### 18 ABSTRACT

19 This study investigated the relationships between a list of 23 protein biomarkers with CIE-20  $L^*a^*b^*$  meat color traits and ultimate pH on Longissimus thoracis and Rectus abdominis muscles of 48 PDO Maine-Anjou cows. The technological parameters were correlated with 21 22 several biomarkers and were in some cases muscle-dependent. More biomarkers were related 23 to pHu in LT than in RA muscle. Some consistencies were found, by the common correlation of pHu with MyHC-IIa and MyHC-IIx. The pHu of LT muscle was also correlated with other 24 25 cytoskeletal entities and proteins belonging to metabolism and cellular stress. In contrast to the relationships found between biomarkers and LT pHu, more proteins were related to the 26 instrumental color coordinates in RA than in LT muscle. The regression equations were 27 28 parameter and muscle-dependent. Certain of the retained proteins explained more than one color coordinate. Hsp70-Grp75, was positive in the models of  $L^*$ ,  $a^*$ ,  $b^*$  and  $C^*$  of LT and of 29  $b^*$  in the RA muscle. Further Heat shock proteins were strongly related with the meat color 30 coordinates in both muscles. The involvement of metabolic enzymes and myofibrillar proteins 31 in meat color development was also verified in this experiment. This study confirmed once 32 again the importance of numerous biological pathways in beef color. 33

#### **36 INTRODUCTION**

Color, tenderness, juiciness and flavor are the most important attributes of beef eating 37 quality<sup>1</sup>. Among these, beef color is the first attribute evaluated by consumers and is the major 38 factor which determines and impacts on the decisions of meat purchase at point of 39 sale<sup>2</sup>.Myoglobin (Mb), a protein present in the sarcoplasm of muscular fibres, is responsible 40 41 of the state of color in post-mortem (p-m) meat. Mb is an unstable chemical compound and 42 when the oxygen availability is high, it changes to oxymyoglobin (OxyMb) giving meat a bright red color<sup>2</sup>. However, if the oxygen level is low, an oxidation reaction may occur and 43 metmyoglobin (MetMb) of brown color is formed. The above mentioned reactions may be 44 reversible in relation to the amount of oxygen on the meat surface and to other factors. The 45 amount of Mb in muscle fibres may also affect the variations in meat color<sup>3</sup> and was reported 46 to be related to mitochondria and its functional status<sup>4</sup>. 47

48 The implementation of high-throughput analytical tools over the last two decades was an 49 important step towards a better understanding of the complex biological systems that define muscle to meat conversion<sup>5, 6</sup>. Thus, numerous studies have focused on the factors influencing 50 meat color and a recent comprehensive review by Joseph et al.<sup>7</sup> highlighted the importance of 51 the use of proteomic approaches to unravel the mechanisms behind the variations in meat 52 color. For example, Savd *et al.*<sup>8</sup> investigated the biochemical mechanisms on sarcoplasmic 53 proteome components responsible of the change in pork color stability. The authors found 22 54 55 proteins or fragments differentially abundant in Semimembranosus muscle between light and dark meat. In beef, Joseph et al.<sup>9</sup> were the first to characterize the sarcoplasmic proteins of 56 two muscles with different color stability. They identified 16 differentially abundant proteins, 57 which included antioxidant and chaperone proteins and enzymes involved in energy 58 metabolism. More recently, we have analyzed the relationships between a list of protein 59 biomarkers of tenderness belonging to myriad biological pathways<sup>10</sup> and color development 60 and pH decline in *Longissimus* muscles of young bulls<sup>11</sup>. The main correlated proteins were 61 involved in apoptosis, oxidative stress or had chaperone activities. 62

The rate of p-m pH decline influences further the biochemical reactions and structural characteristics of the muscles<sup>12</sup>. In order to understand the molecular aspects of meat quality development more fully, we have recently performed an extensive study using a proteomic approach and found a number of protein biomarkers, including elements of muscle fibre type to be related with pH parameters<sup>11</sup>. Hence, the objectives of this study using the PDO

(Protected Designation of Origin) Maine-Anjou cows and two different muscles (Longissimus 68 69 thoracis (LT, ribeye steak) and Rectus abdominis (RA, flank steak)) sampled early p-m were for the first time i) to compare the muscle characteristics and meat quality of the two sampled 70 71 muscles of the breed; ii) to relate the abundances of a list of 23 protein biomarkers with meat 72 color coordinates and ultimate pH; iii) to predict these technological meat quality traits with 73 this list of biomarkers using multivariate analyses and iv) to elucidate the underlying mechanisms of meat color on PDO Maine-Anjou cull cows. The PDO Maine-Anjou breed 74 75 was the second (since 2004) among the 4 breeds allowed to be used in France for PDO meat 76 production. This PDO is composed of around 80% of cows, younger than 10 years of age, 77 having calved at least once and a minimal carcass weight of 380 kg. Steers over 30 months of age with carcass weight of 400 kg minimum can also be found (20%). PDOs are of special 78 79 importance for the valorization of local breeds and the specifications of animal products under 80 PDO pay an increasing attention. Thus, there is a great interest as an initiative of the breeders 81 association, for the implementation of high-throughput techniques, likely omics techniques, 82 for meat quality management of PDO meat to guarantee great quality for the consumers.

#### 83 MATERIALS AND METHODS

#### 84 Animals and sampling

85 A total of forty-eight French Rouge des Prés cull cows (hereafter PDO Maine-Anjou breed, 86 originated in the northwestern part of France) of an average of 67 months old at slaughter 87 were collected from a cooperative of livestock farmers located in the department of Maine-et-Loire (France). Before slaughter, all animals were food deprived for 24 h and had free access 88 89 to water. The animals were slaughtered in a commercial abattoir (Elivia, Lion d'Angers, 49220, France), stunned using captive-bolt pistol prior to exsanguination and dressed 90 according to standard commercial practice. Slaughtering was performed in compliance with 91 92 French welfare regulations and respecting EU regulations (Council Regulation (EC) No. 1099/2009). After slaughter, the hot carcasses were weighed and their classification was 93 94 graded according to the European beef grading system (CE 1249/2008). In this study, mean hot carcass weight and carcass conformation were  $434\pm 30$  kg and  $4.8\pm 0.8$ , respectively. The 95 carcasses were not electrically stimulated and they were chilled and stored at 4°C until 24 h p-96 m. Muscle samples from the 6<sup>th</sup> and 7<sup>th</sup> ribs of *Longissimus thoracis* (LT, mixed fast oxido-97 glycolytic muscle) and from the dorsal part of *Rectus abdominis* (RA, slow oxidative) were 98 99 excised from the right-hand side of the carcass of each animal24 h after slaughter. These two

muscles were chosen because i) sampling of M. longissimus leads to a significant depreciation 100 101 of the carcass, other easier-to-sample muscles and low depreciative such as M. rectus abdominis need to be studied, ii) the two muscles are known to differ in their contractile and 102 metabolic properties<sup>21,22</sup> (representing different anatomical regions and divergent growth and 103 functionalities) and iii) no overall characterization of their proteome in PDO Maine-Anjou 104 105 breed was conducted. So, RA muscle might appear as an alternative to LT for fast and routine physico-chemical analysis for studies on beef quality. After muscle sampling, the epimysium 106 107 was carefully dissected and about 110 g of each muscle sample was taken. Part of the samples 108 was frozen in liquid nitrogen and kept at -80°C until analyzed for determination of enzyme activities, protein extraction for Dot-Blot analysis and myosin heavy chain (MyHC) 109 110 quantification. The other part was used for meat color coordinates determination.

#### 111 *pH measurement*

The ultimate pHof all cull cows LT and RA muscles were measured 24h p-m using a pH meter (HI9025, Hanna Instruments Inc., Woonsocket, RI, USA) equipped with a glass electrode suitable for meat penetration. For LT muscle the measurements were done between the 6<sup>th</sup> and 7<sup>th</sup> rib and for RA muscle at the center of the dorsal part of the muscle. For each animal, five measurements were made (positioned on a horizontal line with about 1.5 cm between two measurements) and the average value was used for analysis.

#### 118 Color measurement of meat

The color of the surface meat was monitored at 24h p-m on the two muscles using a 119 120 portable colorimeter (Minolta Cameras CR 400, Japan) (CIELAB coordinates, light source D65, 8-mm diameter measurement area, 0° standard observer). D65 was chosen as the 121 illuminant because it closely approximates daylight<sup>13</sup>. Calibration was performed by using a 122 white plate supplied by the manufacturer prior to the color determination. Fresh cut slices of 123 124 muscles of not less than 2.5 cm thick and overwrapped were left on a polystyrene tray to refrigerate at 4°C for 1h to allow blooming. Instrumental meat color measurements were 125 recorded for lightness ( $L^*$  = the lightness component, which ranges from 0 to 100 (from black 126 to white)), and the parameters, redness ( $a^* =$  from green if negative to red if positive) and 127 yellowness ( $b^*$  = from blue if negative to yellow if positive). The parameters Chroma ( $C^*$ ), 128 related to the intensity of color(higher when  $a^*$  of  $b^*$  are high), and hue angle ( $h^*$ ), related to 129 the change of color from red to vellow, were calculated using the CIE  $L^*$ ,  $a^*$ , and  $b^*$  values 130 with the following equations:  $C^* = [(a^{*2} + b^{*2})^{1/2}]$  and  $h^* = [ATAN^{-1} (b^{*/a^*})]$ . The 131

measurements were done in three replicate series, at nine different locations on each steak to

133 obtain three measures for each muscle and an average value was used for analysis.

134 Enzyme activities measurement

Glycolytic and oxidative metabolism was determined by the measurement of enzyme 135 activities of respectively lactate dehydrogenase (LDH; EC 1.1.1.27) and isocitrate 136 dehydrogenase (ICDH; EC 1.1.1.42), using the protocol of Jurie *et al.*<sup>14</sup>. These enzymes 137 representative of different steps of the glycolytic and oxidative pathways are currently used 138 for the characterization of the metabolic types of beef muscles<sup>15</sup>. Briefly, two hundred mg of 139 frozen muscle was thawed, ground and homogenized with a Polytron during 15 s in a 5% 140 141 (w/v) solution buffer of 10 mM Trizma-Base (pH 8.0), 250 mM sucrose and 2 mM EDTA. One aliquot of homogenate was centrifuged at 6000g for 15min at 4°C for determination of 142 143 LDH and ICDH activities. Enzyme activities (means of triplicate) were measured at 25°C 144 using an automatic spectrophotometric analyser (UVIKON 923, Biotek-Instruments, Winooski, VT, USA). The results were expressed as  $\mu$ mol .min<sup>-1</sup> .g<sup>-1</sup> of wet muscle. 145

#### 146 Electrophoresis separation of Myosin Heavy Chain (MyHC) isoforms

147 In addition to the two biomarkers of muscle metabolism described above, three other biomarkers corresponding to Myosin Heavy Chain (MyHC) isoforms were quantified 148 according to Picard et al.<sup>16</sup>. For that, we have used an adequate SDS-PAGE. Briefly, the 149 myofibrillar proteins were extracted using a buffer containing 0.5 M NaCl, 20 mM Na 150 Pyrophosphate, 50 mM Tris, 1 mM EDTA and 1 mM Dithiothreitol. After homogenization of 151 152 approximately 100 mg of frozen muscle in 5 mL of the extraction buffer using a Polytron (x22 000) and an incubation time of 5 min at 4°C on ice, the sample was subjected to a 153 centrifugation at 5000 x g for 10 min at 4°C. Following centrifugation, the supernatant was 154 diluted 1:1 (v/w) with glycerol at 87% and stored at -20°C until use. The samples were then 155 156 mixed with an equal volume of loading buffer (basic 2 x Laemmli) containing 4% SDS (w/v), 157 125 mM Tris (pH 6.8), 20% glycerol (v/v), 10%  $\beta$ -mercaptoethanol (v/v) and 0.02% pyronin Y (w/v), incubated at room temperature for 10 min and then heated (70°C) in a water bath for 158 10 min. The protein extracts (10  $\mu$ g) were loaded per well onto 0.75-mm-thick gels and were 159 160 separated using 9.2% polyacrylamide gels. The lower running buffer consisted of 50mM Tris (base), 75mM glycine and 0.05% w/v SDS. The upper running buffer was at 2x 161 the concentration of the lower running buffer and  $\beta$ -mercaptoethanol (0.07% v/v) was added. 162 Ten micrograms of protein extracts were loaded per well onto 0.75-mm-thick gels mounted 163

on a Mini-Protean II Dual Slab Cell electrophoretic system (Bio-Rad). The migration was 164 165 carried out at a constant voltage of 70 V for 30 hours at 4°C. Controls of bovine muscle containing three (MyHC-I, IIa and IIx) or four (MyHC-I, IIa, IIx and IIb) muscle fibers were 166 167 added at the extremities of each gel. After migration, the gels were fixed in 30% (v/v) ethanol 168 and 5% acetic acid (v/v) and then stained with colloidal Coomassie Blue R250 for 24 h. Gels were destained in a 30% ethanol (v/v) and 5 % acetic acid (v/v) solution until the background 169 was sufficiently cleared. After staining in a Coomassie Blue dye solution, the gels were 170 171 scanned and the proportions of the different MyHCs bands were quantified by densitometry 172 with ImageQuant Software 5500 (Amersham Biosciences/GE Healthcare) and expressed in percentage. The quantification of the bands revealed no existence of MyHC-IIb<sup>16</sup> isoform in 173 PDO Maine-Anjou breed, thus only MyHC-I, IIa and IIx isoforms are reported. 174

#### 175 Extraction of proteins for Dot-Blot analysis

Total protein extractions were performed to use subsequently the soluble fractions for Dot-Blot analysis according to Bouley *et al.*<sup>17</sup> and as recently reported by Gagaoua *et al.*<sup>18</sup>. Briefly, 80 mg of muscle was homogenized using a polytron (x22 000) in a denaturation/extraction buffer containing 8.3M urea, 2M thiourea, 1% DTT and 2% CHAPS. After 30 min of centrifugation at 10 000g at 8 °C, the supernatant was stored at –20°C until usefor protein assay and biomarkers quantification by Dot-Blot.

#### 182 Protein content determination

The protein concentrations of the protein extracts used in this study were determined according to the dye binding method of Bradford<sup>19</sup> using the Bio-Rad Protein assay (Bio-Rad Laboratories Inc.). Bovine serum albumin (BSA) at a concentration of 1 mg/mL was used as standard and the protein content was calculated from the standard curve.

#### 187 Immunological protein quantification

The abundance of 18 protein biomarkers (including intact molecules and their fragments) corresponding to six different biological functions (**Table 1**): *heat shock proteins* ( $\alpha$ Bcrystallin, Hsp20, Hsp27, Hsp40, Hsp70-1A, Hsp70-1B, and Hsp70-Grp75); *muscle fibre structure* ( $\alpha$ -actin, MyLC-1F and MyBP-H); *energy metabolism* (ENO3 and PGM1); *proteolysis* ( $\mu$ -calpain and m-calpain); *oxidative resistance* (DJ-1, Prdx6 and SOD1) and *apoptosis* (TP53) were determined as recently reported by Gagaoua *et al.*<sup>18</sup> using specific antibodies. The specificity of the antibodies was checked by western blots. An antibody was considered specific against the studied protein when only one band at the expected molecular weight was detected by western blot. Optimal dilution ratios for each of the 18 antibodies were determined at the same time, using the conditions indicated by the supplier of the reactant and adapted to bovine muscle samples<sup>11</sup>. Conditions retained and suppliers for all primary antibodies dilutions are reported in **Table 1**.

200 Protein extracts (15  $\mu$ g) of each of the LT (n = 48) and RA (n = 48) muscle samples were 201 spotted (four replications per muscle sample) on a nitrocellulose membrane with the Minifold 202 I Dot-Blot apparatus from Schleicher & Schuell Biosciences (Germany) in a random order on 203 the 96-spot membrane. In addition, a mixed standard sample (15  $\mu$ g) was deposited for data 204 normalization. The Dot-Blot membranes were air-dried for 5 min, blocked in 10% PBS milk 205 buffer at 37°C for 20 min, and then incubated to be hybridized with the specific primary 206 antibody of each protein. Subsequently, the membranes were incubated at 37°C for 30 min 207 with the anti-mouse fluorochrome-conjugated LICOR-antibody IRDye 800CW (1 mg/mL). Infrared fluorescence detection was used for quantification of the relative protein abundances. 208 Subsequently, the membranes were scanned using the Odyssey NIR imager (LI-COR 209 Biosciences), with an 800 nm laser, a 169 µm spatial resolution and a fixed gain of 5. Finally, 210 211 the Dot-Blot images were quantified with GenePix PRO v6.0 (Axon). Each dot volume was calculated as the total dot intensity from which the median local background value multiplied 212 by the dot area was subtracted. Because Dot-Blot offers the possibility of replicates, a data-213 prefiltering approach was implemented to eliminate outlier values mainly due to dust. The 214 215 exclusion technique of outliers was based on the Medium Absolute Difference (MAD) and 216 applied before repeated values were averaged. Finally, to make the data comparable between 217 assays, the data were normalized using a regression-approach based on the used mix standard specific for each muscle. Thus, relative protein abundances were based on the normalized 218 219 volume and expressed in arbitrary units.

#### 220 Statistical analysis

Data were analyzed using Statistical Analysis System (SAS) software version 9.2 (SAS Institute, Cary, NJ, USA). Before analysis, raw data means were scrutinized for data entry errors and outliers. To determine the significance of differences between the least squares means of color coordinates, ultimate pH and proteins between the two muscles, PROC GLM procedure of SAS was performed. Significant differences between LT and RA muscles were performed using Tukey's test at a significance level of P < 0.05. The PROC CORR of SAS was used to compute the Pearson's correlations of coefficients between the 23 biomarkers with ultimate pH and color coordinates parameters. Correlation values were considered significant at P < 0.05.

Principal components analyses (PCA) were carried out using the PROC PRINCOMP 230 procedure of SAS to visually illustrate the biomarkers, the color coordinates and pH 231 232 according to the studied muscles (LT vs. RA). The overall Kaiser's Measure of Sampling Adequacy of the performed PCA was 0.76. To confirm that the two muscles are correctly 233 separated (discriminated) by the PCA, a K-means cluster analysis (k = 2 or 3) was performed. 234 This was done using the variability explained by the axes of the PCA with eigenvalues > 1.0235 236 after Z-scores calculation. K-means clustering is a widely used classification method that 237 generates a specific number of classes (non-hierarchical). In our case, the Euclidean matrix 238 distance was applied to classify the samples into 2 or 3 classes to confirm the separation of the 239 two muscles using the variables projected on the PCA.

In addition, for each color coordinate parameter and pHu, a PCA was carried out using only the correlated biomarkers. They aimed to illustrate visually the correlated biomarkers with each technological quality trait.

243 Multiple regression analyses were performed using PROC REG of SAS to create best models for pH and color coordinates (as dependent variables, x) using the 23 protein 244 biomarkers (as independent variables, v) for each muscle. For that, the option "optimal 245 model" was chosen to produce the model with the highest  $r^2$  value. The  $r^2$  value expressed as 246 a percentage will be referred to as the % of variability explained. The maximal number of 247 248 explanatory variables (among the 23 proteins) to be retained in the models was set at 4 to meet to the principle of parsimony (one variable each ten observations (animals)). Variables 249 that were significant but contributed less than 2% in terms of explanatory power (r<sup>2</sup>) were 250 excluded from the model. Partial R-squares, regression coefficients, t-values and significance 251 of each retained variable are given for the models. Regression analyses were further 252 253 conducted on the above dependant variables using both muscles (LT and RA) as one data set. 254 For that, the data of LT and RA muscles were first standardized for muscle effect using the Proc Standard of SAS 9.2 to obtain Z-scores. A Z-score represents the number of standard 255 deviations for each observation relative to the mean of the corresponding animal:  $z = \frac{x-\mu}{\sigma}$ 256 257 where x is the raw value,  $\mu$  is the mean of the population for each muscle and  $\sigma$  is the standard 258 deviation of the same population. Finally, the absence of collinearity was systematically

verified for each regression model, by producing condition indices and variance proportions using the COLLIN procedure of SAS. Variables were identified as collinear if they possessed both a high condition index > 10 and a proportion of variation > 0.5 for two or more traits<sup>11</sup>,  $^{15}$ .

263 **RESULTS** 

#### 264 Instrumental meat color coordinates, ultimate pH and protein biomarkers

The results of instrumental color and ultimate pH values of LT and RA muscles are presented in **Table S2**. The results revealed that there are no significant differences for Lightness ( $L^*$ ) and hue ( $h^*$ ) between the two muscles. The Redness ( $a^*$ ), Yellowness ( $b^*$ ) and Chroma ( $C^*$ ) indices were significantly different (P < 0.001) between LT and RA muscles. The three parameters were the highest in LT muscle. The ultimate pH (pHu) was significantly different (P < 0.001) between the two muscles and was the highest in RA muscle. The findings showed that the lower the pHu is, the highest are the redness and yellowness values.

272 Mean and standard deviations of the biomarkers abundances are summarized in Table S2 273 except those of myosin heavy chains isoforms presented in Figure 1. Among the quantified biomarkers, nearly most proteins (18 from 23) were significantly different (P < 0.05) between 274 275 the two muscles. Globally, Hsp proteins are higher abundant in RA than LT muscle. Significant differences (P < 0.05) were found for  $\alpha$ B-crystallin, Hsp27 and Hsp70-1A. The 276 277 abundances of Hsp20, Hsp40, Hsp70-1B and Hsp70-Grp75 were not different between the two muscles. Among the four metabolism proteins, they were all significantly different (P <278 279 0.05). ENO3 and ICDH were the highest in RA, and LDH and PGM1 were the highest in LT muscle. All the structural proteins quantified were significantly different between the two 280 muscles. The abundances of α-actin, MyBP-H and MyHC-IIa were the highest in LT muscle. 281 282 Those of MyLC-1F, MyHC-I and MyHC-IIx isoforms were the highest in RA muscle. The 283 abundances of the proteins of oxidative stress, namely DJ-1, Prdx6 and SOD1 were 284 exclusively the highest in RA muscle. Significant differences were also obtained for the proteolytic enzymes. Thus,  $\mu$ -calpain was the highest in LT and m-calpain was the highest in 285 RA muscle. Finally, TP53, a protein representative of apoptosis, was found to differ 286 significantly (P < 0.001) between the two muscles and was the highest in RA muscle. 287

The PCA computed using color parameters, ultimate pH and abundances of the 23 biomarkers is given on **Figure 2**. The score plot on the first and second principal components

290 showed a clear separation between the two muscles, and this differentiation was mainly 291 caused by the first principal component (PC). Together, the two first PCs accounted for 40.6% of the total variance, with the first and second components explaining 26.8% and 13.8% of the 292 293 total variability, respectively. It allowed discriminating efficiently the two studied muscles on 294 the two first axes (LT on the right (red circles) and RA on the left (green circles)). The separation was confirmed using a K-means clustering by choosing the option to construct two 295 or three classes. As can be seen on **Figure 2a**, the option of two clusters, separated perfectly 296 the 48 animals, regrouping in classes 1 and 2 only observations of LT and RA muscle, 297 298 respectively. Moreover, the option of three clusters (Figure 2b) allowed obtaining three groups and once again the observations of RA muscle were all grouped together from those of 299 LT muscle subdivided by this option into LT class1 and 2, respectively. This confirms that 300 PCA allowed, by means of the studied variables, the separation of LT and RA muscles. 301 Finally, further PCAs were performed for each muscle using all the variables and are 302 303 presented as supplementary data (Figure S2).

Correlations calculated per muscle showed that  $L^*$  was correlated with  $b^*$  (r = 0.52, P </br>

<0.001) in LT muscle only. For both muscles,  $a^*$  was strongly correlated with  $b^*$ . Chroma

(C\*) was found to be slightly correlated (r = 0.36, P <0.05) with the hue angle ( $h^*$ ) in LT

307
muscle only. Finally, pHu was not correlated (P> 0.1) with color coordinates in both muscles.

#### 308 Relationships between meat color coordinates, pHu and biomarker abundances

309 The significant correlations found between the relative abundances of biomarkers and the 310 technological quality traits for LT and RA muscles are given in **Table 2**, respectively. For LT 311 muscle, only  $L^*$ ,  $h^*$  and pHu were correlated with the abundances of protein biomarkers and most of them, mainly structural and metabolic proteins, were with pHu. Lightness  $(L^*)$  was 312 correlated with four proteins, negatively with Hsp20 (r = -0.26, P < 0.1) and Hsp40 (r = -0.29, 313 P < 0.05) and positively with PGM1 (r = 0.32, P < 0.05) and TP53 (r = 0.34, P < 0.05). Hue 314 315 angle was correlated positively with three proteins, namely Hsp70-1A (r = 0.26, P < 0.1), ENO3 (r = 0.32, P < 0.05) and TP53 (r = 0.31, P < 0.05). Finally, pHu was correlated with 316 317 eight proteins, negatively with Hsp70-1A (r = -0.24, P < 0.1), PGM1 (r = -0.46, P < 0.01), LDH (r = -0.46, P < 0.01),  $\alpha$ -actin (r = -0.34, P < 0.05), MyLC-1F (r = -0.38, P < 0.01) and 318 MyHC-IIx (r = -0.38, P < 0.01) and positively with ICDH (r = 0.44, P < 0.01) and MyHC-IIa 319 (r = 0.33, P < 0.05).320

For RA muscle, the technological quality traits were all found to correlate with several 321 322 biomarkers. L\* was correlated negatively with ICDH (r = -0.26, P < 0.1) and MyHC-I (r = -0.33, P < 0.05) and positively with LDH (r = 0.28, P < 0.05) and MyHC-IIx (r = 0.34, P323 324 <0.05).  $a^*$  was correlated with two proteins only, negatively with Hsp70-1A (r = -0.29, P <0.05) and positively with  $\mu$ -calpain (r = 0.27, P <0.1). b\* was correlated with five proteins, 325 three of them are large Hsp70s (negatively with Hsp70-1A (r = -0.30, P < 0.05) and Hsp70-326 1B (r = -0.24, P <0.1) and positively with Hsp70-Grp75 (r = 0.24, P <0.1)). The two other 327 proteins are PGM1 (r = 0.29, P < 0.05) and Prdx6 (r = 0.27, P < 0.1). C\*was correlated with 328 329 four proteins, negatively with two Hsp70 proteins (Hsp70-1A (r = -0.31, P < 0.05) and Hsp70-1B (r = -0.25, P < 0.1)) and positively with ENO3 (r = 0.29, P < 0.05) and  $\mu$ -calpain (r 330 = 0.25, P < 0.1). Hue angle was slightly correlated with three proteins, positively with  $\alpha$ -actin 331 (r = 0.26, P < 0.1) and Prdx6 (r = 0.24, P < 0.1) and negatively with MvHC-IIa (r = -0.26, P < 0.1)332 <0.1). Finally, independently of muscle type, pHu was correlated with two structural proteins, 333 positively with MyHC-IIa (r = 0.33, P < 0.05) and negatively with MyHC-IIx (r = -0.32, P334 <0.05). A graph showing these common correlations is given in **Figure S1a**,b. 335

The biomarkers that were significantly correlated with color coordinates and pHu of LT and RA muscle and given above, were introduced into PCAs (**Figure 3**and **4**). For LT muscle, thefirst two PCAs axes explained 65.4, 71.4, and 64% of the variability of  $L^*$  (**Figure 3a**),  $h^*$ (**Figure 3b**), and pHu (**Figure 3c**), respectively between animals. For RA muscle, the first two axes of the PCAs explained 71.3, 63.1, 65.1 and 74.1% of the variability of  $L^*$  (**Figure 4a**),  $b^*$  (**Figure 4b**),  $h^*$  (**Figure 4c**) and  $C^*$  (**Figure 4c**), respectively between animals. The PCAs of  $a^*$  and pHu which were correlated with two biomarkers only are not illustrated.

#### 343 *Regression analyses of meat color coordinates and pHu for LT muscle*

344 The regression models of LT muscle using color coordinates and pHu as dependent and biomarker proteins abundances as independent variables are presented in **Table 3**. The models 345 346 were significant but less powerful and they explained between 14 and 30% of variability. The 347 model of  $L^*$  explained 30% of the variability between animals (P < 0.01) by three Hsp 348 proteins: Hsp70-Grp75 (positive) and Hsp40 and Hsp20 (both negative). The model of  $a^*$ explained 21% of the variability (P < 0.05) by Hsp27 (negative) and ICDH and Hsp70-Grp75 349 (both positive). The model of  $b^*$  explained 14% of the variability (P < 0.05) by Hsp70-Grp75 350 and MyHC-I (both positive) and Hsp20 (negative). The C\* model explained 25% of the 351 variability (P< 0.05) by Hsp70-Grp75 and ICDH (both positive) and MyHC-IIa and Hsp20 352

(both negative). For the four above models ( $L^*$ ,  $a^*$ ,  $b^*$  and  $C^*$ ), Hsp70-Grp75 was already retained as an explanatory variable. The  $h^*$  model explained 23% of the variability (P < 0.01) by three new variables not retained for the other color coordinates, namely the glycolytic enzymes ENO3 and PGM1 (both positive) and MyBP-H (negative). Finally, the model of ultimate pH included two variables, ICDH (positive) and Hsp70-1A (negative), and explained 27% of the variability (P < 0.001). In this model, ICDH alone explained 20% of the variability.

#### 360 *Regression analyses of meat color coordinates and pHu for RA muscle*

361 The regression models of RA muscle using color coordinates and pHu as dependent and 362 biomarker proteins abundances as independent variables are presented in **Table 4**. The models were significant but less powerful and they explained between 14 and 33% of variability. The 363 model of L\* explained 33% of the variability between animals ( $P \le 0.01$ ) and retained three 364 structural proteins. MyHC-IIx and Hsp27were positive and MyBP-H and  $\alpha$ -actin were 365 366 negative in the model equation. The model of  $a^*$  explained 29% of the variability (P < 0.01) by Hsp70-1A (negative) and  $\mu$ -calpain, Prdx6 and ICDH (all positive). The model of  $b^*$ 367 explained 33% of the variability (P < 0.001) and highly predictive compared to the LT  $b^*$ 368 model. It retained Hsp70-1A (negative) and Prdx6 and Hsp70-Grp75 (both positive) as 369 370 explaining variables. The  $C^*$ ,  $h^*$  and pHu models explained between 14 and 19% of the variability and all retained MyHC-IIa as an explanatory variable. The  $h^*$  model was explained 371 372 by structural proteins only (both  $\alpha$ -actin and MyHC-IIa). Overall, the retained variables are 373 trait and muscle dependant.

#### 374 Regression analyses of meat color coordinates and pHu for both LT and RA muscles

The explanatory powers of regression analyses using Z-scores for both muscles to explain common color coordinates and pHu as one dataset (**Table S3**) were very weak and ranges from 11 to 17%. For certain models, the retained variables are shared with the LT and RA muscles, likely for  $L^*$ ,  $a^*$ ,  $h^*$  and pHu models.

#### 379 **DISCUSSION**

This study investigated the relationship between a list of proteins so far validated as potential biomarkers of meat tenderness with meat color coordinates and pHu in two muscles (*Longissimus thoracis* and *Rectus abdominis*) of PDO Maine-Anjou cows. It allowed us to explore consistencies and differences among the two muscles and revealed thanks to the studied biomarkers some biological mechanisms that may explain the meat color and pHu for
this breed. Further, it allowed us to use these prime candidate biomarkers to show the strength
of their relationships with the meat traits studied using multivariate analysis.

#### 387 Differences and similarities between muscle characteristics of LT and RA

The ultimate pH values of all individuals in both muscles were below the threshold of 6.0 388 and were within the normal range for cattle<sup>20</sup> but significantly different between the two 389 muscles. The pHu of RA was higher than that of LT muscle. Higher pHu values were already 390 reported in RA muscle<sup>21</sup>. This may be in part related to the type of metabolism of the studied 391 muscles, as RA is known to be less glycolytic than  $LT^{22}$ . Also, the composition of fibre type 392 is well-accepted as a vital factor responsible for these variations. When comparing RA and LT 393 394 muscles, ICDH activity was higher and LDH and PGM1 activities were lower for RA muscle (Table S2). These findings may be linked with the higher proportion of oxidative MyHC-I 395 396 and the lower proportion of MyHC-IIa fibres in RA muscle (Figure 1). These properties 397 confirmed the less glycolytic and more oxidative metabolism in RA muscle as previously reported<sup>22</sup>. Also, muscles with predominantly type I fibres have lower glycogen 398 concentrations than those with type II or fast twitch muscles<sup>23</sup>. These earlier findings and the 399 results of this study could explain why higher oxidative and lower glycolytic metabolisms are 400 401 noted in RA than for LT muscle, hence explaining part of the differences in pH values.

The data showed that the lower the ultimate pH is, the highest are redness and yellowness 402 for LT muscle. The fact that differences were detected could be attributed to the variation in 403 pH values<sup>24</sup>. Also, beef muscle profiling studies showed that physico-chemical and 404 405 biochemical characteristics of individual muscles in a carcass vary significantly and may impact color attributes differently<sup>25</sup>. Nevertheless, in contrast to several earlier studies<sup>20</sup>, no 406 relationship was observed between pHu values and meat color coordinates. Also, no 407 408 significant difference was found for lightness between the two muscles. This finding is 409 unexpected as it has been shown that differences in muscle structure due to changes caused by protein denaturation may lead to differences in light dispersion and thus  $L^*$  values. Changes 410 in  $L^*$  values have been reported to be subtle<sup>25</sup>. We can suppose that the findings may be due to 411 the same variation of bound and free water within the muscle fibres causing a scattering and 412 reflectance of light altering the lightness of the meat. Although  $a^*$  and  $b^*$  values could 413 reflects important color changes, basing the comparisons on just one parameter may not tell 414 the complete color history. Color is a three-dimensional attribute better described by its hue, 415

416 lightness and saturation properties. The sample's  $C^*$  values for the two muscles had a similar 417 behavior to that of  $a^*$  and  $b^*$  values, increasing in LT samples and decreasing in RA samples, 418 but  $h^*$ -values did not differ between the two muscles. The low  $h^*$  angle obtained in both 419 muscles indicates less meat browning<sup>26</sup> and, therefore, a benefit to PDO Maine-Anjou meat 420 quality. Furthermore, the higher  $C^*$  of LT muscle compared to RA muscle indicates a more 421 vibrant color and the LT muscle can be considered more beneficial from a meat quality 422 perspective.

#### 423 Relationship between biomarkers in the early post-mortem period and ultimate pH

To date, no single factor can explain more than 50% of the variation in pHu which is often associated with p-m muscle glycogen content and metabolism. Although the molecular and cellular mechanisms that regulate p-m pH decline are not yet fully understood, proteomic strategies implemented over the last decade have revealed numerous biological pathways to be involved<sup>11</sup>. Thus, the present study is the first to link between a list of protein biomarkers so far validated for meat tenderness with ultimate pH of the two muscles of PDO Maine-Anjou cows.

The results showed clearly and in agreement to the well documented literature data<sup>10, 18, 27,</sup> 431 <sup>28</sup>, that the relationships are muscle-dependent. More biomarkers are related to pHu in LT 432 than in RA muscle. Nevertheless, some consistencies exist. MyHC-IIa (positive) and MyHC-433 IIx (negative) were correlated to pHu in both LT and RA. The correlation between pHu and 434 MyHC-IIx was recently reported for LT muscle in young Blond d'Aquitaine bulls<sup>11</sup>but the 435 direction is inversed for PDO Maine-Anjou breed (negative). MyHC-IIx content is usually 436 associated with glycogen amount<sup>29</sup> and a potential for a faster metabolism, which may explain 437 438 the relationship with pH decline, thus suggesting this protein as a prime candidate biomarker of pHu independently of muscle and breed. Overall, muscles composed of type II fibres are 439 more susceptible to p-m glycolysis than muscles composed of type I fibres<sup>30</sup>, and these may 440 441 explain the relationships with pH decline.

pHu in LT muscle was correlated with further structural proteins and others belonging to metabolism and Heat shock proteins pathways. Earlier studies reported that pHu was related with levels of various muscle proteins present in beef and pork muscles early p-m<sup>11, 31</sup>. The relationships with  $\alpha$ -actin and MyLC-1F have been for example already described by Gagaoua *et al.*<sup>11</sup>. In coherence with our findings, previous proteomic studies found that during the early p-m period, actin fragments are released and that pH decline and actin degradation

were closely related<sup>5</sup>. Actin, a component of microfilaments, is the second most abundant 448 protein in skeletal muscle<sup>6</sup> and was reported to undergo intense degradation during the p-m 449 period<sup>5</sup>. Higher actin content was found in LT compared to RA muscle, and this may be 450 related to the differences in the final pHu values. MyLC-1F is a member of the myosin light 451 chain family; which is the principal component of myofibrils associated both with myosin 452 heavy chain heads and actin<sup>32</sup>. It is highly expressed in fast-twitch skeletal muscle and prone 453 to phosphorylation<sup>33</sup>. In p-m muscle, protein phosphorylation is known to play important roles 454 in meat quality development by regulating the activities of glycolytic enzymes, hence 455 explaining the relationship with pHu. These data are in agreement with the results presented 456 by Choi et al.<sup>34</sup> who reported that meat with faster glycolysis rates contain less MyLC. 457

458 pHu of LT muscle was further related with proteins of energy metabolism, negatively with 459 glycolytic (PGM1 and LDH) and positively with oxidative (ICDH) enzymes. In the early p-m period, as long as glycolytic enzymes are not inhibited by low pH, glycolysis will continue, 460 461 thus contributing to the acidification process. Changes in energy metabolism in beef LT muscle early p-m were investigated using proteomic studies. A clear shift in p-m energy 462 metabolism was indicated. For example, an increase of PGM1 during ageing has been 463 reported<sup>35</sup>. PGM1 catalyzes the production of 3-phosphoglycerate and ATP from 1.3-464 bisphosphoglycerate. 465

As expected, LDH was also related to pHu. It is a key glycolytic enzyme that catalyzes the inter-conversion of pyruvate and lactate, with concomitant inter-conversion of NADH and NAD<sup>+</sup>. It is among the metabolic enzymes which are already identified by proteomic studies to be related with meat qualities<sup>6</sup>. Recently and in agreement to our findings Liang *et al.*<sup>36</sup> reported that LDH was negatively correlated with changes in intramuscular pH levels.

ICDH involved in the tricarboxylic acid (TCA) cycle was already identified to play a great role in p-m beef metabolism<sup>37</sup>. It was retained in the explanatory model of LT muscle and overall model for both muscles. In LT muscle, this enzyme explained 20% of the variability of pHu. Although the explanatory powers of the models are weak (<27%), the biological significances of the retained variables are of great interest for a better understanding of the mechanisms.

Hsp70-1A was both slightly correlated with pHu and retained in the prediction model of
LT muscle. In a recent study by our group, we showed that large Hsp proteins are related to
pH decline<sup>11</sup>. Heat shock proteins (HSPs), also called stress proteins, are considered to be

molecular chaperones which play a universal physiological role in maintaining cellular homeostasis<sup>38</sup>. Pulford *et al.*<sup>39</sup> showed that variation in bull beef quality due to ultimate muscle pH is in part related to Hsp proteins levels. The correlation with pH may be explained as a response to cellular stress since they have been reported to be induced in skeletal muscle and to bind to the structural proteins to maintain homeostasis.

#### 485 *Relationships between biomarkers and meat color coordinates*

Inversely to the relationships found between biomarkers and LT pHu, more proteins were related to instrumental color coordinates in RA than in LT muscle. For LT muscle, only  $L^*$ and  $h^*$ values were correlated with 4 and 3 proteins, respectively. In RA muscle, all the color coordinates were correlated with several biomarkers, 4 proteins with  $L^*$ , 2 with  $a^*$ , 5 with  $b^*$ , 4 with  $C^*$  and 3 with  $h^*$ .

491 The findings of this study confirm the muscle-dependent relationship between the 492 biomarkers and meat quality traits. The regression equations are also trait and muscledependent and there is no universal model. Nonetheless, some consistencies exist and some 493 494 proteins entered in the regression equations of more than one coordinate. For example, Hsp70-Grp75 (a glucose regulated protein) was retained (positive) in the models of  $L^*$ ,  $a^*$ ,  $b^*$ 495 and  $C^*$  of LT muscle and of  $b^*$  in the RA. The central role of this biomarker for meat quality 496 was already reported<sup>40</sup>. It was found to be related to meat color coordinates in LT muscle of 497 different young bulls, namely Blond d'Aquitaine<sup>11</sup>. Grp75 is a cytoprotective chaperone 498 triggered by glucose deprivation,  $Ca^{2+}$  influx, agents perturbing glycolysis or oxidative 499 stress<sup>41</sup>. The lack of oxygen and nutrients in p-m muscle might lead to accumulation of ROS 500 in the mitochondria, the end of ATP production and a deregulation of  $Ca^{2+}$  which may set off 501 apoptosis<sup>5</sup>. Apoptosis was reported to play significant role in the muscle to meat conversion 502 process<sup>5</sup>. In the present study, Grp75 content soon after slaughter was the highest in LT 503 muscle characterized also by high abundances of  $\mu$ -calpain and low ultimate pH value. Earlier 504 studies reported that  $\mu$ -calpain activity is influenced by Grp75 activity<sup>42</sup>. Grp75 was also 505 reported to enhance Ca<sup>2+</sup> trafficking from endoplasmic reticulum towards mitochondria and 506  $cytosol^{43}$ . Possibly, increased Ca<sup>2+</sup> levels may exert regulatory effects on many enzymes, 507 namely µ-calpain and proteins involved in metabolic and apoptotic processes. A biological 508 mechanism involving Grp75 in muscle to meat conversion was recently described by our 509 group<sup>11, 18</sup>. By these mechanisms, structural proteins may be altered and once their reflectance 510 is affected, a direct relationship with meat color may occur. Grp75 could also interact with 511

antioxidant enzymes regulating its activity during the depletion of redox potential NADH<sup>18</sup>,
thus affecting meat color traits.

514 Further Hsp proteins were in this study closely related with the meat color coordinates in both LT and RA muscles. These findings are in agreement to several proteomic studies 515 aiming to understand meat color<sup>9, 44-46</sup>. Small and large Hsp proteins were involved. For 516 example, Hsp70-1A was negatively correlated with  $a^*$ ,  $b^*$  and  $C^*$  in RA muscle. The 517 potential role of this inducible chaperone in meat color development was recently reported in 518 several studies<sup>9, 11, 31</sup>. Hsp70 (HSPA1A/HSPA1B), a crucial member of Hsps, is believed to 519 play various protective roles in skeletal muscle and regulating apoptosis. Furthermore, small-520 521 Hsp proteins (Hsp20 and 27) were negatively related with  $L^*$  and already entered in the regression equations of  $L^*$ ,  $a^*$ ,  $b^*$  and  $C^*$  of LT muscle. In agreement to our findings, the 522 523 expression levels of Hsp27 were negatively correlated with  $L^*$  and  $a^*$  of Korean native cattle<sup>47</sup>. Similarly, in earlier studies Hsp27 was overabundant in dark porcine 524 Semimembranosus muscles<sup>8</sup>. Hsp27 play a central role in organizing and protecting 525 myofibrillar structures, as suggested by its localization to the Z-line and the I-band in muscle<sup>6</sup>. 526 In addition to these activities, Hsp20 and 27 have the ability to collaborate to control the 527 redox status<sup>48</sup>. We suppose that the involvement of Hsps in meat color may be in part related 528 529 to their protective role against protein denaturation known to affect the reflectance of meat aspects. 530

531 Metabolic enzymes were also correlated with color coordinates and entered in the regression equations of both muscles. For example, glycolytic enzymes were earlier found to 532 be related with instrumental beef color parameters<sup>9, 40, 44, 45</sup>. PGM1 was positively correlated 533 with  $L^*$  in LT muscle and with  $b^*$  in RA muscle. Recently, a positive correlation was reported 534 between PGM1 and  $a^*$  values of beef LT muscle<sup>44</sup>. Previous investigations reported 535 significant correlations of PGM1 with instrumental color parameters of pork meat. 536 Kwasiborski *et al.*<sup>31</sup> reported a negative correlation with  $a^*$  values. In broiler breast, a 537 negative correlation was also reported with  $L_{24h}^{*45}$ . Phosphorylation increases the enzymatic 538 activity of this protein, thus accelerating the conversion of glucose-1-phosphate to glucose-6-539 540 phosphate, which in turn favors the generation of substrates necessary for regeneration of NADH<sup>44</sup>. NADH is an important co-factor in enzymatic and non-enzymatic metmyoglobin 541 reduction<sup>2</sup>. ENO3 was in this study positively correlated with  $h^*$  in LT muscle and with  $C^*$  in 542 RA muscle. The enzyme was also retained as an explanatory variable (first) in the  $h^*$  model 543 of LT muscle.ENO3 is involved in the conversion of 2-phosphoglycerate to 544

phosphoenolpyruvate during glycolysis. Joseph et al. reported that ENO3 was over-abundant 545 in color-stable Longissimus lumborum compared with color-labile Psoas major<sup>9</sup> and a 546 positive correlation was found with  $a^*$  values. ENO3 expression was reported to be 547 influenced by differences in glucose levels and deprivation of oxygen supply<sup>49</sup>. These 548 research findings were interpreted to indicate that ENO3 was a critical enzyme related to meat 549 550 color. Finally, LDH was found to be slightly related with  $L^*$  in RA muscle. LDH may help replenish the pool of p-m NADH. Production of reducing equivalents via this enzyme seemed 551 to be used for metmyoglobin reduction<sup>7</sup> and thus affect the color coordinates of beef meat. 552

Antioxidant proteins are slightly related in this study with instrumental color parameters. 553 554 Only Prdx6 was correlated with  $b^*$  and  $h^*$  coordinates and entered in the regression equations of  $a^*$  and  $b^*$  of RA muscle. It is also retained in the models of  $a^*$ ,  $b^*$  and  $C^*$  for both muscles 555 556 when grouped as one data set. Prdx6, a bifunctional protein with both glutathione peroxidase (GPx, antioxidative) and phospholipase A2 (PLA2) activities was reported by our group to 557 play a significant role in pH decline of LT muscle of young bull breeds<sup>11</sup>. To date little is 558 known about the pathways by which Prdx6 may impact meat color. It was suggested that the 559 production of Prdx6 during storage could be regarded as counteraction against the meat 560 561 discoloration, as the antioxidant protein contributes to protection against meat discoloration<sup>9,11</sup>. Further, Joseph et al. found that Prdx2, a member of peroxiredoxins 562 superfamily, overabundant in bovine Longissimus lumborum, was a good model for color-563 stable muscle. The expression of peroxiredoxins may be considered an indicator for meat 564 discoloration. 565

566 The involvement of myofibrillar proteins in meat color development was also confirmed in this study. Several structural proteins were correlated with  $L^*$  and  $h^*$  in RA muscle but never 567 in LT muscle. Also, several among them entered in the regression equations of color 568 569 coordinates. Little studies have reported relationships between myofibrillar proteins and meat color traits, since most of them investigated the sarcoplasmic proteins only. For example, the 570 association between slow twitch oxidative fibres (type I) and L\*has recently been 571 reported<sup>11</sup> and may be related to their relatively high content of myoglobin, which explains 572 573 part of the variation in meat color. These fibres contain high levels of inducible Hsp70 (closely related to  $a^*$ ,  $b^*$  and  $C^*$ ), of which the potential role has been described above. 574 Otherwise, as an important regulatory protein of the thick filament, MyBP-H has significant 575 effects on length, thickness, and lateral alignment of myosin filaments, thus its involvement in 576 meat color may be of great significance. 577

578 The findings of the present study indicated that the protein biomarkers related to pH and 579 meat color traits would be of primary importance for the beef industry, which has to satisfy 580 the increasing consumer expectations. The present study used for the first time Dot-Blot as a 581 fast and routine throughput technique, to quantify pre-selected proteins of interest in two 582 muscles of PDO Maine-Anjou. This study confirmed once again the importance of several biological pathways in beef color and some of them are muscle-dependent. Looked at in more 583 detail, ultimate pH is influenced by many biological pathways. The knowledge of these 584 processes allows a faster understanding of similarities but also differences that may exist 585 according to each muscle. The proteins related to both technological parameters were also 586 reported to play great roles in the determinism of meat tenderness trait<sup>5, 6, 10, 27</sup>, thus common 587 biological pathways may be shared. In addition, the variables were able to separate between 588 589 the two muscles and some of them would be used for the authenticity of muscle cuts. Thus, 590 the meat industry may benefit from the use of these biomarkers, once validated, as a tool for 591 investigation, monitoring or decision/management of meat depending on the desired quality trait. 592
