Random walk on random walks: higher dimensions

Abstract

We study the evolution of a random walker on a conservative dynamic random environment composed of independent particles performing simple symmetric random walks, generalizing results of [16] to higher dimensions and more general transition kernels without the assumption of uniform ellipticity or nearest-neighbour jumps. Specifically, we obtain a strong law of large numbers, a functional central limit theorem and large deviation estimates for the position of the random walker under the annealed law in a high density regime. The main obstacle is the intrinsic lack of monotonicity in higher-dimensional, non-nearest neighbour settings. Here we develop more general renormalization and renewal schemes that allow us to overcome this issue. As a second application of our methods, we provide an alternative proof of the ballistic behaviour of the front of (the discrete-time version of) the infection model introduced in [23].

1 Introduction

Random walks on random environments are models for the movement of a tracer particle in a disordered medium, and have been the subject of intense research for over 40 years. The seminal works [22, 33, 34], concerning one-dimensional random walk in static random environment (i.e., constant in time), established a rich spectrum of asymptotic behaviours that can be very different from that of usual random walks. In higher dimensions, important questions remain open despite much investigation. For excellent expositions on this topic, see [35, 37]. The *dynamic* version of the model, i.e., when the random environment is allowed to evolve in time, has been also studied for over three decades (see e.g. [14, 27]). However, models with both space and time correlations have been only considered relatively recently. For an overview, we refer to the PhD theses [1, 31]. We will abbreviate “RWRE” for random walk in static random environment, and “RWDRE” for random walk in dynamic random environment.

Asymptotic results for RWDRE under general conditions were derived e.g. in [5, 6, 12, 15, 19, 29, 30], often requiring *uniform mixing* conditions on the random environment (implying e.g. that the conditional distribution of the environment at the origin given the initial state uniformly approaches a fixed law for large times). This uniformity can be relaxed in particular examples, e.g. [10, 18, 28] (supercritical contact process), or under additional assumptions, e.g. [2, 3] (spectral gap, weakly non-invariant) and [11] (attractivity). But arguably, some of the most challenging random environments are given by conservative particle systems, due to their poor mixing properties. Such cases have been considered in [4, 7, 8, 21, 32] (simple symmetric exclusion), and in [16, 17] (independent random walks). Each of these works imposes additional conditions and explores very specific properties of the environment in question. In particular, the works [16, 17, 21] introduce *perturbative* approaches, where parameters of the system are driven to a limiting value where the behaviour is known.

In the present paper, we consider as in [16] dynamic random environments given by systems of independent simple symmetric random walks. As mentioned above, asymptotic results for this model are challenging since the random environment is conservative and has slow and non-uniform mixing. We extend the results of [16] to higher dimensions and more general transition kernels. Additional difficulties arise in this setting due to the loss of monotonicity properties present in the one-dimensional, nearest-neighbour case. Our main results are a strong law of large numbers, a functional central limit theorem and large deviation bounds for the position of the random walker under the annealed law in a high density regime. As an additional application of our methods, we re-obtain a (slightly improved) ballisticity condition for (the discrete-time version of) the infection-spread model considered in [23]. Some tools developed in the present paper will be also used in the accompanying article [13].

1.1 Definition of the model and main results

Denote by $\mathbb{N} = \{1, 2, \dots\}$ the set of positive integers and let $\mathbb{Z}_+ := \{0\} \cup \mathbb{N}$. Fix $d \in \mathbb{N}$ and let $N = (N(x, t))_{x \in \mathbb{Z}^d, t \in \mathbb{Z}_+}$ be a random process with each $N(x, t)$ taking values in

\mathbb{Z}_+ , which we call the *random environment*. Let $\alpha : \mathbb{Z}_+ \times \mathbb{Z}^d \rightarrow [0, 1]$ satisfy

$$\sum_{x \in \mathbb{Z}^d} \alpha(k, x) = 1 \quad \text{for every } k \in \mathbb{Z}_+. \quad (1.1)$$

For a fixed a realization of N , the random walker in random environment $X = (X_t)_{t \in \mathbb{Z}_+}$ is the Markov chain that, when at position $x \in \mathbb{Z}^d$ at time $t \in \mathbb{Z}_+$, jumps to $x + z \in \mathbb{Z}^d$ with probability $\alpha(N(x, t), z)$. Note that the chain is time-inhomogeneous when the random environment is dynamic. The law of X conditioned on N is called the *quenched law*, and the quenched law averaged over the law of N is called the *annealed law*.

We are interested in the case where N is given by the occupation numbers of a system of simple symmetric random walks in equilibrium. More precisely, fix $\rho \in (0, \infty)$ and let $(N(x, 0))_{x \in \mathbb{Z}^d}$ be an i.i.d. collection of Poisson(ρ) random variables. From each site $x \in \mathbb{Z}^d$, start $N(x, 0)$ independent simple symmetric random walks (which can be lazy or not). The value of $N(x, t)$, $t > 0$ is then defined as the number of random walks present at x at time t . The process $N(\cdot, t)$ is a Markov chain in equilibrium on the state-space $(\mathbb{Z}_+)^{\mathbb{Z}^d}$. As already mentioned, N has relatively poor mixing properties; for example, it can be shown that $\text{Cov}(N(0, t), N(0, 0))$ decays as $t^{-d/2}$ when $t \rightarrow \infty$.

Let $|\cdot|$ denote the ℓ^1 -norm on \mathbb{Z}^d . We will make the following assumptions on α :

Assumption (S): The set of possible steps

$$\mathcal{S} := \{x \in \mathbb{Z}^d : \exists k \in \mathbb{Z}_+, \alpha(k, x) > 0\} \quad (1.2)$$

is finite. We set $\mathfrak{R} := \max_{x \in \mathcal{S}} |x|$, which we call the *range* of the random walk.

Assumption (D): We assume that

$$v_\bullet := \liminf_{k \rightarrow \infty} \sum_{x \in \mathcal{S}} \alpha(k, x) x \cdot e_1 > 0, \quad (1.3)$$

where e_1 is the first of the canonical base vectors e_1, \dots, e_d of \mathbb{Z}^d .

Assumption (R): There exists $x_\bullet \in \mathcal{S}$ satisfying $x_\bullet \cdot e_1 > 0$ and

$$\liminf_{k \rightarrow \infty} \alpha(k, x_\bullet) > 0. \quad (1.4)$$

Assumption (D) means that, for sufficiently high particle density, the random walker has a local drift in direction e_1 . Assumptions (S) and (R) are technical; (S) simplifies the execution of many technical steps while (R) ensures some regularity for $\alpha(k, \cdot)$ over large enough $k \in \mathbb{N}$. Note that (R) follows from (D) if either $\alpha(k, \cdot)$ is constant for sufficiently large k , or the random walker moves by nearest-neighbour steps, i.e., $\mathcal{S} \subset \{x \in \mathbb{Z}^d : |x| \leq 1\}$.

Denote by \mathbb{P}^ρ the joint law of N and X and by \mathbb{E}^ρ the corresponding expectation. We can now state the main result of the present paper.

Theorem 1.1. For every $v_\star \in (0, v_\bullet)$, there exists a $\rho_\star = \rho_\star(\alpha, v_\star) < \infty$ large enough such that, for every $\rho \geq \rho_\star$, there exists a $v = v(\alpha, \rho) \in \mathbb{R}^d$ with $v \cdot e_1 \geq v_\star$ and:

(i) (Law of large numbers)

$$\lim_{t \rightarrow \infty} \frac{X_t}{t} = v \quad \mathbb{P}^\rho\text{-almost surely.} \quad (1.5) \quad \text{e:lln}$$

(ii) (Functional central limit theorem) There exists a deterministic covariance matrix $\Sigma = \Sigma(\alpha, \rho)$ such that, under \mathbb{P}^ρ ,

$$\left(\frac{X_{[nt]} - v[nt]}{\sqrt{n}} \right)_{t \geq 0} \Rightarrow B^\Sigma \quad (1.6) \quad \text{e:clt}$$

where B^Σ is a Brownian motion on \mathbb{R}^d with covariance matrix Σ and “ \Rightarrow ” denotes convergence in distribution as $n \rightarrow \infty$ with respect to the Skorohod topology.

(iii) (Large deviation bounds) For every $\varepsilon > 0$, there exists $c > 0$ such that

$$\mathbb{P}^\rho \left(\left| \frac{X_t}{t} - v \right| > \varepsilon \right) \leq c^{-1} \exp\{-c(\log t)^{3/2}\} \quad \text{for all } t \in \mathbb{N}. \quad (1.7) \quad \text{e:ldb}$$

Theorem 1.1 may be interpreted as follows: Assumption (D) ensures that the random walker has a positive local drift in direction e_1 inside densely occupied regions of \mathbb{Z}^d . Theorem 1.1 shows that, when the density ρ is large enough, this behaviour “takes over”, i.e., the random walker exhibits a macroscopic drift in direction e_1 , which introduces enough mixing for a law of large numbers and a central limit theorem to hold.

Note that the matrix Σ in item (ii) above might be zero; indeed, our assumptions on α do not exclude the case that X is deterministic. However, Σ will be non-zero as soon as X is non-trivial, and it will be non-singular under mild ellipticity assumptions such as e.g. $\sup_{k \in \mathbb{Z}_+} \alpha(k, \pm e_i) > 0$ for all $1 \leq i \leq d$; see (5.17). The speed of the decay in (1.7) is not optimal, and only reflects the limitations of our methods.

As previously mentioned, one of the biggest obstacles to obtain Theorem 1.1 are the poor space-time mixing properties of the random environment. A method to overcome this difficulty in ballistic situations was developed in [16] for the high density regime in one dimension, see also [21] for a similar approach when the random environment is given by a one-dimensional simple symmetric exclusion process. However, these results rely on monotonicity properties of the random walker that are in general not valid in higher-dimensional and/or non-nearest neighbour settings. A coupling method (cf. [20], [11]) can sometimes be used to deal with this problem, but is limited to cases where α belongs to a set of at most two transition kernels. Here we follow a different approach, exploiting properties of the random environment through more general renormalization and renewal schemes that also bypass the requirement of uniform ellipticity.

As another application of our methods, we provide a short proof of ballisticity for the one-dimensional discrete-time version of the model for the spread of an infection

studied in [23]. In this model, particles can be of two types: healthy or infected. Fix $\rho \in (0, \infty)$. At time zero, we place on each site of \mathbb{Z} an independent number of particles, each distributed as a Poisson(ρ) random variable. Given the assignment of particles to sites, we declare all particles to the right of the origin to be healthy and all particles to its left, including those on the origin, to be infected. Then the system evolves as follows: each particle, regardless of its state, moves independently as a discrete-time simple symmetric random walk (with a fixed random walk transition kernel), and any healthy particle sharing a site with an infected particle becomes immediately infected. We are interested in the position \bar{X}_t of the rightmost infected particle at time $t \in \mathbb{Z}_+$. Still denoting by \mathbb{P}^ρ the underlying probability measure, we obtain:

Proposition 1.2. *For any $\rho > 0$, there exist $v > 0$ and $c > 0$ such that*

$$\mathbb{P}^\rho (\bar{X}_t < vt) \leq c^{-1} \exp\{-c(\log t)^{3/2}\} \quad \text{for all } t \in \mathbb{N}. \quad (1.8)$$

The above proposition offers a slight improvement to the deviation bound given in [23], which is an important ingredient in establishing finer results about the infection front. For example, a similar statement was used in [24] to prove a law of large numbers, and in [9] to establish a central limit theorem for (the continuous-time version of) \bar{X}_t .

The rest of the paper is organized as follows. Section 1.2 below contains a short heuristic description of ideas used in our proofs. In Section 2, we give a particular construction of our model with convenient properties. In Section 3, we develop a renormalization procedure for general classes of observables, relying on a key decoupling result for the environment (Theorem 3.4 below) whose proof is given in Appendix A. Applications of the renormalization scheme to show ballisticity of the random walker and of the infection front, including the proof of Proposition 1.2, are discussed in Section 4. Finally, in Section 5 we define and control a regeneration structure for the random walker path and finish the proof of Theorem 1.1.

Throughout the text, we denote by c a generic positive constant whose value may change at each appearance. These constants may depend on all model parameters discussed above but, in Section 3 and in Appendix A, they will not be allowed to depend on ρ , as we recall in the beginning of these sections.

1.2 Proof ideas

The proof of Theorem 1.1 is split into two main steps that can be informally described as: a ballisticity condition and a renewal decomposition. They are performed respectively in Sections 4 and 5. Let us now describe them in more detail.

Our first result for the random walker described above is reminiscent of the (T') -condition of Sznitman (see [35]): in Theorem 4.1, we show that, for ρ large enough, $X_t \cdot e_1$ diverges to infinity in a strong sense, i.e., the random walker is ballistic. This is done via a renormalization argument. Once ballisticity has been established, our intuition tells us that, as time passes, the random walker will see “fresh environments” since the particles of the random environment have no drift; this informal description is made precise by defining a regeneration structure for the path of the random walker. Here this step must be performed differently from [16] because of the higher dimensions and non-nearest neighbour transition kernels. Moreover, because of the lack of monotonicity, the tail of the regeneration time must also be controlled differently.

Proposition 1.2 is proved using a similar argument as for Theorem 4.1. First, the problem is reduced to showing that, with large probability, we can frequently find particles near \bar{X}_t , cf. Lemma 4.4. Indeed, this implies the existence of a density of times where \bar{X}_t behaves as a random walk with a drift, which is enough because it always dominates a simple symmetric random walk. The reduced problem can then be tackled using the renormalization procedure, driving not ρ to infinity but the size of the window around \bar{X}_t where we look for particles. See Section 4.2.

2 Construction

s:construction

In this section, we introduce a construction of the environment of simple random walks in terms of a Poisson point process of trajectories as in [16]. This construction provides a convenient way to explore certain independence properties of the environment. We also provide a construction for the random walker and discuss positive correlations of certain monotone observables of the environment (cf. Proposition 2.2 below).

Define the set of trajectories

$$W = \left\{ w : \mathbb{Z} \rightarrow \mathbb{Z}^d : |w(i+1) - w(i)| \leq 1 \quad \forall i \in \mathbb{Z} \right\}. \quad (2.1)$$

Note that the trajectories in W are allowed to jump in any canonical direction, as well as to stay put. We endow the set W with the σ -algebra \mathcal{W} generated by the canonical coordinates $w \mapsto w(i)$, $i \in \mathbb{Z}$.

Let $(S^{z,i})_{z \in \mathbb{Z}^d, i \in \mathbb{N}}$ be a collection of independent random elements of W , with each $S^{z,i} = (S_\ell^{z,i})_{\ell \in \mathbb{Z}}$ distributed as a double-sided simple symmetric random walk on \mathbb{Z}^d started at z , i.e., the past $(S_{-\ell}^{z,i})_{\ell \geq 0}$ and future $(S_\ell^{z,i})_{\ell \geq 0}$ are independent and distributed as a simple symmetric random walk on \mathbb{Z}^d started at z (lazy or not).

For a subset $K \subset \mathbb{Z}^d \times \mathbb{Z}$, denote by W_K the set of trajectories in W that intersect K , i.e., $W_K := \{w \in W : \exists i \in \mathbb{Z}, (w(i), i) \in K\}$. This allows us to define the space of

point measures

$$\Omega = \left\{ \omega = \sum_i \delta_{w_i}; w_i \in W \text{ and } \omega(W_{\{y\}}) < \infty \text{ for every } y \in \mathbb{Z}^d \times \mathbb{Z} \right\}, \quad (2.2)$$

e:Omega

endowed with the σ -algebra generated by the evaluation maps $\omega \mapsto \omega(W_K)$, $K \subset \mathbb{Z}^d \times \mathbb{Z}$.

Fix $\rho \in (0, \infty)$ and let $N(x, 0)$, $x \in \mathbb{Z}^d$ be i.i.d. $\text{Poisson}(\rho)$ random variables. Defining the random element $\omega \in \Omega$ by

$$\omega := \sum_{z \in \mathbb{Z}^d} \sum_{i \leq N(z, 0)} \delta_{S^{z, i}}, \quad (2.3)$$

it is straightforward to check that ω is a Poisson point process on Ω with intensity measure $\rho\mu$, where

$$\mu = \sum_{z \in \mathbb{Z}^d} P_z \quad (2.4)$$

and P_z is the law of $S^{z, 1}$ as an element of W . Setting then

$$N(y) := \omega(W_{\{y\}}), \text{ for } y \in \mathbb{Z}^d \times \mathbb{Z}, \quad (2.5)$$

e:defN

we may verify that N has the distribution described in Section 1.

We enlarge our probability space to support i.i.d. random variables U_y , $y \in \mathbb{Z}^d \times \mathbb{Z}$ sampled independently from ω , where each U_y is uniformly distributed in the interval $[0, 1]$. We then define \mathbb{P}^ρ to be the joint law of ω and $U = (U_y)_{y \in \mathbb{Z}^d \times \mathbb{Z}}$. Our configuration space may be thus identified as $\bar{\Omega} := \Omega \times [0, 1]^{\mathbb{Z}^d \times \mathbb{Z}}$, equipped with the product σ -algebra.

To define our random walker, recall Assumption (R) and let

$$p_\bullet(k) := \inf_{\ell \geq k} \alpha(\ell, x_\bullet), \quad k \in \mathbb{Z}_+. \quad (2.6)$$

For each $k \in \mathbb{Z}_+$, fix a partition of $[0, 1]$ into intervals I_x^k , $x \in \mathcal{S}$ such that $|I_x^k| = \alpha(k, x)$ and $[0, p_\bullet(k)] \subset \bigcap_{\ell \geq k} I_{x_\bullet}^\ell$. Finally, for $y \in \mathbb{Z}^d \times \mathbb{Z}$, we define $Y^y = (Y_\ell^y)_{\ell \in \mathbb{Z}_+}$ by

$$Y_0^y = y, \quad Y_{\ell+1}^y = Y_\ell^y + \sum_{x \in \mathcal{S}} (x, 1) \mathbb{1}_{\left\{ U_{Y_\ell^y} \in I_x^{N(Y_\ell^y)} \right\}}, \quad \ell \geq 0. \quad (2.7)$$

e:defY

For $y = (x, t) \in \mathbb{Z}^d \times \mathbb{Z}$ we write X_ℓ^y for the projection of Y_ℓ^y into \mathbb{Z}^d , i.e., $Y_\ell^y = Y_\ell^{(x, t)} = (X_\ell^y, \ell + t)$. When $y = 0$ we omit it from the notation. One may verify that the random walker $X = (X_\ell)_{\ell \in \mathbb{Z}_+}$ is indeed distributed as described in Section 1.

We discuss next an important property of our random environment: the FKG inequality (cf. e.g. [26] Corollary 2.12 p. 78). It states that monotone functions of ω are positively correlated. This result will be used in the proof of Lemma 5.4, which is an important ingredient to control the tail of the regeneration time constructed in Section 5. We first need the following definition.

Definition 2.1. A measurable function $f : \Omega \rightarrow \mathbb{R}$ is called non-decreasing if $f(\omega') \geq f(\omega)$ whenever $\omega', \omega \in \Omega$ satisfy $\omega'(B) \geq \omega(B)$ for all $B \in \mathcal{W}$, and it is called non-increasing if $-f$ is non-decreasing. If either f or $-f$ is non-decreasing, we say that f is monotone. An event $A \in \sigma(\omega)$ is said to be non-decreasing, non-increasing or monotone if the corresponding property is satisfied by its indicator function $\mathbb{1}_A$.

The inequality reads as follows.

Proposition 2.2 (FKG inequality). Let $f, g : \Omega \rightarrow \mathbb{R}$ be bounded measurable functions that are either both non-decreasing or both non-increasing. Then

$$\mathbb{E}^\rho [f(\omega)g(\omega)] \geq \mathbb{E}^\rho [f(\omega)] \mathbb{E}^\rho [g(\omega)]. \quad (2.8)$$

Proof. One may follow the proof of Theorem 3.1 in [36]. \square

We extend the notion of monotonicity to functions defined on $\bar{\Omega}$ as follows.

d:monotone

Definition 2.3. A measurable function $f : \bar{\Omega} \rightarrow \mathbb{R}$ is called non-decreasing, non-increasing or monotone if, for all $U \in [0, 1]^{\mathbb{Z}^d}$, the function $\omega \mapsto f(\omega, U)$ satisfies the same property in the sense of Definition 2.1, and analogously for events in $\sigma(\omega, U)$.

Remark 2.4. Note that monotone functions in the sense of Definition 2.3 are not necessarily positively correlated under \mathbb{P}^ρ : consider e.g. the indicator functions of the events $\{U_0 \in (0, 1/2)\}$ and $\{U_0 \in (1/2, 1)\}$. However, such monotone functions are positively correlated under the conditional law given U , as can be deduced from Proposition 2.2.

We give next a few other useful definitions. For a measurable function $g : \bar{\Omega} \rightarrow E$ (with E some measurable space), we will abuse notation by writing g to refer also to the random variable $g(\omega, U)$, distributed according to the push-forward of \mathbb{P}^ρ .

Definition 2.5. We say that the function $g : \bar{\Omega} \rightarrow E$ is supported on the set $K \subset \mathbb{Z}^d \times \mathbb{Z}$ if

$$g(\omega, U) \in \sigma(N(y), U_y : y \in K). \quad (2.9)$$

For $y = (x, n) \in \mathbb{Z}^d \times \mathbb{Z}$ and $w \in W$, define the space-time translation $\theta_y w$ as

$$\theta_y w(i) := w(i - n) + x, \quad i \in \mathbb{Z}. \quad (2.10)$$

For $A \subset W$, $\theta_y A$ is defined analogously, i.e., $\theta_y A := \bigcup_{w \in A} \{\theta_y w\}$. We may then define space-time translations operating on $\bar{\Omega}$ as follows. For $(\omega, U) \in \bar{\Omega}$, let

$$\theta_y(\omega, U) := (\theta_y \omega, \theta_y U) \quad (2.11)$$

$$\text{where } (\theta_y \omega)(A) := \omega(\theta_y A) \quad \forall A \in \mathcal{W}, \quad (\theta_y U)_u := U_{y+u} \quad \forall u \in \mathbb{Z}^d \times \mathbb{Z}.$$

e:defttheta

The translations of a measurable function $g : \bar{\Omega} \rightarrow E$ are then defined by setting

$$g_y = \theta_y g := g \circ \theta_y. \quad (2.12)$$

Note that $\theta_y N(u) = N(y + u)$, and that the law of (ω, U) is invariant with respect to the space-time translations, i.e., $\theta_y(\omega, U)$ is distributed as (ω, U) under \mathbb{P}^ρ for any $y \in \mathbb{Z}^d \times \mathbb{Z}$. In particular, the law of $Y^y - y$ in (2.7) does not depend on y since $Y^y = y + \theta_y Y$.

3 Renormalization

s:renormalization

In this section, we develop an important tool in the analysis of our model, namely, a multi-scale renormalization scheme. We will keep the setup reasonably general so that it may be used in future applications. An important consequence of the technique developed here is the ballisticity of the random walker (cf. Theorem 4.1), which is an essential ingredient for proving Theorem 1.1. All constants in this section will be *independent* of ρ , but may depend on other parameters of the model.

3.1 General procedure

To describe the renormalization procedure, we introduce the sequence of scales

$$L_0 = 10^{50} \quad \text{and} \quad L_{k+1} = \lfloor L_k^{1/2} \rfloor L_k, \quad \text{for } k \geq 0. \quad (3.1)$$

The choice of constants 10^{50} and $1/2$ appearing above is not crucial; many other choices would have been equally good for our purposes. Note that

$$L_k^{1/2} \geq \lfloor L_k^{1/2} \rfloor \geq \frac{1}{2} L_k^{1/2} \quad \text{for all } k \geq 0. \quad (3.2)$$

e:lowerbound Lk

Fix $\mathfrak{R} \in \mathbb{N}$. In the relevant applications, \mathfrak{R} will be taken as in Assumption (S). Given a scale k , we will consider translations of the space-time boxes

do we ever use \mathfrak{R} for something else?

$$B_{k,0} = \{[-2\mathfrak{R}L_k, 3\mathfrak{R}L_k]^d \times [0, L_k]\} \cap (\mathbb{Z}^d \times \mathbb{Z}). \quad (3.3)$$

e:Bk

More precisely, let

$$M_k = \{k\} \times (\mathbb{Z}^d \times \mathbb{Z}), \quad k \geq 0, \quad (3.4)$$

be the set of indices of scale k and, for $\hat{k} \geq 0$, let

$$M_{\geq \hat{k}} = \bigcup_{k \geq \hat{k}} M_k \quad (3.5)$$

be the set of indices of all scales greater or equal to \hat{k} . For $m = (k, y) \in M_k$, we define the corresponding translation of the box $B_{k,0}$

$$B_m = B_{k,0} + L_k y. \quad (3.6)$$

The base of the box $B_{k,0}$ is given by the set $I_{k,0} = ([0, \mathfrak{R}L_k]^d \times \{0\}) \cap (\mathbb{Z}^d \times \mathbb{Z})$ and its corresponding translations are

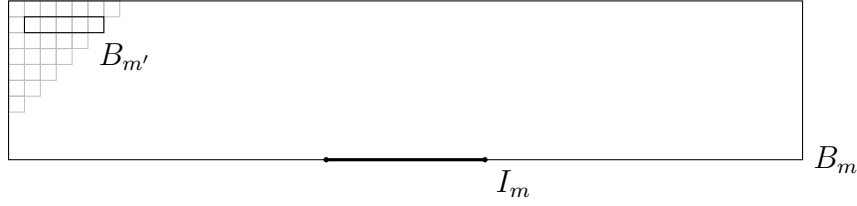


Figure 1: The box B_m for some $m \in M_{k+1}$. At the bottom we picture the corresponding base I_m and, in the upper left corner, a box $B_{m'}$ in the previous scale k .

$$I_m = I_{k,0} + L_k y, \quad \text{for } m = (k, y) \in M_k, \quad (3.7)$$

e:Im

see Figure 1.

Having this in place, we introduce the following definition.

d:adapted

Definition 3.1. Fix $\hat{k} \geq 0$ and a collection of events $(A_m)_{m \in M_{\geq \hat{k}}}$. We say that this collection is adapted if the indicator function of A_m is supported in B_m (as in Definition 2.5) for each $m \in M_{\geq \hat{k}}$.

We aim to bound the probability of certain events A_m inductively in k . For this, we will need another definition, concerning the occurrence of A_m in consecutive scales.

Definition 3.2. Fix $\hat{k} \geq 0$ and a collection of events $(A_m)_{m \in M_{\geq \hat{k}}}$. This collection is said to be cascading if, for every $k \geq \hat{k}$ and $m \in M_{k+1}$, we have

$$A_m \subseteq \bigcup_{\substack{m_1 \leftrightarrow_m m_2 \\ m}} A_{m_1} \cap A_{m_2}, \quad (3.8)$$

e:cascading

where $m_1 \leftrightarrow_m m_2$ stands for pairs of indices $m_1, m_2 \in M_k$ such that $B_{m_1}, B_{m_2} \subseteq B_m$ and such that the vertical distance between the boxes B_{m_1}, B_{m_2} is at least L_k .

In the definition above, if $m_1 = (k, y_1)$ and $m_2 = (k, y_2)$ with $y_1 = (x_1, t)$, $y_2 = (x_2, s) \in \mathbb{Z}^d \times \mathbb{Z}$ we say that the vertical distance between the boxes B_{m_1} and B_{m_2} is equal to $[(|t - s| - 1)L_k + 1]^+$.

Intuitively speaking, the above definition says that the occurrence of A_m implies that two similar events happened in well-separated boxes of the smaller scale. The imposition that the boxes indexed by m_1 and m_2 in (3.8) are vertically separated will be useful to decouple the events A_{m_1} and A_{m_2} via Theorem 3.4. Examples of cascading events will be given in Section 3.2.

Given a family $(A_m)_{m \in M_{\geq \hat{k}}}$, we will be interested in the following quantities:

$$p_k(\rho) = \sup_{m \in M_k} \mathbb{P}^\rho(A_m), \quad k \geq \hat{k}. \quad (3.9)$$

Let us also denote

$$\iota_{\hat{k}} := \exp \left\{ 2 \sum_{k \geq \hat{k}} L_k^{-1/16} \right\} \in (0, \infty). \quad (3.10)$$

e:deftota

The next theorem is the main result that we will use in order to bound $p_k(\rho)$.

t:pk'decay

Theorem 3.3. For any $\gamma \in (1, 3/2]$, there exists $k_o = k_o(d, \gamma) \in \mathbb{Z}_+$ such that the following holds. Fix $\hat{k} \geq k_o$ and a collection $(A_m)_{m \in M_{\geq \hat{k}}}$ that is adapted and cascading. Assume that the A_m 's are either all non-increasing or all non-decreasing and that, for some $\hat{\rho} \geq L_{\hat{k}}^{-1/16}$,

$$p_{\hat{k}}(\hat{\rho}) \leq \exp\{-\log L_{\hat{k}}^\gamma\}. \quad (3.11)$$

e:kprime'rhoprime

Then, writing $\rho_* := \iota_{\hat{k}} \hat{\rho}$ and $\rho_{**} := \iota_{\hat{k}}^{-1} \hat{\rho}$, for all $k \geq \hat{k}$ we have

$$p_k(\rho) \leq \exp\{-(\log L_k)^\gamma\} \begin{cases} \forall \rho \geq \rho_* & \text{in the non-increasing case,} \\ \forall \rho \leq \rho_{**} & \text{in the non-decreasing case.} \end{cases} \quad (3.12)$$

e:pk'decay

The upper bound $3/2$ appearing in Theorem 3.3 is not sharp; any number β satisfying $(3/2)^\beta < 2$ would suffice (see (3.16) below).

The statement of the previous theorem has two different cases, depending on whether the events A_m are non-increasing or non-decreasing. All applications considered in this paper concern non-increasing events, but we choose to keep the exposition general in order to be able to use our results in the accompanying paper [13].

One of the main ingredients for the proof of Theorem 3.3 is a recursion inequality for p_k , cf. Lemma 3.5 below. As the cascading property suggests, the key to obtain such a recursion is to decouple pairs of events A_{m_1} and A_{m_2} supported in boxes that are well-separated in time. Recall however that the environment of simple random walks, being conservative, presents poor mixing properties, which makes decoupling hard. We overcome this difficulty using a ‘‘sprinkling technique’’, which consists in performing a change in the density of particles in the environment in order to blur the dependency between such events. Thus, up to an error term, we bound $\mathbb{P}^{\bar{\rho}}(A_{m_1} \cap A_{m_2})$ by the product $\mathbb{P}^\rho(A_{m_1})\mathbb{P}^\rho(A_{m_2})$, where ρ is slightly different from $\bar{\rho}$. This is the content of Theorem 3.4 below, which has different statements for the cases where the events A_m are non-increasing or non-decreasing.

t:decouple

Theorem 3.4. *There exist constants $n_o \in \mathbb{N}$, $C_o \geq 1$ and $c_o > 0$, depending only on d and on the law of $S^{0,1}$, such that the following holds. Let $B = ([a, b]^d \times [n, n']) \cap \mathbb{Z}^d \times \mathbb{Z}$ be a space-time box satisfying $n \geq n_o$, and let $D = \mathbb{Z}^d \times \mathbb{Z}_-$ be the space-time lower half-space. Let $f_1, f_2: \bar{\Omega} \rightarrow [0, 1]$ be measurable functions supported respectively in D and B (cf. Definition 2.5). Denote by $\text{diam}(B)$ the diameter of B . Then, for all $\rho > 0$:*

(a) *If both f_1 and f_2 are non-increasing (cf. Definition 2.3), then*

$$\mathbb{E}^{\rho(1+n^{-1/16})}[f_1 f_2] \leq \mathbb{E}^{\rho(1+n^{-1/16})}[f_1] \mathbb{E}^\rho[f_2] + C_o (\text{diam}(B) + n)^d e^{-2c_o \rho n^{1/8}}. \quad (3.13)$$

e:dec'NI

(b) *If both f_1 and f_2 are non-decreasing (cf. Definition 2.3), then*

$$\mathbb{E}^\rho[f_1 f_2] \leq \mathbb{E}^\rho[f_1] \mathbb{E}^{\rho(1+n^{-1/16})}[f_2] + C_o (\text{diam}(B) + n)^d e^{-2c_o \rho n^{1/8}}. \quad (3.14)$$

e:dec'ND

The proof of Theorem 3.4 is given in the Appendix A, and is very similar to the proof of Theorem C.1 in [16].

We may now identify the constant k_o appearing in Theorem 3.3. Fix $\gamma \in (1, 3/2]$ and let n_o, C_o, c_o as given by Theorem 3.4. Then fix $k_o = k_o(d, \gamma) \in \mathbb{Z}_+$ such that

$$L_{k_o} \geq n_o \quad (3.15)$$

e:defk'o1

and

$$C_o L_k^{2d+1} \left(e^{-(2-(3/2)^{3/2})(\log L_k)^\gamma} + e^{-c_o L_k^{1/16} + (3/2)^{3/2}(\log L_k)^{3/2}} \right) < 1 \quad \forall k \geq k_o. \quad (3.16)$$

e:defk'o2

As anticipated, Theorem 3.4 leads to the following recursion inequality for p_k .

induction

Lemma 3.5. Fix $\gamma \in (1, 3/2]$ and let $k_o \in \mathbb{Z}_+$ as in (3.15)–(3.16). Fix $\hat{k} \geq k_o$ and a collection $(A_m)_{m \in M_{\geq \hat{k}}}$ that is adapted and cascading. Assume that the A_m 's are either all non-increasing or all non-decreasing. For fixed $\rho > 0$ and $k \geq \hat{k}$, define

$$\bar{\rho} = \begin{cases} \rho(1 + L_k^{-1/16}) & \text{in the non-increasing case,} \\ \rho(1 - L_k^{-1/16}) & \text{in the non-decreasing case.} \end{cases} \quad (3.17)$$

e:barrho

Then we have

$$p_{k+1}(\bar{\rho}) \leq C_o L_k^{2d+1} (p_k(\rho)^2 + \exp\{-c_o \rho L_k^{1/8}\}), \quad (3.18)$$

e:induction

where C_o, c_o are as in Theorem 3.4.

Proof. We start with the case when the A_m 's are all non-increasing. Using that the A_m 's are adapted and cascading and that, by (3.15), $L_k \geq n_o$, we apply Theorem 3.4 to the indicator functions of A_{m_1}, A_{m_2} to obtain

$$\begin{aligned} p_{k+1}(\bar{\rho}) &= \sup_{m \in M_{k+1}} \mathbb{P}^{\bar{\rho}}(A_m) \leq \sup_{m \in M_{k+1}} \sum_{\substack{m_1 \leftrightarrow m_2 \\ m}} \mathbb{P}^{\bar{\rho}}(A_{m_1} \cap A_{m_2}) \\ &\stackrel{(3.1)}{\leq} [L_k^{1/2}]^{2(d+1)} \sup_{m \in M_{k+1}} \sup_{\substack{m_1 \leftrightarrow m_2 \\ m}} \mathbb{P}^{\bar{\rho}}(A_{m_1} \cap A_{m_2}) \\ &\stackrel{\text{Theorem 3.4}}{\leq} L_k^{d+1} \sup_{m_1, m_2 \in M_k} (\mathbb{P}^{\bar{\rho}}(A_{m_1}) \mathbb{P}^{\rho}(A_{m_2}) + C_o L_k^d \exp\{-2c_o \rho L_k^{1/8}\}) \\ &\stackrel{A_m \text{ 's non-increas.}}{\leq} C_o L_k^{2d+1} (p_k(\rho)^2 + \exp\{-2c_o \rho L_k^{1/8}\}), \end{aligned} \quad (3.19)$$

This finishes the proof of (3.18) in the first case.

Now assume that the events A_m are all non-decreasing. As before, we can estimate

$$\begin{aligned} p_{k+1}(\bar{\rho}) &= \sup_{m \in M_{k+1}} \mathbb{P}^{\bar{\rho}}(A_m) \leq \sup_{m \in M_{k+1}} \sum_{\substack{m_1 \leftrightarrow m_2 \\ m}} \mathbb{P}^{\bar{\rho}}(A_{m_1} \cap A_{m_2}) \\ &\leq C_o L_k^{2d+1} (p_k(\rho)^2 + \exp\{-2c_o \bar{\rho} L_k^{1/8}\}). \end{aligned} \quad (3.20)$$

Since, by the definition of L_0 , $\bar{\rho} \geq \rho/2$, (3.18) follows. \square

Now that we know how large the sprinkling should be as we move from scale $k+1$ to k in order to obtain a good recursive inequality for the p_k 's, we will introduce a sequence of densities ρ_k .

Given $\rho_{\hat{k}} > 0$, define ρ_k for $k \geq \hat{k}$ recursively by setting

$$\rho_{k+1} = \begin{cases} \rho_k(1 + L_k^{-1/16}) & \text{when the } A_m \text{ 's are all non-increasing,} \\ \rho_k(1 - L_k^{-1/16}) & \text{when the } A_m \text{ 's are all non-decreasing.} \end{cases} \quad (3.21)$$

e:rhok

Note that, with the above definition, when the A_m 's are non-increasing,

$$\log \rho_k = \log \rho_{\hat{k}} + \sum_{i=\hat{k}}^k \log(1 + L_i^{-1/16}) \leq \log \rho_{\hat{k}} + \sum_{i=\hat{k}}^{\infty} L_i^{-1/16} < \log(\iota_{\hat{k}} \rho_{\hat{k}}) < \infty \quad (3.22)$$

e:rho*star

while, when the A_m 's are non-decreasing, since $e^{-2x} \leq 1 - x$ for all $x \in (0, L_0^{-1/16})$,

$$\log \rho_k \geq \log \rho_{\hat{k}} - 2 \sum_{i=\hat{k}}^{\infty} L_i^{-1/16} = \log(\iota_{\hat{k}}^{-1} \rho_{\hat{k}}) > -\infty. \quad (3.23)$$

This shows that the sequence of densities ρ_k is not asymptotically trivial.

We are now in position to prove Theorem 3.3.

Proof of Theorem 3.3. Given $\gamma \in (1, 3/2]$, take k_o as in (3.15)–(3.16). The first step in the proof is to show how one can use (3.18) to transport the bound $p_k(\rho_k) \leq \exp\{-(\log L_k)^\gamma\}$ to the scale $k + 1$. This can be summarized by saying that:

$$\text{if (3.18) holds with } \rho = \rho_k \geq L_k^{-1/16}, \text{ then} \quad (3.24)$$

$$p_k(\rho_k) \leq \exp\{-(\log L_k)^\gamma\} \text{ implies } p_{k+1}(\rho_{k+1}) \leq \exp\{-(\log L_{k+1})^\gamma\}.$$

To see why this is true, let us first use (3.18) in order to estimate

$$\frac{p_{k+1}(\rho_{k+1})}{\exp\{-(\log L_{k+1})^\gamma\}} \leq C_o L_k^{2d+1} \left(e^{-2(\log L_k)^\gamma} + e^{-c_o \rho_k L_k^{1/8}} \right) \exp\{(\log L_{k+1})^\gamma\}. \quad (3.25)$$

Now, since $\rho_k \geq L_k^{-1/16}$ and by (3.1), (3.25) is at most

$$C_o L_k^{2d+1} \left(e^{-(2-(3/2)^{3/2})(\log L_k)^\gamma} + e^{-c_o L_k^{1/16} + (3/2)^{3/2}(\log L_k)^{3/2}} \right) \quad (3.26)$$

which is smaller than 1 by (3.16), proving (3.24).

Let us now see how (3.12) follows from (3.24) and Lemma 3.5. Let $\rho_{\hat{k}} = \hat{\rho}$ (from (3.11)) and define ρ_k for $k \geq \hat{k}$ through (3.21). We claim that, for all $k \geq \hat{k}$,

$$p_k(\rho_k) \leq \exp\{-(\log L_k)^\gamma\}. \quad (3.27)$$

Then (3.12) follows since, by the definition of $\iota_{\hat{k}}$ and (3.22)–(3.23), if $\rho \geq \iota_{\hat{k}} \rho_{\hat{k}}$ and the A_m 's are non-increasing (resp. $\rho \leq \iota_{\hat{k}}^{-1} \rho_{\hat{k}}$ and the A_m 's are non-decreasing), then $p_k(\rho) \leq p_k(\rho_k)$. Thus we only need to prove (3.27).

To this end, we first claim that, for all $k \geq \hat{k}$,

$$\rho_k \geq L_k^{-1/16}. \quad (3.28)$$

Indeed, if the A_m 's are all non-increasing, then $\rho_k \geq \rho_{\hat{k}} \geq L_{\hat{k}}^{-1/16} \geq L_k^{-1/16}$ by (3.21) and our definition of $\rho_{\hat{k}}$ while, if the A_m 's are all non-decreasing, then (3.28) follows by induction using (3.21), (3.1) and the assumption that $\hat{\rho} \geq L_{\hat{k}}^{-1/16}$.

Let us now prove (3.27) by induction on k . The case $k = \hat{k}$ holds by hypothesis. Assume now that (3.27) holds for some $k \geq \hat{k}$. Noting that $\rho_{k+1} \geq L_{k+1}^{-1/16}$ by (3.28) and that (3.18) holds for ρ_k and ρ_{k+1} replacing ρ and $\bar{\rho}$ respectively (because the relation between ρ_{k+1} and ρ_k is exactly as for $\bar{\rho}$ and ρ in Lemma 3.5) we conclude by (3.24), that (3.27) also holds with $k + 1$ replacing k . This concludes the induction step and the proof of the theorem. \square

3.2 Constructing cascading events

ss:cascading

We provide in this section a systematic way to construct certain collections of cascading events based on averages of functions of the random environment along Lipschitz paths. Our ultimate goal is to obtain Corollary 3.11 below, which provides in this context a short-cut to ballisticity-type results with minimal reference to the bulkier technical setup of the previous section.

Let us first describe the type of paths that we will consider. We say that a function $\sigma : \mathbb{Z} \rightarrow \mathbb{Z}^d$ is \mathfrak{R} -Lipschitz if for any $x, y \in \mathbb{Z}$, we have $|\sigma(x) - \sigma(y)| \leq \mathfrak{R}|x - y|$. The set of \mathfrak{R} -Lipschitz paths is defined as

$$\mathfrak{S} := \left\{ \sigma : \mathbb{Z}_+ \rightarrow \mathbb{Z}^d : \sigma(0) = 0, |\sigma(i+1) - \sigma(i)| \leq \mathfrak{R} \forall i \in \mathbb{Z}_+ \right\}, \quad (3.29)$$

e:deffrakS

We will further restrict the class of paths using a function $H : \overline{\Omega} \times \mathbb{Z}^d \rightarrow \{0, 1\}$ as follows. Given such a function H and a path $\sigma : [n, \infty) \rightarrow \mathbb{Z}^d$, we define, for $t \geq n$,

$$h_\sigma(t) := H(\theta_{(\sigma(t), t)}(\omega, U), \sigma(t+1) - \sigma(t)). \quad (3.30)$$

The interpretation is that $h_\sigma(t) = 1$ if and only if the jump $\sigma(t+1) - \sigma(t)$ is allowed by the random environment according to the rule H . The formal definition is as follows.

Definition 3.6. *Given a box index $m \in M_k$, we say that an \mathfrak{R} -Lipschitz function $\sigma : [n, \infty) \cap \mathbb{Z} \rightarrow \mathbb{Z}^d$ is an m -crossing if $(\sigma(n), n) \in I_m$ (recall the definition of B_m and I_m in (3.6) and (3.7)). In addition, if for $H : \overline{\Omega} \times \mathbb{Z}^d \rightarrow \{0, 1\}$ we have $h_\sigma(j) = 1$ for all $j \in [n, n + L_k) \cap \mathbb{Z}$, we say that σ is an (m, H) -crossing.*

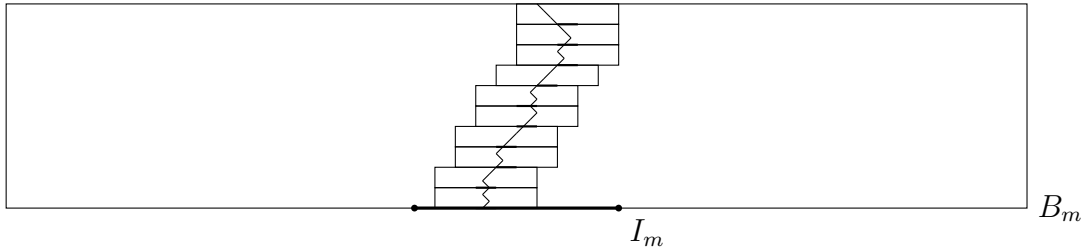


Figure 2: The box B_m for some $m \in M_{k+1}$ and an illustrative m -crossing σ .

Figure 2 illustrates an (m, H) -crossing. Note that an (m, H) -crossing does not exit B_m through its sides. Furthermore, if $m \in M_{k+1}$, every (m, H) -crossing induces L_{k+1}/L_k (m_i, H) -crossings for $m_i \in M_k$ such that $B_{m_i} \subset B_m$. Note that in the particular case where $H \equiv 1$ the notions of m -crossing and (m, H) -crossing coincide.

Remark 3.7. *In the remainder of this paper, we will only be interested in applications where $H \equiv 1$, which implies that every \mathfrak{R} -Lipschitz function starting in I_m is an (m, H) -crossing. The more general set-up to be used in [13] will allow us to consider only paths σ that coincide with the trajectory performed by the random walker.*

The following definition plays a central role in our construction.

Definition 3.8. Given $g : \bar{\Omega} \rightarrow [-1, 1]$, an index $m \in M_k$ and an m -crossing $\sigma : [n, \infty) \cap \mathbb{Z} \rightarrow \mathbb{Z}^d$, we define the average χ_σ^g of g along σ by

$$\chi_\sigma^g(\omega, U) := \frac{1}{L_k} \sum_{i=n}^{n+L_k-1} g_{(\sigma(i), i)}(\omega, U), \quad (3.31)$$

e:chi'g

where $g_y = \theta_y g$ as in (2.12).

Given a scale $\hat{k} \geq 0$ and $v_{\hat{k}} \in [L_{\hat{k}}^{-1/16}, 1]$, recursively define (compare with (3.21))

$$v_{k+1} = v_k(1 - L_k^{-1/16}), \quad k \geq \hat{k}. \quad (3.32)$$

e:vforchi

Note that v_k decreases monotonically to (see (3.23))

$$v_\infty := v_{\hat{k}} \prod_{k \geq \hat{k}} (1 - L_k^{-1/16}) \in (0, 1). \quad (3.33)$$

e:defvinfy

Given $g : \bar{\Omega} \rightarrow [-1, 1]$, $H : \bar{\Omega} \times \mathbb{Z}^d \rightarrow \{0, 1\}$ and an integer $k \geq \hat{k}$, define the events

$$A_m = \left\{ \text{there exists an } (m, H)\text{-crossing } \sigma \text{ such that } \chi_\sigma^g < v_k \right\}, \quad m \in M_k. \quad (3.34)$$

e:A'm'with'chi

Note that the events defined by (3.34) are not necessarily adapted or monotone. However, as already anticipated, we have the following.

l:build'cascade

Lemma 3.9. The family $(A_m)_{m \in M_{\geq \hat{k}}}$ defined by (3.34) is cascading.

Proof. Fix $k \geq \hat{k}$ and recall that we have assumed $v_{\hat{k}} \geq L_{\hat{k}}^{-1/16}$. The first thing we note is that this inequality holds for all $k \geq \hat{k}$. This indeed follows by induction using the definition of v_k exactly as for (3.28).

Next we claim that:

$$\begin{aligned} \text{if } A_m \text{ occurs for some } m \in M_{k+1}, \text{ then there exist at least three elements} \\ m_i = (k, y_i) \text{ in } M_k, i = 1, 2, 3, \text{ with } y_i = (x_i, s_i) \in \mathbb{Z}^d \times \mathbb{Z} \text{ and } B_{m_i} \subset B_m \\ \text{satisfying } s_i \neq s_j \text{ when } i \neq j \text{ and such that } A_{m_i} \text{ occurs for } i = 1, 2, 3. \end{aligned} \quad (3.35)$$

e:A'k+1'k

Indeed, assume by contradiction that

$$\begin{aligned} \text{there are at most two elements } m' = (k, y'), m'' = (k, y'') \text{ in } M_k \text{ with} \\ y' = (x', s') \text{ and } y'' = (x'', s''), s' \neq s'' \text{ and } B_{m'}, B_{m''} \text{ contained in } B_m \\ \text{for which the events } A_{m'} \text{ and } A_{m''} \text{ happen.} \end{aligned} \quad (3.36)$$

e:at'most'two

Let σ be an (m, H) -crossing. We split its domain into disjoint intervals of length L_k :

$$\{n, \dots, n+L_{k+1}-1\} = \bigcup_{j=1}^J \{n+(j-1)L_k, \dots, n+jL_k-1\}, \quad \text{where } J = L_{k+1}/L_k, \quad (3.37)$$

Let us denote by σ_j , $j \in \{1, \dots, J\}$, the restriction of σ to $[n + (j-1)L_k, n + jL_k)$ which is again an (m_j, H) -crossing for an appropriate index m_j in M_k , with $B_{m_j} \subset B_m$ (see Figure 2). We now estimate

$$\begin{aligned}
\chi_\sigma^g &= \frac{1}{L_{k+1}} \sum_{i=n}^{n+L_{k+1}-1} g_{(\sigma(i), i)} = \frac{1}{L_{k+1}} \sum_{j=1}^J \sum_{i=n+jL_k}^{n+(j+1)L_k-1} g_{(\sigma(i), i)} = \frac{L_k}{L_{k+1}} \sum_{j=1}^J \chi_{\sigma_j}^g \\
&\stackrel{(3.36)}{\geq} -2 \frac{L_k}{L_{k+1}} + v_k \frac{L_k}{L_{k+1}} \left(\frac{L_{k+1}}{L_k} - 2 \right) \\
&\geq v_k - 4 \frac{L_k}{L_{k+1}} = v_{k+1} + (v_k - v_{k+1}) - 4 \frac{L_k}{L_{k+1}},
\end{aligned} \tag{3.38}$$

where, in the first inequality, we used the fact that, if A_{m_i} does not occur for some $i \in \{1, \dots, J\}$, then $1 \geq \chi_\sigma^g \geq v_k$. From the definition of v_k , we see that

$$v_k - v_{k+1} = v_k L_k^{-1/16} \geq \frac{1}{L_k^{1/8}} \geq \frac{4}{\lfloor L_k^{1/2} \rfloor} = 4 \frac{L_k}{L_{k+1}}, \tag{3.39}$$

where for the second inequality we use $L_k \geq 10^{50}$ (cf. (3.1)). Substituting this into (3.38), we get $\chi_\sigma^g \geq v_{k+1}$ so that A_m cannot occur. This proves the claim (3.35).

Thus, on the event A_m , we may assume that there exist $m_1 = (k, y_1)$, $m_3 = (k, y_3)$ in M_k where $y_1 = (x_1, s_1)$ and $y_3 = (x_3, s_3)$ with $s_3 \geq s_1 + 2$ (meaning that the vertical distance between B_{m_3} and B_{m_1} is at least L_k) and such that both A_{m_1} and A_{m_3} occur. This finishes the proof of the lemma. \square

The events defined by (3.34) may be analysed with the help of Theorem 3.3 whenever they are adapted and monotone. We next give a complementary result stating that, whenever the conclusion of Theorem 3.3 holds for $(A_m)_{m \in M_{\geq \hat{k}}}$, it can be extended by interpolation to boxes of length $L \in \mathbb{N}$ (not necessarily of the form L_k). We first need to extend the above definitions.

For $y \in \mathbb{Z}^d \times \mathbb{Z}$ and $L \in \mathbb{N}$, let

$$B_{y,L} = y + \{[-2\mathfrak{R}L, 3\mathfrak{R}L]^d \times [0, L)\} \cap (\mathbb{Z}^d \times \mathbb{Z}) \tag{3.40}$$

and similarly

$$I_{y,L} = y + ([0, \mathfrak{R}L]^d \times \{0\}) \cap (\mathbb{Z}^d \times \mathbb{Z}). \tag{3.41}$$

Given a function $H : \bar{\Omega} \times \mathbb{Z}^d \rightarrow \{0, 1\}$ and $y = (x, n)$, we define a (y, L, H) -crossing to be an \mathfrak{R} -Lipschitz function $\sigma : [n, \infty) \cap \mathbb{Z} \rightarrow \mathbb{Z}^d$ such that $(\sigma(n), n) \in I_{y,L}$ and $h_\sigma(j) = 1$ for every $j \in [n, n+L) \cap \mathbb{Z}$. If the function H is identically equal to one we simply say that σ is a (y, L) -crossing.

Finally, given σ a (y, L, H) -crossing, we let

$$\chi_\sigma^g(\omega, U) := \frac{1}{L} \sum_{i=n}^{n+L-1} g_{(\sigma(i), i)}(\omega, U). \tag{3.42}$$

Our interpolation result reads as follows.

Proposition 3.10. Fix $\hat{k} \geq 0$, $v_{\hat{k}} \in [L_{\hat{k}}^{-1/16}, 1]$ and two functions $g : \bar{\Omega} \rightarrow [-1, 1]$, $H : \bar{\Omega} \times \mathbb{Z}^d \rightarrow \{0, 1\}$. Define $(A_m)_{m \in M_{\geq \hat{k}}}$ by (3.34). Fix $\rho > 0$, $\gamma \in (1, 3/2]$ and assume that

$$p_k(\rho) = \max_{m \in M_k} \mathbb{P}^\rho(A_m) \leq \exp\{-(\log L_k)^\gamma\} \quad \forall k \geq \hat{k}. \quad (3.43)$$

`e:assump'interpol`

Then, for every $\varepsilon > 0$, there exists $c > 0$ such that

$$\mathbb{P}^\rho(\exists a (0, L)\text{-crossing } \sigma \text{ s.t. } \chi_\sigma^g < v_\infty - \varepsilon) \leq c^{-1} e^{-c(\log L)^\gamma} \quad \forall L \geq 1, \quad (3.44)$$

`e:interpolate`

where v_∞ is given by (3.33).

Proof. We follow the proof of Lemma 3.5 in [16]. We may assume L to be so large that, defining \check{k} by $2L_{\check{k}+2} \leq L < 2L_{\check{k}+3}$, then $\check{k} \geq \hat{k}$ and $\frac{L_{\check{k}+1}}{L_{\check{k}}} > 1 + 2/\varepsilon$ for all $k \geq \check{k}$.

We first consider multiples of L_k , $k \geq \check{k}$. Define

$$M'_k := \{m \in M_k : B_m \subset B_{(k+2,0)}\}, \quad (3.45)$$

$$\mathcal{B}_{\check{k}} := \bigcap_{k \geq \check{k}} \bigcap_{m \in M'_k} A_m^c \quad (3.46)$$

$$\text{and } J_{\check{k}} := \bigcup_{k \geq \check{k}} \bigcup_{l=1}^{L_{k+2}/L_k} \{lL_k\} \subset \mathbb{N}. \quad (3.47)$$

Let us see that $\mathcal{B}_{\check{k}}$ has high probability. Indeed,

$$\begin{aligned} \mathbb{P}^\rho(\mathcal{B}_{\check{k}}^c) &\leq \sum_{k \geq \check{k}} \sum_{m \in M'_k} \mathbb{P}(A_m) \stackrel{(3.43)}{\leq} \sum_{k \geq \check{k}} c \left(\frac{L_{k+2}}{L_k} \right)^{d+1} e^{-(\log L_k)^\gamma} \\ &\leq c^{-1} e^{-c(\log L_{\check{k}})^\gamma} \leq c^{-1} e^{-c(\log L)^\gamma}, \end{aligned} \quad (3.48)$$

`e:printerpl`

where for the last inequality we used that $L_{\check{k}} \geq L_{\check{k}+3}^{(2/3)^3} > \frac{1}{2} L^{(2/3)^3}$.

We now claim that:

$$\text{on } \mathcal{B}_{\check{k}}, \text{ for any } L' \in J_{\check{k}} \text{ and any } ((0, L'), h)\text{-crossing } \sigma, \text{ we have } \chi_\sigma^g \geq v_\infty. \quad (3.49)$$

`e:LinJ`

Let us prove this for fixed $k \geq \check{k}$ by induction on $l \leq L_{k+2}/L_k$. For $l = 1$, the claim holds since any $((0, L_k), h)$ -crossing σ is indeed an (m, H) -crossing for $m = (k, 0)$ so that, on the event $A_m^c \subset \mathcal{B}_{\check{k}}$, we have $\chi_\sigma^g \geq v_k \geq v_\infty$. Assume that it holds for $L' = lL_k$ with $1 \leq l < L_{k+2}/L_k$. Fix a $((0, (l+1)L_k), h)$ -crossing σ . Notice that there exists $m \in M'_k$ such that $(\sigma(lL_k), lL_k) \in I_m$. Therefore, σ restricted to times $i = lL_k, \dots, (l+1)L_k - 1$ is an (m, H) -crossing and σ restricted to times $i = 0, \dots, lL_k - 1$ is a $((0, lL_k), h)$ -crossing. Hence, by induction and since we are on $\mathcal{B}_{\check{k}}$,

$$\begin{aligned} \sum_{i=0}^{(l+1)L_k-1} g(\sigma(i), i) &= \sum_{i=0}^{lL_k-1} g(\sigma(i), i) + \sum_{i=lL_k}^{(l+1)L_k-1} g(\sigma(i), i) \\ &\geq v_\infty lL_k + v_k L_k \geq v_\infty (l+1)L_k, \end{aligned} \quad (3.50)$$

completing the induction step and proving (3.49).

We now prove (3.44). In fact, we show that

$$\text{on } \mathcal{B}_{\check{k}}, \chi_{\sigma}^g \geq v_{\infty} - \varepsilon \text{ for any } (0, n)\text{-crossing } \sigma \text{ with } n \geq 2L_{\check{k}+2}. \quad (3.51)$$

To this end, for n as in (3.51), define $\bar{k} = \bar{k}(n)$ to be the smallest integer such that $n \in [\bar{l}L_{\bar{k}}, (\bar{l} + 1)L_{\bar{k}}]$ for some $1 \leq \bar{l} \leq L_{\bar{k}+2}/L_{\bar{k}}$. Note that $\bar{k} \geq \check{k}$ and that, by the minimality of \bar{k} , we have $n \geq L_{\bar{k}+1}$ and thus $\bar{l} \geq 2/\varepsilon$. Then estimate

$$\begin{aligned} \sum_{i=0}^{n-1} g_{(\sigma(i), i)} &= \sum_{i=0}^{\bar{l}L_{\bar{k}}-1} g_{(\sigma(i), i)} + \sum_{i=\bar{l}L_{\bar{k}}}^{n-1} g_{(\sigma(i), i)} \\ &\geq v_{\infty}\bar{l}L_{\bar{k}} - L_{\bar{k}} = L_{\bar{k}}((v_{\infty} - \varepsilon)\bar{l} + \varepsilon\bar{l} - 1) \\ &\geq L_{\bar{k}}(v_{\infty} - \varepsilon)(\bar{l} + 1) \geq n(v_{\infty} - \varepsilon), \end{aligned} \quad (3.52)$$

where we used (3.49), $|g| \leq 1$ and $v_{\infty} \leq 1$. This finishes the proof. \square

We may now state our target corollary, which conveniently summarizes ballisticity-type results without explicit reference to most of the technical renormalisation setup. Recall (3.42) and the definition above.

Corollary 3.11. *Let $(L_k)_{k \in \mathbb{Z}_+}$ be given by (3.1). For any $\gamma \in (1, 3/2]$, there exists an index $k_o = k_o(\gamma, d) \in \mathbb{N}$ satisfying the following. Fix two functions $g : \bar{\Omega} \rightarrow [-1, 1]$, $H : \bar{\Omega} \times \mathbb{Z}^d \rightarrow \{0, 1\}$ and two non-negative sequences $v(L), \rho(L)$. Assume that, for some $L_* \in \mathbb{N}$ and all $L \geq L_*$, $v(L) \wedge \rho(L) \geq L^{-1/16}$ and, for any $\hat{v} > 0$, the event*

$$\left\{ \text{there exists a } (0, L, H)\text{-crossing } \sigma \text{ such that } \chi_{\sigma}^g \leq \hat{v} \right\} \quad (3.53)$$

is measurable in $\sigma(N(y), U_y : y \in B_{0,L})$ and non-increasing (respectively non-decreasing). Assume additionally that, for some $\hat{k} \geq k_o$ such that $L_{\hat{k}} \geq L_$,*

$$\mathbb{P}^{\rho(L_{\hat{k}})}(\exists \text{ a } (0, L_{\hat{k}}, H)\text{-crossing } \sigma \text{ such that } \chi_{\sigma}^g \leq v(L_{\hat{k}})) \leq \exp(-(\log L_{\hat{k}})^{\gamma}). \quad (3.54)$$

Then there exist (explicit) $\rho_{\infty}, v_{\infty} > 0$ such that, for each $\varepsilon > 0$,

$$\mathbb{P}^{\rho}(\exists \text{ a } (0, L, H)\text{-crossing } \sigma \text{ such that } \chi_{\sigma}^g \leq v_{\infty} - \varepsilon) \leq c^{-1} \exp(-c(\log L)^{\gamma}) \quad (3.55)$$

for some $c \in (0, \infty)$, all $L \in \mathbb{N}$ and all $\rho \geq \rho_{\infty}$ (respectively, all $\rho \leq \rho_{\infty}$).

Before we proceed to the proof, a few words about Corollary 3.11. Assumption (3.54) can be interpreted as a *triggering condition*, i.e., an a-priori estimate that must be provided in order to start the renormalisation procedure. The measurability and monotonicity assumptions must be checked in each case. Note that measurability follows whenever g and $H(\cdot, x)$ (for all $x \in \mathbb{Z}^d$) are *local* (i.e., supported in a finite set in the sense of Definition 2.9) and *instantaneous*, where we say that a function $f : \bar{\Omega} \rightarrow \mathbb{R}$ is instantaneous if $f(\omega, U) \in \sigma(N(z, 0), U_{(z,0)}) : z \in \mathbb{Z}^d$, i.e., f depends only on one time slice of the random environment.

Proof of Corollary 3.11. Let $k_o \in \mathbb{N}$ be as in the statement of Theorem 3.3, and fix $\hat{k} \geq k_o$ satisfying $L_{\hat{k}} \geq L_*$ and (3.54). Setting $v_{\hat{k}} := v(L_{\hat{k}})$, define v_k , $k > \hat{k}$ as in (3.32) and v_∞ as in (3.33). For $k \geq \hat{k}$, let A_m be defined as in (3.34) and $p_k(\rho)$ as in (3.9). Note that the events A_m , for $m \in M_{\geq \hat{k}}$ as above are cascading, adapted and non-decreasing (resp. non-increasing) according to Lemma 3.9 and our assumptions.

Set now $\hat{\rho} := \rho(L_{\hat{k}})$ and note that, by (3.54),

$$p_{\hat{k}}(\hat{\rho}) \leq \exp\left(-(\log L_{\hat{k}})^\gamma\right). \quad (3.56)$$

Therefore we can use Theorem 3.3 to conclude that, for some $\rho_\infty > 0$ (more precisely, $\rho_\infty := \rho_*$ in the non-increasing case, or $\rho_\infty := \rho_{**}$ in the non-decreasing case),

$$p_k(\rho) \leq \exp\left\{-\left(\log L_k\right)^\gamma\right\}, \text{ for every } k \geq \hat{k} \quad (3.57)$$

for any $\rho \geq \rho_\infty$ in the non-increasing case, or any $\rho \leq \rho_\infty$ in the non-decreasing case. The conclusion then follows from Proposition 3.10. \square

4 Applications

s:applications

This section is dedicated to applying the renormalization setup developed in Section 3 to show ballistic behavior of two processes. Namely, for a random walker in the environment of simple random walks and for the front of an infection process.

4.1 Random walker on random walks (large density)

In this subsection, we will prove a ballisticity result for the random walker in the environment of simple random walks, generalizing Theorem 1.5 of [16]. Let

$$\mathcal{H}_{v,L} := \{(x, n) \in \mathbb{Z}^d \times \mathbb{Z} : x \cdot e_1 \leq -L + vn\}. \quad (4.1) \quad \text{e:defcH}$$

thm:ballisticity

Theorem 4.1 (Ballisticity condition). *For any $v_\star \in (0, v_\bullet)$, there exists $\rho_\star \in (0, \infty)$ and $c > 0$ such that, for all $\rho \geq \rho_\star$,*

$$\mathbb{P}^\rho(\exists n \geq 0 : Y_n \in \mathcal{H}_{v_\star, L}) \leq c^{-1} e^{-c(\log L)^{3/2}} \quad \forall L \geq 1. \quad (4.2) \quad \text{e:LD}$$

Theorem 4.1 will be proved by means of two propositions stated and proved below. Both the theorem and these intermediate results will be crucial to control the tail of the regeneration time constructed in Section 5.

The next proposition is very intuitive, stating that if the density is high enough then all paths stay most of their time on points with a large number of particles.

Proposition 4.2 (Uniform density control along paths). *For all $K \in \mathbb{N}$ and $\varepsilon \in (0, 1)$, there exists $c > 0$ and $\rho(K, \varepsilon) \in (0, \infty)$ such that, for all $\rho \geq \rho(K, \varepsilon)$,*

$$\mathbb{P}^\rho\left(\exists \ell \geq L/(2\mathfrak{N}), \sigma \in \mathfrak{S} : \sum_{i=0}^{\ell-1} \mathbb{1}_{\{N(\sigma(i), i) \geq K\}} < (1 - \varepsilon)\ell\right) \leq c^{-1} e^{-c(\log L)^{3/2}} \quad (4.3) \quad \text{e:enoughparticles}$$

for all $L \geq 1$.

Proof. Take k_o as in the statement of Theorem 3.3 for $\gamma = 3/2$, and let $\hat{k} \geq k_o$ be large enough such that $\prod_{k \geq \hat{k}} (1 - L_k^{-1/16}) \geq 1 - \varepsilon/2$. Choose $v_{\hat{k}} := 1$, $g := \mathbb{1}_{\{N(0,0) \geq K\}}$, $H \equiv 1$ (thus, we will say only m -crossing instead of (m, H) -crossing). Define the family $(A_m)_{m \in M_{\geq \hat{k}}}$ as in (3.34) and note that it is adapted and that each A_m is non-increasing. For a fixed $\hat{\rho} > 0$, consider the crude bound

$$\begin{aligned} p_{\hat{k}}(\hat{\rho}) &\leq \mathbb{P}^{\hat{\rho}}(\exists(y, n) \in B_{L_{\hat{k}}} \text{ such that } N(y, n) < K) \\ &\leq (5\mathfrak{R}L_{\hat{k}})^d L_{\hat{k}} \mathbb{P}^{\hat{\rho}}(N(0, 0) < K) \leq (5\mathfrak{R}L_{\hat{k}})^d L_{\hat{k}} K (\hat{\rho} \vee 1)^K e^{-\hat{\rho}}. \end{aligned} \quad (4.4)$$

For fixed K, \hat{k} , we can choose $\hat{\rho} \geq L_{\hat{k}}^{-1/16}$ such that the right-hand side of (4.4) is less than $\exp(-(\log L_{\hat{k}})^{3/2})$. Therefore, by Theorem 3.3 and Proposition 3.10, there exists $c > 0$ such that, for all $\rho \geq \rho(K, \varepsilon) := \iota_{\hat{k}} \hat{\rho}$ (with $\iota_{\hat{k}}$ as in (3.10)) and all $\ell \geq 1$,

$$\mathbb{P}^{\rho} \left(\text{there exists a } (0, \ell)\text{-crossing } \sigma \text{ with } \sum_{i=0}^{\ell-1} \mathbb{1}_{\{N(\sigma(i), i) \geq K\}} < (1 - \varepsilon)\ell \right) \leq c^{-1} e^{-c(\log \ell)^{3/2}}$$

The proposition follows by noticing that the first ℓ steps of any $\sigma \in \mathfrak{S}$ form a $(0, \ell)$ -crossing, and then applying a union bound. \square

Our second proposition is a quenched deviation estimate for the position of the random walk. Intuitively speaking, it says that if all paths spend a large proportion of their time in sites with many particles, then the random walker itself has to move ballistically.

For technical reasons we first have to restrict our attention to the collection of paths that behave well in a certain sense. For $L \in \mathbb{N}$ and $v \in (0, \mathfrak{R}]$, let $\mathfrak{S}^{v, L}$ be those paths of \mathfrak{S} that never touch $\mathcal{H}_{v, L}$. More precisely

$$\mathfrak{S}^{v, L} := \{ \sigma \in \mathfrak{S} : (\sigma(i), i) \notin \mathcal{H}_{v, L} \forall i \in \mathbb{Z}_+ \}. \quad (4.5)$$

For $K \in \mathbb{N}$, $\varepsilon > 0$ and $y \in \mathbb{Z}^d \times \mathbb{Z}$, let

$$\mathcal{A}_y^{L, v, K, \varepsilon} := \left\{ \exists \ell \geq L/(2\mathfrak{R}), \sigma \in \mathfrak{S}^{v, L} : \sum_{i=0}^{\ell-1} \mathbb{1}_{\{N(y + (\sigma(i), i)) \geq K\}} < (1 - \varepsilon)\ell \right\}. \quad (4.6)$$

Proposition 4.3 (Quenched deviation estimate). *For all $v_{\star} \in (0, v_{\bullet})$, there exist $k_{\star} \in \mathbb{N}$, $\varepsilon_{\star} \in (0, 1)$ and $c > 0$ such that, for all $\rho \in (0, \infty)$, $y \in \mathbb{Z}^d \times \mathbb{Z}$, $v \leq v_{\star}$ and $K \geq k_{\star}$, \mathbb{P}^{ρ} -almost surely, if the event $\mathcal{A}_y^{L, v, K, \varepsilon_{\star}}$ does not occur then*

$$\mathbb{P}^{\rho}(\exists \ell \geq 0 : Y_{\ell}^y - y \in \mathcal{H}_{v, L} \mid \omega) \leq c^{-1} e^{-cL}. \quad (4.7)$$

Proof. Let $y = (x, n) \in \mathbb{Z}^d \times \mathbb{Z}$ be fixed. Fix $\delta_{\star} \in (0, 1)$ satisfying $v_{\star} + 2\delta_{\star} < v_{\bullet}$. By Assumption (D), there exists a $k_{\star} \in \mathbb{N}$ such that

$$\inf_{k \geq k_{\star}} \sum_{z \in \mathcal{S}} \alpha(k, z) z \cdot e_1 > v_{\star} + 2\delta_{\star}. \quad (4.8)$$

Take $\varepsilon_\star \in (0, 1)$ small enough such that $2(\mathfrak{R} + 1)\varepsilon_\star < \delta_\star$, and fix $K \geq k_\star$, $v \leq v_\star$.

For $(z, l) \in \mathbb{Z}^d \times \mathbb{Z}$, let

$$d^\omega(z, l) := \mathbb{E}^\rho \left[(X_1^{(z, l)} - z) \cdot e_1 \mid \omega \right] = \sum_{u \in \mathcal{S}} u \cdot e_1 \alpha(N(z, l), u) \quad (4.9) \quad \text{e:deftocaldrift}$$

denote the quenched local drift in direction e_1 at the point (z, l) . For $\sigma \in \mathfrak{S}$, let

$$D_\ell^\omega(\sigma) := \sum_{k=0}^{\ell-1} d^\omega(y + (\sigma(k), k)) \quad (4.10) \quad \text{e:deftotaldrift}$$

be the total drift accumulated along the path that starts at y and has increments given by σ up to time $\ell \in \mathbb{N}$. When $\sigma = X^y - x$ we omit it and write D_ℓ^ω . On $(\mathcal{A}_y^{L, v, K, \varepsilon_\star})^c$, for all $\ell \geq L/(2\mathfrak{R})$ and all $\sigma \in \mathfrak{S}^{v, L}$,

$$\begin{aligned} D_\ell^\omega(\sigma) &\geq (v_\star + 2\delta_\star) \sum_{k=0}^{\ell-1} \mathbb{1}_{\{N(y+(\sigma(k), k)) \geq K\}} - \mathfrak{R} \sum_{k=0}^{\ell-1} \mathbb{1}_{\{N(y+(\sigma(k), k)) < K\}} \\ &\geq [v_\star + 2\delta_\star - \varepsilon_\star(v_\star + \mathfrak{R} + 2\delta_\star)] \ell \\ &> (v_\star + \delta_\star) \ell \geq (v + \delta_\star) \ell. \end{aligned} \quad (4.11) \quad \text{e:propdrift}$$

by our choice of δ_\star , k_\star and ε_\star .

Note that, under $\mathbb{P}^\rho(\cdot \mid \omega)$, the process

$$\begin{aligned} M_\ell &:= (X_\ell^y - x) \cdot e_1 - D_\ell^\omega \\ &= \sum_{k=0}^{\ell-1} (X_{k+1}^y - X_k^y) \cdot e_1 - \mathbb{E}^\rho \left[(X_{k+1}^y - X_k^y) \cdot e_1 \mid X_0^y, \dots, X_k^y, \omega \right] \end{aligned} \quad (4.12) \quad \text{e:deftmartingale}$$

is a zero-mean martingale with respect to the filtration $\sigma(X_0^y, \dots, X_\ell^y)$, and has increments bounded by $2\mathfrak{R}$. Therefore, by Azuma's inequality and a union bound, there exists a $c > 0$ such that

$$\mathbb{P}^\rho(\exists \ell \geq L/(2\mathfrak{R}): |M_\ell| \geq \delta_\star \ell \mid \omega) \leq c^{-1} e^{-cL} \quad \forall L \in \mathbb{N}. \quad (4.13) \quad \text{e:applyAzuma}$$

Now we argue that, on $(\mathcal{A}_y^{L, v, K, \varepsilon_\star})^c$,

$$\{\exists \ell \geq 0: Y_\ell^y - y \in \mathcal{H}_{v, L}\} \subset \{\exists \ell \geq L/(2\mathfrak{R}): |M_\ell| \geq \delta_\star \ell\}. \quad (4.14) \quad \text{e:lastargquenched}$$

Indeed, let $\ell_0 \in \mathbb{N}$ be the smallest time satisfying $Y_{\ell_0}^y - y \in \mathcal{H}_{v, L}$. Then $\ell_0 \geq L/(\mathfrak{R} + v) \geq L/(2\mathfrak{R})$. Setting $\sigma = X^y - x$ up to time $\ell_0 - 1$ and equal to an arbitrary \mathfrak{R} -Lipschitz path that does not touch $\mathcal{H}_{v, L}$ for times greater than ℓ_0 , then $\sigma \in \mathfrak{S}^{v, L}$ and we obtain by (4.11) that, on $(\mathcal{A}_y^{L, v, K, \varepsilon_\star})^c$, $D_{\ell_0}^\omega \geq (v + \delta_\star) \ell_0$. If additionally $|M_{\ell_0}| < \delta_\star \ell_0$ would hold, then we would have a contradiction since

$$(X_{\ell_0}^y - x) \cdot e_1 \geq D_{\ell_0}^\omega(\sigma) - |M_{\ell_0}| > v \ell_0 \Rightarrow Y_{\ell_0}^y - y \notin \mathcal{H}_{v, L}. \quad (4.15) \quad \text{e:contradiction}$$

This shows (4.14), and the conclusion follows by (4.13). \square

Propositions 4.2–4.3 imply the ballisticity condition (4.2) as follows.

Proof of Theorem 4.1. For $v_\star \in (0, v_\bullet)$, fix $k_\star \in \mathbb{N}$, $\varepsilon_\star > 0$ as in Proposition 4.3 and set $\rho_\star := \rho(k_\star, \varepsilon_\star)$ as in Proposition 4.2. The theorem follows by noting that

$$\mathcal{A}_y^{L, v, K, \varepsilon} \subset \left\{ \exists \ell \geq L/(2\mathfrak{A}), \sigma \in \mathfrak{S} : \sum_{k=1}^{\ell-1} \mathbb{1}_{\{N(y+(\sigma(k), k)) \geq K\}} < (1 - \varepsilon)\ell \right\} \quad (4.16)$$

and that the probability of the right-hand side of (4.16) does not depend on y . \square

4.2 Infection

In this subsection, we prove Proposition 1.2 regarding the front of the infection process described in the introduction. We start with a precise construction of the model.

Fix $\rho > 0$, $d = 1$ and let $N(z, 0)$ and $S^{z, i}$ be as in Section 2, i.e., $(N(z, 0))_{z \in \mathbb{Z}}$ are i.i.d. Poisson(ρ) random variables and $(S^{z, i} - z)_{z \in \mathbb{Z}, i \in \mathbb{N}}$ are i.i.d., each distributed as a double-sided simple symmetric random walk on \mathbb{Z} started at 0.

We also introduce random variables $\eta(z, i, n) \in \{0, 1\}$ to indicate whether the particle corresponding to $S^{z, i}$ is healthy ($\eta(z, i, n) = 0$) or infected ($\eta(z, i, n) = 1$) at time n . We will define them recursively as follows. Set the initial configuration to be

$$\eta(z, i, 0) = 1 \quad \text{if } z \leq 0 \text{ and } i \leq N(z, 0), \quad (4.17)$$

$$\eta(z, i, 0) = 0 \quad \text{otherwise.} \quad (4.18)$$

Supposing that, for some $n \geq 0$, $\eta(z, i, n)$ is defined for all $z \in \mathbb{Z}$, $i \in \mathbb{N}$, we set

$$\eta(z, i, n+1) = \begin{cases} 1 & \text{if } i \leq N(z, 0) \text{ and there exists} \\ & z' \in \mathbb{Z}, i' \in \mathbb{N} \text{ with } \eta(z', i', n) = 1, S_n^{z', i'} = S_n^{z, i}, \\ 0 & \text{otherwise.} \end{cases} \quad (4.19)$$

This definition means that, whenever a collection of particles share the same site at time n , if one of them is infected then they will all become infected at time $n+1$.

We are interested in the process $\bar{X} = (\bar{X}_n)_{n \in \mathbb{Z}_+}$ defined by

$$\bar{X}_n = \max\{S_n^{z, i} : \eta(z, i, n) = 1\}, \quad (4.20)$$

i.e., \bar{X}_n is the rightmost infected particle at time n . We call \bar{X} the *front of the infection*.

Note that the process η differs slightly from that described in the introduction, where particles sharing a site with an infected one were required to become immediately infected. However, it is easy to check that the process \bar{X} is not affected by this difference, and we choose to work with η for simplicity.

Our first result towards Proposition 1.2 is a reduction step, stating that it suffices to find, with high probability, enough times n when the front \bar{X}_n of the infection process is close to another particle. For this we fix $r \geq 0$ and define g_r by

$$g_r = \mathbb{1}_{\left\{ \sum_{x \in [-r, r] \cap (2\mathbb{Z})} N(x, 0) \geq 2 \right\}}, \quad (4.21)$$

that is, g_r is the indicator function of the event that, at time zero, there are at least two particles at even sites within distance r from the origin. Our lemma reads as follows.

Lemma 4.4. Fix $\rho > 0$ and $r \geq 0$ and suppose that, for some $h \in (0, 1)$, $c > 0$,

$$\mathbb{P}^\rho \left(\chi_\sigma^{g_r} \geq h \text{ for every 1-Lipschitz path } \sigma : \{0, \dots, L\} \rightarrow \mathbb{Z} \text{ with } |\sigma(0)| < L \right) \geq 1 - c^{-1} e^{-c(\log L)^{3/2}} \quad \forall L \geq 1, \quad (4.22)$$

e:always'close

where g_r is as in (4.21) and $\chi_\sigma^{g_r}$ as in (3.31). Then (1.8) holds for some $v, c > 0$.

Proof. One can check from the definition of the rightmost infected particle that the increment $\bar{X}_{n+1} - \bar{X}_n$ always dominates that of a symmetric random walk on \mathbb{Z} . At some steps, however, this increment has a drift to the right, namely when there is more than one particle at \bar{X}_n . The idea of the proof will be to bound the number of times at which such positive drift is observed.

We first note that the front starts close to the origin. Indeed,

$$\mathbb{P}^\rho \left(\bar{X}_0 < -\sqrt{L} \right) = \mathbb{P}^\rho \left(N(z, 0) = 0 \quad \forall z \in [-\sqrt{L}, 0] \cap \mathbb{Z} \right) \leq c e^{-\rho\sqrt{L}}. \quad (4.23)$$

Now, at every time n' at which there is another particle at distance at most r from the front $\bar{X}_{n'}$ at a site with the same parity as $\bar{X}_{n'}$, we can use the Markov property to see that, with uniformly positive probability, this additional particle will reach the front within the next r steps. This means that, if n' is such a time, the increment $\bar{X}_{n'+r+1} - \bar{X}_{n'}$ stochastically dominates (under the conditional law given $(N(\cdot, \ell))_{\ell \leq n'}$) a random variable ζ with positive expectation satisfying $|\zeta| \leq r + 1$. We will show that $v = hE[\zeta]/(3(r + 1))$ fulfills (1.8).

Consider the 1-Lipschitz path given by the front $(\bar{X}_\ell)_{\ell=0}^L$. Denote by \mathcal{D} the intersection of the event appearing in (4.22) with $\{\bar{X}_0 \geq -\sqrt{L}\}$. On \mathcal{D} , we see that, for at least $\lfloor hL \rfloor$ steps between times zero and L , the front \bar{X} is r -close to another particle. Therefore, the same happens for at least $k_L := \lfloor \lfloor hL \rfloor / (r + 1) \rfloor$ steps that are at least $r + 1$ time units apart from each other, and we can estimate using the Markov property

$$\mathbb{P}^\rho[\bar{X}_L < vL] \leq \mathbb{P}^\rho(\mathcal{D}^c) + \mathbb{P}^\rho(\zeta_1 + \dots + \zeta_{k_L} < 2vL + \sqrt{L}) + \mathbb{P}^\rho(S_{L-(r+1)k_L}^{0,1} < -vL),$$

where the ζ_i 's are i.i.d. and distributed as ζ . Applying standard large deviation estimates to the sum of the ζ_i 's and to $S^{0,1}$, we see that

$$\mathbb{P}^\rho(\bar{X}_L < vL) \leq \mathbb{P}^\rho(\mathcal{D}^c) + c^{-1} \exp\{-cL\} + \leq c^{-1} \exp\{-c(\log L)^{3/2}\}, \quad (4.24)$$

finishing the proof of the lemma. \square

We next present the proof of Proposition 1.2. In light of Lemma 4.4, all we need to prove is (4.22), and for this we will use the renormalization procedure developed in Section 3. One might try to obtain (4.22) by direct application of Theorem 3.3, defining the events A_m in a natural way and then taking r large enough. There is however a serious problem with this approach: for large values of r , the family A_m will no longer be adapted in the sense of Definition 3.1. To circumvent this issue, we define intermediate classes of events that will certainly be adapted, although not necessarily cascading. The details are carried out next.

Proof of Proposition 1.2. Given $\rho > 0$, let $\hat{\rho} := \iota_0^{-1}\rho$ (cf. (3.10)). Fix $h_0 = 1/2$ and define inductively the sequence h_k by $h_{k+1} = h_k(1 - L_k^{-1/16})$. Since $h_0 \geq L_0^{-1/16}$, using (3.1) it follows by induction that $h_k \geq L_k^{-1/16}$ for every $k \geq 0$. Moreover, h_k decreases monotonically to $h_\infty := (2\iota_0)^{-1} > 0$. For $m \in M_k$, let

$$A'_m = \left\{ \text{there exists an } m\text{-crossing } \sigma \text{ such that } \chi_\sigma^{g_{L_k}} < h_k \right\}. \quad (4.25)$$

In the definition of A'_m we have used the local function g_{L_k} , which means that we are looking for particles on even sites at distance at most L_k from the origin. Intuitively speaking, this task will become easier and easier to accomplish as k grows. This is made precise in the following claim: there exists a $c > 0$ such that

$$\mathbb{P}^{\hat{\rho}}(A'_m) \leq c^{-1} \exp\{-cL_k\}, \text{ for every } m \in M_k, k \geq 0. \quad (4.26)$$

Indeed, this follows from a union bound over the points of the box B_m together with a simple large deviations estimate on the sum of independent $\text{Poisson}(\hat{\rho})$ random variables.

By (4.26), there exists a $\hat{k}_o \in \mathbb{N}$ such that

$$\mathbb{P}^{\hat{\rho}}(A'_m) \leq \exp\{-(\log L_k)^{3/2}\}, \text{ for every } m \in M_k, k \geq \hat{k}_o. \quad (4.27)$$

As mentioned above, the family A'_m may not be cascading, however it is clearly adapted. We now define another collection that will indeed be cascading. Let k_o as in the statement of Theorem 3.3 and take $\hat{k} \geq k_o \vee \hat{k}_o$. Then define, for $k \geq \hat{k}$ and $m \in M_k \subset M_{\geq \hat{k}}$,

$$A_m = \left\{ \text{there exists an } m\text{-crossing } \sigma, \text{ such that } \chi_\sigma^{g_{L_{\hat{k}}}} < h_k \right\}. \quad (4.28)$$

Note here that the local function $g_{L_{\hat{k}}}$ is fixed, i.e. it does not depend on the scale k associated with m . This allows us to employ Lemma 3.9 and conclude that

$$\text{the family } (A_m)_{m \in M_{\geq \hat{k}}} \text{ is cascading.} \quad (4.29)$$

Moreover, this collection is adapted and composed of non-increasing events.

In view of (4.27) and (4.29), we have $p_{\hat{k}}(\hat{\rho}) := \sup_{m \in M_{\hat{k}}} \mathbb{P}^{\hat{\rho}}(A_m) \leq \exp\{-(\log L_{\hat{k}})^{3/2}\}$ since $A'_m = A_m$ for $m \in M_{\hat{k}}$. Applying Theorem 3.3 and Proposition 3.10, we obtain, since $\rho = \iota_0 \hat{\rho} \geq \iota_{\hat{k}} \hat{\rho}$ and by translation invariance,

$$\mathbb{P}^\rho \left(\begin{array}{l} \text{there exists a 1-Lipschitz path } \sigma : [0, L] \cap \mathbb{Z} \rightarrow \mathbb{Z} \text{ that is either} \\ \text{a } (0, L)\text{-crossing or a } ((-L, 0), L)\text{-crossing with } \chi_\sigma^{g_{L_{\hat{k}}}} < h_\infty/2 \end{array} \right) \leq c^{-1} e^{-c(\log L)^{3/2}}, \quad (4.30)$$

implying (4.22). Proposition 1.2 then follows from Lemma 4.4. \square

5 Regeneration: proof of Theorem 1.1

In this section, we adapt Section 4 of [16] to our setting using Propositions 4.2 and 4.3. Theorem 1.1 will then follow as a consequence of the resulting renewal structure.

Hereafter, we fix $v_\star \in (0, v_\bullet)$ and take $k_\star \in \mathbb{N}$ and $\epsilon_\star \in (0, 1)$ as in Proposition 4.3. We then define $\rho_\star := \rho(k_\star, \epsilon_\star)$ as given by Proposition 4.2 and Theorem 4.1. We will also fix $\rho \geq \rho_\star$ and write $\mathbb{P} := \mathbb{P}^\rho$ from now on. By Assumption (R) and Proposition 4.3, we may assume that

$$p_\star := p_\bullet(k_\star) = \inf_{k \geq k_\star} \alpha(k, x_\bullet) > 0, \quad (5.1) \quad \text{e:defpstar}$$

see also (2.6).

Let

$$\widehat{v}_\star := v_\star \wedge \frac{1}{2} \quad \text{and} \quad \bar{v} := \frac{1}{3} \widehat{v}_\star. \quad (5.2) \quad \text{e:defbarv}$$

For $y \in \mathbb{R}^d \times \mathbb{R}$, we define the following space-time regions:

$$\angle(y) = y + \angle(0, 0), \quad \angle(0, 0) := \{(x, n) \in \mathbb{Z}^d \times \mathbb{Z}_+ : x \cdot e_1 \geq \bar{v}n, |x| \leq \mathfrak{R}n\}, \quad (5.3)$$

$$\nearrow(y) = y + \nearrow(0, 0), \quad \nearrow(0, 0) := \{(x, n) \in \mathbb{Z}^d \times \mathbb{Z}_- : x \cdot e_1 < \bar{v}n\}, \quad (5.4)$$

where \mathfrak{R} is as in Assumption (S). As in [16], we define the sets of trajectories

$$\begin{aligned} W_y^\angle &= \text{trajectories in } W \text{ that intersect } \angle(y) \text{ but not } \nearrow(y), \\ W_y^\nearrow &= \text{trajectories in } W \text{ that intersect } \nearrow(y) \text{ but not } \angle(y), \\ W_y^\neq &= \text{trajectories in } W \text{ that intersect both } \angle(y) \text{ and } \nearrow(y). \end{aligned} \quad (5.5)$$

Note that W_y^\angle , W_y^\nearrow and W_y^\neq are disjoint, and therefore the sigma-algebras

$$\mathcal{G}_y^I := \sigma(\omega(A) : A \subset W_y^I, A \in \mathcal{W}), \quad I = \angle, \nearrow, \neq, \quad (5.6) \quad \text{e:sigmaalgebra}$$

are jointly independent under \mathbb{P} . Define also the sigma-algebras

$$\begin{aligned} \mathcal{U}_y^\angle &= \sigma(U_z : z \in \angle(y)), \\ \mathcal{U}_y^\nearrow &= \sigma(U_z : z \in \nearrow(y)), \end{aligned} \quad (5.7) \quad \text{e:sigmaalgebra}$$

and set

$$\mathcal{F}_y = \sigma(\mathcal{G}_y^\nearrow, \mathcal{G}_y^\neq, \mathcal{U}_y^\nearrow). \quad (5.8) \quad \text{e:sigmaalgebra}$$

Note that, for two space-time points $y, y' \in \mathbb{Z}^d \times \mathbb{Z}$, if $y \in \nearrow(y')$ then $\mathcal{F}_y \subset \mathcal{F}_{y'}$.

In order to define the regeneration time, we first need to introduce certain *record times* $(R_k)_{k \in \mathbb{N}}$. The definition here will be different from the one in [16]. To this end, set $R_0 := 0$ and, recursively for $k \in \mathbb{N}_0$,

$$R_{k+1} := \inf \{n \geq R_k + 1 : (X_n - X_{R_k}) \cdot e_1 > \bar{v}(n - R_k)\}. \quad (5.9) \quad \text{e:records}$$

Note that $(X_{R_{k+1}} - X_{R_k}) \cdot e_1 > 0$ if and only if $R_{k+1} = R_k + 1$.

Define now a filtration $(\mathcal{F}_k)_{k \geq 0}$ by setting, for $k \geq 0$,

$$\mathcal{F}_k := \left\{ B \in \sigma(\omega, U) : \forall y \in \mathbb{Z}^d \times \mathbb{Z}, \exists B_y \in \mathcal{F}_y \text{ with } B \cap \{Y_{R_k} = y\} = B_y \cap \{Y_{R_k} = y\} \right\}, \quad (5.10)$$

i.e., the sigma-algebra generated by Y_{R_k} , all U_z with $z \in \mathcal{Z}(Y_{R_k})$ and all $\omega(A)$ such that $A \subset W_{Y_{R_k}}^- \cup W_{Y_{R_k}}^+$. In particular, $(Y_i)_{0 \leq i \leq R_k} \in \mathcal{F}_k$.

Finally we define the event

$$A^y = \{Y_i^y \in \mathcal{L}(y) \forall i \in \mathbb{Z}_+\} \quad (5.11)$$

in which the walker started at y remains inside $\mathcal{L}(y)$, the probability measure

$$\mathbb{P}^{\mathcal{L}}(\cdot) = \mathbb{P}(\cdot \mid \omega(W_0^+) = 0, A^0) \quad (5.12)$$

with corresponding expectation operator $\mathbb{E}^{\mathcal{L}}$, the *regeneration record index*

$$\mathcal{I} = \inf \left\{ k \in \mathbb{N} : \omega(W_{Y_{R_k}}^+) = 0, A^{Y_{R_k}} \text{ occurs} \right\} \quad (5.13)$$

and the *regeneration time*

$$\tau = R_{\mathcal{I}}. \quad (5.14)$$

The following two theorems are the analogous of Theorems 4.1–4.2 of [16] in our setting.

Theorem 5.1. *Almost surely on the event $\{\tau < \infty\}$, the process $(Y_{\tau+i} - Y_{\tau})_{i \in \mathbb{Z}_+}$ under either the law $\mathbb{P}(\cdot \mid \tau, (Y_i)_{0 \leq i \leq \tau})$ or $\mathbb{P}^{\mathcal{L}}(\cdot \mid \tau, (Y_i)_{0 \leq i \leq \tau})$ has the same distribution as that of $(Y_i)_{i \in \mathbb{Z}_+}$ under $\mathbb{P}^{\mathcal{L}}(\cdot)$.*

Theorem 5.2. *There exists a constant $c > 0$ such that*

$$\mathbb{E} \left[e^{c(\log \tau)^{3/2}} \right] < \infty \quad (5.15)$$

and the same holds with $\mathbb{E}^{\mathcal{L}}$ replacing \mathbb{E} .

The proof of Theorem 5.1 follows exactly as that of Theorem 4.1 in [16] and thus we omit it here. Theorem 5.2 will be proved in the next section. From them follows the:

Proof of Theorem 1.1. Using Theorems 5.1–5.2, one may follow almost word for word the arguments given in Section 4.3 of [16], with the difference of having now random vectors instead of real-valued random variables. In particular, we obtain the formulas

$$v = \frac{\mathbb{E}^{\mathcal{L}}[X_{\tau}]}{\mathbb{E}^{\mathcal{L}}[\tau]}, \quad (5.16)$$

$$\Sigma_{i,j} = \frac{\mathbb{E}^{\mathcal{L}}[(X_{\tau} - v\tau) \cdot e_i (X_{\tau} - v\tau) \cdot e_j]}{\mathbb{E}^{\mathcal{L}}[\tau]} \quad (5.17)$$

for the velocity v and the covariance matrix Σ , from which the comments made after Theorem 1.1 may be deduced. The fact that $v \cdot e_1 \geq v_{\star}$ follows from Theorem 4.1. \square

5.1 Control of the regeneration time

ss:tailregeneration

In this section, we prove Theorem 5.2 by adapting Section 4.2 of [16] to our setting. The two most important modifications are as follows. First, in order to bypass the requirement of uniform ellipticity, we do not require the random walker to make jumps in a fixed direction independently of the environment but instead only over points containing enough particles. For this, we need to estimate the probability of certain joint occupation events, cf. Lemma 5.3 below. Second, we need a substitute for Lemma 4.5 of [16], which gave a quenched estimate on the backtrack probability of the random walker and was obtained therein using a monotonicity property only available in one dimension. This is the role of Lemma 5.4 below, obtained with the help of Propositions 4.2–4.3.

In our first lemma, we construct a path for the random walk to follow where all the points have a large number of particles. This has a cost that is at most exponential.

Lemma 5.3. *There exists $c_0 \in (0, 1)$ such that, for all $L \in \mathbb{N}$,*

$$\mathbb{P} \left(\omega \left(W_{ix_\bullet, i} \setminus (W_{Lx_\bullet, L}^+ \cup W_0^+) \right) \geq k_\star \forall i = 0, \dots, L-1 \right) \geq c_0^L. \quad (5.18)$$

Proof. We proceed by induction in L . Recall the definition of $S^{0,1}$ in Section 2 and let

$$c_0 := \mathbb{P}(N(0) \geq k_\star) \mathbb{P}(S_n^{0,1} \notin \mathcal{Z}(0) \cup \mathcal{Z}(x_\bullet, 1) \forall n \in \mathbb{Z})^{k_\star} > 0. \quad (5.19)$$

Since $\mathbb{P}(\omega(W_0 \setminus (W_{x_\bullet, 1}^+ \cup W_0^+)) \geq k_\star) \geq c_0$, the claim holds for $L = 1$. Assume that it holds for some $L \geq 1$. Noting that $\mathcal{Z}((i+1)x_\bullet, i+1) \subset \mathcal{Z}(ix_\bullet, i)$, write

$$\begin{aligned} & \mathbb{P} \left(\bigcap_{i=0}^L \left\{ \omega \left(W_{ix_\bullet, i} \setminus (W_{(L+1)x_\bullet, L+1}^+ \cup W_0^+) \right) \geq k_\star \right\} \right) \\ & \geq \mathbb{P} \left(\bigcap_{i=0}^{L-1} \left\{ \omega \left(W_{ix_\bullet, i} \setminus (W_{Lx_\bullet, L}^+ \cup W_0^+) \right) \geq k_\star \right\} \cap \right. \\ & \quad \left. \left\{ \omega \left(W_{Lx_\bullet, L} \setminus (W_{(L+1)x_\bullet, L+1}^+ \cup W_{Lx_\bullet, L}^+) \right) \geq k_\star \right\} \right). \end{aligned} \quad (5.20)$$

Using now that, for any $i = 0, \dots, L-1$, the sets of trajectories $W_{ix_\bullet, i} \setminus (W_{Lx_\bullet, L}^+ \cup W_0^+)$ and $W_{Lx_\bullet, L} \setminus (W_{(L+1)x_\bullet, L+1}^+ \cup W_{Lx_\bullet, L}^+)$ are disjoint, and using also the translation invariance of \mathbb{P} , we see that the right-hand side of (5.20) equals

$$\mathbb{P} \left(\bigcap_{i=0}^{L-1} \left\{ \omega \left(W_{ix_\bullet, i} \setminus (W_{Lx_\bullet, L}^+ \cup W_0^+) \right) \geq k_\star \right\} \right) \mathbb{P} \left(\omega \left(W_0 \setminus (W_{x_\bullet, 1}^+ \cup W_0^+) \right) \geq k_\star \right) \geq c_0^{L+1} \quad (5.21)$$

by the induction hypothesis, concluding the proof. \square

Our next result is an estimate on the conditional backtrack probability of the random walker, which as already mentioned can be seen as a substitute for Lemma 4.5 of [16]. Recall the definition of $\widehat{v}_\star = v_\star \wedge \frac{1}{2}$.

$$\begin{aligned} \mathcal{B}_y^L &:= \bigcap_{i=0}^{L-1} \left\{ \omega \left(W_{y+(ix_\bullet, i)} \setminus (W_{y_{(L)}}^+ \cup W_y^+) \right) \geq k_\star \right\}, \\ \mathcal{C}_y^L &:= \bigcap_{i=0}^{L-1} \left\{ U_{y+(ix_\bullet, i)} \leq p_\star \right\}. \end{aligned} \quad (5.23)$$

Recall (2.6) and the discussion below it. Put $L_\star := \lfloor (1 - \widehat{v}_*)L \rfloor$ and abbreviate $\mathcal{A}_y^{L_\star} := \mathcal{A}_y^{L_\star, \widehat{v}_*, k_\star, \varepsilon_\star}$ (cf. (4.6)). Note that $\mathcal{B}_y^L, \mathcal{C}_y^L$ are measurable in $\mathcal{F}_{y_{(L)}}$ to obtain, \mathbb{P} -a.s.,

$$\begin{aligned} &\mathbb{P}\left(Y_i^y - y \notin \mathcal{H}_{\widehat{v}_*, 0} \forall i \in \mathbb{N} \mid \mathcal{F}_y\right) \\ &\geq \mathbb{P}\left(\mathcal{C}_y^L, \mathcal{B}_y^L, (\mathcal{A}_{y_{(L)}}^{L_\star})^c, Y_n^{y_{(L)}} - y_{(L)} \notin \mathcal{H}_{\widehat{v}_*, L_\star} \forall n \in \mathbb{N} \mid \mathcal{F}_y\right) \\ &= \mathbb{E}\left[\mathbb{1}_{\mathcal{C}_y^L} \mathbb{1}_{\mathcal{B}_y^L} \mathbb{P}\left((\mathcal{A}_{y_{(L)}}^{L_\star})^c, Y_n^{y_{(L)}} - y_{(L)} \notin \mathcal{H}_{\widehat{v}_*, L_\star} \forall n \in \mathbb{N} \mid \mathcal{F}_{y_{(L)}}\right) \mid \mathcal{F}_y\right]. \end{aligned} \quad (5.24)$$

Now, since $\mathcal{A}_{y_{(L)}}^{L_\star}, Y^{y_{(L)}}$ are independent of $\mathcal{U}_{y_{(L)}}^\mathbb{Z}$,

$$\begin{aligned} &\mathbb{P}\left((\mathcal{A}_{y_{(L)}}^{L_\star})^c, Y_n^{y_{(L)}} - y_{(L)} \notin \mathcal{H}_{\widehat{v}_*, L_\star} \forall n \in \mathbb{N} \mid \mathcal{F}_{y_{(L)}}\right) \\ &= \mathbb{P}\left((\mathcal{A}_{y_{(L)}}^{L_\star})^c, Y_n^{y_{(L)}} - y_{(L)} \notin \mathcal{H}_{\widehat{v}_*, L_\star} \forall n \in \mathbb{N} \mid \mathcal{G}_{y_{(L)}}^\prec \vee \mathcal{G}_{y_{(L)}}^+\right) \\ &\geq (1 - c^{-1}e^{-cL_\star}) \mathbb{P}\left((\mathcal{A}_{y_{(L)}}^{L_\star})^c \mid \mathcal{F}_{y_{(L)}}\right) \quad \text{a.s.} \end{aligned} \quad (5.25)$$

by Proposition 4.3 (recall that $\widehat{v}_* \leq v_*$). Substituting this back into (5.24) and using that $\mathcal{B}_y^L, \mathcal{A}_{y_{(L)}}^{L_\star} \in \sigma(\omega), \mathcal{C}_y^L \in \sigma(U)$, we obtain that (5.24) is a.s. larger than

$$\frac{1}{2} p_\star^L \mathbb{P}\left(\mathcal{B}_y^L, (\mathcal{A}_{y_{(L)}}^{L_\star})^c \mid \mathcal{G}_y^\mathbb{Z} \vee \mathcal{G}_y^+\right) \quad (5.26)$$

when L is large enough. Reasoning as for equation (4.16) in [16], we see that, \mathbb{P} -a.s.,

Moreover, since $\mathcal{B}_y^L \cap (\mathcal{A}_{y_{(L)}}^{L_\star})^c$ is non-decreasing (in the sense of Definition 2.1), its conditional probability given $\mathcal{G}_y^\mathbb{Z} \vee \mathcal{G}_y^+$ only increases if $\omega(W_y^+) \neq 0$. Hence, \mathbb{P} -a.s.,

$$\begin{aligned} \mathbb{P}\left(\mathcal{B}_y^L, (\mathcal{A}_{y_{(L)}}^{L_\star})^c \mid \mathcal{G}_y^\mathbb{Z} \vee \mathcal{G}_y^+\right) &\geq \mathbb{P}\left(\mathcal{B}_0^L, (\mathcal{A}_{Lx_\bullet, L}^{L_\star})^c \mid \omega(W_0^+) = 0\right) \\ &= \mathbb{P}\left(\mathcal{B}_0^L, (\widehat{\mathcal{A}}_{Lx_\bullet, L}^{L_\star})^c\right) \end{aligned} \quad (5.27)$$

where

$$\widehat{\mathcal{A}}_{Lx_\bullet, L}^{L_\star} := \left\{ \exists \ell \geq L_\star / (2\mathfrak{R}), \sigma \in \mathfrak{S}^{\widehat{v}_\star, L_\star} : \sum_{i=0}^{\ell-1} \mathbb{1}_{\{\omega(W_{\sigma(i)+Lx_\bullet, i+L} \setminus W_0) \geq k_\star\}} < (1 - \varepsilon_\star)\ell \right\}. \quad (5.28)$$

Since \mathcal{B}_0^L and $(\widehat{\mathcal{A}}_{Lx_\bullet, L}^{L_\star})^c$ are functions of ω only and are both non-decreasing, it follows from Proposition 2.2 and Lemma 5.3 that (5.27) is at least

$$\mathbb{P}(\mathcal{B}_0^L) \mathbb{P}\left((\widehat{\mathcal{A}}_{Lx_\bullet, L}^{L_\star})^c\right) \geq c_0^L \mathbb{P}\left((\mathcal{A}_{Lx_\bullet, L}^{L_\star})^c \mid \omega(W_0^+) = 0\right). \quad (5.29)$$

Now note that, by Proposition 4.2,

$$\mathbb{P}\left(\mathcal{A}_{Lx_\bullet, L}^{L_\star} \mid \omega(W_0^+) = 0\right) \leq \frac{\mathbb{P}\left(\mathcal{A}_{Lx_\bullet, L}^{L_\star}\right)}{\mathbb{P}\left(\omega(W_0^+) = 0\right)} \leq c^{-1} e^{-c(\log L)^{3/2}} \quad (5.30)$$

for some constant $c > 0$. For fixed L large enough, (5.30) is smaller than $1/2$, and thus (5.22) follows from (5.24)–(5.30) with $c_1 := \frac{1}{4}(c_0 p_\star)^L$. \square

We proceed with the adaptation of Section 4.2 of [16]. As in equation (4.21) therein, we define the *influence field*

$$h(y) := \inf \left\{ l \in \mathbb{Z}_+ : \omega(W_y^+ \cap W_{y+(lx_\bullet, l)}^+) = 0 \right\}, \quad y \in \mathbb{Z}^d \times \mathbb{Z}. \quad (5.31)$$

Using $x_\bullet \cdot e_1 \geq 1$ and similar arguments as for Lemma 4.3 in [16], we obtain:

Lemma 5.5. *There exist constants $c_2, c_3 > 0$ such that, for all $y \in \mathbb{Z}^d \times \mathbb{Z}$,*

$$\mathbb{P}(h(y) > l) \leq c_2 e^{-c_3 l}, \quad l \in \mathbb{Z}_+. \quad (5.32)$$

Let

$$\widehat{p} := c_0 p_\star > 0 \quad (5.33)$$

where p_\star is as in (5.1) and c_0 as in (5.18). Analogously to equations (4.28)–(4.29) in [16], we set, for $T > 1$,

$$\delta := (-4 \log(\widehat{p}))^{-1}, \quad \epsilon := \frac{1}{4(d+1)}(c_3 \delta \wedge 1), \quad T' = \lfloor T^\epsilon \rfloor, \quad T'' = \lfloor \delta \log(T) \rfloor, \quad (5.34)$$

and we define the *local influence field* at a space-time point $y \in \mathbb{Z}^d \times \mathbb{Z}$ to be:

$$h^T(y) := \inf \left\{ l \in \mathbb{Z}_+ : \omega(W_y^+ \cap W_{y+(lx_\bullet, l)}^+ \cap W_{y - (\lfloor (\bar{v}/\mathfrak{R})T' \rfloor x_\bullet, \lfloor (\bar{v}/\mathfrak{R})T' \rfloor)})^\leq = 0 \right\}. \quad (5.35)$$

Note that our definition is slightly different from that of [16]. As in Lemma 4.4 therein, we obtain:

Lemma 5.6. *For all $T > 1$ and all $y \in \mathbb{Z}^d \times \mathbb{Z}$,*

$$\mathbb{P}(h^T(y) > l \mid \mathcal{F}_{y - (\lfloor (\bar{v}/\mathfrak{R})T' \rfloor x_\bullet, \lfloor (\bar{v}/\mathfrak{R})T' \rfloor)}) \leq c_2 e^{-c_3 l} \quad \forall l \in \mathbb{Z}_+ \quad \mathbb{P}\text{-a.s.}, \quad (5.36)$$

where c_2, c_3 are the same constants as in Lemma 5.5.

Proof. Note that $h^T(y)$ is independent of $\mathcal{F}_{y - (\lfloor (\bar{v}/\mathfrak{R})T' \rfloor x_\bullet, \lfloor (\bar{v}/\mathfrak{R})T' \rfloor)}$ and $h^T(y) \leq h(y)$. \square

As in [16], an important definition is that of a *good record time* (g.r.t.): for $k \in \mathbb{N}$, we call R_k a g.r.t. if

$$h^T(Y_{R_k}) \leq T'', \quad (5.37) \quad \text{e:good'record1}$$

$$\omega \left(W_{Y_{R_k} + (lx_\bullet, l)} \setminus (W_{Y_{R_k}}^+ \cup W_{Y_{R_k} + (T''x_\bullet, T'')}) \right) \geq k_\star \quad \forall l = 0, \dots, T'' - 1, \quad (5.38) \quad \text{e:good'record2}$$

and $U_{Y_{R_k} + (lx_\bullet, l)} \leq p_\star$

$$\omega(W_{Y_{R_k} + (T''x_\bullet, T'')}^+ \cap W_{Y_{R_k}}^\angle) = 0, \quad (5.39) \quad \text{e:good'record3}$$

$$Y_n \in \angle(Y_{R_k + T''}) \text{ for all } n \in \{R_k + T'', \dots, R_k + T''\}. \quad (5.40) \quad \text{e:good'record4}$$

Note that, when (5.38) occurs, $Y_{R_k} + (T''x_\bullet, T'') = Y_{R_k + T''}$.

With the above definitions and results in place, only minor modifications are required to adapt the rest of Section 4.2 of [16] to our setting. For completeness, we provide below all the details.

The following proposition is the main step in the proof of Theorem 5.2.

Proposition 5.7. *There exists a constant $c_4 > 0$ such that, for all $T > 1$ large enough,*

$$\mathbb{P}[R_k \text{ is not a g.r.t. for all } 1 \leq k \leq T] \leq e^{-c_4 T^{1/2}}. \quad (5.41)$$

Proof. First we claim that there exists a $c > 0$ such that, for any $k > T'$,

$$\mathbb{P}[R_k \text{ is a g.r.t.} \mid \mathcal{F}_{k-T'}] \geq c T^{\delta \log(\hat{p})} \text{ a.s.} \quad (5.42) \quad \text{e:saw'pemba}$$

To prove (5.42), we will find $c > 0$ such that

$$\mathbb{P}[(5.37) \mid \mathcal{F}_{k-T'}] \geq c \quad \text{a.s.}, \quad (5.43) \quad \text{e:good'cond1}$$

$$\mathbb{P}[(5.38) \mid \mathcal{F}_{k-T'}] \geq T^{\delta \log(\hat{p})} \quad \text{a.s.}, \quad (5.44) \quad \text{e:good'cond2}$$

$$\mathbb{P}[(5.39) \mid \mathcal{F}_{k-T'}] \geq c \quad \text{a.s.}, \quad (5.45) \quad \text{e:good'cond3}$$

$$\mathbb{P}[(5.40) \mid \mathcal{F}_{k-T'}] \geq c \quad \text{a.s.} \quad (5.46) \quad \text{e:good'cond4}$$

Proof of (5.43): For $B \in \mathcal{F}_{k-T'}$, write

$$\mathbb{P}(h^T(Y_{R_k}) > T'', B) = \sum_{y_1, y_2 \in \mathbb{Z}^d \times \mathbb{Z}} \mathbb{P}(h^T(y_2) > T'', Y_{R_k} = y_2, Y_{R_k - T'} = y_1, B_{y_1}). \quad (5.47) \quad \text{e:manygrts1}$$

Note that, if $Y_n^{Y_{R_k - T'}} - Y_{R_k - T'} \notin \mathcal{H}_{\hat{v}_\star, 0}$ for all $n \in \mathbb{N}$, then $R_k \leq R_{k-T'} + CT'$ for some constant $C \geq \mathfrak{R} \geq 1$, and moreover $Y_{R_k - T'} \in \mathcal{Z}(Y_{R_k} - (\lfloor (\bar{v}/\mathfrak{R})T' \rfloor x_\bullet, \lfloor (\bar{v}/\mathfrak{R})T' \rfloor))$. Thus we may upper-bound (5.47) by

$$\begin{aligned} & \sum_{y_1 \in \mathbb{Z}^d \times \mathbb{Z}} \sum_{\substack{y_2 \in \mathbb{Z}^d \times \mathbb{Z}: |y_2 - y_1|_\infty \leq CT' \\ y_1 \in \mathcal{Z}(Y_{R_k} - (\lfloor (\bar{v}/\mathfrak{R})T' \rfloor x_\bullet, \lfloor (\bar{v}/\mathfrak{R})T' \rfloor))}} \mathbb{P}(h^T(y_2) > T'', Y_{R_k - T'} = y_1, B_{y_1}) \\ & + \sum_{y_1 \in \mathbb{Z}^d \times \mathbb{Z}} \mathbb{P}(\exists n \in \mathbb{N}: Y_n^{y_1} - y_1 \in \mathcal{H}_{\hat{v}_\star, 0}, Y_{R_k - T'} = y_1, B_{y_1}) \\ & \leq \left\{ \hat{C}(T')^{d+1} c_2 e^{-c_3 T''} + 1 - c_1 \right\} \mathbb{P}(B) \leq \left\{ \hat{C} c_2 e^{c_3 T'' - \frac{3}{4} \delta c_3} + 1 - c_1 \right\} \mathbb{P}(B) \end{aligned} \quad (5.48) \quad \text{e:manygrts2}$$

for some constant $\hat{C} > 0$, where for the first inequality we use Lemmas 5.4 and 5.6 (see also the comment after (5.8)), and for the second we use the definition of ϵ . Thus, for T large enough, (5.43) is satisfied with $c = c_1/2$.

Proof of (5.44): Let \mathcal{B}_y^L as in (5.23) and note that $\mathcal{B}_y^{T''}$, $(U_{y+(lx_\bullet, l)})_{l \in \mathbb{Z}_+}$ and \mathcal{F}_y are jointly independent. For $B \in \mathcal{F}_k$, write

$$\begin{aligned} \mathbb{P}\left(\mathcal{B}_{Y_{R_k}}^{T''}, U_{Y_{R_k}+(lx_\bullet, l)} \leq p_\star, B\right) &= \sum_{y \in \mathbb{Z}^d \times \mathbb{Z}} \mathbb{P}\left(\mathcal{B}_y^{T''}, U_{y+(lx_\bullet, l)} \leq p_\star, Y_{R_k} = y, B_y\right) \\ &= p_\star^{T''} \mathbb{P}\left(\mathcal{B}_0^{T''}\right) \mathbb{P}(B) \end{aligned} \quad (5.49)$$

to conclude that (5.38) is independent of \mathcal{F}_k . Then (5.44) follows by Lemma 5.3 and (5.34).

Proof of (5.45): We may ignore the conditioning on (5.38) since this event is independent of (5.39) and \mathcal{F}_k . For $B \in \mathcal{F}_k$, write

$$\begin{aligned} \mathbb{P}\left(\omega(W_{Y_{R_k}}^\angle \cap W_{Y_{R_k}+(T'', T'')}^+) = 0, B\right) &= \sum_{y \in \mathbb{Z}^2} \mathbb{P}\left(\omega(W_y^\angle \cap W_{y+(T'', T'')}^+) = 0, Y_{R_k} = y, B_y\right) \\ &= \sum_{y \in \mathbb{Z}^2} \mathbb{P}\left(\omega(W_y^\angle \cap W_{y+(T'', T'')}^+) = 0\right) \mathbb{P}(Y_{R_k} = y, B_y) \geq \mathbb{P}\left(\omega(W_0^+) = 0\right) \mathbb{P}(B), \end{aligned} \quad (5.50)$$

where the second equality uses the independence between \mathcal{G}_y^\angle and \mathcal{F}_y .

Proof of (5.46): For $B \in \mathcal{F}_{k+T''}$, write

$$\begin{aligned} &\mathbb{P}\left(Y_n \in \angle(Y_{R_{k+T''}}) \forall R_{k+T''} \leq n \leq R_{k+T'}, B\right) \\ &\geq \sum_{y \in \mathbb{Z}^2} \mathbb{P}\left(Y_n^y \notin \mathcal{H}_{\hat{v}_\star, 0} \forall n \in \mathbb{N}, Y_{R_{k+T''}} = y, B_y\right) \\ &\geq c_1 \mathbb{P}(B) \end{aligned} \quad (5.51)$$

by Lemma 5.4.

Thus, (5.42) is verified. Since $\{R_k \text{ is a g.r.t.}\} \in \mathcal{F}_{k+T'}$, we obtain, for T large enough,

$$\begin{aligned} \mathbb{P}(R_k \text{ is not a g.r.t. for any } k \leq T) &\leq \mathbb{P}(R_{(2k+1)T'} \text{ is not a g.r.t. for any } k \leq T/3T') \\ &\leq \exp\left\{-\frac{c}{4} \frac{T^{1+\delta \log(\hat{p})}}{T'}\right\} \\ &\leq \exp\left\{-\frac{c}{4} T^{\frac{1}{2}}\right\} \end{aligned} \quad (5.52)$$

by our choice of ϵ and δ . \square

The proof of Theorem 5.2 can then be finished as in [16].

Proof of Theorem 5.2. Since $\mathbb{P}^\angle(\cdot) = \mathbb{P}(\cdot | A^0, \omega(W_0^+) = 0)$ and $\mathbb{P}(A^0, \omega(W_0^+) = 0) > 0$, it is enough to prove the statement under \mathbb{P} . To that end, let

$$\begin{aligned} E_1 &= \{\exists y \in [-2\mathfrak{R}T, 2\mathfrak{R}T]^d \times [-T, T] \cap \mathbb{Z}^d \times \mathbb{Z} : h(y) \geq \lfloor (\bar{v}/\mathfrak{R})T' \rfloor\}, \\ E_2 &= \{\exists y \in [-2\mathfrak{R}T, 2\mathfrak{R}T]^d \times [-T, T] \cap \mathbb{Z}^d \times \mathbb{Z} : Y^y \text{ touches } y + \mathcal{H}_{\hat{v}_\star, \lfloor \bar{v}T' \rfloor}\}. \end{aligned} \quad (5.53)$$

Then, by Lemma 5.5, (4.2) and a union bound, there exists a $c > 0$ such that

$$\mathbb{P}(E_1 \cup E_2) \leq c^{-1} e^{-c(\log T)^{3/2}} \quad \forall T > 1. \quad (5.54) \quad \text{prtailreg2}$$

Next we argue that, for all T large enough, if R_k is a good record time with $k \leq (\bar{v}/\mathfrak{R})T$ and both E_1 and E_2 do not occur then $\tau \leq R_{k+T''} \leq T$. Indeed, if $T'' \leq \bar{v}T/\mathfrak{R}$, then on E_2^c we have $R_{\lfloor (\bar{v}/\mathfrak{R})T \rfloor + T''} \leq T$ since otherwise Y touches $\mathcal{H}_{\hat{v}_x, \lfloor \bar{v}T' \rfloor}$. Thus we only need to verify that

$$\omega(W_{Y_{R_{k+T''}}}^+) = 0 \quad (5.55) \quad \text{prtailreg3}$$

and that

$$A^{Y_{R_{k+T''}}} \text{ occurs} \quad (5.56) \quad \text{prtailreg4}$$

under the conditions stated.

To verify (5.56), note that, on E_2^c , we have $Y_{R_{k+T''}} \in [-2\mathfrak{R}T, 2\mathfrak{R}T]^d \times [0, T] \cap \mathbb{Z}^d \times \mathbb{Z}$ and, moreover, if $T'' < \frac{1}{2}T'$ then

$$Y_{R_{k+T''}+l} \in \angle(Y_{R_{k+T''}}) \quad \forall l \in \mathbb{Z}_+, \quad (5.57) \quad \text{prtailreg4.5}$$

which together with (5.40) implies (5.56).

To verify (5.55), first note that, by (5.37) and (5.39), it is enough to check that

$$\omega(W_{Y_{R_k}}^+ \cap W_{Y_{R_k} - (\lfloor (\bar{v}/\mathfrak{R})T' \rfloor x_\bullet, \lfloor (\bar{v}/\mathfrak{R})T' \rfloor)}) = 0 \quad (5.58) \quad \text{prtailreg5}$$

on $E_1^c \cap E_2^c$. Noting that, on E_2^c , $Y_{R_k} - (\lfloor (\bar{v}/\mathfrak{R})T' \rfloor x_\bullet, \lfloor (\bar{v}/\mathfrak{R})T' \rfloor) \in [-2\mathfrak{R}T, 2\mathfrak{R}T]^d \times [0, T] \cap \mathbb{Z}^d \times \mathbb{Z}$, (5.58) follows from the definitions of E_1 and of h .

In conclusion, for T large enough we have

$$\begin{aligned} \mathbb{P}(\tau > T) &\leq \mathbb{P}(E_1 \cup E_2) + \mathbb{P}(R_k \text{ is not a g.r.t. } \forall k \leq \bar{v}T) \\ &\leq c^{-1} e^{-c(\log T)^{3/2}} + e^{-c_4(\bar{v}T)^{1/2}} \end{aligned} \quad (5.59) \quad \text{prtailreg8}$$

from which (5.15) follows. \square

A Decoupling of space-time boxes

s:decouple

The aim of this section is to prove Theorem 3.4. The proof is very similar to the proof of Theorem C.1 in [16]; only the most important changes are described here. In the following subsections, we will concentrate on intermediate results required for item (b) of Theorem 3.4, i.e., the case where f_1, f_2 are both non-decreasing. The non-increasing case will be discussed in the proof of Theorem 3.4 itself at the end of this Appendix.

The constants in this section will be all *independent* of ρ ; this is crucial for the perturbative arguments of Section 3.

A.1 Soft local times

ss:SLT

We start with a coupling result. For a Polish space Σ and a Radon measure μ on Σ , let m denote the Poisson point process on $\Sigma \times \mathbb{R}_+$ with intensity measure $\mu \otimes dv$, where dv is the Lebesgue measure on \mathbb{R}_+ . We write $m = \sum_{i \in \mathbb{N}} \delta_{z_i, v_i}$ with $(z_i, v_i) \in \Sigma \times \mathbb{R}_+$.

Fix a sequence of independent Σ -valued random elements Z_j , $j \in \mathbb{N}$. Assume that the law of Z_j is absolutely continuous with respect to μ with density g_j . As in Appendix A of [16], we define the *soft local times* $G_j : \Sigma \rightarrow [0, \infty)$, $j \in \mathbb{N}$ by setting

$$\begin{aligned} \xi_1 &= \inf \{t \geq 0 : tg_1(z_i) \geq v_i \text{ for at least one } i \in \mathbb{N}\}, \\ G_1(z) &= \xi_1 g_1(z), \\ &\vdots \\ \xi_k &= \inf \{t \geq 0 : tg_j(z_i) + G_{k-1}(z_i) \geq v_i \text{ for at least } k \text{ indices } i \in \mathbb{N}\}, \\ G_k(z) &= \xi_1 g_1(z) + \cdots + \xi_k g_k(z) \end{aligned} \tag{A.1}$$

e:defSLT

This construction can be used to prove the following.

lcouplessystem

Lemma A.1. *The random variables $(\xi_j)_{j \in \mathbb{N}}$ in (A.1) are i.i.d. $\text{Exp}(1)$. Furthermore, there exists a coupling \mathbb{Q} of $(Z_j)_{j \in \mathbb{N}}$ and m such that, for any $J \in \mathbb{N}$, $\rho > 0$,*

$$\mathbb{Q} \left[\mathbb{1}_{H'} \sum_{j \leq J} \delta_{Z_j} \leq \mathbb{1}_{H'} \sum_{i: v_i < \rho} \delta_{z_i} \right] \geq \mathbb{Q} \left[\sup_{z \in H'} G_J(z) \leq \rho \right] \tag{A.2}$$

Qineq

for all compact $H' \subset \Sigma$.

Proof. Follows from Proposition A.2 in [16] (compare to Corollary A.3 therein). \square

A.2 Simple random walks

ss:SRW

As in [16], we will need some basic facts about the heat kernel of random walks on \mathbb{Z}^d . Let $p_n(x, x') = P_x(S^{x,1} = x')$, $x, x' \in \mathbb{Z}^d$, with $P_z, S^{z,i}$ as defined in Section 2. Hereafter we will assume that $S^{1,0}$ is lazy; non-lazy $S^{1,0}$ are bipartite, and the argument below may adapted as outlined in Remark C.4 of [16]. Lazy $S^{1,0}$ are aperiodic in the sense of [25], and thus there exist constants $C, c > 0$ such that the following hold for all $n \in \mathbb{N}$:

$$\sup_{x \in \mathbb{Z}^d} p_n(0, x) \leq \frac{C}{n^{d/2}}, \tag{A.3}$$

e:localct

$$|p_n(0, x) - p_n(0, x')| \leq \frac{C|x - x'|}{n^{(d+1)/2}} \quad \forall x, x' \in \mathbb{Z}^d, \tag{A.4}$$

e:SRW1

$$P_0(|S_n| > \sqrt{n} \log n) \leq C e^{-c \log^2 n}. \tag{A.5}$$

e:SRW2

For (A.3), see e.g. Lawler and Limic [25, Theorem 2.4.4]. To get (A.4), use [25, Theorem 2.3.5 and equation (2.2)], while (A.5) follows by an application of e.g. Azuma's inequality.

The above inequalities will be used to prove Lemma A.3 below, regarding the integration of the heat kernel over a sparse cloud of sample points. In order to state it, we need the following definitions.

d:balanced

Definition A.2. (a) We say that a collection of intervals $\{C_i\}_{i \in I}$ is an L -paving if

$$|C_i| = L^d \quad \forall i \in I, \quad \bigcup_{i \in I} C_i = \mathbb{Z}^d \quad \text{and} \quad C_i \cap C_j = \emptyset \quad \forall i \neq j \in I. \quad (\text{A.6})$$

e:paving

(b) For $\rho \in (0, \infty)$, we say that a collection of points $(x_j)_{j \in J} \subset \mathbb{Z}^d$ is ρ -sparse with respect to the L -paving $\{C_i\}_{i \in I}$ when

$$\#\{j : x_j \in C_i\} \leq \rho L^d \quad \forall i \in I. \quad (\text{A.7})$$

e:rhodense

In the above definition, by interval, we mean a subset of \mathbb{Z}^d that is a Cartesian products of intervals of \mathbb{Z} .

The next lemma provides an estimate of the sum of the heat kernel over a sparse collection $(x_j)_{j \in J}$.

i:integration

Lemma A.3. There exists $c > 0$ such that the following holds. Let $\{C_i\}_{i \in I}$ be an L -paving and $(x_j)_{j \in J}$ be ρ -sparse collection with respect to $\{C_i\}_{i \in I}$. Then, for all $n \geq L$,

$$\sum_{j \in J} p_n(0, x_j) \leq \rho \left\{ 1 + \frac{cL(\log n)^d}{\sqrt{n}} \right\}. \quad (\text{A.8})$$

Proof. For each $i \in I$, choose $z_i \in C_i$ such that

$$p_n(0, z_i) = \max_{x \in C_i} p_n(0, x). \quad (\text{A.9})$$

Then we have

$$\begin{aligned} \sum_{j \in J} p_n(0, x_j) &= \sum_{i \in I} \sum_{j : x_j \in C_i} p_n(0, x_j) \leq \sum_{i \in I} \rho L^d p_n(0, z_i) \\ &\leq \rho \sum_{i \in I} \sum_{x \in C_i} |p_n(0, x) - p_n(0, z_i)| + \rho. \end{aligned} \quad (\text{A.10})$$

e:int1

On the other hand, by (A.4)–(A.5) we have (since $p_n(0, z_i) \leq P_0(S^{0,1} \in C_i)$)

$$\begin{aligned} \sum_{i \in I} \sum_{x \in C_i} |p_n(0, x) - p_n(0, z_i)| &\stackrel{n \geq L}{\leq} (1 + n^d) P_0(|S_n| > \sqrt{n} \log n) + \sum_{|x| \leq \sqrt{n} \log n} \frac{cL}{n^{(d+1)/2}} \\ &\leq cL(\log n)^d / \sqrt{n} \end{aligned} \quad (\text{A.11})$$

e:int2

and the claim follows by combining (A.10) and (A.11). \square

A.3 Coupling of trajectories

ss:couptraj

Given a sequence of points $(x_j)_{j \in J}$ in \mathbb{Z}^d , let $(Z_n^j)_{n \in \mathbb{Z}_+, j \in J}$ be a sequence of independent simple random walks on \mathbb{Z}^d starting at x_j , and let $\bigotimes_{j \in J} P_{x_j}$ denote their joint law. The next lemma, analogous to Lemma B.3 in [16], provides a coupling of $(Z_n^j)_{j \in J}$ with a product Poisson measure on \mathbb{Z}^d .

l:couple

Lemma A.4. *There exists a constant $c \geq 1$ such that the following holds. Let $(x_j)_{j \in J} \subset \mathbb{Z}^d$ be ρ -sparse with respect to the L -paving $\{C_i\}_{i \in I}$. Then for any $\rho' \geq \rho$ there exists a coupling \mathbb{Q} of $\bigotimes_{j \in J} P_{x_j}$ and the law of a Poisson point process $\sum_{j' \in J'} \delta_{Y_{j'}}$ on \mathbb{Z}^d with intensity ρ' such that*

$$\mathbb{Q} \left[\mathbb{1}_{H'} \sum_{j \in J} \delta_{Z_n^j} \leq \mathbb{1}_{H'} \sum_{j' \in J'} \delta_{Y_{j'}} \right] \geq 1 - |H'| \exp \left\{ -(\rho' - \rho)L + \left(\frac{c\rho L^2 (\log n)^d}{\sqrt{n}} \right) \right\} \quad (\text{A.12})$$

for all finite $H' \subset \mathbb{Z}^d$ and all $n \geq cL^2$.

Proof. By Lemma A.1, there exists a coupling \mathbb{Q} such that

$$\mathbb{Q} \left[\mathbb{1}_{H'} \sum_{j \in J} \delta_{Z_n^j} \leq \mathbb{1}_{H'} \sum_{j' \in J'} \delta_{Y_{j'}} \right] \geq \mathbb{Q}[G_J(z) \leq \rho' \forall z \in H'], \quad (\text{A.13})$$

e:coupleGG

where $G_J(z) = \sum_{j \in J} \xi_j p_n(x_j, z)$ with $(\xi_j)_j$ i.i.d. $\text{Exp}(1)$ random variables. Write

$$\begin{aligned} \mathbb{Q}[\exists z \in H' : G_J(z) > \rho'] &\leq |H'| \sup_{z \in H'} \mathbb{Q}[G_J(z) > \rho'] \\ &\leq |H'| e^{-\rho' L} \sup_{z \in H'} E^{\mathbb{Q}}[\exp\{LG_J(z)\}]. \end{aligned} \quad (\text{A.14})$$

e:QGJz

If $n \geq cL^2$ with large enough $c \geq 1$, then, by (A.3),

$$\sup_{x \in \mathbb{Z}} Lp_n(0, x) \leq \frac{1}{2}. \quad (\text{A.15})$$

e:localit2

Thus we may write, for any $z \in \mathbb{Z}$,

$$E^{\mathbb{Q}}[\exp\{LG_J(z)\}] = \prod_{j \in J} E^{\mathbb{Q}}[\exp\{\xi_j Lp_n(x_j, z)\}] = \prod_{j \in J} (1 - Lp_n(x_j, z))^{-1}. \quad (\text{A.16})$$

Using (A.15) and $-\log(1-x) \leq x + x^2$ for all $x \in [0, 1/2]$, we obtain

$$\begin{aligned} \prod_{j \in J} (1 - Lp_n(z, x_j))^{-1} &\leq \prod_{j \in J} \exp\{Lp_n(z, x_j)(1 + Lp_n(z, x_j))\} \\ &\leq \exp \left\{ \sum_{j \in J} Lp_n(z, x_j) (1 + \sup_{x \in \mathbb{Z}} Lp_n(0, x)) \right\} \\ &\leq \exp \left\{ \rho L \left(1 + \frac{cL(\log n)^d}{\sqrt{n}} \right) \left(1 + \frac{cL}{\sqrt{n}} \right) \right\} \\ &\leq \exp \left\{ \rho L \left(1 + \frac{c'L(\log n)^d}{\sqrt{n}} \right) \right\}. \end{aligned} \quad (\text{A.17})$$

where the last two inequalities are justified using $n \geq cL^2 \geq L$, Lemma A.3 and (A.3). Inserting this estimate into (A.14), we get the claim. \square

A.4 Proof of Theorem 3.4

We can now finish the:

Proof of Theorem 3.4. The proof of item (a) can be obtained by adapting Appendixes B–C of [16] to higher dimensions as follows. First of all, (B.1)–(B.3) therein should be substituted by their d -dimensional counterparts (A.3)–(A.5) above. Definition B.1 therein should be substituted by the ρ -dense analogue of Definition A.2 above, i.e., changing “ \leq ” to “ \geq ” in (A.7). One may then follow the arguments given in [16] to re-obtain Lemmas B.2–B.3 therein with the following differences: in both (B.6) and (B.10) therein, $\log n$ should be substituted by $(\log n)^d$ (analogously to Lemmas A.3–A.4 above). The proof of Theorem 3.4(a) then follows from these results exactly as in the proof of Theorem C.1 in [16]. The proof of Theorem 3.4(b) is completely analogous, following from Lemma A.4 above as Theorem C.1 in [16] follows from Lemma B.3 therein. \square
