# ENERGY SCATTERING FOR A CLASS OF THE DEFOCUSING INHOMOGENEOUS NONLINEAR SCHRÖDINGER EQUATION

AbStract. In this paper, we consider a class of the defocusing inhomogeneous nonlinear Schrödinger equation

$$
i \partial_{t} u+\Delta u-|x|^{-b}|u|^{\alpha} u=0, \quad u(0)=u_{0} \in H^{1}
$$

with $b, \alpha>0$. We firstly study the decaying property of global solutions for the equation when $0<\alpha<\alpha^{\star}$ where $\alpha^{\star}=\frac{4-2 b}{d-2}$ for $d \geq 3$. The proof makes use of an argument of Visciglia in [22]. We next use this decay to show the energy scattering for the equation in the case $\alpha_{\star}<\alpha<\alpha^{\star}$, where $\alpha_{\star}=\frac{4-2 b}{d}$.

## 1. Introduction

Consider the Cauchy problem for the inhomogeneous nonlinear Schrödinger equation

$$
\left\{\begin{align*}
i \partial_{t} u+\Delta u+\mu|x|^{-b}|u|^{\alpha} u & =0  \tag{INLS}\\
u(0) & =u_{0},
\end{align*}\right.
$$

where $u: \mathbb{R} \times \mathbb{R}^{d} \rightarrow \mathbb{C}, u_{0}: \mathbb{R}^{d} \rightarrow \mathbb{C}, \mu= \pm 1$ and $\alpha, b>0$. The parameters $\mu=1$ and $\mu=-1$ correspond to the focusing and defocusing cases respectively. The case $b=0$ is the well-known nonlinear Schrödinger equation which has been studied extensively over the last three decades. The inhomogeneous nonlinear Schrödinger equation arises naturally in nonlinear optics for the propagation of laser beams, and it is of a form

$$
\begin{equation*}
i \partial_{t} u+\Delta u+K(x)|u|^{\alpha} u=0 \tag{1.1}
\end{equation*}
$$

The (INLS) is a particular case of (1.1) with $K(x)=|x|^{-b}$. The equation (1.1) has been attracted a lot of interest in a past several years. Bergé in [1] studied formally the stability condition for soliton solutions of (1.1). Towers-Malomed in [21] observed by means of variational approximation and direct simulations that a certain type of time-dependent nonlinear medium gives rise to completely stabe beams. Merle in [16] and Raphaël-Szeftel in [18] studied (1.1) for $k_{1}<K(x)<k_{2}$ with $k_{1}, k_{2}>0$. Fibich-Wang in [10] investigated (1.1) with $K(x):=K(\epsilon|x|)$ where $\epsilon>0$ is small and $K \in C^{4}\left(\mathbb{R}^{d}\right) \cap L^{\infty}\left(\mathbb{R}^{d}\right)$. The case $K(x)=|x|^{b}$ with $b>0$ is studied by many authors (see e.g. [3, 15, 23] and references therein).

In order to review known results for the (INLS), we recall some facts for this equation. We firstly note that the (INLS) is invariant under the scaling,

$$
u_{\lambda}(t, x):=\lambda^{\frac{2-b}{\alpha}} u\left(\lambda^{2} t, \lambda x\right), \quad \lambda>0
$$

An easy computation shows

$$
\left\|u_{\lambda}(0)\right\|_{\dot{H}^{\gamma}\left(\mathbb{R}^{d}\right)}=\lambda^{\gamma+\frac{2-b}{\alpha}-\frac{d}{2}}\left\|u_{0}\right\|_{\dot{H}^{\gamma}\left(\mathbb{R}^{d}\right)}
$$

[^0]Thus, the critical Sobolev exponent is given by

$$
\begin{equation*}
\gamma_{\mathrm{c}}:=\frac{d}{2}-\frac{2-b}{\alpha} . \tag{1.2}
\end{equation*}
$$

Moreover, the (INLS) has the following conserved quantities:

$$
\begin{align*}
M(u(t)) & :=\int_{\mathbb{R}^{d}}|u(t, x)|^{2} d x=M\left(u_{0}\right)  \tag{1.3}\\
E(u(t)) & :=\int_{\mathbb{R}^{d}} \frac{1}{2}|\nabla u(t, x)|^{2}-\frac{\mu}{\alpha+2}|x|^{-b}|u(t, x)|^{\alpha+2} d x=E\left(u_{0}\right) \tag{1.4}
\end{align*}
$$

The well-posedness for the (INLS) was firstly studied by Genoud-Stuart in [11, Appendix] by using the argument of Cazenave [2] which does not use Strichartz estimates. More precisely, the authors showed that the focusing (INLS) with $0<b<\min \{2, d\}$ is well posed in $H^{1}\left(\mathbb{R}^{d}\right)$ :

- locally if $0<\alpha<\alpha^{\star}$,
- globally for any initial data if $0<\alpha<\alpha_{\star}$,
- globally for small initial data if $\alpha_{\star} \leq \alpha<\alpha^{\star}$,
where $\alpha_{\star}$ and $\alpha^{\star}$ are defined by

$$
\alpha_{\star}:=\frac{4-2 b}{d}, \quad \alpha^{\star}:=\left\{\begin{array}{cl}
\frac{4-2 b}{d-2} & \text { if } d \geq 3  \tag{1.5}\\
\infty & \text { if } d=1,2 .
\end{array}\right.
$$

In the case $\alpha=\alpha_{\star}$ ( $L^{2}$-critical), Genoud in [12] showed that the focusing (INLS) with $0<b<$ $\min \{2, d\}$ is globally well-posed in $H^{1}\left(\mathbb{R}^{d}\right)$ assuming $u_{0} \in H^{1}\left(\mathbb{R}^{d}\right)$ and

$$
\left\|u_{0}\right\|_{L^{2}\left(\mathbb{R}^{d}\right)}<\|Q\|_{L^{2}\left(\mathbb{R}^{d}\right)}
$$

where $Q$ is the unique nonnegative, radially symmetric, decreasing solution of the ground state equation

$$
\Delta Q-Q+|x|^{-b}|Q|^{\frac{4-2 b}{d}} Q=0
$$

Also, Combet-Genoud in [5] established the classification of minimal mass blow-up solutions for the focusing $L^{2}$-critical (INLS).

In the case $\alpha_{\star}<\alpha<\alpha^{\star}$, Farah in [7] showed that the focusing (INLS) with $0<b<\min \{2, d\}$ is globally well-posedness in $H^{1}\left(\mathbb{R}^{d}\right), d \geq 3$ assuming $u_{0} \in H^{1}\left(\mathbb{R}^{d}\right)$ and

$$
\begin{gather*}
E\left(u_{0}\right)^{\gamma_{\mathrm{c}}} M\left(u_{0}\right)^{1-\gamma_{\mathrm{c}}}<E(Q)^{\gamma_{\mathrm{c}}} M(Q)^{1-\gamma_{\mathrm{c}}}  \tag{1.6}\\
\left\|\nabla u_{0}\right\|_{L^{2}\left(\mathbb{R}^{d}\right)}^{\gamma_{\mathrm{c}}}\left\|u_{0}\right\|_{L^{2}\left(\mathbb{R}^{d}\right)}^{1-\gamma_{\mathrm{c}}}<\|\nabla Q\|_{L^{2}\left(\mathbb{R}^{d}\right)}^{\gamma_{\mathrm{c}}}\|Q\|_{L^{2}\left(\mathbb{R}^{d}\right)}^{1-\gamma_{\mathrm{c}}},
\end{gather*}
$$

where $Q$ is the unique nonnegative, radially symmetric, decreasing solution of the ground state equation

$$
\Delta Q-Q+|x|^{-b}|Q|^{\alpha} Q=0
$$

He also proved that if $u_{0} \in H^{1}\left(\mathbb{R}^{d}\right) \cap L^{2}\left(\mathbb{R}^{d},|x|^{2} d x\right)=: \Sigma$ satisfies (1.6) and

$$
\begin{equation*}
\left\|\nabla u_{0}\right\|_{L^{2}\left(\mathbb{R}^{d}\right)}^{\gamma_{\mathrm{c}}}\left\|u_{0}\right\|_{L^{2}\left(\mathbb{R}^{d}\right)}^{1-\gamma_{\mathrm{c}}}>\|\nabla Q\|_{L^{2}\left(\mathbb{R}^{d}\right)}^{\gamma_{\mathrm{c}}}\|Q\|_{L^{2}\left(\mathbb{R}^{d}\right)}^{1-\gamma_{\mathrm{c}}} \tag{1.7}
\end{equation*}
$$

then the blow-up in $H^{1}\left(\mathbb{R}^{d}\right)$ must occur. Afterwards, Farah-Guzman in $[8,9]$ proved that the above global solution is scattering under the radial condition of the initial data.

Recently, Guzman in [14] used Strichartz estimates and the contraction mapping argument to establish the well-posedness for the (INLS) in Sobolev space. Precisely, he showed that:

- if $0<\alpha<\alpha_{\star}$ and $0<b<\min \{2, d\}$, then the (INLS) is locally well-posed in $L^{2}\left(\mathbb{R}^{d}\right)$. It is then globally well-posed in $L^{2}\left(\mathbb{R}^{d}\right)$ by mass conservation.
- if $0<\alpha<\widetilde{\alpha}, 0<b<\widetilde{b}$ and $\max \left\{0, \gamma_{c}\right\}<\gamma \leq \min \left\{\frac{d}{2}, 1\right\}$ where

$$
\widetilde{\alpha}:=\left\{\begin{array}{cl}
\frac{4-2 b}{d-2 \gamma} & \text { if } \gamma<\frac{d}{2},  \tag{1.8}\\
\infty & \text { if } \gamma=\frac{d}{2}
\end{array} \quad \text { and } \quad \widetilde{b}:=\left\{\begin{array}{cl}
\frac{d}{3} & \text { if } d=1,2,3 \\
2 & \text { if } d \geq 4,
\end{array}\right.\right.
$$

then the (INLS) is locally well-posed in $H^{\gamma}\left(\mathbb{R}^{d}\right)$.

- if $\alpha_{\star}<\alpha<\widetilde{\alpha}, 0<b<\widetilde{b}$ and $\gamma_{c}<\gamma \leq \min \left\{\frac{d}{2}, 1\right\}$, then the (INLS) is globally well-posed in $H^{\gamma}\left(\mathbb{R}^{d}\right)$ for small initial data.
In particular, Guzman proved the following local well-posedness in the energy space for the (INLS).
Theorem 1.1 ([14]). Let $d \geq 2,0<b<\widetilde{b}$ and $0<\alpha<\alpha^{\star}$. Then the (INLS) is locally wellposed in $H^{1}\left(\mathbb{R}^{d}\right)$. Moreover, the local solutions satisfy $u \in L_{\mathrm{loc}}^{p}\left(\mathbb{R}, L^{q}\left(\mathbb{R}^{d}\right)\right)$ for any Schrödinger admissible pair $(p, q)$.

Recently, the author in [6] improved the range of $b$ in Theorem 1.1 in the two and three dimensional spatial spaces. More precisely, he proved the following:

Theorem 1.2 ([6]). Let

$$
d \geq 4, \quad 0<b<2, \quad 0<\alpha<\alpha^{\star}
$$

or

$$
d=3, \quad 0<b<1, \quad 0<\alpha<\alpha^{\star}
$$

or

$$
d=3, \quad 1 \leq b<\frac{3}{2}, \quad 0<\alpha<\frac{6-4 b}{2 b-1}
$$

or

$$
d=2, \quad 0<b<1, \quad 0<\alpha<\alpha^{\star}
$$

Then the (INLS) is locally well-posed in $H^{1}\left(\mathbb{R}^{d}\right)$. Moreover, the solutions satisfy $u \in L_{\mathrm{loc}}^{p}\left(\mathbb{R}, L^{q}\left(\mathbb{R}^{d}\right)\right)$ for any Schrödinger admissible pair $(p, q)$.

Note that the results of Guzman [14] and Dinh [6] about the local well-posedness of (INLS) in $H^{1}\left(\mathbb{R}^{d}\right)$ are a bit weaker than the one of Genoud-Stuart [11]. Precisely, they do not treat the case $d=1$, and there is a restriction on the validity of $b$ when $d=2$ or 3 . Note also that the author in [6] pointed out that one cannot expect a similar result as Theorem 1.1 or Theorem 1.2 holds in the one dimensional case by using Strichartz estimates. Although the result showed by Genoud-Stuart is strong, but one does not know whether the local solutions belong to $L_{\mathrm{loc}}^{p}\left(\mathbb{R}, L^{q}\left(\mathbb{R}^{d}\right)\right)$ for any Schrödinger admissible pair $(p, q)$. This property plays an important role in proving the scattering for the defocusing (INLS).

Note that the local well-posedness (which is also available for the defocusing case) of GenoudStuart in [11] and the conservations of mass and energy immediately give the global well-posedness in $H^{1}\left(\mathbb{R}^{d}\right)$ for the defocusing (INLS). In [6], the author used the pseudo-conformal conservation law to show the decaying property of global solutions by assuming the initial data in $\Sigma$ (see before (1.7)). In particular, he showed that in the case $\alpha \in\left[\alpha_{\star}, \alpha^{\star}\right)$, global solutions have the same decay as the solutions of the linear Schrödinger equation, that is for $2 \leq q \leq \frac{2 d}{d-2}$ when $d \geq 3$ or $2 \leq q<\infty$ when $d=2$ or $2 \leq q \leq \infty$ when $d=1$,

$$
\|u(t)\|_{L^{q}\left(\mathbb{R}^{d}\right)} \lesssim|t|^{-d\left(\frac{1}{2}-\frac{1}{q}\right)}, \quad \forall t \neq 0
$$

This allows the author proved the scattering in $\Sigma$ for a certain class of the defocusing (INLS). We refer the reader to [6] for more details.

The main purpose of this paper is to show the energy scattering property for the defocusing (INLS). Before stating our resuts, let us recall some known techniques to prove the energy scattering for the nonlinear Schrödinger equation (NLS). To our knowledge, there are two methods to prove
the energy scattering for the (NLS). The first one is to use the classical Morawetz inequality to derive the decay of global solutions, and then use it to prove the global Strichartz bound of solutions (see e.g. $[13,17]$ or [2]). The second one is to use the interaction Morawetz inequality to derive directly the global Strichartz bound for solutions (see e.g. [20], [4] and references therein). With the global Strichartz bound at hand, the energy scattering follows easily. Note also that Visciglia in [22] used the interaction Morawetz inequality to show the decay of global solutions. This allows the author to show the decaying property for the (NLS) in any dimensions. This approach is a complement to [13] where the classical Morawetz inequality only allowed to prove the decaying property in spatial dimensions greater than or equal to three. It is worth noticing that the (INLS) does not enjoy the conservation of momentum which is crucial to prove the interaction Morawetztype inequality (see e.g. [4]). We thus do not attempt to show the interaction Morawetz-type inequality for the defocusing (INLS). It is also not clear to us that the techniques of $[13,17]$ can be applied for the defocusing (INLS). Fortunately, we are able to use the classical Morawetz-type inequality and the technique of [22] to show the decay of global solutions for the defocusing (INLS). More precisely, we have the following decay of global solutions to the defocusing(INLS).
Theorem 1.3. Let $d \geq 3,0<b<2$ and $0<\alpha<\alpha^{\star}$. Let $u_{0} \in H^{1}\left(\mathbb{R}^{d}\right)$ and $u \in C\left(\mathbb{R}, H^{1}\left(\mathbb{R}^{d}\right)\right)$ be the unique global solution to the defocusing (INLS). Then,

$$
\begin{equation*}
\lim _{t \rightarrow \pm \infty}\|u(t)\|_{L^{q}\left(\mathbb{R}^{d}\right)}=0 \tag{1.9}
\end{equation*}
$$

for every $q \in\left(2,2^{\star}\right)$, where $2^{\star}:=\frac{2 d}{d-2}$.
The proof of this result is based on the classical Morawetz-type inequality and an argument of Visciglia in [22]. The classical Morawetz-type inequality related to the defocusing (INLS) is derived by using the same argument of that for the classical (NLS). This inequality is enough to prove the decaying property for global solutions of the defocusing (INLS) by following the technique of [22]. Note that in [22], the author used the interaction Morawetz inequality to show the decay of solutions for the defocusing (NLS) in any dimensions. We expect that the decay (1.9) still holds in dimensions 1 and 2 . But it is not clear to us how to prove it at the moment.

Using the decaying property given in Theorem 1.3, we are able to show the energy scattering for the defocusing (INLS). Due to the singularity of $|x|^{-b}$, the scattering result does not cover the full range of exponents as in Theorem 1.2. Our main result is the following:

Theorem 1.4. Let

$$
d \geq 4, \quad 0<b<2, \quad \alpha_{\star}<\alpha<\alpha^{\star}
$$

or

$$
d=3, \quad 0<b<\frac{5}{4}, \quad \alpha_{\star}<\alpha<3-2 b .
$$

Let $u_{0} \in H^{1}\left(\mathbb{R}^{d}\right)$ and $u$ be the unique global solution to the defocusing (INLS). Then there exists $u_{0}^{ \pm} \in H^{1}\left(\mathbb{R}^{d}\right)$ such that

$$
\lim _{t \rightarrow \pm \infty}\left\|u(t)-e^{i t \Delta} u_{0}^{ \pm}\right\|_{H^{1}\left(\mathbb{R}^{d}\right)}=0
$$

The proof of this result is based on a standard argument as for the nonlinear Schrödinger equation (see e.g. [2, Chapter 7]). Because of the singularity $|x|^{-b}$, one needs to be careful in order to control the nonlinearity in terms of decay norms and Strichartz norms. The singularity also leads to a restriction on the ranges of $b$ and $\alpha$ compared to those in Theorem 1.3. We expect that the same result still holds true in the two dimensional case. This expectation will be possible if one can show the same decay as in Theorem 1.3 in 2D.

The plan of this paper is as follows. In Section 2, we introduce some notations and give
some preliminary results related to our problem. In Section 3, we derive classical Morawetztype inequalities for the defocusing (INLS). The proof of the decaying property of Theorem 1.3 is given in Section 4. Section 5 is devoted to the proof of the scattering result of Theorem 1.4.

## 2. Preliminaries

In the sequel, the notation $A \lesssim B$ denotes an estimate of the form $A \leq C B$ for some constant $C>0$. The constant $C$ may change from line to line.
2.1. Nonlinearity. Let $F(x, z):=|x|^{-b} f(z)$ with $b>0$ and $f(z):=|z|^{\alpha} z$. The complex derivatives of $f$ are

$$
\partial_{z} f(z)=\frac{\alpha+2}{2}|z|^{\alpha}, \quad \partial_{\bar{z}} f(z)=\frac{\alpha}{2}|z|^{\alpha-2} z^{2}
$$

We have for $z, w \in \mathbb{C}$,

$$
f(z)-f(w)=\int_{0}^{1}\left(\partial_{z} f(w+\theta(z-w))(z-w)+\partial_{\bar{z}} f(w+\theta(z-w)) \overline{z-w}\right) d \theta
$$

Thus,

$$
\begin{equation*}
|F(x, z)-F(x, w)| \lesssim|x|^{-b}\left(|z|^{\alpha}+|w|^{\alpha}\right)|z-w| . \tag{2.1}
\end{equation*}
$$

To deal with the singularity $|x|^{-b}$, we have the following remark.
Remark 2.1 ([14]). Let $B:=B(0,1)=\left\{x \in \mathbb{R}^{d}:|x|<1\right\}$ and $B^{c}:=\mathbb{R}^{d} \backslash B$. Then

$$
\left\||x|^{-b}\right\|_{L^{\gamma}(B)}<\infty \quad \text { if } \quad \frac{d}{\gamma}>b
$$

and

$$
\left\||x|^{-b}\right\|_{L^{\gamma}\left(B^{c}\right)}<\infty \quad \text { if } \quad \frac{d}{\gamma}<b
$$

2.2. Strichartz estimates. Let $J \subset \mathbb{R}$ and $p, q \in[1, \infty]$. We define the mixed norm

$$
\|u\|_{L_{t}^{p}\left(J, L_{x}^{q}\right)}:=\left(\int_{J}\left(\int_{\mathbb{R}^{d}}|u(t, x)|^{q} d x\right)^{\frac{1}{q}}\right)^{\frac{1}{p}}
$$

with a usual modification when either $p$ or $q$ are infinity. When there is no risk of confusion, we may write $L_{t}^{p} L_{x}^{q}$ instead of $L_{t}^{p}\left(J, L_{x}^{q}\right)$. We also use $L_{t, x}^{p}$ when $p=q$.

Definition 2.2. A pair $(p, q)$ is said to be Schrödinger admissible, for short $(p, q) \in S$, if

$$
(p, q) \in[2, \infty]^{2}, \quad(p, q, d) \neq(2, \infty, 2), \quad \frac{2}{p}+\frac{d}{q}=\frac{d}{2}
$$

We denote for any spacetime slab $J \times \mathbb{R}^{d}$,

$$
\begin{equation*}
\|u\|_{S\left(L^{2}, J\right)}:=\sup _{(p, q) \in S}\|u\|_{L_{t}^{p}\left(J, L_{x}^{q}\right)}, \quad\|v\|_{S^{\prime}\left(L^{2}, J\right)}:=\inf _{(p, q) \in S}\|v\|_{L_{t}^{p^{\prime}\left(J, L_{x}^{q^{\prime}}\right)}} \tag{2.2}
\end{equation*}
$$

We next recall well-known Strichartz estimates for the linear Schrödinger equation. We refer the reader to $[2,19]$ for more details.
Proposition 2.3. Let $u$ be a solution to the linear Schrödinger equation, namely

$$
u(t)=e^{i t \Delta} u_{0}+\int_{0}^{t} e^{i(t-s) \Delta} F(s) d s
$$

for some data $u_{0}, F$. Then,

$$
\begin{equation*}
\|u\|_{S\left(L^{2}, \mathbb{R}\right)} \lesssim\left\|u_{0}\right\|_{L_{x}^{2}}+\|F\|_{S^{\prime}\left(L^{2}, \mathbb{R}\right)} \tag{2.3}
\end{equation*}
$$

## 3. Classical Morawetz-type inequality

In this section, we will derive interaction Morawetz inequalities for the defocusing (INLS) by following the technique of [20]. Given a smooth real valued function $a$, we define the Morawetz action by

$$
\begin{equation*}
M_{a}(t):=2 \int_{\mathbb{R}^{d}} \nabla a(x) \cdot \operatorname{Im}(\bar{u}(t, x) \nabla u(t, x)) d x \tag{3.1}
\end{equation*}
$$

By a direct computation, we have the following result.
Lemma 3.1 ([20]). If $u$ is a smooth-in-time and Schwartz-in-space solution to

$$
i \partial_{t} u+\Delta u=N(u)
$$

with $N(u)$ satisfying $\operatorname{Im}(N(u) \bar{u})=0$, then we have

$$
\begin{align*}
\frac{d}{d t} M_{a}(t)=-\int \Delta^{2} a(x)|u(t, x)|^{2} d x & +4 \sum_{j, k=1}^{d} \int \partial_{j k}^{2} a(x) \operatorname{Re}\left(\partial_{k} u(t, x) \partial_{j} \bar{u}(t, x)\right) d x  \tag{3.2}\\
& +2 \int \nabla a(x) \cdot\{N(u), u\}_{p}(t, x) d x
\end{align*}
$$

where $\{f, g\}_{p}:=\operatorname{Re}(f \nabla \bar{g}-g \nabla \bar{f})$ is the momentum bracket.
We refer the reader to [20, Lemma 5.3] for the proof of this result. Note that if $N(u)=F(x, u)=$ $|x|^{-b}|u|^{\alpha} u$, then we have ${ }^{1}$

$$
\begin{equation*}
\{N(u), u\}_{p}=-\frac{\alpha}{\alpha+2} \nabla\left(|x|^{-b}|u|^{\alpha+2}\right)-\frac{2}{\alpha+2} \nabla\left(|x|^{-b}\right)|u|^{\alpha+2} \tag{3.3}
\end{equation*}
$$

In particular, we have the following consequence.
Corollary 3.2. If $u$ is a smooth-in-time and Schwartz-in-space solution to the defocusing (INLS), then we have

$$
\begin{align*}
\frac{d}{d t} M_{a}(t)= & -\int \Delta^{2} a(x)|u(t, x)|^{2} d x+4 \sum_{j, k=1}^{d} \int \partial_{j k}^{2} a(x) \operatorname{Re}\left(\partial_{k} u(t, x) \partial_{j} \bar{u}(t, x)\right) d x  \tag{3.4}\\
& +\frac{2 \alpha}{\alpha+2} \int \Delta a(x)|x|^{-b}|u(t, x)|^{\alpha+2} d x-\frac{4}{\alpha+2} \int \nabla a(x) \cdot \nabla\left(|x|^{-b}\right)|u(t, x)|^{\alpha+2} d x
\end{align*}
$$

With the help of Lemma 3.1, we obtain the following classical Morawetz-type inequalities for the defocusing (INLS).
Proposition 3.3. Let $d \geq 3,0<b<2$ and $u$ be a solution to the defocusing (INLS) on the spacetime slab $J \times \mathbb{R}^{d}$. Then

$$
\begin{equation*}
\int_{J} \int_{\mathbb{R}^{d}}|x|^{-b-1}|u(t, x)|^{\alpha+2} d x d t<\infty \tag{3.5}
\end{equation*}
$$

Proof. We consider $a(x)=|x|$. An easy computation shows

$$
\partial_{j} a(x)=\frac{x_{j}}{|x|}, \quad \partial_{j k}^{2} a(x)=\frac{1}{|x|}\left(\delta_{j k}-\frac{x_{j} x_{k}}{|x|^{2}}\right)
$$

for $j, k=1, \cdots, d$. This implies

$$
\nabla a(x)=\frac{x}{|x|}, \quad \Delta a(x)=\frac{d-1}{|x|}
$$

-\Delta^{2} a(x)=-(d-1) \Delta\left(\frac{1}{|x|}\right)= $$
\begin{cases}4 \pi(d-1) \delta_{0} & \text { if } d=3 \\ \frac{(d-1)(d-3)}{|x|^{3}} & \text { if } d \geq 4\end{cases}
$$
\]

where $\delta_{0}$ is the Dirac delta function. Since $a$ is a convex function, it is well-known that

$$
\sum_{j, k=1}^{d} \partial_{j k}^{2} a \operatorname{Re}\left(\partial_{k} u \partial_{j} \bar{u}\right) \geq 0
$$

Therefore, applying (3.4) with $a(x)=|x|$, we get

$$
\frac{d}{d t} M_{|x|}(t) \geq \frac{2 \alpha(d-1)+4 b}{\alpha+2} \int|x|^{-b-1}|u(t, x)|^{\alpha+2} d x
$$

Thus,

$$
\int_{J} \int_{\mathbb{R}^{d}}|x|^{-b-1}|u(t, x)|^{\alpha+2} d x d t \lesssim \sup _{t \in J}\left|M_{|x|}(t)\right| \lesssim\|u(t)\|_{L_{t}^{\infty}\left(J, L_{x}^{2}\right)}\|\nabla u(t)\|_{L_{t}^{\infty}\left(J, L_{x}^{2}\right)}<\infty
$$

The last estimate follows from the conservations of mass and energy.
Remark 3.4. The above method breaks down for $d \leq 2$ since the distribution $-\Delta^{2}(|x|)$ is not positive anymore. In this case, one can adapt an argument of Nakanishi in [17] to show

$$
\begin{equation*}
\int_{J} \int_{\mathbb{R}^{d}} \frac{t^{2}}{\left(t^{2}+|x|^{2}\right)^{\frac{3}{2}}}|x|^{-b}|u(t, x)|^{\alpha+2} d x d t<\infty \tag{3.6}
\end{equation*}
$$

However, we do not know whether the estimate (3.6) is sufficient to prove the decay of global solutions to the defocusing (INLS).

## 4. Decay of global solutions

In this section, we will give the proof of Theorem 1.3. To do so, we follow the argument of Visciglia in [22]. Let us start with the following:
Lemma 4.1. Let $d \geq 3,0<b<2$ and $0<\alpha<\alpha^{\star}$. Let $\chi \in C_{0}^{\infty}$ be a cutoff function and $\psi_{n} \in H_{x}^{1}$ be a sequence such that

$$
\sup _{n \in \mathbb{N}}\left\|\psi_{n}\right\|_{H_{x}^{1}}<\infty, \quad \text { and } \quad \psi_{n} \rightharpoonup \psi \text { weakly in } H_{x}^{1}
$$

Let $v_{n}$ and $v \in C\left(\mathbb{R}, H_{x}^{1}\right)$ be the corresponding solutions to the defocusing (INLS) with initial data $\psi_{n}$ and $\psi$ respectively. Then for every $\epsilon>0$, there exists $T(\epsilon)>0$ and $n(\epsilon) \in \mathbb{N}$ such that

$$
\begin{equation*}
\sup _{t \in(0, T(\epsilon))}\left\|\chi\left(v_{n}(t)-v(t)\right)\right\|_{L_{x}^{2}} \leq \epsilon, \quad \forall n>n(\epsilon) \tag{4.1}
\end{equation*}
$$

Proof. By the conservations of mass and energy,

$$
\begin{equation*}
\sup _{t \in \mathbb{R}, n \in \mathbb{N}}\left\{\left\|v_{n}(t)\right\|_{H_{x}^{1}},\|v(t)\|_{H_{x}^{1}}\right\}<\infty \tag{4.2}
\end{equation*}
$$

By Rellich's compactness lemma, up to a subsequence,

$$
\begin{equation*}
\lim _{n \rightarrow \infty}\left\|\chi\left(\psi_{n}-\psi\right)\right\|_{L_{x}^{2}}=0 \tag{4.3}
\end{equation*}
$$

Now let $w_{n}(t, x):=\chi(x) v_{n}(t, x)$ and $w(t, x):=\chi(x) v(t, x)$. It is easy to see that

$$
i \partial_{t} w_{n}=-\Delta w_{n}+2 \nabla \chi \cdot \nabla v_{n}+v_{n} \Delta \chi+\chi|x|^{-b}\left|v_{n}\right|^{\alpha} v_{n}, \quad w_{n}(0)=\chi \psi_{n}
$$

and

$$
i \partial_{t} w=-\Delta w+2 \nabla \chi \cdot \nabla v+v \Delta \chi+\chi|x|^{-b}|v|^{\alpha} v, \quad w(0)=\chi \psi
$$

Thus, by Duhamel formula,

$$
\begin{align*}
w_{n}(t)-w(t)= & e^{i t \Delta}\left(\chi\left(\psi_{n}-\psi\right)\right)-i \int_{0}^{t} e^{i(t-s) \Delta}\left(2 \nabla \chi \cdot \nabla\left(v_{n}(s)-v(s)\right)+\left(v_{n}(s)-v(s)\right) \Delta \chi\right) d s \\
& -i \int_{0}^{t} e^{i(t-s) \Delta}\left(\chi|x|^{-b}\left(\left|v_{n}(s)\right|^{\alpha} v_{n}(s)-|v(s)|^{\alpha} v(s)\right)\right) d s \tag{4.4}
\end{align*}
$$

Due to the singularity of $|x|^{-b}$, we need to consider two cases:
Case 1: The support of $\chi$ does not contain the origin. In this case, the proof follows as in [22, Lemma 1.1]. For reader's convenience, we recall some details. Denote $J=(0, T)$. Let us introduce the following Schrödinger admissible pair $(p, q)$, where

p=\frac{8}{(d-2) \alpha}, \quad q=\frac{4 d}{2 d-(d-2) \alpha} .
$$

Using Strichartz estimates, we get

$$
\begin{align*}
\left\|w_{n}-w\right\|_{L_{t}^{p}\left(J, L_{x}^{q}\right)} \lesssim & \left\|\chi\left(\psi_{n}-\psi\right)\right\|_{L_{x}^{2}}+\left\|\nabla \chi \cdot \nabla\left(v_{n}-v\right)\right\|_{L_{t}^{1}\left(J, L_{x}^{2}\right)} \\
& +\left\|\left(v_{n}-v\right) \Delta \chi\right\|_{L_{t}^{1}\left(J, L_{x}^{2}\right)}+\left\|\chi|x|^{-b}\left(\left|v_{n}\right|^{\alpha} v_{n}-|v|^{\alpha} v\right)\right\|_{L_{t}^{p^{\prime}}\left(J, L_{x}^{q^{\prime}}\right)} \tag{4.5}
\end{align*}
$$

We use (4.2), Hölder's inequality and the Sobolev embedding $H_{x}^{1} \subset L_{x}^{\frac{2 d}{d-2}}$ to get

$$
\begin{aligned}
\left\|w_{n}-w\right\|_{L_{t}^{p}\left(J, L_{x}^{q}\right)} & \lesssim\left\|\chi\left(\psi_{n}-\psi\right)\right\|_{L_{x}^{2}}+|J|+\left\|\chi\left(v_{n}-v\right)\right\|_{L_{t}^{p^{\prime}}\left(J, L_{x}^{q}\right)} \sup _{t \in J}\left(\left\|v_{n}(t)\right\|_{L_{x}^{\frac{2 d}{d-2}}}+\|v(t)\|_{L_{x}^{\frac{2 d}{d-2}}}^{\alpha}\right) \\
& \lesssim\left\|\chi\left(\psi_{n}-\psi\right)\right\|_{L_{x}^{2}}+|J|+|J|^{1-\frac{2}{p}}\left\|v_{n}-v\right\|_{L_{t}^{p}\left(J, L_{x}^{q}\right)} .
\end{aligned}
$$

We learn from the above estimate and (4.3) that for every $\epsilon>0$, there exists $n(\epsilon) \in \mathbb{N}$ and $T(\epsilon)>0$ such that

$$
\begin{equation*}
\left\|w_{n}-w\right\|_{L_{t}^{p}\left(I(\epsilon), L_{x}^{q}\right)} \leq \epsilon, \tag{4.6}
\end{equation*}
$$

for all $n>n(\epsilon)$, where $I(\epsilon)=(0, T(\epsilon))$. By applying again Strichartz estimate and arguing as above, we obtain

$$
\left\|w_{n}-w\right\|_{L_{t}^{\infty}\left(I(\epsilon), L_{x}^{2}\right)} \lesssim\left\|\chi\left(\psi_{n}-\psi\right)\right\|_{L_{x}^{2}}+C|I(\epsilon)|+|I(\epsilon)|^{1-\frac{2}{p}}\left\|w_{n}-w\right\|_{L_{t}^{p}\left(I(\epsilon), L_{x}^{q}\right)}
$$

Combining this estimate with (4.2) and (4.6), we prove (4.1).
Case 2: The support of $\chi$ contains the origin. Without loss of generality, we assume that $\operatorname{supp}(\chi) \subset B$, where $B$ is the ball centered at the origin and of radius 1. Since we are considering $0<\alpha<\frac{4-2 b}{d-2}$, there exists $\delta \in\left(0, \frac{2-b}{2(d-2)}\right)$ such that $\alpha=\frac{4-2 b}{d-2}-4 \delta$. Let us choose a Schrödinger admissible pair $(p, q)$ with

$$
p=\frac{4}{2-(d-2) \delta}, \quad q=\frac{2 d}{(d-2)(1+\delta)}
$$

In the view of (4.5), it suffices to bound $\left\|\chi|x|^{-b}\left(\left|v_{n}\right|^{\alpha} v_{n}-|v|^{\alpha} v\right)\right\|_{L_{t}^{p^{\prime}}\left(J, L_{x}^{q^{\prime}}\right)}$. To do this, we use Hölder's inequality, Sobolev embedding and (4.2) to get
where

$$
\gamma=\frac{d}{(d-2) \delta+b}, \quad r=\frac{2 d}{4-2 b+(d-2)(1-3 \delta)}
$$

By Remark 2.1, $\left\||x|^{-b}\right\|_{L_{x}^{\gamma}(B)}<\infty$ provided $\frac{d}{\gamma}>b$, and it is easy to check that

$$
\frac{d}{\gamma}=(d-2) \delta+b>b
$$

With (4.7) at hand, we argue as in Case 1 to have (4.1).
Remark 4.2. It is not hard to check that Lemma 4.1 still holds true for any $d \geq 1,0<b<$ $\min \{2, d\}$ and $0<\alpha<\alpha^{\star}$.

We are now able to prove the decay of global solutions to the defocusing (INLS).
Proof of Theorem 1.3. We only consider the case $t \rightarrow+\infty$, the case $t \rightarrow-\infty$ is treated similarly. We firstly note that by interpolating between $L_{x}^{2}$-norm, $L_{x}^{2^{\star}}$-norm and $L_{x}^{q}$ with $2<q<2^{\star}$, it suffices to prove (1.9) for $q=2+\frac{4}{d}$. We next recall the following localized Gagliardo-Nirenberg inequality for $d \geq 3$, that is

$$
\begin{equation*}
\|\varphi\|_{L_{x}^{2+\frac{4}{d}}}^{2+\frac{4}{2}} \leq C\left(\sup _{x \in \mathbb{R}^{d}}\|\varphi\|_{L^{2}\left(Q_{1}(x)\right)}\right)^{\frac{4}{d}}\|\varphi\|_{H_{x}^{1}}^{2} \tag{4.8}
\end{equation*}
$$

where $Q_{r}(x)$ is the cubic in $\mathbb{R}^{d}$ centered at $x$ whose edge has length $r$. Let $u$ be the global solution to the defocusing (INLS). The conservations of mass and energy show that

$$
\sup _{t \in \mathbb{R}}\|u(t)\|_{H_{x}^{1}}<\infty
$$

Assume by the absurd that there is a sequence $t_{n} \rightarrow \infty$ such that

$$
\begin{equation*}
\left\|u\left(t_{n}\right)\right\|_{L_{x}^{2+\frac{4}{d}}} \geq \epsilon_{0}>0 \tag{4.9}
\end{equation*}
$$

for all $n \in \mathbb{N}$. By applying (4.8) with $\varphi \equiv u\left(t_{n}, x\right)$, we see from (4.9) that there exists a sequence $\left(x_{n}\right)_{n \in \mathbb{N}}$ of $\mathbb{R}^{d}$ such that

$$
\begin{equation*}
\left\|u\left(t_{n}\right)\right\|_{L^{2}\left(Q_{1}\left(x_{n}\right)\right)} \geq \epsilon_{1}>0 \tag{4.10}
\end{equation*}
$$

for all $n \in \mathbb{N}$. We now set $\psi_{n}(t, x):=u\left(t_{n}, x+x_{n}\right)$. By the conservations of mass and energy,

$$
\sup _{n \in \mathbb{N}}\left\|\psi_{n}\right\|_{H_{x}^{1}}<\infty
$$

Thus, up to a subsequence, there exists $\psi \in H^{1}$ such that $\psi_{n} \rightharpoonup \psi$ weakly in $H_{x}^{1}$. By Rellich's compactness lemma, up to a subsequence, we have

$$
\begin{equation*}
\lim _{n \rightarrow \infty}\left\|\psi_{n}-\psi\right\|_{L^{2}\left(Q_{1}(0)\right)}=0 \tag{4.11}
\end{equation*}
$$

We also have from (4.10) that $\left\|\psi_{n}\right\|_{L^{2}\left(Q_{1}(0)\right)} \geq \epsilon_{1}$. Thus, (4.11) ensures that there exists a positive real number still denoted by $\epsilon_{1}$ such that

$$
\begin{equation*}
\|\psi\|_{L^{2}\left(Q_{1}(0)\right)} \geq \epsilon_{1} \tag{4.12}
\end{equation*}
$$

Let us now introduce $v_{n}(t, x)$ and $v(t, x)$ as the solutions to

$$
\left\{\begin{aligned}
i \partial_{t} v_{n}+\Delta v_{n}-\left|x-x_{n}\right|^{-b}\left|v_{n}\right|^{\alpha} v_{n} & =0 \\
v_{n}(0) & =\psi_{n}
\end{aligned}\right.
$$

and

$$
\left\{\begin{aligned}
i \partial_{t} v+\Delta v-\left|x-x_{n}\right|^{-b}|v|^{\alpha} v & =0 \\
v(0) & =\psi
\end{aligned}\right.
$$

Let $\chi$ be any cutoff function supported in $Q_{2}(0)$ such that $\chi \equiv 1$ on $Q_{1}(0)$. We have from (4.12) and a continuity argument that there exists $T_{1}>0$ such that

$$
\inf _{t \in\left(0, T_{1}\right)}\|\chi v(t)\|_{L_{x}^{2}} \geq \frac{\epsilon_{1}}{2}
$$

Next, applying Lemma 4.1, there exists $T_{2}>0$ and $N \in \mathbb{N}$ such that

$$
\sup _{t \in\left(0, T_{2}\right)} \| \chi\left(v_{n}(t)-v(t) \|_{L_{x}^{2}} \leq \frac{\epsilon_{1}}{4}\right.
$$

for all $n>N$. Thus, we get for all $t \in\left(0, T_{0}\right)$ with $T_{0}=\min \left\{T_{1}, T_{2}\right\}$ and all $n>N$,

$$
\left\|\chi v_{n}(t)\right\|_{L_{x}^{2}} \geq\|\chi v(t)\|_{L_{x}^{2}}-\| \chi\left(v_{n}(t)-v(t) \|_{L_{x}^{2}} \geq \frac{\epsilon_{1}}{4}\right.
$$

By the choice of $\chi$, we have for all $t \in\left(0, T_{0}\right)$ and all $n>N$,

$$
\begin{equation*}
\left\|v_{n}(t)\right\|_{L^{2}\left(Q_{2}(0)\right)} \geq \frac{\epsilon_{1}}{4} . \tag{4.13}
\end{equation*}
$$

By the uniqueness of local solution to the (INLS),

$$
v_{n}(t, x)=u\left(t+t_{n}, x+x_{n}\right)
$$

Thus, for all $t \in\left(t_{n}, t_{n}+T_{0}\right)$ and all $n>N$,

$$
\begin{equation*}
\|u(t)\|_{L^{2}\left(Q_{2}\left(x_{n}\right)\right)} \geq \frac{\epsilon_{1}}{4} \tag{4.14}
\end{equation*}
$$

Moreover, as $\lim _{n \rightarrow \infty} t_{n}=+\infty$, we can suppose ${ }^{2}$ that $t_{n+1}-t_{n}>T_{0}$ for $n>N$. By Hölder's inequality,

$$
\begin{equation*}
\|u(t)\|_{L^{\alpha+2}\left(Q_{2}\left(x_{n}\right)\right)} \gtrsim\|u(t)\|_{L^{2}\left(Q_{2}\left(x_{n}\right)\right)} \geq \frac{\epsilon_{1}}{4} \tag{4.15}
\end{equation*}
$$

for all $t \in\left(t_{n}, t_{n}+T_{0}\right)$ and all $n>N$.
The classical Morawetz inequality (3.5) combined with (4.15) imply

$$
\begin{aligned}
\infty & >\int_{0}^{+\infty} \int_{\mathbb{R}^{d}}|x|^{-b-1}|u(t, x)|^{\alpha+2} d x d t \\
& \gtrsim \sum_{n>N} \int_{t_{n}}^{t_{n}+T_{0}} \int_{Q_{2}\left(x_{n}\right)}|u(t, x)|^{\alpha+2} d x d t \\
& \gtrsim \sum_{n>N}\left(\frac{\epsilon_{1}}{4}\right)^{\alpha+2} T_{0}=\infty .
\end{aligned}
$$

This is impossible, and the proof is complete.

## 5. Scattering property

In this section, we will give the proof of the scattering property given in Theorem 1.4. To do this, we use Strichartz estimates and the decay property given in Theorem 1.3 to obtain a global bound on the solution. The scattering property follows easily from the standard argument.
Lemma 5.1. Let $d, b$ and $\alpha$ be as in Theorem 1.4. Let $u$ be a solution to the defocusing (INLS) on a spacetime slab $J \times \mathbb{R}^{d}$ and $t_{0} \in J$. Then there exists $\theta_{1}, \theta_{2} \in(0, \alpha)$ and $q_{1}, q_{2} \in\left(2,2^{\star}\right)$ such that

$$
\left\|u-e^{i t \Delta} u\left(t_{0}\right)\right\|_{S(J)} \lesssim\|u\|_{L_{t}^{\infty}\left(J, L_{x}^{q_{1}}\right)}^{\alpha-\theta_{1}}\|u\|_{S(J)}^{1+\theta_{1}}+\|u\|_{L_{t}^{\infty}\left(J, L_{x}^{q_{2}}\right)}^{\alpha-\theta_{2}}\|u\|_{S(J)}^{1+\theta_{2}},
$$

where $\|u\|_{S(J)}:=\|\langle\nabla\rangle u\|_{S\left(L^{2}, J\right)}$.

[^2]Proof. By Duhamel's formula, the solution to the defocusing (INLS) can be writen as

u(t)=e^{i t \Delta} u\left(t_{0}\right)-i \int_{t_{0}}^{t} e^{i(t-s) \Delta}|x|^{-b}|u(s)|^{\alpha} u(s) d s

The Strichartz estimate (2.3) implies

\left\|u-e^{i t \Delta} u\left(t_{0}\right)\right\|_{S(J)} \lesssim\left\||x|^{-b}|u|^{\alpha} u\right\|_{S^{\prime}\left(L^{2}, J\right)}+\left\|\nabla\left(|x|^{-b}|u|^{\alpha} u\right)\right\|_{S^{\prime}\left(L^{2}, J\right)} .
$$

We next bound

$$
\begin{aligned}
\left\||x|^{-b}|u|^{\alpha} u\right\|_{S^{\prime}\left(L^{2}, J\right)} & \leq\left\||x|^{-b}|u|^{\alpha} u\right\|_{S^{\prime}\left(L^{2}(B), J\right)}+\left\||x|^{-b}|u|^{\alpha} u\right\|_{S^{\prime}\left(L^{2}\left(B^{c}\right), J\right)}=: A_{1}+A_{2}, \\
\left\|\nabla\left(|x|^{-b}|u|^{\alpha} u\right)\right\|_{S^{\prime}\left(L^{2}, J\right)} & \leq\left\|\nabla\left(|x|^{-b}|u|^{\alpha} u\right)\right\|_{S^{\prime}\left(L^{2}(B), J\right)}+\left\|\nabla\left(|x|^{-b}|u|^{\alpha} u\right)\right\|_{S^{\prime}\left(L^{2}\left(B^{c}\right), J\right)}=: B_{1}+B_{2} .
\end{aligned}
$$

On B. By Hölder's inequality and Remark 2.1,

$$
\begin{aligned}
A_{1} \leq\left\||x|^{-b}|u|^{\alpha} u\right\|_{L_{t}^{p_{1}^{\prime}}\left(J, L_{x}^{q_{1}^{\prime}}(B)\right)} & \lesssim\left\||x|^{-b}\right\|_{L_{x}^{\gamma_{1}}(B)}\left\||u|^{\alpha} u\right\|_{L_{t}^{p_{1}^{\prime}}\left(J, L_{x}^{v_{1}}\right)} \\
& \lesssim\left\|\|u\|_{L_{x}^{q_{1}}}^{\alpha+1}\right\|_{L_{t}^{p_{1}^{\prime}}(J)} \\
& \lesssim\|u\|_{L_{t}^{\alpha}\left(J, L_{x}^{q_{1}}\right)}^{\alpha-\theta_{1}}\|u\|_{L_{t}^{p_{1}}\left(J, L_{x}^{q_{1}}\right)}^{1+\theta_{1}}
\end{aligned}
$$

provided that $\left(p_{1}, q_{1}\right) \in S$ and

$$
\frac{1}{q_{1}^{\prime}}=\frac{1}{\gamma_{1}}+\frac{1}{v_{1}}, \quad \frac{d}{\gamma_{1}}>b, \quad \frac{1}{v_{1}}=\frac{\alpha+1}{q_{1}}, \quad \theta \in(0, \alpha), \quad \frac{1}{p_{1}^{\prime}}=\frac{1+\theta_{1}}{p_{1}} .
$$

This implies

$$
\begin{equation*}
\frac{d}{\gamma_{1}}=d-\frac{d(\alpha+2)}{q_{1}}>b, \quad p_{1}=\theta_{1}+2 \in(2, \alpha+2) \tag{5.1}
\end{equation*}
$$

The first condition in (5.1) is equivalent to $q_{1}>\frac{d(\alpha+2)}{d-b}$. Let us choose

$$
\begin{equation*}
q_{1}=\frac{d(\alpha+2)}{d-b}+\epsilon \tag{5.2}
\end{equation*}
$$

B_{22} \lesssim\|u\|_{L_{t}^{\infty}\left(J, L_{x}^{q_{2}}\right)}^{\alpha-\theta_{2}}\|u\|_{L_{t}^{p_{2}}\left(J, L_{x}^{q_{2}}\right)}^{\theta_{2}}\|\langle\nabla\rangle u\|_{L_{t}^{p_{2}}\left(J, L_{x}^{q_{2}}\right)} \lesssim\|u\|_{L_{t}^{\infty}\left(J, L_{x}^{q_{2}}\right)}^{\alpha-\theta_{2}}\|u\|_{S(J)}^{1+\theta_{2}} \tag{5.17}
\end{equation*}
$$

Collecting (5.3), (5.4), (5.6), (5.10), (5.13), (5.14), (5.16) and (5.17), we complete the proof.
Corollary 5.2. Let $d, b$ and $\alpha$ be as in Theorem 1.4. Let $u_{0} \in H^{1}\left(\mathbb{R}^{d}\right)$ and $u$ be the unique global solution to the defocusing (INLS). Then

$$
u \in L_{t}^{p}\left(\mathbb{R}, W_{x}^{1, q}\right)
$$

for any Schrödinger admissible pair $(p, q)$.
Proof. By applying Lemma 5.1 with $J=(T, t)$ and using the decay property given in Theorem 1.3, we see that there exist $\theta_{1}, \theta_{2} \in(0, \alpha)$ such that

$$
\|u\|_{S((T, t))} \lesssim\|u(T)\|_{H_{x}^{1}}+\epsilon_{1}(T)\|u\|_{S((T, t))}^{1+\theta_{1}}+\epsilon_{2}(T)\|u\|_{S((T, t))}^{1+\theta_{2}},
$$

where $\epsilon_{1}(T), \epsilon_{2}(T) \rightarrow 0$ as $T \rightarrow+\infty$. By the conservations law and the continuity argument (see e.g. [2, Lemma 7.7.4] or [19, Section 1.3]), we learn that for $T$ large enough,

$$
\|u\|_{S((T, t))} \leq C
$$

for some $C>0$ independent of $t$. We thus get $u \in L_{t}^{p}\left((T,+\infty), W_{x}^{1, q}\right)$ for any $(p, q) \in S$. Similarly, we prove as well that $u \in L_{t}^{p}\left((-\infty,-T), W_{x}^{1, q}\right)$ for any $(p, q) \in S$. Combining these facts and the local well-posedness given in Theorem 1.2 , we obtain $u \in L_{t}^{p}\left(\mathbb{R}, W_{x}^{1, q}\right)$ for any Schrödinger admissible pair $(p, q)$.

We are now able to prove Theorem 1.4. The proof is based on a standard argument (see e.g. [2, Section 8.3] or [19, Section 3.6]).
Proof of Theorem 1.4. Let $u$ be the global solution to the defocusing (INLS). By Duhamel's formula,

$$
\begin{equation*}
u(t)=e^{i t \Delta} u_{0}-i \int_{0}^{t} e^{i(t-s) \Delta}|x|^{-b}|u(s)|^{\alpha} u(s) d s \tag{5.18}
\end{equation*}
$$

As in the proof of Lemma 5.1, we see that there exists $\theta_{1}, \theta_{2} \in(0, \alpha)$ and $q_{1}, q_{2} \in\left(2,2^{\star}\right)$ such that

$$
\left\|\langle\nabla\rangle\left(|x|^{-b}|u|^{\alpha} u\right)\right\|_{S^{\prime}\left(L^{2}, \mathbb{R}\right)} \lesssim\|u\|_{L_{t}^{\infty}\left(\mathbb{R}, L_{x}^{q_{1}}\right)}^{\alpha-\theta_{1}}\|u\|_{S(\mathbb{R})}^{1+\theta_{1}}+\|u\|_{L_{t}^{\infty}\left(\mathbb{R}, L_{x}^{q_{2}}\right)}^{\alpha-\theta_{2}}\|u\|_{S(\mathbb{R})}^{1+\theta_{2}} .
$$

Thus, Theorem 1.3 and Corollary 5.2 imply

$$
\begin{equation*}
\left\|\langle\nabla\rangle\left(|x|^{-b}|u|^{\alpha} u\right)\right\|_{S^{\prime}\left(L^{2}, \mathbb{R}\right)}<\infty \tag{5.19}
\end{equation*}
$$

Let $0<t_{1}<t_{2}<+\infty$. By Strichartz estimates and (5.19), we have

$$
\left\|e^{-i t_{2} \Delta} u\left(t_{2}\right)-e^{-i t_{1} \Delta} u\left(t_{1}\right)\right\|_{H_{x}^{1}} \lesssim\left\|\langle\nabla\rangle\left(|x|^{-b}|u|^{\alpha} u\right)\right\|_{S^{\prime}\left(L^{2},\left(t_{1}, t_{2}\right)\right)} \rightarrow 0
$$

as $t_{1}, t_{2} \rightarrow+\infty$. This implies that the limit

$$
u_{0}^{+}:=\lim _{t \rightarrow+\infty} e^{-i t \Delta} u(t)
$$

exists in $H_{x}^{1}$. Moreover,

$$
u(t)-e^{i t \Delta} u_{0}^{+}=-i \int_{t}^{+\infty} e^{i(t-s) \Delta}|x|^{-b}|u(s)|^{\alpha} u(s) d s
$$

Applying again Strichartz estimates, we get

$$
\lim _{t \rightarrow+\infty}\left\|u(t)-e^{i t \Delta} u_{0}^{+}\right\|_{H_{x}^{1}}=0
$$

This gives the result for positive time, the one for negative time is treated similarly. The proof is complete.

## Appendix

In this Appendix, we will give the proof of (3.3). Let $N(u)=F(x, u)=|x|^{-b}|u|^{\alpha} u$. We compute

$$
\begin{aligned}
\nabla\left(|x|^{-b}|u|^{\alpha+2}\right) & =\nabla\left(|x|^{-b}\right)|u|^{\alpha+2}+|x|^{-b} \nabla\left(|u|^{\alpha+2}\right) \\
& =\nabla\left(|x|^{-b}\right)|u|^{\alpha+2}+(\alpha+2)|x|^{-b}|u|^{\alpha} \operatorname{Re}(\nabla u \bar{u}) \\
& =\nabla\left(|x|^{-b}\right)|u|^{\alpha+2}+(\alpha+2)|x|^{-b}|u|^{\alpha} \operatorname{Re}(u \nabla \bar{u})
\end{aligned}
$$

Similarly,

$$
\nabla\left(|x|^{-b}|u|^{\alpha+2}\right)=\nabla\left(|x|^{-b}|u|^{\alpha} \bar{u} u\right)=\nabla\left(|x|^{-b}|u|^{\alpha} \bar{u}\right) u+|x|^{-b}|u|^{\alpha} \bar{u} \nabla u
$$

or

$$
\nabla\left(|x|^{-b}|u|^{\alpha} \bar{u}\right) u=\nabla\left(|x|^{-b}|u|^{\alpha+2}\right)-|x|^{-b}|u|^{\alpha} \bar{u} \nabla u
$$

Therefore,

$$
\begin{aligned}
\{N(u), u\}_{p} & =\operatorname{Re}\left(|x|^{-b}|u|^{\alpha} u \nabla \bar{u}-u \nabla\left(|x|^{-b}|u|^{\alpha} \bar{u}\right)\right) \\
& =2 \operatorname{Re}\left(|x|^{-b}|u|^{\alpha} u \nabla \bar{u}\right)-\nabla\left(|x|^{-b}|u|^{\alpha+2}\right) \\
& =\frac{2}{\alpha+2}\left(\nabla\left(|x|^{-b}|u|^{\alpha+2}\right)-\nabla\left(|x|^{-b}\right)|u|^{\alpha+2}\right)-\nabla\left(|x|^{-b}|u|^{\alpha+2}\right) \\
& =-\frac{\alpha}{\alpha+2} \nabla\left(|x|^{-b}|u|^{\alpha+2}\right)-\frac{2}{\alpha+2} \nabla\left(|x|^{-b}\right)|u|^{\alpha+2}
\end{aligned}
$$
