Effects of Tropical Climate and Language Format on Imagery Ability Among French- Creole Bilinguals

This study examined how a tropical climate (i.e., hot, and wet climatic environment) and different movement imagery language instructions could affect imagery ability on French- Creole bilingual teachers. This study was realized in Guadeloupe where the majority of the inhabitants are bilinguals (Massina et al., 2000). The participants, (Mean = 31 years), performed two tests sessions in quite hot temperature: Air Conditioning (AC) then in Tropical Climate (TC). They were divided into two independent groups: Half of them completed the Creole validated version of the Movement Imagery Questionnaire (MIQ-C; Anciaux, Alin, Le Her, & Mondor, 2002) developed by Hall and Pongrac (1983), whereas the others realized the French validated version (MIQ-F; Lorant & Gaillot, 2003).

The result of this study evidenced significant main effects of the climate: Participants had worse visual and kinesthetic MIQ-F and kinesthetic MIQ-C imagery scores in TC than in AC. More surprisingly participants had better visual imagery MIQ-C scores in TC than in AC. Finally, significant interactions revealed that bad imagers had significant lower kinesthetic imagery MIQ-F scores in TC than in AC, and had significant better visual imagery MIQ-C scores in TC than AC.

The present study highlights the necessity to take imagery ability into consideration. Moreover, the significant differences in the MIQ-C scores for kinesthetic imagery and in the MIQ-F scores for visual and kinesthetic imagery between TC and AC, confirm the literature that heat stress can negatively influence cognition (Gaoua, 2010). However, the fact that visual imagery MIQ-C scores were positively affected by TC, indicates that it is important to take the environment in which a language of movement imagery instruction is done into account. Finally, when realizing movement imagery in sport or physical education the use of Creole language can be particularly beneficial for bilinguals.
