# Variational formulation of American option prices in the Heston Model

#### Abstract

We give an analytical characterization of the price function of an American option in Heston-type models. Our approach is based on variational inequalities and extends recent results of Daskalopoulos and Feehan (2011). We study the existence and uniqueness of a weak solution of the associated degenerate parabolic obstacle problem. Then, we use suitable estimates on the joint distribution of the log-price process and the volatility process in order to characterize the analytical weak solution as the solution to the optimal stopping problem. We also rely on semi-group techniques and on the affine property of the model.


Keywords: American options; degenerate parabolic obstacle problem; optimal stopping problem.

## 1 Introduction

The model introduced by S. Heston in 1993 ([9]) is one of the most widely used stochastic volatility models in the financial world and it was the starting point for several more complex models which extend it. The great success of the Heston model is due to the fact that the dynamics of the underlying asset can take into account the non-lognormal distribution of the asset returns and the observed mean-reverting property of the volatility. Moreover, it remains analytically tractable and provides a closed-form valuation formula for European options using Fourier transform.

These features have called for an extensive literature on numerical methods to price derivatives in Hestontype models. In this framework, besides purely probabilistic methods such as standard Monte Carlo and tree approximations, there is a large class of algorithms which exploit numerical analysis techniques in order to solve the standard PDE (resp. the obstacle problem) formally associated with the European (resp. American) option price function. However, these algorithms have, in general, little mathematical support and in particular, as far as we know, a rigorous and complete study of the analytic characterization of the American price function is not present in the literature.

The main difficulties in this sense come from the degenerate nature of the model. In fact, the infinitesimal generator associated with the two dimensional diffusion given by the log-price process and the volatility process is not uniformly elliptic: it degenerates on the boundary of the domain, that is when the volatility variable vanishes. Moreover, it has unbounded coefficients with linear growth. Therefore, the existence and the uniqueness of the solution to the pricing PDE and obstacle problem do not follow from the classical theory, at least in the case in which the boundary of the state space is reached with positive probability, as happens in many cases of practical importance (see [3]). Moreover, the probabilistic representation of the solution, that is the identification with the price function, is far from trivial in the case of non regular payoffs.

It should be emphasized that a clear analytic characterization of the price function allows not only to formally justify the theoretical convergence of some classical pricing algorithms but also to investigate the regularity properties of the price function (see 11] for the case of the Black and Scholes models).

[^0]Concerning the existing literature, E. Ekstrom and J. Tysk in 6] give a rigorous and complete analysis of these issues in the case of European options, proving that, under some regularity assumptions on the payoff functions, the price function is the unique classical solution of the associated PDE with a certain boundary behaviour for vanishing values of the volatility. However, the payoff functions they consider do not include the case of standard put and call options.

Recently, P. Daskalopoulos and P. Feehan studied the existence, the uniqueness, and some regularity properties of the solution of this kind of degenerate PDE and obstacle problems in the elliptic case, introducing suitable weighted Sobolev spaces which clarify the behaviour of the solution near the degenerate boundary. Again, as regards the probabilistic representation, they only treat the case with heavy regularity assumptions on the payoff function (see [7]).

The aim of this paper is to give a precise analytical characterization of the American option price function for a large class of payoffs which includes the standard put and call options. In particular, we give a variational formulation of the American pricing problem using the weighted Sobolev spaces and the bilinear form introduced in [5]. The paper is organized as follows. In Section 2 we introduce our notations and we state our main results. Then, in section 3 we study the existence and uniqueness of the solution of the associated variational inequality, extending the results obtained in [5] in the elliptic case. The proof essentially relies on the classical penalization technique introduced by Bensoussan and Lions (4] with some technical devices due to the degenerate nature of the problem. We also establish a Comparison Theorem. Finally, in section 4, we prove that the solution of the variational inequality with obstacle function $\psi$ is actually the American option price function with payoff $\psi$, with conditions on $\psi$ which are satisfied, for example, by the standard call and put options. In order to do this, we use the affine property of the underlying diffusion given by the $\log$ price process $X$ and the volatility process $Y$. Thanks to this property, we first identify the analytic semigroup associated with the bilinear form with a correction term and the transition semigroup of the pair $(X, Y)$ with a killing term. Then, we prove regularity results on the solution of the variational inequality and suitable estimates on the joint law of the process $(X, Y)$ and we deduce from them the analytical characterization of the solution of the optimal stopping problem, that is the American option price.

## 2 Notations and main results

### 2.1 The Heston model

We recall that in the Heston model the dynamics under the pricing measure of the asset price $S$ and the volatility process $Y$ are governed by the stochastic differential equation system

$$
\left\{\begin{aligned}
\frac{d S_{t}}{S_{t}} & =(r-\delta) d t+\sqrt{Y_{t}} d B_{t}, & & S_{0}=s>0 \\
d Y_{t} & =\kappa\left(\theta-Y_{t}\right) d t+\sigma \sqrt{Y_{t}} d W_{t}, & & Y_{0}=y \geq 0
\end{aligned}\right.
$$

where $B$ and $W$ denote two correlated Brownian motions with

$$
d\langle B, W\rangle_{t}=\rho d t, \quad \rho \in(-1,1)
$$

Here $r \geq 0$ and $\delta>0$ are respectively the risk free rate of interest and the continuous dividend rate. The dynamics of $Y$ follows a CIR process with mean reversion rate $\kappa \geq 0$ and long run state $\theta \geq 0$. The parameter $\sigma>0$ is called the volatility of the volatility. Note that we do not require the Feller condition $2 \kappa \theta \geq \sigma^{2}$ : the volatility process $Y$ can hit 0 (see, for example, 2, Section 1.2.4]).

We are interested in studying the price of an American option with payoff function $\psi$. For technical reasons which will be clarified later on, hereafter we consider the process

$$
\begin{equation*}
X_{t}=\log S_{t}-\bar{c} t, \quad \text { with } \bar{c}=r-\delta-\frac{\rho \kappa \theta}{\sigma} \tag{2.1}
\end{equation*}
$$

which satisfies

$$
\left\{\begin{align*}
d X_{t} & =\left(\frac{\rho \kappa \theta}{\sigma}-\frac{Y_{t}}{2}\right) d t+\sqrt{Y_{t}} d B_{t}  \tag{2.2}\\
d Y_{t} & =\kappa\left(\theta-Y_{t}\right) d t+\sigma \sqrt{Y_{t}} d W_{t}
\end{align*}\right.
$$

Note that, in this framework, we have to consider payoff functions $\psi$ which depend on both the time and the space variables. For example, in the case of a standard put option (resp. a call option) with strike price $K$ we have $\psi(t, x)=\left(K-e^{x+\bar{c} t}\right)_{+}\left(\right.$resp. $\left.\psi(t, x)=\left(e^{x+\bar{c} t}-K\right)_{+}\right)$. So, the natural price at time $t$ of an American option with a nice enough payoff $\left(\psi\left(t, X_{t}, Y_{t}\right)\right)_{0 \leq t \leq T}$ is given by $P\left(t, X_{t}, Y_{t}\right)$, with

$$
P(t, x, y)=\operatorname{esssup}_{\theta \in \mathcal{T}_{t, T}} \mathbb{E}\left[e^{-r(\theta-t)} \psi\left(\theta, X_{\theta}^{t, x, y}, Y_{\theta}^{t, y}\right)\right]
$$

where $\mathcal{T}_{t, T}$ is the set of all stopping times with values in $[t, T]$ and $\left(X_{s}^{t, x, y}, Y_{s}^{t, y}\right)_{t \leq s \leq T}$ denotes the solution to (2.2) with the starting condition $\left(X_{t}, Y_{t}\right)=(x, y)$.

Our aim is to give an analytical characterization of the price function $P$. We recall that the infinitesimal generator of the two dimensional diffusion $(X, Y)$ is given by

$$
\mathcal{L}=\frac{y}{2}\left(\frac{\partial^{2}}{\partial x^{2}}+2 \rho \sigma \frac{\partial^{2}}{\partial y \partial x}+\sigma^{2} \frac{\partial^{2}}{\partial y^{2}}\right)+\kappa(\theta-y) \frac{\partial}{\partial y}+\left(\frac{\rho \kappa \theta}{\sigma}-\frac{y}{2}\right) \frac{\partial}{\partial x}
$$

which is defined on the open set $\mathcal{O}:=\mathbb{R} \times(0, \infty)$. Note that $\mathcal{L}$ has unbounded coefficients and is not uniformly elliptic: it degenerates on the boundary $\partial \mathcal{O}=\mathbb{R} \times\{0\}$.

### 2.2 American options and variational inequalities

### 2.2.1 Heuristics

From the optimal stopping theory, we know that the discounted price process $\tilde{P}\left(t, X_{t}, Y_{t}\right)=e^{-r t} P\left(t, X_{t}, Y_{t}\right)$ is a supermartingale and that its finite variation part only decreases on the set $P=\psi$. We want to have an analytical interpretation of these features on the function $P_{\tilde{\sim}}(t, x, y)$. So, assume that $P \in \mathcal{C}^{1,2}((0, T) \times \mathcal{O})$. Then, by applying Ito's formula, the finite variation part of $\tilde{P}\left(t, X_{t}, Y_{t}\right)$ is

$$
\left(\frac{\partial \tilde{P}}{\partial t}+\mathcal{L} \tilde{P}\right)\left(t, X_{t}, Y_{t}\right)
$$

Since $\tilde{P}$ is a supermartingale, we can deduce the inequality

$$
\frac{\partial \tilde{P}}{\partial t}+\mathcal{L} \tilde{P} \leq 0
$$

and, since its finite variation part decreases only on the set $P\left(t, X_{t}, Y_{t}\right)=\psi\left(t, X_{t}, Y_{t}\right)$, we can write

$$
\left(\frac{\partial \tilde{P}}{\partial t}+\mathcal{L} \tilde{P}\right)(\psi-P)=0
$$

This relation has to be satisfied $d t$ - a.e. along the trajectories of $\left(t, X_{t}, Y_{t}\right)$. Moreover, we have the two trivial conditions $P(T, x, y)=\psi(T, x, y)$ and $P \geq \psi$.

The previous discussion is only heuristic, since the price function $P$ is not regular enough to apply the Ito's formula. However, it suggests the following strategy:

1. Study the obstacle problem

$$
\begin{cases}\frac{\partial u}{\partial t}+\mathcal{L} u \leq 0, \quad u \geq \psi, & \text { in }[0, T] \times \mathcal{O}  \tag{2.3}\\ \left(\frac{\partial u}{\partial t}+\mathcal{L} u\right)(\psi-u)=0, & \text { in }[0, T] \times \mathcal{O} \\ u(T, x, y)=\psi(T, x, y) & \end{cases}
$$

2. Show that the discounted price function $\tilde{P}$ is equal to the solution of (2.3) where $\psi$ is replaced by $\tilde{\psi}(t, x, y)=e^{-r t} \psi(t, x, y)$.

We will follow this program providing a variational formulation of system (2.3).

### 2.2.2 Weighted Sobolev spaces and bilinear form associated with the Heston operator

We consider the measure first introduced in (5]:

$$
\mathfrak{m}_{\gamma, \mu}(d x, d y)=y^{\beta-1} e^{-\gamma|x|-\mu y} d x d y
$$

with $\gamma>0, \mu>0$ and $\beta:=\frac{2 \kappa \theta}{\sigma^{2}}$. It will be clear later on that this measure in some sense describes the qualitative behaviour of the process $(X, Y)$ near the degenerate boundary. For $u \in \mathbb{R}^{n}$ we denote by $|u|$ the standard euclidean norm of $u$ in $\mathbb{R}^{n}$. The relevant Sobolev spaces are defined as follows (see [5]).

Definition 2.1. For every $p \geq 1$ let $L^{p}\left(\mathcal{O}, \mathfrak{m}_{\gamma, \mu}\right)$ be the space of all measurable functions $u: \mathcal{O} \rightarrow \mathbb{R}$ for which

$$
\|u\|_{L^{p}\left(\mathcal{O}, \mathfrak{m}_{\gamma, \mu}\right)}^{p}:=\int_{\mathcal{O}}|u|^{p} d \mathfrak{m}_{\gamma, \mu}<\infty
$$

and denote $H^{0}\left(\mathcal{O}, \mathfrak{m}_{\gamma, \mu}\right):=L^{2}\left(\mathcal{O}, \mathfrak{m}_{\gamma, \mu}\right)$.

1. If $\nabla u:=\left(u_{x}, u_{y}\right)$ and $u_{x}, u_{y}$ are defined in the sense of distributions, we set

H^{1}\left(\mathcal{O}, \mathfrak{m}_{\gamma, \mu}\right):=\left\{u \in L^{2}\left(\mathcal{O}, \mathfrak{m}_{\gamma, \mu}\right): \sqrt{1+y} u \text { and } \sqrt{y}|\nabla u| \in L^{2}\left(\mathcal{O}, \mathfrak{m}_{\gamma, \mu}\right)\right\}
$$

and

$$
\|u\|_{H^{1}\left(\mathcal{O}, \mathfrak{m}_{\gamma, \mu}\right)}^{2}:=\int_{\mathcal{O}}\left(y|\nabla u|^{2}+(1+y) u^{2}\right) d \mathfrak{m}_{\gamma, \mu}
$$

2. If $D^{2} u:=\left(u_{x x}, u_{x y}, u_{y x}, u_{y y}\right)$ and all derivatives of $u$ are defined in the sense of distributions, we set

H^{2}\left(\mathcal{O}, \mathfrak{m}_{\gamma, \mu}\right):=\left\{u \in L^{2}\left(\mathcal{O}, \mathfrak{m}_{\gamma, \mu}\right): \sqrt{1+y} u,(1+y)|\nabla u|, y\left|D^{2} u\right| \in L^{2}\left(\mathcal{O}, \mathfrak{m}_{\gamma, \mu}\right)\right\}
$$

and

$$
\|u\|_{H^{2}\left(\mathcal{O}, \mathfrak{m}_{\gamma, \mu}\right)}^{2}:=\int_{\mathcal{O}}\left(y^{2}\left|D^{2} u\right|^{2}+(1+y)^{2}|\nabla u|^{2}+(1+y) u^{2}\right) d \mathfrak{m}_{\gamma, \mu}
$$

For brevity and when the context is clear, we shall often denote

$$
H:=H^{0}\left(\mathcal{O}, \mathfrak{m}_{\gamma, \mu}\right), \quad V:=H^{1}\left(\mathcal{O}, \mathfrak{m}_{\gamma, \mu}\right)
$$

and

$$
\|u\|_{H}:=\|u\|_{L^{2}\left(\mathcal{O}, \mathfrak{m}_{\gamma, \mu}\right)}, \quad\|u\|_{V}:=\|u\|_{H^{1}\left(\mathcal{O}, \mathfrak{m}_{\gamma, \mu}\right)}

Note that the spaces $H^{k}\left(\mathcal{O}, \mathfrak{m}_{\gamma, \mu}\right)$, for $k=0,1,2$ are Hilbert spaces with the inner products

and

(u, v)_{H^{2}\left(\mathcal{O}, \mathfrak{m}_{\gamma, \mu}\right)}:=\int_{\mathcal{O}}\left(y^{2}\left(D^{2} u, D^{2} v\right)+(1+y)^{2}(\nabla u, \nabla v)+(1+y) u v\right) d \mathfrak{m}_{\gamma, \mu}
$$

where $(\cdot, \cdot)$ denotes the standard scalar product in $\mathbb{R}^{n}$. Moreover, note that

$$
H^{2}\left(\mathcal{O}, \mathfrak{m}_{\gamma, \mu}\right) \subset H^{1}\left(\mathcal{O}, \mathfrak{m}_{\gamma, \mu}\right)
$$

We can now introduce the bilinear form associated with the differential operator $\mathcal{L}$.
Definition 2.2. For any $u, v \in H^{1}\left(\mathcal{O}, \mathfrak{m}_{\gamma, \mu}\right)$ we define the bilinear form

\begin{aligned}
a_{\gamma, \mu}(u, v)= & \frac{1}{2} \int_{\mathcal{O}} y\left(u_{x} v_{x}(x, y)+\rho \sigma u_{x} v_{y}(x, y)+\rho \sigma u_{y} v_{x}(x, y)+\sigma^{2} u_{y} v_{y}(x, y)\right) d \mathfrak{m}_{\gamma, \mu} \\
& +\int_{\mathcal{O}} y\left(j_{\gamma, \mu}(x) u_{x}(x, y)+k_{\gamma, \mu}(x) u_{y}(x, y)\right) v(x, y) d \mathfrak{m}_{\gamma, \mu}
\end{aligned}
$$

where

$$
j_{\gamma, \mu}=\frac{1}{2}(1-\gamma \operatorname{sgn}(x)-\mu \rho \sigma), \quad k_{\gamma, \mu}=\kappa-\frac{\gamma \rho \sigma}{2} \operatorname{sgn}(x)-\frac{\mu \sigma^{2}}{2}
$$

We will prove that for every $u \in H^{2}(\mathcal{O}, \mathfrak{m})$ and for every $v \in H^{1}(\mathcal{O}, \mathfrak{m})$, we have

$$
(\mathcal{L} u, v)_{H}=-a_{\gamma, \mu}(u, v)
$$

In order to simplify the notation, from now on we fix $\gamma$ and $\mu$ and we write $\mathfrak{m}$ and $a$ instead of $\mathfrak{m}_{\gamma, \mu}$ and $a_{\gamma, \mu}$.

### 2.3 Variational formulation of the American price

Fix $T>0$. We consider an assumption on the payoff function $\psi$ which will be crucial in the discussion of the penalized problem.
Assumption $\mathcal{H}^{1}$. We say that a function $\psi$ satisfies Assumption $\mathcal{H}^{1}$ if $\psi \in \mathcal{C}([0, T] ; H), \sqrt{1+y} \psi \in L^{2}([0, T] ; V)$, $\psi(T) \in V$ and there exists $\Psi \in L^{2}([0, T] ; V)$ such that $\left|\frac{\partial \psi}{\partial t}\right| \leq \Psi$.

We will also need a domination condition on $\psi$ by a function $\Phi$ which satisfies the following assumption.
Assumption $\mathcal{H}^{2}$. We say that a function $\Phi \in L^{2}\left([0, T] ; H^{2}(\mathcal{O}, \mathfrak{m})\right)$ satisfies Assumption $\mathcal{H}^{2}$ if $(1+y)^{\frac{3}{2}} \Phi \in$ $L^{2}([0, T] ; H), \frac{\partial \Phi}{\partial t}+\mathcal{L} \Phi \leq 0$ and $\sqrt{1+y} \Phi \in L^{\infty}\left([0, T] ; L^{2}\left(\mathcal{O}, \mathfrak{m}_{\gamma, \mu^{\prime}}\right)\right)$ for some $0<\mu^{\prime}<\mu$.

The domination condition is needed to deal with the lack of corercivity of the bilinear form associated with our problem. Similar conditions are also used in [5].

The first step in the variational formulation of the problem is to introduce the associated variational inequality and to prove the following existence and uniqueness result.

Theorem 2.3. Assume that $\psi$ satisfies Assumption $\mathcal{H}^{1}$ together with $0 \leq \psi \leq \Phi$, where $\Phi$ satisfies Assumption $\mathcal{H}^{2}$. Then, there exists a unique function $u$ such that $u \in \mathcal{C}([0, T] ; H) \cap L^{2}([0, T] ; V), \frac{\partial u}{\partial t} \in L^{2}([0, T] ; H)$ and

$$
\left\{\begin{array}{l}
-\left(\frac{\partial u}{\partial t}, v-u\right)_{H}+a(u, v-u) \geq 0, \quad \text { a.e. in }[0, T] \quad v \in V, v \geq \psi  \tag{2.4}\\
u \geq \psi \text { a.e. in }[0, T] \times \mathbb{R} \times(0, \infty) \\
u(T)=\psi(T) \\
0 \leq u \leq \Phi
\end{array}\right.
$$

The proof is presented in Section 3 and essentially relies on the penalization technique introduced by Bensoussan and Lions (see also [8]) with some technical devices due to the degenerate nature of the problem. We extend in the parabolic framework the results obtained in [5] for the elliptic case.

The second step is to identify the unique solution of the variational inequality (2.4) as the solution of the optimal stopping problem, that is the (discounted) American option price.

Recall that an adapted right continuous process $\left(Z_{t}\right)_{t \geq 0}$ is said to be of class $\mathcal{D}$ if the family $\left(Z_{\tau}\right)_{\tau \in \mathcal{T}_{0, \infty}}$, where $\mathcal{T}_{0, \infty}$ is the set of all stopping times with values in $[0, \infty)$, is uniformly integrable. We introduce the following further assumption:

Assumption $\mathcal{H}^{*}$. We say that a function $\Phi:[0, T] \times \mathbb{R} \times[0, \infty) \rightarrow \mathbb{R}$ satisfies Assumption $\mathcal{H}^{*}$ if $\Phi$ is continuous and, for all $(t, x, y) \in[0, T] \times \mathbb{R} \times[0, \infty)$, the process $\left(\Phi\left(t+s, X_{s}^{t, x, y}, Y_{s}^{t, y}\right)\right)_{s \in[0, T-t]}$ is of class $\mathcal{D}$.

Assumption $\mathcal{H}^{*}$ is crucial in order to get the following identification result.
Theorem 2.4. Fix $p>\beta+\frac{5}{2}$. Assume that, in addition to the assumptions of Theorem 2.3, there exists a sequence $\left(\psi_{n}\right)_{n \in \mathbb{N}}$ of continuous functions on $[0, T] \times \mathbb{R} \times[0, \infty)$ which converges uniformly to $\psi$ and satisfies the following properties for each $n \in \mathbb{N}$ :

1. $\psi_{n}$ satisfies Assumption $\mathcal{H}^{1}$ and $0 \leq \psi_{n} \leq \Phi_{n}$ for some $\Phi_{n}$ satisfying Assumption $\mathcal{H}^{2}$, Assumption $\mathcal{H}^{*}$ and $(1+y) \Phi_{n} \in L^{p}\left([0, T] ; L^{p}(\mathcal{O}, \mathfrak{m})\right)$;
2. $\psi_{n} \in L^{2}\left([0, T], H^{2}(\mathcal{O}, \mathfrak{m})\right)$ and $\frac{\partial \psi_{n}}{\partial t}+\mathcal{L} \psi_{n} \in L^{p}\left([0, T] ; L^{p}(\mathcal{O}, \mathfrak{m})\right)$.

Then, the solution $u$ of the variational inequality (2.4) associated with $\psi$ is continuous and coincides with the function $u^{*}$ defined by

$$
u^{*}(t, x, y)=\sup _{\tau \in \mathcal{T}_{t, T}} \mathbb{E}\left[\psi\left(\tau, X_{\tau}^{t, x, y}, Y_{\tau}^{t, x, y}\right)\right]
$$

We conclude this overview with a natural remark. The assumptions on $\psi$ in Theorem 2.3 and Theorem 2.4 seem to be very stringent but we will see that, by choosing $\gamma$ large enough, they are satisfied by the class of payoff functions $\psi=\psi(t, x)=e^{-r t} \bar{\psi}(x+\bar{c} t)$, where $\bar{c}=r-\delta-\frac{\rho \kappa \theta}{\sigma}$ as defined in (2.1), $\bar{\psi}$ is continuous, positive and such that

$$
|\bar{\psi}|+\left|\bar{\psi}^{\prime}\right| \leq C\left(e^{x}+1\right)
$$

with $C>0$. Note that the standard call and put payoff functions fall into this category (see Remark 4.17).

## 3 Existence and uniqueness of solutions to the variational inequality

### 3.1 Integration by parts and energy estimates

The following result justifies the definition of the bilinear form $a$.
Proposition 3.1. If $u \in H^{2}(\mathcal{O}, \mathfrak{m})$ and $v \in H^{1}(\mathcal{O}, \mathfrak{m})$, we have

$$
\begin{equation*}
(\mathcal{L} u, v)_{H}=-a(u, v) \tag{3.1}
\end{equation*}
$$

Before proving Proposition [3.1, we show some preliminary results. The first one is about the standard regularization of a function by convolution.

Lemma 3.2. Let $\varphi: \mathbb{R} \times \mathbb{R} \rightarrow \mathbb{R}^{+}$be a $C^{\infty}$ function with compact support in $[-1,+1] \times[-1,0]$ and such that $\iint \varphi(x, y) d x d y=1$. For $j \in \mathbb{N}$ we set $\varphi_{j}(x, y)=j^{2} \varphi(j x, j y)$. Then, for every function $u$ locally squareintegrable on $\mathbb{R} \times(0, \infty)$ and for every compact set $K$, we have

$$
\lim _{j \rightarrow \infty} \iint_{K}\left(\varphi_{j} * u-u\right)^{2}(x, y) d x d y=0
$$

Proof. We first observe that

$$
\begin{aligned}
\iint_{K}\left(\varphi_{j} * u\right)^{2}(x, y) d x d y & \leq \iint_{K} d x d y \iint \varphi_{j}(\xi, \zeta) u^{2}(x-\xi, y-\zeta) d \xi d \zeta \\
& =\iint \varphi_{j}(\xi, \zeta) d \xi d \zeta \iint 1_{K}(x+\xi, y+\zeta) u^{2}(x, y) d x d y
\end{aligned}
$$

We deduce, for $j$ large enough,

$$
\iint_{K}\left(\varphi_{j} * u\right)^{2}(x, y) d x d y \leq \iint_{\bar{K}} u^{2}(x, y) d x d y
$$

where $\bar{K}=\left\{(x, y) \in \mathcal{O} \left\lvert\, d_{\infty}((x, y), K) \leq \frac{1}{j}\right.\right\}$. Let $\epsilon$ be a positive constant and $v$ be a continuous function such that $\iint_{\bar{K}}(u(x, y)-v(x, y))^{2} d x d y \leq \epsilon$. We have

$$
\begin{aligned}
& \iint_{K}\left(\varphi_{j} * u-u\right)^{2}(x, y) d x d y \\
& \leq 3 \iint_{K}\left(\varphi_{j} * u-\varphi_{j} * v\right)^{2}(x, y) d x d y+3 \iint_{K}\left(\varphi_{j} * v-v\right)^{2}(x, y) d x d y+3 \iint_{K}(v-u)^{2}(x, y) d x d y \\
& \quad \leq 3 \iint_{\bar{K}}(v-u)^{2}(x, y) d x d y+3 \iint_{K}\left(\varphi_{j} * v-v\right)^{2}(x, y) d x d y+3 \iint_{\bar{K}}(v-u)^{2}(x, y) d x d y \\
& \quad \leq 6 \epsilon+3 \iint_{K}\left(\varphi_{j} * v-v\right)^{2}(x, y) d x d y
\end{aligned}
$$

Since $v$ is continuous, we have $\left|\varphi_{j} * v\right| \leq \sup _{x, y \in \bar{K}}|v(x, y)|$ and $\varphi_{j} * v(x, y) \rightarrow v(x, y)$ on $K$. Therefore, by Lebesgue Theorem, we can pass to the limit in the above inequality and we get

$$
\limsup _{j \rightarrow \infty} \iint_{K}\left(\varphi_{j} * u-u\right)^{2}(x, y) d x d y \leq 6 \epsilon
$$

which completes the proof.
Then, the following two propositions justify the integration by parts formulas with respect to the measure $\mathfrak{m}$.

Proposition 3.3. Let us consider $u, v: \mathcal{O} \rightarrow \mathbb{R}$ locally square-integrable on $\mathcal{O}$, with derivatives $u_{x}$ and $v_{x}$ locally square-integrable on $\mathcal{O}$ as well. Moreover, assume that

$$
\int_{\mathcal{O}}\left(\left|u_{x}(x, y) v(x, y)\right|+\left|u(x, y) v_{x}(x, y)\right|+|u(x, y) v(x, y)|\right) d \mathfrak{m}<\infty
$$

Then, we have

$$
\begin{equation*}
\int_{\mathcal{O}} u_{x}(x, y) v(x, y) d \mathfrak{m}=-\int_{\mathcal{O}} u(x, y)\left(v_{x}(x, y)-\gamma \operatorname{sgn}(x) v\right) d \mathfrak{m} \tag{3.2}
\end{equation*}
$$

Proof. First we assume that $v$ has compact support in $\mathbb{R} \times(0, \infty)$. For any $j \in \mathbb{N}$ we consider the $C^{\infty}$ functions $u_{j}=\varphi_{j} * u$ and $v_{j}=\varphi_{j} * v$, with $\varphi_{j}$ as in Lemma 3.2 Note that supp $v_{j} \subset \operatorname{supp} g+\operatorname{supp} \varphi_{j}$ and so, for $j$ large enough, supp $v_{j} \subset \mathbb{R} \times(0, \infty)$. For any $\epsilon>0$, integrating by parts, we have

$$
\int_{-\infty}^{\infty}\left(u_{j}\right)_{x}(x, y) v_{j}(x, y) e^{-\gamma \sqrt{x^{2}+\epsilon}} d x=-\int_{-\infty}^{\infty} u_{j}\left(\left(v_{j}\right)_{x}(x, y)-\gamma \frac{x}{\sqrt{x^{2}+\epsilon}} v_{j}(x, y)\right) e^{-\gamma \sqrt{x^{2}+\epsilon}} d x
$$

and, letting $\epsilon \rightarrow 0$,

$$
\int_{-\infty}^{\infty}\left(u_{j}\right)_{x}(x, y) v_{j}(x, y) e^{-\gamma|x|} d x=-\int_{-\infty}^{\infty} u_{j}\left(\left(v_{j}\right)_{x}(x, y)-\gamma \operatorname{sgn}(x) v_{j}(x, y)\right) e^{-\gamma|x|} d x
$$

Multiplying by $y^{\beta-1} e^{-\mu y}$ and integrating in $y$ we obtain

$$
\int_{\mathcal{O}}\left(u_{j}\right)_{x}(x, y) v_{j}(x, y) d \mathfrak{m}=-\int_{\mathcal{O}} u_{j}\left(\left(v_{j}\right)_{x}(x, y)-\gamma \operatorname{sgn}(x) v_{j}(x, y)\right) d \mathfrak{m}
$$

Recall that, for $j$ large enough, $v_{j}$ has compact support in $\mathbb{R} \times(0, \infty)$ and $\mathfrak{m}$ is bounded on this compact. By using Lemma 3.2, letting $j \rightarrow \infty$ we get

$$
\int_{\mathcal{O}} u_{x}(x, y) v(x, y) d \mathfrak{m}=-\int_{\mathcal{O}} u\left(v_{x}(x, y)-\gamma \operatorname{sgn}(x) v(x, y) d \mathfrak{m}\right.
$$

Now let us consider the general case of a function $v$ without compact support. We introduce a $C^{\infty}$-function $\alpha$ with values in $[0,1], \alpha(x, y)=0$ for all $(x, y) \notin[-2,+2] \times[-2,+2], \alpha(x, y)=1$ for all $(x, y) \in[-1,+1] \times[-1,+1]$ and a $C^{\infty}$-function $\chi$ with values in $[0,1], \chi(y)=0$ for all $y \in\left[0, \frac{1}{2}\right], \chi(y)=1$ for all $y \in[+1, \infty)$. We set

$$
A_{j}(x, y)=\alpha\left(\frac{x}{j}, \frac{y}{j}\right) \chi(j y), \quad j \in \mathbb{N} .
$$

For every $j \in \mathbb{N}, A_{j}$ has compact support in $\mathcal{O}$ and we have

$$
\begin{gathered}
\int_{\mathcal{O}} u_{x}(x, y) A_{j}(x, y) v(x, y) d \mathfrak{m} \\
=-\int_{\mathcal{O}} u(x, y)\left(u_{x}(x, y)-\gamma \operatorname{sgn}(x) v(x, y)\right) A_{j}(x, y) d \mathfrak{m}-\int_{\mathcal{O}} u(x, y) v(x, y)\left(A_{j}\right)_{x}(x, y) d \mathfrak{m} .
\end{gathered}
$$

The function $A_{j}$ is bounded by $\|\alpha\|_{\infty}\|\chi\|_{\infty}$ and $\lim _{j \rightarrow+\infty} A_{j}(x, y)=1$ for every $(x, y) \in \mathcal{O}$. Moreover $\left(A_{j}\right)_{x}(x, y)=\frac{1}{j} \alpha_{x}\left(\frac{x}{j}, \frac{y}{j}\right) \chi(j y)$, so that

$$
\left|\int_{\mathcal{O}} u(x, y) v(x, y)\left(A_{j}\right)_{x}(x, y) d \mathfrak{m}\right| \leq \frac{C}{j} \int_{\mathcal{O}} 1_{\{|x| \geq j\}}|u(x, y) v(x, y)| d \mathfrak{m}
$$

where $C=\left\|\alpha_{x}\right\|_{\infty}\|\chi\|_{\infty}$. Therefore, we obtain (3.2) letting $j \rightarrow \infty$.
Proposition 3.4. Let us consider $u, v: \mathcal{O} \rightarrow \mathbb{R}$ locally square-integrable on $\mathcal{O}$, with derivatives $u_{y}$ and $v_{y}$ locally square-integrable on $\mathcal{O}$ as well. Moreover, assume that

$$
\int_{\mathcal{O}} y\left(\left|u_{y}(x, y) v(x, y)\right|+\left|u(x, y) v_{x} y(x, y)\right|\right)+|u(x, y) v(x, y)| d \mathfrak{m}<\infty
$$

Then, we have

$$
\begin{equation*}
\int_{\mathcal{O}} y u_{y}(x, y) v(x, y) d \mathfrak{m}=-\int_{\mathcal{O}} y u(x, y) v_{y} d \mathfrak{m}-\int_{\mathcal{O}}(\beta-\mu y) u(x, y) v(x, y) d \mathfrak{m} \tag{3.3}
\end{equation*}
$$

Proof. If $v$ has compact support in $\mathcal{O}$, we obtain (3.3) as in the proof of Proposition 3.3. On the other hand, if $v$ has not compact support,

$$
\begin{aligned}
\int_{\mathcal{O}} y u_{y}(x, y) & v(x, y) A_{j}(x, y) d \mathfrak{m}=-\int_{\mathcal{O}} y u(x, y) v_{y}(x, y) A_{j}(x, y) d \mathfrak{m} \\
& -\int_{\mathcal{O}}(\beta-\mu y) u(x, y) v(x, y) A_{j}(x, y) d \mathfrak{m}-\int_{\mathcal{O}} y u(x, y) v(x, y)\left(A_{j}\right)_{y}(x, y) d \mathfrak{m}
\end{aligned}
$$

where $A_{j}(x, y)=\alpha\left(\frac{x}{j}, \frac{y}{j}\right) \chi(j y)$, as in the proof of Proposition 3.3 but choosing $\chi$ such that, moreover, $\left\|y \chi^{\prime}(y)\right\|_{\infty}<$ $\infty$. We have $\left(A_{j}\right)_{y}(x, y)=\frac{1}{j} \alpha_{y}\left(\frac{x}{j}, \frac{y}{j}\right) \chi(j y)+j \alpha\left(\frac{x}{j}, \frac{y}{j}\right) \chi^{\prime}(j y)$. Note that

$$
\left|\int_{\mathcal{O}} y u(x, y) v(x, y) j \alpha\left(\frac{x}{j}, \frac{y}{j}\right) \chi^{\prime}(j y) d \mathfrak{m}\right| \leq \int_{\mathcal{O}} 1_{y \leq \frac{1}{j}}|u(x, y) v(x, y)|\|\alpha\|_{\infty} \sup _{\zeta>0}\left|\zeta \chi^{\prime}(\zeta)\right| d \mathfrak{m}
$$

The last expression goes to 0 as $j \rightarrow \infty$ since $\int_{\mathcal{O}}|u(x, y) v(x, y)| d \mathfrak{m}<\infty$. The assertion follows by passing to the limit $j \rightarrow \infty$.

We can now prove Proposition 3.1.
Proof of Proposition 3.1. By using Proposition 3.3 and Proposition 3.4 we have

$$
\begin{gathered}
\int_{\mathcal{O}} y \frac{\partial^{2} u}{\partial x^{2}} v d \mathfrak{m}=-\int_{\mathcal{O}} y \frac{\partial u}{\partial x}\left(\frac{\partial v}{\partial x}-\gamma \operatorname{sgn}(x) v\right) d \mathfrak{m} \\
\int_{\mathcal{O}} y \frac{\partial^{2} u}{\partial y^{2}} v d \mathfrak{m}=-\int_{\mathcal{O}} y \frac{\partial u}{\partial y} \frac{\partial v}{\partial y} d \mathfrak{m}_{\gamma, \mu}+\int_{\mathcal{O}}(\mu y-\beta) \frac{\partial u}{\partial y} v d \mathfrak{m} \\
\int_{\mathcal{O}} y \frac{\partial^{2} u}{\partial x \partial y} v d \mathfrak{m}_{\gamma, \mu}=-\int_{\mathcal{O}} y \frac{\partial u}{\partial y}\left(\frac{\partial v}{\partial x}-\gamma \operatorname{sgn}(x) v\right) d \mathfrak{m}
\end{gathered}
$$

and

$$
\int_{\mathcal{O}} y \frac{\partial^{2} u}{\partial x \partial y} v d \mathfrak{m}_{\gamma, \mu}=-\int_{\mathcal{O}} y \frac{\partial u}{\partial x} \frac{\partial v}{\partial y} d \mathfrak{m}+\int_{\mathcal{O}}(\mu y-\beta) \frac{\partial u}{\partial x} v d \mathfrak{m}
$$

Recalling that

$$
\mathcal{L}=\frac{y}{2}\left(\frac{\partial^{2}}{\partial x^{2}}+2 \rho \sigma \frac{\partial^{2}}{\partial x \partial y}+\sigma^{2} \frac{\partial^{2}}{\partial y^{2}}\right)+\left(\frac{\rho \kappa \theta}{\sigma}-\frac{y}{2}\right) \frac{\partial}{\partial x}+\kappa(\theta-y) \frac{\partial}{\partial y}
$$

and using the equality $\beta=2 \kappa \theta / \sigma^{2}$, we have

$$
\begin{aligned}
(\mathcal{L} u, v)_{H}= & -\int_{\mathcal{O}} \frac{y}{2}\left(\frac{\partial u}{\partial x} \frac{\partial v}{\partial x}+\sigma^{2} \frac{\partial u}{\partial y} \frac{\partial v}{\partial y}+\rho \sigma \frac{\partial u}{\partial x} \frac{\partial v}{\partial y}+\rho \sigma \frac{\partial u}{\partial y} \frac{\partial v}{\partial x}\right) d \mathfrak{m} \\
& +\int_{\mathcal{O}} \frac{1}{2} \frac{\partial u}{\partial x}(y \gamma \operatorname{sgn}(x)+\rho \sigma(\mu y-\beta)) v d \mathfrak{m} \\
& +\int_{\mathcal{O}} \frac{1}{2} \frac{\partial u}{\partial y}\left(\mu \sigma^{2} y-\beta \sigma^{2}+\rho \sigma y \gamma \operatorname{sgn}(x)\right) v d \mathfrak{m} \\
& +\int_{\mathcal{O}}\left[\left(\frac{\rho \kappa \theta}{\sigma}-\frac{y}{2}\right) \frac{\partial u}{\partial x}+\kappa(\theta-y) \frac{\partial u}{\partial y}\right] v d \mathfrak{m} \\
& =-a(u, v)
\end{aligned}
$$

Remark 3.5. It is now clear why we have considered the process $X_{t}=\log S_{t}-\bar{c} t$ instead of the standard logprice process $\log S_{t}$. Actually, the choice of $\bar{c}$ allows to avoid terms of the type $\int\left(u_{x}+u_{y}\right) d \mathfrak{m}$ in the associated bilinear form $a$. This trick will be crucial in order to obtain suitable energy estimates.

Recall the well known inequality

$$
\begin{equation*}
b c=(\sqrt{\zeta} b)\left(\frac{1}{\sqrt{\zeta} c}\right) \leq \frac{\zeta}{2} b^{2}+\frac{1}{2 \zeta} c^{2}, \quad b, c \in \mathbb{R}, \zeta>0 \tag{3.4}
\end{equation*}
$$

Hereafter we will often apply (3.4) in the proofs even if it is not explicitly recalled each time.

Proposition 3.6. For every $u, v \in V$, the bilinear form $a(\cdot, \cdot)$ satisfies

\begin{gather*}
|a(u, v)| \leq C_{1}\|u\|_{V}\|v\|_{V}  \tag{3.5}\\
a(u, u) \geq C_{2}\|u\|_{V}^{2}-C_{3}\left\|(1+y)^{\frac{1}{2}} u\right\|_{H}^{2} \tag{3.6}
\end{gather*}
$$

where

$$
C_{1}=\delta_{0}+K_{1}, \quad C_{2}=\frac{\delta_{1}}{2}, \quad C_{3}=\frac{\delta_{1}}{2}+\frac{K_{1}^{2}}{2 \delta_{1}}
$$

with

$$
\begin{gather*}
\delta_{0}=\sup _{s_{1}^{2}+t_{1}^{2}>0, s_{2}^{2}+t_{2}^{2}>0} \frac{\left|s_{1} s_{2}+\rho \sigma s_{1} t_{2}+\rho \sigma s_{2} t_{1}+\sigma^{2} t_{1} t_{2}\right|}{2 \sqrt{\left(s_{1}^{2}+t_{1}^{2}\right)\left(s_{2}^{2}+t_{2}^{2}\right)}}  \tag{3.7}\\
\delta_{1}=\inf _{s^{2}+t^{2}>0} \frac{s^{2}+2 \rho \sigma s t+\sigma^{2} t^{2}}{2\left(s^{2}+t^{2}\right)} \tag{3.8}
\end{gather*}
$$

and

$$
\begin{equation*}
K_{1}=\sup _{(x, y) \in \mathbb{R} \times] 0,+\infty[ } \sqrt{j_{\gamma, \mu}^{2}(x, y)+k_{\gamma, \mu}^{2}(x, y)} \tag{3.9}
\end{equation*}
$$

Proof. Recall that

$$
\begin{aligned}
a(u, v)= & \frac{1}{2} \int_{\mathcal{O}} y\left(u_{x} v_{x}+\rho \sigma u_{x} v_{y}+\rho \sigma u_{y} v_{x}+\sigma^{2} u_{y} v_{y}\right) d \mathfrak{m} \\
& +\int_{\mathcal{O}} y\left(j_{\gamma, \mu}(x) u_{x}(x, y)+k_{\gamma, \mu}(x) u_{y}(x, y)\right) v(x, y) d \mathfrak{m}
\end{aligned}
$$

We can easily see that

$$
\left|\frac{1}{2} \int_{\mathcal{O}} y\left(u_{x} v_{x}+\rho \sigma u_{x} v_{y}+\rho \sigma u_{y} v_{x}+\sigma^{2} u_{y} v_{y}\right) d \mathfrak{m}\right| \leq \delta_{0} \int_{\mathcal{O}} y\left|\nabla u\left\|\nabla v \mid d \mathfrak{m} \leq \delta_{0}\right\| u\left\|_{V}\right\| v \|_{V}\right.
$$

and

$$
\left|\int_{\mathcal{O}} y\left(j_{\gamma, \mu}(x) u_{x}(x, y)+k_{\gamma, \mu}(x) u_{y}(x, y)\right) v(x, y) d \mathfrak{m}\right| \leq K_{1} \int_{\mathcal{O}} y\left|\nabla u\left\|v \mid d \mathfrak{m} \leq K_{1}\right\| u\left\|_{V}\right\| v \|_{V}\right.
$$

Then (3.5) immediately follows. In order to prove (3.6), we note that

$$
\frac{1}{2} \int_{\mathcal{O}} y\left(u_{x} v_{x}+\rho \sigma u_{x} v_{y}+\rho \sigma u_{y} v_{x}+\sigma^{2} u_{y} v_{y}\right) d \mathfrak{m} \geq \delta_{1} \int_{\mathcal{O}} y|\nabla u|^{2} d \mathfrak{m}
$$

Therefore

$$
\begin{aligned}
a(u, u) & \geq \delta_{1} \int_{\mathcal{O}} y|\nabla u|^{2} d \mathfrak{m}-K_{1} \int_{\mathcal{O}} y|\nabla u||u| d \mathfrak{m} \\
& \geq \delta_{1} \int_{\mathcal{O}} y|\nabla u|^{2} d \mathfrak{m}-\frac{K_{1} \zeta}{2} \int_{\mathcal{O}} y|\nabla u|^{2} d \mathfrak{m}-\frac{K_{1}}{2 \zeta} \int_{\mathcal{O}}(1+y) u^{2} d \mathfrak{m} \\
& =\left(\delta_{1}-\frac{K_{1} \zeta}{2}\right) \int_{\mathcal{O}}\left(y|\nabla u|^{2}+(1+y) u^{2}\right) d \mathfrak{m}-\left(\delta_{1}-\frac{K_{1} \zeta}{2}+\frac{K_{1}}{2 \zeta}\right) \int_{\mathcal{O}}(1+y) u^{2} d \mathfrak{m}
\end{aligned}
$$

Choosing $\zeta=\delta_{1} / K_{1}$ we have

$$
a(u, u) \geq \frac{\delta_{1}}{2}\|u\|_{V}^{2}-\left(\frac{\delta_{1}}{2}+\frac{K_{1}^{2}}{2 \delta_{1}}\right)\|\sqrt{1+y} u\|_{H}^{2}
$$

and the assertion is proved.

### 3.2 Proof of Theorem 2.3

Among the standard assumptions required in (4] for the penalization procedure, there are the coercivity and the symmetry of the bilinear form $a$ and the boundedness of the coefficients. In the Heston-type models these assumptions are no longer satisfied and this leads to some technical difficulties. In order to overcome them, we introduce some auxiliary operators.

From now on, we set

$$
a(u, v)=\bar{a}(u, v)+\tilde{a}(u, v)
$$

where

$$
\begin{aligned}
\bar{a}(u, v) & =\int_{\mathcal{O}} \frac{y}{2}\left(\frac{\partial u}{\partial x} \frac{\partial v}{\partial x}+\rho \sigma \frac{\partial u}{\partial x} \frac{\partial v}{\partial y}+\rho \sigma \frac{\partial u}{\partial y} \frac{\partial v}{\partial x}+\sigma^{2} \frac{\partial u}{\partial y} \frac{\partial v}{\partial y}\right) d \mathfrak{m} \\
\tilde{a}(u, v) & =\int_{\mathcal{O}} y \frac{\partial u}{\partial x} j_{\gamma, \mu} v d \mathfrak{m}+\int_{\mathcal{O}} y \frac{\partial u}{\partial y} k_{\gamma, \mu} v d \mathfrak{m}
\end{aligned}
$$

Note that $\bar{a}$ is symmetric. We have, for every $u, v \in V$,

$$
\begin{aligned}
|\bar{a}(u, v)| & \leq \delta_{0} \int_{\mathcal{O}} y|\nabla u||\nabla v| d \mathfrak{m} \\
\bar{a}(u, u) & \geq \delta_{1} \int_{\mathcal{O}} y|\nabla u|^{2} d \mathfrak{m}
\end{aligned}
$$

and

$$
|\tilde{a}(u, v)| \leq K_{1} \int_{\mathcal{O}} y|\nabla u||v| d \mathfrak{m}
$$

with $\delta_{0}, \delta_{1}$ and $K_{1}$ defined in Proposition 3.6. Then, we introduce for $\lambda \geq 0$ and $M>0$,

\begin{aligned}
a_{\lambda}(u, v) & =a(u, v)+\lambda \int_{\mathcal{O}}(1+y) u v d \mathfrak{m} \\
\bar{a}_{\lambda}(u, v) & =\bar{a}(u, v)+\lambda \int_{\mathcal{O}}(1+y) u v d \mathfrak{m} \\
\tilde{a}^{(M)}(u, v) & =\int_{\mathcal{O}} y \wedge M\left(\frac{\partial u}{\partial x} j_{\gamma, \mu}+\frac{\partial u}{\partial y} k_{\gamma, \mu}\right) v d \mathfrak{m}
\end{aligned}
$$

and

$$
a_{\lambda}^{(M)}(u, v)=\bar{a}_{\lambda}(u, v)+\tilde{a}^{(M)}(u, v)
$$

Lemma 3.7. Let $\delta_{0}, \delta_{1}, K_{1}$ be defined as in (3.7), (3.8) and (3.9) respectively. For any fixed $\lambda \geq \frac{\delta_{1}}{2}+\frac{K_{1}^{2}}{2 \delta_{1}}$ the bilinear forms $a_{\lambda}$ and $a_{\lambda}^{(M)}$ are continuous and coercive. More precisely, we have

\end{gather*}

and

\begin{align*}
&\left|a_{\lambda}^{(M)}(u, v)\right| \leq C\|u\|_{V}\|v\|_{V}, u, v \in V,  \tag{3.12}\\
& a_{\lambda}^{(M)}(u, u) \geq \frac{\delta_{1}}{2}\|v\|_{V}^{2}, \quad u \in V . \tag{3.13}
\end{align*}
$$

where $C=\delta_{0}+K_{1}+\lambda$.

Proof. Note that, for every $u, v \in V$,

& \leq \delta_{0} \int_{\mathcal{O}} y|\nabla u||\nabla v| d \mathfrak{m}+\lambda \int_{\mathcal{O}}(1+y)|u||v| d \mathfrak{m}+K_{1} \int_{\mathcal{O}} y|\nabla u \| v| d \mathfrak{m} \\
& \leq\left(\delta_{0}+\lambda+K_{1}\right)\|u\|_{V}\|v\|_{V} .
\end{aligned}
$$

On the other hand, for every $\zeta>0$,

\begin{aligned}
a_{\lambda}^{(M)}(u, u) & \geq \delta_{1} \int_{\mathcal{O}} y|\nabla u|^{2} d \mathfrak{m}+\lambda \int_{\mathcal{O}}(1+y) u^{2} d m_{\gamma, \mu}-K_{1} \int_{\mathcal{O}} y|\nabla u \| u| d \mathfrak{m} \\
& \geq\left(\delta_{1}-\frac{K_{1} \zeta}{2}\right) \int_{\mathcal{O}} y|\nabla u|^{2} d \mathfrak{m}+\left(\lambda-\frac{K_{1}}{2 \zeta}\right) \int_{\mathcal{O}}(1+y) u^{2} d \mathfrak{m} .
\end{aligned}
$$

By choosing $\zeta=\delta_{1} / K_{1}$, we get

We deduce that, if $\lambda \geq \frac{\delta_{1}}{2}+\frac{K_{1}^{2}}{2 \delta_{1}}$,

The same calculations hold for the bilinear form $a_{\lambda}$ and the assertion is proved.
Remark 3.8. Let $\|a\|=\sup _{u, v \in V, u, v \neq 0} \frac{|a(u, v)|}{\|u\|_{V}\|v\|_{V}}$ be the norm of a bilinear form $a: V \times V \rightarrow \mathbb{R}$. Then we stress that Lemma 3.7 gives us

From now on in the rest of this paper we assume $\lambda \geq \frac{\delta_{1}}{2}+\frac{K_{1}^{2}}{2 \delta_{1}}$ as in Lemma 3.7.
Finally, we define

### 3.2.1 Penalized problem

For any fixed $\varepsilon>0$ we define the penalizing operator

Since the function $x \mapsto-(\psi-x)_{+}$is nondecreasing, we easily get the following monotonicity result.
Lemma 3.9. The penalizing operator (3.14) is monotone, in the sense that

We now introduce the intermediate penalized coercive problem with a source term $g$. We consider the following assumption:

Assumption $\mathcal{H}^{0}$. We say that a function $g$ satisfies Assumption $\mathcal{H}^{0}$ if $\sqrt{1+y} g \in L^{2}([0, T] ; H)$.
Theorem 3.10. Assume that $\psi$ satisfies Assumption $\mathcal{H}^{1}$ and $g$ satisfies Assumption $\mathcal{H}^{0}$. Then, for every fixed $\varepsilon>0$, there exists a unique function $u_{\varepsilon, \lambda}$ such that $u_{\varepsilon, \lambda} \in \mathcal{C}([0, T] ; H) \cap L^{2}([0, T] ; V), \frac{\partial u_{\varepsilon, \lambda}}{\partial t} \in L^{2}([0, T] ; H)$ and

$$
\left\{\begin{array}{l}
-\left(\frac{\partial u_{\varepsilon, \lambda}}{\partial t}(t), v\right)_{H}+a_{\lambda}\left(u_{\varepsilon, \lambda}, v\right)+\left(\zeta_{\varepsilon}\left(u_{\varepsilon, \lambda}(t)\right), v\right)_{H}=(g(t), v)_{H}, \quad \text { a.e. in }[0, T], \quad v \in V,  \tag{3.15}\\
u_{\varepsilon, \lambda}(T)=\psi(T) .
\end{array}\right.
$$

Moreover, the following estimates hold:

\begin{gather*}
\left\|u_{\varepsilon, \lambda}\right\|_{L^{\infty}([0, T], V)} \leq K  \tag{3.16}\\
\left\|\frac{\partial u_{\varepsilon, \lambda}}{\partial t}\right\|_{L^{2}([0, T] ; H)} \leq K  \tag{3.17}\\
\frac{1}{\sqrt{\varepsilon}}\left\|\left(\psi-u_{\varepsilon, \lambda}\right)^{+}\right\|_{L^{\infty}([0, T], H)} \leq K \tag{3.18}
\end{gather*}
$$

where $K=C\left(\|\Psi\|_{L^{2}([0, T] ; V)}+\|\sqrt{1+y} g\|_{L^{2}([0, T] ; H)}+\|\sqrt{1+y} \psi\|_{L^{2}([0, T] ; V)}+\|\psi(T)\|_{V}^{2}\right)$, with $C>0$ independent of $\varepsilon$, and $\Psi$ is given in Assumption $\mathcal{H}^{1}$.

We first prove uniqueness of the penalized coercive problem.
Proof of Theorem 3.10; uniqueness. Assume that there exist two functions $u_{1}$ and $u_{2}$ satisfying (3.15) and set $w=u_{1}-u_{2}$. If we choose $v=u_{1}-u_{2}$ in the equation satisfied by $u_{1}$ and $v=u_{2}-u_{1}$ in the one satisfied by $u_{2}$ and then we add the resulting equations, we get

By the coercivity of $a_{\lambda}$ and the monotonicity of the penalized operator we deduce that

But $w(T)=\psi(T)-\psi(T)=0$, so $w(t)=0$ a.e. in $[0, T]$, which means $u_{1}=u_{2}$.
The proof of existence in Theorem 3.10 is quite long and technical, so we split it into two propositions. We first consider the truncated penalized problem, which requires less stringent conditions on $\psi$ and $g$.

Proposition 3.11. Let $\psi \in \mathcal{C}([0, T] ; H) \cap L^{2}([0, T] ; V)$ and $g \in L^{2}([0, T] ; H)$. Moreover, assume that $\psi(T) \in$ $H^{2}(\mathcal{O}, \mathfrak{m}), \frac{\partial \psi}{\partial t} \in L^{2}([0, T] ; V)$ and $\frac{\partial g}{\partial t} \in L^{2}([0, T] ; H)$. Then, there exists a unique function $u_{\varepsilon, \lambda, M}$ such that $u_{\varepsilon, \lambda, M} \in \mathcal{C}([0, T] ; V) \cup L^{2}([0, T] ; V), \frac{\partial u_{\varepsilon, \lambda, M}}{\partial t} \in L^{2}([0, T] ; V)$ and

$$
\left\{\begin{array}{l}
-\left(\frac{\partial u_{\varepsilon, \lambda, M}}{\partial t}(t), v\right)_{H}+a_{\lambda}^{(M)}\left(u_{\varepsilon, \lambda, M}(t), v\right)+\left(\zeta_{\varepsilon}\left(u_{\varepsilon, \lambda, M}\right)(t), v\right)_{H}=(g(t), v)_{H}, \quad \text { a.e. in }[0, T), \quad v \in V,  \tag{3.19}\\
u_{\varepsilon, \lambda, M}(T)=\psi(T) .
\end{array}\right.
$$

Proof. 1. Finite dimensional problem We use the classical Galerkin method of approximation, which consists in introducing a nondecreasing sequence $\left(V_{j}\right)_{j}$ of subspaces of $V$ such that $\operatorname{dim} V_{j}<\infty$ and, for every $v \in V$, there exists a sequence $\left(v_{j}\right)_{j \in \mathbb{N}}$ such that $v_{j} \in V_{j}$ for any $j \in \mathbb{N}$ and $\left\|v-v_{j}\right\|_{V} \rightarrow 0$ as $j \rightarrow \infty$. Moreover, we assume that $\psi(T) \in V_{j}$, for all $j \in \mathbb{N}$. Let $P_{j}$ be the projection of $V$ onto $V_{j}$
and $\psi_{j}(t)=P_{j} \psi(t)$. We have $\psi_{j}(t) \rightarrow \psi(t)$ strongly in $V$ and $\psi_{j}(T)=\psi(T)$ for any $j \in \mathbb{N}$. The finite dimensional problem is, therefore, to find $u_{j}:[0, T] \rightarrow V_{j}$ such that

-\left(\frac{\partial u_{j}}{\partial t}(t), v\right)_{H}+a_{\lambda}^{(M)}\left(u_{j}(t), v\right)-\frac{1}{\varepsilon}\left(\left(\psi_{j}(t)-u_{j}(t)\right)_{+}, v\right)_{H}=(g(t), v)_{H}, \quad v \in V_{j}  \tag{3.20}\\
u_{j}(T)=\psi(T)
\end{array}\right.
$$

This problem can be interpreted as an ordinary differential equation in $V_{j}\left(\operatorname{dim} V_{j}<\infty\right)$ and we can easily deduce the existence and the uniqueness of a solution $u_{j}$ of (3.20), continuous from $[0, T]$ into $V_{j}$, a.e. differentiable and with bounded derivatives.
2. Estimates on the finite dimensional problem First, we take $v=u_{j}(t)-\psi_{j}(t)$ in (3.20). We get

=\left(g(t), u_{j}(t)-\psi_{j}(t)\right)_{H}
\end{gathered}
$$

which can be rewritten as

-\frac{1}{2} & \frac{d}{d t}\left\|u_{j}(t)-\psi_{j}(t)\right\|_{H}^{2}-\left(\frac{\partial \psi_{j}}{\partial t}(t), u_{j}(t)-\psi_{j}(t)\right)_{H}+a_{\lambda}^{(M)}\left(u_{j}(t)-\psi_{j}(t), u_{j}(t)-\psi_{j}(t)\right)_{H} \\
& +\frac{1}{\varepsilon}\left(\left(\psi_{j}(t)-u_{j}(t)\right)_{+}, \psi_{j}(t)-u_{j}(t)\right)_{H}+a_{\lambda}^{(M)}\left(\psi_{j}(t), u_{j}(t)-\psi_{j}(t)\right)=\left(g(t), u_{j}(t)-\psi_{j}(t)\right)_{H}
\end{aligned}
$$

We integrate between $t$ and $T$ and we use coercivity and $u_{j}(T)=\psi_{j}(T)$ to obtain

$$
\begin{aligned}
& \frac{1}{2}\left\|u_{j}(t)-\psi_{j}(t)\right\|_{H}^{2}+\frac{\delta_{1}}{2} \int_{t}^{T}\left\|u_{j}(s)-\psi_{j}(s)\right\|_{V}^{2} d s+\frac{1}{\varepsilon} \int_{t}^{T}\left\|\left(\psi_{j}(s)-u_{j}(s)\right)_{+}\right\|_{H}^{2} d s \\
& \leq \int_{t}^{T}\left\|\frac{\partial \psi_{j}(s)}{\partial t}\right\|_{H}\left\|u_{j}(s)-\psi_{j}(s)\right\|_{H} d s+\int_{t}^{T}\|g(s)\|_{H}\left\|u_{j}(s)-\psi_{j}(s)\right\|_{H} d s \\
& \quad+\left\|a_{\lambda}^{(M)}\right\| \int_{t}^{T}\left\|\psi_{j}(s)\right\|_{V}\left\|u_{j}(s)-\psi_{j}(s)\right\|_{V} d s \\
& \leq \frac{1}{2 \zeta} \int_{t}^{T}\left\|\frac{\partial \psi_{j}(s)}{\partial t}\right\|_{H}^{2} d s+\frac{\zeta}{2} \int_{t}^{T}\left\|u_{j}(s)-\psi_{j}(s)\right\|_{H}^{2} d s+\frac{1}{2 \zeta} \int_{t}^{T}\|g(s)\|_{H}^{2} d s+\frac{\zeta}{2} \int_{t}^{T}\left\|u_{j}(s)-\psi_{j}(s)\right\|_{V}^{2} d s \\
& \quad+\frac{\left\|a_{\lambda}^{(M)}\right\| \zeta}{2} \int_{t}^{T}\left\|u_{j}(s)-\psi_{j}(s)\right\|_{H}^{2} d s+\frac{\left\|a_{\lambda}^{(M)}\right\|}{2 \zeta} \int_{t}^{T}\left\|\psi_{j}(s)\right\|_{V}^{2} d s,
\end{aligned}
$$

for any $\zeta>0$. Recall that $\psi_{j}=P_{j} \psi$, and so $\left\|\psi_{j}(t)\right\|_{V}^{2} \leq\|\psi(t)\|_{V}^{2}$. In the same way $\left\|\frac{\partial \psi_{j}(t)}{\partial t}\right\|_{H}^{2} \leq$ $\left\|\frac{\partial \psi_{j}(t)}{\partial t}\right\|_{V}^{2} \leq\left\|\frac{\partial \psi(t)}{\partial t}\right\|_{V}^{2}$. Choosing $\zeta=\frac{\delta_{1}}{4\left(1+\frac{\left\|\alpha_{\lambda}^{(M)}\right\|}{2}\right)}$ after simple calculations we deduce that there exists $C>0$ independent of $M, \varepsilon$ and $j$ such that

& \quad \leq C\left(\left\|\frac{\partial \psi}{\partial t}\right\|_{L^{2}([t, T] ; V)}^{2}+\|g\|_{L^{2}([t, T] ; H)}^{2}+\|\psi\|_{L^{2}([t, T] ; V)}^{2}\right) \tag{3.21}
\end{align*}
$$

We now go back to (3.20) and we take $v=\frac{\partial u_{j}}{\partial t}(t)$. We have

-\left(\frac{\partial u_{j}}{\partial t}(t), \frac{\partial u_{j}}{\partial t}(t)\right)_{H}+a_{\lambda}^{(M)}\left(u_{j}(t), \frac{\partial u_{j}}{\partial t}(t)\right)-\frac{1}{\varepsilon}\left(\left(\psi_{j}(t)-u_{j}(t)\right)_{+}, \frac{\partial u_{j}}{\partial t}(t)\right)_{H}=\left(g(t), \frac{\partial u_{j}}{\partial t}(t)\right)_{H}
$$

so that

$$
\begin{aligned}
-\frac{1}{2}\left\|\frac{\partial u_{j}}{\partial t}(t)\right\|_{H}^{2}+\bar{a}_{\lambda}\left(u_{j}(t), \frac{\partial u_{j}}{\partial t}(t)\right) & +\tilde{a}^{(M)}\left(u_{j}(t), \frac{\partial u_{j}}{\partial t}(t)\right)-\frac{1}{\varepsilon}\left(\left(\psi_{j}(t)-u_{j}(t)\right)_{+}, \frac{\partial u_{j}}{\partial t}(t)\right)_{H} \\
& =\left(g(t), \frac{\partial u_{j}}{\partial t}(t)\right)_{H}
\end{aligned}
$$

Note that

$$
\begin{aligned}
-\frac{1}{\varepsilon}\left(\left(\psi_{j}(t)-u_{j}(t)\right)_{+}, \frac{\partial u_{j}}{\partial t}(t)\right)_{H} & =\frac{1}{\varepsilon}\left(\left(\psi_{j}-u_{j}\right)_{+}, \frac{\partial\left(\psi_{j}-u_{j}\right)}{\partial t}(t)\right)_{H}-\frac{1}{\varepsilon}\left(\left(\psi_{j}(t)-u_{j}(t)\right)_{+}, \frac{\partial \psi_{j}}{\partial t}(t)\right)_{H} \\
& =\frac{1}{2 \varepsilon} \frac{d}{d t}\left\|\left(\psi_{j}-u_{j}\right)_{+}(t)\right\|_{H}^{2}-\frac{1}{\varepsilon}\left(\left(\psi_{j}(t)-u_{j}(t)\right)_{+}, \frac{\partial \psi_{j}}{\partial t}(t)\right)_{H}
\end{aligned}
$$

Therefore, using the symmetry of $\bar{a}_{\lambda}$, we have

-\frac{1}{2}\left\|\frac{\partial u_{j}}{\partial t}(t)\right\|_{H}^{2}+ & \frac{1}{2} \frac{d}{d t} \bar{a}_{\lambda}\left(u_{j}(t), u_{j}(t)\right)+\tilde{a}^{(M)}\left(u_{j}(t), \frac{\partial u_{j}}{\partial t}(t)\right)+\frac{1}{2 \varepsilon} \frac{\partial}{\partial t}\left\|\left(\psi_{j}(t)-u_{j}(t)\right)_{+}\right\|_{H}^{2} \\
& -\frac{1}{\varepsilon}\left(\left(\psi_{j}(t)-u_{j}(t)\right)_{+}, \frac{\partial \psi_{j}}{\partial t}(t)\right)_{H}=\left(g(t), \frac{\partial u_{j}}{\partial t}(t)\right)_{H}
\end{aligned}
$$

Integrating between $t$ and $T$, we obtain

& \int_{t}^{T} \frac{1}{2}\left\|\frac{\partial u_{j}}{\partial t}(s)\right\|_{H}^{2} d s+\frac{1}{2} \bar{a}_{\lambda}\left(u_{j}(t), u_{j}(t)\right)+\frac{1}{2 \varepsilon}\left\|\left(\psi_{j}(t)-u_{j}(t)\right)_{+}\right\|_{H}^{2} \\
& =\int_{t}^{T} \tilde{a}^{(M)}\left(u_{j}(s), \frac{\partial u_{j}}{\partial s}(s)\right) d s+\frac{1}{2} \bar{a}_{\lambda}\left(\psi_{j}(T), \psi_{j}(T)\right)-\int_{t}^{T} \frac{1}{\varepsilon}\left(\left(\psi_{j}(s)-u_{j}(s)_{+}, \frac{\partial \psi_{j}}{\partial s}(s)\right)_{H} d s\right. \\
& -\int_{t}^{T}\left(g(s), \frac{\partial u_{j}}{\partial s}(s)\right)_{H} d s
\end{aligned}
$$

Recall that $\bar{a}_{\lambda}\left(u_{j}(t), u_{j}(t)\right) \geq \delta_{1}\left\|u_{j}(t)\right\|_{V}^{2}, \bar{a}_{\lambda}\left(\psi_{j}(T), \psi_{j}(T)\right)=\bar{a}_{\lambda}(\psi(T), \psi(T)) \leq\left\|a_{\lambda}^{-}\right\|\|\psi(T)\|_{V}^{2}$ and $\left|\tilde{a}^{(M)}(u, v)\right| \leq K_{1} \int_{\mathcal{O}} y \wedge M|\nabla u \| v| d \mathfrak{m}$, so that, for every $\zeta>0$,

& \frac{1}{2} \int_{t}^{T}\left\|\frac{\partial u_{j}}{\partial s}(s)\right\|_{H}^{2} d s+\frac{\delta_{1}}{4}\left\|u_{j}(t)\right\|_{V}^{2}+\frac{1}{2 \varepsilon}\left\|\left(\psi_{j}(t)-u_{j}(t)\right)_{+}\right\|_{H}^{2} \\
& \leq K_{1} \int_{t}^{T} d s \int_{\mathcal{O}} y \wedge M\left|\nabla u_{j}(s, .)\right|\left|\frac{\partial u_{j}}{\partial t}(s, .)\right| d \mathfrak{m}+\frac{\left\|\bar{a}_{\lambda}\right\|^{2}}{2}\|\psi(T)\|_{V}^{2}+\frac{1}{\varepsilon} \int_{t}^{T}\left\|\left(\psi_{j}(s)-u_{j}(s)\right)_{+}\right\|_{H}\left\|\frac{\partial \psi_{j}}{\partial s}(s)\right\|_{H} d s \\
& \quad+\int_{t}^{T}\|g(s)\|_{H}\left\|\frac{\partial u_{j}}{\partial s}(s)\right\|_{H} d s \\
& \leq \frac{K_{1}}{2 \zeta} \int_{t}^{T}\left\|u_{j}(s)\right\|_{V}^{2} d s+\frac{K_{1} M}{2} \zeta \int_{t}^{T}\left\|\frac{\partial u_{j}}{\partial s}(s)\right\|_{H}^{2} d s+\frac{\left\|\bar{a}_{\lambda}\right\|^{2}}{2}\|\psi(T)\|_{V}^{2} \\

\end{align*}

where $C_{\varepsilon, M}$ is a constant which depends on $\varepsilon$ and $M$ but not on $j$.
We will also need a further estimation. If we denote $\bar{u}_{j}=\frac{\partial u_{j}}{\partial t}$ and we differentiate the equation (3.20) with respect to $t$ for a fixed $v$ independent of $t$, we obtain that $\bar{u}_{j}$ satisfies

We can take $v=\bar{u}_{j}(t)$ in (3.23) and we obtain

& \leq \frac{1}{\varepsilon}\left(\frac{\partial \psi_{j}}{\partial t}(t) 1_{\left\{\psi_{j}(t) \geq u_{j}\right\}}, \bar{u}_{j}(t)\right)_{H}+\left(\frac{\partial g}{\partial t}(t), \bar{u}_{j}(t)\right)_{H}
\end{aligned}

Integrating between $t$ and $T$, with the usual calculations, we obtain, in particular, that

where $C_{\varepsilon}$ is a constant which depends on $\varepsilon$, but not on $j$.

## 3. Passage to the limit

Let $\varepsilon$ and $M$ be fixed. By passing to a subsequence, from (3.22) we can assume that $\frac{\partial u_{j}}{\partial t}$ weakly converges to a function $u_{\varepsilon, \lambda, M}^{\prime}$ in $L^{2}([0, T] ; H)$. We deduce that, for any fixed $t \in[0, T], u_{j}(t)$ weakly converges in $H$ to

Indeed, $u_{j}(t)$ is bounded in $V$, so the convergence is weakly in $V$. Passing to the limit in (3.24) we deduce that $\frac{\partial u_{\varepsilon, \lambda, M}}{\partial t} \in L^{2}([0, T] ; V)$. Moreover, from (3.22), we have that $\left(\psi_{j}-u_{j}(t)\right)^{+}$weakly converges in $H$ to a certain function $\chi \in H$. Now, for any $v \in V$ we know that there exists a sequence $\left(v_{j}\right)_{j \in \mathbb{N}}$ such that $v_{j} \in V_{j}$ for all $j \in \mathbb{N}$ and $\left\|v-v_{j}\right\|_{V} \rightarrow 0$. We have

We only have to note that $\chi(t)=\left(\psi(t)-u_{\varepsilon, \lambda, M}(t)\right)_{+}$. In fact, $\psi_{j}(t) \rightarrow \psi(t)$ in $V$ and, up to a subsequence, $1_{\mathcal{U}} u_{j}(t) \rightarrow \mathcal{1}_{\mathcal{U}} u_{\varepsilon, \lambda, M}(t)$ in $L^{2}(\mathcal{U}, \mathfrak{m})$ for every open $\mathcal{U}$ relatively compact in $\mathcal{O}$. Therefore, there exists a subsequence which converges a.e. and this allows to conclude the proof.

We want now to get rid of the truncated operator, that is to pass to the limit for $M \rightarrow \infty$. In order to do this we need some estimates on the function $u_{\varepsilon, \lambda, M}$ which are uniform in $M$.

Lemma 3.12. Assume that, in addition to the assumptions of Proposition $\left[3.11, \sqrt{1+y} \psi \in L^{2}([0, T] ; V)\right.$, $\left|\frac{\partial \psi}{\partial t}\right| \leq \Psi$ with $\Psi \in L^{2}([0, T] ; V)$ and $g$ satisfies Assumption $\mathcal{H}^{0}$. Let $u_{\varepsilon, \lambda, M}$ be the solution of (3.19). Then,

\end{gather*}

where $C$ is a positive constant independent of $M$ and $\varepsilon$.
Proof. To simplify the notation we denote $u_{\varepsilon, \lambda, M}$ by $u$. For $n \geq 0$, define $\varphi_{n}(x, y)=1+y \wedge n$. Since $\varphi_{n}$ and its derivatives are bounded, if $v \in V$, we have $v \varphi_{n} \in V$. Applying (3.19) with $v=\left(u_{\varepsilon, \lambda, M}-\psi\right) \varphi_{n}=(u-\psi) \varphi_{n}$, we get

& +a_{\lambda}^{(M)}\left(\psi,(u-\psi) \varphi_{n}\right)
\end{aligned}
$$

With the notation $\varphi_{n}^{\prime}=\frac{\partial \varphi_{n}}{\partial y}=\mathbb{1}_{\{y \leq n\}}$, we have

& +\int_{\mathcal{O}} \frac{y}{2}\left(\rho \sigma \frac{\partial(u-\psi)}{\partial x}+\sigma^{2} \frac{\partial(u-\psi)}{\partial y}\right)(u-\psi) \varphi_{n}^{\prime} d \mathfrak{m} \\
& +\int_{\mathcal{O}} y \wedge M\left(\frac{\partial(u-\psi)}{\partial x} j_{\gamma, \mu}+\frac{\partial(u-\psi)}{\partial y} k_{\gamma, \mu}\right)(u-\psi) \varphi_{n} d \mathfrak{m} \\
& +\lambda \int_{\mathcal{O}}(1+y)(u-\psi)^{2} \varphi_{n} d \mathfrak{m} \\
\geq & \delta_{1} \int_{\mathcal{O}} y|\nabla(u-\psi)|^{2} \varphi_{n} d \mathfrak{m}+\lambda \int_{\mathcal{O}}(1+y)(u-\psi)^{2} \varphi_{n} d \mathfrak{m} \\

where, for the last inequality, we have chosen $\zeta=\delta_{1} / K_{1}$ and used the inequality $\lambda \geq \frac{\delta_{1}}{2}+\frac{K_{1}^{2}}{2 \delta_{1}}$. Again, in the case $n=0$ the last term on the righthand side can be omitted.

Hence, we have, with the notation $\|v\|_{V, n}^{2}=\int_{\mathcal{O}}\left(y|\nabla v|^{2}+(1+y) v^{2}\right) \varphi_{n} d \mathfrak{m}$,

In fact, for example for the function $g$, we can consider a sequence of functions $g_{n}=g * \varphi_{n}$, where $\left(\varphi_{n}\right)_{n} \in C_{c}^{\infty}([0, T] \times \mathcal{O})$, $\int_{[0, T] \times \mathcal{O}} \varphi_{n}=1$ and $\lim _{n \rightarrow \infty} \varphi_{n}(x)=\delta_{x}$. Then $\left(g_{n}\right)_{n} \subset L^{2}([0, T] ; H), \frac{\partial g_{n}}{\partial t} \in L^{2}([0, T] ; H) \forall n \in \mathbb{N}$ and $\left\|g_{n}-g\right\|_{L^{2}([0, T] ; H)} \rightarrow 0$ as $n \rightarrow \infty$. In the same way, we can find a sequence $\psi_{n}$ such that $\psi_{n}(T) \in H^{2}(\mathcal{O}, \mathfrak{m})$
and $\frac{\partial \psi_{n}}{\partial t} \in L^{2}([0, T] ; V)$ for every $n \in \mathbb{N}$ and $\int_{0}^{T}\left\|\psi_{n}(t)-\psi(t)\right\|_{V} d s \rightarrow 0$ as $n \rightarrow \infty$. Therefore, the solution $u_{\varepsilon, \lambda, M}^{n}$ of the equation (3.15) with source function $g_{n}$ and obstacle function $\psi_{n}$ satisfies

Let $u_{\varepsilon, \lambda}^{i}$ be the unique solution of (3.15) with obstacle function $\psi$ and source function $g_{i}$. If $g_{1} \leq g_{2}$, then $u_{\varepsilon, \lambda}^{1} \leq u_{\varepsilon, \lambda}^{2}$.
3. Assume that $\psi_{i}$ satisfies Assumption $\mathcal{H}^{1}$ for $i=1,2$ and $g$ satisfies Assumption $\mathcal{H}^{0}$. Let $u_{\varepsilon, \lambda}^{i}$ be the unique solution of (3.15) with obstacle function $\psi_{i}$ and source function $g$. \left(\frac{\partial\left(u_{\varepsilon, \lambda}^{1}-u_{\varepsilon, \lambda}^{2}\right)_{+}}{\partial t},\left(u_{\varepsilon, \lambda}^{1}-u_{\varepsilon, \lambda}^{2}\right)_{+}\right)_{H}=\frac{1}{2} \frac{d}{d t}\left\|\left(u_{\varepsilon, \lambda}^{1}-u_{\varepsilon, \lambda}^{2}\right)_{+}\right\|_{H}^{2} \geq 0
$$

But $\left(u_{\varepsilon, \lambda}^{1}(T)-u_{\varepsilon, \lambda}^{2}(T)\right)_{+}=\left(\psi_{1}(T)-\psi_{2}(T)\right)_{+}=0$, so $\left\|\left(u_{\varepsilon, \lambda}^{1}-u_{\varepsilon, \lambda}^{2}\right)_{+}\right\|_{H}^{2} \equiv 0$ and the proof is completed.
2. Again we consider $v=\left(u_{\varepsilon, \lambda}^{1}-u_{\varepsilon, \lambda}^{2}\right)_{+}$and we prove that $v \equiv 0$. With the same passages, this time we get

$$
\begin{aligned}
& -\left(\frac{\partial\left(u_{\varepsilon, \lambda}^{1}-u_{\varepsilon, \lambda}^{2}\right)}{\partial t},\left(u_{\varepsilon, \lambda}^{1}-u_{\varepsilon, \lambda}^{2}\right)_{+}\right)_{H}+a_{\lambda}\left(u_{\varepsilon, \lambda}^{1}-u_{\varepsilon, \lambda}^{2},\left(u_{\varepsilon, \lambda}^{1}-u_{\varepsilon, \lambda}^{2}\right)_{+}\right) \\
& +\left(\zeta_{\varepsilon}\left(u_{\varepsilon, \lambda}^{1}\right)-\zeta_{\varepsilon}\left(u_{\varepsilon, \lambda}^{2}\right),\left(u_{\varepsilon, \lambda}^{1}-u_{\varepsilon, \lambda}^{2}\right)_{+}\right)_{H}=\left(g_{1}-g_{2},\left(u_{\varepsilon, \lambda}^{1}-u_{\varepsilon, \lambda}^{2}\right)_{+}\right)_{H} \leq 0 .
\end{aligned}
$$

Again

$$
a_{\lambda}\left(u_{\varepsilon, \lambda}^{1}-u_{\varepsilon, \lambda}^{2},\left(u_{\varepsilon, \lambda}^{1}-u_{\varepsilon, \lambda}^{2}\right)_{+}\right)=a_{\lambda}\left(\left(u_{\varepsilon, \lambda}^{1}-u_{\varepsilon, \lambda}^{2}\right)_{+},\left(u_{\varepsilon, \lambda}^{1}-u_{\varepsilon, \lambda}^{2}\right)_{+}\right) \geq 0
$$

and

$$
\left(\zeta_{\varepsilon}\left(u_{\varepsilon, \lambda}^{1}\right)-\zeta_{\varepsilon}\left(u_{\varepsilon, \lambda}^{2}\right),\left(u_{\varepsilon, \lambda}^{1}-u_{\varepsilon, \lambda}^{2}\right)_{+}\right)_{H} \geq 0
$$

thanks to the monotonicity of the penalized operator. Therefore we obtain

$$
\left(\frac{\partial\left(u_{\varepsilon, \lambda}^{1}-u_{\varepsilon, \lambda}^{2}\right)_{+}}{\partial t},\left(u_{\varepsilon, \lambda}^{1}-u_{\varepsilon, \lambda}^{2}\right)_{+}\right)_{H}=\frac{1}{2} \frac{d}{d t}\left\|\left(u_{\varepsilon, \lambda}^{1}-u_{\varepsilon, \lambda}^{2}\right)_{+}\right\|_{H}^{2} \geq 0
$$

and we can conclude the proof as before.
3. With the same procedure, we choose $v=\left(u_{\varepsilon, \lambda}^{1}-u_{\varepsilon, \lambda}^{2}-C\right)_{+}$, with $C=\left\|\psi_{1}-\psi_{2}\right\|_{\infty}$ and, with the usual passages, we get

$$
-\left(\frac{\partial v}{\partial t}, v\right)_{H}+a_{\lambda}(v, v)+\int_{\mathcal{O}}(r+\lambda(1+y)) C v d \mathfrak{m}+\frac{1}{\varepsilon}\left(\left(\psi_{2}-u_{\varepsilon, \lambda}^{2}\right)_{+}-\left(\psi_{1}-u_{\varepsilon, \lambda}^{1}\right)_{+}, v\right)_{H}=0
$$

The last three terms are all positives so the assertion follows as in the other cases.

### 3.2.2 Coercive variational inequality

Proposition 3.14. Assume that $\psi$ satisfies Assumption $\mathcal{H}^{1}$ and $g$ satisfies Assumption $\mathcal{H}^{0}$. Moreover, assume that $0 \leq \psi \leq \Phi$ with $\Phi:[0, T] \rightarrow H^{2}(\mathcal{O}, \mathfrak{m})$ such that $\frac{\partial \Phi}{\partial t}+\mathcal{L} \Phi \leq 0$ and $0 \leq g \leq-\frac{\partial \Phi}{\partial t}-\mathcal{L}^{\lambda} \Phi$. Then, there exists a unique function $u_{\lambda}$ such that $u_{\lambda} \in L^{2}([0, T] ; V), \frac{\partial u_{\lambda}}{\partial t} \in L^{2}([0, T] ; H)$ and

$$
\left\{\begin{array}{l}
-\left(\frac{\partial u_{\lambda}}{\partial t}, v-u_{\lambda}\right)_{H}+a_{\lambda}\left(u_{\lambda}, v-u_{\lambda}\right) \geq\left(g, v-u_{\lambda}\right)_{H}, \quad \text { a.e. in }[0, T] \quad v \in V, v \geq \psi,  \tag{3.34}\\
u_{\lambda}(T)=\psi(T), \\
u_{\lambda} \geq \psi \text { a.e. in }[0, T] \times \mathbb{R} \times(0, \infty) .
\end{array}\right.
$$

Moreover, $0 \leq u_{\lambda} \leq \Phi$.
Proof of uniqueness in Proposition 3.14. Suppose that there are two functions $u_{1}$ and $u_{2}$ which satisfy (3.34). We can take $v=u_{2}$ in the equation satisfied by $u_{1}$ and $v=u_{1}$ in the one satisfied by $u_{2}$ and we get

$$
\begin{aligned}
& -\left(\frac{\partial u_{1}}{\partial t}, u_{2}-u_{1}\right)_{H}+a_{\lambda}\left(u_{1}, u_{2}-u_{1}\right) \geq\left(g, u_{2}-u_{1}\right)_{H} \\
& -\left(\frac{\partial u_{2}}{\partial t}, u_{1}-u_{2}\right)_{H}+a_{\lambda}\left(u_{2}, u_{1}-u_{2}\right) \geq\left(g, u_{1}-u_{2}\right)_{H}
\end{aligned}
$$

Setting $w:=u_{2}-u_{1}$ and adding the second equation from the first one we obtain

$$
\left(\frac{\partial w}{\partial t}, w\right)_{H}-a_{\lambda}(w, w) \geq 0
$$

so that

$$
\left(\frac{\partial w}{\partial t}, w\right)_{H}=\frac{1}{2} \frac{d}{d t}\|w\|_{H} \geq 0
$$

But $w(T)=u_{1}(T)-u_{2}(T)=\psi(T)-\psi(T)=0$ and, therefore, $w \equiv 0$, that is $u_{1}=u_{2}$.
Proof of existence in Proposition 3.14. For each fixed $\varepsilon>0$ we have the estimates (3.16) and (3.17), so, for every $t \in[0, T]$, we can extract a subsequence $u_{\varepsilon, \lambda}$ such that $u_{\varepsilon, \lambda}(t) \rightharpoonup u_{\lambda}(t)$ in $V$ as $\varepsilon \rightarrow 0$ and $u_{\varepsilon}^{\prime}(t) \rightharpoonup u_{\lambda}^{\prime}(t)$ in $H$ for some function $u_{\lambda} \in V$.

Note that $u=0$ is the unique solution of (3.15) when $\psi=g=0$, while $u=\Phi$ is the unique solution of (3.15) when $\psi=\Phi$ and $g=-\frac{\partial \Phi}{\partial t}-\mathcal{L}^{\lambda} \Phi=-\frac{\partial \Phi}{\partial t}-\mathcal{L} \Phi+\lambda(1+y) \Phi$. Therefore, Proposition 3.13 implies that $0 \leq u_{\varepsilon, \lambda} \leq \Phi$. Recall that $u_{\varepsilon, \lambda}(t) \rightarrow u_{\lambda}(t)$ in $L^{2}(\mathcal{U}, \mathfrak{m})$ for every relatively compact open $\mathcal{U} \subset \mathcal{O}$. This, together with the fact that $d \mathfrak{m}$ is a finite measure, allows to conclude that we have strong convergence of $u_{\varepsilon, \lambda}$ to $u_{\lambda}$ in $H$. In fact, if $\delta>0$ and $\mathcal{O}_{\delta}:=\left(-\frac{1}{\delta}, \frac{1}{\delta}\right) \times\left(\delta, \frac{1}{\delta}\right)$,

$$
\int_{\mathcal{O}}\left|u_{\varepsilon, \lambda}-u_{\lambda}\right|^{2} d \mathfrak{m} \leq \int_{\mathcal{O}_{\delta}}\left|u_{\varepsilon, \lambda}-u_{\lambda}\right|^{2} d \mathfrak{m}+\int_{\mathcal{O}_{\delta}^{c}}\left|u_{\varepsilon, \lambda}-u_{\lambda}\right|^{2} d \mathfrak{m} \leq \int_{\mathcal{O}_{\delta}}\left|u_{\varepsilon, \lambda}-u_{\lambda}\right|^{2} d \mathfrak{m}+\int_{\mathcal{O}_{\delta}^{c}} 4 \Phi^{2} d \mathfrak{m}
$$

and it is enough to let $\delta$ goes to 0 .
From (3.18) we also have that $\left(\psi-u_{\varepsilon, \lambda}\right)^{+} \rightarrow 0$ strongly in $H$ as $\varepsilon \rightarrow 0$. On the other hand $\left(\psi-u_{\varepsilon, \lambda}\right)^{+} \rightharpoonup \chi$ weakly in $H$ and $\chi=\left(\psi-u_{\lambda}\right)^{+}$since there exists a subsequence of $u_{\varepsilon, \lambda}$ which converges pointwise to $u_{\lambda}$. Therefore, $\left(\psi-u_{\lambda}\right)^{+}=0$, which means $u_{\lambda} \geq \psi$.

If we consider the penalized coercive equation in (3.15) replacing $v$ by $v-u_{\varepsilon, \lambda}$, with $v \geq \psi$, we have

$$
-\left(\frac{\partial u_{\varepsilon, \lambda}}{\partial t}, v-u_{\varepsilon, \lambda}\right)_{H}+a_{\lambda}\left(u_{\varepsilon, \lambda}, v-u_{\varepsilon, \lambda}\right)_{H}+\left(\zeta_{\varepsilon}\left(u_{\varepsilon, \lambda}\right), v-u_{\varepsilon, \lambda}\right)_{H}=\left(g, v-u_{\varepsilon, \lambda}\right)_{H}
$$

Since $\zeta_{\varepsilon}(v)=0$, we can write

$$
-\left(\frac{\partial u_{\varepsilon, \lambda}}{\partial t}, v-u_{\varepsilon, \lambda}\right)_{H}+a_{\lambda}\left(u_{\varepsilon, \lambda}, v-u_{\varepsilon, \lambda}\right)_{H}-\underbrace{\left(\zeta_{\varepsilon}(v)-\zeta_{\varepsilon}\left(u_{\varepsilon, \lambda}\right), v-u_{\varepsilon, \lambda}\right)_{H}}_{\geq 0}=\left(g, v-u_{\varepsilon, \lambda}\right)_{H}
$$

Therefore

$$
-\left(\frac{\partial u_{\varepsilon, \lambda}}{\partial t}, v-u_{\varepsilon, \lambda}\right)_{H}+a_{\lambda}\left(u_{\varepsilon, \lambda}, v-u_{\varepsilon, \lambda}\right) \geq\left(g, v-u_{\varepsilon, \lambda}\right)_{H}
$$

and, letting $\varepsilon$ goes to 0 , we have

$$
\begin{aligned}
-\left(\frac{\partial u_{\lambda}}{\partial t}, v-u_{\lambda}\right)_{H}+a_{\lambda}\left(u_{\lambda}, v\right) & \geq\left(g, v-u_{\lambda}\right)_{H}+\liminf _{\varepsilon \rightarrow 0} a_{\lambda}\left(u_{\varepsilon, \lambda}, u_{\varepsilon, \lambda}\right) \\
& \geq\left(g, v-u_{\lambda}\right)_{H}+a_{\lambda}\left(u_{\lambda}, u_{\lambda}\right)
\end{aligned}
$$

Moreover, since $0 \leq u_{\varepsilon, \lambda} \leq \Phi$ for every $\varepsilon>0$ and $u_{\lambda}=\lim _{\varepsilon \rightarrow 0} u_{\varepsilon, \lambda}$, we have $0 \leq u_{\lambda} \leq \Phi$ and the assertion follows.

The following Comparison Principle is a direct consequence of Proposition 3.13.
Proposition 3.15. 1. For $i=1,2$, assume that $\psi_{i}$ satisfies Assumption $\mathcal{H}^{1}, g$ satisfies Assumption $\mathcal{H}^{0}$ and $0 \leq \psi_{i} \leq \Phi$ with $\Phi:[0, T] \rightarrow H^{2}(\mathcal{O}, \mathfrak{m})$ such that $\frac{\partial \Phi}{\partial t}+\mathcal{L} \Phi \leq 0$ and $0 \leq g \leq-\frac{\partial \Phi}{\partial t}-\mathcal{L}^{\lambda} \Phi$. Let $u_{\lambda}^{i}$ be the unique solution of (3.34) with obstacle function $\psi_{i}$ and source function $g$. If $\psi_{1} \leq \psi_{2}$, then $u_{\lambda}^{1} \leq u_{\lambda}^{2}$.
2. For $i=1,2$, assume that $\psi$ satisfies Assumption $\mathcal{H}^{1}$, $g_{i}$ satisfy Assumption $\mathcal{H}^{0}$ and $0 \leq \psi \leq \Phi$ with $\Phi:[0, T] \rightarrow H^{2}(\mathcal{O}, \mathfrak{m})$ such that $\frac{\partial \Phi}{\partial t}+\mathcal{L} \Phi \leq 0$ and $0 \leq g_{i} \leq-\frac{\partial \Phi}{\partial t}-\mathcal{L}^{\lambda} \Phi$. Let $u_{\lambda}^{i}$ be the unique solution of (3.34) with obstacle function $\psi$ and source function $g_{i}$. If $g_{1} \leq g_{2}$, then $u_{\lambda}^{1} \leq u_{\lambda}^{2}$.
3. For $i=1,2$, assume that $\psi_{i}$ satisfies Assumption $\mathcal{H}^{1}$, g satisfies Assumption $\mathcal{H}^{0}$ and $0 \leq \psi_{i} \leq \Phi$ with $\Phi:[0, T] \rightarrow H^{2}(\mathcal{O}, \mathfrak{m})$ such that $\frac{\partial \Phi}{\partial t}+\mathcal{L} \Phi \leq 0$ and $0 \leq g \leq-\frac{\partial \Phi}{\partial t}-\mathcal{L}^{\lambda} \Phi$. Let $u_{\lambda}^{i}$ be the unique solution of (3.34) with obstacle function $\psi_{i}$ and source function $g$. If $\psi_{1}-\psi_{2} \in L^{\infty}$, then $u_{\lambda}^{1}-u_{\lambda}^{2} \in L^{\infty}$ and $\left\|u_{\lambda}^{1}-u_{\lambda}^{2}\right\|_{\infty} \leq\left\|\psi_{1}-\psi_{2}\right\|_{\infty}$.

### 3.2.3 Non-coercive variational inequality

We can finally prove Theorem 2.3. Again, we first study the uniqueness of the solution and then we deal with the existence.

Proof of uniqueness in Theorem 2.3. Suppose that there are two functions $u_{1}$ and $u_{2}$ which satisfies (2.4). As usual, we take $v=u_{2}$ in the equation satisfied by $u_{1}$ and $v=u_{1}$ in the one satisfied by $u_{2}$ and we add the resulting equations. Setting $w:=u_{2}-u_{1}$, we get

$$
\left(\frac{\partial w}{\partial t}, w\right)_{H}-a(w, w) \geq 0
$$

From the energy estimate (3.6), we know that

$$
a(u, u) \geq C_{1}\|u\|_{V}^{2}-C_{2}\left\|(1+y)^{\frac{1}{2}} u\right\|_{H}^{2}
$$

so that

$$
\frac{1}{2} \frac{d}{d t}\|w\|_{H}^{2}+C_{2}\left\|(1+y)^{\frac{1}{2}} w\right\|_{H}^{2} \geq 0
$$

By integrating from $t$ to $T$, since $w(T)=0$, we have

$$
\begin{aligned}
& \|w(t)\|_{H}^{2} \leq C_{2} \int_{t}^{T} d s\left\|(1+y)^{\frac{1}{2}} w\right\|_{H}^{2} \\
& \quad \leq C_{2}\left(\int_{t}^{T} d s \int_{\mathcal{O}} 1_{\{y \leq \lambda\}}(1+y) w^{2} d \mathfrak{m}+\int_{t}^{T} d s \int_{\mathcal{O}} 1_{\{y>\lambda\}}(1+y) w^{2} d \mathfrak{m}\right) \\
& \leq C\left(\int_{t}^{T} d s \int_{\mathcal{O}}(1+\lambda) w^{2} y^{\beta-1} e^{-\gamma|x|} e^{-\mu y} d x d y+\int_{t}^{T} d s \int_{\mathcal{O}} 1_{\{y>\lambda\}}(1+y) w^{2} y^{\beta-1} e^{-\gamma|x|} e^{-\left(\mu-\mu^{\prime}\right) y} e^{-\mu^{\prime} y} d x d y\right) \\
& \quad \leq C\left(\int_{t}^{T} d s \int_{\mathcal{O}} d x d y(1+\lambda) w^{2} y^{\beta-1} e^{-\gamma|x|} e^{-\mu y}+e^{-\left(\mu-\mu^{\prime}\right) \lambda} \int_{t}^{T} d s \int_{\mathcal{O}} d x d y(1+y) \Phi^{2} y^{\beta-1} e^{-\gamma|x|} e^{-\mu^{\prime} y}\right)
\end{aligned}
$$

where $\mu^{\prime}<\mu$ and $\lambda>0$. Since $C_{2}=\int_{\mathcal{O}} d x d y(1+y) \Phi^{2} y^{\beta-1} e^{-\gamma|x|} e^{-\mu^{\prime} y}<\infty$, we have

$$
\|w(t)\|_{H}^{2} \leq C(1+\lambda) \int_{t}^{T}\|w(s)\|_{H}^{2} d s+C_{2}(T-t) e^{-\left(\mu-\mu^{\prime}\right) \lambda}
$$

so, by using the Gronwall Lemma,

$$
\|w(t)\|_{H}^{2} \leq C_{2} T e^{-\left(\mu-\mu^{\prime}\right) \lambda+C(T-t)(1+\lambda)}
$$

Sending $\lambda \rightarrow \infty$, we deduce that $w(t)=0$ in $[T, t]$ for $t$ such that $T-t<\frac{\mu-\mu^{\prime}}{C}$. Then, we iterate the same argument: we integrate between $t^{\prime}$ and $t$ with $t-t^{\prime}<\frac{\mu-\mu^{\prime}}{C}$ and we have $w(t)=0$ in $\left[T, t^{\prime}\right]$ and so on. We deduce that $w(t)=0$ for all $t \in[0, T]$ so the assertion follows.

Proof of existence in Theorem 2.3. Given $u_{0}=\Phi$, we can construct a sequence $\left(u_{n}\right)_{n} \subset V$ such that

$$
\begin{gather*}
u_{n} \geq \psi \text { a.e. in }[0, T] \times \mathcal{O}, \quad n \geq 1  \tag{3.35}\\
-\left(\frac{\partial u_{n}}{\partial t}, v-u_{n}\right)_{H}+a\left(u_{n}, v-u_{n}\right)+\lambda\left((1+y) u_{n}, v-u_{n}\right)_{H} \geq \lambda\left((1+y) u_{n-1}, v-u_{n}\right)_{H}  \tag{3.36}\\
v \in V, \quad v \geq \psi, \quad \text { a.e. on }[0, T] \times \mathcal{O}, \quad n \geq 1 \\
u_{n}(T)=\psi(T), \quad \text { in } \mathcal{O},  \tag{3.37}\\
\Phi \geq u_{1} \geq u_{2} \geq \cdots \geq u_{n-1} \geq u_{n} \geq \cdots \geq 0, \quad \text { a.e. on }[0, T] \times \mathcal{O} \tag{3.38}
\end{gather*}
$$

In fact, if we have $0 \leq u_{n-1} \leq \Phi$ for all $n \in \mathbb{N}$, then the assumptions of Proposition 3.14 are satisfied with

$$
g_{n}=\lambda(1+y) u_{n-1}
$$

since $g_{n}$ and $\sqrt{1+y} g_{n}$ belong to $L^{2}([0, T] ; H)$ and $0 \leq g_{n} \leq \lambda(1+y) \Phi \leq-\frac{\partial \Phi}{\partial t}-\mathcal{L}_{\lambda} \Phi$. Therefore, step by step, we can deduce the existence and the uniqueness of a solution $u_{n}$ to (3.36) such that $0 \leq u_{n} \leq \Phi$. (3.38) is a simple consequence of Proposition 3.15. In fact, proceeding by induction, at each step we have

$$
g_{n}=\lambda(1+y) u_{n-1} \leq \lambda(1+y) u_{n-2}=g_{n-1}
$$

so that $u_{n} \leq u_{n-1}$. Now, recall that

$$
\begin{aligned}
\left\|u_{n}\right\|_{L^{\infty}([0, T], V)} & \leq K \\
\left\|\frac{\partial u_{n}}{\partial t}\right\|_{L^{2}([0, T] ; H)} & \leq K
\end{aligned}
$$

where $K=C\left(\|\Phi\|_{L^{2}([0, T] ; V)}+\left\|\sqrt{1+y} g_{n}\right\|_{L^{2}([0, T] ; H)}+\|\sqrt{1+y} \psi\|_{L^{2}([0, T] ; V)}+\|\psi(T)\|_{V}^{2}\right)$. Note that the constant $K$ is independent of $n$ since $\left|g_{n}\right|=\left|\lambda(1+y) u_{n-1},\right| \leq \lambda(1+y) \Phi$, for every $n \in \mathbb{N}$. Therefore, by passing
to a subsequence, we can assume that there exists a function $u$ such that $u \in L^{2}([0, T] ; V), \frac{\partial u}{\partial t} \in L^{2}([0, T] ; H)$ and for every $t \in[0, T], u_{n}^{\prime}(t) \rightharpoonup u^{\prime}(t)$ in $H$ and $u_{n}(t) \rightharpoonup u(t)$ in $V$. Indeed, again thanks to the fact that $0 \leq u_{n} \leq \Phi$, we can deduce that $u_{n}(t) \rightarrow u(t)$ in $H$. Therefore we can pass to the limit in

$$
-\left(\frac{\partial u_{n}}{\partial t}, u_{n}-v\right)_{H}+a\left(u_{n}, v-u_{n}\right)+\lambda\left((1+y) u_{n}, v-u_{n}\right)_{H} \geq \lambda\left((1+y) u_{n-1}, v-u_{n}\right)_{H}
$$

and the assertion follows.
Remark 3.16. Keeping in mind our purpose of identifying the solution of the variational inequality (2.4) with the American option price we have considered the case without source term $(g=0)$ in the variational inequality (2.4). However, under the same assumptions of Theorem 2.3, we can prove in the same way the existence and the uniqueness of a solution of

$$
\left\{\begin{array}{l}
-\left(\frac{\partial u}{\partial t}, v-u\right)_{H}+a(u, v-u) \geq(g, v-u)_{H}, \quad \text { a.e. in }[0, T] \quad v \in V, v \geq \psi \\
u \geq \psi \text { a.e. in }[0, T] \times \mathbb{R} \times(0, \infty) \\
u(T)=\psi(T) \\
0 \leq u \leq \Phi
\end{array}\right.
$$

where $g$ satisfies Assumption $\mathcal{H}^{0}$ and $0 \leq g \leq-\frac{\partial \Phi}{\partial t}-\mathcal{L} \Phi$.
We conclude stating the following Comparison Principle, whose proof is a direct consequence of Proposition 3.15 and the proof of Proposition 2.3.

Proposition 3.17. For $i=1,2$, assume that $\psi_{i}$ satisfies Assumption $\mathcal{H}^{1}$ and $0 \leq \psi_{i} \leq \Phi$ with $\Phi$ satisfying Assumption $\mathcal{H}^{2}$. Let $u_{\lambda}^{i}$ be the unique solution of (3.34) with obstacle function $\psi_{i}$. Then:

1. If $\psi_{1} \leq \psi_{2}$, then $u_{\lambda}^{1} \leq u_{\lambda}^{2}$.
2. If $\psi_{1}-\psi_{2} \in L^{\infty}$, then $u_{\lambda}^{1}-u_{\lambda}^{2} \in L^{\infty}$ and $\left\|u_{\lambda}^{1}-u_{\lambda}^{2}\right\|_{\infty} \leq\left\|\psi_{1}-\psi_{2}\right\|_{\infty}$.

## 4 Connection with the optimal stopping problem

Once we have the existence and the uniqueness of a solution $u$ of the variational inequality (2.3), our aim is to prove that it matches the solution of the optimal stopping problem, that is

$$
u(t, x, y)=u^{*}(t, x, y), \quad \text { on }[0, T] \times \overline{\mathcal{O}}
$$

where $u^{*}$ is defined by

$$
u^{*}(t, x, y)=\sup _{\tau \in \mathcal{T}_{t, T}} \mathbb{E}\left[\psi\left(\tau, X_{\tau}^{t, x, y}, Y_{\tau}^{t, x, y}\right)\right]
$$

$\mathcal{T}_{t, T}$ being the set of the stopping times with values in $[t, T]$. Since the function $u$ is not regular enough to apply Ito's Lemma, we use another strategy in order to prove the above identification. So, we first show, by using the affine character of the underlying diffusion, that the semigroup associated with the bilinear form $a_{\lambda}$ coincides with the transition semigroup of the two dimensional diffusion $(X, Y)$ with a killing term. Then, we prove suitable estimates on the joint law of $(X, Y)$ and $L^{p}$-regularity results on the solution of the variational inequality and we deduce from them the probabilistic interpretation.

### 4.1 Semigroup associated with the bilinear form

We introduce now the semigroup associated with the coercive bilinear form $a_{\lambda}$. With a natural notation, we define the following spaces

$$
L_{l o c}^{2}\left(\mathbb{R}^{+} ; H\right)=\left\{f: \mathbb{R}^{+} \rightarrow H: \forall t \geq 0 \int_{0}^{t}\|f(s)\|_{H}^{2} d s<\infty\right\}
$$

$$
L_{l o c}^{2}\left(\mathbb{R}^{+} ; V\right)=\left\{f: \mathbb{R}^{+} \rightarrow V: \forall t \geq 0 \int_{0}^{t}\|f(s)\|_{V}^{2} d s<\infty\right\}
$$

First of all, we state the following result:
Proposition 4.1. For every $\psi \in V, f \in L_{\text {loc }}^{2}\left(\mathbb{R}^{+} ; H\right)$ with $\sqrt{y} f \in L_{l o c}^{2}\left(\mathbb{R}^{+} ; H\right)$, there exists a unique function $u \in L_{l o c}^{2}\left(\mathbb{R}^{+} ; V\right)$ such that $\frac{\partial u}{\partial t} \in L_{l o c}^{2}\left(\mathbb{R}^{+} ; H\right), u(0)=\psi$ and

$$
\begin{equation*}
\left(\frac{\partial u}{\partial t}, v\right)_{H}+a_{\lambda}(u, v)=(f, v)_{H}, \quad v \in V \tag{4.1}
\end{equation*}
$$

Moreover we have, for every $t \geq 0$,

$$
\begin{equation*}
\|u(t)\|_{H}^{2}+\frac{\delta_{1}}{2} \int_{0}^{t}\|u(s)\|_{V}^{2} d s \leq\|\psi\|_{H}^{2}+\frac{2}{\delta_{1}} \int_{0}^{t}\|f(s)\|_{H}^{2} d s \tag{4.2}
\end{equation*}
$$

and

$$
\|u(t)\|_{V}^{2}+\int_{0}^{t}\left\|u_{t}(s)\right\|_{H}^{2} d s \leq C\left(\|\psi\|_{V}^{2}+\frac{1}{2} \int_{0}^{t}\|\sqrt{1+y} f(s)\|_{H}^{2} d s\right)
$$

with $C>0$.
The proof follows the same lines as the proof of Proposition 3.14 so we omit it. Moreover, we can prove a Comparison Principle for the equation (4.1) as we have done for the variational inequality.

We denote $u(t)=\bar{P}_{t}^{\lambda} \psi$ the solution of (4.1) corresponding to $u(0)=\psi$ and $g=0$. From (4.2) we deduce that the operator $\bar{P}_{t}^{\lambda}$ is a linear contraction on $H$ and, from uniqueness, we have the semigroup property.
Proposition 4.2. Let us consider $f: \mathbb{R}^{+} \rightarrow H$ such that $\sqrt{1+y} f \in L_{l o c}^{2}\left(\mathbb{R}^{+}, H\right)$. Then, the solution of

$$
\left\{\begin{array}{l}
\left(\frac{\partial u}{\partial t}, v\right)+a_{\lambda}(u, v)=(f, v), \quad v \in V \\
u(0)=0
\end{array}\right.
$$

is given by $u(t)=\int_{0}^{t} \bar{P}_{s}^{\lambda} f(t-s) d s=\int_{0}^{t} \bar{P}_{t-s}^{\lambda} f(s) d s$.
Proof. Note that $V$ is dense in $H$ and recall the estimate (4.2), so it is enough to prove the assertion for $f=\mathbb{1}_{\left(t_{1}, t_{2}\right]} \psi$, with $0 \leq t_{1}<t_{2}$ and $\psi \in V$. If we set $u(t)=\int_{0}^{t} \bar{P}_{t-s}^{\lambda} f(s) d s$, we have

$$
\begin{aligned}
u(t) & =\mathbb{1}_{\left\{t \geq t_{1}\right\}} \int_{t_{1}}^{t \wedge t_{2}} \bar{P}_{t-s}^{\lambda} \psi d s \\
& = \begin{cases}\int_{t_{1}}^{t_{2}} \bar{P}_{t-s}^{\lambda} \psi d s=\int_{t-t_{2}}^{t-t_{2}} \bar{P}_{s}^{\lambda} \psi d s & \text { if } t \geq t_{2} \\
\int_{t_{1}}^{t} \bar{P}_{t-s}^{\lambda} \psi d s=\int_{0}^{t-t_{1}} \bar{P}_{s}^{\lambda} \psi d s & \text { if } t \in\left[t_{1}, t_{2}\right)\end{cases}
\end{aligned}
$$

Therefore, for every $v \in V$, we have $\left(u_{t}, v\right)+a_{\lambda}(u, v)=0$ if $t \leq t_{1}$ and, if $t \geq t_{1}$,

$$
\left(\frac{\partial u}{\partial t}, v\right)+a_{\lambda}(u(t), v)= \begin{cases}\left(\bar{P}_{t-t_{1}}^{\lambda} \psi-\bar{P}_{t-t_{2}}^{\lambda} \psi, v\right)+a_{\lambda}\left(\int_{t-t_{2}}^{t-t_{1}} \bar{P}_{s}^{\lambda} \psi d s, v\right) & \text { if } t \geq t_{2} \\ \left(\bar{P}_{t-t_{1}}^{\lambda} \psi, v\right)+a_{\lambda}\left(\int_{0}^{t-t_{1}} \bar{P}_{s}^{\lambda} \psi d s, v\right) & \text { if } t \in\left[t_{1}, t_{2}\right)\end{cases}
$$

The assertion follows from $\left(\bar{P}_{t}^{\lambda} \psi, v\right)+\int_{0}^{t} a_{\lambda}\left(\bar{P}_{s} \psi, v\right) d s=(\psi, v)$.
Remark 4.3. It is not difficult to prove that $\bar{P}_{t}^{\lambda}: L^{p}(\mathcal{O}, \mathfrak{m}) \rightarrow L^{p}(\mathcal{O}, \mathfrak{m})$ is a contraction for every $p \geq 2$, and it is an analytic semigroup. This is not useful to our purposes so we omit the proof.

### 4.2 Transition semigroup

We define $\mathbb{E}_{x_{0}, y_{0}}(\quad)=\mathbb{E}\left(\quad \mid X_{0}=x_{0}, Y_{0}=y_{0}\right)$. Fix $\lambda>0$. For every measurable positive function $f$ defined on $\mathbb{R} \times[0,+\infty)$, we define

$$
P_{t}^{\lambda} f\left(x_{0}, y_{0}\right)=\mathbb{E}_{x_{0}, y_{0}}\left(e^{-\lambda \int_{0}^{t}\left(1+Y_{s}\right) d s} f\left(X_{t}, Y_{t}\right)\right) .
$$

The operator $P_{t}^{\lambda}$ is the transition semigroup of the two dimensional diffusion $(X, Y)$ with the killing term $e^{-\lambda \int_{0}^{t}\left(1+Y_{s}\right) d s}$.

Set $\mathbb{E}_{y_{0}}(\quad)=\mathbb{E}\left(\quad \mid Y_{0}=y_{0}\right)$. We first prove some useful results about the Laplace transform of the pair $\left(Y_{t}, \int_{0}^{t} Y_{s} d s\right)$. These results rely on the affine structure of the model and have already appeared in slightly different forms in the literature (see, for example, [2, Section 4.2.1]). We include a proof for convenience.
Proposition 4.4. Let $\alpha$ and $\beta$ be two complex numbers with nonpositive real parts. The equation

$$
\begin{equation*}
\psi^{\prime}(t)=\frac{\sigma^{2}}{2} \psi^{2}(t)-\kappa \psi(t)+\beta \tag{4.3}
\end{equation*}
$$

has a unique solution $\psi_{\alpha, \beta}$ defined on $[0,+\infty)$, such that $\psi_{\alpha, \beta}(0)=\alpha$. Moreover, for every $t \geq 0$,

$$
\mathbb{E}_{y_{0}}\left(e^{\alpha Y_{t}+\beta} \int_{0}^{t} Y_{s} d s\right)=e^{y_{0} \psi_{\alpha, \beta}(t)+\theta \kappa \phi_{\alpha, \beta}(t)}
$$

with $\phi_{\alpha, \beta}(t)=\int_{0}^{t} \psi_{\alpha, \beta}(s) d s$.
Proof. Let $\psi$ be the solution of (4.3). We define $\psi_{1}$ (resp. $\beta_{1}$ ) and $\psi_{2}$ (resp. $\beta_{2}$ ) the real and the imaginary part of $\psi$ (resp. $\beta$ ). We have

$$
\left\{\begin{array}{l}
\psi_{1}^{\prime}(t)=\frac{\sigma^{2}}{2}\left(\psi_{1}^{2}(t)-\psi_{2}^{2}(t)\right)-\kappa \psi_{1}(t)+\beta_{1}, \\
\psi_{2}^{\prime}(t)=\sigma^{2} \psi_{1}(t) \psi_{2}(t)-\kappa \psi_{2}(t)+\beta_{2} .
\end{array}\right.
$$

From the first equation we deduce that $\psi_{1}^{\prime}(t) \leq \frac{\sigma^{2}}{2}\left(\psi_{1}(t)-\frac{2 \kappa}{\sigma^{2}}\right) \psi_{1}(t)+\beta_{1}$ and, since $\beta_{1} \leq 0$, the function $t \mapsto \psi_{1}(t) e^{-\int_{0}^{t}\left(\psi_{1}(s)-\frac{2 \kappa}{\sigma^{2}}\right) d s}$ is nonincreasing. Therefore $\psi_{1}(t) \leq 0$ if $\psi_{1}(0) \leq 0$. Multiplying the first equation by $\psi_{1}(t)$ and the second one by $\psi_{2}(t)$ and adding we get

$$
\begin{aligned}
\frac{1}{2} \frac{d}{d t}\left(|\psi(t)|^{2}\right) & =\left(\frac{\sigma^{2}}{2} \psi_{1}(t)-\kappa\right)|\psi(t)|^{2}+\beta_{1} \psi_{1}(t)+\beta_{2} \psi_{2}(t) \\
& \leq\left(\frac{\sigma^{2}}{2} \psi_{1}(t)-\kappa\right)|\psi(t)|^{2}+|\beta||\psi(t)| \\
& \leq\left(\frac{\sigma^{2}}{2} \psi_{1}(t)-\kappa\right)|\psi(t)|^{2}+\epsilon|\psi(t)|^{2}+\frac{|\beta|^{2}}{4 \epsilon} .
\end{aligned}
$$

We deduce that $|\psi(t)|$ cannot explode in finite time and, therefore, $\psi_{\alpha, \beta}$ actually exists on $[0,+\infty)$. Moreover, note that we have $|\psi(t)|^{2} \leq C_{\kappa^{\prime}} e^{-\kappa^{\prime} t}$ for every $\kappa^{\prime}<\kappa$.

Now, let us define the function $F_{\alpha, \beta}(t, y)=e^{y \psi_{\alpha, \beta}(t)+\theta \kappa \phi_{\alpha, \beta}(t)} . F_{\alpha, \beta}$ is $C^{1,2}$ on $[0,+\infty) \times \mathbb{R}$ and it satisfies by construction the following equation

$$
\frac{\partial F_{\alpha, \beta}}{\partial t}=\frac{\sigma^{2}}{2} y \frac{\partial^{2} F_{\alpha, \beta}}{\partial y^{2}}+\kappa(\theta-y) \frac{\partial F_{\alpha, \beta}}{\partial y}+\beta y F_{\alpha, \beta} .
$$

Therefore, for every $T>0$, the process $\left(M_{t}\right)_{0 \leq t \leq T}$ defined by

$$
\begin{equation*}
M_{t}=e^{\beta \int_{0}^{t} Y_{s} d s} F_{\alpha, \beta}\left(T-t, Y_{t}\right) \tag{4.4}
\end{equation*}
$$

is a local martingale. On the other hand, note that $\left|M_{t}\right| \leq 1$, so the process $\left(M_{t}\right)_{t}$ is a true martingale indeed. We deduce that $F_{\alpha, \beta}\left(T, y_{0}\right)=\mathbb{E}_{y_{0}}\left(e^{\beta \int_{0}^{T} Y_{s} d s} e^{\alpha Y_{T}}\right)$ and the assertion follows.

Remark 4.5. If we take $\alpha=0$ and $\beta=-s$, with $s>0$, we get

$$
\mathbb{E}_{y_{0}}\left(e^{-s \int_{0}^{t} Y_{v} d v}\right)=e^{y_{0} \psi_{0,-s}(t)+\theta \kappa \phi_{0,-s}(t)}
$$

and, as we have seen in the proof of Proposition 4.4 $\psi_{0,-s}^{\prime}$ has constant sign. Since $\psi_{0,-s}^{\prime}(0)=-s<0$, the function $\psi_{0,-s}$ is decreasing. Again from the proof of Proposition 4.4,

$$
\psi_{0,-s}(t) \geq \frac{\kappa}{\sigma^{2}}-\sqrt{\left(\frac{\kappa}{\sigma^{2}}\right)^{2}+2 \frac{s}{\sigma^{2}}} \geq-\sqrt{2 s / \sigma^{2}}
$$

and, integrating, $\phi_{0,-s}(t) \geq-t \sqrt{2 s / \sigma^{2}}$.
We deduce that, for every $y_{0} \geq 0$,

$$
\mathbb{E}_{y_{0}}\left(e^{-s \int_{0}^{t} Y_{v} d v}\right) \leq e^{-t \kappa \theta \sqrt{2 s / \sigma^{2}}}=e^{-t \sigma \beta \sqrt{s / 2}}
$$

and, for every $q>0$,

$$
\begin{aligned}
\mathbb{E}_{y_{0}}\left(\int_{0}^{t} Y_{v} d v\right)^{-q} & =\mathbb{E}_{y_{0}}\left(\frac{1}{\Gamma(q)} \int_{0}^{\infty} s^{q-1} e^{-s \int_{0}^{t} Y_{v} d v} d s\right) \\
& \leq \frac{1}{\Gamma(q)} \int_{0}^{\infty} s^{q-1} e^{-t \sigma \beta \sqrt{s / 2}} d s \\
& =\frac{2^{q}}{t^{2 q}(\sigma \beta)^{2 q} \Gamma(q)} \int_{0}^{\infty} s^{q-1} e^{-\sqrt{s}} d s=\frac{2^{q+1} \Gamma(2 q)}{t^{2 q}(\sigma \beta)^{2 q} \Gamma(q)}
\end{aligned}
$$

We also have the following result.
Proposition 4.6. Let $\lambda_{1}$ and $\lambda_{2}$ be two real numbers such that

$$
\frac{\sigma^{2}}{2} \lambda_{1}^{2}-\kappa \lambda_{1}+\lambda_{2} \leq 0
$$

Then, the equation

$$
\begin{equation*}
\psi^{\prime}(t)=\frac{\sigma^{2}}{2} \psi^{2}(t)-\kappa \psi(t)+\lambda_{2} \tag{4.5}
\end{equation*}
$$

has a unique solution $\psi_{\lambda_{1}, \lambda_{2}}$ defined on $[0,+\infty)$ such that $\psi_{\lambda_{1}, \lambda_{2}}(0)=\lambda_{1}$. Moreover, for every $t \geq 0$, we have

$$
\mathbb{E}_{y_{0}}\left(e^{\lambda_{1} Y_{t}+\lambda_{2} \int_{0}^{t} Y_{s} d s}\right) \leq e^{y_{0} \psi_{\lambda_{1}, \lambda_{2}}(t)+\theta \kappa \phi_{\lambda_{1}, \lambda_{2}}(t)}
$$

with $\phi_{\lambda_{1}, \lambda_{2}}(t)=\int_{0}^{t} \psi_{\lambda_{1}, \lambda_{2}}(s) d s$.
Proof. Let $\psi$ be the solution of (4.5) with $\psi(0)=\lambda_{1}$. We have

$$
\psi^{\prime \prime}(t)=\left(\sigma^{2} \psi(t)-\kappa\right) \psi^{\prime}(t)
$$

Therefore $\psi^{\prime}(t)$ has constant sign and the assumption on $\lambda_{1}$ and $\lambda_{2}$ ensures that $\psi^{\prime}(0) \leq 0$. We deduce that $\psi^{\prime}(t) \leq 0$ and $\psi(t)$ remains between the solutions of the equation

$$
\frac{\sigma^{2}}{2} \lambda^{2}-\kappa \lambda+\lambda_{2}=0
$$

This proves that the solution is defined on the whole interval $[0,+\infty)$. Now the assertion follows as in the proof of Proposition 4.4 just note that the the process $\left(M_{t}\right)_{t}$ defined as in (4.4) is no more a martingale but it remains a positive local martingale, hence a supermartingale.

Remark 4.7. Let us now consider two real numbers $\lambda_{1}$ and $\lambda_{2}$ such that

$$
\frac{\sigma^{2}}{2} \lambda_{1}^{2}-\kappa \lambda_{1}+\lambda_{2}<0
$$

From the proof of Proposition 4.6. by using the optimal stopping theorem we have

$$
\sup _{\tau \in \mathcal{T}_{0, T}} \mathbb{E}_{y}\left(e^{\mu} \int_{0}^{\tau} Y_{s} d s e^{\psi_{\lambda, \mu}(T-\tau) Y_{\tau}+\theta \kappa \phi_{\lambda, \mu}(T-\tau)}\right) \leq e^{y \psi_{\lambda, \mu}(T)+\theta \kappa \phi_{\lambda, \mu}(T)}
$$

Consider now $\epsilon>0$ and let $\lambda_{\epsilon}=(1+\epsilon) \lambda$ and $\mu_{\epsilon}=(1+\epsilon) \mu$. For $\epsilon$ small enough, we have $\frac{\sigma^{2}}{2} \lambda_{\epsilon}^{2}-\kappa \lambda_{\epsilon}+\mu_{\epsilon}<0$. Therefore

$$
\sup _{\tau \in \mathcal{T}_{0}, T} \mathbb{E}_{y}\left(e^{\mu_{\epsilon} \int_{0}^{\tau} Y_{s} d s} e^{\psi_{\lambda_{\epsilon}, \mu_{\epsilon}}(T-\tau) Y_{\tau}+\theta \kappa \phi_{\lambda_{\epsilon}, \mu_{\epsilon}}(T-\tau)}\right) \leq e^{y \psi_{\lambda_{\epsilon}, \mu_{\epsilon}}(T)+\theta \kappa \phi_{\lambda_{\epsilon}, \mu_{\epsilon}}(T)} .
$$

If we have $\psi_{\lambda_{\epsilon}, \mu_{\epsilon}} \geq(1+\epsilon) \psi_{\lambda, \mu}$, we can deduce that

$$
\sup _{\tau \in \mathcal{T}_{0, T}} \mathbb{E}_{y}\left(e^{\mu(1+\epsilon) \int_{0}^{\tau} Y_{s} d s} e^{(1+\epsilon)\left(\psi_{\lambda, \mu}(T-\tau) Y_{\tau}+\theta \kappa \phi_{\lambda, \mu}(T-\tau)\right)}\right) \leq e^{y \psi_{\lambda_{\epsilon}, \mu_{\epsilon}}(T)+\theta \kappa \phi_{\lambda_{\epsilon}, \mu_{\epsilon}}(T)}
$$

and, therefore, that the family $\left(e^{\mu \int_{0}^{\tau} Y_{s} d s} e^{\psi_{\lambda, \mu}(T-\tau) Y_{\tau}+\theta \kappa \phi_{\lambda, \mu}(T-\tau)}\right)_{\tau \in \mathcal{T}_{0, T}}$ is uniformly integrable. As a consequence, the process $\left(M_{t}\right)_{t}$ is a true martingale and we have

$$
\mathbb{E}_{y}\left(e^{\lambda Y_{t}+\mu \int_{0}^{t} Y_{s} d s}\right)=e^{y \psi_{\lambda, \mu}(t)+\theta \kappa \phi_{\lambda, \mu}(t)}
$$

So, it remains to show that $\psi_{\lambda_{\epsilon}, \mu_{\epsilon}} \geq(1+\epsilon) \psi_{\lambda, \mu}$. In order to do this we set $g_{\epsilon}(t)=\psi_{\lambda_{\epsilon}, \mu_{\epsilon}}(t)-(1+\epsilon) \psi_{\lambda, \mu}(t)$. From the equations satisfied by $\psi_{\lambda_{\epsilon}, \mu_{\epsilon}}$ and $\psi_{\lambda, \mu}$ we deduce that

$$
\begin{aligned}
g_{\epsilon}^{\prime}(t) & =\frac{\sigma^{2}}{2}\left(\psi_{\lambda_{\epsilon}, \mu_{\epsilon}}^{2}(t)-(1+\epsilon) \psi_{\lambda, \mu}^{2}(t)\right)-\kappa\left(\psi_{\lambda_{\epsilon}, \mu_{\epsilon}}(t)-(1+\epsilon) \psi_{\lambda, \mu}(t)\right) \\
& =\frac{\sigma^{2}}{2}\left(\psi_{\lambda_{\epsilon}, \mu_{\epsilon}}^{2}(t)-(1+\epsilon)^{2} \psi_{\lambda, \mu}^{2}(t)\right)-\kappa g_{\epsilon}(t)+\frac{\sigma^{2}}{2}\left((1+\epsilon)^{2}-(1+\epsilon)\right) \psi_{\lambda, \mu}^{2}(t) \\
& =\frac{\sigma^{2}}{2}\left(\psi_{\lambda_{\epsilon}, \mu_{\epsilon}}(t)+(1+\epsilon) \psi_{\lambda, \mu}(t)\right) g_{\epsilon}(t)-\kappa g_{\epsilon}(t)+\frac{\sigma^{2}}{2} \epsilon(1+\epsilon) \psi_{\lambda, \mu}^{2}(t) \\
& =f_{\epsilon}(t) g_{\epsilon}(t)+\frac{\sigma^{2}}{2} \epsilon(1+\epsilon) \psi_{\lambda, \mu}^{2}(t)
\end{aligned}
$$

where

$$
f_{\epsilon}(t)=\frac{\sigma^{2}}{2}\left(\psi_{\lambda_{\epsilon}, \mu_{\epsilon}}(t)+(1+\epsilon) \psi_{\lambda, \mu}(t)\right)-\kappa
$$

Therefore, the function $g_{\epsilon}(t) e^{-\int_{0}^{t} f_{\epsilon}(s) d s}$ is nondecreasing and, since $g_{\epsilon}(0)=0$, we have $g_{\epsilon}(t) \geq 0$.
Now recall that the diffusion $(X, Y)$ evolves according to the following stochastic differential system

$$
\left\{\begin{array}{l}

d Y_{t}=\kappa\left(\theta-Y_{t}\right) d t+\sigma \sqrt{Y_{t}} d W_{t}
\end{array}\right.
$$

If we set $\tilde{X}_{t}=X_{t}-\frac{\rho}{\sigma} Y_{t}$, we have

d Y_{t}=\kappa\left(\theta-Y_{t}\right) d t+\sigma \sqrt{Y_{t}} d W_{t}

where $\tilde{B}_{t}=\left(1-\rho^{2}\right)^{-1 / 2}\left(B_{t}-\rho W_{t}\right)$. Note that $\tilde{B}$ is a standard Brownian motion with $\langle\tilde{B}, W\rangle_{t}=0$.

### 4.3 Identification of the semigroups

We now show that the semigroup associated with the coercive bilinear form $\bar{P}_{t}^{\lambda}$ can be actually identified with the transition semigroup $P_{t}^{\lambda}$.

The function $F(t, x, y)$ defined by $F(t, x, y)=$ $e^{-\lambda t} e^{i u x+y\left(\psi_{\lambda_{1}, \mu}(t)-i u \frac{\rho}{\sigma}\right)+\theta \kappa \phi_{\lambda_{1}, \mu}(t)}$ satisfies $F(0, x, y)=e^{i u x+i v y}$ and

Moreover, for every $t \geq 0$, we have $\int_{\mathcal{O}}\left(y\left|D^{2} F\right|^{2}(t, x, y)+|\nabla F|^{2}(t, x, y)\right) d \mathfrak{m}<\infty$, so that, for every $v \in V$, $(\mathcal{L} F(t, .,), v)=.-a(F(t, .,), v$.$) . Therefore$

### 4.4 Estimates on the joint law

In this section we prove some estimates on the joint law of the diffusion $(X, Y)$ which will be crucial in order to prove Proposition 2.4. With the notations

& =\frac{C_{\nu}}{2} e^{-\frac{y_{t}+y}{2 L_{t}}}\left(\frac{y^{\nu}}{L_{t}^{\nu+1}} \mathbb{1}_{\left\{y y_{t} \leq L_{t}^{2}\right\}}+\frac{y^{\frac{\nu}{2}-\frac{1}{4}} e^{\frac{\sqrt{y y_{t}}}{L_{t}}}}{\left(y_{t}\right)^{\frac{\nu}{2}+\frac{1}{4}} L_{t}^{1 / 2}} \mathbb{1}_{\left\{y y_{t}>L_{t}^{2}\right\}}\right)

& =\frac{C_{\nu}}{2 L_{t}^{\nu+\frac{3}{2}}} e^{-\frac{\left(\sqrt{y}-\sqrt{\left.y_{t}\right)^{2}}\right.}{2 L_{t}}} y^{\nu}\left(L_{t}^{1 / 2} \mathbb{1}_{\left\{y y_{t} \leq L_{t}^{2}\right\}}+\left(y y_{t}\right)^{1 / 4} \mathbb{1}_{\left\{y y_{t}>L_{t}^{2}\right\}}\right)
\end{aligned}

& =\mathbb{E}_{y_{0}}\left(e^{-\lambda \Sigma_{t}^{2}} \int \tilde{f}\left(\tilde{x}_{0}+z, Y_{t}\right) n\left(\frac{z-\bar{\kappa} \Sigma_{t}^{2}}{\bar{\rho} \Sigma_{t}}\right) \frac{d z}{\bar{\rho} \Sigma_{t}}\right)

Hölder inequality with respect to the measure $e^{-\gamma|z|-\bar{\mu} Y_{t}} d z d \mathbb{P}_{y_{0}}$, where $\gamma>0$ and $\bar{\mu}$ will be chosen later on gives, for every $p>1$

& \leq e^{-\frac{y}{2 L_{\infty}} e^{\epsilon \frac{y}{2 L_{\infty}}} e^{\frac{y t}{2 \epsilon L_{\infty}}} e^{-\frac{y_{t}}{2 L_{\infty} \infty}}} \\
& =e^{-(1-\epsilon) \frac{y}{2 L_{\infty}}} e^{\frac{y_{t}}{2 \epsilon L_{\infty}}(1-\epsilon)} \\

J_{q}^{q} & \leq \frac{2}{\sqrt{q}}\left(\mathbb{E}_{y_{0}}\left(e^{p_{1}(q-1) \bar{\mu} Y_{t}+p_{1} \bar{\lambda}_{q} \Sigma_{t}^{2}}\right)\right)^{1 / p_{1}}\left(\mathbb{E}_{y_{0}}\left(\frac{1}{\left(\bar{\rho} \Sigma_{t}\right)^{q_{1}(q-1)}}\right)\right)^{1 / q_{1}} \\
& \leq \frac{C_{q, q_{1}}}{t^{q-1}}\left(\mathbb{E}_{y_{0}}\left(e^{p_{1}(q-1) \bar{\mu} Y_{t}+p_{1} \bar{\lambda}_{q} \Sigma_{t}^{2}}\right)\right)^{1 / p_{1}}
\end{aligned}
$$

where the last inequality follows from Remark 4.5 ,

We now apply Proposition 4.6 with $\lambda_{1}=p_{1}(q-1) \bar{\mu}$ et $\lambda_{2}=p_{1} \bar{\lambda}_{q}$. The assumption on $\lambda_{1}$ and $\lambda_{2}$ becomes

& \leq \frac{C_{p, \epsilon} e^{A_{p, \epsilon} y_{0}}}{t^{\frac{\beta}{p}+\frac{3}{2 p}}}\left(\int d z e^{-\gamma|z|} \int_{0}^{\infty} d y e^{-y\left(\bar{\mu}+\frac{1-2 \epsilon}{2 L_{\infty}}\right)} y^{\beta-1} f^{p}\left(\tilde{x}_{0}+z+\frac{\rho}{\sigma} y, y\right)\right)^{1 / p} \\
& =\frac{C_{p, \epsilon} e^{A_{p, \epsilon} y_{0}}}{t^{\frac{\beta}{p}+\frac{3}{2 p}}}\left(\int d z e^{-\gamma\left|z-\tilde{x}_{0}-\frac{\rho}{\sigma} y\right|} \int_{0}^{\infty} d y e^{-y\left(\bar{\mu}+\frac{1-2 \epsilon}{2 L_{\infty}}\right)} y^{\beta-1} f^{p}(z, y)\right)^{1 / p} \\
& \leq \frac{C_{p, \epsilon} e^{A_{p, \epsilon} y_{0}+\gamma\left|\tilde{x}_{0}\right|}}{t^{\frac{\beta}{p}+\frac{3}{2 p}}}\left(\int d z e^{-\gamma|z|} \int_{0}^{\infty} d y e^{-y\left(\bar{\mu}-\gamma \frac{|\rho|}{\sigma}+\frac{1-2 \epsilon}{2 L}\right)} y^{\beta-1} f^{p}(z, y)\right)^{1 / p}
\end{aligned}

If we choose $\epsilon=1 / 2$ and $\bar{\mu}=\mu+\gamma \frac{|\rho|}{\sigma}$, the assertion follows provided $\lambda$ satisfies

with $X_{0}=x, Y_{0}=y$ and $\langle B, W\rangle_{t}=\rho t$. We have, for every $t \geq 0$ and for every $(x, y),\left(x^{\prime}, y^{\prime}\right) \in \mathbb{R} \times[0,+\infty)$, $\mathbb{E}\left|Y_{t}^{y^{\prime}}-Y_{t}^{y}\right| \leq\left|y^{\prime}-y\right|$ and

The proof of Lemma 4.12 is straightforward so we omit the details: the inequality $\mathbb{E}\left|Y_{t}^{y^{\prime}}-Y_{t}^{y}\right| \leq\left|y^{\prime}-y\right|$ can be proved by using standard techniques for the CIR process introduced in [10, Section IV.3] and the other inequality easily follows.

Then, thanks to Theorem 4.11 we have the following result.
Proposition 4.13. Fix $p>1$ and $\lambda$ as in Theorem 4.11. If $\varphi \in L^{p}(\mathcal{O}, \mathfrak{m})$ then, $(t, x, y) \rightarrow P_{t}^{\lambda} \varphi(x, y)$ is continuous on $\mathbb{R}^{+} \times \mathbb{R} \times \mathbb{R}^{+}$.

Proof. If $\left(\left(t_{n}, x_{n}, y_{n}\right)\right)_{n}$ converges to $(t, x, y)$, we deduce from Lemma 4.12 that $X_{t_{n}}^{x_{n}, y_{n}} \rightarrow X_{t}^{x, y}, Y_{t_{n}}^{y_{n}} \rightarrow Y_{t}^{y}$ and $\int_{0}^{t_{n}} Y_{s}^{y_{n}} d s \rightarrow \int_{0}^{t} Y_{s}^{y} d s$ in probability. Therefore, the assertion is trivial if $\varphi$ is bounded continuous. If $\varphi \in \mathcal{L}^{p}(\mathcal{O}, \mathfrak{m}), \varphi$ is the limit in $L^{p}$ of a sequence of bounded continuous functions $\left(\varphi_{n}\right)_{n}$. Moreover, thanks to Theorem 4.11, for every compact $K \subseteq \mathbb{R} \times[0,+\infty)$, there is $C_{p, K, T}>0$ such that

Therefore $P_{t}^{\lambda} \varphi_{n}(x, y)$ converges locally uniformly to $P_{t}^{\lambda} \varphi(x, y)$ and the assertion follows.

### 4.5 Proof of Theorem 2.4

We are finally ready to prove the identification Theorem 2.4. We first prove the result under further regularity assumptions on the payoff function $\psi$, then we deduce the general statement by an approximation technique.

### 4.5.1 Case with a regular function $\psi$

The following two regularity results pave the way for the identification theorem in the case of a regular payoff function.

Proposition 4.14. Assume that $\psi$ satisfies Assumption $\mathcal{H}^{1}$ and $0 \leq \psi \leq \Phi$ with $\Phi$ satisfying Assumption $\mathcal{H}^{2}$. If moreover we assume $\psi \in L^{2}\left([0, T] ; H^{2}(\mathcal{O}, \mathfrak{m})\right)$ and $\frac{\partial \psi}{\partial t}+\mathcal{L} \psi,(1+y) \Phi \in L^{p}\left([0, T] ; L^{p}(\mathcal{O}, \mathfrak{m})\right)$ for $p \geq 2$, then there exists $\lambda_{0}>0$ and $F \in L^{p}\left([0, T] ; L^{p}(\mathcal{O}, \mathfrak{m})\right)$ such that for all $\lambda \geq \lambda_{0}$ the solution $u$ of (2.4) satisfies

Since both $u_{\varepsilon, \lambda}$ and $\psi$ are positive and $\psi$ belongs to $L^{p}\left([0, T] ; L^{p}(\mathcal{O}, \mathfrak{m})\right)$, we have $\left(\psi-u_{\varepsilon, \lambda}\right)_{+} \in L^{p}\left([0, T] ; L^{p}(\mathcal{O}, \mathfrak{m})\right)$. Taking $v=\left(\psi-u_{\varepsilon, \lambda}\right)_{+}^{p-1}$ and assuming that $\psi$ is bounded we observe that $v \in L^{2}([0, T] ; V)$ and we can write

& \quad=\left(g,\left(\psi-u_{\varepsilon, \lambda}\right)_{+}^{p-1}\right)_{H}-\left(\frac{\partial \psi}{\partial t},\left(\psi-u_{\varepsilon, \lambda}\right)_{+}^{p-1}\right)_{H}+a_{\lambda}\left(\psi,\left(\psi-u_{\varepsilon, \lambda}\right)_{+}^{p-1}\right)
\end{aligned}

Integrating from 0 to $T$ we get

since, for $\lambda$ large enough, the quadratic forms $(a, b) \rightarrow \delta_{1}(p-1) a^{2}+j_{\gamma \cdot \mu} a b+\frac{\lambda}{2} b^{2}$ and $(a, b) \rightarrow \delta_{1}(p-1) a^{2}+$ $k_{\gamma \cdot \mu} a b+\frac{\lambda}{2} b^{2}$ are both positive definite.

Recall that $\psi \in L^{2}\left([0, T] ; H^{2}(\mathcal{O}, \mathfrak{m})\right), \frac{\partial \psi}{\partial_{t}}+\mathcal{L} \psi \in L^{p}\left([0, T], L^{p}(\mathcal{O}, \mathfrak{m})\right),(1+y) \psi \leq(1+y) \Phi \in L^{p}\left([0, T], L^{p}(\mathcal{O}, \mathfrak{m})\right)$ and $g=(1+y) u \leq(1+y) \Phi \in L^{p}\left([0, T] ; L^{p}(\mathcal{O}, \mathfrak{m})\right)$. Therefore, going back to 4.10) and using Holder's inequality,

1. For every $t \in[0, T], u(t)=P_{t}^{\lambda} \psi+\int_{0}^{t} P_{s}^{\lambda} f(t-s) d s$.
2. The function $(t, x, y) \mapsto u(t, x, y)$ is continuous on $[0, T] \times \mathbb{R} \times[0,+\infty)$.
3. If $\Lambda_{t}=\lambda \int_{0}^{t}\left(1+Y_{s}\right) d s$, the process $\left(M_{t}\right)_{0 \leq t \leq T}$, defined by

In fact, it is trivial if $(t, x, y) \mapsto f(t, x, y)$ is bounded continuous. If $f \in L^{p}\left([0, T] ; L^{p}(\mathcal{O}, \mathfrak{m})\right), f$ is the limit in $L^{p}$ of a sequence of bounded continuous functions and we have $\int_{0}^{t} P_{s}^{\lambda} f_{n}(t-s, \cdot) d s \rightarrow \int_{0}^{t} P_{s}^{\lambda} f(t-s, \cdot) d s$ uniformly in $[0, T] \times K$ for every compact $K$ of $\mathbb{R} \times[0,+\infty))$. In fact, thanks to Theorem4.11] we can write for $t \in[0, T]$ and $(x, y) \in K$

\int_{0}^{t} P_{s}^{\lambda}\left|f_{n}-f\right|(t-s, \cdot, \cdot)(x, y) d s & \leq \int_{0}^{t} \frac{C_{p, K, T}}{s^{\frac{2 \beta+3}{2 p}}} d s\left\|\left(f_{n}-f\right)(t-s, \cdot, \cdot)\right\|_{L^{p}(\mathcal{O}, \mathfrak{m})} \\
& \leq C_{p, K, T}\left(\int_{0}^{t}\left\|\left(f_{n}-f\right)(t-s, \cdot, \cdot)\right\|_{L^{p}(\mathcal{O}, \mathfrak{m})}^{p} d s\right)^{1 / p}\left(\int_{0}^{t} \frac{d s}{s^{\frac{2 \beta+3}{2(p-1)}}}\right)^{1-\frac{1}{p}}  \tag{4.12}\\
& \leq C_{p, K, T}\left(\int_{0}^{T}\left\|\left(f_{n}-f\right)(s, \cdot, \cdot)\right\|_{L^{p}(\mathcal{O}, \mathfrak{m})}^{p} d s\right)^{1 / p}\left(\int_{0}^{T} \frac{d s}{s^{\frac{2 \beta+3}{2(p-1)}}}\right)^{1-\frac{1}{p}}
\end{align*}
$$

The assumption $p>\beta+\frac{5}{2}$ ensures the convergence of the integral in the right hand side.
For the last assertion, note that $M_{T}=e^{-\Lambda_{T}} \psi\left(X_{T}, Y_{T}\right)+\int_{0}^{T} e^{-\Lambda_{s}} f\left(T-s, X_{s}, Y_{s}\right) d s$. Then, we can prove that $M_{t}$ is integrable with the same arguments that we used to show the continuity of $(t, x, y) \mapsto u(t, x, y)$. Moreover, by using the Markov property,

$$
\begin{aligned}
\mathbb{E}_{x, y}\left(M_{T} \mid \mathcal{F}_{t}\right) & =e^{-\Lambda_{t}} P_{T-t}^{\lambda} \psi\left(X_{t}, Y_{t}\right)+\int_{0}^{t} e^{-\Lambda_{s}} f\left(T-s, X_{s}, Y_{s}\right) d s+e^{-\Lambda_{t}} \int_{t}^{T} P_{s-t}^{\lambda} f(T-s, ., .)\left(X_{t}, Y_{t}\right) d s \\
& =e^{-\Lambda_{t}}\left(P_{T-t}^{\lambda} \psi\left(X_{t}, Y_{t}\right)+\int_{0}^{T-t} P_{s}^{\lambda} f(T-t-s, ., .)\left(X_{t}, Y_{t}\right) d s\right)+\int_{0}^{t} e^{-\Lambda_{s}} f\left(T-s, X_{s}, Y_{s}\right) d s \\
& =e^{-\Lambda_{t}} u\left(T-t, X_{t}, Y_{t}\right)+\int_{0}^{t} e^{-\Lambda_{s}} f\left(T-s, X_{s}, Y_{s}\right) d s=M_{t}
\end{aligned}
$$

We are now ready to prove the following proposition.
Proposition 4.16. Fix $p>\beta+\frac{5}{2}$. Assume that $\psi$ satisfies Assumption $\mathcal{H}^{1}$ and $0 \leq \psi \leq \Phi$, with $\Phi$ satisfying Assumption $\mathcal{H}^{2}$, Assumption $\mathcal{H}^{*}$ and $(1+y) \Phi \in L^{p}\left([0, T], L^{p}(\mathcal{O}, \mathfrak{m})\right)$. Moreover, assume that $\frac{\partial \psi}{\partial t}+\mathcal{L} \psi \in$ $L^{p}\left([0, T] ; L^{p}(\mathcal{O}, \mathfrak{m})\right)$. Then, the solution $u$ of the variational inequality (2.4) satisfies

$$
\begin{equation*}
u(t, x, y)=u^{*}(t, x, y), \quad \text { on }[0, T] \times \overline{\mathcal{O}} \tag{4.13}
\end{equation*}
$$

where $u^{*}$ is defined by

$$
u^{*}(t, x, y)=\sup _{\tau \in \mathcal{T}_{t, T}} \mathbb{E}\left[\psi\left(\tau, X_{\tau}^{t, x, y}, Y_{\tau}^{t, x, y}\right)\right]
$$

Proof. Thanks to Proposition 4.14 we know that, for $\lambda$ large enough, there exists $F \in L^{p}\left([0, T] ; L^{p}(\mathcal{O}, \mathfrak{m})\right)$ such that $u$ satisfies

$$
-\left(\frac{\partial u}{\partial t}, v\right)_{H}+a_{\lambda}(u, v)=(F, v)_{H}, \quad v \in V
$$

that is

$$
-\left(\frac{\partial u}{\partial t}, v\right)_{H}+a(u, v)=(F-\lambda(1+y) u, v)_{H}, \quad v \in V
$$

On the other hand we know that

$$
\left\{\begin{array}{l}
-\left(\frac{\partial u}{\partial t}, v-u\right)_{H}+a(u, v-u) \geq 0, \quad \text { a.e. in }[0, T] \quad v \in V, v \geq \psi \\
u(T)=\psi(T) \\
u \geq \psi \text { a.e. in }[0, T] \times \mathbb{R} \times(0, \infty) .
\end{array}\right.
$$

From the previous relations we easily deduce that $F-\lambda(1+y) u \geq 0$ a.e. and, taking $v=\psi$, that $(F-\lambda(1+$ y) $u, \psi-u)=0$. Moreover, from Proposition4.15 we know that the process $\left(M_{t}\right)_{0 \leq t \leq T}$, defined by

$$
\begin{equation*}
M_{t}=e^{-\Lambda_{t}} u\left(t, X_{t}, Y_{t}\right)+\int_{0}^{t} e^{-\Lambda_{s}} F\left(s, X_{s}, Y_{s}\right) d s \tag{4.14}
\end{equation*}
$$

with $X_{0}=x, Y_{0}=y$ is a martingale for every $(x, y) \in \mathbb{R} \times[0,+\infty)$. Then, we deduce that the process

$$
\tilde{M}_{t}=u\left(t, X_{t}, Y_{t}\right)+\int_{0}^{t}\left(F\left(s, X_{s}, Y_{s}\right)-\lambda\left(1+Y_{s}\right) u\left(s, X_{s}, Y_{s}\right)\right) d s
$$

is a local martingale. In fact, from (4.14) we can write

$$
\begin{aligned}
d \tilde{M}_{t}= & d\left[e^{\Lambda_{t}} M_{t}-e^{\Lambda_{t}} \int_{0}^{t} e^{-\Lambda_{s}} F\left(s, X_{s}, Y_{s}\right) d s\right]+F\left(t, X_{t}, Y_{t}\right) d t-\lambda\left(1+Y_{t}\right) u\left(t, X_{t}, Y_{t}\right) d t \\
= & e^{\Lambda_{t}} d M_{t}+\left[\lambda\left(1+Y_{t}\right) M_{t}-\lambda\left(1+Y_{t}\right) e^{+\Lambda_{t}} \int_{0}^{t} e^{-\Lambda_{s}} F\left(s, X_{s}, Y_{s}\right) d s\right. \\
& \left.-e^{\Lambda_{t}} e^{-\Lambda_{t}} F\left(t, X_{t}, Y_{t}\right)+F\left(t, X_{t}, Y_{t}\right)-\lambda\left(1+Y_{t}\right) u\left(t, X_{t}, Y_{t}\right)\right] d t \\
= & e^{\Lambda_{t}} d M_{t} .
\end{aligned}
$$

So, for any stopping time $\tau$ there exists an increasing sequence of stopping times $\left(\tau_{n}\right)_{n}$ such that $\lim _{n} \tau_{n}=\infty$ and

$$
\mathbb{E}_{x, y}\left[u\left(\tau \wedge \tau_{n}, X_{\tau \wedge \tau_{n}}, Y_{\tau \wedge \tau_{n}}\right)\right]=u(0, x, y)-\mathbb{E}_{x, y}\left[\int_{0}^{\tau \wedge \tau_{n}}\left(F\left(s, X_{s}, Y_{s}\right)-\lambda\left(1+Y_{s}\right) u\left(s, X_{s}, Y_{s}\right)\right) d s\right]
$$

Since $F-\lambda(1+y) u \geq 0$ we can pass to the limit in the right hand side thanks to the monotone convergence theorem. On the other hand, we have that $\lim _{n \rightarrow \infty} \mathbb{E}_{x, y}\left[u\left(\tau \wedge \tau_{n}, X_{\tau \wedge \tau_{n}}, Y_{\tau \wedge \tau_{n}}\right)\right]=\mathbb{E}_{x, y}\left[u\left(\tau, X_{\tau}, Y_{\tau}\right)\right]$ since $0 \leq u(t, x, y) \leq \Phi(t, x, y)$ and $\left(\Phi\left(t+s, X_{s}^{t, x, y}, Y_{s}^{t, y}\right)\right)_{s \in[t, T]}$ is of class $\mathcal{D}$ for every $(t, x, y) \in[0, T] \times \mathbb{R} \times[0, \infty)$ by assumption. Therefore, passing to the limit as $n \rightarrow \infty$, we get

$$
\mathbb{E}_{x, y}\left[u\left(\tau, X_{\tau}, Y_{\tau}\right)\right]=u(0, x, y)-\mathbb{E}_{x, y}\left[\int_{0}^{\tau} e^{\Lambda_{\tau}-\lambda_{s}}\left(F\left(s, X_{s}, Y_{s}\right)-\lambda\left(1+Y_{s}\right) u\left(s, X_{s}, Y_{s}\right)\right) d s\right]
$$

for every $\tau \in \mathcal{T}_{[0, T]}$. Recall that $F-\lambda(1+y) u \geq 0$, so the process $u\left(t, X_{t}, Y_{t}\right)$ is actually a supermartingale. Since $u \geq \psi$, we deduce directly from the definition of Snell envelope that $u\left(t, X_{t}, Y_{t}\right) \geq u^{*}\left(t, X_{t}, Y_{t}\right)$ a.e. for $t \in[0, T]$.

In order to show the opposite inequality, we consider the so called continuation region

$$
\mathcal{C}=\{(t, x, y) \in[0, T) \times \mathbb{R} \times[0, \infty): u(t, x, y)>\psi(t, x, y)\}
$$

its $t$-sections

$$
\mathcal{C}_{t}=\{(x, y) \in \mathbb{R} \times[0, \infty):(t, x, y) \in \mathcal{C}\}, \quad t \in[0, T)
$$

and the stopping time

$$
\begin{aligned}
\tau_{t} & =\inf \left\{s \geq t:\left(s, X_{s}, Y_{s}\right) \notin \mathcal{C}\right\} \\
& =\inf \left\{s \geq t: u\left(s, X_{s}, Y_{s}\right)=\psi\left(s, X_{s}, Y_{s}\right)\right\} .
\end{aligned}
$$

Note that $u\left(x, X_{s}, Y_{s}\right)>\psi\left(s, X_{s}, Y_{s}\right)$ for $t \leq s<\tau_{t}$. Moreover, recall that $(F-\lambda(1+y) u, \psi-u)=0$ a.e., so $\operatorname{Leb}\left\{(x, y) \in \mathcal{C}_{t}: F-\lambda(1+y) u \neq 0\right\}=0 d t$ a.e.. Since the two dimensional diffusion $(X, Y)$ has a density, we deduce that $\mathbb{E}\left[F\left(s, X_{s}, Y_{s}\right)-\lambda\left(1+Y_{s}\right) u\left(s, X_{s}, Y_{s}\right) 1_{\left\{\left(X_{s}, Y_{s}\right) \in \mathcal{C}_{s}\right\}}\right]=0$, and so $F\left(s, X_{s}, Y_{s}\right)-\lambda(1+$ $\left.Y_{s}\right) u\left(s, X_{s}, Y_{s}\right)=0 d s, d \mathbb{P}-$ a.e. on $\left\{s<\tau_{t}\right\}$. Therefore,

$$
\mathbb{E}\left[u\left(\tau_{t}, X_{\tau_{t}}, Y_{\tau_{t}}\right)\right]=\mathbb{E}\left[u\left(t, X_{t}, Y_{t}\right)\right]
$$

and, since $u\left(\tau_{t}, X_{\tau_{t}}, Y_{\tau_{t}}\right)=\psi\left(\tau_{t}, X_{\tau_{t}}, Y_{\tau_{t}}\right)$,

$$
E\left[u\left(t, X_{t}, Y_{t}\right)\right]=\mathbb{E}\left[\psi\left(\tau_{t}, X_{\tau_{t}}, Y_{\tau_{t}}\right)\right] \leq \mathbb{E}\left[u^{*}\left(t, X_{t}, Y_{t}\right)\right]
$$

so that $u\left(t, X_{t}, Y_{t}\right)=u^{*}\left(t, X_{t}, Y_{t}\right)$ a.e.. With the same arguments we can prove that $u(t, x, y)=u^{*}(t, x, y)$ and this concludes the proof.

### 4.5.2 Weaker assumptions on $\psi$

The last step is to establish the equality $u=u^{*}$ under weaker assumptions on $\psi$, so proving Theorem 2.4.
Proof of Theorem 2.4. For every $n \in \mathbb{N}$, with natural notations, we have

$$
u_{n}(t, x, y)=u_{n}^{*}(t, x, y) \quad \text { on }[0, T] \times \overline{\mathcal{O}}
$$

The left hand side converges to $u(t, x, y)$ thanks to the Comparison Principle. As regards the right hand side,

$$
\sup _{\tau \in \mathcal{T}_{t, T}} \mathbb{E}\left[\psi_{n}\left(\tau, X_{\tau}^{t, x, y}, Y_{\tau}^{t, x, y}\right)\right] \rightarrow \sup _{\tau \in \mathcal{T}_{t, T}} \mathbb{E}\left[e^{-r(\tau-t)} \psi\left(\tau, X_{\tau}^{t, x, y}, Y_{\tau}^{t, x, y}\right)\right]
$$

thanks to the uniform convergence of $\psi_{n}$ to $\psi$.
Remark 4.17. It is natural to ask if the assumptions of Theorem 2.4 are not vacuous and to look for payoff functions for which they are indeed satisfied.

Let us consider, for example, the class of payoff functions $\psi=\psi(t, x)=e^{-r t} \bar{\psi}(x+\bar{c} t)$, where $\bar{c}=r-\delta-\frac{\rho \kappa \theta}{\sigma}$ as defined in (2.1) and $\bar{\psi}$ is continuous, positive and such that

$$
|\bar{\psi}|+\left|\bar{\psi}^{\prime}\right| \leq C\left(e^{x}+1\right)
$$

with $C>0$. Note that the standard call and put options fall into this category.
We can show that $\psi$ satisfies the assumptions of Theorem 2.4. In fact, fix $p>\beta+\frac{5}{2}$ and assume $\gamma>p$ in the definition of the measure $\mathfrak{m}$. Note that

$$
|\psi|+\left|\frac{\partial \psi}{\partial t}\right|+\left|\frac{\partial \psi}{\partial x}\right| \leq \Phi(t, x)
$$

where

$$
\Phi(t, x)=C_{T}\left(e^{x-\frac{\rho \kappa \theta}{\sigma} t}+1\right), \quad(t, x) \in[0, T] \times \mathbb{R}
$$

for some $C_{T}>0$. Then, $\psi$ satisfies Assumption $\mathcal{H}^{1}$ since $\psi \in \mathcal{C}([0, T] ; H), \sqrt{1+y} \psi \in L^{2}([0, T] ; V), \psi(T) \in V$ and $\left|\frac{\partial \psi}{\partial t}\right| \leq \Phi$ with $\Phi \in L^{2}([0, T] ; V)$. Moreover, $\Phi$ satisfies Assumption $\mathcal{H}^{2}$ since $\Phi$ has values in $H^{2}(\mathcal{O}, \mathfrak{m})$, $(1+y)^{\frac{3}{2}} \Phi \in L^{2}([0, T], H)$ and, by straightforward computations, $\frac{\partial \Phi}{\partial t}+\mathcal{L} \Phi=0$. Therefore, $\psi$ satisfies the assumptions of Theorem 2.3 and there exists a unique solution of the variational inequality (2.4).

It remains to prove that $\psi$ satisfies the further assumptions required in Theorem 2.4 in order to have the probabilistic representation (4.13). Note that $\Phi \in L^{p}\left([0, T] ; L^{p}(\mathcal{O}, \mathfrak{m})\right)$ and it satisfies Assumption $\mathcal{H}^{*}$. In fact, recall that the discounted and dividend adjusted price process $\left(e^{-(r-\delta) t} S_{t}\right)_{t}=\left(e^{X_{t}-\frac{\rho \kappa \theta}{\sigma} t}\right)_{t}$ is a martingale (we refer to [1D] for an analysis of the martingale property in general affine stochastic volatility models). Therefore, the process $\left(\Phi\left(t, X_{t}\right)\right)_{t \in[0, T]}=C_{T}\left(e^{X_{t}-\frac{\rho \kappa \theta}{\sigma} t}+1\right)_{t \in[0, T]}$ is a martingale, so that $\left(\Phi\left(s, X_{s}\right)\right)_{s \in[t, T]}$ is of class $\mathcal{D}$ for every $(t, x, y) \in[0, T] \times \mathbb{R} \times[0, \infty)$.

Then, recall the following result:

Lemma 4.18. Let $0<\nu_{1}<\nu_{2}$. If $f \in W^{1, p}\left(\mathbb{R}, e^{-\nu_{1}|x|}\right)$ with $p>1$, there exists a sequence $\left(f_{n}\right)$ such that $f_{n} \in W^{2, p}\left(\mathbb{R}, e^{-\nu_{2}|x|}\right)$ and $f_{n}$ converges to $f$ uniformly.

We refer to [11] for a proof. Since $\bar{\psi} \in W^{1, p}\left(\mathbb{R}, e^{-\gamma^{\prime}|x|}\right)$ for every $\gamma^{\prime}>\gamma$, from Lemma 4.18 we deduce the existence of a sequence $\left(\bar{\psi}_{n}\right)_{n} \subseteq W^{2, p}\left(\mathbb{R}, e^{-\gamma|x|}\right)$ which uniformly converges to $\bar{\psi}$. Hence, there exists a sequence $\left(\psi_{n}\right)_{n}$ which converge uniformly to $\psi$ and such that, for every $n \in \mathbb{N}, 0 \leq \psi_{n} \leq \Phi$ and $\psi_{n}$ satisfies Assumption $\mathcal{H}^{1}, \psi_{n} \in L^{2}\left([0, T], H^{2}(\mathcal{O}, \mathfrak{m})\right)$ and $\frac{\partial \psi_{n}}{\partial t}+\mathcal{L} \psi_{n}, \Phi \in L^{p}\left([0, T] ; L^{p}(\mathcal{O}, \mathfrak{m})\right)$.

Therefore, $\psi$ satisfies all the assumptions required in Theorem 2.4 and we can identify the solution of the variational inequality with the solution of the optimal stopping problem, that is the American option price.
