# Numerical analysis with error estimates for the Korteweg-de Vries Equation

#### Abstract

This article deals with the numerical analysis of the Cauchy problem for the Korteweg-de Vries equation with a finite difference scheme. We consider the Rusanov scheme for the hyperbolic flux term and a 4-points $\theta$-scheme for the dispersive term. We prove the convergence under a hyperbolic Courant-Friedrichs-Lewy condition when $\theta \geq \frac{1}{2}$ and under an "Airy" Courant-Friedrichs-Lewy condition when $\theta<\frac{1}{2}$. More precisely, we get the first order convergence rate for strong solutions in the Sobolev space $H^{s}(\mathbb{R}), s \geq 6$ and extend this result to the non-smooth case for initial data in $H^{s}(\mathbb{R})$, with $s \geq \frac{3}{4}$, to the price of a loss in the convergence order. The orders of convergence seem optimal with numerical simulations in some cases, at least when $s \geq 3$.


## 1 Introduction

We are interested in the Korteweg-de Vries equation (called the KdV equation thereafter) which is a model for wave propagation on shallow water surfaces in a channel and was first established by D.J. Korteweg and G. de Vries in 1895 [KdV95]. We focus on the numerical analysis of the Cauchy problem

\begin{cases}\partial_{t} u(t, x)+\partial_{x}\left(\frac{u^{2}}{2}\right)(t, x)+\partial_{x}^{3} u(t, x)=0, & (t, x) \in[0, T] \times \mathbb{R},  \tag{1a}\\ u_{\mid t=0}(x)=u_{0}(x), & x \in \mathbb{R},\end{cases}
$$

for which the local well-posedness in Sobolev spaces $H^{s}(\mathbb{R})$ is well-established. (In particular, well-posedness was proved for $s \geq 2$ in [ST76], $s>\frac{3}{2}$ in [BS75], $s>\frac{3}{4}$ in [KPV91], $s \geq 0$ in [Bou93], $s>-\frac{5}{8}$ in [KPV93], note that one of the first existence result was obtained by proving the convergence of a semi-discrete scheme [Sjö70]). Due to the conservation of the $L^{2}$ norm, this yields global well-posedness for any $s \geq 0$. Note that global well-posedness is even known below $L^{2}$ (see [CKS $\left.{ }^{+} 03\right]$, for example). There are two antagonist effects in the KdV equation: the Burgers nonlinearity tends to create singularities (shock waves, which yield a blow up in finite time) whereas the linear term tends to smooth the solution due to dispersive effects (and creates dispersive oscillating waves of Airy type). In some sense the above global well-posedness results come from the fact that dispersive effects dominate.

Given the practical importance of the KdV equation in concrete physical situations, there exists a wide range of numerical schemes to solve it. A very classical numerical approach is the finite difference method which consists in approximating the exact solution $u$ by a numerical solution $\left(v_{j}^{n}\right)_{(n, j)}$ in such a way that $v_{j}^{n} \approx u\left(t^{n}, x_{j}\right)$ in which $t^{n}=n \Delta t, x_{j}=j \Delta x$ with $\Delta t$ and $\Delta x$ respectively the time and space steps. In most cases, the convergence is ensured only if a stability condition between $\Delta t$ and $\Delta x$ is satisfied. Let us mention for instance the explicit leap-frog scheme designed by Zabusky and Kruskal in [ZK65] with periodic boundaries conditions, or the Lax-Friedrichs scheme studied by Vliegenthart in [Vli71]. Both are formally convergent to the second order in space under a very restrictive stability condition $\Delta t=\mathcal{O}\left(\Delta x^{3}\right)$. The price to pay to avoid a so restrictive stability condition $\Delta t=\mathcal{O}\left(\Delta x^{3}\right)$ is to design formally an implicit scheme, as in [Win80], for example,

[^0]with a twelve-points implicit finite difference scheme with three time levels or in [TA84] with a pentagonal implicit scheme.

The analysis and the rigorous justification of the stability condition started in [Vli71], where Vliegenthart computed rigorously the amplification factor for a linearized equation. More recently, Holden, Koley and Risebro in [HKR15] prove the convergence of the Lax-Friedrichs scheme with an implicit dispersion under the stability condition $\Delta t=\mathcal{O}\left(\Delta x^{\frac{3}{2}}\right)$ without obtaining convergence rates. More precisely, they obtain the strong convergence without rate of the numerical scheme towards a classical solution if $u_{0} \in H^{3}(\mathbb{R})$ and a strong convergence towards a weak solution $L^{2}\left(0, T ; L_{\text {loc }}^{2}(\mathbb{R})\right)$ if $u_{0} \in L^{2}(\mathbb{R})$.

The aim of this paper is to prove rigorously the convergence of some finite difference schemes by analyzing the rate of convergence and in particular its dependence on the regularity of the initial datum.

Let us mention that many types of numerical methods can be used to solve the KdV equation sometimes with the aim of capturing the long time behavior or the low dispersion regime. The equation being Hamiltonian (the Hamiltonian is the energy), symplectic schemes based on compact finite differences that conserve the energy have been designed. We refer for example to [KMY12], [LV06], [AM05]. Splitting methods (the equation being split into the linear Airy part and the nonlinear Burgers part) are also widely studied. For example, a rigorous analysis of such schemes has been performed in [HKRT11], [HLR13]. One can also use spectral methods see [NS89] for example or [HS17] where a Fourier pseudo spectral method is combined with an exponential-type time-integrator. A quite widespread discretization is related to finite element type schemes, see for example [BDK83], [DK85] for Galerkin methods and the recent work [BCKX13] where a non-dissipative scheme is derived and applied to the computation of traveling waves.

In the present paper, we discretize Equation (1a) together with the initial datum (1b) in a finite difference way and our aim is to determine the convergence rate of this numerical scheme. We exhibit the error estimate on the convergence error by a method which suits both non-linear term and dispersive term of KdV.

Let us introduce some notations and present the finite difference scheme here under study.

Notations and numerical scheme We use a uniform time- and space-discretization of (1a). Let $\Delta t$ be the constant time step and $\Delta x$ the constant space step. We note $t^{n}=n \Delta t$ for all $n \in \llbracket 0, N \rrbracket=\{0,1, . ., N\}$ where $N=\left\lfloor\frac{T}{\Delta t}\right\rfloor$ (with $\lfloor$.$\rfloor the integer part) and x_{j}=j \Delta x$ for all $j \in \mathbb{Z}$.

Numerical scheme. Let $c \in \mathbb{R}_{+}^{*}$ and $\theta \in[0,1]$. We denote by $\left(v_{j}^{n}\right)_{(n, j) \in \mathbb{N} \times \mathbb{Z}}$ the discrete unknown defined by the following scheme with parameters $c$ and $\theta$ :

with

If $\theta=0$, we recognize the explicit scheme whereas $\theta=1$ corresponds to the implicit scheme (with respect to the dispersive term). Without the dispersive term $\theta \frac{v_{j+2}^{n+1}-3 v_{j+1}^{n+1}+3 v_{j}^{n+1}-v_{j-1}^{n+1}}{\Delta x^{3}}+(1-\theta) \frac{v_{j+2}^{n}-3 v_{j+1}^{n}+3 v_{j}^{n}-v_{j-1}^{n}}{\Delta x^{3}}$, we recognize the Rusanov scheme applied to the Burgers equation, which consists in a centered hyperbolic flux $\frac{\left(v_{j+1}^{n}\right)^{2}-\left(v_{j-1}^{n}\right)^{2}}{4 \Delta x}$ and an added artificial viscosity $c\left(\frac{v_{j+1}^{n}-2 v_{j}^{n}+v_{j-1}^{n}}{2 \Delta x}\right)$ in order to ensure the stability of the scheme. In the following, the constant $c$ will be called the Rusanov coefficient.

Without the non-linear term and the right hand side, we recognize the $\theta$-right winded finite difference scheme for the Airy equation

Remark 1. All the results are valid with a variable time step $\Delta t^{n}$ and a variable Rusanov coefficient $c^{n}$. For simplicity, we will keep them constant.

Remark 2. The choice of the right winded scheme for the dispersive part is dictated by the result in [Cou16] on numerical schemes applied to high-order dispersive equations $\partial_{t} u+\partial_{x}^{2 p+1} u=0$, with $p \in \mathbb{N}$, which brought to light that right winded schemes are stable under a Courant-Friedrichs-Lewy type condition (CFL-type condition) for $p$ odd (including the Airy equation) and left winded schemes are stable under a CFL-type condition for $p$ even.
Remark 3. This scheme (2)-(3) is a generalization of the one studied by Holden, Koley and Risebro [HKR15]. Indeed, they consider the Lax-Friedrichs scheme for the hyperbolic flux term together with the implicit scheme for the dispersive term, which consists in taking $c \Delta t=\Delta x$ and $\theta=1$ in Scheme (2)-(3).

Discrete operators. For notational convenience for Scheme (2)-(3), let us use the notations introduced in [HKR15] and define the following discrete operators. For any sequence $\left(a_{j}^{n}\right)_{(n, j) \in \mathbb{N} \times \mathbb{Z}}$,

Equation (2) rewrites

Function spaces. In the following, we denote by $H^{r}(\mathbb{R})$, with $r \in \mathbb{R}$, the Sobolev space whose norm is

with $\widehat{u}$ the Fourier transform of $u$. If there is ambiguity, an ' $x$ ' will be added in $H_{x}^{r}$ for the Sobolev space with respect to the space variable.

We study the convergence in the discrete space $\ell^{\infty}\left(\llbracket 0, N \rrbracket, \ell_{\Delta}^{2}(\mathbb{Z})\right)$ whose norm is defined by

for all $a=\left(a^{n}\right)_{n \in \llbracket 0, N \rrbracket}=\left(a_{j}^{n}\right)_{(n, j) \in \llbracket 0, N \rrbracket \times \mathbb{Z}}$. This norm is a relevant discrete equivalent for the $L^{\infty}\left([0, T] ; L^{2}(\mathbb{R})\right)$ norm.

Convergence error. Let $u$ be the exact solution of (1a)-(1b). From $u$, we construct the following sequence

From the averaged exact sequence $\left(\left[u_{\Delta}\right]_{j}^{n}\right)_{(n, j)}$ and the numerical one $\left(v_{j}^{n}\right)_{(n, j)}$, we define two piecewise constant functions $u_{\Delta}$ and $v_{\Delta}$ by, for all $n \in \llbracket 0, N \rrbracket$ and $j \in \mathbb{Z}$,

We define the convergence error by the following difference

Thanks to the definition (7), the convergence error satisfies

Consistency error. We denote by $\left(\epsilon_{j}^{n}\right)_{(n, j) \in \llbracket 0, N \rrbracket \times \mathbb{Z}}$ the consistency error defined by the following relation

Main result In our first main result we handle the case of smooth enough initial data, $u_{0} \in H^{s}(\mathbb{R}), s \geq 6$.
Theorem 1 (Convergence rate in the smooth case). Let $s \geq 6$ and $u_{0} \in H^{s}(\mathbb{R})$. Let $T>0$ and $c>0$ such that the unique global solution $u$ of (1a)-(1b) verifies

Let $\beta_{0} \in(0,1)$ and $\theta \in[0,1]$. There exists $\widehat{\omega_{0}}>0$ such that, for every $\Delta x \leq \widehat{\omega}_{0}$ and $\Delta t$ satisfying

the finite difference scheme (2)-(3) with parameters $c$ and $\theta$ and time- and space discretization steps $\Delta t, \Delta x$ satisfies, for any $\eta \in\left(0, s-\frac{3}{2}\right]$,

In this estimate, $e^{n}$ is defined as in (10)-(8)-(9) and $\Lambda_{T,\left\|u_{0}\right\|_{H^{\frac{3}{4}}}}$ is defined by

in which $C$ is a constant, $\kappa_{\frac{3}{4}}$ and $\kappa$ depend only on $\left\|u_{0}\right\|_{L^{2}(\mathbb{R})}$.
Remark 4. Conditions (13a)-(13b) are Courant-Friedrichs-Lewy-type conditions (in short, CFL conditions). The hypothesis $\left[c+\frac{1}{2}\right] \frac{\Delta t}{\Delta x} \leq 1-\beta_{0}$ seems to be a technical hypothesis, which probably may be replaced with the classical hyperbolic CFL condition $c \Delta t \leq \Delta x$. Indeed, experimental results suit with Theorem 1 with this classical CFL condition, see Section 7.

Remark 5. Thereafter, $\eta$ should be chosen as small as possible, then norms $\left\|u_{0}\right\|_{H^{s+\eta}(\mathbb{R})}$ should be regarded as $\left\|u_{0}\right\|_{H^{s+}(\mathbb{R})}$.
Thus, the scheme (2)-(3) is convergent to the first order in space in the $\ell^{\infty}\left(\llbracket 0, N \rrbracket, \ell_{\Delta}^{2}(\mathbb{Z})\right)$-norm.
In our second main result, we improve the previous result to handle non-smooth initial data $u_{0} \in H^{s}(\mathbb{R})$, $s \geq 3 / 4$. To perform the analysis, we first have to approximate in a suitable way the initial datum. Let $\chi$ be a $\mathcal{C}^{\infty}$-function such that

- $0 \leq \chi \leq 1$,
- $\chi \equiv 1$ in the ball $\mathcal{B}\left(0, \frac{1}{2}\right)$ and $\chi$ is supported in the ball $\mathcal{B}(0,1)$,
- $\chi(-\xi)=\chi(\xi)$.

Let $\varphi$ be such as $\widehat{\varphi}(\xi)=\chi(\xi)$, where $\widehat{\varphi}$ stands for the Fourier transform of $\varphi$, and for all $\delta>0$, we define $\varphi^{\delta}$ such that $\widehat{\varphi^{\delta}}(\xi)=\chi(\delta \xi)$, which implies $\varphi^{\delta}=\frac{1}{\delta} \varphi(\dot{\bar{\delta}})$. Eventually,

- we shall still denote by $u$ the exact solution of (1a) starting from the initial datum $u_{0}$.
- Let $u^{\delta}$ be the solution of (1a) with $u_{0}^{\delta}=u_{0} \star \varphi^{\delta}$ as initial datum, where $\star$ stands for the convolution product.
- We denote then by $\left(v_{j}^{n}\right)_{(n, j) \in \llbracket 0, N \rrbracket \times \mathbb{Z}}$ the numerical solution obtained by applying the numerical scheme (2) from the initial datum $\left(u_{0}^{\delta}\right)_{\Delta}$ :

Theorem 2 (Convergence rate in the non-smooth case). Let $s \geq \frac{3}{4}$ and $u_{0} \in H^{s}(\mathbb{R})$. Let $T>0$ and $c>0$ such that the unique global solution $u$ of (1a)-(1b) verifies

Let $\beta_{0} \in(0,1)$ and $\theta \in[0,1]$. There exists $\widehat{\omega_{0}}>0$ such that for every $\Delta x \leq \widehat{\omega_{0}}$ and $\Delta t$ satisfying

the finite difference scheme (2)-(16) with parameters $c$ and $\theta$ and time- and space discretization steps $\Delta t, \Delta x$ satisfies, for any $\eta \in\left(0, s-\frac{1}{2}\right]$,

$$
\left\|e^{n}\right\|_{\ell^{\infty}\left(\llbracket 0, N \rrbracket, \ell_{\Delta}^{2}(\mathbb{Z})\right)} \leq \Gamma_{T,\left\|u_{0}\right\|_{H^{\frac{3}{4}}}}\left(1+\left\|u_{0}\right\|_{H^{\frac{1}{2}+\eta}}^{2}\right)\left(\frac{1}{c+\frac{1}{2}}+1+\left\|u_{0}\right\|_{H^{\min (1, s)}}\right)\left\|u_{0}\right\|_{H^{s}} \Delta x^{q} .
$$

In this estimate, $e^{n}$ is defined as in (10)-(8)-(9),

- $q=\frac{s}{12-2 s}$ if $\frac{3}{4} \leq s \leq 3$,
- $q=\frac{\min (s, 6)}{6}$ if $3<s$,
and $\Gamma_{T,\left\|u_{0}\right\|_{H^{\frac{3}{4}}}}$ is defined by

$$
\Gamma_{T,\left\|u_{0}\right\|_{H^{\frac{3}{4}}}}=C\left[\Lambda_{T,\left\|u_{0}\right\|_{H^{\frac{3}{4}}}}+\exp \left(\frac{T^{\frac{3}{4}} C_{\frac{3}{4}} e^{\kappa_{\frac{3}{4}}^{4}}}{4}\left\|u_{0}\right\|_{H^{\frac{3}{4}}}\right)\right],
$$

where $\Lambda_{T,\left\|u_{0}\right\|_{H^{\frac{3}{4}}}}$ is defined by (15), C and $C_{\frac{3}{4}}$ are two constants and $\kappa_{\frac{3}{4}}$ depends only on $\left\|u_{0}\right\|_{L^{2}(\mathbb{R})}$.
If $u_{0} \in H^{m}(\mathbb{R})$ with $m \geq 6$, then Theorem 2 implies an order of convergence equal to 1 and we get back the result of Theorem 1. Note that the results are valid for any $T>0$ in agreement with the fact that at this level of regularity we have global solutions keeping their regularity.

To prove Theorem 1, we prove consistency and stability of the scheme. It is in the control of the consistency error that we need the exact solution to be smooth. The most challenging part of the proof is the study of the stability of the scheme in order to take advantage of the fact that the exact solution remains smooth on the whole $[0, T]$. The main idea is to transpose at the discrete level the well known weak-strong stability property for hyperbolic conservation laws that relies on a relative entropy estimate, see [Daf10] for a detailed presentation. This method is classical for the study of hyperbolic systems, see for exemple [CMS16] for the numerical approximation of systems of conservation laws, [Tza05] for a relaxation hyperbolic system or [LV11] for the approximation of shocks and contact discontinuities. An important outcome of this approach is that in the stability estimate, the exponential amplification factor only involves the norm $\int_{0}^{T}\left\|\partial_{x} u(t, .)\right\|_{L^{\infty}} \mathrm{dt}$ of the exact solution, which is bounded thanks to the dispersive properties of the equation. This allows to get the
convergence of the scheme on the full interval of time $[0, T]$ and also to handle less smooth initial data at the price of deteriorating the convergence order as stated in Theorem 2. Indeed in order to prove Theorem 2, we replace the initial data $u_{0}$ with a smoother one $u_{0}^{\delta}$ and just use the triangular inequality

$$
\left\|v_{\Delta}-u_{\Delta}\right\|_{L^{\infty}\left([0, T], L_{x}^{2}\right)} \leq\left\|v_{\Delta}-u_{\Delta}^{\delta}\right\|_{L^{\infty}\left([0, T], L_{x}^{2}\right)}+\left\|u_{\Delta}^{\delta}-u_{\Delta}\right\|_{L^{\infty}\left([0, T], L_{x}^{2}\right)},
$$

where $u_{\Delta}^{\delta}$ is the discretization of the exact solution $u^{\delta}$ of the KdV equation with initial data $u_{0}^{\delta}$. We then use the stability in $L^{2}$ for exact solutions of the KdV equation and the stability estimate of Theorem 1. The amplification factor $\int_{0}^{T}\left\|\partial_{x} u^{\delta}(t, .)\right\|_{L^{\infty}} d t$ is finite and can be bounded independently of $\delta$ as soon as the initial data is in $H^{s}(\mathbb{R})$, with $s \geq 3 / 4$ because of the Strichartz estimate that ensures that at this level of regularity, the exact solution is actually also such that $\partial_{x} u \in L^{4}\left([0, T], L^{\infty}(\mathbb{R})\right)$. We then end the proof by optimizing these estimates in terms of $\delta$ and $\Delta x$.

Outline of the paper In Section 2, we state precisely the results of the Cauchy theory of KdV that we shall use in this paper. Then, in Section 3, we analyze the consistency error of the scheme (postponing the more technical part to the appendix). The aim of Section 4 is to derive the crucial $\ell_{\Delta}^{2}$-stability inequality. We study the discrete equation verified by the convergence error and we obtain the $\ell_{\Delta}^{2}$ estimates. Eventually, the rate of convergence is determined in Section 5.
Section 6 is devoted to the study of the convergence rate for a non smooth solution. A convolution product by mollifiers enables us to counteract the lack of regularity. It requires several general approximation estimates between initial data and regularized initial data which are gathered in Subsection 6.1. The proof of Theorem 2 is developed in Subsection 6.2. Some numerical results illustrate the theoretical rate of convergence in Section 7. Finally, in Appendix A, we prove an estimate of the consistency error in $\ell^{\infty}\left(\llbracket 0, N \rrbracket, \ell_{\Delta}^{2}(\mathbb{Z})\right)$-norm, and in Appendix B, some technical lemmas of Section 4 are proved.

Notation Thereafter, the letter $C$ represents a positive number that may differ from line to line and that can be chosen independently of $\Delta t, \Delta x, u, u_{0}, T$ and $\delta$. We denote by $\kappa$ all numbers depending only on $\left\|u_{0}\right\|_{L^{2}(\mathbb{R})}$.

## 2 Known results on the Cauchy problem for the KdV equation

Let us recall the definition of Bourgain spaces. A tempered distribution $u(t, x)$ on $\mathbb{R}^{2}$ belongs to $X^{s, b}$ if its following norm is finite

$$
\|u\|_{X^{s, b}}=\left(\int_{\mathbb{R}} \int_{\mathbb{R}}(1+|\xi|)^{2 s}\left(1+\left|\tau-\xi^{3}\right|\right)^{2 b}|\tilde{u}(\tau, \xi)|^{2} d \xi d \tau\right)^{\frac{1}{2}}
$$

where $\tilde{u}$ is the space and time Fourier transform of $u$. We shall also use a localized version of this space, $u \in X^{s, b}(I)$ where $I \subset \mathbb{R}$ is an interval if $\|u\|_{X^{s, b}(I)}<+\infty$ where

$$
\|u\|_{X^{s, b}(I)}=\inf \left\{\|\bar{u}\|_{X^{s, b}}, \bar{u}_{/ I}=u\right\} .
$$

By using results from [KPV91], [Bou93], [KPV93], see for example the book [LP15], we get the following theorem.

Theorem 3. Consider $s \geq 0,1>b>1 / 2$. There exists a unique global solution $u$ of (1a)-(1b), with $u_{0} \in H^{s}(\mathbb{R})$, such that for every $T \geq 0, u \in \mathcal{C}\left([0, T], H^{s}(\mathbb{R})\right) \cap X^{s, b}([0, T])$. Moreover, there exists $\kappa_{s}>0$, depending only on $s$ and on the norm $\left\|u_{0}\right\|_{L^{2}}$, and $C_{s}>0$, depending only on $s$, such that, for any $T \geq 0$,
$\bullet \sup _{t \in[0, T]}\|u(t)\|_{H^{s}(\mathbb{R})} \leq C_{s}\left\|u_{0}\right\|_{H^{s}(\mathbb{R})} e^{\kappa_{s} T}$,

- if $s \geq \frac{3}{4}, \quad\left\|\partial_{x} u\right\|_{L^{i}\left([0, T], L^{\infty}(\mathbb{R})\right)} \leq T^{\frac{4-i}{4 i}}\left\|u_{0}\right\|_{H^{\frac{3}{4}(\mathbb{R})}} C_{\frac{3}{4}} e^{\kappa_{\frac{3}{4}}^{4}}, \quad$ for $i \in\{1,2\}$.

The growth rate in the above estimates is not optimal.
Note that a local well-posedness result for $s>3 / 4$ follows directly from [KPV91]. In the present paper, we will be only interested in $s \geq 3 / 4$, nevertheless, to get the global well-posedness for $s \in[3 / 4,1$ ), we need to go through the $L^{2}$ local well-posedness result.

Proof. Let us just briefly explain how we can organize now classical arguments to get the result. We refer for example to [KPV93], [LP15] for the details. The existence is proven by a fixed point argument on the following truncated problem:

$$
v \mapsto F(v)
$$

such that

$$
F(v)(t)=\chi(t) e^{-t \partial_{x}^{3}} u_{0}-\chi(t) \int_{0}^{t} e^{-(t-\tau) \partial_{x}^{3}} \partial_{x}\left(\chi\left(\frac{\tau}{\delta}\right) \frac{v^{2}}{2}(\tau)\right) d \tau
$$

where $\chi \in[0,1]$ is a smooth compactly supported function which is equal to 1 on $[-1,1]$ and supported in $[-2,2]$. For $|t| \leq \delta \leq 1 / 2$, a fixed point of the above equation gives a solution of the original Cauchy problem, denoted by $u$.

Fix $C>0$, that does not depend on $u$, such that

$$
\left\|\chi(t) e^{-t \partial_{x}^{3}} u_{0}\right\|_{X^{0, b}} \leq C\left\|u_{0}\right\|_{L^{2}}
$$

We can first prove that $F$ is a contraction on a suitable ball of $X^{0, b}$, provided $8 C^{2}\left\|u_{0}\right\|_{L^{2}} \delta^{\beta} \leq 1$ for some $\beta>0$ (that is related to $1>b>1 / 2$ ) that does not depend on $\delta$ nor $u$. In particular, for the fixed point, we can ensure that

$$
\|v\|_{X^{0, b}} \leq 2 C\left\|u_{0}\right\|_{L^{2}}
$$

Next, by using again the Duhamel formula, we can obtain, for $s \geq 0$,

$$
\|v\|_{X^{s, b}} \leq c_{s}\left\|u_{0}\right\|_{H^{s}}+c_{s} \delta^{\beta}\|v\|_{X^{0, b}}\|v\|_{X^{s, b}} \leq c_{s}\left\|u_{0}\right\|_{H^{s}}+2 c_{s} C\left\|u_{0}\right\|_{L^{2}} \delta^{\beta}\|v\|_{X^{s, b}}
$$

where $c_{s}$ depends only on $s$. In particular, by choosing $\delta$, possibly smaller than previously, such that $2 c_{s} C\left\|u_{0}\right\|_{L^{2}} \delta^{\beta} \leq$ $1 / 2$, we thus obtain that

$$
\|v\|_{X^{s, b}} \leq 2 c_{s}\left\|u_{0}\right\|_{H^{s}}
$$

Next, by using that the $X^{s, b}$ norm for $b>1 / 2$ controls the $\mathcal{C}\left(\mathbb{R}, H^{s}\right)$ norm (see for example [Tao06] lemma 2.9 page 100), we obtain that

$$
\|u\|_{\mathcal{C}\left([0, \delta], H^{s}(\mathbb{R})\right)} \leq\|v\|_{\mathcal{C}\left(\mathbb{R}, H^{s}(\mathbb{R})\right)} \leq B_{s}\left\|u_{0}\right\|_{H^{s}(\mathbb{R})}
$$

where $B_{s}$ depends only on $s$. Since the existence time $\delta$ depends only on the $L^{2}$-norm of the initial datum and that the $L^{2}$-norm is conserved for the KdV equation, we can iterate the above argument to get a global solution. Moreover, in a quantitative way, by choosing $n=\lfloor T / \delta\rfloor+1$ and iterating $n$ times, we obtain that

$$
\|u\|_{\mathcal{C}\left([0, T], H^{s}\right)}+\|u\|_{X^{s, b}[0, T]} \leq B_{s}^{n}\left\|u_{0}\right\|_{H^{s}} \leq C_{s}\left\|u_{0}\right\|_{H^{s}} e^{\kappa_{s} T}
$$

where $\kappa_{s}$ depends only on $s$ and $\left\|u_{0}\right\|_{L^{2}}$ while $C_{s}$ depends only on $s$.
Finally, since the Strichartz estimate in the KdV context (see [KPV91]) reads

$$
\left\|\left|\partial_{x}\right|^{\frac{1}{4}} e^{-t \partial_{x}^{3}} u_{0}\right\|_{L_{t}^{4}\left(\mathbb{R}, L_{x}^{\infty}\right)} \leq C\left\|u_{0}\right\|_{L^{2}}
$$

by using the embedding properties of the Bourgain spaces (see again [Tao06] lemma 2.9 page 100), we obtain that

$$
\left\|\partial_{x} u\right\|_{L_{t}^{4}\left([0, \delta], L_{x}^{\infty}\right)} \leq\left\|\partial_{x} v\right\|_{L_{t}^{4}\left(\mathbb{R}, L_{x}^{\infty}\right)} \leq\|v\|_{X^{\frac{3}{4}, b}} \leq C\left\|u_{0}\right\|_{H^{\frac{3}{4}}} .
$$

Again by iterating this estimate, we finally obtain that

$$
\left\|\partial_{x} u\right\|_{L_{t}^{4}\left([0, T], L_{x}^{\infty}\right)} \leq C_{\frac{3}{4}}\left\|u_{0}\right\|_{H^{\frac{3}{4}}} e^{\kappa_{\frac{3}{4}}^{4} T}
$$

and the desired estimate follows from the Hölder inequality.

## 3 Consistency error estimate

This section is devoted to the computation of the consistency error defined by Equation (11). As a starting point, by using Theorem 3, we obtain the following estimates on the averaged solution $u_{\Delta}$.

Lemma 1. Let $u$ be the exact solution of (1a)-(1b) from $u_{0} \in H^{s}(\mathbb{R}), s>\frac{1}{2}$ and $u_{\Delta}$ be defined by (9). Then there exists $C>0$, depending only on $s$, and $\kappa_{s}>0$, depending only on $s$ and $\left\|u_{0}\right\|_{L^{2}}$, such that, for any $T \geq 0$ and any $n \in \llbracket 0, N \rrbracket$ with $N=\left\lfloor\frac{T}{\Delta t}\right\rfloor$,

- $\left\|\left(u_{\Delta}\right)^{n}\right\|_{\ell \infty} \leq C e^{\kappa_{s} T}\left\|u_{0}\right\|_{H^{s}}$,
- if $s \geq \frac{3}{4}, \Delta t\left\|D_{+}\left(u_{\Delta}\right)^{n}\right\|_{\ell \infty}^{i} \leq \int_{t^{n}}^{t^{n+1}}\left\|\partial_{x} u(s, .)\right\|_{L_{x}^{\infty}}^{i} d s \leq T^{\frac{4-i}{4 i}} C e^{\kappa_{\frac{3}{4}}^{4} T}\left\|u_{0}\right\|_{H^{\frac{3}{4}}(\mathbb{R})}, \quad$ for $i \in\{1,2\}$.

Proof. The Sobolev embedding $H^{s}(\mathbb{R}) \hookrightarrow L^{\infty}(\mathbb{R})$, for $s>\frac{1}{2}$ yields the inequality

$$
\left\|\left(u_{\Delta}\right)^{n}\right\|_{\ell \infty} \leq \frac{1}{\Delta t} \int_{t^{n}}^{t^{n+1}}\|u(t, .)\|_{L^{\infty}(\mathbb{R})} d t \leq C \sup _{t \in[0, T]}\|u(t, .)\|_{H^{s}(\mathbb{R})}
$$

Theorem 3 implies

$$
\left\|\left(u_{\Delta}\right)^{n}\right\|_{\ell \infty} \leq C C_{s}\left\|u_{0}\right\|_{H^{s}(\mathbb{R})} e^{\kappa_{s} T}
$$

which proves the first estimate of Lemma 1.
To prove Equation (18) for $i=1$, we use a Taylor expansion:

$$
\begin{aligned}
\Delta t\left\|D_{+}\left(u_{\Delta}\right)^{n}\right\|_{\ell \infty} & =\Delta t\left\|\frac{1}{\Delta t \Delta x^{2}} \int_{t^{n}}^{t^{n+1}} \int_{x_{j}}^{x_{j+1}} u(s, y+\Delta x)-u(s, y) d y d s\right\|_{\ell^{\infty}} \\
& =\Delta t\left\|\frac{1}{\Delta x^{2} \Delta t} \int_{t^{n}}^{t^{n+1}} \int_{x_{j}}^{x_{j+1}} \int_{y}^{y+\Delta x} \partial_{x} u(s, z) d z d y d s\right\|_{\ell_{\infty}} \\
& \leq \int_{t^{n}}^{t^{n+1}}\left\|\partial_{x} u(s, .)\right\|_{L_{x}^{\infty}} d s
\end{aligned}
$$

For $i=2$, the same Taylor expansion gives, thanks to the Cauchy-Schwarz inequality,

$$
\begin{aligned}
\Delta t\left\|D_{+}\left(u_{\Delta}\right)^{n}\right\|_{\ell^{\infty}}^{2} & =\Delta t\left\|\frac{1}{\Delta x^{2} \Delta t} \int_{t^{n}}^{t^{n+1}} \int_{x_{j}}^{x_{j+1}} \int_{y}^{y+\Delta x} \partial_{x} u(s, z) d z d y d s\right\|_{\ell^{\infty}}^{2} \\
& \leq \frac{\Delta t}{\Delta x^{4} \Delta t^{2}} \Delta t \Delta x^{2} \int_{t^{n}}^{t^{n+1}} \int_{x_{j}}^{x_{j+1}} \int_{y}^{y+\Delta x}\left\|\partial_{x} u(s, .)\right\|_{L_{x}^{\infty}}^{2} d z d y d s \\
& \leq \int_{t^{n}}^{t^{n+1}}\left\|\partial_{x} u(s, .)\right\|_{L_{x}^{\infty}}^{2} d s .
\end{aligned}
$$

Theorem 3 concludes the proof.

Remark 6. The Sobolev regularity of the initial datum is at least $H^{\frac{3}{4}}(\mathbb{R})$ in Theorem 2 because we need to control $\int_{0}^{T}\left\|\partial_{x} u(t, .)\right\|_{L^{\infty}(\mathbb{R})}^{i} d t$, for $i \in\{1,2\}$ in some of the proofs. This is explicitly needed in Lemma 1, Theorem 3 and in the definition of $\Lambda_{T,\left\|u_{0}\right\|_{\frac{3}{4}}}$ in (15).

As a consequence, we control the $\ell_{\Delta}^{2}$-norm of the consistency error $\epsilon^{n}$ defined in (11) in terms of the initial datum thanks to the following proposition.

Proposition 1. Consider $u_{0} \in H^{s}(\mathbb{R})$, with $s \geq 6$. There exist $C>0$ and $\kappa>0$, depending only on $\left\|u_{0}\right\|_{L^{2}}$, such that for any $\eta \in\left(0, s-\frac{3}{2}\right]$ and for any $T>0$,

$$
\begin{equation*}
\left\|\epsilon^{n}\right\|_{\ell^{\infty}\left(\mathbb{} 0, N \rrbracket ; \ell_{\Delta}^{2}(\mathbb{Z})\right)} \leq C e^{\kappa T}\left(1+\left\|u_{0}\right\|_{H^{\frac{1}{2}+\eta}}^{2}\right)\left\{\Delta t\left\|u_{0}\right\|_{H^{6}}+\Delta x\left[\left\|u_{0}\right\|_{H^{4}}+\left\|u_{0}\right\|_{H^{\frac{3}{2}+\eta}}\left\|u_{0}\right\|_{H^{1}}\right]\right\} \tag{19}
\end{equation*}
$$

Proof. The consistency error satisfies the following inequality (cf. Appendix A for the proof):
$\left\|\epsilon^{n}\right\|_{\ell \infty\left(\left[0, N \rrbracket, \ell_{\Delta}^{2}\right)\right.} \leq B_{1}\left\{\Delta t \sup _{t \in[0, T]}\left[\left(1+\|u\|_{L_{x}^{\infty}}^{2}\right)\|u\|_{H_{x}^{6}}\right]+\Delta x \sup _{t \in[0, T]}\left[\left(1+\|u\|_{L_{x}^{\infty}}\right)\|u\|_{H_{x}^{4}}+\left\|\partial_{x} u\right\|_{L_{x}^{\infty}}\|u\|_{H_{x}^{1}}\right]\right\}$,
with $B_{1}$ a constant that does not depend on $u, u_{0}, T, \Delta t$ and $\Delta x$. By using the Sobolev embedding $H^{\frac{1}{2}+\eta}(\mathbb{R}) \hookrightarrow$ $L^{\infty}(\mathbb{R})$, with $\eta>0$, we obtain

$$
\left\|\epsilon^{n}\right\|_{\ell \infty\left(\llbracket 0, N \rrbracket, \ell_{\Delta}^{2}\right)} \leq B_{1}\left\{\Delta t \sup _{t \in[0, T]}\left[\left(1+\|u\|_{H_{x}^{\frac{1}{2}+\eta}}^{2}\right)\|u\|_{H_{x}^{6}}\right]+\Delta x \sup _{t \in[0, T]}\left[\left(1+\|u\|_{H_{x}^{\frac{1}{x}+\eta}}\right)\|u\|_{H_{x}^{4}}+\|u\|_{H_{x}^{\frac{3}{2}+\eta}}\|u\|_{H_{x}^{1}}\right]\right\} .
$$

Theorem 3 enables to rewrite

$$
\begin{aligned}
\left\|\epsilon^{n}\right\|_{\ell \infty\left(\left[\mathbb{0}, N \rrbracket, \ell_{\Delta}^{2}\right)\right.} \leq \Delta t B_{1} C_{6} C_{\frac{1}{2}+\eta}^{2} e^{\left(2 \kappa_{\frac{1}{2}+\eta}+\kappa_{6}\right) T} & {\left[\left(1+\left\|u_{0}\right\|_{H^{\frac{1}{2}+\eta}}^{2}\right)\left\|u_{0}\right\|_{H^{6}}\right] } \\
& +\Delta x \bar{C} e^{\overline{\kappa T}}\left[\left(1+\left\|u_{0}\right\|_{H^{\frac{1}{2}+\eta}}\right)\left\|u_{0}\right\|_{H^{4}}+\left\|u_{0}\right\|_{H^{\frac{3}{2}+\eta}}\left\|u_{0}\right\|_{H^{1}}\right]
\end{aligned}
$$

with $\bar{C}=\max \left(B_{1} C_{\frac{1}{2}+\eta} C_{4}, B_{1} C_{\frac{3}{2}+\eta} C_{1}, B_{1} C_{4}\right)$ and $\bar{\kappa}=\max \left(\kappa_{\frac{1}{2}+\eta}+\kappa_{4}, \kappa_{\frac{3}{2}+\eta}+\kappa_{1}, \kappa_{4}\right)$.
Inequality (19) follows from the fact that there exists a constant $B_{2} \geq 2$ such that

$$
\left(1+\left\|u_{0}\right\|_{H^{\frac{1}{2}+\eta}}\right) \leq B_{2}\left(1+\left\|u_{0}\right\|_{H^{\frac{1}{2}+\eta}}^{2}\right)
$$

We fix $C=\max \left(B_{1} C_{6} C_{\frac{1}{2}+\eta}^{2}, B_{2} \bar{C}\right)$ and $\kappa=\max \left(2 \kappa_{\frac{1}{2}+\eta}+\kappa_{6}, \bar{\kappa}\right)$.

## 4 Stability estimate

The stability property will be proved in stating a discrete weak-strong stability type inequality : Equation (39). This inequality gives an upper bound of the convergence error at time $n+1$ with convergence error at time $n$. However, some terms $B_{i}$ of (39) are in factor of derivatives on the convergence error $\left(e_{j}^{n}\right)_{(n, j)}$, which are not controlled at this first step: we will cancel those terms in Section 5.

### 4.1 Preliminary results

We here collect some discrete "Leibniz's rules" (Lemma 2), $\ell^{2}$-norm identities (Lemma 3) and discrete integrations by parts formulas (Lemma 4) which will be used in Subsection 4.2. Their proofs lie in Appendix B.

We focus on the derivation of the $\ell_{\Delta}^{2}$-stability inequality (39), which corresponds to a discrete equivalent of a weak-strong estimate.

& +\sum_{j \in \mathbb{Z}} \Delta t \Delta x\left(e_{j}^{n}-(1-\theta) \Delta t D_{+} D_{+} D_{-}(e)_{j}^{n}\right)^{2}+\sum_{j \in \mathbb{Z}} \Delta x \Delta t A_{b}\left[D_{+}(e)_{j}^{n}\right]^{2}+\sum_{j \in \mathbb{Z}} \Delta x \Delta t^{2} A_{c}\left[D(e)_{j}^{n}\right]^{2} \\

## 5 Rate of convergence

In the left hand side of the $\ell_{\Delta}^{2}$-stability inequality (39), $e_{j}^{n+1}$ appears in the operator $I+\Delta t \theta D_{+} D_{+} D_{-}$. The study of this dispersive operator is the aim of Subsection 5.1.

In the right hand side of (39), $D_{+}(e)_{j}^{n}, D_{+} D_{-}(e)_{j}^{n}$ appear in factor of some terms $B_{i}$. Since we have no control on these derivatives of the convergence error, we reorganize terms $B_{i}$ in Subsection 5.2 to obtain nonpositive terms : the $C_{i}$ and $E_{i}$ terms of Corollaries 3 and 4 . We notice that the reorganization is not exactly the same for $\theta \geq \frac{1}{2}$ and $\theta<\frac{1}{2}$, therefore, we state two corollaries.

In Subsection 5.3, the correct CFL hypothesis enables to cancel extra terms $C_{i}$ and $E_{i}$ and an induction method concludes the convergence proof.

### 5.1 Properties of the operator $I+\theta \Delta t D_{+} D_{+} D_{-}$

For more simplicity, we denote by $\mathcal{A}$ the operator

$$
\begin{equation*}
\mathcal{A}=I+\theta \Delta t D_{+} D_{+} D_{-}, \tag{45}
\end{equation*}
$$

where $I$ is the identity operator in $\ell_{\Delta}^{2}(\mathbb{Z})$.
Proposition 3. For every $\Delta t>0$ and $\Delta x>0, \mathcal{A}$ is

- continuous (with a norm depending on $\frac{\Delta t}{\Delta x^{3}}$ ) from $\ell_{\Delta}^{2}$ to $\ell_{\Delta}^{2}$,
- invertible.

Moreover, one has the following inequalities, for any sequence $\left(a_{j}\right)_{j \in \mathbb{Z}} \in \ell_{\Delta}^{2}(\mathbb{Z})$

$$
\begin{equation*}
\|a\|_{\ell_{\Delta}^{2}}^{2} \leq\|\mathcal{A} a\|_{\ell_{\Delta}^{2}}^{2} \leq\left\{1+\frac{16 \theta \Delta t}{\Delta x^{3}}\left[1+\frac{4 \theta \Delta t}{\Delta x^{3}}\right]\right\}\|a\|_{\ell_{\Delta}^{2}}^{2} . \tag{46}
\end{equation*}
$$

Remark 9. Inequality (46) implies that the inverse of $\mathcal{A}$ is continuous from $\ell_{\Delta}^{2}$ to $\ell_{\Delta}^{2}$ with a norm independent of $\frac{\Delta t}{\Delta x^{3}}$.
Proof. Given $a \in \ell_{\Delta}^{2}(\mathbb{Z})$, we may define the function $\widehat{a} \in L^{2}(0,1)$ by

$$
\widehat{a}(\xi)=\sum_{k \in \mathbb{Z}} a_{k} e^{2 i \pi k \xi}, \quad \xi \in(0,1)
$$

(the sequence $a$ is seen as the Fourier-series of the function $\widehat{a}$ ). Parseval identity yields

$$
\begin{equation*}
\sum_{j \in \mathbb{Z}} \Delta x\left|a_{j}\right|^{2}=\Delta x \int_{0}^{1}|\widehat{a}(\xi)|^{2} d \xi \tag{47}
\end{equation*}
$$

We define furthermore the shift operator $\mathcal{S}^{\ell}$ with $\ell \in \mathbb{Z}$ by

$$
\mathcal{S}^{\ell} a=\left(a_{j+\ell}\right)_{j \in \mathbb{Z}},
$$

the associated function verifies

$$
\widehat{\mathcal{S}^{\ell} a}(\xi)=e^{-2 i \pi \ell \xi} \widehat{a}(\xi), \quad \xi \in(0,1) .
$$

The function associated to $\mathcal{A} a$ is

$$
\begin{aligned}
\widehat{\mathcal{A} a}(\xi) & =\widehat{a}+\theta \frac{\Delta t}{\Delta x^{3}} \widehat{a}\left(e^{-4 i \pi \xi}-3 e^{-2 i \pi \xi}+3-e^{2 i \pi \xi}\right), \quad \xi \in(0,1), \\
& =\widehat{a}\left\{1+\theta \frac{\Delta t}{\Delta x^{3}}\left[-2 i e^{-i \pi \xi} \sin (3 \pi \xi)+6 i e^{-i \pi \xi} \sin (\pi \xi)\right]\right\}, \quad \xi \in(0,1)
\end{aligned}
$$

As $\sin (3 \pi \xi)=3 \sin (\pi \xi)-4 \sin ^{3}(\pi \xi)$, we obtain

$$
\widehat{\mathcal{A} a}(\xi)=\widehat{a}\left\{1+8 i \theta \frac{\Delta t}{\Delta x^{3}} e^{-i \pi \xi} \sin ^{3}(\pi \xi)\right\}
$$

The operator $\mathcal{A}$ is thus inversible and its inverse is defined by $\widehat{\mathcal{A}^{-1} a}(\xi)=\frac{1}{1+8 i \theta \frac{\Delta t}{\Delta x^{3}} e^{-i \pi \xi} \sin ^{3}(\pi \xi)} \widehat{a}(\xi)$. Moreover, this operator and its inverse are continuous since

$$
\|\mathcal{A} a\|_{\ell_{\Delta}^{2}}^{2}=\Delta x \int_{0}^{1}\left|1+8 i \theta \frac{\Delta t}{\Delta x^{3}} e^{-i \pi \xi} \sin ^{3}(\pi \xi)\right|^{2}|\widehat{a}(\xi)|^{2} d \xi
$$

and the module $\left|1+8 i \theta \frac{\Delta t}{\Delta x^{3}} e^{-i \pi \xi} \sin ^{3}(\pi \xi)\right|^{2}$ satisfies

$$
\begin{aligned}
\left|1+8 i \theta \frac{\Delta t}{\Delta x^{3}} e^{-i \pi \xi} \sin ^{3}(\pi \xi)\right|^{2} & =\left(1+8 \theta \frac{\Delta t}{\Delta x^{3}} \sin ^{4}(\pi \xi)\right)^{2}+\left(8 \theta \frac{\Delta t}{\Delta x^{3}} \cos (\pi \xi) \sin ^{3}(\pi \xi)\right)^{2} \\
& =1+16 \theta \frac{\Delta t}{\Delta x^{3}} \sin ^{4}(\pi \xi)\left(1+4 \theta \frac{\Delta t}{\Delta x^{3}} \sin ^{2}(\pi \xi)\right) \\
& \in\left[1,1+16 \theta \frac{\Delta t}{\Delta x^{3}}\left(1+4 \theta \frac{\Delta t}{\Delta x^{3}}\right)\right]
\end{aligned}
$$

Thus, the operator $\mathcal{A}$ verifies

$$
\Delta x \int_{0}^{1}|\widehat{a}(\xi)|^{2} d \xi \leq\|\mathcal{A} a\|_{\ell_{\Delta}^{2}}^{2} \leq\left\{1+16 \theta \frac{\Delta t}{\Delta x^{3}}\left(1+4 \theta \frac{\Delta t}{\Delta x^{3}}\right)\right\} \Delta x \int_{0}^{1}|\widehat{a}(\xi)|^{2} d \xi
$$

We conclude by using Identity (47).
Remark 10. The norm of the inverse operator $\mathcal{A}^{-1}$ is upper bounded by 1 (independent of $\frac{\Delta t}{\Delta x^{3}}$ ). This independence is crucial to be able to impose a hyperbolic Courant-Friedrichs-Lewy condition ( $\left[c+\frac{1}{2}\right] \frac{\Delta t}{\Delta x}<1$ ) for $\theta \geq \frac{1}{2}$, to establish Equation (66) for example.

The operator $\mathcal{A}$ enables us to control not only the $\ell_{\Delta^{2}}^{2}$-norm (as proved in Proposition 3) but also an $h_{\Delta^{-}}^{2}$ discrete norm and $h_{\Delta}^{3}$-discrete norm as in the following proposition.
Proposition 4. Let $\mathcal{A}$ be the operator defined by (45), then for any sequence $\left(a_{j}\right)_{j \in \mathbb{Z}}$, one has

$$
\|\mathcal{A} a\|_{\ell_{\Delta}^{2}}^{2}=\|a\|_{\ell_{\Delta}^{2}}^{2}+\theta \Delta t \Delta x\left\|D_{+} D_{-}(a)\right\|_{\ell_{\Delta}^{2}}^{2}+\theta^{2} \Delta t^{2}\left\|D_{+} D_{+} D_{-}(a)\right\|_{\ell_{\Delta}^{2}}^{2} .
$$

Proof. We develop the square of the $\ell_{\Delta}^{2}$-norm of $\left(\mathcal{A} a_{j}\right)_{j \in \mathbb{Z}}$ :
$\sum_{j \in \mathbb{Z}} \Delta x\left(a_{j}+\theta \Delta t D_{+} D_{+} D_{-}(a)_{j}\right)^{2}=\sum_{j \in \mathbb{Z}} \Delta x\left(a_{j}\right)^{2}+\sum_{j \in \mathbb{Z}} 2 \theta \Delta x \Delta t a_{j} D_{+} D_{+} D_{-}(a)_{j}+\sum_{j \in \mathbb{Z}} \theta^{2} \Delta x \Delta t^{2}\left(D_{+} D_{+} D_{-}(a)_{j}\right)^{2}$.
Let us focus on the cross term. Discrete integration by parts (29) together with (31) (with $D_{-}(a)_{j}$ instead of $a_{j}$ ) give

$$
\sum_{j \in \mathbb{Z}} 2 \theta \Delta t \Delta x a_{j} D_{+} D_{+} D_{-}(a)_{j}=-\sum_{j \in \mathbb{Z}} 2 \theta \Delta t \Delta x D_{-}(a)_{j} D_{+} D_{-}(a)_{j}=\sum_{j \in \mathbb{Z}} \theta \Delta t \Delta x^{2}\left(D_{+} D_{-}(a)_{j}\right)^{2}
$$

which concludes the proof.

The following proposition enables to deal with the term $e_{j}^{n}-(1-\theta) \Delta t D_{+} D_{+} D_{-}(e)_{j}^{n}$ in Equation (39).
Proposition 5. For $\theta \in[0,1]$, assume the CFL condition $\Delta t(1-2 \theta) \leq \frac{\Delta x^{3}}{4}$ is satisfied. Then, for any sequence $\left(a_{j}\right)_{j \in \mathbb{Z}}$, it holds

$$
\begin{equation*}
\sum_{j \in \mathbb{Z}} \Delta x\left(a_{j}-(1-\theta) \Delta t D_{+} D_{+} D_{-}(a)_{j}\right)^{2} \leq\|\mathcal{A} a\|_{\ell_{\Delta}^{2}}^{2} \tag{48}
\end{equation*}
$$

Proof. We develop the expression:

$$
\begin{array}{r}
\sum_{j \in \mathbb{Z}} \Delta x\left(a_{j}-(1-\theta) \Delta t D_{+} D_{+} D_{-}(a)_{j}\right)^{2}=\sum_{j \in \mathbb{Z}} \Delta x\left(a_{j}+\theta \Delta t D_{+} D_{+} D_{-}(a)_{j}\right)^{2}-\sum_{j \in \mathbb{Z}} 2 \Delta x \Delta t a_{j} D_{+} D_{+} D_{-}(a)_{j} \\
+\sum_{j \in \mathbb{Z}} \Delta x \Delta t^{2}(1-2 \theta)\left(D_{+} D_{+} D_{-}(a)_{j}\right)^{2}
\end{array}
$$

By applying Relations (29) and (31) (with $D_{-}(a)_{j}$ instead of $a_{j}$ ), the previous equation becomes

$$
\begin{array}{r}
\sum_{j \in \mathbb{Z}} \Delta x\left(a_{j}-(1-\theta) \Delta t D_{+} D_{+} D_{-}(a)_{j}\right)^{2}=\sum_{j \in \mathbb{Z}} \Delta x\left(a_{j}+\theta \Delta t D_{+} D_{+} D_{-}(a)_{j}\right)^{2}-\sum_{j \in \mathbb{Z}} \Delta x^{2} \Delta t\left(D_{+} D_{-}(a)_{j}\right)^{2} \\
+\sum_{j \in \mathbb{Z}} \Delta x \Delta t^{2}(1-2 \theta)\left(D_{+} D_{+} D_{-}(a)_{j}\right)^{2}
\end{array}
$$

If $\theta \geq \frac{1}{2}$, Proposition 5 is proved.
If $\theta<\frac{1}{2}$, thanks to Identity (28), we have

$$
\begin{aligned}
\sum_{j \in \mathbb{Z}} \Delta x\left(a_{j}-(1-\theta) \Delta t D_{+} D_{+} D_{-}(a)_{j}\right)^{2} & =\sum_{j \in \mathbb{Z}} \Delta x\left(a_{j}+\theta \Delta t D_{+} D_{+} D_{-}(a)_{j}\right)^{2}-\sum_{j \in \mathbb{Z}} \Delta x^{2} \Delta t\left(D_{+} D_{-}(a)_{j}\right)^{2} \\
+ & \sum_{j \in \mathbb{Z}} \frac{4 \Delta t^{2}(1-2 \theta)}{\Delta x}\left(D_{+} D_{-}(a)_{j}\right)^{2}-\sum_{j \in \mathbb{Z}} \frac{4 \Delta t^{2}(1-2 \theta)}{\Delta x}\left(D_{+} D(a)_{j}\right)^{2} .
\end{aligned}
$$

Since $\Delta t(1-2 \theta) \leq \frac{\Delta x^{3}}{4}$, the term $\frac{4 \Delta t^{2}(1-2 \theta)}{\Delta x}$ is upper bounded by $\Delta t \Delta x^{2}$, which transforms the previous equation into

$$
\begin{aligned}
\sum_{j \in \mathbb{Z}} \Delta x\left(a_{j}-(1-\theta) \Delta t D_{+} D_{+} D_{-}(a)_{j}\right)^{2} \leq & \sum_{j \in \mathbb{Z}} \Delta x\left(a_{j}+\theta \Delta t D_{+} D_{+} D_{-}(a)_{j}\right)^{2}-\sum_{j \in \mathbb{Z}} \Delta x^{2} \Delta t\left(D_{+} D_{-}(a)_{j}\right)^{2} \\
& +\sum_{j \in \mathbb{Z}} \Delta t \Delta x^{2}\left(D_{+} D_{-}(a)_{j}\right)^{2}-\sum_{j \in \mathbb{Z}} \frac{4 \Delta t^{2}(1-2 \theta)}{\Delta x}\left(D_{+} D(a)_{j}\right)^{2}
\end{aligned}
$$

The conclusion of the proposition is a straightforward consequence, since $1-2 \theta>0$.

### 5.2 Simplification of Inequality (39)

The previous study of the dispersive operator $\mathcal{A}$ enables us to reorganize terms in $\ell_{\Delta}^{2}$-stability inequality (39) in a way simpler to study : signs of new terms are easier to identify. The reorganization is not exactly the same for $\theta \geq \frac{1}{2}$ and $\theta<\frac{1}{2}$, as seen in the two following corollaries of Proposition 2.
Corollary 3 (Corollary of Proposition 2). Consider Scheme (2)-(3). Let $\left(e_{j}^{n}\right)_{(j, n)}$ be the convergence error defined by (10). Then, for every $n \in \llbracket 0, N \rrbracket, \gamma \in\left[0, \frac{1}{2}\right)$ and $\theta \geq \frac{1}{2}$, one has

$$
\begin{align*}
\left\|\mathcal{A} e^{n+1}\right\|_{\ell_{\Delta}^{2}}^{2} \leq & \left\|\mathcal{A} e^{n}\right\|_{\ell_{\Delta}^{2}}^{2}\left[1+\Delta t F_{a}\right]+\Delta t C_{b}\left\|D_{+}(e)^{n}\right\|_{\ell_{\Delta}^{2}}^{2}+\Delta t^{2} C_{c}\left\|D(e)^{n}\right\|_{\ell_{\Delta}^{2}}^{2}+\Delta t C_{e}\left\|D_{+} D(e)^{n}\right\|_{\ell_{\Delta}^{2}}^{2} \\
& +\Delta t C_{f}\left\|D_{+} D_{+} D_{-}(e)^{n}\right\|_{\ell_{\Delta}^{2}}^{2}+\Delta t\left\|\epsilon^{n}\right\|_{\ell_{\Delta}^{2}}^{2}\left\{1+4 \frac{\Delta t}{\Delta x}+\Delta t\right\} \tag{49}
\end{align*}
$$

with

$$
\begin{align*}

& \quad+\left\|D_{+}\left(u_{\Delta}\right)^{n}\right\|_{\ell^{\infty}}^{2}\left[\sqrt{2} \frac{\sqrt{\Delta t}}{\sqrt{\Delta x}}+\frac{\Delta t^{2}}{\Delta x^{2}}\right]+1+2 c^{2} \frac{\Delta t}{\Delta x},  \tag{50a}\\
& C_{b}=\left(\frac{\Delta x}{6} D_{+}(e)_{j}^{n}-c\right)(\Delta x-c \Delta t),  \tag{50b}\\

Remark 11. Corollary 3 is, in fact, true for all $\theta \neq 0$ (if $\theta<\frac{1}{2}$ we have to add the dispersive CFL condition hypothesis $\left.\Delta t(1-2 \theta) \leq \frac{\Delta x^{3}}{4}\right)$, but we essentially use it for $\theta \geq \frac{1}{2}$.
Proof. We choose $\sigma=0$ in Inequality (39).

- First, we upper bound $\left\|e^{n}-(1-\theta) \Delta t D_{+} D_{+} D_{-}(e)^{n}\right\|_{\ell_{\Delta}^{2}}^{2}$ in (39) by $\left\|e^{n}+\theta \Delta t D_{+} D_{+} D_{-}(e)^{n}\right\|_{\ell_{\Delta}^{2}}^{2}$ thanks to Proposition 5.
- We tranform $B_{b}$ in (40b) into

- As a third step, we transform the $B_{d}$-term of (39) (recall that $\sigma=0$ ):

For $\theta \in\left[\frac{1}{2}, 1\right]$, one has $C_{a} \leq F_{a}$ with $F_{a}$ defined in (50a). Finally, we define $C_{c}:=B_{c}$ and $C_{e}:=B_{e}+(1-\theta) \Delta t$ and $C_{f}:=B_{g}+(1-\theta) \frac{\Delta t \Delta x^{2}}{4}$.

Corollary 4 (Corollary of Proposition 2). Consider Scheme (2)-(3). Let $\left(e_{j}^{n}\right)_{(j, n)}$ be the convergence error defined by (10). Then, for every $n \in \llbracket 0, N \rrbracket, \gamma \in\left[0, \frac{1}{2}\right)$ and $\theta<\frac{1}{2}$, one has, if $\Delta t(1-2 \theta) \leq \frac{\Delta x^{3}}{4}$

In the following, we will have to show that $C_{i}$ and $E_{i}$ are non-positive to loop the estimates.

### 5.3 Induction method

We are now able to prove, by induction, the main result for a smooth initial datum: Theorem 1.
Proof of Theorem 1. Let $T>0$ and $s \geq 6$ with $u_{0} \in H^{s}(\mathbb{R})$. Let the Rusanov coefficient $c$ be such that (12) is true. This choice is possible because of Theorem 3 which proves that the exact solution belongs to $L_{x}^{\infty}$ for $t \in[0, T]$.
Remark 13. Thanks to Hypothesis (12) : $\sup _{t \in[0, T]}\|u(t, \cdot)\|_{L^{\infty}(\mathbb{R})}<c$, there exists a constant $\alpha_{0}>0$ such that, for all $\Delta t>0, \Delta x>0$ and for all $n \in \llbracket 0, N \rrbracket$,

Let $\beta_{0} \in(0,1), \theta \in[0,1]$ and $\gamma \in\left(0, \frac{1}{2}\right)$. We fix $\tilde{\omega}_{0}>0$ such that

We also fix $\omega_{0}>0$ such that following Inequalities (56) and (57a)-(57d) if $\theta \geq \frac{1}{2}$ and following Inequalities (56) and (58a)-(58d) if $\theta<\frac{1}{2}$ are verified

- for $\theta \geq \frac{1}{2}$,

\begin{cases}\omega_{0}^{\frac{1}{4}-\frac{\gamma}{2}} \sqrt{\left[\omega_{0}^{\frac{1}{2}-\gamma}+\omega_{0}^{\frac{3}{2}-\gamma}\right]+2 \sup _{t \in[0, T]}\|u(t, \cdot)\|_{L^{\infty}(\mathbb{R})}+\frac{2 c}{3}} \leq \alpha_{0}  \tag{57a}\\ \frac{13\left(1-\beta_{0}\right)}{2 c+1} \omega_{0}^{\frac{1}{2}-\gamma} \leq \beta_{0}, \\ (1-2 \theta)+\frac{(1-\theta) \omega_{0}^{2}}{2}\left[c+\frac{1}{2}+\frac{11}{2} \omega_{0}^{\frac{1}{2}-\gamma}\right] \leq 0, & \text { if } \theta>\frac{1}{2} \\ \frac{11\left(1-\beta_{0}\right)}{2 c+1} \omega_{0}^{\frac{1}{2}-\gamma} \leq \beta_{0}, & \text { if } \theta=\frac{1}{2}\end{cases}
$$

- for $\theta<\frac{1}{2}$,

\omega_{0}^{\frac{1}{4}-\frac{\gamma}{2}} \sqrt{\left[\omega_{0}^{\frac{1}{2}-\gamma}+\omega_{0}^{\frac{3}{2}-\gamma}\right]+2 \sup _{t \in[0, T]}\|u(t, \cdot)\|_{L^{\infty}(\mathbb{R})}+\frac{2 c}{3}} \leq \alpha_{0},  \tag{58a}\\
12 \omega_{0}^{\frac{1}{2}-\gamma} \leq \alpha_{0}, \\
\frac{(1-\theta)\left(1-\beta_{0}\right)}{2(1-2 \theta) c}\left\|\left(u_{\Delta}\right)^{n}\right\|_{\ell \infty} \omega_{0}+\frac{\left(1-\beta_{0}\right)}{3 c+\frac{3}{2}} \omega_{0}^{\frac{1}{2}-\gamma}+\frac{\omega_{0}^{\frac{1}{2}-\gamma}}{3 c} \leq \beta_{0}, \\

Remark 14. These conditions on $\omega_{0}$ are very likely not optimal.
Let us prove by induction on $n \in \llbracket 0, N \rrbracket$ that
if $\Delta x \leq \min \left(\tilde{\omega}_{0}, \omega_{0}\right)$ and if CFL conditions (13a) - (13b) hold, one has $\left\|e^{n}\right\|_{\ell_{\infty}} \leq \Delta x^{\frac{1}{2}-\gamma}$, for all $n \in \llbracket 0, N \rrbracket$
Initialization : For $n=0$, the inequality $\left\|e^{0}\right\|_{\ell \infty} \leq \Delta x^{\frac{1}{2}-\gamma}$ is true because Expressions (3) and (8) imply

Heredity : Let us assume that
if $\Delta x \leq \min \left(\tilde{\omega}_{0}, \omega_{0}\right)$ and if CFL conditions (13a) - (13b) hold, one has $\left\|e^{k}\right\|_{\ell_{\infty}} \leq \Delta x^{\frac{1}{2}-\gamma}$, for all $k \leq n$.
Then our goal is to prove that
if $\Delta x \leq \min \left(\tilde{\omega}_{0}, \omega_{0}\right)$ and if CFL conditions (13a) - (13b) hold, one has $\left\|e^{n+1}\right\|_{\ell_{\infty}} \leq \Delta x^{\frac{1}{2}-\gamma}$.

Step 1 : simplification of Corollaries 3 and 4. Let us prove in this first step that $\Delta x \leq \min \left(\tilde{\omega}_{0}, \omega_{0}\right)$ and CFL conditions (13a)-(13b) imply the non-positivity of extra terms $C_{i}$ and $E_{i}$ in Corollaries 3 and 4 . We dissociate two cases according to the value of $\theta$.

CASE $\theta \geq \frac{1}{2}:$
We show the non-positivity of coefficients $C_{i}$ in Corollary 3, for $i \in\{b, c, e, f\}$.

- Sign of $C_{b}$ : We get by developing $D_{+}(e)_{j}^{n}$

However, by induction hypothesis, one has $\Delta x \leq \omega_{0}$ (with $\omega_{0}$ verifying, among others, Inequality (56)) and $\left\|e^{n}\right\|_{\ell \infty} \leq \Delta x^{\frac{1}{2}-\gamma}$. It gives

As $c \geq \alpha_{0}+\left\|\left(u_{\Delta}\right)^{n}\right\|_{\ell \infty}$ (see Remark 13) and $\Delta x \leq \omega_{0}$ (with $\omega_{0}$ satisfying Inequality (57a)) by induction hypothesis, one has

- Sign of $C_{e}$ : since we suppose $\left\|e^{n}\right\|_{\ell^{\infty}} \leq \Delta x^{\frac{1}{2}-\gamma}$, the term $C_{e}$ satisfies

As $\theta \geq \frac{1}{2}$, then $2(1-\theta) \leq 1$, and, thanks to the choice of $c(12)$, one has

Using $\Delta x \leq \omega_{0}$ and using hyperbolic CFL (13b), one has

which is non-positive if $\Delta x \leq \omega_{0}$. Indeed,

and Condition (13b) together with $\Delta x \leq \omega_{0}$ for $\omega_{0}$ verifying Inequality ( 57 d ) enable us to conclude about the non-positivity of $C_{f}$.

CASE $\theta<\frac{1}{2}:$
In the same way, from Corollary 4 , we show the non-positivity of $E_{i}$, for $i \in\{b, c, d, e\}$.

- Sign of $E_{b}$ : one has, by definition of $E_{b}$ and by hypothesis $\left\|e^{n}\right\|_{\ell \infty} \leq \Delta x^{\frac{1}{2}-\gamma}$

& \leq \frac{\Delta x\left\|e^{n}\right\|_{\ell \infty}}{3}+\frac{c \Delta t\left\|e^{n}\right\|_{\ell \infty}}{3}-c \Delta x+c^{2} \Delta t+2(1-\theta) \frac{\Delta t}{\Delta x}\left\|\left(u_{\Delta}\right)^{n}\right\|_{\ell \infty} \\
& \leq c\left[c \Delta t\left(1+\frac{\Delta x^{\frac{1}{2}-\gamma}}{3 c}\right)-\Delta x\left(1-\frac{\Delta x^{\frac{1}{2}-\gamma}}{3 c}-2(1-\theta) \frac{\Delta t}{\Delta x^{2} c}\left\|\left(u_{\Delta}\right)^{n}\right\|_{\ell \infty}\right)\right] \\

The hyperbolic CFL condition (13b) and the dispersive one (13a) (we recall that $1-2 \theta>0$ in that case) imply

- Sign of $E_{c}$ : since $E_{c}=C_{c}$, we follow exactly the same proof as for $\theta \geq \frac{1}{2}$ to show $E_{c} \leq 0$.
- Sign of $E_{d}$ : thanks to Definition (54d), one has

& \left.\left.+\Delta t(1-\theta)\left\|D_{+}\left(u_{\Delta}\right)^{n}\right\|_{\ell \infty}+\frac{(1-\theta) \Delta x^{2}}{4}\left\{\left\|D_{+}\left(u_{\Delta}\right)^{n}\right\|_{\ell \infty}+\frac{\Delta x}{2}\left\|D_{-}\left(u_{\Delta}\right)^{n}\right\|_{\ell \infty}\right\}\right]-\frac{\Delta x^{3}}{4}\right\}
\end{aligned}
$$

Since $\left\|e^{n}\right\|_{\ell \infty} \leq \Delta x^{\frac{1}{2}-\gamma}$, it becomes, thanks to dispersive CFL (13a),

& \left.\quad+(1-\theta)\left\|u_{\Delta}^{n}\right\|_{\ell \infty} \frac{\left(1-\beta_{0}\right)}{(1-2 \theta)}\left[\frac{\left(1-\beta_{0}\right)}{2(1-2 \theta)} \Delta x^{2}+\frac{\Delta x(2+\Delta x)}{4}\right]-1\right\}
\end{aligned}

Thanks to $\Delta x \leq \omega_{0}$, with $\omega_{0}$ verifying (58d) and thanks to the CFL condition (13a), one has

& -\frac{8 \Delta t^{2}}{\Delta x^{3}}(1-\theta)\left\|\left(u_{\Delta}\right)^{n}\right\|_{\ell \infty} \\
& \leq 2(1-\theta) \Delta t\left\{\left\|\left(u_{\Delta}\right)^{n}\right\|_{\ell \infty}+12 \Delta x^{\frac{1}{2}-\gamma}-c\right\}-\frac{4 \Delta t}{\Delta x^{2}}\left[(1-2 \theta)+\frac{2 \Delta t}{\Delta x}(1-\theta)\left\|\left(u_{\Delta}\right)^{n}\right\|_{\ell \infty}\right] .

## ALL IN ALL:

We have proved that, under the induction hypothesis, the following equality holds, for all $\theta \in[0,1]$

By splitting $F_{a}$ and using the first inequality of (18) to upper bound $\Delta t\left\|D_{+}\left(u_{\Delta}\right)^{n}\right\|_{\ell \infty}$ and $\Delta t\left\|D_{+}\left(u_{\Delta}\right)^{n}\right\|_{\ell^{\infty}}^{2}$, Inequality (60) becomes

\left\|\mathcal{A} e^{n+1}\right\|_{\ell_{\Delta}^{2}}^{2} \leq \exp \left(t^{n+1} F_{b}+\sum_{i=1}^{2} \int_{0}^{t^{n+1}}\left\|\partial_{x} u(s, .)\right\|_{L_{x}^{\infty}(\mathbb{R})}^{i} F_{c, i}\right) \sup _{n \in \llbracket 0, N \rrbracket}\left\|\epsilon^{n}\right\|_{\ell_{\Delta}^{2}}^{2} T\left\{1+4 \frac{\Delta t}{\Delta x}+\Delta t\right\} \tag{64}
\end{equation*}
$$

Finally, Theorem 3 and Proposition 1 give, for $0<\eta \leq 6-\frac{3}{2}$,

\left\|\mathcal{A} e^{n+1}\right\|_{\ell_{\Delta}^{2}}^{2} \leq M^{2}\left(1+\left\|u_{0}\right\|_{H^{\frac{1}{2}+\eta}}^{2}\right)^{2}\left\{\Delta t^{2}\left\|u_{0}\right\|_{H^{6}}^{2}+\Delta x^{2}\left[\left\|u_{0}\right\|_{H^{4}}^{2}+\left\|u_{0}\right\|_{H^{\frac{3}{2}+\eta}}^{2}\left\|u_{0}\right\|_{H^{1}}^{2}\right]\right\} \tag{65}
\end{equation*}
$$

with

$$
\begin{aligned}
M^{2} & =\exp \left(T F_{b}+\left\|u_{0}\right\|_{H^{\frac{3}{4}}} C_{\frac{3}{4}} e^{\kappa_{\frac{3}{4}}^{4} T}\left[F_{c, 1} T^{\frac{3}{4}}+F_{c, 2} T^{\frac{1}{2}}\right]\right) C^{2} e^{2 \kappa T} T\left\{1+4 \frac{\Delta t}{\Delta x}+\Delta t\right\} \\
& \leq \exp \left(C\left(1+c^{2}\right)\left(1+\frac{\Delta t^{2}}{\Delta x^{2}}\right)\left(T+\left(T^{\frac{3}{4}}+T^{\frac{1}{2}}\right)\left\|u_{0}\right\|_{H^{\frac{3}{4}}} e^{\kappa_{\frac{3}{4}} T}\right)\right) C^{2} e^{2 \kappa T} T\left\{1+\frac{\Delta t}{\Delta x}\right\}
\end{aligned}
$$

with $C$ independent of $u_{0}$ and $\kappa, \kappa_{\frac{3}{4}}$ dependent only on $\left\|u_{0}\right\|_{L^{2}}$. Thanks to the CFL condition (13b), an upper bound for $M$ is

M^{2} \leq \Lambda_{T,\left\|u_{0}\right\|_{H^{\frac{3}{4}}}^{2}}
$$

with

\Lambda_{T,\left\|u_{0}\right\|_{H^{\frac{3}{4}}}^{2}}=\exp \left(C\left(1+c^{2}\right)\left(1+\frac{\left(1-\beta_{0}\right)^{2}}{\left(c+\frac{1}{2}\right)^{2}}\right)\left(T+\left(T^{\frac{3}{4}}+T^{\frac{1}{2}}\right)\left\|u_{0}\right\|_{H^{\frac{3}{4}}} e^{\kappa_{\frac{3}{4}} T}\right)\right) C^{2} e^{2 \kappa T} T\left\{1+\frac{1-\beta_{0}}{c+\frac{1}{2}}\right\} .
$$

Since $\left\|e^{n+1}\right\|_{\ell_{\Delta}^{2}}^{2} \leq\left\|\mathcal{A} e^{n+1}\right\|_{\ell_{\Delta}^{2}}^{2}$ (Proposition 3), Inequality (65) gives

\left\|e^{n+1}\right\|_{\ell_{\Delta}^{2}}^{2} & \leq \Lambda_{T,\left\|u_{0}\right\|_{H^{\frac{3}{4}}}^{2}}\left(1+\left\|u_{0}\right\|_{H^{\frac{1}{2}+\eta}}^{2}\right)^{2}\left\{\Delta t^{2}\left\|u_{0}\right\|_{H^{6}}^{2}+\Delta x^{2}\left[\left\|u_{0}\right\|_{H^{4}}^{2}+\left\|u_{0}\right\|_{H^{\frac{3}{2}+\eta}}^{2}\left\|u_{0}\right\|_{H^{1}}^{2}\right]\right\} \\
& \leq \Lambda_{T,\left\|u_{0}\right\|_{H^{\frac{3}{4}}}^{2}}\left(1+\left\|u_{0}\right\|_{H^{\frac{1}{2}+\eta}}^{2}\right)^{2}\left(\frac{\left\|u_{0}\right\|_{H^{6}}^{2}}{\left(c+\frac{1}{2}\right)^{2}}+\left\|u_{0}\right\|_{H^{4}}^{2}+\left\|u_{0}\right\|_{H^{\frac{3}{2}+\eta}}^{2}\left\|u_{0}\right\|_{H^{1}}^{2}\right) \Delta x^{2} \tag{66}
\end{align*}
$$

where the last inequality is obtained thanks to the CFL condition (13b).
Conclusion : It remains to verify the induction hypothesis (59) at step $n+1$. The definition of the $\ell_{\Delta}^{2}$-norm, Identity (7), together with the inclusion $\ell^{2} \subset \ell^{\infty}$, holds

According to the upper bound (66), the $\ell^{\infty}$-norm is bounded as follow

\left\|e^{n+1}\right\|_{\ell \infty} \leq \Lambda_{T,\left\|u_{0}\right\|_{H^{\frac{3}{4}}}}\left(1+\left\|u_{0}\right\|_{H^{\frac{1}{2}+\eta}}^{2}\right)\left(\frac{\left\|u_{0}\right\|_{H^{6}}}{c+\frac{1}{2}}+\left\|u_{0}\right\|_{H^{4}}+\left\|u_{0}\right\|_{H^{\frac{3}{2}+\eta}}\left\|u_{0}\right\|_{H^{1}}\right) \sqrt{\Delta x} .
$$

The choice of a small $\Delta x$ satisfying $\Delta x \leq \min \left(\tilde{\omega}_{0}, \omega_{0}\right)$ with $\tilde{\omega}_{0}$ defined in (55) implies thus $\left\|e^{n+1}\right\|_{\ell \infty} \leq$ $\Delta x^{\frac{1}{2}-\gamma}$. The induction hypothesis is then true for $n+1$.

Thus, we have proved Equation (14) with $\Lambda_{T,\left\|u_{0}\right\|_{H^{\frac{3}{4}}}}$ defined by (15) and $\widehat{\omega_{0}}=\min \left(\omega_{0}, \tilde{\omega}_{0}\right)$.
Remark 15. The choice of a time average in the definition of $u_{\Delta}$, Equation (9), is dictated by the discrete Grönwall Lemma on (64). Indeed, applying discrete Grönwall Lemma introduces the following term $\sum_{n=0}^{N} \Delta t\left\|D_{+}\left(u_{\Delta}\right)^{n}\right\|_{\ell_{\infty}}^{i}$ which is controlled thanks to the estimate (18), where the time integral plays a crucial role.
Regarding the space average in the definition of $u_{\Delta}$, its necessity comes from controlling the sum on $j \in \mathbb{Z}$ in the consistency estimates (75).

Remark 16. This method is a process to find the CFL condition which suits also for the Airy equation

with the finite difference scheme

\end{equation*}
$$

The analogue of Equation (39) is here

\sum_{j \in \mathbb{Z}} \Delta x\left(e_{j}^{n+1}+\right. & \left.\theta \Delta t D_{+} D_{+} D_{-}(e)_{j}^{n+1}\right)^{2} \leq\{1+\Delta t\} \sum_{j \in \mathbb{Z}}\left(e_{j}^{n}+\theta \Delta t D_{+} D_{+} D_{-}(e)_{j}^{n}\right)^{2} \\
& +\sum_{j \in \mathbb{Z}} \Delta x \Delta t \underbrace{\{1+\Delta t\}\left\{(1-2 \theta) \Delta t-\frac{\Delta x^{3}}{4}\right\}}_{C_{f}^{\text {Airy }}}\left[D_{+} D_{+} D_{-}(e)_{j}^{n}\right]^{2}+\sum_{j \in \mathbb{Z}} \Delta x \Delta t\{1+\Delta t\}\left(\epsilon_{j}^{n}\right)^{2}
\end{aligned}
$$

Imposing $C_{f}^{\text {Airy }} \leq 0$ (which corresponds to Step 1 in the previous proof of Theorem 1) leads to

\Delta t(1-2 \theta) \leq \frac{\Delta x^{3}}{4}
$$

This so-called Courant-Friedrichs-Lewy condition, in the case $\theta=0$, is exactly the one which is obtained in [Men83] with a computation of the zeros of the amplification factor in [Men83] and the one obtained by the Fourier method. Indeed, the amplification factor obtained by Fourier analysis on Airy equation is

\frac{1-8 \frac{(1-\theta) \Delta t}{\Delta x^{3}} \sin ^{4}(\pi \xi)-8 i \frac{(1-\theta) \Delta t}{\Delta x^{3}} \sin ^{3}(\pi \xi) \cos (\pi \xi)}{1+8 \frac{\theta \Delta t}{\Delta x^{3}} \sin ^{4}(\pi \xi)+8 i \frac{\theta \Delta t}{\Delta x^{3}} \sin ^{3}(\pi \xi) \cos (\pi \xi)}, \quad \xi \in(0,1)
$$

Requiring that its modulus is less than 1 yields

Remark 17. For a Rusanov finite difference scheme applied to the non-linear term of the KdV equation: the Burgers equation

which corresponds to the discrete equation

\frac{v_{j}^{n+1}-v_{j}^{n}}{\Delta t}+\frac{\left(v_{j+1}^{n}\right)^{2}-\left(v_{j-1}^{n}\right)^{2}}{4 \Delta x}=c\left(\frac{v_{j+1}^{n}-2 v_{j}^{n}+v_{j-1}^{n}}{2 \Delta x}\right), \quad(n, j) \in \llbracket 0, N \rrbracket \times \mathbb{Z}, \tag{68}
\end{equation*}
$$

the analogue of Equation (39) would be

\left\|e^{n+1}\right\|_{\ell_{\Delta}^{2}}^{2} \leq\left\|e^{n}\right\|_{\ell_{\Delta}^{2}}^{2}\left\{1+\Delta t F_{a}^{\text {Burgers }}\right\}+\sum_{j \in \mathbb{Z}} \Delta x \Delta t C_{b}^{\text {Burgers }}\left[D_{+}(e)_{j}^{n}\right]^{2}+ & \sum_{j \in \mathbb{Z}} \Delta x \Delta t^{2} C_{c}^{\text {Burgers }}\left[D(e)_{j}^{n}\right]^{2} \\
& +\sum_{j \in \mathbb{Z}} \Delta x \Delta t\left(\epsilon_{j}^{n}\right)^{2}\left\{4 \frac{\Delta t}{\Delta x}+\Delta t\right\}
\end{aligned}
$$

with

$$
\begin{gathered}
F_{a}^{\text {Burgers }}=\left\|u_{\Delta}^{n}\right\|_{\ell \infty}^{2}+\left\|D_{+}\left(u_{\Delta}\right)^{n}\right\|_{\ell \infty}\left(1+\frac{\Delta t}{\Delta x}\left[2 c+\frac{2}{3}\left\|e^{n}\right\|_{\ell \infty}+\frac{3}{2}\left\|u_{\Delta}^{n}\right\|_{\ell \infty}\right]\right) \\
\\
+\frac{\Delta t^{2}}{\Delta x^{2}}\left\|D_{+}\left(u_{\Delta}\right)^{n}\right\|_{\ell^{\infty}}^{2}+\frac{\Delta t}{\Delta x}\left(\left\|\left(u_{\Delta}\right)^{n}\right\|_{\ell^{\infty}}^{2}+2 c^{2}\right), \\
C_{b}^{\text {Burgers }}=\left(\frac{\Delta x}{6} D_{+}(e)_{j}^{n}-c\right)(\Delta x-c \Delta t),
\end{gathered}
$$

and

C_{c}^{\text {Burgers }}=\left\|e^{n}\right\|_{\ell^{\infty}}^{2}[1+\Delta x]+\left\|u_{\Delta}^{n}\right\|_{\ell_{\infty}}^{2}-c^{2}+2\left\|e^{n}\right\|_{\ell \infty}\left\|u_{\Delta}^{n}\right\|_{\ell \infty}+\frac{2 c}{3}\left\|e^{n}\right\|_{\ell \infty}
$$

Therefore, for $u_{0} \in H^{\frac{3}{2}}(\mathbb{R})$ and for $\Delta x$ small enough, the well-known CFL condition is verified

c \Delta t \leq \Delta x
$$

(thanks to the condition $C_{b}^{\text {Burgers }} \leq 0$ ) and the well-known condition for the Rusanov coefficient is verified

$$
\left\|u_{\Delta}^{n}\right\|_{\ell \infty}<c
$$

(thanks to the condition $C_{c}^{\text {Burgers }} \leq 0$ ).
Remark 18. For Burgers equation, we know a natural bound for the convergence error: thanks to the maximum principle one has $\left\|e^{n}\right\|_{\ell \infty} \leq 2\left\|u_{0}\right\|_{L^{\infty}}$.

## 6 Convergence for less smooth initial data

In this section, we relax the hypothesis $u_{0} \in H^{6}(\mathbb{R})$ and adapt the previous proof for any solution in $H^{\frac{3}{4}}(\mathbb{R})$ to obtain Theorem 2. When $u_{0}$ is not smooth enough to verify $u_{0} \in H^{6}(\mathbb{R})$, we regularize it thanks to mollifiers $\left(\varphi^{\delta}\right)_{\delta>0}$, as explained in Introduction. Recall that we denote the mollifiers by $\left(\varphi^{\delta}\right)_{\delta>0}$, whose construction is based on $\chi$ a $\mathcal{C}^{\infty}$-function such that $\chi \equiv 1$ on $\left[-\frac{1}{2}, \frac{1}{2}\right], \chi$ is supported in $[-1,1]$ and $\chi(\xi)=\chi(-\xi)$. We denote the exact solution from $u_{0}$ by $u$, the exact solution from $u_{0} \star \varphi^{\delta}$ by $u^{\delta}$ and the numerical solution from (16) by $\left(v_{j}^{n}\right)_{(n, j) \in \llbracket 0, N \rrbracket \times \mathbb{Z}}$.

### 6.1 Approximation results

We need to quantify the dependence of the Sobolev norms of the solution $u^{\delta}$ on $\delta$. That result is gathered in Proposition 6 whose proof needs the following lemma.

Lemma 9. Assume $(m, s) \in \mathbb{R}^{2}$ with $m \geq s \geq 0$. There exists a constant $C>0$ such that, if $u_{0} \in H^{s}(\mathbb{R})$ and $\delta>0$ and $u_{0}^{\delta}$ is such as $u_{0}^{\delta}=u_{0} \star \varphi^{\delta}$, then

\begin{equation*}
\left\|u_{0}^{\delta}\right\|_{H^{m}(\mathbb{R})} \leq \frac{C}{\delta^{m-s}}\left\|u_{0}\right\|_{H^{s}(\mathbb{R})} \tag{69}
\end{equation*}
$$

Proof. According to (6), the $H^{m}(\mathbb{R})$-norm of $u_{0}^{\delta}$ verifies

\left\|u_{0} \star \varphi^{\delta}\right\|_{H^{m}(\mathbb{R})}^{2} & =\int_{\mathbb{R}}\left(1+|\xi|^{2}\right)^{m}|\chi(\delta \xi)|^{2}\left|\widehat{u_{0}}(\xi)\right|^{2} d \xi \\
& \leq \int_{\mathbb{R}}\left(1+|\xi|^{2}\right)^{s}\left|\widehat{u_{0}}\right|^{2}\left(1+|\xi|^{2}\right)^{m-s}|\chi(\delta \xi)|^{2} d \xi
\end{aligned}
$$

By hypothesis on $\chi$ and its support, one has $|\chi(\delta \xi)| \leq 1$ and there exists a constant $C>0$ such that $\left(1+|\xi|^{2}\right)^{m-s}|\chi(\delta \xi)|^{2} \leq \frac{C}{\delta^{2(m-s)}}$, which concludes the proof.

We are now able to estimate the Sobolev norms of $u^{\delta}$.
Proposition 6. Assume $m \geq s \geq 0$ and $u_{0} \in H^{s}(\mathbb{R})$ then,

$$
\sup _{t \in[0, T]}\left\|u^{\delta}(t, .)\right\|_{H^{m}(\mathbb{R})} \leq C e^{\kappa_{m} T} \frac{\left\|u_{0}\right\|_{H^{s}(\mathbb{R})}}{\delta^{m-s}},
$$

where $C$ is a number which depends on $m$ and $\kappa_{m}$ depends on $\left\|u_{0}\right\|_{L^{2}}$ and $m$. Both are independent of $\delta$.
Proof. We combine Theorem 3 and Lemma 9.
We need then to know the rate of convergence of $u_{0}^{\delta}$ toward $u_{0}$ with respect to $\delta$ (as $\delta$ tends to 0 ), which is summarized as follows.

Lemma 10. Assume $u_{0} \in H^{s}(\mathbb{R})$ with $0 \leq \ell \leq s$, then, there exists a number $C$ independent of $\delta$ such that

$$
\left\|u_{0}-u_{0}^{\delta}\right\|_{H^{\ell}(\mathbb{R})} \leq C \delta^{s-\ell}\left\|u_{0}\right\|_{H^{s}(\mathbb{R})}
$$

Proof. By definition of the $H^{\ell}(\mathbb{R})$-norm, we have, for $s \geq \ell$ :

\left\|u_{0}-u_{0}^{\delta}\right\|_{H^{\ell}(\mathbb{R})}^{2} & =\int_{\mathbb{R}}\left(1+|\xi|^{2}\right)^{\ell}\left|\widehat{u_{0}}(\xi)\right|^{2}(1-\chi(\delta \xi))^{2} d \xi \\
& =\delta^{2(s-\ell)} \int_{\mathbb{R}}\left(1+|\xi|^{2}\right)^{\ell}\left|\widehat{u_{0}}(\xi)\right|^{2}\left(\frac{1-\chi(\delta \xi)}{(\delta \xi)^{s-\ell}}\right)^{2} \xi^{2(s-\ell)} d \xi
\end{aligned}
$$

Hypothesis on $\chi$ implies that $\sup _{z \in \mathbb{R}}\left|\frac{1-\chi(z)}{z^{s-\ell}}\right| \leq C_{2}$ for a certain constant $C_{2}$. Hence, by using the inequality $\left(1+|\xi|^{2}\right)^{\ell}|\xi|^{2(s-\ell)} \leq C\left(1+|\xi|^{2}\right)^{s}$, with $C$ a constant,

\begin{aligned}
\left\|u_{0}-u_{0}^{\delta}\right\|_{H^{\ell}(\mathbb{R})}^{2} & \leq \delta^{2(s-\ell)} C C_{2}^{2} \int_{\mathbb{R}}\left(1+|\xi|^{2}\right)^{s}\left|\widehat{u_{0}}(\xi)\right|^{2} d \xi \\
& \leq C C_{2}^{2} \delta^{2(s-\ell)}\left\|u_{0}\right\|_{H^{s}(\mathbb{R})}^{2} .
\end{aligned}
$$

### 6.2 Proof of Theorem 2

Let $s \geq \frac{3}{4}$. Assume $u_{0} \in H^{s}(\mathbb{R}), T>0$ and $c$ such that (12) is true, which implies the existence of $\alpha_{0}$ as in Remark 13. We construct $u_{0}^{\delta}=u_{0} \star \varphi^{\delta}$ as previously.
Let $\beta_{0} \in(0,1), \theta \in[0,1]$ and $\left(v_{j}^{n}\right)_{(n, j) \in \llbracket 0, N \rrbracket \times \mathbb{Z}}$ the unknown of the numerical scheme (2)-(16). Thanks to Theorem 1, there exists $\widehat{\omega_{0}}>0$ such that for every $\Delta x \leq \widehat{\omega_{0}}$ and $\Delta t$ satisfying CFL conditions (13a)-(13b), one has

\left\|v^{n}-\left(u_{\Delta}^{\delta}\right)^{n}\right\|_{\ell_{\Delta}^{2}} \leq \Lambda_{T,\left\|u_{0}^{\delta}\right\|_{H^{\frac{3}{4}}}}\left(1+\left\|u_{0}^{\delta}\right\|_{H^{\frac{1}{2}+\eta}}^{2}\right)\left(\frac{\left\|u_{0}^{\delta}\right\|_{H^{6}}}{c+\frac{1}{2}}+\left\|u_{0}^{\delta}\right\|_{H^{4}}+\left\|u_{0}^{\delta}\right\|_{H^{\frac{3}{2}+\eta}}\left\|u_{0}^{\delta}\right\|_{H^{1}}\right) \Delta x
$$

with $\Lambda_{T,\left\|u_{0}^{\delta}\right\|_{H^{\frac{3}{4}}}}$ defined by (15).
Remark 19. Thanks to Theorem $1, \widehat{\omega_{0}}$ is such that $\widehat{\omega_{0}} \leq \tilde{\omega}_{0}$ with

$$
\begin{equation*}
\tilde{\omega}_{0}=\left[\Lambda_{T,\left\|u_{0}^{\delta}\right\|_{H^{\frac{3}{4}}}}\left(1+\left\|u_{0}^{\delta}\right\|_{H^{\frac{1}{2}+\eta}}^{2}\right)\left(\frac{\left\|u_{0}^{\delta}\right\|_{H^{6}}}{c+\frac{1}{2}}+\left\|u_{0}^{\delta}\right\|_{H^{4}}+\left\|u_{0}^{\delta}\right\|_{H^{\frac{3}{2}+\eta}}\left\|u_{0}^{\delta}\right\|_{H^{1}}\right)\right]^{-\frac{1}{\gamma}}, \tag{70}
\end{equation*}
$$

where $\Lambda_{T,\left\|u_{0}^{\delta}\right\|_{H^{\frac{3}{4}}}}$ is defined in (15).
By using a triangle inequality between the analytical solution starting from $u_{0}$ and the one starting from $u_{0}^{\delta}$, the global error is upper bounded by

with
$\left[B_{1}\right]^{n}=\sum_{j \in \mathbb{Z}} \Delta x\left(\frac{1}{\Delta x\left[\inf \left(t^{n+1}, T\right)-t^{n}\right]} \int_{t^{n}}^{\inf \left(t^{n+1}, T\right)} \int_{x_{j}}^{x_{j+1}} u(s, x)-u^{\delta}(s, x) d x d s\right)^{2}=\sum_{j \in \mathbb{Z}} \Delta x\left(\left(u_{\Delta}\right)_{j}^{n}-\left[u_{\Delta}^{\delta}\right]_{j}^{n}\right)^{2}$,
with the notation (9), and

$$
\left[B_{2}\right]^{n}=\sum_{j \in \mathbb{Z}} \Delta x\left(\frac{1}{\Delta x\left[\inf \left(t^{n+1}, T\right)-t^{n}\right]} \int_{t^{n}}^{\inf \left(t^{n+1}, T\right)} \int_{x_{j}}^{x_{j+1}} u^{\delta}(s, x) d x d s-v_{j}^{n}\right)^{2}=\sum_{j \in \mathbb{Z}} \Delta x\left(\left[u_{\Delta}^{\delta}\right]_{j}^{n}-v_{j}^{n}\right)^{2}
$$

Let us first focus on term $\left[B_{1}\right]^{n}$. The Cauchy-Schwarz inequality implies $\left[B_{1}\right]^{n} \leq \sup _{t \in[0, T]}\left\|u(t, .)-u^{\delta}(t, .)\right\|_{L^{2}(\mathbb{R})}^{2}$, which imposes to study the difference between $u$ and $u^{\delta}$.
Since $u$ and $u^{\delta}$ are two solutions of the initial equation (1a), one has

\partial_{t}\left(u-u^{\delta}\right)+\partial_{x}^{3}\left(u-u^{\delta}\right)+u \partial_{x}\left(u-u^{\delta}\right)+\left(u-u^{\delta}\right) \partial_{x} u^{\delta}=0
$$

Multiplying by $\left(u-u^{\delta}\right)$, integrating the equation and changing $u^{\delta}$ in $u-\left(u-u^{\delta}\right)$ in the latest term yield

\begin{aligned}
\frac{d}{d t} \int_{\mathbb{R}} \frac{\left(u(t, x)-u^{\delta}(t, x)\right)^{2}}{2} d x-\int_{\mathbb{R}} \partial_{x} u(t, x) & \frac{\left(u(t, x)-u^{\delta}(t, x)\right)^{2}}{2} d x \\
& +\int_{\mathbb{R}}\left(u(t, x)-u^{\delta}(t, x)\right)^{2} \partial_{x}\left[u(t, x)-\left(u(t, x)-u^{\delta}(t, x)\right)\right] d x=0
\end{aligned}
$$

thus

$$
\frac{d}{d t} \frac{\left\|u(t, .)-u^{\delta}(t, .)\right\|_{L^{2}(\mathbb{R})}^{2}}{2} \leq \frac{\left\|\partial_{x} u(t, .)\right\|_{L^{\infty}(\mathbb{R})}}{2}\left\|u(t, .)-u^{\delta}(t, .)\right\|_{L^{2}(\mathbb{R})}^{2}
$$

The previous inequality looks like the 'weak-strong uniqueness' of DiPerna [DiP79] or Dafermos [Daf79, Daf10].
The $L^{2}(\mathbb{R})$-norm of the difference $u-u^{\delta}$ is then upper bounded by

\begin{aligned}
\left\|u(t, .)-u^{\delta}(t, .)\right\|_{L^{2}(\mathbb{R})}^{2} & \leq \exp \left(\int_{0}^{t} \frac{\left\|\partial_{x} u(s, .)\right\|_{L^{\infty}(\mathbb{R})}}{2} d s\right)\left\|u_{0}-u_{0}^{\delta}\right\|_{L^{2}(\mathbb{R})}^{2} \\
& \leq \exp \left(\frac{T^{\frac{3}{4}} C_{\frac{3}{4}} e^{\kappa_{\frac{3}{4}}^{4}}}{2}\left\|u_{0}\right\|_{H^{\frac{3}{4}}}\right)\left\|u_{0}-u_{0}^{\delta}\right\|_{L^{2}(\mathbb{R})}^{2}
\end{aligned}
$$

where $\kappa_{\frac{3}{4}}$ and $C_{\frac{3}{4}}$ are defined in Theorem 3. Then

$$
\left[B_{1}\right]^{n} \leq \sup _{t \in[0, T]}\left\|u(t, .)-u^{\delta}(t, .)\right\|_{L^{2}(\mathbb{R})}^{2} \leq \exp \left(\frac{T^{\frac{3}{4}} C_{\frac{3}{4}} e^{\kappa_{\frac{3}{4}}^{4} T}}{2}\left\|u_{0}\right\|_{H^{\frac{3}{4}}}\right)\left\|u_{0}-u_{0}^{\delta}\right\|_{L^{2}(\mathbb{R})}^{2}
$$

Lemma 10 implies

$$
\begin{equation*}
\left[B_{1}\right]^{n} \leq C^{2} \delta^{2 s}\left\|u_{0}\right\|_{H^{s}(\mathbb{R})}^{2} \exp \left(\frac{T^{\frac{3}{4}} C_{\frac{3}{4}} e^{\kappa_{\frac{3}{4}}^{4} T}}{2}\left\|u_{0}\right\|_{H^{\frac{3}{4}}}\right) \tag{71}
\end{equation*}
$$

In the other hand, the term $\left[B_{2}\right]^{n}$ corresponds to the estimate (66) derived in Subsection 5.3 with a smooth initial datum. It remains us to quantify the dependency of it upper bound with respect to $\delta$. Thanks to Theorem 1 , one has

$$
\sqrt{\left[B_{2}\right]^{n}} \leq \Lambda_{T,\left\|u_{0}^{\delta}\right\|_{H^{\frac{3}{4}}}}\left(1+\left\|u_{0}^{\delta}\right\|_{H^{\frac{1}{2}+\eta}}^{2}\right)\left(\frac{\left\|u_{0}^{\delta}\right\|_{H^{6}}}{c+\frac{1}{2}}+\left\|u_{0}^{\delta}\right\|_{H^{4}}+\left\|u_{0}^{\delta}\right\|_{H^{\frac{3}{2}+\eta}}\left\|u_{0}^{\delta}\right\|_{H^{1}}\right) \Delta x
$$

with $\Lambda_{T,\left\|u_{0}^{\delta}\right\|_{H^{\frac{3}{4}}}}$ defined by (15). As $u_{0}$ belongs to $H^{s}(\mathbb{R})$ with $s \geq \frac{3}{4}$, then $\left\|u_{0}^{\delta}\right\|_{H^{\frac{3}{4}}}=\left\|u_{0}\right\|_{H^{\frac{3}{4}}}$ and $\left\|u_{0}^{\delta}\right\|_{H^{\frac{1}{2}+\eta}}=\left\|u_{0}\right\|_{H^{\frac{1}{2}+\eta}}$.
Lemma 11. For every $s \geq \frac{3}{4}$, there exists $C$, depending only on $s$ and on $\left\|u_{0}\right\|_{L^{2}}$, such that, if $u_{0} \in H^{s}(\mathbb{R})$,

\frac{\left\|u_{0}^{\delta}\right\|_{H^{6}}}{c+\frac{1}{2}}+\left\|u_{0}^{\delta}\right\|_{H^{4}}+\left\|u_{0}^{\delta}\right\|_{H^{\frac{3}{2}+\eta}}\left\|u_{0}^{\delta}\right\|_{H^{1}} \leq \frac{\left\|u_{0}\right\|_{H^{s}}}{\delta^{6-s}} C\left(\frac{1}{c+\frac{1}{2}}+1+\left\|u_{0}\right\|_{H^{\min (1, s)}}\right)
$$

Proof. We apply Lemma 9 with $s=6,4, \frac{3}{2}+\eta, 1$ and the biggest power of $\delta$ is $\frac{1}{\delta^{6-s}}$.
Thus, an upper bound for $\left[B_{2}\right]^{n}$ is

However, for Theorem 1 to be applied, we need to choose a small $\Delta x$ such that $\Delta x \leq \widehat{\omega_{0}} \leq \tilde{\omega}_{0}$ where $\tilde{\omega}_{0}$ is defined by (70). With the above lemma, this condition rewrites

\Delta x \leq\left[\Lambda_{T,\left\|u_{0}\right\|_{H^{\frac{3}{4}}}}\left(1+\left\|u_{0}\right\|_{H^{\frac{1}{2}+\eta}}^{2}\right)\left(\frac{1}{c+\frac{1}{2}}+1+\left\|u_{0}\right\|_{H^{\min (1, s)}}\right) C \frac{\left\|u_{0}\right\|_{H^{s}}}{\delta^{6-s}}\right]^{-\frac{1}{\gamma}}=\left(\frac{\tilde{C}}{\delta^{6-s}}\right)^{-\frac{1}{\gamma}} \tag{72}
\end{equation*}
$$

Hence, if $\Delta x \leq\left(\frac{\tilde{C}}{\delta^{6-s}}\right)^{-\frac{1}{\gamma}}$, with $\tilde{C}>0$ a constant depending on $T, c, \beta_{0},\left\|u_{0}\right\|_{H^{s}}$ and $\left\|u_{0}\right\|_{H^{\frac{3}{4}}}$ and if CFL conditions (13a)-(13b) are verified, the convergence error $\left(e_{j}^{n}\right)_{(n, j)}$ is upper bounded by

$$
\begin{align*}
& \left\|e^{n}\right\|_{\ell_{\Delta}^{2}} \\
\leq & C\left[\Lambda_{T,\left\|u_{0}\right\|_{H^{\frac{3}{4}}}}\left(1+\left\|u_{0}\right\|_{H^{\frac{1}{2}+\eta}}^{2}\right)\left(\frac{1}{c+\frac{1}{2}}+1+\left\|u_{0}\right\|_{H^{\min (1, s)}}\right)+\exp \left(\frac{T^{\frac{3}{4}} C_{\frac{3}{4}} e^{\kappa_{\frac{3}{4}}^{4}}}{4}\left\|u_{0}\right\|_{H^{\frac{3}{4}}}\right)\right]\left\|u_{0}\right\|_{H^{s}}\left[\frac{\Delta x}{\delta^{6-s}}+\delta^{s}\right], \tag{73}
\end{align*}
$$

for $n \in \llbracket 0, N \rrbracket$.
The final key point is to find the optimal $\delta$, in other words, the parameter $\delta$ which makes both terms $\delta^{s}$, coming from $\sqrt{\left[B_{1}\right]^{n}}$ and $\frac{\Delta x}{\delta^{6-s}}$ coming from $\sqrt{\left[B_{2}\right]^{n}}$ in (73) equal while respecting the constraint (72). Defining $\delta=\Delta x^{a}$ summarizes the problem in the following system

$$
\left\{\begin{array}{l}
\text { Find } a \text { such that }: \Delta x^{a s}=\frac{\Delta x}{\Delta x^{a(6-s)}}, \\
\text { under the constraint }: \frac{1}{\Delta x^{a(6-s)}}<\frac{1}{\Delta x^{\gamma}}
\end{array}\right.
$$

Three cases have to be considered:

- if $\frac{3}{4} \leq s \leq 6-6 \gamma$, the constraint is binding and we have to choose $a$ which transforms the constraint inequality in an equality : $a=\frac{\gamma}{6-s}$. In that case, the rate of convergence is given by the smallest term between $\Delta x^{a s}$ and $\frac{\Delta x}{\Delta x^{a(6-s)}}$ i.e. $\Delta x^{\frac{\gamma s}{6-s}}$.
- If $6-6 \gamma \leq s \leq 6, a=\frac{1}{6}$ enables both terms $\Delta x^{a s}$ and $\frac{\Delta x}{\Delta x^{a(6-s)}}$ to be equal without violating the constraint. This choice of $a$ gives a rate of convergence of $\Delta x^{\frac{s}{6}}$.
- If $s \geq 6$, the result of the Theorem 1 applies.

Since $\gamma$ is in $\left(0, \frac{1}{2}\right.$ ) (cf. Lemma 7 and induction hypothesis (59)), we take the optimal $\gamma: \gamma=\frac{1}{2}-\eta$ with $\eta$ small and $\eta>0$. The conclusion of the theorem is straightforward consequence.
Remark 20. The choice of $\delta$ is independent of the regularity $s$ of the initial datum, if $3 \leq s \leq 6$.

## 7 Numerical results

In this section, the previous results are illustrated numerically by some examples and the numerical convergence rates are computed for the KdV equation.

### 7.1 Convergence rates

Through the rest of the paper, the computations are performed with an implicit scheme $\theta=1$ in order to avoid the dispersive CFL condition. Our purpose is to gauge the relevance of our theoretical results on the rate of convergence with respect to $\Delta x$. To this end, the time step is chosen according to the hyperbolic CFL condition. More precisely, $c$ is numerically chosen such that $c^{n}=\max \left|v_{j}^{k}\right| \quad$ and $\Delta t^{n}=\frac{\Delta x}{c^{n}}$. This choice seems surprising $k \in \llbracket 0, n \rrbracket, j \in \llbracket 1, J \rrbracket$
related to the CFL of Theorems 1 and 2 but, as explain in Remark 4, the condition $\left[c+\frac{1}{2}\right] \Delta t<\Delta x$ seems technical and may be replaced by the classical one $c \Delta t \leq \Delta x$. Eventually, we fix the final time $T=0.1$.

We can not simulate numerical solutions on $\mathbb{Z}$ as done in the theoretical results. We have to take into account numerical boundaries: we use periodic initial data. We fix the space domain to $[0, L]$ with $L=50$ (except for cnoidal wave where $L=1$ ) and fix $J=\left\lfloor\frac{L}{\Delta x}\right\rfloor$.
Remark 21. Notice that the theoretical results do not apply rigorously since the solutions do not belong to $H^{s}(\mathbb{R})$ because of their periodicity.

The convergence rate $r_{J}$ is computed with

$$
r_{J}=\frac{\log \left(E_{J}\right)-\log \left(E_{2 J}\right)}{\log (2)} .
$$

When the exact solution is known (e.g. for the cnoidal-wave solution), the variable $E_{J}$ corresponds to the following difference

$$
E_{J}=\sup _{n \in \llbracket 0, N \rrbracket}\left\|\left(e_{j}^{n}\right)_{j \in \llbracket 0, J \rrbracket}\right\|_{\ell_{\Delta}^{2}}=\sup _{n \in \llbracket 0, N \rrbracket}\left\|\left(v_{j}^{n}\right)_{j \in \llbracket 0, J \rrbracket}-\left(\left[u_{\Delta}\right]_{j}^{n}\right)_{j \in \llbracket 0, J \rrbracket}\right\|_{\ell_{\Delta}^{2}}
$$

with $\left(v_{j}^{n}\right)_{j \in \llbracket 0, J \rrbracket}$ the numerical solution computed with $J$ cells in space and $\left(\left[u_{\Delta}\right]_{j}^{n}\right)_{j \in \llbracket 0, J \rrbracket}$ the $J$-piecewise constant function from the analytical solution. However, for test cases with an unknown exact solution, the convergence error is computed from two numerical solutions with a different mesh and $E_{J}$ is replaced by the following $\tilde{E}_{J}$

$$
\tilde{E}_{J}=\sup _{n \in \llbracket 0, N \rrbracket}\left\|\left(v_{j}^{n}\right)_{j \in \llbracket 0, J \rrbracket}-\left(\tilde{v}_{j}^{n}\right)_{j \in \llbracket 0, J \rrbracket}\right\| .
$$

Previously, $\tilde{v}_{j}^{n}:=w_{2 j}^{n}$ for all $j \in \llbracket 0, J \rrbracket$, where $\left(w_{j}^{n}\right)_{j \in \llbracket 0,2 J \rrbracket}$ is a numerical solution computed with a refined grid with $2 J$ space meshes. In that case, $\left(\tilde{v}_{j}^{n}\right)_{j \in \llbracket 0, J \rrbracket}$, computed from the refined numerical solution $\left(w_{j}^{n}\right)_{j \in \llbracket 0,2 J \rrbracket}$, plays the role of the exact one $\left(\left[u_{\Delta}\right]_{j}^{n}\right)_{j \in \llbracket 0, J \rrbracket}$.

Remark 22. We have considered exactly $2 J$ space meshes for the refined numerical solution. Moreover, in all cases, 0 is a grid node, therefore, the error $\tilde{E}_{J}$ is nothing but the difference between every two consecutive values for $\left(w_{j}^{n}\right)_{j \in \llbracket 0,2 J \rrbracket}$ and every value for $\left(v_{j}^{n}\right)_{j \in \llbracket 0, J \rrbracket}$.

### 7.2 Smooth initial data

To assess the optimality of Theorem 1 , the corresponding test cases are carried out with two smooth periodic initial data, either the sinusoidal initial datum

$$
u_{0}(x)=\cos \left(\frac{2 \pi}{L} x\right)
$$

or the so-called cnoidal-wave initial datum. This cnoidal-wave solution represents a periodic solitary wave solution of the Korteweg-de Vries equation whose analytical expression is known as follow:

$$
u(t, x)=\frac{1}{\mu^{\frac{1}{5}}} a \mathrm{cn}^{2}\left(4 K(m)\left(\mu^{\frac{2}{5}}\left(x-\frac{L}{2}\right)-v \mu^{\frac{1}{5}} t\right)\right)
$$

where $\mu=\frac{1}{24^{2}}$ and $\operatorname{cn}(z)=\operatorname{cn}(z: m)$ is the Jacobi elliptic function with modulus $m \in(0,1)$ (we choose $m=0.9$ ) and the parameters have the values $a=192 m \mu K(m)^{2}$ and $v=64 \mu(2 m-1) K(m)^{2} . K(m)$ is the complete elliptic integral of the first kind (cf [BCKX13]).
Both results are gathered in Figure 1 for sinusoidal solution and Figure 2 for cnoidal-wave solution. We display the values of $r$ with respect to $J$ in the left table and post the corresponding graph in logarithmic scale on the right. The first order is confirmed for both initial data whether in tables or in graphs.

### 7.3 For a regularity between $H^{3}(\mathbb{R})$ and $H^{10}(\mathbb{R})$

To illustrate numerically Theorem 2, we initialize the scheme with a less regular initial datum. We test two kinds of periodic initial data in $H^{s}(\mathbb{R})$, with $s \geq 3$. The first one is computed from some integrations of the
indicator function and leads to initial data in $H^{s}(\mathbb{R})$ with $s$ a half-integer. The second one is computed from the periodized square root function and leads to initial data in $H^{s}(\mathbb{R})$ with $s$ an integer.

Tests achieved from the indicator function. Since the indicator function $\mathbb{1}_{\left[0, \frac{L}{2}\right]}$ belongs to $H^{s}([0, L])$ for all $s<\frac{1}{2}$, an idea to construct a periodic function in $H^{s+\ell}([0, L])$, with $s<\frac{1}{2}$ and $\ell \in \mathbb{N}^{*}$ is to integrate $\ell$ times the periodic indicator function. For instance, after a first integration, the initial datum

$$
u_{0}(x)=x \mathbb{1}_{\left[0, \frac{L}{2}\right]}+(L-x) \mathbb{1}_{\left[\frac{L}{2}, L\right]}
$$

is periodic and "almost" in $H^{\frac{3}{2}}([0, L])$. By reiterating the process of periodization and integration, we obtain initial data in $H^{s}([0, L])$, with $s=\frac{7}{2}^{-}, \frac{9}{2}^{-}, \frac{11}{2}^{-} \ldots$ The numerical results are summarized in the following table.

| Theoretical convergence rate | 0.58333 | 0.75000 | 0.91667 |

We detail some tests below : $s=\frac{7}{2}^{-}$in Figure 3, and $s=\frac{9}{2}^{-}$in Figure 4. For each figure, the graph on the right illustrates the error in $\ell^{\infty}\left(0, T, \ell_{\Delta}^{2}(\mathbb{Z})\right)$ with respect to the mesh size $\Delta x$ in logarithmic scale. Those errors and those mesh sizes are detailed in the table on the left. On the graph, we have displayed the points cloud but also the least squares regression and the numerical slope of that regression line is considered to be the experimental convergence rate. For more simplicity, we denote $H^{s-}(\mathbb{R})$ the space $H^{s-\ell}(\mathbb{R})$ with $\ell>0$ as small as possible.

Remark 23. The relative error between the experimental rate and the theoretical one is sometimes significant, for example, this relative error is more than $12 \%$ in the case $s=\frac{7}{2}-$. However, the theoretical rate is an asymptotic result for $\Delta x$ and $\Delta t$ small enough. As seen in the table on the left of Figure 3, the numerical order appears to be decreasing when $\Delta x$ decreases, which agrees closely with the theoretical results.

Tests achieved from the square root function. Since the square root function is in $H^{1-}([0, L])$ we construct a $H^{s-}([0, L])$ function by integrating the square root function $s-1$ times. However, we need, in addition, a periodic initial datum, this is why we add the beginning of a Taylor expansion for the function and its derivatives up to $(s-1)$-th to be continuous and periodic. More precisely, we search the coefficients $b_{i}$, $i \in \llbracket 1, s \rrbracket$ such that the function

and all its derivatives up to $(s-1)$-th be equal for $x=0$ and for $x=L$. To find those coefficients, we just have to solve the matrix system

The comparison between the experimental rates of convergence and the theoretical ones are very closed and gathered in the following table.

### 7.4 For a regularity between $L^{2}(\mathbb{R})$ and $H^{3}(\mathbb{R})$

Theoretically, the necessity to bound $\int_{0}^{T}\left\|\partial_{x} u(s, .)\right\|_{L^{\infty}(\mathbb{R})}^{i} d s$ in (64) forces to choose $s \geq \frac{3}{4}$. In addition, the necessity to bound $\left\|e^{n}\right\|_{\ell \infty}$ in $F_{a}$ in (50a) in order to apply the Grönwall lemma leads to choose $\Delta x$ such as Equation (55) be true which forces to have the constraint $\frac{1}{\delta^{6-s}}<\frac{1}{\Delta x^{\gamma}}$ in (72). However, those restrictions may be only technical and the rate of convergence seems to be $\Delta x^{\frac{s}{6}}$ for all $s \in[0,3)$. This is based on the following numerical results.

Tests achieved from the indicator function. The integration from the indicator function enables us to obtain examples of functions in $H^{s}(\mathbb{R})$ with $s=\frac{1}{2}^{-}, \frac{3}{2}^{-}, 5^{-}$, whose results are listed below.

We summarize the theoretical and numerical results in Figure 13. The blue line corresponds to the theoretical rate of convergence, the dashed line matches the conjectured rate and the red dots stand for the numerical rates of convergence. Both are intertwined, which validates the rate of convergence of $\frac{\min (s, 6)}{6}$ with $s$ the Sobolev regularity of the initial value.

\begin{array}{r}
-\sum_{j \in \mathbb{Z}} D_{+} D_{-}(a)_{j} D_{-}\left(\frac{b_{j}}{2} D_{+}(a)_{j}\right) \leq \sum_{j \in \mathbb{Z}} \frac{\Delta x^{\nu}\left|D_{-} b_{j}\right|^{\sigma}}{4}\left(D_{+} D_{-}(a)_{j}\right)^{2}+\sum_{j \in \mathbb{Z}} \frac{\left|D_{+}(b)_{j}\right|^{2-\sigma}}{4 \Delta x^{\nu}}\left(D_{+}(a)_{j}\right)^{2} \\
-\sum_{j \in \mathbb{Z}} \frac{b_{j}}{2}\left(D_{+} D_{-}(a)_{j}\right)^{2}
\end{array}
$$

For the term $-\sum_{j \in \mathbb{Z}} D_{+} D_{-}(a)_{j} D_{-}\left(\frac{b_{j}}{2} D_{-}(a)_{j}\right)$, one has thanks to Equality (21b),

$$
-\sum_{j \in \mathbb{Z}} D_{+} D_{-}(a)_{j} D_{-}\left(\frac{b_{j}}{2} D_{-}(a)_{j}\right)=-\sum_{j \in \mathbb{Z}} D_{+} D_{-}(a)_{j}\left(\frac{D_{-}(b)_{j}}{2} D_{-}(a)_{j}+\frac{b_{j-1}}{2} D_{-} D_{-}(a)_{j}\right)
$$

Hence, it holds (by Young inequality)

$$
\begin{aligned}
-\sum_{j \in \mathbb{Z}} D_{+} D_{-} & (a)_{j} D_{-}\left(\frac{b_{j}}{2} D_{-}(a)_{j}\right) \\
& \leq \sum_{j \in \mathbb{Z}} \frac{\Delta x^{\nu}\left|D_{-} b_{j}\right|^{\sigma}}{4}\left(D_{+} D_{-}(a)_{j}\right)^{2}+\sum_{j \in \mathbb{Z}} \frac{\left|D_{+}(b)_{j}\right|^{2-\sigma}}{4 \Delta x^{\nu}}\left(D_{+} a_{j}\right)^{2}-\sum_{j \in \mathbb{Z}} \frac{b_{j-1}}{2} D_{+} D_{-}(a)_{j} D_{-} D_{-}(a)_{j} \\
& \leq \sum_{j \in \mathbb{Z}} \frac{\Delta x^{\nu}\left|D_{-} b_{j}\right|^{\sigma}}{4}\left(D_{+} D_{-} a_{j}\right)^{2}+\sum_{j \in \mathbb{Z}} \frac{\left|D_{+}(b)_{j}\right|^{2-\sigma}}{4 \Delta x^{\nu}}\left(D_{+} a_{j}\right)^{2} \\
& -\sum_{j \in \mathbb{Z}} b_{j-1}\left(\frac{D_{+} D_{-} a_{j}+D_{-} D_{-} a_{j}}{2}\right)^{2}+\sum_{j \in \mathbb{Z}} \frac{b_{j-1}}{4}\left(D_{+} D_{-} a_{j}\right)^{2}+\sum_{j \in \mathbb{Z}} \frac{b_{j-1}}{4}\left(D_{-} D_{-} a_{j}\right)^{2} \\
& \leq \sum_{j \in \mathbb{Z}}\left(\frac{\Delta x^{\nu}\left|D_{-} b_{j}\right|^{\sigma}}{4}+\frac{b_{j-1}+b_{j}}{4}\right)_{\left(D_{+} D_{-} a_{j}\right)^{2}-\sum_{j \in \mathbb{Z}} b_{j}\left(D_{+} D a_{j}\right)^{2}+\sum_{j \in \mathbb{Z}} \frac{\left|D_{+}(b)_{j}\right|^{2-\sigma}}{4 \Delta x^{\nu}}\left(D_{+}(a)_{j}\right)^{2}}
\end{aligned}
$$

By collecting the previous results, one has

$$
\begin{aligned}
& \sum_{j \in \mathbb{Z}} b_{j} D_{+} D_{+} D_{-}(a)_{j} D(a)_{j} \leq \sum_{j \in \mathbb{Z}}\left\{\frac{\Delta x^{\nu}\left|D_{-} b_{j}\right|^{\sigma}}{4}+\frac{\Delta x^{\nu}\left|D_{-} b_{j}\right|^{\sigma}}{4}+\frac{b_{j-1}-b_{j}}{4}\right\}\left(D_{+} D_{-} a_{j}\right)^{2} \\
&+\sum_{j \in \mathbb{Z}} \frac{\left|D_{+}(b)_{j}\right|^{2-\sigma}}{2 \Delta x^{\nu}}\left(D_{+}(a)_{j}\right)^{2}-\sum_{j \in \mathbb{Z}} b_{j}\left(D_{+} D a_{j}\right)^{2}
\end{aligned}
$$

Lemma 12 is then proved.
Lemma 6 is a consequence, with $\nu=0$.

Proof of Lemma \%. To prove Lemma 7, the following lemma is useful.
Lemma 13. Let $\left(a_{j}\right)_{j \in \mathbb{Z}}$ be a sequence in $\ell_{\Delta}^{2}(\mathbb{Z})$, then one has

$$
\left\|D_{+} a\right\|_{\ell_{\Delta}^{4}} \leq \sqrt{3\|a\|_{\ell_{\infty}}\left\|D_{+} D_{-} a\right\|_{\ell_{\Delta}^{2}}} .
$$

Proof of Lemma 13. We compute the following sum thanks to the discrete integration by parts (29)

$$
\begin{equation*}
\sum_{j \in \mathbb{Z}}\left(D_{+} a_{j}\right)^{4}=\sum_{j \in \mathbb{Z}}\left(D_{+} a_{j}\right)^{3} D_{+} a_{j}=-\sum_{j \in \mathbb{Z}} D_{-}\left[\left(D_{+} a_{j}\right)^{3}\right] a_{j} \tag{79}
\end{equation*}
$$

We use Relation (21b) to develop $D_{-}\left[\left(D_{+} a_{j}\right)^{3}\right]$ in (79) and $D_{-}\left[\left(D_{+}(a)_{j}\right)^{2}\right]$ in (80)

$$
\begin{aligned}
-\sum_{j \in \mathbb{Z}} D_{-}\left[\left(D_{+} a_{j}\right)^{3}\right] a_{j} & =-\sum_{j \in \mathbb{Z}} D_{-}\left[\left(D_{+}(a)_{j}\right)^{2}\right] D_{-}(a)_{j} a_{j}-\sum_{j \in \mathbb{Z}}\left(D_{+} a_{j}\right)^{2} D_{-} D_{+}(a)_{j} a_{j} \\
& =-\sum_{j \in \mathbb{Z}} D_{+} D_{-}(a)_{j}\left(D_{-} a_{j}\right)^{2} a_{j}-\sum_{j \in \mathbb{Z}} D_{+}(a)_{j} D_{+} D_{-}(a)_{j} D_{-}(a)_{j} a_{j}-\sum_{j \in \mathbb{Z}}\left(D_{+} a_{j}\right)^{2} D_{+} D_{-}(a)_{j} a_{j} .
\end{aligned}
$$

We recover $D(a)_{j}$ in the second sum, which gives

$$
\begin{aligned}
\sum_{j \in \mathbb{Z}}\left(D_{+} a_{j}\right)^{4} & =-\sum_{j \in \mathbb{Z}} D_{+} D_{-} a_{j}\left(D_{-} a_{j}\right)^{2} a_{j}-\sum_{j \in \mathbb{Z}} 2 D_{+} D_{-}(a)_{j} a_{j}\left(D(a)_{j}\right)^{2}+\sum_{j \in \mathbb{Z}} D_{+} D_{-}(a)_{j} a_{j} \frac{\left(D_{+} a_{j}\right)^{2}}{2} \\
& +\sum_{j \in \mathbb{Z}} D_{+} D_{-}(a)_{j} a_{j} \frac{\left(D_{-} a_{j}\right)^{2}}{2}-\sum_{j \in \mathbb{Z}}\left(D_{+} a_{j}\right)^{2} D_{+} D_{-}(a)_{j} a_{j} \\
& =-\sum_{j \in \mathbb{Z}} \frac{D_{+} D_{-}(a)_{j} a_{j}\left(D_{-} a_{j}\right)^{2}}{2}-2 \sum_{j \in \mathbb{Z}} D_{+} D_{-}(a)_{j} a_{j}\left(D a_{j}\right)^{2}-\sum_{j \in \mathbb{Z}} D_{+} D_{-}(a)_{j} \frac{a_{j}\left(D_{+} a_{j}\right)^{2}}{2} .
\end{aligned}
$$

Multiplying by $\Delta x$ and applying Cauchy-Schwarz inequality simplify the $\ell_{\Delta}^{4}$-norm
$\left\|D_{+} a\right\|_{\ell_{\Delta}^{4}}^{4} \leq \frac{\|a\|_{\ell^{\infty}}}{2}\left\|D_{+} D_{-}(a)\right\|_{\ell_{\Delta}^{2}}\left\|D_{-} a\right\|_{\ell_{\Delta}^{4}}^{2}+2\|a\|_{\ell^{\infty}}\left\|D_{+} D_{-}(a)\right\|_{\ell_{\Delta}^{2}}\|D a\|_{\ell_{\Delta}^{4}}^{2}+\frac{\|a\|_{\ell^{\infty}}}{2}\left\|D_{+} D_{-}(a)\right\|_{\ell_{\Delta}^{2}}\left\|D_{+} a\right\|_{\ell_{\Delta}^{4}}^{2}$.

However, one has

$$
\begin{aligned}
\|D a\|_{\ell_{\Delta}^{4}}^{4} & =\sum_{j \in \mathbb{Z}} \Delta x\left(\frac{a_{j+1}-a_{j}+a_{j}-a_{j-1}}{2 \Delta x}\right)^{4} \\
& =\sum_{j \in \mathbb{Z}} \Delta x\left(\frac{a_{j+1}-a_{j}+a_{j}-a_{j-1}}{2 \Delta x}\right)^{2}\left(\frac{a_{j+1}-a_{j}+a_{j}-a_{j-1}}{2 \Delta x}\right)^{2} \\
& =\sum_{j \in \mathbb{Z}} \Delta x\left[2\left(\frac{a_{j+1}-a_{j}}{2 \Delta x}\right)^{2}+2\left(\frac{a_{j}-a_{j-1}}{2 \Delta x}\right)^{2}\right]\left[2\left(\frac{a_{j+1}-a_{j}}{2 \Delta x}\right)^{2}+2\left(\frac{a_{j}-a_{j-1}}{2 \Delta x}\right)^{2}\right] \\
& \leq \sum_{j \in \mathbb{Z}} \Delta x \frac{1}{4}\left(\frac{a_{j+1}-a_{j}}{\Delta x}\right)^{4}+\frac{1}{2} \Delta x\left(\frac{a_{j+1}-a_{j}}{\Delta x}\right)^{2}\left(\frac{a_{j}-a_{j-1}}{\Delta x}\right)^{2}+\frac{1}{4} \Delta x\left(\frac{a_{j}-a_{j-1}}{\Delta x}\right)^{4} \\
& \leq \sum_{j \in \mathbb{Z}} \Delta x\left(\frac{a_{j+1}-a_{j}}{\Delta x}\right)^{4} \\
& \leq\left\|D_{+} a\right\|_{\ell_{\Delta}^{4}}^{4} .
\end{aligned}
$$

Equation (81) is changed as follows

$$
\left\|D_{+} a\right\|_{\ell_{\Delta}^{4}}^{4} \leq 3\|a\|_{\ell \infty}\left\|D_{+} D_{-}(a)\right\|_{\ell_{\Delta}^{2}}\left\|D_{+} a\right\|_{\ell_{\Delta}^{4}}^{2} .
$$

Then it holds

$$
\left\|D_{+} a\right\|_{\ell_{\Delta}^{4}}^{2} \leq 3\|a\|_{\ell_{\infty}}\left\|D_{+} D_{-}(a)\right\|_{\ell_{\Delta}^{2}} .
$$

Lemma 13 is thus proved.
Remark 24. Lemma 13 is also valid for the classical discrete $\ell^{4}$-norm instead of $\ell_{\Delta}^{4}$-norm.
To prove Lemma 7, we first develop the left hand side thanks to

$$
\begin{equation*}
\sum_{j \in \mathbb{Z}} D_{+} D_{+} D_{-}(a)_{j} D\left(\frac{a^{2}}{2}\right)_{j}=\sum_{j \in \mathbb{Z}} D_{+} D_{+} D_{-}(a)_{j}\left[\frac{a_{j}}{2} D(a)_{j}+\frac{a_{j+1}}{4} D_{+}(a)_{j}+\frac{a_{j-1}}{4} D_{-}(a)_{j}\right] \tag{23}
\end{equation*}
$$

- The first term $\sum_{j \in \mathbb{Z}} \frac{a_{j}}{2} D_{+} D_{+} D_{-}(a)_{j} D(a)_{j}$ is treated with Lemma 12 of Appendix B with $\nu=\frac{1}{2}-\gamma$ and $\sigma=0$, which rewrites

$$
\sum_{j \in \mathbb{Z}} \frac{a_{j}}{2} D_{+} D_{+} D_{-}(a)_{j} D(a)_{j} \leq \sum_{j \in \mathbb{Z}} \frac{1}{4}\left\{\Delta x^{\frac{1}{2}-\gamma}-\frac{\Delta x}{2} D_{-} a_{j}\right\}\left(D_{+} D_{-} a_{j}\right)^{2}+\sum_{j \in \mathbb{Z}} \frac{1}{4 \Delta x^{\frac{1}{2}-\gamma}}\left(D_{+} a_{j}\right)^{4}-\sum_{j \in \mathbb{Z}} \frac{a_{j}}{2}\left(D_{+} D a_{j}\right)^{2} .
$$

- For the second term, we integrate by parts thanks to (29) and (21b)

$$
\begin{aligned}
\sum_{j \in \mathbb{Z}} D_{+} D_{+} D_{-}(a)_{j} \frac{a_{j+1}}{4} D_{+}(a)_{j} & =\sum_{j \in \mathbb{Z}}-D_{+} D_{-}(a)_{j} D_{-}\left(\frac{a_{j+1}}{4} D_{+}(a)_{j}\right) \\
& =\sum_{j \in \mathbb{Z}}-D_{+} D_{-}(a)_{j}\left\{\frac{a_{j}}{4} D_{+} D_{-}(a)_{j}+\frac{\left(D_{+}(a)_{j}\right)^{2}}{4}\right\}
\end{aligned}
$$

Young inequality completes the upper bound
$\sum_{j \in \mathbb{Z}} D_{+} D_{+} D_{-}(a)_{j} \frac{a_{j+1}}{4} D_{+}(a)_{j}=\sum_{j \in \mathbb{Z}}-\left(D_{+} D_{-}(a)_{j}\right)^{2} \frac{a_{j}}{4}+\sum_{j \in \mathbb{Z}} \frac{1}{8}\left(D_{+} D_{-}(a)_{j}\right)^{2} \Delta x^{\frac{1}{2}-\gamma}+\sum_{j \in \mathbb{Z}} \frac{1}{8 \Delta x^{\frac{1}{2}-\gamma}}\left(D_{+}(a)_{j}\right)^{4}$.

- For the third term, Relation (29) together with (21a) gives
$\sum_{j \in \mathbb{Z}} D_{+} D_{+} D_{-}(a)_{j} \frac{a_{j-1}}{4} D_{-}(a)_{j}=\sum_{j \in \mathbb{Z}}-D_{+} D_{+}(a)_{j} D_{+}\left(\frac{a_{j-1}}{4} D_{-}(a)_{j}\right)$
$=\sum_{j \in \mathbb{Z}}-D_{+} D_{+}(a)_{j}\left\{\frac{a_{j}}{4} D_{+} D_{-}(a)_{j}+\frac{D_{+}(a)_{j-1}}{4} D_{-}(a)_{j}\right\}$
$=\sum_{j \in \mathbb{Z}}-\frac{a_{j}}{2}\left(\frac{D_{+} D_{+}(a)_{j}+D_{+} D_{-}(a)_{j}}{2}\right)^{2}+\sum_{j \in \mathbb{Z}} \frac{a_{j}}{8}\left(D_{+} D_{+}(a)_{j}\right)^{2}+\sum_{j \in \mathbb{Z}} \frac{a_{j}}{8}\left(D_{+} D_{-}(a)_{j}\right)^{2}-\sum_{j \in \mathbb{Z}} D_{+} D_{+}(a)_{j} \frac{\left(D_{-}(a)_{j}\right)^{2}}{4}$
$\leq \sum_{j \in \mathbb{Z}}-\frac{a_{j}}{2}\left(D_{+} D(a)_{j}\right)^{2}+\sum_{j \in \mathbb{Z}} \frac{a_{j}+a_{j-1}}{8}\left(D_{+} D_{-}(a)_{j}\right)^{2}+\sum_{j \in \mathbb{Z}} \frac{\Delta x^{\frac{1}{2}-\gamma}}{8}\left(D_{+} D_{-}(a)_{j}\right)^{2}+\sum_{j \in \mathbb{Z}} \frac{1}{8 \Delta x^{\frac{1}{2}-\gamma}}\left(D_{+}(a)_{j}\right)^{4}$.
Gathering all these results yields

$$
\begin{array}{r}
\sum_{j \in \mathbb{Z}} D_{+} D_{+} D_{-}(a)_{j} D\left(\frac{a^{2}}{2}\right)_{j} \leq \sum_{j \in \mathbb{Z}}\left\{\frac{\Delta x^{\frac{1}{2}-\gamma}}{2}-\frac{\Delta x}{8} D_{-}(a)_{j}+\frac{a_{j-1}-a_{j}}{8}\right\}\left(D_{+} D_{-}(a)_{j}\right)^{2}+\sum_{j \in \mathbb{Z}} \frac{1}{2 \Delta x^{\frac{1}{2}-\gamma}}\left(D_{+} a_{j}\right)^{4} \\
-\sum_{j \in \mathbb{Z}} a_{j}\left(D_{+} D(a)_{j}\right)^{2}
\end{array}
$$

Lemma 13 concludes this proof

$$
\sum_{j \in \mathbb{Z}} D_{+} D_{+} D_{-}(a)_{j} D\left(\frac{a^{2}}{2}\right)_{j} \leq \sum_{j \in \mathbb{Z}}\left\{\frac{\Delta x^{\frac{1}{2}-\gamma}+\|a\|_{\ell \infty}+9 \frac{\|a\|_{\ell}^{2} \infty}{\Delta x^{\frac{1}{2}-\gamma}}}{2}\right\}\left(D_{+} D_{-}(a)_{j}\right)^{2}+\sum_{j \in \mathbb{Z}}\|a\|_{\ell \infty}\left(D_{+} D(a)_{j}\right)^{2} .
$$

Proof of Lemma 8. For Identity (44), the right hand side yields

$$
\begin{aligned}
& \sum_{j \in \mathbb{Z}}\left[D(a)_{j}\right]^{2} \frac{a_{j+1} b_{j+1}+a_{j-1} b_{j-1}}{2}-\sum_{j \in \mathbb{Z}} D(b)_{j}\left[D(a)_{j}\right]^{3} \frac{4 \Delta x^{2}}{3}-\sum_{j \in \mathbb{Z}} \frac{1}{3} D D(b)_{j} a_{j}^{3} \\
& =\sum_{j \in \mathbb{Z}} \frac{a_{j+1}^{3} b_{j+1}+a_{j+1}^{2} a_{j-1} b_{j-1}-2 a_{j+1}^{2} a_{j-1} b_{j+1}-2 a_{j+1} a_{j-1}^{2} b_{j-1}+a_{j-1}^{2} a_{j+1} b_{j+1}+a_{j-1}^{3} b_{j-1}}{8 \Delta x^{2}} \\
& -\sum_{j \in \mathbb{Z}}\left(\frac{b_{j+1}-b_{j-1}}{2 \Delta x}\right) \frac{a_{j+1}^{3}-3 a_{j+1}^{2} a_{j-1}+3 a_{j+1} a_{j-1}^{2}-a_{j-1}^{3}}{8 \Delta x^{3}}\left(\frac{4 \Delta x^{2}}{3}\right)-\sum_{j \in \mathbb{Z}} \frac{1}{3} \frac{b_{j+2}-2 b_{j}+b_{j-2}}{4 \Delta x^{2}} a_{j}^{3} .
\end{aligned}
$$

Adding the first two sums gives

$$
\sum_{j \in \mathbb{Z}} \frac{a_{j+1}^{3} b_{j+1}-3 a_{j+1}^{2} a_{j-1} b_{j-1}-3 a_{j-1}^{2} a_{j+1} b_{j+1}+a_{j-1}^{3} b_{j-1}+2 a_{j-1}^{3} b_{j+1}+2 b_{j-1} a_{j+1}^{3}}{24 \Delta x^{2}}
$$

The sum yields then

$$
\begin{aligned}
& \sum_{j \in \mathbb{Z}}\left[D(a)_{j}\right]^{2} \frac{a_{j+1} b_{j+1}+a_{j-1} b_{j-1}}{2}-\sum_{j \in \mathbb{Z}} D(b)_{j}\left[D(a)_{j}\right]^{3} \frac{4 \Delta x^{2}}{3}-\sum_{j \in \mathbb{Z}} \frac{1}{3} D D(b)_{j} a_{j}^{3} \\
& =\sum_{j \in \mathbb{Z}} \frac{a_{j+1}^{3} b_{j+1}-3 a_{j+1}^{2} a_{j-1} b_{j-1}-3 a_{j-1}^{2} a_{j+1} b_{j+1}+a_{j-1}^{3} b_{j-1}+2 a_{j-1}^{3} b_{j+1}+2 b_{j-1} a_{j+1}^{3}}{24 \Delta x^{2}} \\
& =\sum_{j \in \mathbb{Z}} \frac{a_{j+1}^{3} b_{j+1}-a_{j+1}^{2} a_{j-1} b_{j-1}-a_{j-1}^{2} a_{j+1} b_{j+1}+a_{j-1}^{3} b_{j-1}}{8 \Delta x^{2}} \frac{1}{3} \frac{b_{j+1} a_{j-1}^{3}-2 b_{j} a_{j}^{3}+b_{j-1} a_{j+1}^{3}}{4 \Delta x^{2}} \\
& =\sum_{j \in \mathbb{Z}}\left(\frac{a_{j+1} b_{j+1}-a_{j-1} b_{j-1}}{2 \Delta x}\right)\left(\frac{a_{j+1}^{2}-a_{j-1}^{2}}{4 \Delta x}\right) \\
& =\sum_{j \in \mathbb{Z}} D(a b)_{j} D\left(\frac{a^{2}}{2}\right)_{j} .
\end{aligned}
$$
