Introduction

One of the remaining issues, impeding the commercialization of the low cost and high efficiency perovskite solar cells (PSCs) is the stability of the halide perovskite materials, including the light-induced degradation and the hysteresis effect. The perovskite/TiO_x and perovskite/Au interfaces are numerically investigated, simulating the current-voltage (J-V) and capacitance-voltage (C-V) characteristics. Furthermore, a new approach is proposed for the modelling of Kelvin Probe Force Microscopy (KPFM). It is applied to hetero-structures in dark and under illumination, aiming at estimating the surface states on the top of the electron transport materials and understanding the charge carrier behavior inside the cells.

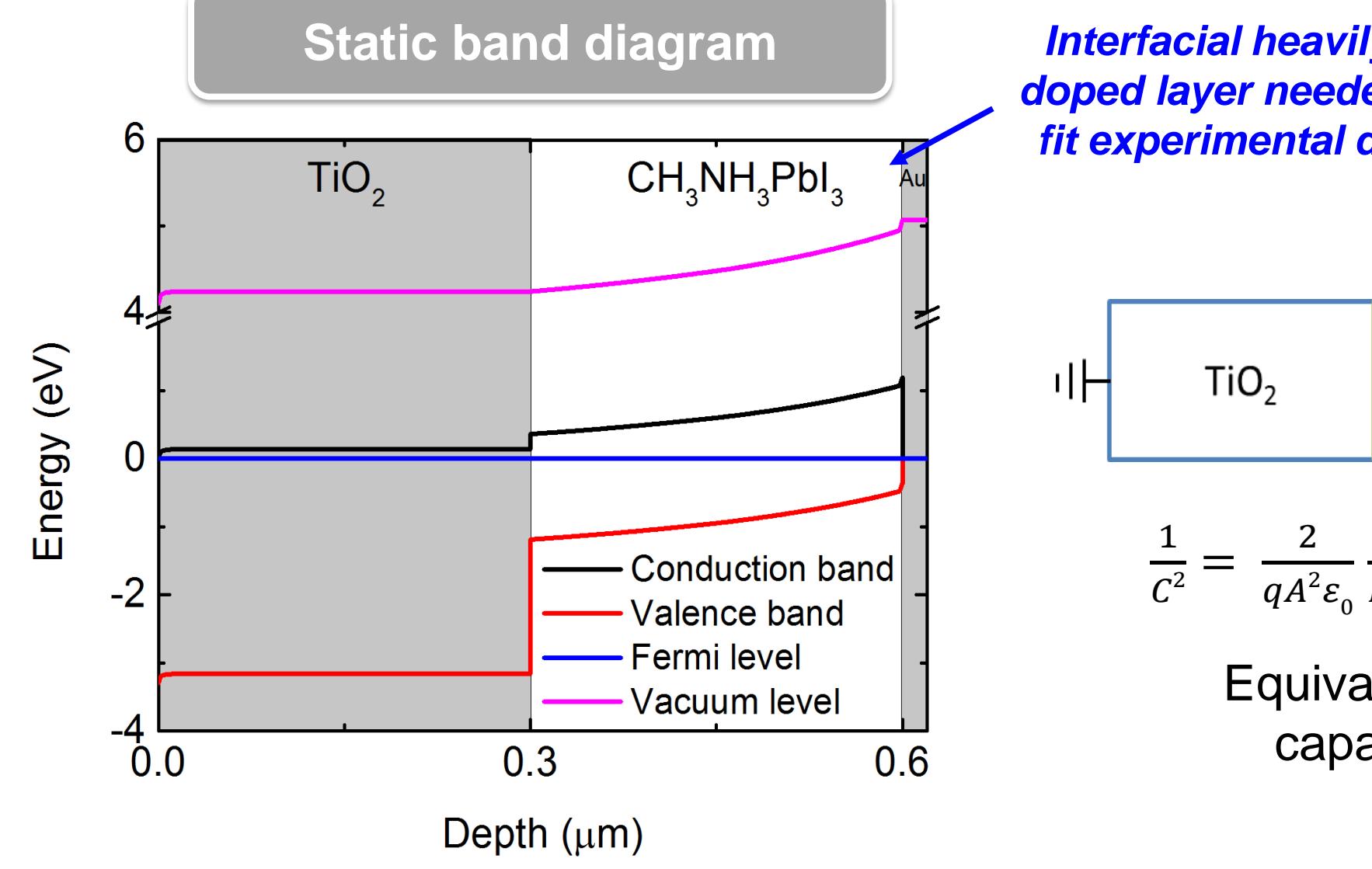

Static band diagram

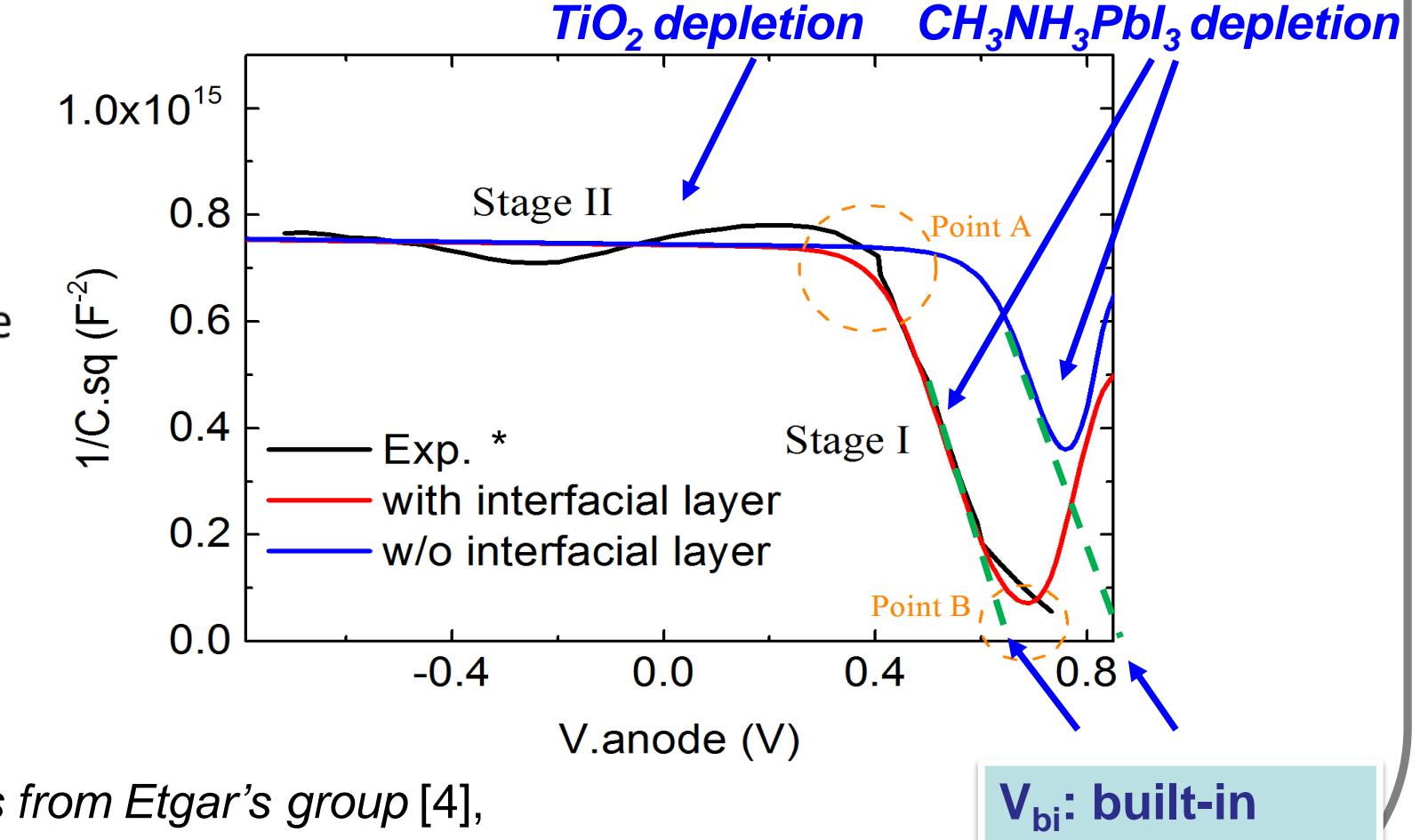

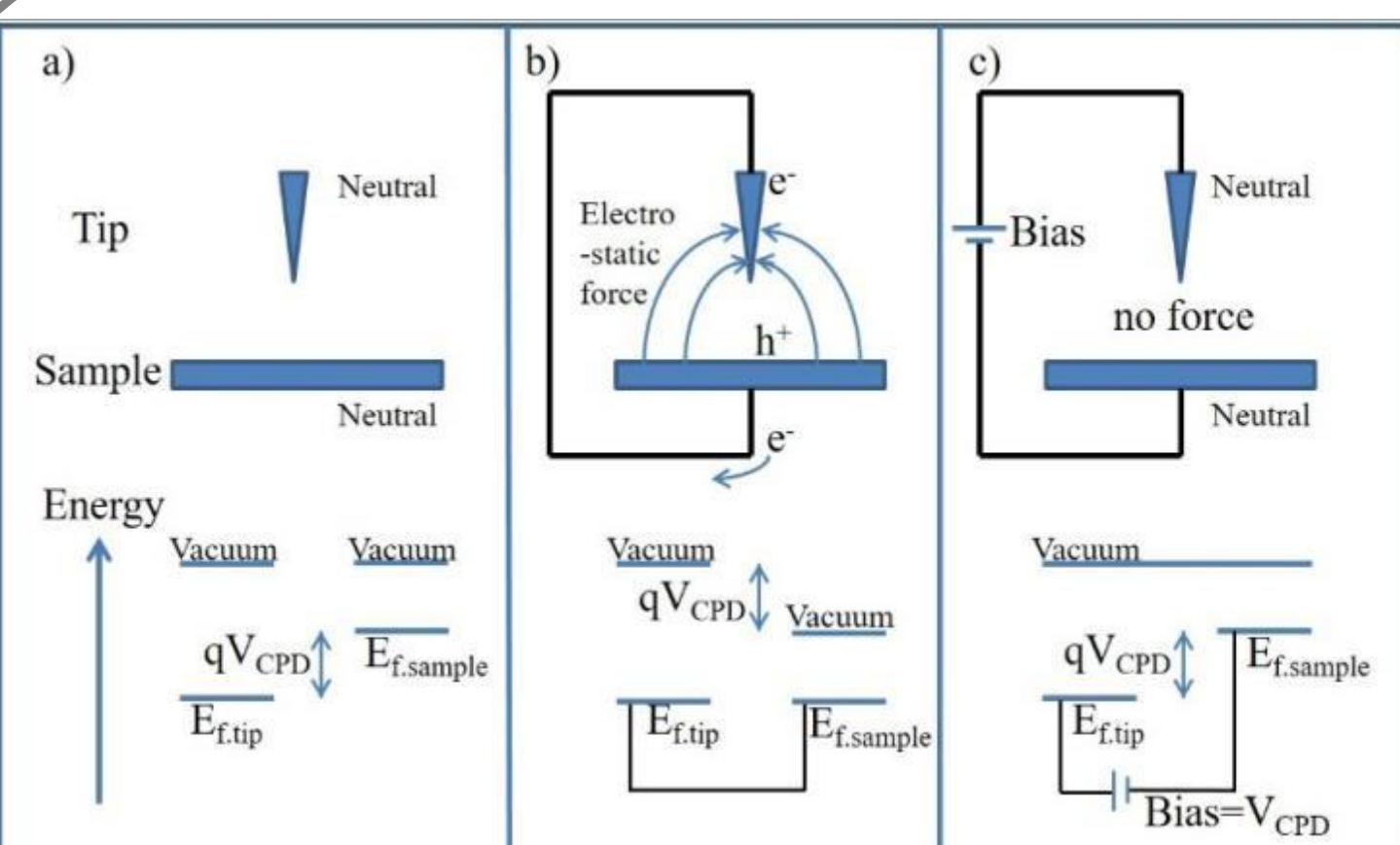


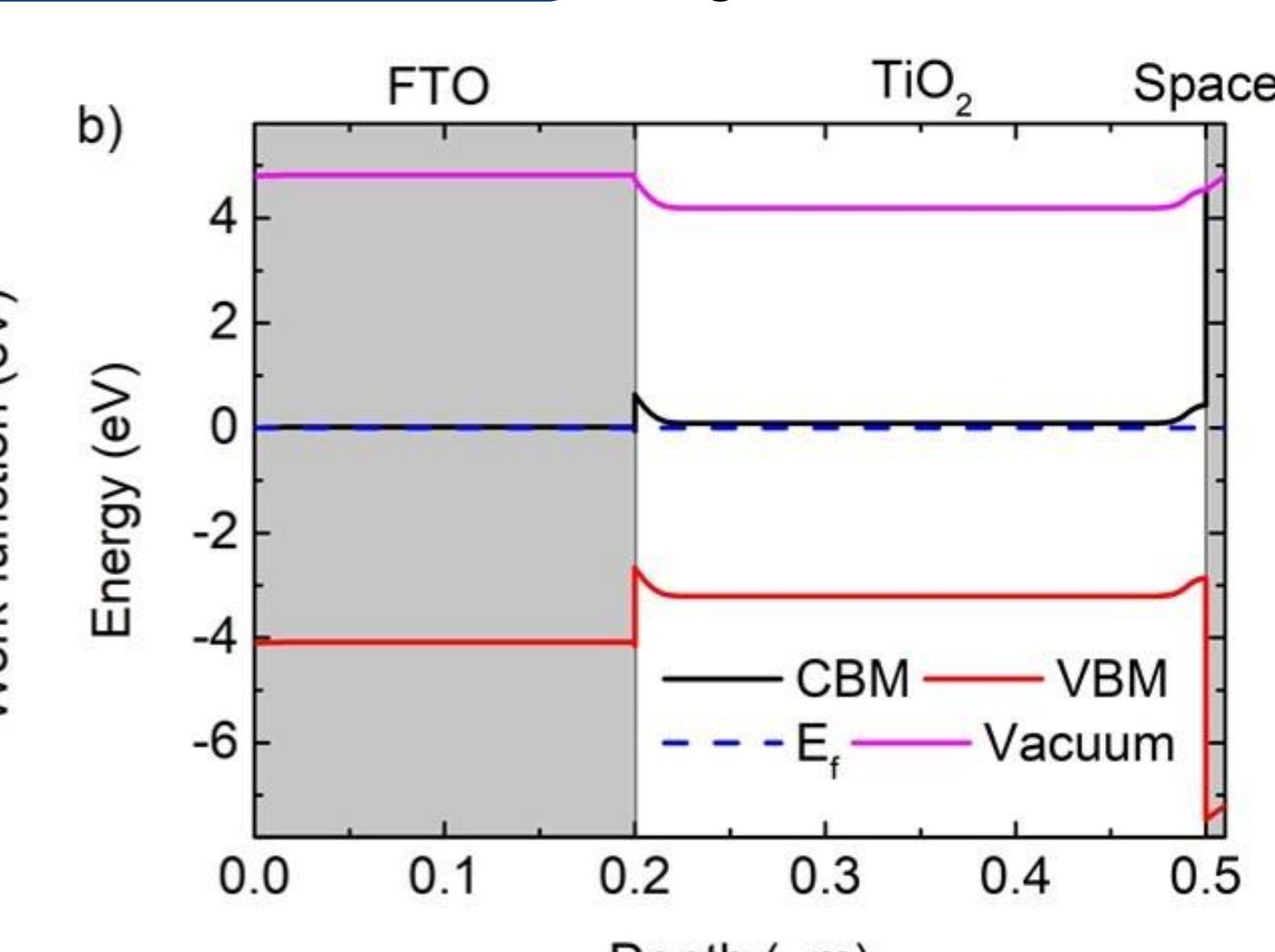
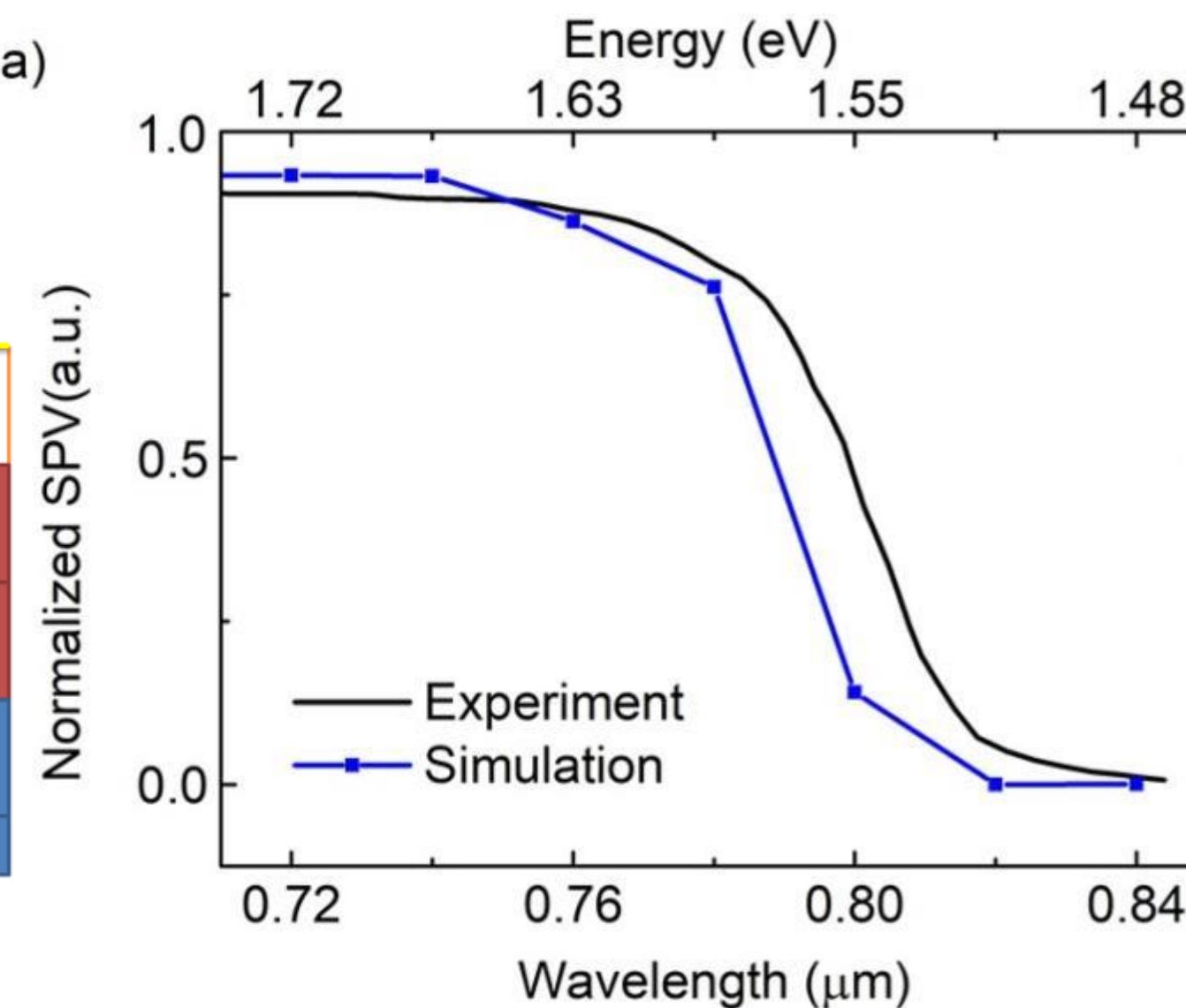
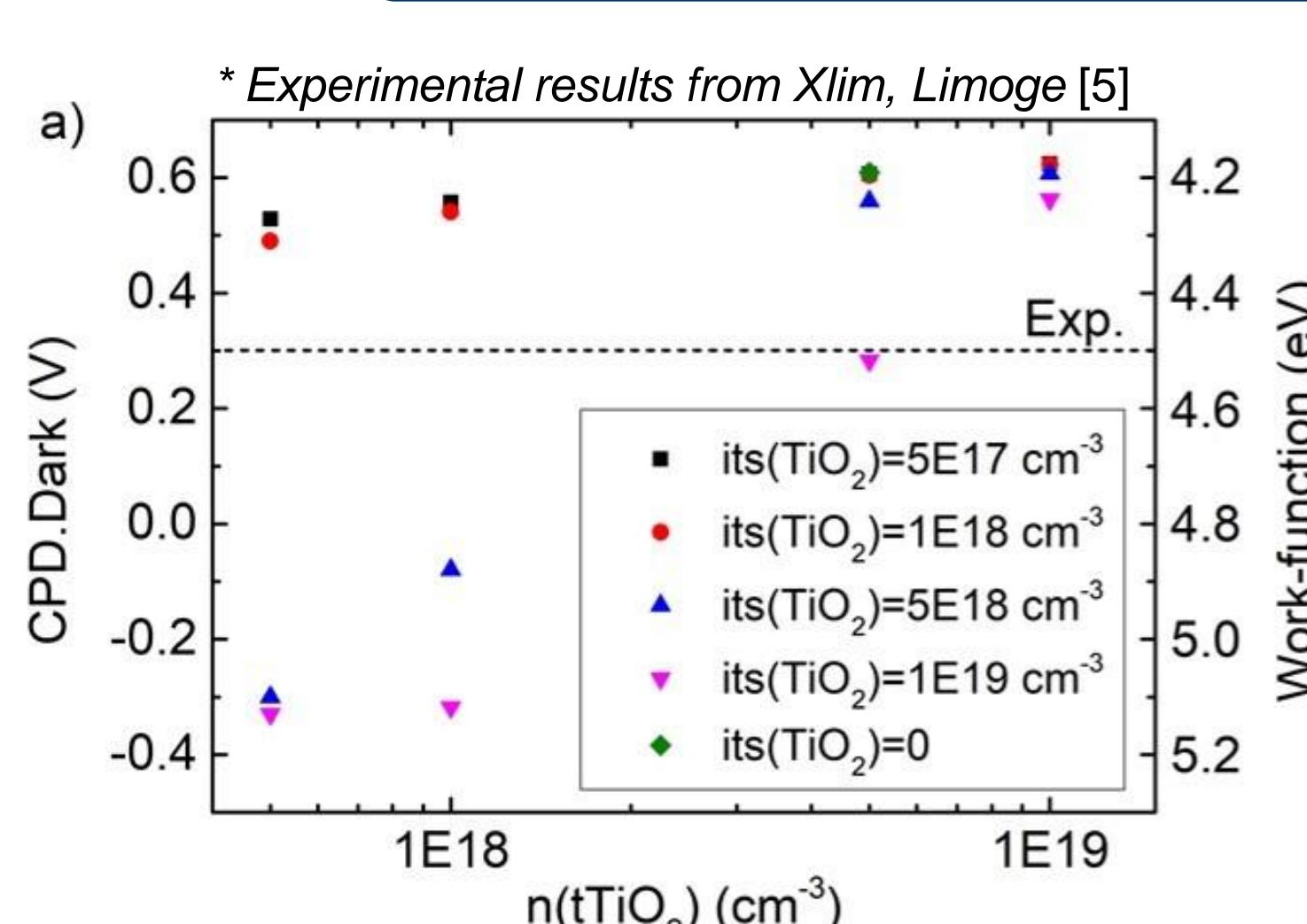
Illustration of the basic measurement setup of Contact Potential Difference (CPD). Tip and sample are a) separated, b) connected at short circuit and c) under bias of V_{CPD} .

$$V_{CPD} = \frac{E_{f,tip} - E_{f,sample}}{q}$$

V_{CPD} measured by KPFM, $E_{f,tip}$ is known.

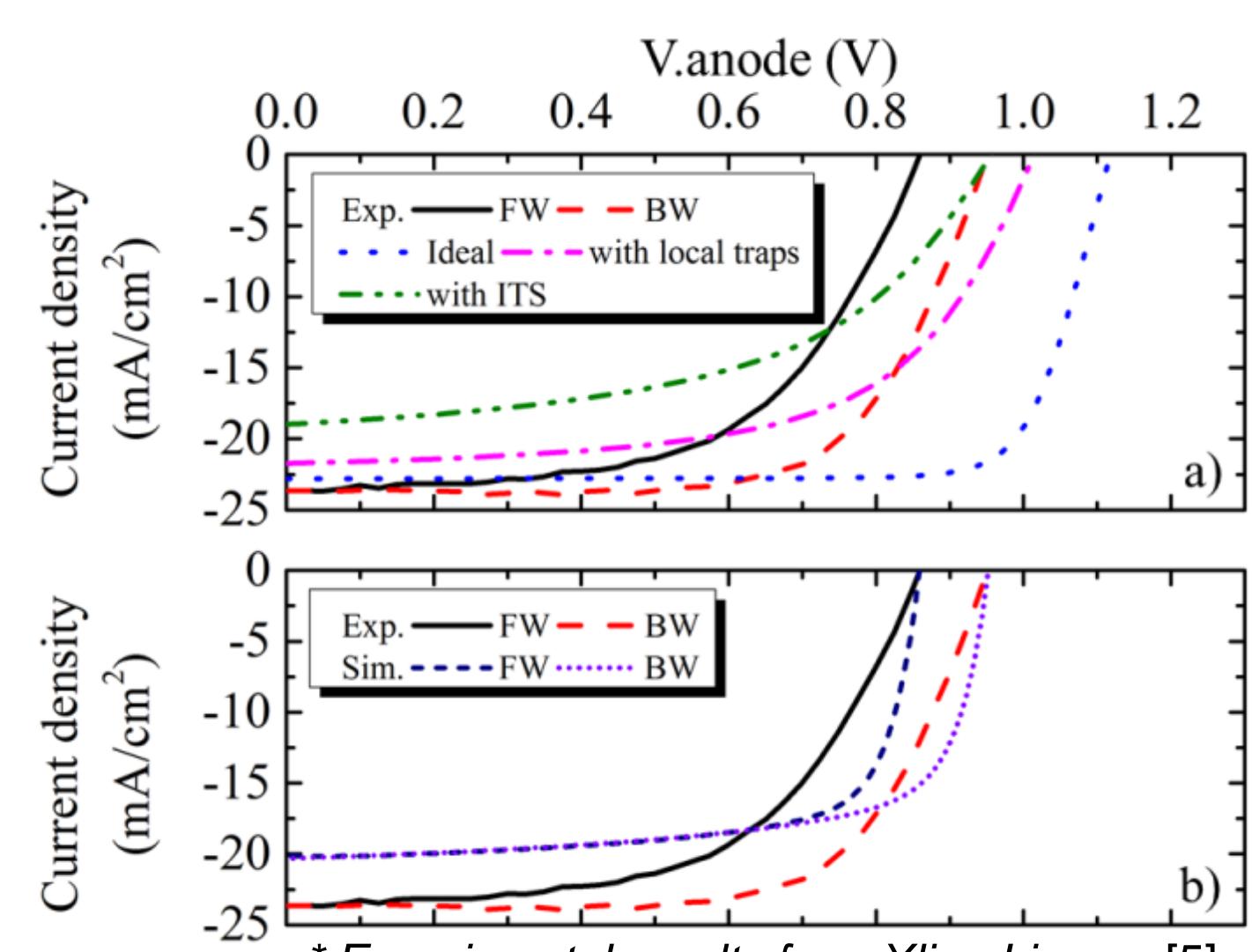

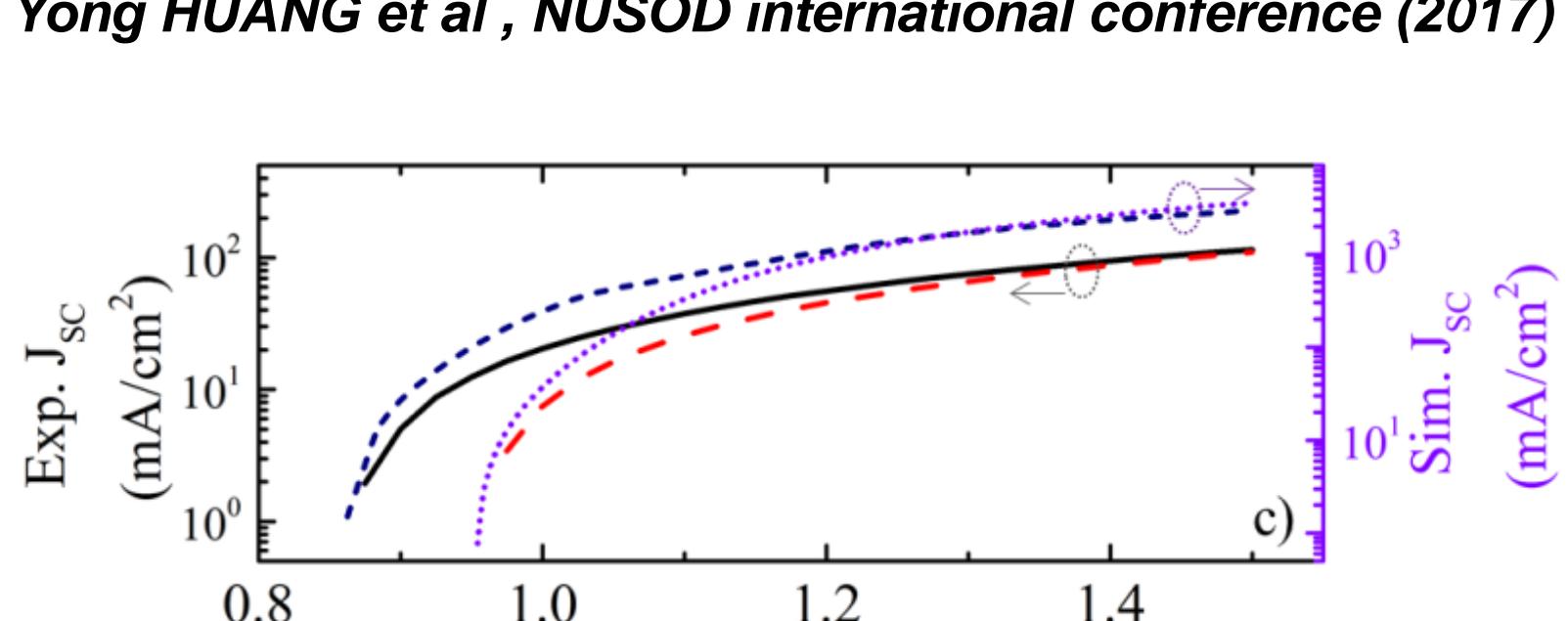
V_{oc} Losses in PSCs

- a) Experimental J-V properties of TiO_x/MAPbI₃/Spiro-OMeTAD solar cells; black solid and red dash lines indicate forward and backward scan, respectively. The computed ideal case with only bimolecular recombination is drawn as blue dots. The curve shift to violet dash dot line with taking into account the local trap states, and it becomes worse with interface trap states as the green dot dot dash line. b) Experiment data in comparison with the computation with ITS and mobile ions. The tick labels of a) and b) are on the top. c) J-V characteristics of experimental and simulation with mobile ions biased above 0.8V.



The V_{oc} loss of standard TiO_x/CH₃NH₃PbI₃/Spiro-OMeTAD PSCs could mainly come from the local trap-assisted recombination in the bulk, besides the interface trap recombination and ion migration.



A new approach to modelling Kelvin Probe Force Microscopy for hetero-structures in the dark and under illumination has been presented. The approach has been tested by examining FTO/TiO₂ and FTO/TiO₂/MAPbI₃ structures. Unexpected surface states on the top of TiO₂ layer are inferred by the combination of theoretical computation and experimental results. The basic applications of KPFM under illumination are analyzed as well.
