Neither a Dog, Nor a Beggar Seasonal Labour Migration, Development, and Poverty in Andhra Pradesh

#### INTRODUCTION

Madiga Kurmaïah stands alone in the middle of the stone quarry on the outskirts of HITECH City Hyderabad, Andhra Pradesh (AP). Proud to work on his own account as a swanta kuli (a self-employed labourer), he uses his hammer to break stones that he will sell to the company, PCC, on a piece-rate basis. A little further on, Madiga Laxmaïah, a debt-bonded labourer, works under the orders of his elder brother Ramullu, his maistri (labour middleman), along with Sayamma, Venkata, and other ex-Untouchable Madigas. They collect stones broken by a machine owned by an ex-Member of the Legislative Assembly (MLA) from their Mandal of origin and load them on to the tractor.

Their food is prepared by Kajebi, a Muslim widow whose parents recently died. Her 13-year-old son, Moïnadeen, is paid Rs 1,200 per

Their food is prepared by Kajebi, a Muslim widow whose parents recently died. Her 13-year-old son, Moïnadeen, is paid Rs 1,200 per month as a helper to Sudhakar Reddy, a truck driver. All originate from Peddapur, a village of Mahabubnagar district (AP). Kajebi and Moïnadeen have been recruited through the peddanianishi (hereditary

title of Head of the village) of Peddapur, to whom she has to repay a loan taken from a village development project. When she does not make a repayment, N. Reddy, a rising political middleman and henchman of the *peddamanishi*, comes to take her wages, using physical and verbal intimidation. Alternatively, he accepts further delays in exchange for sex.

Alone, Kajebi had no other way of repaying her debt. In Peddapur, a 'village community', ruled by Kumar Reddy, the *peddamanishi*, and administered by N. Reddy, was established and supported by an NGO² to foster collective decisions for the development of the village. The building of a new Hindu temple was decided: the NGO loaned Rs 50,000, and 50,000 more were collected in the village—except from the Madigas, who are denied access to the temple. The whole sum was insufficient for the project and was subsequently distributed as loans, repayable with interest. Kajebi received 6,000 rupees from the project through the *peddamanishi* who 'protected' her: 'I provide some work, she is a Muslim and it could be seen as an offence against Hindus if she does not reimburse.'

More than a technical failure, the sexual violence, the obligation to migrate, and the extortion of wages appear rather as regular outcomes of the articulation between seasonal labour migration, development programmes (whether funded by the state, by NGOs, or by transnational forms of government), and power relations. At this stone quarry, employing labourers under various kinds of labour 'contract', to focus on the relations of production would provide an incomplete picture of the everyday lives of the working poor and of the process of the accumulation and reproduction of poverty. Rural and urban economies and spaces have become closely connected, while the forms of labour and migration are all related to the power relations of the village and its development projects.

This chapter examines the dynamic of how poverty is reproduced among labour migrants through the interplay between labour migration, development, and power in rural Telangana, AP. Based on a case study of seasonal labour migrants originating from Peddapur, it argues that the articulation between labour migration of Madigas (characterized by lack of protection at work, debt, and segmentation of labour markets) and the anti-poverty programmes (cornered and

For the Madiga seasonal migrant labourers discussed in this chapter, the decline of patronage and the mechanisms of the labour market often mean the near absence of social, political, and economic protection, both at work and in the village. Security of employment and basic subsistence security have become the main issues in the processes of the reproduction of power relations and poverty, notably for the Dalits, who remain 'overwhelmingly represented in the lowest ranks of the socio-economic hierarchy in India' (Heyer 2010: 226). In India, 87 per cent of debt-bonded labourers belong to Scheduled

Castes (SCs) and Scheduled Tribes (STs) (NCEUS 2009: 147). As this chapter will show, the enlarged spaces of negotiations and claims for independence of Madiga labourers, fostered by the changing labour relations, do not transform into bargaining power, but into renewed forms of dependence on political musclemen (goondas) and into an extra burden and workload in order to gain access to development resources.

The lack of security at work has reinforced the material and symbolic importance of those programmes, which have become the major sources of protection for the workers—and of political competition—in rural AP. The rising political clientelism, the power of rural leaders, and the importance of political intermediaries have been widely acknowledged in the literature. In rural Karnataka, Pattenden argues that 'whilst traditional forms of control over the laboring class have been eroded, gatekeeping increasingly allows the dominant class to exert a more subtle form of political control, which in turn facilitates processes of accumulation' (2011: 164). I intend to look at how the articulations and complementarities between the multiple forms of migration and the modes of control and redistribution of resources reformulate poverty and microhierarchies within and between caste and family. Harriss-White (2006) argues that capitalism transforms and recreates forms of poverty. Mosse (2010: 1157) adopts a relational approach to poverty, defined as a consequence of historically developed economic and political relations, with an emphasis on social processes and relations of power, that produce identities through embodiment and/or mobilization. But poverty is in addition ensured by a complementary process of social mobility for the few, who often trample over their own kin and caste fellows in order to climb the social ladder.

This chapter aims to contribute three points to this debate. First, the processes of migration create spaces of negotiation for Madiga labourers, but the working conditions and relations (debt, absence of skill acquisition, lack of protection) in segmented labour markets push them back to the village in search of protection. Secondly, the rural leaders' changing forms of control over labour and development resources are shaped not only by local politics and perspectives of accumulation in rural and urban economics,

but also by a renewed moral duty to protect Madiga labourers. The latter is conceived as a modern form of leadership based on reformulated caste micro-hierarchies and discriminations. Thirdly, the local history of exploitation and caste discrimination, reassessed in the everyday politics of fear, routine, and discouragement by maistris and political intermediaries (goondas), also serves as a platform for labourers' mobilizations for respect and dignity and for producing vernacular representations of poverty shaped by the fear of destitution and by claims for independence and entitlements to development programmes.

However, in this district, the main source of accumulation for Reddys has been through the local debt-bondage system, called Palamur, put in place in the 1930s (Olsen and Murthy 2000). This system is organized around a contractor for enterprises located in a town or in Hyderabad which are owned by an industrialist or a

major politician (or both), who responds to government invitations to tender for the construction of canals, roads, dams, or railways all over India. The management is delegated to a *peddamaistri*, a rural leader, often a politician at MLA, MP (Member of Parliament), or District Panchayat level (local government body). He then turns to a large number of *labour maistri* (up to 200) responsible for the recruitment of workers at the local level. Each *maistri* recruits a gang by distributing advance payments to 40 men and women from different low castes and neighbouring villages, organizes the labour camp (in locations decided by the *peddamaistri*), and supervises the food and the work during the nine-month season. When he is absent from the labour camp, he relies on a loyal worker, called *gumppupampupedda*, to lead the group.

Since the 1980s, due to transformations of labour relations and the politicization of low castes, this system has coexisted with the seasonal migration of daily-wage labourers (Gollas and Lambadis) employed in the construction industry in Hyderabad and Mumbai for six to nine months a year (Picherit 2012). More recently young Madigas have tried their luck as swanta kuli (self-employed labourers) on construction sites and even, for the educated few, as truck and rickshaw drivers. The multiple forms of labour and of circulation between working sites all over India, and between working sites and villages, are nevertheless connected through a flexible articulation of family, gender, caste, and class relations within the village, while the achievement of solidarity is made extremely difficult.

## MULTIPLE FORMS OF MIGRATION AND LACK OF PROTECTION

The PCC stone quarry offers a striking example of the coexistence of machines (owned by Reddys) and labourers working under arrangements ranging from debt bondage to the most flexible types of labour relations, from neo-bondage to casualized labour. This section examines how the multiple but coexistent forms of labour

migration push labourers back to the village in search of multiple and temporary forms of protection/dependence. It analyses how the forms of social mobility, contestations, and quests for dignity are related to the labour conditions and power relations.

### A way out of poverty?

The reproduction of poverty in rural India takes very diverse forms according to the social, political, and economic context, and according to the specific avenues for social mobility that exist at the local level. Investigating the social mobility of some Madigas within the broader social and power relations enables us to grasp the character of the debt-bondage relations that have evolved.

In the context of the politicization of low-caste communities in the 1980s, of rising assertiveness among labourers, and of the changing economy, Reddys gradually invested in machines rather than in manual labour for the construction industry (they rent out tippers for work on dams and canals), and delegated the management of direct labour to low-caste *maistris*. While Reddys have retained the main positions in the debt-bondage system (*peddamaistri*), Gollas have taken *maistri* jobs, and they were followed by some Madigas at the end of the 1990s.

This has had profound implications in terms of the management and protection of labour, and has offered a few Madigas a significant form of social mobility. Without doubt, Ramullu, the PCC maistri, is one of them. A former debt-bonded labourer, he managed to gain the trust of a Reddy peddamaistri to begin as a labour middleman, get contracts in the construction industry, and access the capital to provide advances to labourers. The peddamaistri provides half of the total advances, and the maistri borrows and takes the financial risk for the second half. Within 15 years, Ramullu has secured his position and is well known in the locality. He is respected by his caste fellows and by the peddamaistri for his loyalty and commitment, and his social ascension represents a clear break from poverty.

This mobility has also changed his position within his caste, but the latter remains strictly limited by the segmentation of financial, political, and labour markets. Indeed, Ramullu has no chance of extending his business. The capital is controlled by Reddys, and Ramullu cannot rely on his caste fellows for loans. Reddys limit the ascension of Madiga *maistris* by delegating their own power over labour only to small *maistris* with no more than 40 labourers. In

The changing Palamur debt-bondage system is a powerful means of tying labour through debt and migration. Although PCC gathers labourers of different status, the circulation of these workers all over India clearly limits their interactions and solidarities at work. The lack of protection from the *maistri* and the absolute need for physical rest after the extreme living and working conditions during migration turn the slack season into a period for the reproduction of the labour force, the cost of which is borne by the labourers themselves. Periods of rest and/or unemployment are times of rising indebtedness, financed by the expected future advance, which considerably reduces the bargaining position of potential migrants.

## The cost of independence

Among the labourers in PCC, the swanta kuli represents an emerging, influential, and valued category among young Madigas, who favour working independently of a muistri. A bachelor and the son of debt-bonded labourers, Kurmaïah works on his own: he breaks stones that he sells to the company on a piece-rate basis. Although he is better paid than debt-bonded labourers, his independence has a cost: he works longer and harder (to ensure a better wage), pays for his food, his tools, and his huts, has no job security, and is compelled to circulate between stone quarries according to the fluctuations of the market.

The tension between independence, better wages, and self-exploitation is a common consequence of insecure, temporary, and mobile forms of labour, detached from personal relations of power but dependent on segmented labour markets. Kurmaïah has acquired no specific skills (only stamina is required, and that is partly an attribute of youth) and he cannot access better jobs in construction labour markets. Yet he continues to value his independence, which he asserts by putting other Madigas down. He congratulates himself that 'I work wherever and whenever I want. I am not like those Madigas who bow in front of their maistri.'

Swanta kuli justly conveys how he considers his position in relation to debt-bondage and to dignity. The better wages that he receives comfort him in his assertion of freedom and help to lessen the burden of his heavy workload and his feelings of self-exploitation, which are expressed at times of unemployment. He is dependent on the availability of work, extremely vulnerable to a downturn in

demand, and must constantly search for work in other stone quarries. However, the assertion of his status is limited to micro-hierarchies (it is directed against his caste fellows). It creates tensions not only with other labourers in the stone quarries but also at home in the village. Kurmaïah shows disdain for any task performed by Madigas for Reddys (unpaid work to get loans, or rituals during funerals or festivals that older Madigas can hardly refuse). This arrogance provokes contrasted reactions. Debt-bonded labourers envy his independence but never consider it sustainable over time: 'This is a three-year job, no more, otherwise you just die'. They are sure that the swanua kuli will end up in the arms of a maistri when he gets married and settles down.

## Migration and the slack season

The concept of labour classes, defined by Lerche (2010), helps to explain what unites and differentiates these labourers. Power is here not limited to economic issues but plays on social and religious stigma, as for Kajebi, a Muslim widow, who is subjected to sexual and labour violence; on family ties, as for Laxmaïah, who is attached to his

Beyond dichotomies such as constraints and choices, agency and dependency, survival and coping strategies, the everyday lives of migrants are composed of harsh realities, of quests for dignity, and tensions between social expectations and lack of opportunities, changing according to location (village or working site) and social context. The adjustment to labour markets does not preclude refusal to be attached to a *maistri*, or pride in independence—independence expressed in relation to the local and historical context of labour and power relations. In addition, harsh working conditions, the necessary periods of rest, and rising indebtedness considerably limit effective bargaining power during the slack season, denying labourers opportunities to contest the *maistri* and to access development programmes—the main options by which labourers might ameliorate their precarious and insecure situations.

# RURAL LEADERS' PERSPECTIVES ON POVERTY

Development programmes play a central role in political and economic struggles. The Reddys have extended their control over the anti-poverty resources of the state and the development agencies as a way of maintaining their power, while at the same time diversifying and extending their economic activities to small towns and cities.

In the village and the *Mandal*, no anti-poverty scheme or programme can exist without the involvement of local leaders. Their voracious appetite for such schemes is directly linked to ensuring re-election and political power, and also to an appetite for the profits yielded by the schemes. But this is not the only motive, and the *peddamanishi* of Peddapur, Kumar Reddy, is probably committed to the development of the village and to upgrading conditions of the poorest, provided only that power relations remain unchanged. He closely associates development with profit, but leadership legitimized by development is conceived as the modern mode of domination (compared with debt bondage):

Money is politics, this is not agriculture. If you lose elections, you have nothing. We, the TDP, thanks to everything I have done, have brought money, schemes, programmes, and people vote for me. They know everything my family has done: bus, electricity, phone, and roads. It was a struggle. Many people here did not want change, but we managed. The harijan wada is clean, nice houses, water; my father started with Indira Gandhi, all my family has always taken care of the village.

Kumar Reddy is the main landowner, the leader of the Telegu Desam Party (TDP) at the Mandal level, and the vice-president of the local Bank. He is, first and foremost, the peddaminishi, a title inherited from his father and forefathers. Unlike titles such as Dora, Kapu, or Patel—referring to oppressive forms of domination associated with landlordism—peddamanishi rather conjures the respect due to a powerful, strong, and fair natural leader. His family has ruled locally for generations, thanks to a combination of land, capital, politics, and caste. This heritage provides moral authority assessed by regular features of leadership in rural India: his refusal of the direct exercise of violence, his soft voice, restrained gestures, and white dress reinforce his respectable position, above the degrading

nature of everyday matters. The various and regular marks of respect that he receives are attributed to his public activities:

I went to look for NGOs to find solutions. I insisted on micro-credit and other programmes. If I had not done that, everyone would have migrated as in other deserted villages. This is my village and I brought lot of money.

Those programmes help him to appear as a modern leader by exercising what he conceives as his traditional duty: moral control of the Madigas. Rural leaders determine what is necessary and what is superficial, what the poor need or not, what development and poverty mean, and which programme should be implemented and/or supported in the village. But caste plays a central role. On account of their caste, Madigas are believed incapable of dealing with important issues or of escaping poverty by themselves. It is the moral duty of Reddys to take them in hand. A distinction is drawn between poor Gollas and the Madigas, who are considered not only as uneducated but also as unfit for education: 'I have built this school but what does it bring to them? They do not want to work in agriculture any more and prefer to roam around without money.'

Kumar Reddy's commitment to development must be placed in the changing political landscapes in the state and the historical context of the locality. In this former part of Hyderabad State ruled by the Nizam, local landlords have for long derived advantage from delegations of power. The local samasthan<sup>11</sup> of Wanaparthi—in which Peddapur is located—was headed by a Paligar (Zamindar) who relied on local Doras to establish domains with local taxes and bondage in agriculture (vetti, baghela) (Thirumali 2003; Vaddiraju 1999) and to interact with the justice and administrative systems beyond the village borders. <sup>12</sup> The Palamur debt-bondage system grew out of those connections, allowing public contracts for the construction of canals, roads, and dams.

G. Satyanarayana notes how rural leaders in the 1970s invested in pump stations as well as in the alcohol business. This ability to extend their business beyond the locality was perpetuated by development

programmes from the 1980s onwards: 'All the development programmes adopted by the government have given chance to Doras to turn into brokers and exploit the people' (1992: 39).

Reddys have historically shown huge capacities to bolster and/ or adjust to changing rural and urban economies by investing in alcohol shops, in machines for the construction industry (rather than for agriculture), and in education, as well as in village development activities:

There is no profit in agriculture; there is no water and no food for cattle. <sup>13</sup> My two sons went to school and now work in cities; they rent tippers for construction work. We invest in machines; it makes more money than labour or *maistri*.

The absence of profit in agriculture—and 'the costly labourers' lack of loyalty'—has always been a traditional complaint of landowners. But agriculture has never been the main source of accumulation in this drought-prone area. Adapting to the urban economy (in the form of labour migration, renting out tippers, etc.) has reinforced the obligation to maintain links with the village in order to secure the labour force needed for the urban construction projects and to ensure re-election. Kumar Reddy's son, who lives in Hyderabad, was elected to the Gram Panchayat in 2009.

However, these rural leaders differ from the Reddys of coastal Andhra and Rayalaseema (the southern belt of AP). In coastal Andhra, from the 1960s Reddy (and Kamma) landowners have invested in education and accessed political and business positions from Hyderabad to the USA. Rayalaseema is locally known as a land of factions, vendettas, political violence, crime, rape, and bomb manufacture. These are an integral part of the nexus between business and politics, nowadays extended to global business and national politics. Since 1994, three Chief Ministers of AP have come from this area.

By contrast, the local Mandal generates much less money, violence, and conflict. Even though politics is organized around competing Reddy families in the village, violence is strongly constrained. Pressure from Naxalites, absent in the Mandal but influential 30 km away, and structural poverty in the district, indirectly put pressure on Reddys to reach a compromise for the redistribution of development resources. Conflicts are not prevented,

but their degeneration is at least avoided. Reddy Congress supporters in the village have been further silenced by alliances built by Kumar Reddy with the Congress Party at the *Mandal* and district levels, partly through kinship networks:

I am TDP from the beginning, but I have always kept contacts with Congress. My father was in Congress, my children contracted successful marriages and here politics has no place. One of my brothers-in-law is an MP of Congress, one is a ZPTC<sup>14</sup> member from Congress, and my close cousin is an MLA for TDP. We all meet, they help us, I help them and everyone enjoys development.

This rosy story of mutual co-operation for development, as Kumar Reddy tells it, is now threatened by the social mobility of Gollas (Congress Reddys observe it with anger and anxiety) and by the victory of the Congress at the state level (not in the district or the village). The consensus is very much contested by Chandrashekar Reddy, the Congress leader in the village, but his influence and assets are in no way comparable to those of Kumar Reddy.

In 2003, during the *Vinayakacaviti* festival, villagers were called in the evenings to gather around two Ganesh statues—one for each political party, displayed in separate parts of the village. The Congress Party never managed to gather more than 20 people, whereas the TDP attracted from two to three hundred. On the last night, young Reddy members of Congress entered into a fierce two-hour battle with TDP Gollas. When the police came, they installed themselves in the courtyard of Kumar Reddy and interviewed only TDP members. The Congress Reddys were found guilty: 10 were jailed for two weeks and excluded from the village for a month; 20 had to report every day at the nearest police station.

The TDP lost the state election in AP in 2004, but maintained its leadership in the district and in the Mandal. Although the Congress victory in the elections raised the expectations of its local leaders, none has managed to challenge the peddamanishi. Political, familial, and economic networks ensure (at least for the time being) the TDP's ability to corner development resources, which are redistributed unequally through a renewal of caste-based and

class-based micro-hierarchies. This is often in line with the design of the programmes. As the head of one micro-credit organization in Mahabubnagar explained:

We have never targeted the poorest: how could they reimburse? Our targets are the ones who are just above the poorest, as they have relations to support them in case of troubles. Some may loan to the poor, and that is why micro-credit is in crisis. But we are not responsible as we have never supported the very poor.

The government's Indiramma housing scheme for the poor provides a subsidy of about 40 per cent on the construction of houses, the remaining money being borrowed. Nine Gollas in 2011 were able to benefit from this scheme, but none of the Madigas. Misappropriation always reinforces inequalities. The State government admitted that 240 crores of rupees had gone astray. <sup>15</sup> Even N. Reddy got a new house under this scheme.

The shift from the TDP to Congress at the state level has awakened competition in the village and has obliged Kumar Reddy to reinforce his hierarchical networks in order to ensure the loyalty of his followers, notably the Gollas who are the first beneficiaries of the TDP. Madiga labourers are kept away from politics and decisions about anti-poverty programmes. Congress can hardly base strong opposition on their support. The structural absence of labourers from the village limits claims for development to the sphere of redistribution. Even the Madigas who have reserved seats in the Gram Panchayat are the manual labourers of Kumar Reddy. They are called 'dumnnies' by their caste fellows.

State and development resources are distributed in the name of the *peddamanishi*, and are represented as the result of the work that he has done for it. This renewed clientelism is reinforced by moral discourses about historical caste and familial duty, while direct and visible violence is delegated to *goondas*. Madigas are called to vote for the TDP; if their votes are uncertain, henchmen are present to reduce this uncertainty through a combination of friendship and violence, proximity and distance. Here ends the role of the *peddamanishi*, proud of his non-violence (defined by Heuzé, 1994 as an absence

This situation points to the changes happening locally. For other debt-bonded, casual or self-employed Madiga labourers, those claims of independence are not sustainable. Debt-bonded labour migrants are, without doubt, last in line for the redistribution of development resources and get only the crumbs of any scheme. No Madiga has emerged as a middleman, and labourers negotiate mostly through the Reddy political intermediary and have no possibility of gaining any significant 'advantage' over others or of escaping from poverty. They all benefit marginally from the schemes, but never as a right. If their absolute conditions have improved over the years, their relative position in the village has not changed.

# The Palamur, the dog, and the beggar

Claims expressed in terms of rights and entitlements to development outcomes are nevertheless on the rise, but those claims are made on the basis of patronage, deference, and unpaid work—forms of negotiation that the Madiga know about. Between dignity and dependence, insecurity and survival, assertion of rights and unpaid work, freedom to negotiate and incurring extra burdens, the margins are very narrow. This implies contested representations of poverty, while the failures of development offer an easy way to condemn labourers as responsible for their own plight.

On one occasion, during the public distribution of rice in the village, about a hundred people gathered to collect their ration. Bags were missing (as usual), and everyone began shouting. On this rare occasion, Sayamma started publicly blaming N. Reddy:

You treat us like dogs [kukkalu] but I am not a biccagadu [beggar]; we are Palamur labourers, I have toiled all my life on dams, canals, roads, I have carried stones and stones and I have nothing; you have to respect [maryaada] us [Madiga].

A Mandal Revenue Officer looked at me and loudly commented within Madiga hearing: 'We have done so much for them, but they prefer to live like dogs and beg for rice.' No one replied. With his characteristic sense of impunity, N. Reddy later dismissed Sayamma and other

Madigas: 'They make a lot of noise, but they akways come back from migration to eat from my hands.'

Alongside the administrative categories of poverty (Below Poverty Line, Scheduled Caste, Poorest of the Poor, women, youth, elderly, and so forth) that confer the right to benefit from such schemes are a number of vernacular categories related to poverty which also produce representations, mobilization, and discriminations. I will now examine how this relates to destitution, work, and dignity, and how poverty is expressed in terms of the social relations of power.

The term 'Palamur' (which is the former name of Mahabubnagar District which has given its name to the system) has long referred to its institution of debt bondage. It is now widely used by all manual labourers originating from the district, irrespective of caste and the form of migration. Well known in the construction industry, it has become a brand with various complimentary significations: labourers use it as a marker of hard, compliant, serious and/or docile workers when they want to be hired as daily-wage labourers in the Hyderabad construction market. The swanta kuli, proud of their 'independent' status, always refer to Palamur to emphasize stamina and skills of labourers. Furthermore, the maistri and peddamaistri sell a 'Palamur labour force' to construction sites and always praise these labourers for their commitment to hard work. This pride references migrant work under harsh conditions, with poverty as its reward.

#### CONCLUSION

'They always come back to eat from my hands' is the regular boast of N. Reddy. If this reflects his compulsive need to show off, it also points to the impunity and confidence of rural leaders and their henchmen about the present state of social and economic relations. They have a deep faith that the mechanisms of the informal urban economy and of the organization of labour migration will maintain their power over labourers who are back in the village during the slack season. The indirect control over labour and development resources exercised by rural leaders, and the lack of protection for labourers, maintains a system of clientelism that cannot be understood only in terms of

economic and political calculations. The unequal redistribution is also reformulated as a modern moral duty of Reddys to protect Madiga labourers, while the engagement with development is seen as a modern form of leadership. Reddys consider themselves as having the duty of bringing development to the Madigas, who on account of their 'nature' are considered as incapable of taking advantage of it for themselves. Caste hierarchies and discriminations are renewed with development. Moral control is exercised over what Madigas need, do, wear, earn, or eat, and this control has been stripped of long-term personalized forms of attachment.

This history may serve to provide a platform for labourers to insist that respect be accorded to them. Seasonal migration encourages workers to strive to benefit from anti-poverty programmes; to use whatever caste, class and gender linkages they have access to as well as to use local patronage to improve their position. This is the nexus between migration, power, and development that perpetuates the poverty of Madigas. Maintained as a mobile, flexible, and dependent labour force in a state of poverty, Madigas are prevented from challenging the unequal redistribution of development resources,

from securing a stable economic and political basis in the village, and from contesting openly and directly the power of the rural leadership.
