# Asymptotic behavior of the extrapolation error associated with the estimation of extreme quantiles

#### Abstract

We investigate the asymptotic behavior of the (relative) extrapolation error associated with some estimators of extreme quantiles based on extreme-value theory. It is shown that the extrapolation error can be interpreted as the remainder of a first order Taylor expansion. Necessary and sufficient conditions are then provided such that this error tends to zero as the sample size increases. Interestingly, in case of the so-called Exponential Tail estimator, these conditions lead to a subdivision of Gumbel maximum domain of attraction into three subsets. In constrast, the extrapolation error associated with Weissman estimator has a common behavior over the whole Fréchet maximum domain of attraction. First order equivalents of the extrapolation error are then derived and their accuracy is illustrated numerically.


Keywords: Extrapolation error, Extreme quantiles, Extreme-value theory.

## 1 Introduction

The starting point of this work is the study of the asymptotic behavior of the Exponential Tail (ET) estimator, a nonparametric estimator of the extreme quantiles from an unknown distribution. Theoretical developments can be found in [4] while numerical aspects are investigated in [10]. Given a $n$-sample $X_{1}, \ldots, X_{n}$ from a cumulative distribution function $F$ with associated survival distribution function $\bar{F}$, an extreme quantile is a $\left(1-p_{n}\right)$ th quantile $q\left(p_{n}\right)$ of $F$ essentially larger than the maximal observation, i.e. such that $\bar{F}\left(q\left(p_{n}\right)\right)=p_{n}$ with $p_{n} \leq 1 / n$. The estimation of extreme quantiles requires specific methods. Among them, the Peaks Over Threshold (POT) method relies on an approximation of the distribution of excesses over a given threshold [22]. More precisely, let us introduce a deterministic threshold $u_{n}$ such that $\bar{F}\left(u_{n}\right)=\alpha_{n}$ or equivalently $u_{n}=q\left(\alpha_{n}\right)$ with $\alpha_{n} \rightarrow 0$ and $n \alpha_{n}>1$ as $n \rightarrow \infty$. The excesses above $u_{n}$ are defined as $Y_{i}=X_{i}-u_{n}$ for all $X_{i}>u_{n}$. The survival distribution function of an excess is given

[^0]by $\bar{F}_{u_{n}}(x)=\bar{F}\left(u_{n}+x\right) / \bar{F}\left(u_{n}\right)$. Pickands theorem [12, 21] states that, under mild conditions, $\bar{F}_{u_{n}}$ can be approximated by a Generalized Pareto Distribution (GPD). As a consequence, the extreme quantile $q\left(p_{n}\right)$ can be in turn approximated by the deterministic term

\end{equation*}

where $\sigma_{n}$ and $\gamma_{n}$ are respectively the scale and shape parameters of the GPD distribution. Then, the POT method consists in estimating these two unknown parameters. The ET method corresponds to the important particular case where $F$ belongs to Gumbel Maximum Domain of Attraction, MDA(Gumbel). In such a situation, $\gamma_{n}=0$ and the GPD distribution reduces to an Exponential distribution with scale parameter $\sigma_{n}$. Thus, approximation (1) can be rewritten as

and the associated estimator [4] is

\hat{q}_{\mathrm{ET}}\left(p_{n} ; \alpha_{n}\right)=\hat{q}\left(\alpha_{n}\right)+\hat{\sigma}_{n} \log \left(\alpha_{n} / p_{n}\right)
$$

where $\hat{q}\left(\alpha_{n}\right)=X_{n-k_{n}+1, n}$ with $k_{n}=\left\lfloor n \alpha_{n}\right\rfloor$ and

$$
\hat{\sigma}_{n}=\frac{1}{k_{n}} \sum_{i=1}^{k_{n}} X_{n-i+1, n}
$$

Let us recall that $X_{1, n} \leq \ldots \leq X_{n, n}$ denote the order statistics associated with $X_{1}, \ldots, X_{n}$. The $\operatorname{error}\left(q\left(p_{n}\right)-\hat{q}_{\mathrm{ET}}\left(p_{n} ; \alpha_{n}\right)\right)$ can be expanded as a sum of two terms:

q\left(p_{n}\right)-\hat{q}_{\mathrm{ET}}\left(p_{n} ; \alpha_{n}\right)=\left(\tilde{q}_{\mathrm{ET}}\left(p_{n} ; \alpha_{n}\right)-\hat{q}_{\mathrm{ET}}\left(p_{n} ; \alpha_{n}\right)\right)+\left(q\left(p_{n}\right)-\tilde{q}_{\mathrm{ET}}\left(p_{n} ; \alpha_{n}\right)\right),
$$

the first one being a random estimation error

$$
\begin{equation*}
\tilde{q}_{\mathrm{ET}}\left(p_{n} ; \alpha_{n}\right)-\hat{q}_{\mathrm{ET}}\left(p_{n} ; \alpha_{n}\right)=q\left(\alpha_{n}\right)-\hat{q}\left(\alpha_{n}\right)+\left(\sigma_{n}-\hat{\sigma}_{n}\right) \log \left(\alpha_{n} / p_{n}\right) \tag{3}
\end{equation*}
$$

and the second one being a deterministic extrapolation error

$$
\begin{equation*}
q\left(p_{n}\right)-\tilde{q}_{\mathrm{ET}}\left(p_{n} ; \alpha_{n}\right)=q\left(p_{n}\right)-q\left(\alpha_{n}\right)-\sigma_{n} \log \left(\alpha_{n} / p_{n}\right) . \tag{4}
\end{equation*}
$$

The asymptotic behavior of the estimation error (3) is driven by the asymptotic distributions of $\hat{q}\left(\alpha_{n}\right)$ and $\hat{\sigma}_{n}$ which can be found for instance in [6], Theorem 2.4.1 and Theorem 3.4.2 respectively.

In this paper, we focus on the asymptotic behavior of the extrapolation error (4). Indeed, in view of (2), it appears that the ET method extrapolates in the distribution tail from $q\left(\alpha_{n}\right)$ to $q\left(p_{n}\right)$ thanks to an additive correction proportional to $\log \left(\alpha_{n} / p_{n}\right)$. Our goal is thus to quantify to which extent this extrapolation can be performed in a consistent way. More specifically, we provide necessary and sufficient conditions on the pair $\left(p_{n}, \alpha_{n}\right)$ such that the relative extrapolation error

\varepsilon_{\mathrm{ET}}\left(p_{n} ; \alpha_{n}\right):=\left(q\left(p_{n}\right)-\tilde{q}_{\mathrm{ET}}\left(p_{n} ; \alpha_{n}\right)\right) / q\left(p_{n}\right) \tag{5}
\end{equation*}
$$

tends to zero as $n \rightarrow \infty$. These conditions depend on the underlying distribution function $F$ and they lead to a subdivision of MDA(Gumbel) into three sub-domains depending on the restrictions they impose on the extrapolation range. Related works include [5, 17] who exhibited penultimate approximations for $F^{n}$ together with convergence rates for distributions in MDA(Gumbel). These results were extended to other maximum domains of attraction in [18, 19] while penultimate approximations were established for the distribution of the excesses $F_{u_{n}}$ in [24].

Here, we focus on the approximation of quantiles rather than approximations of distribution functions. Let us also highlight that these investigations are not limited to the ET method. To illustrate this, let us introduce $x_{n}=\log \left(1 / \alpha_{n}\right), y_{n}=\log \left(1 / p_{n}\right)$ and $\varphi(\cdot)=(\bar{F})^{-1}(1 / \exp (\cdot))$. The extrapolation error (4) can thus be interpreted as the remainder of a first order Taylor expansion:

\begin{equation*}
q\left(p_{n}\right)-\tilde{q}_{\mathrm{ET}}\left(p_{n} ; \alpha_{n}\right)=\varphi\left(y_{n}\right)-\varphi\left(x_{n}\right)-\sigma_{n}\left(y_{n}-x_{n}\right) \text { where } \sigma_{n}=\varphi^{\prime}\left(x_{n}\right) . \tag{6}
\end{equation*}
$$

We shall show that Weissman estimator [23] dedicated to MDA(Fréchet) can also enter this framework thanks to adapted definitions of $x_{n}, y_{n}$ and $\varphi$. In this case, the necessary and sufficient conditions on the extrapolation range are automatically fulfilled for most distributions in MDA(Fréchet) which is a very different situation from MDA(Gumbel).

The paper is organized as follows: The asymptotic behavior of the remainder associated with the first order Taylor expansion (6) is investigated in Section 2. The applications to ET and Weissman approximations are detailed in Section 3 and Section 4 respectively. As a conclusion, some numerical illustrations are presented in Section 5. Proofs are postponed to Section 6 and auxiliary results can be found in the Appendix.

## 2 Theoretical framework

Let $\varphi$ be an arbitrary twice differentiable, increasing function. Let $\left(x_{n}\right)$ and $\left(y_{n}\right)$ be two sequences such that $0<x_{n} \leq y_{n}$ for all $n$ large enough, $x_{n} \rightarrow \infty$ as $n \rightarrow \infty$ and

$$
\begin{equation*}
0<\liminf x_{n} / y_{n} \leq \lim \sup x_{n} / y_{n} \leq 1 . \tag{7}
\end{equation*}
$$

Motivated by (5) and (6), we introduce

$$
\begin{equation*}
\Delta_{n}=\frac{\varphi\left(y_{n}\right)-\varphi\left(x_{n}\right)-\left(y_{n}-x_{n}\right) \varphi^{\prime}\left(x_{n}\right)}{\varphi\left(y_{n}\right)} . \tag{8}
\end{equation*}
$$

The goal of this section is to establish necessary and sufficient conditions on $\delta_{n}:=\left(y_{n}-x_{n}\right) / y_{n}$ so that $\Delta_{n} \rightarrow 0$ as $n \rightarrow \infty$. The following two functions are of the utmost importance in this study:

$$
K_{1}(x)=\frac{x \varphi^{\prime}(x)}{\varphi(x)}, K_{2}(x)=\frac{x^{2} \varphi^{\prime \prime}(x)}{\varphi(x)}, x \in \mathbb{R} .
$$

The limits of $K_{1}(x)$ and $K_{2}(x)$ when $x \rightarrow \infty$ are denoted by $\ell_{1} \in \overline{\mathbb{R}}_{+}$and $\ell_{2} \in \overline{\mathbb{R}}$, when they exist. The study of $\Delta_{n}$ relies on the assumption that $K_{1}$ is regularly-varying at infinity with
index $\theta_{1} \leq 1$. This property is denoted for short by $K_{1} \in R V_{\theta_{1}}$ and means that $K_{1}$ is ultimately positive such that

$$
\frac{K_{1}(t x)}{K_{1}(x)} \rightarrow t^{\theta_{1}} \text { as } x \rightarrow \infty \text { for all } t>0
$$

We refer to [3] for a general account on regular variation theory. This assumption is discussed in Section 3 and Section 4 while applying this general framework to the particular cases of ET and Weissman estimators.

The first step is to establish the links between $\delta_{n}$ and $\Delta_{n}$ through the functions $K_{1}$ and $K_{2}$.

## Lemma 1 (Bounds on $\Delta_{n}$ )

(i) If $K_{1} \in R V_{\theta_{1}}$ with $\theta_{1} \leq 1$ and (7) holds then

\Delta_{n}=\delta_{n}^{2} \int_{0}^{1} \frac{K_{2}\left(y_{n}\left(1-\delta_{n} u\right)\right)}{\left(1-\delta_{n} u\right)^{2}} \exp \left(K_{1}\left(y_{n}\right) L_{\theta_{1}}\left(1-\delta_{n} u\right)(1+o(1))\right) u d u
$$

where $L_{\theta_{1}}(x)=\int_{1}^{x} u^{\theta_{1}-1} d u$ for all $x \in \mathbb{R}$.
(ii) If, moreover, $K_{2}$ is ultimately of constant sign and monotone, then

$$
\begin{aligned}
& \left|\Delta_{n}\right| \leq \max \left(\left|K_{2}\left(y_{n}\right)\right|,\left|K_{2}\left(x_{n}\right)\right|\right) \frac{\delta_{n}^{2}}{\left(1-\delta_{n}\right)^{2}} \Phi\left(\delta_{n} K_{1}\left(y_{n}\right)(1+o(1))\right) \text { and } \\
& \left|\Delta_{n}\right| \geq \min \left(\left|K_{2}\left(y_{n}\right)\right|,\left|K_{2}\left(x_{n}\right)\right|\right) \delta_{n}^{2} \Phi\left(\delta_{n} K_{1}\left(y_{n}\right)\left(1-\delta_{n}\right)^{\theta_{1}-1}(1+o(1))\right)
\end{aligned}
$$

where $\Phi(t)=\int_{0}^{1} u \exp (-u t) d u$ for all $t \geq 0$.
Second, as a consequence of the above bounds, a sufficient condition as well as a necessary condition can be established such that $\Delta_{n} \rightarrow 0$ as $n \rightarrow \infty$.

## Lemma 2 (Necessary and sufficient conditions for $\Delta_{n} \rightarrow 0$ )

Assume (7) holds, $K_{1} \in R V_{\theta_{1}}$ with $\theta_{1} \leq 1$ and $K_{2}$ is ultimately of constant sign and monotone.
(i) If $\delta_{n}^{2} \max \left(\left|K_{2}\left(y_{n}\right)\right|,\left|K_{2}\left(x_{n}\right)\right|\right) \rightarrow 0$ then $\Delta_{n} \rightarrow 0$ as $n \rightarrow \infty$.
(ii) If $\Delta_{n} \rightarrow 0$ then $\delta_{n}^{2} \min \left(\left|K_{2}\left(y_{n}\right)\right|,\left|K_{2}\left(x_{n}\right)\right|\right) \rightarrow 0$ as $n \rightarrow \infty$.

It appears that the asymptotic behavior of $\Delta_{n}$ heavily relies on $\ell_{2}$. Since $\ell_{2}$ can be derived from $\ell_{1}$, see Lemma 4 in the Appendix, we are now in position to state our first main result:

Proposition 1 (Role of $\ell_{1}$ for $\Delta_{n} \rightarrow 0$ )
Under the assumptions of Lemma 2,
(i) If $\ell_{1} \in\{0,1\}$ then $\ell_{2}=0$ and $\Delta_{n} \rightarrow 0$ as $n \rightarrow \infty$.
(ii) If $\ell_{1} \in(0, \infty) \backslash\{1\}$ then $\ell_{2} \in(0, \infty)$ and $\Delta_{n} \rightarrow 0$ if and only if $\delta_{n} \rightarrow 0$ as $n \rightarrow \infty$.
(iii) If $\ell_{1}=\infty$ then $\left|\ell_{2}\right|=\infty$ and $\Delta_{n} \rightarrow 0$ if and only if $\delta_{n}^{2} K_{2}\left(y_{n}\right) \rightarrow 0$ as $n \rightarrow \infty$.

Three cases appear. If $\ell_{1} \in\{0,1\}$ then $\Delta_{n} \rightarrow 0$ as $n \rightarrow \infty$ as soon as (7) holds. If $0<\ell_{1}<\infty$ and $\ell_{1} \neq 1$ then a necessary and sufficient condition for $\Delta_{n} \rightarrow 0$ is $\delta_{n} \rightarrow 0$ as $n \rightarrow \infty$. If $\ell_{1}=\infty$ then the necessary and sufficient condition for $\Delta_{n} \rightarrow 0$ is $\delta_{n}^{2} K_{2}\left(y_{n}\right) \rightarrow 0$ as $n \rightarrow \infty$. Clearly, this condition implies $\delta_{n} \rightarrow 0$ since, in this situation, $\left|\ell_{2}\right|=\infty$.

Finally, first order approximations of $\Delta_{n}$ can be provided in each situation.

## Proposition 2 (First order approximations of $\Delta_{n}$ )

Under the assumptions of Lemma 2,
(i) Assume $\ell_{1}=0$ (and thus $\left.\ell_{2}=0\right)$.
(a) If $\delta_{n} \rightarrow 0$ then

\frac{1}{2} \delta_{n}^{2}\left|K_{2}\left(y_{n}\right)\right|(1+o(1)) \leq\left|\Delta_{n}\right| \leq \frac{1}{2} \delta_{n}^{2}\left|K_{2}\left(x_{n}\right)\right|(1+o(1))
$$

(b) If $\delta_{n} \rightarrow \delta \in(0,1)$ then

$$
\left|K_{2}\left(y_{n}\right)\right| \frac{\delta^{2}}{2}(1+o(1)) \leq\left|\Delta_{n}\right| \leq\left|K_{2}\left(x_{n}\right)\right| \frac{\delta^{2}}{2(1-\delta)^{2}}(1+o(1))
$$

(ii) Assume $\ell_{1}=1$ (and thus $\ell_{2}=0$ ).
(a) If $\delta_{n} \rightarrow 0$ then

$$
\frac{1}{2} \delta_{n}^{2}\left|K_{2}\left(y_{n}\right)\right|(1+o(1)) \leq\left|\Delta_{n}\right| \leq \frac{1}{2} \delta_{n}^{2}\left|K_{2}\left(x_{n}\right)\right|(1+o(1))
$$

(b) If $\delta_{n} \rightarrow \delta \in(0,1)$ then

$$
\left|K_{2}\left(y_{n}\right)\right| \delta^{2} \Phi(\delta /(1-\delta))(1+o(1)) \leq\left|\Delta_{n}\right| \leq\left|K_{2}\left(x_{n}\right)\right| \frac{\delta^{2}}{(1-\delta)^{2}} \Phi(\delta)(1+o(1))
$$

(iii) Assume $0<\ell_{1}<\infty$ and $\ell_{1} \neq 1$.
(a) If $\delta_{n} \rightarrow 0$ then

$$
\Delta_{n}=\frac{\ell_{1}\left(\ell_{1}-1\right)}{2} \delta_{n}^{2}(1+o(1)) \text { as } n \rightarrow \infty .
$$

(b) If $\delta_{n} \rightarrow \delta \in(0,1)$ then

$$
\Delta_{n} \rightarrow c\left(\delta, \ell_{1}\right):=\ell_{1}\left(\ell_{1}-1\right) \delta^{2} \int_{0}^{1}(1-\delta u)^{\ell_{1}-2} u d u \text { as } n \rightarrow \infty
$$

(iv) Assume $\ell_{1}=\infty$.
(a) If $\delta_{n} K_{1}\left(y_{n}\right) \rightarrow 0$ then

$$
\Delta_{n}=\frac{1}{2} \delta_{n}^{2} K_{1}^{2}\left(y_{n}\right) \sim \frac{1}{2} \delta_{n}^{2} K_{2}\left(y_{n}\right)(1+o(1)) \text { as } n \rightarrow \infty
$$

(b) If $\delta_{n} K_{1}\left(y_{n}\right) \rightarrow a>0$ then

$$
\Delta_{n} \rightarrow a^{2} \Phi(a) \text { as } n \rightarrow \infty
$$

(c) If $\delta_{n} K_{1}\left(y_{n}\right) \rightarrow \infty$ then

$$
\Delta_{n} \rightarrow 1 \text { as } n \rightarrow \infty
$$

In situations (i) and (ii) where $\ell_{1} \in\{0,1\}, \Delta_{n} \rightarrow 0$ in both cases $\delta_{n} \rightarrow 0$ and $\delta_{n} \rightarrow \delta \neq 0$, and the convergence is the fastest in the case $\delta_{n} \rightarrow 0$. In situation (iii) where $0<\ell_{1}<\infty$ and $\ell_{1} \neq 1$, $\Delta_{n}$ is asymptotically proportional to $\delta_{n}^{2}$. In situation (iv) where $\ell_{1}=\infty, \Delta_{n} \rightarrow 0$ in the only case where $\delta_{n} K_{1}\left(y_{n}\right) \rightarrow 0$ and $\Delta_{n}$ is asymptotically proportional to $\left(\delta_{n} K_{1}\left(y_{n}\right)\right)^{2}$ or equivalently to $\delta_{n}^{2} K_{2}\left(y_{n}\right)$.

## 3 Application to the ET approximation

Recall that $y_{n}=\log \left(1 / p_{n}\right), x_{n}=\log \left(1 / \alpha_{n}\right)$ with $0<p_{n} \leq 1 / n \leq \alpha_{n}<1$. Introduce

$$
\tau_{n}=\frac{\log \left(1 / p_{n}\right)}{\log (n)} \text { and } \tau_{n}^{\prime}=\frac{\log \left(1 / \alpha_{n}\right)}{\log (n)}
$$

so that $p_{n}=n^{-\tau_{n}}, \tau_{n} \geq 1, \alpha_{n}=n^{-\tau_{n}^{\prime}}, \tau_{n}^{\prime} \leq 1$ and $\delta_{n}=1-\tau_{n}^{\prime} / \tau_{n}$. In the sequel, $F$ is assumed to be increasing and twice differentiable and the cumulative hazard rate function is denoted by $H(\cdot)=-\log \bar{F}(\cdot)$. Following the ideas of Section 1, we let $\varphi(\cdot)=(\bar{F})^{-1}(1 / \exp (\cdot))=H^{-1}(\cdot)$ so that $\varepsilon_{\mathrm{ET}}\left(p_{n} ; \alpha_{n}\right)=\Delta_{n}$. In this context, the assumption $K_{1} \in R V_{\theta_{1}}, \theta_{1} \in \mathbb{R}$ has been introduced and discussed by Cees de Valk et. al. in a series of papers [7, 8, 9]. The next result provides a characterization of the tail behavior of $F$ according to the sign of $\theta_{1}$.

## Proposition 3 (Characterizations)

Let $x^{*}:=\sup \{x: F(x)<1\}$ be the endpoint of $F$ and assume that the density $F^{\prime}$ is ultimately monotone.
(i) If $H \in R V_{\beta}, \beta>0$, then $K_{1} \in R V_{0}$ and $\ell_{1}=1 / \beta$.
(ii) $K_{1} \in R V_{\theta_{1}}, \theta_{1}>0$ (and thus $\ell_{1}=\infty$ ) if and only if $x^{*}=\infty$ and $H(\exp \cdot) \in R V_{1 / \theta_{1}}$.
(iii) $K_{1} \in R V_{\theta_{1}}, \theta_{1}<0$ (and thus $\ell_{1}=0$ ) if and only if $x^{*}<\infty$ and $H\left(x^{*}(1-1 / \cdot)\right) \in R V_{-1 / \theta_{1}}$.

In the case (i) where $H$ is regularly varying with index $\beta>0$, necessarily $\theta_{1}=0$ and $F$ is referred to as a Weibull tail-distribution, see for instance $[2,13,16]$. Such distributions encompass Gaussian, Gamma, Exponential and strict Weibull distributions. In the case (ii) where $H$ (exp •) is regularly varying, $F$ is called a log-Weibull tail-distribution, see $[1,11,15]$, the most popular example being the lognormal distribution. The case (iii) corresponds to distributions with a Weibull tail behavior in the neighborhood of a finite endpoint.

Besides, let us highlight that the domain of attraction associated with $F$ depends on the position of $\theta_{1}$ with respect to 1 :

## Proposition 4 (Domains of attraction)

(i) If $K_{1} \in R V_{\theta_{1}}, \theta_{1}<1$, then $F \in M D A$ (Gumbel).
(ii) If $F \in M D A$ (Fréchet) then $K_{1} \in R V_{1}$.
(iii) If $K_{1} \in R V_{\theta_{1}}, \theta_{1}>1$, then $F$ does not belong to any domain of attraction.

These results justify the assumption $\theta_{1} \leq 1$ used in Lemma 2 and its consequences. The situation $\theta_{1}>1$ which does not correspond to any domain of attraction is sometimes referred to as super-heavy tails, see [1] or [3], Section 8.8 for further developments on this topic.

Applying Proposition 1 to the ET framework yields:
Theorem 1 (Necessary and sufficient conditions for $\varepsilon_{\mathbf{E T}}\left(p_{n} ; \alpha_{n}\right) \rightarrow 0$ )
Assume $0<\liminf \tau_{n}^{\prime} / \tau_{n} \leq \lim \sup \tau_{n}^{\prime} / \tau_{n} \leq 1, K_{1} \in R V_{\theta_{1}}$ with $\theta_{1} \leq 1$ and $K_{2}$ is ultimately of constant sign and monotone.
(i) If $\ell_{1} \in\{0,1\}$ then $\varepsilon_{E T}\left(p_{n} ; \alpha_{n}\right) \rightarrow 0$ as $n \rightarrow \infty$.
(ii) If $\ell_{1} \in(0, \infty) \backslash\{1\}$ then $\varepsilon_{E T}\left(p_{n} ; \alpha_{n}\right) \rightarrow 0$ if and only if $\tau_{n} \rightarrow 1$ and $\tau_{n}^{\prime} \rightarrow 1$ as $n \rightarrow \infty$.
(iii) If $\ell_{1}=\infty$ then $\varepsilon_{E T}\left(p_{n} ; \alpha_{n}\right) \rightarrow 0$ if and only if $\left(\tau_{n}-\tau_{n}^{\prime}\right)^{2} K_{2}(\log n) \rightarrow 0$ as $n \rightarrow \infty$.

It appears that, from the extrapolation error point of view, MDA(Gumbel) can be splitted into three sub-domains of attraction:

- $\mathrm{MDA}_{1}$ (Gumbel) defined by $\ell_{1} \in\{0,1\}$ and where the relative extrapolation error tends to zero without restriction on the order $p_{n}$ of the extreme quantile. As illustrated by Proposition 3(iii), the case $\ell_{1}=0$ includes distributions with a finite endpoint. The case $\ell_{1}=1$ encompasses Weibull tail-distributions with shape parameter $\beta=1$ (Proposition 3(i)), i.e close to the Exponential distribution (the Gamma distribution for instance) as well as the class E defined in [5].
- $\mathrm{MDA}_{2}$ (Gumbel) defined by $\ell_{1} \in(0, \infty) \backslash\{1\}$ and where the relative extrapolation error tends to zero for extreme quantiles close to the maximal observation in the sense that $\log \left(p_{n}\right) \sim \log (1 / n)$ as $n \rightarrow \infty$. Extreme orders such as $p_{n}=n^{-\tau}, \tau>1$ are thus not permitted. As illustrated by Proposition 3(i), this situation encompasses Weibull taildistributions with shape parameter $\beta \neq 1$ i.e far from the Exponential distribution (the Gaussian distribution for instance).
- $\mathrm{MDA}_{3}$ (Gumbel) defined by $\ell_{1}=\infty$ and where the relative extrapolation error tends to zero under strong restrictions on the order $p_{n}$ of the extreme quantile: $\log \left(p_{n}\right) / \log (1 / n)=$ $1+o\left(\left|K_{2}(\log n)\right|^{1 / 2}\right)$ as $n \rightarrow \infty$. As illustrated by Proposition 3(ii), this case corresponds to log-Weibull tail-distributions (including the lognormal distribution for instance).

We refer to Table 1 for examples of distributions in each sub-domain. To conclude this part, one may obtain first order approximations of the relative extrapolation error $\varepsilon_{\mathrm{ET}}\left(p_{n} ; \alpha_{n}\right)$ thanks to Proposition 2. For the sake of simplicity, it is assumed that $\left|K_{2}\right|$ is regularly varying. This assumption is in fact not restrictive. Indeed, in case of Weibull tail-distributions with shape parameter $\beta \neq 1$, Proposition 3(i) shows that $\ell_{1} \neq 1$ and Lemma 4(iii) entails $\left|K_{2}\right| \in R V_{0}$. In case of log-Weibull tail-distributions, $\theta_{1}>0$ from Proposition 3(ii) and thus $K_{2} \in R V_{2 \theta_{1}}$ from Lemma 4(iv). Finally, for finite endpoint distributions, $\theta_{1}<0$ from Proposition 3(iii) and thus $\left|K_{2}\right| \in R V_{\theta_{1}}$ from Lemma 4(i).

The results are collected in Theorem 2 below. The following notations have been introduced: $u_{n} \sim v_{n}$ if and only if $u_{n} / v_{n} \rightarrow 1$ as $n \rightarrow \infty$ and $u_{n} \asymp v_{n}$ if and only if $0<\liminf u_{n} / v_{n} \leq$ $\limsup u_{n} / v_{n}<\infty$.

Theorem 2 (First order approximations of $\varepsilon_{\mathbf{E T}}\left(p_{n} ; \alpha_{n}\right)$ )
Suppose $0<\liminf \tau_{n}^{\prime} / \tau_{n} \leq \limsup \tau_{n}^{\prime} / \tau_{n} \leq 1, K_{1} \in R V_{\theta_{1}}$ with $\theta_{1} \leq 1$ and $\left|K_{2}\right| \in R V_{\theta_{2}}$ with $\theta_{2} \in \mathbb{R}$. Then, as $n \rightarrow \infty$ :
(i) Assume $F \in M D A_{1}$ (Gumbel)
(a) If $\delta_{n} \rightarrow 0$ then $\varepsilon_{E T}\left(p_{n} ; \alpha_{n}\right) \sim \frac{1}{2}\left(\tau_{n}-\tau_{n}^{\prime}\right)^{2} K_{2}(\log n) \sim \frac{1}{2} \delta_{n}^{2} K_{2}(\log n)$.
(b) If $\delta_{n} \rightarrow \delta \in(0,1)$ then $\left|\varepsilon_{E T}\left(p_{n} ; \alpha_{n}\right)\right| \asymp\left|K_{2}(\log n)\right|$.
(ii) Assume $F \in M D A_{2}$ (Gumbel)
(a) If $\delta_{n} \rightarrow 0$ then $\varepsilon_{E T}\left(p_{n} ; \alpha_{n}\right) \sim \frac{\ell_{1}\left(\ell_{1}-1\right)}{2}\left(\tau_{n}-\tau_{n}^{\prime}\right)^{2} \sim \frac{\ell_{1}\left(\ell_{1}-1\right)}{2} \delta_{n}^{2}$.
(b) If $\delta_{n} \rightarrow \delta \in(0,1)$ then $\varepsilon_{E T}\left(p_{n} ; \alpha_{n}\right) \rightarrow c\left(\delta, \ell_{1}\right)$.
(iii) Assume $F \in M D A_{3}$ (Gumbel)
(a) If $\delta_{n} K_{1}(\log n) \rightarrow 0$ then $\varepsilon_{E T}\left(p_{n} ; \alpha_{n}\right) \sim \frac{1}{2}\left(\tau_{n}-\tau_{n}^{\prime}\right)^{2} K_{1}^{2}(\log n) \sim \frac{1}{2} \delta_{n}^{2} K_{2}(\log n)$.
(b) If $\delta_{n} K_{1}(\log n) \rightarrow a>0$ then $\varepsilon_{E T}\left(p_{n} ; \alpha_{n}\right) \rightarrow a^{2} \Phi(a)$.
(c) If $\delta_{n} K_{1}(\log n) \rightarrow \infty$ then $\varepsilon_{E T}\left(p_{n} ; \alpha_{n}\right) \rightarrow 1$.

Remark that the only situation where $\delta_{n} \rightarrow \delta \neq 0$ and $\varepsilon_{\mathrm{ET}}\left(p_{n} ; \alpha_{n}\right) \rightarrow 0$ as $n \rightarrow \infty$ occurs for $F \in \mathrm{MDA}_{1}$ (Gumbel). In this case, it is possible to choose extreme orders such that $p_{n}=n^{-\tau}$, $\tau>1$, and the relative extrapolation error tends to zero at a logarithmic rate.

As expected, in the three situations (i,ii,iii)-(a) where $\delta_{n} \rightarrow 0$ and $\varepsilon_{\mathrm{ET}}\left(p_{n} ; \alpha_{n}\right) \rightarrow 0$ as $n \rightarrow \infty$, the convergence is the fastest in $\mathrm{MDA}_{1}$ (Gumbel) and the slowest in $\mathrm{MDA}_{3}$ (Gumbel). Let us also highlight that the rate of convergence is independent from the distribution in $\mathrm{MDA}_{2}$ (Gumbel). To illustrate these results, let us focus on the distributions introduced in Table 1. Clearly, in all six cases, $F \in \mathrm{DA}$ (Gumbel), $K_{1}$ and $\left|K_{2}\right|$ are regularly varying so that the assumptions of Theorem 2 are fulfilled. Let us consider the case where $p_{n}=1 /(n \log n)$ and $\alpha_{n}=(\log n) / n$ leading to

$$
\begin{equation*}
\tau_{n}=1+\frac{\log \log n}{\log n}, \tau_{n}^{\prime}=1-\frac{\log \log n}{\log n} \text { and } \delta_{n} \sim 2 \frac{\log \log n}{\log n}, \tag{9}
\end{equation*}
$$

as $n \rightarrow \infty$. Let us stress that these choices entail $\delta_{n} \rightarrow 0$ and $\delta_{n} K_{1}(\log n) \rightarrow 0$ as $n \rightarrow \infty$ so that Theorem 2(i,ii,iii)-(a) can be applied and $\varepsilon_{\mathrm{ET}}\left(p_{n} ; \alpha_{n}\right) \rightarrow 0$ as $n \rightarrow \infty$ for all six distributions. The associated first order approximations of $\varepsilon_{\mathrm{ET}}\left(p_{n} ; \alpha_{n}\right)$ are provided in Table 2. It appears that, in most cases, the convergence of the relative extrapolation error to zero is rather slow. The $\log$-Weibull $(\beta>1)$ distribution corresponds to the worst case, since arbitrary low rates of convergence can be obtained by letting $\beta \xrightarrow{>} 1$. At the opposite, the Finite endpoint $(\beta>0)$ distribution is the most favorable case, letting $\beta \xrightarrow{\longrightarrow} 0$ could lead to arbitrary high logarithmic rates of convergence.

## 4 Application to Weissman approximation

When $F \in \operatorname{MDA}$ (Fréchet), $\gamma_{n}>0$ and the GPD approximation (1) can be simplified by letting $\sigma_{n}=\gamma_{n} q\left(\alpha_{n}\right)$, see [6], Theorem 1.2.5, leading to

$$
\begin{equation*}
\tilde{q}_{\mathrm{W}}\left(p_{n} ; \alpha_{n}\right)=q\left(\alpha_{n}\right)\left(\frac{\alpha_{n}}{p_{n}}\right)^{\gamma_{n}} \tag{10}
\end{equation*}
$$

which is called Weissman approximation in the sequel. Weissman estimator [23] is then obtained by replacing the intermediate quantile $q\left(\alpha_{n}\right)$ and the tail index $\gamma_{n}$ by appropriate estimators:

$$
\hat{q}_{W}\left(p_{n} ; \alpha_{n}\right)=\hat{q}\left(\alpha_{n}\right)\left(\frac{\alpha_{n}}{p_{n}}\right)^{\hat{\gamma}_{n}} .
$$

The most common choices are $\hat{q}\left(\alpha_{n}\right)=X_{n-k_{n}+1, n}$, see Section 1, and Hill estimator [20]:

$$
\hat{\gamma}_{n}=\frac{1}{k_{n}} \sum_{i=1}^{k_{n}} \log X_{n-i+1, n}-\log X_{n-k_{n}+1, n} .
$$

Taking the logarithm of (10) yields

$$
\log q\left(p_{n}\right)-\log \tilde{q}_{\mathrm{W}}\left(p_{n} ; \alpha_{n}\right)=\log q\left(p_{n}\right)-\log q\left(\alpha_{n}\right)-\gamma_{n} \log \left(\alpha_{n} / p_{n}\right)
$$

and thus, similarly to the ET case (4), the extrapolation error can be interpreted as a first order Taylor remainder. To this end, recall that $y_{n}=\log \left(1 / p_{n}\right), x_{n}=\log \left(1 / \alpha_{n}\right)$ with $0<p_{n} \leq 1 / n \leq$ $\alpha_{n}<1$ and introduce $\varphi(\cdot)=\log (\bar{F})^{-1}(1 / \exp (\cdot))=\log U(\exp \cdot)$ where $U$ is the tail quantile function, so that

$$
\log q\left(p_{n}\right)-\log \tilde{q}_{\mathrm{W}}\left(p_{n} ; \alpha_{n}\right)=\varphi\left(y_{n}\right)-\varphi\left(x_{n}\right)-\gamma_{n}\left(y_{n}-x_{n}\right) \text { where } \gamma_{n}=\varphi^{\prime}\left(x_{n}\right) .
$$

The quantity of interest is

$$
\begin{equation*}
\varepsilon_{\mathrm{W}}\left(p_{n} ; \alpha_{n}\right):=\left(q\left(p_{n}\right)-\tilde{q}_{\mathrm{W}}\left(p_{n} ; \alpha_{n}\right)\right) / q\left(p_{n}\right)=1-\exp \left(-\Delta_{n} \log q\left(p_{n}\right)\right), \tag{11}
\end{equation*}
$$

where $\Delta_{n}$ is defined in (8). Here, the property $K_{1} \in R V_{\theta_{1}}$ is a direct consequence of the assumption $F \in \operatorname{MDA}$ (Fréchet). Indeed, from [6], Corollary 1.2.1, $F \in \mathrm{MDA}$ (Fréchet) is equivalent to $U \in R V_{\gamma}$ for some $\gamma>0$ which can be rewritten as

$$
\begin{equation*}
U(t)=t^{\gamma} L(t), \text { with } L \in R V_{0} \text { and } \gamma>0 . \tag{12}
\end{equation*}
$$

The function $L$ is said to be slowly-varying [3]. Classical properties of slowly-varying functions yield, as $t \rightarrow \infty$,

$$
\begin{align*}
\varphi(t) & =\gamma t+\log L(\exp t) \sim \gamma t  \tag{13}\\
\varphi^{\prime}(t) & =\gamma+\eta(\exp t) \rightarrow \gamma
\end{align*}
$$

where $\eta(t)=t L^{\prime}(t) / L(t)$ is called the auxiliary function associated with $L$. It follows that $K_{1}(t) \rightarrow 1$ as $t \rightarrow \infty$ and thus $\ell_{1}=1$ and $K_{1} \in R V_{0}$. This means that only the case (i) of Proposition 1 and the case (ii) of Proposition 2 have to be considered. In particular $\Delta_{n} \rightarrow 0$ as $n \rightarrow \infty$ without further assumption, which is a very different situation from Section 3:

## Theorem 3 (First order approximation of $\varepsilon_{\mathbf{W}}\left(p_{n} ; \alpha_{n}\right)$ )

Assume (12) hold and let $\eta(t)=t L^{\prime}(t) / L(t)$ be the auxiliary function associated with L. Suppose $\eta$ is asymptotically monotone with a constant sign and $|\eta| \in R V_{\rho}$ with $\rho<0$.
(i) If $\delta_{n} \rightarrow \delta \in(0,1)$ then $\varepsilon_{W}\left(p_{n} ; \alpha_{n}\right) \rightarrow 0$ as $n \rightarrow \infty$.
(ii) Moreover, as $n \rightarrow \infty$,

$$
\varepsilon_{W}\left(p_{n} ; \alpha_{n}\right) \sim-\frac{\delta}{1-\delta} \log \left(1 / \alpha_{n}\right) \eta\left(1 / \alpha_{n}\right)
$$

The assumption $|\eta| \in R V_{\rho}, \rho<0$, is recurrent in extreme-value statistics to control the bias of estimators, $\rho$ being known as the second-order parameter, see e.g. [14]. This assumption holds for most heavy-tailed distributions such as Fréchet, Pareto or Student distributions.

Let us also remark that one can choose extreme orders such that $p_{n}=n^{-\tau}, \tau>1$ as in $\mathrm{DA}_{1}$ (Gumbel), see Theorem 2(i)-(b), and still obtain $\varepsilon_{\mathrm{W}}\left(p_{n} ; \alpha_{n}\right) \rightarrow 0$ as $n \rightarrow \infty$. However, here, the relative extrapolation error converges to zero at a polynomial rate, depending on $\rho$.

## 5 Numerical illustrations

To conclude, the quality of the first order approximations associated with the ET relative extrapolation error given in Table 2 is assessed graphically. Recall that these results are obtained by applying Theorem 2 to sequences $\left(\tau_{n}\right)$ and $\left(\tau_{n}^{\prime}\right)$ given in (9) and distributions described in Table 1: Finite endpoint $(\beta=5), \operatorname{Gamma}(a=0.1)$, $\operatorname{Weibull}(\beta=5)$, Gaussian, $\log$-Weibull $(\beta=3)$ and $\log$ normal $(\sigma=0.5)$. The exact relative extrapolation $\operatorname{error} \varepsilon_{\mathrm{ET}}\left(p_{n} ; \alpha_{n}\right)$ as well as the corresponding first order approximation provided by Theorem 2 are computed as functions of $\log n$. The results are displayed on Figures 1-3. It appears that, for all six distributions, the relative extrapolation error converges towards zero as predicted by Theorem 2 , even though the convergence can be very slow in $\mathrm{DA}_{3}$ (Gumbel), see Figure 3. In all cases, the asymptotic sign of $\varepsilon_{\mathrm{ET}}\left(p_{n} ; \alpha_{n}\right)$ is coherent with the first order equivalent given in Table 2: Positive for $\operatorname{Gamma}(a<1)$, $\log$ Weibull $(\beta>1)$ and lognormal distributions, negative for Finite endpoint $(\beta>0)$, Weibull $(\beta>1)$ and Gaussian distributions. Finally, the first order equivalent provides a reasonable approximation of the error behavior is all situations.

## 6 Proofs of main results

Proof of Lemma 1. (i) A second order Taylor expansion with integral remainder yields

\begin{aligned}
\Delta_{n} & =\int_{x_{n}}^{y_{n}} \frac{K_{2}(t)}{t^{2}} \frac{\varphi(t)}{\varphi\left(y_{n}\right)}\left(y_{n}-t\right) d t \\
& =\delta_{n}^{2} \int_{0}^{1} \frac{K_{2}\left(y_{n}\left(1-\delta_{n} u\right)\right)}{\left(1-\delta_{n} u\right)^{2}} \frac{\varphi\left(y_{n}\left(1-\delta_{n} u\right)\right)}{\varphi\left(y_{n}\right)} u d u
\end{aligned}
$$

thanks to the change of variable $u=\left(y_{n}-t\right) /\left(y_{n}-x_{n}\right)$. Besides,

$$
\begin{aligned}
\frac{\varphi\left(y_{n}\left(1-\delta_{n} u\right)\right)}{\varphi\left(y_{n}\right)} & =\exp \left(\log \varphi\left(y_{n}\left(1-\delta_{n} u\right)\right)-\log \varphi\left(y_{n}\right)\right) \\
& =\exp \left(\int_{y_{n}}^{y_{n}\left(1-\delta_{n} u\right)}(\log \varphi(t))^{\prime} d t\right) \\
& =\exp \left(\int_{y_{n}}^{y_{n}\left(1-\delta_{n} u\right)} \frac{K_{1}(t)}{t} d t\right) \\
& =\exp \left(\int_{1}^{1-\delta_{n} u} \frac{K_{1}\left(v y_{n}\right)}{v} d v\right) \\
& =\exp \left(K_{1}\left(y_{n}\right) \int_{1}^{1-\delta_{n} u} \frac{K_{1}\left(v y_{n}\right)}{K_{1}\left(y_{n}\right)} \frac{d v}{v}\right)
\end{aligned}
$$

Since $1-\delta_{n} u \in\left[1-\delta_{n}, 1\right]$, the regular variation property of $K_{1}$ yields $K_{1}\left(v y_{n}\right) / K_{1}\left(y_{n}\right) \rightarrow v^{\theta_{1}}$ uniformly locally as $y_{n} \rightarrow \infty$, and condition (7) leads to

$$
\frac{\varphi\left(y_{n}\left(1-\delta_{n} u\right)\right)}{\varphi\left(y_{n}\right)}=\exp \left(K_{1}\left(y_{n}\right) L_{\theta_{1}}\left(1-\delta_{n} u\right)(1+o(1))\right)
$$

It thus follows that

$$
\Delta_{n}=\delta_{n}^{2} \int_{0}^{1} \frac{K_{2}\left(y_{n}\left(1-\delta_{n} u\right)\right)}{\left(1-\delta_{n} u\right)^{2}} \exp \left(K_{1}\left(y_{n}\right) L_{\theta_{1}}\left(1-\delta_{n} u\right)(1+o(1))\right) u d u
$$

and the first part of the result is proved.
(ii) The sign of $K_{2}$ is supposed to be ultimately constant so that

$$
\left|\Delta_{n}\right|=\delta_{n}^{2} \int_{0}^{1} \frac{\left|K_{2}\left(y_{n}\left(1-\delta_{n} u\right)\right)\right|}{\left(1-\delta_{n} u\right)^{2}} \exp \left(K_{1}\left(y_{n}\right) L_{\theta_{1}}\left(1-\delta_{n} u\right)(1+o(1))\right) u d u
$$

Let us remark that, for all $u \in[0,1]$ and $\theta_{1} \leq 1$, one has $1-\delta_{n} \leq 1-\delta_{n} u \leq 1$ and

$$
-\left(1-\delta_{n}\right)^{\theta_{1}-1} \delta_{n} u \leq L_{\theta_{1}}\left(1-\delta_{n} u\right) \leq-\delta_{n} u .
$$

It is thus clear that

$$
\begin{aligned}
\left|\Delta_{n}\right| & \leq \frac{\delta_{n}^{2}}{\left(1-\delta_{n}\right)^{2}} \int_{0}^{1}\left|K_{2}\left(y_{n}\left(1-\delta_{n} u\right)\right)\right| \exp \left(-\delta_{n} K_{1}\left(y_{n}\right) u(1+o(1))\right) u d u \text { and } \\
\left|\Delta_{n}\right| & \geq \delta_{n}^{2} \int_{0}^{1}\left|K_{2}\left(y_{n}\left(1-\delta_{n} u\right)\right)\right| \exp \left(-\delta_{n} K_{1}\left(y_{n}\right)\left(1-\delta_{n}\right)^{\theta_{1}-1} u(1+o(1))\right) u d u
\end{aligned}
$$

Since $\left|K_{2}\right|$ is assumed to be ultimately monotone, it follows that, for $n$ large enough,

$$
\min \left(\left|K_{2}\left(y_{n}\right)\right|,\left|K_{2}\left(x_{n}\right)\right|\right) \leq\left|K_{2}\left(y_{n}\left(1-\delta_{n} u\right)\right)\right| \leq \max \left(\left|K_{2}\left(y_{n}\right)\right|,\left|K_{2}\left(x_{n}\right)\right|\right),
$$

leading to

$$
\begin{aligned}
& \left|\Delta_{n}\right| \leq \max \left(\left|K_{2}\left(y_{n}\right)\right|,\left|K_{2}\left(x_{n}\right)\right|\right) \frac{\delta_{n}^{2}}{\left(1-\delta_{n}\right)^{2}} \int_{0}^{1} u \exp \left(-\delta_{n} K_{1}\left(y_{n}\right) u(1+o(1))\right) d u \text { and } \\
& \left|\Delta_{n}\right| \geq \min \left(\left|K_{2}\left(y_{n}\right)\right|,\left|K_{2}\left(x_{n}\right)\right|\right) \delta_{n}^{2} \int_{0}^{1} u \exp \left(-\delta_{n} K_{1}\left(y_{n}\right)\left(1-\delta_{n}\right)^{\theta_{1}-1} u(1+o(1))\right) d u
\end{aligned}
$$

Introducing for all $t \geq 0, \Phi(t)=\int_{0}^{1} u \exp (-u t) d u$, the above bounds can be rewritten as

$$
\begin{aligned}

&\left|\Delta_{n}\right| \geq \min \left(\left|K_{2}\left(y_{n}\right)\right|,\left|K_{2}\left(x_{n}\right)\right|\right) \delta_{n}^{2} \Phi\left(\delta_{n} K_{1}\left(y_{n}\right)\left(1-\delta_{n}\right)^{\theta_{1}-1}(1+o(1))\right)
\end{aligned}
$$

which concludes the proof.

Proof of Lemma 2. Let us focus on the situation where $\left|K_{2}\right|$ is ultimately non decreasing and introduce $A_{n}=\delta_{n} K_{1}\left(y_{n}\right)$.
(i) Assume that $\delta_{n}^{2}\left|K_{2}\left(y_{n}\right)\right| \rightarrow 0$. From Lemma 3(i) in the Appendix, $0 \leq \Phi(t) \leq 1 / 2$ for all $t \geq 0$ and thus Lemma 1(ii) entails

Let us introduce $\xi(w)=\left(L_{\theta_{1}}^{-1}(w)\right)^{\theta_{1}-1}\left(1-L_{\theta_{1}}^{-1}(w)\right)$ for all $w \in\left[L_{\theta_{1}}(1-\delta), 0\right]$. Routine calculations show that $\xi(0)=0$ and $\xi^{\prime}(0)=-1$. A second order Taylor expansion thus yields $\xi(w)=-w+w^{2} \xi^{\prime \prime}\left(\eta_{w}\right) / 2$ with $\eta_{w} \in[w, 0] \subset\left[L_{\theta_{1}}(1-\delta), 0\right]$. Remarking that $\left|\xi^{\prime \prime}\right|$ is bounded on compact sets, there exists $M>0$ such that

& =\exp \left(\log x \int_{0}^{1} \frac{K_{1}(\log t+v \log x)}{\log t+v \log x} d v\right)
\end{aligned}
$$

and the regular variation property of $K_{1}$ implies that

$$
\frac{K_{1}(\log t+v \log x)}{\log t+v \log x}=\frac{K_{1}(\log t)}{\log t}(1+o(1))
$$

as $t \rightarrow \infty$ uniformly locally on $v \in[0,1]$. It follows that

$$
\frac{H^{-1}(\log t x)}{H^{-1}(\log t)}=\exp \left(\log x \frac{K_{1}(\log t)}{\log t}(1+o(1))\right) \rightarrow 1
$$

as $t \rightarrow \infty$ since $K \in R V_{\theta_{1}}$ with $\theta_{1}<1$. As a conclusion, $U^{\prime}(t x) / U^{\prime}(t) \rightarrow 1 / x$ as $t \rightarrow \infty$ for all $x>0$ and thus $U^{\prime} \in R V_{-1}$. This implies that $F \in \operatorname{MDA}(G u m b e l)$, see [6], Corollary 1.1.10.
(ii) Assume $F \in \operatorname{MDA}$ (Fréchet). From [6], Corollary 1.2.10, there exists $\gamma>0$ such that the tail quantile function $U \in R V_{\gamma}$. Since $H^{-1}(\cdot)=U(\exp \cdot)$, it follows that

$$
K_{1}(x)=x \frac{\exp (x) U^{\prime}(\exp x)}{U(\exp x)} \sim \gamma x
$$

as $x \rightarrow \infty$ from the monotone density theorem [3], Theorem 1.7.2. It is thus clear that $K_{1} \in R V_{1}$. (iii) Assume $K_{1} \in R V_{\theta_{1}}, \theta_{1}>1$. First, Proposition 3(ii) implies $x^{*}=\infty$ and thus $F \notin$ MDA(Weibull). Second, Proposition 4(ii) shows that $F \in \operatorname{MDA}$ (Fréchet) entails $K_{1} \in R V_{1}$. It is thus clear that $F \notin \mathrm{MDA}$ (Fréchet). Finally, it remains to show that $F \notin \mathrm{MDA}$ (Gumbel). To this end, consider for all $x>0$ and $t \rightarrow \infty$,

$$
\left.\frac{U(t x)}{U(t)}=\frac{H^{-1}(\log t x)}{H^{-1}(\log t)}=\exp \left\{\frac{1}{\theta_{1}}\left(K_{1}(\log t x)-K_{1}(\log t)\right)(1+o(1))\right)\right\}
$$

from (17) in the proof of Proposition 3(ii, $\Longrightarrow$ ). A first order Taylor expansion yields

$$
\frac{U(t x)}{U(t)}=\exp \left\{\frac{\log x}{\theta_{1}} K_{1}^{\prime}(\log t+\eta \log x)(1+o(1))\right\}=\exp \left\{\frac{\log x}{\theta_{1}} K_{1}^{\prime}(\log t)(1+o(1))\right\}
$$

where $\eta \in(0,1)$ since $K_{1}^{\prime} \in R V_{\theta_{1}-1}$. Recalling that $\theta_{1}>1$, it follows that $K_{1}^{\prime}(\log t) \rightarrow \infty$ as $t \rightarrow \infty$ and therefore $U(t x) / U(t) \rightarrow 0$ as $t \rightarrow \infty$ if $x<1$ and $U(t x) / U(t) \rightarrow \infty$ as $t \rightarrow \infty$ if $x>1$. Finally [6], Lemma 1.2 .9 shows that $F \notin \mathrm{MDA}($ Gumbel ) since $U(t x) / U(t)$ does not converge to 1 as $t \rightarrow \infty$.

Proof of Theorem 1. The proof relies on the application of Proposition 1. Condition (7) is fulfilled under the assumption $0<\lim \inf \tau_{n}^{\prime} / \tau_{n} \leq \lim \sup \tau_{n}^{\prime} / \tau_{n} \leq 1$.
(i) is a straightforward consequence of Proposition 1(i).
(ii) is based on the remark that $\delta_{n} \rightarrow 0$ if and only if $\tau_{n} \rightarrow 1$ and $\tau_{n}^{\prime} \rightarrow 1$ since, by assumption, $\tau_{n}^{\prime} \leq 1 \leq \tau_{n}$.
(iii) Since $\ell_{2}=\infty, \delta_{n}^{2} K_{2}\left(\tau_{n} \log n\right) \rightarrow 0$ implies $\delta_{n} \rightarrow 0$ and thus $\tau_{n} \rightarrow 1$ and $\tau_{n}^{\prime} \rightarrow 1$ in view of the above remark. Thus, $\delta_{n}^{2} \sim\left(\tau_{n}-\tau_{n}^{\prime}\right)^{2}$ as $n \rightarrow \infty$. Besides, Lemma 4(iv) in the Appendix entails that $K_{2}$ is regularly varying when $\ell_{2}=\infty$. As a consequence, $K_{2}\left(\tau_{n} \log n\right) \sim K_{2}(\log n)$ as $n \rightarrow \infty$ and the result is proved.

Proof of Theorem 2. The proof relies on the application of Proposition 2.
(i) is a consequence of Proposition 2(i, ii). Let us highlight that, when $\delta_{n} \rightarrow 0$ then $x_{n} \sim y_{n}$ and thus $\left|K_{2}\left(x_{n}\right)\right| \sim\left|K_{2}\left(y_{n}\right)\right| \sim\left|K_{2}(\log n)\right|$ in view of the assumption $\left|K_{2}\right|$ is regularly varying.

Moreover, $\delta_{n}^{2} \sim\left(\tau_{n}-\tau_{n}^{\prime}\right)^{2}$ as already seen in the proof of Theorem 1. Let us also remark that, since the sign of $K_{2}$ is ultimately constant, in view of Lemma $1(\mathrm{i}), \varepsilon_{\mathrm{ET}}\left(p_{n} ; \alpha_{n}\right)$ and $K_{2}(\log n)$ have ultimately the same sign. The absolute values can thus be dropped. Similarly, when $\delta_{n} \rightarrow \delta \in(0,1)$ then $x_{n} \asymp y_{n}$ and thus $\left|K_{2}\left(x_{n}\right)\right| \asymp\left|K_{2}\left(y_{n}\right)\right| \asymp\left|K_{2}(\log n)\right|$.
(ii) is a straightforward consequence of Proposition 2(iii).
(iii) is a consequence of Proposition 2(iv). If $\delta_{n} K_{1}(\log n) \rightarrow a \geq 0$ then necessarily $\delta_{n} \rightarrow 0$ and thus $y_{n} \sim \log n$ leading to $K_{1}\left(y_{n}\right) \sim K_{1}(\log n)$. In the case where $\delta_{n} K_{1}(\log n) \rightarrow \infty$, one still has $1 \leq \lim \inf \tau_{n} \leq \limsup \tau_{n}<\infty$ and thus $K_{1}\left(y_{n}\right) \asymp K_{1}(\log n)$, the result is proved.

Proof of Theorem 3. The proof relies on the application of Lemma 1(i) and the fact that $K_{1}(t) \rightarrow 1$ as $t \rightarrow \infty$ entailing $K_{1} \in R V_{0}$ :

$$
\Delta_{n}=\delta_{n}^{2} \int_{0}^{1} K_{2}\left(y_{n}\left(1-\delta_{n} u\right)\right)\left(1-\delta_{n} u\right)^{-1+o(1)} u d u
$$

From (13), $\varphi^{\prime \prime}(t)=\exp (t) \eta^{\prime}(\exp (t))$ and consequently

$$
K_{2}(t) \sim \frac{1}{\gamma} t \exp (t) \eta^{\prime}(\exp (t))
$$

as $t \rightarrow \infty$. Moreover, $\eta$ is asymptotically monotone with a constant sign and $|\eta| \in R V_{\rho}$ imply that $x \eta^{\prime}(x) / \eta(x) \rightarrow \rho$ as $x \rightarrow \infty$, leading to, as $t \rightarrow \infty$,

$$
K_{2}(t) \sim \frac{\rho}{\gamma} \operatorname{t\eta }(\exp (t)) .
$$

It follows, when $\delta_{n} \rightarrow \delta \in(0,1)$,

$$
\Delta_{n} \sim y_{n} \frac{\delta^{2} \rho}{\gamma} \int_{0}^{1} u \eta\left(e^{y_{n}\left(1-\delta_{n} u\right)}\right) d u
$$

Since $|\eta| \in R V_{\rho}$, Potter's bounds (see for instance [6], Proposition B.1.9 (5.)) entail that there exists $0<\epsilon<|\rho|$ such that

$$
(1-\epsilon) e^{y_{n} \delta_{n}(1-u)(\rho-\epsilon)} \leq \frac{|\eta|\left(e^{y_{n}\left(1-\delta_{n} u\right)}\right)}{|\eta|\left(e^{x_{n}}\right)} \leq(1+\epsilon) e^{y_{n} \delta_{n}(1-u)(\rho+\epsilon)} .
$$

Recalling that $\eta$ is asymptotically monotone with a constant sign yields

$$
\Delta_{n} \sim \frac{\delta^{2} \rho}{\gamma} \eta\left(e^{x_{n}}\right) I_{n} y_{n}
$$

where $I_{n}^{-} \leq I_{n} \leq I_{n}^{+}$and

$$
\begin{aligned}
& I_{n}^{-}=(1-\epsilon) \int_{0}^{1} u e^{y_{n} \delta_{n}(1-u)(\rho-\epsilon)} d u \\
& I_{n}^{+}=(1+\epsilon) \int_{0}^{1} u e^{y_{n} \delta_{n}(1-u)(\rho+\epsilon)} d u
\end{aligned}
$$

Straightforward calculations show that

$$
\int_{0}^{1} u e^{y_{n} \delta_{n}(1-u) x} d u \sim-\frac{1}{y_{n} \delta x},
$$

as $n \rightarrow \infty$, since $\delta_{n} \rightarrow \delta$ and thus $y_{n} \delta_{n} \rightarrow \infty$. Consequently, $I_{n}^{-} \sim(1-\epsilon) /\left(y_{n} \delta(\epsilon-\rho)\right)$, $I_{n}^{+} \sim(1+\epsilon) /\left(y_{n} \delta(-\epsilon-\rho)\right)$ and thus $I_{n} y_{n} \in\left[\frac{(1-\epsilon)}{\delta(\epsilon-\rho)}(1+o(1)) ; \frac{(1+\epsilon)}{\delta(-\epsilon-\rho)}(1+o(1))\right]$. Letting $\epsilon \rightarrow 0$ entails $I_{n} y_{n} \rightarrow-1 /(\rho \delta)$ as $n \rightarrow \infty$ and thus

$$
\Delta_{n} \sim-\frac{\delta}{\gamma} \eta\left(e^{x_{n}}\right) .
$$

Remarking that $\log q\left(p_{n}\right)=\varphi\left(y_{n}\right) \sim \gamma y_{n} \sim \frac{\gamma}{1-\delta} x_{n}$ and taking account of (11) yield, when $\delta_{n} \rightarrow \delta \in(0,1)$,

$$
\varepsilon_{\mathrm{W}}\left(p_{n} ; \alpha_{n}\right)=1-\exp \left(-\frac{\gamma}{1-\delta} \Delta_{n} x_{n}(1+o(1))\right)
$$

Finally, since $|\eta| \in R V_{\rho}, \rho<0, \Delta_{n} x_{n} \sim-\frac{\delta}{\gamma} x_{n} \eta\left(e^{x_{n}}\right) \rightarrow 0$ as $n \rightarrow \infty$ and thus

$$
\varepsilon_{\mathrm{W}}\left(p_{n} ; \alpha_{n}\right) \sim-\frac{\delta}{1-\delta} x_{n} \eta\left(e^{x_{n}}\right) \sim-\frac{\delta}{1-\delta} \log \left(1 / \alpha_{n}\right) \eta\left(1 / \alpha_{n}\right),
$$

which concludes the proof of (i) and (ii).

## Appendix: Auxiliary results

Lemma 3 For all $(a, b, t) \in \mathbb{R}_{+}^{3}$, let

$$
\Psi_{a}(t ; b)=\int_{0}^{b} u^{a} \exp (-t u) d u
$$

and remark that $\Phi(\cdot)=\Psi_{1}(\cdot ; 1)$.
(i) $\Psi_{a}(\cdot ; b)$ is continuous, non-increasing on $\mathbb{R}_{+}, \Psi_{a}(0 ; b)=b^{a+1} /(a+1)$ and $\Psi_{a}(t ; b) \rightarrow 0$ as $t \rightarrow \infty$.
(ii) $\Psi_{1}(t, b) \sim 1 / t^{2}$ and $\Psi_{2}(t, b) \sim 1 / t^{3}$ as $t \rightarrow \infty$.

The proof is straightforward.
Lemma 4 Assume $K_{1} \in R V_{\theta_{1}}$.
(i) If $\ell_{1}=0$ then $\theta_{1} \leq 0$ and $\ell_{2}=0$. If, moreover, $\theta_{1}<0$, then $-K_{2} \in R V_{\theta_{1}}$ and $K_{2}(t) \sim$ $\left(\theta_{1}-1\right) K_{1}(t)$ as $t \rightarrow \infty$.
(ii) If $\ell_{1}=1$ then $\theta_{1}=0$ and $\ell_{2}=0$.
(iii) If $0<\ell_{1}<\infty$ and $\ell_{1} \neq 1$ then $\theta_{1}=0, \ell_{2}=\ell_{1}\left(\ell_{1}-1\right) \neq 0$ and $\left|K_{2}\right| \in R V_{0}$.
(iv) If $\ell_{1}=\infty$ then $\theta_{1} \geq 0, \ell_{2}=\infty, K_{2} \in R V_{2 \theta_{1}}$ and $K_{2}(t) \sim K_{1}^{2}(t)$ as $t \rightarrow \infty$.

Proof. The proof relies on the following four facts: First, for all $x \in \mathbb{R}$,

$$
K_{2}(x)=K_{1}^{2}(x)+K_{1}(x)\left(\frac{x K_{1}^{\prime}(x)}{K_{1}(x)}-1\right),
$$

or, equivalently,

$$
\begin{equation*}
\frac{K_{2}(x)}{K_{1}^{2}(x)}=1+\frac{1}{K_{1}(x)}\left(\frac{x K_{1}^{\prime}(x)}{K_{1}(x)}-1\right) \tag{18}
\end{equation*}
$$

Second, $x K_{1}^{\prime}(x) / K_{1}(x) \rightarrow \theta_{1}$ as $x \rightarrow \infty$. Third, it straightforwardly follows that $\ell_{2}=\ell_{1}\left(\ell_{1}+\right.$ $\left.\theta_{1}-1\right)$. Finally, for all positive function $K, K(x) \rightarrow c>0$ as $x \rightarrow \infty$ implies $K \in R V_{0}$.
