# UNIQUENESS OF AXISYMMETRIC VISCOUS FLOWS ORIGINATING FROM POSITIVE LINEAR COMBINATIONS OF CIRCULAR VORTEX FILAMENTS

#### Abstract

Following the recent papers [9] and [10] by T. Gallay and V. Šverák, in the line of work initiated by H. Feng and V. S̆verák in their paper [3], we prove the uniqueness of a solution of the axisymmetric Navier-Stokes equations without swirl when the initial data is a positive linear combination of Dirac masses.

## 1. Introduction

In 3-D ideal fluids, a vortex ring is an axisymmetric flow whose vorticity is entirely concentrated in a solid torus, which moves with constant speed along the symmetry axis. See $[1,4,5,6]$ for the existence of vortex ring solutions to the 3-D Euler equations.

However, for viscous fluids, the vortex ring solutions can not exist, since all localized structures will be spread out by diffusion. Thus it is natural to consider the Navier-Stokes equations with a vortex filament, and more generally with positive linear combinations of circular vortex filaments which have a common axis of symmetry as initial data.

To state this precisely, let us start with the Navier-Stokes equations in $\mathbb{R}^{3}$

$$
\begin{equation*}
\partial_{t} u+u \cdot \nabla u-\Delta u+\nabla p=0, \quad \operatorname{div} u=0, \quad(t, x) \in \mathbb{R}^{+} \times \mathbb{R}^{3}, \tag{1.1}
\end{equation*}
$$

where $u(t, x)=\left(u^{1}, u^{2}, u^{3}\right)$ stands for the velocity field and $p$ the scalar pressure function of the fluid, which guarantees that the velocity field remains divergence free.
In the following, we restrict ourselves to the axisymmetric solutions without swirl of (1.1), for which the velocity field $u$ and the vorticity $\omega \stackrel{\text { def }}{=} \operatorname{curl} u$ take the particular form

$$
u(t, x)=u^{r}(t, r, z) e_{r}+u^{z}(t, r, z) e_{z}, \quad \omega(t, x)=\omega^{\theta}(t, r, z) e_{\theta},
$$

where $(r, \theta, z)$ denotes the cylindrical coordinates in $\mathbb{R}^{3}$ so that $x=(r \cos \theta, r \sin \theta, z)$, and

$$
e_{r}=(\cos \theta, \sin \theta, 0), e_{\theta}=(-\sin \theta, \cos \theta, 0), e_{z}=(0,0,1), r=\sqrt{x_{1}^{2}+x_{2}^{2}} .
$$

In view of [9], we equip the half-plane $\Omega=\{(r, z) \mid r>0, z \in \mathbb{R}\}$ with the measure $d r d z$. More precisely, for any measurable function $f: \Omega \rightarrow \mathbb{R}$, we denote

$$
\|f\|_{L^{p}(\Omega)} \stackrel{\text { def }}{=}\left(\int_{\Omega}|f(r, z)|^{p} d r d z\right)^{\frac{1}{p}}<\infty, 1 \leq p<\infty,
$$

and $\|f\|_{L^{\infty}(\Omega)}$ to be the essential supremum of $|f|$ on $\Omega$. For notational simplicity, we shall always denote a generic point in $\Omega$ by $x=(r, z)$.

Recalling the axisymmetric Biot-Savart law discussed in Section 2 of [9], we know that for any given $\omega^{\theta} \in L^{1}(\Omega) \cap L^{\infty}(\Omega)$ which vanishes on $r=0$, the linear elliptic system

$$
\left\{\begin{array}{l}
\partial_{r} u^{r}+\frac{1}{r} u^{r}+\partial_{z} u^{z}=0, \quad \partial_{z} u^{r}-\partial_{r} u^{z}=\omega^{\theta}, \quad \text { on } \Omega, \\
\left.u^{r}\right|_{r=0}=0,\left.\quad \partial_{r} u^{z}\right|_{r=0}=0,
\end{array}\right.
$$

has a unique solution $\left(u^{r}, u^{z}\right) \in C(\Omega)^{2}$ vanishing at infinity. We denote this solution by $u=B S\left[\omega^{\theta}\right]$. Hence we only need to study the equation for $\omega^{\theta}$ :

$$
\begin{equation*}
\partial_{t} \omega^{\theta}+\left(u^{r} \partial_{r}+u^{z} \partial_{z}\right) \omega^{\theta}-\frac{u^{r} \omega^{\theta}}{r}=\left(\partial_{r}^{2}+\partial_{z}^{2}+\frac{1}{r} \partial_{r}-\frac{1}{r^{2}}\right) \omega^{\theta} . \tag{1.2}
\end{equation*}
$$

Now let us discuss the initial condition. We first recall from [9] that, the axisymmetric vorticity equation (1.2) is globally well-posed whenever the initial vorticity is in $L^{1}(\Omega)$. As a natural extension, then they considered the initial vorticity in $\mathcal{M}(\Omega)$, which denotes the set of all real-valued finite regular measures on $\Omega$, equipped with the total variation norm

$$
\|\mu\|_{\mathrm{tv}} \stackrel{\text { def }}{=} \sup \left\{\int_{\Omega} \phi d \mu \mid \phi \in C_{0}(\Omega),\|\phi\|_{L^{\infty}(\Omega)} \leq 1\right\},
$$

where $C_{0}(\Omega)$ denotes the set of all real-valued continuous functions on $\Omega$ that vanishes at infinity and on the boundary $\partial \Omega$. It is also proved in [9] that (1.2) is globally well-posed if the initial vorticity $\mu$ is in $\mathcal{M}(\Omega)$ whose atomic part is small enough.

As mentioned in the first paragraph of the introduction, we focus here on the particular case

$$
\mu=\sum_{i=1}^{n} \alpha_{i} \delta_{x_{i}}
$$

where $\alpha_{i}$ is some positive constant and $\delta_{x_{i}}$ is the Dirac mass at point $x_{i}=\left(r_{i}, z_{i}\right) \in \Omega$ with $r_{i}>0$. Such a $\mu$ is purely atomic and we deduce from [9] that (1.2) is global well-posed provided that

$$
\|\mu\|_{\mathrm{tv}}=\sum_{i=1}^{n} \alpha_{i}
$$

is small enough. On the other hand, for arbitrary positive values of $\alpha_{i},[3]$ gives the existence of a global mild solution, and [10] proves the uniqueness when $n=1$. In this paper, we prove the uniqueness for general $n$. Our result can be stated as follows:
Theorem 1.1. Fix an integer $n$. Let

$$
\mu=\sum_{i=1}^{n} \alpha_{i} \delta_{x_{i}}
$$

where $\alpha_{i}$ is some positive constant and $\delta_{x_{i}}$ is the Dirac mass at point $x_{i}=\left(r_{i}, z_{i}\right) \in \Omega$ with $r_{i}>0$. Then (1.2) has a unique global solution $\omega^{\theta}$ in $\mathcal{C}(] 0, \infty\left[, L^{1}(\Omega) \cap L^{\infty}(\Omega)\right)$ in the mild sense (see Definition 2.1), satisfying

$$
\begin{equation*}
\sup _{t>0}\left\|\omega^{\theta}(t)\right\|_{L^{1}(\Omega)}<\infty, \quad \text { and } \quad \omega^{\theta}(t) d r d z \rightharpoonup \mu \quad \text { as } \quad t \rightarrow 0 \tag{1.3}
\end{equation*}
$$

Moreover, there exists some constant $C_{0}$ depending only on $\left(\alpha_{i}, x_{i}\right)_{i=1}^{n}$, such that whenever $\sqrt{t} \leq \frac{1}{2} \min _{1 \leq i<j \leq n}\left\{\left|x_{i}-x_{j}\right|, r_{i}\right\}$, there holds the following short time estimate:

$$
\begin{equation*}
\left\|\omega^{\theta}(t, \cdot)-\frac{1}{4 \pi t} \sum_{i=1}^{n} \alpha_{i} e^{-\frac{\left|-x_{i}\right|^{2}}{4 t}}\right\|_{L^{1}(\Omega)} \leq C_{0} \sqrt{t}|\ln t| \tag{1.4}
\end{equation*}
$$

Let us end this section with some notations. We use $C$ (resp. $C_{0}$ ) to denote some absolute positive constant (resp. some positive constant depending on $\left.\left(\alpha_{i}, x_{i}\right)_{i=1}^{n}\right)$, which may be different in each occurrence. $f \lesssim g$ means that there exists some constant $C$ such that $f \leq C g$. For a Banach space $B$, we shall use the shorthand $\|u\|_{L_{T}^{p} B}$ for the norm $\left\|\|u(t, \cdot)\|_{B}\right\|_{L^{p}(0, T)}$.

## 2. Decomposition of the solution

In order to use the uniqueness result for the case when the initial measure is one single Dirac mass which has been proved in [10], a natural thought is to decompose the solution into $n$ parts:

$$
\omega^{\theta}=\sum_{i=1}^{n} \omega_{i}^{\theta}
$$

according to the decomposition of the initial measure

$$
\mu=\sum_{i=1}^{n} \alpha_{i} \delta_{x_{i}}
$$

The nonlinearity of the equation (1.2) renders this idea nontrivial to implement. The strategy is to use the fundamental solution of some advection-diffusion equation. This will be done in the first subsection.

The purpose of the second subsection will be to show that, at least for short times, $\omega_{i}^{\theta}$ is very close - in the $L^{1}(\Omega)$ sense - to the Oseen vortex located at $x_{i}$ with circulation $\alpha_{i}$. This goal will be achieved using self-similar variables around the point $x_{i}$.
2.1. The linear semigroup and the trace of the solution at initial time. Let us denote by $(S(t))_{t \geq 0}$ the evolution semigroup defined by the linearized system of (1.2), namely

$$
\left\{\begin{array}{l}
\partial_{t} \omega^{\theta}-\left(\partial_{r}^{2}+\partial_{z}^{2}+\frac{1}{r} \partial_{r}-\frac{1}{r^{2}}\right) \omega^{\theta}=0, \quad(t, r, z) \in \mathbb{R}^{+} \times \Omega  \tag{2.1}\\
\left.\omega^{\theta}\right|_{r=0}=0,\left.\quad \omega^{\theta}\right|_{t=0}=\omega_{0}^{\theta}
\end{array}\right.
$$

One can see Section 3 of [9] for a detailed study of this semigroup.
By using $(S(t))_{t \geq 0}$, we can define the mild solutions of (1.2) in the following way:
Definition 2.1. Let $T>0$, we say that $\omega^{\theta} \in C(] 0, T\left[, L^{1}(\Omega) \cap L^{\infty}(\Omega)\right)$ is a mild solution of (1.2) on $] 0, T$, if for any $0<t_{0}<t<T$, there holds the following integral equation

$$
\begin{equation*}
\omega^{\theta}(t)=S\left(t-t_{0}\right) \omega^{\theta}\left(t_{0}\right)-\int_{t_{0}}^{t} S(t-s) \operatorname{div}_{*}\left(u(s) \omega^{\theta}(s)\right) d s \tag{2.2}
\end{equation*}
$$

Here $u=\mathrm{BS}\left[\omega^{\theta}\right]$ and $\operatorname{div}_{*}\left(u \omega^{\theta}\right) \stackrel{\text { def }}{=} \partial_{r}\left(u^{r} \omega^{\theta}\right)+\partial_{z}\left(u^{z} \omega^{\theta}\right)$.
Before proceeding further, let us recall some a priori estimates for the mild solution.
Lemma 2.1. Let $\omega^{\theta}$ be a mild solution of (1.2) on ( $0, T$ ) satisfying (1.3), $u=\mathrm{BS}\left[\omega^{\theta}\right]$. It is shown in Estimates (2.13), (2.14) of [10] that, for any $t \in] 0, T[$, and any $k, \ell \in \mathbb{N}$, there holds

$$
\begin{equation*}
t^{k+\frac{\ell}{2}+\frac{1}{2}}\left\|\partial_{t}^{k} \nabla_{x}^{\ell} u(t)\right\|_{L^{\infty}(\Omega)}+t^{\frac{3}{2}}\left\|\nabla \omega^{\theta}(t)\right\|_{L^{\infty}(\Omega)} \leq C_{0} \tag{2.3}
\end{equation*}
$$

Moreover, we can deduce from Estimate (9) of [9] that

$$
\begin{equation*}
\lim _{t \rightarrow 0} t^{1-\frac{1}{p}}\left\|\omega^{\theta}(t)\right\|_{L^{p}(\Omega)}=0, \quad \text { for any } \quad 1<p \leq \infty \tag{2.4}
\end{equation*}
$$

Combining the conclusions of Corollary 2.9, 2.10 and Remark 2.11 in [10], we prove the following.

Proposition 2.1. For any $T>0$, if $\omega^{\theta} \in C\left((0, T), L^{1}(\Omega) \cap L^{\infty}(\Omega)\right)$ is a mild solution of (1.2) on $(0, T)$ satisfying (1.3), then for any $t \in(0, T)$ and $(r, z) \in \Omega$, we have

$$
\begin{equation*}
\omega^{\theta}(t, r, z) \geq 0, \quad\left\|\omega^{\theta}(t)\right\|_{L^{1}(\Omega)} \leq\|\mu\|_{\mathrm{tv}} \quad \text { and } \quad \lim _{t \rightarrow 0}\left\|\omega^{\theta}(t)\right\|_{L^{1}(\Omega)}=\|\mu\|_{\mathrm{tv}} \tag{2.5}
\end{equation*}
$$

Moreover, for any bounded and continuous function $\phi$ on $\Omega$, there holds the convergence

$$
\begin{equation*}
\int_{\Omega} \phi(r, z) \omega^{\theta}(t, r, z) d r d z \rightarrow \int_{\Omega} \phi d \mu, \quad \text { as } \quad t \rightarrow 0 \tag{2.6}
\end{equation*}
$$

Noting that although the initial measure $\mu$ is no longer a single Dirac mass as considered in [10], it is still supported in $\left[\min _{1 \leq i \leq n} r_{i}, \max _{1 \leq i \leq n} r_{i}\right] \times \mathbb{R}$. Thus the estimates of Proposition 3.1, 3.3 and then Lemma 3.8 in [10] still hold for the case here. Precisely, we have

$$
\begin{equation*}
\int_{0}^{T}\left\|u^{r}(t) / r\right\|_{L^{\infty}(\Omega)} d t \leq C_{0} \tag{2.7}
\end{equation*}
$$

Next, let us state a particular case of Aronson's pioneering work [2] on the fundamental solution of parabolic equations, which will be a key ingredient in our decomposition.

Proposition 2.2 (Proposition 3.9 of [10]). Assume that $U, V:(0, T) \times \mathbb{R}^{3} \rightarrow \mathbb{R}^{3}$ are continuous functions such that $\operatorname{div} U(t, \cdot)=0$, for all $t \in(0, T)$ and

$$
\sup _{0<t<T} t^{\frac{1}{2}}\|U(t, \cdot)\|_{L^{\infty}\left(\mathbb{R}^{3}\right)}=K_{1}<\infty, \quad \int_{0}^{T}\|V(t, \cdot)\|_{L^{\infty}\left(\mathbb{R}^{3}\right)} d t=K_{2}<\infty
$$

Then the regular solutions of the following type advection-diffusion equation

$$
\begin{equation*}
\partial_{t} f+U \cdot \nabla f-V f=\Delta f, \quad x \in \mathbb{R}^{3}, \quad t \in(0, T) \tag{2.8}
\end{equation*}
$$

can be represented in the following way:

$$
f(t, x)=\int_{\mathbb{R}^{3}} \Phi_{U, V}(t, x ; s, y) f(s, y) d y, \quad x \in \mathbb{R}^{3}, 0<s<t<T
$$

where $\Phi_{U, V}$ is the (uniquely defined) fundamental solution, which is Hölder continuous in space and time, and satisfies, for all $x, y \in \mathbb{R}^{3}$ and $0<s<t<T$, that

$$
\begin{equation*}
0<\Phi_{U, V}(t, x ; s, y) \leq \frac{C}{(t-s)^{\frac{3}{2}}} \exp \left(-\frac{|x-y|^{2}}{4(t-s)}+K_{1} \frac{|x-y|}{\sqrt{t-s}}+K_{2}\right) \tag{2.9}
\end{equation*}
$$

It is easy to derive the evolution equation for $\omega=\omega^{\theta}(t, r, z) e_{\theta}$ from (1.1) that

$$
\begin{equation*}
\partial_{t} \omega+u \cdot \nabla \omega-r^{-1} u^{r} \omega=\Delta \omega, \quad x \in \mathbb{R}^{3}, \quad t \in(0, T) \tag{2.10}
\end{equation*}
$$

which is exactly of the form (2.8) with $U=u, V=r^{-1} u^{r}$. In view of (2.3) and (2.7), the conditions of Proposition 2.2 are satisfied. Thus this $\omega$ can be represented as

$$
\omega(t, x)=\int_{\mathbb{R}^{3}} \Phi(t, x ; s, y) \omega(s, y) d y, \quad x \in \mathbb{R}^{3}, 0<s<t<T
$$

From which, we can deduce that $\omega^{\theta}$ satisfies

$$
\begin{equation*}
\omega^{\theta}(t, r, z)=\int_{\Omega} \widetilde{\Phi}\left(t, r, z ; s, r^{\prime}, z^{\prime}\right) \omega^{\theta}\left(s, r^{\prime}, z^{\prime}\right) d r^{\prime} d z^{\prime}, \quad 0<s<t<T \tag{2.11}
\end{equation*}
$$

where

$$
\widetilde{\Phi}\left(t, r, z ; s, r^{\prime}, z^{\prime}\right)=\int_{-\pi}^{\pi} \Phi\left(t,(r, 0, z) ; s,\left(r^{\prime} \cos \theta, r^{\prime} \sin \theta, z^{\prime}\right)\right) \cdot r^{\prime} \cos \theta d \theta
$$

Using the Gaussian upper bound (2.9) of the fundamental solution $\Phi$, we get
Lemma 2.2 (Lemma 3.10 of [10]). For any $\eta \in] 0,1[$ and $0<s<t<T$, there exists some positive constant $C_{\eta, \alpha}$ depending only on the choice of $\eta$ and $\left(\alpha_{i}\right)_{i=1}^{n}$, such that

$$
\begin{equation*}
0<\widetilde{\Phi}\left(t, r, z ; s, r^{\prime}, z^{\prime}\right) \leq \frac{C_{\eta, \alpha}}{t-s}\left|\frac{r^{\prime}}{r}\right|^{\frac{1}{2}} \widetilde{H}\left(\frac{t-s}{(1-\eta) r r^{\prime}}\right) e^{-\frac{1-\eta}{4(t-s)}\left(\left(r-r^{\prime}\right)^{2}+\left(z-z^{\prime}\right)^{2}\right)} \tag{2.12}
\end{equation*}
$$

where $\widetilde{H}:(0, \infty) \rightarrow \mathbb{R}$ is decreasing with $\tilde{H}(\tau) \rightarrow 1$ as $\tau \rightarrow 0$ and $\tilde{H}(\tau) \sim 1 / \sqrt{\pi \tau}$ as $\tau \rightarrow \infty$.
Let us write (2.11) in the following way

$$
\begin{aligned}
\omega^{\theta}(t, r, z)= & \int_{\Omega} \widetilde{\Phi}\left(t, r, z ; 0, r^{\prime}, z^{\prime}\right) \omega^{\theta}\left(s, r^{\prime}, z^{\prime}\right) d r^{\prime} d z^{\prime} \\
& +\int_{\Omega}\left(\widetilde{\Phi}\left(t, r, z ; s, r^{\prime}, z^{\prime}\right)-\widetilde{\Phi}\left(t, r, z ; 0, r^{\prime}, z^{\prime}\right)\right) \omega^{\theta}\left(s, r^{\prime}, z^{\prime}\right) d r^{\prime} d z^{\prime}
\end{aligned}
$$

In view of the Hölder continuity and Gaussian upper bound (2.9) of the fundamental solution $\Phi$, we deduce that $\widetilde{\Phi}$ is continuous whenever $0<s<t<T$. Combining this with the facts that $\widetilde{\Phi}$ is bounded as shown in (2.12), and $\left\|\omega^{\theta}(t)\right\|_{L^{1}(\Omega)} \leq\|\mu\|_{\text {tv }}$ as shown in (2.5), we know the second integral in the right-hand side converges to 0 as $s$ tends to 0 . On the other hand, since $\widetilde{\Phi}$ is continuous and bounded, we can use (2.6) to derive the limit of the first integral as $s$ tends to 0 , and we finally obtain the following useful representation:

$$
\omega^{\theta}(t, r, z)=\int_{\Omega} \widetilde{\Phi}\left(t, r, z ; 0, r^{\prime}, z^{\prime}\right) d \mu
$$

Recalling $\mu=\sum_{i=1}^{n} \alpha_{i} \delta_{x_{i}}$, we can obtain the decomposition for $\omega^{\theta}$ as follows:

$$
\begin{equation*}
\omega^{\theta}(t, r, z)=\sum_{i=1}^{n} \omega_{i}^{\theta}(t, r, z), \quad \text { where } \quad \omega_{i}^{\theta}(t, r, z)=\alpha_{i} \widetilde{\Phi}\left(t, r, z ; 0, r_{i}, z_{i}\right) \tag{2.13}
\end{equation*}
$$

and the corresponding decomposition for $u=B S\left[\omega^{\theta}\right]$ :

$$
\begin{equation*}
u(t, r, z)=\sum_{i=1}^{n} u_{i}(t, r, z), \quad \text { where } \quad u_{i}=B S\left[\omega_{i}^{\theta}\right] \tag{2.14}
\end{equation*}
$$

It is easy to see that $\omega_{i}^{\theta} \in C(] 0, T\left[, L^{1}(\Omega) \cap L^{\infty}(\Omega)\right)$ is a mild solution of

$$
\left\{\begin{array}{l}
\left.\partial_{t} \omega_{i}^{\theta}+u \cdot \nabla \omega_{i}^{\theta}-\left(\partial_{r}^{2}+\partial_{z}^{2}+\frac{1}{r} \partial_{r}-\frac{1}{r^{2}}\right) \omega_{i}^{\theta}=0, \quad(t, r, z) \in\right] 0, T[\times \Omega  \tag{2.15}\\
\omega_{i}^{\theta} \rightharpoonup \alpha_{i} \delta_{x_{i}} \quad \text { as } \quad t \rightarrow 0
\end{array}\right.
$$

Moreover, we have the following estimates for $\omega_{i}^{\theta}$.
Proposition 2.3. $i$ ) For any $\eta \in] 0,1[,(r, z) \in \Omega$ and $0<t<T$, we have

$$
\begin{gather*}
0<\omega_{i}^{\theta}(t, r, z) \leq \frac{C_{\eta, \alpha}}{t} e^{-\frac{1-\eta}{4 t}\left(\left(r-r_{i}\right)^{2}+\left(z-z_{i}\right)^{2}\right)}  \tag{2.16}\\
\left\|\omega_{i}^{\theta}(t)\right\|_{L^{1}(\Omega)} \leq\|\mu\|_{\mathrm{tv}} \quad \text { and } \quad \lim _{t \rightarrow 0}\left\|\omega_{i}^{\theta}(t)\right\|_{L^{1}(\Omega)}=\alpha_{i} . \tag{2.17}
\end{gather*}
$$

ii) There exists some positive time $t_{1}<T$, such that for any $0<t<t_{1}$, there holds

$$
\begin{equation*}
t^{\frac{3}{2}}\left\|\nabla \omega_{i}^{\theta}(t)\right\|_{L^{\infty}(\Omega)} \leq C_{0} \tag{2.18}
\end{equation*}
$$

Proof. i) Using (2.12), we immediately get

\end{equation*}
$$

When $2 r \leq r_{i}$, using the facts $\widetilde{H}(\tau) \leq 1 / \sqrt{\pi \tau}$ and $2\left|r_{i}-r\right| \geq r_{i}$ in this case gives

\left|\frac{r_{i}}{r}\right|^{\frac{1}{2}} \widetilde{H}\left(\frac{t}{(1-\eta) r r_{i}}\right) \leq \frac{r_{i}}{\sqrt{\pi}}\left(\frac{1-\eta}{t}\right)^{\frac{1}{2}} \leq C_{\eta, \alpha} \cdot e^{\frac{\eta(1-\eta)}{4 t}\left(r-r_{i}\right)^{2}}

Substituting this into (2.19), and noting the fact that, when $\eta$ runs over $] 0,1\left[,(1-\eta)^{2}\right.$ also runs over $] 0,1[$, gives exactly (2.16) in this case.

And when $2 r>r_{i},(2.16)$ follows by simply bounding $\widetilde{H}$ by 1 in (2.19).
To prove (2.17), notice that $\omega_{i}^{\theta}>0$ and $\omega^{\theta}=\sum_{i=1}^{n} \omega_{i}^{\theta}$, we have

On the other hand, the initial condition $\omega_{i}^{\theta} \rightharpoonup \alpha_{i} \delta_{x_{i}}$ as $t \rightarrow 0$ implies

Combining the above two sides, clearly there must hold

ii) For any $0<t<T$, we first write (2.15) in the integral form as

Lemma 2.3. For any $1 \leq p \leq q \leq \infty$, and $f(r, z) \in L^{p}(\Omega)$, there holds

Using (2.21) and (2.22), together with the bounds (2.3) and (2.5), as well as the fact that $\omega_{i}^{\theta} \leq \omega^{\theta}$ point-wisely, we achieve

\end{aligned} \omega_{i}^{\theta}(t / 2) \|_{L^{1}(\Omega)}+\int_{\frac{t}{2}}^{t} \frac{C}{(t-s)^{1 / 2}}\left(\|\nabla u(s)\|_{L^{\infty}(\Omega)}\left\|\omega_{i}^{\theta}(s)\right\|_{L^{\infty}(\Omega)}\right)
$$

Multiplying both sides by $t^{3 / 2}$, we get

Noting that $u=B S\left[\omega^{\theta}\right]$, we can use Proposition 2.3 of [9] to obtain

2.2. Self-similar variables. In view of (2.16), we know that $\omega_{j}^{\theta}$ concentrates in a self-similar way around $x_{j}$ for short time. Thus it is very natural to introduce the self-similar variables:

In the new coordinates $\left(R_{j}, Z_{j}\right)$, the domain constraint $r>0$ translates into $r_{j}+\sqrt{t} R_{j}>0$, which means that the rescaled vorticity $f_{j}\left(t, R_{j}, Z_{j}\right)$ is defined in the time-dependent domain

Noting that $u_{j}=B S\left[\omega_{j}^{\theta}\right]$, thus $U_{j}$ can also be determined by $f_{j}$. Recalling the subsection 4.2 of [10], we have the following explicit representation

U_{j}^{r}\left(X_{j}\right)= & \frac{1}{2 \pi} \int_{\Omega_{\epsilon_{j}}} \sqrt{\left(1+\epsilon_{j} R^{\prime}\right)\left(1+\epsilon_{j} R_{j}\right)^{-1}} F_{1}\left(\xi_{j}^{2}\right) \frac{Z_{j}-Z^{\prime}}{\left|X_{j}-X^{\prime}\right|^{2}} f_{j}\left(X^{\prime}\right) d X^{\prime} \\
U_{j}^{z}\left(X_{j}\right)= & -\frac{1}{2 \pi} \int_{\Omega_{\epsilon_{j}}} \sqrt{\left(1+\epsilon_{j} R^{\prime}\right)\left(1+\epsilon_{j} R_{j}\right)^{-1}} F_{1}\left(\xi_{j}^{2}\right) \frac{R_{j}-R^{\prime}}{\left|X_{j}-X^{\prime}\right|^{2}} f_{j}\left(X^{\prime}\right) d X^{\prime}  \tag{2.27}\\
& +\frac{\epsilon_{j}}{4 \pi} \int_{\Omega_{\epsilon_{j}}} \sqrt{\left(1+\epsilon_{j} R^{\prime}\right)\left(1+\epsilon_{j} R_{j}\right)^{-3}}\left(F_{1}\left(\xi_{j}^{2}\right)+F_{2}\left(\xi_{j}^{2}\right)\right) f_{j}\left(X^{\prime}\right) d X^{\prime}
\end{align*}
$$

where $F_{1}, F_{2}$ is some kernel satisfying $s^{\sigma_{1}} F_{1}(s), s^{\sigma_{2}} F_{2}(s)$ are bounded on $] 0, \infty[$ whenever $0 \leq \sigma_{1} \leq 3 / 2,0<\sigma_{2} \leq 3 / 2$, and $\xi_{j}^{2}$ is a shorthand notation for the quantity

\xi_{j}^{2}=\epsilon_{j}^{2}\left|X_{j}-X^{\prime}\right|^{2}\left(1+\epsilon_{j} R_{j}\right)^{-1}\left(1+\epsilon_{j} R^{\prime}\right)^{-1}

We denote this map from $f_{j}$ to $U_{j}$ by $U_{j}=B S^{\epsilon}\left[f_{j}\right]$. We use the superscript $\epsilon_{j}$ since in the new variables, the map depends explicitly on time through the parameter $\epsilon_{j}$.

In the rest of this paper, the following notations will also be used:

here although $R, Z, X, \epsilon$ indeed depend on $i$, we omit the index $i$ for notation simplification.
After this blow-up procedure, the gaussian bound on $\omega_{i}$ given by (2.16) translates into

We can use the estimate (2.29) to derive the point-wise estimate for $U_{i}^{\epsilon}$. First, recalling the proof of Proposition 2.3 in [9], which shows that for any $(r, z) \in \Omega$, there holds

Using the notation (2.26), let us also do this self-similar blow-up of the whole velocity $u$ near the point $x_{i} \in \Omega$ and near the initial time $t=0$, and we get

In view of (2.31), let $t \rightarrow 0$ and $R, Z$ fixed, all $U_{j}\left(t, R+\frac{r_{i}-r_{j}}{\sqrt{t}}, Z+\frac{z_{i}-z_{j}}{\sqrt{t}}\right)$ for $j \neq i$ vanish, and only $U_{i}(t, R, Z)$ remains. Thus after this blow-up procedure, the convection term can be very close to $U_{i} \cdot \nabla f_{i}$, for a short time. Combining with the fact that the initial measure for
$\omega_{i}=\omega_{i}^{\theta} e_{\theta}$ is $\alpha_{i} \delta_{x_{i}}$, hence if we believe in uniqueness, it is reasonable to expect that, for a short time, $\omega_{i}$ will be very close to an Oseen vortex located at $x_{i}$ with circulation $\alpha_{i}$.

In order to write this observation precisely, let us denote the following functions on $\mathbb{R}^{2}$ :

and denote by $\mathcal{X}$ the weighted space $L^{2}\left(\mathbb{R}^{2}, w(x, y) d x d y\right)$. We have:
Proposition 2.1. For any $i \in\{1, \cdots, n\}$, we have $\left\|\bar{f}_{i}(t, \cdot)-G(\cdot)\right\|_{\mathcal{X}} \rightarrow 0$ as $t$ goes to 0 , where $\bar{f}_{i}$ denotes the extension of $f_{i}$ by zero outside $\Omega_{\epsilon}$.
Proof. First, let us denote by $\mathcal{X}_{0}$ a subspace of $\mathcal{X}$, which is defined by the stronger norm

Lemma 2.1 (Lemma 4.4 in [10]). The space $\mathcal{X}_{0}$ is compactly embedded in $\mathcal{X}$, and the unit ball in $\mathcal{X}_{0}$ is closed for the topology induced by $\mathcal{X}$.
In the self-similar variables, the gradient bound for $\omega_{i}^{\theta}$, namely (2.18), translates into

Combining this with the gaussian bound for $f_{i},(2.29)$, we know that, $\left(\bar{f}_{i}(t)\right)_{0<t<T}$ is a bounded subset of $\mathcal{X}_{0}$, hence compact in $\mathcal{X}$. Let $h_{*}$ be an accumulation point in $\mathcal{X}$ of $\left(\bar{f}_{i}(t)\right)_{0<t<T}$ as $t$ goes to 0 , and $\left(t_{m}\right)_{m \in \mathbb{N}}$ be the corresponding sequence of positive time satisfying

Now, let us temporarily consider the whole 3-D vorticity field $\omega$ and the whole 3-D velocity field $u$. For any $m \in \mathbb{N}, y \in \mathbb{R}^{3}$, and $\left.s \in\right] 0, t_{m}^{-1} T$ [, we define the following sequence

where $x_{i}=\left(r_{i}, 0, z_{i}\right) \in \mathbb{R}^{3}$. In other words, the vector fields $\omega^{(m)}, u^{(m)}$ are defined by a self-similar blow-up of the original quantities $\omega, u$ near the point $x_{i} \in \mathbb{R}^{3}$ and near the initial time $t=0$. It is easy to verify that $\omega, u$ satisfy the 3-D vorticity equation:

for $s \in] 0, t_{m}^{-1} T\left[, y \in \mathbb{R}^{3}\right.$. The self-similar rescaling from $u$ to $u^{(m)}$ preserves the bounds given by (2.3), precisely for all indices $k, \ell \in \mathbb{N}$, we have the following a priori estimates

$$

which holds uniformly in $m$. Hence, up to an extraction, we can assume that

\omega^{(m)} \rightarrow \bar{\omega}, \quad u^{(m)} \rightarrow \bar{u}, \quad \text { as } \quad m \rightarrow \infty,
$$

with uniform convergence of both vector fields along with all their derivatives on any compact subset of $] 0, t_{m}^{-1} T\left[\times \mathbb{R}^{3}\right.$. Thus the limiting fields $\bar{\omega}, \bar{u}$ are smooth and satisfy

The goal now is to relate $\bar{\omega}$ to $\omega_{i}$ and $\bar{f}_{i}$. The idea is that the other $\omega_{j}, \bar{f}_{j}(j \neq i)$ should be eliminated by the blow-up procedure. Using the definitions, we get

& \quad=t_{m} \omega\left(t_{m} s, \sqrt{\left(r_{i}+\sqrt{t_{m}} y_{1}\right)^{2}+t_{m} y_{2}^{2}}, 0, z_{i}+\sqrt{t_{m}} y_{3}\right)  \tag{2.35}\\
& \quad=\left(\frac{\alpha_{i}}{s} \bar{f}_{i}\left(t_{m} s, X_{i i}^{(m)}(s, y)\right)+\sum_{j \neq i} \frac{\alpha_{j}}{s} \bar{f}_{j}\left(t_{m} s, X_{i j}^{(m)}(s, y)\right)\right) e_{\theta}\left(x_{i}+\sqrt{t_{m}} y\right),
\end{align*}
$$

where

$$
X_{i j}^{(m)}(s, y) \stackrel{\text { def }}{=}\left(\frac{\sqrt{\left(r_{i}+\sqrt{t_{m}} y_{1}\right)^{2}+t_{m} y_{2}^{2}}-r_{j}}{\sqrt{t_{m} s}}, \frac{z_{i}-z_{j}+\sqrt{t_{m}} y_{3}}{\sqrt{t_{m} s}}\right) .
$$

If $i \neq j$, for any bounded subset $B \subset \mathbb{R}^{3}$ and any $y \in B$, there exists a large constant $N_{B}$, such that for any $m>N_{B}$, there holds

\left|X_{i j}^{(m)}(s, y)\right|^{2} \geq \frac{\left(r_{i}-r_{j}\right)^{2}+\left(z_{i}-z_{j}\right)^{2}}{2 t_{m} s} .

Then the gaussian bound for $f_{j}(2.29)$ entails

Hence, the only contribution in the limit procedure $m \rightarrow \infty$ comes, as expected, from the $i$-th circular vortex. Regarding $\bar{f}_{i}$, as shown before, $\bar{f}_{i}(\cdot, \cdot, t)$ is bounded in $\mathcal{X}_{0}$. Thus for any fixed $s>0$, up to another extraction, there must exist some $h_{s} \in \mathcal{X}$ such that

The boundedness of $\left(\bar{f}_{i}\left(t_{m} s\right)\right)_{m}$ in $\mathcal{X}_{0}$ implies that, this convergence of $\left(\bar{f}_{i}\left(t_{m} s\right)\right)_{m}$ to $h_{s}$ also holds uniformly on any compact set of $\mathbb{R}^{3}$. Therefore, taking the limit $m \rightarrow \infty$ on both sides of (2.35) and noting that $e_{\theta}\left(x_{i}\right)=e_{2}=(0,1,0)$, we obtain

Taking the limit $m \rightarrow \infty$ in (2.29) and (2.30), we deduce

In view of (2.31), as $t_{m} \rightarrow 0$, all $U_{j}^{\epsilon}\left(t_{m} s, X_{i j}^{(m)}(s, y)\right)$ for $j \neq i$ vanish, and only $U_{i}^{\epsilon}\left(t_{m} s, X_{i i}^{(m)}(s, y)\right)$ remains. Regarding $U_{i}$, using (2.31) again and taking the limit $m \rightarrow \infty$, we get

where $\left(\bar{u}_{1}, \bar{u}_{3}\right)$ is the two dimensional velocity field obtained from the scalar vorticity $\bar{\omega}_{2}$ via the Biot-Savart law in $\mathbb{R}^{2}$.

Summarizing, we have shown that the limiting vorticity $\bar{\omega}_{2}$, together with the associated velocity $\left(\bar{u}_{1}, \bar{u}_{3}\right)$ solves the 2-D Navier-Stokes equations, and it follows from (2.37) that $\bar{\omega}_{2}(s, \cdot)$ is uniformly bounded in $L^{1}\left(\mathbb{R}^{2}\right)$ and converges weakly to the Dirac measure $\alpha_{i} \delta_{0}$ as $s \rightarrow 0$. Then we deduce, by using Proposition 1.3 in [11], that $\bar{\omega}_{2}\left(s, y_{1}, y_{3}\right)=\frac{\alpha_{i}}{s} G\left(\frac{y_{1}}{\sqrt{s}}, \frac{y_{3}}{\sqrt{s}}\right)$, i.e. $h_{s}=G$ for any $s>0$. In particular, choosing $s=1$ so that $t_{m} s=t_{m}$, and comparing (2.33) with (2.36), we conclude that $h_{*}=G$, which is the desired result.

In view of Proposition 2.1, it is natural to make a further decomposition of $\omega$. Let

Remark 2.1. For any $j \in\{1, \cdots, n\}$, due to the cutoff function $\chi$, it is easy to see that $f_{0}\left(t, R_{j}, Z_{j}\right)$ vanishes when $\sqrt{t} R<-d / 4$, and thus vanishes when $\sqrt{t} R<-r_{j} / 4$. In particular, this implies that $f_{0}\left(t, R_{j}, Z_{j}\right)$ satisfies the Dirichlet boundary condition on $\partial \Omega_{\epsilon_{j}}$, and thus $\widetilde{f}_{j}\left(t, R_{j}, Z_{j}\right)$ also satisfies the Dirichlet boundary condition on $\partial \Omega_{\epsilon_{j}}$.

It is clear that $f_{0}(t) \in \mathcal{X}$ for all $\left.t \in\right] 0, T\left[\right.$, and $\left\|f_{0}(t)-G\right\|_{\mathcal{X}} \rightarrow 0$ as $t \rightarrow 0$. Thus the perturbation $\widetilde{f}_{j}(t)$ (extended by zero outside $\Omega_{\epsilon_{j}}$ ) belongs to $\mathcal{X}$ for all $\left.t \in\right] 0, T[$, and Proposition 2.1 implies that $\left\|\widetilde{f}_{j}(t)\right\|_{\mathcal{X}} \rightarrow 0$ as $t \rightarrow 0$. In the next section, we shall give a more accurate quantitative rate of this convergence.

## 3. Proof of Theorem 1.1

This section is devoted to the proof of Theorem 1.1. In view of the decomposition (2.41), to prove the uniqueness claim in Theorem 1.1, we only need to show the perturbation part $\left(\widetilde{f}_{j}\right)_{j=1}^{n}$ is uniquely determined. At the end of last section, we have shown that $\left\|\widetilde{f}_{j}(t)\right\|_{\mathcal{X}} \rightarrow 0$ as $t \rightarrow 0$, but this is not enough to prove uniqueness. We shall give a more accurate quantitative rate of this convergence, which in particular implies the short time estimate (1.4). This will be done in the first subsection.

After some modifications to the energy estimates in the proof of the short time estimate, we can prove the uniqueness claim in Theorem 1.1.This will be done in the second subsection.
3.1. Short time asymptotics. Using (2.15) and (2.26), we can derive the evolution equation satisfied by the rescaled vorticity $f_{i}$ reads

And we shall define, following [10], the two types of energy for each vortex

\end{gather*}

as well as the total energies

As we have pointed out in Remark 2.1 that, $\widetilde{f}_{j}$ satisfies the homogeneous Dirichlet condition on $\partial \Omega_{\epsilon_{j}}$, thus although the integral in (3.3) is taken over the time-dependent domain $\Omega_{\epsilon_{j}}$, there is no contribution from the boundary when we differentiate with respect to time. Hence we can get, by doing $L^{2}\left(\Omega_{\epsilon}, w(X) d X\right)$ energy estimate to (3.2) and integrating by parts, that

& \left.\quad-\alpha_{i} \operatorname{div}_{*}\left(U_{0, i} \widetilde{f}_{i}+\widetilde{U}_{i} f_{0}+\widetilde{U}_{i} \widetilde{f}_{i}\right)(t, X)\right) \widetilde{f}_{i}(t, X) \cdot w(X) d X \\
I_{i}(t)= & \int_{\Omega_{\epsilon}} W_{i}(t, X) f_{i}(t, X)\left(\nabla_{X} \widetilde{f}_{i}(t, X)+\frac{X}{2} \widetilde{f}_{i}(t, X)\right) \cdot w(X) d X
\end{aligned}
$$

The main result of this subsection states as follows:
Proposition 3.1. There exists some positive constant $\delta$ depending on the initial measure $\mu$, such that for $t$ sufficiently small, there holds

Proof. Noting that the terms in $A_{i}(t)$ are exactly the same as the ones appearing on the right-hand side of the equality (4.42) in [10]. Thus using the Proposition 4.5 in [10], we know that there exists some $\left.\epsilon_{0} \in\right] 0,1 / 2\left[\right.$, if $t>0$ is small enough so that $\epsilon_{i}<\epsilon_{0}$, then

Due to the cutoff function $\chi$, we know that $f_{0}(t, X)$ vanishes whenever $|X|>\frac{d}{4 \sqrt{t}}$. Thus $I_{i, 1}(t)$ actually only integrates on $\Omega_{\epsilon}^{-}$, and for $X$ in $\Omega_{\epsilon}^{-}$, we have

& \leq C_{0} \sqrt{t} \mathcal{E}_{i}(t)^{\frac{1}{2}}
\end{align*}
$$

Type 2: $I_{i, 2}(t)=\sum_{j \neq i} \int_{\Omega_{\epsilon}} \alpha_{j} U_{j}\left(t, X_{j}\right) \widetilde{f}_{i}(t, X) \cdot\left(\nabla_{X}+X / 2\right) \tilde{f}_{i}(t, X) \cdot w(X) d X$.
We decompose $I_{i, 2}$ into two different parts according to the integra domain. On $\Omega_{\epsilon}^{-}$, by using the bound (3.7) and Cauchy inequality again, we obtain

& \leq C_{0} e^{-\frac{d^{2}}{256 t}} \mathcal{E}_{i}(t)^{\frac{1}{2}}
\end{aligned}

Combining this with the estimate (3.9), we finally get

Recalling that $E(t)$ goes to 0 as $t$ goes to 0 yields the simplified bound

Recalling that by definition $\epsilon_{i}=\sqrt{t} / r_{i}$ and $E(t)$ goes to 0 as $t$ goes to 0 , thus there exists some small constant $t_{0}$ depending only on the initial measure $\mu$, such that both $\epsilon_{i}<\epsilon_{0}$ and $E_{i}(t)^{1 / 2}<\delta / 2$ hold whenever $t<t_{0}$. Combining this with the facts that $E_{i} \leq \mathcal{E}_{i}$ and $0<\mathcal{R}_{i}(t) \leq e^{-C_{0} / t}$, we can get from (3.13), for $t<t_{0}$, that

3.2. Uniqueness. The purpose of this final subsection is to prove the uniqueness result in Theorem 1.1. Assume that $\omega^{\theta,(1)}, \omega^{\theta,(2)} \in \mathcal{C}(] 0, T\left[, L^{1}(\Omega) \cap L^{\infty}(\Omega)\right)$ are two mild solutions to the vorticity equation (1.2) satisfying (1.3). Introducing the self-similar variables and decompose these two solutions just as what we have done in Subsection 2.2, precisely for $\ell=1,2$, we write

In view of $(3.14)$, combining with the elementary fact that $E_{j}^{\Delta} \leq 2\left(E_{j}^{(1)}+E_{j}^{(2)}\right)$, we know that $E_{j}^{\Delta}(t)$ also decays to 0 with rate at least $t|\ln t|^{2}$ as $t \rightarrow 0$. We believe that $E_{j}^{\Delta}(t)$ decays faster than $E_{j}^{(\ell)}$ since the source $\mathcal{H}$ and $\operatorname{div}_{*}\left(W_{0, i} f_{0}\right)$ has disappeared when taking the difference of the equations for $f_{i}^{(1)}$ and $f_{i}^{(2)}$. Precisely, we have:

We mention that the terms with type $C_{0} \sqrt{t}|\ln t| \mathcal{E}_{i}(t)^{\frac{1}{2}}$ in (3.6) does not appear here, due to the cancellation of the source term $\mathcal{H}$ when taking the difference.

For the interaction part $I_{i}^{\Delta}(t)$, thanks to the cancellation of $\operatorname{div}_{*}\left(W_{0, i} f_{0}\right)$, there are only three types of integral terms, which we handle separately in the following.

& \leq C_{0}\left\|w^{-1 / 2}\right\|_{L^{4}\left(\Omega_{e_{j}}^{+}\right)}\left\|\left(\widetilde{f}_{j}^{(1)}-\widetilde{f}_{j}^{(2)}\right) w^{1 / 2}\right\|_{L^{2}\left(\Omega_{\epsilon_{j}}^{+}\right)} \\
& \leq C_{0} e^{-C_{0} / t} E_{j}^{\Delta}(t)^{\frac{1}{2}} .
\end{aligned}
$$

Using this estimate and Hölder's inequality again, we achieve

$$
\begin{align*}
& \int_{\Omega_{\epsilon}^{-}} \sum_{j \neq i}\left|\alpha_{j}\left(\widetilde{U}_{j}^{(1),+}-\widetilde{U}_{j}^{(2),+}\right)\left(t, X_{j}\right) \cdot\left(\nabla_{X}+X / 2\right) \widetilde{f}_{i}^{\Delta}(t, X)\right| d X \\
& \left.\quad \leq \sum_{j \neq i}\left\|\widetilde{U}_{j}^{(1),+}-\widetilde{U}_{j}^{(2),+}\right\|_{L^{4}\left(\Omega_{\epsilon}^{-}\right.}\right)\left\|w^{-1 / 2}\right\|_{L^{4}\left(\Omega_{\epsilon}^{-}\right)}\left\|\left(\nabla_{X}+X / 2\right) \widetilde{f}_{i}^{\Delta} \cdot w^{1 / 2}\right\|_{L^{2}\left(\Omega_{\epsilon}^{-}\right)}  \tag{3.28}\\
& \quad \leq C_{0} e^{-C_{0} / t} E^{\Delta}(t)^{\frac{1}{2}} \mathcal{E}_{i}^{\Delta}(t)^{\frac{1}{2}} .
\end{align*}
$$

Combining the estimates (3.27) and (3.28), we finally achieve that

$$
\begin{equation*}
\left|I_{i, 2}^{\Delta}(t)\right| \leq C_{0} \sqrt{t} E^{\Delta}(t)^{\frac{1}{2}} \mathcal{E}_{i}^{\Delta}(t)^{\frac{1}{2}} . \tag{3.29}
\end{equation*}
$$

Type 3: $I_{i, 3}^{\Delta}(t)=\int_{\Omega_{\epsilon}}\left(\widetilde{W}_{i}^{(1)} \widetilde{f}_{i}^{(1)}-\widetilde{W}_{i}^{(2)} \widetilde{f}_{i}^{(2)}\right)(t, X) \cdot\left(\nabla_{X}+X / 2\right) \widetilde{f}_{i}^{\Delta}(t, X) \cdot w(X) d X$.
The strategy of estimating $I_{i, 3}^{\Delta}(t)$ is to write

$$
\widetilde{W}_{i}^{(1)} \widetilde{f}_{i}^{(1)}-\widetilde{W}_{i}^{(2)} \widetilde{f}_{i}^{(2)}=\widetilde{W}_{i}^{\Delta} \widetilde{f}_{i}^{(1)}+\widetilde{W}_{i}^{(2)} \widetilde{f}_{i}^{\Delta},
$$

where $\widetilde{W}_{i}^{\Delta} \stackrel{\text { def }}{=} \widetilde{W}_{i}^{(1)}-\widetilde{W}_{i}^{(2)}$. Then we get, by using Hölder's inequality, that

$$
\begin{gather*}
\left|I_{i, 3}^{\Delta}(t)\right| \leq\left(\left\|\widetilde{W}_{i}^{\Delta}\right\|_{L^{\infty}\left(\Omega_{\epsilon}\right)}\left\|\widetilde{f}_{i}^{(1)} w^{\frac{1}{2}}\right\|_{L^{2}\left(\Omega_{\epsilon}\right)}+\left\|\widetilde{W}_{i}^{(2)}\right\|_{L^{\infty}\left(\Omega_{\epsilon}\right)}\left\|\widetilde{f}_{i}^{\Delta} w^{\frac{1}{2}}\right\|_{L^{2}\left(\Omega_{\epsilon}\right)}\right) \\
\times\left(\left\|\widetilde{W}_{i}^{\Delta}\right\|_{L^{\infty}\left(\Omega_{\epsilon}\right)} E_{i}^{(1)}(t)^{\frac{1}{2}}+\left\|\widetilde{W}_{i}^{(2)}\right\|_{L^{\infty}\left(\Omega_{\epsilon}\right)} E_{i}^{\Delta}(t)^{\frac{1}{2}}\right) \mathcal{E}_{i}^{\Delta}(t)^{\frac{1}{2}} \tag{3.30}
\end{gather*}
$$

By using (3.22) with $p=4 / 3, q=4$, and Gagliardo-Nirenberg inequality, we obtain

$$
\begin{aligned}
\left\|\widetilde{W}_{i}^{\Delta}\right\|_{L^{\infty}\left(\Omega_{\epsilon}\right)} & \leq C_{0} \sum_{j \neq i}\left\|\widetilde{f}_{j}^{\Delta}\right\|_{L^{4 / 3}\left(\Omega_{\epsilon}\right)}^{1 / 2}\left\|\widetilde{f}_{j}^{\Delta}\right\|_{L^{4}\left(\Omega_{\epsilon}\right)}^{1 / 2} \\
& \leq C_{0} \sum_{j \neq i}\left\|\widetilde{f}_{j}^{\Delta} w^{1 / 2}\right\|_{L^{2}\left(\Omega_{\epsilon}\right)}^{1 / 2}\left\|w^{-1 / 2}\right\|_{L^{2}\left(\Omega_{\epsilon}\right)}^{1 / 2}\left\|\widetilde{f}_{j}^{\Delta}\right\|_{L^{2}\left(\Omega_{\epsilon}\right)}^{1 / 4}\left\|\nabla \widetilde{f}_{j}^{\Delta}\right\|_{L^{2}\left(\Omega_{\epsilon}\right)}^{1 / 4} \\
& \leq C_{0} \sum_{j \neq i} E_{j}^{\Delta}(t)^{\frac{3}{8}} \mathcal{E}_{j}^{\Delta}(t)^{\frac{1}{8}}
\end{aligned}
$$

Similarly, and noting that $\widetilde{f}_{j}^{(2)}$ satisfies the point-wise estimate (3.24), we obtain

$$
\begin{aligned}
\left\|\widetilde{W}_{i}^{(2)}\right\|_{L^{\infty}\left(\Omega_{\epsilon}\right)} & \leq C_{0} \sum_{j \neq i}\left\|\widetilde{f}_{j}^{(2)}\right\|_{L^{4 / 3}\left(\Omega_{\epsilon}\right)}^{1 / 2}\left\|\widetilde{f}_{j}^{(2)}\right\|_{L^{4}\left(\Omega_{\epsilon}\right)}^{1 / 2} \\
& \leq C_{0} \sum_{j \neq i} E_{j}^{(2)}(t)^{\frac{1}{4}}
\end{aligned}
$$

Substituting the above two estimates into (3.30), we achieve

$$
\begin{equation*}
\left|I_{i, 3}^{\Delta}(t)\right| \leq C_{0}\left(E_{i}^{(1)}(t)^{\frac{1}{2}} E^{\Delta}(t)^{\frac{3}{8}} \mathcal{E}^{\Delta}(t)^{\frac{1}{8}}+E^{(2)}(t)^{\frac{1}{4}} E_{i}^{\Delta}(t)^{\frac{1}{2}}\right) \mathcal{E}_{i}^{\Delta}(t)^{\frac{1}{2}} . \tag{3.31}
\end{equation*}
$$

Overall, by putting (3.25), (3.29) and (3.31) together, using Young's inequality and the fact that $E_{i}^{\Delta} \leq \mathcal{E}_{i}^{\Delta} \leq \mathcal{E}^{\Delta}$, we achieve

$$
\begin{equation*}
I^{\Delta}(t) \leq \delta \mathcal{E}_{i}^{\Delta}(t)+C_{0}\left(\sqrt{t}+E_{i}^{(1)}(t)^{\frac{1}{2}}+E^{(2)}(t)^{\frac{1}{4}}\right) \mathcal{E}^{\Delta}(t)+C_{0} e^{-C_{0} / t} \tag{3.32}
\end{equation*}
$$

Then substituting (3.19) and (3.32) into (3.18), and summing up over $i$, leads to

$$
\begin{equation*}
t \frac{d}{d t} E^{\Delta}(t) \leq-\delta \mathcal{E}^{\Delta}(t)+C_{0}\left(\sqrt{t}+E^{(1)}(t)^{\frac{1}{2}}+E^{(2)}(t)^{\frac{1}{2}}+E^{(2)}(t)^{\frac{1}{4}}\right) \mathcal{E}^{\Delta}(t)+C_{0} e^{-C_{0} / t} \tag{3.33}
\end{equation*}
$$

The bound (3.14) guarantees the existence of a positive time $t_{1}$, such that for all $0<t<t_{1}$, there holds $C_{0}\left(\sqrt{t}+E^{(1)}(t)^{\frac{1}{2}}+E^{(2)}(t)^{\frac{1}{2}}+E^{(2)}(t)^{\frac{1}{4}}\right) \leq \frac{\delta}{2}$. Then (3.33) turns into

$$
\begin{equation*}
t \frac{d}{d t} E^{\Delta}(t) \leq-\frac{\delta}{2} \mathcal{E}^{\Delta}(t)+C_{0} e^{-C_{0} / t} \leq-\frac{\delta}{2} E^{\Delta}(t)+C_{0} e^{-C_{0} / t} \tag{3.34}
\end{equation*}
$$

Then integrating this differential inequality from 0 to $t<t_{1}$ gives

$$
E^{\Delta}(t) \leq C_{0} t^{-\delta / 2} \int_{0}^{t} s^{\delta / 2-1} e^{-C_{0} / s} d s \leq e^{-C_{0} / t}
$$

which is exactly the desired estimate (3.17).
Proposition 3.2 already shows that $E^{\Delta}(t)$ converges extremely rapidly to 0 as $t \rightarrow 0$, but our actual goal is to prove that $E^{\Delta}(t)$ vanishes identically, which will be done in the following.

Proof of the uniqueness result in Theorem 1.1. The key is to get a new differential inequality for $E^{\Delta}(t)$ like (3.34), but in which the "inhomogeneous" term like $C_{0} e^{-C_{0} / t}$ does not appear.

First, the estimate (4.73) of [10] claims that as long as $\epsilon<1 / 2$, there holds

$$
\begin{equation*}
A_{i}^{\Delta}(t) \leq-\delta \mathcal{E}_{i}^{\Delta}(t)+C_{0} E_{i}^{\Delta}(t)+C_{0}\left(E_{i}^{(1)}(t)^{\frac{1}{2}}+E_{i}^{(2)}(t)^{\frac{1}{2}}\right) \mathcal{E}_{i}^{\Delta}(t) \tag{3.35}
\end{equation*}
$$

For the estimate of $I_{i}^{\Delta}(t)$, we only need to modify the estimate of $I_{i, 1}^{\Delta}(t)$. By simply using the bound for $U_{i}$ given by (2.31), we can achieve

$$
\left|I_{i, 1}^{\Delta}(t)\right| \leq C_{0} E_{i}^{\Delta}(t)^{\frac{1}{2}} \mathcal{E}_{i}^{\Delta}(t)^{\frac{1}{2}}
$$

The other terms in $I_{i}^{\Delta}(t)$ can be estimated exactly along the proof of Proposition 3.2. Then for small $t$, we deduce

$$
\begin{align*}
\left|I_{i}^{\Delta}(t)\right| & \leq C_{0} E^{\Delta}(t)^{\frac{1}{2}} \mathcal{E}^{\Delta}(t)^{\frac{1}{2}}+C_{0}\left(E_{i}^{(1)}(t)^{\frac{1}{2}}+E^{(2)}(t)^{\frac{1}{4}}\right) \mathcal{E}^{\Delta}(t) \\
& \leq \frac{\delta}{2 n} \mathcal{E}^{\Delta}(t)+C_{0} E^{\Delta}(t)+C_{0}\left(E_{i}^{(1)}(t)^{\frac{1}{2}}+E^{(2)}(t)^{\frac{1}{4}}\right) \mathcal{E}^{\Delta}(t) \tag{3.36}
\end{align*}
$$

Substituting (3.35) and (3.36) into (3.18), and summing up over $i$, leads to

$$
\begin{equation*}
t \frac{d}{d t} E^{\Delta}(t) \leq-\frac{\delta}{2} \mathcal{E}^{\Delta}(t)+C_{0} E^{\Delta}(t)+C_{0}\left(E^{(1)}(t)^{\frac{1}{2}}+E^{(2)}(t)^{\frac{1}{2}}+E^{(2)}(t)^{\frac{1}{4}}\right) \mathcal{E}^{\Delta}(t) \tag{3.37}
\end{equation*}
$$

The bound (3.14) guarantees the existence of a positive time $t_{2}$, such that for all $0<t<t_{2}$, there holds $C_{0}\left(\sqrt{t}+E^{(1)}(t)^{\frac{1}{2}}+E^{(2)}(t)^{\frac{1}{2}}+E^{(2)}(t)^{\frac{1}{4}}\right) \leq \frac{\delta}{2}$. Then (3.37) turns into

$$
t \frac{d}{d t} E^{\Delta}(t) \leq C_{0} E^{\Delta}(t)
$$

hence

$$
\begin{equation*}
E^{\Delta}(t) \leq\left(\frac{t}{t^{\prime}}\right)^{C_{0}} E^{\Delta}\left(t^{\prime}\right), \quad \forall 0<t^{\prime}<t \tag{3.38}
\end{equation*}
$$

In view of (3.17), the right-hand side of (3.38) converges to 0 as $t^{\prime} \rightarrow 0$. Thus $E^{\Delta}(t)=0$, which means that $f^{(1)}(t)=f^{(2)}(t)$ for all $0<t<\min \left(t_{1}, t_{2}\right)$. Returning to the original variables, we conclude that $\omega^{\theta,(1)}(t)=\omega^{\theta,(2)}(t)$ for all $0<t<\min \left(t_{1}, t_{2}\right)$. Then the desired uniqueness follows from the global well-posedness result established in Theorem 1.1 of [9], and the whole theorem has been proved.
