# Hydrodynamic Limit for an Anharmonic Chain under Boundary Tension

#### Abstract

We study the hydrodynamic limit for a one dimensional isothermal anharmonic finite chain in Lagrangian coordinates with hyperbolic space-time scaling. The temperature is kept constant by putting the chain in contact with a heat bath, realised via a stochastic momentum-preserving noise added to the dynamics. The noise is designed to be large at the microscopic level, but vanishing in the macroscopic scale. Boundary conditions are also considered: one end of the chain is kept fixed, while a time-variable tension is applied to the other end. We show that the microscopic deformation and momentum converge (in an appropriate sense) to a weak solution of a system of hyperbolic conservation laws (isothermal Euler equations in Lagrangian coordinates) with boundary conditions. This result include the shock regime of the system. This is done by adapting the theory of compensated compactness to a stochastic setting, as developed by J. Fritz in [6] for the same model without boundary conditions. Finally, changing the external tension allows us to define thermodynamic transformations between equilibrium states. We use this to deduce the first and the second principle of Thermodynamics for our model.


## 1 Introduction

Hydrodynamic limits concern the deduction of macroscopic conservation laws from microscopic dynamics. Ideally the microscopic dynamics should be deterministic and Hamiltonian but most existing results are obtained using microscopic stochastic dynamics. Often the stochastic dynamics models the action of a heat bath thermalising a Hamiltonian dynamics.

For scalar hyperbolic conservation laws these Hydrodynamic limits are well understood, even in presence of shocks [11] and of boundary conditions [1]. Much less is known for hyperbolic systems of conservation laws and boundary conditions, which have been understood only in the smooth regime [4]. In presence of shock waves, in infinite volume, only the hydrodynamic limit for the Leroux system [7] and the p-system [6] have been obtained. Since uniqueness of entropy solutions is still an open problem for these systems, the result is intended here only in the sense that the limit distribution of the macroscopic profiles concentrates on the set of possible weak solutions.

This article is a first attempt to understand the hydrodynamic limit in presence of boundary conditions and shocks in p-systems. The presence of changing boundary conditions (in particular controlling the tension) is important in order to perform isothermal transformations and study the corresponding first and second law of thermodynamics.

The model is an anharmonic chain of $N+1$ particles with a time-dependent external force (tension) attached to one end of the chain (particle number $N$ ). The other end of the chain (particle number 0 ) is kept fixed.

The system is in contact with a thermal bath modelled by a stochastic dynamics chosen in such a way that:

1. The total dynamics is ergodic,
2. The temperature of the chain is fixed to the value $\beta^{-1}$, i.e. the equilibrium stationary probability are given by canonical Gibbs measure at this temperature.
3. The momentum and volume are locally conserved, while the energy is not.
4. The strength of the noise is scaled in such way that it does not appear in the macroscopic equations.
This is the same setup considered by Fritz [6] in infinite volume in order to obtain the p-system:

where $r(t, x)$ and $p(t, x)$ are the local volume strain and momentum of the chain, while $\tau(r)$, smooth and strictly increasing, is the equilibrium tension of the chain corresponding to the length $r$. Here $x$ is the Lagrangian material coordinate. For the finite system $x \in[0,1]$. The physical boundary conditions that we impose microscopically are

- $p(t, 0)=0, t \geq 0$ : the first particle is not moving,
- $\tau(r(t, 1))=\bar{\tau}(t)$, where $\bar{\tau}(t)$ is the force (tension) applied to the last particle $N$, eventually changing on the macroscopic time scale.

In the shock regime, when weak non-smooth solutions are considered, one has to specify the meaning of these boundary conditions, since a discontinuity can be found right at the boundaries. The standard way to address this (see eg [3]) is to consider the special viscous approximation

with the boundary conditions:

This system has a strong unique solution. Then the vanishing viscosity solutions of (1.1) are defined as the limit for $\delta=\left(\delta_{1}, \delta_{2}\right) \rightarrow 0$ for $r^{\delta}, p^{\delta}$. Notice that (1.2) has two extra boundary conditions that will create a boundary layer in the limit $\delta \rightarrow 0$. The particular choice of the viscosity terms and boundary conditions in (1.2) is done in such a way that we have the right thermodynamic entropy production. At the moment there is no uniqueness result for this vanishing viscosity limit, and in principle it may depend on the particular choice of the viscosity term.

The stochastic perturbation of our microscopic dynamics is chosen so that it gives a microscopic stochastic version of (1.2). We prove that the distribution of the empirical profiles of strain and momentum, tested against functions with compact support on $(0,1)$, concentrate on weak solutions of (1.1). Unfortunately we are not able to prove that these limit profiles are the vanishing viscosity solutions with the right boundary conditions, but we conjecture that our limit distributions are concentrated on such vanishing viscosity solutions.

Hydrodynamic limits in smooth regime have been well understood so far. The hydrodynamic limit for the 1D full $3 \times 3$ Euler system in Lagrangian coordinates and boundary conditions has been studied in [4], while the 3D $3 \times 3$ Euler system in Eulerian coordinates has been derived in [10]. Both [4] and [10] use the relative entropy method introduced in the diffusive setting by Yau [13].

The relative entropy method assumes the existence of strong solutions to the macroscopic equation. Then one samples these solutions and builds a family of time-dependent inhomogeneous Gibbs measure which are used for the relative entropy.

As an alternative to the relative entropy method, [6] adapts the techniques of the vanishing viscosity to a stochastic setting, in conjunction with the approach of Guo-Papanicolau-Varadhan [8] based on bounds on Dirichlet forms. We extend the work in [6] to our model by considering a finite chain and including boundary conditions, where the chain is attached to one point on one side and subject to a varying tension force on the other side. We construct some averages of the conserved quantities $\hat{\mathbf{u}}_{N}(t, x)$ which solve (in an appropriate sense) equations that approximate in a mesoscopic scale the p-system we want to derive as $N \rightarrow \infty$. Then we carefully perform the limit $N \rightarrow \infty$ and we obtain $L^{2}$ valued weak solutions to the p -system. The main technical challenge is then to prove that we can commute the weak limits with composition with nonlinear functions. This is done using a stochastic extension, introduced by Fritz in [6], of the Tartar-Murat theory of compensated compactness, properly adapted to the presence of the boundary conditions.

After proving the hydrodynamic limit, we exploit the external tension $\bar{\tau}(t)$ in order to perform a thermodynamic transformation between two equilibrium states. This is done by letting $\bar{\tau}(t)$ to change from a value $\tau_{0}$ at $t=0$ to a value $\tau_{1}$ as $t \rightarrow \infty$. Correspondingly, the system is brought from the equilibrium state $\left(\beta, \tau_{0}\right)$ to the state $\left(\beta, \tau_{1}\right)$. Since the temperature is fixed by the noise, this transformation is isothermal.

Isothermal transformations are of great importance in thermodynamics, as they constitute the Carnot cycle, together with adiabatic transformations. The study of the first and the second law of thermodynamics for an isothermal transformation in smooth regime has been carried out in [9], in a system where energy and momentum are not conserved and a diffusive scaling is performed. In that situation volume stretch evolves macroscopically accordingly to a nonlinear diffusive equation.

The first law of thermodynamics is an energy balance, which takes into account "gains" or "losses" of total internal energy via exchange of heat and work: one defines the internal energy $U$ and the work $W$ (which depends on the external tension only) and proves that the difference of internal energy between two equilibrium states is given by $W$ plus some extra terms, which we call heat and denote by $Q$. In formulae, $\Delta U=W+Q$. The heat depends on terms coming from the stochastic thermostats which survive in the limit $N \rightarrow \infty$. We prove the first law in exactly the same fashion as [9].

The second law states that, for an isothermal transformation, the difference of thermodynamic entropy $\Delta S$ is never smaller than $\beta Q$. The equality $\Delta S=\beta Q$ occurs only for quasistatic transformations. The entropy $S$ is defined by $S=\beta(U-F)$, where $F$ is the free energy. The second law can then be restated as $\Delta F \leq W$. This is also known as Clausius inequality. In [9], this inequality is obtained at the macroscopic level: the macroscopic equation is diffusive and the system dissipates even if the solutions are smooth. This is not the case in the present paper, as smooth solutions would always give a Clausius equality. The main assumption that we have to make in order to obtain Clausius inequality is that the distributions of the limit profiles concentrate on the vanishing viscosity solutions. We will refer to this solutions as entropy solutions, even though in literature this term is referred (in principle) to a more strict class of weak solutions.

## 2 The Model and the Main Theorem

We study a one-dimensional Hamiltonian system of $N+1 \in \mathbb{N}$ particles of unitary mass. The position of the $i$-th particle $(i \in\{0,1, \ldots, N\})$ is denoted by $q_{i} \in \mathbb{R}$ and its momentum by $p_{i} \in \mathbb{R}$. We assume that particle 0 is kept fixed, i.e. $\left(q_{0}, p_{0}\right) \equiv(0,0)$, while on particle $N$ is applied a time-dependent force $\bar{\tau}(t)$.

Denote by $\mathbf{q}=\left(q_{0}, \ldots, q_{N}\right)$ and $\mathbf{p}=\left(p_{0}, \ldots, p_{N}\right)$. The interaction between particles $i$ and $i-1$
is described by the potential energy $V\left(q_{i}-q_{i-1}\right)$ of an anharmonic spring.
We take $V$ of the form

where $\theta$ is a real number and $U$ is a smooth and convex mollification of the function $\kappa \max \{r, 0\} / 2-\kappa r^{2} / 2$, for some $\kappa \in(0,1 / 2)$.

In particular, $V$ is a strongly convex function that grows quadratically at infinity: there exist constants $c_{1}$ and $c_{2}$ such that for any $r \in \mathbb{R}$ :

Moreover, there are some positive constants $V_{+}^{\prime \prime}, V_{-}^{\prime \prime}, \alpha$ and $R$ such that

The energy is defined by the following Hamiltonian:

Since the interaction depends only on the distance between particles, we define

Consequently, the configuration of the system is given by $\left(\mathbf{r}=\left(r_{1}, \ldots, r_{N}\right), \mathbf{p}=\left(p_{0}, \ldots, p_{N}\right)\right)^{T}$ and the phase space is given by $\mathbb{R}^{2 N}$.

Given a smooth function $\bar{\tau}(t)$ that represents the force applied to particle $N$ at the macroscopic time $t$, the dynamics of the system is determined by the generator

Here the Liouville operator $L_{N}^{\tau}$ is given by

where we have used the fact that $p_{0} \equiv 0$. Note that the time scale in the tension is chosen such that it changes smoothly on the macroscopic scale.

The symmetric operators $S_{N}$ and $\tilde{S}_{N}$ are the generators of the stochastic part of the dynamics and are defined by

They conserve total mass and momentum but not energy. The temperature is fixed to the constant value $\beta^{-1}$, in the sense that the only stationary measures of the stochastic dynamics generated by $S_{N}+\tilde{S}_{N}$ are given by the corresponding canonical Gibbs measure at temperature $T=\beta^{-1}$, see definition below.

The positions and the momenta of the particles then evolve in time accordingly to the following system of stochastic equations

for $i \in\{2, \ldots, N-1\} .\left\{w_{i}\right\}_{i=0}^{\infty}$ and $\left\{\widetilde{w}_{i}\right\}_{i=0}^{\infty}$ are independent families of independent Brownian motions on a common probability space $(\Omega, \mathcal{F}, \mathbb{P})$. The expectation with respect to $\mathbb{P}$ is denoted by $\mathbb{E}$.

In (2.6) and (2.11) $\sigma(N)$ is a positive number that tunes the strength of the noise. We need it to be big enough to provide ergodicity but small enough to disappear in the hydrodynamic limit:

We denote by $\rho(\beta, \tau)$ and $\tau(\beta, \rho)$ the corresponding convex conjugate variables, that satisfy

We have the relations
that identify $\beta^{-1}$ as the temperature and $\tau$ as the tension.
For constant $\bar{\tau}$ in the dynamics, the family of product measures

is stationary for the dynamics. These are the canonical Gibbs measures at a temperature $\beta^{-1}$, pressure $\bar{\tau}$ and velocity 0 .

We need Gibbs measures with average velocity different from 0 and we use the following notation:

Observe that $S_{N}$ and $\tilde{S}_{N}$ are symmetric with respect to $\lambda_{\beta, \bar{p}, \tau}^{N}$ for any choice of $\bar{p}$ and $\tau$.
Since the noise does not conserve the energy, we are interested in the macroscopic behaviour of the elongation and momentum of the particles, at time $t$, as $N \rightarrow \infty$. Note that $t$ is already the macroscopic time, as we have already multiplied by $N$ in the generator. We shall use Lagrangian coordinates, that is our space variables will belong to the lattice $\{1 / N, \ldots,(N-1) / N, 1\}$.

Consequently, we set $\mathbf{u}_{i}:=\left(r_{i}, p_{i}\right)^{T}$ and, for a fixed macroscopic time $T$ define $Q_{T}=[0,1] \times[0, T]$. The we introduce the empirical measures on $Q_{T}$ representing the space-time distribution on the interval $[0,1]$ of elongation and momentum:

We expect that the measures $\boldsymbol{\zeta}^{N}(d x, d t)$ converge, as $N \rightarrow \infty$ to an absolutely continuous measure with densities $r(t, x)$ and $p(t, x)$, satisfying the following system of conservation laws:

Since (2.23) is a hyperbolic system of nonlinear partial differential equation, its solutions may develop shocks in a finite time, even if smooth initial conditions are given. Therefore, we shall look for weak solutions, which are defined even if discontinuities appear.
Definition 2.1. We say that $(r(t, x), p(t, x)) \in\left(L_{\text {loc }}^{2}\left(\mathbb{R}_{+} \times[0,1]\right)\right)^{2}$ is a weak solution of the system (2.23) provided

for all functions $\varphi, \psi \in C^{2}\left(\mathbb{R}_{+} \times[0,1]\right)$ with compact support on $\mathbb{R}_{+} \times(0,1)$.
Remark. Notice that a simple definition of weak solution as above, without any further entropy condition, does not depend on the boundary conditions imposed.

Denote by $\mathfrak{Q}_{N}$ the probability distribution of $\boldsymbol{\zeta}_{N}$ on $\mathcal{M}\left(Q_{T}\right)^{2}$.
Observe that $\boldsymbol{\zeta}_{N} \in \mathcal{C}\left([0, T], \mathcal{M}([0,1])^{2}\right)$, where $\mathcal{M}([0,1])$ is the space of signed measures on $[0,1]$, endowed by the weak topology. Our aim is to show the convergence

\boldsymbol{\zeta}_{N}(t, J) \rightarrow\left(\int_{0}^{T} \int_{0}^{1} J(t, x) r(t, x) d x d t, \int_{0}^{T} \int_{0}^{1} J(t, x) p(t, x) d x d t\right)^{T} \tag{2.26}
\end{equation*}
$$

where $r(t, x)$ and $p(t, x)$ satisfy (2.24)-(2.25). Since we do not have uniqueness for the solution of these equations, we need a more precise statement.

Theorem 2.2 (Main theorem). The sequence $\mathfrak{Q}_{N}$ is compact and any limit point of $\mathfrak{Q}_{N}$ has support on absolutely continuous measures with densities $r(t, x)$ and $p(t, x)$ solutions of (2.24)-(2.25).
Remark. Since we are dealing with possibly discontinuous solutions, it is not possible to use the entropy method to perform the hydrodynamic limit. Furthermore, we shall not assume that solutions of (2.24)-(2.25) exists, but we prove existence as part of the proof of Theorem 2.2. With a little more effort it is possible to prove continuity in time for the limit distributions. The proof is relatively standard and we chose not to include it here.

Following Theorem 2.2, we discuss the thermodynamics of the system, in particular that the isothermal transformation we have obtained in the hydrodynamic limit satisfies the first and second principle of thermodynamics. A mathematical deduction of this requires some further assumption that are:

- any limit distributions of the momentum and stretch profiles $\mathfrak{Q}$ is concentrated on certain vanishing viscosity solutions (see definition in appendix B),
- these solutions reach equilibrium as time $T$ approach infinity.

A further technical assumption is that the hydrodynamic limit is valid for quadratic functions of the profiles, like the energy. For this purpose we have to define the macroscopic work $W$ done by the system. Under the weak formulation of the equations (2.24)-(2.25) this is impossible without further conditions. We obtain the following theorem.
Theorem 2.3. Let $\tau, U, W, Q, F$ as in (2.16), (4.4), (4.15), (4.16), (2.14). Then, under the assumptions in Section 4, we have

and

Remark. Equation (2.27) expresses the first law of thermodynamics, and is deduced directly from the microscopic dynamics. The main assumption here is the the convergence of the energy, which is quadratic in the positions and the momenta. In fact, 2.2 allows us to pass the weak limit inside nonlinear functions with strictly less than quadratic growth, but we can say nothing if the growth is quadratic.

Equation (2.28) is the Clausius inequality. It is equivalent to the second law of thermodynamics for an isothermal transformation: $\Delta S \geq \beta Q$. From a PDE point of view, on the other hand, the Clausius inequality reads as a Lax-entropy inequality, provided $W=0$. The presence of $W$ is due to the presence of boundary terms. In fact, the work $W$ depends on the external tension $\bar{\tau}$. The Clausius inequality is strictly connected to the possible presence of shocks in the solutions obtained in Theorem 2.2. In fact, if we had smooth solutions at all times, we would obtain an equality of Clausius.

## 3 The Hydrodynamic Limit

Since the temperature $\beta^{-1}$ is fixed throughout the article, in order to simplify notations we fix $\beta=1$ in most sections.

### 3.1 Approximate Solutions

In this section we construct a family $\left\{\hat{\mathbf{u}}_{N}\right\}_{N \in \mathbb{N}}$ of stochastic processes which solve an approximate version of (2.24)-(2.25). Initial data will be ignored, since we are not able to prove uniqueness.

For any $1 \leq l \leq N$ and $l \leq i \leq N-l+1$ we define the block average:

where $1_{N, i}$ is the indicator function of the ball of center $i / N$ and diameter $1 / N$. Note that, since $l / N \rightarrow 0$, for $N$ large enough $\hat{\mathbf{u}}_{N}(t, \cdot)$ is compactly supported in $(0,1)$.

The proof of the first part of Theorem 2.2 relies on the following lemma, which will be proven in Section 3.3:

Lemma 3.1 (Energy estimate). There exists $C_{e}(t)$ independent of $N$ such that

Since $J$ is compactly supported in $(0,1)$ we have, for large enough $N$ and after a summation by parts,

for some $\xi_{i, j}$ between $i / N$ and $(i+j) / N$. Therefore, the energy estimate (3.4) yields

\leq\left\|J^{\prime}\right\|_{L^{\infty}}\left(1+C_{e}(t)\right) \frac{l}{N},
\end{gather*}

which vanishes as $N \rightarrow \infty$. Finally, for large enough $N$,

where $y_{i}$ is between $i / N-1 /(2 N)$ and $i / N+1 /(2 N)$. Therefore,

and the conclusion follows once more from the energy estimate, since

It follows from Lemma 3.4 that $\hat{\mathbf{u}}_{N}(t, x)$ has values in $L^{2}\left(Q_{T}\right)^{2}$. Let us denote by $\tilde{\mathfrak{Q}}_{N}$ the distribution of $\hat{\mathbf{u}}_{N}(t, x)$ on $L^{2}\left(Q_{T}\right)$. We will show in the following that any convergent subsequence of $\tilde{\mathfrak{Q}}_{N}$ is concentrated on the weak solutions of (2.23). By Lemma 3.2 this implies the conclusion of the main Theorem 2.2 for any limit point of $\mathfrak{Q}_{N}$.

From the interaction $V$ we define

for all $\delta>0$ and all test functions $J:[0,1] \rightarrow \mathbb{R}$ compactly supported in $(0,1)$.
The following theorem will be proven in Section 3.3.
Theorem 3.4 (One-block estimate).

Proposition 3.5. Let $\varphi$ and $\psi$ be as in (2.24)-(2.25). Then

\lim _{N \rightarrow \infty} \mathbb{P}\left\{\left|\int_{0}^{\infty} \int_{0}^{1} \hat{p}_{N}(t, x) \partial_{t} \psi(t, x)-\tau\left(\hat{r}_{N}(t, x)\right) \partial_{x} \psi(t, x) d x d t\right|>\delta\right\}=0 \tag{3.18}
\end{align*}

for any $\delta>0$.
Proof. We prove (3.18), as the proof of (3.17) is analogous and technically easier. We denote

+\int_{0}^{T} \sigma \sum_{i=2}^{N-1} \psi_{i}(t) \Delta p_{i}(t) d t+\int_{0}^{T} \sqrt{2 \frac{\sigma}{N}} \sum_{i=1}^{N-1} \psi_{i}(t) \nabla^{*} d w_{i}(t)
\end{array}

where in the above equation we have set $p_{0}, p_{N+1}, w_{N}$ identically equal to 0 .
The second line of (3.21) is equal to

Since $\psi(t, 0)=0=\psi(t, 1)$ and $\psi$ has continuous derivatives in $[0,1]$, we have that $\psi_{1}(t)=$ $\psi\left(t, N^{-1}\right) \sim O\left(N^{-1}\right)$ and the second term of (3.22) is negligeable, while the third is identically null.

The last line of (3.21), depending on $\sigma$, can be rewritten as

Since $\psi$ is twice differentiable,

as $N \rightarrow \infty$. This, together with $\sigma / N \rightarrow 0$ and the energy estimate imply that the first line of (3.23) vanish as $N \rightarrow \infty$. For the same reason, the quadratic variation of the stochastic integrals (last line of (3.23)) also vanish in the limit.

Also the second line of (3.23) will be negligible for the same reason, since $\psi(t, 0)=0=\psi(t, 1)$.
The conclusion then follows by replacing the sums with integrals, $p_{i}$ by $\hat{p}_{N}(t, x)$ and $V^{\prime}\left(r_{i}\right)$ by $\tau\left(\hat{r}_{N}(t, x)\right)$ accordingly to Lemma 3.2, Corollary 3.3 and Theorem 3.4.

Once we have (3.17) and (3.18), we deduce that the distributions $\tilde{\mathfrak{Q}}_{N}$ of $\hat{\mathbf{u}}_{N}(t, x)$ concentrate on the solutions of the macroscopic equations (2.24), (2.25) as follows: we associate to $\hat{\mathbf{u}}_{N}(t, x)$ the random Young measure $\hat{\nu}_{t, x}^{N}=\delta_{\hat{\mathbf{u}}_{N}(t, x)}$. We show that the sequence $\left(\hat{\nu}_{t, x}^{N}\right)_{N \geq 0}$ is compact, in an appropriate probability space, and converges weakly-* to a measure $\tilde{\nu}_{t, x}$. Since (3.17) is linear, we are done for it. Concerning (3.18) (in which the nonlinear unbounded function $\tau$ appears) we prove that

which is not obvious, since weak-* convergence is not enough to pass limits inside unbounded functions like $\tau$.

Finally, using the theory of compensated compactness, we reduce the support of the limit Young measure $\tilde{\nu}_{t, x}$ to a point, that is $\tilde{\nu}_{t, x}=\delta_{\tilde{\mathbf{u}}(t, x)}$, for some function $\tilde{\mathbf{u}}(t, x)=(\tilde{r}(t, x), \tilde{p}(t, x))^{T}$, almost surely and for almost all $t, x$. This closes the equation, as it implies

What we have just presented is only a sketchy statement of what is extensively proven in the rest of this paper. In particular, extra care is taken when applying the theory of Young measures and compensated compactness to a stochastic setting like ours.

### 3.2 Convergence of the Empirical Process

Proposition 3.5 was a first step in proving Theorem 2.2. In this section we complete the proof.
This is done using random Young measures and a stochastic extension of the theory of compensated compactness. We refer to Sections 4 and 5 of [2] for the definitions and results concerning random Young measures.

### 3.2.1 Random Young Measures and Weak Convergence

Denote by $\hat{\nu}_{t, x}^{N}=\delta_{\hat{\mathbf{u}}_{N}(t, x)}$ the random Young measure on $\mathbb{R}^{2}$ associated to the empiric process $\hat{\mathbf{u}}_{N}(t, x)$ :

with $\tilde{C}(T)$ independent of $N$, implies that there exists a subsequence of random Young measures $\left(\hat{\nu}_{t, x}^{N_{n}}\right)$ and a subsequence of real random variables $\left(\left\|\hat{\mathbf{u}}_{N_{n}}\right\|_{L^{2}\left(Q_{T}\right)}\right)$ that converge in law.

We can now apply the Skorohod's representation theorem to the laws of $\left(\hat{\nu}_{t, x}^{N_{n}},\left\|\hat{\mathbf{u}}_{N_{n}}\right\|_{L^{2}\left(Q_{T}\right)}\right)$ and find a common probability space such that the convergence happens surely. This proves the following proposition:
Proposition 3.6. There exists a probability space $(\tilde{\Omega}, \tilde{\mathcal{F}}, \tilde{\mathbb{P}})$, random Young measures $\tilde{\nu}_{t, x}^{n}, \tilde{\nu}_{t, x}$ and real random variables $a_{n}, a$ such that $\tilde{\nu}_{t, x}^{n}$ has the same law of $\hat{\nu}_{t, x}^{N_{n}}, a_{j}$ has the same law of $\left\|\hat{\mathbf{u}}_{N_{n}}\right\|_{L^{2}\left(Q_{T}\right)}$ and $\tilde{\nu}_{t, x}^{n} \stackrel{*}{\rightharpoonup} \tilde{\nu}_{t, x}, a_{n} \rightarrow a, \tilde{\mathbb{P}}$-surely.

Since $\hat{\nu}_{t, x}^{N_{n}}$ is a random Dirac mass and $\tilde{\nu}_{t, x}^{n}$ and $\hat{\nu}_{t, x}^{N_{n}}$ have the same law, $\tilde{\nu}_{t, x}^{n}$ is a $L^{2}$-random Dirac mass, too: $\tilde{\nu}_{t, x}^{n}=\delta_{\tilde{\mathbf{u}}_{n}(t, x)}$ for some $\tilde{\mathbf{u}}_{n} \in L^{2}\left(\tilde{\Omega} \times Q_{T}\right)^{2}$. $\tilde{\mathbf{u}}_{n}$ and $\hat{\mathbf{u}}_{N_{n}}$ have the same law. Since $a_{n} \rightarrow a$ surely, we have that $\left(a_{n}\right)$ is bounded and so $\left\|\tilde{\mathbf{u}}_{n}\right\|_{L^{2}\left(Q_{T}\right)}$ is bounded uniformly in $n$ with $\tilde{\mathbb{P}}$-probability 1 . Since from a uniformly bounded sequence in $L^{p}$ we can extract a weakly convergent subsequence, we obtain the following proposition:
Proposition 3.7. There exist $L^{2}\left(Q_{T}\right)^{2}$-valued random variables $\left(\tilde{\mathbf{u}}_{n}\right)$, $\tilde{\mathbf{u}}$ such that $\tilde{\mathbf{u}}_{n}$ and $\hat{\mathbf{u}}_{N_{n}}$ have the same law and, $\tilde{\mathbb{P}}$-surely and up to a subsequence, $\tilde{\mathbf{u}}_{n} \rightharpoonup \tilde{\mathbf{u}}$ in $L^{2}\left(Q_{T}\right)$.

The condition $\tilde{\nu}_{t, x}^{n} \stackrel{*}{\rightharpoonup} \tilde{\nu}_{t, x}$ in Proposition 3.6 reads

\lim _{n \rightarrow \infty} \int_{\mathbb{R}^{2}} f(\mathbf{y}) d \tilde{\nu}_{t, x}^{n}(\mathbf{y}) d x d t=\int_{\mathbb{R}^{2}} f(\mathbf{y}) d \tilde{\nu}_{t, x}(\mathbf{y}) d x d t \tag{3.28}
\end{equation*}
$$

for all continuous and bounded $f: \mathbb{R}^{2} \rightarrow \mathbb{R}$. The next proposition extend this result to functions $f$ with subquadratic growth:
Proposition 3.8. There is a constant $C$ independent of $n$ such that

Furthermore, let $J: Q_{T} \rightarrow \mathbb{R}$ and $f: \mathbb{R}^{2} \rightarrow \mathbb{R}$ be continuous, with $f(\mathbf{y}) /|\mathbf{y}|^{2} \rightarrow 0$ as $|\mathbf{y}| \rightarrow \infty$. We have

\lim _{n \rightarrow \infty} \mathbb{E}\left[\left|\int_{Q_{T}} \int_{\mathbb{R}^{2}} J(t, x) f(\mathbf{y}) d \tilde{\nu}_{t, x}^{n}(\mathbf{y}) d x d t-\int_{Q_{T}} \int_{\mathbb{R}^{2}} J(t, x) f(\mathbf{y}) d \tilde{\nu}_{t, x}(\mathbf{y}) d x d t\right|\right]=0 \tag{3.30}
\end{equation*}
$$

Proof. Since $\tilde{\nu}_{t, x}^{n}$ and $\hat{\nu}_{t, x}^{N_{n}}$ have the same law, equations (3.26) and (3.27) imply

for some constant $C$ independent of $n$.
Let $\chi: \mathbb{R} \rightarrow \mathbb{R}$ be a continuous, non-negative non-increasing function supported in $[0,2]$ which is identically equal to 1 on $[0,1]$. For $R>1$ and $a \in \mathbb{R}$ define $\chi_{R}(a):=\chi(a / R)$. By the monotone convergence theorem,

Since now $|\mathbf{y}|^{2} \chi_{R}\left(|\mathbf{y}|^{2}\right)$ is continuous and bounded, we have, surely,

\end{equation*}

Then, applying the Fatou lemma twice, we get

\mathbb{E}\left[\int_{Q_{T}} \int_{\mathbb{R}^{2}}|\mathbf{y}|^{2} d \tilde{\nu}_{t, x}(\mathbf{y}) d x d t\right] \leq \liminf _{R \rightarrow \infty} \mathbb{E}\left[\int_{Q_{T}} \int_{\mathbb{R}^{2}}|\mathbf{y}|^{2} \chi_{R}\left(|\mathbf{y}|^{2}\right) d \tilde{\nu}_{t, x}(\mathbf{y}) d x d t\right]  \tag{3.34}\\
\leq \liminf _{R \rightarrow \infty} \liminf _{n \rightarrow \infty} \mathbb{E}\left[\int_{Q_{T}} \int_{\mathbb{R}^{2}}|\mathbf{y}|^{2} \chi_{R}(h(\xi)) d \tilde{\nu}_{t, x}^{n}(\mathbf{y}) d x d t\right] \leq C \tag{3.35}
\end{gather*}
$$

which proves (3.29).
Define

I_{n}:=\int_{Q_{T}} \int_{\mathbb{R}^{2}} J(t, x) f(\mathbf{y}) d \tilde{\nu}_{t, x}^{n}(\mathbf{y}) d x d t, \quad I:=\int_{Q_{T}} \int_{\mathbb{R}^{2}} J(t, x) f(\mathbf{y}) d \tilde{\nu}_{t, x}(\mathbf{y}) d x d t . \tag{3.36}
\end{equation*}
$$

so that (3.30) reads

\lim _{n \rightarrow \infty} \mathbb{E}\left[\left|I_{n}-I\right|\right]=0 \tag{3.37}
\end{equation*}
$$

We further define

I_{n}^{R} & :=\int_{Q_{T}} \int_{\mathbb{R}^{2}} J(t, x) f(\mathbf{y}) \chi_{R}\left(\frac{|\mathbf{y}|^{2}}{1+|f(\mathbf{y})|}\right) d \tilde{\nu}_{t, x}^{n}(\mathbf{y}) d x d t  \tag{3.38}\\
I^{R} & :=\int_{Q_{T}} \int_{\mathbb{R}^{2}} J(t, x) f(\mathbf{y}) \chi_{R}\left(\frac{|\mathbf{y}|^{2}}{1+|f(\mathbf{y})|}\right) d \tilde{\nu}_{t, x}^{n}(\mathbf{y}) d x d t \tag{3.39}
\end{align*}
$$

and estimate

$$
\begin{equation*}
\mathbb{E}\left[\left|I_{n}-I\right|\right] \leq \mathbb{E}\left[\left|I_{n}-I_{n}^{R}\right|\right]+\mathbb{E}\left[\left|I_{n}^{R}-I^{R}\right|\right]+\mathbb{E}\left[\left|I^{R}-I\right|\right] . \tag{3.40}
\end{equation*}
$$

The first term on the right hand side estimates as follows:

\mathbb{E}\left[\left|I_{N}-I_{N}^{R}\right|\right] \leq \mathbb{E}\left[\int_{Q_{T}} \int_{\mathbb{R}^{2}}|J(t, x)||f(\mathbf{y})|\left(1-\chi_{R}\left(\frac{|\mathbf{y}|^{2}}{1+|f(\mathbf{y})|}\right)\right) d \tilde{\nu}_{t, x}^{n}(\mathbf{y}) d x d t\right] \tag{3.41}
\end{equation*}
$$

Since and $f(\mathbf{y}) /|\mathbf{y}|^{2} \rightarrow 0$ as $|\xi| \rightarrow \infty$ we have

\end{equation*}

for any $R>1$. This implies

\mathbb{E}\left[\left|I_{n}-I_{n}^{R}\right|\right] \leq \frac{\|J\|_{L^{\infty}}}{R} \mathbb{E}\left[\int_{Q_{T}} \int_{\mathbb{R}^{2}}|\mathbf{y}|^{2} d \tilde{\nu}_{t, x}^{n}(\mathbf{y}) d x d t\right] \leq \frac{C\|J\|_{L^{\infty}}}{R} \tag{3.43}
\end{equation*}

For (3.29) we have as well

\end{equation*}

which gives

Since $f$ may diverge only at infinity and $f(\mathbf{y}) /|\mathbf{y}|^{2} \rightarrow 0$ as $|\mathbf{y}| \rightarrow \infty$, then $f(\mathbf{y}) \chi_{R}\left(\frac{|\mathbf{y}|^{2}}{1+|f(\mathbf{y})|}\right)$ is continuous and bounded and hence $I_{n}^{R} \rightarrow I^{R}$ surely. Moreover, thanks to the uniform estimate

the sequence $\left(I_{n}^{R}\right)$ is equi-integrable. Therefore, by the Vitali theorem,

which completes the proof.

We are interested in the weak limit of $\tau\left(\hat{r}_{N}(t, x)\right)$. Since $\tau$ is linearly bounded, the previous proposition applies and the main theorem 2.2 is proved once we show that, surely and for almost all $(t, x) \in Q_{T}, \tilde{\nu}_{t, x}=\delta_{\tilde{\mathbf{u}}(t, x)}$.

In the next two subsections we shall prove that the support of $\tilde{\nu}_{t, x}$ is almost surely and almost everywhere a point. The result will then follow from the lemma:
Lemma 3.9. $\tilde{\nu}_{t, x}=\delta_{\tilde{\mathbf{u}}(t, x)}$ almost surely and for almost all $(t, x) \in Q_{T}$ if and only if the support of $\tilde{\nu}_{t, x}$ is a point for almost all $(t, x) \in Q_{T}$. In this case, $\tilde{\mathbf{u}}_{n} \rightarrow \tilde{\mathbf{u}}$ in $L^{p}\left(Q_{T}\right)^{2}$-strong for all $1 \leq p<2$.

Proof. Suppose there is a measurable function $\mathbf{u}^{*}: Q_{T} \rightarrow \mathbb{R}^{2}$ such that $\tilde{\nu}_{t, x}=\delta_{\mathbf{u}^{*}(t, x)}$ for almost all $(t, x) \in Q_{T}$. For any test function $\mathbf{J}: Q_{T} \rightarrow \mathbb{R}^{2}$ consider the quantity

By taking the limit for $n \rightarrow \infty$ the sense of $L^{2}$-weak first and in the sense of (3.30) then, we obtain

\int_{Q_{T}} \int_{\mathbb{R}^{2}} \mathbf{J}(t, x) \cdot \tilde{\mathbf{u}}(t, x) d x d t=\int_{Q_{T}} \int_{\mathbb{R}^{2}} \mathbf{J}(t, x) \cdot \mathbf{y} d \tilde{\nu}_{t, x}(\mathbf{y}) d x d t=\int_{Q_{T}} \int_{\mathbb{R}^{2}} \mathbf{J}(t, x) \cdot \mathbf{u}^{*}(t, x) d x d t \tag{3.49}
\end{equation*}
$$

almost surely. Then $\tilde{\mathbf{u}}(t, x)=\mathbf{u}^{*}(t, x)$ for almost all $(t, x) \in Q_{T}$ follows from the fact that $\mathbf{J}$ was arbitrary.

Next, fix $1<p<2$. Taking $f(\mathbf{y})=|\mathbf{y}|^{p}$ in (3.30) gives $\left\|\tilde{\mathbf{u}}_{n}\right\|_{L^{p}\left(Q_{T}\right)} \rightarrow\|\tilde{\mathbf{u}}\|_{L^{p}\left(Q_{T}\right)}$, which, together with $\tilde{\mathbf{u}}_{n} \rightharpoonup \tilde{\mathbf{u}}$ in $L^{p}\left(Q_{T}\right)^{2}$ and the fact that $L^{p}\left(Q_{T}\right)^{2}$ is uniformly convex for $1<p<\infty$ implies strong convergence.

The case $p=1$ follows from the result for $p>1$ and Holder's inequality.

### 3.2.2 Reduction of the Limit Young Measure

In this section we prove that the support of $\tilde{\nu}_{t, x}$ is almost surely and almost everywhere a point.
We recall that Lax entropy-entropy flux pair for the system

\partial_{t} r(t, x)-\partial_{x} p(t, x)=0  \tag{3.50}\\
\partial_{t} p(t, x)-\partial_{x} \tau(p(t, x))=0
\end{array}\right.
$$

is a pair of functions $\eta, q: \mathbb{R}^{2} \rightarrow \mathbb{R}$ such that

\partial_{t} \eta(\mathbf{u}(t, x))+\partial_{x} q(\mathbf{u}(t, x))=0 \tag{3.51}
\end{equation*}
$$

for any smooth solution $\mathbf{u}(t, x)=(r(t, x), p(t, x))^{T}$ of (3.50). This is equivalent to the following:

\partial_{r} \eta(r, p)+\partial_{p} q(r, p)=0  \tag{3.52}\\
\tau^{\prime}(r) \partial_{p} \eta(r, p)+\partial_{r} q(r, p)=0
\end{array}\right.
$$

Under appropriate conditions on $\tau$, Shearer ([12]) constructs a family of entropy-entropy flux pairs $(\eta, q)$ such that $\eta, q$, their first and their second derivatives are bounded. As we shall see in the appendix, our choice of the potential $V$ ensures that the tension $\tau$ has the required properties, so the result of Shearer applies to our case.

In particular, always following [12], we have that the support $\tilde{\nu}_{t, x}$ is almost surely and almost everywhere a point provided the Tartar's commutation relation

\begin{equation*}
\left\langle\eta_{1} q_{2}-\eta_{2} q_{1}, \tilde{\nu}_{t, x}\right\rangle=\left\langle\eta_{1}, \tilde{\nu}_{t, x}\right\rangle\left\langle q_{2}, \tilde{\nu}_{t, x}\right\rangle-\left\langle\eta_{2}, \tilde{\nu}_{t, x}\right\rangle\left\langle q_{1}, \tilde{\nu}_{t, x}\right\rangle \tag{3.53}
\end{equation*}
$$

holds almost surely and almost everywhere for any bounded pairs $\left(\eta_{1}, q_{1}\right)$, ( $\eta_{2}, q_{2}$ ) with bounded first and second derivatives.

Obtaining (3.53) in a deterministic setting is standard and relies on the div-curl and the Murat's lemma. Both of these lemmas have a stochastic extension (cf [2][5]) and what we ultimately need to prove in order to obtain (3.53) is that the hypotheses for the stochastic Murat's lemma are satisfied. This is ensured by the following theorem, which we will prove in the next section.
Theorem 3.10. Let $(\eta, q)$ be a bounded Lax entropy-entropy flux pair with bounded first and second derivatives. Let $\varphi: \mathbb{R}^{2} \rightarrow \mathbb{R}$ be such that $\varphi=\phi \psi$, with $\phi$ compactly supported in $(0, \infty) \times(0,1)$ and $\psi \in L^{\infty}\left(\mathbb{R}_{+} \times[0,1]\right) \cap H^{1}\left(\mathbb{R}_{+} \times[0,1]\right)$. Define

\tilde{X}_{n}(\eta, \varphi):=\int_{0}^{\infty} \int_{0}^{1}\left[\partial_{t} \varphi(t, x) \eta\left(\tilde{\mathbf{u}}_{n}(t, x)\right)+\partial_{x} \varphi(t, x) q\left(\tilde{\mathbf{u}}_{n}(t, x)\right)\right] d x d t \tag{3.54}
\end{equation*}
$$

Then $\tilde{X}_{n}$ decomposes as

\tilde{X}_{n}=\tilde{Y}_{n}+\tilde{Z}_{n} \tag{3.55}
\end{equation*}
$$

and there are two deterministic functionals $A_{n}, B_{n}$ independent of $\varphi$ such that

\mathbb{E}\left[\left|\tilde{Y}_{n}(\varphi, \eta)\right|\right] \leq A_{n}(\phi)\|\psi\|_{H^{1}}, \quad \mathbb{E}\left[\left|\tilde{Z}_{n}(\varphi, \eta)\right|\right] \leq B_{n}(\phi)\|\psi\|_{L^{\infty}} \tag{3.56}
\end{equation*}
$$

with

$$
\begin{equation*}
\lim _{n \rightarrow \infty} A_{n}(\varphi)=0, \quad \limsup _{n \rightarrow \infty} B_{n}(\varphi)<\infty \tag{3.57}
\end{equation*}
$$

Remark. Recall that the $H^{1}$ norm of a function $f(t, x)$ is defined as $\|f\|_{H^{1}}=\|f\|_{L^{2}}+\left\|\partial_{t} f\right\|_{L^{2}}+$ $\left\|\partial_{x} f\right\|_{L^{2}}$. Moreover, from now on, $\phi$ (and hence $\varphi$ ) will be supported in $[0, T] \times[a, b]$ for some fixed $T>0$ and $0<a<b<1$.

### 3.2.3 Conditions for the Murat Lemma

This section is devoted to proving Theorem 3.10 through a series of lemmas. Since we are ultimately interested in taking expectations of functions of $\tilde{\mathbf{u}}_{n}$, and since $\tilde{\mathbf{u}}_{n}$ and $\hat{\mathbf{u}}_{N_{n}}$ have the same law, we shall prove the theorem for

\end{equation*}

Recalling that $\hat{\mathbf{u}}_{N}$ is built from a solution $\hat{\mathbf{u}}_{i}=\left(r_{i}, p_{i}\right)$ of the system of SDEs (2.11), and since $\varphi(t, \cdot)$ is compactly supported in $(0,1)$, Itô formula yields

+\int_{0}^{\infty} \sum_{i=l+1}^{N-l} \bar{\varphi}_{i}\left(\partial_{r} q\left(\hat{\mathbf{u}}_{l, i}\right) \nabla \hat{r}_{l, i}-\partial_{p} q\left(\hat{\mathbf{u}}_{l, i}\right) \nabla^{*} \hat{p}_{l, i}\right) d t,  \tag{3.60}\\

=\mathcal{N}_{r, N}(\varphi, \eta)+\mathcal{N}_{p, N}(\varphi, \eta)+\mathcal{N}_{1, N}(\varphi, \eta), \tag{3.159}
\end{gather*}

where

\mathcal{N}_{r, N}(\varphi, \eta)=\int_{0}^{\infty} \sum_{i=l+1}^{N-l}\left(\tilde{\varphi}_{i} \partial_{r} q\left(\tilde{\mathbf{u}}_{l, i}\right)-\bar{\varphi}_{i} \partial_{r} q\left(\hat{\mathbf{u}}_{l, i}\right)\right) \nabla \hat{r}_{l, i} d t,  \tag{3.160}\\
\mathcal{N}_{p, N}(\varphi, \eta)=\int_{0}^{\infty} \sum_{i=l+1}^{N-l}\left(\tilde{\varphi}_{i} \partial_{p} q\left(\tilde{\mathbf{u}}_{l, i}\right)-\bar{\varphi}_{i} \partial_{p} q\left(\hat{\mathbf{u}}_{l, i}\right)\right) \nabla \hat{p}_{l, i} d t  \tag{3.161}\\

### 3.3 One and Two-Block Estimates

### 3.3.1 The Relative Entropy and the Dirichlet Forms

Denote by $\lambda^{N}$ the Gibbs measure

Define the relative entropy

\tilde{D}_{N}\left(f_{t}^{N}\right) & :=\sum_{i=1}^{N-1} \int_{\mathbb{R}^{2 N}} \frac{1}{4 f_{t}^{N}}\left(\frac{\partial f_{t}^{N}}{\partial r_{i+1}}-\frac{\partial f_{t}^{N}}{\partial r_{i}}\right)^{2} d \lambda^{N} . \tag{3.185}

Theorem 3.21. Assume there is a constant $C_{0}$ independent of $N$ such that $H_{N}(0) \leq C N$. Assume also the external tension $\bar{\tau}: \mathbb{R} \rightarrow \mathbb{R}$ is bounded with bounded derivative.

\end{gather*}

We estimate the second term in (3.188) (the third term will be analogous).

=-\sum_{i=1}^{N-1} \int\left(D_{i} f_{t}^{N}\right)\left(D_{i} \log f_{t}^{N}\right) d \lambda^{N}=-\sum_{i=i}^{N-1} \int \frac{\left(D_{i} f_{t}^{N}\right)^{2}}{f_{t}^{N}} d \lambda^{N}=-4 D_{N}\left(f_{t}^{N}\right) . \tag{3.191}
\end{gather*}

\end{gather*}

with $C(\alpha)$ is independent of $N$. Therefore,

### 3.3.2 Block Estimates

In this section we prove the three main estimate we have used in proving our main result: the energy, one-block and two-block estimates. In what follows the expectations $\mathbb{E}$ at time $t$ shall be evaluated in terms of integrals with respect to the measure $\mu_{t}^{N}$.

Integrating by parts we have

$$
\begin{gather*}
\int\left(\hat{V}_{l, i}^{\prime}-\bar{V}_{l, i}^{\prime}\right)^{2} d \mu_{s}^{N}=\int\left(\hat{V}_{l, i}^{\prime}-\bar{V}_{l, i}^{\prime}\right)\left(\hat{V}_{l, i}^{\prime}-\bar{V}_{l, i}^{\prime}\right) f_{s}^{N} d \lambda^{N} \\
=\int\left(\hat{\partial}_{l, i}-\bar{\partial}_{l, i}\right)\left(\hat{V}_{l, i}^{\prime}-\bar{V}_{l, i}^{\prime}\right) d \mu_{s}^{N}+\int\left(\hat{V}_{l, i}^{\prime}-\bar{V}_{l, i}^{\prime}\right)\left(\hat{\partial}_{l, i} f_{s}^{N}-\bar{\partial}_{l, i} f_{s}^{N}\right) d \lambda^{N} . \tag{3.253}
\end{gather*}
$$

We can write

$$
\begin{equation*}
\hat{\partial}_{l, i}-\bar{\partial}_{l, i}=\frac{1}{l} \sum_{|j|<l} c_{j} \partial_{r_{i-j}}, \quad \hat{V}_{l, i}^{\prime}-\bar{V}_{l, i}^{\prime}=\frac{1}{l} \sum_{|j|<l} c_{j} V_{i-j}^{\prime} \tag{3.254}
\end{equation*}
$$

where the numbers $c_{j}$ have the following properties: $c_{j}^{2} \leq 1$, and $\sum_{j} c_{j}=0$. This allows us to estimate

$$
\begin{equation*}
\left(\hat{\tilde{\partial}}_{l, i}-\overline{\tilde{\partial}}_{l, i}\right)\left(\hat{V}_{l, i}^{\prime}-\bar{V}_{l, i}^{\prime}\right)=\frac{1}{l^{2}} \sum_{|i|<l} c_{i}^{2} V^{\prime \prime}\left(r_{i-j}\right) \leq \frac{2\left\|V^{\prime \prime}\right\|_{L^{\infty}}}{l} . \tag{3.255}
\end{equation*}
$$

For the remaining term in (3.253) we use Cauchy-Schwarz:
$\int\left(\hat{V}_{l, i}^{\prime}-\bar{V}_{l, i}^{\prime}\right)\left(\hat{\partial}_{l, i} f_{s}^{N}-\bar{\partial}_{l, i} f_{s}^{N}\right) d \lambda^{N} \leq \frac{1}{2} \int\left(\hat{V}_{l, i}^{\prime}-\bar{V}_{l, i}^{\prime}\right)^{2} d \mu_{s}^{N}+\frac{1}{2} \int \frac{1}{f_{s}^{N}}\left(\hat{\partial}_{l, i} f_{s}^{N}-\bar{\partial}_{l, i} f_{s}^{N}\right)^{2} d \lambda^{N}$.

The last term at the right-hand side evaluates as

$$
\begin{equation*}
\hat{\partial}_{l, i} f_{s}^{N}-\bar{\partial}_{l, i} f_{s}^{N}=\frac{1}{l} \sum_{j=1}^{l} \frac{j}{l}\left(\partial_{r_{i-j+l}} f_{s}^{N}-\partial_{r_{i-j}} f_{s}^{N}\right) . \tag{3.257}
\end{equation*}
$$

Therefore

$$
\begin{equation*}
\int \frac{1}{f_{s}^{N}}\left(\hat{\partial}_{l, i} f_{s}^{N}-\bar{\partial}_{l, i} f_{s}^{N}\right)^{2} d \lambda^{N}=\frac{4}{l^{2}} \int \frac{1}{f_{s}^{N}}\left(\sum_{j=1}^{l} \frac{j}{l}\left(\partial_{r_{i-j+l}} f_{s}^{N}-\partial_{r_{i-j}} f_{s}^{N}\right)\right)^{2} d \lambda^{N} \tag{3.258}
\end{equation*}
$$

is estimated by the Dirichlet form as in the proof of the two block estimate, since $j / l<1$, leading to the conclusion.

The proof of the statement for $\eta_{j}=p_{j}$ is analogous. We are left with the case $\eta_{j}=r_{j}$. Since we do not have an integration by parts formula involving $r_{j}$ alone, we follow the proof of Lemma 3.24: for any $\alpha>0$,

\sum_{i=l}^{N} \alpha \int_{0}^{t} \int\left(\hat{r}_{l, i}-\bar{r}_{l, i}\right)^{2} d \mu_{s}^{N} \leq t \sum_{i=l}^{N} \log \int e^{\alpha\left(\hat{r}_{l, i}-\bar{r}_{l, i}\right)^{2}} d \bar{\lambda}_{2 l-\bar{p}}^{\rho, \bar{p}}, i+l-1+C(t) \frac{(2 l-1)^{3}}{\sigma} \tag{3.259}
\end{equation*}
$$

We write

$$
\begin{gather*}
\int \exp \left(\alpha\left(\hat{r}_{l, i}-\bar{r}_{l, i}\right)^{2}\right) d \bar{\lambda}_{2 l-1, i+l-1}^{\rho, \bar{p}} \leq C^{\prime} \int \exp \left(\alpha\left(\hat{r}_{l, i}-\bar{r}_{l, i}\right)^{2}\right) d \lambda_{1, \bar{p}, \tau(\rho)}^{N}  \tag{3.260}\\
=C^{\prime} \mathbb{E}_{\xi}\left[\int \exp \left(\sqrt{2 \alpha} \xi\left(\hat{r}_{l, i}-\bar{r}_{l, i}\right)\right) d \lambda_{1, \bar{p}, \tau(\rho)}^{N}\right] \tag{3.261}
\end{gather*}
$$

where $\xi$ is a normally distributed random. In order to calculate the last integral, we write

$$
\begin{gather*}
\int \exp \left(\sqrt{2 \alpha} \xi\left(\hat{r}_{l, i}-\bar{r}_{l, i}\right)\right) d \lambda_{1, \bar{p}, \tau(\rho)}^{N}=\int \exp \left(\frac{\sqrt{2 \alpha} \xi}{l} \sum_{|j|<l} c_{j} r_{i-j}\right) d \lambda_{1, \bar{p}, \tau(\rho)}^{N}  \tag{3.262}\\
=\prod_{|j|<l} \int \exp \left(\frac{\sqrt{2 \alpha} \xi}{l} c_{j} r_{i-j}+\tau(\rho) r_{i-j}-V\left(r_{i-j}\right)-G(\tau(\rho))\right) d r_{i-j}  \tag{3.263}\\
=\prod_{|j|<l} \exp \left(G\left(\tau(\rho)+\frac{\sqrt{2 \alpha} \xi}{l} c_{j}\right)-G(\tau(\rho))\right)  \tag{3.264}\\
=\exp \sum_{|j|<l}\left(G^{\prime}(\tau(\rho)) \frac{\sqrt{2 \alpha} \xi}{l} c_{j}+G^{\prime \prime}(\tilde{\tau}) \frac{\alpha \xi^{2}}{l^{2}} c_{j}^{2}\right) \tag{3.265}
\end{gather*}
$$

for some intermediate value $\tilde{\tau}$. Since $\sum_{j} c_{j}=0, c_{j}^{2} \leq 1$, and $G^{\prime \prime}$ is bounded, we have

$$
\begin{equation*}
\exp \sum_{|j|<l}\left(G^{\prime}(\tau(\rho)) \frac{\sqrt{2 \alpha} \xi}{l} c_{j}+G^{\prime \prime}(\tilde{\tau}) \frac{\alpha \xi^{2}}{l^{2}} c_{j}^{2}\right) \leq \exp \left(\frac{2 \alpha(2 l+1)\left\|G^{\prime \prime}\right\|_{L^{\infty}}}{l^{2}} \xi^{2}\right) \tag{3.266}
\end{equation*}
$$

Therefore we have obtained

$$
\begin{equation*}
\int \exp \left(\alpha\left(\hat{r}_{l, i}-\bar{r}_{l, i}\right)^{2}\right) d \bar{\lambda}_{2 l-1, i+l-1}^{\rho, \bar{p}} \leq C^{\prime} \mathbb{E}_{\xi}\left[\exp \left(\frac{6 \alpha\left\|G^{\prime \prime}\right\|_{L^{\infty}}}{l} \xi^{2}\right)\right] \tag{3.267}
\end{equation*}
$$

and again the right hand side is independent of $\rho$ and $\bar{p}$. The conclusion then follows as in the proof of the one block estimate.

We end this section by stating the one block estimate in terms of the averages $\hat{\eta}_{l, i}$.

Corollary 3.29. Let $l_{0}$ be as in Lemma 3.24. There is $C_{1}(t)$ independent of $N$ such that

\sum_{i=l}^{N-l+1} \int_{0}^{t} \int\left(\hat{V}_{l, i}^{\prime}-\tau\left(\hat{r}_{l, i}\right)\right)^{2} d \mu_{s}^{N} d s \leq C_{1}(t)\left(\frac{N}{l}+\frac{l^{2}}{\sigma}\right) \tag{3.268}
\end{equation*}
$$

whenever $N \geq l>l_{0}$.
Proof. It follows immediately from the first one block estimate and the average comparison, since

\left(\hat{V}_{l, i}^{\prime}-\tau\left(\hat{r}_{l, i}\right)\right)^{2} \leq 3\left(\hat{V}_{l, i}^{\prime}-\bar{V}_{l, i}^{\prime}\right)^{2}+3\left(\bar{V}_{l, i}^{\prime}-\tau\left(\bar{r}_{l, i}\right)\right)^{2}+3\left(\tau\left(\bar{r}_{l, i}\right)-\tau\left(\hat{r}_{l, i}\right)\right)^{2} \tag{3.269}
\end{equation*}
$$

and

$$
\begin{equation*}
\left(\tau\left(\bar{r}_{l, i}\right)-\tau\left(\hat{r}_{l, i}\right)\right)^{2} \leq C\left(\bar{r}_{l, i}-\hat{r}_{l, i}\right)^{2} . \tag{3.270}
\end{equation*}
$$

## 4 Thermodynamic Consequences

In this final section we want to prove that any limit distribution $\mathfrak{Q}$ of $\mathfrak{Q}_{N}$ satisfy the thermodynamic principles applied to isothermal transformations. Throughout this section, we shall restore $\beta$.

In order to perform a isothermal thermodynamic transformation we fix $\tau_{0}, \tau_{1}, t_{1} \in \mathbb{R}$ and take the external tension $\bar{\tau}$ to be a smooth function such that $\bar{\tau}(0)=\tau_{0}$ and $\tilde{\tau}(t)=\tau_{1}$ for all $t \geq t_{1}$. This corresponds to the following physical situation: at time 0 the system is at equilibrium, and the equilibrium state determined by ( $\beta, \tau_{0}$ ). Then we vary the external tension and we eventually bring the system to another equilibrium state (reached asymptotically as $t \rightarrow \infty$ ), identified by ( $\beta, \tau_{1}$ ) (we are performing isothermal transformations, so the temperature does not change). This is the way we define a a thermodynamic isothermal transformation between two equilibrium states ( $\beta, \tau_{0}$ ) and $\left(\beta, \tau_{1}\right)$.

Recall the definition of the Gibbs potential:

$$
\begin{equation*}
G(\beta, \tau)=\log \int_{-\infty}^{\infty} \exp (-\beta(V(r)-\tau r)) d r+\log \sqrt{\frac{2 \pi}{\beta}} \tag{4.1}
\end{equation*}
$$

Moreover, the free energy $F$ is defined as

$$
\begin{equation*}
F(\beta, \rho)=\sup _{\tau \in \mathbb{R}}\left\{\tau \rho-\beta^{-1} G(\beta, \tau)\right\} \tag{4.2}
\end{equation*}
$$

and the tension $\tau$ is given by

$$
\begin{equation*}
\tau(\beta, \rho)=\partial_{\rho} F(\beta, \rho) . \tag{4.3}
\end{equation*}
$$

Finally, the internal energy $U$ is defined by

$$
\begin{equation*}
U(\beta, \tau)=\mathbb{E}_{\lambda_{\beta, 0, \tau}}\left[\frac{p_{j}^{2}}{2}+V\left(r_{j}\right)\right] . \tag{4.4}
\end{equation*}
$$

Through this section we need the following assumption on the convergence of the energy:
Assumption A.

$$
\begin{equation*}
\lim _{N \rightarrow \infty} \mathbb{E}\left(E_{N}(t)-\int_{0}^{1} U\left(\beta, \tau\left(r_{N}(t, x)\right) d x\right)=0\right. \tag{4.5}
\end{equation*}
$$

and

$$
\begin{equation*}
\lim _{N \rightarrow \infty} E_{N}(0)=U\left(\beta, \tau_{0}\right) . \tag{4.6}
\end{equation*}
$$

Furthermore, under the proper convergent subsequence,

$$
\begin{equation*}
\lim _{N \rightarrow \infty} \int_{0}^{1} \int_{0}^{\infty} \psi(t, x) E^{\mathfrak{Q}_{N}}\left(f\left(\hat{\mathbf{u}}_{N}(t, x)\right)\right) d x d t=\int_{0}^{1} \int_{0}^{\infty} \psi(t, x) \mathbb{E}^{\mathfrak{Q}}(f(\tilde{\mathbf{u}}(t, x))) d x d t \tag{4.7}
\end{equation*}
$$

for all test functions $\psi$ and all continuous $f$ with quadratic growth.

Remark. Assumption A is necessary because all our bounds rely on relative entropy that is not sufficient to give the uniform integrability for the convergence of second moments.

We also need some assumptions on the weak solutions considered:

- When tension is held at the constant value $\tau_{1}$,

$$
\begin{equation*}
\lim _{t \rightarrow \infty} \tau(\beta, \tilde{r}(t, x))=\tau_{1}, \quad \lim _{t \rightarrow \infty} \tilde{p}(t, x)=0 \tag{4.8}
\end{equation*}
$$

for almost all $x \in[0,1]$.

$$
\begin{equation*}
\mathcal{L}(t):=\int_{0}^{1} r(t, y) d y \tag{4.9}
\end{equation*}
$$

is a bounded variation function of $t$. This is necessary in order to define the macroscopic work $W(t)$ below.
The first law of thermodynamics is an energy balance which takes into account energy loss (or gain) via heat exchange. It reads as follows.

$$
\begin{equation*}
\Delta U=W+Q \tag{4.10}
\end{equation*}
$$

where $\Delta U$ is the difference of internal energy between two equilibrium states, $W$ is the work done on the system (which depends on the external force $\bar{\tau}$ ) and $Q$ is the heat exchanged (which depends on the noise, i.e. on $\sigma$ ). In order to deduce the first principle, we use the equations (2.11) to obtain, from a direct calculation,

$$
\begin{equation*}
E_{N}(t)-E_{N}(0)=\int_{0}^{t} d E_{N}(s)=W_{N}(t)+Q_{N}(t) \tag{4.11}
\end{equation*}
$$

where

$$
\begin{equation*}
W_{N}(t)=\int_{0}^{t} \bar{\tau}(s) p_{N}(s) d s \tag{4.12}
\end{equation*}
$$

and

$$
\begin{equation*}
Q_{N}(t)=-\sigma \int_{0}^{t} \sum_{i=1}^{N-1}\left(\left(\nabla p_{i}(s)\right)^{2}-2 \beta^{-1}\right) d s+\sqrt{\frac{2 \sigma}{\beta N}} \sum_{i=1}^{N-1} \int_{0}^{t}\left(\nabla p_{i}(s)\right) d w_{i}(s) . \tag{4.13}
\end{equation*}
$$

$W_{N}$ can be rewritten in the more expressive form

$$
\begin{equation*}
W_{N}(t)=\int_{0}^{t} \bar{\tau}(s) d\left(\frac{q_{N}(s)}{N}\right)=\int_{0}^{t} \bar{\tau}(s) d\left(\frac{1}{N} \sum_{i=1}^{N} r_{i}(s)\right), \tag{4.14}
\end{equation*}
$$

so that we have

$$
\begin{equation*}
W(t)=\lim _{N \rightarrow \infty} W_{N}(t)=\int_{0}^{t} \bar{\tau}(s) d \mathcal{L}(s), \tag{4.15}
\end{equation*}
$$

$W(t)$ is the macroscopic work done by the external tension up to time $t$.
By our Assumption A about the convergence of the energy, we obtain that $E_{N}(t)-E_{N}(0)$ converges to the difference of internal energy, and so $Q_{N}(t)$ converges, as $N \rightarrow \infty$ to the quantity

$$
\begin{equation*}
Q(t)=\int_{0}^{1}\left(U(\beta, \tau(\tilde{r}(t, x)))-U\left(\beta, \tau_{0}\right)\right) d x-W(t) \tag{4.16}
\end{equation*}
$$

Therefore, taking the limit $t \rightarrow \infty$ we obtain the first principle of thermodynamics

$$
\begin{equation*}
U\left(\beta, \tau_{1}\right)-U\left(\beta, \tau_{0}\right)=W+Q \tag{4.17}
\end{equation*}
$$

Let us move now to the second principle. It states that, during a isothermal thermodynamic transformation,

$$
\begin{equation*}
\Delta S \geq \beta Q \tag{4.18}
\end{equation*}
$$

where $\Delta S$ is the difference of entropy and $Q$ is the heat. The equality holds only for reversible (or quasistatic) transformations. The entropy $S$ is defined by

$$
\begin{equation*}
S=\beta(U-F) . \tag{4.19}
\end{equation*}
$$

where $F$ is the free energy and $U$ is the internal energy. We can combine the first principle (4.17) and (4.19) to have an equivalent formulation of the second principle for an isothermal transformation. In fact, we have

$$
\Delta F=\Delta U-T \Delta S=W+Q-\beta^{-1} \Delta S
$$

Therefore, since $\beta$ is positive, the second principle is equivalent to the following inequality of Clausius

$$
\begin{equation*}
\Delta F \leq W \tag{4.20}
\end{equation*}
$$

We show that (4.20) for our system is a consequence of the above assumptions and the assumption that the hydrodynamic limit concentrates on the the vanishing viscosity solutions.

Define the free energy at time $t$ by

$$
\begin{equation*}
\mathcal{F}(t)=\int_{0}^{1}\left(\frac{\tilde{p}(t, x)^{2}}{2}+F(\beta, \tilde{r}(t, x))\right) d x . \tag{4.21}
\end{equation*}
$$

Notice the presence of the macroscopic kinetic term in (4.21), that eventually disappears when the system reach global equilibrium. It follows from the initial and asymptotic conditions on $\tilde{r}$ and $\tilde{p}$ that

$$
\begin{equation*}
\mathcal{F}(0)=F\left(\beta, \tau^{-1}\left(\tau_{0}\right)\right), \quad \lim _{t \rightarrow \infty} \mathcal{F}(t)=F\left(\beta, \tau^{-1}\left(\tau_{1}\right)\right) . \tag{4.22}
\end{equation*}
$$

In Appendix B we show that the vanishing viscous solutions satisfy $\mathcal{F}(t)-\mathcal{F}(0) \leq W(t)$, and consequently

$$
\begin{equation*}
F\left(\beta, \tau^{-1}\left(\tau_{1}\right)\right)-F\left(\beta, \tau^{-1}\left(\tau_{0}\right)\right) \leq W \tag{4.23}
\end{equation*}
$$

where $W$ is defined in (4.17). In order to make the following calculations more transparent, we omit to write the dependence on $\beta$.

## A Properties of the Tension

In this section we shall give some technical properties about the tension $\tau$. In order to simplify the notation we set $\beta=1$ once again. Thus, we define

$$
\begin{equation*}
\tau(\rho)=F^{\prime}(\rho), \quad F(\rho)=\sup _{\tau \in \mathbb{R}}\{\tau \rho-G(\tau)\}, \tag{A.1}
\end{equation*}
$$

where

$$
\begin{equation*}
G(\tau)=\log \int_{-\infty}^{\infty} e^{\tau r-V(r)} d r-\log \sqrt{2 \pi} \tag{A.2}
\end{equation*}
$$

We will prove the following
Proposition A.1. Let the potential $V \in C^{2}(\mathbb{R})$ be strictly convex, in the sense that there exist $c_{1}, c_{2} \in \mathbb{R}$ such that

$$
\begin{equation*}
0<c_{1} \leq V^{\prime \prime}(r) \leq c_{2}, \quad \forall r \in \mathbb{R} \tag{A.3}
\end{equation*}
$$

Moreover, assume there exist some positive constants $V_{+}^{\prime \prime}, V_{-}^{\prime \prime}, \alpha, R$ such that

$$
\begin{align*}
& \left|V^{\prime \prime}(r)-V_{+}^{\prime \prime}\right|<e^{-\alpha r}, \quad \forall r>R  \tag{A.4}\\
& \left|V^{\prime \prime}(r)-V_{-}^{\prime \prime}\right|<e^{\alpha r}, \quad \forall r<-R
\end{align*} .
$$

Then the following properties hold true.
i) The p-system (2.23) is strictly hyperbolic, meaning $\tau^{\prime}(\rho) \geq c_{1}>0$ for all $\rho \in \mathbb{R}$;
ii) $\tau^{\prime \prime}(\rho)\left(\tau^{\prime}(\rho)\right)^{-5 / 4}$ and $\tau^{\prime \prime \prime}(\rho)\left(\tau^{\prime}(\rho)\right)^{-7 / 4}$ are in $L^{2}(\mathbb{R})$, while $\tau^{\prime \prime}(\rho)\left(\tau^{\prime}(\rho)\right)^{-3 / 4}$ and $\tau^{\prime \prime \prime}(\rho)\left(\tau^{\prime}(\rho)\right)^{-2}$ are in $L^{\infty}(\mathbb{R})$.
iii) $\tau^{\prime}(\rho) \leq c_{2}$ for all $\rho \in \mathbb{R}$. Moreover, $\tau(\rho) / F(\rho) \rightarrow 0$ as $|\rho| \rightarrow \infty$.

Finally, suppose we can write

$$
\begin{equation*}
V(x)=\frac{r^{2}}{2}+\theta U(r) \tag{A.5}
\end{equation*}
$$

for some $\theta \in \mathbb{R}$, where $U$ is a smooth and convex mollification of the function $\kappa r \max \{r, 0\} / 2-\kappa r^{2} / 2$, for some $0<\kappa<1 / 2$.
iv) There exists $\theta_{\kappa}>0$ such that, for $0<|\theta|<\theta_{\kappa}$, the $p$-system (2.23) is genuinely nonlinear, meaning $\tau^{\prime \prime}(\rho) \neq 0$ for all $\rho \in \mathbb{R}$.
We prove the previous propositions through a series of lemmas.
Fix $\bar{p}, \tau \in \mathbb{R}$. We denote by $\lambda_{\bar{p}, \tau}$ the probability measure on $\mathbb{R}^{2}$ defined by

$$
\begin{equation*}
\int_{\mathbb{R}^{2}} f(r, p) d \lambda_{\bar{p}, \tau}(r, p)=\frac{e^{-G(\tau)}}{\sqrt{2 \pi}} \int_{\mathbb{R}^{2}} f(r, p) e^{-\frac{(p-\bar{p})^{2}}{2}+\tau r-V(r)} d r d p, \tag{A.6}
\end{equation*}
$$

for any measurable $f: \mathbb{R}^{2} \rightarrow \mathbb{R}$.
The first lemma we state is used in the proof of the one block estimate.
Lemma A.2. Let $\alpha \in \mathbb{R}$. Then

\int e^{\alpha V^{\prime}(r)} d \lambda_{\bar{p}, \tau} \leq \exp \left(\alpha \tau+\frac{c_{2}}{2} \alpha^{2}\right) . \tag{A.7}
\end{equation*}

A(\alpha, \tau)=\log \int e^{\alpha V^{\prime}(r)} d \lambda_{\bar{p}, \tau} \tag{A.8}
\end{equation*}
$$

Then, integrating by parts, we have

& \partial_{\alpha} A(\alpha, \tau)=\int_{-\infty}^{\infty} V^{\prime}(r) \exp \left(\alpha V^{\prime}(r)+\tau r-V(r)-G(\tau)-A(\alpha, \tau)\right) d r  \tag{A.9}\\
& =\int_{-\infty}^{\infty}\left(\alpha V^{\prime \prime}(r)+\tau\right) \exp \left(\alpha V^{\prime}(r)+\tau r-V(r)-G(\tau)-A(\alpha, \tau)\right) d r \tag{A.10}
\end{align*}
$$

Since

$$
\begin{equation*}
c_{1} \leq V^{\prime \prime}(r) \leq c_{2}, \quad \forall r \in \mathbb{R}, \tag{A.11}
\end{equation*}
$$

if $\alpha>0$ we obtain

$$
\begin{equation*}
\partial_{\alpha} A(\alpha, \tau) \leq c_{2} \alpha+\tau, \tag{A.12}
\end{equation*}
$$

while, if $\alpha \leq 0$

$$
\begin{equation*}
\partial_{\alpha} A(\alpha, \tau) \geq c_{2} \alpha+\tau \tag{A.13}
\end{equation*}
$$

(A.12), together with (A.13) and $A(0, \tau)=0$ imply

$$
\begin{equation*}
A(\alpha, \tau) \leq \alpha \tau+\frac{c_{2}}{2} \alpha^{2} \tag{A.14}
\end{equation*}
$$

for all $\alpha \in \mathbb{R}$, from which the claim follows.
Lemma A.3. Let $\tau$ and $G$ as in (A.1) and (A.2). Moreover, let $c_{1}$ and $c_{2}$ be as in (A.3). Then $c_{2}^{-1} \leq G^{\prime \prime}(\tau) \leq c_{1}^{-1}$ for all $\tau \in \mathbb{R}$. Moreover, $c_{1} \leq \tau^{\prime}(\rho) \leq c_{2}$ for all $\rho \in \mathbb{R}$.
Proof. Let $\rho(\tau)$ be the expectation value of $r$ with respect to $\lambda_{\bar{p}, \tau}$. We have

\rho(\tau)=\int r \exp (\tau r-V(r)-G(\tau)) d r=G^{\prime}(\tau) \tag{A.15}
\end{equation*}

and so

G^{\prime \prime}(\tau)=\int r^{2} \exp (\tau r-V(r)-G(\tau)) d r-\int r G^{\prime}(\tau) \exp (\tau r-V(r)-G(\tau)) d r
$$

$$
\begin{gather*}
=\int r^{2} d \lambda_{\bar{p}, \tau}-\left(\int r d \lambda_{\bar{p}, \tau}\right)^{2}  \tag{A.16}\\
=\int\left(r^{2}-\rho(\tau)^{2}\right) d \lambda_{\bar{p}, \tau}  \tag{A.17}\\
=\int(r-\rho(\tau))^{2} d \lambda_{\bar{p}, \tau}+2 \rho \int(r-\rho(\tau)) d \lambda_{\bar{p}, \tau}  \tag{A.18}\\
=\int(r-\rho(\tau))^{2} d \lambda_{\bar{p}, \tau}>0 . \tag{A.19}
\end{gather*}
$$

Therefore $G$ is smooth and convex on $\mathbb{R}$, and so is its Legendre transform $F$. Then, integrating by parts yields

1=\int(r-\rho(\tau))\left(V^{\prime}(r)-\tau\right) d \lambda_{\bar{p}, \tau}  \tag{A.20}\\
=\int(r-\rho(\tau))\left(V^{\prime}(r)-V^{\prime}(\rho(\tau))\right) d \lambda_{\bar{p}, \tau}=\int(r-\rho(\tau))^{2} V^{\prime \prime}(\tilde{r}) d \lambda_{\bar{p}, \tau} \tag{A.21}
\end{gather*}
$$

where $\tilde{r}$ is between $r$ and $\rho(\tau)$. Recalling that $c_{1} \leq V^{\prime \prime}(r) \leq c_{2}$, this implies

$$
\begin{equation*}
c_{2}^{-1} \leq \int(r-\rho(\tau))^{2} d \lambda_{\bar{p}, \tau} \leq c_{1}^{-1} \tag{A.22}
\end{equation*}
$$

that is

$$
\begin{equation*}
c_{2}^{-1} \leq G^{\prime \prime}(\tau) \leq c_{1}^{-1} \tag{A.23}
\end{equation*}
$$

Finally, since $G$ is smooth, the supremum in (A.1) is attained when $G^{\prime}(\tau)=\rho$. But since we have proven that $G^{\prime}$ is invertible ( $G^{\prime \prime}$ is strictly positive), the equation $G^{\prime}(\tau)=\rho$ has exactly one solution for any $\rho \in \mathbb{R}$. We claim that this solution is precisely $\tau(\rho)$, as defined in (A.1). In fact, let $\rho \in \mathbb{R}$ and let $\tau=\tau(\rho)$ solve $G^{\prime}(\tau)=\rho$. We have

\tau^{\prime}(\rho)=\tau^{\prime}(\rho)=\frac{1}{G^{\prime \prime}(\tau)} \tag{A.26}
\end{equation*}

Therefore we have the desired bound on $\tau^{\prime}$ and the proof is complete.
Remark. Since there is a $1: 1$ correspondence between $\tau$ and $\rho$ via the equation $\rho=G^{\prime}(\tau)$, we can always express $\tau$ as a function of $\rho$ and viceversa. For this reason, we shall adopt the following notation. When writing a chain of equalities or inequalities, the object at the far left tells us which, between $\tau$ and $\rho$ is the independent variable. To be precise, the writing

stands for

f(\tau)=g\left(\tau, G^{\prime}(\tau)\right)

while

f(\rho)=g(\tau, \rho)

stands for

Corollary A.4. Let $\tau$ and $F$ be defined by (A.1). Moreover, let $c_{2}$ be as in (A.3). Then $\tau^{\prime}(\rho) \leq c_{2}$ for all $\rho \in \mathbb{R}$ and $\tau(\rho) / F(\rho) \rightarrow 0$ as $|\rho| \rightarrow \infty$.

Proof. $\tau^{\prime}$ is bounded from above thanks to (A.3). Since $\tau=F^{\prime}$, it is enough to show that $F(\rho)$ grows at least quadratically and $F^{\prime}(\rho)$ grows at most linearly in $\rho$. We consider $\rho \rightarrow \infty$, as $\rho \rightarrow-\infty$ will be analogous. Since $\tau=F^{\prime}$, we have $c_{1} \leq F^{\prime \prime}(\rho) \leq c_{2}$. Integrating this twice we obtain

F^{\prime}(0)+c_{1} \rho \leq F^{\prime}(\rho) \leq F^{\prime}(0)+c_{2} \rho . \tag{A.27}

and

F(0)+F^{\prime}(0) \rho+\frac{c_{1}}{2} \rho^{2} \leq F(\rho) \leq F(0)+F^{\prime}(0) \rho+\frac{c_{2}}{2} \rho^{2} . \tag{A.28}
\end{equation*}
$$

Therefore, since $c_{1}, c_{2}>0, F$ grows at least quadratically and $F^{\prime}$ at most linearly, and the conclusion follows.

Since we have shown that $\tau^{\prime}$ is bounded from below, the $L^{\infty}$ bounds in part $i i i$ ) of Proposition A. 1 follow from the following

Lemma A.5. Let $\tau$ be as in A.1. Then both $\tau^{\prime \prime}$ and $\tau^{\prime \prime \prime}$ are bounded.
Proof. First of all let us note that

& =3 \frac{\tau^{\prime \prime}(\rho)^{2}}{\tau^{\prime}(\rho)}-G^{(i v)}(\tau) \tau^{\prime}(\rho)^{4} . \tag{A.31}
\end{align*}
$$

Therefore it is enough to prove that $G^{\prime \prime \prime}$ and $G^{(i v)}$ are bounded. We have

G^{\prime \prime \prime}(\tau)=\frac{d}{d \tau} \int(r-\rho)^{2} d \lambda_{\bar{p}, \tau}  \tag{A.32}\\
=\int(r-\rho)^{2}\left(r-G^{\prime}(\tau)\right) d \lambda_{\bar{p}, \tau}-2 \rho^{\prime}(\tau) \int(r-\rho) d \lambda_{\bar{p}, \tau}  \tag{A.33}\\
=\int(r-\rho)^{3} d \lambda_{\bar{p}, \tau} \tag{A.34}
\end{gather*}
$$

and

$$
\begin{gather*}
G^{(i v)}(\tau)=\int(r-\rho)^{4} d \lambda_{\bar{p}, \tau}-3 \rho^{\prime}(\tau) \int(r-\rho)^{2} d \lambda_{\bar{p}, \tau}  \tag{A.35}\\
=\int(r-\rho)^{4} d \lambda_{\bar{p}, \tau}-3\left(\int(r-\rho)^{2} d \lambda_{\bar{p}, \tau}\right)^{2}  \tag{A.36}\\
=\int(r-\rho)^{4} d \lambda_{\bar{p}, \tau}-3 G^{\prime \prime}(\tau)^{2} \tag{A.37}
\end{gather*}
$$

Moreover, since

$$
\begin{equation*}
\int|r-\rho|^{3} d \lambda_{\bar{p}, \tau} \leq \frac{1}{2} \int(r-\rho)^{2} d \lambda_{\bar{p}, \tau}+\frac{1}{2} \int(r-\rho)^{4} d \lambda_{\bar{p}, \tau}, \tag{A.38}
\end{equation*}
$$

it is sufficient to show that $\int(r-\rho)^{4} d \lambda_{\bar{p}, \tau}$ is a bounded function of $\tau$. In order to do so, let $\delta \in \mathbb{R}$ be the point at which the function $r \mapsto \tau r-V(r)$ attains its maximum (note that $\delta$ will depend on $\tau$ ). Since $V$ is strictly convex, $\delta$ is the unique root of the equation $V^{\prime}(\delta)=\tau$. We claim that $\int(r-\rho)^{4} d \lambda_{\bar{p}, \tau}$ is bounded provided $\int(r-\delta)^{2} d \lambda_{\bar{p}, \tau}$ and $|\rho-\delta|$ are. In fact, from

and

\begin{equation*}
3 \int(r-\delta)^{2} d \lambda_{\bar{p}, \tau}=\int(r-\delta)^{3}\left(V^{\prime}(r)-\tau\right) d \lambda_{\bar{p}, \tau} \tag{A.40}
\end{equation*}
$$

$$
\begin{equation*}
=\int(r-\delta)^{3}\left(V^{\prime}(r)-V^{\prime}(\delta)\right) d \lambda_{\bar{p}, \tau}=\int V^{\prime \prime}(\tilde{r})(r-\delta)^{4} d \lambda_{\bar{p}, \tau} \geq c_{1} \int(r-\delta)^{4} d \lambda_{\bar{p}, \tau}, \tag{A.41}
\end{equation*}
$$

for some $\tilde{r}$ between $r$ and $\delta$, we obtain

$$
\begin{equation*}
\int(r-\rho)^{4} d \lambda_{\bar{p}, \tau} \leq \frac{24}{c_{1}} \int(r-\delta)^{2} d \lambda_{\bar{p}, \tau}+8(\rho-\delta)^{4} \tag{A.42}
\end{equation*}
$$

The boundedness of $\int(r-\delta)^{2} d \lambda_{\bar{p}, \tau}$ is in turn given by

\begin{equation*}
1=\int(r-\delta)\left(V^{\prime}(r)-\tau\right) d \lambda_{\bar{p}, \tau}=\int V^{\prime \prime}(\tilde{r})(r-\delta)^{2} d \lambda_{\bar{p}, \tau} \tag{A.43}
\end{equation*}
$$

Finally, a bound for $|\rho-\delta|$ follows from

\begin{gather*}
\int(r-\delta)^{2} d \lambda_{\bar{p}, \tau}=\int(r-\rho)^{2} d \lambda_{\bar{p}, \tau}+(\rho-\delta)^{2}+2(\rho-\delta) \int(r-\rho) d \lambda_{\bar{p}, \tau}  \tag{A.44}\\
=G^{\prime \prime}(\tau)+(\rho-\delta)^{2} . \tag{A.45}
\end{gather*}
$$

Let us now prove the $L^{2}$ bounds in part $i i i$ ) of Proposition A.1. By

\tau^{\prime \prime}(\rho)=-\tau^{\prime}(\rho)^{3} G^{\prime \prime \prime}(\tau)  \tag{A.46}\\
\tau^{\prime \prime \prime}(\rho)=\frac{3}{\tau^{\prime}(\rho)} \tau^{\prime \prime}(\rho)^{2}-\tau^{\prime}(\rho)^{4} G^{(i v)}(\tau), \tag{A.47}
\end{gather*}
$$

and the fact that $\tau^{\prime}$ is bounded away from zero, $\tau^{\prime \prime}$ is in $L^{2}$ if and only if $G^{\prime \prime \prime}(\tau)$ is. Moreover $\tau^{\prime \prime \prime}$ is in $L^{2}$ provided both $\left(\tau^{\prime \prime}\right)^{2}$ and $G^{(i v)}(\tau)$ are. But $\tau^{\prime \prime} \in L^{\infty} \cap L^{2}$ implies $\tau^{\prime \prime} \in L^{p}$ for all $p \geq 2$ : in particular $\tau^{\prime \prime} \in L^{4}$, and so $\left(\tau^{\prime \prime}\right)^{2} \in L^{2}$ Finally, via the substitution $\tau=\tau(\rho)$ (or, equivalently, $\left.\rho=G^{\prime}(\tau)\right)$, for $f \in\left\{G^{\prime \prime \prime}, G^{(i v)}\right\}$ we have

Therefore using once more the boundedness from below of $\tau^{\prime}$, the $L^{2}$ bounds in part $i i i$ ) of Proposition A. 1 follow from the next lemma.
Lemma A.6. Let $G$ be defined by A.2. Then both $G^{\prime \prime \prime}$ and $G^{(i v)}$ are in $L^{2}(\mathbb{R})$.
Proof. We observe that, since $G^{\prime \prime \prime}$ and $G^{(i v)}$ are bounded, it is enough to prove that they vanish quickly enough at infinity. We shall prove that they indeed vanish and the decay rate is exponential. Since

G^{\prime \prime \prime}(\tau)=\int(r-\rho)^{3} d \lambda_{\bar{p}, \tau} \tag{A.49}
\end{equation*}
$$

and

$$
\begin{equation*}
G^{(i v)}(\tau)=\int(r-\rho)^{4} d \lambda_{\bar{p}, \tau}-3\left(\int(r-\rho)^{2} d \lambda_{\bar{p}, \tau}\right)^{2} \tag{A.50}
\end{equation*}
$$

we need to estimate the quantities

$$
\begin{equation*}
\int(r-\rho)^{m} d \lambda_{\bar{p}, \tau}=\int_{-\infty}^{\infty}(r-\rho)^{m} \exp (\tau r-V(r)-G(\tau)) d r \tag{A.51}
\end{equation*}
$$

for integers $2 \leq m \leq 4$, as well as

$$
\begin{equation*}
\rho=\int r d \lambda_{\bar{p}, \tau}=\int_{-\infty}^{\infty} r \exp (\tau r-V(r)-G(\tau)) d r, \tag{A.52}
\end{equation*}
$$

as $|\tau| \rightarrow \infty$. We will deal with $\tau \rightarrow \infty$, as the case $\tau \rightarrow-\infty$ is analogous. Recalling that $\delta$ is such that $\tau=V^{\prime}(\delta)$, we can write

\exp (\tau r-V(r)-G(\tau))=\exp \left(\tau \delta-V(\delta)-G(\tau)-\frac{V^{\prime \prime}(\tilde{r})}{2}(r-\delta)^{2}\right) \tag{A.53}

for some $\tilde{r}$ between $r$ and $\delta$. Also, integrating $c_{1} \leq V^{\prime \prime}(r) \leq c_{2}$ between 0 and $\delta$ gives

and so $\delta \rightarrow \infty$ as $\tau \rightarrow \infty$.
Next, we show the following:

\left|\int_{-\infty}^{\infty}(r-\delta)^{m} \exp \left(-\frac{V^{\prime \prime}(\tilde{r})}{2}(r-\delta)^{2}\right) d r-\int_{-\infty}^{\infty} r^{m} \exp \left(-\frac{V_{+}^{\prime \prime}}{2} r^{2}\right) d r\right| \leq e^{-\tilde{\alpha} \tau} \tag{A.55}
\end{equation*}
$$

for integers $0 \leq m \leq 4$, some $0<\tilde{\alpha} \leq \alpha$ and $\tau$ large enough. The constant $V_{+}^{\prime \prime}$ is defined in (A.4). Let $a \in(0, \tau)$ be a multiple of $\tau$. We divide the domain of integration as follows: $(-\infty, \infty)=(-\infty, \delta-a) \cup(\delta-a, \delta+a) \cup(\delta+a, \infty)$. The integrals over the unbounded domains vanish exponentially fast as $\tau \rightarrow \infty$. In fact, since there exists $0<\gamma<c_{1}$ such that, for $\tau$ large enough,

|r-\delta|^{m} \exp \left(-\frac{V^{\prime \prime}(\tilde{r})}{2}(r-\delta)^{2}\right) \leq \exp \left(-\frac{\gamma}{2}(r-\delta)^{2}\right) \tag{A.56}

we have

\begin{align*}
& \int_{\delta+a}^{\infty}|r-\delta|^{m} \exp \left(-\frac{V^{\prime \prime}(\tilde{r})}{2}(r-\delta)^{2}\right) d r \leq \int_{\delta+a}^{\infty} \exp \left(-\frac{\gamma}{2}(r-\delta)^{2}\right) d r  \tag{A.57}\\
& \quad=\int_{0}^{\infty} \exp \left(-\frac{\gamma}{2}(r+a)^{2}\right) d r \leq \exp \left(-\frac{\gamma}{2} a^{2}\right) \int_{0}^{\infty} \exp \left(-\frac{\gamma}{2} r^{2}\right) d r \tag{A.58}
\end{align*}
$$

which vanishes exponentially fast since $a$ is a multiple of $\tau$. The case of $(-\infty, \delta-a)$ is analogous. From similar calculations we obtain also that

\int_{-\infty}^{\infty} r^{m} \exp \left(-\frac{V_{+}^{\prime \prime}}{2} r^{2}\right) d r=\int_{-\infty}^{\infty}(r-\delta)^{m} \exp \left(-\frac{V_{+}^{\prime \prime}}{2}(r-\delta)^{2}\right) d r  \tag{A.59}\\
=\int_{\delta-a}^{\delta+a}(r-\delta)^{m} \exp \left(-\frac{V_{+}^{\prime \prime}}{2}(r-\delta)^{2}\right) d r+R(\tau), \tag{A.60}
\end{gather*}
$$

with $R(\tau)$ vanishing exponentially fast in $\tau$. Therefore (A.55) follows provided

$$
\begin{equation*}
\left|\int_{\delta-a}^{\delta+a}(r-\delta)^{m}\left(\exp \left(-\frac{V^{\prime \prime}(\tilde{r})}{2}(r-\delta)^{2}\right)-\exp \left(-\frac{V_{+}^{\prime \prime}}{2}(r-\delta)^{2}\right)\right) d r\right| \leq e^{-\tilde{\alpha} \tau} \tag{A.61}
\end{equation*}
$$

Recall that $\tilde{r}$ is between $r$ and $\delta$, and therefore is in $(\delta-a, \delta+a)$. Recall also that $\delta \rightarrow \infty$ as $\tau \rightarrow \infty$. Moreover, $\delta-a$ goes to $\infty$ as well, provided $a<c_{2}^{-1} \tau$. For such a choice of $a, \tilde{r}$ goes to $\infty$ as $\tau \rightarrow \infty$ and so, thanks to (A.4), for $\tau$ large enough we have

\left|\int_{\delta-a}^{\delta+a}(r-\delta)^{m} \exp \left(-\frac{V^{\prime \prime}(\tilde{r})}{2}(r-\delta)^{2}\right) d r-\int_{\delta-a}^{\delta+a}(r-\delta)^{m} \exp \left(-\frac{V_{+}^{\prime \prime}}{2}(r-\delta)^{2}\right) d r\right| \\
\leq \int_{\delta-a}^{\delta+a}|r-\delta|^{m} \exp \left(-\frac{V_{+}^{\prime \prime}}{2}(r-\delta)^{2}\right)\left|\exp \left(-\frac{1}{2}\left(V^{\prime \prime}(\tilde{r})-V_{+}^{\prime \prime}\right)(r-\delta)^{2}\right)-1\right| d r  \tag{A.63}\\
\leq 2 a^{m} e^{-\tilde{\alpha} \tau} \int_{\delta-a}^{\delta+a} \exp \left(-\frac{V_{+}^{\prime \prime}}{2}(r-\delta)^{2}\right) d r \tag{A.64}
\end{gather*}
$$

$$
\begin{equation*}
\leq 2 \sqrt{\frac{2 \pi}{V_{+}^{\prime \prime}}} a^{m} e^{-\tilde{\alpha} \tau} \leq e^{-\tilde{\alpha} \tau} \tag{A.65}
\end{equation*}
$$

for $\tau$ large enough and a possibly different choice of $\tilde{\alpha}$. This proves (A.55).
We have now all we need to prove the actual lemma.

1=\int_{-\infty}^{\infty} \exp (\tau r-V(r)-G(\tau)) d r  \tag{A.66}\\
=\int_{-\infty}^{\infty} \exp \left(\tau \delta-V(\delta)-G(\tau)-\frac{V^{\prime \prime}(\tilde{r})}{2}(r-\delta)^{2}\right) d r \tag{A.67}
\end{gather*}
$$

implies

$$
\begin{equation*}
\exp (G(\tau)-\tau \delta+V(\delta))=\int_{-\infty}^{\infty} \exp \left(-\frac{V^{\prime \prime}(\tilde{r})}{2}(r-\delta)^{2}\right) d r \tag{A.68}
\end{equation*}
$$

and the left hand side is bounded away from zero, as the right hand side is. In particular, $\exp (\tau \delta-V(\delta)-G(\tau))$ is bounded.

Next, we show that $\rho-\delta \rightarrow 0$ exponentially fast. We write

& \rho-\delta=\int_{-\infty}^{\infty}(r-\delta) \exp \left(\tau \delta-V(\delta)-G(\tau)-\frac{V^{\prime \prime}(\tilde{r})}{2}(r-\delta)^{2}\right) d r  \tag{A.69}\\
& =\exp (\tau \delta-V(\delta)-G(\tau)) \int_{-\infty}^{\infty}(r-\delta) \exp \left(-\frac{V^{\prime \prime}(\tilde{r})}{2}(r-\delta)^{2}\right) d r \tag{A.70}
\end{align*}
$$

which converges to zero exponentially fast, as $\exp (\tau \delta-V(\delta)-G(\tau))$ is bounded and the integral converges to

$$
\begin{equation*}
\int_{-\infty}^{\infty} r \exp \left(-\frac{V_{+}^{\prime \prime}}{2} r^{2}\right) d r=0 \tag{A.71}
\end{equation*}
$$

exponentially fast. Next, we write

$$
\begin{gather*}
G^{\prime \prime}(\tau)=\int(r-\rho)^{2} d \lambda_{\bar{p}, \tau}=\int\left(r^{2}-\rho^{2}\right) d \lambda_{\bar{p}, \tau}  \tag{A.72}\\
=\int_{-\infty}^{\infty}(r-\delta)^{2} \exp \left(\tau \delta-V(\delta)-G(\tau)-\frac{V^{\prime \prime}(\tilde{r})}{2}(r-\delta)^{2}\right) d r-(\rho-\delta)^{2} \tag{A.73}
\end{gather*}
$$

The term $(\rho-\delta)^{2}$ goes to zero, while the integral, and so $G^{\prime \prime}(\tau)$, converges to

$$
\begin{equation*}
\sqrt{\frac{V_{+}^{\prime \prime}}{2 \pi}} \int_{-\infty}^{\infty} r^{2} \exp \left(-\frac{V_{+}^{\prime \prime}}{2} r^{2}\right) d r=\frac{1}{V_{+}^{\prime \prime}} \tag{A.74}
\end{equation*}
$$

exponentially fast. $G^{\prime \prime \prime}(\tau)$ goes to zero exponentially fast. In fact from

$$
\begin{equation*}
(r-\rho)^{3}=(r-\delta)^{3}+(\delta-\rho)\left((r-\rho)^{2}+(r-\rho)(r-\delta)+(r-\delta)^{2}\right) \tag{A.75}
\end{equation*}
$$

and after integration, the first term vanishes, in the limit, by symmetry. Moreover, all the other terms vanish, after integration, as they are bounded terms multiplied by $\delta-\rho$.

Finally $G^{(i v)}$ vanishes exponentially fast as well. This time, though, we have the difference of two non-vanishing terms, so we do need to pay some extra attention. The quadratic term $-3 G^{\prime \prime}(\tau)^{2}$ converges to $-3 /\left(V_{+}^{\prime \prime}\right)^{2}$. On the other hand, the quartic term decomposes as

(r-\rho)^{4}=(r-\delta)^{4}+(\delta-\rho)(2 r-\rho-\delta)\left((r-\rho)^{2}+(r-\delta)^{2}\right)  \tag{A.76}\\
=(r-\delta)^{4}+(\delta-\rho)\left(2(r-\rho)^{3}+2(r-\delta)^{3}+(\rho-\delta)(r-\rho)^{2}+(\delta-\rho)(r-\delta)^{2}\right) . \tag{A.77}
\end{gather*}
$$

Again, all the terms that multiply $\delta-\rho$ are, after integration, bounded, and therefore the only term which survives is $(r-\delta)^{4}$, whose integral converges to

\begin{equation*}
\sqrt{\frac{V_{+}^{\prime \prime}}{2 \pi}} \int_{-\infty}^{\infty} r^{4} \exp \left(-\frac{V_{+}^{\prime \prime}}{2} r^{2}\right) d r=\frac{3}{\left(V_{+}^{\prime \prime}\right)^{2}} \tag{A.78}
\end{equation*}
$$

Putting everything together we obtain that $G^{(i v)}(\tau)$ converges exponentially fast to zero, and the proof is complete.

We now deal with the question of genuine nonlinearity. First of all we make the following remark. Remark. Suppose $V(r)=r^{2} / 2+\theta U(r)$. Then, if $U$ is an even function, the function $\tau^{\prime \prime}$ vanishes at the origin for all $\theta \in \mathbb{R}$. In particular we can never have genuine nonlinearity.

In order to see this, it is enough to show that $F$ is even: in fact in this case its third derivative, $\tau^{\prime \prime}$, is odd and so $\tau^{\prime \prime}(0)=0 . F$ is indeed even:

$$
\begin{equation*}
F(-\rho)=\sup _{\tau \in \mathbb{R}}\{-\tau \rho-G(\tau)\}=\sup _{\tau \in \mathbb{R}}\{\tau \rho-G(-\tau)\}=F(\rho), \tag{A.79}
\end{equation*}
$$

since

\begin{align*}
& G(-\tau)=\log \int_{-\infty}^{\infty} \exp (-\tau r-V(r)) d r  \tag{A.80}\\
& =\log \int_{-\infty}^{\infty} \exp (\tau r-V(-r)) d r=G(\tau) . \tag{A.81}
\end{align*}
$$

Thanks to the remark, in order to have genuine nonlinearity we must look among non-symmetric interaction. Nevertheless, apart from that, it is not known to us which features a potential must possess in order to ensure $\tau^{\prime \prime} \neq 0$. Therefore, we shall only give one family of examples which work.
Proposition A.7. Suppose we can write

where $\theta \in \mathbb{R}$ and $U(r)$ is a smooth and convex mollification of the function $\kappa r \max \{r, 0\} / 2-\kappa r^{2} / 2$, for some $0<\kappa<1 / 2$. Then there exist $\theta_{\kappa}>0$, depending on $\kappa$, such that, for $0<|\theta|<\theta_{\kappa}, \tau$ is either strictly convex or strictly concave, meaning that either $\tau^{\prime \prime}(\rho)>0$ or $\tau^{\prime \prime}(\rho)<0$ for all $\rho \in \mathbb{R}$.

Proof. Since

$$
\begin{equation*}
\tau^{\prime \prime}(\rho)=-\tau^{\prime}(\rho) G^{\prime \prime \prime}(\tau) \tag{A.83}
\end{equation*}
$$

with $\tau^{\prime}>0$, the sign of $\tau^{\prime \prime}$ is the same as the sign of $-G^{\prime \prime \prime}$. Therefore we need to study

$$
\begin{equation*}
-G^{\prime \prime \prime}(\tau)=-\int(r-\rho)^{3} d \lambda_{\bar{p}, \tau}, \tag{A.84}
\end{equation*}
$$

with $\tau \in \mathbb{R}$. Let $|r|_{+}=\max \{r, 0\}$. In order to make things slightly less technical, we use directly $U(r)=\kappa r|r|_{+} / 2-\kappa r^{2} / 2$ instead of its smooth mollification (note that $U$ is already everywhere differentiable and the mollification only adds the existence of $U^{\prime \prime}$ at the origin). Write

V(r)=\frac{r^{2}}{2}+\theta\left(\frac{\kappa}{2} r|r|_{+}-\frac{\kappa}{2} r^{2}\right)=\frac{a}{2} r^{2}+\theta W(r) \tag{A.85}
\end{equation*}

where $a=1-\theta \kappa$ and $W(r)=\kappa r|r|_{+} / 2$. Then we notice that, by the usual integration by parts trick, we have

\int(r-\rho)^{2}\left(V^{\prime}(r)-\tau\right) d \lambda_{\bar{p}, \tau}=2 \int(r-\rho) d \lambda_{\bar{p}, \tau}=0 \tag{A.86}

a \int(r-\rho)^{3} d \lambda_{\bar{p}, \tau}=\int(r-\rho)^{2}\left(a r-a \rho-V^{\prime}(r)+\tau\right) d \lambda_{\bar{p}, \tau}  \tag{A.87}\\
=\int(r-\rho)^{2}\left(\tau-a \rho-\theta W^{\prime}(r)\right) d \lambda_{\bar{p}, \tau}, \tag{A.88}
\end{gather*}
$$

from which, together with $W^{\prime}(r)=\kappa|r|_{+}$, it follows

$$
\begin{gather*}
-a G^{\prime \prime \prime}(\tau)=\theta \int(r-\rho)^{2} W^{\prime}(r) d \lambda_{\bar{p}, \tau}-(\tau-a \rho) G^{\prime \prime}(\tau)  \tag{A.89}\\
=\theta \kappa \int|r|_{+}(r-\rho)^{2} d \lambda_{\bar{p}, \tau}+(a \rho-\tau) G^{\prime \prime}(\tau) \tag{A.90}
\end{gather*}
$$

We evaluate

$$
\begin{gather*}
\int|r|_{+}(r-\rho)^{2} d \lambda_{\bar{p}, \tau}=e^{-G(\tau)} \int_{0}^{\infty} r(r-\rho)^{2} e^{\tau r-\frac{r^{2}}{2}} d r=  \tag{A.91}\\
=e^{-G(\tau)} \int_{0}^{\infty} r^{3} e^{\tau r-\frac{r^{2}}{2}} d r-2 \rho e^{-G(\tau)} \int_{0}^{\infty} r^{2} e^{\tau r-\frac{r^{2}}{2}} d r+\rho^{2} e^{-G(\tau)} \int_{0}^{\infty} r e^{\tau r-\frac{r^{2}}{2}} d r . \tag{A.92}
\end{gather*}
$$

Now, for $m \in \mathbb{N}, m \geq 1$,

$$
\begin{equation*}
\int_{0}^{\infty} r^{m} e^{\tau r-\frac{r^{2}}{2}} d r=\frac{d}{d \tau} \int_{0}^{\infty} r^{m-1} e^{\tau r-\frac{r^{2}}{2}} d r \tag{A.93}
\end{equation*}
$$

with

$$
\begin{equation*}
\int_{0}^{\infty} e^{\tau r-\frac{r^{2}}{2}} d r=e^{\frac{\tau^{2}}{2}} \int_{-\tau}^{\infty} e^{-\frac{r^{2}}{2}} d r . \tag{A.94}
\end{equation*}
$$

Therefore, setting $\Phi(\tau):=\int_{-\tau}^{\infty} e^{-\frac{r^{2}}{2}} d r$ and noting that $\Phi^{\prime}(\tau)=e^{-\frac{\tau^{2}}{2}}$ yields

$$
\begin{gather*}
\int_{0}^{\infty} r e^{\tau r-\frac{r^{2}}{2}} d r=\frac{d}{d \tau}\left(e^{\frac{\tau^{2}}{2}} \Phi(\tau)\right)=\tau e^{\frac{\tau^{2}}{2}} \Phi(\tau)+1,  \tag{A.95}\\
\int_{0}^{\infty} r^{2} e^{\tau r-\frac{r^{2}}{2}} d r=\frac{d}{d \tau} \int_{0}^{\infty} r e^{\tau r-\frac{r^{2}}{2}} d r=\tau^{2} e^{\frac{\tau^{2}}{2}} \Phi(\tau)+e^{\frac{\tau^{2}}{2}} \Phi(\tau)+\tau  \tag{A.96}\\
\int_{0}^{\infty} r^{3} e^{\tau r-\frac{r^{2}}{2}} d r=\frac{d}{d \tau} \int_{0}^{\infty} r^{2} e^{\tau r-\frac{r^{2}}{2}} d r  \tag{A.97}\\
=\tau e^{\frac{\tau^{2}}{2}} \Phi(\tau)+1+2 \tau e^{\frac{\tau^{2}}{2}} \Phi(\tau)+\tau^{3} e^{\frac{\tau^{2}}{2}} \Phi(\tau)+\tau^{2}+1  \tag{A.98}\\
=\tau^{3} e^{\frac{\tau^{2}}{2}} \Phi(\tau)+3 \tau e^{\frac{\tau^{2}}{2}} \Phi(\tau)+\tau^{2}+2 . \tag{A.99}
\end{gather*}
$$

Putting everything together we obtain

$$
\begin{gather*}
e^{G(\tau)} \int|r|+(r-\rho)^{2} d \lambda_{\bar{p}, \tau}=\tau^{3} e^{\frac{\tau^{2}}{2}} \Phi(\tau)+3 \tau e^{\frac{\tau^{2}}{2}} \Phi(\tau)+2+  \tag{A.100}\\
\quad-2 \rho\left(\tau^{2} e^{\frac{\tau^{2}}{2}} \Phi(\tau)+e^{\frac{\tau^{2}}{2}} \Phi(\tau)+\tau\right)+\rho^{2}\left(\tau e^{\frac{\tau^{2}}{2}} \Phi(\tau)+1\right)  \tag{A.101}\\
=\left(2+\tau^{2}-2 \rho \tau+\rho^{2}\right)+\left(\tau^{3}-2 \rho \tau^{2}+\left(3+\rho^{2}\right) \tau-2 \rho\right) e^{\frac{\tau^{2}}{2}} \Phi(\tau)  \tag{A.102}\\
\quad=\left(2+(\tau-\rho)^{2}\right)+\left(3 \tau-2 \rho+\tau(\tau-\rho)^{2}\right) e^{\frac{\tau^{2}}{2}} \Phi(\tau) . \tag{A.103}
\end{gather*}
$$

Next, we have to evaluate the term proportional to $G^{\prime \prime}(\tau)$ in (A.90), which can be written as follows

& a \rho-\tau=a \rho-\int V^{\prime}(r) d \lambda_{\bar{p}, \tau}  \tag{A.104}\\
& =a \rho-\int\left(a r+\theta W^{\prime}(r)\right) d \lambda_{\bar{p}, \tau}  \tag{A.105}\\
& =-\theta \int W^{\prime}(r) d \lambda_{\bar{p}, \tau}  \tag{A.106}\\
& =-\theta \kappa e^{-G(\tau)} \int_{0}^{\infty} r e^{\tau r-\frac{r^{2}}{2}} d r  \tag{A.107}\\
& =-\theta \kappa e^{-G(\tau)}\left(1+\tau e^{\frac{\tau^{2}}{2}} \Phi(\tau)\right) . \tag{A.108}
\end{align*}
$$

We discuss the case $\theta>0$, which will give $\tau^{\prime \prime}>0$. The case $\theta<0$ is analogous and gives $\tau^{\prime \prime}<0$. Note that $1+\tau e^{\frac{\tau^{2}}{2}} \Phi(\tau)>0$ for $\tau \geq 0$. On the other hand, for $\tau<0$,

\int_{-\tau}^{\infty} e^{-\frac{r^{2}}{2}} d r<\frac{e^{-\frac{\tau^{2}}{2}}}{-\tau} \tag{A.109}
\end{equation*}
$$

which implies

\tau \Phi(\tau)>-e^{-\frac{\tau^{2}}{2}} \tag{A.110}
\end{equation*}
$$

Therefore we have $1+\tau e^{\frac{\tau^{2}}{2}} \Phi(\tau)>0$ also for $\tau<0$ and, as a consequence

\tau>a \rho=(1-\theta \kappa) \rho, \quad \forall \tau \in \mathbb{R} \tag{A.111}
\end{equation*}
$$

Putting everything together we obtain

\begin{align*}
& -\frac{a e^{G(\tau)}}{\theta \kappa} G^{\prime \prime \prime}(\tau)=\left(2-G^{\prime \prime}(\tau)+(\tau-\rho)^{2}\right)+  \tag{A.112}\\
& +\left(\tau\left(3-G^{\prime \prime}(\tau)\right)-2 \rho+\tau(\tau-\rho)^{2}\right) e^{\frac{\tau^{2}}{2}} \Phi(\tau)
\end{align*}
$$

Since

$$
V^{\prime \prime}(r)=\left\{\begin{array}{l}
1, \quad r>0  \tag{A.113}\\
1-\theta \kappa, \quad r<0
\end{array}\right.
$$

in order to have $V^{\prime \prime}>0$ we need $\theta<1 / \kappa$, and, since $0<k<1 / 2$, we are allowed to fix $\theta<1$. Under this assumption we have $a=1-\theta \kappa>0$ and

$$
\begin{equation*}
1 \leq G^{\prime \prime}(\tau) \leq \frac{1}{1-\theta \kappa}<2 \tag{A.114}
\end{equation*}
$$

We show that $-G^{\prime \prime \prime}$ (and therefore $\tau^{\prime \prime}$ ) is positive fo $\tau \leq 0$. Using $1 \leq G^{\prime \prime}(\tau)<2$ yields

\begin{equation*}
-\frac{a e^{G(\tau)}}{\theta \kappa} G^{\prime \prime \prime}(\tau)>\left(2 \tau-2 \rho+\tau(\tau-\rho)^{2}\right) e^{\frac{\tau^{2}}{2}} \Phi(\tau) \tag{A.115}
\end{equation*}
$$

Moreover, using $\tau>(1-\theta \kappa) \rho$ and $\tau \Phi(\tau)>-e^{-\frac{\tau^{2}}{2}}$ gives

\begin{align*}
-\frac{a e^{G(\tau)}}{\theta \kappa} G^{\prime \prime \prime}(\tau) & >-\frac{2 \theta \kappa}{1-\theta \kappa} \tau e^{\frac{\tau^{2}}{2}} \Phi(\tau)+(\tau-\rho)^{2} \tau e^{\frac{\tau^{2}}{2}} \Phi(\tau)  \tag{A.116}\\
& >-\frac{2 \theta \kappa}{1-\theta \kappa} \tau e^{\frac{\tau^{2}}{2}} \Phi(\tau) \geq 0 . \tag{A.117}
\end{align*}
$$

Therefore $\tau^{\prime \prime}(\rho)>0$ if $\tau \leq 0$ and $0<\theta<1$.
For $\tau>0$ we have to be more careful. First of all we note that

\begin{equation*}
a \rho-\tau=-\theta \kappa e^{-G(\tau)}\left(1+\tau e^{\frac{\tau^{2}}{2}} \Phi(\tau)\right) \tag{A.118}
\end{equation*}
$$

implies

$$
\begin{equation*}
\tau-\rho=\frac{\theta \kappa}{1-\theta \kappa} e^{-G(\tau)}\left(\tau\left(e^{\frac{\tau^{2}}{2}} \Phi(\tau)-e^{G(\tau)}\right)+1\right) . \tag{A.119}
\end{equation*}
$$

This, together with

$$
\begin{gather*}
e^{G(\tau)}=\int_{-\infty}^{\infty} e^{\tau r-V(r)} d r  \tag{A.120}\\
=\int_{0}^{\infty} e^{\tau r-\frac{r^{2}}{2}} d r+\int_{-\infty}^{0} e^{\tau r-\frac{1-\theta \kappa}{2} r^{2}} d r  \tag{A.121}\\
=e^{\frac{\tau^{2}}{2}} \Phi(\tau)+\frac{1}{\sqrt{1-\theta \kappa}} e^{\frac{\tau^{2}}{2(1-\theta \kappa)}} \Phi\left(-\frac{\tau}{\sqrt{1-\theta \kappa}}\right) \tag{A.122}
\end{gather*}
$$

and $\tau>0$ gives

$$
\begin{align*}
\tau-\rho= & \frac{\theta \kappa}{1-\theta \kappa} e^{-G(\tau)}\left(1+\frac{-\tau}{\sqrt{1-\theta \kappa}} e^{\frac{\tau^{2}}{2(1-\theta \kappa)} \Phi} \Phi\left(-\frac{\tau}{\sqrt{1-\theta \kappa}}\right)\right)  \tag{A.123}\\
& >e^{-G(\tau)} \frac{\theta \kappa}{1-\theta \kappa}\left(1-e^{\frac{\tau^{2}}{2(1-\theta \kappa)}} e^{-\frac{\tau^{2}}{2(1-\theta \kappa)}}\right)=0 . \tag{A.124}
\end{align*}
$$

Therefore $\tau-\rho>0$ if $\tau>0$ (note here that $\tau-\rho$ is trivially positive for $\tau \leq 0$, too). From this we get

-\frac{a e^{G(\tau)}}{\theta \kappa} G^{\prime \prime \prime}(\tau)=\left(2-G^{\prime \prime}(\tau)+(\tau-\rho)^{2}\right)+\left(\tau\left(1-G^{\prime \prime}(\tau)\right)+2(\tau-\rho)+\right.  \tag{A.125}\\
\left.\quad+\tau(\tau-\rho)^{2}\right) e^{\frac{\tau^{2}}{2}} \Phi(\tau) \\
>\left(2-G^{\prime \prime}(\tau)\right)+\left(1-G^{\prime \prime}(\tau)\right) \tau e^{\frac{\tau^{2}}{2}} \Phi(\tau) . \tag{A.126}
\end{gather*}
$$

$2-G^{\prime \prime}(\tau)$ is positive, while $1-G^{\prime \prime}(\tau)$ is negative, so we need to perform a careful estimate. First of all, the estimate $G^{\prime \prime}(\tau)<2$ is too blunt, and will be replaced by $G^{\prime \prime}(\tau) \leq 1 /(1-\theta \kappa)$, so that

which is positive, since $\theta \kappa<1 / 2$. In order to estimate $1-G^{\prime \prime}(\tau)$ we calculate

=1+\rho(\tau-a \rho)-\theta \kappa e^{-G(\tau)} e^{\frac{\tau^{2}}{2}} \Phi(\tau)-\tau(\tau-a \rho)  \tag{A.129}\\
=1-(\tau-a \rho)(\tau-\rho)-\theta \kappa e^{-G(\tau)} e^{\frac{\tau^{2}}{2}} \Phi(\tau) . \tag{A.130}
\end{gather*}
$$

Therefore

$$
\begin{align*}
1-G^{\prime \prime}(\tau) & =1-\frac{1}{a}+\frac{1}{a}(\tau-a \rho)(\tau-\rho)+\frac{\theta \kappa}{a} e^{-G(\tau)} e^{\frac{\tau^{2}}{2}} \Phi(\tau)  \tag{A.131}\\
& >-\frac{\theta \kappa}{1-\theta \kappa}+\frac{\theta \kappa}{1-\theta \kappa} e^{-G(\tau)} e^{\frac{\tau^{2}}{2}} \Phi(\tau), \tag{A.132}
\end{align*}
$$

which implies

$$
\begin{align*}
& \left(1-G^{\prime \prime}(\tau)\right) \tau e^{\frac{\tau^{2}}{2}} \Phi(\tau)>\frac{\theta \kappa}{1-\theta \kappa} \frac{e^{\frac{\tau^{2}}{2}} \Phi(\tau)}{e^{G(\tau)}} \tau\left(e^{\frac{\tau^{2}}{2}} \Phi(\tau)-e^{G(\tau)}\right)  \tag{A.133}\\
& =\frac{\theta \kappa}{1-\theta \kappa} \frac{e^{\frac{\tau^{2}}{2}} \Phi(\tau)}{e^{G(\tau)}} \frac{-\tau}{\sqrt{1-\theta \kappa}} e^{\frac{\tau^{2}}{2(1-\theta \kappa)}} \Phi\left(-\frac{\tau}{\sqrt{1-\theta \kappa}}\right)  \tag{A.134}\\
& >-\frac{\theta \kappa}{1-\theta \kappa} \frac{e^{\frac{\tau^{2}}{2}} \Phi(\tau)}{e^{G(\tau)}}>-\frac{\theta \kappa}{1-\theta \kappa}, \tag{A.135}
\end{align*}
$$

since $e^{\frac{\tau^{2}}{2}} \Phi(\tau)<e^{G(\tau)}$. Putting everything together we obtain

\begin{equation*}
-\frac{a e^{G(\tau)}}{\theta \kappa} G^{\prime \prime \prime}(\tau)>1-\frac{2 \theta \kappa}{1-\theta \kappa}, \tag{A.136}
\end{equation*}
$$

and the right hand side is positive provided $\theta$ is small enough (say $\theta<1 / 2$ ).

## B On the viscous approximation

If in the dynamics (2.11) we choose $\sigma_{N}=N \delta$, for fixed $\bar{\delta}=\left(\delta_{1}, \delta_{2}\right), \delta_{j}>0, j=1,2$, the macroscopic equation will be given by the diffusive system:

$$
\left\{\begin{array}{l}
\partial_{t} r(t, x)-\partial_{x} p(t, x)=\delta_{1} \partial_{x x} \tau(\beta, r(t, x))  \tag{B.1}\\
\partial_{t} p(t, x)-\partial_{x} \tau(\beta, r(t, x))=\delta_{2} \partial_{x x} p(t, x),
\end{array}\right.
$$

with the boundary conditions:

$$
p(t, 0)=0, \quad \tau(r(t, 1))=\bar{\tau}(t), \quad \partial_{x} p(t, 1)=0, \quad \partial_{x} r(t, 0)=0,
$$

This system has a strong unique solution.

The derivative of the total length is given by

$$
\begin{equation*}
\frac{d}{d t} L(t)=\frac{d}{d t} \int_{0}^{1} r(t, x) d x=p(t, 1)+\left.\delta_{1} \partial_{x} \tau(\beta, r(t, x))\right|_{x=1} \tag{B.2}
\end{equation*}
$$

and the macroscopic work up to time $t$ is given by

$$
\begin{equation*}
W(t)=\int_{0}^{t} \bar{\tau}(s) d L(s)=\int_{0}^{t} \bar{\tau}(s)\left(p(s, 1)+\left.\delta_{1} \partial_{x} \tau(\beta, r(t, x))\right|_{x=1}\right) d s \tag{B.3}
\end{equation*}
$$

Then a direct calculation of the free energy time change gives:

$$
\begin{equation*}
\mathcal{F}(t)-\mathcal{F}(0)=W(t)-\int_{0}^{t} d s \int_{0}^{1}\left[\delta_{1}\left(\partial_{x} \tau(\beta, r(s, x))\right)^{2}+\delta_{2}\left(\partial_{x} p(s, x)\right)^{2}\right] \tag{B.4}
\end{equation*}
$$

Letting $t \rightarrow \infty$, this gives the Clausius relation

$$
\begin{equation*}
F\left(\beta, \tau_{1}\right)-F\left(\beta, \tau_{0}\right)=W-\int_{0}^{\infty} d t \int_{0}^{1}\left[\delta_{1}\left(\partial_{x} \tau(\beta, r(t, x))\right)^{2}+\delta_{2}\left(\partial_{x} p(t, x)\right)^{2}\right] \leq W \tag{B.5}
\end{equation*}
$$

Let $r^{\bar{\delta}}(t, x), p^{\bar{\delta}}(t, x)$ the solution of (B.1). We cannot prove the uniqueness of the limit an $\bar{\delta} \rightarrow 0$, but any limit point should satisfy the Clausius inequality

$$
\begin{equation*}
\mathcal{F}(t)-\mathcal{F}(0) \leq W(t) \tag{B.6}
\end{equation*}
$$

where $W(t)$ is defined as the limit of (B.3).
Any limit point $r(t, x), p(t, x)$ with the corresponding boundary layers are natural candidates for being the entropy solution of the equation (B.1) and one can conjecture that such limit is unique.
