# A NEW PRESENTATION OF THE PLANE CREMONA GROUP 

CHRISTIAN URECH AND SUSANNA ZIMMERMANN


#### Abstract

We give a presentation of the plane Cremona group over an algebraically closed field with respect to the generators given by the Theorem of Noether and Castelnuovo. This presentation is particularly simple and can be used for explicit calculations.


## 1. Introduction

1.1. Main result. Let $\mathbf{k}$ be an algebraically closed field. The plane Cremona group $\operatorname{Bir}\left(\mathbb{P}^{2}\right)$ is the group of birational transformations of the projective plane $\mathbb{P}^{2}=\mathbb{P}_{\mathbf{k}}^{2}$. It was intensely studied by classical algebraic geometers and has attracted again considerable attention in the last decades.

If we fix homogeneous coordinates $[x: y: z]$ of $\mathbb{P}^{2}$, every element $f \in \operatorname{Bir}\left(\mathbb{P}^{2}\right)$ is given by

$$
f:[x: y: z] \longmapsto\left[f_{0}(x, y, z): f_{1}(x, y, z): f_{2}(x, y, z)\right]
$$

where the $f_{i}$ are homogeneous polynomials without common factors and of the same degree, which we call the degree of $f$. We will write $f=\left[f_{0}(x, y, z): f_{1}(x, y, z): f_{2}(x, y, z)\right]$. One of the main classical results is the Theorem of Noether and Castelnuovo ([C1901]), which states that $\operatorname{Bir}\left(\mathbb{P}^{2}\right)$ is generated by the linear group $\operatorname{Aut}\left(\mathbb{P}^{2}\right)=\mathrm{PGL}_{3}(\mathbf{k})$ and the standard quadratic involution $\sigma:=[y z: x z: x y]$.

Throughout the last century, various presentations of the plane Cremona group have been given (see Section 1.2). Each one of these displays a particularly interesting and beautiful aspect of the Cremona group. The aim of this article is to give a presentation of the plane Cremona group that uses the generators given by the Theorem of Noether and Castelnuovo. Another advantage of our presentation is that it is particularly simple and in many cases easy to use for specific calculations. We will illustrate this in Section 1.3 with an example that is due to Gizatullin.

Denote by $D_{2} \subset \mathrm{PGL}_{3}(\mathbf{k})$ the subgroup of diagonal automorphisms and by $S_{3} \subset \mathrm{PGL}_{3}(\mathbf{k})$ the symmetric group of order 6 acting on $\mathbb{P}^{2}$ by coordinate permutations.

Main Theorem. Let $\mathbf{k}$ be an algebraically closed field. The Cremona group $\operatorname{Bir}\left(\mathbb{P}^{2}\right)$ is isomorphic to

$$
\operatorname{Bir}\left(\mathbb{P}^{2}\right) \simeq\left\langle\sigma, \mathrm{PGL}_{3}(\mathbf{k}) \mid(1)-(5)\right\rangle
$$

(1) $g_{1} g_{2} g_{3}^{-1}=\mathrm{id}$ for all $g_{1}, g_{2}, g_{3} \in \mathrm{PGL}_{3}(\mathbf{k})$ such that $g_{1} g_{2}=g_{3}$.
(2) $\sigma^{2}=\mathrm{id}$,
(3) $\sigma \tau(\tau \sigma)^{-1}=$ id for all $\tau \in S_{3}$,
(4) $\sigma d \sigma d=\mathrm{id}$ for all diagonal automorphisms $d \in D_{2}$,
(5) $(\sigma h)^{3}=\mathrm{id}$, where $h=[z-x: z-y: z]$.

Observe that the relations (2) to (4) occur in the group Aut $\left(\mathbf{k}^{*} \times \mathbf{k}^{*}\right)$, which is given by the group of monomial transformations $\mathrm{GL}_{2}(\mathbb{Z}) \ltimes D_{2}$. Relation (5) is a relation from the group

$$
\operatorname{Aut}\left(\mathbb{P}^{1} \times \mathbb{P}^{1}\right)^{0} \simeq \mathrm{PGL}_{2}(\mathbf{k}) \times \mathrm{PGL}_{2}(\mathbf{k})
$$

which we consider as a subgroup of $\operatorname{Bir}\left(\mathbb{P}^{2}\right)$ by conjugation with the birational equivalence $\varpi: \mathbb{P}^{1} \times$ $\mathbb{P}^{1} \rightarrow \mathbb{P}^{2}$, given by $\left(\left[u_{0}: u_{1}\right],\left[v_{0}: v_{1}\right]\right) \mapsto\left[u_{1} v_{0}: u_{0} v_{1}: u_{1} v_{1}\right]$.

The idea of the proof of the Main Theorem is the same as in [I1984, B2012, Z2016]. We study linear systems of compositions of birational transformations and use the presentation of the Cremona group given by Blanc in [B2012].
1.2. Previous presentations. The aim of this section is to give an overview over previous presentations of the plane Cremona group. The first presentation was given by Gizatullin in 1982 ([G1982], see also [G1990]):

Theorem 1.1 ([G1982, Theorem 10.7]). The Cremona group $\operatorname{Bir}\left(\mathbb{P}^{2}\right)$ is generated by the set $Q$ of all quadratic transformations and the relations in $\operatorname{Bir}\left(\mathbb{P}^{2}\right)$ are consequences of relations of the form $q_{1} q_{2} q_{3}=\mathrm{id}$, where $q_{1}, q_{2}, q_{3}$ are quadratic transformations, i.e. we have the presentation:

$$
\left.\operatorname{Bir}\left(\mathbb{P}^{2}\right)=\langle Q| q_{1} q_{2} q_{3}=\mathrm{id} \text { for all } q_{1}, q_{2}, q_{3} \in Q \text { such that } q_{1} q_{2} q_{3}=\mathrm{id} \text { in } \operatorname{Bir}\left(\mathbb{P}^{2}\right)\right\rangle
$$

Definition 1.2. We denote by $\mathcal{J} \subset \operatorname{Bir}\left(\mathbb{P}^{2}\right)$ the group of transformations preserving the pencil of lines through $[1: 0: 0]$ and call it the de Jonquières group.

With respect to affine coordinates $(x, y)$, the de Jonquières can be described by:

$$
\begin{aligned}
\mathcal{J} & =\left\{\left.(x, y) \mapsto\left(\frac{a x+b}{c x+d}, \frac{\alpha(x) y+\beta(x)}{\gamma(x) y+\delta(x)}\right) \right\rvert\,\left(\begin{array}{ll}
a & b \\
c & d
\end{array}\right) \in \operatorname{PGL}_{2}(\mathbf{k}),\left(\begin{array}{cc}
\alpha(x) & \beta(x) \\
\gamma(x) & \delta(x)
\end{array}\right) \in \mathrm{PGL}_{2}(\mathbf{k}(x))\right\} \\
& \simeq \mathrm{PGL}_{2}(\mathbf{k}) \ltimes \mathrm{PGL}_{2}(\mathbf{k}(x))
\end{aligned}
$$

By the Theorem of Noether-Castelnuovo, $\operatorname{Bir}\left(\mathbb{P}^{2}\right)$ is generated by $\mathcal{J}$ and $\mathrm{PGL}_{3}(\mathbf{k})$, since $\sigma$ is an element of $\mathcal{J}$. The following theorem shows that, in a certain way, most of the relations in $\operatorname{Bir}\left(\mathbb{P}^{2}\right)$ are consequences of relations within these groups:
Theorem 1.3 ([B2012]). The Cremona group $\operatorname{Bir}\left(\mathbb{P}^{2}\right)$ over an algebraically closed field is the amalgamated product of $\mathrm{PGL}_{3}(\mathbf{k})$ and $\mathcal{J}$ along their intersection, divided by the relation

$$
\sigma \tau=\tau \sigma
$$

where $\sigma$ is the standard involution and $\tau \in \mathrm{PGL}_{3}(\mathbf{k})$ the transposition $[y: x: z]$.
Note that the Cremona group does not have the structure of an amalgamated product [C2013]. Theorem 1.3 was preceded by the following statement shown by Iskovskikh in [I1984]:
Theorem 1.4 ([I1984]). The Cremona group $\operatorname{Bir}\left(\mathbb{P}^{1} \times \mathbb{P}^{1}\right)$ is generated by $\tau:(x, y) \mapsto(y, x)$ and the group $B$ of birational transformations preserving the fibration given by the first projection and the following relations form a complete system of relations:

- relations inside the groups $\operatorname{Aut}\left(\mathbb{P}^{1} \times \mathbb{P}^{1}\right)$ and $B$,
- $\left(\tau \circ\left(\frac{1}{y}, \frac{y}{x}\right)\right)^{3}=\mathrm{id}$,
- $(\tau \circ(-x, y-x))^{3}=\mathrm{id}$.

A gap in the original proof of Theorem 1.4 had been detected and closed by Lamy ([L2010]).
A presentation of $\operatorname{Bir}\left(\mathbb{P}^{2}\right)$ in the form of a generalised amalgam was given in the following statement:
Theorem 1.5 ([W1992]). The group $\operatorname{Bir}\left(\mathbb{P}^{2}\right)$ is the free product of $\mathrm{PGL}_{3}(\mathbf{k}), \operatorname{Aut}\left(\mathbb{P}^{1} \times \mathbb{P}^{1}\right)$ and $\mathcal{J}$ amalgamated along their pairwise intersections in $\operatorname{Bir}\left(\mathbb{P}^{2}\right)$.

In [BF2013] the authors introduced the Euclidean topology on the Cremona group over a locally compact local field. With respect to this topology, $\operatorname{Bir}\left(\mathbb{P}^{2}\right)$ is a Hausdorff topological group and the restriction of the Euclidean topology to any algebraic subgroup is the classical Euclidean topology. In order to show that $\operatorname{Bir}\left(\mathbb{P}^{2}\right)$ is compactly presentable with respect to the Euclidean topology, Zimmermann proved the following:

Theorem 1.6 ([Z2016]). The Cremona group $\operatorname{Bir}\left(\mathbb{P}^{2}\right)$ is isomorphic to the amalgamated product of $\operatorname{Aut}\left(\mathbb{P}^{2}\right), \operatorname{Aut}\left(\mathbb{F}_{2}\right), \operatorname{Aut}\left(\mathbb{P}^{1} \times \mathbb{P}^{1}\right)$ along their pairwise intersection in $\operatorname{Bir}\left(\mathbb{P}^{2}\right)$ modulo the relation $\tau \sigma \tau \sigma$, where $\tau \in \operatorname{Aut}\left(\mathbb{P}^{2}\right)$ is the coordinate permutation $\tau:[x: y: z] \mapsto[z: y: x]$.

We would also like to mention the paper [IKT94] by Iskovskikh, Kabdykairov and Tregub, in which the authors present a list of generators and relations of $\operatorname{Bir}\left(\mathbb{P}^{2}\right)$ over arbitrary perfect fields.
1.3. Gizatullin-homomorphisms between Cremona groups. In this section we recall a result of Gizatullin in order to illustrate how our presentation can be used for explicit calculations. Throughout Section 1.3 we assume $\mathbf{k}$ to be algebraically closed and of characteristic $\neq 2$. In [G1990], Gizatullin considers the following question: Can a given group-homomorphism $\varphi: \mathrm{PGL}_{3}(\mathbf{k}) \rightarrow \mathrm{PGL}_{n+1}(\mathbf{k})$ be extended to a group-homomorphism $\Phi: \mathrm{Cr}_{2}(\mathbf{k}) \rightarrow \mathrm{Cr}_{n}(\mathbf{k})$ ? He answers this question positively if $\varphi$ is the projective representation induced by the regular action of $\mathrm{PGL}_{3}(\mathbf{k})$ on the space of plane conics, plane cubics or plane quartics. In order to construct these homomorphisms he uses the following construction. Let $\operatorname{Sym}_{n}$ be the k-algebra of symmetric $n \times n$-matrices and define the variety $\mathbb{S}_{2}(n)$ to be the quotient $\left(\operatorname{Sym}_{n}\right)^{3} / / \mathrm{GL}_{n}(\mathbf{k})$ where the regular action of $\mathrm{GL}_{n}(\mathbf{k})$ is given by $C \cdot\left(A_{1}, A_{2}, A_{3}\right)=$ $\left(C A_{1} C^{T}, C A_{2} C^{T}, C A_{3} C^{T}\right)$.

Lemma 1.7. The variety $\mathbb{S}_{2}(n)$ is a rational variety of dimension $(n+1)(n+2) / 2-1=n(n+3) / 2$.
Proof. The dimension of $\left(\operatorname{Sym}_{n}\right)^{3}$ is $3 n(n+1) / 2$. Since the dimension of $\mathrm{GL}_{n}(\mathbf{k})$ is $n^{2}$ and the action of $\mathrm{GL}_{n}(\mathbf{k})$ on $\left(\mathrm{Sym}_{n}\right)^{3}$ has finite kernel, the dimension of $\mathbb{S}_{2}(n)$ is $(n+1)(n+2) / 2-1$.

Define the subvariety $X \subset\left(\operatorname{Sym}_{n}\right)^{3}$ given by triplets of the form (id, $d, A$ ), where $d \in D_{2}$ and consider the following maps:

$$
X \hookrightarrow\left(\operatorname{Sym}_{n}\right)^{3} \xrightarrow{\pi} \mathbb{S}_{2}(n)
$$

Let $U \subset\left(\operatorname{Sym}_{n}\right)^{3}$ be the open dense subset of triplets of the form $\left(A_{1}, A_{2}, A_{3}\right)$ such that $A_{1}$ and $A_{2}$ are invertible. We note that $\pi(X)=\pi(U)$. Indeed, every symmetric element $A_{1} \in \mathrm{GL}_{n}(\mathbf{k})$ is of the form $C C^{T}$ for some $C \in \mathrm{GL}_{n}(\mathbf{k})$ and for every symmetric matrix $A_{2} \in \mathrm{GL}_{n}(\mathbf{k})$ there exists an orthogonal matrix $S \in \mathrm{O}_{n}(\mathbf{k})$ such that $S A_{2} S^{T}$ is diagonal. Consider the open dense subset $V \subset X$ of elements of the form (id, $d, A$ ), where $A \in \operatorname{Sym}_{n}$ and $d=\left(d_{i j}\right)$ is a diagonal element of $\mathrm{GL}_{n}(\mathbf{k})$ such that $d_{i i} \neq d_{j j}$ for all $i \neq j$. This condition ensures that the centralizer $G$ of $d$ in the orthogonal group $\mathrm{O}_{n}(\mathbf{k})$ consists only of diagonal elements. The group $G$ is therefore an abelian group of exponent 2. A Theorem of Fischer ([F1915]) states that the quotient of $\mathbb{A}^{N}$ by $G$ is a rational variety. The image $\pi(V)$ is still dense in $\mathbb{S}_{2}(n)$ and the restriction of $\pi$ to $V$ is the quotient map of the action of $G$ on $V$ given by conjugation. The theorem of Fischer therefore implies that $\mathbb{S}_{2}(n)$ is rational.

Note that Lemma 1.7 implies that $\mathbb{S}_{2}(n)$ has the same dimension as the projective space of all plane curves of degree $n$.

A linear transformation $g=\left[g_{1}: g_{2}: g_{3}\right] \in \mathrm{PGL}_{3}(\mathbf{k})$ induces an automorphism on $\left(\mathrm{Sym}_{n}\right)^{3} / /\left(\mathbf{k}^{*}\right)$ by $g\left(A_{1}, A_{2}, A_{3}\right):=\left(g_{1}\left(A_{1}, A_{2}, A_{3}\right), g_{2}\left(A_{1}, A_{2}, A_{3}\right), g_{3}\left(A_{1}, A_{2}, A_{3}\right)\right)$. This automorphism commutes with the action of $\mathrm{GL}_{n}(\mathbf{k})$, so we obtain a regular action of $\mathrm{PGL}_{3}(\mathbf{k})$ on $\mathbb{S}_{2}(n)$. Our main theorem allows now to give a short proof of the following result of Gizatullin:

Proposition 1.8 ([G1990]). This regular action of $\mathrm{PGL}_{3}(\mathbf{k})$ extends to a rational action of $\operatorname{Bir}\left(\mathbb{P}^{2}\right)$ on $\mathbb{S}_{2}(n)$.

Proof. We define the birational action of the element $\sigma$ on $\mathbb{S}_{2}(n)$ by

$$
\left(A_{1}, A_{2}, A_{3}\right) \longmapsto\left(A_{1}^{-1}, A_{2}^{-1}, A_{3}^{-1}\right) .
$$

In order to see that this indeed defines a rational action of $\mathrm{Cr}_{2}(\mathbf{k})$ on $\mathbb{S}_{2}(n)$ it is enough, by our main theorem, to check that the relations (1) to (5) are satisfied. The relations (1) to (4) are straightforward to check. For relation (5) we calculate for general $A_{1}, A_{2}, A_{3} \in \operatorname{Sym}_{n}$ :

$$
\sigma h \sigma\left(A_{1}, A_{2}, A_{3}\right)=\left(\left(A_{3}^{-1}-A_{1}^{-1}\right)^{-1},\left(A_{3}^{-1}-A_{2}^{-1}\right)^{-1}, A_{3}\right)
$$

and

$$
\begin{aligned}
& h \sigma h\left(A_{1}, A_{2}, A_{3}\right)=\left(A_{3}^{-1}-\left(A_{3}-A_{1}\right)^{-1}, A_{3}^{-1}-\left(A_{3}-A_{2}\right)^{-1}, A_{3}^{-1}\right) \\
& \quad=\left(A_{3}-A_{3}\left(A_{3}-A_{1}\right)^{-1} A_{3}, A_{3}-A_{3}\left(A_{3}-A_{2}\right)^{-1} A_{3}, A_{3}\right)
\end{aligned}
$$

One calculates that the two expressions are the same. Hence relation (5) is satisfied.
Lemma 1.7 and Proposition 1.8 imply that there is a rational $\mathrm{Cr}_{2}(\mathbf{k})$-action on $\mathbb{P}^{N}$ for all $N=$ $(n+1)(n+2) / 2-1$. In [G1990] Gizatullin shows using classical geometry that, for $n=2,3$ and 4 , the $\mathrm{PGL}_{3}(\mathbf{k})$-action on $\mathbb{S}_{2}(n)$ is conjugate to the $\mathrm{PGL}_{3}(\mathbf{k})$-action on the space of plane conics, plane cubics and plane quartics. It is an interesting question whether the $\mathrm{PGL}_{3}(\mathbf{k})$-actions on $\mathbb{S}_{2}(n)$ are conjugate to the $\mathrm{PGL}_{3}(\mathbf{k})$-actions on the space of plane curves of degree $n$. A positive answer would give a rational action of $\mathrm{Cr}_{2}(\mathbf{k})$ on the space of all plane curves preserving degrees. It would also be interesting to look at the geometrical properties of these rational actions. The case of the rational action of $\mathrm{Cr}_{2}(\mathbf{k})$ on the space of plane conics has been studied in [U2016].

## 2. Useful relations

Throughout all the sections we work over an algebraically closed field $\mathbf{k}$.
2.1. Preliminaries. There is a general formula for the degree of a composition of two Cremona transformations [A2002, Corollary 4.2.12], but the multiplicities of the base-points of the composition are hard to compute in general. However, if we compose an arbitrary birational map with a map of degree 2 it is a rather straight forward calculation [A2002, Proposition 4.2.5]. We will only use the formula for de Jonquières maps. For a given transformation $f \in \operatorname{Bir}\left(\mathbb{P}^{2}\right)$, we denote by $m_{p}(f)$ the multiplicity of $f$ in the point $p$.

Lemma 2.1. Let $\tau, f \in \mathcal{J}$ be transformations of degree 2 and $d$ respectively. Let $p_{1}, p_{2}$ be the basepoints of $\tau$ different from $[1: 0: 0]$ and $q_{1}, q_{2}$ the base-points of $\tau^{-1}$ different from $[1: 0: 0]$ such that the pencil of lines through $p_{i}$ is sent by $\tau$ onto the pencil of lines through $q_{i}$. Then

$$
\begin{aligned}
\operatorname{deg}(f \tau) & =d+1-m_{q_{1}}(f)-m_{q_{2}}(f) \\
m_{[1: 0: 0]}(f \tau) & =d-m_{q_{1}}(f)-m_{q_{2}}(f)=\operatorname{deg}(f \tau)-1 \\
m_{p_{i}}(f \tau) & =1-m_{q_{j}}(f), \quad i \neq j .
\end{aligned}
$$

Proof. A de Jonquières map of degree $d$ has multiplicity $d-1$ in $[1: 0: 0]$ and multiplicity 1 in every other of its base-points. The claim now follows from [A2002, Proposition 4.2.5].

Remark 2.2. Keep the notation of Lemma 2.1. Let $\Lambda$ be the linear system of $f$. Then Lemma 2.1 translates to:

$$
\begin{aligned}
\operatorname{deg}(f \tau)=\operatorname{deg}\left(\left(\tau^{-1}\right)(\Lambda)\right) & =d+1-m_{q_{1}}(\Lambda)-m_{q_{2}}(\Lambda) \\
m_{[1: 0: 0]}\left(\left(\tau^{-1}\right)(\Lambda)\right) & =d-m_{q_{1}}(\Lambda)-m_{q_{2}}(\Lambda)=\operatorname{deg}\left(\left(\tau^{-1}\right)(\Lambda)\right)-1 \\
m_{p_{i}}\left(\left(\tau^{-1}\right)(\Lambda)\right) & =1-m_{q_{j}}(\Lambda), \quad i \neq j
\end{aligned}
$$

In particular, as the multiplicity of $\Lambda$ in a point different from $[1: 0: 0]$ is zero or one, we obtain

$$
\operatorname{deg}\left(\left(\tau^{-1}\right)(\Lambda)\right)= \begin{cases}\operatorname{deg}(\Lambda)+1, & m_{q_{1}}(\Lambda)=m_{q_{2}}(\Lambda)=0 \\ \operatorname{deg}(\Lambda), & \left\{m_{q_{1}}(\Lambda), m_{q_{2}}(\Lambda)\right\}=\{0,1\} \\ \operatorname{deg}(\Lambda)-1, & m_{q_{1}}(\Lambda)=m_{q_{2}}(\Lambda)=1\end{cases}
$$

Note as well that Bézout theorem implies that $[1: 0: 0]$ and any two other base-points of $f$ are not collinear since $[1: 0: 0$ ] is a base-point of multiplicity $d-1$ all other base-points are of multiplicity 1 and a general member of $\Lambda$ intersects a line in $d$ points counted with multiplicity.

Notation 2.3. We use the following picture to work with relations. If $f_{1}, \ldots, f_{n} \in\{\sigma\} \cup \mathrm{PGL}_{3}(\mathbf{k})$ and $f_{1} \cdots f_{n}=1$ in the group $\left\langle\sigma, \mathrm{PGL}_{3}(\mathbf{k}) \mid(1)-(5)\right\rangle$, we say that the commutative diagram

is generated by relations (1)-(5) and that the expression $f_{1} \cdots f_{n}=1$ is generated by relations (1)-(5).
2.2. Relations. When dealing with quadratic maps, some relations among them appear quite naturally. We now take a closer look at a few of them and show that they are in fact generated by relations (1)-(5).

Lemma 2.4. Let $g \in \operatorname{PGL}_{3}(\mathbf{k}) \cap \mathcal{J}$ and suppose that the map $g^{\prime}:=\sigma g \sigma$ is linear. Then $g^{\prime}=\sigma g \sigma$ is generated by relations (1)-(4). In other words, the commutative diagram

is generated by relations (1)-(4).
Proof. The map $\sigma g \sigma$ being linear means by Lemma 2.1 that the base points of $\sigma g$ are the same as the base points of $\sigma$, which are $\{[1: 0: 0],[0: 1: 0],[0: 0: 1]\}$. As $g \in \mathcal{J}$, it fixes $[1: 0: 0]$ and thus permutes the points [0:1:0], $[0: 0: 1]$. Hence $g=d \tau$ for some $\tau \in S_{3} \cap \mathcal{J}$ and $d \in D_{2}$. Using our relations we obtain

$$
\sigma g \sigma \stackrel{(1)}{=} \sigma d \tau \sigma \stackrel{(3),(4)}{=} d^{-1} \tau=g^{\prime}
$$

Lemma 2.5. Let $g \in \mathrm{PGL}_{3}(\mathbf{k}) \cap \mathcal{J}$ such that $\operatorname{deg}(\sigma g \sigma)=2$. Suppose that no three points in the union of the base-points of $\sigma$ and the base-points of $\sigma g$ are collinear. Then there exist $g^{\prime}, g^{\prime \prime} \in \mathrm{PGL}_{3}(\mathbf{k}) \cap \mathcal{J}$ such that $\sigma g \sigma=g^{\prime} \sigma g^{\prime \prime}$ and this expression is generated by relations (1)-(5). In other words, the commutative diagram

is generated by relations (1)-(5).
Proof. The assumption $\operatorname{deg}(\sigma g \sigma)=2$ implies by Lemma 2.1 that $\sigma$ and $\sigma g$ have exactly two common base-points, among them $[1: 0: 0]$ because $\sigma g$ and $\sigma$ are de Jonquières maps. Up to coordinate permutations, the second point is $[0: 1: 0]$. More precisely, there exist two coordinate permutations $\tau_{1}, \tau_{2} \in S_{3} \cap \mathcal{J}$ such that $\tau_{1} g \tau_{2}$ fixes the points $[1: 0: 0]$ and $[0: 1: 0]$. Hence there are $a_{1}, a_{2}, b_{1}, b_{2}, c \in \mathbf{k}$ such that

$$
\tau_{1} g \tau_{2}=\left[a_{1} x+a_{2} z: b_{1} y+b_{2} z: c z\right]
$$

The assumption that no three of the base-points of $\sigma$ and $\sigma g$ are collinear implies that $a_{2} b_{2} \neq 0$. So there exist two elements $d_{1}, d_{2} \in D_{2}$ such that $\tau_{1} g \tau_{2}=d_{1} h d_{2}$. Using relations (1)-(5) we obtain

$$
\sigma g \sigma=\sigma \tau_{1}^{-1} \tau_{1} g \tau_{2} \tau_{2}^{-1} \sigma \stackrel{(1)}{=} \sigma \tau_{1}^{-1} d_{1} h d_{2} \tau_{2}^{-1} \sigma \stackrel{(3),(4)}{=} \tau_{1}^{-1} d_{1}^{-1} \sigma h \sigma d_{2}^{-1} \tau_{2}^{-1} \stackrel{(5)}{=} \tau_{1}^{-1} d_{1}^{-1} h \sigma h d_{2}^{-1} \tau_{2}^{-1}
$$

The claim follows with $g^{\prime}:=\tau_{1}^{-1} d_{1}^{-1} h$ and $g^{\prime \prime}:=h d_{2}^{-1} \tau_{2}^{-1}$.
Lemma 2.6. Let $g_{1}, \ldots, g_{4} \in \mathrm{PGL}_{3}(\mathbf{k}) \cap \mathcal{J}$ such that $\sigma g_{2} \sigma g_{1}=g_{4} \sigma g_{3} \sigma$ is of degree 3 and

- no three of the base-points of $\sigma g_{2}$ and $\sigma$ are collinear
- no three of the base-points of $\sigma g_{1}$ and $\sigma$ are collinear.

Then the relation $\sigma g_{2} \sigma g_{1}=g_{4} \sigma g_{3} \sigma$ is generated by relations (1)-(5).

Proof. Let $p_{0}:=[0: 0: 1]$. The maps $g_{1}, \ldots, g_{4} \in \mathrm{PGL}_{3}(\mathbf{k}) \cap \mathcal{J}$ fix it. By Lemma 2.1, the assumption $\operatorname{deg}\left(\sigma g_{2} \sigma g_{1}\right)=3$ is equivalent to the maps $\sigma g_{2}$ and $g_{1}^{-1} \sigma$ having exactly one common base-point, namely $p_{0}$. For the same reason, the maps $g_{4} \sigma$ and $\sigma g_{3}^{-1}$ have only $p_{0}$ as a common base-point. The assumptions on the base-points imply that the maps $\sigma g_{2} \sigma g_{1}$ and $g_{3} \sigma g_{1}^{-1} \sigma$ have only proper base-points. Therefore, the maps $g_{4} \sigma g_{3} \sigma$ and $\sigma g_{4}^{-1} \sigma g_{2}$ have only proper base-points and we obtain that for

$$
(f, g) \in\left\{\left(g_{1}^{-1} \sigma, \sigma g_{2}\right),\left(\sigma g_{1}, g_{3} \sigma\right),\left(\sigma g_{3}^{-1}, g_{4} \sigma\right),\left(g_{2}^{-1} \sigma, \sigma g_{4}^{-1}\right)\right\}
$$

no three base-points of the maps $f$ and $g$ are collinear. Hence there exists a quadratic map $\tau_{1}$ that has exactly two base-points in common with $\sigma g_{1}$ and with $g_{3} \sigma$. We write $\tau_{1}=h_{1} \sigma h_{2}$ for some $h_{1}, h_{2} \in$ $\mathrm{PGL}_{3}(\mathbf{k}) \cap \mathcal{J}$. Then $\sigma g_{1} \tau_{1}^{-1}$ and $g_{3} \sigma \tau_{1}^{-1}$ are quadratic again. Let $h_{3}, \ldots, h_{8} \in \mathrm{PGL}_{3}(\mathbf{k}) \cap \mathcal{J}$ and define the quadratic maps $\tau_{i}:=h_{2 i} \sigma h_{2 i-1} \in \mathcal{J}, i=2, \ldots, 4$. We can chose $h_{3}, h_{4}$ such that $\tau_{2}^{-1} \tau_{1}=$ $h_{3}^{-1} \sigma h_{4}^{-1} h_{2} \sigma h_{3}=\sigma g_{1}$. Analogously we chose $h_{4}, \ldots, h_{8}$ such that:

- the diagram below commutes
- each of the $\tau_{i}$ has exactly two common base-points (one of them $p_{0}$ ) with each of the two other maps departing from the same corner.


Lemma 2.5 applied to the triangles yields that each of them is generated by relations (1)-(5). In particular, the above commutative diagram is generated by relations (1)-(5).

Remark 2.7. Let $a_{1}, a_{2}, b_{1}, b_{2}, c \in \mathbf{k}$. The map

$$
g=\left[a_{1} x+a_{2} z: b_{1} y+b_{2} z: c z\right] \in \mathrm{PGL}_{3}(\mathbf{k}) \cap \mathcal{J}
$$

is a de Jonquières map. Furthermore, observe that if $a_{2}=b_{2}=0$, then $\sigma g \sigma$ is linear. Otherwise, $\sigma g \sigma$ is a quadratic map. In fact, if $a_{2} b_{2} \neq 0$, all its base-points are in $\mathbb{P}^{2}$; this corresponds to the case that is treated in Lemma 2.5. If $a_{2}=0$, the map $\sigma g \sigma$ has a base-point infinitely near to [1:0:0], and if $b_{2}=0$ it has a base-point infinitely near to [0:1:0]. Figure 1 displays the constellation of the base-points of $\sigma g$ and $\sigma$.


Figure 1. The base-points of $\sigma g$ if $a_{2} \neq 0, b_{2}=0$ (left) and if $a_{2}=0, b_{2} \neq 0$ (right).
The following two lemmas provide a solution of how to treat these two cases.
Definition 2.8. For a de Jonquières transformation $f \in \mathcal{J}$ and a line $l \subset \mathbb{P}^{2}$ we define the discrepancy $N(f, l)$ as follows: If $f(l)$ is a line, we set $N(f, l):=0$. If $f(l)=\{p\}$ is a point, then there exists a sequence of $K$ blow-ups $\pi: S \rightarrow \mathbb{P}^{2}$ and an induced birational map $\hat{f}: \mathbb{P}^{2} \rightarrow S$, such that the following diagram commutes:

and such that the strict transform $\hat{f}(l) \subset S$ is a curve. We define $N(f, l)$ to be the least number $K$ of blow-ups necessary for this construction.

Remark 2.9. Let $f \in \mathcal{J}$ and let $l \subset \mathbb{P}^{2}$ be a line. If $N(f, l) \geq 1$, then the point $P:=f(l)$ is a basepoint of $f^{-1}$. More precisely, if $\pi$ and $\hat{f}$ are as above, then $f^{-1}$ has a base-point in the $(N(f, l)-1)$-th neighbourhood of $f(l)$ and the exceptional divisor of this base-point is $\hat{f}(l)$.

Lemma 2.10. Let $f \in \mathcal{J}$ be a de Jonquières transformation and $l \subset \mathbb{P}^{2}$ a line such that $N(f, l) \geq 1$, and let $g \in \mathrm{PGL}_{3}(\mathbf{k}) \cap \mathcal{J}$. Denote by $\eta: S \rightarrow \mathbb{P}^{2}$ the blow-up of the base-points of $\sigma g$. Then
(1) $N(\sigma g f, l)=N(f, l)+1$ if and only if the point $f(l) \in \mathbb{P}^{2}$ is not a base-point of $\sigma g$ but is on a line contracted by $\sigma g$.
(2) $N(\sigma g f, l)=N(f, l)-1$ if and only if the point $f(l) \in \mathbb{P}^{2}$ is a base-point of $\sigma g$ and $\left(\eta^{-1} f\right)(l)$ is a curve or is a point not on the strict transform of a line contracted by $\sigma g$.
(3) $N(\sigma g f, l)=N$ otherwise.

Proof. If $p:=f(l)$ is not a base-point of $\sigma g$, then its image by $\sigma g$ is a base-point of $(\sigma g f)^{-1}$ with $N(\sigma g f, l) \geq N(f, l)$. The inequality is strict if and only if $p$ is on a line contracted by $\sigma g$.

If $p$ is a base-point of $\sigma g$ the discrepancy decreases strictly unless $\eta^{-1} f$ contracts $l$ onto an intersection point of the exceptional divisor of $p$ and the strict transform of a line contracted by $\sigma g$.

Lemma 2.11. Let $g_{1}, \ldots, g_{m} \in \mathrm{PGL}_{3}(\mathbf{k}) \cap \mathcal{J}$ such that $g_{m} \sigma g_{m-1} \sigma \cdots \sigma g_{1}=\mathrm{id}$. Then there exist linear maps $h_{1}, \ldots, h_{m} \in \mathrm{PGL}_{3}(\mathbf{k}) \cap \mathcal{J}$ and a de Jonquières transformation $\varphi \in \mathcal{J}$ such that

$$
\varphi g_{m} \sigma g_{m-1} \sigma \cdots \sigma g_{1} \varphi^{-1}=h_{m} \sigma h_{m-1} \sigma \cdots h_{1} \sigma
$$

and such that the following properties are satisfied:
(1) the above relation is generated by relations (1)-(5),
(2) $\operatorname{deg}\left(\sigma h_{i} \sigma h_{i-1} \cdots \sigma h_{1}\right)=\operatorname{deg}\left(\sigma g_{i} \sigma g_{i-1} \cdots \sigma g_{1}\right)$ for all $i=1, \ldots, m$,
(3) $\left(\sigma h_{i} \sigma h_{i-1} \cdots \sigma h_{1}\right)^{-1}$ does not have any infinitely near base-points above [1:0:0] for all $i=1, \ldots, m$.

Proof. Define $f_{i}:=\sigma g_{i} \cdots \sigma g_{1}$ for $i=1, \ldots, m-1$. We will construct the $h_{i}$ such that (3) is satisfied and then show that the other properties hold as well. If none of the $f_{i}$ has a base-point that is infinitely near to $[1: 0: 0]$, we set $h_{i}:=g_{i}$ for all $i$ and all the claims are trivially satisfied. Otherwise, there exist $k \geq 1$ such that $f_{i}$ has a base-point in the $k$-th neigbourhood of $[1: 0: 0]$ for some $i$. Assume $k$ to be maximal with this property. We will lower $k$ and then proceed by induction. For this we pick two general points $s_{0}, t_{0} \in \mathbb{P}^{2}$ and define

$$
\begin{aligned}
& s_{i}:=f_{i}\left(s_{0}\right)=\sigma g_{i} \sigma \cdots \sigma g_{1}\left(s_{0}\right), \quad t_{i}:=f_{i}\left(t_{0}\right)=\sigma g_{i} \sigma \cdots \sigma g_{1}\left(t_{0}\right), \quad \text { for } i=1, \ldots, m-2, \\
& s_{m-1}:=g_{m} \sigma g_{m-1}\left(s_{m-2}\right), \quad t_{m-1}:=g_{m} \sigma g_{m-1}\left(t_{m-2}\right)
\end{aligned}
$$

Since $s_{0}$ and $t_{0}$ are general points of $\mathbb{P}^{2}$, the $s_{i}$ and $t_{i}$ are general as well. For all $i=1, \ldots, m-1$, there exist $\alpha_{i} \in \mathrm{PGL}_{3}(\mathbf{k}) \cap \mathcal{J}$ that send $p_{0}, p_{1}, p_{2}$ onto $p_{0}, s_{i}, t_{i}$ respectively. The map

$$
\tau_{i}:=\alpha_{i} \sigma \alpha_{i}^{-1} \in \mathcal{J}
$$

is a quadratic involution with base-points $p_{0}, s_{i}, t_{i}$. The assumption $g_{m} \sigma \cdots \sigma g_{1}=$ Id implies that $s_{m-1}=s_{0}$ and $t_{m-1}=t_{0}$, so we may choose $\alpha_{m-1}=\alpha_{0}$ and obtain $\tau_{m-1}=\tau_{0}$. We define

$$
\theta_{i}:=\tau_{i} \sigma g_{i} \tau_{i-1}^{-1} \in \mathcal{J}, \quad i=1, \ldots, m-2, \quad \theta_{m-1}:=\tau_{m-1}\left(g_{m} \sigma g_{m-1}\right) \tau_{m-2}^{-1} \in \mathcal{J}
$$

and consider the sequence

$$
\operatorname{Id}=\tau_{0} g_{m} \sigma g_{m-1} \sigma \cdots \sigma g_{1} \tau_{0}^{-1}=\tau_{0} g_{m} \tau_{m-1}^{-1} \tau_{m-1} \sigma g_{m-1} \tau_{m-2}^{-1} \tau_{m-2} \sigma g_{m-2} \ldots \sigma g_{1} \tau_{0}^{-1}=\theta_{m-1} \theta_{m-2} \cdots \theta_{1}
$$

The situation is visualised in the following commutative diagram:


We claim that for each $i=1, \ldots, m-1$, the map $\theta_{i} \in \mathcal{J}$ is a quadratic map with only proper basepoints in $\mathbb{P}^{2}$. The only common base-point of the transformations $\sigma g_{i}$ and $\tau_{i}$ is $p_{0}$, hence by Lemma 2.1 the map $\tau_{i-1} g_{i}^{-1} \sigma$ is of degree 3 and has $p_{0}, p_{1}, p_{2}, s_{i+1}, t_{i+1}$ as base-points. The common base-points of the two transformations $\tau_{i-1} g_{i}^{-1} \sigma$ and $\tau_{i}$ are the points $p_{0}, s_{i+1}, t_{i+1}$. Therefore, the composition $\theta_{i}=\tau_{i} \sigma g_{i} \tau_{i-1}^{-1}$ is quadratic and its base-points are $p_{0}$ and the image under $\tau_{i-1}$ of the two base-points of $\sigma g_{i}$ different from $p_{0}$.

Since $s_{i-1}$ and $t_{i-1}$ are general points, these images are proper points of $\mathbb{P}^{2}$. So for each $i=1, \ldots, m-1$, we find $\beta_{i}, \gamma_{i} \in \mathrm{PGL}_{3}(\mathbf{k}) \cap \mathcal{J}$ such that $\theta_{i}=\beta_{i} \sigma \gamma_{i}$.


We write $\tilde{h}_{1}:=\gamma_{1}, \tilde{h}_{m}:=\beta_{m-1}, \tilde{h}_{i}:=\gamma_{i} \beta_{i-1}, i=2, \ldots, m-1$. By Remark 2.2, we have

$$
\operatorname{deg}\left(\tau_{i} \sigma g_{i} \cdots \sigma g_{1}\right)=\operatorname{deg}\left(\sigma g_{i} \cdots \sigma g_{1}\right)+1
$$

and therefore

$$
\operatorname{deg}\left(\theta_{i} \cdots \theta_{1}\right)=\operatorname{deg}\left(\tau_{i} \sigma g_{i} \cdots \sigma g_{1} \tau_{0}^{-1}\right)=\operatorname{deg}\left(\sigma g_{i} \cdots \sigma g_{1}\right)
$$

Hence we finally obtain

$$
\operatorname{deg}\left(\sigma \tilde{h}_{i} \sigma \cdots \sigma \tilde{h}_{1}\right)=\operatorname{deg}\left(\beta_{i+1}^{-1} \theta_{i} \cdots \theta_{1}\right)=\operatorname{deg}\left(\sigma g_{i} \cdots \sigma g_{1}\right)
$$

This is part (2) of the lemma. By Lemma 2.6, all squares in the above diagram are generated by relations (1)-(5), hence the whole diagram is generated by these relations. This is part (1).

Let us look at part (3). The base-points of $\left(\theta_{i} \cdots \theta_{1}\right)^{-1}$ are $[1: 0: 0]$ and the proper images of the base-points of $\left(\sigma g_{i} \cdots \sigma g_{1}\right)^{-1}$ different from [1:0:0]. By construction of the $\tau_{i}$, none of the base-points of $\left(\sigma g_{i} \cdots \sigma g_{1}\right)^{-1}$ different from $[1: 0: 0]$ are on a line contracted by $\tau_{i}$. Moreover, the base-points of $\left(\sigma g_{i} \cdots \sigma g_{1}\right)^{-1}$ in the first neighbourhood of $[1: 0: 0]$ are sent by $\tau_{i}$ onto proper points of $\mathbb{P}^{2}$. In conclusion, $\left(\theta_{i} \cdots \theta_{1}\right)^{-1}$ has less base-points infinitely near $[1: 0: 0]$. Induction step done. The same argument yields part (4).

Lemma 2.12. Let $g_{1}, \ldots, g_{m} \in \mathrm{PGL}_{3}(\mathbf{k}) \cap \mathcal{J}$ be linear de Jonquières transformations. Then there exist linear de Jonquières transformations $h_{1}, \ldots, h_{m} \in \mathrm{PGL}_{3}(\mathbf{k}) \cap \mathcal{J}$, and a de Jonquières transformation $\varphi \in \mathcal{J}$ such that

$$
\varphi g_{m} \sigma g_{m-1} \sigma \cdots \sigma g_{1} \varphi^{-1}=h_{m} \sigma h_{m-1} \sigma \cdots \sigma h_{1}
$$

and such that the following properties hold:
(1) the above relation is generated by relations (1)-(5),
(2) $\operatorname{deg}\left(\sigma h_{i} \cdots \sigma h_{1}\right)=\operatorname{deg}\left(\sigma g_{i} \cdots \sigma g_{1}\right)$ for all $i=1, \ldots, m$,
(3) $\left(\sigma h_{i} \sigma h_{i-1} \cdots \sigma h_{1}\right)^{-1}$ does not have any infinitely near base-points for all $i=1, \ldots, m$.

Proof. Define $f_{i}:=\sigma g_{i} \sigma g_{i-1} \cdots \sigma g_{1}$ for $i=1, \ldots, m$. After applying Lemma 2.11 we may assume that none of the transformations $f_{i}^{-1}$ has base-points infinitely near to $[1: 0: 0]$. We define

$$
\begin{aligned}
& N:=\max \left\{N\left(f_{i}, l\right) \mid i=1, \ldots, m, \quad l \subset \mathbb{P}^{2} \text { line }\right\} \\
& k:=\max \left\{i \mid N\left(f_{i}, l\right)=N\right\} \\
& \#:=\text { number of lines } l \subset \mathbb{P}^{2} \text { with } N\left(f_{k}, l\right)=N
\end{aligned}
$$

In other words, $N$ is the maximal discrepancy, $k$ is the maximal number of all $i$ such that $f_{i}$ has $N$ as a discrepancy and $\# \geq 1$ is the number of lines contracted by $f_{k}$ with discrepancy $N$. We do induction over the lexicographically ordered triple ( $N, k, \#$ ).

If $N=1$ there are no infinitely near base-points and we are done. Suppose that $N \geq 2$. We denote by $l_{k} \subset \mathbb{P}^{2}$ a line such that $N=N\left(f_{k}, l_{k}\right)$ and define $p_{k}:=f_{k}\left(l_{k}\right) \in \mathbb{P}^{2}$. Let $s \in \mathbb{P}^{2}$ be a general point. Then there exists a linear de Jonquières map $h \in \mathrm{PGL}_{3}(\mathbf{k}) \cap \mathcal{J}$ such that $\sigma h$ has $[1: 0: 0], p_{k}$ and $s$ as base-points. By definition of $k$ and $N$ we have $N>N\left(f_{k+1}, l_{k}\right)$. Since $f_{k+1}=\sigma g_{k+1} f_{k}$, Lemma 2.10 implies that $p_{k}$ is also a base-point of $\sigma g_{k+1}$. It follows from Lemma 2.1 that $\operatorname{deg}\left(\sigma g_{k+1}(\sigma h)^{-1}\right)=2$. Since $s$ is a general point, we find $a_{1}, a_{2} \in \mathrm{PGL}_{3}(\mathbf{k}) \cap \mathcal{J}$ such that $\sigma g_{k+1}(\sigma h)^{-1}=a_{2} \sigma a_{1}$. Note that $N\left(\sigma h \sigma g_{k} \cdots \sigma g_{1}, l_{k}\right)=N-1$ by Lemma 2.10.

If $N\left(\sigma g_{k-1} \cdots \sigma g_{1}, l_{k}\right)<N$, we find, by similar arguments as above, $b_{1}, b_{2} \in \mathrm{PGL}_{3}(\mathbf{k}) \cap \mathcal{J}$ such that $\sigma h \sigma g_{k}=b_{2} \sigma b_{1}$


The new sequence $g_{m} \sigma g_{m-1} \cdots \sigma g_{k+2} a_{2} \sigma\left(a_{1} b_{2}\right) \sigma\left(b_{1} g_{k-1}\right) \sigma g_{k-2} \cdots \sigma g_{1}$ has maximal discrepancy at most $N$. If it is $N$, that means that there is either another line $l \subset \mathbb{P}^{2}$ such that $N\left(\sigma g_{k} \cdots \sigma g_{1}, l\right)=N$, in which case \# has decreased. Or that $N\left(\sigma g_{k} \cdots \sigma g_{1}, l\right)<N$ for all lines $l$ and $N\left(\sigma g_{i} \cdots \sigma g_{1}, l_{i}\right)=N$ for some $i<k$ and some line $l_{i}$. In any case, the triple $(N, k, \#)$ decreases. Note as well that

$$
\operatorname{deg}\left(\sigma h \sigma g_{k} \cdots \sigma g_{1}\right)=\operatorname{deg}\left(\sigma g_{k} \cdots \sigma g_{1}\right)
$$

If $N\left(\sigma g_{k-1} \cdots \sigma g_{1}, l_{k}\right)=N$, there are two options by Lemma 2.10:
(a) The point $p_{k}$ is a base-point of $\left(\sigma g_{k}\right)^{-1}$ and, if $\eta: S \rightarrow \mathbb{P}^{2}$ is the blow-up of the base-points of $\left(\sigma g_{k}\right)^{-1}$, then $\left(\eta^{-1} f_{k}\right)^{-1}\left(l_{k}\right)$ is the intersection point of an exceptional divisor and the strict transform of a line contracted by $\left(\sigma g_{k}\right)^{-1}$.
(b) The point $p_{k}$ is not a base-point of $\left(\sigma g_{k}\right)^{-1}$ and is not on its contracted lines.

In case (a) we can proceed analogously as in the case above, where $N\left(\sigma g_{k-1} \cdots \sigma g_{1}, l_{k}\right)<N$. So assume now that we are in case (b). The image $p_{k}^{\prime}$ of $p_{k}$ by $\left(\sigma g_{k}\right)^{-1}$ is a proper point of $\mathbb{P}^{2}$. The point $s \in \mathbb{P}^{2}$ is general, hence also its image $s^{\prime}$ by $\left(\sigma g_{k}\right)^{-1}$ is a general point of $\mathbb{P}^{2}$. In particular, there exists $h^{\prime} \in \mathrm{PGL}_{3}(\mathbf{k}) \cap \mathcal{J}$ such that $\sigma h^{\prime}$ has base-points [1:0:0], $p_{k}^{\prime}$ and $s^{\prime}$. The map $\sigma h \sigma g_{k}\left(\sigma h^{\prime}\right)^{-1}$ is of degree 2 , and since the points $s$ and $s^{\prime}$ are in general position, we find $c_{1}, c_{2} \in \mathrm{PGL}_{3}(\mathbf{k}) \cap \mathcal{J}$ such that $\sigma h \sigma g_{k}\left(\sigma h^{\prime}\right)^{-1}=c_{2} \sigma c_{1}$. Moreover, we have $N\left(\sigma h^{\prime} \sigma g_{k-1} \cdots \sigma g_{1}, l_{k}\right)=N-1$. Also note that

$$
\operatorname{deg}\left(\sigma h^{\prime} \sigma g_{k-1} \cdots \sigma g_{1}\right)=\operatorname{deg}\left(\sigma g_{k-1} \cdots \sigma g_{1}\right)
$$

We proceed like this until we find an index $i<k$ such that $N\left(\sigma g_{i} \cdots \sigma g_{1}, l_{k}\right)<N$. Such an index has to exist because $\sigma g_{m} \cdots \sigma g_{1}=\mathrm{id}$. There, the preimage of $p_{k}$ is a base-point of $\left(\sigma g_{i} \cdots \sigma g_{1}\right)^{-1}$, and we repeat the construction of the former case. It yields a new sequence with maximal discrepancy at most $N$. If it is equal to $N$ then either at the index $k$ and another line or at an index smaller than $k$. In other words, the triple $(N, k, \#)$ has decreased.

The commutative diagram below illustrates the procedure if $N\left(\sigma g_{k-2} \cdots \sigma g_{1}, l_{k}\right)<N$.


It remains to remark that all the squares and triangles are generated by relations (1)-(5) by Lemma 2.5 and Lemma 2.6.

## 3. Proof of Theorem 1.1

Proposition 3.1. Let $g_{1}, \ldots, g_{m} \in \mathrm{PGL}_{3}(\mathbf{k}) \cap \mathcal{J}$ and suppose that $\mathrm{Id}=g_{m} \sigma g_{m-1} \sigma \cdots \sigma g_{1}$ as maps. Then this expression is generated by relations (1)-(5).

Proof. Let $\Lambda_{0}$ be the complete linear system of lines in $\mathbb{P}^{2}$ and define

$$
\Lambda_{i}:=\sigma g_{i-1} \sigma \cdots \sigma g_{1}\left(\Lambda_{0}\right), \quad i=1, \ldots, m
$$

Let

$$
\delta_{i}:=\operatorname{deg}\left(\Lambda_{i}\right), \quad D:=\max \left\{\delta_{i} \mid i=1, \ldots, m\right\} \text { and } n:=\max \left\{i \mid \delta_{i}=D\right\}
$$

We do induction on the lexicographically ordered set of pairs of positive integers $(D, n)$.
If $D=1$, then $m=1$ and there is nothing to prove.
Let $D>1$. By Lemma 2.12, we can suppose that for each $i=1, \ldots, m$ the transformation $\left(g_{i} \sigma g_{i-1} \sigma \cdots \sigma g_{1}\right)^{-1}$ does not have any infinitely near base-points, and we can do this without increasing the pair $(D, n)$. Equivalently, each $\Lambda_{i}$ does not have any infinitely near base-points.

All the $g_{i}$ are de Jonquières maps and therefore fix $[1: 0: 0]$, the maps $\sigma g_{i}$ and $\sigma$ always have $[1: 0: 0]$ as common base-point. In particular, Lemma 2.1 yields $\operatorname{deg}\left(\sigma g_{i} \sigma\right) \leq 3$ for all $i=1, \ldots, m$. We will look at the three distinct cases $\operatorname{deg}\left(\sigma g_{n} \sigma\right)=1,2$ and 3 .
(a) If $\operatorname{deg}\left(\sigma g_{n} \sigma\right)=1$, Lemma 2.4 implies that we can replace the word $\sigma g_{n} \sigma$ by the linear map $g_{n}^{\prime}=\sigma g_{n} \sigma$ using only relations (1)-(5). We obtain a new pair $\left(D^{\prime}, n^{\prime}\right)$ where $D^{\prime} \leq D$ and if $D=D^{\prime}$ then $n<n^{\prime}$.
(b) If $\operatorname{deg}\left(\sigma g_{n} \sigma\right)=2$, then $\sigma$ and $\sigma g_{n}$ have exactly two common base-points, among them $[1: 0: 0]$. Up to coordinate permutations, these two points are $[1: 0: 0]$ and $[0: 1: 0]$. More precisely, there exist two permutations of coordinates $\tau_{1}, \tau_{2} \in S_{3} \cap \mathcal{J}$ such that $\tau_{1} g_{n} \tau_{2}$ fixes the points [1:0:0] and [ $0: 1: 0]$. Hence there are $a_{1}, a_{2}, b_{1}, b_{2}, c \in \mathbf{k}$ such that

$$
\tau_{1} g_{n} \tau_{2}=\left[a_{1} x+a_{2} z: b_{1} y+b_{2} z: c z\right]
$$

Using relations (1) and (3) we get

$$
g_{m} \sigma \cdots \sigma g_{n+1} \sigma \tau_{1}^{-1} \tau_{1} g_{n} \tau_{2} \tau_{2}^{-1} \sigma \cdots g_{1}=g_{m} \sigma \cdots \sigma\left(g_{n+1} \tau_{1}^{-1}\right) \sigma\left(\tau_{1} g_{n} \tau_{2}\right) \sigma\left(\tau_{2}^{-1} g_{n-1}\right) \sigma \cdots g_{1}
$$

This replacement does not change the pair $(D, n)$. So, we may assume that

$$
\tau_{1}=\tau_{2}=\mathrm{id} \quad \text { and } \quad g_{n}=\left[a_{1} x+a_{2} z: b_{1} y+b_{2} z: c z\right]
$$

By assumption, for $i=1, \ldots, n$, the maps $g_{i} \sigma g_{i-1} \sigma \cdots \sigma g_{1}$ have no infinitely near base-points. It follows that $\Lambda_{n}$ has no infinitely near base-points.
(b1) If $a_{2} b_{2} \neq 0$, then no three of the base-points of $\sigma$ and $\sigma g_{n}$ are collinear. By Lemma 2.5 there exist $g^{\prime}, g^{\prime \prime} \in \mathrm{PGL}_{3}(\mathbf{k})$ such that we can replace the word $\sigma g_{n} \sigma$ with the word $g^{\prime} \sigma g^{\prime \prime}$ using relations (1)-(5). This yields a new pair $\left(D^{\prime}, n^{\prime}\right)$ where $D^{\prime} \leq D$ and if $D=D^{\prime}$ then $n^{\prime}<n$.
(b2) We want to see that $a_{2} b_{2}=0$ is impossible. Suppose that $a_{2} b_{2}=0$. Then $q:=g_{n}^{-1}([0: 0: 1])$ is a base-point of $\sigma g_{n}$ on a line that is contracted by $\left(\sigma g_{n-1}\right)^{-1}$ (see Remark 2.7). Remark 2.2 implies that

$$
D-1=\delta_{n+1}=D+1-m_{[0: 1: 0]}\left(\Lambda_{n}\right)-m_{q}\left(\Lambda_{n}\right)
$$

In particular, we have

$$
m_{q}\left(\Lambda_{n}\right)=1
$$

Since it is not a base-point of $\sigma$, it is not a base-point of $\left(\sigma g_{n-1}\right)^{-1}$. Hence its proper image by $\left(\sigma g_{n-1}\right)^{-1}$ is a base-point of $\Lambda_{n-1}$. Because of $a_{2} b_{2}=0$, this point is an infinitely near point, a contradiction to our assumption that the $\Lambda_{i}$ do not have any infinitely near base-points.
(c) Assume that $\operatorname{deg}\left(\sigma g_{n} \sigma\right)=3$, so $\sigma$ and $\sigma g_{n}$ have one common base point, which is [1:0:0]. Denote by $p_{0}=[1: 0: 0], p_{1}=[0: 1: 0], p_{2}=[0: 0: 1]$ the base-points of $\sigma$ and by $p_{0}, q_{1}, q_{2}$ the base-points of $\sigma g_{n}$. Remark 2.2 implies

$$
\begin{aligned}
& \delta_{n} \geq \operatorname{deg}\left(\Lambda_{n-1}\right)=\operatorname{deg}\left(\left(\sigma g_{n-1}\right)^{-1}\left(\Lambda_{n}\right)\right)=\delta_{n}+1-m_{p_{1}}\left(\Lambda_{n}\right)-m_{p_{2}}\left(\Lambda_{n}\right) \\
& \delta_{n}>\operatorname{deg}\left(\Lambda_{n+1}\right)=\operatorname{deg}\left(\sigma g_{n}\left(\Lambda_{n}\right)\right)=\delta_{n}+1-m_{q_{1}}\left(\Lambda_{n}\right)-m_{q_{2}}\left(\Lambda_{n}\right) .
\end{aligned}
$$

Therefore, we obtain

$$
1=m_{q_{1}}\left(\Lambda_{n}\right)=m_{q_{2}}\left(\Lambda_{n}\right), \quad 1 \leq m_{p_{1}}\left(\Lambda_{n}\right)+m_{p_{2}}\left(\Lambda_{n}\right)
$$

Choose $i \in\{1,2\}$ such that $m_{p_{i}}\left(\Lambda_{n}\right)=1$. Then the points [1:0:0], $p_{i}$ and $q_{1}$ are not collinear (because $m_{p_{0}}\left(\Lambda_{n}\right)+m_{p_{1}}\left(\Lambda_{n}\right)+m_{q_{1}}\left(\Lambda_{n}\right)>\delta_{n}$ ) and there exists a $g^{\prime} \in \mathrm{PGL}_{3}(\mathbf{k}) \cap \mathcal{J}_{*}$ such that $\sigma g^{\prime}$ has base-points $[1: 0: 0], p_{i}$ and $q_{1}$. Consider Figure 2; we claim that the left pair and the right pair of maps satisfy the assumptions of case (b1), which implies that $\sigma g\left(\sigma g_{n-1}^{\prime}\right)^{-1}$ and $\sigma g_{n} \sigma g^{\prime}$ can be replaced by maps of the form $h \sigma h^{\prime}$ and $h^{\prime \prime} \sigma h^{\prime \prime \prime}$ respectively for some linear maps $h, h^{\prime}, h^{\prime \prime}, h^{\prime \prime \prime}$ and the pair $(D, n)$ decreases.


Figure 2. The two maps on the left and the two maps on the right satisfy the assumptions of case (b1).

The maps $\sigma$ and $\sigma g^{\prime}$ have two common base-points, namely $p_{0}$ and $p_{i}$. The maps $\sigma g^{\prime}$ and $\sigma g_{n}$ have the base-points $p_{0}$ and $q_{1}$ in common. Remark 2.2 tells us that

$$
\operatorname{deg}\left(\sigma g^{\prime}\left(\Lambda_{n}\right)\right)=\delta_{n}+1-m_{p_{i}}\left(\Lambda_{n}\right)-m_{q_{1}}\left(\Lambda_{n}\right)<\delta_{n}=D
$$

It remains to check that no three of the four points $p_{0}, p_{1}, p_{2}, q_{1}$ are collinear and that no three of the four points $p_{0}, p_{i}, q_{1}, q_{2}$ are collinear. Indeed, in the latter case all four points are base-points of $\Lambda_{n}$ and the image of $p_{i}$ by $\sigma g_{n}$ is a base-point of $\Lambda_{n+1}$, which does not have any infinitely near base-points. Therefore, no three of $p_{0}, p_{i}, q_{1}, q_{2}$ are collinear. In the first case, at least $p_{0}, p_{i}, q_{1}$ are base-points of $\Lambda_{n}$ and therefore not collinear by Remark 2.2. The points $p_{1}, p_{2}, q_{1}$ and the points $p_{0}, p_{2}, q_{1}$ are not collinear because $\Lambda_{n-1}$ has no infinitely near base-points. Thus, we can apply case (b1) to the maps $\sigma$ and $\sigma g^{\prime}$ and to the maps $\sigma$ and $\sigma g_{n} g^{\prime-1}$. The pair $(D, n)$ decreases.

So far we have been working with de Jonquières maps only. Now we will use the structure of the plane Cremona group as an almost amalgamated product from Theorem 1.3 to prove the Main Theorem:

Proof of Main Theorem. Let $G=\left\langle\sigma, \mathrm{PGL}_{3}(\mathbf{k}) \mid(1)-(5)\right\rangle$ be the group generated by $\sigma$ and $\mathrm{PGL}_{3}(\mathbf{k})$ divided by the relations (1)-(5), and let $\pi: G \rightarrow \operatorname{Bir}\left(\mathbb{P}^{2}\right)$ be the canonical homomorphism that sends generators onto generators. It follows from Proposition 3.1 that sending an element of $\mathcal{J}$ onto its corresponding word in $G$ is well defined. This yields a homomorphism $w: \mathcal{J} \longrightarrow G$ that satisfies
$\pi \circ w=\operatorname{Id}_{\mathcal{J}}$ and is therefore injective. Consider the commutative diagram

where all unnamed homomorphisms are the canonical inclusions. The universal property of the amalgamated product implies that there exists a unique homomorphism

$$
\varphi: \mathrm{PGL}_{3}(\mathbf{k}) *_{\mathrm{PGL}_{3}(\mathbf{k}) \cap \mathcal{J}} \mathcal{J} \rightarrow G
$$

such that the following diagram commutes:


By Theorem 1.3, the group $\operatorname{Bir}\left(\mathbb{P}^{2}\right)$ is isomorphic to $\mathrm{PGL}_{3}(\mathbf{k}) *_{\mathrm{PGL}_{3}(\mathbf{k}) \cap \mathcal{J}} \mathcal{J}$ divided by the relation $\tau \sigma \tau \sigma$, where $\tau=[y: x: z]$, which is a relation that holds as well in $G$. So $\varphi$ factors through the quotient $\mathrm{PGL}_{3}(\mathbf{k}) *_{\mathrm{PGL}_{3}(\mathbf{k}) \cap \mathcal{J}} \mathcal{J} /\langle\tau \sigma \tau \sigma\rangle$ and we thus obtain a homomorphism $\bar{\varphi}: \operatorname{Bir}\left(\mathbb{P}^{2}\right) \rightarrow G$. In fact, the homomorphisms $\pi$ and $\bar{\varphi}$ both send generators to generators:

$$
\begin{array}{llll}
G \stackrel{\pi}{\longrightarrow} \operatorname{Bir}\left(\mathbb{P}^{2}\right), & \sigma \longmapsto \sigma, & \alpha \longmapsto \alpha & \forall \alpha \in \mathrm{PGL}_{3} \\
\operatorname{Bir}\left(\mathbb{P}^{2}\right) \xrightarrow{\bar{\varphi}} G, & \sigma \longleftrightarrow \sigma, & \alpha \longmapsto \alpha & \forall \alpha \in \mathrm{PGL}_{3} .
\end{array}
$$

Hence $\bar{\varphi}$ and $\pi$ are isomorphisms that are inverse to each other.
