# FIXED POINTS IN SMOOTH CALOGERO-MOSER SPACES

#### Abstract

We prove that every irreducible component of the fixed point variety under the action of $\mu_{d}$ in a smooth Caloger-Moser space is isomorphic to a Calogero-Moser space associated with another reflection group.


Consider a finite subgroup $W \subset \mathbf{G L}_{\mathbb{C}}(V)$ of automorphisms of a finite dimensional complex vector space $V$, generated by reflections and let $c$ be a complex valued function on the set of conjugacy classes of reflections of $W$. To the triple ( $V, W, c$ ), Etingof and Ginzburg [8] have associated an affine variety $\mathscr{Z}_{c}(V, W)$, the Calogero-Moser space, which is defined as the spectrum of the center of the rational Cherednik algebra $\mathbf{H}_{c}$ "at $t=0$ " (see Section 1 for a precise definition). The algebra $\mathbf{H}_{c}$ carries a $\mathbb{Z}$-grading (i.e. a $\mathbb{C}^{\times}$action), which induces a $\mathbb{C}^{\times}$-action on the Calogero-Moser space $\mathscr{Z}_{c}(V, W)$.
We define a reflection subquotient of $(V, W)$ to be a pair $\left(V^{\prime}, W^{\prime}\right)$ where $V^{\prime}$ is a subspace of $V, W^{\prime} \subset \mathbf{G L}_{\mathbb{C}}\left(V^{\prime}\right)$ is generated by reflections and there exists a subgroup $H$ of $W$ which stabilizes $V^{\prime}$ and whose image in $\mathbf{G L}_{\mathbb{C}}\left(V^{\prime}\right)$ is exactly $W^{\prime}$.

Note that any element in $\mathbf{G L}_{\mathbb{C}}(V)$ normalizing $W$ acts on $\mathscr{Z}_{c}(V, W)$. In [4, Conjecture FIX], Rouquier and the first author proposed the following conjecture:

> Conjecture $\mathbf{F}$. Let $\sigma \in \mathbf{G L}_{\mathbb{C}}(V)$ be an element of finite order and normalizing $W$ and let $\mathscr{X}$ be an irreducible component of $\mathscr{Z}_{c}(V, W)^{\sigma}$ (endowed with its reduced scheme structure). Then there exists a reflection subquotient ( $V^{\prime}, W^{\prime}$ ) of $W$ and a complex valued function $c^{\prime}$ on the set of conjugacy classes of reflections in $W^{\prime}$ such that $\mathscr{X} \simeq \mathscr{Z}_{c^{\prime}}\left(V^{\prime}, W^{\prime}\right)$, as varieties endowed with a $\mathbb{C}^{\times}$-action.

Note that the conjecture stated in [4, Conjecture FIX] does not give an explicit description of $c^{\prime}$ in terms of $c$ : it is just mentioned that the map $c \mapsto c^{\prime}$ should be linear. Note also that, as stated, it might be a little bit optimistic: maybe one should replace $\mathscr{X}$ by its normalization (as it is not clear whether $\mathscr{X}$ is normal or not). A special case of an element $\sigma$ normalizing $W$ is when $\sigma$ is a root of unity, viewed as the corresponding homothety on $V$. The aim of this paper is to prove the following result:

Theorem. Conjecture $F$ holds if $\mathscr{Z}_{c}(V, W)$ is smooth and $\sigma$ is a root of unity.

The proof is by case-by-case analysis, as the triples $(V, W, c)$ such that $\mathscr{Z}_{c}(V, W)$ is smooth are classified (see the works of Etingof-Ginzburg [8], Gordon [10], Bellamy [1]). The classification and the conjecture can be easily reduced to the case where $W$ acts irreducibly on $V / V^{W}$ and in this case, the smoothness of $\mathscr{Z}_{c}(V, W)$ implies that $W$ is of type $G(l, 1, n)$ or $G_{4}$ in Shephard-Todd classification. The case of $G_{4}$ can be handled by computer calculations (see Section 5), while the infinite family case will be handled by using an isomorphism between $\mathscr{\mathscr { Z }}_{c}(V, W)$ and a quiver variety.

## 1. Notation and main result

All along this note, we will abbreviate $\otimes_{\mathbb{C}}$ as $\otimes$. By an algebraic variety, we mean a reduced scheme of finite type over $\mathbb{C}$.

Set-up. We fix in this paper a $\mathbb{C}$-vector space $V$ of finite dimension $n$ and a finite subgroup $W$ of $\mathbf{G L}_{\mathbb{C}}(V)$. We set

$$
\operatorname{Ref}(W)=\left\{s \in W \mid \operatorname{dim}_{\mathbb{C}} V^{s}=n-1\right\}
$$

and we assume that

$$
W=\langle\operatorname{Ref}(W)\rangle .
$$

We also fix an element $\sigma \in \mathbf{G L}_{\mathbb{C}}(V)$ of finite order normalizing $W$.
We set $\varepsilon: W \rightarrow \mathbb{C}^{\times}, w \rightarrow \operatorname{det}(w)$. If $s \in \operatorname{Ref}(W)$, we denote by $\alpha_{s}^{\vee}$ and $\alpha_{s}$ two elements of $V$ and $V^{*}$ respectively such that $V^{s}=\operatorname{Ker}\left(\alpha_{s}\right)$ and $V^{* s}=\operatorname{Ker}\left(\alpha_{s}^{\vee}\right)$, where $\alpha_{s}^{\vee}$ is viewed as a linear form on $V^{*}$.
1.A. Rational Cherednik algebra at $t=0$. - All along this note, we fix a function $c$ : $\operatorname{Ref}(W) \rightarrow \mathbb{C}$ which is invariant under conjugacy. We define the $\mathbb{C}$-algebra $\mathbf{H}_{c}$ to be the quotient of the algebra $\mathrm{T}\left(V \oplus V^{*}\right) \rtimes W$ (the semi-direct product of the tensor algebra $\mathrm{T}(V \oplus$ $V^{*}$ ) with the group $W$ ) by the relations
$\left(\mathscr{H}_{c}\right)$

$$
\left\{\begin{array}{l}
{\left[x, x^{\prime}\right]=\left[y, y^{\prime}\right]=0,} \\
{[y, x]=\sum_{s \in \operatorname{Ref}(W)}(\varepsilon(s)-1) c_{s} \frac{\left\langle y, \alpha_{s}\right\rangle\left\langle\alpha_{s}^{\vee}, x\right\rangle}{\left\langle\alpha_{s}^{\vee}, \alpha_{s}\right\rangle} s,}
\end{array}\right.
$$

for all $x, x^{\prime} \in V^{*}, y, y^{\prime} \in V$. The algebra $\mathbf{H}_{c}$ is called the rational Cherednik algebra at $t=0$.
The first commutation relations imply that we have morphisms of algebras $\mathbb{C}[V] \rightarrow \mathbf{H}_{c}$ and $\mathbb{C}\left[V^{*}\right] \rightarrow \mathbf{H}_{c}$. Recall [8, Corollary 4.4] that we have an isomorphism of $\mathbb{C}$-vector spaces

$$
\begin{equation*}
\mathbb{C}[V] \otimes \mathbb{C} W \otimes \mathbb{C}\left[V^{*}\right] \xrightarrow{\sim} \mathbf{H}_{c} \tag{1.1}
\end{equation*}
$$

induced by multiplication (this is the so-called PBW-decomposition).
We denote by $\mathbf{Z}_{c}$ the center of $\mathbf{H}_{c}$ : it is well-known [8, Lemma 3.5] that $\mathbf{Z}_{c}$ is an integral domain, which is integrally closed and contains $\mathbb{C}[V]^{W}$ and $\mathbb{C}\left[V^{*}\right]^{W}$ as subalgebras (so it contains $\left.\mathbf{P}=\mathbb{C}[V]^{W} \otimes \mathbb{C}\left[V^{*}\right]^{W}\right)$, and which is a free $\mathbf{P}$-module of rank $|W|$. We denote by $\mathscr{Z}_{c}$ the algebraic variety whose ring of regular functions $\mathbb{C}\left[\mathscr{Z}_{c}\right]$ is $\mathbf{Z}_{c}$ : this is the CalogeroMoser space associated with the datum $(V, W, c)$. If necessary, we will write $\mathscr{Z}_{c}(V, W)$ for $\mathscr{Z}_{c}$.

Example 1.2. - Let $l \geqslant 1$, let $\zeta$ be a primitive $l$-th root of unity and let $\mu_{l}=\langle\zeta\rangle$. We assume in this example that $n=1$ and $W=\langle t\rangle \simeq \mu_{l}$, where $t(v)=\zeta v$ for all $v \in V$. Then $\operatorname{Ref}(W)=\left\{t, t^{2}, \ldots, t^{l-1}\right\}$ and we set for simplification

$$
k_{j}=\frac{1}{l} \sum_{i=1}^{l-1} \zeta^{-i(j-1)} c_{t^{i}}
$$

$(0 \leqslant j \leqslant l-1)$. Note that $k_{0}+k_{1}+\cdots k_{l-1}=0$. Then

$$
\mathscr{Z}_{c} \simeq\left\{(x, y, e) \in \mathbb{C}^{3} \mid \prod_{i=0}^{l-1}\left(e-l k_{i}\right)=x y\right\}
$$

(see for instance [4, Theorem 18.2.2]). In particular, $\mathscr{Z}_{c}$ is smooth if and only if

$$
\prod_{0 \leqslant i<j \leqslant l-1}\left(k_{i}-k_{j}\right) \neq 0
$$

Note also that the inclusion $\mathbf{P} \subset \mathbf{Z}_{c}$ corresponds to the morphism of algebraic varieties $\mathscr{Z}_{c} \rightarrow \mathbb{C}^{2},(x, y, e) \mapsto(x, y)$.

The $\mathbb{C}^{\times}$-action is given by the formula

$$
\xi \cdot(x, y, e)=\left(\xi^{l} x, \xi^{-l} y, e\right)
$$

where $\xi \in \mathbb{C}^{\times}$and $(x, y, e) \in \mathscr{Z}_{c}$.
1.B. Action of the normalizer. - The normalizer $N_{\mathbf{G L}_{\mathbb{C}}(V)}(W)$ of $W$ in $\mathbf{G L}_{\mathbb{C}}(V)$ acts on $V$ naturally, on $V^{*}$ by the contragredient action and on $W$ by conjugation. This endows $\mathrm{T}\left(V \oplus V^{*}\right) \rtimes W$ with an action of $N_{\mathbf{G} \mathbf{L}_{\mathbb{C}}(V)}(W)$ and it is easily checked that the bunch of relations $\left(\mathscr{H}_{c}\right)$ is stable under this action. So $\mathbf{H}_{c}$ inherits an action of $N_{\mathbf{G L}_{\mathrm{C}}(V)}(W)$. In particular, its centre $\mathbf{Z}_{c}$ also inherits such an action, and this defines an action of $N_{\mathbf{G L}_{\mathbb{C}}(V)}(W)$ on the Calogero-Moser space $\mathscr{Z}_{c}$.

Theorem 1.3. - Assume that $\mathscr{Z}_{c}$ is smooth and that $\sigma$ is a root of unity, and let $\mathscr{X}$ be an irreducible component of $\mathscr{Z}_{c}^{\sigma}$. Then there exists a reflection subquotient $\left(V^{\prime}, W^{\prime}\right)$ of $(V, W)$ and a complex-valued map $c^{\prime}$ on the set of conjugacy classes of reflections of $W^{\prime}$ such that

$$
\mathscr{X} \simeq \mathscr{Z}_{c^{\prime}}\left(V^{\prime}, W^{\prime}\right),
$$

as varieties endowed with a $\mathbb{C}^{\times}$-action.

Remark 1.4. - Note that if $\mathscr{X}$ is reduced to a point, then the theorem is easy because in this case, $\mathscr{X} \simeq \mathscr{Z}_{0}(0,1)$.

This Theorem will be proved in Sections 3 and 5.
1.C. Filtration of the group algebra. - If $w \in W$, we set $\operatorname{cod}(w)=\operatorname{codim}_{\mathbb{C}}\left(V^{w}\right)$. We define a filtration $\mathscr{F}_{\bullet}(\mathbb{C} W)$ of the group algebra of $W$ as follows: let

$$
\mathscr{F}_{i}(\mathbb{C} W)=\bigoplus_{\operatorname{cod}(w) \leqslant i} \mathbb{C} w
$$

Then

$$
\mathbb{C} \operatorname{Id}_{V}=\mathscr{F}_{0}(\mathbb{C} W) \subset \mathscr{F}_{1}(\mathbb{C} W) \subset \cdots \subset \mathscr{F}_{n}(\mathbb{C} W)=\mathbb{C} W=\mathscr{F}_{n+1}(\mathbb{C} W)=\cdots
$$

is a filtration of $\mathbb{C} W$. For any subalgebra $A$ of $\mathbb{C} W$, we set $\mathscr{F}_{i}(A)=A \cap \mathscr{F}_{i}(\mathbb{C} W)$, so that

$$
\mathbb{C I d}_{V}=\mathbb{C} \mathscr{F}_{0}(A) \subset \mathscr{F}_{1}(A) \subset \cdots \subset \mathscr{F}_{n}(A)=A=\mathscr{F}_{n+1}(A)=\cdots
$$

is also a filtration of $A$.
Now, assume that $\mathscr{Z}_{c}(V, W)$ is smooth, let $\sigma$ be a root of unity and let $\mathscr{X}$ be an irreducible component of $\mathscr{Z}_{c}(V, W)^{\sigma}$. According to Theorem 1.3, there exists a reflection subquotient $\left(V^{\prime}, W^{\prime}\right)$ of $(V, W)$, a complex-valued map $c^{\prime}$ on the set of conjugacy classes of reflections of $W^{\prime}$ and a $\mathbb{C}^{\times}$-equivariant isomorphism $i: \mathscr{Z}_{c^{\prime}}\left(V^{\prime}, W^{\prime}\right) \xrightarrow{\sim} \mathscr{X}$. We will view $i$ as a closed immersion $i: \mathscr{Z}_{c^{\prime}}\left(V^{\prime}, W^{\prime}\right) \hookrightarrow \mathscr{Z}_{c}(V, W)$. By [10, Corollary 5.8], the smoothness of $\mathscr{Z}_{c}(V, W)$ implies that there exists a bijection between $\operatorname{Irr}(W)$ and $\mathscr{Z}_{c}(V, W){ }^{\mathbb{C}^{\times}}$. As the fixed point variety of a finite group in a smooth complex algebraic variety is still smooth, this means that $\mathscr{X}$ is smooth, and so $\mathscr{Z}_{c^{\prime}}\left(V^{\prime}, W^{\prime}\right)$ is smooth. Applying again [10, Corollary 5.8], we get another bijection between $\operatorname{Irr}\left(W^{\prime}\right)$ and $\mathscr{Z}_{c^{\prime}}\left(V^{\prime}, W^{\prime}\right)^{\mathbb{C}^{\times}}$. As $\mathscr{X}^{\mathbb{C}^{\times}} \subset \mathscr{Z}_{c}(V, W)^{\mathbb{C}^{\times}}$, this gives an injective map $i_{\mathscr{X}}: \operatorname{Irr}\left(W^{\prime}\right) \hookrightarrow \operatorname{Irr}(W)$, depending on $\mathscr{X}$ and the choice of $i$. This allows to define a surjective morphism of algebras

$$
i_{\mathscr{X}}^{*}: \mathrm{Z}(\mathbb{C} W) \longrightarrow \mathrm{Z}\left(\mathbb{C} W^{\prime}\right)
$$

as follows: if $\chi \in \operatorname{Irr}(W)$, let $e_{\chi}^{W}$ denote the corresponding primitive central idempotent of $\mathbb{C} W$ and set

$$
i_{\mathscr{X}}^{*}\left(e_{\chi}^{W}\right)= \begin{cases}e_{\chi^{\prime}}^{W^{\prime}} & \text { if } \chi^{\prime} \in \operatorname{Irr}\left(W^{\prime}\right) \text { is such that } i_{\mathscr{X}}\left(\chi^{\prime}\right)=\chi \\ 0 & \text { if } \chi \text { is does not belong to the image of } i_{\mathscr{X}}\end{cases}
$$

Using results of Shan and the first author [5], Theorem 1.3 has the following consequence:

Corollary 1.5. - If $i \geqslant 0$, then $i_{\mathscr{X}}^{*}\left(\mathscr{F}_{i}(\mathrm{Z}(\mathbb{C} W))\right) \subset \mathscr{F}_{i}\left(\mathrm{Z}\left(\mathbb{C} W^{\prime}\right)\right)$.

Proof. - If $\mathscr{Y}$ is a complex algebraic variety endowed with a $\mathbb{C}^{\times}$-action, we denote by $\mathrm{H}_{\mathbb{C}^{\times}}^{i}(\mathscr{Y})$ the $i$-th group of equivariant cohomology, with coefficients in $\mathbb{C}$. Let $\hbar$ be an indeterminate and identify $\mathrm{H}_{\mathbb{C}_{\times} \times}(\mathbf{p t})$ with $\mathbb{C}[\hbar]$ as usual, with $\hbar$ homogeneous of degree 2 . Since $\mathscr{Z}_{c}(V, W)$ is smooth, it follows from [5, Theorem A] that

$$
\begin{cases}\mathrm{H}_{\mathbb{C} \times}^{2 i+1}\left(\mathscr{Z}_{c}(V, W)\right)=0 & \text { if } i \geqslant 0 \\ \mathrm{H}_{\mathbb{C}^{\times}}^{2 \bullet} \simeq \operatorname{Rees}_{\mathscr{F}}(\mathrm{Z}(\mathbb{C} W)) & \text { as } \mathbb{C}[\hbar] \text {-algebras }\end{cases}
$$

where $\operatorname{Rees}_{\mathscr{F}}(\mathrm{Z}(\mathbb{C} W))=\bigoplus_{i \geqslant 0} \hbar^{i} \mathscr{F}_{i}(\mathrm{Z}(\mathbb{C} W)) \subset \mathbb{C}[\hbar] \otimes_{\mathbb{C}} \mathrm{Z}(\mathbb{C} W)$ is the Rees algebra associated with the filtration $\mathscr{F}_{\bullet}(\mathrm{Z}(\mathbb{C} W))$. Using the analogous result for $\mathscr{Z}_{c^{\prime}}\left(V^{\prime}, W^{\prime}\right)$ and the functoriality of equivariant cohomology, we get a morphism of algebras $i^{*}: \operatorname{Rees}_{\mathscr{F}}(\mathrm{Z}(\mathbb{C} W)) \longrightarrow$ Rees $_{\mathscr{F}}\left(\mathrm{Z}\left(\mathbb{C} W^{\prime}\right)\right)$.

Now, we will use not only [5, Theorem A] but also its proof: the proof goes by restriction to the fixed point subvariety $\mathscr{Z}_{c}(V, W)^{\mathbb{C}^{\times}}$and identifying $\mathrm{H}_{\mathbb{C}^{\times}}^{2 \bullet}\left(\mathscr{Z}_{c}(V, W)^{\mathbb{C}^{\times}}\right)$with $\mathbb{C}[\hbar] \otimes \mathrm{Z}(\mathbb{C} W)$ using $[10$, Corollary 5.8$]$. As the same strategy holds for $\mathscr{Z}_{c^{\prime}}\left(V^{\prime}, W^{\prime}\right)$, the
functoriality of equivariant cohomology implies that the map $i^{*}$ fits into a commutative diagram


This shows the corollary.

## 2. Preliminaries on quiver varieties

2.A. Quiver varieties. - Let $Q_{l}$ denote the cyclic quiver with $l$ vertices, defined as follows:

- Vertices: $i \in \mathbb{Z} / l \mathbb{Z}$;
- Arrows: $y_{i}: i \longrightarrow i+1, i \in \mathbb{Z} / l \mathbb{Z}$.

We denote by $\bar{Q}_{l}$ the double quiver of $Q_{l}$ that is, the quiver obtained from $Q_{l}$ by adding an arrow $x_{i}: i+1 \rightarrow i$ for all $i \in \mathbb{Z} / l \mathbb{Z}$ (see Figure 1).


Fig. 1. The quiver $\bar{Q}_{l}$
Now, if $d=\left(d_{i}\right)_{i \in \mathbb{Z} / l \mathbb{Z}}$ is a family of elements of $\mathbb{N}$, we denote by $\mathbf{G L}(d)$ the direct product

$$
\mathbf{G L}(d)=\prod_{i \in \mathbb{Z} / l \mathbb{Z}} \mathbf{G L}_{d_{i}}(\mathbb{C})
$$

by $\Delta \mathbb{C}^{\times}$the image of $\mathbb{C}^{\times}$in $\mathbf{G L}(d)$ through the diagonal embedding $\Delta: \mathbb{C}^{\times} \hookrightarrow \mathbf{G L}(d)$ and we set

$$
\operatorname{PGL}(d)=\mathbf{G L}(d) / \Delta \mathbb{C}^{\times}
$$

The group $\operatorname{PGL}(d)$ acts on the variety $\operatorname{Rep}\left(\bar{Q}_{l}, d\right)$ of representations of $\bar{Q}_{l}$ in the family of vector spaces $\left(\mathbb{C}^{d_{i}}\right)_{i \in \mathbb{Z} / l \mathbb{Z}}$. The orbits are the isomorphism classes of representations of $\bar{Q}_{l}$ of dimension vector $d$. We denote by

$$
\mu_{d}: \begin{array}{ccc}
\operatorname{Rep}\left(\bar{Q}_{l}, d\right) & \longrightarrow & \bigoplus_{i \in \mathbb{Z} / l \mathbb{Z}} \operatorname{Mat}_{d_{i}}(\mathbb{C}) \\
\left(X_{i}, Y_{i}\right)_{i \in \mathbb{Z} / l \mathbb{Z}} & \longmapsto & \left(X_{i} Y_{i}-Y_{i-1} X_{i-1}\right)_{i \in \mathbb{Z} / l \mathbb{Z}}
\end{array}
$$

the corresponding moment map. Finally, if $\theta=\left(\theta_{i}\right)_{i \in \mathbb{Z} / l \mathbb{Z}}$ is a family of complex numbers, we denote by $\mathrm{I}_{\theta}(d)$ the family $\left(\theta_{i} \operatorname{Id}_{\mathbb{C}^{d_{i}}}\right)_{i \in \mathbb{Z} / I \mathbb{Z}}$ and by $\mathscr{\sigma}_{\theta}(d)$ the closed subvariety of $\operatorname{Mat}_{d_{0}}(\mathbb{C})$ consisting of matrices of rank $\leqslant 1$ and trace $-\sum_{i \in \mathbb{Z} / / \mathbb{Z}} \theta_{i} d_{i}$. Finally, we set

$$
\mathscr{Y}_{\theta}(d)=\mu_{d}^{-1}\left(\mathrm{I}_{\theta}(d)+\mathscr{O}_{\theta}(d)\right) \quad \text { and } \quad \mathscr{X}_{\theta}(d)=\mathscr{Y}_{\theta}(d) / / \mathbf{P G L}(d) .
$$

We will usually denote an element $\left(X_{i}, Y_{i}\right)_{i \in \mathbb{Z} / l \mathbb{Z}}$ of $\mathscr{Y}_{\theta}(d)$ by $(X, Y)$, where $X=\left(X_{i}\right)_{i \in \mathbb{Z} / l \mathbb{Z}}$ and $Y=\left(Y_{i}\right)_{i \in \mathbb{Z} / l \mathbb{Z}}$. Note that $\mathscr{\mathscr { Y }}_{\theta}(d)$ is endowed with a $\mathbb{C}^{\times}$-action: if $\xi \in \mathbb{C}^{\times}$, we set

$$
\xi \cdot(X, Y)=\left(\xi^{-1} X, \xi Y\right)
$$

This action commutes with the action of $\mathbf{G L}(d)$ and the moment map is constant on $\mathbb{C}^{\times}$orbits, so it induces a $\mathbb{C}^{\times}$-action on $\mathscr{X}_{\theta}(d)$.

Remark 2.1. - We extend the definition of $\mathscr{X}_{\theta}(d)$ to the case where $d \in \mathbb{Z}^{\mathbb{Z}} / l \mathbb{Z}$ by the convention that $\mathscr{X}_{\theta}(d)=\varnothing$ whenever at least one of the $d_{i}$ 's is negative.
2.B. Action of the affine Weyl group. - If $l \geqslant 2$, let $W_{l}^{\text {aff }}$ denote the affine Weyl group of type $\tilde{A}_{l-1}$. It is the Coxeter group with associated Coxeter system ( $W_{l}^{\text {aff }}, S_{l}^{\text {aff }}$ ), where $S_{l}^{\text {aff }}=\left\{s_{i} \mid i \in \mathbb{Z} / l \mathbb{Z}\right\}$ and the Coxeter graph is given by


Fig. 2. Coxeter graph of ( $\left.W_{l}^{\text {aff }}, S_{l}^{\text {aff }}\right)$
We extend this notation to the case where $l=1$ by setting $W_{1}^{\text {aff }}=1$.
Consider the Lie algebra $\mathfrak{g}_{l}=\mathfrak{s l}_{l}(\mathbb{C})$ and its affine version $\widehat{\mathfrak{g}}_{l}=\widehat{\mathfrak{s l}}_{l}(\mathbb{C})=\mathfrak{s l}_{l}(\mathbb{C})\left[t, t^{-1}\right] \oplus$ $\mathbb{C} \mathbf{1} \oplus \mathbb{C} \partial$. Let $\mathfrak{h} \subset \mathfrak{g}$ be the Cartan subalgebra formed by the diagonal matrices and set $\widehat{\mathfrak{h}}=\mathfrak{h} \oplus \mathbb{C} \mathbf{1} \oplus \mathbb{C} \partial$.

The $\mathbb{C}$-vector space $\widehat{\mathfrak{h}}^{*}$ has a basis $\left(\alpha_{0}, \alpha_{1}, \ldots, \alpha_{l-1}, \Lambda_{0}\right)$, where $\alpha_{0}, \alpha_{1}, \ldots, \alpha_{l-1}$ are the simple roots of $\widehat{\mathfrak{g}}_{l}$ and $\Lambda_{0}$ is such that $\Lambda_{0}$ annihilates $\mathfrak{h}$ and $\partial$ and $\Lambda_{0}(\mathbf{1})=1$. Denote by $R_{l}^{\text {aff }}$ and $R_{l}$ the affine and the non-affine root lattices respectively (i.e., $R_{l}^{\text {aff }}$ is the $\mathbb{Z}$-lattice generated by $\alpha_{0}, \alpha_{1}, \ldots, \alpha_{l-1}$ and $R_{l}$ is the sublattice generated by $\alpha_{1}, \ldots, \alpha_{l-1}$.)

Following [17], we define two actions of $W_{l}^{\text {aff: }}$ a non-linear one on $\mathbb{Z}^{\mathbb{Z} / l \mathbb{Z}}$, and a linear one on $\mathbb{C}^{\mathbb{Z}} / l \mathbb{Z}$. If $l=1$, there is nothing to define so we may assume that $l \geqslant 2$. If $d=$ $\left(d_{i}\right)_{i \in \mathbb{Z} / l \mathbb{Z}} \in \mathbb{Z}^{\mathbb{Z} / l \mathbb{Z}}$ and if $j \in \mathbb{Z} / l \mathbb{Z}$, we set $s_{j}(d)=\left(d_{i}^{\prime}\right)_{i \in \mathbb{Z} / l \mathbb{Z}}$, where

$$
d_{i}^{\prime}= \begin{cases}d_{i} & \text { if } i \neq j, \\ \delta_{j 0}+d_{i+1}+d_{i-1}-d_{i} & \text { if } i=j\end{cases}
$$

Remark 2.2. - We can identify $\mathbb{Z}^{\mathbb{Z} / l \mathbb{Z}}$ with the root lattice $R_{l}^{\text {aff }}$ by

$$
d \mapsto \sum_{i \in \mathbb{Z} / l \mathbb{Z}} d_{i} \alpha_{i}
$$

Beware, the action considered here is not the usual action of $W_{l}^{\text {aff }}$ on the root lattice. When we have $w(d)=d^{\prime}$ with respect to the action define above, this corresponds to $w\left(\Lambda_{0}-d\right)=\Lambda_{0}-d^{\prime}$ for the usual action of $W_{l}^{\text {aff }}$ on $\widehat{\mathfrak{h}}^{*}$.

If $\theta=\left(\theta_{i}\right)_{i \in \mathbb{Z} / l \mathbb{Z}} \in \mathbb{C}^{\mathbb{Z}} / l \mathbb{Z}$, we set $s_{j}(\theta)=\left(\theta_{i}^{\prime}\right)_{i \in \mathbb{Z} / l \mathbb{Z}}$, where

$$
\theta_{i}^{\prime}= \begin{cases}\theta_{i} & \text { if } i \notin\{j-1, j, j+1\} \\ \theta_{j}+\theta_{i} & \text { if } i \in\{j-1, j+1\} \\ -\theta_{i} & \text { if } i=j\end{cases}
$$

It is readily seen that these definitions on generators extend to an action of the whole group $W_{l}^{\text {aff }}$. We also define a pairing $\mathbb{Z}^{\mathbb{Z} / l \mathbb{Z}} \times \mathbb{C}^{\mathbb{Z} / l \mathbb{Z}} \rightarrow \mathbb{C},(d, \theta) \mapsto d \cdot \theta$, where

$$
d \cdot \theta=\sum_{i \in \mathbb{Z} / l \mathbb{Z}} d_{i} \theta_{i}
$$

Then

$$
\begin{equation*}
s_{j}(d) \cdot s_{j}(\theta)=(d \cdot \theta)-\delta_{j 0} \theta_{0} \tag{2.3}
\end{equation*}
$$

It is proved in [17, Corollary 3.6] that

$$
\begin{equation*}
\mathscr{X}_{s_{j}(\theta)}\left(s_{j}(d)\right) \simeq \mathscr{X}_{\theta}(d) \quad \text { if } \theta_{j} \neq 0 \tag{2.4}
\end{equation*}
$$

Note that this isomorphism takes into account the convention of Remark 2.1.
Recall also from $[8, \S 11]$ the following result, which follows from the fact that $\mathscr{X}_{\theta}\left(n \delta_{l}\right)$ is isomorphic to some Calogero-Moser space.

Lemma 2.5. - If $n \geqslant 0$, then $\mathscr{X}_{\theta}\left(n \delta_{l}\right)$ is normal and irreducible of dimension $2 n$.

Recall that the affine Weyl group has another presentation. We have $W_{l}^{\text {aff }}=W_{l} \ltimes R_{l}$, where $W_{l}=\mathfrak{S}_{l}$ is the non-affine Weyl group, that is, the subgroup generated by $s_{1}, \ldots$, $s_{l-1}$. For each $\alpha \in R_{l}$, denote by $t_{\alpha}$ the image of $\alpha$ in $W_{l}^{\text {aff }}$. Each element of $W_{l}^{\text {aff }}$ can be written in a unique way in the form $w \cdot t_{\alpha}$, where $w \in W_{l}$ and $\alpha \in R_{l}$. Let $\delta_{l}$ denote the constant family $\delta=(1)_{i \in \mathbb{Z} / l \mathbb{Z}} \in \mathbb{Z}^{\mathbb{Z} / l \mathbb{Z}}$. In the following lemma we identify $\mathbb{Z}^{\mathbb{Z} / l \mathbb{Z}}$ with $R_{l}^{\text {aff }}$.

Lemma 2.6. - Assume $\alpha \in R_{l}$ and $d \in \mathbb{Z}^{\mathbb{Z}} / l \mathbb{Z}$. Then we have $t_{\alpha}(d) \equiv d-\alpha \bmod \mathbb{Z} \delta_{l}$.

Proof. - This statement is a partial case of [13, (6.5.2)] (see also Remark 2.2).

Lemma 2.7. - For each $d \in \mathbb{Z}^{\mathbb{Z}} / l \mathbb{Z}$, there exists a unique $n \in \mathbb{Z}$ such that $d$ and $n \delta_{l}$ are in the same $W_{l}^{\text {aff }}$-orbit.

Proof. - Let us prove the existence of $n$. Set $\alpha=d-d_{0} \delta_{l}$. Then $\alpha$ is clearly an element of $R_{l}$. Then by Lemma 2.6, the element $t_{\alpha}(d)$ is of the form $n \delta_{l}$.

Let us prove the uniqueness of $n$. Assume that $n_{1} \delta_{l}$ and $n_{2} \delta_{l}$ are in the same $W_{l}^{\text {aff }}$ orbit. Since $n_{1} \delta_{l}$ is $W_{l}$-stable, the $W_{l}^{\text {aff }}$-orbit of $n_{1} \delta_{l}$ coincides with the $R_{l}$-orbit of $n_{1} \delta_{l}$. So there exists $\alpha \in R_{l}$ such that $t_{\alpha}\left(n_{1} \delta_{l}\right)=n_{2} \delta_{l}$. By Lemma 2.6, this forces $\alpha=0$ and $n_{1}=n_{2}$.

Consider the $\mathbb{Z}$-linear map

$$
R_{l}^{\text {aff }} \rightarrow \mathbb{C}^{\mathbb{Z} / l \mathbb{Z}}, \quad d \mapsto \bar{d},
$$

given by

$$
\left(\overline{\alpha_{r}}\right)_{i}=2 \delta_{i, r}-\delta_{i, r+1}-\delta_{i, r-1} .
$$

The kernel of this map is $\mathbb{Z} \delta_{l}$. Set

$$
\Sigma(\theta)=\sum_{i \in \mathbb{Z} / l \mathbb{Z}} \theta_{i} .
$$

Lemma 2.8. - For each $\alpha \in R_{l}$ and $\theta \in \mathbb{C}^{\mathbb{Z} / l \mathbb{Z}}$, we have $t_{\alpha}(\theta)=\theta+\Sigma(\theta) \bar{\alpha}$.

Proof. - The $W_{l}^{\text {aff }}$-action on $\mathbb{C}^{\mathbb{Z} / l \mathbb{Z}}$ defined above coincides with the (usual) action of $W_{l}^{\text {aff }}$ on the dual of the span of $\alpha_{0}, \alpha_{1}, \ldots, \alpha_{l-1}$ in $\widehat{\mathfrak{h}}^{*}$. The statement follows from [13, (6.5.2)].

We denote by $\left(\mathbb{Z}^{\mathbb{Z}} / l \mathbb{Z}\right)_{+}$the set of $d \in \mathbb{Z}^{\mathbb{Z} / l \mathbb{Z}}$ which belong to the orbit of some $n \delta_{l}$, with $n \geqslant 0$. This set has a more precise combinatorial description. For example, it will follow from Proposition 4.4 that an element $d \in \mathbb{Z}^{\mathbb{Z}} / l \mathbb{Z}$ is in $\left(\mathbb{Z}^{\mathbb{Z} / l \mathbb{Z}}\right)_{+}$if and only if $d$ is a residue of some Young diagram. In particular, the set $\left(\mathbb{Z}^{\mathbb{Z} / l \mathbb{Z}}\right)_{+}$is contained in $\mathbb{N}^{\mathbb{Z} / l \mathbb{Z}}$.

Lemma 2.9. - Assume that $d \in \mathbb{Z}^{\mathbb{Z} / l \mathbb{Z}}$ is such that there exists a simple representation in $\mathscr{Y}_{\theta}(d)$. Then
(a) the variety $\mathscr{X}_{\theta}(d)$ is normal and irreducible,
(b) we have $d \in\left(\mathbb{Z}^{\mathbb{Z} / l \mathbb{Z}}\right)_{+}$.

Proof. - Let $n \in \mathbb{Z}$ and $w \in W_{l}^{\text {aff }}$ be such that $n \delta_{l}=w(d)$. Let us show that (2.4) implies an isomorphism $\mathscr{X}_{\theta}(d) \simeq \mathscr{X}_{w(\theta)}\left(n \delta_{l}\right)$. (In particular, we must have $n \geqslant 0$.) The only difficulty that we have is caused by the condition $\theta_{i} \neq 0$ in (2.4). But [7, Lemma 7.2] implies that we can find a sequence of reflections such that $s_{i_{1}} s_{i_{2}} \ldots s_{i_{r}}(d)=n \delta_{l}$ and such that we can apply a sequence of isomorphisms (2.4) with no danger to get $\theta_{i_{j}}=0$ while applying $s_{i_{j}}$.
2.C. Smoothness. - The following result is proved in [11, Lemma 4.3 and its proof] (which is based on [15, Theorem 1.2] and [7, Theorem 1.2]):

Theorem 2.10. - Let $n \geqslant 0$. Then the following are equivalent:
(1) The variety $\mathscr{X}_{\theta}\left(n \delta_{l}\right)$ is smooth.
(2) Every element of $\mathscr{Y}_{\theta}\left(n \delta_{l}\right)$ defines a simple representation of the quiver $\bar{Q}_{l}$.
(3) The family $\theta$ satisfies

$$
\Sigma(\theta) \prod_{\substack{1 \leqslant i \leqslant j \leqslant l-1 \\-(n-1) \leqslant k \leqslant n-1}}\left(\left(\theta_{i}+\theta_{i+1}+\cdots+\theta_{j}\right)+k \Sigma(\theta)\right) \neq 0
$$

If these equivalent conditions hold, then $\operatorname{PGL}\left(n \delta_{l}\right)$ acts freely on $\mathscr{Y}_{\theta}\left(n \delta_{l}\right)$, and so, as a set, $\mathscr{X}_{\theta}\left(n \delta_{l}\right)$ identifies with $\mathbf{G L}\left(n \delta_{l}\right)$-orbits in $\mathscr{Y}_{\theta}\left(n \delta_{l}\right)$.
2.D. Fixed points. - For every $m \geqslant 1$, the group of $m$-th roots of unity $\boldsymbol{\mu}_{m}$ acts on $\mathscr{X}_{\theta}\left(n \delta_{l}\right)$ (this is the restriction of the $\mathbb{C}^{\times}$-action defined in $\S 2 . \mathrm{A}$ ). We aim to compute the fixed point variety $\mathscr{X}_{\theta}\left(n \delta_{l}\right)^{\mu_{m}}$ whenever $\mathscr{X}_{\theta}\left(n \delta_{l}\right)$ is smooth. Note first that $\mu_{l}$ acts trivially on $\mathscr{X}_{\theta}\left(n \delta_{l}\right)$ : indeed, if $\zeta \in \mu_{l}$ and if $(X, Y) \in \mathscr{Y}_{\theta}\left(n \delta_{l}\right)$, then $\zeta \cdot(X, Y)=g_{0}(X, Y)$, where $g_{0}=\left(\zeta^{i} \operatorname{Id}_{\mathbb{C}^{n}}\right)_{i \in \mathbb{Z} / l \mathbb{Z}} \in \mathbf{G L}\left(n \delta_{l}\right)$. This means that, in order to describe $\mathscr{X}_{\theta}\left(n \delta_{l}\right)^{\mu_{m}}$, we may replace $\boldsymbol{\mu}_{m}$ by $\left\langle\boldsymbol{\mu}_{m}, \boldsymbol{\mu}_{l}\right\rangle$ or, in other words, we may assume that $l$ divides $m$.

Hypothesis. We fix in this subsection a non-zero natural number $k$ and we set $m=k l$.

If $\theta=\left(\theta_{i}\right)_{i \in \mathbb{Z} / l \mathbb{Z}} \in \mathbb{C}^{\mathbb{Z} / l \mathbb{Z}}$, we define $\theta[k]$ to be the element $\left(\theta[k]_{j}\right)_{j \in \mathbb{Z} / m \mathbb{Z}}$ such that

$$
\theta[k]_{j}=\theta_{i}
$$

if $j \equiv i \bmod l$. Roughly speaking, $\theta[k]$ is the concatenation of $k$ copies of $\theta$.
We denote by $\mathbb{Z}^{\mathbb{Z} / m \mathbb{Z}}\left[n \delta_{l}\right]$ the set of $d=\left(d_{j}\right)_{j \in \mathbb{Z} / m \mathbb{Z}} \in \mathbb{Z}^{\mathbb{Z} / m \mathbb{Z}}$ such that

$$
n=\sum_{\substack{j \in \mathbb{Z} / m \mathbb{Z} \\ j \equiv i \bmod l}} d_{j}
$$

for all $i \in \mathbb{Z} / l \mathbb{Z}$. Set also $\mathscr{E}(k, l, n)=\mathbb{Z}^{\mathbb{Z} / m \mathbb{Z}}\left[n \delta_{l}\right] \cap\left(\mathbb{Z}^{\mathbb{Z}} / m \mathbb{Z}\right)_{+}$. If $d \in \mathscr{E}(k, l, n)$ and $(X, Y) \in$ $\operatorname{Rep}\left(\bar{Q}_{m}, d\right)$, we set

$$
i_{k}^{(d)}(X, Y)=\left(X^{\prime}, Y^{\prime}\right)
$$

where $X_{i}^{\prime}=\bigoplus_{\substack{j \in \mathbb{Z} / m \mathbb{Z} \\ j=i \bmod l}} X_{j}$ and $Y_{i}^{\prime}=\bigoplus_{\substack{j \in \mathbb{Z} / m \mathbb{Z} \\ j=i \bmod l}} Y_{j}$. By the definition of $\mathscr{E}(k, l, n)$, we have $j \equiv i \bmod l=\underset{j \equiv i \bmod l}{ }$
$X_{i}^{\prime}, Y_{i}^{\prime} \in \operatorname{Mat}_{n}(\mathbb{C})$. In other words, $\left(X^{\prime}, Y^{\prime}\right) \in \operatorname{Rep}\left(\bar{Q}_{l}, n \delta_{l}\right):$ it is clear that $i_{k}^{(d)}: \operatorname{Rep}\left(\bar{Q}_{m}, d\right) \hookrightarrow$ $\operatorname{Rep}\left(\bar{Q}_{l}, n \delta_{l}\right)$ is a closed immersion.

Lemma 2.11. - If $d \in \mathscr{E}(k, l, n)$ and $(X, Y) \in \mathscr{Y}_{\theta[k]}(d)$, then $i_{k}^{(d)}(X, Y) \in \mathscr{Y}_{\theta}\left(n \delta_{l}\right)$.

Proof. - Write $i_{k}^{(d)}(X, Y)=\left(X^{\prime}, Y^{\prime}\right)$ and let $i \in \mathbb{Z} / l \mathbb{Z}$. Write $p_{0}$ for the rank one matrix $X_{0} Y_{0}-Y_{-1} X_{-1}-\theta[k]_{0} \operatorname{Id}_{\mathbb{C}^{d_{0}}}$. Then

$$
\begin{aligned}
X_{i}^{\prime} Y_{i}^{\prime}-Y_{i-1}^{\prime} X_{i-1}^{\prime} & =\bigoplus_{\substack{j \in \mathbb{Z} / m \mathbb{Z} \\
j \equiv i \bmod l}}\left(X_{j} Y_{j}-Y_{j-1} X_{j-1}\right) \\
& =\bigoplus_{\substack{j \in \mathbb{Z} / m \mathbb{Z} \\
j \equiv i \bmod l}} \theta[k]_{j} \operatorname{Id}_{\mathbb{C}^{d_{j}}}+\delta_{0 i} p_{0} \\
& =\theta_{i} \mathrm{Id}_{\mathbb{C}^{n}}+\delta_{0 i} p_{0}
\end{aligned}
$$

as desired.

It is also clear that, if $(X, Y)$ and $(\widetilde{X}, \widetilde{Y})$ are two elements of $\mathscr{Y}_{\theta[k]}(d)$ which are conjugate under $\mathbf{G L}(d)$, then $i_{k}^{(d)}(X, Y)$ and $i_{k}^{(d)}(\widetilde{X}, \widetilde{Y})$ are conjugate under $\mathbf{G L}\left(n \delta_{l}\right)$. This means that $i_{k}^{(d)}$ induces a morphism of algebraic varieties still denoted by

$$
i_{k}^{(d)}: \mathscr{X}_{\theta[k]}(d) \longrightarrow \mathscr{X}_{\theta}\left(n \delta_{l}\right)
$$

For $d \in \mathscr{E}(k, l, n)$, set

$$
\mathscr{X}_{d}=i_{k}^{(d)}\left(\mathscr{X}_{\theta[k]}(d)\right) \subset \mathscr{X}_{\theta}\left(n \delta_{l}\right)
$$

For the moment, we allow the possibility that the varieties $\mathscr{X}_{\theta[k]}(d)$ and $\mathscr{X}_{d}$ are empty. Set

$$
\mathscr{E}(k, l, n)_{\neq \varnothing}=\left\{d \in \mathscr{E}(k, l, n) ; \mathscr{X}_{d} \neq \varnothing\right\} .
$$

But we will show in Corollary 4.13 that we have $\mathscr{E}(k, l, n)_{\neq \varnothing}=\mathscr{E}(k, l, n)$.
The next result describes the fixed point variety $\mathscr{X}_{\theta}\left(n \delta_{l}\right)^{\mu_{m}}$ : it is the main step towards the proof of Theorem 1.3.

Theorem 2.12. - Assume that $\mathscr{X}_{\theta}\left(n \delta_{l}\right)$ is smooth. Then:
(a) $\mathscr{X}_{\theta}\left(n \delta_{l}\right)^{\mu_{m}}$ is smooth.
(b) We have

$$
\mathscr{X}_{\theta}\left(n \delta_{l}\right)^{\mu_{m}}=\coprod_{d \in \mathscr{\delta}(k, l, n)_{\neq \varnothing}} \mathscr{X}_{d}
$$

and $\mathscr{X}_{d}$ are exactly the irreducible components of $\mathscr{X}_{\theta}\left(n \delta_{l}\right)^{\mu_{m}}$.
(c) If $d \in \mathscr{E}(k, l, n)_{\neq \varnothing}$, then $i_{k}^{(d)}: \mathscr{X}_{\theta[k]}(d) \rightarrow \mathscr{X}_{d}$ is an isomorphism.

Proof. - (a) follows from the fact already mentioned in the proof of Corollary 1.5 that the fixed point variety under the action of a finite group on a smooth variety is again smooth.

We will now prove (b). Let $\xi$ be a primitive $m$-th root of unity and let $\zeta=\xi^{k}$ (it is a primitive $l$-th root of unity). Let $g_{0}$ denote the element $\left(\zeta^{i} \mathrm{Id}_{\mathbb{C}^{n}}\right)_{i \in \mathbb{Z} / l \mathbb{Z}}$ in $\mathbf{G L}\left(n \delta_{l}\right)$. This element satisfies

$$
\begin{equation*}
{ }^{g_{0}}(X, Y)=\left(\zeta^{-1} X, \zeta Y\right) \tag{*}
\end{equation*}
$$

for all $(X, Y) \in \mathscr{Y}_{\theta}\left(n \delta_{l}\right)$. We will use the following variety:

$$
\mathscr{Z}=\left\{(X, Y, g) \in \mathscr{Y}_{\theta}\left(n \delta_{l}\right) \times\left.\mathbf{G L}\left(n \delta_{l}\right)\right|^{g}(X, Y)=\left(\xi^{-1} X, \xi Y\right) \text { and } g p_{X, Y}=p_{X, Y}\right\}
$$

where $p_{X, Y}=\left(\left[X_{i}, Y_{i}\right]-\theta_{i}\right)_{i \in \mathbb{Z} / \mathbb{Z}}$ : it is 0 except on the 0 -th component, where it is equal to a rank one matrix of trace $-n \Sigma(\theta)$ (recall from Theorem 2.10 that $\Sigma(\theta) \neq 0$ because $\mathscr{X}_{\theta}\left(n \delta_{l}\right)$ is assumed to be smooth).

We denote by $p^{\prime}: \mathscr{Z} \rightarrow \mathscr{Y}_{\theta}\left(n \delta_{l}\right)$ the projection on the first two factors, by $p: \mathscr{Z} \rightarrow$ $\mathscr{X}_{\theta}\left(n \delta_{l}\right)$ the map induced by $p^{\prime}$ and by $q: \mathscr{Z} \rightarrow \mathbf{G L}\left(n \delta_{l}\right)$ the projection on the third factor. Note that $\operatorname{PGL}\left(n \delta_{l}\right)$ acts on $\mathscr{Z}$ by conjugacy on the three factors, and so the maps $p^{\prime}$ and $q$ are equivariant for this action.

First, it is clear that $p(\mathscr{Z}) \subset \mathscr{X}_{\theta}\left(n \delta_{l}\right)^{\mu_{m}}$. Conversely, if $(X, Y) \in \mathscr{Y}_{\theta}\left(n \delta_{l}\right)$ is a representative of an element of $\mathscr{X}_{\theta}\left(n \delta_{l}\right)^{\mu_{m}}$, then there exists $g \in \mathbf{P G L}\left(n \delta_{l}\right)$ such that ${ }^{g}(X, Y)=$ $\left(\xi^{-1} X, \xi Y\right)$. In particular, ${ }^{g} p_{X, Y}=p_{X, Y}$. So $g$ stabilizes the image of $p_{X, Y}$, which is of dimension 1: this means that $g$ acts by a non-zero scalar $\omega$ on $\operatorname{Im}\left(p_{X, Y}\right)$. Setting $g^{\prime}=\omega^{-1} g$, we see that $(X, Y, g) \in \mathscr{Z}$. So we have proved the following fact:
Fact 1. $p(\mathscr{Z})=\mathscr{X}_{\theta}\left(n \delta_{l}\right)^{\mu_{m}}$.
The next fact follows from the freeness of the action of $\operatorname{PGL}\left(n \delta_{l}\right)$ on $\mathscr{Y}_{\theta}\left(n \delta_{l}\right)$ (see Theorem 2.10).
Fact 2. If $(X, Y, g)$ and $\left(X, Y, g^{\prime}\right)$ belong to $\mathscr{Z}$, then $g=g^{\prime}$ and $g^{k}=g_{0}$.
Indeed, the hypothesis implies that ${ }^{g}(X, Y)=g^{\prime}(X, Y)$ and $g^{k}(X, Y)=g_{0}(X, Y)$. So there exists two non-zero complex numbers $\alpha$ and $\beta$ such that $g^{\prime}=\alpha g$ and $g^{k}=\beta g_{0}$. But the condition $g p_{X, Y}=g^{\prime} p_{X, Y}=g_{0} p_{X, Y}$ forces $\alpha=\beta=1$ because $p_{X, Y} \neq 0$.

Now, let $\mathscr{C}$ denote the set of elements $g \in \mathbf{G L}\left(n \delta_{l}\right)$ such that $g^{k}=g_{0}$. Since $g_{0}$ is central in $\mathbf{G L}\left(n \delta_{l}\right), \mathscr{C}$ is a disjoint union of finitely many semisimple conjugacy classes (which are the irreducible components of $\mathscr{C})$. We fix $g \in \mathscr{C}$ such that $q^{-1}(g) \neq \varnothing$ and we denote by $\mathscr{C}_{g}$ its conjugacy class in $\mathbf{G L}\left(n \delta_{l}\right)$. We will describe $q^{-1}(g)$. For this, let $E=\bigoplus_{i \in \mathbb{Z} / l \mathbb{Z}} \mathbb{C}^{n}$ and let $E_{j}=E^{\xi^{-j} g}$ (for $j \in \mathbb{Z} / m \mathbb{Z}$ ). In other words, $E_{j}$ is the $\xi^{j}$-eigenspace of $g$ in $E$ : it is contained in the $i$-th component of $E$, where $i$ is the element of $\mathbb{Z} / l \mathbb{Z}$ such that $j \equiv i$ $\bmod l$. Let $d_{j}=\operatorname{dim}_{\mathbb{C}}\left(E_{j}\right)$ and let $d=\left(d_{j}\right)_{j \in \mathbb{Z} / m \mathbb{Z}}$.

If $(X, Y, g) \in \mathscr{Z}$, then $X$ sends $E_{j}$ to $E_{j-1}$ (we denote by $X_{j}: E_{j} \rightarrow E_{j-1}$ the induced map) while $Y$ sends $E_{j}$ to $E_{j+1}$ (we denote by $Y_{j}: E_{j} \rightarrow E_{j+1}$ the induced map). By choosing a basis of every $E_{j}$, the family $\left(X_{j}, Y_{j}\right)_{j \in \mathbb{Z} / m \mathbb{Z}}$ defines a representation of the quiver $\bar{Q}_{m}$, of dimension vector $d$. This means that we have defined a map $q^{-1}(g) \longrightarrow \operatorname{Rep}\left(\bar{Q}_{m}, d\right)$, which is clearly a closed immersion, and whose image is $\mathscr{Y}_{\theta[k]}(d)$ (because $\operatorname{Im}\left(p_{X, Y}\right)$ is contained in $E_{0}$ ).

Note that by construction we have $d \in \mathbb{Z}^{\mathbb{Z} / m \mathbb{Z}}\left[n \delta_{l}\right]$. Moreover, by Lemma 2.9 (b) and Theorem 2.10 we also have $d \in\left(\mathbb{Z}^{\mathbb{Z} / m \mathbb{Z}}\right)_{+}$. This means that $d$ is an element of $\mathscr{E}(k, l, n)=$ $\mathbb{Z}^{\mathbb{Z} / m \mathbb{Z}}\left[n \delta_{l}\right] \cap\left(\mathbb{Z}^{\mathbb{Z} / m \mathbb{Z}}\right)_{+}$. Moreover, it is clear that the set of elements $d$ that can apper as above (from some $g \in \mathscr{C}$ such that $\left.q^{-1}(g) \neq \varnothing\right)$ is $\mathscr{E}(k, l, n)_{\neq \varnothing}$.

This shows the following fact.
Fact 3. With the above notation, $q^{-1}(g) \simeq \mathscr{Y}_{\theta[k]}(d)$. In particular, $q^{-1}(g)$ is irreducible.
Fact 3 and its proof imply the following.
Fact 4. We have $p\left(q^{-1}\left(\mathscr{C}_{g}\right)\right)=\mathscr{X}_{d}$.
Denote by $\pi$ the projection $\pi: \mathscr{Y}_{\theta}\left(n \delta_{l}\right) \rightarrow \mathscr{X}_{\theta}\left(n \delta_{l}\right)$. Fact 2 implies that the map $p^{\prime}: \mathscr{Z} \rightarrow$ $\pi^{-1}\left(\mathscr{X}_{\theta}\left(n \delta_{l}\right)^{\mu_{m}}\right)$ is bijective. Moreover, since $\pi^{-1}\left(\mathscr{X}_{\theta}\left(n \delta_{l}\right)^{\mu_{m}}\right.$ ) is smooth (the group $\operatorname{PGL}\left(n \delta_{l}\right)$ acts freely on $\left.\mathscr{Y}_{\theta}\left(n \delta_{l}\right)\right)$, this bijection is an isomorphism of algebraic varieties. Let

$$
\left(p^{\prime}\right)^{-1}: \pi^{-1}\left(\mathscr{X}_{\theta}\left(n \delta_{l}\right)^{\mu_{m}}\right) \rightarrow \mathscr{Z}
$$

be its inverse.
Consider the morphism $\tilde{\tau}: \pi^{-1}\left(\mathscr{X}_{\theta}\left(n \delta_{l}\right)^{\mu_{m}}\right) \rightarrow \mathbf{G L}\left(n \delta_{l}\right)$ given by $\tilde{\tau}=q \circ\left(p^{\prime}\right)^{-1}$. Since we have $\pi^{-1}\left(\mathscr{X}_{\theta}\left(n \delta_{l}\right)^{\mu_{m}}\right) / / \mathbf{G L}\left(n \delta_{l}\right)=\mathscr{X}_{\theta}\left(n \delta_{l}\right)^{\mu_{m}}$, we get a morphism $\tau: \mathscr{X}_{\theta}\left(n \delta_{l}\right)^{\mu_{m}} \rightarrow \mathbf{G L}\left(n \delta_{l}\right) / / \mathbf{G L}\left(n \delta_{l}\right)$, where the group $\mathbf{G L}\left(n \delta_{l}\right)$ acts on itself by conjugation.
Moreover, since we clearly have $\tau^{-1}\left(\mathscr{C}_{g}\right)=p\left(q^{-1}\left(\mathscr{C}_{g}\right)\right.$ ), Fact 4 implies the following.
Fact 5. We have $\tau^{-1}\left(\mathscr{C}_{g}\right)=\mathscr{X}_{d}$. In particular $\mathscr{X}_{d}$ is closed.
This completes the proof of $(b)$. Now we prove $(c)$. The group $\mathbf{G L}\left(n \delta_{l}\right)$ acts transitively on $\mathscr{C}_{g}$. So we get an isomorphism of varieties

$$
q^{-1}(g) / / C_{\mathbf{G L}\left(n \delta_{l}\right)}(g) \xrightarrow{\sim} q^{-1}\left(\mathscr{C}_{g}\right) / / \mathbf{G L}\left(n \delta_{l}\right) .
$$

Now, if $d=\left(\operatorname{dim}_{\mathbb{C}}\left(E^{\xi^{-j} g}\right)\right)_{j \in \mathbb{Z} / m \mathbb{Z}}, q^{-1}(g)$ identifies with $\mathscr{Y}_{\theta[k]}(d)$ and $C_{\mathbf{G L}\left(n \delta_{l}\right)}(g)$ identifies with $\mathbf{G L}(d)$. Glueing this with Facts 3 and 4, we get an isomorphism of varieties

$$
\mathscr{X}_{\theta[k]}(d) \xrightarrow{\sim} \mathscr{X}_{d},
$$

which is the map $i_{k}^{(d)}$. This proves (c).

Corollary 2.13. - If $k>n$, then we have $\mathscr{X}_{\theta}\left(n \delta_{l}\right)^{\mu_{m}}=\mathscr{X}_{\theta}\left(n \delta_{l}\right)^{\mathbb{C}^{\times}}$.

Proof. - Take $d \in \mathscr{E}(k, l, n)_{\neq \varnothing}$. Since $k>n$, some component of $d$ must be zero. This implies that $\mathbb{C}^{\times}$acts trivially on $\mathscr{X}_{\theta[k]}(d)$ because the action of $\mathbb{C}^{\times}$is induced by elements of $\mathbf{G L}(d)$.

Since $i_{k}^{(d)}$ is $\mathbb{C}^{\times}$-equivariant and

$$
\mathscr{X}_{\theta}\left(n \delta_{l}\right)^{\mu_{m}}=\coprod_{d \in \delta(k, l, n)_{\neq \varnothing}} i_{k}^{(d)}\left(\mathscr{X}_{\theta[k]}(d)\right)
$$

(by Theorem 2.12(b)), the $\mathbb{C}^{\times}$-action on the variety $\mathscr{X}_{\theta}\left(n \delta_{l}\right)^{\mu_{m}}$ is also trivial.

## 3. Proof of Theorem 1.3

First, the explicit description of $\mathscr{Z}_{c}$ whenever $n=1$ (see Example 1.2) allows to prove easily Theorem 1.3 in this case. Also, let us decompose $V$ as

$$
V=V^{W} \oplus V_{1} \oplus \cdots \oplus V_{r},
$$

where the $V_{i}$ are the non-trivial irreducible components of $V$ as a $\mathbb{C} W$-module. Then $W$ decomposes as $W=W_{1} \times \cdots \times W_{r}$, where ( $V_{i}, W_{i}$ ) is then a reflection subquotient (subgroup) of $W$. Let $c_{i}$ denote the restriction of $c$ to $W_{i}$. Then

$$
\mathscr{Z}_{c}(V, W) \simeq V^{W} \times V^{* W} \times \mathscr{Z}_{c_{1}}\left(V_{1}, W_{1}\right) \times \cdots \times \mathscr{Z}_{c_{r}}\left(V_{r}, W_{r}\right)
$$

so that the proof of Theorem 1.3 is easily reduced to the case where $W$ acts irreducibly on $V / V^{W}$.

In this case, the smoothness of $\mathscr{Z}_{c}(V, W)$ implies that $W$ is of type $G_{4}$ or $G(l, 1, n)$ for some $l \geqslant 1$. The case of type $G_{4}$ will be handled by computer calculations: see Section 5 for details. This means that we can work under the following hypothesis:

Hypothesis. From now on, and until the end of this section, we assume that $n \geqslant 2$, that $V=\mathbb{C}^{n}$ and that $W=G(l, 1, n)$. We also assume that $\sigma$ is an $m$-th root of unity, where $m=k l$ for some $k \geqslant 1$.

Recall that $G(l, 1, n)$ is the group of monomial matrices with coefficients in $\mu_{l}$ (the group of $l$-th root of unity in $\left.\mathbb{C}^{\times}\right)$and recall that $n \geqslant 2$.
3.A. Quiver varieties vs Calogero-Moser spaces. - We fix a primitive $l$-th root of unity $\zeta$. We denote by $s$ the permutation matrix corresponding to the transposition $(1,2)$ and we set

$$
t=\operatorname{diag}(\zeta, 1, \ldots, 1) \in W
$$

Then $s, t, t^{2}, \ldots, t^{l-1}$ is a set of representatives of conjugacy classes of reflections of $W$. We set for simplification

$$
a=c_{s} \quad \text { and } \quad k_{j}=\frac{1}{l} \sum_{i=1}^{l-1} \zeta^{-i(j-1)} c_{t^{i}}
$$

for $j \in \mathbb{Z} / l \mathbb{Z}$. Then

$$
\begin{equation*}
k_{0}+\cdots+k_{l-1}=0 \quad \text { and } \quad c_{t^{i}}=\sum_{j \in \mathbb{Z} / l \mathbb{Z}} \zeta^{i(j-1)} k_{j} \tag{3.1}
\end{equation*}
$$

for $1 \leqslant i \leqslant l-1$. Finally, if $i \in \mathbb{Z} / l \mathbb{Z}$, we set

$$
\theta_{i}= \begin{cases}k_{-i}-k_{1-i} & \text { if } i \neq 0  \tag{3.2}\\ -a+k_{0}-k_{1} & \text { if } i=0\end{cases}
$$

and $\theta=\left(\theta_{i}\right)_{i \in \mathbb{Z} / l \mathbb{Z}}$.
The following result is proved in [11, Theorem 3.10]. (Note that our $k_{i}$ is related with Gordon's $H_{i}$ via $H_{i}=k_{-i}-k_{1-i}$.)

Theorem 3.3. - With the above notation, there is a $\mathbb{C}^{\times}$-equivariant isomorphism of varieties

$$
\mathscr{Z}_{c} \xrightarrow{\sim} \mathscr{X}_{\theta}\left(n \delta_{l}\right) .
$$

The theorem above is also true for $n=1$. But in this case, the variety $\mathscr{Z}_{c}$ has no parameter $a$. On the other hand, the variety $\mathscr{X}_{\theta}\left(\delta_{l}\right)$ is independent of $\theta_{0}$.

Putting Theorems 2.10 and 3.3 together, one gets:

Corollary 3.4. - The variety $\mathscr{Z}_{c}$ is smooth if and only if

$$
a \prod_{\substack{0 \leqslant i \neq j \leqslant l-1 \\ 0 \leqslant r \leqslant n-1}}\left(k_{i}-k_{j}-r a\right) \neq 0
$$

Proof of Theorem 1.3. - Assume now that $\mathscr{Z}_{c}$ is smooth and let $\mathscr{X}$ be an irreducible component of $\mathscr{E}_{c}^{\mu_{m}}$. Using the isomorphism of Theorem 3.3, we see that

$$
\mathscr{Z}_{c}^{\mu_{m}} \xrightarrow{\sim} \mathscr{X}_{\theta}\left(n \delta_{l}\right)^{\mu_{m}} .
$$

So, by Theorem 2.12, there exists $d \in \mathscr{E}(k, l, n)_{\neq \varnothing}$ such that $\mathscr{X} \simeq \mathscr{X}_{\theta[k]}(d)$. By Lemma 2.7, there exists $r \geqslant 0$ and $w \in W_{m}^{\text {aff }}$ such that $w(d)=r \delta_{m}$. So it follows from the isomorphism (2.4) that

$$
\mathscr{X} \simeq \mathscr{X}_{w(\theta[k])}\left(r \delta_{m}\right)
$$

(see also Lemma 2.9 and its proof). Using Theorem 3.3 in the other way, we see that there exists a complex valued function $c^{\prime}$ on the set of conjugacy classes of reflections of $W^{\prime}=G(m, 1, r)$ such that $\mathscr{X}_{w(\theta[k])}\left(r \delta_{m}\right) \simeq \mathscr{Z}_{c^{\prime}}\left(W^{\prime}\right)$. Moreover, as the action of $W_{m}^{\text {aff }}$ on $\mathbb{C}^{\mathbb{Z} / m \mathbb{Z}}$ is linear, this implies that the map $c \mapsto c^{\prime}$ is linear.

This proves almost every statement of Theorem 1.3, except that $W^{\prime}$ can be realized as a reflection subquotient of $(V, W)$. For this, we need the following fact.
Fact. We have $k r \leqslant n$.
Indeed, the element $d-r \delta_{m}$ is in the $W_{m}^{\text {aff }}$-orbit of 0 . Then Proposition 4.4 implies that $d-r \delta_{m}$ is a residue of some $m$-core. In particular, each coordinates of $d-r \delta_{m}$ must be positive. Since the sum of the coordinated of $d$ is $n l$, this gives $n l-r k l \geqslant 0$. This implies $k r \leqslant n$.

Now, using the fact proved above, let $x$ denotes the matrix

$$
x=\operatorname{diag}(\underbrace{\zeta, 1, \ldots, 1}_{k \text { terms }}) \cdot M_{(1,2, \ldots, k)} \in \mathbf{G} \mathbf{L}_{k}(\mathbb{C}),
$$

where $M_{(1,2, \ldots, k)}$ is the permutation matrix associated with the cycle $(1,2, \ldots, k)$. Now, let $g$ be the matrix

$$
g=\operatorname{diag}(\underbrace{x, \ldots, x}_{r \text { terms }}, \operatorname{Id}_{\mathbb{C}^{n-r k}}) \in G(l, 1, n) .
$$

Let $V^{\prime}$ denote the $\xi$-eigenspace of $g$, where $\xi$ is a primitive $m$-th root of unity such that $\xi^{k}=\zeta$. Then $C_{W}(g)$ acts on $V^{\prime}, V^{\prime}$ is of dimension $r$ and, if we denote by $K$ the kernel of this action, then $C_{W}(g) / K \simeq G(m, 1, r)$. So $\left(V^{\prime}, G(m, 1, r)\right)$ is a reflection subquotient of $(V, W)$.

Remark 3.5. - The formula (3.2) above yields a bijection between $\mathbb{C}^{\mathbb{Z} / l \mathbb{Z}}$ and the set of $(l+1)$-tuples of complex numbers $\left(a, k_{0}, \ldots, k_{l-1}\right)$ such that $k_{0}+k_{1}+\ldots+k_{l-1}=0$. Moreover, the $W_{l}^{\text {aff }}$-action on $\mathbb{C}^{\mathbb{Z}} / l \mathbb{Z}$ (see Section 2.B) translates to the action on the $(l+1)$-tuples in the following way

$$
s_{r}\left(a, k_{0}, \ldots, k_{l-r}, k_{l-r+1}, \ldots, k_{l-1}\right)=\left(a, k_{0}, \ldots, k_{l-r+1}, k_{l-r}, \ldots, k_{l-1}\right), \quad \text { for } r=1,2, \ldots, l-1
$$

and

$$
s_{0}\left(a, k_{0}, k_{1}, k_{2}, \ldots, k_{l-1}\right)=\left(a, k_{1}+a, k_{0}-a, k_{2}, \ldots, k_{l-1}\right) .
$$

In particular, we see that the subgroup $W_{l}$ of $W_{l}^{\text {aff }}$ acts by permutation of the parameters $k_{0}, k_{1}, \ldots, k_{l-1}$.

The next result follows from [2], but we provide here a different proof (which works only in type $G(l, 1, n)$ ).

Corollary 3.6. - A permutation of parameters $k_{0}, k_{1}, \ldots, k_{l-1}$ does not change the CalogeroMoser space $\mathscr{Z}_{c}$ (up to an isomorphism of algebraic varieties).

Proof. - The subgroup $W_{l}$ of $W_{l}^{\text {aff }}$ stabilizes $\delta_{l}$. Then by (2.4), for each $w \in W_{l}, n \in \mathbb{Z}_{>0}$ and $\theta \in \mathbb{C}^{\mathbb{Z} / l \mathbb{Z}}$, we have $\mathscr{X}_{\theta}\left(n \delta_{l}\right) \simeq \mathscr{X}_{w(\theta)}\left(n \delta_{l}\right)$. This proves the statement by Theorem 3.3 and Remark 3.5

## 4. Combinatorics

In this subsection, we aim to make the statement of Theorem 1.3 more precise in the case where $W=G(l, 1, n)$ : we wish to describe precisely the map $c \mapsto c^{\prime}$ in terms of the combinatorics of partitions, cores, $l$-quotients, etc.
4.A. Partitions and cores. - Let $l$ and $n$ be positive integers. A partition is a tuple $\lambda=\left(\lambda_{1}, \lambda_{2}, \ldots, \lambda_{r}\right)$ of positive integers (with no fixed length) such that $\lambda_{1} \geqslant \lambda_{2} \geqslant \cdots \geqslant \lambda_{r}$. Set $|\lambda|=\sum_{i=1}^{r} \lambda_{i}$. If $|\lambda|=n$, we say that $\lambda$ is a partition of $n$.

Denote by $\mathscr{P}$ (resp. $\mathscr{P}[n]$ ) be the set of all partitions (resp. the set of all partitions of $n$ ). By convention, $\mathscr{P}[0]$ contains one (empty) partition. We will identify partitions with Young diagrams. The partition $\lambda$ corresponds to a Young diagram with $r$ lines such that the $i$ th line contains $\lambda_{i}$ boxes. For example the partition $(4,2,1)$ corresponds to the Young diagram


Let $b$ be a box of a Young diagram in the line $r$ and column $s$. The $l$-residue of the box $b$ is the number $s-r$ modulo $l$. (We also say that the integer $s-r$ is the $\infty$-residue of the box $b$ ). Then we obtain a map

$$
\operatorname{Res}_{l}: \mathscr{P} \rightarrow \mathbb{Z}^{\mathbb{Z} / l \mathbb{Z}}, \quad \lambda \mapsto \operatorname{Res}_{l}(\lambda)
$$

such that for each $i \in \mathbb{Z} / l \mathbb{Z}$ the number of boxes with residue $i$ in $\lambda$ is $\left(\operatorname{Res}_{l}(\lambda)\right)_{i}$. (Similarly, we obtain a $\operatorname{map} \operatorname{Res}_{\infty}: \mathscr{P} \rightarrow \mathbb{Z}^{\mathbb{Z}}$.)

Example 4.1. - For the partition $\lambda=(4,2,1)$ and $l=3$ the residues of the boxes are

| 0 | 1 | 2 | 0 |
| :--- | :--- | :--- | :--- |
| 2 | 0 |  |  |
| 1 |  |  |  |
|  |  |  |  |

In this case we have $\operatorname{Res}_{l}(\lambda)=(3,2,2)$ because there are three boxes with residue 0 , two boxes with residue 1 and two boxes with residue 2 .

We say that a box of a Young diagram is removable if it has no boxes on the right and on the bottom. For $\lambda, \mu \in \mathscr{P}$, we write $\mu \leqslant \lambda$ if the Young diagram of $\mu$ can be obtained from the Young diagram of $\lambda$ by removing a sequence of removable boxes.

Definition 4.2. - We say that the partition $\lambda$ is an $l$-core if there is no partition $\mu \leqslant \lambda$ such that the Young diagram of $\mu$ differs from the Young diagram of $\lambda$ by $l$ boxes with $l$ different $l$-residues.

See [3] for more details about the combinatorics of $l$-cores. Let $\mathscr{C}_{l} \subset \mathscr{P}$ be the set of $l$-cores. Set $\mathscr{C}_{l}[n]=\mathscr{P}[n] \cap \mathscr{C}_{l}$.

If a partition $\lambda$ is not an $l$-core, then we can get a smaller Young diagram from its Young diagram by removing $l$ boxes with different $l$-residues. We can repeat this operation again and again until we get an $l$-core. It is well-known, that the $l$-core that we get is independent of the choice of the boxes that we remove. Then we get an application

$$
\text { Core }_{l}: \mathscr{P} \rightarrow \mathscr{C}_{l} .
$$

If $\mu=\operatorname{Core}_{l}(\lambda)$, we will say that the partition $\mu$ is the $l$-core of the partition $\lambda$.

Example 4.3. - The partition $(4,2,1)$ from the previous example is not a 3-core because it is possible to remove three bottom boxed. We get


But this is still not a 3-core because we can remove three more boxes and we get

This shows that the partition (1) is the 3 -core of the partition $(4,2,1)$.

As mentioned in Lemma 2.7, for each $d \in \mathbb{Z}^{\mathbb{Z}} / l \mathbb{Z}$, the $W_{l}^{\text {aff }}$-orbit of $d$ contains an element of the form $n \delta_{l}$ for a unique $n \in \mathbb{Z}$.

Proposition 4.4. - Let $d$ be an element of $\mathbb{Z}^{\mathbb{Z}} / l \mathbb{Z}$. The following statements are equivalent.
(a) $d$ is of the form $d=\operatorname{Res}_{l}(\lambda)$ for some $l$-core $\lambda$,
(b) $d$ is in the $W_{l}^{\text {aff }}$-orbit of 0 .

Proof. - Consider the $W_{l}^{\text {aff }}$-action on $\mathscr{C}_{l}$ as in [3, Sec. 3]. By construction, the map $\operatorname{Res}_{l}: \mathscr{C}_{l} \rightarrow \mathbb{Z}^{\mathbb{Z} / l \mathbb{Z}}$ is $W_{l}^{\text {aff }}$-invariant. Moreover, the residue of the empty partition is zero. The stabilizer of the empty partition in $W_{l}^{\text {aff }}$ is $W_{l}$ and the stabilizer of $0 \in \mathbb{Z}^{\mathbb{Z}} / l \mathbb{Z}$ in $W_{l}^{\text {aff }}$ is also $W_{l}$. This shows that the map $\operatorname{Res}_{l}$ yields a bijection between the set of $l$-cores and the $W_{l}^{\text {aff }}$-orbit of 0 in $\mathbb{Z}^{\mathbb{Z} / l \mathbb{Z}}$.

Denote by $\pi$ the obvious surjection $\pi: \mathbb{Z}^{\mathbb{Z} / l \mathbb{Z}} \rightarrow \mathbb{Z}^{\mathbb{Z} / l \mathbb{Z}} / \mathbb{Z} \delta_{l}$.
Proposition 4.5. - The chain of maps

$$
\mathscr{C}_{l} \xrightarrow{\operatorname{Res}_{l}} \mathbb{Z}^{\mathbb{Z} / l \mathbb{Z}} \xrightarrow{\pi} \mathbb{Z}^{\mathbb{Z} / l \mathbb{Z}} / \mathbb{Z} \delta_{l}
$$

yields a bijection between $\mathscr{C}_{l}$ and $\mathbb{Z}^{\mathbb{Z} / l \mathbb{Z}} / \mathbb{Z} \delta_{l}$.

Proof. - We have seen in the proof of Proposition 4.4 that $\operatorname{Res}_{l}$ yields a bijection between $\mathscr{C}_{l}$ and the $W_{l}^{\text {aff }}$-orbit of $0 \in \mathbb{Z}^{\mathbb{Z} / l \mathbb{Z}}$. This proves the statement because the restriction of $\pi$ to the $W_{l}^{\text {aff }}$-orbit of $0 \in \mathbb{Z}^{\mathbb{Z}} / l \mathbb{Z}$ is bijective by Lemma 2.7.

For $d=\left(d_{i}\right)_{i \in \mathbb{Z} / l \mathbb{Z}} \in \mathbb{Z}^{\mathbb{Z} / l \mathbb{Z}}$ we set $|d|=\sum_{i \in \mathbb{Z} / l \mathbb{Z}} d_{i}$. Set $\mathbb{Z}^{\mathbb{Z} / l \mathbb{Z}}[n]=\left\{d \in \mathbb{Z}^{\mathbb{Z} / l \mathbb{Z}} ;|d|=n\right\}$. Denote by $\mathscr{C}_{l}[\equiv n]$ the subset of $\mathscr{C}_{l}$ that contains only $l$-cores with the number of boxes congruent to $n$ modulo $l$. Proposition 4.5 yields the following bijection $\varepsilon: \mathbb{Z} \mathbb{Z} / l \mathbb{Z}[n] \stackrel{\sim}{\longleftrightarrow}$ $\mathscr{C}_{l}[\equiv n]$.

Lemma 4.6. - Assume $d \in \mathbb{Z}^{\mathbb{Z} / l \mathbb{Z}}[n]$. Then $d$ is in $\left(\mathbb{Z}^{\mathbb{Z} / l \mathbb{Z}}\right)_{+}$if and only if $|\varepsilon(d)| \leqslant n$.

Proof. - By construction, $\varepsilon(d)$ is the unique $l$-core $\lambda \in \mathscr{C}_{l}[\equiv n]$ such that $\operatorname{Res}_{l}(\lambda)$ is congruent to $d$ modulo $\delta_{l}$. Write $d=\operatorname{Res}_{l}(\lambda)+r \delta_{l}$. Since by Proposition 4.4, the element $\operatorname{Res}_{l}(\lambda)$ is in the $W_{l}^{\text {aff }}$-orbit of 0 , then $d$ is in the $W_{l}^{\text {aff }}$-orbit of $r \delta_{l}$. Then, by definition, the element $d$ is in $\left(\mathbb{Z}^{\mathbb{Z}} / l \mathbb{Z}\right)_{+}$if and only if $r \geqslant 0$. Now, let us count the sum of the coordinates in the sides of the equality $d=\operatorname{Res}_{l}(\lambda)+r \delta_{l}$. We obtain $n=|\lambda|+r l$. This shows that we have $r \geqslant 0$ if and only if $|\lambda| \leqslant n$.

Let $v$ be an $l$-core. Denote by $\mathscr{P}_{l, v}$ the set of partitions with the $l$-core $v$. In particular we denote by $\mathscr{P}_{l, \varnothing}$ the set of partitions with trivial $l$-core. Let $\mathscr{P}^{l}$ be the set of $l$-partitions (i.e., the set of $l$-tuples of partitions). If $\lambda$ is a partition, we denote by $\beta_{l}(\lambda)$ its $l$-quotient (see for example [16, Sec. 2.2]).

Lemma 4.7. - If $v$ is an l-core, then $\beta_{l}$ restricts to a bijection $\beta_{l, v}: \mathscr{P}_{l, v} \stackrel{\sim}{\leftrightarrows} \mathscr{P}^{l}$.
4.B. Description of $\mathscr{E}(k, l, n)$ in terms of cores. - Let $k$ be a positive integer. Set $m=k l$. Set also $\left(\mathscr{C}_{m}\right)_{l, v}=\mathscr{P}_{l, v} \cap \mathscr{C}_{m}$.

Recall that we have a bijection $\varepsilon: \mathbb{Z}^{\mathbb{Z} / m \mathbb{Z}}[n l] \stackrel{\sim}{\longleftrightarrow} \mathscr{C}_{m}[\equiv n l]$. Assume $d \in \mathbb{Z}^{\mathbb{Z} / m \mathbb{Z}}[n l]$.

Lemma 4.8. - We have $d \in \mathbb{Z}^{\mathbb{Z} / m \mathbb{Z}}\left[n \delta_{l}\right]$ if and only if the $l$-core of $\varepsilon(d)$ is trivial, where the set $\mathbb{Z}^{\mathbb{Z} / m \mathbb{Z}}\left[n \delta_{l}\right]$ is as in Section 2.D.

Proof. - By definition, $\varepsilon(d)$ is the unique $m$-core $\lambda \in \mathscr{C}_{m}[\equiv n l]$ such that $\operatorname{Res}_{m}(\lambda)$ is equal to $d$ modulo $\delta_{m}$. On the other hand, by Proposition 4.4, the partition $\lambda$ is an $l$-core if and only if $\operatorname{Res}_{l}(\lambda)$ is a multiple of $\delta_{l}$. By commutativity of the following diagram,

this condition is clearly equivalent to $d \in \mathbb{Z}^{\mathbb{Z} / m \mathbb{Z}}\left[n \delta_{l}\right]$.
Recall that the set $\mathscr{E}(k, l, n)$ was defined as the intersection $\mathscr{E}(k, l, n)=\mathbb{Z}^{\mathbb{Z} / m \mathbb{Z}}\left[n \delta_{l}\right] \cap$ $\left(\mathbb{Z}^{\mathbb{Z} / m \mathbb{Z}}\right)_{+}$. Combining Lemmas 4.6 and 4.8 , we obtain the following.

Lemma 4.9. - The bijection $\varepsilon: \mathbb{Z}^{\mathbb{Z} / m \mathbb{Z}}[n l] \simeq \mathscr{C}_{m}[\equiv n l]$ restricts to a bijection

$$
\varepsilon^{\prime}: \mathscr{E}(k, l, n) \rightarrow \mathscr{C}_{m}[\equiv n l] \cap \mathscr{C}_{m}[\leqslant n l] \cap\left(\mathscr{C}_{m}\right)_{l, \varnothing}
$$

For $\lambda=\left(\lambda^{0}, \ldots, \lambda^{l-1}\right) \in \mathscr{P}^{l}$ we set $|\lambda|=\left|\lambda^{0}\right|+\cdots+\left|\lambda^{l-1}\right|$. Set also $\mathscr{P}^{l}[n]=\left\{\lambda \in \mathscr{P}^{l} ;|\lambda|=n\right\}$. We say that an element of $\mathscr{P}^{l}[n]$ is an $l$-partition of $n$.

Now recall the bijection $\beta_{l, v}: \mathscr{P}_{l, v} \stackrel{\sim}{\leftrightarrows} \mathscr{P}^{l}$ obtained by restriction from $\beta_{l}$ as in Lemma 4.7. By construction, it has the following properties.

Lemma 4.10. - (a) For each $\lambda \in \mathscr{P}_{l, \varnothing}$, we have $\lambda \in \mathscr{C}_{m}$ if and only if $\beta_{l, \varnothing}(\lambda) \in\left(\mathscr{C}_{k}\right)^{l}$.
(b) For each $\lambda \in \mathscr{P}_{l, v}$, we have $|\lambda|=l \cdot\left|\beta_{l, v}(\lambda)\right|+|\nu|$.

Part (a) of the lemma above shows that $\beta_{l, \emptyset}$ can be restricted to a bijection $\left(\mathscr{C}_{m}\right)_{l, \varnothing} \simeq$ $\left(\mathscr{C}_{k}\right)^{l}$. Moreover, part (b) shows that new bijection restricts to a bijection

$$
\mathscr{C}_{m}[\equiv n l] \cap \mathscr{C}_{m}[\leqslant n l] \cap\left(\mathscr{C}_{m}\right)_{l, \varnothing} \simeq\left(\mathscr{C}_{k}\right)^{l}[\equiv n, \leqslant n],
$$

where

$$
\left(\mathscr{C}_{k}\right)^{l}[\equiv n, \leqslant n]=\left\{\lambda \in\left(\mathscr{C}_{k}\right)^{l} ;|\lambda| \leqslant n \text { and }|\lambda| \equiv n \bmod k\right\} .
$$

Combining this with Lemma 4.9, we get a bijection

$$
\delta: \mathscr{E}(k, l, n) \rightarrow\left(\mathscr{C}_{k}\right)^{l}[\equiv n, \leqslant n] .
$$

This bijection (and Corollary 4.13 below) yileds a parametrization of the irreducible components of $\mathscr{X}_{\theta}\left(n \delta_{l}\right)^{\mu_{m}}$ by the $\operatorname{set}\left(\mathscr{C}_{k}\right)^{l}[\equiv n, \leqslant n]$.
4.C. Parametrization of the $\mu_{m}$-fixed points. - We have proved in Theorem 2.12 that the subset $\mathscr{E}(k, l, n)_{\neq \emptyset}$ of $\mathscr{E}(k, l, n)$ parametrizes the irreducible components of $\mathscr{X}_{\theta}\left(n \delta_{l}\right)^{\mu_{m}}$. (But we will show in Corollary 4.13 that we have $\mathscr{E}(k, l, n)_{\neq \varnothing}=\mathscr{E}(k, l, n)$.) Then the bijection $\varepsilon^{\prime}$ above gives another parametrization of the irreducible components of $\mathscr{X}_{\theta}\left(n \delta_{l}\right)^{\mu_{m}}$ in terms of $\mathscr{C}_{m}[\equiv n l] \cap \mathscr{C}_{m}[\leqslant n l] \cap\left(\mathscr{C}_{m}\right)_{l, \varnothing}$. For each $\lambda \in \mathscr{C}_{m}[\equiv n l] \cap \mathscr{C}_{m}[\leqslant n l] \cap\left(\mathscr{C}_{m}\right)_{l, \varnothing}$, we set $\mathscr{X}_{\lambda}=\mathscr{X}_{\varepsilon^{\prime-1}(\lambda)}$.

This new parametrization has the following nice property.
Lemma 4.11. - Fix positive integers $k_{1}$ and $k_{2}$ such that $k_{1}$ divides $k_{2}$. Set $m_{1}=k_{1} l$ and $m_{2}=k_{2} l$. Fix $\left.\lambda_{1} \in \mathscr{C}_{m_{1}}[\equiv n l] \cap \mathscr{C}_{m_{1}}[\leqslant n l] \cap\left(\mathscr{C}_{m_{1}}\right)\right)_{l, \varnothing}$ and $\left.\lambda_{2} \in \mathscr{C}_{m_{2}}[\equiv n l] \cap \mathscr{C}_{m_{2}}[\leqslant n l] \cap\left(\mathscr{C}_{m_{2}}\right)\right)_{l, \varnothing}$. Then we have $\mathscr{X}_{\lambda_{2}} \subset \mathscr{X}_{\lambda_{1}}$ if and only if $\operatorname{Core}_{m_{1}}\left(\lambda_{2}\right)=\lambda_{1}$.

Proof. - Consider the map

$$
p: \mathbb{Z}^{\mathbb{Z} / m_{2} \mathbb{Z}} \rightarrow \mathbb{Z}^{\mathbb{Z} / m_{1} \mathbb{Z}}, \quad p(d)_{i}=\sum_{j \equiv i \bmod m_{1}} d_{j} .
$$

Let $d^{1} \in \mathscr{E}\left(k_{1}, l, n\right)$ and $d^{2} \in \mathscr{E}\left(k_{2}, l, n\right)$ be such that $\varepsilon^{\prime}\left(d^{1}\right)=\lambda_{1}$ and $\varepsilon^{\prime}\left(d^{2}\right)=\lambda_{2}$. We have $\mathscr{X}_{d^{1}}=\mathscr{X}_{\lambda_{1}}$ and $\mathscr{X}_{d^{2}}=\mathscr{X}_{\lambda_{2}}$. It is clear from the definition that we have $\mathscr{X}_{d^{2}} \subset \mathscr{X}_{d^{1}}$ if and only if $p\left(d^{2}\right)=d^{1}$. Then the statement follows from the commutativity of the following diagram


Note that the set $\mathscr{C}_{m}[\equiv n l] \cap \mathscr{C}_{m}[\leqslant n l] \cap\left(\mathscr{C}_{m}\right)_{l, \varnothing}$ considered above is nothing else but the image of $\mathscr{P}[n l] \cap \mathscr{P}_{l, \varnothing}$ by Core ${ }_{m}$. In other words, the set $\mathscr{C}_{m}[\equiv n l] \cap \mathscr{C}_{m}[\leqslant n l] \cap\left(\mathscr{C}_{m}\right)_{l, \varnothing}$ is the same thing as the set of $m$-cores of partitions of $n l$ with trivial $l$-cores.

Proposition 4.12. - The $\mathbb{C}^{\times}$-fixed points in $\mathscr{X}_{\theta}\left(n \delta_{l}\right)$ are parametrized by the set $\mathscr{P}[n l] \cap \mathscr{P}_{l, \varnothing}$. This parametrization $\mathscr{X}_{\theta}\left(n \delta_{l}\right)^{\mathbb{C}^{\times}}=\left\{p_{\mu} ; \mu \in \mathscr{P}[n l] \cap \mathscr{P}_{l, \varnothing}\right\}$ can be chosen in such a way that for each $k \in \mathbb{Z}$, each $\lambda \in \mathscr{C}_{m}[\equiv n l] \cap \mathscr{C}_{m}[\leqslant n l] \cap\left(\mathscr{C}_{m}\right)_{l, \varnothing}$ and each $\mu \in \mathscr{P}[n l] \cap \mathscr{P}_{l, \varnothing}$ we have $p_{\mu} \in \mathscr{X}_{\lambda}$ if and only if $\lambda$ is the $m$-core of $\mu$.

Proof. - Assume $k>n$. Then by Corollary 2.13, we have $\mathscr{X}_{\theta}\left(n \delta_{l}\right)^{\mu_{m}}=\mathscr{X}_{\theta}\left(n \delta_{l}\right)^{\mathbb{C}^{\times}}$. Moreover, the set $\mathscr{X}_{\theta}\left(n \delta_{l}\right)^{\mathbb{C}^{\times}}$is finite. We already know that $\mathscr{X}_{\theta}\left(n \delta_{l}\right)^{\mu_{m}}$ is in bijection with a subset of $\mathscr{C}_{m}[\equiv n l] \cap \mathscr{C}_{m}[\leqslant n l] \cap\left(\mathscr{C}_{m}\right)_{l, \varnothing}$. Moreover, $k>n$ also implies that we have $\mathscr{C}_{m}[\equiv n l] \cap \mathscr{C}_{m}[\leqslant n l] \cap\left(\mathscr{C}_{m}\right)_{l, \varnothing}=\mathscr{P}[n l] \cap \mathscr{P}_{l, \varnothing}$. This shows that $\mathscr{X}_{\theta}\left(n \delta_{l}\right)^{\mu_{m}}=\mathscr{X}_{\theta}\left(n \delta_{l}\right)^{\mathbb{C}^{\times}}$ is in bijection with a subset of $\mathscr{P}[n l] \cap \mathscr{P}_{l, \varnothing}$. Moreover, by Lemma 4.11, this bijection is independent of the choice of $k$. But it is well-known (see [10]) that $\mathscr{X}_{\theta}\left(n \delta_{l}\right)^{\mathbb{C}^{\times}}$and $\mathscr{P}^{l}[n] \simeq \mathscr{P}[n l] \cap \mathscr{P}_{l, \varnothing}$ have the same cardinalities. This shows that the bijection above is a bijection between $\mathscr{X}_{\theta}\left(n \delta_{l}\right)^{\mathbb{C}^{\times}}$and $\mathscr{P}[n l] \cap \mathscr{P}_{l, \varnothing}\left(\right.$ not just a subset of $\left.\mathscr{P}[n l] \cap \mathscr{P}_{l, \varnothing}\right)$.

The second statement follows from Lemma 4.11.

Corollary 4.13. - For each $\lambda \in \mathscr{C}_{m}[\equiv n l] \cap \mathscr{C}_{m}[\leqslant n l] \cap\left(\mathscr{C}_{m}\right)_{l, \varnothing}$, we have $\mathscr{X}_{\lambda} \neq \varnothing$. In particular, we have $\mathscr{E}(k, l, n)=\mathscr{E}(k, l, n)_{\neq \varnothing}$.

Proof. - Assume $\lambda \in \mathscr{C}_{m}[\equiv n l] \cap \mathscr{C}_{m}[\leqslant n l] \cap\left(\mathscr{C}_{m}\right)_{l, \varnothing}$. Then there exists $\mu \in \mathscr{P}[n l]$ such that $\operatorname{Core}_{m}(\mu)=\lambda$. Then $\mu$ is also automatically in $\mathscr{P}_{l, \varnothing}$. Then $\mathscr{X}_{\lambda}$ is not empty because we have $p_{\mu} \in \mathscr{X}_{\lambda}$ by Proposition 4.12.

Proposition 4.12 and the bijection $\beta_{l, \varnothing}$ yields a parametrization of $\mathscr{X}_{\theta}\left(n \delta_{l}\right)^{\mathrm{C}^{\times}}$by $\mathscr{P}^{l}[n]$.
4.D. $\mathbb{C}^{\times}$-fixed points. - The parametrization of the points of $\mathscr{X}_{\theta}\left(n \delta_{l}\right)^{\mathbb{C}^{\times}}$given in Proposition 4.12 is constructed as a parametrization of the irreducible components of $\mathscr{X}_{\theta}\left(n \delta_{l}\right)^{\mu_{m}}$ for a very big $m$. This parametrization can be seen in an " $m$-independent way" if we replace the quiver $\bar{Q}_{m}$ with a very big $m$ by an infinite quiver. This can be done in the following way.

Let $\bar{Q}_{\infty}$ be the quiver difined in the same way as $\bar{Q}_{l}$ with respect to the vertex set $\mathbb{Z}$ instead of $\mathbb{Z} / l \mathbb{Z}$. The dimention vectors of the quiver $\bar{Q}_{\infty}$ are in $\mathbb{Z}^{\mathbb{Z}}$. Set

$$
\mathbb{Z}_{\text {fin }}^{\mathbb{Z}}=\left\{\widehat{d} \in \mathbb{Z}^{\mathbb{Z}} ; \widehat{d} \text { has finitely many non-zero components }\right\} .
$$

Consider the map

$$
p: \mathbb{Z}_{\mathrm{fin}}^{\mathbb{Z}} \rightarrow \mathbb{Z}^{\mathbb{Z} / l \mathbb{Z}}, \quad(p(\widehat{d}))_{i}=\sum_{j \equiv i \bmod l} \widehat{d}_{j} .
$$

For each $\widehat{d} \in \mathbb{Z}_{\mathrm{fin}}^{\mathbb{Z}}$, we have a linear map $i_{\infty}^{(\hat{d})}: \operatorname{Rep}\left(\bar{Q}_{\infty}, \widehat{d}\right) \rightarrow \operatorname{Rep}\left(\bar{Q}_{l}, p(\widehat{d})\right)$, defined in the same way is in Section 2.D. Now, for each $\theta \in \mathbb{C}^{\mathbb{Z} / l \mathbb{Z}}$ we consider the element $\theta[\infty] \in \mathbb{C}^{\mathbb{Z}}$ given by $\theta[\infty]_{i}=\theta_{i \bmod l}$. Then we obtain a $\mathbb{C}^{\times}$-invariant morphism of algebraic varieties $i_{\infty}^{(\widehat{d})}: \mathscr{X}_{\theta[\infty]}(\widehat{d}) \rightarrow \mathscr{X}_{\theta}\left(p(\widehat{d})\right.$. But the variety $\mathscr{X}_{\theta[\infty]}(\widehat{d})$ is obviously $\mathbb{C}^{\times}$-stable because the $\mathbb{C}^{\times}$
action is induced by elements of $\mathbf{G L}(\widehat{d})$. Since $\mathscr{X}_{\theta[\infty]}(\widehat{d})$ is connected, it is a singleton (if it is not empty). Set

$$
\mathscr{E}(\infty, l, d)=\left\{\widehat{d} \in \mathbb{Z}_{\mathrm{fin}}^{\mathbb{Z}} ; p(\widehat{d})=d, \mathscr{X}_{\theta[\infty]}(\widehat{d}) \neq \varnothing\right\}
$$

If $\widehat{d} \in \mathscr{E}(\infty, l, d)$, the image of $i_{\infty}^{(\widehat{d})}$ is a $\mathbb{C}^{\times}$-fixed point in $\mathscr{X}_{\theta}(d)$. Let us call this point $p_{\widehat{d}}$.
Now, we assume $d=n \delta_{l}, n \geqslant 0$ and that $\mathscr{X}_{\theta}(d)$ is smooth. The construction of the parametrization of the $\mathbb{C}^{\times}$-fixed points in $\mathscr{X}_{\theta}\left(n \delta_{l}\right)$ given in Proposition 4.12 implies that each $\mathbb{C}^{\times}$-fixed point $p_{\mu}, \mu \in \mathscr{P}[n l] \cap \mathscr{P}_{l, \varnothing}$, in $\mathscr{X}_{\theta}\left(n \delta_{l}\right)$ is of the form $p_{\hat{d}}$ for a unique $\widehat{d} \in$ $\mathscr{E}\left(\infty, l, n \delta_{l}\right)$. Moreover, this $\widehat{d}$ is given by $\widehat{d}=\operatorname{Res}_{\infty}(\mu)$.
4.E. Explicit construction of $c^{\prime}$. - We know from Theorem 2.12 that each irreducible component $\mathscr{X}$ of $\mathscr{X}_{\theta}\left(n \delta_{l}\right)^{\mu_{m}}$ is of the form $\mathscr{X}=\mathscr{X}_{d}$. Moreover, by Theorem 1.3 there exists a reflection subquotient $\left(V^{\prime}, W^{\prime}\right)$ of $(V, W)$ and a complex-valued map $c^{\prime}: W^{\prime} \rightarrow \mathbb{C}$ such that $\mathscr{X} \simeq \mathscr{Z}_{c^{\prime}}\left(V^{\prime}, W^{\prime}\right)$. The reflection subquotient was constructed in the proof of Theorem 1.3. Now we give an explicit construction of $c^{\prime}$.

Recall from $\S 1$.A that the parameter $c$ is determined by the sequence of parameters $\left(a, k_{0}, k_{1}, \ldots, k_{l-1}\right)$. Similarly, the parameter $c^{\prime}$ is determined by $\left(a^{\prime}, k_{0}^{\prime}, k_{1}^{\prime}, \ldots, k_{m-1}^{\prime}\right)$. We are going to give explicit expressions for $\left(a^{\prime}, k_{0}^{\prime}, k_{1}^{\prime}, \ldots, k_{m-1}^{\prime}\right)$ in terms of $d \in \mathscr{E}(k, l, m)$ and $\left(a, k_{0}, k_{1}, \ldots, k_{l-1}\right)$.

First, we recall the construction of $c^{\prime}$ in the proof of Theorem 1.3. There is an element $w \in W_{m}^{\text {aff }}$ such that $w(d)$ is a multiple of $\delta_{m}$. Then we put $\theta^{\prime}=w(\theta[k])$. Finally, we can obtain ( $a^{\prime}, k_{0}^{\prime}, \ldots, k_{m-1}^{\prime}$ ) from $\theta^{\prime}$ using (3.1) and (3.2).

This construction of $c^{\prime}$ is not canonical because there is no preferable choice of an element $w$. Note that $\delta_{m}$ is stable by the subgroup $W_{m}$ of $W_{m}^{\text {aff }}$. So the element $w$ can be replaced by any elements of $W_{m} w$. (By Remark 3.5, a different choice of $w$ yields just a permutation of the parameters $k_{0}^{\prime}, k_{1}^{\prime}, \ldots, k_{m-1}^{\prime}$.) The affine Weyl group $W_{m}^{\text {aff }}$ is of the form $W_{m} \ltimes R_{m}$, where $R_{m}$ is the root lattice for $\mathfrak{s l}_{m}$. In particular, there is an element of $w^{\prime} \in W_{m} w$ that is in $R_{m}$. More precisely, we have $w^{\prime}=t_{\alpha}$, where $\alpha=d-d_{0} \delta_{m}$ (see the proof of Lemma 2.7).

Then, by Lemma 2.8, we have $w^{\prime}(\theta[k])=t_{\alpha}(\theta[k])=\theta[k]+\Sigma(\theta[k]) \cdot \bar{\alpha}=\theta[k]+k \Sigma(\theta) \cdot \bar{d}$. (Where the notation $\bar{\alpha}$ and $\bar{d}$ is as in Section 2.B.) This means that we have

$$
\theta_{i}^{\prime}=(\theta[k])_{i}+k \Sigma(\theta)\left(2 d_{i}-d_{i-1}+d_{i+1}\right)=\theta_{(i \bmod l)}-k a\left(2 d_{i}-d_{i-1}+d_{i+1}\right)
$$

Passing back to the $k_{i}$-notations, we get $a^{\prime}=k a$ and

$$
k_{r}^{\prime}=k_{(r \bmod l)}+a\left(\left\lfloor\frac{r-1}{l}\right\rfloor-\frac{k-1}{2}+k\left(d_{1-r}-d_{-r}\right)\right)
$$

for $r=1, \ldots, m-1, m$. (Here $k_{0}=k_{m}$.)

Example 4.14. - Let us make the above formula explicit in the case $l=1$. In this case we have $m=k$. Then we get $\theta=\theta_{0}=-a$ and $\theta[k]=(-a,-a, \ldots-a)(k$ times $)$. This gives

$$
\theta_{i}^{\prime}=-a-a k\left(2 d_{i}-d_{i-1}-d_{i+1}\right)
$$

for $i \in \mathbb{Z} / k \mathbb{Z}$.

$$
k_{r}^{\prime}=a\left(r-\frac{k+1}{2}+k\left(d_{1-r}-d_{-r}\right)\right)
$$

for $r=1, \ldots, k-1, k$. (Here $k_{0}=k_{k}$.)

Example 4.15. - Assume $l=2, k=2$ and $d=(0,0)$. In this case $c$ is determined by $\left(a, k_{0}, k_{1}\right)$ such that $k_{0}+k_{1}=0$. Put $k_{1}=b$ (and then $k_{0}=-b$ ). Let us make the formulas for $k_{r}^{\prime}$ explicit in this case. We have

$$
\left\{\begin{aligned}
k_{0}^{\prime} & =-b+a / 2 \\
k_{1}^{\prime} & =b-a / 2 \\
k_{2}^{\prime} & =-b-a / 2 \\
k_{3}^{\prime} & =b+a / 2
\end{aligned}\right.
$$

## 5. Type $G_{4}$

Hypothesis. In this section, and only in this section, we assume that $V=\mathbb{C}^{2}$, we identify $\mathbf{G L}_{\mathbb{C}}(V)$ with $\mathbf{G L}_{2}(\mathbb{C})$, we fix a primitive third root of unity $\omega$, we set

$$
s=\left(\begin{array}{cc}
\omega & 0 \\
\omega^{2} & 1
\end{array}\right) \quad \text { and } \quad t=\left(\begin{array}{cc}
1 & -\omega^{2} \\
0 & \omega
\end{array}\right)
$$

and we assume that $W=\langle s, t\rangle$, so that $W$ is of type $G_{4}$ in ShephardTodd classification. We denote by $\left(y_{1}, y_{2}\right)$ the canonical basis of $V$ and by $\left(x_{1}, x_{2}\right)$ its dual basis.

Note that there is only one $W$-orbit of reflection hyperplanes (let us call it $\Omega$ ) and we set for simplifying $k_{i}=k_{\Omega, i}$, so that $k_{0}+k_{1}+k_{2}=0$. We also set $\rho=1+2 \omega$, so that $\rho^{2}=-3$.

In this case, we will check Conjecture F even if $\mathscr{Z}_{c}$ is not smooth (and for all elements $\sigma \in \mathbf{G L}_{\mathbb{C}}(V)$ normalizing $W$, as any such elements belong to $\mathbb{C}^{\times} \cdot W$, as we will see in the proof below).

Theorem 5.1. - If $W$ is of type $G_{4}$, then Conjecture $F$ holds.

Proof. - Let $\sigma \in \mathbf{G L}_{2}(\mathbb{C})$ be of finite order and normalizing $W$. The conjugacy class of $s$ is

$$
\left\{s, t, s t s^{-1}, s^{2} t s^{-2}=t s t^{-1}\right\}
$$

and is the unique conjugacy class of reflections of determinant $\omega$. Since $\sigma s \sigma^{-1}$ is a reflection of $W$ of determinant $\omega$, there exists $w \in W$ such that $w \sigma$ commutes with $s$. Since $W$ acts trivially on $\mathscr{Z}_{c}$, we may, and we will, assume that $\sigma s \sigma^{-1}=s$. Now, $\sigma t \sigma^{-1}$ belongs to this conjugacy class and is different from $s$, so there exists $i \in \mathbb{Z}$ such that $s^{i} \sigma$ commutes with $t$. So, replacing $\sigma$ by $s^{i} \sigma$, we may, and we will, assume that $\sigma$ commutes with $s$ and $t$. In other words, $\sigma$ is a root of unity.

Since $Z(W) \simeq \boldsymbol{\mu}_{2}$, we may also assume that the order of $\sigma$ is even, equal to $2 d$ for some $d \geqslant 2$ (because the case $d=1$ is obvious). Let $I_{d}$ denote the ideal of $\mathbf{Z}_{c}$ generated by the $\sigma(z)-z$, where $z$ runs over a set of generators of $\mathbf{Z}_{c}$. Then

$$
(\boldsymbol{\varphi})
$$

$$
\mathbb{C}\left[\mathscr{Z}_{c}^{\sigma}\right]=\mathbf{Z}_{c} / \sqrt{I_{d}} .
$$

Let $\zeta$ denote the root of unity by which $\sigma$ acts: then $\sigma(z)-z=\left(\zeta^{l}-1\right) z$ if $z$ is homogeneous of $\mathbb{Z}$-degree $l$. This shows that $I_{d}$ is generated by the generators of $\mathbf{Z}_{c}$ of degree not divisible by $2 d$. As we will see below, there is a set of generators of $\mathbf{Z}_{c}$ whose $\mathbb{Z}$-degrees belong to the interval $[-6,6]$. So, if $d \geqslant 4$, then $\mathscr{E}_{c}^{\sigma}=\mathscr{Z}_{c}^{\mathbb{C}^{\times}}$, so it is a finite set and the Conjecture F is checked in this case. So we may assume that $d \in\{2,3\}$.

In [6], Thiel and the first author have provided algorithms for computing presentations of the algebra $\mathbf{Z}_{c}$, and such algorithms have been included in the MAGMA package CHAMP developed by Thiel [20] (about the MAGMA software, see [18]). These algorithms provide an explicit presentation of the center $\mathbf{Z}_{c}$ given as follows:

$$

$$

The generators have $\mathbb{Z}$-degrees given by the following map

$$
\left(Y_{1}, Y_{2}, X_{1}, X_{2}, \text { eu, } A, B, D\right) \longmapsto(-4,-6,4,6,0,2,-2,0)
$$

Moreover, in this presentation, $\mathbb{C}[V]^{W}=\mathbb{C}\left[X_{1}, X_{2}\right]$ and $\mathbb{C}\left[V^{*}\right]^{W}=\mathbb{C}\left[Y_{1}, Y_{2}\right]$.
We can deduce from this that $\mathscr{Z}_{c}$ is smooth if and only if

$$
k_{0} k_{1} k_{2}\left(k_{0}-k_{1}\right)\left(k_{0}-k_{2}\right)\left(k_{1}-k_{2}\right) \neq 0 .
$$

First case: assume that $d=2$. In this case, the above presentation shows that, whenever $(\diamond)$ holds, then $\mathscr{E}_{c}^{\sigma}$ has four irreducible components $\mathscr{X}, p, q$ and $r$ where $\mathscr{X}$ has dimension 2 and is isomorphic to

$$
\begin{equation*}
\mathscr{X} \simeq\left\{(x, y, e) \in \mathbb{C}^{3} \mid e\left(e-12 k_{0}\right)\left(e-12 k_{1}\right)\left(e-12 k_{2}\right)=x y\right\}, \tag{O}
\end{equation*}
$$

and $p, q$ and $r$ are three points (which belong to $\mathscr{Z}_{c}^{\mathbb{C}^{\times}}$). If $(\diamond)$ does not hold, then $\mathscr{E}_{c}^{\sigma}$ still contains an irreducible component of dimension 2 with the same description as above,
and a few other isolated points (the number depends on the exact values of the $k_{i}$ ). By Remark 1.4, we only need to consider the irreducible component $\mathscr{X}$. But it follows from ( $(\mathcal{O})$ and Example 1.2 that then $\mathscr{X}$ is isomorphic to the Calogero-Moser associated with a cyclic group of order 4 acting on a one-dimensional space: as there is an element $w$ of order 4 in $W$, one can choose for $V^{\prime}$ an eigenspace of $w$ and for $W^{\prime}$ the cyclic group $\langle w\rangle$ and Conjecture F is checked in this case (note also that the map $c \mapsto c^{\prime}$ is linear).
Second case: assume that $d=3$. In this case, the above presentation shows that, whenever $(\diamond)$ holds, then $\mathscr{E}_{c}^{\sigma}$ has two irreducible components $\mathscr{X}$ and $p$ where $\mathscr{X}$ has dimension 2 and is isomorphic to

$$
\text { (也) } \mathscr{X} \simeq\left\{(x, y, e) \in \mathbb{C}^{3} \mid\left(e-6 k_{0}\right)\left(e-6 k_{1}\right)\left(e-6 k_{2}\right)\left(e-12 k_{0}\right)\left(e-12 k_{1}\right)\left(e-12 k_{2}\right)=x y\right\} \text {, }
$$

and $p$ is a point (which belongs to $\mathscr{Z}_{c}^{\mathbb{C}^{\times}}$). If $(\diamond)$ does not hold, then $\mathscr{E}_{c}^{\sigma}$ still contains an irreducible component of dimension 2 with the same description as above, and maybe one extra point according to the values of the $k_{i}$. By Remark 1.4, we only need to consider the irreducible component $\mathscr{X}$. But it follows from ( $\boldsymbol{\phi}$ ) and Example 1.2 that then $\mathscr{X}$ is isomorphic to the Calogero-Moser associated with a cyclic group of order 6 acting on a one-dimensional space: as $-s \in W$ is of order 6 , one can choose for $V^{\prime}$ the $\omega$-eigenspace of $s$ and for $W^{\prime}$ the cyclic group $\langle-s\rangle$ and Conjecture F is checked in this case (note also that the map $c \mapsto c^{\prime}$ is linear).
