# SWEEPING PROCESSES PERTURBED BY ROUGH SIGNALS

#### Abstract

This paper deals with the existence and the uniqueness of the solution to sweeping processes perturbed by a continuous signal of finite $p$ variation with $p \in[1,3[$. It covers pathwise stochastic noises directed by a fractional Brownian motion of Hurst parameter greater than $1 / 3$.

## 1. Introduction

Consider a multifunction $C:[0, T] \rightrightarrows \mathbb{R}^{e}$ with $e \in \mathbb{N}^{*}$. Roughly speaking, the Moreau sweeping process (see Moreau [20]) associated to $C$ is the path $X$, living in $C$, such that when it hits the frontier of $C$, a minimal force is applied to $X$ in order to keep it inside of $C$. Precisely, $X$ is the solution to the following differential inclusion:

$$
\left\{\begin{align*}
-\frac{d D Y}{d|D Y|}(t) & \in N_{C(t)}(Y(t))|D Y| \text {-a.e. }  \tag{1}\\
Y(0) & =a \in C(0)
\end{align*}\right.
$$

where $D Y$ is the differential measure associated with the continuous function of bounded variation $Y,|D Y|$ is its variation measure, and $N_{C(t)}(Y(t))$ is the normal cone of $C(t)$ at $Y(t)$. This problem has been deeply studied by many authors. For instance, the reader can refer to Moreau [20], Valadier [25] or Monteiro Marques [19].

Several authors studied some perturbed versions of Problem (1), in particular by a stochastic multiplicative noise in Itô's calculus framework (see Revuz and Yor [22]). For instance, the reader can refer to Bernicot and Venel [3] or Castaing et al. [5]. On reflected diffusion processes, which perturbed sweeping processes with constant constraint set, the reader can refer to Kang and Ramanan [13].

Consider the perturbed Skorokhod problem

X(t) & =H(t)+Y(t)  \tag{2}\\
H(t) & =\int_{0}^{t} f(X(s)) d Z(s) \\
-\frac{d D Y}{d|D Y|}(t) & \in N_{C_{H}(t)}(Y(t))|D Y| \text {-a.e. with } Y(0)=a
\end{align*}\right.
$$

where $C_{H}(t)=C(t)-H(t), t \in[0, T]$ (thus $\left.N_{C_{H}(t)}(Y(t))=N_{C(t)}(X(t))\right), Z$ : $[0, T] \rightarrow \mathbb{R}^{d}$ is a continuous signal of finite $p$-variation with $d \in \mathbb{N}^{*}$ and $p \in[1, \infty[$, $f \in \operatorname{Lip}^{\gamma}\left(\mathbb{R}^{e}, \mathcal{M}_{e, d}(\mathbb{R})\right)$ with $\gamma>p$, and the integral against $Z$ is taken in the sense of rough paths. On the rough integral, the reader can refer to Lyons [16], Friz and Victoir [11] or Friz and Hairer [9]. Throughout the paper, the multifunction $C$ satisfies the following assumption.

Assumption 1.1. $C$ is a convex compact valued multifunction, continuous for the Hausdorff distance, and there exists a continuous selection $\gamma:[0, T] \rightarrow \mathbb{R}^{e}$ satisfying

$$
\bar{B}_{e}(\gamma(t), r) \subset \operatorname{int}(C(t)) ; \forall t \in[0, T]
$$

where $\bar{B}_{e}(\gamma(t), r)$ denotes the closed ball of radius $r$ centered at $\gamma(t)$.
This assumption is equivalent to saying that $C(t)$ has nonempty interior for every $t \in[0, T]$, see [5, Lemma 2.2].

In Falkowski and Słomiński [8], when $p \in\left[1,2\left[\right.\right.$ and $C(t)$ is a cuboid of $\mathbb{R}^{e}$ for every $t \in[0, T]$, the authors proved the existence and uniqueness of the solution of Problem (2). Furthermore, several authors studied the existence and uniqueness of the solution for reflected rough differential equations. In [1], M. Besalú et al. proved the existence and uniqueness of the solution for delayed rough differential equations with non-negativity constraints. Recently, S. Aida gets the existence of solutions for a large class of reflected rough differential equations in [2] and [1]. Finally, in [6], A. Deya et al. proved the existence and uniqueness of the solution for 1-dimensional reflected rough differential equations. An interesting remark related to these references is that when $C$ is not a cuboid, moving or not, it is a challenge to get the uniqueness of the solution for reflected rough differential equations and sweeping processes.

For $p \in[1,3[$, the purpose of this paper is to prove the existence of solutions to Problem (2) when $C$ satisfies Assumption 1.1, and a necessary and sufficient condition for uniqueness close to the monotonicity of the normal cone which allows to prove the uniqueness when $p=1$ and there is an additive continuous signal of finite $q$-variation with $q \in[1,3[$.

Section 2 deals with some preliminaries on sweeping processes and the rough integral. Section 3 is devoted to the existence of solutions to Problem (2) when $Z$ is a moderately irregular signal (i.e. $p \in[1,2[$ ) and when $Z$ is a rough signal (i.e. $p \in[2,3[)$. Section 4 deals with some uniqueness results. Finally, Section 5 deals with sweeping processes perturbed by a pathwise stochastic noise directed by a fractional Brownian motion of Hurst parameter greater than $1 / 3$.

The following notations, definitions and properties are used throughout the paper.

## Notations and elementary properties:

1. $C_{h}(t):=C(t)-h(t)$ for every function $h:[0, T] \rightarrow \mathbb{R}^{e}$.
2. $N_{C}(x)$ is the normal cone of $C$ at $x$, for any closed convex subset $C$ of $\mathbb{R}^{e}$ and any $x \in \mathbb{R}^{e}$ (recall that $N_{C}(x)=\emptyset$ if $x \notin C$ ).
3. $\Delta_{T}:=\left\{(s, t) \in[0, T]^{2}: s<t\right\}$ and $\Delta_{s, t}:=\left\{(u, v) \in[s, t]^{2}: u<v\right\}$ for every $(s, t) \in \Delta_{T}$.
4. For every function $x$ from $[0, T]$ into $\mathbb{R}^{d}$ and $(s, t) \in \Delta_{T}, x(s, t):=x(t)-x(s)$.
5. Consider $(s, t) \in \Delta_{T}$. The vector space of continuous functions from $[s, t]$ into $\mathbb{R}^{d}$ is denoted by $C^{0}\left([s, t], \mathbb{R}^{d}\right)$ and equipped with the uniform norm $\|\cdot\|_{\infty, s, t}$ defined by

\|x\|_{\infty, s, t}:=\sup _{u \in[s, t]}\|x(u)\|
$$

for every $x \in C^{0}\left([s, t], \mathbb{R}^{d}\right)$. Moreover, $\|\cdot\|_{\infty, T}:=\|\cdot\|_{\infty, 0, T}$ and

$$
C_{0}^{0}\left([s, t], \mathbb{R}^{d}\right):=\left\{x \in C^{0}\left([s, t], \mathbb{R}^{d}\right): x(0)=0\right\} .
$$

6. Consider $(s, t) \in \Delta_{T}$. The set of all dissections of $[s, t]$ is denoted by $\mathfrak{D}_{[s, t]}$ and the set of all strictly increasing sequences $\left(s_{n}\right)_{n \in \mathbb{N}}$ of $[s, t]$ such that $s_{0}=s$ and $\lim _{\infty} s_{n}=t$ is a denoted by $\mathfrak{D}_{\infty,[s, t]}$.
7. Consider $(s, t) \in \Delta_{T}$. A continuous function $x:[s, t] \rightarrow \mathbb{R}^{d}$ has finite $p$-variation if and only if,

\|x\|_{p-\mathrm{var}, s, t} & :=\sup \left\{\left|\sum_{k=1}^{n-1}\left\|x\left(t_{k}, t_{k+1}\right)\right\|^{p}\right|^{1 / p} ; n \in \mathbb{N}^{*} \text { and }\left(t_{k}\right)_{k \in \llbracket 1, n \rrbracket} \in \mathfrak{D}_{[s, t]}\right\} \\
& <\infty
\end{aligned}
$$

Consider the vector space

$$
C^{p-\operatorname{var}}\left([s, t], \mathbb{R}^{d}\right):=\left\{x \in C^{0}\left([s, t], \mathbb{R}^{d}\right):\|x\|_{p-\operatorname{var}, s, t}<\infty\right\} .
$$

The map $\|\cdot\|_{p-\mathrm{var}, s, t}$ is a semi-norm on $C^{p-\operatorname{var}}\left([s, t], \mathbb{R}^{d}\right)$.
Moreover, $\|\cdot\|_{p-\mathrm{var}, T}:=\|\cdot\|_{p-\mathrm{var}, 0, T}$.
Remarks :
a. For every $q, r \in[1, \infty[$ such that $q \geqslant r$,

$$
\forall x \in C^{r-\operatorname{var}}\left([s, t], \mathbb{R}^{d}\right),\|x\|_{q-\operatorname{var}, s, t} \leqslant\|x\|_{r-\operatorname{var}, s, t} .
$$

In particular, any continuous function of bounded variation on $[s, t]$ belongs to $C^{q \text {-var }}\left([s, t], \mathbb{R}^{d}\right)$ for every $q \in[1, \infty[$.
b. For every $(s, t) \in \Delta_{T}$ and $x \in C^{1-\mathrm{var}}([s, t], \mathbb{R})$,

$$
\|x\|_{1-\mathrm{var}, s, t}=\int_{s}^{t}|D x|
$$

where $|D x|$ is the variation measure of the differential measure $D x$ associated with $x$.
8. The vector space of Lipschitz continuous maps from $\mathbb{R}^{e}$ into $\mathcal{M}_{e, d}(\mathbb{R})$ is denoted by $\operatorname{Lip}\left(\mathbb{R}^{e}, \mathcal{M}_{e, d}(\mathbb{R})\right)$ and equipped with the Lipschitz semi-norm $\|\cdot\|_{\text {Lip }}$ defined by

\|\varphi\|_{\text {Lip }}:=\sup \left\{\frac{\|\varphi(y)-\varphi(x)\|}{\|y-x\|} ; x, y \in \mathbb{R}^{e} \text { and } x \neq y\right\}
$$

for every $\varphi \in \operatorname{Lip}\left(\mathbb{R}^{e}, \mathcal{M}_{e, d}(\mathbb{R})\right)$.
9. For every $\lambda \in \mathbb{R}$,

$$
\lfloor\lambda\rfloor:=\max \{n \in \mathbb{Z}: n<\lambda\}
$$

and $\{\lambda\}:=\lambda-\lfloor\lambda\rfloor$.
10. Consider $\gamma \in\left[1, \infty\left[\right.\right.$. A continuous map $\varphi: \mathbb{R}^{e} \rightarrow \mathcal{M}_{d, e}(\mathbb{R})$ is $\gamma$-Lipschitz in the sense of Stein if and only if,

\begin{aligned}
\|\varphi\|_{\text {Lip } \gamma} & :=\left\|D^{\lfloor\gamma\rfloor} \varphi\right\|_{\{\gamma\} \text {-Höl }} \vee \max \left\{\left\|D^{k} \varphi\right\|_{\infty} ; k \in \llbracket 0,\lfloor\gamma\rfloor \rrbracket\right\} \\
& <\infty .
\end{aligned}
$$

Consider the vector space

$$
\operatorname{Lip}^{\gamma}\left(\mathbb{R}^{e}, \mathcal{M}_{e, d}(\mathbb{R})\right):=\left\{\varphi \in C^{0}\left(\mathbb{R}^{e}, \mathcal{M}_{e, d}(\mathbb{R})\right):\|\varphi\|_{\operatorname{Lip}^{\gamma}}<\infty\right\}
$$

The map $\|\cdot\|_{\text {Lip }^{\gamma}}$ is a norm on $\operatorname{Lip}^{\gamma}\left(\mathbb{R}^{e}, \mathcal{M}_{e, d}(\mathbb{R})\right)$.

## Remarks:

a. If $\varphi \in \operatorname{Lip}^{\gamma}\left(\mathbb{R}^{e}, \mathcal{M}_{e, d}(\mathbb{R})\right)$, then $\varphi \in \operatorname{Lip}\left(\mathbb{R}^{e}, \mathcal{M}_{e, d}(\mathbb{R})\right)$.
b. If $\varphi \in C^{\lfloor\gamma\rfloor+1}\left(\mathbb{R}^{e}, \mathcal{M}_{e, d}(\mathbb{R})\right)$ is bounded with bounded derivatives, then $\varphi \in$ $\operatorname{Lip}^{\gamma}\left(\mathbb{R}^{e}, \mathcal{M}_{e, d}(\mathbb{R})\right)$.

## 2. Preliminaries

This section deals with some preliminaries on sweeping processes and the rough integral. The first subsection states some fundamental results on unperturbed sweeping processes coming from Moreau [20], Valadier [25] and Monteiro Marques [19]. A continuity result of Castaing et al. [5], which is the cornerstone of the proofs of Theorem 3.1 and Theorem 3.2, is also stated. The second subsection deals with the integration along rough paths. In this paper, definitions and propositions are stated as in Friz and Hairer [9], in accordance with M. Gubinelli's approach (see Gubinelli [12]).
2.1. Sweeping processes. The following theorem, due to Monteiro Marques [17, $18,19]$ using an estimation due to Valadier (see [4, 25]), states a sufficient condition of existence and uniqueness of the solution of the unperturbed sweeping process defined by Problem (1).

Proposition 2.1. Assume that $C$ is a convex compact valued multifunction, continuous for the Hausdorff distance, and such that there exists $\left.(x, r) \in \mathbb{R}^{e} \times\right] 0, \infty[$ satisfying

$$
\bar{B}_{e}(x, r) \subset C(t) ; \forall t \in[0, T] .
$$

Then Problem (1) has a unique continuous solution of finite 1-variation y : $[0, T] \rightarrow$ $\mathbb{R}^{e}$ such that

$$
\|y\|_{1-\mathrm{var}, T} \leqslant \mathfrak{l}(r,\|a-x\|)
$$

where $l: \mathbb{R}_{+}^{2} \rightarrow \mathbb{R}_{+}$is the map defined by

$$
l(s, S):=\left\{\begin{array}{c}
\max \left\{0, \frac{S^{2}-s^{2}}{2 s}\right\} \\
\text { if } e>1 \\
\max \{0, S-s\} \text { if } e=1
\end{array} ; \forall s, S \in \mathbb{R}_{+} .\right.
$$

See Monteiro Marques [19] for a proof.
Let $h$ be a continuous function from $[0, T]$ into $\mathbb{R}^{e}$ such that $h(0)=0$. If it exists, a Skorokhod decomposition of $(C, a, h)$ is a couple $\left(v_{h}, w_{h}\right)$ such that:

$$
\left\{\begin{align*}
v_{h}(t) & =h(t)+w_{h}(t)  \tag{3}\\
-\frac{d D w_{h}}{d\left|D w_{h}\right|}(t) & \in N_{C_{h}(t)}\left(w_{h}(t)\right)\left|D w_{h}\right| \text {-a.e. with } w_{h}(0)=a,
\end{align*}\right.
$$

where $v_{h}$ and $w_{h}$ are continuous, and $w_{h}$ has bounded variation. Since $N_{C_{h}(t)}(x)=$ $\emptyset$ when $x \notin C_{h}(t)$, the system (3) implies that, $\left|D w_{h}\right|$-a.e., $w_{h}(t) \in C_{h}(t)$, that is, $v_{h}(t) \in C(t)$. Under Assumption 1.1, by Proposition 2.1 together with Castaing et al. [5, Lemma 2.2], $(C, a, h)$ has a unique Skorokhod decomposition $\left(v_{h}, w_{h}\right)$.

Theorem 2.2. Under Assumption 1.1, if $\left(h_{n}\right)_{n \in \mathbb{N}}$ is a sequence of continuous functions from $[0, T]$ into $\mathbb{R}^{e}$ which converges uniformly to $h \in C^{0}\left([0, T], \mathbb{R}^{e}\right)$, then

$$
\sup _{n \in \mathbb{N}}\left\|w_{h_{n}}\right\|_{1-\mathrm{var}, T}<\infty
$$

and

$$
\left(v_{h_{n}}, w_{h_{n}}\right) \xrightarrow[n \rightarrow \infty]{\|\cdot\|_{\infty, T}}\left(v_{h}, w_{h}\right) .
$$

See Castaing et al. [5, Theorem 2.3].
Under Assumption 1.1, note that there exist $R>0, N \in \mathbb{N}^{*}$ and a dissection $\left(t_{0}, \ldots, t_{N}\right)$ of $[0, T]$ such that

\bar{B}_{e}\left(\gamma\left(t_{k}\right), R\right) \subset C(u) \tag{4}
\end{equation*}
$$

for every $k \in \llbracket 0, N-1 \rrbracket$ and $u \in\left[t_{k}, t_{k+1}\right]$.
Proposition 2.3. Under Assumption 1.1:
(1) The map $(v ., w$.$) is continuous from$

$$
C_{0}^{0}\left([0, T], \mathbb{R}^{e}\right) \text { to } C^{0}\left([0, T], \mathbb{R}^{e}\right) \times C^{1-\operatorname{var}}\left([0, T], \mathbb{R}^{e}\right)
$$

(2) Consider $(s, t) \in \Delta_{T}$ and $\left.\left.\rho \in\right] 0, R / 2\right]$ where $R$ is defined in (4). For every $h \in C_{0}^{0}\left([s, t], \mathbb{R}^{e}\right)$ such that $\|h\|_{\infty, s, t} \leqslant \rho / 2$,

$$
\left\|w_{h}\right\|_{1-\operatorname{var}, s, t} \leqslant \mathfrak{M}(\rho)
$$

with

$$
\mathfrak{M}(\rho):=\frac{N}{2 \rho} \sup _{u \in[0, T]} \sup _{x, y \in C(u)}\|x-y\|^{2}
$$

Proof. Refer to Castaing et al. [5, Lemma 5.3] for a proof of the first point.
Let us insert $s$ and $t$ in the dissection $\left(t_{0}, \ldots, t_{N}\right)$ of $[0, T]$ and define $k(s), k(t) \in$ $\llbracket 0, N+2 \rrbracket$ by

t_{k(s)}:=s \text { and } t_{k(t)}:=t
$$

Consider $k \in \llbracket k(s), k(t)-1 \rrbracket$ and $u \in\left[t_{k}, t_{k+1}\right]$.
On the one hand,

$$
\bar{B}_{e}\left(\gamma\left(t_{k}\right)-h\left(t_{k}\right), \rho\right) \subset B_{e}\left(\gamma\left(t_{k}\right)-h(u), R\right) \subset C_{h}(u) .
$$

So,

$$
\bar{B}_{e}\left(\gamma\left(t_{k}\right)-v_{h}\left(t_{k}\right), \rho\right) \subset C(u)-h\left(t_{k}, u\right)-v_{h}\left(t_{k}\right) .
$$

On the other hand,

v_{h}\left(t_{k}, u\right)=h\left(t_{k}, u\right)+w_{h, t_{k}}(u)
$$

with

w_{h, t_{k}}(u):=w_{h}(u)-w_{h}\left(t_{k}\right) .
$$

Moreover,

and then,

-\frac{d D w_{h, t_{k}}}{d\left|D w_{h, t_{k}}\right|}(u) & \in N_{C(u)-h\left(t_{k}, u\right)-v_{h}\left(t_{k}\right)}\left(w_{h, t_{k}}(u)\right)\left|D w_{h, t_{k}}\right| \text {-a.e. } \\
w_{h, t_{k}}\left(t_{k}\right) & =0 .
\end{aligned}\right.
$$

So, by Proposition 2.1:

\left\|w_{h}\right\|_{1-\mathrm{var}, t_{k}, t_{k+1}} & =\left\|w_{h, t_{k}}\right\|_{1-\mathrm{var}, t_{k}, t_{k+1}} \\
& \leqslant l\left(\rho,\left\|\gamma\left(t_{k}\right)-v_{h}\left(t_{k}\right)\right\|\right) .
\end{aligned}
$$

Therefore,

\left\|w_{h}\right\|_{1-\mathrm{var}, s, t} & =\sum_{k=k(s)}^{k(t)-1}\left\|w_{h}\right\|_{1-\mathrm{var}, t_{k}, t_{k+1}} \\
& \leqslant N \sup _{u \in[s, t]} l\left(\rho,\left\|\gamma(u)-v_{h}(u)\right\|\right) \\
& \leqslant \mathfrak{M}(\rho)
\end{aligned}
$$

2.2. Young's integral, rough integral. The first part of the subsection deals with the definition and some basic properties of Young's integral which allow to integrate a map $y \in C^{r-\operatorname{var}}\left([0, T], \mathcal{M}_{e, d}(\mathbb{R})\right)$ with respect to $z \in C^{q-\operatorname{var}}\left([0, T], \mathbb{R}^{d}\right)$ when $q, r \in[1, \infty[$ and $1 / q+1 / r>1$. The second part of the subsection deals with the rough integral which extends Young's integral when the condition $1 / q+1 / r>1$ is not satisfied anymore. The signal $z$ has to be enhanced as a rough path.

Definition 2.4. A map $\omega: \Delta_{T} \rightarrow \mathbb{R}_{+}$is a control function if and only if,
(1) $\omega$ is continous.
(2) $\omega(s, s)=0$ for every $s \in[0, T]$.
(3) $\omega$ is super-additive:

$$
\omega(s, u)+\omega(u, t) \leqslant \omega(s, t)
$$

for every $s, t, u \in[0, T]$ such that $s \leqslant u \leqslant t$.
Example. Let $p \geqslant 1$. For every $z \in C^{p-\operatorname{var}}\left([0, T], \mathbb{R}^{d}\right)$, the map

$$
\omega_{p, z}:(s, t) \in \Delta_{T} \longmapsto \omega_{p, z}(s, t):=\|z\|_{p-\mathrm{var}, s, t}^{p}
$$

is a control function.
Proposition 2.5. Let $p \geqslant 1$. Consider $x \in C^{0}\left([0, T], \mathbb{R}^{d}\right)$ and a sequence $\left(x_{n}\right)_{n \in \mathbb{N}}$ of elements of $C^{p-\operatorname{var}}\left([0, T], \mathbb{R}^{d}\right)$ such that

$$
\lim _{n \rightarrow \infty}\left\|x_{n}-x\right\|_{\infty, T}=0 \text { and } \sup _{n \in \mathbb{N}}\left\|x_{n}\right\|_{p-\operatorname{var}, T}<\infty .
$$

Then $x \in C^{p-\operatorname{var}}\left([0, T], \mathbb{R}^{d}\right)$ and

$$
\lim _{n \rightarrow \infty}\left\|x_{n}-x\right\|_{(p+\varepsilon)-\operatorname{var}, T}=0 ; \forall \varepsilon>0 .
$$

See Friz and Victoir [11, Lemma 5.12 and Lemma 5.27] for a proof.
Proposition 2.6. Consider $q, r \in[1, \infty[$ such that $1 / q+1 / r>1$, two maps $y \in C^{r-\operatorname{var}}\left([0, T], \mathcal{M}_{e, d}(\mathbb{R})\right)$ and $z \in C^{q-\operatorname{var}}\left([0, T], \mathbb{R}^{d}\right)$, and a sequence $\left(y_{n}\right)_{n \in \mathbb{N}}$ of elements of $C^{r-\operatorname{var}}\left([0, T], \mathcal{M}_{e, d}(\mathbb{R})\right)$ such that.

The geometric p-rough paths metric space $G \Omega_{p, T}\left(\mathbb{R}^{d}\right)$ is the closure of $\mathfrak{S}_{T}\left(\mathbb{R}^{d}\right)$ in $C^{p-\operatorname{var}}\left([0, T], \mathbb{R}^{d}\right) \times C^{p / 2-\operatorname{var}}\left([0, T], \mathcal{M}_{d}(\mathbb{R})\right)$.
Definition 2.10. For $z \in C^{p-\operatorname{var}}\left([0, T], \mathbb{R}^{d}\right)$, a map $y \in C^{p-\operatorname{var}}\left([0, T], \mathcal{M}_{e, d}(\mathbb{R})\right)$ is controlled by $z$ if and only if there exists $y^{\prime} \in C^{p-\operatorname{var}}\left([0, T], \mathcal{L}\left(\mathbb{R}^{d}, \mathcal{M}_{e, d}(\mathbb{R})\right)\right)$ such that

and called rough integral of $y$ with respect to $\mathbf{z}$ on $[0, T]$. Moreover,
(1) There exists a constant $c(p)>0$, depending only on $p$, such that for every $(s, t) \in \Delta_{T}$,

See Friz and Shekhar [10, Theorem 34] for a proof with the $p$-variation topology, and see Gubinelli [12, Theorem 1] or Friz and Hairer [9, Theorem 4.10] for a proof with the $1 / p$-Hölder topology.

\left\|\varphi(x)^{\prime}\right\|_{p-\mathrm{var}, s, t} & \leqslant\|\varphi\|_{\text {Lip } \gamma-1}\left(\left\|x^{\prime}\right\|_{p-\operatorname{var}, s, t}+\left\|x^{\prime}\right\|_{\infty, s, t}\|x\|_{p-\mathrm{var}, s, t}\right) \text { and } \\
\left\|R_{\varphi(x)}\right\|_{p / 2-\mathrm{var}, s, t} & \leqslant\|\varphi\|_{\text {Lip } \gamma-1}\left(\|x\|_{p-\mathrm{var}, s, t}^{2}+\left\|R_{x}\right\|_{p / 2-\mathrm{var}, s, t}\right)

where $\omega_{p, \mathbf{z}}: \Delta_{T} \rightarrow \mathbb{R}_{+}$is the control function defined by

\left(x, x^{\prime}\right):[0, T] \longrightarrow \mathbb{R}^{e} \times \mathcal{L}\left(\mathbb{R}^{d}, \mathbb{R}^{e}\right)
$$

and a sequence $\left(x_{n}, x_{n}^{\prime}\right)_{n \in \mathbb{N}}$ of elements of $\mathfrak{D}_{z}^{p / 2}\left([0, T], \mathbb{R}^{e}\right)$ such that

\left(x_{n}^{\prime}, R_{x_{n}}\right) \xrightarrow[n \rightarrow \infty]{d_{\infty, T}}\left(x^{\prime}, R_{x}\right) \text { and } \sup _{n \in \mathbb{N}}\left\|\left(x_{n}, x_{n}^{\prime}\right)\right\|_{z, p / 2, T}<\infty .

## 3. Existence of solutions

The existence of a solution to Problem (2) is established in Theorem 3.1 when $p \in[1,2[$, and in Theorem 3.2 when $p \in[2,3[$.

Theorem 3.1. Under Assumption 1.1, if $p \in[1,2[$, Problem (2) has at least one solution which belongs to $C^{p-\operatorname{var}}\left([0, T], \mathbb{R}^{e}\right)$.

Proof. Consider the discrete scheme

X_{0}(0) & =a

Since the map $\|Z\|_{p \text {-var, } 0, \text {, is continuous from }[0, T] \text { into } \mathbb{R}_{+} \text {, and since }\|Z\|_{p \text {-var, } 0,0}=}$ 0 , there exists $\tau_{0} \in[0, T]$ such that

For every $t \in[0, T]$, the map $\|Z\|_{p \text {-var, } t, \text {. }}$ is continuous from $[t, T]$ into $\mathbb{R}_{+}$and $\|Z\|_{p \text {-var }, t, t}=0$. Moreover, the constant $\mu$ depends only on $p, m, M$ and $\|f\|_{\text {Lip } \gamma}$. So, since $[0, T]$ is compact, there exist $N \in \mathbb{N}^{*}$ and $\left(\tau_{k}\right)_{k \in \llbracket 0, N \rrbracket} \in \mathfrak{D}_{\left[\tau_{0}, T\right]}$ such that

& (s, t) \in \Delta_{T} \longmapsto\left\|Y_{n}\right\|_{1 \text {-var }, s, t}
\end{aligned}

are control functions, recursively, the sequence $\left(H_{n}, X_{n}, Y_{n}\right)_{n \in \mathbb{N}^{*}}$ is bounded in

Therefore, by Arzelà-Ascoli's theorem together with Proposition 2.5, there exists an extraction $\varphi: \mathbb{N} \backslash\{0,1\} \rightarrow \mathbb{N} \backslash\{0,1\}$ such that $\left(H_{\varphi(n)}\right)_{n \in \mathbb{N} \backslash\{0,1\}}$ converges uniformly to an element $H$ of $C^{p-\operatorname{var}}\left([0, T], \mathbb{R}^{e}\right)$.

Since $\left(H_{\varphi(n)}\right)_{n \in \mathbb{N} \backslash\{0,1\}}$ converges uniformly to $H$, by Theorem 2.2 , the sequence
$\left(X_{\varphi(n)}, Y_{\varphi(n)}\right)_{n \in \mathbb{N} \backslash\{0,1\}}$ converges uniformly to $(X, Y):=\left(v_{H}, w_{H}\right)$. So, for every $t \in[0, T]$,

$$
\left\{\begin{aligned}
X(t) & =H(t)+Y(t) \\
-\frac{d D Y}{d|D Y|}(t) & \in N_{C_{H}(t)}(Y(t))|D Y| \text {-a.e. with } Y(0)=a
\end{aligned}\right.
$$

and by Proposition 2.5,

$$
X \in C^{p-\operatorname{var}}\left([0, T], \mathbb{R}^{e}\right) \text { and } Y \in C^{1-\operatorname{var}}\left([0, T], \mathbb{R}^{e}\right)
$$

Denoting $X^{\prime}:=f(X), X^{\prime}\left(\right.$ resp. $\left.R_{X}\right)$ is the uniform limit of $\left(X_{\varphi(n)}^{\prime}\right)_{n \in \mathbb{N} \backslash\{0,1\}}$ (resp. $\left.\left(R_{X_{\varphi(n)}}\right)_{n \in \mathbb{N} \backslash\{0,1\}}\right)$. So, by Proposition 2.14:

$$
\lim _{n \rightarrow \infty}\left\|H_{\varphi(n)}-\int_{0} f(X(s)) d \mathbf{Z}(s)\right\|_{\infty, T}=0
$$

Therefore, since $\left(H_{\varphi(n)}\right)_{n \in \mathbb{N}^{*}}$ converges also to $H$ in $C^{0}\left([0, T], \mathbb{R}^{e}\right)$,

$$
H(t)=\int_{0}^{t} f(X(s)) d \mathbf{Z}(s) ; \forall t \in[0, T]
$$

## 4. Some uniqueness results

When $p=1$ and there is an additive continuous signal of finite $q$-variation with $q \in[1,3[$, the uniqueness of the solution to Problem (2) is established in Proposition 4.1 below. Proposition 4.2 and Proposition 4.3 provide necessary and sufficient conditions for uniqueness of the solution when $p \in[1,2[$ and $p \in[2,3[$ respectively. These conditions are close to the monotonicity of the normal cone which allows to prove the uniqueness when $p=1$ (see Proposition 4.1).

Proposition 4.1. Assume that $p=1$ and consider the Skorokhod problem

$$
\left\{\begin{align*}
X(t) & =H(t)+Y(t)  \tag{12}\\
H(t) & =\int_{0}^{t} f(X(s)) d Z(s)+\sigma W(t) \\
-\frac{d D Y}{d|D Y|}(t) & \in N_{C_{H}(t)}(Y(t))|D Y| \text {-a.e. with } Y(0)=a
\end{align*}\right.
$$

where $\sigma \in \mathcal{M}_{e, d}(\mathbb{R})$ and $W \in C^{q-\operatorname{var}}\left([0, T], \mathbb{R}^{d}\right)$ with $q \in[1,3[$. Under Assumption 1.1, Problem (12) has a unique solution which belongs to $C^{q-\mathrm{var}}\left([0, T], \mathbb{R}^{e}\right)$.

Proof. Consider two solutions $(X, Y)$ and $\left(X^{*}, Y^{*}\right)$ of Problem (2) on [0,T]. Since $(s, t) \in \Delta_{T} \mapsto\|Z\|_{1-\mathrm{var}, s, t}$ is a control function, there exists $n \in \mathbb{N}^{*}$ and $\left(\tau_{k}\right)_{k \in \llbracket 0, n \rrbracket} \in$ $\mathfrak{D}_{[0, T]}$ such that

$$
\begin{equation*}
\|Z\|_{1-\mathrm{var}, \tau_{k}, \tau_{k+1}} \leqslant M:=\frac{1}{4\|f\|_{\mathrm{Lip} \gamma}} ; \forall k \in \llbracket 0, n-1 \rrbracket . \tag{13}
\end{equation*}
$$

For every $t \in\left[0, \tau_{1}\right]$,

$$
\begin{aligned}
\left\|X(t)-X^{*}(t)\right\|^{2}= & \left\|H(t)-H^{*}(t)\right\|^{2}+2 \int_{0}^{t}\left\langle Y(s)-Y^{*}(s), d\left(Y-Y^{*}\right)(s)\right\rangle \\
& +2 \int_{0}^{t}\left\langle H(t)-H^{*}(t), d\left(Y-Y^{*}\right)(s)\right\rangle \\
\leqslant & m_{1}\left(\tau_{1}\right)^{2}+2 m_{2}(t)+2 m_{3}(t)
\end{aligned}
$$

with $m_{1}\left(\tau_{1}\right):=\left\|H-H^{*}\right\|_{\infty, \tau_{1}}$,

$$
m_{2}(t):=\int_{0}^{t}\left\langle X(s)-X^{*}(s), d\left(Y-Y^{*}\right)(s)\right\rangle
$$

and

$$
m_{3}(t):=\int_{0}^{t}\left\langle H(t)-H^{*}(t)-\left(H(s)-H^{*}(s)\right), d\left(Y-Y^{*}\right)(s)\right\rangle
$$

Consider $t \in\left[0, \tau_{1}\right]$. By Friz and Victoir [11], Proposition 2.2:

$$
\begin{aligned}
\left\|H(t)-H^{*}(t)\right\| & =\left\|\int_{0}^{t}\left(f(X(s))-f\left(X^{*}(s)\right)\right) d Z(s)\right\| \\
& \leqslant\|f\|_{\operatorname{Lip}^{\gamma} \gamma}\left\|X-X^{*}\right\|_{\infty, \tau_{1}}\|Z\|_{1-\mathrm{var}, \tau_{1}} .
\end{aligned}
$$

So,

\begin{equation*}
m_{1}\left(\tau_{1}\right) \leqslant \frac{1}{4}\left\|X-X^{*}\right\|_{\infty, \tau_{1}} \tag{14}
\end{equation*}
$$

Since the map $x \in C(t) \mapsto N_{C(t)}(x)$ is monotone, $m_{2}(t) \leqslant 0$. By the integration by parts formula,

m_{3}(t) & =\int_{0}^{t}\left\langle Y(s)-Y^{*}(s), d\left(H-H^{*}\right)(s)\right\rangle \\
& =\int_{0}^{t}\left\langle X(s)-X^{*}(s)-\left(H(s)-H^{*}(s)\right),\left(f(X(s))-f\left(X^{*}(s)\right)\right) d Z(s)\right\rangle
\end{aligned}
$$

So, by Friz and Victoir [11], Proposition 2.2 and Inequality (14),

$$
\begin{aligned}
m_{3}(t) & \leqslant\|D f\|_{\infty}\left\|X-X^{*}\right\|_{\infty, \tau_{1}}\left(\left\|X-X^{*}\right\|_{\infty, \tau_{1}}+\left\|H-H^{*}\right\|_{\infty, \tau_{1}}\right)\|Z\|_{1-\mathrm{var}, \tau_{1}} \\
& \leqslant\|f\|_{\operatorname{Lip}^{\gamma}}\|Z\|_{1-\mathrm{var}, \tau_{1}}\left(1+\|f\|_{\operatorname{Lip}^{\gamma}}\|Z\|_{1-\mathrm{var}, \tau_{1}}\right)\left\|X-X^{*}\right\|_{\infty, \tau_{1}}^{2} \\
& \leqslant 5 / 16\left\|X-X^{*}\right\|_{\infty, \tau_{1}}^{2} .
\end{aligned}
$$

Therefore,

$$
\left\|X-X^{*}\right\|_{\infty, \tau_{1}}^{2} \leqslant \frac{11}{16}\left\|X-X^{*}\right\|_{\infty, \tau_{1}}^{2}
$$

Necessarily, $(X, Y)=\left(X^{*}, Y^{*}\right)$ on $\left[0, \tau_{1}\right]$.
For $k \in \llbracket 0, n-1 \rrbracket$, assume that $(X, Y)=\left(X^{*}, Y^{*}\right)$ on $\left[0, \tau_{k}\right]$. By Equation (13) and exactly the same ideas as on $\left[0, \tau_{1}\right]$ :

\left\|X-X^{*}\right\|_{\infty, \tau_{k}, \tau_{k+1}}^{2} \leqslant \frac{11}{16}\left\|X-X^{*}\right\|_{\infty, \tau_{k}, \tau_{k+1}}^{2}
$$

So, $(X, Y)=\left(X^{*}, Y^{*}\right)$ on $\left[0, \tau_{k+1}\right]$. Recursively, Problem (2) has a unique solution on $[0, T]$.

Remark. The cornerstone of the proof of Proposition 4.1 is that

$$
\begin{equation*}
\int_{0}^{t}\left\langle X(s)-X^{*}(s), d\left(Y-Y^{*}\right)(s)\right\rangle \leqslant 0 ; \forall t \in[0, T] . \tag{15}
\end{equation*}
$$

Thanks to the monotonicity of the map $x \in C(t) \mapsto N_{C(t)}(x)(t \in[0, T])$, Inequality (15) is true. When $p \in] 1,3[$, it is not possible to get inequalities involving only the uniform norm of $X-X^{*}$. In that case, the construction of the Young/rough integral suggests to use ideas similar to those of the proof of Proposition 4.1, but using the $p$-variation norm of $X-X^{*}$.

In a probabilistic setting, uniqueness up to equality almost everywhere can be obtained for Brownian motion, with $p>2$, in the frame of Itô calculus, using the martingale property of stochastic integrals and Doob's inequality, see [24, 15, 23] for a fixed convex set $C$ and $[3,5]$ for a moving set.

The two following propositions show that when $p \in] 1,3[$, there exist some conditions close to Inequality (15), ensuring the uniqueness of the solution to Problem (2).

Proposition 4.2. Consider $(s, t) \in \Delta_{T}, p \in[1,2[$ and two solutions $(X, Y)$ and $\left(X^{*}, Y^{*}\right)$ to Problem (2) under Assumption 1.1. On $[s, t],(X, Y)=\left(X^{*}, Y^{*}\right)$ if and only if $X(s)=X^{*}(s)$ and

$$
\begin{equation*}
\int_{u}^{v}\left\langle X(u, r)-X^{*}(u, r), d\left(Y-Y^{*}\right)(r)\right\rangle \leqslant 0 ; \forall(u, v) \in \Delta_{s, t} . \tag{16}
\end{equation*}
$$

Proof. For the sake of simplicity, the proposition is proved on $[0, T]$ instead of $[s, t]$, with $(s, t) \in \Delta_{T}$.

First of all, if $(X, Y)=\left(X^{*}, Y^{*}\right)$ on $[s, t]$, then

\int_{u}^{v}\left\langle X(u, r)-X^{*}(u, r), d\left(Y-Y^{*}\right)(r)\right\rangle=0 ; \forall(u, v) \in \Delta_{s, t} .
$$

Now, let us prove that if $X(s)=X^{*}(s)$ and Inequality (16) is true, then $(X, Y)=$ $\left(X^{*}, Y^{*}\right)$.

For every $(s, t) \in \Delta_{T}$,

$$
\begin{aligned}
\left\|X(s, t)-X^{*}(s, t)\right\|^{2}= & \left\|H(s, t)-H^{*}(s, t)\right\|^{2} \\
& +2 \int_{s}^{t}\left\langle Y(s, u)-Y^{*}(s, u), d\left(Y-Y^{*}\right)(u)\right\rangle \\
& +2 \int_{s}^{t}\left\langle H(s, t)-H^{*}(s, t), d\left(Y-Y^{*}\right)(u)\right\rangle \\
= & \left\|H(s, t)-H^{*}(s, t)\right\|^{2} \\
& +2 \int_{s}^{t}\left\langle X(s, u)-X^{*}(s, u), d\left(Y-Y^{*}\right)(u)\right\rangle \\
& +2 \int_{s}^{t}\left\langle H(s, t)-H(s, u)-\left(H^{*}(s, t)-H^{*}(s, u)\right), d\left(Y-Y^{*}\right)(u)\right\rangle \\
\leqslant & \left\|H-H^{*}\right\|_{p-\mathrm{var}, s, t}^{2}+2 m(s, t)
\end{aligned}
$$

with

$$
m(s, t):=\int_{s}^{t}\left\langle H(u, t)-H^{*}(u, t), d\left(Y-Y^{*}\right)(u)\right\rangle .
$$

Let $(s, t) \in \Delta_{T}$ be arbitrarily chosen.
On the one hand,

$$
m(s, t) \leqslant 2 e \cdot c(p, p)\left\|H-H^{*}\right\|_{p-\mathrm{var}, s, t}\left\|Y-Y^{*}\right\|_{p-\mathrm{var}, s, t} .
$$

So, there exists a constant $c_{1}>0$, not depending on $s$ and $t$, such that

$$
\begin{aligned}
\left\|X(s, t)-X^{*}(s, t)\right\|^{p} \leqslant & \left(\left\|H-H^{*}\right\|_{p-\mathrm{var}, s, t}^{2}+2 m(s, t)\right)^{p / 2} \\
\leqslant & c_{1}\left(\left\|H-H^{*}\right\|_{p-\mathrm{var}, s, t}^{p}\right. \\
& \left.+\left(\left\|H-H^{*}\right\|_{p-\mathrm{var}, s, t}^{p}\right)^{1 / 2}\left(\left\|Y-Y^{*}\right\|_{p-\mathrm{var}, s, t}^{p}\right)^{1 / 2}\right)
\end{aligned}
$$

Since $1 / 2+1 / 2=1$, the right-hand side of the previous inequality defines a control function (see Friz and Victoir [11], Exercice 1.9), and then there exists a constant $c_{2}>0$, not depending on $s$ and $t$, such that

$$
\begin{align*}
\left\|X-X^{*}\right\|_{p-\operatorname{var}, s, t}^{p} & \leqslant c_{1}\left(\left\|H-H^{*}\right\|_{p-\operatorname{var}, s, t}^{p}+\left\|H-H^{*}\right\|_{p-\mathrm{var}, s, t}^{p / 2}\left\|Y-Y^{*}\right\|_{p-\operatorname{var}, s, t}^{p / 2}\right) \\
& \leqslant c_{2}\left(\left\|H-H^{*}\right\|_{p-\operatorname{var}, s, t}^{p}+\left\|H-H^{*}\right\|_{p-\mathrm{var}, s, t}^{p / 2}\left\|X-X^{*}\right\|_{p-\mathrm{var}, s, t}^{p / 2}\right) . \tag{17}
\end{align*}
$$

The right-hand side of the previous inequality defines a control function.
On the other hand, since $X(0)=X^{*}(0)$ :

\begin{aligned}
\left\|H-H^{*}\right\|_{p \text {-var }, s, t} \leqslant & c(p, p)\|Z\|_{p-\operatorname{var}, s, t}\left(\left\|f \circ X-f \circ X^{*}\right\|_{p \text {-var }, s, t}\right. \\
& \left.+\left\|f(X(s))-f(X(0))-\left(f\left(X^{*}(s)\right)-f\left(X^{*}(0)\right)\right)\right\|\right) \\
\leqslant & 2 c(p, p)\|Z\|_{p-\operatorname{var}, s, t}\left\|f \circ X-f \circ X^{*}\right\|_{p-\mathrm{var}, t}
\end{aligned}
$$

Consider $(u, v) \in \Delta_{t}$ and

\delta(u, v):=\left\|(f \circ X)(u, v)-\left(f \circ X^{*}\right)(u, v)\right\| .
$$

Applying Taylor's formula to the map $f$ between $X(u, v)$ and $X^{*}(u, v)$ :

\leqslant & \|f\|_{\operatorname{Lip} \gamma}\left(\left\|X-X^{*}\right\|_{p \text {-var }, u, v}+2\left\|X^{*}\right\|_{p \text {-var }, u, v}\left\|X-X^{*}\right\|_{p \text {-var }, t}\right) .
\end{aligned}
$$

So, there exists a constant $c_{3}>0$, not depending on $t$, such that

and then there exists a constant $c_{4}>0$, not depending on $s$ and $t$, such that

\left\|H-H^{*}\right\|_{p-\mathrm{var}, s, t} \leqslant c_{4}\|Z\|_{p-\mathrm{var}, s, t}\left\|X-X^{*}\right\|_{p-\mathrm{var}, t} \tag{18}
\end{equation*}
$$

By Equation (17) and Equation (18) together, there exists a constant $c_{5}>0$, not depending on $s$ and $t$, such that

\left\|X-X^{*}\right\|_{p-\mathrm{var}, s, t} \leqslant c_{5}\|Z\|_{p-\mathrm{var}, s, t}^{1 / 2}\left\|X-X^{*}\right\|_{p-\mathrm{var}, t}
$$

Since $(u, v) \in \Delta_{T} \mapsto\|Z\|_{p-\mathrm{var}, u, v}^{p}$ is a control function, there exists $N \in \mathbb{N}^{*}$ and $\left(\tau_{k}\right)_{k \in \llbracket 0, N \rrbracket} \in \mathfrak{D}_{[0, T]}$ such that

$$
\|Z\|_{p-\mathrm{var}, \tau_{k}, \tau_{k+1}} \leqslant \frac{1}{4 c_{5}^{2}} ; \forall k \in \llbracket 0, N-1 \rrbracket .
$$

First,

$$
\begin{aligned}
\left\|X-X^{*}\right\|_{p-\operatorname{var}, \tau_{1}} & \leqslant c_{5}\|Z\|_{p-\operatorname{var}, \tau_{1}}^{1 / 2}\left\|X-X^{*}\right\|_{p-\operatorname{var}, \tau_{1}} \\
& \leqslant \frac{1}{2}\left\|X-X^{*}\right\|_{p-\operatorname{var}, \tau_{1}}
\end{aligned}
$$

So, $X=X^{*}$ on $\left[0, \tau_{1}\right]$. For $k \in \llbracket 1, N-1 \rrbracket$, assume that $X=X^{*}$ on $\left[0, \tau_{k}\right]$. Then,

$$
\begin{aligned}
\left\|X-X^{*}\right\|_{p-\mathrm{var}, \tau_{k+1}} & =\left\|X-X^{*}\right\|_{p-\mathrm{var}, \tau_{k}, \tau_{k+1}} \\
& \leqslant \frac{1}{2}\left\|X-X^{*}\right\|_{p-\mathrm{var}, \tau_{k+1}}
\end{aligned}
$$

So, $X=X^{*}$ on $\left[0, \tau_{k+1}\right]$. Recursively, $X=X^{*}$ on $[0, T]$.
Proposition 4.3. Consider $(s, t) \in \Delta_{T}, p \in[2,3[$ and two solutions $(X, Y)$ and $\left(X^{*}, Y^{*}\right)$ to Problem (2) under Assumption 1.1. On $[s, t],(X, Y)=\left(X^{*}, Y^{*}\right)$ if and only if $X(s)=X^{*}(s)$ and

$$
\begin{equation*}
\int_{u}^{v}\left\langle R_{X}(u, r)-R_{X^{*}}(u, r), d\left(Y-Y^{*}\right)(r)\right\rangle \leqslant 0 ; \forall(u, v) \in \Delta_{s, t} \tag{19}
\end{equation*}
$$

Proof. For the sake of simplicity, the proposition is proved on $[0, T]$ instead of $[s, t]$ with $(s, t) \in \Delta_{T}$.

First of all, if $(X, Y)=\left(X^{*}, Y^{*}\right)$ on $[s, t]$, then

$$
\int_{u}^{v}\left\langle R_{X}(u, r)-R_{X^{*}}(u, r), d\left(Y-Y^{*}\right)(r)\right\rangle=0 ; \forall(u, v) \in \Delta_{s, t}
$$

Now, let us prove that if $X(s)=X^{*}(s)$ and Inequality (19) is true, then $(X, Y)=$ $\left(X^{*}, Y^{*}\right)$.

There exists a constant $c_{1}>0$ such that for every $(s, t) \in \Delta_{T}$,

\begin{align*}
& \left\|\left(X-X^{*},\left(X-X^{*}\right)^{\prime}\right)\right\|_{Z, p / 2, s, t}  \tag{20}\\
& \quad=\left\|f(X)-f\left(X^{*}\right)\right\|_{p-\operatorname{var}, s, t}+\left\|R_{X}-R_{X^{*}}\right\|_{p / 2-\operatorname{var}, s, t} \\
& \quad \leqslant c_{1}\left(\left\|R_{X}-R_{X^{*}}\right\|_{p / 2-\operatorname{var}, s, t}+\|Z\|_{p-\operatorname{var}, s, t}\left\|\left(X-X^{*},\left(X-X^{*}\right)^{\prime}\right)\right\|_{Z, p / 2, t}\right) .
\end{align*}
$$

Let us find a suitable control function dominating

$$
(s, t) \in \Delta_{T} \longmapsto\left\|R_{X}-R_{X^{*}}\right\|_{p / 2-\mathrm{var}, s, t}^{p / 2} .
$$

For every $(s, t) \in \Delta_{T}$,

$$
\begin{aligned}
\left\|R_{X}(s, t)-R_{X^{*}}(s, t)\right\|^{2}= & \left\|R_{H}(s, t)-R_{H^{*}}(s, t)\right\|^{2} \\
& +2 \int_{s}^{t}\left\langle Y(s, u)-Y^{*}(s, u), d\left(Y-Y^{*}\right)(u)\right\rangle \\
& +2 \int_{s}^{t}\left\langle R_{H}(s, t)-R_{H^{*}}(s, t), d\left(Y-Y^{*}\right)(u)\right\rangle \\
= & \left\|R_{H}(s, t)-R_{H^{*}}(s, t)\right\|^{2} \\
& +2 \int_{s}^{t}\left\langle R_{X}(s, u)-R_{X^{*}}(s, u), d\left(Y-Y^{*}\right)(u)\right\rangle \\
& +2 \int_{s}^{t}\left\langle R_{H}(s, t)-R_{H}(s, u)-\left(R_{H^{*}}(s, t)-R_{H^{*}}(s, u)\right), d\left(Y-Y^{*}\right)(u)\right\rangle \\
\leqslant & \left\|R_{H}-R_{H^{*}}\right\|_{p / 2-\operatorname{var}, s, t}^{2}+2 m(s, t)
\end{aligned}
$$

with

$$
m(s, t):=\int_{s}^{t}\left\langle R_{H}(u, t)-R_{H^{*}}(u, t), d\left(Y-Y^{*}\right)(u)\right\rangle
$$

Let $(s, t) \in \Delta_{T}$ be arbitrarily chosen.
On the one hand,

m(s, t) \leqslant 2 e \cdot c(p, p)\left\|R_{H}-R_{H^{*}}\right\|_{p / 2-\mathrm{var}, s, t}\left\|Y-Y^{*}\right\|_{p / 2-\mathrm{var}, s, t}
$$

So, there exists a constant $c_{2}>0$, not depending on $s$ and $t$, such that

$$
\begin{aligned}
\left\|R_{X}(s, t)-R_{X^{*}}(s, t)\right\|^{p / 2} \leqslant & \left(\left\|R_{H}-R_{H^{*}}\right\|_{p / 2-\mathrm{var}, s, t}^{2}+2 m(s, t)\right)^{p / 4} \\
\leqslant & c_{2}\left(\left\|R_{H}-R_{H^{*}}\right\|_{p / 2-\mathrm{var}, s, t}^{p / 2}\right. \\
& \left.+\left(\left\|R_{H}-R_{H^{*}}\right\|_{p / 2-\mathrm{var}, s, t}^{p / 2}\right)^{1 / 2}\left(\left\|Y-Y^{*}\right\|_{p / 2-\mathrm{var}, s, t}^{p / 2}\right)^{1 / 2}\right)
\end{aligned}
$$

Since $1 / 2+1 / 2=1$, the right-hand side of the previous inequality defines a control function (see Friz and Victoir [11], Exercice 1.9), and then there exists a constant
$c_{3}>0$, not depending on $s$ and $t$, such that

$$
\begin{align*}
\left\|R_{X}-R_{X^{*}}\right\|_{p / 2-\mathrm{var}, s, t}^{p / 2} \leqslant & c_{2}\left(\left\|R_{H}-R_{H^{*}}\right\|_{p / 2-\mathrm{var}, s, t}^{p / 2}\right. \\
& \left.+\left\|R_{H}-R_{H^{*}}\right\|_{p / 2-\mathrm{var}, s, t}^{p / 4}\left\|Y-Y^{*}\right\|_{p / 2-\mathrm{var}, s, t}^{p / 4}\right) \\
\leqslant & c_{3}\left(\left\|R_{H}-R_{H^{*}}\right\|_{p / 2-\mathrm{var}, s, t}^{p / 2}\right. \\
& \left.+\left\|R_{H}-R_{H^{*}}\right\|_{p / 2-\mathrm{var}, s, t}^{p / 4}\left\|R_{X}-R_{X^{*}}\right\|_{p / 2-\mathrm{var}, s, t}^{p / 4}\right) . \tag{21}
\end{align*}
$$

On the other hand, since $X(0)=X^{*}(0)$ :

$$
\begin{aligned}
\left\|f(X)^{\prime}(s)-f\left(X^{*}\right)^{\prime}(s)\right\|= & \| D f(X(s)) f(X(s))-D f(X(0)) f(X(0)) \\
& -\left(D f\left(X^{*}(s)\right) f\left(X^{*}(s)\right)-D f\left(X^{*}(0)\right) f\left(X^{*}(0)\right)\right) \| \\
\leqslant & \left\|f(X)^{\prime}-f\left(X^{*}\right)^{\prime}\right\|_{p \text {-var }, t} .
\end{aligned}
$$

Then,

$$
\begin{aligned}
\left\|R_{H}(s, t)-R_{H^{*}}(s, t)\right\| \leqslant & \Im_{\mathbf{Z}, f(X)-f\left(X^{*}\right)}(s, t)+\left\|\left(f(X)^{\prime}(s)-f\left(X^{*}\right)^{\prime}(s)\right) \mathbb{Z}(s, t)\right\| \\
\leqslant & c(p)\left(\left\|R_{f(X)}-R_{f\left(X^{*}\right)}\right\|_{p / 2 \text {-var }, s, t}\|Z\|_{p-\mathrm{var}, s, t}\right. \\
& \left.+\left\|f(X)^{\prime}-f\left(X^{*}\right)^{\prime}\right\|_{p \text {-var,s,t}}\|\mathbb{Z}\|_{p / 2 \text {-var }, s, t}\right) \\
& +\left\|f(X)^{\prime}-f\left(X^{*}\right)^{\prime}\right\|_{p \text {-var }, t}\|\mathbb{Z}\|_{p / 2 \text {-var }, s, t}
\end{aligned}
$$

So, with the same ideas as in P. Friz and M. Hairer [9, Theorem 8.4 p. 115], there exists a constant $c_{4}>0$, not depending on $s$ and $t$, such that

$$
\begin{equation*}
\left\|R_{H}-R_{H^{*}}\right\|_{p / 2-\mathrm{var}, s, t} \leqslant c_{4}\left\|\left(X-X^{*},\left(X-X^{*}\right)^{\prime}\right)\right\|_{Z, p / 2, t} \omega_{p, \mathbf{Z}}(s, t)^{1 / p} \tag{22}
\end{equation*}
$$

By Equations (20), (21) and (22) together, there exists a constant $c_{5}>0$, not depending on $s$ and $t$, such that

$$
\left\|\left(X-X^{*},\left(X-X^{*}\right)^{\prime}\right)\right\|_{Z, p / 2, s, t} \leqslant c_{5}\left\|\left(X-X^{*},\left(X-X^{*}\right)^{\prime}\right)\right\|_{Z, p / 2, t} \omega_{p, \mathbf{Z}}(s, t)^{1 /(2 p)}
$$

The conclusion of the proof is the same as in Proposition 4.2.
5. SWEEPING PROCESSES PERTURBED BY A STOCHASTIC NOISE DIRECTED BY A FBM

First of all, let us recall the definition of fractional Brownian motion.
Definition 5.1. Let $(B(t))_{t \in[0, T]}$ be a d-dimensional centered Gaussian process. It is a fractional Brownian motion of Hurst parameter $H \in] 0,1[$ if and only if,

$$
\operatorname{cov}\left(B_{i}(s), B_{j}(s)\right)=\frac{1}{2}\left(|t|^{2 H}+|s|^{2 H}-|t-s|^{2 H}\right) \delta_{i, j}
$$

for every $(i, j) \in \llbracket 1, d \rrbracket^{2}$ and $(s, t) \in[0, T]^{2}$.
Fore more details on fractional Brownian motion, we refer the reader to Nualart [21, Chapter 5].

Let $B:=(B(t))_{t \in[0, T]}$ be a $d$-dimensional fractional Brownian motion of Hurst parameter $H \in] 1 / 3,1[$, defined on a probability space $(\Omega, \mathcal{A}, \mathbb{P})$.

By Garcia-Rodemich-Rumsey's lemma (see Nualart [21, Lemma A.3.1]), almost all paths of $B$ are $\alpha$-Hölder continuous with $\alpha \in] 0, H[$. So, in particular, for almost every $\omega \in \Omega, B(\omega)$ is a continuous function of finite $p$-variation with $p \in] 1 / H, \infty[$. By Friz and Victoir [11, Proposition 15.5 and Theorem 15.33], there exists an enhanced Gaussian process $\mathbf{B}:(\Omega, \mathcal{A}) \rightarrow G \Omega_{p, T}\left(\mathbb{R}^{d}\right)$ such that $\mathbf{B}^{(1)}=B$.

Consider $b \in C^{[p]+1}\left(\mathbb{R}^{e}\right), \sigma \in C^{[p]+1}\left(\mathbb{R}^{e}, \mathcal{M}_{e, d}(\mathbb{R})\right)$ and the following sweeping process, perturbed by a pathwise stochastic noise directed by $\mathbf{B}$ :

$$
\left\{\begin{align*}
X(t) & =H(t)+Y(t)  \tag{23}\\
H(t) & =\int_{0}^{t} b(X(s)) d s+\int_{0}^{t} \sigma(X(s)) d \mathbf{B}(s) \\
-\frac{d D Y}{d|D Y|}(t) & \in N_{C_{H}(t)}(Y(t))|D Y| \text {-a.e. with } Y(0)=a
\end{align*}\right.
$$

Let $W:=(W(t))_{t \in[0, T]}$ be the stochastic process defined by:

$$
W(t):=t e_{1}+\sum_{k=1}^{d} B_{k}(t) e_{k+1} ; \forall t \in[0, T] .
$$

By Friz and Victoir [11, Theorem 9.26], there exists an enhanced stochastic process $\mathbf{W}:(\Omega, \mathcal{A}) \rightarrow G \Omega_{p, T}\left(\mathbb{R}^{d+1}\right)$ such that $\mathbf{W}^{(1)}:=W$. Consider also the map $f:$ $\mathbb{R}^{e} \rightarrow \mathcal{M}_{e, d+1}(\mathbb{R})$ defined by:

$$
f(x)(u, v):=b(x) u+\sigma(x) v ; \forall x \in \mathbb{R}^{e}, \forall(u, v) \in \mathbb{R}^{d+1}
$$

So, Problem (23) can be reformulated as follow:

$$
\left\{\begin{array}{rl}
X(\omega, t) & =H(\omega, t)+Y(\omega, t) \\
H(\omega, t) & =\int_{0}^{t} f(X(\omega, s)) d \mathbf{W}(\omega, s) \\
-\frac{d D Y}{d|D Y|}(\omega, t) & \in N_{C_{H}(\omega, t)}(Y(\omega, t))|D Y(\omega)| \text {-a.e. with } Y(0)=a
\end{array} ; \omega \in \Omega\right.
$$

Therefore, the previous results of this paper apply to Problem (23):
Theorem 5.2. (Existence) Assume that, for every $t \in[0, T], C(t)$ is a random set with convex compact values with nonempty interior, and that the paths of $C$ are continuous for the Hausdorff distance. Then Problem (23) has at least one solution, whose paths belong to $C^{p-\operatorname{var}}\left([0, T], \mathbb{R}^{e}\right)$, for $\left.p \in\right] 1 / H, \infty[$.
Proof. This is a direct pathwise application of Theorems 3.1 and 3.2.
Proposition 5.3. (Existence and uniqueness for an additive fractional noise) Assume that, for every $t \in[0, T], C(t)$ is a random set with convex compact values with nonempty interior, and that the paths of $C$ are continuous for the Hausdorff distance. If $\sigma$ is a constant map, then Problem (23) has a unique solution, whose paths belong to $C^{p-\mathrm{var}}\left([0, T], \mathbb{R}^{e}\right)$, for $\left.p \in\right] 1 / H, \infty[$.

Proof. This is a direct pathwise application of Theorem 3.1, Theorem 3.2 and Proposition 4.1.
Remark. For instance, Proposition 5.3 ensures the existence and uniqueness of the solution to a multidimensional reflected fractional Ornstein-Uhlenbeck process.
