# Time Blocks Decomposition of Multistage Stochastic Optimization Problems

#### Abstract

Multistage stochastic optimization problems are, by essence, complex because their solutions are indexed both by stages (time) and by uncertainties. Their large scale nature makes decomposition methods appealing. We provide a method to decompose multistage stochastic optimization problems by time blocks. Our framework covers both stochastic programming and stochastic dynamic programming. We formulate multistage stochastic optimization problems over a so-called history space, with solutions being history feedbacks. We prove a general dynamic programming equation, with value functions defined on the history space. Then, we consider the question of reducing the history using a compressed "state" variable. This reduction can be done by time blocks, that is, at stages that are not necessarily all the original unit stages. We prove a reduced dynamic programming equation. Then, we apply the reduction method by time blocks to several classes of optimization problems, especially two time-scales stochastic optimization problems and a novel class consisting of decision hazard decision models. Finally, we consider the case of optimization with noise process.

## 1 Introduction

Multistage stochastic optimization problems are, by essence, complex because their solutions are indexed both by stages (time) and by uncertainties. Their large scale nature makes decomposition methods appealing.

On the one hand, stochastic programming deals with an underlying random process taking a finite number of values, called scenarios [9]. Solutions are indexed by a scenario tree, the size of which explodes with the number of stages, hence generally few. However, to overcome this obstacle, stochastic programming takes advantage of scenario decomposition methods (Progressive Hedging [8]). On the other hand, stochastic control deals with a state model driven by a white noise, that is, the noise is made of a sequence of independent random variables. Under such assumptions, stochastic dynamic programming is able to handle many stages, as it offers reduction of the search for a solution among state feedbacks (instead of functions of the past noise) [1,6.

In a word, dynamic programming is good at handling multiple stages - but at the price of assuming that noise are stagewise independent - whereas stochastic programming does not require such assumption, but can only handle a few stages. Could we take advantage of both methods? Is there a way to apply stochastic dynamic programming at a slow time scale - a scale at which noise would be statistically independent - crossing over short time scale optimization problems where independence would not hold? This question is one of the motivations of this paper.

We will provide a method to decompose multistage stochastic optimization problems by time blocks. In Sect. 2, we present a mathematical framework that covers both stochastic programming and stochastic dynamic programming. We formulate multistage stochastic optimization problems over a so-called history space, with solutions being history feedbacks. We prove a general dynamic programming equation, with value functions defined on the history space. In Sect. 3, we consider the question of reducing the history using a compressed "state" variable. This reduction can be done by time blocks, that is, at stages that are not necessarily all the original unit stages. We prove a reduced dynamic programming equation. In Sect. 4. we apply the reduction method by time blocks to several classes of optimization problems, especially two time-scales stochastic optimization problems and a novel class consisting of decision hazard decision models. Finally, we consider the case of optimization with noise process; we show in Sect. 5that it is a special case of the setting in Sect. 2,

## 2 Stochastic Dynamic Programming with History Feedbacks

Consider the time span $\{0,1,2 \ldots, T-1, T\}$, with horizon $T \in \mathbb{N}^{*}$. At the end of the time interval $[t-1, t[$, an uncertainty variable $w_{t}$ is produced. Then, at the beginning of the time interval $[t, t+1[$, a decisionmaker takes a decision $u_{t}$, as follows

We present the mathematical formalism to handle such type of problems.

### 2.1 Histories, Feedbacks and Flows

We first define in $\$ 2.1 .1$ the basic and the composite spaces that we will need to formulate multistage stochastic optimization problems. Then, in $\sqrt{2.1 .2}$, we introduce a class of solutions called history feedbacks; we also define flows.

### 2.1.1 Histories and History Spaces

For each time $t=0,1,2 \ldots, T-1$, the decision $u_{t}$ takes its values in a measurable set $\mathbb{U}_{t}$ equipped with a $\sigma$-field $\mathcal{U}_{t}$. For each time $t=0,1,2 \ldots, T$, the uncertainty $w_{t}$ takes its values in a measurable set $\mathbb{W}_{t}$ equipped with a $\sigma$-field $\mathcal{W}_{t}$.

For $t=0,1,2 \ldots, T$, we define the history space $\mathbb{H}_{t}$ equipped with the history field $\mathcal{H}_{t}$ by

with the particular case $\mathbb{H}_{0}=\mathbb{W}_{0}, \mathcal{H}_{0}=\mathcal{W}_{0}$. A generic element $h_{t} \in \mathbb{H}_{t}$ is called a history:

We introduce the notations

& \mathbb{H}_{r: t}=\prod_{s=r-1}^{t-1}\left(\mathbb{U}_{s} \times \mathbb{W}_{s+1}\right)=\mathbb{U}_{r-1} \times \mathbb{W}_{r} \times \cdots \times \mathbb{U}_{t-1} \times \mathbb{W}_{t}, \quad 1 \leqslant r \leqslant t \leqslant T . \tag{2d}

Let $0 \leqslant r \leqslant s \leqslant t \leqslant T$. From a history $h_{t} \in \mathbb{H}_{t}$, we can extract the ( $r: s$ )-history uncertainty part

so that we obtain, for $0 \leqslant r+1 \leqslant s \leqslant t$,

### 2.1.2 Feedbacks and Flows

Let $r$ and $t$ be given such that $0 \leqslant r \leqslant t \leqslant T$.
History Feedbacks. When $0 \leqslant r \leqslant t \leqslant T-1$, we define a $(r: t)$-history feedback as a sequence $\left\{\gamma_{s}\right\}_{s=r, \ldots, t}$ of measurable mappings

We call $\Gamma_{r: t}$ the set of $(r: t)$-history feedbacks.
Flows. When $0 \leqslant r<t \leqslant T$, for a $(r: t-1)$-history feedback $\gamma=\left\{\gamma_{s}\right\}_{s=r, \ldots, t-1} \in \Gamma_{r: t-1}$, we define the flow $\Phi_{r: t}^{\gamma}$ by

When $0 \leqslant r=t \leqslant T$, we put

With this convention, the expression $\Phi_{r: t}^{\gamma}$ makes sense when $0 \leqslant r \leqslant t \leqslant T$ for a ( $r: t-1$ )-history feedback $\gamma=\left\{\gamma_{s}\right\}_{s=r, \ldots, t-1} \in \Gamma_{r: t-1}$ (when $r=t$, no ( $r: r-1$ )-history feedback exists, but none is needed).

The mapping $\Phi_{r: t}^{\gamma}$ gives the history at time $t$ as a function of the initial history $h_{r}$ at time $r$ and of the history feedbacks $\left\{\gamma_{s}\right\}_{s=r, \ldots, t-1} \in \Gamma_{r: t-1}$. An immediate consequence of this definition are the flow properties:

### 2.2 Optimization with Stochastic Kernels

In 2.2.1 given a history feedback and a sequence of stochastic kernels from partial histories to uncertainties, we will build a new sequence of stochastic kernels, but from partial histories to sequences of uncertainties. With this construction, we introduce a family of optimization problems with stochastic kernels in 22.2 .2 , Then, in 2.2 .3 we show how such problems can be solved by stochastic dynamic programming.

In what follows, we say that a function is numerical if it takes its values in $[-\infty,+\infty]$ (also called extended or extended real-valued function) (5].

### 2.2.1 Stochastic Kernels

Definition of stochastic kernels. Let $(\mathbb{X}, \mathcal{X})$ and $(\mathbb{Y}, \mathcal{y})$ be two measurable spaces. A stochastic kernel from $(\mathbb{X}, \mathcal{X})$ to $(\mathbb{Y}, \mathcal{Y})$ is a mapping $\rho: \mathbb{X} \times \mathcal{Y} \rightarrow[0,1]$ such that

- for any $Y \in \mathcal{Y}, \rho(\cdot, Y)$ is $X_{\text {-measurable; }}$
- for any $x \in \mathbb{X}, \rho(x, \cdot)$ is a probability measure on $y$.

By a slight abuse of notation, a stochastic kernel (on $\mathbb{Y}$ knowing $\mathbb{X}$ ) is also denoted as a mapping $\rho$ : $\mathbb{X} \rightarrow \Delta(\mathbb{Y})$ from the measurable space $(\mathbb{X}, \mathcal{X})$ towards the space $\Delta(\mathbb{Y})$ of probability measures over $\mathcal{Y}$, with the property that the function $x \in \mathbb{X} \mapsto \int_{Y} \rho(x, \mathrm{~d} y)$ is measurable for any $Y \in \mathcal{y}$.

Building new stochastic kernels from history feedbacks and stochastic kernels.
Definition 1 Let $r$ and $t$ be given such that $0 \leqslant r \leqslant t \leqslant T$.

- When $0 \leqslant r<t \leqslant T$, for

1. a $(r: t-1)$-history feedback $\gamma=\left\{\gamma_{s}\right\}_{s=r, \ldots, t-1} \in \Gamma_{r: t-1}$,
2. a family $\left\{\rho_{s-1: s}\right\}_{r+1 \leqslant s \leqslant t}$ of stochastic kernels

\rho_{s-1: s}: \mathbb{H}_{s-1} \rightarrow \Delta\left(\mathbb{W}_{s}\right), \quad s=r+1, \ldots, t \tag{6}

we define a stochastic kernel

by, for any $\varphi: \mathbb{H}_{t} \rightarrow[0,+\infty]$, measurable nonnegative numerical function, 1

& \qquad \int_{\mathbb{W}_{r+1: t}} \varphi\left(\Phi_{r: t}^{\gamma}\left(h_{r}, w_{r+1: t}\right)\right) \prod_{s=r+1}^{t} \rho_{s-1: s}\left(\Phi_{r: s-1}^{\gamma}\left(h_{r}, w_{r+1: s-1}\right), \mathrm{d} w_{s}\right) . \tag{7b}

- When $0 \leqslant r=t \leqslant T$, we define

[^1]We detail Equation (7b) in Appendix A The stochastic kernels $\rho_{r: t}^{\gamma}$ on $\mathbb{H}_{t}$, given by (7), are of the form

where, for each $h_{r} \in \mathbb{H}_{r}$, the probability distribution $\varrho_{r: t}^{\gamma}\left(h_{r}, \mathrm{~d} h_{r+1: t}^{\prime}\right)$ only charges the histories visited by the flow from $r+1$ to $t$.

Proposition 1 Following Definition 1, we can define a family $\left\{\rho_{s: t}^{\gamma}\right\}_{r \leqslant s \leqslant t}$ of stochastic kernels. This family has the flow property, that is, for $s<t$,

by Fubini Theorem [5, p.137]

by definition (7b) of $\rho_{s+1: t}^{\gamma}$

=\int_{\mathbb{H}_{t}} \varphi\left(\left(h_{s}^{\prime}, \gamma_{s}\left(h_{s}^{\prime}\right), w_{s+1}^{\prime}\right), h_{s+2: t}^{\prime}\right) \int_{\mathbb{W}_{s+1}} \rho_{s: s+1}\left(h_{s}, \mathrm{~d} w_{s+1}\right) \rho_{s+1: t}^{\gamma}\left(\left(h_{s}, \gamma_{s}\left(h_{s}\right), w_{s+1}\right), \mathrm{d} h_{t}^{\prime}\right) \tag{10b}
\end{equation*}

by Fubini Theorem and by definition (7b) of $\rho_{s: t}^{\gamma}$. As the two expressions (10a) and (10b) are equal for any $\varphi: \mathbb{H}_{t} \rightarrow[0,+\infty]$, we deduce the flow property (9). This ends the proof.

### 2.2.2 Family of Optimization Problems with Stochastic Kernels

To build a family of optimization problems over the time span $\{0, \ldots, T-1\}$, we need two ingredients:

- a family $\left\{\rho_{s-1: s}\right\}_{1 \leqslant s \leqslant T}$ of stochastic kernels

\end{equation*}
$$

- a numerical function, playing the role of a cost to be minimized,

$$
\begin{equation*}
j: \mathbb{H}_{T} \rightarrow[0,+\infty] \tag{12}
\end{equation*}
$$

assumed to be nonnegative ${ }^{2}$ and measurable with respect to the field $\mathcal{H}_{T}$.
We define, for any $\left\{\gamma_{s}\right\}_{s=t, \ldots, T-1} \in \Gamma_{t: T-1}$,

\begin{equation*}
V_{t}^{\gamma}\left(h_{t}\right)=\int_{\mathbb{H}_{T}} j\left(h_{T}^{\prime}\right) \rho_{t: T}^{\gamma}\left(h_{t}, \mathrm{~d} h_{T}^{\prime}\right), \quad \forall h_{t} \in \mathbb{H}_{t} \tag{13}
\end{equation*}
$$

We consider the family of optimization problems, indexed by $t=0, \ldots, T-1$ and parameterized by $h_{t} \in \mathbb{H}_{t}$ :

\inf _{\gamma_{t: T-1} \in \Gamma_{t: T-1}} \int_{\mathbb{H}_{T}} j\left(h_{T}^{\prime}\right) \rho_{t: T}^{\gamma}\left(h_{t}, \mathrm{~d} h_{T}^{\prime}\right) . \tag{14}
\end{equation*}
$$

For all $t=0, \ldots, T-1$, we define the minimum value of Problem (14) by

V_{t}\left(h_{t}\right) & =\inf _{\gamma_{t: T-1} \in \Gamma_{t: T-1}} \int_{\mathbb{H}_{T}} j\left(h_{T}^{\prime}\right) \rho_{t: T}^{\gamma}\left(h_{t}, \mathrm{~d} h_{T}^{\prime}\right)  \tag{15a}\\
& =\inf _{\gamma_{t: T-1} \in \Gamma_{t: T-1}} V_{t}^{\gamma}\left(h_{t}\right), \quad \forall h_{t} \in \mathbb{H}_{t} \tag{15b}
\end{align*}
$$

and we also define

$$
\begin{equation*}
V_{T}\left(h_{T}\right)=j\left(h_{T}\right), \quad \forall h_{T} \in \mathbb{H}_{T} \tag{15c}
\end{equation*}
$$

The last notation is consistent with (14) by the definition (7c) of the stochastic kernel $\rho_{T: T}^{\gamma}$. The numerical function $V_{t}: \mathbb{H}_{t} \rightarrow[0,+\infty]$ is called value function.

### 2.2.3 Resolution by Stochastic Dynamic Programming

Now, we show that the value functions in (15) are Bellman functions, in that they are solution of the Bellman or Dynamic Programming equation.

The following two assumptions will be made throughout the whole paper.
Assumption 1 (Measurable function) For all $t=0, \ldots, T-1$ and for all nonnegative measurable numerical function $\varphi: \mathbb{H}_{t+1} \rightarrow[0,+\infty]$, the numerical function

is measurabl $\bigotimes^{3}$ from $\left(\mathbb{H}_{t}, \mathcal{H}_{t}\right)$ to $[0,+\infty]$.
Assumption 2 (Measurable selection) For all $t=0, \ldots, T-1$, there exists a measurable selection 4 that is, a measurable mapping

\gamma_{t}^{\star}\left(h_{t}\right) \in \underset{u_{t} \in \mathbb{U}_{t}}{\arg \min } \int_{\mathbb{W}_{t+1}} V_{t+1}\left(h_{t}, u_{t}, w_{t+1}\right) \rho_{t: t+1}\left(h_{t}, \mathrm{~d} w_{t+1}\right), \tag{17b}
\end{equation*}
$$

where the numerical function $V_{t+1}$ is given by (15).

[^2]Bellman Operators. For $t=0, \ldots, T$, let $\mathbb{L}_{+}^{0}\left(\mathbb{H}_{t}, \mathcal{H}_{t}\right)$ be the space of nonnegative measurable numerical functions over $\mathbb{H}_{t}$.
Definition 2 For $t=0, \ldots, T-1$, we define the Bellman operator

$$
\begin{equation*}
\mathcal{B}_{t+1: t}: \mathbb{L}_{+}^{0}\left(\mathbb{H}_{t+1}, \mathcal{H}_{t+1}\right) \rightarrow \mathbb{L}_{+}^{0}\left(\mathbb{H}_{t}, \mathcal{H}_{t}\right) \tag{18a}
\end{equation*}
$$

such that, for all $\varphi \in \mathbb{L}_{+}^{0}\left(\mathbb{H}_{t+1}, \mathcal{H}_{t+1}\right)$ and for all $h_{t} \in \mathbb{H}_{t}$,

$$
\begin{equation*}
\left(\mathcal{B}_{t+1: t} \varphi\right)\left(h_{t}\right)=\inf _{u_{t} \in \mathbb{U}_{t}} \int_{\mathbb{W}_{t+1}} \varphi\left(h_{t}, u_{t}, w_{t+1}\right) \rho_{t: t+1}\left(h_{t}, d w_{t+1}\right) . \tag{18b}
\end{equation*}
$$

Since $\varphi \in \mathbb{L}_{+}^{0}\left(\mathbb{H}_{t+1}, \mathcal{H}_{t+1}\right)$, we have that $\mathcal{B}_{t+1: t} \varphi$ is a well defined nonnegative numerical function and, by Assumption we know that $\mathcal{B}_{t+1: t} \varphi$ is a measurable numerical function, hence belongs to $\mathbb{L}_{+}^{0}\left(\mathbb{H}_{t}, \mathcal{H}_{t}\right)$.

Bellman equation and optimal history feedbacks.
Theorem 1 The value functions in (15) satisfy the Bellman equation, or (Stochastic) Dynamic Programming equation

$$
\begin{align*}
V_{T} & =j  \tag{19a}\\
V_{t} & =\mathcal{B}_{t+1: t} V_{t+1} \text { for } t=T-1, \ldots, 0 . \tag{19b}
\end{align*}
$$

Moreover, a solution to any Problem (14) - that is, whatever the index $t=0, \ldots, T-1$ and the parameter $h_{t} \in \mathbb{H}_{t}-$ is any history feedback $\gamma^{\star}=\left\{\gamma_{s}^{\star}\right\}_{s=t, \ldots, T-1}$ defined by the collection of mappings $\gamma_{s}^{\star}$ in (17).

Notice that, although Problem (14) is parameterized by $h_{t} \in \mathbb{H}_{t}$, the optimal history feedback $\gamma^{\star}=$ $\left\{\gamma_{s}^{\star}\right\}_{s=t, \ldots, T-1}$ is not.

Proof From the definition (13), we have for any $\left\{\gamma_{s}\right\}_{s=t, \ldots, T-1} \in \Gamma_{t: T-1}$,

that only depends on $\left\{\gamma_{s}\right\}_{s=t, \ldots, T-1}$

$$
=\int_{\mathbb{H}_{T}} j\left(h_{T}^{\prime}\right) \int_{\mathbb{W}_{t+1}} \rho_{t: t+1}\left(h_{t}, \mathrm{~d} w_{t+1}\right) \rho_{t+1: T}^{\gamma}\left(\left(h_{t}, \gamma_{t}\left(h_{t}\right), w_{t+1}\right), \mathrm{d} h_{T}^{\prime}\right)
$$

by the flow property (9) for stochastic kernels

$$
=\int_{\mathbb{W}_{t+1}} \rho_{t: t+1}\left(h_{t}, \mathrm{~d} w_{t+1}\right) \int_{\mathbb{H}_{T}} j\left(h_{T}^{\prime}\right) \rho_{t+1: T}^{\gamma}\left(\left(h_{t}, \gamma_{t}\left(h_{t}\right), w_{t+1}\right), \mathrm{d} h_{T}^{\prime}\right)
$$

by Fubini Theorem [5, p.137]

$$
=\int_{\mathbb{W}_{t+1}} \rho_{t: t+1}\left(h_{t}, \mathrm{~d} w_{t+1}\right) V_{t+1}^{\gamma}\left(h_{t}, \gamma_{t}\left(h_{t}\right), w_{t+1}\right)
$$

by definition (13) of $V_{t+1}^{\gamma}$

$$
\geqslant \int_{\mathbb{W}_{t+1}} \rho_{t: t+1}\left(h_{t}, \mathrm{~d} w_{t+1}\right) V_{t+1}\left(h_{t}, \gamma_{t}\left(h_{t}\right), w_{t+1}\right)
$$

by definition (15) of the value function $V_{t+1}$, and as $V_{t+1}^{\gamma}$ only depends on $\left\{\gamma_{s}\right\}_{s=t+1, \ldots, T-1}$. We deduce that

V_{t}\left(h_{t}\right) \geqslant \inf _{u_{t}} \int_{\mathbb{W}_{t+1}} \rho_{t: t+1}\left(h_{t}, \mathrm{~d} w_{t+1}\right) V_{t+1}\left(h_{t}, u_{t}, w_{t+1}\right) . \tag{20a}
\end{equation*}
$$

The inequality (20a) above is in fact an equality, as seen by using any measurable history feedback $\gamma^{\star}=\left\{\gamma_{s}^{\star}\right\}_{s=t, \ldots, T-1}$ defined by the collection of functions $\gamma_{s}^{\star}$ in (17).

This ends the proof.

## 3 State Reduction by Time Blocks

In this section, we consider the question of reducing the history using a compressed "state" variable. Such a variable may be not available at any time $t \in\{0, \ldots, T\}$, but at some specified instants. We have to note that the history $h_{t}$ is itself a canonical state variable in our framework, the associated dynamics being $h_{t+1}=\left(h_{t}, u_{t}, w_{t+1}\right)$.
3.1 State Reduction on a Single Time Block

We first present the case where the reduction only occurs at two instants denoted by $r$ and $t$ :

0 \leqslant r<t \leqslant T
$$

Let $\left\{\rho_{s-1: s}\right\}_{r+1 \leqslant s \leqslant t}$ be a family of stochastic kernels

$$
\begin{equation*}
\rho_{s-1: s}: \mathbb{H}_{s-1} \rightarrow \Delta\left(\mathbb{W}_{s}\right), \quad s=r+1, \ldots, t \tag{21}
\end{equation*}
$$

We define the Bellman operator across $(t: r)$ by

\begin{equation*}
\mathcal{B}_{t: r}: \mathbb{L}_{+}^{0}\left(\mathbb{H}_{t}, \mathcal{H}_{t}\right) \rightarrow \mathbb{L}_{+}^{0}\left(\mathbb{H}_{r}, \mathcal{H}_{r}\right), \quad \mathcal{B}_{t: r}=\mathcal{B}_{t: t-1} \circ \cdots \circ \mathcal{B}_{r+1: r} \tag{22}
\end{equation*}
$$

where the one time step operators $\mathcal{B}_{s: s-1}$, for $r+1 \leqslant s \leqslant t$ have been defined in (18).
Definition 3 Let $\mathbb{X}_{r}$ and $\mathbb{X}_{t}$ be two state spaces, $\theta_{r}$ and $\theta_{t}$ be two measurable reduction mappings

$$
\begin{equation*}
\theta_{r}: \mathbb{H}_{r} \rightarrow \mathbb{X}_{r}, \quad \theta_{t}: \mathbb{H}_{t} \rightarrow \mathbb{X}_{t} \tag{23}
\end{equation*}
$$

and $f_{r: t}$ be a measurable dynamics

$$
\begin{equation*}
f_{r: t}: \mathbb{X}_{r} \times \mathbb{H}_{r+1: t} \rightarrow \mathbb{X}_{t} \tag{24}
\end{equation*}
$$

The triplet $\left(\theta_{r}, \theta_{t}, f_{r: t}\right)$ is called a state reduction across $(r: t)$ if we have

$$
\begin{equation*}
\theta_{t}\left(\left(h_{r}, h_{r+1: t}\right)\right)=f_{r: t}\left(\theta_{r}\left(h_{r}\right), h_{r+1: t}\right), \quad \forall h_{t} \in \mathbb{H}_{t} . \tag{25}
\end{equation*}
$$

The state reduction $\left(\theta_{r}, \theta_{t}, f_{r: t}\right)$ is said to be compatible with the family $\left\{\rho_{s-1: s}\right\}_{r+1 \leqslant s \leqslant t}$ of stochastic kernels defined in (21) if

- there exists a reduced stochastic kernel

$$
\begin{equation*}
\tilde{\rho}_{r: r+1}: \mathbb{X}_{r} \rightarrow \Delta\left(\mathbb{W}_{r+1}\right), \tag{26a}
\end{equation*}
$$

such that the stochastic kernel $\rho_{r: r+1}$ can be factored as

$$
\begin{equation*}
\rho_{r: r+1}\left(h_{r}, \mathrm{~d} w_{r+1}\right)=\widetilde{\rho}_{r: r+1}\left(\theta_{r}\left(h_{r}\right), \mathrm{d} w_{r+1}\right), \quad \forall h_{r} \in \mathbb{H}_{r}, \tag{26b}
\end{equation*}
$$

- for all $s=r+2, \ldots, t$, there exists a reduced stochastic kernel

$$
\begin{equation*}
\tilde{\rho}_{s-1: s}: \mathbb{X}_{r} \times \mathbb{H}_{r+1: s-1} \rightarrow \Delta\left(\mathbb{W}_{s}\right) \tag{26c}
\end{equation*}
$$

such that the stochastic kernel $\rho_{s-1: s}$ can be factored as

$$
\begin{equation*}
\rho_{s-1: s}\left(\left(h_{r}, h_{r+1: s-1}\right), \mathrm{d} w_{s}\right)=\tilde{\rho}_{s-1: s}\left(\left(\theta_{r}\left(h_{r}\right), h_{r+1: s-1}\right), \mathrm{d} w_{s}\right), \forall h_{s-1} \in \mathbb{H}_{s-1} . \tag{26~d}
\end{equation*}
$$

According to this definition, the triplet $\left(\theta_{r}, \theta_{t}, f_{r: t}\right)$ is a state reduction across $(r: t)$ if and only of the diagram in Figure 1 is commutative. In addition, it is compatible if and only of the diagram in Figure 2 is commutative.

The following theorem is the key ingredient to formulate Dynamic Programming equations with a reduced state.

Theorem 2 Suppose that there exists a state reduction $\left(\theta_{r}, \theta_{t}, f_{r: t}\right)$ that is compatible with the family $\left\{\rho_{s-1: s}\right\}_{r+1 \leqslant s \leqslant t}$ of stochastic kernels (21) (see Definition (3). Then, there exists a reduced Bellman operator across ( $t: r$ )

$$
\begin{equation*}
\widetilde{\mathcal{B}}_{t: r}: \mathbb{L}_{+}^{0}\left(\mathbb{X}_{t}, \mathcal{X}_{t}\right) \rightarrow \mathbb{L}_{+}^{0}\left(\mathbb{X}_{r}, X_{r}\right) \tag{27}
\end{equation*}
$$

such that, for any measurable nonnegative numerical function $\widetilde{\varphi}_{t}: \mathbb{X}_{t} \rightarrow[0,+\infty]$, we have that

$$
\begin{equation*}
\left(\widetilde{\mathcal{B}}_{t: r} \widetilde{\varphi}_{t}\right) \circ \theta_{r}=\mathcal{B}_{t: r}\left(\widetilde{\varphi}_{t} \circ \theta_{t}\right) \tag{28}
\end{equation*}
$$

Denoting by $\theta_{t}^{*}: \mathbb{L}_{+}^{0}\left(\mathbb{X}_{t}, \mathcal{X}_{t}\right) \rightarrow \mathbb{L}_{+}^{0}\left(\mathbb{H}_{t}, \mathcal{H}_{t}\right)$ the operator such that

\theta_{t}^{*}\left(\widetilde{\varphi}_{t}\right)=\widetilde{\varphi}_{t} \circ \theta_{t} \tag{29}
\end{equation*}
$$

the relation (28) rewrites:

\theta_{r}^{*}\left(\widetilde{\mathcal{B}}_{t: r} \widetilde{\varphi}_{t}\right)=\mathcal{B}_{t: r}\left(\theta_{t}^{*}\left(\widetilde{\varphi}_{t}\right)\right) \tag{30}
\end{equation*}

Equivalently, Theorem 2 states that the diagram in Figure 3 is commutative.

Proof Let $\widetilde{\varphi}_{t}: \mathbb{X}_{t} \rightarrow[0,+\infty]$ be a given measurable nonnegative numerical function, and let $\varphi_{t}: \mathbb{H}_{t} \rightarrow$ $[0,+\infty]$ be

Let $\varphi_{r}: \mathbb{H}_{r} \rightarrow[0,+\infty]$ be the measurable nonnegative numerical function obtained by applying the Bellman operator $\mathcal{B}_{t: r}$ across $(t: r)$ (see (22)) to the measurable nonnegative numerical function $\varphi_{t}$ :

We will show that there exists a measurable nonnegative numerical function

\tilde{\varphi}_{r}: \mathbb{X}_{r} \rightarrow[0,+\infty] \tag{33}
\end{equation*}

such that

\varphi_{r}=\widetilde{\varphi}_{r} \circ \theta_{r} . \tag{34}
\end{equation*}
$$

First, we show by backward induction that, for all $s \in\{r, \ldots, t\}$, there exists a measurable nonnegative numerical function $\bar{\varphi}_{s}$ such that $\varphi_{s}\left(h_{s}\right)=\bar{\varphi}_{s}\left(\theta_{r}\left(h_{r}\right), h_{r+1: s}\right)$. Second, we prove that the function $\widetilde{\varphi}_{r}=\bar{\varphi}_{r}$ satisfies (34).

- For $s=t$, we have, by (31) and by (25), that

\varphi_{t}\left(h_{t}\right)=\widetilde{\varphi}_{t}\left(\theta_{t}\left(h_{t}\right)\right)=\widetilde{\varphi}_{t}\left(f_{r: t}\left(\theta_{r}\left(h_{r}\right), h_{r+1: t}\right)\right),

so that the measurable nonnegative numerical function $\bar{\varphi}_{t}$ is given by $\widetilde{\varphi}_{t} \circ f_{r: t}$.

- Assume that, at $s+1$, the result holds true, that is,

\varphi_{s+1}\left(h_{s+1}\right)=\bar{\varphi}_{s+1}\left(\theta_{r}\left(h_{r}\right), h_{r+1: s+1}\right) . \tag{35}
\end{equation*}

Then,

\varphi_{s}\left(h_{s}\right) & =\left(\mathcal{B}_{s+1: s} \varphi_{s+1}\right)\left(h_{s}\right)  \tag{32}\\
& =\inf _{u_{s} \in \mathbb{U}_{s}} \int_{\mathbb{W}_{s+1}} \varphi_{s+1}\left(\left(h_{s}, u_{s}, w_{s+1}\right)\right) \rho_{s: s+1}\left(h_{s}, \mathrm{~d} w_{s+1}\right)
\end{align*}
$$

by definition (18) of the Bellman operator

$$
=\inf _{u_{s} \in \mathbb{U}_{s}} \int_{\mathbb{W}_{s+1}} \bar{\varphi}_{s+1}\left(\left(\theta_{r}\left(h_{r}\right),\left(h_{r+1: s}, u_{s}, w_{s+1}\right)\right)\right) \rho_{s: s+1}\left(h_{s}, \mathrm{~d} w_{s+1}\right)
$$

by induction assumption (35)

$$
=\inf _{u_{s} \in \mathbb{U}_{s}} \int_{\mathbb{W}_{s+1}} \bar{\varphi}_{s+1}\left(\left(\theta_{r}\left(h_{r}\right),\left(h_{r+1: s}, u_{s}, w_{s+1}\right)\right)\right) \tilde{\rho}_{s: s+1}\left(\left(\theta_{r}\left(h_{r}\right), h_{r+1: s}\right), \mathrm{d} w_{s+1}\right)
$$

by compatibility (26) of the stochastic kernel

$$
=\bar{\varphi}_{s}\left(\theta_{r}\left(h_{r}\right), h_{r+1: s}\right),
$$

where

$$
\bar{\varphi}_{s}\left(x_{r}, h_{r+1: s}\right)=\inf _{u_{s} \in \mathbb{U}_{s}} \int_{\mathbb{W}_{s+1}} \bar{\varphi}_{s+1}\left(\left(x_{r},\left(h_{r+1: s}, u_{s}, w_{s+1}\right)\right)\right) \tilde{\rho}_{s: s+1}\left(\left(x_{r}, h_{r+1: s}\right), \mathrm{d} w_{s+1}\right) .
$$

The result thus holds true at time $s$.
The induction implies that, at time $r$, the expression of $\varphi_{r}\left(h_{r}\right)$ is

$$
\varphi_{r}\left(h_{r}\right)=\bar{\varphi}_{r}\left(\theta_{r}\left(h_{r}\right)\right),
$$

since the term $h_{r+1: r}$ vanishes. Choosing $\widetilde{\varphi}_{r}=\bar{\varphi}_{r}$ gives the expected result.
Corollary 1 Under the assumptions of Theorem 园, the expression of the reduced Bellman operator $\widetilde{\mathcal{B}}_{t: r}$ in (27) is available: for all measurable nonnegative numerical function $\widetilde{\varphi}_{t}: \mathbb{X}_{t} \rightarrow[0,+\infty]$ and for all $x_{r} \in \mathbb{X}_{r}$, we have that

&\left(\widetilde{\mathcal{B}}_{t: r} \widetilde{\varphi}_{t}\right)\left(x_{r}\right)=\inf _{u_{r} \in \mathbb{U}_{r}} \int_{\mathbb{W}_{r+1}} \tilde{\rho}_{r: r+1}\left(x_{r}, \mathrm{~d} w_{r+1}\right) \inf _{u_{r+1} \in \mathbb{U}_{r+1}} \int_{\mathbb{W}_{r+2}} \tilde{\rho}_{r+1: r+2}\left(x_{r}, u_{r}, w_{r+1}, \mathrm{~d} w_{r+2}\right) \\
& \ldots \inf _{u_{t-1} \in \mathbb{U}_{t-1}} \int_{\mathbb{W}_{t}} \widetilde{\varphi}_{t}\left(f_{r: t}\left(x_{r}, u_{r}, w_{r+1}, \ldots, u_{t-1}, w_{t}, u_{t-1}, w_{t}\right)\right) \\
& \widetilde{\rho}_{t-1: t}\left(x_{r}, u_{r}, w_{r+1}, \ldots, u_{t-2}, w_{t-1}, \mathrm{~d} w_{t}\right) . \tag{37}
\end{align*}
$$

Proof Equation (37) follows from the induction developed in the proof of Theorem 2 ,
The optimal feedbacks yielded by (37) are mappings $\widetilde{\gamma}_{s}: \mathbb{X}_{r} \times \mathbb{H}_{r+1: s} \rightarrow \mathbb{U}_{s}$, for $s=r, \ldots, t-1$. These are no longer history feedbacks, by partially truncated history feedbacks where history $h_{r}$ has been replaced by state $x_{r}$.

### 3.2 State Reduction on Multiple Consecutive Time Blocks

Theorem 2 can easily be extended to the case of multiple consecutive time blocks $\left[t_{i}, t_{i+1}\right], i=0, \ldots, N-1$ where

Definition 4 Let $\left\{\mathbb{X}_{t_{i}}\right\}_{i=0, \ldots, N}$ be a family of state spaces, $\left\{\theta_{t_{i}}\right\}_{i=0, \ldots, N}$ be a family of measurable reduction mappings $\theta_{t_{i}}: \mathbb{H}_{t_{i}} \rightarrow \mathbb{X}_{t_{i}}$, and $\left\{f_{t_{i}: t_{i+1}}\right\}_{i=0, \ldots, N-1}$ be a family of dynamics $f_{t_{i}: t_{i+1}}: \mathbb{X}_{t_{i}} \times$ $\mathbb{H}_{t_{i}+1: t_{i+1}} \rightarrow \mathbb{X}_{t_{i+1}}$.

The triplet $\left(\left\{\mathbb{X}_{t_{i}}\right\}_{i=0, \ldots, N},\left\{\theta_{t_{i}}\right\}_{i=0, \ldots, N},\left\{f_{t_{i}: t_{i+1}}\right\}_{i=0, \ldots, N-1}\right)$ is called a state reduction across the consecutive time blocks $\left[t_{i}, t_{i+1}\right], i=0, \ldots, N-1$ if every triplet $\left(\theta_{t_{i}}, \theta_{t_{i+1}}, f_{t_{i}: t_{i+1}}\right)$ is a state reduction, for $i=0, \ldots, N-1$.

The state reduction triplet is said to be compatible with the family $\left\{\rho_{s-1: s}\right\}_{t_{0}+1 \leqslant s \leqslant t_{N}}$ of stochastic kernels given in (39) if every triplet $\left(\theta_{t_{i}}, \theta_{t_{i+1}}, f_{t_{i}: t_{i+1}}\right)$ is compatible with the family $\left\{\rho_{s-1: s}\right\}_{t_{i}+1 \leqslant s \leqslant t_{i+1}}$, for $i=0, \ldots, N-1$.

Theorem 3 Suppose that a state reduction $\left(\left\{\mathbb{X}_{t_{i}}\right\}_{i=0, \ldots, N},\left\{\theta_{t_{i}}\right\}_{i=0, \ldots, N},\left\{f_{t_{i}: t_{i+1}}\right\}_{i=0, \ldots, N-1}\right)$ exists across the consecutive time blocks $\left[t_{i}, t_{i+1}\right], i=0, \ldots, N-1$, that is compatible with the family $\left\{\rho_{s-1: s}\right\}_{t_{0}+1 \leqslant s \leqslant t_{N}}$ of stochastic kernels given in (39).

Then, there exists a family of reduced Bellman operators across the consecutive $\left(t_{i+1}: t_{i}\right), i=$ $0, \ldots, N-1$,

\end{equation*}

such that, for any function $\widetilde{\varphi}_{t_{i+1}} \in \mathbb{L}_{+}^{0}\left(\mathbb{X}_{t_{i+1}}, X_{t_{i+1}}\right)$, we have that

Proof This is an immediate consequence of multiple applications of Theorem 2,

## 4 Stochastic Dynamic Programming by Time Blocks

We apply the reduction by time blocks to several classes of optimization problems: dynamic programming with unit time blocks in 4.1 two time-scales dynamic programming in 4.2 decision hazard decision dynamic programming in 4.3 .

### 4.1 Dynamic Programming with Unit Time Blocks

We now consider the case where a state reduction exists at each time $t=0, \ldots, T-1$, with associated dynamics. We recover the classical Dynamic Programming equations.

Following the setting in $\$ 2.2$, we consider a family $\left\{\rho_{t-1: t}\right\}_{1 \leqslant t \leqslant T}$ of stochastic kernels as in (11) and a measurable nonnegative numerical cost function $j$ as in (12).

### 4.1.1 The General Case of Unit Time Blocks

First, we treat the general criterion case. We assume the existence of a family of state spaces $\left\{\mathbb{X}_{t}\right\}_{t=0, \ldots, T}$ and the existence of a family of mappings $\left\{\theta_{t}\right\}_{t=0, \ldots, T}$ with $\theta_{t}: \mathbb{H}_{t} \rightarrow \mathbb{X}_{t}$. We suppose that there exists a family of dynamics $\left\{f_{t: t+1}\right\}_{t=0, \ldots, T-1}$ with $f_{t: t+1}: \mathbb{X}_{t} \times \mathbb{U}_{t} \times \mathbb{W}_{t+1} \rightarrow \mathbb{X}_{t+1}$, such that

\theta_{t+1}\left(\left(h_{t}, u_{t}, w_{t+1}\right)\right)=f_{t: t+1}\left(\theta_{t}\left(h_{t}\right), u_{t}, w_{t+1}\right), \quad \forall\left(h_{t}, u_{t}, w_{t+1}\right) \in \mathbb{H}_{t} \times \mathbb{U}_{t} \times \mathbb{W}_{t+1} \tag{42}
\end{equation*}
$$

The following Proposition is a direct application of Theorem 3

Proposition 2 Suppose that the triplet $\left(\left\{\mathbb{X}_{t}\right\}_{t=0, \ldots, T},\left\{\theta_{t}\right\}_{t=0, \ldots, T},\left\{f_{t: t+1}\right\}_{t=0, \ldots, T-1}\right)$, which is a state reduction across the consecutive time blocks $[t, t+1]_{t=0, \ldots, T-1}$ of the time span, is compatible with the family $\left\{\rho_{t-1: t}\right\}_{t=1, \ldots, T}$ of stochastic kernels in (11) (see Definition 4).

Suppose that there exists a measurable nonnegative numerical function

such that the cost function $j$ in (12) can be factored as

Define the family $\left\{\widetilde{V}_{t}\right\}_{t=0, \ldots, T}$ of functions by the backward induction

\tilde{V}_{T}\left(x_{T}\right) & =\tilde{j}\left(x_{T}\right), \quad \forall x_{T} \in \mathbb{X}_{T}  \tag{44a}\\
\tilde{V}_{t}\left(x_{t}\right) & =\inf _{u_{t} \in \mathbb{U}_{t}} \int_{\mathbb{W}_{t+1}} \tilde{V}_{t+1}\left(f_{t: t+1}\left(x_{t}, u_{t}, w_{t+1}\right)\right) \widetilde{\rho}_{t: t+1}\left(x_{t}, \mathrm{~d} w_{t+1}\right), \quad \forall x_{t} \in \mathbb{X}_{t} \tag{44b}
\end{align*}
$$

for $t=T-1, \ldots, 0$.
Then, the family $\left\{V_{t}\right\}_{t=0, \ldots, T}$ of value functions defined by the family of optimization problems (15) satisfies

Proof The existence of the family $\left\{\widetilde{\mathcal{B}}_{t+1: t}\right\}_{t=0, \ldots, T-1}$ of reduced Bellman operators, as well as the relation (45), are a direct consequence of Theorem 3. The specific expression (44b) is induced by Corollary 1 in case of a unit time block.

The expression of the optimal state feedbacks is given by the next Corollary.
Corollary 2 Suppose that, for $t=0, \ldots, T-1$, there exist measurable selections

\end{equation*}

where the family $\left\{\tilde{V}_{t}\right\}_{t=0, \ldots, T}$ of functions is given by (44). Then, the family of history feedbacks $\left\{\gamma_{s}^{\star}\right\}_{s=t, \ldots, T-1}$ given by

is a solution to any Problem (14), that is, whatever the index $t=0, \ldots, T-1$ and the parameter $h_{t} \in \mathbb{H}_{t}$.

Proof The proof is an immediate consequence of Theorem 1 and Theorem 2 ,

### 4.1.2 The Case of Time Additive Cost Functions

A time additive Stochastic Optimal Control problem is a particular form of the stochastic optimization problem presented previously.

As in 4.1.1, we assume the existence of a family of state spaces $\left\{\mathbb{X}_{t}\right\}_{t=0, \ldots, T}$, the existence of a family of mappings $\left\{\theta_{t}\right\}_{t=0, \ldots, T}$, and the existence of a family of dynamics such that Equation (42) is fulfilled.

We then assume that there exist measurable nonnegative instantaneous cost numerical functions, for $t=0, \ldots, T-1$,

L_{t}: \mathbb{X}_{t} \times \mathbb{U}_{t} \times \mathbb{W}_{t+1} \rightarrow[0,+\infty] \tag{48a}
\end{equation*}
$$

and that there exists a measurable nonnegative final cost numerical function

K: \mathbb{X}_{T} \rightarrow[0,+\infty], \tag{48b}
\end{equation*}
$$

such that the cost function $j$ in (12) writes

Proposition 3 Suppose that the triplet $\left(\left\{\mathbb{X}_{t}\right\}_{t=0, \ldots, T},\left\{\theta_{t}\right\}_{t=0, \ldots, T},\left\{f_{t: t+1}\right\}_{t=0, \ldots, T-1}\right)$, which is a state reduction across the consecutive time blocks $[t, t+1]_{t=0, \ldots, T-1}$ of the time span, is compatible with the family $\left\{\rho_{t-1: t}\right\}_{t=1, \ldots, T}$ of stochastic kernels in (11) (see Definition 4).

We inductively define the family of functions $\left\{\widehat{V}_{t}\right\}_{t=0, \ldots, T}$, with $\widehat{V}_{t}: \mathbb{X}_{t} \rightarrow[0,+\infty]$, by the relations

\end{equation*}
$$

Then, the family $\left\{V_{t}\right\}_{t=0, \ldots, T}$ of value functions defined by the family of optimization problems (15) satisfies

V_{t}\left(h_{t}\right) & =\sum_{s=0}^{t-1} L_{s}\left(\theta_{s}\left(h_{s}\right), u_{s}, w_{s+1}\right)+\widehat{V}_{t}\left(\theta_{t}\left(h_{t}\right)\right), t=1, \ldots, T  \tag{50a}\\
V_{0}\left(h_{0}\right) & =\widehat{V}_{0}\left(\theta_{0}\left(h_{0}\right)\right) \tag{50b}
\end{align*}
$$

Proof The proof is an immediate consequence of Theorem 2, of the specific form of the cost function $j$ and of the fact that the additive term $\sum_{s=0}^{t-1} L_{s}\left(\theta_{s}\left(h_{s}\right), u_{s}, w_{s+1}\right)$ only depends on $h_{t}$.

Corollary 3 Suppose that, for $t=0, \ldots, T-1$, there exists measurable selections

\hat{\gamma}_{t}^{\star}:\left(\mathbb{X}_{t}, \mathcal{X}_{t}\right) \rightarrow\left(\mathbb{U}_{t}, \mathcal{U}_{t}\right) \tag{51a}

such that, for all $x_{t} \in \mathbb{X}_{t}$,

\hat{\gamma}_{t}^{\star}\left(x_{t}\right) \in \underset{u_{t} \in \mathbb{U}_{t}}{\arg \min } \int_{\mathbb{W}_{t+1}}\left(L_{t}\left(x_{t}, u_{t}, w_{t+1}\right)+\hat{V}_{t+1}\left(F_{t}\left(x_{t}, u_{t}, w_{t+1}\right)\right)\right) \tilde{\rho}_{t: t+1}\left(x_{t}, d w_{t+1}\right) \tag{51b}
\end{equation*}
$$

where the family $\left\{\hat{V}_{t}\right\}_{t=0, \ldots, T}$, of functions is given by (49). Then, the family of history feedbacks $\left\{\gamma_{s}^{\star}\right\}_{s=t, \ldots, T-1}$ given by

is a solution to any Problem (14), that is, whatever the index $t=0, \ldots, T-1$ and the parameter $h_{t} \in \mathbb{H}_{t}$.

### 4.2 Two Time-Scales Dynamic Programming

Let $(D, M) \in \mathbb{N}^{* 2}$. We put

We can think of the index $d \in\{0, \ldots, D+1\}$ as an index of days (slow scale), and $m \in\{0, \ldots, M\}$ as an index of minutes (fast scale).

At the end of every minute $m-1$ of every day $d$, that is, at the end of the time interval $[(d, m-$ $1),(d, m)), 0 \leqslant d \leqslant D$ and $1 \leqslant m \leqslant M$, an uncertainty variable $w_{d, m}$ becomes available. Then, at the beginning of the minute $m$, a decision-maker takes a decision $u_{d, m}$. Moreover, at the beginning of every day $d$, an uncertainty variable $w_{d, 0}$ is produced, followed by a decision $u_{d, 0}$. The interplay between uncertainties and decision is thus as follows

w_{0,0} \leadsto u_{0,0} & \leadsto w_{0,1} \leadsto u_{0,1} \leadsto \cdots \\
\ldots & \leadsto w_{0, M-1} \leadsto u_{0, M-1} \leadsto w_{0, M} \leadsto u_{0, M} \leadsto w_{1,0} \leadsto u_{1,0} \leadsto w_{1,1} \cdots \\
& \ldots \leadsto w_{D, M} \leadsto u_{D, M} \leadsto w_{D+1,0}
\end{aligned}
$$

We present the mathematical formalism to handle such type of problems.

We consider the set $\mathbb{T}$ equipped with the lexicographical order

By abuse of notation, we will simply denote by $(d, m) \in \mathbb{T}$ the element of $\{0, \ldots, T\}$ given by $\tau^{-1}(d, m)=$ $d \times(M+1)+m$

For all $(d, m) \in\{0, \ldots, D\} \times\{0, \ldots, M\}$, the decision $u_{d, m}$ takes its values in a measurable set $\mathbb{U}_{d, m}$ equipped with a $\sigma$-field $\mathcal{U}_{d, m}$. For all $(d, m) \in\{0, \ldots, D\} \times\{0, \ldots, M\} \cup\{(D+1,0)\}$, the uncertainty $w_{d, m}$ takes its values in a measurable set $\mathbb{W}_{d, m}$ equipped with a $\sigma$-field $\mathcal{W}_{d, m}$.

History spaces. With the identification (54e), for all $(d, m) \in \mathbb{T}$, we define the history space $\mathbb{H}_{(d, m)}$ equipped with the history field $\mathcal{H}_{(d, m)}$ as in (11). For all $d \in\{0, \ldots, D+1\}$, we define the slow scale history $h_{d}$ element of the slow scale history space $\mathbb{H}_{d}$ equipped with the slow scale history field $\mathcal{H}_{d}$ as in (1) by:

\end{align*}

Stochastic kernels. Because of the jump from one day to the next, we introduce two families of stochastic kernels5:

- a family $\left\{\rho_{(d, M):(d+1,0)}\right\}_{0 \leqslant d \leqslant D}$ of stochastic kernels accross consecutive slow scale steps

- a family $\left\{\rho_{(d, m-1):(d, m)}\right\}_{0 \leqslant d \leqslant D, 1 \leqslant m \leqslant M}$ of stochastic kernels within consecutive slow scale steps

History feedbacks. Following the notation in $\mathbb{4} 2.1 .2$ a history feedback at index $(d, m) \in \mathbb{T}$ is a measurable mapping

\end{equation*}

and $V_{D+1}=j$.
Bellman operators. For $d=0, \ldots, D$, we define a family of slow scale Bellman operators across $(d+1: d)$

### 4.3 Decision Hazard Decision Dynamic Programming

We consider stochastic optimization problems where, during the time interval between two time steps, the decision-maker takes two decisions. As outlined at the beginning of Sect. 2. at the end of the time interval $\left[s-1, s\left[\right.\right.$, an uncertainty variable $w_{s}^{b}$ is produced, and then, at the beginning of the time interval $\left[s, s+1\left[\right.\right.$, the decision-maker takes a head decision $u_{s}^{\sharp}$. What is new is that, at the end of the time interval $\left[s, s+1\right.$ [, when an uncertainty variable $w_{s+1}^{b}$ is produced, the decision-maker has the possibility to make a tail decision $u_{s+1}^{b}$. This latter decision $u_{s+1}^{b}$ can be thought as a recourse variable for a two stage stochastic optimization problem that would take place inside the time interval $\left[s, s+1\left[\right.\right.$. We call $w_{0}^{\sharp}$ the uncertainty happening right before the first decision. This gives the following sequence of events:

For each time $s=1,2 \ldots, S$, the uncertainty $w_{s}^{b}$ takes its values in a measurable set $\mathbb{W}_{s}^{b}$, equipped with a $\sigma$-field $\mathcal{W}_{s}^{b}$. For time $s=0$, the uncertainty $w_{0}^{\sharp}$ takes its values in a measurable set $\mathbb{W}_{0}^{\sharp}$, equipped with a $\sigma$-field $\mathcal{W}_{0}^{\sharp}$.

Decision Hazard Decision history spaces and fields. We define, for $s=0,1,2 \ldots, S$, the head history space

By a slight abuse of notation, the criterion $j$ in (70) (Decision Hazard Decision setting) corresponds to $j \circ[\cdot]^{\sharp}$ in the two time scales setting in 4.2 The feedbacks in the two time scales setting in $\$ 4.2$ are in one to one correspondence with the same elements (72) in the Decision Hazard Decision setting, namely

## 5 The Case of Optimization with Noise Process

In this Section, we suppose the that, for any $s=0, \ldots, T-1$, the set $\mathbb{U}_{s}$ is a separable complete metric space. Optimization with noise process now becomes a special case of the setting in Sect. 2 as we will show in $\$ 5.1$. Therefore, we can apply the results obtained in Sect. 3 and in Sect. 4 .

### 5.1 Optimization with Noise Process

Noise Process. Let $(\Omega, \mathcal{A})$ be a measurable space. For $t=0, \ldots, T$, the noise at time $t$ is modeled as a random variable $\mathbf{W}_{t}$ defined on $\Omega$ and taking values in $\mathbb{W}_{t}$. Therefore, we suppose given a stochastic process $\left\{\mathbf{W}_{t}\right\}_{t=0, \ldots, T}$ called noise process.

The following assumption will be made in the sequel.
Assumption 3 For any $1 \leqslant s \leqslant T$, there exists a regular conditional distribution of the random variable $\mathbf{W}_{s}$ knowing the random process $\mathbf{W}_{0: s-1}$, denoted by $\mathbb{P}_{\mathbf{W}_{s}}^{\mathbf{W}_{0: s-1}}\left(w_{0: s-1}, \mathrm{~d} w_{s}\right)$.

Under Assumption 33, we can introduce the family $\left\{\rho_{s-1: s}\right\}_{1 \leqslant s \leqslant T}$ of stochastic kernels

Adapted Control Processes. Let $t$ be given such that $0 \leqslant t \leqslant T-1$. We introduce

Family of Optimization Problems Over Adapted Control Processes. We suppose here that the measurable space $(\Omega, \mathcal{A})$ is equipped with a probability $\mathbb{P}$, so that $(\Omega, \mathcal{A}, \mathbb{P})$ is a probability space. Following the setting given in 42.2 , we consider a measurable nonnegative numerical cost function $j$ as in Equation (12).

We consider the following family of optimization problems, indexed by $t=0, \ldots, T-1$ and by $h_{t} \in \mathbb{H}_{t}$,

& =\inf _{\gamma_{t: T-1} \in \Gamma_{t: T-1}} \int_{\mathbb{H}_{T}} j\left(h_{T}^{\prime}\right) \rho_{t: T}^{\gamma}\left(h_{t}, \mathrm{~d} h_{T}^{\prime}\right)  \tag{88b}\\
& =V_{t}\left(h_{t}\right), \tag{88c}

where $\rho_{t: T}^{\gamma}$ is given by Definition 1 with the family $\left\{\rho_{s-1: s}\right\}_{1 \leqslant s \leqslant T}$ of stochastic kernels defined in (84), and where the value function $\left\{V_{t}\right\}$ is defined by (15).

In addition, any optimal history feedback $\gamma^{\star}=\left\{\gamma_{s}^{\star}\right\}_{s=t, \ldots, T-1}$ for Problem (14) yields an optimal adapted control process $\left(\mathbf{U}_{t}^{\star}, \ldots, \mathbf{U}_{T-1}^{\star}\right)$ for Problem 87) by

=\int_{\mathbb{H}_{T}} j\left(h_{T}^{\prime}\right) \rho_{t: T}^{\gamma}\left(h_{t}, \mathrm{~d} h_{T}^{\prime}\right) .
\end{gathered}
$$

As a consequence

& \inf _{\left(\mathbf{U}_{t: T-1}\right) \in \mathbb{L}^{0}\left(\Omega, \mathcal{A}_{t: T-1}, \mathbb{U}_{t: T-1}\right)} \mathbb{E}\left[j\left(h_{t}, \mathbf{U}_{t}, \mathbf{W}_{t+1}, \ldots, \mathbf{U}_{T-1}, \mathbf{W}_{T}\right) \mid\right.\left.\mathbf{W}_{0: t}=\left[h_{t}\right]_{0: t}^{\mathbb{W}}\right] \\
& \leqslant \inf _{\gamma t: T-1} \in \Gamma_{t: T-1}  \tag{92}\\
& \int_{\mathbb{H}_{T}} j\left(h_{T}^{\prime}\right) \rho_{t: T}^{\gamma}\left(h_{t}, \mathrm{~d} h_{T}^{\prime}\right) .
\end{align*}
$$

- Second, we define a $(t: T-1)$-noise feedback as a sequence $\lambda=\left\{\lambda_{s}\right\}_{s=t, \ldots, T-1}$ of measurable mappings (the mapping $\lambda_{t}$ is constant)

We denote by $\Lambda_{t: T-1}$ the set of $(t: T-1)$-noise feedbacks.
Let $\left(\mathbf{U}_{t}, \ldots, \mathbf{U}_{T-1}\right) \in \mathbb{L}^{0}\left(\Omega, \mathcal{A}_{t: T-1}, \mathbb{U}_{t: T-1}\right)$. As each set $\mathbb{U}_{s}$ is a separable complete metric space, for $s=t, \ldots, T-1$, we can invoke Doob Theorem (see [3, Chapter 1, p. 18]). Therefore, there exists a $(t: T-1)$-noise feedback $\lambda=\left\{\lambda_{s}\right\}_{s=t, \ldots, T-1} \in \Lambda_{t: T-1}$ such that

\end{aligned}

By the expression (84b) of $\rho_{s: s+1}\left(h_{s}^{\prime}, \mathrm{d} w_{s+1}\right)$ and by Definition 1 of the stochastic kernel $\rho_{t: T}^{\gamma}$, we obtain that (see Appendix A for details)

& \inf _{\gamma_{t: T-1} \in \Gamma_{t: T-1}} \int_{\mathbb{H}_{T}} j\left(h_{T}^{\prime}\right) \rho_{t: T}^{\gamma}\left(h_{t}, \mathrm{~d} h_{T}^{\prime}\right) \\
& \quad \leqslant \inf _{\left(\mathbf{U}_{t}, \ldots, \mathbf{U}_{T-1}\right) \in \mathbb{L}^{0}\left(\Omega, \mathcal{A}_{t: T-1}, \mathbb{U}_{t: T-1}\right)} \mathbb{E}\left[j\left(h_{t}, \mathbf{U}_{t}, \mathbf{W}_{t+1}, \ldots, \mathbf{U}_{T-1}, \mathbf{W}_{T}\right) \mid \mathbf{W}_{0: t}=\left[h_{t}\right]_{0: t}^{\mathbb{W}}\right] . \tag{95}
\end{align*}
$$

Gathering inequalities (92) and (95) leads to (88).
The relations (89) allowing to build an optimal adapted control process ( $\mathbf{U}_{t}^{\star}, \ldots, \mathbf{U}_{T-1}^{\star}$ ) for Problem (87) when starting from an optimal history feedback $\gamma^{\star}=\left\{\gamma_{s}^{\star}\right\}_{s=t, \ldots, T-1}$ for Problem (14) follow easily. This ends the proof.

An immediate consequence of Theorem 7 and Theorem 1 is the following.
Corollary 4 The family $\left\{\check{V}_{t}\right\}_{t=0, \ldots, T}$ of functions in 87) satisfies the backward induction

& =\inf _{u_{t}} \mathbb{E}\left[\check{V}_{t+1}\left(h_{t}, u_{t}, \mathbf{W}_{t+1}\right) \mid \mathbf{W}_{0: t}=\left[h_{t}\right]_{0: t}^{\mathbb{W}}\right], \quad \forall h_{t} \in \mathbb{H}_{t} \tag{96c}
\end{align*}
$$

5.2 Dynamic Programming with Unit Time Blocks

In the setting of optimization with noise process, we now consider the case where a state reduction exists at each time $t=0, \ldots, T-1$.

### 5.2.1 The Case of Final Cost Function

We first treat the case of a general criterion, as in 4.1.1
Proposition 5 Suppose that there exists a family $\left\{\mathbb{X}_{t}\right\}_{t=0, \ldots, T}$ of state spaces, with $\mathbb{X}_{0}=\mathbb{W}_{0}$, and a family $\left\{f_{t: t+1}\right\}_{t=0, \ldots, T-1}$ of dynamics

Suppose that the noise process $\left\{\mathbf{W}_{t}\right\}_{t=0, \ldots, T}$ is made of independent random variables (under the probability law $\mathbb{P}$ ).

For a measurable nonnegative numerical cost function

\end{align*}

for $t=T-1, \ldots, 0$. Then, the value functions $\tilde{V}_{t}$ are the solution of the following family of optimization problems, indexed by $t=0, \ldots, T-1$ and by $x_{t} \in \mathbb{X}_{t}$,

\mathbf{X}_{s}=x_{t}, \quad \mathbf{X}_{s+1}=f_{s: s+1}\left(\mathbf{X}_{s}, \mathbf{U}_{s}, \mathbf{W}_{s+1}\right), \quad \forall s=t, \ldots, T-1 \tag{100b}
\end{equation*}
$$

Proof We define a family $\left\{\theta_{t}\right\}_{t=0, \ldots, T}$ of reduction mappings $\theta_{t}: \mathbb{H}_{t} \rightarrow \mathbb{X}_{t}$ as in (23) by induction. First, as $\mathbb{X}_{0}=\mathbb{W}_{0}=\mathbb{H}_{0}$ by assumption, we put $\theta_{0}=I_{d}: \mathbb{H}_{0} \rightarrow \mathbb{X}_{0}$. Then, we use (42) to define the mappings $\theta_{1}, \ldots, \theta_{T}$. As a consequence, the triplet $\left(\left\{\mathbb{X}_{t}\right\}_{t=0, \ldots, T},\left\{\theta_{t}\right\}_{t=0, \ldots, T},\left\{f_{t: t+1}\right\}_{t=0, \ldots, T-1}\right)$ is a state reduction across the consecutive time blocks $[t, t+1]_{t=0, \ldots, T-1}$ of the time span.

Since the noise process $\left\{\mathbf{W}_{t}\right\}_{t=0, \ldots, T}$ is made of independent random variables (under $\mathbb{P}$ ), the family $\left\{\rho_{s-1: s}\right\}_{1 \leqslant s \leqslant T}$ of stochastic kernels defined in (84) is given by

As a consequence, we have by (26) that the triplet $\left(\left\{\mathbb{X}_{t}\right\}_{t=0, \ldots, T},\left\{\theta_{t}\right\}_{t=0, \ldots, T},\left\{f_{t: t+1}\right\}_{t=0, \ldots, T-1}\right)$ is compatible (see Definition (4) with the family $\left\{\rho_{t-1: t}\right\}_{t=1, \ldots, T}$ of stochastic kernels in (101). In addition, the reduced stochastic kernels in (26) coincide with the original stochastic kernels in (101).

Define the cost function $j$ as

Proposition 8 Suppose that there exists a family $\left\{\mathbb{X}_{s}\right\}_{s=0, \ldots, S}$ of state spaces, with $\mathbb{X}_{0}=\mathbb{W}_{0}^{\sharp}$, and a family $\left\{f_{s: s+1}\right\}_{s=0, \ldots, S-1}$ of dynamics

$$
\begin{equation*}
f_{s: s+1}: \mathbb{X}_{s} \times \mathbb{U}_{s}^{\sharp} \times \mathbb{W}_{s+1}^{b} \times \mathbb{U}_{s+1}^{b} \rightarrow \mathbb{X}_{s+1} \tag{119}
\end{equation*}
$$

Suppose that the noise process $\left\{\mathbf{W}_{s}^{b}\right\}_{s=0, \ldots, S}$ is made of independent random variables (under the probability law $\mathbb{P}$ ).

For a measurable nonnegative numerical cost function

$$
\begin{equation*}
\tilde{j}: \mathbb{X}_{S} \rightarrow[0,+\infty] \tag{120}
\end{equation*}
$$

we define the family of functions $\left\{\widetilde{V}_{s}\right\}_{s=0, \ldots, S}$ by the backward induction

$$
\begin{align*}
\tilde{V}_{S}\left(x_{S}\right) & =\tilde{j}\left(x_{S}\right), \quad \forall x_{S} \in \mathbb{X}_{S}  \tag{121a}\\
\tilde{V}_{s}\left(x_{s}\right) & =\inf _{u_{s}^{\sharp} \in \mathbb{U}_{s}^{\sharp}} \mathbb{E}\left[\inf _{u_{s+1}^{b} \in \mathbb{U}_{s+1}^{b}} \widetilde{V}_{s+1}\left(f_{s^{\prime}: s^{\prime}+1}\left(x_{s}, u_{s}^{\sharp}, \mathbf{W}_{s+1}^{b}, u_{s+1}^{b}\right)\right)\right]  \tag{121b}\\
& \forall x_{s} \in \mathbb{X}_{s}, \quad \forall s=S-1, \ldots, 0 . \tag{121c}
\end{align*}
$$

Then, the value functions $\tilde{V}_{s}$ in (121) are the solution of the following family of optimization problems, indexed by $s=0, \ldots, S-1$ and by $x_{s} \in \mathbb{X}_{s}$,

$$
\begin{equation*}
\tilde{V}_{s}\left(x_{s}\right)=\inf _{\mathbf{U}_{s: S-1}^{\sharp} \in \mathbb{L}^{0}\left(\Omega, \mathcal{A}_{s: S-1}, \mathbb{U}_{s: S-1}^{\sharp}\right)} \inf _{\mathbf{U}_{s+1: S}^{b} \in \mathbb{L}^{0}\left(\Omega, \mathcal{A}_{s+1: s,}, \mathbb{U}_{s+1: S}^{b}\right)} \mathbb{E}\left[\tilde{j}\left(\mathbf{X}_{S}\right)\right] \tag{122a}
\end{equation*}
$$

where

$$
\begin{equation*}
\mathbf{X}_{s^{\prime}}=x_{s}, \quad \mathbf{X}_{s^{\prime}+1}=f_{s^{\prime}: s^{\prime}+1}\left(\mathbf{X}_{s^{\prime}}, \mathbf{U}_{s^{\prime}}^{\sharp}, \mathbf{W}_{s^{\prime}+1}^{b}, \mathbf{U}_{s^{\prime}+1}^{b}\right), \quad \forall s^{\prime}=s, \ldots, S-1 \tag{122b}
\end{equation*}
$$

## 6 Conclusion

As said in the Introduction Sect. [1, the large scale nature of multistage stochastic optimization problems makes decomposition methods appealing. We have provided a method to decompose multistage stochastic optimization problems by time blocks.

In the case of optimization with noise process, we do not require noise independence within the time blocks. This opens the possibility to apply stochastic dynamic programming between the extremities of the time blocks - at a slow time scale for which noise would be statistically independent - and to apply stochastic programming within the time blocks. Therefore, our time block decomposition paves the way for mixing and reconciliating stochastic dynamic programming and stochastic programming methods.

Such an approach is part of a larger research program, where we aim at mixing various decompositioncoordination methods in multistage stochastic optimization, be they spatial, temporal or by scenarios [4].

## A Construction of the stochastic kernels $\rho_{r: t}^{\gamma}$

We detail here the construction of the stochastic kernels $\rho_{r: t}^{\gamma}$ in 7 when $0 \leqslant r<t \leqslant T$. We assume that the $\left(\mathbb{W}_{s}\right)_{s=0}, \ldots, T$ are measurable spaces and we denote by $\left(\mathcal{W}_{s}\right)_{s=0, \ldots, T}$ the associated $\sigma$-fields.

1. In the first step, we build a family of stochastic kernels $\left(\nu_{r, s: s+1}^{\gamma}\right)_{s=r, \cdots, t-1}$ using composition and then we follow 5 p.138] (see also [2] Proposition 7.28]) to define a stochastic kernel product $\mu_{r: t+1}^{\gamma}=\bigotimes_{s=r}^{t-1} \nu_{r, s: s+1}^{\gamma}$. More precisely, let $r$ and $t$ be fixed (such that $0 \leqslant r<t \leqslant T$ ). First, for $s=r$, we simply define $\nu_{r, r: r+1}^{\gamma}=\rho_{r: r+1}$. Second, for each $s$ such that $0 \leqslant r<s<t$, we define a new stochastic kernel $\nu_{r, s: s+1}^{\gamma}$ by the composition $\nu_{r, s: s+1}^{\gamma}=\rho_{s: s+1} \circ \Phi_{r: s}^{\gamma}$ :


Now, proceeding as in 5 p.138], we construct a stochastic kernel

$$
\mu_{r: t}^{\gamma}: \mathbb{H}_{r} \rightarrow \Delta\left(\mathbb{W}_{r+1: t}\right),
$$

obtained as a product of the stochastic kernels $\left(\nu_{r, s: s+1}^{\gamma}\right)_{s=r, \ldots, t-1}$. The construction if as follows: for a fixed $h_{r} \in \mathbb{H}_{r}$ and a fixed sequence of measurable sets $B_{r+1: t} \in \stackrel{r}{\mathcal{W}}_{r+1: t}^{s: s+1}$, we put

$$
\begin{align*}
\mu_{r: t}^{\gamma}\left(h_{r}, B_{r+1: t}\right)=\int_{B_{r+1}} \cdots & \int_{B_{s+1}} \cdots\left(\int_{B_{t}} \nu_{r, t-1: t}^{\gamma}\left(h_{r}, w_{r+1: t-1}, \mathrm{~d} w_{t}\right)\right) \\
& \cdots \nu_{r, s: s+1}^{\gamma}\left(h_{r}, w_{r+1: s}, \mathrm{~d} w_{s+1}\right) \cdots \nu_{r, r: r+1}^{\gamma}\left(h_{r}, \mathrm{~d} w_{r+1}\right) . \tag{124}
\end{align*}
$$

2. The second step is to define the stochastic kernel $\rho_{r: t}^{\gamma}: \mathbb{H}_{r} \rightarrow \Delta\left(\mathbb{H}_{t}\right)$ from the stochastic kernel $\mu_{r: t}^{\gamma}$ using transport with the flow $\Phi_{r: t}^{\gamma}: \mathbb{H}_{r} \times \mathbb{W}_{r+1: t} \rightarrow \mathbb{H}_{t}$. More precisely, for any measurable nonnegative function $\varphi: \mathbb{H}_{t} \rightarrow[0,+\infty]$, we define the integral with respect to the stochastic kernel $\rho_{r: t}^{\gamma}$ as the integral of the function $\varphi \circ \Phi_{r: t}^{\gamma}$ with respect to the kernel $\mu_{r: t}^{\gamma}$ :

$$
\begin{gather*}
\int_{\mathbb{H}_{t}} \varphi\left(h_{t}^{\prime}\right) \rho_{r: t}^{\gamma}\left(h_{r}, \mathrm{~d} h_{t}^{\prime}\right)=\int_{\mathbb{W}_{r+1: t}} \varphi\left(\Phi_{r: t}^{\gamma}\left(h_{r}, w_{r+1: t}\right)\right) \mu_{r: t}^{\gamma}\left(h_{r}, \mathrm{~d} w_{r+1: t}\right)  \tag{125}\\
\mathbb{L}_{+}^{0}\left(\mathbb{H}_{t}, \mathcal{H}_{t}\right) \ni \varphi \xrightarrow{\rho_{r: t}^{\gamma}}\left\langle\varphi, \rho_{r: t}^{\gamma}\right\rangle \in \mathbb{L}_{+}^{0}\left(\mathbb{H}_{r}, \mathcal{H}_{r}\right) \\
\mathbb{L}_{+}^{0}\left(\mathbb{H}_{r} \times \mathbb{W}_{r+1: t}, \mathcal{H}_{r} \otimes \mathcal{W}_{r+1: t}\right) \ni \psi=\varphi \circ \Phi_{r: t}^{\gamma} \xrightarrow{\mu_{r: t}^{\gamma}}\left\langle\left\langle\psi, \mu_{r: t}^{\gamma}\right\rangle .\right.
\end{gather*}
$$

This ends the construction.

## B Specialization to the noise case

We turn now to the special case where, for any $s=0, \ldots, T-1$, the stochastic kernel $\rho_{s: s+1}$ is the regular conditional distribution $\mathbb{P}_{\mathbf{W}_{s+1}}^{\mathbf{W}_{0: s}}$ of the random variable $\mathbf{W}_{s+1}$ knowing the random process $\mathbf{W}_{0: s}$, that is,

$$
\begin{equation*}
\rho_{s: s+1}\left(h_{s}, \mathrm{~d} w_{s+1}\right)=\mathbb{P}_{\mathbf{W}_{s+1}}^{\mathbf{W}_{0: s}}\left(\left[h_{s}\right]_{0: s}^{\mathbb{W}}, \mathrm{d} w_{s+1}\right) . \tag{126}
\end{equation*}
$$

For any $s$ such that $0 \leqslant r<s<t$ and $B_{s+1} \in \mathcal{W}_{s+1}$, we have that

$$
\begin{align*}
\nu_{r, s: s+1}^{\gamma}\left(\left(h_{r}, w_{r+1: s}\right), B_{s+1}\right) & =\rho_{s: s+1}\left(\Phi_{r: s}^{\gamma}\left(h_{r}, w_{r+1: s}\right), B_{s+1}\right)  \tag{123}\\
& =\mathbb{P}_{\mathbf{W}_{s+1}}^{\mathbf{W}_{0: s}}\left(\left[\Phi_{r: s}^{\gamma}\left(h_{r}, w_{r+1: s}\right)\right]_{0: s}^{\mathbb{W}}, B_{s+1}\right),
\end{align*}
$$

( by (126))
which, using Equations (2e) and 4b), gives

$$
\begin{equation*}
=\mathbb{P}_{\mathbf{W}_{s+1}}^{\mathbf{W}_{0: s}}\left(\left(\left[h_{r}\right]_{0: r}^{\mathbb{W}}, w_{r+1: s}\right), B_{s+1}\right) . \tag{127}
\end{equation*}
$$

We observe that the stochastic kernel $\nu_{r, s: s+1}^{\gamma}$ does not depend on the history feedback $\gamma$. As a consequence, the stochastic kernel $\mu_{r: t}^{\gamma}: \mathbb{H}_{r} \rightarrow \Delta\left(\mathbb{W}_{r+1: t}\right)$ obtained by product in (124), does not depend on the history feedback $\gamma$ either, and can be expressed using the regular conditional distribution of $\mathbf{W}_{r+1: t}$ knowing the random process $\mathbf{W}_{0: r}$. By (127) and (124), for a fixed sequence $B_{r+1: t} \in \mathcal{B}\left(\mathbb{W}_{r+1: t}\right)$ of Borel sets, we have

$$
\begin{equation*}
\mu_{r: t}^{\gamma}\left(h_{r}, B_{r+1: t}\right)=\mathbb{P}_{\mathbf{W}_{r+1: t}}^{\mathbf{W}_{0: r}}\left(\left[h_{r}\right]_{0: r}^{\mathbb{W}}, B_{r+1: t}\right) . \tag{128}
\end{equation*}
$$

Now, for any measurable nonnegative function $\varphi: \mathbb{H}_{t} \rightarrow[0,+\infty]$, the integral with respect to the stochastic kernel $\rho_{r: t}^{\gamma}$ is defined by (125) as the integral of the function $\varphi \circ \Phi_{r: t-1}^{\gamma}$ with respect to the kernel $\mu_{r: t}^{\gamma}$. Using Equation (128), this gives

$$
\begin{align*}
\int_{\mathbb{H}_{t}} \varphi\left(h_{t}^{\prime}\right) \rho_{r: t}^{\gamma}\left(h_{r}, \mathrm{~d} h_{t}^{\prime}\right) & =\int_{\mathbb{W}_{r+1: t}} \varphi\left(\Phi_{r: t}^{\gamma}\left(h_{r}, w_{r+1: t}\right)\right) \mu_{r: t}^{\gamma}\left(h_{r}, \mathrm{~d} w_{r+1: t}\right) \\
& =\int_{\mathbb{W}_{r+1: t}} \varphi\left(\Phi_{r: t}^{\gamma}\left(h_{r}, w_{r+1: t}\right)\right) \mathbb{P}_{\mathbf{W}_{r+1: t}}^{\mathbf{W}_{0: r}}\left(\left[h_{r}\right]_{0: r}^{\mathbb{W}}, \mathrm{d} w_{r+1: t}\right) . \\
& =\mathbb{E}\left[\varphi\left(\Phi_{r: t}^{\gamma}\left(h_{r}, \mathbf{W}_{r+1: t}\right)\right) \mid \mathbf{W}_{0: r}=\left[h_{r}\right]_{0: r}^{\mathbb{W}}\right] . \tag{129}
\end{align*}
$$
