## THE DISCRETE LAPLACIAN ACTING ON 2-FORMS AND APPLICATION

#### HATEM BALOUDI, SAYDA BELGACEM, AND AREF JERIBI

ABSTRACT. In this paper, we study the discrete Laplacian acting on 2—forms that was introduced and investigated in [7]. We establish a new criterion of essential self-adjointness using the Nelson lemma. Moreover, we give an upper bound on the infimum of the essential spectrum. Furthermore, we establish a link between the adjacency matrix and the discrete Laplacian on 2—forms.

#### 1. Introduction

Spectral graph theory is an active area of research. In the last few years, the questions of the essential self-adjointness of discrete Laplacian operators on infinite graphs have attracted a lot of interest, see [10, 17, 21, 16]. There exist other definitions of the discrete Laplacian, e.g., [23, 15, 4, 2]. The one we are studying here is the discrete Laplacian acting on 2-forms and denoted by  $\mathcal{L}_{2,\text{skew}}$ , where skew stands for skew-symmetric. This operator was studied by Chebbi in [7]. The author gives a relation between  $\chi$ -completeness geometric hypothesis for the graph and essential self-adjointness for the discrete Laplacian  $\mathcal{L}_{2,\text{skew}}$ . More specifically, the author has proved that  $\mathcal{L}_{2,\text{skew}}$ is essential self-adjoint, when the triangulation (we refer to Section 2 for a precise definition) is  $\chi$ -complete. The aim of this article is to continue to discuss the question of essential self-adjointness for  $\mathcal{L}_{2.\text{skew}}$ . Note that this operator depends on the weight  $\mathcal{R}$  on oriented triangular face and the weight  $\mathcal{E}$  on oriented edges, see Section 4 for more details. In the setting of electrical networks, the weight  $\mathcal{E}$  correspond to the conductance. We establish a hypothesis on the weights  $\mathcal{R}$  and  $\mathcal{E}$  involving essential self-adjointness. Our technique is based on the Nelson commutator theorem, see [25, Theorem X.37]. Moreover, we give a upper bound on the infimum of the essential spectrum  $\sigma_{\text{ess}}(\mathcal{L}_{2,\text{skew}}^{\mathcal{F}})$ , where  $\mathcal{L}_{2,\text{skew}}^{\mathcal{F}}$  is the Friedreich extension of  $\mathcal{L}_{2,\text{skew}}$ . Finally, we find a link between the adjacency matrix and the discrete Laplacian  $\mathcal{L}_{2,\text{skew}}$ . In the case of 3-partite graph, we prove that  $\mathcal{L}_{2,\text{skew}}$  is unitarily equivalent to the adjacency matrix of the triangular graph, see Section 7 for more details.

#### 2. Generalities about graphs

We star with some definitions to fix notations for graphs and refer to [8, 9, 23] for surveys on the matter. Let  $\mathcal{V}$  be a countable set. We equip  $\mathcal{V}$  with the discrete topology. Let  $\mathcal{E}: \mathcal{V} \times \mathcal{V} \longrightarrow [0, +\infty)$  and assume that  $\mathcal{E}$  is symmetric (i.e,  $\mathcal{E}(x,y) = \mathcal{E}(y,x)$ , for all  $x,y \in \mathcal{V}$ ). Let  $m: \mathcal{V} \longrightarrow (0,+\infty)$ . We say that  $\mathcal{G} = (\mathcal{V}, m, \mathcal{E})$  is a weighted graph with vertices  $\mathcal{V}$ , weight of vertices m and weight of edges  $\mathcal{E}$ . In the setting of electrical networks, the weights correspond of the conductances. We say that x,y are neighbors if  $\mathcal{E}(x,y) \neq 0$  and we denote it by  $x \sim y$ . A graph  $\mathcal{G}$  is simple if it has no loops and  $\mathcal{E}$  has values in  $\{0,1\}$ . The set of neighbors of  $x \in \mathcal{V}$  is denoted by

$$\mathcal{N}_{\mathcal{G}}(x) := \{ y \in \mathcal{V} : \mathcal{E}(x, y) \neq 0 \}.$$

A graph is locally finite if  $\sharp \mathcal{N}_{\mathcal{G}}(x)$  is finite for all  $x \in \mathcal{V}$ . The weighted degree of vertices is given by

$$d_{\mathcal{V}}(x) := \frac{1}{m(x)} \sum_{y \sim x} \mathcal{E}(x, y).$$

When  $\mathcal{G}$  is simple,  $d_{\mathcal{V}}(x) = \sharp \mathcal{N}_{\mathcal{G}}(x)$ . A graph  $\mathcal{G}$  is connected, if for all  $x, y \in \mathcal{V}$ , there exists an x - y-path, i.e., there is a sequence  $(x_1, ..., x_{N+1}) \in \mathcal{V}^{N+1}$  such that  $x_1 = x$ ,  $x_{N+1} = y$  and  $\mathcal{E}(x_n, x_{n+1}) > 0$  for all  $n \in \{1, ..., N\}$ . In this case, we endow  $\mathcal{V}$  with the metric  $d_{\mathcal{V}}$  defined by

$$d_{\mathcal{V}}(x,y) := \inf\{N \in \mathbb{N} : \text{ there exists an } x - y - \text{path of length } N\}.$$

In the sequel, we shall always consider graphs  $\mathcal{G}$ , which are locally finite, connected and have no loop. The path x-y is called a cycle or closed when the origin and the end are identical, i.e  $x_0=x_n$  with  $n\geq 3$ . If no cycle appear more than once in a path, the path is called a simple path. The weighted triangulations is a quartet  $\mathcal{T}=(\mathcal{V},m,\mathcal{E},\mathcal{R})$  where  $\mathcal{R}:\mathcal{V}\times\mathcal{V}\times\mathcal{V}\longrightarrow (0,+\infty)$  is symmetric (i.e  $\mathcal{R}(x,y,z)=\mathcal{R}(z,y,z)$  for all  $(x,y,z)\in\mathcal{V}\times\mathcal{V}\times\mathcal{V}$ ) and

$$(x, y, z) \in \mathcal{F} \iff \mathcal{R}(x, y, z) > 0.$$

 $\mathcal{R}$  is said the weight of faces. We say that  $\mathcal{T}$  is simple if  $\mathcal{G} := (\mathcal{V}, m, \mathcal{E})$  is simple and the weights of the faces equal 1. The set of vertices belonging to the edge (x, y) is given by

$$\mathcal{F}_{(x,y)} := \mathcal{N}_{\mathcal{G}}(x) \cap \mathcal{N}_{\mathcal{G}}(y).$$

The weighted degree of edges is given by:

$$d_{\mathcal{E}}(x,y) := \frac{1}{\mathcal{E}(x,y)} \sum_{z \in \mathcal{F}_{(x,y)}} \mathcal{R}(x,y,z).$$

When  $\mathcal{T}$  is simple,  $d_{\mathcal{E}}(x,y) = \sharp \mathcal{F}_{(x,y)}$ .

#### 3. The symmetric and antisymmetric spaces

3.1. Hilbert structures on the set of edges. Let  $\mathcal{T} = (\mathcal{V}, m, \mathcal{E}, \mathcal{R})$  be a weighted triangulation. Let  $\mathcal{E} := \{(x, y) \in \mathcal{V} \times \mathcal{V} : \mathcal{E}(x, y) > 0\}$ . The set of 1-cochains (or 1-forms) is given by:

$$C_{\text{skew}}(\mathcal{E}) := \Big\{ f : \mathcal{E} \to \mathbb{C}, \ f(x,y) = -f(y,x) \text{ for all } x, y \in \mathcal{V} \Big\},$$

where skew stands for skew-symmetric. This corresponds to fermionic statistics. The set of functions with finite support is denoted by  $C_{\text{skew}}^c(\mathcal{E})$ . Concerning bosonic statistics, we define:

$$\mathcal{C}_{\mathrm{sym}}(\mathcal{E}) := \Big\{ f : \mathcal{E} \to \mathbb{C}, \ f(x,y) = f(y,x) \ \text{for all} \ x,y \in \mathcal{V} \Big\}.$$

The sets of functions with finite support is denoted by  $C_{\text{sym}}^c(\mathcal{E})$ . We turn to the Hilbert structures.

$$\ell_{\text{skew}}^2(\mathcal{E}) := \left\{ f \in \mathcal{C}_{\text{skew}}(\mathcal{E}) \text{ such that } \|f\|^2 := \frac{1}{2} \sum_{x,y \in \mathcal{V}} \mathcal{E}(x,y) |f(x,y)|^2 < \infty \right\}$$

and

$$\ell^2_{\mathrm{sym}}(\mathcal{E}) := \left\{ f \in \mathcal{C}_{\mathrm{sym}}(\mathcal{E}) \text{ such that } \|f\|^2 := \frac{1}{2} \sum_{x,y \in \mathcal{V}} \mathcal{E}(x,y) |f(x,y)|^2 < \infty \right\}.$$

The associated scalar product is given by

$$\langle f, g \rangle := \frac{1}{2} \sum_{(x,y) \in \mathcal{E}} \mathcal{E}(x,y) \overline{f(x,y)} g(x,y),$$

when f and g are both in  $\ell_{\text{skew}}^2(\mathcal{E})$  or in  $\ell_{\text{sym}}^2(\mathcal{E})$ .

3.2. Hilbert structures on the set of faces. Let  $\mathcal{T} = (\mathcal{V}, m, \mathcal{E}, \mathcal{R})$  be a weighted triangulation. The set of 2-cochains or 2-forms is given by

$$\mathcal{C}_{\mathrm{skew}}(\mathcal{R}) = \Big\{ f: \mathcal{F} \longrightarrow \mathbb{C}: f(x,y,z) = -f(z,y,x) \Big\}.$$

The sets of functions with finite support is denoted by  $C^c_{\text{skew}}(\mathcal{R})$ . Concerning the case symmetric, we define

$$C_{\text{sym}}(\mathcal{R}) = \{ f : \mathcal{F} \longrightarrow \mathbb{C} : f(x, y, z) = f(z, y, x) \}.$$

The sets of functions with finite support is denoted by  $\mathcal{C}^c_{\mathrm{sym}}(\mathcal{R})$ . Let us define the Hilbert spaces  $\ell^2_{\mathrm{skew}}(\mathcal{R})$  and  $\ell^2_{\mathrm{sym}}(\mathcal{R})$  as the sets of cochains with finite norm, we have

$$\ell^2_{\mathrm{skew}}(\mathcal{F}) := \left\{ f \in \mathcal{C}_{\mathrm{skew}}(\mathcal{R}) : \quad \|f\| = \frac{1}{6} \sum_{(x,y,z) \in \mathcal{F}} \mathcal{R}(x,y,z) \mid f(x,y,z) \mid^2 \right\}$$

and

$$\ell^2_{ ext{sym}}(\mathcal{R}) := \left\{ f \in \mathcal{C}_{ ext{sym}}(\mathcal{R}) : \quad \|f\| = rac{1}{6} \sum_{(x,y,z) \in \mathcal{F}} \mathcal{R}(x,y,z) \mid f(x,y,z) \mid^2 
ight\}.$$

The associated scalar product is given by

$$\langle f, g \rangle := \frac{1}{2} \sum_{(x,y,z) \in \mathcal{F}} \mathcal{R}(x,y,z) \overline{f(x,y,z)} g(x,y,z)$$

when f and g are both in  $\ell_{\text{skew}}^2(\mathcal{R})$  or in  $\ell_{\text{sym}}^2(\mathcal{R})$ .

#### 4. Operators

In this section, we recall the concept of exterior derivative operator associated to a faces space, we refer to [7] for more detail. This permits to define the discrete Laplacian acting on 2—forms.

4.1. **Skew-symmetric case.** We start by defining the operators in the skew-symmetric case. The skew-symmetric exterior operator is the operator  $d^1_{\text{skew}}: \mathcal{C}^c_{\text{skew}}(\mathcal{E}) \longrightarrow \mathcal{C}^c_{\text{skew}}(\mathcal{R})$ , given by

$$d_{\text{skew}}^{1}(f)(x, y, z) = f(x, y) + f(y, z) + f(z, x).$$

The skew-symmetric co-exterior derivative operator is the formal adjoint of  $d_{\text{skew}}^1$ , i.e. it is the operator  $\delta_{\text{skew}}^1: \mathcal{C}_{\text{skew}}^c(\mathcal{R}) \longrightarrow \mathcal{C}_{\text{skew}}^c(\mathcal{E})$ , given by

$$\forall f \in \mathcal{C}^c_{\mathrm{skew}}(\mathcal{R}), \quad \delta^1_{\mathrm{skew}}(f)(x,y) = \frac{1}{\mathcal{E}(x,y)} \sum_{z \in \mathcal{F}_{(x,y)}} \mathcal{R}(x,y,z) f(x,y,z).$$

both operators are closable (see [7, Lemme 3.1]). We denote their closure by the same symbol. The skew-symmetric discrete Laplacian operator acting on 2—forms is given by

$$\begin{split} \mathcal{L}_{2, \text{skew}}(f)(x, y, z) &= d_{\text{skew}}^1 \delta_{\text{skew}}^1(f)(x, y, z) \\ &= \frac{1}{\mathcal{E}(x, y)} \sum_{t \in \mathcal{F}_{(x, y)}} \mathcal{R}(x, y, t) f(x, y, t) \\ &+ \frac{1}{\mathcal{E}(y, z)} \sum_{t \in \mathcal{F}_{(y, z)}} \mathcal{R}(y, z, t) f(y, z, t) \\ &+ \frac{1}{\mathcal{E}(|z, x|)} \sum_{t \in \mathcal{F}_{(z, x)}} \mathcal{R}(z, x, t) f(z, x, t), \end{split}$$

with  $f \in \mathcal{C}^c_{\text{skew}}(\mathcal{R})$ .

4.2. **Symmetric case.** We turn to the symmetric case. The symmetric exterior derivative in the symmetric case, we define  $d_{\mathrm{sym}}^1: \mathcal{C}_{\mathrm{sym}}^c(\mathcal{E}) \longrightarrow \mathcal{C}_{\mathrm{sym}}^c(\mathcal{R})$  by

$$\forall f \in \mathcal{C}^c_{\text{sym}}(\mathcal{E}), \quad d^1_{\text{skew}}(f)(x, y, z) = f(x, y) + f(y, z) + f(z, x).$$

The symmetric co-exterior derivative operator is the formal adjoint of  $d^1_{\text{sym}}$ , i.e. it is the operator  $\delta^1_{\text{sym}}: \mathcal{C}^1_{\text{sym}}(\mathcal{R}) \longrightarrow \mathcal{C}^c_{\text{sym}}(\mathcal{R})$ , given by

$$\forall f \in \mathcal{C}^1_{\mathrm{sym}}(\mathcal{R}), \delta^1_{\mathrm{sym}}(f)(x,y) := \frac{1}{\mathcal{E}(x,y)} \sum_{z \in \mathcal{F}_{(x,y)}} \mathcal{R}(x,y,z) f(x,y,z).$$

The symmetric discrete Laplacian operator acting on 2-forms is the operator  $\mathcal{L}_{2,\text{sym}} = d_{\text{sym}}^1 \delta_{\text{sym}}^1$ , given by the same expression of  $\mathcal{L}_{2,\text{skew}}$ .

4.3. Relationship between  $\mathcal{L}_{2,\text{skew}}$  and  $\mathcal{L}_{2,\text{sym}}$ . The two operators  $\mathcal{L}_{2,\text{skew}}$  and  $\mathcal{L}_{2,\text{sym}}$  have the same expression. However they do not act on the same spaces. Namely, when  $\mathcal{T}$  is tri-partite, we shall prove that the two operators are unitarily equivalent.

**Definition 4.1.** A triangulation  $\mathcal{T} = (\mathcal{V}, m, \mathcal{E}, \mathcal{R})$  is tri-partite if there there are  $\mathcal{V}_1$ ,  $\mathcal{V}_2$  and  $\mathcal{V}_3$  such that  $\mathcal{V}_1 \cap \mathcal{V}_2 \cap \mathcal{V}_3 = \emptyset$  and such this implication hold

$$\mathcal{E}(x,y) = 0 \Longrightarrow (x,y) \in \mathcal{V}_1^2 \cup \mathcal{V}_2^2 \cup \mathcal{V}_3^2$$

**Theorem 4.2.** Let  $\mathcal{T} = (\mathcal{V}, m, \mathcal{E}, \mathcal{R})$  be a tri-partite weighted triangulation. Then  $\mathcal{L}_{2,\text{skew}}$  and  $\mathcal{L}_{2,\text{sym}}$  are unitarily equivalent.

*Proof.* We consider the tri-partite decomposition  $\{\mathcal{V}_1,\mathcal{V}_2,\mathcal{V}_3\}$ . Let  $\mathcal{U}:\ell^2_{skew}(\mathcal{R}) \longrightarrow \ell^2_{svm}(\mathcal{R})$  be the unitary map given by

$$\mathcal{U}(f)(x, y, z) = S(x, y, z)f(x, y, z),$$

where

$$S = 1_{\mathcal{V}_1 \times \mathcal{V}_2 \times \mathcal{V}_3} + 1_{\mathcal{V}_2 \times \mathcal{V}_3 \times \mathcal{V}_1} + 1_{\mathcal{V}_3 \times \mathcal{V}_1 \times \mathcal{V}_2} - 1_{\mathcal{V}_3 \times \mathcal{V}_2 \times \mathcal{V}_1} - 1_{\mathcal{V}_1 \times \mathcal{V}_3 \times \mathcal{V}_2}.$$

Note that

$$\mathcal{U}^{-1}(f) = \mathcal{U}^*(f)$$

for all  $f \in \ell^2_{\text{sym}}(\mathcal{R})$ . Therefore,

$$\mathcal{UL}_{2,\text{skew}}\mathcal{U}^{-1}(f)(x,y,z) = \mathcal{L}_{2,\text{sym}}(f)(x,y,z)$$

for all 
$$f \in \mathcal{C}^c_{\text{sym}}(\mathcal{R})$$
.

#### 5. A Nelson Criterium

For the general theory of unbounded Hermitian operators and their extensions, we refer the reader to [24, 19, 26]. Let  $\mathcal{L}_{2,\text{max,skew}}$  be the following mapping from  $\mathcal{C}_{\text{skew}}(\mathcal{R})$  into itself:

$$\begin{split} \mathcal{L}_{2,\text{max,skew}}(f)(x,y,z) &= \frac{1}{\mathcal{E}(x,y)} \sum_{t \in \mathcal{F}_{(x,y)}} \mathcal{R}(x,y,t) f(x,y,t) \\ &+ \frac{1}{\mathcal{E}(y,z)} \sum_{t \in \mathcal{F}_{(y,z)}} \mathcal{R}(y,z,t) f(y,z,t) \\ &+ \frac{1}{\mathcal{E}(z,x)} \sum_{t \in \mathcal{F}_{(z,x)}} \mathcal{R}(z,x,t) f(z,x,t). \end{split}$$

Let  $\mathcal{L}_{2,\text{min,skew}}$  be the restrictions of  $\mathcal{L}_{2,\text{max,skew}}$  to

$$\mathcal{D}(\mathcal{L}_{2,\min,\text{skew}}) := \left\{ f \in \ell^2_{\text{skew}}(\mathcal{R}) \text{ such that } \mathcal{L}_{2,\max,\text{skew}} f \in \ell^2_{\text{skew}}(\mathcal{R}) \right\}.$$

Lemma 5.1.  $\mathcal{L}_{2,\text{skew}}^* = \mathcal{L}_{2,\text{min,skew}}$ .

*Proof.* Let  $f \in \mathcal{C}^c_{\text{skew}}(\mathcal{R})$  and let  $g \in \mathcal{C}_{\text{skew}}(\mathcal{R})$ . Let  $\mathcal{F}_{00}$  the support of f and set

$$\mathcal{F}_0 = \left\{ (x, y, z) \in \mathcal{F} : \exists u \in \mathcal{V}, \{ (x, y, u), (y, z, u), (z, x, u) \} \cap \mathcal{F}_{00} \neq \emptyset \right\}$$

which is a finite set. Then  $\operatorname{supp}(\mathcal{L}_{2,skew}) \subset \mathcal{F}_0$  and the following relation holds:

$$\begin{split} \langle \mathcal{L}_{2, \text{skew}} f, g \rangle &= \frac{1}{6} \sum_{(x, y, z) \in \mathcal{F}_0} \mathcal{R}(x, y, z) \mathcal{L}_{2, \text{skew}}(f)(x, y, z) \overline{g(x, y, z)} \\ &= \frac{1}{6} \sum_{(x, y, z) \in \mathcal{F}_0} \mathcal{R}(x, y, z) \Big( \frac{1}{\mathcal{E}(x, y)} \sum_{t \in \mathcal{F}_{(x, y)}} \mathcal{R}(x, y, t) f(x, y, t) \\ &\quad + \frac{1}{\mathcal{E}(y, z)} \sum_{t \in \mathcal{F}_{(y, z)}} \mathcal{R}(y, z, t) f(y, z, t) \\ &\quad + \frac{1}{\mathcal{E}(z, x)} \sum_{t \in \mathcal{F}_{(z, x)}} \mathcal{R}(z, x, t) f(z, x, t) \Big) \overline{g(x, y, z)} \\ &= \frac{1}{6} \sum_{(x, y, z) \in \mathcal{F}_{00}} \mathcal{R}(x, y, z) f(x, y, z) \Big( \frac{1}{\mathcal{E}(x, y)} \sum_{u \in \mathcal{V}} \mathcal{R}(x, y, u) g(x, y, u) \\ &\quad + \frac{1}{\mathcal{E}(y, z)} \sum_{u \in \mathcal{V}} \mathcal{R}(y, z, u) g(y, z, u) \\ &\quad + \frac{1}{\mathcal{E}(z, x)} \sum_{u \in \mathcal{V}} \mathcal{R}(z, x, u) g(z, x, u) \Big) \end{split}$$

(1) 
$$= \frac{1}{6} \sum_{x,y,z \in \mathcal{V}} \mathcal{R}(x,y,z) f(x,y,z) \overline{\mathcal{L}_2 g(x,y,z)}.$$

Let  $g \in \mathcal{D}(\mathcal{L}_{2,\min,\text{skew}})$ . It flows from (1) that

$$\langle \mathcal{L}_{2,\text{skew}} f, g \rangle = \langle f, \mathcal{L}_{2,\text{min,skew}} g \rangle$$

for all  $f \in \mathcal{C}^c_{\text{skew}}(\mathcal{R})$ , which implies that  $g \in \mathcal{D}(\mathcal{L}^*_{2,\text{skew}})$ . Now let  $g \in \mathcal{D}(\mathcal{L}^*_{2,\text{skew}})$ . Let  $(x, y, z) \in \mathcal{F}$  and let

$$f = \frac{1}{\mathcal{R}(x, y, z)} \left( \delta_{x, y, z} + \delta_{y, z, x} + \delta_{z, x, y} \right) - \frac{1}{\mathcal{R}(z, y, x)} \left( \delta_{z, y, x} + \delta_{x, z, y} + \delta_{y, x, z} \right).$$

Then  $f \in \mathcal{C}^c_{\text{skew}}(\mathcal{R})$  and we obtain from (1):

$$\overline{(\mathcal{L}_{2,\text{skew}}^*g)(x,y,z)} = \langle f, \mathcal{L}_{2,\text{skew}}^*g \rangle 
= \langle \mathcal{L}_{2,\text{skew}}f, g \rangle 
= \frac{1}{6} \sum_{(u,v,w) \in \mathcal{F}} \mathcal{R}(u,v,w) \mathcal{L}_{2,\text{skew}}f(u,v,w) \overline{g(u,v,w)} 
= \frac{1}{6} \sum_{(u,v,w) \in \mathcal{F}} \mathcal{R}(u,v,w) f(u,v,w) \overline{\mathcal{L}_{2,\text{min,skew}}g(u,v,w)} 
= \overline{(\mathcal{L}_{2,\text{min,skew}}g)(x,y,z)}.$$

which implies that  $\mathcal{L}_{2,\text{skew}}g = \mathcal{L}_{2,\text{min,skew}}g \in \ell^2_{\text{skew}}(\mathcal{F})$  by the definition of the adjoint, it follows that  $g \in \mathcal{D}(\mathcal{L}_{2,\text{min,skew}})$ . Hence  $\mathcal{L}^*_{2,\text{skew}} = \mathcal{L}_{2,\text{min,skew}}$ .

**Remark 5.2.** Let  $\mathcal{L}_{2,\text{max,sym}}$  be the mapping from  $\mathcal{C}_c(\mathcal{R})$  into itself given by the same expression of  $\mathcal{L}_{2,\text{max,sym}}$ . Then  $\mathcal{L}_{2,\text{sym}}^* = \mathcal{L}_{2,\text{min,sym}}$  where  $\mathcal{L}_{2,\text{min,sym}}$  is the restrictions of  $\mathcal{L}_{2,\text{max,sym}}$  to

$$\mathcal{D}(\mathcal{L}_{2,\min,\text{sym}}) := \left\{ f \in \ell^2_{\text{sym}}(\mathcal{R}) \text{ such that } \mathcal{L}_{2,\max,\text{sym}} f \in \ell^2_{\text{sym}}(\mathcal{R}) \right\}.$$

Using the Nelson commutator theorem, we prove the criterium of essential self-adjointness for  $\mathcal{L}_{1,\text{skew}}$  and  $\mathcal{L}_{1,\text{sym}}$ .

**Theorem 5.3.** Let  $\mathcal{T} = (\mathcal{V}, m, \mathcal{E}, \mathcal{R})$  be a weighted triangulation. Set

$$\mathcal{N}(x, y, z) = 1 + d_{\mathcal{E}}(x, y) + d_{\mathcal{E}}(y, z) + d_{\mathcal{E}}(z, x).$$

Suppose that

$$\sup_{(x,y,z)\in\mathcal{F}} \sum_{r\in\mathcal{F}_{(x,y)}} \frac{1}{\mathcal{E}(x,y)} \mathcal{R}(x,y,r) \mid \mathcal{N}(x,y,r) - \mathcal{N}(x,y,z) \mid^{2} < \infty.$$

Then  $\mathcal{L}_{2,\text{skew}}$  is essentially self-adjoint on  $\mathcal{C}_{\text{skew}}^c(\mathcal{R})$  and  $\mathcal{L}_{2,\text{sym}}$  is essentially self-adjoint on  $\mathcal{C}_{\text{sym}}^c(\mathcal{R})$ .

*Proof.* Let  $\mathcal{N}$  be the operator of multiplication by  $\mathcal{N}(.,.,.)$  ant take  $f \in \mathcal{C}^c_{\text{skew}}(\mathcal{F})$ . We have:

$$\begin{split} \|\mathcal{L}_{2,\text{skew}} f\|^2 &\leq \frac{2}{3} \sum_{(x,y,z) \in \mathcal{F}} \mathcal{R}(x,y,z) \Big( \frac{1}{\mathcal{E}^2(x,y)} \mid \sum_{t \in \mathcal{F}_{(x,y)}} \mathcal{R}(x,y,t) f(x,y,t) \mid^2 \\ &+ \frac{1}{\mathcal{E}^2(y,z)} \mid \sum_{t \in \mathcal{F}_{(x,y)}} \mathcal{R}(y,z,t) f(y,z,t) \mid^2 \\ &+ \frac{1}{\mathcal{E}^2(y,z)} \mid \sum_{t \in \mathcal{F}_{(x,y)}} \mathcal{R}(y,z,t) f(y,z,t) \mid^2 \Big) \\ &\leq 2 \sum_{(x,y,z) \in \mathcal{F}} \mathcal{R}(x,y,z) \frac{1}{\mathcal{E}^2(x,y)} \mid \sum_{t \in \mathcal{F}_{(x,y)}} \mathcal{R}(x,y,t) f(x,y,t) \mid^2 \\ &\leq 2 \sum_{(x,y,z) \in \mathcal{F}} \mathcal{R}(x,y,z) \frac{1}{\mathcal{E}^2(x,y)} \Big( \sum_{r \in \mathcal{F}_{(x,y)}} \mathcal{R}(x,y,r) \Big) \times \\ &\qquad \qquad \Big( \sum_{t \in \mathcal{F}_{(x,y)}} \mathcal{R}(x,y,t) \mid f(x,y,t) \mid^2 \Big) \\ &= 2 \sum_{(x,y,z) \in \mathcal{F}} \mathcal{R}(x,y,z) \Big( \frac{1}{\mathcal{E}(x,y)} \sum_{t \in \mathcal{F}_{(x,y)}} \mathcal{R}(x,y,t) \Big)^2 \mid f(x,y,z) \mid^2 \\ &\leq 12 \|\mathcal{N}(f)\|^2. \end{split}$$

Moreover, noticing that  $\mathcal{N}(.,.,.)$  is symmetric and f(x,y,z) = -f(z,y,x) and let  $J = |\langle f, [\mathcal{L}_{2,\text{skew}}, \mathcal{N}] f \rangle|$ . We get:

$$J \leq \frac{1}{12} \sum_{(x,y,z) \in \mathcal{F}} \mathcal{R}(x,y,z) \Big( \mid f(x,y,z) \mid^{2} \\ + \mid [\mathcal{L}_{2,\text{skew}}, \mathcal{N}](f)(x,y,z) \mid^{2} \Big)$$

$$\leq \frac{1}{2} \|\mathcal{N}^{\frac{1}{2}}(f)\|^{2} + \frac{1}{4} \sum_{(x,y,z) \in \mathcal{F}} \mathcal{R}(x,y,z) \mid \sum_{t \in \mathcal{F}_{(x,y)}} \frac{1}{\mathcal{E}(x,y)} \mathcal{R}(x,y,t) \times \Big( \mathcal{N}(x,y,t) - \mathcal{N}(x,y,z) \Big) f(x,y,t) \mid^{2} \Big)$$

$$\leq \frac{1}{2} \|\mathcal{N}^{\frac{1}{2}}(f)\|^{2} + \frac{1}{4} \sum_{(x,y,z) \in \mathcal{F}} \mathcal{R}(x,y,z) \Big( \sum_{t \in \mathcal{F}_{(x,y)}} \frac{1}{\mathcal{E}(x,y)} \mathcal{R}(x,y,t) \Big) \times \Big( \sum_{r \in \mathcal{F}_{(x,y)}} \frac{1}{\mathcal{E}(x,y)} \mathcal{R}(x,y,r) \mid \mathcal{N}(x,y,r) - \mathcal{N}(x,y,z) \mid^{2} \mid f(x,y,r) \mid^{2} \Big)$$

$$= \frac{1}{2} \|\mathcal{N}^{\frac{1}{2}}(f)\|^{2} + \frac{1}{4} \sum_{(x,y,z) \in \mathcal{F}} \mathcal{R}(x,y,z) \Big( \sum_{t \in \mathcal{F}_{(x,y)}} \frac{1}{\mathcal{E}(x,y)} \mathcal{R}(x,y,t) \Big) \times \Big( \sum_{r \in \mathcal{V}} \frac{1}{\mathcal{E}(x,y)} \mathcal{F}(x,y,r) \mid \mathcal{N}(x,y,r) - \mathcal{N}(x,y,z) \mid^{2} \mid f(x,y,z) \mid^{2} \Big)$$

$$\leq C$$

$$\leq (\frac{1+3C}{2}) \|\mathcal{N}^{\frac{1}{2}}(f)\|.$$

Applying [25, Theorem X.37], the result follows. The proof of  $\mathcal{L}_{2,\mathrm{sym}}$  may be checked in the same way as the proof of  $\mathcal{L}_{2,\mathrm{skew}}$ .

**Corollary 5.4.** Let  $\mathcal{T}=(\mathcal{V},m,\mathcal{E},\mathcal{R})$  be a simple triangulation. Assume that

$$\sup_{(x,y,z)\in\mathcal{F}} \sum_{r\in\mathcal{F}_{(x,y)}} |\sharp \mathcal{F}_{(y,z)} + \sharp \mathcal{F}_{(z,x)} - \sharp \mathcal{F}_{(y,r)} - \sharp \mathcal{F}_{(r,x)}|^2 < \infty.$$

Then  $\mathcal{L}_{2,\text{skew}}$  is essentially self-adjoint on  $\mathcal{C}_{\text{skew}}^c(\mathcal{R})$  and  $\mathcal{L}_{2,\text{sym}}$  is essentially self-adjoint on  $\mathcal{C}_{\text{sym}}^c(\mathcal{R})$ .

#### 6. Essential spectrum

Let A be a closed, densely defined linear operator on a Banach space X, and let  $\sigma(A)$  denote the spectrum of A. We denote by  $\mathcal{K}(X)$  the set of compact operators on X to itself. We define the essential spectrum of the operator A by

$$\sigma_{\rm ess}(A) = \bigcap_{K \in \mathcal{K}(X)} \sigma(A+K).$$

It is well known that if A is a self-adjoint operator on a Hilbert space, the essential spectrum of A is the set of limit points of the spectrum of A, i.e., all points of the spectrum except isolated eigenvalues of finite multiplicity, see [29, 30]. Let  $\mathcal{T} = (\mathcal{V}, m, \mathcal{E}, \mathcal{R})$  be a weighted triangulation. Note that  $\mathcal{L}_{2,\text{skew}}$  is non-negative symmetric operator on  $\mathcal{C}^c_{\text{skew}}(\mathcal{R})$ . We consider the quadratic form

$$q(f,g) = \langle f, \mathcal{L}_{2.\text{skew}} g \rangle + \langle f, g \rangle$$

on  $C^c_{\text{skew}}(\mathcal{R}) \times C^c_{skew}(\mathcal{R})$ . Let  $\mathcal{H}_1$  be the completion of  $C^c_{\text{skew}}(\mathcal{R})$  under the norm

$$||f||_q = \sqrt{\langle \mathcal{L}_{2,\text{skew}} f, f \rangle + ||f||^2}.$$

We define the Friedrichs extension  $\mathcal{L}_{2,\mathrm{skew}}^{\mathcal{F}}$  of  $\mathcal{L}_{2,\mathrm{skew}}$  by:

i) A vector f is in domain  $\mathcal{D}(\mathcal{L}_{2,\mathrm{skew}}^{\mathcal{F}})$  if and only if  $f \in \mathcal{H}_1$  and  $\mathcal{C}_{\mathrm{skew}}^c(\mathcal{R}) \ni g \longmapsto \langle f, \mathcal{L}_{2,\mathrm{skew}}g \rangle + \langle f, g \rangle$  extends to a norm continuous function on  $\ell_{\mathrm{skew}}^2(\mathcal{R})$ . (ii) For each  $f \in \mathcal{D}(\mathcal{L}_{2,\mathrm{skew}}^{\mathcal{F}})$  there is a unique  $u_f$  such that  $\langle f, \mathcal{L}_{2,\mathrm{skew}}g \rangle + \langle f, g \rangle = \langle u_f, g \rangle$  by Riesz' Theorem. The Friedrichs extension of  $\mathcal{L}_{2,\mathrm{skew}}$ , is given by  $\mathcal{L}_{2,\mathrm{skew}}^{\mathcal{F}}f = u_f - f$ . It is self-adjoint extension of  $\mathcal{L}_{2,\mathrm{skew}}$ , e.g. see [25, Theorem X.23].

**Theorem 6.1.** Let  $\mathcal{T} = (\mathcal{V}, m, \mathcal{E}, \mathcal{R})$  be a weighted triangulation and let  $\mathcal{F}_0 = \{\mathcal{K} \subset \mathcal{F} : \mathcal{K} \text{ finite}\}$ . Then,

$$\inf \sigma(\mathcal{L}_{2,\text{skew}}^{\mathcal{F}}) \leq \inf_{(x,y,z) \in \mathcal{F}} \mathcal{R}(x,y,z) \Big( \frac{1}{\mathcal{E}(x,y)} + \frac{1}{\mathcal{E}(y,z)} + \frac{1}{\mathcal{E}(z,x)} \Big).$$

and

$$\inf \sigma_{\mathrm{ess}}(\mathcal{L}^{\mathcal{F}}_{2,\mathrm{skew}}) \leq \sup_{\mathcal{K} \subset \mathcal{F}_0} \inf_{(x,y,z) \in \mathcal{K}^c} \mathcal{R}(x,y,z) (\frac{1}{\mathcal{E}(x,y)} + \frac{1}{\mathcal{E}(y,z)} + \frac{1}{\mathcal{E}(z,x)}).$$

In particular, if  $\mathcal{T}$  is a simple triangulation then  $\mathcal{L}_{2,skew}^{\mathcal{F}}$  is not with compact resolvent.

*Proof.* Let  $(x_0, y_0, z_0) \in \mathcal{F}$  and let

$$f = \frac{\delta_{x_0, y_0, z_0} + \delta_{y_0, z_0, x_0} + \delta_{z_0, x_0, y_0} - \delta_{z_0, y_0, x_0} - \delta_{x_0, z_0, y_0} - \delta_{y_0, x_0, z_0}}{\sqrt{\mathcal{R}(x_0, y_0, z_0)}}.$$

Then ||f|| = 1 and

$$\langle f, \mathcal{L}_{2,\text{skew}} f \rangle = \mathcal{R}(x_0, y_0, z_0) \left( \frac{1}{\mathcal{E}(x_0, y_0)} + \frac{1}{\mathcal{E}(y_0, z_0)} + \frac{1}{\mathcal{E}(z_0, x_0)} \right)$$

Applying [20, Proposition 3], the result follows.

#### 7. Application to the study of the adjacency matrix

7.1. **Adjacency matrix.** The adjacency matrix has some important implications for example it solves the equation of heat, see [5]. Let  $\mathcal{G} = (\mathcal{V}, m, \mathcal{E})$  be a weighted graph. We define the set of 0-cochains on  $\mathcal{V}$  by

$$\mathcal{C}(\mathcal{V}) = \{ f : \mathcal{V} \longrightarrow \mathbb{C} \}.$$

We denote by  $C^c(\mathcal{V})$  the 0-cochains with finite support in  $\mathcal{V}$ . We associate a Hilbert space to  $\mathcal{V}$ :

$$\ell^2(\mathcal{V}) = \Big\{ f \in \mathcal{C}(\mathcal{V}) \text{ such that } \|f\|^2 = \sum_{x \in \mathcal{V}} m(x) |f(x)|^2 < \infty \Big\}.$$

The associated scalar product is given by

$$\langle f,g\rangle = \sum_{x\in\mathcal{V}} m(x)\overline{f(x)}g(x), \text{ for } f,\ g\in\ell^2(\mathcal{V}).$$

We define the adjacency matrix:

$$\mathcal{A}_{\mathcal{G}}(f)(x) = \frac{1}{m(x)} \sum_{y \in \mathcal{V}} \mathcal{E}(x, y) f(y), \ f \in \mathcal{C}^{c}(\mathcal{V}).$$

It is symmetric and thus closable. We denote its closure by the same symbol. When m=1, we have that  $\mathcal{A}_{\mathcal{G}}$  is unbounded if and only if it is unbounded from above and if and only if the degree is unbounded, see [14].

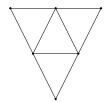
#### 7.2. Triangular graph.

**Definition 7.1.** Let  $\mathcal{T} = (\mathcal{V}, m, \mathcal{E}, \mathcal{R})$  be a weighted triangulation. The triangular graph of  $\mathcal{T}$  is the graph  $\widehat{\mathcal{T}} = (\widehat{\mathcal{V}}, \widehat{m}, \widehat{\mathcal{E}})$  where  $\widehat{\mathcal{V}} = \mathcal{F}$ ,  $\widehat{m} = 1$  and

$$\widehat{\mathcal{E}}((x_0, y_0, z_0), (x, y, z)) = \sqrt{\mathcal{R}(x_0, y_0, z_0)} \left( \frac{\sqrt{\mathcal{R}(x, y, z)}}{\mathcal{E}(x, y)} 1_{x = x_0, y = y_0} \right)$$

$$+\frac{\sqrt{\mathcal{R}(x,y,z)}}{\mathcal{E}(y,z)}1_{y=y_0,\ z=z_0}+\frac{\sqrt{\mathcal{R}(x,y,z)}}{\mathcal{E}(z,x)}1_{z=z_0,\ x=x_0}$$

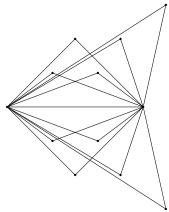
if  $(x_0, y_0, z_0) \neq (x, y, z)$  and 0 otherwise.

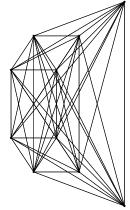


A triangulation  $\mathcal{T}$

**Remark 7.2.** Let  $\mathcal{T} = (\mathcal{V}, m, \mathcal{E}, \mathcal{R})$  be a triangulation. The adjacency matrix on  $\widehat{\mathcal{G}}$  is given by

$$\begin{split} \mathcal{A}_{\widehat{\mathcal{G}}}(f)(x_0,y_0,z_0) := \sum_{z \in \mathcal{V}, \ z \neq z_0} \frac{\sqrt{\mathcal{R}(x_0,y_0,z_0)\mathcal{R}(x_0,y_0,z)}}{\mathcal{E}(x_0,y_0)} f(x_0,y_0,z) \\ + \sum_{x \in \mathcal{V}, \ x \neq x_0} \frac{\sqrt{\mathcal{R}(x_0,y_0,z_0)\mathcal{R}(x,y_0,z_0)}}{\mathcal{E}(y_0,z_0)} f(x,y_0,z_0) \\ + \sum_{y \in \mathcal{V}, \ y \neq y_0} \frac{\sqrt{\mathcal{R}(x_0,y_0,z_0)\mathcal{R}(x_0,y,z_0)}}{\mathcal{E}(z_0,x_0)} f(x_0,y,z_0) \end{split}$$

for all  $f \in \mathcal{C}^c(\widehat{\mathcal{V}})$ .

**Proposition 7.3.** Let  $\mathcal{T} = (\mathcal{V}, m, \mathcal{E}, \mathcal{R})$  be a weighted triangulation. Then  $\mathcal{L}_{2,\text{sym}}$  is unitarily equivalent to

$$\mathcal{A}_{\widehat{\mathcal{G}}} + \mathcal{Q}(V)$$

where

$$V(x_0, y_0, z_0) = \frac{\mathcal{E}(x_0, y_0, z_0)}{\mathcal{R}(x_0, y_0)} + \frac{\mathcal{R}(x_0, y_0, z_0)}{\mathcal{E}(y_0, z_0)} + \frac{\mathcal{R}(x_0, y_0, z_0)}{\mathcal{E}(z_0, x_0)}$$

and Q(V) be the operator of multiplication by V.

*Proof.* Set  $U: \ell^2_{\mathrm{sym}}(\mathcal{R}) \longrightarrow \ell^2(\widehat{\mathcal{V}})$  as the operator given by

$$U(f)(x, y, z) = \sqrt{\mathcal{R}(x, y, z)} f(x, y, z).$$

Notice that

$$U^{-1}(f)(x,y,z) = U^*(f)(x,y,z) = \frac{1}{\sqrt{\mathcal{R}(x,y,z)}} f(x,y,z)$$

for all  $f \in \ell^2(\widehat{\mathcal{V}})$ . Notice now that on  $\mathcal{C}_c(\widehat{\mathcal{V}})$ 

$$U\mathcal{L}_{2,\text{sym}}U^{-1}(f)(x_0, y_0, z_0) = \sum_{t \in \mathcal{V}} \frac{\sqrt{\mathcal{R}(x_0, y_0, z_0)\mathcal{R}(x_0, y_0, t)}}{\mathcal{E}(x_0, y_0)} f(x_0, y_0, t)$$

$$+ \sum_{t \in \mathcal{V}} \frac{\sqrt{\mathcal{R}(x_0, y_0, z_0)\mathcal{R}(y_0, z_0, t)}}{\mathcal{E}(y_0, z_0)} f(y_0, z_0, t)$$

$$+ \sum_{t \in \mathcal{V}} \frac{\sqrt{\mathcal{R}(x_0, y_0, z_0)\mathcal{R}(z_0, x_0, t)}}{\mathcal{E}(z_0, x_0)} f(z_0, x_0, t).$$

Using Remark 7.2, we obtain the result.

**Corollary 7.4.** Let  $\mathcal{T} = (\mathcal{V}, m, \mathcal{E}, \mathcal{R})$  be a weighted 3-partite triangulation. If V is bounded on  $\mathcal{F}$ , then

$$\mathcal{A}_{\widehat{\mathcal{G}}} \ge \sup_{(x,y,z)\mathcal{F}} V(x,y,z).$$

In particular,  $\mathcal{A}_{\widehat{G}} \geq -3$  when  $\mathcal{T}$  is simple.

*Proof.* Since  $\mathcal{L}_{2,\text{sym}}$  is non-negative operator, then

$$\langle \mathcal{A}_{\widehat{\mathcal{G}}}f, f \rangle \ge -3 \|f\|^2$$

for all 
$$f \in \mathcal{C}^c(\widehat{\mathcal{V}})$$

Corollary 7.5. Let  $\mathcal{T} = (\mathcal{V}, m, \mathcal{E}, \mathcal{R})$  be a 3-partite weighted triangulation. Set

$$\mathcal{N}(x, y, z) = 1 + \sum_{r \in \mathcal{V}} \left( d_{\mathcal{E}}(x, y) + d_{\mathcal{E}}(y, z) + d_{\mathcal{E}}(z, x) \right).$$

 $Suppose\ that$ 

$$\sup_{(x,y,z)\in\mathcal{F}} \sum_{r\in\mathcal{F}_{(x,y)}} \frac{1}{\mathcal{E}(x,y)} \mathcal{R}(x,y,r) \mid \mathcal{N}(x,y,r) - \mathcal{N}(x,y,z) \mid^2 < \infty.$$

and V is bounded. Then,  $\mathcal{A}_{\widehat{\mathcal{G}}}$  is essentially self-adjoint on  $\mathcal{C}^c(\widehat{\mathcal{V}})$ .

*Proof.* Combine Proposition 7.3, Theorem 5.3 and Theorem 4.2.  $\Box$ 

#### 7.3. **Geometric Hypothesis.** We recall the two following definitions:

**Definition 7.6.** [1, Definition 8] The graph  $\mathcal{G} := (\mathcal{V}, m, \mathcal{E})$  is  $\chi$ -complete if there exists a increasing sequence of finite set  $(\mathcal{V}_n)_n$  such that  $\mathcal{V} = \bigcup_n \mathcal{V}_n$  and there exist related functions  $\chi_n$  satisfying the following three conditions:

- 1)  $\chi_n \in \mathcal{C}^c(\mathcal{V}), \ 0 \le \chi_n \le 1,$
- 2)  $\chi_n(x) = 1$  if  $x \in \mathcal{V}_n$ ,
- 3)  $\exists C > 0, \ \forall n \in \mathbb{N}, \ x \in \mathcal{V},$

$$\frac{1}{m(x)} \sum_{y \in \mathcal{V}} \mathcal{E}(x, y) |\chi_n(x) - \chi_n(y)|^2 \le C.$$

**Definition 7.7.** [7, Definition 4.2] A weighted triangulation  $\mathcal{T} = (\mathcal{V}, m, \mathcal{E}, \mathcal{R})$ is  $\chi$ -complete, if

- 1)  $\mathcal{G} = (\mathcal{V}, m, \mathcal{E})$  is  $\chi$ -complete.
- 2)  $\exists M > 0, \forall n \in \mathbb{N}, (x,y) \in \mathcal{E}$

$$\frac{1}{\mathcal{E}(x,y)} \sum_{t \in \mathcal{F}_{(x,y)}} \mathcal{R}(x,y,t) |2\chi_n(t) - \chi_n(x) - \chi_n(y)|^2 \le M.$$

We recall the criterion obtained in [7].

**Theorem 7.8.** Let  $\mathcal{T} = (\mathcal{V}, m, \mathcal{E}, \mathcal{R})$  be a  $\chi$ -complete weighted triangulation then  $\mathcal{L}_{2,\text{skew}}$  is essentially self-adjoint on  $\mathcal{C}^c_{\text{skew}}(\mathcal{R})$ .

Corollary 7.9. Let  $\mathcal{T} = (\mathcal{V}, m, \mathcal{E}, \mathcal{R})$  be a  $\chi$ -complete weighted triangulation. If  $\mathcal{T}$  is tri-partite then  $\mathcal{A}_{\widehat{G}}$  is essentially self-adjoint on  $\mathcal{C}^c(\widehat{\mathcal{V}})$ .

*Proof.* Combine Proposition 7.3, Theorem 4.2 and Theorem 7.8.

#### 8. Examples

8.1. Book-like triangulation. We recall the definition of 1-dimensional decomposition given in [6] for the case of graphs.

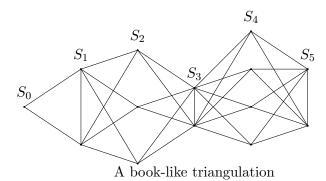
**Definition 8.1.** A 1-dimensional decomposition of the graph  $\mathcal{G} = (\mathcal{V}, m, \mathcal{E})$ is a family of finite sets  $(S_n)_{n\in\mathbb{N}}$  which forms a partitions of  $\mathcal{V}$ , that is  $V = \bigcup_{n \in \mathbb{N}} S_n$ , and such that for all  $x \in S_n$ ,  $y \in S_m$ ,

$$\mathcal{E}(x,y) > 0 \Longrightarrow |n-m| \le 1$$

The following definition is introduced in [7].

**Definition 8.2.** Let  $\mathcal{T} := (\mathcal{V}, m, \mathcal{E}, \mathcal{R})$  be a weighted triangulation and  $(S_n)_{n\in\mathbb{N}}$  a 1-dimensional decomposition of the graph  $\mathcal{G}=(\mathcal{V},m,\mathcal{E})$ . We say that  $\mathcal{T}$  is a book-like triangulation if

- 1)  $\sharp S_0 = 1$ ,  $\sharp S_{2n+1} = 2$  and  $\sharp (S_{2n+1}^2 \cap \mathcal{E}) = 1$ , for all  $n \in \mathbb{N}$ . 2)  $x, y \in S_{2n+2} \Longrightarrow \mathcal{E}(x,y) = 0$ ,
- 3)  $\forall x \in S_{2n+1}, \mathcal{N}_{\mathcal{G}}(x) = S_{2n} \cup S_{2n+2}.$



We recall [7, Proposition 6.5]:

**Proposition 8.3.** Let  $\mathcal{T}$  be a simple book-like triangulation. Assume that

(2) 
$$n \longmapsto \frac{\sharp S_{2n}}{\sharp S_{2(n+1)}} \in \ell^1(\mathbb{N}).$$

Then,  $\mathcal{L}_{2,\text{skew}}$  is not essentially self-adjoint on  $\mathcal{C}^c_{\text{skew}}(\mathcal{R})$ .

**Corollary 8.4.** Let  $\mathcal{T} = (\mathcal{V}, m, \mathcal{E}, \mathcal{R})$  be a simple book-like triangulation satisfying (2). Then,  $\mathcal{A}_{\widehat{G}}$  is not essentially self-adjoint on  $C^c(\widehat{\mathcal{V}})$ .

Proof. Set  $S_0 = \{x_0^0\}$ ,  $S_{2n+1} = \{x_n^0, x_n^1\}$ ,  $\mathcal{V}_0 = \cup_n S_{2n}$ ,  $\mathcal{V}_1 = \cup_n \{x_n^0 : n \in \mathbb{N}\}$  and  $\mathcal{V}_2 = \cup_n \{x_n^1 : n \in \mathbb{N}\}$ . Then,

$$\mathcal{V} = \mathcal{V}_0 \cup \mathcal{V}_1 \cup \mathcal{V}_2 \text{ and } \mathcal{E} \cap (\mathcal{V}_0^2 \cup \mathcal{V}_1^2 \cup \mathcal{V}_2^2) = \emptyset.$$

So,  $\mathcal{T}$  is tri-partite. Using Theorem 4.2, Proposition 7.3 and Proposition 8.3, the result holds.

8.2. **Triangular anti-tree.** Let  $\mathcal{T} = (\mathcal{V}, m, \mathcal{E}, \mathcal{R})$  be a weighted triangulation. The sphere of radius  $n \in \mathbb{N}$  around a vertex  $v \in \mathcal{V}$  is the set

$$S_n(v) := \{ w \in \mathcal{V} : d_{\mathcal{V}}(v, w) = n \}.$$

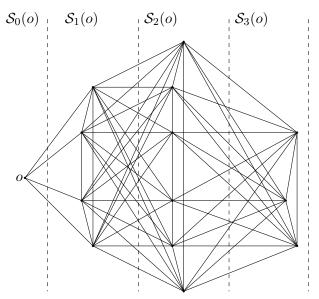
We recall that  $C_n$  denotes the n-cycle graph, i.e.  $\mathcal{V} = \mathbb{Z}/n\mathbb{Z}$ , where  $\mathcal{E}(x,y) > 0$  if and only if |x-y| = 1. Let  $\mathcal{G}(\mathcal{S}_n(o)) = (\mathcal{S}_n(v), \mathcal{E}')$  where  $\mathcal{E}' = \mathcal{E} \mid_{\mathcal{S}_n(v) \times \mathcal{S}_n(v)}$ .

**Definition 8.5.** Let  $\mathcal{T} = (\mathcal{V}, m, \mathcal{E}, \mathcal{R})$  be a weighted triangulation. We say that  $\mathcal{T}$  is anti-tree if there exists a vertex  $o \in \mathcal{V}$  such that

1) For all  $n \in \mathbb{N}^*$  and  $v \in \mathcal{S}_n(o)$ , we have

$$\mathcal{N}_{\mathcal{G}}(v) \setminus \mathcal{S}_n(o) = \mathcal{S}_{n-1}(o) \cup \mathcal{S}_{n+1}(o).$$

2) For all  $n \in \mathbb{N}^*$ ,  $\mathcal{G}(\mathcal{S}_n(o)) \simeq \mathcal{C}_{\mathsf{tl}\mathcal{S}_n(o)}$ .



An triangular anti-tree with spheres  $S_0(o)$ ,  $S_1(o)$ ,  $S_2(o)$ ,  $S_3(o)$ .

**Theorem 8.6.** Let  $\mathcal{T} = (\mathcal{V}, m, \mathcal{E}, \mathcal{R})$  be a simple triangular anti-tree whose root in o. Set  $s_n = \sharp \mathcal{S}_n(o)$  and assume that

(3) 
$$n \longmapsto \frac{s_n^2}{s_{n+2}} \in \ell^1(\mathbb{N}).$$

Then  $\mathcal{L}_{2,\mathrm{sym}}$  does not essentially self-adjoint on  $\mathcal{C}^c_{\mathrm{sym}}(\mathcal{R})$ .

*Proof.* Set  $f \in \ell^2_{\text{sym}}(\mathcal{F}) \setminus \{0\}$  such that  $f \in \text{ker}(\mathcal{L}^*_{2,\text{sym}} + i)$  and such that f is constant on  $\mathcal{S}_n \times \mathcal{S}^2_{n+1} \cup \mathcal{S}^2_n \times \mathcal{S}_{n+1}$ ,  $n \in \mathbb{N}^*$ . We denote the constant value by  $C_n$ . It takes the value 0 on  $\mathcal{S}^2_n$ . We have the following equation:

$$(s_n + 4 + i)C_n + s_{n+2}C_{n+1} = 0.$$

Therefore,

$$||f|_{\mathcal{S}_{n+1} \times \mathcal{S}_{n+2}^2}||^2 = ||f|_{\mathcal{S}_{n+1}^2 \times \mathcal{S}_{n+2}}||^2$$

$$= \frac{1}{6} s_{n+2} s_{n+1} |C_{n+1}|^2$$

$$\leq \frac{|s_n + 4 + i|^2}{s_n s_{n+2}} ||f|_{\mathcal{S}_n \times \mathcal{S}_{n+1}^2}||^2.$$

Since  $\lim_{n\to\infty} \frac{s_n^2}{s_{n+2}} = 0$ , we get by induction:

$$M := \sup_{n \in \mathbb{N}^*} \|f|_{\mathcal{S}_n \times \mathcal{S}_{n+1}^2}\|^2 < \infty.$$

Then, we have

$$||f|_{S_{n+1} \times S_{n+2}^2}||^2 \le M \frac{|i+4+s_n|}{s_n s_{n+2}}.$$

From Eq. (3), we conclude that  $f \in \ell^2_{\text{sym}}(\mathcal{F})$ . Using [25, Theorem X.36], we conclude that  $\mathcal{L}_{2,\text{sym}}$  is not essentially self-adjoint.

Corollary 8.7. Let  $\mathcal{T} = (\mathcal{V}, m, \mathcal{E}, \mathcal{R})$  be a simple triangular anti-tree satisfying (3). Then,  $\mathcal{A}_{\widehat{G}}$  is not essentially self-adjoint on  $C^c(\widehat{\mathcal{V}})$ .
