# Lipschitz-Killing curvatures of excursion sets for two dimensional random fields

#### Abstract

In the present paper we study three geometric characteristics for the excursion sets of a two dimensional stationary random field. First, we show that these characteristics can be estimated without bias if the considered field satisfies a kinematic formula, this is for instance the case for fields that are given by a function of smooth Gaussian fields or for some shot noise fields. By using the proposed estimators of these geometric characteristics, we describe some inference procedures for the estimation of the parameters of the considered field. An extensive simulation study illustrates the performances of each estimator. Then, we use one of the previous estimators to build a test to determine whether a given field is Gaussian or not when compared to various alternatives. The test is based on a sparse information, *i.e.*, the excursion sets for two different levels of the considered field. Finally, this test is adapted and applied in a real-data case: synthesized 2D digital mammograms.

# 1 Introduction

There is an abundant literature on parameters estimation and tests for two dimensional stationary random fields. Inference methods and tests usually rely on the estimation of the covariance function and/or on the estimation of the finite dimensional distribution of the field, see [11], [23] or [22] among others. In the present paper, we have a completely different approach based on the geometry of the excursion sets of the field above a fixed level, considering the random field as a random surface. This perspective is not new, some famous precursors are for instance Longuet-Higgins [20], Wschebor [29] or Lindgren [19] who mainly worked on the modeling of sea waves. Let us also mention two major books on this topics, [1] and [3].

The originality of the present study is threefold. First, we use a very sparse information on the field, namely excursion sets above one or two levels, to recover global characteristics of the considered random field. Therefore, the inference methods we propose rely on the observation of black and white images (see e.g. the second and third images of the first row of Figures 1, 3, 5, 7 and 8). A similar point of view is adopted in [9], [13] and [5] where tests and parameter estimation are performed from the observation of level sets or excursion sets. See also [10] that can be considered as a preliminary study for this work. Our second asset is the joint use of several Lipschitz-Killing (LK) curvatures for a given excursion set. In our bivariate framework, there are three LK curvatures available. Roughly speaking, they are the surface area, the perimeter and the Euler characteristic of the excursion set. This joint observation allows us to get unbiased estimators for the expected values of the LK curvatures of the excursion sets, solving a triangular system. Moreover, each of these three functionals carry different information on the geometry and the topology of the excursion sets. Intuitively, the surface area is related to the occupation density, the perimeter with the regularity and the Euler characteristic with the connectivity of the considered

surface. It is then worth to take all of them into account in order to build more efficient tools. In [10] only the Euler characteristic is used and in [9], [6] and [5], only the length of the level sets is taken into account, while several limit theorems are obtained for the area in [8] and [26]. Note that in [13], only the Euler characteristic of excursion sets is involved, but looking simultaneously at the intersections of excursion sets with rectangles and segments is another way to get additional information. Considering all the LK curvatures at the same time is made possible thanks to recent tools developed in several papers such as [14], [15], [21] or [7], dealing with different aspects of the question.

Finally, the third key point of our paper is to gather in the same study smooth Gaussian type fields and shot noise fields, which are archetypes of non continuous fields. A shot noise field is a multi dimensional extension of one dimensional models such as compound Poisson processes. It is obtained by throwing random shapes at random locations and counting how many shapes cover each point of the space with eventually random weights. Those models are very popular since explicit computations can (sometimes) be performed and simulations are rather simple. They are natural alternatives to Gaussian fields both for theoretical and applicative purposes. That is why we focus our study on providing tools and methods that can be applied to both Gaussian type and shot noise fields. The same objective can be found in the following papers [6] and [7], which have also inspired the present study.

Outline of the paper. The paper is organized as follows. In the remaining of this section we define the three objects of interest, *i.e.*, the Lipschitz-Killing densities for the excursion set of a two dimensional random field. Section 2 is devoted to the study of unbiased estimators of these LK densities from the observation of one excursion set. We examine a wide range of random fields, namely fields of Gaussian type and shot noise fields. Moreover, we show how the knowledge of the LK densities permit to recover and infer on parameters of the considered fields. The problem of the consistency of the proposed estimators is studied, when it is possible. Furthermore, their performances are numerically analyzed. In Section 3 we build a test to detect whether a given field is Gaussian or not based on the knowledge of two excursion sets corresponding to two different levels. A variant of this test is put into practice in Section 4 on a real-data study by using synthesized 2D digital mammograms provided by GE Healthcare Life Sciences, department *Mammography*. Finally, an Appendix section gathers the proofs of the technical results.

#### 1.1 Lipschitz-Killing densities of excursion sets

There are three additive functionals,  $\mathcal{L}_j$  for j=0,1,2, defined on subsets of Borelians in  $\mathbb{R}^2$  that are extensively used in the literature. Depending on the mathematical domain, they are called either intrinsic volumes, or Minkowski functionals or Lipschitz-Killing curvatures. Roughly speaking, for A a Borelian set in  $\mathbb{R}^2$ ,  $\mathcal{L}_0(A)$  stands for the Euler characteristic of A,  $\mathcal{L}_1(A)$  for the half perimeter of the boundary of A and  $\mathcal{L}_2(A)$  is equal to the area of A, *i.e.* the two-dimensional Lebesgue measure.

All over the paper, we will denote by  $|\cdot|$  the two-dimensional Lebesgue measure of any Borelian set in  $\mathbb{R}^2$  and by  $|\cdot|_1$  its one-dimensional Hausdorff measure. In particular, when T is a bounded rectangle in  $\mathbb{R}^2$  with non empty interior,

$$\mathcal{L}_0(T) = 1, \quad \mathcal{L}_1(T) = \frac{1}{2} |\partial T|_1, \quad \mathcal{L}_2(T) = |T|$$
 (1)

where  $\partial T$  stands for the frontier of the set T. The rest of this section is dedicated to precisely define the Lipschitz-Killing (LK) curvatures of excursion sets as well as the associated LK densities.

Let T be a bounded rectangle in  $\mathbb{R}^2$  with non empty interior and u be a real number. For X a real-valued stationary random field defined on  $\mathbb{R}^2$ , we consider the excursion set within T above level u:

$$\{t \in T : X(t) \ge u\} = T \cap E_X(u), \text{ where } E_X(u) := X^{-1}([u, +\infty)).$$

We are interested in the mean of the three LK curvatures of the excursion set, assuming they are well defined. The case of the area  $\mathcal{L}_2$  is particularly easy to handle with. Actually, since X is stationary,

Fubini's Theorem gives immediately

$$\mathbb{E}\left[\left|T \cap E_X(u)\right|\right] = |T| \, \mathbb{P}(X(0) \ge u).$$

This formula is valid without any further assumption on X, whereas the existence and the exact value of the two other LK curvatures is more involving. In particular it is often needed to make strong regularity assumptions on the field in order that one can consider the LK curvatures of its excursion sets.

In the following definitions, we introduce positive reach sets and curvature measures for those sets (see [27], based on the seminal work of Federer [12]).

**Definition 1.1** (Positive reach sets). For a set  $A \subset \mathbb{R}^2$  and r a positive real number, let  $A_r = \{x \in \mathbb{R}^2 : d(A,x) \leq r\}$ . Then, the reach of A is defined as

$$reach(A) := \sup\{r \ge 0 : \forall y \in A_r, \exists \ a \ unique \ x \in A \ nearest \ to \ y\}.$$

The set A is said to have positive reach, if reach(A) > 0.

Intuitively, A is a positive reach set if one can roll a ball of positive radius along the exterior boundary of A keeping in touch with A. Let us remark that positive reach sets are necessarily closed sets. Moreover, convex sets in  $\mathbb{R}^2$  and compact  $C^2$  submanifolds of  $\mathbb{R}^2$  have positive reach.

**Definition 1.2** (Curvature measures). Let A be a positive reach set. Its curvature measures  $\Phi_i(A, \cdot)$ , for i = 0, 1, 2, are defined for any Borel set  $U \subset \mathbb{R}^2$  by

$$\Phi_0(A,U) = \frac{1}{2\pi} TC(\partial A, U), \quad \Phi_1(A,U) = \frac{1}{2} |\partial A \cap U|_1 \quad and \quad \Phi_2(A,U) = |A \cap U|,$$

where  $TC(\partial A, U)$  denotes the integral over U of the curvature along the positively oriented curve  $\partial A$ .

For a positive reach set A such that  $\partial A \subset U$ , let us note that  $\Phi_0(A, U)$  coincides with the Euler characteristic of A. For more details on the total curvature TC, we refer to Def.9 and Theorem 31 in [27] or to Definition 1 and Theorem 1 in [7].

Since the curvature measures  $\Phi_i(A, \cdot)$  are additive functionals (with respect to A), it is natural to deal with unions of positive reach sets. Therefore, we introduce the next definition (see [27] again).

**Definition 1.3** (UPR class). Let UPR be the class of locally finite unions of sets with positive reach.

In the sequel, we are interested in the curvature measures of the excursions above the level u of the random field X, namely we consider  $A = T \cap E_X(u)$ . Note that the random set  $T \cap E_X(u)$  belongs to the UPR class a.s. when, for instance, the random field X is of class  $C^2$  a.s., (actually, in this case the random set  $T \cap E_X(u)$  has positive reach, as  $E_X(u)$  is a  $C^2$  submanifold of  $\mathbb{R}^2$  and its intersection with T provides compactness), or when  $E_X(u)$  is locally given by a finite union of disks.

In this setting, one can define the LK curvatures and the associated densities of excursion sets.

**Definition 1.4** (LK curvatures and associated densities for UPR excursion sets). Let X be a stationary isotropic random field defined on  $\mathbb{R}^2$  and let T be a bounded rectangle in  $\mathbb{R}^2$  with non empty interior. Assuming that  $T \cap E_X(u)$  is a UPR set, define the LK curvatures of the excursion set  $E_X(u)$  within T by

$$C_i(X, u, T) := \Phi_i(T \cap E_X(u), T), \text{ for } i = 0, 1, 2.$$

Define the normalized LK curvatures by

$$C_i^{/T}(X, u) := \frac{C_i(X, u, T)}{|T|}, \text{ for } i = 0, 1, 2,$$
 (2)

and, assuming the limits exist, the associated LK densities are

$$C_i^*(X, u) := \lim_{T \nearrow \mathbb{R}^2} \mathbb{E}[C_i^{/T}(X, u)], \text{ for } i = 0, 1, 2,$$
 (3)

where  $\lim_{T \nearrow \mathbb{R}^2}$  stands for the limit along any sequence of bounded rectangles that grows to  $\mathbb{R}^2$ .

As already noticed, the case i = 2 in the above definition boils down to

$$C_2^*(X, u) = \mathbb{E}[C_2^{/T}(X, u)] = \mathbb{P}(X(0) \ge u). \tag{4}$$

# 2 Kinematic formulas and inference

From now on, all the rectangles T in  $\mathbb{R}^2$  are bounded with non empty interior. Notation  $T \nearrow \mathbb{R}^2$  stands for the limit along any sequence of bounded rectangles that grows to  $\mathbb{R}^2$ . Then,  $\frac{|\partial T|_1}{|T|}$  always goes to 0 as  $T \nearrow \mathbb{R}^2$ .

In this section, we build unbiased estimators of the the asymptotic LK densities in (3), for  $i \in \{0,1\}$ . The problem is more involved than it appears. Actually, a naive approach is to consider (2), that can be easily computed from  $T \cap E_X(u)$ , as an estimator of (3). But, the main difference between theses quantities comes from the boundary terms. Indeed, we can write

$$C_i(X,T,u) = \Phi_i(T \cap E_X(u),T) = \Phi_i(E_X(u),\mathring{T}) + \Phi_i(T \cap E_X(u),\partial T),$$

where, loosely speaking,  $|T|^{-1}\mathbb{E}(\Phi_i(E_X(u),\mathring{T}))$  contains all the information on  $C_i^*(X,u)$  and boundary terms involving  $\partial T$  is blurring the estimation for fixed |T|. However, as  $|\partial T|_1/|T| \to 0$  when  $T \nearrow \mathbb{R}^2$ , this bias term vanishes. Hereafter, we derive the exact relations between (2) and (3) which are valid for a wide range of fields, that are called standard in the sequel, and permit to build unbiased estimators of  $C_i^*(X,u)$ ,  $i \in \{0,1\}$ . Starting from those estimators, we are able to infer some parameters of the random field X.

# 2.1 Kinematic formulas

We use kinematic formulas to get unbiased estimators of  $C_i^*(X, u)$ ,  $i \in \{0, 1\}$  as it is usual to proceed in convex geometry. To this aim, we first introduce the definition of a standard random field.

**Definition 2.1** (Standard random field). Let X be a stationary isotropic random field defined on  $\mathbb{R}^2$ . We say that X is standard at level  $u \in \mathbb{R}$  if  $T \cap E_X(u)$  is UPR for any rectangle T in  $\mathbb{R}^2$ , if  $C_i^*(X, u)$ , for i = 0, 1 in (3) exist, and if

$$\mathbb{E}[C_0^{/T}(X,u)] = C_0^*(X,u) + \frac{1}{2\pi}C_1^*(X,u)\frac{|\partial T|_1}{|T|} + C_2^*(X,u)\frac{1}{|T|},$$

$$\mathbb{E}[C_1^{/T}(X,u)] = C_1^*(X,u) + C_2^*(X,u)\frac{|\partial T|_1}{|T|}.$$

By using (4), no bias correction is necessary for estimating  $C_2^*(X, u)$  whatever the field X. It explains why we do not include a third constraint in the definition of a standard field. The first example of standard field is given by the large class of fields of Gaussian type defined below.

**Definition 2.2** (Fields of Gaussian type). We call field of Gaussian type any random field  $X = F(\mathbf{G})$ , where for some  $k \in \mathbb{N}^*$ ,  $F : \mathbb{R}^k \to \mathbb{R}$  is a  $C^2$  function and  $\mathbf{G} = (G_1, \dots, G_k)$  is a family of i.i.d. Gaussian random fields defined on  $\mathbb{R}^2$  that are  $C^3$ , stationary, isotropic, centered, with unit variance, and such that  $\operatorname{Var} G'_i(0) = \lambda I_2$  with some  $\lambda > 0$ .

**Proposition 2.3.** Let X be a field of Gaussian type as in Definition 2.2, then X is standard at any level  $u \in \mathbb{R}$ .

*Proof.* The Gaussian kinematic formula provides the mean LK curvatures of excursion sets of X within a rectangle T (see e.g. Theorem 15.9.5 in [1] or Theorem 4.8.1 in [2]), for  $u \in \mathbb{R}$  and i = 0, 1, 2,

$$\mathbb{E}\left[C_{i}(X,T,u)\right] = \sum_{l=0}^{2-i} \begin{bmatrix} i+l \\ l \end{bmatrix} (2\pi)^{-l/2} \lambda^{l/2} \mathcal{M}_{l}(X,u) \mathcal{L}_{i+l}(T)$$
 (5)

where  $\mathcal{L}_j(T)$ , j=0,1,2 are defined in (1),  $\begin{bmatrix} i+l \\ l \end{bmatrix} = \binom{i+l}{l} \frac{\omega_{l+i}}{\omega_l \omega_i}$  with  $\omega_k$  the Lebesgue measure of the k-dimensional unit ball ( $w_0=1, w_1=2$  and  $w_2=\pi$ ), and, following Formula (3.5.2) in [2], the coefficients  $\mathcal{M}_l(X,u)$ , l=0,1,2 are obtained having an expansion in  $\rho$  at order 2 of the probability that  $\mathbf{G}(0)$  belongs to

$$Tube(F,\rho):=\{x\in\mathbb{R}^k \text{ such that } \operatorname{dist}(x,F^{-1}([u,\infty)))\leq\rho\},$$

as  $\rho \to 0^+$ . Namely, the expansion is given by

$$\mathbb{P}\left(\mathbf{G}(0) \in Tube(F,\rho)\right) = \mathcal{M}_0(X,u) + \rho \mathcal{M}_1(X,u) + \frac{1}{2}\rho^2 \mathcal{M}_2(X,u) + O(\rho^3). \tag{6}$$

Dividing Equation (5) by |T| and letting T grow to  $\mathbb{R}^2$  imply the existence of the LK densities and

$$C_0^*(X, u) = (2\pi)^{-1} \lambda \mathcal{M}_2(X, u), \quad C_1^*(X, u) = (\pi/2)^{1/2} \lambda^{1/2} \mathcal{M}_1(X, u).$$
 (7)

Injecting these in (5) and dividing by |T| we obtain that X is standard at level u.

Another way to get standard fields relies on convex geometry tools especially developed for Boolean fields with convex grains.

**Proposition 2.4.** Let X be a stationary isotropic random field defined on  $\mathbb{R}^2$  such that for  $u \in \mathbb{R}$ , its excursion set  $E_X(u)$  satisfies:

- a.s.  $T \cap E_X(u)$  is the union of a finite number  $N(T \cap E_X(u))$  of compact convex sets with non empty interior,
- $\mathbb{E}\left(2^{N(T\cap E_X(u))}\right) < +\infty.$

Then, X is standard at level u.

*Proof.* First let us note that by stationarity and isotropy of X we have that  $E_X(u)$  is a stationary and isotropic random set and the assumptions imply that  $E_X(u)$  is a standard random set in the sense of Definition 9.2.1 of [25]. Following the notations of this book,  $C_i(X, u, T) = V_i(T \cap E_X(u))$  with  $V_i$  the so-called intrinsic volume and  $C_i^*(X, u) = \overline{V_i}(E_X(u))$  with  $\overline{V_i}$  the intrinsic density. It holds according to Theorem 9.4.1 of [25], for  $i \in \{0, 1, 2\}$ ,

$$\mathbb{E}(C_i(X, u, T)) = \sum_{k=i}^{2} c_i^{k, 2-k+i} C_k^*(X, u) \mathcal{L}_{2-k+i}(T),$$

where, by Equation (5.5) of [25],  $c_0^{0,2}=c_0^{2,0}=c_1^{2,1}=c_1^{1,2}=1$  and  $c_0^{1,1}=\frac{2}{\pi}$ . We deduce that X is standard at level u.

When X is a random field that is standard at level u, we are now able to build unbiased estimators of  $C_i^*(X, u)$ , for i = 0, 1, 2.

**Proposition 2.5** (Unbiased estimators for LK densities). Let  $u \in \mathbb{R}$  and let X be a stationary isotropic random field defined on  $\mathbb{R}^2$  that is standard at level u. Assume we observe  $T \cap E_X(u)$  for T a rectangle in  $\mathbb{R}^2$ . The following quantities are unbiased estimator of  $C_i^*(X, u)$ , i = 0, 1, 2,

$$\widehat{C}_{0,T}(X,u) = C_0^{/T}(X,u) - \frac{|\partial T|_1}{2\pi|T|}C_1^{/T}(X,u) + \left(\frac{1}{2\pi}\left(\frac{|\partial T|_1}{|T|}\right)^2 - \frac{1}{|T|}\right)C_2^{/T}(X,u),\tag{8}$$

$$\widehat{C}_{1,T}(X,u) = C_1^{/T}(X,u) - \frac{|\partial T|_1}{|T|} C_2^{/T}(X,u), \tag{9}$$

$$\widehat{C}_{2,T}(X,u) = C_2^{/T}(X,u). \tag{10}$$

In the following two sections we analyse how the unbiased estimators in Proposition 2.5 for standard fields can be used for parameter inference purposes. Section 2.2 is devoted to fields of Gaussian type whereas Section 2.3 concerns shot-noise fields.

# 2.2 Fields of Gaussian type

#### 2.2.1 Gaussian field

We start by considering the simplest case of Gaussian type field, *i.e.* with notation of Definition 2.2, k = 1 and  $F: x \mapsto x$ , then  $X = G_1 := G$ . To compute the LK densities, we use expansion (6) to write out

$$\mathbb{P}\Big(G(0) \ge u - \rho\Big) = \psi(u - \rho) = \psi(u) - \rho\psi'(u) + \frac{1}{2}\rho^2\psi''(u) + O(\rho^3),$$

with  $\psi$  being the Gaussian tail distribution with zero mean and unit variance. Hence, one easily gets

$$C_0^*(G, u) = (2\pi)^{-3/2} \lambda u e^{-u^2/2}, \quad C_1^*(G, u) = \frac{1}{2} \lambda^{1/2} e^{-u^2/2}, \quad C_2^*(G, u) = \psi(u),$$
 (11)

where  $\lambda$  denotes the second spectral moment of G as in Definition 2.2.

Parameter estimation. Suppose we observe  $E_G(u)$  for a given level u. Then we can use the unbiased estimators of Proposition 2.5 to propose a consistent estimator for the second spectral moment of a Gaussian field G. Each of the quantities  $C_i(G, u, T)$  satisfies a Central Limit Theorem (CLT) with normalizing term equals to  $|T|^{1/2}$  (see, e.g., [15] or [21]) but, to the best of our knowledge, no joint CLT has been established for these asymptotics. Concerning various levels and/or various disjoint domains, a joint CLT for the Euler characteristic is proved in [10]. To get the asymptotic normality of the estimator of  $\lambda$ , we moreover assume that the Gaussian field G satisfies the following condition.

(A) For any fixed x in  $\mathbb{R}^2$ , the covariance matrix of the random vector (G(x), G'(x), G''(x)) has full rank and r, the covariance function of G, is such that,

$$M_r(x) \to 0$$
 when  $||x|| \to +\infty$  and  $M_r \in L^1(\mathbb{R}^2)$ ,

where 
$$M_r(x) = \max\left(\left|\frac{\partial^{\mathbf{k}}_r}{\partial x^{\mathbf{k}}}(x)\right|; \mathbf{k} = (k_1, k_2) \in \mathbb{N}^2, k_1 + k_2 \le 4\right).$$

**Proposition 2.6** (Spectral moment estimation). Assume that G satisfies condition (A). Consider  $\widehat{C}_{0,T}(G,u)$  the estimator defined in (8) built on the observation  $T \cap E_G(u)$ ,  $u \neq 0$  being fixed. Define the estimator of  $\lambda$ 

$$\widehat{\lambda}_T(u) := \frac{(2\pi)^{3/2}}{u} e^{u^2/2} \widehat{C}_{0,T}(G, u), \quad u \neq 0.$$

Then, it holds that

$$\sqrt{|T|} \left( \widehat{\lambda}_T(u) - \lambda \right) \xrightarrow[T \nearrow \mathbb{R}^2]{d} \mathcal{N}(0, \Sigma(u)), \quad \text{for some} \quad \Sigma(u) < +\infty, \tag{12}$$

where  $\xrightarrow{d}$  stands for the convergence in distribution.

*Proof.* It is sufficient to show that  $\sqrt{|T|}(\widehat{C}_{0,T}(G,u) - C_0^*(G,u)) \xrightarrow{d} \mathcal{N}(0,\Sigma(u))$  for some  $\Sigma(u) < +\infty$ . Decompose this quantity as follows

$$\begin{split} \sqrt{|T|} \big( \widehat{C}_{0,T}(G,u) - C_0^*(G,u) \big) &= \sqrt{|T|} \Big( C_0^{/T}(G,u) - \mathbb{E}[C_0^{/T}(G,u)] \Big) \\ &- \frac{1}{2\pi} \sqrt{|T|} \Big( C_1^{/T}(G,u) - \mathbb{E}[C_1^{/T}(G,u)] \Big) \frac{|\partial T|_1}{|T|} \\ &+ \sqrt{|T|} \Big( C_2^{/T}(G,u) - \mathbb{E}[C_2^{/T}(G,u)] \Big) \left( \frac{1}{2\pi} \frac{|\partial T|_1^2}{|T|^2} - \frac{1}{|T|} \right) \\ &:= I_0(T) + I_1(T) + I_2(T). \end{split}$$

Theorem 4 in [10] leads to  $I_0(T) \xrightarrow[T \nearrow \mathbb{R}^2]{d} \mathcal{N}(0, V(u))$  with a finite asymptotic variance V(u) given by Equation (9) in [10]. Furthermore, the CLT in [15] gives that  $\sqrt{|T|} \left( C_1^{/T}(G, u) - \mathbb{E}[C_1^{/T}(G, u)] \right)$  admits a Gaussian centered limit distribution and therefore  $I_1(T) \xrightarrow{\mathbb{P}} 0$ . Similar arguments hold for  $I_2(T)$ . Finally the convergence of  $\widehat{C}_{0,T}(G,u)$  is established with  $\Sigma(u) = V(u)(2\pi)^3 \frac{e^{u^2}}{u^2}$ .




Figure 1: Gaussian random field as in Section 2.2.1 with covariance  $r(x) = e^{-\kappa^2 \|x\|^2}$ , for  $\kappa = 100/2^{10}$  in a domain of size  $2^{10} \times 2^{10}$  pixels. First row: A realization of a Gaussian random field (left) and two excursion sets for u = 0 (center) and u = 1 (right). Second row:  $\widehat{C}_{0,T}(G,u)$  (left),  $\widehat{C}_{1,T}(G,u)$  (center) and  $\widehat{C}_{2,T}(G,u)$  (right) as a function of the level u. We display the averaged values on M = 100 sample simulations (red stars) and the associated empirical intervals (vertical red lines). Theoretical  $u \mapsto C_0^*(G,u)$ ,  $C_1^*(G,u)$  and  $C_2^*(G,u)$  in (11) are draw in blue lines. We also present  $u \mapsto C_0^{/T}(G,u)$  and  $C_1^{/T}(G,u)$  in green dashed lines. These samples have been obtained using Matlab using circulant embedding matrix.

Numerical illustration. First, Figure 1 displays a realization of a Gaussian random field, two excursion sets and an illustration for the performance of the three estimators  $\widehat{C}_{0,T}(G,u)$ ,  $\widehat{C}_{1,T}(G,u)$  and  $\widehat{C}_{2,T}(G,u)$  in Proposition 2.5, for G with covariance function  $r(x) = e^{-\kappa^2 ||x||^2}$  and second spectral moment  $\lambda = 2\kappa^2$ . Let us remark that the parameter  $\kappa$  is chosen such that  $|T|\kappa^2$  remains bounded, which explains small values of  $\kappa$  and  $\lambda$  in Figure 1. The quantities  $C_0^{/T}(G,u)$ ,  $C_1^{/T}(G,u)$  and  $C_2^{/T}(G,u)$  are computed with the Matlab functions bweuler, bwperim and bwarea, respectively. From a numerical point of view, bweuler and bwarea functions seem very precise contrary to the bwperim function which seems to perform less well. This behavior will be observed also in other random field cases (see, for instance, Figures 7 and 8 in some shot-noise cases). Figure 1 (center) illustrates that  $C_1^{/T}(G,u)$  (green dashed line) does not well approximate  $C_1^*(G,u)$  (blue plain line), especially for small levels u and that the correction induced by (9) (red stars) improves the approximation. In Figure 1 (left), we provide an analogous bias correction for the Euler characteristic by using (8). However in this case, the discrepancy is less evident than in the perimeter case.




Figure 2: Gaussian random field with covariance  $r(x) = e^{-\kappa^2 ||x||^2}$ , for  $\kappa = 100/2^{10}$  in a domain of size  $2^{10} \times 2^{10}$  pixels. Estimate  $\widehat{\lambda}_T(u)$  with associated confidence intervals for M = 100 sample simulations as prescribed by the CLT in (12), for different values of u (left). Theoretical value  $\lambda = 0.019$  is represented by the horizontal line. The empirically estimated variance  $\widehat{\Sigma}(u)$  is displayed for different values of u in the right panel.

In Figure 2 (left), we observe the unbiased estimator  $\widehat{\lambda}_T(u)$  for different values of u. The asymptotic variance  $\Sigma(u)$  in Proposition 2.6 is empirically estimated on M=100 sample simulations (Figure 2, right). This allows us to identify some choices of levels u where the variance is minimum.

#### 2.2.2 Chi-square field

We consider a chi-square random field with k degrees of freedom  $Z_k$  defined with  $Z_k = F(\mathbf{G})$  for  $F : x \in \mathbb{R}^k \to ||x||^2$ , with notations of Definition 2.2. In order to deal with a random field with zero mean and unit variance, we also introduce  $\widetilde{Z}_k$  as

$$\widetilde{Z}_k(t) = \frac{1}{\sqrt{2k}} (Z_k(t) - k), t \in \mathbb{R}^2.$$

Hence,  $\widetilde{Z}_k$  is  $C^3(\mathbb{R}^2)$ , stationary, isotropic, centered, with unit variance, and  $\operatorname{Var} \widetilde{Z}_k'(0) = 2\lambda I_2$ . We assume that  $\widetilde{Z}_k$  is observed on a rectangle  $T \subset \mathbb{R}^2$  through its excursion set above a fixed level u;  $T \cap E_{\widetilde{Z}_k}(u) = T \cap E_{Z_k}(k + u\sqrt{2k})$ . Let us remark that the above excursion is non empty only for a level u such that  $u > -\sqrt{k/2}$ . Moreover, the asymptotic LK densities satisfy

$$C_i^*(\widetilde{Z}_k, u) = C_i^*(Z_k, k + u\sqrt{2k}), \text{ for } j = 0, 1, 2.$$

The  $C_j^*(Z_k,.)$  can be computed using (7) in the framework of Gaussian type fields described previously. Indeed, we have  $Z_k = F(\mathbf{G})$  with  $\mathbf{G} = (G_1, ..., G_k)$  and  $F: x \in \mathbb{R}^k \mapsto ||x||^2$ . Hence,  $F^{-1}([u, +\infty)) = \{x \in \mathbb{R}^k; ||x|| \geq \sqrt{u}\}$  and  $Tube(F, \rho) = \{x \in \mathbb{R}^k; ||x|| \geq \sqrt{u} - \rho\}$ , so that expansion in (6) has to be written with

 $\mathbb{P}\Big(\mathbf{G}(0) \in Tube(F, \rho)\Big) = \mathbb{P}\Big(\sqrt{\chi_k^2} \ge \sqrt{u} - \rho\Big),$ 

where  $\chi_k^2$  stands for a chi-square random variable with k degrees of freedom. We recover the following formulas that can be found, for instance, in [1] Theorem 15.10.1 or in [2] Section 5.2.1:

$$C_0^*(\widetilde{Z}_k, u) = \frac{\lambda}{\pi 2^{k/2} \Gamma(k/2)} (k + u\sqrt{2k})^{(k-2)/2} (u\sqrt{2k} + 1) \exp\left(-\frac{k + u\sqrt{2k}}{2}\right),$$

$$C_1^*(\widetilde{Z}_k, u) = \frac{\sqrt{\pi \lambda}}{2^{(k-1)/2} \Gamma(k/2)} (k + u\sqrt{2k})^{(k-1)/2} \exp\left(-\frac{k + u\sqrt{2k}}{2}\right),$$

$$C_2^*(\widetilde{Z}_k, u) = \mathbb{P}(\chi_k^2 \ge k + u\sqrt{2k}).$$
(13)




Figure 3: Chi-square field as in Section 2.2.2 with 2 degrees of freedom and  $\lambda=0.019$  in a domain of size  $2^{10}\times 2^{10}$  pixels. First row: A realization of a normalized Chi-square random field (left) and two excursion sets for u=0 (center) and u=1 (right). Second row:  $\widehat{C}_{0,T}(\widetilde{Z}_k,u)$  (left),  $\widehat{C}_{1,T}(\widetilde{Z}_k,u)$  (center) and  $\widehat{C}_{2,T}(\widetilde{Z}_k,u)$  (right) as a function of the level u. We display the averaged values on M=100 sample simulations (red stars) and the associated empirical intervals (vertical red lines). Theoretical  $u\mapsto C_0^*(\widetilde{Z}_k,u)$ ,  $C_1^*(\widetilde{Z}_k,u)$  and  $C_2^*(\widetilde{Z}_k,u)$  are draw in blue lines.

These formulas were originally established in [28]. Figure 3 displays a realization of a normalized Chisquare random field  $\widetilde{Z}_k$  with k=2 degrees of freedom, two excursion sets and an illustration for the performance of the three estimators  $\widehat{C}_{0,T}(\widetilde{Z}_k,u)$ ,  $\widehat{C}_{1,T}(\widetilde{Z}_k,u)$  and  $\widehat{C}_{2,T}(\widetilde{Z}_k,u)$ .

**Parameter estimation.** Suppose we observe  $T \cap E_{\widetilde{Z}}(u)$ , the excursion of a centered chi-square field  $\widetilde{Z}$  with unit variance, unknown degree of freedom K and unknown Gaussian second spectral moment  $\lambda$ . Using that for a centered chi-square field with unit variance and k degrees of freedom  $C_2^*(\widetilde{Z},u)$  only depends on k, we propose the following estimator of K:

$$\widehat{K}(u) = \underset{k \in [1, k_{max}]}{\operatorname{arg \, min}} \left| C_2^*(\widetilde{Z}_k, u) - \widehat{C}_{2,T}(\widetilde{Z}, u) \right|, \tag{14}$$

with  $\widehat{C}_{2,T}$  as in (10) and  $k_{max}$  a large positive integer. This estimator can be plugged in  $C_0^*(\widetilde{Z}, u)$  to derive an estimator of the Gaussian second spectral moment of  $\widetilde{Z}$ :

$$\widehat{\lambda}_{T,\widehat{K}(u)}(u) = (2\pi) \frac{\widehat{C}_{0,T}(\widetilde{Z}, u)}{\mathcal{M}_{2,\widetilde{Z}}(\widehat{K}(u), u)},\tag{15}$$

with  $\widehat{C}_{0,T}$  given by (8),  $\widehat{K}(u)$  as in (14) and where  $\mathcal{M}_{2,\widetilde{Z}}(k,u)$  does not depend on  $\lambda$  and is derived from (13)

$$\mathcal{M}_{2,\widetilde{Z}}(k,u) = \frac{1}{\pi 2^{k/2} \Gamma(k/2)} (k + u\sqrt{2k})^{(k-2)/2} (u\sqrt{2k} + 1) \exp\big(-\frac{k + u\sqrt{2k}}{2}\big).$$




Figure 4: Chi-square field as in Section 2.2.2 with 2 degrees of freedom and  $\lambda = 0.019$ . Estimated  $\widehat{K}(u)$  as in Equation (14) (left) and associated  $\widehat{\lambda}_{T,\widehat{K}(u)}(u)$  (right) as in Equation (15). Theoretical chosen values are K=2,  $k_{max}=15$  and  $\lambda=0.019$ . They are represented by horizontal lines.

An illustration of this inference procedure is provided in Figure 4 for a centered chi-square field with K=2 degrees of freedom.

#### 2.2.3 Student field

Following Definition 2.2, let  $k \geq 3$  be an integer and consider  $F: \mathbb{R}^{k+1} \to \mathbb{R}$  as follows,  $x = (x_1, y) \in \mathbb{R} \times \mathbb{R}^k \mapsto F(x) := x_1/\sqrt{\|y\|^{2/k}}$ , then  $\mathcal{T}_k = F(\mathbf{G})$  is a Student random field with k degrees of freedom. Assumption  $k \geq 3$  ensures that all the  $G_i(t)$ , for i = 1, ..., k, cannot vanish at some point  $t \in \mathbb{R}^2$ 

with positive probability. Then,  $\mathcal{T}_k$  is  $C^3(\mathbb{R}^2)$ , stationary, isotropic, centered and  $\operatorname{Var} \mathcal{T}_k(0) = k/(k-2)$ . Furthermore,  $\mathcal{T}_k$  and  $-\mathcal{T}_k$  have the same distribution. In order to deal with a centered and unit variance field, we introduce

$$\widetilde{\mathcal{T}}_k(t) = \sqrt{(k-2)/k} \, \mathcal{T}_k(t), \, t \in \mathbb{R}^2.$$

We again assume that  $\widetilde{\mathcal{T}_k}$  is observed on a rectangle  $T \subset \mathbb{R}^2$  through its excursion set above a fixed level  $u, i.e., T \cap E_{\widetilde{\mathcal{T}_k}}(u) = T \cap E_{\mathcal{T}_k}(u\sqrt{k/(k-2)})$ . Let us remark that the symmetry property of the distribution of  $\mathcal{T}_k$  allows us to only consider levels u that are non-negative. Moreover

$$C_j^*(\widetilde{\mathcal{T}}_k, u) = C_j^*(\mathcal{T}_k, u\sqrt{k/(k-2)}), \ j = 0, 1, 2,$$

and the LK densities are given in the following result.

**Proposition 2.7** (Student LK densities). Let  $k \geq 3$  and  $\widetilde{\mathcal{T}}_k$  be a centered Student random field with unit variance and k degrees of freedom. Then, it holds that

$$C_0^*(\widetilde{\mathcal{T}}_k, u) = \frac{\lambda(k-1)}{4\pi^{\frac{3}{2}}} \frac{u}{\sqrt{k-2}} \frac{\Gamma(\frac{k-1}{2})}{\Gamma(\frac{k}{2})} \left(1 + \frac{u^2}{k-2}\right)^{\frac{1-k}{2}},$$

$$C_1^*(\widetilde{\mathcal{T}}_k, u) = \frac{\sqrt{\lambda}}{2} \left(1 + \frac{u^2}{k-2}\right)^{\frac{1-k}{2}} \quad and \quad C_2^*(\widetilde{\mathcal{T}}_k, u) = \mathbb{P}(Student(k) \ge u\sqrt{k/(k-2)}).$$

The proof of Proposition 2.7 is postponed to Appendix (see Section A.1) as well as the proof of the following remark.

**Remark 2.8.** If  $k \geq 5$ , the second spectral moment  $\lambda_{Stu}(k)$  of  $\mathcal{T}_k$  is finite and

$$\lambda_{Stu}(k) = \begin{cases} \lambda \frac{k}{k-2} & \text{if } k \text{ is even,} \\ \lambda k \left( \frac{1}{k-2} + \frac{\sqrt{\pi}}{2^{k-3}} \frac{(k-5)!}{(\frac{k-5}{2})! \Gamma\left(\frac{k}{2}\right)} \right) & \text{else,} \end{cases}$$
(16)

where  $\lambda$  is the spectral moment of the underlying Gaussian fields. Note that  $\lambda_{Stu}(k) \to \lambda$  as  $k \to \infty$ .




Figure 5: Student field as in Section 2.2.3 with 4 degrees of freedom and  $\lambda=0.019$  in a domain of size  $2^{10}\times 2^{10}$  pixels. First row: A realization of a normalized Student random field (left) and two excursion sets for u=0 (center) and u=1 (right). Second row:  $\widehat{C}_{0,T}(\widetilde{T}_k,u)$  (left),  $\widehat{C}_{1,T}(\widetilde{T}_k,u)$  (center) and  $\widehat{C}_{2,T}(\widetilde{T}_k,u)$  (right) as a function of the level u. We display the averaged values on M=100 sample simulations (red stars) and the associated empirical intervals (vertical red lines). Theoretical  $u\mapsto C_0^*(\widetilde{T}_k,u)$ ,  $C_1^*(\widetilde{T}_k,u)$  and  $C_2^*(\widetilde{T}_k,u)$  are draw in blue lines.

Figure 5 displays a realization of a normalized Student random field  $\widetilde{T}_k$  with k=4 degrees of freedom, two excursion sets and an illustration for the performance of the three estimators  $\widehat{C}_{0,T}(\widetilde{T}_k,u)$ ,  $\widehat{C}_{1,T}(\widetilde{T}_k,u)$  and  $\widehat{C}_{2,T}(\widetilde{T}_k,u)$ .

**Parameter estimation.** Suppose we observe  $E_{\widetilde{\mathcal{T}}}(u)$  the excursion at level u of  $\widetilde{\mathcal{T}}$  a centered Student field with unit variance, unknown degree of freedom K and unknown second spectral moment  $\lambda$  of the underlying Gaussian fields. As in Section 2.2.2, using that for a centered Student field with unit variance with k degrees of freedom  $C_2^*(\widetilde{\mathcal{T}}_k, u)$  only depends on k, we propose the following estimator of K:

$$\widehat{K}(u) = \underset{k \in [3, k_{max}]}{\operatorname{arg\,min}} \left| C_2^*(\widetilde{\mathcal{T}}_k, u) - \widehat{C}_{2,T}(\widetilde{\mathcal{T}}, u) \right|, \tag{17}$$

with  $\widehat{C}_{2,T}$  as in (10) and  $C_2^*(\widetilde{\mathcal{T}}_k, u)$  given by Proposition 2.7. Furthermore, the Gaussian second spectral moment of the considered Student field can be estimated by

$$\widehat{\lambda}_{T,\widehat{K}(u)}(u) = (2\pi) \frac{\widehat{C}_{0,T}(\widetilde{T}, u)}{\mathcal{M}_{2,\widetilde{T}_k}(\widehat{K}(u), u)},$$

with  $\widehat{C}_{0,T}$  as in (8),  $\widehat{K}(u)$  as in (17) and where  $\mathcal{M}_{2,\widetilde{T}_k}(k,u)$  does not depend on  $\lambda$  and is given by

$$\mathcal{M}_{2,\tilde{\tau}_{k}}(k,u) = \frac{(k-1)}{4\pi^{\frac{3}{2}}} \frac{u}{\sqrt{k-2}} \frac{\Gamma(\frac{k-1}{2})}{\Gamma(\frac{k}{2})} \left(1 + \frac{u^{2}}{k-2}\right)^{\frac{1-k}{2}}.$$




Figure 6: Student field as in Section 2.2.3 with 4 degrees of freedom and  $\lambda = 0.019$ . Estimated  $\widehat{K}(u)$  as in Equation (17) (left) and associated  $\widehat{\lambda}_{T,\widehat{K}(u)}(u)$  (right). Theoretical chosen values are K=4,  $k_{max}=20$  and  $\lambda=0.019$ . They are represented by horizontal red lines.

An illustration of the performance of this inference procedure is given in Figure 6 for a centered Student field with K=4 degrees of freedom.

#### 2.3 Shot-noise field

In this section, we consider a shot-noise field  $S_{\Phi}: \mathbb{R}^2 \to \mathbb{R}$  defined as in [6] and [7]. It is prescribed by

$$S_{\Phi}(t) = \sum_{(x_i, b_i, r_i) \in \Phi} b_i \mathbf{1}_{r_i D}(t - x_i), \ t \in \mathbb{R}^2,$$

where  $\Phi$  is a stationary Poisson point process on  $\mathbb{R}^2 \times \mathbb{R}^* \times \mathbb{R}^+$  with intensity measure  $\nu \operatorname{Leb}_{\mathbb{R}^2} \otimes dF_B \otimes dF_R$  where  $\nu > 0$ ,  $F_B$  is a probability measure on  $\mathbb{R}^*$ ,  $F_R$  is a probability measure on  $\mathbb{R}^+$  and D is the unit disc in  $\mathbb{R}^2$ . Under the condition

$$\int_{\mathbb{R}^2 \times \mathbb{R}^* \times \mathbb{R}^+} |b| \mathbf{1}_{rD}(x) \, dx \, F_B(db) F_R(dr) = \pi \, \mathbb{E}(|B|) \, \mathbb{E}(R^2) < +\infty,$$

with B and R two random variables with respective distributions  $F_B$  and  $F_R$ , the field  $S_{\Phi}$  is well-defined, stationary and isotropic. It is moreover integrable and, for any  $t \in \mathbb{R}^2$ ,

$$\mathbb{E}(S_{\Phi}(t)) = \nu \, \bar{a} \, \mathbb{E}(B),$$

with  $\bar{a} = \pi \mathbb{E}(R^2)$ . Furthermore, if  $\mathbb{E}(B^2) < +\infty$ ,  $S_{\Phi}$  is square integrable and  $\operatorname{Var}(S_{\Phi}(t)) = \nu \bar{a} \mathbb{E}(B^2)$ . We also introduce  $\bar{p} = 2\pi \mathbb{E}(R)$ .

In the case B=1 a.s., the marginals of  $S_{\Phi}$  are Poisson distributed with parameter  $\nu \bar{a}$ . In the case where B is uniformly distributed in  $\{-1,+1\}$ , the field  $S_{\Phi}$  is symmetric and its marginals have a Skellam distribution with both parameters equal to  $\nu \bar{a}/2$  (see [24]), that is to say that they coincide with the difference of two independent Poisson random variables with parameter  $\nu \bar{a}/2$ . In that case, the marginal distribution of  $S_{\Phi}$  is given by  $k \in \mathbb{Z} \mapsto e^{-\nu \bar{a}} I_{|k|}(\nu \bar{a})$ , where I denotes the modified Bessel function of the first kind, defined as follows:  $I_n(x) = \sum_{m=0}^{\infty} \frac{(x/2)^{2m+n}}{m!\Gamma(m+n+1)}$ , for any  $n \in \mathbb{Z}^+$  and any  $x \in \mathbb{R}$ .

When B is positive a.s., we prove that the considered shot-noise field  $S_{\Phi}$  is standard as in Definition 2.1.

**Proposition 2.9.** Let  $R_{max} > 0$ . If B > 0 and  $R \le R_{max}$  a.s., the random field  $S_{\Phi}$  is standard at any level  $u \in \mathbb{R}$ .

Proof. Since B>0 a.s.  $T\cap E_{S_{\Phi}}(u)=T$  for any  $u\leq 0$ . Hence we may assume that u>0. Since  $R\leq R_{max}$  a.s. the number of discs intercepting T is bounded by  $N_{\Phi}(T):=\#\{x_i;d(x_i,T)\leq R_{max}\}$  that is a Poisson random variable of finite intensity. It follows that  $T\cap E_{S_{\Phi}}(u)$  must be given by the union of a finite number  $N(T\cap E_{S_{\Phi}}(u))\leq N_{\Phi}(T)$  of some finite intersections of discs that are convex bodies. Since  $N_{\Phi}(T)$  is a Poisson random variable, we clearly have  $\mathbb{E}(2^{N(T\cap E_{S_{\Phi}}(u))})<+\infty$  so that Proposition 2.4 allows us to conclude that  $S_{\Phi}$  is standard at level u.

If B changes sign, excursion sets  $T \cap E_{S_{\Phi}}(u)$  are no more a.s. closed, nor locally convex, nor necessarily of positive reach, however they are elementary sets in the sense of Definition 1 in [7], with boundaries included in the discontinuity set of  $S_{\Phi}$  so that one can compute length and total curvature. Therefore, we still define  $\Phi_i$  and  $C_i$  as in Definitions 1.2 and 1.4. We state the following lemma, in the same vein as Theorem 6 in [7].

**Lemma 2.10.** Let B be a discrete random variable with values in  $\mathbb{Z}\setminus\{0\}$ . Then, for any level u, the LK densities  $C_1^*(S_{\Phi}, u)$  and  $C_0^*(S_{\Phi}, u)$  are well defined and their Fourier transforms are given, for  $t \neq 0$ , by

$$\int_{\mathbb{D}} e^{iut} C_1^*(S_{\Phi}, u) du = \frac{1}{2} \nu \bar{p} \, \varphi_{S(0)}(t) \, \frac{1}{it} \left( \varphi_{B^+}(t) - \varphi_{B^-}(t) \right), \tag{18}$$

$$\int_{\mathbb{R}} e^{iut} C_0^*(S_{\Phi}, u) du = \nu \, \varphi_{S(0)}(t) \, \frac{1}{it} \left( \varphi_B(t) - 1 + \frac{\nu \bar{p}^2}{4\pi} (\varphi_{B^+}(t) - \varphi_{B^-}(t))^2 \right), \tag{19}$$

where  $\varphi_Z(t)$  stands for the characteristic function  $\mathbb{E}(e^{itZ})$  of a random variable Z,  $B^+ = \max(B,0)$  and  $B^- = \min(B,0)$ .

The proof of Lemma 2.10 is established in the Appendix Section A.3. Turning back to the special cases where B = 1, a.s. or B uniformly distributed in  $\{-1, +1\}$  and following the same inverse Fourier procedure as in [7] Th.6, we obtain the explicit formulas below.

**Proposition 2.11.** If B = 1 and  $u \in \mathbb{R}^+ \setminus \mathbb{Z}^+$ , it holds that

$$C_0^*(S_{\Phi}, u) = e^{-\nu \bar{a}} \frac{(\nu \bar{a})^{\lfloor u \rfloor}}{\lfloor u \rfloor!} \nu \left( 1 - \nu \frac{\bar{p}^2}{4\pi} + \lfloor u \rfloor \frac{\bar{p}^2}{4\pi \bar{a}} \right),$$

$$C_1^*(S_{\Phi}, u) = e^{-\nu \bar{a}} \frac{(\nu \bar{a})^{\lfloor u \rfloor}}{\lfloor u \rfloor!} \nu \bar{p} \quad and \quad C_2^*(S_{\Phi}, u) = e^{-\nu \bar{a}} \sum_{k > u} \frac{(\nu \bar{a})^k}{k!}.$$

If B is uniformly distributed in  $\{-1,+1\}$  and  $u \in \mathbb{R} \setminus \mathbb{Z}$ , it holds that

$$C_{0}^{*}(S_{\Phi}, u) = \frac{\nu}{2} e^{-\nu \bar{a}} \left( (I_{\lfloor \lfloor u \rfloor \rfloor} - I_{\lfloor \lfloor u \rfloor + 1 \rfloor})(\nu \bar{a}) + \frac{\nu \bar{p}^{2}}{8\pi} (I_{\lfloor \lfloor u \rfloor - 1 \rfloor} + I_{\lfloor \lfloor u \rfloor \rfloor} - I_{\lfloor \lfloor u \rfloor + 1 \rfloor} - I_{\lfloor \lfloor u \rfloor + 2 \rfloor})(\nu \bar{a}) \right),$$

$$C_{1}^{*}(S_{\Phi}, u) = \frac{\nu \bar{p}}{2} e^{-\nu \bar{a}} \left( I_{\lfloor \lfloor u \rfloor \rfloor} + I_{\lfloor \lfloor u \rfloor + 1 \rfloor})(\nu \bar{a}) \quad and \quad C_{2}^{*}(S_{\Phi}, u) = e^{-\nu \bar{a}} \sum_{k > u} I_{|k|}(\nu \bar{a}),$$

where  $|\cdot|$  denotes the greatest integer less than u.

Figure 7 (resp. Figure 8) displays two excursion sets and an illustration of the shape of  $C_i^*(S_{\Phi}, u)$ , for  $i \in \{0, 1, 2\}$  when B = 1, a.s. (resp. when B is uniformly distributed in  $\{-1, +1\}$ ). Remark that if B is uniformly distributed in  $\{-1, +1\}$  we do not know if  $S_{\Phi}$  is a standard random field in the sense of Definition 2.1. Therefore in Figure 8, we do not apply the unbiased formulas of Proposition 2.5 and we use  $C_i^{/T}(S_{\Phi}, u)$ , for  $i \in \{0, 1, 2\}$ .

Let us quote general results of [16] that may be used to obtain CLT for the volume, the perimeter and the Euler characteristic of shot noise excursion sets (see especially Theorem 4.4 in [16]). In particular, in our setting, by Theorem 2.4 of [16], one can get for  $R \leq R_{\text{max}}$  and  $B \in \mathbb{R}^*$  that

$$\sqrt{|T|} \left( \widehat{C}_{2,T}(S_{\Phi}, u) - C_2^*(S_{\Phi}, u) \right) \xrightarrow[T \times \mathbb{R}^2]{d} \mathcal{N}(0, \sigma_2^2(u)), \quad 0 < \sigma_2^2(u) < \infty.$$

A similar question is the purpose of [14] where a joint CLT is established for all the intrinsic volumes of a Boolean model. Note that the occupied domain of a Boolean model is nothing but the excursion set above level 1 of a shot-noise field with B = 1, a.s.

In our framework, we provide a non-asymptotic result to control the variance on a finite domain T and prove consistency of  $\widehat{C}_{i,T}(S_{\Phi}, u)$ , for i = 0, 1, 2.

**Theorem 2.12.** If B takes values in  $\mathbb{Z} \setminus \{0\}$  and  $R \leq R_{max}$  a.s., there exists a constant C, depending on  $\nu$ ,  $\overline{p}$ ,  $\overline{a}$  and  $R_{max}$  only, such that, for i = 0, 1, 2,

$$\left(\mathbb{E}\left[\left(\widehat{C}_{i,T}(S_{\Phi},u)\right) - C_i^*(S_{\Phi},u)\right)^2\right]\right)^{1/2} \le C\left(\frac{1}{|T|^{1/2}} + \frac{|\partial T|_1}{|T|}\right).$$

We recover that choosing T such that  $|T| \to +\infty$  and  $\frac{|\partial T|_1}{|T|} \to 0$ , leads to the consistency of  $\widehat{C}_{i,T}(S_{\Phi}, u)$ . Proof of Theorem 2.12 is postponed to Section A.4. To establish this result we first derive variance bounds for the weak versions of the perimeter and the total curvature (see Proposition A.1, Section A.2) which present interest on its own and is related to the framework of [16].




Figure 7: Shot-noise field as in Section 2.3 with B=1, a.s.,  $\nu=0.0005$  with random disks of radius R=50 or R=100 (each with probability 0.5) in a domain of size  $2^{10}\times 2^{10}$  pixels. First row: Shot-noise field random field (left) and two excursion sets for u=7 (center) and u=14 (right). Second row  $\widehat{C}_{0,T}(S_{\Phi},u)$  (left),  $\widehat{C}_{1,T}(S_{\Phi},u)$  (center) and  $\widehat{C}_{2,T}(S_{\Phi},u)$  (right) as a function of the level u. We display the averaged values on M=100 sample simulations (red stars) and the associated empirical intervals (vertical red lines). Theoretical  $u\mapsto C_0^*(S_{\Phi},u)$ ,  $C_1^*(S_{\Phi},u)$  and  $C_2^*(S_{\Phi},u)$  are draw with blue dots. Theoretical values of parameters are  $\nu \, \overline{a}=9.8175$ ,  $\nu \, \overline{p}=0.2356$ ,  $\nu=0.0005$ .

**Parameter estimation.** Suppose we observe  $E_S(u)$  for S a shot-noise with B=1, a.s. and for u in  $\mathbb{R}^+ \setminus \mathbb{Z}^+$  with unknown parameters  $\nu$ ,  $\bar{a}$  and  $\bar{p}$ . Define, for some positive A,

$$\widehat{\nu}\,\overline{a}(u) = \underset{\nu\,\overline{a} \in (0,A]}{\operatorname{arg\,min}} \left| C_2^*(S,u) - \widehat{C}_{2,T}(S,u) \right|,\tag{20}$$

with  $\widehat{C}_{2,T}$  as in (10) and  $C_2^*(S,u)$  given by Proposition 2.11. Besides, using Proposition 2.11 we get

$$\widehat{\nu p}(u) = \widehat{C}_{1,T}(S, u) \left( e^{-\widehat{\nu a}(u)} \frac{(\widehat{\nu a}(u))^{\lfloor u \rfloor}}{\lfloor u \rfloor!} \right)^{-1}, \tag{21}$$

with  $\widehat{C}_{1,T}$  as in (9) and  $\widehat{\nu} \, \overline{a}(u)$  as in (20). Then, we define the following estimator for  $\nu$ 

$$\widehat{\nu}(u) = \frac{\widehat{C}_{0,T}(S, u)}{e^{-\widehat{\nu}\widehat{\overline{a}}(u)} \frac{(\widehat{\nu}\widehat{\overline{a}}(u))^{\lfloor u \rfloor}}{\lfloor u \rfloor!}} + \left(\frac{(\widehat{\nu}\widehat{\overline{p}}(u))^2}{4\pi}\right) - \left(\frac{\lfloor u \rfloor (\widehat{\nu}\widehat{\overline{p}}(u))^2}{4\pi\widehat{\nu}\widehat{\overline{a}}(u)}\right), \tag{22}$$

where  $\widehat{C}_{0,T}(S,u)$  is as in Equation (8),  $\widehat{\nu}\overline{a}(u)$  as in (20) and  $\widehat{\nu}\overline{p}(u)$  as in (21). Finally, the obtained  $\widehat{\nu}(u)$  can be used to isolate  $\widehat{\overline{a}}(u)$  and  $\widehat{\overline{p}}(u)$  in Equations (20) and (21) respectively. An illustration of this inference procedure is provided in Figure 9 (first row).




Figure 8: Shot-noise field as in Section 2.3 with B uniformly distributed in  $\{-1,+1\}$ ,  $\nu=0.00003$  and random disks of radius R=150 or R=100 (each with probability 0.5) in a domain of size  $2^{10}\times 2^{10}$  pixels. First row: Shot-noise field random field (left) and two excursion sets for u=-0.5 (center) and u=1.5 (right). Second row  $C_0^{/T}(S_\Phi,u)$  (left),  $C_1^{/T}(S_\Phi,u)$  (center) and  $C_2^{/T}(S_\Phi,u)$  (right) as a function of the level u. We display the averaged values on M=100 sample simulations (red stars) and the associated empirical intervals (vertical red lines). Theoretical  $u\mapsto C_0^*(S_\Phi,u)$ ,  $C_1^*(S_\Phi,u)$  and  $C_2^*(S_\Phi,u)$  are draw with blue dots. Theoretical values of parameters are  $\nu\,\bar{a}=1.5315$ ,  $\nu\,\bar{p}=0.0236$ ,  $\nu=0.00003$ .




Figure 9: First row: Shot-noise field as in Section 2.3 with B=1, a.s.,  $\nu=0.0005$  with random disks of radius R=50 or R=100 (each with probability 0.5) in a domain of size  $2^{10}\times 2^{10}$  pixels. Estimated  $\widehat{\nu a}(u)$  as in Equation (20) for  $\nu \overline{a}_{max}=40$  (left),  $\widehat{\nu p}(u)$  as in Equation (21) (center) and  $\widehat{\nu}(u)$  as in (22) (right). Theoretical values:  $\nu \overline{a}=9.8175$ ,  $\nu \overline{p}=0.2356$  and  $\nu=0.0005$ . They are represented by horizontal lines. Second row: Shot-noise field with B=1, a.s.,  $\nu=0.0005$  and R=100 a.s., in a domain of size  $2^{10}\times 2^{10}$  pixels. Estimated  $\widehat{\nu a}(u)$  as in Equation (20) with  $\nu \overline{a}_{max}=40$  (left) and  $\widehat{\nu}(u)$  as in (23) (right). Theoretical values:  $\nu \overline{a}=15.708$  and  $\nu=0.0005$ . They are represented by horizontal lines.

As mentioned earlier, the unsatisfactory quality of the Matlab function byperim for the estimation of  $C_1^*(S,u)$  strongly impacts the final performance of the estimation of  $\widehat{\nu p}(u)$  (see Figure 9, center panel). For this reason, we also present here the simplified case when R is a constant value (R=100~a.s.). In this particular case  $\nu \overline{a} = \frac{\nu \overline{p}^2}{4\pi}$ . Then, we estimate  $\widehat{\nu a}(u)$  as in (20) and  $\widehat{\nu}(u)$  by using the simplified version of (22), *i.e.*,

$$\widehat{\nu}(u) = \left(\frac{1}{1 + \lfloor u \rfloor - \widehat{\nu} \, \overline{a}(u)}\right) \left(\frac{\widehat{C}_{0,T}(S, u)}{e^{-\widehat{\nu} \, \overline{a}(u)} \, \frac{(\widehat{\nu} \, \overline{a}(u))^{\lfloor u \rfloor}}{|u|!}}\right). \tag{23}$$

An illustration of the finite sample performance of these inference procedures is provided in Figure 9 (second row).

# 3 Using LK densities for testing Gaussianity

Let X be a stationary, isotropic, centered with unit variance random field. We observe an excursion of X above some levels u on the domain T, namely  $T \cap E_X(u)$  and we aim to test whether X is Gaussian.

# 3.1 Testing against a Student field

In this section we are interested in testing

H0: X is Gaussian versus

H1:  $\exists k \geq 3$ , X is Student with k degrees of freedom and unit variance,

where under H0 and H1 the fields are defined through Definition 2.2, where  $F: x \in \mathbb{R} \mapsto x$ , under H0 and  $F: (x_1, y) \in \mathbb{R}^{k+1} \mapsto \sqrt{(k-2)/k} \left( x_1/\sqrt{\|y\|^{2/k}} \right)$ , under H1.

Under H0 and H1 the field X is symmetric and then centered. Suppose that for  $1 \le u_1 < u_2$  we observe  $T \cap E_X(u)$ , for  $u \in \{u_1, u_2\}$ . Notice that the fact that under H0 and H1 the fields have unit variance enables the comparison of the LK densities of their excursions at the same meaningful levels. Assuming  $u_1$  and  $u_2$  are positive and greater than 1 is not necessary. Indeed the test can be easily modified for negative values of  $u_1$  or  $u_2$  by using the symmetry of X under H0 and H1. Furthermore, under H1 we do not assume that k is known. Unsurprisingly, the performance of the test will depend on the unknown k. Moreover, we underline that under H0 and H1 we do not impose any constraint on the shape of the covariance function nor on the spectral moment other than (A). In particular, the spectral moments of X under H0 and H1 can be different.

A test statistic. Our test statistics is built from the previously studied LK densities. As the perimeter  $C_1^{/T}$  is hard to evaluate in practice (see the earlier comment on the Matlab function bwperim), we do not use it to build a test. Moreover, Gaussian and Student distributions differ in the tails, which would lead to consider large values for  $u_2$ . But for large levels we do not observe many excursion sets which deteriorates the estimation of  $C_2^*$ . This explains why we consider  $C_0^*$  to build our test statistic: it is well evaluated in practice and permits to consider intermediate values of  $u_1$  and  $u_2$ . Finally, in order to get statistic free in  $\lambda$ , we take the ratio of  $C_0^*$  between to different levels  $u_1$  and  $u_2$ . This is why we need to observe two distinct excursion sets.

Without loss of generality assume that  $u_2 = \gamma u_1$ , for some  $\gamma > 1$ . For the following empirically accessible ratios, we derive from Equation (11) and from Proposition 2.7 that

$$\frac{C_0^*(X, u_2)}{C_0^*(X, u_1)} = \gamma e^{\frac{u_1^2}{2}(1 - \gamma^2)} =: v(\gamma, \infty) \quad \text{under } H0,$$
(24)

$$\frac{C_0^*(X, u_2)}{C_0^*(X, u_1)} = \gamma \left(1 - \frac{(\gamma^2 - 1)u_1^2}{k - 2 + \gamma^2 u_1^2}\right)^{\frac{k - 1}{2}} =: v(\gamma, k) \quad \text{under } H1.$$
(25)

Quantities  $v(\gamma, \infty)$  and  $v(\gamma, k)$  in (24) and (25), for values of  $u_1$  and  $\gamma$  not too large, are quite different. Furthermore, for all k it holds that  $v(\gamma, k) > v(\gamma, \infty)$  and  $k \mapsto v(\gamma, k)$  is decreasing. We build a non symmetric test where we reject H0 whenever the associated empirical ratio is too large compared to its expected behavior under H0. It is important to observe that  $v(\gamma, \infty)$  does not depend on the spectral moment of X nor on its covariance function. The choice of  $u_1 \geq 1$  and  $\gamma > 1$  are left to the practitioner, or might be imposed by the data-set. We expect that the larger  $\gamma$  is and the smaller k is and better the test will be. However, in practice  $\gamma$  should not be too large as we need to estimate  $C_0^*(X, u_2)$ , which requires to have sufficiently enough excursions above the level  $u_2 = \gamma u_1$ .

Let  $T_1$  and  $T_2$  be two rectangles in  $\mathbb{R}^2$  such that  $\operatorname{dist}(T_1, T_2) > 0$  and  $|T_1| = |T_2| > 0$ . For any positive integer N, we define  $T_i^{(N)} = \{Nt : t \in T_i\}$ , for i = 1, 2. Consider the statistics

$$\widehat{R}_{\gamma,N} := \frac{\widehat{C}_{0,T_2^{(N)}}(X, u_2)}{\widehat{C}_{0,T_1^{(N)}}(X, u_1)},\tag{26}$$

with  $\widehat{C}_{0,T}$  defined in (8).

Test with asymptotic level  $\alpha$ . We can establish the asymptotic normality of the statistics  $\widehat{R}_{\gamma,N}$ .

**Proposition 3.1.** Assume that X satisfies condition (A). Let  $T_1^{(N)}$  and  $T_2^{(N)}$  defined as before and  $\widehat{R}_{\gamma,N}$  as in (26). Then, under H0 it holds that

$$\sqrt{|T_1^{(N)}|}(\widehat{R}_{\gamma,N}-v(\gamma,\infty)) \xrightarrow[N\to\infty]{d} \mathcal{N}(0,\Sigma(u_1,u_2)),$$

where  $\Sigma(u_1, u_2) < \infty$ .

*Proof.* As the sets  $T_1^{(N)}$  and  $T_2^{(N)}$  are such that  $\operatorname{dist}(T_1^{(N)}, T_2^{(N)}) \to +\infty$  and  $|T_1^{(N)}| = |T_2^{(N)}| \to +\infty$ , from Proposition 5a in [10] it holds that

$$\sqrt{|T_1^{(N)}|} \begin{pmatrix} \widehat{C}_{0,T_1^{(N)}}(X,u_1) - \mathbb{E}[C_0^{/T_1^{(N)}}(X,u_1)] \\ \widehat{C}_{0,T_2^{(N)}}(X,u_2) - \mathbb{E}[C_0^{/T_2^{(N)}}(X,u_2)] \end{pmatrix} \xrightarrow[N \to \infty]{d,H0}} \mathcal{N} \begin{pmatrix} \begin{pmatrix} 0 \\ 0 \end{pmatrix}, \begin{pmatrix} V(u_1) & 0 \\ 0 & V(u_2) \end{pmatrix} \end{pmatrix},$$

where  $u \mapsto V(u)$  is defined in Equation (9) of [10]. Moreover, one can prove that the limit of

$$\sqrt{|T_1^{(N)|}} \begin{pmatrix} C_1^{/T_1^{(N)}}(X, u_1) - \mathbb{E}[C_1^{/T_1^{(N)}}(X, u_1)] \\ C_1^{/T_2^{(N)}}(X, u_2) - \mathbb{E}[C_1^{/T_2^{(N)}}(X, u_2)] \end{pmatrix}$$

is non degenerate (see [15] or [21]). Then, the same decomposition as in the proof of Proposition 2.6 leads to

$$\sqrt{|T_1^{(N)}|} \begin{pmatrix} \widehat{C}_{0,T_2^{(N)}}(X,u_2) - C_0^*(X,u_2) \\ \widehat{C}_{0,T_1^{(N)}}(X,u_1) - C_0^*(X,u_1) \end{pmatrix} \xrightarrow[N \to \infty]{d,H_0} \mathcal{N} \begin{pmatrix} \begin{pmatrix} 0 \\ 0 \end{pmatrix}, \begin{pmatrix} V(u_2) & 0 \\ 0 & V(u_1) \end{pmatrix} \end{pmatrix}.$$
 (27)

Applying the delta method, we get the result with  $\Sigma(u_1, u_2) = \frac{\left(V(u_2) + v(\gamma, \infty)^2 V(u_1)\right)}{C_0^*(X, u_1)^2}$ .

Consider the consistent empirical estimator  $\widehat{\Sigma}_{u_1,u_2} := \widehat{\mathbb{V}(\widehat{R}_{\gamma,N})} |T_1^{(N)}|$  of  $\Sigma_{u_1,u_2}$ , where  $\widehat{\mathbb{V}(\widehat{R}_{\gamma,N})}$  is the empirical variance of the considered ratio. Then, from Proposition 3.1, it holds that

$$\sqrt{\frac{|T_1^{(N)}|}{\widehat{\Sigma}_{u_1,u_2}}} (\widehat{R}_{\gamma,N} - v(\gamma,\infty)) = \sqrt{\frac{1}{\widehat{\mathbb{V}(\widehat{R}_{\gamma,N})}}} (\widehat{R}_{\gamma,N} - v(\gamma,\infty)) \xrightarrow[N \to \infty]{d,H0} \mathcal{N}(0,1).$$

Take a confidence level  $\alpha \in (0,1)$  and set  $q_{1-\alpha}$  such that  $\mathbb{P}(N(0,1) \geq q_{1-\alpha}) = \alpha$ . We define the test  $\phi_{T^{(N)}}$  with asymptotic level  $\alpha$  as

$$\phi_{T^{(N)}} = \mathbf{1}_{\left\{\sqrt{\frac{1}{v(\widehat{R}_{\gamma,N})}} \left(\widehat{R}_{\gamma,N} - v(\gamma,\infty)\right) \ge q_{1-\alpha}\right\}}.$$
(28)

**Discussion on consistency.** Suppose that X is a Student field with K degrees of freedom (K is fixed). Then, the test statistic can be decomposed as follows

$$\sqrt{\frac{|T_1^{(N)}|}{\widehat{\Sigma}_{u_1,u_2}}} (\widehat{R}_{\gamma,N} - v(\gamma,\infty)) = \widehat{\Sigma}_{u_1,u_2}^{-1/2} (\sqrt{|T_1^{(N)}|} (\widehat{R}_{\gamma,N} - v(\gamma,K)) + \sqrt{|T_1^{(N)}|} (v(\gamma,K) - v(\gamma,\infty)))$$




Figure 10: Student random field with unit variance and different degrees of freedom in a domain of size  $2^{10} \times 2^{10}$  pixels. We display the empirical  $\mathbb{P}_{H1}(\phi_{T^{(N)}}=1)$  on M=100 sample simulations. Left:  $u_1=1$  and  $\gamma=2$ . Right:  $u_1=1$  and  $\gamma=3$ .

$$:= \widehat{\Sigma}_{u_1,u_2}^{-1/2} (I_1 + I_2),$$

where  $I_2 \xrightarrow[N \to \infty]{\mathbb{P}, H_1} + \infty$ . Then, if we were able to establish that  $\Sigma_{u_1, u_2}^{-1/2}$  is bounded away from 0 and if a joint central limit theorem for  $(C_i^{/T}(X, u_1), C_i^{/T}(X, u_2))$ , i = 0, 1 for X a Student fields was known this would entail the consistency of the test, i.e.,  $\mathbb{P}_{H_1}(\phi_{T^{(N)}} = 1) \xrightarrow[N \to \infty]{} 1$ . Remark that at least numerically, in our simulations studies in Figure 10 below, it seems to be the case.

Numerical illustrations. In Figure 10 (left) we show the empirically estimated  $\mathbb{P}_{H1}(\phi_{T^{(N)}}=1)$  with  $\phi_{T^{(N)}}$  as in (28) on M=100 sample simulations for  $\gamma=2$  and  $u_1=1$  (value where  $C_0^*$  is maximal under H0). The theoretical ratio under H0 is  $\widehat{R}_{\gamma,N}=0.4463$ . In order to show the performance of our test in term of  $\gamma$ , in Figure 10 (right) we consider  $\gamma=3$  and  $u_1=1$ . In this second case, the associated theoretical ratio under H0 is  $\widehat{R}_{\gamma,N}=0.0549$ . The confidence threshold  $\alpha=0.05$  is displayed by a dashed horizontal line. Under H0 hypothesis several experiments have been reproduced and as expected, the test  $\phi_{T^{(N)}}$  with empirical estimated  $\widehat{\Sigma}_{u_1,u_2}$  has the desired asymptotic level  $\alpha$ . However, for the sake of

brevity, we do not display these results here.

Remark that to perform this test, it is not necessary to know the degree of freedom of the Student alternative. However, as illustrated on Figure 10, if k gets too large or  $\gamma$  is too small the test fails to distinguish H1 from H0. It is easily explained by the following expansion as  $K \to \infty$ ,

$$v(\gamma, K) = v(\gamma, \infty) \left(1 + O\left(\frac{\gamma - 1}{K}\right)\right).$$

Conversely, the increasing quality of the test in term of  $\gamma$  can be appreciated in Figure 10.

# 3.2 Testing against a power of a Gaussian field

Consider the alternative

$$H1(\eta): \exists \eta > 0, \ \eta \neq 1 \text{ such that } X = \text{sign}(G) |G|^{\eta} \sigma^{-1}(\eta),$$

where G is a centered Gaussian random fields with unit variance and  $\sigma^2(\eta) := 2^{1-\eta} \frac{\Gamma(2\eta)}{\Gamma(\eta)}$ , such that the field X has unit variance under  $H_1(\eta)$ . It is centered by construction, it is unnecessary to impose any assumption on the covariance function of G. It is straightforward to get  $C_0^*(X, u) = C_0^*(G, \text{sign}(u) |u|^{\frac{1}{\eta}} \sigma(\eta))$  and the statistics in (25) for these alternatives  $H_1$  becomes, for  $u_2 = \gamma u_1$  and  $\gamma > 1$ ,

$$\frac{C_0^*(X, u_2)}{C_0^*(X, u_1)} = \gamma^{\frac{1}{\eta}} \exp\left(-\frac{(\gamma^{2/\eta} - 1)u_1^{2/\eta} \sigma^2(\eta)}{2}\right) := \widetilde{v}(\gamma, \eta). \tag{29}$$

Note that under H0,  $\eta = 1$  and  $v(\gamma, \infty)$  previously defined in (24) coincides with  $\tilde{v}(\gamma, 1)$ . For  $\gamma > 1$ , the quantity in (29) is either smaller or larger than (24) depending on  $\eta$ . Symmetrizing the previous test it follows that to test H0:  $\eta = 1$  against  $H1(\eta)$ :  $\eta \neq 1$  we may consider the test with asymptotic level  $\alpha$ 

$$\widetilde{\phi}_{T^{(N)}} := \mathbf{1}_{\left\{\sqrt{\frac{1}{\mathbb{V}(\widehat{R}_{\gamma,N})}} \left| \widehat{R}_{\gamma,N} - \widetilde{v}(\gamma,1) \right| \geq q_{1-\frac{\alpha}{2}} \right\}},$$

where  $\mathbb{P}(N(0,1) \leq q_{1-\frac{\alpha}{2}}) = 1 - \frac{\alpha}{2}$ . In this case we have a better understanding of the behavior of the test statistic under H1. Under  $(\mathcal{A})$ , applying (27) and using that  $E_X(u) = E_G(\operatorname{sign}(u) |u|^{1/\eta} \sigma(\eta))$ , we

derive  $\forall \eta > 0$ 

$$\sqrt{|T_1^{(N)}|} \begin{pmatrix} \widehat{C}_0^{/T_2^{(N)}}(X, u_2) - C_0^*(X, u_2) \\ \widehat{C}_0^{/T_1^{(N)}}(X, u_1) - C_0^*(X, u_1) \end{pmatrix} \xrightarrow{d} \mathcal{N} \begin{pmatrix} 0 \\ 0 \end{pmatrix}, \begin{pmatrix} V(f_{\eta}(u_2)) & 0 \\ 0 & V(f_{\eta}(u_1)) \end{pmatrix} \end{pmatrix}.$$
(30)

with  $f_{\eta}(u) := \text{sign}(u)|u|^{1/\eta}\sigma(\eta)$ . If we suppose that  $X = \text{sign}(G)|G|^{\eta}\sigma^{-1}(\eta)$  with  $\eta \neq 1$  it holds that

$$\sqrt{\frac{|T_1^{(N)}|}{\widehat{\Sigma}_{u_1,u_2}}} (\widehat{R}_{\gamma,N} - \widetilde{v}(\gamma,1)) = \widehat{\Sigma}_{u_1,u_2}^{-1/2} (\sqrt{|T_1^{(N)}|} (\widehat{R}_{\gamma,N} - \widetilde{v}(\gamma,\eta)) + \sqrt{|T_1^{(N)}|} (\widetilde{v}(\gamma,\eta) - \widetilde{v}(\gamma,1)))$$

$$:= \widehat{\Sigma}_{u_1,u_2}^{-1/2} (\widetilde{I}_1 + \widetilde{I}_2),$$

where from (30) we get  $\widetilde{I}_1 \xrightarrow[N \to \infty]{d} \mathcal{N}(0,\Sigma)$  and  $\widetilde{I}_2 \xrightarrow[N \to \infty]{\mathbb{P},H1} \infty$ . Then, if  $\widehat{\Sigma}_{u_1,u_2}$  is bounded from below, which is not easy to establish, we would have  $\mathbb{P}_{H1}(\widetilde{\phi}_{T^{(N)}} = 1) \xrightarrow[T \to \mathbb{R}^2]{} 1$ , which would ensure the consistency of the test  $\widetilde{\phi}_{T^{(N)}}$ .

# 4 Illustration on synthesized 2D digital mammograms

In this section we consider a recent 3D solid breast texture model inspired by the morphology of medium and small scale fibro-glandular and adipose tissue observed in clinical breast computed tomography (bCT) images (UC Davis database). Each adipose compartment is modeled as a union of overlapping ellipsoids and the whole model is formulated as a spatial marked point process, the contour of each ellipsoid is blurred to render the model more realistic (for details see [17], Section 2.2 and Figure 1). Finally, considered mammograms images were simulated by breast x-ray projection. Evaluation provided in [17] has shown that simulated mammograms and digital breast tomosynthesis images have a reasonable realistic visual appearance, depending on simulated breast density.

**Description of data-set.** We consider 15 simulated 2D digital images generated by this texture model. These images were kindly provided by GE Healthcare Life Sciences, department *Mammography*. The considered images are separated in 3 groups representing different morphologic situations:

- (A) Almost entirely adipose breasts;
- (B) Scattered fibro-glandular dense breasts;
- (C) Heterogeneously dense breasts.




Figure 11: One image from group (A) (left), group (B) (center) and group (C) (right). Image size: 251 × 251.

One image from each group is reported in Figure 11.

From a clinical point of view, radiologists use the Breast Imaging Reporting and Data System (or BI-RADS) to classify breast density into four categories. They go from almost all fatty tissue to extremely dense tissue with very little fat. Groups (A), (B) and (C) considered in this analysis corresponds respectively to the first, second and third category of the BI-RADS. In the first category breasts are almost all fatty tissue. The second category describes the case when there are scattered areas of dense glandular and fibrous tissue. The third category represents the case when the breast is made of dense glandular and fibrous tissue (described as heterogeneously dense). This latter situation can make it hard to see small tumors in or around the dense tissue.

For a mathematical point of view, one difference between the considered 3 groups is the chosen intensity of the homogeneous spatial point process in [17]'s model:  $\nu_A = 3.5 \times 10^{-3} mm^{-3}$  for group (A),  $\nu_B =$

 $5 \times 10^{-3} mm^{-3}$  for group (B) and  $\nu_C = 2.3 \times 10^{-3} mm^{-3}$  for the (C) one. As remarked in Section 3 in [17], the considered simulated digital mammograms from groups (A), (B) and (C) show a high visual realism compared to real images in these 3 different clinical situations.

Gaussian test based on  $C_0^*$ . We perform the test described in Section 3.1 for these 3 data-sets composed by N=5 images and for  $u_1=1$ . The test is more difficult as it may seem, due to the blurring step in the procedure to produce the images, the excursion sets have more irregular contour than a standard shot noise field as in Section 2.3. Moreover, due to the small size of the considered images  $(251 \times 251)$  and of the simulated samples (N=5), we relax the conditions to reject H0. First, we consider larger levels for the test, *i.e.*,  $\alpha \in \{0.2, 0.1, 0.05\}$ . Second, as we have access to the entire image, we consider 1000 different tests corresponding to different values of  $u_2 \in [-3, 3]$  for the excursion sets. Then, we have to symmetrize the test in Section 3.1 since we consider both negative and positive values of  $u_2$ . Then, the test statistic in (28) becomes

$$\phi_{T^{(N)}} = \mathbf{1}_{\{\widehat{\mathbb{V}(\widehat{R}_{\gamma,N})}^{-1/2} \left| \widehat{R}_{\gamma,N} - \widetilde{v}(\gamma,1) \right| \geq q_{1-\frac{\alpha}{2}} \}}, \quad \text{with } q_{1-\frac{\alpha}{2}} \text{ the } (1-\frac{\alpha}{2})\text{-quantile of a } \mathcal{N}(0,1).$$

As the 5 images of each group are random generations of the same parameter setting model, then we estimate the empirical variance of  $\hat{R}_{\gamma}$  based on the 5 images of each group.

We compute for each image in each group the 1000 p-values associated to the considered  $u_2$ . In Table 1, we display the number of the obtained p-values smaller than the significant  $\alpha$ -levels ( $\alpha \in \{0.2, 0.1, 0.05\}$ ). Furthermore, we highlight in bold text the numbers that are larger than  $\alpha \times 1000$  and for which H0 can be put in default.

We can remark the discrepancy with the Gaussianity hypothesis for all images of group (C) and for all considered significant  $\alpha$ -levels. The same consideration holds true for the last three images of group (A). Conversely, some simulated 2D digital mammographies seem to be not so far from the Gaussianity in term of the studied  $\widehat{R}_{\gamma,N}$  ratio. Roughly speaking, images of group (B) are closer to Gaussinity than group (A), which is itself closer to Gaussianity than (C). This might be viewed in parallel with the intensities considered for each group;  $\nu_C < \nu_A < \nu_B$ . This chosen parameter setting may explain why our test rejects Gaussianity more easily in group C than in group B.

The interested reader is referred for instance to the first four images of group (B). However a very different behavior is realized by the last image of this group where the Gaussianity hypothesis is rejected for almost all considered levels  $u_2$ . Finally, the robustness with respect to the chosen significant  $\alpha$ -levels can be observed in Table 1.

## 5 Conclusions and discussion

We have presented new statistical tools for inferring parameters and testing Gaussianity when only a sparse observation of a 2D random field is available, namely only the excursion set(s) above one or two level(s) within a large window. These tools are based on the three LK curvatures of the excursion sets, which are loosely given by the Euler characteristic, the half perimeter and the area.

The idea of considering the statistical characteristics of the excursion sets has been originally developed for one-dimensional processes with the powerful theory of crossings. Let us comment how our two-dimensional results can be adapted to dimension one. First, we recall that only two LK curvatures are available for Borelian subsets of  $\mathbb{R}$ : the one-dimensional Lebesgue measure (*i.e.* the length) and the Euler characteristic  $C_0$  (*i.e.* the number of connected components). A similar statement as Proposition 2.5 provides an unbiased estimator of  $C_0^*(X, u)$  for any *standard* stationary process X.

In particular, when X is a Gaussian process defined on  $\mathbb{R}$ , an adapted version of Proposition 2.6 allows us to build a consistent estimator of the second spectral moment of X, which is moreover asymptotically normal with a known asymptotic variance. Indeed, the latter variance can be computed from the asymptotic variance V(u) appearing in [10] with an explicit formula in dimension one (see Proposition 8 in the quoted paper). Let us again insist on the fact that the consistent estimator of the second spectral moment that we propose only relies on the observation of a single excursion of X. It would be interesting to compare it with more usual estimators based for instance on the estimation of the covariance function of X, which requires the observation of the whole process, or with the empirical rough estimator based on the number of crossings at different levels that is described in [18] and used in [10], Section 4.1.2. In the same vein, for a chi-square process defined on  $\mathbb{R}$ , the finiteness of the asymptotic variance of the

In the same vein, for a chi-square process defined on  $\mathbb{R}$ , the finiteness of the asymptotic variance of the Euler characteristic of excursion sets is proved in Proposition 7 in [10]. Using this result, one could expect to obtain the consistency of the estimator  $\widehat{K}(u)$  of the degrees of freedom and the estimator  $\widehat{\lambda}_{T,\widehat{K}(u)}(u)$  of the Gaussian second spectral moment, which are obtained from Equations (14) and (15) adapted to the univariate framework.




Figure 12:  $\widehat{C}_{2,T}(\cdot,u)$  in (10) for the 3 groups for different values u. The full black line represents  $\psi(u)$  in (11), i.e., the Gaussian tail distribution with zero mean and unit variance. We take here a logarithmic scale for the y-axis.

Turning back to the bivariate framework, let us discuss about the potential improvement provided by

the joint observations of several LK densities. In Section 4, in order to analyse the simulated 2D digital mammograms data-set, we have used  $C_0^*(\cdot, u)$ . Let us now investigate the use of  $C_2^*(\cdot, u)$  and the associated unbiased estimator in Proposition 2.5. In Figure 12 we display  $\widehat{C}_{2,T}(\cdot, u)$  for each image in the 3 groups compared with the tail distribution with zero mean and unit variance  $\psi(u)$  (see (11)). In order to improve the readability for extreme values of u, in Figure 12 we chose a logarithmic scale for the y-axis.

A clear assessment is that the two LK densities  $C_0^*$  and  $C_2^*$  bring two different points of view of the 15 images. For instance, for extreme u levels, say above level 2.5, the  $\widehat{C}_{2,T}(\cdot,u)$  of the mammograms clearly have a different behavior than the Gaussian one (see Figure 12). Moreover, the difference is greater for images of type (C) than for images of type (B), which is already greater than images of type (A). A similar behavior was not observed with the  $\widehat{C}_{0,T}(\cdot,u)$ . This point clearly deserves to be studied and is certainly related with extreme values theory.

Following the idea of taking advantage of the joint observation of several LK densities, our study can be continued with the development of efficient numerical tools adapted to different sorts of medical images. For instance, considering 2D X-ray bones images in order to detect osteoporosis, one can expect getting information on the bone density through  $C_2^*$  and on the bone connectivity through  $C_0^*$ . Both quantities really affect the mechanical bone resistance and should be both evaluated with the target of reducing the number of missclassified patients. Another direction that merits to be explored in the use of 3D images that are now quite common for medical diagnoses. Hence, one should improve our methods by including now four LK curvatures that are directly linked to the bone tissue itself instead of projected images.

In this article, we have not fully used the joint estimation of two (nor three) LK densities. We are not aware of any joint central limit theorem for the LK densities of excursion sets of stationary random fields, except in the case of a Boolean model in [14]. Such a theorem would allow us to get asymptotic confident regions that take into account the whole information of the observed excursion set.

Finally, in the present study, we became aware that the Matlab function by by indo not perform very well yielding bad estimates for  $C_1^*$ . We mentioned this drawback in Section 2. It is certainly due to border effects that are difficult to avoid. An alternative numerical algorithm should be considered in a working paper to improve this point.

# A Technical proofs

# A.1 Proof of Proposition 2.7

Computation of the LK densities for  $\mathcal{T}_k$ . We use (7) after observing that  $\mathcal{T}_k = F(\mathbf{G})$  with  $\mathbf{G} = (G_0, G_1, \dots, G_k)$  and  $F: (x, y) \in \mathbb{R} \times \mathbb{R}^k \mapsto \frac{x}{||y||/\sqrt{k}}$ . Then

$$F^{-1}([u,\infty))) = \left\{ (x,y) \in \mathbb{R} \times \mathbb{R}^k : ||y|| \le \frac{\sqrt{k}}{u} x \right\}, \quad \text{if } u > 0.$$
 (31)




Figure 13: Case k=2. The domain  $F^{-1}([u,\infty))$  in (31) (area delimited by plain lines) and the tube  $Tube(F,\rho)$  around (area delimited by dotted lines), where  $||\mathbf{y}||^2 = \sum_{i=1}^k y_i^2$ ,  $x_0 := \rho \sin(\theta_k) = \frac{\frac{\sqrt{k}}{u}}{\sqrt{1+\frac{k}{u^2}}}$  and  $\tilde{\rho} := \frac{\rho}{\cos\theta_k} = \rho\sqrt{1+\frac{k}{u^2}}$  with  $\theta_k := \arctan\left(\frac{\sqrt{k}}{u}\right)$ .

Denote by  $F_k$  the cumulative chi distribution (the square root of a chi-square random variable) with k degrees of freedom. Using (31) and u > 0, we have that

$$\mathbb{P}\Big(\mathbf{G}(0) \in Tube(F, \rho)\Big) = \int_{x > -x_0} \frac{e^{-x^2/2}}{\sqrt{2\pi}} F_k\Big(\frac{\sqrt{k}}{u}x + \widetilde{\rho}\Big) dx + O(\rho^k),$$

where we have neglected the circular part of  $Tube(F,\rho)$ . Then, using  $x_0 = \frac{\sqrt{k}}{u} \left( \sqrt{1 + \frac{k}{u^2}} \right)^{-1}$ ,  $\tilde{\rho} = \rho \sqrt{1 + \frac{k}{u^2}}$  and that  $F_k(0) = F'_k(0) = 0$ , we get

$$\mathbb{P}\Big(\mathbf{G}(0) \in Tube(F, \rho)\Big) = \int_{x \ge 0} \frac{e^{-x^2/2}}{\sqrt{2\pi}} F_k\Big(\frac{\sqrt{k}}{u}x\Big) dx + \rho \sqrt{1 + \frac{k}{u^2}} \int_{x \ge 0} \frac{e^{-x^2/2}}{\sqrt{2\pi}} F_k'\Big(\frac{\sqrt{k}}{u}x\Big) dx + \frac{1}{2}\rho^2\Big(1 + \frac{k}{u^2}\Big) \int_{x \ge 0} \frac{e^{-x^2/2}}{\sqrt{2\pi}} F_k''\Big(\frac{\sqrt{k}}{u}x\Big) dx + O(\rho^k).$$

The latter formula is established for u > 0. The case u < 0 is derived using symmetry arguments. If u = 0,  $F^{-1}([0,\infty)) = \mathbb{R}_+ \times \mathbb{R}^k$  and Equation (6) becomes

$$\mathbb{P}\Big(\mathbf{G}(0) \in Tube(F, \rho)\Big) = \int_{x > -a} \frac{e^{-x^2/2}}{\sqrt{2\pi}} \times 1 dx = \frac{1}{2} + \rho \frac{1}{\sqrt{2\pi}} + \frac{\rho^2}{2} \times 0 + O(\rho^3).$$

Then, we derive the following formulas, valid for  $k \geq 3$ ,

$$\mathcal{M}_{0}(\mathcal{T}_{k}, u) = \mathbb{P}(Student(k) \geq u) = \begin{cases} \int_{0}^{+\infty} \frac{e^{-x^{2}/2}}{\sqrt{2\pi}} F_{k}(\frac{\sqrt{k}}{u}x) dx & \text{if } u > 0, \\ \frac{1}{2} & \text{if } u = 0, \\ 1 - \int_{0}^{+\infty} \frac{e^{-x^{2}/2}}{\sqrt{2\pi}} F_{k}(\frac{\sqrt{k}}{-u}x) dx & \text{else;} \end{cases}$$

$$\mathcal{M}_{1}(\mathcal{T}_{k}, u) = \begin{cases} (1 + \frac{k}{u^{2}})^{1/2} \int_{0}^{+\infty} \frac{e^{-x^{2}/2}}{\sqrt{2\pi}} F'_{k}(\frac{\sqrt{k}}{|u|}x) dx & \text{if } u \neq 0, \\ \frac{1}{\sqrt{2\pi}} & \text{if } u = 0; \end{cases}$$

$$\mathcal{M}_{2}(\mathcal{T}_{k}, u) = \begin{cases} \operatorname{sign}(u)(1 + \frac{k}{u^{2}}) \int_{0}^{+\infty} \frac{e^{-x^{2}/2}}{\sqrt{2\pi}} F''_{k}(\frac{\sqrt{k}}{|u|}x) dx & \text{if } u \neq 0, \\ 0 & \text{if } u = 0. \end{cases}$$

These quantities can be simplified using the following result  $\mathbb{E}[|\mathcal{N}(0,1)|^k] = \frac{1}{\sqrt{\pi}} 2^{\frac{k}{2}} \Gamma(\frac{k+1}{2})$ . It follows from simple computations that

$$\mathcal{M}_0(\mathcal{T}_k, u) = \mathbb{P}(Student(k) \ge u), \quad \mathcal{M}_1(\mathcal{T}_k, u) = \frac{1}{\sqrt{2\pi}} \left(1 + \frac{u^2}{k}\right)^{\frac{1-k}{2}},$$

$$\mathcal{M}_2(\mathcal{T}_k, u) = \frac{k-1}{2\sqrt{\pi}} \frac{u}{\sqrt{k}} \frac{\Gamma(\frac{k-1}{2})}{\Gamma(\frac{k}{2})} \left(1 + \frac{u^2}{k}\right)^{\frac{1-k}{2}}.$$

Then it is straightforward to derive the asymptotic Minkowski functionals for  $\widetilde{\mathcal{T}}_k$ . The above quantities do not depend on the parameter dimension of the Student field  $\mathcal{T}_k$ , which is equal to 2 in our bivariate context.

Computation of the second spectral moment of  $\mathcal{T}_k$  (Formula (16)). The Student field is isotropic, the second spectral moment is  $\lambda_{Stu} := [\mathbb{V}(\mathcal{T}_k(0)')]_{(1,1)} = \mathbb{V}(\partial_1 \mathcal{T}_k(0))$  where for  $t = (T_1^{(N)}, T_2^{(N)}), \partial_1 f(t) = \frac{\partial f}{\partial T_1^{(N)}}(t)$ . Note that

$$\mathcal{T}_k(t) = \sqrt{k} \frac{G_0(t)}{\sqrt{Z_k(t)}}, \quad t \in \mathbb{R}^2,$$

where  $Z_k = \sum_{i=1}^k G_i(t)^2$  is a chi-square random field with k degrees of freedom independent of the Gaussian field  $G_0$ . We have

$$\partial_1 \mathcal{T}_k(t) = \sqrt{k} \frac{\partial_1 G_0(t) \sqrt{Z_k(t)} - G_0(t) \frac{\partial_1 Z_k(t)}{2\sqrt{Z_k(t)}}}{Z_k(t)} = \sqrt{k} \left( \frac{\partial_1 G_0(t)}{\sqrt{Z_k(t)}} - \frac{1}{2} G_0(t) \frac{\partial_1 Z_k(t)}{Z_k(t)^{3/2}} \right),$$

which is centered, as  $G_0$  and  $\partial_1 G_0$  are independent, centered and independent of  $(Z_k, \partial_1 Z_k)$ . Therefore, we get

$$\lambda_{Stu} = \mathbb{E}[(\partial_1 \mathcal{T}_k(0))^2] = k \left( \lambda \mathbb{E}\left(\frac{1}{Z_k(0)}\right) + \frac{1}{4} \mathbb{E}\left(\frac{\partial_1 Z_k(0)^2}{Z_k(0)^3}\right) \right),$$

where we used that  $G_0$  and  $\partial_1 G_0$  are independent, centered, with unit variance and independent of  $(Z_k, \partial_1 Z_k)$  together with  $\mathbb{E}(\partial_1 G_0(0)^2) := \lambda$ . To complete the computation of  $\lambda_{Stu}$ , we first have that, for  $k \geq 3$ ,  $\mathbb{E}\left(\frac{1}{Z_k(0)}\right) = \frac{1}{k-2}$ . Second, using the definition of a chi-square distribution, it holds that

$$\frac{\partial_1 Z_k(0)^2}{Z_k(0)^3} = 4 \, \frac{\sum_{i,j=1}^k G_i(0) G_j(0) \partial_1 G_i(0) \partial_1 G_j(0)}{\left(\sum_{i=1}^k G_i(0)^2\right)^3}.$$

Taking expectation and using that  $\partial_1 G_i$  is centered and independent of  $((\partial_1 G_j, G_j)_{j \neq i}, G_i)$  together with the definition of  $\lambda$ , we derive that

$$\mathbb{E}\left(\frac{\partial_{1}Z_{k}(0)^{2}}{Z_{k}(0)^{3}}\right) = 4k\lambda\,\mathbb{E}\left(\frac{G_{1}(0)^{2}}{\left(\sum_{i=1}^{k}G_{i}(0)^{2}\right)^{3}}\right) = 4k\lambda\,\mathbb{E}\left(\frac{G_{1}(0)^{2}}{\left(G_{1}(0)^{2} + Z_{k-1}(0)\right)^{3}}\right),$$

where  $Z_{k-1}$  is a chi-square random field with k-1 degrees of freedom and independent of  $G_1$ . Then,

$$\begin{split} I(k) &:= & \mathbb{E}\left(\frac{G_1(0)^2}{\left(\sum_{i=1}^k G_i(0)^2\right)^3}\right) = \frac{1}{\sqrt{2\pi}} \int_{\mathbb{R}} \int_{\mathbb{R}_+} \frac{x^2}{(x^2+z)^3} e^{-(x^2+z)/2} \frac{z^{\frac{k-1}{2}-1}}{2^{\frac{k-1}{2}} \Gamma\left(\frac{k-1}{2}\right)} dz dx \\ &= & \frac{1}{\sqrt{2\pi}} \frac{1}{2^{\frac{k-1}{2}} \Gamma\left(\frac{k-1}{2}\right)} \int_{\mathbb{R}} \int_{\mathbb{R}_+} \frac{x^2}{x^6 (1+y)^3} e^{-x^2 (1+y)/2} \, x^{k-3} \, y^{\frac{k-1}{2}-1} \, x^2 dy dx \quad \text{with } z = x^2 y \\ &= & \frac{1}{2^{\frac{k-1}{2}} \Gamma\left(\frac{k-1}{2}\right)} \int_{\mathbb{R}_+} \frac{y^{\frac{k-3}{2}}}{(1+y)^{5/2}} \left(\int_{\mathbb{R}} \frac{(1+y)^{1/2}}{\sqrt{2\pi}} x^{k-5} e^{-x^2 (1+y)/2} dx\right) dy. \end{split}$$

We recognize the (k-5)-th moment of a  $N(0,(1+y)^{-1})$  random variable in the last line. Let  $\mu(\ell) := \mathbb{E}[N(0,1)^{\ell}]$  with  $\ell \in \mathbb{N}$ , it holds that

$$I(k) = \frac{\mu(k-5)}{2^{\frac{k-1}{2}}\Gamma\left(\frac{k-1}{2}\right)} \int_{\mathbb{R}_+} \frac{u^{\frac{k-3}{2}}}{(1+u)^{k/2}} du = \frac{\mu(k-5)}{2^{\frac{k-1}{2}}\Gamma\left(\frac{k-1}{2}\right)} B\left(\frac{k-1}{2},\frac{1}{2}\right),$$

where B(x,y) denotes the beta function. It simplifies in

$$I(k) = \frac{\mu(k-5)}{2^{\frac{k-1}{2}}\Gamma(\frac{k-1}{2})} \frac{\Gamma(\frac{k-1}{2})\Gamma(\frac{1}{2})}{\Gamma(\frac{k}{2})} = \sqrt{\pi}\mu(k-5) \frac{1}{2^{\frac{k-1}{2}}\Gamma(\frac{k}{2})}.$$

Finally, for  $k \geq 5$ ,

$$\lambda_{Stu} = \lambda k \left( \frac{1}{k-2} + \sqrt{\pi} \frac{\mathbb{E}[N(0,1)^{k-5}]}{2^{\frac{k-1}{2}} \Gamma(\frac{k}{2})} \right) = \begin{cases} \lambda \frac{k}{k-2} & \text{if } k \text{ is even,} \\ \lambda k \left( \frac{1}{k-2} + \frac{\sqrt{\pi}}{2^{k-3}} \frac{(k-5)!}{(\frac{k-5}{2})! \Gamma(\frac{k}{2})} \right) & \text{else.} \end{cases}$$

### A.2 An auxiliary result

In the following we state and prove an auxiliary result which is crucial in the derivation of Proposition 2.11 and Theorem 2.12. In the sequel we will make extensive use of notations and definitions introduced in [7], some of them will be redefined, for the others the reader can refer to [7]. As in section 2.3, we consider a shot-noise field  $S_{\Phi}$  prescribed by

$$S_{\Phi}(t) = \sum_{(x_i, b_i, r_i) \in \Phi} b_i \mathbf{1}_{r_i D}(t - x_i), \ t \in \mathbb{R}^2,$$

where  $\Phi$  is a stationary Poisson point process on  $\mathbb{R}^2 \times \mathbb{R}^* \times \mathbb{R}^+$  with intensity measure  $\nu \operatorname{Leb}_{\mathbb{R}^2} \otimes dF_B \otimes dF_R$  where  $\nu > 0$ ,  $F_B$  is a probability measure on  $\mathbb{R}^*$ ,  $F_R$  is a probability measure on  $\mathbb{R}^+$  and D is the unit disc in  $\mathbb{R}^2$ , well defined under the condition  $\mathbb{E}(|B|)$   $\mathbb{E}(R^2) < +\infty$ , with B and R two random variables with respective distributions  $F_B$  and  $F_R$ .

Since excursion sets of  $S_{\Phi}$  are not always UPR, we need to introduce the level perimeter LP and the level total curvature LTC integrals as introduced in [7]. Using this setting, the excursions  $E_{S_{\Phi}}(u)$  are

elementary sets (see Definition 1 [7]). Then, for a bounded open set U and h a continuous bounded function, one can define

$$\operatorname{LP}_{S_{\Phi}}(h,U) := 2 \int_{\mathbb{R}} h(u) \Phi_{1}(E_{S_{\Phi}}(u), U) du$$

$$\operatorname{LTC}_{S_{\Phi}}(h,U) := \int_{\mathbb{R}} h(u) \operatorname{TC}(\partial E_{S_{\Phi}}(u), U) du = 2\pi \int_{\mathbb{R}} h(u) \Phi_{0}(E_{S_{\Phi}}(u), U) du.$$

Let us consider the distribution  $F(dm) = F_B(db) \times F_R(dr)$  for  $m = (b, r) \in \mathbb{R} \times (0, +\infty) \subset \mathbb{R}^2$  and denote  $g_m(x) = b1_{rD}(x)$  with D the unit disk. The function  $g_m$  is an elementary function on  $\mathbb{R}^2$  (see Definition 3 in [7]) with discontinuity set given by

$$\mathcal{S}_{g_m} = \mathcal{R}_{g_m} = \partial D_r,$$

where  $\partial D_r$  is the circle of radius r. According to Theorem 4 of [7], a.s. for any U bounded open set, the shot noise field  $S_{\Phi}$  is an elementary function on U with discontinuity set given by  $U \cap \mathcal{S}_{S_{\Phi}}$  with

$$S_{S_{\Phi}} = \bigcup_{(x,m)\in\Phi} \tau_x \partial D_r = \mathcal{R}_{S_{\Phi}} \cup \mathcal{I}_{S_{\Phi}},$$

with

$$\mathcal{R}_{S_{\Phi}} = \underset{(x,m) \in \Phi}{\cup} \tau_x \partial D_r \backslash \mathcal{I}_{S_{\Phi}} \text{ for } \mathcal{I}_{S_{\Phi}} = \underset{(x_1,m_1),(x_2,m_2) \in \Phi}{\overset{\neq}{\cup}} \tau_{x_1} \partial D_{r_1} \cap \tau_{x_2} \partial D_{r_2},$$

where  $\tau_x y = x + y$ .



Figure 14: Illustration with an elementary function given by  $f = \mathbf{1}_{D_{r_1}} + \mathbf{1}_{D_{r_2}}$  with  $0 < r_1 < r_2$ . Left: its discontinuity set  $\mathcal{S}_f = \mathcal{R}_f \cup \mathcal{I}_f$  with  $\mathcal{I}_f$  given by the red crosses. Center and Right:  $E_f(1)$  and  $E_f(2)$ : the boundaries are regular except at corner points given by  $\mathcal{I}_f$ .

By Proposition 2 and Theorem 4 of [7], for H a primitive of h and  $\mathcal{H}^1$  the one dimensional Hausdorff measure (recall that  $\mathcal{H}^1(A) = |A|_1$ ), it follows that

$$LP_{S_{\Phi}}(h, U) = \sum_{(x, m) \in \Phi} \int_{\tau_x \partial D_r \cap U} [H(S_{\Phi \setminus \{(x, m)\}}(z) + b^+) - H(S_{\Phi \setminus \{(x, m)\}}(z) + b^-)] \mathcal{H}^1(dz)$$

where we use the fact that  $\mathcal{H}^1(\tau_x \partial D_r \cap \tau_{x'} \partial D_{r'}) = 0$  a.s. for all different points of  $\Phi$  and denote  $b^+ = \max(b, 0)$  and  $b^- = \min(b, 0)$ . Besides, we have  $LTC_{S_{\Phi}}(h, U) = \mathcal{R}_{S_{\Phi}}(h, U) + \mathcal{I}_{S_{\Phi}}(h, U)$ , where

$$\mathcal{R}_{S_{\Phi}}(h,U) = \sum_{(x,m)\in\Phi} \int_{\tau_x\partial D_r\cap U} \left[H(S_{\Phi\setminus\{(x,m)\}}(z) + b^+) - H(S_{\Phi\setminus\{(x,m)\}}(z) + b^-)\right] \operatorname{sign}(b)\kappa_{\partial D_r}(z)\mathcal{H}^1(dz),$$

with  $\kappa_{\partial D_r}(z) = \frac{1}{r}$  the curvature of the curve  $\partial D_r$  at point  $z \in \partial D_r$ , and

$$\mathcal{I}_{S_{\Phi}}(h,U) = \frac{1}{2} \sum_{(x_1,m_1),(x_2,m_2) \in \Phi}^{\neq} \sum_{z \in \tau_{x_1} \partial D_{r_1} \cap \tau_{x_2} \partial D_{r_2} \cap U} \Delta_{b_1,b_2} H(S_{\Phi \setminus \{(x_1,m_1),(x_2,m_2)\}}(z)) \beta_{b_1,b_2}(z),$$

where  $\Delta_{b_1,b_2}H(t) = \left[H(t+b_1^++b_2^+) + H(t+b_1^-+b_2^-) - H(t+b_1^++b_2^-) - H(t+b_1^-+b_2^+)\right]$  and for  $z \in \tau_{x_1}\partial D_{r_1} \cap \tau_{x_2}\partial D_{r_2}$ ,

$$\beta_{b_1,b_2}(z) = \text{dist}\left(\text{sign}(b_1)\frac{x_1 - z}{r_1}, \text{sign}(b_2)\frac{x_2 - z}{r_2}\right),$$

with dist the geodesic distance on the circle.

We can now state the following result that has interest on its own: it allows to obtain uniform bounds for the integral functionals, these bounds being usually hard to obtain when considering an excursion set at a fixed level.

**Proposition A.1** (Moments of  $LP_{S_{\Phi}}$  and  $LTC_{S_{\Phi}}$ ). Assume that  $\mathbb{E}(R^2) < +\infty$  and  $\mathbb{E}(|B|) < +\infty$  and recall that  $\overline{p} = 2\pi \mathbb{E}(R)$  and  $\overline{a} = \pi \mathbb{E}(R^2)$ . Then, for any U bounded open set and any continuous function h with primitive H, one has

i). 
$$\mathbb{E}(LP_{S_{\Phi}}(h,U)) = \nu \overline{p}|U| \int_{\mathbb{R}} \mathbb{E}([H(S_{\Phi}(0)+b^{+})-H(S_{\Phi}(0)+b^{-})]) F_{B}(db);$$

ii). 
$$\mathbb{E}\left(\mathrm{LTC}_{S_{\Phi}}(h,U)\right) = 2\pi\nu|U| \int_{\mathbb{R}} \mathbb{E}\left(\left[H(S_{\Phi}(0)+b^{+})-H(S_{\Phi}(0)+b^{-})\right]\right) sign(b)F_{B}(db) + \frac{(\nu\bar{p})^{2}}{2}|U| \int_{\mathbb{R}^{2}} \mathbb{E}\left(\Delta_{b_{1},b_{2}}H(S_{\Phi}(0))\right)F_{B}(db_{1})F_{B}(db_{2}).$$

Moreover, when  $R \leq R_{\max}$  a.s. for some positive constant  $R_{\max}$  and H is bounded, one has

iii). 
$$Var(LP_{S_{\Phi}}(h, U))) \leq C_H |U| \left( (R_{max} \nu \overline{p})^2 + \nu \overline{a} \right);$$

iv). 
$$Var(LTC_{S_{\Phi}}(h, U)) \leq C_H |U| \left\{ \left( (R_{max}\nu)^2 + \nu \right) + (\nu \overline{p})^2 \left( (R_{max}\nu \overline{p})^2 + \nu \overline{a} + 1 \right) \right\},$$

for a constant  $C_H$  that only depends on  $||H||_{\infty}$  and such that  $C_H \leq 2^7 \pi ||H||_{\infty}^2$ .

*Proof.* i). Let us introduce

$$f_h^{(1)}((x,m),\Phi) = \int_{\mathcal{T}_x \partial D_x \cap U} [H(S_{\Phi}(z) + b^+) - H(S_{\Phi}(z) + b^-)] \mathcal{H}^1(dz)$$

such that  $LP_{S_{\Phi}}(h, U) = \sum_{(x,m)\in\Phi} f_h^{(1)}((x,m), \Phi\setminus\{(x,m)\})$ . It follows from the reduced Campbell formula (see e.g. [4] Theorem 1.4.3),

$$\mathbb{E}\big(\mathrm{LP}_{S_{\Phi}}(h,U)\big) = \int_{\mathbb{R}^2 \times \mathbb{R}^2} \mathbb{E}\left(f_h^{(1)}((x,m),\Phi)\right) \nu dx F(dm),$$

with  $\mathbb{E}\left(f_h^{(1)}((x,m),\Phi)\right) = \mathbb{E}\left(\left[H(S_{\Phi}(0)+b^+)-H(S_{\Phi}(0)+b^-)\right]\right)\mathcal{H}^1\left(\tau_x\partial D_r\cap U\right)$  by stationarity of  $S_{\Phi}$ . Hence,

$$\mathbb{E}\left(\operatorname{LP}_{S_{\Phi}}(h, U)\right) = \nu |U| \int_{\mathbb{R}} \mathcal{H}^{1}\left(\partial D_{r}\right) F_{R}(dr) \int_{\mathbb{R}} \mathbb{E}\left(\left[H(S_{\Phi}(0) + b^{+}) - H(S_{\Phi}(0) + b^{-})\right]\right) F_{B}(db)$$

$$= |U| \nu \overline{p} \int_{\mathbb{R}} \mathbb{E}\left(\left[H(S_{\Phi}(0) + b^{+}) - H(S_{\Phi}(0) + b^{-})\right]\right) F_{B}(db).$$

iii). It holds that

$$(\operatorname{LP}_{S_{\Phi}}(h, U))^{2} = \sum_{(x_{1}, m_{1}) \in \Phi} f_{h}^{(1)}((x_{1}, m_{1}), \Phi \setminus \{(x_{1}, m_{1})\})^{2}$$

$$+ \sum_{(x_{1}, m_{1}), (x_{2}, m_{2}) \in \Phi}^{\neq} f_{h}^{(2)}((x_{1}, m_{1}), (x_{2}, m_{2}), \Phi \setminus \{(x_{1}, m_{1}), (x_{2}, m_{2})\}),$$

where

$$\begin{split} &f_h^{(2)}((x_1,m_1),(x_2,m_2),\Phi\backslash\{(x_1,m_1),(x_2,m_2)\})\\ &=f_h^{(1)}((x_1,m_1),\Phi\backslash\{(x_1,m_1)\})f_h^{(1)}((x_2,m_2),\Phi\backslash\{(x_2,m_2)\})\\ &=\int_{\mathcal{T}_{T_1}\partial D_{T_2}\cap U}\int_{\mathcal{T}_{T_2}\partial D_{T_2}\cap U}K_h((x_1,m_1),(x_2,m_2),\Phi\backslash\{(x_1,m_1),(x_2,m_2)\})(z_1,z_2)\mathcal{H}^1(dz_2)\mathcal{H}^1(dz_1) \end{split}$$

for

$$K_h((x_1, m_1), (x_2, m_2), \Phi)(z_1, z_2) = [H(S_{\Phi}(z_1) + \tau_{x_2} g_{m_2}(z_1) + b_1^+) - H(S_{\Phi}(z_1) + \tau_{x_2} g_{m_2}(z_1) + b_1^-)] \times [H(S_{\Phi}(z_2) + \tau_x, g_{m_1}(z_2) + b_2^+) - H(S_{\Phi}(z_2) + \tau_x, g_{m_2}(z_2) + b_2^-)].$$

Since  $R \leq R_{max}$  a.s, for any  $|z-z'| > 2R_{max}$ , the variables  $S_{\Phi}(z)$  and  $S_{\Phi}(z')$  are independent.

Firstly, it holds

$$\mathbb{E}\left(\sum_{(x_1,m_1),(x_2,m_2)\in\Phi}^{\neq} f_h^{(2)}((x_1,m_1),(x_2,m_2),\Phi\setminus\{(x_1,m_1),(x_2,m_2)\})\right)$$

$$=\int_{\mathbb{R}^2\times\mathbb{R}^2} \int_{\mathbb{R}^2\times\mathbb{R}^2} \mathbb{E}(f_h^{(2)}((x_1,m_1),(x_2,m_2),\Phi)\nu^2 dx_1 F(dm_1) dx_2 F(dm_2) := I_1 + I_2,$$

where we split the integral over the domains  $|x_1 - x_2| \le 4R_{\text{max}}$  and  $|x_1 - x_2| > 4R_{\text{max}}$ . Indeed, for  $|x_1 - x_2| > 4R_{\text{max}}$  we have  $|z_j - x_i| > 3R_{\text{max}}$  for any  $\{i, j\} = \{1, 2\}$  and  $z_j \in \tau_{x_j} \partial D_{\tau_j}$  so that  $\tau_{x_i} g_{m_i}(z_j) = 0$ . By independence, we get that

$$I_{2} = \left(\mathbb{E}(LP_{S_{\Phi}}(h, U))\right)^{2} - \int_{\mathbb{R}^{2} \times \mathbb{R}^{2}} \int_{\mathbb{R}^{2} \times \mathbb{R}^{2}} 1_{|x_{1} - x_{2}| \leq 4R_{\max}} \mathbb{E}(f_{h}^{(1)}((x_{1}, m_{1}), \Phi)\mathbb{E}(f_{h}^{(1)}((x_{2}, m_{2}), \Phi)\nu^{2} dx_{1} F(dm_{1}) dx_{2} F(dm_{2}).$$

Hence

$$I_1 + I_2 = \left( \mathbb{E}(LP_{S_{\Phi}}(h, U)) \right)^2 + \nu^2 \Delta_h(U),$$

with

$$\Delta_h(U) = \int_{\mathbb{R}^2 \times \mathbb{R}^2} \int_{\mathbb{R}^2 \times \mathbb{R}^2} 1_{|x_1 - x_2| \le 4R_{\max}} \Delta_h(U, (x_1, m_1), (x_2, m_2)) dx_1 F(dm_1) dx_2 F(dm_2),$$

for

$$\Delta_h(U,(x_1,m_1),(x_2,m_2)) = \left(\mathbb{E}(f_h^{(2)}((x_1,m_1),(x_2,m_2),\Phi) - \mathbb{E}(f_h^{(1)}((x_1,m_1),\Phi)\mathbb{E}(f_h^{(1)}((x_2,m_2),\Phi))\right).$$

As H is bounded, we have  $|f_h^{(1)}((x,m),\Phi)| \leq 2\|H\|_{\infty}\mathcal{H}^1(\tau_x\partial D_r \cap U)$ , so that

$$|\Delta_h(U,(x_1,m_1),(x_2,m_2))| \le 8||H||_{\infty}^2 \mathcal{H}^1(\tau_{x_1}\partial D_{r_1}\cap U)\mathcal{H}^1(\tau_{x_2}\partial D_{r_2}\cap U).$$

It follows that, for  $C_H := 2^7 \pi ||H||_{\infty}^2$ ,

$$\Delta_h(U) \le 8\|H\|_{\infty}^2 |U| \times \pi (4R_{max})^2 \left( \int_{\mathbb{R}} \mathcal{H}^1(\partial D_r) F(dr) \right)^2 \le C_H R_{max}^2 |U| \overline{p}^2.$$

Secondly,

$$\mathbb{E}\Big(\sum_{(x_1,m_1)\in\Phi} f_h^{(1)}(x_1,m_1), \Phi\setminus\{(x_1,m_1)\})^2\Big) = \int_{\mathbb{R}^2\times\mathbb{R}^2} \mathbb{E}\left(f_h^{(1)}((x,m),\Phi)^2\right) \nu F(dm) dx \\
\leq \nu |U|4||H||_{\infty}^2 \int_{\mathbb{R}} \mathcal{H}^1 \left(\partial D_r\right)^2 F(dr) \leq 16\pi ||H||_{\infty}^2 |U| \nu \overline{a}.$$

Hence, we obtain

$$\operatorname{Var}\left(\operatorname{LP}_{S_{\Phi}}(h, U)\right) \leq C_{H}|U|\left(R_{max}^{2} \nu^{2} \overline{p}^{2} + \nu \overline{a}\right).$$

ii). iv). Recall that  $LTC_{S_{\Phi}}(h, U) = \mathcal{R}_{S_{\Phi}}(h, U) + \mathcal{I}_{S_{\Phi}}(h, U)$ . Then, we bound the expectation and variance of  $\mathcal{R}_{S_{\Phi}}(h, U)$  and  $\mathcal{I}_{S_{\Phi}}(h, U)$  separately.

First consider  $\mathcal{R}_{S_{\Phi}}(h,U)$ , we prove similarly

$$\mathbb{E}\left(\mathcal{R}_{S_{\Phi}}(h,U)\right) = \nu|U| \int_{\mathbb{R}} \frac{\mathcal{H}^{1}\left(\partial D_{r}\right)}{r} F(dr) \int_{\mathbb{R}} \mathbb{E}\left(\left[H(S_{\Phi}(0) + b^{+}) - H(S_{\Phi}(0) + b^{-})\right]\right) \operatorname{sign}(b) F_{B}(db),$$

$$= 2\pi\nu|U| \int_{\mathbb{R}} \mathbb{E}\left(\left[H(S_{\Phi}(0) + b^{+}) - H(S_{\Phi}(0) + b^{-})\right]\right) \operatorname{sign}(b) F_{B}(db),$$

and

$$\mathbb{E}\left(\left(\mathcal{R}_{S_{\Phi}}(h,U)\right)^{2}\right) = \mathbb{E}\left(\mathcal{R}_{S_{\Phi}}(h,U)\right)^{2} + \widetilde{\Delta}_{h}(U), \quad \text{with } |\widetilde{\Delta}_{h}(U)| \leq C_{H}|U|\left(R_{max}^{2}\nu^{2} + \nu\right).$$

Now, let us focus on  $\mathcal{I}_{S_{\Phi}}(h,U)$ . We have

$$\mathcal{I}_{S_{\Phi}}(h,U) = \frac{1}{2} \sum_{(x_1,m_1),(x_2,m_2) \in \Phi}^{\neq} f_h^{(2)}((x_1,m_1),(x_2,m_2),\Phi \setminus \{(x_1,m_1),(x_2,m_2)\}),$$

where

$$f_h^{(2)}((x_1,m_1),(x_2,m_2),\Phi) = \sum_{z \in \tau_{x_1} \partial D_{r_1} \cap \tau_{x_2} \partial D_{r_2} \cap U} \Delta_{b_1,b_2} H(S_{\Phi}(z)) \beta_{b_1,b_2}(z).$$

It holds that

 $\mathbb{E}\left(\mathcal{I}_{S_{\pi}}(h,U)\right)$ 

$$\begin{split} &= \frac{1}{2} \int_{\mathbb{R}^4} \int_{\mathbb{R}^4} \mathbb{E} \left( f_h^{(2)}((x_1, m_1), (x_2, m_2), \Phi) \right) \nu^2 dx_1 F(dm_1) dx_2 F(dm_2) \\ &= \frac{1}{2} \int_{\mathbb{R}^4} \int_{\mathbb{R}^4} \sum_{z \in \tau_{x_1} \partial D_{r_1} \cap \tau_{x_2} \partial D_{r_2} \cap U} \mathbb{E} (\Delta_{b_1, b_2} H(S_{\Phi}(z))) \beta_{b_1, b_2}(z) \nu^2 dx_1 F(dm_1) dx_2 F(dm_2) \\ &= \frac{\nu^2 |U|}{2} \int_{\mathbb{R}^2} \mathbb{E} (\Delta_{b_1, b_2} H(S_{\Phi}(0))) \left( \int_{\mathbb{R}^4} \sum_{z \in \partial D_{\tau_1} \cap \tau_{\tau_2} \partial D_{\tau_2}} \operatorname{dist}(\operatorname{sign}(b_1) \frac{-z}{r_1}, \operatorname{sign}(b_2) \frac{x-z}{r_2})) dx dr_1 dr_2 \right) F_B(db_1) F_B(db_2) \end{split}$$

with, by kinematic formula (see Lemma 1 in [7] for instance),

$$\int_{\mathbb{R}^2} \sum_{z \in \partial D_{r_1} \cap \tau_x \partial D_{r_2}} \operatorname{dist}(\operatorname{sign}(b_1) \frac{-z}{r_1}, \operatorname{sign}(b_2) \frac{x-z}{r_2})) dx = \mathcal{H}^1(\partial D_{r_1}) \mathcal{H}^1(\partial D_{r_2}).$$

It follows that

$$\mathbb{E}\left(\mathcal{I}_{S_{\Phi}}(h,U)\right) = \frac{(\nu \overline{p})^2 |U|}{2} \int_{\mathbb{R}^2} \mathbb{E}(\Delta_{b_1,b_2} H(S_{\Phi}(0))) F_B(db_1) F_B(db_2).$$

Let us write

$$\begin{split} & (\mathcal{I}_{S_{\Phi}}(h,U))^{2} \\ & = \frac{1}{4} \left( \sum_{(x_{1},m_{1}),(x_{2},m_{2})\in\Phi}^{\neq} f_{h}^{(2)}((x_{1},m_{1}),(x_{2},m_{2}),\Phi\setminus\{(x_{1},m_{1}),(x_{2},m_{2})\}) \right)^{2} \\ & = \frac{1}{4} \sum_{(x_{1},m_{1}),\dots,(x_{4},m_{4})\in\Phi}^{\neq} f_{h}^{(4)}((x_{1},m_{1}),\dots,(x_{4},m_{4}),\Phi\setminus\{(x_{1},m_{1}),\dots,(x_{4},m_{4})\} \\ & + \sum_{(x_{1},m_{1}),(x_{2},m_{2}),(x_{3},m_{3})\in\Phi}^{\neq} f_{h}^{(3)}((x_{1},m_{1}),(x_{2},m_{2}),(x_{3},m_{3}),\Phi\setminus\{(x_{1},m_{1}),(x_{2},m_{2}),(x_{3},m_{3})\} \\ & + \frac{1}{4} \sum_{(x_{1},m_{1}),(x_{2},m_{2})\in\Phi}^{\neq} \left( f_{h}^{(2)}((x_{1},m_{1}),(x_{2},m_{2}),\Phi\setminus\{(x_{1},m_{1}),(x_{2},m_{2})\}) \right)^{2} := I_{1}(\Phi) + I_{2}(\Phi) + I_{3}(\Phi), \end{split}$$

where

$$\begin{split} f_h^{(4)}((x_1,m_1),\ldots,(x_4,m_4),\Phi\backslash\{(x_1,m_1),\ldots,(x_4,m_4)\}) \\ &= f_h^{(2)}((x_1,m_1),(x_2,m_2),\Phi\backslash\{(x_1,m_1),(x_1,m_2)\}) f_h^{(2)}((x_3,m_3),(x_4,m_4),\Phi\backslash\{(x_3,m_3),(x_4,m_4)\}) \\ &= \sum_{z\in\tau_{x_1}\partial D_{r_1}\cap\tau_{x_2}\partial D_{r_2}\cap U} \sum_{z'\in\tau_{x_3}\partial D_{r_3}\cap\tau_{x_4}\partial D_{r_4}\cap U} \Delta_{b_1,b_2} H(S_{\Phi\backslash\{(x_1,m_1),\ldots,(x_4,m_4)\}}(z) + \tau_{x_3}g_{m_3}(z) + \tau_{x_4}g_{m_4}(z)) \\ &\times \beta_{b_1,b_2}(z)\Delta_{b_3,b_4} H(S_{\Phi\backslash\{(x_1,m_1),\ldots,(x_4,m_4)\}}(z') + \tau_{x_1}g_{m_1}(z') + \tau_{x_2}g_{m_2}(z'))\beta_{b_3,b_4}(z'), \end{split}$$

and, by symmetry,

$$\begin{split} f_h^{(3)}((x_1,m_1),(x_2,m_2),(x_3,m_3),\Phi\backslash\{(x_1,m_1),(x_2,m_2),(x_3,m_3)\}) \\ &= \sum_{z\in\tau_{x_1}\partial D_{r_1}\cap\tau_{x_2}\partial D_{r_2}\cap U} \sum_{z'\in\tau_{x_3}\partial D_{r_3}\cap\tau_{x_1}\partial D_{r_1}\cap U} \Delta_{b_1,b_2} H(S_{\Phi\backslash\{(x_1,m_1),...,(x_3,m_3)\}}(z) + \tau_{x_3}g_{m_3}(z)) \\ &\times \beta_{b_1,b_2}(z)\Delta_{b_3,b_1} H(S_{\Phi\backslash\{(x_1,m_1),...,(x_3,m_3)\}}(z') + \tau_{x_1}g_{m_1}(z'))\beta_{b_1,b_3}(z'). \end{split}$$

Hence, we can also write

$$\mathbb{E}\left(I_1(\Phi)\right) = \left(\mathbb{E}\left(\mathcal{I}_{S_{\Phi}}(h, U)\right)\right)^2 + \nu^4 \widetilde{\widetilde{\Delta}}_h(U),$$

with

$$\widetilde{\widetilde{\Delta}}_{h}(U) = \frac{1}{4} \int_{\mathbb{R}^{16}} \mathbf{1}_{|x_{1} - x_{3}| \leq 4R_{max}} \widetilde{\widetilde{\Delta}}_{h}(U, (x_{1}, m_{1}), \dots, (x_{4}, m_{4})) dx_{1} F(dm_{1}) \dots dx_{4} F(dm_{4}),$$

for

$$\left| \widetilde{\widetilde{\Delta}}_{h}(U, (x_{1}, m_{1}), \dots, (x_{4}, m_{4})) \right| \leq 2(4\|H\|_{\infty})^{2} \sum_{z \in \tau_{x_{1}} \partial D_{r_{1}} \cap \tau_{x_{2}} \partial D_{r_{2}} \cap U} \sum_{z' \in \tau_{x_{3}} \partial D_{r_{3}} \cap \tau_{x_{4}} \partial D_{r_{4}} \cap U} \beta_{b_{1}, b_{2}}(z) \beta_{b_{3}, b_{4}}(z') dx_{1} F(dm_{1}) \dots dx_{4} F(dm_{4}),$$

Therefore,  $|\widetilde{\widetilde{\Delta}}_h(U)| \leq C_H |U| R_{max}^2 \overline{p}^4$ . Similar arguments lead to

$$|\mathbb{E}(I_2(\Phi))| \le C_H \nu^3 |U| \overline{p}^2 \overline{a}$$
 and  $|\mathbb{E}(I_3(\Phi))| \le C_H \nu^2 |U| \overline{p}^2$ ..

Finally, since  $\operatorname{Var}(\mathcal{I}_{S_{\Phi}}(h,U)) = \mathbb{E}(I_1(\Phi)) + \mathbb{E}(I_1(\Phi)) + \mathbb{E}(I_1(\Phi)) - (\mathbb{E}(\mathcal{I}_{S_{\Phi}}(h,U)))^2$ , we obtain

$$\operatorname{Var}\left(\mathcal{I}_{S_{\Phi}}(h,U)\right) \leq C_H |U|(\nu \overline{p})^2 \left( (R_{max} \nu \overline{p})^2 + \nu \overline{a} + 1 \right).$$

### A.3 Proof of Lemma 2.10

From now on we assume that B is a discrete random variable with values in  $\mathbb{Z}^*$ . Then, the random field  $S_{\Phi}$  has values in  $\mathbb{Z}$ , and it follows that for all  $u \in \mathbb{R}$ ,  $E_{S_{\Phi}}(u) = E_{S_{\Phi}}(\lceil u \rceil)$ . For  $u \in \mathbb{Z}$ , choosing h a continuous function with compact support in (0,1) and such that  $\int_{\mathbb{R}} h(t)dt = 1$  one has

$$\Phi_1(E_{S_{\Phi}}(u), U) = \frac{1}{2} LP_{S_{\Phi}}(\tau_{u-1}h, U) \text{ and } \Phi_0(E_{S_{\Phi}}(u), U) = \frac{1}{2\pi} LTC_{S_{\Phi}}(\tau_{u-1}h, U),$$

where  $\tau_{u-1}h(t)=h(t-(u-1))$  vanishes outside of (u-1,u). Now, considering for  $t\neq 0$ , the function  $h_t(u)=e^{iut}$  we can compute the Fourier transforms of  $u\mapsto \frac{1}{|U|}\mathbb{E}\left(\Phi_j(E_{S_\Phi}(u),U)\right)$  as  $\frac{1}{2|U|}\mathbb{E}\left(\operatorname{LP}_{S_\Phi}(h_t,U)\right)$  for j=1 and  $\frac{1}{2\pi|U|}\mathbb{E}\left(\operatorname{LTC}_{S_\Phi}(h_t,U)\right)$  for j=0. We obtain the right members of (18) and (19) using Proposition A.1 i) and ii), with  $H_t(u)=\frac{e^{itu}-1}{it}$ . The link with  $C_j^*(S_\Phi,u)$  is given in the next proposition.

**Proposition A.2.** For all  $u \in \mathbb{Z}$ ,

- $\left(\mathbb{E}\left(C_1^{/T}(S_{\Phi}, u) \frac{\Phi_1(E_{S_{\Phi}}(u), \mathring{T})}{|T|}\right)^2\right)^{1/2} \leq \frac{|\partial T|_1}{|T|};$
- $\left(\mathbb{E}\left(C_0^{/T}(S_{\Phi}, u) \frac{\Phi_0(E_{S_{\Phi}}(u), \hat{T})}{|T|}\right)^2\right)^{1/2} \le 2\nu \overline{p} \frac{|\partial T|_1}{|T|}$ , as soon as  $\nu \overline{p} |\partial T|_1 > 1$ .

As a consequence  $C_j^*(S_{\Phi}, u)$  exists for  $j \in \{0, 1\}$  and is equal to  $\frac{\mathbb{E}(\Phi_j(E_{S_{\Phi}}(u), U))}{|U|}$ , for any bounded open set U.

*Proof.* Let us remark that the boundary contributions (see Figure 2 of [7]) may be controlled using the fact that a.s.

$$\left| C_1^{/T}(S_{\Phi}, u) - \Phi_1(E_{S_{\Phi}}(u), \mathring{T}) \right| \le |\partial T|_1 \text{ and } \left| C_0^{/T}(S_{\Phi}, u) - \Phi_0(E_{S_{\Phi}}(u), \mathring{T}) \right| \le \frac{1}{2} \# (\mathcal{S}_{S_{\Phi}} \cap \partial T) + 1,$$

where we use that T being a rectangle the curvature is 0 on its boundary except at corner points where it is  $\frac{\pi}{2}$ . Dividing by |T| we immediately get the first point. For the second one, since  $S_{S_{\Phi}} = \bigcup_{i} \tau_{x_{i}} \partial D_{r_{i}}$ , with  $\tau_{x_{i}} \partial D_{r_{i}} \cap \tau_{x_{j}} \partial D_{r_{j}} \cap \partial T = \emptyset$  a.s. as soon as  $i \neq j$ , we have

$$\#\left(\mathcal{S}_{S_{\Phi}}\cap\partial T\right)=\sum_{i}\#\left(\tau_{x_{i}}\partial D_{r_{i}}\cap\partial T\right)a.s.$$

It follows that

$$\mathbb{E}\left(\#\left(\mathcal{S}_{S_{\Phi}}\cap\partial T\right)\right) = \int_{\mathbb{R}^{2}\times\mathbb{R}^{+}} \#\left(\tau_{x}\partial D_{r}\cap\partial T\right)\nu dx F_{R}(dr).$$

But, again kinematic formula (see Lemma 1 of [7]) yields

$$\int_{\mathbb{D}^2} \# \left( \tau_x \partial D_r \cap \partial T \right) dx = 4r |\partial T|_1,$$

so that

$$\mathbb{E}\left(\#\left(\mathcal{S}_{S_{\Phi}}\cap\partial T\right)\right) = \frac{2}{\pi}\nu\overline{p}|\partial T|_{1}.$$

Moreover,

$$\operatorname{Var}\left(\#\left(\mathcal{S}_{S_{\Phi}}\cap\partial T\right)\right) = \int_{\mathbb{R}^{2}\times\mathbb{R}^{+}} \left(\#\left(\tau_{x}\partial D_{r}\cap\partial T\right)\right)^{2} \nu dx F_{R}(dr) \leq \frac{4}{\pi}\nu\overline{p}|\partial T|_{1},$$

since  $\#(\tau_x \partial D_r \cap \partial T) \leq 2$ . Therefore,

$$\mathbb{E}((\#(\mathcal{S}_{S_{\Phi}}\cap\partial T))^2) = \operatorname{Var}(\#(\mathcal{S}_{S_{\Phi}}\cap\partial T)) + \mathbb{E}(\#(\mathcal{S}_{S_{\Phi}}\cap\partial T))^2 \leq \frac{4}{\pi}\nu\overline{p}|\partial T|_1(1 + \frac{1}{\pi}\nu\overline{p}|\partial T|_1) \leq 2\left(\nu\overline{p}|\partial T|_1\right)^2,$$

as soon as  $\nu \overline{p} |\partial T|_1 \ge 1$ . The second bound is obtained dividing by |T| and using the fact that  $\sqrt{2}/2+1 \le 2$ . Now we have

$$\left| \mathbb{E}\left( C_j^{/T}(S_{\Phi}, u) \right) - \frac{\mathbb{E}(\Phi_j(E_{S_{\Phi}}(u), \mathring{T}))}{|\mathring{T}|} \right| \leq \mathbb{E}\left( \left| \|C_j^{/T}(S_{\Phi}, u) - \frac{\Phi_1(E_{S_{\Phi}}(u), \mathring{T})}{|T|} \right| \right) \leq \max(1, \nu \overline{p}) \frac{|\partial T|_1}{|T|},$$

by the previous bound. This allows us to prove that  $C_j^*(S_{\Phi}, u)$ , j = 0, 1 exist as the limit of  $\mathbb{E}(C_j^{/T}(S_{\Phi}, u))$  when  $T \nearrow \mathbb{R}^2$ .

#### A.4 Proof of Theorem 2.12

We work under the same assumptions as in Sections A.2 and A.3. We furthermore assume that  $R \leq R_{\text{max}}$  a.s. Denote by  $||Z||_2 := (\mathbb{E}(Z^2))^{1/2}$ , then we write

$$\|C_j^{/T}(S_{\Phi}, u) - C_j^*(S_{\Phi}, u)\|_2 \le \left\|C_j^{/T}(S_{\Phi}, u) - \frac{\Phi_j(E_{S_{\Phi}}(u), \mathring{T})}{|T|}\right\|_2 + \left\|\frac{\Phi_j(E_{S_{\Phi}}(u), \mathring{T})}{|T|} - C_j^*(S_{\Phi}, u)\right\|_2.$$

The first term is bounded by  $\max(2\nu \overline{p}, 1) \frac{|\partial T|_1}{|T|}$  by Proposition A.2. Moreover, using  $R \leq R_{\max}$  a.s. and choosing h a non-negative continuous function with compact support in (0,1) such that  $\int_{\mathbb{R}} h(t)dt = 1$ ,

$$\left\| \frac{\Phi_1(E_{S_{\Phi}}(u), \mathring{T})}{|T|} - C_1^*(S_{\Phi}, u) \right\|_2^2 = \frac{1}{4|T|^2} \operatorname{Var} \left( \operatorname{LP}_{S_{\Phi}}(\tau_{u-1}h, \mathring{T}) \right) \leq \frac{C}{4|T|} \left( R_{\max}^2 \nu^2 \overline{p}^2 + \nu \overline{a} \right),$$

by Proposition A.1, since we can choose a primitive of  $\tau_{u-1}h$  uniformly bounded by 1. Similarly, we obtain

$$\left\| \frac{\Phi_0(E_{S_{\Phi}}(u), \mathring{T})}{|T|} - C_0^*(S_{\Phi}, u) \right\|_2^2 = \frac{1}{4\pi^2 |T|^2} \operatorname{Var} \left( \operatorname{LTC}_{S_{\Phi}}(\tau_{u-1}h, \mathring{T}) \right) \\ \leq \frac{C}{2\pi^2 |T|} \left( (R_{\max} \nu)^2 + \nu + (\nu \overline{p})^2 \left( (R_{\max} \nu \overline{p})^2 + \nu \overline{a} + 1 \right) \right).$$

Finally,

$$||C_2^{/T}(S_{\Phi}, u) - C_2^*(S_{\Phi}, u)||_2^2 = \frac{1}{|T|^2} \int_{T \times T} \operatorname{Cov}\left(1_{S_{\Phi}(x) \ge u}, 1_{S_{\Phi}(y) \ge u}\right) dx dy \le \frac{4\pi R_{\max}^2}{|T|},$$

using the fact that  $S_{\Phi}(x)$  and  $S_{\Phi}(y)$  are independent as soon as  $|x-y|>2R_{\max}$ . By the triangle inequality, we obtain the result for  $\widehat{C_{j,T}}(S_{\Phi},u), j\in\{0,1,2\}$ .
