# A SURFACE OF DEGREE 24 WITH 1440 SINGULARITIES OF TYPE $D_{4}$

#### Abstract

Using the invariant algebra of the complex reflection group denoted by $G_{32}$ in the Shephard-Todd classification, we construct three irreducible surfaces in $\mathbf{P}^{3}(\mathbb{C})$ with many singularities: one of them has degree 24 and contains 1440 quotient singularities of type $D_{4}$.


Let $\mu_{D_{4}}(d)$ denote the maximal number of quotient singularities of type $D_{4}$ that an irreducible projective surface of degree $d$ in $\mathbf{P}^{3}(\mathbb{C})$ might have. Miyaoka [Miy] proved that

$$
\mu_{D_{4}}(d) \leqslant \frac{16}{117} d(d-1)^{2} .
$$

For $d=8,16$ or 24 , this reads

$$
\mu_{D_{4}}(8) \leqslant 53, \quad \mu_{D_{4}}(16) \leqslant 492 \quad \text { and } \quad \mu_{D_{4}}(24) \leqslant 1736 .
$$

The main results of this note are that

$$

\mu_{D_{4}}(8) \geqslant 44, \quad \mu_{D_{4}}(16) \geqslant 352 \quad \text { and } \quad \mu_{D_{4}}(24) \geqslant 1440 \tag{1}
\end{equation*}
$$

and that

$$
\begin{equation*}
\mu_{D_{4}}(8 k) \geqslant 44 k^{3} \tag{2}
\end{equation*}
$$

for all $k \geqslant 1$. So, let $\mathbb{C}\left[x_{1}, x_{2}, x_{3}, x_{4}\right]$ be the polynomial ring over $\mathbb{C}$ in 4 indeterminates with its usual grading and let $\mathbf{P}^{3}(\mathbb{C})=\operatorname{Proj}\left(\mathbb{C}\left[x_{1}, x_{2}, x_{3}, x_{4}\right]\right)$ be the associated projective space of dimension 3. If $f \in \mathbb{C}\left[x_{1}, x_{2}, x_{3}, x_{4}\right]$ is homogeneous, we denote by $\mathscr{Z}(f)$ the projective hypersurface it defines, and by $\mathscr{Z}(f)_{\text {sing }}$ its reduced singular locus. If $k$ is a natural number, we denote by $f[k]$ the homogeneous polynomial $f\left(x_{1}^{k}, x_{2}^{k}, x_{3}^{k}, x_{4}^{k}\right)$. We aim to prove the following result:

Theorem 1. There exists a homogenous polynomial g of degree 8 such that:
(a) $\mathscr{Z}(g)$ is an irreducible surface of degree 8 in $\mathbf{P}^{3}(\mathbb{C})$ with exactly 44 singular points which are all quotient singularities of type $D_{4}$.
(b) If $k \geqslant 1$, then $\mathscr{Z}(g[k])$ is an irreducible surface of degree $8 k$, whose singular locus has dimension 0 and contains at least $44 k^{3}$ quotient singularities of type $D_{4}$.
(c) $\mathscr{Z}(g[2])$ is an irreducible surface of degree 16 with exactly 472 singular points: 24 quotient singularities of type $A_{1}, 96$ quotient singularities of type $A_{2}$ and 352 quotient singularities of type $D_{4}$.
(d) $\mathscr{Z}(g[3])$ is an irreducible surface of degree 24 in $\mathbf{P}^{3}(\mathbb{C})$ with exactly 1440 singular points which are all quotient singularities of type $D_{4}$. The automorphism group of $\mathscr{Z}(g[3])$ contains at least 25920 elements and acts transitively on the 1440 singular points.

The proof relies on extensive MAGMA computations [Magma], and goes as follow. Let

This is the polynomial of Theorem 1. It has coefficients in $\mathbb{Q}$ but note for instance that the singular points of $\mathscr{Z}(g), \mathscr{Z}(g[2])$ and $\mathscr{Z}(g[3])$ have coordinates in various field extensions of $\mathbb{Q}$, and most of the singular points are not real (at least in this model). So, let $\xi$ denote a primitive 24 -th root of unity and let $\zeta=\xi^{2}, \zeta_{4}=\zeta^{3}$ and $\zeta_{3}=\zeta^{4}$, so that $\zeta, \zeta_{4}$ and $\zeta_{3}$ are roots of unity of order 12, 4 and 3 respectively. Let $\alpha$ be a square root of

$$
18 \xi^{6}+14 \xi^{5}+48 \xi^{4}+2 \xi^{3}-36 \xi^{2}-14 \xi-24 .
$$

Let $K$ denote the cyclotomic field $\mathbb{Q}(\zeta)$ and let $L=\mathbb{Q}(\xi, \alpha)$ : it is a Galois extension of $\mathbb{Q}$. We will check that the singular points of $\mathscr{Z}(g)$ and $\mathscr{Z}(g[3])$ are defined over $K$, while the singular points of $\mathscr{Z}(g[2])$ are defined over $L$.

Remark 1. As we will see in the computations below, the polynomial $g[3]$ is invariant under the action of the complex reflection group denoted by $G_{32}$ in the Shephard-Todd classification [ShTo]. In fact, we did not find $g$ directly: we found first $g[3]$ by looking at invariants of degree 24 of $G_{32}$, following ideas of Barth [Bar] and Sarti [Sar1], [Sar2], [Sar3] (for constructing the Barth sextic with 65 nodes and, for instance, the Sarti surface of degree 12 with 600 nodes), who used invariants of Coxeter groups of type $H_{3}$ and $H_{4}$.

Remark 2. As the expert in computer algebra will notice by reading the MAGMA code below, the author is not a specialist in programming and asks for some indulgence.

An important feature of the polynomials $g, g[2]$ and $g[3]$ is that they are invariant under the action of various linear groups: this will be helpful to treat the big number of singularities, by separating the various orbits of singular points under their action. Let $W_{1}$ be the subgroup of $\mathbf{G L}_{4}(\mathbb{C})$ generated by

Let $W_{2}$ be the subgroup of $\mathbf{G L}_{4}(\mathbb{C})$ generated by

Finally, let $W_{3}$ denote the subgroup of $\mathbf{G L}_{4}(\mathbb{C})$ generated by

Proposition 2. If $1 \leqslant i \leqslant 3$, then $g[i]$ is invariant under the action of $W_{i}$.
Commentaries. Let $\mathrm{Z}\left(W_{i}\right)$ denote the center of $W_{i}$. In all cases, it is isomorphic to a group of roots of unity acting by scalar multiplication. Then:
(a) The group $W_{1}$ has order 48 and is isomorphic to the non-trivial double cover $\tilde{\mathfrak{S}}_{4}$ of the symmetric group $\mathfrak{S}_{4}$. Hence $\operatorname{Aut}(\mathscr{Z}(g))$ contains a subgroup isomorphic to $\mathfrak{S}_{4}$.
(b) The group $W_{2}$ has order 768, contains a normal abelian subgroup $H$ of order 32 and $W_{2} / H \simeq \mathfrak{S}_{4}$. The group $W_{2} / Z\left(W_{2}\right)$ has order 192 , is contained in $\operatorname{Aut}(\mathscr{Z}(g[2]))$, but is not isomorphic to a Coxeter group of type $D_{4}$.
(c) The group $W_{3}$ is the complex reflection group denoted by $G_{32}$ in the Shephard-Todd classification (it has order 155920). Recall that the group $W_{3} / Z\left(W_{3}\right)$, which is a subgroup of $\operatorname{Aut}(\mathscr{Z}(g[3]))$, is a simple group of order 25920, is contained in $\operatorname{Aut}(\mathscr{Z}(g[3]))$, and is isomorphic to the derived subgroup of the Weyl group of type $E_{6}$ (i.e. to the derived subgroup of the special orthogonal group $\left.\mathbf{S O}_{5}\left(\mathbb{F}_{3}\right)\right)$. Note that we have used the form implemented by Michel [Mic] in the Chevie package of Gap3.
It is natural to wonder whether $\operatorname{Aut}(\mathscr{Z}(g[i]))$ is actually equal to $W_{i} / \mathrm{Z}\left(W_{i}\right)$ for $i=1,2,3$.
So let us start by defining the polynomial $g$ and the three groups $W_{i}$ in MAGMA and checking the facts stated in Proposition 2 and Commentaries. These data, together with the definition of the fields $K$ and $L$ as well as a function ProjectiveOrbit used for computing orbits of various points under the action ot the groups $W_{i}$, are all contained in a file g32-article.m, whose content is given in the Appendix. Note that we will first work with the projective space over $\mathbb{Q}$, and the polynomial $g$ will be defined over $\mathbb{Q}$.

We now turn to the study of the singularities of the varieties $\mathscr{Z}(g[i])$ for $i \in\{1,2,3\}$. Note the following fact, that will be used further:

Lemma 3. If $1 \leqslant i<j \leqslant 4$, then the closed subscheme of $\mathbf{P}^{3}(\mathbb{C})$ defined by the ideal $\left\langle g, \frac{\partial g}{\partial x_{i}}, \frac{\partial g}{\partial x_{j}}\right\rangle$ has dimension 0 .

This is checked thanks to the following code:

Note that the fact that $\operatorname{dim} \mathscr{Z}(g)_{\text {sing }}=0$ (see Lemma 3) implies that $\mathscr{Z}(g)$ is geometrically irreducible. Let $\mathscr{U}$ denote the open subset of $\mathbf{P}^{3}(\mathbb{C})$ defined by $x_{1} x_{2} x_{3} x_{4} \neq 0$. We first check that $\mathscr{Z}(g)_{\text {sing }}$ is contained in $\mathscr{U}$.

In particular, all the singular points are contained (for instance) in the affine chart $\mathscr{Z}(g)^{\text {aff }}$ defined by " $x_{4} \neq 0$ ". We will make all the remaining computations in this affine chart (and extend the scalars to the field $K$ ):

The result of the command Set ([Degree (i) : i in irrg]) shows that all singular points have coordinate in $K$, and the last command shows that the number of singular points in $\mathscr{Z}(g)$ is equal to 44 . We then determine the $W_{1}$-orbits in $\mathscr{Z}(g)_{\text {sing }}$ and check that they are all quotient singularities of type $D_{4}$ by picking up one point in each orbit.

This concludes the proof of statement (a) of Theorem 1. As a consequence of the above computations, the group $W_{1}$ does not act transitively on the set of singular points (it admits 3 orbits, of respective length 8,12 and 24 ). Note that the points in the $W_{1}$-orbit of cardinality 8 are the only real singular points of $\mathscr{Z}(g)$. Figure 1 shows part of the real locus of $\mathscr{Z}(g)$.

## 2. Degree $8 k$

Let $\mathscr{U}$ denote the open subset of $\mathbf{P}^{3}(\mathbb{C})$ defined by $x_{1} x_{2} x_{3} x_{4} \neq 0$ and let $\sigma_{k}: \mathbf{P}^{3}(\mathbb{C}) \rightarrow$ $\mathbf{P}^{3}(\mathbb{C}),\left[x_{1} ; x_{2} ; x_{3} ; x_{4}\right] \mapsto\left[x_{1}^{k}, x_{2}^{k}, x_{3}^{k}, x_{4}^{k}\right]$. The restriction of $\sigma_{k}$ to a morphism $\mathscr{U} \rightarrow \mathscr{U}$ is an étale Galois covering, with group $\left(\boldsymbol{\mu}_{k}\right)^{4} / \Delta \boldsymbol{\mu}_{k}$ (here, $\boldsymbol{\mu}_{k}$ denotes the group of $k$-th roots of unity in $\mathbb{C}^{\times}$and $\Delta: \mu_{k} \hookrightarrow\left(\mu_{k}\right)^{4}$ is the diagonal embedding). We have $\mathscr{Z}(g[k])=\sigma_{k}^{*}(\mathscr{Z}(g))$.

Let us first prove that $\mathscr{Z}(g[k])$ is irreducible. We may assume that $k \geqslant 2$, as the result has been proved for $k=1$ in the previous section. Recall that

$$
\frac{\partial g[k]}{\partial x_{i}}=k x_{i}^{k-1}\left(\frac{\partial g}{\partial x_{i}} \circ \sigma_{k}\right),
$$

so the singular locus of $\mathscr{Z}(g[k])$ is contained in

$$
\left\{p_{1}, p_{2}, p_{3}, p_{4}\right\} \cup\left(\bigcup_{i \neq j} \sigma_{k}^{*}\left(\mathscr{Z}_{i, j}\right)\right)
$$

where $p_{i}=\left[\delta_{i 1} ; \delta_{i 2} ; \delta_{i 3} ; \delta_{i 4}\right]$ (and $\delta_{i j}$ is the Kronecker symbol) and $\mathscr{Z}_{i, j}$ is the subscheme of $\mathbf{P}^{3}(\mathbb{C})$ defined by the ideal $\left\langle g, \frac{\partial g}{\partial x_{i}}, \frac{\partial g}{\partial x_{j}}\right\rangle$ (and which has dimension 0 by Lemma 3). Since $\sigma_{k}$ is finite, this implies that $\mathscr{Z}(g[k])_{\text {sing }}$ has dimension 0 , so $\mathscr{Z}(g[k])$ is irreducible.

Now, as $\sigma_{k}: \mathscr{U} \rightarrow \mathscr{U}$ is étale and the singular locus of $\mathscr{Z}(g)$ is contained in $\mathscr{U}$ (see the command Dimension(Intersection(Zgsing, H)) of the previous section), the 44 singularities of $\mathscr{Z}(g)$ give $44 k^{3}$ singularities in $\mathscr{Z}(g[k])$ of the same type, i.e. quotient singularities of type $D_{4}$. This proves the statement (b) of Theorem 1.

Note that, for $k=2,3$ and 4 (and maybe for bigger $k$ ) we will prove in the next sections that $\mathscr{Z}(g[k])$ contains singular points outside of $\mathscr{U}$.

## 3. Degree 16

Using the morphism $\sigma_{2}$ defined in the previous section and the fact that it is étale over $\mathscr{U}$, we get that $\mathscr{Z}(g[2]) \cap \mathscr{U}$ has exactly 352 singular points, which are all quotient singularities of type $D_{4}$. We now need to determine the singularities which are not contained in $\mathscr{U}$. So let $\mathscr{H}$ be the complement of $\mathscr{U}$ in $\mathbf{P}^{3}(\mathbb{C})$.

The last two commands show that $\mathscr{Z}(g)_{\text {sing }} \cap \mathscr{H}$ contains 120 points. We now check that all the singular points contained in $\mathscr{H}$ have coordinates in $L$ :

We now determine the $W_{2}$-orbits in $\mathscr{Z}(g)_{\text {sing }} \cap \mathscr{H}$ : there is one $W_{2}$-orbit of cardinality 24 (and we check that its elements are quotient singularities of type $A_{1}$ ) and one of cardinality 96.

We now study the singularity of $\mathscr{Z}(g[2])$ at the points of the orbit of cardinality 96 . It turns out that that the command IsSimpleSurfaceSingularity takes too much time to get a conclusion, so we will investigate properties of the equation of $\mathscr{Z}(g[2])$ in a neighborhood of the first point $p$ (in Magma list orbits [2]). We work in the affine chart $x_{3} \neq 0$ (where $p=\left[\xi_{1} ; \xi_{2} ; \xi_{3} ; \xi_{4}\right]$ lives), and we denote by $(x, y, z)$ the coordinates of the affine chart $x_{3} \neq 0$ equal to ( $x_{1} / x_{3}+\xi_{1} / \xi_{3}, x_{2} / x_{3}+\xi_{2} / \xi_{3}, x_{4} / x_{3}+\xi_{4} / \xi_{3}$ ) and we set

$$
f(x, y, z)=g[2](x, y, 1, z) .
$$

If $j \geqslant 0$, we denote by $f_{j}$ the homogeneous component of $f$ of degree $j$. As $p \in \mathscr{Z}(g[2])_{\text {sing }}$, we have $f_{0}=f_{1}=0$.

The last command shows that there exists a linear change of the coordinates $(x, y, z) \mapsto$ $(X, Y, Z)$ such that $f_{2}$ might be transformed into $X^{2}+Z^{2}$. By standard arguments, this proves that $p$ is a quotient singularity of type $A_{k}$, for some $k \geqslant 2$, which can be obtained as the Milnor number of $f$ : however, Magma cannot compute this Milnor number in a reasonable amount of time and we need to copy the polynomial $f$ in the software Singular [DGPS] to compute this Milnor number (!): we obtain 2. So $p$ is a quotient singularity of type $A_{2}$. This completes the proof of statement (c) of Theorem 1.

Figure 2 shows part of the real locus of $\mathscr{Z}(g)$.

## 4. Degree 24

We now come to the surface $\mathscr{Z}(g[3])$. From Section 2, we know that $\mathscr{Z}(g[3])_{\text {sing }} \cap \mathscr{U}$ contains $44 \times 3^{3}=1188$ singular points, which are all quotient singularities of type $D_{4}$. Let us compute $\mathscr{Z}(g[3])_{\text {sing }} \cap \mathscr{H}$ :

The last command shows that $\mathscr{Z}(g[3])_{\text {sing }} \cap \mathscr{H}$ contains 252 points. We now show that they are all defined over $K$ :

So $\mathscr{Z}(g[3])_{\text {sing }}$ contains 1440 points, and we now check that $W_{3}$ acts transitively on them:

The proof of statement (d) of Theorem 1 is complete. Note also that, in the given model, the surface $\mathscr{Z}(g[3])$ has only 32 real singular points: Figure 3 gives partial views of its real locus.

Remark 3. From Section 2, we deduce that $\mathscr{Z}(g[4])_{\text {sing }}$ has 2816 quotient singularities of type $D_{4}$ lying in the open subset $\mathscr{U}$ and it can be checked that it has 480 other singular points lying in $\mathscr{H}$, for which we did not determine the type.

Remark 4. After investigations in the invariant rings of several complex reflection groups, we have also been able to construct curves with many singularities. For example:

- Using the reflection group $W=G_{24}$, we have obtained a cuspidal curve of degree 14 in $\mathbf{P}^{2}(\mathbb{C})$ with exactly 42 cusps (all lying in a single $W$-orbit). Note that $W / \mathrm{Z}(W)$ has order 168 and is isomorphic to $\mathbf{G L}_{3}\left(\mathbb{F}_{2}\right)$.
- Using the reflection group $W=G_{26}$, we have obtained a curve of degree 18 in $\mathbf{P}^{2}(\mathbb{C})$ with 72 cusps and 12 nodes (these are the two $W$-orbits of singular points). Note that $W / \mathrm{Z}(W)$ has order 216.
Also, other singular surfaces have been obtained. For example:
- Using the reflection group $W=G_{29}$ (note that $W / \mathrm{Z}(W)$ has order 1920), we have obtained:
- a surface of degree 8 in $\mathbf{P}^{3}(\mathbb{C})$ with 160 nodes, all belonging to the same $W$ orbit. Recall that the Endraß octic [End] has degree 8 and 168 nodes (and its automorphism group has order 16) while the Sarti octic [Sar1] has 144 nodes.
- a surface of degree 8 in $\mathbf{P}^{3}(\mathbb{C})$ with 20 singular points of multiplicity 3 and Milnor number 11, all belonging to the same $W$-orbit.
- Using the reflection group $W=G_{31}$ (note that $W / \mathrm{Z}(W)$ has order 11520), we have obtained a surface of degree 20 in $\mathbf{P}^{3}(\mathbb{C})$ with 1920 nodes, all lying in the same $W$ orbit. Recall that the Chmutov surface [Chm] of degree 20 has 2926 nodes.
Details will appear in a forthcoming paper.

## Appendix

This appendix gives a copy of the file g32-article.m loaded at the beginning of the computations. It contains the data of the polynomial $g$, the fields $K$ and $L$, the three groups $W_{i}$ and the function ProjectiveOrbit which is used throughout the computations (it is certainly not the most efficient code, but it is sufficient for our purpose). Note that $W_{1}$ and $W_{3}$ are defined over the field $K$, while $W_{2}$ is defined over the field $L$.
