Gouverner par les métriques

- Les enjeux environnementaux au niveau global:
 - Une complexité croissante
 - Interdépendance entre les sciences et les politiques (par ex., evidence-based policy-making, expertises, prospectives)
 - Grande incertitude sur les liens entre les enjeux environnementaux et la sécurité alimentaire – la question de la temporalité et interactions entre les vulnérabilités des populations et changement environnemental
- Les modèles d'usage des sols sont utilisés pour 'prédire' certains actions et ils guident des décisions
 - « gouvernement » réfère à une conduite ou à une activité destinée à **modeler, guider ou influencer la conduite** des personnes (...) La rationalité, en tant que forme de pensée qui s'efforce d'être systématique et claire sur la manière dont les choses se passent ou devraient se passer, suggère enfin **qu'avant de pouvoir contrôler ou diriger une personne ou une chose, il faut pouvoir la définir**. L'État, par conséquent, va concevoir des systèmes permettant de définir les populations, c'est-à-dire de les **rendre connues et mesurables**. (Foucault 1978)

Les modèles de l'usage des sols – simplement un outil?

- « We define 'model' broadly, to refer to a **schematic description of a system or phenomenon** that accounts for its key properties and may be used as the **basis for further exploration or prediction**. Modelling takes many forms, shedding light on complex patterns and processes from different perspectives (...) yet such models themselves need to be understood as having **social and political lives**. » (Leach and Scoones, 2013b: 10)

 - Les objets-frontières (Star & Griesemer 1989)

 - Souvent, les modèles économiques façonnent les comportements plus tôt que de les refléter (Callon, 1999);

“Many greens argue that intensification of agriculture harms biodiversity. It is true that pesticides and fertiliser tend to reduce the number of species where they are used, but **intensive agriculture employs less land than extensive farming to produce the same amount of food.** The question, then, is whether the net benefits to other species of “land-sharing” (farming extensively on a larger area) outweigh those of “land-sparing” (farming intensively on a smaller area). A couple of recent papers—a theoretical one by David Tilman of the University of Minnesota and an empirical study by Ben Phalan of Cambridge University, looking at data from Ghana and India—suggest that **land-sparing wins.**”

Figure 1: Number of Publications in the Land Sparing vs. Land Sharing Controversy (2005-2016)

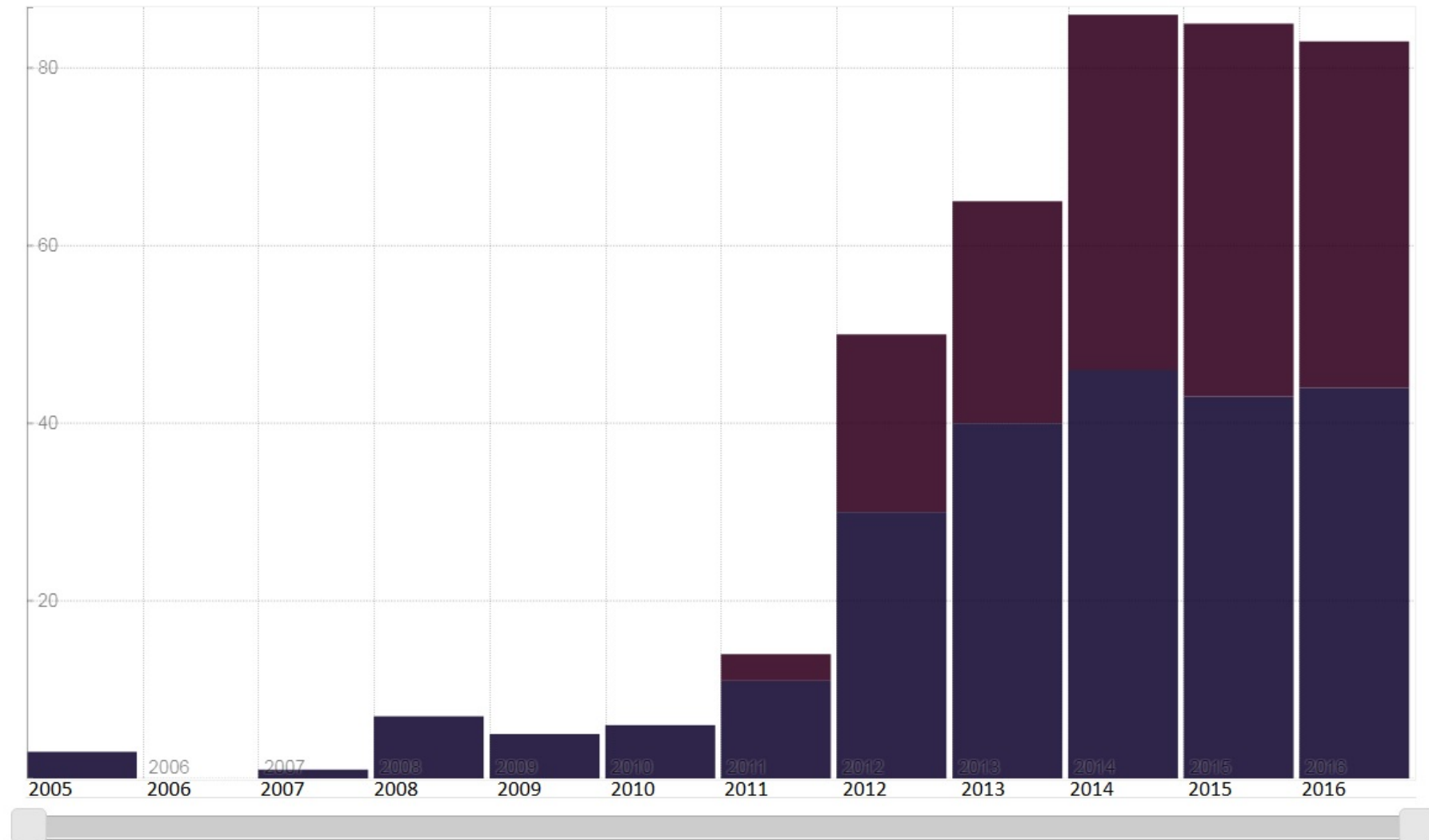

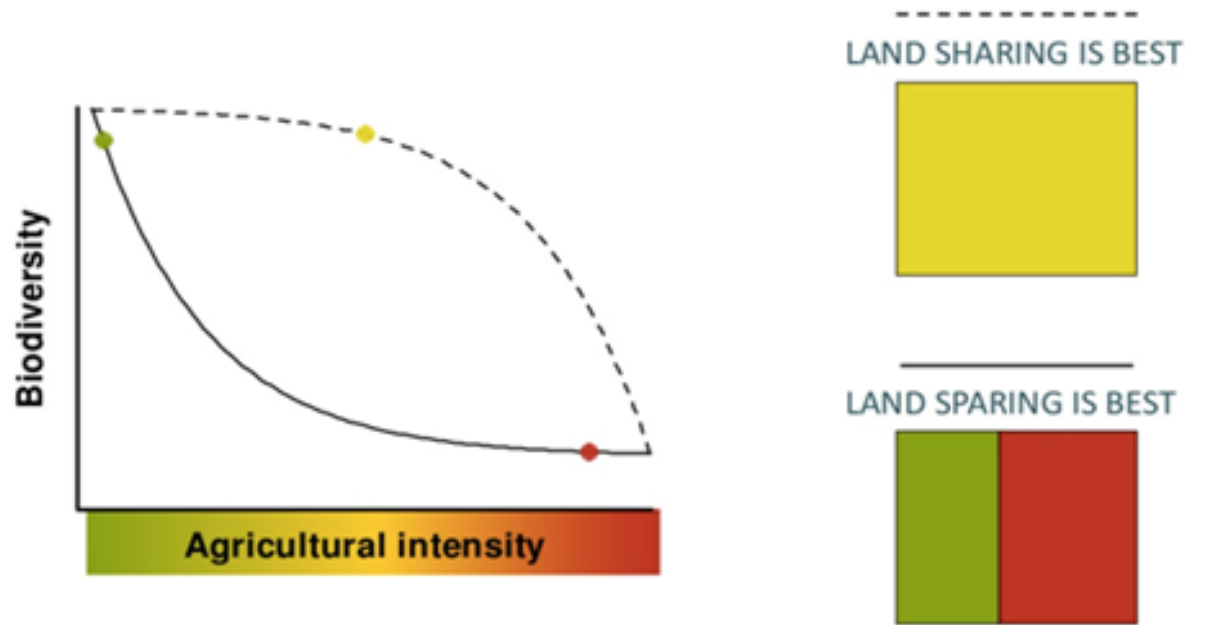

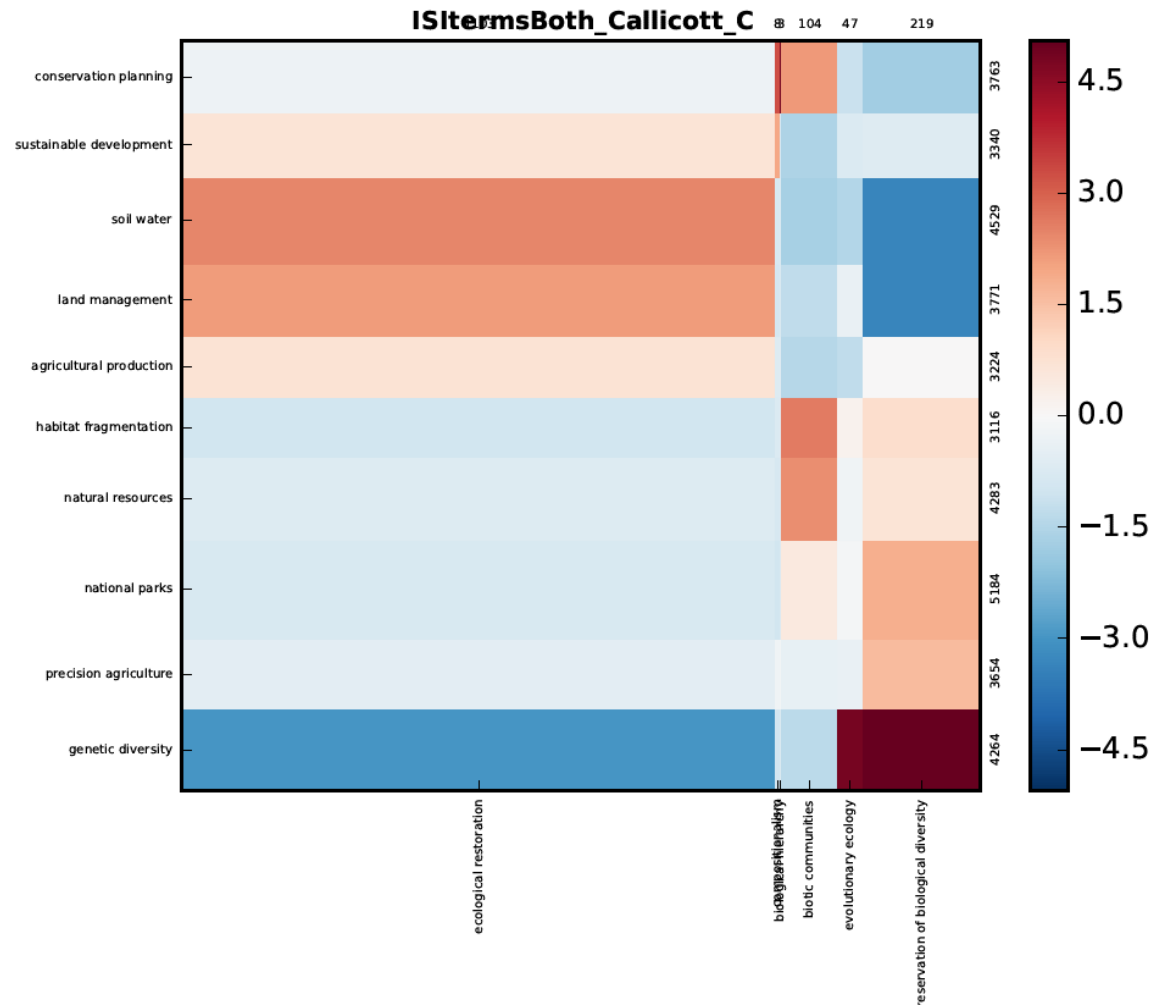


Figure 2.4 Functionalism and Land Sparing

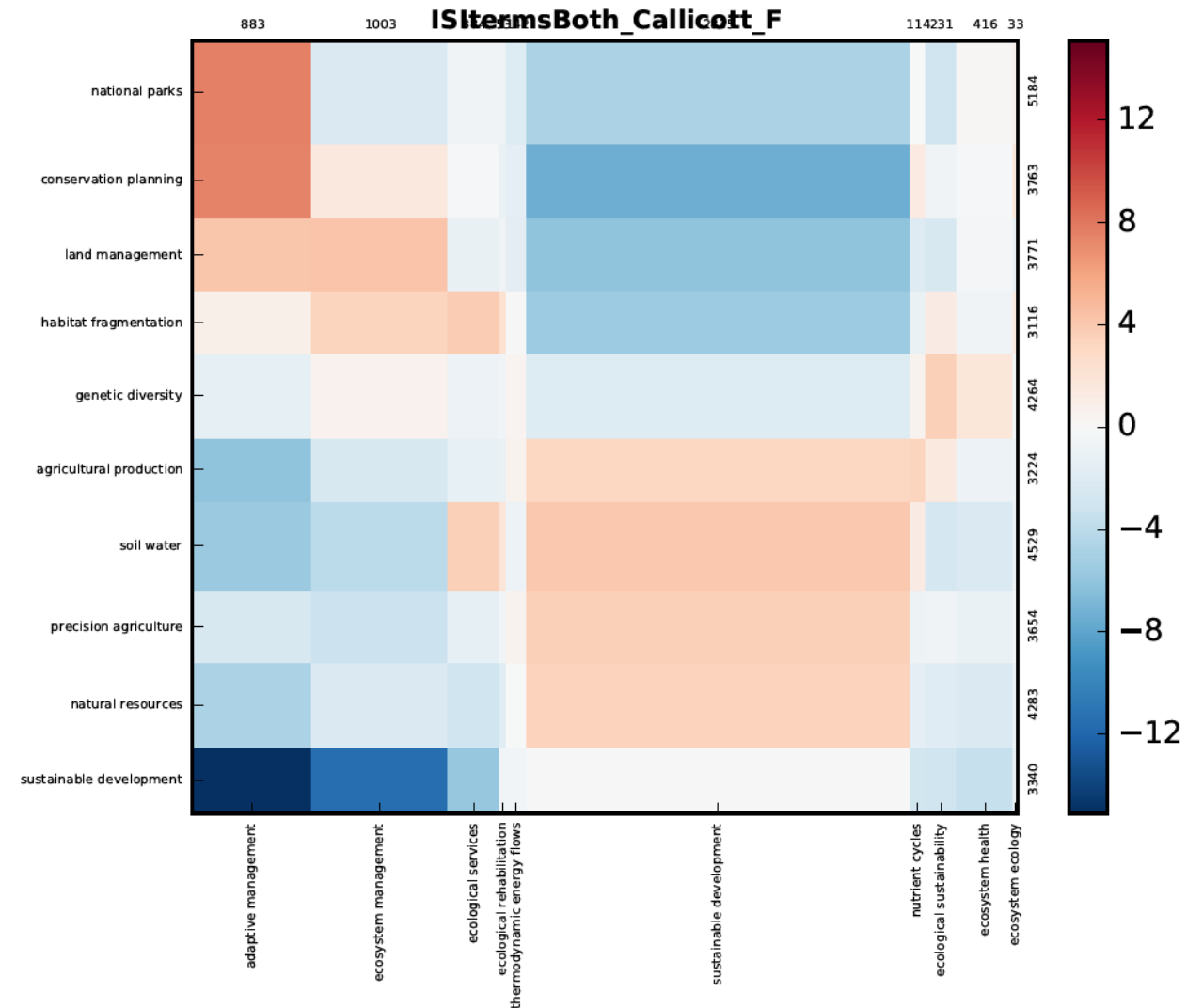


Figure 2.3 Compositionism and Land Sharing

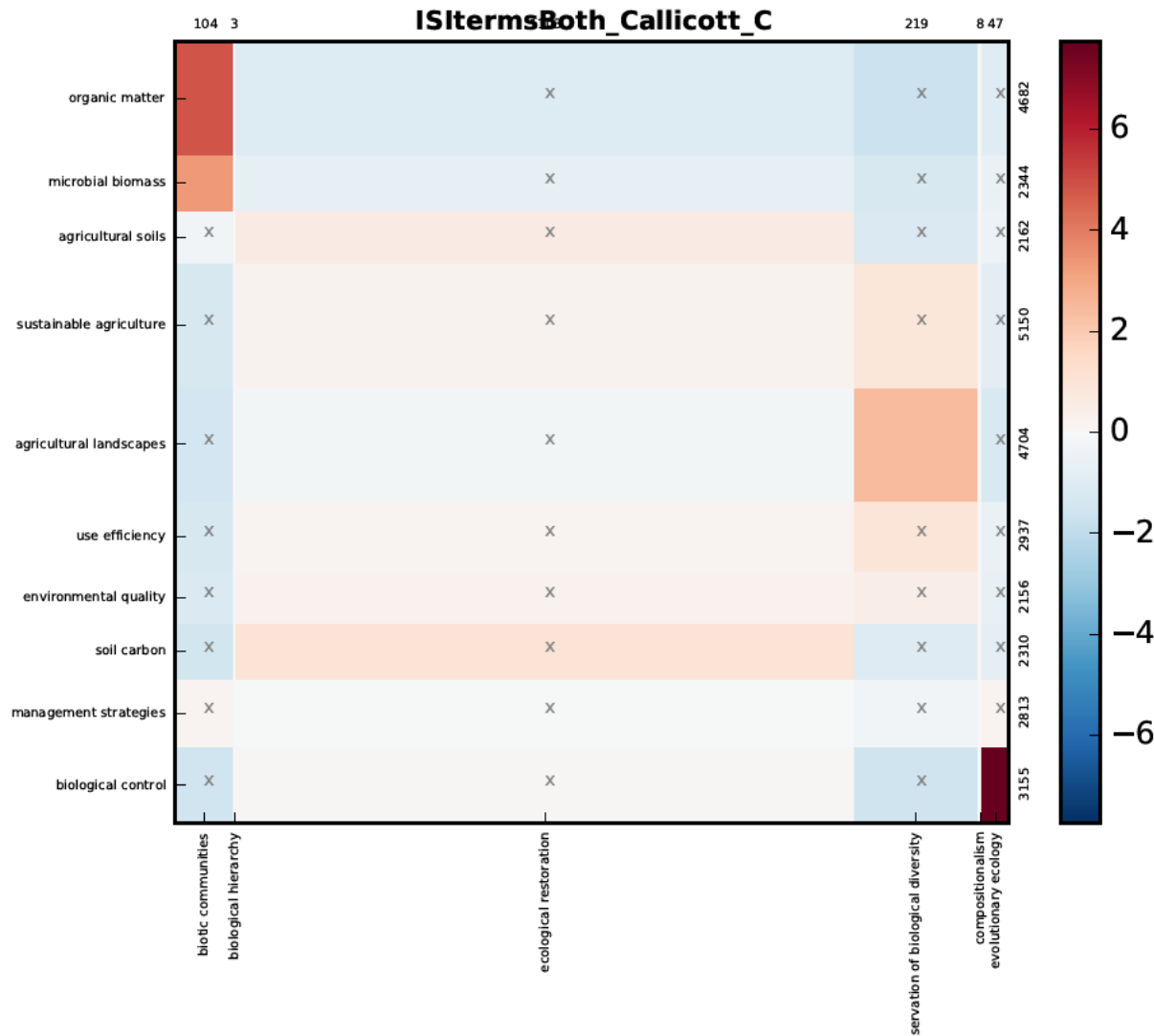
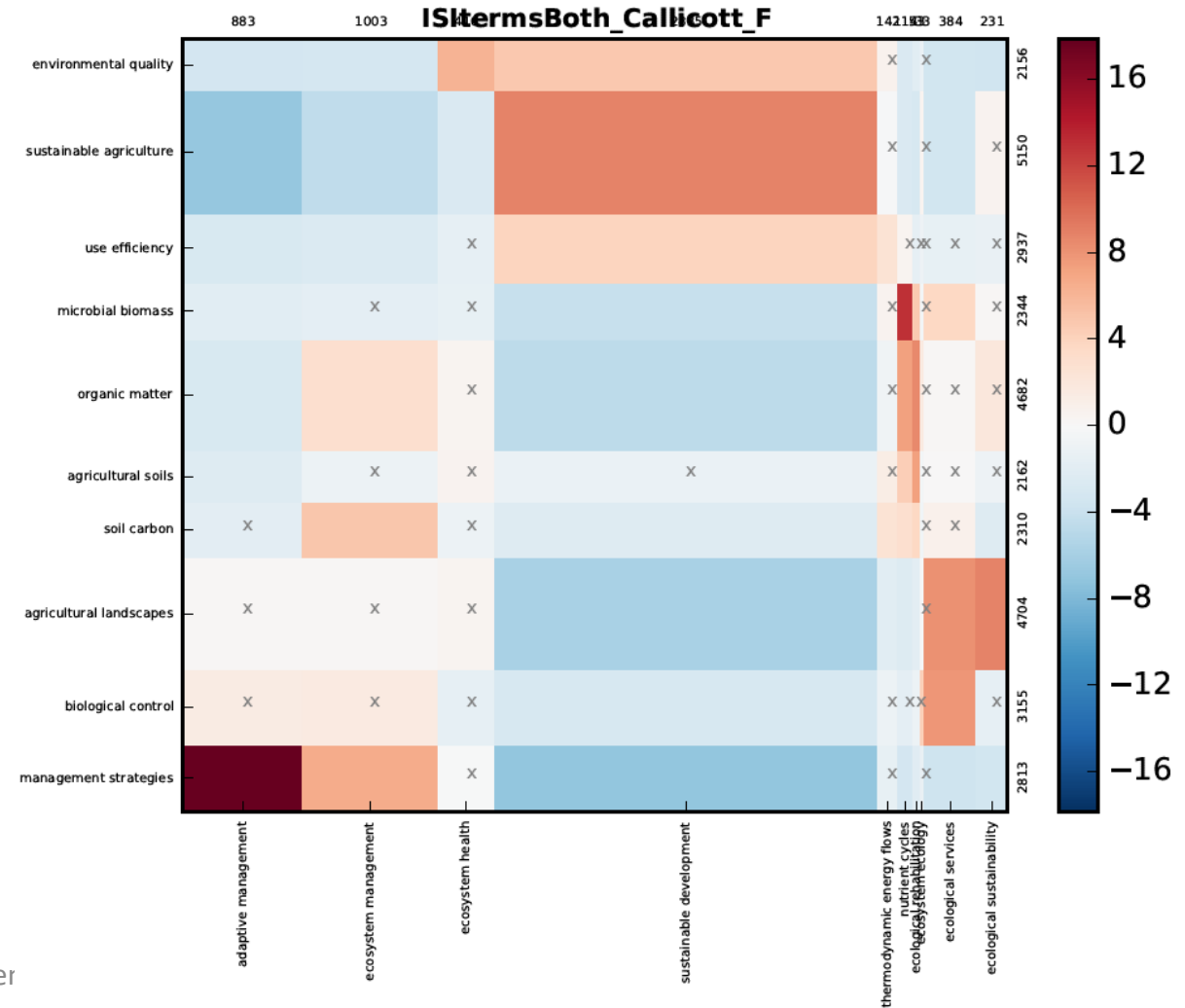
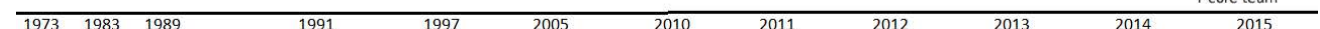
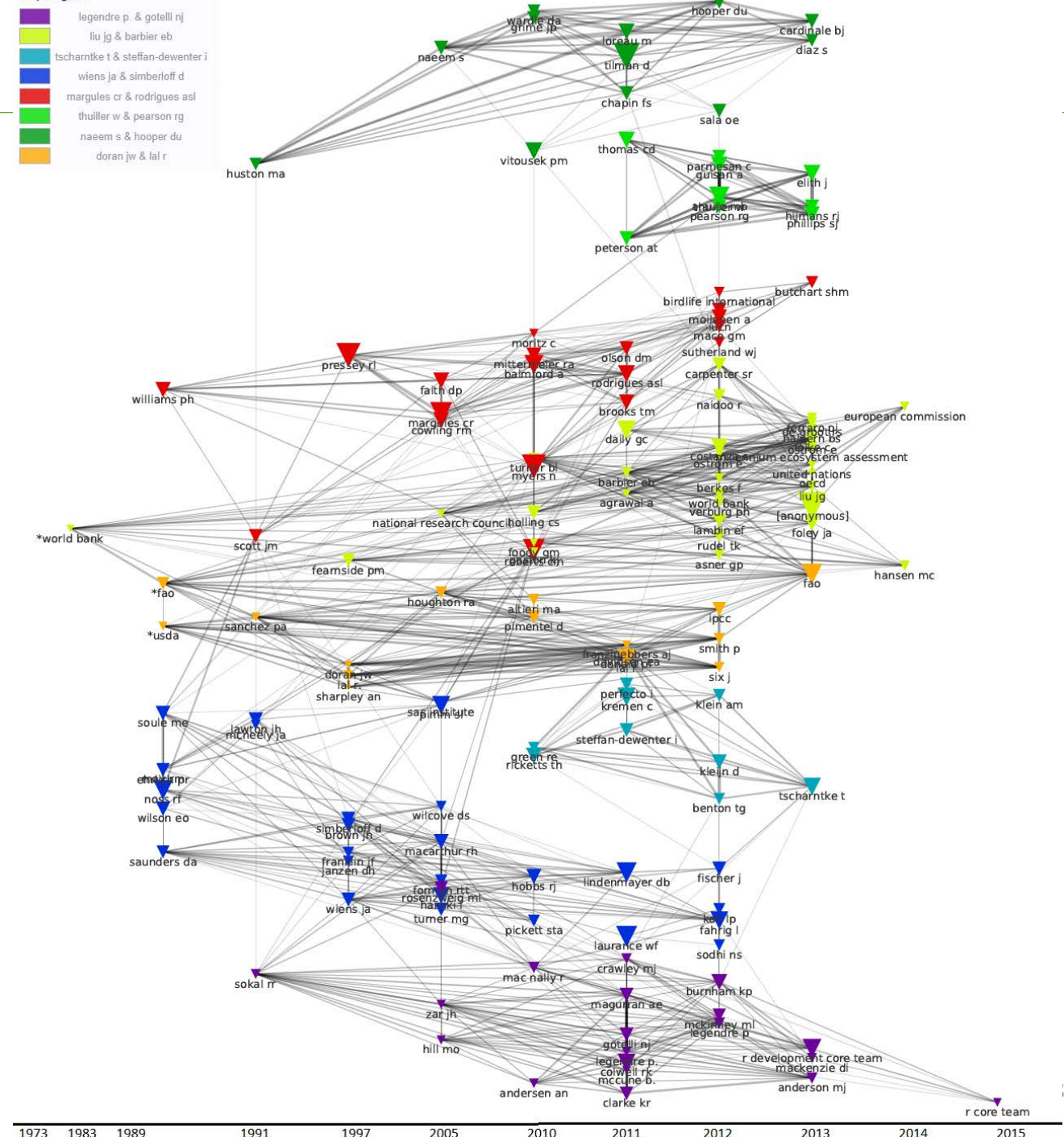
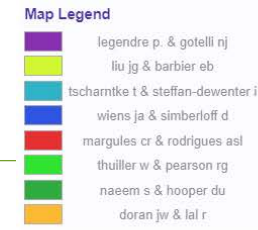


Figure 2.2 Functionalism and Land Sharing

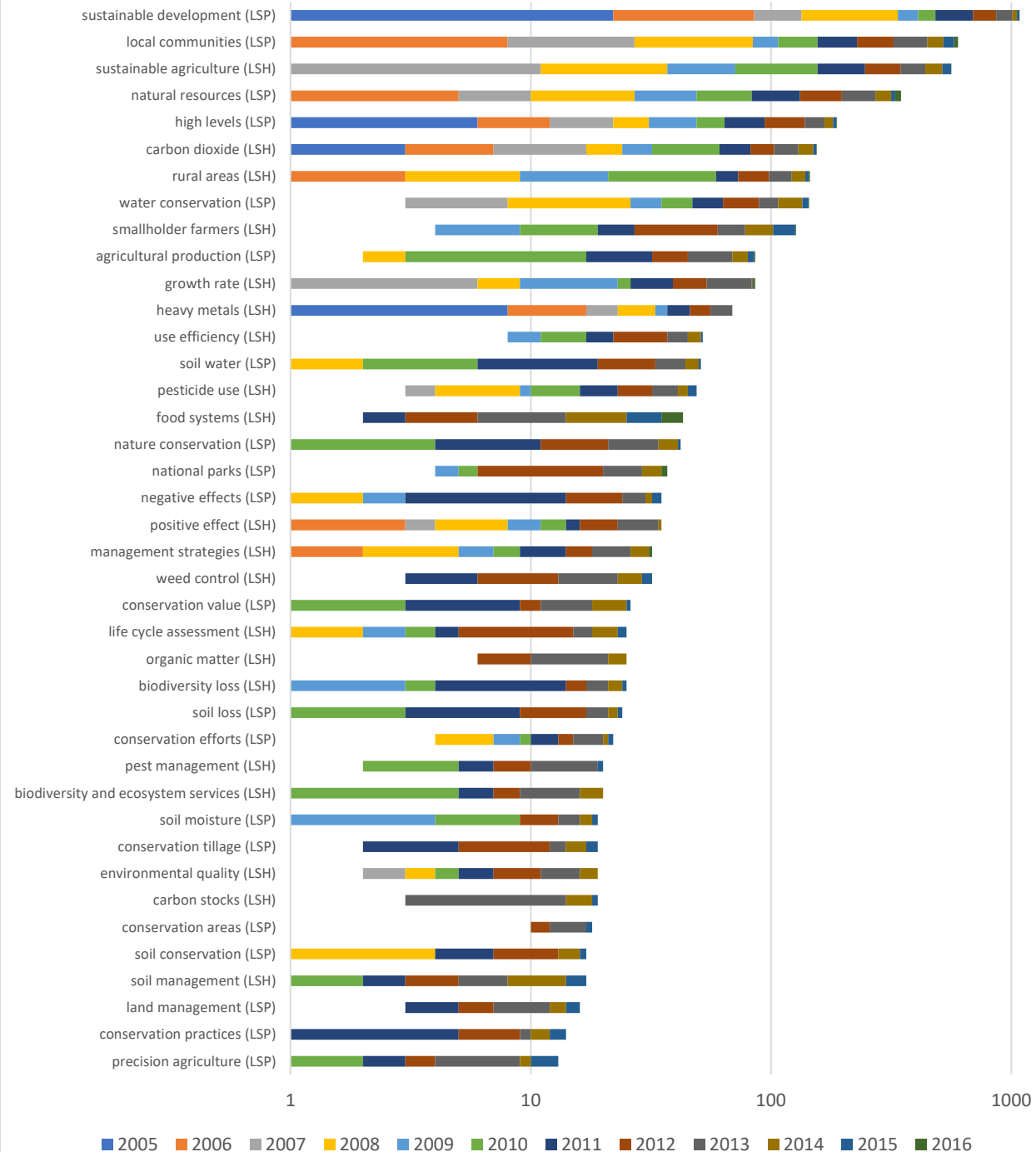

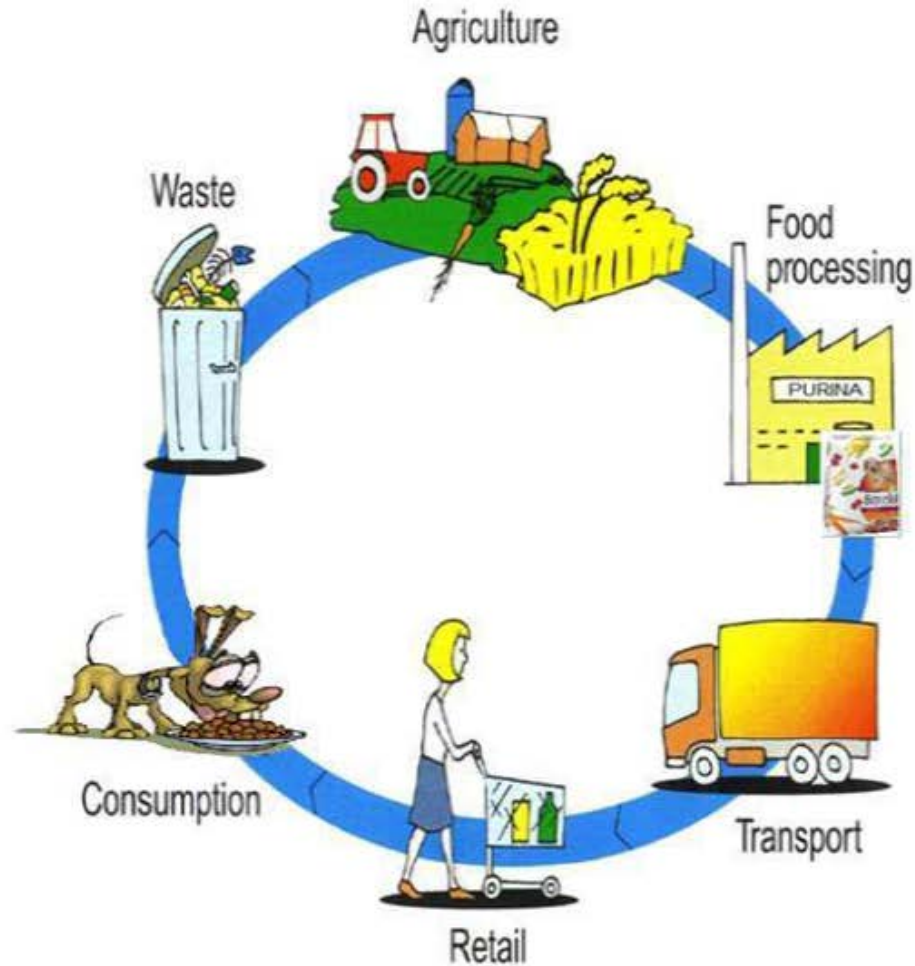

No.	Critical Criteria
2.1	<u>High Conservation Value (HCV) areas</u> have not been <u>destroyed</u> from November 1, 2005 onward.
2.2	Farms <u>conserve</u> all <u>natural ecosystems</u> and have not <u>destroyed forest</u> or other <u>natural ecosystems</u> in the five-year period prior to the date of initial application for Rainforest Alliance certification or after January 1, 2014, whichever date is earlier.
2.3	Production activities do not <u>degrade</u> any <u>protected area</u> .
3.3	The <u>farm management</u> develops and implements an <u>integrated pest management (IPM) plan</u> that is based upon the prevention and monitoring of <u>pests</u> and aims to avoid economically significant crop losses while reducing pesticide risks. The <u>farm management</u> determines pest management steps based on the analysis of pest monitoring records. Pests are managed using biological controls or other non-chemical methods where feasible. When <u>pesticides</u> are used, preference is given to non-restricted low toxicity pesticides, and pesticides are applied only to the parts of the crop affected by pests. All workers involved in pest management activities are trained about the contents of the IPM <u>plan</u> .

“Approaches include the retention of patches of **natural habitat** and extensively farmed semi natural habitats within the countryside and farming in ways that **minimize the negative effects of fertilizers and pesticides** on non-target organisms (...) increase yields on already converted land, thereby **reducing the need to convert remaining intact habitats**, and potentially **freeing up former farmland for restoration to a more natural state**” (Green et al. 2005:551-2).

Performance Level	No.	Continuous Improvement Criteria
C	2.5	Existing native vegetation outside <u>natural ecosystems</u> is maintained, including: <ul style="list-style-type: none"> a) Existing agroforestry shade tree cover; b) Existing vegetated zones adjacent to <u>aquatic ecosystems</u>; c) <u>Large native trees</u>, except when these pose hazards to people or infrastructure.
C	2.6	The <u>farm management</u> and <u>group administrator</u> develop a map that includes <u>natural ecosystems</u> and agroforestry canopy cover or border plantings with estimated vegetation coverage and estimated percentage of <u>native species</u> composition. If the farm or group of <u>member farms</u> have less than 10% total native vegetation cover or less than 15% total native vegetation cover for farms growing <u>shade-tolerant crops</u> , the farm management and group administrator develop and implement a <u>plan</u> to progressively increase or restore native vegetation, including: <ul style="list-style-type: none"> a) <u>Restoration</u> of zones adjacent to <u>aquatic ecosystems</u>; b) <u>Restoration</u> of farmed areas of marginal productivity to <u>natural ecosystem</u>; o c) Incorporation of native trees as border plantings and barriers around housing and infrastructure, <u>live fences</u>, shade trees, and permanent agroforestry systems.
C	2.7	If zones adjacent to <u>aquatic ecosystems</u> are not protected according to <u>Rainforest Alliance restoration parameters</u> , a <u>plan</u> is developed and implemented to restore these zones.
A	2.8	<u>Rainforest Alliance restoration parameters</u> are implemented for all <u>aquatic ecosystems</u> .

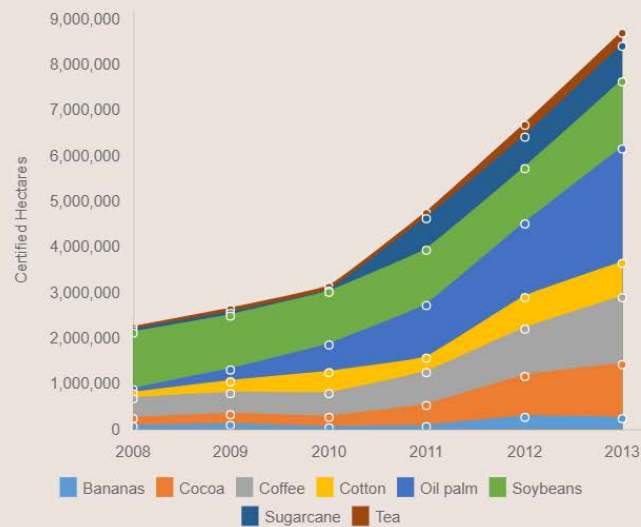
\$50.3 Billion Sustainable Production Value across listed agricultural (2013/2014) and seafood (2015) commodities

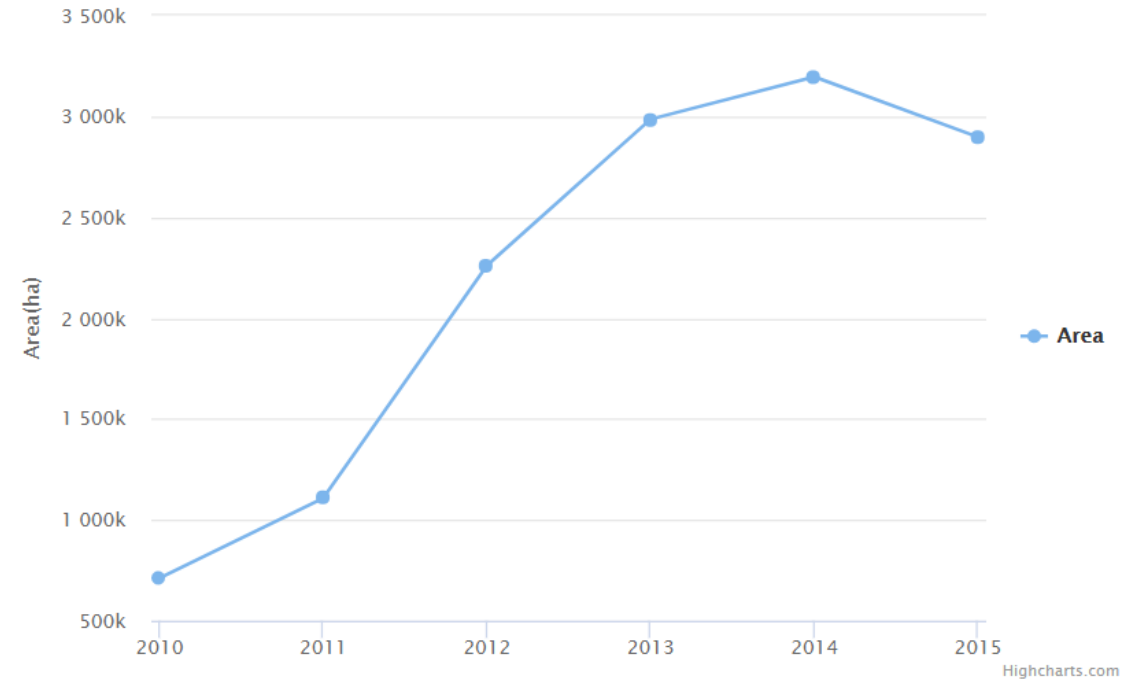
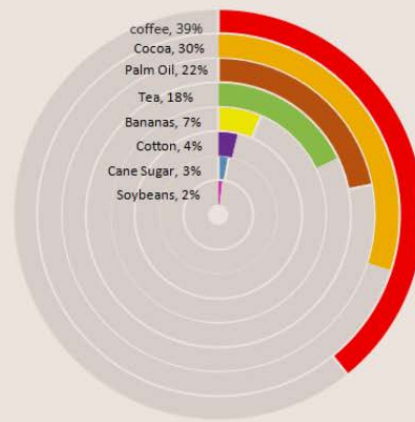
The chart presents the growth of certified land area (fully converted plus under conversion) by a specific Voluntary Sustainability Standard (VSS) from 2008-2015.

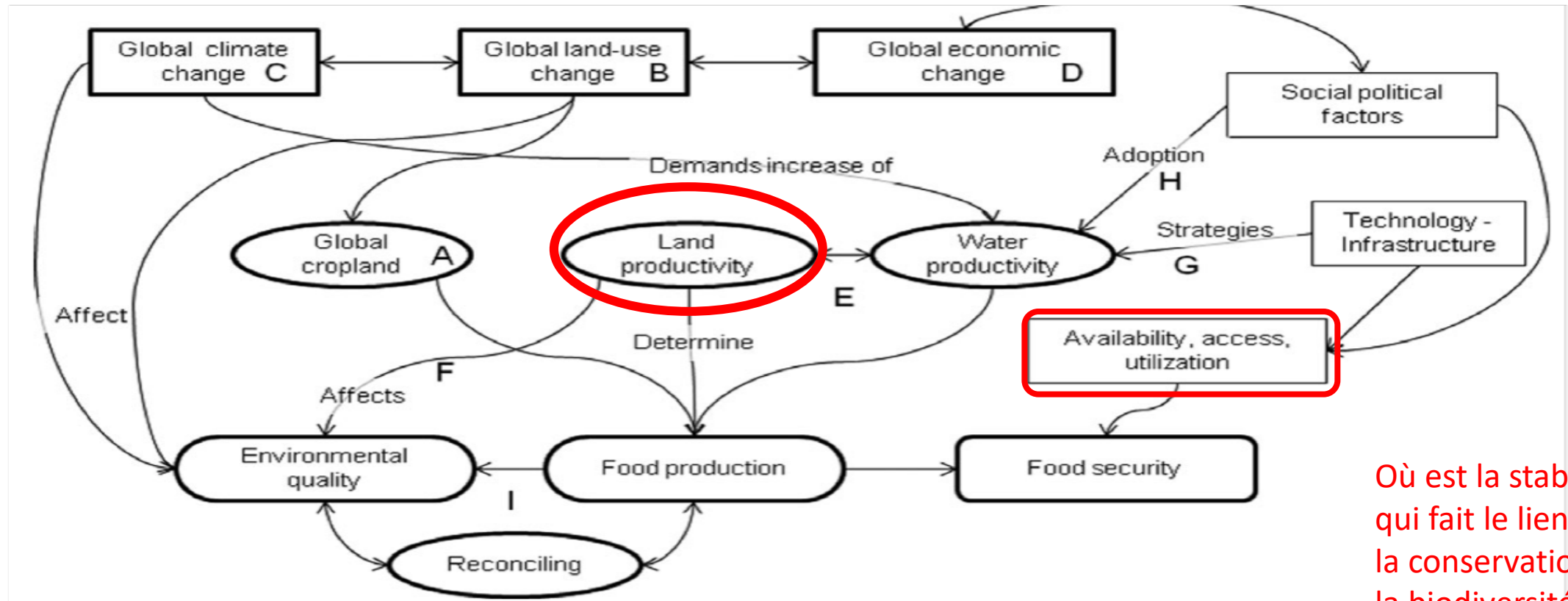


Percentage of Standard Compliant Metric Tonnes in Selected Agricultural Commodities (2013/2014)

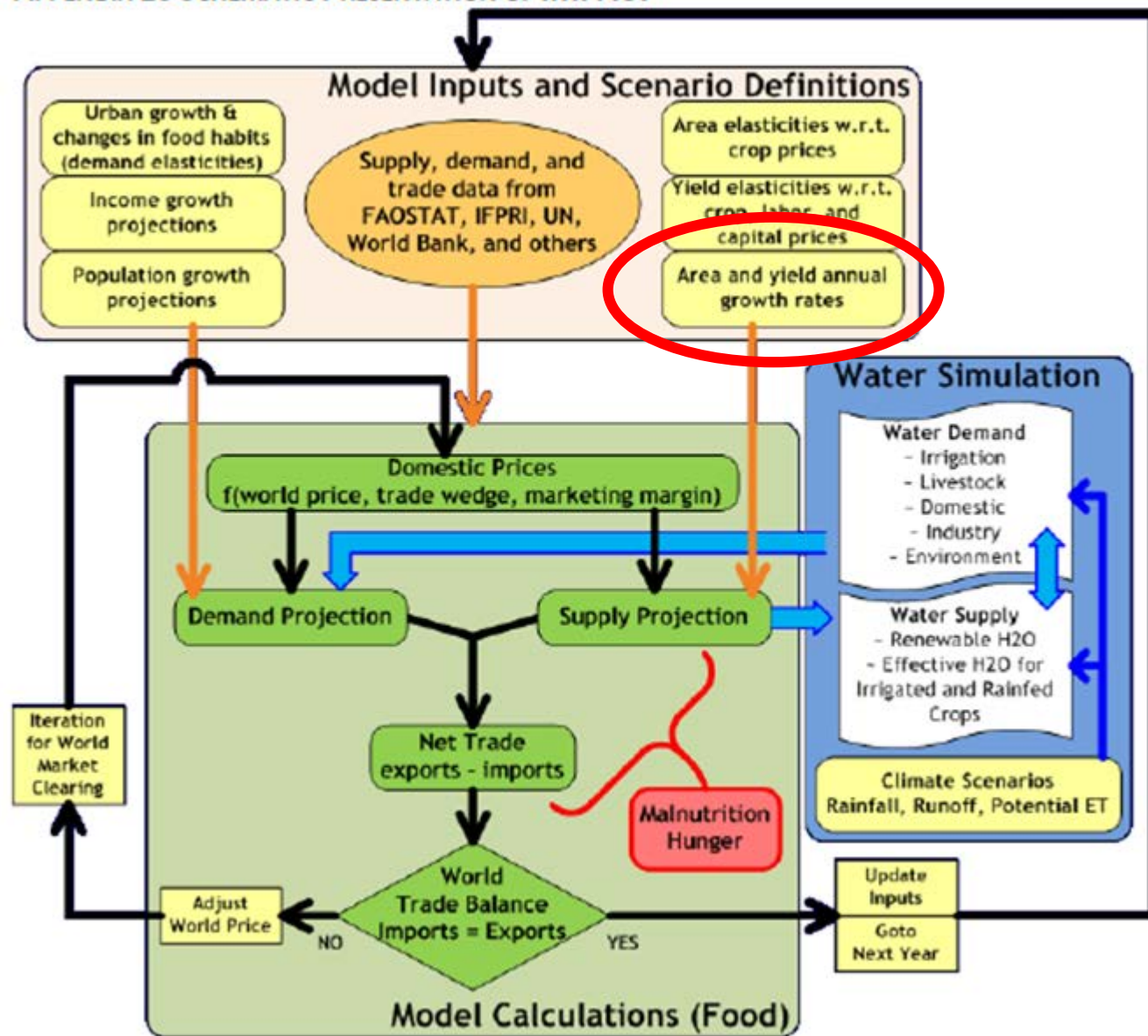

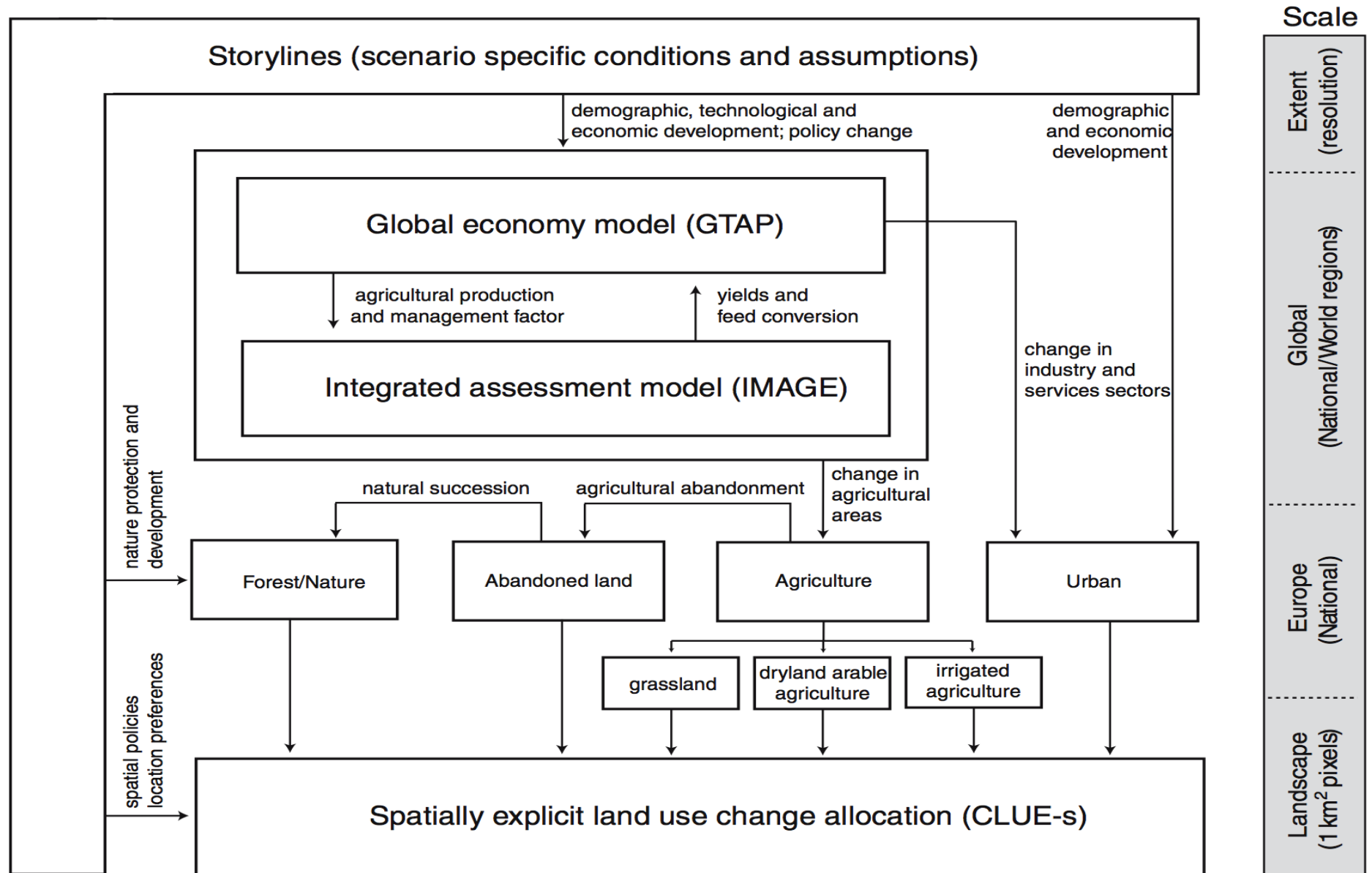


Fig. 2 Schematic representation of the modelling procedure over different scales

Conclusion?

A model should 'satisfice'*

“Reliance on a single model is always dangerous, no matter how careful the modellers. No model can claim to capture everything; reality is too complex to model in full” (Leach and Scoones, 2013c: 16).

“ A model should clarify the issues in the debate; it must be able to enforce a discipline of analysis and discourse among stakeholders; and it must provide an interesting form of “advice,” primarily in the form of what not to do — since a politician is unlikely to do what a model suggests.” (Agarwal, 2002: 1)
