ON THE NON-DETECTABILITY OF SPIKED LARGE RANDOM TENSORS

ABSTRACT

This paper addresses the detection of a low rank high-dimensional tensor corrupted by an additive complex Gaussian noise. In the asymptotic regime where all the dimensions of the tensor converge towards $+\infty$ at the same rate, existing results devoted to rank 1 tensors are extended. It is proved that if a certain parameter depending explicitly on the low rank tensor is below a threshold, then the null hypothesis and the presence of the low rank tensor are undistinguishable hypotheses in the sense that no test performs better than a random choice.

1. INTRODUCTION

The problem of testing whether an observed $n_1 \times n_2$ matrix \mathbf{Y} is either a zero-mean independent identically distributed Gaussian random matrix \mathbf{Z} with variance $\frac{1}{n_2}$, or $\mathbf{X}_0 + \mathbf{Z}$ (where \mathbf{X}_0 is a low rank matrix: a useful signal, called also spike) is a fundamental problem arising in numerous applications such as the detection of low-rank multivariate signals or the Gaussian hidden clique problem. When the two dimensions n_1, n_2 converge towards ∞ at the same rate, the rank of \mathbf{X}_0 remaining fixed, the context is this of the so-called additive spiked large random matrix models. Various results on the singular values of $\mathbf{X}_0 + \mathbf{Z}$ have been established; in particular it is possible to show that the Generalized Likelihood Ratio Test (GLRT) is consistent (*i.e.* the probability of false alarm and the probability of missed detection both converge towards 0 when n_1, n_2 converge towards $+\infty$ in such a way that $n_1/n_2 \to c > 0$) if and only the largest singular value of \mathbf{X}_0 is above the threshold $c^{1/4}$ (see *e.g.* [12], [3], [2]).

In a number of real life problems, the observation is not a matrix, but a tensor \mathbf{Y} of order $d \geq 3$, *i.e.* a d-dimensional array $\mathbf{Y} = \mathbf{Y}_{i_1,i_2,\dots,i_d}$ where for each $k=1,\dots,d,$ $i_k \in [1,\dots,n_k]$. In this context, the generalization of the above matrix hypothesis testing problem becomes: test that the observed order $d \geq 3$ tensor is either a zero-mean independent identically distributed Gaussian random tensor \mathbf{Z} , or the sum of \mathbf{Z} and a low rank deterministic tensor

$$\mathbf{X}_0 = \sum_{i=1}^r \lambda_i \mathbf{x}_0^{(1,i)} \otimes \mathbf{x}_0^{(2,i)} \otimes \dots \mathbf{x}_0^{(d,i)}$$
 (1)

where r is called the rank of \mathbf{X}_0 . Here $(\lambda_i)_{i=1,\dots,r}$ are strictly positive real numbers, and for each $i=1,\dots,r$ and $k=1,\dots,d,\mathbf{x}_0^{(k,i)}$ is a $n_i \times 1$ unit norm vector. Recent works (see e.g. [8, 11, 10, 14]) addressed the detection/estimation of \mathbf{X}_0 when r is reduced to 1 and when the dimensions n_1,\dots,n_d converge towards ∞ at the same rate. We also mention that [8] and [14] only considered the case where the rank 1 tensor \mathbf{X}_0 is symmetric, that is: $n_1=n_2=$

 $\ldots = n_d$ and the d vectors $(\mathbf{x}_0^{(k,i)})_{i=1,\ldots,d}$ are equal. Since the concept of singular value decomposition cannot be extended to tensors, ad'hoc statistical strategies have been considered to prove the (non)-existence of consistent tests: [11] and [14] (r=1) established that if λ_1 is larger than a certain upper bound, then consistent detection of \mathbf{X}_0 is possible. In the other direction, [10][14] (again, r=1) proved that if λ_1 is less than a certain lower bound (which is strictly less than the above upper bound), then \mathbf{X}_0 is non-detectable in the sense that any test behaves as a random choice between the two hypotheses. This is a remarkable phenomenon because such a behaviour is not observed in the matrix case (d=2): indeed, in this context, if the largest eigenvalue of \mathbf{X}_0 is below $c^{1/4}$, it is proved in [13] (r=1) that there exist statistical tests having a better performance than a random choice - a result that [10][14] obtained a different way.

The replica method has been successfully considered [4][9]. In these contributions, the model does not match exactly ours since 1) the spike is assumed symmetric, *i.e.* $\mathbf{X}_0 = \sum_{i=1}^r \lambda_i \left(\mathbf{x}_0^{(i)}\right)^{\otimes d}$ and 2) the rows of the matrix $\left(\mathbf{x}_0^{(1)}, ..., \mathbf{x}_0^{(r)}\right)$ are random i.i.d. with a known distribution (the prior). When r=1, and the prior is of the Rademacher type, the observed tensor follows the pure p-spin model [15]: in an illuminating contribution [4], a tight threshold when $d \geq 3$ is provided (above which consistent detection is possible and under which any detector performs as a random guess). The case $r \geq 1$ with a general prior is addressed in [9]: there, the estimation of the spike is considered rather than the detection; specifically, the asymptotic performance of the MMSE is computed and an estimation threshold is deduced. This latter is rigorously proved when r=1. The threshold is not explicit and intrinsically depends on the prior.

In the present contribution, we follow the methodolodgy of [11] [10][14] and extend it to the general case $r \geq 1$: though suboptimal (the thresholds provided are not tight in general), the machinery is much lighter than this of the replica method, it provides explicit bounds for the non-detectability and lastly allows one to deal with deterministic spikes. Precisely, we find out a simple sufficient condition on the spike \mathbf{X}_0 under which \mathbf{X}_0 is non-detectable. The problem of finding conditions under which the existence of a consistent detection is guaranteed is not addressed here.

2. MODEL, NOTATION, AND BACKGROUND

The order-d tensors are complex-valued, and it is assumed that $n_1 = n_2 = \dots = n$ in order to simplify the notations. The set $\otimes^d \mathbb{C}^n$ is a complex vector-space endowed with the standard scalar product

$$\forall \ \mathbf{X}, \mathbf{Y} \in \otimes^d \mathbb{C}^n \ \langle \mathbf{X}, \mathbf{Y} \rangle = \sum_{i_1, \dots, i_d} \mathbf{X}_{i_1, \dots, i_d} \overline{\mathbf{Y}}_{i_1, \dots, i_d}$$

and the Frobenius norm $\|\mathbf{X}\|_F = \sqrt{\langle \mathbf{X}, \mathbf{X} \rangle}$.

The spike ("the signal") is assumed to be a tensor of fixed rank r following (1). Along this contribution, n is large or, mathematically, $n \to \infty$. We hence have for each n a set of $n \times 1$ vectors $\left(\mathbf{x}_0^{(k,i)}\right)_{k=1,\dots,d,i=1,\dots,r}$. For each $k=1,\dots,d$, we denote by $\chi_0^{(k)}$ the $n \times r$ matrix $\chi_0^{(k)} = (\mathbf{x}_0^{(k,1)},\dots,\mathbf{x}_0^{(k,r)})$. We impose a non-erratic asymptotic behavior of the spike, and specifically, as all the vectors $\mathbf{x}_0^{(k,i)} \in \mathbb{C}^{n\times 1}$ have unit norm, we suppose that for all $i,j,\left\langle\mathbf{x}_0^{(k,i)},\mathbf{x}_0^{(k,j)}\right\rangle = (\chi_0^{(k)*}\chi_0^{(k)})_{i,j}$ converges as $n\to\infty$. The rate of convergence is a technical aspect that is out of the scope of this contribution: we will simply assume that the matrices $(\chi_0^{(k)*}\chi_0^{(k)})_{k=1,\dots,d}$ do not depend on n. We define the SVD of $\chi_0^{(k)}$ as $\mathbf{U}_k\left(\begin{array}{c} \Sigma_k \\ 0 \end{array}\right)\mathbf{V}_k^*$ for \mathbf{U}_k and \mathbf{V}_k unitary matrices respectively of size $n\times n$ and $r\times r$ and Σ_k a diagonal matrix with non-negative entries on the diagonal. \mathbf{V}_k and Σ_k do no depend on n because $\chi_0^{(k)*}\chi_0^{(k)} = \mathbf{V}_k\Sigma_k^2\mathbf{V}_k^*$.

n because $\chi_0^{(k)*}\chi_0^{(k)} = \mathbf{V}_k \mathbf{\Sigma}_k^2 \mathbf{V}_k^*$. We denote by \mathbf{Z} the noise tensor, and assume that its entries are $\mathcal{N}_{\mathbb{C}}(0,1/n)$ independent identically distributed complex circular Gaussian random variables.

In the following, we consider the alternative \mathcal{H}_0 : $\mathbf{Y} = \mathbf{Z}$ versus \mathcal{H}_1 : $\mathbf{Y} = \mathbf{X}_0 + \mathbf{Z}$. We denote by $p_{1,n}(\mathbf{y})$ the probability probability density of \mathbf{Y} under \mathcal{H}_1 and $p_{0,n}(\mathbf{y})$ the density of \mathbf{Y} under \mathcal{H}_0 . $\Lambda(\mathbf{Y}) = \frac{p_1(\mathbf{Y})}{p_0(\mathbf{Y})}$ is the likelihood ratio and we denote by \mathbb{E}_0 the expectation under \mathcal{H}_0 . We now recall the fundamental information geometry results used in [10] in order to address the detection problem. The following properties are well known (see also [1] section 3):

- (i) If $\mathbb{E}_0\left[\Lambda(\mathbf{Y})^2\right]$ is bounded, then no consistent detection test exists.
- (ii) If moreover $\mathbb{E}_0\left[\Lambda(\mathbf{Y})^2\right] = 1 + o(1)$, then the total variation distance between $p_{0,n}$ and $p_{1,n}$ converges towards 0, and no test performs better than a decision at random.

Therefore, the computation of the second order moment of $\Lambda(\mathbf{Y})$ under $p_{0,n}$ may provide insights on the detection. We however notice that conditions (i) and (ii) are only sufficient. In particular, if $\limsup_n \mathbb{E}_0 \left[\Lambda(\mathbf{Y})^2 \right] = +\infty$, nothing can be inferred on the behaviour of the detection problem when $n \to +\infty$.

3. EXPRESSION OF THE SECOND-ORDER MOMENT.

The density of \mathbf{Z} , seen as a collection of n^d complex-valued random variables, is obviously $p_{0,n}(\mathbf{z}) = \kappa_n \exp\left(-n \|\mathbf{z}\|_F^2\right)$ where $\kappa_n = \left(\frac{n}{\pi}\right)^{n^d}$. On the one hand, we notice that the second-order moment approach is not suited to the deterministic model of the spike as presented previously. Indeed, in this case $\mathbb{E}_0\left[\Lambda(\mathbf{Y})^2\right]$ has the simple expression $\exp\left(2n\|\mathbf{X}_0\|_F^2\right)$ and always diverges. On the other hand, the noise tensor shows an invariance property: if $\Theta_1,...,\Theta_d$ are unitary $n\times n$ matrices, then the density of the mode products $(\Theta_1\otimes\Theta_2...\otimes\Theta_d)\mathbf{Z}$ equals this of \mathbf{Z} . For d=2, the notation $(\Theta_1\otimes\Theta_2...\otimes\Theta_d)\mathbf{Z}$ simply means $\Theta_1\mathbf{Z}\Theta_2$ and for a general d, $((\Theta_1\otimes\Theta_2...\otimes\Theta_d)\mathbf{Z})_{i_1,...,i_d}$ is

$$\sum_{\ell_1,\ldots,\ell_d} \left(\Theta_1\right)_{i_1,\ell_1} \left(\Theta_2\right)_{i_2,\ell_2} \ldots \left(\Theta_d\right)_{i_d,\ell_d} \mathbf{Z}_{\ell_1,\ldots,\ell_d}.$$

We hence modify the data according to the procedure: we pick i.i.d. complex Haar samples $\Theta_1, ..., \Theta_d$ and consider the "new" data tensor defined as $(\Theta_1 \otimes \Theta_2 ... \otimes \Theta_d)$ Y. This does not affect the distribution of the noise, but this amounts to assume an artificial prior

on the spike. Indeed, the vectors $\mathbf{x}_0^{(k,i)}$ are replaced by $\boldsymbol{\Theta}_k \mathbf{x}_0^{(k,i)}$. They are all uniformly distributed on the unit sphere of \mathbb{C}^n and for $k \neq l$, vectors $\boldsymbol{\Theta}_k \mathbf{x}_0^{(k,i)}$ and $\boldsymbol{\Theta}_l \mathbf{x}_0^{(l,j)}$ are independent for each i,j. However, vectors $(\boldsymbol{\Theta}_k \mathbf{x}_0^{(k,i)})_{i=1,\dots,r}$ are not independent. In the following, the data and the noise tensors after this procedure are still denoted respectively by \mathbf{Y} and \mathbf{Z} . This transformation of the spike is an extension of a trick used in Section III.C of [10].

We are now in position to give a closed-form expression of the second-order moment of $\Lambda(\mathbf{Y})$. We have $p_{1,n}(\mathbf{Y}) = \mathbb{E}_X \left[p_{0,n}(\mathbf{Y} - \mathbf{X}) \right]$ where \mathbb{E}_X is the mathematical expectation over the distribution of the spike, or equivalently over the Haar matrices $(\Theta_k)_{k=1,\dots,d}$. It holds that

$$\mathbb{E}_{0}\left[\Lambda(\mathbf{Y})^{2}\right] = \mathbb{E}_{X,X'}\left[\exp\left(2n\Re\left\langle\mathbf{X},\mathbf{X}'\right\rangle\right)\right] = \\ \mathbb{E}_{X,X'}\left[\exp\left(2n\Re\sum_{i,j=1}^{r}\lambda_{i}\lambda_{j}\prod_{k=1}^{d}\left\langle\left(\boldsymbol{\Theta}_{k}'\right)^{*}\boldsymbol{\Theta}_{k}\mathbf{x}_{0}^{(k,i)},\mathbf{x}_{0}^{(k,j)}\right\rangle\right)\right]$$

where $\mathbb{E}_{X,X'}$ is over independent copies \mathbf{X},\mathbf{X}' of the spike associated respectively with $(\mathbf{\Theta}_k)_{k=1,\dots,d}$ and $(\mathbf{\Theta}_k')_{k=1,\dots,d}$. \mathfrak{R} stands for the real part. As $\mathbf{\Theta}_k$ and $\mathbf{\Theta}_k'$ are Haar and independent, then $(\mathbf{\Theta}_k')^*\mathbf{\Theta}_k$ is also Haar distributed and $\mathbb{E}_0\left[\Lambda(\mathbf{Y})^2\right] = \mathbb{E}\left[\exp\left(2n\eta\right)\right]$, where the expectation is over the i.i.d. Haar matrices $\mathbf{\Theta}_1,\mathbf{\Theta}_2,\dots,\mathbf{\Theta}_d$ and

$$\eta = \Re \sum_{i,j=1}^{r} \lambda_i \lambda_j \prod_{k=1}^{d} \left\langle \mathbf{\Theta}_k \mathbf{x}_0^{(k,i)}, \mathbf{x}_0^{(k,j)} \right\rangle. \tag{2}$$

 η may be factored as $\eta = \Re \left[\lambda^T \left(\odot_{k=1}^d \left(\chi_0^{(k)*} \Theta_k \chi_0^{(k)} \right) \right) \lambda \right]$. In the latter equation, \odot stands for the Hadamard product of matrices. The ultimate simplification comes from the SVD of $\chi_0^{(k)}$:

$$\boldsymbol{\chi}_0^{(k)*}\boldsymbol{\Theta}_k\boldsymbol{\chi}_0^{(k)} = \mathbf{V}_k \left(\begin{array}{cc} \boldsymbol{\Sigma}_k & \mathbf{0} \end{array} \right) \mathbf{U}_k^*\boldsymbol{\Theta}_k \mathbf{U}_k \left(\begin{array}{c} \boldsymbol{\Sigma}_k \\ \mathbf{0} \end{array} \right) \boldsymbol{\Sigma}_k \mathbf{V}_k^*.$$

Firstly, $\mathbf{U}_k^* \mathbf{\Theta}_k \mathbf{U}_k$ has the same distribution as $\mathbf{\Theta}_k$; secondly, we may associate with any $\mathbf{\Theta}_k$ its upper $r \times r$ block, that we will denote $\mathbf{\Psi}_k$. As a conclusion, we may express η as

$$\eta = \Re \left[\boldsymbol{\lambda}^T \left(\odot_{k=1}^d \left(\mathbf{V}_k \boldsymbol{\Sigma}_k \boldsymbol{\Psi}_k \boldsymbol{\Sigma} \mathbf{V}_k^* \right) \right) \boldsymbol{\lambda} \right].$$
(3)

4. EXTENDING KNOWN RESULTS

When r=1, Montanari *et al.* [10] found a bound on the parameter λ_1 ensuring that $\mathbb{E}_0\left[\Lambda(\mathbf{Y})^2\right]$ is bounded. In this case, η has a simple expression since $\eta=\lambda^2\mathfrak{R}\prod_{k=1}^d\xi_k$ where the $(\xi_k)_{k=1,...,d}$ are i.i.d. distributed as the first component of a uniform vector of the unit sphere of \mathbb{C}^n . As in [10], we introduce

$$\beta_d^{\text{2nd}} = \sqrt{\min_{u \in [0,1]} -\frac{1}{u^d} \log(1 - u^2)}.$$
 (4)

Adapting the result of the aforementioned article to the complexcircular context is straight-forward:

Theorem 1 (case r=1 (Montanari et al.)). Let $\xi_1, ..., \xi_d$ be i.i.d. distributed as the first component of a vector uniformly distributed on the unit sphere of \mathbb{C}^n .

If
$$\lambda_1 < \sqrt{\frac{d}{2}}\beta_d^{2nd}$$
 then $\mathbb{E}_0\left[\exp\left(2n\lambda_1^2\Re\prod_{k=1}^d\xi_k\right)\right]$ is bounded; moreover, if $d>2$, the above expectation is $I+o(I)$.

This non-obvious result may be used in order to derive a condition ensuring that hypotheses \mathcal{H}_0 and \mathcal{H}_1 are indistinguishable when r>1. In this respect, recall the expansion (2). Thanks to the Hölder inequality, $\mathbb{E}_0\left[\Lambda(\mathbf{Y})^2\right]$ is upper bounded by (see (2) for the definition of $\xi_k^{(i,j)}$)

$$\prod_{i,j=1}^{r} \mathbb{E}^{1/p_{i,j}} \left[\exp \left(2np_{i,j} \lambda_i \lambda_j \Re \prod_{k=1}^{d} \xi_k^{(i,j)} \right) \right]$$
 (5)

for any non-negative numbers $p_{i,j}$ such that $\sum_{i,j} \frac{1}{p_{i,j}} = 1$. For fixed i,j, we notice that the random variables $(\xi_k^{(i,j)})_{k=1,\dots,d}$ verify the condition of Theorem 1. Any of the expectations in (5) are hence upper-bounded when $n \to \infty$ provided that, for all i,j: $p_{i,j}\lambda_i\lambda_j < \frac{d}{2}\left(\beta_d^{2\mathrm{nd}}\right)^2$. Choosing eventually $p_{i,j} = \frac{\left(\sum_p \lambda_p\right)^2}{\lambda_i\lambda_i}$, we deduce

Theorem 2 (case $r \geq 1$ - extension of Theorem 1). If $\sum_{i=1}^{r} \lambda_i < \sqrt{\frac{d}{2}} \beta_d^{2nd}$ then $\mathbb{E}_0\left[\Lambda(\mathbf{Y})^2\right]$ is bounded. If moreover d > 2, we have $\mathbb{E}_0\left[\Lambda(\mathbf{Y})^2\right] = 1 + o(1)$ and the hypotheses \mathcal{H}_0 and \mathcal{H}_1 are indistinguishable.

Remark 3. Due to the use of the Hölder inequality, Theorem 2 is suboptimum in general. The inequality is patently an equality when $\forall k,i,j,\mathbf{x}_0^{(k,i)}=\mathbf{x}_0^{(k,j)}$, i.e. the spike has rank r=1 and amplitude $\sum_{i=1}^r \lambda_i$.

5. A TIGHTER BOUND

The main result of our contribution is the following

Theorem 4 (case $r \ge 1$). We define η_{\max} as

$$\eta_{\text{max}} = \lambda \left(\odot_{k=1}^d \chi_0^{(k)*} \chi_0^{(k)} \right) \lambda. \tag{6}$$

If
$$\sqrt{\eta_{\max}} < \sqrt{\frac{d}{2}} \beta_d^{2nd}$$
 then, for $d>2$, $\mathbb{E}_0\left[\Lambda(\mathbf{Y})^2\right] = 1 + o(1)$.

Before providing elements of the proof of the above result, we may briefly justify why the bound in Theorem 4 is tighter than this of Theorem 2, whatever the choice of λ . On the one hand, indeed, $\left(\sum_i \lambda_i\right)^2 = \lambda^T \mathbf{J} \lambda$ where \mathbf{J} is the $r \times r$ matrix having all its entries equal to 1. On the other hand, all the vectors $\mathbf{x}_0^{(k,i)}$ are normalized and consequently, any of the diagonal entries of $\boldsymbol{\chi}_0^{(k)*} \boldsymbol{\chi}_0^{(k)}$ equals 1 and for any $i \neq j$, $\left| (\boldsymbol{\chi}_0^{(k)*} \boldsymbol{\chi}_0^{(k)})_{i,j} \right| \leq 1$. This proves that $\left(\sum_i \lambda_i\right)^2 - \eta_{\max} = \boldsymbol{\lambda}^T \left(\mathbf{J} - \odot_{k=1}^d \boldsymbol{\chi}_0^{(k)*} \boldsymbol{\chi}_0^{(k)} \right) \boldsymbol{\lambda} \geq 0$.

We provide the key elements of the proof of Theorem 4. Remind that we are looking for a condition on the spike under which $\mathbb{E}\left[\exp\left(2n\eta\right)\right]$ is bounded. Evidently, the divergence may occur only when $\eta>0$. We hence consider $E_1=\mathbb{E}\left[\exp\left(2n\eta\right)\mathbf{1}_{\eta>\epsilon}\right]$ and $E_2=\mathbb{E}\left[\exp\left(2n\eta\right)\mathbf{1}_{\eta\leq\epsilon}\right]$, and prove that under the condition $\sqrt{\eta_{\max}}<\sqrt{\frac{d}{2}}\beta_d^{2\mathrm{nd}}$, for a certain small enough ϵ , $E_1=o(1)$ (for $d\geq 2$) and that $E_2=1+o(1)$ (for d>2).

The E_1 term. It is clear that the boundedness of the integral E_1 is achieved when η rarely deviates from 0. As remarked in [10], the natural machinery to consider to understand E_1 is this of the Large Deviation Principle (LDP). In essence, if η follows the LDP with rate n, there can be found a certain non-negative function called Good Rate Function (GRF) I_{η} such that for any Borel set A of \mathbb{R} ,

 $\frac{1}{n}\log\mathbb{P}\left(\eta\in A\right)$ converges towards $\sup_{x\in A}-I_{\eta}(x).$ The existence of a GRF allows one to analyze the asymptotic behaviour of integral $E_1.$ Indeed, the Varadhan lemma (see Theorem 4.3.1 in [6]) states that $\frac{1}{n}\log\mathbb{E}\left[\exp\left(2n\eta\right)\mathbf{1}_{\eta>\epsilon}\right]\to\sup_{x>\epsilon}\left(2x-I_{\eta}(x)\right)$ and hence the E_1 term converges towards 0 when $\sup_{x>\epsilon}\left(2x-I_{\eta}(x)\right)<0.$ We thus justify that η follows a Large Deviation Principle with

We thus justify that η follows a Large Deviation Principle with rate n, and we compute a lower bound of its GRF. For this, we use that for each k, the random matrix Ψ_k defined in (3) follows a LDP with rate n and that its GRF at the parameter $\psi \in \mathbb{C}^{r \times r}$ (we may evidently take $\|\psi\|_2 \leq 1$) is $\log \det (\mathbf{I}_r - \psi^* \psi)$ (see Theorem 3-6 in [7]). η is a function of the i.i.d. matrices $(\Psi_k)_{k=1,\dots,d}$. Therefore, the contraction principle (see Theorem 4.2.1 in [6]) ensures that η follows a LDP with rate n and GRF I_{η} given, for each real x in the range of η , as the solution of the optimization problem:

$$\max_{\forall k} \max_{0 \le \alpha_k \le 1} \max_{\substack{\forall k \ \|\boldsymbol{\psi}_k\| = \alpha_k \\ \eta(\boldsymbol{\psi}_1, ..., \boldsymbol{\psi}_d) = x}} \sum_{k=1}^d \log \det \left(\mathbf{I}_r - \boldsymbol{\psi}_k^* \boldsymbol{\psi}_k \right). \tag{7}$$

When $d \geq 3$, the solution of this optimization problem cannot apparently be expressed in closed form. We thus just provide a lower bound of $I_{\eta}(x)$. When d=2, it is possible to evaluate $I_{\eta}(x)$: see [5].

Proposition 5. For each $x \in \mathbb{R}$, it holds that

$$I_{\eta}(x) \ge -d \log \left(1 - \left(\frac{|x|}{\eta_{\text{max}}} \right)^{2/d} \right).$$
 (8)

where the right-hand side should be understood as $+\infty$ if $|x| \ge \eta_{\max}$.

In order to establish Proposition 5, we use the following algebraic result whose proof is omitted.

Lemma 6. For any matrices $(\mathbf{A}_k)_{k=1,...,d} \in \mathbb{C}^{r \times r}$ and vector $\lambda \in \mathbb{R}^r$, the supremum of $|\lambda^T \odot_{k=1}^d (\mathbf{A}_k \psi_k \mathbf{A}_k^*) \lambda|$ over $r \times r$ matrices ψ_k such that for all k: $||\psi_k||_2 = \alpha_k$ is

$$\left(\prod_{k=1}^{d} \alpha_{k}\right) \boldsymbol{\lambda}^{T} \left(\odot_{k=1}^{d} \left(\mathbf{A}_{k} \mathbf{A}_{k}^{*}\right)\right) \boldsymbol{\lambda}.$$

The immediate consequence of this lemma is that the random variable η is bounded and $|\eta| \leq \eta_{\max}$ where η_{\max} is given by (6). Moreover, take a set of matrices ψ_k such that $\|\psi_k\|_2 = \alpha_k \in [0,1]$; then by Lemma 6, $|\eta\left(\psi_1,...,\psi_d\right)| \leq \left(\prod_k \alpha_k\right) \eta_{\max}$ hence the optimization (7) is to be carried out only on the set of matrice ψ_k such that $\prod_k \alpha_k \geq \frac{|x|}{\eta_{\max}}$. On the other hand, one may use the generous bound $\log \det (\mathbf{I}_r - \psi_k^* \psi_k) \leq \log \left(1 - \|\psi_k\|_2^2\right)$ and finally prove that

$$-I_{\eta}(x) \le \max_{\prod_{k} \alpha_{k} \ge \frac{|x|}{\eta_{\max}}} \sum_{k=1}^{d} \log \left(1 - \alpha_{k}^{2}\right).$$

The supremum of the r.h.s. of this equation is achieved for balanced α_k and we immediately obtain (8). This completes the proof of Proposition 5.

Using Proposition 5 and setting $u=\left(\frac{|x|}{\eta_{\max}}\right)^{1/d}$, we obtain immediately that for each $\delta>0$:

$$\frac{1}{n}\log E_1 < \sup_{\tilde{\epsilon} \leq u \leq 1} \left[2u^d \left(\eta_{\max} + \frac{d}{2} \frac{1}{u^d} \log(1 - u^2) \right) \right] + \delta$$

for n large enough, where $\tilde{\epsilon}=(\epsilon/\eta_{\rm max})^{1/d}$. Recalling (4) and choosing δ small enough, we deduce that the condition $\eta_{\rm max}<\frac{d}{2}\left(\beta_d^{\rm 2nd}\right)^2$ implies that $E_1\to 0$. This holds for any order $d\geq 2$.

The E_2 term. The Varadhan lemma may be invoked: but its conclusion, namely $\frac{1}{n} \log E_2 \to 0$, says nothing on the boundedness of E_2 . We have, however

$$\begin{split} E_2 &= \int_0^\infty \mathbb{P}\left(\exp(2n\eta) \geq t \text{ and } \eta \leq \epsilon\right) \mathrm{d}t \\ &= \int_{-\infty}^0 \mathbb{P}\left(\eta \geq u \text{ and } \eta \leq \epsilon\right) 2n \exp(2nu) \mathrm{d}u + \\ &\int_0^\epsilon \mathbb{P}\left(\eta \geq u \text{ and } \eta \leq \epsilon\right) 2n \exp(2nu) \mathrm{d}u \\ &\leq \mathbb{P}\left(\eta \leq \epsilon\right) + \int_0^\epsilon \mathbb{P}\left(\eta \geq u\right) 2n \exp(2nu) \mathrm{d}u. \end{split}$$

A weak consequence of the LDP on η is the concentration of η around 0, namely $\mathbb{P}(\eta \leq \epsilon) = 1 - \mathbb{P}(\eta > \epsilon) = 1 - o(1)$. We recall the expanded expression for η : see (2). Notice that $\eta \geq u$ implies that at least one of the r^2 terms of this expansion is at least equal to $\frac{u}{r^2}$. By the union bound, and the fact that $\mathfrak{R}\prod_{k=1}^d \xi_k^{(i,j)} \leq \prod_{k=1}^d \left| \xi_k^{(i,j)} \right|$ we deduce that $\mathbb{P}(\eta \geq u) \leq \sum_{i,j=1}^r \mathbb{P}\left(\prod_{k=1}^d \left| \xi_k^{(i,j)} \right| \geq \frac{u}{r^2 \lambda_i \lambda_j}\right)$. Invoking again the union bound and noticing that for fixed i,j, $\left(\xi_k^{(i,j)}\right)_{k=1,\dots,d}$ have the same distribution, we deduce that

$$\mathbb{P}\left(\eta \ge u\right) \le d \sum_{i,j=1}^{r} \mathbb{P}\left(\left|\xi_{k}^{(i,j)}\right| \ge \left(\frac{u}{r^{2}\lambda_{i}\lambda_{j}}\right)^{1/d}\right).$$

Now, the density of
$$\xi_k^{(i,j)}$$
 is in polar coordinates $\frac{n-1}{\pi} \left(1-r^2\right)^{n-2}$ hence, choosing ϵ such that $\epsilon \leq r^2 \max_{i,j} \lambda_i \lambda_j$:
$$\mathbb{P}\left(\left|\xi_k^{(i,j)}\right| \geq \left(\frac{u}{r^2 \lambda_i \lambda_j}\right)^{1/d}\right) = \left(1-\left(\frac{u}{r^2 \lambda_i \lambda_j}\right)^{2/d}\right)^{n-1}.$$
 For any $0 \leq x < 1$, $\log(1-x) \leq -x$, hence

$$E_2 \le d \sum_{i,j} 2n \int_0^{\epsilon} \exp\left(-(n-1) \left(\frac{u}{r^2 \lambda_i \lambda_j}\right)^{2/d} + 2nu\right) du.$$

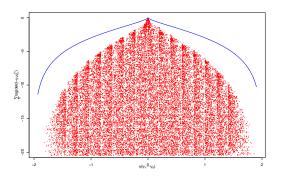
When d>2, it is always possible to determine ϵ sufficiently small such that $-(n-1)\left(\frac{u}{r^2\lambda_i\lambda_j}\right)^{2/d}+2nu\leq -\frac{n-1}{2}\left(\frac{u}{r^2\lambda_i\lambda_j}\right)^{2/d}$. This implies that, for such an ϵ , we have

$$E_2 \le d^2 r^2 n \left(\frac{2}{n-1}\right)^{d/2} \sum_{i,j} \lambda_i \lambda_j \int_0^\infty v^{d/2-1} \exp(-v) dv.$$

The r.h.s. is of course o(1) since d > 2.

Remark 7. The bound $\sqrt{\eta_{\rm max}} < \sqrt{\frac{d}{2}} \beta_d^{\rm 2nd}$ guarantees the nondetectability but it is not tight in general because, in order to study the asymptotics of E_1 , we replaced the true GRF I_{η} by the lower bound (8). Based on the loose inequality $\log \det (\mathbf{I}_r - \boldsymbol{\psi}_k^* \boldsymbol{\psi}_k) <$ $\log \det \left(1 - \|\boldsymbol{\psi}_k\|_2^2\right)$, (8) may not be very accurate. It is easy to check that the equality is reached in (8) when all the matrices $(\boldsymbol{\chi}_0^{(k)})_{k=1,...,d}$ are rank 1, *i.e.* if the rank of \mathbf{X}_0 is equal to 1. Therefore, the lower bound (8) of I_{η} is all the better as all the matrices $\chi_0^{(k)}$ are close to being rank 1 matrices. This suggests that, conversely, the bound (8) is likely to be loose when matrices $(\boldsymbol{\chi}_0^{(k)})_{k=1,\dots,d}$ are close to be orthogonal. As an illustration, we would like to consider experimental results. For a given configuration of the spike, we have chosen at random the matrices ψ_k

with $\|\psi_k\| \leq 1$. For each trial, we plot the points of coordinates $x = \eta(\psi_1,...,\psi_d)$ and $y = \sum_{k=1}^d \log \det (\mathbf{I}_r - \psi_k^* \psi_k)$ and we obtain a cloud the upper envelope of which is a representation of the true GRF of η ; for comparison, we have plotted the graph of the function defined by the lower bound (8). We have chosen r=2, d=3, and two configurations of the spike: in the first one, all the matrices χ_k have orthogonal columns (top graph of 1), in the second one, the eigenvalues of $\chi_k^* \chi_k$ are the same for k = 1, 2 equal to 1.8 and 0.2 (bottom graph of 1).



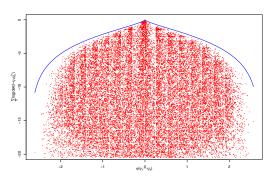


Fig. 1. $-I_{\eta}$ (seen as the upper envelope of the point constellation) and our upper bound

Remark 8. In the specific case d=2, it is possible to compute in closed-form the exact GRF I_{η} of η , and to establish the following result: if $\mu_{\max}(\mathbf{X}_0\mathbf{X}_0^*) < \beta_2^{2\mathrm{nd}} = 1$ (here, μ_{\max} denotes the largest eigenvalue), then E_1 converges towards 0 and E_2 is bounded: see

6. CONCLUSION

In this paper, we have addressed the detection problem of a rank rhigh-dimensional tensor X_0 . We have generalized the results of [10] to the case where r > 1, and established that if the parameter $\eta_{\rm max}$ defined by (6) is less that parameter β_2^{2nd} introduced in [10], the low rank tensor is undetectable. This condition is based on the lower bound (8) of the GRF I_{η} which is however not tight in general. It is thus relevant to try to improve this bound in a future work.
