ON SMALL TRAVELING WAVES TO THE MASS CRITICAL FRACTIONAL NLS

IVAN NAUMKIN AND PIERRE RAPHAËL

ABSTRACT. We consider the mass critical fractional (NLS)

$$i\partial_t u - |D|^s u + u |u|^{2s} = 0, \quad x \in \mathbb{R}, \quad 1 < s < 2.$$

We show the existence of travelling waves for all mass below the ground state mass, and give a complete description of the associated profiles in the small mass limit. We therefore recover a situation similar to the one discovered in [6] for the critical case s=1, but with a completely different asymptotic profile when the mass vanishes.

1. Introduction.

1.1. **Setting of the problem.** We study the existence and uniqueness of traveling waves for the mass critical fractional nonlinear Schrödinger equation

$$i\partial_t u - |D|^s u + u |u|^{2s} = 0, \quad x \in \mathbb{R}, \quad 1 < s < 2,$$
 (1.1)

where

$$D := -i\partial_x, \quad \mathcal{F}(|D|u) = |\xi|(\mathcal{F}u)(\xi),$$

which appear as limiting models in various physical situations, see [12], [4] and references therein. The existence of the ground state solution $u(t,x) = Q_s(x)e^{it}$, $Q_s > 0$, of (1.1) follows from classical variational arguments, and uniqueness is a deep result [12]. The ground state produces a sharp criterion of global existence: for all $u_0 \in H^{\frac{s}{2}}(\mathbb{R})$ with $||u_0||_{L^2} < ||Q_s||_{L^2}$, $\exists !u \in \mathcal{C}^0([0,\infty), H^{\frac{s}{2}})$ solution to (1.1), [5], and there exists a minimal blow up solution at the threshold $||u_0||_{L^2} = ||Q_s||_{L^2}$, [10]. For $||u_0||_{L^2} < ||Q||_{L^2}$, the behaviour of solutions dramatically depends on s:

 $\underline{s}=\underline{2}$: In the local case, all solutions below the ground state scatter, which is an elementary consequence of the pseudo-conformal symmetry for $u_0 \in H^1 \cap \{xu \in L^2\}$ and follows from the Kenig-Merle route map [9] coupled to Morawetz like estimates, [3]. Note that in this case, the travelling wave family generated by the ground state solitary wave is explicitly given by the action of Galilean symmetry

$$u(t,x) = Q_{s,\beta}(x-2\beta t)e^{i|\beta|^2t}, \quad Q_{s,\beta}(y) = e^{i\beta \cdot y}Q_s(y), \quad \beta \in \mathbb{R}$$

and hence the explicit degeneracy

$$\forall \beta \in \mathbb{R}, \ \|Q_{s,\beta}\|_{L^2} = \|Q_s\|_{L^2}.$$
 (1.2)

<u>s = 1</u>: The half wave case is treated in details in [6] where the existence of travelling $u(t,x) = Q_{s,\beta}(x-\beta t)$ is proved with

$$\lim_{\beta \uparrow 1} \|Q_{s,\beta}\|_{L^2} = 0.$$

In fact, a unique branch is constructed with the asymptotic behaviour

$$Q_{s,\beta}(x) = (Q_+ + o_{\beta \to 1}(1)) \left(\frac{x}{1-\beta}\right) \text{ as } \beta \uparrow 1$$
 (1.3)

where Q_{+} is the ground state to the limiting non-local Szegő equation

$$\partial_t u = \Pi_+(u|u|^2), \ \widehat{\Pi_+ u} = \mathbf{1}_{\xi > 0} \hat{u},$$

see [5, 16]. The existence of the critical speed $\beta = 1$ is the starting point for the construction of two bubbles interacting solitons with growing Sobolev norms, [16], [6].

1.2. Statement of the result. Our aim in this paper is to investigate the case 1 < s < 2 and show that a third scenario occurs. Let us consider the travelling wave problem. We define

$$u_{\beta}(t,x) := e^{it\gamma}Q_{\beta}(x-2\beta t),$$

where $\gamma = \gamma(\beta) \in \mathbb{R}$. Then, in order to solve (1.1), Q_{β} must satisfy the equation

$$[|D|^{s} - 2\beta D + \gamma] Q_{\beta} = Q_{\beta} |Q_{\beta}|^{2s}$$
(1.4)

which is the Euler-Lagrange equation corresponding to the minimization problem

$$E_{\beta}(N) := \inf \left\{ \mathcal{E}_{\beta}(u) : u \in H^{s/2}(\mathbb{R}) \text{ and } \int_{\mathbb{R}} |u|^2 = N \right\}$$
 (1.5)

where

$$\mathcal{E}_{\beta}(u) := \frac{1}{2} \int_{\mathbb{R}} \overline{u} |D|^{s} u - \beta \int_{\mathbb{R}} \overline{u} Du - \frac{1}{2s+2} \int_{\mathbb{R}} |u|^{2s+2}. \tag{1.6}$$

For $\beta = 0$, there holds the Gagliardo-Nirenberg-type inequality (see [17] and [18])

$$\int_{\mathbb{R}} |u|^{2s+2} \le C_s \left(\int_{\mathbb{R}} \overline{u} |D|^s u \right) \left(\int_{\mathbb{R}} |u|^2 \right)^s, \tag{1.7}$$

where $C_s = \frac{s+1}{\langle Q,Q \rangle^s}$, and the ground state Q_s is the optimizer of (1.7). We may now state the main results of this paper where to ease notations, we note $Q_s = Q$.

Existence of a minimizer for all mass below the ground state.

Theorem 1.1 (Existence of a minimizer). Let 1 < s < 2 and $\beta \ge 0$. Then, for all $0 < N < \|Q\|_{L^2}$, the problem (1.5) has a minimizer $Q_{\beta,N} \in H^{s/2}(\mathbb{R})$ with $\|Q_{\beta,N}\|_{L^2}^2 = N$ that satisfies (1.4) for some $\gamma = \gamma(\beta, N) \in \mathbb{R}$.

Asymptotic as $N \to 0$. For $0 < N < ||Q||_{L^2}^2$ and $\beta \ge 0$, we denote by $\mathbf{Q}_{\beta,N}$ the set of minimizers of the problem (1.5), which is not empty by the previous result. Let $\mathcal{R} \in H^1$ be the unique positive, radial symmetric solution of

$$-\triangle \mathcal{R} + \lambda(s) \mathcal{R} - \mathcal{R}^{2s+1} = 0$$
 (1.8)

with $\lambda(s) := \left(\frac{s(s-1)}{2}\rho_0^s\right)^{-\frac{2}{2-s}}$, $\rho_0 = \int |\mathcal{R}_0|^2$ and \mathcal{R}_0 -the solution to the equation $-\Delta \mathcal{R}_0 + \mathcal{R}_0 - \mathcal{R}_0^{2s+1} = 0$ (see Proposition 3.1 below). For $\beta \geq 0$, we denote

$$\xi^* = \left(\frac{2\beta}{s}\right)^{\frac{1}{s-1}}.$$

Theorem 1.2 (Asymptotics of $Q_{\beta,N}$ as $N \to 0$). Let $0 < N < ||Q||_{L^2}^2$, $\beta \ge 0$ and $Q_{\beta,N} \in \mathbf{Q}_{\beta,N}$. Consider the function

$$R_N(x) = \left(\frac{s(s-1)}{2}\right)^{-\frac{1}{2s}} e^{-i\left(\xi^* N^{-\frac{s}{2-s}}x\right)} N^{-\frac{1}{2-s}} (\xi^*)^{-1/2} Q_{\beta,N}\left(\frac{x}{N^{\frac{s}{2-s}}\xi^*}\right). \quad (1.9)$$

Then, there exist $\tilde{x}, \tilde{\gamma} \in \mathbb{R}$, $\tilde{\gamma} = \tilde{\gamma}(N)$ and $\tilde{x} = \tilde{x}(N)$, such that

$$\lim_{N \to 0} \left\| e^{i\tilde{\gamma}} R_N \left(\cdot + \tilde{x} \right) - \mathcal{R} \right\|_{H^r} = 0, \tag{1.10}$$

for any $r \geq 0$, uniformly with respect to $\beta \geq 0$. Moreover, suppose that $Q_{\beta,N}$ solves (1.4) with the Lagrange multiplier $\gamma(\beta,N) \in \mathbb{R}$ and let θ_N be given by $\theta_N = \frac{2}{s} \left((s-1)^{-1} \left(\frac{2\beta}{s} \right)^{-\frac{s}{s-1}} \gamma(\beta,N) - 1 \right)$. Then,

$$|\theta_N - \lambda(s)| = o(1)$$
, as $N \to 0$,

uniformly with respect to $\beta \geq 0$.

Uniqueness for small mass.

Theorem 1.3 (Uniqueness for small mass). There exists $0 < N_0 < \|Q\|_{L^2}^2$, such that the following holds. Given $0 < N < N_0$, $\beta \ge 0$ and $Q_{\beta,N}$, $\tilde{Q}_{\beta,N} \in \mathbf{Q}_{\beta,N}$, there exist $\phi, y \in \mathbb{R}$ such that

$$\tilde{Q}_{\beta,N}(x) = e^{i\phi} Q_{\beta,N}(x-y).$$

<u>Control of the tails</u>. Finally, we have a complete description of the tail of solutions for small mass. Let

$$C_1 = \sqrt{\frac{\pi}{2\lambda(s)}} \text{ and } C_2 = \frac{\left(si^{s+1} + (-i)^{s+1}\right)e^{-i\frac{x}{\kappa}}}{2\sqrt{2\pi}(s-1)}\Gamma(s), \qquad (1.11)$$

where $\Gamma(s)$ denotes the Gamma function.

Theorem 1.4 (Tail asymptotics for small mass). Let R_N be defined by (1.9) and $\tilde{x}, \tilde{\gamma} \in \mathbb{R}$ be such that (1.10) holds. Then, the following asymptotics are valid

$$e^{i\tilde{\gamma}}R_{N}(x+\tilde{x}) = C_{1}e^{-\sqrt{\lambda(s)}|x|} \int e^{\sqrt{\lambda(s)}y} \left(|\mathcal{R}|^{2s} \mathcal{R} \right) (y) dy + \frac{C_{2}N^{\frac{s(2+s)}{2-s}}}{|x|^{s+1}} \int |\mathcal{R}|^{2s} \mathcal{R}$$
$$+ \left(e^{-\sqrt{\lambda(s)}|x|} + \frac{N^{\frac{s(2+s)}{2-s}}}{|x|^{s+1}} \right) \left(o_{|x|}(1) + o_{N}(1) \right),$$

where $o_N(1) \to 0$, as $N \to 0$, and $o_{|x|}(1) \to 0$, as $|x| \to \infty$.

Comments on the results.

- 1. Existence and uniqueness. The existence proof follows the path [4] which adapts the classical concentration compactness argument [14]. Let us say that we focused on dimension d=1 only for the sake of simplicity, but clearly the argument can be extended to higher dimensions as well. Uniqueness in the small mass limit requires a careful renormalization on the Fourier side and the sharp understanding of the role Galilean drifts which generate an explicit symmetry group for s=2 only. Related renormalization occur for example in [15] for the description of high momentum solitary waves. Note that like the case s=1 (1.3), a concentration phenomenon occurs in the limit N=0, but the associated profile corresponds to a local limiting (NLS) problem, profile \mathcal{R} , and concentration occurs with large Galilean like oscillations, (1.9).
- 2. Tails and interaction. The computation of the tail of the travelling wave in Theorem 1.4 relies on a careful computation of the Fourier side. Related results for the travelling waves of the Gross Pitaevski equation are given in [7]. In [6], the sharp

description of the tail of the travelling wave is an essential step for the derivation of the modulation equations associated to energy exchanges between two interacting solitary waves. The derivation of related modulation equations for 1 < s < 2 and the description of multiple bubbles interaction is a challenging problem due to the presence of additional high Galilean like oscillations, but Theorems 1.3-1.4 are the necessary starting point for such an investigation.

The paper is organized as follows. In Section 2 we prove Theorem 1.1. We translate problem (1.5) to a β -independent problem and we prove the existence of minimizers for this translated problem. Section 3 is devoted to the proof of Theorem 1.2. Again, we translate (1.5) to a problem where the mass of the minimizers is independent on N. We obtain an asymptotic expansion for small N for the minimizers of this new problem and for the corresponding Lagrange multipliers. These yield the results of Theorem 1.2. Section 4 is dedicated to the proof of Theorem 1.3. Finally, in Section 5 we prove Theorem 1.4.

2. Existence of traveling waves

This Section is devoted to the proof of the existence of solutions to (1.4). First, we want to reduce (1.5) to a problem independent on β . For $1 < s \le 2$ and $\beta \ge 0$ we define the transform τ_{β} by

$$(\tau_{\beta}u)(x) := (\xi^*)^{1/2} e^{i(\xi^*x)} u(\xi^*x),$$
 (2.1)

where $\xi^* = \left(\frac{2\beta}{s}\right)^{\frac{1}{s-1}}$. For any $\xi \in \mathbb{R}$ we define

$$n(\xi) = |\xi + 1|^s - s\xi - 1$$
 (2.2)

We consider the minimization problem

$$I(N) = \inf \left\{ \mathcal{I}(v) : v \in H^{s/2}(\mathbb{R}) \text{ and } \int |v|^2 = N \right\}, \tag{2.3}$$

where

$$\mathcal{I}(v) = \frac{1}{2} \left(\int_{\mathbb{D}} \overline{v} n(D) v - \frac{1}{s+1} \int_{\mathbb{D}} |v|^{2s+2} \right)$$

with $n(D) = \mathcal{F}^{-1}n(\xi)\mathcal{F}$. A minimizer of (2.3) satisfies the equation

$$n(D) S + \eta S = S |S|^{2s},$$
 (2.4)

with some constant $\eta \in \mathbb{R}$. We now prove the following:

Lemma 2.1. Let $1 < s \le 2$ and $\beta \ge 0$. Suppose that $S \in H^{s/2}(\mathbb{R})$ is a minimizer for (2.3). Then, $Q_{\beta}(x) = (\tau_{\beta}S)(x)$ minimizes (1.5). Moreover, if $S \in H^{s/2}(\mathbb{R})$ solves (2.4) with some Lagrange multiplier $\theta \in \mathbb{R}$, $Q_{\beta}(x) = (\tau_{\beta}S)(x)$ is a solution to (1.4) with $\gamma = \tilde{\gamma} = (\xi^*)^s (\eta + s - 1)$.

Proof. We denote

$$m_{\beta}\left(\xi\right) := \left|\xi\right|^{s} - 2\beta\xi.$$

Observe that

$$m'_{\beta}(\xi) = 0 \text{ for } \xi = \xi^*$$

and

$$m_{\beta}(\xi^*) = -(\xi^*)^s (s-1).$$

Note that

$$(|D|^s - 2\beta D - m_\beta(\xi^*)) \left(e^{i\xi^*x}v\right) = e^{i\xi^*x} \left(|D + \xi^*|^s - 2\beta D - (\xi^*)^s\right)v.$$

Then, using that $Q_{\beta}(x) = (\tau_{\beta}S)(x)$ we have

$$[|D|^{s} - 2\beta D] Q_{\beta} = [|D|^{s} - 2\beta D - m_{\beta}(\xi^{*})] Q_{\beta} + m_{\beta}(\xi^{*}) Q_{\beta}$$

= $e^{i\xi^{*}x} (\xi^{*})^{1/2} ((\xi^{*})^{s} (n(D)S) (\xi^{*}x) + m_{\beta}(\xi^{*}) S (\xi^{*}x)).$ (2.5)

Then, we get

$$\mathcal{E}_{\beta}\left(Q_{\beta}\right) = (\xi^{*})^{s} \mathcal{I}\left(S\right) + \frac{m_{\beta}\left(\xi^{*}\right) N}{2}.$$

Hence, if S minimizers (2.3), Q_{β} solves (1.5). Next, consider equation (1.4). Using (2.5) we obtain

$$[|D|^{s} - 2\beta D + \gamma] Q_{\beta} - Q_{\beta} |Q_{\beta}|^{2s}$$

$$= e^{i(\xi^{*}x)} (\xi^{*})^{\frac{2s+1}{2}} \left(n(D) S - S |S|^{2s} + (\xi^{*})^{-s} [\gamma - (\xi^{*})^{s} (s-1)] S \right),$$

and thus, as $\gamma = \tilde{\gamma}$ and S solves (2.4), we conclude that

$$[|D|^{s} - 2\beta D + \gamma] Q_{\beta} - Q_{\beta} |Q_{\beta}|^{2s} = 0.$$

This proves Lemma 2.1. ■

Below we will show that problem (2.3) has a minimizer. More precisely, we aim to prove the following:

Theorem 2.2. Let 1 < s < 2. Then, for all $0 < N < \langle Q, Q \rangle$, problem (2.3) has a minimizer $S_N \in H^{s/2}(\mathbb{R})$. In particular, S_N solves (2.4) with some $\eta = \eta_N \in \mathbb{R}$.

Remark 2.3. Note that Theorem 1.1 follows immediately from Lemma 2.1 and Theorem 2.2.

We begin by preparing several results that are involved in the proof of Theorem 2.2. First we prove one elementary lemma.

Lemma 2.4. For any $0 \le A < 1$, the estimate

$$n(\xi) - A|\xi|^s \ge \frac{1}{2}(1-A)|\xi|^s - C(A),$$
 (2.6)

with some C(A) > 0 is satisfied.

Proof. Since

$$|\xi + 1|^s \ge |\xi|^s - 2^s |\xi|^{s-1}$$
, for $|\xi| \ge 2$,

we have

$$n(\xi) - A|\xi|^{s} \ge (1 - A)|\xi|^{s} - 2^{s+2}|\xi|.$$

Then, noting that

$$\frac{1}{2} (1 - A) |\xi|^s - 2^{s+2} |\xi| \ge 0,$$

if $|\xi| \ge c_1(A) = \left(2^{s+3} (1-A)^{-1}\right)^{\frac{1}{s-1}}$, we deduce that

$$n(\xi) - A|\xi|^s \ge \frac{1}{2} (1 - A) |\xi|^s,$$
 (2.7)

for $|\xi| \geq c_1(A)$. If $|\xi| \leq c_1(A)$, as $n(\xi) \geq 0$, for all $\xi \in \mathbb{R}$, we estimate

$$n(\xi) - A|\xi|^s \ge \frac{1}{2}(1-A)|\xi|^s - c_2(A),$$
 (2.8)

where $c_2(A) = (A+1)(c_1(A))^s$. Estimates (2.7) and (2.8) imply (2.6).

In order to prove Theorem 2.2, first we show that I(N) is bounded from below. We prove the following:

Lemma 2.5. Let $1 < s \le 2$. Then, for all $0 < N \le \langle Q, Q \rangle$, the following inequality holds

$$2\mathcal{I}\left(v\right) \ge \frac{1}{2} \left(1 - \frac{N^{s}}{\langle Q, Q \rangle^{s}}\right) \int_{\mathbb{R}} \overline{u} \left|D\right|^{s} u - C\left(N\right) \ge -C\left(N\right), \tag{2.9}$$

for $v \in H^{s/2}(\mathbb{R})$ such that $\int |v|^2 = N$. Moreover, any minimizing sequence for problem (2.3) is bounded in $H^{s/2}(\mathbb{R})$, for $0 < N < \langle Q, Q \rangle$.

Proof. Let $v \in H^{s/2}(\mathbb{R})$ be such that $\int |v|^2 = N$. By (1.7) we have

$$2\mathcal{I}(v) \ge \int_{\mathbb{R}} \overline{v} \left(n(D) v - \frac{N^s}{\langle Q, Q \rangle^s} \int_{\mathbb{R}} \overline{v} |D|^s v \right). \tag{2.10}$$

Using (2.6) with $A = \frac{N^s}{\langle Q, Q \rangle^s}$ we get

$$n\left(\xi\right) - \frac{N^{s}}{\langle Q, Q \rangle^{s}} \left|\xi\right|^{s} \ge \frac{1}{2} \left(1 - \frac{N^{s}}{\langle Q, Q \rangle^{s}}\right) \left|\xi\right|^{s} - C\left(N\right), \tag{2.11}$$

for some C(N) > 0. Using (2.11) in (2.10) we attain (2.9). The boundedness of minimizing sequences for (2.3) follows immediately from (2.9).

Next, we show that the infimum I(N) is strictly negative. We have:

Lemma 2.6. Let 1 < s < 2 and $0 < N < \langle Q, Q \rangle$. Then, the estimate

$$I\left(N\right) < 0 \tag{2.12}$$

holds.

Proof. Let $v \in \mathcal{S}$ be such that $\widehat{v}(\xi)$ is supported on $B := \{\xi \in \mathbb{R} : \xi > 0\}$ and $\int |v|^2 = N$. We take $\chi(t)$ such that $\chi(t) = 1$, for $0 \le t \le 1$ and $\chi(t) = 0$, for t > 1. By Taylor's theorem, for $\xi > 0$ we have

$$n(\xi) = \chi(\xi) n(\xi) + (1 - \chi(\xi)) n(\xi)$$
$$= \chi(\xi) \left(\int_0^{\xi} n''(\tau) (\xi - \tau) dt \right) + (1 - \chi(\xi)) n(\xi).$$

Then, we get

$$\int_{\mathbb{R}} n(\xi) |\hat{v}(\xi)|^{2} d\xi
= \int_{\mathbb{R}} \chi(\xi) \left(\int_{0}^{\xi} n''(\tau) (\xi - \tau) d\tau \right) |\hat{v}(\xi)|^{2} d\xi + \int_{\mathbb{R}} (1 - \chi(\xi)) (\xi + 1)^{s} |\hat{v}(\xi)|^{2} d\xi
- \int_{\mathbb{R}} (1 - \chi(\xi)) (s\xi + 1) |\hat{v}(\xi)|^{2} d\xi.$$

Thus, using that

$$\chi\left(\xi\right) \int_{0}^{\xi} n''\left(\tau\right) \left(\xi - \tau\right) d\tau \le \frac{s\left(s - 1\right)}{2} \xi^{2}$$

and

$$(1 - \chi(\xi))(\xi + 1)^s \le 2^s \xi^2,$$

for $\xi > 0$, we see that

$$\int_{\mathbb{R}} n(\xi) |\hat{v}(\xi)|^2 d\xi \le 2^{s+1} \int_{\mathbb{R}} \xi^2 |\hat{v}(\xi)|^2 d\xi.$$

Therefore, we obtain

$$\mathcal{I}(v) \le 2^{s} \int_{\mathbb{R}} \overline{v}(-\Delta) v - \frac{1}{2s+2} \int_{\mathbb{R}} |v|^{2s+2}.$$

Let now $w \in \mathcal{S}$ be such that $\widehat{w}(\xi)$ is supported on B and $\int |w|^2 = N$. We take $v(x) = \lambda^{1/2} w(\lambda x)$. Then,

$$\mathcal{I}(v) \le \lambda^{s} \left(2^{s} \lambda^{2-s} \int_{\mathbb{R}} \overline{w} \left(-\Delta \right) w - \frac{1}{2s+2} \int_{\mathbb{R}} |w|^{2s+2} \right). \tag{2.13}$$

As s < 2, choosing $\lambda > 0$ small enough we show that

$$2^{s} \lambda^{2-s} \int_{\mathbb{R}} \overline{w} (-\Delta) w - \frac{1}{2s+2} \int_{\mathbb{R}} |w|^{2s+2} < 0.$$
 (2.14)

Therefore, by (2.13) and (2.14) we obtain

$$I(N) \le \mathcal{I}(v) < 0$$

and (2.12) follows.

In the next lemma we show that I(N) enjoys a strict sub-additivity condition.

Lemma 2.7. Let 1 < s < 2, $0 < N < \langle Q, Q \rangle$ and $0 < \alpha < N$. Then, the following estimate holds

$$I(N) < I(\alpha) + I(N - \alpha). \tag{2.15}$$

Moreover, the function I(N) is strictly decreasing and continuous on $0 < N < \langle Q, Q \rangle$.

Proof. We follow the proof of Lemma 2.3 of [4]. Suppose that $0 < N < \langle Q, Q \rangle$. Then, by Lemma 2.5, I(N) is finite. Observe that

$$I(N) = N(I_1(N)),$$

where

$$I_{1}(N) := \inf_{v \in H^{s/2}(\mathbb{R}), \|v\|_{L^{2}}^{2} = 1} \left\{ \frac{1}{2} \left(\int_{\mathbb{R}} \overline{v} n(D) v - \frac{N^{s}}{s+1} \int_{\mathbb{R}} |v|^{2s+2} \right) \right\}.$$
 (2.16)

We can restrict the infimum in (2.16) to elements $v \in H^{s/2}(\mathbb{R})$, $\|v\|_{L^{2}}^{2} = 1$ such that

$$\int_{\mathbb{R}} |v|^{2s+2} \ge c > 0. \tag{2.17}$$

Indeed, otherwise there exists a minimizing sequence $\{v_m\}_{m=0}^{\infty}$ such that

$$\int_{\mathbb{R}} |v_m|^{2s+2} \to 0.$$

As $n(\xi) \geq 0$, for all $\xi \in \mathbb{R}$, we see that

$$\int_{\mathbb{D}} \overline{v}_m n\left(D\right) v_m \ge 0,$$

for all $m \geq 1$. Then,

$$I(N) = \lim_{m \to \infty} \mathcal{I}(v_m) \ge 0.$$

The last relation contradicts (2.12). Hence, (2.17) holds. Relation (2.17) implies that $I_1(N)$, as function of N, is strictly decreasing. Then,

$$I(\theta N) = \theta N(I_1(\theta N)) < \theta N(I_1(N)) = \theta I(N),$$

for $\theta > 1$. Thus, (2.15) follows from Lemma II.1 of [14]. Now, as $I_1(N)$ is strictly decreasing and $I_1(N) < 0$, by (2.12), for $0 < N < N_1 < \langle Q, Q \rangle$, we have

$$I(N_1) = N_1(I_1(N_1)) < N_1(I_1(N)) < N(I_1(N)) = I(N)$$

and hence, I(N) is strictly decreasing. Since N^s is convex for s > 1, $I_1(N)$ must be concave on $0 < N < \langle Q, Q \rangle$, and hence $I_1(N) \in C((0, \langle Q, Q \rangle))$. Therefore, it follows that I(N) is continuous on $0 < N < \langle Q, Q \rangle$.

We define the functional

$$\mathcal{L}(u) := \int_{\mathbb{R}} \overline{u} n(D) u + \int_{\mathbb{R}} |u|^2.$$
 (2.18)

We need now the following profile decomposition result for a bounded sequence in $H^{s/2}(\mathbb{R})$.

Lemma 2.8. Let $\{u_n\}_{n=1}^{\infty}$ be a bounded sequence in $H^{s/2}(\mathbb{R})$, 1 < s < 2. Then, there exist a subsequence of $\{u_n\}_{n=1}^{\infty}$ (still denoted $\{u_n\}_{n=1}^{\infty}$), a family $\{\mathbf{x}^j\}_{j=1}^{\infty}$ of sequences in \mathbb{R} , with

$$\left|x_n^k - x_n^j\right| \to +\infty, \text{ as } n \to \infty, \text{ for } k \neq j,$$
 (2.19)

and a sequence $\{V^j\}_{j=1}^{\infty}$ of $H^{s/2}(\mathbb{R})$ functions, such that for every $l \geq 1$ and every $x \in \mathbb{R}$,

$$u_n(x) = \sum_{j=1}^{l} V^j(x - x_n^j) + u_n^l(x),$$
 (2.20)

where the series $\sum_{j=1}^{\infty} \|V^j\|_{H^{s/2}(\mathbb{R})}^2$ converges and

$$\lim \sup_{n \to \infty} \left\| u_n^l(x) \right\|_{L^p(\mathbb{R})} \to 0, \quad as \ l \to \infty, \tag{2.21}$$

for every p > 2. Moreover, as $n \to \infty$,

$$\|u_n\|_{L^2}^2 = \sum_{j=1}^l \|V^j\|_{L^2}^2 + \|u_n^l\|_{L^2}^2 + o(1),$$
 (2.22)

$$\left\| |\nabla|^{s/2} u_n \right\|_{L^2}^2 = \sum_{i=1}^l \left\| |\nabla|^{s/2} V^j \right\|_{L^2}^2 + \left\| |\nabla|^{s/2} u_n^l \right\|_{L^2}^2 + o(1), \qquad (2.23)$$

and

$$\mathcal{L}(u_n) = \sum_{j=1}^{l} \mathcal{L}(V^j) + \mathcal{L}(u_n^l) + o(1).$$
 (2.24)

Proof. See the proof of Proposition 2.1 of [8] for the case of bounded sequence in $H^1(\mathbb{R})$. The proof for the fractional case $H^{s/2}(\mathbb{R})$, 1 < s < 2, is analogous. We only make a comment on (2.24). Since $n(\xi) \leq C(|\xi|^s + 1)$, using (2.6) with A = 0, we deduce

$$c(|\xi|^s + 1) \le n(\xi) + 1 \le C(|\xi|^s + 1).$$

for some constants $0 < c \le C$. Therefore, the norm $||u||_{\mathcal{L}} := \sqrt{\mathcal{L}(u)}$ is equivalent to the $H^{s/2}(\mathbb{R})$ norm. Hence, relation (2.24) is obtained similarly to (2.22) and (2.23).

Lemma 2.9. The functional $\mathcal{L}(u)$, defined by (2.18), is weakly semicontinuos in $H^{s/2}(\mathbb{R})$. That is, if $u_n \rightharpoonup u$ weakly in $H^{s/2}(\mathbb{R})$, as $n \to \infty$,

$$\liminf_{n\to\infty} \mathcal{L}\left(u_n\right) \geq \mathcal{L}\left(u\right).$$

Moreover, if $\lim_{n\to\infty} \mathcal{L}(u_n) = \mathcal{L}(u)$ is valid, $\{u_n\}_{n=0}^{\infty}$ converges strongly to u in $H^{s/2}(\mathbb{R})$.

Proof. As noted in the proof of Lemma 2.8, the norm $\|u\|_{\mathcal{L}} = \sqrt{\mathcal{L}(u)}$ is equivalent to the $H^{s/2}(\mathbb{R})$ norm. By Plancharel theorem, the norm $\|u\|_{\mathcal{L}}$ is equivalent to a weighted L^2 -norm. Then, the result of Lemma 2.9 follows from Theorem 2.11 of [13].

Now we have all the ingredients to prove Theorem 2.2.

Proof of Theorem 2.2. Suppose that $0 < N < \langle Q, Q \rangle$, where Q is an optimizer of (1.7). Let $\{u_n\}_{n=0}^{\infty}$ be a minimizing sequence for (2.3). Then,

$$\lim_{n\to\infty} \mathcal{I}\left(u_n\right) = I\left(N\right), \text{ with } u_n \in H^{s/2}\left(\mathbb{R}\right) \text{ and } \int_{\mathbb{R}} \left|u_n\right|^2 = N, \text{ for all } n \geq 0. \tag{2.25}$$

Since by Lemma 2.5 $\{u_n\}_{n=0}^{\infty}$ is bounded in $H^{s/2}(\mathbb{R})$, it follows from Lemma 2.8 that there exist a subsequence of $\{u_n\}_{n=0}^{\infty}$ that we still denote by $\{u_n\}_{n=0}^{\infty}$ and a sequence $\{V^j\}_{j=1}^{\infty}$ of $H^{s/2}(\mathbb{R})$ functions, such that for every $l \geq 1$ and $x \in \mathbb{R}$, (2.20) holds. Note that as $\int_{\mathbb{R}} |u_n|^2 = N$, by (2.22) $\sum_{j=1}^{\infty} ||V^j||_{L^2} \leq N$. Moreover, $\sum_{j=1}^{\infty} ||V^j||_{L^2}$ is strictly positive. Otherwise, $V^j \equiv 0$, for all $j \in \mathbb{N}$ and then, (2.20) would imply that $||u_n||_{L^p} \to 0$, as $n \to \infty$, for all p > 2. This contradicts (2.12), by an argument similar to the proof of (2.17).

Suppose that $\sum_{j=1}^{\infty} \|V^j\|_{L^2} = \alpha$, for some $0 < \alpha < N$, and define

$$V_n(x) := \sum_{j=1}^{l} V^j \left(x - x_n^j \right)$$

and

$$W_n(x) := u_n^l(x).$$

Then, by (2.20),

$$u_n(x) = V_n(x) + W_n(x).$$

Since

$$||V_n(x)||^2 = \sum_{j=1}^l ||V^j||^2 + \sum_{j,k=1, j \neq k}^l \left(V^j(x - x_n^j), V^k(x - x_n^k)\right)$$
(2.26)

and

$$\sum_{j,k=1,\;j\neq k}^{l} \left(V^{j} \left(x - x_{n}^{j} \right), V^{k} \left(x - x_{n}^{k} \right) \right) = o\left(1 \right), \text{ as } n \rightarrow \infty,$$

due to the orthogonality property (2.19), we have

$$\|V_n(x)\|^2 = \sum_{j=1}^l \|V^j\|^2 + o(1), \text{ as } n \to \infty.$$
 (2.27)

Thus, as $\sum_{j=1}^{\infty} ||V^j||_{L^2} = \alpha$, from (2.22) we deduce that for a given $\varepsilon > 0$, there is some $l, n_0 \ge 0$, such that for all $n \ge n_0$,

$$\left| \left\| V_n(x) \right\|^2 - \alpha \right| \le \varepsilon \text{ and } \left| \left\| W_n \right\|^2 - (N - \alpha) \right| \le \varepsilon.$$
 (2.28)

Using that
$$(|a| + |b|)^p \le C \left(|a|^{p-1} |b| + |a| |b|^{p-1} \right)$$
, we have
$$||V_n(x) + W_n(x)|^p - |V_n(x)|^p - |W_n(x)|^p |$$

$$\le C \left(|V_n(x)|^{p-1} |W_n(x)| + |V_n(x)| |W_n(x)|^{p-1} \right).$$

Then, for some l and all n sufficiently large, by (2.19) and (2.21) we deduce

$$\|u_n\|_{L^p}^p \le \|V_n(x)\|_{L^p}^p + \|W_n(x)\|_{L^p}^p + \delta_p(\varepsilon),$$
 (2.29)

with $\delta_p(\varepsilon) \to 0$, as $\varepsilon \to 0$. Similarly to (2.27) we show that

$$\mathcal{L}(V_n) = \sum_{j=1}^{l} \mathcal{L}(V^j) + o(1), \text{ as } n \to \infty.$$

Therefore, from (2.24) we see that

$$\mathcal{L}(u_n) = \mathcal{L}(V_n) + \mathcal{L}(W_n) + o(1), \text{ as } n \to \infty.$$
 (2.30)

Using (2.29) and (2.30) we obtain

$$I(N) = \lim_{n \to \infty} \mathcal{I}(u_n) \ge \liminf_{n \to \infty} \mathcal{I}(V_n) + \liminf_{n \to \infty} \mathcal{I}(W_n) - \delta_p(\varepsilon).$$
 (2.31)

Then, as I(N) is strictly decreasing by Lemma 2.7, using (2.28), from (2.31) we deduce that

$$I(N) \ge I(\alpha + \varepsilon) + I((N - \alpha) + \varepsilon) - \delta_p(\varepsilon).$$
 (2.32)

By Lemma 2.7, I(N) is continuous on $0 < N < \langle Q, Q \rangle$. Then, taking the limit as $\varepsilon \to 0$ in (2.32) we see that

$$I(N) \ge I(\alpha) + I(N - \alpha),$$
 (2.33)

for some $\alpha \in (0,N)$. This contradicts (2.15). Therefore, we get $\sum_{j=1}^{\infty} \|V^j\|_{L^2} = N$. Suppose that $\sum_{j=1}^{\infty} \|V^j\|_{L^2} = N$ and that there are at least to functions V^{j^0} and V^k , for some $j^0, k \geq 0$, that are not identically 0. Let $\alpha = \|V^{j^0}\|_{L^2}^2$. By assumption, $0 < \alpha < N$. We define

$$\tilde{V}_n\left(x\right) := V^{j^0} \left(x - x_n^{j^0}\right)$$

and

$$\tilde{W}_{n}(x) := \sum_{j=1, j \neq j^{0}}^{l} V^{j}(x - x_{n}^{j}) + u_{n}^{l}(x).$$

Note that by (2.22) $\limsup_{n\to\infty} \|u_n^l\|_{L^2}^2 \to 0$, as $l\to\infty$. Then, similarly to (2.28) we have

$$\left| \left\| \tilde{V}_n(x) \right\|^2 - \alpha \right| \le \varepsilon \text{ and } \left| \left\| \tilde{W}_n \right\|^2 - (N - \alpha) \right| \le \varepsilon.$$

Then, arguing as in the case when $\sum_{j=1}^{\infty} \|V^j\|_{L^2} = \alpha$, for some $0 < \alpha < N$, we arrive to (2.33), which contradicts (2.15).

By discussion so far, the sum $\sum_{j=1}^{\infty} \|V^j\|_{L^2} = \|V^{j^0}\|_{L^2} = N$, for some $j^0 \ge 1$. Then, Lemma 2.8 implies that there exist a subsequence of $\{u_n\}_{n=0}^{\infty}$ (still denoted by $\{u_n\}_{n=0}^{\infty}$) and a sequence of real numbers $\{x_n\}_{n=0}^{\infty}$, such that $\tilde{u}_n := u_n (\cdot + x_n)$ converges strongly in $L^p(\mathbb{R})$, $p \ge 2$, to $S_N := V^{j^0}$, as $n \to \infty$. Therefore, by Lemma 2.9 we have

$$I(N) = \lim_{n \to \infty} \mathcal{I}(\tilde{u}_n) \ge \mathcal{I}(S_N) \ge I(N).$$
(2.34)

The last relation implies that $S_N \in H^{s/2}(\mathbb{R})$ is a minimizer for (1.5). Finally, we note that by (2.34), $\lim_{n\to\infty} \mathcal{L}(\tilde{u}_n) = \mathcal{L}(S_N)$. Then, Lemma 2.9 shows that in fact \tilde{u}_n converges strongly to S_N in $H^{s/2}(\mathbb{R})$, as $n\to\infty$.

3. Small-mass behavior of traveling waves.

We now investigate the structure of small mass solitary waves. Consider the minimization problem

$$I_{0} = \inf \left\{ \mathcal{I}_{0}\left(v\right) : v \in H^{1}\left(\mathbb{R}\right) \text{ and } \int \left|v\right|^{2} = s_{0} \right\}, \tag{3.1}$$

where

 $s_0 := \left(\frac{s\left(s-1\right)}{2}\right)^{-\frac{1}{s}}$

and

$$\mathcal{I}_{0}(v) = \frac{1}{2} \int_{\mathbb{R}} \overline{v} |D|^{2} v - \frac{1}{2s+2} \int_{\mathbb{R}} |v|^{2s+2}.$$

We now formulate a result on existence and characterization of minimizers for problem (3.1) (see Chapter 8 of [1]).

Proposition 3.1. There exists a real, positive and radially symmetric function $\mathcal{R} \in H^1$ such that:

- i) The set of minimizers of (3.1) is characterized by the family $e^{i\gamma_0}\mathcal{R}(x-x_0)$, $x_0, \gamma_0 \in \mathbb{R}$.
- ii) For any sequence $\{v_n\}_{n=0}^{\infty} \in H^1$, such that $||v_n|| \to s_0^{1/2}$ and $\mathcal{I}_0(v_n) \to I_0$, as $n \to \infty$, there exist $x_n, \gamma_n \in \mathbb{R}$ and a strictly increasing sequence $\phi : \mathbb{N} \to \mathbb{N}$, with the property:

$$e^{i\gamma_{\phi(n)}}v_{\phi(n)}\left(\cdot+x_{\phi(n)}\right)\to\mathcal{R},\ in\ H^1.$$

iii) $\mathcal{R} \in H^1$ is the unique positive, radial symmetric solution of (1.8).

We aim to compare the minimizers S_N of (2.3) with the minimizer \mathcal{R} of (3.1). For this purpose, we consider the following minimization problem

$$Y(N) = \inf \left\{ \mathcal{Y}_N(v) : v \in H^{s/2}(\mathbb{R}) \text{ and } \int |v|^2 = s_0, \right\},$$
 (3.2)

where

$$\mathcal{Y}_{N}(v) = \frac{1}{2} \left(\int_{\mathbb{R}} \overline{v} n_{N}(D) v - \frac{1}{s+1} \int_{\mathbb{R}} |v|^{2s+2} \right)$$

with

$$n_N(D) = \mathcal{F}^{-1} n_N(\xi) \mathcal{F}, \quad n_N(\xi) := \frac{2n\left(N^{\frac{s}{2-s}}\xi\right)}{s(s-1)N^{\frac{2s}{2-s}}}$$
 (3.3)

and $n(\xi)$ is defined by (2.2). Let

$$R_N(x) = s_0^{1/2} N^{-\frac{1}{2-s}} S_N\left(\frac{x}{N^{\frac{s}{2-s}}}\right).$$
 (3.4)

Note that

$$\mathcal{Y}_N\left(R_N\right) = s_0^{s+1} N^{-\frac{2+s}{2-s}} \mathcal{I}\left(S_N\right)$$

and

$$\int |R_N|^2 = s_0 N^{-1} \int |S_N|^2 \,.$$

Then, as S_N minimizes (2.3), R_N is a minimizer for (3.2). Moreover R_N satisfies the equation

$$n_N(D)R_N + \theta_N R_N - |R_N|^{2s}R_N = 0,$$
 (3.5)

with some Lagrange multiplier $\theta_N \in \mathbb{R}$.

Let $0 < N < \langle Q, Q \rangle$, where Q is an optimizer of (1.7). We denote by \mathbf{R}_N the set of minimizers of the problem (3.2), which is not empty by Theorem 2.2 and (3.4). Now, we prove that R_N converges to \mathcal{R} , as N tends to 0. Namely, we aim to prove the following:

Theorem 3.2. Let $0 < N < \langle Q, Q \rangle$ and $R_N \in \mathbf{R}_N$. Then, there exist $\tilde{x}, \tilde{\gamma} \in \mathbb{R}$, $\tilde{\gamma} = \tilde{\gamma}(N)$ and $\tilde{x} = \tilde{x}(N)$, such that the relation

$$\lim_{N \to 0} \left\| e^{i\tilde{\gamma}} R_N \left(\cdot + \tilde{x} \right) - \mathcal{R} \right\|_{H^r} = 0, \tag{3.6}$$

for any $r \geq 0$.

We prepare a lemma that is involved in the proof of Theorem 3.2.

Lemma 3.3. Let $0 < \alpha < 1$ and $b \ge 2$. Then, for $\kappa_0 = cb^{-\frac{2}{(2-s)\alpha}}$, with some c > 0, and any $0 \le \kappa \le \kappa_0$,

$$n(\kappa\xi) = \frac{s(s-1)}{2}(\kappa\xi)^2 + O(\kappa^{3(1-\alpha)}), \qquad (3.7)$$

for all $|\xi| \leq \kappa^{-\alpha}$. Moreover,

$$n(\kappa \xi) - b\kappa^{2-s} |\kappa \xi|^s \ge 0, \tag{3.8}$$

holds, for all $|\xi| \ge \kappa^{-\alpha}$.

Proof. By using Taylor's theorem, we have

$$n(\kappa\xi) = \frac{s(s-1)}{2} (\kappa\xi)^2 + \frac{s(s-1)(s-2)}{2} \int_0^{\kappa\xi} (y+1)^{s-3} (\kappa\xi - y)^2 dy, \qquad (3.9)$$

for all $|\kappa\xi| \leq \frac{1}{2}$. Then, if $\kappa \leq \left(\frac{1}{2}\right)^{\frac{1}{1-\alpha}}$ we get (3.7). Next we prove (3.8). If $\kappa \leq \kappa_1 := (2b)^{-\frac{1}{2-s}}$, there exists a constant K > 0 (independent of κ) such that (3.8) is true for all $|\kappa\xi| \geq K$. Note now that $n(\kappa\xi) \geq 0$ for all $\xi \in \mathbb{R}$, $n'(\kappa\xi) < 0$, for $\xi < 0$, and $n'(\kappa\xi) > 0$, for $\xi > 0$. Then, $\min_{|\kappa\xi| \geq \frac{1}{2}} n(\kappa\xi) = c > 0$ and thus, if $K \geq \frac{1}{2}$, for $\kappa_2 = \left(\frac{c}{bK^s}\right)^{\frac{1}{2-s}}$ and all $0 < \kappa \leq \kappa_2$, (3.8) is satisfied on $\frac{1}{2} \leq |\kappa\xi| \leq K$. Suppose now that $\xi \in \mathbb{R}$ is such that $\kappa^{1-\delta} \leq |\kappa\xi| \leq \min\{\frac{1}{2}, \kappa^{1-\frac{2+s}{2s}\delta}\}$, for all $\kappa \leq \left(\frac{1}{2}\right)^{\frac{1}{1-\delta}}$ and some $0 < \delta < 1$. Then, using Taylor's theorem we estimate

$$n(\kappa\xi) - b\lambda^{2-s} |\lambda\xi|^{s}$$

$$= s(s-1) \int_{0}^{\kappa\xi} (y+1)^{s-2} (\kappa\xi - y) \, dy - b\kappa^{2-s} |\lambda\xi|^{s}$$

$$\geq \frac{s(s-1)}{2} \left(\min_{y \in [-|\kappa\xi|, |\kappa\xi|]} (y+1)^{s-2} \right) |\kappa\xi|^{2} - b\kappa^{2-s} |\kappa\xi|^{s}$$

$$\geq \kappa^{2-2\delta} \left(\frac{s(s-1)}{2^{3-s}} - b\kappa^{\frac{(2-s)\delta}{2}} \right).$$
(3.10)

Therefore, if $\kappa \leq \kappa_3^{(\delta)} := \min\left\{\left(\frac{1}{2}\right)^{\frac{1}{1-\delta}}, \left(\frac{s(s-1)}{2^{3-s}b}\right)^{\frac{2}{(2-s)\delta}}\right\}$, (3.8) is satisfied on $\kappa^{1-\delta} \leq |\kappa\xi| \leq \kappa^{1-\frac{2+s}{2s}\delta}$. Let m be such that $\left(\frac{2+s}{2s}\right)^m \alpha < 1 \leq \left(\frac{2+s}{2s}\right)^{m+1} \alpha$. For $0 \leq k \leq m$, we

define $\alpha_k := \left(\frac{2+s}{2s}\right)^k \alpha$. We decompose $\left[\kappa^{1-\alpha}, \frac{1}{2}\right] = \bigcup_{k=0}^{m-1} \left[\kappa^{1-\alpha_k}, \kappa^{1-\alpha_{k+1}}\right] \cup \left[\kappa^{1-\alpha_m}, \frac{1}{2}\right]$. Using (3.10) with $\delta = \alpha_k$, $0 \le k \le m$, we see that (3.8) is true on $\kappa^{1-\alpha} \le |\kappa\xi| \le \frac{1}{2}$, if $\kappa \le \kappa_3 := \kappa_3^{(\alpha)}$. Hence, putting $\kappa_0 = \min\{\kappa_1, \kappa_2, \kappa_3\}$, we conclude that (3.8) is satisfied for all $|\xi| \ge \kappa^{-\alpha}$, with $0 < \kappa \le \kappa_0$.

Proof of Theorem 3.2. To somehow simplify the notation, we introduce $\kappa = N^{\frac{s}{2-s}}$ and study the limit of

$$R^{(\kappa)} = R_{\kappa^{\frac{2-s}{s}}},$$

as $\kappa \to 0$. We denote $Y_{\kappa} = Y(N)$ and $\mathcal{Y}^{(\kappa)}(v) = \mathcal{Y}_{N}(v)$. Let $\sigma_{\kappa} \in L^{\infty}$ be such that $\sigma_{\kappa}(\xi) = s_{0}^{1/2} \left(\int_{|\zeta| \le \kappa^{-\alpha}} \left| \hat{\mathcal{R}}(\zeta) \right|^{2} d\zeta \right)^{-1/2}$, for $|\xi| \le \kappa^{-\alpha}$, and $\sigma_{\kappa}(\xi) = 0$, for $|\xi| \ge \kappa^{-\alpha}$. We put $\mathcal{R}_{\kappa} := \mathcal{F}^{-1} \left(\sigma_{\kappa} \hat{\mathcal{R}} \right)$. Note that $\int \left| \hat{\mathcal{R}} \right|^{2} = s_{0}$. Using (3.7), we have

$$Y_{\kappa} \leq \mathcal{Y}^{(\kappa)}\left(\mathcal{R}\right) = \kappa^{-2} \int_{\mathbb{R}} \frac{n(\kappa\xi)}{s(s-1)} \sigma_{\kappa}\left(\xi\right) \left|\hat{\mathcal{R}}\left(\xi\right)\right|^{2} d\xi - \frac{1}{2s+2} \int |\mathcal{R}_{\kappa}|^{2s+2}$$

$$\leq \frac{1}{2} \int_{\mathbb{R}} \xi^{2} \sigma_{\kappa}\left(\xi\right) \left|\hat{\mathcal{R}}\left(\xi\right)\right|^{2} d\xi - \frac{1}{2s+2} \int |\mathcal{R}_{\kappa}|^{2s+2} + O\left(\kappa^{1-3\alpha}\right).$$

$$(3.11)$$

Then, as

$$\frac{1}{2} \int_{\mathbb{R}} \xi^{2} \left(1 - \sigma_{\kappa} \left(\xi \right) \right) \left| \hat{\mathcal{R}} \left(\xi \right) \right|^{2} d\xi + \frac{1}{2s+2} \int \left(\left| \mathcal{R} \right|^{2s+2} - \left| \mathcal{R}_{\kappa} \right|^{2s+2} \right) = O\left(\kappa \right),$$

we deduce

$$Y_{\kappa} \le I_0 + O\left(\kappa^{1-3\alpha}\right). \tag{3.12}$$

Let $\chi_{\kappa} \in L^{\infty}$ be such that $\chi_{\kappa}(\xi) = 1$, for $|\xi| \leq \kappa^{-1/3 + \delta/3}$, $0 < \delta < 1$, and $\chi_{\kappa}(\xi) = 0$, for $|\xi| \geq \kappa^{-1/3 + \delta/3}$. We define

$$w_{\kappa} := \mathcal{F}^{-1} \chi_{\kappa} \mathcal{F} R^{(\kappa)} \text{ and } r_{\kappa} := R^{(\kappa)} - w_{\kappa}.$$
 (3.13)

Let us prove that in fact $Y_{\kappa} \to I_0$, as $\kappa \to 0$. Note that

$$Y_{\kappa} = \mathcal{Y}^{(\kappa)} \left(R^{(\kappa)} \right) = \mathcal{Y}^{(\kappa)} \left(w_{\kappa} + r_{\kappa} \right). \tag{3.14}$$

Using the elementary relation $(a+b)^p \le a^p + b^p + C(a^{p-1}b + ab^{p-1})$, $a, b \ge 0$, $p \ge 1$, by Young's inequality we have

$$|w_{\kappa} + r_{\kappa}|^{2s+2} \le (1 + C\varepsilon) |w_{\kappa}|^{2s+2} + (1 + K(\varepsilon)) |r_{\kappa}|^{2s+2}, \ \varepsilon > 0,$$

with $K(\varepsilon) := C\varepsilon^{-\left(\frac{1}{2s+1}+2s+1\right)}$. Using the last inequality in (3.14) we get

$$Y_{\kappa} \ge Y_1(\kappa) + Y_2(\kappa),$$
 (3.15)

where

$$Y_{1}\left(\kappa\right):=\int_{\mathbb{R}}\frac{n\left(\kappa\xi\right)}{s\left(s-1\right)\kappa^{2}}\left|\hat{w}_{\kappa}\left(\xi\right)\right|^{2}d\xi-\frac{1+C\varepsilon}{2s+2}\int_{\mathbb{R}}\left|w_{\kappa}\right|^{2s+2}$$

and

$$Y_{2}\left(\kappa\right):=\int\limits_{\mathbb{D}}\frac{n\left(\kappa\xi\right)}{s\left(s-1\right)\kappa^{2}}\left|\hat{r}_{\kappa}\left(\xi\right)\right|^{2}d\xi-\frac{1+K\left(\varepsilon\right)}{2s+2}\int\limits_{\mathbb{D}}\left|r_{\kappa}\right|^{2s+2}.$$

By using (3.7) with $\alpha = \frac{1-\delta}{3}$ we have

$$Y_{1}\left(\kappa\right) = \frac{1}{2} \int_{\mathbb{R}} \overline{w_{\kappa}} \left|D\right|^{2} w_{\kappa} - \frac{1 + C\varepsilon}{2s + 2} \int_{\mathbb{R}} \left|w_{\kappa}\right|^{2s + 2} + O\left(\kappa^{\delta}\right) \int_{\mathbb{R}} \left|\hat{w}_{\kappa}\left(\xi\right)\right|^{2} d\xi,$$

as $\kappa \to 0$. Observe that

$$\int |\hat{w}_{\kappa}(\xi)|^{2} d\xi + \int |\hat{r}_{\kappa}(\xi)|^{2} d\xi = \int |R^{(\kappa)}|^{2} = s_{0}.$$
 (3.16)

Hence, we show that

$$Y_{1}(\kappa) = \frac{1}{2} \int_{\mathbb{R}} \overline{w_{\kappa}} |D|^{2} w_{\kappa} - \frac{1 + C\varepsilon}{2s + 2} \int_{\mathbb{R}} |w_{\kappa}|^{2s + 2} + O\left(\kappa^{\delta}\right), \tag{3.17}$$

as $\kappa \to 0$. On the other hand, we claim that there is $\kappa_1(\varepsilon) > 0$ such that

$$Y_2\left(\kappa\right) \ge 0,\tag{3.18}$$

for any $0 < \kappa \le \kappa_1(\varepsilon)$. Indeed, using (1.7) and (3.16), we estimate

$$\int_{\mathbb{R}} |r_{\kappa}|^{2s+2} \le C_s \int_{\mathbb{R}} |\xi|^s |\hat{r}_{\kappa}(\xi)|^2 d\xi. \tag{3.19}$$

Then,

$$Y_{2}(\kappa) \geq \frac{1}{s(s-1)\kappa^{2}} \int_{\mathbb{R}} \left(n(\kappa\xi) - \frac{C_{s}s(s-1)(1+K(\varepsilon))}{2s+2} \kappa^{2-s} |\kappa\xi|^{s} \right) |\hat{r}_{\kappa}(\xi)|^{2} d\xi.$$

$$(3.20)$$

Therefore, since $\hat{r}_{\kappa}(\xi) = 0$ for $|\xi| \leq \kappa^{-1/3 + \delta/3}$, using (3.8) of Lemma 3.3 with $\alpha = \frac{1-\delta}{3}$ and $b = \frac{C_s s (s-1) (1+K(\varepsilon))}{2s+2}$, we get (3.18). Since by Lemma 3.3 $\kappa = O\left(b^{-\frac{2}{(2-s)\alpha}}\right)$, we note that

$$\varepsilon = O\left(\kappa^{\frac{(2-s)\alpha}{2\left(\frac{1}{2s+1} + 2s+1\right)}}\right). \tag{3.21}$$

Using (3.17) and (3.18) in (3.15) we see

$$Y_{\kappa} \geq Y_{1}(\kappa) + Y_{2}(\kappa) \geq Y_{1}(\kappa) = \frac{1}{2} \int_{\mathbb{R}} \overline{w_{\kappa}} |D|^{2} w_{\kappa} - \frac{1 + C\varepsilon}{2s + 2} \int_{\mathbb{R}} |w_{\kappa}|^{2s + 2} + O\left(\kappa^{\delta}\right),$$
(3.22)

as $\kappa \to 0$. Thus, taking into account (3.12), we get

$$\frac{1}{2} \int_{\mathbb{R}} \overline{w_{\kappa}} |D|^2 w_{\kappa} - \frac{1 + C\varepsilon}{2s + 2} \int_{\mathbb{R}} |w_{\kappa}|^{2s + 2} \le C,$$

for any $0 < \kappa \le \kappa_2(\varepsilon)$, and some $\kappa_2(\varepsilon) > 0$. Then, from (1.7) and (3.16) we get

$$\int_{\mathbb{R}} \left(\frac{1}{2} \left| \xi \right|^2 - \frac{C_s \left(1 + C\varepsilon \right)}{2s + 2} \left| \xi \right|^s \right) \left| \hat{w}_{\kappa} \left(\xi \right) \right|^2 d\xi \le C.$$

Therefore, as for some c > 0, $\frac{|\xi|^2}{2} - \frac{C_s(1+C\varepsilon)}{2s+2} |\xi|^s \ge \frac{|\xi|^2}{4}$, for all $|\xi| \ge c$, by (3.16) we obtain the estimate

$$\|w_{\kappa}\|_{H^1} \le C,\tag{3.23}$$

uniformly on $0 < \kappa \le \kappa_2(\varepsilon)$. Moreover, using (3.8) we get

$$Y_{2}(\kappa) \geq \frac{1}{s(s-1)\kappa^{2}} \int_{\mathbb{R}} \left(n\left(\kappa\xi\right) - \frac{C_{s}s\left(s-1\right)\left(1+K\left(\varepsilon\right)\right)}{2s+2} \kappa^{2-s} \left|\kappa\xi\right|^{s} \right) \left|\hat{r}_{\kappa}\left(\xi\right)\right|^{2} d\xi$$

$$\geq \int_{\mathbb{R}} \left|\xi\right|^{s} \left|\hat{r}_{\kappa}\left(\xi\right)\right|^{2} d\xi.$$
(3.24)

Then, since the left-hand side of the last relation is bounded by I_0 , due to (3.12) and (3.15), we deduce

$$||r_{\kappa}||_{H^{s/2}}^2 \le C,$$

for all $\kappa > 0$ sufficiently small. In particular, we have

$$\kappa^{-\frac{(1-\delta)s}{3}} \int_{\mathbb{R}} |\hat{r}_{\kappa}(\xi)|^{2} d\xi = \kappa^{-\frac{(1-\delta)s}{3}} \int_{|\xi| \ge \kappa^{-1/3 + \delta/3}} |\hat{r}_{\kappa}(\xi)|^{2} d\xi$$

$$\leq \int_{|\xi| \ge \kappa^{-1/3 + \delta/3}} |\xi|^{s} |\hat{r}_{\kappa}(\xi)|^{2} d\xi \leq C,$$

which implies

$$\int_{\mathbb{R}} \left| \hat{r}_{\kappa} \left(\xi \right) \right|^{2} d\xi \le C \kappa^{\frac{(1-\delta)s}{3}}.$$
(3.25)

Then, it follows from (3.16) that

$$\int |w_{\kappa}|^2 \to s_0, \text{ as } \kappa \to 0.$$
 (3.26)

Then, returning to (3.22) and using (3.21) we get

$$Y_{\kappa} \ge Y_{1}(\kappa) + Y_{2}(\kappa) \ge Y_{1}(\kappa) = \mathcal{I}_{0}(w_{\kappa}) + o(\kappa^{\delta_{1}}),$$

for some $0 < \delta_1 \le \delta$. Therefore, using (3.12), (3.23) and (3.26), we obtain

$$I_{0} + o\left(\kappa^{\delta_{1}}\right) \geq Y_{\kappa} \geq Y_{1}\left(\kappa\right) + Y_{2}\left(\kappa\right) \geq Y_{1}\left(\kappa\right)$$
$$= \mathcal{I}_{0}\left(w_{\kappa}\right) + o\left(\kappa^{\delta_{1}}\right) \geq I_{0} + o\left(\kappa^{\delta_{1}}\right). \tag{3.27}$$

In particular, this means

$$\lim_{\kappa \to 0} \mathcal{I}_0(w_{\kappa}) = I_0 \text{ and } \lim_{\kappa \to 0} Y_2(\kappa) = 0.$$
 (3.28)

Then, from (3.24) and (3.25) we deduce that

$$\lim_{\kappa \to 0} \|r_{\kappa}\|_{H^{s/2}}^{2} = \lim_{\kappa \to 0} \left(\int_{|\xi| \ge \kappa^{-1/3 + \delta/3}} |\hat{r}_{\kappa}(\xi)|^{2} d\xi + \int_{\mathbb{R}} |\xi|^{s} |\hat{r}_{\kappa}(\xi)|^{2} d\xi \right) = 0. \quad (3.29)$$

Now, we have all the estimates that we need to prove Theorem 3.2. We argue as follows. Let $\{N_n\}_{n=1}^{\infty}$ be such that $0 < N_n < \langle Q, Q \rangle$ and $N_n \to 0$, as $n \to \infty$. Then, $\kappa_n = N_n^{\frac{s}{2-s}}$ also tends to 0. We consider the sequence $\{w_n\}_{n=1}^{\infty}$, where $w_n := w_{\kappa_n}$. Taking into account (3.26) and (3.28), from Proposition 3.1 it follows that there exist a subsequence of $\{w_n\}_{n=1}^{\infty}$, that we still denote by $\{w_n\}_{n=1}^{\infty}$ and $x_n, \gamma_n \in \mathbb{R}$, such that

$$\lim_{n \to \infty} \left\| e^{i\gamma_n} w_n \left(\cdot + x_n \right) - \mathcal{R} \right\|_{H^1} = 0.$$

Furthermore, using (3.13) and (3.29) we deduce that

$$\lim_{n \to \infty} \left\| e^{i\gamma_n} R^{(\kappa_n)} \left(\cdot + x_n \right) - \mathcal{R} \right\|_{H^{s/2}} = 0. \tag{3.30}$$

To complete the proof, we need to show that $e^{i\gamma_n}R^{(\kappa_n)}(\cdot + x_n)$ converges to \mathcal{R} in H^r , for all $r \geq 0$. Recall that for any $0 < \kappa < \langle Q, Q \rangle^{\frac{2-s}{s}}$, $R^{(\kappa)}$ is a minimizer of (3.2). Then, $R^{(\kappa)}$ satisfies equation (3.5), that is

$$n^{(\kappa)}(D) R^{(\kappa_n)} + \theta^{(\kappa)} R^{(\kappa_n)} - \left| R^{(\kappa_n)} \right|^{2s} R^{(\kappa_n)} = 0, \tag{3.31}$$

where

$$n^{(\kappa)}(D) := n_{\kappa^{\frac{2-s}{s}}}(D), \qquad (3.32)$$

for some $\theta^{(\kappa)} = \theta_{\kappa^{\frac{2-s}{s}}} \in \mathbb{R}$. Since $R^{(\kappa_n)}$ converges to \mathcal{R} , in $H^{s/2}$, as $n \to \infty$, $\|R^{(\kappa_n)}\|_{H^{s/2}} \leq C$, uniformly for $n \in \mathbb{N}$. In particular, from Sobolev theorem we get $\int |R^{(\kappa_n)}|^{2s+2} \leq C$, and then, using the bound (3.12) we see that

$$\int_{\mathbb{D}} n^{(\kappa_n)}(\xi) \left| \hat{R}^{(\kappa_n)}(\xi) \right|^2 d\xi \le C.$$

Hence, from (3.31) we get

$$\left|\theta^{(\kappa_n)}\right| \le \int \left|R^{(\kappa_n)}\right|^{2s+2} + \int_{\mathbb{R}} n^{(\kappa_n)}(\xi) \left|\hat{R}^{(\kappa_n)}(\xi)\right|^2 d\xi \le C, \tag{3.33}$$

uniformly for $n \in \mathbb{N}$. From (3.31) and (3.33), via the Sobolev theorem, we also deduce

$$\int_{\mathbb{D}} \left(n^{(\kappa_n)}(\xi) \right)^2 \left| \hat{R}^{(\kappa_n)}(\xi) \right|^2 d\xi \le C \left(\int \left| R^{(\kappa_n)} \right|^2 + \int \left| R^{(\kappa_n)} \right|^{4s+2} \right) \le C.$$
 (3.34)

Then, it follows from Lemma 3.3 that $\|R^{(\kappa_n)}\|_{H^s} \leq C$. Applying the operator D to equation (3.31) and arguing similarly to the proof of (3.34), we get $\|R^{(\kappa_n)}\|_{H^{s+1}} \leq C$. By induction on $r \in \mathbb{N}$, we see that, in fact, $R^{(\kappa_n)}$ is uniformly bounded in H^r , for all $r \in \mathbb{N}$ (and hence all $r \geq 0$). Therefore, as (3.30) is true, $e^{i\gamma_n}R^{(\kappa_n)}$ ($\cdot + x_n$) converges to \mathcal{R} in H^r , $r \geq 0$, as $n \to \infty$. Recalling that $R^{(\kappa_n)} = R_{\frac{2-s}{\kappa_n}}$ and $\kappa_n = N_n^{\frac{s}{2-s}}$ we deduce that for any $\{N_n\}_{n=1}^{\infty}$ such that $0 < N_n < \langle Q, Q \rangle$ and $N_n \to 0$, as $n \to \infty$, the estimate

$$\lim_{n \to \infty} \left\| e^{i\gamma_n} R_{N_n} \left(\cdot + x_n \right) - \mathcal{R} \right\|_{H^r} = 0,$$

holds for any $r \geq 0$. Since the sequence $\{N_n\}_{n=1}^{\infty}$ in the last relation is arbitrary, we attain (3.6).

Theorem 3.2 allows to calculate the limit as the mass $0 < N < \langle Q, Q \rangle$ tends to 0 for Lagrange multiplier θ_N in the equation (3.5) for R_N . We have the following.

Lemma 3.4. Let $0 < N < \langle Q, Q \rangle$. The relation

$$|\theta_N - \lambda(s)| = o(1), \text{ as } N \to 0, \tag{3.35}$$

is true, where $\lambda(s) = \left(\rho_0^s \frac{s(s-1)}{2}\right)^{-\frac{2}{2-s}}$ is the Lagrange multiplier in equation (1.8) for \mathcal{R} .

Proof. Theorem 3.2 implies that there is $R_N(x)$, such that R_N converges to \mathcal{R} , in H^r , $r \geq 0$, as $N \to 0$. Since R_N and \mathcal{R} solve (3.5) and (1.8), respectively, we have

$$|\theta_{N} - \lambda(s)| \mathcal{R} \leq \mathbf{r} + |n_{N}(D)(\mathcal{R} - R_{N})| + ||R_{N}|^{2s} R_{N} - \mathcal{R}^{2s+1}| + |\theta_{N}||\mathcal{R} - R_{N}|,$$

$$(3.36)$$

where

$$\mathbf{r}:=\left|\left(|D|^{2}-n_{N}\left(D\right)\right)\mathcal{R}\right|.$$

As $n_N(\xi) \leq C(1+\xi^2)$ for all $\xi \in \mathbb{R}$,

$$n_N(D) \le C \langle D \rangle^2$$
. (3.37)

By noting that the sequence $\{\kappa_n\}_{n=1}^{\infty}$ in (3.33) is arbitrary, as $\theta^{(\kappa_n)} = \theta_{\frac{2-s}{\kappa_n}}^{\frac{2-s}{s}}$ we have

$$|\theta_N| \le C,\tag{3.38}$$

uniformly for all N > 0 small enough. Then, since R_N converges to \mathcal{R} , using (3.37), (3.38) and Sobolev theorem, we see that the last three terms in the right hand side of (3.36) tend to 0, as $N \to 0$. Now, note that Sobolev theorem implies

$$\mathbf{r}^{2} \leq \int_{|\xi| < \kappa^{-\alpha}} \langle \xi \rangle \left| |\xi|^{2} - n_{N}(\xi) \right| \left| \hat{\mathcal{R}}(\xi) \right|^{2} d\xi + \tilde{\mathbf{r}}, \tag{3.39}$$

with $\kappa = N^{\frac{s}{2-s}}$, $0 < \alpha < 1/3$ and

$$\tilde{\mathbf{r}} := \int_{|\xi| \ge \kappa^{-\alpha}} \langle \xi \rangle \left| |\xi|^2 - n_N(\xi) \right| \left| \hat{\mathcal{R}}(\xi) \right|^2 d\xi.$$

Using (3.37) we have

$$\tilde{\mathbf{r}} \leq C \int_{|\xi| > \kappa^{-\alpha}} \langle \xi \rangle^4 \left| \hat{\mathcal{R}} \left(\xi \right) \right|^2 d\xi \leq C \kappa^{\alpha} \left\| \hat{\mathcal{R}} \right\|_{H^2}^2.$$

Then, using (3.7) to estimate the first term in the right hand side of (3.39), we see that $\mathbf{r} = o(1)$, as $N \to 0$. Hence, from (3.36) we attain (3.35).

Proof of Theorem 1.2. To prove the first part of Theorem 1.2 we note that the minimizers S_N of (2.3) and the minimizers R_N of (3.2) are related by (3.4). Moreover, by Lemma 2.1 we see that S_N is related to $Q_{\beta,N}$ by the equation

$$Q_{\beta,N}(x) = (\tau_{\beta}S_N)(x), \qquad (3.40)$$

with τ_{β} given by (2.1). Then, R_N and $Q_{\beta,N}$ are related by (1.9), and hence, the first part of Theorem 1.2 is consequence of Theorem 3.2. To prove the second part we observe that if R_N satisfies (3.5), S_N solves (2.4) with $\eta = \frac{s(s-1)}{2}\theta_N$. On the other hand, it follows from Lemma 2.1 that the Lagrange multiplier η corresponding to S_N is related to the Lagrange multiplier $\gamma(\beta, N)$ that corresponds to $Q_{\beta,N}$ by the

formula $\gamma\left(\beta,N\right)=\left(\frac{2\beta}{s}\right)^{\frac{s}{s-1}}\left(\eta+s-1\right).$ Then,

$$\theta_N = \frac{2}{s} \left((s-1)^{-1} \left(\frac{2\beta}{s} \right)^{-\frac{s}{s-1}} \gamma(\beta, N) - 1 \right).$$

Therefore, the second part of Theorem 1.2 follows from (3.35).

4. Uniqueness of traveling waves.

We now turn to the proof of Theorem 1.3. In view of relations (3.4) and (3.40), we need to show the unicity of the minimizers $R_N \in \mathbf{R}_N$. We aim to prove the following.

Lemma 4.1. There exists $N_0 > 0$ with the following property: given $0 < N < N_0$ and $R_N, \tilde{R}_N \in \mathbf{R}_N$, there exist $\phi, y \in \mathbb{R}$ such that

$$\tilde{R}_{N}(x) = e^{i\phi} R_{N}(x - y).$$

Before proving Lemma 4.1 we present a lemma that is involved in its proof. Consider some fixed $R_N \in \mathbf{R}_N$ and recall that R_N satisfies equation (3.5). We define the linearized operator $\mathcal{L}_{R_N}: H^{s/2} \to H^{-s/2}$ close to R_N by

$$\mathcal{L}_{R_{N}}f := n_{N}(D) f + \theta_{N}f - (s+1) |R_{N}|^{2s} f - s (|R_{N}|^{2s-2} R_{N}^{2}) \overline{f}, \quad f \in H^{s/2}$$

Recall the notation $(f,g) = \text{Re} \int f\overline{g}$. We now prove the following invertibility result for \mathcal{L}_{R_N} .

Lemma 4.2. There exists $N_0 > 0$, such that for all $0 < N < N_0$ and all $R_N \in \mathbf{R}_N$ the estimate

$$||f||_{H^{s/2}} \le C \left(||\mathcal{L}_{R_N} f||_{H^{-s/2}} + |(f, iR_N)| + |(f, \nabla R_N)| \right) \tag{4.1}$$

is true for all $f \in H^{s/2}$. Moreover, for all $F \in H^{-s/2}$ with $(F, iR_N) = (F, \nabla R_N) = 0$, the problem

$$\begin{cases} \mathcal{L}_{R_N} f = F, & f \in H^{s/2}, \\ (f, iR_N) = (f, \nabla R_N) = 0, \end{cases}$$

has a unique solution $f \in H^{s/2}$, and

$$||f||_{H^{s/2}} \le C ||F||_{H^{-s/2}} \tag{4.2}$$

holds.

Proof. Let $\mathcal{L}: H^1 \to H^{-1}$ be the linearized operator for the equation (1.8) around $\mathcal{R}:$

$$\mathcal{L}f := |D|^2 f + \lambda(s) f - (s+1) \mathcal{R}^{2s} f - s \mathcal{R}^{2s} \overline{f}, \quad f \in H^1.$$

We write $f \in H^1$ as f = h + ig, with real h and g. Then,

$$\mathcal{L}f = L_{+}h + iL_{-}g$$

where

$$L_{+}h := |D|^{2} h + \lambda(s) h - (2s+1) \mathcal{R}^{2s} h$$

and

$$L_{-}g := |D|^{2} g + \lambda(s) g - \mathcal{R}^{2s} g.$$

Thus,

$$(\mathcal{L}f, f) = (L_{+}h, h) + (L_{-}g, g),$$
 (4.3)

for real functions $h, g \in H^1$. It is known (see Lemmas 2.1 and 2.2 of [2]) that $\ker L_+ = \operatorname{span}\{\nabla \mathcal{R}\}, \ L_+|_{\{\mathcal{R}\}^{\perp}} \geq 0 \text{ and } L_-|_{\{\mathcal{R}\}^{\perp}} > 0.$ Then, from (4.3) we get

$$(\mathcal{L}f, f) \ge c \|f\|_{H^1}^2$$
,

for all $f \in H^1$ such that $|(f, \mathcal{R})| + |(f, i\mathcal{R})| + |(f, \nabla \mathcal{R})| = 0$. Moreover, using the relation $L_+\mathcal{R} = -2s\left(|D|^2 + \lambda(s)\right)\mathcal{R}$, we see that

$$||f||_{H^1} \le C \left(||\mathcal{L}f||_{H^{-1}} + |(f, i\mathcal{R})| + |(f, \nabla \mathcal{R})| \right), \tag{4.4}$$

for all $f \in H^1$.

Now, in order to prove (4.1), let us compare \mathcal{L}_{R_N} and \mathcal{L} . Theorem 3.2 shows that there exist $x(N), \gamma(N) \in \mathbb{R}$ such that $\tilde{R}_N := e^{i\gamma(N)}R_N(\cdot + x(N)) \to \mathcal{R}$, in $H^r, r \geq 0$, as $N \to 0$. Since the Sobolev norms are invariant under translations and phase-shift, to prove (4.1) we may assume that R_N itself converges to \mathcal{R} , in $H^r, r \geq 0$, as $N \to 0$. We fix such $R_N \in \mathbf{R}_N$ and denote $\mathcal{L}_N := \mathcal{L}_{R_N}$. Let $\eta_N \in L^{\infty}$ be such that $\eta_N(\xi) = 1$, for $|\xi| \leq \kappa^{-\alpha}$, $\kappa = N^{\frac{s}{2-s}}$, $0 < \alpha < 1/3$, and $\eta_N(\xi) = 0$, for $|\xi| \geq \kappa^{-\alpha}$. We decompose $f \in H^{s/2}$ as

$$f = f_1 + r, (4.5)$$

with

$$f_1 := \mathcal{F}^{-1} \eta_N \mathcal{F} f$$
 and $r := \mathcal{F}^{-1} (1 - \eta_N) \mathcal{F} f$. (4.6)

We have

$$\|\mathcal{L}_{N}f\|_{H^{-s/2}}^{2} = \|\mathcal{L}_{N}f_{1}\|_{H^{-s/2}}^{2} + \|\mathcal{L}_{N}r\|_{H^{-s/2}}^{2} + 2\left(\langle D \rangle^{-s}\mathcal{L}_{N}f_{1},\mathcal{L}_{N}r\right) \\ \geq \|\mathcal{L}_{N}f_{1}\|_{H^{-s/2}}^{2} + \|\mathcal{L}_{N}r\|_{H^{-s/2}}^{2} - 2\left|\left(\langle D \rangle^{-s}\mathcal{L}_{N}f_{1},\mathcal{L}_{N}r\right)\right|.$$

$$(4.7)$$

We denote

$$\mathcal{D} = \left(\langle D \rangle^{-s} \, n_N \, (D) \right)^{1/2}.$$

Observe that

$$\left| \left(\langle D \rangle^{-s} \mathcal{L}_{N} f_{1}, \mathcal{L}_{N} r \right) \right| \leq$$

$$\leq \int \left| \mathcal{D} f_{1} \right| \left| \mathcal{D} \left((s+1) \left| R_{N} \right|^{2s} r + s \left(\left| R_{N} \right|^{2s-2} R_{N}^{2} \right) \overline{r} \right) \right|$$

$$+ \int \left| \mathcal{D} r \right| \left| \mathcal{D} \left((s+1) \left| R_{N} \right|^{2s} f_{1} + s \left(\left| R_{N} \right|^{2s-2} R_{N}^{2} \right) \overline{f}_{1} \right) \right|$$

$$+ C \int \left(1 + \left| \theta_{N} \right| + \left| R_{N} \right|^{4s} \right) \left| f_{1} \right| \left| r \right|$$

$$(4.8)$$

and

$$\|\mathcal{L}_{N}r\|_{H^{-s/2}}^{2} \ge \|n_{N}(D)r\|_{H^{-s/2}}^{2} -2\int |\mathcal{D}r| \left| \mathcal{D}\left(\theta_{N}r - (s+1)|R_{N}|^{2s}r - s\left(|R_{N}|^{2s-2}R_{N}^{2}\right)\overline{r}\right) \right|.$$
(4.9)

Also, we have

$$\|\mathcal{L}_N f_1\|_{H^{-1}}^2 \ge \frac{1}{2} \|\mathcal{L} f_1\|_{H^{-1}}^2 - \|(\mathcal{L}_N - \mathcal{L}) f_1\|_{H^{-1}}^2.$$
(4.10)

Using (4.8), (4.9) and (4.10) in (4.7) we get

$$\|\mathcal{L}_{N}f\|_{H^{-s/2}}^{2} \ge \frac{1}{2} \|\mathcal{L}f_{1}\|_{H^{-1}}^{2} + \|n_{N}(D)r\|_{H^{-s/2}}^{2} - \mathbf{r}_{1}(f) - \mathbf{r}_{2}(f). \tag{4.11}$$

where

$$\mathbf{r}_{1}(f) := \|(\mathcal{L}_{N} - \mathcal{L}) f_{1}\|_{H^{-1}}^{2},$$

and

$$\mathbf{r}_{2}(f) := \mathbf{r}_{21}(f) + \mathbf{r}_{22}(f) + \mathbf{r}_{23}(f) + \mathbf{r}_{24}(f),$$

with

$$\mathbf{r}_{21}\left(f\right) := 2\int \left|\mathcal{D}f_{1}\right| \left|\mathcal{D}\left(\left(s+1\right)\left|R_{N}\right|^{2s} r + s\left(\left|R_{N}\right|^{2s-2} R_{N}^{2}\right) \overline{r}\right)\right|,$$

$$\mathbf{r}_{22}\left(f\right) := 2\int \left|\mathcal{D}r\right| \left|\mathcal{D}\left(\left(s+1\right)\left|R_{N}\right|^{2s} f_{1} + s\left(\left|R_{N}\right|^{2s-2} R_{N}^{2}\right) \overline{f}_{1}\right)\right|$$

$$\mathbf{r}_{23}\left(f\right) := 2\int \left|\mathcal{D}r\right| \left|\mathcal{D}\left(\theta_{N}r - \left(s+1\right)\left|R_{N}\right|^{2s} r - s\left(\left|R_{N}\right|^{2s-2} R_{N}^{2}\right) \overline{r}\right)\right|.$$

and

$$\mathbf{r}_{24}(f) := C \int \left(1 + |\theta_N| + |R_N|^{4s}\right) |f_1| |r|,$$

It follows from (3.8) that

$$||n_N(D)r||_{H^{-s/2}}^2 \ge c ||r||_{H^{s/2}}^2.$$
 (4.12)

Moreover, from (4.4) by (4.5) we obtain

$$\frac{1}{2} \|\mathcal{L}f_1\|_{H^{-1}}^2 \ge c_1 \|f_1\|_{H^1}^2 - \left(\left| (f, i\mathcal{R}) \right|^2 + \left| (f, \nabla \mathcal{R}) \right|^2 + \left| (r, i\mathcal{R}) \right|^2 + \left| (r, \nabla \mathcal{R}) \right|^2 \right),$$

for some $c_1 > 0$. Then, using (4.12) and $||f_1||_{H^1}^2 \ge c ||f_1||_{H^{s/2}}^2$ (s < 2), from (4.11) we deduce

Let us prove that there exists $N_0 > 0$, such that for any $0 < N < N_0$

$$\mathbf{r}_{1}(f) + \mathbf{r}_{2}(f) + \mathbf{r}_{3}(f) \le \frac{c_{2}}{2} \|f\|_{H^{s/2}}^{2},$$
 (4.14)

for all $f \in H^1$, with $c_2 > 0$ given by (4.13). By the definition (4.6) of r we have

$$||r||_{H^p}^2 = \int_{\mathbb{R}} \langle \xi \rangle^{2p} |\hat{r}(\xi)|^2 d\xi \le C \kappa^{(s-2p)\alpha} ||f||_{H^{s/2}}^2, \text{ for } p < s/2.$$

Then,

$$\mathbf{r}_{3}\left(f\right) \le C\kappa^{s\alpha} \left\|f\right\|_{H^{s/2}}^{2}.\tag{4.16}$$

As R_N converges to \mathcal{R} , in H^r , $r \geq 0$, as $N \to 0$, there exists $N_0 > 0$, such that

$$||R_N||_{H^r} \le C,$$
 (4.17)

uniformly on $0 < N < N_0$. Then, via Sobolev theorem, using (3.37) we estimate $\mathbf{r}_{21}(f)$ as

$$\mathbf{r}_{21}(f) \le C \|r\|_{H^{1-s/2}} \|f_1\|_{H^{1-s/2}}.$$

Thus, taking into account (4.15) with p = 1 - s/2, we see that

Let us consider $\mathbf{r}_1(f)$. Observe that

$$(\mathcal{L}_{N} - \mathcal{L}) f_{1} = \left(n_{N}(D) - |D|^{2}\right) f_{1} + (\theta_{N} - \lambda(s)) f_{1} - (s+1) \left(|R_{N}|^{2s} - \mathcal{R}^{2s}\right) f_{1} - s \left(|R_{N}|^{2s-2} R_{N}^{2} - \mathcal{R}^{2s}\right) \overline{f}_{1}.$$

Then, as R_N converges to \mathcal{R} , by the definition (4.6) of f_1 , (3.7) and (3.35), as $\kappa = N^{\frac{s}{2-s}}$ we obtain

$$\mathbf{r}_{1}(f) = o(1) \|f\|_{H^{s/2}}^{2}, \text{ as } N \to 0.$$
 (4.19)

Using (4.16), (4.18) and (4.19), we attain (4.14). Introducing (4.14) into (4.13) we get

$$||f||_{H^{s/2}} \le C\left(||\mathcal{L}_N f||_{H^{-s/2}} + |(f, i\mathcal{R})| + |(f, \nabla \mathcal{R})|\right). \tag{4.20}$$

Since R_N converges to \mathcal{R} ,

$$|(f, i(\mathcal{R} - R_N))| + |(f, \nabla(\mathcal{R} - R_N))| \le o(1) ||f||_{H^{s/2}},$$

as $N \to 0$. Hence, $|(f, i\mathcal{R})| + |(f, \nabla \mathcal{R})|$ in (4.20) may be replaced by $|(f, i\mathcal{R}_N)| + |(f, \nabla \mathcal{R}_N)|$. Therefore, we arrive to (4.1). Now, note that (4.1) implies $\ker \mathcal{L}_N = \operatorname{span}\{i\mathcal{R}_N, \nabla \mathcal{R}_N\}$. Then, the second statement of Lemma 4.2 follows from Fredholm alternative applied to the operator $(n_N(D) + \theta_N)^{-1} \mathcal{L}_{\mathcal{R}_N}$.

Proof of Lemma 4.1. Without loss of generality we suppose that R_N and \tilde{R}_N tend to \mathcal{R} , as $N \to 0$. For any $\gamma, y \in \mathbb{R}$ we define

$$\varepsilon_N(x,\gamma,y) := \tilde{R}_N(x) - e^{i\gamma}R_N(x-y)$$

and

These functions are smooth with respect to γ and y. Let us denote by $\mathcal{J}_N(\gamma, y)$ the Jacobian matrix of f_N and g_N at (γ, y) . As R_N converges to \mathcal{R} , in H^r , $r \geq 0$, as $N \to 0$, there is $N_0 > 0$, such that for all $0 < N < N_0$,

$$\left|\det \mathcal{J}_{N}\left(\gamma,y\right)\right| \geq \frac{1}{2} \left\|\mathcal{R}\right\|_{L^{2}}^{2} \left\|\nabla \mathcal{R}\right\|_{L^{2}}^{2},$$

for (γ, y) in some neighborhood of (0, 0) (dependent only on N_0). Then, as $f_N(0, 0)$ and $g_N(0, 0)$ tend to 0, as $N \to 0$, we conclude that there are $\gamma(N), y(N) \in \mathbb{R}$ such that

$$f_N(\gamma(N), y(N)) = g_N(\gamma(N), y(N)) = 0.$$
 (4.21)

Since R_N and \tilde{R}_N satisfy equation (3.31) and R_N converges to \mathcal{R} , we have

5. Spatial asymptotics of travelling waves.

This Section is devoted to the proof of Theorem 1.4. For this purpose we use relations (2.1) and (3.4) and consider the function R_N which satisfies the equation (3.5). Taking the Fourier transform in the both sides of (3.5) we have

$$n_{N}\left(\xi\right)\hat{R}_{N}\left(\xi\right) + \theta_{N}\hat{R}_{N}\left(\xi\right) = \left(\mathcal{F}\left(\left|R_{N}\right|^{2s}R_{N}\right)\right)\left(\xi\right),$$

where we recall that

$$n_{N}(\xi) = \frac{2n\left(N^{\frac{s}{2-s}}\xi\right)}{s(s-1)N^{\frac{2s}{2-s}}} = \frac{2\left(\left|N^{\frac{s}{2-s}}\xi+1\right|^{s} - sN^{\frac{s}{2-s}}\xi - 1\right)}{s(s-1)N^{\frac{2s}{2-s}}}.$$

(Here we used formulae (3.3) and (2.2)). Then

$$R_N = m_N * \left(\left| R_N \right|^{2s} R_N \right) \tag{5.1}$$

where

$$m_N(x) := \left(\mathcal{F}^{-1}\left(\frac{1}{n_N(\cdot) + \theta_N}\right)\right)(x).$$

We begin by studying the asymptotics of the function $m_N(x)$. Recall that

$$C_1 = \sqrt{\frac{\pi}{2\lambda(s)}}$$
 and $C_2 = \frac{\left(si^{s+1} + (-i)^{s+1}\right)e^{-i\frac{x}{\kappa}}}{2\sqrt{2\pi}(s-1)}\Gamma(s)$.

 $(\Gamma(s))$ denotes the Gamma function.) We prove the following.

Lemma 5.1. The following expansion is true

$$m_{N}(x) = C_{1}e^{-\sqrt{\lambda(s)}|x|} + C_{2}\frac{N^{\frac{s(2+s)}{2-s}}}{|x|^{s+1}} + o_{N}(1)e^{-\sqrt{\lambda(s)}|x|} + \left(o_{N}(1) + o_{|x|}(1)\right)\frac{N^{\frac{s(2+s)}{2-s}}}{|x|^{s+1}},$$
(5.2)

for $|x| \to \infty$ and $N \to 0$, where $o_N(1) \to 0$, as $N \to 0$, and $o_{|x|}(1) \to 0$, as $|x| \to \infty$.

Before proving Lemma 5.1, we prepare a result that is involved in its proof. Let us consider the functions

$$f_1^{\pm}(y) = (y+1)^s - sy - 1 + \frac{s(s-1)}{2} N^{\frac{2s}{2-s}} \theta_N$$
 (5.3)

on $G_1^{\pm} = \{ y \in \mathbb{C} : \operatorname{Re} y > -1 \text{ and } \pm \operatorname{Im} y > 0 \}$, with the brunch of $(y+1)^s$ selected in such way that $(x+1)^s = (x+1)^s$, for x > -1. Also, let

$$f_2^{\pm}(y) = (y-1)^s + sy - 1 + N^{\frac{2s}{2-s}}\theta_N$$
 (5.4)

on $G_2^{\pm} = \{ y \in \mathbb{C} : \operatorname{Re} y > 1 \text{ and } \pm \operatorname{Im} y > 0 \}$, where $(x-1)^s = (x-1)^s$, for x > 1. We have the following.

Lemma 5.2. i) There is $N_0 > 0$, such that for any $0 \le N \le N_0$, the function $f_1^{\pm}(y)$ has only one root $y^{\pm} = y^{\pm}(N)$ in the region G_1^{\pm} . This root satisfies the estimate

$$\left| y^{\pm} \left(N \right) \right| = O\left(N^{\frac{s}{2-s}} \right), \tag{5.5}$$

as N tends to 0.

ii) On the other hand, the function $f_2^{\pm}(y)$ has no roots in the region G_2^{\pm} .

Proof. Let us consider the case of f_1^+ . We translate $y \to y-1$ and study the zeros of the function $\tilde{f}_1^+(y)=y^s-sy+s-1+\kappa^2\theta^{(\kappa)}$ in $\tilde{G}_1^+=\{y\in\mathbb{C}: \operatorname{Re} y\geq 0 \text{ and } \operatorname{Im} y\geq 0\}$. We write $y=|y|\,e^{i\phi}$, for $0\leq\phi\leq\frac{\pi}{2}$. Then, we need to solve the following equation

$$\tilde{f}_{1}^{+}(y) = |y|^{s} e^{is\phi} - s |y| e^{i\phi} + s - 1 + N^{\frac{2s}{2-s}} \theta_{N} = f_{11}^{+}(|y|, \phi) + i f_{12}^{+}(|y|, \phi) = 0,$$

with

$$f_{11}^{+}(|y|,\phi) = |y|^{s}\cos(s\phi) - s|y|\cos\phi + s - 1 + N^{\frac{2s}{2-s}}\theta_{N}$$

and

$$f_{12}^{+}(|y|,\phi) = |y|^{s} \sin(s\phi) - s|y| \sin\phi.$$

Equivalently, we get the equations

$$f_{11}^{+}(|y|,\phi) = 0$$
 (5.6)

and

$$f_{12}^{+}(|y|,\phi) = 0.$$
 (5.7)

From (5.7) we see that for $0 < \phi \le \frac{\pi}{2}$

$$|y|^{s-1} = s \frac{\sin \phi}{\sin(s\phi)}. (5.8)$$

The right-hand side is increasing on $0 \le \phi \le \frac{\pi}{2}$ and it is equal to 1 for $\phi = 0$. Therefore, there is no roots for $f_1^+(y)$ if |y| < 1. Let $r(\phi) = \left(s \frac{\sin \phi}{\sin(s\phi)}\right)^{\frac{1}{s-1}}$. Then,

we need to solve $f_{11}^+\left(r\left(\phi\right),\phi\right)=0$ on $0\leq\phi\leq\frac{\pi}{2}$. Note that for $0<\phi\leq\frac{\pi}{2}$

$$\frac{d}{d\phi}f_{11}^{+}(r(\phi),\phi) = s\left(r^{s-1}(\phi)\cos(s\phi) - \cos\phi\right) \frac{dr(\phi)}{d\phi}
-sr\left(r^{s-1}(\phi)\sin(s\phi) - \sin\phi\right)
= \frac{s}{\sin(s\phi)}\left(s\sin\phi\cos(s\phi) - \sin(s\phi)\cos\phi\right) \frac{dr(\phi)}{d\phi}
-s\left(s-1\right)r(\phi)\sin\phi < 0.$$
(5.9)

Moreover, $f_{11}^+\left(r\left(0\right),0\right)=N^{\frac{2s}{2-s}}\theta_N$. Then, using (3.35), we see that $f_{11}^+\left(r\left(0\right),0\right)>0$ for N>0 small enough. Since $r\left(\phi\right)$ is increasing on $0\leq\phi\leq\frac{\pi}{2}$, from (5.9) we get

$$\frac{d}{d\phi} f_{11}^{+} (r(\phi), \phi)$$

$$= \frac{s}{\sin(s\phi)} (s \sin \phi \cos(s\phi) - \sin(s\phi) \cos \phi) \frac{dr(\phi)}{d\phi}$$

$$-s(s-1) (r(\phi)-1) \sin \phi - s(s-1) \sin \phi < -s(s-1) \sin \phi.$$

Integrating the last inequality we see that

$$f_{11}^{+}\left(r\left(\phi\right),\phi\right) < N^{\frac{2s}{2-s}}\theta_{N} - s\left(s-1\right)\left(1-\cos\phi\right).$$

Thus, there is $0 < \phi_0 < \frac{\pi}{2}$, such that $f_{11}^+\left(r\left(\phi_0\right),\phi_0\right) < 0$, for all N > 0 small enough. Hence, we conclude that there is $N_0 > 0$, such that for any $0 \le N \le N_0$, there is $0 < \phi\left(N\right) < \frac{\pi}{2}$ with the property

$$f_{11}^{+}(r(\phi(N)),\phi(N))=0.$$

Therefore we conclude for N>0 sufficiently small, the function $f_1^+(y)$ has only one root $y^+=y^+(N)$. Since $(y+1)^s-sy-1=0$ only for y=0, we show that $y(N)\to 0$, as N tends to 0. Then, using that $(y+1)^s-sy-1=Cy^2+o\left(y^2\right)$, as $y\to 0$, from the equation $f_1^+(y(N))=0$ we get (5.5). To prove the same result for f_1^- , we again translate $y\to y-1$ and study the zeros of the function $\tilde{f}_1^-(y)=y^s-sy+s-1+\kappa^2\theta^{(\kappa)}$ in $\tilde{G}_1^-=\{y\in\mathbb{C}:\operatorname{Re} y\geq 0\text{ and }\operatorname{Im} y\leq 0\}$. We represent $y=|y|\,e^{-i\phi}$, for $0\le\phi\le\frac{\pi}{2}$. Then,

$$\tilde{f}_{1}^{-}(y) = f_{11}^{-}(|y|, \phi) + i f_{12}^{-}(|y|, \phi) = 0,$$

with

$$f_{11}^{-}(|y|,\phi) = |y|^{s}\cos(s\phi) - s|y|\cos\phi + s - 1 + N^{\frac{2s}{2-s}}\theta_{N}$$

and

$$f_{12}^{-}(|y|,\phi) = -|y|^{s}\sin(s\phi) + s|y|\sin\phi.$$

Arguing similarly to the case of f_1^+ we prove that f_1^- has only one root $y^- = y^-(N)$ which satisfies (5.5). This proves the first part of Lemma 5.2.

To prove the second part, we first translate $y \to y+1$ and study the existence of zeros for

$$\tilde{f}_2^{\pm}(y) = y^s + sy + s - 1 + N^{\frac{2s}{2-s}}\theta_N$$
 (5.10)

on $\tilde{G}_2^{\pm}=\{y\in\mathbb{C}:\operatorname{Re}y\geq0\text{ and }\pm\operatorname{Im}y\geq0\}$. We introduce the decomposition $y=|y|\,e^{\pm i\phi}$, for $0\leq\phi\leq\frac{\pi}{2}$ into (5.10) to get

$$\tilde{f}_{2}^{\pm}(y) = f_{21}^{\pm}(|y|, \phi) + i f_{22}^{\pm}(|y|, \phi),$$

with

$$f_{21}^{\pm}(|y|,\phi) = |y|^s \cos(s\phi) + s|y|\cos\phi + s - 1 + N^{\frac{2s}{2-s}}\theta_N$$

and

$$f_{22}^{\pm}\left(\left|y\right|,\phi\right)=\pm\left(\left|y\right|^{s}\sin\left(s\phi\right)+s\left|y\right|\sin\phi\right).$$

Since

$$\pm f_{22}^{\pm}(|y|,\phi) > 0$$

for all |y| > 0 and all $0 < \phi \le \frac{\pi}{2}$, and

$$f_{21}^{\pm}(|y|,0) = |y|^s + s|y| + s - 1 + N^{\frac{2s}{2-s}}\theta_N > 0,$$

we conclude that $\tilde{f}_2^{\pm}(y)$ does not have roots on \tilde{G}_2^{\pm} .

Proof of Lemma 5.1. We have

$$m^{(\kappa)}(x) := m_N(x) = \frac{s(s-1)}{2} \mathcal{F}^{-1}\left(\frac{1}{\kappa^{-2}(|\kappa\xi+1|^s - s\kappa\xi - 1) + \theta^{(\kappa)}}\right)(x),$$

with $\kappa = N^{\frac{s}{2-s}}$ and $\theta^{(\kappa)} = \frac{s(s-1)}{2}\theta_N$. Let us study the function

$$+ \frac{1}{\sqrt{2\pi}} \int_{-\infty}^{\infty} e^{ix\xi} \frac{d\xi}{\kappa^{-2} (|\kappa\xi + 1|^s - s\kappa\xi - 1) + \theta^{(\kappa)}}$$

$$= I_1 + I_2,$$
(5.11)

with

$$I_{1} = \frac{1}{\sqrt{2\pi}} \int_{-\frac{1}{\kappa}}^{\infty} e^{ix\xi} \frac{d\xi}{\kappa^{-2} \left((\kappa \xi + 1)^{s} - s\kappa \xi - 1 \right) + \theta^{(\kappa)}}$$

and

$$I_2 = \frac{1}{\sqrt{2\pi}} \int_{\frac{1}{\kappa}}^{\infty} e^{-ix\xi} \frac{d\xi}{\kappa^{-2} \left((\kappa \xi - 1)^s + s\kappa \xi - 1 \right) + \theta^{(\kappa)}}.$$

Suppose that x > 0. First, we consider I_1 . We extend the denominator $F(\xi) = \kappa^{-2} ((\kappa \xi + 1)^s - s\kappa \xi - 1) + \theta^{(\kappa)}$ analytically by the function $\kappa^{-2} f_1^+(\kappa \xi)$, defined by (5.3). By Lemma 5.2 $F(\xi) = \kappa^{-2} ((\kappa \xi + 1)^s - s\kappa \xi - 1) + \theta^{(\kappa)}$ has only one root $\xi = \xi^{(\kappa)}$ in the region $\{\xi \in \mathbb{C} : \operatorname{Re} \xi > -\frac{1}{\kappa} \text{ and } \operatorname{Im} \xi > 0\}$. Then, it follows from Jordan's lemma that

$$I_{1} = \frac{2\pi i}{\sqrt{2\pi}} e^{ix\xi^{(\kappa)}} \frac{\kappa}{s \left(\kappa \xi^{(\kappa)} + 1\right)^{s-1} - s} + I_{11}, \tag{5.12}$$

$$I_{11} = \frac{1}{\sqrt{2\pi}} \int_{-\frac{1}{\kappa}}^{-\frac{1}{\kappa} + i\infty} e^{ix\xi} \frac{d\xi}{\kappa^{-2} ((\kappa \xi + 1)^s - s\kappa \xi - 1) + \theta^{(\kappa)}}.$$

By (3.9)
$$F\left(\xi^{(\kappa)}\right) = \frac{s\left(s-1\right)}{2} \left(\xi^{(\kappa)}\right)^2 + \theta^{(\kappa)} + O\left(\kappa\left(\xi^{(\kappa)}\right)^3\right) = 0. \tag{5.13}$$

 (5.15)

with

$$Z = \frac{i\kappa^2 e^{-i\frac{x}{\kappa}}}{x\sqrt{2\pi}} \int_{0}^{\infty} e^{-\frac{x}{\kappa}y} \frac{\left(i^s s y^{s-1} - is\right)}{\left(i^s y^s - i s y + s - 1 + \kappa^2 \theta^{(\kappa)}\right)^2} dy.$$

We decompose now Z as

$$Z = Z_1 + Z_2 + Z_3, (5.16)$$

where

$$Z_1 = i^{s+1} \frac{s\kappa^2 e^{-i\frac{x}{\kappa}}}{(s-1)^2 x\sqrt{2\pi}} \int_0^\infty e^{-\frac{x}{\kappa}y} y^{s-1} dy,$$

$$Z_2 = \frac{s\kappa^2 e^{-i\frac{x}{\kappa}}}{x\sqrt{2\pi}} \int_0^\infty e^{-\frac{x}{\kappa}y} \frac{1}{\left(i^s y^s - isy + s - 1 + \kappa^2 \theta^{(\kappa)}\right)^2} dy$$

and

$$Z_{3} = \frac{si^{s+1}\kappa^{2}e^{-i\frac{x}{\kappa}}}{x\sqrt{2\pi}} \int_{0}^{\infty} e^{-\frac{x}{\kappa}y} y^{s-1} \left(\frac{1}{\left(i^{s}y^{s} - isy + s - 1 + \kappa^{2}\theta^{(\kappa)}\right)^{2}} - \frac{1}{\left(s - 1\right)^{2}} \right) dy.$$

Making the change $z = \frac{x}{\kappa}y$ in Z_1 and Z_3 we have

$$Z_{1} = \frac{si^{s+1}\kappa^{2+s}e^{-i\frac{x}{\kappa}}}{(s-1)^{2}x^{s+1}\sqrt{2\pi}}\int_{0}^{\infty}e^{-z}z^{s-1}dz = \frac{si^{s+1}e^{-i\frac{x}{\kappa}}}{(s-1)^{2}\sqrt{2\pi}}\Gamma\left(s\right)\left(\frac{\kappa^{2+s}}{x^{s+1}}\right)$$
(5.17)

and

$$Z_3 = \frac{o(\kappa^{2+s})}{x^{s+1}} + \kappa^{2+s} o\left(\frac{1}{x^{s+1}}\right). \tag{5.18}$$

Using (5.17) and (5.18) in (5.16) we have

$$Z = \frac{si^{s+1}e^{-i\frac{x}{\kappa}}}{(s-1)^2\sqrt{2\pi}}\Gamma(s)\left(\frac{\kappa^{2+s}}{x^{s+1}}\right) + Z_2 + \frac{o(\kappa^{2+s})}{x^{s+1}} + \kappa^{2+s}o\left(\frac{1}{x^{s+1}}\right).$$

Introducing the last equation into (5.15) we get

Finally, using (5.14) and (5.19) in (5.12)

$$I_{1} = \sqrt{\frac{\pi}{2}} \frac{2}{s(s-1)\sqrt{\lambda(s)}} e^{-\sqrt{\lambda(s)}|x|} + \frac{si^{s+1}e^{-i\frac{x}{\kappa}}}{(s-1)^{2}\sqrt{2\pi}} \Gamma(s) \left(\frac{\kappa^{2+s}}{x^{s+1}}\right) + \frac{i\kappa^{2}}{x\sqrt{2\pi}} \frac{e^{-i\frac{x}{\kappa}}}{s-1+\kappa^{2}\theta^{(\kappa)}} + Z_{2} + e^{-\sqrt{\lambda(s)}|x|} o_{\kappa}(1) + \frac{\kappa^{2+s}}{x^{s+1}} o_{\kappa}(1) + \frac{\kappa^{2+s}}{x^{s+1}} o_{|x|}(1),$$

$$(5.20)$$

where $o_{\kappa}(1) \to 0$, as $\kappa \to 0$, and $o_{|x|}(1) \to 0$, as $|x| \to \infty$.

Let us now consider I_2 . We extend $F_1(\xi) = \kappa^{-2} ((\kappa \xi - 1)^s + s\kappa \xi - 1) + \theta^{(\kappa)}$ to the analytic function $\kappa^{-2} f_2^-(\kappa \xi)$, defined by (5.4). $$\tilde{Z}_2 = -\frac{s\kappa^2 e^{-i\frac{x}{\kappa}}}{x\sqrt{2\pi}} \int_{0}^{\infty} e^{-\frac{x}{\kappa}y} \frac{1}{\left((-iy)^s - isy + s - 1 + \kappa^2 \theta^{(\kappa)}\right)^2} dy$$

and

$$\tilde{Z}_{3} = \frac{(-i)^{s+1} s \kappa^{2} e^{-i\frac{x}{\kappa}}}{x\sqrt{2\pi}} \int_{0}^{\infty} e^{-\frac{x}{\kappa}y} y^{s-1} \left(\frac{1}{\left((-iy)^{s} - isy + s - 1 + \kappa^{2} \theta^{(\kappa)}\right)^{2}} - \frac{1}{(s-1)^{2}} \right) dy.$$

Changing $z = \frac{x}{\kappa}y$ in \tilde{Z}_3 we show that

$$\tilde{Z}_3 = \frac{o\left(\kappa^{2+s}\right)}{x^{s+1}} + \kappa^{2+s}o\left(\frac{1}{x^{s+1}}\right).$$

Since $\nabla \left(\omega_{\varepsilon,\delta}\overline{P_N}\right) = \left(\nabla \omega_{\varepsilon,\delta}\right)\overline{P_N} + \omega_{\varepsilon,\delta}\nabla \overline{P_N}$,

$$\int \nabla P_N \nabla \left(\omega_{\varepsilon,\delta} \overline{P_N}\right) \ge \int \omega_{\varepsilon,\delta} \left|\nabla P_N\right|^2 - \int \omega_{\varepsilon,\delta} \left|P_N\right| \left|\nabla P_N\right|$$

 $\ge \int \omega_{\varepsilon,\delta} \left|\nabla P_N\right|^2 - \frac{1}{2} \int \omega_{\varepsilon,\delta} \left|P_N\right|^2 - \frac{1}{2} \int \omega_{\varepsilon,\delta} \left|\nabla P_N\right|^2,$

and then from (5.31) it follows

+2 \int (((-\Delta) - n_N(D)) R_N) \left(\omega_{\varepsilon,\delta} \overline{R_N}\right).$$

Using (5.29) we have

$$\frac{\frac{2}{\theta_{N}} \int \omega_{\varepsilon,\delta} |P_{N}|^{2s+2} \leq \frac{2}{\theta_{N}} \int_{|y| \leq R} \omega_{\varepsilon,\delta} |P_{N}(y)|^{2s+2} dy}{+ \frac{2C}{\theta_{N} (1+R^{s+1})^{2s}} \int_{|y| \geq R} \omega_{\varepsilon,\delta} |P_{N}(y)|^{2} dy} \leq \frac{2}{\theta_{N}} \int_{|y| < R} e^{\delta|y|} |P_{N}(y)|^{2s+2} dy + \frac{1}{2} \int \omega_{\varepsilon,\delta} |P_{N}|^{2},$$

for some R > 0 big enough. Using the last relation in (5.32) we get

We estimate the second term in the right-hand side of (5.33) by

$$\leq \int \left| \langle y \rangle \frac{\omega_{\varepsilon, \delta}}{\sqrt{\omega_{\varepsilon, \delta} \left(\sqrt{\theta_{N}} y \right)}} \left(\left(\left(-\Delta \right) - n_{N} \left(D \right) \right) R_{N} \right) \right| \left(\langle y \rangle^{-1} \sqrt{\omega_{\varepsilon, \delta} \left(\sqrt{\theta_{N}} y \right)} \left| R_{N} \right| \right) dy.$$

$$(5.34)$$

Using (5.27) we have $\langle y \rangle \frac{\omega_{\varepsilon,\delta}}{\sqrt{\omega_{\varepsilon,\delta}(\sqrt{\theta_N y})}} \leq N^{-k\delta}$, for some k > 0. Then, if $\delta > 0$ is small enough, by using (3.7), via Sobolev's theorem we obtain

$$\left| \langle y \rangle \frac{\omega_{\varepsilon,\delta}}{\sqrt{\omega_{\varepsilon,\delta}(\sqrt{\theta_N}y)}} \left(\left(\left(-\Delta \right) - n_N \left(D \right) \right) R_N \right) \right|$$

$$\leq C N^{-k\delta} \left\| \left(\left(\left(-\Delta \right) - n_N \left(D \right) \right) R_N \right) \right\|_{H^1} \leq C N^{\delta_1} \left\| R_N \right\|_{H^n},$$

for some $\delta_1 > 0$ and n > 1. Then, there is $N_0 > 0$, such that

$$\sup_{y \in \mathbb{R}} \left| \langle y \rangle \frac{\omega_{\varepsilon,\delta}}{\sqrt{\omega_{\varepsilon,\delta}(\sqrt{\theta_N}y)}} \left(\left(\left(-\Delta \right) - n_N(D) \right) R_N \right) \right| \le \frac{\sqrt{\theta_N}}{8}.$$

Using this inequality in (5.34) we get

$$\left| \int \left(\left(\left(\left(-\Delta \right) - n_N \left(D \right) \right) R_N \right) \left(\omega_{\varepsilon, \delta} \overline{R_N} \right) \right| \leq \frac{\sqrt{\theta_N}}{4} + \frac{\sqrt{\theta_N}}{8} \int \omega_{\varepsilon, \delta} \left(\sqrt{\theta_N} y \right) \left| R_N \left(y \right) \right|^2 dy.$$

Introducing the last inequality into (5.33) we arrive to

$$\int \omega_{\varepsilon,\delta} \left(\sqrt{\theta_N} y \right) |R_N (y)|^2 dy \le \frac{8}{(\theta_N)^{3/2}} \int_{|y| \le R} e^{\delta |x|} |P_N (y)|^{2s+2} dy + 2.$$

Taking the limit as $\varepsilon \to 0$, we obtain

$$\int e^{\sqrt{\theta_N}\delta|x|} |R_N(y)|^2 dy \le C.$$
(5.35)

Note that by (5.27) $|m_N(x)| \leq Ce^{-\frac{2\lambda(s)}{s(s-1)}|x|}$. Then, it follows from (5.1) that

$$|R_N(x)| \le C \int e^{-\sqrt{\lambda(s)}|x-y|} \left(|R_N|^{2s} R_N \right) (y) dy.$$
 (5.36)

Since 2s + 1 > 2, from (5.35) and (5.36) we deduce (5.28). Finally, summing up (5.26) and (5.28) we attain (5.23).

We have now all ingredients that we need to prove Theorem 1.4.

Proof of Theorem 1.4. We consider again equation (5.1). It follows from Theorem 1.2 that there exist $\tilde{x}, \tilde{\gamma} \in \mathbb{R}, \ \tilde{\gamma} = \tilde{\gamma}(N)$ and $\tilde{x} = \tilde{x}(N)$, such that

$$\lim_{N \to 0} \left\| e^{i\tilde{\gamma}} R_N \left(\cdot + \tilde{x} \right) - \mathcal{R} \right\|_{H^1} = 0.$$

Let $\tilde{R}_N(x) = e^{i\tilde{\gamma}}R_N(x+\tilde{x})$. Note that \tilde{R}_N solves (5.1) and tends to \mathcal{R} , as $N \to 0$. We write

$$\tilde{R}_{N}(x) = \mathcal{C}_{1} \int_{|y| \leq \frac{|x|}{2}} e^{-\sqrt{\lambda(s)}|x-y|} \left(|\mathcal{R}|^{2s} \mathcal{R} \right) (y) dy$$

$$+ \frac{\mathcal{C}_{2}N^{\frac{s(2+s)}{2-s}}}{|x|^{s+1}} \int |\mathcal{R}|^{2s} \mathcal{R} + \sum_{j=1}^{5} \rho_{j},$$

$$(5.37)$$

where

$$\rho_{1} := \frac{C_{2}N^{\frac{s(2+s)}{2-s}}}{|x|^{s+1}} \int_{|y| \ge \frac{|x|}{2}} \left(|\mathcal{R}|^{2s} \, \mathcal{R} \right) (y) \, dy$$

$$\rho_{2} := C_{2}N^{\frac{s(2+s)}{2-s}} \int_{|y| \le \frac{|x|}{2}} \left(\frac{1}{|x-y|^{s+1}} - \frac{1}{|x|^{s+1}} \right) \left(|\mathcal{R}|^{2s} \, \mathcal{R} \right) (y) \, dy$$

$$\rho_{3} := \int_{|y| \le \frac{|x|}{2}} \left(m_{N} (x-y) - C_{1}e^{-\sqrt{\lambda(s)}|x-y|} - C_{2} \frac{N^{\frac{s(2+s)}{2-s}}}{|x-y|^{s+1}} \right) \left(|\mathcal{R}|^{2s} \, \mathcal{R} \right) (y) \, dy,$$

$$\rho_{4} := \int_{|y| \le \frac{|x|}{2}} m_{N} (x-y) \left(\left(\left| \tilde{R}_{N} \right|^{2s} \tilde{R}_{N} \right) (y) - \left(|\mathcal{R}|^{2s} \, \mathcal{R} \right) (y) \right) dy$$

and

$$\rho_5 := \int_{|y| \ge \frac{|x|}{2}} m_N (x - y) \left(\left| \tilde{R}_N \right|^{2s} \tilde{R}_N \right) (y) \, dy.$$

We observe that \mathcal{R} satisfies the estimate

$$|\mathcal{R}(x)| \le Ce^{-\sqrt{\lambda(s)}|x|}, \quad x \in \mathbb{R}.$$
 (5.38)

Then, as s>1, $\rho_1=N^{\frac{s(2+s)}{2-s}}e^{-\sqrt{\lambda(s)}|x|}o_{|x|}(1)$, where $o_{|x|}(1)\to 0$, as $|x|\to\infty$. Taking into account the relation

$$\left| \int_{|y| \le \frac{|x|}{2}} \left(\frac{1}{|x-y|^{s+1}} - \frac{1}{|x|^{s+1}} \right) \left(\left| \mathcal{R} \right|^{2s} \mathcal{R} \right) (y) \, dy \right|$$

$$\le \frac{C}{|x|^{s+2}} \int_{|y| \le \frac{|x|}{2s}} |y| \, \left| \left| \mathcal{R} \right|^{2s} \mathcal{R} \right| (y) \, dy,$$

we show that $\rho_2 = \frac{N^{\frac{s(2+s)}{2-s}}}{|x|^{s+1}} o_{|x|}(1)$. From Lemma 5.1 it follows that

$$\rho_{3} = o_{N}(1) e^{-\sqrt{\lambda(s)}|x|} + \frac{N^{\frac{s(2+s)}{2-s}} o_{N}(1)}{|x|^{s+1}} + \frac{N^{\frac{s(2+s)}{2-s}}}{|x|^{s+1}} o(1),$$

with $o_N(1) \to 0$, as $N \to 0$. Since $m_N \in H^{\frac{1}{2}+\varepsilon}$, for $\varepsilon > 0$, in particular $m_N \in L^{\infty}$. Then, using Lemma 5.1 we show that m_N satisfies estimate (5.22). Hence, since $\tilde{R}_N \to \mathcal{R}$, as $N \to 0$, we estimate

$$\rho_4 = o_N(1) \left(e^{-\sqrt{\lambda(s)}|x|} + \frac{1}{|x|^{s+1}} \right).$$

Finally, as s > 1, by using Lemma 5.3 we deduce that

$$\rho_5 = e^{-\sqrt{\lambda(s)}|x|} o_{|x|} (1) + \frac{N^{\frac{s(2+s)}{2-s}}}{1 + |x|^{s+1}} o_{|x|} (1) o_N (1).$$

Therefore, summing up the above estimates we prove

$$\sum_{j=1}^{5} \rho_{j} = \left(e^{-\sqrt{\lambda(s)}|x|} + \frac{N^{\frac{s(2+s)}{2-s}}}{|x|^{s+1}} \right) \left(o_{|x|} \left(1 \right) + o_{N} \left(1 \right) \right).$$

As \mathcal{R} is radially symmetric we have

$$C_{1} \int_{|y| \leq \frac{|x|}{2}} e^{-\sqrt{\lambda(s)}|x-y|} \left(|\mathcal{R}|^{2s} \mathcal{R} \right) (y) dy$$

$$= C_{1} e^{-\sqrt{\lambda(s)}|x|} \int_{|y| \leq \frac{|x|}{2}} e^{\sqrt{\lambda(s)}y} \left(|\mathcal{R}|^{2s} \mathcal{R} \right) (y) dy.$$

Using this equality in (5.37) we obtain

$$\tilde{R}_{N}(x) = \mathcal{C}_{1}e^{-\sqrt{\lambda(s)}|x|} \int e^{\sqrt{\lambda(s)}y} \left(|\mathcal{R}|^{2s} \mathcal{R} \right) (y) dy$$
$$+ \frac{\mathcal{C}_{2}N^{\frac{s(2+s)}{2-s}}}{|x|^{s+1}} \int |\mathcal{R}|^{2s} \mathcal{R} + \sum_{j=1}^{6} \rho_{j},$$

with

$$\rho_6 := -\mathcal{C}_1 e^{-\sqrt{\lambda(s)}|x|} \int_{|y| \ge \frac{|x|}{2}} e^{\sqrt{\lambda(s)}y} \left(|\mathcal{R}|^{2s} \mathcal{R} \right) (y) \, dy$$

By using (5.38) we estimate $\rho_6 = e^{-\sqrt{\lambda(s)}|x|}o_{|x|}(1)$. Theorem 1.4 is proved.
