On the Equality of Solutions of Max-Min and Min-Max Systems of Variational Inequalities with Interconnected Bilateral Obstacles.

Abstract

In this paper, we deal with the solutions of systems of PDEs with bilateral inter-connected obstacles of minmax and max-min types. These systems arise naturally in stochastic switching zero-sum game problems. We show that when the switching costs of one side are regular, the solutions of the min-max and max-min systems coincide. Then, this common viscosity solution is related to a multi-dimensional doubly reflected BSDE with bilateral interconnected obstacles. Finally, its relationship with the the values of a zero-sum switching game is studied.

1. Introduction

Let us consider the following two systems of partial differential equations (PDEs) with bilateral inter-connected obstacles (i.e., the obstacles depend on the solution) of min-max and max-min types: for any $(i,j) \in \Gamma^1 \times \Gamma^2$, $(t,x) \in [0,T] \times \mathbb{R}^k$,

- (i) Γ^1 and Γ^2 are finite sets (possibly different);
- $\text{(ii) For any } (t,x) \in [0,T] \times \mathbb{R}^k, \ \vec{v}(t,x) = (v^{kl}(t,x))_{(k,l) \in \Gamma^1 \times \Gamma^2} \text{ and for any } (i,j) \in \Gamma^1 \times \Gamma^2,$

$$L^{ij}(\vec{v})(t,x) = \max_{k \in \Gamma^1, k \neq i} \{ v^{kj}(t,x) - \underline{g}_{ik}(t,x) \}, \ U^{ij}(\vec{v})(t,x) = \min_{p \in \Gamma^2, p \neq j} \{ v^{ip}(t,x) + \bar{g}_{jp}(t,x) \}.$$

(iii) \mathcal{L}^X is a second order generator associated with the following diffusion process $X^{t,x}$ satisfying:

The required properties on b and σ will be precised later.

The systems (1.1) and (1.2) are of min-max and max-min types respectively. The barriers $L^{ij}(\vec{v}), U^{ij}(\vec{v})$ and $L^{ij}(\vec{v}), U^{ij}(\vec{v})$ depend on the solution $\vec{v} = (\vec{v}^{ij})_{(i,j)\in\Gamma^1\times\Gamma^2}$ and $\vec{v} = (\underline{v}^{ij})_{(i,j)\in\Gamma^1\times\Gamma^2}$ of (1.1) and (1.2) respectively. They are related to zero-sum switching game problems since actually, specific cases of these systems, stand for the Hamilton-Jacobi-Bellman-Isaacs equations associated with those games.

Switching problems have recently attracted a lot of research activities, especially in connection with mathematical finance, commodities, and in particular energy markets, etc (see e.g. [3, 23, 4, 5, 11, 1, 9, 8, 10, 15, 16, 18, 20, 22, 24, 25, 26, 21, 30, 27, 28] and the references therein). Several points of view, mainly dealing with control problems, have been considered (theoritical and practical [3, 23, 5, 9, 10, 15, 18, 26], numerics [4, 15], filtering and partial information [22]). However, except [19, 20], problems related to switching games did not attract that much interest in the literature.

In [8], by means of systems of reflected backward stochastic differential equations (BSDEs) with interconnected obstacles in combination with Perron's method, Djehiche et al. have shown that each of the systems (1.1) and (1.2) has a unique continuous solution with polynomial growth, under classical assumptions on the data f^{ij} , \bar{g}_{ij} , \underline{g}_{ij} and h^{ij} . The question of whether or not these solutions coincide was conjectured as an open problem, leaving a possible connection of the solution of system (1.1) and (1.2) with zero-sum switching games unanswered. The main objective of this paper is three-fold: (i) to investigate under which additional assumptions on the data of these problems, the unique solutions of systems (1.1) and (1.2) coincide; (ii) to make a connection between this solution and the associated system of reflected BSDEs with bilateral inter-connected obstacles; (iii) to study the relationship with the value function of the associated zero-sum switching game.

We show that if the switching costs of one side (or player), i.e. either $(\bar{g}_{ij})_{(i,j)\in\Gamma^1\times\Gamma^2}$ or $(\underline{g}_{ij})_{(i,j)\in\Gamma^1\times\Gamma^2}$, are regular enough, then the solutions of the systems (1.1) and (1.2) coincide, i.e., $\bar{v}^{ij} = \underline{v}^{ij}$, for any $(i,j)\in\Gamma^1\times\Gamma^2$. The strategy to obtain these results is to show that the barriers, which depend on the solution, are comparable and then thanks to a result by Hamadène-Hassani [14] (see Theorem 6.3 in appendix (A2)) on viscosity solutions of standard min-max and max-min PDE problems and uniqueness of the solutions of (1.1) and (1.2), we obtain the equality of those latter.

Next, with the help of this common solution, we have proved existence and uniqueness of quadruples $(Y^{ij}, Z^{ij}, K^{ij,\pm})_{(i,j)\in\Gamma^1\times\Gamma^2}$ solution of the following system of reflected BSDEs with inter-connected obstacles: $\forall (i,j)\in\Gamma^1\times\Gamma^2, \, \forall s\in[t,T],$

The component $(Y^{ij})_{(i,j)\in\Gamma^1\times\Gamma^2}$ has the following Feynman-Kac representation:

$$\forall (i,j) \in \Gamma^1 \times \Gamma^2 \text{ and } s \in [t,T], Y_s^{ij} = \bar{v}^{ij}(s, X_s^{t,x}). \tag{1.6}$$

In this Markovian framework of randomness, this result improves substancially the one by Hu-Tang [19] on the same subject. Uniqueness is even new.

Finally at the end of the paper, we deal with issues related to the link of the solution of systems (1.1) and (1.2) and the value function of the zero-sum switching game. In some particular cases, we show that they are equal and a saddle-point for the game is obtained.

To the best of our knowledge, these issues have not been addressed in the literature yet.

The paper is organized as follows. In Section 2, we fix some notations and, for sake of completeness, recall accurately under which conditions each of the systems (1.1) and (1.2) has a unique solution. Note that these results are already given in [8]. In Section 3, we show that if mainly the switching costs \bar{g}_{ij} , $(i,j) \in \Gamma^1 \times \Gamma^2$, are $C^{1,2}$ then the unique solutions of (1.1) and (1.2) coincide. Next the link with the unique solution of system (1.5) is stated. The proof of this result is postponed to Appendix, given in the end of the paper. In Section 4, we first describe the zero-sum switching game problem. Then, under some additional conditions on the two families $(f^{ij})_{(i,j)\in\Gamma^1\times\Gamma^2}$ and $(h^{ij})_{(i,j)\in\Gamma^1\times\Gamma^2}$, we show that this game has a value which is given by the unique solution of (1.1) and (1.2) and thus in terms of the solution of (1.5) as well, due to relation (1.6). We also provide a saddle-point of this game. The relationship of Y^{ij} and the upper and lower values of the game are also studied.

2. Notations and first results

Let T (resp. k,d) be a fixed positive constant (resp. two integers) and Γ^1 (resp. Γ^2) denote the set of switching modes for player 1 (resp. 2). For later use, we shall denote by Λ the cardinal of the product set $\Gamma := \Gamma^1 \times \Gamma^2$ and for $(i,j) \in \Gamma$, $(\Gamma^1)^{-i} := \Gamma^1 - \{i\}$ and $(\Gamma^2)^{-j} := \Gamma^2 - \{j\}$. For $\vec{y} = (y^{kl})_{(k,l) \in \Gamma^1 \times \Gamma^2} \in \mathbb{R}^{\Lambda}$, $(i,j) \in \Gamma^1 \times \Gamma^2$, and $\underline{y} \in \mathbb{R}$, we denote by $[(y^{kl})_{(k,l) \in \Gamma^1 \times \Gamma^2 - \{i,j\}}, \underline{y}]$ the matrix obtained from the matrix $\vec{y} = (y^{kl})_{(k,l) \in \Gamma^1 \times \Gamma^2}$ by replacing the element y^{ij} with y.

For any $(i, j) \in \Gamma^1 \times \Gamma^2$, let

A function $\Phi:(t,x)\in[0,T]\times\mathbb{R}^k\mapsto\Phi(t,x)\in\mathbb{R}$ is called of *polynomial growth* if there exist two non-negative real constants C and γ such that

$$|\Phi(t,x)| \le C(1+|x|^{\gamma}), \, \forall (t,x) \in [0,T] \times \mathbb{R}^k.$$

Hereafter, this class of functions is denoted by Π_g . Let $\mathcal{C}^{1,2}([0,T]\times\mathbb{R}^k)$ (or simply $\mathcal{C}^{1,2}$) denote the set of real-valued functions defined on $[0,T]\times\mathbb{R}^k$, which are once (resp. twice) differentiable w.r.t. t (resp. x) and with continuous derivatives.

The following assumptions (H0)-(H4) on the data of the systems (1.1) and (1.2) are in force throughout the paper. They are the same as in [8].

(H0) The functions b and σ are jointly continuous in (t,x) and Lipschitz continuous w.r.t. x uniformly in t, meaning that there exists a non-negative constant C such that for any $(t,x,x') \in [0,T] \times \mathbb{R}^{k+k}$ we have

$$|\sigma(t,x) - \sigma(t,x')| + |b(t,x) - b(t,x')| \le C|x - x'|.$$

Thus they are also of linear growth w.r.t. x, i.e., there exists a constant C such that for any $(t, x) \in [0, T] \times \mathbb{R}^k$,

$$|b(t,x)| + |\sigma(t,x)| < C(1+|x|).$$

- (**H1**) Each function f^{ij}
 - (i) is continuous in (t, x) uniformly w.r.t. the other variables (\vec{y}, z) and, for any (t, x), the mapping $(t, x) \to f^{ij}(t, x, 0, 0)$ is of polynomial growth.
 - (ii) is Lipschitz continuous with respect to the variables $(\vec{y} := (y^{ij})_{(i,j)\in\Gamma_1\times\Gamma_2}, z)$ uniformly in (t,x), i.e. $\forall (t,x) \in [0,T] \times \mathbb{R}^k, \ \forall (\vec{y_1},\vec{y_2}) \in \mathbb{R}^\Lambda \times \mathbb{R}^\Lambda, (z^1,z^2) \in \mathbb{R}^d \times \mathbb{R}^d,$

$$|f^{ij}(t, x, \vec{y}_1, z_1) - f^{ij}(t, x, \vec{y}_2, z_2)| \le C(|\vec{y}_1 - \vec{y}_2| + |z_1 - z_2|),$$

where $|\vec{y}|$ stands for the standard Euclidean norm of \vec{y} in \mathbb{R}^{Λ} .

- (**H2**) Monotonicity: Let $\vec{y} = (y^{kl})_{(k,l) \in \Gamma^1 \times \Gamma^2}$. For any $(i,j) \in \Gamma^1 \times \Gamma^2$ and any $(k,l) \neq (i,j)$ the mapping $y^{kl} \to f^{ij}(s,\vec{y},z)$ is non-decreasing.
- (H3) The functions h^{ij} , which are the terminal conditions in the systems (1.1) and (1.2), are continuous with respect to x, belong to class Π_q and satisfy the following consistency condition:

$$\forall \ (i,j) \in \Gamma^1 \times \Gamma^2 \text{ and } x \in \mathbb{R}^k, \ \max_{k \in (\Gamma^1)^{-i}} \left(h^{kj}(x) - \underline{g}_{ik}(T,x) \right) \leq h^{ij}(x) \leq \min_{l \in (\Gamma^2)^{-j}} \left(h^{il}(x) + \bar{g}_{jl}(T,x) \right).$$

(H4) The non-free loop property: The switching costs \underline{g}_{ik} and \bar{g}_{jl} are non-negative, jointly continuous in (t, x), belong to Π_q and satisfy the following condition:

For any loop in $\Gamma^1 \times \Gamma^2$, i.e., any sequence of pairs $(i_1, j_1), \ldots, (i_N, j_N)$ of $\Gamma^1 \times \Gamma^2$ such that $(i_N, j_N) = (i_1, j_1),$ card $\{(i_1, j_1), \ldots, (i_N, j_N)\} = N - 1$ and any $q = 1, \ldots, N - 1$, either $i_{q+1} = i_q$ or $j_{q+1} = j_q$, we have: $\forall (t, x) \in [0, T] \times \mathbb{R}^k$,

$$\sum_{q=1,N-1} \varphi_{i_q j_q}(t,x) \neq 0, \tag{2.1}$$

where, $\forall q = 1, ..., N-1, \ \varphi_{i_q j_q}(t, x) = -\underline{g}_{i_q i_{q+1}}(t, x) \mathbb{1}_{i_q \neq i_{q+1}} + \bar{g}_{j_q j_{q+1}}(t, x) \mathbb{1}_{j_q \neq j_{q+1}}$

This assumption implies in particular that

$$\forall (i_1, \dots, i_N) \in (\Gamma^1)^N \text{ such that } i_N = i_1 \text{ and } \operatorname{card}\{i_1, \dots, i_N\} = N - 1, \sum_{p=1}^{N-1} \underline{g}_{i_k i_{k+1}} > 0$$

and

$$\forall (j_1, \dots, j_N) \in (\Gamma^2)^N \text{ such that } j_N = j_1 \text{ and } \operatorname{card}\{j_1, \dots, j_N\} = N - 1, \sum_{n=1}^{N-1} \bar{g}_{j_k j_{k+1}} > 0.$$

By convention we set $\bar{g}_{jj} = \underline{g}_{ii} = 0$.

Conditions (2.2) and (2.3) are classical in the literature of switching problems and usually referred to as the *non* free loop property.

We now introduce the probabilistic tools we need later. Let $(\Omega, \mathcal{F}, \mathbb{P})$ be a fixed probability space on which is defined a standard d-dimensional Brownian motion $B = (B_t)_{0 \le t \le T}$ whose natural filtration is $(\mathcal{F}_t^0 := \sigma\{B_s, s \le t\})_{0 \le t \le T}$. Let $\mathbf{F} = (\mathcal{F}_t)_{0 \le t \le T}$ be the completed filtration of $(\mathcal{F}_t^0)_{0 \le t \le T}$ with the \mathbb{P} -null sets of

 \mathcal{F} , hence $(\mathcal{F}_t)_{0 \leq t \leq T}$ satisfies the usual conditions, i.e., it is right continuous and complete. On the other hand, we denote by \mathcal{P} be the σ -algebra on $[0,T] \times \Omega$ of **F**-progressively measurable sets.

Next, let us fix t in [0,T] and let us define

- (i) $\mathcal{H}_t^{2,\ell}$ ($\ell \geq 1$) be the set of \mathcal{P} -measurable and \mathbb{R}^{ℓ} -valued processes $w = (w_s)_{s \in [0,T]}$ such that $\mathbb{E}[\int_t^T |w_s|^2 ds] < \infty$;
- (ii) S_t^2 (resp. $S_{t,d}^2$) be the set of \mathcal{P} -measurable continuous (resp. RCLL) processes $w=(w_s)_{s\in[0,T]}$ such that $\mathbb{E}[\sup_{t\leq s\leq T}|w_s|^2]<\infty$;
- (iii) $\mathcal{A}_{t,i}^2$ be the subset of \mathcal{S}_t^2 of non-decreasing processes $K = (K_s)_{s \in [0,T]}$ such that $K_t = 0$ (and then $K_s = 0$ for s < t);
 - (iv) The sets $\mathcal{H}^{2,\ell}_0$, \mathcal{S}^2_0 , $\mathcal{S}^2_{0,d}$ and $\mathcal{A}^2_{0,i}$ will be simply denoted by $\mathcal{H}^{2,\ell}$, \mathcal{S}^2 , \mathcal{S}^2_d and \mathcal{A}^2_i .

For $(t,x) \in [0,T] \times \mathbb{R}^k$, let $X^{t,x}$ be the diffusion process solution of the following standard SDE:

Under Assumption (H0) on b and σ , the process $X^{t,x}$ exists and is unique ([29], Theorem 2.1 pp.375). Moreover, it satisfies the following estimates: For all $p \ge 1$,

Its infinitesimal generator \mathcal{L}^X is given, for every $(t,x) \in [0,T] \times \mathbb{R}^k$ and $\phi \in \mathcal{C}^{1,2}$, by

Under Assumptions (H0)-(H4), we have

Theorem 2.1. ([8], Theorems 5.4 and 5.5) There exists a unique continuous viscosity solution in the class Π_g $(\bar{v}^{ij})_{(i,j)\in\Gamma^1\times\Gamma^2}$ (resp. $(\underline{v}^{ij})_{(i,j)\in\Gamma^1\times\Gamma^2}$) of the following system: $\forall (i,j)\in\Gamma^1\times\Gamma^2$,

where the obstacles U^{ij} and L^{ij} are defined in (1.3).

In order to obtain the solutions of the systems (2.7) and (2.8) respectively, Djehiche et al. ([8]) introduced the following sequences of backward reflected BSDEs with inter-connected obstacles: $\forall m, n \geq 0, \forall (i, j) \in \Gamma^1 \times \Gamma^2$,

$$\begin{cases} \bar{Y}^{ij,m} \in \mathcal{S}^{2}, \ \bar{Z}^{ij,m} \in \mathcal{H}^{2,d} \ \text{and} \ \bar{K}^{ij,m} \in \mathcal{A}_{i}^{2}; \\ \bar{Y}_{s}^{ij,m} = h^{ij}(X_{T}^{t,x}) + \int_{s}^{T} \bar{f}^{ij,m}(r, X_{r}^{t,x}, (\bar{Y}_{r}^{kl,m})_{(k,l) \in \Gamma^{1} \times \Gamma^{2}}, \bar{Z}_{r}^{ij,m}) dr + \int_{s}^{T} d\bar{K}_{r}^{ij,m} - \int_{s}^{T} \bar{Z}_{r}^{ij,m} dB_{r}, \ s \leq T; \\ \bar{Y}_{s}^{ij,m} \geq \max_{k \in (\Gamma^{1})^{-i}} \{\bar{Y}_{s}^{kj,m} - \underline{g}_{ik}(s, X_{s}^{t,x})\}, \ s \leq T; \\ \int_{0}^{T} (\bar{Y}_{s}^{ij,m} - \max_{k \in (\Gamma^{1})^{-i}} \{\bar{Y}_{s}^{kj,m} - \underline{g}_{ik}(s, X_{s}^{t,x})\}) d\bar{K}_{s}^{ij,m} = 0 \end{cases}$$

\underline{Y}_{s}^{ij,n} = h^{ij}(X_{T}^{t,x}) + \int_{s}^{T} \underline{\mathbf{f}}^{ij,n}(r, X_{r}^{t,x}, (\underline{Y}_{r}^{kl,n})_{(k,l)\in\Gamma^{1}\times\Gamma^{2}}, \underline{Z}_{r}^{ij,n}) dr - \int_{s}^{T} \underline{Z}_{r}^{ij,n} dB_{r} - \int_{s}^{T} \underline{d}\underline{K}_{r}^{ij,n}, s \leq T; \\
\underline{Y}_{s}^{ij,n} \leq \min_{l \in (\Gamma^{2})^{-j}} (\underline{Y}_{s}^{il,n} + \bar{g}_{jl}(s, X_{s}^{t,x})), s \leq T; \\

where, for any $(i, j) \in \Gamma^1 \times \Gamma^2$, $n, m \ge 0$ and (s, x, \vec{y}, z^{ij}) ,

$$\bar{f}^{ij,m}(s,x,\vec{y},z^{ij}) := f^{ij}(s,x,(y^{kl})_{(k,l)\in\Gamma^1\times\Gamma^2},z^{ij}) - m(y^{ij} - \min_{l\in(\Gamma^2)^{-j}}(y^{il} + \bar{g}_{il}(s,x)))^+$$
(2.11)

and

$$\underline{\mathbf{f}}^{ij,n}(s,x,\vec{y},z^{ij}) := f^{ij}(s,x,(y^{kl})_{(k,l)\in\Gamma^1\times\Gamma^2},z^{ij}) + n(y^{ij} - \max_{k\in(\Gamma^1)^{-i}}(y^{kj} - g_{ik}(s,x)))^{-}. \tag{2.12}$$

Under Assumptions (H0)-(H4), it is shown in [16] (see also [5] or [17]) that each one of the systems (2.9) and (2.10) has a unique solution ($\bar{Y}^{ij,m}, \bar{Z}^{ij,m}, \bar{K}^{ij,m}$) and ($\underline{Y}^{ij,m}, \underline{Z}^{ij,m}, \underline{K}^{ij,m}$) respectively. In addition, they enjoy the following properties:

(i) For any $m, n \ge 0$ and $(i, j) \in \Gamma^1 \times \Gamma^2$

$$\bar{Y}^{ij,m} \ge \bar{Y}^{ij,m+1} \ge \underline{Y}^{ij,n+1} \ge \underline{Y}^{ij,n}. \tag{2.13}$$

(ii) For any $n, m \geq 0$ and $(i, j) \in \Gamma^1 \times \Gamma^2$, there exist deterministic continuous functions $\bar{v}^{ij,m}$ and $\underline{v}^{ij,n}$ such that, for any $(t, x) \in [0, T] \times \mathbb{R}^k$ and $s \in [t, T]$, we have

$$\bar{Y}_s^{ij,m} = \bar{v}^{ij,m}(s, X_s^{t,x})$$
 and $\underline{Y}_s^{ij,n} = \underline{v}^{ij,n}(s, X_s^{t,x})$.

Moreover, from (2.13) we easily deduce that, for any $n, m \ge 0$ and $(i, j) \in \Gamma^1 \times \Gamma^2$

Finally, for any $m \geq 0$ (resp. $n \geq 0$), $\bar{v}_m := (\bar{v}^{ij,m})_{(i,j)\in\Gamma^1\times\Gamma^2}$ (resp. $\underline{v}_n := (\underline{v}^{ij,n})_{(i,j)\in\Gamma^1\times\Gamma^2}$) is the unique continuous viscosity solution, in the class Π_g , of the following system of PDEs with inter-connected obstacles: $\forall (i,j) \in \Gamma^1 \times \Gamma^2, \ \forall (t,x) \in [0,T] \times \mathbb{R}^k$,

$$\begin{cases} \min \left\{ (\bar{v}^{ij,m} - L^{ij}(\vec{v}_m)(t,x); \\ -\partial_t \bar{v}^{ij,m}(t,x) - \mathcal{L}^X(\bar{v}^{ij,m})(t,x) - \bar{f}^{ij,m}(t,x,(\bar{v}^{kl,m}(t,x))_{(k,l) \in \Gamma^1 \times \Gamma^2}, \sigma(t,x)^\top D_x \bar{v}^{ij,m}(t,x)) \right\} = 0, \\ \bar{v}^{ij,m}(T,x) = h^{ij}(x) \end{cases}$$

(resp.

$$\left\{ \begin{array}{l} \max \Bigl\{ (\underline{v}^{ij,n} - U^{ij}(\underline{\vec{v}}_n))(t,x); \\ -\partial_t \underline{v}^{ij,n}(t,x) - \mathcal{L}^X(\underline{v}^{ij,n})(t,x) - \underline{\mathbf{f}}^{ij,n}(t,x,(\underline{v}^{kl,n}(t,x))_{(k,l) \in \Gamma^1 \times \Gamma^2}, \sigma^\top(t,x) D_x \underline{v}^{ij,n}(t,x)) \Bigr\} = 0, \\ \underline{v}^{ij,n}(T,x) = h^{ij}(x)). \end{array} \right.$$

(iii) For $(i,j)\in\Gamma^1\times\Gamma^2$ and $(t,x)\in[0,T]\times\mathbb{R}^k,$ let us set

$$\bar{v}^{ij}(t,x) := \lim_{m \to \infty} \searrow \bar{v}^{ij,m}(t,x)$$
 and $\underline{v}^{ij}(t,x) := \lim_{n \to \infty} \nearrow \underline{v}^{ij,n}(t,x)$.

Then, using Perron's method, it is shown that $(\bar{v}^{ij})_{(i,j)\in\Gamma^1\times\Gamma^2}$ (resp. $(\underline{v}^{ij})_{(i,j)\in\Gamma^1\times\Gamma^2}$) is continuous, belongs to Π_g and is the unique viscosity solution, in class Π_g , of system (2.7) (resp. (2.8)). Finally, by construction and in view of (2.14), it holds that, for any $(i,j)\in\Gamma^1\times\Gamma^2$,

$$\underline{v}^{ij} \le \bar{v}^{ij}. \tag{2.15}$$

3. Equality of the solutions of min-max and max-min systems. Related system of reflected BSDEs.

In [8], the question whether or not for any $(i,j) \in \Gamma^1 \times \Gamma^2$, $\underline{v}^{ij} \equiv \overline{v}^{ij}$ was left open. This was mainly due to the fact we have not been able to compare the inter-connected obstacles neither in (2.7) nor in (2.8).

Actually, had we known that

(i)
$$\forall (i,j) \in \Gamma^1 \times \Gamma^2$$
, $L^{ij}(\vec{v}) \leq U^{ij}(\vec{v})$
or
(ii) $\forall (i,j) \in \Gamma^1 \times \Gamma^2$, $L^{ij}(\vec{v}) \leq U^{ij}(\vec{v})$

$$(3.1)$$

then we would have deduced, from the general existence result obtained in Hamadène-Hassani [14] (see Theorem 6.3 in appendix (A2)) and the uniqueness of the solution of (2.7) or (2.8), that for any $(i,j) \in \Gamma^1 \times \Gamma^2$, $\bar{v}^{ij} = \underline{v}^{ij}$. In this section, we are going to investigate under which additional regularity assumptions on the data of the problem, one of the inequalities in (3.1) is satisfied to be able to conclude that $\bar{v}^{ij} = \underline{v}^{ij}$, for any $(i,j) \in \Gamma^1 \times \Gamma^2$, i.e., the solutions of (2.7) and (2.8) are the same.

For this objective, let us introduce the following additional assumption.

(H5):

(i) For any $(i,j) \in \Gamma^1 \times \Gamma^2$, the functions \bar{g}_{ij} are $C^{1,2}$ and, $D_x \bar{g}_{ij}$, $D^2_{xx} \bar{g}_{ij}$ belong to Π_g . Furthermore, for any $j_1, j_2, j_3 \in \Gamma_2$ such that $|\{j_1, j_2, j_3\}| = 3$,

$$\bar{g}_{j_1j_3}(s,x) < \bar{g}_{j_1j_2}(s,x) + \bar{g}_{j_2j_3}(s,x), \ \forall (s,x) \in [0,T] \times \mathbb{R}^k.$$

(ii) For any $(i,j) \in \Gamma^1 \times \Gamma^2$, the function f^{ij} verifies the following estimate:

$$|f^{ij}(s, x, \vec{y}, z^{ij})| \le C(1 + |x|^p), \ \forall (s, x, \vec{y}, z^{ij}) \in [0, T] \times \mathbb{R}^{k + \Lambda + d},$$

for some real constants C and p.

Remark 3.1. Note that by Itô's formula, for any $(i,j) \in \Gamma^1 \times \Gamma^2$,

$$\begin{cases} \bar{g}_{ij}(s, X_s^{t,x}) = \bar{g}_{ij}(t, x) + \int_t^s \mathcal{L}^X(\bar{g}_{ij})(r, X_r^{t,x})dr + \int_t^s D_x \bar{g}_{ij}(r, X_r^{t,x})\sigma(r, X_r^{t,x})dB_r, & s \in [t, T] \\ and & \\ \bar{g}_{ij}(s, X_s^{t,x}) = \bar{g}_{ij}(s, x), & s \leq t. \end{cases}$$

Hereafter and to ease the reading of the Itô-Tanaka formula in Step 2 below (proof of Theorem 3.2), we denote by α^{ij} and β^{ij} , $(i,j) \in \Gamma^1 \times \Gamma^2$, the following processes:

$$\alpha^{ij}(s) := \mathcal{L}^{X}(\bar{g}_{ij})(s, X_s^{t,x}), \ \beta^{ij}(s) := D_x \bar{g}_{ij}(s, X_s^{t,x}) \sigma(s, X_s^{t,x}), \ s \le T.$$

We now provide the main result of this section.

Theorem 3.2. Under Assumptions (H0)-(H5), for any $(i, j) \in \Gamma^1 \times \Gamma^2$, it holds that $\bar{v}^{ij} = \underline{v}^{ij}$.

We derive this last equality after the following four steps.

Step 1: Another approximating scheme for system (2.7).

For any $m \geq 0$, $(i, j) \in \Gamma^1 \times \Gamma^2$ and $(t, x) \in [0, T] \times \mathbb{R}^k$, let us consider the system of reflected BSDEs with one interconnected obstacle:

Y^{ij,m}_{s} \geq \max_{k \in (\Gamma^{1})^{-i}} \{Y^{kj,m}_{s} - \underline{g}_{ik}(s, X_{s}^{t,x})\}, s \leq T; \\
\int_{0}^{T} (Y^{ij,m}_{s} - \max_{k \in (\Gamma^{1})^{-i}} \{Y^{kj,m}_{s} - \underline{g}_{ik}(s, X_{s}^{t,x})\}) dK_{s}^{ij,m} = 0,
\end{cases}$$
(3.2)

where,

$$f^{ij,m}(s,x,\vec{y},z^{ij}) := f^{ij}(s,x,\vec{y},z^{ij}) - m \sum_{l \in (\Gamma^2)^{-j}} (y^{ij} - y^{il} - \bar{g}_{jl}(s,x))^+.$$
(3.3)

This generator is (slightly) different from $\bar{f}^{ij,m}$ given by (2.11) in Section 2. We mention that this new penalized generator is more convenient both for the application of the Itô-Tanaka formula and obtention of the estimate (3.5) (in Step 2). On the other hand, note that for any $(i,j) \in \Gamma^1 \times \Gamma^2$ and $(k,l) \neq (i,j)$ the mapping $\tilde{y} \in \mathbb{R} \mapsto f^{ij,m}(s,x,[(y^{rq})_{(r,q)\in\Gamma^1\times\Gamma^2-(k,l)},\tilde{y}],z^{ij})$ is non-decreasing.

By Corollary 2, in [16], the solution of this system exists and is unique and there exist deterministic continuous functions $(v^{ij,m})_{(i,j)\in\Gamma^1\times\Gamma^2}$, which belong also to Π_g such that, for any i,j and $m\geq 0$, it holds that

$$\forall s \in [t, T], \quad Y_s^{ij,m} = v^{ij,m}(s, X_s^{t,x}). \tag{3.4}$$

Moreover, the family of functions $\vec{v}_m := (v^{ij,m})_{(i,j)\in\Gamma^1\times\Gamma^2}$ is the unique continuous solution in viscosity sense in Π_q of the following system of PDEs with obstacles:

$$\begin{cases} \min \Big\{ (v^{ij,m} - L^{ij}(\vec{v}_m))(t,x); \\ -\partial_t v^{ij,m}(t,x) - \mathcal{L}^X(v^{ij,m})(t,x) - f^{ij,m}(t,x,(v^{kl,m}(t,x))_{(k,l) \in \Gamma^1 \times \Gamma^2}, \sigma(t,x)^\top D_x v^{ij,m}(t,x)) \Big\} = 0, \\ v^{ij,m}(T,x) = h^{ij}(x). \end{cases}$$

Finally, by the Comparison Theorem (see [16], Remark 1) and using that $f^{ij,m+1} \leq f^{ij,m}$ and $\bar{f}^{ij,|\Gamma_2|m} \leq f^{ij,m} \leq \bar{f}^{ij,m}$, we deduce: $\forall (i,j) \in \Gamma^1 \times \Gamma^2$ and $m \geq 0$,

$$Y^{ij,m+1} < Y^{ij,m}$$
 and $\bar{Y}^{ij,|\Gamma_2|m} < Y^{ij,m} < \bar{Y}^{ij,m}$.

which implies that, for any $(i, j) \in \Gamma^1 \times \Gamma^2$ and $m \ge 0$,

$$v^{ij,m+1} < v^{ij,m} \text{ and } \bar{v}^{ij,|\Gamma_2|m} < v^{ij,m} < \bar{v}^{ij,m}.$$

Then, for any $(i,j) \in \Gamma^1 \times \Gamma^2$, the sequence $(v^{ij,m})_{m \geq 0}$ is decreasing and converges, by Dini's theorem, uniformly on compact subsets of $[0,T] \times \mathbb{R}^k$, to \bar{v}^{ij} since $\lim_{m \to \infty} \bar{v}^{ij,m}(t,x) = \bar{v}^{ij}(t,x)$, for any $(t,x) \in [0,T] \times \mathbb{R}^k$.

Step 2: The following estimate holds true: For any $t \leq T$, $(i, j) \in \Gamma^1 \times \Gamma^2$ and $m \geq 0$,

$$\mathbb{E}\left\{m\int_{t}^{T}\sum_{l\in(\Gamma^{2})^{-j}}\{Y_{s}^{ij,m}-Y_{s}^{il,m}-\bar{g}_{jl}(s,X_{s}^{t,x})\}^{+}ds\right\} \leq C(1+|x|^{p}),\tag{3.5}$$

and

$$\mathbb{E}\left\{m^2 \int_t^T \sum_{l \in (\Gamma^2)^{-j}} (\{Y_s^{ij,m} - Y_s^{il,m} - \bar{g}_{jl}(s, X_s^{t,x})\}^+)^2 ds\right\} \le C(1 + |x|^{2p}),\tag{3.6}$$

where p and the generic constant C are independent of m and x.

For later use, we first give a representation of $Y^{ij,m}$ as the optimal payoff of a switching problem. Indeed, let $\delta := (\tau_n, \zeta_n)_{n>0}$ be an admissible strategy of switching, i.e.,

- (a) $(\tau_n)_{n\geq 0}$ is an increasing sequence of stopping times such that $\mathbb{P}[\tau_n < T, \forall n \geq 0] = 0$;
- (b) $\forall n \geq 0, \zeta_n$ is a random variable with values in Γ^1 and \mathcal{F}_{τ_n} -measurable;
- (c) If $(A_s^{\delta})_{s\leq T}$ is the non-decreasing, **F**-adapted and RCLL process defined by

$$\forall s \in [0, T), \quad A_s^{\delta} = \sum_{n \ge 1} \underline{g}_{\zeta_{n-1}\zeta_n}(\tau_n, X_{\tau_n}^{t, x}) \mathbb{1}_{\{\tau_n \le s\}} \quad \text{ and } \quad A_T^{\delta} = \lim_{s \to T} A_s^{\delta},$$

then $\mathbb{E}[(A_T^{\delta})^2] < \infty$. The quantity A_T^{δ} stands for the switching cost at terminal time T when the strategy δ is implemented.

Next, with an admissible strategy $\delta := (\tau_n, \zeta_n)_{n \geq 0}$ we associate a piecewise constant process $a = (a_s)_{s \in [0,T]}$ defined by

$$a_s := \zeta_0 \mathbf{1}_{\{\tau_0\}}(s) + \sum_{j=1}^{\infty} \zeta_{j-1} \mathbf{1}_{]\tau_{j-1},\tau_j]}(s), \quad s \le T.$$
(3.7)

For any $s \ge \tau_0$, a_s is the mode indicator at time s of the system which is subject to control strategy δ . Note that there is a bijection between the processes a and the admissible strategies δ , therefore hereafter we indifferently write A^a or A^{δ} . This notation a for the indicator process shall be used in Section 4 to deal with the zero-sum switching game (see Theorem 4.1).

Finally, for any fixed $i \in \Gamma^1$ and a real constant $\theta \in [t, T]$, we denote by \mathcal{A}_{θ}^i the following set:

$$\mathcal{A}_{\theta}^{i}:=\Big\{\delta=(\tau_{n},\zeta_{n})_{n\geq0}\text{ admissible strategy such that }\tau_{0}=\theta\text{ and }\zeta_{0}=i\Big\}.$$

Now, for any $\delta = (\tau_n, \alpha_n)_{n\geq 0}$ (or equivalently a) which belongs to \mathcal{A}_{θ}^i , let us define the pair of processes $(U^{aj,m}, V^{aj,m})$ which belongs to $\mathcal{S}_d^2 \times \mathcal{H}^{2,d}$ and which solves the following BSDE (which is of non standard form):

$$U_s^{aj,m} = h^{a_T j}(X_T) + \int_s^T 1_{\{r \ge \tau_0\}} f^{aj,m}(r, X_r^{t,x}, U_r^{aj,m}, V_r^{aj,m}) dr - \int_s^T V_r^{aj,m} dB_r - \left(A_T^a - A_s^a\right), \ s \le T, \quad (3.8)$$

where, for any $s \geq \tau_0$ and $(\bar{y}, \bar{z}) \in \mathbb{R}^{1+d}$, $f^{aj,m}(s, X_s^{t,x}, \bar{y}, \bar{z})$ (resp. $f^{aj}(s, X_s^{t,x}, \bar{y}, \bar{z})$) is equal to

$$f^{\ell j,m}(s,X_s^{t,x},[(v^{kl,m}(s,X_s^{t,x}))_{(k,l)\in\Gamma^1\times\Gamma^2-\{(\ell,j)\}},\bar{y}],\bar{z})$$

(resp.

$$f^{\ell j}(s, X_s^{t,x}, [(v^{kl,m}(s, X_s^{t,x}))_{(k,l) \in \Gamma^1 \times \Gamma^2 - \{(\ell,j)\}}, \bar{y}], \bar{z}))$$

if at time s, $a(s) = \ell$. Let us point out that since a is admissible and then $\mathbb{E}[(A_T^{\delta})^2] < \infty$, the solution of equation (3.8) exists and is unique by an immediate change of variables. Furthermore, we have the following representation of $Y^{ij,m}$ (see e.g. [16, 18] for more details on this representation):

$$Y_{\theta}^{ij,m} = \operatorname{ess sup}_{a \in \mathcal{A}_{\theta}^{i}} \{ U_{\theta}^{a,j,m} - A_{\theta}^{a} \}, \ t \le \theta \le T.$$
(3.9)

The equality (3.9) differs from the one given in [18] and some other papers including [16]. However there is a lack in the previous papers which we correct here. Note that this is a minor point which does not affect the results in those papers ([5, 16, 18] etc.). The accurate relation is given in ([9], equation (9), pp. 2757) in the particular case when the generators do not depend on the components (\vec{v} , z) but this fact is irrelevant.

Finally note that the function $f^{\ell j,m}$ depends only on (\bar{y},\bar{z}) . However the representation (3.9) for $Y^{ij,m}$ still holds since the solution of system of reflected BSDEs (3.2) is unique and by (3.4). It follows that, for any $j,l \in \Gamma^2$ and $\theta \leq T$,

$$(Y_{\theta}^{ij,m} - Y_{\theta}^{il,m} - \bar{g}_{jl}(\theta, X_{\theta}^{t,x}))^{+} \le \operatorname{ess sup}_{a \in \mathcal{A}_{\theta}^{i}} (U_{\theta}^{aj,m} - U_{\theta}^{al,m} - \bar{g}_{jl}(\theta, X_{\theta}^{t,x}))^{+}. \tag{3.10}$$

We now examine the quantity $(U_{\theta}^{aj,m} - U_{\theta}^{al,m} - \bar{g}_{jl}(\theta, X_{\theta}^{t,x}))^+$. Define the set \mathcal{B}_{jl} as follows:

$$\mathcal{B}_{jl} = \{(s,\omega) \in [0,T] \times \Omega, \text{ such that } U_s^{aj,m} - U_s^{al,m} - \bar{g}_{jl}(s,X_s^{t,x}) > 0\}$$

and, for any $s \in [0, T]$,

Then, by Itô-Tanaka's formula, we have, for every $s \in [\theta, T]$,

$$\begin{split} (W_s^{a,jl,m})^+ + & \frac{1}{2} \int_s^T dL_r^{a,jl,m} + m \int_s^T dr \{ \sum_{j'' \neq j} \mathbf{1}_{\mathcal{B}_{jl}(r)} (W_r^{a,jj'',m})^+ - \sum_{j'' \neq l} \mathbf{1}_{\mathcal{B}_{jl}}(r) (W_r^{a,lj'',m})^+ \} \\ &= \int_s^T \mathbf{1}_{\mathcal{B}_{jl}}(r) \{ f^{aj}(r, X_r^{t,x}, U_r^{aj,m}) - f^{al}(r, X_r^{t,x}, U_r^{al,m}) - \alpha^{jl}(r) \} dr \\ &- \int_s^T \mathbf{1}_{\mathcal{B}_{jl}}(r) (V_r^{aj,m} - V_r^{al,m} - \beta^{jl}(r)) dB_r \end{split}$$

where, the process $L^{a,jl,m}$ is the local time at 0 of the semimartingale $W^{a,jl,m}$. Splitting the difference

$$\Delta_{a,jl,m}(r) := m \sum_{j'' \neq j} \mathbf{1}_{\mathcal{B}_{jl}}(r) (W_r^{a,jj'',m})^+ - m \sum_{j'' \neq l} \mathbf{1}_{\mathcal{B}_{jl}}(r) (W_r^{a,lj'',m})^+$$

as

$$\Delta_{a,jl,m}(r) = m \mathbf{1}_{\mathcal{B}_{jl}}(r) (W_r^{a,jl,m})^+ - \mathbf{1}_{\mathcal{B}_{jl}}(r) (W_r^{a,lj,m})^+ + m \sum_{j^* \neq j,l} \mathbf{1}_{\mathcal{B}_{jl}}(r) \{ (W_r^{a,jj'',m})^+ - (W_r^{a,lj'',m})^+ \},$$

the previous formula can be rewritten as follows: $\forall s \in [\theta, T]$,

$$(W_{s}^{a,jl,m})^{+} + \frac{1}{2} \int_{s}^{T} dL_{r}^{a,jl,m} + m \int_{s}^{T} \mathbf{1}_{\mathcal{B}_{jl}}(r) (W_{r}^{a,jl,m})^{+} dr$$

$$= \int_{s}^{T} \mathbf{1}_{\mathcal{B}_{jl}}(r) (f^{aj}(r, X_{r}^{t,x}, U_{r}^{aj,m}, V_{r}^{aj,m}) - f^{al}(r, X_{r}^{t,x}, U_{r}^{al,m}, V_{r}^{al,m}) - \alpha^{jl}(r)) dr + m \int_{s}^{T} \mathbf{1}_{\mathcal{B}_{jl}}(r) (W_{r}^{a,lj,m})^{+} dr$$

$$- \int_{s}^{T} \mathbf{1}_{\mathcal{B}_{jl}}(r) (V_{r}^{aj,m} - V_{r}^{al,m} - \beta^{jl}(r)) dB_{r} - m \int_{s}^{T} dr \{ \sum_{j'' \neq j,l} \mathbf{1}_{\mathcal{B}_{jl}(r)} [(W_{r}^{a,j'',m})^{+} - (W_{r}^{a,lj'',m})^{+}] \}.$$

$$(3.12)$$

But by (H5)-(i), one has $\bar{g}_{jl}(t,x) + \bar{g}_{lj}(t,x) > \bar{g}_{jj}(t,x) = 0$. Thus, we obtain that, for every $(t,x) \in [0,T] \times \mathbb{R}^k$,

$$\{y \in \mathbb{R}^m, \ y_j - y_l - \bar{g}_{jl}(t, x) \ge 0\} \cap \{y \in \mathbb{R}^m, \ y_l - y_j - \bar{g}_{lj}(t, x) \ge 0\} = \emptyset,$$

from which we deduce that

Relying next on the elementary inequality $a^+ - b^+ \leq (a - b)^+$ $(a, b \in \mathbb{R})$, it holds

$$\mathbf{1}_{\mathcal{B}_{jl}(r)}[(W_r^{a,jj^{"},m})^{+} - (W_r^{a,lj^{"},m})^{+}] \le \mathbf{1}_{\mathcal{B}_{jl}}(r) \left(U_r^{al,m} - U_r^{aj,m} - \bar{g}_{lj''}(r, X_r^{t,x}) + \bar{g}_{jj''}(r, X_r^{t,x}) \right)^{+}. \tag{3.14}$$

Using here that the family of penalty costs satisfies: \bar{g}_{jj} $< \bar{g}_{jl} + \bar{g}_{lj}$ we deduce that

Going back now to (3.12), applying Itô's formula to $e^{-ms}(W_s^{a,jl,m})^+$ and taking into account of (3.13), (3.14) and (3.15) to obtain: $\forall s \in [\theta, T]$,

$$(W_s^{a,jl,m})^+ \leq \int_s^T \mathbf{1}_{\mathcal{B}_{jl}}(r)e^{-m(r-s)} (f^{aj}(r, X_r^{t,x}, U_r^{aj,m}, V_r^{aj,m}) - f^{al}(r, X_r^{t,x}, U_r^{al,m}, V_r^{al,m}) - \alpha^{jl}(r))dr$$

$$- \int_s^T \mathbf{1}_{\mathcal{B}_{jl}}(r)e^{-m(r-s)} (V_r^{aj,m} - V_r^{al,m} - \beta^{jl}(r))dB_r.$$

Making now use of the estimates given in Assumptions (H0)-(H5) (namely the polynomial growth of both the drivers f^{ij} and of the penalty costs \bar{g}_{ij}) and taking the conditional expectation, we obtain: $\forall s \in [\theta, T]$,

Recall now (3.10) and (3.11) to obtain

$$m(Y_{\theta}^{ij,m} - Y_{\theta}^{il,m} - \bar{g}_{jl}(\theta, X_{\theta}^{t,x}))^{+} \le C\mathbb{E}[(1 + \sup_{r \le T} |X_{r}^{t,x}|^{p})|\mathcal{F}_{\theta}].$$
 (3.16)

Taking expectation in both hand-sides and integrating in $\theta \in [t, T]$ to obtain (3.5). Next by squaring each side of the previous inequality, taking expectation and finally using Doob's inequality ([29], pp.54) we obtain:

$$m^{2}\mathbb{E}\left\{\sum_{l\neq j}((Y_{\theta}^{ij,m}-Y_{\theta}^{il,m}-\bar{g}_{jl}(\theta,X_{\theta}^{t,x}))^{+})^{2}\right\} \leq C(1+|x|^{2p}), \quad \forall \theta \leq T$$
(3.17)

since $X^{t,x}$ has moments of any order by (2.5). Now as θ is arbitrary in [t,T] then, once more by integration with respect to θ in the previous inequality, we obtain (3.6).

Step 3: We now prove that for any $(t_0, x_0) \in [0, T] \times \mathbb{R}^k$ and $(i, j) \in \Gamma^1 \times \Gamma^2$,

$$L^{ij}(\vec{v})(t_0, x_0) \le \bar{v}^{ij}(t_0, x_0) \le U^{ij}(\vec{v})(t_0, x_0). \tag{3.18}$$

We just need to check the property for $t_0 < T$ since by the consistency condition (see (H3)), those inequalities hold true for $t_0 = T$.

We first claim that $\bar{v}^{ij}(t_0, x_0) \geq L^{ij}(\vec{v})(t_0, x_0)$ holds. Indeed, by construction of the sequence $\vec{v}_m := (\bar{v}^{ij,m})_{(i,j)\in\Gamma^1\times\Gamma^2}$ (proof of Theorem 2.1, Section 2), one has $\bar{v}^{ij,m}(t_0, x_0) \geq L^{ij}(\vec{v}_m)(t_0, x_0)$. Therefore, taking the limit w.r.t. m, we obtain $\bar{v}^{ij}(t_0, x_0) \geq L^{ij}(\vec{v})(t_0, x_0)$.

We now show that $\bar{v}^{ij}(t_0, x_0) \leq U^{ij}(\vec{v})(t_0, x_0)$. First, assume that $\bar{v}^{ij}(t_0, x_0) > L^{ij}(\vec{v})(t_0, x_0)$. Then, relying on the viscosity subsolution property of \bar{v}^{ij} yields

which implies that

$$\max\Bigl\{(\bar{v}^{ij}-U^{ij}(\vec{\bar{v}}))(t_0,x_0); -\partial_t \bar{v}^{ij}(t_0,x_0) - \mathcal{L}^X(\bar{v}^{ij})(t_0,x_0) - f^{ij}(t_0,x_0,(\bar{v}^{kl}(t_0,x_0))_{(k,l)\in\Gamma^1\times\Gamma^2}))\Bigr\} \leq 0.$$

Hence, $(\bar{v}^{ij} - U^{ij}(\vec{v}))(t_0, x_0) \leq 0$.

Suppose now that, at (t_0, x_0) , we have: $\bar{v}^{ij}(t_0, x_0) = L^{ij}(\bar{v})(t_0, x_0)$. Proceeding by contradiction we suppose in addition that

$$\exists \epsilon > 0, \quad (\bar{v}^{ij} - U^{ij}(\bar{v}))(t_0, x_0) > \epsilon. \tag{3.19}$$

Using both the continuity of $(t,x) \mapsto \bar{v}^{ij}(t,x)$ and $(t,x) \mapsto U^{ij}(\bar{v})(t,x)$ as well as the uniform convergence on compact subsets of $(v^{ij,m})_{m\geq 0}$ to \bar{v}^{ij} , we claim that for some strictly positive ρ and for m_0 large enough it holds that

$$\forall m \geq m_0, \ \forall (t, x) \in \mathcal{B}((t_0, x_0), \rho), \quad (v^{ij, m} - U^{ij}(\vec{v}_m))(t, x) \geq \frac{\epsilon}{2},$$

with $\mathcal{B}((t_0, x_0), \rho) = \{(t, x) \in [0, T] \times \mathbb{R}^k \text{ s.t. } |t - t_0| \le \rho, |x - x_0| \le \rho\}.$

Without loss of generality we can now assume $[t_0, t_0 + \rho] \subset [t_0, T]$. Let $(t, x) \in \mathcal{B}((t_0, x_0), \rho)$. By the definition of $U^{ij}(\vec{v}_m)$ and as Γ^2 is finite, there exists one index $l_0 \neq j$ (which may depend on (t, x)) such that

By summing over $l \in (\Gamma^1)^{-i}$, we deduce that for any $(t, x) \in \mathcal{B}((t_0, x_0), \rho)$,

Let us now introduce the following stopping time τ_X :

We then have, for all $m \geq m_0$,

as $m \to \infty$. But, this is contradictory to (3.5). Then $\bar{v}^{ij}(t_0, x_0) \leq U^{ij}(\bar{v})(t_0, x_0)$ and the proof of the claim is complete.

Step 4: Finally, using inequality (3.18) and Theorem 6.2 in [14] (Theorem 6.3 in appendix (A2)), we deduce that for any fixed $(i, j) \in \Gamma^1 \times \Gamma^2$, \bar{v}^{ij} is continuous and of polynomial growth and also a viscosity solution of

\max \left\{ (\bar{v}^{ij} - U^{ij}(\vec{v}))(t, x); \min \left\{ (\bar{v}^{ij} - L^{ij}(\vec{v}))(t, x); \\
-\partial_t \bar{v}^{ij}(t, x) - \mathcal{L}^X(\bar{v}^{ij})(t, x) - f^{ij}(t, x, (\bar{v}^{kl}(t, x))_{(k, l) \in \Gamma^1 \times \Gamma^2}, \sigma(t, x)^\top D_x \bar{v}^{ij}(t, x)) \right\} \right\} = 0, \\
\bar{v}^{ij}(T, x) = h^{ij}(x).
\end{cases} (3.22)$$

Thus $(\bar{v}^{ij})_{(i,j)\in\Gamma^1\times\Gamma^2}$ is also a solution for the multi-dimensional system (2.8) and then, by uniqueness of the solution of (2.8) in Π_g , we have $\bar{v}^{ij} = \underline{v}^{ij}$ for any $(i,j)\in\Gamma^1\times\Gamma^2$, which completes the proof.

Remark 3.3. The result of Theorem 3.2 is still valid if (H0)-(H4) are in force and the functions $(\underline{g}_{ij})_{(i,j)\in\Gamma^1\times\Gamma^2}$ verify (H5) since, by symmetry, one can go through the decreasing scheme (2.9) to the increasing one (2.10) and conversely.

Next, let us introduce the following family of processes $(Y^{ij})_{(i,j)\in\Gamma^1\times\Gamma^2}$ defined through the common solution $(v^{ij})_{(i,j)\in\Gamma^1\times\Gamma^2}$ of the min-max and max-min systems as follows: $\forall s \leq T$ and $(i,j)\in\Gamma^1\times\Gamma^2$,

$$Y_s^{ij} = v^{ij}(s \lor t, X_{s \lor t}^{t,x}). \tag{3.23}$$

We are going to show that the backward SDE counterpart of system (2.7) (or (2.8)) has a unique global solution. Actually, we have:

Theorem 3.4. Assume that Assumptions (H0)-(H5) are fulfilled. Then there exist processes $(Z^{ij})_{(i,j)\in\Gamma^1\times\Gamma^2}$, $(K^{ij,+})_{(i,j)\in\Gamma^1\times\Gamma^2}$ and $(K^{ij,-})_{(i,j)\in\Gamma^1\times\Gamma^2}$ which belong respectively to $\mathcal{H}^{2,d}_t$, \mathcal{A}^2_t and \mathcal{A}^2_t (which depend on (t,x) and which we omit to precise) such that the family $(Y^{ij}, Z^{ij}, K^{ij,+}, K^{ij,-})_{(i,j)\in\Gamma^1\times\Gamma^2}$ is a solution of the following doubly reflected BSDEs (DRBSDE in short) with bilateral interconnected obstacles: For any $(i,j)\in\Gamma^1\times\Gamma^2$ and $s\in[t,T]$,

$$\begin{cases} dY_s^{ij} = -f^{ij}(s, X_s^{t,x}, \vec{Y}_s, Z_s^{ij})ds + dK_s^{ij,-} - dK_s^{ij,+} - Z_s^{ij}dB_s ; Y_T^{ij} = h^{ij}(X_T^{t,x}); \\ Y_s^{ij} \leq U_s^{ij}(\vec{Y}) \ and \ Y_s^{ij} \geq L_s^{ij}(\vec{Y}) ; \\ \int_t^T (Y_s^{ij} - U_s^{ij}(\vec{Y}))dK_s^{ij,-} = 0 \ and \ \int_t^T (L_s^{ij}(\vec{Y}) - Y_s^{ij})dK_s^{ij,+} = 0 \end{cases}$$

$$(3.24)$$

where, for each $(i,j) \in \Gamma^1 \times \Gamma^2$, the lower (resp. upper) interconnected obstacle $L^{ij}(\vec{Y})$ (resp. $U^{ij}(\vec{Y})$) is defined by: $\forall s \in [t,T]$,

$$L_s^{ij}(\vec{Y}) = \max_{k \in (\Gamma^1)^{-i}} \{ Y_s^{kj} - g_{:k}(s, X_s^{t,x}) \} \ (resp.\ U_s^{ij}(\vec{Y}) = \min_{l \in (\Gamma^2)^{-j}} \{ Y_s^{il} + \bar{g}_{jl}(s, X_s^{t,x}) \}).$$

This solution is unique in the following sense: If $(\bar{Y}^{ij}, \bar{Z}^{ij}, \bar{K}^{ij,+}, \bar{K}^{ij,-})_{(i,j)\in\Gamma^1\times\Gamma^2}$ is another solution of (3.24) then for any $(i,j)\in\Gamma$, $Y^{ij}=\bar{Y}^{ij}$, $Z^{ij}=\bar{Z}^{ij}$ and $K^{ij,+}-K^{ij,-}=\bar{K}^{ij,+}-\bar{K}^{ij,-}$.

Proof: It is postponed to Appendix (A1) relegated to the end of this paper.

4. The min-max (or max-min) solution as the value of the zero-sum switching game

In this section, our objective is to study the link of the solution $(v^{ij})_{(i,j)\in\Gamma^1\times\Gamma^2}$ of both the min-max and maxmin system with the values of an explicit switching game. To do this, we shall deeply rely on the representation (3.23) in terms of the solution $(Y^{ij})_{(i,j)\in\Gamma^1\times\Gamma^2}$ of the general DRBSDE given in Theorem 3.4.

So once for all in this section, we suppose that Assumptions (H0)-(H5) hold. On the other hand we assume that:

(H6):

For any $(i,j) \in \Gamma^1 \times \Gamma^2$, the function f^{ij} does not depend on (\vec{y}, z^{ij}) .

4.1. Description of the zero-sum switching game

Assume we have two players π_1 and π_2 who intervene on a system (e.g. the production of energy from several sources such as oil, cole, hydro-electric, etc.) with the help of switching strategies. An admissible switching strategy for π_1 (resp. π_2) is a sequence $\delta := (\sigma_n, \xi_n)_{n \geq 0}$ (resp. $\nu := (\tau_n, \zeta_n)_{n \geq 0}$) where for any $n \geq 0$,

- (i) σ_n (resp. τ_n) is an **F**-stopping times such that \mathbb{P} -a.s., $\sigma_n \leq \sigma_{n+1} \leq T$ (resp. $\tau_n \leq \tau_{n+1} \leq T$);
- (ii) ξ_n (resp. ζ_n) is a random variable with values in Γ^1 (resp. Γ^2) which is \mathcal{F}_{σ_n} (resp. \mathcal{F}_{τ_n})-measurable;
- (iii) $\mathbb{P}[\sigma_n < T, \forall n \ge 0] = \mathbb{P}[\tau_n < T, \forall n \ge 0] = 0$;
- (iv) If $(A_s^{\delta})_{s\leq T}$ and $(B_s^{\nu})_{s\leq T}$ are the **F**-adapted RCLL processes defined by:

$$\forall \, s \in [t,T), \quad A_s^{\delta} = \sum_{n \geq 1} \underline{g}_{\xi_{n-1}\xi_n}(\sigma_n, X_{\sigma_n}^{t,x}) \mathbf{1}_{[\sigma_n \leq s]} \quad \text{ and } \quad A_T^{\delta} = \lim_{s \to T} A_s^{\delta},$$

and

$$\forall s \in [t, T), \quad B_s^{\nu} = \sum_{n \ge 1} \bar{g}_{\zeta_{n-1}\zeta_n}(\tau_n, X_{\tau_n}^{t,x}) 1_{[\tau_n \le s]} \quad \text{ and } \quad B_T^{\nu} = \lim_{s \to T} B_s^{\nu}$$

then $\mathbb{E}[(A_T^{\delta})^2 + (B_T^{\nu})^2] < \infty$. For any $s \leq T$, A_s^{δ} (resp. B_s^{ν}) is the cumulative switching cost at time s for π_1 (resp. π_2) when she implements the strategy δ (resp. ν).

Next let $(i,j) \in \Gamma$ and $t \in [0,T]$ be fixed. We say that the admissible switching strategy $\delta := (\sigma_n, \xi_n)_{n \geq 0}$ (resp. $\nu := (\tau_n, \zeta_n)_{n \geq 0}$) of π_1 (resp. π_2) belongs to $\mathcal{A}^i_{\pi_1}(t)$ (resp. $\mathcal{A}^j_{\pi_2}(t)$) if $\sigma_0 = t$, $\xi_0 = i$ (resp. $\tau_0 = t$, $\xi_0 = j$).

Given an admissible strategy δ (resp. ν) of π_1 (resp. π_2), one associates a stochastic process $(a_s)_{s \leq T}$ (resp. $(b_s)_{s \leq T}$) which indicates along with time the current mode of π_1 (resp. π_2) and which is defined by:

$$\forall s \leq T, \ a_s = \xi_0 1_{\{\sigma_0\}}(s) + \sum_{n \geq 1} \xi_{n-1} 1_{]\sigma_{n-1},\sigma_n]}(s) \ (\text{resp. } b_s = \zeta_0 1_{\{\tau_0\}}(s) + \sum_{n \geq 1} \zeta_{n-1} 1_{]\tau_{n-1},\tau_n]}(s)). \tag{4.1}$$

Let now $\delta = (\sigma_n, \xi_n)_{n\geq 0}$ (resp. $\nu = (\tau_n, \zeta_n)_{n\geq 0}$) be an admissible strategy for π_1 (resp. π_2) which belongs to $\mathcal{A}^i_{\pi_1}(t)$ (resp. $\mathcal{A}^j_{\pi_2}(t)$). The interventions of the players are not free and generate a payoff which is a reward (resp. cost) for π_1 (resp. π_2) and whose expression is given by

$$J_t(\delta, \nu) := \mathbb{E}[h^{a_T b_T}(X_T^{t, x}) + \int_t^T f^{a_r b_r}(r, X_r^{t, x}) dr - A_T^{\delta} + B_T^{\nu} | \mathcal{F}_t]. \tag{4.2}$$

When the system is in (i, j) at the initial time $t \in [0, T]$, we define the upper (resp. lower) value of the game by

$$\bar{V}_t^{ij} := \text{ess inf}_{\nu \in \mathcal{A}_{\pi_2}^i(t)} \text{ess sup}_{\delta \in \mathcal{A}_{\pi_1}^i(t)} J_t(\delta, \nu) \text{ (resp. } \underline{V}_t^{ij} = \text{ess sup}_{\delta \in \mathcal{A}_{\pi_1}^i(t)} \text{ess inf}_{\nu \in \mathcal{A}_{\pi_2}^j(t)} J_t(\delta, \nu)).$$

The game has a value if $\bar{V}_t^{ij} = \underline{V}_t^{ij}$ and finally, we say that the game has a saddle-point if there exists a pair of admissible strategies $(\delta^*, \nu^*) \in \mathcal{A}_{\pi_1}^i(t) \times \mathcal{A}_{\pi_2}^j(t)$ such that for any δ and ν , it holds

$$J_t(\delta, \nu^*) \le J_t(\delta^*, \nu^*) \le J_t(\delta^*, \nu). \tag{4.3}$$

As previously mentionned, we are going to study the link between the solution $(v^{ij})_{(i,j)\in\Gamma^1\times\Gamma^2}$ of (2.7) and the upper and lower values \bar{V}_t^{ij} , \underline{V}_t^{ij} of the zero-sum switching game.

Theorem 4.1. Suppose that Assumptions (H0)-(H6) are in force. Then the processes $(Y^{ij})_{(i,j)\in\Gamma^1\times\Gamma^2}$ of the unique solution of the doubly reflected BSDE (3.24) satisfy

Proof: Let us consider two families of auxiliary processes $(\hat{U}^{\delta j})_{j\in\Gamma^2}$ and $(\hat{U}^{i\nu})_{i\in\Gamma^1}$ associated with admissible strategy $\delta\in\mathcal{A}^i_{\pi_1}(t)$ and $\nu\in\mathcal{A}^j_{\pi_2}(t)$ and defined by: $\forall j\in\Gamma^2$,

These equations are actually not of standard form, but once more by a change of variables, one verifies that both $(\hat{U}^{\delta j} - A^{\delta})_{j \in \Gamma^2}$ and $(U^{i\nu} + B^{\nu})_{i \in \Gamma^1}$ solve standard multi-dimensional RBSDEs system which have a unique solution. On the other hand, let us point out that thanks to the connection between the standard switching problem and multi-dimensional RBSDE with upper (resp. lower) interconnected obstacles (see e.g. [9] or [18]) the family $(\hat{U}^{\delta j} - A^{\delta})_{j \in \Gamma^2}$ (resp. $(U^{i\nu} + B^{\nu})_{i \in \Gamma^1}$) of processes verifies:

In order to prove (4.4), it is enough to establish the following:

In the sequel, we only prove the first inequality in (4.8) since the second one can be obtained by symmetry comparing Y_t^{ij} to $U_t^{i\nu} + B_t^{\nu}$ for an arbitrary ν .

So let us consider, on the time interval [t,T], the penalized decreasing scheme introduced in (3.2). The processes

As already mentioned, we know that, for any $(i,j) \in \Gamma^1 \times \Gamma^2$, $Y^{ij,m} \to_m Y^{ij}$ in \mathcal{S}_t^2 .

Next fix $(i_0, j_0) \in \Gamma^1 \times \Gamma^2$ and let us show that $Y_t^{i_0 j_0} \ge \hat{U}_t^{\delta j_0} - A_t^{\delta}$ for any $\delta = (\sigma_l, \xi_l)_{l \ge 0}$ in $\mathcal{A}_{\pi_1}^{i_0}(t)$. So let us define the processes $(Y^{\delta j, m})_{j \in \Gamma^2}$ and $(\hat{U}^{\delta j, m})_{j \in \Gamma^2}$ as follows:

On the other hand, at time $0 < \sigma_l < T$, $Y^{\delta j,m}$ has a jump which is equal to $Y^{\xi_l j,m}_{\sigma_l} - Y^{\xi_{l-1} j,m}_{\sigma_l}$.

(ii) The processes $(\hat{U}^{\delta j,m})_{j\in\Gamma^2}$ are defined as the solution in $\mathcal{S}^2_{t,d}$ of the following non standard multi-dimensional BSDE: $\forall i \in \Gamma^2$,

Note that $(\hat{U}^{\delta j,m} + A^{\delta})_{j \in \Gamma^2}$ is a solution of a standard multi-dimensional BSDE whose coefficient is Lipschitz. As those latter processes exist, then so are $(\hat{U}^{\delta,j,m})_{j \in \Gamma^2}$. On the other hand, as for the system given in (4.9), the sequence of processes $((\hat{U}^{\delta j,m})_{j \in \Gamma^2})_{m \geq 0}$ converges in $\mathcal{S}^2_{t,d}$ toward $(\hat{U}^{\delta j})_{j \in \Gamma^2}$.

We now prove the following: for any $m \geq 0$ and $j \in \Gamma^2$,

This equation implies also that $\mathbb{E}[(\tilde{A}_T^{\delta j,m})^2]<\infty.$

Let us now introduce the sequence of processes $((Y^{\delta j,m,k},Z^{\delta j,m,k})_{j\in\Gamma^2})_{k\geq 0}$ (m is fixed) defined by Picard type iterations as follows:

- (a) For any $j\in\Gamma^2$ and $s\in[t,T],\,(Y_s^{\delta j,m,0},Z_s^{\delta j,m,0})=(\hat{U}_s^{\delta j,m},\hat{V}_s^{\delta j,m})$;

First note that those backward equations are decoupled and the processes $(Y^{\delta j,m,k},Z^{\delta j,m,k})$ are well defined by an obvious change of variables. Next by the one dimensional comparison theorem [13] one has $Y^{\delta j,m,k} \geq \hat{U}^{\delta j,m}$ and $Y^{\delta j,m,k} \geq Y^{\delta j,m,k-1}$, $k \geq 1$ and $j \in \Gamma^2$. This last inequality is obtained by induction since for any $q \neq j$, the mapping $y_q \in \mathbb{R} \mapsto -m \sum_{l \neq j} \left(y_j - y_l - \bar{g}_{jl}(r, X_r^{t,x})\right)^+$ is non-decreasing when the other variable are fixed. Finally since the coefficients of the BSDEs of (4.15) are Lipschitz then for any $j \in \Gamma^2$, the sequence $(Y^{\delta j,m,k}, Z^{\delta j,m,k})_{k\geq 0}$ converges in $\mathcal{S}^2_{t,d} \times \mathcal{H}^{2,d}_t$ to a limit $(\bar{Y}^{\delta j,m}, \bar{Z}^{\delta j,m})$ which satisfies: $\forall j \in \Gamma^2$,

But the solution of (4.14) is unique then for any $j \in \Gamma^2$,

Similarly as above and introducing first the sequence $(U^{i\nu,n})_{n\geq 0}$ such that, for any n, $U^{i\nu,n}$ is obtained from $U^{i\nu}$ (defined in (4.6)) by penalization of the lower barrier, one can prove that

by comparing the two penalized equations solved by $\underline{Y}^{ij,n}$ and $U^{i\nu,n}$. Next, relying on the fact that $(\underline{Y}^{ij,n})$ is related to the increasing penalized scheme (converging to Y^{ij}) one gets

The point now is which kind of additional assumptions should we add in order to have equalities in (4.4) and then the game has a value. The response to this question is affirmative if we moreover assume that the utilities f_{ij} and h_{ij} are separated with respect to i and j, i.e., if they satisfy the following assumption:

(H7): the two families $(f^{ij})_{(i,j)\in\Gamma^1\times\Gamma^2}$ and $(h^{ij})_{(i,j)\in\Gamma^1\times\Gamma^2}$ of functions satisfy, for any $(i,j)\in\Gamma^1\times\Gamma^2$,

 and $h^{ij} := h_1^i + h_2^j$.

Once more we recall that we work under the assumptions (H0)-(H7). So let us consider the following system of reflected BSDEs with one interconnected lower (resp. upper) obstacles associated with

Under assumptions (H3)-(H4), equations (4.19) and (4.20) have unique solutions (see e.g. [16], Prop. 5.1, pp.188). We then have:

Proposition 4.2. Suppose Assumptions (H0)-(H7) are satisfied. Then for any $(i, j) \in \Gamma^1 \times \Gamma^2$,

Proof: Let us first deal with the first point. For $(i,j) \in \Gamma^1 \times \Gamma^2$, let $\underline{Y}^{ij} = Y^{1,i} + Y^{2,j}$, $\underline{Z}^{ij} = Z^{1,i} + Z^{2,j}$, $\underline{K}^{ij,+} = K^{1,i}$ and $\underline{K}^{ij,-} = K^{2,j}$. Then by (4.19) and (4.20) it is easily seen that $(\underline{Y}^{ij}, \underline{Z}^{ij}, \underline{K}^{ij,+}, \underline{K}^{ij,-})$ is also a solution for the DRBSE (3.24). As the solution of this latter is unique then $Y^{ij} = \underline{Y}^{ij} = Y^{1,i} + Y^{2,j}$.

We now focus on the second point. First note that under the condition of separation of the utilities f^{ij} and h^{ij} , for any $\delta \in \mathcal{A}^i_{\pi_1}(t)$ and $\nu \in \mathcal{A}^j_{\pi_2}(t)$ we have

and by (4.4) we obtain $\underline{V}_t^{ij} = \bar{V}_t^{ij} = Y_t^{ij} = v^{ij}(t,x)$.

Next the link between the solution of the BSDE (4.19) (resp. (4.20)) and the standard switching problem implies that (one can see [16] or Step 2 of the proof of Theorem 3.2 for more details):

Then δ^* (resp. ν^*) is admissible and optimal i.e., belongs to $\mathcal{A}_{\pi_1}^i(t)$ (resp. $\mathcal{A}_{\pi_2}^j(t)$) and verifies

(see [16] for more details). Therefore

for any $\delta \in \mathcal{A}_{\pi_1}^i(t)$ and $\nu \in \mathcal{A}_{\pi_2}^j(t)$, which means that (δ^*, ν^*) is a saddle-point for the zero-sum switching game.

Remark 4.3. Under (H0)-(H7), we also have the following relation: $\forall (i,j) \in \Gamma^1 \times \Gamma^2$,

5. Conclusion

In this paper, we have given appropriate conditions on the data of both the min-max and max-min systems so that their respective unique viscosity solutions coincide. These unique continuous viscosity solution have been constructed by means of a penalization procedure in the recent paper [8]. The main difficulty faced in that paper is that the two obstacles are interconnected and therefore not comparable. For this reason and without the comparison of the two barriers, we cannot apply the classical relationship between doubly reflected

BSDEs, system of PDEs with lower and upper obstacles and the underlying game (see e.g. [14]). By providing appropriate regularity conditions so that comparison holds, the viscosity solutions of the min-max and max-nin systems coincide. Finally, under further conditions on the drivers, this unique solution of the doubly reflected BSDE (3.24) is related and interpreted as the value function of a switching game.

Since we also make use of the uniqueness of the viscosity solution of both the max-min and min-max systems to justify the uniqueness for the doubly reflected BSDE (3.24), our analysis deeply relies on the Markovian setting, therefore it seems quite natural to ask whether one can study the switching game in the general non-Markovian case. We leave this question for future research.

6. Appendix

(A1): Proof of Theorem 3.4

Let us recall that for any $m \geq 0$, the quadruple $(Y^{ij,m}, Z^{ij,m}, K^{ij,m,+}, K^{ij,m,-})_{(i,j)\in\Gamma^1\times\Gamma^2}$ of (3.2) verifies the following system of reflected BSDEs with one interconnected obstacle: $\forall s \in [0,T]$,

Let (i,j) in $\Gamma_1 \times \Gamma^2$ be fixed. For $m \ge 0$ and $s \in [0,T]$, let us set $\alpha_s^{ij,m} := \frac{dK_s^{ij,m-1}}{ds} 1_{[t,T]}(s)$. Then by estimate (3.6) we have

Next, the sequence $(Y^{ij,m})_{m\geq 0}$ converges in \mathcal{S}_t^2 to Y^{ij} . Actually, this stems from the uniform convergence of $(v^{ij,m})_{m\geq 0}$ to v^{ij} in compact sets of $[0,T]\times\mathbb{R}^k$, the definition (3.23) of Y^{ij} , estimate (2.5) and finally the polynomial growth of $v^{ij,m}$ and \bar{v}^{ij} which comes from inequalities (2.14).

Now and using a classical method (see e.g. [12], proof of Theorem 5.2 in Section 6) and since $(\alpha^{ij,m})_{m\geq 0}$ is uniformly bounded in \mathcal{H}_t^2 then using Itô's formula twice, respectively with $(Y^{ij,m})^2$ and $(Y^{ij,m} - Y^{ij,n})^2$, we deduce that:

(see [14], pp. 261-262 or appendix (A2)). But v^{ij} is also a solution of this latter, thus $v^{ij} = \tilde{v}^{ij}$ since the continuous solution with polynomial growth of (6.5) is unique. This uniqueness is due to polynomial growth of $f^{ij}(t,x,0,0)$ and $(v^{ij})_{(i,j)\in\Gamma^1\times\Gamma^2}$, and the continuity of $(t,x)\mapsto f^{ij}(t,x,y,z)$ unifromly w.r.t. (y,z). Then and for any $s\in[t,T]$, $Y^{ij}_s=\tilde{Y}^{ij}_s$. where for any $(i,j) \in \Gamma$, we initialize the scheme as follows: $Y^{ij,m,0} = \bar{Y}^{ij}$. First note that for any fixed $(i,j) \in \Gamma$ and $p \geq 0$, $(Y^{ij,m,p+1},Z^{ij,m,p+1},K^{ij,m,p+1})$ exists since it solves a standard reflected BSDE. Next and by comparison of solutions of reflected BSDEs [12], we have for any $(i,j) \in \Gamma$, $Y^{ij,m,1} \geq \bar{Y}^{ij}$. Referring then to equality (19), Section 4 in [9], the family $(Y^{ij,m,p})_{i\in\Gamma^1}$ is identified with the value of a standard switching problem with triple of data $(f^{ij,m},h^{ij},(\underline{g}_{ik})_{k\neq i})$ when only p switchings at most are permitted, i.e.,

$$Y_{t}^{ij,m,p} = \operatorname{ess sup}_{\{\delta = (\sigma_{k}, \, \xi_{k})_{k \geq 0} \in \mathcal{A}_{\pi_{1}}^{i}(t), \sigma_{p+1} = T\}} \mathbb{E} \left[\int_{t}^{\sigma_{p} \wedge T} \sum_{k=1,p} f^{\xi_{k-1}j,m}(s, X_{s}) \mathbf{1}_{\sigma_{k-1} \leq s < \sigma_{k}} ds - \sum_{k=1,p} \underline{g}_{\xi_{k-1},\xi_{k}}(\sigma_{k}, X_{\sigma_{k}}) \mathbf{1}_{\{\sigma_{k} < T\}} + \bar{Y}_{\sigma_{p}}^{\xi_{p-1}j} \mathbf{1}_{\{\sigma_{p} < T\}} + h^{a_{T}j}(X_{T}) \mathbf{1}_{\{\sigma_{p} = T\}} |\mathcal{F}_{t}|.$$

$$(6.8)$$

Taking now into account both the representation (6.8), Assumption (H5)-(ii) satisfied by f^{ij} and the fact that the penalty costs are non negative, one obtains the existence of a stochastic process W^{ij} such that for any (m, p) it holds

$$Y^{ij,m,p} < \bar{Y}^{ij,m} < W^{ij}.$$

Actually, it is enough to take

$$W_s^{ij} = \mathbb{E}[\int_s^T C(1+|X_r^{t,x}|^p)dr + \sum_{(k,l)\in\Gamma} \sup_{s\in[t,T]} |\bar{Y}_s^{kl}||\mathcal{F}_s], \ s\in[t,T]$$

where C is a constant appropriately choosen. Next in the same way as in ([18], Theorem 2.1), one can show that the sequence of processes $((Y^{ij,m,p},Z^{ij,m,p},K^{ij,m,p})_{(i,j)\in\Gamma^1\times\Gamma^2})_{p\geq 0}$ converges to $(Y^{ij,m},Z^{ij,m},K^{ij,m})_{(i,j)\in\Gamma^1\times\Gamma^2}$ which implies that $\bar{Y}^{ij,m}\geq \bar{Y}^{ij}$ for any $(i,j)\in\Gamma^1\times\Gamma^2$. But, in a symmetric way, one can show that $\bar{Y}^{ij}\geq \underline{Y}^{ij,n}$ for any $(i,j)\in\Gamma$. Take now the limit w.r.t to m and n in the previous inequalities to obtain $Y^{ij}\geq \bar{Y}^{ij}\geq Y^{ij}$ since $Y^{ij}=\lim_m \bar{Y}^{ij,m}=\lim_n \underline{Y}^{ij,n}$. Thus for any $(i,j)\in\Gamma$, $Y^{ij}=\bar{Y}^{ij}$. Next, comparing the martingale parts in the equation (6.6) solved by Y^{ij} and \bar{Y}^{ij} , we deduce that $Z^{ij}=\bar{Z}^{ij}$ and finally $K^{ij,+}-K^{ij,-}=\bar{K}^{ij,+}-\bar{K}^{ij,-}$ for any $(i,j)\in\Gamma$. Thus the solution of (6.6) is unique.

Remark 1. Since the interconnected barriers $U^{ij}_s(\vec{Y}) := \min_{l \neq j} \{Y^{il}_s + \bar{g}_{jl}(s, X^{t,x}_s)\}$ and $L^{ij}_s(\vec{Y}) := \max_{k \neq i} \{Y^{kj}_s + \underline{g}_{kj}(s, X^{t,x}_s)\}$ are not completely separated, then one cannot infer that the processes $K^{ij,+}$

and $K^{ij,-}$ of (6.6) are unique. But if we moreover require that $dK^{ij,+}$ and $dK^{ij,-}$ are singular then they are actually unique. Indeed, $dK^{ij,+} - dK^{ij,-}$ is a signed measure which has a unique decomposition into $d\lambda^{ij,+} - d\lambda^{ij,-}$, i.e., $dK^{ij,+} - dK^{ij,-} = d\lambda^{ij,+} - d\lambda^{ij,-}$ where $d\lambda^{ij,+}$ and $d\lambda^{ij,-}$ are non-negative singular measures. Therefore $dK^{ij,+} + d\lambda^{ij,-} = d\lambda^{ij,+} + dK^{ij,-}$. Then $d\lambda^{ij,+} \ll dK^{ij,+}$ and $d\lambda^{ij,-} \ll dK^{ij,-}$ which implies that $d\lambda^{ij,+}_s = a^{ij,+}_s dK^{ij,-}_s = a^{ij,-}_s dK^{ij,-}_s$. It follows that $(Y^{ij,+}_s - L^{ij}_s(\vec{Y}))d\lambda^{ij,+}_s = (Y^{ij}_s - L^{ij}_s(\vec{Y}))a^{ij,+}_s dK^{ij,+}_s = 0$ and similarly $(Y^{ij,-}_s - U^{ij}_s(\vec{Y}))d\lambda^{ij,-}_s = (Y^{ij}_s - U^{ij}_s(\vec{Y}))a^{ij,-}_s dK^{ij,-}_s = 0$.

(A2): PDEs with bilateral obstacles

Let $(t,x) \in [t,T] \times \mathbb{R}^k$ and $(X_s^{t,x})_{s \leq T}$ be the solution of the standard SDE given in (2.4) where the functions b and σ satisfy Assumption (H0). Let us now consider the following functions:

$$g: \quad x \in \mathbb{R}^k \longmapsto g(x) \mathbb{R}$$

$$f: \quad (t, x, y, z) \in [0, T] \times \mathbb{R}^{k+1+d} \longmapsto f(t, x, y, z) \in \mathbb{R}$$

$$H: \quad (t, x) \in [0, T] \times \mathbb{R}^k \longmapsto H(t, x) \in \mathbb{R}$$

$$L: \quad (t, x) \in [0, T] \times \mathbb{R}^k \longmapsto L(t, x) \in \mathbb{R}$$

We assume that all those functions are continuous and satisfy the following assumptions (A1)-(A2).

(A1): $\forall t \in [0,T], x \in \mathbb{R}^k, y, y' \in \mathbb{R}, z, z' \in \mathbb{R}^d,$

$$\begin{cases} \text{ (i) } |g(x)| + |f(t,x,0,0)| + |H(t,x)| + |L(t,x)| \le C(1+|x|^p), \\ \text{ (ii) } |f(t,x,y,z) - f(t,x,y',z')| \le C(|y-y'| + |z-z'|), \\ \text{ (iii) } L(t,x) \le H(t,x) \text{ and } L(T,x) \le g(x) \le H(T,x), \end{cases}$$

where C and p are some positive constants.

(A2): For each R > 0, there is a function Φ_R from \mathbb{R}^+ to \mathbb{R}^+ satisfying $\Phi_R(s) \to 0$ as $s \to 0$ and such that

$$|f(t,x,y,z) - f(t,x',y,z)| < \Phi_R((1+|z|)|x-x'|)$$
(6.9)

for all $t \in (0,T)$, |x|, |x'|, $|y| \le R$ and $z \in \mathbb{R}^d$.

The following lemma gives a link between Assumptions (A2) and (H1)-(i).

Lemma 6.1. If the function $(t,x) \in [0,T] \times \mathbb{R}^k \mapsto f(t,x,y,z) \in \mathbb{R}$ is continuous, uniformly w.r.t. (y,z), i.e., for any $(t,x) \in [0,T] \times \mathbb{R}^k$, for any $\varepsilon > 0$ there exists $\eta_{t,x,\varepsilon} > 0$ such that if $|(t',x') - (t,x)| < \eta_{t,x,\varepsilon}$ then $|f(t',x',y,z) - f(t,x,y,z)| < \varepsilon$, then assumption (A2) is satisfied with Φ_R , for any $R \geq 0$, given by

$$\forall \gamma \ge 0, \Phi_R(\gamma) := \sup_{|t-t'|+|x-x'| \le \gamma, t, t' \in [0,T], x, x' \in B'(0,R), |y| \le R, z \in \mathbb{R}^d} |f(t,x,y,z) - f(t',x',y,z)|$$

where $B'(0,R) := \{x \in \mathbb{R}^k, |x| \le R\}.$

Proof: Let R > 0 and $(t, x) \in [0, T] \times B'(0, R)$. Let $\varepsilon > 0$. By definition, there exists $\eta_{t,x,\varepsilon} > 0$ such that if $(t', x') \in B((t, x), \eta_{t,x,\varepsilon})$ (the open ball in $[0, T] \times \mathbb{R}^k$ with center (t, x) and radius $\eta_{t,x,\varepsilon}$) then

$$|f(t', x', y, z) - f(t, x, y, z)| < \varepsilon.$$

As

$$[0,T]\times B'(0,R)\subset \bigcup_{(t,x)\in [0,T]\times B'(0,R)}B((t,x),\frac{\eta_{t,x,\varepsilon}}{2})$$

then by compacity one can find finitely many points $(t_1, x_1), ..., (t_m, x_m)$ such that

$$[0,T] \times B'(0,R) \subset \bigcup_{i=1,m} B((t_i,x_i),\frac{\eta_{t_i,x_i,\varepsilon}}{2}).$$

(i) First note that the function $\gamma \in \mathbb{R}^+ \mapsto \Phi_R(\gamma)$ is non-decreasing and $\Phi_R(0) = 0$. Next let us set $\eta = \min_{i=1,m} \frac{\eta_{t_i,x_i,\varepsilon}}{3}$. Then $\eta > 0$ and we claim that $\Phi_R(\eta) \in \mathbb{R}^+$.

Indeed let $z \in \mathbb{R}^d$, $|y| \le R$ and (t, x), (t', x') elements of $[0, T] \times B'(0, R)$ such that $|t - t'| + |x - x'| \le \eta$. Then there exists $i \in \{1, ..., m\}$ such that $(t, x) \in B((t_i, x_i), \frac{\eta_{t_i, x_i, \varepsilon}}{2})$. It follows that

$$|(t', x') - (t_i, x_i)| \le |(t', x') - (t, x)| + |(t, x) - (t_i, x_i)| \le \eta + \frac{\eta_{t_i, x_i, \varepsilon}}{2} < \eta_{t_i, x_i, \varepsilon}$$

which implies that (t', x') belongs also to $B((t_i, x_i), \eta_{t_i, x_i, \varepsilon})$. Then by continuity we have

$$|f(t, x, y, z) - f(t', x', y, z)| \le |f(t, x, y, z) - f(t_i, x_i, y, z)| + |f(t_i, x_i, y, z) - f(t', x', y, z)| \le 2\varepsilon.$$

Taking the supremum to obtain that $\Phi_R(\eta) \leq 2\varepsilon$.

- (ii) As Φ_R is non-decreasing then $\Phi_R(\gamma) \leq 2\varepsilon$ for any $\gamma \leq \eta$. Note that this property implies also that $\Phi_R(\gamma) \to 0 = \Phi_R(0)$ as $\gamma \to 0$.
- (iii) For any γ_1 and γ_2 in \mathbb{R}^+ , $\Phi_R(\gamma_1 + \gamma_2) \leq \Phi_R(\gamma_1) + \Phi_R(\gamma_2)$.

Indeed let $z \in \mathbb{R}^d$, $|y| \le R$ and (t, x), (t', x') elements of $[0, T] \times B'(0, R)$ such that $|t - t'| + |x - x'| \le \gamma_1 + \gamma_2$. Then there exists $(\bar{t}, \bar{x}) \in [0, T] \times B'(0, R)$ such that $|(t, x) - (\bar{t}, \bar{x})| \le \gamma_1$ and $|(\bar{t}, \bar{x}) - (t', x')| \le \gamma_2$. Therefore

$$|f(t, x, y, z) - f(t', x', y, z)| \le |f(t, x, y, z) - f(\bar{t}, \bar{x}, y, z)| + |f(\bar{t}, \bar{x}, y, z) - f(t', x', y, z)| \le \Phi_R(\gamma_1) + \Phi_R(\gamma_2)$$

which implies that $\Phi_R(\gamma_1 + \gamma_2) \leq \Phi_R(\gamma_1) + \Phi_R(\gamma_2)$.

(iv) For any $\gamma \in \mathbb{R}^+$, $\Phi_R(\gamma) \in \mathbb{R}^+$ and $\Phi_R(.)$ verifies (6.9).

Indeed by induction and (iii), for any $\gamma \in \mathbb{R}^+$ and $n \geq 1$, $\Phi_R(n\gamma) \leq n\Phi_R(\gamma)$. On the other hand, by (ii) and (iii), for any $\gamma \in \mathbb{R}^+$ one can find an integer n such that $\Phi_R(\gamma) \leq n\Phi_R(\eta)$ which implies that $\Phi_R(\gamma) \in \mathbb{R}$. Finally (6.9) is obviously satisfied since $\Phi_R(.)$ is non-decreasing and

$$|f(t,x,y,z) - f(t,x',y,z)| < \Phi_R(|x-x'|)$$

for all $t \in (0,T)$, |x|, |x'|, $|y| \le R$ and $z \in \mathbb{R}^d$.

Remark 6.2. This property of continuity of the function $(t, x) \in [0, T] \times \mathbb{R}^k \mapsto f(t, x, y, z) \in \mathbb{R}$, uniformly w.r.t. (y, z), is needed to get uniqueness of the viscosity solution of the PDE (6.11). However one can obtain uniqueness of (6.11) with a substantially weaker condition than the previous one.

Now for $(t,x) \in [t,T] \times \mathbb{R}^k$, let $Y^{t,x} := (Y^{t,x}_s)_{s \in [0,T]}$ be the local solution of the BSDE associated with the quadruple $(f(s,X^{t,x}_s,y,z),g(X^{t,x}_T),L(s,X^{t,x}_s),H(s,X^{t,x}_s))$ (see [14] for more details) and let us set $u(t,x) = Y^{t,x}_t$. Then u(t,x) is an \mathbb{R} -valued deterministic function of (t,x) which is morever of polynomial growth and continuous. Furthermore it satisfies:

$$\forall (t,x) \in [0,T] \times \mathbb{R}^k, \ \forall s \in [t,T], \ Y_s^{t,x} = u(s, X_s^{t,x}). \tag{6.10}$$

Let us now consider the following PDE with two obstacles of min-max type whose solutions will be considered in viscosity sense:

$$\begin{cases}
\min \left\{ v(t,x) - L(t,x); \max \left[v(t,x) - H(t,x); \\
-\partial_t v(t,x) - \mathcal{L}^X v(t,x) - f(t,x,v(t,x),\sigma(t,x)^\top D_x v(t,x)) \right] \right\} = 0; \\
v(T,x) = g(x).
\end{cases} (6.11)$$

For the definition of the viscosity solution of equation (6.11), which is standard, we refer the reader to [14].

The link between PDE (6.11) and the process $Y^{t,x}$ through the function u defined in (6.10) is:

Theorem 6.3. [14]: Under (H0),(A1) and (A2) we have:

- (i) The function u is the unique continuous viscosity solution of (6.11) with polynomial growth;
- (ii) The function u is also a unique continuous viscosity solution, in the class Π_g , of the following max-min problem:

$$\begin{cases}
\max \left\{ v(t,x) - H(t,x) \; ; \; \min \left[v(t,x) - L(t,x) ; \\
-\partial_t v(t,x) - \mathcal{L}^X v(t,x) - f(t,x,v(t,x),\sigma(t,x)^\top D_x v(t,x)) \right] \right\} = 0; \\
v(T,x) = g(x).
\end{cases} (6.12)$$

The proof of (i) is similar to the one given in [14]. However, we should point out that in [14], the barriers L and H are assumed to be completely separated (i.e. L < H) while in our framework they only satisfy $L \le U$. This fact is irrelevant and does not rise a major issue. As for (ii), the construction of the function u (see [14]) implies that w = -u is the unique viscosity solution in the class Π_q of the following system:

$$\begin{cases}
\min \left\{ w(t,x) + H(t,x), \max \left[w(t,x) + L(t,x), \\
-\partial_t w(t,x) - \mathcal{L}w(t,x) + f(t,x,-w(t,x),-\sigma(t,x)^\top D_x w(t,x)) \right] \right\} = 0; \\
w(T,x) = -g(x).
\end{cases} (6.13)$$

Thus -w = u is the unique solution in the class Π_g of system (6.12) (see e.g. [2], pp.18).
