3 Technical report

3.1 Statistical territory

The geographical territory used for statistics does not always clearly appear in the statistical yearbook. The total for France or for the French Empire (“Total France” or “Empire”) are often the only available information, as if the territory at stake was well defined.

If statistics exist for colonies or for Algeria, the INSEE (National Institute of Statistics and Economic Studies) has always distinguished between these and the ones from the French Metropolitan Territory. Nevertheless, a choice remains necessary since this territory has changed over time. We chose to draw on the territory that was used for the surveys, i.e., this territory did not remain the same. Below are shown all the modifications that occurred during our time-frame. The authors from the work on the UK have undergone the same choice¹. They kept the same statistical territory, which explains the huge drop in their statistics at the time Ireland becomes independent. We don't observe such an impact in our work. Nevertheless, we can mention an addition of about 10% in the total coal extraction in 1919.²

If the statistical territory evolves, the changes almost always correspond to the changes of the metropolitan territory (Annuaire 1919-1920, shelf number: 4-LF262-3):

- addition of the *Départements* of the Alpes-Maritimes, Savoie, and Haute-Savoie in 1860;
- loss of the *Départements* of Moselle, Haut-Rhin, Bas-Rhin (except the Territoire de Belfort which remains in the statistics) in 1871;
- re-addition of the *Départements* of Moselle, Haut-Rhin, Bas-Rhin in 1919. For example, there are 86 departments in the statistical survey of 1852, 89 in 1862, 87 in 1892 (including Belfort), and 90 in 1929 (including Belfort);

- Territory of the Saar Basin (Saargebiet in German and Territoire du Bassin de la Sarre in French): it appears as separated from France and Germany through 1924. This territory is attached to the French statistical territory in 1925, and removed on 17 February 1935; it is attached again on 1 April 1948, and removed on 6 July 1959.

Exceptions are the following:

Customs Since 1 January 1997, the overseas departments (DOM) have been integrated into the statistical territory of France. This includes mainland France, Corsica, Monaco, the other French coastal islands, and the DOM (Melzi 2012, p. 232)

Fisheries some are carried out in Iceland, Feroe Islands and Dogger-Bank, Newfoundland (*Terre-Neuve*), and (rarely) West Coast of Africa. This is necessarily outside national territory but has been taken into account (derisory figures anyway).

3.2 Physical Trade Balance (PTB)

3.2.1 Errors from the administration.

We have no precise idea of how wrong are customs statistics in the 1800s. Apart from that, they estimate a loose in traceability since 1993 of about 5 to 10% concerning trade within the European Union (all operators with commodity flows inferior to 460,000 euros per year do not declare anything at all³).

3.2.2 Extrapolation

The dataset we have for years 1830-1880 comes from *Tableaux statistiques décennaux* consisting of production average for the following periods: 1827-1836; 1837-1846; 1847-1856; 1857-1866; 1867-1876; 1877-1886; 1887-1896.

In order to obtain a yearly dot, we followed two things:

- an assumption: production increases through the 19th century;
- we attributed this average to the median year of the intervals, respectively 1832, 1842, 1852, 1872, 1882, and 1892, then thanks to a simple linear interpolation (example: $B.1.1_{1833} = (-B.1.1_{1842}^* - B.1.1_{1832}^*)/(1842 - 1832) \times 1833 + (B.1.1_{1842}^* - (-B.1.1_{1842}^* - B.1.1_{1832}^*))/(1842 - 1832) \times 1842$), où X^* designate the attributed values, we got an estimated for annual production for each category.

We have yearly data for years 1888-1942, which allow us to verify whether the above interpolation was right on years 1888-1892. Regarding the four main categories (B.1, B.2, B.3, B.4), the main difference is a 15%-underestimation of metal imports (B.2) in 1888. Regarding secondary categories, changes in nomenclatures do not allow any relevant and coherent comparison. In the end, the interpolation method is quite satisfactory. To smooth nomenclatures' transitions, annual data for 1888 (imports) and 1889 (exports) have been chosen as final boundary markers for the linear interpolation.

3.3 Domestic extraction (DE)

3.3.1 Primary sources

The MFA analysis requires the use of the extraction of raw material. In order to achieve national statistics related to the Metropolitan territory, we used statistical yearbooks from the French National Institute of Statistics and Economic Studies (INSEE) for most data. For years 1948-1988, most data come from a retrospective statistical report published in 1990 (Institut national de la statistique et des études économiques 1988). However, for some categories—such as fish, oil, coal—data were extracted from normal yearbooks. For years 1990-2015, we completed the yearbooks' statistics with data from the Ministry of Ecology and Energy transition which has given us a MFA-yearly data set. This is especially the case after 2005 which is the last year of publication of the INSEE yearbooks.

Data from the retrospective report sometimes really differ from the yearbooks' data. As a common rule for all data related to domestic extraction, we favor those from the retrospective report. For instance, quantities of feldspath in the 1966 yearbook and in the retrospective report are the same. However, in 1970, the value from the retrospective report is double. We would like to bring here a kind reminder for the reader: there are issues of convention, bargaining, estimations, reports, construction, transcription, nomenclature inherently brought with the production and publication of data by the INSEE. For a more robust analysis, we must confront data from other sources so that we could corroborate the numbers used.

Categories of raw material that appear in the domestic extraction for achieving a MFA analysis are detailed and ordered following four categories in the methodological guide Krausmann et al. (2015). In general, our work was simply to copy data from the yearbooks to the corresponding MFA section. For a detailed list, please see section "Association table" (table 7).

The data set from the Ministry of Ecology shows some classification's differences which are as follow (first: Krausmann's guideline ; second: Ministry of Energy transition):

If a change in a parent node keeps children nodes in the same order, only the parent node is written above.

3.3.2 Errors in yearbooks

Some sections were harder to fill in. First of all, obvious units' mistakes have been noticed for rice harvest (data in million of quintals instead of thousands of tons), rapeseed and sunflower harvest (data in million of quintals instead of thousands of quintals). Errors have been noticed while comparing the yearbooks and the retrospective reports for some years (for instance: 1953, 1960, 1963, and 1970).

3.3.3 Conversions

Natural gas If data were mostly presented in metric tons, some conversions remained necessary. For instance, natural gas was sometimes indicated in billion of therms (thm), an old energy unit which was as follow: $1\text{thm} = 1000\text{kcal}$. We used a weight-energy conversion factor from Kraussmann *et al.* (2015, p. 68), which is the following:

$$n_{\text{natural gas}}[T] = \frac{E_{\text{natural gas}}[10^9\text{thm}] \times 10^6}{2.39 \times 5}$$

Natural gas was also given in terms of ton of oil equivalent (toe). In order to convert this unit, we used a footnote from the 1994 yearbook indicating $1000\text{m}^3 = 0.9\text{toe}$ and the factor given in the MFA methodology (Kraussmann *et al.*, 2015, p. 68), which lead to the following formula:

$$n_{\text{natural gas}}[T] = V_{\text{gas}}[\text{m}^3] \times \frac{0.8}{1000} = E_{\text{gas}}[\text{toe}] \times \frac{0.8}{0.9}$$

Timber Regarding timber, we had to convert cubic meters in tons for both broad-leaved trees and conifers (see Table 1). Two isolated cases are noteworthy:

- Sleepers made of wood (*bois sous rail* is the French designation) for which we used the size given by the British railway association (rta.org) so that we could convert cubic meters of sleepers in tons. The size was: 235 lbs of weight for a volume of $7'' \times 9'' \times 8'5''$.
- Regarding tropical timber, in the absence of any reliable conversion, we used the coefficient given in the MFA methodology for the UE25.

Density is converted to ton using the 15% moisture coefficients for hardwoods (0.68) and conifers (0.52). If the species are mixed or the woods of unknown types, the EU25 average coefficient (80% coniferous) applied is 0.55.

Other conversions Some other coefficients are gathered in table 4.

3.3.4 Estimations

Harvest Some other values had to be estimated (Kraussmann *et al.*, 2015, p. 28). For instance, this may be the case of plant residues used (notably straw when it is not given by statistics). In order to get the weight of plant residues, the simple following calculus is necessary:

$$m_{\text{residue}} = m_{\text{harvest}} \times t_{\text{residue}}$$

Table 5 shows the values given in the methodology (Kraussmann *et al.*, 2015, p. 28) combining both the harvest factors and the recovery rates.

Please note that these coefficients do not depend on time, which makes them ahistorical with regards to plant selection and evolution. The case of wheat is a great defense for criticizing this type of coefficient. Quantities of straw - and quality of course - was doubtlessly different in 1988 and in 1848.

The harvest factor is used to get the weight of straw or residue produced from crops if not given in national statistics. For Western Europe, the MFA methodology gives a number of 1.0 for cereals. Given the evolution of crops and cultivars along the 19th and 20th centuries, we claim that this factor should be historicized. Since French national statistics show quantities of straw produced, it was been possible to construct the harvest factor from our data for some years. It is shown in Table 4. It enlightens the following considerations:

- the problems of having an ahistorical factor;
- a huge volatility even for year-to-year periods, which emphasizes a botanical issue beyond a simple historical issue;
- the harvest factor we found is much greater than the one given in the MFA methodology;
- there is also an induced variability, due to estimation methods (since most of the time these data are estimates from surveys and are not census data)—this would deserve further investigations; what extent may we ensure that our data are accurate, i.e. can we believe their reliability? Indeed, we have not studied how they were constructed

and gathered from 1852. This particular point may enter a more general criticism for all data we use. This being said let us note here that the harvest factor remains quite stable from 1852 to 1920.

Moreover, MFA studies incorporate assumptions regarding data: the acknowledgement of national official statistics without any amendment for self-consumption and other non-profit/non-trading/non-market consumption, the adoption of a constant harvest factor over time, etc. These assumptions tend to underestimate past quantities, and thus they reinforce the "everything grows" narrative, which is one of the two sides of the conquering modernity.

Metal ores Regarding metal ores, a particular care must be taken to use gross ore and not metal content. Our data indicate alternatively the mass of gross ore, the mass of commercial concentrate (sometimes the concentration of the concentrate is specified sometimes not), and the mass of metal content. Table 5 lists the various factors we used if not already specified in the sources. Values are from Krausmann *et al.* (2015, pp. 44-53) and Schaffartzik *et al.* (2016, p.8).⁴ We must again note the limit of this type of conversion without opening a discussion with, especially for the metal, the archives of the mines. For example, there is no

longer any copper ore mining in France since the 1961 Chizeuil (Saône-et-Loire) formation was depleted, with the exception of copper contained in gold ores unknown concentration levels: this makes the checks all the more complicated.

Wine grapes Regarding wine grapes used for the manufacture of wine, it is necessary to convert the volumes of wine into quantity of grapes since they do not appear elsewhere in the national statistics. Robinson (2006, pp. 780-781) gives a coefficient of 140 kilograms per hectoliter for a mixture of red wine and white wine. We use this coefficient as a raw estimate for the 20th century, observing that it would be different among types of grape, and can vary greatly depending on the type of variety. For the 19th we assumed that 10hL of beverage would equal 1T.

Ready-mix concrete The first cement plants were developed in France between 1850 and 1860 by the *Société des Ciments Français*. Ready-mix concrete is recorded only from 1963 in the statistical yearbooks. At present, we do not have sufficient information to certify which materials are accounted for by the INSEE for ready-mix concrete. For instance, we do not know if sand is accounted for twice or none. Yet according to the great importance of ready-mix concrete takes in terms of tons, it is simply not possible to remove for the analysis. Though one should take particular attention to this case. Table 6 givers the weight coefficient we used to convert ready-mix concrete to cement and aggregate, i.e., removing the water weight.

Moreover, a lot of materials were given as manufactured products made of concrete (and not cement). These materials are not accounted for in other categories since they go directly out from quarries which are also factories. In the absence of a better estimate, the same ratios as for ready-mix concrete have been applied to these products.

3.4 Missing data

Some data are clearly missing for a few years in both types of yearbooks, in particular for non-metallic minerals and metals. Hereinafter is shown a non-definitive list of missing data. Data from the 19th are not present in this list since many data were missing. Details about missing-data estimates are provided in the following sections.

- 1948-1950: lead ore, *plaques de couverture, plaques ondulées, plaques planes*
- 1948-1951: gypsum, shale oil ;
- 1948-1952: fish and other water creatures, tin ore, other stones, granite and marble – slices, concrete stands, run material, kaolin, refractory earths, sodium chloride in dissolution, sea salt, rock salt, asphalt rocks, spar, quartz and quartzite, talc, feldspar
- 1954-1961: uranium
- 1985-1988: *plaques de couverture, plaques ondulées, plaques planes*
- 1987-1988: wine
- 1988: lentils, copper ore, lead ore, gross marble tiles, granite, gross basic slag, gypsum, plaster for construction, special plasters for molding, curb, rocks, gravels, *matériaux concassés de roche et de laitier*, rubble stones, sands, industrial sands, concrete stands, run material, sanitation pipes

Uranium The French production of uranium began in 1954. Though there is no data in the yearbooks between 1954 and 1961 (except for 1960) for gross ore of uranium. Production is of 50T in 1954, 826T in 1958, 1180T in 1959 and 1000T in 1962. The following procedure was followed for getting gross ore:

- gross ore in 1961 = mean(1960, 1962)
- gross ore in 1954 = $0.05 \times$ gross ore in 1962
- gross ore in 1958 = $0.826 \times$ gross ore in 1962
- gross ore in 1959 = $1.180 \times$ gross ore in 1962

Other years are smoothed using affine lines.

Straw We estimated straw for the missing years using the straw-to-grain ratio calculated thanks to the years when data are present (see Table 4), and then smoothed with affine lines. The coefficient is multiplied by the grain harvest of the year in question.

Pastures Regarding pastures (non-mowing meadows, moor, heather), 1852 is the only available year. The total forage excluding beet, cabbage and fodder turnips in 1852 is 26,000,000T. The total forage (excluding beet, cabbage and fodder turnips) was first roughly estimated between 1840 and 1939, assuming an increase towards the post-harvest level (about 50,000,000T in 1948). This assumption is supported with the development of animal draft and meat consumption until the 1930s. Moreover, the rural exodus made lands with small yields for cereals turn back to pasture and fodder from the end of the 19th century.

As soon as national statistics were significantly below our estimate, we added a box "Pastures (non-mowing meadows, heath, heather, pasture)" and included the difference between

our estimate and the total statistics in order to avoid neglecting fodders eaten by animals in woods and heather. This concerns the following years: 1840, 1850, 1852, 1874, 1880, 1885, 1890 and 1900.

Other estimations for biomass

Potatoes Toutain (1971, p. 1927) gives ten-year data for periods covering 1815-1830, 1850-1860, 1870, and 1874. Then data are smoothed with affine lines.

Pulses Toutain (1971, p. 1929) gives data for a period covering 1815-1939, with the exception of 1920 (we used the data from the yearbook) and of 1910 (we used the yearbook giving 236,531T, instead of the 220,000T given by Toutain).

Cereals For period 1815-1930, if data were missing in the yearbooks, we used the "other cereals" category as a missing data filling box. Other cereals then become the amount of cereals evaluated by Toutain (1971, p. 1918) minus data from the yearbooks.

Fruits and vegetables Toutain (1971, p. 1931-1937) gives data for a period covering 1855-1945. When only a total for fruit and vegetables was given, we keep the ratio fruit/vegetables given for 1882 and extrapolate a separate weight for fruit and vegetable.

Fodder rutabagas and cabbages Data are given in statistics in 1852 and 1910. Missing data are estimated from 1815 to 1910 thanks to an affine line.

Fodder roots One point exists in 1885. Using the same slope as the one for fodder turnips (data from 1852 to 1910), missing data are estimated back to 1815 thanks to this affine line.

Artificial grasslands We have data in 1840, 1852, 1862, and from 1885 onwards for artificial grasslands (sainfoin, alfalfa, clover). Missing data are estimated thanks to affine lines.

Natural grasslands We have data in 1840, 1852, 1862, and from 1885 onwards for natural grasslands. Missing data are estimated thanks to affine lines.

4 Association table

Categories followed by a star were either estimated or converted. Hence these data are not raw data from our sources.

The reference nomenclature is that of 1970 (and its minor variations from 1956 to 1982), the column “1948 - 1956” refers to the correspondences between this reference nomenclature and the nomenclature of 1948 (and its minor variations of 1953), and the column “1988” refers to the correspondences between this reference nomenclature and the 1988 nomenclature.

Some remarks, the correspondences between the nomenclature of 1948 and 1970 are given provisionally for the section 26. Metallurgical ores, slag and ash. For the threads and fabrics 50. to 58. Sections, the nomenclature changes between 1948 and 1970 are so important that we favored a simpler approach, separating the following categories: *Textile Fibers in Biomass* and *Textile Synthetic Fibers* from 1948 to 1956.

5 Criticisms of agricultural statistics

Agricultural statistics were not census, but mostly consisted of surveys. Before the mid-20th century, survey methods were either very rough or non-existent. Indeed, it was only in

the 1930s that sampling and randomization methods appeared with the developments of statistics, firstly in the UK and in the US (Desrosières 1993; Didier 2009; Neyman 1934), which later allowed for the construction of representative surveys. Michel Augé-Laribé (1945, p. 69) enlightens the fact that annual reports were mainly made of "usable estimates" whose main usefulness was to represent trends and means at a macroscopic level: based on mayors self-statements (Barral 1968). Self-production of family farms was also mainly unrecorded (Moulin 1992, p. 173), even though one fourth of the total production is self-consumed in 1938 (Moulin 1992, p. 184).

Musset (1933, p. 287) also harshly criticizes the national French agricultural statistics:

The agricultural statistics of France? They are everywhere, spread, lost in the chaos of French official publications: the ones published by the Ministry of Agriculture are only a small fraction. One has never been concerned about the gathering of all data in one and about providing workers with all relevant statistical files. This indicates how unorganized is agricultural statistics. So one must look them up with extreme caution and one should improve them, if it were possible.⁵

None of the two last ten-year statistics, 1882 and 1892 has been made by statisticians specialized on their task: each of them is the work of an ad-libbed staff which had to answer an excessively vast form without any preparation.⁶

6 Conclusion

These data remains to be completed thanks to year-by-year directories or other sources. All these data should be completed or even replaced by data from each sector or specialized institutions.
