## I. Non-Causal Encoding and Decoding



Fig. 1. Non-Causal Encoding function $f: \mathcal{U}^{n} \times \mathcal{S}^{n} \rightarrow \mathcal{X}^{n}$ and Decoding function $g: \mathcal{Y}^{n} \times \mathcal{Z}^{n} \rightarrow \mathcal{V}^{n}$.

## Theorem I. 1 (Non-Causal Encoding and Decoding)

1) Joint probability distribution $\mathcal{Q}(u, s, z, x, y, v)$ is achievable if and only if it decomposes as follows:

$$
\left\{\begin{array}{l}
\mathcal{Q}(u, s, z)=\mathcal{P}_{\mathrm{usz}}(u, s, z),  \tag{1}\\
\mathcal{Q}(y \mid x, s)=\mathcal{T}(y \mid x, s), \\
Y \multimap(X, S) \multimap(U, Z), \\
Z \multimap(U, S) \multimap(X, Y),
\end{array}\right.
$$

and $\mathcal{P}_{\text {usz }}(u, s, z) \otimes \mathcal{Q}(x \mid u, s) \otimes \mathcal{T}(y \mid x, s) \otimes \mathcal{Q}(v \mid u, s, z, x, y)$ is achievable.
2) Joint probability distribution $\mathcal{P}_{\text {usz }}(u, s, z) \otimes \mathcal{Q}(x \mid u, s) \otimes \mathcal{T}(y \mid x, s) \otimes \mathcal{Q}(v \mid u, s, z, x, y)$ is achievable if:

$$
\begin{equation*}
\max _{\mathcal{Q} \in \mathbb{Q}}\left(I\left(W_{1}, W_{2} ; Y, Z\right)-I\left(W_{1}, W_{2} ; U, S\right)\right)>0 \tag{2}
\end{equation*}
$$

3) Joint probability distribution $\mathcal{P}_{\text {usz }}(u, s, z) \otimes \mathcal{Q}(x \mid u, s) \otimes \mathcal{T}(y \mid x, s) \otimes \mathcal{Q}(v \mid u, s, z, x, y)$ is not achievable if:

$$
\begin{equation*}
\max _{\mathcal{Q} \in \mathbb{Q}}\left(I\left(W_{1} ; Y, Z \mid W_{2}\right)-I\left(W_{2} ; U, S \mid W_{1}\right)\right)<0 \tag{3}
\end{equation*}
$$

where $\mathbb{Q}$ is the set of distributions $\mathcal{Q} \in \Delta\left(\mathcal{U} \times \mathcal{S} \times \mathcal{Z} \times \mathcal{W}_{1} \times \mathcal{W}_{2} \times \mathcal{X} \times \mathcal{Y} \times \mathcal{V}\right)$ with auxiliary random variables $\left(W_{1}, W_{2}\right)$ that satisfies:

$$
\left\{\begin{array}{l}
\sum_{\left(w_{1}, w_{2}\right) \in \mathcal{W}_{1} \times \mathcal{W}_{2}} \mathcal{Q}\left(u, s, z, w_{1}, w_{2}, x, y, v\right) \\
\quad=\mathcal{P}_{\mathrm{uzz}}(u, s, z) \otimes \mathcal{Q}(x \mid u, s) \otimes \mathcal{T}(y \mid x, s) \otimes \mathcal{Q}(v \mid u, s, z, x, y), \\
Y-(X, S)-\left(U, Z, W_{1}, W_{2}\right), \\
Z-(U, S) \mapsto\left(X, Y, W_{1}, W_{2}\right), \\
V-\left(Y, Z, W_{1}, W_{2}\right) \multimap(U, S, X)
\end{array}\right.
$$

The probability distribution $\mathcal{Q} \in \mathbb{Q}$ decomposes as follows:

$$
\mathcal{P}_{\text {usz }}(u, s, z) \otimes \mathcal{Q}(x \mid u, s) \otimes \mathcal{Q}\left(w_{1}, w_{2} \mid u, s, x\right) \otimes \mathcal{T}(y \mid x, s) \otimes \mathcal{Q}\left(v \mid y, z, w_{1}, w_{2}\right) .
$$

The supports of the auxiliary random variables $\left(W_{1}, W_{2}\right)$ are bounded by $\max \left(\left|\mathcal{W}_{1}\right|,\left|\mathcal{W}_{2}\right|\right) \leq(|\mathcal{B}|+1)$. $(|\mathcal{B}|+2)$ with $\mathcal{B}=\mathcal{U} \times \mathcal{S} \times \mathcal{Z} \times \mathcal{X} \times \mathcal{Y} \times \mathcal{V}$.

Remark I. 2 The mutual informations in equation (2) are continuous over the set of probability distributions $\mathbb{Q}$. Moreover, $\mathbb{Q}$ is compact since the supports of the auxiliary random variables $\left(W_{1}, W_{2}\right)$ are finite and $\mathbb{Q}$ has equality constraints. As mentioned in [8] pp. 7083 and in [2] pp. 9, we can consider the maximum instead of the supremum in equation (2).

Remark I. 3 The achievability result of Theorem I. 1 without state informations $S$ and $Z$ was already stated in [1], with a unique auxiliary random variable $W=\left(W_{1}, W_{2}\right)$.

Remark I. 4 As mentioned in Theorem I. 1 1), probability distribution $\mathcal{Q}(u, s, z, x, y, v)$ should satisfy the marginal distributions over the source $\mathcal{P}_{\text {usz }}(u, s, z)$, the channel $\mathcal{T}(y \mid x, s)$ and the Markov chains representing the network topology. If a probability distribution $\mathcal{Q}(u, s, z, x, y, v)$ does not decomposes with $\mathcal{P}_{\text {usz }}(u, s, z) \otimes \mathcal{Q}(x \mid u, s) \otimes \mathcal{T}(y \mid x, s) \otimes \mathcal{Q}(v \mid u, s, z, x, y)$, then the error probability can not converge to zero and this probability distribution is not achievable. This remark is valid for all coding theorems presented in this document.

## A. Achievability Proof

Denote by $\mathcal{Q}\left(u, s, z, x, w_{1}, w_{2}, y, v\right) \in \mathbb{Q}$ the joint probability distribution that achieves the maximum in equation (2). There exists $\delta>0$ and rate $\mathrm{R} \geq 0$ such that :

\begin{align*}
& \mathrm{R} \geq I\left(W_{1}, W_{2} ; U, S\right)+\delta,  \tag{4}\\
& \mathrm{R} \leq I\left(W_{1}, W_{2} ; Y, Z\right)-\delta . \tag{5}
\end{align*}
$$

- Random codebook. We generate $|\mathcal{M}|=2^{n \mathrm{R}}$ pairs of sequences $\left(W_{1}^{n}(m), W_{2}^{n}(m)\right)$ with index $m \in \mathcal{M}$ drawn from the i.i.d. marginal probability distribution $\mathcal{Q}_{\mathrm{w}_{1} \mathrm{w}_{2}}^{\otimes n}$.
- Encoding function. The encoder observes the sequences of source symbols $U^{n} \in \mathcal{U}^{n}$ and state symbols $S^{n} \in \mathcal{S}^{n}$. It finds the index $m \in \mathcal{M}$ such that the sequences $\left(U^{n}, S^{n}, W_{1}^{n}(m), W_{2}^{n}(m)\right) \in$ $A_{\varepsilon}^{\star n}(\mathcal{Q})$ are jointly typical. Encoder sends the sequence $X^{n}$ drawn from the conditional probability distribution $\mathcal{Q}_{\times \mid \text {usw }_{1} w_{2}}^{\otimes n}$ depending on sequences $\left(U^{n}, S^{n}, W_{1}^{n}(m), W_{2}^{n}(m)\right)$.
- Decoding function. The decoder observes the pair of sequences $\left(Y^{n}, Z^{n}\right)$ and finds the index $m \in \mathcal{M}$ such that the sequences $\left(Y^{n}, Z^{n}, W_{1}^{n}(m), W_{2}^{n}(m)\right) \in A_{\varepsilon}^{\star n}(\mathcal{Q})$ are jointly typical. Decoder returns the sequence $V^{n}$ drawn from the conditional probability distribution $\mathcal{Q}_{\mathrm{v} \mid \mathrm{yzw}_{1} \mathrm{w}_{2}}^{\otimes n}$ depending on sequences $\left(Y^{n}, Z^{n}, W_{1}^{n}(m), W_{2}^{n}(m)\right)$.

From the properties of typical sequences, packing and covering Lemmas stated in [9] pp. 27, 46 and 208, equations (4), (5), imply there exists a $\bar{n} \in \mathbb{N}$ such that the expected probability of error events are bounded by $\varepsilon$ for all $n \geq \bar{n}$ :

& \mathbb{E}_{c}\left[\mathcal{P}\left(\forall m \in \mathcal{M}, \quad\left(U^{n}, S^{n}, W_{1}^{n}(m), W_{2}^{n}(m)\right) \notin A_{\varepsilon}^{\star n}(\mathcal{Q})\right)\right] \leq \varepsilon,  \tag{7}\\
& \mathbb{E}_{c}\left[\mathcal{P}\left(\exists m^{\prime} \neq m, \text { s.t. }\left(Y^{n}, Z^{n}, W_{1}^{n}\left(m^{\prime}\right), W_{2}^{n}\left(m^{\prime}\right)\right) \in A_{\varepsilon}^{\star n}(\mathcal{Q})\right)\right] \leq \varepsilon . \tag{8}
\end{align*}
$$

For all $n \geq \bar{n}$, there exists a code $c^{\star} \in \mathcal{C}(n)$ such that sequences $\left(U^{n}, S^{n}, Z^{n}, W_{1}^{n}(m), W_{2}^{n}(m), X^{n}, Y^{n}, V^{n}\right) \in$ $A_{\varepsilon}^{\star n}(\mathcal{Q})$ are jointly typical for distribution $\mathcal{P}_{\text {usz }}(u, s, z) \otimes \mathcal{Q}\left(x, w_{1}, w_{2} \mid u, s\right) \otimes \mathcal{T}(y \mid x, s) \otimes \mathcal{Q}\left(v \mid y, z, w_{1}, w_{2}\right)$ with probability more than $1-3 \varepsilon$.

The cardinality bound is stated in Lemma 6 in the Appendix. This concludes the achievability proof of Theorem I.1.

## B. Converse Proof

We introduce the random event of error $E \in\{0,1\}$ defined as follows:

0 & \text { if } & \left\|Q^{n}-\mathcal{Q}\right\|_{\mathrm{tv}} \leq \varepsilon \quad \Longleftrightarrow & \left.\Longleftrightarrow U^{n}, S^{n}, Z^{n}, X^{n}, Y^{n}, V^{n}\right) \in A_{\varepsilon}^{\star n}(\mathcal{Q}),  \tag{9}\\
1 & \text { if } \quad\left\|Q^{n}-\mathcal{Q}\right\|_{\mathrm{tv}}>\varepsilon \quad \Longleftrightarrow \quad\left(U^{n}, S^{n}, Z^{n}, X^{n}, Y^{n}, V^{n}\right) \notin A_{\varepsilon}^{\star n}(\mathcal{Q}) .
\end{array}\right.
$$

Consider a sequence of code $c(n) \in \mathcal{C}$ that achieves the probability distribution $\mathcal{Q}(u, s, z, x, y, v)$, i.e. for which the probability of error $\mathcal{P}_{\mathrm{e}}(c)=\mathcal{P}(E=1)$ is small. We have equations:

\begin{align*}
0 & =\sum_{i=1}^{n} I\left(U_{i+1}^{n}, S_{i+1}^{n}, Y_{i+1}^{n}, Z_{i+1}^{n} ; Y_{i}, Z_{i} \mid Y^{i-1}, Z^{i-1}\right) \\
& -\sum_{i=1}^{n} I\left(Y^{i-1}, Z^{i-1} ; U_{i}, S_{i}, Y_{i}, Z_{i} \mid U_{i+1}^{n}, S_{i+1}^{n}, Y_{i+1}^{n}, Z_{i+1}^{n}\right)  \tag{10}\\
& \leq \sum_{i=1}^{n} I\left(U_{i+1}^{n}, S_{i+1}^{n}, Y_{i+1}^{n}, Z_{i+1}^{n} ; Y_{i}, Z_{i} \mid Y^{i-1}, Z^{i-1}\right) \\
& -\sum_{i=1}^{n} I\left(Y^{i-1}, Z^{i-1} ; U_{i}, S_{i} \mid U_{i+1}^{n}, S_{i+1}^{n}, Y_{i+1}^{n}, Z_{i+1}^{n}\right)  \tag{11}\\
& =\sum_{i=1}^{n} I\left(W_{1, i} ; Y_{i}, Z_{i} \mid W_{2, i}\right)-\sum_{i=1}^{n} I\left(W_{2, i} ; U_{i}, S_{i} \mid W_{1, i}\right) \tag{12}
\end{align*}
$$

Equation (10) comes from Csiszár Sum Identity stated pp. 25 in [9].
Equation (11) comes from the properties of the mutual information.
Equation (12) comes from the introduction of the auxiliary random variables $W_{1, i}=$ $\left(U_{i+1}^{n}, S_{i+1}^{n}, Y_{i+1}^{n}, Z_{i+1}^{n}\right)$ and $W_{2, i}=\left(Y^{i-1}, Z^{i-1}\right)$. The pair of random variables $\left(W_{1, i}, W_{2, i}\right)$ satisfy the three Markov Chains that correspond to the set of probability distributions $\mathbb{Q}$ :

& Y_{i} \not\left(X_{i}, S_{i}\right) \multimap\left(U_{i}, Z_{i}, W_{1, i}, W_{2, i}\right),  \tag{13}\\
& Z_{i} \mapsto\left(U_{i}, S_{i}\right) \mapsto\left(X_{i}, Y_{i}, W_{1, i}, W_{2, i}\right),  \tag{14}\\
& V_{i} \mapsto\left(Y_{i}, Z_{i}, W_{1, i}, W_{2, i}\right) \multimap\left(U_{i}, S_{i}, X_{i}\right) . \tag{15}
\end{align*}
$$

- The first Markov chain comes from the memoryless property of the channel and the fact that $Y_{i}$ does not belong to ( $W_{1, i}, W_{2, i}$ ).
- The second Markov chain comes from the i.i.d. property of the source and the fact that $Z_{i}$ does not belong to ( $W_{1, i}, W_{2, i}$ ).
- The third Markov chain comes from the non-causal decoding: $V_{i}$ is a function of the pair $\left(Y^{n}, Z^{n}\right)$ that is included in ( $Y_{i}, Z_{i}, W_{1, i}, W_{2, i}$ ).

$$
\begin{align*}
0 & \leq \sum_{i=1}^{n} I\left(W_{1, i} ; Y_{i}, Z_{i} \mid W_{2, i}\right)-\sum_{i=1}^{n} I\left(W_{2, i} ; U_{i}, S_{i} \mid W_{1, i}\right) \\
& \leq n \cdot\left(I\left(W_{1, T} ; Y_{T}, Z_{T} \mid W_{2, T}, T\right)-I\left(W_{2, T} ; U_{T}, S_{T} \mid W_{1, T}, T\right)\right)  \tag{16}\\
& \leq n \cdot\left(I\left(W_{1, T}, T ; Y_{T}, Z_{T} \mid W_{2, T}\right)-I\left(W_{2, T} ; U_{T}, S_{T} \mid W_{1, T}, T\right)\right)  \tag{17}\\
& \leq n \cdot \max _{\mathcal{Q} \in \mathbb{Q}}\left(I\left(W_{1} ; Y_{T}, Z_{T} \mid W_{2}\right)-I\left(W_{2} ; U_{T}, S_{T} \mid W_{1}\right)\right)  \tag{18}\\
& \leq n \cdot \max _{\mathcal{Q} \in \mathbb{Q}}\left(I\left(W_{1} ; Y_{T}, Z_{T} \mid W_{2}, E=0\right)-I\left(W_{2} ; U_{T}, S_{T} \mid W_{1}, E=0\right)+\varepsilon\right)  \tag{19}\\
& \leq n \cdot \max _{\mathcal{Q} \in \mathbb{Q}}\left(I\left(W_{1} ; Y, Z \mid W_{2}\right)-I\left(W_{2} ; U, S \mid W_{1}\right)+2 \varepsilon\right) . \tag{20}
\end{align*}
$$

Equation (16) comes from the introduction of the uniform random variable $T$ over $\{1, \ldots, n\}$ and the introduction of the corresponding mean random variables $U_{T}, S_{T}, Z_{T}, W_{1, T}, W_{2, T}, X_{T}, Y_{T}, Z_{T}$.

Equation (17) comes from the properties of the mutual information.
Equation (18) comes from identifying $W_{1}$ with $\left(W_{1, T}, T\right)$ and $W_{2}$ with $W_{2, T}$ and taking the maximum over the probability distributions $\mathcal{Q}$ that belong to $\mathbb{Q}$. This is possible since the random variables $\left(W_{1, T}, T\right)$ and $W_{2, T}$ satisfy the Markov chains of the set of probability distributions $\mathbb{Q}$, as stated in Lemma 7 in the Appendix.

Equation (19) comes from the empirical coordination requirement as stated in Lemma 8. Sequences are not jointly typical with small error probability $\mathcal{P}(E=1)$.

Equation (20) comes from Lemma 9 that states that the probability distribution induced by the coding scheme $\mathcal{P}\left(\left(U_{T}, S_{T}, Z_{T}, X_{T}, Y_{T}, V_{T}\right)=(u, s, z, x, y, v) \mid E=0\right)$ is closed to the target probability distribution $\mathcal{Q}(u, s, z, x, y, v)$. The continuity of the entropy function stated pp .33 in [10] concludes the converse proof of Theorem I.1.

## II. Perfect Channel



Fig. 2. The perfect channel is defined by $\mathcal{T}_{y \mid \times s}=\mathbb{1}(y \mid x)$ and the decoding is lossy.

## Theorem II. 1 (Perfect Channel)

1) The joint probability distribution $\mathcal{Q}(u, s, z, x, v)$ is achievable if and only if it decomposes as follows:

$$
\left\{\begin{array}{l}
\mathcal{Q}(u, s, z)=\mathcal{P}_{\mathrm{usz}}(u, s, z),  \tag{21}\\
Z \multimap(U, S) \multimap X
\end{array}\right.
$$

and $\mathcal{P}_{\text {usz }}(u, s, z) \otimes \mathcal{Q}(x \mid u, s) \otimes \mathcal{Q}(v \mid u, s, z, x)$ is achievable.
2) The probability distribution $\mathcal{P}_{\mathrm{usz}}(u, s, z) \otimes \mathcal{Q}(x \mid u, s) \otimes \mathcal{Q}(v \mid u, s, z, x)$ is achievable if:

$$
\begin{equation*}
\max _{\mathcal{Q} \in \mathbb{Q}_{\mathrm{p}}}\left(I\left(W_{2} ; Z \mid X\right)+H(X)-I\left(X, W_{2} ; U, S\right)\right)>0 \tag{22}
\end{equation*}
$$

3) The probability distribution $\mathcal{P}_{\mathrm{usz}}(u, s, z) \otimes \mathcal{Q}(x \mid u, s) \otimes \mathcal{Q}(v \mid u, s, z, x)$ is not achievable if:

$$
\begin{equation*}
\max _{\mathcal{Q} \in \mathbb{Q}_{p}}\left(I\left(W_{2} ; Z \mid X\right)+H(X)-I\left(X, W_{2} ; U, S\right)\right)<0 \tag{23}
\end{equation*}
$$

where $\mathbb{Q}_{\mathrm{p}}$ is the set of distributions $\mathcal{Q} \in \Delta\left(\mathcal{U} \times \mathcal{S} \times \mathcal{Z} \times \mathcal{W}_{2} \times \mathcal{X} \times \mathcal{V}\right)$ with auxiliary random variable $W_{2}$ that satisfies:

$$
\left\{\begin{array}{l}
\sum_{w_{2} \in \mathcal{W}_{2}} \mathcal{Q}\left(u, s, z, x, w_{2}, v\right) \\
\quad=\mathcal{P}_{\mathrm{usz}}(u, s, z) \otimes \mathcal{Q}(x \mid u, s) \otimes \mathcal{Q}(v \mid u, s, z, x), \\
Z \multimap(U, S) \multimap\left(X, W_{2}\right) \\
V \rightarrow\left(X, Z, W_{2}\right) \multimap(U, S)
\end{array}\right.
$$

The probability distribution $\mathcal{Q} \in \mathbb{Q}_{\mathrm{p}}$ decomposes as follows:

$$
\mathcal{Q}\left(u, s, z, x, w_{2}, v\right)=\mathcal{P}_{\mathrm{usz}}(u, s, z) \otimes \mathcal{Q}(x \mid u, s) \otimes \mathcal{Q}\left(w_{2} \mid u, s, x\right) \otimes \mathcal{Q}\left(v \mid x, z, w_{2}\right) .
$$

The support of the auxiliary random variable $W_{2}$ is bounded by $\left|\mathcal{W}_{2}\right| \leq|\mathcal{B}|+1$ with $\mathcal{B}=\mathcal{U} \times \mathcal{S} \times \mathcal{Z} \times$ $\mathcal{X} \times \mathcal{Y} \times \mathcal{V}$.

Remark II. 2 This result generalizes the coding theorem of Wyner Ziv stated in [2].

## A. Achievability Proof

This proof can be obtained from achievability result of Sec. I-A, by replacing random variables $W_{1}$ and $Y$ by $X$. Note that $I\left(W_{2} ; Z \mid X\right)+H(X)-I\left(X, W_{2} ; U, S\right)=I\left(X, W_{2} ; X, Z\right)-I\left(X, W_{2} ; U, S\right)$.

Denote by $\mathcal{Q}\left(u, s, z, x, w_{2}, v\right) \in \mathbb{Q}_{\mathrm{p}}$ the joint probability distribution that achieves the maximum in equation (22). There exists $\delta>0$ and rate $\mathrm{R} \geq 0$ such that :

$$
\begin{align*}
& \mathrm{R} \geq I\left(X, W_{2} ; U, S\right)+\delta,  \tag{24}\\
& \mathrm{R} \leq I\left(X, W_{2} ; X, Z\right)-\delta . \tag{25}
\end{align*}
$$

- Random codebook. We generate $|\mathcal{M}|=2^{n \mathrm{R}}$ pairs of sequences $\left(X^{n}(m), W_{2}^{n}(m)\right)$ with index $m \in \mathcal{M}$ drawn from the i.i.d. marginal probability distribution $\mathcal{Q}_{\mathrm{x} \mathrm{w}_{2}}^{\otimes n}$.
- Encoding function. The encoder observes the sequences of source symbols $U^{n} \in \mathcal{U}^{n}$ and state symbols $S^{n} \in \mathcal{S}^{n}$. It finds the index $m \in \mathcal{M}$ such that the sequences $\left(U^{n}, S^{n}, X^{n}(m), W_{2}^{n}(m)\right) \in$ $A_{\varepsilon}^{\star n}(\mathcal{Q})$ are jointly typical. Encoder sends the corresponding sequence $X^{n}(m)$ through the channel.
- Decoding function. The decoder observes the pair of sequences $\left(X^{n}, Z^{n}\right)$ and finds the index $m \in \mathcal{M}$ such that the sequences $\left(X^{n}, Z^{n}, X^{n}(m), W_{2}^{n}(m)\right) \in A_{\varepsilon}^{\star n}(\mathcal{Q})$ are jointly typical (for probability distribution $\mathcal{Q}_{\text {xzw }} \otimes \mathbb{1}_{x \mid x}$ ). Decoder returns the sequence $V^{n}$ drawn from the conditional probability distribution $\mathcal{Q}_{\mathrm{v} \mid \times \mathrm{K}_{2}}^{\otimes n}$ depending on sequences $\left(X^{n}, Z^{n}, W_{2}^{n}(m)\right)$.

From the properties of typical sequences, packing and covering Lemmas stated in [9] pp. 27, 46 and 208, equations (24), (25), imply there exists a $\bar{n} \in \mathbb{N}$ such that the expected probability of error events are bounded by $\varepsilon$ for all $n \geq \bar{n}$ :

For all $n \geq \bar{n}$, there exists a code $c^{\star} \in \mathcal{C}(n)$ such that sequences $\left(U^{n}, S^{n}, Z^{n}, X^{n}(m), W_{2}^{n}(m), V^{n}\right) \in$ $A_{\varepsilon}^{\star n}(\mathcal{Q})$ are jointly typical for distribution $\mathcal{P}_{\text {usz }}(u, s, z) \otimes \mathcal{Q}\left(x, w_{2} \mid u, s\right) \otimes \mathcal{Q}\left(v \mid x, z, w_{2}\right)$ with probability more than $1-3 \varepsilon$.

The cardinality bound is stated in Lemma 6 in the Appendix. This concludes the achievability proof of Theorem II.1.

## B. Converse Proof

Equation (32) comes from the i.i.d. property of the information source and Lemma 10 in the Appendix
that implies $\sum_{i=1}^{n} I\left(U_{i+1}^{n}, S_{i+1}^{n} ; U_{i}, S_{i} \mid E=0\right) \leq n \cdot \varepsilon$.
Equations (33) and (34) come from the properties of the mutual information.
Equation (35) comes from the i.i.d. property of the information source $(U, S, Z)$ and Lemma 10 in the Appendix that implies $\sum_{i=1}^{n} H\left(Z_{i} \mid X^{n}, Z^{-i}, U_{i+1}^{n}, S_{i+1}^{n}, U_{i}, S_{i}, E=0\right)-\sum_{i=1}^{n} H\left(Z_{i} \mid U_{i}, S_{i}, E=0\right) \leq n \cdot \varepsilon$. Equation (36) comes from the i.i.d. property of the information source ( $U, S, Z$ ) and Lemma 10 in the Appendix that implies $\sum_{i=1}^{n} H\left(Z_{i} \mid U_{i}, S_{i}, E=0\right)-H\left(Z^{n} \mid U^{n}, S^{n}, E=0\right) \leq n \cdot \varepsilon$.
Equation (37) comes from the introduction of the auxiliary random variable $W_{2, i}=$ $\left(X^{-i}, Z^{-i}, U_{i+1}^{n}, S_{i+1}^{n}\right)$. The random variable $W_{2, i}$ satisfy the Markov Chains that correspond to the set of probability distributions $\mathbb{Q}_{\mathrm{p}}$ corresponding to the perfect channel:

Equation (40) comes from the introduction of the uniform random variable $T$ over $\{1, \ldots, n\}$ and the introduction of the corresponding mean random variables $U_{T}, S_{T}, Z_{T}, W_{2, T}, X_{T}, V_{T}$.

Equation (41) comes from the i.i.d. property of the information source $(U, S)$ and Lemma 11 in the Appendix that implies $I\left(T ; U_{T}, S_{T} \mid E=0\right)=0$.

Equation (42) comes from identifying $W_{2}$ with $\left(W_{2, T}, T\right)$ and taking the maximum over the probability distributions that belong to $\mathbb{Q}_{\mathrm{p}}$. This is possible since the random variables $\left(W_{2, T}, T\right)$ satisfy the Markov chains of the set of probability distributions $\mathbb{Q}_{p}$, as stated in Lemma 7 in the Appendix.

Equation (43) comes from Lemma 9 that states that the probability distribution induced by the coding scheme $\mathcal{P}\left(\left(U_{T}, S_{T}, Z_{T}, X_{T}, V_{T}\right)=(u, s, z, x, v) \mid E=0\right)$ is closed to the target probability distribution $\mathcal{Q}(u, s, z, x, y, v)$. The continuity of the entropy function stated pp. 33 in [10] concludes the converse proof of Theorem II.1.

The support of the auxiliary random variables $W_{1}$ is bounded by $\left|\mathcal{W}_{1}\right| \leq|\mathcal{B}|+1$ with $\mathcal{B}=\mathcal{U} \times \mathcal{S} \times \mathcal{Z} \times$ $\mathcal{X} \times \mathcal{Y} \times \mathcal{V}$.

Remark III. 2 This result was already stated in [4] and [5] with a more restrictive lossless decoding constraint: $\mathcal{P}\left(\hat{U}^{n} \neq U^{n}\right) \leq \varepsilon$. It generalizes the coding theorem of Gel'fand Pinsker stated in [3].

## A. Achievability Proof

This proof can be obtained from the achievability result of Sec. I-A, by replacing random variables $W_{2}$ and $V$ by $U$. Note that $I\left(U, W_{1} ; Y, Z\right)-I\left(W_{1} ; S \mid U\right)-H(U)=I\left(W_{1}, U ; Y, Z\right)-I\left(W_{1}, U ; U, S\right)$.

Denote by $\mathcal{Q}\left(u, s, z, w_{1}, x, y, \hat{u}\right) \in \mathbb{Q}_{1}$ the joint probability distribution that achieves the maximum in equation (45). There exists $\delta>0$ and rate $\mathrm{R} \geq 0$ such that :

It finds the index $m \in \mathcal{M}$ such that the sequences $\left(U^{n}, S^{n}, W_{1}^{n}(m), U^{n}(m)\right) \in$ $A_{\varepsilon}^{\star n}(\mathcal{Q})$ are jointly typical (for probability distribution $\mathcal{Q}_{\mathrm{usw}_{1}} \otimes \mathbb{1}_{u \mid u}$ ). Encoder sends a sequence $X^{n}$ drawn from the conditional probability distribution $\mathcal{Q}_{\times \mid \text {usw }}^{\otimes n}$ depending on sequences $\left(S^{n}, W_{1}^{n}(m), U^{n}(m)\right)$.
- Decoding function. The decoder observes the pair of sequences $\left(Y^{n}, Z^{n}\right)$ and finds the index $m \in \mathcal{M}$ such that the sequences $\left(Y^{n}, Z^{n}, W_{1}^{n}(m), U^{n}(m)\right) \in A_{\varepsilon}^{\star n}(\mathcal{Q})$ are jointly typical. Decoder returns the sequence $\hat{U}^{n}=U^{n}(m)$.

From the properties of typical sequences, packing and covering Lemmas stated in [9] pp. 27, 46 and 208, equations (47), (48), imply there exists a $\bar{n} \in \mathbb{N}$ such that the expected probability of error events are bounded by $\varepsilon$ for all $n \geq \bar{n}$ :

The cardinality bound is stated in Lemma 6 in the Appendix. This concludes the achievability proof of Theorem III.1.

An alternative achievability proof based on superposition coding can be found in [4] and [5].

## IV. Separation between Source and Channel



Fig. 4. Random variables of the source $(U, Z, V)$ are independent of the random variables of the channel $(S, X, Y)$.

Remark IV. 2 This separation result was already stated in [6] for a given distortion level and a given channel cost.

## A. Achievability Proof

The achievability proof is based on the combination of the achievability proof of Gel'fand Pinsker [3] and the achievability proof of Wynzer Ziv [2].

- Encoding function. Encoder observes the source sequence $U^{n}$ and find the indexes $\left(m, l_{2}\right) \in$ $\mathcal{M} \times \mathcal{M}_{\mathrm{L}_{2}}$ such that $\left(U^{n}, W_{2}^{n}\left(m, l_{2}\right)\right) \in A_{\varepsilon}^{\star n}(\mathcal{Q})$ are jointly typical. For each index $m \in \mathcal{M}$, it finds an index $l_{1} \in \mathcal{M}_{\mathrm{L}_{1}}$ such that $\left(S^{n}, W_{1}^{n}\left(m, l_{1}\right)\right) \in A_{\varepsilon}^{\star n}(\mathcal{Q})$ are jointly typical. Encoder sends the sequence $X^{n}$ drawn from the probability $\mathcal{Q}_{\times \mid \text {sw }_{1}}^{\otimes n}$ depending on $\left(S^{n}, W_{1}^{n}\left(m, l_{1}\right)\right)$.
- Decoding function. The decoder observes the output sequence $Y^{n}$ and the sequence of state information $Z^{n}$. It finds the pair of indexes $\left(m, l_{1}\right) \in \mathcal{M} \times \mathcal{M}_{\mathrm{L}_{1}}$ such that $\left(Y^{n}, W_{1}^{n}\left(m, l_{1}\right)\right) \in A_{\varepsilon}^{\star n}(\mathcal{Q})$. It finds the index $l_{2} \in \mathcal{M}_{\mathrm{L}_{2}}$ such that $\left(Z^{n}, W_{2}^{n}\left(m, l_{2}\right)\right) \in A_{\varepsilon}^{\star n}(\mathcal{Q})$. It returns the sequence $V^{n}$ drawn from the probability $\mathcal{Q}_{\mathrm{v} \mid \mathrm{zw}}^{2} \mathrm{~m}$ depending on $\left(Z^{n}, W_{2}^{n}\right)$.

From the properties of typical sequences, packing and covering Lemmas stated in [9] pp. 27, 46 and 208, equations (81), (82), (83), (84) imply there exists a $\bar{n} \in \mathbb{N}$ such that the expected probability of

The cardinality bound is stated in Lemma 6 in the Appendix. This concludes the achievability proof of Theorem IV.1.

= & \sum_{i=1}^{n} I\left(U^{n}, Y^{i-1}, S_{i+1}^{n} ; Y_{i} \mid E=0\right)-\sum_{i=1}^{n} I\left(S_{i+1}^{n} ; Y_{i} \mid U^{n}, Y^{i-1}, E=0\right)  \tag{94}\\

Equations (92), (93) and (94) come from the properties of the mutual information.
Equation (95) comes from Csiszár Sum Identity stated pp. 25 in [9].
Equation (96) comes from the i.i.d. property of the information source $U$ and the independence with the channel states $S$, hence by Lemma 10 in the Appendix: $\sum_{i=1}^{n} I\left(S_{i} ; U^{n}, S_{i+1}^{n} \mid E=0\right) \leq n \cdot \varepsilon$.
Equation (97) comes from the introduction of the auxiliary random variable $W_{1, i}=\left(U^{n}, Y^{i-1}, S_{i+1}^{n}\right)$. The Markov chain property $Y_{i} \rightarrow\left(X_{i}, S_{i}\right) \multimap W_{1, i}$ is satisfied since the channel is memoryless and $Y_{i}$ is not included in $W_{1, i}$.

Lower Bound. For every code, the random variables satisfy the following equations:

Equation (98) comes from the Markov chain $Z^{n} \multimap U^{n} \multimap Y^{n}$.
Equations (99) and (100) come from the properties of the mutual information.
Equation (101) comes from the i.i.d. property of the information sources $(U, Z)$ and Lemma 10 in the Appendix that implies $\sum_{i=1}^{n} I\left(U_{i} ; Z^{-i}, U^{i-1} \mid Z_{i}, E=0\right) \leq n \cdot \varepsilon$.
Equation (102) comes from the properties of the mutual information.
Equation (103) comes from the Markov chain property $Z_{i} \rightarrow U_{i} \oslash\left(Y^{n}, Z^{-i}, U^{i-1}\right)$ that is valid for all $i \in\{1, \ldots, n\}$. This comes from the i.i.d. property of the source $(U, Z)$.
Equation (104) comes from the introduction of the auxiliary random variable $W_{2, i}=\left(Y^{n}, Z^{-i}, U^{i-1}\right)$. The random variable $W_{2, i}$ satisfies the Markov Chains that correspond to the set of product probability distributions $\mathbb{Q}_{s}$ for the separation between source and channel:

- The second Markov chain comes from the non-causal decoding: $V_{i}$ is a function of $\left(Y^{n}, Z^{n}\right)$ that is included in $\left(Z_{i}, W_{2, i}\right)=\left(Z_{i}, Y^{n}, Z^{-i}, U^{i-1}\right)$.

Combining upper and lower bounds. Equations (97) and (104) give equation (107):

Equation (108) comes from the introduction of the uniform random variable $T$ over $\{1, \ldots, n\}$ and the corresponding mean random variables $U_{T}, S_{T}, Z_{T}, W_{1, T}, W_{2, T}, X_{T}, Y_{T}, V_{T}$.

Equation (109) comes from the independence of $T$ with $S_{T}$ and with $U_{T}$ as stated in Lemma 11 in the Appendix. This implies $I\left(T ; S_{T} \mid E=0\right)=I\left(T ; U_{T} \mid E=0\right)=0$.

Equation (110) comes from replacing the mean random variables $\left(U_{T}, S_{T}, Z_{T}, X_{T}, Y_{T}, V_{T}\right)$ by the random variables $(U, S, Z, X, Y, V)$ with probability distribution $\mathcal{Q}(u, z, v) \otimes \mathcal{Q}(s, x, y)$. Lemma 9 states that the probability distribution induced by the coding scheme $\mathcal{P}\left(\left(S_{T}, U_{T}, Z_{T}, X_{T}, Y_{T}, V_{T}\right)=\right.$ $(s, u, z, x, y, v) \mid E=0)$ is closed to the target probability distribution $\mathcal{Q}(u, z, v) \otimes \mathcal{Q}(s, x, y)$. It remains to apply the continuity of the entropy function stated pp. 33 in [10] to obtain this upper bound with the additional error term: $n \cdot \varepsilon$.

Equation (111) comes from identifying $W_{1}$ and $W_{2}$ with $\left(W_{1, T}, T\right)$ and ( $W_{2, T}, T$ ) and taking the maximum over the distributions $\mathcal{Q}\left(u, z, w_{2}, v\right) \otimes \mathcal{Q}\left(s, x, w_{1}, y\right) \in \mathbb{Q}_{s}$. Auxiliary random variables $W_{1}=\left(W_{1, T}, T\right)$ and $W_{2}=\left(W_{2, T}, T\right)$ satisfy the three Markov chains of the set $\mathbb{Q}_{s}$ as stated in Lemma 7 in the Appendix:

Remark IV. 3 By construction, $W_{1}$ and $W_{2}$ are correlated since $W_{1, i}=\left(U^{n}, Y^{i-1}, S_{i+1}^{n}\right)$ and $W_{2, i}=$ ( $Y^{n}, Z^{-i}, U^{i-1}$ ) have a common part, namely $\left(U^{i-1}, Y^{i-1}\right)$. However, the random variables of the channel $(S, X, Y)$ are independent of ones of the source $(U, Z, V)$. Hence, the optimal distribution for maximizing the first term $I\left(W_{1} ; Y\right)-I\left(W_{1} ; S\right)$ of equation (111) does not depends on the distribution of random variables $W_{2}$ and $(U, Z, V)$. Similarly, the optimal distribution for maximizing the second term $I\left(W_{2} ; Z\right)-I\left(W_{2} ; U\right)$ of equation (111) does not depends on the distribution of random variables $W_{1}$ and $(S, X, Y)$. $\max _{\mathcal{Q}_{X r}}(\mathbb{E}[f(X)]+\mathbb{E}[g(Y)])=\max _{\mathcal{Q}_{X}} \mathbb{E}[f(X)]+\max _{\mathcal{Q}_{r}} \mathbb{E}[g(Y)]=\max _{\mathcal{Q}_{X} \otimes \mathcal{Q}_{r}}(\mathbb{E}[f(X)]+\mathbb{E}[g(Y)])$.
Hence, the optimal distribution $\mathcal{Q} \in \mathbb{Q}_{s}$ for the optimization problem of equation (111) is a product of independent probability distributions $\mathcal{Q}\left(u, z, w_{2}, v\right) \otimes \mathcal{Q}\left(s, x, w_{1}, y\right)$. ## V. Causal Decoding

## Theorem V. 1 (Causal Decoding)

1) Joint probability distribution $\mathcal{Q}(u, s, z, x, y, v)$ is achievable if and only if it decomposes as follows:

and $\mathcal{P}_{\text {usz }}(u, s, z) \otimes \mathcal{Q}(x \mid u, s) \otimes \mathcal{T}(y \mid x, s) \otimes \mathcal{Q}(v \mid u, s, z, x, y)$ is achievable.
2) Joint probability distribution $\mathcal{P}_{\mathrm{usz}}(u, s, z) \otimes \mathcal{Q}(x \mid u, s) \otimes \mathcal{T}(y \mid x, s) \otimes \mathcal{Q}(v \mid u, s, z, x, y)$ is achievable if:

where $\mathbb{Q}_{\mathrm{d}}$ is the set of distributions $\mathcal{Q} \in \Delta\left(\mathcal{U} \times \mathcal{S} \times \mathcal{Z} \times \mathcal{W}_{1} \times \mathcal{W}_{2} \times \mathcal{X} \times \mathcal{Y} \times \mathcal{V}\right)$ with auxiliary random variables $\left(W_{1}, W_{2}\right)$ that satisfies:

The probability distribution $\mathcal{Q} \in \mathbb{Q}_{\mathrm{d}}$ decomposes as follows:

The supports of the auxiliary random variables $\left(W_{1}, W_{2}\right)$ are bounded by: $\max \left(\left|\mathcal{W}_{1}\right|,\left|\mathcal{W}_{2}\right|\right) \leq(|\mathcal{B}|+$ 1) $\cdot(|\mathcal{B}|+2)$ with $\mathcal{B}=\mathcal{U} \times \mathcal{S} \times \mathcal{Z} \times \mathcal{X} \times \mathcal{Y} \times \mathcal{V}$.

Remark V. 2 Note that the last Markov chain is different from the previous results for coordination since $V$ is generated using $\mathcal{Q}\left(v \mid y, z, w_{2}\right)$ instead of $\mathcal{Q}\left(v \mid y, z, w_{1}, w_{2}\right)$.

Remark V. 3 This result was already stated in [7] without considering state informations at the encoder $S$ and at the decoder $Z$.

## A. Achievability Proof

We consider a probability distribution $\mathcal{Q} \in \mathbb{Q}_{\mathrm{d}}$ that satisfies equation (116). There exists a $\delta>0$ and rates $R \geq 0, R_{L} \geq 0$ such that:

We consider a block-Markov random code $c \in \mathcal{C}(n)$ defined over $B \in \mathbb{N}$ blocs of length $n \in \mathbb{N}$. The total length of the code is denoted by $N=n \cdot B \in \mathbb{N}$.

- Random codebook. We generate $|\mathcal{M}|=2^{n \mathrm{R}}$ sequences $W_{2}^{n}(m)$ drawn from the i.i.d. probability distribution $\mathcal{Q}_{\mathrm{W}_{2}}^{\otimes n}$ with index $m \in \mathcal{M}$. We generate $\left|\mathcal{M} \times \mathcal{M}_{\mathrm{L}}\right|=2^{n\left(\mathrm{R}+\mathrm{R}_{\mathrm{L}}\right)}$ sequences $W_{1}^{n}(m, l)$ drawn from the i.i.d. probability distribution $\mathcal{Q}_{\mathrm{w}_{1}}^{\otimes n}$ with indexes $(m, l) \in \mathcal{M} \times \mathcal{M}_{\mathrm{L}}$.
- Encoding function. At block $b \in\{2, \ldots B-1\}$, the encoder observes the sequence of symbols of source and state $\left(U_{b+1}^{n}, S_{b+1}^{n}\right) \in \mathcal{U}^{n} \times \mathcal{S}^{n}$ over the next block $b+1$. It finds an index $m \in \mathcal{M}$ such that the sequences $\left(U_{b+1}^{n}, S_{b+1}^{n}, W_{2, b+1}^{n}(m)\right) \in A_{\varepsilon}^{\star n}(\mathcal{Q})$ are jointly typical. Encoder observes the jointly typical sequences of symbols $\left(U_{b}^{n}, S_{b}^{n}, W_{2, b}^{n}\right) \in \mathcal{U}^{n} \times \mathcal{S}^{n} \times \mathcal{W}_{2}^{n}$ of the current block $b$ and finds the index $l \in \mathcal{M}_{\mathrm{L}}$ such that the sequences $\left(U_{b}^{n}, S_{b}^{n}, W_{2, b}^{n}, W_{1, b}^{n}(m, l)\right) \in A_{\varepsilon}^{\star n}(\mathcal{Q})$ are jointly typical. Encoder sends the sequence $X_{b}^{n}$ drawn from the transition probability $\mathcal{Q}_{\times \times{ }^{\otimes} \text { usw }_{1} w_{2}}^{\otimes n}$ depending on the sequences $\left(U_{b}^{n}, S_{b}^{n}, W_{2, b}^{n}, W_{1, b}^{n}(m, l)\right)$ of block $b \in \mathbb{N}$.
- Decoding function. At the end of block $b \in\{2, \ldots B-1\}$, the decoder observes the pair of sequences $\left(Y_{b}^{n}, Z_{b}^{n}\right)$ and recalls the sequence $W_{2, b}^{n}$ of block $b \in \mathbb{N}$. It finds the indexes $(m, l) \in \mathcal{M} \times \mathcal{M}_{\mathrm{L}}$ such that $\left(Y_{b}^{n}, Z_{b}^{n}, W_{2, b}^{n}, W_{1, b}^{n}(m, l)\right) \in A_{\varepsilon}^{\star n}(\mathcal{Q})$ are jointly typical. It deduces the sequence $W_{2, b+1}^{n}(m)$ corresponding to index $m \in \mathcal{M}$ over the block $b+1 \in \mathbb{N}$. In the next block $b+1 \in \mathbb{N}$, it returns the sequence $V_{b+1}^{n}$ drawn from the transition probability $\mathcal{Q}_{\mathrm{v} \mid \mathrm{yzw}_{2}}^{\otimes n}$ depending on the sequences $\left(Y_{b+1}^{n}, Z_{b+1}^{n}, W_{2, b+1}^{n}(m)\right)$.
- First bloc. Encoder finds the index $m \in \mathcal{M}$ such that the sequences $\left(U_{b_{2}}^{n}, S_{b_{2}}^{n}, W_{2, b_{2}}^{n}(m)\right) \in A_{\varepsilon}^{\star n}$ are jointly typical in the second block $b_{2}$. It sends index $m \in \mathcal{M}$ to the decoder using classical Gel'fand

Pinsker [3] coding scheme. Decoder returns an arbitrary sequence of symbols $V^{n} \in \mathcal{V}^{n}$.

Remark V. 4 In the first bloc, Gel'fand Pinsker [3] coding scheme can be used to transmit index $m \in \mathcal{M}$. Consider $(U, S)$ as state information for the encoder, $Y$ as decoder output and $Z$ as state information of the decoder. Equation (116) proves that there exists a distribution $\mathcal{Q}_{\mathrm{xw} \mid \text { us }}$ such that $I(W ; Y, Z)-I(W ; U, S)>0$.

Hence Gel'fand Pinsker [3] coding scheme can be used at a rate strictly greater than $I\left(W_{2} ; Y, Z\right)$. If it is necessary, the length $n \in \mathbb{N}$ of the first block can be adapted to transmit the index $m \in \mathcal{M}$ reliably.

- Last bloc. Encoder sends a sequence of symbols $X_{B}^{n} \in \mathcal{X}^{n}$ jointly typical with the sequences $\left(U_{B}^{n}, S_{B}^{n}, W_{2, B}^{n}\right) \in \mathcal{U}^{n} \times \mathcal{S}^{n} \times \mathcal{W}_{2}^{n}$. Decoder returns the sequence $V_{B}^{n}$ drawn from the transition probability $\mathcal{Q}_{\mathrm{v} \mid \mathrm{yzw}_{2}}^{\otimes n}$ depending on the sequences $\left(Y_{B}^{n}, Z_{B}^{n}, W_{2, B}^{n}\right)$. The sequences $\left(U_{B}^{n}, S_{B}^{n}, Z_{B}^{n}, X_{B}^{n}, Y_{B}^{n}, V_{B}^{n}\right) \in A_{\varepsilon}^{\star n}(\mathcal{Q})$ are jointly typical over the last block.

For each block $b \in\{2, \ldots, B\}$, for all $n \geq \bar{n}$, there exists a code $c^{\star} \in \mathcal{C}(n)$ such that sequences $\left(U_{b}^{n}, S_{b}^{n}, Z_{b}^{n}, W_{1, b}^{n}, W_{2, b}^{n}, X_{b}^{n}, Y_{b}^{n}, V_{b}^{n}\right) \in A_{\varepsilon}^{\star n}(\mathcal{Q})$ are jointly typical for distribution $\mathcal{P}_{\text {usz }}(u, s, z) \otimes$ $\mathcal{Q}(x \mid u, s) \otimes \mathcal{Q}\left(w_{1}, w_{2} \mid u, s, x\right) \otimes \mathcal{T}(y \mid x, s) \otimes \mathcal{Q}\left(v \mid y, z, w_{2}\right)$ with probability more than $1-4 \varepsilon$.

We denote by $\widetilde{Q}^{N} \in \Delta(\mathcal{U} \times \mathcal{S} \times \mathcal{Z} \times \mathcal{X} \times \mathcal{Y} \times \mathcal{V})$, the empirical distribution of symbols over every blocs $b \in\{2, \ldots, B\}$ removing the first bloc. We show $\widetilde{Q}^{N}$ is close to the empirical distribution $Q^{N}$ over all the $B$ blocks, for a number of block $B \in \mathbb{N}$ sufficiently large, i.e. for which $\frac{2}{B} \cdot|\mathcal{U} \times \mathcal{S} \times \mathcal{Z} \times \mathcal{X} \times \mathcal{Y} \times \mathcal{V}| \leq \varepsilon$. We denote by $Q_{1}$, the empirical distribution of symbols over the first bloc.

This implies the existence of a code $c^{\star} \in \mathcal{C}(N)$ with an error probability below $(1-4 \varepsilon)^{B-1}$ for all $N \geq B \cdot \bar{n}$.

The cardinality bound is stated in Lemma 6 in the Appendix. This concludes the achievability proof of Theorem V.1.

## B. Converse Proof

Equation (131) comes from Csiszár Sum Identity stated pp. 25 in [9].
Equation (132) comes from the i.i.d. property of the information source $(U, S)$ that implies $I\left(U_{i}, S_{i} ; U_{i+1}^{n}, S_{i+1}^{n}\right)=0$ for all $i \in\{1, \ldots, n\}$.
Equation (133) comes from the introduction of the auxiliary random variables $W_{1, i}=\left(U_{i+1}^{n}, S_{i+1}^{n}\right)$ and $W_{2, i}=\left(Y^{i-1}, Z^{i-1}\right)$. The two random variables $\left(W_{1, i}, W_{2, i}\right)$ satisfy the Markov Chains corresponding to the set of probability distributions $\mathbb{Q}_{\mathrm{d}}$ :

- The first Markov chain comes from i.i.d. property of the source and the fact that $Z_{i}$ does not belong to $\left(W_{1, i}, W_{2, i}\right)$.
- The second Markov chain comes from memoryless property of the channel and the fact that $Y_{i}$ does not belong to ( $W_{1, i}, W_{2, i}$ ).
- The third Markov chain comes from the causal decoding: $V_{i}$ is a function of $\left(Y^{i}, Z^{i}\right)$ that corresponds to $\left(Y_{i}, Z_{i}, Y^{i-1}, Z^{i-1}\right)=\left(Y_{i}, Z_{i}, W_{2, i}\right)$.

Equation (138) comes from the introduction of the uniform random variable $T$ over $\{1, \ldots, n\}$ and the introduction of the corresponding mean random variables $U_{T}, S_{T}, Z_{T}, W_{1, T}, W_{2, T}, X_{T}, Y_{T}, V_{T}$.

Equation (139) comes from the i.i.d. property of the information source that implies $I\left(T ; U_{T}, S_{T}\right)=0$. Equation (140) comes from identifying $W_{1}$ and $W_{2}$ with $W_{1, T}$ and $\left(W_{2, T}, T\right)$ and taking the maximum over the probability distributions that belong to $\mathbb{Q}_{\mathrm{d}}$. This is made possible since the random variables $W_{1, T}$ and $\left(W_{2, T}, T\right)$ satisfies the three Markov chains of the set of probability distributions $\mathbb{Q}_{\mathrm{d}}$, as stated in Lemma 7 in the Appendix.

Equation (141) comes from the empirical coordination requirement as stated in Lemma 8 in the Appendix. Sequences are not jointly typical with small error probability $\mathcal{P}(E=1)$.
Equation (142) comes from Lemma 9 that states that the probability distribution induced by the coding scheme $\mathcal{P}\left(\left(U_{T}, S_{T}, Z_{T}, X_{T}, Y_{T}, V_{T}\right)=(u, s, z, x, y, v) \mid E=0\right)$ is closed to the target probability distribution $\mathcal{Q}(u, s, z, x, y, v)$. The continuity of the entropy function stated pp .33 in [10] concludes.

This concludes the converse proof of Theorem V.1.

The supports of the auxiliary random variables $\left(W_{1}, W_{2}\right)$ are bounded by $\max \left(\left|\mathcal{W}_{1}\right|,\left|\mathcal{W}_{2}\right|\right) \leq(|\mathcal{B}|+1)$. $(|\mathcal{B}|+2)$ with $\mathcal{B}=\mathcal{U} \times \mathcal{S} \times \mathcal{Z} \times \mathcal{X} \times \mathcal{Y} \times \mathcal{V}$.

Remark VI. 2 This result was already stated in [1] without considering state informations at the encoder $S$ and at the decoder $Z$.

## A. Achievability Proof

We consider a probability distribution $\mathcal{Q} \in \mathbb{Q}_{\mathrm{e}}$ that achieves the maximum in equation (144). There exists a $\delta>0$ and a rate $\mathrm{R}>0$ such that:

We consider a block-Markov random code $c \in \mathcal{C}(n)$ defined over $B \in \mathbb{N}$ blocs of length $n \in \mathbb{N}$. The total length of the code is denoted by $N=n \cdot B \in \mathbb{N}$ and R denotes the rate of the code.

- Random codebook. We generate $|\mathcal{M}|=2^{n \mathrm{R}}$ sequences $W_{1}^{n}(m)$ drawn from the i.i.d. probability distribution $\mathcal{Q}_{\mathrm{w}_{1}}^{\otimes n}$ with index $m \in \mathcal{M}$. For each index $m \in \mathcal{M}$, we generate the same number $|\mathcal{M}|=2^{n \mathrm{R}}$ of sequences $W_{2}^{n}(m, \hat{m})$ with index $\hat{m} \in \mathcal{M}$, drawn from the i.i.d. conditional probability distribution $\mathcal{Q}_{\mathrm{w}_{2} \mid w_{1}}^{\otimes n}$ depending on sequence $W_{1}^{n}(m)$.
- Encoding function. At the beginning of block $b \in\{2, \ldots B-1\}$, the encoder observes the sequences of source symbols $\left(U_{b-1}^{n}, S_{b-1}^{n}\right) \in \mathcal{U}^{n} \times \mathcal{S}^{n}$ of the previous block $b-1$. It also recalls the index $m_{b-1} \in \mathcal{M}$ of the sequence $W_{1}^{n}\left(m_{b-1}\right) \in \mathcal{W}_{1}^{n}$ over block $b-1$. It finds index $m_{b} \in \mathcal{M}$ such that the sequences $\left(U_{b-1}^{n}, S_{b-1}^{n}, W_{1}^{n}\left(m_{b-1}\right), W_{2}^{n}\left(m_{b-1}, m_{b}\right)\right) \in A_{\varepsilon}^{\star n}(\mathcal{Q})$ are jointly typical. It deduces the sequence $W_{1}^{n}\left(m_{b}\right)$ corresponding to the current block $b \in\{2, \ldots B-1\}$. Encoder sends the sequence $X_{b}^{n}$ drawn from the conditional probability $\mathcal{Q}_{\times \mid \text {usw }}^{1} \boldsymbol{\otimes n}$ depending on sequences $W_{1}^{n}\left(m_{b}\right)$ and $\left(U_{b}^{n}, S_{b}^{n}\right)$ observed causally on the current block $b \in\{2, \ldots B-1\}$.

Remark VI. 3 An alternative encoder can choose index $m_{b} \in \mathcal{M}$ such that the sequences $\left(U_{b-1}^{n}, S_{b-1}^{n}, X_{b-1}^{n}, W_{1}^{n}\left(m_{b-1}\right), W_{2}^{n}\left(m_{b-1}, m_{b}\right)\right) \in A_{\varepsilon}^{\star n}(\mathcal{Q})$ are jointly typical, including with sequence $X_{b-1}^{n}$. This alternative encoder introduces more correlation between the random variables and the Markov chain $X \rightarrow\left(U, S, W_{1}\right) \ominus W_{2}$ is removed. However the corresponding rate constraint writes $I\left(W_{2} ; U, S, X \mid W_{1}\right)=I\left(W_{2} ; U, S \mid W_{1}\right)+I\left(W_{2} ; X \mid W_{1}, U, S\right)$. Hence, the price of removing the Markov chain $X \rightarrow\left(U, S, W_{1}\right) \multimap W_{2}$ is equal to $I\left(W_{2} ; X \mid W_{1}, U, S\right)$ and the converse proof concludes it is not optimal.

- Decoding function. At the end of block $b \in\{2, \ldots B-1\}$, the decoder recalls sequences $\left(Y_{b-1}^{n}, Z_{b-1}^{n}\right)$ and the index $m_{b-1} \in \mathcal{M}$ corresponding to the sequence $W_{1}^{n}\left(m_{b-1}\right)$. It observes
the sequences $\left(Y_{b}^{n}, Z_{b}^{n}\right)$ and finds index $m_{b} \in \mathcal{M}$ such that $\left(Y_{b}^{n}, Z_{b}^{n}, W_{1}^{n}\left(m_{b}\right)\right) \in A_{\varepsilon}^{\star n}(\mathcal{Q})$ and $\left(Y_{b-1}^{n}, Z_{b-1}^{n}, W_{1}^{n}\left(m_{b-1}\right), W_{2}^{n}\left(m_{b-1}, m_{b}\right)\right) \in A_{\varepsilon}^{\star n}(\mathcal{Q})$ are jointly typical. Decoder returns sequence $V_{b-1}^{n}$ drawn from the conditional probability distribution $\mathcal{Q}_{\mathrm{v} \mid y z w_{1} w_{2}}^{\otimes n}$ depending on sequences $\left(Y_{b-1}^{n}, Z_{b-1}^{n}, W_{1}^{n}\left(m_{b-1}\right), W_{2}^{n}\left(m_{b-1}, m_{b}\right)\right)$.
- First bloc at the encoder. An arbitrary index $m_{1} \in \mathcal{M}$ of $W_{1}^{n}\left(m_{1}\right) \in \mathcal{W}_{1}^{n}$ is given to both encoder $\mathcal{C}$ and decoder $\mathcal{D}$. Encoder sends the sequence $X_{b_{1}}^{n}$ drawn from the conditional probability distribution
 At the beginning of the second bloc $b_{2}$, encoder recalls $\left(U_{b_{1}}^{n}, S_{b_{1}}^{n}, W_{1}^{n}\left(m_{1}\right)\right)$ and finds index $m_{2}$ such that sequences $\left(U_{b_{1}}^{n}, S_{b_{1}}^{n}, W_{1}^{n}\left(m_{1}\right), W_{2}^{n}\left(m_{1}, m_{2}\right)\right) \in A_{\varepsilon}^{\star n}(\mathcal{Q})$ are jointly typical. Encoder sends the sequence $X_{b_{2}}^{n}$ drawn from the conditional probability $\mathcal{Q}_{\times \mid \text {usw }}^{\otimes n}$ depending on sequences $W_{1}^{n}\left(m_{2}\right)$ and $\left(U_{b_{2}}^{n}, S_{b_{2}}^{n}\right)$ observed causally on the second block $b_{2}$.
- First bloc at the decoder. At the end of second block $b_{2}$, the decoder finds the index $m_{2}$ such that $\left(Y_{b_{2}}^{n}, Z_{b_{2}}^{n}, W_{1}^{n}\left(m_{2}\right)\right) \in A_{\varepsilon}^{\star n}(\mathcal{Q})$ and $\left(Y_{b_{1}}^{n}, Z_{b_{1}}^{n}, W_{1}^{n}\left(m_{1}\right), W_{2}^{n}\left(m_{1}, m_{2}\right)\right) \in A_{\varepsilon}^{\star n}(\mathcal{Q})$ are jointly typical. Over the first bloc, decoder $\mathcal{D}$ returns $V_{b_{1}}^{n} \in \mathcal{V}^{n}$ drawn from the conditional probability $\mathcal{Q}_{\mathrm{v}^{\left(y z w_{1} w_{2}\right.}}^{\otimes n}$ depending on sequences $\left(Y_{b_{1}}^{n}, Z_{b_{1}}^{n}, W_{1}^{n}\left(m_{1}\right), W_{2}^{n}\left(m_{1}, m_{2}\right)\right)$. Sequences $\left(U_{b_{1}}^{n}, S_{b_{1}}^{n}, Z_{b_{1}}^{n}, W_{1}^{n}\left(m_{1}\right), W_{2}^{n}\left(m_{1}, m_{2}\right), X_{b_{1}}^{n}, Y_{b_{1}}^{n}, V_{b_{1}}^{n}\right) \in A_{\varepsilon}^{\star n}(\mathcal{Q})$ are jointly typical over the first block $b_{1}$.
- Last bloc. Encoder $\mathcal{C}$ and decoder $\mathcal{D}$ choose arbitrary sequences $X_{B}^{n}$ and $V_{B}^{n}$. Sequences are not jointly typical on the last block.

Remark VI. 4 The source and state $(U, S)$ are jointly encoded using two streams of information represented by the auxiliary random variables $W_{1}$ and $W_{2}$. Auxiliary random variable $W_{2}$ is used to quantify the past source and the past codeword $\left(U, S, W_{1}\right)$. The quantification index is transmitted in the next block using codeword $W_{1}$. This process works in this way from one block to another.

For each block $b \in\{1, \ldots, B-1\}$, the properties of typical sequences, packing and covering lemmas stated in [9] pp. 27, 46 and 208, equations (146), (147) imply there exists a $\bar{n} \in \mathbb{N}$ such that the expected

probability of error events are bounded by $\varepsilon$ for all $n \geq \bar{n}$ :

& \leq n \cdot \max _{\mathcal{Q} \in \mathbb{Q}}\left(I\left(W_{1}, W_{2} ; Y_{T}, Z_{T} \mid E=0\right)-I\left(W_{2} ; U_{T}, S_{T} \mid W_{1}, E=0\right)+\varepsilon\right)  \tag{175}\\
& =n \cdot \max _{\mathcal{Q} \in \mathbb{Q}}\left(I\left(W_{1}, W_{2} ; Y, Z\right)-I\left(W_{2} ; U, S \mid W_{1}\right)+2 \varepsilon\right) . \tag{176}

Equation (173) comes from the introduction of the uniform random variable $T$ over $\{1, \ldots, n\}$ and the introduction of the corresponding mean random variables $U_{T}, S_{T}, Z_{T}, W_{1, T}, W_{2, T}, X_{T}, Y_{T}, V_{T}$.

Equation (174) comes from identifying $W_{1}$ and $W_{2}$ with $\left(W_{1, T}, T\right)$ and $W_{2, T}$ and taking the maximum over the probability distributions that belong to the set $\mathbb{Q}_{\mathrm{e}}$. This is possible since the random variables $\left(W_{1, T}, T\right)$ and $W_{2, T}$ satisfy the properties of the set of probability distributions $\mathbb{Q}_{\mathrm{e}}$ as stated in Lemma 7 in the Appendix.

Equation (175) comes from the empirical coordination requirement as stated in Lemma 8 in the Appendix. Sequences are not jointly typical with small error probability $\mathcal{P}(E=1)$.

Equation (176) comes from Lemma 9 that states that the probability distribution induced by the coding scheme $\mathcal{P}\left(\left(U_{T}, S_{T}, Z_{T}, X_{T}, Y_{T}, V_{T}\right)=(u, s, z, x, y, v) \mid E=0\right)$ is closed to the target probability distribution $\mathcal{Q}(u, s, z, x, y, v)$. The continuity of the entropy function stated pp .33 in [10] concludes.

This concludes the proof of Theorem VI.1.

Lemma 3 Markov chain $V_{i} \rightarrow\left(Y_{i}, Z_{i}, W_{1, i}, W_{2, i}\right) \multimap\left(U_{i}, S_{i}, X_{i}\right)$ is satisfied for all $i \in\{1, \ldots, n\}$.

Equation (179) comes from the i.i.d. property of the information source: $Z^{i-1}$ only depends on $\left(U^{i-1}, S^{i-1}\right)$.
Equation (180) comes from the causal encoding: $X^{i-1}$ is a deterministic function of $\left(U^{i-1}, S^{i-1}\right)$.
Equation (181) comes from the memoryless property of the channel: $Y^{i-1}$ only depends on ( $X^{i-1}, S^{i-1}$ ). Equation (182) comes from the non-causal decoding: $V_{i}$ is a deterministic function of $\left(Y^{n}, Z^{n}\right)=$ $\left(Y^{i-1}, Y_{i}, Y_{i+1}^{n}, Z^{i-1}, Z_{i}, Z_{i+1}^{n}\right)$.

Hence we have:

The above equation corresponds to the Markov chain $V_{i} \rightarrow\left(Y_{i}, Z_{i}, W_{1, i}, W_{2, i}\right) \multimap\left(U_{i}, S_{i}, X_{i}\right)$ and it concludes the proof of Lemma 3.

## VII. Strictly Causal Decoding



Fig. 7. Non-causal encoding function $f: \mathcal{U}^{n} \times \mathcal{S}^{n} \rightarrow \mathcal{X}^{n}$ and strictly causal decoding function $g_{i}: \mathcal{Y}^{i-1} \times \mathcal{Z}^{i-1} \rightarrow \mathcal{V}$ for all $i \in\{1, \ldots, n\}$.

## Theorem VII. 1 (Strictly Causal Decoding)

1) Joint probability distribution $\mathcal{Q}(u, s, z, x, y, v)$ is achievable if and only if it decomposes as follows:

2) Joint probability distribution $\mathcal{P}_{\text {usz }}(u, s, z) \otimes \mathcal{Q}(x, v \mid u, s) \otimes \mathcal{T}(y \mid x, s)$ is achievable if:

where $\mathbb{Q}_{\text {sd }}$ is the set of distributions $\mathcal{Q} \in \Delta\left(\mathcal{U} \times \mathcal{S} \times \mathcal{Z} \times \mathcal{W}_{1} \times \mathcal{X} \times \mathcal{Y} \times \mathcal{V}\right)$ with auxiliary random variable $W_{1}$ that satisfies:

The probability distribution $\mathcal{Q} \in \mathbb{Q}_{\text {sd }}$ decomposes as follows:

The supports of the auxiliary random variable $W_{1}$ is bounded by: $\left|\mathcal{W}_{1}\right| \leq|\mathcal{B}|+1$ with $\mathcal{B}=\mathcal{U} \times \mathcal{S} \times$ $\mathcal{Z} \times \mathcal{X} \times \mathcal{Y} \times \mathcal{V}$.

Remark VII. 2 Strictly causal decoding requires the output of the decoder $V$ is not directly correlated with $(Y, Z)$. Hence, the general probability distributions $\mathcal{P}_{\text {usz }}(u, s, z) \otimes \mathcal{Q}(x \mid u, s) \otimes \mathcal{T}(y \mid x, s) \otimes$ $\mathcal{Q}(v \mid u, s, z, x, y)$ reduces to $\mathcal{P}_{\text {usz }}(u, s, z) \otimes \mathcal{Q}(x, v \mid u, s) \otimes \mathcal{T}(y \mid x, s)$.

Remark VII. 3 This result was already stated in [7] without considering state informations at the encoder $S$ and at the decoder $Z$.

## A. Achievability Proof

The achievability proof is very similar to the one of Theorem V. 1 for causal decoding replacing $W_{2}$ by $V$. We consider a probability distribution $\mathcal{Q} \in \mathbb{Q}_{\text {sd }}$ that satisfies equation (187). There exists a $\delta>0$ and rates $R \geq 0, R_{L} \geq 0$ such that:

We consider a block-Markov random code $c \in \mathcal{C}(n)$ defined over $B \in \mathbb{N}$ blocs of length $n \in \mathbb{N}$. The total length of the code is denoted by $N=n \cdot B \in \mathbb{N}$.

- Random codebook. We generate $|\mathcal{M}|=2^{n \mathrm{R}}$ sequences $V^{n}(m)$ drawn from the i.i.d. probability distribution $\mathcal{Q}_{\mathrm{V}}^{\otimes n}$ with index $m \in \mathcal{M}$. We generate $\left|\mathcal{M} \times \mathcal{M}_{\mathrm{L}}\right|=2^{n\left(\mathrm{R}+\mathrm{R}_{\mathrm{L}}\right)}$ sequences $W_{1}^{n}(m, l)$ drawn from the i.i.d. probability distribution $\mathcal{Q}_{\mathrm{w}_{1}}^{\otimes n}$ with indexes $(m, l) \in \mathcal{M} \times \mathcal{M}_{\mathrm{L}}$.
- Encoding function. At block $b \in\{2, \ldots B-1\}$, the encoder observes the sequence of symbols of source and state $\left(U_{b+1}^{n}, S_{b+1}^{n}\right) \in \mathcal{U}^{n} \times \mathcal{S}^{n}$ of the next block $b+1$. It finds an index $m \in \mathcal{M}$ such that the sequences $\left(U_{b+1}^{n}, S_{b+1}^{n}, V_{b+1}^{n}(m)\right) \in A_{\varepsilon}^{\star n}(\mathcal{Q})$ are jointly typical. Encoder observes the jointly typical sequences of symbols $\left(U_{b}^{n}, S_{b}^{n}, V_{b}^{n}\right) \in \mathcal{U}^{n} \times \mathcal{S}^{n} \times \mathcal{V}^{n}$ of the current block $b$ and finds the index $l \in \mathcal{M}_{\mathrm{L}}$ such that the sequences $\left(U_{b}^{n}, S_{b}^{n}, V_{b}^{n}, W_{1, b}^{n}(m, l)\right) \in A_{\varepsilon}^{\star n}(\mathcal{Q})$ are jointly typical. Encoder sends the sequence $X_{b}^{n}$ drawn from the transition probability $\mathcal{Q}_{\times \mid \text {usvw }}^{\otimes n}$ depending on the sequences $\left(U_{b}^{n}, S_{b}^{n}, V_{b}^{n}, W_{1, b}^{n}(m, l)\right)$ of block $b \in \mathbb{N}$.
- Decoding function. At the end of block $b \in\{2, \ldots B-1\}$, the decoder observes the pair of sequences $\left(Y_{b}^{n}, Z_{b}^{n}\right)$ and recalls the sequence $V_{b}^{n}$ of block $b \in \mathbb{N}$. It finds the indexes $(m, l) \in \mathcal{M} \times \mathcal{M}_{\mathbf{L}}$ such that $\left(Y_{b}^{n}, Z_{b}^{n}, V_{b}^{n}, W_{1, b}^{n}(m, l)\right) \in A_{\varepsilon}^{\star n}(\mathcal{Q})$ are jointly typical. In the next block $b+1 \in \mathbb{N}$, it returns the sequence $V_{b+1}^{n}(m)$ corresponding to index $m \in \mathcal{M}$ over the block $b+1 \in \mathbb{N}$.
- First bloc. Encoder finds the index $m \in \mathcal{M}$ such that the sequences $\left(U_{b_{2}}^{n}, S_{b_{2}}^{n}, V_{b_{2}}^{n}(m)\right) \in A_{\varepsilon}^{\star n}$ are jointly typical in the second block $b_{2}$. It sends index $m \in \mathcal{M}$ to the decoder using classical Gel'fand Pinsker [3] coding scheme. Decoder returns an arbitrary sequence of symbols $V^{n} \in \mathcal{V}^{n}$.

Remark VII. 4 In the first bloc, Gel'fand Pinsker [3] coding scheme can be used to transmit index $m \in \mathcal{M}$. Consider $(U, S)$ as state information of the encoder, $Y$ as decoder output and $Z$ as state information of the decoder. Equation (187) proves that there exists a distribution $\mathcal{Q}_{\mathrm{xw} \mid \text { us }}$ such that $I(W ; Y, Z)-I(W ; U, S)>0$.

Hence Gel'fand Pinsker [3] coding scheme can be used at a rate strictly greater than $I(V ; Y, Z)$. If it is necessary, the length $n \in \mathbb{N}$ of the first block can be adapted to transmit the index $m \in \mathcal{M}$ reliably.

- Last bloc. Encoder sends a sequence of symbols $X_{B}^{n} \in \mathcal{X}^{n}$ jointly typical with the sequences $\left(U_{B}^{n}, S_{B}^{n}, V_{B}^{n}\right) \in \mathcal{U}^{n} \times \mathcal{S}^{n} \times \mathcal{V}^{n}$. Decoder returns the sequence $V_{B}^{n}$. The sequences $\left(U_{B}^{n}, S_{B}^{n}, Z_{B}^{n}, X_{B}^{n}, Y_{B}^{n}, V_{B}^{n}\right) \in A_{\varepsilon}^{\star n}(\mathcal{Q})$ are jointly typical over the last block.

For each block $b \in\{2, \ldots, B\}$, the properties of typical sequences, packing and covering lemmas stated in [9] pp. 27, 46 and 208, equations (189), (190), (191) imply there exists a $\bar{n} \in \mathbb{N}$ such that the expected probability of error events are bounded by $\varepsilon$ for all $n \geq \bar{n}$ :

For each block $b \in\{2, \ldots, B\}$, for all $n \geq \bar{n}$, there exists a code $c^{\star} \in \mathcal{C}(n)$ such that sequences $\left(U_{b}^{n}, S_{b}^{n}, Z_{b}^{n}, W_{1, b}^{n}, X_{b}^{n}, Y_{b}^{n}, V_{b}^{n}\right) \in A_{\varepsilon}^{\star n}(\mathcal{Q})$ are jointly typical for distribution $\mathcal{P}_{\text {usz }}(u, s, z) \otimes \mathcal{Q}(x, v \mid u, s) \otimes$ $\mathcal{Q}\left(w_{1} \mid u, s, x, v\right) \otimes \mathcal{T}(y \mid x, s)$ with probability more than $1-4 \varepsilon$.

The remaining of the proof is very similar to the achievability part of Theorem V.1. The cardinality bound is stated in Lemma 6 in the Appendix. This concludes the achievability proof of Theorem VII.1.

## B. Converse Proof

We consider the joint probability distribution $\mathcal{Q}(u, s, z, x, y, v)$ and we introduce the random event of error $E \in\{0,1\}$ defined as follows:

Consider a sequence of code $c(n) \in \mathcal{C}$ that achieves the probability distribution $\mathcal{Q}(u, s, z, x, y, v)$, i.e. for which the probability of error $\mathcal{P}_{\mathrm{e}}(c)=\mathcal{P}(E=1)$ goes to zero. We have the following equations:

Equation (203) comes from the i.i.d. property of the information source $(U, S)$ that implies $I\left(U_{i}, S_{i} ; U_{i+1}^{n}, S_{i+1}^{n}\right)=0$ for all $i \in\{1, \ldots, n\}$.
Equation (204) comes from the strictly causal decoding that implies $V_{i}$ is a deterministic function of $\left(Y^{i-1}, Z^{i-1}\right)$. Hence, for all $i \in\{1, \ldots, n\}$ we have:

Equation (215) comes from identifying $W_{1}$ with $\left(W_{1, T}, T\right)$ and taking the maximum over the probability distributions that belong to $\mathbb{Q}_{s d}$. This is made possible since the pair of random variables $\left(W_{1, T}, T\right)$ satisfies the three Markov chains of the set of probability distributions $\mathbb{Q}_{\text {sd }}$, as stated in Lemma 7 in the Appendix.

Equation (216) comes from the empirical coordination requirement as stated in Lemma 8 in the Appendix. Sequences are not jointly typical with small error probability $\mathcal{P}(E=1)$.

Equation (217) comes from Lemma 9 that states the probability distribution induced by the coding scheme $\mathcal{P}\left(\left(U_{T}, S_{T}, Z_{T}, X_{T}, Y_{T}, V_{T}\right)=(u, s, z, x, y, v) \mid E=0\right)$ is closed to the target probability distribution $\mathcal{Q}(u, s, z, x, y, v)$. The continuity of the entropy function stated pp. 33 in [10] concludes.

This concludes the converse proof of Theorem VII.1.

Remark VIII. 2 Strictly causal encoding requires the channel input $X$ to be independent of the source and state $(U, S)$. Hence, the general probability distributions $\mathcal{P}_{\text {usz }}(u, s, z) \otimes \mathcal{Q}(x \mid u, s) \otimes \mathcal{T}(y \mid x, s) \otimes$ $\mathcal{Q}(v \mid u, s, z, x, y)$ reduces to $\mathcal{P}_{\text {usz }}(u, s, z) \otimes \mathcal{Q}(x) \otimes \mathcal{T}(y \mid x, s) \otimes \mathcal{Q}(v \mid u, s, x, y, z)$.

Remark VIII. 3 This result was already stated in [1] without considering state informations at the encoder $S$ and at the decoder $Z$.

## A. Achievability Proof

The achievability proof is very similar to the one of Theorem VI. 1 for causal encoding replacing $W_{1}$ by $X$. We consider a probability distribution $\mathcal{Q} \in \mathbb{Q}_{\text {se }}$ that achieves the maximum in equation (219). There exists a $\delta>0$ and a rate $\mathrm{R}>0$ such that:

- Random codebook. We generate $|\mathcal{M}|=2^{n \mathrm{R}}$ sequences $X^{n}(m)$ drawn from the i.i.d. probability distribution $\mathcal{Q}_{x}^{\otimes n}$ with index $m \in \mathcal{M}$. For each index $m \in \mathcal{M}$, we generate the same number $|\mathcal{M}|=2^{n \mathrm{R}}$ of sequences $W_{2}^{n}(m, \hat{m})$ with index $\hat{m} \in \mathcal{M}$, drawn from the i.i.d. conditional probability distribution $\mathcal{Q}_{\mathrm{w}_{2} \mid \times}^{\otimes n}$ depending on sequence $X^{n}(m)$.
- Encoding function. At the beginning of block $b \in\{2, \ldots B-1\}$, the encoder observes the sequences of source symbols $\left(U_{b-1}^{n}, S_{b-1}^{n}\right) \in \mathcal{U}^{n} \times \mathcal{S}^{n}$ of the previous block $b-1$. It also recalls the index $m_{b-1} \in \mathcal{M}$ of the sequence $X^{n}\left(m_{b-1}\right) \in \mathcal{X}^{n}$ over block $b-1$. It finds index $m_{b} \in \mathcal{M}$ such that the sequences $\left(U_{b-1}^{n}, S_{b-1}^{n}, X^{n}\left(m_{b-1}\right), W_{2}^{n}\left(m_{b-1}, m_{b}\right)\right) \in A_{\varepsilon}^{\star n}(\mathcal{Q})$ are jointly typical. Encoder sends the sequence $X^{n}\left(m_{b}\right)$ corresponding to the current block $b \in\{2, \ldots B-1\}$.
- Decoding function. At the end of block $b \in\{2, \ldots B-1\}$, the decoder recalls sequences $\left(Y_{b-1}^{n}, Z_{b-1}^{n}\right)$ and the index $m_{b-1} \in \mathcal{M}$ corresponding to the sequence $X^{n}\left(m_{b-1}\right)$. It observes the sequences $\left(Y_{b}^{n}, Z_{b}^{n}\right)$ and finds index $m_{b} \in \mathcal{M}$ such that $\left(Y_{b}^{n}, Z_{b}^{n}, X^{n}\left(m_{b}\right)\right) \in A_{\varepsilon}^{\star n}(\mathcal{Q})$ and $\left(Y_{b-1}^{n}, Z_{b-1}^{n}, X^{n}\left(m_{b-1}\right), W_{2}^{n}\left(m_{b-1}, m_{b}\right)\right) \in A_{\varepsilon}^{\star n}(\mathcal{Q})$ are jointly typical. Decoder returns the
 $\left(Y_{b-1}^{n}, Z_{b-1}^{n}, X^{n}\left(m_{b-1}\right), W_{2}^{n}\left(m_{b-1}, m_{b}\right)\right)$.
- First bloc at the encoder. An arbitrary index $m_{1} \in \mathcal{M}$ is given to both encoder $\mathcal{C}$ and decoder $\mathcal{D}$. Encoder sends the corresponding sequence $X^{n}\left(m_{1}\right) \in \mathcal{X}^{n}$. At the beginning of the second bloc $b_{2}$, encoder recalls $\left(U_{b_{1}}^{n}, S_{b_{1}}^{n}, X^{n}\left(m_{1}\right)\right)$ and finds index $m_{2}$ such that sequences $\left(U_{b_{1}}^{n}, S_{b_{1}}^{n}, X^{n}\left(m_{1}\right), W_{2}^{n}\left(m_{1}, m_{2}\right)\right) \in A_{\varepsilon}^{\star n}(\mathcal{Q})$ are jointly typical. Encoder sends the corresponding
sequence $X^{n}\left(m_{2}\right)$ on the second block $b_{2}$.
- First bloc at the decoder. At the end of second block $b_{2}$, the decoder finds the index $m_{2}$ such that $\left(Y_{b_{2}}^{n}, Z_{b_{2}}^{n}, X^{n}\left(m_{2}\right)\right) \in A_{\varepsilon}^{\star n}(\mathcal{Q})$ and $\left(Y_{b_{1}}^{n}, Z_{b_{1}}^{n}, X^{n}\left(m_{1}\right), W_{2}^{n}\left(m_{1}, m_{2}\right)\right) \in A_{\varepsilon}^{\star n}(\mathcal{Q})$ are jointly typical. Over the first bloc, decoder $\mathcal{D}$ returns $V_{b_{1}}^{n} \in \mathcal{V}^{n}$ drawn from the conditional probability distribution $\mathcal{Q}_{\mathrm{v}^{\otimes n z x w_{2}}}^{\otimes n}$ depending on sequences $\left(Y_{b_{1}}^{n}, Z_{b_{1}}^{n}, X^{n}\left(m_{1}\right), W_{2}^{n}\left(m_{1}, m_{2}\right)\right)$. Sequences $\left(U_{b_{1}}^{n}, S_{b_{1}}^{n}, Z_{b_{1}}^{n}, X^{n}\left(m_{1}\right), W_{2}^{n}\left(m_{1}, m_{2}\right), Y_{b_{1}}^{n}, V_{b_{1}}^{n}\right) \in A_{\varepsilon}^{\star n}(\mathcal{Q})$ are jointly typical over the first block $b_{1}$.
- Last bloc. Encoder $\mathcal{C}$ and decoder $\mathcal{D}$ choose arbitrary sequences $X_{B}^{n}$ and $V_{B}^{n}$. Sequences are not jointly typical on the last block.

For each block $b \in\{1, \ldots, B-1\}$, the properties of typical sequences, packing and covering lemmas stated in [9] pp. 27, 46 and 208, equations (221), (221) imply there exists a $\bar{n} \in \mathbb{N}$ such that the expected probability of error events are bounded by $\varepsilon$ for all $n \geq \bar{n}$ :

The remaining of the proof is very similar to the achievability part of Theorem VI.1. Lemma 2 also proves that equation (222) implies equation (225). The cardinality bound is stated in Lemma 6 in the Appendix. This concludes the achievability proof of Theorem VIII.1.

Equation (267) comes from the independence of the source ( $U_{i}, S_{i}$ ) with respect to $T$ and $W_{1, i}$. Equation (268) comes from the i.i.d. property of the source.

- Equation (265) comes from the following equations:

$$
\begin{align*}
& \mathcal{P}\left(X_{T}=x \mid U_{T}=u, S_{T}=s, W_{1, T}=w_{1}, T=i, W_{2, T}=w_{2}\right) \\
= & \mathcal{P}\left(X_{i}=x \mid U_{i}=u, S_{i}=s, W_{1, i}=w_{1}, T=i, W_{2, i}=w_{2}\right)  \tag{269}\\
= & \mathcal{P}\left(X_{i}=x \mid U_{i}=u, S_{i}=s, W_{1, i}=w_{1}, T=i\right)  \tag{270}\\
= & \mathcal{P}\left(X_{T}=x \mid U_{T}=u, S_{T}=s, W_{1, T}=w_{1}, T=i\right) \tag{271}
\end{align*}
$$

Equation (269) comes from the definition of the mean random variables $U_{T}, S_{T}, Z_{T}, W_{1, T}, W_{2, T}, X_{T}$, $Y_{T}, V_{T}$.

Equation (270) comes from the Markov chain property $X_{i} \rightarrow\left(U_{i}, S_{i}, W_{1, i}\right) \rightarrow W_{2, i}$ that is valid for all $i \in\{1, \ldots, n\}$.
Equation (271) comes from the definition of the mean random variables $U_{T}, S_{T}, Z_{T}, W_{1, T}, W_{2, T}, X_{T}$, $Y_{T}, V_{T}$.

Lemma 8 Fix a probability distribution $\mathcal{Q} \in \mathbb{Q}$ and suppose that the error probability $\mathcal{P}(E=1)$ is small enough such that $\mathcal{P}(E=1) \cdot \log _{2}|\mathcal{Y} \times \mathcal{Z}|+2 \cdot h_{b}(\mathcal{P}(E=1)) \leq \varepsilon$. Then we have:

& I\left(W_{1} ; Y_{T}, Z_{T} \mid W_{2}\right)-I\left(W_{2} ; U_{T}, S_{T} \mid W_{1}\right)  \tag{272}\\
\leq & I\left(W_{1} ; Y_{T}, Z_{T} \mid W_{2}, E=0\right)-I\left(W_{2} ; U_{T}, S_{T} \mid W_{1}, E=0\right)+\varepsilon \tag{273}
\end{align*}
$$

The proof of Lemma 8 extends to the following equations that intervene in the proof of Theorems V.1, VI.1, VII. 1 and VIII.1.

Proof A. 3 Lemma 8 comes from the properties of the mutual information.

& I\left(W_{1} ; Y_{T}, Z_{T} \mid W_{2}\right)-I\left(W_{2} ; U_{T}, S_{T} \mid W_{1}\right)  \tag{274}\\
= & I\left(W_{1} ; Y_{T}, Z_{T} \mid W_{2}, E\right)-I\left(W_{2} ; U_{T}, S_{T} \mid W_{1}, E\right)  \tag{275}\\
+ & I\left(E ; Y_{T}, Z_{T} \mid W_{2}\right)-I\left(E ; Y_{T}, Z_{T} \mid W_{1}, W_{2}\right)-I\left(E ; U_{T}, S_{T} \mid W_{1}\right)+I\left(E ; U_{T}, S_{T} \mid W_{1}, W_{2}\right)(276) \\
\leq & I\left(W_{1} ; Y_{T}, Z_{T} \mid W_{2}, E\right)-I\left(W_{2} ; U_{T}, S_{T} \mid W_{1}, E\right)+2 H(E)  \tag{277}\\
= & \mathcal{P}(E=0) \cdot\left(I\left(W_{1} ; Y_{T}, Z_{T} \mid W_{2}, E=0\right)-I\left(W_{2} ; U_{T}, S_{T} \mid W_{1}, E=0\right)\right) \\
+ & \mathcal{P}(E=1) \cdot\left(I\left(W_{1} ; Y_{T}, Z_{T} \mid W_{2}, E=1\right)-I\left(W_{2} ; U_{T}, S_{T} \mid W_{1}, E=1\right)\right)+2 H(E)  \tag{278}\\
\leq & I\left(W_{1} ; Y_{T}, Z_{T} \mid W_{2}, E=0\right)-I\left(W_{2} ; U_{T}, S_{T} \mid W_{1}, E=0\right) \\
+ & \mathcal{P}(E=1) \cdot \log _{2}|\mathcal{Y} \times \mathcal{Z}|+2 \cdot h_{b}(\mathcal{P}(E=1))  \tag{279}\\
\leq & I\left(W_{1} ; Y_{T}, Z_{T} \mid W_{2}, E=0\right)-I\left(W_{2} ; U_{T}, S_{T} \mid W_{1}, E=0\right)+\varepsilon . \tag{280}
\end{align*}
$$

This concludes the proof of Lemma 8.

Lemma 9 Probability distribution $\mathcal{P}\left(\left(S_{T}, U_{T}, Z_{T}, X_{T}, Y_{T}, V_{T}\right)=(s, u, z, x, y, v) \mid E=0\right)$ is closed to the target probability distribution $\mathcal{Q}(s, u, z, x, y, v)$ :

\begin{equation*}
\left|\mathcal{P}\left(\left(S_{T}, U_{T}, Z_{T}, X_{T}, Y_{T}, V_{T}\right)=(s, u, z, x, y, v) \mid E=0\right)-\mathcal{Q}(s, u, z, x, y, v)\right| \leq \varepsilon \tag{281}
\end{equation*}
$$

Proof A. 4 (Proof of Lemma 9) We evaluate the probability $\mathcal{P}\left(S_{T}=s \mid E=0\right)$ and we show it is closed to the desired probability $\mathcal{P}_{\mathbf{s}}(s)$ :

\mathcal{P}\left(S_{T}=s \mid E=0\right) & =\sum_{s^{n} \in A_{\varepsilon}^{\star n}} \sum_{i=1}^{n} \mathcal{P}\left(S^{n}=s^{n}, T=i, S_{T}=s \mid E=0\right)  \tag{282}\\
& =\sum_{s^{n} \in A_{\varepsilon}^{\star n}} \sum_{i=1}^{n} \mathcal{P}\left(S^{n}=s^{n} \mid E=0\right) \\
& \times \mathcal{P}\left(T=i \mid S^{n}=s^{n}, E=0\right) \cdot \mathcal{P}\left(S_{T}=s \mid S^{n}=s^{n}, T=i, E=0\right)  \tag{283}\\
& =\sum_{s^{n} \in A_{\varepsilon}^{\star n}} \sum_{i=1}^{n} \mathcal{P}\left(S^{n}=s^{n} \mid E=0\right) \\
& \times \mathcal{P}(T=i) \cdot \mathcal{P}\left(S_{T}=s \mid S^{n}=s^{n}, T=i, E=0\right)  \tag{284}\\
& =\sum_{s^{n} \in A_{\varepsilon}^{\star n}} \sum_{i=1}^{n} \mathcal{P}\left(S^{n}=s^{n} \mid E=0\right) \cdot \mathcal{P}(T=i) \cdot \mathbb{1}_{\left\{s_{T}=s\right\}}  \tag{285}\\
& =\sum_{s^{n} \in A_{e}^{\star n}} \mathcal{P}\left(S^{n}=s^{n} \mid E=0\right) \cdot \sum_{i=1}^{n} \frac{1}{n} \cdot \mathbb{1}_{\left\{s_{T}=s\right\}}  \tag{286}\\
& =\sum_{s^{n} \in A_{\varepsilon}^{\star n}} \mathcal{P}\left(S^{n}=s^{n} \mid E=0\right) \cdot \frac{N\left(s \mid s^{n}\right)}{n} . \tag{287}
\end{align*}
$$

Equation (284) comes from the independence of event $\{T=i\}$ with events $\left\{S^{n}=s^{n}\right\}$ and $\{E=0\}$.
Equation (287) comes from the definition of the number of occurrence $N\left(s \mid s^{n}\right)=\sum_{i=1}^{n} \mathbb{1}_{\left\{s_{T}=s\right\}}$.

Since the sequences $s^{n} \in A_{\varepsilon}^{\star n}$ are typical, we have the following equation:

\mathcal{P}_{\mathrm{s}}(s)-\varepsilon \leq \frac{N\left(s \mid s^{n}\right)}{n} \leq \mathcal{P}_{\mathrm{s}}(s)+\varepsilon \tag{288}

This provides an upper bound and a lower bound on $\mathcal{P}\left(S_{T}=s \mid E=0\right)$ :

& \leq \mathcal{P}\left(S_{T}=s \mid E=0\right)  \tag{290}\\
& \leq \sum_{s^{n} \in A_{\varepsilon}^{* n}} \mathcal{P}\left(S^{n}=s^{n} \mid E=0\right) \cdot\left(\mathcal{P}_{\mathbf{s}}(s)+\varepsilon\right)  \tag{291}\\
& =\mathcal{P}_{\mathbf{s}}(s)+\varepsilon,  \tag{292}\\
\Longleftrightarrow & \left|\mathcal{P}\left(S_{T}=s \mid E=0\right)-\mathcal{P}_{\mathbf{s}}(s)\right| \leq \varepsilon . \tag{293}
\end{align*}
$$

Using the same arguments, we prove that $\mathcal{P}\left(\left(S_{T}, U_{T}, Z_{T}, X_{T}, Y_{T}, V_{T}\right)=(s, u, z, x, y, v) \mid E=0\right)$ is closed to the target probability distribution $\mathcal{Q}(s, u, z, x, y, v)$ :

$$
\begin{equation*}
\left|\mathcal{P}\left(\left(S_{T}, U_{T}, Z_{T}, X_{T}, Y_{T}, V_{T}\right)=(s, u, z, x, y, v) \mid E=0\right)-\mathcal{Q}(s, u, z, x, y, v)\right| \leq \varepsilon \tag{294}
\end{equation*}
$$

This concludes the proof of Lemma 9.

Lemma 10 The i.i.d. property of the information source and state informations $(U, S, Z)$ induces the following equation:

$$
\begin{equation*}
\sum_{i=1}^{n} I\left(S_{i} ; U^{-i}, S_{i+1}^{n} \mid U_{i}, E=0\right) \leq n \cdot \varepsilon . \tag{295}
\end{equation*}
$$

Remark A. 5 The proof of Lemma 10 extends to the following equations that intervene in the proofs of Theorems II.1, III. 1 and IV.1:

\begin{array}{r}
\sum_{i=1}^{n} I\left(U_{i+1}^{n}, S_{i+1}^{n} ; U_{i}, S_{i} \mid E=0\right) \leq n \cdot \varepsilon, \\
\sum_{i=1}^{n} H\left(Z_{i} \mid X^{n}, Z^{-i}, U_{i+1}^{n}, S_{i+1}^{n}, U_{i}, S_{i}, E=0\right)-\sum_{i=1}^{n} H\left(Z_{i} \mid U_{i}, S_{i}, E=0\right) \leq n \cdot \varepsilon, \\
\sum_{i=1}^{n} H\left(Z_{i} \mid U_{i}, S_{i}, E=0\right)-H\left(Z^{n} \mid U^{n}, S^{n}, E=0\right) \leq n \cdot \varepsilon, \\
\sum_{i=1}^{n} I\left(U_{i} ; Z^{-i}, U^{i-1} \mid Z_{i}, E=0\right) \leq n \cdot \varepsilon . \tag{299}
\end{array}
$$

In the proof of Theorem IV.1, the random variables $U$ and $S$ are independent. Hence this gives the following equation:

\sum_{i=1}^{n} I\left(S_{i} ; U^{n}, S_{i+1}^{n} \mid E=0\right) \leq n \cdot \varepsilon . \tag{300}
\end{equation*}

## Proof A. 6 (Proof of Lemma 10)

\sum_{i=1}^{n} I\left(S_{i} ; U^{-i}, S_{i+1}^{n} \mid U_{i}, E=0\right) & =\sum_{i=1}^{n} H\left(S_{i} \mid U_{i}, E=0\right)-\sum_{i=1}^{n} H\left(S_{i} \mid U^{n}, S_{i+1}^{n}, E=0\right)  \tag{301}\\
& =\sum_{i=1}^{n} H\left(S_{i} \mid U_{i}, E=0\right)-H\left(S^{n} \mid U^{n}, E=0\right) \tag{302}
\end{align*}
$$

Equations (301) and (302) come from the properties of the mutual information.

$$
\begin{align*}
H\left(S^{n} \mid U^{n}, E=0\right) & =\frac{1}{\mathcal{P}(E=0)} \cdot\left[H\left(S^{n} \mid U^{n}, E\right)-\mathcal{P}(E=1) \cdot H\left(S^{n} \mid U^{n}, E=1\right)\right]  \tag{303}\\
& \geq H\left(S^{n} \mid U^{n}, E\right)-\mathcal{P}(E=1) \cdot H\left(S^{n} \mid U^{n}, E=1\right)  \tag{304}\\
& \geq H\left(S^{n} \mid U^{n}\right)-I\left(E ; S^{n} \mid U^{n}\right)-\mathcal{P}(E=1) \cdot n \cdot \log _{2}|\mathcal{S}|  \tag{305}\\
& \geq H\left(S^{n} \mid U^{n}\right)-H(E)-\mathcal{P}(E=1) \cdot n \cdot \log _{2}|\mathcal{S}|  \tag{306}\\
& \geq H\left(S^{n} \mid U^{n}\right)-1-\mathcal{P}(E=1) \cdot n \cdot \log _{2}|\mathcal{S}|  \tag{307}\\
& =n \cdot\left(H(S \mid U)-\frac{1}{n}-\mathcal{P}(E=1) \cdot \log _{2}|\mathcal{S}|\right) . \tag{308}
\end{align*}
$$

Equation (303) comes from the definition of the entropy. Note that $\mathcal{P}(E=0) \neq 0$, since error probability $\mathcal{P}(E=1)<1$ is low.
Equation (304) comes from $\mathcal{P}(E=0) \leq 1$ that implies $\frac{1}{\mathcal{P}(E=0)} \geq 1$.
Equations (305), (306), (307) come from the properties of the mutual information.
Equation (308) comes from the i.i.d. property of the sequences of source $U^{n}$ and states $S^{n}$.

$$
\begin{align*}
H\left(S_{i} \mid U_{i}, E=0\right) & =\frac{1}{\mathcal{P}(E=0)} \cdot\left[H\left(S_{i} \mid U_{i}, E\right)-\mathcal{P}(E=1) \cdot H\left(S_{i} \mid U_{i}, E=1\right)\right]  \tag{309}\\
& \leq \frac{1}{\mathcal{P}(E=0)} \cdot H\left(S_{i} \mid U_{i}, E\right)  \tag{310}\\
& =H\left(S_{i} \mid U_{i}, E\right)+\frac{1-\mathcal{P}(E=0)}{\mathcal{P}(E=0)} \cdot H\left(S_{i} \mid U_{i}, E\right)  \tag{311}\\
& \leq H\left(S_{i} \mid U_{i},\right)+\frac{1-\mathcal{P}(E=0)}{\mathcal{P}(E=0)} \cdot \log _{2}|\mathcal{S}|  \tag{312}\\
& =H(S \mid U)+\frac{\mathcal{P}(E=1)}{1-\mathcal{P}(E=1)} \cdot \log _{2}|\mathcal{S}| \tag{313}
\end{align*}
$$

Equations (309), (310), (311), (312) come from the properties of the entropy.
Equation (313) comes from the i.i.d. property of the source $U_{i}$ and states $S_{i}$, for all $i \in\{1, \ldots, n\}$.

$$
\begin{align*}
& \sum_{i=1}^{n} I\left(S_{i} ; U^{-i}, S_{i+1}^{n} \mid U_{i}, E=0\right)  \tag{314}\\
= & \sum_{i=1}^{n} H\left(S_{i} \mid U_{i}, E=0\right)-H\left(S^{n} \mid U^{n}, E=0\right)  \tag{315}\\
\leq & n \cdot\left(H(S \mid U)+\frac{\mathcal{P}(E=1)}{1-\mathcal{P}(E=1)} \cdot \log _{2}|\mathcal{S}|-H(S \mid U)+\frac{1}{n}+\mathcal{P}(E=1) \cdot \log _{2}|\mathcal{S}|\right)  \tag{316}\\
= & n \cdot\left(\frac{\mathcal{P}(E=1)^{2}}{1-\mathcal{P}(E=1)} \cdot \log _{2}|\mathcal{S}|+\frac{1}{n}\right)  \tag{317}\\
\leq & n \cdot \varepsilon . \tag{318}
\end{align*}
$$

Equation (315) comes from equations (308) and (313).
Equation (318) comes from the hypothesis of small error probability $\mathcal{P}(E=1)$ and large length of codewords $n \in \mathbb{N}$, hence $\varepsilon \geq \frac{\mathcal{P}(E=1)^{2}}{1-\mathcal{P}(E=1)} \cdot \log _{2}|\mathcal{S}|+\frac{1}{n}$.

This concludes the proof of Lemma 10.

Lemma 11 Independence of random variable $T$ with $\left(U_{T}, S_{T}\right)$ induces the following equation:

$$
\begin{equation*}
I\left(T ; S_{T}, U_{T} \mid E=0\right)=0 \tag{319}
\end{equation*}
$$

This implies: $I\left(T ; S_{T} \mid U_{T}, E=0\right)=I\left(T ; S_{T} \mid E=0\right)=I\left(T ; U_{T} \mid E=0\right)=0$.

Proof A. 7 (Proof of Lemma 11) The i.i.d. property of the source $(U, S)$ implies that for all $i, j \in$ $\{1, \ldots, n\}$, we have:

\begin{align*}
& \mathcal{P}\left(\left(U_{T}, S_{T}\right)=(u, s) \mid T=i, E=0\right)=\mathcal{P}\left(\left(U_{T}, S_{T}\right)=(u, s) \mid T=j, E=0\right)  \tag{320}\\
\Longrightarrow & \mathcal{P}\left(\left(U_{T}, S_{T}\right)=(u, s) \mid T=i, E=0\right)=\mathcal{P}\left(\left(U_{T}, S_{T}\right)=(u, s) \mid E=0\right), \forall i \in\{1, \ldots, n\}(321) \\
\Longrightarrow & I\left(T ; S_{T}, U_{T} \mid E=0\right)=0 \tag{322}
\end{align*}
$$
