Another method of viscosity solutions of integro-differential partial equation by concavity

Abstract

In this paper we consider the problem of viscosity solution of integro-partial differential equation (IPDE in short) via the solution of backward stochastic differential equations (BSDE in short) with jumps where Lévy's measure is not necessarily finite. We mainly use the concavity of the generator at the level of its second variable to establish the existence and uniqueness of the solution with non local terms.

Keywords: Integro-partial differential equation; Backward stochastic differential equations with jumps; Viscosity solution; Non-local operator; Concavity.

1 Introduction

We consider the following system of integro-partial differential equation, which is a function of (t, x): $\forall i \in \{1, ..., m\}$,

-h^{(i)}(t,x,u^i(t,x),(\sigma^\top \mathcal{D}_x u^i)(t,x), \mathcal{B}_i u^i(t,x)) = 0, \quad (t,x) \in [0,T] \times \mathbb{R}^k; \\
u^i(T,x) = g^i(x);
\end{cases} (1.1)$$

where the operators B_i and K_i are defined as follows:

The resolution of (1.1) is in connection with the following system of backward stochastic differential equations with jumps:

and

the following standard stochastic differential equation of diffusion-jump type:

for $s \in [t, T]$ and $X_s^{t,x} = x$ if $s \le t$.

Several authors have studied (1.1) by various and varied methods. Among others we can quote Barles and al. [1], who use the theorem of comparison by supposition the monotony of the generator; Ouknine and Hamadène [5] use the penalization method.

But recently Hamadène does a relaxation on the hypothesis of monotony on the generator to introduce a new class of functions(see [3] page 216) for the resolution of (1.1).

In this work we propose to solve (1.1) by relaxing the monotonicity of the generator and the class of functions introduced in [3] and assuming that $\lambda = \infty$ and the concavity of the generator at the level of its second variable. We recall that this technic was used in [8] for the resolution of BSDE.

Our paper is organized as follows: in the next section we give the notations and the assumptions; in section 3 we recall a number of existing results; in section 4 we build estimates and properties for a good resolution of our problem; section 5 is reserved to give our main result.

And at the end, classical definition of the concept of viscosity solution is put in appendix.

2 Notations and assumptions

Let $(\Omega, \mathcal{F}, (\mathcal{F}_t)_{t \leq T}, \mathbb{P})$ be a stochastic basis such that \mathcal{F}_0 contains all \mathbb{P} -null sets of \mathcal{F} , and $\mathcal{F}_t = \mathcal{F}_{t+} := \bigcap_{\epsilon > 0} \mathcal{F}_{t+\epsilon}$, $t \geq 0$, and we suppose that the filtration is generated by the two mutually independents processes:

- (i) $B := (B_t)_{t>0}$ a d-dimensional Brownian motion and,
- (ii) a Poisson random measure μ on $\mathbb{R}^+ \times E$ where $E := \mathbb{R}^\ell \{0\}$ is equipped with its Borel field \mathcal{E} ($\ell \geq 1$). The compensator $\nu(\mathrm{d}t, \mathrm{d}e) = \mathrm{d}t\lambda(\mathrm{d}e)$ is such that $\{\widetilde{\mu}([0,t] \times A) = (\mu \lambda)([0,t] \times A)\}_{t\geq 0}$ is a martingale for all $A \in \mathcal{E}$ satisfying $\lambda(A) < \infty$. We also assume that λ is a σ -finite measure on (E, \mathcal{E}) , integrates the function $(1 \wedge |e|^2)$ and $\lambda(E) = \infty$.

Let's now introduce the following spaces:

- (iii) \mathcal{P} (resp. \mathbf{P}) the field on $[0,T] \times \Omega$ of $\mathcal{F}_{t \leq T}$ -progressively measurable (resp. predictable) sets.
- (iv) For $\kappa \geq 1$, $\mathbb{L}^2_{\kappa}(\lambda)$ the space of Borel measurable functions $\varphi := (\varphi(e))_{e \in E}$ from E into \mathbb{R}^{κ} such that $\|\varphi\|^2_{\mathbb{L}^2_{\kappa}(\lambda)} = \int_E |\varphi(e)|^2_{\kappa} \lambda(\mathrm{d}e) < \infty$; $\mathbb{L}^2_1(\lambda)$ will be simply denoted by $\mathbb{L}^2(\lambda)$;
- (v) $\mathcal{S}^2(\mathbb{R}^{\kappa})$ the space of RCLL (for right continuous with left limits) \mathcal{P} -measurable and \mathbb{R}^{κ} -valued processes such that $\mathbb{E}[\sup_{s\leq T}|Y_s|^2]<\infty$;
- (vi) $\mathbb{H}^2(\mathbb{R}^{\kappa \times d})$ the space of processes $Z := (Z_s)_{s \leq T}$ which are \mathcal{P} -measurable, $\mathbb{R}^{\kappa \times d}$ -valued and satisfying $\mathbb{E}\left[\int_0^T |Z_s|^2 ds\right] < \infty;$
- (vii) $\mathbb{H}^2(\mathbb{L}^2_{\kappa}(\lambda))$ the space of processes $U := (U_s)_{s \leq T}$ which are **P**-measurable, $\mathbb{L}^2_{\kappa}(\lambda)$ -valued and satisfying $\mathbb{E}\left[\int_0^T \|U_s(\omega)\|_{\mathbb{L}^2_{\kappa}(\lambda)}^2 \,\mathrm{d}s\right] < \infty;$
- (viii) Π_q the set of deterministics functions
- $\varpi: (t,x) \in [0,T] \times \mathbb{R}^{\kappa} \mapsto \varpi(t,x) \in \mathbb{R}$ of polynomial growth, i.e., for which there exists two non-negative constants C and p such that for any $(t,x) \in [0,T] \times \mathbb{R}^{\kappa}$,

$$|\varpi(t,x)| < C(1+|x|^p).$$

The subspace of Π_g of continuous functions will be denoted by Π_g^c ;

(ix) \mathcal{M} the class of functions which satisfy the p-order Mao condition in x i.e. If $f \in \mathcal{M}$ then there exists a nondecreasing, continuous and concave function $\rho(\cdot): \mathbb{R}^+ \mapsto \mathbb{R}^+$ with $\rho(0) = 0$, $\rho(u) > 0$, for u > 0 and $\int_{0^+} \frac{du}{\rho(u)} = +\infty$, such that $d\mathbb{P} \times dt$ -a.e., $\forall x, x' \in \mathbb{R}^k$ and $\forall p \geq 2$,

(x) For any process $\theta := (\theta_s)_{s \le T}$ and $t \in (0,T], \ \theta_{t-} = \lim_{s \nearrow t} \theta_s$ and

Now let b and σ be the following functions:

$$b:(t,x)\in[0,T]\times\mathbb{R}^k\mapsto b(t,x)\in\mathbb{R}^k;$$

$$\sigma: (t, x) \in [0, T] \times \mathbb{R}^k \mapsto \sigma(t, x) \in \mathbb{R}^{k \times d}.$$
We assume that b and σ belong to \mathcal{M} (2.5)

Let $\beta:(t,x,e)\in[0,T]\times\mathbb{R}^k\times E\mapsto\beta(t,x,e)\in\mathbb{R}^k$ be a measurable function such that for some real constant C, and for all $e\in E$,

- (ii) β belongs to \mathcal{M} ;
- (iii) the mapping $(t,x) \in [0,T] \times \mathbb{R}^k \mapsto \beta(t,x,e) \in \mathbb{R}^k$ is continuous for any $e \in E$.

The functions $(g^i)_{i=1,m}$ and $(h^{(i)})_{i=1,m}$ be two functions defined as follows: for $i=1,\ldots,m$,

Moreover we assume they satisfy:

(**H1**): For any $i \in \{1, ..., m\}$, the function g^i belongs to \mathcal{M} .

(H2): For any $i \in \{1, ..., m\}$,

- (i) the function $h^{(i)}$ is Lipschitz in (y, z, q) uniformly in (t, x), i.e., there exists a real constant C such that for any $(t, x) \in [0, T] \times \mathbb{R}^k$, (y, z, q) and (y', z', q') elements of \mathbb{R}^{m+d+1} , $\left|h^{(i)}(t, x, y, z, q) - h^{(i)}(t, x, y', z', q')\right| \le C(|y - y'| + |z - z'| + |q - q'|); \tag{2.7}$
- (ii) the $(t,x) \mapsto h^{(i)}(t,x,y,z,q)$, for fixed $(y,z,q) \in \mathbb{R}^{m+d+1}$, belongs uniformly to \mathcal{M} ,

Next let γ^i , $i=1,\ldots,m$ be Borel measurable functions defined from $[0,T]\times\mathbb{R}^k\times E$ into \mathbb{R} and satisfying:

(i) $|\gamma^i(t, x, e)| \le C(1 \land |e|);$

(ii)
$$\gamma^i$$
 belongs to \mathcal{M} ; (2.8)

(iii) the mapping $t \in [0,T] \mapsto \gamma^i(t,x,e) \in \mathbb{R}$ is continuous for any $(x,e) \in \mathbb{R}^k \times E$.

Finally we introduce the following functions $(f^{(i)})_{i=1,m}$ defined by:

$$\forall (t, x, y, z, \zeta) \in [0, T] \times \mathbb{R}^{k+m+d} \times \mathbb{L}^2(\lambda), \ f^{(i)}(t, x, y, z, \zeta) := h^{(i)}\left(t, x, y, z, \int_E \gamma^i(t, x, e)\zeta(e)\lambda(de)\right). \tag{2.9}$$

The functions $(f^{(i)})_{i=1,m}$, enjoy the two following properties:

(a) The function $f^{(i)}$ is Lipschitz in (y, z, ζ) uniformly in (t, x), i.e., there exists a real constant

C such that

$$\left| f^{(i)}(t, x, y, z, \zeta) - f^{(i)}(t, x, y', z', \zeta') \right| \le C(|y - y'| + |z - z'| + ||\zeta - \zeta'||_{\mathbb{L}^2(\lambda)});$$
since $h^{(i)}$ is uniformly Lipschitz in (y, z, q) and γ^i verifies (2.8)-(i);

(b) The function $(t,x) \in [0,T] \times \mathbb{R}^k \mapsto f^{(i)}(t,x,0,0,0)$ belongs to Π_g^c ; and then $\mathbb{E}\left[\int_0^T \left|f^{(i)}(r,X_r^{t,x},0,0,0)\right|^2 dr\right] < \infty$.

3 Some results in backward stochastic differential equation with jumps

3.1 A class of diffusion processes with jumps

Let $(t,x) \in [0,T] \times \mathbb{R}^d$ and $(X_s^{t,x})_{s \leq T}$ be the stochastic process solution of (1.4). Under assumptions (2.5)-(2.6) the solution of Equation (1.4) exists and is unique (see [2] for more details). We state some properties of the process $\{(X_s^{t,x}), s \in [0,T]\}$ which can found in [2].

Proposition 3.1 For each $t \geq 0$, there exists a version of $\{(X_s^{t,x}), s \in [t,T]\}$ such that $s \to X_s^t$ is a $C^2(\mathbb{R}^d)$ -valued rell process. Moreover it satisfies the following estimates: $\forall p \geq 2, x, x' \in \mathbb{R}^d$ and $s \geq t$,

$$\mathbb{E}\left[\sup_{t \le r \le s} \left| X_r^{t,x} - x \right|^p \right] \le M_p(s - t)(1 + |x|^p);$$

$$\mathbb{E}\left[\sup_{t \le r \le s} \left| X_r^{t,x} - X_r^{t,x'} - (x - x')^p \right|^p \right] \le M_p(s - t)(|x - x'|^p);$$
(3.11)

for some constant M_p .

3.2 Existence and uniqueness for BSDE with jumps

Let $(t,x) \in [0,T] \times \mathbb{R}^d$ and we consider the following m-dimensional BSDE with jumps:

(ii) \ dY^{i;t,x}_{s} = -f^{(i)}(s,X^{t,x}_{s},Y^{i;t,x}_{s},Z^{i;t,x}_{s},U^{i;t,x}_{s})ds + Z^{i;t,x}_{s}d\mathbf{B}_{s} + \int_{\mathbf{E}} \mathbf{U}^{i;t,x}_{s}(e)\widetilde{\mu}(ds,de), \quad s \leq T; \\
(iii) \ Y^{i;t,x}_{T} = g^{i}(X^{t,x}_{T});
\end{cases}$$

where for any $i \in \{1, ..., m\}$, $Y_s^{i;t,x}$ is the ith row of $Y_s^{t,x}$, $Z_s^{i;t,x}$ is the ith component of $Z_s^{t,x}$ and $U_s^{i;t,x}$ is the ith component of $U_s^{t,x}$.

Proposition 3.2 Assume that assumptions (**H1**) and (**H2**) hold. Then for any $(t, x) \in [0, T] \times \mathbb{R}^d$, the BSDE (3.12) has an unique solution $(\vec{Y}^{t,x}, Z^{t,x}, U^{t,x})$.

For proof of this proposition we can see [1].

3.3 Viscosity solutions of integro-differential partial equation

Proposition 3.3 (see, [1]) Assume that (**H1**), (**H2**), are fulfilled. Then there exists deterministic continuous functions $(u^i(t,x))_{i=1,m}$ which belong to Π_g such that for any $(t,x) \in [0,T] \times \mathbb{R}^k$, the solution of the BSDE (3.12) verifies:

$$\forall i \in \{1, \dots, m\}, \ \forall s \in [t, T], \ Y_s^{i;t,x} = u^i(s, X_s^{t,x}). \tag{3.13}$$

Moreover if for any $i \in \{1, ..., m\}$,

- $(i) \quad \gamma^i \geq 0;$
- (ii) for any fixed $(t, x, \vec{y}, z) \in [0, T] \times \mathbb{R}^{k+m+d}$, the mapping $(q \in \mathbb{R}) \longmapsto h^{(i)}(t, x, \vec{y}, z, q) \in \mathbb{R}$ is non-decreasing.

The function $(u^i)_{i=1,m}$ is a continuous viscosity solution (in Barles and al. 's sense, see Definition 5.3 in the Appendix) of (1.1). The solution $(u^i)_{i=1,m}$ of (1.1) is unique in the class Π_g^c .

Remark 1 (see, [1]) Under the assumptions (H1), (H2), there exists a unique viscosity solution of (1.1) in the class of functions satisfying

uniformly for $t \in [0,T]$, for some $\widetilde{A} > 0$.

4 Estimates and properties

In this section, we will establish a priori estimates concerning solutions of BSDE (3.12), which will play an important role in the proof of our main results.

Lemma 4.1 (see, [3]) Under assumption (H1), (H2), for any $p \geq 2$ there exists two non-negative constants C and δ such that,

$$\mathbb{E}\left[\left\{\int_{0}^{T} ds \left(\int_{E} \left|U_{s}^{t,x}(e)\right|^{2} \lambda(de)\right)\right\}^{\frac{p}{2}}\right] = \mathbb{E}\left[\left\{\int_{0}^{T} ds \|U_{s}^{t,x}\|_{\mathbb{L}_{m}^{2}(\lambda)}^{2}\right\}^{\frac{p}{2}}\right] \leq C\left(1 + |x|^{\delta}\right). \tag{4.15}$$

Proposition 4.2 For any i = 1, ..., m, there exist $C \ge 0$, $\kappa > 0$ such that, $\forall x \text{ and } x'$ elements of \mathbb{R}^k

Proof. Let x and x' be elements of \mathbb{R}^k . Let $(\vec{Y}^{t,x}, Z^{t,x}, U^{t,x})$ (resp. $(\vec{Y}^{t,x'}, Z^{t,x'}, U^{t,x'})$) be the solution of the BSDE with jumps (3.12) associated with $(f(s, X_s^{t,x}, y, \eta, \zeta), g(X_T^{t,x}))$ (resp. $f(s, X_s^{t,x'}, y, \eta, \zeta), g(X_T^{t,x'})$). Applying Itô formula to $\left|\vec{Y}^{t,x} - \vec{Y}^{t,x'}\right|^2$ between s and T, we have

where the processes ΔX_r , ΔY_r , $\Delta f(r)$, ΔZ_r and ΔU_r are defined as follows: $\forall r \in [t, T]$, $\Delta f(r) := ((\Delta f^{(i)}(r))_{i=1,m} = (f^{(i)}(r, X_r^{i;t,x}, \vec{Y}_r^{t,x}, Z_r^{i;t,x}, U_r^{i;t,x}) - f^{(i)}(r, X_r^{i;t,x'}, \vec{Y}_r^{i;t,x'}, Z_r^{i;t,x'}, U_r^{i;t,x'}))_{i=1,m},$ $\Delta X_r = X_r^{t,x} - X_r^{t,x'}$, $\Delta Y(r) = \vec{Y}_r^{t,x} - \vec{Y}_r^{t,x'} = (Y_r^{j;t,x} - Y_r^{j;t,x'})_{j=1,m},$ $\Delta Z_r = Z_r^{t,x} - Z_r^{t,x'}$ and $\Delta U_r = U_r^{t,x} - U_r^{t,x'}$ ($\langle \cdot, \cdot \rangle$ is the usual scalar product on \mathbb{R}^m). • To complete our estimation of (4.17) we need to deal with $\mathbb{E}\left[2\int_s^T <\left(\vec{Y}_s^{t,x}-\vec{Y}_s^{t,x'}\right),\Delta f(r)>dr\right]$. Taking into account the expression of $f^{(i)}$ given by (2.9) we then split $\Delta f(r)$ in the follows way: for $r\leq T$,

\leq C \int_{0}^{\eta} \rho(\mathbb{E}\left[\left| X_{\tau}^{t,x} - {}^{k} X_{\tau}^{t,x} \right|^{2} \right]) dr + C \mathbb{E}\left[\int_{\{|e|<\frac{1}{k}\}} (1 \wedge |e|^{2}) \lambda(de) \right] \quad \text{(by Jensen)},$$

By Bihari's inequality (see [8] page 171 and [9]) and the fact of $\int_{\{|e|<\frac{1}{k}\}} (1 \wedge |e|^2) \lambda(de)_k \xrightarrow{\longrightarrow} 0$; we obtain our result the (4.34).

We now focus on (4.33). Note that we can apply Ito's formula, even if the BSDEs are related to filtrations and Poisson random measures which are not the same, since:

(i) $\mathcal{F}_s^k \subset \mathcal{F}_s$, $\forall s \leq T$;

+ C\sqrt{\mathbb{E}\left[\sup_{s \leq r \leq T}\rho^{2}(\left|X_{r}^{t,x} - {}^{k}X_{r}^{t,x}\right|^{2})\right]} \times \sqrt{\mathbb{E}\left[\left(\int_{s}^{T}\int_{E}\left|U_{r}^{i;t,x}(e)\right|^{2}\lambda(de) dr\right)^{2}\right]} \\
+ C\epsilon\mathbb{E}\left[\int_{t}^{T}\int_{E}\left|U_{s}^{t,x} - {}^{k}U_{s}^{t,x}1_{\{|e| \geq \frac{1}{k}\}}\right|^{2}\lambda(de) ds\right] \tag{4.43}$$

For $C\epsilon < 1$ and the Gronwall's lemma going through the dominated convergence theorem, the continuity of g and ρ and the lemma 4.1, then

Now let us consider a subsequence which we still denote by $\{k\}$ such that $\sup_{s \leq T} \left| X_s^{t,x} - ^k X_s^{t,x} \right|^2 \xrightarrow{0} 0$. P-a.s. (and then $\left| X_{s-}^{t,x} - ^k X_{s-}^{t,x} \right| \xrightarrow{0} 0$ since $\left| X_{s-}^{t,x} - ^k X_{s-}^{t,x} \right| \le \sup_{s \leq T} \left| X_s^{t,x} - ^k X_s^{t,x} \right|^2$). By (4.34), this subsequence exists. As the mapping $x \mapsto \beta(t,x,e)$ is Lipschitz then the sequence

5 The main result

Unlike Barles and al. [1] our result on viscosity solutions is established for the following definition.

Definition 5.1 We say that a family of deterministics functions $u = (u^i)_{i=1,m}$ which belongs to $\mathcal{M} \quad \forall i \in \{1,\ldots,m\}$ is a viscosity sub-solution (resp. super-solution) of the IPDE (1.1) if:

- (i) $\forall x \in \mathbb{R}^k$, $u^i(x,T) \leq g^i(x)$ (resp. $u^i(x,T) \geq g^i(x)$);
- (ii) For any $(t,x) \in [0,T] \times \mathbb{R}^k$ and any function ϕ of class $C^{1,2}([0,T] \times \mathbb{R}^k)$ such that (t,x) is a global maximum point of $u^i \phi$ (resp. global minimum point of $u^i \phi$) and $(u^i \phi)(t,x) = 0$ one has

The family $u = (u^i)_{i=1,m}$ is a viscosity solution of (1.1) if it is both a viscosity sub-solution and viscosity super-solution.

Assume that assumptions $(\mathbf{H1})$ and $(\mathbf{H2})$ are fulfilled, then the following multi-dimensional BSDEs with jumps

Next as for any i = 1, ..., m, u^i belongs to \mathcal{M} , then by proposition 3.3 the (3.13), there exists a family of deterministics continuous functions of polynomial growth $(\underline{u}^i)_{i=1,m}$ that fact for any $(t, x) \in [0, T] \times \mathbb{R}^k$,

Therefore $\underline{u}^i = u^i$, such that by (4.45) we obtain $U_s^{t,x}(e) = (u_i(s, X_{s-}^{t,x} + \beta(s, X_{s-}^{t,x}, e)) - u_i(s, X_{s-}^{t,x}))$, on $\Omega \times [t, T] \times E$, which give the viscosity solution in the sense of definition 5.1 (see [3]) by pluging (4.46) in $h^{(i)}$ of (5.51).

+ \int_{s}^{T} h^{(i)}(r, X_{r}^{t,x}, \overline{Y}_{r}^{i;t,x}, \overline{Z}_{r}^{i;t,x}, \int_{\mathbb{E}} \gamma^{i}(t, X_{r}^{t,x}, e) (\overline{u}_{i}(s, X_{s-}^{t,x} + \beta(s, X_{s-}^{t,x}, e)) - \overline{u}_{i}(s, X_{s-}^{t,x})) \lambda(de)) dr; \\
(iii) \ \overline{Y}_{T}^{i;t,x} = g(X_{T}^{t,x}).
\end{cases} (5.53)$$

By Feynman Kac formula $\overline{u}^i(s, X_s^{t,x}) = Y_s^{i;t,x}$ where $Y_s^{i;t,x}$ satisfies the BSDE with jumps (1.3) associated to IPDE (1.1).

Since that the BSDE with jumps (5.51) has solution and it is unique by assumed that (**H1**) and (**H2**) are verified. By proposition 3.3 the (3.13), there exists a family of deterministic continuous functions of polynomial growth $(v^i)_{i=1,m}$ that fact for any $(t,x) \in [0,T] \times \mathbb{R}^k$,

$$\forall s \in [t, T], \qquad \overline{Y}_s^{i;t,x} = v^i(s, X_s^{t,x}).$$

Such that by the same proposition, the family $(v^i)_{i=1,m}$ is a viscosity solution of the following system:

-\mathcal{K}_i v^i(t,x) - h^{(i)}(t,x,(v^j(t,x))_{j=1,m},(\sigma^\top \mathcal{D}_x v^i)(t,x), \mathcal{B}_i \overline{u}^i(t,x)) = 0, \quad (t,x) \in [0,T] \times \mathbb{R}^k; \\
u^i(T,x) = g^i(x).
\end{cases}$$
(5.54)

By uniqueness of solution of (5.52) \overline{u}^i is viscosity solution of (5.53); and by proposition 3.3 $v^i = \overline{u}^i$ $\forall i \in \{1, ..., m\}$.

Now for completing our proof we show that on $\Omega \times [t, T] \times E$, $ds \otimes d\mathbb{P} \otimes d\lambda$ – a.e. $\forall i \in \{1, \dots, m\}$;

$$\overline{U}_{s}^{i;t,x}(e) = (v^{i}(s, X_{s-}^{t,x} + \beta(s, X_{s-}^{t,x}, e)) - v^{i}(s, X_{s-}^{t,x}))

By Remark 3.4 in [3]; let us considere $(x_k)_{k\geq 1}$ a sequence of \mathbb{R}^k which converges to $x\in\mathbb{R}^k$ and the two following BSDE with jumps (adaptation is w.r.t. \mathcal{F}^k):

(i) \ \overrightarrow{\overline{Y}}^{k,t,x} := (\overline{Y}^{i;k,t,x})_{i=1,m} \in \mathcal{S}^{2}(\mathbb{R}^{m}), \ \overline{Z}^{k,t,x} := (\overline{Z}^{i;k,t,x})_{i=1,m} \in \mathbb{H}^{2}(\mathbb{R}^{m \times d}), \ \overline{U}^{k,t,x} := (\overline{U}^{i;k,t,x})_{i=1,m} \in \mathbb{H}^{2}(\mathbb{L}_{m}^{2}(\lambda)); \\
(ii) \ \overline{Y}^{i;k,t,x}_{s} = g^{i}(X_{T}^{k,t,x}) - \int_{s}^{T} \overline{Z}^{i;k,t,x} dB_{r} - \int_{s}^{T} \int_{\mathbb{E}} \overline{U}^{i;k,t,x}_{r}(e) \widetilde{\mu}(dr, de) \\
+ \int_{s}^{T} h^{(i)} \left(r, X_{r}^{k,t,x}, \overline{Y}_{r}^{i;k,t,x}, \overline{Z}_{r}^{i;k,t,x}, \\
\int_{\mathbb{E}} \gamma^{i}(t, X_{r}^{k,t,x,k}, e) (\overline{u}_{i}(s, X_{s-}^{k,t,x,k} + \beta(s, X_{s-}^{k,t,x,k}, e)) - \overline{u}_{i}(s, X_{s-}^{k,t,x,k})) \lambda(de) \right) dr; \\
(iii) \ \overline{Y}^{i;k,t,x_{k}}_{T} = g(X_{T}^{k,t,x_{k}}).

(i) \overrightarrow{\overline{Y}}^{k,t,x_k} := (\overline{Y}^{i;k,t,x_k})_{i=1,m} \in \mathcal{S}^2(\mathbb{R}^m), \ \overline{Z}^{k,t,x_k} := (\overline{Z}^{i;k,t,x_k})_{i=1,m} \in \mathbb{H}^2(\mathbb{R}^{m \times d}), \\
\overline{U}^{k,t,x_k} := (\overline{U}^{i;k,t,x_k})_{i=1,m} \in \mathbb{H}^2(\mathbb{L}^2_m(\lambda)); \\
(ii) \overline{Y}^{i;k,t,x_k}_s = g^i(X_T^{k,t,x_k}) - \int_s^T \overline{Z}^{i;k,t,x_k} dB_r - \int_s^T \int_{\mathbb{E}} \overline{U}^{i;k,t,x_k}_r(e)\widetilde{\mu}(dr,de) \\

By proof of step 2 of proposition 4.3, $(\overline{Y}^{i;k,t,x}, \overline{Z}^{i;k,t,x}, \overline{U}^{i;k,t,x} 1_{\{|e| \geq \frac{1}{k}\}})_k$ converge to $(\overline{Y}^{i;t,x}, \overline{Z}^{i;t,x}, \overline{U}^{i;t,x})$ in $\mathcal{S}^2(\mathbb{R}) \times \mathbb{H}^2(\mathbb{R}^{\kappa \times d}) \times \mathbb{H}^2(\mathbb{L}^2(\lambda))$.

Let $((v_{i=1,m}^k))_{k\geq 1}$ be the sequence of continuous deterministics functions such that for any $t\leq T$ and $s\in [t,T]$,

$$\overline{Y}_s^{i;k,t,x} = \overline{v}_i^k(s, X_s^{t,x})$$
 and $\overline{Y}_s^{i;k,t,x_k} = \overline{v}_i^k(s, X_s^{t,x_k}) \quad \forall i = 1, \dots, m.$

Such that we have respectively by proof of proposition 4.3 in step 1 and step 2:

$$(i) \ \overline{U}_{s}^{i;k,t,x}(e) = (v^{i}(s, {}^{k}X_{s-}^{t,x} + \beta(s, {}^{k}X_{s-}^{t,x}, e)) - v^{i}(s, {}^{k}X_{s-}^{t,x})), \ ds \otimes d\mathbb{P} \otimes d\lambda_{k} \text{-a.e on } [t,T] \times \Omega \times E;$$

(ii) the sequence $((v_{i=1,m}^k))_{k\geq 1}$ converges to $v^i(t,x)$ by using (4.44).

So that $x_k \longrightarrow_k x$ we take the following estimation which is obtaining by Ito's formula and by the properties of $h^{(i)}$.

$$\mathbb{E}\left[\left|\vec{Y}_{s}^{k,t,x_{k}} - Y_{s}^{k,t,x}\right|^{2} + \int_{0}^{T} \left\{\left|Z_{s}^{k,t,x_{k}} - Z_{s}^{k,t,x}\right|^{2} + \int_{E} \left|U_{s}^{k,t,x_{k}} - U_{s}^{k,t,x}\right|^{2} \lambda_{k}(de)\right\} ds\right]$$

$$\leq \mathbb{E}\left[\left|g(^{k}X_{T}^{t,x_{k}}) - g(^{k}X_{T}^{t,x})\right|^{2} + 2\int_{s}^{T} \left\langle\left(\vec{Y}_{r}^{k,t,x_{k}} - Y_{r}^{k,t,x}\right), ^{k} \Delta h^{(i)}(r) > dr\right]\right]$$

Using the same arguments as in proof (4.33), it follows that for s = t; $\forall i = 1, ..., m$,

$$v_i^k(t, x_k) \longrightarrow_k v_i^k(t, x).$$

Therefore by (i)-(ii) we have, for any i = 1, ..., m,

$$\overline{U}_s^{i;t,x}(e) = (v^i(s, X_{s-}^{t,x} + \beta(s, X_{s-}^{t,x}, e)) - v^i(s, X_{s-}^{t,x})) \quad ds \otimes d\mathbb{P} \otimes d\lambda - \text{a.e. in } [t, T] \times \Omega \times E, \quad \forall i \in \{1, \dots, m\}.$$

$$(5.58)$$

By this result we can replace $(\overline{u}_i(s, X_{s-}^{t,x} + \beta(s, X_{s-}^{t,x}, e)) - \overline{u}_i(s, X_{s-}^{t,x}))$ by $\overline{U}_s^{i;t,x}(e)$ in (5.55), we deduce

that $(\overline{Y}^{t,x}, \overline{Z}^{t,x}, \overline{U}^{t,x})$ verifies: $\forall i \in \{1, \dots, m\}$

that
$$(\overline{Y}^{t,x}, \overline{Z}^{t,x}, \overline{U}^{t,x})$$

It follows that

$$\forall i \in \{1, \dots, m\}, \quad \overline{Y}^{i;t,x} = Y^{i;t,x}.$$

With the uniqueness of solution (5.53), we have $u^i = \overline{u}^i = v^i$ which means that the solution of (1.1) in the sense of Definition 5.1 is unique inside the class \mathcal{M} .

In this paper we have shown the existence and uniqueness of viscosity solution through BSDE by weakening the condition on the generator used in [3].

The question that arose now is to have the existence and uniqueness of viscosity solution through the RBSDEs.

Appendix

Barles and al.'s definition for viscosity solution of IPDE (1.1)

Definition 5.3 We say that a family of deterministics functions $u = (u^i)_{i=1,m}$ which is continuous $\forall i \in \{1, ..., m\}$, is a viscosity sub-solution (resp. super-solution) of the IPDE (1.1) if:

- (i) $\forall x \in \mathbb{R}^k$, $u^i(x,T) \leq g^i(x)$ (resp. $u^i(x,T) \geq g^i(x)$);
- (ii) For any $(t,x) \in [0,T] \times \mathbb{R}^k$ and any function ϕ of class $C^{1,2}([0,T] \times \mathbb{R}^k)$ such that (t,x) is a global maximum point of $u^i \phi$ (resp. global minimum point of $u^i \phi$) and $(u^i \phi)(t,x) = 0$, one has

$$\min \left\{ u^{i}(t,x) - \ell(t,x); -\partial_{t}\phi(t,x) - \mathcal{L}^{X}\phi(t,x) - h^{i}(t,x,(u^{j}(t,x))_{j=1,m},\sigma^{\top}(t,x))D_{x}\phi(t,x), B_{i}\phi(t,x)) \right\} \leq 0$$
(resp.

$$\min \left\{ u^{i}(t,x) - \ell(t,x); -\partial_{t}\phi(t,x) - \mathcal{L}^{X}\phi(t,x) - h^{i}(t,x,(u^{j}(t,x))_{j=1,m},\sigma^{\top}(t,x))D_{x}\phi(t,x), B_{i}\phi(t,x)(t,x)) \right\} \ge 0 \right\}.$$

The family $u = (u^i)_{i=1,m}$ is a viscosity solution of (1.1) if it is both a viscosity sub-solution and viscosity super-solution.

Note that
$$\mathcal{L}^X \phi(t,x) = b(t,x)^\top D_x \phi(t,x) + \frac{1}{2} \text{Tr}(\sigma \sigma^\top(t,x) D_{xx}^2 \phi(t,x)) + K \phi(t,x);$$

where $K \phi(t,x) = \int_{\mathcal{E}} (\phi(t,x+\beta(t,x,e)) - \phi(t,x) - \beta(t,x,e)^\top D_x \phi(t,x)) \lambda(de).$

Another Mao condition

In this paper it was mainly a question of the p-order Mao condition, it is necessary to know that there exists another condition of Mao which is mainly used in the case of monotony of the generator for apply the comparison theorem at the viscosity solution.

Definition 5.4 f satisfies the p-order one-sided Mao condition in x i.e., there exists a nondecreasing, concave function $\rho(\cdot): \mathbb{R}^+ \to \mathbb{R}^+$ with $\rho(0) = 0$, $\rho(u) > 0$, for u > 0 and $\int_{0^+} \frac{du}{\rho(u)} = +\infty$, such that $d\mathbb{P} \times dt - a.e., \forall x, x' \in \mathbb{R}^k$ and $\forall p \geq 2$,

$$<\frac{x-x'}{|x-x'|}\mathbb{1}_{|x-x'|\neq 0}, f(t,x,y,z,q) - f(t,x',y,z,q) > \le \rho^{\frac{1}{p}}(|x-x'|^p).$$

Remark 2 Applying Cauchy-Schwartz inequality for the p-order one-sided Mao condition, we deduce the p-order Mao condition.
