# UNIFORM A PRIORI ESTIMATES FOR ELLIPTIC PROBLEMS WITH IMPEDANCE BOUNDARY CONDITIONS

#### Abstract

We derive stability estimates in $H^{2}$ for elliptic problems with impedance boundary conditions that are uniform with respect to the impedance coefficient. Such estimates are of importance to establish sharp error estimates for finite element discretizations of contact impedance and high-frequency Helmholtz problems. Though stability in $H^{2}$ is easily obtained by employing a "bootstrap" argument and well-established result for the corresponding Neumann problem, this strategy leads to a stability constant that increases with the impedance coefficient. Here, we propose alternative proofs to derive sharp and uniform stability constants for domains that are convex or smooth.


## 1. Introduction

In this paper, we consider the following elliptic problem with impedance boundary conditions in a bounded domain $\Omega$ of $\mathbb{R}^{n}, n \in\{2,3\}$ :

A \boldsymbol{\nabla} u \cdot \boldsymbol{n}+\xi u & =0 & \\
\text { on } \Gamma_{\text {Diss }}, \\
u & =0 & \\
\text { on } \Gamma_{\text {Dir }},
\end{array}\right.
$$

where $f: \Omega \rightarrow \mathbb{C}$ is a given source term, and $\Gamma_{\text {Dir }}$ and $\Gamma_{\text {Diss }}$ are two disjoint open subsets of the boundary $\Gamma:=\partial \Omega$ of $\Omega$ such that $\overline{\Gamma_{\text {Dir }}} \cup \overline{\Gamma_{\text {Diss }}}=\partial \Omega$. In addition, $\Gamma_{\text {Diss }}$ is supposed to be non-empty, the matrix-valued function $A$ is supposed to be symmetric with real coefficients, smooth enough $\left(C^{0,1}\left(\Omega, \mathbb{R}^{n \times n}\right)\right)$ and positive definite, i.e.,

$$

and finally $\xi \in W^{1, \infty}\left(\Gamma_{\text {Diss }}\right)$ is a complex valued function (that for instance plays the role of the angular frequency or the contact impedance according to the context) such that

\operatorname{Im} \xi \geq 0 \text { on } \Gamma_{\text {Diss }} \text { or } \operatorname{Im} \xi \leq 0 \text { on } \Gamma_{\text {Diss }}, \\
|\xi| \geq c_{b} \text { on } \Gamma_{\text {Diss }} \tag{1.4}
\end{array}
$$

and finally

$$
\begin{equation*}
\frac{\left|\nabla_{T} \xi\right|}{|\xi|} \leq c_{\sharp} \text { on } \Gamma_{\text {Diss }}, \tag{1.5}
\end{equation*}
$$

[^0]for some two positive constants $c_{b}$ and $c_{\sharp}$.
Such a problem occur in different applications like complete electrode models [7, 10, 11, $14]$, singularly perturbed radiation problem [6,16], embedding of a quantum mechanically described structures into a macroscopic flow [12].
In addition, problem (1.1) with $A=I_{n}$ and a purely imaginary complex number $\xi=i \omega$, namely

was introduced in [8] (with $\mathcal{V}=1$ ) in order to derive pre-asymptotic error estimates for finite element discretizations of the standard Helmholtz problem

$$
\left\{\begin{array}{rll}
-\frac{\omega^{2}}{\mathcal{V}^{2}} u-\Delta u=f & \text { in } \Omega \\
\nabla u \cdot \boldsymbol{n}-\frac{i \omega}{\mathcal{V}} u=0 & \text { on } \Gamma_{\text {Diss }} \\
u=0 & \text { on } \Gamma_{\text {Dir }}
\end{array}\right.
$$

In this case a uniform $H^{2}$ estimate (in $\omega$ ) is needed and is formulated as an assumption in [8, Lemma 4.3]. This proof technique has been subsequently employed in later works [3, 5, 17, 18], but without a rigorous proof for the aforementioned estimate.
As a result, one of our motivations is to show that indeed such a uniform estimate is valid under realistic geometrical assumptions and for space dependent parameters $\mathcal{V}$. In this case, the (real-valued) function $\mathcal{V}$ corresponds to the wavespeed in the domain. For the sake of simplicity, we focus on the case where $\mathcal{V} \in C^{1}(\bar{\Omega})$. Such a model is employed in [15] for instance.

In most applications related to Helmholtz equation, the boundary $\Gamma_{\text {Dir }}$ is imposed, and represents an obstacle or the basis of a cavity. On the other hand, the boundary $\Gamma_{\text {Diss }}$ is artificially designed to approximate the Summerfeld condition. For complete electrode models, $\Gamma_{\text {Dir }}$ is empty and $\xi$ is different from zero on the electrodes.

We finish this section with some notations used in the remainder of the paper. For a bounded domain $D$, the usual norm and semi-norm of $H^{s}(D)(s \geq 0)$ are denoted by $\|\cdot\|_{s, D}$ and $|\cdot|_{s, D}$, respectively. Furthermore, the notation $A \lesssim B$ (resp. $A \gtrsim B$ ) means the existence of a positive constant $C_{1}$ (resp. $C_{2}$ ), which is independent of $A, B$ and $\xi$ (but might depend on $\Omega, c_{b}$ and $c_{\sharp}$ ), such that $A \leq C_{1} B$ (resp. $A \geq C_{2} B$ ). The notation $A \sim B$ means that $A \lesssim B$ and $A \gtrsim B$ hold simultaneously.

## 2. The weak formulation

Classically, assuming that $f \in L^{2}(\Omega)$, we recast (1.1) into the variational problem that consists in looking for $u \in H_{\Gamma_{\text {Dir }}}^{1}(\Omega)$ solution to

\begin{equation*}
B(u, v)=(f, v), \quad \forall v \in H_{\Gamma_{\mathrm{Dir}}}^{1}(\Omega) \tag{2.1}
\end{equation*}
$$

where

$$
B(u, v)=\langle\xi u, v\rangle_{\Gamma_{\mathrm{Diss}}}+(A \boldsymbol{\nabla} u, \nabla v)
$$

and

$$
H_{\Gamma_{\text {Dir }}}^{1}(\Omega)=\left\{v \in H^{1}(\Omega): \gamma_{0} v=0 \text { on } \Gamma_{\text {Dir }}\right\}
$$

$\gamma_{0}$ being the trace operator from $H^{1}(\Omega)$ to $H^{\frac{1}{2}}(\partial \Omega)$.
Under the previous assumption, the sesquilinear form $B$ is coercive on $H_{\Gamma_{\text {Dir }}}^{1}(\Omega)$ in the sense that

|B(v, v)| \gtrsim\|v\|_{1, \Omega}^{2}+\left\||\xi|^{\frac{1}{2}} v\right\|_{\Gamma_{\text {Diss }}}^{2}, \forall v \in H_{\Gamma_{\text {Dir }}}^{1}(\Omega) . \tag{2.2}
\end{equation*}
$$

Indeed writting $\xi=\sigma+i \omega$, for $v \in H_{\Gamma_{\text {Dir }}}^{1}(\Omega)$, due to (1.2) and (1.3), we have

$$
|B(v, v)|^{2}=\left(\int_{\Omega} A \boldsymbol{\nabla} v \cdot \nabla v d x+\left\|\sigma^{\frac{1}{2}} v\right\|_{\Gamma_{\text {Diss }}}^{2}\right)^{2}+\left\||\omega|^{\frac{1}{2}} v\right\|_{\Gamma_{\text {Diss }}}^{4}
$$

We then deduce that

$$
\begin{aligned}
|B(v, v)|^{2} & \geq\left(\int_{\Omega} A \nabla v \cdot \nabla v d x\right)^{2}+\left\|\sigma^{\frac{1}{2}} v\right\|_{\Gamma_{\text {Diss }}}^{4}+\left\||\omega|^{\frac{1}{2}} v\right\|_{\Gamma_{\text {Diss }}}^{4} \\
& \gtrsim\left(\int_{\Omega} A \nabla v \cdot \nabla v d x\right)^{2}+\left\||\xi|^{\frac{1}{2}} v\right\|_{\Gamma_{\text {Diss }}}^{4} \\
& \gtrsim|v|_{1, \Omega}^{4}+\left\||\xi|^{\frac{1}{2}} v\right\|_{\Gamma_{\text {Diss }}}^{4}
\end{aligned}
$$

Since we have supposed that $|\xi| \geq c_{b}$ and that $\Gamma_{\text {Diss }}$ is non-empty, we conclude that (2.2) holds with the following Poincaré inequality (see for instance Theorem 3.3 of [1] with $\varphi(v)=\left(1 /\left|\Gamma_{\text {Diss }}\right|\right) \int_{\Gamma_{\text {Diss }}} v(x) d \sigma(x)$, for all $v \in H^{1}(\Omega)$, see also [13, Theorem 1]):

$$
\|v\|_{0, \Omega} \lesssim|v|_{1, \Omega}+\|v\|_{\Gamma_{\text {Diss }}}
$$

Consequently by a variant of Lax-Milgram lemma (see [2, Theorem 2.1]), problem (2.1) has a unique solution $u \in H_{\Gamma_{\text {Dir }}}^{1}(\Omega)$ that satisfies

$$
\begin{equation*}
\|u\|_{1, \Omega}+\left\||\xi|^{1 / 2} u\right\|_{\Gamma_{\text {Diss }}} \lesssim\|f\| . \tag{2.3}
\end{equation*}
$$

The aim of our work is to find sufficient conditions that guarantee the $H^{2}$ regularity of the solution $u \in H_{\Gamma_{\text {Dir }}}^{1}(\Omega)$ of (2.1) with

$$
\begin{equation*}
\|u\|_{2, \Omega} \lesssim\|f\| \tag{2.4}
\end{equation*}
$$

where we recall that here and below the constant is independent of $\xi$ for $|\xi|$ large enough.
We finally mention that deriving (2.4) is not trivial, as the standard "bootstrap" argument fails. Looking at the boundary condition on $\Gamma_{\text {Diss }}$ as a non-homogeneous Neumann boundary condition

$$
A \boldsymbol{\nabla} u \cdot \boldsymbol{n}=-\xi u \text { on } \Gamma_{\text {Diss }},
$$

standard shift theorem yields the $H^{2}(\Omega)$ regularity of $u$, under some regularity assumptions on $\Gamma_{\text {Diss }}$ and $\Gamma_{\text {Dir }}$ since $\xi u$ belongs to $H^{1 / 2}\left(\Gamma_{\text {Diss }}\right)$. With such an approach we obtain the estimate

$$
\|u\|_{2, \Omega} \lesssim\|f\|+\|\xi u\|_{\frac{1}{2}, \Gamma_{\text {Diss }}}
$$

and using (2.3) we conclude that

$$
\|u\|_{2, \Omega} \lesssim\left(1+\max _{\Gamma_{\text {Diss }}}|\xi|^{\frac{1}{2}}\right)\|f\| .
$$

As a result, we obtain an estimate like (2.4) but with a constant depending on $\xi$.

## 3. The convex case

In this section we focus on the case of convex domains. Here, we make the additional assumptions that $\Gamma_{\text {Dir }}=\emptyset$, that $A$ is a constant matrix and that $\xi$ is constant. Though these hypothesis seem rather restrictive, we will employ a localization argument in Section 5 , and show that they are only required in in some neighborhood of the non-smooth parts of $\Gamma_{\text {Diss }}$ (e.g. edges and corners). We start by making the assumption that $A=I_{n}$ is the identity matrix. We will get back to the general case by a change of coordinates argument. In the remaining of this section, we employ the notation $\xi=\sigma+i \omega$, with $\sigma, \omega \in \mathbb{R}$ for the (unique) value taken by the function $\xi$.

Theorem 3.1. Assume that $\Omega$ is a convex domain with a $C^{2}$ boundary, that $A=I_{n}$ that $\Gamma_{\text {Dir }}=\emptyset$ and that $\xi$ is constant. Then the solution $u \in H_{\Gamma_{\text {Dir }}}^{1}(\Omega)$ to (2.1) belongs to $H^{2}(\Omega)$ and satisfies (2.4), more precisely

$$
\begin{equation*}
|u|_{2, \Omega} \leq\|f\| . \tag{3.1}
\end{equation*}
$$

Proof. $u \in H^{1}(\Omega)$ can be seen as the solution of the inhomogeneous Neumann problem

$$
\left\{\begin{aligned}
-\Delta u & =f & & \text { in } \Omega \\
\boldsymbol{\nabla} u \cdot \boldsymbol{n} & =-\xi u & & \text { on } \Gamma
\end{aligned}\right.
$$

where $\Gamma$ is the boundary of $\Omega$. Then, by Theorem 2.4.2.7 of [9], $u$ belongs to $H^{2}(\Omega)$ and hence $\boldsymbol{\nabla} u$ belongs to $H^{1}(\Omega)^{n}$. Consequently we can apply Theorem 3.1.1.1 of [9] to the real (resp. imaginary) part $\boldsymbol{V}$ (resp. $\boldsymbol{W}$ ) of $\boldsymbol{\nabla} u$ (in other words, writting $u=X+i Y$, with $X$ and $Y$ real-valued, we have $\boldsymbol{V}=\boldsymbol{\nabla} X$ and $\boldsymbol{W}=\boldsymbol{\nabla} Y$ ) to get

$$
\begin{aligned}
\int_{\Omega}\left(|\Delta X|^{2}+|\Delta Y|^{2}\right) d x-\left(|X|_{2, \Omega}^{2}\right. & \left.+|Y|_{2, \Omega}^{2}\right)=-2 \int_{\Gamma}\left(\boldsymbol{V}_{T} \cdot \boldsymbol{\nabla}_{T} V_{\boldsymbol{n}}+\boldsymbol{W}_{T} \cdot \boldsymbol{\nabla}_{T} W_{\boldsymbol{n}}\right) d \sigma \\
& -\int_{\Gamma} \mathcal{B}\left(\boldsymbol{V}_{T} ; \boldsymbol{V}_{T}\right)+\mathcal{B}\left(\boldsymbol{W}_{T} ; \boldsymbol{W}_{T}\right)+(\operatorname{tr} \mathcal{B})\left(V_{\boldsymbol{n}}^{2}+W_{\boldsymbol{n}}^{2}\right) d \sigma,
\end{aligned}
$$

where $\mathcal{B}$ is the second fundamental quadratic form of $\Gamma$ and $\operatorname{tr} \mathcal{B}$ is its trace(see $[9$, p. 133-134] for more details). $V_{\boldsymbol{n}}=\boldsymbol{V} \cdot \boldsymbol{n}$ is the normal component of $\boldsymbol{V}, \boldsymbol{V}_{T}=\boldsymbol{V}-(\boldsymbol{V} \cdot \boldsymbol{n}) \boldsymbol{n}$ is its tangential component and similar notations hold for $\boldsymbol{W}$. Due to the convexity of $\Omega$, $\mathcal{B}$ is non positive (see [9, p. 141]), and therefore the second term of this right-hand side is non negative. Therefore the previous identity implies that

$$
\int_{\Omega}\left(|\Delta X|^{2}+|\Delta Y|^{2}\right) d x-\left(|X|_{2, \Omega}^{2}+|Y|_{2, \Omega}^{2}\right) \geq-2 \int_{\Gamma}\left(\boldsymbol{V}_{T} \cdot \boldsymbol{\nabla}_{T} V_{\boldsymbol{n}}+\boldsymbol{W}_{T} \cdot \boldsymbol{\nabla}_{T} W_{\boldsymbol{n}}\right) d \sigma .
$$

But recalling that $\xi=\sigma+i \omega$, the boundary condition is equivalent to

$$
V_{n}=-\sigma X+\omega Y, \quad W_{n}=-\omega X-\sigma Y \text { on } \Gamma,
$$

and thus, we have

$$
\boldsymbol{\nabla}_{T} V_{\boldsymbol{n}}=-\sigma \boldsymbol{\nabla}_{T} X+\omega \boldsymbol{\nabla}_{T} Y, \quad \boldsymbol{\nabla}_{T} W_{\boldsymbol{n}}=-\omega \boldsymbol{\nabla}_{T} X-\sigma \boldsymbol{\nabla}_{T} Y
$$

Recalling that $\boldsymbol{V}_{T}=\boldsymbol{\nabla}_{T} X$ and $\boldsymbol{W}_{T}=\boldsymbol{\nabla}_{T} Y$, we may write

$$
\begin{aligned}
\int_{\Gamma}\left(\boldsymbol{V}_{T} \cdot \boldsymbol{\nabla}_{T} V_{\boldsymbol{n}}+\boldsymbol{W}_{T} \cdot \boldsymbol{\nabla}_{T} W_{\boldsymbol{n}}\right) d \sigma & =\int_{\Gamma} \omega\left(\boldsymbol{\nabla}_{T} X \cdot \boldsymbol{\nabla}_{T} Y-\boldsymbol{\nabla}_{T} Y \cdot \boldsymbol{\nabla}_{T} X\right) d \sigma \\
& -\int_{\Gamma} \sigma\left(\left|\boldsymbol{\nabla}_{T} X\right|^{2}+\left|\boldsymbol{\nabla}_{T} Y\right|^{2}\right) d \sigma \\
& =-\int_{\Gamma} \sigma\left(\left|\boldsymbol{\nabla}_{T} X\right|^{2}+\left|\boldsymbol{\nabla}_{T} Y\right|^{2}\right) d \sigma \\
& \leq 0 .
\end{aligned}
$$

This shows that

$$
\int_{\Omega}\left(|\Delta X|^{2}+|\Delta Y|^{2}\right) d x-\left(|X|_{2, \Omega}^{2}+|Y|_{2, \Omega}^{2}\right) \geq 0
$$

and proves (3.1).
In Theorem 3.1 we established (2.4) for smooth convex domains with an explicit constant that is independent of the domain. In Theorem 3.2, we extend this result to general convex domains. Following [9], the key idea is to regularize the boundary of the domain and employ the uniform estimate of Theorem 3.1.
Theorem 3.2. Assume that $\Omega$ is a convex domain, that $A=I_{n}$, that $\Gamma_{\mathrm{Dir}}=\emptyset$ and that $\xi$ is constant. Then the solution $u \in H_{\Gamma_{\text {Dir }}}^{1}(\Omega)$ to (2.1) belongs to $H^{2}(\Omega)$ and satisfies (2.4).
Proof. As in [9, p. 157], we approach $\Omega$ by a sequence of bounded and convex domains $\Omega_{m}, m \in \mathbb{N}$, with a $C^{2}$ boundary such that $\Omega \subset \Omega_{m}$ for all $m \in \mathbb{N}$, and $d\left(\Gamma_{m}, \Gamma\right) \rightarrow 0$ as $m \rightarrow \infty$, where $\Gamma_{m}$ is the boundary of $\Omega_{m}$.

Then for all $m \in \mathbb{N}$, we consider $u_{m} \in H^{2}\left(\Omega_{m}\right)$ solution to

$$
\left\{\begin{array}{rll}
-\Delta u_{m} & =\tilde{f} & \text { in } \Omega_{m}  \tag{3.2}\\
\boldsymbol{\nabla} u_{m} \cdot \boldsymbol{n}+\xi u_{m} & =0 & \text { on } \Gamma_{m}
\end{array}\right.
$$

where $\tilde{f}$ is the extension of $f$ by zero outside $\Omega$. Theorem 3.1 yields

$$
\begin{equation*}
\left|u_{m}\right|_{2, \Omega_{m}} \leq\|\tilde{f}\|_{\Omega_{m}}=\|f\| \tag{3.3}
\end{equation*}
$$

We first check that

$$
\begin{equation*}
\|v\|_{1, \Omega_{m}}^{2} \lesssim|v|_{1, \Omega_{m}}^{2}+\int_{\Gamma_{m}}|v|^{2} d \sigma \quad \forall v \in H^{1}\left(\Omega_{m}\right) \tag{3.4}
\end{equation*}
$$

where here and below in the proof, the constant is independent of $\xi$ but also of $m$. For that purpose, using Lemma 3.2.3.2 of [9] and its notation, in local coordinates $\left(z^{k}, y_{n}^{k}\right)$ in the hypercube $V_{k}=V_{k}^{\prime} \times\left(-a_{n}^{k}, a_{n}^{k}\right), k=1, \cdots, K$ (common to all $\Omega_{m}$ ), we may write

$$
v\left(z^{k}, y_{n}^{k}\right)=v\left(z^{k}, \varphi_{m}^{k}\left(z^{k}\right)\right)+\int_{\varphi_{m}^{k}\left(z^{k}\right)}^{y_{n}^{k}} \partial_{n} v\left(z^{k}, s\right) d s
$$

for any $v \in C^{\infty}\left(\bar{\Omega}_{m}\right)$. Note that, here and below, $\partial_{n}=\frac{\partial}{\partial y_{n}^{k}}$ is the partial derivative with respect to $y_{n}^{k}$, the dependency on $k$ is omitted for shortness. Taking the square of this identity and using Cauchy-Schwarz's inequality, we get

$$
\left|v\left(z^{k}, y_{n}^{k}\right)\right|^{2} \lesssim\left|v\left(z^{k}, \varphi_{m}^{k}\left(z^{k}\right)\right)\right|^{2}+\int_{-a_{n}^{k}}^{\varphi_{m}^{k}\left(z^{k}\right)}\left|\partial_{n} v\left(z^{k}, s\right)\right|^{2} d s
$$

Integrating this result in $y_{n}^{k} \in\left(-a_{n}^{k}, \varphi_{m}^{k}\left(z^{k}\right)\right)$ and in $z^{k} \in V_{k}^{\prime}$, one gets

$$
\|v\|_{0, \Omega_{m} \cap V_{k}}^{2} \lesssim\|v\|_{0, \Gamma_{m} \cap V_{k}}^{2}+|v|_{1, \Omega_{m} \cap V_{k}}^{2},
$$

where the hidden constant is independent of $m$. Summing up this estimate on $k$, and using a density argument, we arrive at

$$
\begin{equation*}
\|v\|_{0, O_{m}} \lesssim\|v\|_{0, \Gamma_{m}}+|v|_{1, \Omega_{m}} \quad \forall v \in H^{1}\left(\Omega_{m}\right) \tag{3.5}
\end{equation*}
$$

where $O_{m}$ is a neighborhood of $\Gamma_{m}$ defined by $O_{m}=\cup_{k=1}^{K}\left(\Omega_{m} \cap V_{k}\right)$. Hence defining $O=\cup_{k=1}^{K}\left(\Omega \cap V_{k}\right)$, we deduce that $O \subset O_{m}$.

By the compact embedding of $H^{1}(\Omega)$ into $L^{2}(\Omega)$ and the use of a contradiction argument, one easily shows that

$$
\|w\|_{0, \Omega} \lesssim\|w\|_{0, O}+|w|_{1, \Omega} \quad \forall w \in H^{1}(\Omega)
$$

Since any element $v \in H^{1}\left(\Omega_{m}\right)$ can be seen as an element of $H^{1}(\Omega)$, applying this estimate to $v$ and (3.5) and the fact that $O \subset O_{m}$ to estimate this right-hand side, we deduce that

$$
\begin{equation*}
\|v\|_{0, \Omega} \lesssim\|v\|_{0, \Gamma_{m}}+|v|_{1, \Omega_{m}} \quad \forall v \in H^{1}\left(\Omega_{m}\right) . \tag{3.6}
\end{equation*}
$$

As for $v \in H^{1}\left(\Omega_{m}\right)$, we clearly have

$$
\|v\|_{0, \Omega_{m}} \leq\|v\|_{0, \Omega}+\|v\|_{0, O_{m}}
$$

by (3.5) and (3.6), we conclude that

$$
\|v\|_{0, \Omega_{m}} \lesssim\|v\|_{0, \Gamma_{m}}+|v|_{1, \Omega_{m}},
$$

and consequently (3.4) holds.
If we come back to (3.2), using its variational formulation, (3.3) and (3.4) one gets

\left\|u_{m}\right\|_{2, \Omega_{m}} \lesssim\|f\|_{0, \Omega} \quad \forall m \in \mathbb{N} . \tag{3.7}
\end{equation*}
$$

Again as $\Omega \subset \Omega_{m}$, this estimate implies in particular that

\left\|u_{m}\right\|_{2, \Omega} \lesssim\|f\|_{0, \Omega} \quad \forall m \in \mathbb{N}
$$

Hence owing to the compact embedding of $H^{2}(\Omega)$ into $H^{s}(\Omega)$, for all $s<2$, we deduce that there exists $u \in H^{2}(\Omega)$ such that, up to a subsequence still denoted by $\left(u_{m}\right)_{m}$ for shortness, we have

\begin{align*}
& u_{m} \rightharpoonup u \text { weakly in } H^{2}(\Omega), \text { as } m \rightarrow \infty,  \tag{3.8}\\
& u_{m} \rightarrow u \text { strongly in } H^{s}(\Omega), \text { as } m \rightarrow \infty, \forall s<2, \tag{3.9}
\end{align*}
$$

and

$$
\begin{equation*}
\|u\|_{2, \Omega} \lesssim\|f\|_{0, \Omega} \tag{3.10}
\end{equation*}
$$

It remains to show that $u$ is the unique solution to (2.1). For that purpose, we fix an arbitrary element $v \in C^{\infty}(\bar{\Omega})$. As $\Omega$ has a Lipschitz boundary (see [9, Corollary 1.2.3.3], there exists an extension operator $E$ from $H^{1}(\Omega)$ into $H^{1}\left(\mathbb{R}^{n}\right)$ that is a linear, continuous and such that $E v=v$ in $\Omega$. Furthermore by [9, p. 23], Ev belongs to $H^{k}\left(\mathbb{R}^{n}\right)$, for all $k \in \mathbb{N}$, hence in particular it is $C^{1}$.

Let us first show that

$$
\begin{equation*}
\int_{\Omega_{m}} \boldsymbol{\nabla} u_{m} \cdot \boldsymbol{\nabla}(E v) d x \rightarrow \int_{\Omega} \boldsymbol{\nabla} u \cdot \boldsymbol{\nabla} v d x \tag{3.11}
\end{equation*}
$$

as $m \rightarrow \infty$. We may write

$$
\begin{aligned}
\left|\int_{\Omega_{m}} \boldsymbol{\nabla} u_{m} \cdot \boldsymbol{\nabla}(E v) d x-\int_{\Omega} \boldsymbol{\nabla} u \cdot \boldsymbol{\nabla} v d x\right| & =\left|\int_{\Omega} \boldsymbol{\nabla}\left(u_{m}-u\right) \cdot \boldsymbol{\nabla} v d x+\int_{\Omega_{m} \backslash \Omega} \boldsymbol{\nabla} u_{m} \cdot \boldsymbol{\nabla}(E v) d x\right| \\
& \leq\left\|u_{m}-u\right\|_{1, \Omega}\|v\|_{1, \Omega}+\left|u_{m}\right|_{1, \Omega_{m}}|E v|_{1, \Omega_{m} \backslash \Omega} .
\end{aligned}
$$

By (3.9), the first term of this right-hand side tends to zero as $m$ goes to infinity, while by (3.7), we have

$$
\left|u_{m}\right|_{1, \Omega_{m}}|E v|_{1, \Omega_{m} \backslash \Omega} \lesssim\|f\|_{0, \Omega}|E v|_{1, \Omega_{m} \backslash \Omega} .
$$

As the measure of $\Omega_{m} \backslash \Omega$ tends to zero and $E v \in C^{1}$, this right-hand side tends to zero as $m$ goes to infinity, which leads to (3.11).

Let us secondly show that

$$
\begin{equation*}
\int_{\Gamma_{m}} u_{m} E v d \sigma_{m} \rightarrow \int_{\Gamma} u v d \sigma \tag{3.12}
\end{equation*}
$$

as $m \rightarrow \infty$. We can fix cut-off functions $\theta_{k} \in \mathcal{D}\left(\mathbb{R}^{n}\right), k=1, \cdots, K$ such that the support of $\theta_{k}$ is included into $V_{k}$ and

$$
\sum_{k=1}^{K} \theta_{k}=1 \text { on } \Gamma \cup \Gamma_{m}
$$

for $m$ large enough, see [9, p. 162]. Consequently, for $m$ large enough, we may write

$$
\begin{align*}
& \int_{\Gamma_{m}} u_{m} E v d \sigma_{m}=\sum_{k=1}^{K} \int_{\Gamma_{m}} u_{m} \theta_{k} E v d \sigma_{m}  \tag{3.13}\\
&=\sum_{k=1}^{K} \int_{V_{k}^{\prime}} u_{m}\left(z, \varphi_{m}^{k}(z)\right) E v\left(z, \varphi_{m}^{k}(z)\right) \theta_{k}\left(z, \varphi_{m}^{k}(z)\right) \sqrt{1+\left|\nabla \varphi_{m}^{k}(z)\right|^{2}} d z
\end{align*}
$$

As $u_{m}$ belongs to $H^{2}\left(\Omega_{m}\right)$, it is continuous in $\bar{\Omega}_{m}$, and we may write

$$
u_{m}\left(z, \varphi_{m}^{k}(z)\right)-u_{m}\left(z, \varphi^{k}(z)\right)=\int_{\varphi^{k}(z)}^{\varphi_{m}^{k}(z)} \partial_{n} u_{m}(z, s) d s
$$

which yields the splitting

$$
u_{m}\left(z, \varphi_{m}^{k}(z)\right)=u\left(z, \varphi^{k}(z)\right)+r_{m, 1}(z)+r_{m, 2}(z)
$$

where the remainders are defined by

$$
\begin{aligned}
r_{m, 1}(z) & =u_{m}\left(z, \varphi^{k}(z)\right)-u\left(z, \varphi^{k}(z)\right), \\
r_{m, 2}(z) & =\int_{\varphi^{k}(z)}^{\varphi_{m}^{k}(z)} \partial_{n} u_{m}(z, s) d s
\end{aligned}
$$

Similarly we can split up $\operatorname{Ev}\left(z, \varphi_{m}^{k}(z)\right)$ into

$$
E v\left(z, \varphi_{m}^{k}(z)\right)=v\left(z, \varphi^{k}(z)\right)+s_{m}(z),
$$

where

$$
s_{m}(z)=\int_{\varphi^{k}(z)}^{\varphi_{m}^{k}(z)} \partial_{n} E v(z, s) d s
$$

All together we can split up

$$
\begin{aligned}
u_{m}\left(z, \varphi_{m}^{k}(z)\right) E v\left(z, \varphi_{m}^{k}(z)\right) & =u\left(z, \varphi^{k}(z)\right) v\left(z, \varphi^{k}(z)\right)+u\left(z, \varphi^{k}(z)\right) s_{m}(z) \\
& +r_{m, 1}(z) v\left(z, \varphi^{k}(z)\right)+r_{m, 1}(z) s_{m}(z) \\
& +r_{m, 2}(z) v\left(z, \varphi^{k}(z)\right)+r_{m, 2}(z) s_{m}(z), \\
& =X+R_{m, 1}+R_{m, 2}+R_{m, 3},
\end{aligned}
$$

where

$$
\begin{aligned}
X & =u\left(z, \varphi^{k}(z)\right) v\left(z, \varphi^{k}(z)\right) \\
R_{m, 1} & =u\left(z, \varphi^{k}(z)\right) s_{m}(z) \\
R_{m, 2} & =r_{m, 1}(z)\left[v\left(z, \varphi^{k}(z)\right)+s_{m}(z)\right] \\
R_{m, 3} & =r_{m, 2}(z)\left[v\left(z, \varphi^{k}(z)\right)+s_{m}(z)\right],
\end{aligned}
$$

These terms are now analyzed separately.

1. For $X$, as

$$
X \theta_{k}\left(z, \varphi_{m}^{k}(z)\right) \sqrt{1+\left|\nabla \varphi_{m}^{k}(z)\right|^{2}} \rightarrow X \theta_{k}\left(z, \varphi^{k}(z)\right) \sqrt{1+\left|\boldsymbol{\nabla} \varphi^{k}(z)\right|^{2}} \text { a.e. in } V_{k}^{\prime},
$$

$\theta_{k}\left(z, \varphi_{m}^{k}(z)\right) \sqrt{1+\left|\boldsymbol{\nabla} \varphi_{m}^{k}(z)\right|^{2}}$ is uniformly bounded (in $z$ and in $m$ ) and $u v$ is integrable in $\Gamma$, by Lebesgue's convergence theorem we deduce that

\begin{align*}
& \int_{V_{k}^{\prime}} u\left(z, \varphi^{k}(z)\right) v\left(z, \varphi^{k}(z)\right) \theta_{k}\left(z, \varphi_{m}^{k}(z)\right) \sqrt{1+\left|\boldsymbol{\nabla} \varphi_{m}^{k}(z)\right|^{2}} d z  \tag{3.14}\\
& \quad \rightarrow \int_{V_{k}^{\prime}} u\left(z, \varphi^{k}(z)\right) v\left(z, \varphi^{k}(z)\right) \theta_{k}\left(z, \varphi^{k}(z)\right) \sqrt{1+\left|\boldsymbol{\nabla} \varphi^{k}(z)\right|^{2}} d z
\end{align*}
$$

as $m \rightarrow \infty$.
2. The first reminder $R_{m, 1}$ is managed as follows, recalling that $\theta_{k}$ is bounded and that
$\left|\nabla \varphi_{m}^{k}(z)\right|$ is uniformly bounded:

\begin{aligned}
I_{m, 1} & :=\left|\int_{V_{k}^{\prime}} R_{m, 1} \theta_{k}\left(z, \varphi_{m}^{k}(z)\right) \sqrt{1+\left|\nabla \varphi_{m}^{k}(z)\right|^{2}} d z\right| \\
& \lesssim\left|\int_{V_{k}^{\prime}}\right| u\left(z, \varphi^{k}(z)\right)\left|\left|s_{m}(z)\right| d z\right| \lesssim\|u\|_{\infty, \Omega}\left\|s_{m}\right\|_{V_{k}^{\prime}} .
\end{aligned}
$$

This leads to

$$
\begin{equation*}
I_{m, 1} \rightarrow 0 \tag{3.15}
\end{equation*}
$$

as $m \rightarrow \infty$, if we can prove that

$$
\begin{equation*}
\left\|s_{m}\right\|_{V_{k}^{\prime}} \rightarrow 0 \tag{3.16}
\end{equation*}
$$

as $m \rightarrow \infty$. But, by Cauchy-Schwarz's inequality we have

$$
\begin{aligned}
\left\|s_{m}\right\|_{V_{k}^{\prime}}^{2} & \leq \int_{V_{k}^{\prime}}\left|\varphi^{k}(z)-\varphi_{m}^{k}(z)\right|^{2}\left(\int_{\varphi^{k}(z)}^{\varphi_{m}^{k}(z)}\left|\partial_{n} E v(z, s)\right|^{2} d s\right) d z \\
& \leq\left\|\varphi^{k}-\varphi_{m}^{k}\right\|_{\infty, V_{k}^{\prime}}|E v|_{1, V_{k} \cap \Omega_{m}}^{2} \\
& \lesssim\left\|\varphi^{k}-\varphi_{m}^{k}\right\|_{\infty, V_{k}^{\prime}}\|v\|_{1, \Omega}^{2} .
\end{aligned}
$$

This leads to (3.16) as $\varphi_{m}^{k}$ converges uniformly to $\varphi^{k}$ in $V_{k}^{\prime}$ (see again Lemma 3.2.3.2 of [9]).
3. The second reminder is easily estimated by

I_{m, 2}:=\left|\int_{V_{k}^{\prime}} R_{m, 2} \theta_{k}\left(z, \varphi_{m}^{k}(z)\right) \sqrt{1+\left|\nabla \varphi_{m}^{k}(z)\right|^{2}} d z\right| \lesssim\left\|u_{m}-u\right\|_{\infty, \Omega}\left(\left\|s_{m}\right\|_{0, V_{k}^{\prime}}+\|v\|_{0, \Gamma}\right),
$$

and we conclude that

$$
\begin{equation*}
I_{m, 2} \rightarrow 0 \tag{3.17}
\end{equation*}
$$

as $m \rightarrow \infty$, owing to (3.9) and the Sobolev embedding theorem.
4. For the last reminder, we notice as before that

$$
\left\|r_{m, 2}\right\|_{V_{k}^{\prime}}^{2} \leq\left\|\varphi^{k}-\varphi_{m}^{k}\right\|_{\infty, V_{k}^{\prime}}\left|u_{m}\right|_{1, V_{k} \cap \Omega_{m}}^{2}
$$

and by (3.7) and (3.9) we deduce that

$$
\begin{equation*}
\left\|r_{m, 2}\right\|_{V_{k}^{\prime}} \rightarrow 0 \tag{3.18}
\end{equation*}
$$

as $m \rightarrow \infty$. Consequently by Cauchy-Schwarz's inequality one obtain

$$
\begin{aligned}
I_{m, 3} & :=\left|\int_{V_{k}^{\prime}} r_{m, 2}(z)\left(v\left(z, \varphi^{k}(z)\right)+s_{m}(z)\right) \theta_{k}\left(z, \varphi_{m}^{k}(z)\right) \sqrt{1+\left|\nabla \varphi_{m}^{k}(z)\right|^{2}} d z\right| \\
& \lesssim\left\|r_{m, 2}\right\|_{V_{k}^{\prime}}\left(\|v\|_{\Gamma}+\left\|s_{m}\right\|_{V_{k}^{\prime}}\right)
\end{aligned}
$$

and (3.18) and (3.16) lead to

$$
\begin{equation*}
I_{m, 3} \rightarrow 0 \tag{3.19}
\end{equation*}
$$

as $m \rightarrow \infty$.
In summary using the properties (3.14) to (3.19) into the identity (3.13), we arrive at

$$
\int_{\Gamma_{m}} u_{m} E v d \sigma_{m} \rightarrow \sum_{k=1}^{K} \int_{V_{k}^{\prime}} u\left(z, \varphi^{k}(z)\right) v\left(z, \varphi_{m}^{k}(z)\right) \theta_{k}\left(z, \varphi^{k}(z)\right) \sqrt{1+\left|\boldsymbol{\nabla} \varphi^{k}(z)\right|^{2}} d z
$$

which is exactly (3.12).
In conclusion, starting from the variational formulation of (3.2) with the test-function $E v$ :

$$
\int_{\Omega_{m}} \boldsymbol{\nabla} u \cdot \boldsymbol{\nabla}(E v) d x+\xi \int_{\Gamma_{m}} u_{m} E v d \sigma_{m}=\int_{\Omega} f v d x
$$

passing to the limit in $m$ and using (3.11)-(3.12), one obtains

$$
\int_{\Omega} \boldsymbol{\nabla} u \cdot \boldsymbol{\nabla} v d x+\xi \int_{\Gamma} u v d \sigma=\int_{\Omega} f v d x
$$

Since this holds for all $v \in C^{\infty}(\bar{\Omega})$, by density this identity remains valid for all $v \in H^{1}(\Omega)$ and consequently $u$ is the unique solution of (2.1). The estimate (3.10) ends the proof.
Corollary 3.3. Assume that $\Omega$ is convex, that $\Gamma_{\mathrm{Dir}}=\emptyset$ and that $A$ and $\xi$ are constant. Then the solution $u \in H_{\Gamma_{\text {Dir }}}^{1}(\Omega)$ to (2.1) belongs to $H^{2}(\Omega)$ and satisfies (2.4).

Proof. Let us consider a matrix $T \in \mathbb{R}^{n \times n}$ such that

$$
T^{\top} A T=I_{n}
$$

then by the change of variables $\hat{x}=T^{\top} x$, and the change of unknown $\hat{u}(\hat{x})=u(x)$, we transform problem (2.1) into a similar one in $\hat{\Omega}$ with $A=I_{n}$ and $\widehat{\Gamma_{\text {Dir }}}=\emptyset$. Since a linear mapping preserves the convexity, $\hat{\Omega}$ is convex. Hence we conclude by applying Theorem 3.2 to $\hat{u}$ and using the transformation back.

## 4. The smooth case

In this section we show that Theorem 3.1 remains valid if the convexity assumption is replaced by the assumption that the boundary is of class $C^{1,1}$, but with no control of the constant in (3.1). Our proof is based on an adaptation of the so-called method of tangential differential quotients of Nirenberg (see [9] for instance). Let us start with two technical results, namely local $H^{2}$-regularity results: the first one concerns the case when $\Gamma_{\text {Diss }}$ is flat. Let $U=V \cap \mathbb{R}_{+}^{n}$, where $V$ is open domain of $\mathbb{R}^{n}$. To simplify notation, we set

$$
\begin{aligned}
& H_{c}^{1}(U)=\left\{u \in H^{1}(U) \mid \exists W \text { a neighborhood of } \partial V \backslash\left\{x_{n}=0\right\} \text { such that } u=0 \text { in } W\right\}, \\
& H_{+}^{1}(U)=\left\{u \in H^{1}(U) \mid \text { such that } u=0 \text { on } \partial V \backslash\left\{x_{n}=0\right\}\right\}, \\
& \Gamma_{U}=\partial V \cap\left\{x_{n}=0\right\} .
\end{aligned}
$$

Lemma 4.1. Assume that $u \in H_{c}^{1}(U)$ satisfies

$$
\left\{\begin{array}{rll}
-\boldsymbol{\nabla} \cdot(A \boldsymbol{\nabla} u) & =f & \text { in } U \\
A \boldsymbol{\nabla} u \cdot \boldsymbol{n}+\xi d u & =0 & \text { on } \Gamma_{U}
\end{array}\right.
$$

where $A \in C^{0,1}\left(\bar{U} ; \mathbb{R}^{n \times n}\right)$ is uniformly positive definite in $\bar{U}, d \in C^{1}\left(\Gamma_{U} ; \mathbb{R}\right)$ is a strictly positive function and $f \in L^{2}(U)$. Then $u$ belongs to $H^{2}(U)$ and satisfies

$$
|u|_{2, U} \lesssim\|f\|_{U}+\|u\|_{1, U}+\left\||\xi|^{1 / 2} u\right\|_{\Gamma_{U}} .
$$

Proof. Let us first notice that the regularity $u \in H^{2}(U)$ follows immediately from standard shift property since $\xi d u$ belongs to $H^{\frac{1}{2}}\left(\Gamma_{U}\right)$. Now, we introduce the "differential quotients" that we employ in the proof. Let $\left(e_{j}\right)_{j=1}^{n}$ denote the canonical basis of $\mathbb{R}^{n}$. For $h \in \mathbb{R}^{\star}$ and $i \in\{1, \ldots, n-1\}$ we introduce the translation operator $\tau_{j, h}$ defined by $\left(\tau_{j, h} \phi\right)(x)=$ $\phi\left(x+h e_{j}\right)$ for a scalar or vectorial function $\phi$. In addition, we define the differential quotient $D_{j, h}$ as

$$
D_{j, h} \phi=\frac{1}{|h|}\left(\tau_{j, h} \phi-\phi\right) .
$$

The key properties of $D_{j, h}$ can be found, for instance, in [4, Section 9.6].
Since $u \in H_{c}^{1}(U)$, we see that if $|h|$ is small enough, $\tau_{j, h} u \in H_{c}^{1}(U)$, and therefore, the function $v=D_{j,-h} D_{j, h} u \in H_{0}^{1}(U)$.

We recall that the variational formulation of (4.1) is

$$
\int_{U} A \boldsymbol{\nabla} u \cdot \nabla \bar{w} d x+\int_{\Gamma_{U}} \xi d u \bar{w} d \sigma=\int_{U} f \bar{v} \quad \forall w \in H_{+}^{1}(U)
$$

We select $w=v$ as a test function. Noticing that the adjoint operator of $D_{j, h}$ is $D_{j,-h}$, we obtain

$$
\begin{equation*}
\int_{U} D_{j, h}(A \boldsymbol{\nabla} u) \cdot \boldsymbol{\nabla} D_{j, h} \bar{u} d x+\int_{\Gamma_{U}} D_{j, h}(\xi d u) \overline{D_{j, h} u} d \sigma=\int_{U} f D_{j,-h} D_{j, h} \bar{u} d x \tag{4.1}
\end{equation*}
$$

Since for two functions $\psi$ and $\phi$, the discrete Leibniz rule $D_{j, h}(\psi \phi)=\left(D_{j, h} \psi\right)\left(\tau_{j, h} \phi\right)+$ $\psi\left(D_{j, h} \phi\right)$ holds, we get

$$
\begin{aligned}
\int_{U} D_{j, h}(A \boldsymbol{\nabla} u) \cdot \boldsymbol{\nabla} D_{j, h} \bar{u} d x & =\int_{U}\left(\left(D_{j, h} A\right)\left(\tau_{j, h} \boldsymbol{\nabla} u\right)\right) \cdot \boldsymbol{\nabla} D_{j, h} \bar{u} d x+\int_{U}\left|A^{\frac{1}{2}} \nabla D_{j, h} u\right|^{2} d x, \\
\int_{\Gamma_{U}} D_{j, h}(\xi d u) \overline{D_{j, h} u} d \sigma & =\int_{\Gamma_{U}} D_{j, h}(\xi d)\left(\tau_{j, h} u\right) \overline{D_{j, h} u} d \sigma+\int_{\Gamma_{U}} \xi d\left|D_{j, h} u\right|^{2} d \sigma .
\end{aligned}
$$

Therefore the previous identity may be transformed into

$$
\begin{align*}
& \int_{U}\left|A^{\frac{1}{2}} \boldsymbol{\nabla}\left(D_{j, h} u\right)\right|^{2} d x+\int_{\Gamma_{U}} \xi d\left|D_{j, h} u\right|^{2} d \sigma=  \tag{4.2}\\
& \int_{U} f D_{j,-h} D_{j, h} \bar{u} d x-\int_{U}\left(\left(D_{j, h} A\right)\left(\tau_{j, h} \boldsymbol{\nabla} u\right)\right) \cdot \nabla D_{j, h} \bar{u} d x-\int_{\Gamma_{U}} D_{j, h}(\xi d)\left(\tau_{j, h} u\right) \overline{D_{j, h} u} d \sigma .
\end{align*}
$$

Lemma 2.2.2.2 of [9] shows that $\left\|D_{j, h} \phi\right\|_{U} \leq\left\|D_{j} \phi\right\|_{U}$ for all $\phi \in H_{c}^{1}(U)$, where here and afterward, we use the notation

$$
D_{j}=\frac{\partial}{\partial \boldsymbol{x}_{j}}
$$

therefore, up to a subsequence $D_{j, h} \phi$ converges strongly to $D_{j} \phi$ in $L^{2}(U)$. Since we already know that $u$ belongs to $H^{2}(U)$, this argument yields that $D_{j, h} u$ converges strongly to $D_{j} u$ in $L^{2}(U)$, and that $D_{j, h} \boldsymbol{\nabla} u$ converges strongly to $D_{j} \boldsymbol{\nabla} u$ in $L^{2}(U)^{n}$ (up to a subsequence). Hence, in the identity (4.2), taking the limit when $h$ tends to 0 (up to a subsequence), we have

$$
\begin{align*}
\int_{U}\left|A^{\frac{1}{2}} \nabla D_{j} u\right|^{2} d x & +\int_{\Gamma_{U}} \xi d\left|D_{j} u\right|^{2} d \sigma=\int_{U} f D_{j}^{2} \bar{u} d x  \tag{4.3}\\
& -\int_{U}\left(D_{j} A\right) \nabla u \cdot \nabla D_{j} \bar{u} d x-\int_{\Gamma_{U}} D_{j}(\xi d) u \overline{D_{j} u} d \sigma .
\end{align*}
$$

Thus, taking the real part of (4.3), we have

\int_{U}\left|A^{\frac{1}{2}} \nabla D_{j} u\right|^{2} d x+ & \int_{\Gamma_{U}} \sigma d\left|D_{j} u\right|^{2} d \sigma \lesssim\|f\|_{U}\left\|D_{j}^{2} u\right\|_{U}+\left\|D_{j} A \nabla u\right\|_{U}\left\|D_{j} \nabla u\right\|_{U} \\
& +\operatorname{Re}\left(\int_{\Gamma_{U}}\left(\xi D_{j} d+d D_{j} \xi\right) u \overline{D_{j} u} d \sigma\right) \\
\lesssim & \left(\|f\|_{U}+\|u\|_{1, U}\right)\left\|\nabla D_{j} u\right\|_{U}+\left\||\xi|^{1 / 2} u\right\|_{\Gamma_{U}}\left\||\xi|^{1 / 2} D_{j} u\right\|_{\Gamma_{U}} \\
& +\operatorname{Re}\left(\int_{\Gamma_{U}} d \frac{D_{j}(\xi)}{\xi} \xi u \overline{D_{j} u} d \sigma\right) \\
\lesssim & \left(\|f\|_{U}+\|u\|_{1, U}\right)\left\|\nabla D_{j} u\right\|_{U}+\left\||\xi|^{1 / 2} u\right\|_{\Gamma_{U}}\left\||\xi|^{1 / 2} D_{j} u\right\|_{\Gamma_{U}}, \tag{4.4}
\end{align*}
$$

where we have used (1.5). On the other hand, by taking the imaginary part of (4.3), in the same way as (4.4), we have

Recalling that $A$ is positive definite, that $d \geq d_{0}>0$ and that $|\xi| \simeq \sigma+|\omega|$, it follows from (4.4) and (4.5) that

& \left.\lesssim \int_{U}\left|A^{\frac{1}{2}} \nabla D_{j} u\right|^{2} d x+\int_{\Gamma_{U}} \sigma d\left|D_{j} u\right|^{2} d \sigma+\left.\left|\int_{\Gamma_{U}} \omega d\right| D_{j} u\right|^{2} d \sigma \right\rvert\, \\
& \lesssim\left(\|f\|_{U}+\|u\|_{1, U}\right)\left\|\nabla D_{j} u\right\|_{U}+\left\||\xi|^{1 / 2} u\right\|_{\Gamma_{U}}\left\||\xi|^{1 / 2} D_{j} u\right\|_{\Gamma_{U}} .
\end{aligned}
$$

By Young's inequality we deduce that for all $\epsilon>0$,

& +\frac{C \epsilon}{2}\left\||\xi|^{1 / 2} D_{j} u\right\|_{\Gamma_{U}}^{2}+\frac{C}{2 \epsilon}\left\||\xi|^{1 / 2} u\right\|_{\Gamma_{U}}^{2},
\end{aligned}
$$

for some $C>0$ (independent of $\epsilon>0$ ). Choosing $\epsilon>0$ small enough so that $d_{0}-\frac{C \epsilon}{2} \geq 0$, we have

& \lesssim\left(\|f\|_{U}+\|u\|_{1, U}\right)\left\|\nabla D_{j} u\right\|_{U}+\left\||\xi|^{1 / 2} u\right\|_{\Gamma_{U}}^{2} .
\end{aligned}

Again by Young's inequality, we arrive at

Indeed, the right-hand-side only contains already estimated derivatives of $u$. We conclude the proof since

In the next lemma, we employ a change of coordinates to analyze the case of a $C^{1,1}$ boundary $\Gamma_{\text {Diss }}$.
Corollary 4.2. Let $\Omega$ be an open domain of $\mathbb{R}^{n}$ with a $C^{1,1}$ boundary. For $x \in \partial \Omega$ and $R>0$ small enough, we consider $V=\Omega \cap B(x, R)$ and $\Gamma_{V}=\partial \Omega \cap B(x, R)$ as well as the space

Assume that $u \in H_{c}^{1}(V)$ satisfies

\text { in } V, \\
A \boldsymbol{\nabla} u \cdot \boldsymbol{n}+\xi u & =0 & \text { on } \Gamma_{V},
\end{array}\right.
$$

where $A \in C^{0,1}\left(\bar{V}, \mathbb{R}^{n \times n}\right)$ is symmetric positive definite, and $f \in L^{2}(\Omega)$. Then

|u|_{2, V} \lesssim\|f\|_{V}+\|u\|_{1, V}+\left\||\xi|^{1 / 2} u\right\|_{\Gamma_{V}} .
$$

Proof. For $R$ small enough, there exists a $C^{1,1}$ diffeomorphism $\Phi$ from an open set $V_{2}$ of $\mathbb{R}^{n}$ onto $B(x, R)$, such that

Following [9, §2.2.2], $u^{\#}=u \circ \Phi^{-1}$ satisfies

with $d^{\#}$ a strictly positive $C^{1,1}$ function, $A^{\#}$ positive definite in $\bar{U}$, and $\xi^{\#}=\xi \circ \Phi^{-1}$. Hence, we can apply the previous lemma to this system and use a transformation back to conclude.

Theorem 4.3. If $\Omega$ is a bounded domain with a $C^{1,1}$ boundary such that $\overline{\Gamma_{\text {Dir }}} \cap \overline{\Gamma_{\text {Diss }}}=\emptyset$, then the solution $u \in H_{\Gamma_{\text {Dir }}}^{1}(\Omega)$ of (2.1) belongs to $H^{2}(\Omega)$ and satisfies (2.4).

Proof. We take an open covering of $\Omega=\cup_{1 \leq i \leq N} V_{i}$ with $V_{i}=B\left(x_{i}, R_{i}\right) \cap \Omega$ such that either $B\left(x_{i}, R_{i}\right) \subset \Omega$ or $x_{i} \in \partial \Omega$. We take a partition of unity $\left(\eta_{i}\right)_{1 \leq i \leq N}$ related to this covering, i. e., $\eta_{i} \in \mathcal{D}\left(V_{i}\right)$, for all $1 \leq i \leq N$ and $\sum_{i=1}^{N} \eta_{i}=1$ on $\bar{\Omega}$. So, for all $1 \leq i \leq N$, we may write

& =\int_{\Omega} A \boldsymbol{\nabla} u \cdot\left(\left(\boldsymbol{\nabla} \eta_{i}\right) \bar{v}+(\boldsymbol{\nabla} \bar{v}) \eta_{i}\right) d x+\int_{\partial \Omega} \xi \eta_{i} u \bar{v} d \sigma \\
& =\int_{\Omega} A \boldsymbol{\nabla}\left(\eta_{i} u\right) \cdot \boldsymbol{\nabla} \bar{v}+\left(\boldsymbol{\nabla} \eta_{i} \cdot A \boldsymbol{\nabla} u\right) \bar{v}-u\left(A \boldsymbol{\nabla} \eta_{i} \cdot \boldsymbol{\nabla} \bar{v}\right) d x+\int_{\partial \Omega} \xi \eta_{i} u \bar{v} d \sigma .
\end{aligned}
$$

Moreover, Green's formula yields

\int_{\Omega} u\left(A \boldsymbol{\nabla} \eta_{i} \cdot \boldsymbol{\nabla} \bar{v}\right) d x & =-\int_{\Omega} \boldsymbol{\nabla} \cdot\left(u A \boldsymbol{\nabla} \eta_{i}\right) \bar{v} d x+\int_{\partial \Omega} A \boldsymbol{\nabla} \eta_{i} \cdot \boldsymbol{n} u \bar{v} d \sigma \\
& =\int_{\Omega} \boldsymbol{\nabla} \cdot\left(u A \boldsymbol{\nabla} \eta_{i}\right) \bar{v} d x+\int_{\Gamma_{V_{i}}}\left(A \boldsymbol{\nabla} \eta_{i} \cdot \boldsymbol{n}\right) u \bar{v} d \sigma
\end{aligned}
$$

where we recall that $\Gamma_{V_{i}}=B\left(x_{i}, R_{i}\right) \cap \partial \Omega$. Hence, setting on $\Gamma_{V_{i}}, g=\left(A \boldsymbol{\nabla} \eta_{i} \cdot \boldsymbol{n}\right) u$, we deduce that

Now, we remark that there exists $\tilde{u}_{i} \in H_{c}^{1}\left(V_{i}\right) \cap H^{2}\left(V_{i}\right)$ such that

\end{equation*}

with

\begin{equation*}
\left\|\tilde{u}_{i}\right\|_{2, V_{i}} \lesssim\|u\|_{1, V_{i}} . \tag{4.7}
\end{equation*}
$$

Indeed as $\frac{1}{n^{\top} A n} \in C^{1,1}(\partial \Omega)$, this last problem is equivalent to

Now fix a larger domain $\tilde{V}_{i}$ than $V_{i}$ with a $C^{1,1}$ boundary that contains $\Gamma_{V_{i}}$. Furthermore let $\tilde{g}$ be the extension of $g$ by zero outside the support of $g$, Then Theorem 1.5.1.2 of [9] ensures the existence of a function $v_{i} \in H_{0}^{1}\left(\tilde{V}_{i}\right) \cap H^{2}\left(\tilde{V}_{i}\right)$ such that

A \boldsymbol{\nabla} v_{i} \cdot n=\tilde{g} \quad \text { on } \partial \tilde{V}_{i},

with

\left\|v_{i}\right\|_{2, \tilde{V}_{i}} \lesssim\left\|\frac{\tilde{g}}{n^{\top} A n}\right\|_{\frac{1}{2}, \partial \tilde{V}_{i}} \lesssim\|g\|_{\frac{1}{2}, \Gamma V_{i}} \lesssim\|u\|_{1, V_{i}}
$$

Then, we fix a cut-off function $\psi_{i}$ such that $\psi_{i}=1$ on the support of $g$ and that is zero in a neighbourhood of $\partial V_{i} \backslash \Gamma_{V_{i}}$. We readily check that

By Green's formula, we see that

\int_{V_{i}} A \boldsymbol{\nabla} \tilde{u}_{i} \cdot \boldsymbol{\nabla} \bar{v} d x & =\int_{V_{i}}-\boldsymbol{\nabla} \cdot\left(A \boldsymbol{\nabla} \tilde{u}_{i}\right) \bar{v} d x+\int_{\partial V_{i}} A \boldsymbol{\nabla} \tilde{u}_{i} \cdot n \bar{v} d \sigma \\
& =\int_{V_{i}}-\boldsymbol{\nabla} \cdot\left(A \boldsymbol{\nabla} \tilde{u}_{i}\right) \bar{v} d x+\int_{\Gamma_{V_{i}}} g \bar{v} d \sigma
\end{aligned}
$$

Then, by defining $u_{i}=\eta_{i} u-\tilde{u}_{i}$, we notice that $u_{i} \in H_{+}^{1}\left(V_{i}\right)$ verifies for all $v \in H^{1}(\Omega)$

B_{V_{i}}\left(u_{i}, v\right)= & B_{V_{i}}\left(\eta_{i} u, v\right)-B_{V_{i}}\left(\tilde{u}_{i}, v\right) \\
= & <\eta_{i} f, v>_{V_{i}}+<\boldsymbol{\nabla} \eta_{i} \boldsymbol{\nabla} u, v>_{V_{i}}+<\boldsymbol{\nabla} \cdot\left(u \boldsymbol{\nabla} \eta_{i}\right), v>_{V_{i}} \\
& +\int_{V_{i}} \boldsymbol{\nabla} \cdot\left(A \boldsymbol{\nabla} \tilde{u}_{i}\right) \bar{v} d x-\int_{\Gamma_{V_{i}}} g \bar{v} d \sigma+\int_{\Gamma_{V_{i}}} g \bar{v} d \sigma \\
= & <f_{i}, v>_{V_{i}},
\end{aligned}
$$

with

$$
B_{V_{i}}(u, v)=\int_{V_{i}} A \boldsymbol{\nabla} u \cdot \nabla \bar{v} d x+\int_{\Gamma_{V_{i}}} \xi u \bar{v} d \sigma
$$

$f_{i}=\eta_{i} f+\boldsymbol{\nabla} \cdot\left(u \boldsymbol{\nabla} \eta_{i}\right)+\boldsymbol{\nabla} \eta_{i} \boldsymbol{\nabla} u+\boldsymbol{\nabla} \cdot\left(A \boldsymbol{\nabla} \tilde{u}_{i}\right)$ and

$$
\begin{equation*}
\left\|f_{i}\right\|_{V_{i}} \lesssim\|f\|_{V_{i}}+\|u\|_{1, V_{i}} \tag{4.8}
\end{equation*}
$$

Now, we can apply Corollary 4.2 if $x_{i} \in \Gamma_{\text {Diss }}$ or Lemma 2.2.2.1 of [9] if $x_{i} \in \Gamma_{\text {Dir }} \cup \Omega$, to obtain

& \lesssim\|f\|_{V_{i}}+\|u\|_{1, V_{i}}+\left\||\xi|^{1 / 2} u\right\|_{\Gamma_{V_{i}}},
\end{aligned}
$$

and

$$
\left|\eta_{i} u\right|_{2, V_{i}} \lesssim\left|u_{i}\right|_{2, V_{i}}+\left|\tilde{u}_{i}\right|_{2, V_{i}} \lesssim\|f\|_{V_{i}}+\|u\|_{1, V_{i}}+\left\||\xi|^{1 / 2} u\right\|_{\Gamma_{V_{i}}} .
$$

This estimate and the triangle inequality lead to

& \lesssim\|f\|_{\Omega}+\|u\|_{1, \Omega}+\left\||\xi|^{1 / 2} u\right\|_{\Gamma_{\text {Diss }}}
\end{aligned}
$$

and we conclude with the help of (2.3).

## 5. The general case

We now consider the general case where the boundary of $\Omega$ is not necessarily convex or globally $C^{1,1}$ or when $\Gamma_{\text {Dir }}$ is empty or not. For the sake of simplicity, we focus on the case $A=I_{n}$, but similar results can be deduced for variable coefficients using the ideas developed below.

In this section, we also assume that $\Gamma_{\text {Dir }}$ and $\Gamma_{\text {Diss }}$ are piecewise $C^{1,1}$.
We also introduce two additional assumptions on $\Gamma_{\text {Diss }}$ and $\Gamma_{\text {Dir }}$. The first additional assumption concerns some geometrical restrictions along the points where mixed boundary conditions are imposed.

Assumption 1. $\Gamma_{\text {Diss }}$ is flat in a neighbourhood of each connected component of $\overline{\Gamma_{\text {Dir }} \cap \overline{\Gamma_{\text {Diss }}} .}$ Furthermore for all $x \in \overline{\Gamma_{\text {Dir }}} \cap \overline{\Gamma_{\text {Diss }}}$, there exists $\varepsilon_{x}>0$ small enough and a $C^{1,1}$ diffeomorphism $\Phi_{x}$ from a neighborhood $N_{x}$ of 0 onto $B\left(x, \varepsilon_{x}\right)$ of $x$ such that $\widehat{\Gamma_{\text {Dir }}}=\Phi_{x}^{-1}\left(\Gamma_{\text {Dir }} \cap\right.$ $\left.\bar{B}\left(x, \varepsilon_{x}\right)\right)$ and $\widehat{\Gamma_{\text {Diss }}}=\Phi_{x}^{-1}\left(\Gamma_{\text {Diss }} \cap \bar{B}\left(x, \varepsilon_{x}\right)\right)$ are flat and the angle along $\widehat{\widehat{\Gamma_{\text {Dir }}} \cap \widehat{\Gamma_{\text {Diss }}}}$ is $\frac{\pi}{2}$. We then set $W_{x}=\Phi_{x}^{-1}\left(B\left(x, \varepsilon_{x}\right) \cap \Omega\right)$ that coincides with a hypercube near 0 .
For the other points (recalling that $\Gamma_{\text {Diss }}$ and $\Gamma_{\text {Dir }}$ are open in $\mathbb{R}^{n-1}$ ), we require the next geometrical constraints.

Assumption 2. For all $x \in \Gamma_{\text {Diss }} \cup \Gamma_{\text {Dir }}$, there exists $\varepsilon_{x}>0$ small enough such that either the boundary of $B\left(x, \varepsilon_{x}\right) \cap \Omega$ is convex or the boundary of $\Omega$ is $C^{1,1}$ near $B\left(x, \varepsilon_{x}\right) \cap \Gamma$. Furthermore in dimension 3, if $x \in \Gamma_{\text {Diss }}$ and if $B\left(x, \varepsilon_{x}\right) \cap \Omega$ is only convex, we assume that $B\left(x, \varepsilon_{x}\right) \cap \Gamma_{\text {Diss }}$ is piecewise flat.

Without loss of generality, in this last assumption we can always assume that $\bar{B}\left(x, \varepsilon_{x}\right) \cap$ $\overline{\overline{\Gamma_{\text {Dir }}}}=\emptyset$ if $x \in \Gamma_{\text {Diss }}\left(\right.$ resp. $\bar{B}(x, \varepsilon) \cap \overline{\Gamma_{\text {Diss }}}=\emptyset$ if $\left.x \in \Gamma_{\text {Dir }}\right)$.

Under these assumptions, we have as before the
Theorem 5.1. If $\Omega$ is a bounded domain such that Assumptions 1 and 2 hold and if $\xi$ is contant on $B\left(x, \varepsilon_{x}\right)$ for all $x \in \Gamma_{\text {Diss }}$ such that $B\left(x, \varepsilon_{x}\right) \cap \Omega$ is only convex. Then the solution $u \in H_{\Gamma_{\text {Dir }}}^{1}(\Omega)$ of (2.1) with $A=I_{n}$ belongs to $H^{2}(\Omega)$ and satisfies (2.4).
Proof. We start by fixing an adequate finite covering of the boundary of $\Omega$. First for all $x \in \Gamma$, we fix $\varepsilon_{x}$ from Assumptions 1 and 2. This yields an open covering $\cup_{x \in \Gamma}\left(B\left(x, \varepsilon_{x}\right) \cap \Gamma\right)$ of $\Gamma$. Hence we can extract a finite covering

$$
\cup_{i=1}^{J}\left(B\left(x_{i}, \varepsilon_{i}\right) \cap \Gamma\right)
$$

of $\Gamma$ with $\varepsilon_{i}=\varepsilon_{x_{i}}$. Now we can fix a partition of unity $\left(\eta_{i}\right)_{i=1}^{N}$ such that the support of $\eta_{i}$ is included into $B\left(x_{i}, \varepsilon_{i}\right)$ and

$$
\sum_{i=1}^{N} \eta_{i}=1 \text { on } W,
$$

where $W$ is a neighborhood of $\Gamma$. Without loss of generality, we can assume that $\eta_{i}=1$ in a neighborhood of $x_{i}$ and that $\eta_{i}$ is radial, namely

$$
\eta_{i}(x)=\eta_{i}\left(\left|x-x_{i}\right|\right), \forall x \in B\left(x_{i}, \varepsilon_{i}\right) .
$$

For all $i=1, \cdots, N$, we look at $\eta_{i} u$ as the solution to the following problem (compare with (1.1))

$$
\left\{\begin{aligned}
-\Delta\left(\eta_{i} u\right) & =f_{i} & & \text { in } V_{i}:=B\left(x_{i}, \varepsilon_{i}\right) \cap \Omega, \\
\boldsymbol{\nabla}\left(\eta_{i} u\right) \cdot \boldsymbol{n}+\xi\left(\eta_{i} u\right) & =u \boldsymbol{\nabla} \eta_{i} \cdot \boldsymbol{n} & & \text { on } \partial V_{i} \backslash \overline{\Gamma_{\operatorname{Dir}}}, \\
u & =0 & & \text { on } \Gamma_{\operatorname{Dir}} \cap \partial V_{i},
\end{aligned}\right.
$$

where

$$
f_{i}:=\eta_{i} f+2 \boldsymbol{\nabla} \eta_{i} \cdot \nabla u+u \Delta \eta_{i}
$$

that belongs to $L^{2}\left(V_{i}\right)$ with

$$
\left\|f_{i}\right\|_{V_{i}} \lesssim\|f\|,
$$

owing to (2.3).
We distinguish four different cases:

1. if $x_{i} \in \Gamma_{\text {Diss }}$ and $B\left(x_{i}, \varepsilon_{i}\right) \cap \Gamma_{\text {Diss }}$ is $C^{1,1}$, then we can apply Theorem 4.3 (see its proof) to deduce that $\eta_{i} u$ belongs to $H^{2}(\Omega)$ with

$$
\begin{equation*}
\left\|\eta_{i} u\right\|_{2, V_{i}} \lesssim\left\|f_{i}\right\|_{V_{i}} \lesssim\|f\| . \tag{5.1}
\end{equation*}
$$

2. if $x_{i} \in \Gamma_{\text {Diss }}$ and $B\left(x_{i}, \varepsilon_{i}\right) \cap \Gamma_{\text {Diss }}$ is only convex but is piecewise flat, then we can apply Theorem 3.2 because

$$
\begin{equation*}
\boldsymbol{\nabla} \eta_{i} \cdot \boldsymbol{n}=0 \text { on } \Gamma_{\mathrm{Diss}} \cap \bar{B}\left(x_{i}, \varepsilon_{i}\right) . \tag{5.2}
\end{equation*}
$$

In such a case, we still conclude that $\eta_{i} u$ belongs to $H^{2}(\Omega)$ and satisfies (5.1).
On the contrary if $B\left(x_{i}, \varepsilon_{i}\right) \cap \Gamma_{\text {Diss }}$ is only piecewise $C^{1,1}$ (which is allowed only in dimension 2 and is of interest when $x_{i}$ is a corner), we cannot directly apply

Theorem 3.2 to $\eta_{i} u$ because it does not satisfy the homogeneous absorbing boundary condition. But in view of the proof of Theorem 4.3, it suffices to find a lifting $\tilde{u}_{i} \in H_{c}^{1}\left(V_{i}\right) \cap H^{2}\left(V_{i}\right)$ satisfying (4.6) (with $A=I_{n}$ ) and (4.7). But in this case, we can use Theorem 1.5.2.8 of [9], because $\left(\boldsymbol{\nabla} \eta_{i} \cdot \boldsymbol{n}\right) u$ is zero near $x_{i}$. With the help of this lifting, we can apply Theorem 3.2 to $\eta_{i} u-\tilde{u}_{i}$ and conclude as in the first item.
3. if $x_{i} \in \Gamma_{\text {Dir }}$, then, as $\eta_{i} u$ belongs to $H_{0}^{1}\left(B\left(x_{i}, \varepsilon\right) \cap \Omega\right)$, by Theorem 2.2.2.3 or Theorem 3.2.1.2 of [9], we conclude that $\eta_{i} u$ belongs to $H^{2}(\Omega)$ and satisfies (5.1).
4. if $x_{i} \in \overline{\Gamma_{\text {Dir }}} \cap \overline{\Gamma_{\text {Diss }}}$, then we first perform a change of variables

$$
x=\Phi_{i}(\hat{x})
$$

with $\hat{x} \in N_{x_{i}}$ that transforms problem (2.1) in $V_{i}$ into a similar problem in $W_{x_{i}}$ but with an operator with variable coefficients. Denote by $\hat{u}_{i}(\hat{x})=\eta_{i}(x) u(x)$. Since the angle along $\widehat{\widehat{\Gamma_{\text {Dir }}}} \cap \overline{\widehat{\Gamma_{\text {Diss }}}}$ is $\frac{\pi}{2}$, we then perform an odd reflexion of $\hat{u}_{i}$ in $W_{x_{i}}$ with respect to $\widehat{\Gamma_{\text {Dir }}}$. Up to some rotations, we can assume that $\widehat{\Gamma_{\text {Dir }}}$ is perpendicular to the $\hat{x}_{n}$-axis and that $W_{x_{i}}$ is included into the half-plane $\hat{x}_{n}>0$. Then we denote by

$$
R_{i}=\left\{\left(\hat{x}^{\prime}, \hat{x}_{n}\right) \in \mathbb{R}^{n}:\left(\hat{x}^{\prime},\left|\hat{x}_{n}\right|\right) \in W_{x_{i}}\right\}
$$

and define $O\left(\hat{u}_{i}\right)$ on $R_{i}$ as follows:

$$
O\left(\hat{u}_{i}\right)\left(\hat{x}^{\prime}, \hat{x}_{n}\right)= \begin{cases}\hat{u}_{i}\left(\hat{x}^{\prime}, \hat{x}_{n}\right) & \text { if }\left(\hat{x}^{\prime}, \hat{x}_{n}\right) \in W_{x_{i}}, \\ -\hat{u}_{i}\left(\hat{x}^{\prime},-\hat{x}_{n}\right) & \text { if }\left(\hat{x}^{\prime},-\hat{x}_{n}\right) \in W_{x_{i}} .\end{cases}
$$

As usual, $O\left(\hat{u}_{i}\right)$ belongs to $H^{1}\left(R_{i}\right)$ and is solution of problem (2.1) in $R_{i}$ with an operator with variable coefficients (but in $C^{0,1}$ ), a dissipative boundary condition on its whole boundary and a datum $O\left(\hat{f}_{i}\right)$. As $R_{i}$ is smooth near 0 , by Theorem 4.3 we deduce that $O\left(\hat{u}_{i}\right)$ belongs to $H^{2}\left(R_{i}\right)$ with

$$
\left\|O\left(\hat{u}_{i}\right)\right\|_{2, R_{i}} \lesssim\left\|O\left(\hat{f}_{i}\right)\right\|_{W_{i}}=2\left\|\hat{f}_{i}\right\|_{W_{x_{i}}} \lesssim\left\|f_{i}\right\|_{V_{i}} \lesssim\|f\| .
$$

Restricting ourselves to $W_{x_{i}}$, we get

$$
\left\|\hat{u}_{i}\right\|_{2, W_{x_{i}}} \lesssim\|f\| .
$$

Performing the transformation back, we deduce that $\eta_{i} u$ belongs to $H^{2}\left(V_{i}\right)$ and satisfies (5.1).
All together, we have shown that in all cases, $\eta_{i} u$ belongs to $H^{2}(\Omega)$ and satisfies (5.1). Consequently $u$ belongs to $H^{2}(W)$ for one neighborhood $W$ of $\Gamma$ and summing (5.1) on $i$, one has

$$
\begin{equation*}
\|u\|_{2, W} \lesssim\|f\| . \tag{5.3}
\end{equation*}
$$

For the regularity in the interior of $\Omega$, we fix a cut-off function $\psi \in \mathcal{D}(\Omega)$ such that

$$
\psi=1 \text { on } \Omega \backslash W
$$

Then $\psi u$ can be seen as the solution of the Dirichlet problem in a smooth domain $S$ included into $\Omega$, its boundary being supposed to be included into the set where $\psi=0$ with

a datum equal to

$$
\psi f+2 \boldsymbol{\nabla} \psi \cdot \nabla u+u \Delta \psi
$$

Hence $\psi u$ belongs to $H^{2}(S)$ with

$$
\|\psi u\|_{2, S} \lesssim\|\psi f+2 \boldsymbol{\nabla} \psi \cdot \nabla u+u \Delta \psi\|
$$

and consequently by (2.3)

$$
\begin{equation*}
\|\psi u\|_{2, S} \lesssim\|f\| . \tag{5.4}
\end{equation*}
$$

We conclude with estimates (5.3) and (5.4).
Assumptions 1 and 2 are satisfied in a number of applications, as illustrated by Figures 1,2 and 3 . The first case depicted in Figure 1 (resp. 2) corresponds to the diffraction by an obstacle $\mathcal{O}$ with a $C^{1,1}$ boundary $\Gamma_{\text {Dir }}$ where the artifical boundary $\Gamma_{\text {Diss }}$ is the boundary of a parallelipiped (resp. a ball) $R$ such that $\overline{\mathcal{O}} \subset R$. Hence the domain $\Omega$ of interest is $R \backslash \mathcal{O}$, with the above choice of $\Gamma_{\text {Dir }}$ and $\Gamma_{\text {Diss. }}$. Since in this case they are disjoint, Assumption 1 is irrelevant, while Assumption 2 is automatically satisfied. The second example illustrated by Figure 3 concerns cavities builded up as follows: take a bounded domain $D$ of $\mathbb{R}^{n}$ with a $C^{1,1}$ boundary or being convex and fix a hyperplane $\Pi$ for which $D \cap \Pi$ is not empty. If $H$ is one of the half space induced by $\Pi$, the domain $\Omega$ is defined as $D \cap H, \Gamma_{\text {Dir }}=\partial D \cap H$ and $\Gamma_{\text {Diss }}=\Pi \cap D$. By the regularity assumption made on $\partial D$, Assumption 2 holds. In order to guarantee Assumption 1 we need that that the boundary of $D$ is $C^{1,1}$ along the edge $\Pi \cap \partial D=\overline{\overline{D_{\text {Diss }}}} \cap \overline{\Gamma_{\text {Dir }}}$ and that for all $x \in \Pi \cap \partial D$, the interior angle between $\Pi$ and the hyperplane tangent to $\partial D$ at $x$ is less or equal to $\frac{\pi}{2}$. The verification of the Assumption 1 is made in the next Lemma.

Lemma 5.2. For the family of cavities described here above, Assumption 1 holds.

Proof. We start with the two-dimensional case, i.e., $n=2$. Fix one point $x \in \overline{\Gamma_{\text {Diss }}} \cap \overline{\Gamma_{\text {Dir }}}$, then by assumption there exist a neighborhood $V$ of $x$ and a local orthogonal coordinates system $\left(y_{1}, y_{2}\right)$ such that $V$ is a rectangle in this system, i.e.,

$$
V=\prod_{j=1}^{2}\left(-a_{j}, a_{j}\right)
$$

with $a_{j}>0$. Furthermore there exists a $C^{1,1}$ mapping $\varphi:\left(-a_{1}, a_{1}\right) \rightarrow \mathbb{R}$ such that

$$
\begin{aligned}
V \cap D & =\left\{\left(y_{1}, y_{2}\right) \in V ; y_{2}<\varphi\left(y_{1}\right), y_{1} \in\left(-a_{1}, a_{1}\right)\right\} \\
V \cap \partial D & =\left\{\left(y_{1}, y_{2}\right) \in V ; y_{2}=\varphi\left(y_{1}\right), y_{1} \in\left(-a_{1}, a_{1}\right)\right\} .
\end{aligned}
$$

Furthermore, we can assume that the line $\Pi$ is the line $y_{1}=0$ and by our assumption we then have

$$
D \cap \Pi \cap V \subset\left\{\left(y_{1}, y_{2}\right) \in \mathbb{R}^{2}: y_{1}>0\right\} .
$$

Hence the change of variables

$$
\left\{\begin{array}{l}
\hat{y}_{1}=y_{1}, \\
\hat{y}_{2}=y_{2}-\varphi\left(y_{1}\right),
\end{array}\right.
$$

allows to map the line $y_{1}=0$ into the line $\hat{y}_{1}=0$ and to flatten the curved boundary $\partial D$ into the line $\hat{y}_{2}=0$. Furthermore the domain $D \cap \Pi \cap V$ will be mapped into $W_{x}$ that coincides with the quater plane $\hat{y}_{1}>0, \hat{y}_{2}<0$ near $(0,0)$. As $\varphi$ is $C^{1,1}$, this change of variables implies that the mapping

$$
\Psi:\left(y_{1}, y_{2}\right) \rightarrow\left(y_{1}, y_{2}-\varphi\left(y_{1}\right)\right)
$$

is $C^{1,1}$ and invertible because

$$
\operatorname{det} J_{\Psi}(y)=1
$$

Hence its inverse $\Phi$ is a $C^{1,1}$ diffeomorphism, which proves that Assumption 1 holds.
The proof is fully similar in dimension 3. In that case, for $x \in \overline{\Gamma_{\text {Diss }}} \cap \overline{\Gamma_{\text {Dir }}}$, we can assume that there exists a local orthogonal coordinates system $\left(y_{1}, y_{2}, y_{3}\right)$ such that $\partial D$ is described near $x$ by the curve $y_{3}=\varphi\left(y_{1}, y_{2}\right)$ with a $C^{1,1}$ mapping $\varphi$, and $\Pi \equiv y_{1}=0$. Hence the change of variables

$$
\left\{\begin{array}{l}
\hat{y}_{1}=y_{1}, \\
\hat{y}_{2}=y_{2}, \\
\hat{y}_{3}=y_{3}-\varphi\left(y_{1}, y_{2}\right),
\end{array}\right.
$$

allows to map the plane $y_{1}=0$ into the plane $\hat{y}_{1}=0$ and to flatten the curved boundary $\partial D$ into the plane $\hat{y}_{3}=0$. The remainder of the proof being the same as in dimension 2 , we skip it.

The cavity illustrated in Fig. 4 is not covered by our general framework, while Theorem 5.1 remains valid in this case since at each corner belonging $\overline{\Gamma_{\text {Dir }}} \cap \overline{\Gamma_{\text {Diss }}}$, two successive odd reflexions along the Dirichlet faces allow to apply Theorem 4.3.
