# An overview on skew constacyclic codes and their subclass of LCD codes.

#### Abstract

This paper is about a first characterization of LCD skew constacyclic codes and some constructions of LCD skew cyclic and skew negacyclic codes over $\mathbb{F}_{p^{2}}$.


Keywords Skew polynomial rings, skew constacyclic codes, LCD codes, MDS codes

## 1 Introduction

One of the most active and important research areas in noncommutative algebra is the investigation of skew polynomial rings. Recently they have been successfully applied in many areas and specially in coding theory. The principal motivation for studying codes in this setting is that polynomials in skew polynomials rings exhibit many factorizations and hence there are many more ideals in a skew polynomial ring than in the commutative case. The research on codes in this setting has resulted in the discovery of many new codes with better Hamming minimum distances than any previously linear code with the same parameters. Some of them were given in [3, 4, 5, 6, 7, 8].

On the other hand, constacyclic codes over finite fields is an important class of linear codes as it includes the well-known family of cyclic codes. They also have many practical applications as they can be efficiently encoded using simple shift registers. Further, they have a rich algebraic structure which can be used for efficient error detection and correction.

Linear complementary dual (LCD) codes, were introduced by Massey [17. They provide an optimum linear coding solution for the two-user binary adder channel, and in [18] it was shown that asymptotically good LCD codes exist. Since then, several authors have studied these codes
 noncommutative case.

This article is organized as follows. In Section 2, some preliminaries are given about skew constacyclic codes over finite fields and skew polynomial rings. In Section 3. conditions for the equivalency between skew constacyclic codes, skew cyclic codes and skew negacyclic codes are provided. We give examples of skew cyclic codes which are not equivalent to any skew negacyclic codes in the case when the length is even. In Section 4 the notion of LCD skew constacyclic codes is introduced and we give some characterizations of their skew generator polynomials. Section 5 focuses on the construction and enumeration of LCD skew cyclic and negacyclic codes over $\mathbb{F}_{p^{2}}$. If $p$ is odd, the Euclidean LCD $\theta$-cyclic codes of length $2 p^{s}$ and dimension $p^{s}$ over $\mathbb{F}_{p^{2}}$ are all Hermitian LCD codes. All MDS LCD skew codes of length $\leq 16$ over $\mathbb{F}_{p^{2}}$ for $p \in\{3,5,7\}$ are obtained and the results are presented in tables.

## 2 Preliminaries

Let $q$ be a prime power, $\mathbb{F}_{q}$ a finite field and $\theta$ an automorphism of $\mathbb{F}_{q}$. We define the skew polynomial ring $R$ as

$$
R=\mathbb{F}_{q}[x ; \theta]=\left\{a_{0}+a_{1} x+\ldots+a_{n-1} x^{n-1} \mid a_{i} \in \mathbb{F}_{q} \text { and } n \in \mathbb{N}\right\}
$$

under usual addition of polynomials and where multiplication is defined using the rule $\forall a \in$ $\mathbb{F}_{q}, x \cdot a=\theta(a) x$. The ring $R$ is noncommutative unless $\theta$ is the identity automorphism on $\mathbb{F}_{q}$. According to [20], an element $f \in R$ is central if and only if $f$ is in $\mathbb{F}_{q}^{\theta}\left[x^{\mu}\right]$ where $\mu$ is the order of the automorphism $\theta$ and $\mathbb{F}_{q}^{\theta}$ is the fixed field of $\theta$. The two-sided ideals of $R$ are generated by elements having the form $\left(c_{0}+c_{1} x^{\mu}+\ldots+c_{n} x^{n \mu}\right) x^{l}$, where $l$ is an integer. Central elements of $R$ are the generators of two-sided ideals in $R$ 6]. The ring $R$ is Euclidean on the right : the division on the right is defined as follows. Let $f$ and $g$ be in $R$ with $f \neq 0$. Then there exist unique skew polynomials $q$ and $r$ such that

$$
g=q \cdot f+r \quad \operatorname{deg}(r)<\operatorname{deg}(f)
$$

If $r=0$ then $f$ is a right divisor of $g$ in $R(20)$. There exists greatest common right divisors (gcrd) and least common left multiples (lclm). The ring $R$ is also Euclidean on the left : there exist a division on the left, greatest common left divisors (gcld) as well as least common right multiples (lcrm).

In what follows, we consider a positive integer $n$ and a constant $\lambda$ in $\mathbb{F}_{q}^{*}$. We assume that $n$ is a multiple of the order of $\theta$ and $\lambda$ fixed by $\theta$, which means that $x^{n}-\lambda$ is central.

According to [ [6], [10]], a linear code $C$ of length $n$ over $\mathbb{F}_{q}$ is said to be $(\theta, \lambda)$-constacyclic or skew $\lambda$-constacyclic if it satisfies

$$
\forall c \in C, c=\left(c_{0}, c_{1}, \ldots, c_{n-1}\right) \in C \Rightarrow\left(\lambda \theta\left(c_{n-1}\right), \theta\left(c_{0}\right), \ldots, \theta\left(c_{n-2}\right)\right) \in C
$$

Any element of the quotient algebra $R /\left\langle x^{n}-\lambda\right\rangle$ is uniquely represented by a polynomial $\beta_{0}+\beta_{1} x+\ldots+\beta_{n-1} x^{n-1}$ of degree less than $n$, hence is identified with a word ( $\beta_{0}, \beta_{1}, \ldots, \beta_{n-1}$ ) of length $n$ over $\mathbb{F}_{q}$.

In this way, any skew $\lambda$-constacyclic code $C$ of length $n$ over $\mathbb{F}_{q}$ is identified with exactly one left ideal of the quotient algebra $R /\left\langle x^{n}-\lambda\right\rangle$, which is generated by a right divisor $g$ of $x^{n}-\lambda$. In that case, $g$ is called a skew generator polynomial of $C$ and we will denote $C=<g>_{n}$.

Note that the skew 1-constacyclic codes are skew cyclic codes and the skew -1-constacyclic codes are skew negacyclic codes.

The Hamming weight $w t(y)$ of an n-tuple $y=\left(y_{l}, y_{2} \ldots y_{n}\right) \in \mathbb{F}_{q}^{n}$ is the number of nonzero entries in $y$, that is, $w t(y)=\left|\left\{i: y_{i} \neq 0\right\}\right|$. The minimum distance of a linear code $C$ is $\min _{c \in C, c \neq 0} w t(c)$.

A $\mathbb{F}_{q}$-linear transformation $T: \mathbb{F}_{q}^{n} \rightarrow \mathbb{F}_{q}^{n}$ is a monomial transformation if there exists a permutation $\sigma$ of $\{1,2 \ldots n\}$ and nonzero elements $\alpha_{1}, \alpha_{2}, \ldots, \alpha_{n}$ of $\mathbb{F}_{q}^{n}$ such that

$$
T\left(y_{1}, y_{2}, \ldots, y_{n}\right)=\left(\alpha_{1} y_{\sigma(1)}, \alpha_{2} y_{\sigma(2)}, \ldots, \alpha_{n} y_{\sigma(n)}\right)
$$

for all $\left(y_{1}, y_{2} \ldots y_{n}\right) \in \mathbb{F}_{q}^{n}$. Two linear codes $C_{1}$ and $C_{2}$ in $\mathbb{F}_{q}^{n}$ are equivalent if there exists a monomial transformation $T: \mathbb{F}_{q}^{n} \rightarrow \mathbb{F}_{q}^{n}$ taking $C_{1}$ to $C_{2}$ (i.e. there exists a linear Hamming isometry [16]).

The Euclidean dual of a linear code $C$ of length $n$ over $\mathbb{F}_{q}$ is defined as $C^{\perp}=\left\{x \in \mathbb{F}_{q}^{n} \mid \forall y \in\right.$ $C,<x, y>=0\}$ where for $x, y$ in $\mathbb{F}_{q}^{n},<x, y>:=\sum_{i=1}^{n} x_{i} y_{i}$ is the (Euclidean) scalar product of $x$ and $y$. A linear code is called an Eulidean LCD code if $C \oplus C^{\perp}=\mathbb{F}_{q}^{n}$, which is equivalent to $C \cap C^{\perp}=\{0\}$.

Assume that $q=r^{2}$ is an even power of an arbitrary prime and denote for $a$ in $\mathbb{F}_{q}, \bar{a}=a^{r}$. The Hermitian dual of a linear code $C$ of length $n$ over $\mathbb{F}_{q}$ is defined as $C^{\perp_{H}}=\left\{x \in \mathbb{F}_{q}^{n} \mid \forall y \in\right.$ $\left.C,<x, y>_{H}=0\right\}$ where for $x, y$ in $\mathbb{F}_{q}^{n},<x, y>_{H}:=\sum_{i=1}^{n} x_{i} \overline{y_{i}}$ is the (Hermitian) scalar product of $x$ and $y$. The code $C$ is a Hermitian LCD code if $C \cap C^{\perp_{H}}=\{0\}$.

The skew reciprocal polynomial of $g=\sum_{i=0}^{k} g_{i} x^{i} \in R$ of degree $k$ is $g^{*}=\Sigma_{i=0}^{k} \theta^{i}\left(g_{k-i}\right) x^{i}$. The left monic skew reciprocal polynomial of $g$ is $g^{\natural}=\left(1 / \theta^{k}\left(g_{0}\right)\right) g^{*}$. If a skew polynomial is equal to its left monic skew reciprocal polynomial, then it is called self-reciprocal.

Consider $\lambda$ in $\left(\mathbb{F}_{q}^{\theta}\right)^{*}$ and $C$ a skew $\lambda$-constacyclic code of length $n$ and skew generator polynomial $g$. According to Theorem 1 of [8], the Euclidean dual $C^{\perp}$ of $C$ is a skew $\lambda^{-1}$-constacyclic code generated by $h^{\natural}$ where $g \cdot h=h \cdot g=x^{n}-\lambda$. If $q=r^{2}$, the Hermitian dual $C^{\perp_{H}}$ of $C$ is generated by $\overline{h^{\natural}}$ where for $a(x)=\sum a_{i} x^{i} \in R, \overline{a(x)}=\sum \overline{a_{i}} x^{i}$.

The two following lemma will be useful later.
Lemma 1. [5, Lemma 4] Consider hand g in R. Then $(h \cdot g)^{*}=\Theta^{\operatorname{deg}(h)}\left(g^{*}\right) \cdot h^{*}$, where $t=\operatorname{deg}(h)$ and $\Theta: R \mapsto R$ is given by $\Sigma_{i=0}^{k} a_{i} x^{i} \mapsto \sum_{i=0}^{k} \theta\left(a_{i}\right) x^{i}$.

Lemma 2 (Theorem 6.3 .7 of [10]). Consider $C_{1}$ and $C_{2}$ two skew $\lambda$-constacyclic code of length $n$ over $\mathbb{F}_{q}$ with skew generator polynomials $g_{1}$ and $g_{2}$, then:

1. $C_{1} \cap C_{2}$ is a skew $\lambda$-constacyclic code of length $n$ generated by $\operatorname{lclm}\left(g_{1}, g_{2}\right)$.
2. $C_{1}+C_{2}$ is a skew $\lambda$-constacyclic code of length $n$ generated by $\operatorname{gcrd}\left(g_{1}, g_{2}\right)$.

## 3 The equivalency between skew $\lambda$-constacyclic codes, skew cyclic codes and skew negacyclic codes

Let $q$ be a prime power, $\mathbb{F}_{q}$ a finite field and $\theta$ an automorphism of $\mathbb{F}_{q}$. Consider $\lambda$ in $\mathbb{F}_{q}^{*}$ which is fixed by $\theta$. We assume that $n$ is a multiple of the order of $\theta$. For $i$ in $\mathbb{N}^{*}$ and $\alpha$ element of $\mathbb{F}_{q}$ the $i^{\text {th }}$ norm is defined as

$$
N_{i}(\alpha)=\alpha \theta(\alpha) \cdots \theta^{i-1}(\alpha)
$$

In this section, we provide conditions on the existence of an isomorphism between skew $\lambda$ constacyclic codes, skew cyclic codes and skew negacyclic codes. We start with the following useful lemma.

Lemma 3. Consider an element $\alpha$ of $\mathbb{F}_{q}^{*}$. The application

$$
\begin{array}{rl}
\phi_{\alpha}: R & R \\
\quad f(x) \longmapsto f(\alpha x)
\end{array}
$$

is a morphism. Furthermore for all $i$ in $\mathbb{N}, \phi_{\alpha}\left(x^{i}\right)=N_{i}(\alpha) x^{i}$.
Theorem 1. - If $\mathbb{F}_{q}^{*}$ contains an element $\alpha$ where $\lambda=N_{n}\left(\alpha^{-1}\right)$ then the skew $\lambda$-constacyclic codes of length $n$ over $\mathbb{F}_{q}$ are equivalent to the skew cyclic codes of length $n$ over $\mathbb{F}_{q}$.

- If $\mathbb{F}_{q}^{*}$ contains an element $\alpha$ where $\lambda=-N_{n}\left(\alpha^{-1}\right)$ then the skew $\lambda$-constacyclic codes of length $n$ over $\mathbb{F}_{q}$ are equivalent to the skew negacyclic codes of length $n$ over $\mathbb{F}_{q}$.
Proof. Consider $\alpha$ in $\mathbb{F}_{q}^{*}$ such that $\lambda=N_{n}\left(\alpha^{-1}\right)$. Define

$$
\begin{aligned}
\Phi_{\alpha}: R /\left\langle x^{n}-1\right\rangle & \xrightarrow{\longrightarrow} R /\left\langle x^{n}-\lambda\right\rangle \\
f(x) & \longmapsto f(\alpha x)
\end{aligned}
$$

Let us prove that the application $\Phi_{\alpha}$ is an isomorphism who preserves the Hamming weight:

- The application $\Phi_{\alpha}$ is well-defined: consider $f(x)$ and $g(x)$ in $R$ such that $x^{n}-1$ divides on the right $f(x)-g(x)$. There exists $h$ in $R$ such that $f(x)-g(x)=h(x) \cdot\left(x^{n}-1\right)$. By Lemma 3 .
$f(\alpha x)-g(\alpha x)=\phi_{\alpha}(h(x)) \cdot \phi_{\alpha}\left(x^{n}-1\right)=\phi_{\alpha}(h(x)) \cdot\left(N_{n}(\alpha) x^{n}-1\right)=\phi_{\alpha}(h(x)) \cdot N_{n}(\alpha) \cdot\left(x^{n}-\lambda\right)$.
Therefore, $x^{n}-\lambda$ divides on the right $f(\alpha x)-g(\alpha x)$.
In the same way one can prove that the application is injective (and therefore surjective).
- The application $\Phi_{\alpha}$ is a morphism: consider $f(x)=\sum_{i=0}^{n-1} a_{i} x^{i}$ and $g(x)=\sum_{i=0}^{n-1} b_{i} x^{i}$ in $R /\left\langle x^{n}-\right.$ 1)
$f(x) \cdot g(x)=\sum_{j=0}^{n-1}\left(\sum_{i=0}^{j} a_{i} \theta^{i}\left(b_{j-i}\right)+\sum_{i=j+1}^{n-1} a_{i} \theta^{i}\left(b_{n-i+j}\right)\right) x^{j}$
because $x^{j+n}=x^{j}$ in $R /\left\langle x^{n}-1\right\rangle$.
As $\Phi_{\alpha}\left(x^{j}\right)=N_{j}(\alpha) x^{j}$, one gets
$\Phi_{\alpha}(f(x) \cdot g(x))=\sum_{j=0}^{n-1}\left(\sum_{i=0}^{j} a_{i} \theta^{i}\left(b_{j-i}\right)+\sum_{i=j+1}^{n-1} a_{i} \theta^{i}\left(b_{n-i+j}\right)\right) N_{j}(\alpha) x^{j}$
Furthermore,

$$
\begin{aligned}
& \Phi_{\alpha}(f(x)) \cdot \Phi_{\alpha}(g(x))= \\
& \sum_{j=0}^{n-1}\left(\sum_{i=0}^{j} a_{i} N_{i}(\alpha) \theta^{i}\left(b_{j-i} N_{j-i}(\alpha)\right)\right) x^{j}+\sum_{j=0}^{n-1}\left(\sum_{i=j+1}^{n-1} a_{i} N_{i}(\alpha) \theta^{i}\left(b_{n-i+j} N_{n+j-i}(\alpha)\right)\right) x^{j+n} \\
& \text { As } x^{j+n}=x^{j} \cdot\left(x^{n}-\lambda\right)+x^{j} \lambda=\theta^{j}(\lambda) x^{j} \text { in } R /\left\langle x^{n}-\lambda\right\rangle \\
& \Phi_{\alpha}(f(x)) \cdot \Phi_{\alpha}(g(x))= \\
& \sum_{j=0}^{n-1}\left(\sum_{i=0}^{j} a_{i} \theta^{i}\left(b_{j-i}\right) N_{i}(\alpha) \theta^{i}\left(N_{j-i}(\alpha)\right)+\sum_{i=j+1}^{n-1} a_{i} \theta^{i}\left(b_{n-i+j}\right) N_{i}(\alpha) \theta^{i}\left(N_{n+j-i}(\alpha)\right) \theta^{j}(\lambda)\right) x^{j}
\end{aligned}
$$

Furthermore $N_{i}(\alpha) \theta^{i}\left(N_{j-i}(\alpha)\right)=N_{j}(\alpha)$ and $N_{i}(\alpha) \theta^{i}\left(N_{n+j-i}(\alpha)\right) \theta^{j}(\lambda)=N_{j+n}(\alpha) /\left(\theta^{j}\left(N_{n}(\alpha)\right)\right)=$ $N_{j}(\alpha)$.
Therefore
$\Phi_{\alpha}(f(x)) \cdot \Phi_{\alpha}(g(x))=\sum_{j=0}^{n-1}\left(\sum_{i=0}^{j} a_{i} \theta^{i}\left(b_{j-i}\right)+\sum_{i=j+1}^{n-1} a_{i} \theta^{i}\left(b_{n-i+j}\right)\right) N_{j}(\alpha) x^{j}=\Phi_{\alpha}(f(x) \cdot g(x))$.

- $\Phi_{\alpha}$ preserves the Hamming weight:

Consider $c(x)=\sum_{i=0}^{n-1} a_{i} x^{i}$, then $\Phi_{\alpha}(c(x))=\sum_{i=0}^{n-1} a_{i} N_{i}(\alpha) x^{i}$.
$\forall i \in\{0, \ldots, n-1\}, a_{i} N_{i}(\alpha)=0 \Leftrightarrow a_{i}=0$ (because $\mathbb{F}_{q}$ integral domain), therefore $w t(c(x))=$ $w t\left(\Phi_{\alpha}(c(x))\right)$.

Example 1. For $\mathbb{F}_{2^{4}}=\mathbb{F}_{2}(w)$ where $w^{4}=w+1, \theta$ is the automorphism of $\mathbb{F}_{2^{4}}$ given by $a \mapsto a^{2^{2}}$ and $\mathbb{F}_{2^{4}}^{\theta}=\mathbb{F}_{4}=\left\{0,1, w^{5}, w^{10}\right\}$.

We have 33 skew cyclic codes of length 4 over $\mathbb{F}_{16}$, we give some of them:

$$
\begin{aligned}
x^{4}-1 & =\left(x^{2}+w^{13} x+w^{9}\right)\left(x^{2}+w^{13} x+w^{6}\right) \\
& =\left(x+w^{12}\right)\left(x^{3}+w^{3} x^{2}+x+w^{3}\right)
\end{aligned}
$$

All of the [4]-th roots of $w^{5}$ are $\left\{w^{2}, w^{5}, w^{8}, w^{11}, w^{14}\right\}$.
All of the [4]-th roots of $w^{10}$ are $\left\{w, w^{4}, w^{7}, w^{10}, w^{13}\right\}$.
The table 1 below gives examples of skew $w^{5}$-constacyclic codes of length 4 over $\mathbb{F}_{16}$ who are equivalent to the skew cyclic code $C=\left\langle x^{2}+w^{13} x+w^{6}\right\rangle$ of length 4 over $\mathbb{F}_{16}$.

The table 2 below gives examples of skew $w^{10}$-constacyclic codes of length 4 over $\mathbb{F}_{16}$ who are equivalent to the skew cyclic code $C=\left\langle x^{3}+w^{3} x^{2}+x+w^{3}\right\rangle$ of length 4 over $\mathbb{F}_{16}$.

In the following, we give a relationship between skew cyclic codes and skew negacyclic codes.

Corollary 1. If $q$ is odd and $n$ is an odd integer then the skew cyclic codes of length $n$ over $\mathbb{F}_{q}$ are equivalent to the skew negacyclic codes of length $n$ over $\mathbb{F}_{q}$.
Proof. Consider $\alpha$ in $\mathbb{F}_{q}^{*}$ such that $\lambda=N_{n}\left(\alpha^{-1}\right) \neq 1$. As $n$ is odd, $\lambda=-N_{n}\left(-\alpha^{-1}\right)$ and we conclude with Theorem 1 .

In the following example, we show that not all a skew cyclic codes of length $n$ over $\mathbb{F}_{q}$ are equivalent to a skew negacyclic code of length $n$ over $\mathbb{F}_{q}$, when $n$ is even.
Example 2. Let $\mathbb{F}_{9}=\mathbb{F}_{3}(w)$ where $w^{2}=w+1$, $\theta$ the Frobenius automorphism. Let the skew cyclic code $C=\left\langle x^{3}+x^{2}+x+1\right\rangle$ over $\mathbb{F}_{9}$ with parameter $[4,1,4]$. There is no skew negacyclic code of length 4 equivalent to $C$ (because there is no skew negacyclic code of length 4 with minimum distance 4).

In the following we give a case where the skew constacyclic codes are equivalent to the skew cyclic codes using only a relation between the length $n$, the characteristic of $\mathbb{F}_{q}$ and the cardinality of $\mathbb{F}_{q}$. We start with the following useful lemma.
Lemma 4. [2, Lemma 3.1] Let $\alpha$ be a primitive element of $\mathbb{F}_{q}$ and $\lambda=\alpha^{i}$ for $i \leqslant q-1$. Then the equation $x^{s}=\lambda$ has a solution in $\mathbb{F}_{q}$ if and only if $(s, q-1) \mid i$.

In the following, we give a similar result of [2, Theorem 3.4] but in the noncommutative case.
Proposition 1. Assume that $\theta$ is the automorphism defined by $a \mapsto a^{p^{r}}$ and that $([n], q-1)=1$ where $[n]:=\frac{p^{r n}-1}{p^{r}-1}$. Then all skew $\lambda$-constacyclic codes of length $n$ over $\mathbb{F}_{q}$ are equivalent to skew cyclic codes of length $n$ over $\mathbb{F}_{q}$.

Proof. Let $\lambda$ in $\mathbb{F}_{q}^{*}$ fixed by $\theta$ then there exist $i$ such that $\lambda=\alpha^{i}$. As $([n], q-1)=1 \mid i$, according to Lemma 4, there exist $\delta$ in $\mathbb{F}_{q}^{*}$ such that $\lambda=\delta^{[n]}$. Furthermore $N_{n}(\delta)=\delta^{[n]}$, therefore by Theorem 1 skew $\lambda$-constacyclic codes of length $n$ over $\mathbb{F}_{q}$ are equivalent to skew cyclic codes of length $n$ over $\mathbb{F}_{q}$.

When $\theta$ is the Frobenius and $\mathbb{F}_{q}=\mathbb{F}_{p^{n}}, \theta$-cyclic codes of length $n$ are equivalent to $\theta$-negacyclic codes of length $n$ :

Proposition 2. Assume that $\theta$ is the automorphism defined by $a \mapsto a^{p}$ and that $q=p^{n}$. Then all skew negacyclic codes of length $n$ over $\mathbb{F}_{q}$ are equivalent to skew cyclic codes of length $n$ over $\mathbb{F}_{q}$.

Proof. According to Theorem 1, it suffices to prove that the equation $N_{n}(\alpha)=-1$ has a solution in $\mathbb{F}_{q}^{*}$. Consider $a$ a primitive element of $\mathbb{F}_{q}$, then $-1=a^{\frac{p^{n}-1}{2}}$, furthermore $\left(\frac{p^{n}-1}{p-1}, p^{n}-1\right)=\frac{p^{n}-1}{p-1}$ divides $\frac{p^{n}-1}{2}$, therefore according to Lemma 4 the equation $N_{n}(\alpha)=\alpha^{\frac{p^{n}-1}{p-1}}=-1$ has a solution in $\mathbb{F}_{q}^{*}$.

The previous isometry of Theorem 1 does not preserve the duality as shown in the following example.
Example 3. Consider $R=\mathbb{F}_{9}[x ; \theta]$ where $\theta: u \mapsto u^{3}$ and $a \in \mathbb{F}_{9}$ such that $a^{2}=a+1$. The application

$$
\Phi_{a}:\left\{\begin{array}{cl}
R /<x^{2}-1> & \rightarrow R /<x^{2}+1> \\
x & \mapsto a x
\end{array}\right.
$$

is an isomorphism which preserves the Hamming distance according to Theorem 1 (because $-1=$ $\left.a^{4}=N_{2}(a)\right)$. However it does not preserve the duality. Namely, consider the skew cyclic code $C$ generated by $g=x+a^{2}$. As $\Phi_{a}(g)=a x+a^{2}=a(x+a)$, the image $D$ of $C$ by $\Phi_{a}$ is generated by $x+a$. Now we have $\left(x+a^{2}\right) \cdot\left(x+a^{2}\right)=x^{2}-1$, therefore the dual $C^{\perp}$ of $C$ is generated by $\left(x+a^{2}\right)^{\natural}=x+1 / a^{6}=x+a^{2}$ (and $C$ is self-dual). The image of $C^{\perp}$ by $\Phi_{a}$ is generated by $x+a$. Now, we have $\left(x+a^{7}\right) \cdot(x+a)=x^{2}+1$, therefore the dual $D^{\perp}$ of $D$ is generated by $\left(x+a^{7}\right)^{\natural}=x+a^{3}$. We obtain that $D^{\perp} \neq \Phi_{a}\left(C^{\perp}\right)$ (and $D=\Phi_{a}(C)$ is not self-dual whereas $C$ is self-dual).

Lemma 5. If $n$ is odd and $h \in R$ with degree $k$, then $\phi_{-1}\left(h^{*}\right)=(-1)^{k} \phi_{-1}(h)^{*}$.
Proof. Consider $h=\sum_{i=0}^{k} h_{i} X^{i}$ with degree $k$, then $h^{*}=\sum_{i=0}^{k} X^{k-i} \cdot h_{i}$. As $\phi_{\alpha}$ is a morphism, one gets

$$
\phi_{\alpha}\left(h^{*}\right)=\sum_{i=0}^{k} N_{k-i}(\alpha) X^{k-i} \cdot h_{i} .
$$

Now the skew reciprocal polynomial of $\phi_{\alpha}(h)=\sum_{i=0}^{k} h_{i} N_{i}(\alpha) X^{i}$ is equal to $\phi_{\alpha}(h)^{*}=\sum_{i=0}^{k} X^{k-i}$. $\left(h_{i} N_{i}(\alpha)\right)=\sum_{i=0}^{k} \theta^{k-i}\left(N_{i}(\alpha)\right) X^{k-i} \cdot h_{i}$ therefore

$$
\phi_{\alpha}(h)^{*}=N_{k}(\alpha) \sum_{i=0}^{k} 1 / N_{k-i}(\alpha) X^{k-i} \cdot h_{i}
$$

If $\alpha=-1$, then $N_{k-i}(\alpha)^{2}=1$, therefore $\phi_{\alpha}(h)^{*}=(-1)^{k} \phi_{\alpha}\left(h^{*}\right)$.
Proposition 3. If $n$ is odd and $C$ is a skew cyclic code of length $n$ then the dual of the skew negacyclic code $\Phi_{-1}(C)$ is $\Phi_{-1}(C)^{\perp}=\Phi_{-1}\left(C^{\perp}\right)$
Proof. As $n$ is odd, $N_{n}(-1)=-1$, therefore according to Theorem $1, \Phi_{-1}$ is well defined and is an isometry. Consider $C$ a skew cyclic code $[n, k]$ with generator skew polynomial $g$ and consider $h$ in $R$ such that $x^{n}-1=g \cdot h=h \cdot g$. Then the skew generator polynomial of $D=\Phi_{-1}(C)$ is generated by $G=(-1)^{r} \Phi_{-1}(g)$ where $r=\operatorname{deg}(g)=n-k$. Furthermore $G \cdot H=H \cdot G=x^{n}+1$ where $H=(-1)^{r+1} \Phi_{-1}(h)$. The dual $D^{\perp}$ of $D$ is generated by $H^{*}$ and the conclusion follows from Lemma 5 .

In what follows, we will study LCD skew cyclic and skew negacyclic codes. We will mostly concentrate on the case when the length of the code is even and the automorphism $\theta$ has order 2 .

## 4 Skew generator polynomials of LCD skew cyclic and negacyclic codes

Like previously, we assume that $\mathbb{F}_{q}$ is a finite field, $\theta$ is an automorphism of $\mathbb{F}_{q}$ of order $\mu$ and $n$ is a multiple of $\mu$. In the following, we give a necessary and sufficient condition for skew $\lambda$-constacyclic codes to be LCD codes, when $\lambda^{2}=1$.

Theorem 2. Consider $\mathbb{F}_{q}$ a finite field, $\theta$ an automorphism of $\mathbb{F}_{q}$ of order $\mu, R=\mathbb{F}_{q}[x ; \theta]$, $n$ a multiple of $\mu$ and $\lambda \in\{-1,1\}$. Consider a $(\theta, \lambda)$-constacyclic code $C$ with length $n$, skew generator polynomial $g$. Consider $h$ such that $h \cdot g=g \cdot h=x^{n}-\lambda$.

1. $C$ is an Euclidean LCD code if and only if $\operatorname{gcrd}\left(g, h^{\natural}\right)=1$.
2. If $q$ is an even power of a prime number, $q=r^{2}, C$ is an Hermitian $L C D$ code if and only if $\operatorname{gcrd}\left(g, \overline{h^{\natural}}\right)=1$.

Proof. As $C$ and $C^{\perp}$ are two skew $\lambda$-constacyclic codes of length $n$ and skew generator polynomials $g$ and $h^{\natural}$, according to Lemma 2 the skew polynomial $f=\operatorname{lc} \operatorname{lm}\left(g, h^{\natural}\right)$ is the skew generator polynomial of the skew constacyclic code $C \cap C^{\perp}$. In particular, as $g$ and $h^{\natural}$ both divide $x^{n}-\lambda, f$ divides $x^{n}-\lambda$. Assume that $C \cap C^{\perp}=\{0\}$, then $x^{n}-\lambda$ divides $f$, therefore $x^{n}-\lambda=f$. According to [22], $\operatorname{deg}\left(\operatorname{gcrd}\left(g, h^{\natural}\right)\right)+\operatorname{deg}\left(\operatorname{lclm}\left(g, h^{\natural}\right)\right)=\operatorname{deg}(g)+\operatorname{deg}\left(h^{\natural}\right)$, therefore $\operatorname{deg}\left(\operatorname{gcrd}\left(g, h^{\natural}\right)\right)=\operatorname{deg}(g)+\operatorname{deg}(h)-\operatorname{deg}(f)=0$ and $\operatorname{gcrd}\left(g, h^{\natural}\right)=1$.

Conversely, if $\operatorname{gcrd}\left(g, h^{\natural}\right)=1$, then $\operatorname{deg}(f)=n$, therefore, as $f$ divides $x^{n}-\lambda, f=x^{n}-\lambda$, and $C \cap C^{\perp}=\{0\}$. The same proof holds for Hermitian LCD codes.

Example 4. Consider $\mathbb{F}_{9}=\mathbb{F}_{3}(w)$ where $w^{2}=w+1$ and $\theta$ the Frobenius automorphism $\theta: a \mapsto$ $a^{3}$. One has :

$$
x^{4}+1=\left(x^{2}+w^{3} x+1\right) \cdot\left(x^{2}+w^{7} x+1\right)
$$

The skew reciprocal polynomial of $x^{2}+w^{3} x+1$ is $x^{2}+w x+1$ and $\operatorname{gcrd}\left(x^{2}+w^{7} x+1, x^{2}+w x+1\right)=1$.
Then by Theorem 2 the skew negacyclic code $C=\left\langle x^{2}+w^{7} x+1\right\rangle$ of length 4 and minimum distance 3 over $\mathbb{F}_{9}$ is an Euclidean LCD code.

Example 5. For $\mathbb{F}_{9}=\mathbb{F}_{3}(w)$ where $w^{2}=w+1$ and $\theta$ the Frobenius automorphism $\theta: a \mapsto a^{3}$, one has:

$$
x^{6}-1=\left(x^{3}+w x^{2}+x+1\right) \cdot\left(x^{3}+w^{7} x^{2}+x+2\right)
$$

The skew reciprocal polynomial of $x^{3}+w x^{2}+x+1$ is $x^{3}+x^{2}+w^{3} x+1$ and $\operatorname{gcrd}\left(x^{3}+w^{7} x^{2}+\right.$ $\left.x+2, x^{3}+x^{2}+w x+1\right)=1$.

Then by Theorem 2 the skew cyclic code $C=\left\langle x^{3}+w^{7} x^{2}+x+2\right\rangle$ of length 6 and minimum distance 4 over $\mathbb{F}_{9}$ is an Hermitian LCD code.

Over a finite field $\mathbb{F}_{q}$, if a cyclic code $C$ generated by a monic polynomial $g$ is an Euclidean LCD code then $g=g^{\natural}$. Furthermore if $q$ is coprime with $n$, then $g=g^{\natural}$ if and only if $C$ is an Euclidean LCD code ([17], [19]). This comes from the fact that when $q$ is coprime with $n$ then $x^{n}-1=g h=\operatorname{ppcm}(g, h)$ is squarefree therefore, if $g=g^{\natural}$, then $g$ and $h=h^{\natural}$ are coprime.

The following proposition generalizes this result. We use the notion of similarity (definition 1).
Definition 1 ([22]). Consider $a, b$ in $R$. $a$ is similar to $b$ if there exists $u$ in $R$ such that $\operatorname{lclm}(a, u)=b \cdot u$ and $\operatorname{gcrd}(a, u)=1$.
Remark 1. If $\theta$ is the identity then $a$ is similar to $b$ if and only if $a$ is equal to $b$ up to a multiple constant.

Proposition 4. Consider $\mathbb{F}_{q}$ a finite field, $\theta$ an automorphism of $\mathbb{F}_{q}$ of order $\mu, R=\mathbb{F}_{q}[x ; \theta]$, n a multiple of $\mu$ and $\lambda \in\{-1,1\}$. Consider $a(\theta, \lambda)$-constacyclic code $C$ with dimension $k$, length $n$, skew generator polynomial $g$. Consider $G=\Theta^{k}\left(g^{*} \cdot \frac{1}{g_{0}}\right)=g_{0} \cdot \Theta^{k}\left(g^{\natural} \cdot \frac{1}{g_{0}}\right)$ where $g_{0}$ is the constant coefficient of $g$ and $h$ in $R$ such that $g \cdot h=h \cdot g=x^{n}-\lambda$.

1. If $C$ is an Euclidean (resp. Hermitian) LCD code then $g$ is similar to $G$ (resp. $\Theta(G)$ ).
2. Assume that $\operatorname{lclm}(g, h)=x^{n}-1$. If $g=G$ (resp. $g=\Theta(G)$ ) then $C$ is an Euclidean (resp. Hermitian) LCD code.

Proof. As $h \cdot g=x^{n}-\lambda$, according to Lemma 1 , $x^{n}-\lambda=g_{0} \cdot \Theta^{k}\left(g^{\natural} \cdot \frac{1}{g_{0}}\right) \cdot h^{\natural}=G \cdot h^{\natural}$. Therefore, as $g$ and $h^{\natural}$ divide on the right $x^{n}-\lambda, \operatorname{lclm}\left(g, h^{\natural}\right)$ divides $x^{n}-\lambda$ on the right.

1. Assume that $\operatorname{gcrd}\left(g, h^{\natural}\right)=1$, then $\operatorname{deg}\left(\operatorname{lclm}\left(g, h^{\natural}\right)\right)=\operatorname{deg}(g)+\operatorname{deg}\left(h^{\natural}\right)=n$, therefore, one has $\operatorname{lclm}\left(g, h^{\natural}\right)=x^{n}-\lambda=G \cdot h^{\natural}$, and $\operatorname{lclm}\left(g, h^{\natural}\right)=G \cdot h^{\natural}$ with $\operatorname{gcrd}\left(g, h^{\natural}\right)=1$. One can conclude that $g$ is similar to $G$.
2. Assume that $g=G$. As $x^{n}-\lambda=g \cdot h=G \cdot h^{\natural}$, one gets $h=h^{\natural}$. As $\operatorname{lclm}(g, h)=x^{n}-1$, one deduces that $\operatorname{gcrd}\left(g, h^{\natural}\right)=\operatorname{gcrd}(g, h)=1$, therefore $C$ is an Euclidean LCD code.

Example 6. In Example 4 one has $g=x^{2}+w^{7} x+1$ and $G=\Theta^{2}\left(1 \cdot g^{*} \cdot \frac{1}{1}\right)=x^{2}+w^{3} x+1$, therefore $\operatorname{lclm}\left(g, w^{2}\right)=G \cdot w^{2}=w^{2} \cdot g$ and $g$ is similar to $G$.

Example 7. In Example 5, one has $g=x^{3}+w^{7} x^{2}+x+2$ and $G=\Theta^{3}\left(g^{*}\right)=x^{3}-x^{2}+w^{3} x-1$. As $\operatorname{lclm}\left(g, x^{2}-x+w^{7}\right)=\Theta(G) \cdot\left(x^{2}-x+w^{7}\right)=x^{5}+x^{4}+x^{3}+w x^{2}+w^{5} x+w^{3}$ and $\operatorname{gcrd}\left(g, x^{2}-x+w^{7}\right)=1$, $g$ is similar to $\Theta(G)$.

If $\theta$ is the identity, then $G=g_{0} g^{\natural} \frac{1}{g_{0}}=g^{\natural}$ and following Remark 1 , one gets the already known result recalled above the proposition : if $C$ is an Euclidean LCD code then $g=G=g^{\natural}$. If $g$ and $h$ are coprime and $g=G=g^{\natural}$ then $C$ is an Euclidean LCD code.

If $\theta$ is not the identity, as seen in the previous example, Euclidean LCD $(\theta, \lambda)$-constacyclic codes do not necessarily satisfy the equality $g=G$. Furthermore, when $\operatorname{lc} \operatorname{lm}(g, h)=x^{n}-1, g$ being similar to $G$ does not imply necessarily the code to be a LCD code :

Example 8. Consider $R=\mathbb{F}_{4}[x ; \theta]$ where $\mathbb{F}_{4}=\mathbb{F}_{2}(w), g=x^{2}+w^{2} x+w$ and $h=x^{2}+w^{2} w+w^{2}$. One has $g \cdot h=h \cdot g=\operatorname{lclm}(g, h)=x^{4}-1$ and $G=w\left(x^{2}+x+w^{2}\right) \cdot \frac{1}{w}=x^{2}+w^{2} x+w^{2}$. The $\theta$-cyclic code of length 4 generated by $g$ is not an Euclidean LCD code because $\operatorname{gcrd}\left(g, h^{\natural}\right)=g \neq 1$, however $g$ and $G$ are similar because $\operatorname{lclm}(g, x+w)=x^{3}+x^{2}+x+1=G \cdot(x+w)$ and $\operatorname{gcrd}(g, x+w)=1$.

We are now going to characterize the skew generators of LCD skew cyclic and negacyclic codes as least common left multiples of skew polynomials. This will enable to give a construction and an enumeration of LCD skew cyclic and negacyclic codes over $\mathbb{F}_{p^{2}}$ (section 5). Let us introduce a first notation. We recall that the fixed field of $\theta$ is $\mathbb{F}_{q}^{\theta}$ and we denote $\mu$ the order of $\theta$. For $F\left(x^{\mu}\right) \in \mathbb{F}_{q}^{\theta}\left[x^{\mu}\right]$ and $b$ in $\{0,1\}$, consider the following set :

$$
\mathcal{L}_{F\left(x^{\mu}\right)}^{(b)}:=\left\{g \in R \mid g \text { monic, } g \cdot h=F\left(x^{\mu}\right) \text { and } \operatorname{gcrd}\left(\Theta^{b}\left(h^{\natural}\right), g\right)=1\right\} .
$$

The following proposition is inspired from Proposition 28 of [5] and Proposition 2 of [3. It will enable to construct and enumerate LCD skew cyclic and negacyclic codes over $\mathbb{F}_{p^{2}}$.
Proposition 5. Consider $\mathbb{F}_{q}$ a finite field, $\theta$ an automorphism of $\mathbb{F}_{q}$ of order $\mu, R=\mathbb{F}_{q}[x ; \theta]$. Consider $F\left(x^{\mu}\right)=f_{1}\left(x^{\mu}\right) \cdots f_{r}\left(x^{\mu}\right)$ where $f_{1}\left(x^{\mu}\right), \ldots, f_{r}\left(x^{\mu}\right)$ are polynomials of $\mathbb{F}_{q}^{\theta}\left[x^{\mu}\right]$ such that $f_{i}$ is coprime with $f_{j}$ and $f_{j}^{\natural}$ for all $i \neq j$. The application

$$
\phi:\left\{\begin{array}{cll}
\mathcal{L}_{f_{1}\left(x^{\mu}\right)}^{(b)} \times \cdots \times \mathcal{L}_{f_{r}\left(x^{\mu}\right)}^{(b)} & \rightarrow & \mathcal{L}_{F\left(x^{\mu}\right)}^{(b)} \\
\left(g_{1}, \ldots, g_{r}\right) & \mapsto & \operatorname{lclm}\left(g_{1}, \ldots, g_{r}\right)
\end{array}\right.
$$

is bijective.
Proof. - The application $\phi$ is well-defined.
Consider $\left(g_{1}, \ldots, g_{r}\right)$ in $\mathcal{L}_{f_{1}\left(x^{\mu}\right)}^{(b)} \times \cdots \times \mathcal{L}_{f_{r}\left(x^{\mu}\right)}^{(b)}$ and $g=\operatorname{lclm}\left(g_{1}, \ldots, g_{r}\right)$. Consider $h_{1}, \ldots, h_{r}$ such that $g_{i} \cdot h_{i}=h_{i} \cdot g_{i}=f_{i}\left(x^{\mu}\right)$ and $\operatorname{gcrd}\left(g_{i}, \Theta^{b}\left(h_{i}^{\natural}\right)\right)=1$. Consider $h=\operatorname{lcrm}\left(h_{1}, \ldots, h_{r}\right)$. Let us prove that $g \cdot h=F\left(x^{\mu}\right)$ and that $\operatorname{gcrd}\left(g, h^{\natural}\right)=1$.

First of all, as $h_{1}, \ldots, h_{r}$ divide respectively $f_{1}\left(x^{\mu}\right), \ldots, f_{r}\left(x^{\mu}\right)$, and as $f_{1}\left(x^{\mu}\right), \ldots, f_{r}\left(x^{\mu}\right)$ are pairwise coprime central polynomials, the degree of $h=\operatorname{lcrm}\left(h_{1}, \ldots, h_{r}\right)$ is equal to $\sum_{i=1}^{r} \operatorname{deg}\left(h_{i}\right)$. In the same way, the degree of $g=\operatorname{lclm}\left(g_{1}, \ldots, g_{r}\right)$ is equal to $\sum_{i=1}^{r} \operatorname{deg}\left(g_{i}\right)$. Furthermore, as $g_{i} \cdot h_{i}=f_{i}\left(x^{\mu}\right)$, the degree of $g_{i} \cdot h_{i}$ is equal to the degree of $f_{i}\left(x^{\mu}\right)$ in $x$, therefore the degree of $g \cdot h$ is equal to the degree of $F\left(x^{\mu}\right)$ in $x$.
Consider, for $i$ in $\{1, \ldots, r\}, A_{i}$ in $R$ such that $g=A_{i} \cdot g_{i}$ and $B_{i}$ in $R$ such that $h=h_{i} \cdot B_{i}$. One gets $g \cdot h=A_{i} \cdot g_{i} \cdot h_{i} \cdot B_{i}=A_{i} \cdot f_{i}\left(x^{\mu}\right) \cdot B_{i}$. As $f_{i}\left(x^{\mu}\right)$ is central, it divides $g \cdot h$. The polynomials $f_{i}\left(x^{\mu}\right)$ are pairwise coprime in $\mathbb{F}_{q}^{\theta}\left[x^{\mu}\right]$, therefore their least common right multiple is equal to their product $F\left(x^{\mu}\right)$, and $F\left(x^{\mu}\right)$ divides $g \cdot h$. As $\operatorname{deg}(g \cdot h)=\operatorname{deg}\left(F\left(x^{\mu}\right)\right)$, one gets $g \cdot h=F\left(x^{\mu}\right)$. Now $\operatorname{gcrd}\left(g, \Theta^{b}\left(h^{\natural}\right)\right)=\operatorname{gcrd}\left(\operatorname{lclm}\left(g_{1}, \ldots, g_{r}\right), \operatorname{lclm}\left(\Theta^{b}\left(h_{1}^{\natural}\right), \ldots, \Theta^{b}\left(h_{r}^{\natural}\right)\right)\right)$. One can notice that the skew polynomials $g_{i}$ and $\Theta^{b}\left(h_{j}^{\natural}\right)$ are right coprime. Namely, if $i=j$, $\operatorname{gcrd}\left(g_{i}, \Theta^{b}\left(h_{i}^{\natural}\right)\right)=1$ by hypothesis. If $i \neq j$ consider a right divisor $u$ of $g_{i}$ and $\Theta^{b}\left(h_{j}^{\natural}\right)$, then $u$ divides $f_{i}\left(x^{\mu}\right)$ and $f_{j}^{\natural}\left(x^{\mu}\right)$, as $f_{i}\left(x^{\mu}\right)$ and $f_{j}^{\natural}\left(x^{\mu}\right)$ are coprime one gets that $u=1$. One deduces that $\operatorname{gcrd}\left(g, \Theta^{b}\left(h^{\natural}\right)\right)=1$. To conclude, the skew polynomial $g$ belongs to $\mathcal{L}_{F\left(x^{\mu}\right)}^{(b)}$ therefore $\phi$ is well defined.

- The application $\phi$ is bijective.

Consider $g$ in $\mathcal{L}_{F\left(x^{\mu}\right)}^{(b)}$, then $g$ divides $F\left(x^{\mu}\right)$, therefore, according to Theorem 4.1 of [11], $g=\operatorname{lclm}\left(g_{1}, \ldots, g_{r}\right)$ where $g_{i}=\operatorname{gcrd}\left(f_{i}\left(x^{\mu}\right), g\right)$ and this lclm-decomposition into skew polynomials dividing $f_{1}\left(x^{\mu}\right), \ldots, f_{r}\left(x^{\mu}\right)$ is unique. Furthermore $\operatorname{deg}(g)=\sum_{i=1}^{r} \operatorname{deg}\left(g_{i}\right)$ because $f_{i}\left(x^{\mu}\right)$ and $f_{j}\left(x^{\mu}\right)$ are coprime. Let us prove that $g_{i}$ belongs to $\mathcal{L}_{f_{i}\left(x^{\mu}\right)}^{(b)}$. Consider $h$ in $R$ such that $g \cdot h=h \cdot g=F\left(x^{\mu}\right)$ and $\operatorname{gcrd}\left(g, \Theta^{b}\left(h^{\natural}\right)\right)=1$. As $h$ divides $F\left(x^{\mu}\right)$, according to Theorem 4.1 of [11], $h=\operatorname{lcrm}\left(h_{1}, \ldots, h_{r}\right)$ where $h_{i}=\operatorname{gcld}\left(f_{i}\left(x^{\mu}\right), h\right)$. This lcrm-decomposition into skew polynomials dividing $f_{1}\left(x^{\mu}\right), \ldots, f_{r}\left(x^{\mu}\right)$ is unique and $\operatorname{deg}(h)=\sum_{i=1}^{r} \operatorname{deg}\left(h_{i}\right)$.
Consider, for $i$ in $\{1, \ldots, r\}, A_{i}$ in $R$ such that $g=A_{i} \cdot g_{i}$ and $B_{i}$ in $R$ such that $h=h_{i} \cdot B_{i}$. As $g \cdot h=F\left(x^{\mu}\right)$ and as $F\left(x^{\mu}\right)$ is central, the skew polynomial $g_{i} \cdot h_{i}$ divides $F\left(x^{\mu}\right)$ on the right. Therefore, $g_{i} \cdot h_{i}=\operatorname{lclm}\left(\operatorname{gcrd}\left(g_{i} \cdot h_{i}, f_{j}\left(x^{\mu}\right)\right), j=1, \ldots, r\right)=\operatorname{gcrd}\left(g_{i} \cdot h_{i}, f_{i}\left(x^{\mu}\right)\right)$ divides $f_{i}\left(x^{\mu}\right)$. As $\sum_{i=1}^{r} \operatorname{deg}\left(g_{i} \cdot h_{i}\right)=\operatorname{deg}(g)+\operatorname{deg}(h)=\operatorname{deg}\left(F\left(x^{\mu}\right)\right)=\sum_{i=1}^{r} \operatorname{deg}\left(f_{i}\left(x^{\mu}\right)\right)$, one gets $g_{i} \cdot h_{i}=f_{i}\left(x^{\mu}\right)$. Lastly, consider $u$ in $R$ such that $u$ divides on the right $g_{i}$ and $\Theta^{b}\left(h_{i}^{\natural}\right)$. As $h_{i}$ divides on the left $h, \Theta^{b}\left(h_{i}^{\natural}\right)$ divides on the right $\Theta^{b}\left(h^{\natural}\right)$, therefore $u$ divides on the right both $g$ and $\Theta^{b}\left(h^{\natural}\right)$, and $u=1$.

We now introduce some notations that will be useful later :

& \mathcal{F}_{\text {ir }}:=\left\{f=f\left(x^{\mu}\right) \in \mathbb{F}_{q}^{\theta}\left[x^{\mu}\right] \mid f=f^{\natural} \text { irreducible in } \mathbb{F}_{q}^{\theta}\left[x^{\mu}\right], \operatorname{deg}_{x^{\mu}} f>1\right\} \\
& \mathcal{F}_{\text {red }}:=\left\{f=f\left(x^{\mu}\right) \in \mathbb{F}_{q}^{\theta}\left[x^{\mu}\right] \mid f=f_{\text {ir }} f_{i r}^{\natural}, f_{\text {ir }} \neq f_{i r}^{\natural} \text { irreducible in } \mathbb{F}_{q}^{\theta}\left[x^{\mu}\right]\right\} .
\end{aligned}
$$

Theorem 3. Consider $\mathbb{F}_{q}$ a finite field with $q$ elements, $\theta$ an automorphism over $\mathbb{F}_{q}$ with order $\mu$, $R=\mathbb{F}_{q}[x ; \theta], \lambda \in\{-1,1\}, b \in\{0,1\}$. Consider $n$ a multiple of $\mu$ and $x^{n}-\lambda=f_{1}\left(x^{\mu}\right)^{p^{s}} \cdots f_{r}\left(x^{\mu}\right)^{p^{s}}$ where $f_{1}\left(x^{\mu}\right), \ldots, f_{r}\left(x^{\mu}\right)$ are polynomials of $\mathbb{F}_{p}\left[x^{\mu}\right]$ belonging to $\left\{x^{\mu} \pm 1\right\} \cup \mathcal{F}_{i r} \cup \mathcal{F}_{\text {red }}$. Consider $a(\theta, \lambda)$-constacyclic code $C$ of length $n$ and skew generator polynomial $g$.

1. $C$ is an Euclidean $L C D$ code if and only if $g=\operatorname{lclm}\left(g_{1}, \ldots, g_{r}\right)$ where for all $i$ in $\{1, \ldots, r\}$, $g_{i} \in \mathcal{L}_{f_{i}\left(x^{\mu}\right)^{p^{s}}}^{(0)}$.
2. $C$ is an Hermitian $L C D$ code if and only if $g=\operatorname{lclm}\left(g_{1}, \ldots, g_{r}\right)$ where for all $i$ in $\{1, \ldots, r\}$, $g_{i} \in \mathcal{L}_{f_{i}\left(x^{\mu}\right)^{p^{s}}}^{(1)}$.

Proof. According to Theorem 2, the Euclidean (resp. Hermitian) LCD $\theta$-cyclic codes of length $n$ are generated by the elements of the set $\mathcal{L}_{x^{n}-1}^{(b)}$ where $b=0$ (resp. $b=1$ ). The Euclidean (resp. Hermitian) LCD $\theta$-negacyclic codes of length $n$ are associated to the set $\mathcal{L}_{x^{n}+1}^{(b)}$ where $b=0$ (resp. $b=1)$. As $x^{n} \pm 1$ is self-reciprocal, one has $x^{n} \pm 1=f_{1}\left(x^{\mu}\right)^{p^{s}} \cdots f_{r}\left(x^{\mu}\right)^{p^{s}}$ where $f_{1}\left(x^{\mu}\right), \ldots, f_{r}\left(x^{\mu}\right)$ are self-reciprocal polynomials of $\mathbb{F}_{p}\left[x^{\mu}\right]$ who are either irreducible or products of an irreducible polynomial and its reciprocal polynomial. Therefore for $i \neq j, f_{i}$ is coprime with $f_{j}$ and $f_{j}^{\natural}$ and Theorem 5 can be applied to $F\left(x^{\mu}\right)=x^{n} \pm 1$.

Remark 2. The Euclidean LCD skew cyclic (resp. negacyclic) codes of length $n$ over $\mathbb{F}_{q}$ are the skew cyclic (resp. negacyclic) codes $C=\bigcap_{i=1}^{r} C_{i}$ where $C_{i}$ is a skew cyclic (resp. negacyclic) code generated by $g_{i} \in \mathcal{L}_{f_{i}\left(x^{\mu}\right)^{p^{s}}}^{(0)}$ and where the polynomial $F\left(x^{\mu}\right)=x^{n}-1$ (resp. $x^{n}+1$ ) factorizes in $\mathbb{F}_{q}^{\theta}\left[x^{\mu}\right]$ as $F\left(x^{\mu}\right)=\prod_{i=1}^{r} f_{i}\left(x^{\mu}\right)^{p^{s}}, f_{i}\left(x^{\mu}\right) \in \mathcal{F}_{i r} \bigcup \mathcal{F}_{\text {red }} \bigcup\left\{x^{\mu} \pm 1\right\}$. The same remark holds for Hermitian LCD skew cyclic and negacyclic codes where $g_{i} \in \mathcal{L}_{f_{i}\left(x^{\mu}\right)^{p^{s}}}^{(1)}$ instead of $g_{i} \in \mathcal{L}_{f_{i}\left(x^{\mu}\right)^{p^{s}}}^{(1)}$.

## 5 LCD skew cyclic and negacyclic codes over $\mathbb{F}_{p^{2}}$

In this section, we construct and enumerate LCD skew cyclic and negacyclic codes in the particular case when $q=p^{2}$ is the square of a prime number $p$ and $\theta: a \mapsto a^{p}$ is the Frobenius automorphism over $\mathbb{F}_{q}$. Therefore the order $\mu$ of $\theta$ is equal to 2 and the fixed field $\mathbb{F}_{q}^{\theta}$ of $\theta$ is $\mathbb{F}_{p}$. We will use the characterization of LCD skew cyclic and negacyclic given by Theorem 3. This point of view is useful for the construction and the enumeration of the codes (Propositions 7, 8, 9).

According to Theorem 3, LCD $\theta$-cyclic and $\theta$-negacyclic codes of even length $n$ over $\mathbb{F}_{p^{2}}$ are generated by skew polynomials which are least common left multiples of skew polynomials $g_{i} \in$ $\mathcal{L}_{f_{i}\left(x^{2}\right)^{p}}^{(b)}$ where $f=f_{i} \in \mathcal{D}_{x^{n} \pm 1}$ is a divisor of $x^{n} \pm 1$ in $\mathbb{F}_{p}\left[x^{2}\right]$ satisfying one of the following cases

- $f\left(x^{2}\right)=x^{2}-\epsilon$ where $\epsilon= \pm 1$ (see Lemma 6)
- $f\left(x^{2}\right) \in \mathcal{F}_{\text {ir }}$ irreducible in $\mathbb{F}_{p}\left[x^{2}\right]$ with degree $d>1$ in $x^{2}$ (see Lemma 6);
- $f\left(x^{2}\right) \in \mathcal{F}_{\text {red }}$ is the product of two irreducible distinct polynomials in $\mathbb{F}_{p}\left[x^{2}\right]$ (see Lemma 7 ).

The following proposition enables to characterize those skew polynomials having a unique factorization into the product of monic irreducible skew polynomials. It will be useful later.

Proposition 6 (Proposition 16 of [5]). Consider p a prime number, $\theta: a \mapsto a^{p}$ the Frobenius automorphism over $\mathbb{F}_{q}$ with $q=p^{2}, R=\mathbb{F}_{q}[x ; \theta], f \in \mathbb{F}_{p}\left[x^{2}\right]$ irreducible in $\mathbb{F}_{p}\left[x^{2}\right]$ and $h=h_{m} \cdots h_{1}$ a product of irreducible monic polynomials dividing $f$. The following assertions are equivalent
(i) $h$ has a unique factorization into irreducible monic polynomials;
(ii) $f$ does not divide $h$ in $R$;
(iii) for all $i$ in $\{1, \ldots, m-1\}, f \neq h_{i+1} \cdot h_{i}$.

### 5.1 Length $2 p^{s}$ over $\mathbb{F}_{p^{2}}$

Lemma 6 describes the set $\mathcal{L}_{f\left(x^{2}\right)^{m}}^{(b)}$ where $f\left(x^{2}\right) \in \mathcal{F}_{i r} \bigcup\left\{x^{2} \pm 1\right\}$. It will be useful to characterize all nontrivial LCD skew cyclic and negacyclic codes of length $2 p^{s}$ over $\mathbb{F}_{p^{2}}$ (Proposition 7 and algorithm 1).

Lemma 6. Consider $p$ a prime number, $\theta: a \mapsto a^{p}$ the Frobenius automorphism over $\mathbb{F}_{q}$ with $q=p^{2}, R=\mathbb{F}_{q}[x ; \theta], f\left(x^{2}\right) \in \mathcal{F}_{i r} \bigcup\left\{x^{2} \pm 1\right\}$ with degree $d$ in $x^{2}, g$ in $R$ and $m \in \mathbb{N}$. The skew polynomial $g$ belongs to the set $\mathcal{L}_{f\left(x^{2}\right)^{m}}^{(b)}$ if, and only if, $g=1$ or $g=f\left(x^{2}\right)^{m}$ or $g$ has a unique factorization into the product of $m$ monic irreducible skew polynomials $g=g_{m} \cdots g_{1}$ where

\left\{\begin{array}{l}
\forall i \in\{1, \ldots, m\}, \operatorname{deg}\left(g_{i}\right)=d  \tag{1}\\
g_{i} \text { divides on the right } f\left(x^{2}\right) \\
\forall i \in\{1, \ldots, m-1\}, g_{i+1} \cdot g_{i} \neq f\left(x^{2}\right) \\
g_{1} \neq \Theta^{b}\left(h_{1}^{\natural}\right) \text { where } \Theta^{b}\left(h_{1}^{\natural}\right) \cdot h_{1}=f\left(x^{2}\right) .
\end{array}\right.
$$

Proof. Consider $g$ in $\mathcal{L}_{f\left(x^{2}\right)^{m}}^{(b)} \backslash\left\{f\left(x^{2}\right)^{m}, 1\right\}$. Consider $h$ in $R$ such that $g \cdot h=h \cdot g=f\left(x^{2}\right)^{m}$. As $f\left(x^{2}\right)$ is central and irreducible in $\mathbb{F}_{p}\left[x^{2}\right]$, the skew polynomials $g$ and $h$ are products of irreducible monic factors dividing $f\left(x^{2}\right)$. As $\operatorname{deg}(g)>2 d m$ and $\operatorname{deg}(h)+\operatorname{deg}(g)=2 d m$, there exists $r \in\{1, \ldots, 2 m-1\}, g_{1}, \ldots, g_{2 m-r}, h_{1}, \ldots, h_{r}$ monic of degree $d$ dividing $f\left(x^{2}\right)$ such that

g=g_{2 m-r} \cdots g_{1}
$$

and

$$
h=h_{1} \cdots h_{r}
$$

The skew polynomial $\Theta^{b}\left(h_{1}^{\natural}\right)$ is an irreducible right factor of $\Theta^{b}\left(h^{\natural}\right)$ which divides $\Theta^{b}\left(f^{\natural}\left(x^{2}\right)\right)=$ $f\left(x^{2}\right)$ and does not divide $g$ on the right because $\operatorname{gcrd}\left(\Theta^{b}\left(h^{\natural}\right), g\right)=1$. Therefore $f\left(x^{2}\right)$ does not divide $g$. Similarly, one gets that $f\left(x^{2}\right)$ does not divide $\Theta^{b}\left(h^{\natural}\right)$ and $h$. Therefore, according to Proposition 6, the above factorizations of $g$ and $h$ into the products of monic irreducible factors are unique and for all $i$ in $\{1, \ldots, m-1\}, g_{i+1} \cdot g_{i} \neq f\left(x^{2}\right)$.
As $g \cdot h=h \cdot g=f\left(x^{2}\right)^{m}$ one gets that for all $i, g_{i} \cdot h_{i}=f\left(x^{2}\right)$, therefore, $r=m$.
Laslty, as $g$ and $\Theta^{b}\left(h^{\natural}\right)$ are right coprime, necessarily, $g_{1} \neq \Theta^{b}\left(h_{1}^{\natural}\right)$.
Conversely, consider $g=g_{m} \cdots g_{1}$ where $g_{1}, \ldots, g_{m}$ are monic skew polynomials satisfying (1). Consider $h=h_{1} \cdots h_{m}$ with $g_{i} \cdot h_{i}=h_{i} \cdot g_{i}=f\left(x^{2}\right)$ then $g \cdot h=h \cdot g=f\left(x^{2}\right)^{m}$. Furthermore as $g_{i+1} \cdot g_{i} \neq f\left(x^{2}\right)$, according to Proposition 6 the above factorization of $g$ into the product of monic irreducible factors is unique. Similarly, the factorizations of $h$ and $\Theta^{b}\left(h^{\natural}\right)$ into the products of monic irreducible factors are unique.
Consider $u$ a right factor of $g$ and $\Theta^{b}\left(h^{\natural}\right)$ with degree $>1$. Necessarily, $u$ has a unique factorization into the product of monic skew polynomials. The unique monic linear right factor of $u$ is also the unique monic right factor of $g$ and $\Theta^{b}\left(h^{\natural}\right)$, therefore $u=g_{1}=\Theta^{b}\left(h_{1}^{\natural}\right)$, which is impossible according to $\sqrt{11}$. Therefore $\operatorname{gcrd}\left(g, \Theta^{b}\left(h^{\natural}\right)\right)=1$ and $g$ belong to $\mathcal{L}_{f\left(x^{2}\right)^{m}}^{(b)}$.

Lemma 6 enables to characterize all nontrivial LCD skew cyclic and negacyclic codes of length $2 p^{s}$ over $\mathbb{F}_{p^{2}}$ (Proposition 7). Their dimensions are necessarily equal to $p^{s}$ :

Proposition 7. Consider $p$ a prime number, $\theta: a \mapsto a^{p}$ the Frobenius automorphism over $\mathbb{F}_{q}$ with $q=p^{2}, R=\mathbb{F}_{q}[x ; \theta], \epsilon \in\{-1,1\}$, s in $\mathbb{N}, n=2 p^{s}$ and $k \leq n$.

1. There is no non trivial (Euclidean and Hermitian) $L C D(\theta, \epsilon)$-constacyclic codes of length $n=2 p^{s}$ and dimension $k \neq p^{s}$.
2. The number of Euclidean $L C D(\theta, \epsilon)$-constacyclic codes of length $n=2 p^{s}$ and dimension $k=p^{s}$ over $\mathbb{F}_{p^{2}}$ is

$$
\left\{\begin{array}{cl}
2^{k} & \text { if } \quad p=2 \\
p^{k-1}\left(p-\epsilon(-1)^{(p+1) / 2}\right) & \text { if } \quad p \neq 2
\end{array}\right.
$$

3. The number of Hermitian $L C D(\theta, \epsilon)$-constacyclic codes of length $n=2 p^{s}$ and dimension $k=p^{s}$ over $\mathbb{F}_{p^{2}}$ is

$$
\left\{\begin{array}{cl}
0 & \text { if } p=2 \text { or } p \text { odd and } \epsilon=-1 \\
p^{k-1}(p+1) & \text { if } p \text { odd and } \epsilon=1
\end{array}\right.
$$

Proof. - The Euclidean LCD $\theta$-cyclic (resp. $\theta$-negacyclic) codes of length $n=2 p^{s}$ over $\mathbb{F}_{p^{2}}$ are generated by the monic irreducible skew polynomials belonging to $\mathcal{L}_{\left(x^{2}-\epsilon\right)^{p^{s}}}^{(0)}$ where $\epsilon=1$ (resp. $\epsilon=-1$ ). According to Lemma 6, a monic skew polynomial $g$ belongs to the set $\mathcal{L}_{\left(x^{2}-\epsilon\right)^{p^{s}}}^{(0)}$ if, and only if, $g=1$ or $g=\left(x^{2}-\epsilon\right)^{p^{s}}$ or $g=g_{p^{s}} \cdots g_{1}$ where $g_{1}, \ldots, g_{p^{s}}$ are monic skew polynomials satisfying :

\operatorname{deg}\left(g_{i}\right)=1 \\
g_{i} \operatorname{divides} \text { on the right } x^{2}-\epsilon \\
g_{i+1} \cdot g_{i} \neq x^{2}-\epsilon \\
g_{1} \neq h_{1}^{\natural} \text { where } h_{1}^{\natural} \cdot h_{1}=x^{2}-\epsilon
\end{array}\right.
$$

Therefore $g \neq 1,\left(x^{2}-\epsilon\right)^{p^{s}}$ belongs to the set $\mathcal{L}_{\left(x^{2}-\epsilon\right)^{p^{s}}}^{(0)}$ if, and only if, $g=\left(x+\alpha_{p^{s}}\right) \cdots\left(x+\alpha_{1}\right)$ where

$$
\left\{\begin{array}{l}
\alpha_{i}^{p+1}=\epsilon  \tag{2}\\
\alpha_{i+1} \neq-\epsilon / \alpha_{i} \\
\epsilon \neq-\theta\left(\alpha_{1}\right) / \alpha_{1}
\end{array}\right.
$$

Furthermore the above factorization of $g$ is unique, therefore the number of skew polynomials of degree $k=p^{s}$ in $\mathcal{L}_{\left(x^{2}-\epsilon\right)^{k}}^{(0)}$ is

$$
\left\{\begin{array}{cll}
p^{k-1}(p-1) & \text { if } p \text { odd and } \epsilon=(-1)^{(p+1) / 2} \\
p^{k-1}(p+1) & \text { if } p \text { odd and } \epsilon \neq(-1)^{(p+1) / 2} \\
2^{k} & \text { if } p=2
\end{array}\right.
$$

- The Hermitian LCD $\theta$-cyclic (resp. $\theta$-negacyclic) codes of length $n=2 p^{s}$ over $\mathbb{F}_{p^{2}}$ are generated by the monic skew polynomials belonging to $\mathcal{L}_{\left(x^{2}-\epsilon\right)^{p^{s}}}^{(1)}$ where $\epsilon=1$ (resp. $\epsilon=-1$ ). According to Lemma 6, a monic skew polynomial $g$ belongs to the set $\mathcal{L}_{\left(x^{2}-\epsilon\right)^{p^{s}}}^{(1)}$ if, and only if, $g=1$ or $g=\left(x^{2}-\epsilon\right)^{p^{s}}$ or $g=\left(x+\alpha_{p^{s}}\right) \cdots\left(x+\alpha_{1}\right)$ where

$$
\left\{\begin{array}{l}
x+\alpha_{i} \text { divides on the right } x^{2}-\epsilon \\
\left(x+\alpha_{i+1}\right) \cdot\left(x+\alpha_{i}\right) \neq x^{2}-\epsilon \\
x+\alpha_{1} \neq \Theta\left(h_{1}^{\natural}\right) \text { where } \Theta\left(h_{1}^{\natural}\right) \cdot h_{1}=x^{2}-\epsilon .
\end{array}\right.
$$

If $\epsilon=-1$ or $p=2, \mathcal{L}_{\left(x^{2}-\epsilon\right)^{p^{s}}}^{(1)}=\left\{1,\left(x^{2}-\epsilon\right)^{p^{s}}\right\}$. If $\epsilon=1$ and $p \neq 2$, the skew polynomial $g \neq$ $1,\left(x^{2}-\epsilon\right)^{p^{s}}$ belongs to the set $\mathcal{L}_{\left(x^{2}-\epsilon\right)^{p^{s}}}^{(1)}=\mathcal{L}_{\left(x^{2}-1\right)^{p^{s}}}^{(1)}$ if, and only if, $g=\left(x+\alpha_{p^{s}}\right) \cdots\left(x+\alpha_{1}\right)$ where

$$
\left\{\begin{array}{l}
\alpha_{i}^{p+1}=1  \tag{3}\\
\alpha_{i+1} \neq-1 / \alpha_{i}
\end{array}\right.
$$

In this case there are $(p+1) p^{k-1}$ skew polynomials of degree $k=p^{s}$ in $\mathcal{L}_{\left(x^{2}-\epsilon\right)^{k}}^{(1)}$.

Remark 3. Over $\mathbb{F}_{4}$, one can notice that when $k=2^{s}$, the number of Euclidean LCD $\theta$-cyclic codes [2k, k] growths exponentially with $k$ (Point 1. of Proposition 7), while the number of Euclidean self-dual $\theta$-cyclic codes $[2 k, k]$ is constant (Corollary 26 of [5]).

Remark 4. When $p$ is odd, the Euclidean LCD $\theta$-cyclic codes of length $2 p^{s}$ and dimension $p^{s}$ over $\mathbb{F}_{p^{2}}$ are all Hermitian LCD codes (because $\sqrt{2} \Rightarrow(3)$ when $\epsilon=1$ ). Assume now that $p \equiv 1$ $(\bmod 4)$, then there does not exist $\alpha$ in $\mathbb{F}_{p^{2}}$ such that $\alpha^{p+1}=1$ and $\alpha^{2}=-1$, therefore when $\epsilon=1,(2) \Leftrightarrow(3)$ and $a[2 p, p] \theta$-cyclic code over $\mathbb{F}_{p^{2}}$ is an Euclidean LCD code if and only if it is an Hermitian LCD code.

From the proof of Proposition 7. one deduces the following algorithm 1 for the construction of all LCD skew cyclic and negacyclic codes over $\mathbb{F}_{p^{2}}$ :

Example 9. There are $16=2^{2^{2}}$ nontrivial Euclidean $L C D \theta$-cyclic codes of length 8 over $\mathbb{F}_{4}=$ $\mathbb{F}_{2}(w)$ where $\theta$ is the Frobenius automorphism over $\mathbb{F}_{4}$. Their dimensions are all equal to 4. Consider $g=(x+1) \cdot\left(x+w^{2}\right) \cdot\left(x+w^{2}\right) \cdot\left(x+w^{2}\right)=x^{4}+w x^{3}+w x^{2}+x+1$. As $p=2$, $\left(w^{2}\right)^{p+1}=1^{p+1}=1,\left(w^{2}\right)^{2} \neq-1, w^{2} \neq 1 / w^{2}$ and $1 \neq 1 / w^{2}$, according to Proposition 7 and Algorithm 1, g generates an Euclidean LCD $[8,4]_{4} \theta$-cyclic code which is not an Hermitian LCD code. The systematic generator matrix of $C$ is $\left(I_{4} \mid P\right)$ where $P=\left(\begin{array}{cccc}1 & 1 & w & w \\ w^{2} & w & 0 & w \\ w^{2} & 1 & w & 1 \\ 1 & w^{2} & w^{2} & 1\end{array}\right)$. One checks that $1 \notin \operatorname{Spec}\left(P \times{ }^{t} P\right)$ therefore according to Proposition 4 of [ 9 ] $C$ is an Euclidean LCD code. Furthermore $1 \in \operatorname{Spec}\left(P \times{ }^{t} \bar{P}\right)$ therefore according to Proposition 6 of [9] $C$ is not an Hermitian LCD code.

Example 10. Consider $\mathbb{F}_{9}=\mathbb{F}_{3}(w)$ where $w^{2}=w+1$. There are $18=3^{2} \times\left(3-(-1)^{2}\right)$ nontrivial Euclidean LCD $\theta$-cyclic codes and $36=3^{2} \times(3+1)$ nontrivial Hermitian LCD $\theta$-cyclic codes of length 6 over $\mathbb{F}_{9}$. Their dimensions are equal to 3 .

- Consider $g=\left(x+w^{2}\right) \cdot\left(x+w^{6}\right) \cdot(x+1)=x^{3}+w^{5} x^{2}+w^{5} x+1$ and $h=(x+2) \cdot\left(x+w^{6}\right) \cdot\left(x+w^{2}\right)$. Then $g \cdot h=h \cdot g=x^{6}-1, h^{\natural}=\left(x+w^{6}\right) \cdot\left(x+w^{2}\right) \cdot(x+2)$ and $\Theta\left(h^{\natural}\right)=\left(x+w^{2}\right) \cdot\left(x+w^{6}\right) \cdot(x+2)$. These factorizations of $g, h$ and $\Theta\left(h^{\natural}\right)$ into the products of monic linear skew polynomials are unique. As $x+2 \neq x+1$, $h^{\natural}$ is right coprime with $g$ and $\Theta\left(h^{\natural}\right)$ is also rigth coprime to $g$. Therefore $g$ generates a $\theta$-cyclic code of length 6 which is both an Euclidean LCD code and a Hermitian LCD code.
- Consider $g=(x-1)^{2} \cdot\left(x-w^{6}\right)$ and $h=\left(x-w^{6}\right) \cdot(x+1)^{2}$. Then $g \cdot h=h \cdot g=x^{6}-1$. Consider the $\theta$-cyclic code $C$ of length 6 and dimension 3 generated by $g$. This code is MDS. Furthermore $h^{\natural}=g$, therefore $C$ is not an Euclidean LCD code and $\Theta\left(h^{\natural}\right)=(x-1)^{2} \cdot\left(x-a^{2}\right)$ is right coprime with $g$, therefore $C$ is a MDS Hermitian LCD code.

Example 11. Consider $\mathbb{F}_{9}=\mathbb{F}_{3}(w)$ where $w^{2}=w+1$. There are $36=3^{2} \times(3-(-1))$ nontrivial Euclidean LCD $\theta$-negacyclic codes of length 6 over $\mathbb{F}_{9}$. Their dimensions are equal to 3 . Consider

$g=\left(x+w^{5}\right) \cdot\left(x+w^{7}\right) \cdot\left(x+w^{3}\right)=x^{3}+x^{2}+w x+w^{7}$ and $h=\left(x+w^{5}\right) \cdot(x+w) \cdot\left(x+w^{3}\right)$. Then $g \cdot h=h \cdot g=x^{6}+1, h^{\natural}=\left(x+w^{3}\right) \cdot(x+w) \cdot(x+w)$ and $\Theta\left(h^{\natural}\right)=\left(x+w^{2}\right) \cdot\left(x+w^{3}\right) \cdot\left(x+w^{3}\right)$. These factorizations of $g, h$ and $\Theta\left(h^{\natural}\right)$ into the products of monic linear skew polynomials are unique. As $x+w^{3} \neq x+w, h^{\natural}$ is right coprime with $g$. Therefore $g$ generates a $\theta$-negacyclic code of length 6 which is an Euclidean LCD code. However $g$ and $\Theta\left(h^{\natural}\right)$ are not right coprime because $x+w^{3}$ divides both $g$ and $\Theta\left(h^{\natural}\right)$ and the code is not an Hermitian LCD code.

Example 12. Consider $\mathbb{F}_{25}=\mathbb{F}_{5}(w)$ where $w^{2}=w-2$. The skew polynomials $g=(x+1)^{3} \cdot(x+$ $w) \cdot(x+1)=x^{5}+w^{16} x^{4}+w^{5} x^{3}+2 x^{2}+w x+w^{4}$ and $h=(x-1) \cdot\left(x+w^{8}\right) \cdot(x-1)^{3}$ satisfy $g \cdot h=h \cdot g=x^{10}-1$. Furthermore $h^{\natural}=\left(x+w^{4}\right) \cdot\left(x+w^{20}\right) \cdot\left(x+w^{4}\right) \cdot\left(x+w^{16}\right) \cdot(x-1)$, $\Theta\left(h^{\natural}\right)=\left(x+w^{20}\right) \cdot\left(x+w^{4}\right) \cdot\left(x+w^{20}\right) \cdot\left(x+w^{8}\right) \cdot(x-1)$. The factorizations of $g$, $h$ and $\Theta\left(h^{\natural}\right)$ into the products of monic linear skew polynomials are unique. As $x-1 \neq x+1$, $h^{\natural}$ and $\Theta\left(h^{\natural}\right)$ are right coprime with $g$. Therefore $g$ generates a $\theta$-cyclic code $[10,5]$ which is an Euclidean LCD code and an Hermitian LCD code. Furthermore, this is an MDS code.

The following table 3 sums up the number of $[2 p, p]_{p^{2}}$ LCD $\theta$-cyclic codes and the number of $[2 p, p]_{p^{2}}$ MDS LCD $\theta$-cyclic codes for $p \in\{3,5,7,11\}$.

### 5.2 Any length over $\mathbb{F}_{p^{2}}$

The aim of this section is to give a complete description of Euclidean and Hermitian LCD skew cyclic and skew negacyclic codes over $\mathbb{F}_{p^{2}}$ (Proposition 8 and algorithm 3 ). In the case when the skew generator polynomials are not divisible by any central polynomial a complete counting formula is given (Proposition 9). Some examples and tables are given to illustrate the obtained results. Some MDS LCD codes are obtained over $\mathbb{F}_{9}, \mathbb{F}_{25}$ and $\mathbb{F}_{49}$.

In order to consider LCD skew cyclic and negacyclic codes of any even length over $\mathbb{F}_{p^{2}}$, we will characterize $\mathcal{L}_{f\left(x^{2}\right)^{m}}^{(b)}$ for $f\left(x^{2}\right) \in \mathcal{F}_{\text {red }}$ (Lemma 7 below). We deduce from Lemma 6 and 7 an algorithm for the construction of $\mathcal{L}_{f\left(x^{2}\right)^{m}}^{(b)}$ for $f\left(x^{2}\right) \in \mathcal{F}_{\text {irr }} \cup \mathcal{F}_{\text {red }}$ (algorithm 2p.

Lemma 7. Consider $p$ a prime number, $\theta: a \mapsto a^{p}$ the Frobenius automorphism over $\mathbb{F}_{q}$ with $q=p^{2}, R=\mathbb{F}_{q}[x ; \theta], f\left(x^{2}\right)=f_{i r}\left(x^{2}\right) f_{i r}^{\natural}\left(x^{2}\right)$ in $\mathcal{F}_{\text {red }}$ with degree $d=2 \delta$ in $x^{2}$. The monic skew polynomial $g \in R$ belongs to the set $\mathcal{L}_{f\left(x^{2}\right)^{m}}^{(b)}$ if, and only if, $g=1$ or $g=f\left(x^{2}\right)^{m}$ or $g=\operatorname{lclm}\left(g_{1}, g_{2}\right)$ where $g_{1}=g_{1, m} \cdots g_{1,1}$ and $g_{2}=g_{2, m} \cdots g_{2,1}$ have unique factorizations into the products of $m$ monic irreducible skew polynomials satisfying :

Proof. Consider $g$ in $\mathcal{L}_{f\left(x^{2}\right)^{m}}^{(b)} \backslash\left\{1, f_{i r}\left(x^{2}\right)^{m} f_{i r}^{\natural}\left(x^{2}\right)^{m}\right\}$ and $h$ in $R$ such that $g \cdot h=h \cdot g=$ $f_{i r}\left(x^{2}\right)^{m} f_{i r}^{\natural}\left(x^{2}\right)^{m}$ and $\operatorname{gcrd}\left(g, \Theta^{b}\left(h^{\natural}\right)\right)=1$. As $g$ divides $f_{i r}\left(x^{2}\right)^{m} f_{i r}^{\natural}\left(x^{2}\right)^{m}$, according to Theorem 4.1 of [11], $g=\operatorname{lclm}\left(g_{1}, g_{2}\right)$ where $g_{1}=\operatorname{gcrd}\left(f_{i r}\left(x^{2}\right)^{m}, g\right)$ and $g_{2}=\operatorname{gcrd}\left(f_{i r}^{\natural}\left(x^{2}\right)^{m}, g\right)$. Similarly, $h=\operatorname{lcrm}\left(h_{1}, h_{2}\right)$, where $h_{1}=\operatorname{gcld}\left(f_{i r}\left(x^{2}\right), h\right)$ and $h_{2}=\operatorname{gcld}\left(f_{i r}^{\natural}\left(x^{2}\right), h\right)$.

As $g \cdot h=h \cdot g=f_{i r}\left(x^{2}\right)^{m} f_{i r}^{\natural}\left(x^{2}\right)^{m}$, one has $g_{1} \cdot h_{1}=f_{i r}\left(x^{2}\right)^{m}$ and $g_{2} \cdot h_{2}=f_{i r}^{\natural}\left(x^{2}\right)^{m}$, therefore $g_{1}$ and $h_{1}$ (resp. $g_{2}$ and $h_{2}$ ) are products of irreducible skew polynomials dividing $f_{i r}\left(x^{2}\right)$ (resp. $\left.f_{i r}^{\natural}\left(x^{2}\right)\right)$.

If $f_{i r}\left(x^{2}\right)$ divides $g_{1}$, then, as $\Theta^{b}\left(h_{2}^{\natural}\right)$ divides $f_{i r}\left(x^{2}\right)^{m}, g_{1}$ and $\Theta^{b}\left(h_{2}^{\natural}\right)$ have a common right divisor (dividing $f_{i r}\left(x^{2}\right)$ ), therefore $g$ and $\Theta^{b}\left(h^{\natural}\right)$ also have a common nontrivial right divisor, which is impossible as $g$ and $\Theta^{b}\left(h^{\natural}\right)$ are right coprime. Therefore $f_{i r}\left(x^{2}\right)$ does not divide $g_{1}$. In the same way, $f_{i r}\left(x^{2}\right)$ does not divide $h_{1}, f_{i r}^{\natural}\left(x^{2}\right)$ does not divide $g_{2}$ and $h_{2}$, therefore using Proposition 6, one gets that the factorizations of $g_{1}, g_{2}, h_{1}$ and $h_{2}$ into the products of monic irreducible skew polynomials are unique and

As $g$ and $\Theta^{b}\left(h^{\natural}\right)$ are right coprime, $g_{1}$ and $\Theta^{b}\left(h_{2}^{\natural}\right)$ are right coprime, therefore $g_{1,1} \neq \Theta^{b}\left(h_{2,1}^{\natural}\right)$. Conversely, assume that $g=\operatorname{lclm}\left(g_{1}, g_{2}\right)$ where $g_{1}=g_{1, m} \cdots g_{1,1}, g_{2}=g_{2, m} \cdots g_{2,1}$ and 4) is satisfied. Consider $h_{i, j}$ such that $g_{1, i} \cdot h_{1, i}=f_{i r}\left(x^{2}\right)$ and $g_{2, i} \cdot h_{2, i}=f_{i r}^{\natural}\left(x^{2}\right)$. Consider $h_{1}=$ $h_{1,1} \cdots h_{1, m}, h_{2}=h_{2,1} \cdots h_{2, m}$ and $h=\operatorname{lcrm}\left(h_{1}, h_{2}\right)$. Then $g \cdot h=h \cdot g=f_{i r}\left(x^{2}\right)^{m} f_{i r}^{\natural}\left(x^{2}\right)^{m}$ and $g$ and $\Theta^{b}\left(h^{\natural}\right)$ are right coprime.

From Lemma 6 and Lemma 7, one deduces the following algorithm 2 for the construction of $\mathcal{L}_{f\left(x^{2}\right)^{m}}^{(b)}$ where $m \in \mathbb{N}$ and $f\left(x^{2}\right) \in \mathcal{F}_{i r} \cup \mathcal{F}_{\text {red }}$.

Theorem 3, Lemma 6 and Lemma 7 enable to characterize the skew generators of LCD $\theta$-cyclic and $\theta$-negacyclic codes over $\mathbb{F}_{p^{2}}$ as follows :
Proposition 8. Consider $\mathbb{F}_{q}$ a finite field with $q=p^{2}$ elements where $p$ is a prime number, $\theta: a \mapsto a^{p}$ the Frobenius automorphism over $\mathbb{F}_{p^{2}}, R=\mathbb{F}_{q}[x ; \theta], \lambda \in\{-1,1\}, b \in\{0,1\}, k \in \mathbb{N}$ and $n=2 p^{s} t$ an even integer with $t$ not divisible by $p$. Consider $x^{n}-\lambda=f_{1}\left(x^{2}\right)^{p^{s}} \cdots f_{r}\left(x^{2}\right)^{p^{s}}$ where $f_{1}\left(x^{2}\right), \ldots, f_{r}\left(x^{2}\right)$ are polynomials of $\mathbb{F}_{p}\left[x^{2}\right]$ belonging to $\left\{x^{2} \pm 1\right\} \cup \mathcal{F}_{i r} \cup \mathcal{F}_{\text {red }}$. Consider a $(\theta, \lambda)$ constacyclic code $C$ of length $n$ and with skew generator $g . C$ is an Euclidean (resp Hermitian) $L C D$ code of length $n$ and dimension $k$ if and only if

In this case, $C$ is the intersection of the skew constacyclic codes of length $n$ generated by $\prod_{i \in I} f_{i}\left(x^{2}\right)^{p^{s}}$ and $g_{j}$ where $j \in J$.

Proof. Proposition 5 Lemma 6 and Lemma 7
Remark 5. In Proposition 8, if $J$ is empty then $g$ is central; if $I$ is empty then $g$ is not divisible by any central polynomial. If $J=\{1, \ldots, r\}$ (and $I=\emptyset$ ), then $g$ is not divisible by any central polynomial and $\operatorname{deg}(g)=\sum_{i=1}^{r} \operatorname{deg}\left(g_{i}\right)=k$.

From Proposition 8, one deduces the Algorithm 3 for the construction of LCD $\theta$-cyclic and $\theta$-negacyclic codes of length $n$ and dimension $k$ over $\mathbb{F}_{p^{2}}$.

The following proposition characterizes LCD skew cyclic and negacyclic codes of even length $n=2 k$ and of dimension $k$ whose generator polynomials are not divisible by any central polynomial ( $J=\{1, \ldots, r\}$ and $I=\emptyset$ in Proposition 88).

Proposition 9. Consider a prime number $p, \theta: a \mapsto a^{p}$ the Frobenius automorphism over $\mathbb{F}_{p^{2}}$, $\lambda \in\{-1,1\}$ and $n=2 k=2 p^{s} t$ where $s$ is an integer and $t$ is an integer not divisible by $p$.

1. The number of Euclidean $L C D(\theta, \lambda)$-constacyclic codes of length $2 k$ and dimension $k$ with skew generator polynomial not divisible by any central polynomial is

$$

where $N_{1}= \begin{cases}2^{2^{s}} & \text { if } p=2 \\ \left(p^{p^{s}-1}\right)^{2}\left(p^{2}-1\right) & \text { if } k \text { is even and } p \text { is odd } \\ p^{p^{s}-1}\left(p-(-1)^{(p+1) / 2}\right) & \text { if } k \text { is odd and } p \text { is odd }\end{cases}$
and $N_{-1}=\left\{\begin{array}{cc}1 & \text { if } k \text { is even and } p \text { is odd } \\ p^{p^{s}-1}\left(p-(-1)^{(p-1) / 2}\right) & \text { if } k \text { is odd and } p \text { is odd }\end{array}\right.$

2. The number of Hermitian $L C D(\theta, \lambda)$-constacyclic codes of length $2 k$ and dimension $k$ with skew generator polynomial not divisible by any central polynomial is

N_{\lambda} \times \prod_{\substack{f \in \mathcal{F}_{i r} \cap \mathcal{D}_{x^{n}}-\lambda \\ d=\operatorname{deg}(f)}}\left(p^{d}-p^{d / 2}\right) p^{d\left(p^{s}-1\right)} \times \prod_{\substack{f \in \mathcal{F}_{r e d} \cap \mathcal{D}_{x^{n}}-\lambda \\ d=\operatorname{deg}(f)}}\left(1+p^{d / 2}\right) p^{\left(2 p^{s}-1\right) d / 2}
$$

where $N_{1}= \begin{cases}0 & \text { if } p=2 \\ 0 & \text { if } k \text { is even and } p \text { is odd } \\ p^{p^{s}-1}(p+1) & \text { if } k \text { is odd and } p \text { is odd }\end{cases}$
and $N_{-1}= \begin{cases}1 & \text { if } k \text { is even and } p \text { is odd } \\ 0 & \text { if } k \text { is odd and } p \text { is odd. }\end{cases}$
Proof. If $f\left(x^{2}\right) \in \mathbb{F}_{p}\left[x^{2}\right]$ is irreducible in $\mathbb{F}_{p}\left[x^{2}\right]$ with degree $d$, according to [21], the number of monic irreducible right factors of $f\left(x^{2}\right)$ is equal to $1+p^{d}$, and according to Lemma 3.4 of [7], the number of irreducible monic right factors $h_{1}$ of $f\left(x^{2}\right)$ such that $\Theta^{b}\left(h_{1}^{\natural}\right) \cdot h_{1}=f\left(x^{2}\right)$ is equal to $1+p^{d / 2}$. Therefore according to Lemma 6, if $f\left(x^{2}\right)$ belongs to $\mathcal{F}_{i r}$, the number of monic skew polynomials of degree $m d$ in $\mathcal{L}_{f\left(x^{2}\right)^{m}}^{(b)}$ is $\left(\left(p^{d}+1\right)-\left(1+p^{d / 2}\right)\right)\left(1+p^{d}-1\right)^{m-1}=\left(p^{d}-p^{d / 2}\right) p^{d(m-1)}$.

If $f\left(x^{2}\right)$ belongs to $\mathcal{F}_{r e d}, \mathcal{L}_{f\left(x^{2}\right)^{m}}^{(b)} \backslash\left\{1, f\left(x^{2}\right)^{m}\right\}$ has $\left(1+p^{d / 2}\right) p^{(2 m-1) d / 2}$ elements where $\delta=d / 2$ and $d$ is the degree of $f\left(x^{2}\right)$ in $x^{2}$. Namely, according to Lemma 7, the elements of $\mathcal{L}_{f\left(x^{2}\right)^{m}}^{(b)}$ $\left\{1, f\left(x^{2}\right)^{m}\right\}$ are the skew polynomials $g$ in bijection with the couples $\left(g_{1}, g_{2}\right)$ satisfying (4). There are $1+p^{\delta}$ possibilities for $g_{1,1}$ and $p^{\delta}$ possibilities for each $g_{1, j}$, with $j=2, \ldots, m$, therefore $\left(1+p^{\delta}\right) p^{\delta(m-1)}$ possibilities for $g_{1}$. For each $j$ in $\{1, \ldots, m\}$ there are $p^{\delta}$ possibilities for $g_{2, j}$, therefore, one gets $p^{\delta m}$ possibilities for $g_{2}$.

Lastly the value of $N$ is deduced from the cardinalities of $\mathcal{L}_{\left(x^{2} \pm 1\right)^{p^{s}}}^{(b)}$ (Proposition 7 .

We give below some detailed examples over $\mathbb{F}_{4}, \mathbb{F}_{25}$ and $\mathbb{F}_{49}$ who illustrate Proposition 9 and Algorithm 3 .

Example 13. One has $x^{6}+1=\left(x^{2}+1\right)\left(x^{4}+x^{2}+1\right)$ in $\mathbb{F}_{2}\left[x^{2}\right]$. For $\theta: a \mapsto a^{2}$, the Euclidean $L C D$-cyclic codes of length 6 over $\mathbb{F}_{4}=\mathbb{F}_{2}(w)$ are generated by the monic skew polynomials

$g=\operatorname{lclm}\left(g_{1}, g_{2}\right)$ where $g_{1} \in \mathcal{L}_{x^{2}+1}^{(0)}=\left\{x+w, x+w^{2}, 1, x^{2}+1\right\}$ and $g_{2} \in \mathcal{L}_{x^{4}+x^{2}+1}^{(0)}=\left\{x^{2}+w x+\right.$ $\left.1, x^{2}+w^{2} x+1,1, x^{4}+x^{2}+1\right\}$. There are four $[6,3]_{4}$ Euclidean LCD $\theta$-cyclic codes.

These codes are also Hermitian self-dual. Namely $x+w=\Theta\left(x+w^{2}\right)=\Theta\left(\left(x+w^{2}\right)^{\natural}\right)$ and $\Theta\left(\left(x+w^{2}\right)^{\natural}\right) \cdot\left(x+w^{2}\right)=x^{2}+1$. Furthermore, $x^{2}+w x+1=\Theta\left(x^{2}+w^{2} x+1\right)=\Theta\left(\left(x^{2}+w x+1\right)^{\mathrm{\natural}}\right)$ and $\Theta\left(\left(x^{2}+w x+1\right)^{\mathfrak{4}}\right) \cdot\left(x^{2}+w x+1\right)=x^{4}+x^{2}+1$ therefore the above skew polynomials $g$ all satisfy $g=\Theta\left(h^{\natural}\right)$ where $\Theta\left(h^{\natural}\right) \cdot h=x^{6}-1$.
Example 14. There are 32 Euclidean LCD $\theta$-cyclic codes of length 12 and dimension 6 over $\mathbb{F}_{4}$ where $\theta: a \mapsto a^{2}$. They are generated by the skew polynomials $g=\operatorname{lclm}\left(g_{1}, g_{2}\right)$ where $g_{1} \in$ $\left\{(x+1) \cdot(x+w),(x+w) \cdot(x+w),(x+1) \cdot\left(x+w^{2}\right),\left(x+w^{2}\right) \cdot\left(x+w^{2}\right)\right\}$ and $g_{2} \in\left\{\left(x^{2}+w\right) \cdot\left(x^{2}+\right.\right.$ $w x+1),\left(x^{2}+w^{2}\right) \cdot\left(x^{2}+w x+1\right),\left(x^{2}+x+1\right) \cdot\left(x^{2}+w x+1\right),\left(x^{2}+w^{2} x+1\right) \cdot\left(x^{2}+w x+1\right),\left(x^{2}+w\right)$. $\left.\left(x^{2}+w^{2} x+1\right),\left(x^{2}+w^{2}\right) \cdot\left(x^{2}+w^{2} x+1\right),\left(x^{2}+x+1\right) \cdot\left(x^{2}+w^{2} x+1\right),\left(x^{2}+w x+1\right) \cdot\left(x^{2}+w^{2} x+1\right)\right\}$.

Table 4 below sums up the repartition of all the Euclidean LCD $\theta$-cyclic codes of length 12 over $\mathbb{F}_{4}$ and gives one example for each dimension.

Example 15. As $x^{14}+1=\left(x^{2}+1\right)\left(x^{6}+x^{4}+1\right)\left(x^{6}+x^{2}+1\right)$ over $\mathbb{F}_{2}\left[x^{2}\right]$, there are $2 \times\left(1+2^{3}\right) \times 2^{3}=$ 144 Euclidean LCD $\theta$-cyclic codes of length 14 and dimension 7 over $\mathbb{F}_{4}$ where $\theta: a \mapsto a^{2}$. For example, consider $g_{0}=x+w, g_{1}=x^{3}+x^{2}+w^{2} x+1$ and $g_{2}=x^{3}+w^{2} x^{2}+x+w$. $g_{1}$ is a right divisor of $x^{6}+x^{2}+1$ and $g_{2}$ is a right divisor of $x^{6}+x^{4}+1$. Furthermore $h_{2}=x^{3}+w x^{2}+x+w^{2}$ is such that $g_{2} \cdot h_{2}=x^{6}+x^{4}+1$ and $h_{2}^{\natural}=x^{3}+w^{2} x^{2}+w x+w^{2} \neq g_{1}$ therefore $g=\operatorname{lc} \operatorname{lm}\left(g_{0}, g_{1}, g_{2}\right)=$ $1+w^{2} x+w x^{2}+w^{2} x^{4}+w^{2} x^{5}+w x^{6}+x^{7}$ generates an Euclidean LCD $\theta$-cyclic code of length 14 over $\mathbb{F}_{4}$. The minimum distance of the code is equal to 6 .
Example 16. Consider $\theta$ the Frobenius automorphism over $\mathbb{F}_{25}=\mathbb{F}_{5}(w)$ where $w^{2}+4 w+2=0$. The skew polynomial $g=x^{7}+4 x^{6}+w^{4} x^{5}+w^{7} x^{4}+w^{7} x^{3}+w^{16} x^{2}+w^{8} x+w^{20}$ generates $a$ $M D S[14,7,8]_{25} \theta$-cyclic code over $\mathbb{F}_{25}$ which a LCD code for the Euclidean scalar product and for the Hermitian scalar product. The skew polynomial $g$ is obtained as $g=\operatorname{lclm}\left(g_{1}, g_{2}\right)$ where $g_{1}=x+w^{16}$ belongs to $\mathcal{L}_{x^{2}-1}^{(0)} \cap \mathcal{L}_{x^{2}-1}^{(1)}$ and $g_{2}=x^{6}+w^{11} x^{5}+2 x^{4}+w^{3} x^{3}+2 x^{2}+w^{11} x+1$ belongs to $\mathcal{L}_{x^{12}+x^{10}+x^{8}+x^{6}+x^{4}+x^{2}+1}^{(0)} \cap \mathcal{L}_{x^{12}+x^{10}+x^{8}+x^{6}+x^{4}+x^{2}+1}^{(1)}$.
Example 17. Consider $\theta$ the Frobenius automorphism over $\mathbb{F}_{49}=\mathbb{F}_{7}(w)$ where $w^{2}+6 w+3=0$. The skew polynomial $g=x^{8}+6 x^{7}+w^{7} x^{6}+w^{28} x^{5}+w^{11} x^{4}+w^{47} x^{3}+w^{10} x^{2}+w^{30} x+w^{12}$ generates a $M D S[16,8,9]_{49} \theta$-negacyclic code over $\mathbb{F}_{49}$ which is both an Euclidean $L C D$ code and a Hermitian LCD code. The skew polynomial $g$ is obtained as $g=\operatorname{lc} \operatorname{lm}\left(g_{1}, g_{2}\right)$ where $g_{1}=$ $x^{4}+w^{39} x^{3}+w^{3} x^{2}+w^{33} x+1$ belongs to $\mathcal{L}_{x^{8}+4 x^{4}+1}^{(0)} \cap \mathcal{L}_{x^{8}+4 x^{4}+1}^{(1)}$ and $g_{2}=x^{4}+5 x^{3}+w^{30} x^{2}+w^{35} x+w^{6}$ belongs to $\mathcal{L}_{x^{8}+3 x^{4}+1}^{(0)} \cap \mathcal{L}_{x^{8}+3 x^{4}+1}^{(1)}$.

Lastly, Table 5 and Table 6 illustrate Proposition 9 over $\mathbb{F}_{4}$ and $\mathbb{F}_{9}$. Best minimum distances and numbers of LCD $[2 k, k]$ skew cyclic and negacyclic codes over $\mathbb{F}_{4}$ and $\mathbb{F}_{9}$ are given in the case when the skew generator polynomials are not divisible by any central polynomial. The index * means that the minimum distance is the best known minimum distance of codes with these parameters.

Tables 7 sums up the dimensions of MDS LCD skew codes of given length $\leq 10$ over $\mathbb{F}_{9}$. Tables 8 and 9 sum up the dimensions of MDS LCD skew codes of length $\leq 18$ over $\mathbb{F}_{25}$ and of length $\leq 16$ over $\mathbb{F}_{49}$.

## 6 Conclusion

In this text, skew LCD codes are studied. LCD skew cyclic and negacyclic codes are constructed and enumerated over $\mathbb{F}_{p^{2}}$. Some computations are made and MDS LCD codes are constructed. It could be interesting to see if there exists $[2 p, p]_{p^{2}}$ MDS LCD codes for $p$ odd prime greater than 11.
