# An arithmetical function related to Báez-Duarte's criterion for the Riemann hypothesis 

Michel Balazard

#### Abstract

In this mainly expository article, we revisit some formal aspects of Báez-Duarte's criterion for the Riemann hypothesis. In particular, starting from Weingartner's formulation of the criterion, we define an arithmetical function $v$, which is equal to the Möbius function if, and only if the Riemann hypothesis is true. We record the basic properties of the Dirichlet series of $v$, and state a few questions.

## 1 The spaces $D$ and $D_{0}$

We will denote by $\mathbb{N}$ (resp. $\left.\mathbb{N}^{*}\right)$ the set of non-negative (resp. positive) integers, by $H$ the Hilbert space $L^{2}\left(0, \infty ; t^{-2} d t\right)$, with inner product

$$
\langle f, g\rangle=\int_{0}^{\infty} f(t) \overline{g(t)} \frac{d t}{t^{2}}
$$

and by $\operatorname{Vect}(\mathscr{F})$ the set of finite linear combinations of elements of a family $\mathscr{F}$ of elements of $H$.
For $k \in \mathbb{N}^{*}$, we define

$$
e_{k}(t)=\{t / k\} \quad(t>0),
$$

where $\{u\}=u-\lfloor u\rfloor$ denotes the fractional part of the real number $u$, and $\lfloor u\rfloor$ its integer part. The functions $e_{k}$ belong to $H$, as do the functions $\chi$ and $\kappa$ defined by

$$
\chi(t)=[t \geq 1] \quad ; \quad \kappa(t)=t[0<t<1]
$$

(here, and in the following, we use Iverson's notation : $[P]=1$ if the assertion $P$ is true, $[P]=0$ if it is false).

Let $D$ be the closed subspace of functions $f \in H$ of the type

$$
\begin{equation*}
f(t)=\lambda t+\varphi(t) \tag{1}
\end{equation*}
$$

where $\varphi$ is constant on each interval $[j, j+1[, j \in \mathbb{N}$ (for $j=0$, the constant must be 0 ). The functions $e_{k}$ belong to $D$.

Let $D_{0}$ be the subspace of $D$ defined by taking $\lambda=0$ in (1), that is, the subspace of functions $\varphi \in H$ which are constant on each interval $\left[j, j+1\left[, j \in \mathbb{N}\right.\right.$. The functions $\chi$ and $e_{k}-e_{1} / k$ belong to $D_{0}$.

A hilbertian basis for $D_{0}$ is given by the family of step functions $\varepsilon_{k}$ defined by

$$
\varepsilon_{k}(t)=\sqrt{k(k+1)} \cdot[k \leq t<k+1] \quad\left(k \in \mathbb{N}^{*}, t>0\right) .
$$

The mapping $h \mapsto(h(j))_{j \geq 1}$ is a Hilbert space isomorphism of $D_{0}$ onto the sequence space $\mathfrak{h}$ of complex sequences $\left(x_{j}\right)_{j \geq 1}$ such that

$$
\sum_{j \geq 1} \frac{\left|x_{j}\right|^{2}}{j(j+1)}<\infty
$$

Observe that, for $f \in D$, written as (1), one has

$$
\begin{align*}
\lambda & =\langle f, \kappa\rangle  \tag{2}\\
f & =\lambda e_{1}+h, \text { where } h \in D_{0} . \tag{3}
\end{align*}
$$

Thus, the subspace $D$ is the (non orthogonal) direct sum of $\operatorname{Vect}\left(e_{1}\right)$ and $D_{0}$.
In formula (2), the function $\kappa$ could be replaced by its orthogonal projection $\kappa^{\prime}$ on $D$. The definition of the families $\left(\psi_{n}\right)$ of Proposition 2 and $\left(g_{n}\right)$ of Proposition 4 below could be modified accordingly. We compute $\kappa^{\prime}$ in the appendix.

To every function in $D$, one can associate certain arithmetical functions. Let $f \in D$, with $\lambda$ and $h$ as in (2), (3). We first define the arithmetical function

$$
\begin{equation*}
u(n)=u(n ; f)=-\lambda+h(n)-h(n-1) \quad\left(n \in \mathbb{N}^{*}\right) \tag{4}
\end{equation*}
$$

With this definition, we see that the function $\varphi$ of (1) is given by

$$
\varphi(t)=-\lambda t+f(t)=-\lambda t+\lambda\{t\}+h(t)=\sum_{n \leq t} u(n) .
$$

Thus, $f(t)$ is the remainder term in the approximation of the sum function $\varphi(t)$ of the arithmetical function $u$ by the linear function $-\lambda t$. The fact that $f$ belongs to $H$ implies, and is stronger than, the asymptotic relation $f(t)=o(t)$.

For $f \in D$, we will also consider the arithmetical function $w=\mu * u$, where $\mu$ denotes the Möbius function,

$$
w(n)=w(n ; f)=\sum_{d \mid n} \mu(n / d) u(d ; f) \quad\left(n \in \mathbb{N}^{*}\right) .
$$

For instance,

$$
u(n ; \chi)=[n=1] \quad ; \quad w(n ; \chi)=\mu(n) \quad\left(n \in \mathbb{N}^{*}\right)
$$

The arithmetical functions $u$ and $w$ depend linearly on $f$ and the correspondences are one-to-one.
Proposition 1 For $f \in D$,

$$
f=0 \Leftrightarrow u=0 \Leftrightarrow w=0 .
$$

## Proof

The second equivalence follows from $w=u * \mu$ and $u=w * 1$ (Möbius inversion). It remains to prove that $u=0 \Rightarrow f=0$. By (4), $u=0$ implies $h(n)=\lambda n$ for all $n$, hence $\lambda=0$ since $h \in D_{0}$, and $h=0$.

Since $u=w * 1$, one has

$$
f(t)=\lambda t+\sum_{n \leq t} u(n)=\lambda t+\sum_{n \geq 1} w(n)\lfloor t / n\rfloor .
$$

In Proposition 7 below, we will prove the identity

$$
\begin{equation*}
\sum_{n \geq 1} \frac{w(n)}{n}=-\lambda \tag{5}
\end{equation*}
$$

so that, for every $f$ in $D$ and every $t>0$, one has

$$
\begin{equation*}
f(t)=-\sum_{n \geq 1} w(n) e_{n}(t) . \tag{6}
\end{equation*}
$$

Of course, it does not mean that the series $\sum_{n \geq 1} w(n ; f) e_{n}$ converges in $H$ (in fact, it diverges if $f=\chi$, cf. [1], Theorem 2.2, p. 6), but, if it does, its sum is $-f$.

## 2 Vasyunin's biorthogonal system

In Theorem 7 of his paper [7], Vasyunin defined a family $\left(f_{k}\right)_{k \geq 2}$, which, together with the family $\left(e_{k}-e_{1} / k\right)_{k \geq 2}$, yields a biorthogonal system in $D_{0}$, which means that

$$
\begin{equation*}
\left\langle e_{j}-e_{1} / j, f_{k}\right\rangle=[j=k] \quad(j \geq 2, k \geq 2) . \tag{7}
\end{equation*}
$$

We will recall Vasyunin's construction, which can be thought of as a Hilbert space formulation of Möbius inversion, and add several comments.

### 2.1 The sequence $\left(\varphi_{k}\right)$

First one defines, for $k \in \mathbb{N}^{*}$, a step function $\varphi_{k} \in D_{0}$ by

$$
\varphi_{k}(t)=k(k-1)[k-1 \leq t<k]-k(k+1)[k \leq t<k+1]
$$

(Vasyunin's $\varphi_{k}$ have the opposite sign, according to his definition for $e_{k}$ ). Thus

$$
\varphi_{k}=\sqrt{k(k-1)} \cdot \varepsilon_{k-1}-\sqrt{k(k+1)} \cdot \varepsilon_{k} \quad\left(k \in \mathbb{N}^{*}\right)
$$

with $\varepsilon_{0}=0$ by convention. One sees that the family $\left(\varphi_{k}\right)_{k \geq 1}$ is total in $D_{0}$.
One checks that

$$
\begin{equation*}
\left\langle h, \varphi_{k}\right\rangle=h(k-1)-h(k) \quad\left(k \in \mathbb{N}^{*}\right), \tag{8}
\end{equation*}
$$

for $h \in D_{0}$ with constant value $h(k)$ on $[k, k+1[(h(0)=0)$. In particular,

$$
\left\langle e_{j}-e_{1} / j, \varphi_{k}\right\rangle=[j \mid k]-1 / j \quad(j \geq 1, k \geq 1) .
$$

Using the family $\left(\varphi_{k}\right)$, one can write the values $u(n ; f)$, for $f \in D$, as scalar products.

Proposition 2 For $f \in D$, with $\lambda$ and $h$ as in (2), (3), one has

$$
u(n ; f)=\left\langle f, \psi_{n}\right\rangle,
$$

where

$$
\psi_{n}=\left(\left\langle e_{1}, \varphi_{n}\right\rangle-1\right) \kappa-\varphi_{n} \quad\left(n \in \mathbb{N}^{*}\right) .
$$

In particular, $f \mapsto u(n ; f)$ is a continuous linear form on $D$, for every $n \in \mathbb{N}^{*}$.

## Proof

By (2), (4) and (8), one has

$$
\begin{aligned}
u(n ; f) & =-\langle f, \kappa\rangle-\left\langle h, \varphi_{n}\right\rangle \\
& =-\langle f, \kappa\rangle-\left\langle f-\langle f, \kappa\rangle e_{1}, \varphi_{n}\right\rangle \\
& =-\langle f, \kappa\rangle-\left\langle f, \varphi_{n}\right\rangle+\left\langle e_{1}, \varphi_{n}\right\rangle\langle f, \kappa\rangle \\
& =\left\langle f, \psi_{n}\right\rangle \quad\left(n \in \mathbb{N}^{*}\right) .
\end{aligned}
$$

We compute the scalar product $\left\langle e_{1}, \varphi_{n}\right\rangle$ in the appendix.
The next proposition describes the behavior of the series $\sum_{k} \varphi_{k} / k$.
Proposition 3 The series

$$
\sum_{k \geq 1} \frac{\varphi_{k}}{k}
$$

is weakly convergent in $D_{0}$, with weak sum $-\chi$.

## Proof

The partial sum

$$
\sum_{k \leq K} \frac{\varphi_{k}}{k}
$$

is the step function with values

$$
\begin{aligned}
& \quad 0 \text { on }(0,1) \text { and }(K+1, \infty) \\
& -1 \text { on }(1, K) \\
& -(K+1) \text { on }(K, K+1)
\end{aligned}
$$

This partial sum is thus equal to $-\chi$ on every fixed bounded segment of $(0, \infty)$, if $K$ is large enough, and the norm of this partial sum in $H$ is the constant $\sqrt{2}$. The result follows.

### 2.2 The sequence $\left(f_{k}\right)$

Vasyunin defined

$$
f_{k}=\sum_{d \mid k} \mu(k / d) \varphi_{d} \quad\left(k \in \mathbb{N}^{*}\right)
$$

Equivalently,

$$
\varphi_{k}=\sum_{d \mid k} f_{d} \quad\left(k \in \mathbb{N}^{*}\right),
$$

by Möbius inversion ; this implies that the family $\left(f_{k}\right)_{k \geq 1}$ is also total in $D_{0}$.
A slightly more general form of (7), namely

$$
\begin{equation*}
\left\langle e_{j}-e_{1} / j, f_{k}\right\rangle=[j=k]-[k=1] / j \quad\left(j, k \in \mathbb{N}^{*}\right) \tag{9}
\end{equation*}
$$

is proved by means of the identity

$$
\sum_{j|d| k} \mu(k / d)=[j=k] .
$$

Using the family $\left(f_{k}\right)$, one can write the values $w(n ; f)$, for $f \in D$, as scalar products.
Proposition 4 For $f \in D$, with $\lambda$ and $h$ as in (2), (3), one has

$$
w(n ; f)=\left\langle f, g_{n}\right\rangle,
$$

where

$$
g_{n}=\left(\left\langle e_{1}, f_{n}\right\rangle-[n=1]\right) \kappa-f_{n} \quad\left(n \in \mathbb{N}^{*}\right)
$$

In particular, $f \mapsto w(n ; f)$ is a continuous linear form on $D$, for every $n \in \mathbb{N}^{*}$.

## Proof

By Proposition 2, one has

$$
\begin{aligned}
w(n ; f) & =\sum_{d \mid n} \mu(n / d) u(d ; f) \\
& =\left\langle f, \sum_{d \mid n} \mu(n / d) \psi_{d}\right\rangle \quad\left(n \in \mathbb{N}^{*}\right) .
\end{aligned}
$$

Now,

$$
\begin{aligned}
\sum_{d \mid n} \mu(n / d) \psi_{d} & =\sum_{d \mid n} \mu(n / d)\left(\left(\left\langle e_{1}, \varphi_{d}\right\rangle-1\right) \kappa-\varphi_{d}\right) \\
& =\left(\left\langle e_{1}, f_{n}\right\rangle-[n=1]\right) \kappa-f_{n}
\end{aligned}
$$

We compute the scalar product $\left\langle e_{1}, f_{n}\right\rangle$ in the appendix.
In order to study the series $\sum_{k} f_{k} / k$, we will need the following auxiliary proposition.
Proposition 5 Let

$$
f(x)=\sum_{k \leq x} \eta(k) \quad(x>0)
$$

where $\eta$ is a complex arithmetical function such that $\eta(k)=O(1 / k)$, for $k \geq 1$.
Then, for every fixed $\alpha>1$,

$$
\sum_{k \geq 1}|f(x / k)-f(x /(k+1))|^{\alpha}=O(1) \quad(x>0)
$$

## Proof

The series is in fact a finite sum, as

$$
f(x / k)=f(x /(k+1))=0 \quad(k>x) .
$$

We will use the estimate

$$
f(y)-f(x) \ll \sum_{x<k \leq y} \frac{1}{k} \ll \frac{1}{x}+\ln (y / x) \quad(y>x \geq 1)
$$

Thus,

$$
f(x / k)-f(x /(k+1)) \ll \frac{k}{x}+\frac{1}{k} \ll \frac{1}{k} \quad(k \leq \sqrt{x}),
$$

and

$$
\sum_{k \leq \sqrt{x}}|f(x / k)-f(x /(k+1))|^{\alpha} \ll \sum_{k \geq 1} \frac{1}{k^{\alpha}} \ll 1 \quad(x>0) .
$$

If $k>\sqrt{x}$, then

$$
\frac{x}{k}-\frac{x}{k+1}<1
$$

so that the interval $] x /(k+1), x / k\rfloor$ contains at most one integer, say $n$, and, if $n$ exists, one has $k=\lfloor x / n\rfloor$ and

$$
f(x / k)-f(x /(k+1))=\eta(n) \ll \frac{1}{n}
$$

Hence

$$
\sum_{k>\sqrt{x}}|f(x / k)-f(x /(k+1))|^{\alpha} \ll \sum_{n \geq 1} \frac{1}{n^{\alpha}} \ll 1 \quad(x>0)
$$

The result follows.
Proposition 6 The series

$$
\sum_{k \geq 1} \frac{f_{k}}{k}
$$

is weakly convergent in $D_{0}$ (hence in $H$ ), with weak sum 0 .

## Proof

Let $K \in \mathbb{N}^{*}$. One has

$$
S_{K}=\sum_{k \leq K} \frac{f_{k}}{k}=\sum_{d \leq K} \frac{m(K / d)}{d} \varphi_{d}
$$

where

$$
m(x)=\sum_{n \leq x} \frac{\mu(n)}{n} \quad(x>0)
$$

Hence,

$$
\begin{aligned}
S_{K} & =\sum_{d \leq K} \frac{m(K / d)}{d}\left(\sqrt{d(d-1)} \cdot \varepsilon_{d-1}-\sqrt{d(d+1)} \cdot \varepsilon_{d}\right) \\
& =\sum_{d \leq K-1}\left(\frac{m(K /(d+1))}{d+1}-\frac{m(K / d)}{d}\right) \sqrt{d(d+1)} \cdot \varepsilon_{d}-\sqrt{1+1 / K} \cdot \varepsilon_{K}
\end{aligned}
$$

For every fixed $d \in \mathbb{N}^{*}$, the fact that $\left\langle S_{K}, \varepsilon_{d}\right\rangle$ tends to 0 when $K$ tends to infinity follows from this formula and the classical result of von Mangoldt, that $m(x)$ tends to 0 when $x$ tends to infinity.

It remains to show that $\left\|S_{K}\right\|$ is bounded. One has

$$
\begin{aligned}
\left\|S_{K}\right\|^{2}= & \sum_{d \leq K-1} d(d+1)\left(\frac{m(K / d)}{d}-\frac{m(K /(d+1))}{d+1}\right)^{2}+1+1 / K \\
\leq & 2 \sum_{d \leq K-1} d(d+1)\left(\frac{m(K / d)-m(K /(d+1))}{d}\right)^{2} \\
& +2 \sum_{d \leq K-1} d(d+1)\left(\frac{m(K /(d+1))}{d(d+1)}\right)^{2}+1+1 / K \\
\ll & 1+\sum_{d \leq K-1}(m(K / d)-m(K /(d+1)))^{2}
\end{aligned}
$$

The boundedness of $\left\|S_{K}\right\|$ then follows from Proposition 5.
We are now able to prove (5).
Proposition 7 Let $f \in D$, with $\lambda$ and $h$ as in (2), (3). The series

$$
\sum_{n \geq 1} \frac{w(n ; f)}{n}
$$

is convergent and has sum $-\lambda$.

## Proof

Putting $\beta_{N}=\sum_{n \leq N} f_{n} / n$ for $N \in \mathbb{N}^{*}$, one has

$$
\begin{aligned}
\sum_{n \leq N} \frac{g_{n}}{n} & =\sum_{n \leq N} \frac{\left(\left\langle e_{1}, f_{n}\right\rangle-[n=1]\right) \kappa-f_{n}}{n} \\
& =\left(\left\langle e_{1}, \beta_{N}\right\rangle-1\right) \kappa-\beta_{N}
\end{aligned}
$$

which tends weakly to $-\kappa$, as $N$ tends to infinity, by Proposition 6.
Hence,

$$
\sum_{n \leq N} \frac{w(n ; f)}{n}=\sum_{n \leq N} \frac{\left\langle f, g_{n}\right\rangle}{n}=\left\langle f, \sum_{n \leq N} g_{n} / n\right\rangle \rightarrow-\langle f, \kappa\rangle=-\lambda \quad(N \rightarrow \infty)
$$

## 3 Dirichlet series

For $f \in D$ we define

$$
F(s)=\sum_{n \geq 1} \frac{u(n ; f)}{n^{s}}
$$

and we will say that $F$ is the Dirichlet series of $f$.
We will denote by $\sigma$ the real part of the complex variable $s$. The following proposition summarizes the basic facts about the correspondance between elements $f$ of $D$ and their Dirichlet series $F$. We keep the notations of (2) and (3).

Proposition 8 For $f \in D$, the Dirichlet series $F(s)$ is absolutely convergent in the half-plane $\sigma>3 / 2$, and convergent in the half-plane $\sigma>1$. It has a meromorphic continuation to the half-plane $\sigma>1 / 2$ (we will denote it also by $F(s)$ ), with a unique pole in $s=1$, simple and with residue $-\lambda$. In the strip $1 / 2<\sigma<1$, one has

$$
\begin{equation*}
F(s) / s=\int_{0}^{\infty} f(t) t^{-s-1} d t \tag{10}
\end{equation*}
$$

If $f \in D_{0}$, that is $\lambda=0$, there is no pole at $s=1$, and the Mellin transform (10) represents the analytic continuation of $F(s) / s$ to the half-plane $\sigma>1 / 2$. Moreover, the Dirichlet series $F(s)$ converges on the line $\sigma=1$.

## Proof

If $h=0$ in (3), the arithmetical function $u$ is the constant $-\lambda$, and $F=-\lambda \zeta$. In this case, the assertion about (10) follows from (2.1.5), p. 14 of [6].

If $\lambda=0$, then $f=h \in D_{0}$ and $u(n)=h(n)-h(n-1)$ by (4). Therefore,

$$
\begin{aligned}
\sum_{n \geq 1} \frac{|u(n)|}{n^{\sigma}} & \leq 2 \sum_{n \geq 1} \frac{|h(n)|}{n^{\sigma}} \\
& \leq 2\left(\sum_{n \geq 1} \frac{|h(n)|^{2}}{n^{2}}\right)^{1 / 2}\left(\sum_{n \geq 1} \frac{1}{n^{2 \sigma-2}}\right)^{1 / 2} \\
& \leq 2 \zeta(2 \sigma-2)^{1 / 2}\|h\|<\infty
\end{aligned}
$$

if $\sigma>3 / 2$, where we used Cauchy's inequality for sums.
The convergence of the series $F(1)$ follows from the formula $u(n)=-\left\langle h, \varphi_{n}\right\rangle$ and Proposition 3 . It implies the convergence of $F(s)$ in the half-plane $\sigma>1$.

Using the Bunyakovsky-Schwarz inequality for integrals, and the fact that $h=0$ on $(0,1)$, one sees that the integral (10) now converges absolutely and uniformly in every half-plane $\sigma \geq 1 / 2+\varepsilon$ (with $\varepsilon>0$ ), thus defining a holomorphic function in the half-plane $\sigma>1 / 2$. It is the analytic continuation of $F(s) / s$ since one has, for $\sigma>3 / 2$,

$$
\begin{aligned}
\int_{0}^{\infty} h(t) t^{-s-1} d t & =\frac{1}{s} \sum_{n \geq 1} h(n)\left(n^{-s}-(n+1)^{-s}\right) \\
& =\frac{1}{s} \sum_{n \geq 1} \frac{h(n)-h(n-1)}{n^{s}}=\frac{F(s)}{s}
\end{aligned}
$$

Finally, the convergence of the Dirichlet series $F(s)$ on the line $\sigma=1$ follows from the convergence at $s=1$ and the holomorphy of $F$ on the line, by a theorem of Marcel Riesz (cf. [5], Satz I, p. 350).

One combines the two cases, $h=0$ and $\lambda=0$, to obtain the statement of the proposition.
The Dirichlet series $F(s)$ of functions in $D_{0}$ are precisely those which converge in some halfplane and have an analytic continuation to $\sigma>1 / 2$ such that $F(s) / s$ belongs to the Hardy space $H^{2}$ of this last half-plane. As we will not use this fact in the present paper, we omit its proof.

We now investigate the Dirichlet series

$$
\frac{F(s)}{\zeta(s)}=\sum_{n \geq 1} \frac{w(n ; f)}{n^{s}}
$$

Proposition 9 Let $f \in D$, and let $F(s)$ be the Dirichlet series of $f$. The Dirichlet series $F(s) / \zeta(s)$ is absolutely convergent if $\sigma>3 / 2$, and convergent if $\sigma \geq 1$.

## Proof

The Dirichlet series $F(s)$ converges for $\sigma>1$, and converges absolutely for $\sigma>3 / 2$ (Proposition 8). The Dirichlet series $1 / \zeta(s)$ converges absolutely for $\sigma>1$. The Dirichlet product $F(s) / \zeta(s)$ thus converges absolutely for $\sigma>3 / 2$, and converges for $\sigma>1$.

If $s=1$, the series is convergent by Proposition 7. Since the function $F(s) / \zeta(s)$ is holomorphic in the closed half-plane $\sigma \geq 1$, Riesz' convergence theorem applies again to ensure convergence on the line $\sigma=1$.

## 4 Báez-Duarte's criterion for the Riemann hypothesis

We now define

$$
\mathscr{B}=\operatorname{Vect}\left(e_{n}, n \in \mathbb{N}^{*}\right) \quad ; \quad \mathscr{B}_{0}=\operatorname{Vect}\left(e_{n}-e_{1} / n, n \in \mathbb{N}^{*}, n \geq 2\right)
$$

Since $e_{n} \in D$ and $e_{n}-e_{1} / n \in D_{0}$ for all $n \in \mathbb{N}^{*}$, one sees that

$$
\overline{\mathscr{B}} \subset D \quad ; \quad \overline{\mathscr{B}_{0}} \subset D_{0} \quad ; \quad \overline{\mathscr{B}_{0}}=\overline{\mathscr{B}} \cap D_{0}
$$

The subspace $\overline{\mathscr{B}}$ is the (non orthogonal) direct sum of $\operatorname{Vect}\left(e_{1}\right)$ and $\overline{\mathscr{B}_{0}}$.
We will consider the orthogonal projection $\widetilde{\chi}$ (resp. $\widetilde{\chi}_{0}$ ) of $\chi$ on $\overline{\mathscr{B}}$ (resp. $\overline{\mathscr{B}_{0}}$ ). In 2003, BáezDuarte gave the following criterion for the Riemann hypothesis.

Proposition 10 The following seven assertions are equivalent.
(i) $\overline{\mathscr{B}}=D \quad ; \quad(i)_{0} \quad \overline{\mathscr{B}_{0}}=D_{0}$
(ii) $\chi \in \overline{\mathscr{B}} \quad ; \quad(\text { ii })_{0} \quad \chi \in \overline{\mathscr{B}_{0}}$
(iii) $\quad \widetilde{\chi}=\chi \quad ; \quad(i i i)_{0} \quad \tilde{\chi}_{0}=\chi$
(iv) the Riemann hypothesis is true.

In fact, Báez-Duarte's paper [2] contains the proof of the equivalence of (ii) and (iv) ; the other equivalences are mere variations. The statements $(i)_{0},(i i)_{0}$ and $(i i i)_{0}$ allow one to work in the sequence space $\mathfrak{h}$ instead of the function space $H$; see [3] for an exposition in this setting.

The main property of Dirichlet series of elements of $\overline{\mathscr{B}}$ is given in the following proposition.
Proposition 11 If $f \in \overline{\mathscr{B}}$, the Dirichlet series $F(s) / \zeta(s)$ has a holomorphic continuation to the halfplane $\sigma>1 / 2$.

Proof
Write $f=\lambda e_{1}+h$, with $\lambda \in \mathbb{R}$ and $h \in D_{0}$. If $h=0$, one has $F=-\lambda \zeta$ and the result is true.
Now suppose $\lambda=0$. The function $h$ is the limit in $H$ of finite linear combinations, say $h_{j}(j \geq 1)$, of the $e_{k}-e_{1} / k(k \geq 2)$, when $j \rightarrow \infty$. The Dirichlet series of $e_{k}-e_{1} / k$ is

$$
\left(k^{-1}-k^{-s}\right) \zeta(s)
$$

so that the result is true for each $h_{j}$. It remains to see what happens when one passes to the limit.
By the relation between the Dirichlet series of $h_{j}$ and the Mellin transform of $h_{j}$, one sees that the Mellin transform of $h_{j}$ must vanish at each zero $\rho$ of $\zeta$ in the half-plane $\sigma>1 / 2$, with a multiplicity no less than the corresponding multiplicity of $\rho$ as a zero of $\zeta$. Thus

$$
\begin{equation*}
\int_{1}^{\infty} h_{j}(t) t^{-\rho-1} \ln ^{k} t d t=0 \tag{11}
\end{equation*}
$$

for every zero $\rho$ of the Riemann zeta function, such that $\Re \rho>1 / 2$, and for every non-negative integer $k$ smaller than the multiplicity of $\rho$ as a zero of $\zeta$. When $j \rightarrow \infty$, one gets (11) with $h_{j}$ replaced by $h$, which proves the result for $h$.

One combines the two cases, $h=0$ and $\lambda=0$, to obtain the statement of the proposition.

## 5 The $v$ function

### 5.1 Weingartner's form of Báez-Duarte's criterion

For $N \in \mathbb{N}^{*}$, we will consider the orthogonal projections of $\chi$ on the subspaces $\operatorname{Vect}\left(e_{1}, \ldots, e_{N}\right)$ and $\operatorname{Vect}\left(e_{2}-e_{1} / 2, \ldots, e_{N}-e_{1} / N\right)$ :

$$
\begin{align*}
\chi_{N} & =\sum_{k=1}^{N} c(k, N) e_{k}  \tag{12}\\
\chi_{0, N} & =\sum_{k=2}^{N} c_{0}(k, N)\left(e_{k}-e_{1} / k\right) \tag{13}
\end{align*}
$$

thus defining the coefficients $c(k, N)$ and $c_{0}(k, N)$. In [8], Weingartner gave a formulation of BáezDuarte's criterion in terms of the coefficients $c_{0}(k, N)$ of (13). The same can be done with the $c(k, N)$ of (12). First, we state a basic property of these coefficients.

Proposition 12 For every $k \in \mathbb{N}^{*}$, the coefficients $c(k, N)$ in (12) and $c_{0}(k, N)$ in (13) (here, with $k \geq 2$ ) converge when $N$ tends to infinity.

## Proof

With the notations of $\S 4$,

$$
\begin{aligned}
\widetilde{\chi} & =\lim _{N \rightarrow \infty} \chi_{N} \\
\widetilde{\chi}_{0} & =\lim _{N \rightarrow \infty} \chi_{0, N}
\end{aligned}
$$

where the limits are taken in $H$.
Using the identity (6), we observe that, for every $N \in \mathbb{N}^{*}$,

$$
\begin{aligned}
c(k, N) & =-w\left(k ; \chi_{N}\right) \\
c_{0}(k, N) & =-w\left(k ; \chi_{0, N}\right) \\
& (k \geq 2)
\end{aligned}
$$

Therefore, Proposition 4 yields, for every $k$,

$$
\begin{array}{cl}
c(k, N) & \rightarrow-w(k ; \widetilde{\chi}) \quad(N \rightarrow \infty) \\
c_{0}(k, N) & \rightarrow-w\left(k ; \widetilde{\chi_{0}}\right) \\
& (N \rightarrow \infty) .
\end{array}
$$

Definition 1 The arithmetical functions $v$ and $v_{0}$ are defined by

$$
\begin{aligned}
v(n) & =w(n ; \widetilde{\chi}) \\
v_{0}(n) & =w\left(n ; \widetilde{\chi_{0}}\right) .
\end{aligned}
$$

Note that

$$
v_{0}(1)=\lim _{N \rightarrow \infty} \sum_{2 \leq k \leq N} \frac{c_{0}(k, N)}{k}=-\sum_{k \geq 2} \frac{v_{0}(k)}{k},
$$

by Proposition 7.
We can now state Báez-Duarte's criterion in Weingartner's formulation.
Proposition 13 The following assertions are equivalent.
(i) $\quad v=\mu$
(ii) $v_{0}=\mu$ on $\mathbb{N}^{*} \backslash\{1\}$
(iii) the Riemann hypothesis is true.

## Proof

By Báez-Duarte's criterion, (iii) is equivalent to $\chi=\widetilde{\chi}$. By Proposition 1, this is equivalent to $w(n ; \chi)=w(n ; \widetilde{\chi})$ for all $n \geq 1$, that is, $\mu=v$.

Similarly, (iii) implies $\mu=v_{0}$. Conversely, if $\mu(n)=v_{0}(n)$ for all $n \geq 2$, then $w\left(n ; \chi-\widetilde{\chi}_{0}\right)=0$ for $n \geq 2$, which means that $\chi-\widetilde{\chi}_{0}$ is a scalar multiple of $e_{1}$. This implies $\chi=\widetilde{\chi}_{0}$ since $\chi$ and $\widetilde{\chi}_{0}$ belong to $D_{0}$.

### 5.2 The Dirichlet series $\sum_{n} v(n) n^{-s}$

Since $v(n)=w(n ; \widetilde{\chi})$, the following proposition is a corollary of Propositions 9 and 11 .
Proposition 14 The Dirichlet series

$$
\sum_{n \geq 1} \frac{v(n)}{n^{s}}
$$

is absolutely convergent for $\sigma>3 / 2$, convergent for $\sigma \geq 1$, and has a holomorphic continuation to the half-plane $\sigma>1 / 2$.

## 6 Questions

Here are three questions related to the preceding exposition.
Question 1 Is it true that $\widetilde{\chi}=\widetilde{\chi}_{0}$ ?
Question 2 Let $f \in D$ such that the Dirichlet series $F(s) / \zeta(s)$ has a holomorphic continuation to the half-plane $\sigma>1 / 2$. Is it true that $f \in \overline{\mathscr{B}}$ ?

A positive answer would be a discrete analogue of Bercovici's and Foias' Corollary 2.2, p. 63 of [4].
Question 3 Is the Dirichlet series

$$
\sum_{n \geq 1} \frac{v(n)}{n^{s}}
$$

convergent in the half-plane $\sigma>1 / 2$ ?
Another open problem is to obtain any quantitative estimate beyond the tautologies $\left\|\tilde{\chi}-\widetilde{\chi}_{N}\right\|=o(1)$ and $\left\|\widetilde{\chi}_{0}-\widetilde{\chi}_{0, N}\right\|=o(1)(N \rightarrow \infty)$.

## Appendix : some computations

## Scalar products

1. One has

$$
\begin{equation*}
\left\langle e_{1}, \varepsilon_{k}\right\rangle=\sqrt{k(k+1)} \int_{k}^{k+1}(t-k) \frac{d t}{t^{2}}=\sqrt{k(k+1)}(\ln (1+1 / k)-1 /(k+1)) \tag{14}
\end{equation*}
$$

2. For $k \in \mathbb{N}^{*}$, one has

$$
\begin{aligned}
\left\langle e_{1}, \varphi_{k}\right\rangle & =\int_{k-1}^{k} k(k-1)(t-k+1) \frac{d t}{t^{2}}-\int_{k}^{k+1} k(k+1)(t-k) \frac{d t}{t^{2}} \\
& =2 k^{2} \ln k-k(k-1) \ln (k-1)-k(k+1) \ln (k+1)+1 \\
& =-\omega(1 / k)
\end{aligned}
$$

where

$$
\begin{aligned}
\omega(z) & =z^{-2}((1-z) \ln (1-z)+(1+z) \ln (1+z))-1 \\
& =\sum_{j \geq 1} \frac{z^{2 j}}{(j+1)(2 j+1)} \quad(|z| \leq 1)
\end{aligned}
$$

3. For $n \in \mathbb{N}^{*}$, one has

$$
\begin{aligned}
\left\langle e_{1}, f_{n}\right\rangle & =\sum_{k \mid n} \mu(n / k)\left\langle e_{1}, \varphi_{k}\right\rangle=-\sum_{k \mid n} \mu(n / k) \omega(1 / k) \\
& =-\sum_{j \geq 1} \frac{\sum_{k \mid n} \mu(n / k) k^{-2 j}}{(j+1)(2 j+1)}=-\sum_{j \geq 1} \frac{n^{-2 j} \prod_{p \mid n}\left(1-p^{2 j}\right)}{(j+1)(2 j+1)} .
\end{aligned}
$$

In particular,

$$
\sup _{n \in \mathbb{N}^{*}}\left|\left\langle e_{1}, f_{n}\right\rangle\right|=\sum_{j \geq 1} \frac{1}{(j+1)(2 j+1)}=\ln 4-1
$$

## Projections

By (14), the orthogonal projection $e_{1}^{\prime}$ of $e_{1}$ on $D_{0}$ is

$$
e_{1}^{\prime}=\sum_{k \geq 1}\left\langle e_{1}, \varepsilon_{k}\right\rangle \varepsilon_{k}=\sum_{k \geq 1} \sqrt{k(k+1)}(\ln (1+1 / k)-1 /(k+1)) \varepsilon_{k} .
$$

Since $e_{1}^{\prime}(k)$ has limit $1 / 2$ when $k$ tends to infinity, one sees that $e_{1}-e_{1}^{\prime}$ "interpolates" between the fractional part (on $[0,1[$ ) and the first Bernoulli function (at infinity). One has the hilbertian decomposition

$$
D=D_{0} \oplus \operatorname{Vect}\left(e_{1}-e_{1}^{\prime}\right)
$$

Since $\kappa \perp D_{0}$ and $\left\langle\kappa, e_{1}\right\rangle=1$, the orthogonal projection of $\kappa$ on $D$ is

$$
\kappa^{\prime}=\frac{e_{1}-e_{1}^{\prime}}{\left\|e_{1}-e_{1}^{\prime}\right\|^{2}}
$$
