Organocatalytic Enantioselective Synthesis of Tetrahydropyridines

Abstract: Tetrahydropyridines are important heterocycles present in many molecules of natural and non-natural origins that exhibit a wide array of biological activities. With several spi-hybridized carbon atoms in their structure, they often include one or several stereogenic centers, whose control represents a great synthetic challenge. For the past two decades, enantioselective organocatalysis has developed as a very powerful strategy to perform the synthesis of enantioenriched compounds, including heterocycles. In this Microreview, we wish to provide the readers with a general overview about the organocatalytic strategies that have been used to achieve the preparation of diversified families of tetrahydropyridines, thereby providing elements of reflection for further developments.

1. Introduction

1.1. Significance of tetrahydropyridines

Nitrogen-containing heterocycles are among the most common structural motifs in bioactive compounds.^[1] Among them, six-membered rings containing a nitrogen atom as the single heteroatom lead the dance, with piperidine and pyridine ranking at the first two positions for their frequency among U.S. FDA approved pharmaceuticals. Between these two extreme oxidation levels, partially saturated congeners, i.e. dihydro- and tetrahydropyridines (DHPs and THPs, respectively) and their

fused derivatives, also exhibit interesting bioactivities. The different regioisomers of the THP motif can be found in a large variety of natural and non-natural organic molecules of moderate to very high complexity, several of them being of industrial relevance.[2] A non-exhaustive list is presented below (Figure 1). Both 1-(1,4,5,6-tetrahydropyridin-2-yl)ethanone 1[3] and betanin 2⁽⁴⁾ are used in food industry, as aroma and dye, respectively. (E)-Pandamarilactonine-32 3 is an alkaloid obtained from Pandanus amaryllifolius, whose extracts have been used as flavors but also in traditional medicine in Southeast Asia, because of their antioxidant, antibiofilm, and anti-inflammatory activities. [5] Moreover, the THP ring can also be part of complex fused polycyclic architectures such as in pauciduridine 4, extracted from Kopsia pauciflora, a tree found in Malaysian Borneo that produces a variety of indolic alkaloids with pluripotent inhibitory activities against human cancer cell lines. [5] Purely synthetic THPs are also of great interest. For example, compound 5 bearing a THP ring attached to a pyrrole nucleus can act as an anti-inflammatory agent with superior activities compared to the corresponding piperidine and pyridine analogues.[7] To finish with, ester 6 behaves as an antagonist for Ms muscarinic acetylcholine receptor, a potential target for the treatment of drug abuse,[8] whereas N-tosyl THP 7 is a reversible inhibitor of plateletactivating factor acetylhydrolases, thereby causing the death of cancer cells.[9]

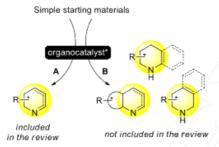
Since both DHPs and THPs non-planar rings comprise Csp3 carbon atoms, many of them are chiral. Of course, their biological activities depend on the absolute and relative configurations of their stereogenic elements, rendering necessary the development of methods to control them. Over the past twenty years or so, organocatalysis, that is to say the use of small organic molecules able to catalyze transformations, has emerged as an extremely powerful strategy to achieve stereocontrol.[10] Through a variety of activation modes involving covalent and/or non-covalent interactions with their substrates, organocatalysts can decrease the activation barriers of transformations while tightly controlling the position of the reaction partners in the transition state of the enantiodiscriminating step.[11] Moreover, since they obviate the use of transition metals and are often tolerant towards water, oxygen and many functional groups, organocatalysts are easy to handle and interesting tools in the context of green chemistry. More specifically, organocatalysis is an especially efficient tool for the preparation of nitrogen-containing heterocycles.[12] If the application of enantioselective organocatalysis to the synthesis of 1,4-DHPs has been recently reviewed,[13] there is no comprehensive discussion on the preparation of the related enanticenriched THPs.[2]

1.2. Scope and organization of the review

In this review, we aim at providing the readers with an overview of the synthetic strategies that exist to prepare chiral enantioenriched THPs from simple starting materials in the

presence of a chiral organocatalyst. Numerous disconnections and activation strategies exist and they deliver different regioisomers depending on the position of the double bond. It appeared to us that the enantiodiscriminating step involved in the construction of the THP ring is the key event in the process and we selected this criterion to sort the transformations (Scheme 1A). We put 1,2-additions on the one hand and 1,4-additions on the other hand. In the former section, the reactions are sorted based on the nature of the nucleophile, whereas we found it clearer to organize the second section depending on the nature of the electrophile.

There exist also reactions where the organocatalyst controls stereogenic elements at the periphery of the THP rather than within the ring (Scheme 1B).^[14] Moreover, numerous organocatalytic transformations allow the preparation of fused polycyclic systems, where the double bond of the six-membered nitrogen heterocycle is shared with a carbocyclic or heterocyclic aromatic ring (tetrahydroquinolines, tetrahydro-β-carbolines, etc.).^[15] For the sake of clarity and conciseness, those transformations will not be discussed in this review

2. 1,2-Additions

2.1. Additions of enolates and related species

The Mannich reaction that consists in the addition of an enol or enolate to an imine is one of the most useful transformations, not only in organic synthesis in general, but also more specifically in organicallysis. [16] The first strategy to attain THPs via a Mannich reaction was to use 1,5-dialdehydes synthetic equivalents in the presence of proline derivatives. In 2008, Xu and co-workers showed that inexpensive aqueous tetrahydro-2*H*-pyran-2,6-diol (8) could interact with (S)-proline (I) to afford an intermediate enamine able to trap diversely substituted *N*-(*p*-methoxyphenyl)aldimines 9 (Scheme 2).^[17] The initial Mannich reaction is followed by hemiaminal formation and dehydration to afford 1,2,3,4-THPs 10 in moderate yields but with complete diastereoselectivities and very high enantiomeric excesses. Notably, catalysts that do not bear an acidic proton failed to provide the product, pointing towards a bifunctional activation mode where the carboxylic acid function interacts with the

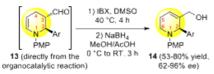
nitrogen atom of the imine. The aldimines obtained from enals or aliphatic aldehydes performed very poorly compared to their aromatic congeners.

Further studies showed that silylated *N*-sulfonyl-4-hydroxyprolinamide II was also a potent catalyst to achieve the same transformation starting from ethyl glyoxylate-derived imine 11 to afford 1,2,3,4-THP 12 with similar results (Scheme 3). [18] It should be noted that NaHCO₃ as an additive led to a dramatic increase of the enantioselectivity.

A third study using this strategy showed that the reaction could be conveniently carried out with *in situ* formation of the imine from the aldehyde and the amine. [10] Interestingly the 1,2,3,4-THP 13 obtained initially could be converted into the corresponding 1,2,5,6-THP 14 via a one-pot oxidation-reduction sequence (Scheme 4). These compounds could then serve as intermediates for the synthesis of several biologically active nitrogen-containing heterocycles.

There exists also other possibilities of combination of an aldehyde, an amine and a third partner in the presence of an organocatalyst to prepare chiral enanticenriched THPs. [20] Two molecules of linear β-ketoesters 16, two molecules of formaldehyde (15) and substituted anilines 17 could assemble in a pseudo-five-component reaction, in the presence of proline I to deliver 1,4,5,6-THPs 18 in moderate yields and enantiomeric excesses, the absolute configuration of which has not been determined (Scheme 5).[21] The authors claim that the enantioselective step consists in the addition of a chiral but not configurationally stable proline-derived enamine to the imine.

A similar combination of starting materials, with aromatic aldehydes 19 replacing formaldehyde, in the presence of phosphoric acids III or IV could delivered highly substituted 1,2,5,6-THPs 20 with very good enantomeric excesses (Scheme 6). [22] Both reaction intermediates involved in the stereodetermining step could be isolated from reactions that did not reach full conversion and allowed to propose a detailed mechanism, where the catalyst acts in a bifunctional fashion by protonating the imine and interacting with the enamine hydrogen atom, thereby increasing its nucleophilicity. [21b] The authors of this study could also show that lower enamticselectivity was observed when the reaction was carried out in a stepwise fashion instead of the multicomponent protocol, a rather common observation in such transformations. [23]

Enolates can also be generated indirectly in the presence of an organocatalyst and then trap enantioselectively an imine to initiate a cascade towards enantioenriched THPs. The aza-Baylis-Hillman reaction consists in the combination of a Michael acceptor and an imine in the presence of a Lewis basic catalyst.[24] The polyfunctional pyridine V that is flanked with a BINOL unit could control the enantics electivity in the aza-Baylis-Hillman reaction of acrolein (21) with N-tosylaldimines 22 through conjugate addition of the nucleophilic catalyst and creation of a hydrogen-bonding network between the BINOL moiety and the Lewis-basic atoms of the substrates (Scheme 7a).[25] The resulting intermediates could trap a second molecule of acrolein through an aza-Michael addition, and cyclization followed by dehydration afforded 1,2,5,6-THPs 23. Products were isolated in moderate yields and enantiomeric excesses. The reaction could also be performed in a sequential fashion with the replacement of acrolein by methyl vinyl ketone (24) in the aza-Baylis-Hillman reaction. Acrolein (21) was added in a second step in the presence of a substoichiometric amount to DBU to deliver THP products 25 with an additional methyl substituent at position 4 (Scheme 7b). Notably, this modification was also accompanied by a significant improvement of enantiocontrol.

In a similar fashion, allenoates could give rise to vinylogous enolates when they are treated with nucleophilic catalysts. In this way, allenoate 26 could be combined with chiral phosphine VI and the resulting vinylogous enolate could add to saccharin-derived ketimines 27 (Scheme 8). [26] Tautomerism and allylic substitution with expulsion of the catalyst delivered 1,2,5,6-THPs 28 in good yields and moderate to high enantioselectivities.

In a similar fashion to enolizable carbonyl compounds, nitroalkanes can also be deprotonated in a position to afford nucleophilic nitronates. This reactivity was exploited by the group of Dixon in a one-pot synthesis of 1,2,3,4-THPs $30\ \text{from}\ \omega$ nitroalkyne 28 and N-Boc or N-Cbz aldimines 29 (Scheme 9) [27] At first, bifunctional urea catalyst VII could promote an enantioand diastereoselective nitro-Mannich reaction. After the addition of diphenyl phosphate as a quenching additive to neutralize the basic organocatalyst, Echavarren's gold catalyst enabled an intramolecular hydroamination reaction with 6-exo-dig cyclization followed by protodemetallation. The final products were obtained with very high stereoselectivities after migration of the olefin inside the six-membered ring. It should be noted that non-terminal alkynes were compatible with the first step but failed in the cyclization step.

2.2. Additions of electron-rich olefins

Electron-rich olefinic systems are nucleophilic enough to add to imines activated by chiral Brensted acids. If one of these two functionalities is conjugated with an additional alkene that can also participate in the reaction, then it becomes possible to achieve formal (4+2) cycloadditions to obtain enanticenriched THPs. In 2015, Enders and co-workers engaged ethyl glyoxylate imine 11 with different electron-rich dienes 31 in a normal demand Diels-Alder reaction in the presence of BINOL-derived phosphoric acid IX (Scheme 10).^[28]

Original 1,2,3,6-THPs 32 were isolated in rather good yields and stereoselectivites except when the aromatic ring on the diene bore an *ortho* substituent or was replaced by a furan ring.

2.3. Additions of electron-rich aromatic compounds

The organocatalytic addition of electron-rich aromatic compounds to iminium ions, known as the Pictet-Spengler reaction, is also a possible alternative to prepare enanticenriched THPs, as illustrated by the recent work from the group of You (Scheme 11). [29] Starting from substrate 33a or its homologue 33b in the presence of catalyst X or ent-IX, respectively, cyclization at the position 2 or 3 of the indole could be observed. By this way, both fused 1,4,5,6-THPs 34 and spiro 1,4,5,6-THPs 36 were prepared in high yields and enantiomeric excesses. The electron-withdrawing group on the DHP ring was essential for the reaction sequence and dictated the regionselectivity of the isomerization that occurred at the most electron-rich enamine. Moreover, in the second reaction, Hantzsch ester 35 was added to reduce the intermediate cyclic imine obtained after spirocyclization.

2.4. Additions of hydrides

An intuitive synthetic pathway towards enantioenriched THPs is to achieve an enantioselective reduction of DHPs. In 2008, Rueping and Antonchick combined enamines 38 flanked with an electron-withdrawing group at the β position with enones 37 in the presence of Brønsted acid IX (Scheme $12)^{120}$). The intermediate DHPs then underwent profonation from the catalyst to deliver the intermediate iminium ion associated with the chiral conjugated base. Reduction by hydride transfer from Hantzsch ester 35 afforded the 1.4.5.6-THPs 39 with excellent enantiomeric excesses.

3. 1,4-Additions

Conjugate additions are ubiquitous in the literature concerning enantioselective organocatalysis and they can accommodate a very broad variety of substrates and activation modes. For this reason, it is not surprising that conjugate additions to imines, carbonyl compounds and nitroolefins have developed as one of the most popular strategies to prepare enantioenriched THPs.

3.1. Additions to imines

α,β-Unsaturated imines can furnish four atoms to be integrated within the THP structure. In 2009, the group of Chen showed that they could be intercepted in a domino sequence by aldehydes under secondary amine catalysis. Dienamine formation from enals 40 combined with Hayashi-Jørgensen catalyst XI and conjugate addition to q.B-unsaturated N-tosylimine 41 was followed by trapping of the aldehyde function by the nucleophilic nitrogen atom to afford 5-alkenyl-6-hydroxy-1,4,5,6-THP 42 (Scheme 13a).^[31] Almost complete a/y regioselectivity was obtained during the dienamine addition and extremely high enantioselectivities (>97% ee) were observed throughout the whole substrate scope. On the contrary, MacMillan-type catalyst oriented the reactivity towards the y position but with moderate stereoselectivities. For some examples, PCC oxidation of 42 into the corresponding lactam was necessary to allow complete characterization of the products. Two years later, the same group showed that aldehydes 43 bearing a suitably positioned electronrich (hetero)aromatic ring could participate in the reaction (Scheme 13b).[32] Dehydration followed by Friedel-Crafts-type trapping of the iminium ion delivered bicyclic 1,4,5,6-THPs 44 with excellent yields and stereoselectivities. The linker X-Y could be composed only of carbon atoms or different heteroatoms (O, S, NR).

Following their initial work on inverse-electron-demand Diels-Alder reaction that afforded tetrahydroquinolines, $^{\rm Fid.49}$ the group of Masson proposed another retrosynthesis that opened a synthetic route towards 6-amino-1,4,5,6-THPs 47 from *N*-alkenylcarbamates 45 and α,β -unsaturated *N*-arylimine 46 in the presence of TRIP catalyst XII (Scheme 14). $^{\rm (23)}$ Products were

obtained with very good diastereo- and enanticselectivities and the mechanism is likely to proceed in a concerted fashion, with the catalyst acting in a bifunctional manner: protonation of the imine to increase its electrophilicity and deprotonation of the enamine to make it more nucleophilic.

3.2. Additions to carbonyl compounds

In addition to α,β -unstaturated imines, α,β -unstaturated carbonyl compounds can also participate in organocatalytic enantioselective 1,4-additions. Interestingly, they can combine with aminocatalysts to furnish intermediate α,β-unstaturated iminium ions that can be trapped by nucleophiles such as enamines. In 2008, Yu, Wang and co-workers developed a formal (4+2) cycloaddition between N-alkenyl acetamides 48 and cinnamaldehydes 49 in the presence of proline-derived catalyst XI and benzoic acid as co-catalyst (Scheme 15a).[34] 2-Hydroxy-1,2,3,4-THPs 50 were formed in moderate to good yields and hydrolyzed by treatment with iron(III) chloride hydrate to allow determination of the enantiomeric excess (90-97% ee) on 5oxoaldehydes 51. A few years later, the group of Enders extended this reactivity pattern to enaminoketones 52 to prepare 6-hydroxy-1,4,5,6-THPs 53 in moderate yields and diastereoselectivities, but with enantiomeric excesses that could be very high for some examples (Scheme 15b).[35]

HydroxyTHPs can dehydrate to furnish the corresponding iminium ions, whose interception by nucleophiles has been well

documented. In 2010, Wu, Cao, Zhao and co-workers illustrated this strategy by mixing acetoacetates 55 with diversely substituted enals 54 (R3 being a alkyl chain, an aromatic ring or an ester) in the presence of proline-derived catalysts XI or XIII, followed by the addition of tryptamine derivatives 56 (Scheme 16a).[36] the overall Michael addition-iminium ion formation-Pictet-Spengler cyclization sequence delivered the 1,4,5,6-THPs 57 as single diastereomers in good yields and moderate to high enantioselectivities. Shortly after, the same authors prepared similar products 57 lacking the substituent R1 via a two-step sequence involving an aza-Michael addition of 56 to propiolate 59 followed by the organocatalyzed sequence with the resulting enaminoester and β-alkylenals 58 (Scheme 16b).[37] The former reactivity pattern could also then be extended to cyclic βdiketones as illustrated by the same group and Rueping and co-workers.[38] To finish with, attempts to introduce a chiral phosphoric acid as the catalyst in the Michael addition-Pictet-Spengler sequence with tryptamine was less successful, with only 49% ee.[39]

In 2014, our group showed that it is possible to replace the indole moiety by a pyrrole ring as the nucleophile in the Pictet-Spengler cyclization (Scheme 17). [40] /h/(2-aminoethyl)pyrroles 60 delivered the expected 1,4,5,6-THPs 61 in moderate yields without diastereocontrol. However, the two diastereomers could generally be separated and were formed with high enantiomeric excesses. It is worth noting that the reaction could be carried out in a multicomponent fashion and that the higher nucleophilicity of the pyrrole ring compared to the indole obviated the use of an acid to achieve the Pictet-Spengler cyclization.

In addition to electron-rich aromatic rings, the iminium ion formed after the initial Michael addition of pronucleophiles such as β-cyclohexadiones 62 could also be trapped by heteroatoms. A few examples were reported by Rueping and co-workers using 2-aminomethylaniline 63a and anthranilic acid 63b to deliver the tetracyclic 1,4,5,6-THPs 64a-b with good yields and nearly perfect stereoselectivities (Scheme 18). ^[388]

All the reactions discussed in this sub-section afforded the same regioisomer with the intracyclic enamine being conjugated with a carbonyl function. In 2015, our group tried to reverse the

regioselectivity by using tertiary β -ketoamides 65 as pronucleophiles in the Michael addition to destabilize the conjugated enamine because of the added steric interaction brought about by the amide function (Scheme 19). With aromatic enals 54 as electrophiles and 2-aminophenols 66 as the third reaction partner, 1,2,3,4-THPs 67 were formed in moderate yields, notably better with more activated Weinreb β -ketoamides, $^{(42)}$ but with very high stereoselectivities.

Other modes of activation have been more sporadically used for the preparation of enanticenriched THPs from α,β -unsaturated compounds. When enals are replaced by activated enones, iminium ion activation is outcompeted by hydrogen-bonding activation. The group of Shi could combine cyclic diketones 62, β,γ -unsaturated-o-ketoesters 68 and substituted benzylamines 69 in the presence of bifunctional squaramide catalyst XIV (Scheme 20). $^{(43)}$ This species can activate at the same time the diketone by deprotonation and the Michael acceptor by hydrogenbonding. The addition of DBU was able to promote a transamination-hydrolysis sequence, explaining why the N-unsubstituted 1,4.5.6-THPs 70 were obtained.

The last reaction that can be placed in this sub-section consists in the addition of enolizable aldehydes 71 to alkylideneindolinones 72 in the presence of catalyst XI to deliver an open chain synthetic intermediate (Scheme 21), [52]
Subsequent introduction of 3,4-dihydroisoquinoline 73 and

DABCO could promote a cascade Mannich-enamine formation to afford spirocyclic 1,2,3,4-THP **74**.

3.3. Additions to nitroolefins

Nitroolefins are exceptionally efficient Michael acceptors for enanticiselective organocatalysis and these transformations can serve as the starting point to prepare enanticenriched THPs. The group of Sun and Lin published a couple of studies where nitroolefins 75 were at first combined with enolizable aldehydes 71 in the presence of secondary amine XI and 4-nitrophenol 76 as co-catalyst (Scheme 22).^[43] In a second time, an aza-Henry reaction followed by cyclization delivered the 1,2,3,4-THPs 79a,b. In the first case, the imine engaged in the aza-Henry reaction catalyzed by XV was produced in situ by adding an amine 77 that combines with the excess aldehyde. In the second case, an external cyclic ketimine 78 was added together with a stoichiometric amount of DIPEA. In both transformations, the products were obtained in excellent diastereo- and enanticselectivities.

A similar strategy has been exploited by the group of Enders, but with 1,3-dicarbonyl compounds 80 as pronucleophiles and 0,5 mol% of Rawal's squaramide XVI as catalyst (Scheme 23) $^{(46)}$ After the addition of aldimines 81, 1,2,4,3-THPs 82 were obtained with variable diastereoselectivities but uniformly high enantioselectivities.

4. Conclusion and Perspective

In summary, we have presented a general overview of the organocatalytic synthetic methods that allow the preparation of diversely functionalized regioisomers of enantioenriched tetrahydropyridines. Both 1,2- and 1,4-additions are equally represented as the key enantioselective step, in combination with all the most common activation modes of organocatalysis. Many

of those transformations allowed to reach high levels of regio- and stereocontrol.

However, compared to the diversity of functions that could potentially be installed on the different positions of the THP ring, we feel like there is still a rather large unexploited potential of innovative development and we can expect that this review could help to draw the attention of more research groups to this inspiring family of synthetic targets.
