

Explicit H^1 -estimate for the solution of the Lamé system with mixed boundary conditions.

Abstract

In this paper we consider the Lamé system on a polygonal convex domain with mixed boundary conditions of Dirichlet-Neumann type. An explicit L^2 norm estimate for the gradient of the solution of this problem is established. This leads to an explicit bound of the H^1 norm of this solution. Note that the obtained upper-bound is not optimal.

1 Introduction

Let Ω be a bounded open connected subset of \mathbb{R}^2 . The static equilibrium of a deformable structure occupying Ω is governed by the Lamé linear elastostatic system, see [6]. In this paper, we restrict the study to a convex domain Ω whose boundary has a polygonal shape that posses $m + 1$ edges with $m \geq 2$. We denote $\Gamma = \cup_{i=0}^m \Gamma_i$ its boundary and $d(\Omega)$ its diameter. Moreover, we assume that all the edges Γ_i have strictly positive measure. This system is given by

$$\begin{cases} Lu = f & \text{a.e in } \Omega, \\ \sigma \cdot \vec{n}_i = g_i & \text{on } (\Gamma - \Gamma_0) \cap \Gamma_i, \quad 1 \leq i \leq m \\ u = 0 & \text{on } \Gamma_0. \end{cases} \quad (1)$$

We need to assume that the edges Γ_i of the boundary Γ fulfill a condition similar to (H_2) of Theorem 2.3 stated in the paper [10]. Actually, for our purpose, a stronger condition is needed and it is formulated in (5)

below. The vector function $u = (u^1, u^2)$ satisfying the system (8) describes a displacement in the plane. In this model we impose a homogeneous Dirichlet condition on Γ_0 and a Neumann condition on the remaining part of the boundary. The equality on the boundary is understood in the sense of the trace. We denote L the Lamé operator defined by

$$Lu := -\operatorname{div} \sigma(u) = -\operatorname{div}[2\mu\varepsilon(u) + \lambda \operatorname{Tr} \varepsilon(u) Id] \quad (2)$$

We assume the data functions f and g at the right hand sides to satisfy $f \in [L^2(\Omega)]^2$ and $g \in [H^{\frac{1}{2}}(\Gamma - \Gamma_0)]^2$. The vector \vec{n}_i represents the outside normal to Γ_i . We write μ and λ the Lamé's coefficients. We place ourselves in the isotropic framework, the deformation tensor ε is defined by

$$\varepsilon(u) = \frac{1}{2}(\nabla u + \nabla^t u). \quad (3)$$

The weak form of problem (1) is (see [2], [6]):

find $u \in V$; $\forall v \in V$

$$\int_{\Omega} 2\mu\varepsilon(u)\varepsilon(v) + \lambda \operatorname{div} u \operatorname{div} v \, dx = \int_{\Omega} f v \, dx + \int_{\Gamma - \Gamma_0} g v \, d\sigma(x) \quad (4)$$

where

$$V = \{v \in [H^1(\Omega)]^2; \quad v = 0 \quad \text{on} \quad \Gamma_0.\}$$

The existence and uniqueness issue of the solution of (4) in V is classic, (see [2]).

If we denote θ the interior angle between the edges Γ_j and Γ_k , $0 \leq j, k \leq m$ such that $\bar{\Gamma}_j \cap \bar{\Gamma}_k \neq \emptyset$ and if we denote γ the interior angle between the Neumann part of the boundary $\Gamma_N := \Gamma - \Gamma_0$ and the Dirichlet part of the boundary $\Gamma_D := \Gamma_0$, then we impose

$$0 < \theta < \pi, \quad 0 < \gamma < \pi. \quad (5)$$

The reason behind this assumption on the boundary is to get a better regularity of the solution of the weak problem (4). Precisely in that case we have, following theorem 2.3 in [10], bottom of page 330, $u \in [H^{\frac{3}{2}+\nu}(\Omega)]^2$ for some positive ν , which implies in particular, using the appropriate Sobolev embedding and since Ω is a locally Lipschitz domain, (see part II of theorem 4.12 in [1] page 85), that $u \in [C^{0, \frac{1}{2}+\nu}(\bar{\Omega})]^2$ i.e. u is $(\frac{1}{2}+\nu)$ -holder continuous. One should notice that condition (5) are met since the domain considered in our case is convex. Let us denote

$$\|\varepsilon(u)\|_{0,\Omega} := \left(\int_{\Omega} \varepsilon(u)\varepsilon(u) \, dx \right)^{\frac{1}{2}}, \quad \|\nabla u\|_{0,\Omega} := \left(\int_{\Omega} |\nabla u^1|^2 + |\nabla u^2|^2 \, dx \right)^{\frac{1}{2}}.$$

By using the second Korn inequality, see [8], the trace and the Poincaré's inequalities, one easily gets from (4) the following estimate

$$\|\nabla u\|_{0,\Omega} \leq \frac{1}{c_k} \frac{1}{2\mu} (c_p \|f\|_{0,\Omega} + c_{p,t} \|g\|_{\frac{1}{2},\Gamma-\Gamma_0}), \quad (6)$$

where $c_{p,t}$ is a constant that depends of Poincaré constant and the constant of trace inequality. c_k is the constant of the Korn's inequality. Note that the value of the constant c_k and $c_{p,t}$ appearing in (6) are unknown and can not be explicitly lower-bounded in the general case. We propose to determine explicitly these constants. The main result of this work is stated in the following theorem:

Theorem 1. *The unique weak solution u of (4) on the convex polygonal domain Ω admits the explicit upper bound*

$$\|\nabla u\|_{0,\Omega} \leq \frac{1}{\sqrt{\mu}} [1 + d(\Omega) \|f\|_{0,\Omega} + 8(|\Gamma| + \|g\|_{0,\Gamma}^2)], \quad (7)$$

where $d(\Omega)$ represent the diameter of Ω and $|\Gamma|$ the measure of the boundary of Ω .

Estimate (7) is similar to estimate (6) in the sense that the constants appearing there are the same. Before demonstrating this theorem, it is useful to go through some remarks and results. These auxiliary results are needed in order to adequately get a decomposition of the solution of the main problem, which belongs to $H^1(\Omega)$, into functions that are still in $H^{\frac{1}{2}}(\Gamma)$. Denote x_i , for $1 \leq i \leq m$, the vertex of the polygon that connects Γ_{i-1} with Γ_i and x_0 the one that connects Γ_m to Γ_0 . Define the auxiliary function $u_\epsilon \in H^1(\Omega)$ as the unique solution to the following Dirichlet problem

$$\begin{cases} Lu_\epsilon = f & \text{a.e in } \Omega, \\ u_\epsilon = u_\epsilon^d & \text{on } \Gamma, \end{cases} \quad (8)$$

where u_ϵ^d is the trace on the boundary Γ of the function

$$\phi_\epsilon(x)u(x). \quad (9)$$

For $\epsilon \ll \frac{|\Gamma_i|}{2} \forall i$, $0 \leq i \leq m$, the function ϕ_ϵ is defined by

$$\begin{cases} \phi_\epsilon(x) & = 0, & \|x - x_i\| \leq \epsilon^2, & 0 \leq i \leq m; \\ \phi_\epsilon(x) & = \exp\left[-\frac{\epsilon^{\frac{1}{2}}(\epsilon - \|x - x_i\|)}{\|x - x_i\| - \epsilon^2}\right], & \epsilon^2 < \|x - x_i\| < \epsilon, & 0 \leq i \leq m; \\ \phi_\epsilon(x) & = 1, & \epsilon \leq \|x - x_i\|, & 0 \leq i \leq m, \end{cases}$$

let us denote

$$D_{i,\epsilon} := \{x \in \mathbb{R}^2 \text{ such that } \|x - x_i\| < \epsilon^2\}.$$

Where $\|x - x_i\|$ stands for the Euclidean norm of the vector $x - x_i$. We easily see that $\phi_\epsilon \in C^0(\overline{\Omega})$, consequently, there will be no jump when passing to the distributional derivative and thus $\nabla u_\epsilon \in L^2(\Omega)$ and by using the Poincaré inequality we infer that $u_\epsilon \in H^1(\Omega)$. It is shown, using Lebesgue's dominated convergence theorem for instance, that $\|\phi_\epsilon - 1\|_{0,\Gamma_i} \rightarrow 0$ i.e. we have convergence in L^2 along the edge Γ_i . The functions ϕ_ϵ are identically zero on a small neighborhood of the respective vertices of the polygon.

In the sequel, we denote u_ϵ the vector-valued function $u_\epsilon = (u_\epsilon^1, u_\epsilon^2)$.

2 Weak problem for u_ϵ and approximation results

First of all, we construct the weak problem verified by the approximating function u_ϵ . With the approximating displacement $u_\epsilon \in V$ is associated the approximating stress tensor

$$\sigma_\epsilon := 2\mu\varepsilon(u_\epsilon) + \lambda \operatorname{Tr} \varepsilon(u_\epsilon)I, \quad (10)$$

since $Lu_\epsilon = \operatorname{div} \sigma_\epsilon = f$, then $\sigma_\epsilon \in [H(\operatorname{div})(\Omega)]^{2 \times 2}$. For a fixed ϵ , by density of the regular functions in the space $H(\operatorname{div})(\Omega)$, there exists $\sigma_\epsilon^n \in [C^\infty(\overline{\Omega})]^{2 \times 2}$ such that $\sigma_\epsilon^n \rightarrow \sigma_\epsilon$ in $[H(\operatorname{div})(\Omega)]^{2 \times 2}$. This means

$$\|\sigma_\epsilon^n - \sigma_\epsilon\|_{\operatorname{div},\Omega} := \|\operatorname{div} \sigma_\epsilon^n - \operatorname{div} \sigma_\epsilon\|_{0,\Omega} + \|\sigma_\epsilon^n - \sigma_\epsilon\|_{0,\Omega} \rightarrow 0 \quad (11)$$

when $n \rightarrow \infty$. We pose $\operatorname{div} \sigma_\epsilon^n = f^n$, then integrating by part against a test function $v \in [C^\infty(\overline{\Omega})]^2 \cap V$ yields the following

$$\int_{\Omega} \sigma_\epsilon^n \nabla v = \int_{\Omega} f^n v + \int_{\Gamma} \sigma_\epsilon^n \cdot \vec{n} v d\sigma.$$

Passing to the limit in n using (11), we find $\forall v \in [C^\infty(\overline{\Omega})]^2 \cap V$

$$\int_{\Omega} \sigma_\epsilon \nabla v = \int_{\Omega} f v + \langle \sigma_\epsilon \cdot \vec{n}, v \rangle_{[H^{\frac{1}{2}}]'\!(\Gamma - \Gamma_0) \times [H^{\frac{1}{2}}]'\!(\Gamma - \Gamma_0)},$$

where $\sigma_\epsilon \cdot \vec{n} =: g^\epsilon \in [H^{\frac{1}{2}}(\Gamma - \Gamma_0)]'$ is the image of the normal component σ_ϵ by the trace operator on Γ . Since, following theorem 1 established in [5], $[C^\infty(\overline{\Omega})]^2 \cap V$ is a dense subset of $V \subset H^1(\Omega)$, then, according to the definition (3) and the expression (10), the function u_ϵ satisfy

$\forall v \in V$,

$$\int_{\Omega} 2\mu\varepsilon(u_\epsilon)\varepsilon(v) + \int_{\Omega} \lambda \operatorname{div} u_\epsilon \operatorname{div} v = \int_{\Omega} f v + \langle g^\epsilon, v \rangle_{[H^{\frac{1}{2}}]'\!(\Gamma - \Gamma_0) \times [H^{\frac{1}{2}}]'\!(\Gamma - \Gamma_0)}; \quad (12)$$

this is the weak problem satisfied by the approximating function u_ϵ .

Let us recall, (see [9]), that the $H^{\frac{1}{2}}$ -norm in one dimension on Γ_i is defined by:

$$\|u\|_{\frac{1}{2},\Gamma_i} := (\|u\|_{0,\Gamma_i}^2 + \int_{\Gamma_i} \int_{\Gamma_i} \frac{|u(x) - u(y)|^2}{\|x - y\|^2} dx dy)^{\frac{1}{2}}.$$

Remark 2. For any sufficiently small $\epsilon > 0$, it is possible to cover Ω with a collection of open sets $(W_j^\epsilon)_j$ such that for each j , $W_j^\epsilon \cap \Gamma$ is either empty or equals one of the following subsets: for some i , $0 \leq i \leq m-1$

- 1) $\Gamma_i^{1,\epsilon} := \{x \in \Gamma_i; \quad 0 < \|x - x_i\| < 2\epsilon\};$
- 2) $\Gamma_i^{2,\epsilon} := \{x \in \Gamma_i; \quad 0 < \|x - x_{i+1}\| < 2\epsilon\};$
- 3) $\Gamma_i^{3,\epsilon} := \{x \in \Gamma_i; \quad \|x - x_i\| > \frac{3}{2}\epsilon \quad \text{and} \quad \|x - x_{i+1}\| > \frac{3}{2}\epsilon\};$
- 4) $\Gamma_i^{4,\epsilon} = \{x \in \Gamma_i \cup \Gamma_{i+1}; \quad \|x - x_{i+1}\| < \epsilon^2\};$

and for $i = m$

- 1) $\Gamma_m^{1,\epsilon} := \{x \in \Gamma_m; \quad 0 < \|x - x_m\| < 2\epsilon\};$
- 2) $\Gamma_m^{2,\epsilon} := \{x \in \Gamma_m; \quad 0 < \|x - x_0\| < 2\epsilon\};$
- 3) $\Gamma_m^{3,\epsilon} := \{x \in \Gamma_m; \quad \|x - x_m\| > \frac{3}{2}\epsilon \quad \text{and} \quad \|x - x_0\| > \frac{3}{2}\epsilon\};$
- 4) $\Gamma_m^{4,\epsilon} = \{x \in \Gamma_m \cup \Gamma_0; \quad \|x - x_0\| < \epsilon^2\}$

let $(\vartheta_j^\epsilon)_j$, with $\text{supp } \vartheta_j^\epsilon \subset W_j^\epsilon$, a C^1 -partition of unity with respect to this cover; since $\vartheta_j^\epsilon \in H^{\frac{1}{2}}(\Gamma)$ then

$$\begin{aligned} \|\phi_\epsilon - 1\|_{\frac{1}{2},\Gamma} &= \|(\phi_\epsilon - 1) \sum_j \vartheta_j^\epsilon\|_{\frac{1}{2},\Gamma} \\ &\leq \sum_{i=0}^m \|(\phi_\epsilon - 1) \sum_{j, \text{supp } \vartheta_j^\epsilon \subset \Gamma_i} \vartheta_j^\epsilon\|_{\frac{1}{2},\Gamma_i} + \sum_{i=0}^m \|(\phi_\epsilon - 1)\|_{\frac{1}{2},\Gamma_i^{4,\epsilon}} \\ &\leq \sum_{i=0}^m \|\phi_\epsilon - 1\|_{\frac{1}{2},\Gamma_i} + (m+1) \|(\phi_\epsilon - 1)\|_{\frac{1}{2},\Gamma_0^{4,\epsilon}} \\ &= \sum_{i=0}^m \|\phi_\epsilon - 1\|_{\frac{1}{2},\Gamma_i} + (m+1) \|(\phi_\epsilon - 1)\|_{0,\Gamma_0^{4,\epsilon}} \end{aligned} \quad (13)$$

So, using the definition and symmetry of ϕ_ϵ , we get for all $0 \leq i \leq m$

$$\begin{aligned} \|\phi_\epsilon - 1\|_{\frac{1}{2},\Gamma_i} &= \|(\phi_\epsilon - 1) \sum_{j, \text{supp } \vartheta_j^\epsilon \subset \Gamma_i} \vartheta_j^\epsilon\|_{\frac{1}{2},\Gamma_i} \\ &\leq \|(\phi_\epsilon - 1) \sum_{j, \text{supp } \vartheta_j^\epsilon \subset \Gamma_i^{1,\epsilon}} \vartheta_j^\epsilon\|_{\frac{1}{2},\Gamma_i} + \|(\phi_\epsilon - 1) \sum_{j, \text{supp } \vartheta_j^\epsilon \subset \Gamma_i^{2,\epsilon}} \vartheta_j^\epsilon\|_{\frac{1}{2},\Gamma_i} \\ &+ \|(\phi_\epsilon - 1) \sum_{j, \text{supp } \vartheta_j^\epsilon \subset \Gamma_i^{3,\epsilon}} \vartheta_j^\epsilon\|_{\frac{1}{2},\Gamma_i} + 2 \|(\phi_\epsilon - 1)\|_{\frac{1}{2},\Gamma_i^{4,\epsilon}} \end{aligned}$$

thus,

$$\begin{aligned} \|\phi_\epsilon - 1\|_{\frac{1}{2}, \Gamma_i} &\leq \sum_{j=1}^3 \|\phi_\epsilon - 1\|_{\frac{1}{2}, \Gamma_i^{j, \epsilon}} + 2\|\phi_\epsilon - 1\|_{\frac{1}{2}, \Gamma_i^{4, \epsilon}} \\ &= 2\|\phi_\epsilon - 1\|_{\frac{1}{2}, \Gamma_i^{1, \epsilon}} + 2\|\phi_\epsilon - 1\|_{\frac{1}{2}, \Gamma_i^{4, \epsilon}} \end{aligned}$$

thus we have

$$\begin{aligned} \|\phi_\epsilon - 1\|_{\frac{1}{2}, \Gamma_i} &\leq 2\|\phi_\epsilon - 1\|_{0, \Gamma_i^{1, \epsilon}} + 2\left(\int_{\Gamma_i^{1, \epsilon}} \int_{\Gamma_i^{1, \epsilon}} \frac{|\phi_\epsilon(x) - \phi_\epsilon(y)|^2}{\|x - y\|^2} dx dy\right)^{\frac{1}{2}} \\ &\quad + 2\|(\phi_\epsilon - 1)\|_{0, \Gamma_i^{4, \epsilon}}. \end{aligned} \quad (14)$$

Lemma 3. *The functions ϕ_ϵ admit the following limits*

$$\text{for all } 0 \leq i \leq m \quad \|\phi_\epsilon - 1\|_{\frac{1}{2}, \Gamma_i} \rightarrow 0 \quad \text{as } \epsilon \rightarrow 0$$

Proof. If we choose the vertex point x_i as the origin of the \mathbb{R}^2 -orthonormal coordinate system such that Γ_i is supported by the positive half x -axis then the abscissas of $x \in \Gamma_i^{1, \epsilon} \equiv]0, 2\epsilon[$ satisfy

$$\|x - x_i\| = |x| = x.$$

the $H^{\frac{1}{2}}$ -semi-norm of ϕ_ϵ on Γ_i writes

$$|\phi_\epsilon - 1|_{\frac{1}{2}, \Gamma_i}^2 := \int_{\Gamma_i} \int_{\Gamma_i} \frac{|\phi_\epsilon(x) - \phi_\epsilon(y)|^2}{\|x - y\|^2} dx dy. \quad (15)$$

it yields by using the definition of ϕ_ϵ

$$|\phi_\epsilon - 1|_{\frac{1}{2}, \Gamma_i}^2 \leq 2 \int_0^\epsilon \int_0^\epsilon \frac{|\phi_\epsilon(x) - \phi_\epsilon(y)|^2}{|x - y|^2} dx dy. \quad (16)$$

Consider the decomposition of (16) into four partial double integrals

$$1) \int_0^{\epsilon^2} \int_0^{\epsilon^2} \frac{|\phi_\epsilon(x) - \phi_\epsilon(y)|^2}{|x - y|^2} dx dy = 0,$$

this is obvious.

$$2) \int_{\epsilon^2}^\epsilon \int_{\epsilon^2}^\epsilon \frac{|\phi_\epsilon(x) - \phi_\epsilon(y)|^2}{|x - y|^2} dx dy \leq \int_{\epsilon^2}^\epsilon \int_{\epsilon^2}^\epsilon \frac{|\exp[-\frac{\epsilon^{\frac{1}{2}}(\epsilon-x)}{(x-\epsilon^2)}] - \exp[-\frac{\epsilon^{\frac{1}{2}}(\epsilon-y)}{(y-\epsilon^2)}]|^2}{|x - y|^2} dx dy.$$

The function $F(x) := \exp[-\frac{\epsilon^{\frac{1}{2}}(\epsilon-x)}{(x-\epsilon^2)}]$ is $C^1(] \epsilon^2, \epsilon[)$ and thus lipschitz. We have, using the fact that $x \rightarrow F'(x)$ is increasing on $[\epsilon^2, \frac{\epsilon}{2}]$, that

$$|F'(x)| \leq \frac{\epsilon^{\frac{1}{2}}(1-\epsilon)}{\epsilon(\frac{1}{2}-\epsilon)^2} \exp(\frac{-\epsilon^{\frac{1}{2}}}{\frac{1}{2}-\epsilon}) =: L_1,$$

$\forall x \in [\epsilon^2, \frac{\epsilon}{2}]$. On the other hand

$$|F'(x)| \leq \frac{\epsilon^{\frac{1}{2}}}{\epsilon(1-\epsilon)} \exp\left(\frac{2}{1-\epsilon}\right) =: L_2,$$

$\forall x \in [\frac{\epsilon}{2}, \epsilon]$. Therefore we conclude that

$$|F'(x)| \leq L := \max(L_1, L_2) \leq L_1 + L_2$$

for all $x \in [\epsilon^2, \epsilon]$. This yields

$$\begin{aligned} & \left(\int_{\epsilon^2}^{\epsilon} \int_{\epsilon^2}^{\epsilon} \frac{|\phi_{\epsilon}(x) - \phi_{\epsilon}(y)|^2}{|x-y|^2} dx dy \right)^{\frac{1}{2}} \\ & \leq \left(\int_{\epsilon^2}^{\epsilon} \int_{\epsilon^2}^{\epsilon} \frac{\left| \frac{\epsilon^{\frac{1}{2}}}{\epsilon(1-\epsilon)} \exp\left(\frac{2}{1-\epsilon}\right) + \frac{\epsilon^{\frac{1}{2}(1-\epsilon)}}{\epsilon(\frac{1}{2}-\epsilon)^2} \exp\left(\frac{-\frac{\epsilon^{\frac{1}{2}}}{2}}{\frac{1}{2}-\epsilon}\right) \right|^2 |x-y|^2}{|x-y|^2} dx dy \right)^{\frac{1}{2}} \\ & \leq \left(\int_{\epsilon^2}^{\epsilon} \int_{\epsilon^2}^{\epsilon} \left| \frac{\epsilon^{\frac{1}{2}}}{\epsilon(1-\epsilon)} \exp\left(\frac{2}{1-\epsilon}\right) \right|^2 dx dy \right)^{\frac{1}{2}} + \left(\int_{\epsilon^2}^{\epsilon} \int_{\epsilon^2}^{\epsilon} \left| \frac{\epsilon^{\frac{1}{2}(1-\epsilon)}}{\epsilon(\frac{1}{2}-\epsilon)^2} \exp\left(\frac{-\frac{\epsilon^{\frac{1}{2}}}{2}}{\frac{1}{2}-\epsilon}\right) \right|^2 dx dy \right)^{\frac{1}{2}} \\ & \rightarrow 0 \quad \text{as } \epsilon \rightarrow 0. \end{aligned}$$

$$\begin{aligned} 3) & \int_0^{\epsilon^2} \int_{\epsilon^2}^{\epsilon} \frac{|\phi_{\epsilon}(x) - \phi_{\epsilon}(y)|^2}{|x-y|^2} dx dy \\ & \leq \int_0^{\epsilon^2} \int_{\epsilon^2}^{\frac{\epsilon}{2}} \frac{1}{|x-\epsilon^2|^2} \exp^2\left[-\frac{\epsilon^{\frac{1}{2}}(\epsilon-x)}{(x-\epsilon^2)}\right] dx dy + \int_0^{\epsilon^2} \int_{\frac{\epsilon}{2}}^{\epsilon} \frac{1}{|x-\epsilon^2|^2} \exp^2\left[-\frac{\epsilon^{\frac{1}{2}}(\epsilon-x)}{(x-\epsilon^2)}\right] dx dy \\ & \leq \epsilon^2 \int_{\epsilon^2}^{\frac{\epsilon}{2}} \frac{1}{|x-\epsilon^2|^2} \exp^2\left[-\frac{\epsilon^{\frac{1}{2}+1}(1-\epsilon)}{2(x-\epsilon^2)}\right] dx + \epsilon^2 \int_{\frac{\epsilon}{2}}^{\epsilon} \frac{1}{|\frac{\epsilon}{2}-\epsilon^2|^2} \exp^2\left[\frac{\epsilon^{\frac{1}{2}}(2\epsilon)}{(\frac{\epsilon}{2}-\epsilon^2)}\right] dx \\ & \leq \frac{\epsilon^{\frac{1}{2}} \exp\left(-\frac{\epsilon^{\frac{3}{2}}(1-\epsilon)}{x}\right)}{1-\epsilon} \Big|_{x=0}^{x=\frac{\epsilon}{2}} + \frac{1}{(\frac{1}{2}-\epsilon)^2} \frac{\epsilon}{2} \exp^2\left[\frac{2\epsilon^{\frac{1}{2}}}{(\frac{1}{2}-\epsilon)}\right] \\ & \rightarrow 0 \quad \text{as } \epsilon \rightarrow 0, \end{aligned}$$

here we used the properties of the exponential function and elementary majorizations.

$$4) \int_{\epsilon^2}^{\epsilon} \int_0^{\epsilon^2} \frac{|\phi_{\epsilon}(x) - \phi_{\epsilon}(y)|^2}{|x-y|^2} dx dy = \int_{\epsilon^2}^{\epsilon} \int_0^{\epsilon^2} \frac{|\exp\left[-\frac{\epsilon^{\frac{1}{2}}(y-\epsilon)}{(y-\epsilon^2)}\right]|^2}{|x-y|^2} dx \rightarrow 0,$$

proceed in the same way as for 3).

Combining these integrals on one hand and using the facts:

$$\|\phi_{\epsilon} - 1\|_{0,\Gamma} \rightarrow 0 \quad \text{and} \quad 2\|(\phi_{\epsilon} - 1)\|_{0,\Gamma_i^{4,\epsilon}} \rightarrow 0$$

for all $0 \leq i \leq m$ on the other hand yield, using (14), the result of lemma 3. Consequently, using (13), it yields also

$$\|\phi_\epsilon - 1\|_{\frac{1}{2}, \Gamma} \rightarrow 0.$$

□

Since u is $(\frac{1}{2} + \iota)$ -holder continuous and thus uniformly continuous on Ω , the result of lemma (3) implies

$$\|u_\epsilon - u\|_{\frac{1}{2}, \Gamma} \leq \|u(\phi_\epsilon - 1)\|_{\frac{1}{2}, \Gamma} \leq \|u\|_{\infty, \Gamma} \|\phi_\epsilon - 1\|_{\frac{1}{2}, \Gamma} \rightarrow 0.$$

One proves the following approximation lemma:

Lemma 4. *The function u_ϵ defined by (8) and the distribution g^ϵ appearing in problem (12) satisfy respectively the following limits*

$$a) \|\nabla u_\epsilon - \nabla u\|_{0, \Omega} \rightarrow 0, \quad b) \|g^\epsilon - g\|_{[H^{\frac{1}{2}}]', \Gamma - \Gamma_0} \rightarrow 0$$

as $\epsilon \rightarrow 0$.

Proof. a) let us consider the following problem

$$\begin{cases} Lu = 0 & \text{a.e in } \Omega, \\ u = u^d & \text{on } \Gamma. \end{cases} \quad (17)$$

Consider the linear operator G that associates to each $u^d \in H^{\frac{1}{2}}(\Gamma)$ the corresponding unique solution u of problem (17).

$$G : (H^{\frac{1}{2}}(\Gamma), \|\cdot\|_{\frac{1}{2}, \Gamma}) \rightarrow A \subset V, \\ u^d := u|_\Gamma \rightarrow K(u^d) = u.$$

Where $(A, \|\cdot\|_{H^1(\Omega)})$ denote the range of $H^{\frac{1}{2}}(\Gamma)$ under G . The inverse operator G^{-1} identifies with the trace operator applied to $u \in A$ on Γ . This operator is obviously well defined and bijective. Using the trace inequality on Γ , there exists $c > 0$ such that $\forall u \in A$

$$\|G^{-1}u\|_{\frac{1}{2}, \Gamma} := \|u\|_{\frac{1}{2}, \Gamma} \leq c_{-1} \|\nabla u\|_{0, \Omega}$$

this implies the continuity of the linear bijective operator G^{-1} . According to the Banach isomorphism theorem the operator G is continuous, this means that there exists $c > 0$ such that for all $u \in A$ we have

$$\|\nabla u\|_{0, \Omega} \leq c \|u\|_{\frac{1}{2}, \Gamma}$$

thus, since $L(u - u_\epsilon) = 0$ then, using the limit established in lemma (3)

$$\|\nabla u - \nabla u_\epsilon\|_{0,\Omega} \leq c \|u - u_\epsilon\|_{\frac{1}{2},\Gamma} \rightarrow 0, \quad (18)$$

this proves *a*).

b) We Make the same reasoning as for *a*). Given $g \in [H^{\frac{1}{2}}(\Gamma - \Gamma_0)]'$, let $w \in V$ be the unique solution of

$$\int_{\Omega} 2\mu\varepsilon(w)\varepsilon(v) + \lambda \operatorname{div} w \operatorname{div} v \, dx = \langle g, v \rangle_{[H^{\frac{1}{2}}(\Gamma - \Gamma_0)]', H^{\frac{1}{2}}(\Gamma - \Gamma_0)} \quad , \quad (19)$$

for all $v \in V$. Choosing $v = w$, there exists $c' > 0$ such that

$$\|\nabla w\|_{0,\Omega} \leq c' \|g\|_{[H^{\frac{1}{2}}(\Gamma - \Gamma_0)]'}. \quad (20)$$

Let K be the operator that associates to each data $g \in [H^{\frac{1}{2}}(\Gamma - \Gamma_0)]'$ the solution function w of the corresponding problem (19):

$$\begin{aligned} K : [H^{\frac{1}{2}}(\Gamma - \Gamma_0)]' &\rightarrow D \subset V \\ g &\rightarrow K(g) = w. \end{aligned}$$

Where $(D, \|\cdot\|_{H^1(\Omega)})$ denote the range of $[H^{\frac{1}{2}}(\Gamma - \Gamma_0)]'$ under K . Following existence and uniqueness result for problem (19), K is well defined, furthermore it is linear and invertible. An equivalent formulation of (20) is: there exists a constant $c' > 0$ such that $\forall g \in [H^{\frac{1}{2}}(\Gamma - \Gamma_0)]'$, we have

$$\|K(g)\|_{H^1} \leq c' \|g\|_{[H^{\frac{1}{2}}(\Gamma - \Gamma_0)]'}$$

i.e. K is continuous. Then, according to Banach's isomorphism theorem, we deduce that $\exists c'_{-1} > 0$ such that

$$\|g\|_{[H^{\frac{1}{2}}(\Gamma - \Gamma_0)]'} \leq c'_{-1} \|\nabla w\|_{0,\Omega}. \quad (21)$$

Rewriting (4) with $g \in H^{\frac{1}{2}}(\Gamma - \Gamma_0) \equiv D \subset [H^{\frac{1}{2}}(\Gamma - \Gamma_0)]'$ then subtracting (4) and (12) member-to-member, one find that $u - u_\epsilon$ satisfy: $\forall v \in V$,

$$\int_{\Omega} 2\mu(\varepsilon(u_\epsilon) - \varepsilon(u))\varepsilon(v) + \lambda \operatorname{div}(u_\epsilon - u) \operatorname{div} v \, dx = \langle g^\epsilon - g, v \rangle_{[H^{\frac{1}{2}}(\Gamma - \Gamma_0)]', H^{\frac{1}{2}}(\Gamma - \Gamma_0)}.$$

Applying (21) to $w = u_\epsilon - u$ we get:

$$\|g^\epsilon - g\|_{[H^{\frac{1}{2}}(\Gamma - \Gamma_0)]'} \leq c'_{-1} \|\nabla u_\epsilon - \nabla u\|_{0,\Omega}.$$

Considering (18), we infer *b*). □

Remark 5. A consequence of the previous lemma: for arbitrary small $\beta > 0$, there exists $\epsilon_1 > 0$ such that $\forall \epsilon, 0 < \epsilon < \epsilon_1$ we have

$$i) \quad \|g^\epsilon - g\|_{[H^{\frac{1}{2}}(\Gamma - \Gamma_0)]'} \leq \beta, \quad ii) \quad \|\nabla u_\epsilon - \nabla u\|_{0,\Omega} \leq \beta$$

iii) Since by assumption $g \in H^{\frac{1}{2}}(\Gamma - \Gamma_0)$ then, by using the continuity of the canonical embedding

$$I : H^{\frac{1}{2}}(\Gamma - \Gamma_0) \rightarrow L^2(\Gamma - \Gamma_0),$$

we have

$$\|g\|_{0,\Gamma - \Gamma_0} \leq \|g\|_{\frac{1}{2},\Gamma - \Gamma_0}.$$

3 Auxiliary lemmas

Let ϵ_1 be such as defined in remark (5). For the rest of the paper, we fix ϵ , $0 < \epsilon < \epsilon_1$.

Before presenting a proof of the main result, we intend to state two auxiliary lemmas. These lemmas are established using, principally, Theorem 2.1 proved in [11]. In order to apply this later result, assumption 1.2 in that same paper need to be met. Our polygonal domain satisfy very well that assumption.

These lemmas convey the essential idea in the demonstration of the main theorem (1). We begin with approximating the solution u_ϵ of problem (8) by a smooth function vanishing on an adequate part of the boundary Γ . Then the idea is to carry out a particular decomposition, alluded to in the introduction, of this approximating function. This key idea is illustrated in the following example. Consider $v \in V$ to be the solution of a problem similar to (8) e.g.

$$\begin{cases} Lv = f & \text{a.e in } \Omega, \\ v = v^d & \text{on } \cup_i \Gamma_i. \end{cases}$$

We assume that the trace of v on the boundary vanish on an open neighborhood of the vertices of Ω . Set

$$E_i = \{v \in V; \quad v = 0 \quad \text{on } \Gamma_i\}. \quad (22)$$

Let us decompose this problem into two other problems

$$S_1^i \begin{cases} Lv_1^i = f & \text{a.e in } \Omega, \\ v_1^i = v^d & \text{on } \Gamma_i. \\ v_1^i = 0 & \text{on } \cup_i \Gamma_i - \Gamma_i. \end{cases} \quad S_2^i \begin{cases} Lv_2^i = f & \text{a.e in } \Omega, \\ v_2^i = 0 & \text{on } \Gamma_i. \\ v_2^i = v^d & \text{on } \cup_i \Gamma_i - \Gamma_i. \end{cases}$$

Provided that the problems are well posed, the functions v_1^i and v_2^i are well defined. On the other hand, it is easy to see that $v_1^i = v$ on Γ_i does not generally imply $\sigma(v_1^i) \cdot n = \sigma(v)$ on Γ_i . So the idea is to find a decomposition that makes such a property to be fulfilled. i.e. such that v_1^i can be approximated by a function $v_1^{i,n}$ and such that $\sigma(v_1^{i,n}) \cdot n$ is an approximation of $\sigma(v_1^i)$ on Γ_i in the sense of trace. An adequate use of Theorem 2.1 proved in [11] can make this decomposition possible.

Using theorem 1 established in [5], we can find $(u_\epsilon^p)_p \in C^\infty(\overline{\Omega})$ such that for each p , u_ϵ^p vanishes on the same part of Γ where does u_ϵ and such that

$$\|\nabla u_\epsilon^p - \nabla u_\epsilon\|_{0,\Omega} \rightarrow 0 \quad \text{as } p \rightarrow \infty. \quad (23)$$

If we denote

$$f^p := L(u_\epsilon^p) \quad g_p^\epsilon := \sigma(u_\epsilon^p) \cdot \vec{n} \quad (24)$$

then, a particular consequence of (23) is: we can fix p such that

$$\|\nabla u_\epsilon^p - \nabla u_\epsilon\|_{0,\Omega} \leq \frac{1}{4C_6\sqrt{\mu}}, \quad (25)$$

where C' is the continuity constant of the operator G'^{-1} defined as follows. Let G' be the operator that associates to each data $(f, g) \in L^2(\Omega) \times [H^{\frac{1}{2}}(\Gamma - \Gamma_0)]'$ the solution v of

$$\begin{cases} Lv = f & \text{a.e in } \Omega, \\ \sigma(v) \cdot \vec{n} = g & \text{on } \Gamma - \Gamma_0 \\ v = 0 & \text{on } \Gamma_0 \end{cases}$$

i.e.

$$\begin{aligned} G' : L^2(\Omega) \times [H^{\frac{1}{2}}(\Gamma - \Gamma_0)]' &\rightarrow M \subset V \\ (f, g) &\rightarrow G'(f, g) = v, \end{aligned}$$

where $(M, \|\cdot\|_{H^1(\Omega)})$ denote the range of $L^2(\Omega) \times [H^{\frac{1}{2}}(\Gamma - \Gamma_0)]'$ under G' . Since G' is bijective and continuous then, applying the Banach theorem with G' we infer that the inverse operator G'^{-1} is continuous i.e. $\forall v \in M$

$$\|G'^{-1}v\|_{L^2(\Omega), H^{\frac{1}{2}}(\Gamma - \Gamma_0)} \leq C_6 \|v\|_M$$

thus by using (25) we obtain, with $v = u_\epsilon^p - u_\epsilon$, and given an arbitrary small $\beta > 0$

$$(i) \|f^p - f\|_{0,\Omega} \leq C_6 \|\nabla u_\epsilon^p - \nabla u_\epsilon\|_{0,\Omega} \leq \frac{1}{4\sqrt{\mu}} \quad (26)$$

$$(ii) \|g_p^\epsilon - g^\epsilon\|_{[H^{\frac{1}{2}}(\Gamma - \Gamma_0)]'} \leq \beta. \quad (27)$$

We fix, for the rest of the paper, p for which (25), (26) and (27) are fulfilled.

Lemma 6. *Let δ_0 be an arbitrary small number. There exists two functions u_1 and u_2 such that*

$$i) \quad u_\epsilon^p = u_1 + u_2.$$

$$ii) \quad \begin{cases} L(u_1) &= f_1 & \text{in } \Omega \\ u_1 &= 0 & \text{on } \Gamma - \Gamma_0 \\ u_1 &= 0 & \text{on } \Gamma_0 \end{cases} \quad \begin{cases} L(u_2) &= f_2 & \text{in } \Omega \\ u_2 &= u_\epsilon^p & \text{on } \Gamma - \Gamma_0, \\ u_2 &= 0 & \text{on } \Gamma_0. \end{cases}$$

$$iii) \quad \sigma(u_1) \cdot \vec{n} = 0 \quad \text{on } \Gamma \text{ and thus, } \sigma(u_2) \cdot \vec{n} = g_p^\epsilon \quad \text{on } \Gamma.$$

$$iv) \quad f_2 := f^p - f_1 \text{ satisfy } \|f^p - f_1\|_{0,\Omega} \leq \frac{\delta_0}{2m}.$$

Proof. Let $\delta_0 > 0$ be an arbitrary small number. Consider the decomposition

$$u_\epsilon^p := w + z$$

where w and z are respectively the solutions of the following problems

$$\begin{cases} L(w) &= f^p & \text{in } \Omega \\ w &= 0 & \text{on } \Gamma - \Gamma_0 \\ w &= 0 & \text{on } \Gamma_0 \end{cases} \quad \begin{cases} L(z) &= 0 & \text{in } \Omega \\ z &= u_\epsilon^p & \text{on } \Gamma - \Gamma_0 \\ z &= 0 & \text{on } \Gamma_0 ; \end{cases}$$

observe that $\sigma(w) \cdot \vec{n}$ does not necessary equal zero and thus $\sigma(z) \cdot \vec{n}$ does not necessary equal g . Nevertheless, by density, there is functions $w_n \in C_0^\infty(\Omega)$ such that

$$\|\nabla w_n - \nabla w\|_{0,\Omega} \rightarrow 0 \quad \text{as } n \rightarrow \infty.$$

One should note that, following the definition of compactly supported functions in Ω , $\sigma(w_n) \cdot \vec{n} = 0$ on $\partial\Omega$ for all n .

Using the same argument as in the proof of lemma (4) (Banach theorem), and for the fixed homogeneous Dirichlet boundary condition, there exists $C_0 > 0$ depending merely on the domain Ω such that

$$\|L(w_n) - f^p\|_{0,\Omega} \leq C_0 \|\nabla w_n - \nabla w\|_{0,\Omega} \rightarrow 0 \text{ as } n \rightarrow \infty, \quad (28)$$

thus, there exists an element w^* in $\{w_n\}_{n \in \mathbb{N}}$ that satisfy the estimate

$$\|L(w^*) - f^p\|_{0,\Omega} \leq \frac{\delta_0}{m}. \quad (29)$$

Decompose $w := w^* + w_2$ where w_2 is a solutions of

$$\begin{cases} L(w_2) = f^p - L(w^*) & \text{in } \Omega \\ w_2 = 0 & \text{on } \Gamma - \Gamma_0 \\ w_2 = 0 & \text{on } \Gamma. \end{cases}$$

One should remark that

$$\sigma(w_2) \cdot \vec{n} + \sigma(z_1) \cdot \vec{n} = g_p^\epsilon,$$

indeed, $\sigma(w_2) \cdot \vec{n} + \sigma(z_1) \cdot \vec{n} = \sigma(u) \cdot \vec{n} - \sigma(w^*) \cdot \vec{n} = g_p^\epsilon - 0$. Pose

$$u_1 := w^* \quad , \quad u_2 := w_2 + z_1,$$

and

$$f_1 := L(w^*) \quad , \quad f_2 := f^p - L(w^*),$$

this concludes the lemma. \square

It should be pointed out that we repeatedly apply the essential argument in lemma (4), namely the Banach isomorphism theorem, in order to obtain estimates for the inverse of some operators. On the other hand, although the functions u_1 and u_2 depends on ϵ we have removed the index ϵ for clarity of presentation.

Lemma 7. *Let E_i be the subspace of V defined by (22). Let u_1, u_2 be such as defined in lemma (6). Given $\delta_1, \delta_2 > 0$ arbitrary small numbers, there exists m functions $u_{2,i} \in E_i, 1 \leq i \leq m$, such that*

$$u_{2,i} = 0 \quad \text{on } \Gamma - \Gamma_i,$$

and such that $g_i := \sigma(u_{2,i}) \cdot \vec{n}$ satisfy

$$\|g_i - g_p^\epsilon\|_{0,\Gamma_i} \leq \frac{\delta_1}{m}. \quad (30)$$

moreover, $u'_2 := \sum_{i=1}^m u_{2,i}$ satisfy

$$\|\nabla(u_1 + u'_2) - \nabla u_\epsilon^p\|_{0,\Omega} \leq \delta_2. \quad (31)$$

The construction of the function $u_{2,i}$ that is presented in the proof of lemma (7) below shows that for all i , the functions $u_{2,i}$ vanish not only on Γ but also on $N_i \cap \partial\Omega$, where $N_i \subset \mathbb{R}^2$ is an open neighborhood of Γ_i . The proof is done in two main steps. In the first one, we construct the functions $u_{2,i}$ and in the second step we prove that these functions actually satisfy estimate (30) and (31).

Proof. Let δ_1, δ_2 be arbitrary small numbers. The functions $u_{2,i}$ will be defined by introducing the intermediate functions X_i, Y_i, \tilde{Y}_i^n and V_i respectively in subsections a), b), c) and d). As we define these functions, we demonstrate some estimates that will be used to derive (30) and (31) in the second step.

Step 1: Fix $i, 1 \leq i \leq m$. Consider the decomposition

$$u_2 = X_i + \sum_{j \neq i} X_j = X_i + Z_i,$$

where $X_i \in E_i$ and Z_i are the solutions of

$$(P_1) \begin{cases} L(X_i) & = 0 & \text{in } \Omega \\ X_i & = u_\epsilon^p & \text{on } \Gamma_i \\ X_i & = 0 & \text{on } \Gamma - \Gamma_i \cup \Gamma_0 \\ X_i & = 0 & \text{on } \Gamma_0 \end{cases} \quad (P'_1) \begin{cases} L(Z_i) & = f_2 & \text{in } \Omega \\ Z_i & = 0 & \text{on } \Gamma_i \\ Z_i & = u_\epsilon^p & \text{on } \Gamma - \Gamma_i \cup \Gamma_0 \\ Z_i & = 0 & \text{on } \Gamma_0. \end{cases}$$

One should notice that these two problems are well posed, this can be seen by considering the regularity of u_ϵ^p on the boundary and the fact that u_ϵ^p vanish identically on a neighborhood of the the vertices. Since Ω is a Lipschitz domain, it posses the $W^{1,2}$ -Sobolev extension property.

a) According to (theorem 2.1, [11]) see Index A at the end, there exists $X_i^n \in C_0^\infty(\mathbb{R}^2)$ such that we have

$$(h1) \quad \|\nabla X_i^n - \nabla X_i\|_{0,\Omega} \leq \frac{\delta_3}{m} \quad (h2) \quad \text{supp}(X_i^n) \cap (\Gamma - \Gamma_i) = \emptyset,$$

where $\delta_3 > 0$ is an adequately chosen real number. A consequence of (h2) is:

$$(h3) \quad \sigma(X_i^n) \cdot \vec{n} = 0 \text{ on } \Gamma - \Gamma_i, \quad X_i^n = 0 \text{ on } \Gamma - \Gamma_i.$$

Furthermore, with the homogeneous Dirichlet condition on $\Gamma - \Gamma_i$ being fixed in the problem P_1 and in the problem solved by X_i^n then, using the Banach theorem, there exists $C_1 > 0$ such that

$$\|\sigma(X_i^n) \cdot \vec{n} - \sigma(X_i) \cdot \vec{n}\|_{0,\Gamma_i} + \|L(X_i^n) - 0\|_{0,\Omega} \leq C_1 \|\nabla X_i^n - \nabla X_i\|_{0,\Omega} \leq \frac{C_1 \delta_3}{m}.$$

We choose δ_3 in assumption (h1) such that

$$(c1) : \quad \frac{C_1 \delta_3}{m} < \frac{\delta_0}{4m}$$

where δ_0 is a positive real number whose choice will be precised later (see condition (c4) below). Fix n_1 such that $F_i^{n_1} := L(X_i^{n_1})$ satisfy

$$\|F_i^{n_1} - 0\|_{0,\Omega} \leq \frac{\delta_0}{4m}. \quad (32)$$

Denote $\tilde{X}_i^{n_1} := X_i - X_i^{n_1} \in E_i$, it does satisfy

$$X_i^{n_1} + \tilde{X}_i^{n_1} + Z_i = u_\epsilon^p \quad (33)$$

i.e.

$$(P_2) \begin{cases} L(X_i^{n_1}) & = F_i^n & \text{in } \Omega \\ X_i^{n_1} & = x_i^{n_1} & \text{on } \Gamma_i \\ X_i^{n_1} & = 0 & \text{on } \Gamma - \Gamma_i \end{cases} \quad (P'_2) \begin{cases} L(\tilde{X}_i^{n_1}) & = -F_i^n & \text{in } \Omega \\ \tilde{X}_i^{n_1} & = u_\epsilon^p - x_i^{n_1} & \text{on } \Gamma_i \\ \tilde{X}_i^{n_1} & = 0 & \text{on } \Gamma - \Gamma_i, \end{cases}$$

for the same reasons as for (P_1) and (P'_1) , problems (p_2) and (P'_2) are well posed. Considering $(h3)$ and (33) , the function $\tilde{X}_i^{n_1} + Z_i$ satisfy

$$(P_3) \begin{cases} L(\tilde{X}_i^{n_1} + Z_i) & = -F_i^{n_1} + f_2 & \text{in } \Omega \\ \tilde{X}_i^{n_1} + Z_i & = u_\epsilon^p - x_i^{n_1} & \text{on } \Gamma_i \\ \sigma(\tilde{X}_i^{n_1} + Z_i) \cdot \vec{n} & = g_p^\epsilon & \text{on } \Gamma - \Gamma_i \cup \Gamma_0 \\ \tilde{X}_i^{n_1} + Z_i & = 0 & \text{on } \Gamma_0. \end{cases}$$

b) Let Y_i be the function defined by

$$(P_4) \begin{cases} L(Y_i) & = -F_i^{n_1} + f_2 & \text{in } \Omega \\ Y_i & = 0 & \text{on } \Gamma_i \\ \sigma(Y_i) \cdot \vec{n} & = g_p^\epsilon & \text{on } \Gamma - \Gamma_i \cup \Gamma_0 \\ Y_i & = 0 & \text{on } \Gamma_0, \end{cases}$$

Thanks to assumption (5), this problem is well posed. There exists a trace constant c_t such that, using $(h1)$, we have

$$\|(u_\epsilon^p - x_i^{n_1})\|_{0,\Gamma_i} \leq c_t \times \|\nabla X_i - \nabla X_i^{n_1}\|_{0,\Omega} \leq \frac{c_t \times \delta_3}{m}; \quad (34)$$

for the fixed $-F_i^{n_1} + f_2 \in L^2(\Omega)$, $g_p^\epsilon \in L^2(\Gamma - \Gamma_i \cup \Gamma_0)$ and the homogeneous Dirichlet condition on Γ_0 in problems (P_3) and (P_4) , and by using an argument similar to that in part (a) of the proof of lemma (4) (Banach theorem), there exists a constant $C_3 > 0$ such that

$$\begin{aligned} \|\nabla Y_i - \nabla(\tilde{X}_i^{n_1} + Z_i)\|_{0,\Omega} &\leq C_3 \|Y_i - (u_\epsilon^p - x_i^{n_1})\|_{0,\Gamma_i} \\ &= C_3 \|0 - (u_\epsilon^p - x_i^{n_1})\|_{0,\Gamma_i} \\ &\leq \frac{c_t \times C_3 \delta_3}{m}, \end{aligned} \quad (35)$$

and by using the trace inequality again we have

$$\begin{aligned} \|Y_i - (\tilde{X}_i^{n_1} + Z_i)\|_{0,\Gamma-\Gamma_i} &\leq c_t \|\nabla Y_i - \nabla(\tilde{X}_i^{n_1} + Z_i)\|_{0,\Omega} \\ &\leq c_t^2 \times C_3 \frac{\delta_3}{m}. \end{aligned} \quad (36)$$

Considering (33) and (h3), we easily see that $\tilde{X}_i^{n_1} + Z_i = u_\epsilon^p$ on $\Gamma - \Gamma_i$; and thus, estimates (35), (36) become respectively

$$\|\nabla(X_i^{n_1} + Y_i) - \nabla u_\epsilon^p\|_{0,\Omega} \leq \frac{c_t \times C_3 \delta_3}{m}. \quad (37)$$

$$\|Y_i - u_\epsilon^p\|_{0,\Gamma-\Gamma_i} \leq \frac{c_t^2 \times C_3 \delta_3}{m}. \quad (38)$$

On the other hand, since $Y_i = 0$ on Γ_i then, using the result (Theorem 2.1, [11] see Index A at the end), there exists $Y_i^n \in C_0^\infty(\mathbb{R}^2)$ such that

$$(h4) \quad \|\nabla Y_i^n - \nabla Y_i\|_{0,\Omega} \leq \frac{\delta'_1}{m} \quad \text{and} \quad \text{supp}(Y_i^n) \cap \Gamma_i = \emptyset,$$

where $\delta'_1 > 0$ is an adequately chosen real number, thus

$$\sigma(Y_i^n) \cdot \vec{n} = 0 \text{ on } \Gamma_i \quad \text{and} \quad Y_i^n = 0 \text{ on } \Gamma_i \quad (39)$$

for the homogeneous Dirichlet condition on $\Gamma_i \cup \Gamma_0$ for problem (P_4) and the problem solved by Y_i^n , and using Banach theorem, there exists $C'_1 > 0$ such that

$$\|L(Y_i^n) - (-F_i^{n_1} + f_2)\|_{0,\Omega} \leq C'_1 \|\nabla Y_i^n - \nabla Y_i\|_{0,\Omega}.$$

We choose $\delta'_1 > 0$ in assumption (h4) such that

$$(c2) : \quad \frac{C'_1 \delta'_1}{m} < \frac{\delta_0}{4m},$$

where δ_0 is as defined in lemma (6) i.e. need to satisfy condition (c4) below. Fix $n_2 > n_1$ such that

$$h_i^{n_2} := L(Y_i^{n_2}) \quad (40)$$

satisfy

$$\|h_i^{n_2} - (-F_i^{n_1} + f_2)\|_{0,\Omega} \leq \frac{\delta_0}{4m};$$

consequently, considering (iv) of lemma (6) and (32), we have

$$\|h_i^{n_2} - 0\| \leq \frac{\delta_0}{m}. \quad (41)$$

c) Denote $\tilde{Y}_i^{n_2} := Y_i - Y_i^{n_2}$, we have

$$(P_5) \begin{cases} L(Y_i^{n_2}) & = h_i^{n_2} & \text{in } \Omega \\ Y_i^{n_2} & = 0 & \text{on } \Gamma_i \\ Y_i^{n_2} & = y_i^{n_2} & \text{on } \Gamma - \Gamma_i \cup \Gamma_0 \\ Y_i^{n_2} & = 0 & \text{on } \Gamma_0 \end{cases}$$

and

$$(P_6) \begin{cases} L(\tilde{Y}_i^{n_2}) & = -h_i^{n_2} - F_i^{n_1} + f_2 & \text{in } \Omega \\ \tilde{Y}_i^{n_2} & = 0 & \text{on } \Gamma_i \\ \tilde{Y}_i^{n_2} & = Y_i - y_i^{n_2} & \text{on } \Gamma - \Gamma_i \cup \Gamma_0 \\ \tilde{Y}_i^{n_2} & = 0 & \text{on } \Gamma_0, \end{cases}$$

estimate (37) rewrites

$$\|\nabla(\tilde{Y}_i^{n_2} + Y_i^{n_2} + X_i^{n_1}) - \nabla u_\epsilon^p\|_{0,\Omega} \leq \frac{c_t \times C_3 \delta_3}{m}, \quad (42)$$

denote

$$g' := \sigma(\tilde{Y}_i^{n_2}) \cdot \vec{n} \in L^2(\Gamma - \Gamma_0).$$

d) Let $V_i \in E_i$ be the function defined by

$$(P_7) \begin{cases} L(V_i) & = -h_i^{n_2} - F_i^{n_1} + f_2 & \text{in } \Omega \\ \sigma(V_i) \cdot \vec{n} & = g' & \text{on } \Gamma_i \\ V_i & = 0 & \text{on } \Gamma - \Gamma_i \cup \Gamma_0 \\ V_i & = 0 & \text{on } \Gamma_0. \end{cases}$$

Set

$$u_{2,i} := X_i^{n_1} + V_i \in E_i,$$

Step 2: The functions $u_{2,i}$ are the unique solutions of

$$\begin{cases} L(u_{2,i}) & = -h_i^{n_2} + f_2 & \text{in } \Omega \\ u_{2,i} & = X_i^{n_1} + V_i & \text{on } \Gamma_i \\ u_{2,i} & = 0 & \text{on } \Gamma - \Gamma_i \cup \Gamma_0 \\ u_{2,i} & = 0 & \text{on } \Gamma_0. \end{cases}$$

Using the estimates established in step 1, we are ready to prove (30) and (31).

Proof of estimate (30): Since $\sigma(V_i) \cdot \vec{n} = \sigma(\tilde{Y}_i^{n_2}) \cdot \vec{n}$ on Γ_i , then we have for $g_i := \sigma(V_i + X_i^{n_1}) \cdot \vec{n}$

$$\begin{aligned} \|g_i - g_p^\epsilon\|_{0,\Gamma_i} &= \|\sigma(V_i + X_i^{n_1}) \cdot \vec{n} - g_p^\epsilon\|_{0,\Gamma_i} \\ &= \|\sigma(\tilde{Y}_i^{n_2} + X_i^{n_1}) \cdot \vec{n} - \sigma(u_\epsilon^p) \cdot \vec{n}\|_{0,\Gamma_i} \end{aligned}$$

Using (39)

$$\begin{aligned} \|g_i - g_p^\epsilon\|_{0,\Gamma_i} &= \|\sigma(\tilde{Y}_i^{n_2} + Y_i^{n_2} + X_i^{n_1}) \cdot \vec{n} - \sigma(u_\epsilon^p) \cdot \vec{n}\|_{0,\Gamma_i} \\ &\leq \|\sigma(\tilde{Y}_i^{n_2} + Y_i^{n_2} + X_i^{n_1}) \cdot \vec{n} - \sigma(u_\epsilon^p) \cdot \vec{n}\|_{0,\Gamma-\Gamma_0} ; \end{aligned}$$

for the fixed homogeneous Dirichlet condition on Γ_0 , and according to the Banach isomorphism theorem, there exists a constant $C_2 > 0$ depending merely on Ω such that, using (42) and since we have $Y_i = Y_i^{n_2} + \tilde{Y}_i^{n_2}$

$$\begin{aligned} \|g_i - g_p^\epsilon\|_{0,\Gamma_i} &\leq \|\sigma(Y_i + X_i^{n_1}) \cdot \vec{n} - \sigma(u_\epsilon^p) \cdot \vec{n}\|_{0,\Gamma-\Gamma_0} \\ &\leq C_2 \|\nabla(Y_i + X_i^{n_1}) - \nabla u_\epsilon^p\|_{0,\Omega} \\ &\leq \frac{c_t \times C_3 C_2 \delta_3}{m}. \end{aligned}$$

If δ_3 also fulfill condition

$$(c3) : \quad \frac{c_t \times C_3 C_2 \delta_3}{m} < \frac{\delta_1}{m},$$

where δ_1 is the arbitrary small number assumed at the beginning of the proof then, estimate (30) is proved.

In order to prove estimate (31), we need to estimate the trace of $X_i^{n_1} + V_i$ on Γ_i .

1) Firstly remark, by using (h3), that

$$V_i + X_i^{n_1} = 0 \quad \text{on} \quad \Gamma - \Gamma_i.$$

2) For the fixed $-(h_i^{n_2} + F_i^{n_1} - f_2) \in L^2(\Omega)$, $g' \in L^2(\Gamma_i)$ and the homogeneous Dirichlet condition on Γ_0 in problems (P_6) and (P_7) , the Banach isomorphism theorem ensures the existence of a constant $C_4 > 0$ depending merely on Ω such that

$$\|\nabla V_i - \nabla \tilde{Y}_i^{n_2}\|_{0,\Omega} \leq C_4 \|V_i - \tilde{Y}_i^{n_2}\|_{0,\Gamma-\Gamma_i} = C_4 \|0 - (Y_i - y_i^{n_2})\|_{0,\Gamma-\Gamma_i},$$

hence, considering (h4) and using trace inequality, we have

$$C_4 \|0 - (Y_i - y_i^{n_2})\|_{0,\Gamma-\Gamma_i} \leq c_t C_4 \|\nabla Y_i - \nabla Y_i^{n_2}\|_{0,\Omega} \leq c_t C_4 \frac{\delta'_1}{m},$$

thus,

$$\|\nabla V_i - \nabla \tilde{Y}_i^{n_2}\|_{0,\Omega} \leq c_t C_4 \frac{\delta'_1}{m}. \quad (43)$$

Using trace inequality and (43) we obtain

$$\|V_i - 0\|_{0,\Gamma_i} \leq \|V_i - \tilde{Y}_i^{n_2}\|_{0,\Gamma} \leq c_t \|\nabla V_i - \nabla \tilde{Y}_i^{n_2}\|_{0,\Omega} \leq c_t^2 \times C_4 \frac{\delta'_1}{m}. \quad (44)$$

Estimates (34) and (44) imply

$$\begin{aligned} \|V_i + X_i^{n_1} - u_\epsilon^p\|_{0,\Gamma_i} &\leq \|V_i - 0\|_{0,\Gamma_i} + \|X_i^{n_1} - u_\epsilon^p\|_{0,\Gamma_i} \\ &= \|V_i - 0\|_{0,\Gamma_i} + \|x_i^{n_1} - u_\epsilon^p\|_{0,\Gamma_i} \\ &\leq c_t^2 \times C_4 \frac{\delta'_1}{m} + \frac{c_t \delta_3}{m}. \end{aligned} \quad (45)$$

Proof of estimate (31): Write $u'_2 := \sum_i u_{2,i} = \zeta' + \eta'$ where ζ' and η' are respectively the solutions of

$$\left\{ \begin{array}{l} L(\zeta') = -\sum_{i=1}^m (h_i^{n_2} - f_2) \quad \text{in } \Omega \\ \zeta' = 0 \quad \text{on } \Gamma_i \\ \zeta' = 0 \quad \text{on } \Gamma - \Gamma_i \end{array} \right. \quad (P_8) \quad \left\{ \begin{array}{l} L(\eta') = 0 \quad \text{in } \Omega \\ \eta' = \sum_{i=1}^m u_{2,i} \quad \text{on } \Gamma - \Gamma_0 \\ \eta' = 0 \quad \text{on } \Gamma_0, \end{array} \right.$$

and write $u_2 = \zeta + \eta$ where ζ and η are the solutions of

$$\left\{ \begin{array}{l} L(\zeta) = f_2 \quad \text{in } \Omega \\ \zeta = 0 \quad \text{on } \Gamma_i \\ \zeta = 0 \quad \text{on } \Gamma - \Gamma_i \end{array} \right. \quad (P_9) \quad \left\{ \begin{array}{l} L(\eta) = 0 \quad \text{in } \Omega \\ \eta = u_\epsilon^p \quad \text{on } \Gamma - \Gamma_0 \\ \eta = 0 \quad \text{on } \Gamma_0. \end{array} \right.$$

If we denote c_k the constant in the Korn inequality then the weak form of the problem solved by $\zeta - \zeta'$ yields

$$\begin{aligned} \|\nabla \zeta - \nabla \zeta'\|_{0,\Omega} &\leq c_k d(\Omega) \|f_2 + \sum_i (h_i^{n_2} - f_2)\|_{0,\Omega} \\ &\leq d(\Omega) (\|f_2\|_{0,\Omega} + \sum_i \|h_i^{n_2}\|_{0,\Omega} + \sum_i \|f_2\|_{0,\Omega}) \end{aligned}$$

using (iv) of lemma (6) and (41), we have

$$\|\nabla \zeta - \nabla \zeta'\|_{0,\Omega} \leq d(\Omega) \left(\frac{\delta_0}{2m} + \delta_0 + \frac{\delta_0}{2} \right). \quad (46)$$

On the other hand, the Banach isomorphism theorem ensures, for the null source term and the Dirichlet homogeneous condition on Γ_0 in problems (P_8) and (P_9) , that there exists a constant $C_5 > 0$ such that

$$\begin{aligned} \|\nabla\eta - \nabla\eta'\|_{0,\Omega} &\leq C_5\|\eta - \eta'\|_{0,\Gamma-\Gamma_0} = C_5\|u_\epsilon^p - \sum_{i=1}^m u_{2,i}\|_{0,\Gamma-\Gamma_0} \\ &\leq C_5\sum_{i=1}^m \|u_\epsilon^p - \sum_{i=1}^m u_{2,i}\|_{0,\Gamma_i} \\ &= C_5\sum_{i=1}^m \|u_\epsilon^p - u_{2,i}\|_{0,\Gamma_i}. \end{aligned}$$

Applying estimate (45) with $u_{2,i} = V_i + X_i^{n_1}$

$$\|\nabla\eta - \nabla\eta'\|_{0,\Omega} \leq C_5(c_t^2 \times C_4\delta'_1 + c_t\delta_3). \quad (47)$$

Combining (46) and (47), we obtain using triangular inequality

$$\begin{aligned} \|\nabla u_2 - \nabla u'_2\|_{0,\Omega} &\leq \|\nabla\zeta - \nabla\zeta'\| + \|\nabla\eta - \nabla\eta'\|_{0,\Omega} \\ &\leq d(\Omega)\left(\frac{\delta_0}{2m} + \delta_0 + \frac{\delta_0}{2}\right) + C_5(c_t^2 \times C_4\delta'_1 + c_t\delta_3), \end{aligned}$$

Finally, if δ_0 , δ_3 and δ'_1 are subject to fulfill the condition

$$(c4) : \quad d(\Omega)\left(\frac{\delta_0}{2m} + \delta_0 + \frac{\delta_0}{2}\right) + C_5(c_t^2 \times C_4\delta'_1 + c_t\delta_3) < \delta_2.$$

where δ_2 is the arbitrary small number assumed at the beginning of the proof then,

$$\|\nabla u_\epsilon^p - \nabla(u_1 + u'_2)\|_{0,\Omega} \leq \delta_2$$

This proves (48). □

Remark 8. 1) Let g_p^ϵ such as defined in (24), we can easily show that

$$\|g_p^\epsilon\|_{0,\Gamma-\Gamma_0}^2 \leq \|g\|_{0,\Gamma-\Gamma_0}^2 + \delta_6^2, \quad (48)$$

where δ_6 is an arbitrary small positive real number. Indeed, write using triangular inequality

$$\begin{aligned}
\left| \|g_p^\epsilon\|_{0,\Gamma-\Gamma_0}^2 - \int_{\Gamma-\Gamma_0} g g_p^\epsilon \, d\sigma \right| &= \left| \langle g_p^\epsilon, g_p^\epsilon \rangle_{[H^{\frac{1}{2}}(\Gamma-\Gamma_0)]', H^{\frac{1}{2}}(\Gamma-\Gamma_0)} \right. \\
&\quad \left. - \langle g, g_p^\epsilon \rangle_{[H^{\frac{1}{2}}(\Gamma-\Gamma_0)]', H^{\frac{1}{2}}(\Gamma-\Gamma_0)} \right| \\
&\leq \left| \langle g_p^\epsilon - g, g_p^\epsilon \rangle_{[H^{\frac{1}{2}}(\Gamma-\Gamma_0)]', H^{\frac{1}{2}}(\Gamma-\Gamma_0)} \right| \\
&\leq \|g_p^\epsilon - g\|_{[H^{\frac{1}{2}}(\Gamma-\Gamma_0)]'} \|g_p^\epsilon\|_{\frac{1}{2},\Gamma-\Gamma_0} \\
&\leq (\|g_p^\epsilon - g^\epsilon\|_{[H^{\frac{1}{2}}(\Gamma-\Gamma_0)]'} + \\
&\quad \|g^\epsilon - g\|_{[H^{\frac{1}{2}}(\Gamma-\Gamma_0)]'}) \|g_p^\epsilon\|_{\frac{1}{2},\Gamma-\Gamma_0}
\end{aligned}$$

Since, following estimate (ii) of (27), g_p^ϵ converges in $[H^{\frac{1}{2}}(\Gamma - \Gamma_0)]'$ to g^ϵ i.e. weakly in $H^{\frac{1}{2}}(\Gamma - \Gamma_0)$ hence, there exists $C' > 0$ such that

$$\|g_p^\epsilon\|_{\frac{1}{2},\Gamma-\Gamma_0} \leq C'$$

for all $p \in \mathbb{N}$. Thus,

$$\|g_p^\epsilon\|_{0,\Gamma-\Gamma_0}^2 - \int_{\Gamma-\Gamma_0} g g_p^\epsilon \, d\sigma \leq C' (\|g_p^\epsilon - g^\epsilon\|_{[H^{\frac{1}{2}}(\Gamma-\Gamma_0)]'} + \|g^\epsilon - g\|_{[H^{\frac{1}{2}}(\Gamma-\Gamma_0)]'}),$$

using (i) of remark (5) and estimates (ii) of (27) and for an adequate choice of β , the parameters p and ϵ can be chosen such that

$$\|g_p^\epsilon\|_{0,\Gamma-\Gamma_0}^2 - \int_{\Gamma-\Gamma_0} g g_p^\epsilon \, d\sigma \leq 2\beta C'$$

and thus, Cauchy-Schwarz yields

$$\|g_p^\epsilon\|_{0,\Gamma-\Gamma_0}^2 \leq \int_{\Gamma-\Gamma_0} g g_p^\epsilon + 2\beta C' \leq \|g\|_{0,\Gamma-\Gamma_0} \|g_p^\epsilon\|_{0,\Gamma-\Gamma_0} + 2\beta C',$$

Young inequality on the other hand gives us

$$\|g_p^\epsilon\|_{0,\Gamma-\Gamma_0}^2 \leq \frac{1}{2} \|g\|_{0,\Gamma-\Gamma_0}^2 + \frac{1}{2} \|g_p^\epsilon\|_{0,\Gamma-\Gamma_0}^2 + 2\beta C'$$

and hence, there exists p such that g_p^ϵ satisfy

$$\|g_p^\epsilon\|_{0,\Gamma-\Gamma_0}^2 \leq \|g\|_{0,\Gamma-\Gamma_0}^2 + 4\beta C',$$

pose

$$\delta_6^2 := 4\beta C'$$

since, following (i) of remark (5) and (27), β is arbitrary small then the same holds with δ_6 .

2) on the other hand, if $u_{2,i}$ and $h_i^{n_2}$ are respectively such as defined in lemma (7) and (40) then

$$\begin{aligned} \|L(u_{2,i})\|_{0,\Omega} &= \|h_i^{n_2} + f_2\|_{0,\Omega} \leq \|h_i^{n_2}\|_{0,\Omega} + \|f_2\|_{0,\Omega} \\ &\leq \frac{\delta_0}{m} + \frac{\delta_0}{2m} =: \tau, \end{aligned} \quad (49)$$

where δ_0 is arbitrary small and satisfy (c4) and thus, τ is also arbitrary small.

We introduce some useful lemmas, which will play important roles in the proof of theorem (1).

3.1 Extension of the functions $u_{2,i}$

Since we are looking for explicit estimates, we should use Poincaré, trace and Korn's inequalities relatively to suitable geometric configurations i.e. for which they are explicitly formulated. The configuration that best fits our polygonal convex domain Ω is the half-plane \mathbb{R}^{2+} containing the domain Ω for Korn's inequality, the square S_d with edge's length equal to $d(\Omega)$ for the Poincaré inequality and with edge Γ_i for the trace inequality. These squares are taken to be subsets of the half-plane containing Ω . Thus we determine these constants thanks to results available for this type of domains. The need to consider the functions in and outside the domain Ω suggests to extend by zero the functions $u_{2,i}$ outside the convex domain Ω . The definition of the functions $u_{2,i}$ is adapted to make such an extension.

Let $u_{2,i}$ be such as defined in lemma (7). We consider for i , $1 \leq i \leq m$, the extension by zero of $u_{2,i}$ from the convex domain Ω to the half-plane \mathbb{R}^{2+} containing Ω such that $\Gamma_i \subset \partial\mathbb{R}^{2+}$.

$$\tilde{u}_{2,i} = \begin{cases} u_{2,i}, & a.e. \quad x \in \bar{\Omega}, \\ 0, & x \in \mathbb{R}^{2+} - \bar{\Omega}. \end{cases} \quad (50)$$

We assert that $\tilde{u}_{2,i} \in H^1(\mathbb{R}^{2+})$, this is due essentially to definition (9), this definition implies the existence of an open neighborhood V_i of the vertex i such that $u_{2,i}$ vanish on $V_i \cap \Gamma$. Thus, we have, obviously, the following

$$\|\partial_{x_i} \tilde{u}_{2,i}\|_{0,\mathbb{R}^{2+}} = \|\partial_{x_i} \tilde{u}_{2,i}\|_{0,\Omega} = \|\partial_{x_i} u_{2,i}\|_{0,\Omega}. \quad (51)$$

One can easily see that the resulting extend functions $\tilde{u}_{2,i}$ are still in the Sobolev space $H^1(\mathbb{R}^{2+})$. Indeed, thanks the definition of these function, there will be no jump when passing to the distributional derivative.

The following inequalities are established for the extended H^1 regular functions defined on a square containing the convex polygonal domain Ω .

3.2 Explicit constant in the Poincaré inequality

We show in the following lemma that the function $u_{2,i} \in E_i$ satisfy the Poincaré inequality for which we determine explicitly the constant.

Lemma 9. *For all i , $0 \leq i \leq m$, the function $u_{2,i}$ satisfy:*

$$\|u_{2,i}\|_{0,\Omega} \leq d(\Omega) \|\nabla u_{2,i}\|_{0,\Omega}, \quad (52)$$

the constant $d(\Omega)$ means the diameter of Ω .

Proof. We establish Poincaré inequality for one of the two components $u_{2,i}^l, l = 1, 2$, the same estimate hold with the other. Note $abcd$ the square S_d , with edge's length equal to $d(\Omega)$ and subset of the half-plane containing Ω , such that $a = (a_1, a_2), b = (b_1, b_2), c = (c_1, c_2)$ et $d = (d_1, d_2)$ and such that $\Gamma_i \subset S_i := [c, d]$; so $\tilde{u}_{2,i}^l = 0$ on $\partial S_d - \Gamma_i$.

Since $\tilde{u}_{2,i}^l$ is absolutely continuous on the lines parallel to the coordinate axis, then applying the fundamental theorem of calculus to $\tilde{u}_{1,i}^{n,l}$ on S_d for $l = 1, 2$, we have for all $(x_1, x_2) \in [a_1, d_1] \times [a_2, b_2]$

$$\tilde{u}_{2,i}^l(x_1, x_2) = \int_{a_1}^{x_1} \partial_{x_1} \tilde{u}_{2,i}^l(s, x_2) ds + \tilde{u}_{2,i}^l(a_1, x_2).$$

Since $(a_1, x_2) \in \partial S_d - \Gamma_i$, then $\forall (x_1, x_2) \in [a_1, d_1] \times [a_2, b_2]$

$$\tilde{u}_{2,i}^l(x_1, x_2) = \int_{a_1}^{x_1} \partial_{x_1} \tilde{u}_{2,i}^l(s, x_2) ds.$$

Using Cauchy-Schwarz inequality $\forall (x_1, x_2) \in [a_1, d_1] \times [a_2, b_2]$

$$|\tilde{u}_{2,i}^l(x_1, x_2)| \leq |x_1 - a|^{1/2} \left(\int_{a_1}^{x_1} |\partial_{x_1} \tilde{u}_{2,i}^l(s, x_2)|^2 ds \right)^{1/2}.$$

Taking the square of the two hand sides of this inequality and using the fact $|x_1 - a| \leq d(\Omega)$: $\forall (x_1, x_2) \in [a_1, d_1] \times [a_2, b_2]$ yields

$$|\tilde{u}_{2,i}^l(x_1, x_2)|^2 \leq |x_1 - a| \int_{a_1}^{x_1} |\partial_{x_1} \tilde{u}_{2,i}^l(s, x_2)|^2 ds \leq d(\Omega) \int_{a_1}^{d_1} |\partial_{x_1} \tilde{u}_{2,i}^l(s, x_2)|^2 ds.$$

Integrating on S_d with respect to the variables x_1 and x_2 :

$$\begin{aligned} \|\tilde{u}_{2,i}^l\|_{0,S_d}^2 &= \int_{a_2}^{b_2} \int_{a_1}^{d_1} |\tilde{u}_{2,i}^l(x_1, x_2)|^2 dx dx \leq d(\Omega) \int_{a_2}^{b_2} \int_{a_1}^{d_1} \int_{a_1}^{d_1} |\partial_{x_1} \tilde{u}_{2,i}^l(s, x_2)|^2 ds dx dx \\ &\leq d^2(\Omega) \int \int_{S_d} |\partial_x \tilde{u}_{2,i}^l(s, x_2)|^2 ds dx. \end{aligned}$$

According to definition (50) and by considering (51) we get

$$\|u_{2,i}^l\|_{0,\Omega}^2 \leq d^2(\Omega) \|\nabla u_{2,i}^l\|_{0,\Omega}^2.$$

We infer that

$$\begin{aligned} \|u_{2,i}\|_{0,\Omega}^2 &= \|u_{2,i}^1\|_{0,\Omega}^2 + \|u_{2,i}^2\|_{0,\Omega}^2 \leq d^2(\Omega) (\|\nabla u_{2,i}^1\|_{0,\Omega}^2 + \|\nabla u_{2,i}^2\|_{0,\Omega}^2) \\ &= d^2(\Omega) \|\nabla u_{2,i}\|_{0,\Omega}^2. \end{aligned}$$

□

3.3 Explicit bound for the trace of $u_{2,i}$ on Γ_i

Using mainly the inequality of Poincaré stated in lemma (9) and the trace inequality for $u_{2,i}$ on the edge Γ_i of a the parallelogram S_{Γ_i} (see lemma 4.2 in [3] and remark 3.3 in [3] and the reference therein), one establishes an explicit bound for the trace of the function $u_{2,i}$ on Γ_i .

Lemma 10. *For all i , the function $u_{2,i}$ defined in lemma (7) satisfy:*

$$\|u_{2,i}\|_{0,\Gamma_i} \leq 16|\Gamma_i| \|g_i\|_{0,\Gamma_i} + \delta_9, \quad (53)$$

where δ_9 is an arbitrary small real positive number.

Proof. Let $\tilde{u}_{2,i}$ be defined on the square S_{Γ_i} with edge Γ_i such that S_{Γ_i} is a subset of the half-plane \mathbb{R}^{2+} containing Ω . One should notice that $\tilde{u}_{2,i}$ is not necessarily zero on $\partial S_{\Gamma_i} - \Gamma_i$. Let us write

$$\tilde{u}_{2,i} = \alpha + \varrho,$$

this decomposition is made similarly to that presented in lemma (7) i.e. such that on one hand

$$\|L(\alpha)\|_{0,S_{\Gamma_i}} \quad \text{and} \quad \|\sigma(\alpha) \cdot \vec{n} - g_i\|_{0,\Gamma_i} \quad \text{are small enough} \quad (54)$$

and on the other hand, α , ϱ vanish respectively on $\partial S_{\Gamma_i} - \Gamma_i$, Γ_i . We prove (53) for the the trace of the function α , the same estimate holds for the trace of $u_{2,i}$ since α and $u_{2,i}$ coincide on Γ_i . Decompose $\alpha := \alpha_1 + \alpha_2$ in the following way

$$\left\{ \begin{array}{ll} L(\alpha_1) & = L(\alpha) \quad \text{in } S_{\Gamma_i} \\ \sigma(\alpha_1) \cdot \vec{n} & = 0 \quad \text{on } \Gamma_i \\ \alpha_1 & = 0 \quad \text{on } \partial S_{\Gamma_i} - \Gamma_i \end{array} \right\} \quad \left\{ \begin{array}{ll} L(\alpha_2) & = 0 \quad \text{in } S_{\Gamma_i} \\ \sigma(\alpha_2) \cdot \vec{n} & = \sigma(\alpha) \cdot \vec{n} \quad \text{on } \Gamma_i, \\ \alpha_2 & = 0 \quad \text{on } \partial S_{\Gamma_i} - \Gamma_i. \end{array} \right.$$

Applying the inequality of trace on the boundary Γ_i of the the square S_{Γ_i} , which is a parallelogram (see lemma 4.2 in [3]), it yields for both $k = 1, 2$

$$\|\alpha_k\|_{0,\Gamma_i}^2 \leq 2 \frac{|\Gamma_i|}{|\Gamma_i|^2} \|\alpha_k\|_{0,S_{\Gamma_i}}^2 + 2 \frac{|\Gamma_i|^2}{|\Gamma_i|} \|\nabla \alpha_k\|_{0,S_{\Gamma_i}}^2,$$

simplifying,

$$\|\alpha_k\|_{0,\Gamma_i}^2 \leq 2 \frac{1}{|\Gamma_i|} \|\alpha_k\|_{0,S_{\Gamma_i}}^2 + 2|\Gamma_i| \|\nabla \alpha_k\|_{0,S_{\Gamma_i}}^2,$$

using estimate (52) for the case where Ω is the square S_{Γ_i} , with $d(S_{\Gamma_i}) = \sqrt{2}|\Gamma_i|$, yields

$$\begin{aligned} \|\alpha_k\|_{0,\Gamma_i}^2 &\leq 2 \frac{2|\Gamma_i|^2}{4|\Gamma_i|} \|\nabla \alpha_k\|_{0,S_{\Gamma_i}}^2 + 2|\Gamma_i| \|\nabla \alpha_k\|_{0,S_{\Gamma_i}}^2 \\ &\leq 3|\Gamma_i| \|\nabla \alpha_k\|_{0,S_{\Gamma_i}}^2. \end{aligned} \quad (55)$$

Applying Korn's inequality for the extended function $\tilde{\alpha}$ defined on the half-plane \mathbb{R}^{2+} containing S_{Γ_i} , for which case Korn constant equals $\frac{1}{2}$, estimate (55) becomes

$$\|\alpha_k\|_{0,\Gamma_i}^2 \leq 12|\Gamma_i| \|\varepsilon(\alpha_k)\|_{0,S_{\Gamma_i}}^2. \quad (56)$$

Since α_1 and α_2 satisfy respectively

$$\|\varepsilon(\alpha_1)\|_{0,S_{\Gamma_i}}^2 = \int_{S_{\Gamma_i}} L(\alpha) \alpha_1 \, dx \quad \text{and} \quad \|\varepsilon(\alpha_2)\|_{0,S_{\Gamma_i}}^2 = \int_{\Gamma_i} \sigma(\alpha) \cdot \vec{n} \, \alpha_2 \, d\sigma,$$

then, using Cauchy-schwarz, this leads to estimates

$$\|\varepsilon(\alpha_1)\|_{0,S_{\Gamma_i}} \leq 2\sqrt{2}|\Gamma_i| \|L(\alpha)\|_{0,S_{\Gamma_i}} \quad \text{and} \quad \|\varepsilon(\alpha_2)\|_{0,S_{\Gamma_i}} \leq \|\sigma(\alpha) \cdot \vec{n}\|_{0,\Gamma_i} \|\alpha_2\|_{0,\Gamma_i},$$

using these last estimates, (56) becomes

$$\|\alpha_1\|_{0,\Gamma_i}^2 \leq 12 \times 8|\Gamma_i|^2 \|L(\alpha)\|_{0,S_{\Gamma_i}}^2, \quad \|\alpha_2\|_{0,\Gamma_i}^2 \leq 12|\Gamma_i| \|\sigma(\alpha) \cdot \vec{n}\|_{0,\Gamma_i} \|\alpha_2\|_{0,\Gamma_i}.$$

Using (49) and assumption (54), we can find δ_5 and δ_6 small enough such that

$$\|\alpha_1\|_{0,\Gamma_i} \leq \delta_5, \quad \|\alpha_2\|_{0,\Gamma_i} \leq 12|\Gamma_i| \|g_i\|_{0,\Gamma_i} + \delta_6,$$

for all i . Hence, combining these two estimates, we obtain

$$\|u_{2,i}\|_{0,\Gamma_i} \leq \|\alpha_1\|_{0,\Gamma_i} + \|\alpha_2\|_{0,\Gamma_i} \leq \delta_9 + 16|\Gamma_i| \|g_i\|_{0,\Gamma_i}$$

with $\delta_9 = \delta_5 + \delta_6$ arbitrary small.

□

4 Proof of theorem 1

We are ready now to present a proof of the main theorem. It uses, principally, lemma (6) and lemma (7).

Proof. Step 1: Let u_1 be as defined in lemma (6), it is easy to check that it satisfies

$$2\mu \int_{\Omega} \varepsilon(u_1)\varepsilon(v) \, dx + \lambda \int_{\Omega} \operatorname{div} u_1 \operatorname{div} v \, dx = \int_{\Omega} f_1 v \, dx$$

for all $v \in H_0^1(\Omega)$. Choose $v = u_1$ and use Cauchy-Schwarz inequality

$$2\mu \|\varepsilon(u_1)\|_{0,\Omega}^2 + \lambda \|\operatorname{div} u_1\|_{0,\Omega}^2 \leq \|f_1\|_{0,\Omega} \|u_1\|_{0,\Omega}$$

Using Korn's inequality relatively to the case of homogeneous Dirichlet condition on one hand, and Poincaré inequality on the other hand, yield

$$\frac{\mu}{2} \|\nabla u_1\|_{0,\Omega}^2 \leq \|f_1\|_{0,\Omega} \frac{d(\Omega)}{2} \|\nabla u_1\|_{0,\Omega},$$

using (iv) of lemma (6), we obtain

$$\mu \|\nabla u_1\|_{0,\Omega} \leq d(\Omega) \|f^p\|_{0,\Omega} + d(\Omega) \frac{\delta_0}{m}. \quad (57)$$

Fix i , $1 \leq i \leq m$. Let $u_{2,i}$ be such as defined in lemma (7), it is easy to check that $u_{2,i}$ satisfies

$$2\mu \int_{\Omega} \varepsilon(u_{2,i})\varepsilon(v) \, dx + \lambda \int_{\Omega} \operatorname{div} u_{2,i} \operatorname{div} v \, dx = \int_{\Omega} L(u_{2,i})v \, dx + \int_{\Gamma-\Gamma_0} g_i v \, d\sigma$$

for all $v \in V$. Choose $v = u_{2,i}$ and use Cauchy-Schwarz to obtain

$$2\mu \|\varepsilon(u_{2,i})\|_{0,\Omega}^2 + \lambda \|\operatorname{div} u_{2,i}\|_{0,\Omega}^2 \leq \|L(u_{2,i})\|_{0,\Omega} \|u_{2,i}\|_{0,\Omega} + \|g_i\|_{0,\Gamma_i} \|u_{2,i}\|_{0,\Gamma_i},$$

using estimate (52)

$$2\mu \|\varepsilon(u_{2,i})\|_{0,\Omega}^2 \leq \|L(u_{2,i})\|_{0,\Omega} d(\Omega) \|\nabla u_{2,i}\|_{0,\Omega} + \|g_i\|_{0,\Gamma_i} \|u_{2,i}\|_{0,\Gamma_i}.$$

On the other hand, there exists constants c_k , c_p and c_t such that

$$\|\nabla u_{2,i}\|_{0,\Omega} \leq c_p \|L(u_{2,i})\|_{0,\Omega} + c_t c_t \|g_i\|_{0,\Gamma_i}$$

thus

$$\begin{aligned} & 2\mu \|\varepsilon(u_{2,i})\|_{0,\Omega}^2 \\ & \leq d(\Omega) \|L(u_{2,i})\|_{0,\Omega} c_k (c_p \|L(u_{2,i})\|_{0,\Omega} + c_t \|g_i\|_{0,\Gamma_i}) + \|g_i\|_{0,\Gamma_i} \|u_{2,i}\|_{0,\Gamma_i}; \end{aligned} \quad (58)$$

since, following (30) and (48), $\|g_i\|_{0,\Omega}$ are uniformly bounded with respect to ϵ then, using (49)

$$\begin{aligned} 2\mu\|\varepsilon(u_{2,i})\|_{0,\Omega}^2 &\leq d(\Omega)\tau c_k(c_p\tau + c_t\|g_i\|_{0,\Gamma_i}) + \|g_i\|_{0,\Gamma_i}\|u_{2,i}\|_{0,\Gamma_i} \\ &\leq d(\Omega)\tau c_k(c_p\tau + c_t(\|g\|_{0,\Gamma-\Gamma_0} + \delta_6 + \frac{\delta_1}{m})) + \|g_i\|_{0,\Gamma_i}\|u_{2,i}\|_{0,\Gamma_i}; \end{aligned} \quad (59)$$

pose

$$\delta_7^2 := d(\Omega)\tau c_k(c_p\tau + c_t(\|g\|_{0,\Gamma-\Gamma_0} + \delta_6 + \frac{\delta_1}{m})),$$

it can be made, thanks to estimate (49), as small as desired. Applying (53), (30) and (48), estimate (59) becomes

$$\begin{aligned} 2\mu\|\varepsilon(u_{2,i})\|_{0,\Omega}^2 &\leq \delta_7^2 + 16|\Gamma_i| \|g_i\|_{0,\Gamma_i}^2 + \delta_9\|g_i\|_{0,\Gamma_i} \\ &\leq \delta_7^2 + 16|\Gamma_i| \|g_i\|_{0,\Gamma_i}^2 + \delta_9(\frac{\delta_1}{m} + \delta_6 + \|g\|_{0,\Gamma_i}) \\ &\leq \frac{\delta_{10}^2}{m^2} + 16|\Gamma_i| \|g_i\|_{0,\Gamma_i}^2, \end{aligned}$$

where $\frac{\delta_{10}^2}{m^2} := \delta_7^2 + \delta_9(\frac{\delta_1}{m} + \delta_6 + \|g\|_{0,\Gamma_i})$, then by simplifying,

$$\sqrt{2\mu}\|\varepsilon(u_{2,i})\|_{0,\Omega} \leq \frac{\delta_{10}}{m} + 4|\Gamma_i|^{\frac{1}{2}} \|g_i\|_{0,\Gamma_i}. \quad (60)$$

One should notice that, by definition of the constants δ_6 , δ_7 and δ_9 , the constant δ_{10} can be made as small as possible.

Step 2: Since the deformation $\varepsilon(u_{2,i})$ is a linear application with respect to the first derivatives of $u_{2,i}$ then, with the same notations as in (50) and by using (51), we have

$$\|\varepsilon(\tilde{u}_{2,i})\|_{0,\mathbb{R}^{2+}} = \|\varepsilon(\tilde{u}_{2,i})\|_{0,\Omega} = \|\varepsilon(u_{2,i})\|_{0,\Omega_i}.$$

Applying the estimate stated in (corollary 1.2.2, [7]) to $\tilde{u}_{2,i}$ gives

$$\frac{1}{2} \times \|\nabla u_{2,i}\|_{0,\Omega} = \frac{1}{2} \times \|\nabla \tilde{u}_{2,i}\|_{0,\mathbb{R}^{2+}} \leq \|\varepsilon(\tilde{u}_{2,i})\|_{0,\mathbb{R}^{2+}},$$

thus, (60) becomes

$$\frac{\sqrt{\mu}}{\sqrt{2}} \|\nabla u_{2,i}\|_{0,\Omega} \leq \frac{\delta_{10}}{m} + 4|\Gamma_i|^{\frac{1}{2}} \|g_i\|_{0,\Gamma_i},$$

Young inequality yields

$$\frac{\sqrt{\mu}}{\sqrt{2}} \|\nabla u_{2,i}\|_{0,\Omega} \leq \frac{\delta_{10}}{m} + 2(|\Gamma_i| + \|g_i\|_{0,\Gamma_i}^2).$$

Using approximation result (30), we have

$$\frac{\sqrt{\mu}}{\sqrt{2}} \|\nabla u_{2,i}\|_{0,\Omega} \leq \frac{\delta_{10}}{m} + 4(|\Gamma_i| + \|g_p^\epsilon\|_{0,\Gamma_i}^2 + \frac{\delta_1^2}{m^2}).$$

Summing over $i = \overline{1, m}$ we obtain using triangular inequality

$$\frac{\sqrt{\mu}}{\sqrt{2}} \|\nabla u'_2\|_{0,\Omega} \leq \frac{\sqrt{\mu}}{\sqrt{2}} \sum_i \|\nabla u_{2,i}\|_{0,\Omega} \leq \delta_{10} + 4|\Gamma| + 4\|g_p^\epsilon\|_{0,\Gamma}^2 + 4\delta_1^2. \quad (61)$$

Finally, combining (57) and (61) we get

$$\begin{aligned} & \sqrt{\mu} \|\nabla(u_1 + u'_2)\|_{0,\Omega} \\ & \leq \frac{\delta_0}{m} d(\Omega) + \sqrt{2}\delta_{10} + 4\delta_1^2 + d(\Omega) \|f^p\|_{0,\Omega} + 8(|\Gamma| + \|g_p^\epsilon\|_{0,\Gamma}^2), \end{aligned}$$

considering (31) and posing $\delta_{11} := \frac{\delta_0}{m} d(\Omega) + \sqrt{2}\delta_{10} + 4\delta_1^2$,

$$\sqrt{\mu} \|\nabla u_\epsilon^p\|_{0,\Omega} \leq \delta_{11} + \sqrt{\mu}\delta_2 + d(\Omega) \|f^p\|_{0,\Omega} + 8(|\Gamma| + \|g_p^\epsilon\|_{0,\Gamma}^2). \quad (62)$$

Use (48), estimate (62) becomes

$$\|\nabla u_\epsilon^p\|_{0,\Omega} \leq \frac{1}{\sqrt{\mu}} [8\delta_6^2 + \delta_{11} + \sqrt{\mu}\delta_2 + d(\Omega) \|f^p\|_{0,\Omega} + 8(|\Gamma| + \|g\|_{0,\Gamma}^2)], \quad (63)$$

using (25) and (i) of (27), estimate (63) becomes

$$\|\nabla u_\epsilon\|_{0,\Omega} \leq \frac{1}{\sqrt{\mu}} \left[\frac{1}{2} + 8\delta_6^2 + \sqrt{\mu}\delta_2 + \delta_{11} + d(\Omega) \|f\|_{0,\Omega} + 8(|\Gamma| + \|g\|_{0,\Gamma}^2) \right].$$

By adequately choosing the positive numbers δ'_j 's, we immediately get

$$\|\nabla u_\epsilon\|_{0,\Omega} \leq \frac{1}{\sqrt{\mu}} [1 + d(\Omega) \|f\|_{0,\Omega} + 8(|\Gamma| + \|g\|_{0,\Gamma}^2)]. \quad (64)$$

We conclude the theorem for u by applying (a) of lemma (4) on one hand, and (iii) of remark (5) on the other hand. \square

Finally; in order to get the explicit H^1 estimate of u_ϵ , and so that of u , we use the poincaré inequality (52) to bound $\|u\|_{0,\Omega}$ at one hand and the estimate (7) at the other hand.

Conclusion

In the point of view of numerical analysis, estimate of theorem (1) is interesting. Indeed, error estimates in finite element method of the type

$$\|u - u_h\|_{0,\Omega} \leq Ch \|\nabla u\|_{0,\Omega}$$

involve the quantity $\|\nabla u\|_{0,\Omega}$. Assuming that the constant C can be explicitly computed, then it is possible to explicitly bound $\|\nabla u\|_{0,\Omega}$ which implies a better estimate of $\|u\|_{0,\Omega}$.

Another interesting feature of the estimate (7) that makes it effective is that it does not depend on the characteristic parameters of the polygonal domain Ω , namely, the edges's length, their number as well as the measures of the angles. The estimate is therefore indifferently applicable to all polygons. All this allows the possibility to generalize this result, by substantial approximation, to a C^1 class domain.

Some clarifications

Regarding the application of the main result established in [11], we note the following facts. The part of theorem 2.1 in [11] used in the proof of lemma (7) is the equivalence between the following two assertions.

1) X_i is approximated by smooth functions with support away from $\Gamma - \Gamma_i$.

$$2) \lim_{r \rightarrow 0} \frac{1}{|B(x, r)|} \int_{B(x, r) \cap \Omega} |X_i(y)| dy = 0.$$

To effectively apply this result, we need to show that the fact $X_i = 0$ on $\Gamma - \Gamma_i$ implies 2). Indeed, let $x \in \Gamma - \Gamma_i$. We assume for convenience, that x coincide with the origin $(0, 0)$ of \mathbb{R}^2 . Since $\partial\Omega$ is a polygon then, there exists $c > 0$ independent of r such that

$$|B(0, r) \cap \Omega| = c|B(0, r)|.$$

On the other hand, the function X_i solution of problem (P_1) is continuous on $\overline{\Omega}$. One can see this using the following argument: according to the definition of u_ϵ^p , $\overline{X_i}|_{\partial\Omega} \in C^\infty(\partial\Omega)$. Applying the Whitney extension theorem (see [12]), one can find $\overline{X_i} \in C^\infty(\overline{\Omega})$ that coincide with X_i on Γ . Thus, $X_i - \overline{X_i} \in H^1(\Omega)$ solves the following problem

$$\begin{cases} L(X_i - \overline{X_i}) = -L(\overline{X_i}) & \text{a.e in } \Omega, \\ X_i - \overline{X_i} = 0 & \text{on } \cup_i \Gamma_i. \end{cases}$$

Since the boundary Γ of Ω satisfies the conditions (5) and $L(\overline{X_i}) \in L^2(\Omega)$ then, $X_i - \overline{X_i} \in H^{\frac{3}{2}+\nu}(\Omega)$. Consequently

$$X_i = (X_i - \overline{X_i}) + \overline{X_i} \in H^{\frac{3}{2}+\nu}(\Omega)$$

as well. Furthermore, by an adequate Sobolev embedding, $X_i \in C^0(\overline{\Omega})$ and thus, the claimed continuity. The Lebesgue differentiation theorem yields:

$$\begin{aligned} \lim_{r \rightarrow 0} \frac{1}{|B(x, r)|} \int_{B(x, r) \cap \Omega} |X_i(y) \, dy| &= \lim_{r \rightarrow 0} \frac{1}{|B(0, r)|} \int_{B(0, r) \cap \Omega} |X_i(y) \, dy| \\ &\leq \lim_{r \rightarrow 0} \frac{1}{|B(0, r) \cap \Omega|} \int_{B(0, r) \cap \Omega} |X_i(y) \, dy| \\ &= |X_i(0)| = 0, \end{aligned}$$

we infer that assertion 2) holds for all $x \in \Gamma - \Gamma_i$ and thus, $C_{1,2}$ -almost everywhere. Where $C_{1,2}$ refers to the 2 - capacity of the set $\Gamma - \Gamma_i$.

Finally, one can show continuity of the function Y_i that solves problem P_4 by remarking that $\sigma(Y_i) \cdot \vec{n} = g_p^\epsilon \in H^{\frac{1}{2}}(\Gamma - \Gamma_i \cup \Gamma_0)$ and by applying the same argument used for justifying the regularity of the solution u of problem (1), one easily infer that $Y_i \in C^0(\overline{\Omega})$ and gets the same conclusions as for X_i .
