#### Abstract

Microelements play important roles in improving crop productivity and quality. Two traditional methods of providing micronutrients are soil and foliar application, yet the cost involved and phytotoxicity risks poses a major challenge in most global agricultural areas. Nutri-priming represents thus a very promising and viable alternative to ensure that the plants' requirements for micronutrients are met. This paper explores the Mo-priming effects on the germination, growth and yield components of common bean (*Phaseolus vulgaris* L.). In order to accomplish this research objective, our study is divided in two phases. The first phase seeks to determine the effects of two durations (5 and 10 hours) of Mo-priming on the germination parameters. Then, a greenhouse pot experiment was conducted with primed seeds showing better germination performance to assess the effects of Mo-priming on certain parameters related to biological nitrogen fixation and crop yield. Five seed pretreatments were studied, namely, 0, 0.025, 0.05, 0.1 and 0.2% of ammonium heptamolybdate ((NH<sub>4</sub>)<sub>6</sub>Mo<sub>7</sub>O<sub>24</sub>.4H<sub>2</sub>O). Unprimed seeds treated with or without the recommended dose through a soil application were used as controls. Hydropriming is sufficient to improve seed germination performance. However, 0.1% Mo-priming for 10 hours improved the net CO<sub>2</sub> assimilation rate, chlorophyll content and biological nitrogen fixation. Six times more nitrogen was fixed (65.8 kg ha<sup>-1</sup>) in these plants than in the controls. Additionally, grain yield increased by 115% compared to the negative control. Thus, compared to soil intake, nutripriming was a very efficient experimental method.

#### 1. Introduction

Although agriculture is one of the main contributors to the economy of Morocco, fertilizer use is low and only meets approximately 50% of the real needs (El Gharous and Boulal, 2016), with nearly 618 500 tons year<sup>-1</sup> of nutrients, representing an average intake of 71.1 kg ha<sup>-1</sup> (World Bank, 2018). While many large, modern farms have largely integrated fertilizer into their production, small farmers have not implemented this practice, but present an enormous growth potential. In addition, the majority of Moroccan farmers use only the NPK trilogy. This practice might be due to the high cost of microelements and farmer ignorance concerning their existence and/or importance. Microelements, which are required in very small quantities, play important roles in improving crop productivity and quality (Marschner, 2011). New methods for microelement application must be implemented to 1) take advantage of the improved productivity facilitated by the use of microelements, without negatively impacting the quality of the environment, and 2) encourage farmers to use these elements. Two traditional methods of providing micronutrients are soil and foliar application. However, in the case of soil application, the availability of microelements may be reduced by the complexity of controlling soil parameters like alkaline soil pH, calcareousness, low organic matter and rapid adsorption on soil particles (Alloway, 2008). Moreover, the plant uptake was restricted at low moisture (Yadegari, 2016). These constraints disappear or are limited when the fertilizers are foliar-sprayed. However, multiple applications are often necessary (increasing application costs) along with the risk of phytotoxicity (Marschner, 2011). As a low-risk application, nutri-priming represents a good alternative to ensure that the plants' requirements for micronutrients are met.

Priming is defined as a simple technique that involves soaking seeds in water or an osmotic solution followed by redrying to its original weight (Lutts et al., 2016). Used empirically to overcome dormancy, it includes the absorption of water at a sufficient level to accomplish preparatory metabolic events preceding the radicle emergence. In the case of nutri-priming, seeds are primed in nutrient solutions (Farooq et al., 2012), which combines the biochemical effect of priming with water and the nutritional effect of the applied element. It is an easy, inexpensive, cost-effective and environmentally friendly method (Ghassemi-Golezani et al., 2008; Rehman et al., 2018) that may offer an attractive option to farmers. Several microelements show good nutri-priming ability in various crops, including boron in Stevia (Shahverdi et al., 2017), manganese and zinc in wheat (Rehman et al., 2018) and soybean and zinc in maize (Imran et al., 2017b).

In addition to the problems associated with the micronutrient assimilation efficiency, one of the major problems facing farmers in developing countries is the heterogeneity of seedling emergence under inappropriate conditions for germination. This issue becomes more noticeable in arid and semi-arid regions, and particularly in recent years with the impacts of climate change (van der Esch et al., 2017, Porkka et al., 2017). In fact, seeds are sometimes sown in seed beds with an unfavorable humidity because of insufficient rain, causing a heterogeneous emergence. Nevertheless, accelerated and homogenous germination is required for better crop establishment, efficient use of seed reserves, and ultimately, increased final yields (Finch-Savage and Bassel, 2016). Priming is an effective method for improving germination and its speed, as well as rapid emergence under favorable and stress conditions, which, due to the induction of various biochemical changes, is essential for initiating germination processes in seeds during the pretreatment (Farooq et al., 2012).

The nutrient content of seeds plays an important role in the germination process and growth. During early stages of growth, plants use mineral nutrients derived partly from seed reserves and partly from the soil (Rengel and Graham, 1995). During the germination process, seed reserve are degraded by enzymes and transported to the growing embryo (Fincher, 1989). In this stage, external sources have less of an effect on plant development. Certainly, sufficient mineral nutrient reserves in the seed are needed to ensure proper seedling growth until the root system is functional. However, these nutrients can promote the growth of plants in later stages (Imran et al., 2017a) and thus contribute to improving growth parameters, yield and even the seed quality (Imran et al., 2015).

Molybdenum (Mo) plays an important role in nitrogen metabolism in plants, particularly in legumes. It functions as a cofactor for nitrogenase enzymes, catalyzing the redox reaction to convert atmospheric nitrogen to ammonium ( $NH_4^+$ ) (Kaiser, 2005). It is also part of the prosthetic group of nitrate reductase, the key enzyme required for nitrogen assimilation in plants. Therefore, plant nitrogen metabolism is closely related to the assimilable fraction of Mo in soil, particularly for legumes (Mendel and Hänsch, 2002).

This study explores the Mo-priming effects on the germination, growth and yield components of common bean (*Phaseolus vulgaris* L.). Particular attention will be paid to biological nitrogen fixation (BNF), because common beans have lower symbiotic fixation efficiency (Toshiyuki and Shigekata, 1991; Peoples et al., 2009). In order to accomplish this objective, we firstly evaluate the effects of two Mo-priming durations (5 and 10 hours) on germination parameters. Then, a greenhouse pot experiment was conducted with primed seeds

showing better germination performance to assess the effects of Mo-priming on parameters related to biological nitrogen fixation and crop yield

## 2. Materials and methods

# **Nutri-priming treatment and germination assay**

Five treatments, 0 (distilled water) and 0.025, 0.05, 0.1 and 0.2% ammonium molybdate [(NH<sub>4</sub>)<sub>6</sub>Mo<sub>7</sub>O<sub>24</sub>.4H<sub>2</sub>O], were defined to study the effect of Mo-priming on germination and growth traits of common bean (*Phaseolus vulgaris*). Healthy seeds with a similar shape and size were selected and divided into batches (125 ± 2 g, approximately 300 seeds for each treatment). Each batch was weighed and immersed in a 1% sodium hypochlorite solution for 5 min to remove pathogenic microorganisms. After three surface washes with distilled water, seeds were primed at room temperature (25±1°C) in an aerated treatment solution using an air pump at a ratio of 1:5 (w:v). Each treatment was administered for two priming durations: 5 and 10 hours. At the end of priming process, the seeds were weighed (to determine the amount of solution absorbed) and then dried to the initial moisture content at 25±3°C. The hydration capacity (HC) and hydration index (HI) were then calculated using following formulas (1) and (2), respectively:

Twenty treated and nontreated seeds were allowed to germinate separately in 9 cm Petri dishes containing Whatman filter paper N°1 moistened with 20 ml of distilled water. Three replicates were used for each treatment. Petri dishes were then incubated in the dark at a constant temperature of 25°C. The germinated seeds were counted, removed and the paper moistened each day for seven days. The speed of germination (SG) and final germination percentage (FGP) were calculated using formulas (3) and (4) (Maguire, 1962):

## **Determination of Mo contents in primed bean seeds**

Mo contents were determined in treated and untreated seeds. Approximately 2 g of ground seed samples were weighed in a porcelain capsule and placed in a muffle furnace for incineration at 550°C for 6 hours. The ash was dissolved in 5 ml of HNO<sub>3</sub> (5 N) and subsequently evaporated to dryness on a hot plate at 40°C for at least 2 hours. Then, samples were extracted with 30 ml of a 1:5 mixture of HNO<sub>3</sub> (1 N) and HCl (0.1 N). After adding 5 ml of LaCl<sub>3</sub> (0.1 N), the final solution was adjusted to 100 ml with HNO<sub>3</sub> (2%). Mo concentrations were measured using inductively coupled plasma spectrometry (ICP). All analyses were conducted in triplicate. For each treatment, three replicates were performed. The seed Mo content was calculated as follows (5) (Imran et al., 2017a):

## Plant material, growth conditions and experimental setup

The soil used in this study was a sandy soil (87.8% sand) taken from within the top 30 cm of the soil layer of an uncultivated agricultural plot in the rural commune of Ait Yaazem in the province of El Hajeb, Morocco (33°44′59″ N latitude, 5°34′29″W longitude) (Fig. 1). The physico-chemical characteristics of the soil are detailed in Table 1. The experiment was performed under a shelter at the National School of Agriculture of Meknes (Meknes-Fes Region, Morocco). Certified seeds of the Michelet bean cultivar were purchased from a local seed dealer and planted in pots 30 cm in height with bottom and top diameters of 20 and 16 cm, respectively. The pots were filled with a 5 cm layer of gravel at the bottom to improve drainage and 6 kg of dried soil.

According to the results of germination assays, seeds that had been primed for 10 hours were chosen for cultivation. On March 26, 2018, four seeds were planted in each pot. The plants were allowed to grow under natural conditions and were later thinned to one healthy plant per pot. Seedlings were irrigated with tap water to 70% of the field capacity three times a week or twice a day in warm weather. The experiment was established using a randomized

complete block design (RCBD) with 5 blocks and 7 treatments: M0, M1, M2, M3 and M4 correspond to seeds primed in 0, 0.025, 0.05, 0.1 and 0.2% ammonium molybdate, respectively. Unprimed seeds without (NC: negative control) or with (PC: positive control) the recommended dose provided by a soil application were used as controls. For PC, the recommended dose applied was 1 kg ha<sup>-1</sup> of Mo (approximately 0.25 ppm) in the form of ammonium molybdate at the V4 stage (third trifoliate leaf) (Bhuiyan et al., 2008). A schematic illustrating the experimental setup is summarized in Figure 2. As the bean is a legume capable of fixing atmospheric nitrogen, a small amount of nitrogen fertilizer (starter-N) was applied. Thus, NPK (20-60-80 kg ha<sup>-1</sup>) were provided as a basic fertilizer before sowing. At the flowering stage, all treated plants received 30 kg ha<sup>-1</sup> of K<sub>2</sub>O in order to correct the K deficiency.

During cultivation, growth parameters (plant height, stem diameter and leaf number) were measured every 10 days from emergence to harvest. The relative growth rate (RGR) was calculated using equation (6) to quantify the rate at which the plant height increased at specific time points (James and Richards, 2006):

# Measurements of photosynthesis and chlorophyll contents

At the seed filling stage, leaf gas exchange measurements were recorded *in situ* with a Li-COR6400 portable photosynthesis system (LI-COR-6400, LI-COR Biosciences, Inc., Lincoln, Nebraska, USA), connected to a 2 x 3 cm leaf chamber and a red-blue diode illuminator. Measures of the  $CO_2$  assimilation rate  $(A_n)$  in relation to calculated stomatal conductance  $(g_{sw})$  and transpiration  $(T_r)$  were measured from 9:00 to 15:00 on the middle leaf of each plant. Leaf chamber conditions during measurements were: air flow rate 400  $\mu$ mol s<sup>-1</sup>, leaf temperature 25°C,  $CO_2$  concentration 400  $\mu$ mol s<sup>-1</sup>, and photon flux density 200  $\mu$ mol m<sup>-2</sup> s<sup>-1</sup>. After a 5-minute period to allow the leaves to acclimate to the chamber conditions, ten data logs were recorded at 1 min intervals.

After measuring leaf gas exchange, leaves were harvested and the contents of photosynthetic pigments (chlorophyll a and b) were analyzed using a spectrophotometer (Jenway 6315 UV/Visible) in 100% acetone extracts prepared using the method reported by

Shabala and colleagues (Shabala et al., 1998). Chlorophyll concentrations are reported as μg g<sup>-1</sup> of fresh weight (FW).

# Measurements of other growth, yield and biological nitrogen fixation parameters

At harvest, the aerial part of each plant was cut and the root portion was carefully removed from the pot, separated from the adhering soil with a low pressure water jet and washed with distilled water. After wiping the roots with absorbent paper, the root length was measured. Then, the fresh weight of each part was determined. All samples were placed in a 60°C drying oven for 48 hours. The dried samples were weighed and then ground into a fine powder for Kjeldahl nitrogen determination. All yield components were calculated per plant to determine the grain yield per plant, and subsequently the grain yield per hectare, including the pod number, grain number and 1000-grain weight.

At harvest, the total nodule number was determined and three groups of ten nodules were randomly removed from each plant to estimate the specific nodular weight and the total nodular weight. The amount of biologically fixed nitrogen (BFN) was calculated based on the N supply, the soil richness and the total amount of N fixed by the plant using equation (7)

## Statistical analysis

Values are presented as the means  $\pm$  SD (n=5). Statistical analyses were performed with the SPSS software (version 20). Data were first tested for normality and homogeneity of variance to assess the statistical demands. The data were then analyzed using one-way analysis of variance (ANOVA) followed by the Student-Newman-Keuls (SNK) multiple comparison test. A p value of <5% (p<0.05) was considered statistically significant.

## 3. Results

The culture cycle extends from March 26 to June 19, 2018. The emergence coincided with a period marked by an average temperature of 16.1°C, while the flowering-pod formation stage (from May 20) was characterized by an average temperature of 26.5°C.

Generally, the interval fluctuations were [7.9 - 11°C], [16.1 - 26.7°C] and [23.6 - 42.8°C] for the minimum, average and maximum temperatures respectively.

# Seed hydration and germination indices and Mo contents of primed seeds

The data recorded for the hydration indices (HC and HI), germination indices (SG and FGP) and Mo contents are presented in Table 2. HC and HI fluctuated between 0.32 and 0.51 g of solution per seed and between 0.73 and 1.16 g of solution per g of seeds, respectively. These two indices are strongly influenced by the priming duration. In fact, the seed absorption capacity of the solution was 43% higher when the priming duration doubled.

All treatments resulted in a higher FGP than the control, with the exception of the 0.2% treatment for 10 hours, which produced a similar value to the control (82%). In addition, the highest germination percentage (100%) was obtained when seeds were soaked in 0.1% ammonium molybdate for 10 hours. However, no significant differences were observed between these treatments. With the exception of 0.2% treatment, the statistical analysis revealed a significant increase in SG in response to all treatments compared to the control (untreated seeds). The highest value (18.9) was recorded for the 0.1% treatment for 10 hours, which represents an improvement of 47% compared with the control. For both priming durations, the 0.2% treatment had no effect on this parameter. Figure 3 highlights the priming effects on germination kinetics. A ten hour priming duration allowed us to obtain the highest germination rate during the first 12 hours, particularly with water, whose germination rate was 49% compared with oscillating values ranging from 25 to 30% for other treatments. For the 5 hour priming duration, the germination rate did not exceed 13%, while the untreated seeds did not germinate for up to 12 hours. After 24 hours and with the exception of the 0.2% treatment, all primed seeds were germinated at rate greater than 50% for both durations and at a rate greater than 80% for the 10 h priming duration, in contrast to the control whose first day germination rate did not exceed 20%.

Compared to the natural seed reserves, primed bean seeds showed significantly increased Mo contents in proportion to the priming concentration, whereas the priming duration only positively correlated with the highest concentration of priming solution (0.1 and 0.2%). In fact, seed enrichment was 16-, 27-, 65- and 110-fold higher after Mopriming for 5 hours in 0.025, 0.05, 0.1 and 0.2% solutions, respectively, than the initial content (2.1 µg seed<sup>-1</sup>). The Mo contents increased to 179.9 and 372.4 µg seed<sup>-1</sup> after 10 hours of priming in 0.1 and 0.2% ammonium molybdate, respectively. Thus, a large amount of Mo

accumulated during the first 5 hours, representing 91, 83, 76 and 62% of the seed contents primed for 10 hours in 0.025, 0.05, 0.1 and 0.2% treatments, respectively.

## **Growth parameters**

 Figure 4 shows the evolution of the increase in the bean plant height (stem height and RGR). No significant differences were observed between treatments during all stages. In addition, the same growth evolution pattern was observed in response to all treatments. At harvest, the minimum height growth was recorded in M4 plants, with an average of 43.9 cm, and the highest value (51.4 cm) was observed for M2 plants (Table 3). For all treatments, the highest RGR was recorded during the 10-20 day interval after emergence and then decreased until the end of the study. Likewise, the leaf number, stem diameter, total fresh biomass and total dry biomass did not show any significant difference between treatments. Nevertheless, a significantly greater root length was measured in M1 and M2 plants, which showed an increase of approximately 66.6 and 50% compared to the NC, respectively. However, few differences were observed between plants subjected to these treatments and plants derived from seeds primed in water (M0) and those that received molybdic fertilization by soil application (PC). Additionally, a regressive effect of Mo-priming was noted in M4 plants, but the reported value was similar to the NC plants.

## Gas exchange and chlorophyll content

The effects of Mo-priming on photosynthetic parameters are shown in Figure 5. A<sub>n</sub> increased significantly in M2 and M3 plants and the values obtained from M2 plants were similar to PC plants. The highest average, which was calculated for M3 plants, was 113 and 48% greater than NC and PC, respectively. In contrast, this parameter was reduced in plants treated with the highest concentration of priming solution compared to M2 and M3, but a statistically significant difference was not observed compared with NC. Moreover, A<sub>n</sub> measured in M0 and M1 plants remained similar to NC values. T<sub>r</sub> and g<sub>sw</sub> also showed the same trend as A<sub>n</sub>. In contrast, C<sub>i</sub> was inversely correlated with A<sub>n</sub>. Thus, C<sub>i</sub> decreased significantly in PC, M2 and M3 plants compared to the NC plants. The highest average value (248 µmol CO<sub>2</sub> mol<sup>-1</sup>) was observed in M4 plants. Significantly increased chlorophyll contents were only observed in the leaves of M3 plants (Fig. 6). Furthermore, no significant differences were noted between all other treatments.

## **Biological nitrogen fixation**

Table 4 shows a significant increase in the total nodule number of M1, M2 and M3 plants compared to both controls. However, no differences were observed between these three treatments, with values ranging from 335 to 439 nodules per plant. In M4 plants, this

parameter was reduced but the values were the same as those recorded in plants from unprimed (NC and PC) and hydroprimed seeds (M0). Similar to the number of nodules per plant, the specific and total nodular weights exhibited the same trends. Significant increases in the amount of fixed nitrogen per plant were observed in the M3 plants (328.9 mg plant<sup>-1</sup>), followed by the M1 and M2 plants, with an average of 202.7 mg plant<sup>-1</sup>. However, the quantity fixed by M4 plants remained significantly lower (101.4 mg plant<sup>-1</sup>) than in plants that received the other Mo-priming treatments but was significantly superior to the quantities fixed by both controls (55.6 mg plant<sup>-1</sup>). In contrast, BNF was reduced by 38% in plants that germinated from hydroprimed seeds compared to controls.

## **Yield components**

Both Mo fertilization methods induced slight increases in all yield components (Table 5). However, the increases were only significant in the M3 plants, which produced the highest grain number per pod (4.4), an increase of 41.2% compared with NC plants. Additionally, the maximum yield was found in M3 plants, with an average of 13.8 q ha<sup>-1</sup>, representing 115 and 49% increases compared to NC and TP plants, respectively. The lowest yield was recorded for the M4 plants, with an average of 6.2 q ha<sup>-1</sup>.

## 4. Discussion

## **Mo-priming effect on germination**

The priming solution concentration did not affect the seed absorption capacity for the same priming duration, potentially due to the low osmotic potential of the priming solutions, which did not slow the absorption. In contrast, seed hydration was improved by increasing the treatment duration to 10 hours, and thus we concluded that the first phase of early germination (imbibition) had not yet been completed after soaking for 5 hours.

The speed of germination is important for successful crop establishment (Finch-Savage and Bassel, 2016). All treatments, except for seeds primed in the highest Mo concentration, resulted in faster germination. However, no difference was detected between the seeds primed in water and those primed with ammonium molybdate solutions. Thus, this effect is due to the priming technique. The acceleration of primed seed germination is due to 1) a reduced imbibition time (Brocklehurst and Dearman, 2008), which is explained by a better water absorption efficiency due to aquaporin activation (Boursiac et al., 2005), and 2) the rapid stimulation of many metabolic processes involved in the first two phases of germination (imbibition and germination sensu stricto) (Wahid et al., 2008). In fact, the seeds shortened the first two phases and rapidly entered the growth phase by protruding the radicle.

Additionally, seed priming in water or osmotic solutions has been reported to trigger processes related to germination by activating ATPase and other enzymes promoting ATP availability (Nasri et al., 2011). During this phase, the acceleration of germination is also associated with the increased respiration contributing to rapid ATP production. This energy source then allows the mobilization of seed reserves and macromolecules, resulting in embryo elongation. Thus, the increased speed of germination is attributed to early mobilization of reserves due to the activation of  $\alpha$  and  $\beta$  amylases (Lee and Kim, 2000). For example, according to Kata et al. (2014), hydropriming increases  $\alpha$ -amylase activity, resulting in better mobilization of stored carbohydrates.

The negative effect of the highest concentration on speed germination might be explained by ionic toxicity, either by Mo ions and/or excess nitrogen. Indeed, the seeds primed in 0.2% ammonium molybdate displayed a greenish color, regardless of the priming duration. The toxic effect of Mo might also be related to the increased levels of abscisic acid (ABA) in seeds, which is not only responsible for the desiccation and maturation of seeds but also for the inhibition of germination in dormant seeds. Mo is an aldehyde oxidase cofactor that catalyzes the final step of abscisic aldehyde oxidation to ABA (Mendel and Haensch, 2002). Thus, the highest concentration of Mo probably increased the ABA level to a sufficient concentration that would delay but not inhibit germination.

Our germination test results are consistent with several studies confirming this positive effect of priming, including hydropriming, on improving the seed germination performance of *Cicer arietinum*, *Lens culinaris* (Johnson et al., 2005), *Vigna radiata* (Umair et al., 2011) and *Phaseolus vulgaris* (Ghassemi-Golezani et al., 2010).

According to the hydration indices, germination indices and Mo contents of primed seeds, a 10 hour priming duration allowed seeds to enter the activation phase. At priming durations ranging from 5 to 10 hours, we noticed a slowing of solution absorption and a slight increase in the speed and rate of germination.

# Effect of Mo-priming on growth parameters

Common bean (*Phaseolus vulgaris* L.) has a lower efficiency of BNF (15 kg ha<sup>-1</sup>) than other legumes, such as soybean (137 kg ha<sup>-1</sup>) (Martinez-Romero, 2003; Peoples et al., 2009). Moreover, Mo deficiency negatively affects the nitrogenase enzyme system present in bacteroids (Kaiser et al., 2005) and subsequently limits BNF under field conditions (Campo et al., 2009). Thus, the application of Mo fertilizers can enhance BNF. Bean fertilization with Mo is accomplished either by soil application or by foliar feeding. With the first method, the

Mo availability may be reduced due to the complexity of controlling soil parameters like alkaline soil pH, calcareousness, low organic matter and rapid adsorption on soil particles (Alloway, 2008). Moreover, the plant uptake was restricted at low moisture (Yadegari, 2016). These constraints disappear or are limited when the fertilizers are foliar-sprayed. However, in most of the global agricultural areas, this method increases the farmer's cost of cultivation while crop prices have not kept pace. Based on the results of the present study, Mo-priming exerted a positive, significant effect on BNF compared to soil application. In fact, seeds primed in 0.1% ammonium molybdate for 10 hours accumulated 180 µg of Mo per seed, corresponding to approximately 36 g of Mo per hectare, allowing plants to fix 65.8 kg of nitrogen per hectare. The greater level of BNF may be due to the high specific nodular weight and total nodule number, which are substantially influenced by Mo-priming. A moderately positive correlation (r = 0.63) was established between these two parameters. However, the highest values were observed in the M1 plants, which were slightly decreased as the Mo concentration increased. Thus, the active nodules were probably more abundant in the roots of M3 plants. Additionally, both control plants (NC and PC) fixed approximately 11.1 kg ha<sup>-1</sup>, similar to the reported BNF of 15 kg ha<sup>-1</sup> for common bean (Peoples et al., 2009). As shown in the study by Umair et al. (2011), the priming of Vigna radiata seeds in 0.02 and 0.04% sodium molybdate dihydrate for 5 hours significantly increases the BNF by 47 and 36%, with 38.6 and 35.7 kg ha<sup>-1</sup> of fixed nitrogen, respectively. The second treatment approximately corresponds to M1 in our study, which allowed us to fix an estimated amount of nitrogen at 40.5 kg ha<sup>-1</sup>. These interesting results are attributed to the primordial role of Mo in BNF as cofactor of nitrogenase. Moreover, Rhizobium is very effective when sufficient Mo concentrations are provided to plants (Pessoa et al., 2001).

399 400 Mo-primed seeds ensure that plants have an early source of this micronutrient compared to the soil application. In fact, the Mo bioavailability to the plant and thus to bacteroids in the early stages increases the activities of nitrogenase and nitrate reductase (González et al., 2008), and subsequently increases nitrogen assimilation. These changes increase chlorophyll biosynthesis (Hopkins, 2003). However, the Mo provided by soil application does not influence the chlorophyll content, probably due to insufficient intake or the application at late stage, because the most important factor affecting the effectiveness of Mo fertilization is the application period (Masi and Boselli, 2011). Our study revealed a positive effect of Mopriming in 0.1% ammonium molybdate (M3) on the chlorophyll content, which strongly and positively correlated with the leaf photosynthetic capacity. A<sub>n</sub>, g<sub>sw</sub> and T<sub>r</sub> were much greater

in M3 plants. Meanwhile,  $C_i$  inversely correlated with  $A_n$ . An increase in  $g_{sw}$  increased  $T_r$  and improved  $A_n$  (Moualeu-Ngangue et al., 2016). The role of Mo in maintaining an adequate chlorophyll content and therefore high photosynthetic efficiency of plants has been reported (Chen et al., 2004).

Despite the positive effects of Mo-priming on BNF, the chlorophyll content and A<sub>n</sub>, it did no alter the growth parameters (stem height, leaf number, stem diameter and biomass). A potential explanation for this difference is that the initial nitrogen and Mo content in the soil used in this study were sufficient to ensure the normal vegetative growth of the negative control plants, without inducing symptoms of Mo deficiency. The present results are consistent with the findings reported by Alkhamisi et al. (2017), who showed that Mo-priming of wheat seeds did not affect plant height. However, El-Hersh et al. (2011), Singh et al. (2014) and Arun et al. (2017) reported that Mo-priming significantly improved growth parameters in lentils, chickpea and cowpea, respectively.

In contrast to all growth parameters, root length was influenced by molybdic fertilization. Seed treatment has been shown to promote root development and subsequently the absorption efficiency of the elements from the soil solution. According to Harris (2001), seed priming with ammonium molybdate results in significantly higher uptake of N, P, and K in cowpea compared to hydropriming and control conditions. The influence of Mo on root elongation is probably associated with the stimulation of ABA production. In fact, Mo catalyzes the last step in the ABA biosynthesis pathway (Mendel and Hänsch, 2002), resulting in its accumulation in the roots and the subsequent induction of root cell elongation. Notably, Mo exerted a toxic effect on two plants from seeds treated with 0.2% ammonium molybdate. Approximately 50 days after emergence, black spots were observed on bean stems, leading to plant death.

## Effect of Mo-priming on grain yield

The priming of bean seeds in 0.1% ammonium molybdate resulted in the highest yield (estimated at 13.8 q ha<sup>-1</sup>), representing a 115% increase compared with the NC, in the present study. However, greater than 45% increases in yield were recorded in plants fertilized through the soil application method. Thus, the positive effect of Mo-priming on grain yield was attributed to both the Mo nutritional effect and the biochemical advantages induced during the priming process. This assumption was supported by an examination of the hydropriming effect on yield, which was 55% greater than the NC. Yield, per plant or per hectare, was highly positively correlated with the number of grains per pod compared to other yield

components (r=0.96). Therefore, we concluded that the increased yield induced by molybdic fertilization was due to the grain number improvement. The results of these all yield components were consistent with other studies examining different legume species, but the magnitude of the response depends on the crop species. Ghassemi-Golezani et al. (2008) and Arun et al. (2017) highlighted this positive effect of Mo-priming on the yield of chickpea and in cowpea, respectively. The authors reported that this technique significantly improved number of pods per plant, number of seeds per plant, pod length and 1000-grain weight. Regarding hydropriming, some studies reported a positive effect on yield (Rashid et al., 2004; Arif et al., 2007). Furthermore, Mo-priming increases the yield attributes to certain levels and then gradually decreases, highlighting the toxic effect on M4 plants for all parameters studied.

## Conclusion

Bean seeds primed with a solution enriched with Mo exhibited significantly increased levels of nitrogen fixed per plant compared to the soil application, which, partially through ecological processes, restore nitrogen to land areas that have extensively been used for agriculture. In fact, bean seeds, which are known to have a low BNF efficiency (15 kg ha<sup>-1</sup>), subjected to Mo-priming in 0.1% ammonium molybdate for 10 hours allowed the plant to fix 65.8 kg ha<sup>-1</sup> and increase the grain yield by 115%. Thus, nutri-priming has emerged as a promising approach to increase crop performance because of the small amount of Mo, the more uniform application and the absorption efficiency. Nevertheless, the optimal treatment differs according to the concentrations and durations of priming and drying, which is considered a major limitation of this method. Therefore, many trials are needed to identify the most appropriate strategy for each situation.

- 636 0.05.

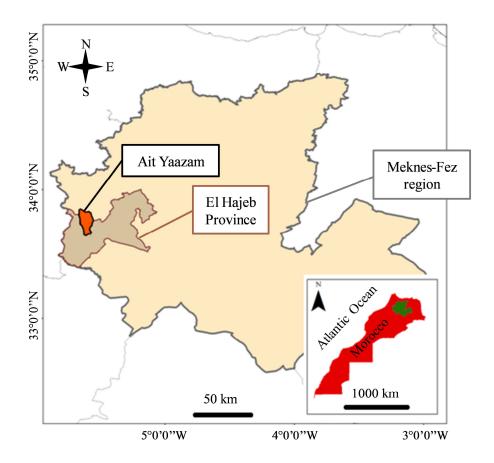

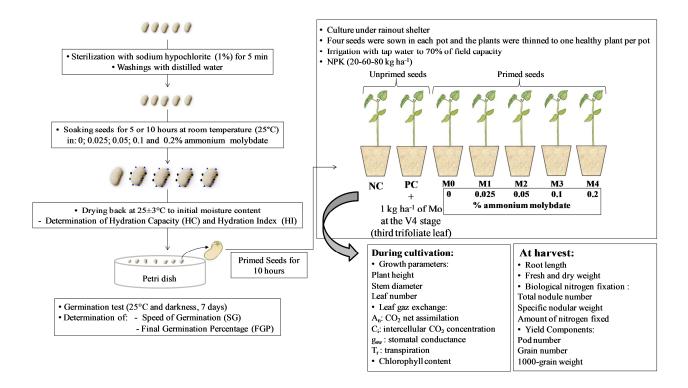

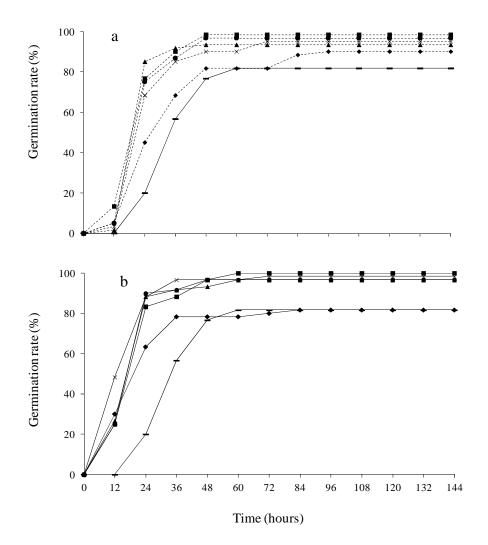

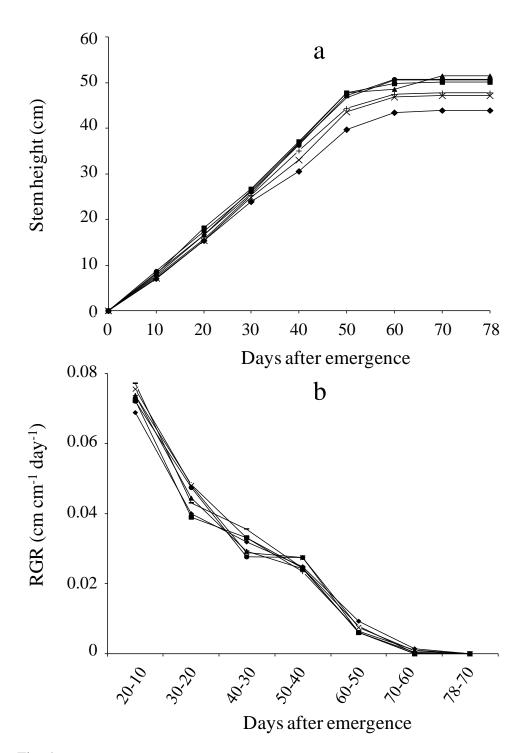

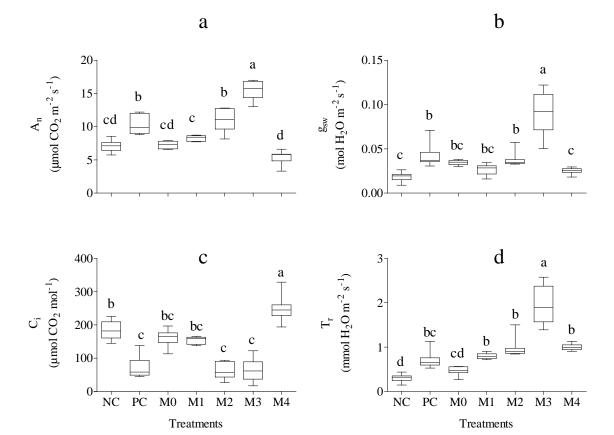

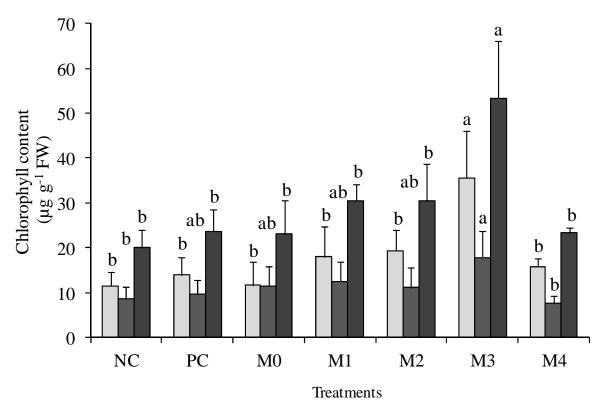
