- Anion exchange membrane fuel cells (AEMFCs) can potentially 1
- 2 revolutionize the energy generation market; however, to be
- seriously considered as a real alternative to the mainstream fuel 3
- cell technology, complete removal of previous metal 4
- electrocatalysts needs to be achieved. While in cathode 5
- electrodes platinum can be easily substituted, the 6
- electrochemical hydrogen oxidation reaction (HOR) in the 7
- AEMFC anodes currently involves prohibitive overpotential 8
- losses, making the removal of platinum extremely challenging. 9
- Understanding the HOR in AEMFCs will facilitate the path to 10
- overcome the challenge and finally develop and demonstrate 11
- 12 platinum-free high-performance AEMFC devices.

Introduction 18

There is an increasing worldwide interest in anion ex-19 change membrane fuel cells (AEMFCs), as the technol-20 ogy promises significant reduction in costs by avoiding 21 the use of platinum as electrocatalysts [1^{••}-4]. Very re-22 cently, extensive research in hydrogen AEMFCs led to 23 significant progress in cell performance of this technology 24 [5^{••}-10], and to an important increasing in the un-25 26 derstanding of the main current challenges - mem-27 brane degradation/performance stability [11-16[•]] and CO₂ effect on AEMFC performance [17–24]. This recent 28 progress and the numerous achievements reached in the 29 past years in the technology, suggest that AEMFC can 30 now be considered as a serious alternative to the coun-31 terpart proton exchange membrane fuel cells (PEMFCs), 32

but potentially without expensive electrocatalysts in their 33 cells. In this front however, while for oxygen reduction 34 reaction there are already several potentially good non-35 precious metal electrocatalyst alternatives under study 36 [25–29], for the hydrogen oxidation reaction (HOR) at the 37 anode of AEMFCs it seems that the challenge is consid-38 erably higher, and the way to achieve high anode per-39 formance based on low cost, non-PGM catalysts is still 40 very long [30^{••}]. The ability to understand and resolve 41 the challenge of hydrogen electrooxidation in AEMFC, 42 in order to develop electrocatalysts highly active towards 43 HOR, is crucial for the future of the AEMFC technology 44 [5**,30**,31]. 45

About the challenging HOR in AEMFC alkaline environment

The electrochemical reactions of hydrogen oxidation differ, depending on the medium, as shown below. In acidic and alkaline environment, the HOR is given by:

 $H_2 \rightarrow 2H^+ + 2e^-$ [acidic medium in PEMFCs] (1)

 $H_2 + 2OH^- \rightarrow 2H_2O + 2e^-$ [alkaline medium in AEMFCs] (2)

The HOR in the acidic medium (Equation (1)) has 51 been well studied, as this electrochemical reaction is of 52 fundamental importance in electrochemistry and electro-53 chemical devices, including PEMFCs. Numerous studies 54 showing different aspects of this reaction have been 55 published [32–34]. Researchers found that the kinetic 56 rates and activities of different electrocatalytic materials 57 towards HOR in acidic medium, are strongly correlated 58 to the hydrogen energy bonding (HEB) of the adsorbed 59 hydrogen (H_{ad}) onto the catalyst surface [33–35]. 60

In contrast, the HOR in alkaline medium (Equation 61 (2)), although also a reaction of central importance in the 62 electrochemical field, has been scarcely studied. A recent 63 comprehensive review of the current understanding of 64 HOR electrocatalysis in basic medium describes in de-65 tails the research studies done in this field, highlighting 66 the challenges involved in developing new materials with 67 high activity in this medium [30^{••}]. In their review, the au-68 thors also focused on the kinetics and the reaction mech-69 anisms of HOR in alkaline medium. Several research 70

studies have shown that the kinetics of the HOR in alka-71 line media is much slower than in acidic solutions [36,37[•]]. 72 For instance, the HOR activity of carbon-supported no-73 ble metals (Pt, Pd and Ir) decreases by around two 74 orders of magnitude when transitioning from low to high 75 pH [38]. The HOR kinetics changes with the pH of 76 the medium were clearly shown by Strmcnik *et al.* [39^{••}]. 77 The authors presented a series of experimental measured 78 polarization curves for the HOR on different catalytic 79 materials in a wide range of pH (1 < pH < 13), as shown 80 in Figure 1. Clear differences between the measured 81 current densities at pH < 3 and pH > 11 can be seen. 82

The authors also performed a simulation of the po-83 larization curves using a simple set of electrochemical 84 equations, confirming the experimental results shown in 85 Figure 1. Results revealed that in strong acidic medium 86 (pH < 3, corresponding to acidic environment of PEM-87 FCs) the HOR proceeds through the direct oxidation of 88 hydrogen to H^+ (Equation (1)); while in strong alkaline 89 medium (pH > 13, corresponding to acidic environment 90 of AEMFCs), pure diffusion-limiting currents are also ob-91 served. As mentioned by the authors, this suggests that in 92 alkaline medium, the supply for both hydrogen and hy-93 droxide anions (both reactants in the HOR in AEMFCs, 94 see Equation (2)) are sufficient to maximize the electro-95 chemical oxidation of hydrogen to water. We can then also 96 say that as the pH in the environment is increased, an 97 increase in the diffusion-limiting currents is obtained. In 98 other words, as the OH⁻ concentration in the fuel cell is 99 higher, purer diffusion-limiting currents will be observed, 100 indicating then that the OH⁻ plays an important role in 101 the HOR for AEMFCs. What is the best way to quantify 102 this role of the OH⁻ is not yet clear. 103

Is HBE descriptor good enough to evaluateHOR catalyst for AEMFCs?

As shown in Equation (2), in AEMFCs the electrochemical oxidation of hydrogen involves two reactants –

hydrogen and hydroxide anions - instead of only one reac-108 tant for the acidic counterpart (\mathbb{E} quation (1)) – hydrogen. 109 As hydrogen is a reactant for both acidic and alkaline fuel 110 cells, the differences in the kinetics rates for the HOR on 111 different electrocatalysts in both systems are sometimes 112 attempted to be explained by the variation in HBE val-113 ues [40]. Although differences in HBE mostly succeed to 114 explain kinetics variations for PEMFCs, in the alkaline 115 counterpart the situation seems to be more complex [37[•]]. 116

The best catalysts for HOR in acidic PEMFCs are those 117 with an optimal interaction between the catalytic sub-118 strate and the H_{ad} species, that usually is quantified by 119 the HBE. Similarly, it was proposed that the role of the 120 OH- in the HOR in alkaline medium can be related to 121 the OH_{ad} properties of the catalyst [39^{••}]. In other words, 122 it was suggested that fine-tuning of the adsorption en-123 ergy of OH_{ad} could be a new way to quantify HOR in 124 AEMFC systems [39^{••}]. To quantify this energy, Davy-125 dova et al. [30**] proposed to calculate a new descriptor 126 called OHBE - OH_{ad} binding energy - and compare it to 127 the HBE for each electrocatalyst system. Similar to what 128 has been suggested by Koper [41], for some electrocat-129 alytic systems, both HBE and OHBE are expected to be 130 interconnected, as the presence of OH_{ad} is probable to 131 improve the reactivity of the adsorbed hydrogen inter-132 mediated H_{ad}, enhancing the overall reactivity of HOR, 133 and vice versa. In other words, if this basic idea is correct, 134 it means that the best electrocatalysts for HOR in alka-135 line AEMFCs are those with an optimal interaction be-136 tween the catalytic substrate and both the H_{ad} and OH_{ad} 137 species, evaluated by the HBE and OHBE descriptors, re-138 spectively. What exactly is the relationship between HBE 139 and OHBE, and how close they are interconnected each 140 other, is currently an unknown. 141

Very recently, Davydova *et al.* [42] first attempted to evaluate both HBE and OHBE descriptors on their HOR 143 electrocatalysts for AEMFCs (see Figure 2). The authors 144

used density functional theory to calculate the HBE and 145 OHBE values for bare Ni and Ni-metal catalysts, for a few 146 metals (Cu, Co, Fe), and suggested that the dopant metal 147 onto Ni electrocatalyst have a significant effect onto the 148 HBE and OHBE values, showing that these can be use-149 ful descriptors to evaluate different catalysts and eventu-150 ally, relate these values to the exchange current densities. 151 However, this is a first attempt, while this idea is waiting 152 for further exploration, to finally unravel the full role of 153 the hydroxide anions in the HOR. 154

Ideally, to find the best HOR electrocatalysts for AEM-155 FCs we should then evaluate both HBE and OHBE and 156 correlate the interaction between them and the exchange 157 current densities. This ideal situation is schematically il-158 lustrated by a 'volcano plot', where both HBE and OHBE 159 descriptors are simultaneously plotted for different elec-160 trocatalysts, as shown in Figure 3. The interaction be-161 tween the electrocatalytic substrate and the H_{ad} species, 162 quantified by the HBE, is for instance, illustrated for a 163 series of electrocatalysts with different OHBE values by 164 a series of yellow curves. Similarly, interaction between 165 the electrocatalytic substrate and the OH_{ad} species, quan-166 tified by the OHBE, for electrocatalysts with different 167 HBE values is shown by the green curves in Figure 3. 168 The optimal fine-tuning of the adsorption energy of H_{ad} 169 and OH_{ad}, which may lead to the optimal HOR electro-170 catalysts can then be represented by a combination and 171 simultaneous optimization of both HBE and OHBE de-172 scriptors. In that case, different fine-tuned HBE/OHBE 173 combinations can lead to electrocatalysts highly active to-174 wards HOR for AEMFCs. 175

Does water play a role in the AEMFC HOR?

During operation of an AEMFC, the higher overpoten-177 tial of the HOR at high pH anode electrode is also aggra-178 vated by the fact that water needs to be quickly removed 179 from the catalyst layer. In contrast to the acidic counter-180 part, AEMFC operation involves generation of water as a 181 product of the electrochemical HOR. Figure 4(a) shows a 182 schematic diagram of an anode catalyst layer of AEMFCs. 183 The porous of the anode catalyst layer needs not only 184 to allow the hydrogen transport through the entire layer 185 thickness, but also to 'accommodate' the water generated 186 and allow its efficient removal. Two water molecules per 187 reactant hydrogen molecule are generated (see Equation 188 (2)), in absolute contrast to the HOR in acidic PEMFCs, 189 where water is not taken direct part in the electrochem-190 ical reaction. This is a significant amount of water that is 191 generated at the AEMFC anode, twice as much as wa-192 ter generated in the cathode of PEMFCs, per hydrogen 193 molecule (or per electron produced), during the reduction 194 of oxygen. In addition to that, in practical fuel cell systems 195 running under standard gas stoichs, the volumetric flow 196 of hydrogen is around 5 to 10 times lower than that of air. 197 Therefore, with these extreme low hydrogen flows and 198 the high amount of water generated by the HOR, water 199 removal from AEMFC anodes is extremely challenging. 200

The accumulation of water in the AEMFC anode itself 201 represents also a challenge for the supply of the reac-202 tants that as previously discussed, are sufficient to max-203 imize the electrochemical HOR in the cell. Due to this 204 fact, the electrolyte/electrode interface of AEMFCs can 205 behave very differently from other similar electrochem-206 ical devices. The characterization of interfacial structure 207 and understanding of fundamental characteristics of the 208 AEMFC electrode/electrolyte interface may help shed 209

light on designing and developing highly active non-precious metal HOR electrocatalysts.

Figure 4(b) shows a schematic comparison of the triple-212 phase boundary (TPB) for the electrooxidation of hydro-213 gen for both acidic and alkaline fuel cell environments. As 214 mentioned above, for AEMFCs the supply of hydrogen as 215 well as the supply of OH⁻ reactants to the TPB are critical 216 for the HOR. Two OH- anions (of larger ion radius as com-217 pared with the H⁺ cation radius in the acidic counterpart) 218 should be transported through the solidanion-conducting 219 electrolyte to react with the hydrogen in the TPB. In ad-220 dition, as HOR occurs, water is generated in the surround-221 ings of the catalyst. If water is not quickly removed from 222 the TPB, a thin film of water will eventually cover the 223 catalyst surface, creating additional resistance to the dif-224 fusive transport of the hydrogen to the TPB (see bottom 225 Figure 4(b)). As previously discussed, removal of this wa-226 ter film from the fuel electrode is challenging, therefore 227 we expect this film to be of significant thickness, affecting 228 then the overall HOR kinetics. We can also assume that 229

this water film affects the properties of the catalyst, for 230 instance, affecting the HEB and maybe the OHBE and 231 in turn, the HOR activity. Moreover, as the current den-232 sity in the AEMFC device increases, the amount of water 233 accumulated on the catalyst surrounding increases, gen-234 erating thicker water films around the catalysts, which in 235 turn are translated to increased resistance of the hydrogen 236 transport through the water film. Taken into account all 237 these effects water has onto the HOR electrocatalysis and 238 AEMFC anodes, would provide a better understanding 239 of the requirements for designing better hydrogen elec-240 trooxidation electrocatalysts for this technology. 241

Concluding comments

The field of AEMFCs has never been more active than in the past couple of years. However, to become a real alternative to the counterpart acidic fuel cells, AEMFCs should be able to equal PEMFC performance while based on affordable PGM-free electrocatalysts. In this work, we have remarked the challenges of HOR in AEMFCs. We highlighted the prohibitive overpotential 249

of standard electrocatalysts towards HOR, the need to 250 have two descriptors to achieve a better understanding 251 of this reaction, and the importance and challenge of 252 253 water in the AEMFC anodes. It is crucial to understand 254 all these relations in order to develop highly active HOR PGM-free electrocatalysts for AEMFCs. In particular, 255 increasing the understanding of the mechanism of reac-256 257 tion as well as the relationship between the HOR current density and the descriptors HBE and OHBE, will be 258 of significant help in solving this major barrier in the 259 technology, aiming for cells based completely on precious 260 metal-free AEMFC electrodes. 261
