# Isochronous centers of polynomial Hamiltonian systems and a conjecture of Jarque and Villadelprat

#### Abstract

We study the conjecture of Jarque and Villadelprat stating that every center of a planar polynomial Hamiltonian system of even degree is nonisochronous. This conjecture has already been proved for quadratic and quartic systems. Using the correction of a vector field to characterize isochronicity and explicit computations of this quantity for polynomial vector fields, we are able to describe a very large class of nonisochronous Hamiltonian systems of even arbitrarily large degree.

## 1. Introduction and main results

### 1.1. The Jarque-Villadelprat conjecture

In this paper, we study centers of planar polynomial Hamiltonian systems in the real case. In particular we focus on isochronous centers. Our main concern is the following conjecture stated 5 by Jarque and Villadelprat in [20]:

Let $X$ be a real polynomial Hamiltonian vector field of the form:

$$
\begin{equation*}
X(x, y)=-\partial_{y} H(x, y) \partial_{x}+\partial_{x} H(x, y) \partial_{y}, \quad(x, y) \in \mathbb{R}^{2} \tag{1}
\end{equation*}
$$

where $H(x, y)$ is a real polynomial in the variables $x$ and $y$. The maximum degree of the polynomials $\partial_{x} H$ and $\partial_{y} H$ is the degree of the Hamiltonian vector field.

[^0]Conjecture : Every center of a planar polynomial Hamiltonian system of even degree is nonisochronous.

The conjecture is known to be true for quadratic systems thanks to a result of Loud in [22] and with a vector field of arbitrary large degree (see for example [20] p.337). This is indeed the case when one has no informations on the algebraic structure of these coefficients. Then one is reduced to compute Grobner bases or to use the elimination method. However, one is quickly limited by the computational complexity and the memory size need to perform these computations. Existing results are restricted to polynomials of order 5 .

### 1.2. Main results

In this paper, using the formalism of moulds (see [10], [11]) and a particular object attached to a vector field called the correction defined by Ecalle and Vallet in [14]. In particular, we obtain a partial answer to the conjecture for arbitrarily large degree.

It is well known that isochronicity of a real center is equivalent to its linearisability (see [2], theorem 3.3, p.12). A main property of the correction is that it gives a very useful criterion for linearisability. Indeed, a vector field is linearisable if and only if its correction is zero. As the correction possesses an algorithmic and explicit form which is easily calculable using mould calculus so we are able to give more informations on the isochronous set. This strategy was already used by one of us in [6].

In the following, we use the classical complex representation of real vector fields (see [21]). Let us denote by $X_{l i n}=i\left(x \partial_{x}-\bar{x} \partial_{\bar{x}}\right)$ and $X_{r}=P_{r}(x, \bar{x}) \partial_{x}+\overline{P_{r}(x, \bar{x})} \partial_{\bar{x}}$ with $x \in \mathbb{C}, P_{r}$ is a ${ }_{55}$ homogeneous polynomial of degree $r, P_{r}(x, \bar{x})=\sum_{j=0}^{r} p_{r-j-1, j} x^{r-j} \bar{x}^{j}$.

We formulate our main results (Theorem 1 to Theorem 4) whose proofs are postpone in Section 4.

Theorem 1. Let $X$ be a non trivial real Hamiltonian vector field of even degree $2 n$ given by:

$$
X=X_{l i n}+\sum_{r=2}^{2 n} X_{r}
$$

If $X$ satisfies one of the following conditions :
6о a) there exists $1 \leq r<n-1$ such that $p_{i, i}=0$ for $i=1, \ldots, r-1$ and $\operatorname{Im}\left(p_{r, r}\right)>0$,
b) $p_{i, i}=0$ for $i=1, \ldots, n-1$,
then the vector field is nonisochronous.
As a consequence we deduce that:

$$
\begin{aligned}
& X=X_{l i n}+X_{2} \\
& X=X_{l i n}+X_{2}+X_{3}+X_{4} \text { with } \operatorname{Im}\left(p_{1,1}\right) \geq 0 \\
& X=X_{l i n}+X_{2}+X_{3}+X_{4}+X_{5}+X_{6} \text { with } p_{1,1}>0 \text { or } p_{1,1}=0 \text { and } \operatorname{Im}\left(p_{2,2}\right)>0
\end{aligned}
$$

are nonisochronous.

As a corollary, we obtain the weak version of the Jarque-Villadelprat conjecture proved by X. Chen and al. [3]:

Corollary 1 (weak Jarque-Villadelprat conjecture). Let $X$ be a non trivial real Hamiltonian vector field of even degree $2 n$ given by

$$
X=X_{l i n}+X_{2}+X_{4}+\cdots+X_{2 n}
$$

then $X$ is nonisochrnous.

The proof follows easily from Theorem 1 as for all $i=1, \ldots, n-1$, we have $p_{i, i}=0$ due to the fact that there exists no odd components.

Theorem 2. Let $X$ be a non trivial real Hamiltonian vector field of the form:

$$
X=X_{l i n}+X_{k}+\ldots+X_{2 l}
$$

70 for $k \geq 2,2 l \geq k$ and $l \leq k-1$. Then $X$ is nonisochronous.
Using this last theorem, without any conditions we have that:

$$
\begin{aligned}
& X=X_{l i n}+X_{2} \\
& X=X_{l i n}+X_{3}+X_{4} \\
& X=X_{l i n}+X_{4}+X_{5}+X_{6}
\end{aligned}
$$

or more funny

$$
X=X_{l i n}+\sum_{i=47}^{92} X_{i}
$$

are nonisochronous. We see that Theorem 1 and Theorem 2 are complementary to each other.
${ }^{75}$ Mixing the proofs of Theorem 1 and Theorem 2 we obtain:
Theorem 3. Let $X$ be a non trivial real polynomial Hamiltonian vector field on the form:

$$
X=X_{l i n}+X_{k}+\ldots+X_{2 l}+\sum_{n=1}^{m} \sum_{j=c_{n}}^{2\left(c_{n}-1\right)} X_{j}
$$

where $k \geq 2,2 l \geq k, l \leq k-1, m \geq 1$ and the sequence $c_{n}$ is defined $b y$ :

c_{1}=4 l \text { and } \forall n \geq 2, \quad c_{n}=4\left(c_{n-1}-1\right) \tag{2}
\end{equation*}
$$

Then $X$ is nonisochronous.
A first example of nonisochronous vector field given by the last theorem is:

$$
X=X_{l i n}+X_{2}+X_{4}+X_{5}+X_{6}
$$

Theorem 4. Let $k \geq 2$ and $l \leq k-1$, a real polynomial Hamiltonian vector field denoted by $X$ on one of these two forms:

$$
i) X=X_{l i n}+X_{k}+\ldots+X_{2 l}+X_{2 l+1}+\sum_{m=r}^{r+n} X_{m}
$$

where $r \geq 2 l+2$ and $\operatorname{Im}\left(p_{l, l}\right)>0$ or

$$
\text { ii) } X=X_{l i n} X_{k}+\ldots+X_{2 l}+X_{4 l-1}+\sum_{m=r}^{r+n} X_{r}
$$

where $X_{2 l}$ is nontrivial, $r \geq 4 l$, with $\operatorname{Im}\left(p_{2 l-1,2 l-1}\right)>0$, are nonisochronous.
Using Theorem 3 and Theorem 4 we easily deduce the classical result that homogeneous perturbations of a linear center are non isochronous (see [27]) as well its generalization (see [28, 6]).

### 1.3. Plan of the paper

In Section 2, we give following J. Ecalle and B. Vallet [14] the definition of the correction of a vector field and remind some of its properties. We then look more specifically to the correction of polynomial real vector fields. We derive explicit formula allowing us to analyse its structure.

In Section 3, we prove that the set of isochronous Hamiltonian centers is an affine variety which can be explicitly described. We also prove that this variety is invariant under a non trivial torus action.

90 In Section 4, we give the proofs of our main results and some technical Lemmas.

We then discuss several perspectives for this work.

## 2. Correction of vector fields and Hamiltonian systems

### 2.1. Correction of a vector field

 of J. Ecalle and B. Vallet [14]. In particular, we give the mould expansion of the correction, which plays a central role in our approach to study the linearisability. It must be noted that all these computations can be made in arbitrary dimension.
### 2.1.1. The correction of a vector field

We denote by $X$ an analytic vector field on $\mathbb{C}^{\nu}$ at 0 :

X=\sum_{1 \leq j \leq \nu} X_{j}(x) \partial_{x_{j}}
$$

with $X_{j}(0)=0$ and $X_{j}(x) \in \mathbb{C}\{x\}$. We can write the vector field $X$ in its prepared form:
Definition 1. A vector field $X$ is said to be in prepared form if it is given by

\begin{equation*}
X=X_{l i n}+\sum_{n \in A(X)} B_{n} \tag{3}
\end{equation*}
$$

where $X_{\text {lin }}$ is the linear part of $X$ in diagonal form

$$
\begin{equation*}
X_{l i n}=\sum_{j=1}^{\nu} \lambda_{j} x_{j} \partial_{x_{j}} \tag{4}
\end{equation*}
$$

the $B_{n}$ are homogeneous differential operators of degree $n=\left(n_{1}, \ldots, n_{\nu}\right) \in \mathbb{Z}^{\nu}$, where all $n_{i}$ are integer except one which can be -1 , satisfying for all monomial $x^{m}=x_{1}^{m_{1}} \ldots x_{m}^{m_{\nu}}$, where $x=\left(x_{1}, \ldots, x_{\nu}\right) \in \mathbb{C}^{\nu}, m=\left(m_{1}, \ldots, m_{\nu}\right) \in \mathbb{N}^{\nu}$, the equality

$$
\begin{equation*}
B_{n}\left(x^{m}\right)=\beta_{n, m} x^{n+m}, \quad \beta_{n, m} \in \mathbb{C}^{\nu} \tag{5}
\end{equation*}
$$

and $A(X) \in \mathbb{Z}^{\nu}$ is the set of the degree of the operators $B_{n}$ in the decomposition of $X$.
From the point of view of Analysis, homogeneous differential operators are more tractable. An operator $B_{n}$ is said to be homogeneous of degree $n=\left(n_{1}, n_{2}\right)$ if for all monomial $x^{l} y^{k}$ we have $B_{n}\left(x^{l} y^{k}\right)=\beta_{n}^{l, k} \cdot x^{n_{1}+l} y^{n_{2}+k}$ with $\beta_{n}^{l, k} \in \mathbb{C}$.

In [14], J.Ecalle and B.Vallet introduce the correction of a vector field following previous works of G.Gallavotti [18] and H.Eliasson [15] in the Hamiltonian case.

Let us consider a vector field in prepared form. The correction is defined as follows([14], p.258):
115 Definition 2. Let $X$ be a vector field in prepared form with linear part $X_{\text {lin }}$. The correction of $X$, denoted by $\operatorname{Carr}(X)$ is the vector field solution of the following problem:

Find a vector field $Z$ such that

$$
\begin{equation*}
X-Z \sim X_{l i n}, \quad \text { and } \quad\left[X_{l i n}, Z\right]=0, \tag{6}
\end{equation*}
$$

where for two vector fields $A$ and $B$, we denote $A \sim B$ if the vectors fields $A$ and $B$ are formally conjugate.

The second condition implies that $\operatorname{Carr}(X)$ is only made of resonant terms.

In [14], Ecalle and Vallet prove that the correction of a vector field admits a mould expansion.

Precisely, let us denote by $A^{*}(X)$ the set of the words given by the letters in $A(X)$ using the concatenation morphism conc on letters :

\begin{aligned}
\text { conc }: A(X)^{p} & \rightarrow A^{*}(X) \\
\quad\left(n_{1}, \ldots, n_{p}\right) & \mapsto n_{1} \cdot n_{2} \cdot \ldots \cdot n_{p} .
\end{aligned}
$$

for any integer $p$.

In the following, a word is denoted by $n_{1} \cdot n_{2} \cdot \ldots \cdot n_{p}$ or $n_{1} n_{2} \ldots n_{p}$.
Remark 1. The length of the word $n_{1} \ldots n_{p}$ is $p$. The word of length 0 is denoted by $\emptyset$.
Definition 3. The set $A^{*}(X)$ is composed by all the words of all lengths that is, if $\boldsymbol{n} \in A^{*}(X)$ there exists an integer $p \geq 0$ such that $\boldsymbol{n}=\operatorname{conc}\left(n_{1}, \ldots, n_{p}\right)$ where $n_{j} \in A(X)$ for $j=1, \ldots, p$. We denote $A^{p}(X)$ the set of words of length $p$.

For all $\mathbf{n}=n_{1} \cdot \ldots \cdot n_{r} \in A^{*}(X)$, we denote:

$$
\begin{equation*}
B_{\mathbf{n}}=B_{n_{1}} \circ \ldots \circ B_{n_{r}} \tag{7}
\end{equation*}
$$

The correction can be written as ([14], Lemma 3.2 p.267):

$$
\begin{equation*}
\operatorname{Carr}(X)=\sum_{\mathbf{n} \in A^{*}(X)} \operatorname{Carr}^{\mathbf{n}} B_{\mathbf{n}} \tag{8}
\end{equation*}
$$

where $\operatorname{Carr}^{\mathbf{n}} \in \mathbb{C}$ for all $\mathbf{n} \in A^{*}(X)$, or simply

$$
\begin{equation*}
\operatorname{Carr}(X)=\sum_{\bullet} \operatorname{Carr}^{\bullet} B \tag{9}
\end{equation*}
$$

135 following Ecalle's notations (see [10] and [5]).

The mapping

$$
\operatorname{Carr}^{\bullet}: \begin{array}{ll}
A(X)^{*} & \longrightarrow \mathbb{C}  \tag{10}\\
\mathbf{n} & \longmapsto \operatorname{Carr}^{\mathbf{n}}
\end{array}
$$

is called a mould (see [10, 11] and [5]). formula on the length of words.

Precisely for all $n \in A(X)$, let us denote by $\omega(n)$ the quantity:

$$
\omega(n)=\langle n, \lambda\rangle,
$$

where the $\langle.,$.$\rangle is the usual scalar product on \mathbb{C}^{n}$ and $\lambda=\left(\lambda_{1}, \ldots, \lambda_{\nu}\right)$ are the eigenvalues of $X_{\text {lin }}$. We can extend $\omega$ to a morphism from $\left(A^{*}(X)\right.$, conc) to $(\mathbb{C},+)$, i.e. for all $\mathbf{n}=n_{1} \cdot n_{2} \ldots n_{r} \in A^{*}(X)$, $n_{i} \in A(X), i=1, \ldots, r$, we have

$$
\begin{equation*}
\omega(\mathbf{n})=\omega\left(n_{1}\right)+\cdots+\omega\left(n_{r}\right) \tag{11}
\end{equation*}
$$

The quantity $\omega(n)$ is called the weight of the letter $n$.
We have the following theorem (formula 3.42 in [14]):

Theorem 5 (Variance formula). The mould of the correction is given by the formula for any word $\boldsymbol{n}=n_{1} \cdot \ldots \cdot n_{r}:$

$$
\begin{equation*}
\omega\left(n_{1}\right) \operatorname{Carr}^{n_{1}, n_{2}, \ldots, n_{r}}+\operatorname{Carr}^{n_{1}+n_{2}, n_{3}, \ldots n_{r}}=\sum_{n_{1} \boldsymbol{b} \boldsymbol{c}=\boldsymbol{n}} \operatorname{Carr}^{n_{1} \boldsymbol{c}} \operatorname{Carr}^{\boldsymbol{b}} \tag{12}
\end{equation*}
$$

The proof of this theorem is nontrivial. It follows from the variance formula for a vector field discussed in ([14], Prop 3.1 p.270). The variance of a vector field gives many different way to
compute the mould of the correction.

The main consequence of the previous Theorem is the universal character of the mould of the correction. Precisely, following the definition of universality used in [5], we have :

Theorem 6 (Universality of the Correction's mould). There exists a one parameter family of complex functions $C_{r}: \mathcal{D}_{r} \subset \mathbb{C}^{r} \rightarrow \mathbb{C}, r \in \mathbb{N}$ such that for all $X$ the correction's mould Carr${ }^{\bullet}$ defined on $A(X)^{*}$ is given for all $\mathbf{n} \in A(X)^{*}$ such that $l(\mathbf{n})=r, r \in \mathbb{N}$ by

$$
\text { Carr }^{\mathbf{n}}= \begin{cases}C_{r}\left(\omega\left(n_{1}\right), \ldots, \omega\left(n_{r}\right)\right), & \text { if } \omega(\mathbf{n})=0  \tag{13}\\ 0 & \text { otherwise }\end{cases}
$$

This property is fundamental concerning our problem as the computation of these coefficients is done once and for all and does not depends on the value of the coefficients entering the polynomials but on the alphabet generated by the vector field. Up to our knowledge only the mould formalism is able to produce such kind of coefficients allowing to write the correction (this is not the case for example dealing with the classical Lie framework).

Definition 4. A word $\boldsymbol{n} \in A^{*}(X)$ is said to be resonant if $\omega(\boldsymbol{n})=0$.
In the following, we give explicit expressions for $C_{1}, C_{2}$ and $C_{3}$.

### 2.1.2. The mould of the correction

The following theorem concerns precisely the length 1,2 and 3 :
As for prenormal forms (see [13]), a specific role is played by resonant terms:

Theorem 7. The universal correction functions $C_{r}: \mathbb{C}^{r} \rightarrow \mathbb{C}$ of Theorem 6 are given for $r=1,2,3$ by

\begin{gather*}
C_{1}(x)=\left\{\begin{array}{ll}
1 & \text { if } z_{1}=0, \\
0 & \text { otherwise. }
\end{array} \quad C_{2}\left(z_{1}, z_{2}\right)= \begin{cases}-\frac{1}{z_{1}} & \text { if } z_{1}+z_{2}=0, z_{1} \neq 0 \\
0 & \text { otherwise }\end{cases} \right.  \tag{14}\\
C_{3}\left(z_{1}, z_{2}, z_{3}\right)= \begin{cases}\frac{1}{z_{1}\left(z_{1}+z_{2}\right)}, & \text { if } z_{1}+z_{2}+z_{3}=0, z_{1} \neq 0, z_{1}+z_{2} \neq 0 \\
0 & \text { otherwise. }\end{cases} \tag{15}
\end{gather*}
$$

The proof is based on explicit computations which are summarized in the following Lemmas whose proof are given in Appendix.

We can remark that the values of the correction's mould depend on the weight of the letters.

Lemma 1. The mould Carr• verifies :

1) $C a r r^{\emptyset}=0$,
2) If $\boldsymbol{n}$ is non resonant, Carr $^{\boldsymbol{n}}=0$,
3) If $\boldsymbol{n}=n_{1} \ldots n_{r}$ is such that there exists $j$ satisfying $\omega\left(n_{j}\right)=0$ then Carr $^{\boldsymbol{n}}=0$.

Moreover, we have:
Lemma 2. 1) If $\omega(n)=0$, Carr $^{n}=1$,
2) If $\omega\left(n_{1} \cdot n_{2}\right)=0$ with $\omega\left(n_{1}\right)=-\omega\left(n_{2}\right) \neq 0$, we have Carr $^{n_{1} \cdot n_{2}}=-\frac{1}{\omega\left(n_{1}\right)}$,
3) If $\omega\left(n_{1} \cdot n_{2} \cdot n_{3}\right)=0$ with $\omega\left(n_{j}\right) \neq 0 j=1,2,3$, we have Carr $^{n_{1} \cdot n_{2} \cdot n_{3}}=\frac{1}{\omega\left(n_{1}\right)\left(\omega\left(n_{1}\right)+\omega\left(n_{2}\right)\right)}$.

We refer to Appendix B. 2 and Appendix B. 3 for the proofs.

### 2.1.3. Some computations of the correction mould

Let us consider the quadratic case, i.e.

$$
\begin{equation*}
X=X_{l i n}+X_{2} \tag{16}
\end{equation*}
$$

where $X_{\text {lin }}$ is diagonal with eigenvalues $(i,-i)$ and $X_{2}$ is a homogeneous polynomial vector field of degree 2 given by

$$
\begin{equation*}
X_{2}=\left(p_{1,0} x^{2}+p_{0,1} x y+p-1,2 y^{2}\right) \partial_{x}+\left(q_{2,-1} x^{2}+q_{0,1} x y+q_{1,0}\right) \partial_{y} \tag{17}
\end{equation*}
$$

We have:

Lemma 3. The alphabet generated by $X_{2}$ is given by

$$
\begin{equation*}
A(X)=\left\{n_{1}=(1,0), n_{-1}=(0,1), n_{3}=(2,-1), n_{-3}=(-1,2)\right\} \tag{18}
\end{equation*}
$$

Proof. The alphabet generated by $X_{2}$ is related to the decomposition of $X_{2}$ in homogeneous differential operators. A simple rearrangement of terms proves that

$$
\begin{equation*}
X_{2}=B_{(1,0)}+B_{(0,1)}+B_{(-1,2)}+B_{(2,-1)} \tag{19}
\end{equation*}
$$

where

$$
\begin{array}{ll}
B_{(1,0)}=x\left(p_{1,0} x \partial_{x}+q_{1,0} y \partial_{y}\right), & B_{(0,1)}=y\left(p_{0,1} x \partial_{x}+q_{0,1} y \partial_{y}\right)  \tag{20}\\
B_{(-1,2)}=p_{-1,2} y^{2} \partial_{x}, & B_{(2,-1)}=q_{2,-1} x^{2} \partial_{y}
\end{array}
$$

This concludes the proof.
All the letters in $A(X)$ are non resonant. Indeed, we have

$$
\begin{equation*}
\omega\left(n_{1}\right)=i, \omega\left(n_{-1}\right)=-i, \omega\left(n_{3}\right)=3 i, \omega\left(n_{-3}\right)=-3 i \tag{21}
\end{equation*}
$$

As a consequence, the correction mould is always zero in length 1.

In length 2 however, some resonant combinations are possible. We have

### 2.2. Correction of a polynomial vector field

### 2.2.1. Prepared form and alphabet

Let $X$ a polynomial vector field in $\mathbb{C}^{2}$ of the form:

with

\begin{equation*}
X_{r}=P_{r}(x, y) \partial_{x}+Q_{r}(x, y) \partial_{y} \tag{23}
\end{equation*}
$$

where $P_{r}$ and $Q_{r}$ are homogeneous polynomials of degree $r$ such that:

\begin{equation*}
P_{r}(x, y)=\sum_{k=0}^{r} p_{k-1, r-k} x^{k} y^{r-k}, Q_{r}(x, y)=\sum_{l=0}^{r} q_{r-k, k-1} x^{r-k} y^{k} \tag{24}
\end{equation*}
$$

In the following, we describe explicitly the prepared form of $X$, the set $A(X)$ and the operators $B_{n}$.

Lemma 4. For all $r \geq 2$, we can associate an alphabet to the vector field $X_{r}$, written $A\left(X_{r}\right)$ given by:

A\left(X_{r}\right)=\{(r,-1),(-1, r),(k-1, r-k) \text { with } k=1, \ldots, r\} .
$$

Moreover, we get from $A\left(X_{r}\right)$ the set denoted $\mathcal{B}\left(X_{r}\right)$ of the homogeneous differential operators given by the decomposition :

& B_{(r,-1)}=q_{r,-1} x^{r} \partial_{y}, \\
& B_{(k-1, r-k)}=x^{k-1} y^{r-k}\left(p_{k-1, r-k} x \partial_{x}+q_{k-1, r-k} y \partial_{y}\right)
\end{aligned}
$$

${ }_{210}$ with $k \in\{1, \ldots, r\}$.

Proof. We first rewrite any vector field $X_{r}, r=2, \ldots, l$, in order to make apparent the order, in term of differential operators, of all its components. We have :

P_{r}(x, y) \partial_{x}+Q_{r}(x, y) \partial_{y} & =\sum_{k=1}^{r}\left(p_{k-1, r-k} x^{k-1} y^{r-k} x \partial_{x}+q_{r-k, k-1} x^{r-k} y^{k-1} y \partial_{y}\right)+p_{-1, r} y^{r} \partial_{x}+q_{r,-1} x^{r} \partial_{y} \\
& =\sum_{k=1}^{r}\left(O_{(k-1, r-k)}+\tilde{O}_{(r-k, k-1)}\right)+O_{(-1, r)}+O_{(r,-1)}
\end{aligned}
$$

with

$$
\begin{aligned}
O_{(k-1, r-k)} & =p_{k-1, r-k} x^{k-1} y^{r-k} x \partial_{x}, \\
\tilde{O}_{(r-k, k-1)} & =q_{r-k, k-1} x^{r-k} y^{k-1} y \partial_{y}, \\
O_{(-1, r)} & =p_{-1, r} y^{r} \partial_{x}, \\
O_{(r,-1)} & =q_{r,-1} x^{r} \partial_{y} .
\end{aligned}

We want to know if there exists some operators of the same degree among the operators $O_{(k-1, r-k)}$ and $\tilde{O}_{(r-k, k-1)}$. If it is the case, we gather them in a same operator of the form $B_{\left(n^{1}, n^{2}\right)}=x^{n^{1}} y^{n^{2}}\left(p_{\left(n^{1}, n^{2}\right)} x \partial_{x}+q_{\left(n^{1}, n^{2}\right)} y \partial_{y}\right)$.

For that, we have to solve the equation

where $k, \tilde{k} \in\{1, \ldots, r\}$. As $\tilde{k} \in\{1, \ldots, r\}, r-\tilde{k} \in\{0, \ldots, r-1\}$ hence $r-\tilde{k}+1 \in\{1, \ldots, r\}$. So there always exists solutions. This concludes the proof.

Example 1. We consider the vector field $X=X_{\text {lin }}+X_{2}+X_{3}$ where

\end{aligned}
$$

Hence we obtain the three following alphabets :

& A\left(X_{3}\right)=\{(3,-1),(2,0),(1,1),(0,2),(-1,3)\}
\end{aligned}

For example, we also have the elements of the set $\mathcal{B}\left(X_{3}\right)$ :

Definition 5. We define the degree of a vector fields as the maximum of the degree of its defining polynomial.

In a same way, we define the degree of the homogeneous differential operators $B_{n}$ or of a Lie bracket of $B_{n}$ which appear in the decomposition of $X$. We denote by $\operatorname{deg}\left(B_{n}\right)\left(\operatorname{resp} . \operatorname{deg}\left(\left[B_{n}\right]\right)\right.$ ) the degree of $B_{n}$ (resp. $\left[B_{n}\right]$ ).
Lemma 5. Let $X$ be a vector fields of the form $X=X_{\text {lin }}+\sum_{r=2}^{m} X_{r}$ then $X$ admits the alphabet $A(X)=\bigcup_{r=2}^{m} A\left(X_{r}\right)$ and $\mathcal{B}(X)$, the set of homogeneous differential operators of $X$, is given by $225 \mathcal{B}(X)=\bigcup_{r=2}^{m} \mathcal{B}\left(X_{r}\right)$.

Proof. For all $n=\left(n^{1}, n^{2}\right) \in A(X)$, we define the application :

n=\left(n^{1}, n^{2}\right) & \mapsto n^{1}+n^{2} .
\end{aligned}
$$

For every $r \geq 2$, for all $n \in A\left(X_{r}\right)$, we have $p(n)=r-1$, so $\forall r, r^{\prime}$, such that $r \neq r^{\prime}$, we have $A\left(X_{r}\right) \cap A\left(X_{r^{\prime}}\right)=\emptyset$ because $p\left(A\left(X_{r}\right)\right) \neq p\left(A\left(X_{r^{\prime}}\right)\right)$. Moreover, as $\operatorname{Der}\left(\mathbb{C}^{2}\right)=\bigoplus_{r \geq 1} \operatorname{Der}_{r}\left(\mathbb{C}^{2}\right)$ and $\mathcal{B}\left(X_{r}\right) \subset \operatorname{Der}_{r}\left(\mathbb{C}^{2}\right)$, then $\mathcal{B}\left(X_{r}\right) \cap \mathcal{B}\left(X_{r^{\prime}}\right)=\emptyset$ if $r \neq r^{\prime}$.

The elements of the alphabet $A(X)$ are named letter.

### 2.2.2. Depth

As we have a one-to-one correspondence between $\left(A^{*}(X), \operatorname{conc}\right)$ and $\left(\mathcal{B}^{*}(X), \circ\right)$ :

A^{*}(X) & \rightarrow \mathcal{B}^{*}(X) \\
\mathbf{n}=n_{1} \cdot \ldots \cdot n_{r} & \mapsto B_{\mathbf{n}}=B_{n_{1}} \circ \ldots \circ B_{n_{r}}
\end{aligned}
$$

the degree of $\left[B_{\mathbf{n}}\right]$ gives a natural notion of depth for the words defined by:
Definition 6. We denote by $p: A^{*}(X) \rightarrow \mathbb{N}$ the mapping defined by:

p(\boldsymbol{n})=\operatorname{deg}\left(\left[B_{\boldsymbol{n}}\right]\right)-1
$$

Lemma 6. The mapping $p$ is a morphism from $\left(A^{*}(X)\right.$, conc) in $(\mathbb{N},+)$.
Proof. We prove it by induction on the length of the words. Let $n_{1}, n_{2} \in A(X)$,

Let $n_{1} \in A(X)$ and $\mathbf{n} \in A^{*}(X)$, so:

& =\operatorname{deg}\left(B_{n_{1}}\right)+\operatorname{deg}\left(B_{\mathbf{n}}\right)-1-1 \\
& =p\left(n_{1}\right)+p(\mathbf{n})
\end{aligned}
$$

### 2.2.3. The projection Theorem and rewriting of a mould expansion

Let $\mathcal{M}(X)$ be a mould series, i.e. an expression of the form

\left.\left.\left[B_{\mathbf{n}}\right]=\left[B_{n_{1} \ldots n_{r}}\right]=\left[\ldots\left[\left[B_{n_{1}}, B_{n_{2}}\right], B_{n_{3}}\right], \ldots\right], B_{n_{r-1}}\right], B_{n_{r}}\right] \tag{28}
\end{equation*}
$$

We can reorganize this sum using the depth as follows:

where

\begin{equation*}
\mathcal{M}_{d}(X)=\sum_{\substack{\mathbf{n} \in A^{*}(X) \\ p(\mathbf{n})=d}} M^{\mathbf{n}} B_{\mathbf{n}} . \tag{30}
\end{equation*}
$$

A useful consequence is that the equation $\mathcal{M}(X)=0$ is equivalent to $\mathcal{M}_{d}(X)=0$ for all $d \geq 1$.

### 2.2.4. Expression of the correction and criterion of linearisability

The main property of the correction is that it provides a useful and simple criterion of lineariz245 ability. Indeed, we have by definition of the correction (see [14], p.258) :

Lemma 7. A vector field $X$ is linearizable if and only if $\operatorname{Carr}(X)=0$.

Using the above decomposition, we obtain an explicit criterion for linearizability writing $\operatorname{Carr}(X)$ as :

\operatorname{Carr}(X)=\sum_{p \geq 1}\left(\sum_{\substack{\mathbf{n} \in A^{*}(X) \\ p(\mathbf{n})=p}} \operatorname{Carr}^{\mathbf{n}} B_{\mathbf{n}}\right)=\sum_{p \geq 1} \operatorname{Carr}_{p}(X)
$$

Theorem 8. A vector fields $X$ is linearizable if and only if $\operatorname{Carr}_{p}(X)=0 \forall p \geq 1$.

In the following, we derive some properties of the quantities $\operatorname{Carr}_{p}(X)$.

### 2.3. Correction of real polynomial Hamiltonian vector fields

### 2.3.1. General properties

An interesting property of the correction is that we just have to consider the even depth, indeed:

Theorem 9. Let $X$ be a real Hamiltonian vector fields as above. Its correction in odd depth is zero, i.e.

255 for all integer $p$.

This theorem is a consequence of the following lemma :
Lemma 8. For a resonant word $\boldsymbol{n}$, the related Lie bracket is on the form :

\left[B_{\boldsymbol{n}}\right]=(x y)^{\frac{p(\boldsymbol{n})}{2}}\left(P_{\boldsymbol{n}} x \partial_{x}+Q_{\boldsymbol{n}} y \partial_{y}\right)
$$

Proof. For all resonant word $\mathbf{n}=n_{1} \cdot \ldots \cdot n_{r}$, the related Lie bracket is :

$$
\left[B_{\mathbf{n}}\right]=x^{\sum n_{j}^{1}} y^{\sum n_{j}^{2}}\left(P_{\mathbf{n}} x \partial_{x}+Q_{\mathbf{n}} y \partial_{y}\right)
$$

where $n_{j}=\left(n_{j}^{1}, n_{j}^{2}\right)$. As $\mathbf{n}$ is resonant, we have :

$$
\begin{aligned}
\omega(\mathbf{n}) & =\omega\left(n_{1}\right)+\ldots+\omega\left(n_{r}\right) \\
& =i\left(\sum n_{j}^{1}-\sum n_{j}^{2}\right)=0
\end{aligned}
$$

then $\sum n_{j}^{1}=\sum n_{j}^{2}=\alpha \in \mathbb{N}$. We just have to remark that $p(\mathbf{n})=p\left(n_{1}\right)+\ldots+p\left(n_{r}\right)=$ $\sum n_{j}^{1}+\sum n_{j}^{2}=2 \alpha$, then $\alpha=\frac{p(\mathbf{n})}{2}$.

As a consequence, we can restrict our attention to the even components of the correction. For a given integer $p$, terms in $C a r r_{2 p}$ can be decomposed with respect to the length of words. Precisely, we have

\operatorname{Carr}_{p}(X)=\operatorname{Car}_{p, 1}(X)+\cdots+\operatorname{Car}_{p, p}(X) \tag{32}
\end{equation*}
$$

where

$$
\begin{equation*}
\operatorname{Carr}_{p, j}(X)=\sum_{\substack{\mathbf{n} \in A^{*}(X) \\ p(\mathbf{n})=p, l(\mathbf{n})=j}} \operatorname{Carr}^{\mathbf{n}} B_{\mathbf{n}}, \tag{33}
\end{equation*}
$$

for $j=1, \ldots, p$.
The main point is that of course, this is a finite sum. Indeed, as each differential operator entering in the definition are at least of depth one, we can not have more than a word of length $p$ as for all $j \in \mathbb{N}^{*}, \mathbf{n} \in A^{*}(X)$ such that $l(\mathbf{n})=j$, we have $p(\mathbf{n}) \geq j$.

Moreover, some of these terms are easily determined.

Lemma 9. Let $p \in \mathbb{N}^{*}$, we have

\begin{align*}
& \operatorname{Carr}_{2 p, 2 p}(X)=\operatorname{Carr}_{2 p, 2 p}\left(X_{2}\right) \\
& \operatorname{Carr}_{2 p, 2}(X)=\operatorname{Carr}_{2 p, 2}\left(X_{p+1}\right)+\sum_{r=2}^{p} \operatorname{Carr}_{2 p, 2}\left(X_{r}, X_{2 p-r+2}\right)  \tag{34}\\
& \operatorname{Carr}_{2 p, 1}(X)=\operatorname{Carr}_{2 p}\left(X_{2 p+1}\right)=B_{p, p}
\end{align*}
$$

This Lemma has important implications on the following, as it gives the maximal degree of the homogeneous vector fields $X_{r}$ entering in the computation of a given correction term. In particular, for $\operatorname{Carr}_{2 p}$ we have no terms coming from the $X_{r}$ with $r \geq 2 p+2$.

The proof of Lemma 9 is based on the properties of the set of resonant words with respects to length and depth.

Proof. i) The first equality easily follows from the fact that an element of depth $2 p$ and length $2 p$ is necessarily made of elements of depth 1 corresponding to operators in $X_{2}$.

280 correction term of depth $2 p$. We denoted by $\mathcal{W}\left(X_{r}\right)$ the set of weights coming from the component $X_{r}$ of $X$ and given by :

\mathcal{W}\left(X_{r}\right)=\left\{\langle n, \lambda\rangle, n \in A\left(X_{r}\right)\right\} \tag{35}
\end{equation*}
$$

The first term comes from the following decomposition lemma:
Lemma 10. For every $r \geq 2, \mathcal{W}\left(X_{r}\right)$ can be decomposed in the following way:

\mathcal{W}\left(X_{r}\right)=\mathcal{W}^{+}\left(X_{r}\right) \cup \mathcal{W}^{-}\left(X_{r}\right) \cup \mathcal{W}^{0}\left(X_{r}\right)
$$

where $\mathcal{W}^{+}\left(X_{r}\right)$ is the set of positive weights coming from $X_{r}, \mathcal{W}^{-}\left(X_{r}\right)=-\mathcal{W}^{+}\left(X_{r}\right)$ and $\mathcal{W}_{r}^{0}(X)$ is the set of the zero weight.

This decomposition shows the interaction between each homogeneous component $X_{l}$ intervening in $\operatorname{Carr}_{2 p, 2}(X)$. In length 2, as any weight as its symmetric counterpart, we always have a contribution of $X_{p+1}$.
iii) The third equality follows directly from a computation:

Lemma 11. A component $X_{r}, r \geq 2$, produces a resonant letter in $A(X)$ if and only if $r$ is odd. In this case, the letter is unique and given by $n_{0}=\left(\frac{r-1}{2}, \frac{r-1}{2}\right)$.

Proof. Let $r \geq 2$ be fixed. By Lemma 4 we know the set of letters produced by $X_{r}$. The two letters $(-1, r)$ and $(r,-1)$ are never resonant. For the other ones given by $(k-1, r-k)$, one must solve the equation of resonance

for $k=1, \ldots, r$. This equation has a unique solution given by

This concludes the proof of Lemma 9.

### 2.3.2. Explicit computation and the fundamental Lemma

Let $X$ a polynomial vector field in $\mathbb{C}^{2}$ of the form:

where $P_{r}$ and $Q_{r}$ are homogeneous polynomials of degree $r$.
Lemma 12. The complex vector field (38) corresponds to a real vector field if for all $r=2, \ldots, d$, we have

$$
\begin{equation*}
\overline{p_{i, j}}=q_{j, i}, i=0, \ldots, r-1, j=r-i . \tag{39}
\end{equation*}
$$

The proof follows easily from the fact that $\bar{x}=y$ and $Q_{r}(x, y)=\overline{P_{r}(x, y)}$ which gives $Q_{r}(x, y)=\overline{P_{r}}(y, x)$ for all $r=2, \ldots, d$.

Real Hamiltonian systems satisfy moreover the following conditions:
310 Lemma 13. The complex vector field (38) corresponds to a real Hamiltonian vector fields if conditions (39) are satisfied and moreover if for all $r=2, \ldots, d$, we have

$$
\begin{equation*}
p_{i-1, r-i}=-\frac{r-i+1}{i} \overline{p_{r-i, i-1}}, \quad i=1, \ldots, r . \tag{40}
\end{equation*}
$$

We give some examples of relations between the coefficients in $X_{2}$ and $X_{3}$ :
Example 2. For the vector field $X_{2}$ defined above, we have:

$$
\begin{aligned}
& p_{1,0}=\frac{-1}{2} \bar{p}_{0,1} \\
& p_{-1,2}=\bar{q}_{2,-1}
\end{aligned}
$$

For the vector field $X_{3}$, we have :

$$
\begin{aligned}
& p_{2,0}=\frac{-1}{3} \bar{p}_{0,2} \\
& p_{1,1}=-\bar{p}_{1,1} \\
& p_{-1,3}=\bar{q}_{3,-1}
\end{aligned}
$$

Under the two previous conditions on the coefficients we have:
Lemma 14 (Fundamental Lemma). Let $X$ be a real Hamiltonian vector fields of the form $X=$ $i\left(x \partial_{x}-y \partial_{y}\right)+\sum_{j=r}^{2 r-1}\left(P_{j}(x, y) \partial_{x}+\overline{P_{j}(x, y)} \partial_{y}\right)$ with $\bar{x}=y$, then:

$$
\operatorname{Carr}_{2(r-1)}(X)=p_{r-1, r-1}+i\left(\sum_{k=\left[\frac{r+1}{2}\right]+1}^{r} \frac{r(r+1)}{(r-k+1)^{2}}\left|p_{k-1, r-k}\right|^{2}+\frac{r}{r+1}\left|p_{-1, r}\right|^{2}\right)
$$

Proof. The computation of the correction in depth $2(k-1)$ requires to know which operators appear in it and the alphabet. In this depth, there are just the homogeneous differential operators from the polynomial $P_{r}$ and the resonant letter from the polynomial $P_{2 r-1}$.
The alphabet given by $P_{r}$ is $A\left(X_{r}\right)=\{(r,-1),(-1, r),(k-1, r-k)$ with $k=1, \ldots, r\}$.
We also have the homogeneous differential operators :

$$
B_{(-1, r)}=p_{-1, r} y^{r} \partial_{x}, B_{(r,-1)}=q_{r,-1} x^{r} \partial_{y}, B_{(k-1, r-k)}=x^{k-1} y^{r-k}\left(p_{k-1, r-k} x \partial_{x}+q_{k-1, r-k} y \partial_{y}\right)
$$

with $k \in\{1, \ldots, r\}$.
Here the resonant words are :

$$
\begin{aligned}
& ((k-1, r-k),(r-k, k-1)) \\
& ((r-k, k-1),(k-1, r-k)) \\
& ((-1, r),(r-1)) \\
& ((r,-1),(-1, r))
\end{aligned}
$$

So the Lie brackets associated, using the real and Hamiltonian conditions, are:

$$
\begin{aligned}
{\left[B_{(k-1, r-k)}, B_{(r-k, k-1)}\right] } & =\frac{r(r+1)(2 k-r-1)}{(r-k+1)^{2}}\left|p_{k-1, r-k}\right|^{2}(x y)^{r-1}\left(x \partial_{x}-y \partial_{y}\right) \\
& =-\left[B_{(r-k, k-1)}, B_{(k-1, r-k)}\right] \\
{\left[B_{(-1, r)}, B_{(r,-1)}\right] } & =-r\left|p_{-1, r}\right|^{2}(x y)^{r-1}\left(x \partial_{x}-y \partial_{y}\right)=-\left[B_{(r,-1)}, B_{(-1, r)}\right]
\end{aligned}
$$

The mould of the correction in this resonant word are:

$$
\begin{aligned}
\operatorname{Carr}^{(k-1, r-k) \cdot(r-k, k-1)} & =\frac{i}{2 k-r-1} \\
\operatorname{Carr}^{(-1, r) \cdot(r,-1)} & =\frac{-i}{r+1}
\end{aligned}
$$

The only resonant letter in $P_{2 k-1}$ is $p_{r-1, r-1}$ with the operator $B_{(r-1, r-1)}=p_{r-1, r-1}(x y)^{r-1}\left(x \partial_{x}-\right.$ $\left.y \partial_{y}\right)$. Using the alternality of the mould $\operatorname{Carr}{ }^{\bullet}$ and the skew-symmetric of the Lie brackets, we get the formula :

$$
\operatorname{Carr}_{2(k-1)}(X)=p_{r-1, r-1}+i\left(\sum_{k=\left[\frac{r+1}{2}\right]+1}^{r} \frac{r(r+1)}{(r-k+1)^{2}}\left|p_{k-1, r-k}\right|^{2}+\frac{r}{r+1}\left|p_{-1, r}\right|^{2}\right)
$$

### 2.3.3. Examples of computations

We give examples of computations of the correction.

The quadratic case. We consider the real Hamiltonian vector field :

$$
X=X_{l i n}+X_{2}
$$

We remind that the alphabet is given by $A\left(X_{2}\right)=\{(1,0),(0,1),(2,-1),(-1,2)\}$ (see Section 2.1.3) and is non resonant.

The first none trivial correction term is then in depth 2 .

The correction in depth 2 is given by:

$$
\begin{aligned}
\operatorname{Carr}_{2}(X)= & \operatorname{Carr}_{2,2}(X) \\
= & \sum_{\substack{\mathbf{n} \in A^{*}(X) \\
p(\mathbf{n})=2 \\
\omega(\mathbf{n})=0}} \operatorname{Carr}^{\mathbf{n}} B_{\mathbf{n}} \\
= & \sum_{\substack{\mathbf{n} \in A^{*}(X) \\
p(\mathbf{n})=2 \\
\omega(\mathbf{n})=0}} \frac{1}{\ell(\mathbf{n})} \operatorname{Carr}^{\mathbf{n}} B_{[\mathbf{n}]} \\
= & \frac{1}{2}\left(\operatorname{Carr}^{(1,0) \cdot(0,1)} B_{[(1,0) \cdot(0,1)]}+\operatorname{Carr}^{(0,1) \cdot(1,0)} B_{[(0,1) \cdot(1,0)]}\right. \\
& \left.+\operatorname{Carr}^{(2,-1) \cdot(-1,2)} B_{[(2,-1) \cdot(-1,2)]}+\operatorname{Carr}^{(-1,2) \cdot(2,-1)} B_{[(-1,2) \cdot(2,-1)]}\right) .
\end{aligned}
$$

By the Fundamental Lemma, we finally have :

$$
\operatorname{Carr}_{2}(X)=i\left(6\left|p_{1,0}\right|^{2}+\frac{2}{3}\left|p_{-1,2}\right|^{2}\right)
$$

The cubic case. We consider the real Hamiltonian vector field :

$$
X=X_{l i n}+X_{2}+X_{3}
$$

with $X_{2}=\left(p_{1,0} x^{2}+p_{0,1} x y+p-1,2 y^{2}\right) \partial_{x}+\left(q_{2,-1} x^{2}+q_{0,1} x y+q_{1,0}\right) \partial_{y}$ and $X_{3}=\left(p_{2,0} x^{3}+p 1,1 x^{2} y+\right.$ $\left.p_{0,2} x y^{2}+p_{-1,3} y^{3}\right) \partial_{x}+\left(q_{3,-1} x^{3}+q_{2,0} x^{2} y+q_{1,1} x y^{2}+q_{0,2} y^{3}\right) \partial_{y}$.
As above, the first none trivial correction is in depth 2 :

$$
\operatorname{Carr}_{2}(X)=\operatorname{Carr}_{2,1}\left(X_{3}\right)+\operatorname{Carr}_{2,2}\left(X_{2}\right)
$$

The only operator which is of depth 2 from $X_{3}$ is given by its resonant letter $(1,1)$ and the operator $B_{1,1}=x y\left(p_{1,1} x \partial_{x}+q_{1,1} y \partial_{y}\right.$. So, using the previous result on the quadratic case, we have :

$$
\operatorname{Carr}_{2}(X)=p_{1,1}+i\left(6\left|p_{1,0}\right|^{2}+\frac{2}{3}\left|p_{-1,2}\right|^{2}\right)
$$

In depth 4, we have :

$$
\operatorname{Carr}_{4}(X)=\operatorname{Carr}_{4,2}\left(X_{3}, X_{3}\right)+\operatorname{Carr}_{4,3}\left(X_{3}, X_{2}, X_{2}\right)++\operatorname{Carr}_{4,4}\left(X_{2}, X_{2}, X_{2}, X_{2}\right)
$$

The different $\operatorname{Carr}_{i, j}(X)$ are given by :

$$
\begin{aligned}
& \operatorname{Carr}_{4,2}\left(X_{3}, X_{3}\right)=i\left(12\left|p_{2,0}\right|^{2}+\frac{3}{4}\left|p_{-1,3}\right|^{2}\right) \\
& \operatorname{Carr}_{4,3}\left(X_{3}, X_{2}, X_{2}\right)=-i\left(120 \operatorname{Im}\left(p_{2,0} \bar{p}_{1,0}^{2}\right)+\frac{26}{3} \operatorname{Im}\left(\bar{p}_{-1,3} p_{-1,2} \bar{p}_{1,0}\right)+40 \operatorname{Im}\left(p_{2,0} p_{-1,2} p_{1,0}\right)\right) \\
& \operatorname{Carr}_{4,4}\left(X_{2}, X_{2}, X_{2}, X_{2}\right)=i\left(-144\left|p_{1,0}\right|^{4}+12\left|p_{1,0}\right|^{2}\left|p_{-1,2}\right|^{2}-\frac{8}{9}\left|p_{-1,2}\right|^{4}+40 \operatorname{Re}\left(p_{-1,2} p_{0,1}^{3}\right)\right)
\end{aligned}
$$

The quartic case. We consider the real Hamiltonian vector field :

$$
X=X_{l i n}+X_{2}+X_{3}+X_{4}
$$

with $X_{2}$ and $X_{3}$ as above and $X_{4}=\left(p_{3,0} x^{4}+p_{2,1} x^{3} y+p_{1,2} x^{2} y^{2}+p_{0,3} x y^{3}+p_{-1,4} y^{4}\right) \partial_{x}+\left(q_{4,-1} x^{4}+\right.$ $\left.q_{3,0} x^{3} y+q_{2,1} x^{2} y^{2}+q_{1,2} x y^{3}+q_{0,3} y^{4}\right) \partial_{y}$.
The correction in depth 2 is the same as the cubic case.
In depth 4, we have :

$$
\begin{aligned}
\operatorname{Carr}_{4}(X) & =\operatorname{Carr}_{4,2}\left(X_{4}, X_{2}\right)+\operatorname{Carr}_{4,2}\left(X_{3}, X_{3}\right) \\
& +\operatorname{Carr}_{4,3}\left(X_{3}, X_{2}, X_{2}\right)+\operatorname{Carr}_{4,4}\left(X_{2}, X_{2}, X_{2}, X_{2}\right),
\end{aligned}
$$

where $\operatorname{Carr}_{4,2}\left(X_{4}, X_{2}\right)$ is given by :

$$
\operatorname{Carr}_{4,2}\left(X_{4}, X_{2}\right)=i\left(12 \operatorname{Re}\left(p_{2,1} \bar{p}_{1,0}\right)+8 \operatorname{Re}\left(p_{3,0} p_{-1,2}\right)\right)
$$

Maple program. For the interested readers, we can send some Maple program to compute the correction of a polynomial vector fields. The program can be found in [25].

## 3. The isochronous center affine variety

In this part, we prove that the set of isochronous center is a rational affine variety which is invariant under a non trivial $\mathbb{C}^{*}$ action. This affine variety is moreover explicitly described. We also give estimates on the growth of the degree of each rational polynomials entering in this description as well as the growth of the rational coefficients.

### 3.1. Affine variety of isochronous center

We consider real vector fields written in complex form as $X=X_{l i n}+P(x, y) \partial_{x}+Q(x, y) \partial_{y}$ where $P$ and $Q$ are polynomials with coefficients in $\mathbb{C}$ such that $\overline{P(x, y)}=Q(y, x)$. We denote by $N(d)$ the number of independent coefficients defining $P$ and by $\mathbf{p}$ any element of this set. By the reality condition, the coefficient of $Q$ can be deduced from those of $P$. We then identify the set of complex polynomials of a given degree $d$ with $\mathbb{C}^{N(d)}$, where $N(d)$ is given by $N(d)=\frac{(d-1)(d+4)}{2}$.

We denote by $\mathscr{L}_{d}$ the set of polynomial perturbations $(P, Q)$ of degree $d$ such that $X$ is linearizable. The set $\mathscr{L}$ can be seen as a subset of $\mathbb{C}^{N(d)}$. Precisely, we have :

Theorem 10 (Geometric structure). For all $d \geq 2$, the set $\mathscr{L}_{d}$ of isochronous centers is an affine variety over $\mathbb{Q}$ in $\mathbb{C}^{N(d)}$.

The proof is based on a precise description of the algebraic form of the correction. For all $\mathbf{n} \in A^{*}(X)$, let us denote by $P(\mathbf{n})$ and $Q(\mathbf{n})$ the coefficients given by Lemma 8 and satisfying

$$
\left[B_{\mathbf{n}}\right]=(x y)^{\frac{p(\mathbf{n})}{2}}\left(P(\mathbf{n}) x \partial_{x}+Q(\mathbf{n}) y \partial_{y}\right)
$$

Theorem 11 (Algebraic structure). For all $p \in \mathbb{N}^{*}$ the correction term $\operatorname{Carr}_{2 p}(X)$ has the form

$$
\begin{equation*}
\operatorname{Carr}_{2 p}(X)=(x y)^{p}\left[C a_{2 p}(\mathbf{p}) x \partial_{x}+\overline{C a_{2 p}(\mathbf{p})} y \partial y\right] \tag{41}
\end{equation*}
$$

where

$$
\begin{equation*}
C a_{2 p}(\mathbf{p})=\sum_{i=1}^{2 p} \frac{1}{i!} C a_{2 p, i}(\mathbf{p}) \tag{42}
\end{equation*}
$$

with

$$
\begin{equation*}
C a_{2 p, i}(\mathbf{p}):=\sum_{\substack{\mathbf{n} \in A^{*}(X) \\ p(\mathbf{n})=2 p, l(\mathbf{n})=i}} \operatorname{Carr}^{\mathbf{n}} P(\mathbf{n}), \quad i=1, \ldots, 2 p \tag{43}
\end{equation*}
$$

The quantities $C a_{2 p, i}(\mathbf{p}), i=1, \ldots, 2 p$, are explicit polynomials of degree $i$ in the coefficients ${ }_{345}$ of $P$ with coefficients in $\mathbb{Q}$ if $i$ is even and $i \mathbb{Q}$ otherwise. Moreover, these polynomials can be computed algorithmically using recursive formula.

The proof of this theorem is a consequence of two results. First, nested Lie brackets have a very special shapes which can be easily computed. Precisely, we have :

Lemma 15. For all $\mathbf{n} \in A^{*}(X)$, the coefficients $P(\mathbf{n})$ and $Q(\mathbf{n})$ are polynomials in $\mathbb{Z}\left[\mathbb{C}^{N(d)}\right]$ of degree $l(\mathbf{n})$ and defined recursively on the length of $\mathbf{n}$ by

$$
\begin{align*}
& P(n \mathbf{n})=\left(|\mathbf{n}|^{1}-n^{1}\right) p_{n} P(\mathbf{n})+|\mathbf{n}|^{2} q_{n} P(\mathbf{n})-n^{2} p_{n} Q(\mathbf{n}),  \tag{44}\\
& Q(n \mathbf{n})=\left(|\mathbf{n}|^{2}-n^{2}\right) q_{n} Q(\mathbf{n})+|\mathbf{n}|^{1} p_{n} Q(\mathbf{n})-n^{1} q_{n} P(\mathbf{n}) .
\end{align*}
$$

where for $\boldsymbol{n}=n_{1} \cdot \ldots \cdot n_{r} \in A^{*}(X)$, we let $|n|^{j}=n_{1}^{j}+\ldots+n_{r}^{j}, j=1,2$ with $n_{i}=\left(n_{i}^{1}, n_{i}^{2}\right)$.

Second, the correction mould can also be computed by a recursive formula from which we deduce :

Lemma 16. For all $\mathbf{n} \in A^{*}(X)$, the mould Carr $^{\mathbf{n}}$ belongs to $\mathbb{Q}$ if $l(\mathbf{n})$ is odd and $i \mathbb{Q}$ if $l(\mathbf{n})$ is even.

The proof of Theorem 11 easily follows.

### 3.1.1. Proof of Theorem 10

Using Theorem 11 and the characterization of isochronous centers given by Theorem 8 , the set $\mathcal{L}_{d}$ is defined by the zero set of an infinite family of polynomials over $\mathbb{C}^{N(d)}$ given by

$$
\begin{equation*}
\mathcal{L}_{d}=\left\{P \in \mathbb{C}^{N(d)}, C a_{2 p}(X)=0, p \geq 1\right\} \tag{45}
\end{equation*}
$$

${ }_{360}$ We define the ascending chain of ideals $I_{k}$ generated by $\left\langle C a_{2}(\mathbf{p}), \ldots, C a_{2 k}(\mathbf{p})\right\rangle$ in $\mathbb{C}[\mathbf{p}]$. By the Hilbert Basis Theorem (see [4], Theorem 4, p.77), there exists an $M(d) \in \mathbb{N}^{*}$ such that $I_{M}=$ $I_{M+1}=\ldots$ We denote by $\mathcal{I}_{d}$ the resulting ideal. As a consequence, the set $\mathcal{L}_{d}$ can be obtained as (see [4], Definition 8,p.81)

$$
\begin{equation*}
\mathcal{L}_{d}=\mathbf{V}\left(\mathcal{I}_{d}\right)=\left\{\mathbf{p} \in \mathbb{C}^{N(d)} \mid f(\mathbf{p})=0 \text { for all } f \in \mathcal{I}_{d}\right\} \tag{46}
\end{equation*}
$$

and corresponds to the affine variety (see [4], Proposition 9 p.81) defined by

$$
\begin{equation*}
\mathcal{L}_{d}=\mathbf{V}\left(f_{1}, \ldots, f_{s(d)}\right)=\left\{\mathbf{p} \in \mathbb{C}^{N(d)} \mid f_{i}(\mathbf{p})=0 \text { for all } i=1, \ldots, s(d)\right\} \tag{47}
\end{equation*}
$$

where the finite family of polynomials $f_{i}, i=1, \ldots, s(d)$ is a generating set of $\mathcal{I}_{d}$. As the polynomials defining this variety have coefficients in $\mathbb{Q}$ or $i \mathbb{Q}$ this concludes the proof.

Remark 2. Theorem 10 together with Theorem 11 gives explicit informations on the degree as well as on the growth of the rational coefficients entering in the definition of the affine variety. A natural question is up to which extend these informations can be used to provide a natural upper bound on the number of generators for the ideal generating $\mathcal{L}_{d}$ thanks to a constructive version of the Hilbert basis theorem. This will be explored in another work.

## 3.2. $\mathbb{C}^{*}$-invariance

The resonant character of the correction has an interesting consequence on the rational algebraic variety of isochronous center. Indeed, let us consider the following action of $\mathbb{C}^{*}$ :

Definition 7. Let $\lambda \in \mathbb{C}^{*}$, we denote by $T_{\lambda}$ the map

$$
\begin{aligned}
T_{\lambda}: \mathscr{C}^{N(d)} & \rightarrow \mathscr{C}^{N(d)} \\
p \bullet & \mapsto \lambda^{\omega(\bullet)} p
\end{aligned}
$$

where • is an arbitrary letter.
We extend this action for all monomials $p_{\mathbf{n}}=p_{1}^{n_{1}} \ldots p_{r}^{n_{r}}$, with $\mathbf{n}$ is a word $n_{1} \cdot \ldots \cdot n_{r}$, we have:

$$
\begin{aligned}
T_{\lambda}\left(p_{\mathbf{n}}\right) & =T_{\lambda}\left(p_{1}^{n_{1}} \ldots p_{r}^{n_{r}}\right) \\
& =\lambda^{\omega\left(n_{1}\right)+\ldots+\omega\left(n_{r}\right)} p_{\mathbf{n}} \\
& =\lambda^{\omega(\mathbf{n})} p_{\mathbf{n}} .
\end{aligned}
$$

We denoted by $\left[B_{\mathbf{n}}\right]=\left[B_{n_{1} \ldots \ldots n_{r}}\right]=(x y)^{\frac{p(\mathbf{n})}{2}}\left(P(\mathbf{n}) x \partial_{x}+Q(\mathbf{n}) y \partial_{y}\right)$ where, as we have just shown, $P(\mathbf{n})$ and $Q(\mathbf{n})$ are polynomial in the coefficient of $B_{n_{1}}, \ldots, B_{n_{r}}$. We have the following lemma which show the $\mathbb{C}^{*}$-invariance:

Lemma 17. For all resonant word $n$, we have :

$$
T_{\lambda}(P(\boldsymbol{n}))=P(\boldsymbol{n}) \text { and } T_{\lambda}(Q(\boldsymbol{n}))=Q(\boldsymbol{n}) .
$$

Proof. By definition of a resonant word, we have $\omega(\mathbf{n})=0$. So :

$$
T_{\lambda}\left(p_{\mathbf{n}}\right)=\lambda^{\omega(\mathbf{n})} p_{\mathbf{n}}=\lambda^{0} p_{\mathbf{n}}=p_{\mathbf{n}} .
$$

Corollary 2. For all $\lambda \in \mathbb{C}^{*}$, the algebraic variety $\mathscr{L}_{d}$ of the isochronous centers is invariant under the action of $T_{\lambda}$.

Proof. To prove this corollary we just have to remind that only the resonant word contribute to the linearisability. We can conclude by the above lemma.

## 4. Proof of the main results

### 4.1. Proof of Theorem 1

Let $X$ be a real Hamiltonian vector field of even degree $2 n$ of the form :

$$
X=X_{l i n}+\sum_{r=2}^{2 n} X_{r} .
$$

For each $X_{r}$, we can associate its depth as follows :

| $X_{r}$ | Depth |
| :--- | :--- |
| $X_{2}$ | 1 |
| $X_{3}$ | 2 |
| $X_{3}$ | 3 |
| $\ldots$ | $\ldots$ |
| $X_{2 n-1}$ | $2 n-2$ |
| $X_{2 n}$ | $2 n-1$ |

By Theorem 7, we are only interested by the even depth. As a consequence, we look for all possible combinations of arbitrary length which give rise under Lie bracket to an even depth vector field. In the following, we denote by $\left[X_{k_{1}}, \ldots, X_{k_{r}}\right]$ the set of operators that one obtain by nested Lie brackets of homogeneous differential operators $B_{n_{i}}$ coming from $X_{k_{i}}, i=1, \ldots, r$. As an example, we have :

| $\left[X_{2}, X_{2}\right]$ | 2 |
| $X_{5}$ | 4 |

| $\left[X_{3}, X_{3}\right]$ | 4 |
| $\left[X_{3}, X_{2}, X_{2}\right]$ | 4 |
| $X_{7}$ | 6 |
| $\left[X_{6}, X_{2}\right]$ | 6 |
| $\left[X_{5}, X_{3}\right]$ | 6 |
| $\left[X_{4}, X_{4}\right]$ | 6 |
| $\left[X_{5}, X_{2}, X_{2}\right]$ | 6 |
| $\left[X_{4}, X_{3}, X_{2}\right]$ | 6 |
| $\left[X_{4}, X_{2}, X_{2}, X_{2}\right]$ | 6 |
| $\left[X_{3}, X_{2}, X_{2}, X_{2}, X_{2}\right]$ | 6 |
| $\left[X_{2}, X_{2}, X_{2}, X_{2}, X_{2}, X_{2}\right]$ | 6 |

The correction in depth 2 is given by :

$$
\operatorname{Carr}_{2}(X)=\operatorname{Carr}_{2,1}\left(X_{3}\right)+\operatorname{Carr}_{2,2}\left(X_{2}\right),
$$

As the depth is a morphism we have the contribution of the Lie bracket of $X_{2}$, we also have the contribution of the resonant letter of $X_{3}$. By the Fundamental Lemma, the correction is given by

By the linearisation criterion, we must have $\operatorname{Carr}_{2}(X)=0$. This implies that

As $X$ is real and Hamiltonian, the first equation is always satisfied. The second one has only a non trivial solution if and only if $\operatorname{Im}\left(p_{1,1}\right)<0$. The situation when $\operatorname{Im}\left(p_{1,1}\right) \geq 0$ leads to two distinct cases. When $\operatorname{Im}\left(p_{1,1}\right)=0$, the Birkhoff sphere reduce to 0 and we obtain $X_{2}=0$. When $\operatorname{Im}\left(p_{1,1}\right)>0$, the equation can not be satisfied and the vector field is then nonisochronous.

Assume that $p_{1,1}=0$ then $X_{2}=0$ and we are reduce to the case

As $p_{1,1}=0$, the first non zero term of the correction is $\operatorname{Carr}_{4}(X)$. By the fundamental Lemma, the term $\operatorname{Carr}_{4}(X)$ has exactly the same algebraic structure than the preceding $\operatorname{Carr}_{2}(X)=0$
case. The role of $X_{2}$ is played by $X_{3}$ and the role of the resonant term of $X_{3}$ is played by the

As $\operatorname{Im}\left(p_{r, r}\right)>0$, this equality can not be satisfied and $X$ is nonisochronous.

Case 2: $r=n-1$. In this case, we are reduced to an homogeneous perturbation of degree $2 n$ and the correction is given by

As $X_{2 n}$ is nontrivial, this equation can not be satisfied and $X$ is nonisochrnous.

This concludes the proof of the Theorem.

### 4.2. Proof of Theorem 2

The proof follows the lines of those of Theorem 1 . We have to distinguish two cases : $k$ is even or odd.

Case 1: $k$ is even. The vector field $X_{k}$ does not contain resonant terms. As a consequence, its first contribution to the correction appears in depth $2(k-1)$ corresponding to resonant Lie brackets of homogeneous differential operators in $X_{k}$ of length two. As $l \leq k-1$, this implies that $2 l-1<2 l \leq 2(k-1)$. The even component between $X_{k}$ and $X_{2 l}$ will come into play in the correction only with a greater depth as $2(k-1)$ by Lie brackets of length at least two. In the same way, for odd components, the resonant term will intervene in the correction with a strictly smaller depth in length one and the other terms in depth greater than $2(k-1)$ by a Lie brackets
of length at least two.

As a consequence, the correction term coming from an even $k$ is given by :

435 In order to satisfy the linearisability criterion, we must have $\operatorname{Carr}_{2(k-1)}=0$. If the component $X_{k}$ is non trivial then the system is already non isochronous. Otherwise, we have $X_{k}=0$ and we are leaded to the same problem but with an odd component.

Case 2: $k$ is odd. In this case the vector field $X_{k}$ contain a resonant homogeneous operator. 440 Let us write $k=2 m+1$ then $B_{m, m}$ is of depth $2 m$ and weight zero. We have

By the linearisability criterion, $\operatorname{Carr}_{k-1}(X)=0$ and the resonant term $B_{m, m}$ in $X_{k}$ is zero. The contribution of $X_{k}$ in length 2 follows the same argument as for the even case and we deduce that finally $X_{k}=0$.

445 As a consequence, we can prove by induction that in order to be linearisable the components $X_{k}, \ldots, X_{2 l}$ must be zero. But, by assumption, we have that $X_{2 l}$ is non trivial. As a consequence, the vector field $X$ is necessarily nonisochronous.

### 4.3. Proof of Theorem 3

The strategy of proof follows those of Theorem 2. The main observation is that there exists no interactions between each family of vector fields $\left\{X_{k}, \ldots, X_{2 l}\right\}$ and $\left\{X_{c_{n}}, \ldots, X_{2\left(c_{n}-1\right)}\right\}, n=$ $1, \ldots, m$. Indeed, let us first analyse the depth of all these objects. We have :

Following the same lines as for Theorem 2, we see that the arguments based on the contributions of a given component belonging to $\left\{X_{k}, \ldots, X_{2 l}\right\}$ are valid. In other words, we easily proved

By induction, we easily deduce that a vector field of this type is linearisable if and only if all the components vanish. As by assumption we are considering a non trivial vector field, we are leaded to a contradiction and the vector field is necessarily nonisochronous.

## 5. Conclusion and perspectives

 that in order to be linearisable, then one must have $X_{k}=\cdots=X_{2 l-2}=0$. The last argument concerning $X_{2 l}$ is also satisfies because the first contribution of $X_{2 l}$ to the correction is of length two and depth $4 l-2$ which is not disturbed by terms of the remaining family $\left\{X_{c_{n}}, \ldots, X_{2\left(c_{n}-1\right)}\right\}$, $n=1, \ldots, m$ as the minimal contribution of these terms to the correction is in depth $4 l-1$.As a consequence, a vector fields of this type will be linearisable if $X_{k}=\cdots=X_{2 l}=0$.

By the same argument, we see that there exists no interaction between the family $\left\{X_{c_{1}}, \ldots\right.$ $\left.\ldots, X_{2\left(c_{1}-1\right)}\right\}$ and the remaining one $\left\{X_{c_{n}}, \ldots, X_{2\left(c_{n}-1\right)}\right\}, n=2, \ldots, m$. We deduce that a linearisable vector field of this type must satisfy $X_{c_{1}}=\cdots=X_{2\left(c_{1}-1\right)}$.

### 5.1. Toward a complete proof of the Jarque-Villadelprat conjecture

Our main results give a very strong support to the Jarque-Villadelprat conjecture. The remaining cases always deal with the role of the resonant term in the deformation of the Birkhoff's
spheres. However, the phenomenon which is working for a quartic perturbation, which was precisely studied by Jarque and Villadelprat using geometrical methods, must applies in the same way for arbitrary degrees. Indeed, as we have seem in our derivation of the main results, the algebraic structure of the correction during the cancellation process does not change and can be closely investigated. We have then some directions in order to solve completely the Jarque-Villadelprat conjecture :

- Can we prove using an extension of our method the quartic case?
number of generators of the ideal. The isochronous centers seem to be more tractable than the usual center. However, it is clear that any advance in this direction will have consequences on the local 16th Hilbert problem. Indeed, the same kind of combinatoric and tools can be used to obtain analogous information for centers of polynomial vector fields (see [8]).


### 5.3. Isochronicity for complex Hamiltonian systems

In [21], the authors study isochronicity of complex Hamiltonian systems when the linear part has for spectrum $(1,-1)$. Our method and results extend naturally to this case and give an explicit and algorithmic description of the isochronous centers affine variety. This will be the subject of a forthcoming work.

## Appendix B. Properties of the Correction's mould

The proofs of Lemma 1 and 2 use the definition of the mould of the correction using the variance formula (12) and also an alternative one based on the knowledge of the mould of a given prenormal form that we remind in the next Section.

The neutral element for the composition of moulds is denoted by $I^{\bullet}$ and is defined by $I^{\mathbf{n}}=1$ if $\ell(\mathbf{n})=1$ and $I^{\mathbf{n}}=0$ for $\ell(\mathbf{n}) \neq 1$.

\omega\left(n_{1}\right) \operatorname{Carr}^{n_{1} \cdot n_{2}}=-\operatorname{Carr}^{n_{1}+n_{2}}=-1 \tag{B.14}
\end{equation*}
$$

As a consequence, we have

$$
\begin{equation*}
\operatorname{Carr}^{n_{1} \cdot n_{2}}=\frac{-1}{\omega\left(n_{1}\right)} \tag{B.15}
\end{equation*}
$$

We can also prove this result using the alternative definition :

$$
\begin{aligned}
I^{n_{1} \cdot n_{2}}-\operatorname{Carr}^{n_{1} \cdot n_{2}} & =\left(\left(I^{\bullet}-M^{\bullet}\right)^{\circ 2}\right)^{n_{1} \cdot n_{2}} \\
& =\left(\left(I^{\bullet}-M^{\bullet}\right) \circ\left(I^{\bullet}-\operatorname{Carr}^{\bullet}\right)\right)^{n_{1} \cdot n_{2}} \\
& =\left(I^{\bullet}-M^{\bullet}\right)^{\left\|n_{1} \cdot n_{2}\right\|}\left(I^{\bullet}-\operatorname{Carr}^{\bullet}\right)^{n_{1} \cdot n_{2}}+ \\
& \left.+\left(I^{\bullet}-M^{\bullet}\right)\right)^{\left\|n_{1}\right\| \cdot\left\|n_{2}\right\|}\left(I^{\bullet}-\operatorname{Carr}^{\bullet}\right)^{n_{1}}\left(I^{\bullet}-\operatorname{Carr}^{\bullet}\right)^{n_{2}}
\end{aligned}
$$

As above we will use the mould Tram ${ }^{\bullet}$ in length 2, $\operatorname{Carr}^{n_{1} \cdot n_{2}}=\operatorname{Tram}^{n_{1} \cdot n_{2}}=\frac{\omega\left(n_{2}\right)-\omega\left(n_{1}\right)}{\omega\left(n_{1}\right) \omega\left(n_{2}\right)}$. As $\omega\left(n_{1}\right)=-\omega\left(n_{2}\right)$, we finally have :

$$
\operatorname{Carr}^{n_{1} \cdot n_{2}}=\frac{1}{\omega\left(n_{1}\right)}
$$

As we can see the result differs by a multiplication by -1 . It is due to the fact in [13] and [14], the nested Lie brackets are taken in this form $\left[B_{n_{1} \ldots \ldots n_{r}}\right]=\left[B_{n_{r}},\left[B_{n_{r-1}},\left[\ldots\left[B_{n_{2}}, B_{n_{1}}\right] ..\right]\right]\right.$ whereas in [7] and [5] we consider $\left.\left.\left[B_{n_{1} \cdot \ldots \cdot n_{r}}\right]=\left[\ldots\left[B_{n_{1}}, B_{n_{2}}\right], \ldots\right], B_{n_{r-1}}\right], B_{n_{r}}\right]$. And we have the relation:

\left.\left.\left[B_{n_{r}},\left[B_{n_{r-1}},\left[\ldots\left[B_{n_{2}}, B_{n_{1}}\right] . .\right]\right]=(-1)^{r+1}\left[B_{n_{1}}, B_{n_{2}}\right], \ldots\right], B_{n_{r-1}}\right], B_{n_{r}}\right]
$$

Appendix B.3.3. The mould Carr ${ }^{\bullet}$ in length 3
Using the variance formula we obtain for a word $\mathbf{n}=n_{1} n_{2} n_{3}$ of length 3 the following equality:

\omega\left(n_{1}\right) \operatorname{Carr}^{n_{1} \cdot n_{2} \cdot n_{3}}+\operatorname{Carr}^{\left(n_{1}+n_{2}\right) \cdot n_{3}}=\operatorname{Carr}^{n_{1} \cdot n_{3}} \operatorname{Carr}^{n_{2}}+\operatorname{Carr}^{n_{1}} \operatorname{Carr}^{n_{2} \cdot n_{3}} . \tag{B.16}
\end{equation*}

One can prove the following lemma:
Lemma 19. If $\mathbf{n} \in A(X)^{*}$ is such that $l(\mathbf{n})=3, \omega(\mathbf{n})=0$, we have the following possibilities:

1. If all the letters have zero weight, i.e. $\omega\left(n_{i}\right)=0$ for all $i=1,2,3$, then $\operatorname{Carr}^{\mathbf{n}}=0$.
2. If there exists a letter $a \in\left\{n_{1}, n_{2}, n_{3}\right\}$ such that $\omega(a)=0$ and $\omega(b) \neq 0$ for $b \in\left\{n_{1}, n_{2}, n_{3}\right\} \backslash$ $\{a\}$, then $\operatorname{Carr}^{\mathbf{n}}=0$.
3. If all the letters have a non zero weight, i.e. $\omega\left(n_{i}\right) \neq 0, i=1,2,3$, then

$$
\begin{equation*}
\operatorname{Carr}^{n_{1} \cdot n_{2} \cdot n_{3}}=\frac{1}{\omega\left(n_{1}\right)\left(\omega\left(n_{1}\right)+\omega\left(n_{2}\right)\right)} \tag{B.17}
\end{equation*}
$$

Proof. 1) This case follows from Lemma ??.
2) Let us take for example $a=n_{2}$ such that $\omega\left(n_{2}\right)=0$, then $\omega\left(n_{1} n_{3}\right)=0$ and $\omega\left(n_{3}\right)=-\omega\left(n_{1}\right)$. As a consequence, using (B.16) and the fact that $\operatorname{Carr}^{n_{2}}=1$, we obtain

$$
\begin{equation*}
\omega\left(n_{1}\right) \operatorname{Carr}^{n_{1} \cdot n_{2} \cdot n_{3}}+\operatorname{Carr}^{\left(n_{1}+n_{2}\right) \cdot n_{3}}=\operatorname{Carr}^{n_{1} \cdot n_{3}}+\operatorname{Carr}^{n_{1}} \operatorname{Carr}^{n_{2} \cdot n_{3}} . \tag{B.18}
\end{equation*}
$$

Let us assume that $n_{1}$ is such that $\omega\left(n_{1}\right) \neq 0$, then $\operatorname{Carr}^{n_{1}}=0$ and the previous equality reduces to

$$
\begin{equation*}
\omega\left(n_{1}\right) \operatorname{Carr}^{n_{1} \cdot n_{2} \cdot n_{3}}=\operatorname{Carr}^{n_{1} \cdot n_{3}}-\operatorname{Carr}^{\left(n_{1}+n_{2}\right) \cdot n_{3}} . \tag{B.19}
\end{equation*}
$$

Using the expression of the mould $\mathrm{Carr}^{\bullet}$ in length 2, we have

$$
\begin{equation*}
\operatorname{Carr}^{n_{1} \cdot n_{3}}=-1 / \omega\left(n_{1}\right), \quad \operatorname{Carr}^{\left(n_{1}+n_{2}\right) \cdot n_{3}}=-1 / \omega\left(n_{1}+n_{2}\right)=-1 / \omega\left(n_{1}\right) \tag{B.20}
\end{equation*}
$$

We deduce easily that

\omega\left(n_{1}\right) \operatorname{Carr}^{n_{1} \cdot n_{2} \cdot n_{3}}=0 \tag{B.21}
\end{equation*}
$$

and as a consequence $\operatorname{Carr}^{n_{1} \cdot n_{2} \cdot n_{3}}=0$. obtain $\operatorname{Carr}^{n_{1} n_{2} n_{3}}=0$ if $\omega(\mathbf{n})=0, \omega\left(n_{1}\right)=0$ and $\omega\left(n_{2}\right) \neq 0$.
3) From now on, let us assume that all the $\omega\left(n_{i}\right)$ are non zero. Then using formula (B.16) and the fact that $\operatorname{Carr}^{n_{1}}=0$ and $\operatorname{Carr}^{n_{2}}=0$, we obtain

\omega\left(n_{1}\right) \operatorname{Carr}^{n_{1} \cdot n_{2} \cdot n_{3}}+\operatorname{Carr}^{\left(n_{1}+n_{2}\right) \cdot n_{3}}=0 \tag{B.23}
\end{equation*}
$$

Using the expression of $\operatorname{Carr}^{\left(n_{1}+n_{2}\right) \cdot n_{3}}$ we deduce that

\begin{equation*}
\operatorname{Carr}^{n_{1} \cdot n_{2} \cdot n_{3}}=\frac{1}{\omega\left(n_{1}\right)\left(\omega\left(n_{1}\right)+\omega\left(n_{2}\right)\right)} \tag{B.24}
\end{equation*}
$$

${ }_{615}$ As in length 2, we can give an alternative proof using the mould Tram ${ }^{\bullet}$ to compute the correction

& =\left(I^{\bullet}-\operatorname{Tram}^{\bullet}\right) \circ\left(I^{\bullet}-\operatorname{Carr}^{\bullet}\right)^{n_{1} \cdot n_{2} \cdot n_{3}} \\
& =-\operatorname{Tram}^{n_{1} \cdot n_{2} \cdot n_{3}}
\end{aligned}
\end{align*}

So $\operatorname{Carr}^{n_{1} \cdot n_{2} \cdot n_{3}}=\operatorname{Tram}^{n_{1} \cdot n_{2} \cdot n_{3}}=\frac{1}{\omega\left(n_{1}\right)\left(\omega\left(n_{1}\right)+\omega\left(n_{2}\right)\right)}$.

p(\mathbf{n})=2 p, l(\mathbf{n})=i}} \operatorname{Carr}^{\mathbf{n}}(x y)^{\frac{p(\mathbf{n})}{2}}\left(P(\mathbf{n}) x \partial_{x}+Q(\mathbf{n}) y \partial_{y}\right),  \tag{C.1}\\
& =\frac{1}{i!}(x y)^{p} \sum_{\substack{\mathbf{n} \in A^{*}(X) \\
p(\mathbf{n})=2 p, l(\mathbf{n})=i}} \operatorname{Carr}^{\mathbf{n}}\left(P(\mathbf{n}) x \partial_{x}+Q(\mathbf{n}) y \partial_{y}\right) .
\end{align*}
$$

By definition of $C a_{2 p, i}(X)$ we obtain

Appendix C.2. Proof of Lemma 15
Let $B_{n}=B_{\left(n^{1}, n^{2}\right)}=x^{n^{1}} y^{n^{2}}\left(p_{n} x \partial_{x}+q_{n} y \partial_{y}\right)$ and $B_{m}=B_{\left(m^{1}, m^{2}\right)}=x^{m^{1}} y^{m^{2}}\left(p_{m} x \partial_{x}+q_{m} y \partial_{y}\right)$. Then, the Lie brackets of $B_{n}$ and $B_{m}$ is :

\begin{aligned}
{\left[B_{n m}\right]:=\left[B_{n}, B_{m}\right] } & =x^{n^{1}+m^{1}} y^{n^{2}+m^{2}}\left(P_{n, m} x \partial_{x}+Q_{n, m} y \partial_{y}\right), \\
& =x^{|n m|^{1}} y^{|n m|^{2}}\left(P_{n, m} x \partial_{x}+Q_{n, m} y \partial_{y}\right)
\end{aligned}
$$

where $P_{n, m}$ and $Q_{n, m}$ are polynomials in the coefficients of $B_{n}$ and $B_{m}$, precisely :

\begin{aligned}
& P_{n, m}=\left(m^{1}-n^{1}\right) p_{n} p_{m}+m^{2} q_{n} p_{m}-n^{2} p_{n} q_{m}, \\
& Q_{n, m}=\left(m^{2}-n^{2}\right) q_{n} q_{m}+m^{1} p_{n} q_{m}-n^{1} q_{n} p_{m} .
\end{aligned}
$$

We easily prove by induction that all the Lie bracket in any length are of the above form.
