 $\frac{30}{21}$  13 Photocrosslinked silicone acrylates are used in a variety of applications, such as printing inks adhesives or  $\frac{32}{22}$  14 adhesive release liners. Their production requires the use of a photoinitiator. Even if the photoinitiator represents  $\frac{34}{25}$  15 a minor mass in the photocurable formulation (2 to 10%), it is used in excess and residual amounts may therefore  $\frac{36}{27}$  16 remain in the polymerized products and possibly migrate into the environment during the use of the products  $\frac{38}{30}$  17 and/or at their end-of-life stage. Results showed that 44% of Darocur 1173 photoinitiator initially used in  $\frac{51}{2}$  23 silicone formulation was released from silicone matrix in the leaching test. 3 29 Adhesive release liners have a wide range of applications in everyday-life products such as labels, diaper <sup>5</sup> 30 closures, medical wound dressings, or health and beauty products (Benedek 2004). They facilitate the transfer of <sup>7</sup> 31 the adhesive from the liner. Photocrosslinked acrylate silicone coatings are widely used in this domain for their  $\frac{9}{2}$  32 unique ability to be applied and cured on various substrates and their lower release forces as compared to other  $\frac{11}{2}$  33 types of coatings. The production of self-adhesive labels accounts for 70% of the overall consumption of  $1<sup>3</sup>$  34 adhesive release liners in the world. About 20 billion square meters of release liners are produced annually  $\frac{15}{2}$  35 worldwide out of which about 10% use UV photocuring technology. 22 38 During the UV curing process at industrial scale in this field of application, radical photoinitiators are generally 24 39 applied in excess in order to favour their reactivity, usually at concentrations ranging from 2 to 10% (by weight 26 40 of the total photocurable formulation). Within the large group of known photoinitiators structures,  $\alpha$ -28 41 hydroxyalkylphenones have gained much interest due to their high reactivity, thermal stability and universal applicability (Seidl et al. 2006; Kaczmarek and Vukovic-Kwiatkowsk 2012; Belaidi et al. 2013). Darocur 1173 30 (2-hydroxy-2-methyl-1-phenylpropan-1-one) is the most widely used molecule in this group. It is commonly 32 used with silicon acrylate formulations (Gruber 1992). It has been reported that only about 10% of the 34 36 45 photoinitiator is converted during photocuring (Wipo Green 2015). The coated products therefore contain <sup>38</sup> 46 residual amounts of acrylate monomers and photoinitiator (Gruber 1992; Jang et al. 2005; Green 2010) which  $40$  47 after curing may migrate (Green 2010) to the surface of the film and be released into environmental media if the  $\frac{42}{12}$  48 polymerized products are contacted with water during their use and / or at their end-of-life stages. The products containing adhesive release films may be exposed to potentially aggressive environmental factors 49 51 52 during their use and at their end-of-life stage. For example, in outdoors applications, adhesive release liners are 53 53 exposed to UV light, temperature, oxygen, and moisture. These conditions may alter the chemical structure and 55 **54** functional properties of polymers (Colin et al. 2015) and increase the release of the residual photoinitiator, 57 55 resulting in potential environmental or health impacts. Yet, very little is known on the fate of silicone in the 59 56 environment (Laubie et al. 2012), and to our knowledge no work has been yet published on silicone acrylates 50 52 54 56 58

UV curable silicone acrylate was prepared by mixing 98% (w/w) silicone acrylate oil provided by Bluestar Silicones company (700-800 cPs at  $25^{\circ}$ C, Mn=8000, Mw = 20000 g/mol,  $D = 2.4$ ) and 2% (w/w) photo-initiator 2-Hydroxy-2-methyl-1-phenylpropane-1-one (Darocur 1173, 97%, MW 164.2 g/mol, hydrosolubility 13.3 g/L at 20 $^{\circ}$ C, CAS N $^{\circ}$  7473-98-5) purchased from BASF. The chemical structure of silicone acrylate oil is  $MD_{85}D^*M_{7.5}$  (with  $D^*$  motif= SiMe (CH<sub>2</sub>)3OCH<sub>2</sub>CHOHCH<sub>2</sub>OCOCHCH<sub>2</sub>) The mixture was stirred for 30 min at room temperature until a homogeneous liquid phase was obtained.<br>42<br>**43** 76 The formulation was coated as a 1 µm-thick layer on 20 µm-thick extruded films composed of 57% PP, 33% PE 45 77 and 9% TiO<sub>2</sub> (called GLD2) corresponding to a covering weight of 3.62 g/m<sup>2</sup>. 17 92 A drop of Darocur 1173 was analyzed by FTIR-ATR. Its spectrum, shown in Figure 3, exhibited intensive 19 93 hydroxyl absorption vO-H (with maximum at 3455 cm<sup>-1</sup>), bands at 2800-3100 cm<sup>-1</sup> range, at 1598, 1446, 1366, 21 94 957, 719 cm<sup>-1</sup> assigned to aliphatic and aromatic C-H (stretching and bending), 1670 cm<sup>-1</sup> (carbonyl C=O 23  $95$  vibration) and 1170 cm<sup>-1</sup> (C-O-C vibrations). 18 20 22

## 30 98 Evaluation of Darocur leaching

33 99 Batch leaching tests were performed by contacting thin coated film samples (GLD2) with leaching solutions of  $35$  100 different natures. An aliquote sample of 1.44 g of coated film (calculated to contain 5 mg of PI) was cut into  $\frac{37}{101}$  small pieces of 1 cm<sup>2</sup> and introduced into 50 mL high-density polyethylene flasks (HDPE) containing 20 mL of  $\frac{39}{102}$  leaching solutions. The leaching solutions used were (i) de-ionized water (pH= 6; 18 M $\Omega$ /cm, Veolia water STI), <sup>41</sup> 103 (2) acidic aqueous solution (pH=2 with HCl; Chimie-Plus Laboratories, 37%) and (iii) alcaline solution (pH=12 <sup>43</sup> 104 with NaOH; Chimie-Plus Laboratories, 98%). The flasks were placed in an orbital shaker operated in the dark at  $\frac{45}{46}$  105 9 rpm and room temperature (25°C) over 15 days. Experiments were performed in triplicates. Blanks were  $\frac{47}{40}$  106 prepared in triplicates with uncoated GLD2 films and treated in the same manner as the assays. #### 14 118 EDXRF analysis of silicone coating

17 119 The Rigaku NEX QC is a Benchtop Energy Dispersive X-ray Fluorescence (EDXRF) spectrometer which was 19 120 used for elemental analysis of silicon in film coatings on solid substrates. 

21<br>22 **121** In EDXRF, low energy "soft" X-rays (1-50 keV) are emitted from an X-ray tube. These source X-rays enter the fluorescent X rays are captured by the detector and counted by a multi channel analyzer. The X-ray analysis gives a signal proportional to the Si-atoms concentration in the coating. Calibration curves in X-ray units are used to calculate the actual silicone coat. 

### 35 127 UV spectrophotometry

Darocur 1173 (PI) was analyzed using a Jasco V 630 Spectrophotometer at a wavelength of 247 nm. Quartz cells 40 129 of 1 cm path length were used, and the respective leaching solutions were used as a reference. A calibration 42 130 range of PI was prepared in each tested solution from 1.56 mg/L to 20 mg/L. The calibration curve was linear with optical density ranging from 0 to 0.89. Samples were diluted before analysis, if necessary, to be within this 46 132 range of absorbance.

## 10 142 Results and discussion

#### $\frac{13}{14}$  143 Leaching tests  $14$   $\sim$  1.0 Leading tests

 $\frac{16}{17}$  144 Leaching tests results were expressed in mg of photoinitiator released per gram of silicone coating introduced  $\frac{18}{10}$  145 (mg/g). Results are shown in Figure 4. It can be seen that Darocur was leached at significant concentrations  $\frac{20}{21}$  146 from coated GLD2 films under all the conditions tested. Blanks with uncoated GLD2 films did not release any 22<br>23 **147** compound which may have interferred with the analysis of Darocur (data not shown). Leaching of Darocur  $\frac{24}{25}$  148 from coated films was affected by the pH of the leaching solution. Around 27% of Darocur 1173 used in the 26<br>27 **149** formulation of the films were leached in 15 days in de-ionized water (pH=6) and the alkaline solution (pH=12), 28<br>29 150 whereas around 44% were leached under acidic conditions (pH=2). The leaching tests therefore confirmed that the dosage of Darocur used in the formulation of the silicone 42 acrylates was largely in excess. The photo-initiator did not react entirely, and residual amounts were therefore 44 available to be released into the leaching solutions. Although an excess of photo-initiator is needed to guarantee 46 a good reticulation of silicon acrylates. The dosage of the photoinitiator used in the formulation of silicone 48 50 160 acrylates should be optimized on an industrial scale in order to check if the use of an amount less than 2% would 52 **161** keep the desired physico-chemical properties for the final material (coating). 43 45 47 49 51

During coating under UV radiation, the photoinitiator generates free reactive radicals that interact with the functional acrylic groups of silicone thus initiating the crosslinking of the formulation following a chain reaction initiated by these free radicals.
