# A Simple Proof of the Generalized Riemann's Hypothesis

#### Abstract

This article is the continuation of the previous RH proof[1]. We present a simple proof of the Generalized Riemann's Hypothesis (GRH) where we apply the same method we used to prove the RH.

**Keywords:** Riemann Hypothesis; Zeta function; Prime Numbers; Millennium Problems.

## 1 Dirichlet L-functions

Let's  $(z_n)_{n\geq 1}$  be a sequence of complex numbers. A Dirichlet series[3] is a series of the form  $\sum_{n=1}^\infty \frac{z_n}{n^s}$ , where  $s=\sigma+i\tau$  is complex. The zeta function is a Dirichlet series. Let's define the function L(s) of the complex s:  $L(s)=\sum_{n=1}^\infty \frac{z_n}{n^s}$ .

- If  $(z_n)_{n\geq 1}$  is a bounded, then the corresponding Dirichlet series converges absolutely on the open half-plane where  $\Re(s) > 1$ .
- If the set of sums  $z_n + z_{n+1} + ... + z_{n+k}$  for each n and  $k \ge 0$  is bounded, then the corresponding Dirichlet series converges on the open half-plane where  $\Re(s) > 0$ .
- In general, if  $z_n = O(n^k)$ , the corresponding Dirichlet series converges absolutely in the half plane where  $\Re(s) > k + 1$ .

The function L(s) is analytic on the corresponding open half plane[2-3]. To define Dirichlet L-functions we need to define Dirichlet characters. A function  $\chi: \mathbb{Z} \longrightarrow \mathbb{C}$  is a Dirichlet character modulo q if it satisfies the following criteria:

- (i)  $\chi(n) \neq 0$  if (n, q) = 1.
- (ii)  $\chi(n) = 0$  if (n, q) > 1.
- (iii)  $\chi$  is periodic with period  $q:\chi(n+q)=\chi(n)$  for all n.
- (iv)  $\chi$  is multiplicative  $:\chi(mn)=\chi(m)\chi(n)$  for all integers m and n.

The trivial character is the one with  $\chi_0(n) = 1$  whenever (n, q) = 1.

Here are some known results for a Dirichlet character modulo q. For any integer n we have  $\chi(1)=1$ . Also if (n,q)=1, we have  $(\chi(n))^{\phi(q)}=1$  with  $\phi$  is Euler's totient function.  $\chi(n)$  is a  $\phi(q)$ -th root of unity. Therefore,  $|\chi(n)|=1$  if (n,q)=1, and  $|\chi(n)|=0$  if (n,q)>1.

Also, we recall the cancellation property for Dirichlet characters modulo q: For any n integer

$$\sum_{i=1}^{q} \chi(i+n) = \begin{cases} \phi(q), & \text{if } \chi = \chi_0 \text{ the trivial character} \\ 0, & \text{if otherwise, } \chi \neq \chi_0 \end{cases}$$
 (1)

The Dirichlet L-functions are simply the sum of the Dirichlet series. Let's  $\chi$  be a Dirichlet character modulo q, The Dirichlet L-function  $L(s,\chi)$  is defined for  $\Re(s)>1$  as the following:

$$L(s,\chi) = \sum_{n=1}^{+\infty} \frac{\chi(n)}{n^s}$$
 (2)

They are a natural generalization of the Riemann zeta-function  $\zeta(s)$  to an arithmetic progression and are a powerful tool in analytic number theory. The Dirichlet series, converges absolutely and uniformly in any bounded domain in the complex s-plane for which  $\Re(s) \geq 1 + \gamma$ ,  $\gamma > 0$ . In the particular case of the trivial character  $\chi_0$ ,  $L(s,\chi_0)$  extends to a meromorphic function[2-5] in  $\Re(s) > 0$  with the only pole at s = 1.

If  $\chi$  is a non-trivial character, we have

$$L(s,\chi) = s \int_{1}^{+\infty} \frac{\sum_{n=1}^{n \le x} \chi(n)}{x^{s+1}} dx$$
 (3)

Since the sum in the integrand is bounded, this formula gives an analytic continuation of  $L(s,\chi)$  to a regular function in the half-plane  $\Re(s)>0$ . Also, like the zeta function, the Dirichlet L-functions have their Euler product[1-2]. For  $\Re(s)>1$ :

$$L(s,\chi) = \prod_{p \text{ Prime}} \left(1 - \frac{\chi(p)}{p^s}\right)^{-1} \tag{4}$$

Therefore, if  $\chi = \chi_0$  is a trivial character mod q, we have, for q = 1,

$$L(s, \chi_0) = \zeta(s) \tag{5}$$

And for q > 1, we have,

$$L(s,\chi_0) = \zeta(s) \prod_{p/q} \left(1 - \frac{1}{p^s}\right) \tag{6}$$

For this reason the properties of  $L(s, \chi_0)$  in the entire complex plane are determined by the properties of  $\zeta(s)$ .

Let's now q' be the smallest divisor (prime) of q. Let's  $\chi'$  be the Dirichlet character  $\chi'$  mod q'. For any integer n such that (n,q)=1, we have also (n,q')=1 and  $\chi(n)=\chi'(n)$ .  $\chi'$  is called primitive and  $L(s,\chi)$  and  $L(s,\chi)$  are related analytically such that if  $\chi \neq \chi_0$ :

$$L(s,\chi) = L(s,\chi') \prod_{p/q} \left( 1 - \frac{\chi'(p)}{p^s} \right) \tag{7}$$

 $L(s,\chi)$  and  $L(s,\chi')$  have the same zeros in the critical strip  $0<\Re(s)<1$ . Also, for a primitive character  $\chi$ ,  $(i.e.\chi=\chi')$   $L(s,\chi)$  has the following functional equation:

$$\tau(\chi)\Gamma(\frac{1-s+a}{2})L(1-s,\chi) = \sqrt{\pi}(\frac{q}{\pi})^s i^a q^{\frac{1}{2}} \Gamma(\frac{s+a}{2})L(s,\overline{\chi}) \tag{8}$$

Where  $\Gamma$  is the Gamma function and a=0 if  $\chi(-1)=1$  and a=1 if  $\chi(-1)=-1$ , and  $\tau(\chi)=\sum_{k=1}^q \chi(k) \exp(\frac{2\pi k i}{q})$ . When  $\Re(s)>1$  there is no zero for  $L(s,\chi)$ . When  $\Re(s)<0$ , for a

When  $\Re(s) > 1$  there is no zero for  $L(s,\chi)$ . When  $\Re(s) < 0$ , for a primitive character  $\chi$ , we have the trivial zeros of  $L(s,\chi)$ : s = a - 2k, where k is a positive integer and a is defined above. For more details, please refer to the references[1-8].

# 2 The Generalized Riemann Hypothesis

The Generalized Riemann Hypothesis states that the Dirichlet L-functions have all their non-trivial zeros on the critical line  $\Re(s) = \frac{1}{2}$ .

We know that for any character  $\chi$  modulo q, all non-trivial zeros of  $L(s,\chi)$  lies in the critical strip  $\{s\in\mathbb{C}:0<\Re(s)<1\}$ . From the functional equation above we have that if:

- $s_0$  is a non-trivial zero of  $L(s,\chi)$ , then  $1-s_0$  is a zero of  $L(s,\overline{\chi})$ .
- $s_0$  is a non-trivial zero of  $L(s, \overline{\chi})$ , then  $1 s_0$  is a zero of  $L(s, \chi)$ .

Therefore, we just need to prove that for any character<sup>1</sup>  $\chi$  modulo q, there is no non-trivial zeros of  $L(s,\chi)$  in the right hand side of the critical strip  $\{s \in \mathbb{C} : \frac{1}{2} < \Re(s) < 1\}$ .

# 3 Proof of the Generalized Riemann Hypothesis

Let's take a complex number s such that  $s=\sigma+i\tau$ . Unless we explicitly mention otherwise, let's suppose that  $0<\sigma<1,\,\tau>0$  and  $L(s,\chi)=0$  where  $L(s,\chi)=\sum_{n=1}^{+\infty}\frac{\chi(n)}{n^s}$  and  $\chi$  is a non-trivial Dirichlet character  $\chi$  modulo q. When q=2 there is only one Dirichlet character and it is

trivial. So here we are going to assume that  $q \geq 3$ .

We have from the integral equation (3) above:

$$L(s,\chi) = s \int_{1}^{+\infty} \frac{\sum_{n=1}^{n \le x} \chi(n)}{x^{s+1}} dx$$
 (9)

We have from the Riemann's integral in [1]:

$$\zeta(s) = \frac{s}{s-1} - s \int_{1}^{+\infty} \frac{\{x\}}{x^{s+1}} dx \tag{10}$$

To continue, we will need to prove the following lemma where we leverage on the RH proof in [1] to proof GRH.

**Lemma 3.1.** Let's consider two variables  $\sigma$  and  $\tau$  such that  $\sigma > 0$ ,  $\tau > 0$  and  $s = \sigma + i\tau$ . Let's  $L(s,\chi)$  be a L-function where  $\chi$  is a character (not necessarily a Dirichlet character) such that:

$$L(s,\chi) = \frac{\lambda s}{s-1} - s \int_{1}^{+\infty} \frac{\left(\lambda \{x\} + f(x)\right)}{x^{s+1}} dx \tag{11}$$

With the function  $x \to f(x)$  is bounded and the complex constant  $\lambda \neq 0$ . If  $L(s,\chi) = 0$ , then:

$$\sigma = \frac{1}{2} \tag{12}$$

*Proof.* To prove this lemma, we will use the same method and notations as in the lemmas 1.2 and 1.4 in [1]. Let's denote the following functions:

$$\epsilon(x) = \{x\} \tag{13}$$

$$\phi(x) = \{x\} (1 - \{x\}) \tag{14}$$

$$F(x) = \int_{1}^{x} f(x)dx \tag{15}$$

$$\psi_0(x) = \phi(x) \tag{16}$$

$$\psi_{n+1}(x) = \frac{1}{x} \int_0^x \psi_n(t) \tag{17}$$

$$\tilde{\psi}_0(x) = \frac{\psi_0(x)}{x^{1-2\sigma}}$$
 (18)

$$\tilde{\psi}_{n+1}(x) = \frac{1}{x} \int_0^x \tilde{\psi}_n(t) \tag{19}$$

Since s is a  $L(s,\chi)$  zero, therefore we can write:

$$\frac{\lambda s}{s-1} - s \int_{1}^{+\infty} \frac{\left(\lambda \{x\} + f(x)\right)}{x^{s+1}} dx = 0 \tag{20}$$

Therefore, since  $s \neq 0$  and  $\lambda \neq 0$ , we have:

$$\int_{1}^{+\infty} \frac{\{x\}}{x^{s+1}} dx = \frac{1}{s-1} - \frac{1}{\lambda} \int_{1}^{+\infty} \frac{f(x)}{x^{s+1}} dx$$
 (21)

We use integration by parts to get:

$$\int_{1}^{+\infty} \frac{\phi(x)}{x^{2+s}} dx = \frac{1}{s(1-s)} + \frac{2}{\lambda} \int_{1}^{+\infty} \frac{F(x)}{x^{2+s}} dx$$
 (22)

We use the same technique used in lemma 1.2 lemma 1.4 in [1] to get the following results:

1. For each n:

$$\int_{1}^{+\infty} dx \frac{\psi_n(x)}{x^{2+s}} = \frac{1}{s \, 2^n} + \frac{1}{(1-s) \, 3^n} + \frac{2}{\lambda (s+2)^n} \int_{1}^{+\infty} \frac{F(x)}{x^{2+s}} dx \tag{23}$$

2. For each n:

$$\frac{1}{(n-1)!} \int_{1}^{+\infty} dx \frac{\int_{1}^{x} dt \, \psi_{0}(t) \left(\ln\left(\frac{x}{t}\right)\right)^{n-1}}{x^{3+s}} = \frac{1}{s(1-s)(2+s)^{n}} - \frac{2}{\lambda(s+2)^{n}} \int_{1}^{+\infty} \frac{F(x)}{x^{2+s}} dx \tag{24}$$

3. For each n:

$$\int_{1}^{+\infty} dx \frac{\tilde{\psi}_{n}(x)}{x^{2+s}} = \frac{1}{(1-\overline{s})(1+2\sigma)^{n}} + \frac{1}{\overline{s}(2+2\sigma)^{n}} + \frac{2}{\lambda(s+2)^{n}} \int_{1}^{+\infty} \frac{F(x)}{x^{3-\overline{s}}} dx \tag{25}$$

4. For each n

$$\frac{1}{(n-1)!} \int_{1}^{+\infty} dx \frac{\int_{1}^{x} dt \, \tilde{\psi}_{0}(t) \left(\ln\left(\frac{x}{t}\right)\right)^{n-1}}{x^{3+s}} = \frac{1}{\overline{s}(1-\overline{s})(2+s)^{n}} - \frac{2}{\lambda(s+2)^{n}} \int_{1}^{+\infty} \frac{F(x)}{x^{3-\overline{s}}} dx \tag{26}$$

Where  $\overline{s}$  is the complex conjugate of s.

5. For each n:

$$\int_{1}^{+\infty} \frac{\cos(\tau \ln(x)) \int_{1}^{x} dt \, \tilde{\psi}_{0}(t) \left(\ln(\frac{x}{t})\right)^{n-1}}{x^{3+\sigma}} = \frac{1}{c_{n}^{1-2\sigma}} \int_{1}^{+\infty} \frac{2\cos^{2}(\frac{\tau}{2} \ln(x)) \int_{1}^{x} dt \, \psi_{0}(t) \left(\ln(\frac{x}{t})\right)^{n-1}}{x^{3+\sigma}}$$
(27)

$$-\frac{1}{c^{1-2\sigma}} \int_{1}^{+\infty} dx \frac{\int_{1}^{x} dt \, \psi_{0}(t) \left(\ln\left(\frac{x}{t}\right)\right)^{n-1}}{x^{3+\sigma}}$$
 (28)

Where  $c_n > 1$  and c > 1 are real numbers.

Let's write the following:

$$\frac{1}{s(1-s)} = \frac{e^{-i\alpha}}{\|s(1-s)\|} \tag{29}$$

$$\frac{1}{2+s} = \frac{e^{-i\beta}}{\|2+s\|} \tag{30}$$

$$\frac{2}{\lambda} \int_{1}^{+\infty} \frac{F(x)}{x^{2+s}} dx = \left\| \frac{2}{\lambda} \int_{1}^{+\infty} \frac{F(x)}{x^{2+s}} dx \right\| e^{i\gamma_I} = \lambda_1 e^{i\gamma_I}$$
 (31)

$$\frac{2}{\lambda} \int_{1}^{+\infty} \frac{F(x)}{x^{3-\overline{s}}} dx = \left\| \frac{2}{\lambda} \int_{1}^{+\infty} \frac{F(x)}{x^{3-\overline{s}}} dx \right\| e^{i\gamma_2} = \lambda_2 e^{i\gamma_2}$$
(32)

Where  $\alpha \in (0, \pi)$  and  $\beta \in (0, \pi)$ . Without loss of generality, we can assume  $\alpha$  and  $\beta$  are in  $(0, \frac{\pi}{2})$  since  $0 < \sigma < \frac{1}{2}$  and  $\tau > 0$ .

Therefore, we can write:

$$\frac{1}{(2+s)^n} = \frac{e^{-i\beta n}}{\|2+s\|^n} \tag{33}$$

Therefore, when we combine the equations (23-28) and get the following:

$$X_n = \frac{1}{(n-1)!} \int_1^{+\infty} dx \frac{2\cos^2(\frac{\tau}{2}\ln(x)) \int_1^x dt \, \psi_0(t) \left(\ln(\frac{x}{t})\right)^{n-1}}{x^{3+\sigma}}$$
(34)

$$= \frac{1}{\|s(1-s)\| \|2+s\|^n} \frac{\cos(\alpha-\beta n) - \frac{\cos(\alpha+\beta n)}{c^{1-2\sigma}} - \|s(1-1)\| \left(\lambda_2 \cos(\gamma_2-\beta n) - \frac{\lambda_1 \cos(\gamma_1-\beta n)}{c^{1-2\sigma}}\right)}{\frac{1}{c_n^{1-2\sigma}} - \frac{1}{c^{1-2\sigma}}}$$
(35)

And

$$Y_n = \frac{1}{(n-1)!} \int_1^{+\infty} dx \frac{\int_1^x dt \, \psi_0(t) \left(\ln(\frac{x}{t})\right)^{n-1}}{x^{3+\sigma}}$$
(36)

$$= \frac{1}{\|s(1-s)\| \|2+s\|^n} \frac{\cos(\alpha-\beta n) - \frac{\cos(\alpha+\beta n)}{c_n^{1-2\sigma}} - \|s(1-1)\| \left(\lambda_2 \cos(\gamma_2-\beta n) - \frac{\lambda_1 \cos(\gamma_1-\beta n)}{c_n^{1-2\sigma}}\right)}{\frac{1}{c_n^{1-2\sigma}} - \frac{1}{c^{1-2\sigma}}}$$
(37)

We can also calculate  $X_n$  and  $Y_n$  in another way as follows:

$$X_n = \frac{U_0}{(2+\sigma)^n} + \frac{\cos(\alpha+\beta n)}{\|s(1-s)\| \|2+s\|^n} - \frac{\lambda_1 \cos(\gamma_1-\beta n)}{\|2+s\|^n}$$
(38)

And

$$Y_n = \frac{U_0}{(2+\sigma)^n} \tag{39}$$

Where

$$U_0 = \int_1^{+\infty} dt \frac{\psi_0(t)}{t^{2+\sigma}} \tag{40}$$

We have from the equations (34-37):

$$\frac{X_n}{Y_n} = 1 + \frac{(2+\sigma)^n \cos(\alpha+\beta n)}{U_0 \|s(1-s)\| \|2+s\|^n} - \frac{\lambda_1 \cos(\gamma_1-\beta n)(2+\sigma)^n}{U_0 \|2+s\|^n}$$

$$= \frac{\cos(\alpha-\beta n) - \frac{\cos(\alpha+\beta n)}{c^{1-2\sigma}} - \|s(1-1)\| \left(\lambda_2 \cos(\gamma_2-\beta n) - \frac{\lambda_1 \cos(\gamma_1-\beta n)}{c^{1-2\sigma}}\right)}{\cos(\alpha-\beta n) - \frac{\cos(\alpha+\beta n)}{c_n^{1-2\sigma}} - \|s(1-1)\| \left(\lambda_2 \cos(\gamma_2-\beta n) - \frac{\lambda_1 \cos(\gamma_1-\beta n)}{c_n^{1-2\sigma}}\right)}$$
(42)

$$= \frac{A\cos(\beta n) + B\sin(\beta n)}{A_n\cos(\beta n) + B_n\sin(\beta n)}$$
(43)

Where

$$A_n = \cos(\alpha) \left( 1 - \frac{1}{c_n^{1-2\sigma}} \right) - \|s(1-s)\| \left( \lambda_2 \cos(\gamma_2) - \frac{\lambda_1 \cos(\gamma_1)}{c_n^{1-2\sigma}} \right)$$
(44)

$$B_n = \sin(\alpha) \left( 1 + \frac{1}{c_n^{1-2\sigma}} \right) - \|s(1-s)\| \left( \lambda_2 \sin(\gamma_2) - \frac{\lambda_1 \sin(\gamma_1)}{c_n^{1-2\sigma}} \right)$$
(45)

Where the sequences  $(A_n)$  and  $(B_n)$  converge respectively to A and B defined as follows:

$$A = \cos(\alpha) \left( 1 - \frac{1}{c^{1 - 2\sigma}} \right) - \|s(1 - s)\| \left( \lambda_2 \cos(\gamma_2) - \frac{\lambda_1 \cos(\gamma_1)}{c^{1 - 2\sigma}} \right)$$
 (46)

$$B = \sin(\alpha) \left( 1 + \frac{1}{c^{1-2\sigma}} \right) - \|s(1-s)\| \left( \lambda_2 \sin(\gamma_2) - \frac{\lambda_1 \sin(\gamma_1)}{c^{1-2\sigma}} \right)$$
(47)

The sequence  $(\frac{1}{c_n})_{n\geq 1}$  is bounded. From the equations (35) and (38), we deduce that the limit of  $(\frac{1}{c_n})_{n\geq 1}$  is  $\frac{1}{c} < 1$ . We will distinguish between two cases.

1. Case 1: There exists  $n_0 \in \mathbb{N}$  such that for each  $n \geq n_0$ :  $c_n = c$ . Therefore, from the equation (35), we can deduce that for  $n \geq n_0$ :

$$A\cos(\beta n) + B\sin(\beta n) = 0 \tag{48}$$

Therefore

$$A = B = 0 \tag{49}$$

Therefore

$$\cos(\alpha)\left(1 - \frac{1}{c^{1-2\sigma}}\right) = \|s(1-s)\| \left(\lambda_2\cos(\gamma_2) - \frac{\lambda_1\cos(\gamma_1)}{c^{1-2\sigma}}\right)$$
(50)

$$\sin(\alpha)\left(1 + \frac{1}{c^{1-2\sigma}}\right) = \|s(1-s)\| \left(\lambda_2 \sin(\gamma_2) - \frac{\lambda_1 \sin(\gamma_1)}{c^{1-2\sigma}}\right)$$
(51)

From the equations (41) and (43) we can write:

$$\cos(\alpha + \beta n) = \lambda_1 \|s(1-s)\| \cos(\gamma_1 - \beta n)$$
 (52)

Therefore

$$\cos(\alpha) = \lambda_1 \|s(1-s)\| \cos(\gamma_1) \tag{53}$$

$$\sin(\alpha) = -\lambda_1 \|s(1-s)\| \sin(\gamma_1) \tag{54}$$

Therefore

$$\cos^{2}(\alpha) + \sin^{2}(\alpha) = \lambda_{1}^{2} \|s(1-s)\|^{2} \cos^{2}(\gamma_{1}) + \lambda_{1}^{2} \|s(1-s)\|^{2} \sin^{2}(\gamma_{1}) = 1$$
 (55)

Therefore

$$\lambda_1 = \frac{1}{\|s(1-s)\|} \tag{56}$$

Therefore by taking into account the equations (50-51)

$$\cos(\alpha) = \lambda_2 \|s(1-s)\| \cos(\gamma_2) \tag{57}$$

$$\sin(\alpha) = \lambda_2 \|s(1-s)\| \sin(\gamma_2) \tag{58}$$

And the same

$$\lambda_2 = \frac{1}{\|s(1-s)\|} \tag{59}$$

Therefore

$$\cos(\alpha) = \cos(\gamma_1) = \cos(\gamma_2) \tag{60}$$

$$\sin(\alpha) = -\sin(\gamma_1) = \sin(\gamma_2) \tag{61}$$

Therefore

$$\gamma_1 = (k + k\prime)\pi\tag{62}$$

$$\gamma_2 = (k - k\prime)\pi\tag{63}$$

Where  $k, k' \in \mathbb{Z}$ . Therefore

$$\sin(\alpha) = 0 \tag{64}$$

Which is a contradiction since  $\alpha \in (0, \frac{\pi}{2})$ .

2. Case 2: For each  $n_0 \in \mathbb{N}$  there exists  $n \geq n_0$ :  $c_n \neq c$ . We have from the equations (41-43):

$$\frac{X_n}{Y_n} = \frac{A\cos(\beta n) + B\sin(\beta n)}{A_n\cos(\beta n) + B_n\sin(\beta n)}$$
(65)

The case where A=B=0 is similar to the previous case and it is not possible since  $X_n>0$ . So, let assume that  $AB\neq 0$ . And since the sequence  $(c_n)$  terms and c are different, therefore the sequence  $(A_n)$  terms are different from A and the sequence  $(B_n)$  terms are different from B, similarly like in the lemma 1.4 in [1], we can find  $n_0$  such that  $A_{n_0}\cos(\beta n_0)+B_{n_0}\sin(\beta n_0)>0$  and  $A\cos(\beta n_0)+B\sin(\beta n_0)<0$  or  $A_{n_0}\cos(\beta n_0)+B_{n_0}\sin(\beta n_0)<0$  and  $A\cos(\beta n_0)+B\sin(\beta n_0)>0$ . Therefore, in such case, we will have  $\frac{X_{n_0}}{Y_{n_0}}<0$ . Which means either  $X_{n_0}<0$  or  $Y_{n_0}<0$ . Which is a contradiction.

We can also prove it in an another way: from the equations (41-43), we deduce that the sequence  $(\frac{X_n}{Y_n})$  converges to 1. And therefore the sequence  $(\frac{A\cos(\beta n)+B\sin(\beta n)}{A_n\cos(\beta n)+B_n\sin(\beta n)})$  converges to 1. But  $AB\neq 0$ , so, the sequence  $(\frac{A\cos(\beta n)+B\sin(\beta n)}{A_n\cos(\beta n)+B_n\sin(\beta n)})$  cannot converge. Hence the contradiction. Therefore we must have A=B=0. And therefore  $\sin(\alpha)$  be zero.

Therefore

$$\sigma = \frac{1}{2} \tag{66}$$

In the case of  $\sigma > \frac{1}{2}$ . We work with 1-s that is also another zero and here we have  $1-\sigma < \frac{1}{2}$ . And we will reach to the same contradiction. Therefore,  $\sigma$  can only be  $\frac{1}{2}$ . This ends the proof of our lemma.

From the lemma above we can conclude the following corollary.

**Corollary 3.1.1.** Let's consider two variables  $\sigma$  and  $\tau$  such that  $\sigma > 0$ ,  $\tau > 0$  and  $s = \sigma + i\tau$ . Let's q > 1 be an positive integer. Let's  $L(s,\chi)$  be a L-function where  $\chi$  is a Dirichlet character mod q with no cancellation property such that:

$$\sum_{n=1}^{q} \chi(n) \neq 0 \tag{67}$$

If  $L(s,\chi) = 0$ , then:

$$\sigma = \frac{1}{2} \tag{68}$$

*Proof.* Let's take x > 1 a real number. Let's denote  $n_x = \lfloor x \rfloor$  be the integer part of x. We have  $n_x = x - \{x\}$ . We denote  $q_x$  and  $r_x$  the quotient and the rest of the Euclidean division of  $n_x$  by q as follows:  $n_x = qq_x + r_x$ . Therefore we can write:

$$\sum_{n=1}^{x} \chi(n) = \sum_{n=0}^{q_x - 1} \sum_{k=1}^{q} \chi(nq + k) + \sum_{k=1}^{r_x} \chi(nq + k)$$
 (69)

$$= q_x \sum_{n=1}^{q} \chi(n) + \sum_{k=1}^{r_x} \chi(k)$$
 (70)

$$= \frac{x - \{x\} - r_x}{q} \sum_{k=1}^{q} \chi(n) + \sum_{k=1}^{r_x} \chi(k)$$
 (71)

$$= \frac{x}{q} \sum_{k=1}^{q} \chi(n) - \frac{\left(\{x\} + r_x\right)}{q} \sum_{k=1}^{q} \chi(n) + \sum_{k=1}^{r_x} \chi(k)$$
 (72)

Let's define the constant  $\lambda$  and the function g as follows:

$$\lambda = \frac{\sum_{k=1}^{q} \chi(n)}{q} \tag{73}$$

$$g(x) = \frac{(\{x\} + r_x)}{q} \sum_{k=1}^{q} \chi(n) - \sum_{k=1}^{r_x} \chi(k)$$
 (74)

$$= \lambda\{x\} + \underbrace{\lambda r_x - \sum_{k=1}^{r_x} \chi(k)}_{f(x)}$$

$$\tag{75}$$

It is clear that the function f(x) is bounded. And by assumption we have  $\lambda \neq 0$ . Therefore, we can calculate  $L(s,\chi)$  as follows:

$$L(s,\chi) = s \int_{1}^{+\infty} \frac{\sum_{n=1}^{n \le x} \chi(n)}{x^{s+1}} dx$$
 (76)

$$= s \int_{1}^{+\infty} \frac{\lambda x - g(x)}{x^{s+1}} dx \tag{77}$$

$$= s \int_{1}^{+\infty} \frac{\lambda}{x^{s}} dx - s \int_{1}^{+\infty} \frac{\lambda\{x\} + f(x)}{x^{s+1}} dx \tag{78}$$

(79)

If  $\Re(s) > 1$ , we can conclude:

$$L(s,\chi) = \frac{\lambda s}{s-1} - s \int_{1}^{+\infty} \frac{\lambda \{x\} + f(x)}{x^{s+1}} dx \tag{80}$$

We can extend the equation (80) over the region  $\Re(s) > 0$ .  $L(s, \chi)$  has a holomorphic continuation as a function of s to the whole complex plane (see [3, 6, 7, 8]). Therefore, we apply the lemma 3.1 to prove that  $\sigma = \frac{1}{2}$ .

**Remark.** As a direct result of the above corollary, we can see that GRH is true for the series  $(\sum_{n\geq 1} \frac{1}{(qn+p)^s})$  with p>0 and q>1 are integers.

**Lemma 3.2.** Let's consider two variables  $\sigma$  and  $\tau$  such that  $\sigma > 0$ ,  $\tau > 0$  and  $s = \sigma + i\tau$ . Let's q > 1 be an positive integer. Let's  $L(s,\chi)$  be a L-function where  $\chi$  is a Dirichlet character mod q with cancellation property such that:

$$\sum_{n=1}^{q} \chi(n) = 0 \tag{81}$$

Therefore:

$$L(s,\chi) = \left(\frac{1-q^{1-s}}{q}\right) \frac{s}{s-1} - s \int_{1}^{+\infty} \frac{\left(\frac{1-q^{1-s}}{q}\right)\{x\} + f(x)}{x^{s+1}} dx$$
 (82)

Where f is a bounded function.

*Proof.* We will use the zeta function  $\zeta(s)$  to prove our case. Let's now write the following for s > 1:

$$\zeta(s) = \sum_{n=1}^{+\infty} \frac{1}{n^s} \tag{83}$$

$$= \sum_{n=0}^{\infty} \sum_{i=1}^{q} \frac{1}{(qn+i)^s}$$
 (84)

$$= \sum_{i=1}^{q} \sum_{n=0}^{\infty} \frac{1}{(qn+i)^s}$$
 (85)

Therefore

$$\left(1 - \frac{1}{q^s}\right)\zeta(s) = \sum_{i=1}^{q-1} \sum_{n=0}^{\infty} \frac{1}{(qn+i)^s}$$
(86)

Also

$$L(s,\chi) = \sum_{n=1}^{+\infty} \frac{\chi(n)}{n^s}$$
 (87)

$$= \sum_{n=0}^{+\infty} \sum_{i=1}^{q} \frac{\chi(i)}{(qn+i)^s}$$
 (88)

$$= \sum_{i=1}^{q} \chi(i) \sum_{n=0}^{+\infty} \frac{1}{(qn+i)^s}$$
 (89)

Therefore since  $\chi(q) = 0$ 

$$L(s,\chi) = \sum_{i=1}^{q-1} \chi(i) \sum_{n=0}^{+\infty} \frac{1}{(qn+i)^s}$$
 (90)

Since  $\sum_{n=1}^{q} \chi(n) = 0$  and  $\chi(1) = 1$ , we can write the following:

$$\sum_{n=0}^{+\infty} \frac{1}{(qn+1)^s} = L(s,\chi) - \sum_{i=2}^{q-1} \chi(i) \sum_{n=0}^{+\infty} \frac{1}{(qn+i)^s}$$
 (91)

$$\sum_{n=0}^{+\infty} \frac{1}{(qn+1)^s} = \left(1 - \frac{1}{q^s}\right)\zeta(s) - \sum_{i=2}^{q-1} \sum_{n=0}^{+\infty} \frac{1}{(qn+i)^s}$$
 (92)

Therefore

$$\left(1 - \frac{1}{q^s}\right)\zeta(s) - L(s,\chi) = \sum_{i=2}^{q-1} \left(1 - \chi(i)\right) \sum_{n=0}^{+\infty} \frac{1}{(qn+i)^s}$$
(93)

Let's denote  $L(s,i)_{2 \le i \le q-1}$  as follows:

$$L(s,i) = \sum_{n=0}^{+\infty} \frac{1}{(qn+i)^s}$$
 (94)

We can write also:

$$L(s,i) = s \int_{1}^{+\infty} \frac{\sum_{n=1}^{n \le x} \chi_i(n)}{x^{s+1}} dx$$
 (95)

Where  $\chi_i$  is the character of L(s, i):

- (i)  $\chi_i(qn+i) = 1$
- (ii)  $\chi_i(qn+j) = 0$  if  $j \neq i$

We use the equation (90-94) to write:

$$\lambda_i = \frac{\sum_{k=1}^q \chi_i(n)}{q} = \frac{1}{q} \tag{96}$$

$$f_i(x) = \frac{(\{x\} + r_x)}{q} \sum_{k=1}^q \chi_i(n) - \sum_{k=1}^{r_x} \chi_i(k)$$
 (97)

$$= \frac{(\{x\} + r_x)}{q} - \sum_{k=1}^{r_x} \chi_i(k)$$
 (98)

Therefore from the equation (96)

$$L(s,i) = \frac{s}{q(s-1)} - s \int_{1}^{+\infty} \frac{f_i(x)}{x^{s+1}} dx$$
 (99)

Therefore, we can write the equation (94) as follows:

$$\left(1 - \frac{1}{q^s}\right)\zeta(s) - L(s,\chi) = \sum_{i=2}^{q-1} \left(1 - \chi(i)\right)L(s,i) \tag{100}$$

$$= \frac{s}{q(s-1)} \sum_{i=2}^{q-1} (1 - \chi(i)) - s \sum_{i=2}^{q-1} (1 - \chi(i)) \int_{1}^{+\infty} \frac{f_i(x)}{x^{s+1}} dx \quad (101)$$

Thanks to the cancellation property, we can conclude that:

$$\left(1 - \frac{1}{q^s}\right)\zeta(s) - L(s,\chi) = \frac{s(q-1)}{q(s-1)} - s \int_1^{+\infty} \frac{\sum_{i=2}^{q-1} \left(1 - \chi(i)\right)f_i(x)}{x^{s+1}} dx \quad (102)$$

From the equation (10) we replace the  $\zeta(s)$  by its L- function:

$$L(s,\chi) = \frac{1-q^{1-s}}{q} \frac{s}{(s-1)} - s \int_{1}^{+\infty} \frac{(1-q^{-s})\{x\} - \sum_{i=2}^{q-1} (1-\chi(i)) f_i(x)}{x^{s+1}} dx \quad (103)$$

Let's define the function g(x) as follows:

$$g(x) = (1 - q^{-s})\{x\} - \sum_{i=2}^{q-1} (1 - \chi(i)) f_i(x)$$
(104)

$$= \frac{1 - q^{1-s}}{q} \{x\} - \left(1 - \frac{1}{q}\right) r_x + \sum_{i=2}^{q-1} \left(1 - \chi(i)\right) \sum_{k=1}^{r_x} \chi_i(k)$$
 (105)

$$= \frac{1 - q^{1-s}}{q} \{x\} + f(x) \tag{106}$$

Where f is unrelated to s, bounded and defined as follows:

$$f(x) = -\left(1 - \frac{1}{q}\right)r_x + \sum_{i=2}^{q-1} \left(1 - \chi(i)\right) \sum_{k=1}^{r_x} \chi_i(k)$$
 (107)

$$= \frac{r_x}{q} - \sum_{k=1}^{r_x} \chi(k) \tag{108}$$

And

$$L(s,\chi) = \left(\frac{1-q^{1-s}}{q}\right)\frac{s}{s-1} - s\int_{1}^{+\infty} \frac{\left(\frac{1-q^{1-s}}{q}\right)\{x\} + f(x)}{x^{s+1}} dx \quad (109)$$

**Lemma 3.3.** Let's consider two variables  $\sigma$  and  $\tau$  such that  $0 < \sigma < 1$ ,  $\tau > 0$  and  $s = \sigma + i\tau$ . Let's q > 1 be an positive integer. Let's  $L(s,\chi)$  be a L-function where  $\chi$  is a Dirichlet character mod q with cancellation property such that:

$$\sum_{n=1}^{q} \chi(n) = 0 {(110)}$$

Let's suppose that  $s=\sigma+i\tau$  is a zero for  $L(s,\chi)$ . i.e  $L(s,\chi)=0$ . Therefore

$$\sigma = \frac{1}{2} \tag{111}$$

And the Generalized Riemann's Hypothesis is true.

*Proof.* The proof is straightforward as we can use the lemmas 3.1 and 3.2. From lemma 3.2 we can write the following:

$$L(s,\chi) = \frac{\lambda s}{s-1} - s \int_{1}^{+\infty} \frac{\lambda \{x\} + f(x)}{x^{s+1}} dx$$
 (112)

$$\lambda = \frac{1 - q^{1-s}}{q} \tag{113}$$

Where f is a bounded function. Then, we apply the lemma 3.1 to conclude that

$$\sigma = \frac{1}{2} \tag{114}$$

And the Generalized Riemann's Hypothesis is true.

### 3.1 Conclusion

We saw that if s is a zeta zero, then real part  $\Re(s)$  can only be  $\frac{1}{2}$ . Therefore, the Generalized Riemann Hypothesis (GRH) is true: The non-trivial zeros of a L-Dirichlet function have real part equal to  $\frac{1}{2}$ . With this, we conclude that P=NP.
