# A Simple Proof of the Generalized Riemann's Hypothesis

#### Abstract

This article is the continuation of the previous RH proof[1]. We present a simple proof of the Generalized Riemann's Hypothesis (GRH) where we apply the same method we used to prove the RH.

Keywords: Riemann Hypothesis; Zeta function; Prime Numbers; Millennium Problems.

### **1** Dirichlet *L*-functions

Let's  $(z_n)_{n\geq 1}$  be a sequence of complex numbers. A Dirichlet series[3] is a series of the form  $\sum_{n=1}^{\infty} \frac{z_n}{n^s}$ , where  $s = \sigma + i\tau$  is complex. The zeta function is a Dirichlet series. Let's define the function L(s) of the complex s:  $L(s) = \sum_{n=1}^{\infty} \frac{z_n}{n^s}$ .

- If (z<sub>n</sub>)<sub>n≥1</sub> is a bounded, then the corresponding Dirichlet series converges absolutely on the open half-plane where ℜ(s) > 1.
- If the set of sums  $z_n + z_{n+1} + ... + z_{n+k}$  for each n and  $k \ge 0$  is bounded, then the corresponding Dirichlet series converges on the open half-plane where  $\Re(s) > 0$ .
- In general, if  $z_n = O(n^k)$ , the corresponding Dirichlet series converges absolutely in the half plane where  $\Re(s) > k + 1$ .

The function L(s) is analytic on the corresponding open half plane[2-3]. To define Dirichlet L-functions we need to define Dirichlet characters.

A function  $\chi : \mathbb{Z} \longrightarrow \mathbb{C}$  is a Dirichlet character modulo q if it satisfies the following criteria:

- (i)  $\chi(n) \neq 0$  if (n,q) = 1.
- (ii)  $\chi(n) = 0$  if (n,q) > 1.
- (iii)  $\chi$  is periodic with period  $q: \chi(n+q) = \chi(n)$  for all n.
- (iv)  $\chi$  is multiplicative : $\chi(mn) = \chi(m)\chi(n)$  for all integers m and n.

The trivial character is the one with  $\chi_0(n) = 1$  whenever (n, q) = 1.

Here are some known results for a Dirichlet character modulo q. For any integer n we have  $\chi(1) = 1$ . Also if (n,q) = 1, we have  $(\chi(n))^{\phi(q)} =$ 1 with  $\phi$  is Euler's totient function.  $\chi(n)$  is a  $\phi(q)$ -th root of unity. Therefore,  $|\chi(n)| = 1$  if (n,q) = 1, and  $|\chi(n)| = 0$  if (n,q) > 1. Also, we recall the cancellation property for Dirichlet characters modulo q: For any n integer

$$\sum_{i=1}^{q} \chi(i+n) = \begin{cases} \phi(q), & \text{if } \chi = \chi_0 \text{ the trivial character} \\ 0, & \text{if otherwise, } \chi \neq \chi_0 \end{cases}$$
(1)

The Dirichlet *L*-functions are simply the sum of the Dirichlet series. Let's  $\chi$  be a Dirichlet character modulo q, The Dirichlet *L*-function  $L(s, \chi)$  is defined for  $\Re(s) > 1$  as the following:

$$L(s,\chi) = \sum_{n=1}^{+\infty} \frac{\chi(n)}{n^s}$$
<sup>(2)</sup>

They are a natural generalization of the Riemann zeta-function  $\zeta(s)$  to an arithmetic progression and are a powerful tool in analytic number theory. The Dirichlet series, converges absolutely and uniformly in any bounded domain in the complex s-plane for which  $\Re(s) \ge 1 + \gamma, \gamma > 0$ . In the particular case of the trivial character  $\chi_0$ ,  $L(s, \chi_0)$  extends to a meromorphic function[2-5] in  $\Re(s) > 0$  with the only pole at s = 1.

If  $\chi$  is a non-trivial character, we have

$$L(s,\chi) = s \int_{1}^{+\infty} \frac{\sum_{n=1}^{n \le x} \chi(n)}{x^{s+1}} dx$$
(3)

Since the sum in the integrand is bounded, this formula gives an analytic continuation of  $L(s, \chi)$  to a regular function in the half-plane  $\Re(s) > 0$ . Also, like the zeta function, the Dirichlet L-functions have their Euler product[1-2]. For  $\Re(s) > 1$ :

$$L(s,\chi) = \prod_{p \text{ Prime}} \left(1 - \frac{\chi(p)}{p^s}\right)^{-1} \tag{4}$$

Therefore, if  $\chi = \chi_0$  is a trivial character mod q, we have, for q = 1,

$$L(s,\chi_0) = \zeta(s) \tag{5}$$

And for q > 1, we have,

$$L(s,\chi_0) = \zeta(s) \prod_{p/q} \left( 1 - \frac{1}{p^s} \right)$$
(6)

For this reason the properties of  $L(s, \chi_0)$  in the entire complex plane are determined by the properties of  $\zeta(s)$ .

Let's now q' be the smallest divisor (prime) of q. Let's  $\chi'$  be the Dirichlet character  $\chi' \mod q'$ . For any integer n such that (n,q) = 1, we have also (n,q') = 1 and  $\chi(n) = \chi'(n)$ .  $\chi'$  is called primitive and  $L(s,\chi)$  and  $L(s,\chi')$  are related analytically such that if  $\chi \neq \chi_0$ :

$$L(s,\chi) = L(s,\chi') \prod_{p/q} \left( 1 - \frac{\chi'(p)}{p^s} \right)$$
(7)

 $L(s,\chi)$  and  $L(s,\chi')$  have the same zeros in the critical strip  $0 < \Re(s) < 1$ .

Also, for a primitive character  $\chi$ ,  $(i.e.\chi = \chi \prime) L(s,\chi)$  has the following functional equation:

$$\tau(\chi)\Gamma(\frac{1-s+a}{2})L(1-s,\chi) = \sqrt{\pi}(\frac{q}{\pi})^s i^a q^{\frac{1}{2}} \Gamma(\frac{s+a}{2})L(s,\overline{\chi})$$
(8)

Where  $\Gamma$  is the Gamma function and a = 0 if  $\chi(-1) = 1$  and a = 1 if  $\chi(-1) = -1$ , and  $\tau(\chi) = \sum_{k=1}^{q} \chi(k) \exp(\frac{2\pi k i}{q})$ . When  $\Re(s) > 1$  there is no zero for  $L(s,\chi)$ . When  $\Re(s) < 0$ , for a

When  $\Re(s) > 1$  there is no zero for  $L(s, \chi)$ . When  $\Re(s) < 0$ , for a primitive character  $\chi$ , we have the trivial zeros of  $L(s, \chi)$ : s = a - 2k, where k is a positive integer and a is defined above. For more details, please refer to the references[1-8].

## 2 The Generalized Riemann Hypothesis

The Generalized Riemann Hypothesis states that the Dirichlet L-functions have all their non-trivial zeros on the critical line  $\Re(s) = \frac{1}{2}$ .

We know that for any character  $\chi$  modulo q, all non-trivial zeros of  $L(s,\chi)$  lies in the critical strip  $\{s \in \mathbb{C} : 0 < \Re(s) < 1\}$ . From the functional equation above we have that if:

- $s_0$  is a non-trivial zero of  $L(s, \chi)$ , then  $1 s_0$  is a zero of  $L(s, \overline{\chi})$ .
- $s_0$  is a non-trivial zero of  $L(s, \overline{\chi})$ , then  $1 s_0$  is a zero of  $L(s, \chi)$ .

Therefore, we just need to prove that for any character<sup>1</sup>  $\chi$  modulo q, there is no non-trivial zeros of  $L(s, \chi)$  in the right hand side of the critical strip  $\{s \in \mathbb{C} : \frac{1}{2} < \Re(s) < 1\}.$ 

# 3 Proof of the Generalized Riemann Hypothesis

Let's take a complex number s such that  $s = \sigma + i\tau$ . Unless we explicitly mention otherwise, let's suppose that  $0 < \sigma < 1$ ,  $\tau > 0$  and  $L(s, \chi) = 0$ where  $L(s, \chi) = \sum_{n=1}^{+\infty} \frac{\chi(n)}{n^s}$  and  $\chi$  is a non-trivial Dirichlet character  $\chi$ modulo q. When q = 2 there is only one Dirichlet character and it is

trivial. So here we are going to assume that  $q \geq 3$ .

We have from the integral equation (3) above:

$$L(s,\chi) = s \int_{1}^{+\infty} \frac{\sum_{n=1}^{n \le x} \chi(n)}{x^{s+1}} dx$$
(9)

We have from the Riemann's integral in [1]:

$$\zeta(s) = \frac{s}{s-1} - s \int_{1}^{+\infty} \frac{\{x\}}{x^{s+1}} dx \tag{10}$$

To continue, we will need to prove the following lemma where we leverage on the RH proof in [1] to proof GRH.

**Lemma 3.1.** Let's consider two variables  $\sigma$  and  $\tau$  such that  $\sigma > 0$ ,  $\tau > 0$ and  $s = \sigma + i\tau$ . Let's  $L(s, \chi)$  be a L-function where  $\chi$  is a character (not necessarily a Dirichlet character) such that:

$$L(s,\chi) = \frac{\lambda s}{s-1} - s \int_{1}^{+\infty} \frac{(\lambda\{x\} + f(x))}{x^{s+1}} dx$$
(11)

With the function  $x \to f(x)$  is bounded and the complex constant  $\lambda \neq 0$ . If  $L(s, \chi) = 0$ , then:

$$\sigma = \frac{1}{2} \tag{12}$$

*Proof.* To prove this lemma, we will use the same method and notations as in the lemmas 1.2 and 1.3 in [1]. Let's denote the following functions:

$$\epsilon(x) = \{x\} \tag{13}$$

$$\phi(x) = \{x\} (1 - \{x\}) \tag{14}$$

$$F(x) = \int_{1}^{x} f(x)dx \tag{15}$$

$$\psi_0(x) = \phi(x) \tag{16}$$

$$\psi_{n+1}(x) = \frac{1}{x} \int_{0}^{0} \psi_n(t)$$
 (17)

$$\tilde{\psi}_0(x) = \frac{\psi_0(x)}{x^{1-2\sigma}} \tag{18}$$

$$\tilde{\psi}_{n+1}(x) = \frac{1}{x} \int_0^x \tilde{\psi}_n(t)$$
(19)

Since s is a  $L(s,\chi)$  zero, therefore we can write:

$$\frac{\lambda s}{s-1} - s \int_{1}^{+\infty} \frac{\left(\lambda \{x\} + f(x)\right)}{x^{s+1}} dx = 0$$
 (20)

Therefore, since  $s \neq 0$  and  $\lambda \neq 0$ , we have:

$$\int_{1}^{+\infty} \frac{\{x\}}{x^{s+1}} dx = \frac{1}{s-1} - \frac{1}{\lambda} \int_{1}^{+\infty} \frac{f(x)}{x^{s+1}} dx \tag{21}$$

We use integration by parts to get:

$$\int_{1}^{+\infty} \frac{\phi(x)}{x^{2+s}} dx = \frac{1}{s(1-s)} + \frac{2}{\lambda} \int_{1}^{+\infty} \frac{F(x)}{x^{2+s}} dx$$
(22)

We use the same technique used in lemma 1.2 lemma 1.3 in [1] to get the following results:

1. For each n:

$$\int_{1}^{+\infty} dx \frac{\psi_n(x)}{x^{2+s}} = \frac{1}{s \, 2^n} + \frac{1}{(1-s) \, 3^n} + \frac{2}{\lambda(s+2)^n} \int_{1}^{+\infty} \frac{F(x)}{x^{2+s}} dx \tag{23}$$

2. For each n:

$$\int_{1}^{+\infty} dx \frac{\psi_n(x)}{x^{3-s}} = \frac{1}{(1-s)2^n} + \frac{1}{s3^n} + \frac{2}{\lambda(3-s)^n} \int_{1}^{+\infty} \frac{F(x)}{x^{3-s}} dx \qquad (24)$$

3. For each n:

$$\int_{1}^{+\infty} dx \frac{\tilde{\psi}_n(x)}{x^{2+s}} = \frac{1}{(1-\overline{s})(1+2\sigma)^n} + \frac{1}{\overline{s}(2+2\sigma)^n} + \frac{2}{\lambda(s+2)^n} \int_{1}^{+\infty} \frac{F(x)}{x^{3-\overline{s}}} dx$$
(25)

4. For each n:

$$\int_{1}^{+\infty} dx \frac{\tilde{\psi}_n(x)}{x^{3-s}} = \frac{1}{\overline{s} (1+2\sigma)^n} + \frac{1}{(1-\overline{s}) (2+2\sigma)^n} + \frac{2}{\lambda(3-s)^n} \int_{1}^{+\infty} \frac{F(x)}{x^{2+\overline{s}}} dx$$
(26)

Where  $\overline{s}$  is the complex conjugate of s.

5. For each n:

$$\int_{1}^{+\infty} dx \frac{2\cos^2(\frac{\tau}{2}\ln(x))\psi_n(x)}{x^{3-\sigma}} = \frac{1}{c_n^{1-2\sigma}} \int_{1}^{+\infty} dx \frac{2\cos^2(\frac{\tau}{2}\ln(x))\psi_n(x)}{x^{2+\sigma}}$$
(27)

Where  $c_n > 1$  is a real number.

6. For each n:

$$\int_{1}^{+\infty} dx \frac{2\cos^2(\frac{\tau}{2}\ln(x))\,\tilde{\psi}_n(x)}{x^{3-\sigma}} = \frac{1}{d_n^{1-2\sigma}} \int_{1}^{+\infty} dx \frac{2\cos^2(\frac{\tau}{2}\ln(x))\,\tilde{\psi}_n(x)}{x^{2+\sigma}}$$
(28)

Where  $d_n > 1$  is a real number.

And

$$\int_{1}^{+\infty} dx \frac{2\cos^{2}(\frac{\tau}{2}\ln(x))\psi_{n}(x)}{x^{3-\sigma}} = \int_{1}^{+\infty} dx \frac{\psi_{n}(x)\cos(\tau\ln(x))}{x^{3-\sigma}} + \int_{1}^{+\infty} dx \frac{\psi_{n}(x)}{x^{3-\sigma}}$$
(29)
$$= \frac{1}{2} \left( \int_{1}^{+\infty} dx \frac{\psi_{n}(x)}{x^{3-s}} + \int_{1}^{+\infty} dx \frac{\psi_{n}(x)}{x^{3-s}} \right) + \int_{1}^{+\infty} dx \frac{\psi_{n}(x)}{x^{3-\sigma}}$$
(30)

Since  $\overline{s}$  is a zero of  $L(s, \overline{\chi})$ , therefore we can use the equation(24) to write:

$$\int_{1}^{+\infty} dx \frac{2\cos^{2}(\frac{\tau}{2}\ln(x))\psi_{n}(x)}{x^{3-\sigma}} = \frac{1}{2} \left( \frac{1}{(1-s)2^{n}} + \frac{1}{s3^{n}} + \frac{1}{(1-\overline{s})2^{n}} + \frac{1}{\overline{s}3^{n}} + \frac{2}{\lambda(3-s)^{n}} \int_{1}^{+\infty} \frac{F(x)}{x^{3-s}} dx \right)$$
(31)

$$+ \frac{2}{\lambda(3-\overline{s})^{n}} \int_{1}^{+\infty} \frac{\overline{F}(x)}{x^{3-\overline{s}}} dx + \frac{1}{(1-\sigma)^{2n}} + \frac{1}{\sigma^{3n}} + \frac{1}{(3-\sigma)^{n}} \left[ U_{0}(1-\sigma) - \frac{1}{\sigma(1-\sigma)} \right] (32)$$

$$= - \frac{(1-\sigma)}{\sigma(1-\sigma)} + \frac{1}{\sigma^{3-\overline{s}}} + \frac{\sigma}{\sigma^{3-\overline{s}}} + \frac{1}{\sigma^{3-\overline{s}}} + \frac{1}{\sigma^{3$$

$$= \frac{(1-\sigma)}{\|1-s\|^2 2^n} + \frac{1}{(1-\sigma)2^n} + \frac{\sigma}{\|s\|^2 3^n} + \frac{1}{\sigma 3^n}$$
(33)

+ 
$$\frac{A_n(1-s)}{\|3-s\|^n} + \frac{1}{(3-\sigma)^n} \left[ U_0(1-\sigma) - \frac{1}{\sigma(1-\sigma)} \right]$$
 (34)

Where  $U_0(1-\sigma)$  is defined as follows:

$$U_{0}(1-\sigma) = \int_{1}^{+\infty} dt \, \frac{\psi_{0}(t)}{t^{3-\sigma}}$$

$$\frac{A_{n}(1-s)}{\|3-s\|^{n}} = \frac{2}{\lambda(3-s)^{n}} \int_{1}^{+\infty} \frac{F(x)}{x^{3-s}} dx + \frac{2}{\lambda(3-\overline{s})^{n}} \int_{1}^{+\infty} \frac{\overline{F}(x)}{x^{3-\overline{s}}} dx$$
(36)

And the same

$$\int_{1}^{+\infty} dx \frac{2\cos^{2}(\frac{\tau}{2}\ln(x))\psi_{n}(x)}{x^{2+\sigma}} = \int_{1}^{+\infty} dx \frac{\psi_{n}(x)\cos(\tau\ln(x))}{x^{2+\sigma}} + \int_{1}^{+\infty} dx \frac{\psi_{n}(x)}{x^{2+\sigma}} \qquad (37)$$

$$= \frac{1}{2} \left( \int_{1}^{+\infty} dx \frac{\psi_{n}(x)}{x^{2+s}} + \int_{1}^{+\infty} dx \frac{\psi_{n}(x)}{x^{2+s}} \right) + \int_{1}^{+\infty} dx \frac{\psi_{n}(x)}{x^{2+\sigma}} \qquad (38)$$

Since  $\overline{s}$  is a zero of  $L(s, \overline{\chi})$ , therefore we can use the equation (23) to write:

$$\int_{1}^{+\infty} dx \frac{2\cos^{2}(\frac{\tau}{2}\ln(x))\psi_{n}(x)}{x^{2+\sigma}} = \frac{1}{2} \left( \frac{1}{s 2^{n}} + \frac{1}{(1-s)3^{n}} + \frac{1}{\overline{s} 2^{n}} + \frac{1}{(1-\overline{s})3^{n}} + \frac{2}{\lambda(2+s)^{n}} \int_{1}^{+\infty} \frac{F(x)}{x^{2+s}} dx \right)$$
(39)

$$+ \frac{2}{\lambda(2+\overline{s})^n} \int_1^{+\infty} \frac{F(x)}{x^{2+\overline{s}}} dx + \frac{1}{\sigma^{2n}} + \frac{1}{(1-\sigma)^{3n}} + \frac{1}{(2+\sigma)^n} \left[ U_0(\sigma) - \frac{1}{\sigma(1-\sigma)} \right]$$
(40)  
$$= \frac{\sigma}{\pi^n r^2} + \frac{1}{\sigma^n} + \frac{1-\sigma}{\pi^n r^2} + \frac{1}{\sigma^n} + \frac{1}{\sigma^n}$$

$$= \frac{A_n(s)}{\|2 + s\|^n} + \frac{1}{(2 + \sigma)^n} \left[ U_0(\sigma) - \frac{1}{\sigma(1 - \sigma)} \right]$$

Therefore, from the equations (27), (33-34) and (41-42), we conclude:

$$\frac{1}{c_n^{1-2\sigma}} \sim_{n \to +\infty} \frac{\frac{(1-\sigma)}{\|1-s\|^2} + \frac{1}{(1-\sigma)}}{\frac{\sigma}{\|s\|^2} + \frac{1}{\sigma}}$$
(43)

Since  $c_n > 1$  for each n, we conclude that:

$$\frac{\frac{(1-\sigma)}{\|1-s\|^2} + \frac{1}{(1-\sigma)}}{\frac{\sigma}{\|s\|^2} + \frac{1}{\sigma}} \le 1$$
(44)

And we do the same for  $\tilde{\psi_n}$ . From the equations (25), (26) and (28), we can write the following for  $n\geq 1$ 

$$\int_{1}^{+\infty} dx \frac{2\cos^{2}(\frac{\tau}{2}\ln(x))\tilde{\psi}_{n}(x)}{x^{3-\sigma}} = \frac{1}{d_{n}^{1-2\sigma}} \int_{1}^{+\infty} dx \frac{2\cos^{2}(\frac{\tau}{2}\ln(x))\tilde{\psi}_{n}(x)}{x^{2+\sigma}}$$
(45)

Where  $d_n > 1$  is a real number. And

$$\int_{1}^{+\infty} dx \frac{2\cos^{2}(\frac{\tau}{2}\ln(x))\tilde{\psi}_{n}(x)}{x^{3-\sigma}} = \int_{1}^{+\infty} dx \frac{\tilde{\psi}_{n}(x)\cos(\tau\ln(x))}{x^{3-\sigma}} + \int_{1}^{+\infty} dx \frac{\tilde{\psi}_{n}(x)}{x^{3-\sigma}} \qquad (46)$$

$$= \frac{1}{2} \left( \int_{1}^{+\infty} dx \frac{\tilde{\psi}_{n}(x)}{x^{3-s}} + \int_{1}^{+\infty} dx \frac{\tilde{\psi}_{n}(x)}{x^{3-\overline{s}}} \right) + \int_{1}^{+\infty} dx \frac{\tilde{\psi}_{n}(x)}{x^{3-\sigma}} \qquad (47)$$

Since  $\overline{s}$  is a zero of  $L(s, \overline{\chi})$ , therefore we can use the equation (26) to write:

$$\int_{1}^{+\infty} dx \frac{2\cos^{2}(\frac{\tau}{2}\ln(x))\tilde{\psi}_{n}(x)}{x^{3-\sigma}} = \frac{1}{2} \left( \frac{1}{\overline{s}(1+2\sigma)^{n}} + \frac{1}{(1-\overline{s})(2+2\sigma)^{n}} + \frac{1}{s(1+2\sigma)^{n}} + \frac{1}{(1-s)(2+2\sigma)^{n}} \right)$$
(48)

$$+ \frac{2}{\lambda(3-s)^n} \int_1^{+\infty} \frac{F(x)}{x^{2+\overline{s}}} dx + \frac{2}{\lambda(3-\overline{s})^n} \int_1^{+\infty} \frac{\overline{F}(x)}{x^{2+s}} dx$$

$$\frac{\tilde{A}_{n}(1-s)}{\|3-s\|^{n}} = \frac{2}{\lambda(3-s)^{n}} \int_{1}^{+\infty} \frac{F(x)}{x^{2+s}} dx + \frac{2}{\lambda(3-\overline{s})^{n}} \int_{1}^{+\infty} \frac{\overline{F}(x)}{x^{2+s}} dx \quad (54)$$

And the same

$$\int_{1}^{+\infty} dx \frac{2\cos^{2}(\frac{\tau}{2}\ln(x))\tilde{\psi}_{n}(x)}{x^{2+\sigma}} = \int_{1}^{+\infty} dx \frac{\tilde{\psi}_{n}(x)\cos(\tau\ln(x))}{x^{2+\sigma}} + \int_{1}^{+\infty} dx \frac{\tilde{\psi}_{n}(x)}{x^{2+\sigma}}$$
(55)  
$$= 1 \left( \int_{1}^{+\infty} dx \frac{\tilde{\psi}_{n}(x)}{x^{2+\sigma}} + \int_{1}^{+\infty} dx \frac{\tilde{\psi}_{n}(x)}{x^{2+\sigma}} \right) + \int_{1}^{+\infty} dx \frac{\tilde{\psi}_{n}(x)}{x^{2+\sigma}}$$
(55)

$$= \frac{1}{2} \left( \int_{1}^{+\infty} dx \frac{\tilde{\psi}_{n}(x)}{x^{2+s}} + \int_{1}^{+\infty} dx \frac{\tilde{\psi}_{n}(x)}{x^{2+s}} \right) + \int_{1}^{+\infty} dx \frac{\tilde{\psi}_{n}(x)}{x^{2+\sigma}}$$
(56)

Since  $\overline{s}$  is a zero of  $L(s, \overline{\chi})$ , therefore we can use the equation (25) to write:

$$\int_{1}^{+\infty} dx \frac{2\cos^{2}(\frac{\tau}{2}\ln(x))\tilde{\psi}_{n}(x)}{x^{2+\sigma}} = \frac{1}{2} \left( \frac{1}{(1-\overline{s})(1+2\sigma)^{n}} + \frac{1}{\overline{s}(2+2\sigma)^{n}} + \frac{1}{(1-s)(1+2\sigma)^{n}} + \frac{1}{s(2+2\sigma)^{n}} \right)$$
(57)

$$+ \frac{2}{\lambda(2+s)^n} \int_1^{+\infty} \frac{F(x)}{x^{3-\overline{s}}} dx + \frac{2}{\lambda(2+\overline{s})^n} \int_1^{+\infty} \frac{\overline{F}(x)}{x^{3-s}} dx \right)$$
(58)

+ 
$$\frac{1}{(1-\sigma)(1+2\sigma)^n} + \frac{1}{\sigma(2+2\sigma)^n} + \frac{1}{(2+\sigma)^n} \left[ \tilde{U}_0(\sigma) - \frac{1}{\sigma(1-\sigma)} \right]$$
 (59)

$$= \frac{1-\sigma}{\|1-s\|^2 (1+2\sigma)^n} + \frac{1}{(1-\sigma)(1+2\sigma)^n} + \frac{\sigma}{\|s\|^2 (2+2\sigma)^n} + \frac{1}{\sigma (2+2\sigma)^n}$$
(60)

+ 
$$\frac{\tilde{A}_n(s)}{\|2+s\|^n} + \frac{1}{(2+\sigma)^n} \left[ \tilde{U}_0(\sigma) - \frac{1}{\sigma(1-\sigma)} \right]$$
 (61)

Where  $\tilde{U}_0(\sigma)$  is defined as follows:

$$\tilde{U}_0(\sigma) = \int_1^{+\infty} dt \, \frac{\tilde{\psi}_0(t)}{t^{2+\sigma}} \tag{62}$$

Therefore, from the equations (45), (51-52) and (60-61), we conclude:

$$\frac{1}{d_n^{1-2\sigma}} \sim_{n \to +\infty} \frac{\frac{\sigma}{\|s\|^2} + \frac{1}{\sigma}}{\frac{(1-\sigma)}{\|1-s\|^2} + \frac{1}{(1-\sigma)}}$$
(63)

Since  $d_n > 1$  for each n, we conclude that:

$$\frac{\frac{\sigma}{\|s\|^2} + \frac{1}{\sigma}}{\frac{(1-\sigma)}{\|1-s\|^2} + \frac{1}{(1-\sigma)}} \le 1$$
(64)

From the equations (44) and (64), we conclude that:

$$\frac{\sigma}{\|s\|^2} + \frac{1}{\sigma} = \frac{(1-\sigma)}{\|1-s\|^2} + \frac{1}{(1-\sigma)}$$
(65)

Since the function  $g(x) \rightarrow \frac{x}{x^2 + \tau^2} + \frac{1}{x}$  is strictly decreasing since its first derivative is strictly negative: for each x > 0:

$$g'(x) = \frac{-2x^4 - \tau^4 - x^2\tau^2}{x^2(x^2 + \tau^2)^2} < 0$$
(66)

$$\sigma = 1 - \sigma = \frac{1}{2} \tag{67}$$

■. □

This ends the proof of our lemma.

From the lemma 3.1 above we can conclude the following corollary.

**Corollary 3.1.1.** Let's consider two variables  $\sigma$  and  $\tau$  such that  $\sigma > 0$ ,  $\tau > 0$  and  $s = \sigma + i\tau$ . Let's q > 1 be an positive integer. Let's  $L(s, \chi)$  be a *L*-function where  $\chi$  is a Dirichlet character mod q with no cancellation property such that:

$$\sum_{n=1}^{q} \chi(n) \neq 0 \tag{68}$$

If  $L(s, \chi) = 0$ , then:

$$\sigma = \frac{1}{2} \tag{69}$$

*Proof.* Let's take x > 1 a real number. Let's denote  $n_x = \lfloor x \rfloor$  be the integer part of x. We have  $n_x = x - \{x\}$ . We denote  $q_x$  and  $r_x$  the quotient and the rest of the Euclidean division of  $n_x$  by q as follows:  $n_x = qq_x + r_x$ . Therefore we can write:

$$\sum_{n=1}^{x} \chi(n) = \sum_{n=0}^{q_{x}-1} \sum_{k=1}^{q} \chi(nq+k) + \sum_{k=1}^{r_{x}} \chi(nq+k)$$
(70)

$$= q_x \sum_{n=1}^{q} \chi(n) + \sum_{k=1}^{r_x} \chi(k)$$
(71)

$$= \frac{x - \{x\} - r_x}{q} \sum_{k=1}^{q} \chi(n) + \sum_{k=1}^{r_x} \chi(k)$$
(72)

$$= \frac{x}{q} \sum_{k=1}^{q} \chi(n) - \frac{\left(\{x\} + r_x\right)}{q} \sum_{k=1}^{q} \chi(n) + \sum_{k=1}^{r_x} \chi(k)$$
(73)

Let's define the constant  $\lambda$  and the function g as follows:

$$\lambda = \frac{\sum_{k=1}^{q} \chi(n)}{q} \tag{74}$$

$$g(x) = \frac{(\{x\} + r_x)}{q} \sum_{k=1}^{q} \chi(n) - \sum_{k=1}^{r_x} \chi(k)$$
(75)

$$= \lambda\{x\} + \underbrace{\lambda r_x - \sum_{k=1}^{r_x} \chi(k)}_{f(x)}$$
(76)

It is clear that the function f(x) is bounded. And by assumption we have  $\lambda \neq 0$ . Therefore, we can calculate  $L(s, \chi)$  as follows:

$$L(s,\chi) = s \int_{1}^{+\infty} \frac{\sum_{n=1}^{n \le x} \chi(n)}{x^{s+1}} dx$$
(77)

$$= s \int_{1}^{+\infty} \frac{\lambda x - g(x)}{x^{s+1}} dx \tag{78}$$

$$= s \int_{1}^{+\infty} \frac{\lambda}{x^{s}} dx - s \int_{1}^{+\infty} \frac{\lambda\{x\} + f(x)}{x^{s+1}} dx$$
(79)

If  $\Re(s) > 1$ , we can conclude:

$$L(s,\chi) = \frac{\lambda s}{s-1} - s \int_{1}^{+\infty} \frac{\lambda \{x\} + f(x)}{x^{s+1}} dx$$
(81)

We can extend the equation (80) over the region  $\Re(s) > 0$ .  $L(s, \chi)$  has a holomorphic continuation as a function of s to the whole complex plane (see [3, 6, 7, 8]). Therefore, we apply the lemma 3.1 to prove that  $\sigma = \frac{1}{2}$ .

**Remark.** As a direct result of the above corollary, we can see that GRH is true for the series  $\left(\sum_{n\geq 1} \frac{1}{(qn+p)^s}\right)$  with p>0 and q>1 are integers.

**Lemma 3.2.** Let's consider two variables  $\sigma$  and  $\tau$  such that  $\sigma > 0$ ,  $\tau > 0$ and  $s = \sigma + i\tau$ . Let's q > 1 be an positive integer. Let's  $L(s, \chi)$  be a *L*-function where  $\chi$  is a Dirichlet character mod q with cancellation property such that:

$$\sum_{n=1}^{q} \chi(n) = 0 \tag{82}$$

Therefore:

$$L(s,\chi) = \left(\frac{1-q^{1-s}}{q}\right)\frac{s}{s-1} - s\int_{1}^{+\infty} \frac{\left(\frac{1-q^{1-s}}{q}\right)\{x\} + f(x)}{x^{s+1}} dx$$
(83)

Where f is a bounded function.

*Proof.* We will use the zeta function  $\zeta(s)$  to prove our case.

Let's now write the following for s > 1:

$$\zeta(s) = \sum_{n=1}^{+\infty} \frac{1}{n^s} \tag{84}$$

$$= \sum_{n=0}^{\infty} \sum_{i=1}^{q} \frac{1}{(qn+i)^s}$$
(85)

$$= \sum_{i=1}^{q} \sum_{n=0}^{\infty} \frac{1}{(qn+i)^s}$$
(86)

Therefore

$$(1 - \frac{1}{q^s})\zeta(s) = \sum_{i=1}^{q-1} \sum_{n=0}^{\infty} \frac{1}{(qn+i)^s}$$
 (87)

Also

$$L(s,\chi) = \sum_{n=1}^{+\infty} \frac{\chi(n)}{n^s}$$
(88)

$$= \sum_{n=0}^{+\infty} \sum_{i=1}^{q} \frac{\chi(i)}{(qn+i)^s}$$
(89)

$$= \sum_{i=1}^{q} \chi(i) \sum_{n=0}^{+\infty} \frac{1}{(qn+i)^s}$$
(90)

Therefore since  $\chi(q) = 0$ 

$$L(s,\chi) = \sum_{i=1}^{q-1} \chi(i) \sum_{n=0}^{+\infty} \frac{1}{(qn+i)^s}$$
(91)

Since  $\sum_{n=1}^{q} \chi(n) = 0$  and  $\chi(1) = 1$ , we can write the following:

$$\sum_{n=0}^{+\infty} \frac{1}{(qn+1)^s} = L(s,\chi) - \sum_{i=2}^{q-1} \chi(i) \sum_{n=0}^{+\infty} \frac{1}{(qn+i)^s}$$
(92)

$$\sum_{n=0}^{+\infty} \frac{1}{(qn+1)^s} = \left(1 - \frac{1}{q^s}\right)\zeta(s) - \sum_{i=2}^{q-1} \sum_{n=0}^{+\infty} \frac{1}{(qn+i)^s}$$
(93)

Therefore

$$\left(1 - \frac{1}{q^s}\right)\zeta(s) - L(s,\chi) = \sum_{i=2}^{q-1} \left(1 - \chi(i)\right) \sum_{n=0}^{+\infty} \frac{1}{(qn+i)^s}$$
(94)

Let's denote  $L(s,i)_{2\leq i\leq q-1}$  as follows:

$$L(s,i) = \sum_{n=0}^{+\infty} \frac{1}{(qn+i)^s}$$
(95)

We can write also:

$$L(s,i) = s \int_{1}^{+\infty} \frac{\sum_{n=1}^{n \le x} \chi_i(n)}{x^{s+1}} dx$$
(96)

Where  $\chi_i$  is the character of L(s, i):

- (i)  $\chi_i(qn+i) = 1$
- (ii)  $\chi_i(qn+j) = 0$  if  $j \neq i$

We use the equation (90-94) to write:

$$\lambda_i = \frac{\sum_{k=1}^q \chi_i(n)}{q} = \frac{1}{q}$$
(97)

$$f_i(x) = \frac{(\{x\} + r_x)}{q} \sum_{k=1}^q \chi_i(n) - \sum_{k=1}^{r_x} \chi_i(k)$$
(98)

$$= \frac{(\{x\} + r_x)}{q} - \sum_{k=1}^{r_x} \chi_i(k)$$
(99)

Therefore from the equation (96):

$$L(s,i) = \frac{s}{q(s-1)} - s \int_{1}^{+\infty} \frac{f_i(x)}{x^{s+1}} dx$$
(100)

Therefore, we can write the equation (94) as follows:

$$\left(1 - \frac{1}{q^s}\right)\zeta(s) - L(s,\chi) = \sum_{i=2}^{q-1} \left(1 - \chi(i)\right)L(s,i)$$
(101)

$$= \frac{s}{q(s-1)} \sum_{i=2}^{q-1} \left(1 - \chi(i)\right) - s \sum_{i=2}^{q-1} \left(1 - \chi(i)\right) \int_{1}^{+\infty} \frac{f_i(x)}{x^{s+1}} dx \quad (102)$$

Thanks to the cancellation property, we can conclude that:

$$\left(1 - \frac{1}{q^s}\right)\zeta(s) - L(s,\chi) = \frac{s(q-1)}{q(s-1)} - s \int_1^{+\infty} \frac{\sum_{i=2}^{q-1} \left(1 - \chi(i)\right) f_i(x)}{x^{s+1}} dx \quad (103)$$

From the equation (10) we replace the  $\zeta(s)$  by its L-function:

$$L(s,\chi) = \frac{1-q^{1-s}}{q} \frac{s}{(s-1)} - s \int_{1}^{+\infty} \frac{(1-q^{-s})\{x\} - \sum_{i=2}^{q-1} (1-\chi(i))f_i(x)}{x^{s+1}} dx \quad (104)$$

Let's define the function g(x) as follows:

$$g(x) = (1 - q^{-s}) \{x\} - \sum_{i=2}^{q-1} (1 - \chi(i)) f_i(x)$$
(105)

$$= \frac{1-q^{1-s}}{q} \{x\} - (1-\frac{1}{q})r_x + \sum_{i=2}^{q-1} \left(1-\chi(i)\right) \sum_{k=1}^{r_x} \chi_i(k) \qquad (106)$$

$$= \frac{1-q^{1-s}}{q} \{x\} + f(x) \tag{107}$$

Where f is unrelated to s, bounded and defined as follows:

$$f(x) = -(1 - \frac{1}{q})r_x + \sum_{i=2}^{q-1} (1 - \chi(i)) \sum_{k=1}^{r_x} \chi_i(k)$$
(108)

$$= \frac{r_x}{q} - \sum_{k=1}^{r_x} \chi(k)$$
 (109)

And

$$L(s,\chi) = \left(\frac{1-q^{1-s}}{q}\right)\frac{s}{s-1} - s\int_{1}^{+\infty} \frac{\left(\frac{1-q^{1-s}}{q}\right)\{x\} + f(x)}{x^{s+1}} dx \quad (110)$$

**Lemma 3.3.** Let's consider two variables  $\sigma$  and  $\tau$  such that  $0 < \sigma < 1$ ,  $\tau > 0$  and  $s = \sigma + i\tau$ . Let's q > 1 be an positive integer. Let's  $L(s, \chi)$  be a *L*-function where  $\chi$  is a Dirichlet character mod q with cancellation property such that:

$$\sum_{n=1}^{q} \chi(n) = 0 \tag{111}$$

Let's suppose that  $s = \sigma + i\tau$  is a zero for  $L(s, \chi)$ . i.e  $L(s, \chi) = 0$ . Therefore

$$\sigma = \frac{1}{2} \tag{112}$$

And the Generalized Riemann's Hypothesis is true.

*Proof.* The proof is straightforward as we can use the lemmas 3.1 and 3.2. From lemma 3.2 we can write the following:

$$L(s,\chi) = \frac{\lambda s}{s-1} - s \int_{1}^{+\infty} \frac{\lambda\{x\} + f(x)}{x^{s+1}} dx$$
(113)

$$\lambda = \frac{1 - q^{1-s}}{q} \tag{114}$$

Where f is a bounded function. Then, we apply the lemma 3.1 to conclude that

$$\sigma = \frac{1}{2} \tag{115}$$

And the Generalized Riemann's Hypothesis is true.

#### 3.1 Conclusion

We saw that if s is a zeta zero, then real part  $\Re(s)$  can only be  $\frac{1}{2}$ . Therefore, the Generalized Riemann Hypothesis (GRH) is true: The non-trivial zeros of a L – Dirichlet function have real part equal to  $\frac{1}{2}$ . With this, we can also conclude that P = NP.
