# Unsteady micropolar fluid flow in a thin domain with Tresca fluid-solid interface law

#### Abstract

We consider a micropolar fluid flow in a two-dimensional domain. We assume that the velocity field satisfies a non-linear slip boundary condition of friction type on a part of the boundary while the micro-rotation field satisfies non-homogeneous Dirichlet boundary conditions. We prove the existence and uniqueness of a solution. Then motivated by lubrication problems we assume that the thickness and the roughness of the domain are of order $0<\varepsilon \ll 1$ and we study the asymptotic behaviour of the flow as $\varepsilon$ tends to zero. By using the two-scale convergence technique we derive the limit problem which is totally decoupled for the limit velocity and pressure $\left(v^{0}, p^{0}\right)$ on one hand and the limit micro-rotation $Z^{0}$ on the other hand. Moreover we prove that $v^{0}, p^{0}$ and $Z^{0}$ are uniquely determined via auxiliary well-posed problems.

## 1. Description of the problem

Several industrial problems involve nowadays complex fluids like polymers, colloidal fluids, ferro-liquids or liquid crystals. Such fluids contain suspensions of rigid particles that undergo rotations and the classical Navier-Stokes theory is inadequate since it does not take into account the effects of the micro-structures. The micropolar fluid model has been introduced by A.C. Eringen in [10] in order to describe the macroscopic behaviour of such fluids under the assumptions that the particles are randomly oriented or spherical and the deformation of the particles is neglected. The unknowns are the fluid velocity $u=\left(u_{1}, u_{2}, u_{3}\right)$, the pressure $p$ and the micro-rotation field $\omega=\left(\omega_{1}, \omega_{2}, \omega_{3}\right)$ which can be interpreted as the angular velocity field of the micro-particles. Then the equilibrium of

[^0]momentum, of mass and moment of momentum lead to a system of coupled partial differential equations for the triplet $(u, p, \omega)$ (see [10] or $[2,3,11,15]$ ).

Motivated by lubrication problems we consider a flow in an infinite journal bearing. The cross section of the domain is thus given by the gap between two non-concentric discs which is much smaller that the discs radii. After a radial cut the fluid domain can be represented as

where $L>0$ and $h^{\varepsilon}$ is a function of class $\mathcal{C}^{\infty}$ which is $L$-periodic in $z_{1}$ such that

By assuming that the flow and the external excitation fields do not depend on the coordinate along the longitudinal axis of the bearing we obtain a 2D problem given by

where $T>0, \nu, \nu_{r}$ and $\alpha$ are three positive physical parameters and $u^{\varepsilon}=$ $\left(u_{1}^{\varepsilon}(t, z), u_{2}^{\varepsilon}(t, z)\right), \omega^{\varepsilon}=\omega_{3}^{\varepsilon}(t, z)$. Let us emphasize that the choice $\nu_{r}=0$ would allow to decouple the two first equations from the third one and we would recover the Navier-Stokes system for $\left(u^{\varepsilon}, p^{\varepsilon}\right)$. For this reason $\nu_{r}$ is called the micro-rotation viscosity while $\nu$ is called the Newtonian viscosity of the microplolar fluid.

We decompose $\partial \Omega^{\varepsilon}$ as $\Gamma_{0}=\left\{z \in \partial \Omega^{\varepsilon}: z_{2}=0\right\}, \Gamma_{1}^{\varepsilon}=\left\{z \in \partial \Omega^{\varepsilon}: z_{2}=\right.$ $\left.\varepsilon h^{\varepsilon}\left(z_{1}\right)\right\}$, and $\Gamma_{L}^{\varepsilon}$ is the lateral part of the boundary. Due to the original geometry of the flow domain, we have

A first study for non-homogeneous Dirichlet conditions on $\Gamma_{0}$ and non-standard free boundary conditions on $\Gamma_{1}^{\varepsilon}$ has been proposed in [7]. Nevertheless, experimental studies $([16,12])$ have shown that non-linear slip boundary conditions of friction type are more realistic for such complex fluids. Hence we will consider in this paper non-homogeneous Dirichlet boundary conditions on $\Gamma_{1}^{\varepsilon}$ and Tresca friction boundary conditions for the fluid velocity on $\Gamma_{0}$ i.e.

where $k^{\varepsilon}$ is a positive given function defined on $(0, T) \times \Gamma_{0}$ and $s_{0}$ is a given function of the time variable corresponding to the Tresca friction threshold for the shear stress and the velocity of the inner cylinder of the journal bearing, respectively (see [9]). We have denoted as $\tau$ and $n$ the tangent and ouward normal unit vectors to the boundary and $\sigma\left(u^{\varepsilon}, p^{\varepsilon}\right)=\left(\sigma_{i j}\left(u^{\varepsilon}, p^{\varepsilon}\right)\right)_{1 \leq i, j \leq 2}$ is the Cauchy stress tensor defined as

Let us emphasize that we identify $\varphi \theta+v^{\varepsilon}$ and $v^{\varepsilon}$ with their trace on $\Gamma_{0}$ in the definition of $j^{\varepsilon}\left(\varphi \theta+v^{\varepsilon}\right)$ and $j^{\varepsilon}\left(v^{\varepsilon}\right)$.

The paper is organized as follows. In Section 2 we prove the existence and uniqueness of a solution to problem $\left(P^{\varepsilon}\right)$ for any $\varepsilon>0$. Then motivated by the asymptotic behaviour of thin flows we study the limit as $\varepsilon$ tends to zero. Having in mind that the roughness of the domain depends also on $\varepsilon$, we consider the particular scaling of a roughness in inverse proportion of the thickness as usual in lubrication theory $([6,7])$. In Section 3 we establish some a priori estimates for the $v^{\varepsilon}, p^{\varepsilon}$ and $Z^{\varepsilon}$ and we apply the two-scale convergence technique to get a limit velocity $v^{0}$, pressure $p^{0}$ and micro-rotation $Z^{0}$. Finally in Section 4 we derive the limit problem and we prove that $v^{0}, p^{0}$ and $Z^{0}$ are uniquely determined through auxiliary well-posed problems.

## 2. Existence and uniqueness for $\left(P^{\varepsilon}\right)$

Theorem 1. Let $\left(U_{0}, W_{0}, s_{0}\right) \in\left(H^{1}(0, T)\right)^{3}, f^{\varepsilon} \in\left(L^{2}\left((0, T) \times \Omega^{\varepsilon}\right)\right)^{2}, g^{\varepsilon} \in$ $L^{2}\left((0, T) \times \Omega^{\varepsilon}\right), k^{\varepsilon} \in L^{\infty}\left(0, T ; L_{+}^{\infty}\left(\Gamma_{0}\right)\right)$ and $\left(v_{0}^{\varepsilon}, Z_{0}^{\varepsilon}\right) \in H^{\varepsilon} \times H^{0, \varepsilon}$. Then problem $\left(P^{\varepsilon}\right)$ admits an unique solution.

Proof. In order to establish the existence of a solution we replace Tresca functional $j^{\varepsilon}$ by some regularization $j_{\eta}^{\varepsilon}(\eta>0)$ and we consider the condition " $\operatorname{div} v^{\varepsilon}=0$ " as a constraint. Hence we introduce the doubly penalized problem

Let us observe that $-\frac{1}{\delta} \operatorname{div} v_{\eta \delta}^{\varepsilon}(\delta>0)$ can be interpreted as an approximate pressure while the two terms $\frac{1}{2} \int_{0}^{T}\left(v_{\eta \delta}^{\varepsilon} \operatorname{div} v_{\eta \delta}^{\varepsilon}, \varphi\right) \theta d t$ and $\frac{1}{2} \int_{0}^{T}\left(Z_{\eta \delta}^{\varepsilon} \operatorname{div} v_{\eta \delta}^{\varepsilon}, \psi\right) \theta d t$ are added for technical reasons. Indeed, in this approximate problem the velocity is not anymore divergence free. Hence the trilinear term $B\left(\bar{v}_{\eta \delta}^{\varepsilon}, \bar{v}_{\eta \delta}^{\varepsilon}, \bar{\Theta}\right)$ does not vanish anymore when we choose $\bar{\Theta}=\bar{v}_{\eta \delta}^{\varepsilon}$ and these two additional terms are introduced in order to cancel with $B\left(\bar{v}_{\eta \delta}^{\varepsilon}, \bar{v}_{\eta \delta}^{\varepsilon}, \bar{\Theta}\right)$ when $\bar{\Theta}=\bar{v}_{\eta \delta}^{\varepsilon}$.

Then we prove the existence of a solution to Problem $\left(P_{\eta \delta}^{\varepsilon}\right)$ by using a Galerkin method. Indeed let $\left(\Phi_{j}\right)_{j \geq 1}$ and $\left(\Psi_{j}\right)_{j \geq 1}$ be Hilbertian bases of $V^{\varepsilon}$ and $H^{1, \varepsilon}$, respectively such that $\left(\Phi_{j}\right)_{j \geq 1}$ and $\left(\Psi_{j}\right)_{j \geq 1}$ are orthogonal for the inner product of $\left(H^{1}\left(\Omega^{\varepsilon}\right)\right)^{2}$ and $H^{1}\left(\Omega^{\varepsilon}\right)$ and orthonormal for the inner product of $\left(L^{2}\left(\Omega^{\varepsilon}\right)\right)^{2}$ and $L^{2}\left(\Omega^{\varepsilon}\right)$, respectively. In order to prove uniqueness of the solution to Problem $\left(P^{\varepsilon}\right)$, we use Sobolev's inequalities. Indeed, since $\Omega^{\varepsilon} \subset \mathbb{R}^{2}$, there exists a constant $C\left(\Omega^{\varepsilon}\right)>0$ such that

## 3. A priori estimates and two-scale convergence limit

As usual in lubrication theory the roughness of the flow domain depends also on $\varepsilon$ and is inversely proportional to its thickness (see $[6,7]$ ). Hence we assume from now on that $h^{\varepsilon}\left(z_{1}\right)=h\left(z_{1}, \frac{z_{1}}{\varepsilon}\right)$ with
$\frac{L}{\varepsilon} \in \mathbb{N}, \quad h:\left(z_{1}, \eta_{1}\right) \mapsto h\left(z_{1}, \eta_{1}\right)$ is $\mathrm{L}-$ periodic in $z_{1}$ and $1-$ periodic in $\eta_{1}$ and $h \in \mathcal{C}^{\infty}\left(\mathbb{R}^{2}\right)$ is bounded from above and from below by two positive real numbers $h_{M}$ and $h_{m}$.

Let us observe that the roughness introduces a rapid scale variable $\frac{z_{1}}{\varepsilon}$ in the horizontal direction. So motivated by the asymptotic behaviour as $\varepsilon$ tends to zero we introduce the following scaling

For the sake of notational simplicity we will still denote them as $v^{\varepsilon}, p^{\varepsilon}$ and $Z^{\varepsilon}$ whatever we choose as space variables i.e.

Then we rewrite all these integrals by using the rescaled variables $\left(y_{1}, y_{2}\right)$ and we apply Young's inequality and Gronwall's lemma to derive (6)-(9). In order to keep some information at the limit about the dependence of the flow with respect to the rapid scale oscillations of the boundary we choose to apply the two-scale convergence technique, introduced by G. Nguetseng ([18]) and G. Allaire ([1]) in the framework of elliptic partial differential equations and extended later on to time-dependent problems (see for instance [17, 13, 19, 7]). For the convenience of the reader let us recall the definition and main results of two-scale convergence.

We may observe that the time variable appears now as a parameter in (11). Moreover by choosing test-functions $\Theta=(0, \psi) \in V_{0, \text { div }} \times H_{0, \sharp}^{1}$ we obtain a variational equality for $Z^{0}$ leading to the following limit problem:

Let us emphasize that we recover the same limit problem for $Z^{0}$ as in [7]: this is not surprising since the coupling terms in Problem $\left(P^{\varepsilon}\right)$ involve only first order derivatives so they disappear at the limit leading to a decoupled problem for $\left(v^{0}, p^{0}\right)$ on one hand and $Z^{0}$ on the other hand. As a consequence we have:

Remark 3. We may observe that $\bar{p}^{1}$ depends linearly and continuously on $w^{*}$ i.e. there exists $\mathcal{Q} \in \mathcal{L}_{c}\left(V_{\text {div }}^{*}, H_{\sharp}^{1}(0, L)_{\mathbb{R}}\right)$ such that $\bar{p}^{1}=\mathcal{Q}\left(w^{*}\right)$.

It remains to identify the limit problem for $v^{0}$.

Let $\left(U_{0}, W_{0}, s_{0}\right) \in\left(H^{1}(0, T)\right)^{3}$ and $f \in\left(\mathcal{C}\left([0, T] ; \mathcal{C}\left(\bar{\Omega} ; \mathcal{C}_{\sharp}(0,1)\right)\right)^{2}\right.$, $g \in \mathcal{C}\left([0, T] ; \mathcal{C}\left(\bar{\Omega} ; \mathcal{C}_{\sharp}(0,1)\right)\right.$ and $k \in \mathcal{C}\left([0, T] ; \mathcal{C}\left([0, L] ; \mathcal{C}_{\sharp}(0,1)\right)\right)$ such that $k$ takes its values in $\mathbb{R}_{*}^{+}, f, g$ and $k$ are L-periodic in $y_{1}$ and
$\varepsilon^{2} f^{\varepsilon}(t, y)=f\left(t, y, \frac{y_{1}}{\varepsilon}\right), \quad \varepsilon^{2} g^{\varepsilon}(t, y)=g\left(t, y, \frac{y_{1}}{\varepsilon}\right), \quad \varepsilon k^{\varepsilon}\left(t, y_{1}\right)=k\left(t, y_{1}, \frac{y_{1}}{\varepsilon}\right)$
for all $(t, y) \in[0, T] \times \bar{\Omega}$. Let us assume moreover that $\varepsilon Z_{0}^{\varepsilon}$ is bounded in $L^{2}(\Omega)$ and that $u_{0}^{\varepsilon}$ satisfies the following compatibility condition: there exists $\mathcal{U} \in C^{\infty}(\mathbb{R})$ such that

$$
\mathcal{U}(0)=\mathcal{U}^{\prime}(0)=0, \quad \mathcal{U}(X)=1 \quad \forall X \in\left[h_{m}, h_{M}\right]
$$

and

$$
u_{0}^{\varepsilon}=s_{0}(0) e_{1}+\left(U_{0}(0)-s_{0}(0)\right) \mathcal{U}\left(\frac{z_{2}}{\varepsilon}\right) e_{1}
$$

Then the limit problem for $v^{0}$ is given by
Problem ( $P_{v^{0}}$ )

$$
\begin{aligned}
& \int_{0}^{T} \int_{0}^{L} \bar{a}_{y_{1}}\left(v^{0}, \varphi\right) d y_{1} d t+\int_{0}^{T} \int_{0}^{L} \frac{\partial p^{0}}{\partial y_{1}}\left(\int_{Y} h\left(y_{1}, \cdot\right) \varphi_{1} d \eta_{1} d y_{2}\right) d y_{1} d t \\
& +\int_{0}^{T} \int_{(0, L) \times(0,1)} k\left(\left|\varphi+v^{0}\right|-\left|v^{0}\right|\right) d \eta_{1} d y_{1} d t \geq-\int_{0}^{T} \int_{0}^{L} \bar{a}_{y_{1}}\left(\bar{U} e_{1}, \varphi\right) d y_{1} d t \\
& +\int_{0}^{T} \int_{0}^{L}\left(\int_{Y} f h \varphi d \eta_{1} d y_{2}\right) d y_{1} d t \quad \forall \varphi \in L^{2}\left(0, T ; V_{\text {div }}\right) .
\end{aligned}
$$

Proof. With the compatibility condition for $u_{0}^{\varepsilon}$ we may choose the extension $U^{\varepsilon}$ given by

$$
U^{\varepsilon}\left(t, z_{2}\right)=s_{0}(t)+\left(U_{0}(t)-s_{0}(t)\right) \mathcal{U}\left(\frac{z_{2}}{\varepsilon}\right)
$$

which implies $v_{0}^{\varepsilon}=0$.
Now let $\varphi \in \widetilde{V}_{d i v}$ and $\Theta^{\varepsilon}=\left(\varphi^{\varepsilon}, 0\right)$ with

$$
\varphi^{\varepsilon}(z)=\varphi\left(z_{1}, \frac{z_{2}}{\varepsilon h^{\varepsilon}\left(z_{1}\right)}, \frac{z_{1}}{\varepsilon}\right)+\frac{z_{2}}{h^{\varepsilon}\left(z_{1}\right)} \frac{\partial h}{\partial y_{1}}\left(z_{1}, \frac{z_{1}}{\varepsilon}\right) \varphi_{1}\left(z_{1}, \frac{z_{2}}{\varepsilon h^{\varepsilon}\left(z_{1}\right)}, \frac{z_{1}}{\varepsilon}\right) e_{2}
$$

for all $\left(z_{1}, z_{2}\right) \in \Omega^{\varepsilon}$. We have $\Theta^{\varepsilon} \in \widetilde{V}^{\varepsilon} \times \widetilde{H}^{1, \varepsilon}$ and we introduce this test-function in $\left(P^{\varepsilon}\right)$. Then we introduce $\bar{\Theta}^{\varepsilon}=\left(-v^{\varepsilon}, 0\right)$ as test-function in $\left(P^{\varepsilon}\right)$ and we add the two inequalities. For all $\theta \in \mathcal{D}(0, T)$ we get

$$
\begin{aligned}
& -\int_{0}^{T}\left[\bar{v}^{\varepsilon}, \Theta^{\varepsilon}\right] \theta^{\prime} d t+\int_{0}^{T} a\left(\bar{v}^{\varepsilon}, \Theta^{\varepsilon}\right) \theta d t+\int_{0}^{T} B\left(\bar{v}^{\varepsilon}, \bar{v}^{\varepsilon}, \Theta^{\varepsilon}\right) \theta d t \\
& +\int_{0}^{T} \mathcal{R}\left(\bar{v}^{\varepsilon}, \Theta^{\varepsilon}\right) \theta d t-\int_{0}^{T} \mathcal{R}\left(\bar{v}^{\varepsilon},\left(v^{\varepsilon}, 0\right)\right) d t+\underbrace{j^{\varepsilon}\left(\varphi^{\varepsilon} \theta+v^{\varepsilon}\right)-j^{\varepsilon}\left(v^{\varepsilon}\right)}_{\leq j^{\varepsilon}\left(\varphi^{\varepsilon} \theta\right)} \\
& \geq j^{\varepsilon}\left(v^{\varepsilon}\right)+\int_{0}^{T}\left(p^{\varepsilon}, \operatorname{div} \varphi^{\varepsilon}\right) \theta d t+\int_{0}^{T}\left(\mathcal{F}\left(\bar{v}^{\varepsilon}\right), \Theta^{\varepsilon}\right) \theta d t \\
& -\int_{0}^{T}\left(\mathcal{F}\left(\bar{v}^{\varepsilon}\right),\left(v^{\varepsilon}, 0\right)\right) d t+\left(\nu+\nu_{r}\right) \int_{0}^{T}\left(\nabla v^{\varepsilon}, \nabla v^{\varepsilon}\right) d t+\underbrace{\frac{1}{2}\left\|v^{\varepsilon}(T)\right\|_{L^{2}\left(\Omega^{\varepsilon}\right)}^{2}}_{\geq 0} .
\end{aligned}
$$

We rewrite the integrals in terms of $\left(y_{1}, y_{2}\right)$ and we multiply by $\varepsilon$. Then we pass to the limit as $\varepsilon$ tends to zero by using the same techniques as in Theorem 5.1 in [7] (see also Proposition 5), except for the quadratic term $\varepsilon \int_{0}^{T}\left(\nabla v^{\varepsilon}, \nabla v^{\varepsilon}\right) d t$ for which we apply Proposition 1.6 in [1], the boundary term $\varepsilon j^{\varepsilon}\left(\varphi^{\varepsilon} \theta\right)$ which
converges to $\int_{0}^{T} \int_{(0, L) \times(0,1)} k\left(t, y_{1}, \eta_{1}\right)\left|\varphi_{1}\left(y_{1}, 0, \eta_{1}\right) \theta(t)\right| d \eta_{1} d y_{1} d t$ thanks to Remark 2 and for the boundary term $\varepsilon j^{\varepsilon}\left(v^{\varepsilon}\right)$ for which we apply the following lemma.

Lemma 4. Let $\left(w^{\varepsilon}\right)_{\varepsilon>0}$ be a bounded sequence of $L^{2}\left(0, T ; L^{2}(0, L)\right)$ and let us denote as $w^{0} \in L^{2}\left(0, T ; L^{2}((0, L) \times(0,1))\right)$ its two-scale limit. Then

$$
\lim \inf _{\epsilon \rightarrow 0} \int_{0}^{T} \int_{0}^{L}\left|w^{\varepsilon}\left(t, y_{1}\right)\right| d y_{1} d t \geq \int_{0}^{T} \int_{(0, L) \times(0,1)}\left|w^{0}\left(t, y_{1}, \eta_{1}\right)\right| d \eta_{1} d y_{1} d t
$$

Proof. Let us denote as $\phi$ the convex, proper and continuous function defined by $\phi(s)=|s|$ for all $s \in \mathbb{R}$. The Yosida approximation of $A=\partial \phi$ is defined by $A_{\lambda}=\left\{\nabla \phi_{\lambda}\right\}$ with $\phi_{\lambda} \in C^{1}(\mathbb{R} ; \mathbb{R})$ given by

$$
\phi_{\lambda}(z)=\inf _{s \in \mathbb{R}}\left(\phi(s)+\frac{|s-z|^{2}}{2 \lambda}\right) \quad \forall z \in \mathbb{R}, \quad \forall \lambda>0
$$

With the usual properties about the subdifferential of convex functions (see for instance Proposition 2.6 and Proposition 2.11 in [8]), we know that $\phi_{\lambda}$ is convex, $\nabla \phi_{\lambda}$ is $\frac{1}{\lambda}$-Lipschitz continuous and

$$
\begin{equation*}
0 \leq \phi_{\lambda}(z) \leq \phi(z), \quad \lim _{\lambda \rightarrow 0} \phi_{\lambda}(z)=\phi(z) \quad \forall z \in \mathbb{R} \tag{15}
\end{equation*}
$$

Now let $\lambda>0$. For all $\varepsilon>0$, by using the convexity of $\phi_{\lambda}$ we have

$$
\begin{aligned}
& \int_{0}^{T} \int_{0}^{L} \phi\left(w^{\varepsilon}\left(t, y_{1}\right)\right) d y_{1} d t \geq \int_{0}^{T} \int_{0}^{L} \phi_{\lambda}\left(w^{\varepsilon}\left(t, y_{1}\right)\right) d y_{1} d t \\
& \geq \int_{0}^{T} \int_{0}^{L} \phi_{\lambda}\left(w\left(t, y_{1}, \frac{y_{1}}{\varepsilon}\right)\right) d y_{1} d t \\
& +\int_{0}^{T} \int_{0}^{L} \nabla \phi_{\lambda}\left(w\left(t, y_{1}, \frac{y_{1}}{\varepsilon}\right)\right)\left(w^{\varepsilon}\left(t, y_{1}\right)-w\left(t, y_{1}, \frac{y_{1}}{\varepsilon}\right)\right) d y_{1} d t
\end{aligned}
$$

for all $w \in \mathcal{D}((0, T) \times(0, L) \times(0,1))$. Then we pass to the limit as $\varepsilon$ tends to zero: the left hand side of the previous inequality is bounded, so it admits a limit inf while the right hand side admits a limit and we obtain

$$
\begin{aligned}
& \liminf _{\varepsilon \rightarrow 0} \int_{0}^{T} \int_{0}^{L} \phi\left(w^{\varepsilon}\left(t, y_{1}\right)\right) d y_{1} d t \geq \int_{0}^{T} \int_{(0, L) \times(0,1)} \phi_{\lambda}\left(w\left(t, y_{1}, \eta_{1}\right)\right) d y_{1} d t \\
& +\int_{0}^{T} \int_{(0, L) \times(0,1)} \nabla \phi_{\lambda}\left(w\left(t, y_{1}, \eta_{1}\right)\right)\left(w^{0}\left(t, y_{1}, \eta_{1}\right)-w\left(t, y_{1}, \eta_{1}\right)\right) d y_{1} d t
\end{aligned}
$$

Using again the convexity of $\phi_{\lambda}$ we infer

$$
\begin{gathered}
\liminf _{\varepsilon \rightarrow 0} \int_{0}^{T} \int_{0}^{L} \phi\left(w^{\varepsilon}\left(t, y_{1}\right)\right) d y_{1} d t \geq \int_{0}^{T} \int_{(0, L) \times(0,1)} \phi_{\lambda}\left(w^{0}\left(t, y_{1}, \eta_{1}\right)\right) d y_{1} d t \\
+\int_{0}^{T} \int_{(0, L) \times(0,1)}\left(\nabla \phi_{\lambda}\left(w^{0}\left(t, y_{1}, \eta_{1}\right)\right)-\nabla \phi_{\lambda}\left(w\left(t, y_{1}, \eta_{1}\right)\right)\right) \\
\times\left(w\left(t, y_{1}, \eta_{1}\right)-w^{0}\left(t, y_{1}, \eta_{1}\right)\right) d y_{1} d t .
\end{gathered}
$$

Since $w^{0} \in L^{2}\left(0, T ; L^{2}((0, L) \times(0,1))\right)=L^{2}((0, T) \times(0, L) \times(0,1))$ we may consider a sequence $\left(w_{k}^{0}\right)_{k \in \mathbb{N}} \in \mathcal{D}((0, T) \times(0, L) \times(0,1))$ which converges strongly to $w^{0}$ in $L^{2}((0, T) \times(0, L) \times(0,1))$. Thus
$\lim \inf _{\varepsilon \rightarrow 0} \int_{0}^{T} \int_{0}^{L} \phi\left(w^{\varepsilon}\left(t, y_{1}\right)\right) d y_{1} d t \geq \int_{0}^{T} \int_{(0, L) \times(0,1)} \phi_{\lambda}\left(w^{0}\left(t, y_{1}, \eta_{1}\right)\right) d y_{1} d t$
for all $\lambda>0$. Finally we pass to the limit as $\lambda$ tends to zero with Lebesgue's theorem.

We obtain

$$
\begin{aligned}
& \int_{0}^{T} \int_{0}^{L} \bar{a}_{y_{1}}\left(v^{0}, \varphi \theta-v^{0}\right) d y_{1} d t+\int_{0}^{T} \int_{0}^{L} \frac{\partial p^{0}}{\partial y_{1}}\left(\int_{Y} h\left(y_{1}, \cdot\right) \varphi_{1} d \eta_{1} d y_{2}\right) \theta d y_{1} d t \\
& +\int_{0}^{T} \int_{(0, L) \times(0,1)}^{T} k\left(|\varphi \theta|-\left|v^{0}\right|\right) d \eta_{1} d y_{1} d t \geq-\int_{0}^{T} \int_{0}^{L} \bar{a}_{y_{1}}\left(\bar{U} e_{1}, \varphi \theta-v^{0}\right) d y_{1} d t \\
& +\int_{0}^{T} \int_{(0, L) \times Y} f\left(\varphi \theta-v^{0}\right) h d \eta_{1} d y_{1} d t \quad \forall \theta \in \mathcal{D}(0, T), \quad \forall \varphi \in \widetilde{V}_{d i v}
\end{aligned}
$$

and we conclude by using the density of $\mathcal{D}(0, T) \otimes \widetilde{V}_{\text {div }}$ into $L^{2}\left(0, T ; V_{\text {div }}\right)$ and (14).

Remark 4. We may weaken the compatibility condition on $u_{0}^{\varepsilon}$ by assuming only that $\left(\varepsilon u_{0}^{\varepsilon}\right)_{\varepsilon>0}$ converges to zero in $\left(L^{2}(\Omega)\right)^{2}$.

By replacing $v^{0}$ by its decomposition (13) we obtain a limit problem for $w^{*}$ and we have

Proposition 8. Under the assumptions of Theorem 3, $w^{*} \in L^{2}\left(0, T ; V_{d i v}^{*}\right)$ is the unique solution of the variational inequality

$$
\begin{aligned}
& b\left(w^{*}, \varphi\right)+\int_{0}^{T} \int_{(0, L) \times(0,1)} k\left(\left|\varphi+w^{*}\right|-\left|w^{*}\right|\right) d \eta_{1} d y_{1} d t+T(\varphi) \geq 0 \\
& \forall \varphi \in L^{2}\left(0, T ; V_{d i v}^{*}\right)
\end{aligned}
$$

with
$b(w, \varphi)=\int_{0}^{T} \int_{0}^{L} \bar{a}_{y_{1}}(w, \varphi) d y_{1} d t+\int_{0}^{T} \int_{0}^{L} \frac{\partial \mathcal{Q}(w)}{\partial y_{1}} \frac{\partial \mathcal{Q}(\varphi)}{\partial y_{1}} \bar{a}_{y_{1}}\left(w_{y_{1}}^{1}, w_{y_{1}}^{1}\right) d y_{1} d t$
and

$$
\begin{aligned}
& T(\varphi)=\int_{0}^{T} \int_{0}^{L} \frac{\partial \bar{p}^{0}}{\partial y_{1}}\left(\int_{Y} h \varphi_{1} d \eta_{1} d y_{2}\right) d y_{1} d t+\int_{0}^{T} \int_{0}^{L} \bar{a}_{y_{1}}\left(\bar{U} e_{1}, \varphi\right) d y_{1} d t \\
& -\int_{0}^{T} \int_{0}^{L}\left(\int_{Y} f h \varphi d \eta_{1} d y_{2}\right) d y_{1} d t
\end{aligned}
$$

for all $\varphi \in L^{2}\left(0, T ; V_{d i v}^{*}\right)$ and for all $w \in L^{2}\left(0, T ; V_{\text {div }}^{*}\right)$.

Proof. With straighforward computations we obtain (16) and it remains only to prove that (16) admits a unique solution. Since $\mathcal{Q} \in \mathcal{L}_{c}\left(V_{d i v}^{*}, H_{\sharp}^{1}(0, L)_{\mid \mathbb{R}}\right)$ it is clear that $b$ is a bilinear continuous mapping on $L^{2}\left(0, T ; V_{d i v}^{*}\right)$. Moreover $\bar{a}_{y_{1}}$ is coercive on $V_{y_{1}, d i v}$ for all $y_{1} \in[0, L]$ uniformly with respect to $y_{1}$ (see Proposition 5.2 in [7]) which implies that $b$ is coercive on $L^{2}\left(0, T ; V_{d i v}^{*}\right)$ and we may conclude by applying for instance Theorem 8.5 in [14].

As a consequence of the uniqueness of $w^{*}$, we can state:
Theorem 5. Let $\left(U_{0}, W_{0}, s_{0}\right) \in\left(H^{1}(0, T)\right)^{3}$ and $f \in\left(\mathcal{C}\left([0, T] ; \mathcal{C}\left(\bar{\Omega} ; \mathcal{C}_{\sharp}(0,1)\right)\right)^{2}\right.$, $g \in \mathcal{C}\left([0, T] ; \mathcal{C}\left(\bar{\Omega} ; \mathcal{C}_{\sharp}(0,1)\right)\right.$ and $k \in \mathcal{C}\left([0, T] ; \mathcal{C}\left([0, L] ; \mathcal{C}_{\sharp}(0,1)\right)\right)$ such that $k$ takes its values in $\mathbb{R}_{*}^{+}, f, g$ and $k$ are L-periodic in $y_{1}$ and
$\varepsilon^{2} f^{\varepsilon}(t, y)=f\left(t, y, \frac{y_{1}}{\varepsilon}\right), \quad \varepsilon^{2} g^{\varepsilon}(t, y)=g\left(t, y, \frac{y_{1}}{\varepsilon}\right), \quad \varepsilon k^{\varepsilon}\left(t, y_{1}\right)=k\left(t, y_{1}, \frac{y_{1}}{\varepsilon}\right)$
for all $(t, y) \in[0, T] \times \bar{\Omega}$. Let us assume moreover that $\varepsilon Z_{0}^{\varepsilon}$ is bounded in $L^{2}(\Omega)$ and that $u_{0}^{\varepsilon}$ satisfies the following compatibility condition: there exists $\mathcal{U} \in C^{\infty}(\mathbb{R})$ such that

$$
\mathcal{U}(0)=\mathcal{U}^{\prime}(0)=0, \quad \mathcal{U}(X)=1 \quad \forall X \in\left[h_{m}, h_{M}\right]
$$

and

$$
u_{0}^{\varepsilon}=s_{0}(0) e_{1}+\left(U_{0}(0)-s_{0}(0)\right) \mathcal{U}\left(\frac{z_{2}}{\varepsilon}\right) e_{1} .
$$

Then the whole sequences $\left(\varepsilon^{2} p^{\varepsilon}\right)_{\varepsilon>0},\left(v^{\varepsilon}\right)_{\varepsilon>0}$ and $\left(Z^{\varepsilon}\right)_{\varepsilon>0}$ satisfy the following convergence:

$$
\begin{aligned}
& \varepsilon p^{\varepsilon} \rightarrow \rightarrow \bar{p}^{0}+\bar{p}^{1} \\
& v^{\varepsilon} \rightarrow \rightarrow v^{0}=\frac{\partial \bar{p}^{0}}{\partial y_{1}} w_{y_{1}}^{1}+\left(U_{0}-s_{0}\right) w_{y_{1}}^{2}+w_{t, y_{1}}^{3}+\frac{\partial \bar{p}^{1}}{\partial y_{1}} w_{y_{1}}^{1}+w^{*} \\
& Z^{\varepsilon} \rightarrow \rightarrow Z^{0}=W_{0} z_{y_{1}}^{1}+z_{t, y_{1}}^{2} .
\end{aligned}
$$
