Height and contour processes of Crump-Mode-Jagers forests (II): the Bellman–Harris universality class

Emmanuel Schertzer* Florian Simatos†

Abstract

Crump–Mode–Jagers (CMJ) trees generalize Galton–Watson trees by allowing individuals to live for an arbitrary duration and give birth at arbitrary times during their life-time. In this paper, we exhibit a simple condition under which the height and contour processes of CMJ forests belong to the universality class of Bellman–Harris processes. This condition formalizes an asymptotic independence between the chronological and genealogical structures. We show that it is satisfied by a large class of CMJ processes and in particular, quite surprisingly, by CMJ processes with a finite variance offspring distribution. Along the way, we prove a general tightness result.

1 Introduction and presentation of results in the non-triangular case

1.1 Crump-Mode-Jagers forests

The subject of the present paper is the study of the height and contour processes of planar Crump–Mode–Jagers (CMJ) forests, which are random instances of chronological forests. Chronological trees generalize discrete trees in the following way. Each individual u is endowed with a pair (V_u, \mathscr{P}_u) such that:

- (1) \mathscr{P}_u is a point measure on $(0,\infty)$ where atoms represent the age of u at childbearing, so that the mass $|\mathscr{P}_u|$ of \mathscr{P}_u is the total number of children of u;
- (2) $V_u \in (0,\infty)$ represents the life-length of u and satisfies $\mathscr{P}_u(V_u,\infty) = 0$, i.e., individuals produce their offspring during their life-time.

As noted by Lambert [17], a chronological tree can be regarded as a tree satisfying the rule "edges always grow to the right". This is illustrated in Figures 1 and 2 where we present the sequential construction of a planar chronological forest from a sequence of "sticks" $\omega = (\omega_n, n \ge 0)$, where $\omega_n = (V_n, \mathcal{P}_n)$. For $n \ge 1$, (V_n, \mathcal{P}_n) describes the life of the nth individual according to the lexicographic order.

A CMJ forest is obtained when the initial sequence of sticks $((V_n, \mathscr{P}_n), n \geq 0)$ is i.i.d.. In this introduction we aim to present our main results in a concise way. In particular, we explain our main results (corresponding to Theorems A–E below) in the non-triangular setting where the common law of the (V_n, \mathscr{P}_n) , denoted by (V^*, \mathscr{P}^*) , is independent of the scaling parameter p and satisfies $\mathbb{E}(|\mathscr{P}^*|)=1.$ Except for Theorem D, these results are extended to the triangular case in Theorems A', B', C' and E' below. Moreover, our results involve some complex objects (such as the spine process) which are defined next only informally: formal and more cumbersome definitions are provided in Section 2.

Figure 1: Sequence of sticks used in the next figures: this sequence corresponds to one chronological tree.

Figure 2: Sequential construction of the chronological tree from the sequence of sticks of Figure 1: as long as there is a stub available, we graft the next stick at the highest one. At $n = 10$ the construction is complete (there is no more stub available) and the next stick will therefore start the next tree in the forest.

1.2 Height, spine and contour of a CMJ forest

The chronological height, spine and contour processes introduced now are illustrated on Figures 3 and 4.

We define the chronological height process at time n , denoted $H(n)$, as the date of birth of the nth individual in the forest. The chronological height can be obtained by summing up the "chronological contribution" of each ancestor along the ancestral line associated with n . To formalize this statement, we consider the spine at time n , denoted $\Pi(n)$, which is the measure recording each of those contributions along the spine. In particular, we have the relation $\mathbb{H}(n) = |\mathbb{\Pi}(n)|$ with $|\nu|$ the mass of a measure ν .

For the contour process, we follow Duquesne [8] (with the difference that we consider càdlàg instead of càglàd coding functions) and consider an exploration particle traveling along the edges of the forest from left to right with the following convention: the particle travels at infinite speed when going downward and at unit speed when going upward (see Figure 4). Usually, the contour process at time t, denoted $\mathbb{C}(t)$, is defined as the distance of the particle to the root. Here we rather encode the chronological contour process by two coordinates and write $\mathbb{C}(t) = (\mathbb{C}^{\star}(t), \mathscr{X}(t))$ with $\mathbb{C}^{\star}(t)$ the chronological height of the individual visited at time t by the exploration particle and $\mathscr{X}(t)$ the position of the exploration particle relatively to the edge currently visited. In particular, the distance of the particle to the root at time t (i.e., the value of the classical contour process) is given by $\mathbb{C}^{\star}(t) + \mathscr{X}(t)$. The motivation for this decomposition is that we then have the explicit expression

$$
\mathbb{C}^{\star}(t) = \mathbb{H} \circ \mathscr{V}^{-1}(t) \quad \text{and} \quad \mathscr{X}(t) = t - \mathscr{V}(\mathscr{V}^{-1}(t) -), \ t \ge 0,\tag{1.1}
$$

where $\mathscr V$ is the renewal process $\mathscr V(n)=V_0+\cdots+V_n$ and $\mathscr V^{-1}$ is its right-continuous inverse, see Figure 4.

Moreover, we will denote by $\mathcal H$ the genealogical height process defined similarly as above but from the genealogical forest constructed out of the sequence of sticks

Figure 3: Spine decomposition of the individual 7: $\Pi(7)=\hat{R}^7(\{2\})\epsilon_0+\hat{R}^7(\{1\})\epsilon_1$ where $\hat{R}^7(\{k\})$ is the age of the kth ancestor of 7 when giving birth to the next individual on the spine. In particular, $\mathbb{H}(7)=\hat{R}^7(\{1\})+\hat{R}^7(\{2\})=|\Pi(7)|$ expressing that the chronological height of 7 is obtained by summing up the chronological contribution of each ancestor on her spine.

The genealogical tree is obtained by resizing all the sticks to unit size and putting all the atoms at one. The genealogical height process is then obtained as before, but from the genealogical tree.

 $(1, |\mathscr{P}_i| \epsilon_1)$ where sticks are scaled to unit size and all atoms are gathered at the end (here and in the sequel, ϵ_x denotes the Dirac measure at x). In other words, $\mathcal{H}(n)$ is the number of ancestors of n.

To summarize, we will consider the following processes:

- **Genealogical process:** \mathcal{H} denotes the *genealogical* height process which encodes the forest constructed out of the sequence $(1, |\mathscr{P}_i| \epsilon_1)$ – see Figure 5;
- **Chronological processes:** H and $C = (C^*, C)$ denote the *chronological* height and contour processes, respectively, and $\Pi = (\Pi(n), n \ge 0)$ denotes the spine process.

1.3 General tightness result

Our first main result is that, under the standard assumptions G, C1 and C2 below, there exists a "good" scaling of the chronological height and contour processes, i.e.,

one that leads to tight sequences with non-degenerate accumulation points. These assumptions are related to the tail of random variables $T(1)$ and $R(1)$ where, for a given "typical" individual x :

- $T(1)$ is the lexicographic distance to her first ancestor;
- $R(1)$ is the age of her parent when begetting x.

Formally, those random variables are defined through the ladder height process associated with the Lukasiewicz path

$$
S(n) = \sum_{i=0}^{n-1} (|\mathcal{P}_i| - 1)
$$

and their joint law is described in more details in (2.3) below. Assumption G concerns the genealogical structure, and Assumptions C1 and C2 the chronological structure.

Assumption G. We say that Assumption G holds if $\mathbb{E}(|\mathscr{P}^*|^2)<\infty$ or if $|\mathscr{P}^*|$ is in the domain of attraction of a γ -stable distribution with $\gamma \in (1,2)$.

Assumption C1**.** We say that Assumption C1 holds if R(1) is in the domain of attraction of a β -stable distribution with $\beta \in (0,1)$.

Assumption C2. We say that Assumption C2 holds if V^* is in the domain of attraction of an α -stable law with $\alpha \in (0,1)$.

Actually, our results also apply when $R(1)$ and V^* have finite means. However, this case has already been treated in [25] and leads to somewhat degenerate limits within the framework of the present paper (deterministic subordinators), see Section 1.7 for more details.

Let X, Y, Z be stable laws with respective Laplace exponents $\lambda^{\gamma}, \lambda^{\beta}, \lambda^{\alpha}$. Under Assumptions G, C1 and C2, there exist vanishing scaling sequences (g_p) , (c_p) and (v_p) such that

$$
g_p \sum_{i=1}^p (|\mathscr{P}_i| - 1) \Rightarrow X
$$
, $c_p \sum_{i=1}^{[1/g_p]} R(i) \Rightarrow Y$ and $v_p \sum_{i=1}^p |V_i| \Rightarrow Z$.

More precisely, these scaling sequences can be written

$$
g_p = p^{-1/\gamma} \ell(p), c_p = g_p^{1/\beta} \ell'(p)
$$
 and $v_p = p^{-1/\alpha} \ell''(p)$

with $\gamma \in (1,2]$ ($\gamma = 2$ corresponding to the finite variance case) and ℓ, ℓ' and ℓ'' slowly varying functions. Armed with these scaling sequences we then scale the renewal process V and the height and contour processes as follows:

$$
\mathscr{V}_p(t) = v_p \mathscr{V}([pt]), \quad \mathbb{H}_p(t) = c_p \mathbb{H}([pt]), \quad \mathbb{C}_p^{\star}(t) = c_p \mathbb{C}^{\star}(pt) \quad \text{and} \quad \mathscr{X}_p(t) = v_p \mathscr{X}(pt)
$$

for $t \geq 0$. Note in particular that the two coordinates of the contour do not have the same scaling, and we will actually show that, under general assumptions, we have $c_p \gg v_p$, which informally corresponds to the fact that the edge currently visited is much longer than the height of its bottom point.

Finally Π_p will denote the spine process when time is scaled by p, space by g_p and mass by c_p : $\Pi_p(t)([0, x]) = c_p \Pi([pt])([0, x/g_p])$ (recall that $\Pi(n)$ is a measure). The process Π_p will be seen as a path-valued process, see Section 2.5 for more details and in particular for the topology considered.

Theorem A. Under Assumptions G, C1 and C2 and the above scaling, the sequence (Π_p, \mathscr{V}_p) is tight. Moreover, let $(\Pi_\infty, \mathscr{V}_\infty)$ be any accumulation point and for $t \geq 0$ define $\mathbb{H}_{\infty}(t)=|\Pi_{\infty}(t)|$, $\mathbb{C}_{\infty}^{\star}(t)=\mathbb{H}_{\infty}\circ\mathscr{V}_{\infty}^{-1}(t)$ and $\mathscr{X}_{\infty}(t)=t-\mathscr{V}_{\infty}(\mathscr{V}_{\infty}^{-1}(t)-).$ Then:

- 1. Π_{∞} is almost surely continuous, and \mathcal{V}_{∞} is a subordinator with Laplace exponent λ^{α} ;
- 2. for every $t \geq 0$, $\mathbb{H}_{\infty}(t)$ and $\mathbb{C}_{\infty}^{\star}(t)$ are almost surely finite and strictly positive;
- 3. if $(\Pi_p, \mathscr{V}_p) \Rightarrow (\Pi_\infty, \mathscr{V}_\infty)$ along a subsequence, then for any finite set $I \subset \mathbb{R}_+$ we have

$$
\left(\Pi_p, \mathscr{V}_p, (\mathbb{H}_p(t))_{t \in I}, (\mathbb{C}_p^*(t))_{t \in I}, \mathscr{X}_p\right) \Rightarrow \left(\Pi_\infty, \mathscr{V}_\infty, (\mathbb{H}_\infty(t))_{t \in I}, (\mathbb{C}_\infty^*(t))_{t \in I}, \mathscr{X}_\infty\right) \tag{1.2}
$$

along the same subsequence.

In the Galton–Watson case, it is well-known that the height and contour processes are related by a deterministic time change [9] (as is suggested by the above result and was shown in [25], this continues to hold as soon as V^* has finite mean). The convergence (1.2) thus states that a similar result holds for general CMJ's, where the first coordinate of the contour is obtained by a time change of H_{∞} expressed in terms of a subordinator \mathscr{V}_{∞} .

1.4 The Bellman–Harris case

In the Bellman–Harris case, an individual gives birth at her death and the number of children is independent from the life length, i.e., $\mathscr{P}_u = \xi_u \epsilon_{V_u}$ and ξ_u an integervalued random variable independent from V_u . Bellman–Harris branching processes have received considerable attention in the literature, in part owing to the fact that they are the simplest tractable non-Markovian branching processes.

The chronological tree corresponding to a Bellman–Harris process can be obtained by putting i.i.d. marks (distributed as V^*) on the edges of the corresponding genealogical tree, that can be seen as stretching factors. From this viewpoint, these trees are particular cases of branching random walks which are obtained in a similar manner but without the positivity constraint on the marks.

Upon normalization, it is known since Aldous [2], see also [9, 11, 21], that the genealogical tree converges to a random tree called Lévy tree (the famous Brownian continuous random tree in the case of offspring distribution with finite variance).

Given the above relation between the chronological and genealogical trees in the Bellman–Harris case, in this case it is natural to expect the CMJ tree to converge toward a random tree obtained by marking the limiting genealogical Lévy tree and then using these marks to stretch the corresponding portion of the tree. This intuition has been carried out for branching random walks with finite variance offspring distribution by Marckert and Mokkadem [22], see also [12, 14]. Formally, the height process of the limiting tree is then described as the terminal value of a Brownian snake.

1.5 Main result: the Bellman–Harris universality class

Our second main result is a generalization of the above picture for a much wider class of CMJ forests. In the Bellman–Harris case, the Brownian snake arises because of the independence between V^* and $|\mathscr{P}^*|$, i.e., between the chronological and genealogical structures. In this paper we identify general asymptotic independence conditions ((IC1) and (IC2) below) under which the limiting height process is, as in the Bellman–Harris case, the terminal value of a snake.

1.5.1 The $\lambda^{\gamma}/\lambda^{\beta}$ snake

As in [12, 14, 22] this snake is a Brownian snake in the case of finite variance offspring distribution but in the case $\gamma \in (1, 2)$, it will be a snake whose lifelength process is the height process associated with the Lévy process with Laplace exponent λ^γ and whose spatial displacement is given by a subordinator with Laplace exponent λ^β : this snake will be called the $\lambda^\gamma/\lambda^\beta$ -snake, see Section 2.5 and [9] for more details.

Informally, this object is the continuum counterpart of the description of the Bellman– Harris forests spelled out in the last paragraph of Section 1.4. It can be generated by considering a γ -stable Lévy tree, which encodes the genealogy, and by marking the tree according to a Poisson point process with intensity measure $\mathrm{d}\lambda\times\mathbbm{1}$ $(x>0)\,x^{-\beta}\mathrm{d}x$ where λ denotes the branch-length measure on the real tree [10]. In particular, the first coordinate of each point of the Poisson point process is a location in the tree, whereas the second coordinate is a positive real number interpreted as a mark (or stretching factor in the spirit of the previous section). The spine process $\Pi_{\infty}(t)$ associated with the snake is then obtained by considering the marks lying along the ancestral line associated with the point t . See Section 2.5 for a definition.

1.5.2 The Bellman–Harris universality class

The conditions that generalize the independence condition in the Bellman–Harris case are:

$$
\mathbb{P}\left(c_p R(1) \ge \varepsilon \mid T(1) \ge \delta p\right) \to 0 \quad \text{for every} \quad \varepsilon, \delta > 0 \tag{IC1}
$$

and

$$
\mathbb{P}\left(|\mathscr{P}^*| \geq \varepsilon p g_p \mid v_p V^* \geq \delta\right) \to 0 \text{ for every } \varepsilon, \delta > 0. \tag{IC2}
$$

In the Bellman–Harris case the independence structure implies that

$$
\mathbb{P}\left(c_p R(1) \ge \varepsilon \mid T(1) \ge \delta p\right) = \mathbb{P}\left(c_p R(1) \ge \varepsilon\right)
$$

and

$$
\mathbb{P}\left(|\mathscr{P}^*| \ge \varepsilon p g_p \mid v_p V^* \ge \delta\right) = \mathbb{P}\left(|\mathscr{P}^*| \ge \varepsilon p g_p\right)
$$

so that (IC1) and (IC2) are indeed satisfied as $c_p \to 0$ while $pg_p \to \infty$.

Theorem B. If Assumptions G, C1 and C2 are satisfied and the asymptotic independence condition (IC1) holds, then $\Pi_p \Rightarrow \Pi_\infty$ where Π_∞ is the $\lambda^\gamma/\lambda^\beta$ snake. In particular, \mathbb{H}_p has the same scaling limit than the scaled height process of a well-chosen Bellman–Harris forest.

Combining Theorems A and B, we see that when G, C1, C2 and (IC1) hold, then (Π_p, \mathscr{V}_p) is tight and the marginals of any accumulation point $(\Pi_\infty, \mathscr{V}_\infty)$ are specified: Π_∞ is the $\lambda^\gamma/\lambda^\beta$ -snake and \mathscr{V}_∞ is a subordinator with Laplace exponent λ^α . As $\mathbb{H}_\infty(t)=$ $|\Pi_{\infty}(t)|$ this is enough to describe the law of \mathbb{H}_{∞} (which by Theorem A is the scaling limit of \mathbb{H}_p) but since $\mathbb{C}_{\infty}^{\star}=\mathbb{H}_{\infty}\circ\mathscr{V}_{\infty}^{-1}$ one needs to specify the correlation structure between Π_∞ and \mathscr{V}_∞ in order to determine the scaling limit of $\mathbb{C}_p^\star.$ Our next main result shows that if in addition (IC2) holds, then \mathbb{H}_{∞} and \mathscr{V}_{∞} are independent, thereby implying the finite-dimensional convergence of $(\mathbb{H}_p, \mathbb{C}_p^{\star})$ (and thus of $(\mathbb{H}_p, \mathbb{C}_p^{\star}, \mathscr{X}_p)$).

Theorem C. If Assumptions G, C1 and C2 are satisfied and the asymptotic independence conditions (IC1) and (IC2) hold, then \mathcal{V}_{∞} is independent of Π_{∞} . Moreover, in this case we have $c_p/v_p \to \infty$.

Under the assumptions of Theorem C, we therefore have $(\mathbb{C}_p^*, \mathscr{X}_p) \stackrel{\text{fdd}}{\Rightarrow} (\mathbb{C}_\infty^*, \mathscr{X}_\infty).$ This convergence suggests that asymptotically, the chronological contour process C can be seen as a nice, baseline process $\mathbb{H}_\infty\circ \mathscr{V}_\infty^{-1}$ on the space scale $1/c_p$, to which long "hairs" of the order $v_p \gg 1/c_p$ are grafted. Such a behavior was first established for Bellman–Harris processes in [26] and then in a more precise form for branching random walks [14, Theorem 5].

1.6 Explicit examples

We now describe two large classes of models where the above assumptions are satisfied. The first class consists of CMJ forests with finite variance offspring distribution. We find it quite striking that such a simple condition, without any assumption on how atoms of \mathscr{P}^* are spread, implies that the corresponding CMJ forests belong to the Bellman–Harris universality class.

Theorem D. If Assumptions G, C1 and C2 are satisfied with $\mathbb{E}(|\mathscr{P}^*|^2)<\infty$, then (IC1) and (IC2) hold. In particular, the limiting spine process is a $\lambda^2/\lambda^{\beta}$ snake and the time-change \mathcal{V}_{∞} is an independent subordinator with Laplace exponent λ^{α} .

The second class is a natural extension of the Bellman–Harris case, and allows $|\mathscr{P}^*|$ to have infinite variance.

Theorem E. Assume that:

- Assumptions G and C2 are satisfied with V^* and $|\mathscr{P}^*|$ independent;
- conditionally on $(V^*, |\mathscr{P}^*|) = (v, n)$, the locations of the atoms of \mathscr{P}^* are i.i.d. with common distribution vX for some random variable $X \in (0,1]$.

Then Assumption C1 is satisfied with $\beta = \alpha$ and (IC1) and (IC2) hold. In particular, Π_{∞} is the $\lambda^\gamma/\lambda^\alpha$ -snake and the time-change \mathscr{V}_∞ is an independent subordinator with Laplace exponent λ^{α} .

Note that this result generalizes results for Bellman–Harris processes which correspond to the case $X = 1$.

1.7 Beyond the Galton–Watson and Bellman–Harris universality classes

As presented above, our main results assume that $R(1)$ and V^* have infinite first moment. When both $R(1)$ and V^* have finite first moment, all the edges are "short" and the CMJ forest is close to its genealogical counterpart: in other words, the time structure does not matter much. This case of "short edges" has been worked out in [25]. The main result is that CMJ forests with $\mathbb{E}(R(1))<\infty$ and $\mathbb{E}(V^*)<\infty$ belong to the universality class of Galton–Watson processes and that in the limit, the chronological height and contour processes are related through a deterministic time-change.

Beyond the Galton–Watson and Bellman–Harris universality classes treated in [25] and in the present paper, there remains a large class of CMJ forests with "long" edges but where the chronological and genealogical structures remain dependent in the limit (i.e., (IC1) or (IC2) does not hold). In current work in progress, we are looking at the case where \mathscr{P}^* conditionally on V^* is a renewal process stopped at V^* : the chronology and the genealogy then remain positively correlated. Whether or not even more general results can be obtained in this dependent setting is an interesting research direction.

1.8 Comments on the contour process

There are various definitions of the contour process in the literature. In every case, the value of the contour is defined as the distance to the root of an exploration particle, but various choices have been made for the speed at which this particle explores the tree.

For discrete trees and in [25], the particle is assumed to travel at unit speed along the edges of the forest, in such a way that each point of the tree is visited twice.

Alternatively, Lambert proposed in [17] the Jumping Chronological Contour Process where the particle travels at infinite speed when going upward and at speed one when going downward. In the binary, homogeneous case where \mathscr{P}^* is an independent Poisson process stopped at V^* , this contour process has the desirable property of being a Lévy process. This property has far-reaching implications which allow for a detailed study of this important class of CMJ processes, see for instance [5, 6, 7, 18, 19, 23, 24].

In the present paper, analogously to [8] we make the exploration particle move at infinite speed when going downward, and at unit speed when going upward, see Figure 4. We believe that this is a good choice as far as scaling limits are concerned because of the relations (1.1). In [25], we defined the contour process in the "classical way", i.e., when the exploration particle moves at constant speed. This definition led to a significant number of technical problems due to the absence of tightness of the contour in the Skorohod topology. Our choice of contour function allows to circumvent these problems and we believe that it has potential for broader applications.

2 Notation and set-up

2.1 Notation

We gather here the notation used in the rest of the paper. Let $\mathbb Z$ denote the set of integers, $\mathbb{N} = \mathbb{Z} \cap \mathbb{R}_+$ the set of non-negative integers and Q the set of rational numbers. For $x, y \in \mathbb{R}$ let $[x] = \max\{n \in \mathbb{Z} : n \leq x\}$, $x^+ = \max(x, 0)$ and $x \wedge y = \min(x, y)$. Throughout we adopt the convention max $\emptyset = \sup \emptyset = -\infty$ and $\min \emptyset = \inf \emptyset = \infty$.

2.1.1 Functions

The set of càdlàg functions is endowed with the Skorohod topology. For a càdlàg function $f : \mathbb{R} \to \mathbb{R}$ we denote by $f(x-)$ its left-limit at $x \in \mathbb{R}$, by $\Delta f(x) = f(x) - f(x-)$ the size of its jump and by f^{-1} its right-continuous inverse:

$$
f^{-1}(t) = \inf \{ s \ge 0 : f(s) > t \}, t \in \mathbb{R}.
$$

For any $h \geq 0$ and any two mappings f, g defined on \mathbb{R}_+ or a subset thereof (such that f is at least defined on $[0, h]$) we define $[f, g]_h$ by

$$
[f,g]_h(x) = \begin{cases} f(x) & \text{if } x \le h, \\ f(h) + g(x-h) & \text{if } x > h. \end{cases}
$$
 (2.1)

For $h \in \mathbb{R}$ we consider Θ_h , $\cdot \big|_h$ and $\cdot \big|_h$ the shift and stopping operators, which act on functions $f : \mathbb{R} \to \mathbb{R}$ by

$$
\Theta_h(f)(x) = \begin{cases} f(x+h) - f(h) & \text{if } x > 0, \\ 0 & \text{if } x \le 0, \end{cases}
$$

and

$$
f|_h(x) = f(x \wedge h) \quad \text{and} \quad f|_{h-}(x) = f|_h(x) - \Delta f(h) \mathbb{1}(x \ge h) = \begin{cases} f(x) & \text{if } x < h, \\ f(h-) & \text{if } x \ge h. \end{cases}
$$

Note in particular that $\Theta_h(f)(0) = 0$, $f \mid_h (h) = f(h)$ and $f \mid_{h-} (h) = f(h-)$.

2.1.2 Measures

We let M be the set of positive Radon measures on $[0, \infty)$ endowed with the weak topology, $\epsilon_x \in \mathcal{M}$ for $x > 0$ be the Dirac measure at x and z be the zero measure. We will identify any measure $\nu \in \mathcal{M}$ with the càdlàg, non-decreasing function $x \in \mathbb{R} \mapsto \nu[0, x^+] \in$ \mathbb{R}_+ which gives sense to $\Theta_h(\nu)$, $\nu\mid_h \nu\mid_{h-}$ and $[\nu, \nu']_h$ for $\nu, \nu'\in\mathscr{M}$ and $h\in\mathbb{R}$, e.g.,

$$
\Theta_h(\nu)(x)=\nu\left((h,x+h]\cap\mathbb{R}_+\right),\ \nu\mid_h(x)=\nu\big([0,h]\cap[0,x]\big)\ \ \text{and}\ \ [\nu,\nu']_h\ =\ \nu\mid_h+\Theta_{-h}(\nu')
$$

for $x \geq 0$. We will also write

$$
[\nu, \nu']_{h-} \; = \; \nu \mid_{h-} + \Theta_{-h}(\nu')
$$

so that $[\nu, \nu']_h = [\nu, \nu']_{h-} + \nu(\lbrace h \rbrace) \epsilon_h$. Note also that we have $\nu = [\nu, \Theta_h(\nu)]_h$.

The mass of $\nu \in \mathcal{M}$ will be denoted by $|\nu| = \nu[0, \infty)$ and the supremum of its support by $\pi(\nu) = \inf\{x \geq 0 : \pi(x,\infty) = 0\}$ with the convention $\pi(\mathbf{z}) = 0$. When $|\nu|$ and $\pi(\nu)$ are finite we consider the reversed measure $\mathscr{L}(\nu)$ defined by

$$
\mathscr{L}(\nu)(x) = \nu[\pi(\nu) - x, \pi(\nu)] = |\nu| - \nu[0, \pi(\nu) - x), \ x \ge 0.
$$

If $\nu \in \mathscr{M}$ is of the form $\nu = \sum_{i=1}^{|\nu|} \epsilon_{a(i)}$ with $0 \leq a(1) \leq \cdots \leq a(|\nu|)$ and if $k \in$ $\{0,\ldots,|\nu|-1\}$, we will write $A_k(\nu)=a(k+1)$ for the position of the $(k+1)$ st atom of ν where atoms are ranked from bottom to top.

In the following we need continuity properties of some of the above operators. The following lemma gathers the required results, which can be proved using standard results of the Skorohod topology, see for instance [13].

Lemma 2.1. If $f_p \to f$, $t_p \to t$ and either $\Delta f_p(t_p) \to \Delta f(t)$ or $\Delta f(t) = 0$, then $f_p |_{t_p} \to f |_{t_p}$ $f_p \mid_{t_p} \to f \mid_{t-}$ and $\Theta_{t_p}(f_p) \to \Theta_t(f)$.

If $\nu_p\to\nu$ with $\pi(\nu)=\infty$, $h_p\to h$ and ν has no atom at h , then $\mathscr{L}(\nu_p\mid_{h_p})\to\mathscr{L}(\nu\mid_h)$ as well as $\mathscr{L}(\nu_p \mid_{h_p-}) \to \mathscr{L}(\nu \mid_h).$

2.1.3 Random variables

Let

$$
\mathbb{L} = \{ (v, \nu) \in (0, \infty) \times \mathscr{M} : \nu\{0\} = 0 \text{ and } v \ge \pi(\nu) \}.
$$

We will start from discrete processes defined on the measurable space (Ω, \mathscr{F}) with $\Omega=\mathbb{L}^{\mathbb{Z}}$ the space of doubly infinite sequences of sticks and \mathscr{F} the σ -algebra generated by the coordinate mappings. An elementary event $\omega \in \Omega$ is written as $\omega = (\omega_n, n \in \mathbb{Z})$ and $\omega_n = (V_n, \mathscr{P}_n)$. For $n \in \mathbb{Z}$ we consider the operators $\theta_n, \vartheta^n : \Omega \to \Omega$ defined as follows:

- θ_n is the shift operator, defined by $\theta_n(\omega) = (\omega_{n+k}, k \in \mathbb{Z})$;
- ϑ^n is the dual (or time-reversal) operator, defined by $\vartheta^n(\omega) = (\omega_{n-k-1}, k \in \mathbb{Z})$.

When no confusion can arise we will use the notation $W^n = W \circ \theta_n$ and $\hat{W}^n = W \circ \vartheta^n$ for any random variable W defined on Ω .

We define $\sigma(X)$ as the σ -algebra generated by the random variable X, $\mathscr{F}_{\geq \Gamma}$ = $\sigma(\omega_k, k \geq \Gamma)$ and $\mathscr{F}_{\leq \Gamma} = \sigma(\omega_k, k \leq \Gamma)$ for any random time $\Gamma : \Omega \to \mathbb{N}$, and $m\mathscr{F}$ the set of random variables that are measurable with respect to the σ -algebra $\mathscr F$. For random variables X, Y we will write $X \perp Y$ to mean that they are independent.

2.2 Lukasiewicz path and ladder process

In this section, we introduce an important trivariate renewal process (\mathscr{Z}, T, R) : (\mathscr{Z}, T) is the usual ladder process of the Lukasiewicz path, and R adds chronological information. We define the Lukasiewicz path $S = (S(n), n \in \mathbb{Z})$ by $S(0) = 0$ and, for $n > 1$,

$$
S(n) = \sum_{k=0}^{n-1} (|\mathcal{P}_k| - 1) \text{ and } S(-n) = -\sum_{k=-n}^{-1} (|\mathcal{P}_k| - 1).
$$

Define the ladder time process $T = (T(k), k \in \mathbb{N})$ by $T(0) = 0$ and for $k \geq 0$,

$$
T(k+1) = \inf \{ \ell > T(k) : S(\ell) \ge S(T(k)) \} = T(1) \circ \theta_{T(k)} + T(k)
$$

with the convention $T(k + 1) = \infty$ if $T(k) = \infty$. We identify T and the function $x \in \mathbb{R}_+ \mapsto$ $T([x])$, and thus also with the measure $\sum_{k\in \mathbb{N}}(T(k+1)-T(k))\epsilon_{k+1}.$ We consider the following two inverses of T :

$$
T^{-1}(n) = \min\left\{k \ge 0 : T(k) \ge n\right\} \text{ and } \tilde{T}^{-1}(n) = \max\left\{k \ge 0 : T(k) \le n\right\}.
$$

Note that $T^{-1}(n) = \tilde{T}^{-1}(n)$ if n is a weak record time and $T^{-1}(n) = \tilde{T}^{-1}(n) + 1$ otherwise. Moreover, it is well-known that in the Galton–Watson case, the height process at time n is related to the renewal process T through the relation $\mathscr{H}(n) = \tilde{T}^{-1}(n) \circ \vartheta^n.$

Consider the ladder height process \mathscr{L} , defined (as a measure) by

$$
\mathscr{Z}(\{k\}) = S(T(1)) \circ \theta_{T(k-1)}
$$

for $k > 1$ with $T(k-1) < \infty$. In words, $\mathscr{L}(\{k\})$ is the value of the kth overshoot of S. We can now define the process R that contains the useful chronological information (recall that $A_k(\nu)$ denotes the position of the $(k+1)$ st atom of ν):

$$
R = \sum_{k \in \mathbb{N}^* : T(k) < \infty} A_{\mathscr{Z}(\{k\})}(\mathscr{P}_{T(k)-1}) \epsilon_k.
$$

As we shall see in Theorem 2.2 below, $\hat{R}^n = R \circ \vartheta^n$ makes it possible to recover the chronological contribution of the successive ancestors of n to its chronological height.

The strong Markov property implies that (T, \mathcal{Z}, R) is a trivariate renewal process. With the notation of the present paper, the equation below (2.18) in [25] states that

$$
\mathbb{E}\big[F\big(\mathscr{P}_{T(1)-1}, -S(T(1)-1), T(1)\big)\big] = \sum_{t\geq 1, x\geq 0} \mathbb{E}\left(F(\mathscr{P}^*, x, t); |\mathscr{P}^*| \geq x+1\right) \mathbb{P}\left(\tau_x^- = t\right)
$$
\n(2.2)

with $\tau_x^- = \inf\{n \ge 0 : S(n) = -x\}$, from which we deduce that for any $G : \mathbb{N} \times \mathbb{N} \times \mathbb{R}_+ \to$ \mathbb{R}_+ measurable, we have

$$
\mathbb{E}\big[G(T(1),\mathscr{Z}(1),R(1))\big] = \sum_{t,x\geq 1} \sum_{z\geq 0} \mathbb{E}\left[G(t,z,A_z(\mathscr{P}^*));|\mathscr{P}^*|=x+z\right] \mathbb{P}\left(\tau_{x-1}^- = t-1\right).
$$
\n(2.3)

2.3 Spine process

The spine process was introduced in [25] as an extension of the classical exploration process [20] suited for the chronological setting. Here, we only need a marginal of this process, denoted $\Pi = (\Pi(n), n \ge 0)$, which for simplicity we continue to name spine process. For each $n \geq 0$, $\Pi(n) \in \mathcal{M}$ is the random measure defined by

$$
\Pi(n) = \sum_{i=1}^{\mathcal{H}(n)} \hat{R}^n(\{i\}) \epsilon_{\mathcal{H}(n)-i} = \left(\sum_{i=1}^{\widetilde{T}^{-1}(n)} R(\{i\}) \epsilon_{\widetilde{T}^{-1}(n)-i}\right) \circ \vartheta^n.
$$
 (2.4)

2.4 Joint distribution

One of the main result of [25] is to relate the height process H as well as the spine process Π to the bivariate renewal process (T, R) . Namely, with the notation of the present paper, Theorem 1.1 and Proposition 2.4 of [25] can be formulated as follows.

Theorem 2.2. For any $n > 0$ we have

$$
\mathbb{H}(n) = \left(R \circ \widetilde{T}^{-1}(n)\right) \circ \vartheta^n, \ \mathscr{H}(n) = \widetilde{T}^{-1}(n) \circ \vartheta^n \ \text{ and } \ \Pi(n) = \mathscr{L}\left(R \mid_{\widetilde{T}^{-1}(n)}\right) \circ \vartheta^n. \tag{2.5}
$$

In particular, $\mathbb{H}(n)$ can be recovered by summing up the weights carried by the atoms of the measure $\Pi(n)$, i.e.,

$$
\mathbb{H}(n) = |\Pi(n)| = \Pi(n)(\mathcal{H}(n) -) = \sum_{i=1}^{\mathcal{H}(n)} \hat{R}^n(\{i\}) = \hat{R}^n(\mathcal{H}(n)).
$$

2.5 The ψ/ϕ -snake

Let ψ with $\int_{0}^{\infty} d u/\psi(u) < \infty$ be the Laplace exponent of a spectrally positive Lévy process with infinite variation that does not drift to $+\infty$. We call ψ -height process the height process associated with the Lévy process with Laplace exponent ψ and ψ/ϕ snake the Lévy snake whose life-time process is the ψ -height process and whose spatial displacement is the Lévy process with Laplace exponent ϕ , see Duquesne and Le Gall [9].

The ψ -height process encodes the genealogy of the forest. As explained in the introduction, the scaling limit of the chronological forest will be obtained by marking the genealogy where the marks correspond to random stretching, which is exactly the interpretation of the ψ/ϕ -snake when ϕ is the Lévy exponent of a subordinator as will be the case here.

Let a killed path be a càdlàg mapping $w : [0, \zeta) \to \mathbb{R}$ with $\zeta \in (0, \infty)$ called the life-time of the path and $\mathscr W$ be the set of killed paths, which is the state-space of the ψ/ϕ -snake.

Whenever it exists in $\mathbb{R} \cup \{\pm \infty\}$, we call terminal value of a killed path the value of $w(\zeta-)$. For two killed paths $w, w' \in \mathscr{W}$ with respective life times ζ and ζ' , we consider the distance

$$
d(w, w') = |\zeta - \zeta'| + \int_0^{\zeta \wedge \zeta'} d(u) (w_{\le u}, w'_{\le u}) \wedge 1 \, du,
$$
\n(2.6)

where $w_{\leq u}$ is the restriction of the path w to $[0, u]$ and $d_{(u)}(f, g)$ denotes the Skorohod distance on the set of real-valued, càdlàg functions defined on $[0, u]$. As mentioned in [1], (\mathscr{W}, d) is a Polish space. We will use the following characterization of the ψ/ϕ -snake.

Theorem 2.3. The ψ/ϕ -snake is the unique *W*-valued continuous process $(W(t), t \ge 0)$ satisfying the two following properties:

- (1) the life-time process H is the ψ -height process;
- (2) conditionally on H, $(W(t), t \ge 0)$ is the *W*-valued time-inhomogeneous Markov process with the following transition mechanism. For every $0 \leq s \leq t$,

$$
W(t) = \left[W(s), \tilde{W}\right]_{\min_{[s,t]} H} \text{ in law}
$$
\n(2.7)

where \tilde{W} is a Lévy process independent from $W(s)$ with Laplace exponent ϕ and killed at $H(t) - \min_{[s,t]} H$.

2.6 Triangular setting

Recall that the main results announced in the introduction are stated in a nontriangular setting. In the following, we consider a triangular setting where \mathbb{P}_p is the law under which the common law of the (V_k, \mathscr{P}_k) is equal to $(V_p^*, \mathscr{P}_p^*).$ When considering convergence, we are then implicitly working under \mathbb{P}_p , that is, $X_p \Rightarrow X_\infty$ means that $\mathbb{E}_p(f(X_p)) \to \mathbb{E}(f(X_\infty))$ for every bounded continuous function $f.$ Likewise, $\stackrel{\text{fdd}}{\Rightarrow}$ refers to convergence of the finite-dimensional distributions under \mathbb{P}_p .

3 General tightness result

3.1 Scaling

As in the introduction, we consider throughout three vanishing scaling sequences (q_p) , (c_p) and (v_p) used to scale the genealogical and chronological processes as follows:

$$
\mathscr{H}_p(t) = g_p \mathscr{H}([pt]) \text{ and } S_p(t) = \frac{1}{pg_p} S([pt]),
$$

$$
\mathbb{C}_p = (\mathbb{C}_p^\star, \mathscr{X}_p) \text{ with } \mathbb{C}_p^\star(t) = c_p \mathbb{C}^\star(pt) \text{ and } \mathscr{X}_p(t) = v_p \mathscr{X}_p(pt),
$$

and

$$
\mathbb{H}_p(t)=c_p\mathbb{H}([pt]),\; \Pi_p(t)(x)=c_p\Pi([pt])(x/g_p)\;\;\text{and}\;\;\mathscr{V}_p(t)=v_p\mathscr{V}([pt])
$$

with as before $\mathcal{V}(n) = V_0 + \cdots + V_n$ for $n \geq 0$. In the sequel, we will consider Π_p as a W -valued process since the definition (2.4) of $\Pi(n)$ implies $\Pi_p(t)/\mathscr{H}_p(t), \infty) = 0$ and thus allows to identify $\Pi_p(t)$ with the killed path $x \in [0, \mathcal{H}_p(t)) \mapsto \Pi_p(t)[0, x]$. Scale in addition the processes T, R and $\mathscr Z$ as

$$
T_p(x)=\frac{1}{p}T(x/g_p),\;R_p(x)=c_pR(x/g_p)\;\textrm{and}\; \mathscr{Z}_p(x)=\frac{1}{pg_p}\mathscr{Z}(x/g_p),\;x\geq 0,
$$

and finally define the dual and shifted versions of T_p , R_p and \mathscr{Z}_p as follows:

$$
\hat{T}_p^t = T_p \circ \vartheta^{[pt]}, \ \hat{R}_p^t = R_p \circ \vartheta^{[pt]} \ \text{ and } \hat{\mathscr{Z}}_p^t = \hat{\mathscr{Z}}_p \circ \vartheta^{[pt]} \tag{3.1}
$$

and

$$
T_p^t = T_p \circ \theta_{[pt]}, \ R_p^t = R_p \circ \theta_{[pt]} \text{ and } \mathscr{Z}_p^t = \mathscr{Z}_p \circ \theta_{[pt]}.
$$
 (3.2)

Note that with these definitions, Theorem 2.2 gives

$$
\mathbb{H}_p(t)=|\Pi_p(t)|=\Pi_p(t)\big(\mathscr{H}_p(t)-\big) \ \ \text{and} \ \ \Pi_p(t)=\mathscr{L}\big(\hat{R}^t_p\mid_{\mathscr{H}_p(t)}\big).
$$

3.2 Main assumptions and general tightness result

Throughout the paper, we consider a double-sided Lévy process $S_{\infty} = (S_{\infty}(t), t \in \mathbb{R})$ of infinite variation, which is spectrally positive and does not drift to $+\infty$ as $t \to +\infty$. We denote by ψ its Laplace exponent which is assumed to satisfy

$$
\int_1^\infty \frac{\mathrm{d} u}{\psi(u)} < \infty.
$$

We let T_∞ denote the ladder time process of $(S_\infty(t), t \ge 0)$ and $\mathscr{Z}_\infty = S_\infty \circ T_\infty$ denote its ladder height process. We also consider \mathcal{H}_{∞} its associated height process which is therefore the ψ -height process.

Duquesne and Le Gall [9] proved that the following assumption implies the joint convergence of the Lukasiewicz path together with the genealogical height and contour processes. Proposition 3.1 below states a slight extension of this result needed for our purposes. Note that the condition on Z_p below is automatically satisfied in the non-triangular case.

Assumption G'. We say that Assumption G' holds if $S_p \Rightarrow S_\infty$ with S_∞ introduced above, and if for every $\delta > 0$ we have

$$
\liminf_{p \to \infty} \; \mathbb{P}\left(Z_p([\delta/g_p]) = 0\right) > 0
$$

where $(Z_p(k), k \ge 0)$ is a Galton–Watson process with offspring distribution $|\mathscr{P}_p^*|$ and started with $[pq_p]$ individuals.

Note that Assumption G' implies that $pg_p \to \infty$. In addition to the genealogical Assumption G', we will need the next chronological assumptions.

Assumption C1'. We say that Assumption C1' holds if $R_p \Rightarrow R_\infty$ with R_∞ a nondegenerate subordinator. In this case, its Laplace exponent is denoted by ϕ .

Assumption C2'. We say that Assumption C2' holds if $\mathcal{V}_p \Rightarrow \mathcal{V}_{\infty}$ with \mathcal{V}_{∞} a nondegenerate subordinator.

Theorem A' (Triangular version of Theorem A)**.** Under Assumptions G', C1' and C2', the sequence (Π_p, \mathcal{V}_p) is tight. Moreover, let $(\Pi_\infty, \mathcal{V}_\infty)$ be any accumulation point and for $t \geq 0$ define $\mathbb{H}_{\infty}(t) = |\Pi_{\infty}(t)|$, $\mathbb{C}_{\infty}^{\star}(t) = \mathbb{H}_{\infty} \circ \mathscr{V}_{\infty}^{-1}(t)$ and $\mathscr{X}_{\infty}(t) = t - \mathscr{V}_{\infty}(\mathscr{V}_{\infty}^{-1}(t)-)$. Then:

- 1. Π_{∞} is almost surely continuous:
- 2. for every $t \geq 0$, $\mathbb{H}_{\infty}(t)$ and $\mathbb{C}_{\infty}^{\star}(t)$ are almost surely finite and strictly positive;
- 3. if $(\Pi_p, \mathscr{V}_p) \Rightarrow (\Pi_\infty, \mathscr{V}_\infty)$ along a subsequence, then for any finite set $I \subset \mathbb{R}_+$ we have

$$
\left(\Pi_p, \mathscr{V}_p, (\mathbb{H}_p(t))_{t \in I}, (\mathbb{C}_p^*(t))_{t \in I}, \mathscr{X}_p\right) \Rightarrow (\Pi_\infty, \mathscr{V}_\infty, (\mathbb{H}_\infty(t))_{t \in I}, (\mathbb{C}_\infty^*(t))_{t \in I}, \mathscr{X}_\infty)
$$
(1.2)

along the same subsequence.

The proof of Theorem A' relies on genealogical results which we establish first.

3.3 Genealogical convergence

For every $t \in \mathbb{R}$, define $S^t_{\infty} = \Theta_t(S_{\infty})$ the shifted version of S_{∞} at time t , i.e.,

$$
S^t_\infty(u) = S_\infty(t+u) - S_\infty(t), \ u \ge 0,
$$

and \hat{S}^t_∞ the dual path of S_∞ at time t as

$$
\hat{S}^t_\infty(u) = S_\infty(t) - S_\infty(t - u), \ u \ge 0.
$$

For every random variable W that can be written as a measurable function of S_{∞} , \hat{W}^t or $W\circ \vartheta^t$ will refer to the same functional applied to \hat{S}^t_∞ and W^t or $W\circ \theta_t$ will refer to the same functional applied to $S_\infty^t.$ This gives for instance sense to $\hat T_\infty^t, \hat {\mathscr{Z}}_\infty^t$, T_∞^t and \mathscr{Z}_∞^t that will appear repeatedly, and is coherent with the notation introduced in (3.1) and (3.2) .

An important relation, which follows from the definition of the height process, is that for every $t\geq 0$ we have $\mathscr{H}_\infty(t)=(\hat{T}_\infty^t)^{-1}(t)$ almost surely. Note that this is the continuous analog of the relation $\mathscr{H}(n) = T^{-1}(n) \circ \vartheta^n$ of (2.5). The next result is an extension of a result due to Duquesne and Le Gall [9]

Proposition 3.1. If Assumption G' holds, then

$$
\left(S_p, \mathcal{H}_p, (\hat{\mathscr{L}}_p^{t}, \hat{T}_p^{t}, (\hat{T}_p^{t})^{-1})_{t \in \mathbb{Q}}\right) \Rightarrow \left(S_\infty, \mathcal{H}_\infty, (\hat{\mathscr{L}}_\infty^{t}, \hat{T}_\infty^{t}, (\hat{T}_\infty^{t})^{-1})_{t \in \mathbb{Q}}\right).
$$
 (3.3)

Proof. Throughout the proof, we repeatedly use the following token in order to get joint convergence results: if $(X_p, Y_p) \Rightarrow (X_\infty, Y_\infty)$ and $(X_p, Z_p) \Rightarrow (X_\infty, Z_\infty)$ with Y_∞ and Z_∞ measurable functions of X_{∞} , then $(X_p, Y_p, Z_p) \Rightarrow (X_{\infty}, Y_{\infty}, Z_{\infty})$. This comes from the continuous mapping theorem and will be used without further mention.

First, we reduce the proof of (3.3) to the simpler convergence

$$
(S_p, T_p, T_p^{-1}, \mathscr{Z}_p) \Rightarrow (S_\infty, T_\infty, T_\infty^{-1}, \mathscr{Z}_\infty). \tag{3.4}
$$

Indeed, if (3.4) holds, then for each fixed $t \geq 0$ a simple time-reversal argument implies that $(S_p, \hat{T}_p^t, (\hat{T}_p^t)^{-1}, \hat{\mathscr{Z}}_p^t) \Rightarrow (S_\infty, \hat{T}_\infty^t, (\hat{T}_\infty^t)^{-1}, \hat{\mathscr{Z}}_\infty^t)$ and since $(\hat{T}_\infty^t, (\hat{T}_\infty^t)^{-1}, \hat{\mathscr{Z}}_\infty^t)$ is measurable with respect to S_{∞} we obtain the joint convergence for $t \in \mathbb{Q}$. Moreover, Duquesne and Le Gall [9, Corollary 2.5.1] have proved that Assumption G' implies that $(S_p, \mathcal{H}_p) \Rightarrow (S_\infty, \mathcal{H}_\infty)$. Since again \mathcal{H}_∞ is a measurable function of S_∞ , this finally gives the full joint convergence of (3.3). The rest of the proof is therefore devoted to proving (3.4).

The joint convergence of the Lukasiewicz path together with its local time process at its maximum is proved in the proof of Theorem 2.2.1 in [9]: to be precise, the almost sure convergence $\gamma_p^{-1}\Lambda_{[p\gamma_pt]}^{(p)}\to L_t$ stated in Equation (50) of [9] implies with our notation¹ that $(S_p,(T_p^{-1}(t))_{t\in I}) \stackrel{\sim}{\Rightarrow} (S_\infty,(T_\infty^{-1}(t))_{t\in I})$ for every finite set $I\subset \mathbb{R}_+$. Since T_p^{-1} and T_∞^{-1} are non-decreasing and T_∞^{-1} is continuous (as the local time process at 0 of S_{∞} reflected at its maximum), standard properties of the Skorohod topology imply that the finite-dimensional convergence $T_p^{-1} \; \stackrel{\rm fdd}{\Rightarrow} \; T_\infty^{-1}$ actually implies the functional convergence $T_p^{-1} \Rightarrow T_{\infty}^{-1}$, see for instance [13, Theorem VI.2.15]. Thus we obtain $(S_p, T_p^{-1}) \Rightarrow (S_{\infty}, T_{\infty}^{-1}).$

Because T_p for $p\in\mathbb{N}\cup\{\infty\}$ is non-decreasing, we have $(T_p^{-1})^{-1}=T_p$ and so general properties of the inverse map in the Skorohod topology show that the convergence $(S_p, T_p^{-1}) \Rightarrow (S_\infty, T_\infty^{-1})$ implies $(S_p, T_p^{-1}, (T_p(t))_{t \in I}) \Rightarrow (S_\infty, T_\infty^{-1}, (T_\infty(t))_{t \in I})$ for any finite set $I \subset \mathbb{R}_+$, see for instance the remark following Theorem 7.1 in [27]. Since T_p is a random walk, we thus obtain $(S_p, T_p^{-1}, T_p) \Rightarrow (S_\infty, T_\infty^{-1}, T_\infty)$ by [15, Theorem 16.14].

Since T_{∞} is strictly increasing, this convergence implies that

$$
(S_p, T_p^{-1}, T_p, (S_p \circ T_p(t))_{t \in I}) \Rightarrow (S_{\infty}, T_{\infty}^{-1}, T_{\infty}, (S_{\infty} \circ T_{\infty}(t))_{t \in I})
$$

for any finite set $I \subset \mathbb{R}_+$, see for instance [16, Lemma 2.3]. Since $S_p \circ T_p = \mathscr{Z}_p$ for $p \in \mathbb{N} \cup \{\infty\}$ and \mathscr{Z}_p is a random walk, the previous finite-dimensional result can be strengthened to a functional one and so we get the desired result. \Box

3.4 Proof of Theorem A'

We decompose the proof into several steps.

Step 1: proof of tightness and of (1)

By assumption, $\mathcal{V}_p \Rightarrow \mathcal{V}_{\infty}$ and so the proof of this step amounts to showing that (Π_p) is tight (as a W -valued process) and that any accumulation point is continuous.

The measure $\Pi(n)$ describes the ancestral line of the individual n, where the first atoms correspond to the ancestors closest to the root. In particular, we have $\Pi(n)$ $\big|\mathcal{H}(\mu)-1=\Pi(m)\big|\mathcal{H}(\mu)-1$ with μ the most recent common ancestor of m and n, whose height $\mathcal{H}(\mu)$ is given by $\mathcal{H}(\mu) = \min_{\{m,\dots,n\}} \mathcal{H} - \mathbb{1}(\mu \neq m)$. A formal proof

¹To be more precise: γ_p in [9] is the time scale of the Galton–Watson branching proces, i.e., their γ_p is our $1/g_p$; $(L_t, t \ge 0)$ is the local time process at level 0 of the Lévy process reflected at its maximum, i.e., their L_t is our $T_\infty^{-1}(t)$; and their $\Lambda^{(p)}$ is the same at the discrete level, i.e., upon proper scaling, their $\gamma_p^{-1}\Lambda^{(p)}_{[p\gamma_p t]}$ is our $T_p^{-1}(t)$.

of these facts is given in [25]. Upon scaling we thus obtain $\Pi_p(s) |_{h} = \Pi_p(t) |_{h}$ with $h = \min_{[s,t]} \mathcal{H}_p - 2c_p$ and so from the expression (2.6) of the distance d we get that

$$
d\left(\Pi_p(s), \Pi_p(t)\right) \leq |\mathcal{H}_p(t) - \mathcal{H}_p(s)| + \mathcal{H}_p(t) \wedge \mathcal{H}_p(s) - \inf_{[s,t]} \mathcal{H}_p + 2c_p.
$$

Since $\mathcal{H}_p \Rightarrow \mathcal{H}_{\infty}$ with \mathcal{H}_{∞} continuous, the above inequality gives the tightness of (Π_p) and also shows that any accumulation point is almost surely continuous.

Step 2: exchangeability argument

We now present a simple yet crucial exchangeability argument. For $a < b$ let us write $\omega_a^b=(\omega_k,k=[a],\ldots,[b]-1).$ Then for any t,k , exchangeability implies that $\omega_0^k\circ\vartheta^{\mathscr{V}^{-1}(t)}$ conditioned on $\mathscr{V}^{-1}(t) \geq k$ is equal in distribution to ω_0^k conditioned on $\mathscr{V}^{-1}(t) \geq k$. Indeed, consider an arbitrary measurable $\varphi:\mathbb{L}^k\to\mathbb{R}_+ .$ Since

$$
\mathbb{E}_p\left(\varphi(\omega_0^k) \mid \mathscr{V}^{-1}(t) \ge k\right) = \frac{1}{\mathbb{P}_p(\mathscr{V}^{-1}(t) \ge k)} \sum_{\ell \ge k} \mathbb{E}_p\left(\varphi(\omega_0^k); \mathscr{V}^{-1}(t) = \ell\right)
$$

in order to prove this claim it is enough to prove that

$$
\mathbb{E}_p(\varphi(\omega_0^k); \mathscr{V}^{-1}(t) = \ell) = \mathbb{E}_p(\varphi(\omega_0^k) \circ \vartheta^{\ell}; \mathscr{V}^{-1}(t) = \ell)
$$

for every $\ell \geq k$. To see this, write

$$
\mathbb{E}_p\left(\varphi(\omega_0^k); \mathscr{V}^{-1}(t) = \ell\right) = \mathbb{E}_p\left(\varphi(\omega_0^k); \sum_{i=0}^{\ell-1} V_i \le t < \sum_{i=0}^{\ell} V_i\right) = \mathbb{E}_p\left(h(\omega_0, \dots, \omega_\ell)\right)
$$

with

$$
h(\omega_0,\ldots,\omega_\ell)=\varphi(\omega_0^k)\mathbbm{1}\left(t-V_\ell<\sum_{i=0}^{\ell-1}V_i\leq t\right).
$$

Since the ω_k 's are i.i.d., we have

$$
\mathbb{E}_p(h(\omega_0, \dots, \omega_{\ell-1}, \omega_{\ell})) = \mathbb{E}_p(h(\omega_{\ell-1}, \dots, \omega_0, \omega_{\ell}))
$$

=
$$
\mathbb{E}_p\left(\varphi(\omega_{\ell-1}, \dots, \omega_{\ell-k}); \sum_{i=0}^{\ell-1} V_i \le t < \sum_{i=0}^{\ell} V_i\right)
$$

=
$$
\mathbb{E}_p\left(\varphi(\omega_0^k) \circ \vartheta^{\ell}; \mathcal{V}^{-1}(t) = \ell\right)
$$

This exchangeability property will be used in the sequel in the following form: for any measurable mapping $\varphi > 0$ acting on finite sequence of sticks, we have

$$
\mathbb{E}_p\left(\varphi(\omega_0^{\varepsilon p})\circ\vartheta^{p\mathscr{V}_p^{-1}(t)};\mathscr{V}_p^{-1}(t)\geq\varepsilon\right)=\mathbb{E}_p\left(\varphi(\omega_0^{\varepsilon p});\mathscr{V}_p^{-1}(t)\geq\varepsilon\right).
$$
 (3.5)

Step 3: proof of (3) and that $\mathbb{H}_{\infty}(t)$, $\mathbb{C}_{\infty}^{*}(t) < \infty$

Assume without loss of generality that $(\Pi_p, \mathcal{V}_p) \Rightarrow (\Pi_\infty, \mathcal{V}_\infty)$. By definition, the process \mathscr{X}_p increases at rate 1 in time intervals of the form $(\mathscr{V}_p(k/p-), \mathscr{V}_p(k/p))$, $k \in \mathbb{N}$, and jumps to 0 at times $\mathcal{V}_p(k/p)$. From this description and the convergence $\mathcal{V}_p \Rightarrow \mathcal{V}_{\infty}$ it can be proved that $\mathscr{X}_p \Rightarrow \mathscr{X}_{\infty}$ jointly with Π_p and \mathscr{Y}_p . Indeed, if the Lévy measure of \mathscr{V}_{∞} was finite, this would be immediate, and the general case follows by a truncation argument. We thus have $(\Pi_p, \mathcal{V}_p, \mathcal{X}_p) \Rightarrow (\Pi_\infty, \mathcal{V}_\infty, \mathcal{X}_\infty)$ and so in order to prove (3) and that $\mathbb{H}_{\infty}(t)$ and $\mathbb{C}_{\infty}^{\star}(t)$ are almost surely finite, it is enough to prove that

$$
(\Pi_p, \mathscr{V}_p, \mathbb{H}_p(\tau_p)) \Rightarrow (\Pi_\infty, \mathscr{V}_\infty, \mathbb{H}_\infty(\tau_\infty)) \text{ for } \tau_p = t \text{ or } \tau_p = \mathscr{V}_p^{-1}(t), t \ge 0, p \in \mathbb{N} \cup \{\infty\}
$$

with $\mathbb{H}_{\infty}(\tau_{\infty})$ being almost surely finite. We will only show that

$$
\mathbb{H}_p(\tau_p) \Rightarrow \mathbb{H}_\infty(\tau_\infty) \quad \text{with} \quad \mathbb{P}(\mathbb{H}_\infty(\tau_\infty) < \infty) = 1 \tag{3.6}
$$

where either $\tau_p=t$, or $\tau_p=\mathscr{V}_p^{-1}(t)$ ($p\in\mathbb{N}\cup\{\infty\}$, $t>0$). Indeed, the joint convergence with (Π_n, \mathcal{V}_n) relies on the same arguments but is only notationally more cumbersome. In order to show (3.6), we will need the next technical lemma.

Lemma 3.2. Let $t_p \to t_\infty$ in \mathbb{R}_+ , w_p for $p \in \mathbb{N} \cup \{\infty\}$ be a *W*-valued process with $w_p(t)$ non-decreasing for every $t \geq 0$, and ζ_p be the life time of $w_p(t_p)$. If $w_p \to w_{\infty}$, w_{∞} is continuous and

$$
\lim_{c \uparrow \zeta_{\infty}} \lim_{p \to \infty} (w_p(t_p)(\zeta_p -) - w_p(t_p)(c)) = 0 \tag{3.7}
$$

then $w_{\infty}(t_{\infty})(\zeta_{\infty}-)<\infty$ and $w_{n}(t_{n})(\zeta_{n}-)\to w_{\infty}(t_{\infty})(\zeta_{\infty}-).$

Proof. Let $c < \zeta_{\infty}$ with $w_{\infty}(t_{\infty})$ continuous at c: then $w_p(t_p) \to w_{\infty}(t_{\infty})$ in \mathscr{W} (which holds because $w_p \to w_\infty$ with w_∞ continuous) implies $w_p(t_p)(c) \to w_\infty(t_\infty)(c)$ (note that $c < \zeta_p$) for p large enough as $w_p \to w_\infty$ implies $\zeta_p \to \zeta_\infty$). Since $w_\infty(t_\infty)(c) < \infty$, this implies in view of (3.7) that $\limsup_{p\to\infty} w_p(t_p)(\zeta_p-\zeta) \ll \infty$. Next, since $w_p(t_p)(\zeta_p-\zeta) \geq w_p(t_p)(c)$ for p large enough, we obtain

$$
w_{\infty}(t_{\infty})(c) \le \limsup_{p \to \infty} w_p(t_p)(\zeta_p)
$$

and then

$$
w_{\infty}(t_{\infty})(\zeta_{\infty}-) \le \limsup_{p \to \infty} w_{p}(t_{p})(\zeta_{p}-)
$$

by letting $c \uparrow \zeta_{\infty}$ along continuity points. This shows that $w_{\infty}(t_{\infty})(\zeta_{\infty}-)<\infty$ and we now proceed to showing that $w_p(t_p)(\zeta_p-\to w_\infty(t_\infty)(\zeta_\infty-\)$. For $p\in\mathbb{N}\cup\{\infty\}$ and $c<\zeta_\infty$ let $\delta_p(c) = |w_p(t_p)(\zeta_p-) - w_p(t_p)(c)|$: then

$$
|w_p(t_p)(\zeta_p-) - w_\infty(t_\infty)(\zeta_\infty-)|\leq \delta_p(c) + \delta_\infty(c) + |w_p(t_p)(c) - w_\infty(t_\infty)(c)|\,.
$$

Proceeding with similar arguments as above we obtain the result by letting first $p \to \infty$ and then $c \uparrow \zeta_{\infty}$. \Box

Since $\mathbb{H}_p(\tau_p) = \Pi_p(t)(\mathcal{H}_p(\tau_p) -)$, proving (3.6) is the same as proving

$$
\Pi_p(\tau_p)(\mathcal{H}_p(\tau_p)-\Rightarrow \Pi_{\infty}(\tau_{\infty})(\mathcal{H}_{\infty}(\tau_{\infty})-)\text{ with }\mathbb{P}\left(\Pi_{\infty}(\tau_{\infty})(\mathcal{H}_{\infty}(\tau_{\infty})-\right)<\infty)=1. \tag{3.8}
$$

By standard arguments (e.g., Skorohod's representation theorem), Lemma 3.2 implies that in order to prove this, it is enough to prove that

$$
\limsup_{p \to \infty} \mathbb{P}_p \Big(\Pi_p(\tau_p) (\mathcal{H}_p(\tau_p) -) - \Pi_p(\tau_p) (\mathcal{H}_p(\tau_p) - c) \ge \eta \Big) \underset{c \to 0}{\longrightarrow} 0
$$

for every $\eta > 0$. Since $\Pi(n) = \mathscr{L}(\hat{R}^n \mid_{\mathscr{H}(n)})$ according to Theorem 2.2, we have

$$
\Pi_p(\tau_p)(\mathscr{H}_p(\tau_p)-)-\Pi_p(\tau_p)(\mathscr{H}_p(\tau_p)-c)\leq \hat{R}_p^{\tau_p}(c)
$$

which reduces the proof of (3.8) to showing that

$$
\limsup_{p \to \infty} \mathbb{P}\left(\hat{R}_p^{\tau_p}(c) \ge \eta\right) \xrightarrow[c \to 0]{} 0 \tag{3.9}
$$

for every $\eta>0.$ If $\tau_p=t$, then $\hat{R}^{\tau_p}_p(c)$ is identical in law to $R_p(c)$, and so (3.9) follows by the convergence of R_p and the continuity of R_∞ at $0.$

Let us now prove (3.9) for $\tau_p = \mathcal{V}_p^{-1}(t)$. Since $T_p^{-1}(T_p(t)) = t$ and $R_p \circ T_p^{-1}$ is increasing, on the event ${T_p(c) \leq \varepsilon}$ we have

$$
R_p(c) = R_p \circ T_p^{-1}(T_p(c)) \le R_p \circ T_p^{-1}(\varepsilon).
$$

In particular,

$$
\mathbb{P}_p(R_p(c) \circ \vartheta^{\tau_p} \ge \eta) \le \mathbb{P}_p(R_p \circ T_p^{-1}(\varepsilon) \circ \vartheta^{\tau_p} \ge \eta) + \mathbb{P}_p(T_p(c) \circ \vartheta^{\tau_p} \ge \varepsilon)
$$

\n
$$
\le \mathbb{P}_p(R_p \circ T_p^{-1}(\varepsilon) \circ \vartheta^{\tau_p} \ge \eta, \mathcal{V}_p^{-1}(t) \ge \varepsilon)
$$

\n
$$
+ \mathbb{P}_p(T_p(c) \circ \vartheta^{\tau_p} \ge \varepsilon, \mathcal{V}_p^{-1}(t) \ge \varepsilon) + 2\mathbb{P}_p(\mathcal{V}_p^{-1}(t) \le \varepsilon).
$$

By definition, we can write $R_p \circ T_p^{-1}(\varepsilon)$ as a function of $\omega_0^{p\varepsilon}$, i.e., $R_p \circ T_p^{-1}(\varepsilon) = \varphi(\omega_0^{p\varepsilon})$ for some measurable mapping φ . The exchangeability identity (3.5) thus gives

$$
\mathbb{P}_p(R_p \circ T_p^{-1}(\varepsilon) \circ \vartheta^{\tau_p} \ge \eta, \mathscr{V}_p^{-1}(t) \ge \varepsilon) = \mathbb{P}_p(R_p \circ T_p^{-1}(\varepsilon) \ge \eta, \mathscr{V}_p^{-1}(t) \ge \varepsilon)
$$

and, for the same reasons,

$$
\mathbb{P}_p(T_p(c) \circ \vartheta^{\tau_p} \geq \varepsilon, \mathscr{V}_p^{-1}(t) \geq \varepsilon) = \mathbb{P}_p(T_p(c) \geq \varepsilon, \mathscr{V}_p^{-1}(t) \geq \varepsilon)
$$

which thus leads to the bound

$$
\mathbb{P}_p(R_p(c) \circ \vartheta^{\tau_p} \geq \eta) \leq \mathbb{P}_p(R_p \circ T_p^{-1}(\varepsilon) \geq \eta) + \mathbb{P}_p(T_p(c) \geq \varepsilon) + 2\mathbb{P}_p(\mathscr{V}_p^{-1}(t) \leq \varepsilon).
$$

Letting first $p\to\infty$, then $c\to 0$ and finally $\varepsilon\to 0$ yields (3.9) in the case $\tau_p=\mathscr{V}_p^{-1}(t)$, which achieves the proof of this step.

Step 4: proof that $\mathbb{H}_{\infty}(t)$, $\mathbb{C}_{\infty}^{\star}(t) > 0$

We now prove that $\mathbb{H}_{\infty}(t)$ and $\mathbb{C}_{\infty}^{\star}(t)$ are almost surely strictly positive. For $\mathbb{H}_{\infty}(t)$, this comes from the convergence $\mathbb{H}_p(t) \Rightarrow \mathbb{H}_{\infty}(t)$ which we have just proved, together with the fact that $\mathbb{H}_p(t)$ is equal in distribution to $R_p \circ \widetilde{T}_{p}^{-1}(t)$ with R_p and \widetilde{T}_{p}^{-1} converging to two subordinators (this does not imply that $R_p \circ \tilde{T}_p^{-1}(t) \Rightarrow R_\infty \circ T_\infty^{-1}(t)$, but it does imply that any accumulation point is necessarily almost surely > 0).

Let us now prove that

$$
\liminf_{p \to \infty} \, \mathbb{P}_p \left(\mathbb{C}_p^{\star}(t) \ge \eta \right) \xrightarrow[\eta \downarrow 0]{} 1.
$$

We use the same exchangeability arguments as in the previous step. We have

$$
\mathbb{C}_p^{\star}(t) = \mathbb{H}_p(\mathscr{V}_p^{-1}(t)) = \left(R_p \circ \widetilde{T}_p^{-1} \circ \vartheta^{p\mathscr{V}_p^{-1}(t)}\right) (\mathscr{V}_p^{-1}(t)).
$$

Let φ_p be the measurable mapping such that $\varphi_p(\omega_0^n)=R_p\circ \widetilde{T}_p^{-1}(n/p)$, so that $\varphi_p(\omega_0^{pt})=0$ $R_p \circ \tilde{T}_p^{-1}(t)$: then for any $u \ge t$, on the event $\{\mathscr{V}_p^{-1}(t) = u\}$ we have

$$
\left(R_p \circ \tilde{T}_p^{-1} \circ \vartheta^{p\mathscr{V}_p^{-1}(t)}\right)(\mathscr{V}_p^{-1}(t)) = \left(R_p \circ \tilde{T}_p^{-1} \circ \vartheta^{pu}\right)(u) = \varphi_p(\omega_0^{pu}) \circ \vartheta^{pu} \ge \varphi_p(\omega_0^{pt}) \circ \vartheta^{pu}
$$

with the last inequality following from the monotonicity of $n \mapsto \varphi_p(\omega_0^n).$ In particular,

$$
\mathbb{P}_p\left(\mathbb{C}_p^{\star}(t) \geq \eta\right) \geq \mathbb{P}_p\left(\mathbb{H}_p(\mathscr{V}_p^{-1}(t)) \geq \eta, \mathscr{V}_p^{-1}(t) \geq \varepsilon\right) \\
\geq \mathbb{P}_p\left(\varphi_p(\omega_0^{pt}) \circ \vartheta^{p\mathscr{V}_p^{-1}(t)} \geq \eta, \mathscr{V}_p^{-1}(t) \geq \varepsilon\right)
$$

and (3.5) finally gives

$$
\mathbb{P}_p\left(\mathbb{C}_p^*(t) \geq \eta\right) \geq \mathbb{P}_p\left(\varphi_p(\omega_0^{pt}) \geq \eta, \mathscr{V}_p^{-1}(t) \geq \varepsilon\right) \geq \mathbb{P}_p\left(\mathbb{H}_p(t) \geq \eta\right) - \mathbb{P}_p\left(\mathscr{V}_p^{-1}(t) \leq \varepsilon\right).
$$

Letting first $p \to \infty$, then $\eta \downarrow 0$ and finally $\varepsilon \to 0$ gives the result, since we know that $\mathbb{H}_p(t) \Rightarrow \mathbb{H}_{\infty}(t)$ with $\mathbb{P}(\mathbb{H}_{\infty}(t) > 0) = 1$.

4 Convergence of the height process

In this section we state and prove the following triangular version of Theorem B.

Theorem B' (Triangular version of Theorem B)**.** If Assumptions G', C1' and C2' are satisfied and the asymptotic independence relation

$$
\mathbb{P}_p(c_p R(1) \ge \varepsilon \mid T(1) \ge \delta p) \to 0 \text{ for every } \varepsilon, \delta > 0
$$
 (IC1')

holds, then $\Pi_p\Rightarrow \Pi_\infty$ where Π_∞ is the ψ/ϕ snake. In particular, $\mathbb{H}_p\stackrel{\text{fdd}}{\Rightarrow}|\Pi_\infty(\,\cdot\,)|.$

The rest of the section is devoted to the proof of Theorem B': until the end of this section, we thus assume that all the assumptions of Theorem B' hold. The core of the proof is given in this section, and the lengthy proof of a technical result (Proposition 4.1) is in Section 7.

First, we note that the assumptions made imply that $(R_p, T_p, \mathscr{Z}_p) \Rightarrow (R_\infty, T_\infty, \mathscr{Z}_\infty)$ with R_{∞} independent from $(\mathscr{Z}_{\infty}, T_{\infty})$. Indeed, $R_p \Rightarrow R_{\infty}$ by assumption and $(T_p, \mathscr{Z}_p) \Rightarrow$ $(T_\infty, \mathscr{Z}_\infty)$ by Proposition 3.1. Moreover, the independence condition (IC1') means precisely that in the limit, R_{∞} and T_{∞} do not jump simultaneously, and as any accumulation point of $(R_p, T_p, \mathscr{Z}_p)$ is necessarily a subordinator, this implies that $R_\infty \perp T_\infty$ from which we get $R_{\infty} \perp (T_{\infty}, \mathscr{Z}_{\infty}).$

In order to prove Theorem B', we will need the following stronger independence property. The proof is rather long and technical, and thus postponed to Section 7.

Proposition 4.1. Assume that the assumptions of Theorem B' hold. Then for any finite set $J \subset \mathbb{R}$ we have $R_{\infty} \mathcal{L}(\mathscr{Z}_{\infty}^t, T_{\infty}^t)_{t \in J}$.

Remark 4.2. In Theorem E, we introduce a simple extension of a Bellman–Harris forest. In this case, one can check that $R_p\perp(T_p,\mathscr{Z}_p)$ but that R_p is in general not independent from $(\mathscr{Z}_p^t,T_p^t)_{t\in J}$ for $|J|>1.$ As a consequence, the passage from $R_\infty\bot\!\!\!\bot (T_\infty,\mathscr{Z}_\infty)$ to Proposition 4.1 only holds asymptotically and actually requires some delicate arguments developed in Section 7.

Recall from Theorem A' that (Π_p) is tight. Since by assumptions we have $(S_p, \mathcal{H}_p) \Rightarrow$ $(S_{\infty}, \mathscr{H}_{\infty})$ and $(R_p, T_p, \mathscr{Z}_p) \Rightarrow (R_{\infty}, T_{\infty}, \mathscr{Z}_{\infty})$ with $R_{\infty} \perp (T_{\infty}, \mathscr{Z}_{\infty})$, it follows by duality and the previous result that the sequence

$$
\left(S_p, \mathscr{H}_p, \Pi_p, (\hat{\mathscr{L}}_p^t, \hat{T}_p^t, \hat{R}_p^t)_{t \in \mathbb{Q}}\right)
$$

is tight. Consider any accumulation point and assume without loss of generality in the rest of this section that there is almost sure convergence

$$
\left(S_p, \mathcal{H}_p, \Pi_p, (\hat{\mathscr{L}}^t_\infty, \hat{T}^t_p, \hat{R}^t_p)_{t \in \mathbb{Q}}\right) \to \left(S_\infty, \mathcal{H}_\infty, \Pi_\infty, (\hat{\mathscr{L}}^t_\infty, \hat{T}^t_\infty, \hat{R}^t_\infty)_{t \in \mathbb{Q}}\right)
$$
(4.1)

with $\hat R^t_\infty\!\perp\!\!\!\perp(\hat {\mathscr{Z}}_\infty^t, \hat T^t_\infty)$ for any $t\in\mathbb Q$ and Π_∞ continuous with life-time process $\mathscr H_\infty.$ Since

$$
(\hat{T}_{\infty}^t)^{-1}(t-s) = \mathcal{H}_{\infty}(t) - \min_{[s,t]} \mathcal{H}_{\infty}, \ 0 \le s \le t \in \mathbb{Q}
$$
\n(4.2)

(see for instance [25, Lemma 5.3]) we obtain in particular $\hat R^t_\infty\bot \mathscr{H}_\infty(t).$ Actually, as a consequence of Proposition 4.1, a stronger result holds.

Lemma 4.3. For any $t\in\mathbb{Q}$ we have $\hat{R}_{\infty}^t\bot\!\!\!\!\perp\mathscr{H}_{\infty}.$

Proof. According to Proposition 4.1 we have $R_{\infty} \perp (T_{\infty}^u, u \in J)$ for any finite set $J \subset \mathbb{R}$, which implies $\hat R^t_\infty\!\perp\!\!\!\perp\!\! (T^u_\infty\circ \vartheta^t,u\in J)$ for every $t\in {\mathbb Q}.$ Since $T^u_\infty\circ \vartheta^t=\hat T^{t-u}_\infty$ (i.e., reverting time from t and then shifting by u is the same as reverting time from $t - u$) and $\mathcal{H}_{\infty}(u) =$ $(\hat{T}^u_\infty)^{-1}(u)$ we obtain the result. \Box **Lemma 4.4.** For any $t \in \mathbb{Q}$ we have $\Pi_{\infty}(t) = \mathscr{L}(\hat{R}_{\infty}^{t} |_{\mathscr{H}_{\infty}(t)}).$

Proof. Since $\hat R^t_\infty\bot \mathscr H_\infty(t)$ and $\hat R^t_\infty$ is a subordinator, $\hat R^t_\infty$ does not jump at time $\mathscr H_\infty(t)$ and so Lemma 2.1 and the convergence (4.1) imply that

$$
\Pi_p(t) = \mathscr{L}\left(\hat{R}_p^t \,|\, \mathscr{H}_p(t)\right) \to \mathscr{L}\left(\hat{R}_\infty^t \,|\, \mathscr{H}_\infty(t)\right)
$$

with the convergence holding in the usual Skorohod space. On the other hand, since $\Pi_p \to \Pi_\infty$ with Π_∞ continuous, we have also $\Pi_p(t) \to \Pi_\infty(t)$, this time in \mathscr{W} . From these two convergences one gets the desired result. \Box

For $s \leq t$ with $t \in \mathbb{Q}$, we define

$$
\tilde{\Pi}_{\infty}(s,t) = \mathscr{L}(\hat{R}_{\infty}^t \mid_{(\hat{T}_{\infty}^t)^{-1}(t-s)}).
$$

Intuitively, $\Pi_{\infty}(s,t)$ is the section of the chronological spine from t that does not overlap the chronological spine from s.

Lemma 4.5. Let $s \leq t$ with $t \in \mathbb{Q}$. Then $\Pi_\infty(t) = \left[\Pi_\infty(s), \ \tilde{\Pi}_\infty(s,t)\right]$ $\min_{[s,t]} \mathscr{H}_\infty$. Moreover, conditionally on \mathscr{H}_{∞} , $\tilde{\Pi}_{\infty}(s,t)$ is a subordinator with Laplace exponent ϕ killed at $(\hat{T}_{\infty}^t)^{-1}(t-s)$ and independent from $(\Pi_{\infty}(u), u \leq s)$.

Proof. That conditionally on \mathscr{H}_{∞} , $\tilde{\Pi}_{\infty}(s,t)$ is a subordinator with Laplace exponent ϕ killed at $(\hat{T}_\infty^t)^{-1}(t-s)$ is immediate from its definition and the fact that \hat{R}_∞^t is a subordinator with Laplace exponent ϕ independent from \mathscr{H}_{∞} . It remains to prove $\Pi_{\infty}(t) = \left[\Pi_{\infty}(s), \ \tilde{\Pi}_{\infty}(s,t)\right]$ $\min_{[s,t]}\mathscr{H}_\infty$ and the conditional independence.

Proof of the relation $\Pi_\infty(t) = \left[\Pi_\infty(s), \ \tilde\Pi_\infty(s,t)\right]$. We have seen in the proof of $\min_{[s,t]} \mathscr{H}_\infty$ Theorem A' that $\Pi_p(t)\mid_{\min_{[s,t]}\mathscr{H}_p-2c_p}=\Pi_p(s)\mid_{\min_{[s,t]}\mathscr{H}_p-2c_p}$: letting $p\to\infty$ we thus obtain $\Pi_\infty(t)\mid_{\min_{[s,t]}\mathscr{H}_\infty}=\Pi_\infty(s)\mid_{\min_{[s,t]}\mathscr{H}_\infty}$ (using as before the convergence of the $\hat R^{t\,}_p$'s, their asymptotic independence with \mathcal{H}_{∞} and Lemma 2.1) and so

$$
\Pi_\infty(t)=\left[\Pi_\infty(t),\Theta_{\min_{[s,t]}}\mathscr{H}_\infty(\Pi_\infty(t))\right]_{\min_{[s,t]}\mathscr{H}_\infty}=\left[\Pi_\infty(s),\Theta_{\min_{[s,t]}\mathscr{H}_\infty}(\Pi_\infty(t))\right]_{\min_{[s,t]}\mathscr{H}_\infty}.
$$

Since $\Pi_\infty(t)=\mathscr{L}(\hat R^t_\infty\mid_{(\hat T^t_\infty)^{-1}(t)})$ (Lemma 4.4) and $(\hat T^t_\infty)^{-1}(t-s)=\mathscr{H}_\infty(t)-\min_{[s,t]}\mathscr{H}_\infty$ (Relation (4.2)) we obtain

$$
\Theta_{\min_{[s,t]}} \mathscr{H}_\infty \left(\Pi_\infty(t) \right) = \mathscr{L} \left(\hat{R}^t_\infty \mid_{(\hat{T}^t_\infty)^{-1}(t-s)} \right).
$$

Combining the last two displays proves the desired relation.

Proof of the conditional independence. We now prove that $\Pi_{\infty}(s,t)$ is independent of $(\Pi_{\infty}(u), u \leq s)$ conditionally on \mathscr{H}_{∞} . For finite p, define

$$
\tilde{\Pi}_p(s,t) = \mathscr{L}(\hat{R}_p^t \mid_{(\hat{T}_p^t)^{-1}(t-s)-}).
$$

We have $(\tilde{\Pi}_p(s,t),\Theta_s(S_p))\in m\mathscr{F}_{\geq [ps]}$ and $((\hat{R}^u_p)_{u\leq s},S_p\mid_s)\in m\mathscr{F}_{<[ps]}$ which implies by letting $p \to \infty$ that

$$
\left(\tilde{\Pi}_{\infty}(s,t),\Theta_{s}(S_{\infty})\right)\perp\!\!\!\perp\left((\hat{R}_{\infty}^{u})_{u\leq s,u\in\mathbb{Q}},S_{\infty}\mid_{s}\right).
$$

Since $\Pi_{\infty}(u) = \mathscr{L}(\hat{R}_{\infty}^u \mid_{\mathscr{H}_{\infty}(u)})$ for $u \in \mathbb{Q}$, this gives

$$
\left(\tilde{\Pi}_{\infty}(s,t),\Theta_{s}(S_{\infty})\right)\perp\!\!\!\perp\left(\left(\Pi_{\infty}(u)\right)_{u\leq s},S_{\infty}\mid_{s}\right)
$$

(note that we can remove the condition $u \in \mathbb{Q}$ by continuity of Π_{∞}) which further gives the independence between $\Pi_{\infty}(s,t)$ and $(\Pi_{\infty}(u), u \leq s)$ conditionally on S_{∞} . Since finally $\sigma(S_{\infty}) = \sigma(\mathscr{H}_{\infty})$ this gives the desired conditional independence result. \Box

We can now prove Theorem B'.

Proof of Theorem B'. We already know that its life-time process is \mathcal{H}_{∞} and is the height process associated with S_{∞} . Thus according to Theorem 2.3 we only have to show that conditionally on \mathscr{H}_{∞} , Π_{∞} is (time-inhomogeneous) Markovian and satisfies for every $s \leq t$ the equality in distribution

$$
\Pi_{\infty}(t) = [\Pi_{\infty}(s), \Gamma]_{\min_{[s,t]} \mathscr{H}_{\infty}}
$$

with Γ an independent subordinator with Laplace exponent ϕ killed at $\mathscr{H}_{\infty}(t)-\min_{[s,t]}\mathscr{H}_{\infty}$. To do so, we only have to prove that

$$
\mathbb{E}\left[f(\Pi_{\infty}(t))\mid \mathscr{H}_{\infty}, \Pi_{\infty}(u), u\leq s\right] = \mathbb{E}\left[f\left([\Pi_{\infty}(s),\Gamma]_{\min_{[s,t]}\mathscr{H}_{\infty}}\right)\mid \mathscr{H}_{\infty}, \Pi_{\infty}(s)\right].
$$

For $t \in \mathbb{Q}$ this is a direct consequence of Lemma 4.5, and so the result follows by continuity of Π_{∞} . \Box

5 Convergence of the contour process

In this section we state and prove the following triangular version of Theorem C.

Theorem C' (Triangular version of Theorem C)**.** If Assumptions G', C1' and C2' are satisfied, if (IC1') holds and if

$$
\mathbb{P}\left(|\mathscr{P}_p^*| \geq \varepsilon p g_p \mid v_p V_p^* \geq \delta\right) \underset{p \to \infty}{\longrightarrow} 0 \text{ for every } \varepsilon, \delta > 0,
$$
 (IC2')

then \mathscr{V}_∞ is independent of \mathbb{H}_∞ and $c_p/v_p\to\infty.$ In particular, $\mathbb{C}_p^\star\stackrel{\text{fdd}}{\Rightarrow}\mathbb{H}_\infty\circ\mathscr{V}_\infty^{-1}.$

Under the assumptions of this theorem, we know by Theorem B' that $\Pi_p \Rightarrow \Pi_\infty$ and since $\mathscr{V}_p \Rightarrow \mathscr{V}_{\infty}$, we can assume without loss of generality that $(\Pi_p, \mathscr{V}_p) \Rightarrow (\Pi_{\infty}, \mathscr{V}_{\infty})$ with an unknown (at this point) correlation structure between Π_{∞} and \mathscr{V}_{∞} .

As we will see, the main idea is that the asymptotic behavior of \mathcal{V}_p and \mathbb{C}_p is governed by long edges, i.e., edges with length $\geq \varepsilon/v_p$ for some $\varepsilon > 0.$ In contrast, $\dot{\mathbb{H}}$ and \mathbb{C}^\star only "see", by construction, the birth times of individuals, which are of the order of $1/c_p$ and are thus somehow insensitive to long edges because, intuitively, these long edges are close to the leaves.

To formalize this idea, for each $\varepsilon > 0$ and $k \geq 0$ we consider λ_k the kth individual with an edge longer than ε/v_p and λ_k^+ its last child: $\lambda_0=0$ and for $k\geq 1$,

$$
\lambda_k = \min \{ n > \lambda_{k-1} : V_n \ge \varepsilon/v_p \} \text{ and } \lambda_k^+ = \inf \{ n \ge \lambda_k : S(n) = S(\lambda_k) - 1 \}.
$$

In particular, $\{\lambda_k,\ldots,\lambda_k^+-1\}$ is the set of λ_k 's descendants (including λ_k) and

$$
\bigcup_{k\geq 0} \left\{\lambda_k,\ldots,\lambda_k^+-1\right\}.
$$

is the set of individuals with an ancestor (including potentially the individual herself) with an edge $\ge \varepsilon/v_p.$ Note that the sequences (λ_k) and (λ_k^+) depend on p and ε but this dependency is omitted from the notation for simplicity. We will also denote with $\tilde{\cdot}$ scaled versions of these random times, namely

$$
\tilde{\lambda}^+_k = \frac{1}{p} \lambda^+_k \text{ and } \tilde{\lambda}^+_k = \frac{1}{p} \lambda^+_k
$$

We finally define λ_k^{∞} as the time of the k th jump $\geq \varepsilon$ of \mathscr{V}_{∞} . Note that since $\mathscr{V}_p \Rightarrow \mathscr{V}_{\infty}$, standard properties of the Skorohod topology imply that

$$
\left(\tilde{\lambda}_k, k \ge 0\right) \Rightarrow \left(\lambda_k^{\infty}, k \ge 0\right),\tag{5.1}
$$

see for instance [13, Proposition VI.2.17].

We will thus consider sequences $(X_{p,\varepsilon})$ indexed by the scaling parameter p and also by ε , and for such sequences we will use the notation $X_{p,\varepsilon} \Rightarrow_{p,\varepsilon} X$ to mean that $X_{p,\varepsilon}$ converges weakly to X when we let first $p \to \infty$ and then $\varepsilon \downarrow 0$, or more formally that for every bounded continuous function f we have

$$
\limsup_{p \to \infty} |E[f(X_{p,\varepsilon})] - E[f(X)]| \xrightarrow[\varepsilon \to 0]{} 0.
$$

For instance, standard properties of the Skorohod topology imply that $\mathscr{V}_p^{<\varepsilon}(t)\Rightarrow_{p,\varepsilon}\mathsf{d} t$ for each fixed $t\geq 0$, where $\mathsf{d}\geq 0$ denotes the drift of the process \mathscr{V}^∞ and $\mathscr{V}^{\leqslant\varepsilon}_p$ for $p\in\mathbb{N}\cup\{\infty\}$ is obtained from \mathcal{V}_n by only keeping jumps $\lt \varepsilon$, i.e., by removing all jumps $\gt \varepsilon$.

5.1 Step 1: $c_p/v_p \rightarrow \infty$

The proof of $c_p/v_p \to \infty$ relies on the next lemma which shows that the time spent visiting subtrees rooted at long edges is negligible.

Lemma 5.1. For every $k \geq 0$ we have $\tilde{\lambda}_k^+ - \tilde{\lambda}_k \Rightarrow 0$.

Proof. We note that $\lambda_k^+ - \lambda_k$ is equal in distribution to the hitting time of $-M$ by S, where $M\bot\!\!\!\bot S$ is distributed as $|\mathscr{P}_{\lambda_1}|.$ Since $S_p \Rightarrow S_\infty$, the time needed for S to hit $-\varepsilon p g_p$ is of the order of $p.$ Since $|\mathscr{P}_{\lambda_1}|/(p g_p)\Rightarrow 0$ by assumption, i.e., M is negligible compared to pg_p , the hitting time of M is also negligible compared to p, hence the result.

We now prove that $c_p/v_p \to \infty$: by working along appropriate subsequences assume without loss of generality that $v_p/c_p \to \ell = \limsup_p (v_p/c_p).$ Since $R(k) \leq V_{T(k)-1}$ we have

$$
\mathbb{H}([pt]) = \left(\sum_{k:T(k)\leq [pt]} R(k)\right) \circ \vartheta^{[pt]} \leq \left(\sum_{k:T(k)\leq [pt]} V_{T(k)-1}\right) \circ \vartheta^{[pt]}.
$$

Let

$$
E_p = \left\{ [pt] \notin \bigcup_{k \ge 1} \left\{ \lambda_k, \dots, \lambda_k^+ - 1 \right\} \right\}
$$

be the event that no ancestor of $[pt]$ has long edges. In E_n we have

$$
\mathbb{H}([pt]) \le \sum_{j \le [pt]} V_j \mathbb{1}(V_j < \varepsilon/v_p)
$$

and so upon scaling, we get $v_p \mathbb{H}_p(t)/c_p \leq \mathscr{V}^{<\varepsilon}_p(t)$ in E_p . Since $\mathbb{H}_p(t) \Rightarrow R_\infty(T_\infty^{-1}(t)),$ $\mathscr{V}_p^{<\varepsilon}(t) \Rightarrow_{p,\varepsilon}$ dt and $\mathbb{P}(E_p) \to 1$ as a consequence of Lemma 5.1, we obtain that $\mathbb{P}(\ell R_\infty(T_\infty^{-1}(t)) \leq \mathsf{d} t) = 1$ which can only hold if $\ell = 0$.

5.2 Step 2: snake-like property

Let in the sequel

$$
X(m) = \sup_{\{0,\ldots,m\}} S - S(m).
$$

In the following statement, we consider a functional W whose k th increment is a functional of the sequence of sticks between the kth and $(k+1)$ th record time of the path S . By standard fluctuation theory, W can be seen as a renewal process whose time is measured in local time units for the reflected process X .

The basic idea behind the next relation consists in decomposing the process W before and after the local time corresponding to the excursion of X straddling t . We refer the reader to Figure 6.

Recall (see Section 2.1.3) that $\mathscr{F}_{\leq \Gamma} = \sigma(\omega_k, k \leq \Gamma)$ for any random time $\Gamma : \Omega \to \mathbb{N}$, that $m\mathscr{F}$ is the set of random variables that are measurable with respect to the σ -algebra $\mathscr F$, and that we use throughout the notation $W^n = W \circ \theta_n$ and $\hat W^n = W \circ \vartheta^n$ for any random variable W defined on Ω . In the following statement, Z is any random variable taking values in an arbitrary measurable space: the following result will typically be used for real-valued random variables.

Lemma 5.2 (Snake-like property). Let $Z \in m\mathscr{F}_{\leq T(1)}$ and

$$
W = \sum_{k \in \mathbb{N}} Z \circ \theta_{T(k)} \epsilon_{k+1}.
$$
 (5.2)

Then $W\mid_{\tilde{T}^{-1}(m)}\in\mathscr{F}_{\leq m}$ and if m is not a weak record time for the walk S, then

$$
\Theta_{T^{-1}(m)}(W) = \Theta_{(\mathscr{Z}^m)^{-1} \circ X(m)}(W^m) \text{ and } W = [W, \Theta_{(\mathscr{Z}^m)^{-1} \circ X(m)}(W^m)]_{\tilde{T}^{-1}(m)+1}.
$$
 (5.3)

Proof. The fact that $W|_{\tilde{T}^{-1}(m)} \in \mathscr{F}_{\leq m}$ is a direct consequence of the assumption $Z \in$ $m\mathscr{F}_{\leq T(1)}$ and the fact that $T(\widetilde{T}^{-1}(m)) \leq m$ and is a stopping time.

Consider now m which is not a weak ascending ladder height time and let us prove the two relations of (5.3). Since $W = [W, \Theta_h(W)]_h$ for every $h \geq 0$, the second relation follows directly from the first one with $h=T^{-1}(m)$ since, when m is not a weak ascending ladder height time, we have $T^{-1}(m) = \tilde T^{-1}(m) + 1.$

As for the first one, $\Theta_{T^{-1}(m)}(W)$ is obtained by skipping the $T^{-1}(m)$ first excursions of S reflected at its maximum. In terms of the shifted process W^m at time m, this amounts to skipping the excursions needed to escape the "valley" in which m sits, see Figure 6 for an explanation of this loose statement on a picture. The shifted process needs to reach level $X(m)$ to escape the valley, and the number of excursions needed to do so is precisely given by $(\mathscr{Z}^m)^{-1}\circ X(m)$ by definition of $\mathscr{Z}^m.$ This proves the result. \Box

5.3 Step 3: Π∞⊥⊥V[∞] **by a perturbation argument**

In this step we prove that $\Pi_{\infty} \perp \mathcal{V}_{\infty}$ through a perturbation argument. We first introduce the perturbed sequence, explain the main idea and prove that $S_{\infty} \perp \!\!\! \perp \mathscr{V}_{\infty}$ in Section 5.3.1. The independence between Π_{∞} and \mathcal{V}_{∞} is then established in Section 5.3.2.

5.3.1 Perturbed sequence, main idea and $S_{\infty} \perp \!\!\! \perp \mathscr{V}_{\infty}$

For each $p\geq 1$, let $((V_n',\mathscr{P}_n'),n\geq 1)$ be a sequence of i.i.d. random variables, independent of $((V_n, \mathscr{P}_n), n \ge 1)$ and with the same law as that of (V_p^*, \mathscr{P}_p^*) conditioned on $V_p^* < \varepsilon/v_p$. Out of the sequence $((V_n',\mathscr{P}_n'),n\geq 1)$ and the original sequence $((V_n,\mathscr{P}_n),n\geq 1)$, we define a new sequence of sticks

$$
\left(\widehat{V}_n, \widehat{\mathscr{P}}_n\right) = \begin{cases} (V_n, \mathscr{P}_n) & \text{if } V_n < \varepsilon/v_p, \\ (V_n', \mathscr{P}_n') & \text{else.} \end{cases}
$$

which implies for instance that

$$
\widehat{\Pi}_{p} \bot \!\!\! \bot \mathscr{V}_{p}^{\geq \varepsilon}
$$

with $\mathscr{V}^{\geq\varepsilon}_p=\mathscr{V}_p-\mathscr{V}^{<\varepsilon}_p$ obtained from \mathscr{V}_p by only keeping jumps $\geq\varepsilon.$ If we can show that the perturbation induced by the (V'_n, \mathcal{P}'_n) 's is negligible in the sense that $\Pi_p(t) - \widehat{\Pi}_p(t) \Rightarrow 0$ for each fixed t , then we will get $\Pi_\infty\bot\!\!\!\bot\mathscr{V}_\infty$ (because $\mathscr{V}^{\geq\varepsilon}_p\Rightarrow_{p,\varepsilon}(\mathscr{V}_\infty(t)-\mathsf{d} t,t\geq 0)$). This is the object of the next section, and before going on we use these arguments to show that $S_{\infty} \perp \!\!\! \perp \mathscr{V}_{\infty}$.

The fact that $S_p - \hat{S}_p \Rightarrow 0$ is a direct consequence of the assumption (IC2') and the fact that $((V_n, \mathcal{P}_n), n \geq 1)$ and $((\widehat{V}_n, \widehat{\mathcal{P}}_n), n \geq 1)$ only differ by a locally finite number of terms (by Lemma 5.1). More precisely, we have

$$
\sup_{[0,t]} \left| S_p - \widehat{S}_p \right| \le \frac{1}{p g_p} \sum_{k: \lambda_k \le [pt]} \left(|\mathcal{P}_{\lambda_k}| + |\mathcal{P}'_{\lambda_k}| \right). \tag{5.4}
$$

By assumption we have $|\mathscr{P}_{\lambda_k}|/(p g_p)\Rightarrow 0.$ Since

$$
\mathbb{P}\left(\left|\mathscr{P}_{\lambda_k}'\right|\geq xpg_p\right)=\mathbb{P}\left(\left|\mathscr{P}_{p}^*\right|\geq xpg_p\mid V_p^*<\varepsilon/v_p\right)\leq \frac{\mathbb{P}\left(\left|\mathscr{P}_{p}^*\right|\geq xpg_p\right)}{\mathbb{P}\left(V_p^*<\varepsilon/v_p\right)}
$$

we also have $|\mathscr{P}'_{\lambda_k}|/(pg_p)\Rightarrow 0$ since Assumptions G' and C2' imply that $|\mathscr{P}^*_p|/(pg_p)\Rightarrow 0$ and $v_p V_p^* \Rightarrow 0$. Since the number of terms in the sum in the right-hand side of (5.4) forms a tight sequence, we get as desired that $S_p - \widehat{S}_p \Rightarrow 0$. We now show that the perturbation does not significantly change the chronological height process as well.

5.3.2 Perturbation of the chronological spine process

Let $((\widehat{V}_n^{(k)}, \widehat{\mathscr{P}}_n^{(k)}), n \ge 1)$ be obtained by induction as $(\widehat{V}_n^{(0)}, \widehat{\mathscr{P}}_n^{(0)}) = (V_n, \mathscr{P}_n)$ and

$$
\left(\widehat{V}_n^{(k+1)}, \widehat{\mathscr{P}}_n^{(k+1)}\right) = \begin{cases} (V_n', \mathscr{P}_n') & \text{if } n = \lambda_{k+1}, \\ \left(\widehat{V}_n^{(k)}, \widehat{\mathscr{P}}_n^{(k)}\right) & \text{else.} \end{cases}
$$

Thus, $((\widehat{V}_n^{(k)}, \widehat{\mathscr{P}}_n^{(k)}), n \ge 1)$ and $((\widehat{V}_n^{(k+1)}, \widehat{\mathscr{P}}_n^{(k+1)}), n \ge 1)$ only differ by one element and in order to prove that $\Pi_p(t) - \widehat{\Pi}_p(t) \Rightarrow 0$ it is enough to prove that $\widehat{\Pi}_p^{(k)}(t) - \widehat{\Pi}_p^{(k+1)}(t) \Rightarrow 0$ for every $k\geq 0.$ Because $\Pi_p(t)=(R_p\mid_{\tilde{T}_p^{-1}(t)})\circ\vartheta^{[pt]},\ (R_p,T_p)\Rightarrow(R_\infty,T_\infty)$ with R_∞ a subordinator independent from T_{∞} , it is enough to prove that

$$
\widehat{R}_p^{(k)}-\widehat{R}_p^{(k+1)}\Rightarrow 0\;\;\text{and}\;\;\widehat{T}_p^{(k)}-\widehat{T}_p^{(k+1)}\Rightarrow 0,\;k\geq 0.
$$

By shifting and using the strong Markov property, it is enough to prove the result for $k = 0$. We show that $R_p - \widehat{R}_p^{(1)} \Rightarrow 0$, the convergence $T_p - \widehat{T}_p^{(1)} \Rightarrow 0$ can be shown along the same lines. To ease the notation let us define $\tilde{\lambda} = \frac{1}{p}\lambda_1$ and let us also denote with $\frac{1}{p}$ instead of with $\widehat{\cdot}^{(1)}$ all quantities defined from the $(\widehat{V}^{(1)}_n, \widehat{\mathscr{P}}^{(1)}_n)'$ s, e.g., \underline{R}_p instead of $\widehat{R}_p^{(1)}$, etc.

For the sake of simplicity, let us now assume that the drift of the subordinator \mathscr{Z}_{∞} is equal to 0. We will briefly discuss in Remark 5.3 how to adapt our argument to the case of positive drift. Since $S_{\infty} \perp \!\!\! \perp \mathscr{V}_{\infty}$, λ_1 is with high probability not a record time of S and so Lemma 5.2 entails (in an event of probability going to one)

$$
R = R |_{\widetilde{T}^{-1}(\lambda_1)} + \Delta R \left(T^{-1}(\lambda_1) \right) \epsilon_{T^{-1}(\lambda_1)} + \Theta_{(\mathscr{Z}^{\lambda_1})^{-1}(X(\lambda_1))} \left(R^{\lambda_1} \right)
$$
(5.5)

and

$$
\underline{R} = \underline{R} \big|_{\underline{\widetilde{T}}^{-1}(\lambda_1)} + \Delta \underline{R} \left(\underline{T}^{-1}(\lambda_1) \right) \epsilon_{T^{-1}(\lambda_1)} + \Theta_{(\underline{\mathscr{Z}}^{\lambda_1})^{-1}(\underline{X}(\lambda_1))} \left(\underline{R}^{\lambda_1} \right). \tag{5.6}
$$

In order to grasp more intuition on what follows, let us briefly give an interpretation of the previous relations. Recall that for the processes R, T, \mathscr{L} , time is measured in local time units for the reflected process X . The previous relation consists in decomposing the process R (and \bar{R}) before and after the local time corresponding to the excursion of X straddling λ_1 . In particular, $(Z^{\lambda_1})^{-1}(X(\lambda_1))$ is the local time needed to exit the "valley" straddling λ_1 . See Figure 6.

Since the two initial sequences of sticks coincide up to λ_1 , we have

$$
R\mid_{\widetilde{T}^{-1}(\lambda_1)}= \underline{R}\mid_{\underline{\widetilde{T}}^{-1}(\lambda_1)}.
$$

Next, let E be the event

which can be formerly defined as

$$
E = \left\{ \mathscr{Z}^{\lambda_1} \circ \left(\mathscr{Z}^{\lambda_1} \right)^{-1} \circ X(\lambda_1) \geq \underline{X}(\lambda_1) \right\}
$$

and analogously, define

$$
\underline{E} = \left\{ \underline{\mathscr{Z}}^{\lambda_1} \circ \left(\underline{\mathscr{Z}}^{\lambda_1} \right)^{-1} \circ \underline{X}(\lambda_1) \geq X(\lambda_1) \right\}.
$$

In the event $E \cap \underline{E}$, the two Lukaziewicz paths exit the valley straddling λ_1 at the same time, i.e.,

$$
T \circ T^{-1}(\lambda_1) = \underline{T} \circ \underline{T}^{-1}(\lambda_1),
$$

and this implies that, in this event,

$$
\Theta_{(Z^{\lambda_1})^{-1}(X(\lambda_1))}\left(R^{\lambda_1}\right) = \Theta_{(\underline{Z}^{\lambda_1})^{-1}(\underline{X}(\lambda_1))}\left(\underline{R}^{\lambda_1}\right).
$$

We now claim that $\mathbb{P}(E), \mathbb{P}(E) \to 1$. Let us first consider the overshoot when exiting the valley straddling λ_1 , which is given by

$$
\mathscr{Z}^{\lambda_1} \circ (\mathscr{Z}^{\lambda_1})^{-1} \circ X(\lambda_1) - X(\lambda_1).
$$

As $X(\lambda_1)\in m\mathscr{F}_{<\lambda_1}$ and $\mathscr{Z}^{\lambda_1}\in m\mathscr{F}_{\geq\lambda_1}$, the latter quantity converges in distribution (after proper space rescaling by $1/pg_p$) to $\mathscr{Z}_\infty\circ\mathscr{Z}_\infty^{-1}(\xi)-\xi$, where $\xi\bot\!\bot\!\mathscr{Z}_\infty$ is almost surely positive. In the absence of drift for the subordinator \mathscr{Z}_{∞} , we must have

$$
\mathscr{Z}_\infty \circ \mathscr{Z}_\infty^{-1}(\xi)-\xi>0
$$

because S_{∞} does not creep at level ξ (see for instance [3, Thereom VI.19]) and as a consequence, $\mathscr{Z}^{\lambda_1} \circ (\mathscr{Z}^{\lambda_1})^{-1} \circ X(\lambda_1) - X(\lambda_1)$ is of the order of $1/(pg_p)$. On the other hand, $X(\lambda_1) - X(\lambda_1)$ is negligible compared to $1/(pg_p)$ because of (IC2') which implies that $P(E) \rightarrow 1$. By similar arguments one can prove that $P(E) \rightarrow 1$. This shows that $P(E), P(E) \rightarrow 1$, and as discussed earlier, the last terms on the RHS of (5.5) and (5.6) are equal.

In order to conclude the proof, we only have to show that for the middle terms of (5.5) and (5.6) we have

$$
\mathbb{P}\left(c_p \Delta R(T^{-1}(\lambda_1)) \geq x\right) \xrightarrow[p \to \infty]{} 0, \ \mathbb{P}\left(c_p \Delta \underline{R}(\underline{T}^{-1}(\lambda_1)) \geq x\right) \xrightarrow[p \to \infty]{} 0
$$

for any $x > 0$. We have

$$
\Delta R(T^{-1}(\lambda_1)) = \Delta R^{\lambda_1} ((\mathscr{Z}^{\lambda_1})^{-1}(X(\lambda_1))).
$$

As $X(\lambda_1)\in m\mathscr{F}_{<\lambda_1}$ and $(R^{\lambda_1},\mathscr{Z}^{\lambda_1})\in m\mathscr{F}_{\geq\lambda_1}$ we see that $c_p\Delta R(T^{-1}(\lambda_1))$ is equal in distribution to $\Delta R_p(\mathscr{Z}_p^{-1}(\zeta_p))$ with (R_p, \mathscr{Z}_p) $\bot \zeta_p$ and ζ_p equal in distribution to $X_p(\tilde{\lambda})$. Thus ζ_p converges in distribution to some ζ_∞ independent from \mathscr{Z}_∞ , so that $\mathscr{Z}^{-1}_p(\zeta_p)\Rightarrow$ $\mathscr{Z}_{\infty}^{-1}(\zeta_{\infty})$ and because $R_{\infty}\perp\!\!\!\perp\mathscr{Z}_{\infty}$ we obtain $\Delta R_p(\mathscr{Z}_{p}^{-1}(\zeta_{p}))\Rightarrow 0.$ In the event $E\cap \underline{E}$ we have

$$
\Delta \underline{R}(\underline{T}^{-1}(\lambda_1)) = \Delta R^{\lambda_1} ((Z^{\lambda_1})^{-1}(\underline{X}(\lambda_1)))
$$

and so the same argument as above gives $c_p\Delta\underline R(\underline T^{-1}(\lambda_1))\Rightarrow 0.$ This shows that $\mathscr{V}_\infty\bot \Pi_\infty$ which completes the proof of Theorem C'.

Remark 5.3. As mentioned in the proof, we only proved the previous result assuming that \mathscr{Z}_{∞} has no drift. In this case, we argued that the two random walks exit the λ_1 -valley at the same time with high probability. In the presence of drift, this is not the case anymore. The two random walks S or \overline{S} can exit the valley by "creeping". In this case, the exit times are not equal, but their differences vanish (macroscopically) at the limit. A similar but more cumbersome argument can then be applied, but the spirit of the proof remains the same.

6 Applications

We now come back to the two specific examples of Section 1.6.

6.1 Proof of Theorem D

In the non-triangular case and when $|\mathscr{P}^*|$ has finite variance, Assumptions G, C1 and C2 imply Assumptions G', C1' and C2' with $\psi(\lambda) = \lambda^2$, and so in order to prove Theorem D we only have to check that conditions (IC1) and (IC2) hold. We first check (IC2). Fix $\varepsilon > 0$ and let $\lambda = \inf\{n \geq 0 : V_n \geq \varepsilon/v_n\}$. Then for every $K > 0$

$$
\begin{split} \mathbb{P}\left(|\mathscr{P}^*| \geq x\sqrt{p} \mid v_pV^* \geq \varepsilon\right) &= \mathbb{P}\left(|\mathscr{P}_\lambda| \geq x\sqrt{p}\right) \\ &\leq \mathbb{P}\left(\lambda \geq [Kp]\right) + \mathbb{P}\left(\max_{i \in \{0, \dots, [Kp]\}} |\mathscr{P}_i| \geq x\sqrt{p}\right). \end{split}
$$

Since $|\mathscr{P}^*|$ has finite variance, the second term vanishes when we let $p \to \infty$, while since $\mathscr{V}_p \Rightarrow \mathscr{V}_{\infty}$ we have that λ/p is tight, and so the first term also vanishes when we let first $p \to \infty$ and then $K \to \infty$.

We now turn to (IC1). We have

$$
\mathbb{P}\left(c_p R(1) \geq \varepsilon \mid T(1) \geq \delta p\right) = \frac{\mathbb{P}\left(c_p R(1) \geq \varepsilon, T(1) \geq \delta p\right)}{\mathbb{P}\left(T(1) \geq \delta p\right)}.
$$

In the finite variance case, the tail of the ladder height time of a recurrent, zero-mean random walk with finite variance decays asymptotically like $x^{-1/2}$ up to a multiplicative constant. Applying this result to S and $-S$, we obtain the existence of finite and positive constants κ_1, κ_2 such that

$$
\mathbb{P}(T(1) \ge x) \sim \kappa_1 x^{-1/2} \text{ and } \mathbb{P}(\tau_1^- \ge x) \sim \kappa_2 x^{-1/2} \text{ as } x \to \infty,
$$

and in particular, in order to prove (IC1) we only have to prove that

$$
\sqrt{p} \mathbb{P}\left(c_p R(1) \ge \varepsilon, T(1) \ge \delta p\right) \to 0.
$$

Remark 6.1. Note that

$$
\sqrt{p} \mathbb{P}\left(c_p R(1) \ge \varepsilon, T(1) \ge \delta p\right) \le \sqrt{p} \mathbb{P}\left(T(1) \ge \delta p\right)
$$

From the tail behavior $\mathbb{P}(T(1) \geq x) \sim \kappa_1 x^{-1/2}$, the right-hand side remains bounded. Obviously, the previous bound is poor since we got rid of an event of small probability. Informally, the upcoming computations boil down to proving that for large values of p , the events $\{\sqrt{p}(c_pR(1)\geq \varepsilon\}$ and $\{T(1)\geq \delta p\}$ are sufficiently decorrelated so that the the left-hand side goes to 0.

Since $x \mapsto 1 - e^{-x}$ is decreasing, Markov inequality gives

$$
\mathbb{P}\left(c_p R(1) \ge \varepsilon, T(1) \ge \delta p\right) \le \frac{1}{(1 - e^{-\varepsilon})(1 - e^{-\delta})} \mathbb{E}\left(\left(1 - e^{-c_p R(1)}\right) \left(1 - e^{-T(1)/p}\right)\right)
$$

and so in order to prove the result, it is enough to show that

$$
\sqrt{p} \mathbb{E}\left(\left(1 - e^{-c_p R(1)}\right) \left(1 - e^{-T(1)/p}\right) \right) \underset{p \to \infty}{\longrightarrow} 0.
$$

Considering $F(t, z, r) = (1 - e^{-t/p})(1 - e^{-c_p r})$ in (2.3) and using the notation $\xi = |\mathscr{P}^*|$, we obtain

$$
\mathbb{E}\left(\left(1 - e^{-T(1)/p}\right) \left(1 - e^{-c_p R(1)}\right)\right)
$$
\n
$$
= \sum_{t,x,z} \mathbb{E}\left(\left(1 - e^{-t/p}\right) \left(1 - e^{-c_p A_z(\mathscr{P}^*)}\right); \xi = x+z\right) \mathbb{P}(\tau_{x-1}^- = t-1)
$$
\n
$$
= \sum_{x,z} \mathbb{E}\left(1 - e^{-c_p A_z(\mathscr{P}^*)}; \xi = x+z\right) \mathbb{E}\left(1 - e^{-(\tau_{x-1}^- + 1)/p}\right)
$$
\n
$$
= \sum_{x\geq 1} \mathbb{E}\left(1 - e^{-c_p A_{\xi-x}(\mathscr{P}^*)}; \xi \geq x\right) \left(1 - e^{-1/p} u_p^x\right)
$$

where the initial sum is taken over $t,x\geq 1$ and $z\geq 0$ and $u_p=\mathbb{E}(e^{-\tau_1^{-}/p}).$ We thus have

$$
\sqrt{p} \mathbb{E}\left(\left(1 - e^{-T(1)/p}\right) \left(1 - e^{-c_p R(1)}\right)\right) = \sqrt{p} \sum_{x \ge 1} \mathbb{E}\left(1 - e^{-c_p A_{\xi - x}(\mathscr{P}^*)}; \xi \ge x\right) \left(1 - u_p^x\right) + o(1)
$$

with $o(1)$ an error term that vanishes as $p \to \infty$. We split the sum into two terms, depending on whether x is large or not. Fix until further notice some $\eta > 0$, and consider the terms $x \leq \eta \sqrt{p}$: we have

$$
\sqrt{p} \sum_{x \le \eta \sqrt{p}} \mathbb{E} \left(1 - e^{-c_p A_{\xi - x}(\mathscr{P}^*)}; \xi \ge x + 1 \right) \left(1 - u_p^x \right)
$$

\n
$$
\le \sqrt{p} \left(1 - u_p^{\eta \sqrt{p}} \right) \sum_{x \le \eta \sqrt{p}} \mathbb{E} \left(1 - e^{-c_p A_{\xi - x}(\mathscr{P}^*)}; \xi \ge x + 1 \right)
$$

\n
$$
\le \sqrt{p} \left(1 - u_p^{\eta \sqrt{p}} \right) \sum_x \mathbb{E} \left(1 - e^{-c_p A_{\xi - x}(\mathscr{P}^*)}; \xi \ge x + 1 \right)
$$

\n
$$
= \sqrt{p} \mathbb{E} \left(1 - e^{-c_p R(1)} \right) \times \left(1 - u_p^{\eta \sqrt{p}} \right) = 1 - u_p^{\eta \sqrt{p}}.
$$

From the tail behavior $\mathbb{P}(\tau_1^-\geq x)\sim \kappa_2x^{-1/2}$, standard Tauberian theorems imply the existence of a finite constant κ such that $\mathbb{E}(1-e^{-\lambda\tau_1^-})\sim \kappa\lambda^{1/2}$ as $\lambda\to 0$ (see for instance [4, Corollary 8.1.7]), which implies in particular that $1-u_p^{\pi\sqrt{p}} \to 1-e^{-\eta\kappa}$. Thus we obtain

$$
\limsup_{p \to \infty} \sqrt{p} \sum_{x \le \eta \sqrt{p}} \mathbb{E}\left(1 - e^{-c_p A_{\xi - x}(\mathscr{P}^*)}; \xi \ge x + 1\right) \left(1 - u_p^x\right) \le 1 - e^{-\eta \kappa}.
$$

Let us now look at the other terms corresponding to $x \geq \eta\sqrt{p}$: we have

$$
\sqrt{p} \sum_{x \ge \eta \sqrt{p}} \mathbb{E} \left(1 - e^{-c_p A_{\xi - x}(\mathscr{P}^*)}; \xi \ge x + 1 \right) \left(1 - u_p^x \right)
$$

\n
$$
\le \sqrt{p} \sum_{x \ge \eta \sqrt{p}} \mathbb{E} \left(1 - e^{-c_p A_{\xi - x}(\mathscr{P}^*)}; \xi \ge x + 1 \right)
$$

\n
$$
= \sqrt{p} \sum_{x \ge \eta \sqrt{p}} \mathbb{E} \left(1 - e^{-c_p A_{\xi - x}(\mathscr{P}^*)}; \xi \ge x + 1, \xi \ge \eta \sqrt{p} \right)
$$

\n
$$
\le \sqrt{p} \sum_{x} \mathbb{E} \left(1 - e^{-c_p A_{\xi - x}(\mathscr{P}^*)}; \xi \ge x + 1, \xi \ge \eta \sqrt{p} \right).
$$

From (2.2) we obtain

$$
\mathbb{E}\left(1-e^{-c_pR(1)};|\mathscr{P}_{T(1)-1}|\geq \eta\sqrt{p}\right)=\sum_{x}\mathbb{E}\left(1-e^{-c_pA_{\xi-x}(\mathscr{P}^*)};\xi\geq x+1,\xi\geq \eta\sqrt{p}\right)
$$

and so using Cauchy–Schwarz inequality we get

$$
\sqrt{p} \sum_{x \ge \eta \sqrt{p}} \mathbb{E} \left(1 - e^{-c_p A_{\xi - x}(\mathscr{P}^*)}; \xi \ge x + 1 \right) \left(1 - u_p^x \right)
$$

$$
\le \sqrt{p} \sqrt{\mathbb{E} \left[\left(1 - e^{-c_p R(1)} \right)^2 \right] \mathbb{P} \left(|\mathscr{P}_{T(1)-1}| \ge \eta \sqrt{p} \right)}
$$

$$
\le \eta^{-1/2} \sqrt{\sqrt{p} \mathbb{E} \left(1 - e^{-2c_p R(1)} \right) \mathbb{E} \left(|\mathscr{P}_{T(1)-1}|; |\mathscr{P}_{T(1)-1}| \ge \eta \sqrt{p} \right)}.
$$

Since $|\mathscr{P}^*|$ is assumed to have finite variance, $|\mathscr{P}_{T(1)-1}|$ has finite mean and so as $p\to\infty$ we have $\mathbb{E}(|\mathscr{P}_{T(1)-1}|; |\mathscr{P}_{T(1)-1}| \geq \eta \sqrt{p}) \to 0$. On the other hand, the fact that $R(1)$ is in the domain of attraction of a β -stable distribution and the choice of c_p (which ensures that R_{∞} has Laplace exponent λ^{β}) implies that $\sqrt{pE}(1 - e^{-2c_pR(1)}) \rightarrow 2^{\beta}$, and so we get

$$
\sqrt{p} \sum_{x \ge \eta \sqrt{p}} \mathbb{E}\left(1 - e^{-c_p A_{\xi - x}(\mathscr{P}^*)}; \xi \ge x + 1\right) \left(1 - u_p^x\right) \underset{p \to \infty}{\longrightarrow} 0.
$$

We have thus proved that for any $\eta > 0$,

$$
\limsup_{p \to \infty} \sqrt{p} \mathbb{E}\left(\left(1 - e^{-tT(1)/p}\right) \left(1 - e^{-c_p R(1)}\right)\right) \le 1 - e^{-\eta \kappa}.
$$

Letting $\eta \rightarrow 0$ concludes the proof of (IC1).

6.2 Proof of a triangular version of Theorem E

The following result extends Theorem E to a triangular setting.

Theorem E' (Triangular version of Theorem E)**.** Assume that:

- Assumptions G' and C2' are satisfied and V_p^* and $|\mathscr{P}_p^*|$ are independent;
- conditionally on $(V_p^*, |\mathscr{P}_p^*|) = (v, n)$, the locations of the atoms of \mathscr{P}_p^* are i.i.d. with common distribution $v\hat{X}_p$ for some random variable $X_p \in (0,1]$;
- $\liminf_{n} \mathbb{E}(X_n) > 0.$

Then Assumption C1' is satisfied with $c_p = v_{[1/q_p]} / \mathbb{E}(X_p)$ and $R_\infty = \mathcal{V}_\infty$, and (IC1') and (IC2') hold. In particular, Π_{∞} is the ψ/φ -snake with φ the Laplace exponent of \mathscr{V}_{∞} .

Proof. We need to check Assumption C1' and that the asymptotic independence conditions (IC1') and (IC2') hold. Let for simplicity define $\xi = |\mathscr{P}_{T(1)-1}|$. It is well-known that conditionally on $\xi = n$, $Z(1)$ is uniformly distributed on $\{0, \ldots, n-1\}$ (this can be checked from (2.2)). Given the law of (V_p^*, \mathscr{P}_p^*) , it follows that $R(1)$ conditioned on $\xi = n$ is equal in distribution to $V_p^*X_p^{(U:n)}$ where V_p^*,X_p^1,\ldots,X_p^n and U are independent, the X^k_p are i.i.d. distributed as X_p , U is uniformly distributed on $\{1,\ldots,n\}$ and $X^{(k:n)}_p$ is the k th order statistic of the $(X_p^1,\ldots,X_p^n).$ Since $X_p^{(U:n)}$ is equal in distribution to X_p by exchangeability, we obtain that $R(1)$ is independent from ξ , and thus from $T(1)$, and is equal in distribution to $V_p^*X_p$ with $V_p^*{\perp\!\!\!\perp} X_p$.

It follows that Assumption C1' is satisfied with $c_p = v_{[1/g_p]}/\mathbb{E}(X_p)$ and $R_{\infty} = \mathcal{V}_{\infty}$. The independence condition (IC1) also holds since we have just argued that

$$
\mathbb{P}_p(c_p R(1) \ge \varepsilon \mid T(1) \ge \delta p) = \mathbb{P}(c_p V_p^* X_p \ge \varepsilon) \to 0.
$$

Further, (IC2) holds since $V_p^* \!\perp\!\!\perp\! |\mathscr{P}^*_p|$ by assumption and $p g_p \to \infty.$

7 Proof of Proposition 4.1

In the following, for $m \in \mathbb{N}$, $t \geq 0$ and $p \in \mathbb{N} \cup \{\infty\}$ we define

$$
X(m) = \sup_{\{0,\ldots,m\}} S - S(m) \text{ and } X_p(t) = \sup_{[0,t]} S_p - S_p(t) = - \inf_{[0,t]} \hat{S}_p^t. \tag{7.1}
$$

To prove Proposition 4.1 we will repeatedly use the following two simple lemmas. The first lemma is obvious but the situation it considers will actually be often encountered in what follows. The second lemma follows from Lemma 2.1 and the assumption $(R_p, T_p) \Rightarrow$ (R_{∞}, T_{∞}) with $R_{\infty} \perp T_{\infty}$ (so that that R_{∞} is almost surely continuous at any random time $\Gamma \in m\sigma(T_{\infty})$). Recall also that under Assumption G' we have proved in Proposition 3.1 that $T_p^{-1}\Rightarrow T_\infty^{-1}$ which is also needed in the proof.

Lemma 7.1. If the pair (A_{∞}, B_{∞}) is the weak limit of a sequence (A_p, B_p) such that $A_p\in m\mathscr{F}_{\leq [pt]}$ and $B_p\in m\mathscr{F}_{\geq [pt]}$ for some $t\geq 0$, then $A_\infty\bot\!\!\!\bot B_\infty.$

Lemma 7.2. If Assumption G' holds and $(R_p, T_p) \Rightarrow (R_\infty, T_\infty)$ with $R_\infty \perp T_\infty$, then for any $t\geq 0$ we have $R_p\mid_{T_p^{-1}(t)}\Rightarrow R_\infty\mid_{T_\infty^{-1}(t)}$ as well as $R_p\mid_{T_p^{-1}(t)-}\Rightarrow R_\infty\mid_{T_\infty^{-1}(t)}.$

For $0 \leq s \leq t$ let

$$
\Xi^s(t)=\left(T^s_\infty\mid_{(T^s_\infty)^{-1}(t-s)^{-}},\mathscr{Z}^s_\infty\mid_{(T^s_\infty)^{-1}(t-s)^{-}}\right).
$$

Since R_p^u is distributed as R_p , the sequence (R_p^u) is tight. In the following, we will assume without loss of generality by working along appropriate subsequences that $R_p^u \Rightarrow R_\infty^u$ with R_∞^u equal in distribution to R_∞ , and that this convergence holds jointly with any other random variables needed. In particular, the R^u_∞ are assumed to live on the same probability space as all the other random variables previously defined, in particular S_{∞} and R_{∞} .

7.1 Subordinator decomposition

We first extend the snake-like property of Proposition 5.2 to the continuum. For further notice we make the following remark.

Remark 7.3. Under Assumption G', S suitably rescaled converges to a Lévy process with infinite variation and so the condition " m is not a weak record time" holds with high probability. In particular, without loss of generality and in order to avoid cumbersome statements we will henceforth assume that (5.3) always holds, thereby neglecting an event of vanishing probability.

 \Box

The main application of Proposition 5.2 is to disentangle the dependence of the subordinators $R_{\infty}, T_{\infty}, \mathscr{Z}_{\infty}$ in the past before time t and in the future after time t, where time is now measured in real time units. This is the purpose of the next result.

Proposition 7.4. For any $s \le t \in \mathbb{R}$ such that $\Delta S_{\infty}(t-s) = 0$, $(T_{\infty}^{s}, \mathscr{Z}_{\infty}^{s})$ can be expressed as a measurable function of T_∞^t , \mathscr{Z}_∞^t , $\Xi^s(t)$ and $X_\infty(t)$.

Proof. Upon shifting time, it is enough to prove the result for $s = 0$. By definition we have

$$
T_{\infty} = \left[T_{\infty}, \Theta_{T_{\infty}^{-1}(t)}(T_{\infty}) \right]_{T_{\infty}^{-1}(t) -} + \epsilon_{T_{\infty}^{-1}(t)} \Delta T_{\infty} \left(T_{\infty}^{-1}(t) \right)
$$
(7.2)

and

$$
\mathscr{Z}_{\infty} = \left[\mathscr{Z}_{\infty}, \Theta_{T_{\infty}^{-1}(t)}(\mathscr{Z}_{\infty}) \right]_{T_{\infty}^{-1}(t) -} + \epsilon_{T_{\infty}^{-1}(t)} \Delta \mathscr{Z}_{\infty} \left(T_{\infty}^{-1}(t) \right). \tag{7.3}
$$

Now we claim that the shifted processes are given by

$$
\Theta_{T_{\infty}^{-1}(t)}(T_{\infty}) = \Theta_{(\mathscr{Z}_{\infty}^t)^{-1} \circ X_{\infty}(t)}(T_{\infty}^t) \text{ and } \Theta_{T_{\infty}^{-1}(t)}(\mathscr{Z}_{\infty}) = \Theta_{(\mathscr{Z}_{\infty}^t)^{-1} \circ X_{\infty}(t)}(\mathscr{Z}_{\infty}^t)
$$
(7.4)

while the jumps are given by

$$
\Delta T_{\infty}(T_{\infty}^{-1}(t)) = T_{\infty}^t \circ (\mathscr{Z}_{\infty}^t)^{-1} \circ X_{\infty}(t) + \left(t - T_{\infty}(T_{\infty}^{-1}(t) - \right) \tag{7.5}
$$

and

$$
\Delta \mathscr{Z}_{\infty}(T_{\infty}^{-1}(t)) = \Delta \mathscr{Z}_{\infty}^{t} \left(T_{\infty}^{t} \circ (\mathscr{Z}_{\infty}^{t})^{-1} \circ X_{\infty}(t) \right). \tag{7.6}
$$

Indeed, all relations (7.4)–(7.6) hold at the discrete level, i.e., by replacing ∞ by $p < \infty$: for (7.4) this is obtained after scaling from Lemma 5.2; for (7.5) and (7.6) this comes from the fact that $T(T^{-1}(m)) - m = T^m \circ (\mathscr{Z}^m)^{-1} \circ X(m)$ which expresses the fact that, for the shifted process, the time needed to exit the "valley" straddling t is equal to the time needed to go above level $X(m)$ (see Figure 6): this directly implies (7.5) and also (7.6) because both sides then correspond to the overshoot when exiting the valley.

Since these relations hold at the discrete level, $(T_p, \mathscr{Z}_p) \Rightarrow (T_\infty, \mathscr{Z}_\infty)$ and we consider a continuity point of all the processes involved, we can invoke Lemma 2.1 to justify the passage to the limit $p = \infty$ and thus obtain (7.4)–(7.6). This completes the proof of the result. \Box

A direct consequence of the next result is that Proposition 4.1 holds for negative indices. Recall the random variables R^u_∞ introduced after Lemma 7.2, which are weak limits of the R_p^u assumed to live on the same probability space than S_{∞} .

Corollary 7.5. Assume that the assumptions of Theorem B' hold. Then for any finite set $J \subset \mathbb{R} \cap (-\infty, 0)$ we have

$$
R_{\infty} \perp \!\!\!\perp \left(\left(\mathscr{Z}_{\infty}^u, T_{\infty}^u, R_{\infty}^u \right)_{\left(T_{\infty}^u \right)^{-1}(-u)} \right)_{u \in J}, \hat{S}_{\infty}^0 \right).
$$

Proof. Let $G_{\infty} = (R_{\infty}^u \mid_{(T_{\infty}^u)^{-1}(-u)})_{u \in J}$ and $G_p = (R_p^u \mid_{(T_p^u)^{-1}(-u)^{-}})_{u \in J}$ for $p \in \mathbb{N}$. By working under appropriate subsequences, it follows from Lemma 7.2 that

$$
(G_p, \hat{S}_p^0, R_p, \mathscr{Z}_p, T_p) \Rightarrow (G_{\infty}, \hat{S}_{\infty}^0, R_{\infty}, \mathscr{Z}_{\infty}, T_{\infty})
$$

Since for finite $p\in\mathbb{N}$ we have $(G_p,\hat{S}^0_p)\in m\mathscr{F}_{< 0}$ while $(R_p,\mathscr{Z}_p,T_p)\in m\mathscr{F}_{\geq 0}$, Lemma 7.1 shows that $(G_{\infty}, \hat{S}_{\infty}^{0})\bot\!\!\!\bot (R_{\infty}, \mathscr{Z}_{\infty}, T_{\infty}).$ Since by assumption we have $R_{\infty} \bot\!\!\!\bot (\mathscr{Z}_{\infty}, T_{\infty})$, this gives further $R_\infty\bot\!\!\bot(\mathscr{Z}_\infty,T_\infty,G_\infty,\hat{S}^0_\infty).$ This finally entails the desired result as the remaining random variables $(\mathscr{Z}^u_\infty,T^u_\infty)_{u\leq 0}$ are measurable with respect to $(\mathscr{Z}_\infty,T_\infty,\hat{S}^0_\infty)$ in view of Proposition 7.4 (because $T_\infty\mid_{T_\infty^{-1}(t)-}$, $\mathscr{Z}_\infty\mid_{T_\infty^{-1}(t)-}$ and $X_\infty(t)$ are measurable with respect to \hat{S}^t_∞). \Box

Remark 7.6. Contrary to the shifted process T^s_{∞} that can be directly defined through the shifted path S^s_{∞} , the process R^s_{∞} has no other obvious definition at the continuum than its existence in terms of the limit of its discrete counterpart.

We will finally need the following result, whose proof uses the same continuity arguments as in the proof of Proposition 7.4. Note in particular (and this is rather crucial) that R_{∞} and R_{∞}^{s} are continuous at the points considered because $R_{\infty} \bot\!\bot T_{\infty}$ and $R_\infty^s\bot\!\!\bot(\mathscr{Z}_\infty^s,X_\infty(s))$. Note also that in contrast with the similar decompositions (7.2) and (7.3) for T_{∞} and \mathscr{Z}_{∞} , there is no extra atom in the decomposition of R_{∞} because of this independence structure.

Proposition 7.7. Assume that the assumptions of Theorem B' hold. Then for every $s \geq 0$, we have almost surely that

$$
R_{\infty} = \left[R_{\infty}, \Theta_{(\mathscr{Z}_{\infty}^s)^{-1} \circ X_{\infty}(s)}(R_{\infty}^s)\right]_{T_{\infty}^{-1}(s)} = \left[R_{\infty}, \Theta_{(\mathscr{Z}_{\infty}^s)^{-1} \circ X_{\infty}(s)}(R_{\infty}^s)\right]_{T_{\infty}^{-1}(s)^{-}}.\tag{7.7}
$$

7.2 Another path decomposition

The proof of Proposition 4.1 relies on one extra path decomposition presented now. We begin with the following result, which is a consequence of excursion theory applied to the process reflected at its supremum.

Lemma 7.8. Let (\mathscr{G}_t) be a filtration such that S_∞ is still a Lévy process with respect to this filtration. Fix some $\tau \geq 0$ and let $e := (S_{\infty}(t + H) - S_{\infty}(H), t \in [0, \tau - H])$ with $H = T_{\infty}(T_{\infty}^{-1}(\tau) -)$ be the last negative excursion of S_{∞} away from its supremum. If $X \in m\mathscr{G}_H$ then X and e are independent conditionally on H.

Corollary 7.9. Let $J \subset \mathbb{R}$ be any finite set with $\min J = 0$, $\tau > \max J$ and e and H defined as in the previous lemma. Then e and $R_\infty\mid_{T_\infty^{-1}(\tau)}$ are independent conditionally on the shifted/stopped processes $(\Xi^s(\tau), s \in J)$.

Proof. The main idea is to apply the previous lemma with the filtration $\mathscr{G}_t = \sigma(Z_t)$ where

$$
Z_t = \left(R_\infty\mid_{T_\infty^{-1}(t)}, S_\infty\mid_t\right), \ t \ge 0,
$$

and $X = Z_H$. We decompose the proof into two steps.

Step 1. We first prove that the assumptions of the previous result hold: by definition we have $X \in m\mathscr{G}_H$ and so we need to show that S_∞ is a Lévy process in the filtration (\mathscr{G}_t) . To do so we only have to prove that for any bounded and continuous functions f and g and any $t \geq 0$ we have

$$
\mathbb{E}\left[f\left(\Theta_t(S_\infty)\right)g\left(R_\infty\mid_{T_\infty^{-1}(t)},S_\infty\mid_t\right)\right] = \mathbb{E}\left[f\left(S_\infty\right)\right]\mathbb{E}\left[g\left(R_\infty\mid_{T_\infty^{-1}(t)},S_\infty\mid_t\right)\right].
$$

For finite p this is true as

$$
\Theta_t(S_p) \in m\mathscr{F}_{\geq [pt]} \text{ while } \left(R_p \mid_{T_p^{-1}(t)-} S_p \mid_t\right) \in m\mathscr{F}_{\leq [pt]}
$$

and so the result follows by letting $p \to \infty$.

Step 2. In the first step we have proved that the assumptions of the previous lemma hold, which gives the independence between Z_H and the excursion e conditionally on H. By definition of H, S_{∞} does not accumulate any local time at its maximum on $[H, \tau]$ and so we have $T^{-1}_\infty(\tau)=T^{-1}_\infty(H).$ Thus, we obtain the independence between

$$
\left(R_{\infty}\left|_{T_{\infty}^{-1}(\tau)},S_{\infty}\left|_{H}\right.\right)\text{ and }e\qquad(7.8)
$$

conditionally on H. Let $\sigma^* = \min\{s \in J \cup \{\tau\} : s \geq H\}$ and define

$$
A = \left(\Xi^s(\tau), s \in J \cap [0, \sigma^*)\right) \text{ and } B = \left(\Xi^s(\tau), s \in J \cap [\sigma^*, \tau]\right).
$$

Then by definition of H we have $A \in m\sigma(S_{\infty} | H)$ while $B \in m\sigma(e)$. Thus (7.8) implies that

$$
\Big(R_\infty\mid_{T^{-1}_\infty(\tau)},A\Big)\ \text{ and }\ (e,B)
$$

are independent conditionally on H. If $X \perp \!\!\! \perp (Y, Z)$, then X and Y are independent conditionally on Z: using this observation twice, we obtain from the previous independence statement that

$$
\left(R_\infty \mid_{T_\infty^{-1}(\tau)}\right) \text{ and } e
$$

are independent conditionally on (H, A, B) and so also simply conditionally on (A, B) since $H \in m\sigma(A)$. This completes the proof of the result. \Box

7.3 Proof of Proposition 4.1

We decompose the proof into several steps. The last step of the proof will use the following lemma.

Lemma 7.10. If S_1 and S_2 are two i.i.d. subordinators, then for any random time κ independent from (S_1, S_2) , $[S_1, S_2]$ _κ is distributed as S_1 and is independent of κ .

Step 0. The very first step is to show that it is enough to prove the result for finite sets J such that $0 = \min J$. Indeed, assume this is the case and consider any finite set $J \subset \mathbb{R}$ with $0 \in J$. Write $J = J_- \cup J_+$ where J_- consists of all the strictly negative indices and $J_+ \subset \mathbb{R}_+$. Lemma 7.1 implies that

$$
(R_{\infty}, (\mathscr{Z}_{\infty}^s, T_{\infty}^s)_{s \in J_+}) \perp \hat{S}_{\infty}^0
$$

and thus

$$
R_\infty{\perp\!\!\!\perp} \left(\hat{S}_\infty^0, (\mathscr{Z}_\infty^s, T_\infty^s)_{s\in J_+}\right)
$$

since we assume $R_\infty \perp \!\!\! \perp (\mathscr{Z}_\infty^s, T_\infty^s)_{s \in J_+}$. Since $\min J_+ = 0$ and $(\mathscr{Z}_\infty^u, T_\infty^u) \in m \sigma(\mathscr{Z}_\infty, T_\infty)$ $\hat{S}^0_\infty)$ for any $u\leq 0$ by Proposition 7.4 we get the desired result.

Therefore, the rest of the proof is devoted to proving that

$$
R_{\infty} \perp \left(T_{\infty}^{t}, \mathscr{Z}_{\infty}^{t} \right)_{t \in J}
$$

for any finite set $J \subset \mathbb{Q}$ with $\min J = 0$. The proof operates by induction on $|J| \geq 1$. For $|J| = 1$ this is simply $R_{\infty} \perp \!\!\! \perp (\mathscr{Z}_{\infty}, T_{\infty})$ which holds by assumption, so let $J \subset \mathbb{Q}$ be a finite set with $\min J = 0$, let $\tau > \max J$ and $J_+ = J \cup {\tau}$: assuming that $R_\infty \mathcal{L}(T_\infty^s, \mathscr{Z}_\infty^s)_{s \in J}$, the rest of the proof is devoted to proving that $R_\infty\bot\!\!\bot(\mathscr{Z}_\infty^s,T_\infty^s)_{s\in J_+}$, i.e., that

$$
\mathbb{E}\left[f\left(R_{\infty}\right)g\left((\mathscr{Z}_{\infty}^{s},T_{\infty}^{s})_{s\in J_{+}}\right)\right]=\mathbb{E}\left[f\left(R_{\infty}\right)\right]\mathbb{E}\left[g\left((\mathscr{Z}_{\infty}^{s},T_{\infty}^{s})_{s\in J_{+}}\right)\right]
$$
(7.9)

for any bounded measurable functions $f,g.$ Recall the random variables R^s_∞ introduced after Lemma 7.2 and in order to ease the notation, for $s \in J$ define

$$
\Gamma=\Theta_{(\mathscr{Z}^{\tau}_\infty)^{-1}\circ X_\infty(\tau)}(R^\tau_\infty)
$$

so that

$$
R_{\infty} = [R_{\infty}, \Gamma]_{T_{\infty}^{-1}(\tau)}
$$

in view of Proposition 7.7. We now investigate in more details the structure of this decomposition.

Step 1. A consequence of Corollary 7.5 (replacing R_{∞} with R_{∞}^{τ} and taking $u = -\tau$) is that

$$
R_\infty^{\tau} \!\perp\!\!\!\perp \left((\mathscr{Z}_\infty^s, T_\infty^s)_{s \in J_+}, R_\infty \big|_{T_\infty^{-1}(\tau)}, X_\infty(\tau)\right).
$$

As R_∞^τ is a β -stable subordinator, this entails that Γ is a β -stable subordinator indepen- $\det \mathrm{from} \, \Bigl((\mathscr{Z}^{s}_{\infty}, T^{s}_{\infty})_{s \in J_{+}}, R_{\infty} \,|_{T^{-1}_{\infty}(\tau)} \Bigr).$

Step 2. In this step we prove that

$$
\mathbb{E}\left[f\left(R_{\infty}|_{T_{\infty}^{-1}(\tau)}\right) \mid (\mathscr{Z}_{\infty}^{s}, T_{\infty}^{s})_{s \in J_{+}}\right] = \mathbb{E}\left[f\left(R_{\infty}|_{T_{\infty}^{-1}(\tau)}\right) \mid T_{\infty}^{-1}(\tau)\right].
$$
 (7.10)

To prove this we will use the following independence and measurability results:

$$
\left(R_{\infty}|_{T_{\infty}^{-1}(\tau)}, (\Xi^s(\tau), X_{\infty}^s(\tau - s))_{s \in J}\right) \perp \!\!\! \perp (\mathscr{Z}_{\infty}^{\tau}, T_{\infty}^{\tau}) \tag{7.11}
$$

as a consequence of Lemma 7.1, and

$$
(X_{\infty}^s(\tau - s), s \in J_+) \in m\sigma(e) \tag{7.12}
$$

where e is defined as in Corollary 7.9. Indeed, either e does not straddle s and then $X^s_\infty(\tau - s) = -\min e$, or e straddles s and then $X^s_\infty(\tau - s)$ can be computed from e .

Let us now proceed with the proof of (7.10). By shifting at time s, Proposition 7.4 implies that for any $s \in J$ we have

$$
(\mathscr{Z}^{s}_{\infty},T^{s}_{\infty})\in m\sigma\left(\mathscr{Z}^{\tau}_{\infty},T^{r}_{\infty},\Xi^{s}(\tau),X^{s}_{\infty}(\tau-s)\right)
$$

and thus

$$
\mathscr{Z}_{\infty}^{s}, T_{\infty}^{s})_{s \in J_{+}} \in m\sigma \left(\mathscr{Z}_{\infty}^{\tau}, T_{\infty}^{\tau}, (\Xi^{s}(\tau), X_{\infty}^{s}(\tau - s))_{s \in J} \right).
$$

In particular, the law of total expectation gives

$$
\mathbb{E}\left[f\left(R_{\infty}\mid_{T_{\infty}^{-1}(\tau)}\right)\mid(\mathscr{Z}_{\infty}^{s},T_{\infty}^{s})_{s\in J_{+}}\right]
$$
\n
$$
=\mathbb{E}\left(\mathbb{E}\left[f\left(R_{\infty}\mid_{T_{\infty}^{-1}(\tau)}\right)\mid\mathscr{Z}_{\infty}^{\tau},T_{\infty}^{\tau},(\Xi^{s}(\tau),X_{\infty}^{s}(\tau-s))_{s\in J}\right]\mid(\mathscr{Z}_{\infty}^{s},T_{\infty}^{s})_{s\in J_{+}}\right).
$$
\n(7.13)

Next, if $X \perp \!\!\! \perp (Y, Z)$, then X and Y are independent conditionally on Z: using this observation with the independence relation (7.11) allows to get rid of $(\mathscr{Z}^\tau_\infty, T^\tau_\infty)$ in the conditioning, i.e.,

$$
\mathbb{E}\left[f\left(R_{\infty}\left|_{T_{\infty}^{-1}(\tau)}\right)\mid \mathscr{Z}_{\infty}^{\tau},T_{\infty}^{\tau},\left(\Xi^{s}(\tau),X_{\infty}^{s}(\tau-s)\right)_{s\in J}\right]\right]
$$
\n
$$
=\mathbb{E}\left[f\left(R_{\infty}\left|_{T_{\infty}^{-1}(\tau)}\right)\mid \left(\Xi^{s}(\tau),X_{\infty}^{s}(\tau-s)\right)_{s\in J}\right]\right]
$$

which leads further to

$$
\mathbb{E}\left[f\left(R_{\infty}\mid_{T_{\infty}^{-1}(\tau)}\right)\mid \mathscr{Z}_{\infty}^{\tau},T_{\infty}^{\tau},\left(\Xi^{s}(\tau),X_{\infty}^{s}(\tau-s)\right)_{s\in J}\right] = \mathbb{E}\left[f\left(R_{\infty}\mid_{T_{\infty}^{-1}(\tau)}\right)\mid (\Xi^{s}(\tau))_{s\in J}\right]
$$

according to Corollary 7.9 and (7.12). At this point, we have therefore proved that

$$
\mathbb{E}\left[f\left(R_{\infty}\mid_{T_{\infty}^{-1}(\tau)}\right) \mid \mathscr{Z}_{\infty}^{\tau}, T_{\infty}^{\tau}, \left(\Xi^{s}(\tau), X_{\infty}^{s}(\tau-s)\right)_{s\in J}\right] = \mathbb{E}\left[f\left(R_{\infty}\mid_{T_{\infty}^{-1}(\tau)}\right) \mid (\Xi^{s}(\tau))_{s\in J}\right]
$$

and since

and since

$$
(\Xi^s(\tau))_{s \in J} \in m\sigma(\mathscr{Z}_{\infty}^s, T_{\infty}^s, s \in J) \subset m\sigma(\mathscr{Z}_{\infty}^s, T_{\infty}^s, s \in J_+),\tag{7.14}
$$

(7.13) implies that

$$
\mathbb{E}\left[f\left(R_{\infty}\mid_{T_{\infty}^{-1}(\tau)}\right)\mid(\mathscr{Z}_{\infty}^s,T_{\infty}^s)_{s\in J_{+}}\right]=\mathbb{E}\left[f\left(R_{\infty}\mid_{T_{\infty}^{-1}(\tau)}\right)\mid(\Xi^s(\tau))_{s\in J}\right]
$$

Height and contour processes of Crump-Mode-Jagers forests (II)

Let us now evaluate the right-hand side of the latter identity. Since $(R_\infty)\bot (\mathscr{Z}_\infty^s,T_\infty^s)_{s\in J}$ by induction hypothesis and because of (7.14), we get that $R_{\infty}\mid_{T^{-1}_{\infty}(\tau)}$ only depends on $(\Xi^s(\tau), s \in J)$ through $T^{-1}_{\infty}(\tau)$, i.e.,

$$
\mathbb{E}\left[f\left(R_{\infty}\mid_{T_{\infty}^{-1}(\tau)}\right) \mid (\Xi^s(\tau))_{s\in J}\right] = \mathbb{E}\left[f\left(R_{\infty}\mid_{T_{\infty}^{-1}(\tau)}\right) \mid T_{\infty}^{-1}(\tau)\right].
$$

This concludes the proof of this step.

Step 3. We now conclude the proof: Step 1 and (7.10) entail, using total expectation,

$$
\begin{split} \mathbb{E}\left[f\left(R_{\infty}\right)g\left((\mathscr{Z}_{\infty}^{s},T_{\infty}^{s})_{s\in J_{+}}\right)\right] \\ & =\mathbb{E}\left[f\left(\left[R_{\infty}\mid_{T_{\infty}^{-1}\left(\tau\right)},\Gamma\right]\right)g\left((\mathscr{Z}_{\infty}^{s},T_{\infty}^{s})_{s\in J_{+}}\right)\right] \\ & =\mathbb{E}\left[g\left((\mathscr{Z}_{\infty}^{s},T_{\infty}^{s})_{s\in J_{+}}\right)\mathbb{E}\left[f\left(\left[R_{\infty}\mid_{T_{\infty}^{-1}\left(\tau\right)},\Gamma\right]\right)\mid(\mathscr{Z}_{\infty}^{s},T_{\infty}^{s})_{s\in J_{+}}\right]\right] \\ & =\mathbb{E}\left[g\left((\mathscr{Z}_{\infty}^{s},T_{\infty}^{s})_{s\in J_{+}}\right)\mathbb{E}\left[f\left(\left[R_{\infty}\mid_{T_{\infty}^{-1}\left(\tau\right)},\Gamma\right]\right)\mid T_{\infty}^{-1}\left(\tau\right)\right]\right]. \end{split}
$$

At this point we want to apply Lemma 7.10. We first note that $\big(R_\infty\mid_{(T^s_\infty)^{-1}(\tau)},\Gamma\big)$ is equal in distribution to $\left(R_\infty\mid_{(T_\infty^s)^{-1}(\tau)},\tilde\Gamma\right)$ where $\tilde\Gamma$ is independent of (R_∞,T_∞) according to Step 1. Further, since $R_\infty \bot\!\bot T_\infty$, it follows that R_∞ , $\tilde{\Gamma}$ and T_∞ are mutually independent. Finally, applying Lemma 7.10 with S_1 = R_{∞} , S_2 = $\tilde{\Gamma}$ and κ = $T_{\infty}^{-1}(\tau)$ we get that $[R_\infty\mid_{T^{-1}_\infty(\tau)},\tilde\Gamma]$ is equal in distribution to R_∞ and is independent from $T^{-1}_\infty(\tau)$, i.e.,

$$
\mathbb{E}\left[\mathbb{E}\left[f\left(\left[R_\infty\mid_{T_\infty^{-1}(\tau)},\tilde{\Gamma}\right]\right)\mid T_\infty^{-1}(\tau)\right]\right] = \mathbb{E}\left[f\left(R_\infty\right)\right].
$$

This concludes the proof of Proposition 4.1.
