# COMPLEMENTED COPIES OF $c_{0}(\tau)$ IN TENSOR PRODUCTS OF $L_{p}[0,1]$

#### Abstract

Let $X$ be a Banach space and $\tau$ an infinite cardinal. We show that if $\tau$ has uncountable cofinality, $p \in[1, \infty)$ and either the Lebesgue-Bochner space $L_{p}([0,1], X)$ or the injective tensor product $L_{p}[0,1] \widehat{\otimes}_{\varepsilon} X$ contains a complemented copy of $c_{0}(\tau)$, then so does $X$. We show also that if $p \in(1, \infty)$ and the projective tensor product $L_{p}[0,1] \widehat{\otimes}_{\pi} X$ contains a complemented copy of $c_{0}(\tau)$, then so does $X$.


## 1. Introduction and Preliminaries

We use standard set-theoretical and Banach space theory terminology as may be found, e.g., in [16] and [17]. We denote by $B_{X}$ the closed unit ball of the Banach space X . If $X$ and $Y$ are Banach spaces, we denote by $\mathcal{L}(X, Y)$ the space of all bounded linear operators from $X$ to $Y$ and by $\mathcal{K}(X, Y)$ the subspace of all compact linear operators. We say that $Y$ contains a copy (resp. a complemented copy) of $X$, and write $X \hookrightarrow Y$ (resp. $X \stackrel{c}{\hookrightarrow} Y$ ), if $X$ is isomorphic to a subspace (resp. complemented subspace) of $Y$. The density character of $X$, denoted by dens $(X)$, is the smallest cardinality of a dense subset of $X$.

A Banach space $X$ has the bounded approximation property if there exists $\lambda>0$ such that, for every compact subset $K$ of $X$ and every $\varepsilon>0$, there exists a finite rank operator $T: X \rightarrow X$ such that $\|T\| \leq \lambda$ and $\|x-T(x)\|<$ $\varepsilon$, for every $x \in K$.

We shall denote the projective and injective tensor norms by $\|\cdot\|_{\pi}$ and $\|\cdot\|_{\varepsilon}$ respectively. The projective (resp. injective) tensor product of $X$ and $Y$ is the completion of $X \otimes Y$ with respect to $\|\cdot\|_{\pi}\left(\right.$ resp. $\left.\|\cdot\|_{\varepsilon}\right)$ and will be denoted by $X \widehat{\otimes}_{\pi} Y$ (resp. $X \widehat{\otimes}_{\varepsilon} Y$ ).

For a non-empty set $\Gamma, c_{0}(\Gamma)$ denotes the Banach space of all real-valued maps $f$ on $\Gamma$ with the property that for each $\varepsilon>0$, the set $\{\gamma \in \Gamma:|f(\gamma)| \geq$ $\varepsilon\}$ is finite, equipped with the supremum norm. We will refer to $c_{0}(\Gamma)$ as $c_{0}(\tau)$ when the cardinality of $\Gamma$ (denoted by $\left.|\Gamma|\right)$ is equal to $\tau$. This space will be denoted by $c_{0}$ when $\tau=\aleph_{0}$. By $\ell_{\infty}(\Gamma)$ we will denote the Banach space of all bounded real-valued maps on $\Gamma$, with the supremum norm. This space will be denoted by $\ell_{\infty}$ when $\Gamma=\mathbb{N}$.

Given $X$ a Banach space and $p \in[1, \infty)$, we denote by $L_{p}([0,1], X)$ the Lebesgue-Bochner space of all (classes of equivalence of) measurable

[^0]functions $f:[0,1] \rightarrow X$ such that the scalar function $\|f\|^{p}$ is integrable, equipped with the complete norm
$$
\|f\|_{p}=\left[\int_{0}^{1}\|f(t)\|^{p} d t\right]^{\frac{1}{p}}
$$

These spaces will be denoted by $L_{p}[0,1]$ when $X=\mathbb{R}$.
A measurable function $f:[0,1] \rightarrow X$ is essentially bounded if there exists $\varepsilon>0$ such that the set $\{t \in[0,1]:\|f(t)\| \geq \varepsilon\}$ has Lebesgue measure zero, and we denote by $\|f\|_{\infty}$ the infimum of all such numbers $\varepsilon>0$. By $L_{\infty}([0,1], X)$ we will denote the space of all (classes of equivalence of) essentially bounded functions $f:[0,1] \rightarrow X$, equipped with the complete norm $\|\cdot\|_{\infty}$.

Recall that if $\tau$ is an infinite cardinal then the cofinality of $\tau$, denoted by $\operatorname{cf}(\tau)$, is the least cardinal $\alpha$ such that there exists a family of ordinals $\left\{\beta_{j}: j \in \alpha\right\}$ satisfying $\beta_{j}<\tau$ for all $j \in \alpha$, and $\sup \left\{\beta_{j}: j \in \alpha\right\}=\tau$. A cardinal $\tau$ is said to be regular when $\operatorname{cf}(\tau)=\tau$; otherwise, it is said to be singular.

Many papers in the history of the geometry of Banach spaces have been devoted to establish results about when certain Banach spaces contain complemented copies of $c_{0}$ or $c_{0}(\tau)$ for uncountable cardinals $\tau$, see for example $[1,2,6,7,12,26,27]$. The starting points of our research are three of these results related to the space $c_{0}$, i.e., Theorems 1,2 and 3 below.

We begin by recalling the following immediate consequence of the classical Cembranos-Freniche Theorem [6, Main Theorem], [14, Corollary 2.5].

Theorem 1. For each $p \in[1, \infty), c_{0} \stackrel{c}{\hookrightarrow} L_{p}[0,1] \widehat{\otimes}_{\varepsilon} \ell_{\infty}$.
However, $c_{0} \stackrel{\leftrightarrows}{\leftrightarrows} \ell_{\infty}$ (see, e. g., [10, Corollary 11, p. 156]).
On the other hand, Oja proved the following stability property.
Theorem 2 ([22], Theorem 3b). If $X$ is a Banach space and $p \in(1, \infty)$, then

$$
c_{0} \stackrel{c}{\hookrightarrow} L_{p}[0,1] \widehat{\otimes}_{\pi} X \Longrightarrow c_{0} \stackrel{c}{\hookrightarrow} X .
$$

Observe that Theorem 2 does not hold for $p=1$. Indeed, $L_{1}([0,1], X)$ is linearly isometric to $L_{1}[0,1] \hat{\otimes}_{\pi} X$ [24, Example 2.19, p. 29] and Emmanuele obtained the following result.
Theorem 3 ([12], Main Theorem). If $X$ is a Banach space and $p \in[1, \infty)$, then

$$
c_{0} \hookrightarrow X \Longrightarrow c_{0} \stackrel{c}{\hookrightarrow} L_{p}([0,1], X)
$$

So, in particular, $L_{p}\left([0,1], \ell_{\infty}\right)$ contains a complemented copy of $c_{0}$, but once again $c_{0} \stackrel{q}{\leftrightarrows} \ell_{\infty}$.

We recall also that, denoting by $\|\cdot\|_{\Delta_{p}}$ the natural tensor norm induced on $L_{p}[0,1] \otimes X$ by $L_{p}([0,1], X)$ and by $L_{p}[0,1] \widehat{\otimes}_{\Delta_{p}} X$ the completion of $L_{p}[0,1] \otimes X$ with this norm, the space $L_{p}([0,1], X)$ is linearly isometric to $L_{p}[0,1] \widehat{\otimes}_{\Delta_{p}} X$ [9, Chapters 7.1 and 7.2].

Thus, the above facts naturally lead us to the following problem.

Problem 4. Let $X$ be a Banach space, $p \in[1, \infty)$ and $\tau$ be an infinite cardinal. Under which conditions

$$
c_{0}(\tau) \stackrel{c}{\hookrightarrow} L_{p}[0,1] \widehat{\otimes}_{\alpha} X \Longrightarrow c_{0}(\tau) \stackrel{c}{\hookrightarrow} X,
$$

where $\alpha$ denotes either the projective, injective or natural norm?
This problem becomes more interesting if we keep in mind that, in general, it is not so simple to determine whether the tensor products of $E$ and $X$ contain complemented copies of a certain space $F$, even when $E$ contains no complemented copies of $F$. Indeed, there are a number of elementary questions about this topic that remain unanswered. For instance, it is not known whether $l_{\infty} \widehat{\otimes}_{\pi} l_{\infty}$ contains a complemented copy of $c_{0}$ or not [4, Remark 3].

In the present paper, we will prove that for every Banach space $X$, $p \in(1, \infty)$ and an infinite cardinal $\tau$,

$$
c_{0}(\tau) \stackrel{c}{\hookrightarrow} L_{p}[0,1] \widehat{\otimes}_{\pi} X \Longrightarrow c_{0}(\tau) \stackrel{c}{\hookrightarrow} X .
$$

Additionally, if $\tau$ has uncountable cofinality, then for every $p \in[1, \infty)$

$$
c_{0}(\tau) \stackrel{c}{\hookrightarrow} L_{p}[0,1] \widehat{\otimes}_{\varepsilon} X \Longrightarrow c_{0}(\tau) \stackrel{c}{\hookrightarrow} X,
$$

and

$$
c_{0}(\tau) \stackrel{c}{\hookrightarrow} L_{p}([0,1], X) \Longrightarrow c_{0}(\tau) \stackrel{c}{\hookrightarrow} X .
$$

This paper is organized as follows. We study complemented copies of $c_{0}(\tau)$ in the injective (Section 2), projective (Section 3) and natural (Section 4) tensor products with $L_{p}[0,1]$.

## 2. Complemented copies of $c_{0}(\tau)$ in $X \hat{\otimes}_{\varepsilon} Y$ spaces

The goal of this section is to prove Theorem 7 . We recall that given Banach spaces $X$ and $Y$, the operator $S: X \hat{\otimes}_{\varepsilon} Y \rightarrow \mathcal{K}\left(X^{*}, Y\right)$ satisfying

$$
S(v)\left(x^{*}\right)=\sum_{i=1}^{j} x^{*}\left(a_{i}\right) b_{i}
$$

for every $x^{*} \in X^{*}$ and $v=\sum_{i=1}^{j} a_{i} \otimes b_{i} \in X \otimes Y$, is a linear isometry onto its image.

We will need the following key lemma.
Lemma 5. Let $X$ and $Y$ be Banach spaces. Suppose that $X$ has the bounded approximation property. Then there exist sets $A \subset X$ and $B \subset X^{*}$ such that $\max (|A|,|B|) \leq \operatorname{dens}(X)$ and for every $u \in X \hat{\otimes}_{\varepsilon} Y$ and $\delta>0$ there exist $x_{1}, \ldots, x_{m} \in A$ and $\varphi_{1}, \ldots, \varphi_{m} \in B$ satisfying

$$
\left\|u-\sum_{n=1}^{m} x_{n} \otimes S(u)\left(\varphi_{n}\right)\right\|_{\varepsilon}<\delta .
$$

Proof. By hypothesis, there exists $\lambda \geq 1$ such that for every finite dimensional subspace $Z$ of $X$ there exists a finite rank operator $T$ on $X$ such that $\|T\| \leq \lambda$ and $T(x)=x$ for all $x \in Z$ [5, Theorem 3.3.(3), p. 288].

Let $D$ be a dense subset of $X$ with $|D|=\operatorname{dens}(X)$ and let $\mathcal{F}$ be the family of all finite, non-empty subsets of $D$. For each $F \in \mathcal{F}$, fix a finite
rank operator $T_{F}$ on $X$ such that $\left\|T_{F}\right\| \leq \lambda$ and $T_{F}(d)=d$ for all $d \in F$. Let $m_{F}$ be the dimension of $T_{F}(X),\left\{x_{1}^{F}, \ldots, x_{m_{F}}^{F}\right\}$ be a basis of $T_{F}(X)$ and $\varphi_{1}^{F}, \ldots, \varphi_{m_{F}}^{F} \in X^{*}$ such that

$$
T_{F}(x)=\sum_{n=1}^{m_{F}} \varphi_{n}^{F}(x) x_{n}^{F}
$$

for every $x \in X$. Define

$$
A=\bigcup_{F \in \mathcal{F}}\left\{x_{1}^{F}, \ldots, x_{m_{F}}^{F}\right\} \quad \text { and } \quad B=\bigcup_{F \in \mathcal{F}}\left\{\varphi_{1}^{F}, \ldots, \varphi_{m_{F}}^{F}\right\} .
$$

We claim that $A$ and $B$ have the desired properties. Indeed, notice that

$$
|A| \leq|\mathcal{F}| \sup _{F \in \mathcal{F}}\left|\left\{x_{1}^{F}, \ldots, x_{m_{F}}^{F}\right\}\right| \leq \max \left(|D|, \aleph_{0}\right)=|D|
$$

and similarly $|B| \leq|D|$.
Next, let $u \in X \hat{\otimes}_{\varepsilon} Y$ and $\delta>0$ be given. There exists $v=\sum_{j=1}^{k} d_{j} \otimes y_{j} \in$ $X \otimes Y$ such that $d_{1}, \ldots, d_{k} \in D, d_{i} \neq d_{j}$ if $i \neq j$, and

$$
\|u-v\|_{\varepsilon}<\frac{\delta}{\lambda+1} .
$$

Writing $G=\left\{d_{1}, \ldots, d_{k}\right\}$, we see that

$$
\sum_{n=1}^{m_{G}} x_{n}^{G} \otimes S(v)\left(\varphi_{n}^{G}\right)=\sum_{j=1}^{k}\left(\sum_{n=1}^{m_{G}} \varphi_{n}^{G}\left(d_{j}\right) x_{n}^{G}\right) \otimes y_{j}=\sum_{j=1}^{k} T_{G}\left(d_{j}\right) \otimes y_{j}=v
$$

Furthermore, since

$$
\left\|\sum_{n=1}^{m_{G}} x_{n}^{G} \otimes \varphi_{n}^{G}\right\|_{\varepsilon}=\sup _{x \in B_{X}}\left\|\sum_{n=1}^{m_{G}} \varphi_{n}^{G}(x) x_{n}^{G}\right\|=\left\|T_{G}\right\| \leq \lambda,
$$

we obtain

$$
\begin{aligned}
\left\|\sum_{n=1}^{m_{G}} x_{n}^{G} \otimes S(u-v)\left(\varphi_{n}^{G}\right)\right\|_{\varepsilon} & =\sup _{x^{*} \in B_{X^{*}}}\left\|\sum_{n=1}^{m_{G}} x^{*}\left(x_{n}^{G}\right) S(u-v)\left(\varphi_{n}^{G}\right)\right\| \\
& \leq\|u-v\|_{\varepsilon} \sup _{x^{*} \in B_{X^{*}}}\left\|\sum_{n=1}^{m_{G}} x^{*}\left(x_{n}^{G}\right)\left(\varphi_{n}^{G}\right)\right\| \\
& <\frac{\delta}{\lambda+1}\left\|\sum_{n=1}^{m_{G}} x_{n}^{G} \otimes \varphi_{n}^{G}\right\|_{\varepsilon} \leq \frac{\lambda \delta}{\lambda+1} .
\end{aligned}
$$

Thus,

$$
\left\|u-\sum_{n=1}^{m_{G}} x_{n}^{G} \otimes S(u)\left(\varphi_{n}^{G}\right)\right\|_{\varepsilon}<\delta
$$

and we are done.
The following result obtained in [8] will also be used frequently throughout this work.

Theorem 6 ([8], Theorem 2.4). Let $X$ be a Banach space and $\tau$ be an infinite cardinal. The following are equivalent:
(1) $X$ contains a complemented copy of $c_{0}(\tau)$.
(2) There exist a family $\left(x_{j}\right)_{j \in \tau}$ equivalent to the unit-vector basis of $c_{0}(\tau)$ in $X$ and a weak*-null family $\left(x_{j}^{*}\right)_{j \in \tau}$ in $X^{*}$ such that, for each $j, k \in \tau$,

$$
x_{j}^{*}\left(x_{k}\right)=\delta_{j k} .
$$

(3) There exist a family $\left(x_{j}\right)_{j \in \tau}$ equivalent to the unit-vector basis of $c_{0}(\tau)$ in $X$ and a weak ${ }^{*}$-null family $\left(x_{j}^{*}\right)_{j \in \tau}$ in $X^{*}$ such that

$$
\inf _{j \in \tau}\left|x_{j}^{*}\left(x_{j}\right)\right|>0
$$

Theorem 7. Let $X$ and $Y$ be Banach spaces and $\tau$ be an infinite cardinal. If $X$ has the bounded approximation property and $\operatorname{cf}(\tau)>\operatorname{dens}(X)$, then

$$
c_{0}(\tau) \stackrel{c}{\hookrightarrow} X \hat{\otimes}_{\varepsilon} Y \Longrightarrow c_{0}(\tau) \stackrel{c}{\hookrightarrow} Y .
$$

Proof. Let $A \subset X$ and $B \subset X^{*}$ be the sets provided by Lemma 5. By Theorem 6, there exist families $\left(u_{i}\right)_{i \in \tau}$ in $X \hat{\bigotimes}_{\varepsilon} Y$ and $\left(\psi_{i}\right)_{i \in \tau}$ in $\left(X \hat{\otimes}_{\varepsilon} Y\right)^{*}$ such that $\left(u_{i}\right)_{i \in \tau}$ is equivalent to the usual unit-vector basis of $c_{0}(\tau),\left(\psi_{i}\right)_{i \in \tau}$ is weak ${ }^{*}$-null and $\psi_{i}\left(u_{j}\right)=\delta_{i j}$, for each $i, j \in \tau$. Let $s=\sup _{i \in \tau}\left\|\psi_{i}\right\|<\infty$.

For each $i \in \tau$ there exist $x_{1}^{i}, \ldots, x_{m_{i}}^{i} \in A$ and $\varphi_{1}^{i}, \ldots, \varphi_{m_{i}}^{i} \in B$ such that

$$
\left\|u_{i}-\sum_{n=1}^{m_{i}} x_{n}^{i} \otimes S\left(u_{i}\right)\left(\varphi_{n}^{i}\right)\right\|_{\varepsilon}<\frac{1}{2 s}
$$

and hence

$$
\frac{1}{2}<\sum_{n=1}^{m_{i}}\left|\psi_{i}\left(x_{n}^{i} \otimes S\left(u_{i}\right)\left(\varphi_{n}^{i}\right)\right)\right| .
$$

Put $\mathcal{M}=\left\{m_{i}: i \in \tau\right\}$ and for each $m \in \mathcal{M}$ define $\alpha_{m}=\left\{i \in \tau: m_{i}=m\right\}$. Since $\mathcal{M}$ is countable and $\tau$ has uncountable cofinality, there exists $M \in \mathcal{M}$ such that $\left|\alpha_{M}\right|=\tau$. Setting $\tau_{1}=\alpha_{M}$, we have

$$
\frac{1}{2}<\sum_{n=1}^{M}\left|\psi_{i}\left(x_{n}^{i} \otimes S\left(u_{i}\right)\left(\varphi_{n}^{i}\right)\right)\right|, \forall i \in \tau_{1}
$$

Next, for each $i \in \tau_{1}$ there exists $1 \leq n_{i} \leq M$ satisfying

$$
\frac{1}{2 M}<\left|\psi_{i}\left(x_{n_{i}}^{i} \otimes S\left(u_{i}\right)\left(\varphi_{n_{i}}^{i}\right)\right)\right| .
$$

Let $\mathcal{N}=\left\{n_{i}: i \in \tau_{1}\right\}$ and for each $n \in \mathcal{N}$ consider $\beta_{n}=\left\{i \in \tau_{1}: n_{i}=n\right\}$. Since $\mathcal{N}$ is finite, there exists $N \in \mathcal{N}$ such that $\left|\beta_{N}\right|=\tau$. Setting $\tau_{2}=\beta_{N}$, we obtain

$$
\frac{1}{2 M}<\left|\psi_{i}\left(x_{N}^{i} \otimes S\left(u_{i}\right)\left(\varphi_{N}^{i}\right)\right)\right|, \forall i \in \tau_{2}
$$

Now let $\mathcal{A}=\left\{x_{N}^{i}: i \in \tau_{2}\right\}$ and for each $a \in \mathcal{A}$ put $\gamma_{a}=\left\{i \in \tau_{2}: x_{N}^{i}=a\right\}$. Since $\operatorname{cf}(\tau)>\operatorname{dens}(X) \geq|\mathcal{A}|$, there exists $x_{0} \in \mathcal{A}$ such that $\left|\gamma_{x_{0}}\right|=\tau$. Setting $\tau_{3}=\gamma_{x_{0}}$, we get

$$
\frac{1}{2 M}<\left|\psi_{i}\left(x_{0} \otimes S\left(u_{i}\right)\left(\varphi_{N}^{i}\right)\right)\right|, \forall i \in \tau_{3} .
$$

Finally, let $\mathcal{B}=\left\{\varphi_{N}^{i}: i \in \tau_{3}\right\}$ and for each $\varphi \in \mathcal{B}$ put $\lambda_{\varphi}=\left\{i \in \tau_{3}: \varphi_{N}^{i}=\right.$ $\varphi\}$. Since $\operatorname{cf}(\tau)>\operatorname{dens}(X) \geq|\mathcal{B}|$, there exists $\varphi_{0} \in \mathcal{B}$ such that $\left|\lambda_{\varphi_{0}}\right|=\tau$. Setting $\tau_{4}=\lambda_{\varphi_{0}}$, we obtain

$$
\begin{equation*}
\frac{1}{2 M}<\left|\psi_{i}\left(x_{0} \otimes S\left(u_{i}\right)\left(\varphi_{0}\right)\right)\right|, \forall i \in \tau_{4} . \tag{2.1}
\end{equation*}
$$

For each $i \in \tau_{4}$, write $y_{i}=S\left(u_{i}\right)\left(\varphi_{0}\right) \in Y$ and consider the linear functional $y_{i}^{*} \in Y^{*}$ defined by $y_{i}^{*}(y)=\psi_{i}\left(x_{0} \otimes y\right)$, for every $y \in Y$. By (2.1), we have

$$
\frac{1}{2 M}<\left|y_{i}^{*}\left(y_{i}\right)\right| \leq\left\|\psi_{i}\right\|\left\|x_{0}\right\|\left\|y_{i}\right\| \leq s\left\|x_{0}\right\|\left\|y_{i}\right\|, \forall i \in \tau_{4}
$$

and therefore

$$
\begin{equation*}
\frac{1}{2 M s\left\|x_{0}\right\|}<\left\|y_{i}\right\|, \forall i \in \tau_{4} . \tag{2.2}
\end{equation*}
$$

Denote by $\left(e_{i}\right)_{i \in \tau}$ the unit-vector basis of $c_{0}(\tau)$ and let $T: c_{0}(\tau) \rightarrow$ $X \hat{\otimes}_{\varepsilon} Y$ be an isomorphism from $c_{0}(\tau)$ onto its image such that $T\left(e_{i}\right)=u_{i}$, for each $i \in \tau$. Consider $P: X \hat{\otimes}_{\varepsilon} Y \rightarrow Y$ the linear operator defined by $P(u)=S(u)\left(\varphi_{0}\right)$, for every $u \in X \hat{\otimes}_{\varepsilon} Y$. The inequality (2.2) then yields

$$
\left\|(P \circ T)\left(e_{i}\right)\right\|=\left\|y_{i}\right\| \geq \frac{1}{2 M s\left\|x_{0}\right\|}>0, \forall i \in \tau_{4}
$$

and thus, by [23, Remark following Theorem 3.4], there exists $\tau_{5} \subset \tau_{4}$ such that $\left|\tau_{5}\right|=\tau$ and $P \circ T_{c_{0}\left(\tau_{5}\right)}$ is an isomophism onto its image. This shows that $\left(y_{i}\right)_{i \in \tau_{5}}=\left(P\left(T\left(e_{i}\right)\right)_{i \in \tau_{5}}\right.$ is equivalent to the unit-vector basis of $c_{0}\left(\tau_{5}\right)$ in $Y$. Notice also that

$$
\left(y_{i}^{*}(y)\right)_{i \in \tau_{5}}=\left(\psi_{i}\left(x_{0} \otimes y\right)\right)_{i \in \tau_{5}} \in c_{0}\left(\tau_{5}\right), \forall y \in Y
$$

since $\left(\psi_{i}\right)_{i \in \tau}$ is weak*-null by hypothesis. Thus, $\left(y_{i}^{*}\right)_{i \in \tau_{5}}$ is weak*-null in $Y^{*}$. Combining these facts with (2.1), an appeal to Theorem 6 yields a complemented copy of $c_{0}(\tau)$ in $Y$.

Note that according to Theorem 1 the above result is optimal. Moreover, Theorem 7 does not hold for cardinals with uncountable cofinality equal to the density of $X$. Indeed, by [15, Theorem 4.5] it follows that $c_{0}(\tau) \stackrel{c}{\hookrightarrow} \ell_{1}(\tau) \hat{\otimes}_{\varepsilon} \ell_{\infty}(\tau)$, however according to [10, Corollary 11, p. 156] $c_{0}(\tau) \stackrel{q}{\leftrightarrows} \ell_{\infty}(\tau)$.

As a direct application of Theorem 7, we have:
Corollary 8. Let $X$ be a Banach space, $p \in[1, \infty)$ and $\tau$ an infinite cardinal with $\operatorname{cf}(\tau)>\aleph_{0}$. Then

$$
c_{0}(\tau) \stackrel{c}{\hookrightarrow} L_{p}[0,1] \hat{\otimes}_{\varepsilon} X \Longrightarrow c_{0}(\tau) \stackrel{c}{\hookrightarrow} X .
$$

3. Complemented copies of $c_{0}(\tau)$ in $L_{p}[0,1] \hat{\otimes}_{\pi} X$ spaces

We will use a convenient characterization of $L_{p}[0,1] \hat{\otimes}_{\pi} X$ as a sequence space.
3.1. The spaces $L_{p}^{\text {weak }}(X)$ and $L_{p}\langle X\rangle$. We will denote by $\left(\chi_{n}\right)_{n \geq 1}$ the Haar system, that is, the sequence of functions defined on $[0,1]$ by $\chi_{1}(\bar{t})=1$, for every $t \in[0,1]$, and

$$
\chi_{2^{k}+j}(t)=\left\{\begin{array}{cl}
1, & \text { if } t \in\left[\frac{2 j-2}{2^{k+1}}, \frac{2 j-1}{2^{k+1}}\right) \\
-1, & \text { if } t \in\left[\frac{2 j-1}{2^{k+1}}, \frac{2 j}{2^{k+1}}\right) \\
0, & \text { otherwise, }
\end{array}\right.
$$

for each $k \geq 0$ and $1 \leq j \leq 2^{k}$. It is well known (see [18, p. 3], [19, p. 155]) that the Haar system is an unconditional basis of $L_{p}[0,1], p \in(1, \infty)$, and we will denote its unconditional basis constant by $K_{p}$. Following [3,11], we renorm $L_{p}[0,1]$ by

$$
\|f\|_{p}^{\mathrm{new}}=\sup \left\{\left\|\sum_{n=1}^{\infty} \theta_{n} \alpha_{n} \chi_{n}\right\|_{p}: \theta_{n}= \pm 1, n \geq 1\right\}
$$

for each $f=\sum_{n=1}^{\infty} \alpha_{n} \chi_{n} \in L_{p}[0,1]$. Then

$$
\|\cdot\|_{p} \leq\|\cdot\|_{p}^{\text {new }} \leq K_{p}\|\cdot\|_{p}
$$

and $\left(\chi_{n}\right)_{n \geq 1}$ is a monotone, unconditional basis with respect to $\|\cdot\|_{p}^{\text {new }}$. By $L_{p}^{\text {new }}[0,1]$ we will denote $L_{p}[0,1]$ equipped with the norm $\|\cdot\|_{p}^{\text {new }}$.

Now, for each $n \geq 1$ let

$$
e_{n}^{p}=\frac{\chi_{n}}{\left\|\chi_{n}\right\|_{p}^{\text {new }}} .
$$

The sequence $\left(e_{n}^{p}\right)_{n \geq 1}$ is a normalized, unconditional basis of $L_{p}^{\text {new }}[0,1]$ whose unconditional basis constant is 1 . Furthermore, by [18, p. 18], $\left(e_{n}^{p}\right)_{n \geq 1}$ is also a boundedly complete basis.

Given $X$ a Banach space and $p, q \in(1, \infty)$ satisfying $1 / p+1 / q=1$, we denote by $L_{p}^{\text {weak }}(X)$ the space

$$
\left\{\left(x_{n}\right)_{n \geq 1} \in X^{\mathbb{N}}: \sum_{n=1}^{\infty} x^{*}\left(x_{n}\right) e_{n}^{p} \text { converges in } L_{p}^{\text {new }}[0,1] \text { for each } x^{*} \in X^{*}\right\}
$$

equipped with the norm

$$
\|\bar{x}\|_{p}^{\text {weak }}=\sup \left\{\left\|\sum_{n=1}^{\infty} x^{*}\left(x_{n}\right) e_{n}^{p}\right\|_{p}^{\text {new }}: x^{*} \in B_{X^{*}}\right\}
$$

and by $L_{p}\langle X\rangle$ the space

$$
\left\{\left(x_{n}\right)_{n \geq 1} \in X^{\mathbb{N}}: \sum_{n=1}^{\infty}\left|x_{n}^{*}\left(x_{n}\right)\right|<\infty \text { for each }\left(x_{n}^{*}\right)_{n \geq 1} \in L_{q}^{\text {weak }}\left(X^{*}\right)\right\}
$$

with the norm

$$
\|\bar{x}\|_{L_{p}\langle X\rangle}=\sup \left\{\sum_{n=1}^{\infty}\left|x_{n}^{*}\left(x_{n}\right)\right|:\left(x_{n}^{*}\right)_{n \geq 1} \in B_{L_{q}^{\text {weak }}\left(X^{*}\right)}\right\},
$$

where $\bar{x}=\left(x_{n}\right)_{n \geq 1}$. With their own respective norms, $L_{p}^{\text {weak }}(X)$ and $L_{p}\langle X\rangle$ are Banach spaces [3].

For each $n \geq 1$, we will denote by $I_{n}: X \rightarrow X^{\mathbb{N}}$ the natural inclusion

$$
I_{n}(x)=\left(\delta_{m n} x\right)_{m \geq 1}, \forall x \in X
$$

It is easy to see that $\left\|I_{n}(x)\right\|_{p}^{\text {weak }}=\|x\|$ and furthermore, by [18, Proposition 1.c.7], we know that $\left\|I_{n}(x)\right\|_{L_{p}\langle X\rangle} \leq 2\|x\|$, for every $x \in X$.

We shall consider also the following closed subspace of $L_{p}^{\text {weak }}(X)$ :

$$
F_{p}(X)=\left\{\bar{x}=\left(x_{n}\right)_{n \geq 1} \in L_{p}^{\text {weak }}(X):\left\|\bar{x}-\sum_{n=1}^{m} I_{n}\left(x_{n}\right)\right\|_{p}^{\text {weak }} \longrightarrow 0\right\}
$$

Next, we recall some results obtained in [3].
Theorem 9 ([3], Theorem 2.4). Given $X$ a Banach space, $p \in(1, \infty)$ and $\bar{x}=\left(x_{n}\right)_{n \geq 1} \in L_{p}\langle X\rangle$, the series $\sum_{n=1}^{\infty} I_{n}\left(x_{n}\right)$ converges to $\bar{x}$ in $L_{p}\langle X\rangle$.

The next one gives a sequential representation of $L_{p}[0,1] \hat{\otimes}_{\pi} X$.
Theorem 10 ([3], Theorem 3.4). Let $X$ be a Banach space and $p \in(1, \infty)$. The function $\Psi: L_{p}\langle X\rangle \rightarrow L_{p}[0,1] \hat{\otimes}_{\pi} X$ defined by

$$
\Psi(\bar{x})=\sum_{n=1}^{\infty} e_{n}^{p} \otimes x_{n}
$$

for each $\bar{x}=\left(x_{n}\right)_{n \geq 1} \in L_{p}\langle X\rangle$, is an isomorphism onto $L_{p}[0,1] \hat{\otimes}_{\pi} X$.
Theorem 11. Let $X$ be a Banach space and $p, q \in(1, \infty)$ such that $1 / p+$ $1 / q=1$. Then $L_{q}^{\text {weak }}(X)$ is isomorphic to $\mathcal{L}\left(L_{p}[0,1], X\right)$ and its subspace $F_{q}(X)$ is isomorphic to $\mathcal{K}\left(L_{p}[0,1], X\right)$.
Proof. Let $\left(e_{n}^{*}\right)_{n \geq 1}$ be the sequence of coordinate functionals in $L_{p}[0,1]^{*}$ with respect to the basis $\left(e_{n}^{p}\right)_{n \geq 1}$. It is easy to check that the usual isometry from $L_{p}[0,1]^{*}$ onto $L_{q}[0,1]$ associates the functional $e_{n}^{*}$ to $e_{n}^{q}$.

Fix $\bar{x}=\left(x_{n}\right)_{n \geq 1} \in L_{q}^{\text {weak }}(X)$ and $f=\sum_{n=1}^{\infty} \alpha_{n} e_{n}^{p} \in L_{p}[0,1]$. We claim that the series $\sum_{n=1}^{\infty} \alpha_{n} x_{n}$ converges in $X$. Indeed, given $k \geq j \geq 1$ we have

$$
\begin{aligned}
\left\|\sum_{n=j}^{k} \alpha_{n} x_{n}\right\| & =\left\|\sum_{n=j}^{k} e_{n}^{*}(f) x_{n}\right\|=\sup _{x^{*} \in B_{X^{*}}}\left|\sum_{n=j}^{k} e_{n}^{*}(f) x^{*}\left(x_{n}\right)\right| \\
& =\sup _{x^{*} \in B_{X^{*}}}\left|\left(\sum_{n=j}^{k} x^{*}\left(x_{n}\right) e_{n}^{*}\right)\left(\sum_{m=j}^{k} e_{m}^{*}(f) e_{m}^{p}\right)\right| \\
& \leq \sup _{x^{*} \in B_{X^{*}}}\left\|\sum_{n=j}^{k} x^{*}\left(x_{n}\right) e_{n}^{*}\right\|\left\|\sum_{m=j}^{k} e_{m}^{*}(f) e_{m}^{p}\right\| \\
& =\sup _{x^{*} \in B_{X^{*}}}\left\|\sum_{n=j}^{k} x^{*}\left(x_{n}\right) e_{n}^{q}\right\|\left\|\sum_{m=j}^{k} e_{m}^{*}(f) e_{m}^{p}\right\| \\
& \leq\|\bar{x}\|_{q}^{\text {weak }}\left\|\sum_{m=j}^{k} e_{m}^{*}(f) e_{m}^{p}\right\|
\end{aligned}
$$

and therefore the partial sums of the series $\sum_{n=1}^{\infty} \alpha_{n} x_{n}$ form a Cauchy sequence in $X$, which establishes our claim.

This proves that $\mathcal{I}: L_{q}^{\text {weak }}(X) \rightarrow \mathcal{L}\left(L_{p}[0,1], X\right)$ given by

$$
\mathcal{I}(\bar{x})(f)=\sum_{n=1}^{\infty} \alpha_{n} x_{n}
$$

for each $\bar{x}=\left(x_{n}\right)_{n \geq 1} \in L_{q}^{\text {weak }}(X)$ and $f=\sum_{n=1}^{\infty} \alpha_{n} e_{n}^{p} \in L_{p}[0,1]$, is a well defined linear operator satisfying $\|\mathcal{I}(\bar{x})\| \leq\|\bar{x}\|_{q}^{\text {weak }}$.

Let us show now that $\mathcal{I}$ is an isomorphism onto $\mathcal{L}\left(L_{p}[0,1], X\right)$. Fix $S \in \mathcal{L}\left(L_{p}[0,1], X\right)$ and consider $\bar{y}=\left(S\left(e_{n}^{p}\right)\right)_{n \geq 1}$. We claim that $\bar{y} \in L_{q}^{\text {weak }}$. Indeed, for each $m \geq 1$ and $x^{*} \in B_{X^{*}}$ we have

$$
\begin{aligned}
\left\|\sum_{n=1}^{m} x^{*}\left(S\left(e_{n}^{p}\right)\right) e_{n}^{q}\right\|_{q}^{\text {new }} & =\sup _{\theta_{n}= \pm 1}\left\|\sum_{n=1}^{m} \theta_{n} x^{*}\left(S\left(e_{n}^{p}\right)\right) e_{n}^{q}\right\|_{q} \\
& =\sup _{\theta_{n}= \pm 1} \sup _{g \in B_{L_{p}[0,1]}}\left\|x^{*}\left(\sum_{n=1}^{m} \theta_{n} e_{n}^{*}(g) S\left(e_{n}^{p}\right)\right)\right\| \\
& \leq \sup _{\theta_{n}= \pm 1} \sup _{g \in B_{L_{p}[0,1]}}\left\|S\left(\sum_{n=1}^{m} \theta_{n} e_{n}^{*}(g) e_{n}^{p}\right)\right\| \\
& \leq\|S\| \sup _{\theta_{n}= \pm 1} \sup _{g \in B_{L_{p}[0,1]}}\left\|\sum_{n=1}^{m} \theta_{n} e_{n}^{*}(g) e_{n}^{p}\right\|_{p} \\
& =\|S\| \sup _{g \in B_{L_{p}[0,1]}}\left\|\sum_{n=1}^{m} e_{n}^{*}(g) e_{n}^{p}\right\|_{p}^{\text {new }} \\
& \leq\|S\| \sup _{g \in B_{L_{p}[0,1]}}\left\|\sum_{n=1}^{\infty} e_{n}^{*}(g) e_{n}^{p}\right\|_{p}^{\text {new }} \\
& \leq K_{p}\|S\| \sup _{g \in B_{L_{p}[0,1]}}\left\|\sum_{n=1}^{\infty} e_{n}^{*}(g) e_{n}^{p}\right\|_{p}=K_{p}\|S\| .
\end{aligned}
$$

Since $\left(e_{n}^{q}\right)_{n \geq 1}$ is a boundedly complete basis, the claim is established. This shows that $\mathcal{I}^{\prime}: \mathcal{L}\left(L_{p}[0,1], X\right) \rightarrow L_{q}^{\text {weak }}(X)$ defined by $\mathcal{I}^{\prime}(S)=\left(S\left(e_{n}^{p}\right)\right)_{n \geq 1}$, is a bounded linear operator with $\left\|\mathcal{I}^{\prime}\right\| \leq K_{p}$. Furthermore, it is easy to see that $\mathcal{I}^{\prime}$ is the inverse of $\mathcal{I}$. Thus, $\mathcal{I}$ is an isomorphism onto $\mathcal{L}\left(L_{p}[0,1], X\right)$.

Next we will show that $\mathcal{I}$ maps $F_{q}(X)$ onto $\mathcal{K}\left(L_{p}[0,1], X\right)$. It is clear that $\mathcal{I}\left(F_{q}(X)\right)$ is subset of $\mathcal{K}\left(L_{p}[0,1], X\right)$. Next, fix $T \in \mathcal{K}\left(L_{p}[0,1], X\right)$. Since $\mathcal{I}$ is onto $\mathcal{L}\left(L_{p}[0,1], X\right)$, there exists an unique $\bar{y}=\left(y_{n}\right)_{n \geq 1} \in L_{q}^{\text {weak }}(X)$ such that $\mathcal{I}(\bar{y})=T$. We will show that $\bar{y} \in F_{q}(X)$. Fix $\varepsilon>0$ and denote by $\left(P_{n}\right)_{n \geq 1}$ the sequence of projections associated to the basis $\left(e_{n}^{p}\right)_{n}$. Since $\left(e_{n}^{*}\right)_{n \geq 1}$ is a Schauder basis of $L_{p}[0,1]^{*}$ and $T$ is compact, the sequence $\left(P_{n}^{*}\right)_{n \geq 1}$ converges uniformly to the identity operator on the compact set $T^{*}\left(B_{X^{*}}\right)$. Hence, there exists $N \geq 1$ such that $\left\|P_{m}^{*}\left(T^{*}\left(x^{*}\right)\right)-T^{*}\left(x^{*}\right)\right\|<\varepsilon / K_{p}$ for every $x^{*} \in B_{X^{*}}$ and $m \geq N$, and thus $\left\|T \circ P_{m}-T\right\| \leq \varepsilon / K_{p}$, for every $m \geq N$. It is easy to
see that

$$
\mathcal{I}\left(\sum_{n=1}^{m} I_{n}\left(y_{n}\right)\right)=T \circ P_{m},
$$

for every $m \geq 1$. Therefore we have

$$
\left\|\bar{y}-\sum_{n=1}^{m} I_{n}\left(y_{n}\right)\right\|_{q}^{\text {weak }} \leq\left\|\mathcal{I}^{-1}\right\|\left\|T-T \circ P_{m}\right\|<\varepsilon
$$

for every $m \geq N$, and thus $\bar{y} \in F_{q}(X)$. The proof is complete.
3.2. The duals of the spaces $L_{p}\langle X\rangle$ and $F_{q}(X)$. It is well known that $L_{p}\langle X\rangle^{*}$ is linearly isomorphic to $\mathcal{L}\left(L_{p}[0,1], X^{*}\right)$ [24, Theorem 2.9] and that $F_{q}(X)^{*}$ is linearly isomorphic to $L_{q}[0,1] \widehat{\otimes}_{\pi} X^{*}$ [24, Theorem 5.33].

This subsection will be devoted to obtaining convenient characterizations of the duals of the spaces $F_{q}(X)$ and $L_{p}\langle X\rangle$.

Proposition 12. Given $X$ a Banach space, $p \in(1, \infty), \bar{x}=\left(x_{n}\right)_{n \geq 1} \in$ $L_{p}\langle X\rangle$ and $\varphi \in L_{p}\langle X\rangle^{*}$, the series $\sum_{n=1}^{\infty}\left(\varphi \circ I_{n}\right)\left(x_{n}\right)$ converges absolutely.

Proof. For each $n \geq 1$, let $\theta_{n}=\operatorname{sign}\left(\varphi \circ I_{n}\right)\left(x_{n}\right)$. Then $\bar{y}=\left(\theta_{n} x_{n}\right)_{n \geq 1} \in$ $L_{p}\langle X\rangle$ and by Theorem 9 we have

$$
\sum_{n=1}^{\infty}\left|\left(\varphi \circ I_{n}\right)\left(x_{n}\right)\right|=\sum_{n=1}^{\infty}\left(\varphi \circ I_{n}\right)\left(\theta_{n} x_{n}\right)=\varphi(\bar{y}),
$$

as desired.
Similarly to the previous proposition, we have:
Proposition 13. Given $X$ a Banach space, $p \in(1, \infty), \bar{x}=\left(x_{n}\right)_{n \geq 1} \in$ $F_{p}(X)$ and $\varphi \in F_{p}(X)^{*}$, the series $\sum_{n=1}^{\infty}\left(\varphi \circ I_{n}\right)\left(x_{n}\right)$ converges absolutely.
Proof. For each $n \geq 1$, let $\theta_{n}=\operatorname{sign}\left(\varphi \circ I_{n}\right)\left(x_{n}\right)$. Since $\left(e_{n}^{p}\right)_{n \geq 1}$ is an unconditional basis with unconditional constant equal to 1 , it follows that the series $\sum_{n=1}^{\infty} \theta_{n} x^{*}\left(x_{n}\right) e_{n}^{p}$ converges in $L_{p}^{\text {new }}[0,1]$ for every $x^{*} \in X^{*}$. Moreover, for every $k \geq 1$ and $x^{*} \in X^{*}$ we have

$$
\left\|\sum_{n=k}^{\infty} \theta_{n} x^{*}\left(x_{n}\right) e_{n}^{p}\right\|_{p}^{\text {new }}=\left\|\sum_{n=k}^{\infty} x^{*}\left(x_{n}\right) e_{n}^{p}\right\|_{p}^{\text {new }}
$$

and so $\left(\theta_{n} x_{n}\right)_{n \geq 1} \in F_{p}(X)$. Thus, $\sum_{n=1}^{\infty} \theta_{n}\left(\varphi \circ I_{n}\right)\left(x_{n}\right)$ converges.
Proposition 14. Let $X$ be a Banach space and $p, q \in(1, \infty)$ such that $1 / p+1 / q=1$. A sequence $\bar{x}^{*}=\left(x_{n}^{*}\right)_{n \geq 1}$ of elements of $X^{*}$ belongs to $L_{p}\left\langle X^{*}\right\rangle$ if, and only if, the series $\sum_{n=1}^{\infty} x_{n}^{*}\left(x_{n}\right)$ converges absolutely, for each $\bar{x}=\left(x_{n}\right)_{n \geq 1} \in F_{q}(X)$. Furthermore, in this case one has

$$
\left\|\bar{x}^{*}\right\|_{L_{p}\langle X\rangle} \leq \sup \left\{\sum_{n=1}^{\infty}\left|x_{n}^{*}\left(x_{n}\right)\right|: \bar{x}=\left(x_{n}\right)_{n \geq 1} \in B_{F_{q}(X)}\right\}<\infty .
$$

Proof. Let us show the non-trivial implication. Let $\bar{x}^{*}=\left(x_{n}^{*}\right)_{n \geq 1}$ be a sequence of elements of $X^{*}$ such that the series $\sum_{n=1}^{\infty} x_{n}^{*}\left(x_{n}\right)$ converges absolutely, for each $\bar{x}=\left(x_{n}\right)_{n \geq 1} \in F_{q}(X)$. We claim that

$$
\mathcal{S}\left(\bar{x}^{*}\right)=\sup \left\{\sum_{n=1}^{\infty}\left|x_{n}^{*}\left(x_{n}\right)\right|: \bar{x}=\left(x_{n}\right)_{n \geq 1} \in B_{F_{q}(X)}\right\}<\infty .
$$

Indeed, for each $m \geq 1$, consider the set

$$
U_{m}=\left\{\bar{x}=\left(x_{n}\right)_{n \geq 1} \in B_{F_{q}(X)}: \sum_{n \geq 1}\left|x_{n}^{*}\left(x_{n}\right)\right| \leq m\right\} .
$$

It is easy to check that $U_{m}$ is a closed, absolutely convex subset of $B_{F_{q}(X)}$. Since $B_{F_{q}(X)}=\bigcup_{m>1} U_{m}$ has non-empty interior, by Baire's Theorem there exists $M \geq 1$ such that $U_{M}$ has non-empty interior. The absolute convexity of $U_{M}$ implies that 0 is an interior point of $U_{M}$, that is, there exists $r>0$ satisfying

$$
\left\{\bar{x}=\left(x_{n}\right)_{n \geq 1} \in B_{F_{q}(X)}:\|\bar{x}\|_{q}^{\text {weak }} \leq r\right\} \subset U_{M} .
$$

This proves that $\mathcal{S}\left(\bar{x}^{*}\right) \leq \frac{M}{r}$ and our claim is established.
Next, let us show that $\bar{x}^{*}=\left(x_{n}^{*}\right)_{n \geq 1} \in L_{p}\left\langle X^{*}\right\rangle$. Fix $\bar{x}^{* *}=\left(x_{n}^{* *}\right)_{n \geq 1} \in$ $L_{q}^{\text {weak }}\left(X^{* *}\right), m \geq 1$ and $\varepsilon>0$. Put $Y=\operatorname{span}\left\{x_{1}^{* *}, \ldots, x_{m}^{* *}\right\}$. By the Principle of Local Reflexivity [20, Theorem 2], there exists a linear operator $T: Y \rightarrow$ $X$ satisfying $\|T\| \leq 1+\varepsilon$ and $x_{n}^{*}\left(T\left(x_{n}^{* *}\right)\right)=x_{n}^{* *}\left(x_{n}^{*}\right)$, for each $1 \leq n \leq m$. Put $\bar{y}=\left(y_{n}\right)_{n \geq 1} \in F_{q}(X)$, where $y_{n}=T\left(x_{n}^{* *}\right)$, if $1 \leq n \leq m$, and $y_{n}=0$ otherwise.

Since $\left(e_{n}^{q}\right)_{n \geq 1}$ is an unconditional basis, by [18, p. 18] we have

$$
\begin{aligned}
\|\bar{y}\|_{q}^{\text {weak }} & =\sup _{x^{*} \in B_{X^{*}}}\left\|\sum_{n=1}^{m}\left(x^{*} \circ T\right)\left(x_{n}^{* *}\right) e_{n}^{q}\right\|_{q}^{\text {new }} \\
& \leq(1+\varepsilon) \sup _{\varphi \in B_{X^{* * *}}}\left\|\sum_{n=1}^{m} \varphi\left(x_{n}^{* *}\right) e_{n}^{q}\right\|_{q}^{\text {new }} \\
& \leq(1+\varepsilon) \sup _{\varphi \in B_{X^{* * *}}}\left\|\sum_{n=1}^{\infty} \varphi\left(x_{n}^{* *}\right) e_{n}^{q}\right\|_{q}^{\text {new }}=(1+\varepsilon)\left\|\bar{x}^{* *}\right\|_{q}^{\text {weak }}
\end{aligned}
$$

and hence

$$
\sum_{n=1}^{m}\left|x_{n}^{* *}\left(x_{n}^{*}\right)\right| \leq \mathcal{S}\left(\bar{x}^{*}\right)\|\bar{y}\|_{q}^{\text {weak }} \leq(1+\varepsilon) \mathcal{S}\left(\bar{x}^{*}\right)\left\|\bar{x}^{* *}\right\|_{q}^{\text {weak }}
$$

Since $\varepsilon>0$ was arbitrary, we obtain

$$
\sum_{n=1}^{m}\left|x_{n}^{* *}\left(x_{n}^{*}\right)\right| \leq \mathcal{S}\left(\bar{x}^{*}\right)\left\|\bar{x}^{* *}\right\|_{q}^{\text {weak }}
$$

for each $m \geq 1$, which in turn implies

$$
\sum_{n=1}^{\infty}\left|x_{n}^{* *}\left(x_{n}^{*}\right)\right| \leq \mathcal{S}\left(\bar{x}^{*}\right)\left\|\bar{x}^{* *}\right\|_{q}^{\text {weak }}
$$

Thus, $\bar{x}^{*} \in L_{p}\left\langle X^{*}\right\rangle$ and $\left\|\bar{x}^{*}\right\|_{L_{p}\langle X\rangle} \leq \mathcal{S}\left(\bar{x}^{*}\right)$, as desired.
Theorem 15. Let $X$ be a Banach space and $p, q \in(1, \infty)$ such that $1 / p+$ $1 / q=1$. The function $\mathcal{H}: F_{q}(X)^{*} \rightarrow L_{p}\left\langle X^{*}\right\rangle$ defined by

$$
\mathcal{H}(\varphi)=\left(\varphi \circ I_{n}\right)_{n \geq 1}
$$

for each $\varphi \in F_{q}(X)^{*}$, is a linear isometry onto $L_{p}\left\langle X^{*}\right\rangle$.
Proof. Given $\varphi \in F_{q}(X)^{*}$, Propositions 13 and 14 imply that $\left(\varphi \circ I_{n}\right)_{n \geq 1} \in$ $L_{p}\left\langle X^{*}\right\rangle$. Thus, $\mathcal{H}$ is well defined. It is clear that $\mathcal{H}$ is linear.

By Proposition 13, we have

$$
\begin{aligned}
\|\mathcal{H}(\varphi)\|_{L_{p}\left\langle X^{*}\right\rangle} & \leq \sup \left\{\sum_{n=1}^{\infty}\left|\left(\varphi \circ I_{n}\right)\left(x_{n}\right)\right|: \bar{x}=\left(x_{n}\right)_{n \geq 1} \in B_{F_{q}(X)}\right\} \\
& =\sup \left\{\left|\sum_{n=1}^{\infty}\left(\varphi \circ I_{n}\right)\left(x_{n}\right)\right|: \bar{x}=\left(x_{n}\right)_{n \geq 1} \in B_{F_{q}(X)}\right\} \\
& =\sup \left\{|\varphi(\bar{x})|: \bar{x}=\left(x_{n}\right)_{n \geq 1} \in B_{F_{q}(X)}\right\}=\|\varphi\|,
\end{aligned}
$$

where the first equality follows immediately from the proof of Proposition 13. On the other hand,

$$
\begin{aligned}
\|\mathcal{H}(\varphi)\|_{L_{p}\left\langle X^{*}\right\rangle} & =\sup \left\{\sum_{n=1}^{\infty}\left|x_{n}^{* *}\left(\varphi \circ I_{n}\right)\right|: \bar{x}^{* *}=\left(x_{n}^{* *}\right)_{n \geq 1} \in B_{L_{q}^{\text {wea }}\left(X^{* *}\right)}\right\} \\
& \geq \sup \left\{\sum_{n=1}^{\infty}\left|\left(\varphi \circ I_{n}\right)\left(x_{n}\right)\right|: \bar{x}=\left(x_{n}\right)_{n \geq 1} \in B_{F_{q}(X)}\|=\| \varphi \| .\right.
\end{aligned}
$$

This shows that $\mathcal{H}$ is an isometry onto its image.
Finally, given $\bar{x}^{*}=\left(x_{n}^{*}\right)_{n \geq 1} \in L_{p}\left\langle X^{*}\right\rangle$, the function $\psi: F_{q}(X) \rightarrow \mathbb{R}$ defined by $\psi(\bar{x})=\sum_{n=1}^{\infty} x_{n}^{*}\left(x_{n}\right)$, for each $\bar{x}=\left(x_{n}\right)_{n \geq 1} \in F_{q}(X)$, is a linear functional on $F_{q}(X)$ and it is clear that $\mathcal{H}(\psi)=\bar{x}^{*}$. This completes the proof.

Next, we establish an isomorphism from $L_{p}\langle X\rangle^{*}$ onto $L_{q}^{\text {weak }}\left(X^{*}\right)$.
Theorem 16. Let $X$ be a Banach space and $p, q \in(1, \infty)$ such that $1 / p+$ $1 / q=1$. The function $\mathcal{J}: L_{q}^{\text {weak }}\left(X^{*}\right) \rightarrow L_{p}\langle X\rangle^{*}$ given by

$$
\mathcal{J}\left(\bar{x}^{*}\right)(\bar{x})=\sum_{n=1}^{\infty} x_{n}^{*}\left(x_{n}\right),
$$

for each $\bar{x}^{*}=\left(x_{n}\right)_{n \geq 1} \in L_{q}^{\text {weak }}\left(X^{*}\right)$ and $\bar{x}=\left(x_{n}\right)_{n \geq 1} \in L_{p}\langle X\rangle$, is an isomorphism onto $L_{p}\langle X\rangle^{*}$.

Proof. Let $\Psi: L_{p}\langle X\rangle \rightarrow L_{p}[0,1] \hat{\otimes}_{\pi} X$ be the isomorphism defined in Theorem 10, $\mathcal{I}: L_{q}^{\text {weak }}\left(X^{*}\right) \rightarrow \mathcal{L}\left(L_{p}[0,1], X^{*}\right)$ be the isomorphism defined in Theorem 11, and consider $\Phi: \mathcal{L}\left(L_{p}[0,1], X^{*}\right) \rightarrow\left(L_{p}[0,1] \hat{\otimes}_{\pi} X\right)^{*}$ the canonical linear isometry [24, p. 24]. Given $\bar{x}^{*}=\left(x_{n}\right)_{n \geq 1} \in L_{q}^{\text {weak }}\left(X^{*}\right)$ and
$\bar{x}=\left(x_{n}\right)_{n \geq 1} \in L_{p}\langle X\rangle$, we have

$$
\begin{aligned}
\left(\Psi^{*} \circ \Phi \circ \mathcal{I}\right)\left(\bar{x}^{*}\right)(\bar{x}) & =(\Phi \circ \mathcal{I})\left(\bar{x}^{*}\right)(\Psi(\bar{x}))=\sum_{n=1}^{\infty}(\Phi \circ \mathcal{I})\left(\bar{x}^{*}\right)\left(e_{n}^{p} \otimes x_{n}\right) \\
& =\sum_{n=1}^{\infty} \mathcal{I}\left(\bar{x}^{*}\right)\left(e_{n}^{p}\right)\left(x_{n}\right)=\mathcal{J}\left(\bar{x}^{*}\right)(\bar{x})=\sum_{n=1}^{\infty} x_{n}^{*}\left(x_{n}\right)
\end{aligned}
$$

and therefore $\mathcal{J}=\Psi^{*} \circ \Phi \circ \mathcal{I}$. The proof is complete.
3.3. Complemented copies of $c_{0}(\tau)$ in $L_{p}\langle X\rangle$ spaces. The next lemma will play a crucial role in the proof of Theorem 18.

Lemma 17. Let $X$ be a Banach space, $\tau$ be an infinite cardinal and $p, q \in$ $(1, \infty)$ such that $1 / p+1 / q=1$. Suppose that $\left(\overline{x_{i}}\right)_{i \in \tau}=\left(\left(x_{n}^{i}\right)_{n \geq 1}\right)_{i \in \tau}$ is a family equivalent to the canonical basis of $c_{0}(\tau)$ in $L_{p}\langle X\rangle$ and let $\left(\varphi_{i}\right)_{i \in \tau}$ be a bounded family in $L_{p}\langle X\rangle^{*}$. Then for each $\varepsilon>0$ there exists $M \geq 0$ such that

$$
\left|\sum_{n=M+1}^{\infty}\left(\varphi_{i} \circ I_{n}\right)\left(x_{n}^{i}\right)\right|<\varepsilon, \forall i \in \tau
$$

Proof. We recall that the series $\sum_{n=1}^{\infty}\left(\varphi_{i} \circ I_{n}\right)\left(x_{n}^{i}\right)$ converges absolutely for each $i \in \tau$, by Proposition 12. Let $s=\sup _{i \in \tau}\left\|\psi_{i}\right\|<\infty$.

Suppose the thesis does not hold. Then there exists $\varepsilon>0$ such that, for each $m \geq 0$, there exists $i \in \tau$ satisfying

$$
\left|\sum_{n=m+1}^{\infty}\left(\varphi_{i} \circ I_{n}\right)\left(x_{n}^{i}\right)\right| \geq \varepsilon
$$

We proceed by induction. For $M_{0}=0$, there exists $i_{1} \in \tau$ such that

$$
\left|\sum_{n=1}^{\infty}\left(\varphi_{i_{1}} \circ I_{n}\right)\left(x_{n}^{i_{1}}\right)\right| \geq \varepsilon
$$

The absolute convergence of $\sum_{n=1}^{\infty}\left(\varphi_{i_{1}} \circ I_{n}\right)\left(x_{n}^{i_{1}}\right)$ yields $M_{1} \geq 1$ such that

$$
\sum_{n=M_{1}+1}^{\infty}\left|\left(\varphi_{i_{1}} \circ I_{n}\right)\left(x_{n}^{i_{1}}\right)\right|<\frac{\varepsilon}{2} .
$$

Thus we have

$$
\left|\sum_{n=1}^{M_{1}}\left(\varphi_{i_{1}} \circ I_{n}\right)\left(x_{n}^{i_{1}}\right)\right|>\frac{\varepsilon}{2}
$$

Suppose we have obtained, for some $k \geq 1$, strictly increasing natural numbers $0=M_{0}<M_{1}<\ldots<M_{k}$ and distinct $i_{1}, \ldots, i_{k} \in \tau$ satisfying

$$
\begin{equation*}
\left|\sum_{n=N_{j}}^{M_{j}}\left(\varphi_{i_{j}} \circ I_{n}\right)\left(x_{n}^{i_{j}}\right)\right|>\frac{\varepsilon}{2}>\sum_{n=M_{j}+1}^{\infty}\left|\left(\varphi_{i_{j}} \circ I_{n}\right)\left(x_{n}^{i_{j}}\right)\right|, \tag{3.1}
\end{equation*}
$$

where $N_{j}=M_{j-1}+1$, for each $1 \leq j \leq k$. By hypothesis, there exists $i_{k+1} \in \tau$ such that

$$
\left|\sum_{n=M_{k}+1}^{\infty}\left(\varphi_{i_{k+1}} \circ I_{n}\right)\left(x_{n}^{i_{k+1}}\right)\right| \geq \varepsilon
$$

The absolute convergence of $\sum_{n=1}^{\infty}\left(\varphi_{i_{k+1}} \circ I_{n}\right)\left(x_{n}^{i_{k+1}}\right)$ yields $M_{k+1} \geq M_{k}+1$ such that

$$
\sum_{n=M_{k+1}}^{\infty}\left|\left(\varphi_{i_{k+1}} \circ I_{n}\right)\left(x_{n}^{i_{k+1}}\right)\right|<\frac{\varepsilon}{2} .
$$

Thus we have

$$
\left|\sum_{n=M_{k}+1}^{M_{k+1}}\left(\varphi_{i_{k+1}} \circ I_{n}\right)\left(x_{n}^{i_{k+1}}\right)\right|>\frac{\varepsilon}{2} .
$$

The above inequality and (3.1) imply that $i_{k+1} \notin\left\{i_{1}, \ldots, i_{k}\right\}$.
For each $j \geq 1$, consider $\bar{x}_{j}^{*}=\left(x_{j, n}^{*}\right)_{n \geq 1} \in F_{q}\left(X^{*}\right)$, where

$$
x_{j, n}^{*}=\left\{\begin{array}{cl}
\varphi_{i_{j}} \circ I_{n}, & \text { if } N_{j} \leq n \leq M_{j} \\
0, & \text { otherwise }
\end{array}\right.
$$

We claim that $\left(\bar{x}_{j}^{*}\right)_{j \geq 1}$ is weakly-null in $F_{q}\left(X^{*}\right)$. Indeed, fix $\psi \in F_{q}(X)^{*}$ and $\delta>0$. Let $\mathcal{J}$ be the isomorphism defined in Theorem 16. By Theorem 15, the sequence $\left(\psi \circ J_{n}\right)_{n \geq 1}$ belongs to $L_{p}\left\langle X^{*}\right\rangle$, where $J_{n}: X^{*} \rightarrow\left(X^{*}\right)^{\mathbb{N}}$ is the usual inclusion. By Theorem 9, there exists $N \geq 1$ such that

$$
\left\|\sum_{n=m}^{\infty} K_{n}\left(\psi \circ J_{n}\right)\right\|_{L_{p}\left\langle X^{*}\right\rangle}<\frac{\delta}{s\left\|\mathcal{J}^{-1}\right\|},
$$

for each $m \geq N$, where $K_{n}: X^{* *} \rightarrow\left(X^{* *}\right)^{\mathbb{N}}$ is the usual inclusion. Since the sequence $\left(N_{j}\right)_{j \geq 1}$ is strictly increasing, there exists $J \geq 1$ such that $N_{j} \geq N$, for all $j \geq J$. Thus we have

$$
\begin{aligned}
\left|\psi\left(\bar{x}_{j}^{*}\right)\right| & =\left|\sum_{n=N_{j}}^{M_{j}}\left(\psi \circ J_{n}\right)\left(x_{j, n}^{*}\right)\right| \leq\left\|\bar{x}_{j}^{*}\right\|_{q}^{\text {weak }}\left\|\sum_{n=N_{j}}^{M_{j}} K_{n}\left(\psi \circ J_{n}\right)\right\|_{L_{p}\left\langle X^{*}\right\rangle} \\
& \leq\left\|\left(\varphi_{i_{j}} \circ I_{n}\right)_{n \geq 1}\right\|_{q}^{\text {weak }} \frac{\delta}{s\left\|\mathcal{J}^{-1}\right\|}=\left\|\mathcal{J}^{-1}\left(\varphi_{i_{j}}\right)\right\|_{q}^{\text {weak }} \frac{\delta}{s\left\|\mathcal{J}^{-1}\right\|} \leq \delta,
\end{aligned}
$$

for all $j \geq J$. Claim established.
Now, let $\theta_{j}=\mathcal{J}\left(\bar{x}_{j}^{*}\right) \in L_{p}\langle X\rangle^{*}$, for each $j \geq 1$. By our claim, $\left(\theta_{j}\right)_{j \geq 1}$ is weakly-null. On the other hand, by (3.1) we have

$$
\left|\theta_{j}\left(\overline{x_{i_{j}}}\right)\right|=\left|\sum_{n=N_{j}}^{M_{j}}\left(\varphi_{i_{j}} \circ I_{n}\right)\left(x_{n}^{i_{j}}\right)\right|>\frac{\varepsilon}{2}, \forall j \geq 1 .
$$

This contradicts the Dunford-Pettis property of $c_{0}[13$, p. 596], and we are done.

Theorem 18. Given $X$ a Banach space, $p \in(1, \infty)$ and $\tau$ an infinite cardinal, we have

$$
c_{0}(\tau) \stackrel{c}{\hookrightarrow} L_{p}[0,1] \hat{\otimes}_{\pi} X \Longrightarrow c_{0}(\tau) \stackrel{c}{\hookrightarrow} X .
$$

Proof. By Theorems 6 and 10, there exist families $\left(\overline{x_{i}}\right)_{i \in \tau}=\left(\left(x_{n}^{i}\right)_{n \geq 1}\right)_{i \in \tau}$ in $L_{p}\langle X\rangle$ and $\left(\psi_{i}\right)_{i \in \tau}$ in $L_{p}\langle X\rangle^{*}$ such that $\left(\overline{x_{i}}\right)_{i \in \tau}$ is equivalent to the usual unit-vector basis of $c_{0}(\tau),\left(\psi_{i}\right)_{i \in \tau}$ is weak ${ }^{*}$-null and $\psi_{i}\left(\overline{x_{j}}\right)=\delta_{i j}$, for each $i, j \in \tau$. Let $s=\sup _{i \in \tau}\left\|\psi_{i}\right\|<\infty$.

An appeal to Lemma 17 yields $M \geq 0$ such that

$$
\left|\sum_{n=M+1}^{\infty}\left(\varphi_{i} \circ I_{n}\right)\left(x_{n}^{i}\right)\right|<\frac{1}{2}, \forall i \in \tau .
$$

Since $1=\psi_{i}\left(\overline{x_{i}}\right)=\sum_{n=1}^{\infty}\left(\varphi_{i} \circ I_{n}\right)\left(x_{n}^{i}\right)$, we have $M \geq 1$ and

$$
\frac{1}{2}<\sum_{n=1}^{M}\left|\left(\psi_{i} \circ I_{n}\right)\left(x_{n}^{i}\right)\right|, \forall i \in \tau
$$

Next, for each $i \in \tau$ there exists $1 \leq n_{i} \leq M$ satisfying

$$
\frac{1}{2 M}<\left|\left(\psi_{i} \circ I_{n_{i}}\right)\left(x_{n_{i}}^{i}\right)\right| .
$$

Let $\mathcal{N}=\left\{n_{i}: i \in \tau\right\}$ and for each $n \in \mathcal{N}$ consider $\alpha_{n}=\left\{i \in \tau: n_{i}=n\right\}$. Since $\mathcal{N}$ is finite, there exists $N \in \mathcal{N}$ such that $\left|\alpha_{N}\right|=\tau$. Setting $\tau_{1}=\alpha_{N}$, we obtain

$$
\begin{equation*}
\frac{1}{2 M}<\left|\left(\psi_{i} \circ I_{N}\right)\left(x_{N}^{i}\right)\right|, \forall i \in \tau_{1} . \tag{3.2}
\end{equation*}
$$

For each $i \in \tau_{1}$, define $x_{i}=x_{N}^{i} \in X$ and $x_{i}^{*}=\psi_{i} \circ I_{N} \in X^{*}$. By (3.2), we have

$$
\frac{1}{2 M}<\left|x_{i}^{*}\left(x_{i}\right)\right| \leq\left\|\psi_{i}\right\|\left\|I_{N}\right\|\left\|x_{i}\right\| \leq s\left\|I_{N}\right\|\left\|y_{i}\right\|, \forall i \in \tau_{1}
$$

and therefore

$$
\begin{equation*}
\frac{1}{2 M s\left\|I_{N}\right\|}<\left\|x_{i}\right\|, \forall i \in \tau_{1} . \tag{3.3}
\end{equation*}
$$

Next, let $\left(e_{i}\right)_{i \in \tau}$ denote the unit-vector basis of $c_{0}(\tau)$. By hypothesis, there exists $T: c_{0}(\tau) \rightarrow L_{p}\langle X\rangle$ an isomorphism from $c_{0}(\tau)$ onto its image such that $T\left(e_{i}\right)=\overline{x_{i}}$, for each $i \in \tau$. By (3.3), we have

$$
\left\|\left(P_{N} \circ T\right)\left(e_{i}\right)\right\|=\left\|x_{i}\right\| \geq \frac{1}{2 M s\left\|I_{N}\right\|}>0, \forall i \in \tau_{1}
$$

Therefore, by [23, Remark following Theorem 3.4], there exists $\tau_{2} \subset \tau_{1}$ such that $\left|\tau_{2}\right|=\tau$ and $P_{N} \circ T_{\mid c_{0}\left(\tau_{2}\right)}$ is an isomophism onto its image; hence, $\left(x_{i}\right)_{i \in \tau_{2}}=\left(P_{N}\left(T\left(e_{i}\right)\right)_{i \in \tau_{2}}\right.$ is equivalent to the unit-vector basis of $c_{0}\left(\tau_{2}\right)$.

Finally, given $x \in X$, observe that

$$
\left(x_{i}^{*}(x)\right)_{i \in \tau_{2}}=\left(\psi_{i}\left(I_{N}(x)\right)\right)_{i \in \tau_{2}} \in c_{0}\left(\tau_{2}\right),
$$

since $\left(\psi_{i}\right)_{i \in \tau}$ is weak*-null by hypothesis. This shows that $\left(x_{i}^{*}\right)_{i \in \tau_{2}}$ is weak*null in $X^{*}$.

Combining these facts with (3.2), an appeal to Theorem 6 yields a complemented copy of $c_{0}(\tau)$ in $X$.

## 4. Complemented copies of $c_{0}(\tau)$ in $L_{p}([0,1], X)$ spaces

Let $\rho: L_{p}[0,1] \widehat{\otimes}_{\Delta_{p}} X \rightarrow L_{p}([0,1], X)$ be the unique linear extension of the natural mapping $g \otimes x \mapsto g(\cdot) x$, where $g \in L_{p}[0,1]$ and $x \in X$. By [9, Chapters 7.1 and 7.2], $\rho$ is a linear isometry from $L_{p}[0,1] \widehat{\otimes}_{\Delta_{p}} X$ onto $L_{p}([0,1], X)$.

For every integer $m$ and $u \in L_{p}[0,1]$ we define

$$
\sigma_{m}(u)=\sum_{n=1}^{m} c_{n} \chi_{n}(.) \int_{0}^{1} \chi_{n}(s) u(s) d s
$$

where $c_{1}=1$ and $c_{2^{k}+j}=2^{k}$, for each $k \geq 0$ and $1 \leq j \leq 2^{k}$.
We define also the function $H_{m}$ on $[0,1] \times[0,1]$ by

$$
H_{m}(t, s)=\sum_{n=1}^{m} c_{n} \chi_{n}(t) \chi_{n}(s)
$$

For every integer $k \geq 1$ we denote

$$
I_{k, l}= \begin{cases}{\left[\frac{l-1}{2^{k}}, \frac{l}{2^{k}}[ \right.} & \text { if } 1 \leq l \leq 2^{k}-1 \\ {\left[1-\frac{1}{2^{k}}, 1\right]} & \text { if } l=2^{k} .\end{cases}
$$

We also write $I_{0,1}=[0,1]$ and $C_{k, l}=I_{k, l} \times I_{k, l}$.
It is easy to check by induction that for each $k \geq 0,1 \leq l \leq 2^{k}$ and $m=2^{k}+l$ we have

$$
H_{m}=2^{k+1} \sum_{i=1}^{2 l} 1_{C_{k+1, i}}+2^{k} \sum_{i=l+1}^{2^{k}} 1_{C_{k, i}},
$$

[21, p.17], where $1_{A}$ denotes the characteristic function of $A \subset[0,1]$, and thus $H_{m}$ is a positive function on $[0,1] \times[0,1]$. Since one has

$$
\sigma_{m}(g)=\int_{0}^{1} H_{m}(\cdot, s) g(s) d s
$$

for each $g \in L_{p}[0,1]$, we conclude that $\sigma_{m}$ is a positive operator on $L_{p}[0,1]$. Furthermore, $\left\|\sigma_{m}\right\|=1$ and

$$
\begin{equation*}
\lim _{m \rightarrow \infty}\left\|\sigma_{m}(g)-g\right\|_{p}=0 \tag{4.1}
\end{equation*}
$$

for each $f \in L_{p}[0,1]$, by [18, p. 3] or [25, Example 2.3, p. 13].
Lemma 19. Given $X$ a Banach space, $p \in[1, \infty)$ and $f \in L_{p}([0,1], X)$, the series

$$
\sum_{n=1}^{\infty} c_{n} \chi_{n}(\cdot) \int_{0}^{1} \chi_{n}(s) f(s) d s
$$

converges to $f$ in $L_{p}([0,1], X)$, where $c_{1}=1$ and $c_{2^{k}+j}=2^{k}$, for each $k \geq 0$ and $1 \leq j \leq 2^{k}$.

Proof. The natural tensor norm $\|\cdot\|_{\Delta_{p}}$ is not an uniform cross norm, nevertheless the operator $s_{m}=\sigma_{m} \otimes I_{X}$ is bounded and $\left\|s_{m}\right\|=1$ by $[9$, Chapter 7.2]. By (4.1), we have

$$
\lim _{m \rightarrow \infty}\left\|s_{m}(g \otimes x)-g \otimes x\right\|_{\Delta_{p}}=0
$$

and hence

$$
\lim _{m \rightarrow \infty}\left\|s_{m}(u)-u\right\|_{\Delta_{p}}=0
$$

for every $u \in L_{p}[0,1] \widehat{\otimes}_{\Delta_{p}} X$. The result then follows from the fact that $\rho$ is a linear isometry onto $L_{p}([0,1], X)$.

We are now ready to prove the main result of this section.
Theorem 20. Let $X$ be a Banach space, $\tau$ be an infinite cardinal and $p \in[1, \infty)$. If $\operatorname{cf}(\tau)>\aleph_{0}$, then

$$
c_{0}(\tau) \stackrel{c}{\hookrightarrow} L_{p}([0,1], X) \Longrightarrow c_{0}(\tau) \stackrel{c}{\hookrightarrow} X .
$$

Proof. By Theorem 6, there exist families $\left(f_{i}\right)_{i \in \tau}$ in $L_{p}([0,1], X)$ and $\left(\psi_{i}\right)_{i \in \tau}$ in $L_{p}([0,1], X)^{*}$ such that $\left(f_{i}\right)_{i \in \tau}$ is equivalent to the usual unit-vector basis of $c_{0}(\tau),\left(\psi_{i}\right)_{i \in \tau}$ is weak*-null and $\psi\left(f_{j}\right)=\delta_{i j}$, for each $i, j \in \tau$. Let $s=$ $\sup _{i \in \tau}\left\|\psi_{i}\right\|<\infty$.

By Lemma 19, for each $i \in \tau$ we have

$$
1=\left|\psi_{i}\left(f_{i}\right)\right| \leq \sum_{n=1}^{\infty} c_{n}\left|\psi_{i}\left(\chi_{n}(\cdot) x_{n}^{i}\right)\right|
$$

where $x_{n}^{i}=\int_{0}^{1} \chi_{n}(s) f_{i}(s) d s$, and thus there exists $m_{i} \geq 1$ such that

$$
\frac{1}{2}<\sum_{n=1}^{m_{i}} c_{n}\left|\psi_{i}\left(\chi_{n}(\cdot) x_{n}^{i}\right)\right| .
$$

Put $\mathcal{M}=\left\{m_{i}: i \in \tau\right\}$ and for each $m \in \mathcal{M}$ define $\alpha_{m}=\left\{i \in \tau: m_{i}=m\right\}$. Since $\mathcal{M}$ is countable and $\tau$ has uncountable cofinality, there exists $M \in \mathcal{M}$ such that $\left|\alpha_{M}\right|=\tau$. Setting $\tau_{1}=\alpha_{M}$, we have

$$
\frac{1}{2}<\sum_{n=1}^{M} c_{n}\left|\psi_{i}\left(\chi_{n}(\cdot) x_{n}^{i}\right)\right|, \forall i \in \tau_{1}
$$

Next, for each $i \in \tau_{1}$ there exists $1 \leq n_{i} \leq M$ satisfying

$$
\frac{1}{2 M}<c_{n_{i}}\left|\psi_{i}\left(\chi_{n_{i}}(\cdot) x_{n_{i}}^{i}\right)\right|
$$

Let $\mathcal{N}=\left\{n_{i}: i \in \tau_{1}\right\}$ and for each $n \in \mathcal{N}$ consider $\beta_{n}=\left\{i \in \tau_{1}: n_{i}=n\right\}$. Since $\mathcal{N}$ is finite, there exists $N \in \mathcal{N}$ such that $\left|\beta_{N}\right|=\tau$. Setting $\tau_{2}=\beta_{N}$, we obtain

$$
\begin{equation*}
\frac{1}{2 M c_{N}}<\left|\psi_{i}\left(\chi_{N}(\cdot) x_{N}^{i}\right)\right|, \forall i \in \tau_{2} \tag{4.2}
\end{equation*}
$$

For each $i \in \tau_{2}$, write $x_{i}=x_{N}^{i}$ and consider the linear functional $x_{i}^{*} \in X^{*}$ defined by

$$
x_{i}^{*}(x)=\psi_{i}\left(\chi_{N}(\cdot)(x)\right), \forall x \in X
$$

By (4.2), we obtain

$$
\frac{1}{2 M c_{N}}<\left|x_{i}^{*}\left(x_{i}\right)\right| \leq\left\|\psi_{i}\right\|\left\|\chi_{N}(\cdot) x_{i}\right\|_{p} \leq \delta\left\|\chi_{N}\right\|_{p}\left\|x_{i}\right\|, \forall i \in \tau_{2},
$$

and therefore

$$
\begin{equation*}
\Delta<\left\|x_{i}\right\|, \forall i \in \tau_{2} \tag{4.3}
\end{equation*}
$$

where $\Delta=\left(2 M s c_{N}\left\|\chi_{N}\right\|_{p}\right)^{-1}$.
Next, let $\left(e_{i}\right)_{i \in \tau}$ be the unit-vector basis of $c_{0}(\tau)$ and $T: c_{0}(\tau) \rightarrow$ $L_{p}([0,1], X)$ be an isomorphism from $c_{0}(\tau)$ onto its image such that $T\left(e_{i}\right)=$ $f_{i}$, for each $i \in \tau$. Consider $P: L_{p}([0,1], X) \rightarrow X$ the linear operator defined by

$$
P(f)=\int_{0}^{1} \chi_{N}(s) f(s) d s, \forall f \in L_{p}([0,1], X) .
$$

By (4.3), we have

$$
\left\|(P \circ T)\left(e_{i}\right)\right\|=\left\|x_{i}\right\| \geq \Delta>0, \forall i \in \tau_{2}
$$

Therefore, by [23, Remark following Theorem 3.4], there exists $\tau_{3} \subset \tau_{2}$ such that $\left|\tau_{3}\right|=\tau$ and $P \circ T_{c_{0}\left(\tau_{3}\right)}$ is an isomophism onto its image; hence,

$$
\left(x_{i}\right)_{i \in \tau_{3}}=\left(P\left(T\left(e_{i}\right)\right)_{i \in \tau_{3}}\right.
$$

is equivalent to the unit-vector basis of $c_{0}\left(\tau_{3}\right)$.
Finally, given $x \in X$, observe that

$$
\left(x_{i}^{*}(x)\right)_{i \in \tau_{3}}=\left(\psi_{i}\left(\chi_{N}(\cdot)(x)\right)\right)_{i \in \tau_{3}} \in c_{0}\left(\tau_{3}\right)
$$

since $\left(\psi_{i}\right)_{i \in \tau}$ is weak*-null by hypothesis. This proves that $\left(x_{i}^{*}\right)_{i \in \tau_{3}}$ is weak*null in $X^{*}$.

Combining these facts with (2.1), an appeal to Theorem 6 yields a complemented copy of $c_{0}(\tau)$ in $X$.

We do not know if the statement of Theorem 20 remains true in the case $p=\infty$.
