# On the finiteness of the moments of the measure of level sets of random fields

#### Abstract

General conditions on smooth real valued random fields are given that ensure the finiteness of the moments of the measure of their level sets. As a by product a new generalized Kac-Rice formula (KRF) for the expectation of the measure of these level sets is obtained when the second moment can be uniformly bounded. The conditions involve (i) the differentiability of the trajectories up to a certain order $k$, (ii) the finiteness of the moments of the $k$-th partial derivatives of the field up to another order, (iii) the boundedness of the joint density of the field and some of its derivatives. Particular attention is given to the shot noise processes and fields. Other applications include stationary Gaussian processes, Chi-square processes and regularized diffusion processes.

## 1 Introduction

The study of level sets of random fields occupies a key role in several branches of mathematics as random algebraic geometry, probability and mathematical physics. The interest is centered in different geometric charateristics of the level sets, tipically, their geometric measure. Depending on the dimensions, these characteristics can be the number of crossings of a stochastic process, the length of level curves of a random field, etc. Since the actual distribution of these random variables is usually out of reach it is natural to study their moments and asymptotic distributions.

The present work is concerned with the following two issues: (i) assessing the finiteness of the moments and (ii) their computation or estimation. For (ii) the main tool is the Kac-Rice formula (KRF for short) which give the expected value and the higher order moments of the measure of level sets of smooth random fields. These two issues are highly connected, for instance:

- The KRF of order one is, in general, valid under conditions that imply (without further hypothesis) that the expectation is finite. Furthermore, in some cases, necessary and sufficient conditions for the finiteness of the expectation of the measure of level sets can be obtained from the KRF (see [4] and the references therein).
- The KRF of order two can be used to obtain the finiteness of the second moment of the measure of level sets as in the works (17] and [20. Note also that some complicated study has been performed for higher moments in 8 .
- In the other direction, as it is explained in Section 7 , the finiteness of the second moment is a tool to establish the validity of the KRF.

The seminal works in the field are due to Kac 19 and Rice [28]. The KRFs were first established for Gaussian stochastic processes profiting from the fact that the Gaussian framework allows not only to obtain conditions under which the formulas are valid but also permits some explicit computations.

[^0]For random fields KRFs were also first obtained in the Gaussian case, see Adler [1]. It worths also to mention the recent works [3] and 4] where moments of the measure of nodal sets of a real valued Gaussian stationary field are shown to be finite. To have a panoramic and contemporary vision about these matters we refer to the books 2, 6] and 9.

Mainly motivated by the applications there has been an interest in studying such formulas for non Gaussian processes. A first successful attempt was that of Marcus [22] who provided a formula for the expected number of crossings of a process whose trajectories are absolutely continuous. Later on, Nualart \& Wschebor [24], by using properties of the trajectories of regular processes, show that the expectation of the number of crossings and its moments of order greater than one can be bounded. This result is based on the idea that a "nice function" cannot have too many zeros. Unfortunately, the proof heavily relies on the intermediate value theorem, and for this reason, it applies only to stochastic processes. The KRF for the measure of the level sets of fields (not necessarily Gaussian) was established by Wschebor in 32. However, it is important to point out that the hypothesis of these formulas are difficult to check. An important exception is when the field is a non-linear transformation of a Gaussian one, as is the case of $\chi^{2}$, $t$ or $F$ random fields. The books [2] and [6] contain a comprehensive update of these subjects. Crossings for discontinuous processes have been considered in 10, 15 and [16, the two last works include KRFs. The shot noise process has received attention in regard to crossing problems and KRF (see Biermé \& Desolneux, [11] and [13]).

Within the applications of the KRF we mention the random sea surface modeling, the articles [21], [26], [7] and [25] contain Gaussian and general KRFs. Worsley computes the expectations of some level sets characteristic in the context of medical image processing [31] and in astrophysics 30. Other applications and KRFs for fields can be found in the recent monograph 9$]$.

The present paper is concerned with the finiteness of the moments of level sets and with non Gaussian KRFs. The content of the paper is the following. In Section 2 we present a generalization of the result of $[24$ with, in our opinion, a simpler proof. Section 3 is devoted to the application of the previous result to different examples. Shot noise processes are considered in Section 4 . In Section 5 the previous result is extended to level sets of co-dimension one, that correspond to random fields from $\mathbb{R}^{d}$ and the sphere $S^{d}$ to $\mathbb{R}$. Section 6 is dedicated to shot noise random fields. Finally, Section 7 is devoted to the non Gaussian KRF. All results presented in the examples are new.

## 2 Processes from $\mathbb{R}$ to $\mathbb{R}$

The basic idea of this section is the following:
A real function $f($.$) defined on, say [0,1]$, with $k$ th derivative bounded by $M$ and $k$ zeroes satisfies

$$
|f(1 / 2)| \leq M \frac{(1 / 2)^{k}}{k!}
$$

If we replace this function by a random process $X$ that admits density bounded by $C$ at $1 / 2$, then the probability of such event is smaller than

$$
C M \frac{(1 / 2)^{k}}{k!}
$$

Theorem 2.1]is just a systematic exploitation of this method with some generalisation because we consider the joint density of $X(t)$ and some derivatives.

Assume that $X=\{X(t): t \in \mathbb{R}\}$ is a real valued stochastic process with smooth paths. Define the number of crossings through level $u$ by the process $X$ over the finite time interval $I \subset \mathbb{R}$ by

$$
N_{u}=N_{u}(I):=\#\{t \in I: X(t)=u\}
$$

Let $|I|$ denote the length of $I$ and let $\bar{I}$ be the middle point of $I$. We have the following result.
Theorem 2.1. Consider $u, X, I$ and $N_{u}$ as above. Assume that $X$ satisfies
(H1) The sample paths of $X$ are $C^{k}(I)$ for some $k \geq 1$.
(H2) For some $m=1,2, \ldots$, there exists a constant $D_{m}$ such that

$$
\mathbf{E}\left(\left|X^{(k)}\right|_{\infty}^{m}\right) \leq D_{m}
$$

(H3) There exist $0 \leq h \leq k$ and a constant $C>0$ such that the joint density of $X(t), X^{\prime}(t), \ldots, X^{(h)}(t)$ is bounded by $C$ uniformly in $t \in I$, and on a neighborhood of $(u, 0, \ldots, 0)$.
Then, for $p=1,2, \ldots$, such that

$$
\begin{equation*}
p<\left(k-\frac{h}{2}-\frac{1}{1+h}\right)\left(\frac{1}{m}+\frac{1}{1+h}\right)^{-1} \tag{1}
\end{equation*}
$$

the p-th moment of the number of the crossings $N_{u}$ is finite. More precisely:

$$
\mathbf{E}\left(N_{u}^{p}\right) \leq(k-1)^{p}+D_{m} \cdot E_{\alpha, k, p}+C|I|^{(h+1)(k-h / 2)} \cdot D_{\alpha, k, h, p},
$$

where $\alpha$ is any real number such that $\frac{p}{m}<\alpha<k-\frac{h}{2}-\frac{1+p}{1+h}$,

$$
E_{\alpha, k, p}=p k^{p} \sum_{a=0}^{\infty} \frac{(a+1)^{p}}{a^{m \alpha}}, \quad \text { and } \quad D_{\alpha, k, h, p}=\frac{2^{(h+1)(1+h / 2-k)}}{k!\cdot(k-h)!} \sum_{a=1}^{\infty}(a+1)^{p-1} a^{1-(h+1)(k-h / 2-\alpha)}
$$

Remark 2.2 (Large $m$ ). The limit case, when $m$ can be chosen arbitrarily large (as is the case for Gaussian processes), corresponds to $\alpha$ close to zero. The limit condition (11) then becomes

$$
p<\left(k-\frac{h}{2}\right)(h+1)-1
$$

Remark 2.3 (Large $k$ ). When the process $X$ has $C^{\infty}(I)$ paths, if (H2) holds true for $m=1$ with arbitrary $k$, and (H3) holds true for some $h=0,1, \ldots$, then, all the moments of $N_{u}$ are finite.

Remark $2.4(h=0)$. The case $h=0$ and $m=1$ corresponds to (3.23) in pg. 82 in [6], obtained in Lemma 1.2 in [24]. When $h=0$ and $m>1$ Theorem 2.1] gives the finiteness of the $p$ th moment for

$$
p<\frac{m}{m+1}(k-1) .
$$

Before proving the theorem we establish three preliminary lemmas.
Lemma 2.5. Consider a function $f: I \rightarrow \mathbb{R}$ of class $C^{k}(I)$ for an interval $I$. If $f-u$ has $k$ roots in $I$ and $h \leq k$, we have

$$
|f(\bar{I})-u| \leq \frac{\left|f^{(k)}\right|_{\infty}}{k!}\left(\frac{|I|}{2}\right)^{k},\left|f^{\prime}(\bar{I})\right| \leq \frac{\left|f^{(k)}\right|_{\infty}}{(k-1)!}\left(\frac{|I|}{2}\right)^{k-1}, \ldots,\left|f^{(h)}(\bar{I})\right| \leq \frac{\left|f^{(k)}\right|_{\infty}}{(k-h)!}\left(\frac{|I|}{2}\right)^{k-h}
$$

Proof. The proof is based on the Lagrange remainder form for polynomial interpolation. That is, let $g: I \rightarrow \mathbb{R}$ be $C^{k}, t_{1}, \ldots, t_{k} \in I$ and $P$ be the only polynomial of degree $k-1$ such that $g\left(t_{j}\right)=P\left(t_{j}\right), j=$ $1, \ldots, k$. Then, for $t \in I$ we have

$$
g(t)-P(t)=\frac{1}{k!} \prod_{j=1}^{k}\left(t-t_{j}\right) \cdot g^{(k)}(\xi)
$$

for some $\xi$ such that $\min \left\{t_{1}, \ldots, t_{k}, t\right\}<\xi<\max \left\{t_{1}, \ldots, t_{k}, t\right\}$, see Lemma 5.2, p. 135 in 6].
Now, for $g=f-u, t=\bar{I}$ and using as $t_{1}, \ldots, t_{k}$ the roots of $f-u$, we get $P=u$ and so the first inequality follows. The proofs of the other inequalities follow in a similar way.

Lemma 2.6. Let $Z$ be a random variable taking non negative integer values. Then

$$
\mathbf{E}\left(Z^{p}\right)=\sum_{\ell=1}^{\infty}\left(\ell^{p}-(\ell-1)^{p}\right) \mathbf{P}(Z \geq \ell) \leq p \sum_{\ell=1}^{\infty} \ell^{p-1} \mathbf{P}(Z \geq \ell)
$$

Proof. Use Fubini's Theorem and the convexity of the function $x \mapsto x^{p}$.
Lemma 2.7. Assume that conditions (H1), (H2) and (H3) of Theorem 2.1 hold true. Let $\ell \geq k$ and define $a$ and $r$ such that $\ell=a(k-1)+r$ with $1 \leq r \leq k-1$. Then, for $B>0$, we have:

$$
\mathbf{P}\left(N_{u} \geq \ell,\left|X^{(k)}\right|_{\infty} \leq B\right) \leq a C(2 B)^{h+1} \prod_{i=0}^{h}\left(\frac{|I|}{2 a}\right)^{k-i} \frac{1}{(k-i)!}
$$

where $C$ is the bound in (H3).

Proof. We divide $I$ into $a$ equal subintervals, s.t. at least one of them has $k$ zeros. After this, we use an union bound:

$$
\begin{array}{r}
\mathbf{P}\left(N_{u} \geq \ell,\left|X^{(k)}\right|_{\infty} \leq B\right)=\mathbf{P}\left(N_{u} \geq a(k-1)+r,\left|X^{(k)}\right|_{\infty} \leq B\right) \leq \mathbf{P}\left(\bigcup_{j=1}^{a}\left\{N_{u}\left(I_{j}\right) \geq k\right\},\left|X^{(k)}\right|_{\infty} \leq B\right) \\
\leq \sum_{j=1}^{a} \mathbf{P}\left(\left|X\left(\bar{I}_{j}\right)-u\right| \leq \frac{B}{k!}\left(\frac{|I|}{2 a}\right)^{k}, \bigcap_{i=1}^{h}\left|X^{(i)}\left(\bar{I}_{j}\right)\right| \leq \frac{B}{(k-i)!}\left(\frac{|I|}{2 a}\right)^{k-i}\right) \\
\leq a C \prod_{i=0}^{h} \frac{2 B}{(k-i)!}\left(\frac{|I|}{2 a}\right)^{k-i}
\end{array}
$$

obtaining the result.
Proof of Theorem 2.1. From Lemma 2.6, we have

$$
\begin{equation*}
\mathbf{E}\left(N_{u}^{p}\right) \leq(k-1)^{p}+\sum_{\ell=k}^{\infty} p \ell^{p-1} \mathbf{P}\left(N_{u} \geq \ell\right) \tag{2}
\end{equation*}
$$

In order to bound the summands in the r.h.s. of (2), for given $\ell$ consider $a$ and $r$ as in Lemma 2.7) and $\alpha>0$ to be defined later. We use the following bound:

$$
\mathbf{P}\left(N_{u} \geq \ell\right) \leq \mathbf{P}\left(N_{u} \geq \ell,\left|X^{(k)}\right|_{\infty} \leq a^{\alpha}\right)+\mathbf{P}\left(\left|X^{(k)}\right|_{\infty}>a^{\alpha}\right)
$$

Using now Lemma 2.7 for the first summand and Chebishev inequality for the second, we obtain

$$
\begin{aligned}
& \mathbf{E}\left(N_{u}^{p}\right) \leq(k-1)^{p}+p(k-1)^{p-1} \sum_{a=1}^{\infty}(a+1)^{p-1} \mathbf{P}\left(N_{u} \geq \ell\right) \\
& \leq(k-1)^{p}+p(k-1)^{p-1}\left(C 2^{h+1}\left(\frac{|I|}{2}\right)^{(h+1)(k-h / 2)} \prod_{i=0}^{h} \frac{1}{(k-i)!} \cdot \sum_{a=1}^{\infty}(a+1)^{p-1} a^{(h+1)(\alpha+h / 2-k)+1}\right. \\
&\left.+D_{m} \sum_{a=1}^{\infty}(a+1)^{p-1} a^{-m \alpha}\right) .
\end{aligned}
$$

The conditions for the simultaneous convergence of the two series above are

$$
\frac{p}{m}<\alpha<k-\frac{h}{2}-\frac{1+p}{1+h}
$$

Under condition (11), there always exists an adequate $\alpha$, concluding the proof of Theorem 2.1,

## 3 Examples

Example 3.1 (Conditional sine-cosine process). We begin with a toy example. Consider a random variable $\omega$ such that $\mathbf{E}\left(\omega^{M}\right)<\infty$ and $\mathbf{E}\left(\omega^{M+1}\right)=\infty$. This variable is the random frequency of a process $X=\{X(t): 0 \leq t \leq 2 \pi\}$ that we construct as

$$
X(t)=\xi_{1} \sin \omega t+\xi_{2} \cos \omega t
$$

where $\xi_{1}$ and $\xi_{2}$ are two standard normal independent random variables, also independent from $\omega$. Conditionally to the value of $\omega$, the process $X$ is a Gaussian sine-cosine process. It is clear that the density of $X(t)$ is standard normal for each $t$. Nevertheless, it should be observed that $X(t)$ is, in general, not a Gaussian process. The number $N_{0}$ of roots of $X(t)$ coincides with the number of roots of the process

$$
\tilde{X}(t)=\frac{\xi_{1}}{\sqrt{\xi_{1}^{2}+\xi_{2}^{2}}} \sin \omega t+\frac{\xi_{2}}{\sqrt{\xi_{1}^{2}+\xi_{2}^{2}}} \cos \omega t=\cos (\omega t-\theta)
$$

where $\theta=\arctan \left(\xi_{1} / \xi_{2}\right)$ is defined a.s. Therefore, $N_{0}$ satisfies $\left|N_{0}-2 \omega\right| \leq 2$. This means, that for the considered process, the maximal finite moment of $N_{0}[0,2 \pi]$ is $M$. To apply Theorem 2.1 we compute

$$
\left|X^{(k)}\right|_{\infty} \leq \omega^{k} \sqrt{\xi_{1}^{2}+\xi_{2}^{2}}
$$

Note that $\sqrt{\xi_{1}^{2}+\xi_{2}^{2}}$ follows a Rayleigh's distribution. Then, based on the independence of the three random variables above, we have

$$
\mathbf{E}\left(\left|X^{(k)}\right|_{\infty}^{m}\right) \leq H_{m} \mathbf{E}\left(\omega^{m k}\right)
$$

where $H_{m}$ is the finite moment of the Rayleigh distribution. So we can apply Theorem 2.1] with $h=0$, $k=M$ and $m=1$. This gives that the moments of order $p \leq(M-1) / 2$ are finite. This result should be compared with the true result, which is $M$.

Example 3.2 (Stationary Gaussian process). Consider a stationary Gaussian process with spectral measure supported in a set with an accumulation point. It is then possible to take $h=k$ and $m$ arbitrarily large (ex. 3.4 in [6]), and Formula (1) gives a finite moment of order

$$
p=\frac{k(k+1)}{2}-2 .
$$

To visualize it, see Table 1 .

| $k$ | 2 | 3 | 4 |
| :---: | :---: | :---: | :---: |
| $p$ | 1 | $2,3,4$ | $5,6,7,8$ |

Table 1: If $X$ is $C^{k}$, following Theorem 2.1 we obtain that $\mathbf{E}\left(N_{u}^{p}\right)$ is finite for values of $k$ and $p$ above.

This result improves the previous one obtained in [24], that is recovered in the case $h=0$ and $m=1$.
Example 3.3 (Chi-square process). Consider a Chi-square process $Y=\{Y(t): t \in \mathbb{R}\}$ given by

$$
Y(t)=|X(t)|^{2}=\sum_{i=1}^{n} X_{i}(t)^{2}
$$

where $X=\{X(t): t \in \mathbb{R}\}$ with $X(t)=\left(X_{1}(t), \ldots, X_{n}(t)\right)$ is an $\mathbb{R}^{n}$ valued random process whose coordinates are $n$ independent copies of a stationary Gaussian process with $C^{k}(\mathbb{R})$ paths and variance 1. First observe that the case $n=1$ admits an ad-hoc treatment. If $n=1$ for $u=0$ we have $N_{0}^{Y}[0, T]=$ $N_{0}^{X}[0, T]$, and for $u>0$ we have $N_{u}^{Y}[0, T]=N_{\sqrt{u}}^{X}[0, T]+N_{-\sqrt{u}}^{X}[0, T]$. For $n \geq 2$ the level $u=0$ is not interesting, as for this level the process is differentiable and non-negative and has a bounded density, so Bulinskaya Lemma (Prop. 1.20 in [6]) gives that a.s. the number of crossings is cero. In consequence we consider $n \geq 2$ and $u>0$. Observe that, excluding the uninteresting case where $\lambda_{2}=\operatorname{Var} X^{\prime}(t)=0$, the joint density of the random variables $X(t), X^{\prime}(t)$ is bounded, as they conform a pair of independent Gaussian random variables.

It is not difficult to check the hypothesis of Theorem 2.1] in two different situations: $n=2$ and $n \geq 3$. It is direct to see that $Y$ has $C^{k}$ paths and that $|Y|_{\infty}$ has moments of every order, when considering a finite interval $I \subset \mathbb{R}$. Observe now that $Y(0)$ has a $\chi^{2}(n)$ density, that is bounded for $n \geq 2$. We can then apply Theorem 2.1] with the given $k$, arbitrary $m$, and $h=0$. Based on (1) we obtain the finiteness of the moments of the crossings, for $u>0$, of order

$$
p=k-2
$$

A more refined analysis can be carried out. Regarding the derivative we have

$$
Y^{\prime}(t)=2 \sum_{i=1}^{n} X_{i}(t) X_{i}^{\prime}(t)
$$

We see that conditional to $X(t)$, the random variable $Y^{\prime}(t)$ has a Gaussian distribution with variance $4 \lambda_{2} Y(t)$. Its conditional density $p_{Y^{\prime} \mid X=x}$ is bounded by

$$
(\text { Const })(Y(t))^{-1 / 2}
$$

where (Const) denotes a meaningless constant which value may change from line to line.
Let now $B_{1}$ and $B_{2}$ be two Borel sets of $\mathbb{R}$ with respective measures $\left|B_{1}\right|$ and $\left|B_{2}\right|$. Writting $Y$ and $Y^{\prime}$ for $Y(t)$ and $Y^{\prime}(t)$

$$
\begin{align*}
\mathbf{P}\left(Y^{\prime} \in B_{1}, Y \in B_{2}\right) & =\int_{\mathbb{R}^{n}} d x \int_{B_{1}} d y p_{Y^{\prime} \mid X=x}(y) \mathbf{1}_{\left\{Y \in B_{2}\right\}} p_{X}(x) \\
\leq & (\text { Const }) \int_{\mathbb{R}^{n}}\left|B_{1}\right| Y^{-1 / 2} \mathbf{1}_{\left\{Y \in B_{2}\right\}} p_{X}(x) d x \\
& =(\text { Const })\left|B_{1}\right| \int_{B_{2}} y^{-1 / 2} p_{Y}(y) d y=(\text { Const })\left|B_{1}\right| \int_{B_{2}} y^{n / 2-3 / 2} e^{-y / 2} d y \tag{3}
\end{align*}
$$

where $p_{X}($.$) and p_{Y}($.$) are the density functions of X$ and $Y$ respectively. Note that we used the explicit expression of the density of a $\chi^{2}(n)$ distribution. When $n \geq 3$, the integral in (3) is bounded yielding that

$$
\mathbf{P}\left(Y^{\prime} \in B_{1}, Y \in B_{2}\right) \leq(\text { Const })\left|B_{1}\right|\left|B_{2}\right| .
$$

This proves that the process satisfies the hypotheses of Theorem 2.1 with $h=1$. The conclusion is that, for $n \geq 3$, the number of crossings of $Y$ has a finite moment of order

$$
p=2 k-3
$$

Example 3.4 (Regularized processes). In this example we consider the number of crossings with a level $u$ of a regularized diffusion. We depart from a diffusion $X=\{X(t): t \geq 0\}$ defined as the solution of the stochastic differential equation

$$
X(t)=x_{0}+\int_{0}^{t} b(s, X(s)) d s+\int_{0}^{t} \sigma(s, X(s)) d W(s), \quad t \geq 0
$$

Here $W=\{W(s): s \geq 0\}$ is a standard Brownian motion, $x_{0} \in \mathbb{R}$, and $b, \sigma:[0, \infty) \times \mathbb{R} \rightarrow \mathbb{R}$ are Lipschitz w.r.t. the second variable, that is, for $T>0$ there exists $K_{T}>0$ such that for $x, y \in \mathbb{R}$ and $0 \leq s \leq T$ it holds that

$$
|b(s, x)-b(s, y)|+|\sigma(s, x)-\sigma(s, y)| \leq K_{T}|x-y|
$$

Assume also the linear growth condition

$$
|b(s, x)|+|\sigma(s, x)| \leq K_{T}(1+|x|)
$$

Then, the above equation has a unique strong solution that satisfies

$$
\sup _{0 \leq t \leq T} \mathbf{E}\left(X(t)^{2}\right) \leq H_{T}<\infty
$$

for a constant $H_{T}$ (see Theorem 7.1 in [14). The regularized diffusion is defined by

$$
X_{\Psi}(t)=(\Psi * X)(t)
$$

where $\Psi: \mathbb{R} \rightarrow[0, \infty)$ is a $C^{\infty}$-function with support contained in $[-1,1]$ that integrates one. Thus, $X_{\Psi}$ is obtained from $X$ by path-wise convolution with $\Psi$. We consider two cases:

Case I. We assume that $b=0$ and $\sigma: \mathbb{R}^{+} \times \mathbb{R} \rightarrow \mathbb{R}$ is strictly positive and $C^{3}$.
Case II. The volatility $\sigma$ is strictly positive and $C^{3}$ as in Case I, and there exist constants $B_{T}, c_{T}$ and $C_{T}$ such that

$$
|b(s, x)| \leq B_{T}, \quad 0<c_{T} \leq \sigma(s, x) \leq C_{T}
$$

for all $0 \leq s \leq T$ and $x \in \mathbb{R}$.
We start with Case I. In what respect the hypothesis of Theorem 2.1 we have that $X_{\Psi}$ is $C^{\infty}$ since it inherits the regularity of $\Psi$. Furthermore, for $a$ large enough (depending on $\Psi$ ) the random variable $X_{\Psi}(t)$ has a uniformly bounded density on an interval $[a, T]$ for all finite $T$, see Lemma 3.1 in [24]. Besides, a direct computation gives

$$
\left|X_{\Psi}^{(h)}\right|_{\infty} \leq c \cdot|X|_{\infty}
$$

with $c=\int\left|\Psi^{(h)}(u)\right| d u$ and the infinite norm is taken on the interval $[a, T]$. Hence, it suffices to bound the moments of $|X|_{\infty}$. Now, the Burkholder-Davis-Gundy inequality gives

$$
\mathbf{E}\left(|X|_{\infty}^{2}\right) \leq C_{1} \mathbf{E}\left([X]_{T}\right)
$$

being $[X]_{T}$ the quadratic variation of $X$ on $[0, T]$. Now, by Theorem II-29 in Protter [27, we have

$$
\begin{aligned}
{[X]_{T} } & =\left[\int_{0}^{T} \sigma(s, X(s)) d W(s)\right]_{T}=\int_{0}^{T} \sigma(s, X(s))^{2} d s \\
& \leq K_{T}^{2} \int_{0}^{T}(1+|X(s)|)^{2} d s \leq 2 K_{T}^{2} \int_{0}^{T}\left(1+|X(s)|^{2}\right) d s
\end{aligned}
$$

Taking expectations, we have

$$
\mathbf{E}\left([X]_{T}\right) \leq 2 K_{T}^{2} \int_{0}^{T}\left(1+\mathbf{E}(X(s))^{2}\right) d s \leq 2 K_{T}^{2} T\left(1+H_{T}\right)<\infty
$$

Hence, by Theorem 2.1 with $h=0, m=2$ and arbitrary $k$, we obtain that

$$
\mathbf{E}\left(N_{u}^{p}\right)<\infty
$$

for all $p$, as obtained in [24].
For Case II, we apply Girsanov's theorem [14]. We then have two SDE

$$
\begin{aligned}
d X_{0}(t) & =\sigma(t, X(t)) d W(t) \\
d X(t) & =b(t, X(t)) d t+\sigma(t, X(t)) d W(t)
\end{aligned}
$$

Consider the density process

$$
\rho(t)=\exp \left(\int_{0}^{t} \frac{b(s, X(s))}{\sigma(s, X(s))} d W(s)-\frac{1}{2} \int_{0}^{t}\left(\frac{b(s, X(s))}{\sigma(s, X(s))}\right)^{2} d s\right)
$$

Then, Girsanov's Theorem states that for an arbitrary function on the trajectories of the process $F: C([0, T], \mathbb{R}) \rightarrow$ $\mathbb{R}$ we have $\mathbf{E}(F(X))=\mathbf{E}\left(\rho(T) F\left(X_{0}\right)\right)$. If $F$ is the $p$-power of the number of crossings on $[0, T]$, we have

$$
\mathbf{E}\left(N_{u}(I, X)^{p}\right)=\mathbf{E}\left(\rho(T) N_{u}\left(I, X_{0}\right)^{p}\right) \leq \mathbf{E}\left(\rho(T)^{2}\right)^{1 / 2} \mathbf{E}\left(N_{u}\left(I, X_{0}\right)^{2 p}\right)^{1 / 2}
$$

applying the Hölder inequality ( $X$ and $X_{0}$ are defined above). To bound the first expectation in the r.h.s. consider

$$
\rho(t)^{2}=\exp \left(2 \int_{0}^{t} \frac{b(s, X(s))}{\sigma(s, X(s))} d W(s)-2 \int_{0}^{t}\left(\frac{b(s, X(s))}{\sigma(s, X(s))}\right)^{2} d s\right) \exp \left(\int_{0}^{t}\left(\frac{b(s, X(s))}{\sigma(s, X(s))}\right)^{2} d s\right)
$$

Then

$$
\rho(t)^{2} \leq \exp \left(2 \int_{0}^{t} \frac{b(s, X(s))}{\sigma(s, X(s))} d W(s)-2 \int_{0}^{t}\left(\frac{b(s, X(s))}{\sigma(s, X(s))}\right)^{2} d s\right) \exp \left(\left(\frac{B_{T}}{c_{T}}\right)^{2} T\right)
$$

and

$$
\mathbf{E} \rho(T)^{2} \leq \exp \left(\left(\frac{B_{T}}{c_{T}}\right)^{2} T\right)<\infty
$$

As $\mathbf{E}\left(N_{u}\left(I, X_{0}\right)^{2 p}\right)$ is finite by Case I, the finiteness of $\mathbf{E}\left(N_{u}(I, X)^{p}\right)$ for all $p$ follows.

## 4 Shot noise processes

The stationary shot noise process $X=\left\{X(t): t \in \mathbb{R}^{d}\right\}$ is defined by

$$
\begin{equation*}
X(t)=\sum_{i} \beta_{i} g\left(t-\tau_{i}\right) \tag{4}
\end{equation*}
$$

where $\left(\beta_{i}\right)$ conform a sequence of i.i.d. random, the "impluse", variables, $\left(\tau_{i}\right)$ is a Poisson field on $\mathbb{R}^{d}$ with constant intensity $\lambda$, and $g: \mathbb{R}^{d} \rightarrow \mathbb{R}$ is some function called the kernel function. Following [11 we assume that $\beta_{1}$ is an integrable random variable and that $g \in L^{1}\left(\mathbb{R}^{d}\right)$. This ensures the a.s. convergence of the series in (4). A key issue to apply Theorem 2.1 is the verification of condition (H3) with $h=0$, that requires the boundedness of a density. This is a delicate issue, as was previously noticed by Biermé and Desolneux in [11] (see also [12), that is the main reference of this section, from where we borrow the presentation and notations. We consider below $d=1$, the case $d>1$ (as well as shot noise random fields defined on the sphere) will be considered in Section 6. We begin by specializing Theorem 2.1 to the present situation.

Corollary 4.1. Consider a stationary shot noise process (4) satisfying condition (H1) for some $k \geq 1$, (H2) for some $m \geq 1$ and $k$ above, and (H3) for $h=0$. Then

$$
\mathbf{E}\left(N_{u}^{p}\right)<\infty
$$

for

$$
\begin{equation*}
p<\frac{m}{m+1}(k-1) . \tag{5}
\end{equation*}
$$

The rest of the section is devoted to obtain sufficient conditions to verify this corollary. The differentiability of the sample paths follows directly from the differentiability of the kernel $g$ :

$$
X^{(k)}(t)=\sum_{i} \beta_{i} g^{(k)}\left(t-\tau_{i}\right)
$$

provided that the $k$-th derivative of $g$ is integrable, i.e. $g^{(k)} \in L^{1}(\mathbb{R})$.
Boundedness of moments (H2). We now give conditions on the impulse and the kernel in order to verify (H2) for given $k$ and $m$. For simplicity of exposition we assume that $I=[-1,1]$, the general case can be treated in the same way. We consider the partition of the real line $I_{1}=I=[-1,1]$ and $I_{n}=[-n,-n+1) \cup(n-1, n](n \geq 2)$. In this way we can write

$$
X^{(k)}(t)=\sum_{n=1}^{\infty} \sum_{i: \tau_{i} \in I_{n}} \beta_{i} g^{(k)}\left(t-\tau_{i}\right)
$$

Proposition 4.2. Consider the shot noise in (4) with impulse s.t. $\mathbf{E}\left(\left|\beta_{1}\right|^{m}\right)<\infty$ for given $m \geq 1$. Define

$$
d_{k, n}=\sup _{t \in I_{1}, s \in I_{n}}\left|g^{(k)}(t-s)\right|
$$

for $k \geq 1$, and assume that

$$
\begin{equation*}
D_{k}=\sum_{n=1}^{\infty} d_{k, n}<\infty \tag{6}
\end{equation*}
$$

Then, the condition (H2) holds true for $m$ and $k$ as above, i.e.

$$
\mathbf{E}\left(\left|X^{(k)}\right|_{\infty}^{m}\right)<\infty
$$

Proof. We have

$$
\begin{aligned}
\left|X^{(k)}\right|_{\infty}= & \max _{-1 \leq t \leq 1}\left|X^{(k)}(t)\right| \leq \max _{-1 \leq t \leq 1} \sum_{n=1}^{\infty} \sum_{i: \tau_{i} \in I_{n}}\left|\beta_{i}\right|\left|g^{(k)}\left(t-\tau_{i}\right)\right| \\
& \leq \sum_{n=1}^{\infty} \sum_{i: \tau_{i} \in I_{n}}\left|\beta_{i}\right| \max _{-1 \leq t \leq 1}\left|g^{(k)}\left(t-\tau_{i}\right)\right| \leq \sum_{n=1}^{\infty} \sum_{i: \tau_{i} \in I_{n}}\left|\beta_{i}\right| \sup _{-1 \leq t \leq 1, s \in I_{n}}\left|g^{(k)}(t-s)\right| \\
& =\sum_{n=1}^{\infty} d_{k, n} Z_{n}
\end{aligned}
$$

where $Z_{n}:=\sum_{\tau_{i} \in I_{n}}\left|\beta_{i}\right|$. As the sets $I_{n}$ are disjoint and have the same length, the random variables $Z_{n}$ are i.i.d. Each one has a compound Poisson distribution. As $\mathbf{E}\left(\left|\beta_{1}\right|^{m}\right)<\infty$ we obtain $\mathbf{E}\left(Z_{1}^{m}\right)<\infty$. We now use Jensen's property, based on the convergence in (6), to obtain the following bound:

$$
\left(\sum_{n=1}^{\infty} d_{k, n} Z_{n}\right)^{m}=D_{k}^{m}\left(\sum_{n=1}^{\infty} \frac{d_{k, n}}{D_{k}} Z_{n}\right)^{m} \leq D_{k}^{m-1} \sum_{n=1}^{\infty} d_{k, n} Z_{n}^{m}
$$

Now, as the random variables $Z_{n}^{m}$ are i.i.d. and have finite moments,

$$
\mathbf{E}\left(\left|X^{(k)}\right|_{\infty}^{m}\right) \leq D_{k}^{m-1} \sum_{n=1}^{\infty} d_{k, n} \mathbf{E}\left(Z_{n}^{m}\right)=D_{k}^{m} \mathbf{E}\left(Z_{1}^{m}\right)<\infty
$$

concluding that condition (H2) holds true for $k$ and $m$.
Remark 4.3. Given a kernel $g^{(k)}: \mathbb{R} \rightarrow \mathbb{R}$ we define by $G^{(k)}:[0, \infty) \rightarrow[0, \infty)$ the monotone hull of $\max \left(\left|g^{(k)}(t)\right|,\left|g^{(k)}(-t)\right|\right), \quad t \geq 0$, as the smallest non-increasing function that dominates $\left|g^{(k)}(t)\right|$ and $\left|g^{(k)}(-t)\right|$ for $t \geq 0$. More precisely $G^{(k)}(t)=\sup _{s>t}\left(\left|g^{(k)}(s)\right|,\left|g^{(k)}(-s)\right|\right)$. Then condition (6) is implied by the integrability of $G^{(k)}$. Then, when the kernel $g^{(k)}$ decreases monotonously for large positive and large negative values, condition (6) follows automatically from the integrability of the kernel $g^{(k)}$.

Boundedness of the density (H3). In [12] Section 3.2, it is shown that when $\beta_{1}=1$ a.s., in the two following particular situations the stationary shot noise process has a bounded density:
(a) The kernel is $g(t)=e^{-t} \mathbf{1}_{\{t \geq 0\}}$, and the intensity $\lambda>1$.
(b) The kernel satisfies $g(t)=t^{-\alpha}$ for $t \geq A$ for some $A>0$ and $\alpha>1 / 2$.

We present below a generalization of the results of [11], that constitutes one of the contributions of the present paper.

Proposition 4.4. Consider a shot noise process (4) with a differentiable kernel. Denote by $T$ an exponential random variable with parameter $\lambda$. Assume that either
(A) The impulse $\beta_{1}$ has a density bounded by $B$ and $\mathbf{E}(1 /|g(-T)|)<\infty$ or $\mathbf{E}(1 /|g(T)|)<\infty$.
(B1) Assume that $\mathbf{E}\left(1 /\left|\beta_{1}\right|\right)<\infty$. Assume further that $g(x)$ has a strictly negative derivative in $(0,+\infty)$, and the function

$$
g_{*}^{+}(t):=\inf _{0 \leq s \leq t}\left|g^{\prime}(s)\right|,(t \geq 0)
$$

satisfies $\mathbf{E}\left(1 / g_{*}^{+}(T)\right)<\infty$.
(B2) The same than (B1) replacing $g(x)$ by $g(-x)$ and $g_{*}^{+}(t)$ by

$$
g_{*}^{-}(t):=\inf _{0 \leq s \leq t}\left|g^{\prime}(-s)\right|, \quad(t \geq 0)
$$

Then $X(0)$ has a bounded density.
Note that Proposition 4.4 implies (H3) with $h=0$. The proof requires the following simple result, that has a direct proof.

Lemma 4.5. Consider two independent random variables $X$ and $Y$, where $X$ has a density bounded by $B$.
(a) Then, the sum $X+Y$ has a density bounded by $B$.
(b) If $\mathbf{E}(1 /|Y|)<\infty$, the product $X Y$ has a density bounded by $B \mathbf{E}(1 /|Y|)$.

Proof of Proposition 4.4. Consider (A), assuming that $\mathbf{E}(1 /|g(-T)|)<\infty$ (the other case is analogous). Based on Lemma 4.5] and the decomposition

$$
X(0)=\sum_{i: \tau_{i}>0} \beta_{i} g\left(-\tau_{i}\right)+\sum_{i: \tau_{i} \leq 0} \beta_{i} g\left(-\tau_{i}\right)=: X^{+}(0)+X^{-}(0)
$$

as $X^{+}(0)$ and $X^{-}(0)$ are independent, it is enough to see that $X^{+}(0)$ has a bounded density. Define by $T_{1}$ and $T_{2}$ the first two positive occurrences of the Poisson process. Condition on $T_{2}$ and apply (b) in Lemma 4.5 to obtain that $\beta_{1} g\left(-T_{1}\right)$ has a conditional density bounded by $B \mathbf{E}\left(1 /\left|g\left(-T_{1}\right)\right| \mid T_{2}\right)$. Applying now (a) in Lemma 4.5, we obtain that the sum $X^{+}(0)$ has a conditional density, denote it by $f_{X^{+}(0) \mid T_{2}}(x)$ with the same bound. Finally, integrating

$$
f_{X^{+}(0)}(x)=\mathbf{E}\left(f_{X^{+}(0) \mid T_{2}}(x)\right) \leq \mathbf{E}\left(B \mathbf{E}\left(1 /\left|g\left(-T_{1}\right)\right| \mid T_{2}\right)\right)=B \mathbf{E}\left(1 /\left|g\left(-T_{1}\right)\right|\right)
$$

concluding the proof in this case.
Let us consider now case (B). We see first that, conditional on $T_{2}$, the random variable $g\left(T_{1}\right)$ has a bounded density. In fact, by the change-of-variable formula

$$
f_{g\left(-T_{1}\right) \mid T_{2}}(u)=\frac{1}{\left|g^{\prime}\left(g^{-1}(u)\right)\right|} \frac{1}{T_{2}} \mathbf{1}_{\left\{g^{-1}(u) \leq T_{2}\right\}} \leq \frac{1}{T_{2} g_{*}^{+}\left(T_{2}\right)}
$$

By (b) in Lemma 4.5 the product $\beta_{1} g\left(T_{1}\right)$ has a conditional density bounded by

$$
\begin{equation*}
\frac{1}{T_{2} g_{*}^{+}\left(T_{2}\right)} \mathbf{E}\left(1 /\left|\beta_{1}\right|\right) \tag{7}
\end{equation*}
$$

Then, by conditional independence and (a) in Lemma 4.5 the sum $X^{+}(0)$ has a conditional density with the same bound. Finally, as the density of $T_{2}$ is $\lambda^{2} t_{2} e^{-\lambda t_{2}}$, integrating the bound (7), we obtain that

$$
f_{X^{+}(0)}(u)=\mathbf{E}\left(f_{X^{+}(0) \mid T_{2}}(u)\right) \leq \int_{0}^{\infty} \frac{1}{t_{2} g_{*}^{+}\left(t_{2}\right)} \mathbf{E}\left(1 /\left|\beta_{1}\right|\right) \lambda^{2} t_{2} e^{-\lambda t_{2}} d t_{2}=\lambda \mathbf{E}\left(1 /\left|\beta_{1}\right|\right) \mathbf{E}\left(1 / g_{*}^{+}(T)\right)
$$

This concludes the proof of the Proposition giving the respective bounds.
Corollary 4.6. Consider a shot noise process with a $C^{\infty}(\mathbb{R})$ kernel $g$ such that for every $k \geq 1$

$$
\begin{equation*}
g^{(k)}(t) \simeq c_{k}(t) e^{\alpha t} \text { as } t \rightarrow-\infty \quad \text { and } \quad g^{(k)}(t) \simeq C_{k}(t) e^{-\alpha t} \text { as } t \rightarrow+\infty \tag{8}
\end{equation*}
$$

where $\simeq$ means equivalence and $c_{k}, C_{k}$ are polynomials of an arbitrary degree. Assume furthermore that $\lambda>\alpha$ and $\mathbf{E}\left(\left|\beta_{1}\right|\right)<\infty$. If in addition either
(i) $\beta_{1}$ has bounded density, or
(ii) $\mathbf{E}\left(1 /\left|\beta_{1}\right|\right)<\infty$ and $g$, or $g(-x)$, has a strictly negative derivative on $(0,+\infty)$,
then

$$
\mathbf{E}\left(N_{u}^{p}\right)<\infty, \quad \text { for any } p \geq 1
$$

Proof. We apply Corollary 4.1 with $m=1$ and arbitrarily large $k$. In view of (5) this gives the result for arbitrary $p$. The kernel is differentiable for any $k$. The relation (8) ensures condition (6), as it gives the integrability of the derivatives of any order of the kernel. It remains to see that the density of $X(0)$ is bounded, and this follows in case (i) from the fact that $\lambda>\alpha$ giving $\mathbf{E}\left(1 /\left|g\left(-T_{1}\right)\right|\right)<\infty$, and the boundedness of the density follows by (A) in Proposition 4.4. In case (ii) we apply (B) in Proposition 4.4. In this way we conclude the proof.

## 5 Random fields from $\mathbb{R}^{d}$ and $S^{d}$ to $\mathbb{R}$

We begin with $\mathbb{R}^{d}$. Consider a real valued random field $X=\left\{X(t): t \in \mathbb{R}^{d}\right\}$ and define, for a given $u \in \mathbb{R}$, the level set $C_{u}$ restricted to $\mathbb{D}_{a}$ (the closed centered ball with radius $a$ ) by the formula

$$
C_{u}=C_{u}\left(\mathbb{D}_{a}\right):=\left\{t \in \mathbb{D}_{a}: X(t)=u\right\}
$$

Observe that, under regularity conditions, the level set $C_{u}$ is almost surely a manifold of co-dimension one (see [6]). The aim of the first part of this section is to generalize Theorem 2.1 into this framework.

To this end, we compute the $(d-1)$-dimensional Hausdorff measure of a Borel set $B$, based on Crofton's formula ([23] p. 31):

$$
\begin{equation*}
\mathcal{H}_{d-1}(B)=c_{d-1}(a) \int_{v \in S^{d-1}} \int_{y \in v^{\perp} \cap \mathbb{D}_{a}} \#\left\{B \cap \ell_{v, y}\right\} d v_{a}^{\perp}(y) d S^{d-1}(v) \tag{9}
\end{equation*}
$$

Here $d S^{d-1}$ is the uniform probability on the sphere $S^{d-1}, d v_{a}^{\perp}$ is the uniform probability on $v^{\perp} \cap \mathbb{D}_{a}$, and $\ell_{v, y}$ is the affine linear space $\{y+t v: t \in \mathbb{R}\}$. The constant $c_{d-1}(a)$ can be easily computed in the particular case of the boundary of $\mathbb{D}_{a}$, namely $S_{a}^{d-1}:=\left\{t \in \mathbb{R}^{d}:|t|=a\right\}$, yielding,

$$
\begin{equation*}
c_{d-1}(a)=\frac{1}{2} \mathcal{H}_{d-1}\left(S_{a}^{d-1}\right)=\frac{\pi^{d / 2}}{\Gamma(d / 2)} a^{d-1} . \tag{10}
\end{equation*}
$$

Remark 5.1. When $B \subset \mathbb{R}^{d}$ is a codimension 1 smooth submanifold $\mathcal{H}_{d-1}(B)$, coincides with the (induced) Riemannian measure.

In view of (9), to obtain the finiteness of the moments of $\mathcal{H}_{d-1}\left(C_{u}\right)$, the idea is to give conditions on $X$ that ensure that its restriction to an arbitrary line in $\mathbb{R}^{d}$ verifies the hypothesis of Theorem 2.1 for some values of $m, h$ and $k$, as stated in the following result.

Theorem 5.2. Consider a real valued random field $X=\left\{X(t): t \in \mathbb{D}_{a}\right\}$. Assume that $X$ satisfies
$\left(\mathrm{H}^{\prime}\right)$ The sample paths of $X$ are $C^{k}\left(\mathbb{D}_{a}\right)$.
(H2') For some $m=1,2, \ldots$ there exists a constant $D_{m}$ such that

$$
\max _{|v|=1} \mathbf{E}\left(\left|\frac{\partial^{k} X}{\partial v^{k}}\right|_{\infty}^{m}\right) \leq D_{m}
$$

where $\frac{\partial^{k}}{\partial v^{k}}$ denotes the $k$-th directional derivative w.r.t. the vector $v$.
( $\mathrm{H}^{\prime}$ ) For some $0 \leq h \leq k$ there exists a constant $C>0$ such that the joint density of

$$
X(t), \frac{\partial X(t)}{\partial v}, \ldots, \frac{\partial^{h} X(t)}{\partial v^{h}}
$$

is bounded by $C$ uniformly in $t \in \mathbb{D}_{a}, v \in S^{d-1}$, and in a neighborhood of $(u, 0, \ldots, 0)$ for a fixed level $u$.

Then, for $p \geq 1$ satisfying (1), the $p$-th moment of the measure of the level set $\mathcal{H}_{d-1}\left(C_{u}\right)$ is finite, and bounded by

$$
\left(c_{d-1}(a)\right)^{p}\left((k-1)^{p}+D_{m} \cdot E_{\alpha, k, p}+C|2 a|^{(h+1)(k-h / 2)} \cdot D_{\alpha, k, h, p}\right)
$$

where $\alpha$ and the coefficients $E_{\alpha, k, p}$ and $D_{\alpha, k, h, p}$ are as in Theorem 2.1.
Proof of Theorem 5.2. We first apply Jensen's inequality in (9):

$$
\begin{aligned}
\left(\mathcal{H}_{d-1}\left(C_{u}\right)\right)^{p} & =\left(c_{d-1}(a) \int_{v \in S^{d-1}} \int_{y \in v^{\perp} \cap \mathbb{D}_{a}} \#\left\{C_{u} \cap \ell_{v, y}\right\} d S^{d-1}(v) d v_{a}^{\perp}(y)\right)^{p} \\
& \leq\left(c_{d-1}(a)\right)^{p} \int_{v \in S^{d-1}} \int_{y \in v^{\perp} \cap \mathbb{D}_{a}}\left(\#\left\{C_{u} \cap \ell_{v, y}\right\}\right)^{p} d S^{d-1}(v) d v_{a}^{\perp}(y)
\end{aligned}
$$

Now, take expectation and apply Tonelli's Theorem,

$$
\mathbf{E}\left(\mathcal{H}_{d-1}\left(C_{u}\right)\right)^{p} \leq\left(c_{d-1}(a)\right)^{p} \int_{v \in S^{d-1}} \int_{y \in v^{\perp} \cap \mathbb{D}_{a}} \mathbf{E}\left(\#\left\{C_{u} \cap \ell_{v, y}\right\}\right)^{p} d S^{d-1}(v) d v_{a}^{\perp}(y)
$$

Let us apply Theorem 2.1 to the expectation inside the integral. It is clear that the bound is maximal when the interval is maximal, that corresponds to $y=0$. So, we get,

$$
\mathbf{E}\left(\mathcal{H}_{d-1}\left(C_{u}\right)\right)^{p} \leq\left(c_{d-1}(a)\right)^{p}\left((k-1)^{p}+D_{m} \cdot E_{\alpha, k, p}+C|2 a|^{(h+1)(k-h / 2)} \cdot D_{\alpha, k, h, p}\right)
$$

The expectation in the r.h.s. above is finite due to Theorem 2.1.
The following result is direct.
Corollary 5.3. Assume that the random field in Theorem 5.2 is Gaussian, with a spectral density. Then, the moment of order $p$ of the Hausdorff measure of $C_{u}$ is finite with $p=\frac{k(k+1)}{2}-2$.

Let us mention that the case $p=2$ and the case of arbitrary $p$ were considered in [5] and in 4] repectively.

We move to random fields defined on a sphere. Without loss of generality we can assume that the sphere is $S^{d}=\left\{x \in \mathbb{R}^{d+1}:|x|=1\right\}$.

Given $t \in S^{d}$ and a tangent vector $v \in T_{t} S^{d}$, we denote by $\frac{\partial^{k} X(t)}{\partial v^{k}}$ the $k$-th order derivative of $X$ along the sphere.

We refer to the definition of the integral geometric measure on homogeneous spaces in [29] or [18]. In this case, if $\mathcal{M} \subset S^{d}$ is a codimension one regular set, the Crofton's formula reads

$$
\begin{equation*}
\mathcal{H}_{d-1}(\mathcal{M})=\beta_{2, d+1} \int_{E \in G_{2, d+1}} \#(\mathcal{M} \cap E) d G_{2, d+1}(E) \tag{11}
\end{equation*}
$$

Here $G_{2, d+1}$ denotes the Grassmanian of 2-dimensional subspaces of $\mathbb{R}^{d+1}$, and the integral is with respect to the induced Haar measure as homogeneous space of the orthogonal group of $\mathbb{R}^{d+1}$, i.e. the unique probability measure that is invariant under the action of this group.

Remark 5.4. It is easy to see that the given probability meaure on $G_{2, d+1}$ can be generated by the span of two independent standard gaussian vectors on $\mathbb{R}^{d+1}$.
Remark 5.5. Note that $E \cap S^{d}$ is a great circle for every $E \in G_{2, d+1}$.
The constant $\beta_{2, d+1}$ can be compute in the same fashion as in (10). In this case we have

$$
\beta_{2, d+1}=\frac{\pi^{d / 2}}{\Gamma(d / 2)}
$$

Theorem 5.6. Consider a real valued random field $X=\left\{X(t): t \in S^{d}\right\}$. Assume that:
$\left(\mathrm{H} 1^{\prime \prime}\right) X$ is $C^{k}\left(S^{d}\right)$ for a given $k$.
$\left(H 2^{\prime \prime}\right)$ there exist $m \in \mathbb{N}$ and a constant $D_{m}$ such that

$$
\mathbf{E}\left(\max _{t \in S^{d}, v \in T_{t} S^{d},|v|=1}\left|\frac{\partial^{k} X(t)}{\partial v^{k}}\right|^{m}\right) \leq D_{m}
$$

( $\mathrm{H} 3^{\prime \prime}$ ) Let $0 \leq h \leq k$. Assume that there exists a constant $C>0$ such that the joint density of

$$
X(t), \frac{\partial X(t)}{\partial v}, \ldots, \frac{\partial^{h} X(t)}{\partial v^{h}}
$$

is bounded by $C$ uniformly in $t \in S^{d}$ and $v \in T_{t} S^{d},|v|=1$, and for a neighborhood of $(u, 0, \ldots, 0)$ for a fixed level $u$.

Then, for $p=1,2, \ldots$, satisfying (1) the $p$-th moment of the measure of the level curve $\mathcal{H}_{d-1}\left(C_{u}\right)$ is finite and bounded by

$$
\beta_{2, d+1}^{p}\left((k-1)^{p}+D_{m} \cdot E_{\alpha, k, p}+C|2 \pi|^{(h+1)(k-h / 2)} \cdot D_{\alpha, k, h, p}\right)
$$

where $\alpha$ and the coefficients $E_{\alpha, k, p}, D_{\alpha, k, h, p}$, are given in Theorem 2.1.
Proof. From Remark 5.5, and (11) applied to $\mathcal{M}=C_{u}$, we observe that

$$
\#\left(C_{u} \cap E\right)=\#\left\{t \in E \cap S^{d}: X(t)=u\right\}
$$

is the number of crossings of a process defined on a great circle of radius 1 in such a way that Theorem 2.1 can be applied. Now, the proof follows the same lines as proof of Theorem5.2

## 6 Shot noise random field

In this section we first consider a shot noise defined in $\mathbb{R}^{d}$ and then on the sphere $S^{d}$.
Consider a shot noise random field $X: \mathbb{R}^{d} \rightarrow \mathbb{R}$ defined by (4), where we now consider the case $d>1$. We are interested in the finiteness of high-order moments of the measure of level sets of this differentiable random field, restricted to the closed centered ball $\mathbb{D}_{a}$. For the computation of expectations of excursion sets of shot noise random fields with realizations with bounded variation (possibly discontinuous) see [13.

The following result is a direct application of Theorem 5.2,
Corollary 6.1. Consider a shot noise random field (4) satisfying condition (H1') for some $k \geq 1$, ( $\mathrm{H} 2^{\prime}$ ) for some $m \geq 1$ and $k$ above, and (H3') for $h=0$. Then

$$
\begin{equation*}
\mathbf{E}\left(\mathcal{H}_{d-1}\left(C_{u}\left(\mathbb{D}_{a}\right)\right)^{p}\right)<\infty \tag{12}
\end{equation*}
$$

for

$$
p<\frac{m}{m+1}(k-1)
$$

In the following paragraphs we obtain sufficient conditions to verify this corollary. The differentiability of the trajectories follows directly from the differentiability of the kernel $g$. Consider a multi-index $\alpha=\left(\alpha_{1}, \ldots, \alpha_{d}\right)$ of non-negative integers such that $|\alpha|=\sum_{i} \alpha_{i}=k$ and the usual notation for the partial derivatives. Then

$$
\frac{\partial^{k} X(t)}{\partial t^{\alpha}}=\sum_{i} \beta_{i} \frac{\partial^{k} g(t)}{\partial t^{\alpha}}\left(t-\tau_{i}\right)
$$

is a shot noise provided that the $\alpha$-th derivative of $g$ is integrable.
Boundedness of moments (H2'). For simplicity of exposition we take $a=1$, i.e. the unitary ball $\mathbb{D}_{1}$. Define the partition of $\mathbb{R}^{d}$ given by $A_{1}=\mathbb{D}_{1}$ and

$$
\left\{A_{n}=\mathbb{D}_{r_{n}} \backslash \mathbb{D}_{r_{n-1}}: n=2,3, \ldots\right\}
$$

where the sequence $\left(r_{n}\right)$ has $r_{1}=1$ and is such that the volume of each set $A_{n}$ equals the volume of $A_{1}$. In this way we can write

$$
\frac{\partial^{k} X}{\partial v^{k}}(t)=\sum_{n=1}^{\infty} \sum_{i: \tau_{i} \in A_{n}} \beta_{i} \frac{\partial^{k} g}{\partial v^{k}}\left(t-\tau_{i}\right)
$$

We now present a result useful to verify the moment condition ( $\mathrm{H} 2^{\prime}$ ). The proof follows the same lines as that of Proposition 4.2 in dimension one, and is omitted.

Proposition 6.2. Consider a shot noise with impulse s.t. $\mathbf{E}\left(\left|\beta_{1}\right|^{m}\right)<\infty$ for given $m$, and kernel s.t.

$$
D_{k}^{\prime}=\sum_{n=1}^{\infty} d_{k, n}^{\prime}<\infty, \text { for given } k
$$

with

$$
d_{k, n}^{\prime}=\sup _{|v|=1} \sup _{t \in A_{1}, s \in A_{n}}\left|\frac{\partial^{k} g}{\partial v^{k}}(t-s)\right| .
$$

Then, the condition $\left(\mathrm{H}^{\prime}\right)$ holds true for $m$ and $k$ as above, i.e.

$$
\sup _{|v|=1} \mathbf{E}\left(\left|\frac{\partial^{k} X}{\partial v^{k}}\right|_{\infty}^{m}\right)<\infty
$$

Boundedness of the density ( $\mathbf{H 3}^{\prime}$ ). Introduce the volume of the $d$-dimensional ball of radius $r$ by

$$
V(r)=k_{d} r^{d}, \quad k_{d}=\pi^{d / 2} / \Gamma(1+d / 2)
$$

Proposition 6.3. Consider a shot noise random field (4) with a differentiable kernel. Denote by $T_{1}$ the occurrence of the Poisson field closest to the origin with the Euclidean distance (a.s. defined). Assume that either
(A) The impulse $\beta_{1}$ has a density bounded by $B$ and $\mathbf{E}\left(1 /\left|g\left(-T_{1}\right)\right|\right)<\infty$.
(B) $\mathbf{E}\left(1 /\left|\beta_{1}\right|\right)<\infty$ and the function

$$
G_{*}(r):=\sup _{u \in \mathbb{R}} \int_{t \in g^{-1}(u) \cap B_{r}} \frac{1}{|\nabla g(t)|} d \mathcal{H}_{d-1}(t)
$$

satisfies $\mathbf{E}\left(G_{*}\left(\left|T_{1}\right|\right)\right)<\infty$.
Then $X(0)$ has a bounded density.
The following auxiliary result is needed in the proof under (B). Its proof is elementary and thus omitted.

Lemma 6.4. Denote by $\left(T_{n}\right)$ the occurrence of the Poisson field ordered by the Euclidean distance to the origin. Then, the random variables $\left|T_{1}\right|$ and $\left|T_{2}\right|$ have the following densities:

$$
f_{\left|T_{1}\right|}(x)=d \lambda k_{d} e^{-\lambda k_{d} x^{d}} x^{d-1}, \quad f_{\left|T_{2}\right|}(x)=d \lambda^{2} k_{d}^{2} e^{-\lambda k_{d} x^{d}} x^{2 d-1}
$$

Proof of Proposition 6.3. This proof follows the same lines as those of the proof of Proposition 4.4. To prove case (A), we write

$$
X(0)=\beta_{1} g\left(-T_{1}\right)+\sum_{i=2}^{\infty} \beta_{i} g\left(-T_{i}\right)
$$

Applying (b) in Lemma4.5]we obtain that $\beta_{1} g\left(-T_{1}\right)$ has a conditional density bounded by $B \mathbf{E}\left(1 /\left|g\left(-T_{1}\right)\right| \mid\right.$ $T_{2}$ ). Applying now (a) in Lemma 4.5 by conditional independence we obtain that the sum $X(0)$ has a conditional density: $f_{X(0) \mid T_{2}}(x)$ with the same bound. Finally, integrating

$$
f_{X(0)}(x)=\mathbf{E}\left(f_{X(0) \mid T_{2}}(x)\right) \leq \mathbf{E}\left(B \mathbf{E}\left(1 /\left|g\left(-T_{1}\right)\right| \mid T_{2}\right)\right)=B \mathbf{E}\left(1 /\left|g\left(-T_{1}\right)\right|\right)
$$

concluding the proof in this case.
Let us consider now case (B). Applying the co-area formula we see that, conditional on $T_{2}$, the random variable $g\left(-T_{1}\right)$ has a bounded density:

$$
f_{g\left(-T_{1}\right) \mid T_{2}}(u)=\int_{t \in g^{-1}(u) \cap \mathbb{D}_{\left|T_{2}\right|}} \frac{1}{|\nabla g(t)|} \frac{1}{k_{d}\left|T_{2}\right|^{d}} \mathcal{H}_{d-1}(d t) \leq \frac{G_{*}\left(\left|T_{2}\right|\right)}{k_{d}\left|T_{2}\right|^{d}}
$$

By (b) in Lemma 4.5 the product $\beta_{1} g\left(-T_{1}\right)$ has a conditional density bounded by

$$
\begin{equation*}
\frac{G_{*}\left(\left|T_{2}\right|\right)}{k_{d}\left|T_{2}\right|^{d}} \mathbf{E}\left(1 /\left|\beta_{1}\right|\right) \tag{13}
\end{equation*}
$$

Then, by conditional independence and (a) in Lemma 4.5, the sum $X(0)$ has a conditional density with the same bound (13). Integrating the bound (13), with the density of $\left|T_{2}\right|$ in Lemma 6.4, we obtain that

$$
\begin{aligned}
f_{X(0)}(x)=\mathbf{E}\left(f_{X(0) \mid T_{2}}(x)\right) & \leq \frac{\mathbf{E}\left(1 /\left|\beta_{1}\right|\right)}{k_{d}} \int_{0}^{\infty} \frac{G_{*}(r)}{r^{d}} e^{-\lambda k_{d} r^{d}} \lambda^{2} d k_{d}^{2} r^{2 d-1} d r \\
& =d k_{d} \lambda^{2} \mathbf{E}\left(1 /\left|\beta_{1}\right|\right) \int_{0}^{\infty} G_{*}(r) e^{-\lambda k_{d} r^{d}} r^{d-1} d r=\lambda \mathbf{E}\left(1 /\left|\beta_{1}\right|\right) \mathbf{E}\left(G_{*}\left(\left|T_{1}\right|\right)\right),
\end{aligned}
$$

which is finite because of our hypotheses, concluding the proof.
Example 6.5. Consider a shot noise with a radial kernel of the form $g(t)=e^{-|t|^{2 q}}(q=1,2, \ldots)$, and impulse s.t. $\mathbf{E}\left(\left|\beta_{1}\right|\right)<\infty$. Assume further that
(i) $2 q<d$, or $2 q=d$ and $\lambda k_{d}>1$,
(ii) $\beta_{1}$ has a bounded density, or $\mathbf{E}\left(1 /\left|\beta_{1}\right|\right)<\infty$.

Let us check the finiteness of the moments (12). It is straightforward to verify ( $\mathrm{H} 1^{\prime}$ ) and ( $\mathrm{H} 2^{\prime}$ ). To see $\left(\mathrm{H} 3^{\prime}\right)$ assume first that $\beta_{1}$ has a bounded density. Then, as $g$ is radial, we have

$$
\begin{equation*}
\mathbf{E}\left(\frac{1}{g\left(-T_{1}\right)}\right)=\mathbf{E}\left(\frac{1}{g\left(\left|T_{1}\right|\right)}\right)=\int_{0}^{\infty} \frac{1}{g(r)} f_{\left|T_{1}\right|}(r) d r<\infty \tag{14}
\end{equation*}
$$

due to the form of the kernel, Lemma 6.4, and condition (i).
Assume now that $\mathbf{E}\left(1 /\left|\beta_{1}\right|\right)<\infty$. The sup in the function $G_{*}(r)$ in $(\mathrm{B})$ in Proposition 6.3 is attained when $u=e^{-r^{2 q}}$, giving $G_{*}(r)=e^{r^{2 q}} r^{d-2 q}$. A computation similar to (14) gives $\mathbf{E} G_{*}\left(\left|T_{1}\right|\right)<\infty$. In conclusion, the hypothesis of Corollary 6.1 are valid with arbitrary $k$, obtaining that the shot noise random field (4) verifies (12) with arbitrary $p$.

Now we move to the shot noise random field defined on the sphere. Let $\mathcal{P}$ be the standard Poisson field on the unit sphere $S^{d}$ of $\mathbb{R}^{d+1}$. We realize $\mathcal{P}$ as a sequence $T_{1}, T_{2}, \ldots, T_{N}$ of uniformly distributed random points on $S^{d}$ where $N$ is a Poisson random variable, all variables being independent.

Let $g:[0, \pi) \rightarrow \mathbb{R}$ be a $\mathcal{C}^{\infty}$ function. The shot noise process is defined by

$$
\begin{equation*}
X(t)=\sum_{i=1}^{N} \beta_{i} g\left(\operatorname{dist}^{2}\left(t, T_{i}\right)\right), \quad t \in S^{d} \tag{15}
\end{equation*}
$$

where dist is the geodesic distance, and the $\beta_{i}$ 's are i.i.d. with distribution $F$.
We assume the following conditions:
(H4) $\beta_{1} g\left(\right.$ dist $\left.^{2}(t, T)\right)$ admits a density bounded, where $T$ has a uniform distribution on the sphere.
(H5) The distribution $F$ has moments of any order.
Note that (H4) is rather weak, it is met, for example, if $\beta_{1}$ has a bounded density and $g$ is strictly positive on $[0, \pi]$ (apply Lemma 4.5). We have the following result.

Proposition 6.6. Consider a shot noise random field defined by (15) and assume (H4)-(H5). Then, for every level $u \neq 0$, for every compact set $W$ and for every integer $p$

$$
\mathbf{E}\left(\mathcal{H}_{d-1}^{p}\left(C_{u} \cap W\right)\right)<\infty
$$

The proof follows from Theorem 5.6.

Differentiabliliy (H1 $\mathbf{H}^{\prime \prime}$ ) and Boundedness of moments (H2"). We now check (H1 ${ }^{\prime \prime}$ ) and (H2 ${ }^{\prime \prime}$ ) for arbitrary $k$ and $m$.

Let $v$ be a norm 1 vector orthogonal to $t \in S^{d}$. Since the number of realizations of $\mathcal{P}$ is almost surely finite, for any $k$, the derivative of $X$ along the sphere at $t \in S^{d}$ in the direction of $v$ is given by

$$
\frac{\partial^{k} X(t)}{\partial v^{k}}=\left.\sum_{i=1}^{N} \beta_{i} \frac{d^{k}}{d z^{k}} g\left(\operatorname{dist}^{2}\left(\gamma_{t, v}(z), T_{i}\right)\right)\right|_{z=0}
$$

where $\gamma_{t, v}(z)$ is a $\mathcal{C}^{\infty}$ arc-length parametrization of a great circle through $t$ in the direction of $v$ such that $\gamma_{t, v}(0)=t$.

Then, $X$ is $\mathcal{C}^{k}$ for all $k$, and by compactness of the sphere $S^{d}$ we obtain

$$
\frac{\partial^{k} X(t)}{\partial v^{k}} \leq(\text { Const }) \sum_{i=1}^{N} \beta_{i} .
$$

The condition (H5) implies that the compound Poisson distribution of $\sum_{i=1}^{N} \beta_{i}$ admits moments of every order giving the desired result.

Boundedness of the density ( $\mathbf{H} \mathbf{3}^{\prime \prime}$ ) with $h=0$. For simplicity we consider the hypothesis ( $\mathrm{H} 3^{\prime \prime}$ ) with $h=0$ and study the marginal density of $X(t)$.

Lemma 6.7. For every $t \in S^{d}$ the distribution of $X(t)$ is the sum of one atom at zero and a defective probability with bounded density.

Proof. We consider the distribution of $X(t)$ conditional to $\mathcal{P}\left(S^{d}\right)=k$ in the case $k>0$. Under that condition it is well known that the $T_{i}$ 's, $i=1 \ldots, k$, are i.i.d. with uniform distribution on $S^{d}$, so we write

$$
X(t)=\beta_{1} g\left(\operatorname{dist}^{2}\left(t, T_{1}\right)\right)+\sum_{i=2}^{k} \beta_{i} g\left(\operatorname{dist}^{2}\left(t, T_{i}\right)\right) .
$$

The terms in this sum are independent and, because of (H4), the first term has a bounded density. By convolution it is the same for the conditional distribution of $X(t)$ which admits a density bounded by the same constant. Since this bounds does not depend on $k$, it is also a bound for the density of $X(t)$ conditional to $\mathcal{P}\left(S^{d}\right)>0$. Obviously when $\mathcal{P}\left(S^{d}\right)=0, X(t)=0$ which gives the atom at zero.

## 7 Non Gaussian Kac-Rice Formula

Gaussian KRFs are valid under weak and simple conditions and a comprehensive reference is the book 6] that treats all the relevant dimensions, i.e. random fields $X$ from $\mathbb{R}^{D}$ to $\mathbb{R}^{d}$ with $d \leq D$. These formulas give the expectation or the higher moments of the $\mathcal{H}_{D-d}$ Hausdorff measure of

$$
C_{u}(H)=\{t \in H: X(t)=u\}
$$

that is the level set restricted to a compact set $H \subset \mathbb{R}^{D}$. Though the proofs use basically the change of variable formula (or its generalisation: the co-area formula) and have nothing to do with Gaussianity, its generalisation to non-Gaussian cases encounters difficulties in defining properly the quantities involved in the formulas.

For instance, in the simplest case, the KRF for the expectation when $D=d=1$ formally reads for a compact interval $I$ :

$$
\begin{equation*}
\mathbf{E}\left(N_{u}(I)\right)=\int_{I} \mathbf{E}\left(\left|X^{\prime}(t)\right| \mid X(t)=u\right) p_{X(t)}(u) d t \tag{16}
\end{equation*}
$$

In the non Gaussian case, the conditional expectation is defined only for almost every level $u$. As a consequence, the punctual values of the r.h.s. of (16) are not defined unless some kind of continuity is established. This is why the non Gaussian KRF requires complicated conditions. See [22] and [6] for the case $D=d=1$; for the case $D=d>1$ the only reference is [2]. To our knowledge, in the non-Gaussian case, with the exception of the complicated treatment in [32], there exist no proof of the KRF for the case $D>d$.

Often the process or the random field has $C^{k}$ paths with $k$ "large" and the conditions can be drastically simplified. This is the object of this section. Note that in its full generality the statement of the KRF can not be stated in the classical form.

Our first main result is the following:
Theorem 7.1. Let us consider a real-valued process $X=\{X(t), t \in I\}$, where $I$ is a bounded interval of $\mathbb{R}$. Assume that there exist $u \in \mathbb{R}$ and $\epsilon>0$ such that:
(a) The sample paths of $X$ are $C^{1}(I)$.
(b) $\sup _{|v-u|<\epsilon} \mathbf{E}\left(N_{v}(I)^{2}\right)<\infty$.
(c) The density of $X(t)$ at point $v$ is uniformly bounded for $t \in I$ and for $|v-u|<\epsilon$.

Then,

$$
\begin{equation*}
\mathbf{E}\left(N_{u}(I)\right)=\lim _{\delta \rightarrow 0} \frac{1}{2 \delta} \int_{I} \mathbf{E}\left(\left|X^{\prime}(t)\right| \mathbf{1}_{|X(t)-u| \leq \delta}\right) d t \tag{17}
\end{equation*}
$$

Suppose in addition that $X^{\prime}(t)$ has a finite expectation for every $t \in I$. Define for $|v-u|<\epsilon$

$$
R(v):=\int_{I} \mathbf{E}\left(\left|X^{\prime}(t)\right| \mid X(t)=v\right) p_{X(t)}(v) d t
$$

Then (17) can be rewritten as

$$
\begin{equation*}
\mathbf{E}\left(N_{u}(I)\right)=\lim _{\delta \rightarrow 0} \frac{1}{2 \delta} \int_{u-\delta}^{u+\delta} R(v) d v \tag{18}
\end{equation*}
$$

Proof. By (b) there exists a finite $K$ such that

$$
\mathbf{E}\left(N_{v}^{2}\right) \leq K
$$

for all $|v-u|<\epsilon$. Our conditions imply that, with probability 1 , the process $X(t)$ cannot take the value $u$ at the two extremities of $I$. In addition by the Bulinskaya Lemma (Prop. 1.20 in [6]) there are, with probability 1 , no extremes at the level $u$. Thus, the Kac Lemma (Lemma 3.1 in [6]) yields

$$
N_{u}=\lim _{\delta \rightarrow 0} N_{u}^{\delta}
$$

where $N_{u}^{\delta}$ is the Kac's counter defined by

$$
N_{u}^{\delta}:=\frac{1}{2 \delta} \int_{I}\left|X^{\prime}(t)\right| \mathbf{1}_{\{|X(t)-u| \leq \delta\}} d t
$$

By the area formula (Prop 6.1 in [6])

$$
N_{u}^{\delta}=\frac{1}{2 \delta} \int_{u-\delta}^{u+\delta} N_{v} d v
$$

This, associated to the Jensen inequality, implies that

$$
\mathbf{E}\left(\left(N_{u}^{\delta}\right)^{2}\right) \leq K
$$

This implies in turn that the family $N_{u}^{\delta}$ is uniformly integrable. As a consequence, $N_{u}^{\delta}$ converges also in $L^{1}$, yielding

$$
\mathbf{E}\left(N_{u}\right)=\lim _{\delta \rightarrow 0} \mathbf{E}\left(N_{u}^{\delta}\right)
$$

If we explicit the r.h.s. above we get directly (17). Under the integrability of $X^{\prime}(t)$, the conditional expectation $\mathbf{E}\left(\left|X^{\prime}(t)\right| \mid X(t)\right)$ is well defined giving (18).

Our next theorem concerns random fields defined on $\mathbb{R}^{D}$. Its statement is very close to that of Theorem 7.1. Its proof which is very similar to that of Theorem 7.1 is omitted.

Theorem 7.2. Let us consider a real-valued process $X=\{X(t), t \in H\}$, where $H$ is a compact subset of $\mathbb{R}^{D}$. Assume that $X$ satisfies the following conditions:
(a) The sample paths of $X$ are $C^{1}(H)$.
(b) $\sup _{|v-u|<\epsilon} \mathbf{E}\left(\mathcal{H}_{D-1}\left(C_{u}(H)\right)^{2}\right)<\infty$.
(c) The density of $X(t)$ is uniformly bounded for $t \in H$ and for $|v-u|<\epsilon$.

Then for $v$ in some neighborhood of $u$ :

1. Denote by $X^{\prime}$ the gradient of $X$. Then

$$
\mathbf{E}\left(\mathcal{H}_{D-1}\left(C_{v}(H)\right)\right)=\lim _{\delta \rightarrow 0} \frac{1}{2 \delta} \int_{H} \mathbf{E}\left(\left|X^{\prime}(t)\right| \mathbf{1}_{|X(t)-v| \leq \delta}\right) d t
$$

where the limit in the r.h.s. exists.
2. Suppose in addition that $X^{\prime}(t)$ has finite expectation for every $t \in H$. Then we can define around $u$

$$
R(v):=\int_{H} \mathbf{E}\left(\left|X^{\prime}(t)\right| \mid X(t)=v\right) p_{X(t)}(v) d t
$$

Equation (17) can be rewritten as

$$
\begin{equation*}
\mathbf{E}\left(N_{u}\right)=\lim _{\delta \rightarrow 0} \frac{1}{2 \delta} \int_{u-\delta}^{u+\delta} R(v) d v \tag{19}
\end{equation*}
$$

and the limits in the r.h.s. exists.

Remark 7.3. Analogous to the situation in Theorem 7.1 the finiteness of the second moment of the level set can be obtained using Theorem5.2,

Example 7.4 (The case $D=d=1$ ). Suppose that $X(t)$ satisfies the conditions of Theorem 2.1 with and $k, m, h$ such that

$$
p=2<\left(k-\frac{h}{2}-\frac{1}{1+h}\right)\left(\frac{1}{m}+\frac{1}{1+h}\right)^{-1}
$$

In most of the cases, it is very easy to see that the process also satisfies all the conditions of Theorem 7.1, although this fact is not an exact consequence. This is the case for all the examples considered in Section 3. Of course, for Gaussian processes and $\chi^{2}$ processes the validity of Rice formula has been known for a long time.

Example 7.5 (The case $D>d=1$ ). Consider the shot noise process defined by (4), and satisfying the hypotheses of Proposition 6.2. Its a by product of the proof of this proposition, that the process $X(t)$ satisfies all the conditions of Theorem 7.2 and that the KRF holds true.

Remark 7.6. Of course its is also possible to establish a theorem very similar to Theorem 7.2 for processes defined on the sphere. To avoid repetition it is omitted.
