# Boundary singularities of semilinear elliptic equations with Leray-Hardy potential

#### Abstract

We study existence and uniqueness of solutions of $\left(E_{1}\right)-\Delta u+\frac{\mu}{|x|^{2}} u+g(u)=\nu$ in $\Omega$, $u=\lambda$ on $\partial \Omega$, where $\Omega \subset \mathbb{R}_{+}^{N}$ is a bounded smooth domain such that $0 \in \partial \Omega, \mu \geq-\frac{N^{2}}{4}$ is a constant, $g$ a continuous nondecreasing function satisfying some integral growth condition and $\nu$ and $\lambda$ two Radon measures respectively in $\Omega$ and on $\partial \Omega$. We show that the situation differs considerably according the measure is concentrated at 0 or not. When $g$ is a power we introduce a capacity framework which provides necessary and sufficient conditions for the solvability of problem $\left(E_{1}\right)$.

## 1 Introduction

If $\mu$ is a real number and $N \geq 2$, the Schrödinger operator $\mathcal{L}_{\mu}$, defined in a domain $\Omega \subset \mathbb{R}^{N}$ by

$$
\mathcal{L}_{\mu} u:=-\Delta u+\frac{\mu}{|x|^{2}} u
$$

plays a fundamental role in analysis, because of Hardy's inequality, and in theoretical physics in connexion with uncertainty principle. When the singular point 0 belongs to $\Omega$, there exists a critical value

$$
\mu_{0}=-\left(\frac{N-2}{2}\right)^{2}
$$

If $\mu \geq \mu_{0}$ the operator $\mathcal{L}_{\mu}$ is bounded from below because of Hardy inequality

$$
\begin{equation*}
\int_{\Omega}|\nabla \phi|^{2}+\mu_{0} \int_{\Omega} \frac{\phi^{2}}{|x|^{2}} d x \geq 0 \quad \text { for all } \phi \in C_{0}^{\infty}(\Omega) \tag{1.1}
\end{equation*}
$$

Sharp properties of this inequality has been studied by Brezis and Vazquez [8]. When $\mu \geq \mu_{0}$, we studied in [14] the Hardy equation with absorption semi-linearity

$$
\left\{\begin{align*}
\mathcal{L}_{\mu} u+g(u)=\nu & \text { in } \Omega  \tag{1.2}\\
u=0 & \text { on } \partial \Omega
\end{align*}\right.
$$

for a Radon measure $\nu$ being able to be supported at origin in a bounded smooth domain $\Omega$, where $g$ is a continuous nondecreasing function, by using systematically a notion of weak solutions introduced in [13] associated to a dual formulation with a specific weight function because of the Leray-Hardy potential. In this framework, weak solutions to (1.2) in a class of weighted measures are obtained provided that $g$ satisfies some integrability condition. When this integrability condition is not satisfied by $g$, not all measures in the above class are suitable for solving (1.2). This is called the supercritical case. In the supercritical case and when $g(r)=|r|^{p-1} r$ with $p>1$, we showed that the set of suitable measures is associated to a property of absolute continuity with respect to some Bessel capacity.

In this article we are interested in the configuration where the singular point of the LerayHardy potential lies on the boundary of the domain $\Omega$ and we study the following equation

$$
\left\{\begin{aligned}
\mathcal{L}_{\mu} u+g(u)=\nu & \text { in } \Omega \\
u=\lambda & \text { on } \partial \Omega
\end{aligned}\right.
$$

where $\nu$ and $\lambda$ are bounded Radon measures respectively on $\Omega$ and $\partial \Omega$. When $\mu=0$ the first study is due to Gmira and Véron [17] who proved the existence and uniqueness of a very weak
solution. Such a solution $u$ is a function belonging to $L^{1}(\Omega)$ such that $\rho g(u) \in L^{1}(\Omega)$, where $\rho(x)=\operatorname{dist}(x, \partial \Omega)$, satisfying

$$
\int_{\Omega}(-u \Delta \zeta+g(u) \zeta) d x=-\int_{\partial \Omega} \frac{\partial \zeta}{\partial \mathbf{n}} d \nu
$$

for all $\zeta \in C_{c}^{1}(\bar{\Omega})$ such that $\Delta \zeta \in L^{\infty}(\Omega)$. The condition for the existence and uniqueness of a solution is

$$
\begin{equation*}
\int_{1}^{\infty}(g(s)-g(-s)) s^{-\frac{2 N}{N-1}} d s<\infty \tag{1.3}
\end{equation*}
$$

When $\mu \neq 0$, a typical domain is $\Omega=\mathbb{R}_{+}^{N}:=\left\{x=\left(x^{\prime}, x_{N}\right)=\left(x_{1}, \ldots, x_{N}\right)=x_{N}>0\right\}$. There exists a critical value

$$
\mu \geq \mu_{1}:=-\frac{N^{2}}{4}
$$

which is a fundamental value for the operator $\mathcal{L}_{\mu}$, being the best constant of the Hardy inequality

$$
\int_{\mathbb{R}_{+}^{N}}|\nabla \phi|^{2}+\mu_{1} \int_{\mathbb{R}_{+}^{N}} \frac{\phi^{2}}{|x|^{2}} d x \geq 0 \quad \text { for all } \phi \in C_{0}^{\infty}\left(\mathbb{R}_{+}^{N}\right)
$$

If $\mathbb{R}_{+}^{N}$ is replaced by a bounded domain $\Omega$ satisfying the condition

$$
\begin{equation*}
0 \in \partial \Omega, \Omega \subset \mathbb{R}_{+}^{N} \text { and }\langle x, \mathbf{n}\rangle=O\left(|x|^{2}\right) \text { for all } x \in \partial \Omega \tag{1}
\end{equation*}
$$

where $\mathbf{n}=\mathbf{n}_{x}$ is the outward normal vector at $x$, this inequality is never achieved and there exists a remainder [9]: if we set $R_{\Omega}=\max _{z \in \Omega}|z|$, there holds

$$
\begin{equation*}
\int_{\Omega}|\nabla \phi|^{2}+\mu_{1} \int_{\Omega} \frac{\phi^{2}}{|x|^{2}} d x \geq \frac{1}{4} \int_{\Omega} \frac{\phi^{2}}{|x|^{2} \ln ^{2}\left(|x| R_{\Omega}^{-1}\right)} d x \quad \text { for all } \phi \in C_{0}^{\infty}(\Omega) \tag{1.4}
\end{equation*}
$$

Note that the last condition in $\left(\mathcal{C}_{1}\right)$ holds if $\Omega$ is a $C^{2}$ domain. Put

$$
\alpha_{+}:=\alpha_{+}(\mu)=1-\frac{N}{2}+\sqrt{\mu+\frac{N^{2}}{4}} \text { and } \alpha_{-}:=\alpha_{-}(\mu)=1-\frac{N}{2}-\sqrt{\mu+\frac{N^{2}}{4}} .
$$

If $\Omega$ satisfies $\left(\mathcal{C}_{1}\right)$ there exists $\ell_{\mu}^{\Omega}>0$ defined by

$$
\ell_{\mu}^{\Omega}:=\min \left\{\int_{\Omega}\left(|\nabla v|^{2}+\frac{\mu}{|x|^{2}} v^{2}\right) d x: v \in C_{c}^{1}(\Omega), \int_{\Omega} v^{2} d x=1\right\} .
$$

If $\mu \geq \mu_{1}$ this first eigenvalue is achieved in the space $H_{\mu}(\Omega)$ which is the closure of $C_{c}^{1}(\Omega)$ for the norm

$$
v \mapsto\|v\|_{H_{\mu}(\Omega)}:=\sqrt{\int_{\Omega}\left(|\nabla v|^{2}+\frac{\mu}{|x|^{2}} v^{2}\right) d x} .
$$

Note that $H_{\mu}(\Omega)=H_{0}^{1}(\Omega)$ if $\mu>\mu_{1}, H_{0}^{1}(\Omega) \varsubsetneqq H_{\mu_{1}}(\Omega)$ and the imbedding of $H_{\mu_{1}}(\Omega)$ in $L^{2}(\Omega)$ is compact. We proved in [15] the positive eigenfunction $\gamma_{\mu}^{\Omega} \in H_{\mu}(\Omega)$ of $\mathcal{L}_{\mu}$ associated to the first eigenvalue $\ell_{\mu}^{\Omega}$ satisfies

$$
\left\{\begin{aligned}
\mathcal{L}_{\mu} \gamma_{\mu}^{\Omega} & =\ell_{\mu}^{\Omega} \gamma_{\mu}^{\Omega} & & \text { in } \Omega \\
\gamma_{\mu}^{\Omega} & =0 & & \text { on } \partial \Omega \backslash\{0\}
\end{aligned}\right.
$$

and there exist $c_{1}>c_{2}>0$ and $\tilde{c}>0$ such that for all $x \in \bar{\Omega} \backslash\{0\}$

$$
\begin{align*}
& c_{2}|x|^{\alpha_{+}-1} \rho(x) \leq \gamma_{\mu}^{\Omega}(x) \leq c_{1}|x|^{\alpha_{+}-1} \rho(x),  \tag{i}\\
& \left|\nabla \gamma_{\mu}^{\Omega}(x)\right| \leq \tilde{c} \frac{\gamma_{\mu}^{\Omega}(x)}{\rho(x)} \tag{ii}
\end{align*}
$$

This function will play the role as a weight function. Inequality (1.4) implies the existence of the Green kernel $G_{\mu}^{\Omega}$ with corresponding Green operator $\mathbb{G}_{\mu}^{\Omega}$. The Poisson kernel $K_{\mu}^{\Omega}$ of $\mathcal{L}_{\mu}$ in $\Omega \times \partial \Omega$ is constructed in [15], by a simple truncation as in [31] if $\mu \geq 0$, and by a more elaborate approximation in the general case. When $\mu>0$ the kernel has the property that

$$
K_{\mu}^{\Omega}(x, 0)=0 \quad \text { for all } x \in \bar{\Omega} \backslash\{0\},
$$

by [31, Theorem A.1]. The singular kernel $\phi_{\mu}^{\Omega}$ is the analogue in a bounded domain of the explicit singular solution $x \mapsto \phi_{\mu}(x)=|x|^{\alpha_{-}-1} x_{N}$ defined in $\mathbb{R}_{+}^{N}$, and it satisfies for all $x \in \bar{\Omega} \backslash\{0\}$,

$$
\begin{equation*}
c_{3}|x|^{\alpha_{-}-1} \rho(x) \leq \phi_{\mu}^{\Omega}(x) \leq c_{4}|x|^{\alpha_{-}-1} \rho(x) \quad \text { if } \mu>\mu_{1}, \tag{1.6}
\end{equation*}
$$

and

$$
\begin{equation*}
c_{5}|x|^{-\frac{N}{2}}(|\ln | x| |+1) \rho(x) \leq \phi_{\mu_{1}}^{\Omega}(x) \leq c_{6}|x|^{-\frac{N}{2}}(|\ln | x| |+1) \rho(x) . \tag{1.7}
\end{equation*}
$$

We assume that $\Omega$ is a bounded smooth domain such that $0 \in \partial \Omega$ and its normal vector $e_{N}=(0, \cdots, 0,1) \in \mathbb{R}^{N}$ at origin in the sequel. We define the $\gamma_{\mu}^{\Omega}$-dual operator $\mathcal{L}_{\mu}^{*}$ of $\mathcal{L}_{\mu}$ by

$$
\mathcal{L}_{\mu}^{*} \zeta=-\Delta \zeta-\frac{2}{\gamma_{\mu}^{\Omega}}\left\langle\nabla \gamma_{\mu}^{\Omega}, \nabla \zeta\right\rangle+\ell_{\mu}^{\Omega} \zeta \quad \text { for all } \zeta \in C^{1,1}(\Omega)
$$

It satisfies the following commutating property

$$
\mathcal{L}_{\mu}\left(\gamma_{\mu}^{\Omega} \zeta\right)=\gamma_{\mu}^{\Omega} \mathcal{L}_{\mu}^{*} \zeta
$$

Denote by $\mathfrak{M}\left(\Omega ; \gamma_{\mu}^{\Omega}\right)$ the set of Radon measures $\nu$ in $\Omega$ such that

$$
\sup \left\{\int_{\Omega} \zeta d|\lambda|: \zeta \in C_{c}(\Omega), 0 \leq \zeta \leq \gamma_{\mu}^{\Omega}\right\}:=\int_{\Omega} \gamma_{\mu}^{\Omega} d|\nu|<\infty .
$$

Thus, if $\nu \in \mathfrak{M}_{+}\left(\Omega ; \gamma_{\mu}^{\Omega}\right)$ the measure $\gamma_{\mu}^{\Omega} \nu$ is a bounded measure in $\Omega$. We also set

$$
\begin{equation*}
\beta_{\mu}^{\Omega}(x)=-\left.\frac{\partial \gamma_{\mu}^{\Omega}}{\partial \mathbf{n}}\right|_{\partial \Omega} \tag{1.8}
\end{equation*}
$$

The space of Radon measures $\lambda$ on $\partial \Omega \backslash\{0\}$ such that

$$
\sup \left\{\int_{\partial \Omega \backslash\{0\}} \zeta d|\lambda|: \zeta \in C_{c}(\partial \Omega \backslash\{0\}), 0 \leq \zeta \leq \beta_{\mu}^{\Omega}\right\}:=\int_{\partial \Omega \backslash\{0\}} \beta_{\mu}^{\Omega} d|\lambda|<\infty,
$$

is denoted by $\mathfrak{M}\left(\partial \Omega ; \beta_{\mu}^{\Omega}\right)$. The extension of $\lambda \in \mathfrak{M}_{+}\left(\partial \Omega ; \beta_{\mu}^{\Omega}\right)$ as a measure $\beta_{\mu}^{\Omega} \lambda$ in $\partial \Omega$ is given by

$$
\int_{\partial \Omega} \zeta d\left(\beta_{\mu}^{\Omega} \lambda\right)=\sup \left\{\int_{\partial \Omega} v \beta_{\mu}^{\Omega} d \lambda: v \in C_{c}(\partial \Omega \backslash\{0\}), 0 \leq v \leq \zeta\right\} \quad \text { for all } \zeta \in C(\partial \Omega), \zeta \geq 0
$$

and $\beta_{\mu}^{\Omega} \lambda=\beta_{\mu}^{\Omega} \lambda_{+}-\beta_{\mu}^{\Omega} \lambda_{-}$if $\lambda$ is a signed measure in $\mathfrak{M}\left(\partial \Omega ; \beta_{\mu}^{\Omega}\right)$, and this defines the set $\mathfrak{M}\left(\partial \Omega ; \beta_{\mu}^{\Omega}\right)$ of all such extensions. The Dirac mass at 0 does not belong to $\mathfrak{M}\left(\partial \Omega ; \beta_{\mu}^{\Omega}\right)$, but it is the limit of sequences of measures in this space. We proved in [15] that if $\nu \in \mathfrak{M}_{+}\left(\Omega ; \gamma_{\mu}^{\Omega}\right)$, $\lambda \in \mathfrak{M}\left(\partial \Omega ; \beta_{\mu}^{\Omega}\right)$ and $k \in \mathbb{R}$, the function

$$
u=\mathbb{G}_{\mu}^{\Omega}[\nu]+\mathbb{K}_{\mu}^{\Omega}[\lambda]+k \phi_{\mu}^{\Omega}:=\mathbb{H}_{\mu}^{\Omega}\left[\left(\nu, \lambda+k \delta_{0}\right)\right]
$$

is the unique function belonging to $L^{1}\left(\Omega, \rho^{-1} d \gamma_{\mu}^{\Omega}\right)$ satisfying

$$
\int_{\Omega} u \mathcal{L}_{\mu}^{*} \zeta d \gamma_{\mu}^{\Omega}=\int_{\Omega} \zeta d\left(\gamma_{\mu}^{\Omega} \nu\right)+\int_{\partial \Omega} \zeta d\left(\beta_{\mu}^{\Omega} \lambda\right)+k c_{\mu} \zeta(0)
$$

for all $\zeta \in \mathbb{X}_{\mu}(\Omega)=\left\{\zeta \in C(\bar{\Omega})\right.$ s.t. $\gamma_{\mu}^{\Omega} \zeta \in H_{\mu}(\Omega)$ and $\left.\rho \mathcal{L}_{\mu}^{*} \zeta \in L^{\infty}(\Omega)\right\}$, where

$$
c_{\mu}= \begin{cases}2 \sqrt{\mu-\mu_{1}} \int_{\mathbb{S}_{+}^{N-1}} \phi_{1}^{2} d S & \text { if } \mu>\mu_{1} \\ \left(\frac{N}{2}-1\right) \int_{\mathbb{S}_{+}^{N-1}} \phi_{1}^{2} d S & \text { if } \mu=\mu_{1}\end{cases}
$$

and $\phi_{1}$ is the positive eigenfunction of $\Delta_{\mathbb{S}^{N-1}}$ in $\mathbb{S}_{+}^{N-1}:=\left\{\left(x^{\prime}, x_{N}\right) \in \mathbb{R}^{N}:|x|=1, x_{N}>0\right\}$ with zero Dirichlet boundary condition with respect to the first eigenvalue.

Let $g: \mathbb{R} \mapsto \mathbb{R}$ be a continuous nondecreasing function satisfying $\operatorname{rg}(r) \geq 0$. Thanks to this result we can construct of weak solutions of the problem

$$
\left\{\begin{align*}
\mathcal{L}_{\mu} u+g(u) & =\nu & & \text { in } \Omega  \tag{1.9}\\
u & =\lambda+k \delta_{0} & & \text { on } \partial \Omega .
\end{align*}\right.
$$

Definition 1.1 Let $(\nu, \lambda) \in \mathfrak{M}\left(\Omega ; \gamma_{\mu}^{\Omega}\right) \times \mathfrak{M}\left(\partial \Omega ; \beta_{\mu}^{\Omega}\right)$ and $k \in \mathbb{R}$. A function $u \in L^{1}\left(\Omega, \rho^{-1} d \gamma_{\mu}^{\Omega}\right)$ is a weak solution of (1.9) if $g(u) \in L^{1}\left(\Omega, d \gamma_{\mu}^{\Omega}\right)$ and

$$
\int_{\Omega}\left(u \mathcal{L}_{\mu}^{*} \zeta+g(u) \zeta\right) d \gamma_{\mu}=\int_{\Omega} \zeta d\left(\gamma_{\mu} \nu\right)+\int_{\partial \Omega} \zeta d\left(\beta_{\mu}^{\Omega} \lambda\right)+k c_{\mu} \zeta(0) \text { for any } \zeta \in \mathbb{X}_{\mu}(\Omega)
$$

We set

$$
\begin{equation*}
p_{\mu}^{*}=1-\frac{2}{\alpha_{-}}=\frac{N+2+2 \sqrt{\mu-\mu_{1}}}{N-2+2 \sqrt{\mu-\mu_{1}}} \text { and } p_{\mu}^{* *}=1-\frac{2}{\alpha_{+}}=\frac{N+2-2 \sqrt{\mu-\mu_{1}}}{N-2-2 \sqrt{\mu-\mu_{1}}} . \tag{1.10}
\end{equation*}
$$

Note that $p_{0}^{*}=\frac{N+1}{N-1}, p_{\mu_{1}}^{*}=\frac{N+2}{N-2}, p_{\mu}^{* *}$ is defined only if $N \geq 3$ and $-\frac{N^{2}}{4} \leq \mu<1-N$.
Our first result deals with the existence of a solution with an isolated singularity on boundary:

Theorem A Assume $N \geq 3$ and $\mu \geq \mu_{1}$, or $N=2$ and $\mu>\mu_{1}$, and let $g: \mathbb{R} \mapsto \mathbb{R}$ be $a$ continuous nondecreasing function such that $\operatorname{rg}(r) \geq 0$. If there holds

$$
\begin{equation*}
\int_{1}^{\infty}(g(s)-g(-s)) s^{-1-p_{\mu}^{*}} d s<\infty \quad \text { if } \mu>\mu_{1} \tag{1.11}
\end{equation*}
$$

or

$$
\begin{equation*}
\int_{1}^{\infty}(g(s \ln s)-g(-s \ln |s|)) s^{-1-p_{\mu_{1}}^{*}} d s<\infty \quad \text { if } \mu=\mu_{1} \tag{1.12}
\end{equation*}
$$

then for any $k \in \mathbb{R}$ there exists a unique weak solution $u_{k \delta_{0}}$ to

$$
\left\{\begin{aligned}
\mathcal{L}_{\mu} u+g(u) & =0 & & \text { in } \Omega \\
u & =k \delta_{0} & & \text { on } \partial \Omega .
\end{aligned}\right.
$$

Furthermore,

$$
\lim _{x \rightarrow 0} \frac{u_{k \delta_{0}}(x)}{\phi_{\mu}^{\Omega}(x)}=\frac{k}{c_{\mu}}
$$

When the measures do not charge the point 0 , we have a result which is similar as the one proved in [17].

Theorem B Assume $N \geq 3$ and $\mu \geq \mu_{1}$, or $N=2$ and $\mu>\mu_{1}$, and let $g: \mathbb{R} \mapsto \mathbb{R}$ be a continuous nondecreasing function such that $r g(r) \geq 0$ satisfying

$$
\begin{equation*}
\int_{1}^{\infty}(g(s)-g(-s)) s^{-1-p_{0}^{*}} d s<\infty \tag{1.13}
\end{equation*}
$$

Then for any $(\nu, \lambda) \in \mathfrak{M}\left(\Omega ; \gamma_{\mu}^{\Omega}\right) \times \mathfrak{M}\left(\partial \Omega ; \beta_{\mu}^{\Omega}\right)$ there exists a unique weak solution $u$ to

$$
\left\{\begin{aligned}
\mathcal{L}_{\mu} u+g(u)=\nu & \text { in } \Omega \\
u=\lambda & \text { on } \partial \Omega .
\end{aligned}\right.
$$

Finally we construct a solution to (1.9) without restriction on the measures by gluing solutions corresponding to Theorems A and B provided $g$ satisfies the weak $\Delta_{2}$-condition already introduced in [14]:
There exists a continuous nondecreasing positive function $K: \mathbb{R}_{+} \mapsto \mathbb{R}_{+}$such that

$$
\begin{equation*}
|g(s+r)| \leq K(|r|)(|g(s)|+|g(r)|) \quad \text { for all } \quad(s, r) \in \mathbb{R} \times \mathbb{R} \quad \text { s.t. } \quad s r \geq 0 \tag{1.14}
\end{equation*}
$$

Theorem C Assume $N \geq 3$ and $\mu \geq \mu_{1}$, or $N=2$ and $\mu>\mu_{1}$, and let $g: \mathbb{R} \mapsto \mathbb{R}$ be $a$ continuous nondecreasing function such that $\operatorname{rg}(r) \geq 0$ satisfying the weak $\Delta_{2}$-condition and

$$
\begin{equation*}
\int_{1}^{\infty}(g(s)-g(-s)) s^{-1-\min \left\{p_{\mu}^{*}, p_{0}^{*}\right\}} d s<+\infty \tag{1.15}
\end{equation*}
$$

Then for any $(\nu, \lambda) \in \mathfrak{M}\left(\Omega ; \gamma_{\mu}^{\Omega}\right) \times \mathfrak{M}\left(\partial \Omega ; \beta_{\mu}^{\Omega}\right)$ and $k \in \mathbb{R}$ there exists a solution $u$ to the problem (1.9).

A nonlinearity $g$ for which problem (1.9) admits a solution is called subcritical. A couple of measures $(\nu, \lambda)$ for which problem (1.9) admits a solution is called $g$-good. In the supercritical case all the measures are not $g$-good. Besides the problem at 0 where (1.11)-(1.12) may or may not be satisfied, the admissibility of a measure depends on its concentration expressed in terms of Bessel capacities. We denote these capacities by $c_{\alpha, q}^{\mathbb{R}^{d}}$ where $d=N$ or $N-1$. In this framework we consider only the case where $g(r)=g_{p}(r):=|r|^{p-1} r$ with $p>1$. The following theorem is proved.
Theorem D Assume $\mu \geq \mu_{1}$ and $p>1$.
1- A measure $\nu \in \mathfrak{M}\left(\Omega ; \gamma_{\mu}^{\Omega}\right)$ is $g_{p}$-good if and only if it is absolutely continuous with respect to the $c_{2, p^{\prime}}^{\mathbb{R}^{N}}$-capacity.
2- $A$ measure $\lambda \in \mathfrak{M}\left(\partial \Omega ; \beta_{\mu}^{\Omega}\right)$ is $g_{p}$-good if and only if it is absolutely continuous with respect to the $c_{\frac{\mathbb{R}^{N}}{p}, p^{\prime}}^{\mathbb{R}^{-1}}$-capacity.

Similarly we have a characterization of removable singularities.
Theorem E Assume $\mu \geq \mu_{1}, p>1$ and $K \subset \bar{\Omega}$ is compact. Then any weak solution of

(ii) $c_{\frac{\mathbb{R}^{N}, p^{\prime}}{}}^{\mathbb{R}^{N-1}}(K)=0$ if $K \subset \partial \Omega \backslash\{0\}$.
(iii) $c_{2, p^{\prime}}^{\mathbb{R}^{N}}(K)=0$ and $c_{\frac{2}{p}, p^{\prime}}^{\mathbb{R}^{N-1}}(K \cap \partial \Omega)$ if $K \subset \bar{\Omega} \backslash\{0\}$.
(iv) $c_{\frac{2}{p}, p^{\prime}}^{\mathbb{R}^{N-1}}(K)=0$ and $p \geq p_{\mu}^{*}$ if $0 \in K \subset \partial \Omega$ and $K \backslash\{0\} \neq\{\emptyset\}$.
(v) $c_{2, p^{\prime}}^{\substack{p \\ \mathbb{R}}}(K \cap \Omega)=0, c_{\frac{2}{p}, p^{\prime}}^{\mathbb{R}^{N}-1}(K \cap \partial \Omega)=0$ and $p \geq p_{\mu}^{*}$ if $0 \in K \subset \bar{\Omega}$ and $K \cap \Omega \neq\{\emptyset\}$.

At end we characterize the behaviour of solutions of

This limit set is a connected compact subset of $\mathcal{E}_{\mu}$. If $u \geq 0, \mathcal{E}_{v} \subset \mathcal{E}_{\mu}^{+}$. Thus we prove the following.

In two cases the limit set is reduced to a single element of $\mathcal{E}_{\mu}$, whatever is the structure of this set.

Theorem I Assume $\mu \geq \mu_{1}, h \in C^{3}(\partial \Omega)$ and $u \in C^{2}(\Omega) \cap C(\bar{\Omega} \backslash\{0\})$ is a solution of (1.17)). 1- If $N+2 \sqrt{\mu-\mu_{1}}<4$ and $p=3$, then there exists $\omega \in \mathcal{S}_{\mu, p}$ such that

Furthermore, if $\partial \Omega$ is locally a straigh tline near 0 and the limit in (1.27) is zero, there exists $\ell \in \mathbb{R}$ such that (1.23) holds.

We end this article with a removability result.

Theorem J Assume $\mu \geq \mu_{1}, p \geq p_{\mu}^{*}, h \in C^{3}(\partial \Omega)$ and $u \in C^{2}(\Omega) \cap C(\bar{\Omega} \backslash\{0\})$ is a solution of (1.17). Then $u$ is actually the weak solution of (1.18).

The rest of this paper is organized as follows. In section 2, we recall Kato's inequality and prove the existence and uniqueness of semilinear elliptic equation with measures sources when the nonlinearity is subcritical. Section 3 is devoted to deal with the supcritical case by connecting the measures with Bessel capacities. Finally, we analyze the behaviors of solutions provided regular boundary conditions by considering associated problem on semi-sphere.

## 2 The subcritical case

### 2.1 Kato inequality

Proposition 2.1 Let $N \geq 2, \mu \geq \mu_{1}$ and $g: \Omega \times \mathbb{R} \mapsto \mathbb{R}$ be a continuous function satisfying

\geq & \frac{1}{4} \int_{\Omega_{r}} \frac{w^{2}}{|x|^{2} \ln ^{2}(|x|)} d x+\frac{k^{2}}{2} \int_{\Omega_{r}}\left(\left|\nabla \phi_{\mu}^{\Omega}\right|^{2}+\frac{\mu}{|x|^{2}}\left(\phi_{\mu}^{\Omega}\right)^{2}\right) d x,
\end{aligned}
$$

since $w \in H_{0}^{1}\left(\Omega_{r}\right)$, (1.4) holds and $G \geq 0$. Hence $\tilde{J}_{\mu}^{r}$ and therefore $J_{\mu}^{r}$ is coercive and since it is convex, it admits a unique minimum $u_{r}$, which is the unique classical solution of (2.4) by standard regularity and by Proposition 2.1 such that $0<u_{r} \leq \phi_{\mu}^{\Omega}$ in $\Omega_{r}$.

By monotonicity $0<u_{r} \leq u_{r^{\prime}}$ in $\Omega_{r^{\prime}}$ if $r \in\left(0, r^{\prime}\right)$. Let $u_{k}=\lim _{r \rightarrow 0} u_{r}$. Because of (2.3), $g\left(u_{r}\right) \rightarrow g\left(u_{0}\right)$ in $L^{1}\left(\Omega ; d \gamma_{\mu}^{\Omega}\right)$. Let $\gamma_{r}:=\gamma_{\mu}^{\Omega_{r}}$ be the first eigenfuntion of the operator

with corresponding eigenvalue $\ell_{r}:=\ell_{\mu}^{\Omega_{r}}$. We normalize $\gamma_{r}$ by $\gamma_{r}\left(x_{0}\right)=1$ for some fixed $x_{0}$ in $\Omega_{\frac{1}{4}}$. Then $\ell_{r}>\ell_{\mu}^{\Omega}$ and $\ell_{r} \rightarrow \ell_{\mu}^{\Omega}$ when $r \rightarrow 0$. Furthermore $\gamma_{r} \rightarrow \gamma_{\mu}^{\Omega}$ uniformly on $\bar{\Omega}_{r}$ for any
$\delta>0$, where $\gamma_{\mu}^{\Omega}\left(x_{0}\right)=1$. If $\zeta \in \mathbb{X}_{\mu}(\Omega)$, we have

& =\int_{\Omega_{r}}\left(\left(-\gamma_{r} \Delta \zeta-2\left\langle\nabla \gamma_{r}, \nabla \zeta\right\rangle+\ell_{r} \zeta \gamma_{r}\right) u_{r}+\zeta \gamma_{r} g\left(u_{r}\right)\right) d x-k \int_{\Gamma_{2, r}} \zeta \frac{\partial \gamma_{r}}{\partial \mathbf{n}} \phi_{\mu}^{\Omega} d S
\end{align*}
$$

Since

$$
-\int_{\Gamma_{2, r}} \frac{\partial \gamma_{r}}{\partial \mathbf{n}} \phi_{\mu}^{\Omega} d S=\int_{\Omega_{\epsilon}} \phi_{\mu}^{\Omega} \Delta \gamma_{r} d S-\int_{\Omega_{r}} \gamma_{r} \Delta \phi_{\mu}^{\Omega} d S=-\ell_{\epsilon} \int_{\Omega_{r}} \gamma_{r} \phi_{\mu}^{\Omega} d x
$$

then, letting $r \rightarrow 0$,

$$
\lim _{r \rightarrow 0} \int_{\Gamma_{2, r}} \frac{\partial \gamma_{r}}{\partial \mathbf{n}} \phi_{\mu}^{\Omega} d S=\ell_{\mu}^{\Omega} \int_{\Omega} \gamma_{\mu}^{\Omega} \phi_{\mu}^{\Omega} d x
$$

Noting from (2.5) that

\lim _{r \rightarrow 0} \int_{\Omega_{r}}\left(\left(-\gamma_{r} \Delta \zeta-2\left\langle\nabla \gamma_{r}, \nabla \zeta\right\rangle+\ell_{r} \zeta \gamma_{r}\right) u_{r}+\zeta \gamma_{r} g\left(u_{r}\right)\right) d x=\int_{\Omega}\left(u_{k} \mathcal{L}_{\mu}^{*} \zeta+\zeta g\left(u_{k}\right)\right) d \gamma_{\mu}^{\Omega}
$$

we infer

$$
\begin{equation*}
\int_{\Omega}\left(u_{k} \mathcal{L}_{\mu}^{*} \zeta+\zeta g\left(u_{k}\right)\right) d \gamma_{\mu}^{\Omega}=c_{N, \mu, \Omega} k \zeta(0) \tag{2.6}
\end{equation*}
$$

with

$$
c_{N, \mu, \Omega}=\ell_{\mu}^{\Omega} \int_{\Omega} \gamma_{\mu}^{\Omega} \phi_{\mu} d x
$$

Since $x \mapsto k \phi_{\mu}^{\Omega}(x)$ satisfies (2.4) with $g=0$, it satisfies also (2.6), always with $g=0$. Combining this result with the uniqueness and the estimates given in [15, Proposition 2.1], we can compute the explicit value of $c_{N, \mu, \Omega}=c_{\mu}$.

### 2.3 Proof of Theorem B

We first assume that $(\nu, \lambda) \in \mathfrak{M}_{+}\left(\Omega ; \gamma_{\mu}^{\Omega}\right) \times \mathfrak{M}_{+}\left(\partial \Omega ; \beta_{\mu}^{\Omega}\right)$. Since $g$ satisfies (1.3) and $\mathcal{L}_{\mu}$ is uniformly elliptic in $\Omega_{r}$, it follows from [30, Section 3] that the problem

\end{align*}\right.

admits a unique weak solution $u_{\epsilon, r}$, where $\nu_{\epsilon}=\nu_{\epsilon} \chi_{B_{\epsilon}^{c}}, \lambda_{\epsilon}=\lambda_{\epsilon} \chi_{B_{\epsilon}^{c}}$ and $0<r<\epsilon / 2$.
By the comparison principle, for $0<\epsilon^{\prime}<\epsilon$ and $0<r^{\prime}<r$ there holds

\text { (i) } 0<u_{\epsilon, r}<u_{\epsilon^{\prime}, r^{\prime}} \quad \text { and } \quad \text { (ii) } \quad u_{\epsilon, r} \leq \mathbb{G}_{\mu}^{\Omega_{r}}\left[\nu_{\epsilon}\right]+\mathbb{K}_{\mu}^{\Omega_{r}}\left[\lambda_{\epsilon}\right] \leq \mathbb{G}_{\mu}^{\Omega}[\nu]+\mathbb{K}_{\mu}^{\Omega}[\lambda] \quad \text { in } \quad \Omega_{r}
$$

where $\mathbb{G}_{\mu}^{\Omega_{r}}$ and $\mathbb{K}_{\mu}^{\Omega_{r}}$ denote respectively the Green and the Poisson potentials of the operator $\mathcal{L}_{\mu}$ in $\Omega_{r}$. The mappings $r \mapsto u_{\epsilon, r}, r \mapsto \mathbb{G}_{\mu}^{\Omega_{r}}$ and $r \mapsto \mathbb{K}_{\mu}^{\Omega_{r}}$ are decreasing. We set $u_{\epsilon}=\lim _{r \rightarrow 0} u_{\epsilon, r}$, then

Leray-Hardy equations with absorption

If $\zeta \in \mathbb{X}_{\mu}(\Omega)$ vanishes in some neighbourhood of 0 , there holds for $r>0$ small enough,

Letting $r \rightarrow 0$, we obtain the identity

Because $u_{\epsilon}$ is $\mathcal{L}_{\mu}$-harmonic in $\Omega \cap B_{\epsilon}$ and vanishes on $\partial \Omega \cap B_{\epsilon}$, it satisfies $u_{\epsilon}(x) \leq c_{12} \gamma_{\mu}^{\Omega}(x)$ if $x \in \Omega \cap B_{\frac{\epsilon}{2}}$ for some $c_{12}>0$ depending also on $\epsilon$, and $\left(\gamma_{\mu}^{\Omega}(x)\right)^{-1} u_{\epsilon}(x) \rightarrow c_{13} \geq 0$ when $x \rightarrow 0$ by $[15$, Section 3$]$. Let $\zeta \in \mathbb{X}_{\mu}(\Omega)$ and

We set $\zeta_{n}=\ell_{n} \zeta$. Then

\int_{\Omega}\left(u_{\epsilon} \mathcal{L}_{\mu}^{*} \zeta_{n}+g\left(u_{\epsilon}\right) \zeta_{n}\right) d \gamma_{\mu}^{\Omega}=\int_{\Omega} \zeta_{n} d\left(\gamma_{\mu}^{\Omega} \nu_{\epsilon}\right)+\int_{\partial \Omega} \zeta_{n} d\left(\beta_{\mu}^{\Omega} \lambda_{\epsilon}\right) \tag{2.11}
\end{equation*}
$$

Firstly we observe that

\int_{\Omega} \zeta_{n} d\left(\gamma_{\mu}^{\Omega} \nu_{\epsilon}\right)+\int_{\partial \Omega} \zeta_{n} d\left(\beta_{\mu}^{\Omega} \lambda_{\epsilon}\right) \rightarrow \int_{\Omega} \zeta d\left(\gamma_{\mu}^{\Omega} \nu_{\epsilon}\right)+\int_{\partial \Omega} \zeta d\left(\beta_{\mu}^{\Omega} \lambda_{\epsilon}\right) \quad \text { as } n \rightarrow \infty
$$

Then, for $n$ large enough,

Because $G_{\mu}^{\Omega}$ and $K_{\mu}^{\Omega}$ are respectively equivalent to $G_{0}^{\Omega}$ and $K_{0}^{\Omega}$ in $\Omega_{\frac{r}{2}}$, the condition (1.13), jointly with (2.8), implies that $A_{n}$ is bounded independently of $n$ and converges to $\int_{\Omega_{\frac{r}{2}}} g\left(u_{\epsilon}\right) \zeta d \gamma_{\mu}^{\Omega}$. If $\mu \geq 1-N, \alpha_{+}$is nonnegative thus $g\left(u_{\epsilon}\right) \zeta_{n} \gamma_{\mu}^{\Omega}$ is bounded in $B_{\frac{r}{2}}$. If $\mu_{1} \leq \mu<1-N$, then $\alpha_{+}<0$ and we have

since $\frac{N}{\alpha_{+}} \leq-1-\frac{N+2}{N-2}<-1-\frac{N+1}{N-1}$ and (1.13) holds. Therefore

C_{n}=\int_{\Omega} \ell_{n} u_{\epsilon} \mathcal{L}_{\mu}^{*} \zeta d \gamma_{\mu}^{\Omega}, \quad D_{n}=\int_{\Omega} \zeta u_{\epsilon} \mathcal{L}_{\mu}^{*} \ell_{n} d \gamma_{\mu}^{\Omega}, \quad E_{n}=-2 \int_{\Omega} u_{\epsilon}\left\langle\nabla \zeta, \nabla \ell_{n}\right\rangle d \gamma_{\mu}^{\Omega}
$$

Since $u_{\epsilon}$ satisfies (2.8) it follows from [15, Theorem D] that it is bounded in $L^{1}\left(\Omega, \rho^{-1} d \gamma_{\mu}^{\Omega}\right)$ independently of $\epsilon$. Hence

$$

since $\ell_{n}^{\prime}\left(\frac{1}{n}\right)=\ell_{n}^{\prime}\left(\frac{2}{n}\right)=0$ and $\gamma_{\mu}^{\Omega}$ vanishes on $\partial \Omega$. Similarly

\lim _{n \rightarrow \infty} E_{n}=0
$$

These facts imply that

\begin{equation*}
\int_{\Omega}\left(u_{\epsilon} \mathcal{L}_{\mu}^{*} \zeta+g\left(u_{\epsilon}\right) \zeta\right) d \gamma_{\mu}^{\Omega}=\int_{\Omega} \zeta d\left(\gamma_{\mu}^{\Omega} \nu_{\epsilon}\right)+\int_{\partial \Omega} \zeta d\left(\beta_{\mu}^{\Omega} \lambda_{\epsilon}\right) \text { for any } \zeta \in \mathbb{X}_{\mu}(\Omega) \tag{2.12}
\end{equation*}
$$

Notice that from the above derivation, (2.12) holds true for $\zeta=\eta$, where $\eta$ is defined in (2.12).
Hence $u_{\epsilon}$ is the weak solution of

Because of uniqueness, $\epsilon \mapsto u_{\epsilon}$ is increasing and $u:=\lim _{\epsilon \rightarrow 0} u_{\epsilon}$ satisfies

0 \leq u \leq \mathbb{G}_{\mu}^{\Omega}[\nu]+\mathbb{K}_{\mu}^{\Omega}[\lambda] \quad \text { in } \Omega .
$$

If we take $\zeta=\eta$ defined by (2.1) we deduce from (2.12)

The right-hand side of the above identity converges to $\int_{\Omega} \eta d\left(\gamma_{\mu}^{\Omega} \nu\right)+\int_{\partial \Omega} \eta d\left(\beta_{\mu}^{\Omega} \lambda\right)$. Then by monotone convergence

This implies that $u_{\epsilon} \rightarrow u$ in $L^{1}\left(\Omega, \rho^{-1} d \gamma_{\mu}^{\Omega}\right)$ and $g\left(u_{\epsilon}\right) \rightarrow g(u)$ in $L^{1}\left(\Omega, d \gamma_{\mu}^{\Omega}\right)$ as $\epsilon \rightarrow 0^{+}$. Therefore, since any $\zeta \in \mathbb{X}_{\mu}(\Omega)$, satisfies $|\zeta| \leq c \eta$ for some $c>0$, we infer

\int_{\Omega}\left(u \mathcal{L}_{\mu}^{*} \zeta+g(u) \zeta\right) d \gamma_{\mu}^{\Omega}=\int_{\Omega} \zeta d\left(\gamma_{\mu}^{\Omega} \nu\right)+\int_{\partial \Omega} \zeta d\left(\beta_{\mu}^{\Omega} \lambda\right)
$$

which completes the proof when the two measures are nonnegative.
In the general case we use the Jordan decomposition $\nu=\nu^{+}-\nu^{-}, \lambda=\lambda^{+}-\lambda^{-}$where $\nu^{+}, \nu^{-}, \lambda^{+}$and $\lambda^{-}$are nonnegative. Let $\nu_{\epsilon}^{ \pm}$and $\lambda_{\epsilon}^{ \pm}$be $\nu^{ \pm} \chi_{\Omega_{\epsilon}}$ and $\lambda^{ \pm} \chi_{\partial \Omega \cap B_{\epsilon}^{c}}$ respectively. We denote by $u_{\epsilon, r}^{+}$the solution of (2.7) corresponding to the couple ( $\nu_{\epsilon}^{+}, \lambda_{\epsilon}^{+}$) and by $u_{\epsilon, r}^{-}$the solution of

\left\{\begin{aligned}
& \mathcal{L} u-g(u)=\nu_{\epsilon}^{-} \\
& \text {in } \Omega_{r} \\
& u=\lambda_{\epsilon}^{-} \text {in } \Gamma_{1, r} \\
& u=0 \\
& \text { in } \Gamma_{2, r}
\end{aligned}\right.
$$

Then $-u_{\epsilon, r}^{-} \leq \min \left\{0, u_{\epsilon, r}\right\} \leq \max \left\{0, u_{\epsilon, r}\right\} \leq u_{\epsilon, r}^{+}$. The mapping $r \mapsto u_{\epsilon, r}^{+}\left(\right.$resp. $\left.r \mapsto u_{\epsilon, r}^{-}\right)$is monotone increasing and we set $u_{\epsilon}^{+}=\lim _{r \rightarrow 0} u_{\epsilon, r}^{+}$(resp. $u_{\epsilon}^{-}=\lim _{r \rightarrow 0} u_{\epsilon, r}^{-}$). The mapping $r \mapsto u_{\epsilon, r}$ has no reason to be monotone, but by standard regularity theory there exists $\left\{r_{j}\right\}$ converging to 0 and $u_{\epsilon} \in L_{l o c}^{q}\left(1<q<\frac{N}{N-1}\right)$ such that $u_{\epsilon, r_{j}} \rightarrow u_{\epsilon}$ in $L_{l o c}^{q}(\Omega)$ and a.e. in $\Omega$. Hence $u_{\epsilon}$ satisfies (2.9). Since (2.11) holds we derive that $u_{\epsilon}$ satisfies (2.13). We end the proof as in the first case, using dominated convergence theorem.

### 2.4 Proof of Theorem C

We first assume that $\nu, \lambda$ and $k$ are nonnegative. For $0<r<\epsilon / 4$ we consider the problem

The solution is denoted by $u_{\epsilon, k, r}$ and we recall that $u_{\epsilon, r}$ is the solution of (2.7). There holds

\max \left\{u_{\epsilon, r}, u_{k \delta_{0}}\right\} \leq u_{\epsilon, k, r} \leq u_{\epsilon}+k \mathbb{K}_{\mu}^{\Omega}\left[\delta_{0}\right] \quad \text { in } \Omega_{r} . \tag{2.15}
\end{equation*}

Furthermore $u_{\epsilon, k, r} \leq u_{\epsilon, k, r^{\prime}}$ if $0<r^{\prime}<r$. Since $u_{\epsilon}$ and $k \mathbb{K}_{\mu}^{\Omega}\left[\delta_{0}\right]$ belong to $L^{1}\left(\Omega, \rho^{-1} d \gamma_{\mu}^{\Omega}\right)$ it implies that $u_{\epsilon, k, r}$ converges in $L^{1}\left(\Omega, \rho^{-1} d \gamma_{\mu}^{\Omega}\right)$ and almost everywhere to $u_{\epsilon, k}$ when $r \rightarrow 0$. Since $\gamma_{\mu}^{\Omega}$ is a supersolution for the equation $\mathcal{L}_{\mu} u+g(u)=0$ in $\Omega_{r}$, for any $0<\epsilon_{0}<\epsilon / 4$ there exists $c_{14}>0$ depending on $\epsilon_{0}$ such that for $0<r \leq \epsilon_{0} / 4$,

u_{\epsilon, r}(x) \leq c_{14} \gamma_{\mu}^{\Omega}(x) \quad \text { for all } x \in B_{\epsilon_{0}} \cap \Omega_{r}
$$

For any $\sigma>0$ there exists $r_{\sigma}>0$ such that for any $r<r_{\sigma}, u_{\epsilon, r} \leq \sigma \mathbb{K}_{\mu}^{\Omega}\left[\delta_{0}\right]$ in $B_{r_{\sigma}} \cap \Omega_{r}$. Therefore $u_{\epsilon}+k \mathbb{K}_{\mu}^{\Omega}\left[\delta_{0}\right] \leq(k+\sigma) \mathbb{K}_{\mu}^{\Omega}\left[\delta_{0}\right]$ in $B_{r_{\sigma}} \cap \Omega$. This implies

g\left(u_{\epsilon, k, r}\right) \leq g\left((k+\sigma) \mathbb{K}_{\mu}^{\Omega}\left[\delta_{0}\right]\right) \quad \text { in } \Omega_{r} \cap B_{r_{\sigma}} \tag{2.16}

Then we obtain, with $R=\operatorname{diam} \Omega$ and some $c>0$,

\int_{\Omega} g\left((k+\sigma) \mathbb{K}_{\mu}^{\Omega}\left[\delta_{0}\right]\right) d \gamma_{\mu}^{\Omega} & \leq \int_{0}^{R} g\left(c|x|^{\alpha_{-}}\right)|x|^{\alpha_{+}} d x \\
& =\frac{1}{\left|\alpha_{-}\right|} \int_{R^{\frac{1}{\alpha_{-}}}}^{\infty} g(c t) t^{\frac{N+\alpha_{+}-\alpha_{-}}{\alpha_{-}}} d t \leq \frac{1}{\left|\alpha_{-}\right|} \int_{R^{\frac{1}{\alpha_{-}}}}^{\infty} g(c t) t^{-1-p_{\mu}^{*}}<\infty .
\end{aligned}
$$

This implies in particular that

In the set $\Omega_{r_{\sigma}}$, we have $k \mathbb{K}_{\mu}^{\Omega}\left[\delta_{0}\right] \leq c r_{\sigma}^{\alpha_{-}}$for some $c>0$. By the local $\Delta_{2}$-condition, we deduce

Because $g\left(u_{\epsilon}\right)$ is bounded in $L^{1}\left(\Omega_{r}, d \gamma_{\mu}^{\Omega}\right)$ independently of $r$ by Theorem B, we infer from (2.16), (2.17) and (2.18) that $g\left(u_{\epsilon, k, r}\right)$ is bounded in $L^{1}\left(\Omega_{r}, d \gamma_{\mu}^{\Omega}\right)$ independently of $r$. Let $\zeta \in \mathbb{X}_{\mu}(\Omega)$ vanishing near 0 , then for $r$ small enough,

Using the mononoticity of $r \mapsto u_{\epsilon, k, r}$ and the dominated convergence theorem we get

As we notice it, the singular measure $k \delta_{0}$ cannot appear in this formulation. If $\zeta \in \mathbb{X}_{\mu}(\Omega)$ we set $\zeta_{n}=\ell_{n} \zeta$ where $\ell_{n}$ is defined in (2.10). Then

$$

where

$$
A_{n}=\zeta \Delta \ell_{n}+2\left\langle\nabla \ell_{n}, \nabla \zeta\right\rangle+2 \alpha_{+} \zeta\left\langle\nabla \ell_{n}, \frac{x}{|x|^{2}}\right\rangle
$$

Clearly we have that

$$
\lim _{n \rightarrow \infty} \int_{\Omega}\left(u_{\epsilon, k} \mathcal{L}_{\mu}^{*} \zeta+g\left(u_{\epsilon, k}\right) \zeta\right) \ell_{n} d \gamma_{\mu}^{\Omega}=\int_{\Omega}\left(u_{\epsilon, k} \mathcal{L}_{\mu}^{*} \zeta+g\left(u_{\epsilon, k}\right) \zeta\right) d \gamma_{\mu}^{\Omega}
$$

and

$$
\lim _{n \rightarrow \infty}\left(\int_{\Omega} \zeta \ell_{n} d\left(\gamma_{\mu}^{\Omega} \nu_{\epsilon}\right)+\int_{\partial \Omega} \zeta \ell_{n} d\left(\beta_{\mu}^{\Omega} \lambda_{\epsilon}\right)\right)=\int_{\Omega} \zeta d\left(\gamma_{\mu}^{\Omega} \nu_{\epsilon}\right)+\int_{\partial \Omega} \zeta d\left(\beta_{\mu}^{\Omega} \lambda_{\epsilon}\right) .
$$

Next
$A_{n}=\left[\frac{n^{2} \pi^{2}}{2} \cos \left(n \pi\left(|x|-\frac{1}{n}\right)\right)+\frac{n \pi\left(N-1+2 \alpha_{+}\right)}{2|x|} \sin \left(n \pi\left(|x|-\frac{1}{n}\right)\right)\right](\zeta(0)+o(1))+O(n)$.

Leray-Hardy equations with absorption

Using (2.15) with $\delta=0$ and the fact that $u_{\epsilon}=o\left(\mathbb{K}_{\mu}^{\Omega}\left[\delta_{0}\right]\right)$ near 0 , we obtain after a technical but straightforward computation

\lim _{n \rightarrow \infty} \int_{\Omega \cap\left(B_{\frac{2}{n}} \backslash B_{\frac{1}{n}}\right)} A_{n} u_{\epsilon, k} d \gamma_{\mu}^{\Omega}=k c_{\mu} \zeta(0) \tag{2.19}

By the normalization chosen it follows that $u_{\epsilon, k}$ satisfies

\int_{\Omega}\left(u_{\epsilon, k} \mathcal{L}_{\mu}^{*} \zeta+g\left(u_{\epsilon, k}\right) \zeta\right) d \gamma_{\mu}^{\Omega}=\int_{\Omega} \zeta d\left(\gamma_{\mu}^{\Omega} \nu_{\epsilon}\right)+\int_{\partial \Omega} \zeta d\left(\beta_{\mu}^{\Omega} \lambda_{\epsilon}\right)+k c_{\mu} \zeta(0) \tag{2.20}
\end{equation*}
$$

Hence $u_{\epsilon, k}$ is the weak solution of

\left\{\begin{aligned}
\mathcal{L}_{\mu} u+g(u) & =\nu_{\epsilon} & & \text { in } \Omega \\
u & =\lambda_{\epsilon}+k \delta_{0} & & \text { on } \partial \Omega .
\end{aligned}\right.
$$

The end of the proof in the nonnegative case is standard: we observe that the mapping $\epsilon \mapsto u_{\epsilon, k}$ is nondecreasing. We denote by $u_{k}$ its limit when $\epsilon \rightarrow 0$. If $\zeta \in \mathbb{X}_{\mu}(\Omega)$, the right-hand side of (2.20) converges to

\end{equation*}

and when $\epsilon \rightarrow 0$,

\int_{\Omega}\left(\frac{u_{k}}{\rho}+g\left(u_{k}\right) \eta\right) d \gamma_{\mu}^{\Omega} \leq \int_{\Omega} \eta d\left(\gamma_{\mu}^{\Omega} \nu_{\epsilon}\right)+\int_{\partial \Omega} \eta d\left(\beta_{\mu}^{\Omega} \lambda_{\epsilon}\right)+k c_{\mu} \sup _{\Omega} \eta . \tag{2.22}
\end{equation*}
$$

Thus, by the monotone convergence theorem we have that $u_{\epsilon, k} \rightarrow u_{k}$ in $\left.L^{1}\left(\Omega, \rho^{-1}\right) d \gamma_{\mu}^{\Omega}\right)$ and $g\left(u_{\epsilon, k}\right) \rightarrow g\left(u_{k}\right)$ in $L^{1}\left(\Omega, d \gamma_{\mu}^{\Omega}\right)$ as $\epsilon \rightarrow 0$. Therefore, by the dominated convergence theorem we conclude that for any $\zeta \in \mathbb{X}_{\mu}(\Omega)$ there holds

\int_{\Omega}\left(u_{k} \mathcal{L}_{\mu}^{*} \zeta+g\left(u_{k}\right) \zeta\right) d \gamma_{\mu}^{\Omega}=\int_{\Omega} \zeta d\left(\gamma_{\mu}^{\Omega} \nu\right)+\int_{\partial \Omega} \zeta d\left(\beta_{\mu}^{\Omega} \lambda\right)+k c_{\mu} \zeta(0)

Hence $u_{k}$ is the weak solution of (1.9). When $\nu$ and $\lambda$ are signed measures and $k$ is a real number, we use the Jordan decomposition of $\nu=\nu^{+}-\nu^{-}$and $\lambda=\lambda^{+}-\lambda^{-}$and assume for example that $k$ is nonnegative and we construct the solutions $u_{\epsilon, k, r}^{+}$of

\mathcal{L}_{\mu} u+g(u)=\nu_{\epsilon}^{+} & \text {in } \Omega_{r} \\
u=\lambda_{\epsilon}^{+} & \text {on } \Gamma_{1, r} \\
u=u_{k \delta_{0}} & \text { on } \Gamma_{2, r}
\end{aligned}\right.
$$

and $u_{\epsilon, \delta}^{-}$of

$$
\left\{\begin{aligned}
\mathcal{L}_{\mu} u-g(u) & =\nu_{\epsilon}^{-} & & \text {in } \Omega_{r} \\
u & =\lambda_{\epsilon}^{-} & & \text {on } \Gamma_{1, r} \\
u & =0 & & \text { on } \Gamma_{2, r} .
\end{aligned}\right.
$$

Then the function $u_{\epsilon, k, r}$ of (2.14) satisfies $-u_{\epsilon, r}^{-} \leq \min \left\{0, u_{\epsilon, k, r}\right\} \leq \max \left\{0, u_{\epsilon, k, r}\right\} \leq u_{\epsilon, k, r}^{+}$. Since $u_{\epsilon, k, r}^{+}$is monotone with respect to $r$ with limit $u_{\epsilon, k}^{+}$, we obtain, as in the proof of Theorem B, the existence of a limit $u_{\epsilon, k}$ of a sequence $u_{\epsilon, k, r_{j}}$, a.e. and in $L_{l o c}^{q}(\Omega)$, and $u_{\epsilon, k}$ satisfies (2.17) for any $\zeta \in \mathbb{X}_{\mu}(\Omega)$ which vanishes near 0 .

Since $u_{\epsilon, r}^{-}$is $\mathcal{L}_{\mu}$ Harmonic in $\Omega \cap B_{\epsilon}, u_{\epsilon, r}^{-}=0$ on $\left(\partial \Omega \cap B_{\epsilon}\right) \backslash\{0\}$ and charges no Dirac mass at origin in the weak sense, then

-u_{\epsilon, r}^{-} \geq-c_{15} \gamma_{\mu}^{\Omega} \quad \text { on } \quad \Omega \cap \partial B_{\frac{\epsilon}{2}}
$$

for some $c_{15}>0$ dependent of $\epsilon$. Thus, there exists $c_{16}>0$ such that

\end{equation*}
$$

where $u_{\epsilon, r}^{+}$and $u_{\epsilon}^{+}$are the solutions of (2.13) with $r>0$ and $r=0$ respectively with $\nu_{\epsilon}$ and $\lambda_{\epsilon}$ replaced by $\nu_{\epsilon}^{+}$and $\lambda_{\epsilon}^{+}$. Thanks to estimate (2.23) we infer as in the case where $\nu_{\epsilon}$ and $\lambda_{\epsilon}$ are nonnegative that $u_{\epsilon, k}$ satisfies (2.20). We also have

-u_{\epsilon}^{-} \leq \min \left\{0, u_{\epsilon, k}\right\} \leq \max \left\{0, u_{\epsilon, k}\right\} \leq u_{\epsilon, k}^{+}
$$

and

g\left(-u_{\epsilon}^{-}\right) \leq \min \left\{0, g\left(u_{\epsilon, k}\right)\right\} \leq \max \left\{0, g\left(u_{\epsilon, k}\right)\right\} \leq g\left(u_{\epsilon, k}^{+}\right) .
$$

Then there exist a function $u_{k} \in L_{l o c}^{q}(\Omega)\left(1<q<\frac{N}{N-1}\right)$ and a sequence $\left\{\epsilon_{j}\right\}$ converging to 0 such that $u_{\epsilon_{j}, k} \rightarrow u_{k} L_{l o c}^{q}(\Omega)$ and a.e. in $\Omega$. Since $g\left(u_{\epsilon, k}^{+}\right)$and $g\left(-u_{\epsilon}^{-}\right)$converge in $L^{1}\left(\Omega, d \gamma_{\mu}^{\Omega}\right)$ and $u_{\epsilon, k}^{+}$and $u_{\epsilon}^{-}$in $L^{1}\left(\Omega, \rho^{-1} d \gamma_{\mu}^{\Omega}\right)$, it follows that $g\left(u_{\epsilon, k}\right)$ and $u_{\epsilon, k}$ endow the same properties. This is sufficient to see that (2.20) implies (2.22), which ends the proof.

## 3 The supercritical case

### 3.1 Reduced measures

We present here the notion of reduced measure which has been introduced by Brezis, Marcus and Ponce [7]. This notion turned out to be a very useful tool for analyzing supercritical problems. Since many results are simple adaptations of similar ones used in [14], we will state most of them without detailled proofs. We assume that $g$ is a continuous nondecreasing function vanishing at 0 and for $\ell>0$, we set

$$
g_{\ell}(r)= \begin{cases}\min \{g(r), g(\ell)\} & \text { if } r \geq 0 \\ \max \{g(-\ell), g(r)\} & \text { if } r<0\end{cases}
$$

If $k \in \mathbb{R}_{+}$, and $(\nu, \lambda) \in \mathfrak{M}_{+}\left(\Omega ; \gamma_{\mu}^{\Omega}\right) \times \mathfrak{M}_{+}\left(\partial \Omega ; \beta_{\mu}^{\Omega}\right)$ we denote by $u_{\ell}$ the solution of

$$
\left\{\begin{align*}
\mathcal{L}_{\mu} u+g_{\ell}(u) & =\nu & & \text { in } \Omega  \tag{3.1}\\
u & =\lambda+k \delta_{0} & & \text { on } \partial \Omega
\end{align*}\right.
$$

Existence of $u_{\ell}$ comes from Theorem $C$.
Proposition 3.1 Let $k \in \mathbb{R}_{+}$, and $(\nu, \lambda) \in \mathfrak{M}_{+}\left(\Omega ; \gamma_{\mu}^{\Omega}\right) \times \mathfrak{M}_{+}\left(\partial \Omega ; \beta_{\mu}^{\Omega}\right)$, then $\ell \mapsto u_{\ell}$ is monotone decreasing and converges to some function $u^{*}$ when $\ell \rightarrow \infty$ and there exists a real number $k^{*} \in[0, k]$ and two measures $\left(\nu^{*}, \lambda^{*}\right) \in \mathfrak{M}_{+}\left(\Omega ; \gamma_{\mu}^{\Omega}\right) \times \mathfrak{M}_{+}\left(\partial \Omega ; \beta_{\mu}^{\Omega}\right)$ satisfying $0 \leq \nu^{*} \leq \nu$ and $0 \leq \lambda^{*} \leq \lambda$ such that $u^{*}$ is a weak solution of

$$
\left\{\begin{align*}
\mathcal{L}_{\mu} u+g_{\ell}(u) & =\nu^{*} & & \text { in } \Omega  \tag{3.2}\\
u & =\lambda^{*}+k^{*} \delta_{0} & & \text { on } \partial \Omega
\end{align*}\right.
$$

Furthermore the correspondence $(\nu, \lambda, k) \mapsto\left(\nu^{*}, \lambda^{*}, k^{*}\right)$ is nondecreasing.
Proof. The monotonicity is clear. By Fatou's lemma $u^{*}:=\lim _{\ell \rightarrow \infty} u_{\ell}$ satisfies

\int_{\Omega}\left(u^{*} \mathcal{L}_{\mu}^{*} \zeta+g\left(u^{*}\right) \zeta\right) d \gamma_{\mu}^{\Omega} \leq \int_{\Omega} \zeta d\left(\gamma_{\mu}^{\Omega} \nu\right)+\int_{\partial \Omega} \zeta d\left(\beta_{\mu}^{\Omega} \lambda\right)+k c_{\mu} \zeta(0) \text { for all } \zeta \in \mathbb{X}_{\mu}(\Omega), \zeta \geq 0
$$

The function $u^{*}$ is the largest subsolution of problem (1.9). Since the mapping

$$
\zeta \mapsto \int_{\Omega}\left(u^{*} \mathcal{L}_{\mu}^{*} \zeta+g\left(u^{*}\right) \zeta\right) d \gamma_{\mu}^{\Omega} \quad \text { for all } \zeta \in C_{c}^{\infty}(\Omega)
$$

is a positive distribution, it is a positive measure denoted by $\nu^{*}$. It is smaller than $\nu$, hence it belongs to $\mathfrak{M}_{+}\left(\Omega ; \gamma_{\mu}^{\Omega}\right)$. Similarly the function $u^{*}$ admits a boundary trace $\lambda^{*}$ on $\partial \Omega \backslash\{0\}$ which is a positive Radon measure smaller than $\lambda$. Hence $\lambda^{*} \in \mathfrak{M}_{+}\left(\partial \Omega^{*} ; \beta_{\mu}^{\Omega}\right)$. By using (1.1), it is extended as a measure on $\partial \Omega$, still denoted by $\lambda^{*}$. If $\zeta \in \mathbb{X}_{\mu}(\Omega)$ vanishes near 0 , there holds

$$
\int_{\Omega}\left(u^{*} \mathcal{L}_{\mu}^{*} \zeta+g\left(u^{*}\right) \zeta\right) d \gamma_{\mu}^{\Omega}=\int_{\Omega} \zeta d\left(\gamma_{\mu}^{\Omega} \nu^{*}\right)+\int_{\partial \Omega} \zeta d\left(\beta_{\mu}^{\Omega} \lambda^{*}\right)
$$

Let $v$ be the solution of

$$
\left\{\begin{aligned}
\mathcal{L}_{\mu} v+g(v) & =\nu^{*} & & \text { in } \Omega \\
v & =\lambda^{*} & & \text { on } \partial \Omega
\end{aligned}\right.
$$

Existence is standard since $u^{*}$ exists. Furthermore $v$ is a subsolution of problem (1.9) hence it is smaller than $u^{*}$. Therefore $w=u^{*}-v$ is nonnegative and it satisfies

$$
\left\{\begin{aligned}
& \mathcal{L}_{\mu} w+g\left(u^{*}\right)-g(v)=0 \\
& w=0 \text { in } \Omega \\
& \text { on } \partial \Omega \backslash\{0\}
\end{aligned}\right.
$$

Let $\psi \in H_{\mu}$ be the solution of

$$
\left\{\begin{align*}
\mathcal{L}_{\mu} \psi & =g\left(u^{*}\right)-g(v) & & \text { in } \Omega  \tag{3.3}\\
\psi & =0 & & \text { on } \partial \Omega
\end{align*}\right.
$$

then $w+\psi$ is a nonnegative $\mathcal{L}_{\mu}$-harmonic function vanishing on $\partial \Omega \backslash\{0\}$. By [15, Theorem A] there exists $k^{*} \geq 0$ such that

and

It follows from (3.3) that this implies

\int_{\Omega}\left(w \mathcal{L}_{\mu}^{*} \zeta+\zeta\left(g\left(u^{*}\right)-g(v)\right)\right) d \gamma_{\mu}^{\Omega}=k^{*} c_{\mu} \zeta(0) \quad \text { for all } \zeta \in \mathbb{X}_{\mu}(\Omega)
$$

Since $u^{*}=w+v$ and

$$
\int_{\Omega}\left(v \mathcal{L}_{\mu}^{*} \zeta+\zeta g(v)\right) d \gamma_{\mu}^{\Omega}=\int_{\Omega} \zeta d\left(\gamma_{\mu}^{\Omega} \nu^{*}\right)+\int_{\partial \Omega} \zeta d\left(\beta_{\mu}^{\Omega} \lambda^{*}\right) \quad \text { for all } \zeta \in \mathbb{X}_{\mu}(\Omega)
$$

we infer

$$
\int_{\Omega}\left(u^{*} \mathcal{L}_{\mu}^{*} \zeta+g\left(u^{*}\right) \zeta\right) d \gamma_{\mu}^{\Omega}=\int_{\Omega} \zeta d\left(\gamma_{\mu}^{\Omega} \nu^{*}\right)+\int_{\partial \Omega} \zeta d\left(\beta_{\mu}^{\Omega} \lambda^{*}\right)+k^{*} c_{\mu} \zeta(0) \quad \text { for all } \zeta \in \mathbb{X}_{\mu}(\Omega)
$$

The last assertion is obvious.
Definition 3.1 The triplet of measures $\left(\nu^{*}, \lambda^{*}, k^{*} \delta_{0}\right)$ is called the reduced triplet associated to $\left(\nu, \lambda, k \delta_{0}\right)$. If $\left(\nu^{*}, \lambda^{*}, k^{*} \delta_{0}\right)=\left(\nu, \lambda, k \delta_{0}\right)$ the triplet is called $g$-good.

Lemma 3.2 Let $(\nu, \lambda, k)$ and $\left(\nu^{\prime}, \lambda^{\prime}, k^{\prime}\right)$ in $\mathfrak{M}_{+}\left(\Omega ; \gamma_{\mu}^{\Omega}\right) \times \mathfrak{M}_{+}\left(\partial \Omega ; \beta_{\mu}^{\Omega}\right) \times \mathbb{R}_{+}$. If $\nu^{\prime} \leq \lambda, \lambda^{\prime} \leq \lambda$ and $k^{\prime} \leq k$ and $(\nu, \lambda, k)=\left(\nu^{*}, \lambda^{*}, k^{*}\right)$, then $\left(\nu^{\prime}, \lambda^{\prime}, k^{\prime}\right)=\left(\nu^{\prime *}, \lambda^{\prime *}, k^{\prime *}\right)$.

Proof. For $\ell>0$, let $u_{\ell}=u_{\ell, \nu, \lambda, k}$ be the solution of (3.1). We define similarly $u_{\ell}^{\prime}=u_{\ell, \nu^{\prime}, \lambda^{\prime}, k^{\prime}}^{\prime}$. Then $u_{\ell}^{\prime} \leq u_{\ell}$ for any $\ell>0$. Then $u_{\ell} \downarrow u^{*}$ and $u_{\ell}^{\prime} \downarrow u^{\prime *}$ as $\ell \rightarrow \infty$ where $u^{*} u^{\prime *}$ are the solution of (1.9) with sources $\left(\nu^{*}, \lambda^{*}, k^{*}\right),\left(\nu^{\prime *}, \lambda^{\prime *}, k^{\prime *}\right)$ respectively, and these convergences hold in $L^{1}\left(\Omega, \rho^{-1} d \gamma_{\mu}^{\Omega}\right)$ by the previous proposition. Since $(\nu, \lambda, k)=\left(\nu^{*}, \lambda^{*}, k^{*}\right)$, then

$$
\mathcal{L}_{\mu}\left(u_{\ell}-u^{*}\right)+g_{\ell}\left(u_{\ell}\right)-g_{\ell}\left(u^{*}\right)=g\left(u^{*}\right)-g_{\ell}\left(u^{*}\right)
$$

and we deduce from Proposition 2.2 that

$$
\int_{\Omega}\left(u_{\ell}-u^{*}\right) \rho^{-1} d \gamma_{\mu}^{\Omega}+\int_{\Omega}\left|g_{\ell}\left(u_{\ell}\right)-g_{\ell}\left(u^{*}\right)\right| \eta d \gamma_{\mu}^{\Omega} \leq \int_{\Omega}\left(g(u)-g_{\ell}(u)\right) \eta d \gamma_{\mu}^{\Omega}
$$

Because $\left|g_{\ell}\left(u_{\ell}\right)-g_{\ell}\left(u^{*}\right)\right| \leq\left|g_{\ell}\left(u_{\ell}\right)-g\left(u^{*}\right)\right|+g\left(u^{*}\right)-g_{\ell}\left(u^{*}\right)$ we get

$$
\int_{\Omega}\left|g_{\ell}\left(u_{\ell}\right)-g_{\ell}\left(u^{*}\right)\right| \eta d \gamma_{\mu}^{\Omega} \leq 2 \int_{\Omega}\left(g\left(u^{*}\right)-g_{\ell}\left(u^{*}\right)\right) \eta d \gamma_{\mu}^{\Omega} \rightarrow 0 \quad \text { as } \ell \rightarrow \infty
$$

Since $g_{\ell}\left(u_{\ell}^{\prime}\right) \leq g_{\ell}\left(u_{\ell}\right)$, it follows by Vitali's theorem that $g_{\ell}\left(u_{\ell}^{\prime}\right)$ converges to $g\left(u^{* *}\right)$ in $L^{1}\left(\Omega, d \gamma_{\mu}^{\Omega}\right)$. Letting $\ell \rightarrow \infty$ in the weak formulation of the equation satisfied by $u_{\ell}^{\prime}$ we conclude that $u^{*}$ verifies

$$
\int_{\Omega}\left(u^{\prime *} \mathcal{L}_{\mu}^{*} \zeta+g\left(u^{\prime *}\right) \zeta\right) d \gamma_{\mu}^{\Omega}=\int_{\Omega} \zeta d\left(\gamma_{\mu}^{\Omega} \nu^{\prime}\right)+\int_{\partial \Omega} \zeta d\left(\beta_{\mu}^{\Omega} \lambda^{\prime}\right)+k^{\prime} c_{\mu} \zeta(0) \quad \text { for all } \zeta \in \mathbb{X}_{\mu}(\Omega)
$$

This implies the claim.
As a consequence we have
Proposition 3.3 The triplet $\left(\nu^{*}, \lambda^{*}, k^{*} \delta_{0}\right)$ is the largest $g$-good triplet smaller than $\left(\nu, \lambda, k \delta_{0}\right)$.
Lemma 3.4 Let $(\nu, \lambda, k)$ in $\mathfrak{M}_{+}\left(\Omega ; \gamma_{\mu}^{\Omega}\right) \times \mathfrak{M}_{+}\left(\partial \Omega ; \beta_{\mu}^{\Omega}\right) \times \mathbb{R}_{+}$. The two next statements are equivalent:
(i) The triplet $(\nu, \lambda, k)$ is g-good.
(ii) For any $\epsilon>0,0 \leq k^{\prime} \leq k,\left(\nu_{\epsilon}, \lambda_{\epsilon}, k^{\prime}\right)$ is $g$-good.

Proof. We recall that $\nu_{\epsilon}=\chi_{\Omega_{\epsilon}} \nu$ and $\lambda_{\epsilon}=\chi_{\partial \Omega \cap B_{\epsilon}^{c}} \lambda$.
(i) implies (ii) by Lemma 3.2.

Conversely, if $\left(\nu_{\epsilon}, \lambda_{\epsilon}, k^{\prime}\right)$ is $g$-good for any $\epsilon>0$ and $k^{\prime} \in[0, k]$, let $u_{\epsilon, k^{\prime}}$ be the solution of

$$
\left\{\begin{align*}
\mathcal{L}_{\mu} u+g(u) & =\nu_{\epsilon} & & \text { in } \Omega  \tag{3.4}\\
u & =\lambda_{\epsilon}+k^{\prime} \delta_{0} & & \text { on } \partial \Omega .
\end{align*}\right.
$$

Then map $\left(\epsilon, k^{\prime}\right) \mapsto u_{\epsilon, k^{\prime}}$ is nonincreasing in $\epsilon$ and nondecreasing in $k^{\prime}$. There holds

$$
\int_{\Omega}\left(u_{\epsilon, k^{\prime}} \mathcal{L}_{\mu}^{*} \zeta+g\left(u_{\epsilon, k^{\prime}}\right) \zeta\right) d \gamma_{\mu}^{\Omega}=\int_{\Omega} \zeta d\left(\gamma_{\mu}^{\Omega} \nu_{\epsilon}\right)+\int_{\partial \Omega} \zeta d\left(\beta_{\mu}^{\Omega} \lambda_{\epsilon}\right)+k^{\prime} c_{\mu} \zeta(0) \quad \text { for all } \zeta \in \mathbb{X}_{\mu}(\Omega)
$$

From (2.22) we have that

$$
\int_{\Omega}\left(u_{\epsilon, k^{\prime}} \rho^{-1}+g\left(u_{\epsilon, k^{\prime}}\right) \eta\right) d \gamma_{\mu}^{\Omega} \leq \int_{\Omega} \eta d\left(\gamma_{\mu}^{\Omega} \nu_{\epsilon}\right)+\int_{\partial \Omega} \eta d\left(\beta_{\mu}^{\Omega} \lambda_{\epsilon}\right)+k^{\prime} c_{\mu} \sup _{\Omega} \eta .
$$

Put $u=\lim _{\left(\epsilon, k^{\prime}\right) \rightarrow(0, k)} u_{\epsilon, k^{\prime}}$. By the monotone convergence theorem,

$$
\int_{\Omega}\left(u \rho^{-1}+g(u) \eta\right) d \gamma_{\mu}^{\Omega}=\int_{\Omega} \eta d\left(\gamma_{\mu}^{\Omega} \nu\right)+\int_{\partial \Omega} \eta d\left(\beta_{\mu}^{\Omega} \lambda\right)+k c_{\mu} \eta(0) .
$$

Therefore $u_{\epsilon, k^{\prime}} \rightarrow u$ in $L^{1}\left(\Omega, \rho^{-1} d \gamma_{\mu}^{\Omega}\right)$ and $g\left(u_{\epsilon, k^{\prime}}\right) \rightarrow g(u)$ in $L^{1}\left(\Omega, d \gamma_{\mu}^{\Omega}\right)$ as $\epsilon \rightarrow 0^{+}$. Going to the limit in (3.4) yields the claim.

Remark. The previous result is a particular case of the following result: If $\left\{\left(\nu_{n}, \lambda_{n}, k_{n}\right)\right\} \subset$ $\mathfrak{M}_{+}\left(\Omega ; \gamma_{\mu}^{\Omega}\right) \times \mathfrak{M}_{+}\left(\partial \Omega ; \beta_{\mu}^{\Omega}\right) \times \mathbb{R}_{+}$is an increasing sequence of $g$-good triplet converging to $(\nu, \lambda, k) \in$ $\mathfrak{M}_{+}\left(\Omega ; \gamma_{\mu}^{\Omega}\right) \times \mathfrak{M}_{+}\left(\partial \Omega ; \beta_{\mu}^{\Omega}\right) \times \mathbb{R}_{+}$, then $(\nu, \lambda, k)$ is $g$-good.

### 3.2 Capacitary framework, good measures and removable sets

In the sequel, we set $g(r)=g_{p}(r):=|r|^{p-1} r$ with $p>1$. The following a priori estimate of Keller-Osserman type is standard and easy to prove (see e.g. [18], [23]).

Lemma 3.5 Let $p>1, \mu \in \mathbb{R}, G \subset \mathbb{R}^{N}$ be a domain such that $0 \notin G$. There exist constants $A>0, B \geq 0$ depending on $N, p, \mu$ such that any compact subset $F$ of $\partial G$, possibly empty, and any solution $v$ of

$$
\left\{\begin{aligned}
\mathcal{L}_{\mu} v+g_{p}(v)=0 & \text { in } G \\
v=0 & \text { on } \partial G \backslash(\{0\} \cup F),
\end{aligned}\right.
$$

there holds

$$
|v(x)| \leq A \max \left\{|x|^{-\frac{2}{p-1}},\left(\operatorname{dist}(x, F)^{-\frac{2}{p-1}}\right)\right\}+B \quad \text { for all } x \in G
$$

Proof of Theorem D. Since $g_{p}$ satisfies the uniform $\Delta_{2}$-condition, i.e. $K(|r|)$ is constant in inequality (1.14), if $(\nu, 0,0),(0, \lambda, 0)$ and $\left(0,0, k \delta_{0}\right)$ are $g_{p}$-good, then $\left(\nu, \lambda, k \delta_{0}\right)$ is also $g_{p}$-good, and conversely. Assume now that $(\nu, \lambda, 0)$ is $g_{p}$-good, or, equivalently, for any $\epsilon>0,\left(\nu_{\epsilon}, \lambda_{\epsilon}, 0\right)$, is $g_{p}$-good. Let $u_{\epsilon}$ be the solution of (3.4) with $k^{\prime}=0$. Let $\tilde{\Omega}_{\epsilon}$ be a smooth domain such that $\Omega_{\epsilon} \subset \tilde{\Omega}_{\epsilon} \subset \Omega_{\frac{\epsilon}{2}}$. Then $\tilde{u}_{\epsilon}:=u_{\epsilon} L_{\Omega_{\epsilon}}$ satisfies

$$
\left\{\begin{aligned}
\mathcal{L}_{\mu} \tilde{u}_{\epsilon}+g_{p}\left(\tilde{u}_{\epsilon}\right)=\nu_{\epsilon} & \text { in } \tilde{\Omega}_{\epsilon} \\
\tilde{u}_{\epsilon}=\lambda_{\epsilon} & \text { on } \partial \Omega \cap \partial \tilde{\Omega}_{\epsilon} \\
\tilde{u}_{\epsilon}=u_{\epsilon} & \text { on } \partial \tilde{\Omega}_{\epsilon} \cap \Omega
\end{aligned}\right.
$$

Furthermore $\frac{\mu}{|x|^{2}}$ is bounded in $\tilde{\Omega}_{\epsilon}$. Hence the Green operator $\mathbb{G}^{-\Delta+\mu|\cdot|^{-2}}$ relative to $\tilde{\Omega}_{\epsilon}$ is equivalent of the one relative to $-\Delta$ and $\nu_{\epsilon} \in \mathfrak{M}_{+}(\Omega ; \underset{\sim}{\rho})$. Let $\tilde{\Omega}_{\epsilon, t}=\left\{x \in \tilde{\Omega}_{\epsilon}: \rho(x)>t\right\}$ and $\nu_{\epsilon, t}=\chi_{\tilde{\Omega}_{\epsilon, t}} \nu_{\epsilon}$. The bounded measure $\nu_{\epsilon, t}$ is $g_{p}$ - good in $\tilde{\Omega}_{\epsilon}$. From [2], this holds if and only if for any Borel set $K \subset \tilde{\Omega}_{\epsilon}$,

$$
c_{2, p^{\prime}}^{\mathbb{R}^{N}}(K)=0 \Longrightarrow \nu_{\epsilon, t}(K)=0
$$

Assume now $E \subset \Omega$ is a compact set such that $c_{2, p^{\prime}}^{\mathbb{R}^{N}}(E)=0$. Then $c_{2, p^{\prime}}^{\mathbb{R}^{N}}\left(E \cap \tilde{\Omega}_{\epsilon, t}\right)=0$ and thus $\nu_{\epsilon, t}\left(E \cap \tilde{\Omega}_{\epsilon, t}\right)=0$. By the monotone convergence theorem, it implies

$$
\lim _{\epsilon \rightarrow 0} \lim _{t \rightarrow 0} \nu_{\epsilon, t}\left(E \cap \tilde{\Omega}_{\epsilon, t}\right)=\lim _{\epsilon \rightarrow 0} \nu_{\epsilon}\left(E \cap \tilde{\Omega}_{\epsilon}\right)=\nu(E)=0
$$

Similarly, using Marcus-Véron results on the boundary trace (see e.g. [23]) $\lambda$ is $g_{p}$-good if and only if $\lambda_{\epsilon}$ vanishes on compact sets $E \subset \partial \tilde{\Omega}_{\epsilon}$ such that $c_{\frac{2}{p}, p^{\prime}}^{\mathbb{R}^{N-1}}(E)=0$. Clearly $\lambda$ shares this property.

Conversely, if $\nu$ (resp. $\lambda$ ) vanishes on compact sets $E \subset \Omega$ (resp. $E \subset \partial \Omega$ ) such that $c_{2, p^{\prime}}^{\mathbb{R}^{N}}(E)=0$ (resp. $c_{\frac{\mathbb{R}^{N}}{N}, p^{\prime}}^{\mathbb{R}^{\prime}}(E)=0$ ), then $\nu_{+}\left(\right.$resp. $\left.\lambda_{+}\right)$has the same property. Hence we can assume that $\nu$ (resp. $\lambda$ ) is nonnegative. Clearly $\nu_{\epsilon}$ (resp. $\lambda_{\epsilon}$ ) shares also this property. If $0<t<\epsilon$ we denote by $\Omega_{t}^{*}$ a smooth domain such that $\Omega_{\epsilon} \subset \Omega_{t}^{*} \subset \Omega$ and $\Omega_{t}^{*} \cap B_{\frac{t}{2}}=0$ there exists an increasing sequence $\left\{\nu_{\epsilon, n}\right\}$ (resp. $\left\{\lambda_{\epsilon, n}\right\}$ ) of positive bounded measures belong
to $W^{-2, p}(\Omega)$ (resp. $W^{-\frac{2}{p}, p}(\partial \Omega)$ ) converging to $\nu_{\epsilon}$ (resp. $\lambda_{\epsilon}$ ). The measures $\nu_{\epsilon, n}$ (resp. $\lambda_{\epsilon, n}$ ) are $g_{p}$-good relatively to the open set $\Omega_{t}^{*}$. Therefore there exists a sequence of solutions $\left\{\tilde{u}_{\epsilon, t n}\right\}$ satisfying weakly

$$
\left\{\begin{aligned}
\mathcal{L}_{\mu} \tilde{u}_{\epsilon, t n}+g_{p}\left(\tilde{u}_{\epsilon, t n}\right) & =\nu_{\epsilon, n} & & \text { in } \Omega_{t}^{*} \\
\tilde{u}_{\epsilon, t n} & =\lambda_{\epsilon, n} & & \text { on } \partial \Omega \cap \partial \Omega_{t}^{*} \\
\tilde{u}_{\epsilon, t n} & =0 & & \text { on } \partial \Omega_{t}^{*} \cap \Omega
\end{aligned}\right.
$$

Letting $n \rightarrow \infty$, we infer that $\tilde{u}_{\epsilon, \delta n}$ increases and converges to the solution $\tilde{u}_{\epsilon, \delta}$ of

$$
\left\{\begin{aligned}
\mathcal{L}_{\mu} \tilde{u}_{\epsilon, t}+g_{p}\left(\tilde{u}_{\epsilon, t}\right) & =\nu_{\epsilon} & & \text { in } \Omega_{t}^{*} \\
\tilde{u}_{\epsilon, t} & =\lambda_{\epsilon} & & \text { on } \partial \Omega \cap \partial \Omega_{t}^{*} \\
\tilde{u}_{\epsilon, t} & =0 & & \text { on } \partial \Omega_{t}^{*} \cap \Omega
\end{aligned}\right.
$$

For $0<t<t^{\prime}, \tilde{u}_{\epsilon, t} \geq \tilde{u}_{\epsilon, t^{\prime}}$, hence $\tilde{u}_{\epsilon}:=\lim _{t \rightarrow 0^{+}} \tilde{u}_{\epsilon, t}$ satisfies

$$
\begin{equation*}
\int_{\Omega}\left(\tilde{u}_{\epsilon} \mathcal{L}_{\mu}^{*} \zeta+g_{p}\left(\tilde{u}_{\epsilon}\right) \zeta\right) d \gamma_{\mu}^{\Omega}=\int_{\Omega} \zeta d\left(\gamma_{\mu}^{\Omega} \nu_{\epsilon}\right)+\int_{\partial \Omega} \zeta d\left(\beta_{\mu}^{\Omega} \lambda_{\epsilon}\right) \tag{3.5}
\end{equation*}
$$

for all $\zeta \in \mathbb{X}_{\mu}^{\Omega}$ which vanishes in a neigborhood of 0 . We end the proof as in Theorem B. We first obtain that $\tilde{u}_{\epsilon}$ satisfies (3.5) for all $\zeta \in \mathbb{X}_{\mu}^{\Omega}$, and then we let $\epsilon \rightarrow 0$ and conclude that $u:=\lim _{\epsilon \rightarrow 0} \tilde{u}_{\epsilon}$ satisfies

$$
\left\{\begin{aligned}
\mathcal{L}_{\mu} u+g_{p}(u)=\nu & \text { in } \Omega \\
u=\lambda & \text { on } \partial \Omega
\end{aligned}\right.
$$

hence $(\nu, \lambda)$ is $g_{p}$ good.
Proof of Theorem E. A particular case of Theorem $E$ that we will prove in Theorem $J$ is that 0 is a non-removable singularity if and only if $1<p<p_{\mu}^{*}$ for any $\mu \geq \mu_{1}$ and $N>2$, or $p>p_{\mu}^{* *}$ with $N \geq 3$ and $\mu<1-N$.
(i) Assume $K \subset \Omega$ is compact. It follows from [2, Theorem 3.1] that $c_{2, p^{\prime}}^{\mathbb{R}^{N}}(K)=0$ is a necessary and sufficient condition for $K$ to be removable for the operator $\mathcal{L}_{\mu}$ (and $p \geq \frac{N}{N-2}$ otherwise $K$ is empty).
(ii) Let $K \subset \partial \Omega \backslash\{0\}$ be compact and, for $\epsilon>0, K_{\epsilon}=\{x \in \Omega$ : $\operatorname{dist}(x, K)<\epsilon\}$. Assume $u$ is a function belonging to $L^{1}\left(\Omega \backslash K_{\epsilon}, \rho^{-1} d \gamma_{\mu}^{\Omega}\right) \cap L^{p}\left(\Omega \backslash K_{\epsilon}, d \gamma_{\mu}^{\Omega}\right)$ for any $\epsilon>0$ satisfying

$$
\begin{equation*}
\int_{\Omega}\left(u \mathcal{L}_{\mu}^{*} \zeta+g_{p}(u) \zeta\right) d \gamma_{\mu}(x)=0 \tag{3.6}
\end{equation*}
$$

for any $\zeta \in \mathbb{X}_{\mu}(\Omega)$ vanishing in a neighborhood of $K$. Taking a test function $\zeta \in C^{2}(\bar{\Omega})$ vanishing on $\partial \Omega$ and in a neighborhood of $K$ we infer by standard regularity theory that $u \in$ $C^{2}\left(\bar{\Omega} \backslash(K \cup\{0\})\right.$ is a strong solution of $\mathcal{L}_{\mu} u+g_{p}(u)=0$ in $\Omega$ which vanishes on $\partial \Omega \backslash(K \cup\{0\})$. Let $G \subset \Omega$ be a smooth domain such that $K$ is interior to $\partial G \cap \partial \Omega$ relatively to the induced topology on $\partial \Omega$ and such that $0 \notin \bar{G}$. Then $\mu|x|^{-2}$ is bounded in $\bar{G}$. Then there exists $a>0$ and $b \in \mathbb{R}$ such that

$$
g_{p}(u)+\mu|x|^{-2} u \geq a u_{+}^{p}-b
$$

Set $m=\max \left\{u_{+}(x): x \in \partial G \cap \Omega\right\}$. Then implies that $v=\left(u-m-\left(\frac{b_{+}}{a}\right)^{\frac{1}{p}}\right)$ satisfies $-\Delta v+a v^{p} \leq 0$ in $G$ and vanishes on $\partial G \backslash K$. Since $c_{\frac{2}{p}, p^{\prime}}^{\mathbb{R}^{N-1}}(K)=0$ (and $p \geq \frac{N+1}{N-1}$ otherwise $K$ is empty), $v=0$ by [21, Theorem 3.3], which implies $u \leq m+\left(\frac{b_{+}}{a}\right)^{\frac{1}{p}}$ in $G$. Similarly $u$ is bounded from below in $G$ and it follows that (3.6) holds for all $\zeta \in \mathbb{X}_{\mu}(\Omega)$. Hence $u=0$ by uniqueness.

Conversely, if $c_{\frac{2}{p}, p^{\prime}}^{\mathbb{R}^{N-1}}(K)>0$, then there exists a capacitary measure $\lambda_{K}$ belonging to $W^{-\frac{2}{p}, p}(\partial \Omega)$ with support in $K$. Since $\lambda_{K}$ vanishes on Borel set with $C_{\frac{2}{p}, p^{\prime}}^{\mathbb{R}^{N-1}}$-capacity 0 , it is $g_{p}$-good and there exists a solution $u$ to

\mathcal{L}_{\mu} u+g_{p}(u) & =0 & & \text { in } \Omega  \tag{3.7}\\
u & =\lambda_{K} & & \text { on } \partial \Omega .
\end{align*}\right.
$$

Hence $u$ satisfies (3.6) for all $\zeta \in \mathbb{X}_{\mu}(\Omega)$ vanishing in a neighborhood of $K$. Hence $K$ is not removable.
(iii) If $K \subset \bar{\Omega} \backslash\{0\}$ is such that $c_{\frac{2}{p}, p^{\prime}}^{\mathbb{R}^{N-1}}(K \cap \partial \Omega)>0$ then $K \cap \partial \Omega$ is not removable by (ii). If $c_{2, p^{\prime}}^{\mathbb{R}^{N}}(K \cap \Omega)>0$, then there exists an increasing sequence of compact sets $K_{n} \subset K \cap \Omega$ such that $c_{2, p^{\prime}}^{\mathbb{R}^{N}}\left(K_{n}\right)>0$. Hence $K_{n}$ is not removable, and clearly $K$ inherits the same property as it contains $K_{n}$.
(iv) If $0 \in K \subset \partial \Omega$ and $K \backslash\{0\} \neq \emptyset$ and assume that any solution of (1.16) is identically 0 , in particular any solution which vanishes on $\partial \Omega \backslash\{0\}$ is zero. By Theorem $J$ this is ensured only if $p \geq p_{\mu}^{*}$. If $c_{\frac{\mathbb{R}^{N-1}}{p}, p^{\prime}}(K)>0$, then either $p<\frac{N+1}{N-1}$, thus $K \backslash\{0\}$ contains at least one point which is not removable, or $p \geq \frac{N+1}{N-1}$, and since $c_{\frac{\mathbb{R}^{N}}{N}, p^{\prime}}^{N-1}(K \backslash\{0\})=c_{\frac{2}{p}, p^{\prime}}^{\mathbb{R}^{N-1}}(K)>0>0$, there exists a compact subset $K^{\prime} \subset K \backslash\{0\}$ such that $c_{\underline{R}^{\prime}}^{\mathbb{R}^{N-1}}\left(K^{\prime}\right)>0$. Hence $K^{\prime}$, and therefore $K$, is not removable. This implies that if $K$ is removable one must have $p \geq p_{\mu}^{*}$ and $c_{\frac{\mathbb{R}^{N}}{\mathbb{R}^{N-1}}, p^{\prime}}(K)=0$.

Conversely, if $p \geq p_{\mu}^{*}$, we will see at Theorem J that there exists no nonzero solution $u \in$ $C(\bar{\Omega} \backslash\{0\})$ of $\mathcal{L}_{\mu} u+g_{p}(u)=0$ vanishing on $\partial \Omega \backslash\{0\}$. For $0<t<\epsilon$ we set $K_{t}=\{x \in \Omega$ : $\operatorname{dist}(x, K)<t\}, K_{\delta, \epsilon}=K_{t} \cap B_{2 \epsilon}^{c}$ and $\Omega_{t, \epsilon}=\Omega \backslash \bar{K}_{t, \epsilon}$. We denote by $v_{t, \epsilon}$ the maximal solution of $\mathcal{L}_{\mu} u+g_{p}(u)=0$ in $\Omega_{t, \epsilon}$ which vanishes on $\partial \Omega \backslash K_{t, \epsilon}$; hence it blows-up on $\partial K_{t, \epsilon}$ and it can be easily constructed by Lemma 3.5 by approximation with solutions with finite boundary value on $\partial K_{t, \epsilon}$. We also denote by $w_{\epsilon}$ the maximal solution of the same equation in $\Omega_{\epsilon}:=\Omega \cap \bar{B}_{\epsilon}^{c}$ which vanishes on $\partial \Omega \backslash B_{\epsilon}$. It blows up on $\partial B_{\epsilon} \cap \Omega$. If $u$ is a solution of (1.16), it is dominated in $\Omega \backslash\left(\bar{K}_{t, \epsilon} \cup \bar{B}_{\epsilon}\right)$ by the supersolution $v_{t, \epsilon}+w_{\epsilon}$. When $t \rightarrow 0, v_{t, \epsilon}$ converges to the function $v_{0, \epsilon}$ which satisfies the equation in $\Omega_{\epsilon}$ and vanishes on $\partial \Omega_{\epsilon} \backslash K$. Since $c_{\frac{\mathbb{R}_{p}}{N^{N-1}}}(K)=0$, there holds $c_{\frac{2}{p}, p}^{\mathbb{R}^{N-1}}\left(K \cap B_{2 \epsilon}^{c}\right)=0$. Therefore $v_{0, \epsilon}=0$. When $\epsilon \rightarrow 0, w_{\epsilon}$ decreases and converges to a solution of the equation in $\Omega$ which vanishes on $\partial \Omega \backslash\{0\}$, hence this limit is zero and consequently $u=0$. (v) If $0 \in K \subset \bar{\Omega}$ and $K \backslash\{0\} \neq \emptyset$ and any solution of (1.16) is identically. Then $p \geq p_{\mu}^{*}$ as in (iv). Since $K \cap \Omega \neq \emptyset$ then any point in $K \cap \Omega$ is a removable singularity, hence $p \geq \frac{N}{N-2}$
(which implies $p>\frac{N+1}{N-1}$ ). If $c_{2, p^{\prime}}^{\mathbb{R}^{N}}(K \cap \Omega)>0$, there exists a compact set $K^{\prime} \subset K \cap \Omega$ such that $c_{2, p^{\prime}}^{\mathbb{R}^{N}}\left(K^{\prime}\right)>0$. Then $K^{\prime}$ is not removable by Theorem $D$, hence $K$ is not removable too. If $c_{\frac{2}{p}, p^{\prime}}^{\mathbb{R}^{N-1}}(K \cap \partial \Omega)>0$, then $K$ is not removable as in (iv).

Conversely assume that $p \geq p_{\mu}^{*}, c_{2, p^{\prime}}^{\mathbb{R}^{N}}(K \cap \Omega)=0, c_{\frac{2}{p}, p^{\prime}}^{\mathbb{R}^{N-1}}(K \cap \partial \Omega)=0$ and $u$ satisfies (1.16). For $0<t<\epsilon$, we define $K_{t}=\{x \in \Omega$ : dist $(x, K \cap \partial \Omega)<t\}, K_{t, \epsilon}=K_{\delta} \cap B_{2 \epsilon}^{c}$ as in (iv) and $\tilde{K}_{t, \epsilon}=\{x \in \Omega: \operatorname{dist}(x, K \cap \Omega)<t\} \cap\{x \in \Omega: \operatorname{dist}(x, \partial \Omega)>2 \epsilon\}$. The functions $v_{t, \epsilon}$ and $w_{\epsilon}$ are defined as in (iv). We also denote by $\tilde{v}_{t, \epsilon}$ the maximal solution of $\mathcal{L}_{\mu}+g_{p}(u)=0$ in $\Omega \backslash \tilde{K}_{t, \epsilon}$ which vanishes on $\partial \Omega$. Then $u \leq v_{t, \epsilon}+\tilde{v}_{t, \epsilon}+w_{\epsilon}$ in $\Omega \backslash\left(\bar{K}_{t, \epsilon} \cup \tilde{K}_{t, \epsilon} \cup \bar{B}_{\epsilon}\right.$. When $t \rightarrow 0, v_{t, \epsilon} \rightarrow 0$ since $c_{\frac{2}{p}, p^{\prime}}^{\mathbb{R}^{N-1}}\left(K \cap B_{\epsilon}^{c} \cap \partial \Omega\right)=0$ and $\tilde{v}_{t, \epsilon} \rightarrow 0$ since $c_{2, p^{\prime}}^{\mathbb{R}^{N}}(K \cap\{x \in \Omega: \operatorname{dist}(x, \partial \Omega)>2 \epsilon\})=0$. Hence $u \leq w_{\epsilon}$ and we conclude as in (iv) by letting $\epsilon \rightarrow 0$.

## 4 Isolated boundary singularities

The study of boundary isolated singularities is based upon a technical framework which has been introduced by [17] in the case $\mu=0$. For the sake of completeness we recall this formalism. Up to a rotation we assume that the inward normal direction to $\partial \Omega$ at 0 is $\mathbf{e}_{N}=\left(0^{\prime}, 1\right) \in$ $\mathbb{R}^{N-1} \times \mathbb{R}$ and that the tangent hyperplane to $\partial \Omega$ at 0 is $\partial \mathbb{R}_{+}^{N}=\mathbb{R}^{N-1}$. For $R>0$ set $B_{R}^{\prime}=\left\{x^{\prime} \in \mathbb{R}^{N-1}:\left|x^{\prime}\right|<R\right\}$ and $D_{R}=B_{R}^{\prime} \times(-R, R)$. Then there exist $R>0$ and a $C^{2}$ function $\theta: B_{R}^{\prime} \mapsto \mathbb{R}$ such that $\partial \Omega \cap D_{R}=\left\{x=\left(x^{\prime}, x_{N}\right): x_{N}=\theta\left(x^{\prime}\right)\right.$ for $\left.x^{\prime} \in B_{R}^{\prime}\right\}$ and $\Omega \cap D_{R}=\left\{x=\left(x^{\prime}, x_{N}\right): \theta\left(x^{\prime}\right)<x_{N}<R\right\}$. Furthermore $\nabla \theta(0)=0$. Define the function $\Theta=\left(\Theta_{1}, \ldots, \Theta_{N}\right)$ on $D_{R}$ by $y_{j}=\Theta_{j}(x)=x_{j}$ if $1 \leq j \leq N-1$ and $y_{N}=\Theta_{N}(x)=x_{N}-\theta\left(x^{\prime}\right)$. Since $D \Theta(0)=I d$ we can assume that $\Theta$ is a diffeomorphism from $D_{R}$ onto $\Theta\left(D_{R}\right)$. Let $z$ be the harmonic extension of $h$ in $B_{R} \cap \Omega$ vanishing on $\Omega \cap \partial B_{R}$ and set

u(x)-z(x)=\tilde{u}(y), z(x)=\tilde{z}(y) \quad \text { for all } x \in D_{R}^{+}=B_{R}^{\prime} \times[0, R)
$$

Denote by $(r, \sigma) \in(0, \tilde{r}) \times S^{N-1}$ the spherical coordinates in $\mathbb{R}^{N}$ and set

$$
\tilde{u}(y)=\tilde{u}(r, \sigma)=r^{-a} v(t, \sigma), \tilde{z}(y)=\tilde{z}(r, \sigma)=r^{-a} \mathcal{Z}(t, \sigma), t=\ln r, a=\frac{2}{p-1} .
$$

Then $v$ is bounded and satisfies the following asymptotically autonomous equation in $\left(-\infty, r_{0}\right] \times$ $\mathbb{S}_{+}^{N-1}$

\begin{align*}
& \left(1+\epsilon_{1}(t, \cdot)\right) v_{t t}+\left(N-2-2 a+\epsilon_{2}(t, \cdot)\right) v_{t}+\left(a(a+2-N)-\mu+\epsilon_{3}(t, \cdot)\right) v+\Delta^{\prime} v \\
& +\left\langle\nabla^{\prime} v, \epsilon_{4}(t, \cdot)\right\rangle+\left\langle\nabla^{\prime} v_{t}, \epsilon_{5}(t, \cdot)\right\rangle+\left\langle\nabla^{\prime}\left(\left\langle\nabla^{\prime} v, \mathbf{e}_{N}\right\rangle\right), \epsilon_{6}(t, \cdot)\right\rangle+\mu \mathcal{Z}-|v+\mathcal{Z}|^{p-1}(v+\mathcal{Z})=0 \tag{4.1}
\end{align*}
$$

where $\Delta^{\prime}$ is the Laplace-Beltrami operator on $\mathbb{S}^{N-1}$ and the $\epsilon_{j}$ satisfy the estimates

\left|\epsilon_{j}(t, \cdot)\right|+\left|\partial_{t} \epsilon_{j}(t, \cdot)\right|+\left|\nabla^{\prime} \epsilon_{j}(t, \cdot)\right| \leq c_{17} e^{t}

As for $\mathcal{Z}$ it verifies

|\mathcal{Z}(t, \cdot)|+\left|\partial_{t} \mathcal{Z}(t, \cdot)\right|+\left|\nabla^{\prime} \mathcal{Z}(t, \cdot)\right| \leq c_{17} e^{a t}
$$

This is due to the fact that $\left|\theta\left(x^{\prime}\right)\right|=O\left(\left|x^{\prime}\right|^{2}\right)$ near 0 . Furthermore, standard elliptic equations theory implies that there holds, if $k+\ell \leq 3$,

Proof of Theorem F. We denote by $\mathcal{S}_{\mu, p}$ the set of functions satisfying

where $a=\frac{2}{p-1}$.
(i) If $\omega$ is a solution it satisfies

If $N-1+a(N-2-a)+\mu \geq 0$, then necessarily $\omega=0$. Next

\end{array}\right.

(ii) By minimization $\mathcal{S}_{\mu, p}$ is not empty if the conditions (i) or (ii) of Theorem F are fulfilled, in which case $\mathcal{S}_{\mu, p}$ has a unique positive element (see [17] for a similar situation). This unique positive element is denoted $\omega_{\mu}$.
(iii) The last statement follows an idea introduced in [28]. The hupper hemisphere admits the following representation

& \geq 2^{1-p} \int_{\mathbb{S}_{+}^{N-1}}\left|\omega-\bar{\omega}^{\prime}\right|^{p+1} d S .
\end{aligned}

The function $\omega-\bar{\omega}^{\prime}$ is orthogonal to the first eigenspace of $-\Delta^{\prime}$ in $H_{0}^{1,2}\left(\mathbb{S}_{+}^{N-1}\right)$. Since the second eigenvalue of $-\Delta^{\prime}$ in $H_{0}^{1,2}\left(\mathbb{S}_{+}^{N-1}\right)$ in $2 N$, we have

Hence, if $a(N-2-a)+\mu+2 N \geq 0$ it follows that $\omega-\bar{\omega}^{\prime}=0$. The polynomial

admits two real roots provided $\mu \geq-\left(\frac{N+2}{2}\right)^{2}:=\mu_{2}$, which are expressed by

Note that $a_{+} a_{-}>0$ if and only if $-2 N>\mu$. Furthermore $P_{2}\left(-\alpha_{-}\right)<0$ and $P_{2}\left(-\alpha_{+}\right)<0$. Then
(i) if $\mu \geq 1-N$ then $a_{+}<-\alpha_{+}<0<-\alpha_{-}<a_{-} \Longrightarrow \tilde{p}_{\mu}^{*}<p_{\mu}^{*}$,
(ii) if $N \geq 3 \&-2 N \leq \mu<1-N$
(iii) if $N \geq 9 \& \mu_{1} \leq \mu<-2 N$
then $a_{+}<0<-\alpha_{+} \leq-\alpha_{-}<a_{-} \Longrightarrow \tilde{p}_{\mu}^{*}<p_{\mu}^{*}<p_{\mu}^{* *}$,
then $0<a_{+}<-\alpha_{+} \leq-\alpha_{-}<a_{-} \Longrightarrow \tilde{p}_{\mu}^{*}<p_{\mu}^{*}<p_{\mu}^{* *}<\tilde{p}_{\mu}^{* *}$, where, we recall it,

Therefore $\omega-\bar{\omega}^{\prime}=0$ if the following conditions are satisfied
(i) when $\mu \geq 1-N$ and $\tilde{p}_{\mu}^{*} \leq p<p_{\mu}^{*}$,
(ii) when $N \geq 3,-2 N \leq \mu<1-N$ and either $\tilde{p}_{\mu}^{*} \leq p<p_{\mu}^{*}$ or $p_{\mu}^{* *}<p$,
(iii) when $N \geq 9$ and $\mu_{1} \leq \mu<-2 N$ and either $\tilde{p}_{\mu}^{*} \leq p<p_{\mu}^{*}$ or $p_{\mu}^{* *}<p \leq \tilde{p}_{\mu}^{* *}$.

Leray-Hardy equations with absorption

If one of the above conditions is fulfilled, $\omega$ depends only on the variable $\phi \in\left[0, \frac{\pi}{2}\right]$. It satisfies

$$

Define the operator

\mathcal{B}(\psi)=-\frac{1}{\sin ^{N-2} \phi}\left(\sin ^{N-2} \phi \psi_{\phi}\right)_{\phi}
$$

among functions $\psi$ in the space $\mathcal{H}_{\mathcal{B}} \subset C^{2}\left(\left[0, \frac{\pi}{2}\right]\right)$ satisfying $\psi_{\phi}(0)=0$ and $\psi\left(\frac{\pi}{2}\right)=0$. The first eigenvalue of $\mathcal{B}$ in $\mathcal{H}_{\mathcal{B}}$ is $N-1$ and the second in $2 N$. Since $g_{p}$ is nonnecreasing, it is known (see e.g. [4]) that the constant sign solutions $\omega_{p}$ and $-\omega_{p}$ lie on a branch of bifurcation issued from $N-1$ and there exists no other bifurcation when the parameter $a(N-2-a)+\mu$ belongs to $(N-1,2 N]$. This implies $\mathcal{S}_{\mu, p}=\left\{\omega_{p},-\omega_{p}, 0\right\}$ and ends the proof.

For proving Theorems $G, H, I, J$ we recall here the following technical results [17, Theorem 5.1] related to the solutions of (1.17) satisfying

The statement is easily adapted from the one of the above mentioned theorem. We denote by $\lambda_{k}=\left\{k\left(k+N-2: k \in \mathbb{N}^{*}\right\}\right.$ the set of eigenvalues of $-\Delta^{\prime}$ in $H^{1,0}\left(\mathbb{S}_{+}^{N-1}\right)$. Any separable $\mathcal{L}_{\mu}$-harmonic function in $\mathbb{R}_{+}^{N}$ vanishing on $\partial \mathbb{R}_{+}^{N} \backslash\{0\}$ endows the form

where $\phi_{k} \in \operatorname{ker}\left(\Delta^{\prime}+\lambda_{k} I\right)$ and $\alpha_{k}=\alpha_{k-}$ or $\alpha_{k+}$ the smallest and the largest root of

$$
\alpha^{2}+(N-2) \alpha-\lambda_{k}-\mu=0,
$$

which exist for some $k \geq 1$ if and only if $\mu \geq \mu_{k}:=\mu_{1}+N-1-\lambda_{k}$. Note that $\alpha_{k-} \leq 0$ for all $k \in \mathbb{N}^{*}$ and $\alpha_{k+} \leq 0$ if and only if $\mu \geq-\lambda_{k}$ (which imposes $N \geq 8 k(k+\sqrt{2 k(k-1)})$ ).

Theorem 4.1 Assume $\mu \geq \mu_{1}, 1<p<p_{\mu}^{*}$ and $h \in C^{3}(\partial \Omega)$. If $u \in C(\bar{\Omega} \backslash\{0\}) \cap C^{2}(\Omega)$ is a solution of (1.17) satisfying (4.4) and
(A) either $u_{-}(x)=O\left(|x|^{-\frac{2}{p-1}+\delta}\right)$ near $x=0$, for some $\delta>0$,
(B) or $N=2$ and $\Omega$ is locally a straight line near $x=0$,
(B) or $-\frac{2}{p-1}$ is not equal to some $\alpha_{k-}$ for some $k \in \mathbb{N}^{*}$.

Then
(i) either $u$ is the weak solution of (1.18),
(ii) or there exist an integer $k \in \mathbb{N}^{*}$ such that $-\alpha_{k-}<\frac{2}{p-1}$ and a nonzero spherical harmonic $\psi_{k}$ of degree $k$ such that

$$
\begin{equation*}
\lim _{x \rightarrow 0} r^{\alpha_{k-}} \tilde{u}(r, \sigma)=\psi_{k}(\sigma) \tag{4.5}
\end{equation*}
$$

### 4.1 Proof of Theorems G, H, I and J

Because of (4.2) the negative trajectory of $v$ in $C_{0}^{1}\left(\overline{\mathbb{S}_{+}^{N-1}}\right)$ which is defined by

$$
\mathcal{T}_{-}(v)=\bigcup_{t \leq r_{0}-1}\{v(t, .)\}
$$

is relatively compact in the $C^{2}\left(\overline{\mathbb{S}_{+}^{N-1}}\right)$-topology. The limit set $\mathcal{E}_{v}$ of $\mathcal{T}_{-}(v)$ at $-\infty$ defined by

$$
\mathcal{E}_{v}=\bigcap_{\tau \leq r_{0}-1} \overline{\left.\bigcup_{t \leq \tau}\{v(t, .)\}^{C_{0}^{1}} \overline{\mathbb{S}_{+}^{N-1}}\right)}
$$

is non-empty. Since $1<p<p_{\mu}^{*}$ and $\mu \geq \mu_{1}$, there holds

$$
\begin{equation*}
p<\frac{N+2}{N-2} \tag{4.6}
\end{equation*}
$$

Thus the coefficient of $v_{t}$ in (4.1) is not zero (asymptotically, when $t \rightarrow-\infty$ ). Then energy damping holds and, in the same way as in [17] up to a shift of $\mu$ in the coefficient of $v$ in (4.1), we obtain

$$
\int_{-\infty}^{r_{0}-1} \int_{\mathbb{S}_{+}^{N-1}} v_{t}^{2} d \sigma d t<\infty
$$

Combining this estimate with (4.2) and some standard manipulations (see [17]) implies that

$$
\left\|v_{t}(t, .)\right\|_{C^{1}\left(\overline{\mathbb{S}_{+}^{N-1}}\right)}+\left\|v_{t t}(t, .)\right\|_{C\left(\overline{\mathbb{S}_{+}^{N-1}}\right)} \rightarrow 0 \quad \text { as } t \rightarrow-\infty
$$

Hence $\mathcal{E}_{v}$ is a compact connected component of $\mathcal{S}_{\mu, p}$.
Proof of Theorem G. If $\omega$ is nonnegative, either $\mathcal{E}_{v}=\left\{\omega_{p}\right\}$ and (1.22) holds or

$$
\lim _{t \rightarrow-\infty}\|v(t, .)\|_{C^{2}\left(\overline{\mathbb{S}_{+}^{N-1}}\right)} \rightarrow 0 \quad \text { as } t \rightarrow-\infty
$$

If this holds, it follows by Theorem 4.1-A that either $u=0$ or (4.5) is verified for some $k \geq 1$. Since any spherical harmonics of degree at least two changes sign $k$ must be equal to 1 . Then

$$
\tilde{u}(x)=\ell \phi_{\mu}(x)(1+o(1)) \quad \text { as } x \rightarrow 0,
$$

which is (1.23).
Corollary 4.2 Let $\mu_{1} \leq \mu$ and $1<p<p_{\mu}^{*}$. Then for any $h \in C^{3}(\Omega), h \geq 0$ there exists only one solution of (1.17) with a strong singularity at $x=0$, that is satisfying (1.22).

Proof. It is a consequence of Theorem $G$ that the limit of $u_{\ell \delta_{0}, h}$ of the solution of (1.24) when $\ell \rightarrow \infty$ is a solution which satisfies (1.22). The method of proof of uniqueness is due to Marcus and Véron [20]. The minimal solution of (1.24) with a strong singularity at $x=0$ is defined by

$$
\underline{u}_{\infty, h}:=\lim _{\ell \rightarrow \infty} u_{\ell \delta_{0}, h} .
$$

For constructing the maximal solution we define the sequence $\bar{u}_{n, h}$ of solutions of

$$
\left\{\begin{aligned}
\mathcal{L}_{\mu} \bar{u}_{n, h}+g_{p}\left(\bar{u}_{n, h}\right) & =0 & & \text { in } \Omega \cap \bar{B}_{\frac{1}{n}}^{c} \\
\bar{u}_{n, h} & =h & & \text { in } \partial \Omega \cap B_{\frac{1}{n}}^{c} \\
\bar{u}_{n, h} & =c n^{\frac{2}{p-1}} & & \text { in } \Omega \backslash \partial B_{\frac{1}{n}},
\end{aligned}\right.
$$

where $c>0$ is some constant large enough. Then $u_{\ell \delta_{0}, h} \leq \bar{u}_{n, h}$. By convexity there holds

$$
\bar{u}_{n, h}-u_{\ell \delta_{0}, h} \leq \bar{u}_{n, 0}-u_{\ell \delta_{0}, 0} .
$$

By monotonicity $\left\{\bar{u}_{n, h}\right\}$ decreases and converges to the maximum solution $\bar{u}_{\infty, h}$ of (1.22) and there holds

$$
\bar{u}_{\infty, h}-\underline{u}_{\infty, h} \leq \bar{u}_{\infty, 0}-\underline{u}_{\infty, 0} .
$$

Furthermore, by (1.22), there exists $K=K(p, \mu, \Omega)>1$ such that

$$
\bar{u}_{\infty, 0} \leq K \underline{u}_{\infty, 0} .
$$

If we assume that $\bar{u}_{\infty, 0}>\underline{u}_{\infty, 0}$, then, again by convexity, the function

$$
U=\bar{u}_{\infty, 0}-\frac{1}{K}\left(\underline{u}_{\infty, 0}-\bar{u}_{\infty, 0}\right)
$$

is a supersolution for problem (1.17) smaller than $\underline{u}_{\infty, 0}$. The function

$$
U^{*}=\left(\frac{1}{2 K}+\frac{1}{2}\right) \bar{u}_{\infty}
$$

is a supersolution of the same problem (1.17) smaller than $U$. By a standard result there exists $V$ solution of the problem such that $U^{*} \leq V \leq U$. In particular $V$ has a strong blow-up at $x=0$ and it is smaller than the minimal solution $\underline{u}_{\infty}$, contradiction.
Proof of Theorem H. Since $\mathcal{E}_{v}$ is a connected subset of the discrete set $\mathcal{S}_{\mu, p}$ which has three connected components $\left(\left\{\omega_{p}\right\},\left\{-\omega_{p}\right\},\{0\}\right)$ by Theorem F-(1) either (1.25) or (4.4) holds. Since $p>\tilde{p}_{\mu}^{*},-\frac{2}{p-1}$ which necessarily larger $\alpha_{1-}$ satisfies either $\frac{2}{p-1}<\alpha_{2-}$ or, if $\frac{2}{p-1}>\alpha_{2+}$ in the case $N \geq 9$ and $\mu<-2 N$ and $\frac{2}{p-1}$ is not equal to any $\alpha_{k-}$ or $\alpha_{k+}$ for $k>2$ by the equation. Hence, by Theorem 4.1, (1.23) holds.
Remark. If $p=\tilde{p}_{\mu}^{*}$ or $p=\tilde{p}_{\mu}^{* *}$ the method shows that either (1.25) or (4.4) holds. Since it is the spectral case always difficult to handle we cannot prove that (1.23) also holds, a fact that we conjecture.

Proof of Theorem I. The two statements obey a totaly different approach.
Statement 1- is a consequence of the theory of analytic functionals developped by in [26], [27] and applied to Emden-Fowler equations in [5]. The key point is to consider the equation (4.1) satisfied by $v(t,)=.r^{-\frac{2}{p-1}} \tilde{u}(r, \sigma)$ in $\left(-\infty, r_{0}\right) \times \mathbb{S}_{+}^{N-1}$ and to verify that, as a function of $v$, it is real analytic. Hence $p$ must be an odd integer. If $1<p<p_{\mu}^{*}$ the only possibility is $p=3$ which
is in the range if $N+4 \sqrt{\mu-\mu_{1}}$. If $\mu<1-N$ and $p>p_{\mu}^{* *}$ there are infinitely many possibilities for $p$.
Statement 2- The convergence to one element of $\mathcal{S}_{\mu, p}$ follows from the fact that this set of solutions of (1.27) is discrete. If $\partial \Omega$ is locally a close graph near 0 the paper [12] which use Sturmian arguments and the Jordan closed curve theorem. If $\omega=0$, as quoted in [17, Theorem 5.1-C2] we perform a reflexion through $\partial \Omega$ near 0 and apply the result of [12, Lemma 2.1], the shift of the coefficient by $\mu$ playing no role.

Proof of Theorem J. Since $p>1$, any solution $u$ of (1.17) satisfies the estimate of Lemma 3.5 under the following form

$$
|u(x)| \leq A|x|^{-\frac{2}{p-1}} \quad \text { for all } x \in \bar{\Omega} \backslash\{0\}
$$

If $p>p_{\mu}^{*}$, then $-\frac{2}{p-1}>\alpha_{-}$, therefore $u(x)=o\left(\phi_{\mu}(x)\right)$ near $x=0$. Let $u_{+}$be the solution of

$$
\left\{\begin{align*}
\mathcal{L}_{\mu} u+g_{p}(u) & =0 & & \text { in } \Omega  \tag{4.7}\\
u & =h_{+} & & \text {on } \partial \Omega .
\end{align*}\right.
$$

For any $\epsilon>0, u_{+}+\epsilon \phi_{\mu}$ is a supersolution of $\mathcal{L}_{\mu} u+g_{p}(u)=0$, larger than $u$ near $x=0$. Then that $u \leq u_{+}+\epsilon \phi_{\mu}$ and, letting $\epsilon \rightarrow 0$ then $u \leq u_{+}$. Similarly $u$ is larger than $-u_{-}-\epsilon \phi_{\mu}$, where $u_{-}$is the solution of (4.7) with $h_{+}$replaced by $h_{-}$. Letting $\epsilon \rightarrow 0$ yields $-u_{-} \leq u \leq u_{+}$. It follows by the method of Theorem B that $u$ is the weak solution of (1.18).
If $p=p_{\mu}^{*}$ and $\mu=\mu_{1}$, then similarly $u(x)=o\left(\phi_{\mu}(x)\right)$ near $x=0$ and the result follows by the same method.
Finally, if $p=p_{\mu}^{*}$ and $\mu>\mu_{1}$, then (4.6) holds. Using the variable $t=\ln r$ and $v(t,)=.r^{\frac{2}{p-1}} \tilde{u}(r,$. we obtain from the previous energy method that

$$
\mathcal{E}_{v} \subset \mathcal{S}_{\mu, p}=\{0\} .
$$

Hence $u$ satisfies (4.4). Since $p=p_{\mu}^{*}, \frac{2}{p-1}=-\alpha_{-}$. Hence $u=o\left(\phi_{\mu}\right)$ near 0 and the conclusion follows as in the previous cases.
