# Estimating FARIMA models with uncorrelated but non-independent error terms

#### Abstract

In this paper we derive the asymptotic properties of the least squares estimator (LSE) of fractionally integrated autoregressive moving-average (FARIMA) models under the assumption that the errors are uncorrelated but not necessarily independent nor martingale differences. We relax considerably the independence and even the martingale difference assumptions on the innovation process to extend the range of application of the FARIMA models. We propose a consistent estimator of the asymptotic covariance matrix of the LSE which may be very different from that obtained in the standard framework. A self-normalized approach to confidence interval construction for weak FARIMA model parameters is also presented. All our results are done under a mixing assumption on the noise. Finally, some simulation studies and an application to the daily returns of stock market indices are presented to corroborate our theoretical work.

## 1. Introduction

Long memory processes takes a large part in the literature of time series (see for instance [GJ80], [FT86], [Dah89], [Hos81], [BFGK13], [Pal07], among others). They also play an important role in many scientific disciplines and applied fields such as hydrology, climatology, economics, finance, to name a few. To model the long memory phenomenon, a widely used model is the fractional autoregressive integrated moving average (FARIMA, for short) model. Consider a second order centered stationary process $X:=\left(X_{t}\right)_{t \in \mathbb{Z}}$ satisfying a $\operatorname{FARIMA}\left(p, d_{0}, q\right)$ representation of the form

a(L)(1-L)^{d_{0}} X_{t}=b(L) \epsilon_{t}, \tag{1}

where $\left.d_{0} \in\right]-1 / 2,1 / 2[$ is the long memory parameter, $L$ stands for the back-shift operator and $a(L)=1-\sum_{i=1}^{p} a_{i} L^{i}$ is the autoregressive (AR for short) operator and $b(L)=1-\sum_{i=1}^{q} b_{i} L^{i}$ is the moving average (MA for short) operator (by convention $a_{0}=b_{0}=1$ ). The operators $a$ and
$b$ represent the short memory part of the model. The linear innovation process $\epsilon:=\left(\epsilon_{t}\right)_{t \in \mathbb{Z}}$ is assumed to be a stationary sequence satisfies
(A0): $\quad \mathbb{E}\left[\epsilon_{t}\right]=0, \operatorname{Var}\left(\epsilon_{t}\right)=\sigma_{\epsilon}^{2}$ and $\operatorname{Cov}\left(\epsilon_{t}, \epsilon_{t+h}\right)=0$ for all $t \in \mathbb{Z}$ and all $h \neq 0$.
Under the above assumptions the process $\epsilon$ is called a weak white noise. Different sub-classes of FARIMA models can be distinguished depending on the noise assumptions. It is customary to say that $X$ is a strong $\operatorname{FARIMA}\left(p, d_{0}, q\right)$ representation and we will do this henceforth if in (1) $\epsilon$ is a strong white noise, namely an independent and identically distributed (iid for short) sequence of random variables with mean 0 and common variance. A strong white noise is obviously a weak white noise because independence entails uncorrelatedness. Of course the converse is not true. Between weak and strong noises, one can say that $\epsilon$ is a semi-strong white noise if $\epsilon$ is a stationary martingale difference, namely a sequence such that $\mathbb{E}\left(\epsilon_{t} \mid \epsilon_{t-1}, \epsilon_{t-2}, \ldots\right)=0$. An example of semistrong white noise is the generalized autoregressive conditional heteroscedastic (GARCH) model (see [FZ10]). If $\epsilon$ is a semi-strong white noise in (1), $X$ is called a semi-strong $\operatorname{FARIMA}\left(p, d_{0}, q\right)$. If no additional assumption is made on $\epsilon$, that is if $\epsilon$ is only a weak white noise (not necessarily iid, nor a martingale difference), the representation (1) is called a weak $\operatorname{FARIMA}\left(p, d_{0}, q\right)$. It is clear from these definitions that the following inclusions hold:
$\left\{\right.$ strong $\left.\operatorname{FARIMA}\left(p, d_{0}, q\right)\right\} \subset\left\{\right.$ semi-strong $\left.\operatorname{FARIMA}\left(p, d_{0}, q\right)\right\} \subset\left\{\right.$ weak $\left.\operatorname{FARIMA}\left(p, d_{0}, q\right)\right\}$.
Nonlinear models are becoming more and more employed because numerous real time series exhibit nonlinear dynamics. For instance conditional heteroscedasticity can not be generated by FARIMA models with iid noises. ${ }^{1}$ As mentioned by [FZO5, FZ98] in the case of ARMA models, many important classes of nonlinear processes admit weak ARMA representations in which the linear innovation is not a martingale difference. The main issue with nonlinear models is that they are generally hard to identify and implement. These technical difficulties certainly explain the reason why the asymptotic theory of FARIMA model estimation is mainly limited to the strong or semistrong FARIMA model.

Now we present some of the main works about FARIMA model estimation when the noise is strong or semi-strong. For the estimation of long-range dependent processes, the commonly used estimation method is based on the Whittle frequency domain maximum likelihood estimator (MLE) (see for instance [Dah89], [FT86], [TT97], [GS90]). The asymptotic properties of the MLE of FARIMA models are well-known under the restrictive assumption that the errors $\epsilon_{t}$ are independent or martingale difference (see [Ber95], [BFGK13], [Pal07], [BCT96], [LL97], [HK98], among others). [HR11], [Nie15] and [CNT17] have considered the problem of conditional sum-of squares estimation and inference on parametric fractional time series models driven by conditionally (unconditionally) heteroskedastic shocks. All the works mentioned above assume either strong or semi-strong innovations. In the modeling of financial time series, for example, the GARCH assumption on the errors is often used (see for instance [BCT96], [HK98]) to capture the conditional heteroscedasticity. There is no doubt that it is important to have a soundness inference procedure for the parameter in the FARIMA model when the (possibly dependent) error is subject to unknown conditional heteroscedasticity. Little is thus known when the martingale difference assumption is relaxed. Our aim in this paper is to consider a flexible FARIMA specification and to relax the independence assumption (and even the martingale difference assumption) in order to be able to

[^0]cover weak FARIMA representations of general nonlinear models. This is why it is interesting to consider weak FARIMA models.

A very few works deal with the asymptotic behavior of the MLE of weak FARIMA models. To our knowledge, [Sha12, Sha10b] are the only papers on this subject. Under weak assumptions on the noise process, the author has obtained the asymptotic normality of the Whittle estimator (see [Whi53]). Nevertheless, the inference problem is not addressed. This is due to the fact that the asymptotic covariance matrix of the Whittle estimator involves the integral of the fourth-order cumulant spectra of the dependent errors $\epsilon_{t}$. Using non-parametric bandwidth-dependent methods, one build an estimation of this integral but there is no guidance on the choice of the bandwidth in the estimation procedures (see [Sha12, Tan82, Kee87, Chi88] for further details). The difficulty is caused by the dependence in $\epsilon_{t}$. Indeed, for strong noise, a bandwidth-free consistent estimator of the asymptotic covariance matrix is available. When $\epsilon_{t}$ is dependent, no explicit formula for a consistent estimator of the asymptotic variance matrix seems to be provided in the literature (see [Sha12]).

In this work we propose to adopt for weak FARIMA models the estimation procedure developed in [FZ98] so we use the least squares estimator (LSE for short). We show that a strongly mixing property and the existence of moments are sufficient to obtain a consistent and asymptotically normally distributed least squares estimator for the parameters of a weak FARIMA representation. For technical reasons, we often use an assumption on the summability of cumulants. This can be a consequence of a mixing and moments assumptions (see [DL89], for more details). These kind of hypotheses enable us to circumvent the problem of the lack of speed of convergence (due to the long-range dependence) in the infinite AR or MA representations. We fix this gap by proposing rather sharp estimations of the infinite AR and MA representations in the presence of long-range dependence (see Subsection 6.1 for details).

In our opinion there are three major contributions in this work. The first one is to show that the estimation procedure developed in [FZ98] can be extended to weak FARIMA models. This goal is achieved thanks to Theorem 1 and Theorem 2 in which the consistency and the asymptotic normality are stated. The second one is to provide an answer to the open problem raised by [Sha12] (see also [Sha10b]) on the asymptotic covariance matrix estimation. We propose in our work a weakly consistent estimator of the asymptotic variance matrix (see Theorem 3). Thanks to this estimation of the asymptotic variance matrix, we can construct a confidence region for the estimation of the parameters. Finally another method to construct such confidence region is achieved thanks to an alternative method using a self normalization procedure (see Theorem 6).

The paper is organized as follows. Section 2 shown that the least squares estimator for the parameters of a weak FARIMA model is consistent when the weak white noise $\left(\epsilon_{t}\right)_{t \in \mathbb{Z}}$ is ergodic and stationary, and that the LSE is asymptotically normally distributed when $\left(\epsilon_{t}\right)_{t \in \mathbb{Z}}$ satisfies mixing assumptions. The asymptotic variance of the LSE may be very different in the weak and strong cases. Section 3 is devoted to the estimation of this covariance matrix. We also propose a self-normalization-based approach to constructing a confidence region for the parameters of weak FARIMA models which avoids to estimate the asymptotic covariance matrix. We gather in Section 7 all our figures and tables. These simulation studies and illustrative applications on real data are presented and discussed in Section 4. The proofs of the main results are collected in Section 6.

In all this work, we shall use the matrix norm defined by $\|A\|=\sup _{\|x\| \leq 1}\|A x\|=\rho^{1 / 2}\left(A^{\prime} A\right)$, when $A$ is a $\mathbb{R}^{k_{1} \times k_{2}}$ matrix, $\|x\|^{2}=x^{\prime} x$ is the Euclidean norm of the vector $x \in \mathbb{R}^{k_{2}}$, and $\rho(\cdot)$ denotes the spectral radius.

## 2. Least squares estimation

In this section we present the parametrization and the assumptions that are used in the sequel. Then we state the asymptotic properties of the LSE of weak FARIMA models.

### 2.1. Notations and assumptions

We make the following standard assumption on the roots of the AR and MA polynomials in (1).
(A1): The polynomials $a(z)$ and $b(z)$ have all their roots outside of the unit disk with no common factors.
Let $\Theta^{*}$ be the space

\Theta^{*}:=\left\{\left(\theta_{1}, \theta_{2}, \ldots, \theta_{p+q}\right) \in \mathbb{R}^{p+q}, \text { where } a_{\theta}(z)\right. & =1-\sum_{i=1}^{p} \theta_{i} z^{i} \text { and } b_{\theta}(z)=1-\sum_{j=1}^{q} \theta_{p+j} z^{j} \\
& \text { have all their zeros outside the unit disk }\} .
\end{aligned}
$$

Denote by $\Theta$ the cartesian product $\Theta^{*} \times\left[d_{1}, d_{2}\right]$, where $\left.\left[d_{1}, d_{2}\right] \subset\right]-1 / 2,1 / 2\left[\right.$ with $d_{1}-d_{0}>-1 / 2$. The unknown parameter of interest $\theta_{0}=\left(a_{1}, a_{2}, \ldots, a_{p}, b_{1}, b_{2}, \ldots, b_{q}, d_{0}\right)$ is supposed to belong to the parameter space $\Theta$.

The fractional difference operator $(1-L)^{d_{0}}$ is defined, using the generalized binomial series, by

$$
(1-L)^{d_{0}}=\sum_{j \geq 0} \alpha_{j}\left(d_{0}\right) L^{j},
$$

where for all $j \geq 0, \alpha_{j}\left(d_{0}\right)=\Gamma\left(j-d_{0}\right) /\left\{\Gamma(j+1) \Gamma\left(-d_{0}\right)\right\}$ and $\Gamma(\cdot)$ is the Gamma function. Using the Stirling formula we obtain that for large $j, \alpha_{j}\left(d_{0}\right) \sim j^{-d_{0}-1} / \Gamma\left(-d_{0}\right)$ (one refers to [BFGK13] for further details).

For all $\theta \in \Theta$ we define $\left(\epsilon_{t}(\theta)\right)_{t \in \mathbb{Z}}$ as the second order stationary process which is the solution of

$$
\begin{equation*}
\epsilon_{t}(\theta)=\sum_{j \geq 0} \alpha_{j}(d) X_{t-j}-\sum_{i=1}^{p} \theta_{i} \sum_{j \geq 0} \alpha_{j}(d) X_{t-i-j}+\sum_{j=1}^{q} \theta_{p+j} \epsilon_{t-j}(\theta) \tag{2}
\end{equation*}
$$

Observe that, for all $t \in \mathbb{Z}, \epsilon_{t}\left(\theta_{0}\right)=\epsilon_{t}$ a.s. Given a realization $X_{1}, \ldots, X_{n}$ of length $n, \epsilon_{t}(\theta)$ can be approximated, for $0<t \leq n$, by $\tilde{\epsilon}_{t}(\theta)$ defined recursively by

$$
\begin{equation*}
\tilde{\epsilon}_{t}(\theta)=\sum_{j=0}^{t-1} \alpha_{j}(d) X_{t-j}-\sum_{i=1}^{p} \theta_{i} \sum_{j=0}^{t-i-1} \alpha_{j}(d) X_{t-i-j}+\sum_{j=1}^{q} \theta_{p+j} \tilde{\epsilon}_{t-j}(\theta), \tag{3}
\end{equation*}
$$

with $\tilde{\epsilon}_{t}(\theta)=X_{t}=0$ if $t \leq 0$. It will be shown that these initial values are asymptotically negligible and, in particular, that $\epsilon_{t}(\theta)-\tilde{\epsilon}_{t}(\theta) \rightarrow 0$ in $\mathbb{L}^{2}$ as $t \rightarrow \infty$ (see Remark 4 hereafter). Thus the choice of the initial values has no influence on the asymptotic properties of the model parameters estimator.

Let $\Theta_{\delta}^{*}$ denote the compact set

$$
\Theta_{\delta}^{*}=\left\{\theta \in \mathbb{R}^{p+q} ; \text { the roots of the polynomials } a_{\theta}(z) \text { and } b_{\theta}(z) \text { have modulus } \geq 1+\delta\right\} .
$$

We define the set $\Theta_{\delta}$ as the cartesian product of $\Theta_{\delta}^{*}$ by $\left[d_{1}, d_{2}\right]$, i.e. $\Theta_{\delta}=\Theta_{\delta}^{*} \times\left[d_{1}, d_{2}\right]$, where $\delta$ is a positive constant chosen such that $\theta_{0}$ belongs to $\Theta_{\delta}$.

The random variable $\hat{\theta}_{n}$ is called least squares estimator if it satisfies, almost surely,

$$
\begin{equation*}
\hat{\theta}_{n}=\underset{\theta \in \Theta_{\delta}}{\operatorname{argmin}} Q_{n}(\theta), \text { where } Q_{n}(\theta)=\frac{1}{n} \sum_{t=1}^{n} \tilde{\epsilon}_{t}^{2}(\theta) \tag{4}
\end{equation*}
$$

Our main results are proven under the following assumptions:
(A2): The process $\left(\epsilon_{t}\right)_{t \in \mathbb{Z}}$ is strictly stationary and ergodic.
The consistency of the least squares estimator will be proved under the three above assumptions ((A0), (A1) and (A2)). For the asymptotic normality of the LSE, additional assumptions are required. It is necessary to assume that $\theta_{0}$ is not on the boundary of the parameter space $\Theta_{\delta}$.
(A3): We have $\theta_{0} \in \stackrel{\circ}{\Theta}_{\delta}$, where $\stackrel{\circ}{\Theta}_{\delta}$ denotes the interior of $\Theta_{\delta}$.
The stationary process $\epsilon$ is not supposed to be an independent sequence. So one needs to control its dependency by means of its strong mixing coefficients $\left\{\alpha_{\epsilon}(h)\right\}_{h \geq 0}$ defined by

\alpha_{\epsilon}(h)=\sup _{A \in \mathcal{F}_{-\infty}^{t}, B \in \mathcal{F}_{t+h}^{+\infty}}|\mathbb{P}(A \cap B)-\mathbb{P}(A) \mathbb{P}(B)|,
$$

where $\mathcal{F}_{-\infty}^{t}=\sigma\left(\epsilon_{u}, u \leq t\right)$ and $\mathcal{F}_{t+h}^{+\infty}=\sigma\left(\epsilon_{u}, u \geq t+h\right)$.
We shall need an integrability assumption on the moments of the noise $\epsilon$ and a summability condition on the strong mixing coefficients $\left(\alpha_{\epsilon}(h)\right)_{h \geq 0}$.
(A4): $\quad$ There exists an integer $\tau$ such that for some $\nu \in] 0,1]$, we have $\mathbb{E}\left|\epsilon_{t}\right|^{\tau+\nu}<\infty$ and $\sum_{h=0}^{\infty}(h+1)^{k-2}\left\{\alpha_{\epsilon}(h)\right\}^{\frac{\nu}{k+\nu}}<\infty$ for $k=1, \ldots, \tau$.
Note that (A4) implies the following weak assumption on the joint cumulants of the innovation process $\epsilon$ (see [DL89], for more details).
(A4'): There exists an integer $\tau \geq 2$ such that $C_{\tau}:=\sum_{i_{1}, \ldots, i_{\tau-1} \in \mathbb{Z}}\left|\operatorname{cum}\left(\epsilon_{0}, \epsilon_{i_{1}}, \ldots, \epsilon_{i_{\tau-1}}\right)\right|<\infty$. In the above expression, $\operatorname{cum}\left(\epsilon_{0}, \epsilon_{i_{1}}, \ldots, \epsilon_{i_{\tau-1}}\right)$ denotes the $\tau$-th order cumulant of the stationary process. Due to the fact that the $\epsilon_{t}$ 's are centered, we notice that for fixed $(i, j, k)$

$$
\operatorname{cum}\left(\epsilon_{0}, \epsilon_{i}, \epsilon_{j}, \epsilon_{k}\right)=\mathbb{E}\left[\epsilon_{0} \epsilon_{i} \epsilon_{j} \epsilon_{k}\right]-\mathbb{E}\left[\epsilon_{0} \epsilon_{i}\right] \mathbb{E}\left[\epsilon_{j} \epsilon_{k}\right]-\mathbb{E}\left[\epsilon_{0} \epsilon_{j}\right] \mathbb{E}\left[\epsilon_{i} \epsilon_{k}\right]-\mathbb{E}\left[\epsilon_{0} \epsilon_{k}\right] \mathbb{E}\left[\epsilon_{i} \epsilon_{j}\right]
$$

Assumption (A4) is a usual technical hypothesis which is useful when one proves the asymptotic normality (see [FZ98] for example). Let us notice however that we impose a stronger convergence speed for the mixing coefficients than in the works on weak ARMA processes. This is due to the fact that the coefficients in the AR or MA representation of $\epsilon_{t}(\theta)$ have no more exponential decay because of the fractional operator (see Subsection 6.1 for details and comments).

As mentioned before, Hypothesis (A4) implies (A4') which is also a technical assumption usually used in the fractionally integrated ARMA processes framework (see for instance [Sha10c]) or even in an ARMA context (see [FZ07, ZL15]). One remarks that in [Sha10b], the author emphasized that a geometric moment contraction implies (A4'). This provides an alternative to strong mixing assumptions but, to our knowledge, there is no relation between this two kinds of hypotheses.

### 2.2. Asymptotic properties

The asymptotic properties of the LSE of the weak FARIMA model are stated in the following two theorems.
Theorem 1. (Consistency). Assume that $\left(\epsilon_{t}\right)_{t \in \mathbb{Z}}$ satisfies (1) and belonging to $\mathbb{L}^{2}$. Let $\left(\hat{\theta}_{n}\right)_{n \geq 1}$ be a sequence of least squares estimators. Under Assumptions (A0), (A1) and (A2), we have

$$
\hat{\theta}_{n} \xrightarrow[n \rightarrow \infty]{\mathbb{P}} \theta_{0} .
$$

The proof of this theorem is given in Subsection 6.2.
In order to state our asymptotic normality result, we define the function

$$
\begin{equation*}
O_{n}(\theta)=\frac{1}{n} \sum_{t=1}^{n} \epsilon_{t}^{2}(\theta) \tag{5}
\end{equation*}
$$

where the sequence $\left(\epsilon_{t}(\theta)\right)_{t \in \mathbb{Z}}$ is given by (2). We consider the following information matrices

$$
I(\theta)=\lim _{n \rightarrow \infty} \operatorname{Var}\left\{\sqrt{n} \frac{\partial}{\partial \theta} O_{n}(\theta)\right\} \text { and } J(\theta)=\lim _{n \rightarrow \infty}\left[\frac{\partial^{2}}{\partial \theta_{i} \partial \theta_{j}} O_{n}(\theta)\right] \text { a.s. }
$$

The existence of these matrices are proved when one demonstrates the following result.
Theorem 2. (Asymptotic normality). We assume that $\left(\epsilon_{t}\right)_{t \in \mathbb{Z}}$ satisfies (1). Under (AO)-(A3) and Assumption (A4) with $\tau=4$, the sequence $\left(\sqrt{n}\left(\hat{\theta}_{n}-\theta_{0}\right)\right)_{n \geq 1}$ has a limiting centered normal distribution with covariance matrix $\Omega:=J^{-1}\left(\theta_{0}\right) /\left(\theta_{0}\right) J^{-1}\left(\theta_{0}\right)$.

The proof of this theorem is given in Subsection 6.3.
Remark 1. Hereafter (see more precisely (55)), we will be able to prove that

$$
J\left(\theta_{0}\right)=2 \mathbb{E}\left[\frac{\partial}{\partial \theta} \epsilon_{t}\left(\theta_{0}\right) \frac{\partial}{\partial \theta^{\prime}} \epsilon_{t}\left(\theta_{0}\right)\right] \text { a.s. }
$$

Thus the matrix $J\left(\theta_{0}\right)$ has the same expression in the strong and weak FARIMA cases (see Theorem 1 of [Ber95]). On the contrary, the matrix $I\left(\theta_{0}\right)$ is in general much more complicated in the weak case than in the strong case.
Remark 2. In the standard strong FARIMA case, i.e. when (A2) is replaced by the assumption that $\left(\epsilon_{t}\right)_{t \in \mathbb{Z}}$ is iid, we have $I\left(\theta_{0}\right)=2 \sigma_{\epsilon}^{2} J\left(\theta_{0}\right)$. Thus the asymptotic covariance matrix is then reduced as $\Omega_{S}:=2 \sigma_{\epsilon}^{2} J^{-1}\left(\theta_{0}\right)$. Generally, when the noise is not an independent sequence, this simplification can not be made and we have $I\left(\theta_{0}\right) \neq 2 \sigma_{\epsilon}^{2} J\left(\theta_{0}\right)$. The true asymptotic covariance matrix $\Omega=J^{-1}\left(\theta_{0}\right) I\left(\theta_{0}\right) J^{-1}\left(\theta_{0}\right)$ obtained in the weak FARIMA framework can be very different from $\Omega_{S}$. As a consequence, for the statistical inference on the parameter, the ready-made softwares used to fit FARIMA do not provide a correct estimation of $\Omega$ for weak FARIMA processes because the standard time series analysis softwares use empirical estimators of $\Omega_{S}$. The problem also holds in the weak ARMA case (see [FZO7] and the references therein). This is why it is interesting to find an estimator of $\Omega$ which is consistent for both weak and (semi-)strong FARIMA cases.

Based on the above remark, the next section deals with two different methods in order to find an estimator of $\Omega$.

## 3. Estimating the asymptotic variance matrix

For statistical inference problem, the asymptotic variance $\Omega$ has to be estimated. In particular Theorem 2 can be used to obtain confidence intervals and significance tests for the parameters.

First of all, the matrix $J\left(\theta_{0}\right)$ can be estimated empirically by the square matrix $\hat{J}_{n}$ of order $p+q+1$ defined by:

$$
\begin{equation*}
\hat{\jmath}_{n}=\frac{2}{n} \sum_{t=1}^{n}\left\{\frac{\partial}{\partial \theta} \tilde{\epsilon}_{t}\left(\hat{\theta}_{n}\right)\right\}\left\{\frac{\partial}{\partial \theta^{\prime}} \tilde{\epsilon}_{t}\left(\hat{\theta}_{n}\right)\right\} \tag{6}
\end{equation*}
$$

The convergence of $\hat{\jmath}_{n}$ to $J\left(\theta_{0}\right)$ is classical (see Lemma 6 in Subsection 6.3 for details).
In the standard strong FARIMA case, in view of remark 2 , we have $\hat{\Omega}_{S}:=2 \hat{\sigma}_{\epsilon}^{2} \hat{\jmath}_{n}^{-1}$ with $\hat{\sigma}_{\epsilon}^{2}=$ $Q_{n}\left(\hat{\theta}_{n}\right)$. Thus $\hat{\Omega}_{S}$ is a consistent estimator of $\Omega_{S}$. In the general weak FARIMA case, this estimator is not consistent when $I\left(\theta_{0}\right) \neq 2 \sigma_{\epsilon}^{2} J\left(\theta_{0}\right)$. So we need a consistent estimator of $I\left(\theta_{0}\right)$.

### 3.1. Estimation of the asymptotic matrix $I\left(\theta_{0}\right)$

For all $t \in \mathbb{Z}$, let

$$
\begin{equation*}
H_{t}\left(\theta_{0}\right)=2 \epsilon_{t}\left(\theta_{0}\right) \frac{\partial}{\partial \theta} \epsilon_{t}\left(\theta_{0}\right)=\left(2 \epsilon_{t}\left(\theta_{0}\right) \frac{\partial}{\partial \theta_{1}} \epsilon_{t}\left(\theta_{0}\right), \ldots, 2 \epsilon_{t}\left(\theta_{0}\right) \frac{\partial}{\partial \theta_{p+q+1}} \epsilon_{t}\left(\theta_{0}\right)\right)^{\prime} \tag{7}
\end{equation*}
$$

We shall see in the proof of Lemma 7 that

$$
I\left(\theta_{0}\right)=\lim _{n \rightarrow \infty} \operatorname{Var}\left(\frac{1}{\sqrt{n}} \sum_{t=1}^{n} H_{t}\left(\theta_{0}\right)\right)=\sum_{h=-\infty}^{+\infty} \operatorname{Cov}\left(H_{t}\left(\theta_{0}\right), H_{t-h}\left(\theta_{0}\right)\right)
$$

Following the arguments developed in [BMCF12], the matrix $I\left(\theta_{0}\right)$ can be estimated using Berk's approach (see [Ber74]). More precisely, by interpreting $I\left(\theta_{0}\right) / 2 \pi$ as the spectral density of the stationary process $\left(H_{t}\left(\theta_{0}\right)\right)_{t \in \mathbb{Z}}$ evaluated at frequency 0 , we can use a parametric autoregressive estimate of the spectral density of $\left(H_{t}\left(\theta_{0}\right)\right)_{t \in \mathbb{Z}}$ in order to estimate the matrix $I\left(\theta_{0}\right)$.

For any $\theta \in \Theta, H_{t}(\theta)$ is a measurable function of $\left\{\epsilon_{s}, s \leq t\right\}$. The stationary process $\left(H_{t}\left(\theta_{0}\right)\right)_{t \in \mathbb{Z}}$ admits the following Wold decomposition $H_{t}\left(\theta_{0}\right)=u_{t}+\sum_{k=1}^{\infty} \psi_{k} u_{t-k}$, where $\left(u_{t}\right)_{t \in \mathbb{Z}}$ is a $(p+$ $q+1)$-variate weak white noise with variance matrix $\Sigma_{u}$.

Assume that $\Sigma_{u}$ is non-singular, that $\sum_{k=1}^{\infty}\left\|\psi_{k}\right\|<\infty$, and that $\operatorname{det}\left(I_{p+q+1}+\sum_{k=1}^{\infty} \psi_{k} z^{k}\right) \neq 0$ if $|z| \leq 1$. Then $\left(H_{t}\left(\theta_{0}\right)\right)_{t \in \mathbb{Z}}$ admits a weak multivariate $\operatorname{AR}(\infty)$ representation (see [Aku57]) of the form

$$
\begin{equation*}
\Phi(L) H_{t}\left(\theta_{0}\right):=H_{t}\left(\theta_{0}\right)-\sum_{k=1}^{\infty} \Phi_{k} H_{t-k}\left(\theta_{0}\right)=u_{t}, \tag{8}
\end{equation*}
$$

such that $\sum_{k=1}^{\infty}\left\|\Phi_{k}\right\|<\infty$ and $\operatorname{det}\{\Phi(z)\} \neq 0$ if $|z| \leq 1$.
Thanks to the previous remarks, the estimation of $I\left(\theta_{0}\right)$ is therefore based on the following expression

$$
I\left(\theta_{0}\right)=\phi^{-1}(1) \Sigma_{u} \phi^{-1}(1)
$$

Consider the regression of $H_{t}\left(\theta_{0}\right)$ on $H_{t-1}\left(\theta_{0}\right), \ldots, H_{t-r}\left(\theta_{0}\right)$ defined by

$$
\begin{equation*}
H_{t}\left(\theta_{0}\right)=\sum_{k=1}^{r} \phi_{r, k} H_{t-k}\left(\theta_{0}\right)+u_{r, t}, \tag{9}
\end{equation*}
$$

where $u_{r, t}$ is uncorrelated with $H_{t-1}\left(\theta_{0}\right), \ldots, H_{t-r}\left(\theta_{0}\right)$. Since $H_{t}\left(\theta_{0}\right)$ is not observable, we introduce $\hat{H}_{t} \in \mathbb{R}^{p+q+1}$ obtained by replacing $\epsilon_{t}(\cdot)$ by $\tilde{\epsilon}_{t}(\cdot)$ and $\theta_{0}$ by $\hat{\theta}_{n}$ in (7):

\hat{H}_{t}=2 \tilde{\epsilon}_{t}\left(\hat{\theta}_{n}\right) \frac{\partial}{\partial \theta} \hat{\epsilon}_{t}\left(\theta_{n}\right) \tag{10}
\end{equation*}

Let $\hat{\phi}_{r}(z)=I_{p+q+1}-\sum_{k=1}^{r} \hat{\phi}_{r, k} z^{k}$, where $\hat{\phi}_{r, 1}, \ldots, \hat{\phi}_{r, r}$ denote the coefficients of the LS regression of $\hat{H}_{t}$ on $\hat{H}_{t-1}, \ldots, \hat{H}_{t-r}$. Let $\hat{u}_{r, t}$ be the residuals of this regression and let $\hat{\Sigma}_{\hat{u}_{r}}$ be the empirical variance (defined in (11) below) of $\hat{u}_{r, 1}, \ldots, \hat{u}_{r, r}$. The LSE of $\underline{\Phi}_{r}=\left(\Phi_{r, 1}, \ldots, \Phi_{r, r}\right)$ and $\Sigma_{u_{r}}=\operatorname{Var}\left(u_{r, t}\right)$ are given by

$$
\begin{equation*}
\hat{\underline{\phi}}_{r}=\hat{\Sigma}_{\hat{H}, \hat{\hat{H}}_{r}} \hat{\Sigma}_{\underline{\hat{H}}_{r}}^{-1} \text { and } \hat{\Sigma}_{\hat{u}_{r}}=\frac{1}{n} \sum_{t=1}^{n}\left(\hat{H}_{t}-\hat{\underline{\phi}}_{r} \underline{\hat{H}}_{r, t}\right)\left(\hat{H}_{t}-\underline{\hat{\phi}}_{r} \hat{\hat{H}}_{r, t}\right)^{\prime} \tag{11}
\end{equation*}
$$

where

$$
\hat{\hat{H}}_{r, t}=\left(\hat{H}_{t-1}^{\prime}, \ldots, \hat{H}_{t-r}^{\prime}\right)^{\prime}, \quad \hat{\Sigma}_{\hat{H}, \hat{\hat{H}}_{r}}=\frac{1}{n} \sum_{t=1}^{n} \hat{H}_{t} \underline{\hat{H}}_{r, t}^{\prime} \text { and } \hat{\Sigma}_{\hat{H}_{r}}=\frac{1}{n} \sum_{t=1}^{n} \underline{\hat{H}}_{r, t} \hat{\hat{H}}_{r, t}^{\prime},
$$

with by convention $\hat{H}_{t}=0$ when $t \leq 0$. We assume that $\hat{\Sigma}_{\hat{H}_{r}}$ is non-singular (which holds true asymptotically).

In the case of linear processes with independent innovations, Berk (see [Ber74]) has shown that the spectral density can be consistently estimated by fitting autoregressive models of order $r=r(n)$, whenever $r$ tends to infinity and $r^{3} / n$ tends to 0 as $n$ tends to infinity. There are differences with [Ber74]: $\left(H_{t}\left(\theta_{0}\right)\right)_{t \in \mathbb{Z}}$ is multivariate, is not directly observed and is replaced by $\left(\hat{H}_{t}\right)_{t \in \mathbb{Z}}$. It is shown that this result remains valid for the multivariate linear process $\left(H_{t}\left(\theta_{0}\right)\right)_{t \in \mathbb{Z}}$ with non-independent innovations (see [BMCF12, BMF11], for references in weak (multivariate) ARMA models). We will extend the results of [BMCF12] to weak FARIMA models.

The asymptotic study of the estimator of $I\left(\theta_{0}\right)$ using the spectral density method is given in the following theorem.
Theorem 3. We assume (AO)-(A3) and Assumption (A4') with $\tau=8$. In addition, we assume that the innovation process $\left(\epsilon_{t}\right)_{t \in \mathbb{Z}}$ of the $\operatorname{FARIMA}\left(p, d_{0}, q\right)$ model (1) is such that the process $\left(H_{t}\left(\theta_{0}\right)\right)_{t \in \mathbb{Z}}$ defined in (7) admits a multivariate $A R(\infty)$ representation (8), where $\left\|\Phi_{k}\right\|=\mathrm{o}\left(k^{-2}\right)$ as $k \rightarrow \infty$, the roots of $\operatorname{det}(\Phi(z))=0$ are outside the unit disk, and $\Sigma_{u}=\operatorname{Var}\left(u_{t}\right)$ is non-singular. Then, the spectral estimator of $I\left(\theta_{0}\right)$

$$
\hat{I}_{n}^{\mathrm{SP}}:=\hat{\Phi}_{r}^{-1}(1) \hat{\Sigma}_{\hat{u}_{r}} \hat{\Phi}_{r}^{\prime-1}(1) \rightarrow I\left(\theta_{0}\right)=\phi^{-1}(1) \Sigma_{u} \phi^{-1}(1)
$$

in probability when $r=r(n) \rightarrow \infty$ and $r^{5}(n) / n^{1-2\left(d_{0}-d_{1}\right)} \rightarrow 0$ as $n \rightarrow \infty$ (remind that $d_{0} \in$ $\left.\left[d_{1}, d_{2}\right] \subset\right]-1 / 2,1 / 2[)$.

The proof of this theorem is given in Subsection 6.4.
A second method to estimate the asymptotic matrix (or rather avoiding estimate it) is proposed in the next subsection.

### 3.2. A self-normalized approach to confidence interval construction in weak FARIMA models

We have seen previously that we may obtain confidence intervals for weak FARIMA model parameters as soon as we can construct a convergent estimator of the variance matrix $I\left(\theta_{0}\right)$ (see Theorems

2 and 3). The parametric approach based on an autoregressive estimate of the spectral density of $\left(H_{t}\left(\theta_{0}\right)\right)_{t \in \mathbb{Z}}$ that we used before has the drawback of choosing the truncation parameter $r$ in (9). This choice of the order truncation is often crucial and difficult. So the aim of this section is to avoid such a difficulty.

This section is also of interest because, to our knowledge, it has not been studied for weak FARIMA models. Notable exception is [Sha12] who studied this problem in a short memory case (see Assumption 1 in [Sha12] that implies that the process $X$ is short-range dependent).

We propose an alternative method to obtain confidence intervals for weak FARIMA models by avoiding the estimation of the asymptotic covariance matrix $I\left(\theta_{0}\right)$. It is based on a self-normalization approach used to build a statistic which depends on the true parameter $\theta_{0}$ and which is asymptotically distribution-free (see Theorem 1 of [Sha12] for a reference in weak ARMA case). The idea comes from [Lob01] and has been already extended by [BMS18, KL06, Sha10c, Sha10a, Sha12] to more general frameworks. See also [Sha15] for a review on some recent developments on the inference of time series data using the self-normalized approach.

Let us briefly explain the idea of the self-normalization.
By a Taylor expansion of the function $\partial Q_{n}(\cdot) / \partial \theta$ around $\theta_{0}$, under (A3), we have

$$
\begin{equation*}
0=\sqrt{n} \frac{\partial}{\partial \theta} Q_{n}\left(\hat{\theta}_{n}\right)=\sqrt{n} \frac{\partial}{\partial \theta} Q_{n}\left(\theta_{0}\right)+\left[\frac{\partial^{2}}{\partial \theta_{i} \partial \theta_{j}} Q_{n}\left(\theta_{n, i, j}^{*}\right)\right] \sqrt{n}\left(\hat{\theta}_{n}-\theta_{0}\right) \tag{12}
\end{equation*}
$$

where the $\theta_{n, i, j}^{*}$ 's are between $\hat{\theta}_{n}$ and $\theta_{0}$. Using the following equation
$\sqrt{n}\left(\frac{\partial}{\partial \theta} O_{n}\left(\theta_{0}\right)-\frac{\partial}{\partial \theta} Q_{n}\left(\theta_{0}\right)\right)=\sqrt{n} \frac{\partial}{\partial \theta} O_{n}\left(\theta_{0}\right)+\left\{\left[\frac{\partial^{2}}{\partial \theta_{i} \partial \theta_{j}} Q_{n}\left(\theta_{n, i, j}^{*}\right)\right]-J\left(\theta_{0}\right)+J\left(\theta_{0}\right)\right\} \sqrt{n}\left(\hat{\theta}_{n}-\theta_{0}\right)$,
we shall be able to prove that (12) implies that

$$
\begin{equation*}
\sqrt{n} \frac{\partial}{\partial \theta} O_{n}\left(\theta_{0}\right)+J\left(\theta_{0}\right) \sqrt{n}\left(\hat{\theta}_{n}-\theta_{0}\right)=\mathrm{o}_{\mathbb{P}}(1) \tag{13}
\end{equation*}
$$

This is due to the following technical properties:

- the convergence in probability of $\sqrt{n} \partial Q_{n}\left(\theta_{0}\right) / \partial \theta-\sqrt{n} \partial O_{n}\left(\theta_{0}\right) / \partial \theta$ to 0 (see Lemma 4 hereafter),
- the convergence in probability of $\left[\partial^{2} Q_{n}\left(\theta_{n, i, j}^{*}\right) / \partial \theta_{i} \partial \theta_{j}\right]$ to $J\left(\theta_{0}\right)$ (see Lemma 6 hereafter),
- the tightness of the sequence $\left(\sqrt{n}\left(\hat{\theta}_{n}-\theta_{0}\right)\right)_{n \geq 1}$ (see Theorem 2) and
- the existence and invertibility of the matrix $J\left(\theta_{0}\right)$ (see Lemma 5 hereafter).

Thus we obtain from (13) that

$$
\sqrt{n}\left(\hat{\theta}_{n}-\theta_{0}\right)=\frac{1}{\sqrt{n}} \sum_{t=1}^{n} U_{t}+o_{\mathbb{P}}(1)
$$

where (remind (7))

$$
U_{t}=-J^{-1}\left(\theta_{0}\right) H_{t}\left(\theta_{0}\right)
$$

At this stage, we do not rely on the classical method that would consist in estimating the asymptotic covariance matrix $I\left(\theta_{0}\right)$. We rather try to apply Lemma 1 in [Lob01]. So we need to check that a
functional central limit theorem holds for the process $U:=\left(U_{t}\right)_{t \geq 1}$. For that sake, we define the normalization matrix $P_{p+q+1, n}$ of $\mathbb{R}^{(p+q+1) \times(p+q+1)}$ by

$$
\begin{equation*}
P_{p+q+1, n}=\frac{1}{n^{2}} \sum_{t=1}^{n}\left(\sum_{j=1}^{t}\left(U_{j}-\bar{U}_{n}\right)\right)\left(\sum_{j=1}^{t}\left(U_{j}-\bar{U}_{n}\right)\right)^{\prime}, \tag{14}
\end{equation*}
$$

where $\bar{U}_{n}=(1 / n) \sum_{i=1}^{n} U_{i}$. To ensure the invertibility of the normalization matrix $P_{p+q+1, n}$ (it is the result stated in the next proposition), we need the following technical assumption on the distribution of $\epsilon_{t}$.
(A5): The process $\left(\epsilon_{t}\right)_{t \in \mathbb{Z}}$ has a positive density on some neighborhood of zero.
Proposition 4. Under the assumptions of Theorem 2 and (A5), the matrix $P_{p+q+1, n}$ is almost surely non singular.
The proof of this proposition is given in Subsection 6.5.
Let $\left(B_{m}(r)\right)_{r \geq 0}$ be a $m$-dimensional Brownian motion starting from 0 . For $m \geq 1$, we denote by $\mathcal{U}_{m}$ the random variable defined by:

\begin{equation*}
\mathcal{U}_{m}=B_{m}^{\prime}(1) V_{m}^{-1} B_{m}(1) \tag{15}
\end{equation*}
$$

where

$$
\begin{equation*}
V_{m}=\int_{0}^{1}\left(B_{m}(r)-r B_{m}(1)\right)\left(B_{m}(r)-r B_{m}(1)\right)^{\prime} d r \tag{16}
\end{equation*}
$$

The critical values of $\mathcal{U}_{m}$ have been tabulated by [Lob01].
The following theorem states the self-normalized asymptotic distribution of the random vector $\sqrt{n}\left(\hat{\theta}_{n}-\theta_{0}\right)$.
Theorem 5. Under the assumptions of Theorem 2 and (A5), we have

$$
n\left(\hat{\theta}_{n}-\theta_{0}\right)^{\prime} P_{p+q+1, n}^{-1}\left(\hat{\theta}_{n}-\theta_{0}\right) \xrightarrow[n \rightarrow \infty]{\text { in law }} \mathcal{U}_{p+q+1}
$$

The proof of this theorem is given in Subsection 6.6.
Of course, the above theorem is useless for practical purpose because the normalization matrix $P_{p+q+1, n}$ is not observable. This gap will be fixed below when one replaces the matrix $P_{p+q+1, n}$ by its empirical or observable counterpart

$$
\begin{equation*}
\hat{P}_{p+q+1, n}=\frac{1}{n^{2}} \sum_{t=1}^{n}\left(\sum_{j=1}^{t}\left(\hat{U}_{j}-\frac{1}{n} \sum_{k=1}^{n} \hat{U}_{k}\right)\right)\left(\sum_{j=1}^{t}\left(\hat{U}_{j}-\frac{1}{n} \sum_{k=1}^{n} \hat{U}_{k}\right)\right)^{\prime} \text { where } \hat{U}_{j}=-\hat{J}_{n}^{-1} \hat{H}_{j} . \tag{17}
\end{equation*}
$$

The above quantity is observable and we are able to state our Theorem which is the applicable version of Theorem 5.
Theorem 6. Under the assumptions of Theorem 2 and (A5), we have

$$
n\left(\hat{\theta}_{n}-\theta_{0}\right)^{\prime} \hat{P}_{p+q+1, n}^{-1}\left(\hat{\theta}_{n}-\theta_{0}\right) \xrightarrow[n \rightarrow \infty]{\text { in law }} \mathcal{U}_{p+q+1}
$$

The proof of this theorem is given in Subsection 6.7.
At the asymptotic level $\alpha$, a joint $100(1-\alpha) \%$ confidence region for the elements of $\theta_{0}$ is then given by the set of values of the vector $\theta$ which satisfy the following inequality:

$$
n\left(\hat{\theta}_{n}-\theta\right)^{\prime} \hat{P}_{p+q+1, n}^{-1}\left(\hat{\theta}_{n}-\theta\right) \leq \mathcal{U}_{p+q+1, \alpha}
$$

where $\mathcal{U}_{p+q+1, \alpha}$ is the quantile of order $1-\alpha$ for the distribution of $\mathcal{U}_{p+q+1}$.
Corollary 7. For any $1 \leq i \leq p+q+1$, a $100(1-\alpha) \%$ confidence region for $\theta_{0}(i)$ is given by the following set:

$$
\left\{x \in \mathbb{R} ; n\left(\hat{\theta}_{n}(i)-x\right)^{2} \hat{P}_{p+q+1, n}^{-1}(i, i) \leq \mathcal{U}_{1, \alpha}\right\}
$$

where $\mathcal{U}_{1, \alpha}$ denotes the quantile of order $1-\alpha$ of the distribution for $\mathcal{U}_{1}$.
The proof of this corollary is similar to that of Theorem 6 when one restricts ourselves to a one dimensional case.

## 4. Numerical illustrations

In this section, we investigate the finite sample properties of the asymptotic results that we introduced in this work. For that sake we use Monte Carlo experiments. The numerical illustrations of this section are made with the open source statistical software R (see R Development Core Team, 2017) or (see http://cran.r-project.org/).

### 4.1. Simulation studies and empirical sizes for confidence intervals

We study numerically the behavior of the LSE for FARIMA models of the form

$$
\begin{equation*}
(1-L)^{d}\left(X_{t}-a X_{t-1}\right)=\epsilon_{t}-b \epsilon_{t-1} \tag{18}
\end{equation*}
$$

where the unknown parameter is taken as $\theta_{0}=(a, b, d)=(-0.7,-0.2,0.4)$. First we assume that in (18) the innovation process $\left(\epsilon_{t}\right)_{t \in \mathbb{Z}}$ is an iid centered Gaussian process with common variance 1 which corresponds to the strong FARIMA case. In two other experiments we consider that in (18) the innovation processes $\left(\epsilon_{t}\right)_{t \in \mathbb{Z}}$ are defined respectively by

$$
\left\{\begin{array}{l}
\epsilon_{t}=\sigma_{t} \eta_{t}  \tag{19}\\
\sigma_{t}^{2}=0.04+0.12 \epsilon_{t-1}^{2}+0.85 \sigma_{t-1}^{2}
\end{array}\right.
$$

and

$$
\begin{equation*}
\epsilon_{t}=\eta_{t}^{2} \eta_{t-1} \tag{20}
\end{equation*}
$$

where $\left(\eta_{t}\right)_{t \geq 1}$ is a sequence of iid centered Gaussian random variables with variance 1 . Note that the innovation process in (20) is not a martingale difference whereas it is the case of the noise defined in (19).

We simulated $N=1,000$ independent trajectories of size $n=2,000$ of Model (18) in the three following case: the strong Gaussian noise, the semi-strong noise (19) and the weak noise (20).

Figure 1, Figure 2 and Figure 3 compare the distribution of the LSE in these three contexts. The distributions of $\hat{d}_{n}$ are similar in the three cases whereas the LSE $\hat{a}_{n}$ of $a$ is more accurate in the weak case than in the strong and semi-strong cases. The distributions of $\hat{b}_{n}$ are more accurate
in the strong case than in the weak case. Remark that in the weak case the distributions of $\hat{b}_{n}$ are more accurate to the semi-strong ones.

Figure 4 compares standard estimator $\hat{\Omega}_{S}=2 \hat{\sigma}_{\epsilon}^{2} \hat{J}_{n}^{-1}$ and the sandwich estimator $\hat{\Omega}=\hat{\jmath}_{n}^{-1} \hat{I}_{n}^{\mathrm{SP}} \hat{\jmath}_{n}^{-1}$ of the LSE asymptotic variance $\Omega$. We used the spectral estimator $\hat{I}_{n}^{S P}$ defined in Theorem 3. The multivariate AR order $r$ (see (9)) is automatically selected by AIC (we use the function VARselect () of the vars R package). In the strong FARIMA case we know that the two estimators are consistent. In view of the two upper subfigures of Figure 4, it seems that the sandwich estimator is less accurate in the strong case. This is not surprising because the sandwich estimator is more robust, in the sense that this estimator remains consistent in the semi-strong and weak FARIMA cases, contrary to the standard estimator (see the middle and bottom subfigures of Figure 4). Figure 5 (resp. Figure 6) presents a zoom of the left(right)-middle and left(right)-bottom panels of Figure 4. It is clear that in the semi-strong or weak case $n\left(\hat{a}_{n}-a\right)^{2}, n\left(\hat{b}_{n}-b\right)^{2}$ and $n\left(\hat{d}_{n}-d\right)^{2}$ are, respectively, better estimated by $\hat{\jmath}_{n}^{-1} \hat{I}_{n}^{S P} \hat{J}_{n}^{-1}(1,1), \hat{\jmath}_{n}^{-1} \hat{I}_{n}^{\mathrm{SP}} \hat{\jmath}_{n}^{-1}(2,2)$ and $\hat{\jmath}_{n}^{-1} \hat{I}_{n}^{\mathrm{SP}} \hat{\jmath}_{n}^{-1}(3,3)$ (see Figure 6) than by $2 \hat{\sigma}_{\epsilon}^{2} \hat{\jmath}_{n}^{-1}(1,1), 2 \hat{\sigma}_{\epsilon}^{2} \hat{\jmath}_{n}^{-1}(2,2)$ and $2 \hat{\sigma}_{\epsilon}^{2} \hat{\jmath}_{n}^{-1}(3,3)$ (see Figure 5). The failure of the standard estimator of $\Omega$ in the weak FARIMA framework may have important consequences in terms of identification or hypothesis testing and validation.

Now we are interested in standard confidence interval and the modified versions proposed in Subsections 3.1 and 3.2. Table 1 displays the empirical sizes in the three previous different FARIMA cases. For the nominal level $\alpha=5 \%$, the empirical size over the $N=1,000$ independent replications should vary between the significant limits $3.6 \%$ and $6.4 \%$ with probability $95 \%$. For the nominal level $\alpha=1 \%$, the significant limits are $0.3 \%$ and $1.7 \%$, and for the nominal level $\alpha=10 \%$, they are $8.1 \%$ and $11.9 \%$. When the relative rejection frequencies are outside the significant limits, they are displayed in bold type in Table 1. For the strong FARIMA model, all the relative rejection frequencies are inside the significant limits for $n$ large. For the semi-strong FARIMA model, the relative rejection frequencies of the standard confidence interval are definitely outside the significant limits, contrary to the modified versions proposed. For the weak FARIMA model, only the standard confidence interval of $\hat{b}_{n}$ is outside the significant limits when $n$ increases. As a conclusion, Table 1 confirms the comments done concerning Figure 4.

### 4.2. Application to real data

We now consider an application to the daily returns of four stock market indices (CAC, DAX, Nikkei and S\&P 500). The returns are defined by $r_{t}=\log \left(p_{t} / p_{t-1}\right)$ where $p_{t}$ denotes the price index of the stock market indices at time $t$. The observations cover the period from the starting date of each index to February 14, 2019.

In Financial Econometrics the returns are often assumed to be a white noise. In view of the so-called volatility clustering, it is well known that the strong white noise model is not adequate for these series (see for instance [FZ10, LNS01, BMCF12, BMS18]). A long-range memory property of the stock market returns series was largely investigated by [DGE93] which shown that there are more correlation between power transformation of the absolute return $\left|r_{t}\right|^{v}(v>0)$ than returns themselves (see also [BFGK13], [Pal07], [BCT96] and [LL97]). We choose here the case where $v=2$ which corresponds to the squared returns $\left(r_{t}^{2}\right)_{t \geq 1}$ process. This process have significant positive autocorrelations at least up to lag 100 (see Figure 9) which confirm the claim that stock market returns have long-term memory (see [DGE93]).

We fit a $\operatorname{FARIMA}(1, d, 1)$ model to the squares of the 4 daily returns. As in [Lin03], we denote
by $\left(X_{t}\right)_{t \geq 1}$ the mean corrected series of the squared returns and we adjust the following model

Figure 7 (resp. Figure 8) plots the closing prices (resp. the returns) of the four stock market indices. Figure 9 shows that squared returns $\left(X_{t}\right)_{t \geq 1}$ are generally strongly autocorrelated. Table 2 displays the LSE of the parameter $\theta=(a, b, d)$ of each squared of daily returns. The $p$-values of the corresponding LSE, $\hat{\theta}_{n}=\left(\hat{a}_{n}, \hat{b}_{n}, \hat{d}_{n}\right)$ are given in parentheses. The last column presents the estimated residual variance. Note that for all series, the estimated coefficients $\left|\hat{a}_{n}\right|$ and $\left|\hat{b}_{n}\right|$ are smaller than one and this is in accordance with our Assumption (A1). We also observe that for all series the estimated long-range dependence coefficients $\hat{d}_{n}$ are significant for any reasonable asymptotic level and are inside ] - 0.5,0.5[. We thus think that the assumption (A3) is satisfied and thus our asymptotic normality theorem can be applied. Table 3 then presents for each serie the modified confidence interval at the asymptotic level $\alpha=5 \%$ for the parameters estimated in Table 2.

## 5. Conclusion

Taking into account the possible lack of independence of the error terms, we show in this paper that we can fit FARIMA representations of a wide class of nonlinear long memory times series. This is possible thanks to our theoretical results and it is illustrated in our real cases and simulations studies.

This standard methodology (when the noise is supposed to be iid), in particular the significance tests on the parameters, needs however to be adapted to take into account the possible lack of independence of the errors terms. A first step has been done thanks to our results on the confidence intervals. In future works, we intent to study how the existing identification (see [BM12], [BMK16]) and diagnostic checking (see [BMS18], [FRZ05]) procedures should be adapted in the presence of long-range dependence framework and dependent noise.

## 6. Proofs

In all our proofs, $K$ is a positive constant that may vary from line to line.

### 6.1. Preliminary results

In this subsection, we shall give some results on estimations of the coefficient of formal power series that will arise in our study. Some of them are well know on some others are new to our knowledge. We will make some precise comments hereafter.

We begin by recalling the following properties on power series. If for $|z| \leq R$, the power series $f(z)=\sum_{i \geq 0} a_{i} z^{i}$ and $g(z)=\sum_{i \geq 0} b_{i} z^{i}$ are well defined, then one has $(f g)(z)=\sum_{i \geq 0} c_{i} z^{i}$ is also well defined for $|z| \leq R$ with the sequence $\left(c_{i}\right)_{i \geq 0}$ which is given by $c=a * b$ where $*$ denotes the convolution product between $a$ and $b$ defined by $c_{i}=\sum_{k=0}^{i} a_{k} b_{i-k}=\sum_{k=0}^{i} a_{i-k} b_{k}$. We will make use of the Young inequality that states that if the sequence $a \in \ell^{r_{1}}$ and $b \in \ell^{r_{2}}$ and such that $\frac{1}{r_{1}}+\frac{1}{r_{2}}=1+\frac{1}{r}$ with $1 \leq r_{1}, r_{2}, r \leq \infty$, then

Now we come back to the power series that arise in our context. Remind that for the true value of the parameter,

Thanks to the assumptions on the moving average polynomials $b_{\theta}$ and the autoregressive polynomials $a_{\theta}$, the power series $a_{\theta}^{-1}$ and $b_{\theta}^{-1}$ are well defined.

Thus the functions $\epsilon_{t}(\theta)$ defined in (2) can be written as

For large $j$, [HTSC99] have shown that uniformly in $\theta$ the sequences $\gamma(\theta)$ and $\eta(\theta)$ satisfy

One difficulty that has to be addressed is that (24) includes the infinite past $\left(X_{t-i}\right)_{i \geq 0}$ whereas only a finite number of observations $\left(X_{t}\right)_{1 \leq t \leq n}$ are available to compute the estimators defined in (4). The simplest solution is truncation which amounts to setting all unobserved values equal to zero. Thus, for all $\theta \in \Theta$ and $1 \leq t \leq n$ one defines

Since our assumptions are made on the noise in (1), it will be useful to express the random variables $\epsilon_{t}(\theta)$ and its partial derivatives with respect to $\theta$, as a function of $\left(\epsilon_{t-i}\right)_{i \geq 0}$.

From (23), there exists a sequence $\lambda(\theta)=\left(\lambda_{i}(\theta)\right)_{i \geq 0}$ such that

Equations (29) and (31) imply that for all $\theta \in \Theta$ the random variable $\epsilon_{t}(\theta)$ belongs to $\mathbb{L}^{2}$, that the sequence $\left(\epsilon_{t}(\theta)\right)_{t}$ is an ergodic sequence and that for all $t \in \mathbb{Z}$ the function $\epsilon_{t}(\cdot)$ is a continuous function. We proceed in the same way as regard to the derivatives of $\epsilon_{t}(\theta)$. More precisely, for any $\theta \in \Theta, t \in \mathbb{Z}$ and $1 \leq k, l \leq p+q+1$ there exists sequences $\dot{\lambda}_{k}(\theta)=\left(\dot{\lambda}_{i, k}(\theta)\right)_{i \geq 1}$ and $\ddot{\lambda}_{k, l}(\theta)=\left(\ddot{\lambda}_{i, k, l}(\theta)\right)_{i \geq 1}$ such that

Similarly we have

In order to handle the truncation error $\epsilon_{t}(\theta)-\tilde{\epsilon}_{t}(\theta)$, one needs information on the sequence $\lambda(\theta)-\lambda^{t}(\theta)$. This is the purpose of the following lemma.
Lemma 1. For $2 \leq r \leq \infty$ and $1 \leq k, l \leq p+q+1$, we have

If $d_{0}=0, \eta\left(\theta_{0}\right)$ is the sequence of coefficients of the power series $a_{\theta_{0}}^{-1}(z) b_{\theta_{0}}(z)$, so it belongs to $\ell^{r_{2}}$ for all $r_{2} \geq 1$ since in this case $\left|\eta_{j}\left(\theta_{0}\right)\right|=\mathrm{O}\left(\rho^{j}\right)$ for some $0<\rho<1$ (see [FZ98]). Thanks to (26), when $d_{0} \leq 0$, Young's inequality for convolution yields that for all $r \geq 2$

This is because from (26), the coefficients $\partial \gamma_{j}(\theta) / \partial \theta_{k}$ and $\partial^{2} \gamma_{j}(\theta) / \partial \theta_{k} \partial \theta_{\text {I }}$ are $\mathrm{O}\left(j^{-1-d+\zeta}\right)$ for any small enough $\zeta>0$. The proof of the lemma is then complete.

Remark 3. The above lemma implies that the sequence $\dot{\lambda}_{k}\left(\theta_{0}\right)-\dot{\lambda}^{t}{ }_{k}\left(\theta_{0}\right)$ is bounded and more precisely there exists $K$ such that

Proof. For $1 \leq k \leq p+q+1$, the sequence $\dot{\lambda}_{k}(\theta)=\left(\dot{\lambda}_{i, k}(\theta)\right)_{i \geq 1}$ is in fact the sequence of the coefficients in the power series of

\frac{\partial}{\partial \theta_{k}}\left(b_{\theta}^{-1}(z) a_{\theta}(z)(1-z)^{d-d_{0}} a_{\theta_{0}}^{-1}(z) b_{\theta_{0}}(z)\right)
$$

Thus $\dot{\lambda}_{i, k}\left(\theta_{0}\right)$ is the $i$-th coefficient taken in $\theta=\theta_{0}$. There are three cases.
$\diamond k=1, \ldots, p$ :
Since

$$
\frac{\partial}{\partial \theta_{k}}\left(b_{\theta}^{-1}(z) a_{\theta}(z)(1-z)^{d-d_{0}} a_{\theta_{0}}^{-1}(z) b_{\theta_{0}}(z)\right)=-b_{\theta}^{-1}(z) z^{k}(1-z)^{d-d_{0}} a_{\theta_{0}}^{-1}(z) b_{\theta_{0}}(z),
$$

we deduce that $\dot{\lambda}_{i, k}\left(\theta_{0}\right)$ is the $i$-th coefficient of $-z^{k} a_{\theta_{0}}^{-1}(z)$ which satisfies $\dot{\lambda}_{i, k}\left(\theta_{0}\right) \leq K \rho^{i}$ for some $0<\rho<1$ (see [FZ98] for example).
$\diamond k=p+1, \ldots, p+q$ :
We have

$$
\frac{\partial}{\partial \theta_{k}}\left(b_{\theta}^{-1}(z) a_{\theta}(z)(1-z)^{d-d_{0}} a_{\theta_{0}}(z) b_{\theta_{0}}(z)\right)=\left(\frac{\partial}{\partial \theta_{k}} b_{\theta}^{-1}(z)\right) a_{\theta}(z)(1-z)^{d-d_{0}} a_{\theta_{0}}^{-1}(z) b_{\theta_{0}}(z)
$$

and consequently $\dot{\lambda}_{i, k}\left(\theta_{0}\right)$ is the $i$-th coefficient of $\left(\frac{\partial}{\partial \theta_{k}} b_{\theta_{0}}^{-1}(z)\right) b_{\theta_{0}}(z)$ which also satisfies $\dot{\lambda}_{i, k}\left(\theta_{0}\right) \leq K \rho^{i}$ (see [FZ98]).
The last case will not be a consequence of the usual works on ARMA processes.
$\diamond k=p+q+1$ :
In this case, $\theta_{k}=d$ and so we have

\frac{\partial}{\partial \theta_{k}}\left(b_{\theta}^{-1}(z) a_{\theta}(z)(1-z)^{d-d_{0}} a_{\theta_{0}}^{-1}(z) b_{\theta_{0}}(z)\right)=b_{\theta}^{-1}(z) a_{\theta}(z) \ln (1-z)(1-z)^{d-d_{0}} a_{\theta_{0}}^{-1}(z) b_{\theta_{0}}(z)

and consequently $\dot{\lambda}_{i, k}\left(\theta_{0}\right)$ is the $i$-th coefficient of $\ln (1-z)$ which is equal to $-1 / i$.
The three above cases imply the expected result.

### 6.2. Proof of Theorem 1

Consider the random variable $\mathrm{W}_{n}(\theta)$ defined for any $\theta \in \Theta$ by

For $\beta>0$, let $S_{\beta}=\left\{\theta:\left\|\theta-\theta_{0}\right\| \leq \beta\right\}, \bar{S}_{\beta}=\left\{\theta \in \Theta_{\delta}\right.$ : $\left.\theta \notin S_{\beta}\right\}$. It can readily be shown that

\mathbb{P}\left(\left\|\hat{\theta}_{n}-\theta_{0}\right\|>\beta\right) & \leq \mathbb{P}\left(\hat{\theta}_{n} \in \bar{S}_{\beta}\right) \\
& \leq \mathbb{P}\left(\inf _{\theta \in \bar{S}_{\beta}}\left\{Q_{n}(\theta)-Q_{n}\left(\theta_{0}\right)\right\} \leq 0\right) \\
& \leq \mathbb{P}\left(\sup _{\theta \in \Theta_{\delta}}\left|\mathrm{W}_{n}(\theta)\right| \geq \inf _{\theta \in \bar{S}_{\beta}} \mathrm{V}(\theta)\right) \\
& \leq \mathbb{P}\left(\sup _{\theta \in \Theta_{\delta}}\left|Q_{n}(\theta)-\mathbb{E}\left[O_{n}(\theta)\right]\right| \geq \frac{1}{2} \inf _{\theta \in \bar{S}_{\beta}} \mathrm{V}(\theta)\right) \tag{40}
\end{align*}
$$

Since $d_{1}-d_{0}>-1 / 2$, one has

$$
\begin{align*}
\sup _{\theta \in \Theta_{\delta}} \mathbb{E}\left[\epsilon_{t}^{2}(\theta)\right] & =\sup _{\theta \in \Theta_{\delta}} \sum_{i=0}^{\infty} \sum_{j=0}^{\infty} \lambda_{i}(\theta) \lambda_{j}(\theta) \mathbb{E}\left[\epsilon_{t-i} \epsilon_{t-j}\right]=\sigma_{\epsilon}^{2} \sup _{\theta \in \Theta_{\delta}} \sum_{i=0}^{\infty} \lambda_{i}^{2}(\theta) \\
& \leq \sigma_{\epsilon}^{2}+K \sigma_{\epsilon}^{2} \sum_{i=1}^{\infty} i^{-2-2\left(d_{1}-d_{0}\right)}<\infty . \tag{41}
\end{align*}
$$

We can therefore use the same arguments as those of [FZ98] to prove under (A1) and (A2) that for any $\bar{\theta} \in \Theta_{\delta} \backslash\left\{\theta_{0}\right\}$, there exists a neighbourhood $\mathrm{N}(\bar{\theta})$ of $\bar{\theta}$ such that $\mathrm{N}(\bar{\theta}) \subset \Theta_{\delta}$ and

Note that $\mathbb{E}\left[O_{n}\left(\theta_{0}\right)\right]=\sigma_{\epsilon}^{2}$. It follows from (42) that

for some positive constant $K$.
In view of (40), it is then sufficient to show that the random variable $\sup _{\theta \in \Theta_{\delta}}\left|Q_{n}(\theta)-\mathbb{E}\left[O_{n}(\theta)\right]\right|$
converges in probability to zero to prove Theorem 1. We use Corollary 2.2 of [New91] to obtain this uniform convergence in probability. The set $\Theta_{\delta}$ is compact and $\left(\mathbb{E}\left[O_{n}(\theta)\right]\right)_{n \geq 1}$ is a uniformly convergent sequence of continuous functions on a compact set so it is equicontinuous. We consequently need to show the following two points to complete the proof of the theorem:

- For each $\theta \in \Theta_{\delta}, Q_{n}(\theta)-\mathbb{E}\left[O_{n}(\theta)\right]=o_{\mathbb{P}}(1)$.
- There is $B_{n}$ and $h:[0, \infty) \rightarrow[0, \infty)$ with $h(0)=0$ and $h$ continuous at zero such that $B_{n}=\mathrm{O}_{\mathbb{P}}(1)$ and for all $\theta_{1}, \theta_{2} \in \Theta_{\delta},\left|Q_{n}\left(\theta_{1}\right)-Q_{n}\left(\theta_{2}\right)\right| \leq B_{n} h\left(\left\|\theta_{1}-\theta_{2}\right\|\right)$.
6.2.1. Pointwise convergence in probability of $Q_{n}(\theta)-\mathbb{E}\left[O_{n}(\theta)\right]$ to zero

For any $\theta \in \Theta_{\delta}$, Remark 4, the Cauchy-Schwarz inequality and (41) yield that

\mathbb{E}\left|Q_{n}(\theta)-O_{n}(\theta)\right| & \leq \frac{1}{n} \sum_{t=1}^{n} \mathbb{E}\left|\tilde{\epsilon}_{t}^{2}(\theta)-\epsilon_{t}^{2}(\theta)\right| \\
& \leq \frac{1}{n} \sum_{t=1}^{n} \mathbb{E}\left(\epsilon_{t}(\theta)-\tilde{\epsilon}_{t}(\theta)\right)^{2}+\frac{2}{n} \sum_{t=1}^{n} \mathbb{E}\left|\epsilon_{t}(\theta)-\tilde{\epsilon}_{t}(\theta)\right|\left|\epsilon_{t}(\theta)\right| \\
& \leq \frac{\sigma_{\epsilon}^{2}}{n} \sum_{t=1}^{n}\left\|\lambda_{i}(\theta)-\lambda_{i}^{t}(\theta)\right\|_{\ell^{2}}^{2}+\frac{2 \sigma_{\epsilon}}{n} \sum_{t=1}^{n}\left\|\lambda_{i}(\theta)-\lambda_{i}^{t}(\theta)\right\|_{\ell^{2}} \sqrt{\mathbb{E}\left[\epsilon_{t}^{2}(\theta)\right]} \\
& \leq \frac{\sigma_{\epsilon}^{2}}{n} \sum_{t=1}^{n} t^{-1-2\left(d_{1}-d_{0}\right)}+\frac{2 K \sigma_{\epsilon}}{n} \sum_{t=1}^{n} t^{-1 / 2-\left(d_{1}-d_{0}\right)} \xrightarrow[n \rightarrow \infty]{\longrightarrow} 0 . \tag{43}
\end{align*}
$$

We use the ergodic theorem and the continuous mapping theorem to obtain

\left|O_{n}(\theta)-\mathbb{E}\left[O_{n}(\theta)\right]\right| \xrightarrow[n \rightarrow \infty]{\text { a.s. }} 0 \tag{44}
\end{equation*}

Combining the results in (43) and (44), we deduce that for all $\theta \in \Theta_{\delta}$,

### 6.2.2. Tightness characterization

Observe that for any $\theta_{1}, \theta_{2} \in \Theta_{\delta}$, there exists $\theta^{\star}$ between $\theta_{1}$ and $\theta_{2}$ such that

$$

As before, the uncorrelatedness of the innovation process $\left(\epsilon_{t}\right)_{t \in \mathbb{Z}}$ and Remark 4 entail that

\mathbb{E}\left[\frac{1}{n} \sum_{t=1}^{n}\left\|\frac{\partial \tilde{\epsilon}_{t}^{2}\left(\theta^{\star}\right)}{\partial \theta}\right\|\right] \leq \mathbb{E}\left[\frac{2}{n} \sum_{t=1}^{n} \sum_{i=1}^{p+q+1}\left|\tilde{\epsilon}_{t}\left(\theta^{\star}\right) \frac{\partial \tilde{\epsilon}_{t}\left(\theta^{\star}\right)}{\partial \theta_{i}}\right|\right]<\infty .
$$

Thanks to Markov's inequality, we conclude that

The proof of Theorem 1 is then complete.

### 6.3. Proof of Theorem 2

where the $\theta_{n, i, j}^{*}$ 's are between $\hat{\theta}_{n}$ and $\theta_{0}$. The equation (45) can be rewritten in the form:

Under the assumptions of Theorem 2, it will be shown respectively in Lemma 4 and Lemma 6 that

\left[\frac{\partial^{2}}{\partial \theta_{i} \partial \theta_{j}} Q_{n}\left(\theta_{n, i, j}^{*}\right)\right]-J\left(\theta_{0}\right)=\mathrm{o}_{\mathbb{P}}(1) .
$$

As a consequence, the asymptotic normality of $\sqrt{n}\left(\hat{\theta}_{n}-\theta_{0}\right)$ will be a consequence of the one of $\sqrt{n} \partial / \partial \theta O_{n}\left(\theta_{0}\right)$.
Lemma 4. For $1 \leq k \leq p+q+1$, under the assumptions of Theorem 2, we have

\sqrt{n}\left(\frac{\partial}{\partial \theta_{k}} Q_{n}\left(\theta_{0}\right)-\frac{\partial}{\partial \theta_{k}} O_{n}\left(\theta_{0}\right)\right)=\mathrm{o}_{\mathbb{P}}(1) . \tag{47}

Proof. Throughout this proof, $\theta=\left(\theta_{1}, \ldots, \theta_{p+q}, d\right)^{\prime} \in \Theta_{\delta}$ is such that $\max \left(d_{0}, 0\right)<d \leq d_{2}$ where $d_{2}$ is the upper bound of the support of the long-range dependence parameter $d_{0}$.

The proof is quite long so we divide it in several steps.

## $\diamond$ Step 1: preliminaries

& +\frac{2}{\sqrt{n}} \sum_{t=1}^{n}\left(\epsilon_{t}(\theta)-\epsilon_{t}\left(\theta_{0}\right)\right) \frac{\partial}{\partial \theta_{k}} \tilde{\epsilon}_{t}\left(\theta_{0}\right)+\frac{2}{\sqrt{n}} \sum_{t=1}^{n} \epsilon_{t}\left(\theta_{0}\right)\left(\frac{\partial}{\partial \theta_{k}} \tilde{\epsilon}_{t}\left(\theta_{0}\right)-\frac{\partial}{\partial \theta_{k}} \epsilon_{t}\left(\theta_{0}\right)\right) \\
& +\frac{2}{\sqrt{n}} \sum_{t=1}^{n} \epsilon_{t}\left(\theta_{0}\right) \frac{\partial}{\partial \theta_{k}} \epsilon_{t}\left(\theta_{0}\right) \\
= & \Delta_{n, 1}^{k}(\theta)+\Delta_{n, 2}^{k}(\theta)+\Delta_{n, 3}^{k}(\theta)+\Delta_{n, 4}^{k}\left(\theta_{0}\right)+\sqrt{n} \frac{\partial}{\partial \theta_{k}} O_{n}\left(\theta_{0}\right), \tag{48}
\end{align*}
$$

where

$$
\begin{aligned}
& \Delta_{n, 1}^{k}(\theta)=\frac{2}{\sqrt{n}} \sum_{t=1}^{n}\left(\tilde{\epsilon}_{t}\left(\theta_{0}\right)-\tilde{\epsilon}_{t}(\theta)\right) \frac{\partial}{\partial \theta_{k}} \tilde{\epsilon}_{t}\left(\theta_{0}\right), \\
& \Delta_{n, 2}^{k}(\theta)=\frac{2}{\sqrt{n}} \sum_{t=1}^{n}\left(\tilde{\epsilon}_{t}(\theta)-\epsilon_{t}(\theta)\right) \frac{\partial}{\partial \theta_{k}} \tilde{\epsilon}_{t}\left(\theta_{0}\right), \\
& \Delta_{n, 3}^{k}(\theta)=\frac{2}{\sqrt{n}} \sum_{t=1}^{n}\left(\epsilon_{t}(\theta)-\epsilon_{t}\left(\theta_{0}\right)\right) \frac{\partial}{\partial \theta_{k}} \tilde{\epsilon}_{t}\left(\theta_{0}\right)
\end{aligned}
$$

and

\Delta_{n, 4}^{k}\left(\theta_{0}\right)=\frac{2}{\sqrt{n}} \sum_{t=1}^{n} \epsilon_{t}\left(\theta_{0}\right)\left(\frac{\partial}{\partial \theta_{k}} \tilde{\epsilon}_{t}\left(\theta_{0}\right)-\frac{\partial}{\partial \theta_{k}} \epsilon_{t}\left(\theta_{0}\right)\right) .

\mathbb{P}\left(\left|\Delta_{n, 4}^{k}\left(\theta_{0}\right)\right| \geq \beta\right) & \leq \frac{4}{n \beta^{2}} \mathbb{E}\left[\left(\sum_{t=1}^{n} \sum_{j=1}^{\infty}\left\{\dot{\lambda}_{j, k}-\dot{\lambda}_{j, k}^{t}\right\} \epsilon_{t} \epsilon_{t-j}\right)^{2}\right] \\
& \leq \frac{4}{n \beta^{2}} \sum_{t=1}^{n} \sum_{s=1}^{n} \sum_{j_{1}=1}^{\infty} \sum_{j_{2}=1}^{\infty}\left\{\dot{\lambda}_{j_{1}, k}-\dot{\lambda}_{j_{1}, k}^{t}\right\}\left\{\dot{\lambda}_{j_{2}, k}-\dot{\lambda}_{j_{2}, k}^{s}\right\} \mathbb{E}\left[\epsilon_{t} \epsilon_{t-j_{1}} \epsilon_{s} \epsilon_{s-j_{2}}\right] \\
& \leq \frac{8}{n \beta^{2}} \sum_{t=1}^{n} \sum_{s=1}^{t} \sum_{j_{1}=1}^{\infty} \sum_{j_{2}=1}^{\infty}\left\{\dot{\lambda}_{j_{1}, k}-\dot{\lambda}_{j_{1}, k}^{t}\right\}\left\{\dot{\lambda}_{j_{2}, k}-\dot{\lambda}_{j_{2}, k}^{s}\right\} \mathbb{E}\left[\epsilon_{t} \epsilon_{t-j_{1}} \epsilon_{s} \epsilon_{s-j_{2}}\right] .

\mathbb{E}\left[\epsilon_{t} \epsilon_{t-j_{1}} \epsilon_{s} \epsilon_{s-j_{2}}\right]=\operatorname{cum}\left(\epsilon_{0}, \epsilon_{-j_{1}}, \epsilon_{s-t}, \epsilon_{s-t-j_{2}}\right) & +\mathbb{E}\left[\epsilon_{0} \epsilon_{-j_{1}}\right] \mathbb{E}\left[\epsilon_{s-t} \epsilon_{s-t-j_{2}}\right]+\mathbb{E}\left[\epsilon_{0} \epsilon_{s-t}\right] \mathbb{E}\left[\epsilon_{-j_{1}} \epsilon_{s-t-j_{2}}\right] \\
& +\mathbb{E}\left[\epsilon_{0} \epsilon_{s-t-j_{2}}\right] \mathbb{E}\left[\epsilon_{-j_{1}} \epsilon_{s-t}\right]
\end{aligned}

Since the noise is not correlated, we deduce that $\mathbb{E}\left[\epsilon_{0} \epsilon_{-j_{1}}\right]=0$ and $\mathbb{E}\left[\epsilon_{0} \epsilon_{s-t-j_{2}}\right]=0$ for $1 \leq j_{1}, j_{2}$ and $s \leq t$. Consequently we obtain

& +\frac{8}{n \beta^{2}} \sum_{t=1}^{n} \sum_{s=1}^{t} \sum_{j_{1}=1}^{\infty} \sum_{j_{2}=1}^{\infty}\left|\dot{\lambda}_{j_{1}, k}-\dot{\lambda}_{j_{1}, k}^{t}\right|\left|\dot{\lambda}_{j_{2}, k}-\dot{\lambda}_{j_{2}, k}^{s}\right|\left|\mathbb{E}\left[\epsilon_{0} \epsilon_{s-t}\right] \mathbb{E}\left[\epsilon_{-j_{1}} \epsilon_{s-t-j_{2}}\right]\right| . \tag{50}

& \leq \frac{K}{t^{1+\min \left(d_{0}, 0\right)}} \sum_{s=-\infty}^{\infty} \sum_{j_{1}=-\infty}^{\infty} \sum_{j_{2}=-\infty}^{\infty}\left|\operatorname{cum}\left(\epsilon_{0}, \epsilon_{s}, \epsilon_{j_{1}}, \epsilon_{j_{2}}\right)\right| \xrightarrow[t \rightarrow \infty]{\longrightarrow} 0,
\end{aligned}

hence (51) holds true. Concerning the second term of right hand side of the inequality (50), we have

& \leq \frac{\sigma_{\epsilon} K}{\beta \sqrt{n}} \sum_{t=1}^{n}\left\|\lambda(\theta)-\lambda^{t}(\theta)\right\|_{\ell^{2}}
\end{aligned}

We use Lemma 1 , the fact that $d>\max \left(d_{0}, 0\right)$ and the fractional version of Cesàro's Lemma ${ }^{2}$ to obtain

So it is enough to show that the three terms in the right hand side of (60) converge in probability to 0 when $n$ tends to infinity. Following the same arguments as the proof of Lemma 5 and applying the ergodic theorem, we obtain that

& +\left(\mathbb{E}\left(\frac{\partial \epsilon_{t}\left(\theta_{n, i, j}^{*}\right)}{\partial \theta_{j}}-\frac{\partial \tilde{\epsilon}_{t}\left(\theta_{n, i, j}^{*}\right)}{\partial \theta_{j}}\right)^{2} \mathbb{E}\left(\frac{\partial \epsilon_{t}\left(\theta_{n, i, j}^{*}\right)}{\partial \theta_{i}}\right)^{2}\right)^{1 / 2} \\
\leq & \left(\sup _{\theta \in \Theta_{\delta}} \mathbb{E}\left(\frac{\partial \epsilon_{t}(\theta)}{\partial \theta_{i}}-\frac{\partial \tilde{\epsilon}_{t}(\theta)}{\partial \theta_{i}}\right)^{2} \sup _{\theta \in \Theta_{\delta}} \mathbb{E}\left(\frac{\partial \epsilon_{t}(\theta)}{\partial \theta_{j}}\right)^{2}\right)^{1 / 2} \\
& +\left(\sup _{\theta \in \Theta_{\delta}} \mathbb{E}\left(\frac{\partial \epsilon_{t}(\theta)}{\partial \theta_{j}}-\frac{\partial \tilde{\epsilon}_{t}(\theta)}{\partial \theta_{j}}\right)^{2} \sup _{\theta \in \Theta_{\delta}} \mathbb{E}\left(\frac{\partial \epsilon_{t}(\theta)}{\partial \theta_{i}}\right)^{2}\right)^{1 / 2} \\
\leq & \sigma_{\epsilon}^{2}\left(\sup _{\theta \in \Theta_{\delta}}\left\|\dot{\lambda}_{i}(\theta)-\dot{\lambda}_{i}^{t}(\theta)\right\|_{\ell^{2}}^{2} \sup _{\theta \in \Theta_{\delta}} \sum_{k \geq 1}\left(\dot{\lambda}_{k, j}(\theta)\right)^{2}\right)^{1 / 2} \\
& +\sigma_{\epsilon}^{2}\left(\sup _{\theta \in \Theta_{\delta}}\left\|\dot{\lambda}_{j}(\theta)-\dot{\lambda}_{j}^{t}(\theta)\right\|_{\ell^{2}}^{2} \sup _{\theta \in \Theta_{\delta}} \sum_{k \geq 1}\left(\dot{\lambda}_{k, i}^{t}(\theta)\right)^{2}\right)^{1 / 2} \\
\leq & K \frac{1}{t^{1 / 2+\left(d_{1}-d_{0}\right)-\zeta} \xrightarrow[t \rightarrow \infty]{\longrightarrow} 0 .}

& +\frac{2}{n} \sum_{t=1}^{n}\left\|\left.\frac{\partial}{\partial \theta}\left\{\epsilon_{t}(\theta) \frac{\partial^{2}}{\partial \theta_{i} \partial \theta_{j}} \epsilon_{t}(\theta)\right\}\right|_{\theta=\theta_{n, i, j}^{* *}}\right\|\left\|\theta_{n, i, j}^{*}-\theta_{0}\right\| . \tag{61}

We use (61), (62), (63), the ergodic theorem and Theorem 1 to deduce the convergence in probability of $\left|J_{n}^{*}\left(\theta_{n, i, j}^{*}\right)(i, j)-J_{n}^{*}\left(\theta_{0}\right)(i, j)\right|$ to 0 .

The proof of the lemma is then complete.
The following lemma states the existence of the matrix $I\left(\theta_{0}\right)$.

& \leq K \sum_{h, k, l \in \mathbb{Z}}\left|\operatorname{cum}\left(\epsilon_{0}, \epsilon_{k}, \epsilon_{h}, \epsilon_{l}\right)\right| \\
&+\sum_{k_{1} \geq 1} \sum_{k_{2} \geq 1} \frac{K}{k_{1} k_{2}}\left(\left|\operatorname{cum}\left(\epsilon_{0}, \epsilon_{-k_{1}}, \epsilon_{0}, \epsilon_{-k_{2}}\right)\right|\right. \\
&\left.+\sigma_{\epsilon}^{2}\left|\mathbb{E}\left[\epsilon_{-k_{1}} \epsilon_{-k_{2}}\right]\right|\right) \\
& \leq K \sum_{h, k, l \in \mathbb{Z}}\left|\operatorname{cum}\left(\epsilon_{0}, \epsilon_{k}, \epsilon_{h}, \epsilon_{l}\right)\right|+K \sigma_{\epsilon}^{4} \sum_{k_{1} \geq 1}\left(\frac{1}{k_{1}}\right)^{2} \leq K
\end{aligned}

and we obtain the expected result.
Lemma 8. Under Assumptions of Theorem 2, the random vector $\sqrt{n}(\partial / \partial \theta) O_{n}\left(\theta_{0}\right)$ has a limiting normal distribution with mean 0 and covariance matrix $I\left(\theta_{0}\right)$.

The proof of Theorem 2 is then completed.

### 6.4. Proof of the convergence of the variance matrix estimator

We show in this section the convergence in probability of $\hat{\Omega}:=\hat{\jmath}_{n}^{-1} \hat{I}_{n}^{S P} \hat{J}_{n}^{-1}$ to $\Omega$, which is an adaptation of the arguments used in [BMCF12].
Using the same approach as that followed in Lemma 6 , we show that $\hat{J}_{n}$ converges in probability to
$J$. We give below the proof of the convergence in probability of the estimator $\hat{I}_{n}^{S P}$, obtained using the approach of the spectral density, to $I$.
We recall that the matrix norm used is given by $\|A\|=\sup _{\|x\| \leq 1}\|A x\|=\rho^{1 / 2}\left(A^{\prime} A\right)$, when $A$ is a $\mathbb{R}^{k_{1} \times k_{2}}$ matrix, $\|x\|^{2}=x^{\prime} x$ is the Euclidean norm of the vector $x \in \mathbb{R}^{k_{2}}$, and $\rho(\cdot)$ denotes the spectral radius. This norm satisfies

\left\|\Phi_{r}^{*}\right\|^{2} \leq \sum_{k \geq 1} \operatorname{Tr}\left(\phi_{k} \phi_{k}^{\prime}\right)<\infty .

Therefore the convergence $\hat{\Sigma}_{\hat{u}_{r}}$ to $\Sigma_{u}$ will be a consequence of the four following properties:

- $\left\|\hat{\Sigma}_{\hat{H}}-\Sigma_{H}\right\|=o_{\mathbb{P}}(1)$,
- $\mathbb{P}-\lim _{n \rightarrow \infty}\left\|\hat{\phi}_{r}-\underline{\Phi}_{r}^{*}\right\|=0$,
- $\mathbb{P}-\lim _{n \rightarrow \infty}\left\|\hat{\Sigma}_{\hat{H}, \hat{H}_{r}}^{\prime}-\Sigma_{H, \underline{H}_{r}}^{\prime}\right\|=0$ and
- $\left\|\Sigma_{H, \underline{H}_{r}}^{\prime}\right\|=\mathrm{O}(1)$.

The above properties will be proved thanks to several lemmas that are stated and proved hereafter. This ends the proof of Theorem 3. For this, consider the following lemmas:

When $r=\mathrm{o}\left(n^{1 / 3}\right)$ we finally obtain $\sqrt{r}\left\|\hat{\Sigma}_{\underline{H}_{r, n}}-\hat{\Sigma}_{\underline{H}_{r}}\right\|=\mathrm{o}_{\mathbb{P}}(1)$.
Lemma 13. Under the assumptions of Theorem 3, we have

\sqrt{r}\left\|\underline{\Phi}_{r}^{*}-\underline{\Phi}_{r}\right\|=\mathrm{o}_{\mathbb{P}}(1) \quad \text { as } r \rightarrow \infty .

& =\left(\underline{\Phi}_{r}-\underline{\Phi}_{r}^{*}\right) \Sigma_{\underline{H}_{r}}
\end{aligned}
$$

and consequently

\begin{equation*}
\underline{\Phi}_{r}^{*}-\underline{\Phi}_{r}=-\Sigma_{u_{r}^{*}, \boldsymbol{H}_{r}} \Sigma_{\underline{H}_{r}}^{-1} . \tag{82}
\end{equation*}
$$

Using Lemma 9 and Lemma 10, (82) implies that

\mathbb{P}\left(\sqrt{r}\left\|\underline{\Phi}_{r}^{*}-\underline{\Phi}_{r}\right\| \geq \beta\right) & \leq \frac{\sqrt{r}}{\beta}\left\|\Sigma_{u_{r}^{*}, \underline{H}_{r}}\right\|\left\|\Sigma_{\underline{H}_{r}}^{-1}\right\| \\
& \leq \frac{K \sqrt{r}}{\beta}\left\|\mathbb{E}\left[\left(\sum_{k \geq r+1} \Phi_{k} H_{t-k}\left(\theta_{0}\right)+u_{t}\right) \underline{H}_{r, t}^{\prime}\right]\right\| \\
& \leq \frac{K \sqrt{r}}{\beta} \sum_{k \geq r+1}\left\|\Phi_{k}\right\|\left\|\mathbb{E}\left[H_{t-k}\left(\theta_{0}\right) \underline{H}_{r, t}^{\prime}\right]\right\| \\
& \leq \frac{K \sqrt{r}}{\beta} \sum_{\ell \geq 1}\left\|\Phi_{\ell+r}\right\|\left\|\mathbb{E}\left[H_{t-\ell-r}\left(\theta_{0}\right)\left(H_{t-1}^{\prime}\left(\theta_{0}\right), \ldots, H_{t-r}^{\prime}\left(\theta_{0}\right)\right)\right]\right\| \\
& \leq \frac{K \sqrt{r}}{\beta} \sum_{\ell \geq 1}\left\|\Phi_{\ell+r}\right\|\left(\sum_{j=1}^{p+q+1} \sum_{k=1}^{p+q+1} \sum_{r_{1}=1}^{r}\left|\mathbb{E}\left[H_{t-r-\ell, j}\left(\theta_{0}\right) H_{t-r_{1}, k}\left(\theta_{0}\right)\right]\right|^{2}\right)^{1 / 2} \\
& \leq \frac{K \sqrt{r}}{\beta} \sum_{\ell \geq 1}\left\|\Phi_{\ell+r}\right\|\left(\sum_{j=1}^{p+q+1} \sum_{k=1}^{p+q+1} \sum_{r_{1}=1}^{r} \mathbb{E}\left[H_{t-r-\ell, j}^{2}\left(\theta_{0}\right)\right] \mathbb{E}\left[H_{t-r_{1}, k}^{2}\left(\theta_{0}\right)\right]\right)^{1 / 2} \\
& \leq \frac{K(p+q+1) r}{\beta} \sum_{\ell \geq 1}\left\|\Phi_{\ell+r}\right\| .
\end{aligned}
$$

Under Assumptions of Theorem 3, $r \sum_{\ell \geq 1}\left\|\Phi_{\ell+r}\right\|=o(1)$ as $r \rightarrow \infty$. The proof of the lemma follows.

Lemma 14. Under the assumptions of Theorem 3, we have

& \leq \mathbb{P}\left(\sqrt{r}\left\|\Sigma_{\underline{H}_{r}}^{-1}\right\| \sum_{k=1}^{\infty}\left\|\Sigma_{\underline{H}_{r}}-\hat{\Sigma}_{\hat{\underline{H}}_{r}}\right\|^{k}\left\|\Sigma_{\underline{\underline{H}}_{r}}^{-1}\right\|^{k}>\beta\right) \\
& \leq \mathbb{P}\left(\sqrt{r}\left\|\Sigma_{\underline{\underline{H}}_{r}}^{-1}\right\| \sum_{k=1}^{\infty}\left\|\Sigma_{\underline{H}_{r}}-\underline{\Sigma}_{\underline{\hat{H}}_{r}}\right\|^{k}\left\|\Sigma_{\underline{H}_{r}}^{-1}\right\|^{k}>\beta \text { and }\left\|\Sigma_{\underline{H}_{r}}-\hat{\Sigma}_{\underline{\hat{H}}_{r}}\right\|\left\|\underline{\underline{H}}_{r}^{-1}\right\|<1\right) \\
& +\mathbb{P}\left(\sqrt{r}\left\|\Sigma_{\underline{H}_{r}}^{-1}\right\| \sum_{k=1}^{\infty}\left\|\Sigma_{\underline{H}_{r}}-\hat{\Sigma}_{\underline{\hat{H}}_{r}}\right\|^{k}\left\|\Sigma_{\underline{H}_{r}}^{-1}\right\|^{k}>\beta \text { and }\left\|\Sigma_{\underline{H}_{r}}-\hat{\Sigma}_{\underline{\hat{H}}_{r}}\right\|\left\|\Sigma_{\underline{H}_{r}}^{-1}\right\| \geq 1\right) \\
& \leq \mathbb{P}\left(\sqrt{r} \frac{\left\|\Sigma_{\underline{H}_{r}}^{-1}\right\|^{2}\left\|\Sigma_{\underline{H}_{r}}-\hat{\Sigma}_{\hat{\underline{H}}_{r}}\right\|}{1-\left\|\Sigma_{\underline{H}_{r}}-\hat{\Sigma}_{\hat{\underline{H}}_{r}}\right\|\left\|\Sigma_{\underline{H}_{r}}^{-1}\right\|}>\beta\right)+\mathbb{P}\left(\sqrt{r}\left\|\Sigma_{\underline{H}_{r}}-\hat{\Sigma}_{\hat{\underline{H}}_{r}}\right\|\left\|\underline{\underline{H}}_{r}^{-1}\right\| \geq 1\right) \\
& \leq \mathbb{P}\left(\sqrt{r}\left\|\Sigma_{\underline{H}_{r}}-\hat{\Sigma}_{\underline{\hat{H}}_{r}}\right\|>\frac{\beta}{\left\|\Sigma_{\underline{H}_{r}}^{-1}\right\|^{2}+\beta r^{-1 / 2}\left\|\Sigma_{\underline{H}_{r}}^{-1}\right\|}\right) \\
& +\mathbb{P}\left(\sqrt{r}\left\|\Sigma_{\underline{H}_{r}}-\hat{\Sigma}_{\hat{\underline{H}}_{r}}\right\| \geq\left\|\Sigma_{\underline{H}_{r}}^{-1}\right\|^{-1}\right) .
\end{aligned}
$$

Lemmas 9 and 12 imply the result.
Lemma 15. Under the assumptions of Theorem 3, we have

Proof. Lemmas 9 and 14 yield

\end{equation*}

By (71), we have

0=\mathbb{E}\left[u_{r, t} \underline{H}_{r, t}^{\prime}\right]=\mathbb{E}\left[\left(H_{t}\left(\theta_{0}\right)-\underline{\Phi}_{r} \underline{H}_{r, t}\right) \underline{H}_{r, t}^{\prime}\right]=\Sigma_{H, \underline{H}_{r}}-\underline{\Phi}_{r} \Sigma_{H_{r}}
$$

and so we have $\underline{\Phi}_{r}=\Sigma_{H, \underline{H}_{r}} \Sigma_{\underline{H}_{r}}^{-1}$. Lemmas 9, 12, 14 and (83) imply

\sqrt{r}\left\|\underline{\phi}_{r}-\underline{\Phi}_{r}\right\| & =\sqrt{r}\left\|\hat{\Sigma}_{\hat{H}, \hat{\hat{H}}_{r}} \hat{\Sigma}_{\hat{H}_{r}}^{-1}-\Sigma_{H, \underline{H}_{r}} \Sigma_{\underline{H}_{r}}^{-1}\right\| \\
& =\sqrt{r}\left\|\left(\hat{\Sigma}_{\hat{H}, \hat{\hat{H}}_{r}}-\Sigma_{H, \underline{H}_{r}}\right) \hat{\Sigma}_{\underline{\hat{H}}_{r}}^{-1}+\Sigma_{H, \underline{H}_{r}}\left(\hat{\Sigma}_{\underline{\hat{H}}_{r}}^{-1}-\Sigma_{\underline{H}_{r}}^{-1}\right)\right\| \\
& =\mathrm{o}_{\mathbb{P}}(1)
\end{aligned}
$$

and the lemma is proved.

## Proof of Theorem 3

Since by Lemma 12 we have $\left\|\hat{\Sigma}_{\hat{H}}-\Sigma_{H}\right\|=o_{\mathbb{P}}\left(r^{-1 / 2}\right)=\mathrm{o}_{\mathbb{P}}(1)$ and $\left\|\hat{\Sigma}_{\hat{H}, \hat{H}_{r}}-\Sigma_{H, H_{r}}\right\|=\mathrm{o}_{\mathbb{P}}\left(r^{-1 / 2}\right)=$ $\mathrm{o}_{\mathbb{P}}(1)$, and by Lemma $13\left\|\hat{\Phi}_{r}-\underline{\Phi}_{r}^{*}\right\|=\mathrm{o}_{\mathbb{P}}\left(r^{-1 / 2}\right)=\mathrm{o}_{\mathbb{P}}(1)$, Theorem 3 is then proved.

### 6.5. Invertibility of the normalization matrix $P_{p+q+1, n}$

The following proofs are quite technical and are adaptations of the arguments used in [BMS18].
To prove Proposition 4, we need to introduce the following notation.
We denote $S_{t}$ the vector of $\mathbb{R}^{p+q+1}$ defined by

and $S_{t}(i)$ its $i$-th component. We have

S_{t-1}(i)=S_{t}(i)-U_{t}(i) \tag{84}
\end{equation*}
$$

If the matrix $P_{p+q+1, n}$ is not invertible, there exists some real constants $d_{1}, \ldots, d_{p+q+1}$ not all equal to zero, such that $\mathbf{d}^{\prime} P_{p+q+1, n} \mathbf{d}=0$, where $\mathbf{d}=\left(d_{1}, \ldots, d_{p+q+1}\right)^{\prime}$. Thus we may write that $\sum_{i=1}^{p+q+1} \sum_{j=1}^{p+q+1} d_{j} P_{p+q+1, n}(j, i) d_{i}=0$ or equivalently

$$

Then

\sum_{t=1}^{n}\left(\sum_{i=1}^{p+q+1} d_{i}\left(\sum_{k=1}^{t}\left(U_{k}(i)-\bar{U}_{n}(i)\right)\right)\right)^{2}=0
$$

which implies that for all $t \geq 1$

\sum_{i=1}^{p+q+1} d_{i}\left(\sum_{k=1}^{t}\left(U_{k}(i)-\bar{U}_{n}(i)\right)\right)=\sum_{i=1}^{p+q+1} d_{i}\left(S_{t}(i)-\frac{t}{n} S_{n}(i)\right)=0 .
$$

So we have

\frac{1}{t} \sum_{i=1}^{p+q+1} d_{i} S_{t}(i)=\sum_{i=1}^{p+q+1} d_{i}\left(\frac{1}{n} S_{n}(i)\right) \tag{85}
\end{equation*}

We apply the ergodic theorem and we use the orthogonality of $\epsilon_{t}$ and $(\partial / \partial \theta) \epsilon_{t}\left(\theta_{0}\right)$ in order to obtain that

\sum_{i=1}^{p+q+1} d_{i}\left(\frac{1}{n} \sum_{k=1}^{n} U_{k}(i)\right) \xrightarrow[n \rightarrow \infty]{\text { a.s. }} \sum_{i=1}^{p+q+1} d_{i} \mathbb{E}\left[U_{k}(i)\right]=-2 \sum_{i, j=1}^{p+q+1} d_{i} J^{-1}(i, j) \mathbb{E}\left[\epsilon_{k} \frac{\partial \epsilon_{k}}{\partial \theta_{j}}\right]=0 .
$$

Reporting this convergence in (85) implies that $\sum_{i=1}^{p+q+1} d_{i} S_{t}(i)=0$ a.s. for all $t \geq 1$. By (84), we deduce that

$$
\sum_{i=1}^{p+q+1} d_{i} U_{t}(i)=-2 \sum_{i=1}^{p+q+1} d_{i} \sum_{j=1}^{p+q+1} J^{-1}(i, j)\left(\epsilon_{t} \frac{\partial \epsilon_{t}}{\partial \theta_{j}}\right)=0, \quad \text { a.s. }
$$

Thanks to Assumption (A5), $\left(\epsilon_{t}\right)_{t \in \mathbb{Z}}$ has a positive density in some neighborhood of zero and then $\epsilon_{t} \neq 0$ almost-surely. So we would have $\mathbf{d}^{\prime} J^{-1} \frac{\partial \epsilon_{t}}{\partial \theta}=0$ a.s. Now we can follow the same arguments that we developed in the proof of the invertibility of $J$ (see Proof of Lemma 5 and more precisely (56)) and this leads us to a contradiction. We deduce that the matrix $P_{p+q+1, n}$ is non singular.

### 6.6. Proof of Theorem 5

The arguments follows the one [BMS18] in a simpler context.
Recall that the Skorohod space $\mathbb{D}^{\ell}[0,1]$ is the set of $\mathbb{R}^{\ell}$-valued functions on $[0,1]$ which are rightcontinuous and has left limits everywhere. It is endowed with the Skorohod topology and the weak convergence on $\mathbb{D}^{\ell}[0,1]$ is mentioned by $\xrightarrow{\mathbb{D}^{\ell}}$. The integer part of $x$ will be denoted by $\lfloor x\rfloor$.
The goal at first is to show that there exists a lower triangular matrix $T$ with nonnegative diagonal entries such that

$$
\begin{equation*}
\frac{1}{\sqrt{n}} \sum_{t=1}^{\lfloor n r\rfloor} U_{t} \xrightarrow[n \rightarrow \infty]{\mathbb{D}^{p+q+1}}\left(T T^{\prime}\right)^{1 / 2} B_{p+q+1}(r) \tag{86}
\end{equation*}
$$

where $\left(B_{p+q+1}(r)\right)_{r \geq 0}$ is a $(p+q+1)$-dimensional standard Brownian motion. Using (29), $U_{t}$ can be rewritten as

$$
U_{t}=\left(-2\left\{\sum_{i=1}^{\infty} \dot{\lambda}_{i, 1}\left(\theta_{0}\right) \epsilon_{t} \epsilon_{t-i}, \ldots, \sum_{i=1}^{\infty} \dot{\lambda}_{i, p+q+1}\left(\theta_{0}\right) \epsilon_{t} \epsilon_{t-i}\right\} J^{-1^{\prime}}\right)^{\prime}
$$

The non-correlation between $\epsilon_{t}$ 's implies that the process $\left(U_{t}\right)_{t \in \mathbb{Z}}$ is centered. In order to apply the functional central limit theorem for strongly mixing process, we need to identify the asymptotic covariance matrix in the classical central limit theorem for the sequence $\left(U_{t}\right)_{t \in \mathbb{Z}}$. It is proved in Theorem 2 that

$$
\frac{1}{\sqrt{n}} \sum_{t=1}^{n} U_{t} \underset{n \rightarrow \infty}{\stackrel{\text { in law }}{ }} \mathcal{N}\left(0, \Omega=: 2 \pi f_{U}(0)\right)
$$

where $f_{U}(0)$ is the spectral density of the stationary process $\left(U_{t}\right)_{t \in \mathbb{Z}}$ evaluated at frequency 0 . The existence of the matrix $\Omega$ has already been discussed (see the proofs of lemmas 5 and 7 ).

Since the matrix $\Omega$ is symmetric positive definite, it can be factorized as $\Omega=T T^{\prime}$ where the $(p+q+1) \times(p+q+1)$ lower triangular matrix $T$ has real positive diagonal entries. Therefore, we have

$$
\frac{1}{\sqrt{n}} \sum_{t=1}^{n}\left(T T^{\prime}\right)^{-1 / 2} F_{t} \underset{n \rightarrow \infty}{\text { in law }} \mathcal{N}\left(0, I_{p+q+1}\right)
$$

where $I_{p+q+1}$ is the identity matrix of order $p+q+1$.
As in the proof of the asymptotic normality of $\left(\sqrt{n}\left(\hat{\theta}_{n}-\theta_{0}\right)\right)_{n \geq 1}$, the distribution of $n^{-1 / 2} \sum_{t=1}^{n} U_{t}$ when $n$ tends to infinity is obtained by introducing the random vector $U_{t}^{k}$ defined for any positive integer $k$ by

$$
U_{t}^{k}=\left(-2\left\{\sum_{i=1}^{k} \dot{\lambda}_{i, 1}\left(\theta_{0}\right) \epsilon_{t} \epsilon_{t-i}, \ldots, \sum_{i=1}^{k} \dot{\lambda}_{i, p+q+1}\left(\theta_{0}\right) \epsilon_{t} \epsilon_{t-i}\right\} J^{-1^{\prime}}\right)^{\prime}
$$

Since $U_{t}^{k}$ depends on a finite number of values of the noise process $\left(\epsilon_{t}\right)_{t \in \mathbb{Z}}$, it also satisfies a mixing property (see Theorem 14.1 in [Dav94], p. 210). The central limit theorem for strongly mixing process of [Her84] shows that its asymptotic distribution is normal with zero mean and variance matrix $\Omega_{k}$ that converges when $k$ tends to infinity to $\Omega$ (see the proof of Lemma 8):

\frac{1}{\sqrt{n}} \sum_{t=1}^{n} U_{t}^{k} \underset{n \rightarrow \infty}{\text { in law }} \mathcal{N}\left(0, \Omega_{k}\right)
$$

The above arguments also apply to matrix $\Omega_{k}$ with some matrix $T_{k}$ which is defined analogously as $T$. Consequently, we obtain

\frac{1}{\sqrt{n}} \sum_{t=1}^{n}\left(T_{k} T_{k}^{\prime}\right)^{-1 / 2} U_{t}^{k} \underset{n \rightarrow \infty}{\text { in law }} \mathcal{N}\left(0, I_{p+q+1}\right)
$$

Now we are able to apply the functional central limit theorem for strongly mixing process of [Her84] and we obtain that

$$
\frac{1}{\sqrt{n}} \sum_{t=1}^{\lfloor n r\rfloor}\left(T_{k} T_{k}^{\prime}\right)^{-1 / 2} U_{t}^{k} \xrightarrow[n \rightarrow \infty]{\mathbb{D}^{p+q+1}} B_{p+q+1}(r)
$$

Since

$$
\left(T T^{\prime}\right)^{-1 / 2} U_{t}^{k}=\left(\left(T T^{\prime}\right)^{-1 / 2}-\left(T_{k} T_{k}^{\prime}\right)^{-1 / 2}\right) U_{t}^{k}+\left(T_{k} T_{k}^{\prime}\right)^{-1 / 2} U_{t}^{k}
$$

we may use the same approach as in the proof of Lemma 8 in order to prove that $n^{-1 / 2} \sum_{t=1}^{n}\left(\left(T T^{\prime}\right)^{-1 / 2}-\right.$ $\left.\left(T_{k} T_{k}^{\prime}\right)^{-1 / 2}\right) U_{t}^{k}$ converges in distribution to 0 . Consequently we obtain that

$$
\frac{1}{\sqrt{n}} \sum_{t=1}^{\lfloor n r\rfloor}\left(T T^{\prime}\right)^{-1 / 2} U_{t}^{k} \xrightarrow[n \rightarrow \infty]{\mathbb{D}^{p+q+1}} B_{p+q+1}(r) .
$$

In order to conclude that (86) is true, it remains to observe that uniformly with respect to $n$ it holds that

$$
\begin{equation*}
\tilde{Y}_{n}^{k}(r):=\frac{1}{\sqrt{n}} \sum_{t=1}^{\lfloor n r\rfloor}\left(T T^{\prime}\right)^{-1 / 2} \tilde{Z}_{t}^{k} \xrightarrow[n \rightarrow \infty]{\mathbb{D}^{p+q+1}} 0 \tag{87}
\end{equation*}
$$

where

$$
\tilde{Z}_{t}^{k}=\left(-2\left\{\sum_{i=k+1}^{\infty} \dot{\lambda}_{i, 1}\left(\theta_{0}\right) \epsilon_{t} \epsilon_{t-i}, \ldots, \sum_{i=k+1}^{\infty} \dot{\lambda}_{i, p+q+1}\left(\theta_{0}\right) \epsilon_{t} \epsilon_{t-i}\right\} J^{-1^{\prime}}\right)^{\prime}
$$

By (67), one has

$$
\sup _{n} \operatorname{Var}\left(\frac{1}{\sqrt{n}} \sum_{t=1}^{n} \tilde{Z}_{t}^{k}\right) \xrightarrow[n \rightarrow \infty]{\longrightarrow} 0
$$

and since $\lfloor n r\rfloor \leq n$,

$$
\sup _{0 \leq r \leq 1} \sup _{n}\left\{\left\|\tilde{Y}_{n}^{k}(r)\right\|\right\} \underset{n \rightarrow \infty}{\longrightarrow} 0
$$

Thus (87) is true and the proof of (86) is achieved.
By (86) we deduce that

$$
\begin{equation*}
\frac{1}{\sqrt{n}}\left(\sum_{j=1}^{\lfloor n r\rfloor}\left(U_{j}-\bar{U}_{n}\right)\right) \xrightarrow[n \rightarrow \infty]{\mathbb{D}^{p+q+1}}\left(T T^{\prime}\right)^{1 / 2}\left(B_{p+q+1}(r)-r B_{p+q+1}(1)\right) . \tag{88}
\end{equation*}
$$

One remarks that the continuous mapping theorem on the Skorohod space yields

$$
\begin{aligned}
& P_{p+q+1, n} \xrightarrow[n \rightarrow \infty]{\text { in law }}\left(T T^{\prime}\right)^{1 / 2}\left[\int_{0}^{1}\left\{B_{p+q+1}(r)-r B_{p+q+1}(1)\right\}\left\{B_{p+q+1}(r)-r B_{p+q+1}(1)\right\}^{\prime} \mathrm{dr}\right]\left(T T^{\prime}\right)^{1 / 2} \\
&=\left(T T^{\prime}\right)^{1 / 2} V_{p+q+1}\left(T T^{\prime}\right)^{1 / 2}
\end{aligned}
$$

Using (86), (88) and the continuous mapping theorem on the Skorohod space, one finally obtains

$$
\begin{align*}
& n\left(\hat{\theta}_{n}-\theta_{0}\right)^{\prime} P_{p+q+1, n}^{-1}\left(\hat{\theta}_{n}-\theta_{0}\right) \\
& \xrightarrow[n \rightarrow \infty]{\mathbb{D}^{p+q+1}}\left\{\left(T T^{\prime}\right)^{1 / 2} B_{p+q+1}(1)\right\}^{\prime}\left\{\left(T T^{\prime}\right)^{1 / 2} V_{p+q+1}\left(T T^{\prime}\right)^{1 / 2}\right\}^{-1}\left\{\left(T T^{\prime}\right)^{1 / 2} B_{p+q+1}(1)\right\}  \tag{1}\\
&=B_{p+q+1}^{\prime}(1) V_{p+q+1}^{-1} B_{p+q+1}(1):=\mathcal{U}_{p+q+1} .
\end{align*}
$$

The proof of Theorem 5 is then complete.

### 6.7. Proof of Theorem 6

In view of (14) and (17), we write $\hat{P}_{p+q+1, n}=P_{p+q+1, n}+Q_{p+q+1, n}$ where

$$
\begin{aligned}
Q_{p+q+1, n}=\left(J\left(\theta_{0}\right)^{-1}-\hat{\jmath}_{n}^{-1}\right) \frac{1}{n^{2}} \sum_{t=1}^{n} & \left(\sum_{j=1}^{t}\left(H_{j}-\frac{1}{n} \sum_{k=1}^{n} H_{k}\right)\right)\left(\sum_{t=1}^{n}\left(H_{j}-\frac{1}{n} \sum_{k=1}^{n} H_{k}\right)\right)^{\prime} \\
+\hat{J}_{n}^{-1} \frac{1}{n^{2}} \sum_{t=1}^{n}\{ & \left(\sum_{j=1}^{t}\left(H_{j}-\frac{1}{n} \sum_{k=1}^{n} H_{k}\right)\right)\left(\sum_{t=1}^{n}\left(H_{j}-\frac{1}{n} \sum_{k=1}^{n} H_{k}\right)\right)^{\prime} \\
& \left.-\left(\sum_{j=1}^{t}\left(\hat{H}_{j}-\frac{1}{n} \sum_{k=1}^{n} \hat{H}_{k}\right)\right)\left(\sum_{t=1}^{n}\left(\hat{H}_{j}-\frac{1}{n} \sum_{k=1}^{n} \hat{H}_{k}\right)\right)^{\prime}\right\}
\end{aligned}
$$

Using the same approach as in Lemma $6, \hat{J}_{n}$ converges in probability to $J$. Thus we deduce that the first term in the right hand side of the above equation tends to zero in probability.

The second term is a sum composed of the following terms

$$
q_{s, t}^{i, j, k, l}=\epsilon_{s}\left(\theta_{0}\right) \epsilon_{t}\left(\theta_{0}\right) \frac{\partial \epsilon_{s}\left(\theta_{0}\right)}{\partial \theta_{i}} \frac{\partial \epsilon_{t}\left(\theta_{0}\right)}{\partial \theta_{j}}-\tilde{\epsilon}_{s}\left(\hat{\theta}_{n}\right) \tilde{\epsilon}_{t}\left(\hat{\theta}_{n}\right) \frac{\partial \tilde{\epsilon}_{s}\left(\hat{\theta}_{n}\right)}{\partial \theta_{k}} \frac{\partial \tilde{\epsilon}_{t}\left(\hat{\theta}_{n}\right)}{\partial \theta_{l}} .
$$

Using similar arguments done before (see for example the use of Taylor's expansion in Subsection 6.4, we have $q_{s, t}^{i, j, k, l}=o_{\mathbb{P}}(1)$ as $n$ goes to infinity and thus $Q_{p+q+1, n}=o_{\mathbb{P}}(1)$. So one may find a matrix $Q_{p+q+1, n}^{*}$ that tends to the null matrix in probability and such that

$$
\begin{aligned}
n\left(\hat{\theta}_{n}-\theta_{0}\right)^{\prime} \hat{P}_{p+q+1, n}^{-1}\left(\hat{\theta}_{n}-\theta_{0}\right)= & n\left(\hat{\theta}_{n}-\theta_{0}\right)^{\prime}\left(P_{p+q+1, n}+Q_{p+q+1, n}\right)^{-1}\left(\hat{\theta}_{n}-\theta_{0}\right) \\
= & n\left(\hat{\theta}_{n}-\theta_{0}\right)^{\prime} P_{p+q+1, n}^{-1}\left(\hat{\theta}_{n}-\theta_{0}\right) \\
& +n\left(\hat{\theta}_{n}-\theta_{0}\right)^{\prime} Q_{p+q+1, n}^{*}\left(\hat{\theta}_{n}-\theta_{0}\right) .
\end{aligned}
$$

Thanks to the arguments developed in the proof of Theorem 5, $n\left(\hat{\theta}_{n}-\theta_{0}\right)^{\prime} P_{p+q+1, n}^{-1}\left(\hat{\theta}_{n}-\theta_{0}\right)$ converges in distribution. So $n\left(\hat{\theta}_{n}-\theta_{0}\right)^{\prime} Q_{p+q+1, n}^{*}\left(\hat{\theta}_{n}-\theta_{0}\right)$ tends to zero in distribution, hence in probability. Then $n\left(\hat{\theta}_{n}-\theta_{0}\right)^{\prime} \hat{P}_{p+q+1, n}^{-1}\left(\hat{\theta}_{n}-\theta_{0}\right)$ and $n\left(\hat{\theta}_{n}-\theta_{0}\right)^{\prime} P_{p+q+1, n}^{-1}\left(\hat{\theta}_{n}-\theta_{0}\right)$ have the same limit in distribution and the result is proved.
