9 Abstract

- ¹⁰ Introduction Metabolite identification remains a major bottleneck in the understanding of metabolism. Many metabolomics AQ1
- ¹¹ studies end up with unknown compounds, leaving a landscape of metabolites and metabolic pathways to be unraveled. ¹² Therefore, identifying novel compounds within a metabolome is an entry point into the 'dark side' of metabolicm.

 ¹³ Objectives This work aimed at elucidating the structure of a novel metabolite that was first detected in the soil bacteria.
- Objectives This work aimed at elucidating the structure of a novel metabolite that was first detected in the soil bacterium AQ2
 Acinetobacter baylyi ADP1 (ADP1).
- ¹⁵ Methods We used high resolution multi-stage tandem mass spectrometry for characterizing the metabolite within the
- ¹⁶ metabolome. We purified the molecule for 1D- and 2D-NMR (1H, ¹³C, ¹H-¹H-COSY, ¹H-¹³C-HSQC, ¹H-¹³C-HMBC and
- ¹⁷ ¹H-¹⁵N-HMBC) analyses. Synthetic standards were chemically prepared from MS and NMR data interpretation.
- ¹⁸ **Results** We determined the de novo structure of a previously unreported metabolite: 3-((3-aminopropyl)amino)-4-hydroxy-
- ¹⁹ benzoic acid. The proposed structure was validated by comparison to a synthetic standard. With a concentration in the mil-
- ²⁰ limolar range, this compound appears as a major metabolite in ADP1, which we anticipate to participate to an unsuspected
- ²¹ metabolic pathway. This novel metabolite was also detected in another γ -proteobacterium.
- ²² Conclusion Structure elucidation of this abundant and novel metabolite in ADP1 urges to decipher its biosynthetic pathway
 ²³ and cellular function.

1 Introduction

Extensive and accurate knowledge of bacterial metabolism is critical for developing a comprehensive and detailed understanding of cellular physiology. This requires that, in fine, within a studied organism the function of all genes is established and the identity of all metabolites known. This goal is today probably out of reach given the complexity of the chemistry of life, and represents a long-term objective. On the one side 30-40% of genes of a typical genome remain unannotated or associated with a putative function (Chang et al. 2016; Galperin and Koonin 2004) and on the other side, many metabolites remain unidentified in most metabolomics studies (Bingol et al. 2016; Dias et al. 2016; Domingo-Almenara et al. 2018; Dunn et al. 2013b; Viant et al. 2017). Nuclear magnetic resonance (NMR) is currently the most powerful spectroscopic method for elucidating the chemical structure of organic compounds

due to the development of high field magnets as well as 42 capillary and cryogenic probes that significantly increased 43 the sensitivity of NMR spectroscopy (Dias et al. 2016). 44 45 However, this technique most preferably needs a pure sample in the upper µM range that requires laborious and time 46 consuming work. Moreover, since annotating compounds 47 to most likely structures using high-resolution mass spec-48 trometry (HRMS) is a faster and feasible first step, elec-49 trospray-mass spectrometry (ESI-MS) and tandem mass 50 spectrometry combined with liquid chromatographic (LC) 51 separation is the most used technique for characterizing 52 unknown compounds present in metabolomes. Neverthe-53 less, many metabolomic studies end up with a mere list 54 of mass-to-charge ratio (m/z) values and chromatographic 55 retention times. As a consequence, a landscape of metabo-56 lites and metabolic pathways are yet to be discovered. In 57 metabolomics, identification of metabolites remains one 58 of the biggest bottlenecks (Dunn et al. 2013a; Kind and 59 60 Fiehn 2010; Viant et al. 2017), but of importance, since identifying novel compounds within a metabolome is an 61 entry point into the 'dark side' of bacterial metabolism. 62 63 The use of HRMS instruments with mass accuracy in the low parts per million (ppm) range can provide the elemen-64 tal composition of the detected ions. HRMS also provides 65 a useful method for putative annotation querying databases 66 (Kanehisa et al. 2012; Smith et al. 2005; Wishart et al. 67 2013) for metabolites whose molecular masses are within 68 a specified mass deviation range. However, the majority 69 of the observed peaks continue to remain unidentified or 70 associated with multiple putative identifications. Without 71 72 authentic compounds used for comparison of retention time and product ion spectra, the identity of a metabolite 73 cannot be established. Structural information can also be 74 obtained by performing MS/MS experiments, where the 75 ion is fragmented and the m/z of the resulting fragment 76 ions recorded. However, fragmentation interpretation of an 77 unknown metabolite for its structural elucidation remains 78 hampered by our incomplete understanding of the complex 79 gas phase ion chemistry. Alternatively, these spectra can 80 be matched with existing spectral databases for identity 81 assignment or similarity search (Zhu et al. 2013). These 82 databases, which are increasing in number and size (Horai 83 84 et al. 2010; https://www.mzcloud.org; Kale et al. 2016; Sawada et al. 2012; Smith et al. 2005; Wishart et al. 2013) 85 are very useful for identifying known compounds, but are 86 87 far from being complete. Only a small proportion of all known metabolites are commercially available, leaving the 88 majority of them not included in mass spectral libraries. It 89 is estimated that less than 5% of all known metabolites are 90 MS² spectra available (Frainay et al. 2018; Tsugawa et al. 91 2016). Another drawback of ESI-MS/MS experiments 92 is that the tandem mass spectra generated exhibit high 93 instrument-dependent variability which interferes with the 94

constitution of universal databases as done with electron 95 ionization mass spectrometry (Roux et al. 2011). Com-96 pared to MS² approaches, multistage MS (MSⁿ) fragmen-97 tation in which ions are specifically selected for sequential 98 fragmentation, results in deeper and more detailed frag-99 mentation pathways and provides more structural informa-100 tion (Rojas-Cherto et al. 2012; van der Hooft et al. 2011). 101 In this case, again, complete identification is possible only 102 when a fragmentation tree of the same compound is pre-103 sent in the database. Otherwise, putative candidate struc-104 tures can be proposed using computer assisted structure 105 elucidation (Peironcely et al. 2012; Wolf et al. 2010) but 106 the identity of the unknown remains non-validated. Four 107 levels of reporting metabolite annotation and identification 108 are defined by the metabolomics standards initiative (Sum-109 ner et al. 2007). "Identification" is the most rigorous level 110 (level 1), where two orthogonal properties of the metabo-111 lite are matched to the same properties of an authentic 112 compound analyzed by the same method. Levels 2 and 3 113 provide annotation as metabolites or metabolite classes, 114 respectively, without comparison to authentic compounds. 115 Level 4 considers the metabolite as unidentified. There-116 fore, only information from rigorously 'level 1' identified 117 metabolites can be used for investigating metabolic path-118 ways and accessing other levels of biological hierarchy 119 such as gene function annotation. 120

Acinetobacter baylyi ADP1 (ADP1) is a nutritionally 121 versatile strictly aerobic bacterium (Young et al. 2005). Its 122 extraordinary competence for natural transformation and the 123 ease with which it can be genetically engineered (de Berar-AQ3 4 dinis 2009; Metzgar et al. 2004) make ADP1 a key organ-125 ism for the study of bacterial metabolism. We recently used 126 metabolomics to reinvestigate quinate metabolism in ADP1, 127 which was thoroughly studied for many years (Young et al. 128 2005). We reported that shifting the carbon source from 129 succinate to quinate elicited a global metabolic reprogram-130 ming and led to the production of almost 30 unidentified and 131 unexpected compounds that we anticipate to participate to 132 unsuspected metabolic pathways (Stuani et al. 2014). Here, 133 we report the complete de novo structure elucidation of one 134 these unknown metabolites. We conducted its extensive 135 LC/HRMS/MSⁿ characterization within the metabolome 136 and purified the molecule for 1D- and 2D-NMR (1H, ¹³C, 137 ¹H-¹H-COSY, ¹H-¹³C-HSQC, ¹H-¹³C-HMBC and ¹H-¹⁵N-138 HMBC) analyses. The putative structure deduced from MS 139 and NMR data interpretation was eventually confirmed 140 by means of chemical synthesis to be 3-((3-aminopropyl) 141 amino)-4-hydroxybenzoic acid (APAH). This compound 142 was discovered to be a major metabolite in ADP1 with intra-143 cellular concentration in the millimolar range. Its presence 144 in another y-proteobacterium such as Pseudomonas putida 145 suggests a wider taxonomic distribution and urges to inves-146 tigate its metabolic role. 147

148 2 Materials and methods

149 2.1 Chemicals and reagents

Chemicals, HPLC-grade solvents, ammonium acetate, 150 ammonium carbonate, ammonium hydroxide and deuter-151 ated water were from Sigma-Aldrich. 5-((3-aminopropyl) 152 amino)-2-hydroxybenzoic acid (SN0079), 4-((3-aminopro-153 pyl)amino)-2-hydroxybenzoic acid (SN0080), 2-((3-amino-154 propyl)amino)-5-hydroxybenzoic acid (SN0123), 4-((3-ami-155 nopropyl)amino)-3-hydroxybenzoic acid (SN0124) and 156 3-((3-aminopropyl)amino)-4-hydroxybenzoic acid (SN0140) 157 were synthesized by Synthenova (http://www.synthenova 158 .com). 159

160 2.2 Strains and medium

Acinetobacter baylyi ADP1 strain (DSM 24193) was pro-161 vided by Dr. Nicholas Ornston (Yale University). ADP1, 162 Pseudomonas putida KT2440 (ATCC 47054) and Ralsto-163 nia eutropha H16 (DSMZ 428) were routinely grown on 164 medium for Acinetobacter (MA) minimal medium [31 mM 165 Na₂HPO₄, 25 mM KH₂PO₄, 18 mM NH₄Cl, 41 µM nitrilo-166 triacetic acid, 2 mM MgSO₄, 0.45 mM CaCl₂, 3 µM FeCl₃, 167 168 1 μM MnCl₂, 1 μM ZnCl₂, 0.3 μM (CrCl₃, H₃BO₃, CoCl₂, CuCl₂, NiCl₂, Na₂MoO₂, Na₂SeO₃)] supplemented with 169 20 mM (or 5 mM for protocatechuate) of the desired carbon 170 source. 171

172 2.3 Metabolome preparation

173 2.3.1 Analytical scale

Cells were grown in 5 ml at 30 °C. Metabolite extraction 174 was adapted from the Metabolomics Service Protocols 175 from the University of Glasgow (http://www.polyomics. 176 gla.ac.uk/assets/downloads/MSMetabolomicsPrepCells-177 Aug2013.pdf). A saturated overnight culture was diluted in 178 a fresh medium at an $OD_{600} = 0.05$. 5 ml were transferred in 179 a well of a 24 deep-well plate (Whatman; reference 7701-180 5110). The cells were further grown to an OD_{600} between 181 182 0.6 and 0.8 in a shaking incubator (Climo Shaker ISF1-X Kühner). The plate was then centrifuged at $2700 \times g$ at 4 °C 183 for 10 min and the supernatant removed. The cell pellet 184 was resuspended in 200 µl of water/methanol/acetonitrile 185 (1:3:1 ratio) and placed in a cold bath (-80 °C) composed 186 of dry ice and ethanol. After cell freezing, the mixture was 187 let at 25 °C to complete unfreezing of the cells. This proce-188 dure was repeated twice to completely break the cells. The 189 metabolites were next rocked on a shaker for 1 h at 4 °C. The 190 metabolites were centrifuged at $5000 \times g$ at 4 °C for 10 min. 191

The supernatant was dried and stored at -80 °C. Before 192 LC/MS analysis, the metabolites were suspended with 20 µl 193 water and 42 µl 80% acetonitrile and 20% 10 mM ammonium carbonate (pH 9.9), centrifuged at 5000×g at 4 °C 195 for 10 min. The supernatant was finally filtered on 0.22 µm 196 (PTFE, Acroprep Advance, Pall). 197

2.3.2 Preparative scale

For purification of metabolite of m/z 211 (M211), a satu-199 rated overnight culture was diluted in a fresh medium at 200 an $OD_{600} = 0.05$. 5 ml were distributed in each well of a 201 24 deep-well plate. Four plates were prepared per day. The 202 cells were further grown to an OD_{600} between 0.6 and 0.8 in 203 a shaking incubator. The four plates were then centrifuged 204 at $2700 \times g$ at 4 °C for 10 min and the supernatant removed. 205 Cell pellets were resuspended in 200 µl of water/methanol/ 206 acetonitrile (1:3:1 ratio). The plates were placed in a cold 207 bath (-80 °C) composed of dry ice and ethanol. After cell 208 freezing, the plates were let at 25 °C to complete unfreezing 209 of the cells. This procedure was repeated twice to completely 210 break the cells. The plates were next rocked on a shaker for 211 1 h at 4 °C. The extracted metabolites were pooled in a 50 ml 212 Falcon tube and lyophilized and stored at -80 °C. All this 213 procedure was repeated three times, for a total of twelve 214 24 deep-well plates processed (1.5 l of cell culture). The 215 metabolome was resuspended in 7 ml 80% acetonitrile and 216 20% 10 mM ammonium acetate (pH 6.8) before purification. 217

2.4 Metabolome derivatization

1,3-Diaminopropane (DAP) was labelled with benzoyl chlo-
ride for improving LC/MS detection (Aflaki et al. 2014).219Dried metabolomes from 5 ml cultures were resuspended
in 250 μl water and basified with 0.5 μl 2M NaOH. 250 μl
of 4% benzoyl chloride in acetonitrile were added. After
15 min, the mixture was filtered on 0.22 μm (PTFE, Acro-
prep Advance, Pall) and injected for LC/MS analysis.219

2.5 Analytical chromatography

Analyses were conducted using a Dionex Ultimate 3000 227 Rapid Separation LC (Thermo Fisher Scientific). 228

Chromatographic Method 1 used a ZIC®-pHILIC column229 $(150 \times 4.6 \text{ mm}^2; 5 \mu\text{m}; \text{Merck})$ and was previously reported230(Stuani et al. 2014).231

Chromatographic Method 2 was used for hydrogen/deu-
terium exchange (HDX) experiments, with deuterated (D_2O)232
233mobile phase. Elution was carried out on a ZIC®-pHILIC
column ($100 \times 2.1 \text{ mm}^2$; 5 µm; Merck) to minimize the use
of heavy water. Column temperature was set to 15 °C using
a mobile phase gradient with a flow rate of 0.2 ml/min.

in deuterated water and mobile phase B of acetonitrile. The 239 gradient started at 80% B for 1 min, followed by a linear gra-240 dient to 40% B at 8 min and remained 4 min at 40% B. The 241 system returned to the initial solvent composition in 3 min 242 and re-equilibrated under these conditions for 15 min. 2.5 µl 243 were injected. All experiments done on labelled samples 244 with these new settings were replicated on light samples 245 with the same chromatographic column for comparison. 246

Chromatographic Method 3 used a Syncronis HILIC col-247 umn ($50 \times 2.1 \text{ mm}^2$; 1.7 µm; Thermo Fischer Scientific) and 248 was conducted at 30 °C with a mobile phase gradient at a 249 flow rate of 0.3 ml/min. A consisted of 10 mM ammonium 250 acetate (pH 6.8) and B of acetonitrile. The gradient started 251 at 80% B for 0.3 min, followed by a linear gradient to 40% 252 B at 1.8 min and remained 1.5 min at 40% B. The system 253 returned to the initial solvent composition in 0.5 min and re-254 equilibrated under these conditions for 3.70 min. 2 µl were 255 injected. 256

Chromatographic Method 4 used a ZIC®-pHILIC column 257 $(150 \times 2.1 \text{ mm}^2; 5 \mu\text{m}; \text{Merck})$ with a mobile phase gradient 258 at a flow rate of 0.2 ml/min at 40 °C. A consisted of 10 mM 259 ammonium carbonate with pH adjusted to 9.9 with NH₄OH 260 and B of acetonitrile. The gradient started at 80% B for 261 2 min, followed by a linear gradient to 40% B at 20 min and 262 remained 3 min at 40% B. The system returned to the initial 263 solvent composition in 2 min and re-equilibrated under these 264 conditions for 12.2 min. 5 µl were injected. 265

Chromatographic Method 5 used a ZIC®-pHILIC 266 $(50 \times 2.1 \text{ mm}^2; 5 \mu\text{m}; \text{Merck})$ with a mobile phase gradi-267 ent at a flow rate of 0.2 ml/min at 40 °C. A consisted of 268 10 mM ammonium carbonate with pH adjusted to 9.9 with 269 NH₄OH and B of acetonitrile. The gradient started at 80% B 270 for 0.5 min, followed by a linear gradient to 40% B at 6 min 271 and remained 1.5 min at 40% B. The system returned to the 272 initial solvent composition in 1.5 min and re-equilibrated 273 under these conditions for 4.3 min. 2 µl were injected. 274

Chromatographic Method 6 used an Acquity UPLC BEH 275 C18 column ($100 \times 2.1 \text{ mm}^2$; 1.7 µm; Waters) and was con-276 ducted at 35 °C with a mobile phase gradient at a flow rate 277 of 0.3 ml/min. Mobile phase A consisted of H₂O and mobile 278 phase B consisted of methanol. The gradient started at 10% 279 B for 1 min, followed by a linear gradient to 70% B at 19 min 280 and remained 5 min at 70% B. The system returned to the 281 initial solvent composition in 5 min and re-equilibrated 282 under these conditions for 10 min. 5 µl were injected. For all 283 chromatographic analysis, the autosampler was kept at 4 °C. 284

285 **2.6 Metabolite purification**

Metabolite purification was performed on a semi-preparative
HPLC system Prominence LC-20AP (Shimadzu, Kyoto,
Japan) fitted with a fraction collector FRC-10A (Shimadzu,
Kyoto, Japan). The extracted metabolome was first dissolved

and sonicated for 10 min at 4 °C in 6 ml 80% acetonitrile and 290 20% 10 mM ammonium acetate (pH 6.8). The sample was 291 centrifuged at $4000 \times g$ for 10 min at 4 °C and the superna-292 tant filtered on 0.22 µm (Millipore Millex-GV 13 mm). The 293 filter was further washed with 1 ml of the same solution. The 294 first purification step was conducted using a ZIC®-HILIC 295 column ($250 \times 10 \text{ mm}^2$; 5 µm; Merck). A mobile phase 296 gradient was used with a flow rate of 4.6 ml/min. Mobile 297 phase A consisted of 10 mM ammonium acetate (pH 6.8) 298 and mobile phase B consisted of acetonitrile. The gradient 299 started at 80% B for 2 min, followed by a linear gradient to 300 40% B at 22 min and remained 10 min at 40% B. The system 301 returned to the initial solvent composition in 20 min and 302 re-equilibrated under these conditions for 20 min. 200 µl 303 were injected (33 injections of 200 µl were performed). The 304 compound was monitored at 223 nm and collected in 2.3 ml 305 fractions. Due to the weak UV signal of M211, the eluted 306 fractions were analyzed for the presence of m M211 by LC/ 307 MS using Chromatographic Method 3. The fractions of 308 interest were pooled and dried, yielding 1.1 mg of a yellow/ 309 pale brown solid residue. The partially purified compound 310 was dissolved in 2 ml 72% acetonitrile and 28% 10 mM 311 ammonium acetate (pH 6.8) and centrifuged at $4000 \times g$ for 312 10 min at 4 °C and the supernatant filtered on 0.22 µm (Mill-313 ipore Millex-GV 13 mm). The filter was further washed with 314 1 ml of the same solution. The second purification step was 315 conducted using the same ZIC®-HILIC column (250×10 316 mm^2 ; 5 µm; Merck) with an isocratic separation (mobile 317 phase: 72% acetonitrile and 28% 10 mM ammonium acetate, 318 pH 6.8) at a flow rate of 4.6 ml/min. 200 µl were injected 319 (13 injections of 200 µl were performed). The eluted 2.3 ml 320 fractions were analyzed for the presence of M211 by LC/ 321 MS using Chromatographic Method 3. 100 µg of pure M211 322 were obtained as a pale yellow solid matter. 323

2.7 HRMS analyses

High-resolution measurements were obtained with a Velos 325 Pro Orbitrap Elite mass spectrometer (Thermo Fisher Sci-326 entific) fitted with a heated electrospray ionization source 327 (HESI) operating in positive and negative ionization modes. 328 In the positive ion mode, the ion spray (IS) was set to 329 +3.5 kV and the capillary temperature at 275 °C. Sheath 330 gas and auxiliary gas flow rates were set at 60% arbitrary 331 units (a.u.) and 44 a.u., respectively. The S-lens RF level 332 was set to 55%. In the negative ion mode, the IS was set to 333 -4.0 kV and the S-lens RF level to 60. Mass spectra were 334 acquired over an m/z range from m/z 50 up to m/z 1000 with 335 the mass resolution set to 60,000 FWHM at m/z 400. LC/MS 336 data were acquired in raw files and processed with the Qual-337 browser module of Xcalibur 2.2 (Thermo Fisher Scientific) 338 to access to elemental compositions. Fragmentation experi-339 ments were performed under collision induced dissociation 340

CID and HCD, normalized collision energies (NCE) of 22%
and 28% in positive mode and 33% and 75% in negative
mode, respectively were applied.

345 2.8 NMR analyses

Samples were dissolved in D₂O:H₂O (10:90). NMR experiments were performed on a Bruker Advance 600-MHz NMR
spectrometer equipped with a 1.7 mm cryogenic probe.

The ¹H NMR water signal from the polar fraction was suppressed by means of excitation sculpting (Bruker ZGESGP pulse program). Additional ¹³C NMR spectra were acquired for each sample. ¹H-¹H COSY, ¹H-¹³C HSQC, ¹H-¹³C HMBC and ¹H-¹⁵N HMBC experiments was only carried out for the purified metabolite sample.

³⁵⁵ Chemical shifts (expressed in ppm) of ¹H NMR spectra ³⁵⁶ were referenced to the solvent peaks δ H 4.79 for D₂O.

2.9 APAH quantification

A calibration line for APAH (3-((3-aminopropyl)amino)-395 4-hydroxybenzoic acid) was required to calculate its in vivo 396 concentration. The calibration line was obtained using cali-397 bration solutions containing 0, 1, 2, 5, 10 and 19 µM of syn-398 thetic APAH spiked in metabolomes from succinate-grown 399 cells (devoid of APAH), to take into account the matrix 400 effect. These spiked metabolomes were analyzed on our 401 Velos Pro Orbitrap Elite in the positive mode using Chro-402 matographic Method 4. The peak areas from extracted ion 403 chromatograms of APAH were integrated and the values 404 used to build the calibration line. Next, to estimate APAH 405 concentration in the cell, metabolomes from 13 independent 406 5 ml cultures of quinate-grown cells ($OD_{600} = 0.47 \pm 0.02$) 407 were used. Cell cultures (succinate and quinate) and metabo-408 lome preparation were conducted as described above. The 409 lyophilized metabolomes were resuspended with 20 µl water 410 and 42 µl 80% acetonitrile and 20% 10 mM ammonium car-411 bonate (pH 9.9). Samples were filtered on 0.22 µm prior to 412 injection. 413

3 Results and discussion 414

3.1 LC/HRMS/MSⁿ analysis of an unknown metabolite of m/z 211

Among the compounds exclusively formed in guinate-417 grown cells, we considered here an ion that, analyzed with 418 LC-HRMS, has a long retention time (14.3 min) on the 419 hydrophilic zwitterionic ZIC®-pHILIC column (Chroma-420 tographic Method 1, see "Material and methods" section) 421 and led to intense ionization signal in the positive mode at 422 m/z 211.1074 (Fig. 1a, b). The compound was also detected 423 in the negative mode at m/z 209.0934. These two m/z values 424 were anticipated to be the protonated $[M+H]^+$ and depro-425 tonated form $[M-H]^-$ of the same molecule, respectively. 426 The monoisotopic mass of the protonated form of this 427 unknown metabolite, which we called M211 (metabolite of 428 m/z 211), was consistent with an elemental composition of 429 $C_{10}H_{15}O_3N_2^+$ (-1.6 ppm off the theoretical mass) and with 430 its first natural isotope abundance (M+1=11.1%; Fig. 1b). 431 Elemental composition was validated by applying the Seven 432 Golden Rules (Kind and Fiehn 2007). The long retention 433 time of M211, associated with detection in both ionization $\Lambda Q4$:4 modes suggest a very polar structure carrying acidic and 435 basic functional groups. Photodiode array (PDA) detection 436 indicated UV absorption (Fig. 1c) with maxima at 224, 259, 437

and 302 nm (Fig. 1d) that are evocative of an aromatic moi-438 439 ety (Singh et al. 2007).

Accurate mass and elemental composition of M211 440 matched to only two compounds present in Metlin and 441 KEGG databases: aprobarbital and 2,6-dihydropseudoni-442 cotine. These molecules harbor 2 and 3 mobile protons, 443 respectively (Fig. S1). To check whether these molecules 444 could correspond to M211, we determined its mobile pro-445 ton number. This was established in positive and negative 446 ionization modes using in-solution hydrogen/deuterium 447 448 exchange (HDX) approach (Chromatographic Method 2). Six mobile protons were observed in the positive mode 449 and four in the negative mode; i.e. five mobile protons 450 for the neutral form of the molecule (Fig. 1e-h). This 451

result invalidated the structures proposed by the databases 452 and confirmed that M211 was a previously unreported metabolite.

Mass spectra recorded in the positive mode displayed M211 and a series of other ions with the same extracted ion chromatogram (EIC) shape: a major ion at m/z 180 and minor ones at *m*/*z* 166, 176, 193, 194 and 209 (Fig. 1i). This latter probably originated from in-source oxidation of M211. The similar chromatographic shape of these ions suggests they could be generated by in-source dissociation of the pre-461 cursor ion at m/z 211 (Fig. S2a). 462

In the negative mode M211 was detected at m/z 209. 463 Two others weakly abundant ions at m/z 165 and m/z464 107 observed in the mass spectrum displayed similar 465

chromatographic shapes, and originated from in-source dissociation of m/z 209.

Fragmentation spectra were recorded under collision 468 induced dissociation (CID) and higher energy dissociation 469 (HCD) conditions. Under HCD, small size fragment ions 470 become significantly more abundant. In the positive mode 471 (Fig. 1j), fragmentation spectra display two main product 472 ions: a major one at m/z 193 (water loss) and a slightly less 473 abundant one at m/z 194 (NH₃ loss). Less abundant m/z474 176 and m/z 166 product ions are related to the consecutive 475 losses of $[NH_3 + H_2O]$ and the release of $[C_2H_7N]$, respec-476 tively. The neutral [C₂H₇N] moiety formally corresponds 477 to saturated alkyl amine. The m/z 166 product ion was also 478 formed during consecutive fragmentation of the m/z 194 479 precursor (sequential MS³ experiments), as illustrated in 480 Fig. S2b. This ion is related to the loss of C_2H_4 from m/z481 194 ion produced by the loss of ammonium from m/z 211 482 precursor ion. Therefore, [C₂H₇N] probably corresponds 483 to ethylamine rather than dimethylamine. HCD fragmenta-484 tion also yielded very weak signals at m/z 150 and m/z 122, 485 which likely originated from consecutive fragmentation 486 of m/z 194 by the loss of CO₂ and [CO₂ + C₂H₄], respec-487 tively. These ions were also observed in the sequential 488 MS^3 experiments of the selected m/z 194 (Fig. S2b). All 489 these fragment ions were present in the mass spectrum, 490 too. Ion m/z 180 was not detected in the fragmentation 491 spectrum of M211, using either CID or HCD. However, 492 it was very abundant in the fragmentation spectrum of its 493 oxidized form at m/z 209 (Fig. 1k), indicating that m/z 180 494 observed in the mass spectrum of M211 originated mainly 495 from in-source dissociation of m/z 209. In addition, the 496 number of mobile protons observed on the one side for 497 M211 (5 for the neutral species) and on the other side for 498 m/z 209 (3 for the neutral form) and m/z 180 (mostly 2 and 499 in a much lesser extent 3 for the neutral form) are in agree-500 ment with the loss of CH_2NH (1 mobile proton) from m/z501 209 rather than the release of CH_3NH_2 (2 mobile protons) 502 from M211 (Fig. S2c-f). 503

In the negative mode, HCD spectra of the selected ion m/z 209 yielded a main product ion at m/z165 (CO₂ loss) along with two less abundant radical ions at m/z 107 and m/z151 (Fig. 11). These latter were formed after the loss of the radical ion C₃H₈N·, either from m/z 165 (consecutive loss, which is also observed in MS³ experiments on the selected precursor m/z 165 ion) or from m/z 209, respectively.

The following assumptions can be made from the frag-511 mentation spectra: in the negative mode, a major loss of 512 CO₂ is characteristic of the presence of a carboxylic group. 513 In addition, the formation of an odd electron product ion 514 such as m/z 107 [C₆H₅ON]⁻· with a degree of unsatura-515 tion of 5 (5.5 for the parent ion m/z 209) together with UV 516 data (Fig. 1a, b) suggests the presence of an aromatic core. 517 According to its elemental composition, this relatively stable 518

radical anion should represent a phenol derivative (Afonso et al. 2010).

Generally, an abundant loss of NH₃ in the positive mode 521 is due to the presence of a primary aliphatic amino group. 522 Here, a single ammonium loss suggests the presence of a 523 single primary aliphatic amine in the unknown structure 524 (Levsen et al. 2007). Therefore, taking into account the total 525 number of mobile protons (five for the neutral species), a 526 structure that involves N-containing heterocycle should be 527 excluded. A loss of H₂O in the positive mode can be related 528 to the presence of either a carboxylic group or an aliphatic 529 OH group (Levsen et al. 2007). Considering on the one hand 530 a single water loss, the presence of one carboxylic group 531 (two O-atoms), and on the other hand a total number of three 532 oxygen atoms and the previously discussed existence of an 533 aromatic (phenol) core, we anticipate a phenolic group rather 534 than an aliphatic hydroxyl group. Thus, taking into account 535 five mobile protons for the uncharged molecule, one for the 536 carboxylic group, two for the primary amino group and one 537 for the phenolic hydroxyl group, the molecule should involve 538 a secondary amino group with one more mobile proton. 539

In conclusion, LC–HRMS/MSⁿ data suggest that the unknown metabolite contains an aromatic moiety, possibly a phenol ring, a carboxylic group along with primary and secondary amines, but de novo interpretation of mass spectrometry data did not allow to completely elucidate its chemical structure. 545

3.2 NMR analysis of purified M211

NMR was considered to achieve the complete struc-547 tural elucidation of M211. The metabolite was purified 548 from 1.5 l of bacterial culture in MA medium containing 549 20 mM quinate as the carbon source. Purification was 550 carried out using HILIC-phase chromatography and led 551 to 100 µg of a pale yellow solid (see "Material and meth-552 ods" section). Extensive 1D- and 2D-NMR analyses (¹H, 553 ¹³C, ¹H-¹H-COSY, ¹H-¹³C-HSQC, ¹H-¹³C-HMBC and 554 ¹H-¹⁵N-HMBC) were performed (see Table 1 and Data-555 set_S1). The ¹H-NMR spectrum clearly confirmed the 556 presence of an aromatic ring bearing three protons. Their 557 multiplicity (Table 1; Fig. 2a) indicated a 1,2,4-trisubsti-558 tution pattern (Fig. 2b). The set of three aliphatic signals, 559 integrating each for two protons, suggested a propylene 560 moiety further confirmed by several cross-correlations 561 peaks visible in COSY spectrum (Fig. 2c, d). Combining 562 ¹H and ¹³C chemical shifts of aliphatic signals allowed 563 us to conclude to a 1,3-diaminopropyl substructure, in 564 agreement with HRMS/MSⁿ conclusions that predicted 565 the presence of primary and secondary amines (Fig. 2d). 566 Cross correlation peak between proton $H_{1'}$ and carbon 567 C₃ in HMBC spectrum (Fig. 2e) unambiguously demon-568 strated that the secondary amine is responsible for the 569

linkage of the aliphatic moiety to the aromatic ring. Char-570 acteristic chemical shift values of 147 and 176 ppm for 571 carbon C_4 and $C_{1''}$ confirmed the presence of phenolic 572 and carboxylic moieties (see Table 1 and Dataset S1). 573 HMBC experiments indicated that the carboxylic function 574 is indeed branched onto the aromatic system (Fig. 2f). 575 Expected labile protons for amine, phenol and carboxylic 576 acid groups could not be observed in ¹H NMR neither in 577 organic solvents (dimethylformamide-d6, acetonitrile-d3) 578 nor in aqueous solutions (90/10 H₂O/D₂O and 90/10 H₂O/ 579 $D_2O + 1\%$ trifluoroacetic acid). Another difficulty arose 580 from the superposition of two signals in ¹³C NMR spec-581 trum at 114.5 ppm (Fig. 2g). Finally, we investigated the 582 relative position of aromatic substituents using ¹H-¹³C-583 HMBC and ¹H-¹⁵N-HMBC experiments. Unfortunately, 584 observed long-ranged ¹H-¹³C and ¹H-¹⁵N correlations 585 (Fig. 2f, h) did not allow us to draw any firm conclusion. 586 Indeed, ${}^{2}J({}^{1}H-{}^{13}C)$, ${}^{3}J({}^{1}H-{}^{13}C)$ and ${}^{4}J({}^{1}H-{}^{13}C)$ on the one 587 side and ${}^{2}J({}^{1}H-{}^{15}N)$, ${}^{3}J({}^{1}H-{}^{15}N)$ and ${}^{4}J({}^{1}H-{}^{15}N)$ on the 588 other side are known to lead to coupling values of simi-589 lar frequency in aromatic systems (Martin and Williams 590 2008; Martin and Hadden 2000). At that stage, the com-591 plete structure elucidation of M211 was still not achieved 592 as six regioisomers remained plausible (Fig. 3). 593

3.3 Structure determination of M211 by comparison to the synthetic standards

To help raising the ambiguity, five out of the six possible 596 compounds were synthesized: 5-((3-aminopropyl)amino)-597 2-hydroxybenzoic acid (SN0079), 4-((3-aminopropyl) 598 amino)-2-hydroxybenzoic acid (SN0080), 2-((3-aminopro-599 pyl)amino)-5-hydroxybenzoic acid (SN0123), 4-((3-ami-600 nopropyl)amino)-3-hydroxybenzoic acid (SN0124) 601 and 3-((3-aminopropyl)amino)-4-hydroxybenzoic acid 602 (SN0140). 1 H and 13 C NMR analyses were then recorded 603 in the same manner as for the purified metabolite (Data-604 set S1). Data clearly showed a very high similarity between 605 M211 and SN0140 in detriment of all other structures. The 606 observed slight ¹H chemical shift difference between M211 607 and SN0140 probably originated from the elevated num-608 ber of protonable functions highly sensitive to pH and/ 609 or to concentration due to inter-/intra-Hydrogen bonding 610 (Fig. S3). To confirm the structural assignment, the stand-611 ards along with a metabolome from ADP1 quinate-grown 612 cells were further analyzed by LC/MS (Chromatographic 613 Method 1). According to comparison of its retention time 614 and MS² spectrum with the reference compounds, M211 was 615 eventually unambiguously identified as 3-((3-aminopropyl) 616

amino)-4-hydroxybenzoic acid (APAH), as illustrated in Fig.S4.

619 3.4 Quantification of APAH in ADP1

In vivo quantification of APAH was conducted by 620 LC-HRMS analysis using synthetic APAH. The calibration 621 line (Chromatographic Method 4) was obtained by spiking 622 metabolomes of succinate-grown cells (that are devoid of 623 APAH) with known amounts of synthetic APAH, to over-624 come matrix effects. APAH was quantified according to its 625 EIC area in metabolomes from independent quinate-grown 626 cultures (Fig. S5). Assuming the same internal volume 2.3 627 10^{-9} µl for ADP1 as for *E. coli* (Bazile et al. 1992), we 628 estimated the cellular concentration of APAH to 7 ± 4 mM. 629 APAH is thus present in ADP1 at a high abundance, which 630 could affect osmolality. To draw a comparison, in E. coli 631 the concentration of 70% of quantified metabolites is below 632 633 the millimolar range (Bennett et al. 2009). Its abundance should be related to its role in the cell, as low metabolite 634 concentrations are favorable for avoiding osmotic stress and 635 disadvantageous spontaneous reactions (Bennett et al. 2009). 636 Data in Fig. S5 indicated a wide variation of APAH in the 637 metabolomes (between 2 and 19 mM). This unexplained 638 variability cannot be attributed to incorrect handling of the 639 cells during metabolomics sampling. Here, before metabo-640 lite extraction, culture centrifugation may have yield a cel-641 642 lular stress that caused the observed variation in APAH concentrations. However, in our previous study in which 643 rapid cell quenching was combined with cell inactivation 644 to 'freeze' the microbial metabolism, peak areas of APAH 645

varied in a similar manner sevenfold (Stuani et al. 2014, 646 Online Resource 2, Table S-6). 647

3.5 Hypotheses for APAH biosynthesis

APAH is formed in quinate-grown cells but not in succinate 649 grown-cells (Stuani et al. 2014, Online Resource 2, Table 650 S-6). Quinate is metabolized through the β -ketoadipate 651 pathway (Young et al. 2005). Most aromatic compounds 652 are mainly degraded by this pathway through the formation 653 of catechol (catechol branch) or protocatechuate (protocat-654 echuate branch). From catechol and protocatechuate, a paral-655 lel but separate branch converts them into succinyl-CoA and 656 acetyl-CoA which can enter central metabolism through the 657 TCA cycle (Fig. S6). Quinate is metabolized via the proto-658 catechuate branch. 659

From a structural point of view, APAH is evocative 660 of two metabolites: protocatechuate on the one side and 661 1,3-diaminopropane (DAP) on the other side. DAP is pre-662 sented as the major polyamine in the genus Acinetobacter, 663 with concentrations up to 2.5 µmol/g wet cell (Hamana and 664 Matsuzaki 1992). We hypothesized that APAH may result 665 from an enzymatic condensation of these two metabolites. 666 Both protocatechuate and DAP are indeed present in ADP1 667 quinate-grown cells (Fig. 4). To gain insight in APAH bio-668 synthesis, we explored the feasibility of a spontaneous reac-669 tion between protocatechuate and DAP. We mixed a 20 mM 670 aqueous solution of protocatechuate with a 500 mM aque-671 ous solution of DAP hydrochloride at a molar ratio of 1:2 672 (pH 7). After 30 min, we diluted twofold the solution in 673 80% acetonitrile and 20% 10 mM ammonium carbonate (pH 674 9.9) before LC/MS analysis (Chromatographic Method 1). 675

Two peaks of similar intensities were observed at m/z 211 676 (positive mode) consistent with the formation of two iso-677 mers. According to their retention times and fragmentation 678 patterns, they corresponded to APAH and 4-((3-aminopro-679 pyl)amino)-3-hydroxybenzoic acid (SN0124), indicating 680 that DAP can react with both hydroxyl groups of protocat-681 echuate (Fig. S7). The reaction yield for APAH was very 682 low (0.06%) and its concentration was estimated to be only 683 684 0.3 µM. These data thus indicate that the reaction, thermodynamically feasible, could be enzyme-catalyzed. According 685 to this postulate, the formation of APAH should be strictly 686 687 correlated to the presence of both DAP and protocatechuate in the cell. 688

We thus examined whether the presence of APAH was 689 restricted to quinate metabolism solely or could be also 690 linked to the catechol branch. To this end, we analyzed the 691 metabolomes of ADP1 grown on benzyl alcohol, a com-692 693 pound whose degradation feeds into the catechol branch (Fig. S6). Data analysis revealed that APAH is formed in 694 these conditions, albeit more weakly than in quinate-grown 695 cells (Fig. 4a), but in quantity that can nonetheless be 696

compared to that obtained in protocatechuate-grown cells 697 (Fig. S8). However, although DAP was present, protocate-698 chuate was not detected in ADP1 growing on benzyl alcohol 699 (Fig. 4b). The weak signal detected in the metabolome of 700 benzyl alcohol-grown cells did not match with the reten-701 tion time of protocatechuate and displayed a different MS² 702 spectrum. This suggested that APAH is not formed from 703 protocatechuate and indicates that APAH biosynthesis is 704 neither restricted to quinate degradation nor to the proto-705 catechuate branch of the β -ketoadipate pathway. We next 706 wondered about the presence of APAH in other organisms 707 harboring the quinate degradation pathway. Genome con-708 text analyses conducted on the MicroScope platform (https 709 ://www.genoscope.cns.fr/agc/microscope/home/index.php) 710 showed that clusters of genes orthologous to pca operon 711 encoding the enzymes for protocatechuate degradation 712 (Siehler et al. 2007) are present in the genome of organ-713 isms such as Pseudomonas putida KT4440 and Rasltonia 714 eutropha H16. Despite the absence of genes orthologous 715 to qui operon in P. putida for converting quinate to pro-716 tocatechuate, this organism was nevertheless reported to 717

grow with quinate as the sole carbon source (Jimenez et al. 718 2002). Regarding R. eutropha H16, its genome does not har-719 bor the qui operon either and cannot grow on quinate. We 720 thus analyzed the metabolomes of P. putida and R. eutropha 721 grown on quinate and protocatechuate, respectively, for the 722 presence of APAH. We detected APAH in P. putida but 723 not in R. eutropha (Fig. 4a). This result emphasizes that 724 APAH is not restricted to ADP1 and is produced at least in 725 another γ -proteobacterium. On the other hand, its absence 726 in R. eutropha eliminates a strict association between its 727 synthesis and quinate/protocatechuate catabolism. Moreover, 728 DAP was not observed in P. putida (Fig. 4c). Together, these 729 results suggest that neither protocatechuate nor DAP is a 730 biosynthetic precursor of APAH. APAH origin and function 731 remain unknown. The metabolite is not excreted (Fig. S9) 732 as APAH could not be detected in the medium of a culture 733 at $OD_{600} = 0.8$, although APAH synthesis is maximal at this 734 cell density (Fig. S10). On the contrary, protocatechuate, 735 known to be present in the medium of quinate-degrading 736 cells (D'Argenio et al. 1999) is indeed excreted (Fig. S9). 737 Moreover, APAH does not behave as secondary metabolite: 738 it is not formed at high cell density or during a decrease of 739 the growth rate, or after exhaustion of the carbon source 740 (Fig. S10). 741

4 Conclusion 742

We report here the de novo complete structural elucidation 743 of a novel and abundant metabolite in Acinetobacter baylyi 744 ADP1, APAH, a compound that is not restricted to ADP1. 745

To meet the requirement of 'level 1 identification' 746 (according to the Metabolomics Standard Initiative), we 747 conducted an extensive analytical study that combined NMR 748 and LC/HRMS/MSⁿ techniques. Finally, its identity was 749 established according to comparison of its retention time, 750 MS² and ¹H NMR spectra with a synthetic standard. This 751 work illustrates the significant effort required to unambigu-752 ously identify a previously unreported metabolite, which still 753 remains orphan of enzyme/gene. 754

Interpretation of experimental MS and NMR data for 755 metabolite identification is crucial for metabolism interpre-756 tation, but cannot be scaled up to adapt with the hundreds or 757 thousands of compounds present in a metabolome. Improve-758 ment of tandem mass spectral libraries and MS/MS scoring 759 algorithms are needed (Kind et al. 2018) for faster com-760 pound identification and biochemical landscape covering. 761

To gain insight from APAH biosynthesis, we are actually 762 conducting a LC/HRMS-based screening of the collection of 763 2600 single-gene deletion mutants of ADP1 (de Berardinis 764 et al. 2008). Detecting the mutant metabolomes devoid of 765 APAH shall inform us on the genes involved in its formation 766 and led us to start reconstituting APAH synthetic pathway. 767
