# An experimental study of dissolution and precipitation of forsterite in a thermal gradient: implications for cellular growth of olivine

### Abstract

9 The morphology of crystals in magmas strongly depends on the temperature regime of the system, in particular the degree of 10 undercooling and the cooling rate. To simulate low degrees of undercooling, we developed a new experimental setup based 11 on thermal migration, in which large cylinders of forsterite (single crystals) immersed in haplobasaltic melt were subjected 12 to a temperature gradient. As forsterite solubility is sensitive to temperature, the forsterite on the high-temperature side 13 undergoes dissolution and the dissolved components are transported toward the low-temperature side where a layer of newly 14 grown forsterite forms (up to 340 um thick after 101 h). A striking feature is that the precipitation process does not produce a 15 planar front of forsterite advancing at the expense of liquid: the growth front shows a fingered outline in planar section, with 16 solid lobes separated by glass tubes that are perpendicular to the growth front. We ascribe this texture to cellular growth, a 17 type of growth that had not been experimentally produced so far in silicate systems. We find that the development of cel-18 lular growth requires low degrees of undercooling (a few °C) and large crystal-liquid interfaces (~1 mm across or more), 19 and that it occurs at a growth rate of the order of  $10^{-9}$  m/s. We found natural occurrences of cellular growth on the rims of 20 olivines from basanites, but otherwise cellular textures are poorly documented in natural volcanic rocks. Melt inclusions were 21 produced in our experiments, showing that they can form in olivine at relatively slow rates of growth  $(10^{-9} \text{ m/s or lower})$ .

### Introduction

Crystals and melt inclusions are precious tools to decipher the processes from magma production to final emplacement, and they have been the topic of an impressive amount of studies in the past decades. Melt inclusions are parcels of liquid trapped in crystals, which hold precious information on the chemical composition (major and trace elements, volatiles) of primitive magmas (Roedder and Bodnar 1980; Schiano 2003). Zoning patterns, shape and texture of crystals are a record of the composition of the liquid they grew from and the conditions during crystallization (Welsch et al. 2013). To decipher igneous processes, we need to know the growth mechanisms of minerals. The rate at which crystals grow is of particular interest to investigate the timescale of magmatic processes, such as magma ascent rate or crystal residence time in a reservoir prior to eruption (Armienti et al. 1994; Brewer 2000; Murphy et al. 2000; Blundy et al. 2006; Schiano et al. 2006; Humphreys et al. 2006; Morgan

Crystal growth is controlled by a dominant rate control-45 ling process that defines the morphology of the crystal. Such 46 processes are reaction at the crystal-melt interface, chemical 47 diffusion in the melt or latent heat flow (Kirkpatrick 1975, 48 1981; Sunagawa 1981). The reactions at the crystal-melt 49 interface are attachment mechanisms such as continuous 50 growth, surface nucleation or screw dislocation. In this case, 51 there are not significant compositional gradients in the melt 52 along the interface. Diffusion controls the crystal growth 53 when it is slower than attachment mechanisms. Growth con-54 trolled by chemical diffusion may produce spatial compo-55 sitional gradients and usually results in morphologies like 56 skeletal or dendritic crystals. The mechanisms that define the 57 crystal shape and size depend on the variation of extrinsic 58 (temperature, pressure...) or intrinsic (chemical composi-59 60 tion, volatile content) parameters. A determinant parameter affecting the mechanism of crystal growth is temperature. In 61 most cases, the increase of the crystal growth rate is attrib-62 63 uted to the cooling regime of the magmatic system (O'hara et al. 1968; Takei and Kobayashi 1974; Faure and Schiano 64 2005). For instance, the olivine growth shape switches from 65 polyhedral, to skeletal and to dendritic with increasing 66 degree of undercooling and cooling rate (Donaldson 1976; 67 Faure et al. 2003a). This crystallization shape sequence does 68 not include cellular growth that produces an intermediate 69 morphology (between polyhedral and skeletal/dendritic) at 70 relatively low growth rates. Cellular growth is well known 71 72 in metallurgy but poorly documented in silicate minerals (Tiller et al. 1953; Keith and Padden 1963; Shechtman et al. 73 1984). 74

Most experimental studies of olivine crystal morpholo-75 gies were performed at relatively large undercooling degrees 76 and cooling rates (Donaldson 1976; Jambon et al. 1992; 77 Faure et al. 2003a, 2007; Faure and Schiano 2005; Gold-78 stein and Luth 2006), which are specific to scenarios like 79 the emplacement of a small volume of magma at or near the 80 Earth surface. However, the large abundance of dominantly 81 polyhedral olivine phenocrysts in igneous rocks implies 82 low degrees of undercooling and cooling rates in numer-83 84 ous natural magmatic environments. At present, the study of the effect of low undercooling degrees ( $\leq 10$  °C) on crystal 85 growth is nearly absent from the literature due to experi-86 87 mental limitations. To fill this gap, we conducted thermal migration experiments, in which large forsterite crystals 88 immersed into a basaltic liquid were subjected to a low-89 temperature gradient (typically, 5–10 °C/mm). In the pres-90 ence of a thermal gradient, solid-liquid systems are known 91 to undergo dissolution-precipitation processes that contrib-92 ute to mass transport and can strongly affect the develop-93 ment of cumulates in layered intrusions or the compaction 94

of partially molten rocks (Lesher and Walker 1988; Walker et al. 1988; Schiano et al. 2006; Sonzogni et al. 2011). At a smaller scale, a thermal gradient can cause the migration of a melt inclusion in its host crystal (Lesher and Walker 1988; Walker et al. 1988; Schiano et al. 2006; Sonzogni et al. 2011).

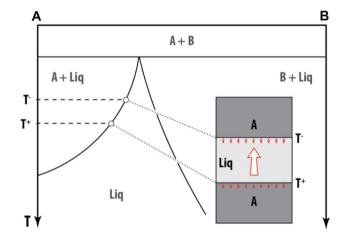

Figure 1 illustrates the concept of thermal migration 101 (Buchwald et al. 1985; Lesher and Walker 1988; Walker 102 and Agee 1988) and how it was adapted in our experimen-103 tal study. Thermal migration is a process of mass transport 104 and phase redistribution in a mixture of crystals and liq-105 uid subjected to a temperature gradient. It comprises two 106 components: chemical diffusion resulting from variations 107 of mineral solubility with temperature, and thermodiffusion 108 (Soret effect) resulting from differences in temperature in 109 the liquid. We consider a simple binary system A-B, with 110 crystals of phase A in suspension in an interconnected liquid 111 phase. If this system is placed in a temperature gradient, then 112 local equilibrium between phase A and liquid will impose 113 a more A-rich liquid composition on the high-temperature 114 side ( $T^+$  in Fig. 1), and a more B-rich composition on the 115 low-temperature side ( $T^{-}$  in Fig. 1). As the liquid is inter-116 connected, this gradient in liquid composition will give rise 117 to chemical diffusion of component A from regions of high 118 temperature to regions of low temperature, and of compo-119 nent B in the opposite direction. This process, which is dic-120 tated by local mineral saturation, is called saturation gradient 121 chemical diffusion (Lesher and Walker 1988; Walker and 122 Agee 1988). To maintain local equilibrium between crystals 123

and liquid, phase A must continuously dissolve on the high-124 temperature side and precipitate on the low-temperature 125 side. In parallel to saturation gradient chemical diffusion, the 126 liquid phase will also undergo thermodiffusion. In the case 127 of basic silicate liquids, thermodiffusion leads to the trans-128 port of dissolved olivine components (MgO, FeO) toward 129 the low-temperature side of the thermal gradient (Lesher 130 and Walker 1986). Accordingly, in our study, Soret effect 131 will assist saturation gradient chemical diffusion and lead 132 to additional concentration of forsterite on the cold end of 133 experimental charges. 134

In comparison to former thermal migration experiments (Lesher and Walker 1988; Walker and Agee 1988; Walker et al. 1988), the main difference in our study is that we replaced the small olivine crystals by large forsterite cylinders (single crystals). The most simple configuration is sketched in Fig. 1: it is composed of a thin layer of liquid between two forsterite monocrystals. Because of the difference of temperature, the lower forsterite-liquid interface (at  $T^+$ ) will continuously dissolve, and the lower forsterite-liquid interface (at  $T^{-}$ ) will continuously grow during the experiment. We show that studying the behavior of large monocrystals in a thermal gradient allows to bridge the gap between Ostwald ripening experiments, in which degrees of undercooling are  $< 1 \,^{\circ}$ C (Cabane et al. 2005), and cooling experiments, in which crystal growth data can only be obtained at degrees of undercooling of  $\approx 10$  °C or more (Donaldson 1976; Kirkpatrick 1981). Another advantage

of our experimental configuration is to provide at the same 152 time an insight into the dissolution and crystallization pro-153 cesses at low degrees of superheating and undercooling, 154 respectively. 155

### **Experimental procedure**

### Starting materials and experimental protocol

The experiments were run in the simplified system 158 Na<sub>2</sub>O-CaO-MgO-Al<sub>2</sub>O<sub>3</sub>-SiO<sub>2</sub> (Na-CMAS). The hap-159 lobasaltic glass was produced by Schott AG Company (see AQ1 30 chemical compositions in Table 1) and crushed down into 161 fine powder. Cylinders of forsterite 2-2.5 mm diameter were 162 cored in a large synthetic monocrystal of pure Mg<sub>2</sub>SiO<sub>4</sub> (Ito 163 et al. 2003a, b) (Table 2). The thickness of the forsterite cyl-164 inders ranged from 0.6 to 2.3 mm. The faces of the cylinders 165 were polished down to the micron. The starting materials 166 were loaded in platinum capsules with an outer diameter 167 of 3.0 mm and an inner diameter of 2.6 mm. The capsules 168 were inserted into an assembly for a <sup>3</sup>/<sub>4</sub>-inch piston-cylinder 169 apparatus with Pyrex glass and NaCl sleeves used as pres-170 sure medium and thermal insulator. All experiments were 171 conducted at 10 kbar (1GPa) and 1400 or 1425 °C (Table 3). 172 The temperature was generated by a graphite cylinder and 173 read by a C-type (tungsten-rhenium alloy) thermocouple 174 placed about 0.8 mm below the capsule. Prior to experiment, 175

of the experiment, the sample was quenched by switching off 188 the power, resulting in a cooling rate of  $\sim 80$  °C/s, and then 189 slowly decompressed to 1 bar. Details of the experimental 190 conditions are presented in Table 3. 191

#### Setup geometry 192

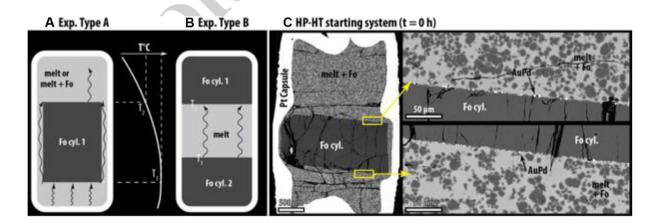


Fig. 2 Sketch of the experimental geometries used for experiments of types A (a) and B (b), with a typical qualitative temperature (T) distribution along the capsule axis; the hot spot is located in the lower third of the capsule, 05-07 mm above the bottom. The height of the samples ranges from 3.1 to 5.1 mm. c Experiment A0 at time zero (t=0.1 h; Table 3): SEM picture of the whole sample and enlargements of the upper and lower faces of the forsterite cylinder; the matrix is composed of small grains of forsterite and Na-CMAS basaltic glass. The bright small balls are metallic droplets produced by the destabilization of a thin layer of Au<sub>80</sub>Pd<sub>20</sub> sputtered on the faces of the forsterite cylinder

In our experiments, a system composed of forsterite 193 monocrystal(s) in contact with a haplobasaltic melt is sub-194 jected to a temperature gradient. In a first series of experi-195 ments, we used the experimental configuration A, in which 196 a single forsterite crystal (Fig. 2a) about 1-2 mm thick is AQ2immersed in haplobasalt. In the final series, we used the 198 configuration B, in which a liquid layer of the order of mm 199 is sandwiched between two crystals (Figs. 1, 2b). Based on 200 temperature calibration experiments, we adjusted the posi-201 tion of the capsule into the piston-cylinder assembly so that 202 its bottom was less than 1 mm below the hot spot in every 203 experiment (Figs. 2 & S1). Consequently, most of the cap-204 sule (70-80%) was above the hot spot and was subjected to 205 a temperature decreasing upwards. 206

The principle of our thermal migration experiments is best explained by considering configuration B (Figs. 1, 2b). 208 In type B experiments, the opposite faces of the cylinders are at temperatures  $T^+$  (upper face of lower cylinder) and  $T^-$  (lower face of the upper cylinder), with  $T^+ > T^-$ . Let us assume that the liquid is homogeneous at the beginning, with a composition in equilibrium with forsterite at the mean temperature  $(T^+ + T^-)/2$ . As forsterite solubility depends on temperature, the liquid is slightly oversaturated in forsterite on the colder side of the liquid layer, and undersaturated on the hotter side. This situation triggers a process of forsterite dissolution, transport, and precipitation. The driving force is

proportional to the temperature difference  $\Delta T = T^+ - T^-$ , and 219 we assume that the degree of undercooling along the upper 220 face of the monocrystal and the degree of superheating on 221 the lower face are equal to  $\approx \Delta T/2$ . Thus, for a thermal gra-222 dient of 6 °C/mm (typical of type B experiment; see below) 223 and a melt thickness of 1 mm, the degree of undercooling 224 driving forsterite growth will be 3 °C. Type B configuration 225 provides a straightforward path for solute transport from the 226 dissolution site to the precipitation site (Fig. 1). 227

In theory, the same reasoning applies to experimental 228 configuration A (Fig. 2a), with a difference of temperature 229 between the lower face of the forsterite monocrystal and its 230 upper face equal to the thermal gradient times the thick-231 ness of the monocrystal. In this case, we expected the lower 232 face of the forsterite to dissolve, the dissolved components 233 to be transported upwards (in the thin melt layer between 234 the forsterite and the platinum wall), and the upper face of 235 the forsterite to crystallize. In practice (see "Results"), we 236 observed that at the end of type A experiments, the plati-237 num capsule was pressed against the forsterite monocrystal 238 and that there was almost no melt layer left to transport the 239 dissolved forsterite components upwards. Hence, the upper 240 and lower parts of the sample behaved as two independent 241 subsystems in all type A experiments. 242

### Sample preparation

In type A geometry (runs A0, A2 and A4; Fig. 2a; Table 3), 244 the sample was composed of a forsterite cylinder embedded 245 in a mixture of haplobasaltic glass and small grains of forst-246 erite (33 wt% forsterite/67 wt% glass). The purpose of add-247 ing micron-sized grains of forsterite in type A experiments 248 was to ensure a fast establishment of equilibrium between 249

forsterite and liquid at the beginning of the experiments. In type B geometry (runs B1, B6–9; Fig. 2b), a layer of pure haplobasaltic glass was sandwiched in between two forsterite cylinders.

In all type A experiments and in experiments B1, B6 and 254 B9, the cylinders were drilled along the *a*-axis of the for-255 sterite lattice (i.e., perpendicular to (b, c) plane; see Fig. 256 S2). Some cylinders were prepared differently to explore 257 the effect of crystal orientation on growth mechanisms: cyl-258 inders of run B7 were prepared parallel to b-axis, and those 259 in B8 were drilled along the *c*-axis of the starting forsterite 260 single crystal (Fig. S2). The others axes of the cylinders 261 were not constrained due to free rotation during their inser-262 tion in the capsule. 263

The faces of forsterite cylinders can advance or recede 264 several hundred microns during an experiment due to pre-265 cipitation or dissolution, respectively. To measure precisely 266 these displacements, it is necessary to be able to locate the 267 initial position of the forsterite faces. We used a Denton 268 Vacuum Coater to sputter the planar surfaces of each forst-269 erite cylinder with a layer of Au<sub>80</sub>Pd<sub>20</sub> (except in two experi-270 ments, B1 and A2, to compare the dissolution and growth 271 textures with and without gold-palladium sputtering). At 272 run temperature, the thin layer (a few tens of nanometers) 273 decomposes into an array of coplanar droplets, which mark 274 the original surfaces without disturbing the dissolution and 275 precipitation processes (Fig. 2c). The decomposition of the 276 continuous Au-Pd layer into droplets is due to the fact that 277 the experiments are run well above the melting temperature 278 of the alloy and that when the alloy layer melts, it breaks 279 down into droplets to minimize interfacial energy. 280

### 281 Thermal profile

Our experiments were conducted at constant temperature, 282 the main driving force for forsterite growth and dissolution 283 being the temperature difference along the sample height. 284 In a piston-cylinder assembly, the temperature difference 285 between the top and the bottom of a sample depends on 286 its vertical position relative to the hot spot of the furnace 287 (Fig. 2a). The thermal profile along the axis of our pis-288 ton-cylinder assemblies has been calibrated previously using 289 either multiple temperature readings (up to five) at different 290 heights or the reaction MgO +  $Al_2O_3 \rightarrow$  spinel (Watson et al. 291 2002) (Fig. S1). These calibrations show that the position of 292 the hot spot is rather well constrained: it is at  $17 \pm 0.5$  mm 293 from the basis of the assembly, with values closer to 294 16.5 mm at high temperatures (1200 °C and above). This is 295 about the mid-height of the furnace (34.3 mm high, includ-296 ing a 1.3-mm-thick graphite disc at the top). In our experi-297 mental configuration, the thermocouple tip is located at a 298 height of 14.5 mm, that is about 2 mm below the hot spot, 299 and the temperature difference between the thermocouple 300

and the hot spot is 20  $^{\circ}$ C (note that the temperatures in Table 3 are the thermocouple temperatures; Fig. S1). There is a thin alumina disc separating the thermocouple tip and the platinum capsule, and the bottom of the silicate sample is located 0.5-0.7 mm below the hot stop (depending on the thickness of the platinum weld at the bottom of the capsule). 306

To estimate the temperature at the top of the capsules (the 307 low-temperature side, on the opposite side to the thermocou-308 ple tip), we relied on two independent techniques: (1) the 309 temperature calibration curve in Fig. S1, and (2) the appear-310 ance of secondary mineral phases (spinel and clinopyroxene) 311 using the phase diagram of our CMAS-Na haplobasaltic 312 composition as reference (M. Hardiagon, personal commu-313 nication). At 10 kbar, the liquidus temperature lies between 314 1450 and 1425 °C, and the liquidus phase is forsterite (Fo). 315 The second solid phase that crystallizes at 10 kbar is spinel 316 (Sp), which appears between 1400 and 1375 °C, and the 317 third one is clinopyroxene (Cpx), which appears between 318 1350 and 1300 °C. At 1300 °C, Cpx and plagioclase (Pl) 319 are stable, in addition to Fo and melt, while spinel is absent. 320 To compute the temperature difference between the bottom 321 and the top of the samples, we considered that the Spl- and 322 Cpx-in temperatures are equal to 1385 (±10 °C) and 1330 323  $(\pm 20 \,^{\circ}\text{C})$ , respectively. 324

The thermal data are summarized in Table 4. The tem-325 perature difference between the warmest and the coldest 326 regions of a capsule ranges from 20 to 80 °C depending 327 on the length of the capsule. The 80 °C difference corre-328 sponds to experiment A2, which was the one with the long-329 est capsule (5.1 mm); it is the only one in which Cpx was 330 found at the top of the capsule (see below). The temperature 331 difference between the two faces of a forsterite cylinder in 332 type A experiments ranges from 8 to 25 °C, depending on 333 their thickness and position in the capsule. The melt layer 334 in type B experiments is placed about 1 mm above the hot 335 spot; thus, the temperature difference across the glass layer 336 between the two forsterite cylinders is less than ~ 10 °C 337 and the thermal gradient is typically 5-6 °C/mm (Fig. S1), 338 except in B1 (10 °C/mm) because the capsule was longer. 339

### **Analytical techniques**

At the end of an experiment, the whole platinum capsule 341 was mounted in epoxy, sectioned lengthwise, polished and 342 carbon coated. Textures of the experimental products were 343 observed with a JEOL JSM-5910 LV scanning electron 344 microscope (SEM). Crystal fractions and sizes were deter-345 mined from SEM photographs of 2D sections (automatic 346 threshold based on the gray level) using SPO2003 software 347 (Launeau 2004). Crystal orientation and face recognition 348 were done from interfacial angle measurements following 349 Welsch et al. (2013). Chemical analyses of the run prod-350 ucts were made by electron probe microanalysis (EPMA) 351

using a Cameca SX 100. Analytical conditions were focused beam (<1  $\mu$ m)—15 nA and 22 kV for crystals—and unfocused beam (<15  $\mu$ m)—8 nA and 15 kV for glasses—during 10+20+10 s (background, sample, background). The probe was calibrated using wollastonite, corundum, albite and forsterite standards.

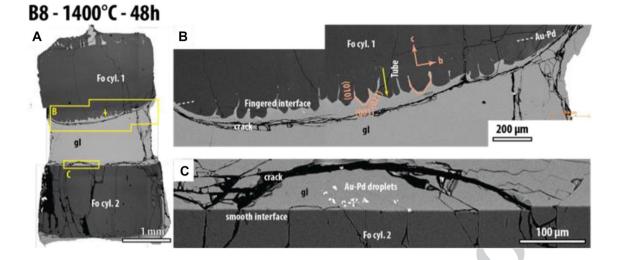


**Fig.3** SEM photographs of experiment B6 (1400 °C, 101 h). **a** Overview of the sample at low magnification. Black regions are due to decompression cracks and crystal snatching, white areas are the platinum capsule, and bright and dark gray are glass (gl) and forsterite (Fo), respectively. **b** Enlargement of the upper part of the sample showing dissolution of the upper face of forsterite cylinder 1 and crystallization of large euhedral forsterite hosting melt inclusions (MI). The dissolution of the upper part of the cylinder is indicated by the Au–Pd droplets deposited on its surface and by the gap between the glass–cylinder interface and the capsule shrinkage (dashed orange arrow). The *a*-axis direction is indicated by an arrow. **c** Enlargement

The textural results are illustrated in Figs. 3, 4, 5, 6, 7, and supplementary Figures S3 and S4. In all figures, the polarity of the sample during the experiment is respected (that is, the lower part of the microphotograph corresponds to the bottom of the sample in the hot spot). The location of electron probe microanalyses is shown using the same shape and color

codes in Figs. 3, 4, 5, 6, and 7. If we put aside experiment365A0 that was quenched shortly after heating, major changes366in the thickness of the forsterite cylinders and in the shape367of their surfaces occurred during all experiments due to dissolution and precipitation processes.368

## Dissolution and precipitation textures: type B experiments

370 371

Experiments B6–B9 (Figs. 3, 4, S3–S4) show the evolution of type B geometry with increasing duration (at T=1400 °C). This geometry is designed to produce a dissolution/precipitation process in three steps (Fig. 1): (1) dissolution of the upper face of the lower cylinder, which is at a higher temperature; (2) solute transport upwards through the melt layer; (3) precipitation along the lower face of the 378

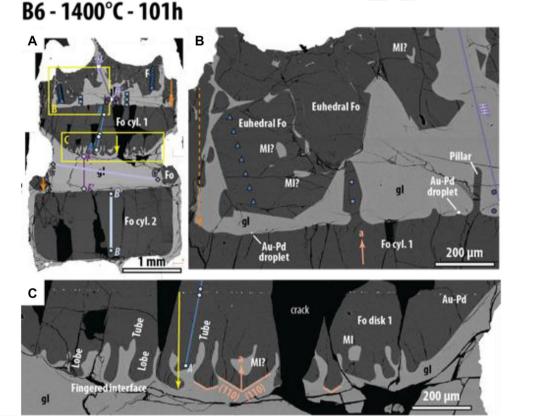

upper cylinder (at a lower temperature). The most obvious 379 380 textures are those associated with step (3), especially after 101 h and 48 h (Figs. 3c, 4b). In these figures, an alignment 381 of Au-Pd droplets is visible deep inside the forsterite cyl-382 383 inder: it corresponds to the Au-Pd layer that was sputtered on the original surface. The thickness of the precipitated 384 layer (measured from the alignment of Au-Pd droplets to 385 the forsterite front) measures 170 um after 48 h and 340 um 386 after 101 h. As presented below, the alignment of Au-Pd 387 droplets corresponds also to a compositional limit (for minor 388 elements: Al, Ca) between the starting synthetic forsterite 389 and the newly grown forsterite. 390

A striking feature is that the precipitation process does 391 not produce a planar front of forsterite advancing at the 392 expense of liquid. There is a kind of self-organization that 393 develops, in which domains of faster growth give rise to 394 forsterite lobes protruding into the liquid. As a result, the 395 growth front shows a fingered outline in two dimensions 396 (2-D), with solid lobes separated by tubes of glass that are 397 398 roughly perpendicular to the growth front (Figs. 3c, 4b). The average lobe spacing is of the order of 0.1 mm (that 399 is, 10 lobes per mm of interface). The longest tubes can be 400 up to ~150  $\mu$ m deep, but are still shorter than the growth 401 layer (that is, they do not reach the alignment of Au-Pd 402 droplets). The lobes are elongated parallel to the orienta-403 tion of the forsterite cylinder: parallel to a-axis in run B6 404 and parallel to c-axis in run B8. Facets controlled by the 405 crystallographic orientation of the cylinder develop at the 406 407 growth front (Figs. 3c, 4b, S3C and S4B); in Fig. 3c, these crystallographic facets join to form pyramids with sharp 408 edges. In some cases, neighboring lobes merge at their ends 409 and thus entrap melt in the observed section. We checked 410

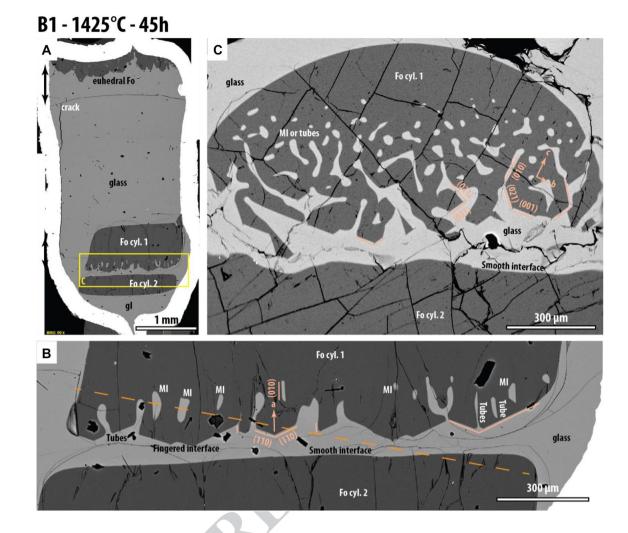

by optical microscopy that some of these regions of trapped 411 melt in 2-D are real glass inclusions in 3-D (i.e., inclusions 412 totally closed). 413

As expected, the upper face of the lower cylinder receded 414 due to dissolution. This is not obvious at first glance because 415 it remained almost flat (Figs. 3a, 4c, S3A, S4C). In experi-416 ment B9 (23 h; Fig. S4C), the slightly curved alignment of 417 Au-Pd droplets visible in the glass few tens of µm above 418 the forsterite cylinder demonstrates that the upper part of 419 the lower cylinder has been dissolved. The Au-Pd align-420 ment is no longer visible in the longer duration experiments, 421 but there are still a few larger Au-Pd droplets visible either 422 suspended in the glass or fallen on the receding forsterite 423 surface (Fig. 4c). The dissolution of the lower cylinder is 424 also demonstrated by the downward displacement of the 425 upper surface compared to its initial position marked by the 426 shrinkage of the capsule (displayed by an orange arrow on 427 Fig. 3a). This shrinkage is due to a higher degree of compac-428 tion of glass powder compared to forsterite cylinder during 429 the compression at the beginning of the experiment. Finally, 430 the forsterite right below the receding surface has levels of 431 CaO and Al<sub>2</sub>O<sub>3</sub> recalling those in the starting synthetic for-432 sterite and lower than those expected at equilibrium with the 433 haplobasaltic melt (see below). 434

In our first type B experiment (B1), we used a slightly 435 different initial configuration, including forsterite cylinders 436 with a smaller outer diameter (2 mm instead of 2.5 mm). 437 Figure 5a shows that this configuration was not stable and 438 that the upper forsterite cylinder fell into the lower part of 439 the liquid reservoir. We observe, however, the same textures 440 as above: dissolution along the top of the lower cylinder 441 produced a flat surface and rounded cylinder edges, and 442

The melt 445 inclusions are especially well developed in this experiment, 446 reaching up to 80 µm and showing a range of shapes from 447 rounded, to ovoid, to negative crystals. A section perpen-448 dicular to the growth front is illustrated in Fig. 5c. On a tech-449 nical point of view, it is interesting to note that experiment 450 B1, in which the forsterite cylinders were not sputtered with 451 Au-Pd, shows the same microtextures as in experiments 452 with Au-Pd-sputtered forsterite cylinders. Accordingly, the 453 precipitation and dissolution processes are not affected by 454 455 the presence of droplets of gold-palladium.

Unlike the sketch in Fig. 2b, some of the liquid was able
to sneak above the upper cylinder during type B experiments
(and to a lesser extent under the lower forsterite cylinder).

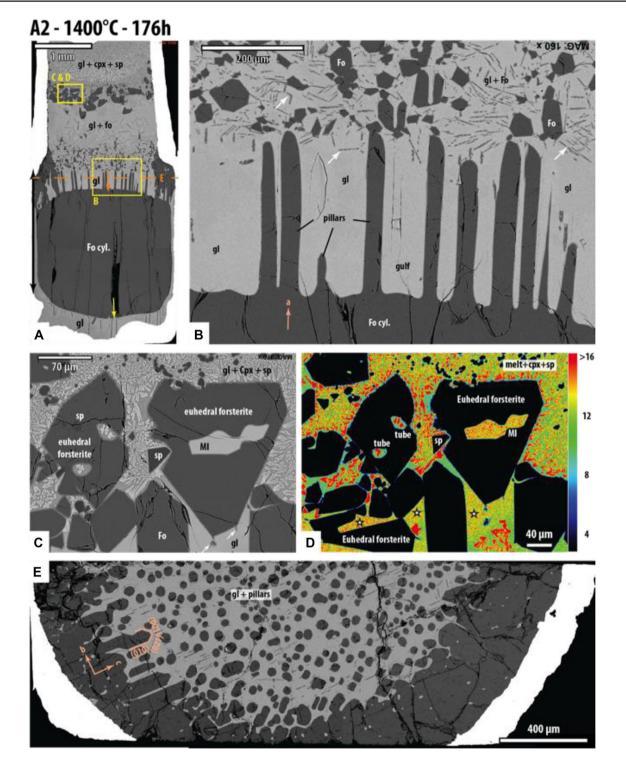

As a result, a second dissolution-precipitation cell operated 459 at the top of the capsule, as a parallel system. The effect is 460 best visible in experiment B6 (Fig. 3), with the recession of 461 the upper face of the top forsterite cylinder and the growth 462 of large euhedral crystals of forsterite hanging from the roof 463 of the capsule. The dissolution of the upper face left a few 464 vertical pillars of forsterite standing several hundreds of 465 microns above a slightly wavy floor (on the right of Fig. 3b). 466 These special features are best visible in type A experiments 467 and will be discussed below. 468

## Dissolution and precipitation textures: type A experiments

A major complication arose in runs A2 (1400 °C, 176 h; 471 Fig. 6) and A4 (1425 °C, 48 h; Fig. 7) due to the absence of 472

connection or the poor connection between the lower face of 473 the forsterite cylinder and its upper face. As a result, the sys-474 tem did not work as sketched in Fig. 2A because two inde-475 pendent subsystems developed in the lower half and upper 476 half of capsules. In the lower half, the lower face of the 477 forsterite cylinder grew at the expense of the small forsterite 478 grains at the bottom of the capsules, giving rise to crystal-479 480 free layers right below the forsterite cylinder (Figs. 6a, 7c). Forsterite overgrowth is best visible in run A4 owing to the 481 presence of a distinct alignment of Au-Pd droplets in the 482 cylinder, 200 µm behind the front. In the upper half of the 483 capsules, the upper face of the forsterite cylinder underwent 484 dissolution (see below) and large, euhedral forsterite crystals 485 grew at the top of the capsules (Figs. 6a, 7a). These crys-486 tals are  $\approx 100-800 \,\mu\text{m}$  in size. They have euhedral outlines, 487 with planar faces and sharp edges; some of them show large 488 embayments and contain glass inclusions (Fig. 6c). Large 489 euhedral crystals are actually present in all experiments of 490 A and B types (Figs. 3, 4, 5, 6, 7, S3 and S4). In all cases, 491 they are located at the top of the capsule, which is the coldest 492

part of the system. In experiment A2, they are not right at the top, but just below a layer of clinopyroxene + spinel + glass, which occupies the upper part of the capsule (Fig. 6a).

Type A experiments show a very special kind of disso-496 lution texture: in experiments A2 and A4, the upper face 497 of the forsterite cylinder displays vertical pillars standing 498 several hundreds of microns above a slightly wavy floor 499 (Figs. 6b, 7b). There is no doubt that these pillars represent 500 a dissolution texture because we found some Au-Pd drop-501 lets kept at the top of the pillars or hanging on their walls 502 (Fig. 7e; they are absent in run A2, in which the forsterite 503 cylinder had not been sputtered with Au-Pd), and because 504 the forsterite making the pillars has low levels of CaO and 505 Al<sub>2</sub>O<sub>3</sub>, which approach the levels of the starting synthetic 506 forsterite and which are lower than those measured in forst-507 erite grown from the haplobasaltic melt (see below). In addi-508 tion, all overgrowth layers show a very distinct alignment of 509 entrapped Au-Pd droplets underlining the original forsterite 510 surface (for example, sample A4 in Fig. 7c); as we do not see 511 any Au-Pd droplets entrapped at the basis of the pillars in 512

Fig. 7b, the forsterite pillars are not growth textures. There 513 is also a geometrical argument because the initial position 514 of the upper face of the cylinder is marked by a kink in 515 the platinum wall (Figs. 6a, 7a); the vertical pillars are well inside the original outline of the forsterite cylinders. Finally, we observe that small forsterite crystals (from the starting material) are present in the glass above the dissolution zone, but not in the dissolution zone between the pillars (e.g., the "gulfs" in Fig. 6b).

We prepared a cross section through the layer of forst-522 erite pillars and glass of sample A2 (Fig. 6e). In the center 523 of the sample, the pillars form numerous, sub-rounded sec-524 tions isolated in glass with ~35  $\mu$ m diameter and a density 525 of 254 pillars per mm<sup>2</sup> (Fig. 6e). Toward the rim, the for-526 sterite increases in proportion relative to glass and it forms 527 polyhedral sections or rods. It is important to note that the 528 forsterite sections from all sides of the capsule display the 529 same crystallographic orientation, which demonstrates that 530 all these crystal units correspond to the same initial forsterite 531 crystal before dissolution. In addition to the forsterite pillars 532 in experiments A2 and A4, a few pillars are also observed 533 in experiment B6 (Fig. 3a, b). Given the crystallographic 534 orientations of the forsterite cylinders in these experiments, 535 the pillars are all elongated preferentially along the *a*-axis 536 of forsterite. 537

#### Mineralogical stratification and temperature 538 gradient 539

The presence of Sp or Sp + Cpx (in addition to Fo + melt) 540 primarily depends on the nominal temperature of the experi-541 ment (1400 or 1425 °C) and on the length of the capsule 542 (3.1–5.1 mm; Table 4). Clinopyroxene was only found 543

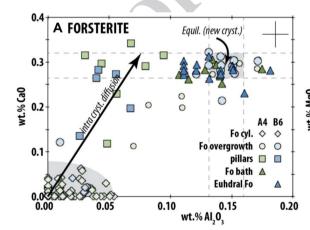


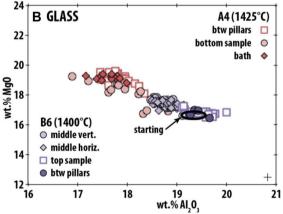

at the top of experiment A2 (Fig. 6), which was made at 544 1400 °C with a capsule length > 5 mm. Thus, this combina-545 tion resulted in a temperature lower than 1330 °C at the very 546 top of the capsule. A few small Sp crystals, but no Cpx, were 547 observed in the layer of large euhedral forsterites at the top 548 of experiments B1 and A4, indicating a temperature lower 549 than 1385 °C but higher than 1330 °C. Again, the presence 550 of an additional phase is related to the length of the samples 551 (4.5 mm). In all other experiments (B6–B9), the capsule 552 length was < 4.3 mm, and the only solid phase was forsterite 553 even when the nominal temperature was 1400 °C. If we take 554 into account the temperature difference between the ther-555 mocouple reading and the maximum temperature at the hot 556 spot (Watson et al. 2002), the temperature interval in these 557 experiments was < 35 °C (Table 4). 558

**Chemical results** 

Chemical compositions of forsterite are presented in Fig. 8a 560 and Table 2. Three main populations can be identified: com-561 positions similar to the starting forsterite, compositions in 562 equilibrium with the haplobasaltic melt at experimental con-563 ditions and intermediate ones. The starting forsterite is char-564 acterized by a molar ratio Mg/Si of about 1.99, and negligi-565 ble levels of CaO and  $Al_2O_3$  (<0.02 wt%). The population 566 similar to the composition of starting forsterite has CaO and 567 Al<sub>2</sub>O<sub>3</sub> concentrations lower than 0.05 wt% and corresponds 568 to the inner parts of forsterite cylinders, from the interface 569 on the dissolution side to the initial forsterite-melt interface 570 revealed by the alignment of Au–Pd droplets (Figs. 3, 7, 8a). 571 The equilibrium forsterite composition is best represented by 572 the small forsterite grains in experiments such as A4, which 573 have an average Mg/Si ratio of 1.98 and concentrations of 574



showing glass compositions in experiments A4 and B6. The location of analyses is shown in Figs. 3 and 7. Quench crystallization of forsterite at the end of the experiments led to glass compositions locally strongly depleted in MgO and enriched in Al<sub>2</sub>O<sub>3</sub> (see also Fig. 9)

CaO and Al<sub>2</sub>O<sub>3</sub> equal to  $\sim 0.30$  and 0.15 wt%, respectively 575 (Table 2). These relatively large concentrations are typical 576 of forsterite in equilibrium with basaltic melts at high tem-577 peratures (Libourel 1999). For Al<sub>2</sub>O<sub>3</sub>, the data in sample 578 A4 yield a forsterite/liquid partition coefficient of  $\sim 0.01$ , 579 consistent with values of 0.003-0.02 reported by (Pack and 580 Palme 2003) (Fig. 8a). The layers of forsterite overgrown on 581 the initial cylinders and the large, euhedral forsterite crystals 582 are also in equilibrium with the haplobasaltic melt. 583

The intermediate population of forsterite compositions is 584 associated with the pillars in the dissolution zones, with CaO 585 concentrations approaching the equilibrium defined above 586 and low aluminum contents (< 0.10 wt%; Fig. 8a). In fact, 587 there is a gradient from the inner parts of the pillars, which 588 have very low levels of CaO and Al<sub>2</sub>O<sub>3</sub> (down to 0.12 wt% 589 and 0.03 wt%, respectively; Table 2) to the rims in contact 590 with haplobasalt, which contain significant concentrations of 591 these two oxides, especially CaO (Fig. S5). The low levels of 592 CaO and Al<sub>2</sub>O<sub>3</sub> in the inner parts of the pillars are a strong 593 argument for an origin of this special texture by dissolu-594 tion. The enrichment in CaO and Al<sub>2</sub>O<sub>3</sub> in the outer parts 595 is presumably due to a process of reequilibration with the 596 surrounding melt, with CaO diffusing faster than Al<sub>2</sub>O<sub>3</sub> in 597 the forsterite crystalline lattice. The effect of solid-state dif-598 fusion can also be observed along profiles performed across 599 the Au–Pd droplet alignments (Fig. 9a); the CaO concen-600 tration profiles measured in B6 and A4 experiments show 601 different slopes that are consistent with the run durations. 602 The dissolution side of forsterite cylinders is also likely to 603 be affected by calcium diffusion up to  $\sim 80 \,\mu\text{m}$  from the melt. 604

Glass compositions analyzed in experiments A4 and B6 605 are shown in Fig. 8b. The interpretation of glass composi-606 tions is complicated by the late crystallization of forsterite 607 during the quench, which results in a strong depletion of 608 MgO (down to 14 wt%) and enrichment in CaO and Al<sub>2</sub>O<sub>3</sub> 609 (Fig. 8b). In fact, MgO depletion is observed over a thick-610 ness of several tens of micrometer wherever the glass is in 611 contact with forsterite and is particularly visible in tubes on 612 the precipitation side and in gulfs close to pillars on the dis-613 solution side of forsterite cylinders (e.g., Fig. 7d-e). Putting 614 aside the compositions analyzed close to forsterite, the glass 615 contains in average  $\approx 19.1$  wt% MgO and 17.8 wt% Al<sub>2</sub>O<sub>3</sub> 616 in sample A4, and  $\approx 16.8$  wt% MgO and 19.5 wt% Al<sub>2</sub>O<sub>3</sub> 617 in sample B6 (Table 1). Glass B6 is close to the starting 618 glass (16.4 wt% MgO and 19.4 wt% Al<sub>2</sub>O<sub>3</sub>) whereas glass 619 A4 is strongly enriched in MgO and depleted in Al<sub>2</sub>O<sub>3</sub> in 620 comparison to the starting glass, indicating bulk forsterite 621 dissolution during this experiment. The difference in glass 622 compositions between A4 and B6 is due to the difference 623 in temperature: 1400 °C in run B6 vs. 1425 °C in run A4. 624 Accordingly, the average MgO content in melt increases by 625 2-2.5 wt% for a temperature increase of 25 °C, that is, a 626 variation of 0.08-0.1 wt% MgO/ °C. 627

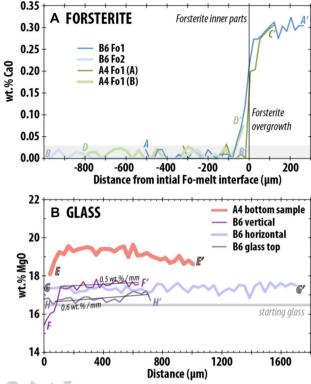
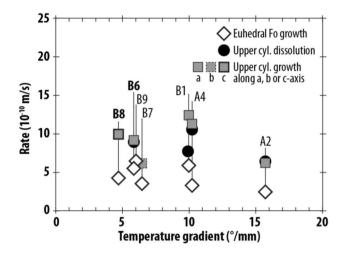

The melt inclusions of experiments A2, A4 and B1 are 628 texturally homogeneous with no crystals discerned but 629 chemical mapping reveals a heterogeneous distribution of 630 calcium or magnesium (Figs. 6d, 7d). Chemical gradients in 631 glass inclusions are due to crystallization of the host forster-632 ite during the quench. Even the cores of the glass inclusions 633 yield compositions depleted in MgO (8.5–14 wt%; Table 1) 634 in comparison to the compositions measured far from any 635 forsterite. Accordingly, they do not reflect equilibrium con-636 ditions. Based on the compositions of forsterite, equilibrium 637 glass composition, and glass in the melt inclusion of experi-638 ment A4 (Fig. 7a), we estimate that about 24 wt% of the melt 639 inclusion crystallized during the quench, forming a layer of 640 forsterite a couple of microns thick along the walls. 641

### **Rates of dissolution and growth**

The growth rate (vGrowth, m/s) of the cylinders was deter-643 mined from the maximum thickness of the growth layer 644 (beyond the Au-Pd sputtering line) divided by run duration 645 (Fig. 10). Similarly, the growth rate of euhedral crystals was 646 calculated by dividing the mean size of the largest crystals 647

by time. To estimate the dissolution rate, we computed the 648 thickness of the dissolution layer as the initial cylinder thick-649 ness plus the thickness of the growth layer minus the final 650 651 cylinder thickness. The thickness of dissolved forsterite can always be closely confirmed by measuring the distance 652 between the final position of the cylinder surface and its ini-653 654 tial position marked by the kinks of the capsule wall due to shrinkage, assuming no displacement of the cylinder. In type 655 B experiments, only the upper cylinder was characterized so, 656 because it gives access to both dissolution and growth. The 657 growth rates and dissolution rates range from  $5.0 \times 10^{-10}$  to 658  $1.2 \times 10^{-9}$  m/s (Table 4; Fig. 10). The growth rate of large, 659 euhedral forsterite ranges from  $2 \times 10^{-10}$  to  $7 \times 10^{-10}$  m/s. 660

### 661 Discussion

## Thermal migration as a technique to study growth and dissolution of crystals in silicate liquids

We were able to produce regular growth or dissolution layers 664 665 reaching thicknesses up to 400 µm by placing monocrystalline cylinders of forsterite into a haplobasaltic melt in a 666 temperature gradient. Of the two experimental configura-667 668 tions tested (Fig. 2a, b), type B involving a layer of melt sandwiched between two forsterite cylinders is by far the 669 more suitable for a quantitative study (Fig. 1). The main 670 advantage is that the transport step of the dissolution/pre-671 cipitation process is straightforward in comparison to type 672 A experiments, in which the dissolved forsterite components 673 674 have to find their way between the cylinder wall and the capsule. A potential improvement for the future would be to use 675 forsterite cylinders whose faces correspond to natural faces 676 of olivine phenocrysts. Our experiments show, however, that 677

similar growth and dissolution textures develop on starting 678 surfaces with different crystallographic orientations. Sput-679 tering a thin layer of Au-Pd over the cylinder faces is of 680 great help to locate the initial forsterite-melt interfaces and 681 to quantify the thickness of the growth layers. Since the 682 same textures are observed in experiments with and without 683 sputtering, the thin layer of gold-palladium does not seem 684 to disturb the dissolution/precipitation processes as long as 685 experiments are run at temperature above the melting point 686 of Au-Pd. 687

As discussed in "Introduction", thermal migration 688 encompasses two diffusion potentials that operate simulta-689 neously: saturation gradient chemical diffusion and Soret 690 diffusion. To evaluate the relative importance of these two 691 components, we computed separately the variations of melt 692 composition arising from Soret effect and saturation gra-693 dient. Using the Soret coefficients for SiO<sub>2</sub>, Al<sub>2</sub>O<sub>3</sub>, MgO, 694 CaO and Na<sub>2</sub>O determined experimentally for a MORB 695 composition (Lesher and Walker 1988; Walker and Agee 696 1988), the composition of melt in experiment B6 (16.81 wt% 697 MgO; Table 1), and considering two points separated by 698 1 °C, we obtain a variation of MgO equal to  $0.45 \times 10^{-3}$  in 699 molar fraction (or a variation of 0.03 wt% MgO). This is 700 almost three times smaller than the variation of MgO due 701 to saturation:  $1.19 \times 10^{-3}$  in mole fraction per °C (based on 702 the difference in liquid compositions in the experiments at 703 1400 and 1425 °C, B6 and A4, respectively). Accordingly, 704 the dominant process in our thermal migration experiments 705 is saturation gradient chemical diffusion, but Soret effect is 706 not negligible. 707

The total flux, J (in moles per unit area per unit time), associated with thermal migration is (Lesher and Walker 1988; Walker and Agee 1988)

$$I = -D\frac{\mathrm{d}c}{\mathrm{d}z} - D'c\frac{\mathrm{d}T}{\mathrm{d}z},\tag{1}$$

where the first term on the right-hand side is the flux 713 arising from saturation gradient chemical diffusion, and the 714 second term is the flux arising from the temperature gradi-715 ent alone. Parameters are as follows: D (cm<sup>2</sup>/s), chemical 716 diffusivity; D' (cm<sup>2</sup>/s/ °C), thermal diffusion coefficient; c717  $(mol/cm^3)$ , solute concentration; z (cm), position along the 718 diffusion axis; T (°C), temperature. Introducing the Soret 719 coefficient  $\sigma = D'/D$  (°C<sup>-1</sup>), Eq. (1) can be rewritten: 720

$$J = -DdcdTLiq + \sigma cdTdz, \qquad (2)$$

where  $[dc/dT]_{Liq}$  is the variation of concentration with temperature along the liquidus. Equation (2) shows that the flux *J* is directly proportional to the temperature gradient and is constant as long as the saturation relations and temperature remain unchanged (Lesher and Walker 1988; Walker and Agee 1988). 727

where  $v_{\text{Growth}}$  is the growth rate (cm/s) and  $V_{\text{Fo}}$  is the molar 733 volume of forsterite ( $\approx 46 \text{ cm}^3/\text{mol in our experimental con-}$ 734 ditions; (Li et al. 2007)). Thus, if as expected, the flux is 735 time independent, then the growth rate of forsterite remains 736 constant during a thermal migration experiment. Using the 737 relation  $c = m\rho/M$ , where *m* is the mass fraction of an oxide, 738 M its molar mass, and  $\rho$  is the liquid density (assumed con-739 stant:  $2.7 \text{ g/cm}^3$ ), we can recombine (1) and (3) into 740

$$\frac{2\nu_{\text{Growth}}}{V_{\text{Fo}}} = -\frac{D_{\text{MgO}}\rho}{M_{\text{MgO}}} \left(\frac{dm_{MgO}}{dz} + \sigma_{\text{MgO}}m_{\text{MgO}}\frac{dT}{dz}\right).$$

For experiment B6, we have  $v_{\text{Growth}} = 9.4 \times 10^{-8} \text{ cm/s}$ , 742  $m_{\rm MgO} = 0.1681, \ dm_{\rm MgO}/dz = -0.05 \ {\rm cm}^{-1}$  (Fig. 9b), dT/743 dz = -58 °C/cm (Table 4); the Soret coefficient  $\sigma_{MgO}$  is 744 equal to 0.00239 (Lesher and Walker 1988; Walker and 745 Agee 1988). Thus, we obtain a chemical diffusivity  $D_{MoO}$ 746 equal to  $7.8 \times 10^{-7}$  cm<sup>2</sup>/s, which is in good agreement with 747 the chemical diffusivity estimated from previous thermal 748 migration experiments run at conditions close to ours:  $D \approx$ 749  $10^{-6} \text{ cm}^2/\text{s}$  (Walker et al. 1988). 750

#### **Dissolution and growth of forsterite** 751 in a temperature gradient 752

The eight experiments of this study yielded qualitatively 753 similar dissolution and growth textures: a planar or slightly 754 wavy forsterite-melt interface, residual pillars (mostly in 755 type A experiments), and rounded cylinder edges in dis-756 solution areas; fingered forsterite-melt interfaces with melt 757 tubes and melt inclusions in the growth areas. We, therefore, 758 conclude that these textures are independent of temperature 759 over the small range investigated (1400–1425 °C; Table 3), 760 forsterite over glass ratio (in the range 0.25–0.83; Table 3), 761 and run duration (no qualitative difference between experi-762 ments A2 and A4 conducted for 176 and 48 h, respectively). 763 Concerning the dissolution textures, the smooth 764 melt-crystal interfaces and rounded cylinder edges produced 765 here are similar to textures described in previous experi-766 mental work (Zhang et al. 1989; Donaldson 1990; Soulié 767 et al. 2017). The pillars represent, however, an original 768 texture undocumented in the literature to our knowledge, and do not follow the rule that olivine dissolution produces almost perfect planar interfaces (Zhang et al. 1989; Chen 771 and Zhang 2008). We suggest the following scenario. At the 772 beginning of the experiment, the upper face of the cylinder 773

was at the level of the tops of the pillars. Because of its 774 higher temperature relative to the upper part of the capsule. 775 it began to dissolve and recede. With time, the original face 776 retreated several hundred micrometers except in areas that 777 were somehow protected from dissolution and that gave rise 778 to the vertical pillars. As the most characteristic pillars are 779 found in runs A2 and A4, the presence of suspended crys-780 tals above the forsterite cylinder is presumably the reason 781 why some areas have remained immune to dissolution. As a 782 matter of fact, a number of pillars are capped by a small for-783 sterite grain (at the center of Fig. 6b, or on the right side of 784 Fig. 7b), and thus resemble the so-called fairy chimneys. In 785 contrast, type B experiments, in which there were no crystals 786 in suspension above the forsterite cylinder, show dissolution 787 surfaces almost perfectly planar with only rare pillars or no 788 pillars at all. 789

Most pillars are robust structures: their length increases 790 with time (by dissolution of the neighboring forsterite) since 791 they are best developed in the longest duration experiment 792 (A2). Some pillars may, however, become unstable with 793 time. For instance, there are a few short pillars in Fig. 6b 794 that may be in the process of resorption. At this stage, our 795 experimental database is not sufficient to establish any sys-796 tematic relationship between the width or the spacing of the 797 pillars and the experimental parameters (time, temperature, 798 crystal orientation). 799

### Melt composition on the dissolution and precipitation sides of forsterite cylinders

During the experiments, the melt in contact with forsterite 802 is anticipated to be slightly enriched in MgO and depleted 803 in CaO and Al<sub>2</sub>O<sub>3</sub> (in comparison to the average melt com-804 position) on the dissolution side of forsterite cylinders, and 805 slightly depleted in MgO and enriched in CaO and Al<sub>2</sub>O<sub>3</sub> 806 on the precipitation side. We do not have access to the equi-807 librium glass composition at the contact with forsterite due 808 to the effect of quench crystallization. To circumvent this 809 difficulty, we acquired three EPMA profiles in experiment 810 B6 (FF', GG', and HH'; Fig. 3a and Online supplementary 811 Table). Profile GG' is a nearly horizontal profile in the melt 812 layer between the two forsterite cylinders, and is rather flat 813 (Fig. 9b). Profiles FF' and HH' are vertical and extend from 814 a zone of forsterite growth to a zone of forsterite dissolu-815 tion. If we ignore the effect of quench crystallization (well 816 visible for instance close to F), we observe that the MgO 817 content in the glass increases very slightly with a gradient 818 of about 0.5-0.6 wt% MgO per mm from the growth side 819 to the dissolution side (Fig. 9b). Due to the effect of quench 820 crystallization, it is not possible to know the exact MgO 821 levels at the contact with the two forsterite cylinders, but the 822 difference in MgO between the dissolution and growth sides 823 is of the order of 0.35 wt%. Considering a variation of 0.08 824

to 0.1 wt% MgO/ °C for melt in equilibrium with forsterite 825 (see above), this difference of 0.35 wt% MgO corresponds 826 to a temperature difference  $\Delta T \approx 4$  °C, in good agreement 827 with the temperature gradient in experiment B6 (5.8 °C/ 828 mm; Table 4) and the thickness of the melt layer (640  $\mu$ m). 829 Accordingly, the well-developed growth layer on the lower 830 face of the upper forsterite cylinder and the thick dissolu-831 tion layer on the upper face of the lower cylinder formed 832 at degrees of undercooling and superheating, respectively, 833 of  $\approx 2 \,^{\circ}\text{C} \, (\Delta T/2)$ . 834

### 835 Cellular growth of olivine in basaltic melts

During the solidification of a melt, solid-melt interfaces 836 become unstable with increasing growth rate, evolving 837 from planar, to cellular, to dendritic. Cellular growth, which 838 occurs at low to intermediate growth rates, is well known in 839 metallurgy (Tiller et al. 1953; Shechtman et al. 1984), but 840 poorly documented in silicate systems and natural magmas. 841 Vermiform rims on spinel in natural basalts were interpreted 842 as the result of a cellular growth mechanism, when diffu-843 sion in the melt is no longer able to support the growth of 844 a smooth interface, creating protuberances (Roeder et al. 845 2001). Takei and Kobayashi suggested that cellular growth 846 was responsible for the shape and distribution of minute gas 847 bubbles in the core of large forsterite monocrystals grown 848 under a cooling rate of 300 °C/h (Takei and Kobayashi 849 1974). With the exception of this reference, cellular mor-850 phology is absent from the catalog of olivine shapes and 851 from the classical sequence from polyhedral, tabular, skel-852 etal to dendritic shape with increasing degree of undercool-853 ing and cooling rate (Donaldson 1976; Faure et al. 2003a). 854

Our experiments show that cellular growth may be a 855 major growth mechanism for olivine at low to moderate 856 degrees of undercooling (of the order of 2 °C in experi-857 ment B6, for instance) and growth rates of  $\approx 10^{-9}$  m/s. The 858 textures produced support the breakdown of a planar forst-859 erite-melt surface into a series of lobes, but we could not 860 relate the number, frequency or shape ratio of lobes to any 861 experimental parameter. We note, however, that cellular 862 growth occurs on surfaces with a lateral extension greater 863 than 1 mm (1.1 mm in experiment A4, and about 2 mm in 864 most cases). In comparison, the large euhedral forsterites 865 whose faces have a lateral extension of at most 300 µm, and 866 more commonly of the order of 100 µm, display a planar 867 morphology (Fig. 3b). This contrast is consistent with the 868 average spacing of lobes ( $\approx 100 \ \mu m$ ). Therefore, cellular 869 growth seems to require a minimum lateral extension of the 870 olivine-melt interface of the order of 1 mm. The formation 871 of a boundary layer enriched in the incompatible elements 872 rejected by the growing crystal and not able to diffuse away 873 fast enough could locally impede or slow down the crystal-874 lization and, beyond a certain value of the growth rate, cause 875

the switch from a planar growth front to a cellular morphology (Jackson 2004).

The rates of dissolution and crystallization of forsterite 878 cylinders and euhedral forsterites are limited to a narrow 879 range  $(4 \times 10^{-10} - 1.4 \times 10^{-9} \text{ m/s}; \text{ Table 4})$ . Those values 880 are very close to the growth rate observed for olivine with a 881 undercooling of 15 °C ( $2 \times 10^{-9}$  m/s) and to the one assessed 882 for lower undercooling values  $[6.3 \times 10^{-10} \text{ m/s}]$ ; (Jambon 883 et al. 1992)]. They fit into the range of natural growth rates 884 determined for olivines from Etna basalt  $[2 \times 10^{-11} \text{ m/s}]$ ; 885 (Armienti et al. 1994)] and from Lanzarote [ $\sim 3 \times 10^{-7}$  m/s; 886 (Armienti et al. 1991)] without and with a 30 °C under-887 cooling, respectively, and for olivine from an oceanic basalt 888 quickly chilled against sediments  $[3.2 \times 10^{-9} \text{ m/s}; (\text{Don-}$ 889 aldson 1975)], although these values were determined by 890 postmortem observation of the crystal size distribution. They 891 are slower by half an order of magnitude than the growth 892 rates measured in situ by (Ni et al. 2014) on olivine. In con-893 trast, the growth rates in our study are similar to the ones 894 measured during transcrystalline migration of melt inclu-895 sions within olivine at very small degrees of undercooling 896  $(<1 \text{ °C}): 3 \times 10^{-10}$  to  $3.2 \times 10^{-9}$  m/s (Schiano et al. 2006). 897 Both our experiments (Fig. 5b) and transcrystalline melt 898 migration experiments produced (001) faces that are char-899 acteristic of a polyhedral olivine habit at very low degrees AQ4 of undercooling (Deer et al. 1962). Morphologies with (001) 901 faces are also observed on olivine dendrites re-equilibrated 902 under near equilibrium conditions (Faure et al. 2003b). The 903 slow growth rate, the absence of marked chemical gradients 904 at crystal-liquid interfaces and the presence of (001) faces 905 are evidence of very low degrees of undercooling during 906 experiments. 907

Faure et al. retained four main morphologies of olivine 908 among the ten described by Donaldson (1976): polyhedral, 909 tabular, hopper and dendritic (Faure et al. 2003a). Those 910 morphologies depend on the type of growth mechanism, 911 steady-state vs. rapid growth mechanisms, which depends, 912 in turn, on the cooling rate and the degree of undercool-913 ing (Faure et al. 2003a). Here, we show a new type of 914 growth mechanism, cellular growth, and new growth 915 morphologies that have not been described in previous 916 studies, in which olivine growth was investigated using 917 cooling experiments (Donaldson 1975, 1976; Coish and 918 Taylor 1979; Kirkpatrick 1981; Lofgren 1983; Jambon 919 et al. 1992; Faure et al. 2003a; Faure and Schiano 2005; 920 Welsch et al. 2012; Ni et al. 2014). Compared to classical 921 cooling experiments, our thermal migration experiments 922 allow to combine two parameters that are required for the 923 occurrence of cellular growth and for the development 924 of cellular morphologies: low degrees of undercooling 925 (estimated at 2 °C in experiment B6) and large forster-926 ite-melt interfaces (typically 2 mm in diameter). Based on 927 our experiments, the classical degree of undercooling vs. 928

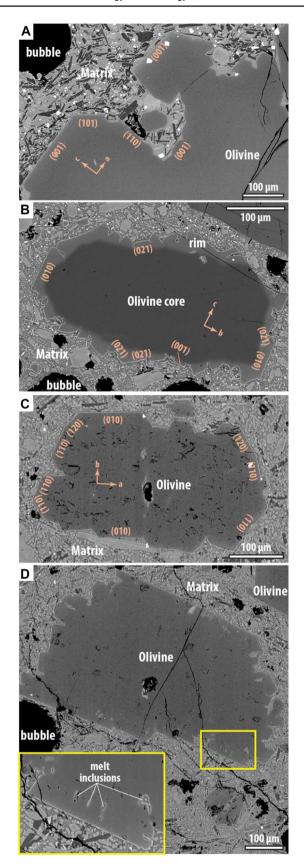

cooling rate vs. olivine morphologies scheme (Faure et al. 929 2007) needs to be completed to include cellular growth of 930 olivine. Integrating the new data with previous ones, we 931 are able to link growth texture in olivine to growth rate: 932 polyhedral, tabular, and cellular morphologies occur at 933 crystallization rates of  $\approx 10^{-9}$  m/s and below, while hop-934 per and dendritic morphologies are generated for higher 935 growth rates ( $\approx 10^{-8}$  m/s and >  $10^{-8}$  m/s, respectively) 936 (Faure et al. 2007; Ni et al. 2014). 937

### 938 Natural occurrences of cellular growth in magmas

The main goal of our thermal migration experiments was 939 to access the low degrees of undercooling characteristic of 940 most magmatic systems. Under conditions pertaining to 941 natural systems (low degrees of undercooling and large phe-942 943 nocryst faces), our major finding is the development of cellular morphologies. To date, cellular growth has been poorly 944 documented in the literature, with few natural examples on 945 pyroxene, plagioclase and spinel (Singer and Pearce 1993; 946 Andersson and Eklund 1994; Hibbard and Sjoberg 1994; 947 Roeder et al. 2001). However, we believe that cellular mor-948 phologies are much more frequent and may not have been 949 detected in the past. For instance, we found microtextures 950 that are suggestive of cellular growth in olivines from the 951 basanitic tephra of Montcineyre (Chaîne des Puys, France; 952 Fig. 11a) and Souilhol and Thueyts volcanoes (Ardèche, 953 France; Fig. 11b-d). The olivine phenocrysts are a few mm 954 long at Montcineyre, and between 0.5 and 1 mm at Souil-955 hol and Thueyts. Most olivine phenocrysts in these basan-956 ites are characterized by a discontinuous outer part show-957 ing lobes or blocks of growth separated by depressed areas 958 or embayments: the result is a crenulated outline. Olivine 959 xenocrysts, which are frequent in these basanites, show the 960 same morphology at their periphery; the MgO-rich olivine 961 core in Fig. 11b is completely surrounded by lobes of olivine 962 in equilibrium with the basanitic matrix. Small melt inclu-963 sions are found in the rim of some olivines from Thueyts 964 (Fig. 11d), yielding microtextures reminiscent of a process 965 of cellular growth in which neighboring lobes merged at 966 their ends and entrapped melt droplets at their roots. In the 967 examples of Fig. 11, the final stage of olivine growth was 968 frozen by the eruption, allowing the preservation of what we 969 interpret as textures of cellular growth. 970

of melt inclusions. With the experimental configuration 973 used here, we could test for the necessity of a temperature 974 decrease to form melt inclusions, such as suggested by Gold-975 stein and Luth (2006) who produced inclusions at cooling rates higher than 1 °C/h only. Here, we generated melt inclusions resembling natural ones in the absence of temperature variations, but with temperature gradients of a few degrees per mm which drove olivine growth under low degrees of undercooling. Therefore, melt inclusions can be formed in steady P-T systems at low degrees of undercooling; their formation does not require a specific cooling regime or rapid crystallization (skeletal of dendritic growth) as previously proposed (Albarede and Bottinga 1972; Roedder 1979; Watson 1996; Schiano 2003; Kohut and Nielsen 2004; Faure and Schiano 2005; Goldstein and Luth 2006; Faure et al. 2007). Cellular growth could favor the formation of melt inclusions by giving rise to melt tubes that will subsequently get closed at their ends (Higuchi et al. 1995; Nakamura and Shimakita 1998; Colin et al. 2012). This process is well 991 illustrated by the merging of neighboring lobes terminated 992 by crystallographic facets in experiment B6 (Fig. 3c), and 993 closely resembles the mechanism described by Colin et al. 994 in skeletal olivine crystals found in a MORB (Colin et al. 995 2012). However, we do not claim that our experiments rep-996 resent the unique or the most likely way of making inclu-997 sions, and there is natural and experimental evidence that 998 melt inclusions form under varying pressure and/or tem-999 perature (Kohut and Nielsen 2004; Faure and Schiano 2005; 1000 Faure et al. 2007; Manzini et al. 2017). Cellular growth is another mechanism to generate melt inclusions hosted in polyhedral forsterite, in addition to the interaction between spiral growth dislocations (Faure and Schiano 2005), par-1004 tial dissolution of host mineral followed by recrystallization 1005 (Anderson 1991; Nakamura and Shimakita 1998; Welsch 1006 et al. 2014; Manzini et al. 2017), dissolution of preexist-1007 ing crystals or impurities (Davey and Mullin 1974; Michael 1008 et al. 2002), or fluctuation of growth rate (Roedder 1979). 1009

#### Conclusions 1010

We used an original experimental setup based on thermal 1011 1012 migration to monitor the growth of large forsterite cylinders (single crystals) at low degrees of undercooling ( $\approx 2$  °C). 1013 As forsterite solubility is sensitive to temperature, the 1014 temperature gradient within the capsules generated a dis-1015 solution-precipitation process involving (1) dissolution 1016 of forsterite on the high-temperature side (giving rise to 1017 rounded crystal-melt interfaces and pillars of residual for-1018 sterite); (2) transport of dissolved components in the melt; 1019

(3) precipitation on the low-temperature side (giving rise to 1020 thick layers of newly grown forsterite with a fingered inter-1021 face and melt inclusions, and to the growth of large, euhe-1022 dral crystals of forsterite). The starting forsterite cylinders 1023 were sputtered with Au-Pd allowing us to mark the initial 1024 melt-forsterite interface and to quantify crystal growth. 1025

The fingered crystal-melt interfaces observed on the 1026 crystallization side of forsterite cylinders result from cel-1027 lular growth, a type of growth that had not been produced 1028 experimentally so far in silicate systems. Our experiments 1029 show that cellular growth requires a low degree of under-1030 cooling (a few °C) and a large substrate (~1 mm across 1031 or more), and that it occurs at growth rates of the order of 1032  $10^{-9}$  m/s. Cellular growth can lead to the formation of melt 1033 inclusions at relatively slow rates of growth. Although 1034 we found microtextures suggestive of cellular growth in 1035 olivines from mafic rocks of the French Massif Central, 1036 cellular textures are poorly documented in natural prod-1037 ucts, probably because they were not recognized as such. 1038
