Highlights

- Pyrite contribution to Ni and Fe speciation is low and restricted to the sediments close to the shore
- Clay minerals are the major host for Fe and Ni across the shore-to-reef gradient
- Fe-rich smectite, glauconite, chrysotile and greenalite/berthierine are the major Fe and Ni-bearing clay minerals identified
- Greenalite/berthierine is the most Ni-rich clay mineral identified and it is considered to have formed *in-situ* upon early diagenesis
- Green clay authigenesis might represent a major process for trace metals cycling in shallow lagoon sedimentary settings

18 ABSTRACT

In the tropics, continental weathering and erosion are major sources of trace metals towards 19 20 estuaries and lagoons, where early diagenesis of sediments may influence their mobility and 21 bioavailability. Determining trace metals speciation in tropical sedimentary settings is thus 22 needed to assess their long-term fate and potential threat to fragile coastal ecosystems. In this 23 study, we determined Fe, Ni and S speciation across a shore-to-reef gradient in sediments 24 from the New Caledonia lagoon that receive mixed contribution from lateritic (iron-25 oxyhydroxides and clay minerals), volcano-sedimentary (silicates) and marine (carbonate) 26 sources. Sulfur K-edge XANES data indicated a major contribution of pyrite (FeS₂) to S 27 speciation close to the shore. However, this contribution was found to dramatically decrease 28 across the shore-to-reef gradient, S mainly occurring as sulfate close to the coral reef. In 29 contrast, Fe and Ni K-edge XANES and EXAFS data indicated a minor contribution of pyrite 30 to Fe and Ni speciation, and this contribution could be evidenced only close to the shore. The 31 major fractions of Fe and Ni across the shore-to-reef gradient were found to occur as Ni- and 32 Fe-bearing clay minerals consisting of smectite (~nontronite), glauconite and two types of 33 serpentines (chrysotile and greenalite/berthierine). Among these clay minerals, 34 greenalite/berthierine, glauconite and possibly smectite, were considered as authigenic. The 35 low contribution of pyrite to trace metals speciation compared to clay minerals is interpreted 36 as a result of (1) a reduced formation rate due to the low amounts of organic carbon compared 37 to the Fe pool and (2) regular re-oxidation events upon re-suspension of the sediments top 38 layers due to the specific context of shallow lagoon waters. This study thus suggests that 39 green clay authigenesis could represent a key process in the biogeochemical cycling of trace 40 metals that are delivered to lagoon ecosystems upon continental erosion and weathering.

45 **1. INTRODUCTION**

Thanks to its wet climate, the intertropical zone is the preferential worldwide area for the 46 47 formation of laterites (Tardy, 1997; Rettalack, 2010). Among these laterites, some have 48 developed upon ultramafic rocks, which represent about 1% of the surface of the earth (Oze et 49 al., 2007). This is for instance the case in Brazil (Raous et al., 2013; Ratie et al., 2018), Cuba 50 (Oliveria et al., 2001), Indonesia (Golightly 1979; Fu et al., 2018), Colombia (Gleeson et al., 51 2004), Cameroon (Yongue-Fouateu et al., 2006), Australia (Elias et al., 1981) and New 52 Caledonia (Beauvais et al., 2007; Fandeur et al., 2009a; 2009b; Dublet et al., 2012; 2014; 53 2017). Ultramafic rocks are composed of ferromagnesian minerals (*i.e.* olivine, pyroxene and 54 amphibole), whereas laterites are mainly composed of Fe-(oxyhydr)oxides (*i.e.* mostly 55 goethite FeO(OH), and at a lesser extent hematite Fe_2O_3 and magnetite Fe_3O_4 ; Oliveria et al. 56 2001; Yongue-Fouateu et al., 2006; Fandeur et al., 2009a; Raous et al., 2013; Dublet et al., 57 2012; 2014; 2017; Ratie et al., 2018). Trace metals such as nickel (Ni), chromium (Cr), cobalt 58 (Co) and manganese (Mn) are usually highly concentrated in the Fe-(oxyhydr)oxides of 59 laterites when developed upon ultramafic rocks (Oliveria et al., 2001; Gleeson et al., 2004; 60 Yongue-Fouateu et al., 2006; Fandeur et al., 2009a; Dublet et al., 2012; 2014; 2017; Raous et 61 al., 2013; Fu et al., 2018; Ratie et al., 2018). This is due to their significant concentration in 62 primary ferromagnesian minerals and to their similar crystal-chemistry with Fe(III), which 63 favors their structural incorporation in secondary Fe-(oxyhydr)oxides (Cornell and 64 Schwertmann, 2004). Natural erosion of laterites has thus been responsible for large inputs of 65 trace metals to continental and marine sedimentary settings for million years.

66 This is especially the case in New Caledonia, where about 30% of the main island surface is 67 covered with laterites that developed several millions of years ago upon ultramafic rocks 68 (Sevin et al., 2012) and are thus enriched in Fe (~36.93 wt%), Ni (~1.15 wt%), Cr (~1.9 69 wt%), Co (~0.08 wt%) and Mn (~1.75 wt%) (Fandeur et al., 2009a; 2009b; Dublet et al., 70 2012; 2017). Since most of these laterites are scattered along the coast and regarding their strong natural erosion due to the tropical climate, shoreline ecosystems of New Caledonia (*i.e.* 71 72 mangrove and lagoon) have been receiving large amounts of trace metals for million years. 73 Moreover, these inputs are considered to have been significantly enhanced in the last 150 74 years due to open-cast mining of Ni ores that developed across the main island since the middle of the 19th century. As a consequence, the concentration of trace metals in the 75 76 mangrove (Marchand et al., 2012; Noël et al., 2014, 2015) and lagoon (Ambatsian et al., 1997; Dalto et al., 2006; Fernandez et al., 2006) sediments of New Caledonia are significantly 77 78 higher than in other similar environmental settings around the world (Pacifico et al., 2007; 79 Morisson et al., 2010; Lewis et al., 2011; Coates-Marnane et al., 2016; Birch et al., 2017; 80 Saravanan et al., 2018; Zonta et al., 2018).

81 Once in the sedimentary setting, metals can be involved in many reactions during early 82 diagenesis. Among these numerous reactions, biologically catalyzed reduction of sulfates to sulfides and Fe(III) to Fe(II) in anoxic conditions is known to lead to the formation of Fe-83 84 sulfides (*i.e.* mainly pyrite FeS₂, but also mackinawite FeS and greigite Fe₃S₄ which are 85 usually included in the generic term of Acid Volatile Sulfides or AVS) (Morse et al., 1987; 86 Huerta-Diaz et al., 1992; Roberts and Turner 1993; Gagnon et al., 1995; Passier et al., 1996; Butler and Rickard 2000; Rickard and Morse, 2005; Neumann et al., 2005; Alvarez-Iglesias et 87 88 al., 2012; Botsou et al., 2015). Among Fe-sulfides, pyrite and mackinawite have been 89 extensively investigated for their strong capacity at trapping trace metals, either through 90 analysis of natural sediments or through laboratory-controlled (bio)synthesis experiments 91 (Huerta-Diaz et al., 1992; 1998; 2014; Morse and Luther, 1999; Rickard and Luther, 2007; 92 Burton et al., 2008; Berner et al., 2013; Neumann et al., 2013; Diaz-de-Alba et al., 2016; Le

93 Pape et al., 2016; Ikogou et al., 2017; Morin et al., 2017; Wilkin and Beck, 2017). However, 94 several studies on natural sediments have also shown that trace metals can be associated with 95 silicate minerals and reducible Fe- and Mn-oxides (Lopez-Sanchez et al., 1996; Jones and 96 Turki 1997; Morillo et al., 2004; Yuan et al., 2004; Cuong and Obbard 2006). This is the case 97 in New Caledonia, where some studies reported that Fe-(oxyhydr)oxides and clays are the 98 major host of trace metals (i.e. Ni, Cr, Co and Mn) in lagoon sediments (Ambatsian et al., 99 1997; Fernandez et al., 2006). In contrast, other studies of mangrove sediments from New 100 Caledonia showed that trace metals are sequestered by Fe-sulfides through pyritization 101 (Marchand et al., 2012; 2016; Noël et al., 2014; 2015; 2017). This apparent discrepancy could 102 indicate a different biogeochemical cycling for trace metals in mangrove and lagoon 103 sediments of New Caledonia. However, it could also be due to the fact that the former studies 104 performed on the lagoon sediments relied on sequential chemical extractions that suffer a lack 105 of specificity particularly in anoxic sediments (Jouanneau et al., 1983; Rapin et al., 1986; 106 Nirel and Morel, 1991). Indeed, in their study, Ambatsian et al. (1997) emphasized that 107 carbonates and weakly crystalline oxides could have been dissolved in the first step of their 108 extraction procedure and that a part of weakly crystalline sulfides could have been counted 109 with Mn- and Fe-(hydr)oxides. Therefore, the absence of Fe-sulfides contribution to trace 110 metals speciation reported in this study could be due to a lack of precision of the 111 methodological approach used by these authors. This doubt was not risen by the study of Fernandez et al. (2006), which focused on surface sediment samples and thus did not bring 112 113 additional information able to describe the crystal-chemistry of trace metals during early 114 diagenesis in the lagoon sediments of New Caledonia.

115 Owing to their potential toxicity to living organisms (Di Toro et al., 1992), this lack of 116 information is an important issue because early diagenesis in the lagoon sediments of New 117 Caledonia could modify the crystal-chemistry of trace metals, and possibly induce some

118 changes in their mobility and bioavailability that could reveal deleterious for the long term 119 sustainability of this fragile ecosystem. Since Ni is the major trace metal mined in New 120 Caledonia, the objective of the present study was to improve our understanding of the 121 biogeochemical cycling of this element in the lagoon sediments of New Caledonia through a 122 thorough evaluation of its actual speciation along the trace metals input gradient. For that 123 purpose, we selected two lagoon bays located downstream of one of the largest mined lateritic 124 Ni-ores from New Caledonia and sampled three sediment cores under controlled anoxic 125 conditions across a shore-to-reef gradient for each bay. In addition, we also sampled one 126 sediment core downstream of a siliceous non-mined watershed to serve as reference. For each 127 sediment core, we used X-Ray Diffraction (XRD), Scanning Electron Microscopy - Energy 128 Dispersive X-Ray Spectroscopy (SEM-EDXS) analyses, Transmission Electron Microscopy -129 Energy Dispersive X-Ray Spectroscopy (TEM-EDXS) analyses and synchrotron-derived X-130 Ray Absorption Spectroscopy (XAS) to identify and quantify the Ni species as a function of 131 depth. Due to their potential strong association with Ni, the speciation of Fe and S were also 132 studied. The results obtained reveal the major trends in the biogeochemical cycling of Ni, but 133 also Fe and S, within the lagoon sediments of New Caledonia downstream lateritic Ni-ores.

- 135 2. MATERIALS AND METHODS
- 136

137 **2.1 Sampling site and sampling procedures**

138

New Caledonia is located in the South-West Pacific Ocean under oceanic tropical climate
(Fig. 1). The main island (Grande Terre) extends over ~500km long and ~50km wide (Fig. 1).
It is surrounded by the second largest reef barrier in the world (*i.e.* about 1500 km long) that
delineates a lagoon of about 30,000 km² (Cabioch et al., 1999; 2003; Andrefouët et al., 2009;
Debenay et al., 2009; Anderfouët and Wantiez, 2010; Grenz et al., 2010a; Ouillon et al.,

144 2010). The two major features of this lagoon setting are the shallow depth of water (*i.e.* rarely 145 more than 50m; Grenz et al., 2010b; Minghelli-Roman and Dupouy, 2013) and its 146 oligotrophic to mesotrophic characteristics (Jacquet et al., 2006; Torreton et al., 2007; 2010; 147 Dupouv et al., 2010; Fichez et al., 2010). The studied site is located on the North-Western 148 part of the lagoon from New Caledonia (Voh-Kone-Pouembout or VKP area, Northern 149 Province; Fig. 1), where about 90% of the water depth is less than 20m (Wattelez et al., 150 2016). The studied sediment cores were sampled in the Vavouto, Kataviti and Chasseloup 151 Bays in July 2016 during the dry season (Fig. 1). The Vavouto Bay is located downstream of 152 the ultramafic Koniambo outcrop (20°59'S; 164°49'E) composed of deeply weathered 153 peridotites and thus characterized by Ferralsols enriched in Fe, Mn, Cr, Ni and Co (i.e. 154 concentrations up to 50-55 wt%, 8-9 wt%, 3-4 wt%, 2.0-2.5 wt% and 0.5-0.6 wt%, 155 respectively; Fandeur et al., 2009a; Dublet et al., 2012; 2017). The Chasseloup Bay is located 156 downstream of a volcano-sedimentary setting mainly composed of Acrisols, Cambisols 157 Vertisols and Fluvisols (Fritsch, 2012) that are characterized by medium to high Si, Al, Mg 158 and K concentrations (i.e. up to 40-45 wt%, 7-8 wt%, 4-4.5 wt%, 0.4-0.5 wt%, respectively; 159 Vincent et al., 2018). The Kataviti Bay is located at an intermediate position, downstream of 160 both types of ultramafic and volcano-sedimentary settings (Fig. 1). In both the Vavouto and 161 Kataviti Bays, three sediments cores were collected at an increasing distance across the shore-162 to-reef gradient : less than 100 m from the mangrove limit (stations referred hereafter as "close to the shore"), 2-3 km from the mangrove limit (stations referred hereafter as 163 164 "intermediate") and 5-6 km from the mangrove limit (stations referred hereafter as "close to 165 the coral reef"). Only one sediment core was collected at an intermediate position (about 2 166 km from the mangrove limit) in the Chasseloup Bay (Fig. 1). Each sediment core was 167 conserved at room temperature with its overlying water no longer than 3 hours. Before 168 sampling, dissolved oxygen concentration in the pore water was determined by inserting a

169 glass micro-electrode in the sediment at 50 µm steps down to ~10 mm depth. All sediments 170 were found to be anoxic below 2 to 5 mm (Fig. S1). After dissolved oxygen measurements, 171 the sediments were sampled every 1 cm under N₂ flow in order to prevent any oxidation and 172 each sample was immediately stored under anoxic conditions at 4°C in glass vials sealed with 173 a butyl rubber stopper. After about 4 weeks of storage, the samples were opened in a glove 174 box under N₂ atmosphere ($[O_2] \le 1$ ppm) for vacuum-drying. After drying, each sample was 175 ground in the glove box, with an agate mortar for XRD analyses and with a mechanical 176 grinder at a 30 Hz frequency during 20 min for chemical and spectroscopic analyses. After 177 manual or mechanical grinding, all samples were stored in sealed glass vials and maintained 178 in the glove box until analyses.

180 **2.2 Chemical and mineralogical analyses**

181

182 Bulk concentrations of major (Ca, Mg, Na, K, Ti, Fe, Al and Si) and trace (Co, Cr, Mn, Ni, 183 Cu, P and Zn) elements in the studied sediment samples were determined by ICP-OES (VARIAN[®] 730ES ICP optical emission spectrometer) and ICP-MS (PERKIN ELMER[®] 184 185 NexION 350x ICP mass spectrometer) respectively after alkaline fusion. Sulfur concentration was also determined by ICP-MS but after a total acid digestion. Total organic C (Corg) and N 186 (Norg) concentrations were measured using a SERCON Integra analyzer. All these analyses 187 188 were performed at the ISO 9001 certified Laboratoire des Moyens Analytiques (LAMA) of 189 the Institut de Recherche pour le Developpement (IRD) in Noumea (New Caledonia).

190 The mineralogical composition of the sediments was determined by XRD with a 191 PANALYTICAL[®] X'Pert Pro diffractometer equipped with an X'celerator detector and using 192 Co K α radiation in order to minimize X-ray absorption by Fe. In the N₂-filled glove box, each 193 sample was mixed with ethanol, and deposited on a zero-background silicon plate that was 194 then inserted in an anaerobic sample chamber to avoid any contact with the atmosphere during transport and XRD analyses (Noël et al., 2014). XRD data were collected in the BraggBrentano geometry with a continuous collection mode over the 5-80° 2θ range with a 0.033°
2θ step, merging two scans of 2h per sample. Quantitative mineralogical analysis was
performed by Rietveld refinement of the XRD patterns using the *xnd* code (Berar, 1998), the
sum of the weight fractions of the mineral phase being normalized to unity (Snyder and Bish,
1989).

201 The clav fraction (<2 um) of selected samples was collected using a sedimentation procedure 202 based on the Stokes' law, in an anoxic glove box and using O₂-free deionized water. Oriented 203 deposits were prepared by suspending few tens of milligrams of the separated $<2\mu$ m fraction, 204 dropping a few hundreds of microliters of this suspension on a glass slide and drying under N₂ 205 atmosphere in the glove box. XRD data were then collected on the oriented deposits over the 206 3-16° 20 range with a 0.017° 20 step after N₂ drying, after heating at 350 and 550°C for 1h 207 and after solvation with ethylene glycol (i.e. oriented deposits left for 24h in a sealed 208 desiccator above an ethylene glycol solution). This procedure is classically designed to 209 identify clay minerals on the basis of their swelling and shrinking behavior (Brindley and 210 Brown, 1980).

SEM-EDXS observations and analyses were used to obtain qualitative analyses of the Ni host phases at the micron scale. For this purpose, selected sediment samples were deposited on a carbon tape, dried overnight in a N₂-filled glove box, quickly transported to a carbon coating device and then quickly transferred into the SEM vacuum chamber. SEM observations and analyses were performed at 15kV with a 60 μ m diaphragm with a Field Emission Gun Scanning Electron Microscope (GEMINI ZEISS Ultra 55) equipped with a Bruker EDXS Sidrift detector.

218 TEM-EDXS observations and semi-quantitative analyses were used to characterize individual 219 clay minerals at the nanoscale. For this purpose, a few milligrams of the clay fraction of 220 selected samples were suspended in absolute ethanol and dispersed in an ultrasonic bath for a 221 few tens of minutes, before being deposited on a holey carbon-coated grid and rapidly 222 transferred into the TEM airlock. TEM observations and semi-quantitative analyses were 223 performed at 200kV with a JEOL 2110F TEM equipped with a JEOL EDXS Si(Li) detector. 224 The concentration of Si, Mg, Fe, Al, Ni and Cr were first semi-quantified as wt% of SiO₂, MgO, FeO, Al₂O₃, NiO and Cr₂O₃, respectively, and then further transformed to atom% in 225 226 order to derive the structural formulae of the corresponding clay minerals. The precision of 227 this quantification is considered to be $\pm 10\%$ of the stated wt% (oxides) values.

229 2.3 Statistical analyses

230

231 A two-steps exploratory statistical analysis was performed on the chemical composition of the studied sediments in order for better describing our dataset. In the first step, a Principal 232 233 Component Analysis (PCA) allowed to determine the relationships among the concentrations 234 of major and trace elements and simplify the dataset by reducing the number of variables into 235 major components. In the second step, a Hierarchical Cluster on Principal Components 236 (HCPC) analysis allowed to group the studied sediments as a function of the principal 237 components extracted from the PCA. For this second step of the procedure, a hierarchical 238 clustering was first performed using the Ward's criterion on the selected principal 239 components of the PCA to group the studied samples on the basis of their chemical 240 characteristics. Then a k-means clustering was done to improve the partition of the studied 241 samples derived from the hierarchical clustering. The number of clusters that are delineated 242 on the final factor map (Fig. 2) correspond to the optimal number of clusters that was defined 243 during the hierarchical clustering on the selected principal components of the PCA. This 244 analysis was performed with the R software (R development Core Team 2008), using the 245 "FactoMineR" package, available at the following link: <u>http://CRAN.R-</u>
246 project.org/package=FactoMineR.

248 2.4 X-ray absorption spectroscopy (XAS) data collection

249

XAS data were collected at the S, Fe and Ni K-edge on the same set of 21 sediment samples,
selected at three depths in each of the seven cores.

- 253 2.4.1 XAS data at the S K-edge

254 Sulfur K-edge X-ray Absorption Near-edge Structure (XANES) data were collected in 255 fluorescence detection mode at room temperature on the wiggler beamline 4-3 at the Stanford 256 Synchrotron Radiation Light Source (SSRL, CA, USA). The energy of the incoming beam 257 was varied with a Si(111) double-crystal monochromator and the fluorescence signal was 258 collected with a SiLi Vortex detector. Energy was calibrated by setting the energy position of 259 the main edge (1s-3p) of the S K-edge of sodium thiosulfate to 2472.02 eV. Bulk sediment 260 samples were loaded into Al sample holders covered with a 4µm thick layer of S-free 261 Parylene window. The sample holders were prepared in a glove box $(3\% H_2/97\% N_2)$ 262 atmosphere) and analyzed in the sample chamber under He flow. Four scans were averaged 263 for each sample.

265 2.4.2 XAS data at the Fe K-edge

Iron K-edge XANES and Extended X-Ray Absorption Fine Structure (EXAFS) data were collected at cryogenic temperature in N_2 liquid cryostat (80-85K) in fluorescence detection mode using a Canberra[®] high-throughput Ge 30-element on the wiggler beamline 4-1 at SSRL. One sample was analyzed in transmission mode at cryogenic temperature in liquid He cryostat (15-20K) on the bending magnet FAME beamline at the European Synchrotron 271 Radiation Facility (ESRF, France). At both beamlines, the energy of the incoming X-ray 272 beam was varied with a Si(220) double-crystal monochromator. Energy was calibrated by 273 setting the first inflection point of the Fe K-edge of a simultaneously measured metallic iron 274 foil to 7112 eV (double transmission mode). For these measurements, pressed pellets were prepared in a glove box under N2 atmosphere after mixing ~12-18 mg sediment sample with 275 276 \sim 35 mg cellulose. Sample pellets were mounted on the cryostat sample rod in the glove box 277 and immersed in a liquid N₂ bath before being transferred into the beamline cryostat. Between 278 2 and 5 scans were necessary to obtain an acceptable signal-to-noise ratio depending on the 279 Fe concentration in the analyzed sample.

281 2.4.3 XAS data at the Ni K-edge

282 Nickel K-edge EXAFS data were collected in fluorescence detection mode at cryogenic 283 temperature in liquid He cryostat (15-20K) on the bending magnet SAMBA beamline at 284 synchrotron SOLEIL (France) for the less dilute samples and on the wiggler beamline 9-3 at 285 SSRL for the most dilute ones. At SAMBA, the energy of the incoming beam was varied with 286 a Si(111) double-crystal monochromator and the fluorescence signal was collected with a 287 Vortex detector. At SSRL BL 9-3, we used a Si(220) double-crystal monochromator and a Canberra® high-throughput Ge 100-elements. Energy was calibrated by setting the first 288 289 inflection point of the Ni K-edge of a simultaneously measured metallic nickel foil to 8333 290 eV (double transmission mode). For these measurements, finely ground and homogenized 291 pure samples were prepared as pressed pellets in a glove box under N2 atmosphere and 292 shipped to the synchrotron facilities in anoxic containers. Sample pellets were mounted on the cryostat sample rod in the glove box and immersed in a liquid N2 bath before being 293 294 transferred into the beamline cryostat. Depending on the chemical composition of the sample, 295 1 to 4 Al foils were used together with Soller slits to improve the signal to noise ratio. Between 3 and 20 scans were necessary to obtain an acceptable signal-to-noise ratiodepending on the Ni (and parasitic Fe) concentrations in the analyzed sample.

298

299 2.5 X-ray Absorption Spectroscopy (XAS) data analysis

300

301 The data collected at SSRL were calibrated and averaged using the SIXPACK code (Webb, 302 2005), whereas those collected at SOLEIL and ESRF were calibrated and averaged using the 303 ATHENA code (Ravel and Newville, 2005). All the data were then analyzed by principal 304 component analysis (PCA) using the SIXPACK code (Webb, 2005). The minimum number of 305 principal components necessary to fit each set of sediment samples spectra was chosen on the 306 basis of the minimum value of the factor indicator function (Malinowski 1978, 1987, 1991; 307 Webb, 2005) and of the quality of the reconstruction with up to the four first principal 308 components. Target Transformation (TT) was then used to select the model compounds 309 spectra that we further used in the linear combination least-square fitting (LC-LSF) of the 310 sediment spectra. We used the ATHENA software (Ravel and Newville, 2005) for the LC-311 LSF analysis of the XANES data and a home-built software based on Levenberg-Marquardt 312 minimization algorithm for the LC-LSF analysis of the EXAFS data (Noël et al., 2014; 2015; 313 Morin et al., 2017).

314

315 **2.6 Model compounds for XAS analyses**

316

Our database for S K-edge model compounds included a large set of sulfates (SO_4^{2-}) as anhydrite [CaSO₄], arcanite [K₂SO₄] (Janot et al., 2016), melanterite [FeSO₄.7H₂O], quenstedite [Fe₂(SO₄)₃.11H₂O], jarosite [KFe³⁺₃(OH)₆(SO₄)₂] (Kumar et al., 2018), and sulfate organic as Taurine (personal data); thiosulfate (S₂O₃²⁻) as sodium thiosulfate [Na₂S₂O₃] (Janot et al., 2016); sulfite (SO₃²⁻) as [Na₂SO₃] (Kumar et al., 2018); elemental sulfur (S⁰) as polysulfides [S₈] (Janot et al., 2016; Kumar et al., 2018); sulfide (S₂²⁻) as pyrite and marcasite [FeS₂] (Kumar et al., 2018), synthetic mackinawite [FeS], mackinawite exposed to sub-stoichiometric amounts of weak oxidants or Fe³⁺ referred to as oxidized mackinawite (Noël et al., 2017), pyrrhotite, and greigite [Fe₃S₄] (Kumar et al., 2018).

326 Our database for Fe K-edge model compounds spectra included a large set of already 327 published data, including Fe(III) (oxyhydr)oxides as goethite [α -FeOOH], hematite [α -Fe2O3], 2-Line, 6-Line ferrihydrite [Fe³⁺₂O₃.0.5(H₂O)] (Maillot et al., 2011; Hohmann et al., 328 329 2011), Fe(II)-sulfides as pyrite [FeS₂] and mackinawite [FeS] (Noël et al., 2014) and Fe(II)-330 and Fe(III)-bearing talc [(Mg,Fe)₃Si₄O₁₀(OH)₂] (Stetten et al., 2018). It also included natural 331 clay minerals such as illite [(K,Na,Ca)_x(Al,Fe,Mg)₂(Si,Al)₄O₁₀(OH)₂] from Le Puy-en-Velay, France (Ildefonse et al., 1998), biotite [K(Mg,Fe)₃Si₃AlO₁₀(OH)₂] from Yosemite 332 333 Collection of IMPMC, (Mineralogy Paris, France) and Garfield nontronite 334 [Ca_xFe₂(Si,Al)₄O₁₀(OH)₂.nH₂O] (Washington, USA) (Bonnin et al., 1985).

335 Our database for Ni K-edge model compounds spectra included a large set of already 336 published synthetic and natural compounds data such as Ni-goethite, Ni-sorbed goethite $\left[\alpha\right]$ 337 (Fe,Ni)OOH], Ni-asbolane $[Mn(O,OH)_2Ni_x(OH)_{2x}.nH_2O]$ Ni-sorbed birnessite 338 $[(Na,Ca)_{0.5}(Mn,Ni)_2O_4.1.5H_2O],$ Ni-serpentine Ni-talc $[(Mg,Fe,Ni)_3Si_2O_5(OH)_4],$ 339 $[(Mg,Fe,Ni)_3Si_4O_{10}(OH)_2]$ and Ni-montmorillonite $[Ca_x(Al,Mg,Ni)_2Si_4O_{10}(OH)_2.nH_2O]$ (Dublet et al., 2012, 2014; Noël et al., 2015). 340

342 **3. RESULTS**

343

344 **3.1 Bulk chemical composition of the lagoon sediments**

345

346 Despite few exceptions (Ni, Fe and Co at the KTV station and Ni, Fe and Cr at the VE2

347 station), trace metals (Ni, Cr, Mn, Co, Ti, Zn and Cu) and major elements (Fe, Si, Al, K, Mg

and Ca) concentrations remain quite stable with depth in all sediments cores (Table S1; Figs.
S2, S3 and S4). As a consequence, mean concentrations for each core were used to compare
the chemical trends from one bay to the other, but also across the shore-to-reef gradient for
the Vavouto and Kataviti Bays.

352

353 Comparison of the mean concentrations of elements from one bay to the other allowed to evidence four different chemical trends (Table 1). The first chemical trend is that of mean Ni 354 concentrations that increase from $255\pm30 \text{ mg.kg}^{-1}$ in the Chasseloup Bay (ST16) to 1505 ± 391 355 mg.kg⁻¹ close to the shore in the Kataviti Bay (KTV). These concentrations are consistent with 356 357 those already reported for other parts of the New Caledonia lagoon downstream of lateritic 358 outcrops (Ambatsian et al., 1997; Dalto et al., 2006). They are significantly higher than those reported for tropical lagoon sediments worldwide (1-67 mg.kg⁻¹) (Morrison et al., 2010), even 359 at the ST16 station (Chasseloup Bay) which shows the lowest Ni concentrations. Magnesium, 360 361 Zn and Cu also follow this first chemical trend with mean concentrations that increase from 1.67±0.07 wt% (Mg), 63±11 mg.kg⁻¹ (Zn) and 26±4 mg.kg⁻¹ (Cu) in the Chasseloup Bay 362 (ST16) to 2.26 ± 0.10 wt% (Mg), 86 ± 6 mg.kg⁻¹ (Zn) and 38 ± 3 mg.kg⁻¹ (Cu) close to the shore 363 364 in the Kataviti Bay (KTV). The second chemical trend is that of Fe concentrations that increase from 2.67±0.12 wt% close to the reef in the Vavouto Bay (LG2B) to 7.10±0.57 wt% 365 366 close to the shore in the Kataviti Bay (KTV). As for Ni, these concentrations are consistent with those reported for other parts of the New Caledonian lagoon downstream of lateritic 367 outcrops (i.e. 4.5-9.0 wt%; Ambatsian et al., 1997). Titanium, Cr, Mn and Co also follow this 368 second chemical trend with mean concentrations that increase from 1312±82 mg.kg⁻¹ (Ti), 369 $278\pm24 \text{ mg.kg}^{-1}$ (Cr), $335\pm20 \text{ mg.kg}^{-1}$ (Mn) and $29\pm14 \text{ mg.kg}^{-1}$ (Co) close to the reef in the 370 Vavouto Bay (LG2B) to 4251±169 mg.kg⁻¹ (Ti), 2879±378 mg.kg⁻¹ (Cr), 85±46 mg.kg⁻¹ (Co) 371 and 547±42 mg.kg⁻¹ (Mn) close to the shore in the Kataviti Bay (KTV). With higher 372

concentrations in the Chasseloup Bay, Si, Al and K follow a third chemical trend. Mean concentrations of these elements increase from 8.26 ± 0.75 wt% (Si), 1.76 ± 0.11 (Al) wt% and 0.31 ± 0.02 wt% (K) close to the reef in the Vavouto Bay (LG2B) to 32.47 ± 1.02 wt% (Si), 6.18 ± 0.42 wt% (Al) and 1.15 ± 0.13 wt% (K) in the Chasseloup Bay (ST16). Finally, with mean concentrations that increase from 1.01 ± 0.13 wt% mg.kg⁻¹ in the Chasseloup Bay (ST16) to 29.57 ± 0.97 wt% close to the reef in the Vavouto Bay (LG2B), Ca follows a fourth chemical trend.

380 Comparison of the mean concentrations of elements across the shore-to-reef gradient for both 381 the Vavouto and Kataviti Bays, allowed to depict two opposite trends (Table 1). The first one 382 is that of major elements (Fe, K, Mg, Si and Al), trace metals (Ni, Cr, Mn, Co, Ti, Zn and Cu) 383 and Corg and Norg concentrations, which show a decrease from the shore to the reef (i.e. from 384 KTV to KL2 and from VE2 to LG2B). The second one is that of Ca concentration, which 385 shows an increase from the shore to the reef. These opposite trends are in agreement with the 386 supposed increasing influence of the marine contribution (*i.e.* at the expense of the detrital 387 continental contribution) across the shore-to-reef gradient.

388

389 **3.2 Statistical assessment of the sediments sources**

390

391 The results of the PCA performed on the major elements and trace metals concentrations in 392 the studied sediments show that the two first principal components explain 80.69% of the 393 cumulative variance (i.e. 59.01% for factor 1 and 21.68% for factor 2; Fig. 2). These results 394 allow to evidence a first clustering for Ni, Mg, Cr, Mn and Co loadings, a second one for K, Norg, Corg, Ti, Al and Si loadings and a third one for Ca loading (Fig. 2). Iron, Zn, Cu and Na 395 396 show mixed loadings between both clusters 1 and 2. These three clusters are considered to 397 represent the three major sources to the studied sediments. Due to the large amounts of Ni, Cr, 398 Co, Mn and Mg in the Koniambo outcrop (Fandeur et al., 2009a; 2009b; Dublet et al., 2012; 399 2014), the first cluster is considered to represent the ultramafic/lateritic source to the studied 400 sediments. The results of the HCPC analysis indicate that the two stations located close to the 401 shore downstream of the Koniambo outcrop (KTV and VE2) are the most exposed to this 402 source (Fig. 2). The major and trace elements that are related to the second cluster (*i.e.* K, 403 Norg, Corg, Ti, Al and Si) are characteristic of the soils developed upon the volcano-404 sedimentary setting that can be found around the ultramafic Koniambo outcrop (Fig. 1; 405 Houles et al., 2018; Vincent et al., 2018). The second cluster is thus considered to represent 406 the volcano-sedimentary source to the studied sediments and the results of the HCPC analysis 407 show that the reference station (ST16) is the most exposed to this source (Fig. 2). With Ca as 408 the only characteristic element, the third cluster is considered to represent the marine source 409 to the studied sediments and the results of the HCPC analysis indicate that the WR2 and 410 LG2B stations in the Vavouto Bay (Fig. 1) are the most exposed to this source (Fig. 2). 411 Finally, the results of the coupled PCA/HCPC analysis also indicate that the KL1 and KL2 stations in the Kataviti Bay (Fig. 1) are exposed to the three sources in roughly similar 412 413 amounts (Fig. 2).

414

415 **3.3 Mineralogy and crystal-chemistry of the lagoon sediments**

416

417 Quantitative mineralogical analysis (Fig. 3; Table S3) fully confirmed the trends observed in 418 the chemical compositions of the sediments (i.e. the increase in the carbonate minerals 419 contribution from the shore to the reef for the Kataviti and the Vavouto Bays, and the larger 420 carbonate minerals contribution in the Vavouto Bay). Indeed, XRD data (Figs. S5, S6 and S7) 421 and their Rietveld refinement (Figs. S8, S9 and S10; Table S3) indicate that the sediments 422 close to the shore, (i.e. KTV Figs. S5 and S8, VE2 Figs. S6 and S9 and ST16 Figs. S7 and 423 S10). mainly consist of quartz $[SiO_2]$, albite $[NaAlSi_3O_8]$ muscovite and

424 $[K_{1-x}Al_{1-x}Si_{3+x}AlO_{10}(OH)_2]$ $[KAl_2Si_3AlO_{10}(OH)_2]$ illite / / smectite 425 [(Na,Ca)_{0.3}(Al,Mg,Fe)₂(Si,Al)₄O₁₀(OH)₂•nH₂O]. The muscovite/illite/smectite mixture is 426 considered as a single pool in our Rietveld refinement analysis because of the overlaping 427 contributions of the (*hkl*) Bragg reflections of theses clay minerals to the XRD pattern in the $23 - 30^{\circ} 2\theta$ range, especially the (111) reflection at ~4.35 Å. Small amounts of pyrite [FeS₂] 428 429 and halite [NaCl] could also be detected in some of the studied samples (Fig. 3). In the same 430 way, minor amounts of two types of serpentines (*i.e.* XRD peak at 7.3 and 7.1 Å) could also 431 latter clay minerals were interpreted as chrysotile be detected. These two 432 [(Mg,Fe)₃Si₂O₅(OH)₄] and greenalite [Fe₃Si₂O₅(OH)₄]/ berthierine [(Fe,Al)₃(Si,Al)₂O₅(OH)₄], respectively, on the basis of TEM-EDXS analyses (see further details below). 433

In contrast, the sediments close to the coral reef (*i.e.* KL2 Figs. S5 and S8 and LG2B Figs. S6 and S9) mainly consist of aragonite [CaCO₃], magnesian calcite [(Mg,Ca)CO₃] and calcite [CaCO₃], together with minor amounts of the silicate minerals observed in the sediments close to the shore (Fig. 3). Finally, the sediments sampled at intermediate locations (*i.e.* KL1 Figs. S5 and S8 and WR2 Figs. S6 and S9) exhibit a mixed mineralogical composition. For all studied sediments, the mineralogy did not show significant changes with depth (Figs. S5, S6 and S7).

441 The XRD patterns obtained on oriented deposits of the clay fraction from the top (0-1 cm) and 442 bottom (20.5-21.5 cm) samples of the VE2 station are displayed in Figure S11. These XRD 443 patterns show major contributions of the basal reflections of swelling smectite (d=15.3Å after air-drying, d=17.1Å after ethylene-glycol solvation) and muscovite/illite (d=10.0 Å), which is 444 445 consistent with our Rietveld analysis. The XRD peaks at d=7.3 and 7.1 Å are interpreted as 446 the basal reflections of chrysotile and greenalite/berthierine, in agreement with our Rietveld 447 analysis of the XRD powder patterns and with TEM-EDXS results detailed below. Minor 448 amounts of chlorite (d=14.2 Å) are also considered due to the small remaining XRD peak at

d=7.3 Å after heating to 550°C. In addition, the small basal reflections at 9.5 and 9.3Å suggest the occurrence of minor amounts of Mg- and Fe-rich talc, respectively. The lack of detection of these latter clay minerals in the powder XRD pattern is likely due to their low concentration.

SEM-EDXS analyses of selected samples from the VE2 and WR2 stations (Vavouto Bay), as well as from the KTV station (Kataviti Bay), indicate that Ni is mainly associated with mineral aggregates having compositions consistent with those of Fe-rich clay minerals (Fig. S12a) or Fe-(oxyhydr)oxides (Fig. S12b). At a lesser extent, Ni can also be found associated with framboidal pyrite (Fig. S12c), but most of the pyrites analyzed were devoid of Ni (Fig. S12d).

459 TEM analyses of the clay fractions from selected samples from the VE2 and WR2 stations 460 (Vavouto Bay) show 3 types of clay minerals (Fig. 4). The first type exhibits a fibrous and 461 tubular morphology characteristic of chrysotile, and the Mg-rich composition (with minor 462 amounts of Fe) depicted in a Mg-Si+Al-Fe ternary diagram (Fig. 4; Table 2) is consistent with 463 this clay mineral (Table S4). TEM-EDXS analyses indicate that this first clay mineral 464 systematically contains minor amounts of Ni and Cr (0.10 wt% NiO and 0.61 wt% Cr₂O₃, on 465 average; Table 2). The second type of clay minerals appears as massive oriented aggregates of 466 elongated thin layers with a Fe-rich composition (and minor amounts of Al and Mg; Fig. 4; 467 Table 2), which is consistent with the 1/1 stoichiometry of greenalite and berthierine (Table 468 S4). TEM-EDXS analyses indicate greenalite as the most enriched in Ni (6,77 wt% NiO and 469 0.90 wt% Cr₂O₃, on average; Table 2) and berthierine as the most enriched in Cr (1.00 wt% 470 NiO and 1.40 wt% Cr₂O₃, on average; Table 2). Finally, the third type of clay minerals 471 appears as aggregates of nano-sized platelets enriched in Fe and Al (with minor amounts of 472 Mg) and with a 2/1 stoichiometry that is consistent with glauconite and Fe-rich smectite (Fig. 4; Table 2). TEM-EDXS analyses of this third type of clay minerals indicate Ni and Cr 473

474 concentrations (0.81 wt% NiO and 0.96 wt% Cr_2O_3 , on average; Table 2) between those 475 found in chrysotile and those found in greenalite/berthierine.

476

477 3.3 XAS analysis of the S, Fe and Ni speciation

478

A coupled PCA and TT analysis was performed on the S K-edge XANES spectra, Fe K-edge
EXFAS spectra and Ni K-edge EXAFS spectra from the 21 studied sediments and a large set
of model compounds in order to select the most relevant model compounds for the LC-LSF
analysis of experimental data.

483 The results of the coupled PCA and TT analysis on the S K-edge XANES data indicate 484 anhydrite, pyrite and mackinawite as the most relevant model compounds (Table S5; Fig S13 485 and 14) to account for the S species in the studied sediments (Table S6; Fig. S15). Anhydrite 486 is here considered as a proxy for sulfate mineral phases in the studied sediments. The results 487 of the LC-LSF analysis of the S K-edge XANES spectra indicate the occurrence of S(VI) 488 represented by sulfate species, S(-I) represented by mackinawite (FeS) and S(-II) represented 489 by pyrite (FeS₂; Figs. 5 and S15). The fraction of sulfide species (*i.e.* pyrite and mackinawite) 490 increases in all sediments, but those collected close to the reef in the Kataviti Bay (KL2; Fig. 491 S15; Table S6). In both the Vavouto and the Kataviti Bays, this proportion decreases from the shore to the reef (*i.e.* from a mean value of 94% at the VE2 station to a mean value of 36% at 492 493 the LG2B station in the Vavouto Bay and from a mean value of 80% at the KTV station to a 494 mean value of 41% at the KL2 station in the Kataviti Bay; Figs. 5 and S15; Table S6). The 495 mean fractions of sulfides (80%) and sulfates (23%) at the reference station (ST16) in the 496 Chasseloup Bay are similar to those found close to the shore in the Kataviti Bay (KTV) (Figs. 497 5 and S15; Table S6).

498 The results of the coupled PCA and TT analysis on the Fe K-edge EXAFS data indicate Fe-499 bearing chlorite and illite, goethite and pyrite as the most relevant model compounds to 500 account for the Fe-bearing species in the studied sediments (Table S7; Fig. S18). Chlorite is 501 here considered to account for Fe incorporated in the trioctahedral layer of the Fe-bearing clay 502 minerals identified by TEM and XRD (i.e. greenalite/berthierine, chrysotile, and minor 503 amounts of talc and chlorite; Fig. 4), whereas illite is considered to account for Fe 504 incorporated in the dioctahedral layer of the Fe-bearing clay minerals identified by TEM and 505 XRD (i.e. mostly smectite; Fig. 4). In addition, SEM-EDXS and TEM analyses support the 506 selection of goethite as a relevant LC-LSF component (Fig S19), whereas SEM-EDXS and 507 XRD analyses support the selection of pyrite (Figs. 3 and S12). The results of the LC-LSF fits 508 of the Fe K-edge EXAFS spectra from the 21 studied sediments using these four components 509 indicate that Fe-bearing clay minerals represent the largest contribution to Fe speciation (i.e. 510 65 - 85% of total Fe speciation), with a dominant contribution from Fe-bearing dioctahedral 511 clay minerals (i.e. 40 - 60 % of total Fe speciation). The contribution of goethite ranges from 512 10 to 35% of total Fe speciation, whereas that of pyrite remains below 15% of total Fe 513 speciation (Figs. 5 and S18; Table S8). Pyrite appears to significantly contribute to Fe 514 speciation only in the sediments close to the shoreline in the three bays (*i.e.* KTV, VE2 and 515 ST16), whereas it is no more detectable at the Fe K-edge at the other stations (Figs. 5 and 516 S18). In the Vavouto Bay, the disappearance of pyrite from the shoreline to the reef appears to 517 be compensated by an increase in the proportion of goethite, whereas it appears to be 518 compensated by an increase of the proportion of Fe-rich trioctahedral clay minerals in the 519 Kataviti Bay (Figs. 5 and S18; Table S8). In the Chasseloup Bay (ST16), the pyrite and Fe-520 rich trioctahedral clay minerals contributions are the highest among all the studied sediments, 521 whereas the goethite contribution is the lowest. According to the results of the LC-LSF fits 522 performed on the first-derivative of their Fe K-edge XANES spectra with the XANES spectra 523 of synthetic Fe(II) and Fe(III) talc model compounds, illite and chlorite are respectively 524 considered to represent a Fe(III) and a Fe(II) pool (Fig. S20; Table S9). As a consequence, the 525 results of the LC-LSF fits performed on the Fe K-edge EXAFS spectra from the studied 526 sediments could be interpreted in terms of Fe(III)/Fe(II) ratio by attributing the proportions of 527 illite and goethite to Fe(III) and those of chlorite and pyrite to Fe(II) (Figs. 5 and S18; Table 528 S8). The results of this approach indicate that Fe mainly occurs as Fe(III) (*i.e.* 53 - 84% of 529 total Fe) in all studied sediments. The highest Fe(II) fraction (*i.e.* 39% of total Fe) is found in 530 the sediments in the Chasseloup Bay (ST16), whereas the lowest (*i.e.* 16% of total Fe) is 531 found in the sediments the closer to the reef in the Vavouto Bay (LG2B). In addition, the 532 fraction of Fe(II) decreases from the shore to the reef in the Vavouto Bay, whereas it remains 533 constant in the Kataviti Bay (Figs. 5 and S18; Table S8). Given the uncertainties reported in 534 Table S8, similar results were obtained by direct LC-LS fitting of the first-derivative of the Fe 535 K-edge XANES data from the sediment samples with the Fe(II) and Fe(III) synthetic talc 536 model compounds.

537 The results of the coupled PCA and TT analysis on the Ni K-edge EXAFS data indicate Ni-538 rich serpentine, Ni-dilute montmorillonite and goethite as the most relevant model compounds 539 (Table S10; Fig S21 and 22) to account for the Ni-bearing species in the studied sediment 540 samples (Table S11; Fig S23). The Ni-rich serpentine model compound is here interpreted as 541 a proxy for Ni incorporated in the trioctahedral layer of the 1/1 Fe-rich clay minerals (i.e. 542 chrysotile and greenalite/berthierine) identified by TEM and XRD, and of talc and chlorite 543 also identified in small amounts by XRD (Fig. S11). Indeed, the EXAFS signals from Ni and 544 Fe second neighbors around Ni in the clay minerals layer are expected to be undistinguishable 545 one from the other due to the close Z numbers of these two elements. The Ni-dilute 546 montmorillonite model compound is interpreted as a proxy for Ni incorporated in the 547 dioctahedral layer of the swelling smectites identified by TEM and XRD as a major clay 548 mineral in our samples. The results of the LC-LSF fits of the Ni K-edge EXAFS spectra from 549 the 21 studied sediments using these three components indicate that Ni speciation is largely 550 dominated by Fe-rich trioctahedral clay minerals (i.e. 36-63% of total Ni speciation), with a 551 lower contribution from Ni dioctahedral clay minerals (*i.e.* 13-46% of total Ni speciation) and 552 goethite (i.e. 12-35% of total Ni speciation) (Figs. 5 and S23; Table S11). For all studied 553 sediments, Ni speciation does not change significantly with depth (Fig. S23). In both the 554 Kataviti and Vavouto Bays, the contribution of Ni-rich trioctahedral clay minerals to Ni 555 speciation is found to remain stable (*i.e.* ~57% and 49%, respectively) from the shore to the 556 reef. In contrast, the contribution of goethite to Ni speciation increases, whereas that of Ni 557 dioctahedral clay minerals decreases (Figs. 5 and S23; Table S11). This latter trend is more 558 marked in the Vavouto Bay than in the Kataviti Bay. In the Chasseloup Bay, the contribution 559 of Ni dioctahedral clay minerals is larger than in the two other bays (Figs. 5 and S23; Table 560 **S**11).

562 4. DISCUSSION

563

4.1. A major contribution of clay minerals to Fe and Ni speciation, compared to Feoxides and Fe-sulfides

566

The presence of Fe- and Ni-bearing clay minerals in the lagoon sediments downstream lateritic outcrops in New Caledonia has already been reported by Fernandez et al. (2017) for the Dumbéa Bay, which is located in the South-Western part of the main Island (Grande-Terre). The results of our study in the North-Western part of the main Island show that these Fe- and Ni-bearing clay minerals are in fact Fe-rich chrysotile, greenalite/berthierine, as well as Fe-rich smectites (nontronite) and micas (glauconite). Our results also indicate that these 573 clay minerals are the major host for Fe and Ni in the lagoon sediments downstream of lateritic 574 outcrops in New Caledonia. In addition to clay minerals, Fe-(oxyhydr)oxides have also been 575 reported as possible hosts for Ni in the sediments from the Dumbéa Bay, but the method employed (*i.e.* sequential chemical extractions) precluded a precise identification of these Fe-576 577 (oxyhydr)oxides (Ambatsian et al., 1997). Thanks to its direct evaluation of Ni and Fe 578 speciation (*i.e.* synchrotron-based XAS data), our study shows that goethite is the Ni-bearing 579 Fe-(oxyhydr)oxides in the lagoon sediments from New Caledonia. In addition, it also 580 indicates that this mineral phase can account for up to 35% of total Ni speciation, this upper 581 value being observed close to the coral reef in the Vavouto Bay. Finally, our results show that 582 the redox state of Fe in the studied lagoon sediments, that were carefully preserved from 583 oxidation during sampling, storage and analysis, is dominated by Fe(III) (i.e. 60 - 80% of 584 total Fe). Despite the significant amounts of Fe(II) that can be found in the studied sediments (*i.e.* 20 - 40% of total Fe), pyrite appears as a scarce host for Fe and it does not contribute to 585 586 Ni speciation at a detectable level in any of the studied samples. However, because of the known possible substitution of Ni^{2+} ions for Fe^{2+} ions within the structure of Fe-sulfides, a 587 588 small contribution of these mineral phases to Ni speciation cannot be dismissed. In the same 589 way, the carbonate minerals (*i.e.* calcite, magnesian calcite and aragonite) that can represent 590 up to 70% of the mineral fraction in the sediments of the Vavouto Bay (Fig. 3; Table S3) do 591 not appear to contribute at a detectable level to Fe and Ni speciation in any of the studied sediments. However, because of the known possible substitution of Fe²⁺ and Ni²⁺ ions for 592 Ca²⁺ ions within the structure of calcite (Dromgoole and Walter, 1990, Hoffman and Stipp, 593 594 2001, Lakshtanov and Stipp, 2007; Mettler et al. 2009) and aragonite (Mejri et al., 2015), a 595 small contribution of these mineral phases to both Ni and Fe speciation cannot be dismissed. 596 All the above-mentioned results indicate that in the studied lagoon sediments Fe is hosted by 597 2/1 clay minerals (mainly smectite and glauconite) for about one half, and by 1/1 clay 598 minerals (mainly chrysotile and greenalite/berthierine), goethite and minor amounts of pyrite 599 for the other half, whereas Ni is hosted by 1/1 clay minerals for about one half, and by 2/1 600 clay minerals and goethite for the other half. Along with detailed mineralogy and sediments 601 chemistry, the evolution of these Fe and Ni speciation along a shore-to-reef gradient helps to 602 draw a general sketch of the influence of the redox state of the sediments on Fe and Ni 603 crystal-chemistry and to assess the actual origin of pyrite and Fe/Ni clay minerals in the 604 lagoon sediments of New Caledonia.

4.2 A contrasted origin for the various Fe- and Ni-bearing mineral phases in the studied lagoon sediments

608

609 Among the three types of Ni-bearing clay minerals identified in the studied lagoon sediments, 610 the first one is a Fe-rich 1/1 trioctahedral phyllosilicate identified as chrysotile. This type of 611 clay minerals has already been recognized as one of the Ni-bearing mineral phases in the 612 Koniambo ultramafic outcrop (Dublet et al., 2012; Fritsch et al., 2016; 2019), as well as in the 613 mangrove sediments of the Vavouto Bay (Noël et al., 2014; 2015) located upstream of the 614 studied lagoon sediments. Therefore, the Ni-bearing chrysotile observed in the studied lagoon 615 sediments is most likely inherited from erosion of the Koniambo lateritic outcrops. The 616 second type of Ni-bearing clay mineral recognized in the studied sediments are Fe-rich 1/1 617 trioctahedral clay minerals identified as greenalite/berthierine. TEM-EDXS analyses show 618 that these Fe-rich 1/1 trioctahedral clay minerals correspond to the most Ni-rich mineral 619 phases observed in the studied sediments (Table 2). The significantly higher Fe content of 620 these clay minerals (between 41 and 54 wt% FeO; Table 2) compared to that in the clay 621 minerals from the saprolite and laterite units of the Koniambo outcrop (at most 7.5wt % FeO; 622 Fritsch et al., 2019) supports the authigenic origin of greenalite/berthierine in the lagoon 623 sediments. This hypothesis is also supported by the authigenic origin reported by Bailey 624 (1988) for odinite, a Fe-rich green clay that is found in shallow marine shelf and reef lagoon 625 at tropical latitudes (Ku and Walter, 2003; Morard et al., 2010). It is noteworthy that odinite 626 can not be confused with the greenalite/berthierine Fe-rich clavs identified by TEM-EDXS in our study since it is significantly richer in Mg (Fig. 4; Table 2). Finally, the third type of Ni-627 628 bearing clay minerals recognized in the studied lagoon sediments is a Fe-rich 2/1 dioctahedral 629 phyllosilicate identified as both glauconite and smectite (Fig. 4; Table 2). Although the 630 authigenic origin of glauconite is widely accepted, the origin of smectite has to be discussed 631 in the present context. This clay mineral has been scarcely detected in the Koniambo outcrop, 632 but the Vertisols and Cambisols that developed on the surrounding volcano-sedimentary 633 settings (Fritsch, 2012) can contain significant amounts of smectite. In addition, the Fe-rich 634 2/1 dioctahedral clay mineral identified as smectite in the studied lagoon sediments shows 635 strong similarities with the Fe-rich nontronite already reported as a major Fe and Ni host in 636 the mangrove sediments of the Vavouto Bay (Noël et al., 2014; 2015). Therefore, the Fe-rich 637 smectite found as one of the Ni-bearing clay minerals in the studied lagoon sediments can be 638 considered as inherited from upstream mangrove sediments and/or Vertisols and Cambisols. 639 Altogether, these results indicate that Fe dominantly occurs as Fe(III) in the studied lagoon 640 sediments, and that the major fraction of this Fe(III) is hosted by Fe-rich 2/1 dioctahedral clay 641 minerals that are either inherited (i.e. smectite/nontronite) or authigenic (i.e. glauconite). In 642 contrast, Ni is mainly hosted by authigenic Fe(II)-bearing 1/1 trioctahedral clay minerals (i.e. 643 greenalite/berthierine).

In addition to clay minerals, the two Fe-sulfides (*i.e.* mackinawite and pyrite) that have been recognized as a host for Fe(II) in the studied sediments (Fig. 5) are considered as mainly authigenic. This assumption relies on the fact that pyritization is a well-known process for marine sediments (Huerta-Diaz et al., 1992; Lovley and Chapelle, 1995; Wang and Morse, 648 1996, Morse and Wang 1997, Neretin et al. 2004, Li et al., 2007; Wang et al., 2012). It is in 649 agreement with S speciation, which shows a global increase of both the fraction of S as 650 sulfides and the pyrite/mackinawite ratio with depth (Fig. S15; Table S6). It is also in 651 agreement with Fe speciation, which shows an increase of Fe(II) with depth in the sediments 652 close to the shore for the Kataviti and Vavouto Bays (*i.e.* KTV and VE2; Fig. S18). These 653 trends strongly supports the hypothesis of an *in-situ* pyritization through the formation of 654 intermediate mackinawite that further transforms to pyrite upon ageing during early 655 diagenesis, as proposed by several authors (Morse at al., 1987; Rickard and Luther, 1997; 656 2007; Wilkin and Barnes, 1997; Benning et al., 2000). However, a possible contribution from 657 the nearby mangrove sediments to the pyrite found in the sediments close to the shore cannot 658 be dismissed. Firstly, because previous studies performed on mangrove sediments located 659 upstream of the Vavouto Bay demonstrated the occurrence of large amounts of pyrite at depth (Noël et al., 2014; 2015). Secondly, because the correlation plot between the fraction of S as 660 661 sulfides and the TOC depicted in Figure S24 suggests that the fraction of S as sulfides in the 662 sediments at the VE2 station (*i.e.* the closest to the mangrove in the Vavouto Bay) is larger 663 than that expected following the linear regression line.

664 Finally, goethite (i.e. the only Fe(III)-oxide identified in the studied lagoon sediments and 665 which also contributes to Ni hosting) is considered as mainly inherited from the Koniambo 666 because of its large occurrence in this lateritic outcrop (Fandeur et al., 2009a; 2009b; Dublet 667 et al., 2102; 2014). In addition, a minor inheritance from mangrove sediments can not be 668 ruled out since a precedent study suggested a possible role of the tidal cycle on the partial 669 oxidation of pyrite and subsequent goethite formation in mangrove sediments (Noël et al., 670 2017). However, a partial authigenic origin for goethite might also be supported by the 671 increasing contribution of this Fe-oxide to Fe speciation across the shore-to-reef gradient in 672 the Vavouto Bay (see discussion below).

674 **4.3. Influence of the redox conditions on Fe and Ni speciation in the studied sediments**

675

676 The results of dissolved oxygen micro-profiling performed at the sediment/water interface 677 indicate anoxic conditions below a maximum depth of 5 mm in all the studied sediments (Fig. 678 S1). However, Fe K-edge XAS results indicate major occurrence of Fe(III) in the studied 679 sediments (Figs. 5 and S18). This apparent discrepancy could be related to a limited anaerobic 680 Fe reduction compared to the global Fe(III) pool. For instance, Fe(III) in crystalline oxides 681 (*i.e.* goethite) would be better preserved from bacterial reduction than Fe(III) in amorphous 682 oxides (i.e. ferrihydrite) even in organic rich sediments (Taylor and MacQuaker, 2011; Barber 683 et al., 2017). In addition, the TOC measured in the studied lagoon sediments (i.e. 1.0-4.5 684 wt%; Table S1; Figs. S2; S3 and S4) is significantly lower than that measured in the nearby 685 mangrove sediments (i.e. 5-15% beneath Rhizophora stand; Marchand et al., 2012; Noël et 686 al., 2015) where Fe reduction was found to be complete with euxinic conditions leading to 687 intense pyritisation (Noël et al., 2015). These results suggest a possible limitation of the TOC 688 pool compared to the Fe(III) pool to explain the low amounts of Fe(II) measured in the 689 studied lagoon sediments. This hypothesis is supported by the higher Fe(II) fraction and TOC 690 content in the Chasseloup Bay (i.e. 40% of total Fe and around 4.5 wt%, respectively) 691 compared to the two other bays (*i.e.* Fe(II) fraction between 20 to 30% of total Fe and TOC 692 between 1.0 and 3.5 wt%). It is also supported by the similar decreasing trend that can be 693 observed for TOC and Fe(II) as a function of the distance to the shore in the Vavouto Bay (i.e. 694 TOC from 2.5 to 1.0 wt% and Fe(II) from 35 to 15% of total Fe; Figs. 5 and S18; Table S8). 695 Although, this trend is not observed in the Kataviti Bay where the Fe(II) fraction remains 696 constant around 20% of total Fe along the shore-to-reef gradient despite a decreasing TOC (*i.e.* from 3.5 to 2.0 wt%; Figs. 5 and S18; Table S8), the amount of Fe(II) in the studied 697

698 lagoon sediments appears to be roughly correlated to the TOC content (Fig. S24). Despite 699 relatively high Fe concentrations compared to other lagoon settings (i.e. 0.17-4.58 wt% Fe; 700 Morisson et al., 2010; Magallanes-Ordóñez et al., 2015) and coastal sediments (i.e. 0.2-7 wt% 701 Fe; Anbuselvan et al., 2018; Koukina et al., 2017) under tropical climate, this correlation 702 suggests that TOC might be a limiting factor for Fe(III) microbial reduction (and in turn, 703 pyritization) in the studied Fe-rich lagoon sediments of New Caledonia. This limiting 704 character of the TOC available to fuel microbial reduction of Fe(III) associated with goethite 705 and/or clay minerals has already been proposed to explain the low formation of pyrite in 706 subsurface redox transition zone or sediments (Benzine et al., 2013; Sabadini-Santos et al., 2014; Wu et al., 2017). 707

708 In addition to the limiting character of TOC compared to the large Fe(III) pool, sediments re-709 suspension could also contribute to the limited microbial reduction of Fe(III) in the studied 710 sediments (Bataillard et al., 2014). This hypothesis is supported by the shallow character of 711 the studied lagoon (*i.e.* not more than 40 m, with a large portion less than 20 m deep; 712 Wattelez et al., 2016) and the high frequency of windy and cyclonic events reported in the 713 South-East Pacific region (Lavigne et Sahal, 2011, Forsberg et al., 2012). A recent study in 714 the similar South-West lagoon of New Caledonia demonstrated the influence of these 715 parameters on the dispersion and transport of suspended particulate matter (Fernandez et al., 716 2017). Following this hypothesis, the Vavouto Bay is expected to be more exposed to 717 sediments re-suspension because of stronger currents in relation with the proximity of a reef 718 pass (Fig. 1). This latter hypothesis is supported by the significant increase in the fraction of 719 Fe(III) across the shore-to-reef gradient in this bay, which is related to the net increase in the 720 fraction of Fe(III) in goethite and the concomitant decrease of Fe(II) in pyrite when 721 approaching the coral reef (Figs. S5 and S18; Table S8). In comparison, the fraction of Fe(III) 722 in the Kataviti Bay does not change significantly across the shore-to-reef gradient because the

723 decrease of Fe(II) in pyrite is compensated by an increase of Fe(II) in clay minerals (i.e. 724 chrysotile and/or greenalite/berthierine; Figs. S5 and S18; Table S8). It is noteworthy that 725 pyrite is detected by EXAFS at the Fe K-edge only in the sediments the closest to the shore 726 and that this fraction remains below 14% of total Fe in all studied sediments (Figs. 5 and S18; 727 Table S8). However, the proposed difference in the redox conditions as a function of the 728 distance to the shore between the Vavouto and the Kataviti Bays is also supported by S 729 speciation. Indeed, S K-edge XANES data indicate a larger decrease of the proportion of S as 730 sulfides from the shore to the reef in the Vavouto Bay (i.e. mean value from 94% to 36% of 731 total S; Table S6) compared to the Kataviti Bay (*i.e.* mean value from 82% to 45% of total S; 732 Table S6).

733 Altogether, these observations suggest that the top layers of the studied lagoon sediments are 734 more or less regularly exposed to oxidation events due to partial re-suspension that are not 735 favorable to the development of sulfidic conditions. Such oscillating redox conditions likely 736 explains the importance of clay minerals on Fe and Ni speciation compared to pyrite because 737 of the better stability of Fe(II)-phyllosilicates in oxic-suboxic conditions compared to Fe(II)-738 sulfides (Luther, 1987; Morse et al., 1987; Luther et al., 1992; Wilson et al., 2006; Dong et 739 al., 2009; Dzene et al., 2018; Rickard and Luther, 2007). In addition, this more or less regular 740 re-oxidation of the top layers of the studied sediments could have important implications on 741 the potential remobilization of the trace metals that are associated with pyrite (Huerta-Diaz et 742 al., 1992, 1998, Scholz and Neumann, 2007, Neumann et al., 2013, Noël et al., 2015, Le Pape 743 et al., 2016), especially Ni-rich pyrite that could be inherited from the mangrove sediments 744 (Noël et al., 2015). Interestingly, the pyrite grains that we observed in the lagoon sediment 745 were found to be either devoid of Ni or to host very low amounts of Ni. These observations 746 are in agreement with the findings of Noël et al. (2015) that the smallest pyrite grains, which 747 are the richest in Ni, are also the most sensitive to oxidation, especially in the sediments

748 beneath the *Rhizophora* stand that are the most exposed to re-aeration (0-50 cm depth) due to 749 tidal pumping on banks along mangrove channels and bio-irrigation by benthic macrofauna in 750 inner *Rhizophora* mangrove. If one expects a partial contribution of the mangrove sediments 751 to the pool of pyrite in the lagoon sediments, only the largest pyrite grains that are the poorest 752 in Ni should be concerned because they show the largest stability (*i.e.* lowest solubilization 753 rates). Further studies on the relative reactivity of pyrite and Fe(II)-bearing clay minerals 754 during simulated redox cycling would help to better evaluate the contribution of this 755 mechanism to the dynamics of trace metals in the lagoon sediments of New Caledonia, and 756 more largely in tropical lagoon sedimentary settings.

758 **5. CONCLUSION**

759

760 The results of this study indicate that goethite (*i.e.* the most abundant mineral phase in the 761 upstream lateritic outcrop) account at most for 30% of total Ni speciation in the studied 762 lagoon sediments. Despite the significant amounts of Fe(II) (i.e. up to 40% of total Fe) that 763 can be found in some of the studied sediments, pyrite appears as a scarce host for Fe that is 764 detected only at the stations close to the shore. More importantly, it does not contribute to Ni 765 speciation at a detectable level in the studied lagoon sediments. On the opposite, Fe(II)-rich 766 1/1 trioctahedral clay minerals identified as chrysotile and greenalite/berthierine, as well as 767 Fe(III)-rich 2/1 dioctahedral clay minerals identified as nontronite and glauconite appear as 768 the major hosts for Fe and Ni in lagoon sediments downstream of lateritic outcrops in New 769 Caledonia. Chrysotile is considered as inherited from either the lateritic outcrop and/or the 770 nearby mangrove sediments, whereas greenalite/berthierine is considered as authigenic. 771 Glauconite is also considered as authigenic, whereas the source of smectite is more 772 controversial since it could originate from the nearby mangrove sediments or soils developed 773 upon volcano-sedimentary settings (i.e. Vertisols and/or Cambisols) or have formed in situ 774 upon early diagenesis. The better stability of Fe(II)-bearing clay minerals in oxic-suboxic 775 conditions compared to Fe(II)-sulfides could explain their importance in these shallow Fe-rich 776 sedimentary settings that are subjected to more or less regular re-oxidation events due to re-777 suspension of the sediments top-layers. In tropical lagoon environments, green clays 778 authigenesis might thus represent a key process in the scavenging of trace metals, especially 779 Fe and Ni (and possibly Cr), that are delivered to the shoreline ecosystems by continental 780 erosion. From a geological perspective, this latter point suggests that the underestimated 781 importance of green clays authigenesis recently proposed for the geological cycling of Fe 782 (Rasmussen et al., 2014a; 2014b; 2015; 2016; 2017; Balderman et al., 2015; 2017; Konhauser 783 et al., 2017) might not only concern deep-sea sediments, but also Fe-rich shallow lagoon 784 sedimentary settings. In addition, regarding the hosting capacity of greenalite/berthierine 785 towards Ni (and possibly Cr) demonstrated in our study, green clays authigenesis might also 786 play, or have played, an important role on the coastal geological cycles of a large set of trace 787 metals. From an environmental perspective, the results of this study suggest that the reactivity 788 of clay minerals, and especially green clays, towards trace metals upon early diagenesis 789 should be more largely considered in ecotoxicological study aimed at evaluating the potential 790 threat of continental inputs towards the benthic biodiversity in tropical lagoon sedimentary 791 settings.
