# Sound absorption by green walls at normal incidence: physical analysis and optimization

## Summary

Sound absorption by different green wall systems at 2 normal incidence is investigated between 100 and 1000 3 Hz. Measurements are conducted in an impedance 4 tube in order to estimate the effective acoustic prop-5 erties of plants and soils. Using these properties, the 6 transfer matrix method is employed to simulate absorption coefficient and surface impedance of multi-8 layer green wall geometries. Results show that an 9 adequate choice of layer geometries may result in an 10 efficient sound absorption in a broad frequency range 11 due to two main mechanisms: thickness resonances 12 of the wall structure and guarter wave transformer 13 effect of plant laver between air and soil media. To 14 optimize the absorption bandwidth of green facade, 15 continuous living wall system or modular living wall 16 system, effect of plant, soil or air layer thicknesses 17 on simulated absorption coefficient are also provided. 18 With a 16 cm thick optimized system, average 19 absorption coefficients typically reach 0.2 be-20 tween 300 and 1000 Hz for a green facade, 0.2 21 between 200 and 1000 Hz for a continuous liv-22 ing wall system and 0.9 between 300 and 1000 23 Hz for a modular living wall system. 24

#### 1 Introduction 25

Green walls are installed in urban areas to intro-26 duce more vegetation without occupying any space 27 at street level. When applied in a significant urban 28 scale, they may contribute to urban biodiversity [1], 29 air quality [2], temperature reduction and mitigation 30 of the heat island effect [3] and acoustic protection 31 [4]. Buildings and roads are made of acousti-32 cally rigid materials (asphalt, brick, concrete, 33 glazing, ...) which reflect sound emitted from 34 road traffic and therefore strongly amplify en-35 vironmental noise. In that context, building 36 envelope greening was found to be an efficient 37 solution for different noise issues in cities: use 38 of green roofs to attenuate sound propagating 39

above buildings from streets toward courtyards [5]; significant traffic noise reduction with vegetated low-height noise barriers placed close to 42 the driving lanes [6]; Abatement of noise reflection by facade in narrow urban streets in the presence of green wall systems [5].

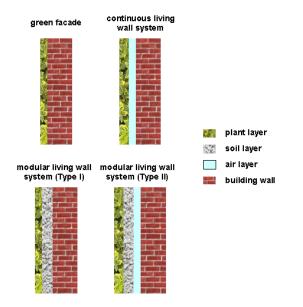


Figure 1: Schematic representation of different green wall systems

Green walls can be subdivided in two main systems: 46 green facades are ground based systems made of 47 plants climbing along a wall; living walls are non-48 ground based systems involving a frame and a 49 support and allowing the use of a wider variety of 50 plants [7]. The former falls into two categories: con-51 tinuous living wall systems and modular living wall 52 systems. In continuous living wall systems, the frame 53 is fixed to the wall. An air gap is kept between the 54 frame and the building wall to bring natural ventila-55 tion and protect against humidity. The frame is usu-56 ally covered with layers of permeable and root proof 57 screens forming pockets for the introduction of plants 58 without substrate. Modular living wall systems are 59 composed of several connected elements made of poly-60 meric material containing both plants and a substrate 61 made of organic or/and inorganic compounds where 62 the roots can proliferate. They often have a flat back-63 ing surface which is directly fixed on the building sur-64 face. A schematic representation of these green wall 65 systems is displayed in Figure 1. Green façade geom-66 etry is composed of a single layer of plants fixed on a 67 building wall (idealized by a rigid backing condition). 68 In continuous living wall system, the plant layer fixed 69 on a support is separated from the building wall by an 70 air gap. Type I modular living wall system is made of 71 a plant layer atop a substrate layer directly mounted 72 on a building wall. Finally, in type II modular living 73 wall system, plant and soil layers are separated from 74 building wall surface by an air gap. 75

Acoustic characterizations of green walls have been 76 conducted both in situ [4, 8] and in reverberant rooms 77 [4, 8, 9]. Insertion loss measurements performed in 78 situ by Wong et al on types I and II modular living 79 wall systems [4] displayed a strong dependence upon 80 thickness of plants and substrate constituents in the 81 audible frequency range. Sound absorption coefficient 82

averaged for all incident angles was also measured 83 in reverberant room using the ISO standard method 84 [10]. For living wall system thicknesses vary-85 ing between 9 and 48 cm, they reported aver-86 age sound absorption coefficients between 0.3 87 and 0.5 for frequencies ranging from 300 Hz 88 Such values were found higher to 5 kHz. 89 than those measured for commonly used build-90 ing materials such as brick, concrete or glass. 91 Smaller values, between 0.05 and 0.3, were measured 92 below 300 Hz. Shimizu et al demonstrated that in-93 sulation performance of a steel noise barrier may be 94 improved by 0.5 to 5.5 dB when installing a type II 95 living wall system [8]. They reported average absorp-96 tion coefficient higher than 0.75 between 100 Hz and 97 1.6 kHz for this system. Sound reduction index mea-98 surement performed by Azkorra et al [9] showed that qq reduction of airborne noise with Type II living wall 100 system is lower than those of common construc-101 tive solutions such as brick or thermal double 102 glazing. Average absorption coefficient of their sys-103 tem was found similar to Wong's results [4] above 300 104 Hz and much higher, between 0.4 and 0.5, below 300 105 Hz. 106

Laboratory measurements have been realized sepa-107 rately on plants and soils to improve the understand-108 ing of sound absorption by green wall systems. As 109 stated before, all incidence average absorption coef-110 ficient is measured in a reverberant room [10], while 111 112 normal incidence absorption coefficient is characterized in an impedance tube [11]. Yang et al provided 113 average absorption coefficients for different configu-114 rations: soil, plants and soil covered by plants with 115 thicknesses varying between 9 and 30 cm for 116

plants and between 5 and 20 cm for soils [12]. 117 They showed that sound absorption by plants is neg-118 ligible below 400 Hz. Conversely, average absorption 119 coefficient of soil is moderate (between 0.25 and 0.5) 120 below 200 Hz and high (between 0.5 and 0.9) above 121 200 Hz and decreases with moisture content. A maxi-122 mum value of 0.9 was obtained at 1 kHz. The effect of 123 plant coverage over a soil was found to be frequency 124 dependent [13, 14, 15, 16, 17]: average absorption 125 coefficient increases below 2 kHz and decreases above 126 2 kHz. Normal-incidence absorption coefficient was 127 studied by Horoshenkov et al [13] and Benkreira et 128 al [14] for similar configurations including five types 129 of plants and two different soils. As in reference [12], 130 they observed that a foliage layer placed above a soil 131 may lead to a significant increase of acoustic absorp-132 tion coefficient in a broad frequency range for normal 133 incidence [13]. This result was correlated to leaf area 134 density and orientation but the underlying physical 135 phenomenon remained unclear. Ding et al [15] re-136 ported measurements and Finite Difference Time Do-137 main simulations of sound absorption by porous sub-138 strates covered by a single leaf. As in [12], they found 139 that leaf coverage increases sound absorption below 2 140 kHz and decreases it beyond 2 kHz. Attal et al [17] 141 characterized the effective speed of sound and charac-142 teristic impedance of plant and soil samples separately 143 and used the transfer matrix method in order to calcu-144 late normal incidence absorption coefficient of plant, 145 soil and plant-soil samples of different thicknesses. 146 They found that quarter wavelength resonance 147 of the sample influences greatly sound absorp-148 tion spectrum for rigid backing condition. 149

In order to improve the physical understanding of 150 sound absorption by green wall systems, this work 151 provides measurements carried out in an impedance 152 tube on plants and soil samples separately in order 153 to determine their effective speed of sound and char-154 acteristic impedance. These experimental results are 155 then used to calculate the normal incidence absorp-156 tion coefficient of composite samples made of plants, 157 soil and air layers using the Transfer Matrix 158 Method. The experimental setup is described 159 in section 2. Measurement of intrinsic proper-160 ties of plants and soils are reported in sections 161 **3** and **4** respectively. Finally, sound absorption at 162 normal incidence is studied in section 5 for the differ-163 ent green wall systems displayed in Figure 1. Sim-164 ulation method is validated by comparing cal-165 culated and measured absorption coefficients. 166 Variation of sound absorption with plants, soil 167 and/or air gap thicknesses is provided for each 168 green wall system. 169

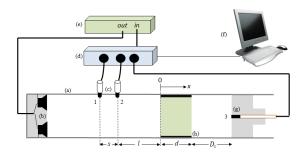


Figure 2: Schematic view of the experimental setup: (a) stainless steel tube; (b) cylindrical PVC disk integrating 4 loudspeakers; (c) microphones; (d) sound card; (e) amplifier; (f) computer; (g) flush mounted microphone on movable piston; (h) sample holder containing the sample.

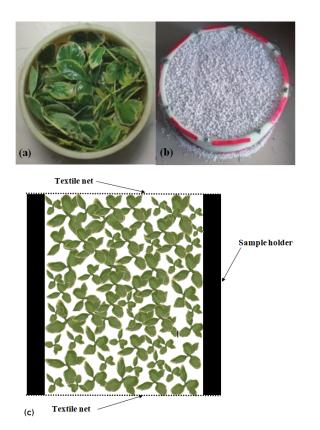


Figure 3: (a) Japanese spindle sample. (b) Perlite sample. (c) Schematic view of plant in sample holder.

## 2 Experimental setup and measurement method 170

Acoustic characterization of samples is performed in 172 an impedance tube using the three-microphone two-173 load method [18, 19, 20]. The impedance tube of 174 circular cross section (length 1.9 m, inner diameter 175 192 mm, wall thickness 15 mm) is made of stain-176 less steel. Thus, a diameter significantly larger than 177 sample heterogeneities (leaves, **stones**...) is used [17]. 178 Four broadband loudspeakers (type Visaton FRS) are 179 mounted in the PVC front disk located at the front 180 end of the tube. A movable Teflon piston (axial thick-181 ness 61 mm) is position at the other end. It is as-182 sumed to be acoustically rigid. A plastic sample 183 holder (axial thickness 16 cm) contains plants or soil 184 maintained by two pieces of textile net. Acoustic pres-185 sure measurements are performed with three micro-186 phones (Sennheiser MKE 2P with 3.8 mm diameter). 187 Two microphones are located in front of the sample 188 respectively at 80 and 90 cm from the front end of 189 the tube (Fig. 2). According to [11], the lowest 190 frequency of measurement corresponds to an 191 acoustic wavelength in air equal to one hun-192 dredth of microphone separation distance i.e. 193 34 Hz for the considered geometry. The third 194 microphone is located at the center of the movable 195 piston behind the sample. The sound card (RME-196 Fireface 802) control inputs and outputs of the sys-197 tem. The excitation signal is a step by step sine. 198

Measurement method is based on plane wave assumption in the tube which is **theoretically** verified up to 1037 Hz in air. This upper frequency bound decreases when speed of sound in sample material is lower than speed of sound in air. As indicated in ISO 10534-2 standard [11], the minimal distance between sample surface and the closest microphone is larger than tube diameter in all experiments to retrieve a plane wave front at the microphone positions. After calibrating each microphone using [21], the sample under test (thickness d) is inserted at a **fixed** position inside the tube. Then, transfer functions  $H_{mn}(D_i)$  between microphones m and n  $(1 \le m \le 3, 1 \le n \le 3, m \ne \mathbf{n})$  are measured for backing cavity lengths  $D_i$   $(1 \le i \le 2)$ . Assuming  $e^{+j\omega t}$  time dependency where  $\omega$  is the circular frequency and t the time, acoustic pressure  $P_i(x)$ and velocity  $V_i(x)$  on sample front (x = 0) and back (x = d) surfaces are written for backing cavity i

where  $\rho_0, c_0$  and  $Z_0 = \rho_0 c_0$  are air density, speed of sound and characteristic impedance respectively and  $k_0 = \omega/c_0$  is the acoustic wave number. Sample transfer matrix  $\mathbf{T}(\omega)$  is written as

are determined using the transfer functions measuredbetween the microphones.

Assuming that the sample may be described as an effective ideal fluid medium,  $\mathbf{T}(\omega)$  is written as

where  $k_c = \omega/c$  and  $Z_c$  are respectively the characteristic wave number and the characteristic impedance of the material constituting the sample. c is the effective speed of sound in the sample.  $k_c$ ,  $Z_c$  and c are deduced from the transfer measured matrix using

Finally, the absorption coefficient  $\alpha(\omega)$  and the surface impedance  $Z_s(\omega)$  of the sample in rigid backing condition are obtained using

## 3 Measurement of plant sam- 218 ples 219

Japanese spindle is an evergreen small shrub with oval 220 leaves which are about 5 cm long and 3 cm wide (Fig. 221 3 a). The sample is constituted by a set of small 222 branches introduced in the sample holder (Fig 223 3.c). The foliage is disposed in the whole vol-224 ume of the sample holder to obtain the most 225 homogeneous distribution possible. A sheet of 226 tulle with fine mesh is added on the top and bot-227 tom of the sample holder to keep the air/plants in-228 terface perpendicular to tube axis. The tulle net 229 on the top side is assumed to be the front sur-230 face of the sample. Japanese spindle is chosen 231 for several reasons: its is largely available; its 232 leaves are small compared to tube diameter; 233 its foliage is not altered when separated from 234 the trunk during three days; its foliage is com-235 pact and thick allowing for samples of lower 236 porosity and larger thickness. The experimental 237 results are reported for 8 and 16 cm thick samples 238 made of Japanese spindle plants with a porosity of 239 95%. Porosity is evaluated by dividing the total 240 volume of the branches (obtained by submerg-241 ing the branches in a water tank and measur-242 ing the water level variation) by the internal 243 volume of the sample holder. Measurements 244 made in winter on japanese shrubs indicate an 245 average foliage thickness of 20 cm and an av-246 erage porosity of 97%. Foliage porosity is in-247 homogeneous and increases when moving away 248 from the source of light. Acoustic measurements 249 are performed for four different geometrical arrange-250 ments of the same branches. 251

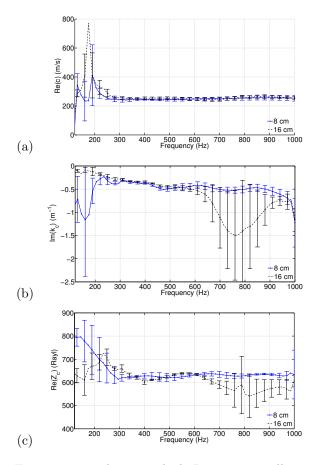


Figure 4: 8 and 16 cm thick Japanese spindle samples with 95% porosity: (a) real parts of effective speed of sound; (b) imaginary part of acoustic wavenumber; (c) real part of **non-normalized** characteristic impedance. **Quantities measured in an impedance tube**. Full line: average value; error bars: standard deviation.

Figure 4 displays the real part of the effective speed 252 of sound, the imaginary part of the acoustic wave 253 number (attenuation) and the real part of the char-254 acteristic impedance versus frequency. Above 250 255 Hz, spindle plants behaves as a nondispersive medium 256 having an almost constant speed of sound of 250 m/s, 257 a slowing down of approximately 25% with respect to 258 air speed of sound. Attenuation increases monoton-259 ically but remains weak with a maximum value of 1 260 Np/m at 1000 Hz. The mean value of the real part 261 of the characteristic impedance is about 620 Rayl in 262 the 300-1000 Hz frequency range, a value correspond-263 ing to a 50% increase with respect to air characteris-264 tic impedance. Similar measured values are ob-265 tained with 8 and 16 cm thick samples. Some dis-266 crepancies are observed when the standard deviation 267 between measurements becomes high: below 200 Hz 268 for 8 and 16 cm thick samples and between 680 and 269 880 Hz for 16 cm thick samples. As attenuation is 270 weak in plant sample, some elements of  $\mathbf{T}(\omega)$  get close 271 to zero when  $kd \approx n\pi/2$ . At these frequencies, inver-272 sion procedure becomes sensitive to small changes in 273

sample geometry or small errors on phase measure-ments.

Frequency spectra of the absorption coefficient and 276 the surface impedance modulus of Japanese spindle 277 samples in rigid backing condition are given in Figure 278 5. Variation of the surface impedance modulus versus 279 frequency displays minima associated to the quarter-280 wavelength resonance of the sample at 781 Hz for d =281 8 cm and 391 Hz for d = 16 cm for a speed of sound of 282 250 m/s. Maximum of the surface impedance mod-283 ulus (antiresonance) at 781 Hz coincides with half-284 wavelength resonance of 16 cm thick sample. Due to 285 weak attenuation (Fig. 4b), acoustic absorption re-286 mains relatively low (< 0.35) in the whole frequency 287 range. These values are close to previously pub-288 lished measurements of plant samples having 289 290 similar porosity and thickness [13]. Highest absorption coefficients are obtained near sample quar-291 ter wave resonance where a better matching is ob-292 tained between the surface impedance of the sample 293 and air characteristic impedance. 294

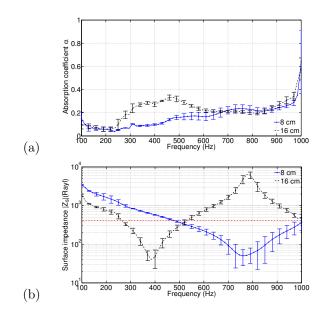


Figure 5: 8 and 16 cm thick Japanese spindle samples with 95% porosity in rigid backing condition: (a) absorption coefficient; (b) surface impedance modulus . **Quantities measured in an impedance tube**. Full line: average value; error bars: standard deviation; red dotted line: air characteristic impedance.

## 4 Measurement of soil samples

Perlite is an amorphous volcanous glass which expands greatly and becomes porous when heated above 850°C. Superheated perlite is used as a soil amendment or alone as a medium for hydroponics, starting cuttings and green walls. Experimental results are reported for 8 and 16 cm thick samples of perlite (Fig. 3b). A sheet of tulle is used to keep the air/perlite interface perpendicular to the axis of the tube. Acoustic measurements are performed for four different geometrical arrangements of the same pebbles.

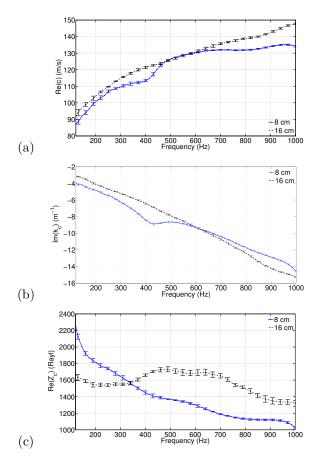


Figure 6: 8 and 16 cm thick perlite samples: (a) real parts of effective speed of sound; (b) imaginary part of acoustic wavenumber; (c) real part of **non-normalized** characteristic impedance (b) versus frequency. **Quantities measured in an impedance tube**. Full line: average value; error bars: standard deviation.

Figure 6 displays the real part of the effective speed 306 of sound, the imaginary part of the acoustic wave 307 number (attenuation) and the real part of the charac-308 teristic impedance of perlite sample versus frequency. 309 The real part of the effective speed of sound increases 310 monotonically from approximately 90 to 150 m/s in 311 the 100-1000 Hz frequency range (Fig. 6a). In that fre-312 quency range, perlite behaves as a dispersive medium 313 with a speed of sound 2 to 4 times smaller than speed 314 of sound in air. Attenuation is much larger than 315 in plant sample and increases monotonically from 5 316 Np/m at 100 Hz to 15 Np/m at 1000 Hz (Fig. 6b). 317 Characteristic impedance spectra of 8 and 16 cm thick 318 samples differs strongly. From Fig. 6a, upper bound 319 frequency for plane wave propagation in perlite sam-320 ple is approximately equal to 300 Hz. Therefore, 321 although incident and reflected waves are plane in 322 air, multimode propagation may occur in the sam-323 ple above 300 Hz in particular if air/perlite inter-324

face is not perfectly perpendicular to the axis of the 325 tube. In addition, this type of substrate may 326 exhibit graded properties (density, porosity...) 327 requiring more sophisticated model and inver-328 sion method which are beyond the scope of 329 this paper. Several authors have reported that 330 acoustic absorption was significantly modified 331 by the gradient of properties in functionally 332 graded polyurethane foams [22, 23]. 333

Frequency spectra of the absorption coefficient and 334 the surface impedance modulus of perlite samples 335 in rigid backing condition are displayed in Figure 336 7. Absorption coefficient exhibits a resonance-337 like behaviour with frequency similar to the 338 one previously reported for light substratum 339 including perlite [13, 14]. Absorption coeffi-340 341 cient increases gradually from 0.2 at low frequency up to 0.8-0.9 at absorption peak and 342 decreases slightly to a value close to 0.6-0.7 at 343 higher frequencies. As for plant samples, quarter-344 wavelength resonances of perlite samples are associ-345

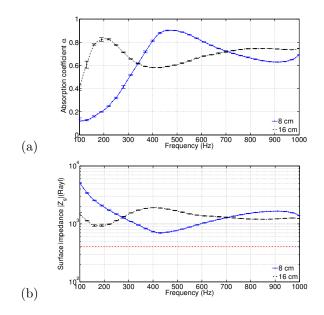


Figure 7: 8 and 16 cm thick perlite samples in rigid backing condition: (a) absorption coefficient; (b) surface impedance modulus. **Quantities measured in an impedance tube**. Full line: average value; error bars: standard deviation; red dotted line: air characteristic impedance.

ated to surface impedance minima at 433 Hz for d =346 8 cm and 166 Hz for d = 16 cm. Due to the high 347 attenuation of perlite (Fig. 6b), no other resonance 348 or antiresonance appears at higher frequencies. Real 349 and imaginary parts of surface impedance are 350 of the same order of magnitude near quarter 351 wave resonance and surface impedance modu-352 lus always remains larger than the character-353 istic impedance of air. Although impedance 354 matching condition is not fulfilled in that case, 355 it may be observed that the maxima of the 356 acoustic absorption coefficient and the minima 357 of the surface impedance modulus take place 358 at nearby frequencies for both samples. An ef-359 ficient absorption of incident acoustic energy by the 360 perlite sample may be seen a two-step process which 361 requires on one hand a limited impedance mis-362 match between the characteristic impedance of air 363 and the surface impedance of the sample and, on the 364 other hand, a high attenuation of the acoustic wave 365 in the sample. 366

## 5 Optimization of sound absorption by green walls

### 5.1 Calculation method

Acoustic absorption of samples composed of spindle, perlite and air layers may be calculated using matrix manipulation. This model relies upon the reduction of a real green wall system into the su-

perposition of homogeneous layers represent-374 ing plants, substrate or air separated by plane 375 interfaces. Such simplified model may not sim-376 ulate the whole complex interaction between 377 air, plants and substrate or the natural gradi-378 ent of porosity of plants related to illumina-379 tion. However, it may be useful to identify the 380 basic acoustic phenomena taking place when 381 sound is absorbed by an air/plant/substrate 382 multi-layered system. As spindle behaves as a 383 homogeneous nondispersive medium, its transfer ma-384 trix  $\mathbf{T}_{plant}(\omega, d_{pl})$  for a layer of thickness equal to 385  $d_{pl}$ , is calculated using measured effective speed of 386 sound and characteristic impedance (deduced from 387 the transfer matrix of 8 cm thick spindle samples) 388 together with Eq. (11). For perlite layers, matrix 389  $\mathbf{T}_{soil}(\omega, d_{so})$  measured for  $d_{so} = 8 \ cm$  or  $d_{so} = 16 \ cm$ 390 is employed as it is. Transfer matrix of a slab of air 391  $\mathbf{T}_{air}(\omega, d_{ai})$  is calculated using Eq. (11) with  $k = k_0$ 392 and  $Z_c = Z_0$ . Transfer matrices of composite sam-393 ples  $\mathbf{T}_{comp}(\omega)$  used to determine absorption coeffi-394 cient and surface impedance with Eq. (15) and (16)395 are expressed as follow: 396

$$\mathbf{T}_{comp}(\omega) = \mathbf{T}_{plant}(\omega, d_{pl}) \tag{17}$$

for green facade,

$$\mathbf{T}_{comp}(\omega) = \mathbf{T}_{plant}(\omega, d_{pl})\mathbf{T}_{air}(\omega, d_{ai})$$
(18)

for continuous living wall system,

$$\mathbf{T}_{comp}(\omega) = \mathbf{T}_{plant}(\omega, d_{pl}) \mathbf{T}_{soil}(\omega, d_{so})$$
(19)

for type I modular living wall system and

$$\mathbf{T}_{comp}(\omega) = \mathbf{T}_{plant}(\omega, d_{pl}) \mathbf{T}_{soil}(\omega, d_{so}) \mathbf{T}_{air}(\omega, d_{ai})$$
(20)

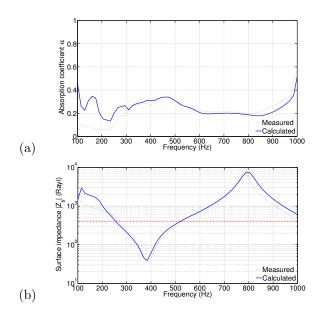


Figure 8: 16 cm thick spindle layer in rigid backing condition: (a) absorption coefficient; (b) surface impedance modulus. Red dotted line: air characteristic impedance.

To validate the calculation method, calculated ab-398 sorption coefficient and surface impedance modulus 399 are compared to measured ones in the 100-1000 Hz 400 frequency range for **three** cases. The first test case 401 is a 16 cm thick spindle layer with rigid backing con-402 dition. Calculated results are obtained by using the 403 effective properties deduced from 8 cm thick spindle 404 layer. They are compared to measurements in Fig. 8. 405 A good agreement is found above 250 Hz. At lower 406 frequencies, noticeable differences observed for both 407 absorption coefficient and surface impedance modulus 408 are the consequence of effective properties discrepan-409 cies between measurements on 8 and 16 cm spindle 410 samples (Fig. 4). 411

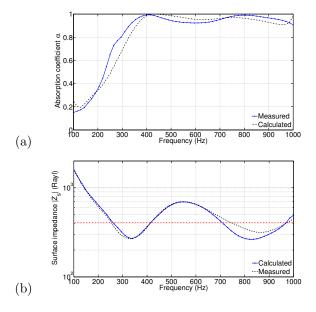


Figure 9: 8 cm thick spindle layer atop 8 cm thick perlite layer in rigid backing condition: (a) absorption coefficient; (b) surface impedance modulus. Red dotted line: air characteristic impedance.

The second test case is a sample composed of a 8 412 cm thick spindle layer placed atop a 8 cm thick per-413 lite layer. A very good agreement is obtained in the 414 whole frequency range for both absorption coefficient 415 and surface impedance modulus (Fig. 9). A high ab-416 sorption coefficient is obtained in a broad frequency 417 range when covering the soil with plants as previ-418 ously reported in [14]. The broad absorption peak 419

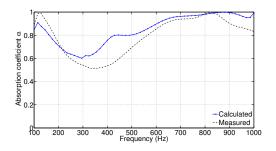


Figure 10: Absorption coefficient of a 8 cm thick spindle layer atop 8 cm thick perlite layer with a 16 cm thick air backing cavity.

between 400 and 1000 Hz is related to a good match-420 ing between the surface impedance of the sample and 421 characteristic impedance of air  $(Z_0 \approx 410 \text{ Rayl})$  in 422 this frequency range. The presence of two minima of 423 the surface impedance modulus located near 350 and 424 850 Hz suggests that at least two different physical 425 phenomena contributes to this broadband impedance 426 matching. This question is discussed in more details 427 in section 5.4. When comparing both test cases, it ap-428 pears that discrepancies appearing at low frequency in 429 effective properties of plants affect significantly simu-430 lation results only if the overall absorption coefficient 431 is low. 432

The last test case is constituted by the previ-433 ous sample in front of a 16 cm thick air back-434 ing cavity. Despite some differences between 435 simulated and measured absorption coefficient 436 spectra (Fig. 10), the main variations with re-437 spect to the second test case (Fig. 9a) are cor-438 rectly predicted by the transfer matrix model: 439 first absorption peak shifts down from 400 Hz 440 to approximately 130 Hz; second absorption 441 stays around 850 Hz; absorption coefficient be-442 tween absorption peaks decreases from 0.95 to 443 0.5-0.6. 444

#### 5.2Sound absorption by green facade 445

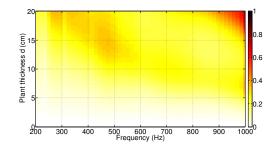


Figure 11: Green facade: variation of simulated absorption coefficient at normal incidence versus plant layer thickness.

Green facade geometry may be schematically repre-446 sented by a plant sample with rigid backing condi-447 tion studied in section 3. Normal incidence absorp-448 tion coefficient by green facade with  $d_{pl} = 8 \ cm$  and 449  $d_{pl} = 16 \ cm$  is displayed in Fig. 5a. Although thick-450 ness resonances occur in the 200-1000 Hz frequency 451 range for this geometry, sound absorption remains 452 limited by the weak acoustic attenuation in spindle. 453 The effect of spindle layer thickness  $d_{pl}$  on the absorp-454 tion coefficient is displayed in Fig. 11 for  $d_{pl}$  vary-455 ing between 0 and 20 cm. Simulations are not per-456 457 formed below 200 Hz to avoid aforementioned discrepancies. When  $d_{pl} \leq 12$  cm, absorption coefficient is 458 low (< 0.3) in the whole frequency range. For thicker 459 plant layers, the absorption coefficient increases near 460 thickness resonance frequencies to reach a maximum 461

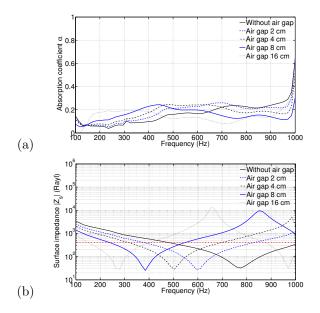


Figure 12: 8 cm thick spindle layer atop an air backing cavity of variable thickness: (a) absorption coefficient; (b) surface impedance modulus. Red dotted line: air characteristic impedance.

of 0.35 in the 300-500 Hz frequency range (quarter of 462 wavelength resonance) and 0.6 above 900 Hz (three 463 quarter of wavelength resonance).

#### 5.3Sound absorption by continuous 465 living wall system 466

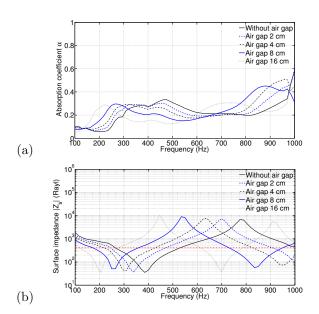


Figure 13: 16 cm thick spindle layer atop an air backing cavity of variable thickness: (a) absorption coefficient; (b) surface impedance modulus. Red dotted line: air characteristic impedance.

From an acoustical perspective, the main difference 467 between continuous living wall system and green fa-468 cade is the presence of an air gap separating plants 469 from building wall. The effect of air gap of thick-470 ness  $d_{ai}$  on the absorption coefficient and the surface 471 impedance is illustrated in Figures 12 and 13 for  $d_{pl}$ 472 equal to 8 and 16 cm respectively. In the consid-473 ered frequency range, both quarter of wavelength and 474 three quarter of wavelength resonances shift down in 475 frequency with increasing air gap thickness. Absorp-476 tion coefficient is always less than 0.3 for  $d_{pl} = 8$  cm. 477 It reaches 0.5 above 800 Hz for  $d_{pl} = 16$  cm even when 478

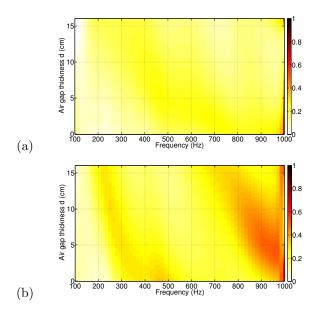


Figure 14: Continuous living wall system: variation of simulated absorption coefficient at normal incidence versus air gap thickness: (a) 8 cm thick spindle layer (b) 16 cm thick spindle layer.

air gap thickness is small. More generally, the variation of absorption coefficient with air gap thickness  $d_{pl}$  is displayed in Figure 14 for  $d_{ai}$  varying between 0 and 16 cm.

When comparing to green facade (Fig. 11), an increase of absorption coefficient is observed in the continuous living wall system with  $d_{pl} = 16$  cm due to quarter of wavelength resonance between 200 and 500 Hz and to three quarter of wave length resonance between 700 and 1000 Hz. Frequencies of these absorption peaks may be adjusted by an adequate choice of air gap thickness.

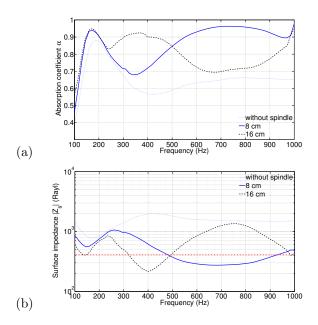


Figure 15: spindle layer of variable thickness atop 16 cm thick perlite layer: (a) absorption coefficient; (b) surface impedance modulus. Red dotted line: air characteristic impedance.

### 5.4 Sound absorption by type type I modular living wall system

The impact of plant layer thickness on sound absorp-493 tion is studied for type I modular living wall sys-494 tems composed of a spindle layer of variable thick-495 ness superposed on a perlite layer of constant thick-496 ness. Figure 15 displays the absorption coefficients 497 and the surface impedance moduli of three different 498 geometries in rigid backing condition: a 16 cm thick 499 perlite layer, two samples composed of a 8 or 16 cm 500 thick spindle layer placed on top of a 16 cm thick 501 perlite layer. When  $d_{so} = 16$  cm, the amplitude of 502 the waves reflected by the backing surface of the per-503 lite sample is small and the physical analysis is sim-504 plified. As mentioned in section 4, the absorption 505 peak observed around 166 Hz for the perlite single 506 layer corresponds to a quarter wavelength thick-507 ness resonance which improves impedance matching 508 with air and facilitates energy transmission into the 509

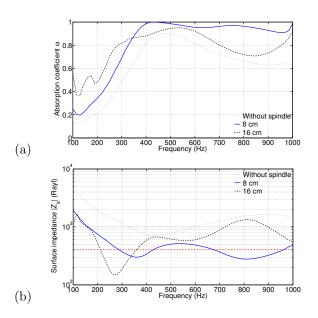


Figure 16: spindle layer of variable thickness atop 8 cm thick perlite layer: (a) absorption coefficient; (b) surface impedance modulus. Red dotted line: air characteristic impedance.

sample. When a spindle layer is added, total sample 510 thickness increases and fundamental quarter wave-511 length resonance slightly shifts down in frequency. 512 Around this mode, the surface impedance matches 513 better air characteristic impedance due to the plant 514 coverage and a higher absorption coefficient is ob-515 tained. Additional peaks of absorption coefficient and 516 minima of sample surface impedance modulus are ob-517 served around 730 Hz and 365 Hz for spindle layer 518 thickness of 8 and 16 cm respectively. At these fre-519 quencies, acoustic wavelength in spindle is approxi-520 mately four times spindle layer thickness which sug-521 gests a quarter-wave transformer effect. In a quarter 522 wave impedance transformer, a transmission 523 line of length one-quarter wavelength is used to 524 present at its input the dual of the impedance 525 with which it is terminated. This properties is 526 obtained when  $Z_{trans} = \sqrt{Z_{in}Z_{load}}$  where  $Z_{trans}$ , 527  $Z_{in}$  and  $Z_{load}$  are the characteristic impedance 528 of the transmission line, the input impedance 529 and the load impedance respectively. For the 530 considered case,  $(Z_{in} = Z_0 \approx 410 \text{ Rayl})$  and 531  $(Z_{load} = Z_{cperlite} \approx 1600 \text{ Rayl}).$  The character-532 istic impedance of the impedance transformer 533  $Z_{trans} = \sqrt{Z_0 Z_{cperlite}} \approx 810$  Rayl only differs by 534 20% from characteristic impedance of spindle. 535 Therefore, additional peaks in absorption coefficient 536 may be attributed to the impedance matching be-537 tween air and perlite provided by spindle which oper-538 ates as a quarter-wave transformer. 539

In the case of a thinner perlite layer, reflection from backing surface takes place and physical analysis becomes more complicated. As an example, absorption coefficients and surface impedance moduli are given 543 in Figure 16 for 8 and 16 cm thick spindle layers atop 544 of a 8 cm thick perlite layer in rigid backing condition. 545 As previously, when adding a plant layer, quarter of 546 wavelength resonance frequency shifts down from 433 547 Hz to 360 Hz when  $d_{pl} = 8$  cm, and to 273 Hz when 548  $d_{pl} = 16$  cm. However, the second minima of sur-549 face impedance modulus at 810 Hz ( $d_{pl} = 8$  cm) and 550 566 Hz ( $d_{pl} = 16$  cm) does not correspond anymore 551 to a quarter of wavelength in spindle layer due to re-552 flection from backing surface. At these minima, the 553 surface impedance modulus is higher for  $d_{pl} = 16$  cm 554  $(Z_s \approx 590 \text{ Rayl})$  than for  $d_{pl} = 8 \text{ cm} (Z_s \approx 280 \text{ Rayl})$ . 555 Consequently, the broadband impedance matching 556 and the absorption coefficient obtained for  $d_{pl} = 8 \text{ cm}$ 557 are degraded when the plant thickness is increased to 558 16 cm. 559

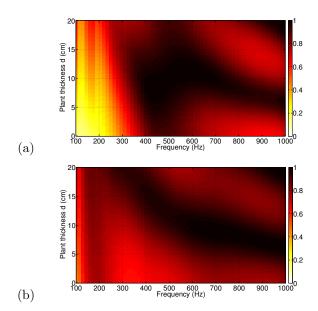


Figure 17: Type I modular living wall system: variation of simulated absorption coefficient at normal incidence versus spindle layer thickness: (a) 8 cm thick perlite layer (b) 16 cm thick perlite layer.

A more complete representation of the absorption 560 coefficient of a type I modular living wall system com-561 posed of a spindle layer of variable thickness atop of 562 a 8 or 16 cm thick perlite layer is given in Figure 17. 563 This green wall system exhibits a much better acous-564 tic absorption than green facade and continuous living 565 wall because of soil layer attenuation. Thus, for a 8 566 cm thick perlite layer, efficient absorption ( $\alpha > 0.9$ ) 567 is obtained in the 350-1000 Hz frequency range when 568  $8 \text{ cm} \leq d_{pl} \leq 10 \text{ cm}$  under normal incidence. A 569 more realistic sound field conditions such as 570 diffuse field will tend to smooth out the absorp-571 tion levels over the frequency range and reduce 572 the maximum level of absorption. For a thicker 573 perlite layer ( $d_{so} = 16$  cm), efficient absorp-574 tion is observed in a narrower frequency range 575 and the acoustic absorption coefficient remains higher 576 than 0.5 in the whole frequency range for all plant 577 layer thicknesses. 578

### 5.5 Sound absorption by type type II modular living wall system

This section focuses on the effect, on the acoustic ab-581 sorption, of an air gap introduced between the plant-582 soil bi-layer and the building wall. A previous work 583 has reported that the addition of a backing air 584 cavity was an efficient way to increase sound 585 reduction index of green roofs [24]. Three dif-586 ferent configurations with an air gap of variable thick-587 ness are simulated: 8 or 16 cm thick spindle laver atop 588 of 8 cm thick perlite layer; 8 cm thick spindle layer 589 atop of 16 cm thick perlite layer. Corresponding ab-590 sorption coefficients and surface impedance moduli in 591 rigid backing condition are given in Figures 18 to 20. 592 For all cases, the increase of air gap thickness induces 593 a down-shift of the lowest (quarter of wavelength) res-594 onance frequency with variable effects on absorption 595 coefficient according to the plant-soil bi-layer geom-596 etry. In the first case  $(d_{pl} = 8 \text{ cm}, d_{so} = 8 \text{ cm}),$ 597 initial broadband absorption band tends to split into 598

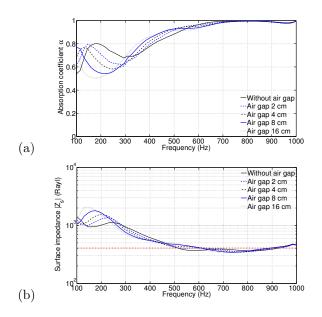


Figure 19: 8 cm thick spindle layer atop 16 cm thick perlite layer with air backing cavity of variable thickness: (a) absorption coefficient; (b) surface impedance modulus. Red dotted line: air characteristic impedance.

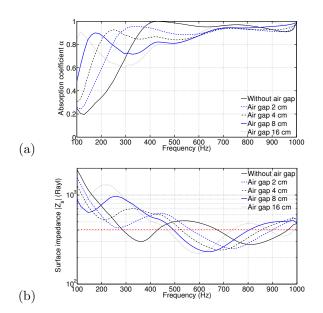


Figure 18: 8 cm thick spindle layer atop 8 cm thick perlite layer with air backing cavity of variable thickness: (a) absorption coefficient; (b) surface impedance modulus. Red dotted line: air characteristic impedance.

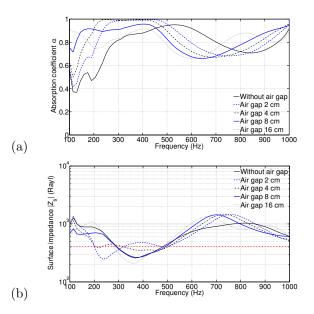


Figure 20: 16 cm thick spindle layer atop 8 cm thick perlite layer with air backing cavity of variable thickness: (a) absorption coefficient; (b) surface impedance modulus. Red dotted line: air characteristic impedance.

two separate absorption peaks with increasing air gap 599 thickness (Fig. 18a). Absorption is degraded between 600 these two peaks due to the increase of the surface 601 impedance modulus (Fig. 18b). In the second case 602  $(d_{pl} = 8 \text{ cm}, d_{so} = 16 \text{ cm})$ , only the low frequency ab-603 sorption peak slightly shifts down in frequency with 604 increasing air gap thickness (Fig. 19a). Above 300 Hz, 605 the absorption coefficient and the impedance surface 606 modulus (Fig. 19b) are not affected by the air gap. 607 The last case  $(d_{pl} = 16 \text{ cm}, d_{so} = 8 \text{ cm})$  is character-608 ized by a low frequency broad absorption peak which 609 shifts down in frequency with increasing air gap thick-610 ness (Fig. 19a). Maximal absorption is obtained be-611 tween 300 and 470 Hz for a 2 cm thick air gap and 612 between 230 and 430 Hz for a 4 cm thick air gap. 613

The variation of absorption coefficient frequency 614 spectrum with air gap thickness is displayed in Figure 615 21 for the three considered plant-soil configurations. 616 The second configuration  $(d_{pl} = 8 \text{ cm}, d_{so} = 16 \text{ cm})$ 617 is characterized by a high absorption coefficient above 618 400 Hz for any air gap thickness. The third config-619 uration ( $d_{pl} = 16$  cm,  $d_{so} = 8$  cm) displays a broad 620 absorption peak below 450 Hz for 2 cm  $\leq d_{pl} \leq 8$  cm. 621 Thus, a high absorption coefficient may be obtained 622 in a broader frequency range between 200 and 1000 623 Hz by combining these two configurations in a single 624 modular living wall system. 625

#### 5.6 Summary and conclusion

Measurement of the effective acoustic properties of 627 plants and soils have been combined with transfer 628 matrix method to simulate the acoustic absorption 629 coefficient by different types of green walls. Results 630 show that an adequate choice of constituents and ge-631 ometry may result in an efficient absorption of sound 632 in a broad frequency range due to two main mecha-633 nisms: **the** thickness resonances of the wall structure; 634 the quarter wave transformer effect provided by the 635 plant layer between air and soil layer. Among differ-636 ent green wall types, modular living wall systems dis-637 play higher sound absorption performance than con-638 tinuous living wall systems or green facades with an 639 absorption coefficient larger than 0.9 in a frequency 640 bandwidth that may reach 600 Hz. The proposed 641 approach could also be used to simulate the effect of 642 environmental (moisture content) or seasonal (decidu-643 ous, semi-deciduous or semi-evergreen plants) changes 644 on sound absorption. 645

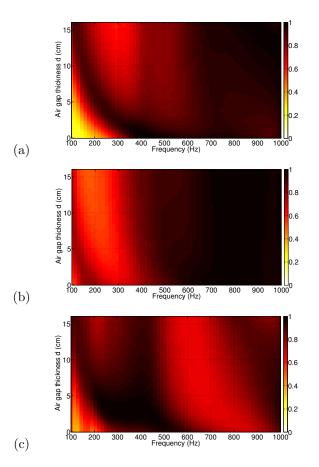


Figure 21: Type II modular living wall system: variation of absorption coefficient at normal incidence versus air gap thickness: (a) 8 cm thick spindle layer atop of 8 cm thick perlite layer; (b) 8 cm thick spindle layer atop of 16 cm thick perlite layer; (c) 16 cm thick spindle layer atop of 8 cm thick perlite layer.
