# Lewy-Stampacchia's inequality for a pseudomonotone parabolic problem

**Abstract:** The main aim of this paper is to extend to the case of a pseudomonotone operator Lewy-Stampacchia's inequality proposed by F. Donati [7] in the framework of monotone operators. For that, an *ad hoc* type of perturbation of the operator is proposed.

**Keywords:** Variational inequalities, penalization, pseudomonotone operator, Lewy-Stampacchia's inequality

## 1 Introduction

The aim of this paper is to prove the existence of a solution to the parabolic variational inequality

$$\int_{0}^{T} \langle \partial_{t} u, v - u \rangle dt + \int_{0}^{T} a(t, x, u, \nabla u) \cdot \nabla (v - u) dx dt \ge \int_{0}^{T} \langle f, v - u \rangle dt$$

and, especially, to give the associated inequality of Lewy-Stampacchia

$$0 \le \partial_t u - \operatorname{div}[a(\cdot, \cdot, u, \nabla u)] - f \le g^- = (f - \partial_t \psi + \operatorname{div}[a(\cdot, \cdot, \psi, \nabla \psi)])^-,$$

where  $u \mapsto -\text{div}[a(t, x, u, \nabla u)]$  is a pseudomonotone operator under the constraint  $u \ge \psi$ .

After the first results of H. Lewy and G. Stampacchia [14] concerning inequalities in the context of superharmonic problems, many authors have been interested in the so-called Lewy-Stampacchia's inequality associated with obstacle problems. Without exhaustiveness, let us cite the monograph of J.F. Rodrigues [21] and the papers of A. Mokrane and F. Murat [18] for pseudomonotone elliptic problems, A. Mokrane and G. Vallet [19] in the context of Sobolev spaces with variable exponents, A. Pinamonti and E. Valdinoci [20] in the framework of Heisenberg group, R. Servadei and E. Valdinoci [24] for nonlocal operators or N. Gigli and S. Mosconi [11] concerning an abstract presentation.

The literature on Lewy-Stampacchia's inequality is mainly aimed at elliptic problems, or close to elliptic problems and fewer papers are concerned with other type of problems. Let us cite J. F. Rodrigues [22] for hyperbolic problems, F. Donati [7] for parabolic problems with a monotone operator or L. Mastroeni and M. Matzeu [17] in the case of a double obstacle.

There is a large literature on parabolic problems with constraints. To cite some recent ones, consider [6, 13] where the main operator is monotone, associated with a nonlinear, possible graph, reaction term.

Concerning Lewy-Stampacchia's inequality, to the best of the author's knowledge, F. Donati's work [7] has not been extended to pseudomonotone parabolic problems with a Leray Lions operator. In this paper, we propose such a result, with very general assumptions on the Carathéodory function a, by using a method of penalization of the constraint associated with a suitable perturbation of the operator. As proposed e.g. by [12, p.102] and [4] for sub/super solutions to obstacle quasilinear elliptic problems, this perturbation is one of the main new point of the proof. Indeed, without it, one is usually only concerned by Lewy-Stampacchia's inequality in the elliptic case, and one needs to assume, as in [18], some additional, now useless, Hölder-continuity assumptions for a with respect to a and a are not in spaces in duality relation.

The paper is organized in the following way: after giving the hypotheses and the main result (Theorem 2.2) in Section 2, Section 3 is devoted to the proof of this result. A first step is devoted to the existence of a solution to the penalized/perturbed problem associated with a parameter  $\varepsilon$ ; then, some *a priori* estimates and passage to the limit with respect to  $\varepsilon$  are considered when  $g^-$  is a regular non-negative element. A first proof of Lewy-Stampacchia's inequality is given when  $g^-$  is still regular; finally, the proof of Lewy-Stampacchia's inequality is extended to the general case. A last part, Section 4, presents an annex containing technical results used in the proofs, in particular the time-integration by part and the time-continuity mentioned above.

# 2 Notation, hypotheses and main result

Let us denote by  $\Omega \subset \mathbb{R}^d$  a Lipschitz bounded domain, for any T > 0, by  $Q = (0, T) \times \Omega$  and by  $p \in (1, +\infty)$ . As usual, p' denotes the conjugate exponent of p,  $V = W_0^{1,p}(\Omega)$  if  $p \ge 2$  and  $V = W_0^{1,p}(\Omega) \cap L^2(\Omega)$  with the graph-norm else. Then, the corresponding dual spaces are  $V' = W^{-1,p'}(\Omega)$  if  $p \ge 2$  and  $V' = W^{-1,p'}(\Omega) + L^2(\Omega)$  else (cf. e.g. [10, p.24]).

In this situation, the Lions-Gelfand triple [23, §. 7.2]

$$V \hookrightarrow_{dense} L^2(\Omega) \hookrightarrow_{dense} V'$$

holds and one denotes, as usually, by

$$W(0, T) = \{u \in L^p(0, T; V), \ \partial_t u \in L^{p'}(0, T; V')\}.$$

Assume in the sequel the following:

 $H_1$ : A is a Leray-Lions pseudomonotone operator of the form

$$v \mapsto A(v) = -\operatorname{div}\left[a(t, x, v, \nabla v)\right],$$

which acts from  $W^{1,p}(\Omega)$  into  $W^{-1,p'}(\Omega)$  where

 $H_{1,1}$   $a:(t,x,u,\vec{\xi})\in Q\times\mathbb{R}\times\mathbb{R}^d\mapsto a(t,x,u,\vec{\xi})\in\mathbb{R}^d$  is a Carathéodory function on  $Q\times\mathbb{R}^{d+1}$ ,  $H_{1,2}$  a is strictly monotone with respect to its last argument:

$$\forall (t, x) \in Q \text{ a.e., } \forall u \in \mathbb{R}, \ \forall \vec{\xi}, \vec{\eta} \in \mathbb{R}^d,$$
$$\vec{\xi} \neq \vec{\eta} \Rightarrow [a(t, x, u, \vec{\xi}) - a(t, x, u, \vec{\eta})] \cdot (\vec{\xi} - \vec{\eta}) > 0.$$

 $H_{1,3}$  a is coercive and bounded: there exist constants  $\bar{\alpha} > 0$ ,  $\bar{\beta} > 0$  and  $\bar{y} \ge 0$ , a function  $\bar{h}$  in  $L^1(Q)$  and a function  $\bar{k}$  in  $L^p(Q)$  and two exponents q, r < p such that, for a.e.  $(t, x) \in Q$ , for all

 $u \in \mathbb{R}$  and for all  $\vec{\xi} \in \mathbb{R}^d$ ,

$$a(t,x,u,\vec{\xi})\cdot\vec{\xi} \geq \bar{\alpha}|\vec{\xi}|^p - \left[\bar{y}|u|^q + |\bar{h}(t,x)|\right], \tag{1}$$

$$|a(t, x, u, \vec{\xi})| \le \bar{\beta} \left[ |\bar{k}(t, x)| + |u|^{r/p} + |\vec{\xi}| \right]^{p-1}.$$
 (2)

: assume that the obstacle  $\psi$  belongs to  $L^p(0,T;W^{1,p}(\Omega))\cap L^p(0,T;L^2(\Omega))$ ; that  $\partial_t\psi$  belongs to  $L^{p'}(0,T;V')$  and  $\psi\leq 0$  on  $\partial\Omega$  (See Section 4.4 for some comments on the time regularity of such elements).

 $H_3$ : the right hand side f, which is assumed to be such that

$$g = f - \partial_t \psi - A(\psi) = g^+ - g^-$$

belongs to the order dual

$$L^{p}(0, T; V)^{*} = \{T = T_{1} - T_{2}, T_{i} \in (L^{p'}(0, T; V'))^{+}, i = 1, 2\}$$

where  $(L^{p'}(0, T; V'))^+$  denotes the non-negative elements of  $L^{p'}(0, T; V')$ .

 $H_4$ :  $u_0 \in L^2(\Omega)$  satisfies the constraint, i.e.  $u_0 \ge \psi(0)$ .

As usual concerning obstacle problems one denotes by

$$\mathcal{K}(\psi) := \{ u \in W(0, T), u \ge \psi \}.$$

**Remark 2.1.**  $\mathcal{K}(\psi)$  is a not empty convex set.

*Proof.* Indeed, if one denotes by  $v^*$ , the solution in W(0, T) to

$$\partial_t v^* - \Delta_p v^* = \partial_t \psi - \Delta_p \psi \in L^{p'}(0, T; V'), \qquad v^*(t=0) = \psi(0).$$

 $-(v^* - \psi)^- \in L^p(0, T; V)$  is an admissible test-function and one has that

$$0 = -\langle \partial_t (v^* - \psi), (v^* - \psi)^- \rangle + \int_{\Omega} 1_{\{v^* - \psi < 0\}} [|\nabla v^*|^{p-2} \nabla v^* - |\nabla \psi|^{p-2} \nabla \psi] \cdot \nabla (v^* - \psi) dx.$$

Then, Corollary 4.5 with  $\beta = 1$  and  $\alpha = 1$  yields for any  $t \in (0, T)$ 

$$0 \ge -\int_{0}^{t} \langle \partial_{t} (v^{*} - \psi), (v^{*} - \psi)^{-} \rangle ds = -\int_{\Omega} \int_{0}^{(v^{*} - \psi)(t)} s^{-} ds dx + \int_{\Omega} \int_{0}^{(v^{*} - \psi)(0)} s^{-} ds dx$$
$$= \frac{1}{2} \| (v^{*} - \psi)^{-} (t) \|_{L^{2}}^{2}$$

since  $(v^* - \psi)^-(0) = 0$ . As a consequence,  $v^* \ge \psi$  and  $v^* \in \mathcal{K}(\psi)$ .

Our aim is to prove the following result.

**Theorem 2.2.** Under the above assumptions  $(H_1)$ - $(H_4)$ , there exists at least u in  $\mathcal{K}(\psi)$  with  $u(t=0)=u_0$  and such that, for any  $v \in L^p(0,T;V)$ ,  $v \ge \psi$  implies that

$$\int_{0}^{T} \langle \partial_{t} u, v - u \rangle dt + \int_{0}^{T} a(t, x, u, \nabla u) \cdot \nabla (v - u) dx dt \ge \int_{0}^{T} \langle f, v - u \rangle dt.$$

Moreover, the following Lewy-Stampacchia's inequality holds

$$0 \le \partial_t u - \operatorname{div}[a(\cdot, \cdot, u, \nabla u)] - f \le g^- = (f - \partial_t \psi + \operatorname{div}[a(\cdot, \cdot, \psi, \nabla \psi)])^-.$$

# 3 Proof of Theorem 2.2

Theorem 2.2 will be proved in four steps.

In a first part, we establish the existence of a solution to a problem where the constraint  $u \ge \psi$  is penalized. Moreover, the crucial point in the method developed in the present paper is to replace  $a(\cdot, \cdot, u, \vec{\xi})$  by  $a(\cdot, \cdot, \max(u, \psi), \vec{\xi})$ . The aim of this additional perturbation is to ensure, formally, a monotone behavior of the operator when u violates the constraint. This is the aim of Theorem 3.2.

For technical reasons, some *a priori* estimates and the passage to the limit will be obtained firstly by assuming that  $g^-$  is regular. This is the object of Lemmas 3.3, 3.4, 3.5 and Theorem 3.7. Then a proof of Lewy-Stampacchia's inequality, still with a regular  $g^-$ , will be presented in Lemma 3.9.

Finally, one will be able to prove Lewy-Stampacchia's inequality in the general case.

#### 3.1 Penalization

Denote by  $\tilde{q} = \min(p, 2)$  and let us define the function  $\Theta$ 

$$\Theta: \mathbb{R} \to \mathbb{R}, \quad x \mapsto -[x^-]^{\tilde{q}-1},$$

and the perturbed operator

$$\tilde{a}(t, x, u, \xi) : Q \times \mathbb{R} \times \mathbb{R}^d \to \mathbb{R}^d$$

$$(x, t, u, \vec{\xi}) \mapsto \tilde{a}(t, x, u, \vec{\xi}) = a(t, x, \max(u, \psi(t, x)), \vec{\xi}).$$
(3)

**Remark 3.1.** We wish to draw the reader's attention to the fact that with the proposed perturbation:  $\tilde{a}(t, x, u, \vec{\xi}) = a(t, x, \max(u, \psi), \vec{\xi})$ , the idea is to make formally the operator monotone and not pseudomonotone any more on the free-set where the constraint is violated.

We define  $A: L^p(0,T;V) \to L^{p'}(0,T;V')$  such that  $[A(u)](t) := \tilde{A}(u(t)) = -\text{div}[\tilde{a}(t,x,u,\nabla u)]$ . Note that, the above assumption  $H_1$  still holds. Indeed,

$$\tilde{a}(t,x,u,\vec{\xi})\cdot\vec{\xi}\geq\bar{\alpha}|\vec{\xi}|^p-\left[\bar{y}|\max(u,\psi)|^q+|\bar{h}(t,x)|\right],\tag{4}$$

$$|\tilde{a}(t,x,u,\vec{\xi})| \le \bar{\beta} \Big[ |\bar{k}(t,x)| + |\max(u,\psi)|^{r/p} + |\vec{\xi}| \Big]^{p-1}.$$
 (5)

Since  $|\max(u,\psi)|^q \le |u|^q + |\psi|^q$ ,  $|\max(u,\psi)|^{r/p} \le |u|^{r/p} + |\psi|^{r/p}$ , (1) and (2) are satisfied by replacing  $\bar{h}$  by  $\bar{h} + \bar{y}|\psi|^q$  and  $\bar{k}$  by  $\bar{k} + |\psi|^{r/p}$ .

For any positive  $\varepsilon$ , a cosmetic modification of [23, Section 8.4] (see also [15, Chap. 3]) yields the following result.

**Theorem 3.2.** There exists  $u \in W(0, T)$  such that  $u(t = 0) = u_0$  and

$$\partial_{t} u - \operatorname{div} \left[ \tilde{a}(t, x, u, \nabla u) \right] + \frac{1}{\varepsilon} \Theta(u - \psi) = f,$$
i.e. 
$$\partial_{t} u - \operatorname{div} \left[ a(t, x, \max[u, \psi], \nabla u) \right] + \frac{1}{\varepsilon} \Theta(u - \psi) = f.$$
(6)

# 3.2 The regular case: $oldsymbol{g}^{\scriptscriptstyle -} \in L^{ ilde{q}'}(Q) \hookrightarrow L^{p'}(Q)$

Following Assumption H<sub>3</sub> let us recall that  $f - \partial_t \psi - A\psi = g = g^+ - g^-$  belongs to the order dual  $L^p(0, T; V)^*$ . In this subsection we impose an additional regularity on  $g^-$ , namely  $0 \le g^- \in L^{\tilde{q}'}(Q) \hookrightarrow L^{p'}(Q)$ .

#### 3.2.1 *A priori* estimates with respect to $\varepsilon$

Let us test the penalized problem (6) with  $u_{\varepsilon} - v^{\star}$ ,

$$\frac{1}{2}\frac{d}{dt}\|u_{\varepsilon}-v^{\star}\|_{L^{2}(\Omega)}^{2}+\int_{\Omega}\tilde{a}(t,x,u_{\varepsilon},\nabla u_{\varepsilon})\cdot\nabla u_{\varepsilon}dx+\frac{1}{\varepsilon}\int_{\Omega}\Theta(u_{\varepsilon}-\psi)(u_{\varepsilon}-v^{\star})dx$$

$$=\langle f-\partial_{t}v^{\star},u_{\varepsilon}-v^{\star}\rangle+\int_{\Omega}\tilde{a}(t,x,u_{\varepsilon},\nabla u_{\varepsilon})\cdot\nabla v^{\star}dx.$$

Thus, by using (1), for any positive  $\delta_1$ , there exists  $C_{\delta_1}$  depending on  $\delta_1$  and  $\Omega$  such that

$$\begin{split} \int\limits_{\Omega} \tilde{a}(t,x,u_{\varepsilon},\nabla u_{\varepsilon}) \cdot \nabla u_{\varepsilon} dx &\geq \int\limits_{\Omega} \bar{\alpha} |\nabla u_{\varepsilon}|^{p} - \bar{y} |\max(u_{\varepsilon},\psi)|^{q} - |\bar{h}| dx \\ &\geq \bar{\alpha} \|u_{\varepsilon}\|_{W_{0}^{1,p}(\Omega)}^{p} - \bar{y} \|u_{\varepsilon}\|_{L^{q}(\Omega)}^{q} - \bar{y} \|\psi\|_{L^{q}(\Omega)}^{q} - \|\bar{h}\|_{L^{1}(\Omega)} \\ &\geq \bar{\alpha} \|u_{\varepsilon}\|_{W_{0}^{1,p}(\Omega)}^{p} - \delta_{1} \|u_{\varepsilon}\|_{L^{p}(\Omega)}^{p} - \bar{y} \|\psi\|_{L^{q}(\Omega)}^{q} - \|\bar{h}\|_{L^{1}(\Omega)} - C_{\delta_{1}}. \end{split}$$

For the third term,  $\Theta \leq 0$  and  $v^* \geq \psi$  yield

$$\frac{1}{\varepsilon}\int\limits_{\Omega}\Theta(u_{\varepsilon}-\psi)(u_{\varepsilon}-v^{*})dx\geq\frac{1}{\varepsilon}\int\limits_{\Omega}\Theta(u_{\varepsilon}-\psi)(u_{\varepsilon}-\psi)dx.$$

By using (2), for any positive  $\delta_2$ , there exists  $C_{\delta_2}$  depending on  $\delta_2$  and  $\Omega$  such that

$$\int_{\Omega} \tilde{a}(t, x, u_{\varepsilon}, \nabla u_{\varepsilon}) \cdot \nabla v^{*} dx \leq \int_{\Omega} \bar{\beta} \left[ |\bar{k}| + |\max(u_{\varepsilon}, \psi)|^{r/p} + |\nabla u_{\varepsilon}| \right]^{p-1} |\nabla v^{*}| dx 
\leq C_{\delta_{2}} ||v^{*}||_{W_{0}^{1,p}(\Omega)}^{p} + \delta_{2} \left[ ||\bar{k}||_{L^{p}(\Omega)}^{p} + ||\psi||_{L^{r}(\Omega)}^{r} + ||u_{\varepsilon}||_{L^{r}(\Omega)}^{r} + ||u_{\varepsilon}||_{W_{0}^{1,p}(\Omega)}^{p} \right] 
\leq \delta_{2} ||u_{\varepsilon}||_{W_{0}^{1,p}(\Omega)}^{p} + \delta_{2} \frac{r}{p} ||u_{\varepsilon}||_{L^{p}(\Omega)}^{p} + C_{\delta_{2}} ||v^{*}||_{W_{0}^{1,p}(\Omega)}^{p} + \delta_{2} ||\bar{k}||_{L^{p}(\Omega)}^{p} + C_{\delta_{2}}.$$

Finally, for any positive  $\delta_3$ , there exists  $C_{\delta_3}$  depending on  $\delta_3$  and  $\Omega$  such that

$$\langle f - \partial_t v^{\star}, u_{\varepsilon} - v^{\star} \rangle \leq \delta_3[\|u_{\varepsilon}\|_V^p + \|v^{\star}\|_V^p] + C_{\delta_3}\|f - \partial_t v^{\star}\|_{V'}^{p'}.$$

In conclusion we have

$$\begin{split} \frac{1}{2} \frac{d}{dt} \| u_{\varepsilon} - v^{\star} \|_{L^{2}(\Omega)}^{2} + \bar{\alpha} \| u_{\varepsilon} \|_{W_{0}^{1,p}(\Omega)}^{p} + \frac{1}{\varepsilon} \int_{\Omega} \Theta(u_{\varepsilon} - \psi)(u_{\varepsilon} - \psi) dx \\ & \leq \delta_{1} \| u_{\varepsilon} \|_{L^{p}(\Omega)}^{p} + \delta_{2} \| u_{\varepsilon} \|_{W_{0}^{1,p}(\Omega)}^{p} + \delta_{2} \frac{r}{p} \| u_{\varepsilon} \|_{L^{p}(\Omega)}^{p} + \delta_{3} \| u_{\varepsilon} \|_{V}^{p} \\ & + \bar{y} \| \psi \|_{L^{q}(\Omega)}^{q} + C_{\delta_{2}} \| v^{\star} \|_{W_{0}^{1,p}(\Omega)}^{p} + \delta_{3} \| v^{\star} \|_{V}^{p} \\ & + C_{\delta_{3}} \| f - \partial_{t} v^{\star} \|_{V'}^{p'} + \| \bar{h} \|_{L^{1}(\Omega)} + \delta_{2} \| \bar{k} \|_{L^{p}(\Omega)}^{p} + C_{\delta_{1}} + C_{\delta_{2}} \| \psi \|_{L^{r}(\Omega)}^{r}. \end{split}$$

Then, using Young's inequality and a convenient choice of the parameters  $\delta_1$ ,  $\delta_2$ ,  $\delta_3$  yield that for any positive  $\delta$  there exists C depending on the listed parameters such that

$$\sup_{t} \|u_{\varepsilon}\|_{L^{2}(\Omega)}^{2}(t) + \|u_{\varepsilon}\|_{L^{p}(0,T;W_{0}^{1,p}(\Omega))}^{p} + \frac{1}{\varepsilon} \|\Theta(u_{\varepsilon} - \psi)(u_{\varepsilon} - \psi)^{-}\|_{L^{1}(\Omega)} \\
\leq C(\delta, \|v^{\star}\|_{W(0,T)}, \|\psi\|_{L^{p}(0,T;V)}, \|\bar{k}\|_{L^{p}(\Omega)}, \|\bar{h}\|_{L^{1}(\Omega)}, \|f\|_{L^{p'}(0,T;V')}) + \delta \|u_{\varepsilon}\|_{L^{p}(0,T;V)}^{p}. \tag{7}$$

**Lemma 3.3.** There exists a constant  $C_1$  depending on  $\|v^*\|_{W(0,T)}$ ,  $\|\psi\|_{L^p(0,T;V)}$ ,  $\|\bar{k}\|_{L^p(\Omega)}$ ,  $\|\bar{h}\|_{L^1(Q)}$  and  $\|f\|_{L^{p'}(0,T;V')}$  such that, for any  $\varepsilon > 0$ ,

$$\sup_{t} \|u_{\varepsilon}\|_{L^{2}(\Omega)}^{2}(t) + \|u_{\varepsilon}\|_{L^{p}(0,T;V)}^{p} + \frac{1}{\varepsilon} \|(u_{\varepsilon} - \psi)^{-}\|_{L^{\tilde{q}}(Q)}^{\tilde{q}} \le C_{1}.$$
 (8)

*Proof.* If  $p \ge 2$ ,  $W_0^{1,p}(\Omega) = V$  so that Lemma 3.3 is a straightforward consequence of (7). If p < 2, it is enough to remark that

$$\sup_{t} \|u_{\varepsilon}\|_{L^{2}(\Omega)}^{2}(t) + \|u_{\varepsilon}\|_{L^{p}(0,T;V)}^{p} = \sup_{t} \|u_{\varepsilon}\|_{L^{2}(\Omega)}^{2}(t) + \int_{0}^{T} [\|u_{\varepsilon}(t)\|_{L^{2}(\Omega)} + \|u_{\varepsilon}(t)\|_{W_{0}^{1,p}(\Omega)}]^{p} dt$$

$$\leq \sup_{t} \|u_{\varepsilon}\|_{L^{2}(\Omega)}^{2}(t) + 2^{p-1} \int_{0}^{T} [\|u_{\varepsilon}(t)\|_{L^{2}(\Omega)}^{p} + \|u_{\varepsilon}(t)\|_{W_{0}^{1,p}(\Omega)}^{p}] dt$$

$$\leq \sup_{t} \|u_{\varepsilon}\|_{L^{2}(\Omega)}^{2}(t) + 2^{p-1} \int_{0}^{T} [\frac{p}{2} \|u_{\varepsilon}(t)\|_{L^{2}(\Omega)}^{2} + \frac{2-p}{2} + \|u_{\varepsilon}(t)\|_{W_{0}^{1,p}(\Omega)}^{p}] dt$$

$$\leq (1 + 2^{p-2}pT) \sup_{t} \|u_{\varepsilon}\|_{L^{2}(\Omega)}^{2}(t) + 2^{p-1} \int_{0}^{T} \|u_{\varepsilon}(t)\|_{W_{0}^{1,p}(\Omega)}^{p} dt + 2^{p-2}T(2-p).$$

It is worth noting that Lemma 3.3 gives that  $\frac{1}{\varepsilon} \int_{\Omega} ((u_{\varepsilon} - \psi)^{-})^{\bar{q}} dx dt$  is bounded (with respect to  $\varepsilon$ ) so that we cannot expect to have a bound of the penalized term  $\frac{1}{\varepsilon}\Theta(u_{\varepsilon}-\psi)$  in  $L^{p'}(Q)$  nor in  $L^{p'}(0,T;V')$ .

Using the additional regularity  $g^- \in L^{\bar{q}'}(Q)$  we prove in the following lemma more precise estimates on  $(u_{\varepsilon}-\psi)^{-}$ .

**Lemma 3.4.** There exists a constant  $C_2$  depending on  $C_1$  of Lemma 3.3, such that for any  $\varepsilon > 0$ ,

$$\sup_{t \in (0,T)} \|(u_{\varepsilon} - \psi)^{-}(t)\|_{L^{2}(\Omega)}^{2} \le C_{2} \|g^{-}\|_{L^{\tilde{q}'}(Q)} \varepsilon^{1/\tilde{q}}, \tag{9}$$

$$\int_{\Omega} \left| \tilde{a}(t, x, u_{\varepsilon}, \nabla u_{\varepsilon}) - \tilde{a}(t, x, \psi, \nabla \psi) \cdot \nabla (u_{\varepsilon} - \psi)^{-} \right| dx ds \le C_{2} \|g^{-}\|_{L^{\tilde{q}'}(Q)} \varepsilon^{1/\tilde{q}}, \tag{10}$$

$$\frac{1}{\varepsilon} \| (u_{\varepsilon} - \psi)^{-} \|_{L^{\tilde{q}}(Q)}^{\tilde{q}-1} \le C_{2} \| g^{-} \|_{L^{\tilde{q}'}(Q)}. \tag{11}$$

*Proof.* With the admissible test-function  $(u_{\varepsilon} - \psi)^{-}$ , one gets that

$$\begin{split} &-\langle \frac{d}{dt}(u_{\varepsilon}-\psi),(u_{\varepsilon}-\psi)^{-}\rangle -\frac{1}{\varepsilon}\int_{\Omega}\Theta(u_{\varepsilon}-\psi)(u_{\varepsilon}-\psi)^{-}dx\\ &-\int_{\Omega\cap\{u_{\varepsilon}-\psi<0\}}\left[\tilde{a}(t,x,u_{\varepsilon},\nabla u_{\varepsilon})-\tilde{a}(t,x,\psi,\nabla\psi)\right]\cdot\nabla(u_{\varepsilon}-\psi)^{-}dx\\ &=-\langle f-\partial_{t}\psi+\operatorname{div}\left[\tilde{a}(t,x,\psi,\nabla\psi)\right],(u_{\varepsilon}-\psi)^{-}\rangle dt. \end{split}$$

Then, since  $(u_{\varepsilon} - \psi)^- \in L^p(0, T; V)$  with  $(u_{\varepsilon} - \psi)^-(0) = 0$ , Corollary 4.5 yields: for any  $t \in (0, T)$ ,

$$\frac{1}{2} \| (u_{\varepsilon} - \psi)^{-}(t) \|_{L^{2}(\Omega)}^{2} - \frac{1}{\varepsilon} \int_{0}^{t} \int_{\Omega} \Theta(u_{\varepsilon} - \psi)(u_{\varepsilon} - \psi)^{-} dx ds 
+ \int_{0}^{t} \int_{\{u_{\varepsilon} - \psi < 0\}} \left[ \tilde{a}(t, x, u_{\varepsilon}, \nabla u_{\varepsilon}) - \tilde{a}(t, x, \psi, \nabla \psi) \right] \cdot \nabla (u_{\varepsilon} - \psi) dx ds 
= - \int_{0}^{t} \langle f - \partial_{t} \psi + \operatorname{div} \left[ \tilde{a}(t, x, \psi, \nabla \psi) \right], (u_{\varepsilon} - \psi)^{-} \rangle dt.$$

In view of the definition of  $\tilde{a}$  we have  $\tilde{a}(t, x, u_{\varepsilon}, \nabla u_{\varepsilon}) = a(t, x, \psi, \nabla u_{\varepsilon})$  in the set  $\{u_{\varepsilon} < \psi\}$ . Therefore using assumption  $H_{1,2}$  we obtain

$$\frac{1}{2}\|(u_{\varepsilon}-\psi)^{-}(t)\|_{L^{2}(\Omega)}^{2} + \int_{0}^{t} \int_{\Omega} \left| \left[ \tilde{a}(t,x,u_{\varepsilon},\nabla u_{\varepsilon}) - \tilde{a}(t,x,\psi,\nabla\psi) \right] \cdot \nabla(u_{\varepsilon}-\psi)^{-} \right| dxds \\
+ \frac{1}{\varepsilon} \int_{0}^{t} \|\Theta(u_{\varepsilon}-\psi)(u_{\varepsilon}-\psi)^{-}\|_{L^{1}(\Omega)} ds \\
\leq -\int_{0}^{t} \langle g,(u_{\varepsilon}-\psi)^{-} \rangle = -\int_{0}^{t} \langle g^{+},(u_{\varepsilon}-\psi)^{-} \rangle + \int_{0}^{T} \int_{\Omega} g^{-}(u_{\varepsilon}-\psi)^{-} dxdt.$$

We recall that Lemma 3.3 yielded  $\|(u_{\varepsilon} - \psi)^-\|_{L^{\tilde{q}}(\Omega)}^{\tilde{q}} \le C_1 \varepsilon$  so that

$$\frac{1}{2}\|(u_{\varepsilon}-\psi)^{-}(t)\|_{L^{2}(\Omega)}^{2} + \int_{0}^{t} \int_{\Omega} \left| \left[ \tilde{a}(t,x,u_{\varepsilon},\nabla u_{\varepsilon}) - \tilde{a}(t,x,\psi,\nabla\psi) \right] \cdot \nabla(u_{\varepsilon}-\psi)^{-} \right| dxds \\
+ \frac{1}{\varepsilon} \int_{0}^{t} \|(u_{\varepsilon}-\psi)^{-}\|_{L^{\tilde{q}}(\Omega)}^{\tilde{q}} ds \\
\leq - \int_{0}^{t} \langle g,(u_{\varepsilon}-\psi)^{-} \rangle = - \int_{0}^{t} \langle g^{+},(u_{\varepsilon}-\psi)^{-} \rangle + \int_{0}^{T} \int_{\Omega} g^{-}(u_{\varepsilon}-\psi)^{-} dxdt \\
\leq \|g^{-}\|_{L^{\tilde{q}'}(\Omega)} \|(u_{\varepsilon}-\psi)^{-}\|_{L^{\tilde{q}}(\Omega)} \leq \sqrt[\tilde{q}]{C_{1}\varepsilon} \|g^{-}\|_{L^{\tilde{q}'}(\Omega)}$$

and Lemma 3.4 holds.

Gathering Lemmas 3.3 and 3.4 we prove the following estimates

**Lemma 3.5.** There exists a constant  $C_3$  depending on  $C_1$ ,  $C_2$  and  $\|g^-\|_{L^{p'}(\Omega)}$  such that for any  $\varepsilon > 0$ 

$$\|\partial_t u_\varepsilon\|_{L^{p'}(0,T;V')} + \|\tilde{a}(t,x,u_\varepsilon,\nabla u_\varepsilon)\|_{L^{p'}(Q)} + \|\tilde{A}(u_\varepsilon)\|_{L^{p'}(0,T;V')} \leq C_3.$$

*Proof.* The growth condition (5) on  $\tilde{a}$  and Lemma 3.3 imply that

$$\begin{split} |\tilde{a}(t,x,u_{\varepsilon},\nabla u_{\varepsilon})|^{p'} &= |a(t,x,\max(u_{\varepsilon},\psi),\nabla u_{\varepsilon})|^{p'} \\ &\leq \bar{\beta}^{p'} \Big[ |\bar{k}| + |u_{\varepsilon}|^{r/p} + |\psi|^{r/p} + |\nabla u_{\varepsilon}| \Big]^{p} \\ &\leq C \Big[ |\bar{k}|^{p} + |u_{\varepsilon}|^{p} + |\psi|^{p} + |\nabla u_{\varepsilon}|^{p} + 1 \Big] \end{split}$$

and then  $\tilde{a}(t, x, u_{\varepsilon}, \nabla u_{\varepsilon})$  is bounded in  $L^{p'}(Q)^d$ . The boundedness of  $\|\tilde{A}(u_{\varepsilon})\|_{L^{p'}(0,T;V')}$  is a direct consequence of the above inequality.

Recalling that  $\partial_t u_{\varepsilon} = f - \tilde{A}(u_{\varepsilon}) - \frac{1}{\varepsilon} \Theta(u_{\varepsilon} - \psi)$  it remains to estimate  $\frac{1}{\varepsilon} \Theta(u_{\varepsilon} - \psi)$  in  $L^{p'}(0, T; V')$ . We distinguish the two cases  $p \ge 2$  and 1 .

If  $p \ge 2$  then  $\tilde{q} = 2$ . From Lemma 3.4 we have  $\frac{1}{\varepsilon} \| (u_{\varepsilon} - \psi)^{-} \|_{L^{2}(Q)} \le C$  and since

$$\|\frac{1}{\varepsilon}\Theta(u_{\varepsilon}-\psi)\|_{L^{p'}(0,T;V')}=\sup_{\|v\|_{L^{p}(0,T;V)}\leq 1}\langle\frac{1}{\varepsilon}\Theta(u-\psi),v\rangle\leq \frac{1}{\varepsilon}\|(u_{\varepsilon}-\psi)^{-}\|_{L^{2}(Q)}\|v\|_{L^{2}(Q)}\leq C$$

it follows that  $\frac{1}{\varepsilon}\Theta(u_{\varepsilon}-\psi)$  is bounded in  $L^{p'}(0,T;V')$ .

If  $1 then <math>\tilde{q} = p$ . From Lemma 3.4 we have  $\frac{1}{\varepsilon} \| (u_{\varepsilon} - \psi)^- \|_{L^p(Q)}^{p-1} \le C$  and we have

$$\|\frac{1}{\varepsilon}\Theta(u_{\varepsilon}-\psi)\|_{L^{p'}(0,T;V')}=\sup_{\|\nu\|_{L^{p}(0,T;V)}\leq 1}\langle\frac{1}{\varepsilon}\Theta(u_{\varepsilon}-\psi),\nu\rangle\leq \frac{1}{\varepsilon}\|(u_{\varepsilon}-\psi)^{-}\|_{L^{p}(Q)}^{p-1}\leq C$$

which concludes the proof of Lemma 3.5.

#### 3.2.2 At the limit when $\varepsilon \to 0$ .

The sequence  $(u_{\varepsilon})$  is bounded in W(0, T), therefore, up to a subsequence denoted the same, there exists  $u \in W(0, T)$  such that  $u_{\varepsilon}$  converges weakly to u in W(0, T). In particular, one gets that  $u(t = 0) = u_0$ . Then, by classical compactness arguments of type Aubin-Lions-Simon [26], the convergence is strong in  $L^p(Q)$ , and a.e. in  $Q^{\dagger}$ .

Therefore,  $(u_{\varepsilon} - \psi)^- \to (u - \psi)^-$  in  $L^p(Q)$  and thanks to Lemma 3.4, one gets that  $(u - \psi)^- = 0$  *i.e.*  $u \in \mathcal{K}(\psi)$ .

Moreover from Lemma 3.5 there exists  $\vec{\xi} \in L^{p'}(Q)^d$  such that

$$\tilde{a}(\cdot,\cdot,u_{\varepsilon},\nabla u_{\varepsilon})$$
 converges weakly to  $\vec{\xi}$  in  $L^{p'}(Q)^d$ . (12)

By (2), the following estimate holds for any  $v \in L^p(0, T; V)$ ,

$$\left|\tilde{a}(t,x,u,\nabla v)\right|^{p'} \leq C \left[1+\left|\bar{k}\right|^p+\left|u\right|^p+\left|\psi\right|^p+\left|\nabla v\right|^p\right],$$

so that, since  $u \in \mathbb{R} \mapsto a(t, x, u, \nabla v)$  is a continuous function, the theory of Nemytskii operators gives that

$$\tilde{a}(t, x, u_{\varepsilon}, \nabla u) \to \tilde{a}(t, x, u, \nabla u) \text{ in } L^{p'}(Q)^d$$
 (13)

and

$$\int_{\Omega} \tilde{a}(t,x,u_{\varepsilon},\nabla u)\cdot\nabla(u_{\varepsilon}-u)dxdt\to 0. \tag{14}$$

Testing the penalized equation (6) introduced in Theorem 3.2 by  $u_{\varepsilon}$  – u yields

$$\int_{0}^{t} \langle \partial_{t} u_{\varepsilon}, u_{\varepsilon} - u \rangle ds + \int_{0}^{t} \int_{\Omega} \tilde{a}(t, x, u_{\varepsilon}, \nabla u_{\varepsilon}) \cdot \nabla(u_{\varepsilon} - u) dx ds = \int_{0}^{t} \langle f, u_{\varepsilon} - u \rangle ds - \frac{1}{\varepsilon} \int_{0}^{t} \int_{\Omega} \Theta(u_{\varepsilon} - \psi) (u_{\varepsilon} - u) dx ds.$$

Since  $\int_0^t \langle f, u_\varepsilon - u \rangle ds \to 0$ , the following decomposition

$$-\frac{1}{\varepsilon}\int_{0}^{t}\int_{\Omega}\Theta(u_{\varepsilon}-\psi)(u_{\varepsilon}-u)dxds = -\frac{1}{\varepsilon}\int_{0}^{t}\int_{\Omega}\Theta(u_{\varepsilon}-\psi)(u_{\varepsilon}-\psi)dxds - \frac{1}{\varepsilon}\int_{0}^{t}\int_{\Omega}\Theta(u_{\varepsilon}-\psi)(\psi-u)dxds$$

leads to

$$\limsup_{\varepsilon} \left[ \int_{0}^{t} \langle \partial_{t} u_{\varepsilon}, u_{\varepsilon} - u \rangle ds + \int_{0}^{t} \int_{0}^{\infty} \tilde{a}(t, x, u_{\varepsilon}, \nabla u_{\varepsilon}) \cdot \nabla (u_{\varepsilon} - u) dx ds \right] \leq 0.$$

Using (14) we obtain

$$\limsup_{\varepsilon} \left[ \int_{0}^{t} \langle \partial_{t}(u_{\varepsilon} - u), u_{\varepsilon} - u \rangle ds + \int_{0}^{t} \int_{\Omega} \left[ \tilde{a}(t, x, u_{\varepsilon}, \nabla u_{\varepsilon}) - \tilde{a}(t, x, u_{\varepsilon}, \nabla u) \right] \cdot \nabla (u_{\varepsilon} - u) dx ds \right] \leq 0.$$

The monotone character of the operator  $\tilde{a}(x,t,u,\vec{\xi})$  with respect to  $\vec{\xi}$  (see Assumption  $H_{1,2}$  and (3)) implies

$$\frac{1}{2} \limsup_{\varepsilon} \|(u_{\varepsilon} - u)(t)\|_{L^{2}(\Omega)}^{2} = \limsup_{\varepsilon} \int_{0}^{t} \langle \partial_{t}(u_{\varepsilon} - u), u_{\varepsilon} - u \rangle ds \leq 0$$

<sup>†</sup> Some arguments are given in Annex 4.2 when p < 2.

and

$$\lim_{\varepsilon} \int_{0}^{t} \int_{0}^{\infty} \left[ \tilde{a}(t, x, u_{\varepsilon}, \nabla u_{\varepsilon}) - \tilde{a}(t, x, u_{\varepsilon}, \nabla u) \right] \cdot \nabla(u_{\varepsilon} - u) dx ds = 0.$$
 (15)

It follows that

$$u_{\varepsilon}(t) \to u(t) \text{ in } L^{2}(\Omega) \text{ for any } t$$
 (16)

and in view of (14)

$$\lim_{\varepsilon} \int_{0}^{t} \int_{0}^{\infty} \tilde{a}(t, x, u_{\varepsilon}, \nabla u_{\varepsilon}) \cdot \nabla (u_{\varepsilon} - u) dx ds = 0.$$
 (17)

Set  $\vec{v} \in L^p(Q)^d$ . Since

$$\begin{split} 0 & \leq \int\limits_{Q} \left[ \tilde{a}(t,x,u_{\varepsilon},\nabla u_{\varepsilon}) - \tilde{a}(t,x,u_{\varepsilon},\vec{v}) \right] \cdot \left[ \nabla u_{\varepsilon} - \vec{v} \right] dx ds \\ & = \int\limits_{Q} \left[ \tilde{a}(t,x,u_{\varepsilon},\nabla u_{\varepsilon}) - \tilde{a}(t,x,u_{\varepsilon},\vec{v}) \right] \cdot \nabla (u_{\varepsilon} - u) dx ds \\ & + \int\limits_{Q} \left[ \tilde{a}(t,x,u_{\varepsilon},\nabla u_{\varepsilon}) - \tilde{a}(t,x,u_{\varepsilon},\vec{v}) \right] \cdot \left[ \nabla u - \vec{v} \right] dx ds \\ & = \int\limits_{Q} \left[ \tilde{a}(t,x,u_{\varepsilon},\nabla u_{\varepsilon}) - \tilde{a}(t,x,u_{\varepsilon},\nabla u) \right] \cdot \nabla (u_{\varepsilon} - u) dx ds \\ & + \int\limits_{Q} \left[ \tilde{a}(t,x,u_{\varepsilon},\nabla u) - \tilde{a}(t,x,u_{\varepsilon},\vec{v}) \right] \cdot \left[ \nabla u - u \right] dx ds \\ & + \int\limits_{Q} \left[ \tilde{a}(t,x,u_{\varepsilon},\nabla u) - \tilde{a}(t,x,u_{\varepsilon},\vec{v}) \right] \cdot \left[ \nabla u - \vec{v} \right] dx ds, \end{split}$$

using (15) and information similar to (14) allow one to pass to the limit and to conclude that

$$0 \leq \int\limits_{Q} [\vec{\xi} - \tilde{a}(t, x, u, \vec{v})] \cdot [\nabla u - \vec{v}] dx ds.$$

By the classical Minty's trick, considering  $\vec{v} = \nabla u + \lambda \vec{w}$ ,  $\vec{w} \in L^p(O)^d$  and  $\lambda \in \mathbb{R}$ , we have necessarily

$$0 = \lim_{\lambda \to 0} \int_{\Omega} [\vec{\xi} - \tilde{a}(t, x, u, \nabla u + \lambda \vec{w})] \cdot \vec{w} dx ds.$$

Thus, a classical property of radial continuity coming from the assumptions on a yields, for any  $\vec{w} \in L^p(Q)^d$ ,

$$\int_{0} \vec{\xi} \cdot \vec{w} dx ds = \int_{0} \tilde{a}(t, x, u, \nabla u) \cdot \vec{w} dx ds = \int_{0} a(t, x, u, \nabla u) \cdot \vec{w} dx ds,$$

i.e.  $\xi = \tilde{a}(t, x, u, \nabla u) = a(t, x, u, \nabla u)$ , since  $u \ge \psi$ .

**Remark 3.6.** Note that, following [3, Proof of Lemma 1], (15) yields the convergence in measure, then the a.e. convergence of  $\nabla u_{\varepsilon}$  to  $\nabla u$  (up to a subsequence if needed), so that this is also a way to identify  $\vec{\xi}$  has being  $a(t, x, u, \nabla u)$ .

We are now in a position to pass to the limit in the penalized problem and to conclude the existence of a solution to the obstacle problem under the additional regularity on  $g^-$ .

Let us consider  $v \in L^p(0, T; V)$ ,  $v \ge \psi$  as a test function in the penalized problem (6),

$$\int_{0}^{T} \langle \partial_{t} u_{\varepsilon}, v - u_{\varepsilon} \rangle + \int_{0}^{T} \tilde{a}(t, x, u_{\varepsilon}, \nabla u_{\varepsilon}) \cdot \nabla(v - u_{\varepsilon}) dx dt + \frac{1}{\varepsilon} \int_{0}^{T} \Theta(u_{\varepsilon} - \psi)(v - u_{\varepsilon}) dx dt = \int_{0}^{T} \langle f, v - u_{\varepsilon} \rangle dt. \quad (18)$$

In view of (16) we have

$$\int_{0}^{T} \langle \partial_{t} u_{\varepsilon}, v - u_{\varepsilon} \rangle dt = \int_{0}^{T} \langle \partial_{t} u_{\varepsilon}, v \rangle dt - \frac{1}{2} \|u_{\varepsilon}(T)\|_{L^{2}(\Omega)}^{2} + \frac{1}{2} \|u_{0}\|_{L^{2}(\Omega)}^{2}$$

$$\rightarrow \int_{0}^{T} \langle \partial_{t} u, v \rangle dt - \frac{1}{2} \|u(T)\|_{L^{2}(\Omega)}^{2} + \frac{1}{2} \|u_{0}\|_{L^{2}(\Omega)}^{2} = \int_{0}^{T} \langle \partial_{t} u, v - u \rangle dt.$$

From (17) and the identification  $\vec{\xi} = \tilde{a}(t, x, u, \nabla u) = a(t, x, u, \nabla u)$  it follows that

$$\int_{Q} \tilde{a}(t, x, u_{\varepsilon}, \nabla u_{\varepsilon}) \cdot \nabla(v - u_{\varepsilon}) dx dt = \int_{Q} \tilde{a}(t, x, u_{\varepsilon}, \nabla u_{\varepsilon}) \cdot \nabla(v - u) dx dt + \int_{Q} \tilde{a}(t, x, u_{\varepsilon}, \nabla u_{\varepsilon}) \cdot \nabla(u - u_{\varepsilon}) dx dt$$

$$\rightarrow \int_{Q} \tilde{a}(t, x, u, \nabla u) \cdot \nabla(v - u) dx dt = \int_{Q} a(t, x, u, \nabla u) \cdot \nabla(v - u) dx dt.$$

The weak convergence of  $u_{\varepsilon}$  to u in  $L^{p}(0, T; V)$  yields that

$$\int_{0}^{T}\langle f, v-u_{\varepsilon}\rangle \to \int_{0}^{T}\langle f, v-u\rangle.$$

At last splitting the penalized term in the following way

$$\frac{1}{\varepsilon} \int_{Q} \Theta(u_{\varepsilon} - \psi)(v - u_{\varepsilon}) dx dt = \underbrace{\frac{-1}{\varepsilon} \int_{Q} [(u_{\varepsilon} - \psi)^{-}]^{\tilde{q}-1}(v - \psi) dx dt}_{Q} - \underbrace{\frac{1}{\varepsilon} \|(u_{\varepsilon} - \psi)^{-}\|_{L^{\tilde{q}}(Q)}^{\tilde{q}}}_{\to 0 \text{ thanks to (11)}}$$

allows one to pass to the limit in (18). One concludes that a solution exists, i.e.

**Theorem 3.7.** Assume  $H_1 - H_4$ ,  $f - \partial_t \psi - A\psi = g = g^+ - g^- \in L^p(0, T; V)^*$  where  $g^- \in L^{p'}(Q) \cap L^2(Q)$ . There exists at least  $u \in \mathcal{K}(\psi)$  with  $u(t = 0) = u_0$  such that, for any  $v \in L^p(0, T; V)$  with  $v \ge \psi$ ,

$$\int_{0}^{T} \langle \partial_{t} u, v - u \rangle dt + \int_{Q} a(t, x, u, \nabla u) \cdot \nabla (v - u) dx dt \ge \int_{0}^{T} \langle f, v - u \rangle dt.$$

**Remark 3.8.** Note that the pseudomonotone assumption of the operator doesn't ensure the uniqueness of the solution. Observe that under additional assumptions on the operator a, namely a local Lipschitz continuity with respect to the third variable, standard arguments allow one to prove the uniqueness of the solution obtained in Theorem 3.7.

### 3.3 Lewy-Stampacchia's inequality for a regular $g^-$ .

Note that  $\mu_{\varepsilon} := \partial_t u_{\varepsilon} - \text{div}[\tilde{a}(\cdot, \cdot, u_{\varepsilon}, \nabla u_{\varepsilon})] - f = \frac{1}{\varepsilon}[(u_{\varepsilon} - \psi)^-]^{\tilde{q}-1} \ge 0$ , so that the limit  $\mu := \partial_t u - \text{div}[\tilde{a}(\cdot, \cdot, u, \nabla u)] - f$  is a non-negative Radon measure which is by Lemma 3.5 an element of  $L^{p'}(0, T; V')$ .

Using an idea from A. Mokrane and F. Murat [18], denote by  $z_{\varepsilon} := g^{-} - \frac{1}{\varepsilon} [(u_{\varepsilon} - \psi)^{-}]^{\tilde{q}-1}$ , we have

$$\partial_t u_{\varepsilon} + A(u_{\varepsilon}) + z_{\varepsilon} = g^+ + \partial_t \psi + A(\psi)$$
 i.e.  $\partial_t (u_{\varepsilon} - \psi) + A(u_{\varepsilon}) - A(\psi) + z_{\varepsilon} = g^+$ .

Observing that

$$\partial_t u_{\varepsilon} + A(u_{\varepsilon}) - f = -z_{\varepsilon} + g^{-1}$$

as in [18] in the elliptic case and under more restrictive assumptions on the operator a, proving that  $z_{\varepsilon}^{-}$  converges to 0 in an appropriate space leads to the Lewy-Stampacchia's inequality. Due to the time variable and the weak assumption on a we have to face to additional difficulties. For technical reasons, we will assume in this section only that, on top of  $g^- \in L^{p'}(Q) \cap L^p(0,T;V)$ ,  $g^- \ge 0$ , that  $\partial_t g^- \in L^{\tilde{q}'}(Q)$ . Roughly speaking it allows one to use a test function depending on g<sup>-</sup> and together with Lemma 4.3 to perform an integration by part formula and then the convergence analysis of  $z_{\varepsilon}^{-}$ .

The general case will be obtained in the next section by a regularization argument based on Lemma 4.1 of the Annex.

Our aim is now to show the convergence of  $z_{\varepsilon}^{-}$  to 0 in  $L^{2}(Q)$  to prove the following lemma.

**Lemma 3.9.** Under the assumptions of Theorem 3.7 and assuming moreover that  $g^- \in L^{p'}(Q) \cap L^p(0,T;V)$ ,  $g^- \ge 0$  with  $\partial_t g^- \in L^{\tilde{q}'}(Q)$ , the solution u satisfies

$$0 \le \partial_t u - \operatorname{div}[a(\cdot, \cdot, u, \nabla u)] - f \le g^- \text{ in } L^{p'}(0, T; V').$$

A priori, following Lemma's 4.3 notations, one should denote by

$$\Psi(t,x,\lambda) = -(g^- - \frac{1}{\varepsilon}[\lambda^-]^{\tilde{q}-1})^- \text{ and } \Lambda(t,x,\lambda) = \int_0^{\lambda} \Psi(t,x,\sigma)d\sigma.$$

For that, we need  $\Psi(t, x, u)$  to be a test-function.

Since  $x \mapsto [x^-]^{\tilde{q}-1}$  is not *a priori* a Lipschitz-continuous function (*e.g.* if  $p < 2^{\ddagger}$ ), therefore, for any positive k, we will denote by  $\eta_k(x) = (\tilde{q} - 1) \int_0^{x^+} \min(k, s^{\tilde{q}-2}) ds$ ,  $\Psi_k(t, x, \lambda) = -(g^- - \frac{1}{\varepsilon} \eta_k(\lambda^-))^-$  and  $\Lambda_k(t, x, \lambda) = -(g^- - \frac{1}{\varepsilon} \eta_k(\lambda^-))^-$ 

Note that  $\Psi_k(t,x,0)=0$  and  $\partial_t\Psi_k(t,x,\lambda)=\partial_tg^-1_{\{g^--\frac{1}{c}\eta_k(\lambda^-)<0\}}$  so that, since  $\Psi_k(t,x,u)$  is a test-function, by Lemma 4.3, for any t,

$$-\int_{0}^{t} \int_{\Omega} \partial_{t} \Lambda_{k}(s, x, u_{\varepsilon} - \psi) dx ds + \int_{\Omega} \Lambda_{k}(t, x, u_{\varepsilon}(t) - \psi(t)) dx - \int_{\Omega} \Lambda_{k}(0, x, u_{\varepsilon}(0) - \psi(0)) dx$$

$$-\int_{0}^{t} \langle A(u_{\varepsilon}) - A(\psi), (g^{-} - \frac{1}{\varepsilon} \eta_{k} [(u_{\varepsilon} - \psi)^{-}])^{-} \rangle dt - \int_{Q} z_{\varepsilon} (g^{-} - \frac{1}{\varepsilon} \eta_{k} [(u_{\varepsilon} - \psi)^{-}])^{-} dx ds$$

$$= -\int_{0}^{t} \langle g^{+}, (g^{-} - \frac{1}{\varepsilon} \eta_{k} [(u_{\varepsilon} - \psi)^{-}])^{-} \rangle ds \leq 0.$$

$$(19)$$

We now pass to the limit first as  $k \to \infty$  and then as  $\varepsilon \to 0$ . Since  $g^- \ge 0$ , one has that  $\Psi_k(t, x, \lambda) = 0$  if  $\lambda \ge 0$ and as  $u_{\varepsilon}(0) = u_0 \ge \psi(0)$ , one gets that

$$\int_{\Omega} \Lambda_k(t,x,u_{\varepsilon}(t)-\psi(t))dx - \int_{\Omega} \Lambda_k(0,x,u_{\varepsilon}(0)-\psi(0))dx = \int_{\Omega} \Lambda_k(t,x,u_{\varepsilon}(t)-\psi(t))dx.$$

Note that  $(\Psi_k(t, x, \lambda))_k$  is a non-increasing sequence of functions with non-positive values so that by monotone convergence theorem

$$\int_{\Omega} \Lambda_k(t, x, u_{\varepsilon}(t) - \psi(t)) dx \xrightarrow{k} - \int_{\Omega} \int_{0}^{(u_{\varepsilon} - \psi)(t)} (g^{-} - \frac{1}{\varepsilon} [\sigma^{-}]^{\tilde{q} - 1} d\sigma)^{-} dx \ge 0$$

since the integration holds on the set of negative values of  $u_{\varepsilon}(t) - \psi(t)$ .

Due to the definition of  $z_{\varepsilon}$  we have

$$\begin{split} &-\int\limits_{Q}z_{\varepsilon}(g^{-}-\frac{1}{\varepsilon}\eta_{k}[(u_{\varepsilon}-\psi)^{-}])^{-}dxdt\\ &=-\int\limits_{Q}(g^{-}-\frac{1}{\varepsilon}[(u_{\varepsilon}-\psi)^{-}]^{\tilde{q}-1})(g^{-}-\frac{1}{\varepsilon}\eta_{k}[(u_{\varepsilon}-\psi)^{-}])^{-}dxdt\\ &=\int\limits_{Q}(g^{-}-\frac{1}{\varepsilon}[(u_{\varepsilon}-\psi)^{-}]^{\tilde{q}-1})^{-}(g^{-}-\frac{1}{\varepsilon}\eta_{k}[(u_{\varepsilon}-\psi)^{-}])^{-}dxdt\\ &-\int\limits_{Q}(g^{-}-\frac{1}{\varepsilon}[(u_{\varepsilon}-\psi)^{-}]^{\tilde{q}-1})^{+}(g^{-}-\frac{1}{\varepsilon}\eta_{k}[(u_{\varepsilon}-\psi)^{-}])^{-}dxdt, \end{split}$$

from which it follows using again the monotone convergence theorem

$$-\int\limits_{\Omega}z_{\varepsilon}(g^{-}-\frac{1}{\varepsilon}\eta_{k}[(u_{\varepsilon}-\psi)^{-}])^{-}dxdt\longrightarrow\limits_{k}\int\limits_{0}^{T}\|z_{\varepsilon}^{-}\|_{L^{2}(\Omega)}^{2}dt.$$

As far as the first term of (19) is concerned we obtain

$$\begin{split} &-\int\limits_{Q}\partial_{t}\Lambda_{k}(t,x,u_{\varepsilon}-\psi)dxds=-\int\limits_{Q}\partial_{t}g^{-}\int\limits_{0}^{u_{\varepsilon}-\psi}\mathbf{1}_{\left\{g^{-}-\frac{1}{\varepsilon}\eta_{k}(\tau^{-})<0\right\}}d\tau dxds\\ &=-\int\limits_{Q}\partial_{t}g^{-}\int\limits_{0}^{-(u_{\varepsilon}-\psi)^{-}}\mathbf{1}_{\left\{g^{-}-\frac{1}{\varepsilon}\eta_{k}(\tau^{-})<0\right\}}d\tau dxds\geq-\int\limits_{Q}|\partial_{t}g^{-}||(u_{\varepsilon}-\psi)^{-}|dxds\xrightarrow{\varepsilon}0. \end{split}$$

For the fourth term of (19) we have the following equality

$$\begin{split} &-\int\limits_{0}^{T}\langle A(u_{\varepsilon})-A(\psi),(g^{-}-\frac{1}{\varepsilon}\eta_{k}[(u_{\varepsilon}-\psi)^{-}])^{-}\rangle dt \\ &=\int\limits_{Q}1_{\left\{g^{-}-\frac{1}{\varepsilon}\eta_{k}[(u_{\varepsilon}-\psi)^{-}]<0\right\}}\left[\tilde{a}(t,x,u_{\varepsilon},\nabla u_{\varepsilon})-\tilde{a}(t,x,\psi,\nabla\psi)\right]\nabla[g^{-}-\frac{1}{\varepsilon}\eta_{k}[(u_{\varepsilon}-\psi)^{-}]]dxdt \\ &=\int\limits_{Q}1_{\left\{g^{-}-\frac{1}{\varepsilon}\eta_{k}[(u_{\varepsilon}-\psi)^{-}]<0\right\}}\left[\tilde{a}(t,x,\psi,\nabla u_{\varepsilon})-\tilde{a}(t,x,\psi,\nabla\psi)\right]\nabla[g^{-}-\frac{1}{\varepsilon}\eta_{k}[(u_{\varepsilon}-\psi)^{-}]]dxdt, \end{split}$$

since in this situation, the integration holds in the set where  $u_{\varepsilon} \leq \psi$ . Thus,

$$\begin{split} & \left[ \tilde{a}(t,x,\psi,\nabla u_{\varepsilon}) - \tilde{a}(t,x,\psi,\nabla\psi) \right] \nabla [g^{-} - \frac{1}{\varepsilon} \eta_{k} [(u_{\varepsilon} - \psi)^{-}]] \\ & \geq \frac{1}{\varepsilon} \eta_{k}' [(u_{\varepsilon} - \psi)^{-}] \left[ \tilde{a}(t,x,\psi,\nabla u_{\varepsilon}) \right. \\ & \left. - \tilde{a}(t,x,\psi,\nabla\psi) \right] \nabla (u_{\varepsilon} - \psi) - \left| \tilde{a}(t,x,\psi,\nabla u_{\varepsilon}) - \tilde{a}(t,x,\psi,\nabla\psi) \right| |\nabla g^{-}| \\ & \geq - \left| \tilde{a}(t,x,\psi,\nabla u_{\varepsilon}) - \tilde{a}(t,x,\psi,\nabla\psi) \right| |\nabla g^{-}|. \end{split}$$

We now claim that estimate (10) of Lemma 3.4 which gives

$$\left[\tilde{a}(t,x,\psi,\nabla u_{\varepsilon})-\tilde{a}(t,x,\psi,\nabla\psi)\right]\nabla(u_{\varepsilon}-\psi)^{-}\underset{\varepsilon}{\longrightarrow}0\text{ in }L^{1}(Q)$$

and Assumptions  $H_{1,1}$  to  $H_{1,3}$  imply that, up to a subsequence (still denoted by  $\varepsilon$ ),  $\nabla (u_{\varepsilon} - \psi)^-$  converges to 0

Indeed, up to a subsequence (still denoted by  $\varepsilon$ ),  $u_{\varepsilon}$  converges to u a.e. in Q with  $u \geq \psi$  a.e. and  $\left| \tilde{a}(t,x,\psi,\nabla u_{\varepsilon}) - \tilde{a}(t,x,\psi,\nabla \psi) \right| |\nabla (u_{\varepsilon} - \psi)^{-}| \to 0 \text{ a.e. in } Q.$ 

Consider (t, x) such that the above limits hold. Since,

$$\begin{split} -\tilde{a}(t,x,\psi,\nabla u_{\varepsilon})\cdot\nabla(u_{\varepsilon}-\psi)^{-} &\geq \left[\bar{\alpha}|\nabla u_{\varepsilon}|^{p}-\bar{y}|\psi|^{q}-|\bar{h}|-\tilde{a}(t,x,\psi,\nabla u_{\varepsilon}).\nabla\psi\right]\mathbf{1}_{\{u_{\varepsilon}<\psi\}} \\ &\geq \left[\bar{\alpha}|\nabla u_{\varepsilon}|^{p}-\bar{y}|\psi|^{q}-|\bar{h}|-\bar{\beta}\left[|\bar{k}|+|\psi|^{r/p}+|\nabla u_{\varepsilon}|\right]^{p-1}|\nabla\psi|\right]\mathbf{1}_{\{u_{\varepsilon}<\psi\}} \\ &\geq \left[\bar{\alpha}/2|\nabla u_{\varepsilon}|^{p}-C(\psi,\bar{h},\bar{k},\nabla\psi)\right]\mathbf{1}_{\{u_{\varepsilon}<\psi\}}, \end{split}$$

and

$$|\tilde{a}(t,x,\psi,\nabla\psi)\cdot\nabla(u_{\varepsilon}-\psi)^{-}|\leq \bar{\beta}\Big[|\bar{k}|+|\psi|^{r/p}+|\nabla\psi|\Big]^{p-1}\Big[|\nabla u_{\varepsilon}|+|\nabla\psi|\Big]1_{\{u_{\varepsilon}<\psi\}},$$

one gets that  $(\nabla (u_{\varepsilon} - \psi)^{-}(t, x))_{\varepsilon}$  is a bounded sequence.

Since 
$$\nabla (u_{\varepsilon} - \psi)^-(t, x) = -\nabla (u_{\varepsilon} - \psi)(t, x) \mathbf{1}_{\{u_{\varepsilon} < \psi\}}(t, x)$$
, it converges to 0 if  $u(t, x) > \psi(t, x)$ .

Else, at the limit, one has that  $u(t, x) = \psi(t, x)$ . If one assumes that  $\nabla (u_{\varepsilon} - \psi)^{-}(t, x)$  is not converging to 0, then there exists a subsequence  $\varepsilon'$  (depending on (t, x)) and a positive  $\delta$  such that  $\|\nabla (u_{\varepsilon'} - \psi)^-(t, x)\| \ge \delta > 0$ . Then, necessarily  $-\nabla (u_{\mathcal{E}'} - \psi)^-(t, x) = \nabla (u_{\mathcal{E}'} - \psi)(t, x)$  and, since it is a bounded sequence in  $\mathbb{R}^d$ , there exists  $\vec{\xi} \in \mathbb{R}^d$ and a new subsequence still labeled  $\varepsilon'$  such that  $\nabla u_{\varepsilon'}(t,x)$  converges to  $\vec{\xi}$ , with the additional information:  $\|\vec{\xi} - \nabla \psi(t, x)\| \ge \delta > 0$ . Therefore, since  $\vec{\xi} \ne \nabla \psi(t, x)$ 

$$\begin{split} & \left[ \tilde{a}(t,x,\psi,\nabla u_{\varepsilon'}(t,x)) - \tilde{a}(t,x,\psi,\nabla \psi(t,x)) \right] \cdot \nabla (u_{\varepsilon'} - \psi)^{-}(t,x) \\ &= - \left[ \tilde{a}(t,x,\psi,\nabla u_{\varepsilon'}(t,x)) - \tilde{a}(t,x,\psi,\nabla \psi(t,x)) \right] \cdot \nabla (u_{\varepsilon'} - \psi)(t,x) \\ & \xrightarrow{\varepsilon'} - \left[ \tilde{a}(t,x,\psi,\vec{\xi}) - \tilde{a}(t,x,\psi,\nabla \psi(t,x)) \right] \cdot [\vec{\xi} - \nabla \psi(t,x)] < 0. \end{split}$$

But, this is in contradiction with the convergence of the same sequence to 0 and the result holds.

Note that  $(t, x) \in Q$  a.e.,

$$\left[\tilde{a}(t,x,\psi,\nabla u_{\varepsilon})-\tilde{a}(t,x,\psi,\nabla\psi)\right]\mathbf{1}_{\left\{u_{\varepsilon}<\psi\right\}}=\left[\tilde{a}(t,x,\psi,\nabla u_{\varepsilon}\mathbf{1}_{\left\{u_{\varepsilon}<\psi\right\}})-\tilde{a}(t,x,\psi,\nabla\psi\mathbf{1}_{\left\{u_{\varepsilon}<\psi\right\}})\right]$$

and  $\nabla u_{\varepsilon} \mathbf{1}_{\{u_{\varepsilon} < \psi\}} - \nabla \psi \mathbf{1}_{\{u_{\varepsilon} < \psi\}}$  converges to 0 with  $\nabla \psi \mathbf{1}_{\{u_{\varepsilon} < \psi\}}$  bounded. Then, the continuity of  $\tilde{a}$  with respect to its fourth argument can be assumed uniform and  $\left[\tilde{a}(t,x,\psi,\nabla u_{\varepsilon})-\tilde{a}(t,x,\psi,\nabla\psi)\right]\mathbf{1}_{\{u_{\varepsilon}<\psi\}}$  converges a.e.

Since it is bounded in  $L^{p'}(Q)$ , it converges weakly to 0 in  $L^{p'}(Q)$  and

$$\int\limits_{\Omega} \Big| \tilde{a}(t,x,\psi,\nabla u_{\varepsilon}) - \tilde{a}(t,x,\psi,\nabla\psi) \Big| |\nabla g^{-}| \mathbb{1}_{\{u_{\varepsilon} < \psi\}} dx dt \to 0.$$

As a conclusion,  $z_{\varepsilon}^-$  converges to 0 in  $L^2(Q)$ . On the one hand we have

$$0 \le \mu_{\varepsilon} = \frac{1}{\varepsilon} \left[ (u_{\varepsilon} - \psi)^{-} \right]^{\tilde{q} - 1} = \partial_{t} u_{\varepsilon} - \operatorname{div} \left[ \tilde{a}(\cdot, \cdot, u_{\varepsilon}, \nabla u_{\varepsilon}) \right] - f$$

$$\Rightarrow \quad 0 \le \partial_{t} u - \operatorname{div} \left[ \tilde{a}(\cdot, \cdot, u, \nabla u) \right] - f;$$

On the other hand

$$z_{\varepsilon} = g^{-} - \frac{1}{\varepsilon} \left[ (u_{\varepsilon} - \psi)^{-} \right]^{\tilde{q} - 1} \Rightarrow z_{\varepsilon}^{+} + \partial_{t} u_{\varepsilon} - \operatorname{div} \left[ \tilde{a}(\cdot, \cdot, u_{\varepsilon}, \nabla u_{\varepsilon}) \right] - f = g^{-} + z_{\varepsilon}^{-}$$
$$\Rightarrow 0 \le \partial_{t} u - \operatorname{div} \left[ \tilde{a}(\cdot, \cdot, u, \nabla u) \right] - f \le g^{-}.$$

Since  $\tilde{a}(\cdot, \cdot, u, \nabla u) = a(\cdot, \cdot, u, \nabla u)$ , Lemma 3.9 is proved.

**Remark 3.10.** *Note that, for any*  $\varphi \in L^p(0, T; V)$ ,

$$\int_{0}^{T} \langle \partial_{t} u_{\varepsilon} - \operatorname{div}[\tilde{a}(\cdot, \cdot, u_{\varepsilon}, \nabla u_{\varepsilon})] - f, \varphi \rangle dt$$

$$= \int_{0}^{T} \langle \partial_{t} u_{\varepsilon} - \operatorname{div}[\tilde{a}(\cdot, \cdot, u_{\varepsilon}, \nabla u_{\varepsilon})] - f, \varphi^{+} \rangle dt - \int_{0}^{T} \langle \partial_{t} u_{\varepsilon} - \operatorname{div}[\tilde{a}(\cdot, \cdot, u_{\varepsilon}, \nabla u_{\varepsilon})] - f, \varphi^{-} \rangle dt$$

$$\leq \int_{0}^{T} \langle \partial_{t} u_{\varepsilon} - \operatorname{div}[\tilde{a}(\cdot, \cdot, u_{\varepsilon}, \nabla u_{\varepsilon})] - f, \varphi^{+} \rangle dt \leq \int_{0}^{T} \langle g^{-}, \varphi^{+} \rangle dt.$$

In such a way,  $\|\partial_t u_{\varepsilon} - \operatorname{div}[\tilde{a}(\cdot, \cdot, u_{\varepsilon}, \nabla u_{\varepsilon})] - f\|_{L^{p'}(0,T;V')} \leq \|g^-\|_{L^{p'}(0,T;V')}$ 

#### 3.4 Proof of the main result

In this section,  $H_3$  is assumed and  $g = f - \partial_t \psi - A(\psi) = g^+ - g^-$  where  $g^+, g^- \in (L^{p'}(0, T; V'))^+$  are non-negative elements of  $L^{p'}(0, T; V')$ .

Thanks to Lemma 4.1, there exists positives  $(g_n^-) \subset L^{p'}(Q)$  such that  $g_n^- \to g^-$  in  $L^{p'}(0, T; V')$ . Then, by a regularization procedure, one can assume that  $g_n^- \in L^{p'}(Q) \cap L^p(0, T; V)$ ,  $g_n^- \ge 0$  with  $\partial_t g_n^- \in L^{\tilde{q}'}(Q)$ . Then, the corresponding sequence  $f_n$  converges to f in  $L^{p'}(0, T; V')$ .

**Remark 3.11.** In fact, since  $D(Q)^+$  is dense in  $L^{p'}(Q)^+$ , one can consider  $g_n^-$  as regular as needed.

Associated with  $g_n^-$ , Theorem 3.7 and Lemma 3.9 provide the existence of  $u_n \in \mathcal{K}(\psi)$  with  $u_n(t=0) = u_0$  and such that, for any  $v \in L^p(0, T; V)$ ,  $v \ge \psi$  implies that

$$\int_{0}^{T} \langle \partial_{t} u_{n}, v - u_{n} \rangle dt + \int_{0}^{T} a(t, x, u_{n}, \nabla u_{n}) \cdot \nabla (v - u_{n}) dx dt \geq \int_{0}^{T} \langle f_{n}, v - u_{n} \rangle dt$$

and satisfying the Lewy-Stampacchia's inequality

$$0 \le \partial_t u_n - \operatorname{div}[a(\cdot, \cdot, u_n, \nabla u_n)] - f_n \le g_n^-$$

Since this solution comes from the above penalization method, and as  $C_1$  of Lemma 3.3 can be chosen independent of n, one gets that

$$\sup_{t} \|u_n\|_{L^2(\Omega)}^2(t) + \|u_n\|_{L^p(0,T;V)}^p \leq C_1.$$

Thus,  $a(\cdot, u_n, \nabla u_n)$  is bounded in  $L^{p'}(Q)^d$  and, thanks to the above Lewy-Stampacchia's inequality,  $\partial_t u_n$  is bounded in  $L^{p'}(0, T; V')$ .

Up to a subsequence denoted similarly,  $u_n$  converges weakly to an element  $u \in \mathcal{K}(\psi)$  in W(0, T) and strongly in  $L^p(Q)$ ; and  $a(\cdot, u_n, \nabla u_n)$  converges to an element  $\vec{\xi}$  in  $L^{p'}(Q)^d$ .

Finally, the embedding of W(0, T) in  $C([0, T], L^2(\Omega))$  yields the weak convergence of  $u_n(t)$  to u(t) in  $L^2(\Omega)$ , for any t.

Since  $u \in \mathcal{K}(\psi)$ ,

$$\int_{0}^{T} \langle \partial_{t} u_{n}, u - u_{n} \rangle dt + \int_{0}^{T} a(t, x, u_{n}, \nabla u_{n}) \cdot \nabla (u - u_{n}) dx dt \geq \int_{0}^{T} \langle f_{n}, u - u_{n} \rangle dt.$$

Therefore, passing to the limit with respect to *n* in

$$\int_{0}^{T} \langle \partial_{t} u_{n}, u \rangle dt + \int_{Q} a(t, x, u_{n}, \nabla u_{n}) \cdot \nabla u dx dt + \frac{1}{2} \|u_{0}\|_{L^{2}(\Omega)}^{2}$$

$$\geq \int_{0}^{T} \langle f_{n}, u - u_{n} \rangle dt + \frac{1}{2} \|u_{n}(T)\|_{L^{2}(\Omega)}^{2} + \int_{Q} a(t, x, u_{n}, \nabla u_{n}) \cdot \nabla u_{n} dx dt$$

vields

$$\int_{0}^{T} \langle \partial_{t} u, u \rangle dt + \int_{Q} \vec{\xi} \cdot \nabla u dx dt + \frac{1}{2} \|u_{0}\|_{L^{2}(\Omega)}^{2}$$

$$\geq \frac{1}{2} \|u(T)\|_{L^{2}(\Omega)}^{2} + \limsup_{n} \int_{Q} a(t, x, u_{n}, \nabla u_{n}) \cdot \nabla u_{n} dx dt.$$

Since  $\int_{0}^{T} \langle \partial_{t} u, u \rangle dt = \frac{1}{2} \|u(T)\|_{L^{2}(\Omega)}^{2} - \frac{1}{2} \|u_{0}\|_{L^{2}(\Omega)}^{2}$ , one gets that

$$\limsup_{n} \int_{O} a(t, x, u_{n}, \nabla u_{n}) \cdot \nabla u_{n} dx dt \leq \int_{O} \vec{\xi} \cdot \nabla u dx dt.$$

Thus, (2) and the continuity property of Nemytskii's operator ensure the following limit argument:

$$0 \leq \int_{Q} [a(t, x, u_n, \nabla u_n) - a(t, x, u_n, \nabla u)] \cdot \nabla (u_n - u) dx dt$$

$$= \int_{Q} a(t, x, u_n, \nabla u_n) \cdot \nabla u_n dx dt - \int_{Q} a(t, x, u_n, \nabla u_n) \cdot \nabla u dx dt$$

$$- \int_{Q} a(t, x, u_n, \nabla u) \cdot \nabla (u_n - u) dx dt,$$

thus

$$0 \leq \liminf_{n} \int_{\Omega} a(t, x, u_n, \nabla u_n) \cdot \nabla u_n dx dt - \int_{\Omega} \vec{\xi} \cdot \nabla u dx dt.$$

Then,  $\lim_n \int_Q a(t, x, u_n, \nabla u_n) \cdot \nabla u_n dx dt = \int_Q \vec{\xi} \cdot \nabla u dx dt$  and arguments already developed previously based on Minty's trick for the pseudomonotone operator A yield the identification  $\vec{\xi} = a(t, x, u, \nabla u)$  and one has

$$\lim_{n}\int_{\Omega}a(t,x,u_{n},\nabla u_{n})\cdot\nabla(u_{n}-v)dxdt=\int_{\Omega}a(t,x,u,\nabla u)\cdot\nabla(u-v)dxdt.$$

From the weak lower semicontinuity of  $|\cdot|_{L^2(\Omega)}$ , one has

$$\limsup_{n}\int_{0}^{T}\langle \partial_{t}u_{n}, v-u_{n}\rangle dt \leq \int_{0}^{T}\langle \partial_{t}u, v-u\rangle dt.$$

Since  $\int_0^T \langle f_n, v - u_n \rangle dt \to \int_0^T \langle f, v - u \rangle dt$ , we deduce the existence result of Theorem 2.2 for general f. At last the Lewy-Stampacchia's inequality is a consequence of passing to the limit in the one satisfied by  $u_n$ .

# 4 Annex

### 4.1 Positive cones in the dual

**Lemma 4.1.** The positive cone of  $L^p(0,T;V) \cap L^2(Q)$  is dense in the positive cone of V', the dual set of V $L^{p}(0, T; V).$ 

By a truncation argument, the same result holds for the positive cone of  $L^p(0,T;V) \cap L^{p'}(Q)$  when p < 2.

*Proof.* This result is given in [7, Lemma p.593]. We propose here a sketch of a proof following the idea of [18].

Consider  $f \in L^{p'}(0, T; V')$  such that  $f \ge 0$  in the sense:  $\forall \varphi \in L^p(0, T; V), \varphi \ge 0 \Rightarrow \langle f, \varphi \rangle \ge 0$ .

Let us construct a sequence  $(f_{\varepsilon}) \subset L^p(0, T; V)$  with  $f_{\varepsilon} \ge 0$  such that  $f_{\varepsilon} \to f$  in  $L^{p'}(0, T; V')$ .

Consider the following operator  $B: L^p(0, T; V) \to L^{p'}(0, T; V')$  defined, for any  $u, v \in L^p(0, T; V)$  by

$$\langle Bu, v \rangle = \int_{\Omega} |\nabla u|^{p-2} \nabla u \cdot \nabla v \, dx dt + \int_{\Omega}^{T} ||u(t)||_{L^{2}(\Omega)}^{p-2} \int_{\Omega} uv \, dx \, dt. \tag{20}$$

B = DJ where  $J: u \mapsto \frac{1}{p} \int_{\Omega} |\nabla u|^p dxdt + \frac{1}{p} \int_{\Omega}^{T} ||u(t)||_{L^2(\Omega)}^p dt$ , is a G-differentiable, hemi continuous convex

function, and, B is a strictly monotone, bounded, continuous and coercive operator from  $L^p(0, T; V)$  into  $L^{p'}(0, T; V')$ . Then ([23, section 2.1]), denote by v the unique solution to Bv = f.

For any  $\varepsilon > 0$  and  $n \in \mathbb{N}$ , denote by  $v_{\varepsilon}^n$  the solution to  $Bv_{\varepsilon}^n + \frac{1}{\varepsilon}T_n(v_{\varepsilon}^n - v) = 0$  in  $L^p(0, T; V)$  where  $T_n$  is the truncation at the height n.

Using  $v_{\varepsilon}^n - v$  as test function, one has  $J(v_{\varepsilon}^n) + \frac{1}{\varepsilon} \|T_n(v_{\varepsilon}^n - v)\|_{L^2(Q)}^2 \le J(v)$ . Thus, there exists  $v_{\varepsilon}$ , weak limit in  $L^p(0, T; V)$  of a subsequence (denoted similarly) of  $v_{\varepsilon}^n$  satisfying:  $J(v_{\varepsilon}) + \frac{1}{\varepsilon} \|T_n(v_{\varepsilon}^n - v)\|_{L^2(Q)}^2 \le J(v)$ .  $\frac{1}{\varepsilon} \|v_{\varepsilon} - v\|_{L^2(Q)}^2 \le J(v)$  and, by classical monotony arguments, solution in  $L^p(0, T; V)$  to the problem:

$$\langle Bv_{\varepsilon}, w \rangle + \frac{1}{\varepsilon} \int_{\Omega} (v_{\varepsilon} - v) w dx dt = 0 \quad \forall w \in L^{p}(0, T; V) \cap L^{2}(Q).$$
 (21)

Then, up to a subsequence,  $v_{\varepsilon} - v \to 0$  in  $L^2(Q)$ ,  $v_{\varepsilon} \rightharpoonup v$  in  $L^p(0, T; V)$  and

$$\langle Bv_{\varepsilon} - Bv, (v_{\varepsilon} - v)^{+} \rangle + \frac{1}{\varepsilon} \int_{O} |(v_{\varepsilon} - v)^{+}|^{2} dx dt = -\langle f, (v_{\varepsilon} - v)^{+} \rangle \leq 0,$$
 (22)

so that  $f_{\varepsilon} = -\frac{1}{\varepsilon}(v_{\varepsilon} - v) \in L^p(0, T; V) \cap L^2(Q)$  is non-negative. Finally, as  $\limsup_{\varepsilon} J(v_{\varepsilon}) \leq J(v)$ , an argument of uniform convexity yields the convergence of  $v_{\varepsilon}$  to v in  $L^p(0,T;V) \text{ and } -\frac{1}{\varepsilon}(v_{\varepsilon}-v)=Bv_{\varepsilon}\to Bv=f \text{ in } L^{p'}(0,T;V').$ 

## 4.2 Compactness when p < 2.

Concerning the compactness argument in  $L^p(Q)$  when p < 2: note that there exists an integer  $k \ge 1$  such that  $W_0^{k,p}(\Omega) \overset{\smile}{\underset{dense}{\hookrightarrow}} L^{p'}(\Omega)$  so that

$$W_0^{k,p}(\Omega) \overset{\hookrightarrow}{\underset{dense}{\longleftrightarrow}} V \overset{\hookrightarrow}{\underset{dense}{\longleftrightarrow}} L^p(\Omega) \equiv [L^{p'}(\Omega)]' \hookrightarrow W^{-k,p'}(\Omega) \text{ and } V' \hookrightarrow W^{-k,p'}(\Omega).$$

**Remark 4.2.** Let us justify that the identification  $L^p(\Omega) \equiv [L^{p'}(\Omega)]'$  is possible if  $L^2(\Omega)$  is already chosen as the pivot-space.

Indeed, one has:  $L^{p'}(\Omega) \underset{dense}{\hookrightarrow} L^2(\Omega) \underset{dense}{\hookrightarrow} L^p(\Omega)$  with reflexive B-spaces, so that  $L^p(\Omega)' \underset{dense}{\hookrightarrow} L^2(\Omega)' \underset{dense}{\hookrightarrow}$  $L^{p'}(\Omega)'$ .

Consider  $T \in L^{p'}(\Omega)'$  and  $T_n \in L^2(\Omega)'$  such that  $T_n \to T$  in  $L^{p'}(\Omega)'$ . Then, by the pivot-space identification, there exists  $u_n \in L^2(\Omega)$  such that  $T_n = u_n$  in the sense of Riesz-identification. Then, for any  $v \in L^{p'}(\Omega)$  with norm 1,

$$|\int_{\Omega} u_n v dx| \leq ||T||_{L^{p'}(\Omega)'} + ||T_n - T||_{L^{p'}(\Omega)'}.$$

By considering  $v = Sgn(u_n) \frac{|u_n|^{p-1}}{\|u_n\|_{L^p}^{p-1}}$ , one has that the sequence  $(u_n)$  is bounded in  $L^p(\Omega)$  and that, up to a subsequence if needed, it converges weakly to a given u in  $L^p(\Omega)$ . Thus, for any  $v \in L^{p'}(\Omega)$ ,

$$\langle T, v \rangle = \lim \langle T_n, v \rangle = \lim \int_{\Omega} u_n v dx = \int_{\Omega} u v dx.$$

Since this element *u* is unique in its way, the identification holds.

Then, since the embedding of V is compact in  $L^p(\Omega)$ , by Aubin-Lions-Simon [26] compactness theorems, if a sequence is bounded in W(0, T), it is also bounded in  $\{u \in L^p(0, T; V), \partial_t u \in L^{p'}(0, T; W^{-k,p'}(\Omega))\}$  and relatively compact in  $L^p(Q)$ .

# 4.3 On Mignot-Bamberger -Alt-Luckhaus integration by part formula

We propose in next Lemma a time integration by part formula adapted to our situation. Its proof has been inspired by [9].

#### Lemma 4.3.

Consider  $u \in L^p(0, T; W^{1,p}(\Omega)) \cap L^p(0, T; L^2(\Omega))$  such that  $\partial_t u \in L^{p'}(0, T; V')$ .

Let  $\Psi: O \times \mathbb{R} \to \mathbb{R}$  be a function such that  $(t, x) \mapsto \Psi(t, x, \lambda)$  is measurable,  $\lambda \mapsto \Psi(t, x, \lambda)$  is non-decreasing (it can be càdlàg§ or càglàd¶) and denote by  $\Lambda: Q \times \mathbb{R} \to \mathbb{R}$ ,  $(t, x, \lambda) \mapsto \int_a^{\lambda} \Psi(t, x, \tau) d\tau$  where a is any arbitrary real number. Assume moreover that  $\partial_t \Psi$  exists with  $|\Psi(\lambda = 0)| + |\partial_t \Psi| \le h \in L^2(Q)$ . If  $\Psi(t, x, u) \in L^p(0, T; V)$ , then, for any  $\beta \in W^{1,\infty}(0,T)$  and any  $0 \le s < t \le T$ ,

$$\int_{s}^{t} \langle \partial_{t}u, \Psi(\sigma, x, u) \rangle \beta d\sigma = \int_{\Omega} \Lambda(t, x, u(t)) \beta(t) dx - \int_{\Omega} \Lambda(s, x, u(s)) \beta(s) dx$$
$$- \int_{s}^{t} \int_{\Omega} \Lambda(\sigma, x, u) \beta' dx d\sigma - \int_{s}^{t} \int_{\Omega} \partial_{t} \Lambda(\sigma, x, u) \beta dx d\sigma.$$

*Proof.* Thanks to the assumptions on  $\Psi$ , it is a measurable function on  $Q \times \mathbb{R}$  and  $\Lambda$  is a Carathéodory function on  $Q \times \mathbb{R}$ . Moreover,

$$|\Psi(t,x,\lambda)| \le \int_0^t |\partial_t \Psi(s,x,\lambda)| ds \le T.h(t,x),$$

$$|\Lambda(t,x,\lambda)| \le |\lambda - a|T.h(t,x) \le |\lambda|^2 + T^2h^2(t,x)/4 + |a|T.h(t,x),$$

<sup>§</sup> continu à droite et limite à gauche: right continuous with left limit

<sup>¶</sup> continu à gauche et limite à droite : left continuous with right limit

so that  $\Lambda$ ,  $\Psi \in L^2_{loc}(\mathbb{R}, L^2(Q))$  and the Nemytskii operator associated with  $\Lambda$  is continuous from  $L^2(Q)$  to  $L^1(Q)$ . Moreover,  $\partial_t \Lambda(t, x, \lambda) = \int_a^\lambda \partial_t \Psi(t, x, \tau) d\tau$  and

 $\left| \partial_t \Lambda(t, x, \lambda) \right| \le |\lambda - a| h(t, x) \le |\lambda|^2 + h^2(t, x)/4 + |a| h(t, x)$  so that the Nemytskii operator associated with  $\partial_t \Lambda$  is also continuous from  $L^2(Q)$  to  $L^1(Q)$ .

By assumption,  $u \in C([0, T], L^2(\Omega))$  and one extends u to  $\bar{u}$  in  $\mathbb{R}$  by  $\bar{u}(t) = u_0$  if t < 0 and  $\bar{u}(t) = u(T)$  si t > T. Therefore, if  $I_1 := (-1, T+1)$ ,  $\bar{u} \in L^p(I_1, W^{1,p}(\Omega)) \cap C(\bar{I}_1, L^2(\Omega))$  such that  $\partial_t \bar{u} \in L^{p'}(I_1, V')$  with  $\partial_t \bar{u} = 0$  when t < 0 or t > T.

Similarly to u, denote by  $\bar{\Psi}$  the extension to  $I_1$  of  $\Psi$  in the same way and by  $\bar{\Lambda}$  the corresponding integral as introduced in the Lemma.

For any fixed 0 < h << 1, let us denote by

$$v_h: t \mapsto \frac{\bar{u}(t+h) - \bar{u}(t)}{h}, \quad w_h: t \mapsto \frac{\bar{u}(t) - \bar{u}(t-h)}{h}.$$

Consider  $\beta \in \mathcal{D}(I_1)$  and h, small enough so that supp $\beta + [-h, h] \subset I_1$ . Then, in  $L^2(\Omega)$ ,

$$\int_{I_1} v_h(t)\beta(t)dt & \int_{I_1} w_h(t)\beta(t)dt$$

$$\rightarrow \int_{h}^{T+1} \bar{u}(t)\beta'(t)dt = -\int_{0}^{T} u(t)\beta'(t)dt + u(T)\beta(T) - u_0\beta(0).$$

Thus,  $v_h$  and  $w_h$  converge to  $\partial_t \bar{u}$  in  $\mathcal{D}'[I_1, L^2(\Omega)]$  and  $\mathcal{D}'[I_1, V']$ , and to  $\partial_t u$  in  $\mathcal{D}'[0, T; L^2(\Omega)]$  and  $\mathcal{D}'[0, T; V']$ . Moreover, by [5, Corollary A.2 p.145], the properties of Bochner integral and since  $\partial_t \bar{u} = 0$  outside (0, T),

$$\int_{I_{1}} \|v_{h}(t)\|_{V'}^{p'} dt = \int_{I_{1}} \frac{1}{h^{p'}} \|\int_{t}^{t+h} \partial_{t} \bar{u}(s) ds\|_{V'}^{p'} dt$$

$$\leq \int_{I_{1}} \frac{1}{h} \int_{t}^{t+h} \|\partial_{t} \bar{u}(s)\|_{V'}^{p'} ds dt \leq \int_{0}^{T} \|\partial_{t} u(s)\|_{V'}^{p'} ds.$$

Therefore,  $v_h$  converges weakly to  $\partial_t \bar{u}$  in  $L^{p'}[I_1, V']$  and to  $\partial_t u$  in  $L^{p'}[0, T; V']$  (as well as for  $w_h$ ).

For any  $\beta \in D(I_1)$ , one has  $\Psi(\cdot, \bar{u})\beta \in L^p(I_1, V)$ , and

$$\int\limits_{I_1\times\Omega}w_h\bar{\Psi}(\cdot,\bar{u}(t))\beta dxdt & \int\limits_{I_1\times\Omega}v_h\bar{\Psi}(\cdot,u(t))\beta dxdt \to \int\limits_{I_1}\langle \partial_t\bar{u},\bar{\Psi}(\cdot,\bar{u})\rangle\beta dt.$$

Let us recall that a is a given real and  $\bar{\Lambda}(t, x, \lambda) = \int_a^{\lambda} \bar{\Psi}(t, x, \tau) d\tau$ . Since  $\bar{\Psi}$  is a non-decreasing function of its third variable, for any real numbers u and v, one has

$$(v-u)\bar{\Psi}(t,x,u)\leq \bar{\Lambda}(t,x,v)-\bar{\Lambda}(t,x,u)=\int\limits_{t}^{v}\bar{\Psi}(t,x,\tau)d\tau\leq (v-u)\bar{\Psi}(t,x,v).$$

Thus, assuming moreover that  $\beta$  is non-negative,

$$\begin{split} [\bar{u}(t+h,x)-\bar{u}(t,x)]\bar{\Psi}(t,x,\bar{u}(t))\beta \leq & [\bar{\Lambda}(t,x,\bar{u}(t+h))-\bar{\Lambda}(t,x,\bar{u}(t))]\beta \\ \leq & [\bar{u}(t+h,x)-\bar{u}(t,x)]\bar{\Psi}(t,x,\bar{u}(t+h))\beta, \\ [\bar{u}(t,x)-\bar{u}(t-h,x)]\bar{\Psi}(t,x,\bar{u}(t-h))\beta \leq & [\bar{\Lambda}(t,x,\bar{u}(t))-\bar{\Lambda}(t,x,\bar{u}(t-h))]\beta \\ \leq & [\bar{u}(t,x)-\bar{u}(t-h,x)]\bar{\Psi}(t,x,\bar{u}(t))\beta. \end{split}$$

and, for *h* small enough to have supp $\beta$  + [-*h*, *h*]  $\subset$   $I_1$ ,

$$\begin{split} \int\limits_{I_{1}\times\Omega} v_{h}\beta\bar{\Psi}(\cdot,u(t))dxdt &\leq \int\limits_{I_{1}\times\Omega} \frac{\bar{\Lambda}(\cdot,\bar{u}(t+h))-\bar{\Lambda}(\cdot,\bar{u}(t))}{h}\beta dxdt \\ &\leq \int\limits_{I_{1}\times\Omega} v_{h}\beta\bar{\Psi}(\cdot,\bar{u}(t+h))dxdt, \\ \int\limits_{I_{1}\times\Omega} w_{h}\beta\bar{\Psi}(\cdot,\bar{u}(t-h))dxdt &\leq \int\limits_{I_{1}\times\Omega} \frac{\bar{\Lambda}(\cdot,\bar{u}(t))-\bar{\Lambda}(\cdot,\bar{u}(t-h))}{h}\beta dxdt \\ &\leq \int\limits_{I_{1}\times\Omega} w_{h}\beta\bar{\Psi}(\cdot,\bar{u}(t))dxdt, \end{split}$$

so that

$$\liminf_{h} \int\limits_{I_{1}\times\Omega} \frac{\bar{\Lambda}(\cdot,\bar{u}(t+h)) - \bar{\Lambda}(\cdot,\bar{u}(t))}{h} \beta dx dt \geq \int\limits_{I_{1}} \langle \partial_{t}\bar{u},\bar{\Psi}(\cdot,\bar{u}) \rangle \beta dt = \int\limits_{0}^{T} \langle \partial_{t}u,\Psi(\cdot,u) \rangle \beta dt,$$
 
$$\limsup_{h} \int\limits_{I_{1}\times\Omega} \frac{\bar{\Lambda}(\cdot,\bar{u}(t)) - \bar{\Lambda}(\cdot,\bar{u}(t-h))}{h} \beta dx dt \leq \int\limits_{I_{1}} \langle \partial_{t}\bar{u},\bar{\Psi}(\cdot,\bar{u}) \rangle \beta dt = \int\limits_{0}^{T} \langle \partial_{t}u,\Psi(\cdot,u) \rangle \beta dt.$$

On the other hand,

$$\int\limits_{I_{1}\times\Omega}\frac{\bar{\Lambda}(t,x,\bar{u}(t+h))-\bar{\Lambda}(t,x,\bar{u}(t))}{h}\beta(t)dxdt$$

$$=\frac{1}{h}\int\limits_{I_{1}\times\Omega}\bar{\Lambda}(t-h,x,\bar{u}(t))\beta(t-h)dxdt-\frac{1}{h}\int\limits_{I_{1}\times\Omega}\bar{\Lambda}(t,x,\bar{u}(t))\beta(t)dxdt$$

$$=\int\limits_{I_{1}\times\Omega}\frac{\bar{\Lambda}(t-h,x,\bar{u}(t))-\bar{\Lambda}(t,x,\bar{u}(t))}{h}\beta(t-h)dxdt+\int\limits_{I_{1}\times\Omega}\frac{\beta(t-h)-\beta(t)}{h}\bar{\Lambda}(t,x,\bar{u}(t))dxdt$$

and

$$\int_{I_{1}\times\Omega} \frac{\bar{\Lambda}(t,x,\bar{u}(t)) - \bar{\Lambda}(t,x,\bar{u}(t-h))}{h} \beta(t) dx dt$$

$$= \int_{I_{1}\times\Omega} \frac{\bar{\Lambda}(t,x,\bar{u}(t)) - \bar{\Lambda}(t+h,x,\bar{u}(t))}{h} \beta(t+h) dx dt + \int_{I_{1}\times\Omega} \frac{\beta(t) - \beta(t+h)}{h} \bar{\Lambda}(t,x,\bar{u}(t)) dx dt.$$

Then, one gets by passing to the limit when  $h \to 0$ , and thanks to the time-extension procedure,

$$\lim \inf_{h} \int_{I_{1} \times \Omega} \frac{\bar{\Lambda}(t - h, x, \bar{u}(t)) - \bar{\Lambda}(t, x, \bar{u}(t))}{h} \beta(t - h) dx dt$$

$$\geq \int_{0}^{T} \langle \partial_{t} u, \Psi(\cdot, u) \rangle \beta dt + \int_{I_{1} \times \Omega} \bar{\Lambda}(\cdot, \bar{u}) \beta' dt$$

$$= \int_{0}^{T} \langle \partial_{t} u, \Psi(\cdot, u) \rangle \beta dt + \int_{Q} \Lambda(\cdot, u) \beta' dt + \int_{\Omega} \Lambda(0, x, u_{0}) \beta(0) dx - \int_{\Omega} \Lambda(T, x, u(T)) \beta(T) dx$$

$$\geq \lim \sup_{h} \int_{I_{1} \times \Omega} \frac{\bar{\Lambda}(t, x, \bar{u}(t)) - \bar{\Lambda}(t + h, x, \bar{u}(t))}{h} \beta(t + h) dx dt$$

Note that

$$\int_{I_1 \times \Omega} \frac{\bar{\Lambda}(t-h, x, \bar{u}(t)) - \bar{\Lambda}(t, x, \bar{u}(t))}{h} \beta(t-h) dx dt$$

$$= -\int_{I_1 \times \Omega} \frac{1}{h} \int_{t-h}^{t} \partial_t \bar{\Lambda}(s, x, \bar{u}(t)) \beta(t-h) ds dx dt.$$

Since,

$$|\partial_t \bar{\Lambda}(s, x, \bar{u}(t))\beta(t-h)| \leq ||\beta||_{\infty} |\bar{u}(t, x) - a|h(s, x)|$$

is an integrable function, the properties of the point of Lebesgue (Steklov average) yields

$$\int_{I_{1}\times\Omega} \frac{\bar{\Lambda}(t-h,x,\bar{u}(t)) - \bar{\Lambda}(t,x,\bar{u}(t))}{h} \beta(t-h) dx dt \xrightarrow{}_{h} - \int_{I_{1}\times\Omega} \partial_{t}\bar{\Lambda}(t,x,\bar{u}(t)) \beta(t) dx dt$$

$$= -\int_{\Omega} \partial_{t}\Lambda(t,x,u(t)) \beta(t) dx dt.$$

Since the same holds for  $\lim_{h} \int\limits_{I_1 \times \Omega} \frac{\bar{\Lambda}(t,x,\bar{u}(t)) - \bar{\Lambda}(t+h,x,\bar{u}(t))}{h} \beta(t+h) dx dt, \ \forall \beta \in D^+([0,T]),$ 

$$\int_{0}^{T} \langle \partial_{t}u, \Psi(\cdot, u) \rangle \beta dt$$

$$= \int_{\Omega} [\Lambda(T, \cdot, u(T))\beta(T) - \Lambda(0, \cdot, u_{0})\beta(0)] dx - \int_{0} [\Lambda(\cdot, \cdot, u)\beta' + \partial_{t}\Lambda(\cdot, \cdot, u)\beta] dx dt.$$

Since  $\beta$  is involved in linear integral terms, a classical argument of regularization yields the result for any non-negative elements of  $W^{1,\infty}$ , then for any elements of  $W^{1,\infty}$ .

Note that T being arbitrary, the result holds for any t and s = 0, then for any t and s by subtracting the integral from 0 to s to the one from 0 to t.

Remark 4.4. As a consequence,

$$\frac{d}{dt}\left[\int\limits_{\Omega}\Lambda(t,x,u)dx\right]=\langle\partial_{t}u,\Psi(t,x,u)\rangle+\int\limits_{\Omega}\partial_{t}\Lambda(t,x,u)dx\ in\ \mathcal{D}'(0,T)$$

and  $t \mapsto \int_{\Omega} \Lambda(t, x, u) dx$  is absolutely-continuous in [0, T].

**Corollary 4.5.** Consider  $u \in L^p(0, T; W^{1,p}(\Omega)) \cap L^{\infty}(0, T; L^2(\Omega))$  such that  $\partial_t u \in L^{p'}(0, T; V')$ ,  $\alpha \in L^2(\Omega)$ ,  $\alpha \geq 0$  and  $\Psi : \mathbb{R} \to \mathbb{R}$  a given non-decreasing function. Assume that  $\Psi(u)\alpha \in L^p(0, T; V)$ , then, for any  $\beta \in W^{1,\infty}(0, T)$  and any  $0 \leq s < t \leq T$ ,

$$\int_{s}^{t} \langle \partial_{t}u, \Psi(u)\alpha \rangle \beta d\sigma = -\int_{s}^{t} \int_{\Omega} \int_{a}^{u} \Psi(\tau) d\tau \alpha \beta' dx d\sigma + \int_{\Omega} \int_{a}^{u(t)} \Psi(\tau) d\tau \alpha \beta(t) dx - \int_{\Omega} \int_{a}^{u(s)} \Psi(\tau) d\tau \alpha \beta(s) dx,$$

where a is any arbitrary real number.

**Remark 4.6.** Note that, by linearity, the same result holds if  $\alpha = \alpha_1 - \alpha_2$  with  $\Psi(u)\alpha_i \in L^p(0, T; V)$  (i = 1, 2) or if  $\Psi = \Psi_1 - \Psi_2$  and  $\Psi_i$  (i = 1, 2) satisfies the assumptions.

# Strong continuity in $L^2(\Omega)$

We consider the following notations in the sequel:  $V(\Omega) = W^{1,p}(\Omega) \cap L^2(\Omega)$ ,  $V_0(\Omega) = W_0^{1,p}(\Omega) \cap L^2(\Omega)$  and  $V'(\Omega) = W^{-1,p'}(\Omega) + L^2(\Omega).$ 

Let us prove in this section the following result of continuity.

**Lemma 4.7.** Let  $\Omega \subset \mathbb{R}^N$  be a bounded domain with Lipschitz boundary  $\partial \Omega$ , then we have

$$u \in L^{p}(0, T; V(\Omega)), \, \partial_{t}u \in L^{p'}(0, T; V'(\Omega)) \Rightarrow u \in C([0, T], L^{2}(\Omega)).$$

**Remark 4.8.** This result is not the usual one since u and  $\partial_t u$  are not in spaces being in duality relation and few words are needed concerning the time-derivative.

Note that both  $V(\Omega)$  and  $V_0(\Omega)$  are dense subspaces of the chosen pivot space  $L^2(\Omega)$  so that it can be identify to a subspace of  $V'(\Omega)$  or  $(V(\Omega))'$ . Therefore, u, as an element of  $L^p(0,T;V(\Omega)) \hookrightarrow L^p(0,T,L^2(\Omega)) \hookrightarrow$  $L^{p'}(0,T;V'(\Omega))$ , has a time derivative in the sense of distributions in  $\mathcal{D}'(0,T,V'(\Omega))$  and it is assumed to belong to  $L^{p'}(0, T; V'(\Omega))$ .

*Proof.* This result is based on a classical method: first in  $\mathbb{R}^N$ , then in the half-space  $\mathbb{R}^N_+$  and finally in  $\Omega$  thanks to an atlas of charts.

Obviously, if  $\Omega = \mathbb{R}^N$ , we have  $W_0^{1,p}(\mathbb{R}^N) = W^{1,p}(\mathbb{R}^N)$ , and the result holds by classical arguments (e.g. [25, Prop. 1.2 p. 106]).

If  $\Omega = \mathbb{R}^N_{+/resp.-} = \{(x', x_N) \in \mathbb{R}^N; x_N > 0/resp. < 0\}$ , the method is based on a suitable extension of u to  $\mathbb{R}^N$ . Following a recommendation of F. Murat, we consider the following extension, proposed in [16, (12.21-22) p.83] and revisited in [8, p.2]:

$$\tilde{u}(t,x',x_N) = \begin{cases} u(t,x',x_N); & x_N > 0 \\ -3u(t,x',-x_N) + 4u(t,x',-2x_N); & x_N < 0. \end{cases}$$

Note that  $\tilde{u} \in L^p(0, T; V(\mathbb{R}^N))$  and, thanks to a change of variables, that for any  $\varphi \in \mathcal{C}^\infty_c(]0, T[\times \mathbb{R}^N)$ , one gets

$$\int\limits_{(0,T)\times\mathbb{R}^N} \tilde{u}\partial_t\varphi\,dxdt$$

$$=\int\limits_{(0,T)\times\mathbb{R}^N_-} [-3u(t,x',-x_N)+4u(t,x',-2x_N)]\partial_t\varphi(t,x',x_N)\,dxdt+\int\limits_{(0,T)\times\mathbb{R}^N_+} u\partial_t\varphi\,dxdt$$

$$=\int\limits_{(0,T)\times\mathbb{R}^N_+} (\partial_t(\varphi(t,x',x_N)-3\varphi(t,x',-x_N)+2\varphi(t,x',-\frac{x_N}{2}))u(t,x,x_N)\,dxdt$$

Then

$$\int_{0}^{T} \int_{\mathbb{R}^{N}} \tilde{u}(t,x) \partial_{t} \varphi(t,x) dx dt$$

$$= \int_{0}^{T} \int_{\mathbb{R}^{N}} (\partial_{t}(\varphi(t,x',x_{N}) - 3\varphi(t,x',-x_{N}) + 2\varphi(t,x',-\frac{x_{N}}{2})) u(t,x,x_{N}) dx dt.$$

By construction,  $\psi(t,x) = \varphi(t,x',x_N) - 3\varphi(t,x',-x_N) + 2\varphi(t,x',-\frac{x_N}{2}) = 0$  if  $x_N = 0$ , as well as  $\partial_t \psi$ , and  $\psi \in W^{1,\infty}(0,T;V_0(\mathbb{R}^N_+))$  with  $\|\psi\|_{L^p(0,T;V_0(\mathbb{R}^N_+))} \le C\|\varphi\|_{L^p(0,T;V(\mathbb{R}^N))}$  for a given constant C.

Therefore,  $|\int\limits_{0}^{t}\int\limits_{-\mathbb{T}} \tilde{u}\partial_{t}\varphi dxdt| \leq C\|\partial_{t}u\|_{L^{p'}(0,T;V'(\mathbb{R}^{N}_{+}))}\|\varphi\|_{L^{p}(0,T;V(\mathbb{R}^{N}))}$ , and  $\partial_{t}\tilde{u}\in L^{p'}(0,T;V'(\mathbb{R}^{N}))$ . Then, one

concludes that  $\tilde{u} \in C([0, T], L^2(\mathbb{R}^N))$  i.e.  $u \in C([0, T], L^2(\mathbb{R}^N_+))$ .

Finally, the result holds in the general case by considering an atlas of charts as proposed e.g. in [8, p.3].
