1. Network definition

A biochemical reaction network is defined by

- Species: A finite set $S = \{S_1, \dots, S_d\}$ of $d \ge 1$ species.
- **Reaction**: A finite set $\mathcal{R} = \{R^1, \dots, R^n\}$ of $n \ge 1$ relation between linear combination of species, that is

$$R_i: \sum_{j=1}^d \alpha_j^i S_j \to \sum_{j=1}^d \beta_j^i S_j.$$

where α_j^i, β_j^i are non-negative integers and called respectively reactant and product stoichiometric coefficients for reaction *i* and species *j*. The set of reactions defines a directed graph between linear combination of species (called "complexes" in the reaction network community).

2. Deterministic mass-action model

A deterministic mass-action dynamic model associated to the biochemical reaction network (S, \mathcal{R}) is given by the set of ordinary differential equations

$$\frac{dx_j}{dt} = \sum_{i=1}^n \left(\beta_j^i - \alpha_j^i\right) k_i \prod_{l=1}^d x_l^{\alpha_l^i}, \quad j = 1, 2, \cdots, d,$$
(1)

and a set initial conditions $x_j(0) \in \mathbb{R}_+$, j = 1..d. The law of mass-action assumes that the rate of reaction R^i is proportional to the concentration of its reactants to the power of their stoichiometry. The constant k_i is called the rate constant of reaction R^i .

3. Stochastic mass-action model

A stochastic mass-action dynamic model associated to the biochemical reaction network (S, \mathcal{R}) is given by a continuous-time Markov chain, with transitions

$$(X_1, X_2, \cdots, X_d) \to (X_1 + \beta_1^i - \alpha_1^i, X_2 + \beta_2^i - \alpha_2^i, \cdots, X_d + \beta_d^i - \alpha_d^i), i = 1, \cdots, n, \quad (2)$$

occurring at rates $\kappa_i \prod_{j=1}^d {X_j \choose \alpha_j^i}$, and with initial conditions $X_j(0) \in \mathbb{N}_+$, j = 1..d. The stochastic law of mass-action assumes that the rate of reaction R^i is proportional to the number of possible combination of its reactants. The constant k_i is called the rate constant of reaction R^i .

4. Observation model

An observation model is a function h that links the kinetic variable x to the data y, with possible additional measurement parameters and taken into account some noise term ε

$$y = h(x,\varepsilon). \tag{3}$$

Additive noise model can be re-written as

$$y = h(x) + \varepsilon, \tag{4}$$

while multiplicative noise model can be re-written as

$$y = h(x)\varepsilon. (5)$$

5. Modeling β -arrestin recruitment kinetics at the FSH receptor

5.1. Topological model. The species list is given by

$$\mathcal{S} = \{FSH, FSHR, FSHFSHR, \beta arrestin, FSHFSHR\beta arrestin\}.$$
(6)

The reaction list together with its rate constants are given by

- $FSH + FSHR \xrightarrow{k_{on}} FSHFSHR$
- $\beta arrestin + FSHFSHR \xrightarrow{k^+} FSHFSHR\beta arrestin$
- $FSHFSHR\beta arrestin \xrightarrow{k^{-}} \emptyset$

5.2. Dynamic model and experimental conditions. After taking care of each experimental conditions (see main text), we obtain the full dynamic model that includes 7 experiments (state variables are indexed by a label $i = 1, \dots, 7$ for each different doses) together with the

$$\frac{d}{dt}FSH_i = -k_{on}FSH_i \cdot FSHR_i + k_{off}FSHFSHR_i, \qquad t \ge 0$$

$$\frac{d}{dt}FSHR_i = -k_{on}FSH_i \cdot FSHR_i + k_{off}FSHFSHR_i, \qquad t \ge 0$$

$$\frac{d}{dt}FSHFSHR_i = k_{on}FSH_i \cdot FSHR_i - k_{off}FSHFSHR_i - k^+\beta arrestin_i \cdot FSHFSHR_i, \quad t \ge 0$$

$$\frac{d}{dt}\beta arrestin_i = -k^+\beta arrestin_i \cdot FSHFSHR_i, \qquad t \ge 0$$

$$\begin{split} \frac{d}{dt}FSHFSHR\beta arrestin_i &= k^+\beta arrestin_i \cdot FSHFSHR_i - k^-FSHFSHR\beta arrestin_i, \qquad t \geq 0 \\ FSH_i(t=0) &= Init_FSH_i, \\ FSHR_i(t=0) &= Init_FSHR, \\ FSHFSHR_i(t=0) &= 0, \\ \beta arrestin_i(t=0) &= Init_\beta arrestin, \\ FSHFSHR\beta arrestin_i(t=0) &= 0, \end{split}$$

$$Induced_BRET_i(t) = kf \cdot FSHFSHR\beta arrestin_i(t) + \varepsilon_t, \qquad t \ge 0$$

(7) where ε_t is a collection of independent Gaussian random variable of zero mean and variance σ^2 , and the initial quantities for FSH are given by

$$(Init_FSH_i)_{i=1,\cdots,7} = (0.0128, 0.064, 0.32, 1.6, 8, 40, 200) \, 10^{-9} M \,. \tag{8}$$

5.3. **Parameterization.** To improve parameter optimization, we use an adimentionalized system and parameters, namely we define

$$x_1^i(t) = \frac{FSH_i(t)}{Init_FSHR}, \qquad t \ge 0$$

$$x_2^i(t) = \frac{FSHR_i(t)}{Init_FSHR}, \qquad t \ge 0$$

$$x_{3}^{i}(t) = \frac{FSHFSHR_{i}(t)}{Init_FSHR}, \qquad t \ge 0$$

$$\beta arrestin_{i}(t)$$

$$x_{4}^{i}(t) = \frac{\beta arrestin_{i}(t)}{Init_FSHR}, \qquad t \ge 0$$

$$\begin{aligned} x_5^i(t) &= \frac{FSHFSHR\beta arrestin_i(t)}{Init_FSHR}, \quad t \ge 0\\ \overline{k}_{on} &= \frac{k_{on}Init_FSHR}{k^-}, \end{aligned}$$

$$\overline{k}_{off} = \frac{k_{off}}{k^{-}},$$

$$\overline{k}^{+} = \frac{k^{+}Init_FSHR}{k^{-}},$$

$$Init_x_{1}^{i} = \frac{Init_FSH_{i}}{Init_FSHR},$$

$$Init_x_{4} = \frac{Init_\beta arrestin}{Init_FSHR},$$

$$\overline{k_{4}} = k_{1} = k_{2} = k_{3} = k_{4} = k_{5} = 0$$

$$\overline{kf} = kf \cdot Init_FSHR, \qquad t \ge 0$$

and we replace the system (7) by

$$\frac{d}{dt}x_1^i = -\overline{k}_{on}k^-x_1^i \cdot x_2^i + \overline{k}_{off}k^-x_3^i, \qquad t \ge 0$$

$$\begin{aligned} \frac{d}{dt}x_2^i &= -\overline{k}_{on}k^-x_1^i \cdot x_2^i + \overline{k}_{off}k^-x_3^i, \qquad t \ge 0\\ \frac{d}{dt}x_3^i &= \overline{k}_{on}k^-x_1^i \cdot x_2^i - \overline{k}_{off}k^-x_3^i - \overline{k}^+k^-x_4^i \cdot x_3^i, \quad t \ge 0\\ \frac{d}{dt}x_4^i &= -\overline{k}^+k^-x_4^i \cdot x_3^i, \qquad t \ge 0 \end{aligned}$$

$$\frac{d}{dt}x_{4}^{i} = -k^{-}k^{-}x_{4}^{i}\cdot x_{3}^{i}, \qquad t \ge 0$$

$$\frac{d}{dt}x_{5}^{i} = \overline{k}^{+}k^{-}x_{4}^{i}\cdot x_{3}^{i} - k^{-}x_{5}^{i}, \qquad t \ge 0$$

$$\begin{aligned} x_{1}^{i}(t=0) &= Init_x_{1}^{i}, \\ x_{2}^{i}(t=0) &= 1, \\ x_{3}^{i}(t=0) &= 0, \\ x_{4}^{i}(t=0) &= Init_x_{4}, \\ x_{5}^{i}(t=0) &= 0, \\ Induced_BRET_{i}(t) &= \overline{kf} \cdot x_{5}^{i}(t) + \varepsilon_{t}, \end{aligned}$$

Thus, to perform data fitting, we actually simulate the system (10). For the optimization algorithm, we further transform the parameter in log scale, so that we search for the parameter set

$$\theta = \left(\log_{10}(\overline{k}_{on}), \log_{10}(\overline{k}_{off}), \log_{10}(\overline{k}^+), \log_{10}(k^-), \log_{10}(Init_FSHR), \log_{10}(Init_x_4), \log_{10}(\overline{kf}), \log_{10}(\sigma)\right)$$
(11)

5.4. **Parameter ranges for numerical optimization.** To start multi-run deterministic optimizations (using D2D), we used uniform distributions with following ranges to search for the optimal parameter sets (in \log_{10} scale):

5.5. **Objective function.** To search for best parameter sets, we minimize the -2log(L), where L is the likelihood function according to the error measurement model. Thus, we are lead to minimize

$$J(\theta) = \sum_{k=1}^{n_t} \sum_{i=1}^{7} \log(2\pi\sigma^2) + \left(\frac{d_{i,k} - Induced_BRET_i(t_k)}{\sigma}\right)^2,$$
(13)

where we denoted by $d_{i,k}$ the measured induced BRET signal for experiment i at time t_k .

6. Example of over parameterization

We show in a slightly different model a concrete case of over parameterization. The following model is an example of catalysis signaling cascade, where the complex Ligand-Receptor catalyse the activation of a downstream molecule (like cAMP for instance). We take as species list

$$S = \{x_1, x_2, x_3, x_4, x_5\}.$$
(14)

The reaction list together with its rate constants are given by

•
$$x_1 + x_2 \xrightarrow{k_{on}} x_3$$

• $x_3 + x_4 \xrightarrow{k^+} x_3 + x_5$
• $x_5 \xrightarrow{k^-} \emptyset$

Suppose as in the BRET measurement technique that one observes the activated molecule x_5 , up to an unknown constant kf. Thus, the dynamic model together with the observation model

is given by (note the close similarity with the system (7)):

$$\begin{aligned} \frac{d}{dt}x_{1} &= -k_{on}x_{1} \cdot x_{2} + k_{off}x_{3}, \quad t \ge 0 \\ \frac{d}{dt}x_{2} &= -k_{on}x_{1} \cdot x_{2} + k_{off}x_{3}, \quad t \ge 0 \\ \frac{d}{dt}x_{3} &= k_{on}x_{1} \cdot x_{2} - k_{off}x_{3}, \quad t \ge 0 \\ \frac{d}{dt}x_{4} &= -k^{+}x_{4} \cdot x_{3}, \qquad t \ge 0 \\ \frac{d}{dt}x_{5} &= k^{+}x_{4} \cdot x_{3} - k^{-}x_{5}, \qquad t \ge 0 \\ x_{1}(t=0) &= Init_x_{1}, \qquad (15) \\ x_{2}(t=0) &= Init_x_{2}, \\ x_{3}(t=0) &= 0, \\ x_{4}(t=0) &= Init_x_{4}, \\ x_{5}(t=0) &= 0, \\ Induced_BRET(t) &= kf \cdot x_{5}(t) + \varepsilon_{t}, \qquad t \ge 0. \end{aligned}$$

In the system (15), a structural identifiability analysis reveals that the parameters $(Init_x_4, kf)$ are not identifiable, and actually only the product $Init_x_4 \cdot kf$ can be identified. In this example, this fact can actually be shown doing an adimentionalization step, normalizing the variables x_4 and x_5 by $Init_x_4$.
