- $\mathbf{7_{Q3}}$ Membranes show a tremendous variety of lipids and proteins
- 8 operating biochemistry, transport and signalling. The dynamics
- 9 and the organization of membrane constituents are regulated in
- ¹⁰ space and time to execute precise functions. Our
- understanding of the molecular mechanisms that shape and govern membrane subcompartmentalization and inter-
- 13 organelle contact sites still remains limited. Here, we review
- some reported mechanisms implicated in regulating plant
- 15 membrane domains including those of plasma membrane,
- plastids, mitochondria and endoplasmic reticulum. Finally, we
- discuss several state-of-the-art methods that allow nowadays
- researchers to decipher the architecture of these structures at
- 19 the molecular and atomic level.

32 Introduction

- Spatiotemporal organization of the cellular biomolecules is critical to coordinate the numerous activities simultaneously carried out by cells. Biological membranes delimit cells and organelles and constitute specialized subunits that are constantly reshaped to adapt to everchanging environmental conditions and to operate cell functions effectively (Special issue on cell biology edited
- 40 by Ref. [1]). Cell membranes are composed of a specific

phosphoinositide lipids and small GTPases proteins are major contributors to endosome identity [2,3]. A tremendous body of evidence shows that the motion and the organization of membrane constituents are dynamically regulated on the level of the membrane to form functional domains and this conversely throughout the tree of life [4^{••},5,6]. Thus, it appears that membrane subcompartmentalization into domains is universal and may represent an essential characteristic. Taking into account the knowledge acquired in various model organisms and model systems over the past decades, membrane domains can be defined as membrane regions in which the local composition, lateral organization, and/or dynamics differ in some way from the average membrane properties [7-9]. Such local specificity is dictated by preferential intermolecular interactions, including intra-membrane interactions (i.e lipid–protein, lipid–lipid and protein–protein) and associations with structures peripheral to the membrane for example cortical cytoskeleton and the cell wall in the case of plasma membrane. This also leads to the formation of inter-membrane interaction through Membrane Contact Sites (MCS), important functional platforms for the exchange of lipids and signalling proteins [10,11], see Figure 1. Yet, membranes being constituted of several thousands of molecules surrounded by variable and complex environments, a tremendous mechanistic complexity remains to be uncovered. Here, we review some described mechanisms regulating membrane architecture in plants and discuss recent technological advancements allowing researchers to study membrane

organization with molecular and atomic resolution.

Plasma membrane domains

The plasma membrane (PM) is the outermost boundary 76 of the cell, acting as a communication headquarter inte-77 grating signal from the environment to the cell interior 78 and *vice-versa*. The PM is asymmetric, as exemplified by 79 the enrichment of sphingolipids in the outer leaflet and 80 phospholipids in the inner leaflet [12,13]. The PM associ-81 ates with the cortical cytoskeleton network and the cell 82 wall creating a continuum at the cell surface [14]. PM 83 establishes MCS with organelles, notably with ER at the 84 level of PD, see Figures 1a and 2. The lipid and protein 85 composition of the domains formed at these MCS is very 86

specific [11]. Organization of the PM can be rationalized 87 into two types: microdomains and nanodomains. 88 Microdomains are site-specific enrichment of membrane 89 compounds at the cellular level usually referred to as polar 90 domains that control localized cell activities. Nanodo-91 mains represent submicrometric heterogeneity of the 92 PM whose visualization often requires the use of high 93 or superresolution microscopy techniques [15,9]. Nano-94 domains have been proposed to act as dedicated platforms 95 regulating cell signalling notably [4^{••},16^{••},9,17[•],15]. 96 Mechanisms regulating the organization of PM domains 97 being recently reviewed [9,15,13,18–22], we present here 98 only three case studies to illustrate the molecular mecha-99 nisms at play in the organization and dynamics of PM 100 domains. 101

REMORINs are plant-specific proteins regulating notably 102 immunity [23-26], symbiosis [27,28,29[•]] and development 103 104 [30] possibly by modulating nanodomain-associated complexes [16^{••},31,32,17[•],29[•]]. REMORINs predominantly 105 associate with the PM [33,23,31,34,35]. In addition, isoforms 106 from group 1 and group 6 REMORINs have been shown to 107 be associated with plasmodesmata (PD) in Rice and in 108 Solanaceae [23,36,30,31]. Electron microscopy immuno-109 localization, stimulated emission depletion microscopy 110 (STED) and photoactivated localization microscopy 111 (PALM) studies showed group 1 REMORINs are organized 112 into nanodomains of about 70-90 nm in diameter that are 113 sensitive to sterol composition [23,37,16**] and cytoskeleton 114 115 integrity [38]. Molecular mechanisms at the basis of REMORIN domain organization are being discovered: 116 REMORINs are targeted from the cytosol to the cytosolic 117 leaflet of the PM via a short unconventional sequence at the 118 extremity of the C-terminus of the protein, called REM-CA 119 (REMORIN C-terminal Anchor) [39,34,40], see Figures 1b 120 and 2; REM-CA undergoes conformational changes upon 121 binding of conserved positively charged residues to phos-122 phoinositides and provides to REMORINs biochemical 123 properties indistinguishable from integral proteins 124 [23,39,16**]; REM-CA-sterol-phosphoinositide interactions 125 are required for Group 1 REMORINs supra-molecular 126 organization into functional domains involved in plant 127 response to the Potato Virus X (PVX). Numerous REMOR-128 129 INs present cysteine residues that can be S-acylated [41,34,42,43]. While S-acylation of Arabidopsis REMORINS 130 seems to regulate PM affinity but not primarily nanodomain 131 organization [34], the substitution of an S-acylated cysteine 132 of Nicotiana benthamiana REM alters nanodomain organiza-133 tion [43], suggesting functional divergence of REMORIN 134 S-acylation. Oligomerization of group 1 REMORINs into 135 homotrimers is required for PM localization [39,44], suggest-136 ing that REMORINs' self-assembly constitute an early step 137 of PM targeting. Furthermore, REMORIN organization 138 seems regulated by intermolecular protein association. 139 Indeed, in Medicago, FLOT4 scaffolds SYMBIOTIC 140 REM1 to recruit the Nod factor co-receptor LYSINE 141 MOTIF KINASE 3 (LYK3) to specific nanodomains 142

controlling root hair infection by Sinorhizobium meliloti and 143 the establishment of symbiosis [29[•]]. Interaction of 144 AtREM1.3 with AtHIR1 in Arabidopsis suggests that 145 association of SPFH (Stomatin, Prohibitin, Flotillin, 146 HflK/C) proteins with REMORINs may represent a con-147 served core module shaping PM organization [45]. Finally, 148 phosphorylation of group 1 REMORINs upon infection of 149 N. benthamiana by the PVX modulates REM1.3 organization and function [31], probably through the modulation of 150 protein-protein interactions. Thus the genesis and regula-151 tion of REMORIN nanodomains appear to rely on several 152 molecular mechanisms such as post-translational modifica-153 tions, and protein-lipid and protein-protein interactions. 154

Rho of Plants (ROPs) are the plant-specific subfamily of 155 Rho/Rac small GTP binding proteins, regulating numerous 156 cellular processes such as signalling, trafficking and cytoskel-157 eton dynamics [46,47]. Reversible switch from a GDP-158 bound state to a GTP-bound state mediated by ROP-GEFs 159 and ROP-GAPs regulates ROPs activity [48]. Polarization of 160 the growth machinery to a predefined root hair initiation 161 domain (RHID) pledges root hair formation in trichoblast 162 cells. ROP2, 4 and 6, are recruited to the RHID before any 163 detectable cell bulging and serve as a landmark for the 164 recruitment of downstream effectors [49,50°]. Strikingly, 165 guanine nucleotide exchange factor 3 (GEF3) defines the 166 RHID by guiding ROPs polarization via direct protein-167 protein binding [50[•]]. At the bulging stage, phosphatidyli-168 nositol-4-phosphate 5-kinase 3 (PIP5K3), the AGCVIII 169 kinase D6 PROTEIN KINASE (D6PK) and sterol 170 composition modulate ROPs association to the RHID 171 [51,52]. Here, co-regulation of ROP, phosphoinositides 172 and phosphoinositide kinases has been proposed to form a 173 self-organizing system amplifying ROP recruitment and 174 activation [3]. In addition, ROPs associate with the PM 175 via post-translational lipid modifications and direct interaction with membrane lipids mediated by the carboxy-176 terminal tail [53,47,4^{••}]. For example, ROP6 interacts with 177 phosphatidylserine (PS) via its polybasic tail, a process likely 178 at the basis of nanodomain organization. Recently, using live 179 superresolution microscopy, Platre et al. elegantly showed 180 that variation in PS level during root development stabilized 181 ROP6 into nanodomains to regulate auxin signaling [4^{••}]. In 182 metaxylem vessel cells, ROP-GEF4 locally activate ROP11 183 to recruit MICROTUBULE DEPLETION DOMAIN 184 1 scaffold protein which in turn recruits microtubule-185 depolymerizing kinesin-13A enabling the formation of pits 186 in secondary cell walls [54,55]. IQD13 associates with corti-187 cal microtubules (cMTs) and the PM to laterally restrict the 188 localization of ROP GTPase domains, establishing a lateral 189 fence for ROP GTPase [56]. In contrary, CORTICAL 190 MICROTUBULE DISORDERING1-induced disorgani-191 zation of cortical microtubules impairs the boundaries of PM 192 domains of active ROP11 GTPase [57]. 193

Cellulose microfibers are synthesized by the PM- 194 embedded cellulose synthase (CESA) complexes (CSCs) 195

which are composed of 18-36 cellulose synthase subunits 196 [58]. Cortical microtubules recruit CESA-containing vesi-197 cles and guide the trajectory of CSCs at the PM [59-61]. In 198 addition, S-acylation of CESAs influences its immediate 199 membrane environment and conditions their location to 200 the PM [62]. CSCs are tethered to cortical microtubules via 201 two integral components, CELLULOSE SYNTHASE 202 INTERACTING 1 [63–65] which determines the trajec-203 tory of CSCs along the cMTs [59] and COMPANION OF 204 CELLULOSE SYNTHASE 1 (CC1), which sustains cel-205 lulose synthesis by promoting the formation of a stress-206

tolerant microtubule array during salt stress [66].

These examples emphasized that regulation of plasma membrane subcompartmentalization is regulated as part of developmental program, is modulated to respond to

environmental clues, relies on the cooperation of multiple

factors and is fundamental for function.

213 Chloroplastic membrane domains

Chloroplasts are organelles composed of a double mem-214 brane envelope and thylakoids found in plant cells and 215 algae that conduct photosynthesis. Little is known about 216 how the photosynthetic membrane machinery is arranged 217 in time and space. Microscopy and biophysical shreds of 218 evidence showed the coexistence of domains where lipids 219 are organized in lamellar or hexagonal phases. For exam-220 ple, hexagonal phases have been described in etioplasts of 221 prolamellar bodies or during the transfer of lipids between 222 223 the envelope and thylakoids, such hexagonal phase domains may be of importance for localizing metabolic 224 activities, for example the violaxanthine-epoxidase in 225 thylakoid domains [67]. 226

Biochemical, 3D reconstruction, in vivo spectroscopy and 227 immunolocalization data, reveal that thylakoids display a 228 heterogeneous subcompartmentalization of photosyn-229 thetic complexes in domains which redistribute during 230 state transitions in *Chlamydomonas* [68] and diatoms [69], 231 see Figure 1c. These domains are interconnected, ensur-232 ing fast equilibration of electron carriers for efficient and 233 optimal photosynthesis. Underlying molecular events at 234 the basis of thylakoid subcompartmentalization remain 235 unclear. Thylakoids possess a special fatty acid namely 236 trans- Δ 3-hexadecenoic acid (trans-16:1) esterified in 237 phosphatidylglycerol (PG) which may play a role in 238 cementing thylakoids during granum formation and con-239 trol of light reactions of photosynthesis [70]. Recent 3D 240 241 cryo-electron tomography showed the thylakoid network of cyanobacteria is organized in domains and forms a 242 synapse-like MCS decorated by ribosomes (but not by 243 phycobilisomes) in tight association with the PM of 244 cyanobacteria. This MCS was named the 'thylapse', for 245 'thyl(akoid syn)apse', and likely serves for compartmen-246 talization of the different functions of the thylakoids that 247 photosynthesis or protein synthesis [71^{••}], see is 248 Figure 1d. Because PM of cyanobacteria represents the 249

inner membrane of eukaryotic plastids, thylapses most 250 likely also exist in higher plants. 251

Chloroplast envelope establishes numerous MCS with other 252 organelles [10]. For example, plastid and mitochondrion 253 envelopes establish membrane connection during phos-254 phate deprivation. The molecular content of this MCS 255 has been recently identified by biochemical and proteomic 256 approaches and showed a big complex of hundred proteins 257 enriched in specific lipids. AtMic60, a conserved protein of 258 the mitochondria inner membrane, plays a crucial role in the 259 lipid transport process by regulating the proximity between 260 mitochondrial membranes via its interaction with the outer 261 membrane protein Tom40 and by destabilizing membranes, 262 likely to promote lipid desorption [72^{••}]. Plastids can also 263 undergo drastic changes in shape under stress, through 264 specialized protrusive membrane domains called stromules 265 (stroma-filled tubules, see Figure 1a) which link plastid 266 envelope with other organelles such as ER, Golgi and 267 nucleus [73,74]. The molecular mechanisms governing stro-268 mule formation are not established, but the involvement of 269 cytoskeleton motors has been proposed [75]. Similarly, 270 peroxules, peroxisomal protrusions tethering chloroplasts 271 or mitochondria through specialized membrane microdo-272 mains have been evidenced [76,77]. Peroxules also for 273 example link with lipid droplets, see section 'Endoplasmic 274 reticulum domains'. These studies reveal the importance of 275 physical connections through plant membrane domains for 276 establishing complex metabolic pathways. 277

Mitochondrial membrane domains

Mitochondria are double-membrane-bound organelles. 279 The outer mitochondrial membrane encloses the entire 280 organelle and can be in contact with other organelles for 281 example during phosphate starvation, see above [10]. The 282 inner membrane separates the mitochondrial matrix from 283 the intermembrane space. The structure of the inner 284 mitochondrial membrane is extensively folded. These 285 invaginations are separated from the inner membrane 286 by dynamin proteins to form three domains namely, 287 the inner boundary membrane, the cristae junctions 288 and the cristae membranes [78], see Figure 1e. The latter 289 contains enzymes of the mitochondrial respiratory chain 290 that, instead of being dispersed in the membrane, are 291 organized into a functional supramolecular respiratory 292 domain called respirasome, see Figure 1. ATP synthase 293 dimers sit at the edge of the cristae. Mitochondria inner 294 membrane is rich in cardiolipin (CL), a key phospholipid 295 playing important roles in maintaining the functional 296 integrity and dynamics of mitochondria. Arabidopsis 297 CL localizes to mitochondria and is enriched at specific 298 domains and CARDIOLIPIN SYNTHASE targets to the 299 inner membrane of mitochondria with its C-terminus in 300 the intermembrane space [79]. Mitochondria of cls 301 mutants exhibit altered structural integrity and morpho-302 genesis. In contrast to animal and yeast, plant CL plays a 303 dominant role in mitochondrial fission and exerts this 304

function through stabilizing the protein complex of 305 DYNAMIN-RELATED PROTEIN3 [79]. In addition, 306 CL induces membrane invaginations which are stabilized 307 by dimers of ATP synthase. In reconstituted systems, 308 bovine ATP synthase is sufficient to deform a lipid 309 bilayer, which is likely the driving force triggering cristae 310 curvature [80]. Recently, dimers of mitochondrial ATP 311 synthase from the green algae *Polytomella* were shown to 312 be required for cristae formation and constitute the main 313 factor in mitochondrial morphogenesis to induce mem-314 brane curvature and self-assembly into rows [81[•]]. Finally, 315 mitochondria-associated ER membrane (MAM) is 316 another structural element that is increasingly recognized 317 for its critical role in cellular physiology and homeostasis 318 of mitochondria [10]. 319

320 Endoplasmic reticulum domains

The endoplasmic reticulum forms a membrane network 321 virtually in contact with all cell organelles, see Figure 1a. 322 Thus, the ER is actively engaged in organizing mem-323 brane domains to perform various functions. For example, 324 ER is known to be organized into smooth and rough 325 domains, the latter being enriched in ribosomes involved 326 in protein production, protein folding, quality control and 327 dispatch. Formation of these domains is regulated by 328 syntaxin proteins [82]. Lipid droplets (LD) are lipid-rich 329 cellular organelles regulating storage and hydrolysis of 330 neutral lipids. LD biogenesis takes place at ER subdo-331 mains which are regulated by lipodystrophy proteins 332 called SEIPINs in human, yeast, and plants. SEIPINs 333 reorganize the normal, reticulated ER structure into 334 discrete ER domains that colocalize with LD. In plants, 335 SEIPINs modulate the number and sizes of LD [83[•],84]. 336 Recent work in plants showed that peroxisome exten-337 sions deliver the major TAG lipase Sugar-Dependent 1 338 (SDP1) to the LD. At early stages of seedling develop-339 ment, SDP1 localizes to a peroxisome membrane domain 340 and then possibly moves to the LD surface through 341 peroxisome tubulations [85]. This constitutes an interest-342 ing case of inter-organelle communication and protein 343 transport that is reminiscent of stromule. 344

In the next chapter, we will briefly describe state-of-the-art
 biophysical methods that have provided access to the
 structural basis membrane domain organization.

How to study the molecular mechanisms shaping biological membrane domains in plants?

Membrane subcompartmentalization is intimately linked 351 to the preferential association of membrane constituents. 352 Therefore, establishing the structure-function relationship 353 between the membrane subcompartment components is an 354 essential piece of the puzzle towards understanding the 355 complex interplay of the cells with the extracellular envi-356 ronment. Yet, the intrinsic soft matter state of membrane-357 related systems in their native environment, such as 358

peripheral or membrane-embedded proteins, hampers 359 the application of numerous techniques in structural biol-360 ogy to visualize molecular association at the atomic level. To 361 provide an overview on a promising route towards under-362 standing the molecular basis underlying membrane sub-363 compartmentalization, we can list tools such as X-ray, 364 crystallography and solution NMR [86-88]. The recent 365 developments of superresolution microscopy (eg. STED, 366 PALM), cryo-electron microscopy (EM) and tomography 367 methods allowed the study of the organization of proteins 368 and lipids and the characterization of membrane subcom-369 partmentalization and MCS [89**,16**,90*] with unpre-370 ceded resolution. The complementary biophysical tools 371 to investigate lipid/protein interactions such as Langmuir 372 monolayer, Fourier-Transform InfraRed spectroscopy 373 (FTIR), NMR or modelling are reviewed in [91,11,13]. 374 Figure 2a shows several examples of diverse contributions, 375 including solid-state nuclear magnetic resonance (ssNMR), 376 X-ray crystallography, modelling, FTIR, tomography by 377 EM and solution NMR. The development of lipid and 378 protein imagery by isotope-labeled high-resolution second-379 ary ion mass spectrometry (nano-SIMS) would allow the 380 study of molecular events at play in domain formation and 381 dynamics [92,93]. In plants, nano-SIMS was used to localize 382 elements such as manganese, arsenic, iron, zinc, and cad-383 mium at the nanoscale level [94], but this approach could 384 also be used for lipids and proteins in internal organelles. 385

Here, we further describe the powerful technique ssNMR 386 that emerges as a tool to understand domain assembly. 387 SsNMR is a versatile technology reporting on membrane 388 and protein structure, sensitive to dynamics and protein-389 lipid interactions. A major advantage relies in its application 390 on systems in the native bilayer environment, that is recon-301 stituted liposomes that can represent membranes of a chosen 392 lipid composition. The flowchart in Figure 2b illustrates the 393 overall procedure applied to inquire on the previously men-394 tioned aspects of membrane-associated proteins. Reporting 395 membrane biophysical and structural parameters are 396 achieved by well-established membrane-focused ssNMR, 397 mainly recorded on ²H and ³¹P nuclei [95,96]. The quad-398 rupolar ²H signal in static ssNMR encodes for the overall 399 lipid mobility and, importantly, the local dynamics along the 400 acyl chain. Upon varying the membrane components (lipid 401 composition, presence or absence of protein) and environ-402 ment (temperature, pH), ²H ssNMR reveals detailed 403 insights on phase, phase transitions, acyl chain dynamics 404 and membrane thickness and curvature depending on the 405 precise lipid composition and on the presence of a potential 406 interaction partner. The chemical shift of ³¹P nuclei comple-407 ments and corroborates the data reporting on phase behavior 408 and the impact of potential partner molecules on the lipid 409 head groups. Tackling membrane proteins is based on 410 Magic-Angle spinning (MAS) ssNMR, a method which 411 has seen tremendous advances in elucidating insoluble pro-412 tein structures, dynamics and interactions in soft matter 413 states such as assemblies, aggregates [97,98,99] or 414

- membrane-association [100**,101,102]. Since 2002, when the 415 first structure of a microcrystalline protein has been solved by 416 MAS ssNMR [103], the technology has proven very powerful 417 to elucidate protein assemblies such as the first amyloid 418 protein structure [104], bacterial filaments [105,106] and 419 protein-membrane complexes [107[•]]. A considerable knowl-420 edge has already been derived from ssNMR on protein-lipid, 421 lipid-lipid interactions and membrane dynamics and func-422 tioning [108-110,96,102]. Most recent technological devel-423
- opments achieving ultra-fast MAS frequencies (≥100 kHz) 424
- 425 MAS ssNMR allow for observing proton nuclei in protonated protein samples (\sim 500 µg) and should facilitate ssNMR to 426
- serve as a common tool for structural biology on membrane/ 427
- protein related questions. Because of its striking technologi-428
- cal evolution, MAS ssNMR has recently been applied in few 429
- cases to shed light on protein structures, dynamics and 430
- protein-lipid interactions promoted by lipid-dependent 431
- membrane features [100**]. Membrane domain formation 432
- 433 in plants, relying on the plant protein and lipid interplay (see
- below the example of REMORIN in PM [16^{••},44]) remains a 434
- 435 field to explore by MAS ssNMR.

Conclusions 436

Virtually all membranes are organized in functional 437 domains that coordinate cell functions. Recent break-438 through in biochemistry, biophysic and microscopy 439 approaches allow nowadays the study of the mechanisms 440 regulating the formation of membrane domains, particu-441 larly the interplay between lipids and proteins. The next 442 decade will likely open a vast area of research to under-443 stand the roles of membrane organization during plant 444 44505 development and adaptation.
