#### 7 Abstract

AQ1 Pendimoun rock-shelter is among the oldest Neolithic sites known on the French littoral (Impressa culture, since ca. 5700 BCE). It was discontinuously occupied from the Mesolithic to the end of the Neolithic. During the Neolithic, it was used for 10 pastoral purposes and domestic activities as well as for pottery production. Agriculture and cereal processing are clearly 11 attested during the Impressa occupation (grains, husk and straw macroremains, grindstones) and become more less obvious 12 in the overlying layers. Phytolith analysis concerned 1 Mesolithic sample (Sauveterrian culture) and 16 samples covering 13 most of the 6th millennium BCE (Impressa, Cardial, and transition to Early Square Mouthed Pottery-SMP cultures). Sig-14 nificant amounts of grass phytoliths and the scarcity of dicot phytoliths suggest that the livestock, whose dung constitutes 15 an important part of the sediment, mainly fed on wild grasses. Inflorescence bract phytoliths are well represented only in 16 the Impressa levels, confirming that cereals were partly processed in situ only during the earliest stages of the Neolithic. 17 Amounts of BILOBATE short cells proved to be higher than expected in an area where only a few panicoid species can grow. 18 The three candidates for BILOBATE phytolith producers (Setaria spp., Digitaria sanguinalis, Echinochloa crus-galli) all have 19 a short vegetation cycle that lies entirely between the end of spring and the beginning of autumn, suggesting that the shelter 20 was mainly used during that period. The low amount of inflorescence bract phytoliths (except during the Impressa) seems 21 to restrict that range to the period before the ears become mature, namely the end of spring or early summer.

#### <sup>23</sup> Introduction

24 Pendimoun is a very important site for understanding of 25 the Neolithic transition in the northwestern Mediterranean. 26 Farming economies, which spread throughout the Near-27 East and the Aegean, reached southern Italy shortly after 28 6000 BCE (Binder et al. 2017). The Neolithic innovations 29 were brought to the Western Mediterranean by groups of 30 pioneers belonging to the Impresso-cardial cultural complex 31 who arrived by sea from Italy. These groups settled close to 32 the littoral, while parts of the hinterlands were still occupied 33 by Late Mesolithic groups. These pioneer populations are

known thanks to a very small number of sites, scattered from Liguria in Italy to the south-eastern Languedoc in France. Pendimoun is one of these few key-sites documenting the very beginning of agro-pastoral economies in south-western Europe. With the spread of agriculture, questions arise concerning the ways prehistoric farmers exploited the territory and managed their resources. In particular, the mobility of the groups and the duration of the occupations, which seem to be linked to the kinds of activities carried out at the sites. remain difficult to assess accurately. Due to the scarcity of archaeological sites and to preservation hazards, plant and animal remains linked to human activities are rare. Therefore, as many as possible of the recovered remains need to be fully exploited and studies must extend beyond the most obvious macroremains. Phytolith analysis has proved to be an effective tool for obtaining reliable quantitative information concerning plant-related activities (and more specifically agriculture and farming), particularly in contexts where organic remains are poorly preserved or scarce (Harvey and Fuller 2005; Delhon et al. 2008; Cabanes et al. 2009;

Lancelotti et al. 2014). In our study, phytolith analysis of
Early Neolithic levels at Pendimoun shelter has been used
as a means, among others (there are several ongoing studies
concerning the same site which rely on a wide range of analytic approaches: see Binder et al. in press), of documenting
agro-pastoral activities.

#### 60 Archaeological background

Pendimoun is a rock-shelter located in south-eastern France, near the Italian border, just above the City of Menton (Fig. 1). Due to the steep topography, this can be considered to be both a coastal site (at less than 4 km from the sea as the crow flies) as well as a low mountain site (at an elevation of nearly 700 m). The site is currently on the ecotone between Meso- and Supramediterranean Vegetation Belts and the surrounding landscape is strongly characterized by pastoral exploitation. The site was first explored in the 1950s, and more recent excavations carried out by Didier Binder between 1985 and 2006 have revealed a discontinuous occupation from the Mesolithic to the end of the Neolithic. The southern and northern sectors of the site are separated by a trench inherited from the old excavation, which unfortunately hinders any strict correlation between the two stratigraphies (Binder et al. 1993).

The oldest archaeological level is attributed to the Sauveterrian Mesolithic culture of the 9th millennium BCE and it is notably represented by an infant burial. Around 80 cm above this level, the Neolithic sequence stretches over a thickness of ca. 200 cm and records occupations from the Impressa Neolithic (Early 6th millennium BCE) to the Bell Beaker cultural complex (Late 3rd millennium BCE). Despite the fact that the two sectors of the site are now disconnected, it appears that the Impressa deposits from the southern sector predate those from the northern sector. The sequence also includes several archaeological discontinuities due to periods of abandonment of the site and/or to erosion. The

identification of sheep bones and the composition of the 89 sediment, partly made up of mineralized dung and rich in 90 spherulites and ashes, indicate that the shelter was used 91 for pastoral purposes since the earliest Neolithic occupa-92 tion, but more intensively during the Chassey Neolithic 93 (Late fifth-Early fourth millennium) (Binder et al. 1993, in 94 press). Charcoal analysis has shown that the impact of pas-95 toral practices on the vegetation remained low until the end 96 of the fifth millennium but increased markedly during the 97 3rd millennium BCE. It also shows the exploitation of diverse 98 patches of a mosaic vegetation, probably linked to a staged 99 agro-sylvo-pastoral system based on the exploitation of the 100 resources from various altitudes (Battentier et al. 2015). 101 Several domestic activities also took place at the site, in 102 particular an abundant and distinctive production of ceramic 103 wares (Basso et al. 2006; Gomart et al. 2017). Numerous 104 hearths and waste from everyday life suggest that the shelter 105 was used as a dwelling by shepherd-potter groups. A set of 106 burials has also been discovered in the Cardial levels (Mid-107 6th millennium BCE) (Zemour et al. 2016). Agriculture is 108 attested since the earliest Neolithic by the presence of cereal 109 grains in the Impressa levels, which are amongst the oldest 110 in France (Binder et al. 1993; Guilaine et al. 2007), and 111 various tools linked with agricultural activities or with grain 112 processing, such as sickle blades or grindstones. Seashell 113 gathering is also attested during the 6th millennium BCE. 114

The stratigraphy is particularly detailed from the 6th to 115 the 5th millennia BCE (235 stratigraphic units grouped in 30 116 clusters). The present study focusses on this period, during 117 which the shelter was used for diverse activities, sometimes 118 successively and sometimes simultaneously. Phytolith analy-119 sis is part of a set of investigations implemented in order to 120 hone our understanding of the chrono-stratigraphy and of 121 the archaeological occupations. Despite the fact that ongo-122 ing studies have not as yet yielded all their results, the data 123 currently available already provide us with a good picture 124 not only of the activities carried out on the site but also of 125 some aspects of the socio-economical organization through 126 time (Binder et al. in press). Like most of these shelters and 127 caves used during the Neolithic in such contexts, Pendimoun 128 is considered to have been a seasonal settlement. The key 129 challenge facing us in terms of the Neolithic in general, and 130 this site in particular, is to understand the nature, periodicity 131 and rhythm of the seasonal occupations, and consequently to 132 understand the position of the site in the territory exploita-133 tion network. During the earliest Neolithic (Impressa), the 134 site was inhabited by a group of farmers (Rowley-Conwy 135 et al. 2013), who cultivated cereals and raised sheep. The 136 activities that took place on the site were diverse and also 137 included some hunting, gathering of plants (acorns) and 138 of seashells as well as the manufacture of ceramics; these 139 activities seem to have been conducted at different seasons 140 of the year, during long-lasting occupations of the shelter. 141

Afterwards, during the Cardial Neolithic, the shelter seems 142 to be used during briefer but repeated periods, although the 143 spectrum of activities remains globally the same (livestock 144 keeping, pottery production), with the noticeable exception 145 of the use of the shelter to bury the dead. The importance 146 of hunting in the economy is not clear, partly because of 147 difficulties in the identification of Suideae (wild boar vs. 148 domestic pig). During the transition phase to the Square 149 Mouthed Pottery (SMP) culture, the shelter was used for 150 the penning of herds, but also for various other domestic and 151 craft activities, which suggest long-lasting occupations. A 152 hiatus of several centuries isolates the first SMP settlement 153 from the rest of the Neolithic sequence, which exhibits an 154 increasing specialization of the site towards pastoral activi-155 ties: during the Middle Neolithic, the occupation is typical 156 of the grottes-bergeries (sheepfold caves) known elsewhere 157 in the Alps and the northwestern Mediterranean area dur-158 ing that period (Delhon et al. 2008; Angelucci et al. 2009; 159 Martin et al. 2011 and references therein); afterwards, dur-160 ing the Bell Beaker period, the pastoral economy switches 161 to rearing cattle rather than small ruminants (Binder et al. 162 1993). Because Pendimoun is a reference site for the first 163 stage of the Neolithic in the area and because the following 164 levels (from mid-fifth to the end of 3rd millennia BCE) pro-165 vided less artefacts and ecofacts, this paper focuses on the 166 earliest Neolithic sequence, i.e. the Impressa first Neolithic, 167 the Cardial Neolithic and the transition towards the SMP. 168

#### **Materials and method**

Phytoliths are microscopic opal silica particles produced in 170 and between plant cells during the life of the plant. Due to 171 their chemical composition, they are usually well preserved 172 in various contexts, even when the organic plant remains are 173 decomposed (Kibblewhite et al. 2015). Because of the high 174 phytolith content of grasses (including cereals) and the spec-175 ificity of the forms produced by the Poaceae, these biore-176 mains are appropriate for reconstructing agricultural prac-177 tices, cereal processing and the diet of herbivores (including 178 domesticated species). Seventeen stratigraphic units were 179 sampled for phytolith analysis, in order to give clues to the 180 relationships between the human groups that frequented the 181 shelter during Prehistory and the surrounding vegetation. 182 In particular, we aimed to gain a better understanding of the 183 share of agriculture in the economy of the Early Neolithic 184 societies by tracking cereal remains, and of the management 185 of herds through the phytolith record of their diet. Focusing 186 on the most promising archaeological levels, phytolith analy-187 sis was carried out on 1 sample from a Mesolithic burial 188 and 16 samples covering most of the 6th millennium BCE 189 (Impressa, Cardial, Early SMP). Our analysis targets chrono-190 cultural complexes for which sharply focused documentation 191

concerning the exploitation of vegetal resources is lacking,
in particular the pioneer stages of the Neolithic (Impressa),
but also the earliest stages of the establishment up of Middle
Neolithic cultural complexes (SMP).

All of the samples come from sheltered zones of the site, AO2 where the sedimentary sequence was shown to have been 197 protected from major erosion. Most of the samples come 198 from the northern sector of the site and were analysed by 199 C.D.; two samples recovered from the southern sector and 200 previously analysed by P.V. are also included into the present 201 study. A small number of samples originate from the fill of 202 identified structures, while most are from the sedimentary 203 matrix of the archaeological levels (Table 1). 204

Around 2 g of sediment from each sample were processed 205 by A.M. at the CEPAM-CNRS Laboratory, following the 206 laboratory's routine protocol for phytolith extraction. The 207 sediment is sieved (200 µm) after soaking (12 h) in demin-208 eralized water for deflocculation of clays. The fine fraction 209 is then treated first with concentrated hydrochloric acid and 210 then with potassium hydroxide in an ultrasonic hot bath. 211 After several rinses, phytoliths are concentrated by heavy 212 liquid separation using a Thoulet solution (d=2.35). Once 213 dried, the phytoliths are dispersed on a slide in a drop of 214 immersion oil and protected by a cover-glass sealed with 215 resin. Phytolith identification is carried out through a trans-216 mitted light microscope, at a magnification of  $\times 1,000$ . 217 Where needed, polarizer/analyser devices are used to differ-218 entiate amorphous silica opal from potentially birefringent 219 particles. The protocol used provides a very clean phytolith 220 extract, but it does not allow the observation of spherulites. 221 These are identified in the sediment through other analytic 222 means (Brochier in Binder et al. 1993) and do not fall in the 223 scope of the present study. Phytolith identification is based 224 on a morphotypic classification prior to a taxonomic one, 225 due to the multiplicity (a single species may produce vari-226 ous different morphotypes) and the redundancy (the same 227 morphotype may be produced by various different spe-228 cies) of phytolith production (Rovner 1971; Brown 1984). 229 As regards the terminology used for the description of the 230 morphotypes, we endeavour to follow the latest recommen-231 dations of the International Committee for Phytolith Nomen-232 clature (ICPN 2.0, ICPT in press). In order to guarantee the 233 statistical reliability of the results, we ensured that more 234 than 200 classified phytoliths were counted for each studied 235 sample. 236

#### 237 **Results**

All of the samples provided abundant and well preserved
phytoliths (Table 1). It was not difficult to observe satisfactory quantities of significant forms on the slides, as
phytoliths proved to be abundant and well preserved in

every sample. As a result, identifiable phytoliths counts 242 vary between 167 and 409. Weathering and surface altera-243 tion (Fredlund and Tieszen 1997) were rarely observed. 244 The phytoliths were nearly always represented by sin-245 gle-cell particles: connected silicified cells, also known 246 as silica skeletons, were only rarely encountered in five 247 different samples, mainly from the sedimentary matrix 248 (Impressa, Cardial, SMP transitions levels) but also from 249 one Impressa combustion structure. They account for 250 0.3 to 1.2% of the assemblages in which they have been 251 observed, i.e. 1 to 4 individuals per sample. These multi-252 celled phytoliths are mainly made up of grass epidermal 253 cells, apart from one example of contiguous silicified grass 254 bulliform cells. The observed morphotypes (Fig. 2) mainly 255 relate to the Poaceae (grass) family. Phytoliths attributed 256 to dicots are rare over all, but reach noticeable values in 257 the southern area. They are represented by globular mor-258 photypes (Spheroid ornate) and by probable epidermal 259 cells (tabular polygonal morphotype). Concerning grass 260 phytoliths, the morphotypes produced in the vegetative 261 parts of the plants (culm, leaves) are abundant. Among 262 them, ELONGATE ENTIRE, ELONGATE SINUATE, ACUTE BULBOSUS 263 are very common and cannot be taxonomically identified 264 further. The silicified bulliform cells have also been allo-265 cated to the general grass family due to a lack of published 266 descriptions and of modern comparison reference mate-267 rial for the area. They were represented by the BULLIFORM 268 FLABELLATE and BLOCKY morphotypes. Although BLOCKY 269 forms are not unequivocal (ICPT in press), the overall 270 composition of the phytolith spectra, dominated by grass 271 phytoliths, points to silicified bulliform cells. A silica skel-272 eton made of articulated BLOCKY phytoliths, likely silici-273 fied bulliform cells, was observed. BULLIFORM FLABELLATE 274 and BLOCKY morphotypes are subsumed into the BULLI-275 FORM category in Table 1 and Fig. 3. On the other hand, 276 short cells allow us to distinguish between several Poaceae 277 sub-families (Twiss et al. 1969; Twiss 1992). CRENATE 278 morphologies characterize the Pooideae subfamily, while 279 RONDEL is more widespread, but, in a temperate context, 280 can be interpreted as mainly originating from the Pooideae 281 family too. BILOBATE morphotype, also previously known 282 as "dumbells", is mainly produced by the Panicoideae 283 subfamily. SADDLE, only present in low amounts in Pen-284 dimoun sediment, is frequently used as a diagnostic the 285 Chloridoideae, despite that it can be found in other related 286 subfamilies (ICPT in press). Nearly all of the species of 287 wild grasses from temperate Europe are Pooideae, as are 288 the first cereals domesticated in the Middle East and then 289 introduced into Europe (Triticum spp., Hordeum spp.). 290 Panicoideae are only represented by a small number of 291 genera in middle latitudes of Western Europe, particularly 292 Setaria (wild millets), Digitaria and Echinochloa. Domes-293 ticated millets also belong to the Panicoideae subfamily. 294

Finally, the Chloridoideae subfamily is mainly distributed 295 in intertropical areas, but it is nevertheless represented in 296 southern France by Cynodon dactylon (Bermuda grass). 297 The common reed, *Phragmites australis*, which belongs 298 to the Arundinoideae subfamily, also produces saddle-299 shaped short cells (Ollendorf et al. 1988), but this spe-300 cies is restricted to wetlands, especially in Mediterranean 301 areas. Morphotypes from grass inflorescence bracts have 302 also been observed, in the form of ELONGATE DENDRITIC and 303 scarce PAPILLATE (Parry and Smithson 1966; Rosen 1992). 304

Most of the spectra show a strong dominance of grass 305 306 phytoliths (Fig. 3). In the Neolithic samples from the northern sector, dicot morphotypes show a discontinuous 307 curve and only account for nil to 1.6% of the total. The 308 pattern is completely different for the samples from the 309 southern area, in which dicots phytoliths, in the form of 310 tabular polygonal particles interpreted as leaf epidermal 311 cells (tp in Fig. 2) have high values: 16.1 and 23.5%. The 312 variability of the phytolith spectra might be linked to a 313 spatial distribution of the activities inside the shelter, but 314 315 more samples from the southern zone would have been necessary to assess the extent of the phenomenon and to 316 propose further interpretations. The Sauveterrian burial, 317 in the northern area, also exceeds the Neolithic levels in 318

this sector in terms of dicots, which represent 6.7% of its 319 phytolith content. 320

#### Discussion

#### Livestock diet

In pastoral sites like Pendimoun, phytolith accumulation 323 is thought to be mainly due to shepherds bringing vegeta-324 tion into the cave as bedding or fodder for the livestock, 325 and also, depending on the frequency and the duration of 326 their presence in the shelter, to the transportation of plant 327 material within the digestive systems of the animals. Nev-328 ertheless, it remains difficult to determine whether these 329 microremains mainly stem from livestock alimentation or 330 if they could also partly result from the use of plants for 331 other purposes. Based on ethnoarchaeological observations, 332 a significant presence of multi-cell phytoliths (also called 333 silica-skeleton) is sometimes considered as a marker of 334 dung accumulation (Portillo et al. 2014) or of the presence 335 of bedding (Cabanes et al. 2009). Yet, these forms are rather 336 rare in Pendimoun. Nevertheless, in some cases, like in La 337 Grande Rivoire, the abundance of spherulites indicates that 338

sediment mainly derives from dung, despite the fact that 339 the abundance of grass multi-cell phytoliths remains low 340 (from 0 to 6%, Delhon 2014). Taphonomical processes may 341 enhance the breakage of these forms into single-cell parti-342 cles. Moreover, depending on environmental factors and on 343 the age of the vegetal tissues, multicelled phytoliths may 344 not be present in the browsed grasses. Thus, the absence or 345 scarcity of silica skeletons at Pendimoun is not sufficient to 346 rule out the possibility that the phytolith assemblages derive 347 from dung accumulation. Focusing on the northern zone, it 348 thus seems that the livestock mainly fed on grasses, either 349 350 brought into the shelter by the shepherds or grazed from the surrounding vegetation. Even though phytolith production is 351 far more important in grass then in dicots (Delhon 2010), the 352 presence of dicot phytoliths suggests that such plants were 353 introduced into the shelter, albeit in smaller quantities com-354 pared to grasses. In dicots from temperate areas, phytolith 355 production seems to be mainly concentrated in leaves (epi-356 dermal cells) and wood (globular morphotypes), although it 357 remains very low in the latter (Scurfield et al. 1974; Kondo 358 359 et al. 1994; Alexandre et al. 1997; Albert and Weiner 2001; Delhon 2010). Wood was used on the site, at least for fuel, 360 as documented by the presence of scattered charcoal in all 361 of the levels. Nevertheless, the scarcity of dicot phytoliths 362

indicates that branches and leaves were probably not used 363 as bedding or for feeding animals. 364

These results are similar to those reported from two 365 Ligurian sites (Italy). In the phytolith analysis of Riparo 366 di Pian del Ciliegio shelter (transition to and early SMP: 367 5000-4800 to 4600-4300 BCE), only grass morphotypes are 368 reported (Arobba and Caramiello 2009), while at the Arene 369 Candide Cave there is a "sharp prevalence" of grass origin 370 (Nisbet 1997). In contrast, the use of tree branches bear-371 ing leaves and/or flowers has been demonstrated on various 372 other Neolithic shelters in southern France (grottes-berger-373 ies) (Thiébault 2005). At La Grande Rivoire (Isère, Vercors 374 massif, Alps), the use of tree fodder is clearly indicated by 375 very high proportions of dicot phytoliths (most of the time 376 between 30 and 50%) throughout the Neolithic (Delhon et al. 377 2008). At Pendimoun, it seems that the livestock mainly fed 378 on grasses, either freely browsed or brought for this pur-379 pose into the shelter by the shepherds. This is consistent 380 with the data from charcoal analysis, which failed to identify 381 any evidence of leaf-fodder either in the taxonomic spectra 382 (Battentier et al. 2015) or in the diameter of the branches 383 (absence of charcoal fragments characteristic of twig mor-384 phology) (Battentier 2018). Perhaps a climatic gradient 385 might explain the need to gather tree fodder only at certain 386

altitudes or latitudes (for example at La Grande Rivoire and 387 not at Pendimoun) where it would have compensated for a 388 lack of vegetation. However husbandry practices could also 389 be involved, such as the duration of the period when the 390 animals were stabled, the season during which the shelter 391 was used as a sheepfold or the type of animals being kept 392 (sheep and/or goats) and their proportions. Concerning the 393 northern sector of Pendimoun, it is noteworthy that the only 394 structure which is not linked with pastoral activity is also 395 the one that provides the best evidence for the potential use 396 of dicots: the phytolith spectra for the Sauveterrian (Meso-397 lithic) burial contain 6.7% dicot phytoliths, including a frag-398 ment of silicified epidermis. Although we are dealing with 399 a single sample, it is tempting to think that this result could 400 be linked to Sauveterrian funerary practices. 401

#### Cereal processing on the site

Morphotypes from inflorescence bracts (ELONGATE DENDRITIC and PAPILLATE) are very rare among Pendimoun grass phytoliths (Fig. 4a), except in the Impressa levels where they reach 12% of the identified phytoliths. In the other levels, the only instance in which they attain frequencies higher than 3.3% is the sample from the Cardial burial (42,110), where they could originate from the Impressa levels. In fact, the funerary pit may have been filled using the surrounding sediment, including the layers deposited during the preceding Impressa period. In archaeological contexts, an accumulation of inflorescence bract phytoliths is generally 413 considered as a sign of an important contribution of cereals 414 to the phytolith record. In cereals, fertile parts (ears) usually 415 represent a greater part of the total biomass than is the case 416 for most European wild grasses, and the increase of seed 417 mass that characterizes domestic grasses could have led to an 418 increase of glume silicification (Novello and Barboni 2015), 419 both phenomena leading to higher amounts of inflorescence 420 bract phytoliths than in wild species. Moreover, even when 421 the archaeological record results from the accumulation of 422 culm and leaves, cereals are most likely to have been har-423 vested when ears were mature, which is not necessarily the 424 case for wild grasses; this leads to the systematic occurrence 425 of significant amounts of inflorescence bract phytoliths. The 426 very Early Neolithic levels at Pendimoun also yielded pre-427 served cereal grains (emmer wheat, einkorn and barley) and 428 grindstones (Binder et al. 1993, in press). In the southern 429 part of the site, one of the research team (P.V.) has identi-430 fied two different types of ELONGATE DENDRITIC phytoliths 431 (Fig. 5). Nevertheless, the range of intraspecific variation 432 of ELONGATE DENDRITIC is considerable (Ball et al. 2017) and 433 makes it hazardous to connect these forms to the cereal taxa 434 identified through macro-remains analysis. Inflorescence 435 bract phytoliths clearly do not occur in the same quantities 436 as on later sites where cereal-related activities have been 437 proved with certainty. For example, in the Bronze Age layers 438 of El Mirador cave (Sierra de Atapuerca, Spain), inflores-439 cence bract phytoliths reach 30% in an assemblage (facies 440

f) considered to be made up of crop-processing (threshing/ 441 winnowing or milling/pounding) residues and also rich in 442 cereal pollen (Cabanes et al. 2009). Nevertheless, our opin-443 ion is that the amount of inflorescence bract phytoliths found 444 in the Impressa levels, which is not only high per se but is 445 also significantly higher than what is observed in all of the 446 447 other levels of the sequence, is evidence of an input of grass inflorescences in the shelter which could be linked to in situ 448 processing of cereals during the earliest Neolithic. 449

With the exception of the Impressa levels, the very low 450 presence of inflorescence bract phytoliths seems to indicate 451 that no crop processing occurred at the site in other periods 452 of occupation. Cereal macroremains were identified in the 453 Cardial levels and in very low quantities in the SMP transi-454 tion levels (Binder et al. in press). These cereals, presum-455 ably consumed by the shelter's inhabitants, seem to have 456 been introduced onto the site in a dehusked form. At Els 457 Trocs (Early and Middle Neolithic, Pyrenees, Spain, 1,564 m 458 a.s.l., end of the sixth/beginning of the third millennia: Rojo 459 Guerra et al. 2013), very low amounts of inflorescence bract 460 phytoliths have been interpreted not only as suggesting an 461 462 absence of cereal processing but also as a sign of a very low input of grass inflorescences, either domesticated or wild, 463 at the site (Lancelotti et al. 2014). The authors suggest that 464 the site was occupied before the complete formation and 465 silicification of the inflorescence bracts, which is achieved 466 at the end of the summer at the altitude which the site is 467 located. Concerning the Cardial and SMP occupations of 468 Pendimoun, the low but variable amount of inflorescence 469 bract phytoliths could also be evidence for the grazing of 470 young grasses, before they bear mature inflorescences, i.e. at 471 an early stage of their life-cycle. Nevertheless, it is more dif-472 ficult to connect it to a specific season of occupation because 473 of the location of the site at a lower altitude (ca. 700 m a.s.l.) 474

in a Mediterranean context in which the favourable season 475 for seed production may be longer. 476

#### Seasonality of pastoral activities as recorded by phytolith assemblages

Grass short cells are very abundant and mainly belong to 479 the RONDEL and CRENATE types, which is not surprising 480 given the importance of Pooideae in the area. Nevertheless, 481 BILOBATE is regularly encountered and in certain instances 482 is quite abundant (around 5% of the total) (Fig. 4b). As a 483 comparison, the forms mainly attributed to Panicoideae are 484 not reported at Pian del Ciliegio (Arobba and Caramiello 485 2009), are nearly absent at La Grande Rivoire (Delhon et al. 486 2008) and seem to show very variable amounts at Arene 487 Candide (Nisbet 1997). In the area of Pendimoun, during the 488 Neolithic, only three different grasses may have contributed 489 to the production of BILOBATE: Setaria sp. (mainly Setaria 490 viridis), Digitaria sanguinalis and Echinochloa crus-galli. 491 Such plants were thus present near the shelter and/or used 492 by the dwellers during the Neolithic. All of these grasses 493 exhibit a C<sub>4</sub>-metabolism and display a ruderal behaviour. 494 Echinochloa seems to be the least likely of the three as it 495

needs humid contexts, but its presence cannot be excluded. 496 All of these plants are annual, with short so-called "summer" 497 lifecycles (for example no more than 8 weeks for S. viridis) 498 (Fig. 6). According to modern data for weeds from organic 499 crops (Institut Technique de l'Agriculture Biologique 2012), 500 germination occurs from the end of spring to the middle of 501 autumn (June/September for S. viridis, May/October for E. 502 crus-galli, June/October for D. sanguinalis) and seed matu-503 rity, followed by plant decay, is reached at the end of sum-504 mer or during autumn (August/October for S. viridis and E. 505 crus-galli, September/October for D. sanguinalis). Because 506 they contain significant amount of BILOBATE short cells, most 507 of the studied levels should therefore record plant collec-508 tion or grazing during summer (broadly speaking: from the 509 end of spring to the beginning of autumn). Combining this 510 evidence with the absence or scarcity of inflorescence bracts 511 phytolith (in most of the SMP and Cardial levels) allow us 512 to narrow down the season of pastoral use of the shelter to 513 the end of spring and early summer, before the complete 514 silicification of inflorescence bracts cells. The levels where 515 BILOBATE are lacking (43662, 40317) might record winter/ 516 early spring frequentation of the site, unless a heterogeneous 517 use of plants through time and space led to their absence in 518 the posthole (43,662) and when the site was used for burial 519 (40,317). Nevertheless, a survey of the actual life-cycles of 520 these plants in the area around the Pendimoun shelter would 521 clarify the picture of suggested seasonality of the Neolithic 522 frequentation of the shelter for pastoral purposes. Indeed, we 523 cannot exclude the possibility that these short-lived grasses 524 may be able to take advantage of temporarily favourable 525 climatic conditions so as to colonize limited areas outside 526 of their "normal" growing season. 527

#### 528 Conclusions

The phytolith spectra from the Pendimoun shelter indicate 529 an important use of grasses, mainly wild Poaceae. Because 530 mineralized dung is a major component of the sediment, 531 we assume that these plants microremains mainly originate 532 from digested animal food. However, the phytolith spectra 533 also partly originate from a mixture of plant used for vari-534 ous purposes. It can be easily argued that cereals, which 535 were probably processed inside the shelter during the earli-536 est Neolithic, were intended to feed the human inhabitants 537 rather than their flocks. 538

In the most probable case, i.e. that phytoliths mainly result from the plant parts eaten by the animals, the low level of morphotypes attributed to dicots indicates that livestock management during the Early/Middle Neolithic did not require any additional food supply in the form of leaf fodder. Thus, the available vegetation in the pasturelands was probably sufficient to address the needs of the farmers. The

reasons why livestock fodder was supplemented with leafy 546 or flowering branches in some pastoral Neolithic sites (for 547 instance at La Grande Rivoire) and not in others (for instance 548 at Pendimoun) requires further investigation. The recourse to 549 additional food supply may have been necessary in certain 550 areas due to the duration of the bad season, or because of 551 pastoral practices resulting in the presence of livestock in 552 some areas (mountains) before or after the period when pas-553 turelands where accessible or productive (before the melt-554 ing of snow or the greening of the vegetation, after the first 555 snowfalls or the senescence of grasses, in cases of severe 556 drought...); the species of animal being raised (goat, sheep, 557 cow...) may also have an influence. Woody leafy branches 558 are easy to dry and stock over few months, and are thus con-559 venient for filling a seasonal shortage of fresh vegetation. 560 Tree fodder may also have been used simply to facilitate the 561 housing of flocks (Battentier et al. 2016) and would have 562 allowed the spacing of the browsing periods. It is broadly 563 acknowledged that mobility was a component of the Neo-564 lithic farming systems in the south of France, as shown by 565 the existence of various types of sites, some of them exhib-566 iting an organization typical of long-term settlements asso-567 ciated with crop production, others being more occupied 568 for shorter periods of time and dedicated to hunting activi-569 ties, and others, like Pendimoun, which provide evidence 570 for probable seasonal pastoral occupation. These different 571 patterns illustrate the increasing complexity of the territory 572 exploitation system, in the form of a network of more or 573 less specialized sites used during certain periods of the year 574 and by different elements of the social groups (Binder 1991; 575 Rowley-Conwy 1991; Beeching et al. 2000; Bréhard et al. 576 2010; Martin 2014). Nevertheless, the season(s) when the 577 pastoral shelters (grottes-bergeries) were occupied, the dura-578 tion of the occupation and its frequency (once a year, several 579 times a year, repeatedly in a given period of the year) are 580 difficult to specify, and could differ from one site to another. 581

In the area concerned, where the winters are mild, the 582 observation that leaf fodder was not used gives no informa-583 tion on the season, but the data from Pendimoun offer other 584 clues concerning that issue: the grasses were consumed 585 before the development of the inflorescences, which seems 586 to exclude a period from mid-summer to the beginning of 587 autumn, and the presence of panicoid grasses restricts the 588 window to a period focused on summer (broadly speaking). 589 Finally, phytolith data make it probable that pastoral activi-590 ties in Pendimoun during the Early/Middle Neolithic prin-591 cipally took place from the end of spring to the beginning 592 of the summer. 593

Of course, this initial hypothesis concerning seasonality now has to be verified by means of other kinds of data. Other phenomena could explain part of the observed spectra, for example the use of grass fodder (harvested during spring and stocked to be used later), which is still not evidenced 598

for the Early Neolithic period, or intense browsing which 599 would prevent the plants from flowering. Moreover, it must 600 be kept in mind that, thanks to their very short lifecycle, the 601 panicoids may have been able to sprout and grow locally 602 outside of the usual season, thanks to temporarily favour-603 able climatic conditions. Besides, the seasonality of pastoral 604 activities may have changed over time. During the Impressa 605 period, pastoralism is combined with agriculture and the 606 shelter seems to be almost continuously occupied, while dur-607 ing the Cardial/SMP periods shepherds may have used the 608 shelter at certain period of the year only, in a system where 609 pastoralism alternated with other activities. 610
